After CGA report, Jafo directs eight council internal auditors out

THE internal auditors of eight local councils that received qualified opinions in the latest annual report of the Controller and Auditor General (CAG) must be suspended forthwith, Minister of State in the President's Office (Regional Administration and Local Governments) Selemani Jafo (pictured) directed yesterday.

He tasked the Permanent Secretary, Joseph Nyamhanga to fire the respective officials, saying he will submit to President Samia Suluhu Hassan their names for final decision.

He also asked regional commissioners and administrative secretaries to evaluate their own conduct well in advance as the conduct of local authorities in expenditures is being examined..

The step follows the presentation of the 2019/20 CAG Report to the president yesterday, whereupon minister Jafo called a press conference to affirm that the ministry was mobilized to take corrective action in the areas of weakness the report highlighted.

"I expected that the internal auditor's task was to oversee proper financial expenditure. But if his council does poorly, it means he

PRESIDENT Samia Suluhu Hassan yesterday created a vivid image of her presidency with directives signaling openness and boldness from the word go.

Receiving annual reports of the Controller and Auditor General (CAG), Charles Kichere and the Director General of the Prevention and Combating of Corruption Bureau (PCCB), Brigadier General John Mbungo at the State House, Chamwino yesterday, the president demonstrated intent to keep the pressure on public officials to obtain credible levels of performance.

President Samia showed she wil continue with the spirit of shaking up slothful bureaucracy and deal with corrupt executives, deepening previous measures in regard to port authorities for instance.

Apart from suspending the director general of the Tanzania Ports Authority to pave the way for investigation of corruption, she directed the TRA to conduct an audit of all the money withdrawn from the Bank of Tanzania (BoT) in three months.

"The governor is here. Go and audit all the

ATCL suffers 60bn/- losses in 2019/2020

AIR Tanzania Corporation (ATCL) chalked up losses of a whopping 60bn/- in one year, on the basis of a report by the Controller and Auditor General (CAG).

Presenting the audit report for the 2019/20 financial year to President Samia Suluhu Hassan at the Chamwino State House in Dodoma yesterday, CAG Charles Kichere said that the national carrier lost the amount in that period and counting. "ATC been making losses for the past five years," he said.

up losses since the government started pumping billions of shillings into its revival in 2016 with new operating systems, staff and a fleet of brand new aircraft.

It is also the first time the actual situation at the national carrier has come out in an audit report prepared by the government

The first time ATCL acknowledged loss was in March last year when it said it had suffered revenue loss of around two to three percent of annual projections following the outbreak of the Covid-19 pandemic.

monies withdrawn from January to March and directed at various projects. We want to know how the same was spent," she said, keeping the method and punch of the mode of governance of her predecessor, John Magufuli.

As for other audit reports, the president told the CAG not to water down his reports but tell the whole truth as it is. Hiding challenges is not solving anything, she declared.

"Don't mince words; be as open as possible. If a certain parastatal is not doing well, say so; if a board is not performing, tell us," the president emphasised.

"By knowing our weaknesses we can improve; by being silent we will not make any gains and our people will suffer the consequences of our silence."

Tanzanians languishing in remand prisons with weak cases against them may regain their freedom soon after the president ordered authorities to review

their cases if they can't be taken to court, and drop them.

Addressing Brigadier General Mbungo, she said there is no need for prosecution authorities to proceed with weak cases that the government cannot win, and yet suspects and accused persons spend months and years in remand prisons. "Drop all baseless cases," she pointedly demanded.

If implemented, this could mean huge relief and joy for suspects and accused persons, especially those who were accused of unbailable offences such as economic crimes.

President Samia was sworn in as the sixth president of the United Republic on 19th March in the wake of the death of her predecessor of heart complications.

She made history as the first woman to hold the position of president in this country and one of the few women who have held the position in African states since independence.

He replaced Awadh Massawe, who was fired along with the then permanent secretary in the transport ministry, Shaaban Mwinjaka, by then President John Magufuli following the disappearance of over 2,700 shipping containers at the Dar es Salaam port.

Access to clean water increased by 20 pct in Lindi Region - govt

Assessing access to safe and clean water in Lindi Region had increased from 42.9 per cent to 61.5 per cent following the government's decision to provide the region with funds to implement water projects in the last five years.

This was revealed by the acting Lindi Region Regional Commissioner Shaibu Ndemanga during special prayers in honour of late Dr President John Magufuli held at Ilulu grounds in Lindi town. Ndemanga was recounting the implementation of various development projects in the region since Dr Magufuli came to power in 2015, saying a total of 72.42bn/- was directed to water

supply projects.

Ndemanga, who is Lindi district commissioner, said the achievements are credited to the fifth phase government under Dr Magufuli in his efforts to improve water infrastructure in urban and rural areas under rural and Urban Water and Sanitation Authority (RUWASA) management.

He explained that to ensure people were supplied with water services delivery every district council in Lindi Region had allocated funds for the implementation of water projects, whereas Ruangwa District received 8,647,406,808/- for its Kitandi and Ruangwa Urban water projects.

He added that Kilwa District received 6,260,775,860/- for its project for Mingumbi and Masoko wards while 3,173,582,199/- was allocated to Nachingwea District for the expansion of water project to from Ngwinji in Masai District in Mtwara Region to Nachingwea and 2,723,864,420/- was given to Liwale District for its projects for Kichonda, Mikunya, Mbaya and Mtumbwa villages.

She added that Lindi Urban Water and Sanitation Authority (LUWASA) was provided with 41,117, 849,038/-, while Lindi Municipality was given 7,588,760, 308/- for Nandambi, Chikonji and Kineng'ene projects.

In regard to late Dr Magufuli Ndemanga said the only way to hold the late President in high esteem was to enhance accountability in agricultural and industrial production.

There is no other way, we must all work hard for our own development," he added.

"Internal Auditors are essential to ensure various financial procedures and guidelines are adhered to, as they are chief consultants and supervisors," he said, directing the PS to appoint capable people in those positions.

The minister sounded caution against local council directors, saying despite training sessions and directives given on financial control, the directors have displayed poor management and received qualified CAG audit certificates. "As they are presidential appointees, I will submit their names to the president for decision," he stated.

He similarly wanted the permanent secretary to examine the report to figure out officials mentioned in other local councils for inappropriate conduct even though they received clean certificates.

"Our regional secretariats which I believe are the main supervisors in their areas were supposed to advise on the conduct of government expenditure in their areas. They should also evaluate themselves."

The move followed closely on a public directive by President Samia for Jafo to find lasting solutions to extensive losses of government funds in local authorities.

"There is massive loss of public funds; please go and supervise revenues and expenditures in this ministry," the president intoned, quipping to the minister that should the minister fail other authorities are there to help, as

the situation is not satisfactory.

The president had earlier received the report of the Controller and Auditor General (CAG) and that of the Prevention and Combating of Corruption Bureau (PCCB) for the financial year 2019/20.

The CAG report shows that local government authorities got 162 unqualified opinions (clean opinion) and three adverse opinions out of the total 165 opinions presented.

"Although the CAG said local government authorities don't have qualified opinion or disclaimer of opinion, the loss of funds is still quite high," she told the minister.

The president especially castigated local government authorities for habitually receiving huge funds from the central government but they don't return funds that aren't used in the designated projects.

ITV producer, presenter Blandina Sembu was murdered, police say

POLICE in Dar es Salaam yesterday confirmed the death of ITV producer and presenter, Blandina Sembu (pictured), saying she was murdered.

Bandina was popular for her programme 'Jarida la Wanawake' (Women Magazine) on ITV.

Kinondoni Regional Police

Commander (RPC) Ramadhani Kingai told journalists in Dar es Salaam yesterday that Blandina (47) died on Sunday mid-night after being hit with a sharp object on her face.

He said the body of the deceased was found between Bamaga and ITV bus stops in Mwenge suburb along Ali Hassan Mwinyi Road.

"The circumstances of the killing are uncertain, preliminary investigation shows that Blandina has been killed. The body was dumped by unknown people who were in a car near Maryland bar at Bamaga, the vehicle's registration number is yet to be established," he said.

He said the murders stopped the car at the area whereby

"The deceased was a resident of Zinga in Bagamoyo District, Coast Region. Investigation on the incident is still going on," Commander Kingai said.

He said that the body was found having injuries on face and eyes, She is seen to have been hit with a heavy object.

"This is not a normal death. Our experts are in the field working to find out the major cause of the death and all who are behind this," he added.

Govt plans to establish aquaculture centres in 80 districts, says minister

THE government has plans to establish aquaculture centres in 80 districts that would be used as demonstration farms for the people to learn

Ndaki said the ministry's FY 2021/22 budget aimed to established these centres to increase fish ponds that would help reducing illegal fishing activities in those areas.

He said another goal is to ensure every district to have an aquaculture centre to be used as demonstration farm tor fish farming.

The minister said the government's strategy through the centres is to attain 50 percent fish production from fish farms and the rest from natural

He said as for now the ministry has mobilized itself through various strategies to attain its goals including its plans to refurbish and empower all



Govt stresses need for women to access land

THE government has reiterated the need to $strengthen women \, participation \, and \, decision \, making$ in Land governance for women empowerment and involvement in economy.

Opening a side event of the 65th session of Commission on the Status of Women (CSW) recently, Commissioner of Social Welfare, Dr Naftali Ng'ondi said the government is aware on the need for women participation on land governance issues as it has taken a number of measures to make it work.

"We aware that the Priority theme is Women's full and effective participation and decision-making in public life, as well as the elimination of violence, for achieving gender equality and the empowerment of all women and girls" he said during the zoom meeting.

He affirmed the government commitment that articulates the issue of promoting equality in access, ownership and use of land as one of the priorities in achieving inclusive development.

He said women's economic development is noted as a pre-requisitely determined by how easily the access and use of land are productive resources for their economic potential.

Statistics, Dr Ng'ondi said show that, more than 65 per cent of Women in the country depend on land as their key productive resource to support their livelihood. However, they only own between ten and 20 per cent of the available land.

The Social Welfare Commissioner said gender inequalities in land rights are pervasive whereby culture and traditions support male inheritance of family land.

"Not only do women in Tanzania have lower access to land than men but they are also restricted to 'secondary land rights', meaning that they hold these rights through male family members" he stressed.

The government has instituted various policy measures to set standards to ensure that land ownership rights are equally shared. It has also made significant progress in ensuring women's participation and decision making in land Governance at all levels.

He noted that ownership of land and other productive assets remain a serious constraint to women's progress as the country women mstill face discrimination in both laws and practices.

The Customary Laws of Inheritance of 1963 prohibits women, widows and daughters from inheriting land. The Lack of secure ownership of land for women contributes mto the lack of identity as household owners, leaving women less able to effectively engage themselves in decision making at various levels.

However, he added, women do not have the same opportunities as men to own assets and improve their economy, which in turn leads to limited opportunities to increase their resource base and investments. He sad is it time to strengthened land rights and tenure security Legal reform to improve women's inheritance rights is therefore required to improve socio-economic outcomes for women.

He also called for strengthening public awareness, participation and education regarding women's inheritance rights, and women enhancement of open and accessible appeal system to address the concerns, are taken as a strategic issue.

He highlighted so some of the initiatives and achievements made by the government in the implementation of Women land Governance as The Constitution of the United Republic of Tanzania recognizes equality to own property for all citizens regardless of their gender.

Moreover, there are The existence of legal framework to execute land rights and women's participation in lands Governance and The 1999 Land Act, revised in 2019, establishes principles that help to safeguard women's land rights and the 1982

Government (District Authorities) Act establishes the village council which requires that a minimum of one-fourth of village council members are women.

Also the government is reviewing Policies that are in line with Gender Equality and Women Empowerment issues to incorporated women rights to access and own land in the Country. Amongst is the review of Women and Gender Development Policy of 2000 which focus to articulate the current situation.

The village council is the executive body vested with power in respect of all village affairs, including managing village land, therefore, decisions made at the village council are then subject to approval from the village assembly - a village's highest decisionmaking body, which includes all villagers including women.

The Government, he said ensures women have access to land without limitations imposed by customs, culture, norms and traditions.

These kind of reforms contribute significantly to the effort of eradicating discriminatory practices which hinders women's participation in land governance.

These efforts have resulted into several achievements which include increase in number of individual women ownerships of land from 9 per cent to 25 per cent and joint ownership increased from six per cent to 16 per cent respectively.

He was optimistic that the meeting panelists and community members who will show case best practices in ensuring Women's participation in Land Governance in line with Sustainable Development Goals. "It is my expectation that, at the end of this Side event, we shall come up with strategies and recommendations on how the Government in collaboration with stakeholders can enhance Women's participation in land governance in our communities" said Dr Ng'ondi.

1,974 villages to be connected to the national grid - minister

AT LEAST 1,974 villages that are yet to get electricity will be connected to the national grid in the second round of the third phase of the national rural electrification project

Energy minister Dr Medard Kalemani said during the project launching at Ugaka village in Igunga District, Tabora Region project will cost 1.24trn/- and will be implemented in 18 months in all regions.

He said every district will be provided with a contractor to implement the project so that it is completed in time, as opposed to earlier practice where a contractor was given a series of regions, thus causing delays in completion of the projects.

He said there would be no extension of time for contractors failing to meet the deadline, but revoking the contract and being referred to court according to the law.

He stressed that rural dwellers pay 27,000/connection costs in villages and watch out for conmen, whether it is unfaithful officials or fake technicians, who would be demanding copious amounts for the service.

Contractors must introduce themselves to district and regional officials before starting work, enter into agreement on the time schedule for implementation of the work in their respective areas to enable district and regional authorities to closely monitor progress in each district, the minister directed.

Contractors must similarly make sure that all work not requiring special expertise is assigned to residents of the area or near the various districts as to enable them to benefit from the projects.

Dr Kalemani also pledged to construct a small power substation in Igunga District to beef up power

The minister held a meeting with Isanzu villagers in Nzega District, where he told them that the contractor for power distribution in the district has already been picked and would start work at any time as the funds were available.

Regional Commissioner Philemon Sengati appealed to people in the villages still not getting power to grab the opportunity and get power connected to their homes. The government wishes to ensure that all households use electricity in petty trade for their development, he added.

Also, he said, DCC issued about 15,512 business licences. He said it spent 11.5bn/- in implementing strategic projects including building of a five star hotel.

According to him, the construction of the hotel located in the city centre was now at 90percent and that it will officially kick off operation in April this vear.

Dodoma sets aside trading grounds for timber traders

DODOMA city authority has set aside trading grounds for timber traders after they were issued relocation notice by private owners of business premises they acquired.

Most of timber traders within the city centre operate around the Jamhuri stadium in private rented premises whose owners have since told them to vacate the area.

Speaking with The Guardian here, City Executive Director, Joseph Mafuru said the authority has set aside trading grounds at Kizota and Nzuguni wards for the traders, saying the aim is to end disturbance the traders face.

"Since timber traders were ordered to vacate their business areas, I have therefore directed the relevant officers to hurriedly set aside the places for them" he said, adding that currently timber are sold unsystematically around the stadium.

He explained that within three months from now the traders shall have permanent trading areas after city authority has held a meeting with them.

According to the director, the aim is to have a well-planned city which generates own revenues and its people are involved in authorized business activities, thus to achieve this, traders must have business addresses.

One of the traders, Vera Ngamale called on the city authority to relocate all timber traders in the city to the designated areas once everything is in place in order to boost business as customers will have a common place.

"All traders should be removed from the city centre and buyers be told of the specific places to get timber" she said, adding that by so doing it will be possible for the authority to get rightful revenues.

In December,2020, Regional Commissioner, Binilith Mahenge expressed satisfaction with the pace of construction going on in various areas in Dodoma Region but has demanded the City Council to embark on fixing the necessary infrastructure.

Dr Mahenge expressed the satisfaction after visiting various areas of investments, including

He said the construction was progressing well but there were still infrastructure challenges in the new settlements.

"The city should issue building permits only to areas which have already been developed with the necessary infrastructure," he said.

During his trip to Nala IFM, the area set for small industries, residential and commercial settlements, Dr Mahenge said the area will also host the Institute of Finance Management (IFM) and the Institute for Rural Development Planning campus.

Dodoma City Director Joseph Mafuru said that the area seats on 5,610 acres in which 5.3bn/- was used to compensate the villagers, noting that 7,500 plots were surveyed and mapped in which 1,600 building permits for the area have so far been issued.

"Now we want to open road infrastructure networks in this area. We have the machinery ready for the job," he said.

Mafuru said in Michese area, 2,062 plots have been surveyed Nala, Mahungu, Michese, Mkalama and over 300 building permits and Iyumbu in the outskirts of the have been issued.

Agency triples production of improved seeds in four years

THE Agricultural Seed Agency (ASA) has increased seed production capacity from 557 tonnes in 2016/17 to at least 1,750 tonnes during 2018/19.

The impressive development has managed the state-owned Agency to stand fifth out of more than 42 companies that produced quality seeds within the country during the period between 2019/20.

ASA Chief Executive Officer (CEO), Dr Sophia Kashenge said that the improvement was attained through an effort by the Agency to add four new seed production farms.

Dr Kashenge unveiled the farms that the agency has obtained include Kilimi (1,115 acres), Msungura (250 acres), Mazizi (12 acres), and the Luhafwe farm (500 acres).

According to her, the new farms have increased the number of the seed farms to 13 from 8, bringing the total Agency's seed production area to 10,115.2 hectares from 9,890.

demand for quality "As government seed keeps on skyrocketing to help accelerate production of enough food and crop-based raw materials, we came aware over continued diminishing of suitable land for

and thus, we decided to initiate an effort to amass more land" she observed.

She added: "The farms are increasingly surrounded by the fast-growing population. It is high time now that the seed farms are highly protected since they are prone to destruction. As part of urban greening, these farms offer traditionally rural services in cities, thereby contributing to food resources as well as working to alleviate pressing social issues like poverty,"

"It also provides a way to create opportunities for employment and community-building for the people surrounding the fields. As part of greening, they present urban agriculture and provide a buffer for pollution and improve environmental (and well as human) health and well-being through the land-based carbon

In more efforts to improve seed production, Dr. Kashenge said ASA has also managed to expand seed production acreage at some of its old farms.

"For instance, at Mwele farm in Tanga, we managed to expand 200 acres, at Kilangali 400 acres and Mbozi farm has been extended to at least 300 new acres," she detailed.

Dr. Kashenge informed that the Agency has so far increased the number of private seed seed productions due to increased companies working under Publicfive during 2017/18 to 11 during 2019/20.

"The companies have played a significant role to help increase production of quality seed from 2,666 tonnes to 3,884, making the total production at ASA's land resources to raise from 3450 to 5634 between 2016/17 and 2019/20," she unveiled.

With a mandate of producing improved seeds, ASA, plus its land resources currently contribute to at least 28 percent of all seeds produced in Tanzania.

The current demand for seed in Tanzania stands at 186,500 tonnes in a year, but the amount that is being produced is only 71,000 tonnes.


To curtail the shortage, the agriculture ministry is currently implementing a 10 -years strategy to improve the seed production sub-sector, aimed at enabling the country to meet the local seed adequacy as well as reaping economic fortunes from potential external seed markets.

The strategy incorporates more investments in the side of seed research, inventions, multiplication as well as quality control.

According to agriculture deputy minister Hussein Bashe, Tanzania was standing a possible chance to fetch lucrative profits from external seed markets, hence a need to strengthen local seed production capacity.

T is a fact that road traffic accidents are the leading cause of death among children and young adults aged 5-29 years. And it is a growing problem in many developing and even developed countries. However, the alarming rate at which it occurred in Tanzania in the past years has raised concern and even suggestion for a national debate over the issue.

Let's bear in mind that road traffic accidents in the the country are multi-factorial. The lesser faire attitude of some drivers, illicit drugs use and speeding.

We cannot agree that it is as a result of rapid urbanisation and motorisation as factors leading to higher number of road traffic accidents.

According World Health Organisation's (WHO) approximately 1.35 million people die each year as a result of road traffic crashes globally. This figure is just alarming and a lot more could be done to address the issue at the national level.

Unless more comprehensive global action is taken, the number of deaths and injuries is likely to rise significantly.

"Guy-Brice Parfait Kolelas died in the medical plane which had come to pick him up in Brazzaville on Sunday afternoon," said his spokesperson Christian Cyr Rodrigue Mayanda.

Just a few hours before the polls were due to open, the former minister posted a video in which he claimed he was "fighting against death."

"My dear compatriots, I am fighting death, but I ask you to stand up," he said weakly. "Go and vote for change. I would not have fought for nothing. Stand up as one. Make me happy. I am fighting on my deathbed. You, too, fight for your change. the future of your children is at stake."

But the death of Kolelas - who resigned from his government position in 2015 before contesting Sassou Nguesso, who he considered his "father," at the ballot box in 2016 - will not change the political game or influence the outcome of the vote. Because the open secret is, Sassou Nguesso remains the big favorite.

A political earthquake?

Should we be prepared for a political earthquake following the first round of this presidential election? The candidates believe they have a change to beat the Congolese president at the ballot box, counting on the discontent and weariness of the population. Then again, former challenger Jean-Marie Michel Mokoko, who has been locked up since 2016 and found guilty in 2018 of endangering state security, thought the same.

In addition to spreading its institutional and ideological web across the country, the ruling Congolese Party of Labour (PCT), which was founded in 1969, is a powerful political apparatus devoted to the president and his willingness to remain the head of state.

A new five-year term for a septuagenarian?

The big question of this presidential election is therefore less about who wins than about what 77-vear-old Sassou Nguesso would do with another five-year term.

One of the challenges of the ensuing political cycle will inevitably be the matter of his succession. And it will be within the great PCT family that the great battles will take place which will decide the future of the Republic of the Congo.

The mysteries of the oil boon Congo is the sixth-largest oil producing country in Africa, with an estimated production rate of 350,000 barrels per day. In 2019, the government announced the discovery of four new oil deposits that would increase its daily production to 980,000 barrels.

But the announcement aroused skepticism among oil exploration specialists, who believe it may be an attempt to foster the illusion of a bright future among the population.

Located in the heart of the Congo Basin - considered the planet's second lung after the Amazon - Sassou Nguesso's country is paradoxically one of the poorest in sub-Saharan Africa.

With a national debt amounting and administration at the service to 87% of its gross domestic

product (GDP), half of the population lives below poverty line. In this respect, the Republic of Congo is a case study for the "curse of the black gold," while its people still hope for a fair distribution of the land's wealth.

In fact, high-ranking dignitaries of the Republic of Congo have, since 2009, been in the crosshairs of several NGOs, as well as French, Swiss and American judicial authorities.

In response, they have cried out against judicial harassment and attempts at neocolonialist destabilization. But ever since the "ill-gotten gains" affair in France, which saw several Congolese officials indicted, the justice system has been steadily inching closer to the management of Congolese oil under the Sassou Nguesso administration.

Two proceedings opened before American courts based on a report by NGO Global Witness, which led to the precautionary seizure of a residence in Miami, Florida. The home, worth approximately \$3 million (€2.52 million), was acquired by one of the president's sons, Denis Christel Sassou Nguesso, when he held the top job at the National Petroleum Company of the Congo (SNPC).

More recently, in 2019, Swiss trading company Gunvor was ordered to pay a fine of 90 million Swiss francs (€81 million, \$97 million) on a charge of acts of corruption for the benefit of Congolese officials.

Regardless of what happens from here, it's clear that a new term for Sassou Nguesso won't be smooth sailing on the judicial

African countries must do more to boost trade among themselves

HE expansion of trade sub-Saharan African nations holds the key to faster growth and development to the benefit of all its citizens. To unlock this potential, countries will have to focus more on trade facilitation, including the simplification modernisation of trade procedures.

Sub-Saharan African countries have the lowest trade among themselves compared with other regions. Intra-regional trade is estimated at about 10 per cent compared with 40 per cent in North America and 60 per cent in

Western Europe. Among the factors holding back growth are non-tariff trade barriers. Excessive document burdensome requirements, customs procedures, inefficient ports and poor infrastructure add to the cost of exporting and importing goods. Firms benefit more from a 10 per cent reduction of these costs than from a similar cut in tariffs.

This is why there has been a major focus on reducing red tape and other non-tariff trade barriers.Implementation of trade facilitation measures can reduce the cost of moving of goods across borders by between 12.5 per cent and 17 per cent. It can boost exports too by making it cheaper for firms to import materials they can transform into finished products for sale in other countries.

Trade facilitation can also create an enabling environment for foreign direct investment.

And red tape harms poor producers the most, so trade facilitation is especially beneficial for small- and medium-sized businesses. This is very important in the case of African countries.

A number of African countries implementing been measures aimed at easing the flow of goods across borders. A guide to what needs to be done is set out in the Trade Facilitation Agreement earlier signed by World Trade Organisation members in 2013. The agreement outlines measures for expediting the movement, release and clearance of goods at borders.

A few sub-Saharan Africa countries have started working towards the implementation of a "single window" system - a collaboration between all state entities involved in the regulation

of international trade. For example, Ghana initiated a single window operation in 2002 following concerns about slow and expensive border procedures. It standardised information through a single administrative document for all its customs operations though implementation is not yet

fully functional and automated. Another measure involves the creation of one-stop joint border posts. An example of this is the Chirundu border between Zambia and Zimbabwe. Since traffic only stops once for the country being entered, the time it takes to cross the border is greatly reduced.

After the implementation of the one-stop border post, trucks are electronically scanned - which takes much less time. Another initiative, the African Union Border Program, initiated in 2007 with the goal to have all borders in Africa delimited and demarcated by 2017, has also made progress.

But there is more that countries can to do to ease the flow of goods across their borders.

harmonise should They procedures. These should be made simple and then they should be aligned - first within regions and then across the continent. The alignment should be backed by appropriate legal and institutional frameworks.

Countries should also be standardising documents through a national and later regional single window system. This will resolve challenges with bureaucracy, corruption and delays processing trade documents.

The capacity of customs should also be enhanced in terms of electronic data management. This will improve risk management and revenue generation. For example, the Philippines' computerised customs management systems reduced corruption in its bureau of customs.

On early marriages and International Women's Day

DVOCACY for early marriage, rather than child marriage, hinges on promotion of reciprocal love, alongside mutual respect and understanding.

I insisted that early marriage, as distinct from child marriage, should be tolerated and encouraged in society. Since marriage is a union of two people who have met certain conditions set up by different cultures, customs, religions and legislation, then it should naturally lead to a legal and legitimate companionship.

In preparation for the 2021 edition of the International Women's Day, Hawwah Jiddare, a vocal feminist from Northern Nigeria and Chevening Scholar requested if I could recommend any person to discuss the rampant cases of early marriage in Arewa, Northern Nigeria.

I told her that not only in Northern Nigeria but also across Africa, a lot of educated people and political leaders are products of early marriages. I added that beyond the hysteria and negative denotations around early marriage, many of these experiences could be narrated from proper and more positive perspectives.

In her response, Hawwah who runs "Sheroes", a publishing platform for women's empowerment, advocacy and documentation, requested my participation as one of the panellists.

"As a journalist, writer, author and Public Relations practitioner, your role is to give us an objective rationale behind a situation where 59% of girls are married before the age of 18 in Northern Nigeria, even though it does not guarantee them having an education... " she added.

While mulling over my proposed participation in the webinar, whose agenda pertaining to the theme of

the discussion was not immediately clear to me, Hawwah added that "What is the rationale behind such beliefs and actions in the North?"

I suspected that she asked the question as a way of goading me and inciting my interest in the discussion. It was a fairly emotional issue for me, not only because of some of the misconceptions that have come to be attributed to the issue of early marriage but also because I am a product of parents who married early. Yet, the experience of my family has been nowhere near the predominantly negative narrative being peddled around. I can say the same for a number of families I know. My father evolved to become a distinguished scholar and academic, who is now retired, while my mother is a trader, who is now a remarkable matriarch of our family. They both remain strong, physically and mentally till date.

I decided to accept the invitation to be a member of the panel on early marriage and girl child education, as a way of offering my lived perspective to the issue of early marriage in the North.

During the webinar on March 8, International Women's Day, I came into the same discursive space with other panel members who had contrary views to mine, including a legal practitioner, a gender activist and a medical doctor.

The designation of legal adulthood and the marriageable age in many countries is 18 years; however, the marriageable age may be older or younger in other countries. Still, cultural traditions may override legislation, as many jurisdictions permit early marriage with parental consent or in special circumstances, such as teenage pregnancy.

Since I had the opportunity to speak first, my argument set the agenda of the discourse.

I insisted that early marriage, as distinct from child marriage, should be tolerated and encouraged in society. Since marriage is a union of two people who have met certain conditions set up by different cultures, customs, religions and legislation, then it should naturally lead to a legal and legitimate companionship.

The designation of legal adulthood and the marriageable age in many countries is



18 years; however, the marriageable age may be older or younger in other countries. Still, cultural traditions may override legislation, as many jurisdictions permit early marriage with parental consent or in special circumstances, such as teenage pregnancy.

Meanwhile, in exceptional cases, apart from parental consent, authorisation from the court and religious laws allow for marriages below the age of 18 to hold.

A report of the United Nations Population Fund (UNFPA) shows that in 2010, 18 years was the minimum legal age for marriage for women, without parental consent or approval by the pertinent authority, in 158 countries; also, in 146 countries, state or customary laws allow girls younger than 18 to marry with the consent of their parents or other authorities. Still, in 52 countries, girls under the age of 15 can marry with their parental consent.

Most religions forbid the marriage of a female before the onset of puberty and maturity. In fact, disputes regarding physical maturity are often resolved by a scholar or a judge, potentially after examination by a female expert witness. In addition, many religions also vehemently prohibit sexual intercourse outside marriage; therefore, they establish a minimum age for marriage in one way or mother.

Early marriage allows a couple to experience adult life, while still young and strong.

Obviously, there are other factors responsible for early marriage, which include the promotion of a sense of responsibility, the guarantee of security and prevention of social decadence. The unfortunate cases of baby factories where young girls are made to reproduce essentially for illegal adoption could be avoided, even when such adoptions are common and encouraged in some developed countries.

The advocacy for early marriage, rather than child marriage, is one that hinges on the promotion and encouragement of reciprocal love, affection, alongside mutual respect and understanding, as against a union formed through compulsion or the forceful yoking of two people.

During the webinar, I pointed out that early marriage provides a safety net against poverty and deprivation, which could lead some to prostitution and drug addiction. It also protects the female, especially, from sexual violation and insecurity, particularly for those who live in or find themselves in slums and crisis zones.

We should also be mindful and aware of the fact that political and financial al-

liances between parents, beyond poverty and insecurity, are also rampant among the Northern elites, who seal these relationships by arranging marriages for their children.

Meanwhile, in most states in Northern Nigeria, newly married wives are becoming homemakers and home-entrepreneurs through skills acquisition. They now engage in tailoring, food catering and snacks making services, among others, from the comfort of their homes. Surprisingly, some of the skills being utilised and deployed are acquired through online programmes on credible social media platforms, websites and webinars, and not necessarily from conventional schools, particularly during the coronavirus pandemic

While age can occasionally be a wrong indicator of physical, emotional and psychological maturity, some good insight can be gleaned from how, in these modern times, young people are emerging as very successful entrepreneurs, who are creating huge business enterprises and empires early in life. Interestingly, some highly successful entrepreneurs have been found out to be even school dropouts. The stories of Mark Zuckerberg of Facebook, Matthew Mullenweg of Word-Press, Catherine Cook of MyYearBook.com, Blake Ross of Mozilla Firefox and even Justin Bieber, a singer and performer are proof that with focus, starting things early in life can only serve to enhance one's potentials.

The advocacy for early marriage, rather than child marriage, is one that hinges on the promotion and encouragement of reciprocal love, affection, alongside mutual respect and understanding, as against a union formed through compulsion or the forceful yoking of two people.

It is necessary to urge partners who are candidates for early marriage to be strong, confident, and supportive of each other in achieving their personal and career goals. They should also seek to be always level-headed, thoughtful, and with senses of maturity in managing their emotions. Quite unfortunately, many even above the age of 40 do not exhibit the same level of maturity displayed by a number of young people.

While the other panel members were not comfortable with some of my submissions, one of them even made bold to suggest that the best age for marriage should be between 35 and 40 years! Nevertheless, the point I reiterated in the webinar is in support of early marriage and not a child marriage.

On this occasion of International Women's Day, we must acknowledge women for making all of us in society aware, appreciative and proud of their fundamental and remarkable contributions to our development.

Access to funds hampers growth of nutrition-sensitive businesses - govt

ONE of the key players in the Morogoro agribusiness value chain is Sokoine University Graduate Entrepreneurs incubator (SUGECO), established in 2011 to promote youth engagement in agriculture and to support nutrition-sensitive businesses in the region.

The incubator works strategically with the reputed university of agriculture to nurture the agribusiness ecosystem in the region, with credits to supporting companies such as Sanavita and Kinshaga Food Products which have also been part of the Lishe Accelerator, a program implemented by Sahara Ventures and Global Alliance for Improved Nutrition (GAIN) Tanzania.

SUGECO also works as the center for product development and technology transfer, offering business development services for SMEs, and advisor to private and public agencies on issues related to nutrition and agribusiness.

A recent report by Sahara Ventures and GAIN Alliance Tanzania on the state of nutrition-sensitive small and medium enterprises in the country has established that the region's ecosystem is growing, compliments to the role played by Sokoine University of Agriculture (SUA) and SUGECO.

The report, however, notes that there are still many challenges that need to be addressed, most notably being lack of access to high quality and attractive packaging materials, access to financing, machines to measure nutritional contents, and new markets for nutrition-sensitive products.

"The incubator play a crucial role in the region's ecosystem, and it addresses serious issues such as malnutrition, ending post-harvest losses, ending hunger, and creating employment opportunities for youths through agribusiness," said Jumanne Mtambalike, Sahara Ventures Chief Executive Officer (CEO), architects of the report.

It has also provided incentives to farmers to get involved in Orange-Fleshed Sweet Potato (OFSP) farming, also known as "Viazi Lishe, by creating a business value chain by linking farmers to local food vendors also known as "Mama Lishe" and Baba Lishe.

According to the report, the incubator which also works as a business incubator has been working with food vendors in Dumila, Kilosa Municipality, and has supported youth and women in the production, processing, and value addition of OFSP.

"The incubator has also been working with entrepreneurs helping them to learn to make healthy bread from OFSP instead of wheat. The incubator is helping the entrepreneurs by creating demands from local schools primary and secondary to adopt health OFSP bread instead of wheat bread," Mtambalike said.

Some of the notable products that emerged from the



incubator include; Akili Banana Biscuits from Kinshaga Food Products, Sanavita OFSP Flour from Sanavita, and SolarTunda Viazi Lishe Biscuits from SolarTunda.

"While at SUGECO some of the key issues we learned even though there is acceptance from the market for nutritionsensitive products and the entrepreneurs are working hard to develop their businesses, there are a lot of obstacles keep entrepreneurs from building products that meet regional and global markets standards," he added.

Founder of Kinshaga Food Products, Elia Kinshaga, shared his frustrations about building his business from the ground up and his experience engaging with financial institutions to access capital, saying that accessing loans from local banks is a back-breaking process.

"Local banks lack understanding and services packages for SMEs and treat SMEs like established businesses," Kinshaga said The company was eventually able to secure funds and raise capital but unfortunately due to the outbreak of the Corona Virus, they faced delays in production because of the difficulties in receiving a machine they need for production which is stuck in China.

"Banks demand that small businesses continue paying interests even when these businesses are not operating," Kinshaga lamented.

He also said that most agribusiness funds that are meant to de-risk SMEs while accessing loans are not designed to support the SMEs since their priority is the safety of their own funds.

"Guarantee fund managers need to rethink their models to ensure they really serve the purpose and address real problems supporting SMEs. Otherwise, the funds will just be helping the banks to maximize profit while benefiting everyone else except the intended businesses which are SMEs at early and growth stages," he said.

Another entrepreneur in the agribusiness value chain, Rachel Kingu, is the founder of Jore TZ, which offers a range of nutrition-sensitive products sold in supermarkets in Dar es Salaam, Mwanza, Morogoro, and Dodoma regions. Her experience in dealing with the local government authorities to access funding dedicated to youth and women groups has left her with a bad aftertaste.

She said that she was involved with a women's group in which she served as a secretary and at one point the group sought funds from Mvomero local government authorities but was disappointed by the sheer lack of commitment by members of the group.

"The lack of commitment on the part of the women involved in the group made it a struggle to return the funds they received from the local government. Out of the ten women involved during the loan application process, only two remained to manage the original project," she said bitterly.

Kingu has advised the government to rethink how it dishes out funds to youth and women with the focus being on supporting actual businesses instead of groups.

Global Alliance for Improved Nutrition (GAIN) Tanzania and Sahara Ventures have been collaborating to support nutrition-sensitive SMEs in the country to attain technical and investor readiness and contribute to the national economic development and nutrition agenda.

Nutrition-sensitive SMEs are more than just businesses that add value to agriculture; they also help people understand the need of consuming nutritional foods in order to address malnutrition

In 2015, more than 2.7 million Tanzanian children under 5 years were estimated to be stunted and more than 600,000 were suffering from acute malnutrition, of which 100,000 were severe cases, according to Unicef.

Ten regions account for 58 percent of all stunted children and five regions account for half of the children suffering from severe acute malnutrition in the country.

Given the importance of nutrition in the overall physical and cognitive development of children, there is a need to focus on the first 1,000 days of a child's life to prevent the negative effects of malnutrition from becoming irreversible.

Unicef argues that investing in nutrition is essential for Tanzania to progress. It is estimated that the country will lose USD 20 billion by 2025 if the nutrition situation does not improve. In contrast, by investing in nutrition and improving the population's nutritional status, the country could gain up to USD 4.7 billion by 2025.

As such supporting these businesses is vital for a myriad of reasons with benefits that spread wide and far.

Hunger hotspots: FAO-WFP early warnings on acute food insecurity

CUTE hunger is set to soar in over 20 countries in the coming months without urgent and scaled-up assistance, warn the UN's Food and Agriculture Organization (FAO) and World Food Programme (WFP) in a

new report issued over the weekend.

Yemen, South Sudan and northern Nigeria top the list and face catastrophic levels of acute hunger, with families in pockets of South Sudan and Yemen already in the grip of or at risk of starvation and death according to the **Hunger Hotspots report. **

Although the majority of the affected countries are in Africa, acute hunger is due to rise steeply in most world regions - from Afghanistan in Asia, Syria and Lebanon in the Middle East, to Haiti in Latin America and the Caribbean.

Already, over 34 million people are grappling with emergency levels of acute hunger (IPC4) - - meaning they are one step away from starvation - across the world.

"The magnitude of suffering is alarming. It is incumbent upon all of us to act now and to act fast to save lives, safeguard livelihoods and prevent the worst situation". said FAO Director-General QU Dongyu.

"In many regions, the planting season has just started or is about to start. We must run against the clock and not let this opportunity to protect, stabilize and even possibly increase local food production slip away," urged Qu.

"We are seeing a catastrophe unfold before our very eyes. Famine -- driven by conflict, and fuelled by climate shocks and the COVID-19 hunger pandemic -- is knocking on the door for millions of families," said WFP Executive Director David Beasley.

"We urgently need three things to stop millions from dying of starvation: the fighting has to stop, we must be allowed access to vulnerable communities to provide life-saving help, and above all we need donors to step up with the US\$ 5.5 billion we are asking for this year," he added.

Conflict, COVID-19 amongst key drivers of acute food insecurity

One or a mix of the following factors are behind the projected rise in acute food insecurity in the 20 hunger "hotspots" between March and July 2021.

Conflict or other forms of violence may protract or is likely to increase in parts of Afghanistan, Central African Republic, Central Sahel, Ethiopia, northern Nigeria, northern Mozambique, Somalia, South Sudan and the Sudan.

COVID-19 will continue to impact numerous countries around the world, leaving them highly vulnerable to economic shocks. Latin America is the region hardest hit by economic decline and will be the slowest to recover. In the Middle East, Yemen, Syria and Lebanon are seriously affected by a rapid currency depreciation and skyrocketing inflation.

Climate extremes and la Niña****-driven weather will likely continue in April and May, driving hunger in several parts of the world -- from Afghanistan, Madagascar to the Horn of Africa.

Desert Locust outbreaks in East Africa and on the Red Sea Coast remain of concern. In Southern Africa, in parts of Angola, Botswana, Namibia, Zambia and Zimbabwe, African migratory locusts threaten to ravage the summer crops

Increasingly constrained access in some countries to help people in need has been making things worse.

 U^{****} rgent, at-scale action needed to stop rising hunger and risk of famine The report recommends critical short-term actions in each hunger hotspot to address existing and future needs.

These range from scaling up food and nutrition assistance, distributing drought-tolerant seeds, treating and vaccinating livestock to rolling out cashfor-work schemes, rehabilitating water-harvesting structures and increasing income opportunities for vulnerable communities.

Agricultural production is possible and essential, especially where access is constrained and people are even more reliant on local production.

Earlier this month, FAO and WFP called for US\$ 5.5 billion to swiftly scale up actions and avert famine through a combination of humanitarian food assistance, cash and emergency livelihoods interventions.

Hunger hotspots -- up close

People in South Sudan, Yemen and northern Nigeria remain most at risk of rising and dangerously high acute food insecurity. In Burkina Faso, food security has slightly improved since last October, but the situation is still very concerning.

In South Sudan, in parts of Jonglei State, people were likely already grappling with famine last October and November, and will continue to do so through this April-July lean season. FAO and WFP call for urgent and at-scale action now to stop likely widespread starvation and death, as well as a complete collapse of livelihoods in these areas.

Over 7 million people across South Sudan are projected to fall into crisis or worse levels of acute food insecurity, including over 100,000 at catastrophe level (IPC5), during April-July - 700,000 more since the same period last year.

In Yemen, continued violence and economic decline as well as severe disruptions to the humanitarian response are likely to persist over the coming months.

In Al Jawf, Amran and Hajjah governorates, the number of people in catastrophe level of food insecurity is estimated to triple -- reaching 47,000 in June 2021, up from 16,000 in October--December 2020.

With already highly vulnerable populations, severe malnutrition, rising displacement and the deteriorating economic situation, the risk of famine in Yemen is increasing.

Overall, over 16 million Yemenis are expected to face high levels of acute food insecurity by June 2021, an increase of some 3 million since the end of last year.

In conflict-hit northern Nigeria, projections for the June-August lean season show that the number of people in emergency level of acute food insecurity is likely to almost double - to over 1.2 million -- since the same period last year. In the next six months, food and nutrition insecurity is set to rise considerably in northern Nigeria with some 13 million people affected unless food and livelihood assistance is scaled up.

Burkina Faso has seen a slight improvement in food security since June 2020 due to a good agricultural season and people in remote and previously, inaccessible areas reached with food. But the situation remains very worrying and needs close monitoring as violence is likely to continue pushing people into acute food insecurity.

Improving the electoral system of Hong Kong is imperative, justified and legitimate

HE National People's Congress (NPC), China's top legislature, on March 11th, adopted a decision on improving the electoral system of the Hong Kong Special Administrative Region (HKSAR) by an overwhelming majority vote during the fourth session of the 13thNPC, which has drawn wide attention. This is a major event in the political life of the people in Hong Kong, as well as a crucial step towards the steady and sustained implementation of the "one country, two systems" principle.



But it is regrettable that some countries interfere in China's internal affairs and interprets the said decision maliciously, calling black white. On this decision, I have some key points of view to share with our Tanzanian friends.

I. Improving the electoral system of the HKSAR is imperative and urgent. During the 150-plus years of colonialism, there was no democracy in Hong Kong, and its people did not even have the right to match on the streets. It was only after reunification with the motherland that Hong Kong had really started the development of democracy. The Chinese Central Government has steadily promoted the development of Hong Kong's democratic political system and ensured that Hong Kong residents enjoy unprecedented democratic rights and freedom in accordance with the law.

However, in recent years, the electoral system of the HKSAR has shown some defects. With the support of some external forces, the anti-China rioters and the advocates of "Hong Kong independence" have been trying to capitalize on these defects to challenge the constitutional order in HKSAR and jeopardize the national sovereignty and security of China. The political security and social stability of Hong Kong have also been threatened due to the unsound electoral system. Therefore, the Chinese Central Government believes it is extremely urgent to revise and improve the electoral system of the HKSAR and let patriots govern Hong Kong. This initiative has been echoed and supported by people from all walks of life in Hong Kong.

II. Improving the electoral system of the HKSAR is justified and reasonable. Hong Kong is a special administrative region of the People's Republic of China. The design, development, and improvement of the electoral system in Hong Kong is an inviolable right of the central government. That the Central Government decides the electoral system of regions is the common legal system and political bottom line of all unitary states.

It is a basic political ethic that the jurisdiction of Hong Kong must be in the hands of patriots. Over the past 20-plus years since Hong Kong's reunification with the motherland, facts have proved that a small number of anti-China rioters in Hong Kong will bring destruction, turbulence, and terror to Hong Kong only. Is there any country in the world that would give the jurisdiction of any part of its territory to the hands of those who advocate or engage in separatist activities? Only patriots can truly strive for the well-being of Hong Kong people, bring prosperity and stability to Hong Kong, and promote the common development of Hong Kong and the motherland.

Ill. Improving the electoral system of the HKSAR is constitutional and lawful. The Constitution of the People's Republic of China stipulates that the NPC has the right to decide on the establishment and system of special administrative regions, including the electoral system. What's more, some provisions in the Basic Law of the HKSAR stipulate that the ultimate aim of the Hong Kong political system reforms is the selection of the Chief Executive and the election of all members of the legislative council (Leg Co) by universal suffrage. Improving the electoral system of the HKSAR this time does not modify these provisions, and the aforementioned ultimate aim has not changed at all.

In fact, some anti-China groups in HKSAR backed by external forces have jeopardized the constitutional order and the rule of law in Hong Kong as well as China's national security. The purpose of improving the electoral system of HKSAR is to maintain the authority of the Constitution of the People's Republic of China and to ensure that the development of democracy in Hong Kong returns to the right track determined by the Basic Law of the HKSAR.

IV. The principle of non-interference in other country's internal affairs remains the cornerstone of international law, which will never fade. As we always say, justice will prevail. On March 5th, a joint statement from 70 countries including Tanzania was delivered at the 46thsession of the United Nations Human Rights Council, reiterating their support for China's "one country, two systems" principle and measures taken in relation to Hong Kong.

Every country has the right to explore its own political system and democratic form which suit its own national conditions. As Tanzania choose the unique Union Government System to maintain national unity and socio-economic development, the Chinese people have adopted the "one country, two systems" principle which has been playing an important role in safeguarding China's sovereignty, security, development interests, and Hong Kong's long-term prosperity and stability.

The decision on improving the electoral system of the HKSAR conforms to the principle of "one country, two systems", meets the realities in the HKSAR and serves to ensure that Hong Kong is administered by those people who love China and love Hong Kong. We hold a firm belief that "patriots administering Hong Kong" is conducive to maintaining stability and promoting prosperity in the HKSAR.

World's biggest shipping giants send vessels towards SA amid Suez blockage


THE world's biggest shipping container companies have redirected their vessels to the route around South Africa as the Suez Canal remains blocked.

On Saturday, The Guardian reported that the world's biggest shipping group Maersk has rerouted two of its ships, and in a statement issued late on Friday, the second-biggest company Mediterranean Shipping Company (MSC) announced that eleven of its vessels have been rerouted around the coast of South Africa.

The Ever Given ran aground in the Suez canal on March 23 due to high winds from a sandstorm. The vessel is one of the world's largest container ships - it's roughly twice the length of the iconic Ponte apartment tower in Johannesburg.

"MSC expects this incident to have a very significant impact on the movement of containerized goods, disrupting supply chains beyond the existing challenges posed by the COVID-19 pandemic," MSC said in a statement.

More than 90 vessels pass through the canal on a typical

day, and with queues building, some of the world's largest ships have changed course away from the Suez, and towards the Cape of Good Hope instead. This includes large oil and gas tankers that have also changed course in the middle of the North Atlantic Ocean before diverting to go around the Cape, CNBC reported.

"We are seeing not only containerships rerouting in both directions but also LNG carriers and dry bulkers from the US Gulf of Mexico," Peter Sand, chief shipping analyst at BIMCO, told CNBC. "The vessels are taking a sharp turn to the right in the middle of the Atlantic to head south towards the Cape of Good Hope to avoid the logjam around Suez."

Among the ships heading towards South Africa is the "mega ship" Ever Greet, which is operated by the same Taiwan-based company (Evergreen) as the Ever Given.

On Friday morning, the international vessel tracking platform Fleet-Mon reported that another ultra-large container ship, the HMM Rotterdam, was on her way from China to the Netherlands, but made a U-turn around Gibraltar to head away from the Suez towards the Cape.

The Hyundai Prestige has also changed course away from the Suez Canal to the Cape, on her way from Thailand to the UK, the shipping platform Marine Traffic reported. A Transnet spokesperson told Business Insider that the detours could result in some vessels using local ports for refuelling services.

KENYA Airways' pilots are earning millions of shillings despite working less than a third of the legally set flying hours amid a legal standoff that has blocked plans to lay off half of them. The workers union has frozen Kenya Airways (KQ) plans to cut up to 207 of the 414 pilots on the carrier's payroll last year over the next three years.

This has seen the pilots to work for an average of 30 hours monthly compared to the legally set limit of 105 hours and normally acceptable target of 72 hours following the coronavirus crisis that hit demand

Idle KQ pilots make millions amid losses

Although the pilots are currently being paid 70 percent of their salaries due to Covid-induced pay cuts, they are technically on full pay because the airline is expected to settle the balance once it returns

KQ last year said the pilots account for 10 percent of the airline's total workforce, but take home the equivalent of 45 percent of the overall pay to employees or Sh6.48

billion based on the carrier's wage bill for the year to December. This means that on average a KQ pilot costs the company Sh1.3 million, which matches the salaries and allowances of top chief executives of Stateowned firms such as KenGen, Kenya-Re and Kenya Power.

"The pilots are currently averaging 30 hours a month while the normal productivity rate of pilots is 72 hours and the legal limit is 105 hours. That means that their

productivity is less than 50 percent," KQ said in an e-mail response to the Business

The carrier's revenues plunged by more than half last year, as lockdown measures reduced passengers. KQ expects its passenger business to recover from the impact of the Covid-19 pandemic in 2024. This has reduced its need for pilots by at least half based on revenue projections. "Based on our three-year projection, we will require 50 percent to 60 percent of pilots to efficiently support the reduced operations," KQ chief executive Allan Kilavuka told the Business Daily earlier.

The airline has been involved in protracted court fights with its pilots and has also suffered from poaching of talent by wealthy Middle East carriers that can afford to pay higher wages, triggering a talent war that has made pilots among Kenya's best-paid workers.

New rule on 50kg potato packaging taking effect April 2

NAIROBI

TRADERS will from April 2 be required to adhere to the 50 kilogramme per bag rule in packaging of Irish potatoes as the agriculture regulator moves to enforce the directive that is meant to safeguard farmers from exploitation by unscrupulous middlemen.

The Agriculture and Food Authority (AFA) in collaboration with the Ministry of Interior and stakeholders in the value chain have set out an elaborate programme for implementation of the Irish Potato business regulations after many years of stalling due to litigation from brokers.

"Key in the implementation process is to ensure packaging in the required standard of 50Kg. The enforcement will be executed in the entire value chain from the farm to the markets," said acting AFA Director-General Kello Harsama yesterday.

The enforcement will reverse the current scenario where potatoes are packaged in 110 kilogramme bags, subjecting farmers to losses. Mr Harsama said inspectors have been recruited and duly briefed ahead of the crackdown across the potato growing counties and major markets.

The inspectors will work with the law enforcement agencies from the national and county governments. A sensitisation campaign will start next Tuesday across the major Irish potato growing counties, targeting farmers, traders and transporters.

Total evacuates workers from Mozambique project after attack

FRENCH oil giant Total SE is evacuating most of the remaining employees from its liquefied natural gas project in northern Mozambique as insurgents attacked a town nearby, throwing Africa's biggest private investment into disarray.

The fresh violence that follows attacks at the turn of the year suggests Mozambique's armed forces are struggling to regain control of the region surrounding the \$20 billion project. Total, which bought a 26.5% stake in the LNG development for \$3.9 billion in 2019, has said it wants security to be restored in the area before resuming onshore work with the aim of starting gas shipments in 2024.

Total has decided to reduce the workforce on the Afungi site to a minimum, the company based near Paris said in a statement Saturday. The resumption of work that was contemplated at the start of the week will also be suspended, it said. The energy giant said it "trusts" the government, whose security forces are "currently working" to take back the control of the area. There were no casualties among employees at the project, Total said.

The pullout comes as militants attacked a security convoy attempting to rescue more than 180 people who'd been under siege in a hotel near the project site, according to three people

familiar with the matter. More than a dozen vehicles were ambushed

late Friday during an operation to evacuate people from the Amarula Palma Hotel, and only seven vehicles managed to escape, two of the people said. While about 100 fled to the beach, many are feared dead, according to one person. The militants, who've previously aligned with the Islamic State, were still active in the town of Palma on Saturday morning, they said. The latest attack began on March 24, the same day Total announced it would resume onshore works at its project, after fighting in late December prompted the company to evacuate staff.

The ongoing raid in Palma, less than 8 kilometres (5 miles) from Total's camp and where a number of subcontractor companies are based, could be a watershed moment in the insurgency that threatens to dampen further foreign investment in the region. The rebellion that started in 2017 has left more than 2,600 people dead and caused about 700,000 more to flee their homes.

Human Rights Watch said there were bodies on the streets in Palma, with residents fleeing after the assailants fired indiscriminately. Omar Saranga, the Ministry of Defense spokesman, declined to comment by phone, saying the government would issue a state**ALERT**

South Africa set to pay well up to Rand 218 billion for power ships

JOHANNESBURG

KARPOWERSHIP, a unit of the Turkish Karadeniz Energy Group, is on track for its longest contract to date to supply power from vessels to South Africa in a deal worth as much as R218-

The company that advertises a "fast, flexible, reliable" solution of floating electricity generation was named last week as a preferred bidder for three projects fuelled by liquefied natural gas to provide 1.2GW of electricity. The programme is aimed at closing a supply gap in South Africa that's resulting in periodic blackouts.

The 20-year deal will cost as much as R10.9-billion annually, according to a presentation by the CSIR. The estimate is based on the department of mineral resources & energy's evaluation price of the bids. It didn't immediately reply to requests for comment.

The award adds a significant amount of generation capacity from fossil fuels for two more decades as South Africa plans a move away from coal that dominates its current power supply and has made it the world's 12th biggest source of greenhouse gases. Other, smaller projects chosen use a mix of solar and wind with batteries and LNG.

"Power ships have proven effective at providing fast-response, emergency electricity - hence the maximum 10year tenure for past contracts," said Antoine Vagneur-Jones, an analyst at BNEF's energy transition policy team for Europe, Middle East and Africa. "That the South African government would procure one for 20 years speaks to the depths of the country's power crisis, and questionable long-term planning in light of dropping renewables costs."

Deal with Shell

The agreement also allows for variable charges, including fuel. "Costs are kept low by Karpowership's reach into the LNG market and an exclusive, longterm deal with Shell," the company said in reply to questions.

The company started pitching power from vessels to be moored off South Africa's coast at least six years ago. More recently it has been looking to expand on the continent, including in two West African countries that it declined to identify in a January inter-

South Africa's department of environment, forestry & fisheries last year revoked an environmental exemption granted to Karpowership because it failed to disclose fully its reasons for the application. Prices have varied among Karpowership contracts and may not always include fuel supply.

Lebanon paid \$0.05/kWh on a three-year contract, according to data compiled by Bloomberg New Energy Finance, while South Africa's evaluation price posted for Karpowership's Saldanha project is about \$0.11/kWh for 20 years.

Bailouts to limit airline consolidations over next five years, IATA chief says

GENEVA

GREATER government intervention in airlines amid the pandemic will limit consolidation within the industry in the next three to five years. Foreign ownership rules and a liquidity crunch will also slow down consolidation in the industry, Alexandre de Juniac, outgoing director general of the International Air Transport Association (IATA), has said.

"I do not believe consolidation will be very active in the coming three to five years because you still have foreign ownership limitations everywhere and because the intervention of states has increased, potentially through shareholding," he said.

"I do not see them giving up their shares in a company in which they have invested taxpayer money to sell to a neighbouring country or partner." Consolidation will also be an expensive proposition for cash-strapped airlines, said Mr de Juniac. "I do not think airlines have the money to commit to any consolidation in the next three to five years ... they don't have a penny to do that."

Governments have poured in aid worth \$225 billion to prop up airlines ravaged by the Covid-19 crisis that has shut borders, hit revenue and grounded aircraft. Iata has called on governments to support a restart in international travel through stimulus measures such as subsidies for air tickets, routes and domestic journeys.

The aviation industry will have fewer players operating smaller networks in the next three to five years, with the possibility of further bankruptcies given that many small and medium-sized airlines remain fragile, Mr de Juniac said.

A shrinking industry "is not good news" for the market and it is "not good news for passengers", he said. "It means less destinations, less connectivity and - perhaps, in some cases - higher fares and reduced competition."

The structure of the industry will remain unchanged, centred around budget and full-service airlines that will overcome Covid-induced challenges - mainly due to government support. "Long-haul, low-cost is still a question mark," he said. "It is in a very, very difficult

situation. I do not know if and when it will restart."

Mr de Juniac said the industry had probably reach the bottom of the crisis. "I hope there will be no fourth or fifth wave with a different mutation of the virus that will resist the vaccine," he said. Mr de Juniac expects a recovery that is linked to vaccination drives and efforts to contain the spread of the virus.

"The recovery will accelerate during the second half of 2021 and in 2022," he said. The resumption of travel could be "very fast and very strong", so governments and the industry must be prepared, he said.

The pandemic has had three main lessons, with the first being that airlines need to strengthen their balance sheets as the industry is "too fragile".

They also need to be better prepared with processes and equipment and, thirdly, to continue to advocate international collaboration between countries, as well as between governments and the aviation industry, said Mr de Juniac.

"We cannot deal with a world problem like this as we have done completely fragmented, no collaboration," he said. "Frankly, it is unacceptable." The executive called on governments to form a strategy to reopen economies and borders while they vaccinate and conduct tests to curb the spread of the pandemic.

"This gives people more reason to follow tough measures that are

"We think that we should do more. We will probably, in the coming months, set up more ambitious targets. The industry is ready for that. We are convinced we have to do it," he said. "Even in this crisis we are still thinking long term to comply with our responsibility for the planet," he said.

The industry contributes 2 per cent of global carbon emissions and pledged to reduce net emissions to half of 2005 levels by 2050. Mr de Juniac said biofuel would be a key contributor to carbon reduction in the next 20 years because "it is safe and it works."

There is need for a commitment from the industry to use sustainable aviation fuel, in addition to significant government investment to scale up its production and distribution networks. "It is really surprising to see that governments have invested billions and billions on renewable energy everywhere and they are not putting a penny into sustainable aviation fuels," he said.

Meanwhile, Iata continues to maintain and push for its gender balance programme called 25 by 2025. The Iata boss will hand over the reins to IAG veteran Willie Walsh in April, after more than four years at the helm. The start of Mr de Juniac's tenure at the lobby group was marked by a decade of airline profitability.

However, he faced mounting challenges that rocked the industry - from two Boeing 737 Max crashes to Britain's complicated exit from the EU, the long-term crisis of climate change and Covid-19. Mr de Juniac, whose motto was aviation is "the business of freedom", said this has never been more true than now.

Smartphone maker Xiaomi 'to make electric cars'

BEIJING

CHINA'S Xiaomi plans to make electric vehicles (EVs) using Great Wall Motor's factory, said three people with direct knowledge of the matter, making it the latest tech firm to join the smart mobility race.

The tech firm's stock price was up more than 9% in afternoon Friday trade after Reuters reported the plan. Great Wall's Hong Kong stock rose more than 15% and its Shanghai shares gained by their maximum 10% daily limit.

Xiaomi, one of the world's biggest smartphone makers, is in talks to use one of Great Wall's plants in China to make EVs under its own brand, said two of the people, who declined to be identified as the information is not public. Xiaomi will aim its EVs at the mass market, in line with the broader positioning of its electronics products, the two people said.

Great Wall, which has not before offered manufacturing services to other companies, will provide engineering consultancy to speed up the project, said one of the people. Both companies plan to announce the partnership as soon as early next week, said another person. Xiaomi and Great Wall declined to comment.

Diversifying

The plan comes as Xiaomi seeks to diversify its revenue streams from the smartphone business which accounts for the bulk of its income but carries razor-thin profit margins. It flagged on Wednesday rising costs from a global chip shortage and reported quarterly revenue below market estimates. The move also comes against the backdrop of automakers and tech firms working closer together to develop smarter vehicles with technology such as smart cabins and autonomous

Chinese search engine provider Baidu said in January it plans to make EVs using an auto plant owned by Geely – a car maker with aspirations to offer engineering consultancy and contract manufacturing.

From smartphones to EVs

Apple and Huawei Technologies also have ambitions to build electric cars. Xiaomi's founder and chief execu-

tive, Lei Jun, believes the firm's expertise in hardware manufacturing will help accelerate the design and production of its EVs, one of the people said.

"Xiaomi wants to find a mature automobile manufacturer to provide model infrastructure, enabling its own advantages in mobile Internet technology," said Alan Kang, senior analyst at LMC Automotive. "Xiaomi's advantages in operating systems and home furnishing also bring a lot of imagination for such cooperation in the future." Alongside smartphones, Xiaomi makes dozens of Internet-connected devices including scooters, air purifiers and rice cookers. The firm plans to launch its first EV around 2023, one of the people said. It will enable its cars to connect with other devices in its product ecosystem, the people said.

Baoding-based Great Wall, China's biggest bakkie maker, this year launched a standalone brand for electric and smart vehicles. It is also building an EV factory in China with Germany's BMW. The automaker sold 1.11 million vehicles last year helped by the popularity of models such as the P-series bakkie and Ora EVs. It is currently building its first factory in Thailand.

South Africa plans to vaccinate 200,000 people daily

JOHANNESBURG

SOUTH Africa is targeting vaccinating about 200,000 people a day from mid-May as the government seeks to scaleup inoculations to tackle the pandemic, according to Health Minister Zweli Mkhize.

The government has set up 2,000 centers where the doses would be administered, Mkhize told the Sunday Times newspa-

Just over 230,000 people have been inoculated in South Africa so far.

Shortages of doses threaten to upend South Africa's plans handful of rich countries, and to vaccinate two-thirds of a a darker reality emerges: The population of about 60 million

people this year, though the country is set to take delivery of 2.8 million Johnson & Johnson vaccines at the end of April.

But move away from this virus is still rampaging around



most of the planet, and uneven vaccine distribution poses a major public risk as variants emerge.

Since mid-March, COVID-19

deaths have started trending upward again worldwide even as the numbers improved in the US and UK, according to Johns Hopkins University (JHU) data.

So far, over 126.61 million confirmed cases and more than 2.77 million deaths have been reported across the world, according to JHU data.

Worldwide, half a billion vaccine doses have been administered, according to Bloomberg's vaccine tracker. While shots have been given in some 140 countries, the vast majority have gone to developed nations that secured early doses by the hundreds of millions. That disparity risks prolonging the pandemic, even for places current-

ly leading the vaccination race. The World Health Organization (WHO) has been particularly condemning rich countries, saying they are directly responsible for the deaths of high-risk people in low- and middle-income countries, USA

Today reported on Thursday. "Countries that are now vaccinating younger, healthy people at low risk of disease are doing so at the cost of the lives of health workers, older people and other at-risk groups in other countries," the report quoted WHO Director-General Tedros Adhanom Ghebreyesus as saying at a news conference on Monday. **Agencies**

Russia likely to achieve herd immunity against COVID-19 by late summer, says Putin

MOSCOW

President RUSSIAN Vladimir Putin expects that herd immunity against COVID-19 in Russia will be developed by the end of summer.

In an interview with Moscow. Kremlin. Putin (pictured) programme on Rossiya-1 TV channel, answering a question when

the pandemic restrictions in Russia could be lifted and the country would return to a normal life, the president assured that "this will happen."

He recommended to "listen to specialists" who say that restrictions could be lifted "after herd immunity is devel-

"In order to make this happen, some 70% of adult population should get the jab. If [mass vaccination] goes at the same pace as now, I believe that in summer, by the end of summer we will achieve, we should achieve this figure," the president stressed.

Three vaccines against COVID-19 have been registered in Russia. The first vaccine registered in the country and in the world is Sputnik V, developed by the Gamaleya Center of Russia's Health Ministry. It was certified on August 11,

EpiVacCorona by the Vector State Research Center of Virology and Biotechnology of the consumer rights watchdog was registered in October 2020. The third vaccine CoviVac by the Russian Academy of Sciences' Chumakov Center was authorized by the Health Ministry in February.

Russia launched mass vaccination against COVID-19 in January 2021. According to the latest data, more than 6 mln Russians have received one vaccine dose and more than 4 mln of them have taken two doses.

Sudan and rebel group sign agreement on separation of religion and state

JUBA

THE Sudanese government and a major rebel group from its southern Nuba Mountains yesterday signed a document which paves the way for a final peace agreement by guaranteeing freedom of worship to all while separating religion and the state.

The signing is viewed as a crucial step in efforts by the power-sharing government headed by General Abdel Fattah al-Burhan to reach accords with rebel groups across the country and end decades of conflicts that left millions displaced and hundreds of thousands dead.

Last year Sudan signed a peace agreement with many groups, including from the Western region of Darfur.

But a key faction of the Sudan People's Liberation Movement-North (SPLM-N) led by Abdelaziz al-Hilu, did not join in last year's agreement because it stuck to its demand that Sudan dispenses with sharia law and becomes a secular, democratic state.

Sharia law was first imposed in Sudan in 1983, and maintained by the now deposed president Omar al-Bashir for the duration of his 30-year-long Islamist rule.

The so-called 'Declaration of Principles' signed on Sunday in South Sudan's capital Juba between Sudan and the rebel faction means talks on a final accord can now begin.

The declaration stated that both sides agreed to "the establishment of a civil, democratic federal state in Sudan, wherein, the freedom of religion, the freedom of belief and religious practices and worship shall be guaranteed to all Sudanese people by separating the identities of culture, religion, ethnicity and religion from the state."

"No religion shall be imposed on anyone and the state shall not adopt official religion," it said, without specifying that Sudan would become a secular state, a controversial issue in the country's transition.

Aman Amum, the Secretary-General of SPLM-N told Reuters yesterday that reaching a consensus on the role of religion in Sudan's politics was a breakthrough that would now accelerate talks towards a final peace settlement. Sudan had now "accepted the separation of religion

from the state," Amum said.

It had been unclear whether Sudan's military, which shares power with a civilian executive branch, would support any such moves after years of backing Islamists.

Civilian prime minister Abdalla Hamdok signed a similar declaration with al-Hilu last year.

Sudan has been wracked by conflicts for decades. After the oil-rich south seceded in 2011, an economic crisis fuelled protests that led to the overthrow of Bashir in 2019.

SPLM-N has been operating in a region inhabited by minority Christians and followers of African beliefs who complain of long discrimination under Bashir's rule.

China's foreign trade continues gaining momentum in spring of 2021

CHINA'S total value of foreign trade in goods in the first two months of 2021 reached 5.44 trillion yuan (\$836.1 billion), up 32.2 percent year on year. In particular, the country's exports registered a remarkable 50.1-percent growth rate from the same period last year. China's foreign trade has maintained momentum since resuming

positive growth last June. As China makes constant efforts to push forward with higher-level opening up, the country is obtaining greater competitive edges in global markets with the help of such growth drivers as technology research and development, talent cultivation, China-Europe freight trains, as well as cross-border e-commerce.

Cybrid Technologies Inc., a Chinese company mainly engaged in the development, production, and sales of functional polymer materials, had over 80 percent of its production lines operating during this year's Spring Festival holiday in February.

"There are so many orders, and everyone is energetic at work," said Wu Xiaoping, president of the company.

As a leading enterprise in the global photovoltaic (PV) panel market, Cybrid Technologies Inc. witnessed shrinking overseas market and declining exports at the beginning of last year due to the COVID-19 pandemic.

In the face of new difficulties, the company adopted a package of countermeasures timely and maintained its market share amid the pandemic. It has intensified efforts to get new customers in regions including Southeast Asia and Japan, and consolidated cooperative relations with old overseas clients through efforts to send antiepidemic supplies to its foreign clients and provide them with technical services via video link

What's more important for the company is to hone its abilities, Wu said, stressing that technological innovation is where its core competitiveness lies and professional personnel hold the key to the company's develop-

Cybrid Technologies Inc. raised its number of research and development personnel from 70 to more than 100 last year, and intends to bring the number to 150 this year.

Not long ago, the company established a school, which offers courses regularly to cultivate a number of versatile employees who can shoulder the main responsibility in the company. Innovation is the driving force for high-quality development of trade and the key to improving the value-added level of commodity value chain, said Wang Xiaohong, deputy director of the Information Department of China Center for International Eco-

nomic Exchanges. Since the cost of production factors rises continuously, traditional comparative advantages are declining, and export commodities have relatively low

additional value, companies should speed up efforts to shift the driver of foreign trade from production factors to innovation, Wang noted.

While the COVID-19 pandemic took a heavy toll on global logistics industry last year, China-Europe freight trains, which feature high efficiency, wide coverage, all-weather stable operation, and low cost, served as an important bridge and fast channel connecting the continents of Europe and Asia.

China-Europe freight trains made a record 12,406 trips and carried a total of nearly 1.14 million twenty-foot equivalent unit (TEU) of cargo in 2020, marking year-on-year growth rates of 50 percent and 56 percent respec-

"This year we will send 3,800 containers of goods to Robert Bosch GmbH, and ship equipment to companies like Mercedes-Benz and Honda. Our annual value of foreign trade is expected to exceed 4 billion yuan this year, more than twice that achieved in 2020," said Chen Jiangnan, an executive of an international freight forwarder in Chengdu, capital of southwest China's Sichuan province.

Fox News faces lawsuits for alleging 2020 election fabrications

DENVER

AMERICA's media network Fox News is facing a lawsuit brought by Dominion Voting Systems for allegedly spreading and reinforcing lies about the results of the 2020 presidential election.

Dominion Voting Systems, one of the largest election equipment manufacturers in the United States, has filed a defamation lawsuit against Fox News in the U.S. state of Delaware, saying the network spread false claims that the voting machine company was involved in voter fraud in last November's presidential election. Dominion was seeking at least 1.6 billion U.S. dollars in lost profits and enterprise value, plus more than 1 million dollars in security expenses and expenses combatting disinformation.

According to Dominion, the incessant conspiracy theories floated by Fox have damaged its credibility and reputation, costing it millions in revenue. "Fox sold a false story of election fraud in order to serve its own commercial purposes, severely injuring Dominion in the process," the filing read.

"What they are saying," NBC legal analyst Pete Williams explained to Yahoo News, "is that if a network continues to broadcast falsehoods even after it has been told about them, then it's actionable."

In a defiant response, Fox News issued a statement on Friday, saying that it "is proud of our 2020 election coverage, which stands in the highest tradition of American journalism, and will vigorously defend against this baseless lawsuit in court."

However, the legal pundit said as the legal system in Delaware is showcasing some of the top defamation lawyers and courts in America, Fox News may be in serious trouble.

Williams said that when Fox News' ratings started slipping, after it fell behind on election night with errant reporting, it tried to "lure voters back in by embracing this claim that Dominion had a system that allowed votes to be flipped in favor of Biden," he said.

Dominion was not the only election technology company to say it was targeted by Fox News. Smartmatic, an electronic voting systems maker, filed a 2.7-billion-dollar lawsuit against the network last month, saying that the media group had accused it of helping rig the U.S. presidential election in favor of Joe Biden.Fox News filed motions seeking to dismiss the Smartmatic lawsuit, claiming it was "meritless" and defended its reporting of the U.S. presidential election.

Fox News was created by billionaire Rupert Murdoch in 1996. **Xinhua**

Sinister intentions behind Xinjiang cotton boycott

BEIJING

RECENT claims made by enterprises like H&M and Nike of refusing to use Xinjiang cotton have triggered widespread denunciation and resistance from the Chinese public.

Behind the so-called Xinjiang cotton boycott are the sinister intentions of anti-China forces in some Western countries including the United States to smear China and suppress Chinese industry.

The Chinese government and people firmly oppose it. Cotton production in Xinjiang has long been highly mechanized and does not require a large number of cotton pickers.

The accusation of "forced labor" in Xinjiang's cotton industry is an utter lie. The ultimate intention of using such phrases as "forced labor," "concentration camps" and "genocide" is to undermine Xinjiang's security and stability and stifle China's development.

Lawrence Wilkerson, chief of staff to former U.S. Secretary of State Colin Powell, has once said that if the Central Intelligence Agency wanted to destabilize China, the best way to do so was to cause social unrest and push China from the inside.

Focusing on Xinjiang cotton has economic motives as well. Bizarre claims of "forced labor" and "human rights abuses" are mere allegations used to suppress China's textile industry.

China is the world's second largest cotton producer, and Xinjiang is the most important cotton producing region, accounting for nearly 90 percent of the country's cotton output. Steady increases in China's cotton production and the growing textile industry are making some in the United States and the West nervous.

As the world's largest cotton exporter, the United States hyped up the Xinjiang issue as early as last February during the Trump administration and has issued a ban on cotton products from Xinjiang.

Under the pretext of protecting human rights, the United States is attempting to bolster production at home. "Countless lies are being spread by people who have never been to Xinjiang," said French journalist Maxime Vivas, who recently published a book about his two trips to the autonomous region in northwest China.

The U.S. government's "genocide" accusation against China was based on data abuse and false claims of a rightwing religious extremist, according to a report published last month by the independent news website Grayzone.

During the just-ended 46th session of the United Nations Human Rights Council, Cuba delivered a joint statement on behalf of 64 countries urging relevant countries to stop interfering in China's internal affairs by manipulating Xinjiang related issues, refrain from making unfounded allegations against China out of political motivations and curbing the development of developing countries under the pretext of human rights.

China is focused on fighting terrorism and separatism in Xinjiang. It is preserving human rights in the region, not abusing them.

Western countries must quit fabricating narratives about Xinjiang and abandon attempts to undermine China's stability and development. Foreign enterprises operating in China should respect market rules and avoid politicizing commercial issues. China welcomes foreign companies and personnel to operate and grow in the country. But it resolutely opposes malicious attacks based on rumors and lies that harm China's interests.

Troops fire at funeral as Myanmar mourns bloodiest day since coup

MYANMAR security forces opened fire yesterday, witnesses said, at people gathered for the funeral of one of the 114 people killed the previous day, the bloodiest day of protests since the military coup on Feb. 1.

There were no immediate reports of casualties in the firing on the funeral in the town of Bago, near the commercial capital Yangon, according to three people who spoke to Reuters.

"While we are singing the revolution song for him, security forces just arrived and shot at us," said a woman called Aye, who was at the service for Thae Maung Maung, a 20-year-old student who was shot on Saturday. "People, including us, run away as they opened fire."

Three people were killed in firing on Sunday in separate incidents elsewhere, witnesses and news reports said. One person was killed when troops opened fire overnight on a group of protesters near the capital Naypyitaw, Myanmar Now news reported.

So far on Sunday there were no reports of large-scale protests in Yangon or in the country's second city, Mandalay, which bore the brunt of the casualties on Saturday, Myanmar's Armed Forces Day. Funerals were held in many places.

At least six children between the ages of 10 and 16 were among those killed on Saturday, according to news reports and witnesses. Protesters call the victims "Fallen Stars"

The bloodshed drew renewed Western condemnation. The U.N. Special Rapporteur for Myanmar said the army was carrying out "mass murder" and called on the world to isolate the junta and halt its access to weapons.

Foreign criticism and sanctions imposed by some Western nations have failed so far to sway the military leaders, as have almost daily protests around the country since the junta took power and detained elected leader Aung San Suu Kyi.

"We salute our heroes who sacrificed lives during this revolution and We Must Win This REVOLUTION," one of the main protest groups, the General Strike Committee of Nationalities (GSCN), posted on Facebook.

Heavy fighting has also erupted between the army and the ethnic armed groups that control swathes of the country

Military jets killed at least two members of the Karen National Union (KNU) militia in a bombing raid near Thailand and many civilians fled across the border, said David Eubank, founder of the Free Burma Rangers, a relief organisation.

In an air attack by the military on Saturday, at least three civilians were killed in a village controlled by the KNU, a civil society group said. The militia earlier said it

had overrun an army post near the border, killing 10 people.

Fighting erupted on Sunday between another armed group, the Kachin Independence Army, and the military in the jade-mining area of Hpakant in the north. The Kachin forces attacked a police station and the military responded with an aerial assault, Kachinwaves media reported.

There were no reports of casualties.

A junta spokesman did not answer calls seeking comment on the killings or the fighting.

Senior General Min Aung Hlaing, the junta leader, said during a parade to mark Armed Forces Day that the military would protect the people and strive for democracy.

'RINGING HOLLOW'

Saturday's dead included 40 people in Mandalay and at least 27 in Yangon, Myanmar Now said. The casualties took the overall number of civilians reported killed since the coup to more than 440.

Countries including the United States, Britain, Germany and the European Union strongly condemned the violence.

German Foreign Minister Heiko Maas said on Twitter: "We will not tolerate the military's brutal course of action against the people of Myanmar".

U.N. Special Rapporteur Tom Andrews said the junta

should be cut off from funding, such as oil and gas revenues, and from access to weapons.

"Words of condemnation or concern are frankly ringing hollow to the people of Myanmar while the military junta commits mass murder against them," he said in a statement.

U.N. Special Adviser on the Prevention of Genocide Alice Wairimu Nderitu and U.N. High Commissioner for Human Rights, Michelle Bachelet called the killings "shameful, cowardly, brutal actions of the military and police, who have been filmed shooting at protesters as they flee, and who have not even spared young children".

The top military officer from the United States and nearly a dozen of his counterparts said in a statement that a professional military must follow international standards for conduct "and is responsible for protecting - not harming - the people it serves".

The Myanmar military took power saying that November elections won by Suu Kyi's party were fraudulent, an assertion dismissed by the country's election commission. Suu Kyi remains in detention at an undisclosed location and many other figures in her party are also in custody.

Over 500 relics found in prehistoric Sanxingdui Ruins in South West China

OVER 500 artifacts were unearthed in the six ancient sacrificial pits newly discovered in Sanxingdui Ruins in southwest China's Sichuan Province between November 2019 and May 2020, including pieces of gold masks, bird-shaped gold pieces, and pieces of miniature ivory sculptures, said archaeologists during a meeting held in Chengdu, capital of Sichuan on March 20.

The historic site, located in Sichuan's Guanghan, is believed to be the remnants of the ancient Shu Kingdom dating back some 3,000 years to 5,000 years ago. It is hailed as one of the greatest archaeological findings in the 20th century. Discussions on it have never faded since the first two sacrificial pits were discovered in 1986.

Archaeologists practiced maximum protection over the Sanxingdui Ruins soon after the salvage excavation of the No.1 and No. 2 pits. The six newly discovered pits are similar with the No.1 and No. 2 pits in terms of shape, structure, orientation and relics unearthed.

The six new pits and the two discovered in 1986 are all in the eastern part of the ancient Sanxingdui city, surrounded by small circular pits, rectangular grooves and large grooves related to sacrificial activities, introduced Lei Yu, a researcher with Sichuan Provincial Cultural Relics and Archaeology Research Institute who heads the excavation work at the Sanxingdui Ruins site. This means that the conclusions formed upon the relics unearthed in the 1986 pits and relevant archaeological activities have to go through new challenges and tests, he added.

This time, bronze heads with colored eyes, gigantic bronze masks, bronze statues, and bronze sacred trees were unearthed in the No. 3 pit of the Sanxingdui Ruins site. Besides, hundreds of ivories were also discovered, a part of which were burned and buried with jade and bronze ware items.

The discoveries this time are of milestone significance compared with those in 1986, as

archaeologists made a new attempt to move advanced laboratories to the field, Lei said.

An emergency shelter was set up in the enclosures at the site with constant humidity and temperature to protect organic relics. The shelter was equipped with low-temperature and low-humidity cabinets, as well as low-temperature sample boxes, in which bones, horns, ivories, textiles, lacquerware and woodware can be protected.

Archaeologists also established another emergency shelter for inorganic relics, where gold pieces, bronze ware, jade and potteries could be protected by ion chromatography and extraction devices. Besides, excavation data and videos were also recorded and transmitted. These techniques guaranteed synergetic excavation and protection, multi-discipline integration and multi-party collaboration.

Sun Hua, professor with Peking University noted that the excavation this time wasn't just about unearthing relics, but also discovering, with technological means and theoretical models, how these relics were buried, so as to help archaeologists gain a better understanding of the layout of the sacrificial zone of the Sanxingdui Ruins.

The academic world has never ceased its studies on Sanxingdui civilization over the past three decades, raising a series of questions and conducting plenty of discussions, said Song Xinchao, deputy director of the National Cultural Heritage Administration.

"Today, we have a clearer picture of the history of the Chengdu Plain, and are well prepared both academically and technically, so we are able to carry out multi-discipline cooperation," he said. He also extended a warm welcome to foreign archaeologists to jointly study the Sanxingdui civilization that brings both challenges and surprises.

Sputnik V production in EU to take one year after certification, says EU

PARIS,

IT will take about a year to organize production of the Russian Sputnik V coronavirus vaccine in Europe after its certification by the European Medicines Agency (EMA), so it is unlikely to influence the coronavirus situation in European nations, EU's Internal Market Commissioner Thierry Breton said on Sunday.

"I really respect Russian scientists and I have no grounds to have any doubts in their vaccine," he stressed. "But my task as a European commissioner is to ensure enough vaccine doses. We cannot meddle with the production processes at our companies that are focused on manufacturing the existing vaccines in the coming months."

He noted that it may take a lot of time to organize production of the Russian vaccine in the European Union.

"If the vaccine is certified within weeks or months and a way of its production in Europe is found, it will take at least 10-14 months before its first batch is manufactured," Breton said. "Why not. But it will not be a response to our today's problems."

Russia was the world's first to register an anticoronavirus vaccine on August 11, 2020. The vaccine, developed by the Gamaleya National Research Center for Epidemiology and Microbiology of the Russian Health Ministry, was given the name Sputnik V. It is a vector vaccine based on the human adenovirus

In early February 2020, The Lancet, a world-acclaimed medical journal, published the results of the third phase of Sputnik V clinical tests.

The vaccine has proved to be among the world's safest and most efficient. Thus, its efficacy is estimated at 91.6% and 91.8% among volunteers older than 60. Ninety-eight percent of volunteers developed antibodies to the coronavirus.

The vaccine has been registered in 57 world nations, including EU countries Hungary and Slovakia, with an overall population of more than 1.5 billion

The European Medicines Agency said on March 4 it had begun the Sputnik V evaluation procedures to look at its compliance with the EU efficacy, safety and quality standards. The Agency anticipates that the registration of the Russian vaccine could be over by late May.

As of today, four coronavirus vaccines have been certified for use in the European Union. They are vaccines of BioNTech-Pfizer, US' Moderna, British-Swedish Astra-Zeneca, and Janssen, a US Johnson & Johnson branch.

Club dominance in African football: Can Simba SC sustain its ascendance?

SOMETHING unusual seems to be taking place in Tanzanian and African football at large, as pundits start thinking of what is likely to happen when Simba SC meets Egyptian giants, Al Ahly, in Cairo in about two weeks, on April 9.

Checking the data to make sense of overly optimistic predictions of an avalanche of local pundits supporting the Msimbazi Street outfit, it was a bit surprising to see that same stance repeated in rapid assessments online.

Simba appears to have a better match result record in tackling the Egyptian champions and veteran winners of the Africa Club Champions League, but is this misleading?

Trying to direct attention to some other factor explaining this situation becomes a problem, as there is an expression that 'numbers don't lie,' in which case the kind of impression that one gets from the numbers must be right, and that is what the pundits affirm.

Yet the wish to dispute that impression persists, as unike Al Ahly, Simba has a poor record in upper levels of the Champions League, despite edging closer to the group stage in a regular manner as years come and go.

For once it looks like the most impressive team in East Africa, rivaled by top Congolese clubs or East and Central Africa top honours.

Still it seems South African clubs are at a different level when it comes to eastern, central and southern Africa lists.

There was a rather misleading statistic that was made plenty of Al Ahly lately, and their results in that match tended to boost the nearly mythical status of how powerful the local side has become.

The statistic was affirming that since November 2019 the only time that Al Ahly had lost a match was its encounter with Bayern Munich in inter-continental tournament semi-final a few weeks earlier, which of course is beside the point.

Not many clubs outside the UEFA top level can stave off a 2-0 outcome if faced with the German giants, definitely.

The trouble with soccer is that mathematics (numbers) appear to lie in soccer if they say the right thing elsewhere, as a team that defeats Al Ahly and then has problems obtaining a good result with Ruvu Shooting in the local premier league might not sound altogether convincing.

To wit, a Mwanza club, Mbao FC, survived relegation three years ago or thereabouts by defeating Yanga in one of its last matches, and it is likely (by rough memory) that the club had defeated Yanga in an earlier encounter and had reason to be confident about the match.

And Yanga appeared to have no ready answer at

In the constraint of data and actual game analysis, it is plausible to say that the Yanga-Mbao FC results or even two results may in a way serve as an image of the Simba-Al Ahly results, that the Msimbazi Street side are now definitely among the 'premier league' sides in African football, and not just as perennial Tanzanian champions.

There is something else, that the team is increasingly more assured of reaching the group stage, unlike in the past where it was almost certain it would fail against good clubs, and often they aren't picked from the neighbourhood as with CECAFA Kagame Cup tournaments. They usually come far quite far.

Pursuing this example one can say that just like Yanga took time to learn the lessons needed from bad results in playing Mbao FC, in like manner Al Ahly are taking time learning lessons from their encounters with Simba SC.

One plausible reason is that Simba may have been improving - given its preoccupation with doing well milking from it, at the time that the in the Champions League while Al Ahly have no such local giants were preparing to tackle worry - in which case the side from Tanzania that itself.

Al Ahly encounters time and again is tactically different from the one they played with at an earlier stage, which can in a sense be said of Mbao FC and Yanga.

The former were taking time to digest lessons from various matches in preparing to tackle Yanga, while the latter were checking

Put differently, it can be said that local pundits are going too far in casting Simba SC not just as an equal of Al Ahly but perhaps the only club that the Egyptian side fears in the wider neighbourhood, apart from local competition in Egypt.

It is to raise Simba to the same rank as the likes of Raia Casablanca or TP Mazembe, the less consistent Enyimba, AC Horoya, Etoile du Sahel and a few others, while the picture one gets is that Simba are a rising side, and at times they are giant killers as with Al Ahly matches lately.

Not more can be said in that direction, as to confirm status as among giant continental clubs needs a track record, one of whose cardinal elements is ability not to reach groups and even quarters, but the final

Ronaldo rages after no-goal call denies Portugal win vs. Serbia

BELGRADE

PORTUGAL's Cristiano Ronaldo stormed off the pitch seconds before the final whistle after he was denied a clear winner in a controversial climax to their World Cup qualifier against Serbia, who fought back from two goals down to snatch a 2-2 draw on Saturday.

Ronaldo was left fuming in stoppage time when his effort was cleared by Serbia defender Stefan Mitrovic after it had crossed the line, with Dutch referee Danny Makkelie waving play on and with no VAR in place to review the de-

Ronaldo threw his captain's armband on the floor before leaving the pitch and heading for the tunnel seconds before the fulltime whistle in a thrilling Group A qualifier.

A Diogo Jota double had given Portugal a 2-0 lead in the first half but Serbia striker Aleksandar Mitrovic became his country's alltime top scorer on 39 goals from 63 international appearances after he pulled one back in the 46th minute.

The Serbians, who ended the match with 10 men, earned a share of the spoils when Filip Kostic levelled and Portugal's misery was completed in stoppage time with Ronaldo also booked for dissent when his effort was denied.

"There are moments which are tough to digest especially when we feel the entire nation is being punished," Ronaldo said on Instagram. "We will keep our heads up and move on to the next chal-

Seconds earlier, Serbia defender Nikola Milenkovic was sent off having received a straight red card for a rash challenge on Portugal midfielder Danilo Pereira.

The result left both sides on four points from two games, with Serbia topping the group ahead of Portugal on goals scored while Luxembourg are third on three points from one game after a shock 1-0 win at Ireland.

Portugal coach Fernando San-

tos was gracious in accepting the result although he said it was unacceptable not to have VAR at this level of competition.

"The referee apologised to me straight after the game and we now have to move on," he told a news conference.

"It was a clear goal but there is nothing we can do now. We controlled the first half but lost our focus in the second and failed to contain Serbia as they surged for-

Serbia coach Dragan Stojkovic, who made five changes to the side that beat Ireland on his national team debut on Wednesday, was philosophical about the incident.

"I never comment on referee's decisions whether they go our way or not. Mistakes by officials are part of the game and should be viewed as such. I didn't see it clearly, I can only pass a verdict after I've seen the replay.

"Ronaldo is a great player but we largely contained him tonight and in the second half we showed true grit and character to fight back from two goals down.

"We always knew what to expect from a top team like Portugal but against such opposition you have to be brave and never give up. This group of players is quickly learning that."

Liverpool forward Jota fired European champions Portugal ahead with an 11th-minute header from a superb Bernardo Silva assist and added another in the 36th as he glanced a Cedric Soares cross from the right.

But Serbia roared back at their Rajko Mitic stadium and halftime substitute Nemanja Radonjic, who engineered both their goals, gave his markers a roasting after the break and also drew a fine save from Portugal goalkeeper Anthony Lopes.

DUTCH BOUNCE BACK

The Netherlands got its World Cup qualification back on track by beating Latvia 2-0, while Turkey continued its strong start in Group G with a 3-0 victory over Norway to go top on goal difference.

Steven Berghuis curled in a leftfooted shot in the 32nd minute and Luuk de Jong headed home a corner in the 69th as the Netherlands rebounded from a 4-2 midweek defeat in Turkey.

In a match played in the Spanish city of Malaga, Ozan Tufan scored a goal in each half and Caglar Soyuncu headed his country's second goal as Turkey easily beat Norway.

Montenegro beat Gibraltar 4-1.

HARD WORK FOR CROATIA

Croatia looks nothing like the team which reached a World Cup final in 2018, but at least its five-game winless run is over.

A defensive error gave Mario Pasalic the chance to score the only goal in a 1-0 win over Cyprus, but it wasn't the emphatic victory Croatia wanted after its opening loss to Slovenia. Luka Modric made his 135th appearance for his country, breaking a tie for the record with former full-back Darijo Srna.

Russia is top of Group Hafter beating Slovenia 2-1 to pick up its second win. Artem Dzyuba scored both of Russia's goals to move within one goal of the Russian team record of 30 held by retired striker Alexander Kerzhakov. There were 13,000 people in the stadium in Sochi on the Black Sea coast because of competition rules and Russian law. Malta earned a rare point in a 2-2 draw with Slovakia.

Dutch fans cheer win over Latvia as players protest for rights in Qatar

THE Netherlands earned their first win of the 2022 World Cup qualifying campaign on Saturday with a 2-0 victory over Latvia in front of 5,000 fans, who saw Stephanie Frappart make history and another pre-match protest for human rights in Oatar.

Frank de Boer's side bounced back from their opening round defeat in Turkey with a dominant performance that delighted the small but rowdy crowd at the Johan Cruyff Arena in

The Dutch capital is set to host matches at this summer's delayed Euro 2020 and the supporters, who all tested negative for Covid-19, were at the match as part of an experiment to see whether events with spectators can take place safely during the pandemic.

They went home happy thanks to Steven Berghuis' superb first-half strike and a Luuk de Jong header in the 69th minute, although the Dutch could have won by more, wasting a host of chances and twice hitting the bar. "The way we played pleased me but only winning 2-0 after creating dozens of chances isn't enough," said a frustrated De Boer.

"We deserved to win by at least five goals. We tried everything... I looked at the statistics and we touched the ball 96 times in the opposition area. It's incredible."

The Netherlands are third in Group G, three points behind leaders Turkey, who won 3-0 win in Norway and Montenegro, who maintained their perfect start with a 4-1 victory over Gibraltar.

The 'Oranje' travel to Gibraltar for their next match on Tuesday.

Frappart was once again a trailblazer as she became the first woman to take charge of a men's World Cup qualifier.

France's Frappart was in December the first woman to take charge of a men's Champions League match, between Juventus and Dynamo Kiev.

The 37-year-old was also the first woman to referee in the French top flight, the lead official for the 2019 UEFA Super Cup final between Liverpool and Chelsea and made her Europa League debut in October.

Ukrainian Kateryna Monzul will oversee Sunday's match between Austria and the Faroe Islands in Vienna.

- Dutch join rights protests

The Dutch became the third team after Norway and Germany to carry out a pre-match protest in favour of rights for the migrant workers involved in stadium construction for next year's finals in Qatar.

They entered the field in Amsterdam wearing T-shirts with the message "Football supports CHANGE", aimed at the Gulf state.

Qatar has faced criticisms for its treatment of migrant workers, many of whom are involved in preparations for the 2022 World Cup, with campaigners accusing employers of exploitation and forcing labourers to work in dangerous conditions.

Qatari authorities insist they have done more than any country in the region to improve worker welfare.

Netherlands defender Matthijs de Ligt told Dutch media he and his teammates would be working with player unions in other countries "to discuss ioint action".

"We know that the workers who are building the stadiums for the 2022 World Cup are working under very difficult conditions. We cannot remain indifferent to it and do nothing," he

Lyon forward Memphis Depay told news agency ANP: "As footballers our voice needs to be heard. It will be more effective through collective action which brings together different countries rather than by acting individually."

ANP also reports that while the Dutch football association (KNVB) was never in favour of holding next year's finals in Qatar, they are not planning on boycotting the tournament.

MENTION France vs. Ukraine to Karim Benzema, and you'll see his eyes sparkle. The expression on his face will light up. In November 2013, Benzema played his best match ever for Les Bleus in a 3-0 win over Ukraine in which he scored France's second. That evening at the Stade de France, he was excellent and helped send his team to the 2014 World Cup in Brazil.

More than seven years on, Les Bleus drew 1-1 with Ukraine at the Stade de France on Wednesday in Europe's official start to World Cup qualifying, but Benzema wasn't involved as his years-long feud with manager Didier Deschamps still rages. He was likely in his big house in Moraleja, a posh suburb of Madrid, and probably didn't watch the game either. He is not interested.

Yet the debate over Benzema's lack of inclusion with the national team continues to rumble on, and Wednesday's lack of attacking prowess -- 18 shots, just three on target -- by his countrymen will do nothing to quiet the noise given the 33-year-old's form at Real Madrid right now.

Benzema is the best French striker in world football at the moment, apart from Kylian Mbappe. He is in incredible form with eight goals in his last six games in all competitions. Almost on his own, he's taken Real Madrid to the Champions League quarterfinal and to within six points of Atletico Madrid in La Liga's title race. He is better than the strikers that Deschamps has called up for France -- Olivier Giroud, Antoine Griezmann, Anthony Martial and Wissam Ben Yedder -during this break, too.

So it's no surprise that Real manager and France legend Zinedine Zidane is struggling with the fact that his No. 9 is not part of the national team set-up. "I don't understand it and a lot of people don't understand it either" Zizou said after the 3-1 win against Celta Vigo on Saturday in which Benzema scored twice.



It was not the first time that Zidane has publicly shown his discontent over Benzema's omission by Deschamps, either. Back in January, he said: "Benzema's returning to the national team would be a good thing." Last August, Zidane was even clearer: "Football-wise, Karim is simply the best, so yes, he deserves his place with France. He loves the national team, he has always wanted to feature. I don't know what happened internally, but football-wise, there is no debate."

But these words have no impact. Deschamps has not called "Benz" back since his 81st and final cap on Oct. 8, 2015, a friendly against Armenia in which he scored a brace, his 26th and 27th goals for his

Deschamps watches almost every Real Madrid game to follow the performances of Ferland Mendy and Raphael Varane, so it's fair to of the context of football, when it assume he also sees Benzema play such a strong relationship. In his first three years in charge, the head coach built everything around the former Lyon striker, and Benzema repaid him well. He was a driving force for the team as he helped them qualify for the 2014 World Cup. He shone in Brazil and carried the team to the quarterfinal, putting in a strong performance against eventual champions Germany despite the defeat.

But none of that matters since Deschamps effectively banished Benzema from the national team after a sex tape and blackmail scandal with teammate Mathieu Valbuena erupted in 2015. Benzema is accused of having played a role in blackmailing his former teammate -- allegations Benzema denies and says he will prove are false in a trial that's due to start at some point in 2021. Guilty or innocent, the incident scarred his reputation. After Deschamps dropped Benzema during the investigation, the player accused him in 2016 of having "bowed to the pressure of a racist part of France" when agreeing to leave him out of the squad for Euro 2016.

Not long after Benzema made that statement, Deschamps' holiday home was tagged with the words "racist" and in some ways, that was the likely point of no return.

"There have been very unpleasant moments which were outside

went on the private and personal every weekend. They used to have sphere. Am I thinking about the tag? Yes. I will never be able to forget it. Then, it went too far. It was violent, inappropriate and unacceptable," Deschamps explained again in the summer of 2020. More and more people in France

right now, like former France captain Jean-Michel Larque, are asking Deschamps to forgive Benzema and call him up again, making the argument that it's such a waste to see a player of his talent and experience not playing international football. They believe the national team would be even stronger with Benzema in the squad, a point that's hard to dispute. While Deschamps always avoids questions about Benzema when in front of the media -- "I make the best choices for the team" is his typical response -- in private, Deschamps is having none of it and simply isn't interested, according to ESPN sources.

The fact is that Deschamps has gotten great results without Benzema, reaching the Euro final in 2016 only to lose to Portugal and winning France's second World Cup title in 2018. The former Juventus manager is a big believer in team spirit, unity, cohesion, as well as preserving the notion of squad and team. The strikers in Deschamps rotation, like Giroud, have done well for him considering the way he wants to play.
