# PM: Surveyed, undeveloped mining areas' licences nixed

"The licences are being used as an excuse for foreign investors to seize large geologically surveyed areas"

THE government is preparing to repossess geologically surveyed areas licensed to foreign investors for mineral surveying or mining and are yet to be developed with mining activities

Prime Minister Kassim Majaliwa made this affirmation at the National Assembly yesterday during question and answer session, indicating that the government has started processes for repossessing the dormant areas.

They are geologically surveyed areas and will substitute their title deeds to artisanal miners and committed investors, he said, noting that the Minerals ministry has already directed regional mining sector managers to review all geological survey licences.

Especially targeted are dormant large areas

that were given to foreign and local investors but are yet to be developed, he said, stressing that the purpose is to revoke the validity of their licences.

"I would like to take this opportunity to emphasize already given instructions to regional minerals managers to fast track the reviewing of the licenses so that the revocation of dormant licenses commences immediately," he

Acknowledging that Tanzanians are eager to reap from the natural resources, he said that "any planned decision to deny them this right shall be controlled by the government."

Licenses are issued as the green light for execution of projects for which the license is applied, not provided to enable seizing investment areas for any other reasons, the premier

### **Plastic bottle producers** ought to manage wastes'

THE government is set to review the Solid Waste Management (Regulations) of 2009 to compel producers of plastic bottles to closely manage their wastes, to protect the environment.

Dr Selemani Jafo, the Union and Environment state minister in the Vice President's Office (VPO) made this declaration at a meeting with stakeholders who produce products packed in plastic bottles or pack-

The meeting explored usable approaches to tackling the problem, for sustainable management of environmental pollution against overflow of the bottles in various environments, taking place in Dodoma on Wednesday.

A VPO statement said yesterday that the minister instructed the permanent secretary to bring together ministerial experts and the relevant stakeholders to see how to improve the regulations before this financial year ends.

The first draft is expected to be completed by late next week, with stakeholders presenting their views, he said, noting that the decision follows detailed discussion between the various parties.

The discussion has increased the momentum of reviewing the regulations, he stated, emphasizing that what was discussed is in the broad interest of the government and the stakeholders.

In the wake of what was contributed by the stakeholders, the ministry will make TURN TO PAGE 2


THE World Bank Group and the African Development Bank Group are creating a new partnership for an ambitious effort to enable at least 300m people in Africa access electricity by 2030.

Ajay Banga, the World Bank Group president, was quoted in a World Bank statement yesterday affirming that electricity access

is the bedrock of all development. "It is a critical ingredient for economic growth and essential for job creation at scale. Our aspiration will only be realized with partnership and ambition," he said, referring to the joint effort with AfDB.

The World Bank Group will work to connect 250 million people to electricity with distributed renewable energy systems or

#### Biteko blames TGDC for delaying Lake Ngozi geothermal project

DEPUTY Prime Minister and Energy minister Dr Doto Biteko has pointed a finger at the Tanzania Geothermal Development Company (TGDC) for impeding the start of drilling geothermal wells at Lake Ngozi area in Mbeya Region.

Dr Biteko said this when opening the Energy Week exhibition in Parliamentary grounds recently, adding that TGDC is one of the subsidiaries of the Tanzania Electric Supply Company (Tanesco) which promised to implement the work in early this month but so far there is nothing to show.

"I have signalled a warning light on you TGDC: when I went to Mbeva. you told me that you were supposed to start drilling in April this year to get geothermal for electricity. I ask the permanent secretary to keep an eye on you to expedite the work," he said.

Dr Biteko however said that the country now has sufficient electricity but worn out infrastructure has been causing power outages.

He said the government plans to make Tanesco win trust of its customers by changing negative attitude that every time there is

a power outage, the problem is

He commended the performance of Tanesco for working tirelessly day and night to ensure that people get electricity service.

"As you know, some areas have been affected by floods. Tanesco officials are in some areas forced to use donkey carts to take poles to restore electricity service; workers sometimes do not sleep," he said.

Dr Biteko added that due to accessibility of sufficient power, even the Kinyerezi 150 megawatt power station has not been switched on, explaining that the situation was due to the ongoing exercise of turning on machines at Julius Nyerere Hydropower Plant (JNHPP) project.

He said soon machine number eight at the JNHPP will be switched on and thus a total of 470 megawatts will be generated.

Dr Biteko said that the government's strategy is to ensure that Tanzania is connected with its neighbouring countries, including Zambia, which used to buy seven megawatts due to drought. but that has declined to four. Other countries to be connected are Uganda and

He said that access to electricity is a fundamental human right and is foundational to any successful development effort. Currently, 600m Africans lack access to electricity, creating significant barriers to health care, education, productivity, digital inclusivity, and ultimately job creation, the global lender noted.

"We will need policy action from governments, financing from multilateral development banks, and private sector investment to see this through," it elaborated, underlining that the partnership is a demonstration of the two multilateral institutions "to be bolder, bigger, and better in tackling one of the most pressing challenges in Africa."

This initiative is the most recent manifestation of the World Bank Group's commitment to become more impact-oriented and is the byproduct of a concerted work plan


grid to build a better bank, the group president affirmed. "It is aided by a constellation of regional energy programmes that will now be aligned toward this common goal," he specified.

For the World Bank Group to connect 250m people, \$30bn of public sector investment will be needed, of which IDA, the World Bank's concessional arm for low-income countries, will be critical.

"In addition, governments will need to put in place policies to attract private investment, and reform their utilities so they are financially sound and efficient with tariff mechanisms that protect the poor," the statement intoned.

Connecting 250m people with electricity would open private sector investment opportunities in distributed renewable energy alone, worth \$9bn, it said.

Beyond that, there would be substantial opportunities for private investments in grid-connected renewable energy needed to power economies for growth, it added.

## Govt wants more stakeholder efforts to curb family conflicts

THE government has called for more efforts by community and religious leaders to address family and marriage conflicts so that children are raised by both parents living under the same roof.

Dr Dorothy Gwajima, Minister for Community Development, Gender, Women and Special Groups made the appeal in Dodoma yesterday when addressing journalists ahead of the International Day of Families which is celebrated on 15th May of every year.

Admitting the increase in divorce cases due to family conflicts, she said that this year's commemoration is themed 'Let's bear our differences at the family level in strengthening the upbringings of children.'

The minister said that conflicts arising from marriage and relationships upset the

upbringing of children who in most cases end up being street children with bad behaviour.

"The theme reminds us of settling our family conflicts so that children are raised while sharing love from their parents. Also, it emphasises child protection against gender based violence," she said.

According to her, government reports show that 27 percent of women aged between 15 and 49 years were subjected to body attack as of 2022 while 12 percent of the women were subjected to sexual harassment.

She said that 13 percent of women who happened to be married or had a relationship in 2021 faced the same gender based violence and discrimination acts.

The reports reveal that family conflicts have led to denying children their basic rights to receiving good education and healthcare. Young teenagers are forced to get involved in

sexual relationships at a tender age.

"About 22 percent of teenage girls aged between 12 and 19 were impregnated. Underage pregnancy in rural areas topped 25 percent compared to 16 percent in urban areas," she said.

Dr Gwajima said to contain family conflicts, the ministry was fully engaged in mediation of marriage conflicts through social welfare commission within the ministry.

It has been observing the same duties through social welfare tribunals at the village and ward levels. She said between July 2023 and April this year, a total of 14,600 family conflict cases were resolved at the tribunals.

Of the conflicts, 5,366 were marriage and divorce conflicts, 5,944 cases were rooted into conflicts related to child custody, 3,350 cases were about conflicts for children born out of wedlock.

"A total of 3,411 family conflict cases were 

reported to social welfare officers out of which 1,642 cases got resolved while 443 cases are in the process of being resolved," she said.

The Disrupting Harm in Tanzania report by the government and UNICEF for 2022 shows that child online discrimination is a new wave of gender discrimination and harassment.

The report states that adolescents and teenagers lead in utilization of electronic devices that give them access to social media where gender discrimination acts are rampant.

percent of children aged between 12 and 17 are consumers of smart phones and internet services hence making them prone to online discrimination and violent acts.

The report reveals that children use smart phones and other electronic devices owned by their relatives, guardians, parents and friends.

It states that four percent of children were subjected to online violence during the period under review.

### PM orders disaster committees to make donation reports public

PRIME Minister Kassim Majaliwa has directed district and regional disaster management committees to issue detailed reports on the amounts of money and items donated to help disaster victims.

The premier issued the directives in the National Assembly yesterday during Prime Minister's questions session when responding to a question by Agnes Hokororo (Special Seats) who wanted to know the reason behind public officials not giving detailed feedback on money raised money to help disaster victims.

Majaliwa admitted that he has been canvassing for public donations when disasters such as fire and floods strike and therefore people have the right of being informed about the administration frontline to raise awareness for of the donations.

"I would like to take this opportunity to direct all disaster management committees from the village level to the regional level to make sure that reports for donations are made public," he said.

"The information should be given in terms of value and utilisation so that the general public and development partners' trust is restored."

He pointed out some of the disasters that he had participated in canvassing for donation but reports are yet to be shared with the public as the fire at Mbuyuni SMEs market in Moshi town where the public and development partners donated money for restoring the facility.

"When fire razed down Lindi Secondary school, I was on the

public donation but the report of what was collected remained a secret of the regional disaster management committee. We need to make such information known to the public," he said.

According to him, the reports for Hanang mudslides, Kilombero and Rufiji floods that have claimed lives and properties must be made public by disaster management committees in the respective areas.

"The Prime Minister's Office has the role of enabling disaster management committees to undertake their responsibilities but not to collect information about donated money or items," he said.

"I direct the committees to change their perception and start sharing information about the donations to

the general public."

AS delegates from various countries are set to meet at the Global Plastics Treaty Negotiations in Ottawa, Canada next week, environmental activists have urged Tanzanian representatives to consider the impact of chemicals in recycled plastics.

Addressing reporters in Dar es Salaam yesterday, officials from the Agenda for Environment and Responsible Development (AGENDA), called for a strong treaty that will reduce production of plastic, eliminate the most toxic forms of plastic and toxic chemical additives.

Dora Swai, executive secretary of AGENDA, said the hazardous chemicals present risks to recycling workers and consumers as well as to the wider society and the environment, saying it is important for Tanzanian officials to carry the

agenda to the meeting.

According to her, recycling is not the best way to reduce the amount of plastic in the environment but could cause further harm by putting more resources into plastics production.

She said that in a recently published study in Data in Brief via ScienceDirect, plastic pellets from plastic recycling plants in 13 different countries in Africa, South America, Asia and Eastern Europe were found to contain hundreds of chemicals, including numerous highly toxic pesticides.

Because of this, scientists have confirmed that recycled plastics are unfit for most purposes and hinder the attempts to create a circular economy.

The published data from the countries, including Tanzania, identified nearly 500 chemicals in recycled plastic pellets, including pesticides, industrial chemicals and other toxic substances.

"At the treaty talks, some countries favour approaches that would rely on plastic recycling as a significant tool for resolving the plastic crisis. But the new data adds to the increasing evidence that plastic recycling is a vector for the spread of toxic chemicals and therefore should not be considered a useful tool in the struggle to end the health and environmental threats from plastics," she said.

"Plastics are made with toxic chemicals, so when plastic is recycled, the chemicals end up in the recycled material," said Silvani Mng'anya, principal programme officer at AGENDA, expressed concern that chemicals found in recycled plastics may already be making people more susceptible to cancer, heart disease, reproductive disorders, diabetes, obesity and other serious health conditions.

"An effective plastics treaty needs to address the health and environmental threat from plastic chemicals and include approaches to control plastic production. We cannot recycle our way out of the toxic plastic problem," he said.

Through the TELS initiative, we aim to bring together stakeholders with the right technical knowledge to deepen an understanding of gender inequality challenges within the key focus areas and develop solutions to enhance gender inclusion," she said.

Our goal extends beyond addressing existing disparities; empowering women is not only a moral imperative but also a strategic move, as women in leadership positions are instrumental to drive a competitive advantage and transformative change."

Benson said that although significant progress has been made towards promoting gender equality and empowering women in the country, there is still much work to be done to provide women with equal opportunities for leadership.

"We acknowledge that to date, there are a number of programmes aimed at increasing women's participation in leadership. However, the unique goal of this initiative is to drive systemic change. The final desired result is a shift in organizational structures, policies and actions of institutions, and directly seeing the shift across all levels of society," she said.

Speaking at a special meeting with religious leaders in Dar es Salaam yesterday, Mayala said clerics have a big role to play in monitoring morals of young people in the society.

The meeting was part of implementation of the Accelerated Hope and Development for Urban Adolescents in Tanzania (AHADI) project, a seven-vear gendertransformative World Vision project that aligns with a framework to prevent gender-based violence by working towards changing harmful social and gender norms that perpetuate gender inequality in urban areas of Tanzania.

Funded by Global Affairs Canada, the project supports adolescent girls and boys in and out of school to end violence, promote positive masculinities and gender equality.

He said the project uses evidencebased models to create a multiplier effect through a peer-to-peer education and behaviour approach in Dodoma and Dar es Salaam regions by raising awareness on issues of sexual reproductive health and rights (SRHR) among others.

He said through the project, adolescent girls and boys are trained on SRHR for them to make informed decisions.

"The initiative provides a gender transformative, rights-based approach to scaling up prevention of violence against women and girls and fulfilment of their sexual and reproductive health, dignity, security, and autonomy," he said.

Rev Amos Mlagwa of the Africa Inland Church Tanzania (AICT) said that fighting moral decay and gender-based violence requires concerted efforts from different stakeholders.

# Revamping law on internal auditing risky, complicated

of the auditing profession must be thinking hard on how far African governments can establish policies and laws making internal auditors in public institutions freer and less interfered with by employers.

This matter is likely to be part of a current of discussion in the profession and where the law may have grey areas - that is, as to whether internal audits are either advised to work with their corporate superiors or have discretion on the matter.

Whether the government will have room to clarify on the issue is open to dispute, though.

Vice President Dr Philip Mpango made an appeal of this sort at midweek when opening the 10th general meeting of the African Federation of Institutes of Internal Auditors in Arusha city.

There was a sort of gap in what the VP was explaining - for instance, whether the issue was for internal auditors to give a true and realistic financial assessment of the specific entity or to render advice on the

The problem is strictly speaking resolved in the former, as there is no law relating to advice.

This brings the matter to where it started, as to whether African governments can institute clauses in their respective pieces of public audit legislation to protect internal auditors from undue influence or interference in their duties.

If the law basically recognizes them as internal to those institutions, it is unavoidable that they bend their work to suit the wishes or interests of such institutions. Unavoidably, it is the chief executive officer who from time to time determines what that

it that internal auditors report to the government what is happening in an institution, which would be beside the point in that the state has its audit

XPERIENCED members office, headed by the Controller and Auditor General.

Since the role of internal auditors is to advise the management on what there is in a particular company, department or agency, not being excessively frank or being 'part of a team' does not come to dereliction of duty on their part.

Internal auditors are supposed to help those who employ them, and they thus accordingly take corporate interest as essential to their own work.

How far internal auditors need to be independent can only relate to the systems in which they work, and to an extent they will take signals from the very same employers as to what they need, expect or are supposed to do.

It isn't any different from external auditors, as they have a mandate to check the entity's standing as a whole and principally in relation to compliance with regulations in one or other regard.

Listening to discussion relating to the CAG's annual reports, it is not evident that internal auditors are accountable for what happens.

Nor do district directors explain their failure or dereliction of duty from what internal auditors do. When cash is diverted at points of sale, do internal auditors sound the alarm?

The VP's remarks suggest that this is precisely what ought to be done - which raises the issue of whether key accounting officers need that advice or it is evident that whoever the auditor is advising seems to be at peace with this or that observation.

Internal auditor can't change the way entities work but only help to dust the files and give the right picture of where the entities stand on revenues and liabilities.

Like everyone else, internal auditors are protected by law, and that includes their work contracts. Otherwise, legislation would have Getting rid of an internal auditor for an act of interference would virtually signal that there is wrongdoing. One wonders whether that would be adequate.

#### Works projects being halted were less of CSR as a community issue

prevailing social responsibility regulations is under way, and it is envisaged that local government authorities (LGAs) will be entirely responsible for monitoring and evaluating development projects being implemented by local and foreign

This is what the National Assembly was effectively told at midweek, rather surprisingly not by the Finance ministry or the Planning and Investment wing of the President's Office but their Works counterpart.

This feature led to a bit of confusion, with some observers viewing CSR as community projects rather than major infrastructure extension projects executed and overseen by LGAs.

The Works minister told the National Assembly that "to start with," CSR contracts for Dodoma Region stood suspended, with accusations of fraud in their implementation.

In the face of the fact that LGAs (district councils in particular) are now to supervise such projects, it implies that the CSR part will be removed from the main projects as investors conducted projects as they usually do.

The contractors ought to provide cash for LGAs to conduct implementation of the projects instead of asking road contractors to use standards other than those used in their own projects.

What many may not have been aware of is that Works and PO-RALG (the Regional Administration and Local Governments "wing" of the President's Office) had teamed up to take up projects described as CSR.

It may not have entailed proper contracts as such but, in that the cash involved wasn't handled by LGAs, the manner of work was an extension of the bigger projects.

The minister did not say that the cash be handed to LGAs for them to oversee implementation but that they use different standards to speed up things -with LGAs monitoring and evaluating the pace of execution.

Strictly speaking, these were not CSR projects in the first place and their being implemented in line with standards applicable to major works was a way of recovering the money, as that aspect of investors' 'force

account' was added to CSR expenses.

The issue now is how LGAs will supervise the work unless the money is handed to them for hiring contractors in line with regulations the two ministries will provide, as CSR often translates into donating the cash or conducting projects.

There is thus a moment of reckoning for this imposition of CSR to tally with the core functions of contractors unconvinced on the CSR aspect, as to how the two can be tallied or fused into one.

Legislators had demanded the suspension of ongoing CSR projects to allow for value for money probes. In fact, one MP pointed out that CSR projects were being put to global

For decades on end, the media have looked at the state as a main advertiser, but this is no longer the case - and we all know this. With the ever-rising power of social media, this and various other advertisers have changed their focus and priorities.

This situation underlines the need for the media to embrace new thinking and change the way they solicit and obtain advertising revenue by accommodating the new realities in the market.

There is also a misconception with respect to the notion of press freedom, originally encompassing only the print media - that is, newspapers and other publications. But when we talk of this freedom in current times we mean media freedom that embraces all forms of media - radio, television, social media, etc.

Yes, newspapers started but along the way we have witnessed and welcomed the introduction of the various other forms of media now that we are in the digital era.

Along the way, the entry of new forms of media has left us with harsh but instructive lessons on how the dominant media have survived and continue to survive - even, in their small way, somewhat thrive.

For instance, many people saw the introduction of radio as heralding the end of the print media - but that has not happened and newspapers are still here today.

Similarly, with the advent of television, the preponderant beliefor fear - was that radio was doomed. Again, that has not been the case.

Therefore, we need to draw lessons from all these changes and transformations and see what was done then - and it is this that will help us positively and meaningfully remould our business models.

We need to revisit what media houses in Tanzania and other parts of the world did when such disruptions occurred because such changes have been occurring. We

are in the digital era and we don't know what will the future has to

With traditional means of mobilising funds having proved awfully inadequate, there is a need to think outside the box and come up with non-traditional financing models for our media houses.

Continuing to think and otherwise move the way we did before the advent of the digital era will be courting disastrous consequences as we witness what are called multiple modes of gathering and processing news and other forms of reportage. Definitely, no one can gainfully compete while sticking to old models of media practice.

The government recently commissioned a team of media and other experts to look into the economic and other doldrums the media in the country are going through. In your view, will that help to relieve the media economically?

It is fortunate that the government has commissioned such a research. We are eagerly waiting for the results, but media houses should not expect that the study will see them spoon-fed.

We should get prepared to use the outcome of the report to chart appropriate ways which will enable us at least to survive in the prevailing challenging economic environment. After the report is published we must sit down and look for viable ways through which we will use the proposals in the report to improve our lot as a profession.

If there are gaps in the report we should not sit down and lament. Rather, it will be our responsibility to commission further research so as to find ways to plug those gaps.

In addition to this initiative by the government initiative, media houses should seek to learn from challenges and success stories as obtain in other parts of the East Africa region and beyond. This is primarily because the problems we are facing in are not very different from those experienced by our counterparts there. We need to see how they survive under their particular circumstances? From that we will learn something which might help us to overcome our own economic challenges. For instance, some media houses over there have done so when dealing with digital disruptions in the media industry. It would surely pay for us to learn from them.

# Effective organisation of social matters can earn an institution a positive image

NDIVIDUALS in an institution or workplace cannot be of the same behavior or culture. A work place is an area which attracts people from different places. It is mainly the work that unites them otherwise they would not be together. But when people stay together for a long time they form a family or society.

When people are told of contributing some amount of money in response to social welfare mattes which arise in the workplace a lot of questions and considerations roll in their minds.

There are those individuals who con-



sider the amount of salary they are paid and how long do they expect to stay in an institution. These challenges are normally in private sector where assurance of income and stay in the workplace is not easily determined. didn't contribute is hit by a social catastrophe and unwisely expecting an assistance. This challenge won't happen if the worker was given the constitution to read and understand at the starting of their contract in an institution.

Setting a reasonable amount that worker can contribute. For smooth operation of social welfare activities, the amount set for contribution must be reasonable regarding income of workers. This will make workers contribute with joy and not grief. Financial matters cause stress easily and therefore demanding individuals to pay something above their capacity may cause lack of mental relaxation and hence decrease in efficiency by some

Organizing a meeting with workers in case of an emergence. There are matters which arise in institutions which become sensitive though they are not spelt by the constitution. To go well with these matters a meeting is necessary. The meeting will generate a common consensus regarding the matter and hence ease the implementation without disturbing the peaceful atmosphere at the workplace which is a prerequisite for efficient performance of

Establishing workers' fund. The aim of workers' fund is boosting financial power of workers. It acts as a means for saving. The reason for saving is the fact that social challenges or problems come unexpectedly and hence may cause a high level of discomfort if not solved on time. Although workers' fund may prove beneficial to workers, its membership should be voluntary because individuals may be having other saving means on their own. What is important is contributing the required sum on time without excuses.

Managing individuals in an institution is not an easy task due to differential understanding and character of people. However there must be efforts of keeping people together despite all those differences. It becomes necessary to ensure effective organization of social matters in an institution so as to avoid unnecessary tensions when problems or other joyful matters arise. This is to enable a peaceful atmosphere to dominate the workplace all the time so that the operations of an institution are not affected. Effective leadership at workplaces entails good organization of social welfare matters. We are social beings.

lems currently facing the continued business growth and development of public entities and even some private companies in our country is lack of creativity and failure to follow the right path to success.

Although these companies and institutions have sufficient employees, capital, assets and a long surviving history, yet they are not organised for change and sad to say they harbour outdated business mentality.

Much management spend an enormous amount of time on capital appropriation decisions, and only a few pay much attention to what happens after the capital investment has been approved and injected. The Controller and Auditor General (CAG) reports have years in years out revealed such weaknesses in a detailed manner.

Creating thinking is therefore important - it refers to how the management, its board and support staff approach the problems and solve the obstacles that appear now and then. In business, to be creative, is for the key personnel to influence the way that business is done so that it can grow profitably.

It is for this reason we wish top authorities to consider introducing what is called the 'Balanced Scorecard' system so it can revamp ongoing business strategies.

In a nutshell, the balanced scorecard is a set of measures that allows senior managers in enterprises to have a comprehensive view of their business.

The system links the organization with its four critical performance measures. They are financial perspective, customer perspective, internal business perspective and innovation perspective. This is to say that the scorecard forces executives to focus on the handful of measures that are most critical.

In our continent we can cite as an

example South Africa, Botswana and Swaziland which have adopted the system but indeed several countries in Europe, North America and Asia have adopted this system too.

In turbulent times, this system has helped to withstand sudden blows and manage well the fundamentals.

The scorecard firstly brings together the managerial needs of the company's agenda venturing on quality of service and products, emphasis on teamwork, watching keenly issues

ensuring good public relations and Communication with various stakeholders and so on.

Many firms have a corporate vision and mission that focuses on the customer but cannot deliver to them appropriately. The scorecard demands that executives translate their mission statement on customer service into specific measures that reflects the factors that really matter to customers.

Customer's concerns tend to fall into five categories- time,

related to customer satisfaction, performance, quality, service and cost. To put the score card to work is for the companies to articulate these goals properly and translate them into specific measures.

> Despite excellent customer performance (derived from processes, decisions and actions) managers must be able to focus on critical internal operations that enable the firm to satisfy customer needs. The scorecard gives the managers good assessment of what internal perspec-

To achieve the right goals close watch should be on cycle time, quality, productivity and cost as well as devising measures that are influenced by employees' actions. That way it will be easy to link key internal processes and action taken by individual staff all aimed at achieving corporate objectives.

The scorecard also emphasises that Information Systems play an invaluable role in helping managers disaggregate the summary measures. If the Information system is weak, reports

nated, and there is late delivery of goods and so on.

Regarding financial performance measures, these indicate whether the company's strategy and execution contribute to the bottom line improvement. Survival is measured by cash flow, success by quarterly sales growth and operating income, and prosperity by increased market share.

It appears today that some managers do not care to observe these categories. That is why by introducing the scorecard system managers will always be alerted which key areas they should pay attention to their financial matters.

Lastly, as companies apply the balanced scorecard measures they begin to recognise that scorecard system represents a fundamental change in the underlying assumptions about performance measure-

It is well suited to the kind of organisations that many firms are trying to become. The scorecard puts strategy and vision, not control, at the centre.

It establishes goals but assumes that people will adopt whatever behaviour and take whatever actions are necessary to arrive at those goals. The measures are designed to pull individuals and top executives towards the overall vision, mission and values. The problem is that some of the missions of the firms are outdated; there must be a way to reactivate them to suit the present situation.

The scorecard keeps the companies moving forward.

# Better incentives needed to expand solar energy in Cuba

TTH a bolder policy and flexible payment mechanisms, perhaps Alexis Rodríguez would have opted for solar panels for his home, instead of the portable generator that has made it possible for him to weather the frequent blackouts caused by Cuba's recurrent energy crises.

"It's a little noisy, the fuel is expensive, but I can tolerate one and solve the other. What is intolerable is for my family and I to spend nights and early mornings without electricity, without rest, suffering the heat and mosquitoes, and with the risk of the food in our fridge spoiling," the barber, who lives in the eastern city of Holguín, said.

"Solar panels are the best, there is no fuel cost or noise. But they need to be sold with real incentives in order for more people to invest in them," said Félix Morffi

Rodríguez shelled out 850 dollars a few months ago for a 2500 watt (W) gasoline-powered generator.

Marileydis Pérez, a homemaker in Batabanó south of Havana, received a 900 W generator from her son, who sent it from his home in the United States, "to run the fans, the television and turn on the lights on blackout nights."

Pérez said that although the government created a system of shifts for the sale of gasoline, "just five liters" for those who have registered generators, "I have only been able to buy it that way once in two years." As a result, she  $resorts \, to \, the \, black \, market \, for \, gasoline.$ 

Highly dependent on fuel imports, Cuba consumes more than eight million tons annually, of which almost 40 percent is covered by heavy domestic crude oil with a high sulfur content, used mainly in thermoelectric genera-

During the last five years, along with the deterioration of the domestic economic situation, the fall of the main sources of foreign currency and the tightening of the U.S. embargo, the authorities have faced increasing difficulties in meeting fuel demand.

An update of retail prices in the domestic market led to an increase of more than 400 percent in sales rates since Mar. 1.

The price of a liter of regular gasoline climbed from 25 to 132 Cuban pesos (equivalent to 1.10 dollars at the official rate). The same was true for regular

On the black market, a liter of regular gasoline costs 250 to 300 pesos, or 0.70 to 0.85 cents on the dollar, taking into account the exchange rate parallel to the governments.

In this country of 11 million inhabitants, the average monthly salary is equivalent to about 40 dollars, which amounts to around 14 dollars in the informal reference market for a significant number of products, goods and services to which families have access in order to satisfy their basic needs.

The problems facing the energy supply have fuelled the importation

of generators, as well as their sale on the black market. Government-owned stores that only take foreign currency also sell them at very high prices, far beyond the reach of most families.

An extension for the non-commercial import of up to two generators that produce more than 900 W has been in place since 2022.

**Barriers** 

People expressed misgivings about the use of generators because they are

They pointed out that they are not always placed outside the houses or in ventilated rooms so that toxic combustion gases can escape and overheating can be avoided.

When asked about the possibility of solar panels, Pérez said that "in addition to being very difficult to find outside Havana, they usually come without batteries, and if they are brought in, they cost half a million pesos (about 4200 dollars at the official exchange

When the public corporation Copextel, in charge of marketing and aftersales services, began to sell them in late 2021, "they were at 55,000 pesos" (2,300 dollars at the official exchange rate at the time), unaffordable for anyone who depends on their wages or on a pension," said Rodríguez. The price covered the purchase,

transportation, installation and assembly of the panels and inverters by the company's technicians.

"I spend less than 200 pesos on electricity a month. With what a solar panel costs I can pay for electricity for more than 20 years," added Rodríguez.

Another hurdle for the expansion of solar power in the residential sector lies in the electricity tariff subsidy, which is charged in a devalued currency.

According to official figures, around six percent of the more than four million households in Cuba consume more than 500 kilowatt hours (kWh) per month. Above that threshold, the electricity tariff was increased by 25 percent since March to eliminate sub-

By installing solar panels, this segment of the population could find a way to offset the amount of the bill through cogeneration for self-consumption or receive a payment for injecting clean energy into the national grid.

"Those who have mainly purchased the panels are people with high incomes, especially owners of hostels and rental houses. It makes it possible

for them to provide air conditioning in rooms for tourists and other services during the day," Dunia Ulloa, commercial manager of Copextel's branch in the Havana municipality of Plaza de la Revolución, said.

Projects and incentives still fall short About 95 percent of Cuba's electricity generation relies on fossil fuels, which include the natural gas produced with domestic oil, offshore oil rigs leased from Turkey, as well as diesel and fuel oil based generators and engines.

The government aims for renewables to account for around 30 percent of electricity generation by 2030, up from the current five percent.

With an installed capacity of 260 megawatts (MW), the solar parks installed in this Caribbean country represented two percent of annual electricity generation at the end of 2023, according to official

On Mar. 14, Minister of Energy and Mines Vicente de la O Levy reported that two contracts had been signed for the installation of 92 solar parks in all provinces, with a potential of 2000 MW.

By May 2025, the first of the 1,000 MW contracts must be fulfilled, and the second by 2028. Each one also has an additional 100 MW of storage capacity, he

Since 2014 Cuba has had a Policy for the Development of Renewable Energy Sources and their Efficient Use, and in 2019, Decree Law 345 established regulations to increase the share of renewables in the energy mix and gradually decrease consumption of fossil fuels.

In 2023 the Ministry of Finance and Prices issued Resolution 238 which doubled to six pesos (0.05 cents of a dollar at the official exchange rate) the price per kWh from renewable sources delivered to the national grid by independent producers in residential areas.

In addition, the regulations waive for up to eight years the tax on profits for economic actors that carry out electricity generation projects with renewable energy sources, and the customs tax on the importation of equipment to that

The results are not very encouraging, pending more attractive proposals for individuals to invest in green energies, in order to sell surplus electricity to the Cuban State.

The regulations do not exempt the import of these technologies for commercialization from customs duties: the cost is the same for materials or equipment, whether they are beneficial or detrimental to energy consumption.

Unlike other countries where people make a living from selling clean energy, in Cuba those who install solar panels essentially seek energy self-sufficiency, that is, to have electric power even during blackouts.

"Solar panels are the best, there is no fuel cost or noise. But they need to be sold with real incentives in order for more people to invest in them," entrepreneur Félix Morffi, 86, a former midlevel technician in machinery and tool repair and a tenacious advocate of clean energy opportunities, said.

A group of 36 solar panels on the roof of his house provide 10 kWh to support the work of his automotive repair shop, an autonomous enterprise built by Morffi next to his house in the municipality of Regla, in the Cuban capital.

After covering his household needs, the surplus electricity he produces goes to the national grid.

"An essential element is to provide credit. Not everyone has the money to buy the equipment. The other is to not get bogged down in red tape, because it scares people off. Banks must have people who deal only with this issue, who are trained, and who want to get things moving. If that happens, you will see how in the neighborhoods more and more people start to put up panels," said

In his view, "those who produce the most should be recognized, perhaps by giving them household appliances, increasing the rates paid to them for surplus energy or covering part of the investment. In the end, it is a gain for the country and reduces fuel expenses."

learned that the government of Uganda was dragging him to court, he expected justice. But he says he has realized these courts are being used to deprive him of his rights to a fair hearing and the right to fair and adequate compensation for his land and property.

Mulimba said that within days after the government's case against him and 41 other landowners in the oil-rich Uganda Albertine region was heard in December 2023, the court ruled that money meant for the expropriation compensation should be deposited with the court and that the government could evict them so that TotalEnergies oil refinery construction could go ahead and the pipes for the East African Crude Oil Pipeline (EACOP) could be installed.

"It was the fastest trial that I have known of since my childhood. And more so that involving a case when the government sued its citizens," Mulimba said.

"Justice Jesse Byaruhanga of the High Court in Hoima heard and passed the judgment against us within four days. You can imagine determining a case filed by the government within four days," he added. Now the landowners are playing a waiting game, not knowing when they will finally be evicted.

Mulimba and hundreds of the dependents of the 42 landowners are on the brink of homelessness, facing eviction for refusing to accept the uniust, unfair, and inadequate compensation by TotalEnergies, which is acquiring the land from the peasant farmers on behalf of the government.

The threat of forceful eviction of the landowners has been around for years. But this time, it appears to be imminent, with the government armed with an eviction order and determined that the oil, discovered in 2006, should be extracted by 2025.

"Unfortunately, we, the landowners, have been punished since 2018. And now, with their eviction order, they can do anything. But we are determined to die for our rights," said Fred Balikenda. The government applied and granted a specific order to have Balikenda evicted from his land in Kirama village.

"Each of us is going through the toughest times. You don't know when they will finally pounce or how they will treat us," said Balikenda

On December 4, 2023, Uganda's Attorney General's Chamber sued 43 landowners. The suit asked the court to grant the government leave to deposit compensation money in the court so that TotalEnergies could take possession of land for the Tilenga oil and gas project.

The government asked that it be discharged from any liabilities arising from any claim from the eviction order.

The High Court ruled on December 8, 2023, that the landowners' compensation be deposited in court so that Total-

Energies can take possession of the land in dispute. TotalEnergies E&P has since 2020 been trying to acquire a 60-acre piece of land on behalf of Uganda's Ministry of Energy.

The "hurried ruling" in favour of the government raised eyebrows within the legal fraternity. In Uganda, land disputes stay in the court system for years without resolution.

"All the cases we filed against the government are still rotting in the courts. The same judiciary hears the case against us by the government in four days. Has the devil taken over our government? We are crying in our hearts, wondering who will help poor people like us," said Kwonka William Mugisa, another landowner.

A human rights lawyer, Eron Kiiza, issued a statement saying that the judge in the matter violated established legal principles by delivering a verdict in the land case within four days, without allowing the accused parties to respond or contest the matter.

"When a judge, oozing impunity, deliberately denies parties to a case/suit an opportunity/right to be heard, to contradict the evidence, to file their submissions, and hastily makes orders for the benefit of TotalEnergies to prejudice Ugandans' homes, gardens, residences, livelihoods, dignity, and property, he is undermining the rule of law and fundamental human rights and freedoms," said Kiiza.

Kiiza and other lawyers in January have tried to urge the Uganda Law Society to boycott the Judiciary's activities in protest against the conduct and the way the judge handled the matter.

He, with the permission of the landowners, appealed the ruling to the Court of Appeal to overturn the High Court eviction order and compensation money deposited in the court.

The Court of Appeal had not fixed the date for hearing the appeal petition. Fearing that the 

government could go ahead with the eviction, Mulimba and four other aggrieved parties travelled to Kampala at the end of February in an attempt to seek an audience with the Minister of Constitutional Affairs and the other leaders in the judiciary to hear their plea. Mulimba said that they were not allowed entering

Kwonka William said that, going by the government's valuation report, he was being forced to accept an equivalent of about USD 9 for his land and assets.

any of the offices.

The Energy Ministry's Permanent Secretary, Irene Batebe, said in an affidavit that compensation due to the respondents was based on approved valuation reports and a 30 percent project uplift by the government.

Meanwhile, Mulimba, flanked by his wife, Pityedi Mugisa, said that the government, through the court, is trying to force them to accept unfair compensation in the form of cash.

"The land is for the family. We asked for land in exchange. If they can find equivalent land, we are ready to leave. But we didn't ask for cash," said Mulimba.

The couple said they have attended scores of meetings demanding fair and adequate compensation but have been unsuccessful.

"We had been using that land for many years. We earned money for school fees from it. We get food from it and we got medical support from there," he said. "So, we are not fighting the government but we are fighting for our rights to be respected."

Dickens Kamugisha, a lawyer and Chief Executive of the Africa Institute for Energy Governance (AFIEGO), told IPS that the landowners have been trying to meet government officials to ensure that there is fairness and justice.

"Instead of ensuring fair and adequate compensation, they are now using the court. Knowing that these people cannot get the best lawyers to represent them, knowing that they cannot influence the courts. So the government is filing those cases to get those rulings that they want to use to evict the people," he said.

Kamugisha said AFIEGO supported the oil refinery-affected people in filing a case against the government of Uganda over low, inadequate, and unfair compensation in March 2014.

"Nearly ten years later, hearings on the case have yet to be concluded. That is an injustice. And where there is injustice, you cannot have a settlement that is coming from negotiations," he asserted.

Besides, Kamugisha said that no law provides that the government can go ahead to acquire

land and deposit the landowner's compensation in court.

"In 2021, the judiciary illegally allowed the government to deposit the households' compensation in court. This set a bad precedent that should never be repeated. It is also sad that the government has continued to use and misuse courts to destroy citizens' right to own property and/or get adequate compensation," Stated Kamugisha.

As the landowners wait for the Court of Appeal to consider their appeal, some of them said that they are being threatened by security operatives who, they said, keep visiting their homesteads.

"That is mainly happening here in Kasinyi, Ngwedo Center, and Kisimo villages, where most of us live. Someone comes and parks a motorcycle or car at your land and then drives away. Isn't that intimidation?" another landowner said.

According to Global Witness, evidence from its undercover investigation in December 2023 showed that state authorities had threatened and detained a number of campaigners.

"In a handful of instances, the state authorities appeared to be in communication with TotalEnergies before reprisals took place," said the report.

IPS learned from some of the employees at TotalEnergies and EACOP that the oil company was opposed to the idea of forceful evictions because it was not within its rules and that it feared the likely negative publicity.

There are also reports that Total-Energies was considering hiring an independent firm to look into the claims by the landowners.

But Kamugisha said it is Total-Energies that is displacing these people.

"It is unfortunate that Total is saying they are bringing here an independent investigator. They are bringing an investigator at a time when they are working with the government to get eviction orders. How is that investigator going to be helpful?"

# Place of counselling amidst emerging exponential technologies

EPORTS about the global digital economy and the future labour market show that due to the emergence of digital technologies some traditional jobs will likely phase out, while new jobs that need new skills and competences will emerge.

That is why researchers suggest that some jobs will be replaced with automation, but there are other jobs that won't. Counselling is one of the professions that will survive replacement due to the fact that no person can be counselled by a machine. Machines may do many things a person does, but they cannot offer counselling service.

This means that in-person services won't be replaced with automation. A counsellor is a person trained in helping others to cope with traumatic or stressful life experiences and make life meaningful and fulfilling again without which their traumatic or stressful life experiences would have tormented them considerably.

The more the labour market becomes more competitive the more challenging it becomes to some people who may find life unbearable and meaningless to them. This can be pronounced in circumstances of losing a job, losing loved ones, financial hardships, marriage breakdown, loss of property, betrayal or when a person feels that life is becoming too unfair to him or her. Counselling skills such as empathetic, communication and interpersonal listening skills are needed to help those who are



traumatised to cope with their situations

Autor et al. (2020) in their article "The Work of the Future: Building Better Jobs in an Age of Intelligent Machines" say although emerging exponential technologies create new work, not all new work is in "high tech" jobs.

"Some jobs are found in in-person service jobs, such as mental-health counsellors, chat room hosts, sommeliers, home health aides, and fitness coaches. These roles partly reflect new demand, stemming from rising incomes (an indirect effect of rising productivity) and the novel needs of individuals in an industrialised society."

Yet, the researchers say, traditional sectors, such as agriculture and production, have created less work, and new occupations have stopped emerging." Why? It is because many jobs in these traditional sectors are replaced with machines. Expounding on this phenomenon, the researchers suggest that "jobs recede in some sectors, such as agriculture, as technology advances."

In others, like manufacturing, globalisation reduces domestic demand. Sometimes consumer tastes shift. Simultaneously, new work emerges in innovative industries, such as computing, renewable energy, and healthcare. Rising incomes also create new consumption demand, such as for new fitness clubs."

Fitness clubs, for instance, were not there before because people had something to do, but due to a changing work environment and lifestyles in order to keep oneself physically fit one has to do regular physical exercises and in the circumstances in which ordinary physical exercises cannot easily take place fitness clubs have been established.

With the disruption of exponential technologies and especially when it results in job losses it has adverse effects on employees depending on those jobs and because of this their lives will be affected. For some peo-

ple, losing a job is the end of every opportunity because they think of how their relatives, colleagues and neighbours will think of them.

But this negative experience can be turned into an opportunity when it is looked at from another perspective which can make life meaningful and fulfilling if the person who loses the job seeks counselling service. It is also the fact that people cannot work throughout their entire lives and at some stage they have to retire.

Retirement also has its own challenges especially when an employee reaches retirement age without being prepared for it and in some cases this results in stressful life or sudden death. This means a person was in need of counselling to go over his or her situation, but because he or she was not helped on time his or her situation worsened and he or she finally got some health complications or died suddenly where he or she would have been helped had he or she been counselled.

Prahl & Enright (2017) suggest that "new forms of automation possessing artificial intelligence (AI) pose a truly unprecedented threat to the human workforce... [their] impli-

cations extend beyond just joblessness, because there is considerable research showing that unemployment has negative effects on mental health." People who cannot easily cope with a challenging situation like a job loss need professional counselling.

We can say that professional counselling is underutilised either due to ignorance or lack of trust in counsellors that they may not have any help in the circumstances. Sometimes people even when they don't have reasons to distrust a person they don't find it a need to seek the help they need. Suicide is a case in point in the sense that a person distrusts other people and tends to keep everything to himself or herself to the extent of deciding to commit suicide.

On the other hand, although many people may blame persons who commit suicide in the actual sense they are unaware of what was going on in the life of their close friend, spouse, relative, colleague or neighbour who has committed suicide. If people knew that there was a counselling service at their disposal and trusted in counsellors they would have sought help and been helped to change their mind and live.

ERTAIN events in the life of a country, a people or even a continent serve to bring into the open just what is wrong with that culture or people, but often it is not easy for those concerned to own up. Those around them make an effort to assuage their feelings, or take time to state somewhat clearly what took place or their role in it, and for the most part it is propaganda that rules.

That has been the case since 1994 in relation to the Rwanda genocide, where propaganda had it that it was the Rwanda Patriotic Front that downed the plane of President Juvenal Habyarimana, while it was his own people, as a signal to start billings in just helf an hour later.

killings, in just half an hour later..

Had it been that the plane was brought down by opponents, and the government of the day realises that the president has died, it would take a certain amount of time for them to be reorganized and start acting cohesively. The downing of the plane was a sort of military coup, where the diehards at the presidential palace and in government moved to eliminate the dovish wing of the state.

It started with the president and then the prime minister, Agathe Uwingiliyimana, the first victim of the genocide in the sense of house invasions and traffic stoppages to haul out people from vehicles and kill them. Either one supported the genocide or die in it.

What also needs to be laid to rest is another rather comforting ideology, that the inaction of the international community allowed the 1994 events to be rolled out Key state organs coordinated an orchestrated mayhem that took a toll of 800,000 lives before power was wrestled from a totally disorganised vampire state upwards of 100 days from April 6, in the night. The president himself didn't know the plan.

That is where the problem of diplomatic failure comes in, as the first person who needed to be assisted was none but the president, and his core enemies planning the genocide were his wife Agatha and his brother in law, Col. Theoneste Bagosora

The proper architect of the genocide, he had earlier quit peace talks with RPF in Arusha, declaring that I am going back home to prepare

an apocalypse.' He had earlier been the minister for defense, then removed and placed in the State House as top adviser on military and security matters, thus he could plan a vast operation.

Just imagine how a peace loving diplomat would seek an appointment with the ruler, to tell him that his wife and brother in law were mobilising for genocide and they would first start with his own death and the prime minister. Too much from any realistic diplomatic expec-

tation, in which case Rwandans fell on their own swords.

And indeed the Tutsis partly had themselves to blame for the horror, as they kept massacring all educated Hutus in neighbouring Burundi, and when international pressure led to polls in July 1993, they killed the Hutu winner three months later, Melchior Ndadaye. Hutus in Rwanda opted to drain the pond, simply.

The point is that like other people around the world, we Africans are only just beginning to be weaned of the demons of cruelty and mayhem to resolve disputes that merit a few demonstrations and a government of national unity. The Rwandan genocide, like what is going on in the Sudan or earlier in Ethiopia, is part of what a classic writer called 'pitfalls of national consciousness,' or alternatively, it is sin. The wages of sin is death, and ethnic arrogance leads to mayhem, as in the current destruction of Gaza following a Hutu-like massacre of more than 1,200 people.

In the final analysis, the powers that were related to Rwanda at the epoch were pursuing self -interest as they have always done, that is, angling a country's interest in relation to its own policies. Thinking that this ought to have excluded the genocide are perfectly wrong, as every country is free to choose its own destiny and others can only be invited to help, unless they are pursuing their own interests by spirited or muscled intervention. If a country opts to commit sui-

cide, it can't blame the rest of the world for not disarming it, as it is the case in individual lives.

The most pilloried of the foreign powers is France, which had intimate ties with the genocidal authorities, but these were ties of dependency and even ideological affinity especially of the Franco-Belgian priesthood with the Hutu state intelligentsia or 'petty bourgeoisie.'

The Tutsis were traditionally the ruling class and what they were doing in Burundi from the late 1950s up to the 1972 massacre of all educated Hutus, that is, with secondary school education, was reprehensible. In that case it was a tenuous situation for the Hutu rulers in Rwanda to incline to global pressure for agreement with RPF, holding elections and loosening the grip.

When Col. Pierre Buyoya, outgoing military ruler of Burundi who remained as de facto head of the army even as he pretended to be handing over reins of office to president-elect Ndadaye as if he really left office, everyone in Rwanda was acutely apprehensive. They wanted to know if the Tutsi dominant classes would actually respect the new dispensation and the new leadership stabilize, which had a chance of showing an example to Rwanda that perhaps times had changed. But it failed.

They soon proved that it was not possible to do business with Tutsis on an even handed and fair dealing framework, when the restless colonel, too drunk with power and vastly contemptuous both of democracy and the Hutus that Ndadaye represented, struck out and the president was killed.

So the die was cast; the fury and rejection of compromise in Rwanda was universal except for few top officials close to the UN, like the president and the prime minister, to start with. And in that case the intensity of the dispute was such that families were torn apart, so that even siblings killed one another as they were at different ends of a fiery sword of hate.

# 23 FIRMS EAGER TO INVEST IN SGR, MGR OPERATIONS

WENTY-THREE companies have eagerly stepped forward to express their interest in investing in six pivotal areas in rail operations, covering crucial facets such as railway business operations for both, Standard Gauge Railway (SGR) and Metre Gauge Railway (MGR).

Mwatuka Maita, Planning Officer at Tanzania Railways Corporation (TRC), shared insight with The Guardian newspaper on the impactful outcomes of the recent Business and Investment Forum.

The forum, which convened key stakeholders in the railway sector to explore investment opportunities and cultivate partnerships, was held in Mwanza, last month.

He explained that the purpose of the forum was to encourage conversations regarding infrastructure development, rolling stock, rail business operations, opportunities within ports, marine, and airports, as well as investment potential along railway corridors. The aim was to facilitate discussions on a va-



railway industry. The official highlighted that the report indicated significant interest from five companies in investing in infrastructure development and rolling stock. These companies demonstrated a strong desire to participate in projects related to infrastructure and rolling stock within the railway sector.

He emphasized their dedication to improving railway efficiency and capacity by riety of topics related to the focusing on technological advancements and sustainable practices. The discussions at the forum centered around ways to enhance the efficiency and capacity of railways through the utilization of innovative technologies and sustainable practices.

He pointed out that one company had already submitted a draft MoU for participating in commuter train services through Public-Private Partnership (PPP) arrangements, while the remaining four

In Real Estate on TRC Land and Properties, six companies have indicated interest in real estate, land, and properties linked to railway infrastructure. The official highlighted that their interest presents opportunities for complementary developments like commercial centers, residential complexes, and industrial zones.

"The demonstrated interest from companies in infrastructure, rolling stock, rail operations, and associated real estate underscores the sector's potential for growth and development," he said.

In regards to opportunities in Ports, Marine, and Airports, six companies have shown considerable interest in investing in port infrastructure development, the marine sector, and airport infrastructure projects. They recognize the importance of modernizing airport facilities to meet the growing demands of passengers and to improve air cargo operations.

The discussions focused on improving capacity, efficiency, and connectivity to handle the rising trade volumes and to support economic growth. All interested companies have been directed to submit their official proposals.

Moving forward, it is crucial for there to be concerted efforts and collaboration in order to turn these interests into concrete investments and drive innovation within the railway ecosystem.

# 'Surveyed land shows promising outcomes'

Experts advise conducting a land survey before purchasing property to gain valuable insight into boundaries, topography, and potential issues. This helps ensure a smooth transaction, prevents disputes, and allows for more confident decisionmaking in real estate investments.

Though many potential buyers neglect this crucial step, but it is essential for a thorough understanding of the property's boundaries and potential issues.

Johnson Mwambuja, the director of the upcoming Dar-based Johan Land Surveying Company Limited, emphasized the importance of thorough research before purchasing property.

He stated in a recent interview with Property Watch in Dar es Salaam that many investors tend to choose a plot or house based on personal preference and make an offer without conducting proper due diligence.

"Surveying and land surveying is the measurement and mapping of our surrounding environment using mathematics, specialised technology and equipment. Surveyors measure just about anything on the land, in the sky or even on the ocean bed," he explained.

Adding that: "Therefore, surveying is part and parcel when it comes to property purchasing; surveyors will determine the boundary measurements to make sure that the plot of land you think you are buying is actually what you are buying."

It is said that with their expertise, a land surveyor can tell you whether the trees, building, fences, sidewalks, driveways, and other features of the land actually lie on the property, and also whether anyone else's buildings or other features encroach onto the property you wish to buy.

For a prospective land buyer to catch potential problems with his/ her plan before purchasing the land, land surveyors would be of benefit as they can help the buyer in evaluating the possibilities for building upon the land. "If you plan to develop the land a survey can help you determine whether this is possible or even

On the other hand, buyers are encouraged not to go off an old land survey as it may not describe recent changes to the land. Therefore, before conducting a land surveyor, the buyer ought to ask for a property profile, which will list the ownership information, legal description, plat map, tax information, and other characteristics.

Recognizing the significance of property surveys, FindLaw has compiled a list of the top 10 reasons why individuals should consider having their property surveyed. These reasons cover a range of important considerations for property owners.

#### **Boundary lines**

One of the most common reasons a landowner seeks the assistance of a surveyor, the location of boundary lines and other lines of occupancy or possession is a critical piece of information to have before you build a fence, add a sunroom or pave your

All too often the survey shows that you and your neighbors were operating under the wrong assumption about the placement of the boundary line between your properties. Before you have that fence erected, you want to make sure it will be built on your property, not your neighbor's. The boundary line certification will also tell you whether the legal description of your property is ac-

#### **Overlaps**

Part of the boundary line certification, most surveys include a state-

ment that unless the surveys says otherwise, there are no discrepancies between the boundary lines of your property and the adjoining property. This is especially pertinent if your property is continuous with alleys, roads, highways, or

#### **Rights-of-way**

A survey will show all the conditions imposed by law that are reflected in your property's title report and other agreements. If your property blocks your neighbor's access to the road, for example, there may be an old agreement that gives your neighbor the right to walk across your yard to the street.

#### **Ponds**

The typical survey reports visible or surface waters only. Underground waters and wetlands are topics that are better covered by other professional inspections.

#### **Right-of-support**

Unbeknownst to you or your nextdoor neighbor, you may have an obligation by law to support your neighbor's driveway by maintaining vour own.

#### **Existing improvements**

The surveyor will usually certify that the buildings and other improvements, alterations, and repairs to your property that exist at the time of the survey are not in violation of laws or other restrictions such as those regarding height, bulk, dimension, frontage, building lines, setbacks, and parking.

Of course, the surveyor will also tell you if your latest improvement is in violation of a local ordinance or other law, which will put you on notice that a change is in order.

#### Infrastructures

Poles and above-ground wires are obvious, but the surveyor can usually report on the existence of underground cables and drains, as well, if the information is provided to him or her by your utility companies and municipality. Such information is important for two reasons.

A utility company may have the right to use a portion of your property for upkeep of utility lines, and may have a say in how tall you let your trees grow, for instance. Also, knowing the exact location of underground utilities is critical before any excavation or construction begins.

#### **Cemeteries**

It is unlikely that unbeknownst to you there is an old family burial ground in your back yard. The survey will show the exact location of any old cemeteries on your plat.


Your survey should state, at a minimum, whether there is physical vehicular ingress and egress to an open public street. It may also specify the adequacy of access for a particular purpose, such as delivery trucks, emergency vehicles such as fire trucks, and driveways for tenants.

#### **Zoning classification**

You probably know whether your property is zoned for residential or light industrial use. But you may be surprised to discover that your zoning classification puts specific restrictions on how you use your property.

This part of the survey simply reports your zoning jurisdiction and classification. Once you have your completed and certified survey, you may want to consult an attorney about whether you are using your property in conformance with zoning ordinances or for other advice about the legal ramifications of your property survey.

# POOR RURAL ROADS HOLDING BACK WOMEN'S ECONOMIES

he public is anxiously waiting to see every corner of the country linked by a seamless network of smooth, modern tarmac roads. The question on everyone's mind is when this long-awaited dream will become a reality

The Tanzania National Roads Agency (TANROADS) needs to be allocated with 37trillion/- for completion of a countrywide tarmac road network covering 24,849 kilometers.

The required money for improving the country's earth roads to tarmac roads is 0.86 percent more than the 2021/22 government's overall budget that stood at 36.68trillion/-.

Only 3,224 kilometers of tarmac road network had been constructed since Tanzania was born on April 26, 1964 an equivalent of 12.97 percent of the total required tarmac road network.

The scenario is posing doubts among young women leaders in higher learning institutions.

They are rising up and pleading for the improvement of rural earth roads to tarmac roads for economic growth.

The today's and future expected leaders are calling upon the government to prioritize budget allocation for construction of tarmac roads in rural areas to facilitate connectivity so that women employed in the agriculture value chain among other sectors, are facilitated to transport their agricultural harvests to urban markets.

Poor road infrastructures in rural areas are also blamed by the young women elites for claiming lives of innocent pregnant women that mostly occurs during rain seasons when they are forced to travel long distances to urban located hospitals for specialized reproductive health services.

Esuvath Daniel, a bachelor's degree student at School of Journalism and Mass Communication (SJMC) who serves as the Children, Women and People with Disabilities Lead Journalist at the school, said that in 2023/24 budget valued at 44.39trn/-, government administrative activities have been allocated 11.89trn/-.

to service the national debt, 5.95trn/for education, 6.68trn/- for defence, security and the rule of law while works, transport and communication has been allocated 3.84trn/-, 3.05trn/- for the energy sector and the health sector has been allocated 2.41trn/-.

"We want the government to come up with a women empowering-led budget in 2024/25. The budget allocation for the current financial year shows that transport, energy and health sectors are allocated with the smallest stake of the total 44.39trn/- budget," she defended.

She argued that the meagre allocated funds for transport, energy and health sectors contradicts the 2023/24 budget in which the government pledges to focus on the priority areas of the Third Five-Year National Development Plan 2021/22-2025/26 that emphasizes improvement of citizens' lives and well-

"The well-being is defined in the 2023/24 budget book as reducing poverty and generating employment. Thus, budget priorities are focused on improving sectors that increase production and the number of jobs;


It mentions these sectors as agriculture, livestock and fishing, energy, construction, transport and tourism," she clarified.

Vivian Robert, students' government Vice President at Mzumbe University Main Campus Morogoro, said that an inclusive gender-based budget by both central and local governments is vital if rural women's lives are to be uplifted.

"The majority of rural women are employed in the agriculture sector. Poor infrastructure is a hindrance to them in accessing urban markets and factories for processing and value addition of their agro products;

In my opinion, budget plans and allocations have not yet taken women affairs into serious consideration," said Robert.

She argued that in the current fiscal year 954.3bn/- has been allocated for local government authorities' expenditure of which only 86.4bn/- has been allocated for the completion of health centers, clinics and district hospitals rehabilitation while there isn't a specified budget

"However, of the central government's total budget for works, transport and communication tuned at 3.84trn/- rural and urban roads are allocated 710.3bn/which as of January this year only onethird of it has been disbursed by the treasury," said Robert.

Vanessa Rutabana, the sitting President of the Students' government at Muhimbili University of Health and Allied Sciences (MUHAS) said that most of the rural areas are not connected to town centers with tarmac roads thus scaring away transporters.

"You may find that most of the broke She said 6.31trn/- has been allocated commuter buses that are not allowed to operate in urban areas have relocated to rural areas where roads are badly affected by rain thus offering poor transport

As a matter of fact, these commuter buses take a single route a day that means if you miss it today you have to wait for tomorrow," said Rurabana.

According to her, poor rural infrastructure are a hindrance for women engaged in agriculture, arts and weaning, poultry and pastoralism to properly benefit from their hard work.

The reporter has spoken to other women university leaders for students' governments who shared related concerns from the National Institute of Transport (NIT), Sokoine University of Agriculture (SUA), Institute of Social Work, Open University of Tanzania (OUT), St. Augustine University of Tanzania (SAUT), Water Institute, and from the Institute of Rural Development Planning (IRDP).

Zainab Mmary, Senior Programme Officer (Research and Analysis) at the Tanzania Gender Networking Programme (TGNP) was of the view that if social services such as transport, communication, health, energy and the access to clean and safe water in rural areas is made the key priority by the government, women could be uplifted not only financially but raising productive families.

"Women are breadwinners be it in rural or urban areas. There is no single woman who is willing to spend her money on awkward things but her children

That's why we say the micro and macro economies can be stabilized by empowering women because they invest in it directly," said Mmary.

According to her, TGNP has been organizing seminars and training for local government leaders for them to develop gender based development plans and

This is the real situation on the ground when Article 8 (1) (b) of the Constitution of the United Republic of Tanzania 1977 highlights responsibilities of the government to the people as it states: 'The primary objective of the government shall be the welfare of the people.'

As of December 31, 2023 the Tanzania Rural and Urban Roads Agency (TARU-RA) had received 82.50bn/- for entire project implementation work, a 12 percent of the total approved budget for fis-Dennis Londo, the chairperson of

the Local Government Affairs standing committee of the National Assembly, said that legislators are worried about disgruntled voters facing difficulties in transportation in many districts around the country.

Londo said in 2023/24 TARURA is allocated a total of 818.02bn/-, where 710.31bn/- is to be sourced from the government and 107.71bn/- from the development partners, noting that the disbursed funds had enabled projects implementation by 38.84 percent of the overall target.

Expressing dissatisfaction with the funds disbursement pace, he said the Treasury pledged to remit an additional 350bn/- on top of approved estimates but has released nothing.

He said TARURA had requested 1.60trn/- in budget allocations for 2023/24 but it was allocated with 818.02bn/- almost a half the requested amount. Meanwhile, the budget rose to 838.16bn/- in 2022/23, up from 722.2bn/in 2021/22 which grew from 275.03bn/-

Elaborating, he said that 69 percent of TARURA projects relate to rehabilitating earth roads to all weather networks stretching 41,107.52 kilometers, from 24,405.40 kilometers in 2020/21, along with rehabilitation of district roads covering 144,429.77 kilometers.

"During the current fiscal year TARU-RA is supposed to rehabilitate earth roads covering 21,000 kilometers, a tarmac road network of 338 kilometers and gravel road network of 8,546 kilometers, plus replacing 4,372 culverts," said Lon-

Innocent Bashungwa, Minister for Works, said that the government has started disbursing the pledged funds intended for rural roads projects emphasizing that by the end of the current financial year all damaged roads will be

Salome Makamba, Special Seats legislator pointed at extensive damage in rural roads after excessive rainfall, where TARURA was to be handed 131bn/- emergency funds for rehabilitation of roads in 184 district councils but by the end of last December just 21bn/- was released.

"We demand serious answers from the government," she said, asserting that road networks are close to being unusable in many rural areas.

But, Zainabu Katimba, Deputy Minister of State in the President's Office, Regional Administration and Local Govern-

ment, reacted that the government has already started issuing the roads rehabilitation emergency funds which as of earlier April 2024 had released a sum of 52.6bn/-.

Vita Kawawa, Namtumbo legislator, said that the Lusewa to Msisima earth road in his province is badly damaged with ongoing rains and needs rebuilding, urgently, noting that 216mn/- was allocated from the 131bn/- but the funds are yet to be released.

"No transport link is usable between the two places," he stated.

Ezra Chiwelesa, Biharamulo West legislator said that from the 350bn/- the Treasury pledged additional budget, constituencies were to obtain 500mn/each but nothing has been done so far.

Sophia Jonathan, Ihumwa resident in Dodoma city, the grain wholesaler at Kibaigwa grain market in the region, said that poor infrastructure in the rural parts of the region has incurred her 3,000/- per 100 kilogram bag of dried corn to be transported from peasants in remote Bahi district council.

"I have been paying an extra 1,500/per 100 kg bag of corn from Bahi town to Kibaigwa market. This makes a sum of 4.500/- per bag:

Transporters argue that poor infrastructure is the reason behind the spiraling cost from which a part of it is spent in fixing regular breakdowns of trucks," said Jonathan.

Jesca Mlowa, (32) a Mikola village resident in Bahi district council said that she pays 3,000/- per 100 Kilogram bag of dried corn if she is to transport her harvests to Bahi town for sale.

"Bulk corn buyers have to travel all the way to the village to purchase the dried corn. It is too costly for peasants to transport our harvests to urban markets," said

The Controller and Auditor General (CAG) Charles Kichere in his 2022/23 report states that funds embezzlements in local government authorities (LGAs) have been holding back the implementation of development projects.

He says in the report that during the audited financial year the 184 district councils recorded 61.15bn/- uncollected revenues from intended important

"The negligence in revenue collections is affecting the LGAs pace of project implementation and leading to poor offered social services," says Kichere in the recently released report.

Kichere asserts that during the same period LGAs didn't cede aside 20.25bn/for villages and street development projects that includes paying for TARURA road projects, agriculture, fishing and pastoralism programmes.

Engineer Ali Mwita, Contractors Registration Board (CRB) Registrar called upon the government to play a critical role in supporting contractors working at the local government level and give them a first priority when it comes to TARURA projects.

"It's high time for the Force Account compliance in the construction sector to be evaluated after seven years of its implementation following diverse challenges that are embedded in new regula-

Kirumbe Ng'enda, Kigoma Urban MP, argued that local contractors' project payments are delayed just because they are not subjected to interest rate penalties as it applies to foreign contractors.

tions," said Mwita.

"Inefficiency of the National e-Procurement System of Tanzania (NeST) has been a challenge for local contractors in bidding for projects. The system has weak internet connectivity. As a matter of fact, I have learned that most district council officials are not well trained on how the system operates," said Ng'enda.

But, Engineer Amin Mcharo, Director, Capacity Building and Advisory Services at the Public Procurement Regulatory Authority (PPRA) said that NeST commenced in July 2023 connected to 17 government procurement and tendering systems.

"Over 29trn/- has been injected into the NeST for procurement of materials for construction projects. However, as of last week contracts worth 5.14trn/- have been extended to 18,101 bidders who are registered on the system," said Mcharo.

According to him, the system operates efficiently and most of the district council's procurement officers have been well trained to it.

Victor Seif, TARURA's Chief Executive Officer, said that local contractors play a central role in the Agency's roads project execution.

According to him, the Agency is currently implementing its five-year strategic plan phase two that commenced in 2020. The plan targets to make 85 percent of district roads passable by 2025/26.

"Since its inception in July 2017, TARU-RA has impacted a growth in tarmac roads network from 1,449.55 kilometers to 3,224 kilometers as of January this year, an increase of 122.4 percent," said

On the way forward, Minister for State, President's Office, Regional Administration and Local Government, Mohamed Mchengerwa, said the ministry in conjunction with TARURA will in the 2024/25 fiscal year float a special bond at the central bank to mobilize funds for lending local contractors to execute rural and urban roads projects.

He said the 'Samia Infrastructure Bond' is meant to support local contractors with loans for them to fairly compete with foreign companies in securing road construction tenders.

The government is confident that the bond will complement municipal bonds and monthly revenue collections by district and municipalities for funding road projects," said Mchengerwa.

But, the Minister for Transport, Professor Makame Mbarawa, on May 23, 2022 told the National Assembly that the ministry had decided to collaborate with the private sector through the public private partnership (PPP) dubbed 'Engineering, Procurement, Construction and Financing Model' in implementing road pro-

Prof. Mbarawa admitted that going independent in execution of road projects leads to delays and mismatch of intended targets.

For instance, he told parliamentarians, in 2021/22 TARURA and TANROADS had collectively targeted construction of 467 kilometers of tarmac road but as of April 2022 they had managed to construct 216 kilometers.

Prof. Mbarawa affirmed that TAN-ROADS needs to be allocated with 37trillion/-for completion of a countrywide tarmac road network covering 24,849 kilometers.

"TANROADS alone had in 2021/22 planned to construct 103 kilometers but as of April 2022 only 34.8 kilometers were constructed," said Prof. Mbarawa.

He said the PPP model in construction of tarmac roads was supposed to commence in 2022/23.

"The Road Fund Tanzania lacks funds for financing road projects. As of April 2022 the Fund's ability in financing road projects stood at 42 percent," said Prof. Mbarawa.

# HOW TO CHOOSE THE RIGHT PAINT FOR YOUR HOUSE

hoosing a colour palette for your building is not merely a practical decision but also a creative opportunity to transform a space. Colour's ability to evoke emotions and set the tone is deeply personal, reflecting one's unique tastes.

Follow these tips to create a colour scheme that reflects your style, personality, and lifestyle authentically.

Choosing your paint

Start by working from a colour wheel. There are primary, secondary and tertiary colour. Primary colour are red, blue and yellow. They are pure colour and cannot be created. Secondary colours are orange, green and purple.

These colours are formed when equal parts of two primary colour are combined. For example, equal parts yellow and blue make green. As basic as this is this is where we begin the color selection.

The tertiary colors are a mixture, in varying parts of secondary and primary colors to create different hues, as a result the primary and secondary colors become less vivid. White and black are often added to darken and soften these hues.

#### Creating your color scheme

Use your color wheel to help you create your own colour scheme that best fit your personality. There are four kinds of possible colour schemes. These include the following;

The monochromatic color scheme uses tone on tone of the same colour with the addition of white or black to lighten or darken the colour. For example, ing your wall colour first. Wall

in this scheme blue can become a pale sky blue or a dark midnight blue and all three hues of the same shade are used to create this effect.

The analogous scheme uses colors that appear next to each other on the color wheel. For example, yellow will be used with green or orange, or blue will be used with green or purple. This creates a colorful and often soothing palette.

The contrast scheme is more dramatic. Here triads of contrasting colors are used, such as yellow-orange, green-blue and red-purple. This introduces more colour and energy into your home's palette. And

Lastly, we have the complementary scheme where two opposing colour, such as blue and orange, are used together to create a dramatic, bold and high energy color

We will caution against select-

paints are inexpensive and can be created in any color and in any hue, you desire. It's best to start with harder to find items such as furniture and rugs or carpets. Once you've selected your furnishings you can then move on to wall colour.

You may decide that you'd prefer your colour not to be on your walls, but in your accessories or furnishings instead. Many people prefer this. Others, conversely, prefer more neutral furnishings contrasted by bold and powerful walls.

#### Things to consider

When choosing your colour palette, you may want to start with contrasts, something dark paired with something light. If you wish to infuse a little more color and energy into your room you might consider adding something bright. Where is it that you want these colors?

If you're more comfortable

with pale walls, look to your furnishings, accessories and rugs for added color. When picking your colour, especially the bolder ones, makes sure they are crisp and the lines are clean. If your style is more subtle, softer, neutral shades should be considered.

#### **Colour tones**

Test out your colors with paint swatches and fabrics. Draw out plans of your rooms and sketch in the colors. If they work on paper, try painting small areas of your walls. You can buy any color paint in a sample size specifically for this reason. When painting sample areas look other rooms and how they connect so that you can create a flow from room to room so that the colour complement each other.

An adjoining room may want a non-accent or a neutral colour, or conversely you can work with contrasting tones as well as long as there is always a semblance of

flow.

#### Lighting

Lighting is an important aspect of all decor and function within the home and should never be overlooked. Light reflects and deflects colour, changing it constantly, throughout the day. A room's truest colors are those found in the daylight hours and the hues will alter throughout the day and the seasons as the lighting changes.

Different lightings can change the appearance of colour as well. Indigo, for example can appear bluer in one room and have much more red in another.

#### Commitment

You love the idea of infusing your space with colour, but you're not really quite ready to add it to your walls. There are plenty of ways to add splashes of colour to your home.

If you keep your walls neutral pale beiges, sands, ivories, greys and whites - you can bring colour in with rugs, furniture, lamps, pillows, throws and artwork, flowers, and fresh fruit. You may also consider painting your ceiling or an accent wall.

#### Where to start with colour

Start at the beginning. The beginning could be a central room or a front hall or entryway. Is there a color, or a set of colour that you're particularly fond of? Do you tend to prefer blues, yellows, greens? Start with a colour that best suits you. Then take that colour and look at it several shades and hues lighter and several shades and hues darker. So, for instance, on your colour wheel, you've chosen green.

You've gone to the paint store

and you've chosen a dozen or so paint swatches that have varying shades of green. You like two shades, one has more of a grey undertone and more has more of a blue undertone. Perhaps select one hue for the dining room and the other for the living room. To make them work together select a neutral that can be used in both rooms for ceiling or trim and both. Some suggest keeping hallways, landings and connecting spaces neutral in tone.

#### Separate the upstairs from the downstairs

The upstairs and downstairs are two separate entities and should be treated as such. It's best to paint your landing or hallway a soft or neutral colour as often the upstairs is comprised of mostly bedrooms which can often have very differing colour and contrasts.

Children's rooms are often bright and bold, whereas guestrooms and home offices are not. If your master bedroom has a master bathroom attached to it, you need not paint both rooms the same colour, but do consider different tones of the same colour - perhaps paint one room slightly lighter than the other. As the two are connected there should be some semblance of flow.

Choosing colour should be enjoyable and should not be stressful in the least. Don't rush into anything. Visit the paint store, talk to the professionals, bring home as many swatches as you desire and hang them up all over your home if you wish.

# WB, ADB join forces to electrify Africa by 2030

THE World Bank Group and African Development Bank Group are partnering on an ambitious effort to provide at least 300 million people in Africa with electricity access by 2030.

A statement made available to The Guardian yesterday, the World Bank Group will work to connect 250 million people to electricity through distributed renewable energy systems or the distribution grid while the African Development Bank Group will support an additional 50 million people.

Access to electricity is a fundamental human right and is foundational to any successful development effort. Currently, 600 million Africans lack access to electricity, creating significant barriers to health care, education, productivity, digital inclusivity, and ultimately job creation.

"Electricity access is the bedrock of all development. It is a critical ingredient for economic growth and essential for job creation at scale," said Ajay Banga, World Bank Group President.

Adding that: "Our aspiration will only be realized with partnership and ambition. We will need policy action from governments, financing from multilateral development banks, and private sector investment to see this through,"

demonstration of the determination of the World Bank Group and the African Development Bank Group to be bolder, bigger, and better in tackling one of the most pressing challenges in Africa.

The initiative is the most recent manifestation of the World Bank Group's commitment to become more impactoriented and is the byproduct of a concerted workplan to build a better bank. It is aided by a constellation of regional energy programs that will now be aligned toward this common goal.

For the World Bank Group to connect 250 million people, \$30 billion of public sector investment will be needed, of which IDA, the World Bank's concessional arm for low-income countries, will be critical.

In addition, governments will need to put in place policies to attract private investment, and reform their utilities so they are financially sound and efficient with tariff mechanisms that protect the poor.

Connecting 250 million people to electricity would open private sector investment opportunities in distributed renewable energy alone worth \$9 billion.

Beyond that, there would be substantial opportunities for private investments in gridconnected renewable energy needed to power

# **UAE** reels for a third day after record-breaking storm

THE United Arab Emirates was still grappling yesterday with the aftermath of a record-breaking storm this week that brought much of the country to a standstill.

In Dubai, operations at the airport, a major travel hub, remain disrupted after Tuesday's storm flooded the runway, resulting in flight diversions, delays and cancella-

The airport said on Thursday morning it had resumed receiving inbound flights at Terminal 1, used by foreign carriers, but that flights continue to be delayed and dis-

Emirates, the single largest carrier at the airport, said it would resume checking-in passengers in Dubai at 9 am (0500 GMT) on Thursday, delaying the restart from midnight by nine hours.

The airport struggled to get food to stranded passengers with nearby roads blocked by flood waters, and because of overcrowding limited access to those who had confirmed bookings.

The storm, which hit neighboring Oman on Sunday, pounded the UAE on Tuesday, flooding roads and causing hours-long gridlock as rainwater inundated homes. One person was reported dead in the UAE and 20 in Oman.

Flooding trapped residents in traffic, offices and homes as the UAE recorded its heaviest rains in the 75 years that records have been kept, authorities said.

Authorities have also told government employees and students to stay home while waterlogged roads are cleared.

Climate experts say rising temperatures caused by human-led climate change are leading to more extreme weather events

around the world, such as the storm that struck the UAE and

"It's likely that the storm was kind of supercharged by climate change because there's just more moisture available in the air for any storm system to then precipitate out," said Colleen Colja, a climate scientist at Imperial College London.

Researchers anticipate that climate change will lead to heightened temperatures, increased humidity and a greater risk of flooding in parts of the Gulf region. The problem can be worsened in

countries like the UAE where there is a lack of drainage infrastructure to cope with heavy rains.

A UAE government agency that oversees cloud seeding - a process of manipulating clouds to increase rainfall - denied that any such operations took place before the

The UAE state news agency late on Wednesday carried a statement from President Sheikh Mohammed bin Zayed Al Nahyan saying he had ordered authorities to assess the damage and provide support to families impacted by the

### **AU urges African countries to** build cyberspace capabilities

THE African Union (AU) has called on African countries to build capabilities in cyberspace as countries face increasing cyber threats.

The call was made during a cyber diplomacy-themed workshop that brought together representatives of diplomatic missions of the AU member states at the AU headquarters in the Ethiopian capital of Addis Ababa on April 15-16, the AU said in a press statement issued Wednesday.

Calixte Aristide Mbari, head of the Division of Democracy, Elections and Constitutionalism at the AU Commission, said African countries need to exert concerted efforts to tackle the challenges faced in cyberspace.

"We are witnessing cyberspace increasingly becoming a new ground for geopolitical competition and sometimes attacks against national security," an AU statement quoted Mbari as saying.

According to the AU, the main objectives of the workshop were to initiate an entry point for cyber diplomacy efforts at the AU, raise awareness of existing cyber threats and key cybersecurity priorities, and initiate discussions among the diplomatic community on the nature and extent of the threat.

Noting that African countries are increasingly facing cyber threats and challenges, the 55-member continental organization said Africa has developed the AU Convention on Cyber Security and Personal Data Protection, which was adopted by African leaders back in 2014.

In 1943, the leaders of China, the United States, and Britain issued the Cairo Declaration, which stated that all territories Japan stole from the Chinese, such as Taiwan region, shall be restored to China. The Potsdam Declaration of 1945 affirmed that the terms of the Cairo Declaration would be carried out.

Today, 183 countries recognize the truth about Taiwan's status, including Rosenberger's own country the United States, which pledged to the one-China principle in its joint communiques with Chitive U.S. administrations have stated the U.S. opposition to Taiwan's "independence."

In the course of its millennia-long history, China was more than once engulfed in internal conflict. Yet in each case the Chinese people came together to reunify their country. It is a force not to be stopped by anyone or anything, and certainly not by a flimsy lie.

#### Humanitarian efforts in Gaza doomed without durable ceasefire, says Russia's UN envoy **UNITED NATIONS**

WITHOUT a comprehensive and durable ceasefire, humanitarian efforts in the Gaza Strip are doomed to fail, Russian Permanent Representative to the UN Vasily Nebenzya told the UN Security Council



"We have repeatedly warned that in the absence of a full-fledged, sustainable ceasefire regime, which must be properly monitored through military observers, humanitarian efforts are doomed. Colleagues, humanitarian workers are defenseless against an army. No amount of voluntary deconfliction will help if one side is determined to continue fighting. And especially when there are signals from a member of the Security Council that the Council's resolutions are allegedly non-binding," he said.

He went on to say that hostilities in the Palestinian enclave continue to escalate contrary to the demands of UN Security Council Resolution 2728 and in violation of norms of the international humanitarian law.

"Under these conditions, the delivery of humanitarian aid to the population of Gaza is practically impossible. UN agencies are unanimous in saying that humanitarian access to the enclave is virtually non-existent. According to OCHA, the Israel Defense Forces block half of the humanitarian convoys to Gaza. At the same time, according to information from humanitarian workers, aid is available, humanitarian supplies are waiting at the borders, and there are enough financial resources to organize deliveries. The only thing is to open the checkpoints and ensure security," he said.

Nebenzya is convinced that the work of the United Nations Relief and Works Agency for Palestine Refugees in the Near East (UNRWA) is indispensable under these circumstances.

"We call to pay tribute to the heroism of the Agency's staff, who carry out their humanitarian mandate in inhumane conditions, paying for it with their lives. To date, 178 staff members have lost their lives. That is the highest single-time death toll for a United Nations entity," he said.

"Against that background, attempts to label UNRWA as a terrorist organization and calls to disband the Agency, which we have heard in this Chamber too. are categorically unacceptable. Indiscriminate accusations against UNRWA representatives must not be used to be mirch this large and vital UN entity, which employs 13,000 people in Gaza alone. If UNRWA is suspended, this move will become yet another illegal and immoral instrument of collective punishment for millions of Palestinians in need," the Russian diplomat



#### **US Defence Secretary lauds ties with** India, calls jet engine deal revolutionary

#### **WASHINGTON**

LAUDING the partnership with India, the United States Secretary of Defence, Lloyd Austin, has said that the deal between the two nations to produce jet weapons in collaboration is revolution-

Underscoring that India and the US are also co-producing an armoured vehicle, Austin said that such joint ventures will provide great capabilities.

The landmark jet engine deal was revealed in June of last year, during Prime Minister Narendra Modi's historic official state visit to the US. To produce fighter jet engines for the Indian Air Force, General Electric and Hindustan Aeronautics signed a memorandum of understanding.

Austin's remarks came as he testified before the Senate panel on the 2025 budget on Wednesday (local time).

"We have a great relationship with India. We recently have enabled India to produce jet weapons in India. That is kind of revolutionary. That will provide great capabilities to them. We are also co-producing an armoured vehicle. All of these things when you add them up, are probably more than what we have seen in half of that region in a very long time," Austin told lawmakers.

He stated that all of this "promotes in-

"They all promote helping increase our ability to respond to a number of different things. Again, these are meaningful things that most of us are not aware of. We have made tremendous progress, and we will continue to do so," he added.

Earlier in 2023, US General Electric (US GE) announced that it had inked an agreement with Hindustan Aeronautics Limited (HAL), the government's aerospace and defence manufacturing firm, to jointly manufacture engines in India to power fighter jets for the Indian Air

Moreover, the Biden Administration notified the US Congress in February this year, of its intent to sell nearly 4 billion dollars worth of arms, comprising mainly of the MQ 9 B Drones armed with Hellfire missiles.

The Defence Security Cooperation Agency, which is an agency within the US Department of Defence, said in a press release that the sale helps strengthen the US-Indian strategic rela-

It added that New Delhi continues to be an "important force for political stability, peace, and economic progress in the Indo-Pacific and South Asia region."ment includes the potential joint production of GE Aerospace's F414 engines in India.

### US to impose new sanctions against Iran after attack on Israel

#### **WASHINGTON**

WHITE House National Security Advisor Jake Sullivan has said that the US will impose new sanctions on Iran's missile and drone programmes and new sanctions against entities backing the Islamic Revolutionary Guard Corps (IRGC) and Iran's Defence Ministry in the coming days.

In a statement, Sullivan (pictured) said, "Following Iran's unprecedented air attack against Israel, President Biden is coordinating with allies and partners, including the G7, and with bipartisan leaders in Congress, on a comprehensive response."

"In the coming days, the United States will impose new sanctions targeting Iran, including its missile and drone program as well as new sanctions against entities supporting the Islamic Revolutionary Guard Corps (IRGC) and Iran's Defence Ministry," he added.

Jake Sullivan said that US also expects its allies and partners to impose sanctions against Iran. He said that the US continues to work to further strengthen and expand the successful integration of air and missile defence and early warning systems across the Middle East to further erode the effectiveness of Iran's missile and UAV capabilities.

Sullivan said, "We anticipate that our allies and partners will soon be following with their own sanctions. In addition, we continue to work through the Department of Defense

and U.S. Central Command to further strengthen and expand the successful tegration of air and missile defence and early warning systems across the Middle East to further erode the effectiveness of Iran's missile and UAV capabilities."

He noted that the new sanctions and other measures will continue a "steady drumbeat of pressure" to contain and degrade Iran's military capacity and effectiveness and confront the full range of its problematic behaviours. He recalled that the US, in the past three years, in addition to missile and drone-related sanctions, has imposed sanctions against more than 600 individuals and entities connected to

Jake Sullivan said, "Over the last three vears, in addition to missile and drone-related sanctions, the United States has sanctioned over 600 individuals and entities connected to terrorism, terrorist financing and other forms of illicit trade, horrific human rights abuses, and support for proxy terror-

ist groups, including Hamas, Hezbollah, the Houthis, and Kataib Hezbollah. The pressure will continue.

"We will not hesitate to continue to take action, in coordination with allies and partners around the world, and with Congress, to hold the Iranian government accountable for its malicious and destabilising actions,"

On April 14, US President Joe Biden met with the national security team for updates on Iran's attacks against Israel, calling its commitment to Israel's security against threats from proxies and Iran "ironclad."

In the wake of Iranian drone strikes on Israel on Saturday, Biden held a meeting with his national security team. In a post on X, Biden stated, "I just met with my national security team for an update on Iran's attacks against Israel. Our commitment to Israel's security against threats from Iran and its proxies is ironclad."

Earlier on Saturday, Iran launched several drones and missiles towards Israel in retaliation for the alleged Israeli air strike on its consulate in Syria that resulted in the killing of Iran's three top generals, The Times of Israel reported.

On Sunday morning, Israel Defence Forces (IDF) spokesperson Rear Admiral Daniel Hagari also said that 99 per cent of the 300 or so projectiles fired by Iran at Israel overnight were intercepted by air defences. ANI

#### IMF fiscal chief cautions against fiscal expansion in election year, calls for rebuilding buffers

#### **WASHINGTON**

THE International Monetary Fund (IMF)'s fiscal chief has warned that fiscal expansion is dominating the political discourse in the biggest-ever election year, calling for a durable and credible fiscal tightening to safeguard public finances.

"The empirical evidence from the political business cycle shows that governments tend to spend more and tax less in election years," Vitor Gaspar (pictured), director of the IMF's fiscal affairs department, told Xinhua earlier this week.According to the IMF's newly released Fiscal Monitor, in election years, realized deficits are 0.4 percentage points of GDP higher than budgeted.

"The current political environment is particularly challenging, because fiscal

expansion is dominating the political discourse," Gaspar said. "In general, you see quite a number of demands for fiscal support and public spending in the political arena.'

The latest report showed that global public debt edged up to 93 percent of GDP in 2023 and remained 9 percentage points above the pre-pandemic level. Looking ahead, global public debt is projected to approach 100 percent of GDP by the end of the decade.

While modest fiscal tightening is projected over the medium term, it will be insufficient to stabilize public debt in many countries, Gaspar noted.

Under current policies, primary deficits -- which exclude interest payment -- will remain above debt-stabilizing levels in 2029 in about a third of advanced and emerging market economies and almost a quarter of low-income developing countries.

Higher real interest rates and lower medium-term growth prospects add to debt pressures, said the IMF fiscal chief. He also noted that for low-income developing countries, scarring from the pandemic has been most significant.

"When we look at the extreme case of low-income developing countries, what we do see is that these countries were not able to extend fiscal support in response to the pandemic crisis and the cost of living crisis to the extent that was possible in advanced economies," he said.

On public finance management, Gaspar noted that it's very important to take into account that interest rates are volatile, and "the cost of funding, the availability of funding may fluctuate in ways that can be sudden and unexpected" in some cases.

The report also warned that loose fiscal policy and rising debt levels, in addition to monetary policy tightening, have contributed to the increase in long-term government yields and their heightened volatility in the United States, raising risks elsewhere through interest rate spillovers.

The year 2023 is "particularly remarkable" for the United States in terms of loose fiscal policy, Gaspar said. "In 2023, the cyclically adjusted primary deficit shifted from 1.9 percent of GDP in 2022 to 5.7 percent of GDP, it was multiplied by almost three during one single year," he said.

Tackling debt and deficits today helps avoid more painful adjustments later, he said, adding that it would also create budgetary space for priority spending and to deal with future shocks.

"Fiscal tightening would also be important, an important contributor to completing the last mile of disinflation, especially in economies characterized by excess demand," he said.

For China, the priority should be stable and sustainable growth, said the IMF fiscal chief.Gaspar said that China should be pushing for innovation and reinforcing the domestic sources of growth, as emphasized in the Two Sessions, which refers to the annual session of China's National People's Congress, and the political advisory

"By taking fiscal measures that support spending by households - for example, by strengthening social safety nets - China will be able to sustain the adjustment to a new growth model at the same time that it contributes to macroeconomic stability right now," he said. He also highlighted the need to address problems in the real

estate sector. "So using the significant policy space that China can afford to decisively solve the crisis would also put public finances - in particular at the sub-national level - in a much sounder footing," he said."In our view, China does have policy space," Gaspar

On March 1, the mutual visa exemption agreement between China and Thailand officially took effect, leading to a continuous rise in the enthusiasm for travel between the two countries.

According to Thailand's

Ministry of Tourism and Sports, as of March 31, Thailand received over 9.37 million foreign tourist visits this year, generating around 454.7 billion Thai baht (\$12.38 billion) in revenue. Over 1.75 million visits were from China, making China the biggest source of tourists for Thailand during this period.

The arrival of Chinese tourists has driven the revival of Thailand's tourism industry. Zhang Zhechen works in the hotel industry in Pattaya, Thailand, and has clearly felt the continued recovery of the local tourism sector since March of this

"Since March, the occupancy rate at our hotel has exceeded 90 percent, and there are noticeably more Chinese tourists on the streets and beaches of Pattaya," he

Adith Chairattananon, secretary general of the Association of Thai Travel Agents, stated that in 2023 there were around 3.5 million Chinese tourist visits to Thailand. Driven by policies like the mutual visa exemption agreement, the number is estimated to increase to 6 to 8 million this vear, he said.

In February this year, Thailand's Ministry of Tourism and Sports partnered with the National Institute of Emergency Medicine under the Ministry of Public Health to announce a 50-million-Baht medical

funding to assist foreign tourists in case of accidents while traveling in Thailand.

Thapanee Kiatphaibool, governor of the Tourism Authority of Thailand, said that China has always been a major source of visitors for Thailand, and Thailand hopes to demonstrate to Chinese tourists its continuous efforts to improve tourism safety standards, as well as the unique charm of Thailand as an ideal travel destination.

The mutual visa exemption between China and Thailand has also boosted the enthusiasm of Thai tourists to travel to China. Statistics showed that this March, the number of Thai nationals entering China through the Xishuangbanna airport in the southwest province of Yunnan increased by 1,183.87 percent from a month ago.

On the afternoon of March 1, Thai tourist Santi posted a photo of his passport cover on social media, showing his successful entry into China. The photo garnered tens of thousands of likes. Santi stated that the mutual visa exemption is excellent news for those who enjoy traveling to China.

Sisdivachr Cheewarattanaporn, president of the Association of Thai Travel Agents, said that the mutual visa exemption agreement will promote the development of the tourism industries in both Thailand and China, and facilitate business exchanges between the two

countries. Korn Dabbaransi, former Deputy Prime Minister of Thailand and president of the Thai-Chinese Friendship Association, noted that the mutual visa exemption between Thailand and China reflects a further enhancement of the friendly relations between the two countries, which will bring more ben-

efits and opportunities. The facilitated exchanges between the two peoples will drive growth in tourism revenue, promote cooperation in areas such as economy, trade, culture and education, help deepen understanding and friendship between the two peoples, and lay a solid people-to-people foundation for the longterm development of the two countries' bilateral

#### **Mikel Arteta does** not rotate and **exhausted Arsenal** are paying price

IT is the 94th minute of a Champions League quarter-final. Every player is in the Bayern Munich penalty box, including the Arsenal goalkeeper. More than 70,000 supporters are holding their breath. Bukayo Saka stands over the ball, ready to produce a delivery that could change the course of the night and, possibly, Arsenal's campaign.

Arsenal's set-piece prowess has been one of their biggest weapons this season but here, at the moment when it mattered most, that excellence suddenly faded away. Saka has been Arsenal's most reliable attacker for two years but he, too, faded away. His delivery failed to even beat the first man. Bayern cleared, the whistle sounded, the game was over.

That one dreadful corner was not the primary problem for Arsenal in this defeat. The bigger issue, in terms of the scoreline, was their failure to mark Joshua Kimmich in their penalty box. But Saka's exhausted delivery did speak to the wider picture for this Arsenal team, which appears to have run out of ideas and energy at the defining point of the year.

As was the case against Aston Villa at the weekend, Arsenal started brightly in Munich. They controlled the game, even if there was only one real chance of note, and Mikel Arteta would have been happy at the break. Just as it was against Villa, though, they shrank in the second half. The speed in their legs was gone and so, it seemed, was the sharpness in their

Worryingly for Arteta, it is not the first time that this has happened at this point of the year. This is the third-consecutive April in which Arsenal have run out of steam, and they now must succeed at Wolves on Saturday if they are to prevent the campaign from collapsing like it did last year. On this evidence, their supporters will not feel confident of victory at Molineux.

Why does this keep happening to Arsenal? A lack of rotation is, once again, a potentially crucial factor. For so much of his Arsenal tenure, Arteta has trusted only a small group of key players. In previous years, it led to those same players featuring in almost every minute of every game. It was hardly a surprise that they looked tired in the final weeks of those

This year, Arteta's squad is stronger than ever. They also have very few injury issues. especially when compared to other Premier League teams. Arteta has, however, remained reluctant to switch it up. Only once in recent months has he made substantial changes to his team – and that was against an understrength Luton Town earlier this month.

On Arsenal's bench in Munich were players who, to be blunt, were simply never going to get a kick here. Mohamed Elneny and Cedric Soares are not in the frame. There were others who are no more than fringe players, who Arteta clearly does not trust in the big games. Emile Smith Rowe and Reiss Nelson remained on the sidelines, as did Fabio Vieira.

Between them, Smith Rowe, Nelson, Vieira, Eddie Nketiah and Thomas Partey have started just five matches in 2024. In the case of Vieira and Partey, that is partly - but not entirely - the result of injury, but it is primarily a result of Arteta sticking to the same core players almost all of the time.

There are seven players in Arsenal's squad who have played more than 3,000 minutes this season: William Saliba, Gabriel Magalhaes, Declan Rice, Martin Odegaard, Saka, Ben White and David Raya. Kai Havertz has played 2,949 minutes. If these players are fit, they always play. White, and Saka, especially, looked absolutely drained in the second half in

The key question here is whether Arteta is to blame for not lessening the load on these players, or whether the problem is that his alternative options are simply not good enough. Should he show more faith in Smith Rowe, for example? Should he be more willing to remove Saka from the action? In the second half, with the team so desperately short of creative spark, it was clear that his players were struggling with the weight of it all.

Arteta could see what was happening but there was nothing, on the night and in the moment, that he could do. In the 67th minute, shortly after Bayern's decisive goal, the Arsenal manager windmilled his arms on the touchline, urging his players to increase the tempo.

A few minutes later, Odegaard did the same. He screamed at his team-mates, demanding more energy. But there was no more energy for Arsenal to give, and by that point Bayern had a hold of the game with the tightest of fists. Arsenal, drained and dismayed, were never going to snatch it back.

# Real Madrid now exact revenge on Man City to reach Champions League semis

EAL Madrid exacted revenge on Manchester City to reach the Champions League semi-finals 4-3 on penalties after withstanding a barrage at the Etihad on Wednesday.

Rodrygo gave the visitors an early lead before Kevin De Bruyne hit back for the holders to leave the match level at 1-1 on the night and 4-4 on aggregate.

However, City's defence of the competition came to an end after Bernardo Silva and Mateo Kovacic saw spot-kicks saved by Madrid's unlikely hero Andriy Lunin.

The Ukrainian, who has deputised this season for the injured Thibaut Courtois, had been at fault for City's early opener in a thrilling first leg but more than made amends.

City had not lost at home in the Champions League since 2018 but the holders were held at bay by a heroic defensive effort by the 14-time European champions despite having 34 attempts on goal.

# Kimmich heads Bayern past Arsenal into Champions League semis

MUNICH

A 63rd-minute Joshua Kimmich header gave Bayern Munich a 1-0 win over Arsenal and a place in the Champions League semi-finals on Wednesday.

aggregate quarter-final victory means Bayern return to the last-four for the first time since winning the title in 2020.

Bayern will face either Manchester City or Real Madrid for a place in the final.

The result continues a poor week for Arsenal, who conceded top spot in the Premier League table on Sunday with their first league loss of 2024.

"We can enjoy this one. The first half was cagey and then we upped the tempo," Bavern striker Harry Kane told TNT. "These games are tough and we had to find our way through them. It's going to be a tough semi

final whoever we play." Arsenal boss Mikel Arteta said his side had "wanted it so badly".

"However, you can see with many other clubs that sometimes it takes six or seven years to get to that stage. We were very close, that is the reality."

Unlike last week's four-goal spectacle in London, Wednesday's match was a cagey affair, with few clear chances for either side in a testy opening half.

Midway through the second-half and with extra-time on the horizon, Kimmich burst through the Arsenal box and headed in a perfect Raphael Guerreiro chip.

Guerreiro, pushed from wing-back to the forwards due to Bayern's injury woes, impressed as a creative presence when freed up from his usual defensive duties.

Hit by injuries to several first-team attackers including former Arsenal winger Serge Gnabry -- who scored along with Kane in the first leg -- and Kingsley Coman, Tuchel pushed Guerreiro into an unfamiliar advanced role.

The move worked early, with the Portuguese finding space down the left flank and linking well with Jamal Musiala in the centre.

Arteta opted for the defensive stability of Takehiro Tomiyasu in place of Jakub Kiwior at leftback to neutralise Leroy Sane but the Japanese, who was making his first start since December, notably lacked rythym.

Tomiyasu completely misjudged a Musiala pass early, allowing Sane to stroll through the Arsenal box and force a corner.

Gabriel Martinelli was the visitors' most dangerous player in the opening half. He scuffed a curling ball just wide of the post after seven minutes and then shot directly at Manuel Neuer with the goal beckoning on the halfhour mark.

Bayern were the better team after the break Six-time Champions and went close immediately, Leon Gore- tors' hopes of a return to tzka heading a clever Kimmich cross onto the woodwork.

The pressure began to tell and Bayern broke through after 63 minutes when Kimmich, among the shortest players on the pitch, was allowed to slip through a crowded Arsenal box and head in a Guerreiro chip.

The hosts almost doubled the tally moments after when Kane found an unmarked Sane in the box, but the Germany winger blasted his shot skywards.

Arsenal pushed for an equaliser and went close in stoppage time when Kai Havertz and Bukayo Saka lashed at a bouncing ball in the box but could not break through, ending the visithe Champions League semis for the first time since 2009.

Meanwhile, Arteta has urged Arsenal to use the "pain" of the Champions League quarter-final exit against Bayern Munich to fuel their Premier League title bid.

Arteta's side failed to clinch a first semi-final appearance since 2009 as Joshua Kimmich's second half header gave Bayern a 1-0 second leg win and a 3-2 aggregate success.

It was a bitter evening in Munich for Arteta and his players, who had dreamed of leading Arsenal to their maiden Champions League crown.

After a blistering run carried them to the top

of the Premier League PSV Eindhoven, Lens and into the Champions League last eight, Arsenal have endured a nightmare week.

They were below their best in the 2-2 first leg draw with Bayern, then surrendered pole position in the Premier League after conceding two late goals in a 2-0 home defeat against Aston Villa on Sunday.

After producing another underwhelming display in Germany, Arteta has to find a way to lift his team's shattered morale in time for a last push for the English title.

"We were very close, that is the reality. It's painful, but we have to learn from this. We had our moments, especially in the first half," Arteta said. "The players gave their best, we didn't have that magical moment that we need in the competition.

"In the first leg, we conceded two avoidable goals, which had a significant impact on the draw. We were still alive when we arrived here. The margins are so fine. A mistake or a moment makes the difference."

After a lengthy absence from the Champions League, Arsenal largely acquitted themselves well. They won their group ahead of

and Sevilla before beating Porto on the penalties in the last 16.

But Arteta conceded a lack of experience in the latter stages of the competition proved a key factor against Bayern, six-time European champions who are perennial contenders for the trophy.

"We haven't been in this position for 14 years. we haven't played in the Champions League for seven years. There's a reason for that. Today's match will make us better." he said.

"I think we have the capacity and the quality to be in the semi-final. When you look historically, it took other clubs seven, eight or 10 years to do it in the Champions League.

"It's easy to praise the players and talk nice things when we win 10 in a row and one draw (in the Premier League). The moment is now to be behind them and be next to them."

Arsenal have little time to lick their wounds, with the title race approaching a gripping conclusion. Arteta's side are in second place, two points behind leaders Man City.

THE race for the 2023/24 NBC Premier League season top goal scorer award is gathering momentum as the campaign enters the homestretch.

Yanga was not in league action for almost one month due to the international break and CAF Champions League engagement.
