

# 40,000 animals dead as drought takes hold

NEARLY 40,000 animals, mostly herded livestock have died for lack of grazing pastures and water as drought conditions spread over most parts of the northern zone.

Nestory Daggaro, the district livestock and climate change officer at the border district of Longido made this observation yesterday at a meeting to review recent reports on indigenous communities' resilience to the effects of climate change.

The material collected from recent research activities was placed for discussion in the meeting organised

The material O collected will be published and distributed, to inform policymakers on the vital importance of indigenous knowledge

by Media Aid for Indigenous and Pastoralist Community (MAIPAC) with sponsorship by the United Nations Development Programme (UNDP).

Its agency, the Global Environment Fund (GEF) worked with the Tanzania Natural Resources Forum (TNRF) to discuss traditional protection of water sources and forests in efforts to control

the impact of climate change. During the past few months, the area has been experiencing the loss of large numbers of livestock, estimated at upwards of 39,000 and a scatter of wildlife also perished as water

the foundation stone for the Kabingo-Kasulu-Manyovu road, a 260.6km highway.

She also switched off generators earlier used to produce power and turned on a switch that connects the region to the national grid, noting that government plans are to make Kigoma a strategic region economically,

The generators must be maintained so that they can be used whenever needed, she said, applauding the region for being connected to the national grid. More investors are likely to opt for Kigoma in the wake of improved electricity services, she said.

The president commended the African Development Bank (AfDB) for supporting the projects, along with a 360.5bn/- low interest loan for the Kabingo-Kasulu road.

Prof Makame Mbarawa, the Works and Transport minister, said that road construction opens up economic and social opportunities by easing the transportation of people and goods. The new roads will stimulate industrial production, elevating fishing and agriculture sectors as well, he stated.

Trade with Rwanda, Burundi, Uganda and the Democratic Republic of Congo will be strengthened as well, with the construction of the Kidawe-Kasulu road fully financed by the government at 64.7bn/-, he elaborated.

Energy minister Januari Makamba said connecting the region to the national grid has helped with operational costs as TANESCO was using 12,000 liters of fuel (144m/-) to generate electricity in Kasulu District alone.

"A total of 52bn/- was spent per year to purchase fuel for the generators while customers could only pay 14bn/- annually. We were spending more than what we were collecting from power purchasers," he said.

Prof Adolf Mkenda, the Education, Science and Technology minister, said the government plans to construct a branch of the Muhimbili University of Health and Integrative Sciences (MUHAS) in Kigoma Region, for which a plot

sources dry up and grazing areas are reduced to hard stems and host

Other than the cattle, wildlife counted 18 zebras, four giraffes and two gazelles which had so far died from the drought, he said, with 19 donkeys, sheep and goats added to the mix.

He pointed at belated efforts in Monduli District to dig wells and create watering ponds for livestock and wildlife ranges, to shore up the district's economy.

Apart from drought, invasive plant species have been a major problem in grazing areas where the alien outcrops stifle edible grass and cause diseases to animals that consume the strange crops, herders

Experts discussed what to do about the invasive plants' problem at the climate change consultative meeting, as background work to the nature-based conservation initiative, focusing on 'forest, water and environment conservation, using indigenous knowledge.'

District officials said this year, the average rainfall for Longido dropped to less than 50mm during the March to May rainy season, whereas the district obtains upwards of ten times that level of precipitation annually.

This year the rain gauges in Longido pooled in an average of 45millimeters of rain, a shocking drop in the district's history, an official remarked.

TNRF executive director Zakharia Faustine pointed at the need for inclusive strategies among the various stakeholders to fight the effects of climate change, pointing civil society organisations, government, international organisations and the various communities.

Collecting traditional knowledge is meant to apply it to fight the effects of climate change by preserving forests and water sources. MAIPAC p efforts are part of strategies to get information for regulatory improvement, he stated.

He lauded MAIPAC and the Civic and Legal Aid Organisation (CiLAO) for initiating the project, linking 12 other environmental projects sponsored by UNDP, involving traditional communities in environmental preservation.

Kilei Mollel, the Kimokoia village chairman in the district, said the government and NGOs including Community Research and Development Services (CORDs) units to uproot invasive weeds, with more than 1,000 hectares of land area invaded by the weeds

MAIPAC Director, Mussa Juma and his CiLAO counterpart, Odero Charles Odero said activists visited Longido, Ngorongoro and Monduli to collect traditional knowledge in regard to the preservation of the environment.

## House panel satisfied with JNHPP progress

THE Parliamentary Energy and Minerals Committee has shown its satisfaction with the progress of the ongoing construction of the Iulius Nyerere Hydro Power Project (INHPP) aimed to increase the country's power generation.

Speaking during the panel's visit to the project site, its vice chairperson Eng Stella Manyanya said the project implementation was going fast and that her panel was satisfied with the progress that has now reached 74 per cent.

"I should say that 74 per cent is no mean accomplishment, as you now see, all these 27 transformers to be installed in the project show that the project is in its final stages of completion," she said.

Eng Manyanya called on the government to have a procedure to identify the youth implementing the big strategic project to enable them to increase the skills gained so that they can be used in other similar projects as needed

She said the project has provided about 13,000 jobs while 11,800 for indigenous and 1,200 for foreigners and will cost 6.5trn/- upon

completion. She added that JNHPP will add

2,115 MW to the national Power Grid (NPG) which will have a capacity of over 5,000MW by 2025.

For his part, TANESCO Assistant director, Eng Athanasius Nangali said they were ready to implement the project to the required quality to assist in the country's economic

"We shall continue working day and night to ensure the project is completed to the required work standards for the country's development," he said.

## UN vows to step up its partnership with Somalia on counter-terrorism

MOGADISHU

On the occasion of the fifth anniversary of the suicide bombing in the Somali capital of Mogadishu on 14 October 2017, the United Nations yesterday joined the people and government of Somalia in remembering the victims and survivors of the deadly attack.

"Time may have passed but the widespread pain caused by this horrific attack remains, and our thoughts go out to those people who lost family and friends as well as to those who were injured," said the Special Representative of the Secretary-General for Somalia,

"The United Nations stands firmly with all Somalis in their tireless efforts to end terrorism and to advance Somalia on its path to peace and stability," he added.

The 2017 attack which killed more than 500 people and injured more than 300 others, ranks as the deadliest-ever terrorist bombing in Africa, involving the use of improvised explosive devices (IEDs).

Assailants with pistols killed one of the clan delegates who elected members of the Somali Parliament in the Warta-Nabada district within Mogadishu.

Abdi Araaye Moalim was shot

the body by the gunmen, thought to be Al-Shabaab members early on Saturday morning.

The late Araaye voted MP in the Galmudug constituency at the beginning of this year. Al-Shabaab group claimed his killing.

The security forces of the Somali government reached the crime scene but failed to arrest the killers, who immediately escaped on foot before their arrival.

Meanwhile, The minister of Commerce and Industry Minister Jibril Abdirashid Haji on Saturday issued yesterday a new stiff warning

to the business community. Speaking at a press conference

several times in the upper part of in the capital, Haji warned the local traders against dealing with Al-Shabab and heeding the group's directives, including the tax payments.

The minister added that the Somali government decided to revoke the license of any firm that violated or reject the order. He also said the violators' assets will be taken over.

Haji termed it illegal and crime financing terrorism.

This comes amid a nationwide military offensive against Al-Shabaab which led to the liberation of more than 40 areas in the Hiran and Galgadud regions since last

## PB opens doors for crop purchases

CEREALS and Other Produce Board (CPB) in the country has opened doors for the purchase of various crops from farmers, especially food crops.

This was revealed at the weekend by CPB Commercial Officer for Lake Zone, Frank Bubelwa, saying the aim is to help to reduce market challenges facing farmers.

He said after buying the crops, the Board will add value thereon and sell them locally as well as export, and added that the crops will be bought at current market 

"We have decided to start buying the crops after seeing many farmers complaining about lack of markets after harvesting and even those available used to be defrauded by big businessmen," said

He added: "In the circumstances, we saw that and decided to help as a way to motivate them to continue farming, even though some of them despaired.'

He mentioned some of the crops they buy including rice, maize, beans, and all leguminous crops for food and nutrition.

"The criteria in buying the crops

include that they should be clean without any impurities or sand in regard to rice, and we weigh them in the presence of farmers themselves," Bubelwa said.

"We also buy the crops at current market prices. For example, if the beans are sold at 2,000/- a kilo, we also buy them at the same price. In addition, we add value to them after purchase for both local and external markets," he said.

He said already they have opened up branches for selling crops in all East African countries and called on farmers to continue farming cash crops.

# Health ministry issues warning on possibility of outbreak of cholera

THE Ministry of Health has issued a warning against cholera, especially in the regions and districts bordering the country of Malawi due to the interaction of economic and social activities between the people of those countries.

Dr Aifello Sichalwe, Chief Medical Officer (CMO) issued the warning yesterday after the Malawian Minister of Health on October 14, this year gave information about the outbreak of the disease in the southeastern African nation.

Reports have it that so far the disease has spread in 25 districts in Malawi, with 132 deaths reported along with the infection of approximately 4,604 people.

Due to that Dr Sichalwe, said that the disease is contracted by eating food or drink contaminated with bacteria called 'Vibrio cholerae', explaining that those bacteria are found in the faces and vomit of a cholera patient or an infected person who has not yet shown symptoms.

He said that in order to control the disease from entering and spreading in the country, everyone should pay attention to washing their hands with soap and clean and safe running water after going to the toilet or bathing a child who has defecated.

"The main symptoms of cholera disease are continuous diarrhea with watery stools similar to the color of the water that has been washed with rice that does not give off an odor, continuous vomiting, fever, lethargy, thirst and exhaustion, the patient may lose his life if he does not receive medical care within a short time," said Dr Sichalwe.

Dr Sichalwe asked the citizens to wash their hands with clean and safe water after attending to the patient, to wash fruits with clean water before eating, to stop the flow of water from the toilet.

He said that people should give information and go to the health

care center if they get diarrhea or vomiting while emphasizing the construction of toilets, use them and keep them clean at all times so that pathogens do not enter the environment including water and

He also insisted on giving information if there are people with symptoms of cholera in the community by calling the free phone number 199.

"Another thing that should be considered is to boil drinking water or treat it with special medicine and take good care of it during use, avoid contamination of water sources, shower, wash, throw away waste and avoid eating food that has cooled or prepared in an unclean and unsafe environment," he said.

He also asked health officials to manage the cleanliness of the environment in their areas and people to follow the instructions given by health experts on protecting themselves against various diseases.

# Stakeholders commend govt for coming up with Universal Health Insurance bill

STAKEHOLDERS commended the government for coming up with a Universal Health Insurance (UHI) bill saying apart from improving the provision of health and facilitating quality healthcare, it will reduce poverty amongst Tanzanians.

They were concerned that most Tanzanians who were hardly paying medical bills from their pockets would now save the money for other development activities.

Director, Mbeya Zonal Referral Hospital, Dr Godlove Mbwanji said that most families were falling into poverty by selling some of their properties to clear medical bills for their relatives.

"Once a family member fell sick increase the number of Tanzanians health insurance schemes such and required specialized medical care; relatives were forced to sell some properties to settle hospital bills. This resulted in increased poverty at a family level," said Dr Mbwanji when speaking at a journalist training in Mbeya Region.

He added: "The universal health coverage plan would ensure access to quality health care to all Tanzanians. People will get quality medical treatment without having money to pay for bills. No one will be forced to sell his/her property to clear medical bills at hospitals."

Head of the Treatment Department at the hospital, Dr Uwesu Mchepange said the universal health coverage plan will registered at health insurance schemes.

Dr Mchepange noted that only 15 percent of Tanzanians have health insurance schemes while the remaining 84 percent had to pay medical bills from their pockets.

"Only 15 percent of the population have health insurance; out of them, 8 percent are enrolled with the National Health Insurance Fund (NHIF), 6 percent have been registered with the Community Health Fund (CHF) and 1 percent use health insurance services provided by private companies.

He said there are a number of countries that have succeeded in fully enrolling their people with

as Rwanda, which has almost 90 percent of its citizens enrolled with health insurance schemes. He said Ghana has 40 percent of the population with health insurance.

The Universal Health Coverage bill was ready for the first time in the National Assembly yesterday with various proposals including imprisonment and a 5m/- to 100m/- fine for suspected dishonesty in the use of health insurance schemes.

The bill also proposes moves to scrutinize private health service providers including the appointment of National Health Insurance Fund (NHIF) authorities in boards of private hospitals to facilitate regulation.

## Ensure your activities are in line with conservation efforts, govt tells residents of 46 villages in Simiyu

THE government has allowed residents of 46 villages in Simiyu region who were in land use conflicts in protected areas to continue with their activities as long as they do not threaten conservation efforts within the 500 metre fenced area.

On the same note, 48 villages which were in similar conflicts are now being evaluated to facilitate annexation of land from the Wildlife Management Area (WMA).

The villages which have been allowed are those operating within the 500 metre fenced land around

Minister of lands and human settlement development Angelina Mabula made the remarks when a committee of eight ministers from various sectors visited the region after a tour in various districts to address land conflicts in 975 villages.

According to Dr Mabula who is the chairman for the committee said when the decision is issued, the region will have the mandate to oversee implementation.

"A committee of experts from the national level to the lower level

Serengeti National Park, Maswa started an evaluation exercise in September," she said.

Dr Mabula said the evaluation involved local leaders up to the village level to ensure land conflicts are addressed.

Deputy Minister of Agriculture Anthony Mayunde said his ministry is there to implement the Agriculture Act to facilitate sustainable farming which is friendly to the land.

Some of the proposals in the ministerial committee on addressing land conflicts include retaining villages in protected areas; identify protected areas which have lost titles so that they

are divided to the people and to conduct demarcation of wildlife and residential land.

The proposals also include dividing the land and giving it to residents and pastoralists as well as proper land use management systems namely water sources which also speaks of 60 metres and

deregistering undeveloped farms. Recently president Samia Suluhu Hassan approved 67 villages within reserved areas in Morogoro Region to continue existing to enable their residents to continue with their

The move by the Head of State was one of the efforts by the sixth phase government to find lasting solutions for land conflicts in 975 villages and streets across the country.

# Z'bar energy minister identifies 14 residences that use power illegally

ZANZIBAR Minister for Energy and Minerals Shaibu Hassan Kaduara has identified 14 residences that use power illegally by bypassing electricity meters, a practice that deny revenue to the Zanzibar Electric Company (ZECO).

The houses were located in Mazizini, Chukwani and Mbuyu Mnene during a special crackdown that aimed to connect power to various houses as well as hunting people using power illegally in various areas of Unguja and Pemba.

Addressing reporters at Mbuyu Mnene area at the weekend, Kaduara said ZECO lose a lot of revenue in this way, adding that those found will be penalized.

He further explained that the culprits will also be charged for the power they used illegally by identifying the electric appliances in the house and the period owners thereof had been using power

"Within two days I have identified 14 houses using power illegally, with some who tampered with the meters and some who bypassed them," said the minister.

Earlier, the minister addressed ZECO workers and told them that whoever among them will be found to have colluded with power thieves will be sacked, and added that he had earlier announced that if any ZECO worker who had colluded with the culprits come forward he or she could be forgiven for the crime, but no one came forward to

He said he already has some of the names of ZECO workers who colluded with power thieves, and added that he will fire them as he is not ready to be sacked himself for protecting criminals.

He also directed ZECO officials to pay benefits to workers who were reinstated after being sacked.

Meanwhile, the Ministry's Permanent Secretary, Joseph Kilangi called on members of the public who want the power to be connected to their houses to directly call him by phone (0777420741).

He also stressed discipline at work saying discipline starts with early attendance at work, cooperating with others and must be accountability in order to reduce complaints from members of the public.

The exercise to connect power to people seeking power services and identify power thieves dubbed "Kaduara Operation" involved various officials from the Ministry of Energy and Minerals.

### World Food Day: AfDB marks key goal in interventions to feed Africa

THE African Development Bank (AfDB) has launched the African Emergency Food Production Facility to enable the production of 38 million tonnes of food over the next two years.

The idea is to mitigate the impacts of soaring food prices and grains, worsened by Russia's war in

The \$1.5 billion facility stepped into action, with the bank approving initial programmes in 26 African countries at a value of \$1.257 billion. The Bank Group's African Emergency Food Production Plan will provide 20 million farmers across Africa with seed varieties of primarily wheat, maize, rice, soybean and oil palm, as well as access to fertilisers to produce additional food worth \$12 billion.

"Africa should not be importing food. Africa should become a major food-producing region and export its surplus to the rest of the world. If there is one thing Africa can do - it is to help the world feed itself," said African Development Bank Group President Dr Akinwumi Adesina at a knowledge exchange event organised by Yara International. Yara International, a Norwegian chemical company, produces, distributes, and sells nitrogen-based mineral fertilisers.

"Africa offers enormous opportunities in agriculture, with 65% of the world's uncultivated arable land still available to feed the world's population, so its actions will determine the future of global nutrition. Furthermore, Africa's food and agriculture market will reach \$1,000 billion by 2030," Adesina assured Norwegian businessmen at the Norwegian-African Business Association (NABA) summit on 29 September.

The bank's initiative has drawn global support, including from UN Secretary-General Antonio Guterres and US President Joe Biden. The Government of Japan, through the of food.

Japan International Cooperation Agency, has partnered with the bank to boost agricultural production in Nigeria, Tanzania, and Côte d'Ivoire. In early October, Norway announced a \$9.2 million allocation for the African Emergency Food Production Facility. International development agencies have also lauded the bank's initiative.

African countries expect to record a significant boost in agricultural production as a result. With African Emergency Food Production Facility assistance, Senegal, for example, aims to harvest an additional 600,000 tonnes of cereals like rice, maize and millet, as well as about 120 tonnes of cowpeas and 150,000 tonnes of potatoes. In Côte d'Ivoire, the bank's support will help produce an additional 546,987 tonnes of maize, 796,323 tonnes of rice, and more than 1 million tonnes of cassava.

The bank's African Emergency Food Production Facility aims to deliver climate-smart seeds and access to affordable fertiliser to 20 million farmers across the continent.

For the Bank Group, progress towards achieving these goals is irreversible, given the African Emergency Food Production Facility will center on another successful bank initiative: Technologies for African Agricultural Transformation (TAAT) programme.

TAAT provides producers climate-resilient with innovative agricultural technologies. Launched in 2018, the programme has been a resounding success. In Ethiopia, heat-tolerant wheat varieties have helped the country become wheat self-sufficient within just three years. Next year, the country expects to become a net exporter of wheat to Djibouti and Kenya. The programme has provided improved agricultural technologies to nearly 12 million farmers and supported the production of 25 million tonnes

## ActionAid calls for establishment of special safe houses for victims of GBV

ACTIONAID Tanzania has called for the establishment of special safe houses to ensure the safety of Gender Based Violence (GBV) victims and to facilitate proper investigations.

Joyce John, ActionAid Tanzania's programme officer made the remarks recently at an event to mark the International Day of the Girl Child in Kilwa- Masoko in collaboration with a women's platform–'Tumaini Jipya kwa Wanawake Kilwa (TUJIWAKI).'

The event involved police, students from both primary and secondary schools, Resident Magistrates in Charge, local communities from different villages across the district, and Social Welfare Officers.

"Safe Houses are very important as they will accommodate survivors of GBV, preparation for the legal process, obtain psychosocial support services, keep the survivors from any further potential harm from the alleged perpetrators and allow them to report GBV incidents comfortably to the responsible authorities," she said.

She said in a bid to help GBV survivors get their rights and even benefit from the safe houses, ActionAid Kilwa through Kilwa Rights Programmes has been training communities on violence against women and girls.

Joyce said the training ranges on the meaning of GBV, types of GBV, how it happens and how to report incidents once occurred within their localities.

"Through the knowledge and skills gained from ActionAid Kilwa at least women are now becoming aware of the GBV issues and they are now reporting GBV cases to the responsible authorities," she

So far GBV cases have been reported to the Police Gender Desk, Tumaini Jipya kwa Wanawake Kilwa (TUJIWAKI) platform and social perpetrators are taken to justice/ court.

Currently, ActionAid Kilwa is implementing the programme to prevent violence against women and girls in Kilwa district council.

According to Social Welfare Officer in Kilwa District Council, in 2022 a total of 55 gender-based violence (GBV) cases were reported at Kilwa District Social Welfare Officer desk.

Among those, 46 cases are abandoned children, nine are matrimonial and child maintenance cases, and 5 cases were reported to the court.

She said among those five cases, three cases were convicted and two are still pending in court.

"Before ActionAid -Kilwa intervention there were many unreported cases and the GBV situation was bad in the district which has a population of 190,000 according to the 2012 census," she

She said, at the local level, ActionAid Kilwa is working with TUJIWAKI platform, Kilwa Youth Development Organisation (KIYODI), women's reflections to create awareness on GBV against women and girls.

At the district level, they are working with the district social welfare officer, police gender desk, court and religion leaders.

TUJIWAKI's chairperson, Theodora Mkundi lauded ActionAid Kilwa for implementing the programme in the district.

"Right now women and girls are aware of GBV-related challenges and we are seeing women getting their rights something which wasn't the case in the past," she said.

Kilwa District Magistrate In-Charge, Alice Mkasela called on parents and guardians in Kilwa district to protect girl child and assist them to meet their dreams.

Also, ActionAid Kilwa and TUJIWAKI should continue to provide training on GBV issues for parents, girls and religious leaders to help more people understand what is GBV and the effects it has on welfare officers in the district and them, how to report GBV incidents and religion leaders should also offer religious education.

## BMGF in \$1.2billion promise to end all forms of polio globally

**BERLIN**, Germany

THE World Health Summit and the Bill & Melinda Gates Foundation have announced a \$1.2 billion commitment to support efforts to end all forms of polio globally.

The announcement was made ahead of a key pledging moment that will be co-hosted by Germany and the Global Polio Eradication Initiative (GPEI).

The new financial commitment will support the implementation of the GPEI's Polio Eradication Strategy 2022-2026, which aims to end wild poliovirus in the last two endemic countries-Pakistan and Afghanistan–and stop outbreaks of new variants of the virus. The foundation has contributed nearly \$5 billion to GPEL

"Polio eradication is within reach. But as far as we have come, the disease remains a threat. Working together, the world can end this disease," said Bill Gates, co-chair of the Bill & Melinda Gates Foundation.

"I want to thank Germany for co-hosting this week's events and its longstanding support for polio eradication, and I urge other donors to support the eradication strategy to ensure no one is paralyzed by polio again."

On October 18, Germany will cohost the GPEI pledging moment at the World Health Summit, where global partners, donors, and country leaders will make further commitments toward the GPEI Strategy 2022-2026, which requires \$4.8 billion in funding.

If fully funded, GPEI will reach

370 million children each year with polio vaccines and other essential health services. GPEI's efforts include deepening relationships with communities, supporting governments in responding to outbreaks, and helping advance the rollout of a next-generation polio vaccine. Investments in GPEI also help

strengthen national health systems and ensure that countries are better prepared to respond to future health threats. In addition, the strategy continues the GPEI's commitment to achieving gender equality across all levels of the program.

"The last steps to eradication are by far the toughest. But our foundation remains dedicated to polio [1] free future, and we're optimistic that we will see it soon," said Mark Suzman, CEO of the Bill & Melinda Gates Foundation.

Another concern is countries that had previously eliminated all forms of poliovirus have recently reported new detections of the virus.

USA and United Kingdom each confirmed outbreaks of variant poliovirus and were added to the World Health Organization's outbreak list in September 2022. Malawi and Mozambique each detected cases of wild polio that originated abroad in 2022.

In 2019, Gavi, the Vaccine Alliance became GPEI's sixth core partner, further strengthening their collaboration. GPEI will continue its focus on interrupting virus transmission and eradicating polio through immunization campaigns using the oral polio vaccine (OPV).

TANZANIANS have been asked to include people with disabilities in various socio-economic activities including job opportunities as well as decision making as they have equal rights like any other person in this world.

Hussein Msacky, founder and Managing Director of Miembeni Action and Passion for People with Disability (MAPPD) said yesterday that, there is no definable physical and social infrastructure for people with disabilities in most of the schools in Tanzania from primary school to higher learning institutions.

He said that in the special

integrated schools there are no special learning materials for people with disabilities like brailed textbooks for the pupils/students with low vision or total blindness; the problem that hinders their studies, thus ending up beggars in

"Also community members should have enough knowledge on the rights of people with disabilities to avoid stigma to the people with disabilities by hiding them in their houses..." he insisted.

He appealed to the local government to have community interventions to identify people with disabilities and enroll them in schools as some people do hide them in their houses.

organisation will this week launch a special center in Rombo district for children and youth with various disabilities, insisting that there is no need to hide them in their homes.

"It is estimated that 70% of the

pupils with various disabilities are from very poor families, and their parents/guardians cannot afford to take care of them due to their special needs that is why Miembeni Action and Passion for People with Disability will in this week launching a special center for them as well as making sure they are enrolled to school for further studies," he explained.

Children with special learning needs refer to children with learning

According to him, his difficulties, a behaviour disorder and/or a disability. These children have diverse abilities and learning needs. Parents or caregivers are often the first to notice that their child's development is delayed or that their child is having problems at school.

The term disability includes children with an intellectual disability, physical disability, vision impairment, hearing impairment, language disorder, mental health conditions or autism.

Children with learning difficulties experience difficulties learning in one or more areas of the curriculum. These difficulties may vary in cause, nature, intensity and duration.

# Take correct measures against environmental degradation culprits, govt urges law enforcers

THE government has directed law enforcement to take immediate steps against suspects alleged in environmental degradation.

Selemani Jafo, Minister of State in the Vice President's Office (Union and Environment) gave the directive yesterday at Kilakala Girls Secondary School in Morogoro Region at the ongoing 'Soma na Mti' campaign organized by the national environmental ambassador, Chage Alex through the vice president's office.

The event brought together educational officials, over 100 students from nearby schools, officials from the regional office, International Center for Sustainable Investment (ICSI) and National **Environment Management Council** (NEM).

Jafo said the tree planting campaign is conducted in Morogoro Region to promote environmental conservation and educate residents on the impacts of burning forests.

He said Morogoro is among the top regions that have lost its biodiversity through environmental degradation including bushfires.

"The government will take immediate steps against anyone who discourages movement to protect the environment. Our plans are to plant 276 million trees per year. To reach the target each of the councils is required to plant 1.5 million trees," he said.

According to the minister, environmental conservation includes other activities such as cleanness, the use of improved stoves and recycling materials as an alternative energy source.

"May I congratulate authorities

Michael in Dar es Salaam Region; the city emerged as number one in last year's cleanness category, followed by Katavi Region which was the first one in natural forest conservation. Morogoro was named the best in terms of high speed of protecting the environment through planting trees," he added.

National Environmental Ambassador, Chage Alex called upon stakeholders to support the 'Soma na Mti' campaign because it also targets planting fruit trees which are useful in protecting the environment and a source of income for individuals.

"Reports show that trees planted in residential areas and public offices are not part of increasing income; under the 'Soma na Mti' campaign, we are going to plant seven hundred trees across the country annually. We target to plant 12 million trees before 2030," said

Chief Executive Officer, Festo Mwandenene said there are many tree planting campaigns that are not sustainable.

"We launched the campaign to make sure every individual plants a tree when celebrating his/her birthday. Through this programme, it is our hope that youth, elderly and disabled will plant trees," he said.

Acting Regional Administrative Secretary, Eng. Ezron Kilamhama said they have strategies for the restoration of natural vegetation through tree planting campaigns which include residents along the Uluguru Mountains.

"We insist people to plant trees that are friendly in residential areas. We are also planning to establish a clove plantation in the Uluguru Mountains, our regional officials are in Zanzibar to learn how to start the clove farms," said Kilamhama.

## Global poverty eradication goes beyond human rights

year is an International Day for the Eradication of Poverty, the most perplexing issue in economic discussion and in policy design. The theme comes up two days from the marking of founder president Mwalimu Nyerere's death in 1999 as his period in office illustrates the discrepancy between hating poverty and removing it. No agreement exists on what policies are best to reduce and ultimately eradicate poverty; massive growth lives with poverty very closely.

A United Nations chronicler says the 2022 theme is 'Dignity for All in Practice,' which is largely underlined in the UN sustainable development goals programme that is taking the world up to 2030.

Recently World Bank president David Malpass, whose organisation is the central agency for the UN to steer policies meant to reduce and eradicate poverty worldwide, admitted that the poverty eradication goal set for 2030 was no longer visible. While that applies for around two thirds of UN member states the picture is darker for Africa, as poverty seems sharply on the rise.

In a speech at the weekend, President Samia Suluhu Hassan appealed for lower birth rates to match existing social services, speaking of her experiences at the Buseresere area in Kagera Region. She was told that one health center helps nearly 1,000 mothers to deliver, each month, demanding what will be the case after three years. She wondered if the government was in a position to add one thousand new primary school spaces each month, for each district in the country. That

That was the mood when the slogan 'New Tanzania' was coming in the past decade, but after a while, 'spell checkers' are brought in and the picture that emerges isn't cool. > When the UN picks dignity as the theme, the idea is that of 'leaving no one behind' in the quest for education, health cover, food security, acceptable habitat and decent work. Anyone assured of those things might be poor but not in abject poverty, where food security and habitat fall off first, then health, etc. But then, does posing these things as fundamental rights change anything in actual reality?

> That is precisely where the problem lies, that activists the world over see these basic needs to assure human dignity - which are essential to the global eradication of biting poverty - in terms of rights. The best way to secure the rights of everyone is by a distributive economy, as the first phase was acutely persuaded and become a leader in |Africa and well beyond for such policies. Yet there is no doubt that the policies also fostered poverty even if they helped to protect unity; it is a mixed bag.

That is why the measures that the government has taken since the late 1980s to energetically foster a market economy ought to be intensified at the moment so that most sectors of the economy experience higher productivity. # Climate-smart agro-sector effort not only for women

of Tanzanian society, within the agricultural sector, is adapting to global climate change threats by adopting suitable technologies. |Strategies used by the Tanzania Horticultural Association (TAHA) to empower rural women economically whilst conserving the natural environment have earned praise from the United Nations. An under-secretary general and executive director of UN Women, a specialised agency, hailed the approach used when visiting Zanzibar; there are similar projects in the Mainland.

The high UN official was greatly moved by what she saw in TAHA's approach of empowering rural through horticulture cultivation while protecting nature by using climate-smart technologies. The director said the method is integral to gender equality as well as inclusive and sustainable development. That is good for women in Zanzibar and other project areas on the Mainland, but the whole of agricultural sector needs similar technologies, if only to ensure basic incomes, etc.

One way of sorting out the question is to demand how many climate smart technologies are being used in farming of food crops, fishing or livestock keeping. If these methods exist the issue is the presence of specialized agencies that can spread such technologies far and wide, as TAHA is anchored in horticulture. while the most strategic crops don't have such role models. At best there are moves to make quality seeds available and subsidized, which is a good start to resilience.

news that a portion communities, or is somewhat limited. Whatever the relevant ministry needs to pursue specific crop based efforts, since TAHA didn't just bring in good seeds or obtain UNO Women assistance to provide them at subsidized prices. When real projects are rolled out, hazards of farmers' random responses are solved early.

There is for instance an endless debate about resilient agro-sector approaches as relates to food security, whether it is to take up root and tuber crops or adopt fast maturing grain varieties. Instead of such issues being approached by sentimentality and fixed ideas about natural crops as best, market analysis is vital to know what is sustainable when sold, not what will fill shelves and public officials preach that people should but, not choose food, etc. This is a gap that hasn't been cleared yet.

Again, we are yet to be assured that all these initiatives have established or receptive market, as often such drives are tied to production, especially when pursued or entrusted to ministerial departments or local authorities. The motto of 'producing more' has not yielded the best results all the time, and projections by public agencies are often unreliable.

That is why the more the private sector is present in the strategy the better, so that people take individual risks when they seek to put their savings in one or other direction, not be led by public agencies and then fail. If public agencies have monopoly about such matters, it is this situation that needs to be addressed first, so that people know valid and reliable risks and opportunities, not just being led by people who wish to complete their annual reports as to how many people have planted **The Guardian Limited Key Contacts**



## Fighting corruption whilst building integrity

ORRUPTION detrimental to the growth and development of any country or society. In Liberia, corruption is unarguably one of the conditions that have made the county one of the least developed in the world. This paper discusses the current situation and policy approach to fighting corruption, and what is being done to build and sustain integrity in the Liberian public service. It outlines the causes of corruption on the one hand, and the impacts of corruption on the country's economic growth and development on the other hand. It then advances possible solutions to address this menace. The first section of this paper defines corruption, and discusses the types of corruption in public service in Liberia, the causes of corruption, and the impact of corruption on national development and economic growth. The second section outlines possible solutions to solve the problem of corruption. World Bank defines

corruption as the misuse of public power for private benefits (World Bank 2001). This definition can include receipt of improper inducement by an official to allow illegal activity (such as smuggling, fraud in awarding government contracts, nepotism, embezzlements, cronyism, appropriation of public assets and property for private use, influence peddling, etc.) to go on. Corruption is arguably the main factor hindering the growth and development of developing countries. The Government of Liberia continues to face challenges in fulfilling its mandates of collecting revenue to invest in the delivery of the needed public goods such as national security, roads, electricity, Hospitals as well as protecting the domestic economy. Corruption over many years have created severe disincentives to the citizenry and distortion of economic growth and development. It continues to prevent the realization of public financial needs and put national security (social and physical) at risk.

There are several types of corruption that can be categorized four major categories. Irene Hors of the Organization for Economic Cooperation and Development (OECD) has identified three types of corruption that occur in the work environment of public officials. According to Hors, the three types of corruption are routine corruption, fraudulent corruption, and criminal corruption (2001). Transparency International (1997) divides corruption into two major types: - petty corruption and grand corruption. Hors' definition and Transparency International's definition are similar. Routine or petty

corruption is survival corruption. These types of corruption usually take place at the junior officer level. At this level, corruption is systemic and endemic and it is not regarded as a criminal or illegal activity. Both the givers and receivers comfortably participate in this type of corruption. Officials involved in this form of corruption believe they are entitled to additional compensation from the businesses or citizenry.

There are several reasons that one can attribute to such corruption. One reason for this form of corruption is that officers at the level where this form of corruption occurs are grossly underpaid and another reason is the lack of professional training, supervision and proper management control.

fraudulent corruption, involves knowingly allowing businesses/ traders to violate the law with the aim of receiving personal gain in return.

The third category, criminal corruption/grand corruption, involves the payment of bribes to public officials to allow criminal operators to carry out illegal activities that are harmful to the country and its people such as illicit drug trafficking, award of concession contracts that are bad for the country, as well as allowing terrorist activities.

Another type of corruption that should be considered is prejudicebased, wherein an individual or company gets favorable treatment, or is treated inappropriately, for no reason other than personal prejudice. This form of corruption includes favoritism in the award of contracts to companies, sectionalism, and nepotism.

Senior bureaucrats are most often the participants in this form of corruption. This type of corruption underpins the codification of corruption in organizations, which then filters down to frontline officials. As a result of prejudice-based corruption at the top, the entire system is likely to become corrupt. From a personal perspective, this is the most damaging form of corruption that lays the foundation systemic and endemic corruption. Once the right person is not placed in the right place at the right time, there is a high possibility of system failure. These types of corruption include nepotism and preferential treatment in dealing with institutions. Nepotism in the context of our discussion includes the selection of unqualified staff, promotion of incompetent staff, and transfer of staff to lucrative positions on the basis of a relationship instead of on a merit basis.

Tomitigatetheimpactofcorruption it is important to understand the distinction between well-organized and chaotic corruption. One major difference between the two forms

of corruption is the predictability of results. Under the Well-organized form of corruption, the supply side has a great idea of who should get bribed and how much to offer for a particular illegal activity to go on without being noticed or disrupted. In this form, authority is centralized. On the other hand, chaotic corruption is marred by confusion wherein the supply side has no idea what would be the outcome of the transaction should he/she bribe their way through. Under this form, authority and responsibilities are decentralized. If the supply side must venture into bribing its way through, there is a high likelihood of overly paying bribes to more people than necessary. When this happens, the person paying the bribe gets The second category of corruption, disoriented and discourage to venture.

Factors giving rise to corrupt practices in public administrations include but are not limited cumbersome regulations, widespread intervention, complex bureaucratic processes and procedures, low stakeholders awareness, the culture of impunity, disregard for the respect of standard operating procedures and guidelines, inadequate internal control, low salaries and remuneration, lack of job security, inadequate social security and welfare policy and the inadequate training and specified professional standards. Until these factors are addressed properly using a holistic approach, there will still be an incentive for public officials to engage in corrupt practices.

, Institutional weaknesses - an institution in the context of this paper holds the definition provided by Elinor Ostrom, an American political economist. Ostrom defines institutions as rules, norms, or strategies that people derive to coordinate or cooperate more successfully in collective endeavors (Ostrom, 1990). With this definition in mind, it can be deduced that weak strategies, rules, and expectations will lead to weak laws policies, and interventions. As Anne O. Krueger postulated, it is assumed that those in the private sector are motivated by self-interest and those in the public sector by social justice (Krueger 1990). Although this is how it ought to be, the case of Liberia is far from this belief. Public officials, instead of playing by the rules to realize government mandate, are at the forefront of self-interest. This attitude has given rise to weak institutions thus creating the incentive for corruption.

Although Government of Liberia has formulated some policies and created some Anti-grafts institutions to fight corruption, performance of these institutions and policies have necessitated the need for reform and strengthening of the existing institutional and policy architecture due to ineffectiveness. Government has created institutions such as Liberia Anti-Corruption Commission, Internal Audit Agency, National Code of Conduct for public officials and a mandatory asset declaration policy. These institutions and policies seem to not be delivering the intended results.

Burdensome regulatory regime an overly regulated doing business environment is entrenched with too many rules, procedures, and regulatory requirements. The compliance cost to businesses is unbearable to the extent that it leads to the creation of avenues for public officials to solicit bribes. Overly regulated environments cost governments huge amounts of resources to ensure compliance. Another factor that renders overly regulated operating environments inefficient is the impracticality of sufficiently monitoring performance. All of the foregoing factors create incentives for companies to seek fast illegal approval through the offer of bribes to public officials.

Complex bureaucratic procedures - Bureaucracy is an array of functional departments with separate and distinct roles. In the Liberia public service, our observation shows that there are too many different government departments performing the same or almost the same task. Because of this, there is a continuous conflict and competition between and amongst employees of entities for power instead of focusing on how to deliver the needed service. Businesses cannot afford long delays waiting for all concerned agencies to grant approval before moving further with their business operations. Complex bureaucratic procedures create a bottleneck in the flow of business processes and create incentives and opportunities for businesses and public officials to organize and implement bribery.

. Disregard for respecting standard operating procedures (SOPs) and guidelines - most public officers do not read and work in line with approved Standard Operation Procedures. This is very serious, as some staff will do the wrong thing thinking that they are doing the right thing. Their intention may be good but in reality, it is against best

Others will knowingly do the wrong thing taking advantage of the ambiguity in the laws and flagrant disregard for approved SOPs. In modern public administration, it is better to set out standards of practice that everyone must follow. Criminals that know the law can hide behind ambiguities. As a matter of fact, there is an escape route to most laws. It is regulation and standards set by administrators aside from legislation that close most of the escape routes.

These political ructions were apparently instigated by disagreements in the ruling party over foreign and domestic policy reforms implemented by Ndayishimiye over the past two years. They aim to restore Burundi's international reputation and bring domestic stability, which deteriorated in 2015 when the late former president Pierre Nkurunziza declared his intention to run for a third term.

The political crisis triggered by Nkurunziza's announcement and the subsequent sanctions issued by the United States (US) and European Union (EU) wreaked havoc on Burundi's economy. It also worsened longstanding domestic political and socio-economic problems.

Ndayishimiye's policy reforms have put Burundi on a new political and economic path, and facilitated the country's return to the international fold. But some changes have adversely affected the party elites' interests, widening the rifts between the president and his rivals in the CNDD-FDD.

Burundi has made great strides on the foreign policy front, including re-engaging its neighbours and signing infrastructure agreements in the East African Community. 'Democratic reforms' adopted to facilitate the removal of sanctions include loosening media restrictions, reinstating the British Broadcasting Corporation's operating licence and releasing human rights activists.

The EU and US welcomed the policy shifts and rewarded the president's efforts by easing restrictions and restoring aid to Burundi.

Back home, the government is trying to tackle political and socio-economic challenges. The president has promised to crack down on monopolies held by party elites over various economic sectors. So it was unsurprising that the trade minister announced in September that the country would ease imports of basic commodities including cement, sugar, maize and maize flour. The central bank lifted restrictions on foreign currency exchange, allowing forex bu-



reaus to operate after a two-year ban.

The foreign currency shortage encouraged a blackmarket currency trade and contributed to the devaluation of the Burundian franc. Earlier this year, the government stepped in to import fuel because private suppliers were struggling to secure foreign currency to do so. Fuel shortages exacerbated the scarcity of essential commodities and increased inflation.

Although these measures have eased shortages of basic goods, the reforms lack political consensus, and questions about their credibility remain. Human rights activ-

ists have publicly petitioned against lifting US and EU sanctions, arguing that the government has yet to make any meaningful change. Several local and international human rights organisations remain banned in Burundi, and activists and opposition party members still face harassment from the security forces and CNDD-FDDaligned youth militia, the Imbonerakure.

The appointment of Gervais Ndirakobuca as Bunyoni's replacement lends credence to human rights activists' allegations. Ndirakobuca is still under EU sanctions for his role in the violent crackdown against civilians during the

Perhaps Burundi's diplomatic victories have given the

president room to post his political allies to top government positions. The continued prominence of CNDD-FDD hardliners like Ndirakobuca in senior government positions casts doubt on the credibility of the reforms.

Ndayishimiye's policy shifts have also exacerbated tensions within the CNDD-FDD. These conflicts are made worse by indications that September's political purge seems to have targeted figures allied to former president Nkurunziza. Aside from Bunyoni, those sacked included chief of staff Gabriel Nizigama, five ministers and 54 provincial police commis-

Unsurprisingly, some political elites have resisted the changes to import policies, which have adversely impacted their businesses. Allegations are rife that Bunyoni and other influential party members attempted to sabotage the easing of import restrictions, having benefited from the shortage of essential goods by inflating prices on the black market.

If the rumours of a coup plot are to be believed, that might signal that aggrieved party members could resort to violence to stop the reforms. Other threats to the country's political stability are ongoing human rights violations and the Imbonerakure's activities. What is clear is that Ndayishimiye's reforms have revealed cracks in Burundi's political landscape.

In the coming months, the government needs to ensure that policy changes are seen as credible, especially in the eyes of citizens. Bans on human rights organisations should be suspended and jailed activists released. The Imbonerakure's violent activities against the population must also be stopped.

The president will have to tread carefully to manage tensions within the CNDD-FDD, which might mean accommodating some of his rivals' economic interests. After the September political reshuffle, Ndayishimiye should feel more confident to forge ahead with reforms despite dissent from within his party.

## Ukraine foreign minister Dmytro Kuleba facing uphill

battle in swaying Africa's perception, narrative on war

HE protracted struggle between Russia and Ukraine (and its Western allies) to win African nations' hearts and minds continued last week with Ukrainian Foreign Minister Dmytro Kuleba's continental tour.

He visited Senegal, Côte d'Ivoire, Ghana and Kenya on a planned 10-day tour. But he cut it short to go home to deal with the massive missile strikes by Russia on Ukrainian cities on 10 and 11 October. Kuleba's African trip followed earlier ones by his American and Russian counterparts, as well as France and Germany's leaders, as Africa becomes a battleground for influ-

Kuleba was under no illusions about the difficulty of his mission. Senegalese officials had told him, "This isn't our war, the West is fighting against Russia," "Russia and Ukraine are one people," and "Russia attacked you because you were going to become a Nato [North Atlantic Treaty Organization] member,' he said.

"Russia's narrative has been very present here," he added. "Now it's time for Ukrainian truths." Over the next week, Kuleba attempted to counter Russia's three 'lies' as he put it to African journalists in a 13 October online briefing. He noted that Russia had first attacked Ukraine in 2014 when Ukraine's policy was neutrality, not Nato membership. And if the intention to join Nato was a provocation to war, why had Russia not attacked

The second Russian 'lie' was that Russia and Ukraine were actually one country, and so Russian president Vladimir Putin could impose his will on Ukraine. "In fact, we are very different countries with our own languages, cultures and histories. Imagine your neighbour coming to you and saying your language, culture and history do not exist. Your statehood is a mistake."

And the third was that "Russia wants peace but Ukraine refuses to negotiate." On the contrary, Kuleba insisted that Russia had rejected Ukraine's many proposals to resolve differences. He said all of Russia's peace plans were smokescreens for ultimatums

for surrender and the extinction of Ukraine. Kuleba also dismissed Russian Foreign Minister Sergey Lavrov's main message on his African tour in July that global shortages of grain and fertiliser – which hit Africa hard – were mainly the fault of Western sanctions against Russia. Kuleba blamed them on Russia's blockade of Ukrainian ports and noted that Russia's bombardment had raised grain prices further. He promised Kyiv would send "boats full of seeds for Africa."

This was the first visit by a Ukrainian foreign minister to Africa. Kuleba said some officials told him most Africans had never heard of his country before the war. He promised to step up relations and announced that Ukraine would open an embassy in Ghana - the country's 11th in Africa.

Kuleba promised digital and cybersecurity assistance, agro-technology, diplomatic training and educational bursaries to African coun-

tries. He confirmed that Ukraine was planning a "large-scale Ukraine-Africa conference" next year - presumably partly to counter the second Russia-Africa summit in St Petersburg.

Kuleba thanked his hosts in the four countries for the moral support they offered Ukraine so far in the war: Côte d'Ivoire for "standing with Ukraine" and Senegalese president Macky Sall for "strongly supporting Ukraine's territorial integrity."

In February, Ukraine was delighted when Kenya advised Putin at the United Nations (UN) Security Council to respect Russia's border with Ukraine and abandon attempts to turn the clock back to Russia's glorious imperialist past. Kenya generally aligns with the democratic West on such issues, so perhaps that wasn't surprising.

Kuleba seemed especially grateful to Ghana's president Nana Akufo-Addo for telling the UN General Assembly last month that "every get in Ukraine, hits our pockets and econo- trality, and questioned whether the EU mies in Africa." But on Thursday, Kuleba professed to be very pleased with his African safari. All four countries visited voted in favour of the UN General Assembly resolution on 12 October that condemned Russia for its "illegal so-called referendums" in the Ukrainian regions of Donetsk, Kherson, Luhansk and Zaporizhzhia and its "attempted illegal annexation" of them.

Kuleba would have been particularly pleased that Senegal shifted its vote from abstaining in March to supporting this one. Significantly, the Angolan government did the same, stepping out of line from the five other former liberation movements in southern Africa, which all abstained. In total, 30 African states backed the resolution two more than supported the 2 March decision.

How will that go down in Ukraine and the West? There have been some impulses in Western countries to use more than persuasion to get African countries 'onside'. HINESE commodities are becoming more and more popular with global buyers thanks to the prospering development of the overseas warehouse model.

Overseas warehouses are warehousing facilities established overseas that provide basic services for Chinese manufacturers, such as storage, transferring, sorting, packaging, in-situ processing and delivery. They also offer value-added services, helping Chinese manufacturers with order processing, customs affairs, refunding, financing and overseas distribution.

Cross-border e-commerce, a new channel for foreign trade, has achieved rapid progress in China over recent years. As an important part of the business model and a new type of foreign trade infrastructure, overseas warehouses are playing a constructive role in helping foreign trade enterprises lower costs, increase efficiency and smoothen the supply chain.

On Sept. 21, a consumer from the Kingdom of Bahrain received a capsule coffee machine and a milk frother. The two devices, manufactured by Chinese company HiBREW and sent from an overseas warehouse in Saudi Arabia, were delivered to the destination only two days after the online order was placed.

The Chinese company started using overseas warehouses in July, 2020. Now its products are stored in warehouses in 12 countries and regions, such as Saudi Arabia, Dubai, Russia, Spain and France. It has seen an 80 percent rise in order quantity thanks to the convenient logistics.

HiBREW is not the only example. So far, cross-border e-commerce platform AliExpress, in cooperation with Cainiao, a Chinese logistics company launched by e-commerce giant Alibaba, has established over 20 overseas warehouses in 11 countries and regions, which cover a total area of 860,000 square meters.

In its Europe market, AliExpress is now able to deliver products to consumers within two days. Besides, the company also offers consumers a Worry-Free 15day return and exchange service. Since this year, the company has begun entering emerging markets such as Mexico and Israel.

According to data released by China's Ministry of Commerce (MOFCOM), China had over 2,000 overseas warehouses as of the end of the last year, which covered a total area of more than 16 million square

form of China's foreign trade and an important infrastructure supporting cross-border e-commerce and other new forms of foreign trade in the future," said Li Mingtao, chief e-commerce expert with the China International Electronic Commerce Center under the MOFCOM, adding that the development of crossborder e-commerce is inseparable from the strong support of overseas warehouses.

A complete overseas warehouse system can further improve cross-border e-commerce enterprises' service capability, provide purchase better experience for overseas consumers, and significantly lower logistics and warehousing costs, thus improving the core competitiveness of these enterprises, the expert

As China constantly enhances its support for overseas warehouses, both the number and functions of the overseas infrastructure are expanded.

Apart from basic storage services and value-added services, most of the overseas warehouses have established online information service platforms to synchronize information with e-commerce platforms. The function is able to manage small quantities of commodities that come in frequent batches to

Overseas warehouses also contribute to alleviating the financing pressure of small- and medium-sized enterprises (SMEs). For ance products and services.

instance, Zongteng Group, a global cross-border e-commerce infrastructure service provider based in China, has acted as a matchmaker between the funding and financing parties based on loads of information acquired when running its overseas warehouses. It helps cross-border e-commerce enterprises lower their cost in financing.

A batch of outstanding overseas warehouses are currently making active exploration in information construction, intelligent development, diversified services and localized operation, said Hong Yong, associate researcher with the Chinese Academy of International Trade and Economic Cooperation under the MOFCOM. The overseas warehouses offer services such as warehousing operation, digital marketing, one-stop customs clearance, supply chain finance and compliance consulting for crossborder e-commerce sellers, Hong added.

In the future, the overseas warehouse model will help more Chinese manufacturers, especially SMEs expand overseas markets, and bring more Chinese products to foreign consumers.

Li Xingqian, an official with the MOFCOM, noted that the ministry will encourage entities to join the construction of overseas warehouses and steadily advance its work on standard making.

In addition, the ministry will also support the digital development of overseas warehouses and improve the construction of intelligent overseas logistics platforms, and strengthen financial support for the construction of overseas warehouses by encouraging eligible financial organizations to launch targeted financing and credit insur-

## Liz Truss's government is living hour by hour

THE Truss programme for government is dead. This is a hand-to-mouth government, living hour by hour.

If you pick up the hint of panic in the air, you're not the only one. Make that a stench. Anything apparently solid quickly becomes air.

Now, nearly every element of her prospectus has just been shredded by her new chancellor.

The statement that has just been delivered is the second vanking forward of an important economic moment for the country. Originally it was in the diary for November. Then Halloween. Now we've had it today.

"We will reverse almost all the tax measures" from the mini-budget, Jeremy Hunt said. What an extraordinary thing to hear.

Diaries are going out of fashion at Westminster but to be clear, there still will be a statement in a fortnight's time, alongside those numbers about the state of the economy from the Office for

Budget Responsibility.

But so nervous are those in charge of the market reaction, that they dared not leave an announcement until midafternoon when he'll stand up in the Commons.

That's right - a government so petrified by the pace of events, dragging forward a statement by a fortnight isn't soon enough.

Not only has the planned cut in the basic rate of income tax been binned, so has the plan originally from Rishi Sunak to cut it in 2024.

The prime minister who promised to cut taxes by more than her rival over the summer, is now keeping them higher than he planned. And even the flagship en-

ergy support package, the crutch upon which the prime minister has leant whenever asked a tricky question in the last few weeks, has shrivelled vastly.

It is now a six month package, not a two year one.

So if this feels a bit confusing this is where it is at: There had to be an interim



statement before the interim statement, to try to steady the

This is a ship where bits have already broken off and sunk, and where the navigation equipment - the very direction and purpose of this government - was ripped out and thrown into the sea with first the U-turns, then the ejection of a chancellor.

A ship where plenty of the

crew are eyeing up the lifeboats, near certain the whole thing is going down soon enough.

"If polling suggests an alternative leader will lose fewer seats than she will, then she's had it," one MP not prone to exaggeration or shouting their mouth off tells me.

"Not many of us buy the idea that another leadership change is the worst case scenario. Nothing can be worse than where we are already," they said, adding "you can't sack your closest ally for carrying out your orders and call it pragmatism."

Yesterday Liz Truss invited Jeremy Hunt and his family to lunch at Chequers. He has gone from backbencher life on Friday morning to the prime minister's country retreat in Buckinghamshire 48 hours later for a three-hour meeting where I am told they were in "violent agreement".

Some in the Tory party see him as the real prime minister now, so enfeebled is the actual prime minister's authority. One source suggested they are working "in lockstep."

That's the very phrase they used to use about the bloke she blew out of the building on Friday lunchtime, the now former Chancellor Kwasi Kwarteng.

What we seem to be getting now is shock and awe in reverse - the Big Bang of radical policy ideas blitzed in one go, promised by Liz Truss when she took office - going backwards. Fast. One source described to-

day as a "down payment" on what the government is now promising.

Say whatever we can, as quickly as we can, to reassure the markets.

My sentence not theirs, but that's the thrust of it.

So in details terms, the focus today is tax. And the focus in a fortnight will be spending. Even a chancellor moving as fast as this one can't negotiate detailed cuts across Whitehall over a single Sunday roast or whatever.

That discussion will start tomorrow in a cabinet meeting. Remember: this is about two things: Restoring the government's financial credibility and propping Liz Truss up in office.

Talking of which, I can bring you a little nugget about one of the things that set tongues wagging last week that throwaway remark from the King when he met Liz Truss for their weekly audience at Buckingham Palace.

You might recall that King Charles said "dear oh dear" as he exchanged small talk with the prime minister as she arrived. Inevitably some couldn't help jump to the conclusion that he was somehow offering a commentary on the pickle she is in.

Not the kind of thing, for a second, the King wants to hear - fending off, as he is, from critics, suggestions he might want to be a meddling monarch after years of being an outspoken Prince of Wales.

I'm now told it was actually a nod of sympathy because of logistics - it was the prime minister's second visit to the Palace in a matter of hours.

She had attended a meeting of what is known as the Privy Council at 4pm, then dashed back to Westminster to meet her MPs, and then had hurtled back to see the King at half six.

The pace of her premiership, for all the wrong reasons from her point of view, shows no sign of slowing.

# North Mara mine makes agriculture coherent to youth

RURAL youth are the future of food security, yet they don't see future for themselves in the rural areas, as there is growing concern that young people have become disillusioned with agriculture.

Engaging the youth in agriculture is a prominent topic for North Mara Gold Mine, a Barrick Gold subsidiary located at Nyamongo area in Tarime district, Mara region.

With most global young people, around 85% living in developing countries, where agriculture is likely to provide the main source of income it is vital that young people are connected with farming. North Mara made a deliberate decision to conduct a rapid agribusiness needs assessment to identify both the gaps and opportunities of agribusiness that exist in the villages surrounding the mine.

The result of the assessment indicted that 100 percent of the population considered agriculture as their primary source of livelihood, meaning food security and income. Yet the level of community awareness on agribusiness is limited in terms of their potential to generate sufficient income and sustain individual and household income.

The findings lead North Mara Gold Mine to commit itself in ensuring that communities living around the mine have alternative source of income and achieve sustainable development. The mine invested in Agribusiness Development Projects, a community initiative designed to provide integrated support in collaboration with communities, stakeholders, agricultural extension and other support services to promote horticultural value service chain assimilation.

The 10 acres project that involves 100 male and female youths as primary beneficiaries from Matongo village in Tarime district, intends to develop life skills including agribusiness skills for students in schools and agribusiness for out of school youths and loan savings skills for youth and women groups.

"The project seeks to ensure that targeted groups become credible suppliers of fresh and nutritious fruits and vegetables for the mine and local market while increasing their

income and securing descent jobs in horticulture," says Hermence Lulah, North Mara Communication superintendent.

The project which will reach 3000 people as secondary beneficiaries as a result of multiplying effects is also anticipated to improve production and productivity, reduce cost of doing business for farmers, increase income and better linkage to markets through multiple distribution channels including the mine and make agribusiness provide decent jobs for communities surrounding North Mara gold Mine.

Living in an era where rapid urbanization has led to a decline in rural populations the North Mara Gold agribusiness project is the sunshine that peeks in clouds. This is the age where for the first time ever the majority of the world's population lives in a city.

The UN World Health Organization predicts that by 2030, 6 out of every 10 people will live in a city, and by 2050, this proportion will increase to 7 out of 10 people. This means that more young people than ever before are moving to cities and towns to find work, leaving few behind to work in rural areas.

This is due to the fact that few young people see a future for themselves in agriculture or rural areas. Rural youth face many hurdles in trying to earn a livelihood. Pressure on arable land is high in many parts of the world, making it difficult to start a farm. Youth often also lack access to credit, and many other productive resources necessary for agriculture. In developing countries, rural youth find themselves in such a bind. While most of the world's food is produced by aging smallholder farmers in developing countries who are less likely to adopt the new technologies needed to sustainably increase agricultural productivity, and ultimately feed the growing world population while protecting the environment, momentus and purposeful measures need to be taken to make agriculture appealing to the youth.

Hence, the need to re-engage youth in agriculture, and this is what North Mara Gold Mine is actually doing, removing all stumbling blocks that hold back youths from agriculture. According to Lulah, North Mara



will provide non-cash support to the ten groups of ten each. The support will be in form of the provision of technologies such as irrigation technologies including installation and agricultural inputs.

"Funds will be treated as revolving, groups will need to demonstrate that they can pay back the money so that other groups in same village can benefit. The groups will also form village loan and saving groups where a small amount of seed money is provided as well training them on financial literacy," narrates Lulah

Marwa Muteba, a resident of Matongo village says the project is an icebreaker to the future of youths in Nyamongo and the whole Tarime district which has good agroecological conditions that favor crop and livestock production nearly throughout the

"Surprisingly we didn't see these potentials in agricultural investments. After the mine took us through several pieces of training and to the nanenane exhibitions in Arusha last August, it sink in our mind that agriculture is not only the green gold but the way to go," says Muteba.

Commenting on the project the Tarime District Commissioner, Colonel Michael Mtenjele said there is a large, untapped reservoir of employment opportunities in the Agri-food sector. "North Mara provides a lot of opportunities for the youth in

this area, it's imperative that they make good use of them for the betterment of the communities neighboring the mine," said Colonel Mtenjele.

He added that the Government, through the 2017 Local Content regulations, has provided an enabling framework for local businesses to benefit from investments in the country through opportunities in the supply chain. "These horticultural products will fall under local content, which means there is a ready market, we will work hand in hand with the mine to see to it that they produce as per required standard and quality."

According to agriculture experts, income growth generated by agriculture is up to four times more effective in reducing poverty than growth in other sectors. Horticulture has been indicated as a sub-sector that offers real opportunities for improving farm earnings and reducing poverty. It has one of the best returns on labor, land and capital invested.

Horticulture is one of the fastest growing sub-sector with average annual growth of eleven percent compared to the growth of the overall agriculture sector which is 4 percent. It is therefore urgent to strengthen the appeal of agriculture and food systems to young people in order to secure the future, the way North Mara is doing. The potential returns of investing in young people are boundless in terms of food security, poverty reduction, employment generation, as well as peace and political stability.

## Call for more investments in digital startup economy

AT 62, Evelyn Masatu is relatively a newbie to the pensioners' club. For starters, she is just two years into retirement and has been enjoying her well-earned retirement perks without having to worry about the next day's demanding schedule of her former job.

Secondly, she believes she still has an option overload as to where to invest her money and time to ponder on the same; that is until when she was approached by her nephew seeking an investor to inject a modest sum for his startup to take shape.

She has never had the faintest inkling as to what a startup is and since all her adult life she had diligently worked for one employer, a government entity, her skepticism was not misplaced

Her reaction to the idea of investing in a company that is starting from ground zero is not uncommon, many people understandably think it is a risky venture to do so because they have faith in established institutions.

Mercy Thomas is the Program and Partnership Lead at Sahara Accelerator. Her roles involve matchmaking startups and SMEs with potential investors. She is also a co-author of a report recently launched by Sahara Ventures titled "Towards Realizing the Startup Economy in Tanzania" prior to hosting the Sahara Sparks event.

She strongly believes that the digital economy is the way forward for countries like Tanzania, and Africa in general, and yet the fear amongst individual and institutional investors continuously hampers the progress

of entrepreneurs in the digital economy.

It should be understood that investment is not about the investor doing a favour to the entrepreneur and vice versa, it is a mutually beneficial commitment where both parties set up conditions under which the investor agrees to inject funds in exchange for equity that is believed will grow in value.

"Technology will strongly help Tanzania keep up with other countries in the digital economy and it will replace many people in the job market as the world switches from analog. However, the challenge remains that not many people are aware of what startups do," she said.

She also believes that there is little exposure in Tanzania on matters pertaining to investment in general, and there is also very little that is known about opportunities that abound by investing in startups, and the country also needs to revisit some policies and regulations to attract more investment in the area. "Tanzania needs to encourage more positive information emerging from our startup ecosystem and celebrate those who have closed major deal rounds

and significantly impacted society and attracted significant capital from investors. We need to attract global firms and companies to develop an interest in Tanzania and establish strategic offices," she said.

Facts tend to speak for themselves, and here are but a few that offer a glimpse of the potential for innovation, technology, and entrepreneurship for job creation and the socio-economic well-being of the continent in the years to come.

As of 2018, six of the fastestgrowing economies in the world were from Africa. Better yet, Africa is the youngest continent in the world, with a median age of 25 and its population will continue to grow until it doubles by 2050.

Fifteen fastest-growing cities are in Africa, three of which are in Tanzania (Dar es Salaam, Mwanza, and Songea in the Ruvuma region). The continent's GDP is expected to reach an estimated US\$ 5.63 trillion by 2025, according to the AFDB's 2018 African Economic Outlook report 2018.

Tanzania's population is projected to increase from 53.9 million in 2015 to 186.9 million by

2065. Young people aged 15-34 are projected to increase from 17.8 million to 62.3 million by 2065 and her estimated annual growth by 2022 is pegged at USD 77.6 billion.

Dar es Salaam is one of the world's fastest-growing cities and it is expected to attain megacity status by 2030 with 10 million denizens. Just a generation or so ago, the city had a mere 400,000 inhabitants.

On that backbone, Africa, and Tanzania if we take into account the maxim that charity begins at home, no longer has to be trapped in a revolving door of poverty because increased urbanization creates opportunities for investors and businesses looking for human capital.

It also creates opportunities for the adoption of new technologies and innovations, creating further opportunities for startups with new innovative businesses to address emerging urban challenges.

The growing population creates demand for goods and services which translates into the need for increased production

and service delivery.

Technologies that improve efficiency and offer convenience can thus be rapidly adopted as evinced in increased interest in Fintech and Logistics technologies - potential for innovation, technology and entrepreneurship for job creation and socioeconomic good of the continent pickup and delivery technologies startups.

All that is needed is the unleashing of the potential of young people in Africa through investments in their innovative ideas, technology and entrepreneurship - a true way to empower young people in the country as is advocated by the government.

"Investors are interested in investing in the market where they can exit safely. Most investors struggle with the exit strategy from our ecosystem. Government should engage with key stakeholders to understand how to develop systems and structures that will ensure local, regional and global individuals and institutional investors can exit once they have invested in Tanzanian startups," she said.

According to the report, at the moment many investors are compelled to invest in Tanzanian businesses if they can only be guaranteed that the company can operate outside Tanzania.

Under such circumstances, the government loses significant income that would have been generated from the exit process and the trend is not a Tanzanian problem but an African problem, Thomas said during the launch of the report.

"African startups are increasingly domiciling overseas and in tax havens. If we can create smooth exit mechanisms for investors, other African startups will want to exit in Tanzania. It will also help attract individuals and institutional investors to establish offices in the country and encourage more capital to flow into the country and create jobs," she added.

The report's launch by Sahara Ventures was part of activities in the build to Sahara Sparks, a platform launched in 2016 with a focus on building innovation and technology entrepreneurship ecosystems in Africa to foster transactions and conversations around innovation, technology, and entrepreneurship

# Poverty haunts resettled farmers in Zimbabwe

DIOUS Murewa has for years boasted of owning a 10-hectare piece of land, but now the 52-year-old is full of regrets. He faces poverty years after he invaded part of a farm once owned by a white commercial farmer.

He (Murewa) was 30 years old when he abandoned his ancestral home in the Mazetese area in the Mwenezi district, in Zimbabwe's Masvingo province and headed west to get his own piece of land at the height of this country's chaotic land seizures from white commercial farmers.

Even as Murewa and several other resettled farmers in Mwenezi are beneficiaries of this country's agricultural inputs like fertilizer and maize seeds, for years, they have had no success in farming on the seized pieces of land as they get next to zero yields each harvest

For Murewa, together with his family - his wife and five children that never finished school because they were required to toil on their 10-hectare piece of land, poverty has turned into their daily foe.

"When I was still at my old home before abandoning it to come here, life was better. I used to send my children to school from the crop yields I was getting each harvest season, but that is no more now as our crops fail now and then," Murewa told

Now, alongside several other resettled farmers in the drought-

prone Zimbabwean district, Murewa has become a habitual

charity case. He and his family depend on donor food handouts and maize meal donations from the Zimbabwean government.

Murewa says the country's governing party, the Zimbabwe Africa National Union Patriotic Front (ZANU-PF), has for many years stepped in to rescue him and his family as drought impacts their farm.

As a result, fearing losing his piece of land, Murewa has to pay back the ruling party with his vote at each election.

"I vote for Zanu-PF every election because it's Zanu-PF that feeds me; it's Zanu-PF that has given me land," said Murewa.

So, decades after seizing land from white farmers, many of Zimbabwe's resettled farmers like Murewa are having to contend with gruelling poverty, with some of them dwelling in slums on the farms they invaded.

Some, like 56-year-old Nyson Dewa, a resettled farmer Zimbabwe's Mashonaland Central Province, have given up on farming.

As others benefitted from farm inputs from the government, Dewa claimed he had always been left out, which has led to him failing as a resettled

For him, just like Murewa in Masvingo, life was better before he decided to join the wave of land invasions here.

"I'm now poorer than before," Dewa told IPS.

He (Dewa) pinned the blame for his agricultural failures on his support for the country's number one opposition, the Citizens Coalition for Change (CCC), which has resulted in him being denied access to farming inputs from government.

Poverty has not spared him, and his cry for help has often fallen on deaf ears.

In 2000, the late former Zimbabwean President Robert Mugabe turned the country's agricultural sector upside down with his extremely contentious fast-track land reform program, parceling land to farmers like Dewa and Murewa.

Then, over seven million hectares (17.3 million acres) of land were redistributed to the country's now poor resettled farmers like Dewa and Murewa.

For the late Zimbabwean President Robert Mugabe, parceling out land to his black citizens was compensation for colonialism. About 4,500 white farmers were dispossessed, often violently, resulting in one million black Zimbabweans being resettled on the seized white-owned farms.

Yet, that for many has not made their lives any better.

Climate change experts like Happison Chikova blame growing climate change impacts for the continued failure of many of this country's resettled farmers.

"Unpredictable weather patterns owing to climate change have worsened the poverty situation of the resettled farmers who have limited understanding of the changing climate," Chikova told IPS.

Instead, resettled farmers like Murewa pounded left, desperately consult self-styled prophets for weather forecasts.


But these have not helped, misleading the poor farmers each farming season.


Even traditional healers like 88-vear-old Kumbirai Chikwaka. who claim to conduct rain-making ceremonies around Masvingo, have not made the situation any better for resettled farmers.

"These traditional healers rob us of our little resources claiming to perform rituals to bring the rains, but we still rarely have any rain. It's like the white farmers took the rains away with them," said Murewa.

Agricultural experts blame a lack of technical skills for resettled farmers' failure on the land they seized from white farmers.

"The resettled farmers sufat a farm outside Bindura in fer because they allocated themselves large farms without technical know-how in terms of serious farming, and that's why most of them are now very poor," Denzel Makarudze, an agricultural extension officer in Masvingo, Zimbabwe's oldest town, told IPS.



# Africa's young entrepreneurs' fortunes change in difficulties

**LAGOS** 

HERE are countless reasons young Africans are opting for entrepreneurship as a career. One of these is the African economy is not creating jobs equal to the supply of the available labour force.

According to the World Economic Forum, 77 percent of Africa's population is below the age of 35. The African Development Bank (AfDB) predicts there will be 850 million young people on the continent by 2063 and they'll constitute more than half of the working-age population.

A recent AfDB report shows that 10 to 12 million young Africans enter the job market each year but the economy creates only three million jobs annually.

This means that more than seven million young people entering the job market each year have no choice but to be unemployed, work in the informal sector, be underemployed or start a business and create employment.

Across the continent, many young people are building their own businesses. From technology startups to innovations that disrupt conventions in industries such as agriculture and transport, they are solving economic issues that confront them. They're creating employment and economic opportunities for themselves and their

Many of these young entrepreneurs have strong stories to tell, some of which have been documented by Africa's entrepreneurship initiative, the Anzisha Prize.

Having experienced unemployment after graduating from university, and the consequent al employees, combatting the dual problems poverty suffered by the majority of the popula- of high unemployment and poverty. She also

tion in her area, Masello Mokhoro, 23, who lives in the Free State, decided to become a job creator. Mokhoro also struggled to get land for her business. She has a passion for the natural environment, her community and socioeconomic change.

It was the combination of this passion and the hardships that confronted her, particularly in the agricultural sector, which informed her decision to establish Starlicious Enter-

prises, a broilers and piglets agribusiness. Mokhoro employs permanent and seasonmentors agricultural students about the business side of the industry.

Nigeria has in the past two decades faced high food insecurity as a result of neglect in domestic food production caused in part by what economists term the resource curse and the weak currency.

Eneyi Oshi, a 22-year-old technology entrepreneur whose web and mobile platform Farmisphere distributes farm produce from her other business ,Maatalous Nasah, to urban dwellers across the country aims to mitigate this problem.

The business also sells farming equipment

to small-scale farmers. Oshi's goal is to mitigate food insecurity and high joblessness among the youth.

It is estimated that 2.1 million people (14% of the analysed population) in Kenya are experiencing elevated levels of acute food insecurity.

Martin Ondiwa, 22, Greenfarms, started which grows and sells fresh produce to consumers and vendors across Kenya, including kale, maize, onions, capsicum, papayas, and passion fruit.

It was Martin's mother who noticed his love for being productive with the land and gave him a few hectares to get him started on his farming career. The business continues to grow in bounds and employs young people on the farm and in the office.

With a passion for technology and artificial intelligence, Zimbabwe's Munyaradzi Makosa tasked himself with the responsibility to solve Africa's

problems, doing so under some of the harshest trading environments in the world.

Makosa's task has therefore begun at home. The 21-year-old taught himself how to program computers and to market his business and skills in this digital era.

He and his three co-founders established Farmhut with the core purpose of enabling a sustainable farming environment among farmers all year round. Farmhut is an artificial intelligence-enabled marketplace connecting Zimbabwean farmers to markets in and outside the country, helping them reach customers and secure fair payments for their products.

Farmhut earns revenue through a subscription service to these farmers, vendor sales of fruits and vegetables and a chatbot advertising space for agricultural service providers. The business aims to expand across the Southern African Development Community in the next three years.

Tsantatiana Rakotoarimanga, a 23-year-old technology entrepreneur, whose company, Dream Study Agency, through its online application Mapwess, helps students in Madagascar apply to universities abroad. Rakotoarimanga recognised the shortages of higher education facilities in his country and the difficulty in accessing facilities elsewhere because of financial problems.

Mapwess is an online platform that supports these students to find and apply to globally recognised universities. The venture has assisted students from Madagascar, Gabon, Côte d'Ivoire, Cameroon and Togo.

To date, Dream Study Agency has been able to place 80% of its students in recognised institutions. It has signed nine agreements with nine universities in Mauritius and Rwanda. The company employs students as agents, allowing them to earn income through commission.

These efforts undertaken by young people in response to problems they have identified have proven to bring benefits to the lives of young people and their communities, contributing to economic growth on the continent.

It is for this reason that the Anzisha Prize, created through the partnership between the Mastercard Foundation and Africa Leadership Academy, identified these young entrepreneurs for their catalytic potential to end the continent's chronic joblessness and meet the anticipated demand for jobs highlighted in the AfDB report.

## Namibia explores introduction of digital currency

NAMIBIA is planning to join the growing list of countries that have introduced the Central Bank Digital Currency (CBDC), triggered by the rise of cryptocurrency.

In a thought leadership event held in the country's capital Windhoek, the Bank of Namibia governor Johannes !Gawaxab, said the country is exploring ways to create a digital currency as part of the central bank's strategic direction and rapid digitization of the financial system.

Techcabal reports that the event titled, "Central Banking Digital Currencies and Virtual Assets," was graced by representatives from the Central Reserve Bank of El Salvador, the South Africa Reserve Bank, Bank of Ghana and the Central Bank of Nigeria.

Nigeria is foremost amongst countries exploring digital currency to have launched CBDC called eNaira, while El Salvador had adopted bitcoin as a legal tender.

!Gawaxab said that a public consultation paper on CB-DCs would be published soon to further demonstrate the Bank's commitment to continued cooperation and dialogue with the industry, private sector innovators, the fintech community and other stakeholders in transforming the financial sector for the prosperity of all Namibians.

"If CBDCs are explored and implemented with due care and caution, they could hold immense potential benefit for a more stable, safer, more widely available, and less expensive means of payment than private forms of digital money," said !Gawaxab.

But the governor warned that CBDCs are in their early



stages thus there is a lot of uncertainty as central banks around the world are building up their understanding and technological capability to explore and optimally utilize new technologies to ready themselves for the future, especially the future of finance.

!Gawaxab's announcement signifies a shift from Namibia's previous stance on cryptocurrency. Just like many other countries that had before, opposed the use of cryptocurrency, the Southern African country is opening its door to a possible future of digital financial landscape that will have CBDC and cryptocurrency.

There is also another announcement along the digital line which has to do with Namibia's position on Virtual Assets (VAs) and Virtual Assets Service Providers (VASPs). The central bank disclosed that while VAs in Namibia remain without legal tender status, their acceptance for the payment of goods and services is left to the discretion of any merchant

The shift in Namibia's stance on cryptocurrency means that the central bank needs to introduce a regulatory framework. While that is still in the pipeline, the apex bank has issued some warning.

The central bank warned that Initial Coin Offerings (ICOs) pose high risks and possibilities of fraud, manipulation, and misrepresentation, adding that it does not advocate nor support the general public's engagement in ICOs.

But in response to the exponential growth in Vas, !Gawaxab said the central bank will amend applicable laws in consultation with stakeholders to accommodate it.

"To ensure a progressive regulatory response to the exponential growth in VAs, the Bank of Namibia has brought VAs and VASPs under its FinTech Innovations Regulatory Framework in a phased approach, through its Innovation Hub," Gawaxab said. "The Bank of Namibia will engage VASPs and consider the amendment of applicable laws and regulations in consultation with other relevant authorities such as Namibia Financial Institutions Super-

## Oil climbs on China's fuel demand recovery

**NEW YORK** 

OIL prices rose on Monday after China rolled over liquidity measures to help its pandemic-hit economy, igniting hopes for a better fuel demand outlook from the world's top crude importer.

Brent crude futures rose 81 cents, or 0.88%, to \$92.44 a barrel by 0642 GMT, recovering from a 6.4% fall last week. U.S. West Texas Intermediate crude was at \$86.33 a barrel, up 72 cents, or 0.84%, after a 7.6% decline last week.

China's central bank rolled over maturing medium-term policy loans while keeping the interest rate unchanged for a second month on

Monday. Analysts said the full rollover is a

signal that the central bank would continue to maintain loose monetary policy.

The country also vowed to greatly increase domestic energy supply capacity and step up risk controls in key commodities including coal, oil and gas, and electricity, a senior National Energy Administration official said on Monday.

China will further increase reserve capacities for key commodities, another state official told a news conference in Beijing.

Oil found support from a combination of factors, including Chinese President Xi Jinping's comments at the Party Congress that reassured accommodative policies for the economy, a positive sign for demand outlook, CMC Markets analyst Tina Teng said.

China is expected to release trade and economic data this week. Although its third-quarter GDP growth could rebound from the previous quarter, President Xi's stringent COVID-19 policy has the world's No. 2 economy facing what will most likely be its worst performing year in almost half a century.

Looking ahead, oil prices are expected to remain volatile as production cuts by OPEC+ will tighten supplies ahead of the European Union embargo on Russian oil, while a strong U.S. dollar and further interest rate increases from the U.S. Federal Reserve limit price gains.

St. Louis Fed President James Bullard said on Friday inflation had become "pernicious" and difficult to



arrest, and warranted continued "frontloading" through larger increases of three-quarters of a percentage point.

visory Authority (NAMFISA)."

Member states of the Organization of the Production Exporting Countries and their allies, including Russia, lined up on Sunday to endorse the steep production cut agreed to this month after the White House, stepping up a war of words with Saudi Arabia, accused Riyadh of coercing other nations into supporting the move.

OPEC+ pledged on Oct. 5 to cut output by 2 million barrels per day, which will lead to an actual drop of about 1 million bpd as some members are already producing below their

Despite this, top exporter Saudi Arabia will keep exports to key Asia markets steady in November.

"Tighter inventories for oil and oil products along with looming supply risks should keep prices volatile," analysts at ANZ Research said in a note.

# Consumer pains on spiralling food prices

T is 4pm and Anna Peter, resident of Goba, Ubungo district in Dar es Salaam is looking for something to prepare for dinner in one cereal shop to the other.

The 24 years old mother of one was captured by The Guardian at the weekend doing surveys in shops; searching for a shop she can get affordable rice.

Carrying shopping bag filled with spinach, a half kilo of meat, spices and some fruits she had already bought, Anna couldn't believe the hiking prices of rice.

She showed no hope of seeing prices going down, as only one month remains towards the end of year festivals, of Christmas and New Year, when prices are beyond the limits.

"I'm moving around different shops looking for a kilo of rice for dinner that I can afford. I have 2,600/- and I need rice of good quality," she said.

"Every shop I have visited, a kilo of quality rice I am looking for, is sold between 2,900/- and 3,000/-," said Anna.

Anna said she makes food purchases on daily basis, since she has no income to shop for a monthly stock.

Her husband also has little income as works as a motorcycle rider at Mbezi Bus Terminal.

She asked; "How come basic needs like food turn out to be luxurious in this country?"


John Mwakalinga, a cereals wholesaler at Mbarikiwa Store Goba Center said prices rise caused by increase in farm prices; for example he buys Soya beans from Arusha and Mbeya at 3,000/- a kilo and yellow beans at 3,100/- a kilo and sells them at a retail price

Mwakalinga buys rice from Mbeya at between 2,000/- and 2,750/- a kilo, and he sells at retail prices of between 2,300/- and 3,000/- in Dar es Salaam.

of 3,400/-.

However, he sells the same kilo of rice at between 2,200/- and 2,900/- to retail traders around Goba.

"The problem is competition between local and export markets. Rice and beans exports to Kenya, Zambia, DR Congo and Zimbabwe offers prices that are attracting



farmers to sale them in large quantities than what they sale to local markets," said Mwakalinga.

"We ought to pay farmers nearly or exactly the amount our competitors do. If prices are to be brought down, the only solution is regulating what should be sold out and what should remain in the country," he suggested.

Allan Shao, a cereals retail seller at Mbezi Kimara said that he sells a kilo of rice at between 2,700/- and 3,300/-depending on the quality of rice and a kilo of beans at 3,600/- regardless of whether it is Soya or yellow beans. Charles Itembe, Export Processing Zones Authority (EPZA) Director General said that agro-processed food commodities accounted for large quantity of goods export during the 2021/22 financial year.

Ashura Juma (28), a food vender, well known in Swahili as 'Mama Ntilie' at Tegeta suburb in Dar es Salaam said they have decided to increase prices of cooked foods due to hiking prices of food commodities in markets. She said one plate of rice, beans and vegetables which she was selling to her clients at 2,000/- last October has increased 2,500/-

She also said a plate of rice and meat is currently costing 3,000/- up from 2,500/- respectively.

"Food vending is business like other businesses; therefore we have to make profit out of it, no matter in what the situation," she said. "Our customers have no choice but to agree with the situation on the ground because we have bills to pay."

Senior Economist Prof Samuel Wangwe said that the way out to reducing food inflation is turn into smart climate agriculture practices that guarantee farmers high yields.

According to him, hiking prices in food stuff resulting from climate change implications against a free market economy, where farmers decide to sell their produce to those who offer them good prices.

He said to contain price hiking extension services, access to farm inputs and smart technologies in agriculture should be embraced so that farmers can increase productivity to boost supply.

While observing these measures, he suggested that regulatory authorities should limit exports to protect domestic consumers from prices escalation.

"Most of low and middle income families in cities suffer the most from hiked prices on food because farmers produced less but sold a large quantity to exporters, which crowds domestic supply,' said Prof Wangwe.

The Bank of Tanzania (BoT) Monthly Economic Review for September, the wholesale prices for foods maintained an upward trend since April 2022, except for finger millet; with maize and rice recording the highest annual changes in prices.

According to the report, 100Kg of maize sold at 89,040/- at the end of August 2022, more than doubled of 44,812/- recorded in August 2021.

A 100Kg bag of rice fetched 209,788/in August 2022 compared to 140,137/- in

August 2021, according to the report.
On a month-to month basis, prices of food crops were higher than July.

The increase in food prices is partly associated with high demands for exports from neighbouring countries.

In August this year, 100Kg of beans was sold at 206,862/- up from 173,213/-recorded in August 2021 while a kilo of sorghum increased to 127,012/- from 94,804/-.

The price for 100Kg of Round potatoes had jumped to 82,523/- in August 2022 from 60,338/- it fetched for one to secure it the corresponding period in 2021.

The National Bureau of Statistics (NBS) National Consumer Price Index (NCPI) shows headline inflation rate for September, 2022 increased to 4.8 percent from 4.6 percent in August, 2022.

The National Food Reserve Agency (NFRA) food stocks amounted to 144,410 tonnes at the end of August 2022, having increased slightly by 3,715 tonnes compared with July when 140,695 tonnes were available.

During August 2022, the Agency sold 2,009.2 tonnes of maize to traders and millers to easy consumer prices, at the same time purchased 5,966.3 tonnes of maize and 211.5 tonnes of sorghum from farmers.

The Cereals and Other Produce Board of Tanzania (CPB) Director General Dr. Anselm Moshi blamed drought and high fuel prices at global and local markets for triggering food prices.

"Our mandate as a state owned business entity is to bring relief to consumers by supplying enough food commodities at affordable prices, but it has not been the case because yields were also low on maize, paddy and beans during this year's harvests," said Dr Moshi.

## Tea farmers' earnings up 53pc in Q3

### NAIROBI

SMALL-SCALE tea grower earnings grew by more than half to Sh2O billion in the third quarter of the year, helped by the government-backed minimum price of \$2.43 (Sh29I) per kilogramme that protected their revenue.

Kenya Tea Development Agency (KTDA) says the earnings were more than the Sh13 billion that was recorded in the corresponding period last year.

The impressive earnings were recorded despite a 13 percent decline in the production of green leaf.

KTDA says green leaf deliveries by farmers to 71 factories that it manages dropped to 197 million kilos in the July-September period compared to 225.8 million kilos last year, with the decline attributed to poor rainfall.

A kilo of tea in the review period fetched \$2.65 (Sh318), up from \$2.55 (Sh302) in the corresponding quarter last year.

The agency says the outlook for the remainder of the year looks promising, coming as a big boost to farmers who will be expecting good returns should the trend hold.

"Prices at the auction have been fairly steady with a positive outlook expected for the coming weeks despite the market challenges faced with the Russia-Ukraine war and the flooding disaster that recently hit Pakistan," KTDA chief executive officer

Wilson Muthaura said. There are plans to increase this not the Russia-Ukraine war cut tea demand globally as it the market demand for the product.

disrupted the product's demand as economies suffered high inflation due to the war.

Pakistan, a key buyer of Kenyan tea that accounts for nearly 40 percent of the total exports, recorded lower-than-expected uptake due to the economic disruption.

Prices for KTDA-managed factories continued to outperform the aggregate Mombasa auction as buyers paid keen interest on the quality of the beverage.

The average price at the auction stood at \$2.28 in the latest

relevant skills by 2025. ## Nigerian fintech Maplerad raises \$6m in seed funding

BANKING-AS-A-SERVICE (BaaS) platforms have taken off rapidly across the fintech world over the last 18 months. By partnering with banks, these platforms allow entities from startups and fintechs to big corporations and banks to provide tailored banking services and experiences to their customers.

Fintechs offering BaaS services in U.S. and Europe, such as Unit, Rapyd and Treasury Prime, have achieved significant scale due to the developed banking systems they enjoy in their markets.

However, their counterparts are trying to replicate this growth in less advanced banking systems like Africa, where the demand and scalability of such products are

In the latest development, Maplerad, a fintech described by its founders Miracle Anyanwu and Obinna Chukwujioke as a global BaaS player targeting Africa, has raised \$6 million in seed funding.

According to sources, the U.S.-based Maplerad, which is coming out of stealth, raised the round at a \$30 million valuation. The founders declined to comment.

Maplerad's journey as a company can be traced back to 2020, when the founders launched its first product, Wirepay. The app started with helping users make international payments by offering crossborder payment solutions in fiat and cryp- would be infrastructural even though tocurrency.

However, it has since shifted into a selfdescribed all-in-one finance product that enables users to receive, hold, and make payments in multiple currencies, create virtual and physical cards, and pay bills.

Last year, Wirepay raised an undisclosed pre-seed, including a \$125,000 check from OnDeck. Golden Palm Investments Corporation, Greenhouse Capital, some Stash executives, and Berrywood Capital were other investors in the round.

As Wirepay grew to over 50,000 users, mainly in Nigeria, Anyanwu, on a call with TechCrunch, said businesses began to inquire about the in-house infrastructure powering the features on its consumer app. "People wanted to use the infrastructure powering Wirepay, our license coverages, and banking relationships," the CEO and CTO stated.

Anywanwu also mentioned that Maplerad (the parent company) had always wanted to spin off this infra for other businesses. However, when outside requests flocked in en masse, they finally arranged to beta-launch Maplerad, the infra product that allows companies to embed powerful financial features like accounts, payments, FX, and cards into their products, this August.

"From day one, when we built Wirepay for our consumers, we knew the end move

we didn't start the business infrastructure first. For anyone to build anything finance-related, they have a whole lot of banking stack that they have to start with and even before integrating features, they have to go past many hurdles," said the chief executive.

"One of them is banking relationships and compliance. The other is licencing. So Maplerad is solving financial infrastructure problems for these businesses in Africa. We handle that whole stack and provide the best-in-class APIs to use that can make you launch a financial product within five minutes. So instead of a company spending 8 months and a couple of million dollars to start building a fintech product, you can integrate with our APIs and go live."

Banking-as-a-service platforms have become popular with companies trying to embed financial services into their offerings because large, incumbent banks have been relatively slow to bring their services up to speed with the pace of change in the world of tech and banking.

As such, banking-as-a-service platforms see an opportunity to provide more personalized services and flexibility at less cost. The space is heating up-some of Maplerad's competitors in Nigeria include YC-backed Anchor, Bloc, OnePipe and larger fintechs such as Flutterwave.

## China's lenders bolstering loans to support economy

CHINA'S economy has been battered by harsh coronavirus pandemic lockdowns and a property market slowdown, but authorities have been reluctant to increase stimulus measures to boost growth.

The biggest state-run Chinese banks have increased their lending by 22 per cent to \$1.3tn in the first nine months of the year, signalling how state groups are being directed to support the country's economy battered by coronavirus pandemic lockdowns and a property market crisis.

In an announcement orchestrated to dovetail with President Xi Jinping's keynote speech at the opening of the Chinese Communist party's congress on Sunday, a group of the country's six largest state banks released data showing Rmb9.53tn in new loans.

Most of the new cash has been directed towards Xi's favoured industries including manufacturing, infrastructure and technology and innovation sectors. Four of the big banks also disclosed at least a 25 per cent boost in funding for "green loans", or lending for clean energy projects, in the first three quarters.

Among six of the top lenders, the Industrial and Commercial Bank of China, the world's biggest bank by assets, and Agricultural Bank of China, the country's thirdlargest lender, each extended Rmb2.2tn of loans during the first three quarters of 2022. China Construction Bank and Bank of China issued Rmb2.1tn and Rmb1.7tn, respectively.

Xi, who is now poised to lead China for an unprecedented third five-year term, promised to speed up his goal of attaining technological selfreliance. He also vowed to accelerate China's shift to clean

China's economy narrowly avoided contracting in the second quarter as a resurgence of citywide lockdowns under Xi's zero-Covid policy hammered consumption and business confidence and exacerbated the fallout from a historic property sector downturn.



Das said the units will also offer a digital assistance zone to answer queries from individuals and small businesses and hear their grievances.

US President Joe Biden on Saturday called embattled British Prime Minister Liz Truss' abandoned tax cut plan a mistake, and said he is worried that other countries' fiscal policies may hurt the United States amid worldwide inflation

Biden said it was predictable that the new prime minister on Friday was forced to walk back plans to aggressively cut taxes without identifying cost savings, after Truss' proposal caused turmoil in global financial markets. It marked an unusual criticism by a US president of the domestic policy decisions of one of its closest allies.

"I wasn't the only one that thought it was a mistake," Biden said. "I disagree with the policy, but that's up to Great Britain"

Biden's comments came after weeks of White House officials declining to criticize Truss' plans, though they emphasized they were monitoring the economic fallout closely.

Biden was speaking to reporters at an Oregon ice cream shop where he made an unannounced stop to promote the candidacy of Democratic gubernatorial candidate Tina Kotek, as Democrats across the country face a tough political environment amid GOP criticism of their handling of the economy.

Biden said he was not concerned about the strength of the dollar – it set a new record against the British pound in recent weeks – which benefits US imports, but makes the country's exports more expensive to the rest of the world.

#### Plan reversal

Britain's new Treasury chief on Saturday acknowledged the mistakes made by his predecessor and suggested that he may reverse much of Truss' tax cutting plans in order to bring stability to the country after weeks of economic and political turbulence.

Jeremy Hunt, who was brought in on Friday to replace Kwasi Kwarteng as Treasury chief and restore order in Truss' administration, warned of "difficult decisions" to come. Taxes could rise and public spending budgets would likely be squeezed further in the coming months, he said.

Truss fired Kwarteng on Friday and ditched her pledge to scrap a planned increase in corporation tax as she sought to hang on to her job after just six weeks in office.

Truss, a free market libertarian, had previously insisted that her tax cutting plans were what Britain needs to boost economic growth.

But a mini Budget that she and Kwarteng unveiled three weeks ago, which promised 45 billion pounds (\$50 billion) in tax cuts without explaining how the government would pay for them, sent the markets and to amounted those promise assuring people with the Office for Budget that we actually can a them," he added. the British pound tumbling and left her credibility in tatters.



## Inter-Parliamentary Union lawmakers commit to overcoming gender inequality

KIGALI

THE Inter-Parliamentary Union (IPU) affirmed working in partnership with national parliaments to push forward gender equality and responsive legislation.

At the conclusion of its 145th assembly in Kigali, Rwanda's capital, Saturday, the lawmakers adopted the Kigali Declaration, highlighting actions to be undertaken to achieve gender equality including enacting gender-responsive laws and ensuring parity in political decision-making.

Esperance Nyirasafari, vice-president of Rwanda's Senate, and Ivan Flores, member of Parliament from Chile, said the Kigali Declaration was arrived at after a "rich, insightful and inspiring general debate of this 145th IPU Assembly."

The lawmakers said gender equality and gender-sensitive parliaments are drivers of change for a more resilient and peaceful world.

According to the IPU, gender-sensitive parliaments are founded on the principle of gender equality, with women and men having equal rights to participate without discrimination or recrimination.

Such parliaments respond to the needs and interests of both men and women in their structures, operations, methods and work. "We must reach parity in political decision-making by all means, including 50:50 quotas," Nyirasafari said, adding that the COVID-19 pandemic had revealed that crises are never gender neutral, but exacerbate gender-based inequality, hold back society and challenge resilience. "We affirm that gender equality is key in confronting pandemics, conflicts, economic recessions and climate change," she said.

IPU President Duarte Pacheco said gender-equal parliaments have the power to influence decisions that can prevent wars. "Gender-sensitive parliaments can help bring more global security. This is because there's no mother that feels well when she sees their children going to war. And

that just shows the difference," said Pacheco.

"I believe that with gender-sensitive parliaments we will be more open, and try to understand the positions of the others and to open to dialogue and avoid so many conflicts." The week-long assembly convened more than 1,000 delegates, including MPs and Speakers from 120 parliaments. The assembly was held under the theme "Gender equality and gender-sensitive parliaments as drivers of change for a more resilient and peaceful world."

The lawmakers called for a new generation of more diverse parliamentarians to advance gender equality and inclusivity. They also committed to placing vulnerable populations at the center, end to gender-based discrimination and ensuring equal sharing of care responsibility.

"We must share the care responsibility equally among men and women. Let's act as examples in our societies by undertaking 50 percent of the daily care work for our families, regardless of whether we are male or female MPs," Nyirasafari said.

MP Ivan Flores stressed the need to end gender-based discrimination and violence, and other harmful practices while ensuring access to sexual and reproductive health, rights and justice for all women and girls.

Martin Chungong, the secretary general of IPU, said peace negotiations involving women tend to be sustainable. "That is why we say that it is important for women to be at the table when peace processes are initiated," he said.

Meanwhile, a survey presented at the IPU assembly indicated that women lawmakers across the world have been targets of violence, sexism and sexual harassment perpetuated by their male colleagues. "Sometimes, we don't believe it but discrimination also happens inside our own parliaments," Pacheco told the assembly. Female lawmakers make up 26 percent of parliaments globally. **Xinhua** 

## CPC vows to boost modernisation

BEIJING

THE Communist Party of China has vowed to comprehensively advance national rejuvenation through a Chinese path to modernization, a central task the Party laid out for the next five years and beyond at the 20th CPC National Congress, which opened in Beijing on Sunday.

While delivering a report at the opening session of the congress on behalf of the 19th CPC Central Committee, Xi Jinping stressed the need to coordinate development and security, and he highlighted safeguarding national security and social stability in the course of promoting sustained growth.

"From this day forward, the central task of the CPC will be to lead the Chinese people of all ethnic groups in a concerted effort to realize the Second Centenary Goal of building China into a great modern socialist country in all respects and to advance the rejuvenation of the Chinese nation on all fronts through a Chinese path to modernization," Xi said.

He said that the next five years will be crucial for getting the efforts to build a modern socialist country in all respects off to a good start.

In a two-step development strategy, the CPC aims to basically realize socialist modernization by 2035, and then build China into a great modern socialist country that is prosperous, strong, democratic, culturally advanced, harmonious and beautiful by the middle of this century.

Xi said that China aims to lead the world in composite national strength and international influence by the middle of this century. He set out the major principles in the nation's endeavor to build a modern socialist China in all respects.

"On the journey ahead, we must firmly adhere to the major principles of upholding and strengthening the Party's overall leadership, following the path of socialism with Chinese characteristics, applying a people-centered development philosophy, remaining committed to deepening reform and opening-up, as well as carrying forward our fighting spirit," he said.

Xi mentioned in the report a wide range of areas in which China will strive for further progress, including high-quality economic growth, balanced development, ecological conservation, people's well-being, strengthening the Party, law-based governance, high-level opening-up, independent technological innovation and diplomatic efforts to promote world peace and development.

On the Taiwan question, which is considered as China's core interest, Xi reiterated striving for China's complete reunification in a peaceful way, but said "we will never promise to renounce the use of force". Resolving the Taiwan question and realizing China's complete reunification is, for the Party, a historic mission and an unshakable commitment, he said.

In analyzing the environment for the country's development, Xi said that China has entered a period of development in which strategic opportunities, risks and challenges are concurrent and uncertainties and unforeseen factors are rising.

Warning of various unpredictable dangerous events ("black swans") and foreseeable but unaddressed dangers ("gray rhi-

nos") that may occur at any time, he urged Party members to be more mindful of potential dangers, be prepared to deal with worst-case scenarios, and be ready to "withstand high winds, choppy waters, and even dangerous storms".

He urged the whole Party to meet obstacles and difficulties head on, ensure both development and security, and prepare well to surmount difficulties and challenges on the road ahead.

The Party will take coordinated steps to ensure external and internal security, homeland and public security, traditional and nontraditional security, as well as its own security and common security with others, he said.

Speaking of China's development in the new era since the 18th CPC National Congress in 2012, Xi said that the past decade marked three major events of profound historical significance for the cause of the Party and the people.

"We embraced the contents of the Communication of the

"We embraced the centenary of the Communist Party of China; we ushered in a new era of socialism with Chinese characteristics; and we eradicated absolute poverty and finished building a moderately prosperous society in all respects," he said.

China has seen a historic rise in its economic strength in the past decade. Its GDP has grown from 54 trillion yuan (\$7.5 trillion) in 2012 to 114 trillion yuan in 2021, and the 2021 figure ac-

counts for 18.5 percent of the world economy, up 7.2 percentage points from 2012, Xi said.

The country continues to be the world's second-largest economy, ranks first in the world in terms of grain output, and its manufacturing sector is the largest in the world, as are its foreign exchange reserves, he said.

Xi also talked about China's response to the COVID-19 pandemic, including its pursuing of the dynamic zero-COVID policy. He said that "we have protected the people's health and safety to the greatest extent possible and made tremendously encouraging achievements in both epidemic response and economic and social development".

"As we fully affirm the remarkable achievements we have made in the cause of the Party and the country, we must not lose sight of the shortcomings in our work and the many difficulties and problems confronting us," Xi said.

He set out a list of issues to be addressed in the coming years, including unbalanced and inadequate development nationwide, bottlenecks hindering high-quality development, and strengthening China's capacity for scientific and technological innovation, as well as major issues to be resolved in order to guard against financial risks and ensure that food, energy, and industrial and supply chains are secure and reliable.

## US schools struggle to deal with hoax shootings

MORE and more US schools are confiscating guns from students and having to deal with calls falsely reporting school shootings.

The number of guns found on students in schools during the first two months of this school year has risen compared with the same time in the past two years, says the nonprofit group Gun Violence Archive, which monitors gun activity.

At least 220 guns were seized last month and in August in 35 states, compared with 128 at the same time last year. In the corresponding period in 2019, 132 guns were confiscated. The number of guns found in 2020 is likely to have been

lower because it was amid the pandemic, when classes were remote.

At least 15 guns were recovered from schools in Baltimore, Maryland, last year, said Sergeant Clyde Boatwright of the Baltimore City School Police Force. It was higher than in any recent year. This school year the department has recovered two guns. One was used when a high-school student was shot dead outside a school.

The increasing prevalence of guns comes with an increase in what has come to be known as swatting. This is a hoax in which someone calls emergency services and reports a nonexistent crime to get law enforcement officials, generally a SWAT team, to go to an address.

On Wednesday many San Francisco Bay Area high schools received active shooter hoax calls, a day after police in Florida responded to swatting calls at several high schools.

Since early last month about 117 hoaxes have been reported at schools in 17 states and the District of Columbia, said the National Association of School Resource Officers, a nonprofit group for school-based law enforcement professionals.

"These false alarms are far from harmless," said Mo Canady, the associations' executive director. "They also divert limited public safety resources from other community needs and in-

crease anxiety among students and others."

The calls have been made mostly from high schools, but also middle and elementary schools, according to local news reports. Some of the calls are hard to trace because they are made from internet phone numbers, law enforcement experts said.

#### Rise in cases

In addition to school shooting hoaxes, the number of guns that were fired in schools, including a bullet hitting school property or being brandished during the day, nights or on weekends, rose this year, the nonprofit group K-12

School Shooting Database said.

It found that there were 224 incidents, compared with 182 last year.

At least 43 people have died and 91 have been injured this year as a result of gun violence in schools, including the mass shooting at Robb Elementary School in Uvalde, Texas, in May, said Everytown for Gun Safety, a group that treels gun violence.

tracks gun violence.

Since students have returned to school, many have experienced behavioral issues, teachers and school safety officers said.

## Africa youth call for concrete climate actions ahead of COP27

AFRICAN youth are calling for concrete climate change actions ahead of the 27th session of the Conference of the Parties (COP27) to the UN Framework Convention on Climate Change next month.

COP27 will take place in Sharm el-Sheikh, Egypt, from Nov. 6-18. In a resolution adopted at the closure of the YouthConnekt Africa summit in Kigali, Rwanda's capital, Saturday the youth said mobilizing finance for climate change is urgently needed as a requirement to many of the actions African countries need to take to address climate change.

COP27 should lay out concrete actions for assisting developing countries in getting climate finance required to boost climate actions, they suggested in the resolution, titled a call to action to global leaders. The resolution will be presented at the COP27 meeting.

Though developed countries had pledged nearly 100 billion U.S. dollars per year by 2020 for climate action in developing countries, this is yet to be fulfilled.

"At COP27 there should be concrete actions to initiate plans on how the funds will transform to ensure sustainability. Still, more innovative financing models and new financing instruments are needed," said Alodie Iradukunda, Rwanda National Youth Council coordinator while addressing the gathering.

The youth also called on COP27 to clarify the steps needed to address loss and damage. "There is an urgent need to secure a dedicated new financing facility that will help developing countries ravaged by climateinduced losses and damages.

More policy-making efforts should be channeled towards understanding and laying out an action plan for tackling loss and damages across vulnerable communities alongside mitigation and adaptation," Iradu-

On youth-led green entrepreneurship, the summit called on Africa to prioritize and harness the power of youth innovative solutions as a tool for green and climate-resilient economic growth.

The role of young people in climate actions should not be underestimated as they are powerful catalysts in advancing climate actions, especially through green entrepreneurship, the youth said. The forum urged Africa to scale up adaptation. Climate change threatens the lives and livelihoods of more than 100 million people in extreme poverty.

The summit warned that with the low levels of adaptive capacity and lack of relevant information and high dependence on agro-eco systems livelihoods in Africa will be harshly affected due to climate change.

"Every problem begins with a climate change issue, that is why transforming our strategies and changing our behaviors to protect the planet and to help vulnerable people is the only way we all have to make Africa and the world a better place," said Juvenile Mugwa, a youth delegate from Cameroon.

Investments need to be made in early warning systems and infrastructure that can withstand extreme weather conditions, according to Iradukunda. "We need to develop plans and policies to deal with the effects of climate change.

Adaptation hence is key and critical to ensuring that

Africa can continue to prosper in the face of climate change," she said. On energy transition for Africa, the youth called on COP27 to ensure sustainable energy access for Africa's 600 million people who still lack access to energy in Africa.

The summit also appealed to Africa to accelerate the drive toward climatesmart agriculture, noting that climate change undermines the continent's ability to feed its population, making it a top priority to address.

The meeting called for improved agriculture productivity to address the mounting food insecurity in the face of climate change.

On plastic pollution and waste management, the summit underlined the need to improve the management of waste, particularly plastic waste as it poses a serious threat to the continent affecting people's

It also urged more investment in waste

management through public-private partnerships or scaling up support to social entrepreneurship efforts that are addressing these issues. Africa's largest annual youth summit that connects youth from across the continent and beyond was organized under the theme "Accelerating Investments in Youth: Resilient Youth, Resilient Africa."

Roughly 10,000 young people and policymakers from more than 90 countries attended the event. Oulie Keita, the executive director of YouthConnekt Africa, commended the young people for showing enthusiasm in their participation and emphasized the need to put youth in the driver's seat.

"Young people have engaged with their leadership in shaping the narrative on Africa's development to ensure that Africa is portrayed for what it truly is -- a continent rich in talent, natural resources and resilience, Africa is indeed the future,"

"Throughout the sessions, attending youth felt a sense of empowerment after leaders and experts from various fields pledged their support to empower the youth to successfully undertake projects that can steer the continent's development."

Key issues discussed at the summit included the contribution of youth toward climate action, sustainable peace and security, cultural creative industry, sports, the economy as well as skilling for the digital economy. # Japan PM orders probe into Unification Church

JAPANESE Prime Minister Fumio Kishida yesterday instructed his culture minister to launch an investigation into the contentious Unification Church amid opposition pressure and slumping support for his Cabi-

The investigation has been launched based on "the right to ask questions" under the Religious Corporations Act, with the probe marking the first time the government here has exercised the right.

The result of the probe could see the organization lose its status as a religious corporation and its tax ben-

At a parliamentary session yesterday Kishida said he ordered the probe following more than 1,700 consultation requests received since early September through a telephone hotline service.

An advisory panel, meanwhile, has also urged the government to use the Religious Corporations Act to disband the group or launch an investigation before disbanding it.

The Unification Church, formally known as the Family Federation for World Peace and Unification, has been under the spotlight for encouraging its followers to make exorbitant donations in the form of "spiritual sales" in return for "karmic benefits."

Following such donations, some followers have been left in financial

"The government has taken seriously the fact that there are a large number of victims as well as poverty and broken families, and they haven't been provided with adequate relief," Kishida said.

Pressure has been mounting on the ruling Liberal Democratic Party (LDP) headed by Kishida, amid slumping public support, to explain its connections to the organization after having previously promised to sever ties.

An internal probe by the LDP last month revealed about half of the LDP's lawmakers had ties with the controversial organization, often referred to as a cult.

Concern has been rife among opposition parties and the public that the controversial group may have been trying to influence politics here through links with LDP lawmakers.

## Nutrition improvement programme for rural students in compulsory education benefits 350 million Chinese students

STUDENTS have grown taller and stronger since the nutrition improvement program for rural students in compulsory education was launched, said Li Ming, principal of an elementary school in Xiji county, Guyuan, northwest China's Ningxia Hui autonomous region.

The program offers students a nutritious and delicious lunch at school, and has put an end to the days when some students had to go back home kilometers away for lunch, the principal noted.

As of the end of 2021, the nutrition improvement program for rural students in compulsory education has benefited a total of 350 million students.

Center for Disease Control and Prevention, the average heights of male and female students in the regions where the program is implemented have increased 4.2 centimeters and 4.1 centimeters from 2012 to 2021, and the weight increases were 3.5 kilograms and 3.3 kilograms, respectively. These figures all outnumbered the average among all rural students across the

Only 2.5 percent of rural students in central and western China suffered delayed growth in 2021, 5.5 percentage points lower than the number in 2012, the center said.

Apart from the rising subsidizing standard and meal quality, the program also encourages schools in pilot areas to build better cafeterias. As of the end of 2021, 76 percent of the schools supplied food under the program to the students

at school cafeterias, and the number was nearly 90 percent among schools in national-level pilot counties.

Improving work mechanisms and ensuring food safety are the top priorities. Qiubei county, Wenshan Zhuang and Miao autonomous prefecture, southwest China's Yunnan province, has launched a digital cafeteria management platform to provide better food to the students.

The platform is joined by the local education and sports bureau, schools and food suppliers. It monitors all procedures, including the verification of suppliers' certificates, purchasing, food safety and financial management.

Today, local authorities in Yunnan province are working to build whole-process online monitoring and management

systems, employing electronic scales, facial recognition, pesticide residue monitoring devices, the Internet of Things and big data, for more targeted management of the nutrition improvement program.

Science popularization activities have been launched across China over recent years to improve the public's knowledge of nutritional science and guide teachers and students to develop science-based dietary

By launching training courses on the nutrition improvement programme and developing an electronic dietitian system, the Ministry of Education and the National Health Commission have effectively improved primary-level personnel's capa-

bility in making nutrition diets. The nutrition improvement program for rural students in compulsory education has been applauded by the international community. According to a survey launched by the World Food Programme in 169 countries, China is one of the few countries in the world that provides nutritional meals for both middle school and primary school students, and ranks among the best in terms of supply volume.

The nutrition improvement program has played a significant role in promoting educational fairness, advancing poverty reduction and implementing the rural vitalization strategy, and has laid a solid foundation for improving Chinese people's health, strengthening education and advancing the Healthy China Initiative.

## **Mayor announces conclusion of** partial mobilization in Moscow

**MOSCOW** 

THE goals of the partial mobilization in Moscow have been achieved in full and reservists' visits to military offices on call-up notices are no longer required, Moscow Mayor Sergey Sobyanin said yesterday.

"According to the information of the Moscow military commissar, the goals of the partial mobilization set pursuant to a presidential decree and mandated by the Defense Ministry have been achieved in full," the mayor wrote on his blog.

Partial mobilization call-up offices are closing at 2:00 p.m. on October 17, Sobyanin

"The call-up notices sent out in the process of mobilization to the places of citizens' residence and businesses cease to be in effect," the Moscow mayor stressed.

Russian President Vladimir Putin earlier said that 222,000 reservists out of the planned figure of 300,000 had already been called up in the partial mobilization campaign in Russia and the remaining personnel would be mobilized in the next two weeks.

Russia's partial mobilization

On September 21, President Putin declared a partial mobilization in Russia. Defense Minister Sergey Shoigu clarified that 300,000 reservists primarily with combat experience would be called up, who would undergo training before being sent to the special military operation zone.

The partial mobilization would not involve students and conscripts and some other categories of citizens, including the workforce of the country's defense enterprises. The staff of IT companies, communications operators and the media would also get a deferment from the partial mobilization if they worked in their specialty full time. In addition, as the Russian General Staff explained, privates and sergeants in reserve under 35 years of age, junior officers under 50 and senior officers under 55 in reserve were subject to the call-up.

# Top 10 Middleweight boxers who were stripped of titles -2

#### Miguel Cotto

Puerto Rico's Miguel Cotto won the WBC Middleweight title by beating Sergio Martinez in June of 2014 and held it until November 2015 when he was stripped.

The 36-year-old Cotto is currently 40-5 with 33 KOs and is a five-time world champion and the first Puerto Rican to win world championships in four different weight divisions.

He was a fine amateur and competed at the 2000 Olympics before turning pro in 2001.

Cotto had already won a junior welterweight, welterweight, and Junior Middleweight title by the time he challenged Martinez for the WBC and Lineal Middleweight championships.

The fighter had already taken on the likes of Antonio Margarito, Austin Trout, Shane Mosley, Zab Judah, Ricardo Mayorga, Floyd Mayweather Jr., and Manny Pacquiao.

The Puerto Rican was stripped of the WBC title when the organization said he did not follow their rules leading up to his loss to Canelo Alvarez in November 2015. However, Cotto said it was because he would not pay their excessive sanctioning fees.

Cotto also lost the Lineal title against Alvarez and is scheduled to meet Yoshihiro Kamegai on August 26 for the vacant WBO Junior Middleweight title.

#### Saul 'Canelo' Alvarez

If a boxing follower has been following the list he/she will see that Mexico's Saul 'Canelo' Alvarez won the WBC Middleweight championship when Miguel Cotto was stripped of it and Alvarez beat Cotto in November 2014.

The 26-year-old Alvarez is a two-division world champion as he also held Junior Middleweight titles on two occasions. He was also the Lineal Middleweight champion from late 2015 to 2017.

Alvarez, currently ranked as one of the best pound-for-pound boxers in the world, is 49-11 with 34 KOs. His lone defeat came in a fight against Floyd Mayweather Jr. by a majority decision in 2013.

In May 2016 Alvarez was stripped of the WBC title when the organization told him he would lose it if he did not meet mandatory challenger Gennady Golovkin.

Alvarez was given the option of either relinquishing the title or being stripped of it, so basically he left it on the table.

Ironically, 16 months later Alvarez and Golovkin were bound to take on each other on September 16 in a Middleweight title bout.

#### Marvin Hagler

Southpaw Marvelous Marvin Hagler took on greats such as Roberto Duran, Tommy Hearns, and Sugar Ray Leonard and went 62-3-2 in his career from 1973 to 1987 with 52 KOs.

Hagler was born in Newark, New Jersey, and was the undisputed Middleweight king between 1980 and 1987 with 12 successful title defenses and a knockout ratio of 78 percent.

He was one of the longest-reigning Middleweight winners due to his granite chin and punching power. Hagler won the WBA, WBC, and Lineal titles by stopping Alan Minter in the third round in 1980.

He added the vacant IBF title in 1983 by beating Wilfred Scypion. Hagler was suddenly stripped of the WBC title in October 1984 after beating Mustafa Hamsho by a third-round TKO.

The WBC said he was stripped because his fight with Hamsho was scheduled for 15 rounds instead of 12.

However, they quickly reinstated Hagler as champion after the public outcry. Hagler lost by controversial split decision a month later and never fought again.

#### Carlos Monzon

In many boxing experts' eyes, Carlos Monzon of Argentina was the best Middleweight that ever lived

The rugged Monzon fought between 1963 and 1977 with a record of 87-3-9 with 59 KOs and one no-contest in 100 bouts.

He won the WBA, WBC, and Lineal titles in November 1970 with a stoppage over Nino Benvenuti. He defended his titles 14 times during his reign of seven years.

The WBC stripped the pugilist boasting of Hall of Fame status in 1975 though when Monzon would not defend the title against Rodrigo Valdez of Colombia.

Monzon would eventually meet Valdez the next year and beat him by a 15-round unanimous decision to regain the WBC title.

The two then faced off in a rematch 13 months later in July 1977 with the fight ending in the same result in Monzon's final career bout.

Over a decade later Monzon was found guilty of killing his wife and died in a 1995 car accident while on a weekend leave from prison.

ARUSHA's athletes emerged as winners of the just-ended Junior Athletics Championship which was held at Sheikh Amri Abeid Stadium in the region last weekend.

The maiden showdown was organized by Tanzania Youth Athletics Championship (TAYAC) and attracted more than 300 junior athletes from across Tanzania and others from India, Turkey, Germany, and other countries.

Rogath Stephen, Arusha Regional Athletics Association's Secretary-General, stated the event was initially slated for two days but it was only held for a day due to what he described as professional handling by the organizers.

He said Arusha won 23 medals while Manyara won 15 medals to finish second, and Kilimanjaro took third place having collected 12 medals.

He attributed his region's success to such schools as St. Jude, St. Patrick's, and Jeffrey which have serious and wellorganized athletics academies.

"I'm happy that our junior athletes won this maiden Junior Athletics Championship, the future of Arusha and the country in athletics is very bright, our region has many international schools which have serious athletics programs," he said

Arusha City Mayor Maxmillian Matle was the guest of honour in the showdown's closing ceremony and pledged his office's continued support to the development of athletics in the region and the country at large.

"I'm asking organizers of the Junior Athletics Championship to involve us, this is a very good development and my office is ready to offer its support," Matle pointed out.

"We hope next time you will involve us so that we can make the event more attractive and competitive," Matle added in a monitored radio interview.

On Friday, Tanzania's athletics legend

Suleiman Nyambui stressed the need for the country to have more junior athletics events for it to realize its dream of having many top athletes.

Nyambui, also former Athletics Tanzania (AT) Secretary-General and Brunei's national athletics team head coach said all countries which are doing well in athletics invest in junior events.

"The best way for the country to produce top athletes who can compete in both local and international events and bring home medals is to start from the grassroots, we must organize many tournaments for the youths, the tournaments will help the juniors gain experience and exposure," he said.

Nyambui that also took charge of the national athletics team which took part in the 2022 Commonwealth Games in England issued his appeal when TAYAC officially unveiled the maiden Junior Athletics Championship.

Sponsors of the championship include Vodacom Tanzania, Moyo Medicare Specialist Clinic, Bonite Bottlers, Arusha Jambo Houses, HD Printing Solutions, Bonds Security Co Ltd, Radio 5 FM, Supreme Auto Upgrade, and Arusha Regional Athletics Association.

In the past three years, the championship has been organized by Tanzania Youth Athletics Championship (TAYAC) with emphasis on athletes falling into the age category of 6-14 years but, this time around, the organizers disclosed they thought it wise to have the event targeting 15-20 years category.

Juliana Mwamsuva, one of TAYAC's directors, said the organization deals with hosting sports competitions in track and field at both local and regional levels.

She revealed that it, in the past three years, had been organizing athletics events for junior athletes aged between six to 14.

According to Juliana, most of the athletes that battled it out in the showpiece in the past three years are now mature, so last weekend's showdown aimed to welcome them to another age group, as the organizers do not want to leave the youngsters behind.

She pointed out that the organization believes that talented athletes should be nurtured at a tender age and the Junior Championship is a better platform for transition.

Juliana revealed: "TAYAC also aims to see that many junior athletes are graduating to the senior team so that they can represent the country in both local and international events."

"We always make follow up on talented athletes and offer some athletic coaching lessons, it pleased us to see that some of the athletes who have been competing in our events were selected to represent Arusha in the last year's National Athletics Championships held in Arusha, we hope that this year many of our athletes will make it in their regional teams," Juliana disclosed in the previous interview.

She said TAYAC programs focus on promoting youths' participation in sports, health development in youths, and increasing youths' access to health care.

TAYAC, Juliana moreover stated, also creates a marketplace for young athletes by introducing training sessions under the supervision of international coaches and clubs.

Th TAYAC director pointed out: "We provide the youths community with an opportunity to a continuous athletics professional training, we expose youths' hidden talents to quality fields, coaching, standard competitions, then they participate in sports competitions, be recognized, and awarded for their talents."

"Our programs are also aimed at reducing of Non-Communicable Diseases (NCDs) as chances of cardiovascular, respiratory, diabetes, and cancer are reduced," she said.

## Azam FC's CAF Confederation Cup motto was easier said than done

WHILE playing away in Benghazi, Libya Tanzania's Azam FC was beaten 3-0 by Al Akhdar SC, putting themselves in danger of qualifying for the next round of the 2022/23 CAF Confederation Cup.

Azam FC fans and Tanzanians, in general, were consequently afraid that the club could hardly change the results in the rematch.

The outfit announced to do what was termed 'Remontanda', a Spanish word meaning either turn tables or overturn the results.

Azam FC had what it takes to turn the tables in the rematch

held at Azam Complex Stadium in Dar es Salaam last weekend. Much as the Tanzanian side won 2-0 the squad was knocked out considering the Libyans notched a 3-2 aggregate win.

The squad would have overturned the results and progressed to the playoffs if it approached the rematch with high intensity and carefulness throughout.

The squad was first required to correct the simple technical mistakes made by the technical bench in the first leg held in Benghazi.

In the first game, Azam FC head coach Denis Lavagne had, despite his experience in African inter-club competitions, no respect for the opponent.

Knowing that he was missing his important players like Malickou Ndoye and Daniel Amoah in the defense, he fielded

two midfielders while using two attackers.

Lavagne should have been more defensive by keeping three midfielders to control the middle of the field where the plans for victory take place.

Starting with two attackers reduces the balance in an outfit and the side, consequently, looks sloppy, and the opponent attacks easily.

The decision by the head coach to leave Ivorian Kipre

Junior out and start with youthful defender Pascal Msindo on the left wing is another insult.

A match like that is not an opportunity to test the players, a gaffer should use the best players he has.

Such mistakes were as well made by Lavagne in Azam FC's top-flight game against Tanzania Prisons at Sokoine Stadium in Mbeya.

He used Tepsie Evance as number 10 and left Abdulhamis Suleiman who is very good in that role. Mistakes like these cannot make a squad successful in a continental showdown.

Since coming to Africa for the first time in 2007, Lavagne has taken charge of clubs in 88 CAF competitions at the club level, reaching the final of the 2008 CAF Champions League and the 2020 CAF Confederation Cup.

That is a great experience that could have been sufficient to make him respect Al Akhdar, but he did not.

For 'Remontanda' to be possible, Azam FC needed to avoid such simple mistakes.

Fielding players in respective positions, Suleiman is fielded as either number 10 or attacking midfielder behind attacker Prince Dube.

Kipre Junior ought to have been fielded as a winger, and either Ayoub Lyanga or Evance taking the other wing. Lusajo Mwaikenda ought to be played as a right full-back, while

Bruce Kangwa plays as the left full-back.

Chances for Mwaikenda to make the squad for the match depended on the recovery of either Amoah or Ndoye.

A midfield consisting of Sospeter Bajana and Issa Ndala which has proven to be solid can do easy tasks because the majority of the mentioned players have turned out for Azam FC this season.

Football has been full of surprises in recent years. 'Remontanda' was possible but Lavagne was supposed to be respectful to opponents.

The last 32 second leg thrashing of Rivers came as a huge relief to new coach Houcine Ammouta, who had come under firer after losing to Berkane and failing in Nigeria.

Wydad are among 16 clubs who have secured group places, and a draw in Cairo on a date to be announced will split the survivors into four groups with the first matches during February.

Elsewhere, Horoya of Guinea equalised in added time to draw 1-1 with ASEC Mimosas of the Ivory Coast in a big west African showdown in Nongo near Conakry and advanced 2-1 on aggregate.

## Liverpool and Man City bitter rivalry boils over at Anfield

LIVERPOOL England

MANCHESTER City manager Pep Guardiola said Liverpool fans needed to improve their aim after coins were allegedly thrown at him – and missed – during his team's 1-0 defeat at Anfield on Sunday.

Liverpool, meanwhile, said City fans must behave better.

"We are deeply disappointed to hear vile chants relating to football stadium tragedies from the away section during today's game at Anfield," Liverpool said in a statement after the Premier League game. "The concourse in the away section was also vandalized with graffiti of a similar nature."

It is not the first time the rivalry between English soccer's most dominant teams of recent years has turned bitter.

In 2018, City's team bus was attacked by Liverpool supporters ahead of a Champions League quarterfinal match at the same stadium. And the wounds clearly run deep for Guardiola, who joined City in 2016.

The flash point Sunday came after Phil Foden's second-half goal was ruled out when VAR invited referee Anthony Taylor to review the pitchside monitor and he spotted a foul on Fabinho in the buildup.

The City manager angrily remonstrated with the crowd, wildly gesticulating before he claims coins were thrown in his direction.


"Next time they will do it better," he said. "They didn't get me. They try it again next year. "All these coins, they tried, but

didn't get it. They got the coach years ago."

Liverpool said it would investigate

the alleged incident and that any fan found guilty of throwing coins faced a lifetime ban from Anfield.

Liverpool was fined just under \$20,000 for incidents around the Champions League match four years ago, which included such severe damage to City's team bus that a replacement was required to get the players back to Manchester.

## Lesson learned for Ancelotti as Real Madrid beats Barcelona

CARLO Ancelotti learned his lesson, and Real Madrid won the "clásico" on Sunday.

After an embarrassing 4-0 loss at home to Barcelona last season, the Madrid coach made sure he didn't try anything different with his team this time as Madrid won 3-1 to take the lead of the Spanish league.

It also handed Barcelona another painful blow four days after the Catalan club's hopes of advancing in the Champions League all but ended.

Ancelotti had used midfielder Luka Modric in the "false nine" position in attack last season and Barcelona took advantage to rout Madrid at the Santiago Bernabéu Stadium.

"I thought about what happened last season, when I tried something different," Ancelotti said. "For this match, I didn't try to come up with anything, I left the players in their positions and Modric played a spectacular match in midfield."

Karim Benzema and Federico Valverde scored first-half goals, and Rodrygo added another in second-half stoppage time as the defending champions won the first "clásico" of the season to move three points ahead of Barcelona in the league standings. The rivals had entered the match tied on points, with Barcelona ahead on goal difference.

It was Madrid's sixth win in the last seven "clásicos," with the only setback the 4-0 result the last time the teams met at the Bernabéu.

Sunday's defeat was another frustrating setback for Barcelona after it was held 3-3 by Inter Milan at home on Wednesday to be virtually eliminated from the Champions League with two rounds left in its group stage.

"We had our chances but we are

MBEYA's Ihefu SC head coach Juma Mwambusi has described his side's first victory in the 2022/23 NBC Premier League as a morale boost and motivation for it to hunt for more wins.

Ihefu SC commanded a 2-0 win over Dodoma Jiji FC at Highland Estates Stadium last Sunday to bring the Mbeya club's string of less convincing results to a halt.

The Mbeya club which had been winless in six NBC Premier League games successfully banished the less convincing performance that had been tormenting the club in the past six games with the victory in front of its supporters at Highland Estates Stadium in Mbarali.

"Earning our first win was our

our confidence, before today's victory we were playing under pressure but now we are a bit relaxed as we plan our next match," the veteran coach pointed out.

Ihefu SC goals on Sunday were scored by goal-getters Jaffary Salum and Obrey Chirwa and have taken the Mbeya-based side to 15th position in the 16-team

The Sunday win by Ihefu SC has now left Polisi Tanzania as the only NBC Premier League outfit to have not tested a win this season.

Ihefu SC will now play crucial three away NBC Premier League games against Singida Big Stars, Azam FC, and Simba

Before the Sunday encounter, Ihefu SC settled for a draw in two games, a 1-1 draw with Mbeya City FC, and garnered the same results when it took on Tanzania Prisons and lost three gamesmost desired mission to regain 1-0 defeat to Namungo FC, 3-1 defeat to

Mtibwa Sugar, and 2-1 loss in the hands of KMC FC. The Sunday game was the first for Dodoma Jiji FC's American gaffer Melis Medo that has replaced Burundian Masoud Djuma that was shown the exit door.

After the game, Medo noted that he has work to do. "The players are good and are doing all we can to win the games, as a new coach, I have a job to do but I'm confident that with support from all team stakeholders we can achieve our goals," he noted.

Dodoma Jiji FC will next week host Mtibwa Sugar and then play two away games against Polisi Tanzania and Coastal Union.

Before the Sunday defeat to Ihefu SC, Dodoma Jiji FC had won 1-0 against Geita Gold FC, recorded two goalless draws with Singida Big Stars and Kagera Sugar, as well as conceded a 3-0 defeat to Simba SC and 1-0 loss to Tanzania Prisons.

### Polisi Tanzania set to decide coaches' fate

THIS season's NBC Premier League struggling outfit, Polisi Tanzania, says the fate of the side's technical panel will be known before the squad's next game against Namungo FC slated for tomorrow.

Polisi Tanzania's vice-chairman Robert Munisi said the management of the club did not give the technical panel members ultimatum to save their jobs but rather said they have assigned one of the club committees to investigate the reasons for the team's poor performance in the league.

He said the main aim of the investigations is to come up with measures that will halt the club's free fall.

"The top leadership of the club will act according to recommendations of the committee," he said.

He said Police are a big institution that cannot rush at making decisions and the investigation will not spare any person found to be behind the team's poor form.

Munisi noted: "There is a lot of pressure from all angles including the management, Polisi Tanzania FC is sponsored by the Police force, and we have competent investigators who are in various committees of the club."

"The committees have been assigned to find the root cause of our team's poor performance in the league," the leader added.

Munisi disclosed: "If their findings will point at us that we are behind the poor form of the team, we will step down to pave way for other competent people to run the affairs of the club, as is the case with the technical panel.'

"Inspector General of Police (IGP) Camilius Wambura always reminds us that if we feel that we are not fit for that role, we should hand chance to others to take over," he said.

One of the members of the technical committee of the club who pleaded for anonymity said pressure is high among the technical panel members.

"We are indeed going through a bad spell but what surprises us the most is that the players play spiritedly in training and during matches but the results are not coming the way we desired," the leader revealed.

"The pressure among us is high and we all hardly know what will happen between now (Monday) to Wednesday, we are just keeping our figures crossed so that better things may come," he said.

Polisi Tanzania coached by Burundian Joslin Shariff Bipfubusa started this season with a 2-1 loss to Premier League defending champions Yanga, then draw 2-2 with KM FC.

The Kilimanjaro-based squad notched a goalless draw with Coast Union, lost 1-0 to Ruvu Shooting, conceded a 2-1 loss to Geita Gold FC, thereafter went down 2-0 to Kagera Sugar and suffered a 3-1 loss to Mbeya City FC.

After tomorrow's encounter with Namungo FC, some of Polisi Tanzania's fixtures include playing away to Prisons, then host Dodoma Jiji FC and Singida Big Stars before taking part in away clashes against Ihefu SC, Mtibwa Sugar, and Simba SC.
