MPs demand surveying of all land plots, wider tax base

Urge disbanding of TRA special task force

MEMBERS of Parliament yesterday advised the government to broaden its tax base by looking into new revenue sources instead of relying on traditional ones.

One potential source of revenue, they said, is surveying of plots and collecting the resultant property tax.

The lawmakers also urged construction of processing factories using locally produced raw materials as well as coming up with cordial methods of collecting taxes

They were debating the lately tabled national development plan 2021/2022 and the third five-year development plan (2021/2022-2025/2026).

Mlimba MP Godwin Kunambi said Tanzania has vast stretches of land but most of it has not been surveyed, which denies the government revenues which could be collected from payment of property taxes.

"The land sector has as yet to perform to required standards. There are 185 districts but we have failed to survey land in 50 districts or more," he said, citing Dodoma

'Less schooled work better than educated'

NATIONAL Assembly Speaker Job Ndugai yesterday poked holes in Tanzania's education system, blaming it for a poor work ethic among the educated compared to the less schooled.

Contributing to debate on the 2021/22 Budget outline and third Five Year Development Plan (2021/22 -2025/26), Ndugai said standard seven leavers and primary school dropouts are the engines driving the Tanzanian economy.

He asserted that from form four leavers to university graduates there is mainly a lazy lot that that does not help the country move forward. This group is allergic to physical work such

as farming and animal husbandry, he affirmed.

"How many educated people farm or keep animals?" he asked. "Everybody who goes beyond form four thinks they are above farming.'

Ndugai asserted that the problem lies in the education system that does not prepare learners to work in any sector with opportunities such as agriculture. "Instead, education makes people look down on some jobs as is the case with majority of educated Tanzanians."

"I really don't know what we can do to get out of this mess but the fact of the matter is we produce youth who like to play snooker and chatting on smart phones. That is why I asked you

Tourism sector earnings up by 1.6trn/- from 2015

REVENUES from the tourism sector reached \$ 2.6bn/- (6,071.3trn/-) in 2019, a sharp increase from \$ 1.9 billion equivalent to 4,436.7trn/- collected in

However, the government spent 269.7bn/- in five years to improve what is offered in tourist activities, including the protection of natural resources.

Presenting the national development plan for 2021/2022 and the third fiveyear development plan (2021/2022-2025/2026) in the National Assembly on Monday, the Minister for Legal and Constitutional Affairs, Dr Mwigulu Nchemba (pictured) said that following



improvements in the sector, the average number of days spent by visiting foreigners increased to 13 in 2019 compared to 10 days in 2015.

The minister informed MPs that tourists visiting Burigi National Park until December last year reached 1,171 where 996 are local visitors and 175 foreigners. Revenues collected from Burigi National Park reached 492,741, 622/- by end of last year.

Dr Nchemba said the number of tourists who visited the newly established Nyerere National Park, part of what is known as Selous Game Reserve until December last year stood at 9,938 where 6,189 were foreign visitors and 3,749 locals, raking up 1,552,712,660/- in earnings.

The various initiatives undertaken to improve the tourism sector resulted in higher tourist flows, from 1,137,182 visitors in 2015 to 1,527,230

Over 8000 farmers get 60bn/- in loans

NEARLY 60bn/-has been disbursed to farmers in soft agricultural loans targeting mostly smallholder growers countrywide, with the funds being issued to peasants in the space of two years.

"During that period more than 8000 recipients, mostly smallholder farmers benefitted from a variety of grant packages," explained George Nyamrunda, director of the Tanzania Agricultural Development Bank (TADB).

He detailed these operations at the launching of the TADB Smallholder Farmers Trust Fund, a ceremony held at the Sheikh Amri Abeid Stadium. The 4th series of empowerment funds and programs exhibition was taking place here at the national level, officials noted.

The exhibition, running under the theme 'Empowerment Funds and Initiatives for National Development,' was organized by the National Economic Empowerment Council (NEEC).

TADB is a development finance institution (DFI) established as an apex national-level bank for agricultural financing, and is currently working with 10 other institutions including banks to support local growers with soft manageable loans.

Targeted recipients include farmers, livestock keepers and fishermen, he stated.

Prime Minister Kassim Majaliwa lauded the gesture of support by local institutions for small scale farmers and traders, noting that the program was in-line with the policy initiatives to strengthen individual economic

activity with personalised credit arrangements.

"We have also seen the need to consolidate institutions with overlapping activities to get fewer organizations with more capacity to reach out to agro-sector producers from grassroots level," he stated.

Не expressed satisfaction with TADB efforts especially in programmes for agriculture financing and crop value chain enhancement. The bank also supports policy initiatives meant

to shape agro-sector financing and rural lending generally.

Region where in three years, authorities managed to survey 2,000 land plots without support from the Treasury.

"Surveying land plots would boost government coffers through payment of property taxes. District councils may use their internal revenues to survey the land by using the registered 80 private land surveying companies. Surveying the lands would also enable title holders to use the documents to secure loans from financial institutions," he pointed

Geita Rural MP Joseph Kasheku said for the government to attain targeted development objectives, should be serious investment in the agricultural sector to create more jobs and raw materials for constructed industries.

He underscored the need to ensure availability of quality certified seeds to produce quality products that can be used by factories and obtain a market outside the country.

implementing development should focus government on improving the business environment as some traders are now opting to close their businesses due to being overrated in tax charges, the MP cautioned.

Constantine Kanyasu, the Deputy Minister for Natural

Resources and Tourism, said that the Tanzania Revenue Authority (TRA) must use cordial methods in collecting taxes, noting that some traders have been complaining of harassment by TRA officials

Kanyasu, the Geita Urban MP, said that to get more people to comply in paying taxes, TRA should avoid overrating the charges. Some traders importing goods from China and elsewhere complain that taxes are hiked when the goods arrive, hence failing to collect their consignments from the port.

Mtama MP Nape Nnauye advised the government to stop using the special 'task force' in collecting revenues from traders, insisting that the officers apply harsh methods which deny the government revenues as traders resolve to close business. He said TRA should use its internal officers and avoid the use of excessive force.

Musoma Rural MP Sospeter Muhongo said that since Tanzania is categorised as a lower-middle income country by the World Bank after clear development strides, there should be deliberate efforts to keep up the economic growth pace to ensure proper middle-income status is attained

Tanzania must borrow a leaf from Kenya and Seychelles whose economic growth has surpassed the set World Bank targets, he urged.

National Assembly Speaker Job Nduagi advised the government to prioritise land surveying as a source of income. He was optimistic that land surveying would boost government coffers


through various taxes. He underscored the need to encourage the youth to work and participate in agricultural activities to produce raw materials for local industries.

"The country's is dominated by youth most of whom have not reached advanced secondary school level but they do not want to venture into agriculture. They should be encouraged to work in agriculture to contribute in the country's economic growth, he emphasised.

David Mwakiposa, MP for Mufindi South, urged increased production of agro-export crops for export. He said Tanzania has the potential to be leading exporter of various agricultural crops including tea and avocado, mostly cultivated in Njombe, Iringa and Mbeya regions.

The MP said Tanzania produces more avocado but exports less compared to our northern neighbour. The country exports 8,500 tonnes of avocado per year while it has a much larger potential, he told the House.

There is a huge market for Tanzanian agricultural products in China which is yet to be properly exploited, the legislator added.

Fisheries ministry set to review regulations

THE Ministry of Livestock and Fisheries is reviewing all the fisheries regulations in efforts to help solve challenges facing the sector, minister Mashimba Ndaki has said.

Addressing a press conference, the minister noted that several stakeholders in the fisheries sector have raised pertinent issues that can only be solved by reviewing the regulations and specifically overhaul the Fisheries Regulations, 2009.

The minister added that the ministry decided to take action following complaints raised by other stakeholders, including fishermen along the Indian Ocean, Lake Victoria and Lake Tanganyika on the amendment of the Fisheries Regulation,2020.

He mentioned some of the challenges raised by stakeholders

such as using ring nets during the day in the Indian Ocean, measuring fishing nets using mesh gauge as outlined in the regulation and full moon fishing of sardines.

"In effort sto solve the other mentioned and challenges, the ministry will review the Fisheries Regulations, 2020 and other areas that derail sustainable fishery development in the country," said the minister.

Minister Ndaki assured the public, especially fishery stakeholders that include fishermen, fish traders and traders on fishing equipment that the ministry is doing all it takes to ensure all players in the sectors operate through common understanding.

He issued four directives for immediate implementation as the ministry awaits recommendation from a team of experts formed to look into the challenges raised by

He directed the Tanzania Fisheries Research Institute(TAFIRI) to conduct a research on fishing using ring nets within two weeks and submit its report to the ministry, thereafter the ministry shall issue a statement.

On the measurement of fishing net size as outlined in the 2020 regulations, the minister said his ministry in collaboration with the Tanzania Bureau of Standards(TBS) shall determine the right measurement, stating that stakeholders should revert to using venier caliper and not mesh

The minister stated that the ministry shall issue guideline on the full moon fishing of sardines, adding that it is estimated to occur within six to seven days in a month.

He stressed the importance of solving challenges facing

the fisheries sector, noting that employs many Tanzanians. According to the minister. statistics show that in 2020, the sector provided 202,053 direct jobs to fishermen and some 4.5 million other people indirectly.

While expressing his readiness to address challenges faced by stakeholders in the sector, the minister called for cooperation in the fight against illegal fishing in the country's water bodies.

H also called for cooperation to help stop illegal exportation of fish products and control of revenue generated by the sector.

On the same note, he warned traders of fishing equipment and manufacturers to produce and sell the fishing gear legally. He urged local government authorities to cooperate with the fishing communities at their areas and strongly oversee fisheries resources in accordance with the

honourable members to think of this problem," he emphasised.

Ndugai then turned on civil servants, saying many do not help President John Magufuli. Though the Head of State is a hard worker, his efforts are hampered by the majority of civil servants with a poor work ethic.

"That is the truth; civil servants are the worst. We must now have a system whereby everybody is appraised," he stated.

"We must be able to establish if extension officers do their job; if at all our community development officers do not draw salaries for nothing. You MPs know what do they do?" The Speaker then turned to

how we can use this plan to fix Tanzania's poor performance in sport and blamed the same for general lack of passion at work. Citing the national football team that was recently eliminated from the African Nations Championship tournament, he said the team did not put up efforts compared to others.

"They (players) were not as hungry for goals like their competitors," he observed.

ZANZIBAR'S Tourism and Heritage minister, Lela Mohamed Mussa, has said she is not happy with unfriendly surroundings in some tourist attractions including beaches.

She said filth in tourist areas could make Zanzibar lose its prominence as a tourist destination as well as threatening visitors' health.

The minister issued the remarks when launching a campaign for cleanliness for the development of tourism in Kwale Island in Zanzibar Urban West Region. She called on District Commissioners to suggest a day for cleaning the tourist attractions including beaches and other islands for visiting tourists.

She called on District Commissioners to set a special day at the end of each month for cleaning tourist attractions in order to fight environmental destruction that could make the

tourist spots lose their pull. "Filth also threatens the health

for visitors especially those being served with food while on their way, hence cleanliness should be

stressed," she said. She said Zanzibar is among few islands that have greatly benefitted from the tourism sector, an important sector that contributes

30 per cent to its national income.

She however praised Zanzibar Organisation Empowerment for making the youth obtain employment as well as employing themselves, including investors in the tourism sector for enabling the cleanliness campaign in tourist attraction areas that would be sustained countrywide for developing and supporting efforts towards the blue economy.

TVLA wins tribute from parliamentary committee

THE Parliamentary Committee on Agriculture, Livestock and Water has commended Tanzania Veterinary Laboratory Agency (TVLA) operations, calling on the government to increase the agency's budget for more efficiency.

Members of the committee were of the opinion that the government need to invest fully in the agency to enable it produce more vaccines and save the livestock sector in the country.

Speaking after the agency's presentation about its operations and the future plans, TVLA acting Chief Executive Officer, Dr Stella Bilangi said the law makers were of the opinion that the government should do a lot more to increase vaccines and enable farmers access services.

Committee chairperson, Dr Christine Ishengoma noted that improving animal health is a crucial matter since animal diseases can also affect human beings.

"As we boast of having big number of livestock in the continent, it is also important to consider health of the animals," she said, adding that Tanzania should be one of the leading countries in exportation of animal products.

She also expressed the need for the government optimism to invest more money in the agency so that it can do research in terms of making new vaccines.

Muleba North MP, Charles Mwijage while speaking at the meeting argued that there is need to look at the health of animals that Tanzanians keep, saying that Tanzanian livestock are much lower in health than those from the neighbouring country.

He said TVLA should request for more money to ensure it produces vaccines that cover the whole country. "You should ask

the government to give you 10bn/in order to produce vaccines that can serve animals in the whole country," he said.

Earlier, while presentation before the Members of Parliament TLVA acting CEO, Dr Bilangi said the agency was asking for 2bn/- from the government.

She said if approved, the amount would enable the agency produce vaccines enough to cover 40 per cent of all animals in the country.

Dr Bilangi noted that the Agency $was formed \, by \, merging \, the \, Central \,$ Veterinary Laboratory (CVL), Tsetse and Trypanosomiasis Research Institute (TTRI), Tsetse and Trypanosomiasis Research Centre (TTRC) and laboratory activities of seven zonal Veterinary Investigation Centres (VICs).

TVLA has by now a total of 12 centres following theestablishment of a new Sumbawanga TVLA Centre in West Southern Zone.

The other 11 centres are, Centre for Infectious Diseases and Biotechnology (CIDB), the Central Veterinary Laboratory (CVL), Tanzania Vaccines Institute (TVI), TVLA Arusha, TVLA Dodoma, TVLA Iringa, TVLA Mtwara, TVLA Mwanza, TVLA Tabora, VVBD Kigoma and VVBD Tanga.

According to the TVLA animal health is crucial in the process of modernising the livestock sector in Tanzania.

She added that the existing and newly emerging livestock diseases, which impede livestock development need to be identified and controlled.

She said TVLA make sure that the core functions and roles of improving animal health and productivity by ensuring delivery of quality laboratory diagnostic services, enhancing vaccine production and distribution, performing animal feeds analysis and conducting animal diseases research.

for sisal cultivation in the entire Morogoro Region, but it was abandoned for many decades but following government's intervention, the crop is now back in the limelight," he said.


Kumbona said due the crop's importance in the country, its stakeholders have met with various government officials in the district to discuss on how best to revive the crop and become widely cultivated.

"The purpose of bringing women together here is to provide education on entrepreneurship as well as empowering them with better understanding on land and property ownership for women,"

he said.

community development officer from Arusha Council Angela Mvaa described women as one of the groups which for years were marginalized when it comes to accessing loans as financial institutions demands collaterals.

Lack of these collaterals was denying women to get loans that is why the government directed councils to allot 10 percent of their revenue collections for the marginalized groups such as

women, youth, and people with disabilities. In the arrangement, from ten percent women get 4 percent, youth (4 percent) and the disabled (2 percent).

"So, it is high time for you (women) to effectively use land economically. But, you should ensure that the piece of land you have is formalised," Angela suggested.

She however encouraged women to use loans wisely and in line with the project writeups.

Over 7 million poor people set to benefit from PSSN support

A TOTAL of 1,400,000 households are expected to benefit with the second phase implementation of the second part of the Productive Social Safety Net (PSSN II) under the Tanzania Social Action Fund (TASAF).

Deputy Minister in the President's Office (Public Service Management and Good Governance), Deo Ndejembi told the National Assembly that under the selected households, more than seven million poor Tanzanians will benefit.

Ndejembi was responding to a question from Special Seats MP, Neema Lugakingira (CCM) who was concerned that some registered beneficiaries of the programme in Bukoba municipal council are not qualified. She also wanted to know the exact objective of the programme.

Ndejembi said a total of 1,100,000 poor households have been registered for the PSSN II programme in the third phase, which will go until 2023. In Kagera Region a total of 68,915 poor households have been registered.

He said the objectives of the TASAF programme are to assist poor households to graduate from poverty in all the district councils in Tanzania mainland and Zanzibar. He said the TASAF's first phase was implemented between 2000 and 2005, second phase started in 2005 to 2012 and the third phase was implemented from 2013 to December, 2019.

The Deputy Minister added that TASAF beneficiaries will now start receiving their payments electronically; a move which is aimed to curb ghost recipients.

He said implementation of

the second phase of the TASAF's Productive Social Safety Net (PSSN) is going to phase out the cash payment system to poor households whereby the beneficiaries will be receiving their monies through mobile phones or bank accounts. He said the adoption of the e-payment initiative is going to address several challenges encountered during the cash payment system.

He said they have so far successfully registered beneficiaries in 39 district councils and that all the 189 district councils across the country will be registered to start receiving their payments electronically.

Launching the second phase PSSN programme in Dar es Salaam in February this year, President John Magufuli directed authorities to make sure that they supervise well and control enrolment of 'phantom' beneficiaries.

Magufuli said that the verification exercise conducted from November 2015 to 2017 found a total of 73,561 ghost and illegible households being enrolled in the programme.

"The involved people are not poor and some leaders are being enrolled in the programmes, this should be addressed, the next phase has to ensure that all these challenges do not exist," he said.

PLANS are underway for the construction of a 45km road from Masasi to Nachingwea at tarmac level, Works and Transport deputy minister Godfrey Kasekenya has told the National Assembly.

Eng Godfrey Kasekenya said that already, the government in the 2020/21 financial year allocated 1.45bn/- for the implementation of the project.

He said as the government continues mobilizing funds for construction of the 45 kilometers at a tarmac level, the ministry would continue allocating budget for maintenance of various roads.

In the 2020/2021 financial year, the government allocated 232.6m/- for maintenance of the road so that it is passable throughout the year, he said.

He was responding to a question by Nachingwea MP, Amandus Chikuwile who asked about the government's plans to construct the road at tarmac level, to ease movement of people, goods and minister said the government parts of Mtwara and Lindi regions.

In another development, the government will continue increasing the budget for Vocational Education Training (VETA), Institutions Parliament was told yesterday.

Deputy Minister of Education, Science and Technology Omar Kipanga made the assurance in the house yesterday as he was responding to a question by Special Seats MP Regina Qwaray who asked of plans to increase the budget for vocational training institutes in Manyara Region.

High Court orders sale of 4 hotel plots, spend proceeds on employees' salaries

Judge Gwae gave the ruling at the sitting of the Arusha Region's High Court Labour Division sub Registrar during which he asked the National Bank of Commerce advocate Wilbard Massawe whether there was any objection in regard to property earmarked to be auctioned, to which Massawe said there were no objections, since, he added, NBC will receive the remaining sum of money from auction sale after workers are paid.

Conserving indigenous food resources will ease stunting

reduced growth rate in human development. It is a primary manifestation of malnutrition or more precisely undernutrition and recurrent infections, such as diarrhea and helminthiasis, in early childhood and even before birth, due to malnutrition during fetal development brought on by a malnourished mother. The definition of stunting according to the World Health OrganiSation (WHO) is for the height for age value to be less than two standard deviations of the WHO child growth standards median.

As of 2012 an estimated 162 million children under 5 years of age, or 25 per cent, were stunted. More than 90 per cent of the world's stunted children live in Africa and Asia, where respectively 36 per cent and 56 per cent of children are affected. Once established, stunting and its effects typically become permanent. Stunted children may never regain the height lost as a result of stunting, and most children will never gain the corresponding body weight. Living in an environment where many people defecate in the open due to lack of sanitation, is an important cause of stunted growth in children, for example in India.

Former Prime Minister Mizengo Pinda has said that the only way to address the serious problem of malnutrition which threatens the well-being of the country at the moment is to encourage the cultivation of nutritious crops to reduce stunting from 32 to 24 per

Pinda made the call this week when he speaking at the pan-African summit aimed at exploring the role of traditional

He said that in order to reduce thinning to less than five per cent, the rate set by the World Health Organisation (WHO), there is a need to increase production of horticultural products from 7,230,217 tonnes to 14,600,000 tonnes by 2025.

"If we're to achieve these goals, we need to identify a number of factors, including capacity building of local government and private institutions to reduce the cost of certification of exports, especially vegetables, whose main investors are women and youth," the ex-premier said.

Three million children of the same age are Vitamin A deficiency-a leading cause of preventable blindness in children and increase the risk of disease and death from severe infections such as diarrhoeal disease and measles

Land rights for women vital for African development

WNERSHIP is the or fact of exclusive rights and control over property, which may be any asset, including an object, land or real estate, intellectual property, or until the nineteenth century, human Ownership involves multiple rights, collectively referred to as title, which may be separated and held by different parties.

The process and mechanics of ownership are fairly complex: one can gain, transfer, and lose ownership of property in a number of ways. To acquire property one can purchase it with money, trade it for other property, win it in a bet, receive it as a gift, inherit it, find it, receive it as damages, earn it by doing work or performing services, make it, or homestead it. One can transfer or lose ownership of property by selling it for money, exchanging it for other property, giving it as a gift, misplacing it, or having it stripped from one's ownership through legal means such as eviction, foreclosure, seizure, or taking. Ownership is self-propagating in that the owner of any property will also own the economic benefits of that property.

Despite recent advancements in land reforms across Africa, women and girls are still hugely disadvantaged, according to a recent meeting of experts. The 2020 Africa Land Forum (ALC), which took place online between 15 and 17 September last year, brought together 500 participants to explore the theme 'Delivering on the African Union Agenda 2063 by Promoting People-Centered Land Governance in Africa'.

Discussions revealed that when it comes to land rights the issue of inclusion and gender equality is still a massive challenge on the continent, and while women continue to provide the largest portion of agricultural labour across Africa, they do not benefit from an equitable, secure land tenure system.

In 2015, the African Union (AU) Commission, the United Nations **Economic Commission for Africa** and the African Development Bank launched a campaign to ensure that 30 per cent of the land in Africa is in the hands of women by 2025. Improving women's access to and ownership and control of land is crucial if African countries are to meet a number of Sustainable Development Goals by 2030, ranging from Goal 1 on poverty eradication to Goal 5 on gender equality to Goal 8 on decent work.

There is little continent-wide data regarding land ownership, but according to a 2018 working paper from the World Bank, based on data representing more than three-quarters of Africa's population, just under 13 per cent of African women (aged 20-49 years) claim sole ownership of land, compared with 36 per cent of African men. And when it comes to joint ownership, just 38 per cent of African women report owning any land (alone or jointly), compared with 51 per cent of African men.

A lack of access to land leaves women and girls at the mercy of a highly patriarchal system, deepening gender inequality and severely curtailing their social, economic and political progress.



■IVE years after the Agreement, Paris India is among the few developing countries that are not only meeting their "green" targets but also aspiring to more ambitious climate goals.

At the recent Climate Ambition Summit, Indian Prime Minister Narendra Modi articulated the country's approach. He said that we must set our sights "even higher", even as we do not lose sight of the past. He added that India would both achieve and exceed its Paris Agreement targets.

At the UN Climate Action Summit in 2019, Modi said that an ounce of practice was worth more than a ton of preaching.

He said India was taking practical steps across all areas, including energy, industry, agriculture transport, protection of green spaces, in its whole-of-society journey to become a leader in climate action and climate ambition.

India recognises that climate change cannot be fought in silos - through singlehanded or isolationist efforts. It requires an integrated, comprehensive and holistic approach.

It requires innovation and adoption of new and sustainable technologies. Conscious these imperatives, India has mainstreamed climate in its national development industrial strategies.

Energy is at the centre of all climate strategies - and we believe that India has become a clean energy powerhouse and

Moving beyond Paris: India steps up its climate ambitions

is a leader in energy transition from carbon dioxide-producing sources to renewables and nonfossil-fuel sources.

We intend to keep harnessing energy India's renewable potential. Our renewable energy capacity is the fourth largest in the world and the capacity expansion being undertaken is also one of the largest in the world. The bulk of this will come from the cleanest energy source - the sun.

We are already seeing progress. We initially committed to 175 GW of renewable energy capacity by 2022. We have gone further and expect to cross 220 GW in the next two years. We have an even more ambitious target of 450 GW by 2030.

We are working to ensure that 40 per cent of electric power in India is from non-fossil fuel sources by 2030. This clean energy push goes hand in hand with a parallel effort to reduce the emissions intensity of our economy by between 33 and 35 per cent (from 2005 levels) by 2030.

The Ujjwala scheme - a national drive to use LED (light-emitting diodes) lamps - is reducing carbon dioxide emissions by 38.5 million tonnes every year. The scheme, under which over 80 million households have been provided with access to clean cooking gas, is one of the largest clean energy initiatives in the world.

sustainability is being brought into government schemes across multiple sectors. Our Smart Cities Mission is working with 100 cities to help them become more sustainable and adaptable to the challenges of climate change. The National Clean Air Programme is meant to reduce air pollution (PM2.5 and PM10) by 20-30 per cent in the next four years.

The Jal Jeevan Mission, which seeks to provide safe and adequate drinking water through individual household tap connections by 2024 to all households in rural India, has a strong sustainability focus.

More trees are being planted and degraded land is being reclaimed to create a carbon "sink" that can absorb between 2.5 billion and 3 billion tonnes of carbon dioxide.

We are also working rapidly to create a green transport network, chiefly with a view to offsetting a sector notorious for its polluting emissions - particularly in our big cities.

building next-India is generation infrastructure, including mass transit systems, green highways and waterways. A national electric mobility plan is creating an e-mobility ecosystem with the aim of ensuring that over 30 per cent of all vehicles on India's roads are electric.

These initiatives are for our own good, as India is among the countries most vulnerable to the impact of climate change.

We recognise that there is still a long way to go, but these efforts are already paying dividends. India's emission intensity has dropped by 21 per cent over the period 2005-2014. We expect even greater reductions over the next decade.

India intends to be a responsible global citizen in the climate space. We are not only going beyond our Paris Agreement commitments. We are adopting innovative instruments to further international cooperation in climate action.

We have created international organisations such as International Solar Alliance and the Coalition for Disaster-Resilient Infrastructure that are working on creating global low-carbon pathways. More than 80 countries have joined the ISA, making it one of the fastest-growing international bodies.

This combination of national responsible action and international citizenship makes India unique among developing countries and is placing it on the path to the realisation of its ambition of becoming a leader in thought and action on climate.

China, US urged to focus on cooperation, manage differences to restore ties

BEIJING/WASHINGTON

Γ was a warm spring day 50 years ago. At China's invitation, a flight with nine U.S. table tennis players on board just landed at the Beijing airport, marking a thaw between China and the United States, which had been at loggerheads for more than two decades.

Starting with what came to be known as "Ping-Pong diplomacy," China and the United States have built one of the world's most important and intertwined relations from almost scratch over the half a century.

However, while people of the world were increasingly counting on and benefiting from China-U.S. cooperation, the former U.S. administration launched relentless assault on bilateral ties, plunging them into historic low and wiping out efforts of generations on both sides within just four years.

Now, as Joe Biden assumed the helm of the United States amid the still raging COVID-19 pandemic, China-U.S. relations are ushering in another critical moment when constructive cooperation between the two countries has never been of more urgency and significance.

ANOTHER CRITICAL JUNCTURE

The past four years have seen the U.S. government under the leadership of former President Donald Trump stretch China-U.S. relations to the limits too many times.

To contain the development of China, Washington's imaginary challenger to its hegemonic position, the United States, typically portraying itself as the champion of freedom and equality, became the very force trampling on those values

Under the pretext of reducing bilateral deficit, Washington slapped tariffs on tens of millions U.S. dollars of products coming from China, initiating trades wars in a bid to maintain its economic dominance, which however incited widespread backlash from its trade partners and created a drag on its domestic economy.

"The trade war with China hurt the U.S. economy and failed to achieve major policy goals," a recent study commissioned by the U.S.-China Business Council said. The study also indicated that the trade war reduced economic growth and cost the United States 245,000 jobs.

Suffering from paranoia about a rapidly developing China, some block-headed politicians with win-or-lose mentality have been going to great lengths to suppress China, resorting to the old tricks of isolation they played during the Cold War, despite the fact that the world has been moving steadily toward a community with a shared future for humankind.

They expelled Chinese companies no matter how many job these companies have created for local communities, they slandered Chinese government based on rumors and groundless accusations, they interfered in the internal affairs of other countries despite protests and oppositions, and they tried to totally decouple with China no matter how



deeply intertwined the two countries have become.

Time and time again, these politicians have proved how short-sighted they were as they were obsessed with building walls, cutting ties, breaking promises and quitting treaties in a world of inclusiveness and openness.

While the Trump administration has now stepped down from the historical stage, the wounds and losses it inflicted are surely to linger long, among which were the already battered China-U.S. relations and the worn U.S. authenticity.

Forty-two years on, bilateral ties are now standing at another critical junc-

COOPERATION IN URGENT NEED

While the challenges to bilateral relations posed by the former Trump administration have been unprecedented in decades, so has the urgency for the two countries to bring the derailed relations back on the track of healthy and stable development.

If the past is any indication, no coun-

were still in plight. Cooperation and solidarity have always been the key to resolving common challenges in hu-

man history.

During the 1997 Asian financial crisis and the 2008 global financial crisis, China and the United States stayed in close cooperation with the rest of the world and made significant contributions to safeguarding international financial stability and jump-starting global recovery.

In 2014, in joint efforts to fight the Ebola virus in Africa, China and the United States also forged close partnership in treating patients and directing medical supplies, which played an important role in turning the tide against the deadly virus.

As the world is still wrestling with once-in-a-century pandemic which has already infected more than 100 million people, killed over 2.3 million and throttled global economy, the cooperation between China and the United States, the world's two largest economies, in navigating the world try could stay unscathed while others out of the mess has never been more uncertainties still loom over the pros-

Cooperating with China would also be a wise and rational choice for the United States per se, as the Biden administration is leading the U.S. people to fight for the resumption of normal life and recovery of economy from the

"In fact, China can be part of the solution to help the U.S. combat the pandemic and revive its economy,' Zhu Zhiqun, a professor of Political Science and International Relations at Bucknell University told Xinhua.

WAY OUT OF DEADLOCK

In a phone conversation on Saturday between senior Chinese diplomat Yang Jiechi and U.S. Secretary of State Antony Blinken, China and the United States have made it clear that they recognize the importance of bilateral ties, and are ready to develop "stable and constructive" bilateral relations, offering a little relief to people expecting a

pect of the two countries' ties, to find a way out of the deadlock, more concrete measures need to be taken to ease tensions and rebuild trust between the two sides.

While the Chinese government has pledged a stable and consistent policy toward the United States, Washington needs to put a hold on its hostile policies toward China, and correct its wrongdoings which have already dealt severe blows to bilateral ties.

First of all, the new U.S. administration should take a rational view toward the development of China, which is neither a process that can be stopped nor a threat to the international position of the United

With the purpose of creating better lives for its people, the Chinese government is willing to work with Washington to push the relationship forward along the track of no conflict, no confrontation, mutual respect and win-win cooperation.

Secondly, to enhance public foundation of bilateral ties, Washington needs to expand avenues for communication with Beijing, remove the stumbling blocks hindering peopleto-people exchanges, and restore normal interactions between the two sides.

Most importantly, the two should properly manage their differences, shift the focus of bilateral ties toward cooperation, and respect each other's core interests and major concerns, as well as the choices of political system and development path.

After returning from his historic visit to China in 1972, then U.S. President Richard Nixon said that with China, the United States shared a "common interest" that trumped the two states' ideological differ-

Japan vaccine czar outshines Suga to rise as potential successor

NE of them is a seasoned public communicator, as comfortable debating his Davos counterparts in English as he is explaining the potential side-effects of coronavirus vaccines. The other is Japan's prime minister.

Just as Yoshihide Suga is facing a pivotal moment in his premiership, he is finding himself being eclipsed by cabinet member Taro Kono, an outspoken politician appointed three weeks ago to lead an imminent vaccine rollout. Polls show Kono is already voters' favorite for premier, an ominous sign for Suga ahead of a party leadership vote in September that will determine whether he stays on or joins the long roster of short-lived leaders.

The contrast between the two has been on full display this month as Japan tries to turn the corner on record coronavirus cases and launch its vaccination program. Both efforts are crucial to keeping on track its plans to host the Summer Olympics from July in Tokyo.

Last week, Suga, 72, stumbled his way through a news conference, triggering social media jokes about his discomfort with what he told reporters was his first experience with a teleprompter. On the same day, Kono, 58, uploaded a video to Twitter that garnered about 400,000 views in which he smoothly explained the potential side effects of the vaccines ahead of a mid-February campaign.

"The Suga administration is seen as being a bit slow on the vaccine and virus policy in general," said Tsuneo Watanabe, a senior fellow at the Sasakawa Peace Foundation in Tokyo. "Sometimes you need a knack for moving things forward, and if you want to do that, Kono is the right person."

Suga has seen his support halved since taking office five months ago, as his emphasis on the economy jarred with voters more concerned about controlling the virus, while a series of scandals sullied his image. The latest included revelations last week the government was investigating tabloid allegations that Suga's businessman oldest son illicitly wined and dined Internal Affairs Ministry of-

Kono, a former foreign minister and defense chief, became the country's most-followed politician on Twitter over the weekend, adding to evidence he could be a strong election contender. His tally of more than 2.2 million followers edged above that of former premier Shinzo Abe on Sunday, the Nikkei newspaper reported, leaving Suga far behind, with less than 400,000.

Kono was also the public's top choice to become the next prime minister in a poll published by the Nikkei last week. About 25 percent of respondents picked him, compared with just 6 percent for Suga. Perhaps more importantly in the factional politics of the ruling Liberal Democratic Party (LDP), Kono enjoys the backing of one its most influential blocs.

While the public doesn't get to vote in the party elec-

tion, its preferences could sway members, with a general election due by October. Kono's public persona has found broader appeal with the younger generation, boosted by attacks on antiquated practices such as the custom of hand-stamping offi-

cial documents. For both politicians, much will depend on the virus in the coming months. A limited state of emergency has so far proved effective in bringing daily cases in Tokyo down to 276 on Monday, compared with a peak of 2,447 on Jan 7.

The son and grandson of high-profile LDP politicians, Kono attended the private Suffield Academy boarding school in Connecticut before en-

tering Georgetown University. After spending several years working at Fuji Xerox Co., he won election to parliament in a district next to his father's seat.

By contrast, Suga, the son of a strawberry farmer from a chilly northern prefecture, spent two years working part-time jobs in Tokyo after high school to save up his college entrance fees. He toiled his way from lawmaker's secretary to regional assemblyman before entering parliament, and has spent little time outside Japan.

Kono could be a rare Japanese premier who brings an international image to the office. The LDP has for decades chosen its leaders through consensus, seeking internal balance among its factions. That's often resulted in unpopular premiers, including Yoshiro Mori, now the head of the Tokyo Olympic organizing committee, who came under fire last week for disparaging remarks about

Kono has advocated cuts in health and social security spending, which has ballooned as the population ages. He has also shown willingness to make big decisions - last year canceling a US\$4 billion land-based ballistic missile defense project unpopular with local residents. It has since been replaced with a shipbased system that the Nikkei newspaper reported would cost even

more.

Suga, meanwhile, served as Abe's right-hand man for eight years and has pledged to continue his policies. The continuity helped send the Nikkei 225 Stock Average to an all-time high in dollar terms last month, even as the economy staggered back from the worst downturn on record. Suga added his own focus on pocket-book issues like mobile phone charges.

Hiroshige Seko, the LDP's secretary-general in the upper house of parliament, said in a Feb 1 interview that Suga was just being honest with the Japanese people.

"People often talk about communication. That's the kind of person Mr. Suga is. He's not good at making speeches, nor is he the type for performances," Seko said. "But in parliament, he's saying what he really thinks. He says he's doing everything he can, but it's not going well. That's why he has to apologize and ask for restraint from the people."

The West vs the Global South: You have the numbers. We have the money

VER the years, Turkey has survived three Coup d'état in which its military forces took power, in 1960, 1971 and 1980. The coup in 1997, was carried out in a "post-modern way", where generals sat down with the then prime minister, Necmettin Erbakan and forced him to resign. However the turning point in Turkey has been the failed coup attempt in July 2016, which has till date been one of the bloodiest coup attempts in its political history, leaving 241 people killed, and 2,194 others injured.

When the 134-member Group of 77, the largest single coalition of developing countries, was trying to strike a hard bargain in its negotiations with Western nations years ago, one of its envoys famously declared: "You have the numbers. We have the money."

But that implicit threat- signifying the power of the purse- did not deter the G77 from playing a key role in helping shape the UN's socio-economic agenda, including sustainable development, environmental protection, universal health care, South-South cooperation, eradication of extreme poverty and hunger-all of them culminating largely in the 17 Sustainable Development Goals (SDGs) adopted in 2015 and targeted for a 2030 deadline.

The People's Republic of China, the world's second largest economy after the US, has remained an integral partand a strong supporter- of the G77, going back to the historic 1992 Earth Summit in Rio.

At that summit meeting - which marked a battle between the West and the global South over funding to promote development while protecting the environment – a G77 delegate told his colleagues in a closed-door gathering: "We have to confront them with an iron fist cloaked in a velvet glove."

The G77's strength in numbers—with over two-thirds of the UN's 193-member states –provides it with an unparalleled political clout ranking ahead of the Non-Aligned Movement (with 120 members), the Organization of Islamic Cooperation (57), the Asian Group (55), the African Group (54), the Latin American and Caribbean Group (33) the European Union (27) and the Eastern European Group (23).

While the G77 focused on achieving sustainable development, NAM pursued the hard-core politics of the global South, including human rights, neo-colonialism, international security, military conflicts and UN peacekeeping.

Speaking from Beijing, Dr Palitha Kohona, Sri Lanka's ambassador to China, told IPS that while many countries in the Western camp have tended to dismiss the G77 and China as irrelevant to contemporary economic/political developments, the Group has provided the platform for developing countries to make a profound input to contemporary global economic policy formulation.

In its heyday, he pointed out, the G77 and China contributed significantly to the development of the New International Economic Order (NIEO) and the Law of the Sea regulatory framework.

"Today, the Law of the Sea Convention is considered to be the Constitution of the oceans and seas," said Dr Kohona, a one-time Chief of the UN Treaty Section and a former Permanent Representative of Sri Lanka to the United Nations. More recently, he noted, its influence on the Rio Process, the conventions on Climate Change, Biological Diversity, Hazardous Wastes, Ozone, the Millennium Development Goals (MDGs) and Sustainable Development Goals (SDGs) has been seminal.

He said the G77's influence on global policy development in these major areas of importance to humanity remain undiminished and cannot be underestimated.

"These global rules are now impacting on policy formulation in the Bretton Woods institutions as well", he added. The role played by individual intellectual giants from the developing world in highlighting the G77 and China

needs to be acknowledged, he argued. "Today China has assumed a lead role in addressing the challenge of climate change affecting the very survival of humanity," he declared.

Mourad Ahmia, Executive Secretary of the G77, told IPS the integral role played by the Group in economic diplomacy and projecting the development interests of the global South is a testimony to its continued relevance in the ongoing global development

When it was established on Jun. 15, 1964, the signing nations of the wellknown "Joint Declaration of Seventy-Seven Countries" formed the largest intergovernmental organisation of developing countries in the United their collective interests and common development agenda.

Trade volume between China and 17 CEECs exceeds 100 bln USD for first time

RADE volume between China and 17 Central and Eastern European countries (CEECs) reached \$103.45 billion in 2020, passing the \$100-billion mark for the first time, according to data from China's Ministry of Commerce (MOC).

The trade figure represented a year-on-year growth of 8.4 percent, higher than the growth rates of China's foreign trade and the country's trade with Europe last

Since the establishment of the China-CEEC cooperation mechanism in 2012, China and 17 CEECs have enjoyed an 8-percent average annual growth rate in foreign trade, which is over three times the growth rate of China's foreign trade and more than twice that of the trade between China and the European Union (EU), said Gao Feng, spokesperson of the MOC at a recent regular press conference of the ministry.

Besides foreign trade, investment cooperation between China and CEECs has also seen continuous progress. Data from the MOC shows that as of the end of 2020, China's industry-wide foreign direct investment in 17 CEECs totaled \$3.14 billion, covering such sectors as energy, mining, infrastructure, logistics, and automobile parts.

During the same period, the 17 CEECs invested \$1.72 billion in China accumulatively.

In addition, connectivity between China and CEECs has been improved constantly. Last year, China-Europe freight trains made a total of 12,400 trips, with such countries as Poland, Hungary, the Czech Republic, Lithuania, and Slovakia becoming important passages and destinations of the freight trains.

In 2020, Chinese companies signed \$5.41 billion worth of project contracts with the 17 CEECs, up 34.6 percent from 2019.

According to the MOC, Ningbo city in east China's Zhejiang province has made active efforts to advance the construction of the China-CEEC demonstration zone for economic cooperation and trade in Ningbo, making CEECs its priorities in further expanding opening-up; Cangzhou city in north China's Hebei province has established the China-CEEC SME Cooperation Zone to boost cooperation between the two sides in fields including aviation, agriculture, and high-end manufacturing; and northeast China's Liaoning province has been actively building the coastal economic belt China-CEEC demonstration zone for economic cooperation and trade.

China is ready to make joint efforts with CEECs to further unleash the potential of cooperation and bring their economic and trade cooperation to a higher level, Gao said.

African ministers meet with IMF and ECA on immediate economic response to COVID-19

ADDIS ABABA

THE Executive Secretary of the Economic Commission for Africa (ECA), Vera Songwe has met with African ministers in charge of finance and the managing director of the International Monetary Fund (IMF), Kristalina Georgieva, to discuss immediate economic response to the COVID-19 pandemic.

During the virtual meeting, which was convened by the ECA and IMF, the ministers were unanimous in their call

for additional liquidity, \$500 billion in Special Drawing Rights (SDR), better market access, more concessional resources and an extension in the Debt Service Suspension Initiative (DSSI), given the prolonged nature of the pan-

"We all know that the COV-ID-19 pandemic will persist for the next 2-3 years. Why are we extending the DSSI for 6 months and not 24 months?" said Ken Ofori-Atta, Ghana's Minister of Finance and Eco-

nomic Planning.

Ofori-Atta said the cascading effects of COVID-19 were "a frightening thing for a finance minister to witness when they don't have the means to respond."

On access to the markets, Egypt's Minister of Finance, Mohamed Maait, said "there's a strong case for vulnerable countries to access the markets at affordable rate to afford essentials such as PPEs and food for their populations."

Equitable access to COV-ID-19 vaccines was highlighted as an imperative for building forward better.

"The world stands to lose an estimated \$9 trillion if only the rich get COVID-19 vaccines. 40 per cent of this loss will be in advanced economies," said

Georgieva. In addition to vaccine availability, ECA's Executive Secretary, Vera Songwe, stated that the issue of distribution and deployment were also worthy of serious attention. And for this reason countries needed additional fiscal space and less

Georgieva noted that in or-

der to build forward better, there is need for "bold and immediate action for response, recovery, and reset of African economies," adding "liquidity and financing response is the bridge to vaccines and recov-

The objective of the meeting was to "seek IMF support in forging a way out of the crisis by transforming existing liquidity instruments and easing market access to alleviate the debt burden and provide much needed liquidity for the continent," said Songwe.

Noting that Songwe's call together with Finance ministers' to triple concessional financing was "critical in the spring meetings' conversations last year," Georgieva urged the ministers to prepare for a focused and practical discussion during the 2021 spring meet-

"Now is the moment to demonstrate that SDR allocation can be part of a comprehensive support framework, together with debt reduction, debt relief and policy support actions in the countries," said

Minister Vera of Angola emphasised the importance of country reforms and in particular good governance reforms as an important component of the response and recovery plan. Angola she said she committed to continuing on its reform path.

The meeting agreed on the need for a concerted effort to accelerate reforms to increase revenues, improve expenditure and manage debt to attract more private sector investments into Africa.

South Africa reassesses its vaccine strategy: What you need to know

HE National Institute for Communicable Diseases (NICD) says levels of immunity, vaccination coverage and the impact of the 501Y.V2 mutation of the coronavirus, first identified in South Africa, are some of the key factors they are studying to determine the likelihood and severity of a third wave of coronavirus infections in the country.

Apart from population behaviour and adherence to non-pharmaceutical interventions such as the washing of hands, mask-wearing and social distancing; vaccination coverage, the NICD said, would play an important role.

"While there is considerable uncertainty regarding many of these parameters, another resurgence of SARS-CoV-2 is likely. Predicting the timing and scale of further resurgences is, however, difficult," the NICD said.

The co-chairperson of the Ministerial Advisory Committee on Covid-19, Professor Salim Abdool Karim, said on Sunday that South Africa was emerging from the second wave of infection with decreasing infection numbers across the board.

However, the country hit a major stumbling block last week when data from the South African trial examining the safety and efficacy of the AstraZeneca/Oxford vaccine, known as Covidshield, showed that it was not efficacious in fighting the new 501Y. V2 strain of the virus.

What vaccines will South Africa be procuring?

Apart from the one million doses of the Oxford/AstraZeneca vaccine already procured from the Serum Institute, the Minister of Health, Dr Zweli Mkhize, said the government was looking at procuring Johnson & Johnson vaccines through an implementation study, the Sputnik V vaccine from Russia, the Sinopharm vaccine from China, the Moderna vaccine from the US and also needed to explore the Novavax vaccine that is manufactured by a US company and has produced good results in a South African trial

What vaccines are on their way to South Africa through the Covax agreement?

The international vaccine alliance Gavi last week announced its allocation of additional doses of the Oxford/AstraZeneca vaccine as well as the Pfizer vaccine to qualifying countries, including South Africa through the Covax agreement.

Covax is the financial instrument used to pay for Covid-19 vaccines with the intention of making sufficient doses available to low and middle-income countries.

An additional 2.9 million doses will be made available to South Africa as well as 117,000 doses of the Pfizer vaccine.

What is South Africa looking for

in a vaccine? Karim said there is currently pub-







lished information on four of seven clinical trials and there are three levels of evidence available to show how well vaccines work against the 501Y.V2 variant. The variant is a mutation of the original virus that made it more transmittable.

AstraZeneca

The first level was laboratory tests. Here, he said, different vaccines were seeing "diminished neutralising activity" against the 501Y.V2 variant, meaning the vaccine must produce more antibodies to kill this mutation of the virus.

The next two levels are clinical trials. He said the Johnson & Johnson vaccine provided a reduced risk of mild and moderate disease against the 501Y.V2 variant but there was no data yet on the other vaccines.

AstraZeneca and Novavax trials have shown that clinical efficacy is diminished against the 501Y.V2 vari-

"We need the data on severe disease," Karim added.

What are the different types of vaccines that have data to show efficacy against the coronavirus?

Some of the vaccines are using novel technology to teach the body to attack the virus's spike protein.

This is the part of the coronavirus that attaches to human cells.

The messenger-RNA vaccines, Pfizer and Moderna, train the body to destroy the spike protein by using single-stranded messenger RNA. The body reads the RNA message and starts to manufacture the spike protein. This then prompts an immune response. The RNA does not alter the recipient's DNA.

The Oxford-AstraZeneca vaccine uses a double-stranded DNA code to deliver the message.

The vector used by the Johnson & Johnson vaccine was also used successfully in vaccines for the Ebola and Zika viruses. This vaccine also uses a double-stranded DNA code and is delivered to the body by a harmless modified virus.

Researchers have been working on mRNA vaccines for the past decade to develop a vaccine against can-

With the Novavax vaccine, the recipient is directly injected with the spike protein and a substance that boosts the body's immune response. This technology is also used in vaccines against whooping cough (pertussis) and diphtheria.

The Sinopharm vaccine uses an

inactivated virus. This technology is also used in the polio vaccine.

More than 40 vaccines are in the human trial phase around the world at the moment.

How well are these vaccines working against the original virus and against the 501Y.V2 mutation?

Karim said most of the vaccines worked well against the original virus. The Johnson & Johnson vaccine prevented clinically apparent Covid-19 in 66% of cases, Pfizer in 95%, Moderna in 94% and the Astra-Zeneca vaccine in 67%. The results looked even better for the prevention of hospitalisation and severe Covid-19. Johnson & Johnson showed 85% efficacy, Pfizer 90%, Moderna 100%, the Sinopharm vaccine 100% and the AstraZeneca/Oxford vaccine

All the vaccines showed diminished efficacy in preventing mild and moderate disease caused by the 501Y.V2 mutation. But the AstraZeneca/Oxford vaccine had the worst outcome, with only 22% efficacy. Johnson & Johnson showed 57% efficacy against the mutation and the Novavax vaccine 49%.

In laboratory tests, Pfizer showed a one- to threefold diminished efficacy, Moderna 6.4-fold and Sinopharm 1.6-fold.

What did the Oxford/AstraZeneca trial use?

The study tested the efficacy of the Oxford/AstraZeneca vaccine, known as Covidshield, on 2,000 "relatively young" healthy participants aged 18 to 65 with a median age of 31.

The main purpose of the study was to test the vaccine's safety and to see if it would protect the recipient against Covid-19 two weeks after the second dose.

The lead investigator in the Oxford/AstraZeneca trial, Professor Shabir Madhi, said the trial was not designed to determine whether the vaccine would protect against severe Covid-19.

He said the majority of people in the trial who got sick had mild to moderate disease.

Did the vaccine work against the 'original' coronavirus?

Madhi explained that most of the approved vaccines currently available were designed using the original coronavirus and created antibodies with "a great affinity" for the virus's

spike protein.

When the 501Y.V2 mutation was first identified in the Eastern Cape scientists discovered that its spike protein was different from that of the original virus and as a result, the vaccines became less effective.

Madhi said the Oxford/AstraZeneca vaccine had worked very well until the end of October and data from the trial showed that those who received it had a 75% reduced risk of being infected by the original virus.

"It showed tremendous potential to prevent infection, mild and moderate disease.

Why do the Oxford/AstraZeneca vaccine and others not work against the 501Y.V2 mutation?

Madhi explained that to ensure its survival the virus had to evade the body's immune responses. He said they discovered through experiments done in laboratories that the antibody produced by the vaccine was not "active" against 501Y.V2. Further data in human trials showed that the vaccine only offered a 22% lower risk of infection.

What data do we still need for the Oxford/AstraZeneca trial?

Madhi said the trial data does not yet tell investigators how well the vaccine protects against severe disease, hospitalisation and death.

Will we be able to use the Oxford/AstraZeneca vaccine at all?

Madhi said several studies were underway to investigate the use of this vaccine in combination with another. In the UK, he said, investigators are looking at combining the Oxford/AstraZeneca vaccine with the Pfizer vaccine as a second dose.

"It might well be that we will explore combining the Johnson & Johnson vaccine with the Oxford/AstraZeneca vaccine in South Africa," he said.

Madhi said that as South Africa expected another resurgence in the winter there should be a conversation on whether the country can afford to take the risk of not vaccinating those at high risk simply because there is uncertainty whether the AstraZeneca/Oxford vaccine will protect against severe disease.

"It will be reckless to discard a million doses of the vaccine while the probability exists that it can protect against severe disease, hospitalisation and death."

Karim said the "mix and match"

study in the UK would provide important clues. "Given that we will be vaccinating [some] people with past immunity it bodes well, but we need empirical evidence to assess if it can be done safely," he said.

What are the body's killer cells and why is their response good news for South Africa?

Madhi said that the data on the body's T-lymphocytes or killer cells gave grounds for optimism that the Oxford/AstraZeneca vaccines might protect against severe disease, hospitalisation and death due to Covid-19

T-cells kill infected host cells and activate other immune cells and are especially important to protect against severe disease. He said the body's T-cell response is largely unaffected by the 501Y.V2 mutation.

Why has the South African government decided to allow for an implementation study of the Johnson & Johnson vaccine?

Professor Glenda Gray, the principal investigator for the Johnson & Johnson Phase 3 Ensemble trial said their vaccine, administered as a single shot, does not protect against "the sniffles" but has a high efficacy against severe disease and death, also for the 501Y.V2 variant.

One of the strengths of the vaccine is that it was tested in a large trial of 43,783 people in the US, South America and South Africa. Around a third of the participants were older than 60, 19.6% were older than 65, 3.5% were older than 75 and 1% were older than 80. Many of the participants also had comorbidities: 28.5% were obese, 7.3% had type 2 diabetes, 10.3% had hypertension and 2.8% had HIV. Gray said the study had included others with compromised immune systems.

She said their trial was conducted at a time when infections were very high and new variants of the disease were emerging.

She said investigators saw efficacy after 14 days and an increase in immune response through to day 56 after the vaccination.

The data showed the vaccine provided high levels of protection against severe disease and hospitalisation (77% after a week and 85% after 28 days) - and it showed a 57% efficacy against the 501Y.V2 variant.

Has the vaccine been approved by Sahpra?

Gray said there is a rolling submis-

sion before the South African Health Products Regulatory Authority (Sahpra) and the investigators are adding data to it as it goes along. They have applied for emergency use of the vaccine from the US Food and Drug Administration as well as other international regulators.

What is an implementation

Both Gray and Karim stressed that there was an urgent need to further evaluate vaccines in large trials in South Africa to get more data.

Gray said they were in advanced negotiations to roll out the vaccine to South African health workers to evaluate its efficacy in the field.

"We can't wait. We already have good data," she said.

Does that mean that health workers will be guinea pigs for the vaccine?

Health Minister Mkhize has been adamant that allowing for the Johnson & Johnson vaccine to be rolled out in South Africa as part of an implementation study did not mean that doctors, nurses and other health workers would be used as "guinea pigs".

"The vaccine has already been proven to be safe and effective. We are doing something extra. It is not the same as the original trial. We will vaccinate everyone and monitor what happens.

"We know that a single shot will stop hospitalisations and death," Gray said. "We want to protect our healthcare workers. The quickest way to bring this vaccine to them is to use this programme."

What about the Novavax vac-

Madhi is also the principal investigator in the Novavax vaccine trial. He said this trial showed that past infection with the original coronavirus did not protect against mild and moderate infections with the 501Y. V2 mutation.

However, he said this vaccine, that is a different type of vaccine from the Oxford/AstraZeneca one but was tested in a similar demographic, showed a 60% reduced risk against mild and moderate disease.

Will the existing vaccines be adapted to fight the 501Y.V2 vari-

Karim said new vaccines are being developed to accommodate this mutation.

Will the virus mutate again? Madhi said viruses do mutate,

sometimes by accident and sometimes to ensure their survival in populations where a high level of infection had occurred.

The NICD said that expert laboratories throughout South Africa are increasing their sequencing capacity and monitoring the 501Y.V2 virus in real-time.

"For example, the detection of the variant currently prevalent in the United Kingdom has now also been identified in South Africa. Ongoing mutations are expected and we expect the virus to evolve over time, the 501Y.V2 lineage to change, but also new lineages to emerge.

"Positive cases identified throughout the country are analysed daily and weekly. We review exactly these details to assess how the epidemiology of the disease is changing.

"Currently, rates of disease are stabilising or decreasing in most provinces. We will continue to monitor these data to identify any new changes or clusters of disease over the next weeks and months," the NICD said. DM/MC

New bid to place digital lenders on CBK watch

NAIROBI

THE Central Bank of Kenya (CBK) will license all mobile loan providers if Parliament passes a proposed law seeking to weed out predatory lending.

Digital lenders without operating licences will be barred from business in a bid to push out rogue players amid concerns of unethical practices such as over pricing of loans, illegal mining of customer private data and shaming of borrowers who default on repayment. The Central Bank of Kenya (Amendment) Bill of 2020, if passed, will also compel the CBK to publish the names of all digital lenders every four months to review those that are compliant.

"The proposed amendment seeks to achieve the following objectives; prohibit any person, institution or firm form lending money to Kenyans unless licensed by the Central Bank of Kenya," says a notice of the Bill sponsored by nominated Member of Parliament Gideon Keter.

The CBK currently regulates banks and micro-lenders but the proposed changes will now grant it supervisory and licensing powers to oversee hundreds of digital lenders operating in the country. There has been a proliferation of digital lenders targeting the banked and unbanked alike, saddling borrowers with high interest rates and leaving regulators scram-

The digital lenders have been accused of listing individuals with credit reference bureaus (CRBs) over very small amounts and failing to reveal their terms and conditions that include lifetime of SMS notifications, full surrenders of their personal data to third parties and waiver of their right

Last year the CBK revoked the approval of digital lenders, barring 337 unregulated digital mobile lenders from forwarding the names of loan defaulters to CRBs. An internal memo showed that only 39 banks, 14 microfinance banks, 1,353 unregulated saccos, 164 regulated saccos were allowed to continue using the mechanism from the end of August.

Rising electric vehicle demand puts Africa on the cusp of a mining boom

JOHANNESBURG

AFRICA is about to experience a battery investment bonanza, necessitated by a mass transition to electric vehicles that will require large amounts of minerals.

As major car makers rev up their electric vehicle ambitions, demand for lithium, graphite, cobalt, copper, nickel and other metals - all crucial for batteries - is

The International Energy Agency expects EV sales to reach 44 million annually by the end of this decade. Demand for lithium is set to balloon to \$60 billion by 2025 from \$8bn in 2018, according to trade body United Nations Conference Trade and Development.

"It's crucial to remember that building and securing the battery supply chain, from mine to gigafactory is key," said Simon Moores, chief executive of Benchmark Mineral Intelligence, which monitors the metals supply chain. Last year, the UK set a target to ban new petrol and diesel vehicles by 2030. Mr Moores said in order to meet the demand for new vehicles, the country will need at least 4 large scale battery production factories.

"For its 4 gigafactories, the UK will need the equivalent of the half of all lithium produced in 2020, and more than the entire world's supply of graphite anode in 2020." Benchmark's research shows at least 175

battery super-factories have come online over the past five years, with more on the way. In 2020 alone, China announced another 38 battery plants, Europe two and at least three are planned for the US. This puts African countries in the front line to supply the raw materials.

"There's no other land mass that has such a large concentration of critical minerals," said Nechan Naiker, group chief executive of Megamillion, a Johannesburgbased lithium battery supplier. "Everything in the value chain is found in this

Zimbabwe has large quantities of lithium, northern Mozambique has some of the world's largest deposits of graphite, South Africa has the world's largest known reserves of manganese and platinum, as well as substantial nickel deposits.

Copper, another crucial mineral for electric vehicle production, is found in Zambia and the Democratic Republic of Congo (DRC). Cobalt, crucial to the current generation of battery technology is also produced in the DRC, which now accounts for 73 per cent of world production.

However, getting the minerals out of the ground will take time, and money, noted Mr Naiker. "The supply chain could kill this industry. You can build a beautiful factory, but without the supply chain in place, it's just a building."

Often, mines need to build not just their

own immediate operations, but support logistics and infrastructure such as ports, railways and power stations. Due to this, mining activities have tended to focus on high-value minerals such as gold and diamonds, or low-cost extraction base metals

such as iron ore and coal. Now, with demand for battery minerals set to grow exponentially, the economics of building extraction capacity has come into line. An example is AVZ Minerals, an Australian-listed company developing the Manono mine in southern DRC. The project will cost at least \$545 million and will be one of the world's largest producers of lithium. "This is the largest hard rock lithium deposit in the world," said AVZ chief executive Nigel Ferguson. "It's a world class project."

The mine is capable of meeting 25 per cent of Europe's current lithium demand, but will need substantial infrastructure investments to get the metal to market. Rail routes will have to be introduced to move product from the land-locked region to the coast at least 1,600 kilometres away.

The mine will also consume vast amounts of electricity to run its extraction plants to retrieve lithium from crushed ore. An old colonial era hydro dam is being completely refurbished to supply the needed electricity to the mine and to the surrounding commu-

"This will be enough to power our sulphate plants as well as one or two towns down the road," Mr Ferguson said. The mine will also deploy EV in its operations, to obviate the need for flying in diesel, at great cost. This, along with hydro power, will greatly reduce the mine's carbon footprint.

"From an operational view, we will be one of the greenest producers in the industry worldwide, Mr Ferguson said. In the meantime, analysts see a crunch in supply until production catches up, which in turn can drive up prices. According to Benchmark data, the price of battery grade lithium in China spiked 40 per cent, as consumers increased their purchase of EVs as they emerged from Covid-19 lockdowns.

Mixed reactions as Kigali reopens after three-week Covid lockdown

KIGALI

IT was a race against time for many businesses and shoppers in the capital Kigali on the evening of the first day of reopening following a three-week lockdown. The lockdown has been lifted and replaced with a raft of tough restrictions designed to help contain the spread of Covid-19, with businesses now required to close at 5p.m while curfew starts at 7p.m.

But some traders in downtown Kigali closed as early as 4p.m on Monday, to afford themselves enough time to go catch a bus and head home in time. At the Downtown Bus Terminal, passengers formed long queues awaiting buses, which are restricted to carry half their normal capacity to ensure social distancing onboard.

"The closing time is too early be-

cause that's around the same time we usually do business, that's when people are returning from office and come to shop," said Justine Ingabire, who deals in shoes close to the bus terminal. She added: "We are actually not waiting until 5p.m to close, most people are closing an hour earlier and then head down to the bus terminal, remember everyone is supposed to be home by 7p.m."

Another passenger, Elie Havugimana, who sells footwear for children on the same block, said he had served only one client the whole day as opposed to previously when he would attend to an average of 20 buyers a day.

"Clearly, we are still grappling with the effects of Covid-19. But this is necessary in the fight against the pandemic, our hope is that people comply with preventive measures against the virus so that business

hours can be extended as soon as possible," he told The New Times. Generally, there was minimal activity and movement on the first day of reopening in areas that are usually teeming with people and business activity.

Only few businesses like hair salons saw a huge turn up of clients. Business operators in the Nyabugogo, a major business hub for the city, told The New Times that they suspect most office employees worked from home on Monday given the reduced flow of shoppers.

Public offices remain closed with employees working remotely, while government has asked private employers to recall not more than 30

per cent of their staff to office and let the bulk of workers continue to work from home on any given day.

Traders in Nyabugogo, a key gateway to the city, also reckon that the ban on travel between Kigali and the countryside has also affected their business. Nyabugogo bus terminal is used by most commuters heading to or departing from the city.

Global health officials back AstraZeneca vaccine after SA study rings alarm

JOHANNNESBURG

HEALTH officials around the world gave their backing to the AstraZeneca vaccine against Covid-19, after a study showing it had little effect against mild disease caused by the variant now spreading quickly in South Africa rang global alarm.

The prospect that new virus variants could evolve the ability to elude vaccines is one of the main risks hanging over the global strategy to emerge from the pandemic by rolling out vaccines this year.

South Africa, where a new variant now accounts for the vast bulk of cases, initially announced a pause in its rollout of a million doses of the AstraZeneca vaccine.

Put it said on Monday it could still

But it said on Monday it could still roll it out in a "stepped manner", giving out 100 000 doses and monitoring it to see if it prevents hospitalisations and deaths.

"It is vastly too early to be dismissing this vaccine," said Richard Hatchett, CEO of the Coalition for Epidemic Preparedness Innovations, a foundation that co-leads the global COVAX programme to provide vaccine doses in poor countries.

More than 330 million doses of AstraZeneca's vaccine form the overwhelming majority of doses that COVAX aims to begin rolling out in a first phase in poor countries beginning as soon as this month. "Obviously the world is full of the wild type virus that this Astrazeneca vaccine is known to work against," Hatchett said.

Professor Salim Abdool Karim, co-chair of South Africa's Ministerial Advisory Committee on Covid-19, said it was too early to conclude that the AstraZeneca would not prevent serious disease caused by the variant prevalent there.

If the vaccine does not work well against new evolving variants of the virus, it could be an ominous sign for other vaccines as well, showing that the virus can potentially thwart the efforts of scientists to fight it.

The overall message from the World Health Organization and others was: don't panic.

Several global health officials noted that the South African study was small and had tested the vaccine using a short four-week interval between the first and second doses, despite evidence having since emerged that it works better if there is a longer wait.

It was becoming "more and more clear, the longer the interval between the two doses the higher the efficacy," said Kate O'Brien, head of immunisations at the WHO.

2021 air travel recovery at risk from new Covid mutations and restrictions

GENEVA

GLOBAL airlines could face a slower-than-expected recovery in travel demand this year as governments impose tighter travel restrictions to curb the spread of new Covid-19 virus strains, the industry's trade body said.

Passenger traffic may improve just 13 per cent this year, compared to 2020, in a pessimistic scenario where new travel restrictions persist, the International Air Travel Association (Iata) said. This contrasts with Iata's December forecast for a 50.1 per cent improvement in 2021 over last year.

Tough and persistent travel restrictions in response to virus mutations, pose a "severe downside risk" to Iata's forecast of a return this year to 50 per cent of pre-crisis passenger traffic levels. Should the lower estimate for a 13 per cent improvement materialise in 2021, that leaves the industry at 38 per cent of the prepandemic levels.

"Optimism that the arrival and initial distribution of vaccines would lead to a prompt and orderly restoration in global air travel have been dashed in the face of new outbreaks and new mutations of the disease," Alexandre de Juniac, Iata's director general, said. "The world is more locked down today than at virtually any point in the past 12 months and passengers face a bewildering array of rapidly changing and globally uncoordinated travel restrictions." For the Middle East, Iata had forecast back in December a passenger traffic recovery of 43 per cent in 2021 compared to 2020. But now there is potential downside risk from new travel re-

"What happened lately unfortunately is the rise of the [virus] variants and the quick actions by governments, exactly like a year ago, unilaterally closing borders, suspending flights and preventing people from moving again," Muhammad Al Bakri, Iata's regional vice president for Africa and the Middle East, said. "If countries continue to act in the same manner of closing borders and imposing harsh measures, we're back to the worst case scenario." The airlines' lobby body urged governments to work with the industry to develop standards for vaccination, testing, and validation that will boost confidence in re-opening borders.

In December, total traffic was 69.7 per cent below the same month in 2019, little improved from the 70.4 per cent contraction in November, Iata said.

Middle East carriers' annual passenger demand in 2020 was 72.9 per cent below 2019. Annual capacity fell 63.9 per cent.

Load factor, a measure of how well airlines can fill seats, plummeted 18.9 percentage points to 57.3 per cent, the lowest of all the regions. December's traffic was down 82.6 per cent compared to December 2019, improving from an 86.1 per cent drop in November.

Global air cargo fared better, decreasing 10.6 per cent in 2020 from a year ago. Still, this was the largest drop in year-on-year demand since Iata started to monitor cargo performance in 1990.

"Air cargo is surviving the crisis in better shape than the passenger side of the business," Mr de Juniac said. "For many airlines, 2020 saw air cargo become a vital source of revenues, despite weakened demand.

But with much of the passenger fleet grounded, meeting demand without belly capacity continues to be an enormous challenge."

Amazon buys 50 percent of Dutch offshore wind farm

AMSTERDAM

AMAZON will buy half of the energy produced by a huge offshore windfarm in the Netherlands to power its European operations, as the global tech giant looks to grow its renewables portfolio.

The Amazon-Shell HKN Offshore Wind Project is the company's largest single-site renewable energy project. The Seattle-based firm will buy its electricity from the Crosswind Consortium, which is operated by oil major Shell and Dutch firm Eneco. The proiect, which has an overall capacity of 759 megawatt is set for completion in 2024.

The deal will quicken Amazon's pledge to operate on 100 per cent renewables by 2025, five years earlier than the previous goal of reaching that target by 2030.

Amazon is making significant strides in clean energy and in December announced plans to add 26 utility-scale wind and solar energy projects with a collective capacity of 3.4 Gigawatts.

By the end of 2020, the company had 35 projects with 4GW of capacity in its portfolio. Amazon has invested in 6.5GW of wind and solar power plants that will supply clean energy to its corporate offices,

fulfilment centres as well as to data centres operated by Amazon Web Services. Amazon's investments in clean energy are in line with commitments made by other tech giants such as Facebook, which plans to reach net zero emissions by 2030.

US corporates have taken a strong stance on climate change, in the absence of policy directives by the previous administration of Donald Trump, which pulled the country out the Paris Agreement. companies made moves towards sustainability in the absence of government-led efforts to nudge corporates towards renewables.

US President Joe Biden is encouraging of such efforts, and plans to push for \$2 trillion-worth of clean energy investments. Anglo-Dutch oil major Shell has made its own commitments to energy transition by writing off \$22 billionworth of hydrocarbon assets and pledging net zero by 2050.

Its agreement with Amazon contributes to the company's pledge and progresses its momentum towards becoming "a netzero emissions business by 2050 or sooner", said Elisabeth Brinton, executive vice president of new energies at Shell.

Gold advances for the third day with stimulus, inflation in focus

GOLD climbed for a third straight day as investors weighed prospects for more stimulus in the US and the possibility of higher consumer prices against an advance in stocks to a record. The haven's steady rise came with traders keeping tabs on a roaring Bitcoin market.

The precious metal headed for the longest run of gains since January 5 after Democrats released the first draft of key legislation that will comprise President Joe Biden's Covid-19 relief bill. Bets on a robust package of support are helping to underpin market-derived inflation expectations, which are at multi-year highs, and have fanned the so-called reflation trade.

Bullion is rebounding after last week's retreat to the lowest level since the start of December, when a stronger dollar and rising US Treasury yields weighed on the haven asset that doesn't offer interest. A report on Wednesday is forecast to show US consumer prices rising at a quickening pace.

Leaving no one behind in continent's health battle

AFRICA'S top political grouping has vowed that no country will be left behind in the continent's collective response to the coronavirus pandemic.

Leaders of the African Union, meeting via video link over the weekend, made commitments to ensure that all members of the bloc are part of an African effort against the coronavirus, especially for the distribution of vac-

The key pledges were made on Saturday, during the assembly of heads of state and government for the 34th African Union summit. The event ended on Sunday.

At the meeting, the union committed to strengthen the collective response to the COVID-19 crisis, marshaling resources for the benefit of all.

Felix Tshisekedi, the president of the Democratic Republic of Congo, was selected as the success of the African Continental Free Trade incoming chairman of the African Union, tak-

ing over from Cyril Ramaphosa, South Africa's president. Tshisekedi applauded the ingenuity and resilience shown by African countries in the fight against the pandemic.

"Let us organize together, with our international partners, for a great offensive against these various scourges," Tshisekedi said. "It is imperative that our organization can strengthen the African Centre for Disease Control and Prevention in order to respond effectively to emergencies and complex health challenges, as a specialized technical institution of the African Union."

Action plan

While highlighting his plan of action during his mandate as chair of the union, Tshisekedi said the African Union can work with the continent's regional economic communities to strengthen peace and security.

He said the bloc can also help to ensure the Area, which started last month. Additionally,

it can promote a renaissance of African culture, arts and heritage.

"I promise that with the support of every one of you, we will take our organization out from the conference rooms, the hard drives of our computers and the well-crafted files of our secretariats, into the classrooms, the refugee camps, the markets of our cities and in the fields of our respective villages."

Ramaphosa highlighted the African Union's establishment of a COVID-19 response fund to raise resources for a continental vaccination response. He thanked African countries for being the first contributors to the fund.

"We established the groundbreaking Africa medical supplies platform to assist AU member states to access affordable medical supplies and equipment," Ramaphosa said.

"In establishing this platform, we have given practical meaning to the mantra we often repeat, that we are committed to developing African solutions to African problems."

Xi: China ready to cooperate with CEE countries on vaccine

BEIJING

CHINESE President Xi Jinping said yesterday that China stands ready for vaccine cooperation with Central and Eastern European countries (CEEC).

So far, Serbia has received 1 million doses of vaccines from a Chinese company, and there is ongoing cooperation between Hungary and Chinese vaccine companies, Xi said at the China-CEEC Summit held via video

China will actively consider such cooperation with other CEE countries if there is the need, he added.

Xi lauded the cooperation between China and Central and Eastern European countries (CEEC), saying that "17 plus 1 could make more than 18."

Xi made the remarks while delivering a keynote speech at the China-CEEC Summit held via video link.

China-CEEC cooperation is based on mutual respect

and has no political strings attached, Xi said, adding that all countries involved, regardless of their size, are equal partners in a cooperation mechanism featuring extensive consultation, joint contribution and shared benefits.

"Guided by the conviction that '17 plus 1 could make more than 18,' we have set up a multi-dimensional cooperation framework led by the leaders' summit and covering 20-plus sectors to ensure the participation of all CEE countries," he

Xi also said that cooperation between China and CEEC has developed some principles that **'17 plus 1 could make more** are reflective of its distinctive features and accepted by all parties.

> The principles are making decisions through consultation; delivering benefits to all cooperation partners; pursuing common development through openness and inclusiveness; and achieving bigger growth through innovation.

It is important for China and CEEC to deepen customs cooperation to ensure trade security and faster clearance, Xi said.

China will work toward the establishment of a China-CEEC customs information center and a focal point for customs and Eastern Europe the first clearance coordination for

countries along the China-Europe Land-Sea Express Line, Xi stressed.

"We could also explore cooperation on a pilot basis under the 'Smart Customs, Smart Borders and Smart Connectivity' Initiative," said Xi.

More imports from CEEC

China intends to import, in the coming five years, more than US\$170 billion of goods from CEEC, Xi said.

"We need to deepen agricultural cooperation, in a bid to double CEE countries' agricultural exports to China and raise two-way agricultural trade by 50 percent over the next five years," Xi said.

Today, trade between China and CEE countries is nearly 85 percent bigger than nine years ago, and the number of mutual tourist visits has grown nearly four times, noted Xi.

Xi added that the China-Europe Railway Express has reached most of the CEE countries, running more than 30,000 freight services so far.

Slapping sanctions on Kremlin officials 'nonsensical' – spokesman

MOSCOW

COUNTRIES who introduce sanctions against members of the Russian presidential administration are making a mistake, Kremlin Spokesman Dmitry Peskov said yesterday. He noted that the sanctions mechanism is a double-edged sword that causes damage to both sides.

"You know that in their sanctions hysteria, many countries even announced sanctions against the leadership of the [Russian presidential] administration. Of course, this is simply nonsensical, there's no other way to put it," the spokesman told reporters yesterday.

The spokesman commented on the joking statement made by Russian President Vladimir Putin, in which he said that some of his acquaintances get offended for not being included on the sanctions list despite being close to the Russian leader.

"As for the statement of the president, you realize that this is a figure of speech. And it is true, some joke about it," the spokesman said. "Other



members of the administration often joke and say that they feel uncomfortable when such important people [the leadership of the presidential administration - TASS] are under sanctions, and they aren't.

Those are just jokes, just a figure of speech." He added that practice shows that "more often, this is a doubleedged sword, which deals a blow not only to the interests of those falling under the restrictions, but of those who

introduce these restrictions as well."

"Sanctions can't be for the best. Sanctions are always bad," Peskov stressed.

"However, while being under some absolutely unlawful restrictions, we get an opportunity to mobilize our domestic resources and do what, perhaps, we would have needed much more time to do under normal conditions: establish our own production, our own electronic systems, strengthen our banking and financial infrastructure and so on." **Agencies**

WHO experts meet to review efficacy of AstraZeneca vaccine

EXPERTS from the World Health Organization (WHO) met on Monday to review the efficacy of the Oxford-AstraZeneca vaccine against COVID-19, after a study showed it was less effective against a new variant, according to WHO Director-General Tedros Adhanom Ghebreyesus.

Earlier on Sunday, South Africa, where the new variant, B.1.351, was found, announced that the rollout of the AstraZeneca vaccine in the country would be temporarily put on hold until more clinical efficacy information becomes available.

At Monday's WHO press briefing, Tedros said although the Oxford-AstraZeneca vaccine is one of the several that have been shown to be effective in preventing severe disease, hospitalizations and deaths from COVID-19, the emergence of new variants of the virus has raised concerns about their potential impacts on the efficacy of vaccines.

He announced that the WHO Strategic Advisory Group of Experts on Immunization (SAGE) has met to review the Oxford-AstraZeneca vaccine and discuss these new developments. Tedros noted that he will meet with the chair of SAGE on Tuesday to discuss its recommenda-

Also at the briefing, Kate O'Brien, director of the Department for Immunization, Vaccines, and Biologicals at the WHO, said SAGE had met with investigators from the trials being conducted in Britain and Brazil, as well as AstraZeneca and investigators from South African trials. In looking at evidence on the AstraZeneca vaccine across a number of trials, it is very clear that it has efficacy against severe disease, hospitalizations and deaths among different variants, said Dr. O'Brien, while admitting that "there are some indications of reduction in the efficacy, some more some less, depending on which variant, which population, and also the neutralizing antibody responses."

"But we also have evidence that there is the likelihood that the retention of meaningful impact against severe disease is a very plausible scenario for the product against the B.1.351 variant," she added.

O'Brien also noted that "we really have to sort of sail a steady ship, based on the preponderance of evidence and not lurch from one particular report or another re-

Meanwhile, the GAVI, a global Vaccine Alliance and a major player in the WHO-led COVAX initiative for COV-ID-19 vaccines, has decided to continue to roll out the AstraZeneca vaccine.

According to GAVI CEO Seth Berkley, the AstraZeneca vaccine is efficacious and has been reviewed and approved by a number of stringent regulatory authorities.

"Therefore we suspect that we will continue to roll that out, and we'll continue to follow the effects of that vaccine over time," Berkley said.

WHO has been pushing forward the COVAX initiative which is expected to include a large portfolio of COV-ID-19 vaccine products in the future.

Last week, China decided to provide 10 million COV-ID-19 vaccine doses to COVAX in response to the urgent needs of developing countries.

According to WHO Chief Scientist Soumya Swaminathan, China has several vaccines under development and

the WHO is speaking with all the developers. *Xinhua*

Myanmar inoculations move ahead despite unrest **By Yang Han**

MYANMAR'S efforts to control the spread of COVID-19 have got back on track with the resumption of its vaccination program despite political unrest and street protests.

Myanmar approved Russia's Sputnik V vaccine on Saturday, making it the first country to do so in Southeast Asia, said a statement issued by the Russian Direct Investment Fund (RDIF), Russia's sovereign wealth fund that supports the development of the vaccine.

"Myanmar has become the 21st country in the world to approve Sputnik V," the RDIF said.

The country recorded 54 new cases on Sunday, bringing its total tally to 141,423, a release of the country's Ministry of Health and Sports said.

Though the country entered a yearlong state of emergency on Feb 1, Myanmar resumed the vaccination program against COVID-19 across the country on Friday.

On Jan 27, the country began vaccinating more than 103,000 frontline medical staff and volunteers, in the first phase of its vaccination program.

The country will strengthen existing COVID-19 containment methods and continue the ongoing vaccination program, said government officials. It will also try to buy more vaccines through bilateral commercial arrangements and the global vaccine sharing initiative COVAX.

China expressed its support for Myanmar's COVID-19 fight. Chinese Foreign Ministry spokesman Wang Wenbin said in a news conference last week that China is providing vaccine aid to Myanmar and a dozen other countries.

CHINA recently announced to increase the forest stock volume by 6 billion cubic meters from the 2005 level by 2030 to contribute more to tackling the global climate

This message excited Zhang Guobin, a researcher of the ecological conservation and restoration department under China's National Forestry and Grassland Administration (NFGA). "Forest carbon sinks will play a more and more important role in achieving the goal of carbon neutrality," he said.

There are two major ways to slow down climate change. The first one is to improve efficiency and lower energy consumption in industries and the energy sector, which reduces the emission of carbon dioxide. The second one is to restore forests, grasslands and wetlands, which increases the planet's capability to absorb carbon dioxide.

China's forest carbon reserve hits 9.2 billion tonnes

"Just like a bank that receives cash deposits, forests can store carbon dioxide by the photosynthesis, which is also called carbon sinks," said Zhu Jianhua, an associate researcher with the Research Institute of Forest Ecology, Environment and Protection under Chinese Academy of Forestry.

Forests, as a major part of the terrestrial ecosystem, is the largest carbon sink in the system. Carbon sinks are also one of the most economical and effective ways to cope with climate change. It's a natural process that doesn't cost too much, and also protects biodiversity, enhances water conservation and prevents desertification.

 $China\,attaches\,high\,attention\,on\,the\,role\,of$ carbon sinks in coping with climate change.

As early as 2009, the country had proposed to increase its forest stock volume by 1.3 billion cubic meters by 2020 compared to the 2005 levels.

In 2015, it once again vowed to increase the forest stock volume by around 4.5 billion cubic meters on the 2005 level by 2030.

In recent years, the country launched massive campaigns to green its territory, protect natural forests, and advance "grain for green" projects.

So far, forests have covered 23.04 percent of its territory, and the forest stock volume has surpassed 17.5 billion cubic meters, 4.5 billion cubic meters higher than the 2005

"We have over-fulfilled our 2020 targets,

and the 2030 goal of increasing 4.5 billion cubic meters of forest stock volume was also completed in advance," Zhang said.

When global forest resources experienced contraction, China's forest coverage rose from 12.7 percent in early 1970s to the current 23.04 percent. Both forest areas and forest stock volume kept expanding for more than three decades.

"Massive tree planting and revegetation are conducive to improving the carbon sink intensity of China's terrestrial ecosystem, and have a prominent role in reducing the emission of greenhouse gases," Zhu said.

The NFGA and Ministry of Ecology and Environment jointly estimated China's carbon sinks. According to Liu Dongsheng, deputy

director of the NFGA, China's forest carbon reserve has totaled 9.2 billion tonnes, representing an increase of over 200 million tonnes on average each year, which is equivalent to a carbon sink of 700 million to 800

"Upon calculation, every 100 million cubic meters of forest stock volume can fix 160 million tonnes of carbon dioxide," said Xu Huaqing, head of the National Center for Climate Change Strategy and International Cooperation. China still needs to make a lot of efforts to reach its new goals, he added.

"The country shall protect existing forests, and to reduce deforestation is to reduce carbon dioxide emission," Zhu remarked. He noted that the reduction forest dieback caused by floods and insect pests is also an important method to improve carbon sinks.

Time to promote healthy, stable development of China-US relations

FEW would disagree that China and the United States, the world's top two economies, could greatly benefit both themselves and the world at large by steering the bilateral relationship to the right course.

On Saturday, senior Chinese diplomat Yang Jiechi held a phone conversation with U.S. Secretary of State Antony Blinken, saying that the Chinese government implements a stable and consistent policy toward the United States, and urging the U.S. side to work with China to uphold the spirit of no conflict, no confrontation, mutual respect and win-win cooperation, so as to push forward the healthy and stable development of bilateral relations.


In 1971, Dr. Henry Kissinger made his secret trip to China and began the great process of ending the estrangement and resuming the engagement between the two countries. Since then, China-U.S. relations have maintained steady development momentum as a whole and have become one of the most important relationships in the world.

However, over the past several years, some U.S. politicians have withdrawn into Cold-War thinking and adopted a completely wrong policy

They have dragged the bilateral relationship down to its lowest ebb by smearing China's anti-epidemic efforts, interfering in China's internal affairs and sanctioning Chinese hi-tech companies.

These actions have not just seriously harmed the interests of the two peoples, but also caused severe disruptions to the world.

History has proven that the shared interests between the two sides far outweigh the differences. In this highly connected and interdependent world, it is imperative for the world's top two economies to step up cooperation, and more efforts are urgently needed for the United States to rebuild a strategic framework for the healthy and



stable development of relations with China.

Priority should be given to enhancing mutual respect between the two sides. In the spirit of seeking common ground while reserving differences, it is hoped that China and the United States can respect each other's social systems and development paths, take care of each other's core interests and major concerns, and adhere to the international norms of non-interference in internal affairs.

China hopes to have practical cooperation with the United States, but it will never make concessions on issues related to its sovereignty, security and development interests.

Candid and constructive dialogue is needed to better understand each side's strategic intentions and rebuild mutual strategic trust. Instead of regarding China as a threat, the U.S. side should view China's development with a positive and constructive attitude, real-

izing the fact that China adheres to the path of peaceful development and hopes to achieve common development with all countries in the world, including the United States. Only by abandoning ideological prejudice and zero-sum game thinking and adopting a rational policy toward China, can bilateral relations grow steadily.

In Kissinger's book "On China," the former U.S. secretary of state wrote, "what a culmination if, forty years later, the United States and China could merge their efforts not to shake the world, but to build it."

Now China-U.S. relations are standing at a critical point, and it is time for the United States to follow this advice, work with China to enhance cooperation in fighting the COVID-19 pandemic, restoring the global economy and tackling climate change, and foster bright prospects for the two peoples and the world at large.

WHO: Virus may have taken 'convoluted path' to Wuhan

A MEMBER of the WHO-China joint team studying the origins of COVID-19 said bats remain a likely source and that transmission of the virus via frozen food is a possibility that warrants further investigation.

At a press conference in China's city Wuhan on Tuesday, Peter Ben Embarek said the team's work had uncovered new information but had not dramatically changed their picture of the outbreak.

"The possible path from whatever original animal species all the way through to the Huanan market could have taken a very long and convoluted path involving also movements across borders," Embarek told a nearly

three-hour media briefing. He said the exact role of the Huanan said work to identify the coronavirus's origins points to a natural reservoir in bats, but it is unlikely that they were in Wuhan.

Huanan market 'may not be site of earliest outbreak'

Wuhan's Huanan seafood market may not have been the site of the earliest COVID-19 outbreak, the team said.

Liang Wannian, a member of the team, said that in retrospect, the first COVID-19 case in Wuhan had no relation to the Huanan seafood market. "We can't say it was the starting point of the epidemic," he said.

The market drew considerable attention after an early cluster of cases was traced to people working in the market. Embarek also

seafood market was unclear.

Embarek noted that while the market was probably a setting where the virus could have easily spread, this is "not the whole story." "There was also spread among individuals that were not linked to the market," he said, adding that some cases were linked to other markets while some had no links to any markets whatsoever.

Lab incident 'extremely unlikely'

Embarek also said laboratory incident is "extremely unlikely" the cause of COVID-19.

Experts from the team identified four hypotheses for the source of the transmission of

the novel coronavirus to the human population, including direct zoonotic spillover, an intermediary host species, the food chain, and a laboratory-related incident, said Embarek.

Initial findings suggest that introduction through an intermediary host species is "the most likely" passway and one that will require further study and more specific targeted research, he said.

"For us it was important to develop a system to evaluate all these hypotheses where we could take a rational approach and look at facts and evidence in a rational way," he added.

Scientists have concluded that it was impossible the virus was man-made, said Liang Wannian,

another member of the WHO-China joint study team.

"There was no novel corona virus in the Wuhan lab at all, so how could the virus leak from the lab?" Liang said.

Tracing COVID-19 origin not bound to any location

The joint study by WHO and Chinese experts in Wuhan will lay the foundation for COVID-19 origin-tracing work globally, Li-

The global origin-tracing of CO-VID-19 will not be bound to any location, Liang added.

Liang also said there is no indication of the transmission of the novel coronavirus before December 2019 in Wuhan.

ROK's top diplomat confident about US coordination on DPRK

SEOUL

THE Republic of Korea (ROK)'s new foreign minister said vesterday he was confident about coordinating policy towards the Democratic People's Republic of Korea (DPRK) with the United States despite earlier signs of differences.

Chung Eui-yong, 74, took office as the ROK's top diplomat, replacing Kang Kyung-wha, who had held the post for nearly four years. As President Moon Jae-in's first national security adviser until last year, Chung helped facilitate Moon's summits with DPRK leader Kim Jong-un and sought to meditate between Pyongyang and Washington.

Chung's nomination came two days after Moon called for US President Joe Biden to hold a dialogue with the DPRK to build on progress made by Kim and former US president Donald Trump at their first summit in Singapore.

Chung played an incremental role in arranging the 2018 Singapore summit between Kim and Trump. But he was accused of misleading both Pyongyang and Washington about the potential for agreement ahead of their failed second summit in Vietnam in 2019.

The allies have shown signs of friction since then, with Seoul keen to reopen inter-Korean economic initiatives while Washington urges those projects should keep step with DPRK's progress on dismantling its nuclear programs.

Chung expressed confidence in coordinating with the new US administration of President Joe Biden, saying an early denuclearization of the Korean peninsula is a shared

"Resolving the issue a very key task that can no longer be postponed," Chung told reporters.

China strives to protect, pass down ethnic culture of Hezhe people

HEZHE people, one of the smallest ethnic minority groups in China, are now embracing prosperity as they keep alive their culture and

People of Hezhe (which means "people in the east" in the local language) ethnic group in China lived on fishing and hunting for several thousand years and have inhabited areas along the Heilongjiang River, Songhua River and Wusuli River in northeast China.

Jiejinkou Hezhe township in Tongjiang city, northeast China's Heilongjiang province, is one of the three existing ethnic townships of the Hezhe people in China.

You Wenfeng, a resident in the township as well as an inheritor of the craft of making fish-skin clothes, always introduces the craft to visitors in details passionately. As the only inheritor of the intangible cultural heritage, the woman in her late sixties considers it her mission to bring the traditional skill of Hezhe to more people.

She has lent most of the fishskin clothes she made to museums for exhibition, and now has two pieces left at home, according to her.

"The skill of making fish-skin clothes has been passed down for generations in our ethnic group," said You, adding that she learnt the technique from her mother.

Basically all Hezhe women in her mother's generation could make clothes from fish skin, according to You.

However, as Hezhe people no longer depend on fishing or hunting for their livelihood, fewer people wear fish-skin

"If too few people can make fish-skin clothes, the traditional technique would become extinct," You said.

Worrying about the inheriting of the intangible cultural heritage, she started to teach residents in her township the traditional craft. As time went by, people started to visit her from outside the township to learn the skill. She has also been invited to introduce and teach the technique in classes held in cultural promotion centers in Tongjiang city.

Her students include both people of Hezhe ethnic group and Han people who are interested in the fish-skin clothes making technique.

As more and more people, with their ages ranging from 20 to 60, have started to learn about making fish-skin clothes in recent years, the traditional craft of Hezhe has been introduced to various

Liu Lei, a woman of Hezhe ethnic group and also the only deputy of the ethnic group to the National People's Congress (NPC) of China, has tried to promote the skill of making fish-skin clothes in front of the cameras during the annual sessions of the NPC and the Chinese People's Political Consultative Conference (CPPCC) National Committee every year since she became a deputy to the NPC in 2008, when she was

only 23.

She always attends the important annual sessions, which are normally held at the Great Hall of the People in Beijing, in Hezhe ethnic clothes with fish skin elements, including waistcoats and hats. During the "two sessions" in 2016, she showed a wallet and accessories made from fish

Putin orders launch of world's most powerful source of neutrons in Leningrad Region

ST. PETERSBURG

RUSSIAN President Vladimir Putin has ordered the energy launch of the world's most powerful source of neutrons at St. Petersburg's B.P. Konstantinov Institute of Nuclear Physics, affiliated with the Kurchatov Institute research center.

"I am asking you to put the reactor into energy operation," Putin told the participants in the launch ceremony in a video conference mode.

The research reactor PIK is one of the six projects the Russian government included in the program for creating mega-science class facilities in Russia. In contrast to most foreign projects the reactor PIK has greater neutron fluxes in the reflector, a high flux neutron trap and the possibility of irradiating materials in the reactor core.

After the launch Putin congratulated the participants in the science experiment.

"Here is my message to your team. I wish you successful and fruitful work.

My congratulations upon Russian Science Day. I am inviting you to participate in the meeting of the Council for Science and Education. You institute has vast tradi-

tions and boasts specialists of an unprecedentedly high level. You have surprised the country with your discoveries more than once. I am certain that this step forward will benefit our great country," Putin said.

Reactor history

The project for building a PIK reactor with a compact core and heavy water reflector began to be created in the early 1970s as a source of highest intensity fluxes of neutrons.

The first phase of construction was completed successfully 70% by 1986. "After the

Chernobyl nuclear power plant disaster, the project was fundamentally revised. Its safety was considerably improved. The expert scrutiny lasted up to 1991.

For several years the construction project remained frozen. The situation changed when the St. Petersburg Institute of Nuclear Physics was included in the pilot project for creating the Kurchatov Institute center.

After the first unit was completed in February 2011 the reactor's physical launch followed. The reactor achieved a capacity of 100 watts.

Spy chief: Iran could seek nuke weapons if 'cornered' by West

DUBAI

IRAN'S intelligence minister said persistent Western pressure could push Tehran to fight back like a "cornered cat" and seek nuclear weapons, which the Islamic Republic has for years insisted it has no intention of ever developing.

The remarks made in a television interview are a rare suggestion that Iran might have an interest in nuclear weapons, which Western nations have accused Iran of pursuing.

Iranian officials have repeatedly dismissed this charge, citing a fatwa or religious decree issued in the early 2000s by the Islamic Republic's top authority, Supreme Leader Ayatollah Ali Khamenei, that bans

"The Supreme Leader has explicitly said in his fatwa that nuclear weapons are against sharia law and the Islamic Republic sees them as religiously forbidden and does not pursue them," the minister, Mahmoud Alavi, told state TV.

"But a cornered cat may behave differently from when the cat is free. And if they (Western states) push

Iran in that direction, then it's no longer Iran's fault," Alavi said in the interview broadcast late on Monday.

Details from the interview were published by Iranian news websites yesterday. Iran has insisted its nu-

clear program is to generate power and for other peaceful purposes. But US intelligence agen-

cies and the United Nations nuclear watchdog believe Iran once had a nuclear weapons programme that it halted.

US President Joe Biden's administration is exploring ways to restore the 2015

major world powers but that was abandoned in 2018 by former president Donald Trump, who restored sanctions. Iran retaliated by breaching the terms of the accord in a stepby-step response. Biden has said that, if Tehran re-

turned to strict compliance with the pact, Washington would follow suit, using that as a springboard to a broader agreement that might restrict Iran's missile development and its regional activities.

Tehran has insisted that Washington must first ease sanctions before it resumes compliance. It has ruled out any negotiations on wider security issues.

Ruling keeps Ronaldo hush-money case with US judge in Nevada

LAS VEGAS

A U.S. appeals court is letting a federal judge in Nevada decide claims by a woman suing soccer star Cristiano Ronaldo over a \$375,000 rape case hush-money settlement reached more than a decade ago.

U.S. District Judge Jennifer Dorsey said last September she would decide whether Kathryn Mayorga was mentally fit to enter the confidentiality agreement with Ronaldo's representatives in 2010.

Mayorga's attorney, Leslie Mark Stovall, appealed part of Dorsey's ruling that said a dispute over the legality of the agreement was eligible for arbitration. The ruling also allowed Ronaldo's attorneys keep documents out of the case and stated that the case was not eligible for a jury trial.

The order by the 9th U.S. Circuit Court of Appeals in San Francisco was dated Jan. 13 and an attorney for Ronaldo in Las Vegas, Peter Christiansen, declined comment Monday about the case being returned to Dorsey.

Stovall did not immediately respond to telephone and email messages seeking comment.

The Associated Press generally doesn't name people who say they are victims of sexual assault, but Mayorga gave consent through Stovall in 2018 to be identified.

Mayorga, now 37, is a former teacher and model who lives in the Las Vegas area.

Stovall acknowledges she received money not to talk about meeting Ronaldo at a Las Vegas nightclub in 2009 and going with him and other people to his hotel suite where she alleges he sexually assaulted her in a bedroom. She was 25 at the time. He was 24.

Mayorga went public with the account in a lawsuit filed by Stovall in Nevada state court in September 2018. The case was moved to federal court a few months later.

PSG's sporting director Leonardo has confirmed the French champions are monitoring Messi's situation, while coach Mauricio Pochettino and players Neymar and Angel Di Maria have publicly stated that they would welcome the Barca captain with open arms.

Di Maria even said there was a "big chance" of Messi signing for PSG -- which led Barca coach Ronald Koeman to brand the French club "disrespectful" -- but City will provide stiff competition if Messi does leave Camp Nou after 20 vears in Catalonia.

Sources have told ESPN that City are still tracking Messi but have decided to adopt a less aggressive tactic in their pursuit of his signature.

He gave Bayern the lead with just 17 minutes gone at the Ahmad Bin Ali Stadium, a host venue for the 2022 World Cup in Qatar.

The Poland star then headed home a pinpoint Leroy Sane cross four minutes before the whistle to book Bayern's place in the final.

Lewandowski, the Bundesliga's top scorer, has now scored 29 goals in 27 club matches this season.

Bayern are bidding to become only the second team after Barcelona in 2009 to win all six domestic and international titles up for grabs in one season.

The German giants lifted the Bundesliga, German Cup, Champions League, German Cup and UEFA Super Cup trophies in

"We want to claim another title -title number six during this season," Lewandowski added.

"This is a World Cup, which is always something special.

"I hope we can play even better in the final and that we will have more goalscoring chances."

The European champions ended Ahly's 32-match unbeaten run in all competitions under their South

Klopp scrambles for answers as Liverpool's season unravels

LIVERPOOL'S Premier League title defence is in tatters after a 4-1 humbling at home by Manchester City, with Jurgen Klopp facing an uphill task to stop the champions' season imploding.

The bedraggled red-shirted players trudged off the pitch at Anfield on Sunday after their third consecutive home defeat left them 10 points behind Pep Guardiola's men, having played a game more.

Goalkeeper Alisson Becker made two costly blunders after Mohamed Salah had cancelled out Ilkay Gundogan's opener, before Phil Foden blasted home a fourth at an empty Anfield.

It means after a run of 68 league games unbeaten at home, Liverpool have now lost three consecutive league games at Anfield for the first time since 1963.

Former Manchester United midfielder Roy Keane, now a Sky Sports pundit, gave a withering assessment of Liverpool's efforts to retain their

"They are making a lot of excuses," said Keane, who won the Premier League seven times at Old Trafford. "To me they've been bad champions and I don't just mean today.

"You can lose a game of football but there is a way to get beaten. I don't see that and I think maybe they have all believed the hype over the last year

A stubborn Klopp defended his side's performance up until Alisson's first error allowed Gundogan to restore City's lead 17 minutes from time, with his second of the match.

"We scored our goal and in that moment it was possible the game goes in our direction, but Alisson made two massive mistakes," said Klopp.

"Apart from that the game ends 1-1. The performance was good enough at least to draw, and that's it."

 Liverpool collapse The figures make grim reading for the Liverpool hierarchy.

After 23 games this season, Liverpool have 40 points -- 27 fewer points than they did at the same stage last That is the biggest drop by any

campaign in English top-flight history. Despite his upbeat words, Klopp knows he has a monumental task on his hands to repair the shattered confidence of a team who just months

reigning champion at this stage of a



ago romped to their first English topflight title for 30 years.

Instead of the title, which now appears to be City's to lose, Liverpool are glancing nervously over their shoulder as the race for Champions League qualification becomes their priority. Chelsea and West Ham are only a point behind, with Everton, who have two matches in hand, just three back. Tottenham and Aston Villa are also within striking distance.

Liverpool have a few days off this week to regroup as they are not involved in FA Cup action but they then face a tricky trip to third-placed Leicester before a Merseyside derby at Anfield against high-flying Everton.

In between those matches they travel to Hungary for a Champions League match against RB Leipzig, second in the Bundesliga, after the game was moved from Germany.

So what has gone so wrong at Anfield for a side that topped the Premier League table just last month? Liverpool's problems at the back

are well-documented. Defensive talisman Virgil van Dijk has been out of action since October

and has been joined on the long-term absentee list by Joe Gomez and Joel Matip. That has forced Klopp to rejig his team, playing Jordan Henderson at the back, depriving the team of the captain's drive from midfield. Midfielder Fabinho has also been pressed into defensive duties. Klopp signed two centre-backs

-- Preston's Ben Davies and Schalke's Ozan Kabak -- on transfer deadline day and he must surely blood one of

them now. Even Liverpool's fearsome front three are not firing on all cylin-

Anderson, Leach consign India to rare home defeat

ENGLAND inflicted a 227-run defeat on India in Chennai thanks to a dominant fourth-innings bowling performance, with Jack Leach and James Anderson taking seven wickets between them on the final day as they wrapped up victory before tea.

After removing Rohit Sharma on the fourth evening, Leach struck the first blow on the fifth morning by drawing an edge from Cheteshwar Pujara, and returned to help mop up the tail, but it was Anderson's spell before lunch that ripped out India's middle order and set the win in motion.

With the ball reverse-swinging and keeping low from a length, Anderson sent the off stump cartwheeling out the ground twice in his first over of the day to remove Shubman Gill and Ajinkya Rahane, and induced a leading edge from Rishabh Pant to leave him with figures of 5-3-6-3 in a spell that defined the day.

Despite a near-faultless innings of 72 from Virat Kohli, India's chances were quashed by the loss of five wickets in the first session, and after a grubber from Ben Stokes snuck under Kohli's bat, Leach and Jofra Archer finished the job to seal a sixth consecutive away win for England. This was only India's second defeat at home since their 2-1 series loss to England in late 2012, and leaves them needing at least two wins and a draw in the remaining three matches if they are to reach the inaugural World Test Championship (WTC) final.

Gill had started the day by working the first ball he faced for four through midwicket, punishing Leach as he dropped a fraction short. But if India had hoped that would be a sign of things to come, there was evidence early on that the pitch would not prove straightforward: Gill had to jam his bat down on a shooter from Leach, and was beaten by some extra bounce from a length two overs later, while Archer found inconsistency in carry while bowling to Pujara.

Pujara's wicket looked the crucial one, after his rearguard efforts in Australia and with his impeccable record against left-arm spin. But he was gone within half an hour: he closed the face looking to work Leach into the leg side, but the ball turned and bounced to take the shoulder of the bat and loop up to Stokes at slip.

Gill continued to score freely, picking off Dom Bess' loose balls and reaching a fluent half-century, at which point Joe Root threw the ball to Anderson, hoping he could get it to reverse-swing. He could. His second ball was full, and hooped in from outside off stump. It breached the gap between Gill's bat and pad, and crashed into the off stump, sending it

But Anderson was not content with a single breakthrough. The fourth ball of his over rapped Rahane on the pad, again hooping in towards the stumps from wide on the crease and keeping low. Umpire Nitin Menon was unmoved so England reviewed, and while the ball was shown to have been crashing into the base of middle, the decision was upheld with its impact shown as 'umpire's call'.
