**TCU opens second varsity forms drive** 

Executive secretary says 90,000 *study places* available

HE Tanzania Commission for Universities (TCU) has opened the second round of applications for first-degree programmes for the 2023/24 academic year, with 116,133 candidates having applied during the first window.

Prof Charles Kihampa, the TCU executive secretary, made his observation in remarks to journalists in Dar es Salaam yesterday, urging those who missed in the first phase to send their applications to the respective universities.

There are over 90,000 more opportunities to be filled by eligible candidates, he said, noting that the second window commences August 25, to close on September 6.

First round applicants had a total of 86,624 candidates confirmed and enrolled in respective universities, he said, citing an increase of applicants in the first window to 116,133 overall, from 106,295 applicants a year earlier.

In total, 186,289 study opportunities are avail-

Samia to inaugurate new PAPU head office buildings

AT least five Heads of State and score of top officials from 26 African countries are expected to join President Samia Suluhu Hassan at the inauguration of the Pan-African Postal Union complex here on September

Selestine Kakele, the Information Communication and Information Technology ministry deputy permanent secretary, told journalists vesterday that the 18-storey building took up 33bn/- to construct. It will serve as the headquarters of the continental posts and communications body as well as a business complex. Inaugurating the new building will cap off the 41st administrative council meetings for PAPU, which changes the city skyline at its tallest edifice yet. The building peaks at 18 floors high in addition to basement parking floor, entry-level ground floor, aside from an additional rear wing. Standing at the Philips junction of Sekei Ward, formerly a radio assembly factory along the Moshi-Arusha highway, it is adjacent to the Simeon Road, next to Mount Meru Hotel, another imposing city feature. Sirili Akko, the Tanzania Association of Tour Operators (TATO) chief executive officer, cited the building inauguration as a major event in improving the city façade and boosting opportunities for conference tourism. Investors will also take into consideration the cost of renting floor space, to ensure that potential tenants are attracted, he said. The PAPU complex is a joint venture with the Tanzania Communications Regulatory Authority (TCRA), where the Pan African body footed 60 percent of the costs.

There is also an increase in university programmes from 757 last year to 809 programmes for the 2023/24 academic year, he said, noting that this change was being stirred by technology shifts and job market needs.

He demanded those who sent applicants and obtained admission confirm with one university before September 7, as a total of 43,213 candidates are cited for admission in more than one university.

Concerned applicants and the general public need to avoid being misled by presumed middlemen claiming to provide services on how to join higher education institutions, he cautioned.

"We have three groups of people who are eligible to apply for higher studies, namely form six leavers, ordinary diploma and those with foundation courses from the Open University of Tanzania (OUT). All information on how to apply and minimum requirements are found in the TCU website and respective varsities," he specified

The various universities need to declare open their programmes that still have chances for students to apply, placing help desks to provide needed assistance to students seeking to process their applications, he added.

# TANESCO hires staff as JNHPP nears completion

THE Tanzania Electric Supply Co. (TANESCO) has increased staff numbers at the Julius Nyerere Hydro-Power project (JNHPP) as it prepares for material assembling ready for power generation rumbling off by next June.

Maharage Chande, the managing director, yesterday led a top management group in touring the site to inspect progress, carrying out a scenario analysis on the recent weather forecast by

the Tanzania Meteorological Authority (TMA).

It shows that the wide parts of the country will receive above normal rains from late next month, where the CEO observed that by the end of this month the project will be 91-percent complete.

He told journalists at the site that manpower will be added in groups as the handing over process proceeds, with 20 employees placed on the site, reaching 92 as the project reaches final touches. That is 10-percent of total work from this moment, he

stated.

"The remaining task here is to assemble equipment and finish off connecting the machinery," he said, noting that at present there is a

power supply deficit of 100 MW which will be curbed when JNHPP starts generation. Electricity needs have increased to 1,482.7megawatts from 1,354.5MW by the end of last year, he said, elaborating that the Kinyerezi I project to generate 185MW was "swallowed" by the rise in electricity demand, owing to a sharp increase in economic activities. The inspection and evaluation tour has shown that everything was intact and evidently the project will be completed as scheduled, he said, affirming that the management was similarly evaluating projected above normal end of year rains to accommodate any such prospects to the JNHPP construction schedules. Finance director Renatha Ndege stated that the management's wish to view progress at close range was informed by the desire to see the project being completed on time, sorting out energy supply bottlenecks quickly The completion of the project will be a game changer to the energy sector as it will stimulate economic activities in improving the feasibility of manufacturing projects, he said Last December 22, President Samia Suluhu Hassan graced an occasion to start filling the dam as contractors completed building in the water diversion channel. The dam has the capacity for 33.2bn cubic meters of water, officials said. With its June

2024 completion schedule, JNHPP will tremendously improve the country's energy mix, as hydropower sourcing lessens overall energy costs in the country. Project works took off in December 2018 as part of the fifth phase government put aside the concerns of a wide ranging conservationist lobby to bring to realisation a decade's old dream of a major power station at the Stiegler's Gorge, standing at 100m depth.

An online entry on the site says it was named after a Swiss explorer who was killed here by an elephant in 1907, and during the decades after independence it was part of the Selous Game Reserve named after a British explorer. Since the start of the power project, the zone with the project was hived off to become the Julius Nyerere National Park, ranking with the Serengeti and Ruaha national park as among the richest concentration of wildlife in Africa. Tanzania needs a sustained increase in power generation as the country inches towards an industrial economy, while seeking to diminish unit costs of energy that for a decade have been weighed upon by considerable reliance on natural

the volume of direct investment up by 2.5 times that of a decade ago, she said.

Over the past decade, BRI has built a new bridge for China-Tanzania friendship and the strategic docking between the two sides has been deeper, he stated, pointing out that over the past ten years, Tanzanian exports to China were chiefly agro-products like coffee, avocados and soybeans.

So far China has provided Tanzania with more than 2,000 scholarships and thousands of vocational and technical training places, she stated, emphasising that cooperation between China and Tanzania in education, culture, health and tourism has flourished.

The people of the two countries have been getting to know each other deeply, she said, pointing at a series of strategic projects having laid a solid foundation for Tanzania's economic and social development and regional interconnection.

"I have witnessed the flourishing cooperation between China and Tanzania under BRI. Tanzanian enterprise representatives told me that the Belt and Road cooperation has brought many business opportunities," Cheng affirmed. deputy speaker, said that BRI represents an opportunity for the East African Community partner states to access financing and material support for infrastructure projects.

Key areas covered by the BRI is infrastructure connectivity, with BRI particularly attractive as a catalyst for EAC economic integration, he said, noting that the EAC partner states are in a better position to take up investment opportunities tied with this initiative.

Deng Li, Foreign Affairs vive minister, said China will join hands with all other countries, including Tanzania to promote high-quality Belt and Road cooperation in a programmatic way, while creating more benefits for people in all participating countries.

# JKT volunteers programme to attract professional youth

THE National Service has opened window for the local youth to apply for this year's volunteers programme, outlining six key professional sectors to be prioritised when selecting applicants.

Brigadier General Hassan Mabena, NS head of administration who doubles as the service chairperson of strategic committee on agriculture, livestock and fisheries development, yesterday unveiled the sector as fisheries, irrigation, psychology, wildlife, livestock and civil engineering.

Furthermore, he communicated that the insight vision behind the program was not to offer any employment, but to capacitate the youth with practicalbased skills to help them stand a chance to employ themselves," Brigadier General Hassan Mabena insisted.

He urged the youth to turn out in multitude and apply for the prestigious opportunity which focuses to turn them becoming more patriotic, saying the application process is being coordinated by the officer of the Regional Commissioners (RCs).

As per this year's setup, the annual pro-

gramme will in this year welcome applicants from different education levels, ranging from primary education to high learning.

For the form four youth applicant, he detailed that they must not exceeding 20 years and must be those graduated between 2020, 2021 and 2022 academic years.

"The form six applicants, he expressed, they must not exceeding 22 years of age, graduated from the same academic years (from 2020 to 2022)," he added.

The envisaged programme will is open for both, the youth from Mainland and Isle, and the prospective applicants must possess the valid relevant certificates.

### TTCL pledges to transform country into cashless economy in four years

THE Tanzania Telecommunications Corporation (TTCL) has talked the plans set to transform the country into a cashless economy by 2027.

Peter Ulanga, the director general unveiled the plans on Thursday in Dar es Salaam when addressing the media 1 on the corporation performance for the last two years.

Ulanga said that TTCL has been positioned to transform the sector and make Tanzania one of the best countries in sub-Saharan Africa in enjoying the digital economy.

"We're are working in line with our four-year strategy-2022/2023 to 2026/2027 that among other issues is to improve data infrastructure that will make TTCL meet its desired target and takes Tanzanians to the cashless economy," Ulanga said, noting that the corporation envisages to export connectivity to the neighboring landlocked countries.

He also said that the corporation is set to accelerate the digital economy through quality supply of communication services including internet data.

According to him, TTCL targets to supply a national fibre optic cable network (National ICT Broadband Backbone (NICTBB) at the door step of about one million households by 2027 and ensure that all 139 districts are connected with 5 generation (5G).

According to Eng. Ulanga, the corporation can make Tanzania a leading country in the East African region and the Southern African Development Community (SADC) due to the presence of an excellent communication infrastructure capable of achieving digital economic growth.

"We're doing well in the digital economy and we'll continue to do better and makes our people go in the same pace of the current digital world," he said, adding when the country connects with other countries digitally, it will be able to help increase the income of foreign currency and the economy will continue to grow.

"We will sell innovation, and technology abroad through TTCL while Tanzanians will see how the organization is growing and capable of making Tanzania a leading country not only technologically but economically in our region, in terms of security and culture when it sells digital," he said.

### Parliament calls upon TEMESA to oversee ferry building contractors

THE Parliamentary Infrastructures Standing Committee has called on Tanzania Electrical, Mechanical and Electronics Services Agency (TEMESA) to closely supervise contractors constructing government ferries to make sure the ferries are of high quality standards.

The remarks were made here by the committee's chairman, Selemani Kakoso after it received TEME-SA's report on government ferries operations. "Make sure you closely follow up of the contractors, we want to see people benefit by these ferries to which the government has been providing huge sums of money for their purchase and/or construction," said Kakoso.

In addition, the panel called on the Agency to make sure it operates commercially in order to go in tandem with market competition from within and outside the country in boosting its services to their customers in various areas of the country. The Committee chairman also instructed TEMESA to hire adequate experts as well as providing training to the existing experts so as to empower them to attain their set goals.

For his part, Deputy Works and Transport Minister (Works Sector) Eng. Godfrey Kasekenya said in 2023/24 FY the Agency plans to implement seven new ferry building projects to serve Kisorya-Rugezi, Bwiro-Bukondo, Mafia-Nyamisati, Ijinga-Kahangara, Nyakariri-Kome and Buyangu-Mbalika as well as two smaller ferries to serve Magogoni-Kigamboni in Dar es Salaam.

Kasekenya explained that the Agency also plans to complete refurbishment to various ferries including the MV Kazi, MV Misungwi, MV Musoma MV Tanga and MV TEMESA.

**TEMESA Chief Executive Officer,** Lazaro Kilahala said that the Agency has attained various achievements including the installation of the electronic revenue collection system at Magogoni - Kigamboni ferry aimed at boosting revenue collections.

He said the government's intention is to see citizens reallocated from the protected area have access to basic needs as well as improved social services such as education and health. He said among the group, two families are moving to Msomera in Handeni District while others are moving to Karatu and Monduli districts.

"May I call upon others to voluntarily register for the exercise to facilitate conservation activities. The government will continue to empower those willing to move to other places," said the minister as he handed over cheques to the families. Mchengerwa insisted that the exercise is voluntary whereas people choose where to go without being influenced. He warned some groups of people trying to convince the villagers not to reallocate, saying they are committing a crime and that legal measures will be taken against them.

"Let no one try to undermine the government's conservation efforts," he remarked, adding the villagers have made wise decisions to move to safer places that are free from wildlife attacks.

One of the villagers, Luka Oleapa said they are thankful to the government because they are going to own better houses and land parcels for development. "I also convinced my fellow villagers to reallocate: at our new homes we will have farms and grazing areas. The government should continue to educate people on the importance of moving from the protected area as some are reluctant only because they are not well educated on the matter," said Oleapa.

Ngorongoro District Commissioner, Raymond Mangwala said the government has successfully reallocated hundreds of people in the first phase.

Mangwala added that the government is determined to improve the tourism sector through enhanced conservation activities. He said the district has within a year generated over 150bn/- through tourism, attributing the success with the Royal Tour film.

# Govt urges stakeholders to limit use of chemicals eroding the ozone layer

THE government has asked procurement and supply officials to consider limiting the use of chemicals and equipment that erode the ozone layer or have an impact on human health and the environment.

Dr Switbert Mkama, the Acting Permanent Secretary in the Vice President's Office (VPO) made the call yesterday when opening oneday training workshop for of the ozone layer is to allow procurement and supply officers on the implemen-

tation of the Montreal Protocol on chemicals that de-

plete the ozone layer. Dr Mkama has said that at the beginning of the 1970s, scientists discovered that some man-made chemicals, including refrigerators, air conditioners, fire extinguishers and mattresses, have infiltrated the air and eroded the ozone layer, causing harm to human health and the environment.

"The result of the erosion more ultraviolet radiation to reach the earth's surface,

which causes various effects on human health and the environment. The effects are such as skin cancer, eye damage that causes

blindness and effects on the growth of plants and other living organisms," said Dr. Mkama

He also said the results of the discovery caused the International Organization for the Environment (UN Environment) to conduct a scientific assessment and decide to take effective measures to protect the Ozone layer by establishing the Montreal Protocol on the control of chemicals that deplete the Ozone Layer adopted in 1987

The VPO official said that in implementing the Protocol, the Government has taken various steps including preparing and implementing the Plan to Eliminate Chemicals that Deplete the Ozone Layer of Hydrochlorofluorocarbons (HCFCs) by 2030 as well as the Implementation Plan of the Kigali Amendment to reduce the use of chemicals in society hydrofluorocarbons.

"Under these plans, one of the activities that are neglected and should be implemented includes providing training to procurement and supply officers from various institutions regarding the implementation of relevant Protocols, including the implementation of Environmental Management Regulations (Control of Chemicals that Deplete the Ozone Layer) of the year 2022" said Dr. Mkama.

He said procurement and supply officers are the main actors in the process of han-

dling the procurement of various equipment in public offices, so they have a great responsibility to provide Ozone education to others in order to increase efforts to preserve the Ozone Layer and save human life and living things.

Kemilembe Mutasa, acting director of the Environment Office of the Vice President, said in implementing the Protocol, the Office has continued to provide training to various stakeholders including procurement and supply officers from various ministries with the aim of building their understanding about the requirements of the Protocol Montreal.

"The Office of the Vice President in collaboration with the Tanzania Revenue Authority, the Chief Government Chemist's Laboratory Authority, the Tanzania Standards Organization and various Technical Training Colleges have continued to provide training to various officials on the management and control of chemicals and equipment containing chemicals controlled under this Protocol" said Kemilembe.

CHINESE social network TikTok has pledged to work with Kenyan authorities so that its content can be monitored and eventually removed, the presidency of the East African country, where a ban on the platform has been requested, said on Thursday.

dent Ruto (pictured) on Thursday morning, TikTok CEO Shou Zi Chew committed to ensuring that content is moderated to meet community standards," says a statement on the Kenvan presidency's website.

"TikTok will work with Kenya to review and monitor its content," the text adds.

"This new development means that inappropriate or offensive content will be removed from the platform", it assures, indicating that Tik-Tok has also committed to opening an office in Kenya "to coordinate its operations on the continent" and "to hire more Kenyans".

No details were provided on the modalities and timing of this content moderation.

The popular video-sharing app owned by the Chinese group ByteDance is very popular in Kenya, where a businessman, Bob Ndolo, recently asked Parliament to rule on its ban.

"The applicant denounces the fact that (...) the content shared on the platform is inappropriate and promotes violence, explicit sexual content, hate speech, vulgar language and offensive behaviour that pose a serious threat to Kenya's cultural and religious values," National Assembly Speaker Moses Wetangula detailed to MPs on August 15.

A parliamentary committee is due to study the request within two months.

Kenya's neighbour Somalia announced on Sunday that it was banning TikTok, as well as the Telegram messaging service and an online betting site, with effect from August 24, claiming that these platforms were being used by "terrorists", notably the radical Islamist Shebab.

In Senegal, the authorities suspended it in early August until "further notice" due to the dissemination of "hateful and subversive" messages following protests against the imprisonment of opposition figure Ousmane Sonko.

The application, which has more than a billion active users worldwide, is also suspected by the authorities in the USA and several European countries of not protecting data sufficiently and of allowing Beijing to spy on and manipulate its users, something the group has always vigorously denied.

# TARURA all set to repair 21,057 kms of roads

THE Tanzania Rural and Urban Roads Agency (TARURA) is set to repair 21,057.06 kilometers of roads in the country in the current financial year which will include a 427-kilometer stretch of tarmac road.

In 2023/24, the government has given TARURA a total of 858.517bn/- to support diverse projects for construction of new roads, but also, for the rehabilitation road infrastructures in different districts across the country.

Out of the amount, 710.31bn/- is from internal sources and a total of in the current fiscal year is to continue

148.207bn/- has been sourced from foreign sources through different projects, including the Tanzanian Cities Transforming Infrastructure and Competitiveness (TACTIC), and the Tanzania Roads to Inclusion and Socio-economic opportunities (RISE) projects, among others.

At a press conference yesterday, TARU-RA Chief Executive Officer Victor Seff said this year's plan involves construction of 855 bridges at different locations and at least 70- km of drainage systems.

"And among our key priorities in the implementation of different projects making good use of resources that are Coast (1), Ruvuma (3) and Iringa at least 15 available at the project's site's vicinity in order to reduce construction costs," he expressed.

Moreover, Seff added that as of March, 2023, the Agency had already managed to construct a total of 163 stone-made bridges, worth 8.7bn/-, the development which served 50 percent of the involved cost.

He unveiled that the stone-made bridges has been constructed in different regions, including Kigoma (92), Singida (24), Tabora (5), Kilimanjaro (10), Mbeya (2), Arusha (6), Morogoro (2), Rukwa (3), bridges have been constructed.

Together with that, and in further efforts to help reducing construction cost, he communicated that TARURA was continuing to conduct several technological trials with an eye to use the soil that available at the roads constructions sites, unveiling the technologies as Ecoroads, Ecozyme and GeoPolymer.

"So far, we have managed to construct a 1km road stretch in Dodoma Capital City through Ecoroads technology, whereby in Mufindi district, a total of 10km of road is expected to be constructed through the

technology," he expressed.

TARURA is an Executive Agency of the President's Office, Regional Administration and Local Government (PO-RALG), established under Section 3 (1) of the Executive agencies Act. (Cap 245) by Order Published in government No. 211 dated May 12, 2017 and was inaugurated on July 02, 2017.

TARURA is vested with the responsibility of managing the development, rehabilitation, maintenance, axle load control, environmental and road reserve management of rural and urban roads network for the Socio - Economic development of Tanzania.

### IFM, Dutch university agree on mutual collaboration in exchange programmes

He said during the 20th years of collaboration, a notable success has been recorded such as numerous PhD's and master degrees candidates graduated in the Netherlands.

Others are joint research publications and various journal studies, training and building capacity in research methodologies to its high level lecturers.

Netherlands Ambassador to Tanzania, Wiebe de Boer said the collaboration has been important for students pursuing PhD and master degrees of all institutions adding that the two countries have a long historical relationship in the agriculture sector.

The relationship has been characterized by strong economic and diplomatic ties, growing trade and investment, exchange of knowledge, experiences and expertise.

Siriel Nchemba, Senior Lecturer at IFM said that the collaboration between IFM and Groningen of Netherlands has played a big role in building the capacity of the institute's staff.

Dr Kelvin Njumwa, from the Institute of Accountancy Arusha (IAA) - Dar Es Salaam Based Campus commended IFM for the strong and sustainable collaboration.

"Since its inception, the e-Government system has been playing a meaningful role in increasing efficiency and transparency at the public institutions; thus, I remain optimistic that the NPS office will benefit the same," he added.

Minister Simbachawene said that the digital system is acting as the 'brain' of the government as it helps to reduce service burden in service delivery in public institutions.

He said that through the e-Government system, a total of 17, 411 criminal cases have so far been registered, whereby out of the cases, at least 7,361 cases have come to an end and judgements have been issued.

This is a good example to be adopted by all public institutions that involve in service delivery towards the public," he insisted.

# Renewable energy offers Africa the best chance to achieve SDGs, say experts

### ABIDJAN

AFRICA must increase investment in developing its renewable energy, and attract greater support of the private sector and international financial institutions, if it is to achieve the Sustainable Development Goals (SDGs), experts meeting in Abidjan stressed Wednesday.

The continent should also control, exploit and transform its enormous mineral resources locally in order to generate the financial resources needed for its development, urged the experts, who represented a dozen African countries, during an African Development Bank workshop held on transition for certain critical miner-August 23-24, 2023. The meeting's theme was Financial Modeling for the Extractive Sector (FIMES).

"Renewable energy gives us opportunities to achieve the Sustainable Development Goals. We also need to be major players in the Transition Advisor for Africa at the energy field," said Dr. John David Natural Resources Governance In-

Cooper, Director of Policy and Research at Sierra Leone's Ministry of Mines and Mineral Resources. He was speaking on the panel on "Financial modeling for a just energy als in transition countries".

Participants note that Africa has made considerable progress in energy transition despite the challenges. Pointing to the scale of the challenges still ahead, Silas Olang, Energy no African country ranks among the world's top 30 in energy transition. Still, Nigeria, Ghana, Ethiopia, Kenya and South Africa are examples of countries implementing ambitious renewable energy development policies.

THE Gross Domestic Product of BRICS is now 36 percent of global GDP and 47 percent of the world population. This follows the announcement of the six nations to the BRICS bloc.

"We have decided to invite the Argentine Republic, the Arab Republic of Egypt, the Federal Democratic Republic of Ethiopia, the Islamic Republic of Iran, the Kingdom of Saudi Arabia and the United Arab Emirates to become full members of BRICS. The membership will take effect from 1 January 2024," announced Cyril Ramaphosa President of South Africa

India said adding the six countries shows the determination of BRICS for unity.

"India will continue to build consensus for those countries wishing to join BRICS. Expansion & modernisation of BRICS is a message that global institutions must mold themselves to changing times," said India Prime Minister Narendra Modi.

In reaction to the bloc expansion, the BRICS Sherpa said they received applications from 22 countries.

"We had applications from 22 countries. All of these countries we have taken on board had applied formally. Expansion had to happen in a structured manner," stated Ambassador Anil Sooklal BRICS Sherpa.

The Johannesburg Declaration 2 adopted at this year's BRICS Summit here in South Africa is expected to ensure the development of BRICS nations and create more inclusive economic policies for all members.

A VISIT to one of the referral hospitals in Dar es Salaam in late March changed the life of a 25-year-old mother of two children aged three and eight.

Mariam Mwakabungu, a resident of Kinyerezi in Ubungo District, had visited her friend at the Amana Regional Referral Hospital that had given birth to premature twins, and as she was about to leave she saw a nurse attending to a premature baby.

"I asked the nurse where the baby's mother was and she told me that she was sick. The nurse asked me whether I could help give the baby kangaroo mother care. I accepted the offer in the blink of an eye," Mwakabungu said in an interview.

Kangaroo mother care is a technique that helps to keep a low birth-weight baby warm by carrying the baby

with skin-to-skin contact which provides protection from infection.

Mwakabungu said she gave the nurse her telephone number, and she went home asking the nurse to call her when she needed her kanga-

roo mother care services. "The nurse called me and I went straight to the hospital where I started giving the service to the baby who, according to doctors, had weighed one kg since it was born a month earlier," said Mwakabungu whose two children were born weighing

more than 3 kg each. She said she stayed with the baby for one week and her weight increased to the required standard which is above 2.5 kg and the baby was later handed over to an orphanage after her sick mother had abandoned it.

She said as she had completed giving the kangaroo mother care to the baby, two

babies were brought to her and she continued giving the service to them.

She said between late March and July she had given the service to three premature babies that have been handed over to an orphanage and now she was looking after a fourth premature baby that she was given to her on Aug 3.

Mwakabungu said her parents died when she was five years old, and years later she has to drop out of school because her grandmother that was looking after her had no money to pay for her school

She said her work was appreciated by Tanzanian President Samia Suluhu Hassan who recently awarded her a monetary prize.

"Top officials of the hospital visited me as I clutched a premature baby and handed me the money saying it is my present from the president. I was overjoyed beyond explanation," she said.

The president also directed the Ministry of Health to employ her permanently as a nurse and the process to employ her has already started, said Sarah Simba, the hospital's head of communications.

Mwakabungu suggested unit has only six beds. "A premature baby is born before 37 weeks of pregnancy are completed," she said. "Kangaroo mother care is both simple and cost-effective because it does not need a machine, but just a skin-toskin bond between mother and child to provide this little baby with the needed warmth."

According to the United Nations Children's Fund data, more than 200,000 children are born prematurely in Tanzania every year, and approximately 9,500 of them fail to survive.

### **Democracy meeting was** helpful event for clarity

STAKEHOLDERS and a range of on- It was partly in view of next year's local lookers at a democracy meeting held in Dar es Salaam at midweek had plenty to chew, and more than enough to carry for their own reflections in due course. It was not an event to cultivate a consensus on what democracy is all about, but rather a few key characteristics, while objectives, and even attendant methods, are open to interpretation. It was altogether to the point and disabusing, for anyone who expected a simple formula for all to obey.

Everyone knows the background to the meeting and indeed its aftermath, and in those regards as well little consensus existed in the meeting, among opposition parties and even within the ruling party, on its causes and outcomes. Suffice it is to say that 'all is well that ends well,' where reminders were given on the way in which democracy is contextual. Mwalimu JK Nyerere once rightly said in his time that democracy wasn't a one-size fits all panacea

It is precisely these limitations that radical proponents of democracy have never accepted, believing that when everyone expresses themselves as they wish, all will be well.

Swiss and U.S envoys who attended the meeting lent a helpful hand in that regard, roundly emphasising that practicising democracy includes taking note of a country's environment. It implies that virtually each country has its specific set of limitations, if not on paper, then in political usage, and those who participate in making use of democracy usually respect those limits

The meeting was called by the Tanzania Centre of Democracy (TCD) and other partners to extensively discuss the state of democracy in the country.

A key diplomat noted that the 30 years journey towards a multiparty democracy has not always been easy or straight, as certain periods witnessed alarming backsliding. While there was no debate on that aspect. local observers are well aware there is another side to that equation, that it wasn't simple backsliding, as if all was well earlier. While it is true that the backsliding has been checked, there is clear backsliding in some other areas, say in the fight against corruption.

Another issue is the seminar reference to certain events threatening to undo the important work that was already done in relation to democracy, where most opinion makers will agree, unlike in policy issues. Is there no threat to undo the important work that has already been done to make Tanzania a better place to do business? Does intervention from this or that quarter have in mind the public interest, in the sense of revenues or it is an issue of specialised interest groups?

The meeting issued a declaration enshrining the need for the forthcoming civic polls and the general election to be conducted after reviewing laws governing elections.


Permitting questioning of presidential election results in court was a substantial demand the stakeholders put across, along with an independent electoral body, independent candidates and election returning officers not drawn from the regional administration or local governments.

These demands are to be expected at present; in the current dialogue environment, plenty can still be achieved.

# Should the coup in Niger amplify fears over terrorism in the Sahel?

NIGER has been hit by multiple jihadist attacks since its president was overthrown last month, but observers caution against concluding that a long-running insurgency is shifting into higher gear as post-coup uncertainty mounts.

Since 2015, when jihadists started mounting cross-border strikes from Mali, thousands of people have died and hundreds of thousands have fled their homes.

The rebel officers in Niger who overthrew President Mohamed Bazoum on 26 July pointed to the "degradation of the security situation" under his watch - a belief shared by many Nigeriens.

Western observers and partners, especially France, Bazoum's ally, had been quick to highlight the improvement.

They praised a shift in strategy that began after Bazoum took office in April 2021 following historic elections.

While the military regimes in Mali and neighbouring Burkina Faso focus on hefty "anti-terrorist" operations that are often blamed for heavy loss of civilian life, Bazoum fostered localised peace agreements, development projects and negotiations with heads of armed groups.

This was a flexible approach - hailed as highly promising by western partners - but often criticised at home, especially within the army.

"The highest-profile attacks are against symbols of state or are largescale attacks, but background violence is a daily phenomenon, because of gangs and the guns in circulation," he said. The unrest across the region has killed thousands of troops, police officers and civilians and forced millions to flee their homes.

Anger at the bloodshed has fuelled military coups in all three countries since 2020, with Niger the latest to fall.

On Tuesday, the African Union said it had suspended Niger until civilian rule was restored and would assess the implications of any armed intervention.

Union adopted the African Union Convention on Preventing and Combating Corruption (The Convention) at the Second Ordinary Session of the Assembly of the Union, held in Maputo (Mozambique), on 11th July 2003. The Convention entered into force on 5th August 2006, thirty (30) days after the deposit of the fifteenth (15th) instrument of ratification. To date Forty Eight (48) countries have ratified the Convention and are states parties to it.

Nearly 75 million people in sub-Saharan Africa are estimated to have paid a bribe in the past year - some to escape punishment by the police or courts, but many forced to pay to get access to the basic services that they desperately need.

Corruption creates and increases poverty and exclusion. While corrupt individuals with political power enjoy a lavish life, millions of Africans are deprived of their basic needs like food, health, education, housing, access to clean water and sanitation.

The majority of Africans (58%) say that corruption has increased over the past year. This is particularly the case in South Africa where more than four-in-five citizens (83%) say they have seen corruption rise recently.

2. Most Governments Failing In Fight Against Corruption

There is no government which is rated positively on its anti-corruption efforts by a clear majority of its citizens. Out of 28 governments, 18 are seen as completely failing to address corruption.

3. Police And Private Sector Seen As Most Corrupt

Across the region, the police and business executives are seen to have the highest levels of corruption. The police have regularly been rated as highly corrupt, but the strongly negative assessment of business executives is a new development.

> Out of six key public services, people who come into contact with the police and the courts are the most likely to have paid a bribe. This is consistent with our previous surveys and highlights the lack of progress made in addressing bribery in these two institutions, which are crucial for citizen security and the rule of law.

> People in the region are divided as to whether ordinary people can make a difference in the fight against corruption - just over half of people think that they can (53 per cent), while 38 per cent think they cannot. Only roughly one-in-ten people who paid a bribe actually reported it.

There are a few countries in which citizens see low levels of corruption in their public institutions and see corruption as on the wane in their own country.

The region faces a serious challenge in ridding itself of corruption: although people told us that reporting incidents of bribery is one of the best ways to stop corruption from happening, they also told us that many people do not report bribery because they are scared of suffering retribution and think reporting mechanisms are ineffective.

In order to effectively prevent corruption in Africa greater efforts need to be made to protect whistleblowers from retribution, improve the effectiveness of reporting channels, and raise public awareness about how and where they can report corruption.

Many countries in the region have seen threats and violence against civil society, making it dangerous to operate and difficult to hold governments to account.

African governments must create safe conditions for civil society to undertake anti-corruption work, and governments need to guarantee the operational and physical freedom of such organisations.

But the situation is more complex than it may appear.

In the run-up to the coup, the situation had in fact been improving, at least in statistical terms.

In the first half of 2023, attacks on civilians fell by 49 percent compared with the same period in 2022, while the number of deaths was down by 16 percent, according to Armed Conflict Location and Event Data (ACLED) project.

Urban versus rural perceptions A June 2022 opinion poll by Afrobarometer found a big difference between rural and urban dwellers about how they rated Niger's security situation. People in the cities were far likelier to say that the problems were bad, even though people in the countryside were far likelier to be victims of violence.

This comes as suspected Islamic insurgents killed at least 12 Nigerien soldiers in the remote south-western region of Tillaberi.

An anti-jihadist operation by national guards was reportedly "the target of an ambush" on Sunday evening, according to TéléSahel.

This comes as the new military ruler General Abdourahamane Tchiani has proposed a three-year transition back to democracy - a call rejected by Ecowas - which sent a delegation to visit Niger on the weekend in a final diplomatic push.

# Marine protection matters for both people and nature

MARINE protection is important for its own sake. We are only passing through this world and must leave behind a thriving planet - at least as healthy as when we arrived - for those who follow.

Equally, an effectively protected ocean is essential for people and prosperity in the here and now - and to have hope for a better, healthier and more resilient future for coastal communities around the world.

Coastal resilience, job security, sustainable fishing, equitable tourism, pollution-free beaches, renewable energy and so much more - these tributes of a healthy ocean promise boundless dividends for people everywhere, for generations to come. The sustainable and equitable use of effectively managed ocean resources is best ensured through the establishment and maintenance of Marine Protected Areas (MPAs). These safeguard the health of life below and above the ocean surface.

In 2015, the Sustainable Development Goals - including SDG14 for the ocean - were established by all UN Member States to serve as a "shared blueprint for peace and prosperity for people and the planet now and into the future." Under SDG14, there is a specific target to "sustainably manage and protect marine and coastal ecosystems to avoid significant adverse impacts, including by strengthening their resilience, and take action for their restoration in order to achieve a healthy and productive ocean" - as well as pledges to tackle marine pollution and overfishing in all its forms.



Increasing MPAs feeds into all of these.

At COP15, the UN Convention on Biological Diversity conference in December 2022, countries came together in signing off on the Global Biodiversity Framework. They committed to protecting at least 30% of land and ocean by 2030, a longcalled-for benchmark of planetary protection known as '30x30.

In January, the World Economic Forum's Ocean Action Agenda and Friends of Ocean Action released the statement Ocean Action in 2023, calling for continued ambitious progress to achieve ocean health through the suite of opportunities ahead.

The first of these opportunities was the Fifth International Marine Protected Areas Congress (IMPAC5) that took place in Vancouver, Canada, on 3-9 February 2023, highlighted as a major stepping stone towards achieving the 30x30 goal.

Many diverse bursts of commitment for ocean

protection were announced during IMPAC5, building on the growing momentum of ocean action. These range from defining minimum required standards for effective MPAs, to pledges for ocean conservation. The Canadian Government also joined a growing swell of voices calling for a precautionary approach to the potential exploitation of resources in the deep ocean, by declaring an effective moratorium on deep seabed mining under its jurisdiction.

Indigenous peoples and first nations, as well as young people from around the world, were front and centre at IMPAC5, with wide applause for the diversity and inclusion of the broadest range of stakeholders at this congress. Diverse voices were valued for their critically important perspectives, knowledge, ideas, solutions, care and ecological stewardship of our ocean. The climate, nature, biodiversity and ocean crises cannot be solved unless we bring everyone to the table.

# What must be proved when relying solely on circumstantial evidence


AST week, we briefly looked at unfair termination of employment in circumstances whereby a man secretly goes to his wife's workstation and talks to her employer to terminate her employment. There are many married women who have fallen victim to this.

We said that by virtue of Article 22(1) of the Constitution of United Republic of Tanzania (R.E. 2005), every person aged 18 and above is entitled to work and by virtue of Article 9 "the state authority and all its agencies are obliged to ensure that every person who is able to work does work, and work means any legitimate activity by which a person earns a living." This Article applies to all persons and does not exclude women - that is, men and women are equally entitled to work or employment.

Therefore, when it happens that one is unfairly laid off or his or her employment is unfairly terminated, that person has the right to sue in court. But if one doesn't sue, they lose their right because "he who sleeps over his rights loses them". That is, only those who are vigilant against the abuse of their rights get court relief.

We even cited section 37(1) of the Employment and Labour Relations Act (Chapter 366) which states that: "It shall be unlawful for an employer to terminate the employment of an employee unfairly."

Today, I invite you to briefly look at circumstantial evidence. According to Black's Law Dictionary, circumstantial evidence "is evidence of facts or circumstances from which the existence or nonexistence of fact in issue may be inferred...it is the proof of various facts or circumstances which usually attend the main fact in dispute, and therefore tend to prove its existence, or to sustain, by their consistency, the hypothesis claimed...it consists in reasoning from facts which are known or proved to establish such as are conjec-





tured to exist."

Circumstantial evidence may be relied on where there is no direct evidence. It is direct evidence when the principal fact is attested directly by witnesses, things or documents and it is circumstantial evidence when there is no direct evidence of an eyewitness.

In criminal cases, Singh (2007) in his book "Principles of the Law of Evidence" argues that it is generally established that "in a case resting on circumstantial evidence all the circumstances brought by the prosecution must inevitably and exclusively point to the guilt of the accused and there should be no circumstances which may reasonably be considered consistent with the inno-

cence of the accused." In the case of Sikujua Idd (appellant) v the Republic (respondent) in a criminal appeal No 484 of 2019 from the judgment of the trial High Court in Bukoba, Sikujua Idd was charged with murder, contrary to section 196 of the Penal Code [R.E. 2002 now R.E. 2022].

It was alleged that on December 23, 2014 while he was at Nyakariba Village in Ngara District, Kagera Region, he murdered his father Idd Buturumbe and was found guilty, convicted and sentenced to suffer death by hanging as stipulated in section 26(1) of the Penal Code. The prosecution had three witnesses, including two of the appellant's relatives and a fellow villager.

In convicting the appellant, the trial court found that the post-mortem examination report showed Idd Buturumbe suffered from a cut at the head and the right upper arm, which led to severe bleeding and caused his death. On the issue of his murder, the trial judge relied on circumstantial evidence to incriminate the appellant in the murder.

Aggrieved by the conviction and sentence, Sikujua Idd appealed to the Court of Appeal of Tanzania. After his appeal he got defence counsel who dropped his original memorandum of appeal in which he had presented seven grounds of appeal.

Instead, his defence counsel presented a supplementary memorandum of appeal which stated only one ground that the trial High Court Judge erred both in law and fact by convicting the appellant based on the prosecution's case which did not, by circumstantial evidence, prove the offence on the standard required by law.

However, the state attorney opposed the appeal on behalf of the Republic. He submitted that the prosecution successfully discharged its burden of proving the case of murder against the appellant and added that the circumstantial evidence which the prosecution presented irresistibly pointed to the appellant as the person who killed his father.

During the weighing of evidence, the Court of Appeal cited the case of Shaban Mpunzu (Elisha Mpunzu v R, criminal appeal No 12 of 2002 (unreported) restated that "in a criminal case based purely on circumstantial evidence, the evidence must irresistibly point to the accused's guilt and exclude any other person."

Furthermore, the Court of Appeal said there was a gap in the circumstantial evidence provided regarding who had killed Idd Buturumbe (the appellant's father), adding that it could be the appellant or any other person.

Citing another case of Francis Alex v R, criminal appeal No 185 of 2017 (unreported), the Appeals Court said the trial court rejected circumstantial evidence, which relied on the evidence of trails of blood found at the compound of the appellant because the prosecution did not make any effort to ascertain whether the blood was of a human being and of the person who was killed.

It said further that where the prosecution case relies on circumstantial evidence, proof of oral confession is only one of the several links in the chain of circumstantial evidence requiring proof beyond reasonable doubt. "It cannot stand alone to sustain a conviction," the court said.

Stressing this point, the Court of Appeal cited the case of Said Bakari v R, criminal appeal No 422 of 2013 (unreported) in which the court said: "It is established law that a charge of murder can be fully proved by circumstantial evidence. In determining a case centred on circumstantial evidence, the proper approach by a trial court and an appellate court is to critically consider and weigh all the circumstances established by the

evidence in their totality, and not to dissect and consider it piecemeal or in cubicles of evidence or circumstances."

In the circumstances, the three justices of appeal led by Chief Justice (CJ) I.H. Juma concluded that the appellant's conviction by the trial court on the basis of circumstantial evidence could not stand. Thus, the Court of Appeal allowed the appeal, quashed the appellant's conviction for murder and set aside his sentence of death by hanging. It also ordered the appellant to be immediately set free, unless he was otherwise lawfully incarcerated.

Today's legal maxim: "In law the proximate, and not the remote cause, is to be regarded."

# Freeze of loans to Uganda doesn't mean World Bank is becoming human rights watchdog

ANY people may be tempted to view the World Bank's recent announcement that it will freeze new loans to Uganda because of the country's vicious anti-LGBTIQ+ law as a harbinger of the Bank taking a more progressive approach to human rights issues.

While the announcement is welcome, based on my many years studying the Bank and on my research for my forthcoming book, The Law of the International Financial Institutions, I think there are good reasons to be cautious about its significance.

The World Bank, which has been operating for over 75 years, has 189 member states as shareholders. It funds development projects and programmes in member states that have annual per capita incomes below about US\$12,535. The member states elect a Board of Executive Directors that oversees the Bank's operations and approves all its loans.

The Bank's Articles of Agreement stipulate that it cannot base its decisions on political grounds. The articles state that the Bank "shall not interfere in the political affairs" of its member states. Nor should its decisions be influenced by the "political character" of these states.

Moreover, the Bank is instructed that it should only pay attention "to considerations of economy and efficiency". And that it should not be affected by "political or other non-economic influences or considerations."

The articles don't define these key terms. They also don't identify the criteria the Bank should consider when deciding if a particular issue should be excluded from consideration because it is "political" rather than "economic".

This means that this decision is within the exclusive discretion of the Bank's decision makers.

The Articles were drafted and agreed in 1944. At the time, the division of responsibilities between those who made the "political" decisions and those who made the "economic" ones seemed relatively clear.

It was assumed that each Bank member state, as an exercise of its sovereignty, would decide for itself how to deal with the social, environmental, and cultural impacts and consequences of the particular transaction for which it was seeking the Bank's support.

The Bank, on the other hand, would take the state's decisions on these issues as given. It would merely consider if the particular loan request was technically sound and

economically and financially feasible.

This division of responsibility, of course, was unrealistic. The Bank's Board of Executive Directors must approve each loan. They represent its member states. It is inevitable that officials elected or appointed by - and ultimately accountable to states - will pay close attention to the political implications of their decisions. And that these considerations may trump the technical merits of the transaction. Thus, inevitably, political considerations, including human rights, have always been, at least implicitly, a factor in Bank operations.

The futility of the Bank's attempt to exclude political, including human rights, considerations from its operations can be seen at two levels. Firstly, at the level of the Bank's relations with its member states. Secondly, at the level of individual transactions.

A good example of the Bank's failed efforts to exclude political factors at the

country level was its decision in the 1960s to lend to Portugal and South Africa to fund the construction of the Cahora Basa dam in Mozambique.

The Bank decided to make this loan despite a UN General Assembly effort to impose sanctions on these countries because of their colonial and apartheid policies.

Many African states, supported by a majority of UN member countries, argued that the loan should have been denied. Their case was that the policies of the borrowers violated the human rights of their subjects. They were also a threat to regional peace and security.

The Bank's General Counsel defended the decision on the basis of the political prohibition in the Bank's articles and on the technical merits of the project. Despite its ostensible non-political position, the Bank did not make any further loans to South Africa until it became a democratic state.

At the individual transaction level, the Bank funds projects and programmes that have profound social and environmental impacts. Consequently, it is forced to pay attention to some of the political, including human rights, implications of these projects and programmes. For example, if it finances a road or a renewable energy project, the project will require land. The current occupants of the land may need to be moved to make way for the project. Alternatively, the project may have social and environmental effects that hurt people. It could, for example, affect the surrounding community's ability to grow food, or place the community at higher risk of accidents or exposes more young girls and women to the risk of gender-based violence.

If the affected community belong to minority groups in the country, with their own language, culture, and geographic attachments, they may qualify as indigenous peo-

ple under international law and the Bank's policies. In this case, the project may require their free, prior informed consent. However, there are disagreements among states and between the Bank and some of its member states about which communities qualify as indigenous and what is required to ensure that their rights are respected.

For example, some states and Bank stakeholders contend that it is enough to seek the consent of the community's leadership. But others maintain that the consent can only be established if particular vulnerable groups within the communities, such as women, youth, LGBTIQ+, or disabled people, are given specific opportunities to express their consent.

Some states may argue that giving such attention to these vulnerable groups is inconsistent with local practices and customs and that the Bank, pursuant to its own Articles, should not be interfering with these internal "political" matters.

In all these cases, the Bank has to exercise judgement. This means, for example, that in the Uganda case, the Bank could decide that it should not extend any new credit to

However, it is also easy to see that in another context the Bank - or its Board of Executive Directors - may conclude that on balance it is better to continue lending to the particular country despite serious human rights issues. Or to a particular project because the perceived benefits outweigh the costs. The challenge, of course, is ensuring that the Bank is making these decisions on a principled and predictable basis. And not according to its own whims and political preferences. And that it can be held accountable for the way in which it makes the decisions.

# Growing feminisation of migration in Cuba poses new challenges

MIGRATING from Cuba was an agonizing decision for Ana Iraida. She left behind family and friends; in her backpack she carried many hopes, but also the fear of facing dangers on the journey to the United States.

"My salary and that of my second job, as an editor, were insufficient. I wanted to prosper and help my parents. Nor did I want to have a child in a country where it is an ordeal to buy everything from disposable diapers to soap, not to mention food," the 33-year-old philologist who, like the others interviewed for this story, asked to withhold her last name, told IPS.

After selling her apartment in Havana, she left for Nicaragua in December 2022.

"Some friends lent me the rest of the money I needed. I reached Mexico by land. I paid 1,800 dollars to be taken to the (U.S.) border. I crossed and turned myself in to the border patrol in Yuma, Arizona, on New Year's Day," the young woman said from Houston, Texas, where she now lives.

Estimates put the number of Cubans who emigrated in 2022 at 300,000. Of these, some 250,000 attempted to reach the United States, the country that receives the largest inflow of Cubans and that is only 167 kilometers from Cuba across the Straits of Florida.

The increase in the exodus from this Caribbean island nation of 11 million people is happening against a backdrop of a worsening economic crisis, fueled by COVID, the stiffening of the U.S. embargo, partial dollarization, waning purchasing power of salaries and pensions, shortages of essential products and inflation.

Added to this are failures and delays in the implementation of a set of reforms to modernize the country, approved in 2011, and the unsuccessful implementation of monetary reforms since January 2021.

Local officials here argue that the U.S. Cuban Adjustment Act - known as the "wet foot, dry foot policy" - in force since 1966, encourages the exodus, since it made all Cubans eligible for permanent residency a year and a day after setting foot in U.S. territory.

In the past, the rule benefited all Cubans who set foot on U.S. soil. But since January 2017 it only applies to those who have entered the country legally.

However, the flow of Cubans into the U.S. slowed after President Joe Biden's administration adopted on Jan. 5 a temporary humanitarian residency permit program known as parole, similar to the one implemented in October 2022 for Venezuelans and previously for people of other nationalities.

As of the end of July, more than 41,000 Cubans had obtained temporary parole, 39,000 of whom had already reached the country, the U.S. Customs and Border Protection (CBP) reported on Aug. 18.

In addition, after a four-year freeze, on Jan. 4 the U.S. Embassy in Havana resumed processing immigrant visas, a decision that the Cuban government welcomed as a "necessary and correct step" aimed at guaranteeing regular, orderly and safe migration.

### **Risks and impacts**

International organizations and human rights groups warn of the risks faced by immigrants en route, especially women, children and the elderly, who are





the feminization of migration, generates significant impacts on demographic, physical, economic, cultural and gender indicators in regions and countries.

Cuba's January 2013 immigration reform eliminated the requirement for exit permits and letters of invitation for nationals residing on the island, extended from 11 to 24 months the time they could stay abroad without losing residency, and repealed legislation that allowed the confiscation of assets of those who left the country.

Subsequent regulations have also favored increased travel abroad for personal reasons and the possibility of living temporarily or permanently outside the country, opening the doors to a better relationship with the Cuban exile community.

Women make up a majority of those seeking temporary residence abroad, while men are a majority among those who decide to live abroad permanently, revealed the report of the National Migration Survey (Enmig 2016-2017), published by the National Bureau of Statistics and Information (Onei) in January 2019.



In the case of women, "getting closer to or visiting family", "supporting or caring for family members" and "helping their family here" (35 percent) are the most important motives, while they were the main motives for only 21 percent of the men.

### Focusing on care

Researchers have called for more attention to be paid to the relationship between the feminization of migration and the burden of care.

In the case of Cuba, they say, migration itself often becomes a complementary strategy to face the problems associated with caregiving.

The economic crisis, the aging demographic and the emigration of young people and professionals are placing additional



obstacles on caregivers to provide food, buy medicines and manage supplies.

"I moved to Ecuador seven years ago," Betsy, a 38-year-old teacher, told IPS from the city of Guayaquil. "My two children were born here. My work makes it possible for me to send money, medicines and other products to Cuba to take care of my 80-year-old father, who has senile dementia. Otherwise, it would be very difficult for my older sister to provide adequate care for him."

In Cuba, 22.3 percent of the population is over 60 years of age, and by 2025 it is estimated that one in four of the island's residents will be an older adult.

The National Gender Equality Survey, published in 2019, showed that Cuban women spend an average of 14 hours more than men on unpaid work per week, which includes caring for the elderly, chronically ill and dependent persons, as well as helping children and adolescents with their homework.

For its part, the 2017 National Survey of Population Aging (Enep), whose data came out in 2020, showed that about 68 percent of those who provide care are women and most are over 50 years old.

In the case of needing care, more than 57 percent of the population over the age of 50 prefers to receive it from women, according to the study.

"I chose to stay and live in Canada almost two years ago," said Rocio from Halifax, the capital of the Canadian province of Nova Scotia. "It has been an ordeal, but I have no regrets. It's a way to help my 11-year-old son and my retired parents, who are taking care of him until we can be together again."

The 40-year-old translator, who lived in the eastern Cuban city of Holguín, told IPS that "with my salary, my son and I were living on a tight budget. I could hardly help my parents, whose pensions barely covered the household bills, medicines and the few foodstuffs they could afford. I am far away, I suffer from the separation, but every month I can send them money so that they can live more comfortably and eat better."

more likely to become victims of abuse, mistreatment, discrimination, extortion, kidnapping and sexual violence by organized crime groups.

"The journey was stressful," said Ana Iraida. "I could have been robbed of my money, raped or even murdered. Almost two years ago, when the airports reopened after the COVID pandemic, some young women who lived near my house left and their families never heard from them again."

Other migrants never reach their destinations and remain trapped in transit countries in overcrowded conditions or as victims of violence.

I was also worried "that they would detain me and send me back to Cuba, and that in the end I would have no home to return to, and be in debt," added Iraida.

According to the International Organization for Migration (IOM), women account for 48 percent of international migrants worldwide and an increasing number are migrating independently, including as heads of households, in search of new opportunities, to join their families or to help relatives in their home countries.

Research indicates that this phenomenon, known as

Increasingly young and femaledominated emigration is challenging national development plans on a sustainable basis.

"This situation calls for further research and public debate on the present and future impacts of demographic dynamics such as migration and aging as they relate to the social organization of caregiving on the island," argues Cuban sociologist Elaine Acosta.

In the opinion of Acosta, executive director of "Cuido60, Observatory of aging, care and rights", there is an urgent need "to accelerate and deepen structural reforms so that migration ceases to be a daily survival strategy and, at the same time, to obtain the necessary resources to implement appropriate and integrated social policies to face the current and future challenges of aging."

# Africa's green business opportunities abundant, research by UNEP finds

FRICA'S private sector can bolster its green agenda and drive increased GDP, higher income per capita, create tens of millions of jobs, and foster collaboration between governments, businesses and local communities.

This is according to a comprehensive study published by the UN Environment Programme (UNEP).

The Africa Environment Outlook for Business is launched as 54 African ministers of environment are gathered in Addis Ababa for the 19th session of the African Ministerial Conference on the Environment (AMCEN). It recommends businesses adopt a holistic approach anchored in profit, people, planet, prosperity, peace, and partnerships.

Elizabeth Mrema (pictured) UNEP Deputy Executive Director, said: "This report shows that policymakers can create an enabling environment for investments that address the triple planetary crisis by adopting robust regulatory frameworks, investing in research, innovation, and education, as well as promoting public-private partnerships and fostering collaboration across governments, businesses and local communities."

The report showcases a range of success stories of green ventures today, as well as data on the potential for growth across sectors.

Transitioning to sustainable agriculture, which currently contributes about 17 per cent to sub-Saharan Africa's GDP. Embracing organic farming, precision agriculture, and agroforestry are some of the approaches that can enhance productivity while minimizing negative impacts on ecosystems and avoiding food insecurity

### and biodiversity loss.

Digital technologies in agribusiness offer a US\$1 trillion market towards feeding the continent's growing population, estimated to reach 2.5 billion by 2050.

Combating soil erosion can have net benefits in nutrients - such as nitrogen, phosphorus, and potassium worth US\$62.4 billion annually.

Restoring nature can unlock a business value of \$10 trillion and create 395 million jobs by 2030.

Through research, innovation and managing aquatic ecosystems, the resilience of the blue economy - projected to generate US\$576 billion and 127 million jobs by 2063 - must be sustained in the face of overfishing, pollution, and climate change.

Marine and coastal tourism presents tremendous opportunities for sustainable development in Africa, with potential value-added of over \$100 billion by 2030.

Africa can become a trailblazer in renewable energy solutions, with abundant solar, wind, hydro, biomass, and geothermal resources that may contribute to a 6.4 per cent increase in GDP from 2021 to 2050. Ocean renewable energy is a vast untapped resource for Africa, with the potential to generate between 100 to 400 per cent of current global energy demand.

Businesses in the energy efficiency sector can provide products and services, such as lighting systems, smart buildings, and efficient industrial processes.

An annual funding gap in climate financing of \$213.4 billion offers innovative investors a chance to make an impact by building Africa's climate resilience.

Significant reserves of critical minerals like copper, graphite, lithium, molybdenum, nickel, zinc, bauxite,



cobalt, manganese, and platinum handled responsibly - make Africa essential for electric vehicles, solar PV cell technology and wind turbines. 'Cool roof paint' can reflect up to 95 per cent of solar heat and the need for air conditioning; investments in clean cooking energy sources can support 900 million (resulting today in poor health and deforestation), and the African LED lighting market may almost double by 2028, reaching US\$5.49 billion.

Opportunities in promoting sanitation, tackling plastic waste, recycling infrastructure, sustainable packaging, e-waste collection and refurbishment.

In the agro-food industry, efficient supply chains and food waste reduction can enhance resource utilisation while meeting growing food demand.

Plant-based proteins and food safety systems can further drive growth and sustainable practices.

The European Union-funded SWITCH Africa Green initiative and SwitchMed programmes, which exemplify the viability of turning to a circular economy in benefitting more than 3,000 MSMEs and eight sub-Saharan African countries in agriculture, integrated waste management, manufacturing, and tourism.

The fast-growing fashion and textiles sector in sub-Saharan Africa is valued at approximately \$31 billion and presents opportunities such as

sustainable material sourcing, recycling, ethical manufacturing, rental and sharing models, and consumer education.

The African automotive market is dominated by used vehicles, paving the way for businesses to thrive in vehicle recycling, remanufacturing, battery recycling, shared mobility solutions, repair and maintenance services, circular supply chain management, and training and skills development.

The financing gap for environmentally sound technologies (ESTs) must be addressed. In 2020, only \$6.07 billion flowed into the continent for ESTs, while the global exported technology value reached \$1.17 trillion. A pipeline of 360 ongoing sustain-

able infrastructure projects worth \$100 billion in sectors - including energy, information and communications technology (ICT), logistics, mining and construction (as of 2022) and additional tentative projects in the same sectors valued at \$257 billion, demonstrates the continent's diverse investment opportunities in the transition to net zero emissions.

Despite immense potential, Africa utilizes only a fraction of its carbon credit capacity concentrated in only five countries, due to fragmented projects, a scarcity of large-scale developers, regulatory uncertainties, credibility concerns for certain credits and equitable value distribution.

Africa's untapped potential is estimated at approximately 2,400 metric tons of CO2 equivalent (MtCO2e) per annum. It could achieve an additional 400 MtCO2e yearly, valued at around US\$7 billion per year by 2030.

Initiatives such as the African Carbon Market Initiative (ACMI) and the Taskforce on Scaling Voluntary Carbon Markets (TSVCM) recommend regional and global actions to scale the supply and demand for high-integrity carbon credits.

The report notes unique challenges to many African economies, including limited investments, institutional capacity, scalability, high transaction costs, effect transportation, and access to- and affordability of electricity. Reducing upfront costs and promoting energy-efficient solutions, and innovative financing mechanisms must all be prioritized by policymakers.

"Africa faces not just incredible challenges on climate change, nature loss, and pollution, but has a uniquely dynamic economic landscape, youthful demographic, and opportunities for decarbonization, digital transformation and for leveraging an environmental, social and governance (ESG) framework for sustainability in the business sector," said Rose Mwebaza, UNEP Director and Regional Representative for Africa.

"With this new report, we hope to inspire African entrepreneurs and businesses, especially audacious first movers, to engage in green growth and contribute to sustainable development goals."

ICRC sows seeds of hope for conflict-affected young farmers in Cameroon

BOUKARA Abba, a smallholder farmer in the Mozogo locality of Cameroon's Far North region, looked happily at his flourishing maize and okra which he planned to harvest next month.

It was a couple of minutes after midday as it drizzled on Abba's approximately three-hectare farm.

The 31-year-old is one of several young people who have found fortune in agriculture in the volatile region. Since 2014, a wide area of the region is suffering from the fighting between Boko Haram, the terrorist group, and government forces.

Many communities in the region have faced renewed violence in recent months. The armed conflict and worsening humanitarian crises have left the region's agriculture sector struggling as more than half of the displaced persons come from agricultural backgrounds.

Some of them were reported to have one meal a day with children and women suffering the most.

Thanks to an agricultural program by the International Committee of the Red Cross (ICRC), however, the displaced persons are now earning a living through farming.

"There was no one to give us seeds before the Red Cross arrived," said Abba who hosts 20 displaced people in his house.

So far this year, the ICRC initiative has assisted 26,000 displaced people, returnees and host communities with agricultural inputs and cash to increase their crop production, said ICRC agricultural engineer Nouratou Bouba Hadja.

"We assist them with maize, okra, sorghum and cowpea seeds. We give fertilizer to families affected by the conflict and in homes, young people are the most active in the production chain. When we identify a household, it is generally young people who work on the farm," said Hadja who had come to supervise Abba's farming activities. "The objective is to improve agricultural production of these vulnerable families and after the production, they can now eat and sell their products to take care of other needs such as health needs or the education of children. It is a revenue-generating activity for these families."

For Abba, the agricultural program has lifted young people out of poverty and unemployment. "Everything has changed. Production has increased. As a young man, we were unemployed. Today ICRC came (and helped us) and now we are living our lives," said the father of three.

For Gui Daidi who was displaced from Zeleved



village, there is never a

ily. question that his six children would have to get their hands dirty and learn how to grow their own food.

"The ICRC program has helped young people to stay away from crime and trouble. No other job could provide the same security as farming because people will always have to eat so there is always money to be made," said the 57-year-old who now lives in Mozogo with his fam-

In Kerawa, a locality in the region that shares a porous border with Nigeria and is notorious for constant Boko Haram raids, Hadja Cheripou gets set to prepare the evening meal.

The 57-year-old fled to settle in Kerawa during the heat of the conflict to restart her life. She said that before now, the community leader and some good people in the locality were assisting her and

her 13 children with food and other daily needs. Now with the good harvest she got from the seeds and cash assistance, she is able to take care of her family. "My children and I now have enough to eat. Life is better now," she said.

"We had nothing. My children and grandchildren now feed well," said 54-year-old Wandala Hoda whose 22 children are now all farmers. The agricultural partner-

ship between the Cameroonian government and ICRC has made farming profitable and cool for young people and the region safer, said Simplice Sadou, Far North regional chief of agriculture and rural development.

"Since this partnership started two years ago with ICRC, we've had a good quantity of quality seeds that are produced in the region," Sadou said. "Seed industry is very important. We have

many young people in the industry and this partnership has increased their capacity and today, in all the zones where the partnership is operational, there is an increase in revenue because of the quality of the seeds."

As the world commemorates International Youth Day on Aug. 12, young people affected by the armed conflict in the region now find a sense of purpose in the valuable farming skills they have brought to their new communities.

# **BRICS** expansion adds clout to bloc, but also imports new tensions

DMITTING six new members to BRICS will add heft to the bloc's efforts to rebalance the global economic and political order. But it will also bring its own problems, including importing new tensions.

And, in particular, accepting Iran raises the prospects of souring relations with the US and the wider West

The five BRICS leaders announced on Thursday after their 15th summit, in Johannesburg, that they would admit Iran, Egypt, Ethiopia, Argentina, Saudi Arabia and the United Arab Emirates as full members on 1 January 2024. Twenty-two countries had formally applied for membership, and wrangling over which to admit delayed by a day the release of the summit declaration and the announcement of the new members.

At the BRICS outreach summit on Thursday, when the BRICS leaders were joined by about 60 other world leaders, they all agreed that the expansion of BRICS from five to 11 members would give it greater clout.

Brazilian President Luiz Inácio Lula da Silva said the addition of the six members would increase the combined GDP of the BRICS countries to 37% of global GDP in purchasing power parity terms and increase its share of the world population to 46%. He dismissed concerns that the bloc would become too unwieldy, saying its expanded membership would help it to find creative solutions to the problems facing the world.

Anil Sooklal, South Africa's chief diplomat or "Sherpa" on BRICS, said that taking on three oil-rich countries - Iran, Saudi Arabia and the UAE - would bring in a new part of the global economy which had not been represented and would further strengthen the bloc.

He dismissed concerns that admitting Iran could fundamentally alter the character of BRICS and antagonise the US and the West.

"Not at all. Iran has no problem with BRICS. It's the West that has imposed unilateral sanctions against BRICS," he added, referring to Western sanctions on Russia and Iran.

"BRICS doesn't recognise unilateral sanctions. Iran will add value, so will Saudi Arabia and the UAE.'

Li Kexin, the Chinese director-general of international economic affairs, also dismissed these concerns, insisting that BRICS was not an anti-Western alliance and that the expansion did not change that. "We are not seeking confrontation," he insisted.

He was asked, though, if accepting Iran as a new member would not heighten tensions with the US, which has a hostile relationship with Tehran. Li recalled that China had recently mediated a reconcilia-

tion between Iran and its regional rival Saudi Arabia.

"Happily, they both joined BRICS together," he added, saying that BRICS could now become a platform for continuing to improve relations between Iran and Saudi Arabia.

#### **Potential tension**

However, Gustavo de Carvalho, a senior researcher on Russia-Africa ties at the South African Institute of International Relations, cautioned that the expanded membership could import some problems.

He noted that Lula had championed Brazil's neighbour Argentina, which currently, like Brazil, has a progressive government. However, he warned that either a centre-right or a far-right party in Argentina was favoured to win the elections in October and this could usher in an anti-BRICS government.

Despite China's brokering of a reconciliation deal between Iran and Saudi Arabia, he said, there were still considerable tensions between them.

He believed that admitting Egypt and Ethiopia could import the tensions between the two countries over Ethiopia's construction of the giant Grand Ethiopian Renaissance Dam on the Blue Nile, which Cairo says could endanger its vital water supply.



De Carvalho said relations between Iran and Argentina remained strained by suspicions that Iran had been behind a major terrorist attack on a Jewish centre in Buenos Aires in 1994.

Nevertheless, he added that BRICS was already an organisation of five countries with very different interests and that China and India had continuing border disputes which had recently flared into warfare.

De Carvalho said he believed Russia had sponsored Iran's admission not only for ideological or geopolitical reasons, but for economic reasons as it sought new markets in the Middle East and Africa to replace those lost in Europe because of sanctions against its invasion of Ukraine.

He said South Africa had backed Egypt and Ethiopia to get another African country into the bloc.

Saudi Arabia and the UAE were probably backed by China and India, respectively, though he added there was probably wide consensus on admitting the rich oil states, not least because they would boost the bloc's economic heft and make the move towards trading in local currencies – rather than the US dollar – more viable.

### **Criteria for membership**

Sooklal said the guiding principles for the selection of additional member states had been finalised by heads of state only on Tuesday.

These included that countries should have a substantial population, should be from the Global South modalities of how we go about partner countries and make a determination on when a further expansion will be appropriate.'

There has been much speculation about whether BRICS would change its name and some tonguetwisting new acronyms have been proposed on social media.

But Sooklal said he did not think the name would change - or at most would change to BRICS-Plus. He noted that the G77 + China had not changed its name even though it now had 120 members.

"The name BRICS has become a global brand in terms of championing the Global South. So we are confident the term BRICS will remain."

Sooklal explained that it was important the six new members fully embraced all dimensions of BRICS cooperation and fully grasped how BRICS functioned. He believed the differences between the countries would not be a stumbling block for the forum.

"We are not saying BRICS must be a homogeneous entity – the

and be in good standing in their regions. They also sought to have a fair geographic representation, coupled with diversity.

"I think it is a good mix because it is one of the guiding principles. We admitted a country - Argentina from Latin America, two from Africa, Egypt and Ethiopia, and three from Western Asia. We are looking to develop the criteria for partner countries, and ministers have been tasked to formulate criteria," he said.

Li disclosed that until the last minute, the five BRICS leaders had only intended to admit new members as BRICS partners. But they had then realised they had to take the candidates more seriously and admit them as full members. He said the BRICS foreign ministers had been tasked with establishing partnerships with the others in the list of 22 that had formally applied for membership but had not been granted it this week.

Sooklal said even with 11 countries, the expanded BRICS was a small group out of the totality of the Global South.

"The door is not shut on the other members who have not been admitted. So we now have to work on global community is not homogeneous. Yes, there are differences, but we are not bringing those into the BRICS group; we are mature enough to bracket those," he said.

Many were surprised by Indonesia's exclusion from the expansion while Ethiopia was asked to join the grouping instead.

Daily Maverick understands that the BRICS leaders could not reach a consensus about inviting Indonesia, with one country refusing to back this move.

Ethiopia and Egypt were endorsed by South Africa. Daily Maverick understands that the inclusion of Ethiopia was because South Africa did not only want to include a country from North Africa while it also felt that Egypt was perceived as a Middle Eastern country. **DM**

# Tea farmers to start processing their leaves through cooperatives

Tea farmers will start to process their produces through their cooperatives, thanks to the new programme planned by the Tanzania Tea Board (TTB).

Mkonya, TTB Nganga economist said this recently at the just ended Afro World Afri Food 2023 International conference, exhibition and awards took place at the Diamond Jubilee which was attended by local and foreign participants.

"To start with, smallholder tea grower in Sakale village, Koregwe district, Tanga Region have already installed small scale processing factory with the capacity to produce 15.6 metric tons of tea leaves per annum with the support from Care International and TBT as pilot project," he said.

The main goal is to promote value addition to tea leaves at high quality in order to meet both local and international markets standards.

TBT is also sensitizing co-

operative societies across the country) to establish investment fund through Tanzania Smallholder Tea Growers Cooperative Union (TASTGCU) that will assist them to build 20 small scale tea processing factories in 14 district councils where the crop is cultivated. He said the government has also planned to purchase and install of small scale machines for processing specialty tea in 14 districts.

Elaborating on the major efforts that are undertaken by the board to promote the tea production, he said TBT is sensitizing smallholder tea growers in all growing areas to set up irrigation farming system in their farms to enable them operate their farming activities more effectively during the draught season in order to cope with the climate change.

Also the government has plans for constructing of irrigation channels in tea farms as a way of sufficing the raw material (green leaf tea) re-



quirements, especially during the draught season (June to October).

In a bid to help farmers reduce transport cost, the government has been able to establish Dar es Salaam Online Tea Auction to address the high transportation costs to

Mombasa Tea Auction.

The online auction will be located at Mivinjeni area in Temeke Municipal Council and will be supervised by Dar es Salaam Based Company-Bravo Group Ltd.

Tanzania has big potential to penetrate in international market because of the agroecological zone it has - that is equatorial regional to lead in this market.

Currently Tanzania has 30,000 smallholder tea growers who mostly depend on tea farming as the source of income, employment and

household earnings.

Among those 80 percent are in Southern Highlands in Njombe, Iringa, Mbeya and the remained farmers are in Nothern Highland -Tanga Region, Kagera and Mara Regions.

In Tanzania, tea is one of

the most important cash crops that help Tanzania to obtain foreign currency and 80 percent of tea produced in Tanzania is exported in overseas because of its uniqueness.

He called on investors from USA, Africa, Europe and Asia continents to come in Tanzania to invest in tea farming and processing.

Highlighting on tea trade, he said in 2021, a total of 26, 550,260 Kg of tea that is equal to 13 percent were exported and sold within the country.

Among those, a total of 3,393,176 Kg of tea were sold within the country, 8, 585.570 Kg were exported through Mombasa Tea Auction while the remained 14,571,514 Kg of tea were exported direct in other countries.

Also in 2020, a total of 26, 730,090 Kg of tea that is equivalent to 17 percent were also exported and sold within the country.

Among those, 4, 607, 592 kg of tea were sold in Tanzania, 8,627,096 kg of tea exported through Mombasa Auction and 13,495.402 Kg of tea were exported directly in other countries.

# **China attracts** global investors to shore up market

Fidelity International Ltd. and Goldman Sachs Group Inc. are among those invited, one of the people said.

China has long relied on large domestic investors to support markets during volatile times, but is now stepping up efforts to influence some of the biggest global funds.

He called for Rufiji residents to use the bank for both individual and business purposes not only through the physical branch, but also agents as well as other digital channels.

"Many people believe that bank is a place of depositing and withdrawing cash, but the truth is this is a place where you can get investment advisory, which is rarely used by many people. Through our CRDB Bank Foundation, we facilitate investments among women and youths through giving them seed capital and financing at affordable requirements," he said.

The meeting came two days after a seminar with some of China's largest institutional investors where the regulator urged the state pension fund, large banks and insurers to increase stock investments.

Global funds have been fleeing the mainland market, offloading almost \$11 billion in a thirteenday run of withdrawals through Wednesday, the longest since Bloomberg began tracking the data in 2016.

China's economy is struggling to regain momentum following years of Covid restrictions, a housing slump and a crackdown on the country's private sector.

Separately, regulators unveiled a further easing of its mortgage policies on Friday to revive its residential property market.

The CSI 300 Index of shares in Shanghai and Shenzhen dropped 0.4 percent on Friday, extending its slump this month to 7.6 percent and keeping it as one of the world's worst performers this year.

A top Chinese hedge fund has blamed foreign investors for sinking the stock market. Li Bei, founder of Shanghai Banxia Investment Management Center, said in an article posted on social media platform WeChat that overseas investors have stirred up market volatility and, "taken together, they are a bunch of aimless flies.

That said, foreign funds have accounted for just around 6 percent of the total onshore turnover this year. Overall, they own less than 4 percent of total A-shares outstanding, according to a report this month from China International Capital Corp.

The CSRC didn't respond to a fax seeking comment. Fidelity and Goldman declined to comment.

Beijing officials have been on the offensive over the past months in trying to reassure investors of the strength of the economy and their openness to foreign investors. A Politburo statement in July promising more support sparked an initial rally that quickly faded away as economic data continue to disappoint and stimulus fails to impress.

China has taken a series of steps to boost investor confidence recently, including guiding mutual funds to buy their own products, encouraging companies to step up share buybacks, and asking mutual funds to avoid dumping stocks. That has achieved little so far, with the CSI 300 Index now hovering near its lowest since November.

Kilolo District council collected total revenue amounting to 4.1bn/- during the financial year 2022/2023, which is equivalent to 88.1 percent of the targeted 4.8bn/-.

The Kilolo District Council Planning Officer Lucas Daudi, who represented the District Executive Director (DED) Laini Kamendu said during the financial year 2022/23, the district council was authorized to collect, receive and spend 49.1bn/ - for paying staff salaries, other expenses and the implementation of development projects.

Until June 30, 2023 a total of 41.63bn/have been received equal to 88.4 percent, of which the council's internal revenue budget is 4.8bn/-, but so far, 4.1bn/- have been collected, explained Daudi.

He said the success resulted from cooperation between councilors, executives and the use of electronic tax collection machines, close monitoring and creating revenue monitoring teams formed at the council level.



In another step, the council has started to install CCTV cameras on barriers and gates to monitor revenue collections on food crops and forests products, to prevent the loss and leakage of revenue.

The district commissioner Peres Magiri has therefore congratulated the district council authority for collecting 4.1bn/revenue, but directed the council to take

legal action against employees who were involved with the loss of 175mn/-.

"I would like to take this opportunity to direct that we cooperate in uncovering who were involved in a loss of income through various sources including through Point of Sales (PoS), so all those involved in the loss should be taken legal action...," said Magiri.

DC Magiri mentioned the areas where the cameras have already been installed as Ndiwili on the border between Kilolo and Iringa districts and Ruaha-Mbuyuni, bordering Kilolo and Morogoro districts respectively.

"If we install these cameras and then they are tempered with especially to the young people who are in charge of the gates, we ask them to be very careful because they may find themselves in trouble," he said. He added that the council needs to collect sufficient funds in order to implement various development plans and projects.

Kilolo District Council Chairperson Anna Msolla said the district council is expected to take legal actions against women, youth and people with special needs groups who have failed to repay their loans they borrowed from allocated a special district fund as required by the government.

Msolla emphasized that for groups that will fail to repay their loans by 30/09/23, legal action will be taken including being brought to the court.

# **Teachers doubt Civics subject replacement**

ivics professional teachers for primary and secondary schools are skeptical of the Ministry of Education, Science and Technology decision of replacing the subject with a new one.

The final draft of the 2023 revised curriculum and the 2014 education policy 2023 edition suggest for the replacement of the subject.

The final draft of the 2023 curriculum suggests that Civics shall be replaced by the new subject known as History of Tanzania and Ethics which according to experienced teachers and education stakeholders will hold back efforts towards grooming responsible citizens from school.

Gratian Mukoba, former president of the Tanzania Teachers Union (TTU) said in an exclusive interview earlier this week in Dar es Salaam that he doesn't see the new proposed subject embracing civic education but historic events from

"I don't see the new subject setting a proper civic education to be taught to students at all levels. Civics is most important in creating a responsible community. It is the subject that teaches people's responsibility to their nation and basic rights they should demand from the government," said Mukoba.

According to him, social issues such as the implication of corruption in the country's economy, democracy, rule of law, and human rights are a must for children and youth to learn from the grassroots stage of their education.

"You cannot build a nation of civilized and responsible people by only teaching past events which most of them have no relevance in today's lifestyle," he defended. Mukoba who started

teaching Civics, History and English subjects in secondary schools in 1981 to his retirement in 2017, said Civics is one of the oldest subjects taught since colonial rule. However, he said the

subject was replaced by the Politics subject in 1965. He said after Tanzania had adopted the Bill of Rights in its 1984 constitution and the multiparty system in 1992, the subject resumed again in primary and secondary schools in 1994.

He further pointed out that the curriculum doesn't identify how the national constitution for instance will be taught.

# regain control of copper and cobalt assets

**DRC seeks to** 

### **KINSHASA**

The Democratic Republic of Congo (DRC) wants to buy back some of the country's prized copper and cobalt deposits, as the government tries to gain more control of crucial green metals.

The assets are some of those owned by Eurasian Resources Group, a Kazakh-backed miner and major cobalt producer with dozens of DRC mining and exploration permits. The government and state-owned miner Gecamines say ERG has been too slow to develop them - and Gecamines in June told ERG it wants to take some over, according to a July letter seen by Bloomberg that was sent by the office of Congolese President Felix Tshisekedi to ERG's shareholders.

The offer didn't include ERG's key Metalkol copper and cobalt tailings project or its Frontier copper mine, and no price was mentioned in the letter.

It's the latest attempt by the DRC and Gecamines to regain control of vast deposits of minerals used in things like electric-vehicle batteries. Despite supplying about 75% of the world's cobalt and being a major copper producer, most DRC mines are foreign-owned. Relations between the state and miners have also been strained by issues over environmental damage and a lack of local investment.

ERG didn't confirm that Gecamines had made an offer to buy its assets or whether it's interested in selling any. Talks "are ongoing between ERG and representatives or certain of its affiliates in the DRC, with the objective of maintaining mutually beneficial partnerships," it said in a statement this month.

Gecamines executives and President Tshisekedi's office declined to comment. Congo's mining ministry didn't respond to multiple messages requesting comment

Gecamines has already tried to take control of one of ERG's undeveloped copper and cobalt assets. In a February letter seen by Bloomberg, it told ERG's Africo Resources DRC Sarl subsidiary that it was cancelling its undeveloped Swanmines joint venture and demanded the return of the permit for the Kalukundi concession due to a lack of development.

### **BEIJING/JOHANNESBURG**

A Foreign Ministry spokesperson confirmed on Thursday that Chinese President Xi Jinping talked with Indian Prime Minister Narendra Modi at the latter's request on Wednesday.

Xi also met with leaders of Iran, the Republic of the Congo, Malawi and Namibia on the sidelines of the 15th BRICS Summit.

Xi returned to China on Friday after attending the summit and paying a state visit to South Africa.

According to the spokesperson, Xi and Modi had a candid and in-depth exchange of views on current China-India relations and other questions of shared interest.

Xi stressed that improving China-India relations serves the common interests of the two countries and peoples, and is also conducive to peace, stability and development of the world and the region.

The two sides should bear in mind the overall interests of their bilateral relations and handle properly the border issue so as to jointly safeguard peace and tranquility in the border region, Xi said.

### **Cooperation with Iran**

# G20: Delhi police to ramp up security, impose restrictions ahead of mega summit

### **New Delhi**

WITH the 18th Heads of State and Government Summit of the G20 (Group of 20), scheduled to begin next month in the national capital under India's presidency, Delhi police authorities are busy making special arrangements to ensure smooth vehicular movement during the arrival of the high-profile delegates, including heads of states for the mega event.

SS Yadav, Special CP, Traffic addressed the media on Friday and said that the restrictions on vehicular movements will be imposed from the night of September 7.

"Another major restriction will be imposed on commercial vehicles', SS Yadav added.

However, there will be leeway for ambulances or vehicles carrying essential goods, he stated.

"There will be no restriction on the movement of ambulances, medical services or the people who are needing medical assistance coming by whatsoever mode of transport...", said the Special CP.

Adding further, he said, "We are establishing a special ambulance assistance control room which will have a dedicated helpdesk".

The G20 Summit is slated to take place on September 9-10 at the state-of-the-art Bharat Mandapam Convention Centre at Pragati Maidan.

Special CP Yadav, "We will be issuing a detailed traffic advisory which will give you information about various types of modes of transportation available. The main summit venue is in New Delhi so there will be restrictions in the New Delhi Municipal Council (NDMC) area. It will be a controlled zone in which authorised vehicles or visitors will be allowed".

"In a controlled zone, metro services will be allowed throughout", he added.

The Special CP of the traffic unit also said that a virtual helpdesk will be launched in order to assist the delegates or tourists.

"We will have a virtual help desk for all the users who are visiting Delhi as delegates, tourists as well as citizens of Delhi and other outsiders...We will provide information about various services including transportation services...," he stated.

Earlier on Wednesday, the Delhi police authorities announced that a detailed traffic plan had been chalked out with necessary arrangements to ensure smooth vehicular movement in the national capital during the event.

Many heads of state and diplomats including US President Joe Biden, Chinese Premier Xi Jinping, Canadian Prime Minister Justin Trudeau and French President Emmanuel Macron are expected to be attending the G20 Leaders' Summit.

The 18th G20 Heads of State and Government Summit in Delhi will be a culmination of all the G20 processes and meetings held throughout the year among ministers, senior officials, and civil society. ANI

### Justice department sues SpaceX, alleges discrimination in hiring process

### WASHINGTON

THE United States Justice Department has filed a lawsuit against Tesla Chief Executive Officer Elon Musk's Space X for allegedly discriminating in hiring the people, CNN reported. The lawsuit claimed that SpaceX, from September 2018 to May 2022, aircraft had discouraged the asylees and refugees from applying and refused to hire or consider them because of their citizenship. This falls under the violation of the Immigration and Nationality Act (INA)," according to an August 24 DOJ news release. It further claimed that SpaceX, in its job listings, has posted that only green card holders and United States citizens could work at the company because of federal export control laws. As per CNN, there are specific laws in the US- such as the International Traffic in Arms Regulations – that apply to companies manufacturing spacecraft and rockets and limit foreign nationals from accessing key information about the vehicles for national security reasons. But the new lawsuit states that regulations such as ITAR do not prevent SpaceX from hiring refugees, whose "permission to live and work in the United States does not expire, and they stand on equal footing with US citizens," according to the DOJ.

# Trump's mug shot released after booking at Georgia jail

### **ATLANTA**

DONALD Trump's mug shot was released on Thursday evening after he was booked at an Atlanta jail on more than a dozen felony charges as part of a wideranging criminal case stemming from the former US president's attempts to overturn his 2020 election defeat in Georgia

An unsmiling Trump - inmate no PO1135809, according to Fulton County Jail records - was captured glaring at the camera in the mug shot. The image represented yet another extraordinary moment for Trump, who did not have to submit to a photograph when making appear-

ances in his three other criminal cases. He wasted little time trying to turn it to his advantage, posting it on X, the site formerly known as Twitter, as well as his own social media site, Truth Social. knows it.' Trump, His campaign website featured the mug shot along with a message from Trump defending his actions and asking for do-

nations. The X post appeared to be Trump's first on the site since his account was banned after a mob of his supporters stormed the US Capitol on Jan 6, 2021. X owner Elon Musk reinstated Trump's account late last year.

Trump spent only about 20 minutes at the jail before heading back to his New Jersey golf club. Before boarding his private plane at Atlanta's Hartsfield-Jackson airport, he repeated his claim that the prosecution - along with the others he faces - is politically motivated. "What



already has entered uncharted territory as the first former US president to face criminal charges, even as he mounts another campaign for the White House next year.

Far from damaging his candidacy for the Republican Party nomination, however, the four cases filed against him have only bolstered his standing. He holds a commanding polling lead in the Republican race to challenge Democratic President Joe Biden in the November 2024 election.

Judge Scott McAfee set a trial date of Oct 23 for one of Trump's 18 co-defendants, attorney Kenneth Chesebro. after Fulton County District Attorney Fani Willis proposed that date in response to Chesebro's request for a speedy trial. The judge's order said the schedule does not yet apply to Trump or any of the other defendants. Eleven of his co-defendants already have been booked, according to authorities. Some, like Rudolph Giuliani, the former New York mayor, were stone-faced in their mug shots, while others, such as lawyer Jenna Ellis, smiled for the camera.

Japan's actions epitomize irresponsible ocean pollution and environmental destruction.

Bad deeds inevitably backfire. Japan's arrogance has drawn strong international condemnation and will

definitely be taken countermeasures by impacted nations. The discharge will also cause lasting reputational damage for the country.

Trust and respect are the most valuable things. Japan's ocean discharge aligns with the country's strategic ambitions. It will generate short-term economic gains and faits accomplis, but Japanese leaders prioritizing quick wins will pay far heavier costs.

Japan assumes established facts will force acceptance, but from Aug. 24, 2023 on, it bears a permanent mark of disgrace. The ecological, political, and economic fallout will accumulate globally. ### BRICS expansion, single currency: What Lavrov told reporters at press conference

### JOHANNESBURG

THE reason for the "explosive growth" of BRICS (Brazil, Russia, India, China, South Africa) is that the countries that want to get closer to the association understand the underlying causes of the processes taking place in the interna-



tional arena, Russian Foreign Minister Sergey Lavrov (pictured) told reporters.

All BRICS member countries should make a decision to expand the association with new members, who believe in multipolarity and the need for fairer international relations. Also, BRICS wants economic relations between member states to be independent of the West, so the association plans to work on the formation of an alternative payment system.

TASS has gathered Lavrov's main statements.

### **On BRICS trade**

A single BRICS currency is out of the question now. The member countries want to find ways to ensure mutual trade and economic projects so as not to depend on the system controlled by the US and its allies.

The West has proven "its ability, its willingness to actively abuse its status as an issuer of reserve currencies to achieve political goals in violation of all the rules of the free market, international trade and the World Trade Organization.

BRICS plan to take steps "to facilitate the use of national currencies, but most importantly to create an alternative payment system.'

BRICS finance ministers will form a group for the next summit in Kazan on the formation of an alternative payment system.

### **On BRICS expansion**

The discussion about BRICS expansion was intense. "I can't say that it was done without problems, but in general each country was focused on making a decision to accept new members.<sup>2</sup>

The criteria in the discussion of BRICS expansion were, first of all, "the weight, authority, importance of this or that candidate country for membership and, of course, its position in the international arena."

All member states are in favor of enriching the organization with like-minded people. Among them are countries that believe in multipolarity, the need for more democratic and fairer international relations, and insist on increasing the role of the Global South in the mechanisms of global governance. "In this regard, the six countries whose names were announced today fully meet these criteria."

The reason for the "explosive growth" of the BRICS "is due to those countries that would like to join the group of five that are coming to understand the root causes of those processes currently underway in the international arena, which have laid bare to what extent the West is stubbornly determined to preserve its hegemony at any cost."

All BRICS countries are in favor of keeping the name, which has already become a trademark. "It will emphasize the continuity of all our work."

Russia will not wait until January 1, 2024, but as the future chair of BRICS will start contacts with new members, "we will help them get into the business."

Washington's hegemonic mindset is global, and everyone "runderstands that the US is pursuing the goal not just of punishing Russia, using the Ukrainian Nazi regime (as its proxy)."

This has been very vividly demonstrated recently in Africa. The US is literally "dictating" its will to African countries. For example, the US has adopted a strategy for countries south of the Sahara-Sahel zone. "For African countries, this is yet another insult. It means that their sovereign right to choose their partners is simply being ignored."

The West is demanding that African countries accept invitations to events in which it is interested and refuse meetings involving Russia. "While many [countries] may not find it easy to take the heat of such pressure alone, they (countries applying for membership – TASS) see in BRICS a group of allies and the foundation of that very multipolar world that all of us should now dedicate ourselves to bringing into being."

In the BRICS, everything is fair and equality is guaranteed for all. This is the difference between the BRICS and the G7 and other Western-centered structures. In the G7, everyone listens to the US.

Speaking of fairness and democratization, "we cannot tolerate the fact that of the 15 members of the Security Council, six are from the US camp and are completely subordinated to its will. Wikipedia's yesterday post further showed Msuva as a JS Kabylie player. However, JK Kabyile did, in the past two days, not post anything regarding the signing of Msuva on its official Facebook page. Msuva has enjoyed a good spell with Morocco's Difaâ Hassani d'El Jadida FC and Waydad Casablancahaving scored 28 goals in 79 outings for the former and 10 goals in 37 appearances for the latter. The goal-getter netted eight goals in 28 appearances at Al-Qadsiah FC of Saudi Arabia and, at Yanga, Msuva scored 43 goals after playing 94 matches.

Mwila said the athletes, in conjunction with TPC, have approached several companies with proposals for both long and short-term deals.

"We are leaving no stone unturned in our quest to make this trip a reality, we are requesting well-wishers to come to our rescue," the athlete noted.

"We are representing the country and as flag carriers, we need support to make the nation proud," he said.

In the 2022 Common-

wealth Games in Birmingham, England the Para Powerlifter settled for eighth place in the mixed weight category.

One of the conditions for him to compete in the 2024 Paralympic Games in Paris is he must take part in any international event recognized by the International Paralympic Committee (IPC).

He already missed the Dubai Qualifiers which took place last Sunday, therefore, the Para Powerlifting World Cup is his last hope.

Mwila's call for support has also come after the government recently said it is not sure if Tanzania's Para athletes will compete in the Ghana showdown that will serve as qualifiers for the 2024 Paris Paralympics.

Najaha Bakari, NSC Information Officer, said the government has not secured funds for athletes' trip to the Games, and she appealed for support from the corporate World and other stakeholders.

"To be honest I cannot say if our Paralympic athletes will travel to Ghana to compete in the African Paralympic Games, I have stated so as currently we don't have funds," the official stated.

"Due to lack of funds, I can't say who will represent the country in the Ghana Games but, once the funds are available, we will see who will go to Ghana," she said.

This is the first time that Africa is hosting Paralympic Games and Tanzania was to be represented by athletes from six disciplines- namely Para athletics, Para Powerlifting, wheelchair basketball, amputee football, wheelchair tennis, and sitting volleyball.

Vincent Kaduma, TPC acting secretary-general, announced that Para athletics and Para Powerlifting events will not be part of the African Paralympic Games because IPC officials who inspected the venues set to host the Games deemed the facilities not ready to host the Games.

Kaduma lamented that the African Paralympic Games were the best opportunity for Tanzania's Para athletes to earn qualification for the 2024 Paris Paralympics and described the miss as a wasted opportunity.

### Spanish FA president ' Luis Rubiales to step down after kissing Jenni Hermoso at Women's World Cup

#### MADRID

SPANISH Football Association president Luis Rubiales was set to step down later yesterday after heavy criticism of his behaviour at the World Cup final in Sydney on Sunday, according to reports in Spain.

Rubiales's expected resignation will come one day after Fifa opened disciplinary proceedings against the 46-year-old, who grabbed his crotch in celebration of Spain's victory over England, then kissed Spain midfielder Jenni Hermoso on the lips during the trophy celebration.

Rubiales, who has been head of the Spanish FA since 2018, on Thursday informed colleagues that he will leave the post on Friday, when the organisation holds a general meeting, according to newspaper El Pais.

Players, politicians and the media have spent the week pushing for Rubiales's resignation. Several professional clubs have issued statements saving he should step down, including Atletico Madrid.

Fifa said in a statement issued on Thursday afternoon: "The Fifa disciplinary committee informed Luis Rubiales, president of the Spanish Football Association, today that it is opening disciplinary proceedings against him based on the events that occurred during the final of the Fifa Women's World Cup on August 20, 2023."

Fifa's statement added: "The events may constitute violations of article 13 paragraphs 1 and 2 of the Fifa Disciplinary Code.

"Fifa reiterates its unwavering commitment to respecting the integrity of all individuals and strongly condemns any behaviour to the contrary."

The sections of the disciplinary code referenced in the Fifa statement cover "offensive behaviour and violations of the principles of fair play".

The code cites examples of behaviour which could lead to disciplinary measures being taken, including "insulting a natural or legal person in any way, especially by using offensive gestures, signs or language" and "behaving in a way that brings the sport of football and/or Fifa into disrepute".

Rubiales initially called the kissing issue "nonsense", but then issued an apology via video on Monday for the Hermoso kiss. Spanish prime minister Pedro Sanchez described the apology as "insufficient".

### MILAN

IUVENTUS are back in the Serie A title discussion as they prepare to host Bologna on Sunday, a punchy new style of play in place for a club looking to bounce back from last season's disasters.

Massimiliano Allegri's side, like Italy's three other big boys, impressed on opening day as they won 3-0 at Udinese and put on the sort of aggressive, attack-minded display not usually associated with the conservative coach.

Federico Chiesa hailed his team's "modern style of football" after blasting them into the lead after 108 seconds in Udine and finally showing signs that his injury problems might be behind him.

Allegri himself was more circumspect about the tactical changes, keener to highlight how Chiesa needs to be play up front.

"He has to score 14-16 goals this season... he is wasted on the wing," he said.

But there was something new about Juve's approach, an optimism which was lacking last season, even before their trials and tribulations in front of the sporting courts ended with a 10-point penalty and a one-season ban from European football.

Juve scored only 35 times from open play last term. Their matches were frequently stodgy affairs. An early exit from the Champions League and a January thumping at the hands Napoli underlined their limitations.

And while Chiesa said Juve's target is a return to Europe's top club competition, observers in Italy immediately made Juventus one of the title favourites

With their principal rivals -- Milan and reigning champions Napoli -- all in transitional periods, Juve looked as hungry, and as capable, as they have since they broke the bank to sign Cristiano Ronaldo.

AC Milan will greet their home fans for the first time this season against Torino on Sunday, with the wind in their sails after their new additions made a positive start last weekend.

Christian Pulisic and Tijjani Reijnders, two of nine new faces, excelled at Bologna and there is hope on the red and black side of Milan that they can reach 20 league crowns before local rivals Inter. AFP
