'Religions can't ignore climate change matters'

THE Pan African Climate Justice Alliance (PACJA) has urged religious leaders around Africa not to relent on the war against climate

PACJA Executive Director Mithika Mwenda (pictured) made this observation ahead of the World Religion Day, marked globally every third Sunday of January.

PACJA is a coalition of over 1000 faith based organisations, CSOs, community groups and individuals in 48 African countries advocating for fair and just climate regimes in the continent, taking into account that religious groups have what it takes to change the course of climate change threats, the director noted.

Faith communities - to which four billion people worldwide belong - have the numbers and resources that could turn the course of climate change around, he stated

"At PACJA, we know the immense influence religion has on people and its interconnectedness with nature. As such, from outset, PACJA has collaborated with religious leaders across the board to canvass support for climate justice that African people need," he said.



This commitment emanates from the individual's religious responsibility to protect himself and his community

Ahead of COP 26 talks in Glasgow back in November, the Christian Aid charity calculated that climate disasters in 2021 caused damage in excess of \$100bbn, one of the costliest years on record, he pointed out.

People of every background, and approximately 4000 recognized churches, faith groups and congregations can now rise up to take joint actions to turn the tide, he asserted, citing the work of the Hindu community in Kenya whose Hindu tree planting project is actively involved in planting trees across the country in support of Kenya government efforts to reach 10 per cent forest cover nationwide.

The community has been planting 10,000 trees annually, he said; while Dr Solomon Belay, representative of the Baha' is International Community in Addis Ababa, said the Baha'is believe in upholding sacred values of stewardship, selflessness, moderation, and trustworthiness-vital in promoting healthy relationships with the natural world.

Fire reduces Karume open market to ashes

AN outbreak of fire at the Mchikichini-Karume market in Ilala District in Dar es Salaam yesterday destroyed most of the market's clothing and household wares.

Regional Commissioner Amos Makalla inspected the area along Uhuru Road, asking traders to remain calm as the regional authorities form a team to find the cause of the fire that destroyed nearly all of the

The market was home to 3,500 traders, with some arriving at the scene and witnessing the fire as it raged, expressing disbelief in what they saw and seeing no light for the future.

Sharima Meshaki, a trader at the market, sobbed profusely. "I have been working hard through this business to ensure that my family gets food, I don't know what to do, I have lost everything, I have debts to pay, children to go to school, I am stranded," she said between cries.

Most traders there were servicing piles of debt in banks and other lenders and the fire has destroyed their dreams and they do know how they are going to repay the loans.

Masudi Issa, a spokesman for shattered small-scale traders, urged his colleagues to remain calm and facilitate efforts by the government to evaluate the loss and come

RC's visit, beacon placing, disturb Loliondo villagers

AFTER Arusha regional commissioner John Mongella visited the Loliondo Game Controlled Area last week to inspect newly erected beacons around Loliondo Division, villagers are raising the alarm.

Ololoosokwan ward councillor, Yohana Moloimet said at the weekend that villagers linked the RC's visit with an impending final decision from the Prime Minister's Office (PMO) on final plans for 1,500 square kilometers of land that the pastoralist community uses, but it belongs to the game controlled zone, a conservation area.

The RC did not address residents on the issue, but the visit was seen as a follow up to the work of a special team sent by Prime Minister Kassim Majaliwa in 2016 to examine the situation as conflicts come up with a hunting firm operating in the area, they said.

The status quo being maintained at present dates to 2013 when then Prime Minister Mizengo Pinda went to Loliondo, visited all the villages and directed that plans to annex 1500 square kilometers of land should be halted.

Loliondo Division is home to over 70,000 residents, holding an estimated 784,000 head of livestock reportedly within 116 square kilometers of land, local officials say, noting that this situation touches off regular conflicts in scrambling for land and water

Kijoro Kakea, a special seats councilor for women in the district, stated that children are harassed when grazing cattle in the 1500 square kilometers annex and sometimes

cattle are confiscated.

Local officials want the government to reaffirm the position reached by the former prime minister in 2013, scrapping off plans to add the 1500 square kilometers within the Loliondo Game Controlled Area for strict conservation purposes.

The premier halted the exercise and directed that the mixed use of the land continue, to stem recurring conflicts, while reaffirming that the 1500 kilometers sq. kms of land is meant for conservation.

"This is a good idea but on the other hand, we have come to conclusion that the Maasai pastoralists are good conservationists themselves, and can thus still take good care of Loliondo," he remarked at a public meeting.

PMO later asked all parties to come up with land-use plans for sustainable environmental preservation, wildlife protection and protecting vital water sources pumping water downstream to the Serengeti National Park and beyond. That issue is still being worked upon, officials affirmed.

The 4000 square kilometers Loliondo Game Controlled Area formed at that time became a multi-purpose area hosting game hunting ventures, conservation and pastoralism, housing Ngorongoro District offices and residences.

The issue of slicing off 1500 square kilometers from Loliondo division to seal it off for conservation purposes met with opposition from the community, pointing out that the earmarked land consists of grazing areas, water sources and village

Loliondo is part of the wider Serengeti ecosystem comprising the Ngorongoro Conservation Area, the Maswa Game Reserve, the Serengeti National Park and Maasai-Mara Game Reserve across the border, one of Africa's largest wildlife areas.

Residents from 14 villages located within eight wards of Loliondo Division,

At least 70,000 people, mostly nomadic in Ngorongoro District, have just signed petition to oppose new plans targeting to take the land from them, arguing that for the last 30 years the area remained under its pristine condition because the Maasai communities know how to take care of the environment.

> "We have heard of underground plans to annex the 1500 square kilometers of land in the Game Controlled Area which means soon a number of villages will be asked to move away from the area, thus dislocating thousands of residents, we are not about to accept this," stated elders of the 14 local villages of Loliondo.

> They were speaking in an open air meeting held at Olorien village, with the local community leaders signing the petition against planned annexation of

> Arash village chairman Mathew Siloma said the area in question lies between the villages and the Serengeti National Park, with Ortello Business Corporation (OBC), a hunting firm from the United Arab Emirates, holding a hunting bloc licence to conduct wildlife trekking in the area.

up with a solution, citing the visit by the RC. Part of the solution includes building another market, so they ought to exercise patience despite the hurt and pain that they feel, he emphasised.

Ombeni Kaizer, an officer with the Information and Disaster Unit at the Tanzania Red Cross Society (TRCS), said nine people were seriously injured and six others hit by objects, thus needing emergency aid.

"We have supported nine people with first aid and psychological counseling after their properties were destroyed," he said, noting that despite efforts by the fire and rescue force, they couldn't control the ravaging fire.

Ilala DC Ng'wilabuza Ludigija said the district was forming a probe committee on the source of the fire incident and submits its findings within 14 days.

The team comprises officials working with the DC, the office of the district executive director, the power company (TANESCO), the police along with the fire and rescue force.

"We are yet to establish the source of the fire," he stated, elaborating that initial reports indicate that the fire started at a stall operated by a food vendor. There is unclear information that some traders were improperly connecting electricity to their business stalls, he stated.

"We will be in a position to state the source of the fire after the probe team hands its report. Fire has destroyed 98 percent of the traders' properties," he declared, noting that the police will continue to conduct patrols at the area until the report is submitted.

The incident shocked the top national leadership including President Samia Suluhu Hassan and the Vice President, Dr Philip Mpango, who appealed to the public to remain calm as the government conducts an investigation.

Concerned traders appealed to the government to allow them to build temporary structures in the area so that they continue doing business as they wait for the investigation report.

Mariam Muya, another trader, said they expect the government to allow them to continue conducting business as they solely depend on trading to survive. "We can hardly live without doing business in two weeks," she

The Karume Market fire comes six months after the imposing Kariakoo Market was ravaged by a devastating fire for many hours July 10 last year.

This is not the first time that the Karume Market is consumed in flames, as it occurred on June 11, 2014 where 80 percent of the market was burnt down, traders recalled.

RC orders contractor for 24 working hours

COAST regional commissioner, Abubakar Kunenge has instructed the contractor building Mbuchi Bridge on Rufiji River at Kibiti to make sure they work 24 hours a day to speed the work to alleviate transport problems facing the people.

The RC issued the instruction vesterday during his inspection visit of the project where he said because the work was jointly being implemented with TARURA, they have to do the work at all time.

He said the bridge is the third largest in Coast Region led by the Ruvu Bridge, and that when completed it will open doors for investment economic opportunities.

Kunenge also thanked President Samia Suluhu Hassan for continuing to open up the country through infrastructures including Coast Region by building roads and bridges in various areas of the region.

For his part, TARURA Coast Region Manager, Eng. Leopold Runji said the implementation of the project was being undertaken by Alfa Logistics Tanzania as contractors at a cost of 6.1bn/- and was expected to take 12 months to complete beginning January 2021.

He said the bridge is 61 metres long and the contractor has requested 23-week time extension due to rains that cause flooding.

He said in the circumstances, he advised for a six-week extension, or 45 days to finish the job.

Runji said the bridge is now expected to be completed in February this year.

One of Mbuchi residents, Hassan Yusuf thanked the government for the construction of the bridge that they had been crying for over 60 vears.

He said before the bridge's construction, they used to cross the river in canoes, and many people drowned doing so.

TOSCI closes 8 shops for selling counterfeit seeds

THE Tanzania Official Seed Certification Institute (TOSCI) has ordered the closure of eight shops that sell crops seeds in Mbeya and Songwe regions after they were found counterfeit seed, some of which imported from foreign without verification of their quality.

Some of the shops were closed for dealing in seeds trade without registration with the Institute and traders thereof had no training on sale of seeds as required by law.

TOSCI ordered the shops' closure at the weekend after making impromptu inspections at various seed shops to verify the quality of regions during the current farming season.

TIORCI officers from the Southern Highlands Zone in collaboration with other organs conducted the inspection, saying during the current period when farmers were busy with their farming activities many farmers become deceitful.

Peter Nassari from TOSCI Southern Highlands Zone said during the crackdown more than 200 shops were inspected in the two regions and that the operation will continue in other regions.

He said if the dealers continue selling ton farmers fake seeds there are a danger for crops production

seeds sold to farmers in the two to drop as some of the seeds will not germinate at all.

> He also said importing seeds from outside the country that are not certified as to their quality may also cause the spread of crops diseases thereby occasioning huge losses to farmers and the nation in general.

> On their part, some seed dealer said they fail to differentiate fake and genuine seeds due to lack of frequent trainings, the situation, they claimed also occasion huge losses to them as well for failing to sell seeds that they had bought at high prices.

> One of the traders, William Mbua said shops for selling farm inputs are open daily, but training

in identifying seeds' quality are provided sparingly.

He added that apart from new shops being opened from time to time, but also new types of seeds are produced every year hence he appealed to the government tom invest more in training for dealers of farm inputs.

On their part, some farmers said fake seeds have been affecting the farming sector by raising production costs and claimed that some seeds do not grow; hence they had to plant

Winfrida Jaston, one of the tomato said fake seeds usually have pictures on the package that do not conform to what it contained.

'130bn/- for water infrastructure, dams to address livestock deaths'

THE government has provided 130bn/- for construction of water infrastructure and rehabilitation of dams in Kiteto district, Manyara region following mass deaths of livestock caused by deepening drought.

The decision came just a week after authorities reported the deaths of 1,874 cattle in Kiteto District that were caused by drought.

Speaking yesterday his tour in the district, Deputy Minister of Livestock and Fisheries, Abdallah Ulega said the government immediately responded on the matter to ensure no more cattle continue to die over lack of water.

Ulega's visit in the district was meant to inspect the available water infrastructures for livestock as well as talking to pastoralists who have lost their animals.

"The government is aware of the drought situation in Kiteto; I am here to inform you on the various measures we have taken to save your cattle and make sure they have access to water even during dry seasons. President Samia Suluhu Hassan has provided funds for construction of water wells and rehabilitation of dams," said the deputy minister.

He added the district water engineer and livestock officers immediately identify areas for construction of the infrastructures for the project to be implemented.

Ulega urged farmers to adopt sustainable ways of using pasture neighbouring countries.

instead of decimating one area and moving to another. He advised them to start planting warm-season grasses and consider saving some of that hay in case of drought.

A pastoralist, James Laizer from Makame area said the deepening drought has killed thousands of cattle because apart from water, farmers do not have grasses to feed their cattle.

"The deaths of our animals have affected most of us economically because we solely depend on our cattle to raise income," said Laizer.

Grace Melau, a livestock keeper in Kiteto District; said that this year's prolonged drought has resulted in a big loss due to cattle deaths. She said it will take long for individuals and families to recover from the economic crisis associated with lack of water and animal feed.

Last week, a total of 62,585 animals were killed by prolonged drought in Simanjiro District, Manyara Region.

Out of the 62,585 killed animals, 35,746 were cattle, 15,136 sheep, 10,033 goats and 1,670 donkeys.

Sendeu Laizer, vice-chairman of the Simanjiro district council, told a meeting of councilors in the district that the drought situation in the district was alarming.

He said livestock officials are continuing to assess the number of animals killed by drought in all the district's villages.

Simanjiro Member of Parliament, Christopher Ole Sendeka, said the drought has forced some livestock keepers to graze their animals in

PRODUCTION of tobacco in Chunya District is expected to drop from 10.3 million kgs last season to 10.0 million kgs this season due to opting out by some of purchasing firms.

In the circumstances, tobacco farmers' income from the crop is also expected to drop due to drop in production levels, the situation that will affect the area's agricultural activities and farmers' economic

The remarks were made here at the weekend by the Chairman of Chunya Tobacco Cooperative Union (CHUTCU), Sebastian Mogella at an ordinary members meeting that discussed various issues including on how to deal with climate change.

Chunya District tobacco production expected to see big drop this season

Mogella said as for now Chunya District is left with only one firm refused hence some primary to buy tobacco - Premium Active Tanzania Limited (PATL) that has entered into contract to buy tobacco with 22 primary cooperatives.

He added that CHUTCU has failed to get other buyers due to various reasons including some of the firms fearing the high cost of investment because of the area's geographical

He said some of the tobacco buying firms that were approached to buy the crop includes Alliance One and JTI that buy the crop from neighbouring Tabora Region.

He added that the two firms cooperatives found themselves without buyers.

"There was a danger that some members/farmers refusing to participate in tobacco farming this season 2021/22, hence we decided to hold talks with PATL to chip in and they agreed," Mogella said.

He further said due the opting out of other buying firms, PATL has increased the volume of the crop's purchase from 9.45 million kgs last season to 10.3 million kgs which farmers expect to harvest this

Chunya District Agriculture Officer, Cuthbert Mwinuka called on tobacco farmers to also cultivate other crops to avoid being economically affected from the effects of climate change.

He said as for now farmers are called on to cultivate that can be harvested in a short time and withstand drought. "Weather experts have already cautioned that this year there will be a very poor distribution of rains, there are some areas raining heavily while others do not receive rains at all, this situation that we did not expect can adversely affect us," he added.

Global warming could lead to an increase in kidney stone disease, study finds

RISING temperatures due to the climate crisis will lead to a rise in people suffering from kidney stones - a painful medical condition exacerbated by heat and dehydration, according to a new

More than 400 weather stations beat heat records in 2021

Researchers used two climate scenarios to estimate the burden of heat and humidity related kidney stone disease by the end of the century in South Carolina - a state in the south-east US, a region which currently has a higher than average incidence rate.

In the US, about one in 10 people suffers from kidney stones at some point, and the incidence increases from north to south.

According to researchers at the Children's Hospital of Philadelphia (CHOP), the number of cases will increase between 2.2% and 3.9% depending on whether greenhouse gas emissions continue at the current rate or are cut to an intermediate level, leading to a huge rise in health costs either way.

Kidney stones are caused by hard deposits of minerals (mostly calcium) that develop in concentrated urine which are extremely painful when passing through the urinary tract. The incidence of the condition has escalated over the past two decades, particularly among people of color, women and adolescents.

Diet and lifestyle changes have contributed to the rise in the condition, but prior research has demonstrated that high ambient temperatures increase the risk. The

number of people seeking medical help for kidney stones escalates following very hot days when the risk of dehydration multiplies.

"With climate change, we don't often talk about the impact on human health, particularly when it comes to children, but a warming planet will have significant effects on human health," said Gregory Tasian, a pediatric urologist at CHOP and senior author of the study published in Scientific Reports.

In the first scenario modeled, the average temperature would increase by 2.3C by 2100, compared with 3.6C in the second. Results from a wide range of climate model studies suggest average temperature could be 1.1C to 5.4C warmer by the end of the century.

It isn't a sin to map out how to benefit from refugees' presence

NITED Nations agencies handling the presence of refugees in the country, under the coordination of the Ministry of Home Affairs, have interminable mind games on how far the situation is peaceful in one or other country for practically all refugees to go back home. Yet the extent of refugees' responses have always differed, some using the first available or practicable opportunity to go back home, and some virtually swearing they will never set foot there. Depending on circumstance, the evidence isn't wanting for one to feel that it isn't peaceful enough to accept repatriation; it also depends on trauma experienced.

This sort of experience however isn't universal in the manner in which refugees' issues are handled, as each migration has its aspects, differing from one instance to another on a time scale, for both the issuing country and the receiving country. How refugees are received and the impact they will have is an aspect of socioeconomic arrangements at that moment, which relate to the country's socioeconomic system as a whole. The more marketbased is an economy, the more it receives refugees with ease as they provide an avenue for cheap labour or market for an economy that produces a surplus; foreign cash aids their upkeep.

There is another parameter which has so far been taken up by various Kenyan county authorities near the border with South Sudan, namely the springing up of refugee cities on account of financing from various sources. It is firstly an issue of mapping out the land and issuing

titles, not to refugees but local owners of the land, who can then obtain credit or direct assistance from UN agencies and other charities, explicitly for building a refugee city. It becomes a new urban centre, and a whole host of services springs up there.

For decades in Kigoma Region in particular, keeping refugees environmental occasioned constraints on account of felling trees for firewood, as coal deposits weren't being used (by modifying the product) or making it possible to use biomass sources. Gas was as yet unheard of for common use, and even now few houses use electricity for cooking, but at present there are several alternatives to firewood or charcoal, diminishing environmental threats from the refugee population. Still, economic potential is underutilized.

There is another aspect of inconveniences related to the presence of refugees, where armed bandits have at times sprung up from such communities, pushing the police to mount energetic search and destroy operations in bushes, etc. This similarly raises the pressure for departure as nearby communities fees insecure with bus robberies or highway hold ups, etc but few such incidents are heard these days. It means we actually have an opportunity to mutate the presence of refugees into a different economic scenario that has dividends for the country's economy, by attracting targeted foreign funding for what will definitely be a charitable initiative lessening pressure on the refugees. It is worth exploring by our experts.

Africa needs to address causes of food insecurity

THE majority of the severest food crises after the second half of the 20th century were caused by a combination of several factors. The most common causes of food insecurity in African and other Third World countries were drought and other extreme weather events. The comparison of the severest food crises in the later history reveals that all were preceded by drought or other extreme weather events. They resulted in poor or failed harvests which in turn resulted food scarcity and high prices of the available food.

In addition to extreme weather events, many failed harvests in African and other Third World countries were also caused by pests such as desert locusts. Cattle diseases and other agricultural problems such as erosion, soil infertility, also play a role in food insecurity.

Some experts suggest that drought and extreme weather in regions affected by food crises in the recent decades could be a result of climate change, especially in the West and East Africa which have problems with recurrent extreme droughts.

History of the severest food crises shows that many countries were completely unprepared for a crisis and unable to resolve the situation without international aid.

In spite of criticism lately, the international community has always sent help in the form of food supplies and other means which saved millions of lives in the affected regions. However, the international aid often did not reach the most vulnerable populations due to a high level of corruption and political instability in many Third World

Many African and Third World governments encourage production of the so-called cash crops, the income from which is used to import food. As a result, countries which depend on cash crops are at high risk of food crisis because they do not produce enough food to feed the population.

The disease which is a serious public health concern in the sub-Saharan Africa worsens food insecurity in two ways. Firstly, it reduces the available workforce in agriculture and secondly, it puts an additional burden on poor households.

Poor African and Third World countries have the highest growth rate in the world which puts them at increased risk of food crises. According to some estimation, Africa will produce enough food for only about a quarter population by 2025 if the current growth rate will

contemporary Nigeria, resource control is a topic that generates opinions. It is grossly __misunderstood by many and can be very divisive. It is a discussion that creeps up whenever there is a discussion about Nigeria's problems and solutions. So, it was unsurprising to see former President Obasanjo's reply to Chief Edwin Clark making headlines as the conversation has been kept aside for some time.

Obasanjo's responses came after Clark challenged him to show respect to the people of the region who are currently facing terrible environmental, social, and economic devastations. Anyone with ethical consideration should empathise with the environmental challenges facing the region. Mr Clark then proclaimed that the 36 states' monthly allocation comes from oil revenue. And that the country depends solely on the minerals produced by the Niger Delta. Additionally, Clark rehashed another incorrect statement about Zamfara state owning its resources. The assumption behind this statement is misguided and worrying. It is worrying that such a comment is coming from an elder statesman.

Before plunging into the uncharted waters of resource control, first, let's debunk the myth that the oilproducing states have ownership of resources. On numerous occasions, the federal government and the Zamfara State government have come out to say the state does not own any goldfield. The assertion started over a year ago when the state governor visited Buhari with bars of gold. The state commissioner for solid minerals, Dr Nuruddeen Isa, explicitly noted that the Zamfara was never involved in mining gold as rumour has it. Obasanjo referred Clark to the current constitution instead of an outdated one to score a point. When speaking truth to power, it is essential to respect the law and stick to the facts.

Under Nigerian law, the ownership of natural resources is vested in the federal government. Section 162(2) of the 1999 Constitution provides a revenue formula for states with natural resources being exploited within their territory. They are entitled to a certain percentage of the revenue accruing directly to the federation account from such exploitation. The allocation principles in the constitution require the government to consider population, equality of States, internal revenue generation, landmass, terrain, and population density.

It should also be clarified that the territorial control of offshore resources is under the federal government, not the state government on the coast. The issue was settled in 2002 by the Supreme Court in the case of the Attorney General of the Federation versus the Attorney General of Abia State & 35 Others. The court reaffirmed the

federal government's sovereignty of barrels have been spilt since oil and jurisdictional control over the vast resources located in the states' offshore and adjacent continental shelf on Nigeria's coast. I will not judge whether this is fair or not. That is a discussion that will lead us to restructuring Nigeria.

Based on the data in the 1990s, offshore oil extraction accounts for 74 per cent of the country's total. That is the information used to decide the revenue allocation formula. Under the current law, the oil-producing states get 13 per cent of the federation's oil revenue, half of the onshore oil revenue. Out of 36 states, 10 are listed as the oil-producing states - Akwa Ibom, Rivers, Delta, Bayelsa, Ondo, Edo, Imo, Abia, Anambra, and Lagos. The first four currently produce 80 per cent of the onshore output. Still, not all these states are in the Niger Delta, and not all the States from the region are listed as oil-producing

Wecanallagreethatthegovernment should not grow by breaking the backs of those supporting it, including other states that generate non-oil revenues. Mr Clark suggested the derivation should be increased to 25 per cent. I feel the government should grant all 100 per cent onshore revenue to the region with some modification to the allocation. There is currently a Bill seeking the derivation fund to be directly paid to oil-producing communities instead of the state Governors, which looks like a decent

Before we digress, we will end this point by noting that the country does not depend on only one region for its finances. It is also essential to know that Nigeria's expenses are above its total revenue, which means the country has to borrow to keep its day-to-day activities. Rightly so, the oil revenue is a significant portion of the federation account. Like other economies, Nigeria also engages in non-oil activities, generating decent revenue. So, it will be disingenuous to assert that the country depends on one region. Nigeria has been borrowing to finance its expenditure from external and domestic sources. For example, 38 per cent of the 2022 budget will be funded through loans, while oil revenues will pay about 35 per cent of the country's expenses. The Central Bank Governor clarified how they print money to lend to the government. The International Monetary Fund has provided loans to the country to sail through the pandemic. Secondly,

the environmental damage in the Niger Delta requires emergency attention, and it will be inhumane not to empathise. One cannot deny the impact of global warming, but the human contribution to this damage is evident. Millions was first discovered in 1956. The burning of natural gas associated with oil extraction - gas flaring - is also a considerable problem. Like oil spillage, gas flaring kills crops, pollute water and damages human health.

An investigation by Amnesty

International reveals the reasons behind oil spillage and gas flaring include poor maintenance and negligence. In contrast, Shell has attributed spillage causes to accidents and organised criminal interference. For gas flaring, various reports point to economic and market constraints. Shell oil company has been the largest onshore producer for more than five decades in Nigeria and was responsible for spilling 560,000 barrels in Bodo between 2008 and 2009. Payments have been agreed upon, and more litigations will continue in European courts. The 2011 report by the United Nations Environmental Programme (UNEP) on Ogoniland was said to be one of the most complex investigations of the agency. The UNEP report recommended a clean-up project to President Goodluck Jonathan. They also suggested that the government jointly conduct a campaign in Ogoniland to end illegal oil-related activities, oil companies and local authorities. But that did not happen under his watch.

President Buhari launched the clean-up exercise in June 2016 by commissioning the Hydrocarbon Pollution Remediation Project (HYPREP), which will take four phases to complete. The global community celebrated with Nigeria when they heard the announcement. But it is five and a half years now, and the first phase of the clean-up is yet to be completed. In July 2021, the Minister of Environment announced that only 10 out of the 17 lots of the first phase were thoroughly restored. Last week, a non-governmental organisation, Ogoni Liberation Initiative, has appealed to President Buhari to halt further payment to HYPREP. They allege that the agency has always misused the fund released for the

Instead of blaming those responsible, Mr Clark's statement digressed from addressing the environmental issues to blaming the wrong group of individuals like Obasanjo. As we did with Obasanjo, the whole country would have agreed with Clark if he had asked for reasons why the government was not keeping its promise. After all, nothing you can say about the government will make them look more incompetent than they already made themselves look. It would also be beneficial if he had pushed for litigation with the oil companies to compensate the communities at the international

The third, and last point, brings us to the social and economic issues in the Niger Delta. These are problems that affect the communities, but they are not unique to the Niger Delta region. The country is facing social and economic issues because of the recurring under-performance of the government for a long time. However, the causes of these problems may be specific to a region. Studies have shownthattheenvironmentaldamage caused by oil spillage and gas flaring in the Niger Delta has contributed to the region's social and economic issues. These include pipeline sabotage, social unrest, militant violence, water contamination and low food production.

The environmental degradation that has left people unemployed in the Niger Delta needs to be addressed to keep the country's unemployment level from rising. History has proven over and over again that anytime you have a concentration of young people without work, the probability of revolt and unrest will increase. Latest figures from the Nigerian Upstream Regulatory Petroleum Commission show oil production have dipped by a third and only 12 oil rigs out of the country's 53 are operating. The outcome is attributed to several forms of criminal activities in the region.

Let's recall that the Niger Delta is the first region to have a dedicated commission to cater for its socioeconomic needs by the federal government. The Niger Delta Development Commission (NDDC) was initiated in 2000 under the Obasanjo regime. The mission statement of the commission on its website reads: To offer a lasting solution to the socio-economic difficulties of the Niger Delta Region and facilitate the rapid and sustainable development of the Niger Delta into a region that is economically prosperous, socially stable, ecologically regenerative, and politically peaceful.

Achieving the above mission would lift the people's spirits in the Niger Delta and the global community. Any crisis there tends to affect world oil prices. Instead, several corruption allegations mar the commission, and competence from the government seems to be an issue. It would benefit the global community if Mr Clark channelled his energy to NDDC to demand efficiency instead of blaming the wrong individuals.

In my opinion, it is worth reflecting that speaking with facts and pointing fingers at the right group will put more pressure on the government to respond appropriately.



Fully ready to kill, shockingly unprepared to save lives

THILE absolutely ready to the biggest military powers spending in 2020 nearly two trillion US dollars on weapons, the world is shockingly unprepared to save the lives of millions of unarmed, innocent civilian victims of wars... and other manmade catastrophes.

The military spending data come from the Stockholm International Peace Research Institute (SIPRI), which also reports that global nuclear arsenals grow as states continue to modernise, thus sharply increasing the dangers of an unimaginable number of victims of the most devastating death machinery.

Parallelly, the world's politicians continue to subsidise fossil fuel with six trillion dollars in just



Credit: Albert ran / UNAMID one year, being fully aware that such fuels harvest the lives of millions of humans, while devoting a tiny portion of such huge amounts to public health care systems.

In fact, 27 December 2021 marked the International Day of Epidemic Preparedness.

According to the United Nations, "global health crises threaten to overwhelm

overstretched health systems, disrupt global supply chains and cause disproportionate devastation of the livelihoods of people, including women and children, and the economies of the poorest and most vulnerable countries."

Otherwise, more epidemics to come

"In the event of the absence of international attention, future epidemics could surpass previous outbreaks in terms of intensity and gravity."

The UN adds that "we need to recognise the primary role and responsibility of Governments and the indispensable contribution of relevant stakeholders in tackling global health challenges, especially women, who make up the majority of the world's health workThe poorest, hit hard-

For his part, Tedros Adhanom Ghebrevesus, Director-General of the World Health Organisation (WHO), said "While we have all undoubtedly been impacted by the pandemic, the poorest and most marginalised have been hit hardest both in terms of lives and livelihoods lost."

Tedros said scaling up production and equitable distribution remains the major barrier to ending the acute stage of the pandemic. "It is a travesty that in some countries health workers and those at-risk groups remain completely unvaccinated."

As countries move forward post-COVID-19, it will be vital to avoid cuts in public spending on health and other social sectors. Such cuts are likely to increase hardship among already disadvantaged groups, said the

WHO chief.

"Instead, governments should target spending an additional 1% of GDP on primary health care. while also working to address the shortfall of 18 million health workers needed globally to achieve universal health coverage by 2030."

An appeal to the world's billionaires

"A perfect storm of conflict, climate crises, the effects of the COVID-19 pandemic and rising costs for reaching people in need is causing a seismic hunger crisis," the Nobel Peace Laureate World Food Programme (WFP) for its part announced.

And launched a onetime appeal for the world's billionaires: 6.6 billion US dollars would help stave off starvation for 42 million people across 43 countries."

A breakdown

Of this required fund-ing, 3.5 billion US dollars are needed for food and its delivery, including the cost of shipping and transport to the counplus warehousing and "last mile" delivery of food using air, land and river transport, contracted truck drivers and required security escorts in conflict-affected zones -fuelled by warlords- to distribute food to those who need it most.

Another 2 billion US dollars are required for cash and food vouchers (including transaction fees) in places where markets can function. This type of assistance enables those most in need to buy the food of their choice and supports local econo-

As well, 700 million US dollars would be devoted to country-specific costs to design, scale up and manage the implementation of efficient and effective programmes for millions of tonnes more food and cash transfers and vouchers - adapted to the in-country conditions and operational risks in 43 countries.

The case of Yemen

For its part, UNICEF's Humanitarian Action for Children has launched an appeal to help support the agency's work in war-torn Yemen as it provides conflict and disaster-affected children with "access to water, sanitation, nutrition, education, health and protection services."

Specifically, UNICEF requires 484.4 million US dollars to reach 8 million children among 11.3 million infants in need.

Meantime, the International Organisation for Migration (IOM) has appealed for 170 million US dollars in 2021 to meet the increasing needs of displaced, conflict-affected and migrant communities in Yemen.

As of today, only half of these funds have been received. The 3.85 billion US dollars Humanitarian Response Plan for Yemen is also only funded at 50 percent.

Yemen's grim picture takes place in a moment in which the World Food Programme (WFP) warns that seven years of conflict show no sign of abating, nor does rising hun-

"As fighting continues to displace tens of thou-

sands while disrupting access to nutritious food for millions of people, over half the population - 16.2 million people - are facing acute hunger, with 5.1 million people at risk of famine. Half of all children under 5 - 2.3 million - are at risk of malnutrition this year."

Infectious diseases: not only COVID

COVID-19 continues to demonstrate how quickly "an infectious disease can sweep across the world", pushing health systems to the brink and upending daily life for all of humanity, the UN chief said on Monday, marking the International Day of Epidemic Preparedness.

"It also revealed our failure to learn the lessons of recent health emergencies like SARS, avian influenza, Zika, Ebola and others", UN Secretary-General António Guterres said in his message on the World Day.

"And it reminded us that the world remains woefully unprepared to stop localised outbreaks from spilling across borders, and spiralling into a global pandemic".

Halting infectious diseases

Noting that infectious diseases remain "a clear and present danger to every country", Guterres maintained COVID-19 would not be the last pandemic for humanity.

"Even as the world responds to this health crisis, he spelled out the need to prepare for the next one."

This means scalingup investments in better monitoring, early detection and rapid response plans in every country especially the most vul-

nerable, he said. "It means strengthening primary health care at the local level to prevent collapse... ensuring equitable access to lifesaving interventions, like vaccines for all people and...achieving Universal Health Cover-

Spreading like wildfire

Meanwhile, as cases of the new Omicron variant continue to spread like wildfire, 70% of COVID vaccines have been distributed to the world's ten largest economies, while the poorest countries have received just 0.8%, according to the UN, calling it "not only unjust, but also a threat to the entire planet.'

To end this cycle, the United Nations underscored that at least 70% of the population in every country must be inoculated, which the UN vaccine strategy aims to achieve by mid-2022.

Deaf ears... again

Although this will require at least 11 billion vaccine doses, it is doable so long as sufficient resources are put into distribu-

In short, the three above-mentioned funding appeals represent an astonishingly irrelevant fraction of the giant amount 2,000,000,000,000 US dollars of the world's spending on killing machines.

In spite of that, such appeals for saving lives fall, once again, on deaf ears.

How Ramaphosa, ANC leaders misled SA about party cadre deployment

THEN Pres-Ramaphopeared before the Zondo Commission on 28 April 2021, Judge Raymond Zondo asked him whether the ANC would ever discuss potential judge candidates, and express preferences on candidates. The question was asked in the context of the ANC's deployment committee, which Ramaphosa chaired in his capacity as deputy president and about which he was testifying.

"Not as far as I am aware," Ramaphosa responded, before clarifying a few moments later: "I do recall once where [judicial] vacancies were mentioned and it was just in passing... it never resulted or descended into saying this [candidate] would be good."

The clear impression Ramaphosa gave to the Zondo Commission, and South Africa at large, was that assessing candidates for judicial vacancies fell beyond the remit of the ANC's deployment committee. Yet, as the nowpublic deployment committee minutes show, this was untrue. On at least one occasion during the limited period covered by the minutes - 22 March 2019 - the committee is shown discussing and recommending candidates for upcoming judicial

"It is concerning that President Cyril Ramaphosa, as the former chairperson of the ANC's cadre deployment committee, may have made an untruthful statement to Judge Zondo during his testimony in front of the State Capture Commission," DA MP Leon Schreiber, who pushed for the public release of the minutes, told DM168.

"Now that we have obtained the ANC's cadre deployment minutes, we see clearly that the deployment committee does in fact 'descend into saving this [candidate] would be a good one'. In fact, the cadre deployment committee explicitly recommends the names of particular judges it wants deployed.'

But Ramaphosa's misrepresentation is just one of multiple untruths conveyed by ANC leaders - all under oath - while defending the party's cadre deployment policy, a DM168 investigation sug-

A court affidavit in the name of ANC deputy secretary-general Jessie Duarte, dated 23 July 2021, swears that the deployment committee "generally" does not get involved in appointments "for independent institutions (including the judiciary)".

deliberations not just over the judicial appointments, but also over appointments for at least two other "independent institutions": the South African Human Rights Commission and the Commission for the Promotion and Protection of the Rights of Cultural, Religious and Linguistic Communities. These are both Chapter 9 bodies, whose independence is enshrined in the Constitution.

Duarte's affidavit, which was submitted in response to the DA's application to have the minutes released, also

states definitively that the committee does "not get involved in the appointment of ambassadors".

Ambassadorial vacancies are in fact discussed on 3 December 2018; in the same meeting, one of the resolutions is to "work on foreign deployments". On 8 March 2019, "Cde Supra" [presumably former North West premier Mahumapelo] is described as being "available for international deployment".

Moreover, Ramaphosa told the Zondo Commission on 12 August 2021 that ambassadorial appointments are indeed within the scope of the committee

Duarte further states in her court papers: "I must stress that the deployment committee does not say to the minister that any of the persons [shortlisted for a position by a Cabinet minister] are not

This is again explicitly contradicted by Ramaphosa's testimony to the Zondo Commission. The President made a point of noting, in fact, that for Cabinet ministers to get lists approved by the deploy-

ment committee is "not an easy process", saying: "I know of ministers who have been there three

times or more just to get a

list recommended." This reality is also reflected by the minutes. Transport Minister Fikile Mbalula's nominations for the Cross-Border Road Transport Agency are recorded as being rejected by the committee on 30 November 2020 because of "issues raised with regard to processes being followed and the candidates and the make-up of the board".

Former ANC secretarygeneral and current Mineral Resources Minister Gwede Mantashe, appearing before the State Capture probe two days after Ramaphosa, stated: "The committee takes a mere interest only in those vacancies which it considers strategic and which could advance the development agenda with the state, such for the post of director-general.'

Duarte's affidavit claims similarly that the committee "gets involved in the civil service i.e. the top leadership, at directorgeneral level".

In fact, the minutes show that the committee routinely considers vacancies below directorgeneral level: on at least three occasions recorded by the minutes, the body deliberates over deputy director-general posi-

tions. The mystery of the missing minutes

It is clear that the ANC is unhappy about the release of the deployment committee minutes. The party has refused to comment on their content, and when DM168 contacted ANC spokespeople for comment last week, we received a call from ANC legal adviser Krish Naidoo informing us that the minutes had been released in error.

Although the DA had made two separate legal attempts to obtain the minutes - via a Paia (Promotion of Access to Information Act) application and ongoing litigation - neither of these had yet met with success when the Zondo Commission was found to have quietly released the minutes on its website as part of a bundle of documentation relating to the testimony of Ramaphosa.

Included in that documentation is a letter from Naidoo to the Zondo Commission dated 6 August 2021, which states that the ANC wishes the commission to treat the minutes with "the requisite degree of confidentiality". Naidoo specifies that the ANC is submitting the minutes "for information purposes only" and not as "part of the information which the Commission is at liberty to publish".

Although the Zondo Commission had asked for minutes of the deployment committee for the entire period of State Capture, it was informed by ANC lawyers that minutes from 2012 to 2018 were unavailable. The only minutes supplied cover the period from May 2018 to 2020.

When questioned about this at the commission. Ramaphosa claimed that minutes had not been taken during the period when he was chairing the committee - or, at least, he could not recall ever going through minutes. This he attributed to the ANC's "rather unfortunate record-keeping processes".

Commission evidence leader Paul Pretorius responded that this seemed "implausible", given that the party in fact had a strong history of recordkeeping in significant meetings. Ramaphosa stuck to his guns, but the notion remains that it seems impossibly convenient for both the ANC and the President that no record was kept of any deployment committee meetings during the Zuma years where Ramaphosa oversaw the committee.

MTN Uganda now launches overdraft facility to compete in digital financing

KAMPALA

MTN Uganda, the country's largest telecommunications company, has just launched a new product called MoMoAdvance, which is an overdraft loan. It's part of the MTN Group, which has businesses in Africa's southern, west, and central regions, as well.

MTN's MoMoAdvance was introduced after a pilot programme that began in late 2020. It lets MTN customers overdraw on their MoMo (mobile money) wallets. In addition to the 2.5% monthly access fee, users will be charged a 0.5% daily interest on the outstanding balance for a total of 45

A close overdraft product, Fuliza, was launched by Kenya's biggest telco, Safaricom, in January 2019. Fuliza allows subscribers to complete transactions even if they don't have enough money in their M-Pesa mobile wallets.

In order to use overdraft services, customers have a borrowing limit that is based on their transaction history. When customers top up their wallets, the overdrawn amount and accrued interest are taken out of their wallets. Three years ago, Fuliza became a lot more popular with people who use M-Pesa. Safaricom now gives out about \$12 million worth of overdraft loans every day to people who use the ser-

MTN Mobile Money Uganda and NCBA Bank Uganda have launched Mo-MoAdvance, a mobile money overdraft solution. KCB and NCBA, two Kenyan banks with a strong presence in other parts of the world, work with Fuliza. Also, MTN Uganda worked with NCBA for its MoMoAdvance credit. It's now possible that the bank will work with MTN in other East African countries, like Rwanda and Tanzania, where the bank already has operations.

As loan apps reach African countries, telecoms are benefiting from mobile-money overdraft programmes. Mobile lending apps like MoKash by MTN Uganda and M-Shwari by Safaricom have become more competitive. These apps allow customers to borrow short-term loans and pay them back within 30 days.

Most of the people in Africa who couldn't get loans from traditional banks because they didn't have a banking history now have access to credit through these new and easy-to-use digital lending services. There are some exceptions, though. Most of the new digital lenders charge high-interest rates, which is often because they work in a risky environment. Users will benefit from lower prices as the legislative framework changes to formalise the industry, while service providers will be protected from financial loss.

Rwanda rallies for global support to beat plastic pollution

KIGALI

The Director General of Rwanda **Environment Management Author**ity (REMA), Juliet Kabera, has urged countries to support a proposed global treaty aimed at beating plastic pollution.

She made the call on Thursday, January 13, while addressing virtually, a dialogue on the elimination of plastic pollution, which was organized by Geneva Environment Network which comprises 75 organisations, led by United Nations Environment Programme. The treaty to reduce global plastic wastes was recently co-sponsored by Rwanda and Peru.

The draft proposal is set to be discussed during the upcoming UN Environment Assembly (UNEA) scheduled from February 28 to March 2, 2022. Kabera said that the plastic waste experience has high lighted the importance of national, regional and international collaboration to beat plastic pollution.

"Following robust conversations over recent months, we are pleased with the progress that has been made towards an international legally binding instrument on plastic pollution," she said. The draft resolution recognizes the trans-boundary nature of the issue of plastic pollution and the need to tackle it at its

"We hope that all countries will agree to take the next practical and ambitious steps of negotiating the global treaty, which will be a useful tool to face the issue of plastic pollution head on," she said and encouraged all nations to limit the manufacture and use of single-use plastics. Rwanda banned single use plastics starting from 2019. "As we

Kabera reiterated that there is a need to increase awareness and understanding of the dangers of plastic pollution, as well as the solutions and technologies that can fast-track the transition to environmentally friendly alternatives. "We also need to foster behavioral change in our communities by investing in grassroots initiatives, empowering change makers and demonstrating the clear health and economic benefits," she said.

She said that there is a need to put in place robust legal and policy frameworks at both the national and global levels saying, "Because plastic pollution is a trans-boundary issue, we can

For more than two decades,

she said, Rwanda has prioritized environmental protection and conservation with focus on sustainable development that led the country to take meaningful action on plastic pollution. "In 2004, Rwanda banned plas-

tic bags as well as specific types of plastic packaging. This was done following an assessment that showed the negative impact these materials were having on human health and our environment. Since then, we have also banned single-use plastics and are now transitioning to sustainable alternatives," she shared the experience. A report on the UN response to marine litter and plastic pollution was also launched at the event.

The report identified the main barriers to combating marine plastic litter, and suggested a number of options to take at a national, regional and global level. "The report is an important contribution to the effort to beat plastic pollution and also provides practical recommendations for scaling up and increasing the impact of this work," she said.

The report recommends boosting the exchange of knowledge, best practices and experience regarding marine litter and microplastics. "The annual global production of plastics is approaching 350 million tons, and some estimates suggest this figure could reach as much as 33 billion tons by 2050 if the current consumption rate continues," reads the

'Kenya's passport eighth most powerful in Africa'

Kenya's passport is now the eighth most powerful in Africa and 71 globally after its mobility score improved six places in the latest ranking.

The Henley Passport Index Report released on Monday shows that the number of countries that Kenyans can visit without a visa, or obtain it on arrival has increased to 72 from 64 in January last year. The mobility

score measures the number of countries that a person holding Kenya's passport can visit without having a visa or the nations where they can get a visa on arrival.

Kenya emerged eighth, a spot that it shared with Tanzania in the latest ranking and behind Mauritius, Botswana, eSwatini, Lesotho, Malawi, Namibia, Seychelles and South Africa. Last year, Kenya's travel document had been placed at position 77 globally on the effects of the Covid-19

"...Covid-19 and its interplay with instability and inequality has highlighted and exacerbated the shocking disparity in international mobility between wealthy developed nations and their poorer counterparts," said the report. Uganda emerged position 76 with Rwanda, Burundi, South Sudan coming in at number 82, 92 and 99 respectively, according to the report.

The mobility score, which is an initiative

of Henley Passport Index had last year downgraded the strength of Kenya's travel document on account of devastating effects of the Covid-19 that lowered the number of countries that one would visit without visa.

Japan and Singapore tied at position one with citizens of these countries able to visit 192 countries without visas. Germany emerged third in the global ranking. Kenya rolled out new chip-embedded passports for its citizens in a move that targets rampant

forgery and impersonation of holders. The new features are meant to make it impossible for anyone to forge or duplicate a Kenyan passport.

Roll-out of the e-passports with a 10-year validity period marked the beginning of the end of the 'analogue' passports that have been in use since Independence and has joined 60 other countries that use new

SA faces more load shedding after Eskom takes atomic units offline

JOHANNESBURG

Eskom Holdings, which supplies almost all of South Africa's power, will take two of the continent's largest generating units offline this year for maintenance, increasing the risk of power cuts after the nation had record outages in 2021.

The extended unavailability of the units with capacity of 920 megawatts each due to the "planned long outages does mean the electricity supply system may be under additional strain during the coming year," Eskom said in statement on its Twitter account.

Unit 2 of the Cape Town nuclear power station will be taken offline for five months from January 17 for refuelling and maintenance, which will include the replacement of three steam generators, Eskom said. That will be followed by maintenance at unit 1 over a similar time period, it said.

This comes as Africa's most industrialised economy experienced record outages last year. The nation's energy supply has been patchy since 2005, with the loss-making Eskom struggling to keep pace with demand.

The frequent power cuts have undermined efforts to revive the coronavirus-battered economy, and President Cyril Ramaphosa said last year they partly contributed to the ruling African National Congress's worst-ever electoral showing in November's municipal vote.

"This is going to be a long, but needed outage – the first of its kind for Koeberg. Our staff are prepared and committed to make history by ensuring success of this project," Riedewaan Bakardien, Eskom's chief nuclear officer, said.

Kenyan textile firm opens Sh5.7bn plant in Zanzibar

NAIROB

Kenya's firm Basra Textiles Ltd is setting up a Sh5.7 billion (\$51.3 million) factory in Zanzibar as it targets to get a pie of the regions clothes market.

It is hoped that the factory, which was launched by President Samia Suluhu Hassan this week, will give a new impetus to Tanzania's textile industry, which has the potential to become a significant sourcing location for foreign buyers.

With the factory at Chunguni area in Zanzibar, Basra Textiles is targeting export markets across East and Central Africa, its company chief executive officer, Ahmed Othman, said on Tuesday. The global textile industry was estimated at around \$920 billion in 2018, and it was projected to reach approximately \$1,230 billion by 2024, available global data show.

Tanzania, which also enjoys duty-free market access to the United States through the African Growth and Opportunity Act (Agoa) as well as to the European Union, is unfortunately importing most of its textile requirements mainly from China, India, Pakistan and Korea among others, official data show.

The country's few locally-processed fabrics (Kitenge and Kanga) are used by domestic users and exported to neighbouring countries of Kenya, Rwanda, Malawi and the Democratic Republic of Congo as well as to China.

Thus, with Agoa and EU arrange-

ments, Basra Textiles Lis also seriously eying the EU and the US markets. The African Continental Free Trade Area (AfCFTA), which officially came into effect on January 1, this year, also offers new markets for Basra Textiles.

This is because apart from facilitating the movement of capital and people, and taking steps to create an Africa-wide Customs union, the AfCFTA also compels member states to slash 90 percent of tariffs on goods traded within the area.

Mr Othman said the factory will be implemented in three phases whereby upon its completion by 2024, it would provide direct employment to a total of 1,600 people. "It will produce 250,000 metres of polyester per day, translating into seven million metres per month," he said. He said apart from Khanga and Kitenge, the company will also produce bedding among others.

"We target to sell our products in the US, EAC, Central Africa and Europe," he said. He said the first phase involves maintenance and repairing of buildings as well as installation of machinery while the second phase was to buy cotton and later produce fabric.

The third phase will involve the construction of a tailoring factory and the fixing of 500 tailoring machines. It is at that phase that production of clothes will start and the number of jobs created by the factory will rise, Mr Othman said.

Zimbabwe breaks from past, urges joint ventures on idle farmland

HARARE

In a break with the past, Zimbabwe is urging farm owners with unproductive land to form partnerships to bolster agricultural output and slash the country's import bill. The joint ventures will need government approval and a database to match landown-

ers with potential investors will be developed, Agriculture Minister Anxious Masuka said Friday in an e-mailed statement. "Abandoned, derelict and under-utilised" farms will be liable for repossession and redistribution to those on a waiting list for land, he added. The directive represents a major policy shift by the southern African nation.

In 2000, Zimbabwe's government, led by the late Robert Mugabe, who was under increasing pressure to improve the lives of citizens, seized farms belonging to mostly White commercial farmers and gave them to Black people, saying the move was meant to redress colonial imbalances.

The land grabs resulted in a country that

used to produce an agricultural surplus becoming a net-food importer. Farm output for products such as corn, Zimbabwe's staple food, and the main cash crop, tobacco, plummeted. After the farms were expropriated, some Western nations imposed sanctions and international isolation followed, with food and foreign currency shortages

becoming commonplace.

Having battled two consecutive droughts, good rains and a better harvest last year formed the basis of Treasury's upwardly revised economic growth forecast. The country harvested 2.7 million tons of corn, triple the prior season's figure, according to data from the Agriculture Ministry.

Double-digit inflation is downside for Baltics in Euro club

he euro area's newest recruits have no regrets about joining the currency bloc but are grappling with one of its major drawbacks.

In the Baltic country of Estonia, inflation clocked in at a twodecade high of 12.2% in December. Nearby Lithuania didn't fare much better, with data this week showing price growth more than double the euro area's record 5% rate.


They shouldn't expect monetary policy to come to the rescue any time soon: The European Central Bank's chief economist reiterated on Tuesday that an interest-rate increase is "highly unlikely" in 2022 as forecasts suggest inflation will slow below the ECB's 2% goal in the medium term.

That contrasts with more aggressive action in nations that aren't part of the euro area, with central bankers from Warsaw to Budapest acting aggressively to curb the kind of price gains not seen since the aftermath of com-

If we had our own monetary policy "we'd probably be doing what Poland is doing and raising interest rates," said Martins Abolins, an economist at Citadele Banka in Riga, the capital of Latvia, where consumer prices jumped 7.9% last month.

While borrowing costs have been "a bit too low" for the Baltic region for years without generating serious economic imbalances, the growing share of wages in gross domestic product is a cause for concern, he said by phone. That concern is on view in Estonia, where the government is considering moves to cool inflation through the budget.

"If we have a single interest-rate policy across the euro area, then the role of national fiscal policy is to smooth over the differences," Finance Minister Keit Pentus-Rosimannus told Bloomberg last month. Her Lithuanian counterpart Gintare Skaiste concurs, telling a news conference Wednesday that the issue of diverging economic situations has been raised at euro-group meetings.

"Finding policies that would match, there's an acute shortsuit everyone is difficult," Skaiste said. "Therefore, we should rely more on national measures that countries can take." Compounding the rate mis-

doubt the Baltic nations are happy they adopted the euro. Alongside economic and trade perks, the switch helped cement a Western orientation for the region of 6 million

Unlike in places like Germany, there's also little public grumbling over the current bout of steep price rises, with many Baltic citizens having survived the hyper-inflation triggered by the collapse of the Soviet Union. In some ways, their current predicament is just a more extreme version of what's happening in the euro zone's larger members, with energy the driv-

Half of last month's increase in Estonian prices came from energy, with electricity and natural gas costs up more than 120% from a year earlier in December and usage higher in the colder northern temperatures. But their plight may also ring alarm bells at the ECB, with the central bank in Tallinn speaking in more urgent terms than policy makers in Frankfurt about the danger of second-round effects.

"High energy prices mean inflation won't come down in the near future," Sulev Pert, an economist at Estonia's central bank, said last week. "It's bad for the economy if a temporary spike in inflation were to lead to higher labour costs for companies, pushing them to adjust their own prices and so causing a wage-price spiral."

Surging global demand drives China's exports to fresh record

BEIJING

China's record-breaking export strength continued into December, pushing the annual trade surplus to a new high and providing support to an economy being dragged down by a propertymarket slump and sporadic Covid

Exports in December were \$340.5 billion, taking the full year total to \$3.36 trillion, according to a customs administration statement Friday. Imports were \$246 billion in December and \$2.69 trillion for the year, leaving a trade surplus of \$94.5 billion for the month and \$676 billion for the full hai have been affected.

The data confirms the picture seen all year – strong demand for Chinese goods of all kinds as the nation's factories pumped out everything from electronics to garden furniture. But trade growth is expected to be weaker in the New Year, as demand for work-from-home technology and health care equipment slows and consumption shifts toward services as the rest of world starts to live

"Last year's growth of 30% is clearly hard to sustain. So export growth this year will decline sharply," partly because global growth is likely to slow down, according to Ding Shuang, chief economist for Greater China and North Asia at Standard Chartered


is sending jitters through supply chains, as the nation's production and shipping face disruptions from virus containment measures. While there hasn't been widespread damage to industrial output or trade so far, some factories have shut down or slowed output in Xi'an and elsewhere, and the capacity of ports in Ningbo, Shenzhen, Tianjin and Shang-

There will be more uncertain, unstable and unbalanced factors in foreign trade this year, Li Kuiwen, a spokesman for the customs administration, said at a briefing in Beijing. Even though there's likely to be some pressure on the data, including from a higher base of comparison, the long-term positive fundamentals for trade won't change, he said.

Global dependence on Chinese production may be reduced if places like Southeast Asia recover from their virus outbreaks. That would allow companies to move orders back to that region after some businesses shifted production to China recently to take advantage of the nation's zero-Covid policies.

Plc. China's domestic restrictions and lockdowns aimed at containing virus outbreaks may also cause some delays, but "the key remains how external demand may evolve."

FBI storms Texas synagogue to release hostages, gunman dead

COLLEYVILLE, TEXAS

An FBI Hostage Rescue Team stormed a synagogue in Colleyville, Texas on Saturday night to free three remaining hostages of a gunman who had disrupted a religious service and began a standoff with police more than 10 hours earlier.

All the hostages were safely released on Saturday night and the gunman was dead, Colleyville Police Chief Michael Miller said at a news conference.

The gunman had initially taken four people hostage, including the rabbi, at the Congregation Beth Israel, officials said. One hostage was released unharmed six hours later.

Local reporters said they heard the sound of explosions, possibly flashbangs, and the sound of gunfire shortly before Texas Governor Greg Abbott announced the crisis was

"Prayers answered. All hostages are out alive and safe," Abbott said on Twitter. The FBI said they have confirmed the identity of the gunman but said they would not yet

disclose it. The FBI declined to confirm the cause of his death, saying it was still under investigation.

The Colleyville Police Department said it first responded to the synagogue with SWAT teams in response to emergency calls beginning at about 10:41 am during the Shabbat service, which was being broadcast online. FBI negotiators soon opened contact with the man, who said he wanted to speak to a woman held in a federal prison.

No injuries were reported among the hos-

In the first few hours, the man could be heard having a one-sided conversation in what appeared to be a phone call during a Facebook livestream of the service of the Reform Jewish synagogue in Colleyville, which is about 16 miles (26 km) northeast of Fort Worth. The livestream cut off around 3 pm EST (2000 GMT).

Before the livestream was ended, the man could be heard ranting and talking about religion and his sister, the Fort Worth Star-Telegram reported. The man could be heard

repeatedly saying he didn't want to see anyone hurt and that he believed he was going to die, the newspaper said.

President Ioe Biden was briefed on the crisis, and Israeli Prime Minister Naftali Bennett said on Twitter he was praying for the safety of the hostages.

Barry Klompus, a member of the congregation since it opened in 1999, said he tuned into the livestream.

"It was horrible listening and watching," Klompus said in a telephone interview.

A US official briefed on the matter told ABC News the hostage-taker had claimed to be the brother of Pakistani neuroscientist Aafia Siddiqui, who is serving an 86-year US prison sentence for her 2010 conviction for shooting at soldiers and FBI agents, and that he is demanding she be freed.

Siddiqui is being held at a federal prison in the Fort Worth area. A lawyer representing Siddiqui, Marwa Elbially, told CNN in a statement the man was not Siddiqui's brother. He implored the man to release the hostages, saying Siddiqui's family condemned his "heinous" actions.

The Council on American-Islamic Relations (CAIR), a U.S. Muslim advocacy group, condemned the man's actions.

"This latest antisemitic attack on Jewish Americans worshipping at a synagogue is an act of pure evil," CAIR said in a state-

Klompus said he did not know of any significant previous threats to the congregation.

"We don't have a security officer on staff but we have what I would say is a very good relationship with the local police," he said.

Johnson's office apologises to Queen for lockdown parties

LONDON

BRITISH Prime Minister Boris Johnson's office apologized to Queen Elizabeth on Friday after it emerged that staff had partied late into the night in Downing Street on the eve of Prince Philip's funeral, at a time when mixing indoors was banned.

Johnson (pictured) is facing the gravest crisis of his premiership after almost daily revelations about a series of social gatherings during COV-ID-19 lockdowns, some son to dying relatives.

After building a political career out of flouting accepted norms, Johnson is now under growing pressure from some of his own lawmakers to quit. Opponents say he is unfit to rule and has misled parliament by denying COV-ID-19 guidance was breached.

In an extraordinary twist to a saga that has been widely lampooned by comedians and cartoon artists, the Daily Telegraph said drinks parties were held inside Downing Street on April 16, 2021, the day before Prince Philip's fu-

Dressed in black and in a white trimmed black face mask, the 95-year-old Elizabeth cut a poignant figure as she sat alone, in strict compliance with coronavirus rules, during the funeral service for Philip at Windsor Castle.

'LEAVE THE STAGE'

Opponents have called for Johnson, 57, to resign, casting him as a charlatan who demanded the British people follow some of the most onerous rules in peacetime history while his own staff partied at the heart of the British

A small but growing number in his own Conservative Party have echoed those calls, fearing it will do lasting damage to its electoral prospects.

"Sadly, the Prime Minister's position has become untenable," said Conservative lawmaker Andrew Bridgen, a former Johnson supporter. "The time is right to leave the

Johnson has given a variety of explanations of the parties, ranging from denials that any rules were broken to expressing understanding for the public anger at apparent hypocrisy at the heart of the British state.

Foreign Secretary Liz Truss, seen as a possible successor, said "real mistakes" were made.

"We need to look at the overall position we're in as a country, the fact that he (Johnson) has delivered Brexit, that we are recovering from COVID... He has apologized."

"I think we now need to move on. To trigger a leadership challenge, 54 of the 360 Conserv-

ative members of parliament must write letters of no confidence to the chairman of the party's "1922 Committee". The Telegraph said as many as 30 such letters had been

submitted. Johnson faces a tough year ahead: beyond COVID, inflation is soaring, energy bills are spiking, taxation will rise in

April and his party faces local elections in May. One of the April 2021 parties was a leaving event for James Slack, a former director of communications at

Downing Street, who on Friday apologized "for the anger and hurt caused". Slack, now deputy editor of the tabloid Sun newspaper,

MSF also said that governments must take steps to ensure that patent monopolies do not stand in the way of access to the treatment.

Russia has no relation to attacks on Ukrainian governmental websites - Kremlin spokesman

RUSSIA has no relation to cyber attacks on Ukrainian governmental websites, Kremlin spokesman Dmitry Peskov told CNN. "We've read those reports,

as well as media. We have nothing to do with it, and Russia has nothing to do with these cyberattacks," he said in a fragment of the interview, published by The Hill newspaper in its Twitter account.

"We have heard accusations against Russia, that Russia is standing behind. But <...> not a proof was presented. We consider it a continuation of another unproved accusations of Russia," the Kremlin spokesman continued

"We are nearly accustomed to the fact that Ukrainians are blaming everything on Russia,

even their bad weather," he added.

Military escalation

According to Peskov, the level of tensions on the border with Ukraine is excessive, that is why Russia is insisting on receiving a concrete response to its initiative of security guarantees. "We have too much tension on the border. We have too much tension in this part of Europe. And, of course, it drags more problems, automatically.

That's why it is extremely, extremely dangerous for our continent. This is the reason [why] we are insisting that we receive a direct response for our concerns, extremely specific response for our extremely specific proposals," he said.

Kremlin Spokesman Dmitry Peskov earlier castigated these claims as "empty and unfounded", serving as a ploy to escalate tensions, pointing out that Russia did not pose any threat whatsoever to anyone.

However, Peskov did not rule out the possibility of provocations aimed at justifying such allegations and warned that attempts to use military force to resolve the crisis in southeastern Ukraine would have serious consequences.

Iran nuclear talks progressing amid 'better atmosphere'

TEUDAN

CHIEF negotiators of Iran and three European countries on Friday temporarily returned to their capitals for consultations as expert talks continue, providing the latest evidence that international talks to salvage the Iranian nuclear deal in Vienna have been moving forward.

The return of chief negotiators to their countries does not mean the eighth round of talks has stopped, according to the website of Iran's Foreign Ministry. The eighth round of negotiations between Iran and other remaining signatories to the Joint Comprehensive Plan of Action (JCPOA) began on Dec. 27 with the United States indirectly involved after its pullout in 2018 from the landmark pact.

"BETTER ATMOSPHERE"

"There's a better atmosphere since Christmas," European Union (EU) foreign policy chief Josep Borrell told reporters on Friday following an informal meeting of EU foreign ministers in the French city of Brest.

"Before Christmas, I was very pessimistic," he said, adding that "today I believe reaching an accord is possible," even within the coming weeks.

Meanwhile, there is "real progress" on the restoration of the JCPOA, Russian Foreign Minister Sergey Lavrov said on Friday.

"There is real progress there, there is a real desire, first of all between Iran and the United States, to understand specific concerns, to understand how these concerns can be taken into account in a common package," Lavrov told a press conference.

The Vienna talks are "moving forward on right track," Iran's official IRNA News Agency reported on Saturday.

"The number of issues of difference has decreased and delegations are busy to discuss the way of implementing any potential agreement," the report said, quoting an informed source on condition of anonymity.

Also, Mikhail Ulyanov, head of Russia's delegation to the nuclear negotiations, tweeted on Thursday that the diplomats in Vienna primarily

paid attention to "to (the) implementation of a future deal."

"We need to agree on who will be doing what and when on the way towards full restoration of the nuclear deal," which is not an easy task, he

"DIFFICULT PART"

Though in a positive atmosphere, it's reported that a wide range of issues remains unresolved in the nuclear talks, given Iran and the United States, the two main parties, indirectly exchanging messages. "We are discussing difficult issues and considering the ways to prepare the draft of the agreed principles," Iran's Mehr News Agency reported on Saturday, citing a source close to the

Vienna talks. According to the reports, about the removal of the sanctions and nuclear issues, lots of disputes have been resolved, and the negotiators "are increasingly working on the third appendix on how to implement and sequence the possible agreement."

The informed source noted that this phase of negotiation is "one of the most tedious, time-consuming and difficult parts of the negotiation, but it is indispensable to achieve the goal."

Based on reports from the venue of the talks, the Iranian negotiators have been focusing on assurances and verification of U.S. next moves, which the Western parties were opposed to, so as to "reach a good and acceptable agreement that will guarantee the Iranian nation's rights and interests." As the indirect negotiations between the United States and Iran reach a critical stage, neither side "wants to seem too eager to compromise, which would risk appearing weak," New York Times commented recently.

WAY AHEAD

While the diplomatic endeavors are going on, Washington still carries on with its pressure campaign. There are only "a few weeks left to see if we can get back to mutual compliance," U.S. Secretary of State Antony Blinken said Thursday, warning his country stands ready to look at "other options" if negotiations fail.

However, Tehran has repeatedly vowed that it will not make hasty concessions under pressure. "Unfortunately, many of the weaknesses of the JCPOA ... have been due to the influence of the negotiators from the U.S. psychological pressures and the haste in signing the JCPOA agreement," said a news article published by Nour News website, which is affiliated with Iran's Supreme National Security Council.

To move the negotiations forward, the United States, Iran's Tehran Times daily suggested, can "greenlight the release of Iranian assets as a good-will gesture to pave the way for a lasting agreement," not an interim one that is unlikely to be accepted by Iran.

Ali Vaez, Iran expert at the International Crisis Group, said in a recent podcast episode that to revive the JCPOA, given former U.S. President Donald Trump's "original sin," the United States "should go first and offer sanctions relief in areas that are actually open to verification," primarily in Iran's oil exports and related services, as well as its ability to repatriate all revenues and access to its frozen assets.

Vaez also suggested Americans and Europeans provide assurances that Iran would be able to, at least during a Biden or Democratic administration, "keep the benefits of the agreement, as long as its own nuclear commitments are fulfilled."

In parallel to Washington taking those steps, Iran should freeze its nuclear program to give time and room for verification, he added.

Sputnik V effective against omicron variant - RDIF

MOSCOW

RUSSIA'S Sputnik V anti-coronavirus vaccine has proven a good level of efficacy against the omicron variant of the novel coronavirus, Russian Direct Investment Fund (RDIF) head Kirill Dmitriev was quoted as saying in the vaccine's Twitter account on Saturday.

"You need to make sure vaccine works against current and future mutations. In that regard Sputnik platform is doing very well, showing good virus neutralization against Omicron," Dmitriev said in a BBC interview.

In his words, booster vaccines, such as Sputnik Light, as well as combinations of existing vaccines are extremely important in the fight against emerging variants of the novel coronavirus.

On November 26, the World Health Organization (WHO) designated the B.1.1.529 variant identified in South Africa as a "Variant of Concern" and assigned it the Greek letter omicron.

In its statement, the WHO noted that "this variant has a large number of mutations, some of which are concerning." To date, as many as 783 Omicron cases have been identified in Russia.

China's intelligent voice market size grows 44 percent in 2021

A virtual host named "i+" has been put into use for the upcoming Beijing 2022 Olympic and Paralympic Winter Games. Empowered by intelligent speech recognition technology, it can translate Mandarin Chinese into English, French, Japanese, and other languages in real time, spreading knowledge about the Beijing 2022 to the world more quickly.

Intelligent speech recognition technology has been increasingly integrated into terminal applications to serve people's everyday life. Besides AI host, its application scenarios also includes smart fitness mirror, smart wearables that can assist couriers in collecting and delivering parcels, and intelligent mouse that can type automatically when you talk.

Intelligent voice industry, as an important part of the software industry, has entered a new stage characterized by high-speed development, said Wang Jianwei, deputy director of the information technology department at China's Ministry of Industry and Information Technology (MIIT), at the China Intelligent Voice Industry Development Summit Forum held in December 2021.

China's intelligent voice industry has grown vibrantly in recent years, with breakthroughs made in core technologies, Wang said, adding that the accuracy rate of speech recognition has reached 98 percent.

The size of China's intelligent voice market hit 21.7 billion yuan (\$3.4 billion) in 2020, an increase of 31 percent from the previous year, and is projected to rise 44 percent year on year to 28.5 billion yuan in 2021, effectively driving industrial digita-

lization, pointed out a white paper on the development of China's intelligent voice industry (2020-2021) released on Dec. 18, 2021.

In the world where all things are connected, more smart devices are required to be controlled from a distance, which brings about opportunities for the industry, said Liu Qingfeng, chairman of the council of the Speech Industry Alliance of China (SIAC) and chairman of iFlytek, a leading Chinese AI firm.

The number of smart devices driven by rising demand for speech interaction is increasing rapidly, Liu noted, adding that the amount of interaction services handled by the company's voice assistants registered a year-on-year increase of 84 percent in 2021.

Intelligent voice technology is faced with three major challenges, including multilingual intercommunication, human-machine interaction in complex scenarios and multi-modal virtual world, Liu pointed out.

Multilingual intercommunication not only includes foreign languages, but also dialects in

China; effective interaction in complex scenarios calls for accurate speech recognition when several people are talking at the same time; and multi-modal interaction means adding timbre, tone, expression, mouth shape and other factors to voice to make speech recognition more intelligent, Liu explained.

It's estimated that the recognition rate of iFlytek products increased from 69 percent to 80 percent in complex scenarios in 2021, according to Liu.

The key innovation drivers of the future development of the intelligent voice industry include unsupervised learning, multi-modal fusion and innovative cross-disciplinary research in brain science, the white paper said.

Algorithm concerning unsupervised learning and low-resource model algorithm still need major breakthroughs; and in terms of AI chips, the foundation of computing power, China needs to hurry to catch up with frontrunners in the world.

Hezbollah, Amal end boycott of Lebanon's cabinet amid crisis

BEIRUT

POWERFUL Lebanese groups Hezbollah and Amal said on Saturday they would end a boycott of cabinet sessions, opening the way for ministers to meet after a three-month gap that has seen the economic crisis deepen and currency collapse further.

The groups, which back several ministers in a government made up of members from across the political and sectarian spectrum, said the decision was driven by a desire to approve the 2022 budget and to discuss an economic recovery.

The groups had been refusing to attend cabinet sessions in a dispute over the handling of an investigation into the huge Beirut port blast in 2020.

The failure to hold cabinet meetings has delayed talks on a recovery plan with the International Monetary Fund, seen as vital to unlocking international support to lift the country out of a crisis that has driven swathes of the nation into poverty.

Hezbollah, an Iran-backed group that has a well-armed militia, and Amal, another Muslim Shi'ite group, have sought the removal of a judge who has been overseeing the blast probe

They have accused Judge Tarek Bitar of bias after he sought to question two senior Amal figures charged over the blast.

Bitar, who does not make public statements, has been quoted by the families of blast victims as saying he would press on with his investigation that has repeatedly been stalled by a slew of lawsuits filed by powerful suspects in the case.

Prime Minister Najib Mikati, whose post is held by a Sunni Muslim under Lebanon's sectarian political system, said in a statement he welcomed the decision to end the boycott and would call for a cabinet meeting as soon as he received a draft 2022 budget from the Finance Ministry.

A government source told Reuters there was not expected to be cabinet session in the coming week as budget preparations were still under way and figures for a financial recovery plan were being drawn up.

Mikati has said his government was seeking to sign a preliminary agreement for an IMF support programme in February.

An IMF spokesperson told Reuters that virtual talks would be held with Lebanese authorities in the last week of January.

US health agencies slammed for failing Americans over COVID-19 communication

NEW YORK

Vox, an American news and opinion website, on Friday published an essay criticizing U.S. health agencies and their officials for their failure to effectively communicate with the public over the COVID-19 pandemic, all the way through its raging course.

"The fierce backlash to the CDC's (the U.S. Centers for Disease Control and Prevention) recent decision to shorten the recommended isolation period for people who test positive for COVID-19 was the latest in a series of communications blunders so severe that they have now become a meme," it said.

America's public health institutions have failed to communicate effectively with the U.S. public throughout the pandemic for two reasons: either they have been left trying to defend poor policies, or the messag-

ing has taken the place of creating any kind of coherent policy at all, according to the article

"I don't think any federal or state agency has done a great job communicating policy during the pandemic," Briana Mezuk, codirector of the Center for Social Epidemiology and Population Health at the University of Michigan School of Public Health, was quoted as saying.

"The CDC should have been setting the example, and I guess in a way it did: a less-than-great example."

INCONSISTENCY

Communication is an essential part of any public health response, but U.S. health agencies have struggled with it since the very beginning of the pandemic, when government officials initially advised against wearing masks in early 2020 before re-

versing themselves to recommend nearly universal masking, said the author Dylan Scott, who is a policy reporter at Vox.

It appeared the initial guidance may have been issued in order to preserve enough masks for health care workers.

Government officials were warning at

Government officials were warning at the time that hospitals' supplies could be depleted at a critical moment if there was a run on masks. It was the first of the pandemic's "noble lies," according to the essay.

A year after the first masking flip-flop, the CDC stumbled on masks again. In April 2021, the agency urged vaccinated people to continue wearing masks in most indoor settings to reduce transmission before reversing itself and saying that vaccinated people could feel free not to wear masks indoors unless it was required by a local or

state government.
"Many public health experts believed the

decision to relax the masking guidance for vaccinated people was premature and, just a few months later when the delta variant drove up cases, the CDC changed course again and recommended everyone, including vaccinated people, wear masks when indoors in public," added the article.

SKEPTICISM

"The problem of unsound or indecisive policy creating bad messaging has been repeated over and over again throughout the pandemic, which has deepened skepticism about the agency's recommendations and created a fertile environment for disinformation to flourish," said the essay titled "The Most Consistently Botched Part of the U.S. Pandemic Response."

"Public health authorities faced serious obstacles to communicating effectively with the public," it said. The American people are divided, consuming different information from different sources, motivated by different ideologies.

Some of the confusion that has undermined the American response was avoidable. Prevailing attitudes inside the medical establishment prior to COVID-19 and specific mistakes made during the pandemic itself have contributed to the disconnect between public health authorities and the public they are trying to protect, according to the article

"Our institutions are failing us with the lack of coordination, the lack of clarity," Scott Ratzan, editor-in-chief of the Journal of Health Communication: International Perspectives and a lecturer at the City University of New York, was quoted as saying. "This is a case clearly that shows our 21st-century institutions are not prepared."

No title defense for No. 1: Novak Djokovic deported from Australia

MELBOURNE, Australia

INSTEAD of starting the defense of his Australian Open title today, Novak Djokovic was slated to be deported from the country, a stunning and unprecedented end to his run of success at Melbourne Park.

Djokovic has won nine of his 20 Grand Slam trophies at the Australian Open – including three in a row – and was scheduled to play in the main stadium to conclude Day 1 of the tournament.

But the No. 1-ranked player in men's tennis now must leave Australia after three Federal Court judges decided unanimously yesterday to affirm the immigration minister's right to cancel Djokovic's visa. The ruling was made less than 18 hours before the first Grand Slam matches of 2022 were scheduled to begin.

Djokovic said he was "extremely disappointed" by the legal outcome but respected the decision and would country." He also said he planned "to rest and to recuperate."

The 34-year-old from Serbia was trying to use a medical exemption approved by two independent medical panels and Tennis Australia to get around the requirements that everyone at the Australian Open – players, their support teams, spectators and others – be inoculated against COVID-19.

Djokovic is not vaccinated, and the government said his presence could stir up anti-vaccine sentiments.

The saga started on Jan. 5, when Djokovic's flight landed at a Melbourne

"I am uncomfortable that the focus of the past weeks has been on me," he said Sunday, "and I hope that we can all now focus on the game and tournament I love."

Tennis Australia issued a statement saying it "respects the decision of the Federal Court" and added: "We look forward to a competitive and exciting Australian Open 2022 and wish all players the best of luck."

Djokovic's absence means just one past champion is in the men's bracket: 2009 winner Rafael Nadal. And that also means now it is only Nadal who will have a chance to claim a 21st Grand Slam title and break a tie with Djokovic and Roger Federer (who is sidelined after a series of knee operations).

Djokovic's dominance in Grand Slam play of late has been particularly impressive, winning four of the last seven major tournaments and finishing as the runner-up at two others. The only time he did not get at least to the final in that span was at the 2020 U.S. Open, where he was disqualified in the fourth round for hitting a ball that inadvertently hit a line judge in the throat after a game.

Last season, Djokovic went 27-1 at majors, coming within a victory in the U.S. Open final of becoming the first man since 1969 to win a calendar-year Grand Slam.

On Monday night, Djokovic was supposed to play Miomir Kecmanovic,

a Serbian ranked 78th, at Rod Laver Arena, the main stadium.

Instead, Kecmanovic will head to a smaller arena to face 150th-ranked Salvatore Caruso of Italy, a so-called "lucky loser" - someone who loses in qualifying rounds but gets access to the main draw because someone else withdraws after the first day's schedule was released.

Third-seeded Alexander Zverev's opener against Daniel Altmaier was moved to Rod Laver Arena.

The Federal Court's decision was as polarizing as Djokovic's vaccination status in a city where residents spent more than 250 days in lockdown and faced harsh travel restrictions at the height of the coronavirus pandemic.

Nadal was among those who said before Sunday's ruling that players knew the rules coming to Australia and no individual was bigger than the tournament.

After the ruling, Vasek Pospisil, a Canadian who won the 2014 Wimbledon cooperate in his "departure from the men's doubles title and has worked with Djokovic to form an association to represent players, tweeted: "There was a political agenda at play here with the (Australian) elections coming up which couldn't be more obvious."

Pospisil also wrote: "This is not his fault. He did not force his way into the country and did not 'make his own rules.'

Pospisil said Djokovic wouldn't have traveled to Australia and would have "been home with his family" had he not received the medical exemption that turned out to be so contentious.

The ATP Tour described Djokovic's absence from the Australian Open as "a loss for the game" and said the court ruling "marks the end of a deeply regrettable series of events."

The tour said it "continues to strongly recommend vaccination to all players.' More than 95% of the Top 100 in both the men's rankings and women's rankings have been vaccinated against

Patrick Mouratoglou, a coach who has worked with Serena Williams and other top players, said the "biggest loser of this mess is the tournament."

Djokovic's visa originally was canceled on Jan. 6 and he spent four nights in an immigration detention hotel before that decision was overturned by a judge on procedural grounds last Monday.

He spent another night confined to an immigration hotel on Saturday while awaiting the result of his last legal challenge.

Australian Prime Minister Scott Morrison has defended Australia's tough border policies since Djokovic was detained, tweeting that "rules are rules" on that day.

Morrison, who will face a vote by May, issued a statement Sunday saying he welcomed the decision "to keep our borders strong and keep Australians safe. ... Australians have made many sacrifices during this pandemic, and they rightly expect the result of those sacrifices to be protected."

AFCON finals a framework for Tanzania's quest for progression to 2023 edition

THE 2021 Africa Cup of Nations (AFCON) finals out in the group stages to secure progression to the knockout stages.

The Confederation of African Football (CAF) faced criticism over the timing of its continental showpiece, and last month had to address rumours the tournament would either be further delayed or moved following the emergence of the Omicron variant of Covid-19.

A total of 24 teams are taking part in the finals which started on January 9 and are expected to end on February 6. The sides have been divided into six groups.

Guinea, Morocco, Nigeria, Mali, Senegal, and hosts, Cameroon, got off to a great start with wins in their opening matches and now have a chance to do well to advance to the next stage.

For the second successive tournament, the AFCON finals have 24 participants. There is nothing like a modest team at this level.

All teams worked hard to qualify for the finals and they have all got off their campaign in the tournament on an equal footing, so it will all depend on the approach in a particular game.

Sages say one trip starts another and that is what is expected to happen in Cameroon as the finals of this phase progress.

The CAF will play a

According to a statement from CAF, the draw for the 2023 AFCON qualifiers will be played on January 21 in Douala, Cameroon.

The qualifiers will start in the preliminary round which will involve teams that are below the FIFA World Cup rankings.

Those who will play in the preliminary round will advance to the group stage which will include a total of 48 teams divided into 12 groups and after that, the two teams that will lead each group will qualify for the AFCON 2023 finals.

Tanzania's senior national football team 'Taifa Stars' will be among the participants in the qualifying tournament.

The side will no doubt start directly in the group stage if it seeks to participate in its third AFCON finals after failing to qualify for the ongoing finals in Cameroon.

'Taifa Stars' has participated in the showpiece on two occasionsthe 2019 AFCON finals held in Egypt and the 1980 AFCON finals next AFCON qualifiers to which took place in Nigeria.

Although 'Taifa Stars' is not in considering that 'Taifa Stars' Cameroon, there are three key operational factors that are seen in the ongoing AFCON finals that could make the squad participate regularly and perform well in the showpiece.

The first thing that Tanzania should do is enhance the quality of the country's soccer referees.

Having the best referees means Tanzania will have a better and more competitive domestic league that will help 'Taifa Stars' find the best players and competitors who will be the key to its success.

The second step is to prepare a large number of talented and high-quality local coaches who will coach national teams and clubs at different levels.

In the ongoing AFCON finals in Cameroon, out of the 24 teams participating in the tournament this year, only nine have head coaches from outside the African continent while 15 are coached by local coaches.

With a large number of good local coaches, it means Tanzania will be sure of embarking on better preparation for local players

has long been relying heavily on locally-based players due to the shortage of those playing abroad.

The third step is to make sure the country strengthens and invests more in youth football than what it is currently doing.

A large number of teams participating in the AFCON finals this year have a large group of young players who have not yet arrived at the pick of their career but fortunately enough they are doing well for their teams.

Many have gone through the basics of football from an early age which attracted the interest of various European and Asian teams to sign and use them.

The approach has turned the footballers into strong and mature performers that are ready to serve their national teams.

Tanzania has made the mistake of failing to make it to Cameroon for the AFCON finals this year, but it should not make the mistake of not learning from what is going on in the 33rd edition of the

Salah shows up for Egypt, Nigeria through to Cup of Nations last 16

MOHAMED Salah got back among the goals for Egypt on Saturday as the record seven-time champions beat Guinea-Bissau after Nigeria secured their place in the last 16 of the Africa Cup of Nations.

Salah's first-time finish at the back post in the 69th minute in Garoua got his and Egypt's campaign in Cameroon up and running after they had lost 1-0 to Nigeria in their opening Group D game.

However, Guinea-Bissau were left fuming after a stunning 82nd-minute strike by Mama Balde was ruled out following a VAR review.

Carlos Queiroz's Egypt, who also hit the woodwork three times, now need only draw their last group game against neighbours Sudan in Yaounde on Wednesday to guarantee safe passage to the last

"It was a really tough game and we were a little bit lucky with the foul," Salah admitted to broadcast-

"We have to win our next game now to make sure we qualify and we will do our best to go as far as we can in the tournament."

Salah, who had not scored in any of his previous six appearances for Egypt this season, struck the post with just 84 seconds played and Mostafa Mohamed hit the same upright later in the first half.

Villarreal's Samuel Chukwueze struck in the third minute and the three-time winners scored a second goal in slightly fortunate circumstances on the

stroke of half-time. Captain William Troost-Ekong's header ricocheted off a Sudan defender and then the head of Taiwo Awoniyi and squirmed in under the goal-

Moses Simon added a third right at the start of the second half, with Walieldin Khidir converting a con-

solation spot-kick for Sudan. The Super Eagles are now certain to top Group D meaning they will stay in Garoua -- close to the border with the Nigerian state of Adamawa -- for a

last-16 tie against a third-placed side on January 23. "To be a champion you should be ready to play against any team, so any team that comes our way, we'll be prepared," said Eguavoen.

The matches in Garoua, home of leading Cameroonian club Cotonsport, attracted larger crowds than have been seen at most Cup of Nations matches, with the requirement to be fully vaccinated against Covid-19 and provide a negative test appearing to put many fans off attending in the football-

On Sunday reigning champions Algeria look for their first win when they play Equatorial Guinea in Douala after the Ivory Coast face Sierra Leone in the same Group E.

A Tunisia side missing a raft of players due to positive coronavirus tests take on Mauritania in the coastal town of Limbe after Gambia face Mali at the same venue.

Ghana striker Benjamin Tetteh has been handed a three-game ban after punching an opponent during a mass brawl at the end of Friday's 1-1 draw with

Tetteh took a swing at Gabon's Aaron Boupendza and was later shown a red card by the referee.

The ban means he will not be able to play again at

HERE was a bit of the fortuitous in Nigeria's second goal against Sudan in their second group game of the Africa Cup of Nations on Saturday, but nothing fortunate about the convincing nature of the result that saw them secure their place in the round of 16.

As record signings stumble, De Bruyne proves priceless

MANCHESTER, England

IT was a goal worthy of winning the Premier League title, even if it is only January and there are still four months of the season to play. But De Bruyne's value to City with Kevin De Bruyne's in another context. stunning 70th-minute sealing Man-City's win against Chelsea, the reality is that the title race has been settled by a player who, in a league of big-money signings, is absolutely priceless.

After this first-versussecond clash, City now sit 13 points clear of Thomas Tuchel's Chelsea following a 12th successive league win. Thirdplace Liverpool are 14 points behind City with two games in hand, but even if they win those, it is difficult to imagine Jurgen Klopp's team going on to overturn an eightpoint deficit to win the title.

Forget those who will say that "anything can happen" in the final months of the season. City are cruising to a fourth Premier League title in five seasons, and De Bruyne's goal, when he broke clear of N'Golo Kante's challenge and burst forward before curling a right-foot shot beyond Kepa Arrizabalaga from 25 yards, was like a chef's kiss for confirmation.

"I didn't see any pass, but then I saw a little gap between the defenders to bend it around them, and it worked," De Bruyne said, with some understatement.

You can toss a coin to settle the debate as to whether De Bruyne or Liverpool's Mohamed Salah is the best player in the Premier League. Both are incredibly in-

of their team, but De Bruyne arguably flies under the radar more than Salah and sometimes doesn't receive the credit his remarkable consistency deserves.

But it is worth putting

This was a game which the record signings of both clubs -City's Jack Grealish and Chelsea's Romelu Lukaku -- continued to struggle to justify their huge transfer fees and contracts. Grealish has flattered to deceive since his £100 million arrival from Aston Villa last summer, while Lukaku's difficulties at Chelsea since his £97.5 million return from Inter Milan have been well documented and publicised by the player himself, who has spoken publicly about his unhappiness at the role he has been asked to play by Tuchel.

Throughout this game, both Grealish and Lukaku looked like square pegs trying to fit into round holes.

Grealish, accustomed to having every attacking move funnelled through him at Villa, is struggling to accept that he is one of seven or eight options at City and that his influence has diminished as a consequence.

The England winger wasted a good chance to score in the first half and won just one significant free kick in the second. He has scored just three goals in all competitions this season, so it is fair say that he is not providing too much value for money at the Etihad.

Lukaku is similar to Grealish in that he has fallen well short of expectations at Stamford Bridge, managing just five Premier League fluential on the fortunes goals so far after hav-

ing been signed with the belief that he would end the campaign with at least 20. Tuchel uses him centrally, when he is perhaps most effective cutting in from the right, but despite this, Lukaku still fails to punch his weight and cause opponents the problems a striker of his pedigree should.

In one first-half chance, Lukaku broke clear of John Stones and bore down on goal, but when it seemed clear he would shoot, he instead passed to Hakim Ziyech and the move fizzled out. He also missed a second-half chance when he tried to beat Ederson with a first-time shot from 20 yards.

Lukaku spends too much time in the central channel, failing to move cleverly enough to drag his defender out of position, and his constant arm-raising when he doesn't receive a pass is likely to irritate his teammates and his man-

Considering the value of the two players' contracts, City and Chelsea are going to be stuck with Grealish and Lukaku, regardless of whether they improve. The difference between the

two, however, is that City have De Bruyne to keep the focus away from their costly addition and Chelsea don't. Lukaku doesn't have the luxury of a brilliant teammate who can get him and his team out of a hole with a piece of magic, as De Bruyne did in this game.

When he signed from VfL Wolfsburg in a £55m transfer in 2015, De Bruyne was by no means a low-budget signing. It was a big fee, but he has since gone on to make it seem like a bargain.

If Grealish's transfer was worth £100m and Lukaku a few million less, how much would it take to sign De Bruyne in today's market?

"We have won what we have done together, and now I want to push him more; he is a world-class player, he has humility, is humble," Guardiola said when asked about De Bruyne. "He has won Premier Leagues and a lot of prizes, but I want more, because I know he can do it. He has everything." City know that he is

priceless. De Bruyne is a player who simply cannot be given a transfer value.
