# **PM: Punish hospital staff demeaning AIDS patients**

PRIME Minister Kassim Majaliwa has instructed hospital administrators to take stern disciplinary measures against health staff found to discriminate people living with HIV/Aids, saying such behaviour has to be eliminated in the society.

Commemorating World Aids Day at national level in Mbeya, the premier said that reports show that employees in health centres habitually stigmatise those patients, divulging private information of HIV/Aids patients when providing services at such facilities.

"Such acts should immediately be reported for action to be taken," he stated, representing President Samia Suluhu Hassan at the event, whose theme this year is "Adhere to equality, eradicate HIV/Aids, and eradicate infectious diseases."

Addressing stigma is vital in the battle against HIV/Aids as it affects patient attendance in health centres for obtaining antiretroviral drugs and regular medical consultations. Stigmatization compels a culture of secrecy and silence tied to the fear of victimization, including denial of access to many public services where a minimum of selection is conducted, experts affirm.

# Six suspects arrested in cross-border car thefts

POLICE in Kilimanjaro Region have reported holding four Kenyans and two Tanzanians over suspected cross-border crime, including car theft.

In an operation late last month, law enforcers also recovered four posh vehicles of different makes and two motorcycles among other items stolen recently in both sides of the border.

Addressing reporters here yesterday, Regional Police Commander Simon Marwa said that the stolen vehicles were being used by the suspected criminals.

"Upon inspection of the four impounded vehicles, preliminary investigations showed that two were stolen in Kenya and the criminals used illegal routes along the porous border to smuggle them into our region," he stated.

The suspected vehicle thieves are linked to a series of vehicle theft incidents in the region and were on the wanted persons list, he affirmed, noting



that stolen vehicles in the region are transported illegally through routes in Same, Mwanga, Rombo and Siha districts to other regions.

Car theft incidents in the region have been rising in recent months, he stated, appealing to law abiding citizens to volunteer information to the police to curb these incidents as the criminals live in social milieu.

This is not the first time suspects have been nabbed in cross-border car thefts as in August 2019, police in the region recovered 20 high-end vehicles stolen from Kenya and sneaked in through notorious unofficial entry points.

The then RPC Hamisi Issah said that law enforcers intercepted the vehicles whose estimated value was close to 2bn/-, on diverse dates, elaborating that the Mercedes Benz, Toyota Land Cruiser, Toyota Prado and Nissan Patrol V.8 cars in particular were being transported through routes in the four districts.

In June 2017 investigation by this newspaper in Arusha, Kilimanjaro and Tanga border regions showed that entering the country without documentation through those routes is not stressful, by the day or at night.

Police and immigration officers keep an eye on official border posts of Namanga (Arusha), Holili and Tarakea (Kilimanjaro), and Horohoro (Tanga), but there are scores of unmanned entry points and informal ports used by speed boats along the coastline in Tanga Region.

discrimination on people living with HIV are still a big challenge in our society," he told the gathering.

Leticia Maurice, chairperson for the National Council of People Living with HIV (NACOPHA), expressed gratitude to President Samia for her vision and efforts in looking for financial resources for implementing the country's various development projects, including those relating to the health sector and infectious disease in particular.



Information was collected from more than 55,000 people in 50 countries, worldwide. varied considerably Views between regions. The lowest tolerance for working directly with people with HIV was found in Asia and the Pacific (only 40 per cent said people living with HIV should be allowed to work with people who

do not have HIV) and in the Middle East and North Africa (where only 42 per cent said people living with HIV should be allowed to work with people who do not have HIV).

Higher educational levels were also associated with positive attitudes towards working with those living with HIV. Globally 68 per cent of those with tertiary education agreed that working directly with people living with HIV

following an impromptu aerial patrol in the national park, the biggest in the country and across the world, where he affirmed that disruptions in water catchment areas adds to threats of water shortages in urban areas and power generation.

After the patrol, the DC who is also the chairman of the district's defence and security committee spoke to workers of the Tanzania National Parks (TANAPA) at Matambwe in the park area.

He pointed at considerable destruction going on in the park, asking those engaged in economic activities in the park to immediately dislodge from the zone before law enforcement is brought to bear upon them fully.

During the aerial patrol officers noticed other activities like wildlife poaching, wanton tree cutting, charcoal making and trapping of wild animals, he stated, noting that the district authorities will not accept this situation to continue.

People are destroying natural resources in the Julius Nyerere National Park, he said, issuing what

he said was the last warning to stop those activities inside the park, "and in this regard Ulanga district authorities will have no mercy to any person found to disregard this directive."

Ulanga District is a big stakeholder in the hydropower project in the area, from the many rivers passing the district emptying their waters to Rufiji River, thereby contributing 62 to 60 per cent of all the water that goes to generate electricity. The district authorities will make sure they protect these water sources from wanton destruction, he declared.

TheparkcoversnearlyallofUlanga District, having an abundance of wildlife including large herds of elephants, crocodiles and hippos apart from wild dogs which experts say they are in danger of extinction, the DC indicated, affirming that they have to be protected for future generations.

For his part, JNNP senior conservationist Seth Mihayo said that poaching was a major challenge in the park but TANAPA protects the natural resources with constant patrols.

### New book by former CAG is a 'weapon' against embezzlement of public funds

THE government says a new book authored by the retired Controller and auditor General, Ludovick Utouh, is a weapon in the fight against embezzlement of public funds.

The book, titled 'Principles of Public Sector Auditing - The Case of SAI Tanzania' was officially launched on Monday in Dar es Salaam.

Speaking at the launching event, Finance and Planning minister Dr Mwigulu Nchemba his speech read on his behalf by the ministry's Permanent Secretary, Emmanuel Tutuba said the book is an important 'weapon' against public funds embezzlement.

"We are taking the book as an important lever that shows us auditing gaps and other weaknesses to be worked upon, hence it will assist us to rescue public funds," he said.

The PS said it was essential for all

internal auditors and accounting officers Utouh says he was compelled to write it countrywide to buy the book as it contains many basic issues on auditing of public funds and finance auditing in general.

Instructing all responsible accounting officers to have the book, he said by reading it they will enhance their experience in on how to manage public funds in order to ward off financial conflicts between them and the government.

He said the book has come up at the right time as as currently the government was dishing a lot of money to local councils for implementation of various development projects and service delivery.

'So, through the book we believe accounting officers will enhance their knowledge in implementing their duties," he said.

However, Tutuba called on Utouh and the WAJIBU Institution he leads to translate the book into Kiswahili to make easy for all Tanzanians to read and understand. The book sells at 40,000 and its author,

after seeing very little understanding on auditing issues in the public sector.

"The book talks on the subject that is taught in colleges but the truth is the subject has no written content in book form.

"hence you will find that the subject was being taught by adhering to what the Constitutions and other relevant laws say, even at the time when I was teaching at Mzumbe University, I saw the problem. But after I became CAG I still saw the problem going on - people not fully understanding auditing in the public sector," said Utouh.

Reading the speech on behalf of the Controller and Auditor General Charles Kichere, Deputy CAG, Sakina Mkumba said the book has adhered to all criteria in the issue of auditing.

"The book is not only beneficial to Tanzania, but also to other countries, taking into consideration that 26 African countries use English," Mkumba added.

PharmAccess Foundation: - 20 years of working with like-minded stakeholders to bring about major health reforms in Africa

"If we can get cold Coca-Cola and beer to every remote corner of Africa, it should not be impossible to do the same with drugs," a wise remark by Prof Joep Lange, who salvaged African communities that were on the sidelines during the HIV/AIDS scourge.

Academically, a virologist and researcher of international acclaim from Amsterdam Medical University, but a philanthropist of a kind the way he sympathised with HIV/AIDS African vulnerable communities.

His move began during the late 1990s and early 2000s when HIV/AIDS emerged and challenged global health systems.

Against that backdrop, he conducted research on the back of HIV advent in Amsterdam communities and managed to provide treatment in early 2000s.

The research was also involved in the prevention of mother - to - child HIV infection and furthered study in African countries of South Africa, Tanzania and Uganda.

He noted that while medicines for HIV were available in western countries nothing was being done for countries in Sub Saharan Africa where the epidemic was even worse.

Several reasons were paraded to justify this anomaly, but Prof Lange said it was unacceptable that those who are in need do not get medicines.

However, Prof Lange was against the world, his Afrocentrism pushed him to finally set up PharmAccess as a facility to steer ahead a movement to make HIV medications available in Africa on the back of his deep-seated impatience for any further policy reforms.

The objective, by then, of this firm, was to turn a ground-breaking research into action by bringing HIV/AIDS treatment to the people in Africa who were being excluded and were facing a health emergency on an unprecedented scale.

Under his influence, Heineken was the first company to commit, and many other multinationals followed.

With a huge impact, it proved that it

was possible to deliver lifesaving treatment to people in Africa and that the delay in doing so was a question of political will.

While focusing on HIV, more problems unfolded. Health systems were proven weak as a result of inadequate investments.

Prof Lange remains a reason why PharmAcess exists today and it marks 20 years of its exalted healthcare system reforms in Tanzania landscape and bevond.

#### Paradigm shift for healthcare in Africa

To address the disparity in investment in healthcare in developing countries' health system weakness, PharmAccess started to advocate for "business unusual approaches" to strengthen health systems in Africa.

In an award winning essay titled; "A New Paradigm for Increased Access to Healthcare in Africa", PharmAccess contended that African public systems have been unable to efficiently deliver health care.

As a result, almost 60 percent of health care, often obtained in the private sector, is paid by patients out of pocket, causing many to fall into a poverty trap.

Private equity investments in the health care supply chain do not take place because the risk is considered too high.

This has resulted in doctors being unable to invest in their clinics, extremely inefficient distribution systems, lack of equipment to perform laboratory tests and a lack of capital for insurance companies to invest in administrative capacity.

To address these challenges, PharmAccess argues that it is time to rethink the way health care is delivered in developing countries.

This essay won accolades from the International Financing Corporation (IFC), Financial Times (2008) and G20 Financial challenge award (2010) and has become the blueprint for PharmAccess's approach to improve access to quality healthcare for low income groups.

With such a shift in the way investments in health in Africa need to be

ushered in, need to improve trust in the systems and improve transparency in quality, zero risk pools were highlighted as challenges that face its financing.

Towards a paradigm shift for healthcare in Africa, in 2006, the Health Insurance Fund was established by PharmAccess, with support from the Dutch Ministry of Foreign Affairs, and several multinationals to tap into private sector potential to introduce public-private health financing schemes for people with low incomes.

Not as a matter of ideology, but based on the pragmatic notion that 50 percent of healthcare in Sub-Saharan countries is delivered through the private sector.

The approach was innovative in its focus on increasing trust in the health system, thereby, aiming to reduce investment risks and costs, create the conditions to mobilize resources from other sources, like local donors, and public and private investors.

In Tanzania, the Health Insurance Fund has focused on working with the government to mobilize and support the informal sector to establish or strengthen health insurance schemes.

PharmAccess worked with the Kilimaniaro Native Cooperative Union (KNCU) to successfully establish the first KNCU health-plan for its members enrolling about 40 percent of their members into the KNCU Health plan.

In 2014, working with local governments in Kilimanjaro and Manyara regions, applying the learnings from the KNCU health plan to strengthen the Community Health Fund (CHF) in the two regions, PharmAccess designed and implemented an improved CHF model, which was able to double enrollment into the scheme (from 10 to 22 per cent) of total population in the region.

The success of this model is further evidenced by the fact that the Government of Tanzania adopted this model for national roll out of National Improved CHF.

In 2008, the Investment Fund for Health in Africa, the first health-focused private equity fund in Africa was launched. Next, in 2009, the Medical Credit Fund launched to provide loans to SMEs in the health sector.

MCF's strategic approach has been to encourage local financial organizations to work with the private health sector by improving transparency and improving trust.

MCF work with local banks by taking the first risk, and also supporting health facilities that adhere to good business practices.

Through this initiative, about Sh14 billion (6 million USD) private capital has been invested to improve quality of care in health facilities in Tanzania.

This collaboration has enabled building of local capacity and created a favorable environment for policy adoption, sustainability and scaling up.



### **Community called on to stop hiding GBV suspects**

THE community has been advised to stop the habit of hiding suspects of Gender Based Violence (GBV) cases; instead they should effectively participate in giving evidence at the court, the practice that will assist in eliminating the vice in the society.

It has also been found that some the families of GBV victims have been receiving money, goats or cattle from the suspects' families as inducement for them to refuse giving evidence or even naming real suspects.

This was revealed yesterday in Manyara Region by Inspector of Police, Nuru Lucas during the National Forum to end GBV in line with commemoration of 16 days of activism against GBV in the region.

Church Aid (NCA), faith actors who have pooled resources with national stakeholders and government through the MKUKI initiative.

Inspector Lucas told the forum: "Evidence has been a major challenge in GBV cases; this is because on the first day the victim gives credible evidence, but later refuses to appear before the court to give evidence saying that they have already settled the matter at family level.

Speaking at the Forum, Thomas Joseph, a participant from Dongobesh in Mbulu district said that tradition and customs are the causes of all GBV cases in the region.

For her part, Lucy Maanda, a Special Seat Councilor from Dareda Ward in rural Babati had fingers pointed to the traditional elders who receive cash or goats from the suspects in order to persuade the victim's family to not continue The Forum was organized by Norwegian with the case and settle the case privately.

She recommended that, for the GBV to end in Manyara Region all tribes in the region should unite and fight against bad customs.

However, Rev. Samuel Sure from ELCT Mbulu Diocese requested the government to set specific times for opening and closure of bars because alcoholism also contributes to GBV.

The Regional Sheikh for Manyara and the Chairman for Interfaith Committee Sheikh Khalid Mohamed said in order to eradicate GBV in the region they came up with the strategy to provide awareness education to various society levels.

However, NCA like many other organizations in the World has been participating in the campaign every year by engaging in various activities in regard to ending violence against women and child abuse.

# CRB urges local contractors to fight for the rights in contracts

CONTRACTORS Registration Board (CRB) has urged local contractors to fight for their rights when violated in their contract with their clients.

chairperson, CRB Eng. Consolatha Ngimbwa made the call in Dar es Salaam yesterday when opening three-day training on contract management to local contractors.

She urged them to take the training seriously and use the material they acquire to practice and don't dump them in their shelves because the tendency show that there are some local contractors who fear to demand their rights for the fear that they would be denied tenders by their clients in the future.

"Don't be like that pleased because it is you rights, fight for it, in every contract clients has his rights and contractor has his rights. Ask yourself when your violet the contract does your employer tolerate you? So if he cannot tolerate you take action for your rights without fear," she said.

She also urged local contractors to ensure that they read the contract between the lines before they start to implement any construction project to avoid consequences they may suffer at the end of the day where some of them abandon their sites.

good contract She said management is very important and necessary for any contractor because they always deal with contracts.

"Your daily job is contract, you participate in tenders and if you succeed to get contract to implement the project, and you will implement the project as required in your contract. There is no way you can work as a contractor without contract so you cannot succeed in this business without having skills in contract management," she said

Eng. Ngimbwa said in the training local contractors will learn different important issues in construction contract adding that in the contract is where rights of both sides are articulated

"I'm very sure that you practice all of this in your daily activities especially when you implement different project. This training will help you to improve how to manage your contract in a professional way," she said.

Eng. Ngimbwa said she is optimistic that the training will help local contractors to improve their knowledge on contract management.

She also urged local contractors to be conversant with Tanzania National e Procurement System (TANePS), because currently it is the only way that is used by the government to receive tenders.

She said because government and its institutions and agencies is number one employer of all construction project there is no way a contractor can survive without having the TANePS Knowledge.

She added that there is information that some local contractors who are not conversant with TANePS to submit their tenders and they find some people to do on their behalf something which she said is not proper.

"By doing so your tender cannot be a secret because it becomes very easy for your competitor to know what you have submitted. Please don't risk your profession take time to learn the system and submit your tender on your own," she said

CRB assistant registrar, Eng. David Jere urged all contractors to pay their annual fees as required by law.

"Please pay your fees on time because we tolerate you so much. Laws give us power to cancel your registration, but we don't want to reach at that point. It is your obligation don't wait for us to push you," he said

TWENTY-five journalists from different media outlets have benefited from the master class training on wildlife conservation, natural resource management and tourism.

Organised by the Journalists' Environmental Association of Tanzania (IET), the three-day training is part of implementation of Tuhifadhi Maliasili project worth US\$30.5million, which is funded by the US Agency for International Development (USAID).

Tuhifadhi Maliasili intends to create an environment wherein movement corridors will improve quality of life for not only wildlife but also the surrounding communities.

To achieve its objectives, the activity will strengthen the institutional capacity of both public and private sector stakeholders.

Through increasing private sector engagement, USAID Tuhifadhi Maliasili will strengthen regulatory policy and the enabling environment for natural resource management. However, during the three day

training journalists have learned about conservation, habitat management and wildlife crimes.


Also the trainees have gained a unique understanding of the most up to date wildlife conservation techniques and practices deployed on the wildlife Corridors.

### Kiswahili elevation to World Day in UNESCO an uplift at 60 years

air in the past few days for the cultural establishment in the country after the governing council of the United Nations Educational, Scientific and Cultural Organisation (UNESCO) moved a resolution to make July 7 of each year as World Kiswahili Day. The festivity around the decision has been rather evenly shared between Kenva and Tanzania, partly due to the different positions they hold in relation to the language. In Kenya it is an ornament of national life, a trait of culture and a monumental point of identification as a country while Tanzania sees the language differently; simply a mother tongue.

East Africa as a whole was made proud with that decision, and for Tanzania it is especially salutary as the country approaches 60 years of independence, where each sector minister has been at pains to show to the public, via the media, what has been achieved during that period.

To arrive there, Kiswahili has attained other noticeable levels of recognition in the past few years, and made notable progress under the late fifth phase president, Dr John Magufuli. He broke with the tradition of speaking customarily in English when we have foreign visitors, such that sixth phase leader addresses gatherings in Kiswahili here at home, even if there are dignitaries from other countries. The traditional obligation to conform is now breached.


It was during the fifth phase that Kiswahili was elevated to one among official languages of the African

OOD news was in the Union, implying that a breadth of documents will be made available in that language, and participants in its meetings being free to use the language.

It also implies that the African Union was now committed to lend a hand in efforts to propagate the use of Kiswahili abroad, and the UNESCO move would have been unthinkable without endorsement by African states at the council, in particular. They convinced doubters.

While East African countries are drawing closer in various areas, economically and culturally so to speak, there is still a dignified measure of competition in what occurs, and tourism is unavoidably one of those spheres. Data for a few past years showed that Kenya was receiving around four times the total number of visitors to Tanzania, partly because the tourism industry there is dominated by private sector players who have been in place since independence days, with minor alterations. So the venue is an extension of home.

That is why the use of Kiswahili as an exotic addition to what these countries offer has a more marketable outlook there than on this side of the border. We tend to focus the pressure on official use of the language, and not so much exposing foreign visitors to Swahili environments, despite that we have the Zanzibar film and music festivals to make s difference. Perhaps we should have more of that, and more visitors from nearby countries and abroad, make the language issue a social matter, not overthrowing English..



# Institutional governance is the only hope to develop Liberia

HE formulation and expected evolution of anything that is intended to last far beyond its simple beginnings must be built upon footings that are supported by a solid base that is far larger and more embedded than that which it supports. No organization can survive the rigidity of time if it entirely relies upon an individual to guarantee its longevity. Man is here for a limited time; Liberia is here forever! How can we guarantee the continued wellbeing and development of Liberia if we entirely entrust national aspirations to the limitations of one flawed human being and not to institutions? The issue of governance is a very simple and straightforward affair. It is only made complicated when people stray far away from time-tested principles that strengthen the governance process. For example, relying on self-indulgent men/women and not institutional guidelines. There must be a defined platform upon which any organization can build that platform must be futuristic in nature; but most importantly, it must be rooted in the belief that it is bigger than any one person, the idea of continuity and robust enough to confront and overcome future challenges. In this light, a government that will succeed must stand on the foundation of institutions. Liberia, on the other hand, did not begin with institutional intentions; it was begun as a temporary outpost with no solidifying, national ambition. ### International Day for the Abolition of Slavery demands profound reflection

approaching this year's commemoration of the International Day for the Abolition of Slavery on December 2, militants in Africa and in the Diaspora had something to celebrate upon. It was the decision by Barbados to end its status as an independent country within the United Kingdom and attain republican status, severing ties with Queen Elisabeth II, until now the country's ceremonial Head of State. Prince Charles, the heir to the British throne, was the guest of honour in that event and described slavery as a blot on the history of the UK. A portion of the citizens were all the same rather apprehensive.

While Tanzania celebrates 60 years of independence, and like other countries it has a lot of achievements too show, there are many who wonder if independence without republican status, merely internal self rule would have prevented unforeseeable excesses and negative political initiatives like munities, coups d'Etat and civil wars that have engulfed Africa since the early 1960s.

Looking at these events, for instance the outbreak of civil war in Ethiopia as a northern province that was hitherto dominating its political life rebelled, it is clear that tribal will to dominate others, or use the military to do so, is a crying political blot.

Grappling with that situation takes one to the issues concerning the slave trade and its abolition, a well as current issues of human trafficking which were at the core of the United Nations General

S the world was Assembly resolution in 1986 against traffic of persons and exploitation via prostitution, later improved to become a commemoration of the struggle against slavery, and how it was abolished.

> Usually Pan-African historians blame Europeans for the slave trade as they purchased slaves, not spending much time on the violence underlying pre-colonial African societies, and how the trade enabled those captures to live, instead of being killed after cattle, farms, women are taken away. This is what plagues African up to the moment.

> Whether one looks at the situation in the Sudan (Darfur), the eastern part of Congo, the Rwandan genocide or atrocious civil wars in West Africa in the earlier years of this century - or the jihads being perpetrated across the Sahel belt, the crucial issue is enslaving others for monetary gain for a warrior class.

> The whole point is to be able to organise, whether it is by warlords who have collected cash from mines and now want to abolish government authority, or political notables dissatisfied by a tribal alliance holding power, it is inability to exercise justice, equity that comes up. It is failure of citizenship as such. So in marking the International Day for the Abolition of Slaverv we should bear in mind that while the resolution talks about trafficking

> people, implying that they are cheated or coerced as in the old days, now there are thousands of volunteers wishing to be trafficked. They look for 'buyers' but expect humane treatment. It is absolutely a sad scenario.

and move to make positive, lifechanging differences for citizens, the economy, and society.

Effective public sector governance and developmental finance can promote economic transformation that strengthens the institutional process. For a society to grow and move in the direction of true development, its public sector governance must be institutionally grounded in strengthening core state functions such as accountability and transparency, justice, equity, and responsible public administration. There is no other way if controlled continuity and sustaining the process are the ultimate objectives!

A country's fiscal health can only be guaranteed if there exist strong public sector arrangements, adequate financial management, a developed procurement system, a judiciary that uncompromisingly administers justice, and an educated citizenry that understands and takes its role seriously. Your governing process must be designed to make sure all of this is systemically synced and aligned to the institutional processes - know that part of your institution formulation must incorporate positive aspects of local cultures and traditions to further solidify the base.

In so doing, appreciate that governance is a combination of processes and a broad reach to implement, manage and monitor the entire operation of government, be it infrastructure, national policy, or the desired citizen action. Understand that governance is a means through which national aspirations are determined and executed. The best way to actualize national vision is through organized means and a process that looks at issues with a broader lens that

scrutinizes public agenda through the institutional process.

Conversely, the all-powerful presidency is hurting Liberia in more ways than one cares to describe; couple this with an absent legislature and a dormant judiciary. Liberia is going nowhere. The only solution lies in aggressive political agitation and nonnegotiable demands for strong government institutions from the people. We must revisit the Liberian Constitution with purposeful intent and push to set stringent guidelines for political office. Our new institutions must weed out harmful mediocrities that continue to hurt us in so many ways. Organizational and structural guidance must direct our public, governance processes and determine national outcomes, not vagrants with personal corrupt agendas.

On the other hand, governance is not a child's plaything. The actions of those who lead can make or break a society. It is a very serious matter that must be viewed with a heightened sense of responsibility, both by the voters and those positioned to check officials of government. There must be a concerted effort to provide the framework to govern our organizations, build our institutions on good governance principles such as inclusive participation, rule of law, consensus building, equity, responsiveness, transparency, and accountability. Anything outside these measures will continue to widen the developmental gap between us and the rest of the world. Effective governance requires that implementation strategy goes through the full wringer of the institutional process, ensuring all compliance, laws, and regulations are met; making sure public sector

financial performance standards are in line with policy - cut no corners.

To fully benefit from the structures of institutions, the reporting standards, and organizational financial performance requirements must be strictly followed - apply penalties and punishments without hesitations. Audit without season and make public records public. Hide nothing from the people except justified national security issues. Arm and protect the press to check the system. Your goal should be to strengthen our institutions are all levels, both publicly and privately.

In this age of "all things on camera" social media, it is in the best interest of the government to get ahead of this and govern responsibly, respond to the people's needs, and quit being neglectful about governance. Shoulder the people's trust with the highest degree of care and reverence.

The reason is simple: You can no longer continue to cheat the people out of a quality standard of living when they can now see for themselves what good governance looks like around the globe. Soon, corrupt and financially irresponsible government officials like ours will have nowhere to hide; they will either have to turn the corner, build institutions to guide our governance process, or be forced to taste the wrath and power of the people.

# What will it take to turn farmers towards more climate-resilient superfood millet?

Bulawayo, ZIMBABWE

illet could be Africa's silver bullet for combating anaemia - and apart from health benefits, it is climateresilient.

Research led by the International Crops Research Institute for the Semi-Arid Tropics (ICRISAT) says millet, long resisted by some of Africa's smallholders, effectively combating anaemia.

Iron deficiency affects more than 1.7 billion people globally, according to the World Health Organization. Undernutrition among children has led to stunted growth and anaemia, says the WHO. The ICRISAT study authored in collaboration with other research organisations notes that governments need to bring "millets into the mainstream" if iron deficiency is adequately addressed globally.

"Although the amount of iron provided depends on the millet variety and its form of processing, the research clearly shows that millets can play a promising role in preventing and reducing high levels of iron deficiency anaemia," said Anitha Seetha, the study's lead author and ICRISAT senior nutritionist.

The grain has another significant benefit - and could assist developing countries bearing the brunt of climate uncertainty and devastating drought cycles. The grain is climate-resilient and could help communities saddled with health emergencies as a result of drought. The study's findings suggest interventions that could ease pressure on already burdened public health services.

"Now that there is strong evidence of the value of millets in reducing or preventing iron deficiency anaemia, it is recommended that one major research study be undertaken on anaemia covering all the different types of millet, common varieties and all

major forms of processing and cooking," says Professor Ian Givens, a co-author of the study and Director at University of Reading's Institute of Food, Nutrition and Health (IFNH) in the UK.

"This will provide the detail required for designing interventions needed to have a major impact on reducing anaemia globally," he said.

For countries like Zimbabwe, where small grains have long been touted as the answer to food insecurity and nutrition concerns, the ICRISAT study's findings could influence smallholders, such as Samukele Jamela. She farms in the arid region of Filabusi, about 120km southeast of Bulawayo.

Jamela is one of many farmers who have routinely faced empty silos because of poor rains but still insists on planting rain-fed maize (corn).

"We plant maize here. That's what we have always done. Very few people want to eat millet or sorghum. Even the children don't like it," she said, explaining why her community shuns growing small grains.

The country's agriculture ministry is aware of this sentiment.

In 2010, Zimbabwe partnered with the Food and Agriculture Organisation to promote the production, processing and marketing of small grains such as millet and sorghum, and a decade later, agriculture officials are still trying to convince smallholders to grow climate-resilient small grains.

The United Nations Development Programme (UNDP) noted in a 2018 report titled "Barrier analysis of small grains value chain in Zimbabwe" that the country has experienced a decline in the production of small grains since the 1990s, with maize remaining the favoured crop despite successive crop failure due to poor rains.

As part of efforts to assist the country in turning the food insecurity curve, the International Fund for Agricultural Development (IFAD) announced a USD67 million investment programme aimed at Zimbabwe's smallholder farmers this November. crops such as millet in drier areas will be supported," Jaan Keitaanranta, IFAD Eswatini and Zimbabwe country director, told IPS.

The support came just as the UN agency warned last month that African countries would see a drop in the yields of staple crops such as maize owing to rising temperatures brought by climate change.

Titled What Can Smallholder Farmers Grow in a Warmer World? the report appeals to African countries to reduce their reliance on maize in favour of small grains, noting that by 2050, maize production could drop by 77 percent in some countries bearing the brunt of climate change.

"Millets are not only healthy but target some of our biggest needs, making them a powerful solution for our diets," said Joanna Kane-Potaka, a former ICRI-SAT Assistant Director-General. She is a co-author of the study and now serves as Executive Director of the Smart Food initiative.

However, local researchers say the labour-intensive nature of small grains is one of many reasons why smallholders continue shunning sorghum and millet.

"Small grains face a major challenge of low yield per hectare compared to maize; hence most farmers prefer to grow maize regardless of climate concerns," said Keith Phiri, a senior lecturer at Lupane State University's Department of Development Studies.

Phiri, who has led research on why smallholders in Zimbabwe's arid regions shun small grains, said reasons included lack of knowledge of millet which "during weeding time, weeds tend to look exactly like the plant," while consumer preferences have always favoured maize.

Among other recommendations, Phiri says the government has to shift its policy that has for years promoted maize as a cash crop, sidelining small grains.

"The need for a solution is critical, and therefore bringing millets into mainstream and government programs is highly recommended," said Jacqueline Hughes, ICRISAT Director-General.

# Global solutions needed for pandemics for all to live in dignity

"Depending on the geographical area,

OVID-19 highlighted significant gaps in the world's ability to deal with pandemics, and it's crucial these are addressed to mitigate the impacts of future global health problems, Masato Kanda, Japan's Vice Minister of Finance for International Affairs, told a recent online meeting of parliamentarians.

The meeting with the theme 'Nairobi Commitments Follow-up under COVID-19' heard that the gaps were serious and significantly affected and in the future, would impact the world's ability to respond to pandemics.

"These gaps include insufficient coordination, information sharing amongst multilateral and bilateral agencies, limited the collaboration between financial and health policymakers, inadequate finance to both effectively prevent or prepare for future pandemics," Kanda said. He elaborated that governance, financing of the current global health system, including development, manufacturing, procurement and delivery of vaccines and medical equipment needed urgent attention.

Japan had energetically participated in recent discussions at the G20 meeting in Italy. Kanda noted that without proper and integrated governance reform, the world would again "end up with fragmented, inappropriate and uncoordinated responses."

Professor Keizo Takemi, MP and Chair of Asian Forum of Parliamentarians on Population and Development (AFPPD), opened the session with a reminder that discussions at the forum and beyond would need to look at the impact of the COVID-19 pandemic, which had caused "prolonged and devastating changes to our daily lives".

He said a face-to-face meeting in Tokyo was planned for February 2022 to celebrate the 40th anniversary of the AFPPD and APDA.

Counting the cost of the pandemic, he noted it had an "unprecedented impact on many areas, such as education, global workforce, food systems, public health and individual decision making on childbearing."



In terms of health, it has impacted the delivery of sexual and reproductive health services, and these needed to form the agenda for discussions in the future.

Yoko Kamikawa, MP and Former Minister of Justice, Chair of Japan Parliamentarians Forum for Population (JPFP), said at the 40th anniversary next year she hoped parliamentarians could look at the "steps the Asian parliamentarians had taken in the past and discuss how to build a society where all people can live their lives with dignity."

Parliamentarians play a crucial role in the delivery of the SDGs, she said.

To achieve sustainable develop-

ment, we need to go beyond the nation-state and establish a new set of standards and rules that will allow us to live humanely on this planet and that will benefit human society as a whole. And this is precisely why it is critically important for parliamentarians who legislate on behalf of its citizens to further efforts in cooperation," Kamikawa said.

"Over the last 18 months, health systems have been stretched to the brink. And we have noted a decrease in investments in routine health services in favour of procurement and delivery of COVID-19 supplies," he said.

This has had a significant impact on communities. For example, over

the past 18 months, there have been changes in patterns of health-seeking behaviour of many people, including pregnant women, who were fearful of leaving their houses and coming into contact with COVID-19 in health facilities.

"This has had a negative impact on maternal mortality. It is clear that more public funding for health is needed alongside innovative strategies that leverage resources to work more effectively without further increasing out-of-pocket costs for individuals and households," Andersson said.

Parliamentarians had a critical role in achieving universal access to Sexual and Reproductive Health Rights as part of universal health coverage (UHC).

"In light of the COVID 19 pandemic and its impacts. It is more important than ever to increase public funding for health be strategic and targeted investments to achieve and sustain the health-related Sustainable Development Goals. Well-functioning delivery of quality health care and essential services cannot be compromised even in the context of the COVID 19 pandemic."

Dr Takeshi Kasai, WHO Regional Director for Western Pacific, agreed that a global solution was critical to counter public health emergencies.

"COVID-19 made it clear that the health, the economy, the broader social well-being are inextricably linked," he said. "The second lesson was the global health (issues) needed a global solution, and for that, effective multilateral mechanisms and institutions are needed."

While nobody expected effective vaccines to be developed as quickly as they were, the challenges with CO-VAX meeting its mandate of ensuring equitable access to vaccines was concerning.

"Unless every country is protected, no country is safe," he said.

It was critically important for the world to prepare as it moved toward a 4th wave of the pandemic, and the key to this was effective multilateral mechanisms.

The online meeting was organised by: Asian Forum for Parliamentarians on Population and Development (AFPPD); Japan Parliamentarians Federation for Population (JPFP) and Asian Population and Development Association (APDA). The event was supported by The Japan Trust Fund (JTF) and United Nations Population Fund (UNFPA).

o matter what it is called it is the abhorrent daily life of a billion enslaved humans. The real number of "modern" slaves is understandably unknown. The International Labour Organisation (ILO) estimates that more than 40 million people worldwide are victims of modern slavery.

Although modern slavery is not defined in law, it is used as an umbrella term covering practices such as forced labour, debt bondage, forced marriage, and human trafficking, it says.

But this figure of 40 million sounds very far away from being accurate. Why? For instance, ILO cites forced marriage as one of the key components of modern slavery. However, there are 800 million child-girls forced to be married.

ILO also includes child forced labour as another key component of slavery. But the UN estimates that there are 160 million children victims of child forced labour.

In fact, the very same world organisation states that more than 150 million children are subject to child labour, accounting for almost one in ten children around the world.

Let alone the number of victims of smuggling and trafficking in human beings who are exploited and recruited as child-soldiers in armed conflicts hitting several developing countries.

#### **One billion slaves**

Consequently, only these two figures combined raise the number of 'modern slaves' to nearly one billion.

According to the UN, slavery essentially refers to situations of exploitation that a person cannot refuse or leave because of threats, violence, coercion, deception, and/or abuse of power.

Marking the 2021 International Day for the Abolition of Slavery on 2 December, the world body says that slavery is not merely a histori-

Coincidently, the International Day for the Abolition of Slavery marks the date of the adoption, by the UN General Assembly, of the United Nations Convention for the Suppression of the Traffic in Persons and of the Exploitation of the Prostitution of Others on 2 December 1949.

The focus of this Day is on eradicating contemporary forms of slavery, such as trafficking in persons, sexual exploitation, the worst forms of child

labour, forced marriage, and the forced recruitment of children for use in armed conflict, the UN remarks.

### **Main Forms of Modern Slavery**

Slavery has evolved and manifested itself in different ways throughout history. Today some traditional forms of slavery still persist in their earlier forms, while others have been transformed into new ones, according to the International Day for the Abolition of Slavery.

"The UN human rights bodies have documented the persistence of old forms of slavery that are embedded in traditional beliefs and customs. These forms of slavery are the result of longstanding discrimination against the most vulnerable groups in societies, such as those regarded as being of low caste, tribal minorities and indigenous peoples."

### **Forced labour** Alongside traditional forms of

forced labour, such as bonded labour and debt bondage there now exist more contemporary forms of forced labour, such as migrant workers, who have been trafficked for economic exploitation of every kind in the world economy: work in domestic servitude, the construction industry, the food and garment industry, the agricultural sector and in forced prostitution.

### Child labour

Globally, one in ten children works. The majority of the child labour that occurs today is for economic exploitation. That goes against the Convention on the Rights of the Child, which recognises "the right of the child to be protected from economic exploitation and from performing any work that is likely to be hazardous or to interfere with the child's education, or to be harmful to the child's health or physical, mental, spiritual, moral or social development."

All this in addition to children pushed into begging by criminal groups, just as an example.

### Trafficking

According to the Protocol to Prevent, Suppress and Punish Trafficking in Persons Especially Women and Children, trafficking in persons means the recruitment, transportation, transfer, harbouring or receipt of persons, by means of the threat or use of force or other forms of coercion for the purpose of exploitation.

### Prostitution, servitude, removal of organs...

"Exploitation includes prostitution of others or other forms of sexual exploitation, forced labour or services, slavery or practices similar to slavery, servitude or the removal of organs. The consent of the person trafficked for exploitation is irrelevant and if the trafficked person is a child, it is a crime even without the use of force."

And there is an unquantified number of victims of debt-slavery, which is more widely spread in South Asia and Sub-Saharan Africa.

In view of the above, there would be many more slavery victims than the official estimates.

High global fertiliser prices overshadow Malawi's farm subsidy programme

llena Joseph, a small-scale maize farmer in Chiradzulu District in Southern Malawi, finished preparing her field early in October.

As the first rains start falling in some parts of the country, her anxiety is growing because she is yet to purchase fertiliser because she does not have any money.

Joseph, 63, is one of the 3.7 million farmers the government targets to benefit under the 2021 Agricultural Input Programme (AIP).

In this programme, the government subsidises fertiliser and seeds for small-scale producers who make up more than 80 percent of farmers in Malawi.

The programme has been running since 2005, and every year, it is saddled with challenges - like corruption, non-availability of goods at sales points and delivery hitches.

This year, these challenges are compounded by a rise in prices of fertiliser which shot up by nearly 100 percent.

The impact of the increase has trickled down to the farmers. For every \$23 in government subsidies for a 50kg bag of fertiliser, the farmers are contributing about \$9. Last year they paid \$5.4.

And Joseph is feeling the weight of that rise on her shoulders. First, she needs money to redeem her two bags of fertiliser.

Then, because chaos is the norm at the agrodealer shop in her area, she has to bribe the clerks or pay some youths to stand in the queue on her behalf. The more the days and nights they stand in the line for her, the more the money she needs to fork out.

Once she buys the fertiliser, she will have to hire a motorbike to transport the commodity to her home, some 17km away.

In total, she needs at least \$28 to meet these expenses.

"I don't have that kind of money, and I don't know where to get it from," she tells IPS. "I hope by the time the fertiliser comes, I will have found the money."

In the previous years, she relied on the government-funded public works programme to earn a small wage. For the past two years, there haven't been any projects in her area.

Amid the perennial challenges rocking the food subsidy programme intended to ensure food security in Malawi, the rise in fertiliser prices has been the most dramatic.

It all began in June, soon after Parliament passed the national budget in which the government allocated \$172,000 towards the programme, targeting 3.7 million farmers - the same number as last year.

Following the hike in price on the global market, the cost of fertiliser increased in the country. Malawi was hit hard. It relies on imports because it does not have a fertiliser manufacturing plant.

In reaction, the Ministry of Agriculture, the implementing agency of the flagship food security programme, announced it would trim the number of beneficiaries.

"Due to financial constraints and the rising prices of fertiliser, the ministry, after looking into these two compound challenges, has decided to have AIP beneficiaries scaled down. It is therefore very necessary that the scaling down of the

beneficiaries be done up to village level," said the ministry's secretary Sandram Maweru in a circular dated July 21, 2021 and addressed to all 28 district commissioners.

The ministry recommended specific figures from every district, resulting in fewer beneficiaries totalling 2.7 million.

But a week after the district commissioner had submitted the revised data to the ministry, on August 21, President Lazarus Chakwera overturned the decision of his agriculture officials. He directed that no one who was on the list last year could be taken off.

"I will not allow anyone to remove any family or village from the list of beneficiaries," he said.

And so began a tug of war between the government and private traders.

While the private traders insisted

they would need to sell the fertiliser at the new prices, which would have outstripped the budget allocated, the government accused the private traders of inflating the prices to sabotage the programme.

It told them it would buy their fertiliser for AIP at \$29 per 50kg bag instead of the \$43.6 per 50 kg which the private traders had set for it.

Efforts to resolve the standoff did not yield results. Last week, 13 of the 164 traders the government had engaged had not signed contracts to supply the fertiliser. This amounts to close to a million bags of fertiliser.

In a statement in Parliament on November 18, Minister of Agriculture Lobin Lowe insisted it was up to the traders to take it or leave it while admitting that only 10 percent of the targeted 371,000 metric tonnes had been procured.

The private traders account for 66

public agencies supply 34 percent for the programme.

However, the fact that 151 traders have signed the contract does not guarantee that the fertiliser will be supplied, indicates Mbawaka Phiri, Executive Administration Officer for the Fertiliser Association of Malawi, a grouping of the private traders.

"Caution must be taken to not assume that all 151 traders have stock and can supply. Many of those who have signed contracts are still having difficulty procuring stock," she says.

According to Phiri, some private traders have decided not to participate in the programme this year because the AIP fertiliser price is too low to do business.

Traders are not obliged to sign the government's contract offer - that is a business decision.

"However, it is also up to the government to decide whether the programme can be successful without the participation of suppliers from the private sector. Last year's programme was successful mainly due to the participation of private suppliers who were able to deliver larger amounts of fertiliser in a very short period and to all areas of the country," she says.

Agriculture policy expert, Tamani Nkhono-Mvula, says in general, the implementation of the programme this year has not been satisfactory.

"This is November, and we have less than 10 percent of the fertiliser supplied when we were supposed to have at least 50 percent of the farmers reached by mid-October. Once rains start in a matter of weeks, that will compound the logistical challenges we already have," he says.

He says the programme is crucial because it targets low-income farmers who cannot afford the farm inputs, but its management is concerning.

"It seems the programme has become a way for some people to make money. They would love to see chaos in the programme because that is the way they are able to benefit," says Nkhono-Mvula.

# World Aids Day: Working together to fight triple threat of HIV, TB and COVID-19

AS Africa works to get back on track to meet its UNAIDS HIV prevention and care targets, healthcare organisations like the BroadReach Group are partnering with governments and donors to find creative solutions for the colliding epidemics of HIV, TB and COVID-19 - a "triple threat" that has had a significant impact on HIV programmes reaching their targets in 2021.

BroadReach Group, a social impact health organisation which has been involved in nearly 10% of the global HIV+ populations' care over the past four year, is working within the United States President's Emergency Plan for AIDS Relief (PEPFAR), the United States Agency For International Development (USAID), Global Fund and the Centers for Disease Control and Prevention (CDC) funded programmes, other healthcare organisations and local governments in Nigeria, Ghana, Uganda, Zambia and South Africa to get these countries back on track to meet the UNAIDS 90-90-90 HIV targets in the next year, and reaching their revised 95-95-95 HIV treatment targets by 2025.

The 90-90-90 and 95-95-95 HIV treat-

ment targets refer to those with HIV knowing their status, receiving their antiretroviral (ARV) treatments and, if they are on ARVs, achieving viral suppression. In many parts of Africa, the gains of the past few years were lost during the COVID-19 pandemic, as both HIV testing and new patients starting on ARVs. One of the greatest setbacks in the fight against both HIV/AIDS and TB in the COVID-era - and the reason why the 90-90-90 gains were lost in many places - is that the COVID pandemic caused the public to stay away from clinics and hospitals.

The recent National Income Dynamics Study (NIDS) Coronavirus Rapid Mobile Survey (CRAM) study by a group of South African researchers found that there was a marked reduction in primary healthcare utilisation in the country during the pandemic, especially in HIV testing and health visits by children under 5 years of age, irrespective of COVID-19 levels, across almost all districts in the country.

The NIDS CRAM study also found that preventive services such as immunisation and contraception dipped across 75% of health districts countrywide and 23% of the uninsured segment of the population reported that they did not seek acute care when they needed it and also missed out on medication, contraceptives or condoms that should have protected them.

Similar problems are being addressed in other parts of Africa. Dr. Andrew Kambugu, the Sande-McKinnell Executive Director at Uganda's Infectious Disease Institute says: "The COVID-19 pandemic has been a challenge for Uganda, as in many other country in Sub-Saharan Africa - also in terms of other communicable and noncommunicable diseases - and this is why it is so important to work smarter together to face the emerging challenges. We believe our collaboration with the PEPFAR, the CDC and implementing partners like BroadReach is vital to turn the situation around. Ending HIV, TB and COVID-19 requires smart strategic partnerships."

Dhirisha Naidoo, Chief of Party for BroadReach's PEPFAR funded USAID program, APACE (Accelerating Programme Achievements to Control the Epidemic) in South Africa, which serves a population of about 4.3 million in South Africa, agrees. She also believes in collaboration and advocates for creative ideas to get patients back to clinics.

"Rather than rely on foot traffic, our programme initiated extensive, creative programmes to ramp up testing to find new cases as well as to ensure patients continued to have access to. For instance, our teams focused on increasing 'index testing' (testing the contacts of HIV+ people), offering extended hours services for clients to access treatment, and enrolling eligible patients onto specific medicine collection programmes."

Naidoo is also advocating for creative measures to tackle the "colliding triple threat of HIV/AIDS, tuberculosis and COVID-19 simultaneously".

One proposed measure is to turn vaccination sites into multipurpose "health events" where patients can be screened and educated on a variety of illnesses. Naidoo says vaccination sites could offer pop-up pharmacies and video content on HIV, TB and cancer prevention, free coffees and other rewards for Pap Smears, TB testing and HIV screening. "We need to think laterally about how we can combine efforts to achieve greater public health outcomes in a shorter time," says Naidoo.

Andy Karas, USAID Southern Africa Mission Director says, "Through our and other PEPFAR implementing agencies' support of HIV and TB care and treatment programmes, great strides had been made in reaching the 90-90-90 HIV treatment, however the COVID-19 pandemic hindered progress. We must now redouble our efforts to get back on track and tackle HIV, TB and COVID-19 together so that we can support people to build healthy and prosperous futures.'

Dr. John Blandford, CDC Country Director for South Africa echoes the call to get back on track. "As we face the colliding epidemics of HIV, TB and COVID-19, we need to collaborate and partner to ensure that testing, treatment and suppression remain our priorities. Africa calls for revival of fishing communities

AFRICAN leaders and policymakers have called for strategies to harness the potential of the blue economy to achieve sustainable development.

The call came at a high-level conference hosted by the Government of Mozambique on November 18 and 19 in the City of Vilanculos. The theme was 'Investing in Ocean Health is Securing the Planet's Future.'

Mozambique President Filipe Nyusi hosted the event, attended by Kenyan President Uhuru Kenyatta, Ministers from other countries and leading policymakers from Africa.

African Development Bank Group President Dr. Akinwumi Adesina delivered a virtual message during the opening ceremony, highlighting the potential of blue economy initiatives.

"The continent has maritime zones that stretch 13 million square kilometers, encompassing territorial seas and continental shelves that also stretch up to 6.5 million kilometers. And 38 African countries are coastal," he said.

Adesina said there was an urgent need to revive the livelihoods of fishing communities.

"This can be achieved by governments and the private sector prioritizing enabling policies, and providing access to modern fish-

ing fleets, cold storage and processing facilities, and investing in infrastructure and climate advisory services to support climatesmart fishing practices."

Leïla Mokaddem, the Director General for the Bank's Southern Africa Region, represented President Adesina in person at the event. She said the Bank would continue to help Mozambique unlock its blue economy potential in the post-pandemic era by supporting regional approaches to coastal resilience and transboundary fisheries management in the Mozambique Channel and Indian Ocean region through the Southern African Development Community Secretariat.

Mozambique has the thirdlongest coastline in Africa, with enormous coastal resources that contribute significantly to the economy, including marine parks that provide social and economic

benefits for about half the population.

Mokaddem, who led the African Development Bank delegation at the conference, said the Bank was also co-financing one of the largest private sector investments, worth over \$5 billion, in regional infrastructure development, through the construction of a rail corridor and the deep water Nacala port to facilitate maritime trade and market access.

The Bank team, which included Cesar Augusto Mba Abogo, Country Manager for Mozambique, reinforced the Bank's commitment to building resilience against climate disasters in Mozambique, one of the 10 countries in the world most vulnerable to climate change. Within this scope, Mokaddem held bilateral meetings with the Minister of the Sea, Inland Waters and Fisheries, Augusta Maita, to discuss strategic

cooperation to develop the blue economy. Mozambique Minister of Economy and Finance, Adriano Maleiane, acknowledged the Bank's role in Mozambique:

"The African Development Bank is one of the principal strategic partners of Mozambique in the development of infrastructure projects and in the context of the development of blue economy initiatives."

The Minister hosted a high-level dialogue with Mokaddem and Bank staff on development projects in northern Mozambique, the transformation of the agriculture sector, the revision process of the 20-year economic development strategy and macroeconomic stability issues. Mokaddem also met with businesswomen to discuss their challenges and opportunities, and how to generate an economic recovery from the Covid-19 pandemic.

# **The EAC council of ministers** unlocks recruitment process

THE East African Community council of ministers has unlocked the recruitment process for vacancies that was postponed in October this year.

Making the announcement here yesterday, the chairperson of the council of ministers who is also Kenya's Cabinet Secretary for EAC and Regional Development, Adan Mohamed, said that shortlisted applicants from the EAC partner states would soon receive invitations from the Secretariat to participate in the interviews.

Mohamed further said that the Council during its deliberations found that the recruitment process had largely been above board, adding that the interviews were expected to begin in earnest to fill the slots that have been vacant for a long time.

To ensure equitability among partner states in the recruitment process, the CS disclosed that 11 of the vacant slots would be reserved for the Republic of South Sudan, the youngest member of the Community.

This is in accordance with the directive of the 41st Council held a day earlier to the Secretariat to ring-fence for the Republic of South Sudan eleven (11) vacant positions out of the fifteen (15) positions that are yet to be shortlisted as an affirmative action in the EAC recruitment process.

Adan was addressing media at the EAC headquarters shortly after he led Partner


# How inequality drives HIV in adolescent girls and young women

espite the advances that have been made against HIV, the world has 37 million people living with HIV. And 680,000 people died from AIDS-related causes in 2020. While the prevention of mother to child transmission, and provision of treatment as prevention, are great successes, there are still gaps. Over 1.5 million new HIV infections were recorded in 2020.

In 2020, adolescent girls and young women aged 15 to 24 accounted for 25% of new infections, while making up only 10% of the population. Six in seven new HIV infections among adolescents (aged 15 to 19) were among girls, even though boys live in similar contexts. Young women aged 15-24 years old were twice as likely to be living with HIV compared with men.

In addition to the difference in risk between the sexes, other risk and protective factors may have an influence. So, within the population of adolescent girls and young women, differences in their unique risk profiles mean that some may be at a higher risk of HIV infection than others.

Understanding risk profiles helps us realise that HIV is more than just a virus. These profiles highlight how HIV risk and HIV prevention uptake are influenced by biological, sociobehavioural and structural factors. So while new HIV prevention options may become available, adoles-

But sexual relationships often start in adolescence. The HIV transmission cycle highlights that adolescent girls and young women in agedisparate sexual relationships, (i.e "sugar daddies") are at higher risk than those in peer relationships.

and 66% of those on treatment Age-disparate relationships often have social, emotional, economic and sexual value that may outweigh potential risks. But they are usually characterised by power dynamics that make discussions about sexual health difficult. In contexts of high female poverty and partner dependency, the power and gender inequalities of these relationships will increase the risk of HIV infection and may limit the ability of adolescent girls and young women to ne-

gotiate safe sex practices. Gender-based violence: Adolescent girls and young women who are victims of gender-based violence will have risk profiles that make them more vulnerable to HIV infection. In contexts where female poverty is high and retaining relationships is critical for survival, agency to make sexual health decisions may be difficult.

Additionally, changing gender norms in young boys and ensuring more equitable gender beliefs as men grow older will create an environment in which female agency is non-negotiable and respected.


#### Services and interventions

Use of HIV prevention services is influenced by inequalities in access and by social and gender norms. Access does not equate to uptake. A lack of knowledge about sexual health, inequitable gender norms around sex, and conservative social norms about adolescent sexual well-being contribute to poor uptake of sexual and reproductive health services among adolescent girls and young women.

Engaging their sexual partners, challenging social and gender norms, providing comprehensive sexual education, and creating sex-positive and egalitarian health services for adolescents are essential for fighting the HIV pandemic in young people.

Without understanding the social context in which adolescent girls and young women manage and negotiate sex, and tailoring interventions to break the transmission cycle, it will be a struggle to achieve epidemic control in adolescent girls and young women

In sub-Saharan Africa, a more nuanced view of the risks faced by adolescent girls and young women will be essential for developing targeted and relevant interventions. These efforts will also help re-

# CBK rules out setting mobile loan rate caps

CBK Governor Patrick Njoroge on Tuesday ruled out fixing a cap for the digital lenders, saying they would apply the loan pricing models used by the banks. "If you mean ourselves having sort of caps and things like that obviously the answer is no. We are not going into that part of the world again, we already explained why," Dr Njoroge said after the Monetary

When Kenya scrapped legal controls of credit charges on November 7, 2019, the CBK warned banks against reverting to punitive interest rates of more than 20 percent in the post-rate cap regime. The regulator has triggered an appetite for

It had asked banks to submit new loan pricing formula that would be the basis of setting interest rates on new credit in an environment most which have not been approved. The CBK Governor said he would use the same approach when it comes to digital borrowers, meaning they will have to justify the expensive loan pricing.

"What we do and I have been saying on the banking side is ensuring the pricing is appropriate in many ways and I think you have already seen what we have done with the banks. We have talked about the pricing principles that we have, things related to how they should treat customers," Dr Njoroge said.

"So I think that's really a good model to start with. It doesn't mean that it will be translated word for word but definitely, the direction is clear." The push to control the activities of digital lenders comes more than a year after Kenya removed the legal cap on commercial lending rates.

The cap, which was introduced in September 2016, slowed down private sector credit growth as commercial banks turned their backs on millions of low-income customers as well as small and medium-sized businesses deemed too risky to lend to. The subsequent credit crunch

crolenders have invested in Kenya's credit market in response to the growth in demand for quick loans. Their proliferation has saddled borrowers with high-interest rates, which rise up to 520 percent when annualised, leading to mounting defaults and an ever-ballooning number of defaulters.

Market leader M-Shwari, Kenya's first mobile-based savings and loans product introduced by Safaricom and NCBA in 2012, charges

# **Bank of** Mozambique acts against financial violations

The Bank of Mozambique, between February 2020 and June 2021, imposed sanctions against eleven commercial banks and other financial bodies over violations of the law on preventing money laundering and the financing of terrorism and other regulations governing credit institutions.

In addition, nine individuals were fined for illegal financial transactions. According to a statement released by the Central Bank on Monday, the largest fine, of 64.4 million meticais (just over one million US dollars), was imposed on the African Banking Corporation (BancABC, which is headquartered in Botswana) for violations between 2016 and 2017.

In particular, it failed to check the identity of clients, conserve documents, immediately notify Bank of Mozambique the suspicious transactions, of prepare an annual report on the effectiveness of its internal control and risk assessment systems, and monitor transactions and politically exposed persons. In addition, the bank failed in its duty to carry out internal auditing on money laundering and the financing of terrorism.

In addition, the country's second largest bank, the BCI (Commercial and Investment Bank) was fined 52 million meticais for its failure between 2013 and 2018 to check the identity of clients or exercise continual vigilance over business relations, preserve documents, and report suspicious transactions. Three other banks, Standard Bank Mozambique, First Capital Bank, and Socremo were also fined for failing to report suspicious transactions.

# **Barrick Gold chief basks in World Gold Council's recognition**

**RECOGNITION of its investments** in communities to boost socio-economic development by World Gold Council has been received by Barrick Gold Corporation's President and CEO, Mark Bristow.

The WGC which released a report last week commending Barrick for investing almost U\$38 billion in 38 countries globally where it operates, said the money is made in form of payments to governments, employees and suppliers.

"We partner with our host communities and countries to transform their natural resources into tangible



benefits and mutual prosperity,' Bristow said while commenting on the WGC report which named Tanzania as one of the beneficiaries. Barrick and Treasury jointly own Twiga Minerals Corporation.

"Additionally, we hire talented individuals from the communities closest to our mines and train them to world-class standards; we leverage our supply chain to facilitate the growth of thriving and self-sustaining businesses; and our taxes further contribute to the economic development of the countries and communities in which we operate," Bristow added.

The WGC said Barrick's status as an industry leader in socio-economic development was underscored by the comparison between its performance and the industry wide figures reported by the World Gold Council which depicted that:

97 percent of Barrick's employees and contractors were host country nationals, compared to 95 percent reported cumulatively by the council's member companies; Barrick paid U\$1.8 billion out of the total U\$7.6 billion reported in taxes, royalties and dividends to host governments; U\$4.5 billion of the total U\$26 billion spent on goods and services was spent with local and national suppliers; and Barrick's total economic contributions amounted to \$12.1 billion out of the total U\$37.9 billion contribution reported in 2020.

"This all happened against the backdrop of the Covid-19 pandemic when our prompt and effective responses protected our businesses from the worst of the virus and provided a further opportunity for us to demonstrate our commitment to partnerships," Bristow noted.

The Barrick president and chief executive said that the company's ability to share the benefits of mining was one of the key ways it measured its success. The world's second largest gold miner spent more than U\$30 million on Covid-related community support measures in 2020 and prepaid more than U\$300 million in taxes and royalties. It also supported communities through a number of initiatives ranging from medical supply donations to local hospitals, loans to small businesses, setting up food banks and delivering food packages.

# SA banks fail to deliver customer satisfaction on social media

South African banks' customer service on social media platforms leaves much to be desired, with the majority of queries going days without a response.

This is one of the key findings of BrandsEye's 2021 South African Banking Sentiment Index, based on the insights company's analysis of the banks' social media customer queries over the past year. Having tracked social media posts about Absa, Capitec, First National Bank (FNB), Nedbank, Standard Bank, African Bank, Discovery Bank and TymeBank, the research found that overall, the banking industry still experienced more negative conversations on social media than positive.

As people settled into their

new socially-distanced normal, the reliance on digital customer service channels continued to grow, with social media platforms fast becoming a preferred service channel for many bank clients, it notes. In its sixth year of producing the index, BrandsEve collected over 2.7 million consumer social media posts about South African banks from 1 September 2020 to 31 August 2021.

The research firm's proprietary crowd of human verifiers analysed some 500 000 of these posts for sentiment and conversation themes, including the treating customers fairly (TCF) outcomes prescribed by the Financial Sector Conduct Authority (FSCA). Scrambling to win trust

BrandsEye, According to banking posted customers

an estimated 188 649 priority Twitter posts over the last year. This represents 28% growth in service conversations - 38% when including risk mentions - and this speaks to an increasing demand for social media customer service across the industry.

BrandsEye business development director Lyndsey Duff points out that considering many (57%) of these mentions went unanswered, South African banks still have a long way to go in meeting customers' growing social media service demands.


"Banks have yet to effectively handle the growing volume of service requests on social media. Service-related conversation first spiked in 2020 as a result of COV-ID-19, but continued to increase throughout 2021,"comments Duff.

In addition to exposing banks to unnecessary reputational risk, failure to swiftly identify and respond to service requests online also poses major regulatory risk, explains Duff. "When mapping the social media conversation according to the six TCF outcomes prescribed by the FSCA, we discovered that 50.1% of sentiment-bearing conversation contained a conduct

oversight theme. "With the Conduct Standard for Banks having come into full effect from July of this year, South African banks are required to enforce the TCF principles across multiple areas of market conduct, or risk facing hefty fines."

# Traders grappling with a whole new world of bond volatility

### **NEW YORK**

Federal Reserve Chair Jerome Powell set off further Tuesday by turbulence suggesting stubbornly high inflation warranted increasing the pace of policy tightening, adding potential upward pressure to bond yields.

At the same time, fears over omicron's resistance to existing vaccines had pushed benchmark 10-year yields to a two-month low this week. The whipsaw trading in bonds is threatening to compound the nervousness that has spread across financial markets as the recovery from the pandemic threatens to go off the rails. The higher the debt-market volatility gets, the greater the prospect it will filter through to spook stocks, which are still not far from record highs despite this week's declines.

Hedge funds have suffered losses in recent months when bond yields suddenly surged on inflation bets. Then, as investors brought forward wagers for rate hikes, central banks pushed back on those expectations to send yields lower.

After insisting for months that inflation is probably transitory, Powell in testimony to the Senate Banking Committee said it was time to retire the term, and possibly for the Fed to move more quickly toward raising interest rates by winding down its asset-purchase program faster. The new coronavirus variant, which last week caused a growth scare, also has inflationary potential

by worsening supply-chain Treasury market implied problems, he said.

"What's going to create a lot of volatility is the transition from one environment to another," said Kathryn Kaminski. chief research strategist and portfolio manager at AlphaSimplex Group in Cambridge, Massachusetts, which oversees about \$6.4 billion. Powell ditching "transitory"


is "this pivot into an different environment from a macro perspective," she said. The June 2022 eurodollar futures contract, which can be used to bet on Fed policy, has

seen historical volatility over a five-day period surge to the highest in more than a year. At the same time, its 50-day average has been rising since mid-September. Meanwhile,

volatility over the next 30 days, as measured by the ICE BofA MOVE Index, has climbed to the highest since the initial pandemic selloff in March 2020.

Volatility is also climbing in Asia-Pacific markets. A measure of implied Japanese bond swings jumped to the highest since March, while price swings for Australian 10year bond futures last week rose to the most since April.

# White House 'plans to tighten travel rules over Omicron threat'

### LONDON

THE Biden administration plans to tighten travel rules to combat the omicron variant of the coronavirus, by requiring all air travelers to the US to be tested within a day of their departure regardless of vaccination status, according to a person familiar with the matter.

President Joe Biden plans to announce the new requirements on Thursday in a speech detailing his plan to contain the pandemic through the winter.

Currently, vaccinated travelers must

get tested within three days of boarding their flight to the US; under the change, that would be cut to one day.

The US last week imposed travel restrictions that bar arrivals from foreign nationals who have been in any of eight southern African nations in the past 14 days. The administration hasn't said how long those measures will be in place.

The Washington Post earlier reported the administration's plans for tightening travel restrictions.

### **CNN suspends Chris Cuomo after** report raises 'serious questions'

### **NEW YORK**

CNN suspended host Chris Cuomo after documents released by the New York Attorney General's office showed he used his journalistic position to gather information about sexual-harassment accusations against his brother, Andrew Cuomo, who was



then serving as New York's governor.

"The documents, which we were not privy to before their public release, raise serious questions," CNN said in a statement, adding that they "point to a greater level of involvement in his brother's efforts than we previously knew."

The suspension is indefinite, the network said, pending further evaluation.

The documents, released on Monday, revealed that Cuomo (pictured) texted the top aide of his brother, Melissa DeRosa, inquiring about allegations against Andrew Cuomo and offering his help. Cuomo inquired about a then-unpublished story by Ronan Farrow in the New Yorker, for example. The CNN host confirmed to investigators that he spoke with "another journalist" about the Farrow piece, but said he didn't directly speak to Farrow.

Andrew Cuomo resigned as governor last summer after a report by New York Attorney General Letitia James found he sexually harassed multiple women. Cuomo denied the allegations.



### LUSAKA

THE Zambian government on Tuesday defended its decision to defend some COVID-19 preventive measures which have received sharp reactions from some quarters.

On Sunday, the Ministry of Health announced a number of preventive measures aimed at averting a surge in cases in view of a new variant detected in some neighboring countries and a projected fourth wave

Among measures include a requirement for all public servants to be vaccinated while entry to all government institutions will require a CO-VID-19 certificate, which have

been criticized as abrogation ensure we protect our people. of human rights and forcing people to vaccinate.

But Minister of Health Sylvia Masebo said the measures have been undertaken in the interest of the people and were not meant to take away people's rights.

She told reporters during a press briefing that the government has been conducting consultations with relevant trade unions and will continue to do so on the preventive measures which have received sharp reactions.

"We know what happened in the third wave when we lost many people due to COVID-19. So we have decided to take these measures in order to

We don't want to take decisions after people start dying," she said.

The minister said since the announcement of the measures on Sunday, the number of people turning up to be vaccinated has increased, adding that it was the government's desire to ensure a good number of the eligible population vaccinated According to her, the health

system in the country would not be able to contain a surge in cases hence the need for preventive measures before the situation gets out of control

While acknowledging the importance of taking the vaccine as one of the preventive measures, the minister said the government will not force people to get the vaccines.

The Resident Doctors Association of Zambia President Brian Sampa said it was wrong to subject people to a vaccine against their will as people have a right to choose what goes into their bodies.

Meanwhile, the Zambia Union of Nurses Organization said it does not support the stance taken by the government to subject public workers to mandatory testing as it was an abuse of their rights.

Michelo Fray, the union general-secretary said the association was not consulted on the matter and accused the

government of already making a decision without getting the views from stakeholders. In a release, he said the union was only in support of mass sensitization and not mandatory vaccination. Xinhua

NIGERIAN authorities on Tuesday confirmed security operatives have arrested up to 17 fleeing inmates among those who escaped from a prison after a gunmen attack in the central state of Plateau on Sunday.

Also, an investigation has been launched into the latest prison attack, with an aim to track down "the sponsors of the incessant jailbreaks" across the country, said Mohammed Tukur, a deputy controller general of the Nigeria Correctional Service (NCoS).

Tukur disclosed this to reporters in Jos, capital of central Nigeria's Plateau state, where the latest attack occurred on Sunday, saying the probe would unravel the identity of the attackers and other necessary details of the incident.

At least 11 people were killed and 252 inmates escaped from the custodial center in the city of Jos when a group of unknown gunmen attacked the facility Sunday evening, the NCoS earlier confirmed.

"We have commenced investigation on the ugly incident and only when that is concluded that we can ascertain who the perpetrators are. But I want to assure Nigerians that we will do our best to bring the criminals to book," said Tukur who was in Jos city to assess the level of damage caused by the attack.

### New technologies impress visitors at 2021 World Manufacturing Convention

It can be used for Go game training, helping improve players' strategies in a targeted manner and providing auxiliary information for professional players to think more creatively, Huang pointed out, adding that interaction with the robot can also help more teenagers understand the charm of Weiqi culture.

A contactless smart integrated cooker exhibited at the 2021 WMC was also eye-catching. Because of interactive aerial imaging technology, the cooker's buttons are shown virtually in the air, thus ef-

fectively avoiding oil stains, according to Geng Dexue, a staff member of Anhui Easpeed Technology Co., Ltd., developer of the smart integrated cooker.

"The interactive aerial imaging technology we developed independently has been applied in health care and other fields. At the beginning of this year, contactless selfservice machines equipped with the technology were put into use in many hospitals in Anhui," Geng noted.

Many cutting-edge technologies and advanced products were also put on display at the event, including quantum computing, high-end new energy vehicles, the 6th-generation flexible display screen, and panchromatic laser.

The 2021 WMC not only provided a stage for products but generated orders and benefits for companies.

# Three students shot dead at Michigan high school

A 15-year-old boy opened fire in a Michigan high school on Tuesday with a semi-automatic pistol his father had purchased days earlier, killing three fellow students and wounding eight other people before he was arrested, authorities said.

Oakland County Sheriff Michael Bouchard told a news briefing hours after the rampage at Oxford High School that investigators were at a loss to explain what might have precipitated "an unspeakable and unforgivable" act of violence.

The suspect, disarmed and taken into custody by sheriff's deputies minutes after the shooting began, has declined to speak with investigators after his parents retained a lawyer and denied authorities permission to interview their son, Bouchard said.

"The person who's got the most insight on motive is not talking," the sheriff told reporters.

Bouchard said he was unaware of any previous run-ins with law enforcement by the suspect, a high school sophomore, adding there was "nothing to suggest that there had been disciplinary issues or problems with him at school."

The bloodshed unfolded around midday in Oxford, Michigan, about 65 km north of Detroit, as terrified students and teachers taking cover inside the school flooded the county emergency dispatch center with more than 100 calls for assistance, authorities said.

Bouchard credited swift action by his deputies, who he said arrived on the scene in minutes and moved straight toward the sound of gunshots, with preventing a much higher casualty toll.

They confronted the young suspect advancing down a hallway toward them with a loaded weapon, when he put his hands over his head and surrendered, Bouchard said.

The precise sequence of events dur-

ing the violence remained unclear, but police believe the boy carried the weapon into the school in a backpack, the sheriff said.

"The only information I have is that he came out of a bathroom with a weapon, and I don't know where he went first," Bouchard said.

### Placed in juvenile detention

Police will ultimately turn over the findings of their investigation to prosecutors, who would decide what charges to bring and whether the suspect would be charged as an adult or a juvenile, the sheriff said.

For now, the 15-year-old suspect, whose name was withheld by authorities because he is a minor, was being detained in a special cell under suicide watch at a juvenile detention center, Oakland County Executive David Coulter said.

Three students died in the shooting spree - a 16-year-old boy who succumbed to his wounds en route to a hospital in a patrol car, and two girls, aged 14 and 17, authorities said.

Of the eight others struck by gunfire, seven were students, two of them hospitalized with gunshot wounds to the head.

At least two girls, aged 14 and 17, were described by Bouchard as critically wounded with chest wounds, one of them placed on a ventilator.

A teacher was also treated for a shoulder wound and later discharged.

### Ethiopia says it's made headway in war against Tigray rebels

### By Bloomberg

ETHIOPIA'S government said its forces have recaptured a swathe of territory in the north of the country in a major counter-offensive against fighters loyal to the dissident Tigray province and have gained the upper hand in a yearlong civil war.

Fighting has engulfed Africa's secondmost populous nation since Prime Minister Abiy Ahmed ordered an incursion into Tigray in retaliation for an attack on a federal army base. The conflict, which shows no signs of letting up, has hammered investor confidence in what was one of the world's fastest-growing economies and sparked a sell-off in the nation's bonds.

,After initially being pushed out of the Tigrayan capital of Mekelle, the region's ruling Tigrav People's Liberation Front struck back and its troops retook the city, most of the province and parts of the neighboring Amhara and Afar regions. That raised fears they could sever key trade routes or even stage a strike against the capital of Addis Ababa.

"The Ethiopian Defense Forces have launched a counter-offensive on the terrorist organization and the prime min-

The government's claims couldn't be independently verified, and it was unclear whether a major turning point had been reached in the fighting. There was no immediate response from Tigray officials, who have previously said they were winning and their forces had advanced to within 220 kilometers of the capital.

Yesterday, Abiy's office said the government offensive had continued to yield results, with rebel forces pushed out of several strategic villages and towns along or near the main road between Tigray and Addis Ababa.

Thousands of people have died in the conflict and hundreds of thousands of others have been displaced. Humanitarian agencies say more than 1 million people are in need of aid.

Billene accused the mainstream media of spreading a "false narrative" that exaggerated the extent of the war, "ignoring the fact there is no more fighting in Tigray and peddling libelous stories of ethnic cleansing and genocide by the government."

The US, UK, France and other Western nations have urged their citizens to leave Ethiopia, and the United Nations has evacuated most of its staff.

China to launch pilot reform project on business environment in six cities

ACCORDING to a recent guideline issued by China's State Council, Six Chinese cities will launch a pilot reform project to improve business environment. The six cities are respectively Beijing, Shanghai, Chongqing, Hangzhou, Guangzhou, and Shenzhen.

Lu Xiangdong, an official from the General Office of the State Council, introduced that the guideline was issued after the State Council solicited a wide range of opinions from market entities and relevant parties and held in-depth discussions. Over 100 reform measures in 10 fields were raised, the official added. The six cities were selected for the reform project because they have a complete industrial system and a large size of market entities, and they have built a solid foundation for reform after having gone through a series of positive explorations, Lu explained. Besides, the six of them include municipalities, cities under separate state planning and provincial capitals located on both the east and west of the country, the official introduced, adding that the six cities have their own advantages and characteristics. Lu said that the pilot reform project will play a bigger catalytic role in these cities. To gain experiences that can be replicated in other regions of China is a fundamental requirement of the pilot project, so that the Chinese business environment can be constantly im-

### Google to ban political advertising ahead of Philippine election

### MANILA

ALPHABET Inc's Google said vesterday it will ban political advertising on its platform in the run-up to Philippine elections in May next year to choose a successor to President Rodrigo Duterte.

The move comes amid pressure on social media platforms over their handling of political advertising during the US presidential election in 2020.

Social media platforms have become political battlegrounds in the Southeast Asian nation, with studies showing Filipinos top the rankings globally for time spent on social media.

Election advertisements that promote or oppose any political party or the candidacy of any person or party for public office, would not be allowed to run between Feb 8 to May 9, 2022, Google said in an update to its political content policy. The dates cover the period of campaigning in the Philippines up to election

day on May 9. Google said notifications would be sent to affected advertisers about the policy update.

Google has banned political advertising on its platform before, including in Canada's federal election in 2019 and before an election in Singapore in 2020. Agencies

The award, held by French magazine France Football and voted for by selected journalists around the world, was cancelled last year because of the coronavirus pandemic, but the honour has once again been bestowed on Paris Saint-Germain and Argentina forward Messi.

Bayern Munich forward Lewandowski finished second in the polling, while Liverpool's Salah was placed in seventh position.

Although voters are urged to vote on the players' individual and collective performances during the calendar, and their fair play, a third element of the vote is focused on the "overall judgement of the player's career."

Liverpool manager Klopp said that criteria favours Messi ahead of all other candidates, including Lewandowski and Salah.

"I'm really not sure about it [Ballon d'Or], 100%," Klopp said when asked in a news conference ahead of the Merseyside derby. "You can always give it to Messi for his career, but if you don't give it to Robert Lewandowski this time, after this year, it's quite tricky for him to get it all.

"And Mo [Salah] should have been higher up, definitely. I was surprised by his position, to be honest. I saw the vote somewhere, I don't know exactly [how it is voted for]. It's journalists, yes? Then don't ask me -- it's your fault. Speak to your colleagues if you think it should have been different."

Liverpool face Everton at Goodison Park on Wednesday in the first Merseyside derby of the season and the first since former Anfield manager Rafael Benitez took charge of the Blues.

Although the fixture is regarded by both sets of supporters as the biggest of the season, Klopp said the players involved cannot treat it the same way.

"We know there are some special things around derbies, but it's a football game as well, that's how we approach it," Klopp said.

"We understand the supporters' soul and we try to fill their wishes. Derbies are in focus, but we approach it like a [normal] football game."

Similarly, Benitez told a news conference the derby is a massive game for Everton and the derby is a good chance to right a bad run: "The fans understand we have issues, injuries to key players, but we started the season well, so we have to get back to that level.

PEP Guardiola has told Jack Grealish that the start to his Manchester City career has been "better than maybe he believes.'

Grealish has admitted he has found life at the Etihad Stadium "difficult" after leaving Aston Villa to become English football's first £100 million player in the summer.

He returns to Villa Park for the first time with City on Wednesday and ahead of the game, Guardiola has assured the 26-year-old he has been happy with his form since his arrival.

"My opinion is he's played much better than maybe he believes," Guardiola told a news conference on Tuesday.

"Maybe at Villa, everything started with him and he was free, you know, now he's in a new position and maybe has not been so determined or so clinical in the final third.

"Maybe because he respects his mates, maybe because it's a new environment, and that's normal, it's a process. He needs time. All the players who come here, for the first season, always struggle.

"But what he sees and what he has to do, is so easy for him with the quality he has. Just be free here and be who you are, that's all, no more. I don't say to the players what they have to do -- they play.

"When they get the ball close to the box, my friend, you decide whatever you want. That's why you are Jack Grealish and not another player. They have to play and make their moments.'

Grealish is hoping to be fit to face his former club after missing the last three games through injury.

He has been a consistent starter for City so far this season but was left on the bench for the 2-0 win at Manchester United before the international break when Guardiola opted for a front three of Gabriel Jesus, Bernardo Silva and Phil Foden.

"Sometimes it's the environment, a new house, private life, but not just Jack -- all the players," added the City boss.
