The president blamed the rampant corruption force among officers, noting that some officers have been asking for bribes from visiting tourists.

"Can you imagine, some officers can even get their heads inside a car to take a bribe; what could happen if the driver had a weapon? Such incidents smear the image of the police force," she declared, charging the po-

lice with being in the forefront of violating the laws they are supposed to enforce. She similarly cautioned the officers on negligence in taking care of their work equipment including weapons.

Dwelling on offensive language, she said some words used by police officers promote racism. "You should learn to be friendly to people and use wisdom in making any decisions,"

she emphasised.

She similarly queried why all police college candidates pass their exams when they go for training at the Moshi-based Tanzania Police School, when in reality some of them do not deserve the pass marks.

'Stone Town tourism spot will be restored'

ZANZIBAR President Dr Hussein Mwinyi has said that rehabilitation and restoration of properties within the Stone Town-the Isles' tourist hotspot-is not a matter of choice, but a necessity.

Addressing editors at the State House Zanzibar at the weekend, Dr Mwinyi said that property owners in the zone, rated as a UNESCO World Heritage Site have to undertake the restoration works themselves or seek investors to collaborate with them in that task.

"As you know we rely on two main types of tourism: antiquities and beach. Yet, most houses in Stone Town are in a dilapidated condition hence the need for urgent repairs," he said.

The tricky part, especially for individual property owners, is that the rebuilding in the area is not free style. Each property must be restored to its original shape, lest it loses its allure-a source of tourist dollars," he explained.

The 'restore to original shape'

condition might compel many landlords to strike deals with investors as the government has received help from Oman in ongoing efforts to restore the landmark House of Wonders which partially collapsed on Christmas Day last year.

"Those who can afford to do it should proceed; those who cannot should seek investors so that arrangements are made for them to temporarily vacate the properties

TAHA member touts organic pest controls

THE Tanzania Horticultural Association (TAHA) says its members have made a breakthrough in organic pest control for domestic and export markets.

TAHA Group CEO Dr Jacqueline Mkindi said here at the weekend that painstaking efforts to produce biological control agents have paid off, noting that some products have already been approved for export abroad.

Multiflower Ltd pioneered production and export of biological control agents, contributing of making Tanzania meet domestic consumption of organic products, she said, noting that the country is now positioned to capture

a slice of the global organic food market, when the produce of other companies are included,

The organic food industry is a thriving trade, with Report Linker projecting the annual global market value growing

to \$368.94bn by 2026, up from \$167.85bn in 2020. "Our duty now is to promote application of this environment-friendly pest

own hands, she stated, tasking the IGP with bold action to make the police force disciplined and capable of winning the public trust.

Some police officers do not adhere to professional ethics excusing themselves with 'low pay,' while pledging to work on the matter.

management method as we seek to get a share of the global organic food market," she stated.

Multiflower Ltd, based in Arusha, says that currently its installed capacity is 1,200 liters of biocontrol agents per day or 6,000 liters per week. This offers a ray of hope to horticultural growers and exporters to take advantage of the world organic food value chain, she stated. Multiflower Ltd managing director Tjerk Scheltema said that the biocontrol agents are currently supplied to local flower farms and the surplus are exported to Holland,

elevating Tanzania's profile in relation to agro-sector innovation.

The biological control agents include predator mites such as Phytoseiulus persimillis, Amblyseius swirkii, Amblyseius montdorensis, Neoseilus californicus and Stratiolaelaps scimitus.

Biological control application in agriculture proves to be beneficial to the environment and human health as it eliminates toxicity by conventional pesticides on the plants, soil and water. The agents multiply easily in the soil and leave no residual problem, he stated. The biocontrol agents not

only control the disease.

but also enhance the root and plant growth by way of encouraging beneficial soil microflora and increasing the crop yield, he said, expressing his being elated at Tanzania for the first time exporting biological control agents to international markets. The success story wouldn't be possible without painstaking efforts by TAHA, working with the Ministry of Agriculture to streamline policies, regulations and procedures to facilitate the production, registration and export of these natural enemies of pests that cause losses in the horticulture industry, he affirmed. It was difficult to import or

export biocontrol agents as the registration procedures under the Pesticides Act (Plant Protection Regulations), 1998 were silent on the process of its registration and exportation. "The tight and silent regulations made it challenging for horticulture companies to produce, register, import or export plant protection substances even though the companies have the requisite capacity. skills and technology to do so," he explained. TAHA in collaboration with the ministry pursued efforts to strengthen pest control, organising strategic discussions to tap

the potential of producing these important agents to meet local and international demand, he elaborated. Through technical expertise from the biological control agents sub-committee, plant health services and parliamentary committee members for Agriculture, Livestock and Water pushed to revise the regulations and come up with an up-to-date regulatory framework incorporating modern technologies, he further stated. These engagements facilitated a legal structure easing the production, registration and exportation of biological control agents under the

Plant Protection Act, 2020

and guidelines for the export, shipment, import and release of biological control agents and other beneficial organisms.

Kelvin Remen the TAHA business enabling environment manager, said that all these efforts have started paying dividends as they have encouraged Multiflowers Ltd to produce and export the biocontrol agents for the first time.

Currently, horticulture earns the economy around \$779m annually, up from \$100m in 2004, despite that the industry is still in its early stages in its potential for creating jobs, wealth and health, he added..

while restorations works take place," he elaborated.

The unique buildings in Stone Town, executed mostly in coral lime ragstone and mangrove timber, set in a thick lime mortar and then plastered and lime-washed. It reflect a complex fusion of Swahili, Indian, Arab and European influences in building traditions and town planning, experts say.

The major buildings date from the 18th and 19th centuries and include monuments such as the Old Fort, built on the site of an earlier Portuguese church; the House of Wonders, the Old Dispensary; St. Joseph's Roman Catholic Cathedral; Anglican Cathedral commemorating abolishment of the slave trade and built on the site of the last slave market.

It also features the residence of ivory and slave trader Tippu Tip, the Malindi Mosque; the Jamaat Khan for the Ismailia community and other monuments.

With alleys meandering to and from different directions, Stone Town is a beehive of activity with owners of commercial and residential properties earning tidy amounts of money, thanks to the purchasing power of tourists who throng Zanzibar to see this unique enclave or bathing in the Isles' sandy beaches.

The partial collapse of the House of Wonders, here two people died, was a wakeup call for authorities to act, leading to the systematic project for dilapidated buildings to be restored.

Home to the Museum of History and Culture, it is not only the largest but also the tallest building in Stone Town. Built in 1883, the palace was the first building on the island to have electricity and the first in the region to have a working elevator, chroniclers affirm.

Health workers undergo capacity building training

A TOTAL of 52 health workers including 26 regional health coordinators and 26 regional school health promotion coordinators from all regions in the country have undergone capacity building training on health promotion at the University of Dodoma (UDOM).

Some other 13 national level health promotion coordinators and administrators also took part in the training, thanks to partnership between the Health Promotion and System Strengthening Project (HPSS) and UDOM that have joined hands in health promotion initiatives.

The five-days training focused on introducing participatory approaches and technics for health promotion in community and school settings.

Speaking on behalf of participants during the closing ceremony, Dr Ndenina Swai, coordinator of school health education in Dar es Salaam region noted that the training which focused on how to provide health education at lower levels, school was very fruitful.

"The training has opened our eyes, providing more insights in implementing health promotion, especially after realizing the situation on the ground during field visits in few schools in the city." she said.

During the field work part of the training, the participant visited Ihumwa, Mkonze and Hombolo primary schools, all within Dodoma city council to witness conditions of health promotion activities.

She said the three groups that visited one school each reported quite a number of health challenges that the government need to look into, saying the schools in Dodoma are just a replica of the situation in other schools across the country.

Dr Swai observed that students, just like other members of the society deserve health services even when while at schools.

HPSS-Tuimarishe Afya a Swiss-Tanzania Cooperation Project, funded by the Swiss Government through Swiss Agency for Development and Cooperation (SDC) and implemented by Swiss Tropical and Public Health Institute (Swiss TPH) in partnership with the UDOM, aimed at building the capacity of health workers from public health facilities across the country.

TPH/HPPS project manajer, Ally Kebby noted that the training covered different participatory approaches that seek to empower communities to take over control of their health and wellbeing.

He said, "Now the participants are expected to have deepened their knowledge in planning, budgeting, implementing and supervising interventions for community and school health promotion".

Kebby termed the training as part of the innovative ways to improve provision of health promotion and services in general.

Zanzibar beach hotel investor arrested second time for assault

OWNER of Sipano Beach Lodge Kiwengwa, Peter Sipano Meelta has been allegedly arrested by the police for the second time after he was first arrested on orders from Unguja North Regional Commissioner and detained for four days without charge.

Unguja North Regional Police Commander, Martin Lotienoa confirmed the second arrest of the native hotel investor on allegation of assaulting Turkish nationals to whom he rented the hotel to run and stealing their mobile phones.

"True, we have arrested him for assaulting Turkish nationals as he was with some fellow Maasai, but we are still investigating the matter," he said, adding that thereafter he would appear in court.

"We are also looking into the alleged theft of mobile phones belonging to the Turkish nationals, but regarding the issue of the conflict pitting him and those to whom he had rented the hotel does not concern us," added the RPC.

However, speaking by phone as he was under police escort, Peter denied any involvement in regard to attacking the Turkish nationals and stealing the mobile phones.

He said since he discovered the scheme to swindle his hotel, he has

committed crimes, including the first one he was arrested on orders from the Regional Commissioner, Ayoub Mohamed Mahmoud.

He said on that day, the Turkish nationals were about to attack him and was forced to move out of the hotel.

"I rented the hotel to Zanfood Trading Limited to enable them operate it under the management of the Turks, but now they have turned against me saying the hotel is theirs while they have never provided even a single brick or equipment for its construction," he complained.

For his part, speaking to journalists at his Mkokotoni office, Zanzibar North Regional commissioner, Ayoub Mohamed Mahmoud, confirmed receiving a complaint from the indigenous investor and decided to bring them together for holding talks. He said after bringing both parties through their lawyers since the government cannot intervene in business disputes, "I beseeched them to avoid acts that could cause breach peace and disrupt the tourist sector in general."

He said as they were in talks, an incident was reported at Kiwengwa police station that a group of more than 13 Maasai with sharp objects invaded the hotel and begun robbing visitors of their belongings.

HKMU calls on govt to increase students loan for medical studies

Hubert Kairuki Memorial University (HKMU) has urged the government to consider increasing loans and sponsorship to students undertaking courses for medical studies, a move that would help to fill the deficit of health professionals.

The plea was made over the weekend by HKMU council chairperson, John Ulanga during the 19th graduation ceremony that was held at the university premises in Mikocheni, Dar es Salaam. A total of 309 students graduated with diploma, degree and master's degrees.

Ulanga said that it is estimated that after 30 years, the number of Tanzanians will double, hence the need to give priorities to students undertaking medical studies because the current deficit of health professionals will become worse in coming vears.

Data from the World Health Organisations (WHO) shows that in Tanzania a doctor attends over 20,000 patients annually while the organisation recommends that one doctor attends to at least 1,000 patients annually.

He commended the Higher Education Students' Loans Board (HESLB) for providing loans to HKMU students and other higher learning students saying that without loans the number of graduates in the health sector could have been lower.

"I advise the government to increase loans to students undertaking medical studies. This year, the majority of students at HKMU got little loans, especially in school fees, this is not a good trend; we must increase sponsorship" he said.

Ulanga commended the HKMU Vice Chancellor, Prof Charles Mgone for a job well done since he joined the university five years back, adding the university's academic quality is becoming better every vear.

Speaking at the occasion, Prof Charles Mgone said the university has sponsored over 13 lectures for master's degree and PhD at various universities within and outside the country. He said the aim is to improve the university's academic perfor-

mance.

He said HKMU will continue to conduct different research through its academics and students, adding that this year, despite their busy schedule they have managed to publish a number of publications.

"We will continue to emphasize on research because it is one of our obligations. I would like to take this chance to commend students for all the publications produced," said Prof Mgone, noting the publications were recognized within and outside the country.

Mpanda district offers sexual and reproductive health training

A section of adolescent girls and young women in Mpanda district, Katavi region have been trained on sexual and reproductive health (SRH), entrepreneurship and HIV/AIDS to help them make informed decisions regarding their lives.

The training is provided by Hope Centre for Children, Girls and Women in Tanzania (HCCGWT), under the support of the Her Voice Fund, the three-day training benefited 20 adolescent girls and young women from 15 wards.

Speaking during the session recently in Mpanda, Halima equip the groups with knowledge on Sexual Reproductive Health Rights (SRHR), HIV/AIDS, how to generate income hence to help them in making informed decisions on their sexual health as well as empower them with advocacy skills to cascade the knowledge to their fellow youth and other community members.

"The training content had five sessions which were COVID-19 precautions and prevention, HIV/AIDS, business and entrepreneurship, SRHR, child marriage, teenage pregnancy and child protection," she noted.

She said peer to peer education on SRHR is very important but sometimes it is misleading therefore it is important to invest in comprehensive SRHR education to youth so that they can cascade the right information to their fellows in the community

"More advocacies are needed to advocate for youth-friendly services in the health centres. Not only youth-friendly but also acceptable and free SRH services to adolescence and young people."

Rhoda Lazaro, one of the beneficiaries said: "The training has helped us o understanding other SRH rights including the right to have a comprehensive sexual education, right to choose a partner, right to safe sex, right to quality SRH services and rights to decide on the number came from wards of and spacing of children." Another participant, Loveness Cosmas said the training has helped them to understand safer sex, protecting themselves and partners from sexually transmitted infections as well as unplanned pregnancies through use of condoms and other safe means.

She further added that decision-making skills and confidence in their choices by saying "no" to unsafe sex no matter what the situation is will help them to convince their partners to use a condom. This is to ensure that the girls remain safe from STDs HIV AIDS and unplanned pregnancies.

Access to SRH and HIV services in Katavi among the young girls and women was still low and this is due to many reasons including stigma towards accessing the services, cowardice in receiving their health status report, unfriendly health service providers.

And this has led many youth to refrain from visiting these centres for advice and testing. After training conducted by HCCGWT, there is a positive response from the AGYW to seek advice and check their health status.

'African countries have rights to choose own governance systems'

AFRICAN nations should be allowed to develop their homegrown governance systems instead of adopting the Western-style democracy that has not yielded positive results over the years, said scholars, government representatives and diplomats as they were attending a democracy symposium on Friday.

Opening the symposium themed "Dissecting Western Democracy in Africa", Okello Oryem, Uganda's minister of state in charge of international affairs, said African people should be allowed to determine a democratic system that works best for them.

"The one-size-fits-all model of democracy cannot deliver the aspirations of the people and it's important that democratic assessment be made based on the unique and peculiar conditions and circumstances" of each country, the minister said at the half-day event.

"There is a need to respect national sovereignty and territorial integrity of each nation. The big and powerful nations should not prescribe, impose and super-impose their systems

and values that may not be tailored to local circumstances," he added, noting that there is a need for democratic adaptations based on what serves well the people.

Alemtsehay Meseret, Ethiopia's ambassador to Uganda, said that just as Africa fought for independence, it should fight neocolonialism.

"We should provide solutions to our own problems. As Africans, we fought for our independence, we shall say no to neocolonialism," Meseret said.

David Mafabi, senior presidential adviser to Ugandan President Yoweri Museveni, said that no other countries can determine African countries' governance systems.

"It is not for any nation or country to tell us what to do and what not to do. It is not for them to determine how we govern ourselves. We have laws, they may be flawed but we don't have impunity," Mafabi said.

African nations need to realize that they can only defeat foreign intervention when united, and as long as Africa remains balkanized, it will be difficult to fend off interference by foreign powers, Mafabi said.

of mind that the United Nations marks each December 12 to exercise positive influence on belligerent parties in war and pave the way to peace. It means that when neutral states are in the majority, it implies that parties adding to widening conflicts are few, with each neutral country pushing for peace. It was a core value of founding the United Nations but with a checking mechanism on naked aggression, and was at the base of the nonalignment movement at the time that most of Africa was coming to independence, after Asia.

While neutrality is basically a foreign policy maxim, there is a significant element of it that works in domestic politics, where a power that stands above two contending groups takes a neutral position, thus pushing the two subordinate or dependent parties to a better negotiating mood.

That can have different implications depending on the situation, for instance neutrality when genocide is happening -the way African countries stood aside during the Rwanda genocide of mid-1994 was rebuked by retired President Julius Nyerere at that time. It was a moment to stand for principles, not feigning neutrality.

A generation earlier, Western countries were demanding that African states show neutrality in the contention between the black majority in Southern African states and white minority regimes, that focus on dialogue takes hold.

It meant that African countries avoid assisting liberation movements and ask those involved in the freedom struggle to talk to regimes

Within the country, the issue of neutrality tested Union relations as Zanzibar was turbulent from the start, with Mwalimu being on record as having visited Zanzibar after the Union and strongly warned the leadership that after ending their torment of Arab citizens, they would turn their guns on themselves.



Forty years of Aids: Justice and equality remain key to quelling a still-potent epidemic

THE past four decades have yielded enormous medical and scientific progress - but death and stigma remain. Many elude testing or die in shame, treatment does not reach all who need it, and inequality impedes our global response.

I can write this because life unexpectedly afforded me survival from AIDS.

Around Easter 1985, I became infected with HIV. There was no treatment: HIV meant certain death.

Like many, I kept my HIV status a secret. I hoped to escape death. No. Twelve years later, AIDS felled my body. I became terribly ill.

But my privileges gave me treatment and care. I had loving family and friends, and my job as a judge in South Africa. With early access to life-saving

because shame, fear and discrimination still silence too many.

As a judge, and from my own deepest life experience, I have witnessed three facts. First, the destructive force of stigma and shame. Second, the damage punitive and discriminatory laws inflict on public health responses. Third, how insufficient legal protections make the cruel load of HIV infinitely worse.

Thus, to overcome AIDS, we must achieve greater equality for all.

It is laudable that UNAIDS's new strategy highlights how "inequalities fuel the HIV epidemic and block progress towards ending AIDS", and ending inequality is vital.

Punitive and discriminatory laws target key populations most at risk of HIV. The criminal law clenches the throat of good AIDS work. Stigma sits as a burden on the backs of those living with and at risk of HIV. It intensifies inequalities.

people behind". They push those most at risk away from health and social services, increasing HIV infections.

UNAIDS executive director, Winnie Byanyima, recounted how stigma killed her brother, who had HIV "and would be living today but he was afraid to go to the clinic to fetch his ARVs". Her conclusion? Stigma and discrimination kill.

Discrimination seeps into data and evidence collecting, where key populations are often under-represented. This is profoundly harmful. We do not know whether services are accessible and acceptable.

This reflects an extreme form of stigma - being wiped out.

How do you remove barriers to access services if you do not even see who they are crushing?

scrapping punitive laws, implementing awareness and education campaigns, and supporting civil society.

Through the decades, activists from all over the world secured lifesaving gains in treatment for AIDS. The activists' struggle was about life versus death, health versus sickness, science versus myths, discrimination versus equality - and how fair practices make sound public health sense and save lives. In South Africa, the activists challenged the denialist government in the highest Court - which ordered him to start providing ARVs.

Though there is no cure, AIDS is no longer a death sentence.

Twenty-four years after taking my first ARVs, I am living a vibrant life. Our challenge lies within ourselves, and our societies: to overcome dis-

RECENTLY, the country was almost thrown into panic when reports from industrial leaders said there was only 15 days of petroleum products available. This is a regulatory requirement but the panic was caused by oil marketing companies warning that the country may face shortage of fuel because importation had been disrupted as they lacked money to place orders.

The Oil Marketing Companies (OMCs) said that the government's decision to stop an increase of pump prices in September had created a 10bn/hole in their finances because the fuel was sold a lower prices compared to increased global prices.

The panic was also a result of the harsh reality that consumers learnt for the first time that the nation had only two weeks of petroleum products in stock. As a net importer of petroleum products, Tanzania needs to have a strategic reserve for the product to guard against unforeseeable risks in future including supply chain disruption, war or other similar forces.

It is along such lines that we feel that the government has to make a firm decision to establish the strategic petroleum products reserve. In fact the facility is already there and is partly owned by Treasury.

Tanzania International Petroleum Reserve which was formerly known as Tanzania Italian Petroleum Refinery, had enough facilities to host the country's proposed strategic petroleum reserve for emergency use.

The TIPER facility in Dar es Salaam which is jointly owned by Treasury and Audax Oryx Geneva of Switzerland, has capacity to store 254 million litres of petroleum products after heavy investment was made since 2000.

The TIPER tank farm at Kigam-

boni which changed its function in 1999, when it became a complete storage facility after the refinery was closed down due to financial constraints, had increased its capacity from 140 million in 1999.

In fact decision was already made in 2018 that TIPER be a single receiving point for all petroleum products to also reduce leakages and demurrage charges paid to shipping liners for delays in offloading petroleum products at Dar es Salaam port.

Kigamboni TIPER tank farm stands on a 50 hectares piece of land with direct connections to Kurasini Oil Jetty and Dar es Salaam port's SPM. In addition to being connected to all oil marketing companies depots for easy transferring of petroleum products, TIPER has also invested in a facility to allow tankers to be loaded with petroleum products right within its backyard.

But by making full use of TI-PER tank farm, Treasury will also be making more revenue both in terms of dividend earned as a shareholder but also in terms of reducing revenue loss caused by leakages resulting from discharging petroleum products from oil tankers to depots of various OMCs.

In his report in 2016/17, Controller and Auditor General advised in a report that TIPER be turned into a single receiving facility for all petroleum products imported into the country to save the nation demurrage charges which are paid to shipping liners for offloading delays at the port. The CAG said the country pays up to U\$25,000 per day in delaying charges to oil tanker owners per day in demurrage charges, something which can be avoided if the decision to have a single receiving point is enforced.

antiretroviral treatment (ARVs), I recovered.

In 1999, I spoke publicly about living with HIV and that ARVs - denied to millions in Africa - had saved me from death.

I remain one of the only public figures in Africa who speaks openly about being gay and living with HIV. I say this Intersectionality matters as the perils of discrimination mingle. A sex worker, who has a higher risk of contracting HIV, is attacked on numerous discriminatory grounds. These laws do not merely "leave We can help by instilling and safeguarding democratic values and enabling legal environments.

The rule of law, freedom of expression, freedom to protest and other human rights matter. It means employing the law to empower rather than oppress. Fostering accountability for human rights violations, crimination and stigma and ensure life-saving treatments are equally and equitably accessible.

We can end AIDS by 2030. But to do so, we must respect, protect and fulfil the basic rights of those living with and at risk of HIV. With enough support, science and love, we can end AIDS.

The competition for summits with Africa

THE 21st Century seems to have ushered in a period of intense competition to woo Africa. Africa, with its vast untapped economic resources, is now the battleground for global powers, notably France, the US, and especially China. Each has established an African Forum, where African leaders are periodically invited to a discussion cocktail. They all purport to have a feeling and understanding for the African Problematique, to which they pledge support for resolution. So we have the US-Africa Summit; the Forum on Sino-African Cooperation (FOCAC); French-Africa Summit.

Not to be undone, the UK has its own version with Africa, signed into operation by Tony Blair, after the Gleneagles G8 Summit that failed to establish his dream International Finance Facility (IFF) of \$550 billion, by which he intended wiping off Africa's indebtedness.

The Russians, a few years ago, invited African leaders to a similar forum in Sochi, Russia, where President Putin offered a Russian plan for engagement with Africa. Turkey has shown strong interest in Africa and is instituting its own African platform. In all these, the three front liners are the French, the US, and the Chinese

The Francophonie, involving France and the French-speaking former colonies had always been the platform for Franco-African relations. But since 2006, the French opened the doors to non-French-speaking countries, in-

cluding Ghana. Each American President tries to meet with African leaders. the famous one being the one with President Obama. The Chinese kicked off with the 2005 FOCAC Summit in Beijing, which was attended by Thirty Five African Heads of State. The 8th ministerial conference of the Forum on Sino-African Cooperation (FOCAC) has just ended in Dakar, Senegal. Two days of summit discussed the question of vaccines and the fight against the pandemic of Covid-19. It also touched on especially the economy within the framework of the Chinese "Belt and Road Initiative", which Eritrea and Guinea-Bissau have just joined. It is clear that the deterioration of the security situation in Ethiopia and the US sanctions imposed on Eritrea must have probably accelerated the haste to join the FOCAC.

By joining the "Belt and Road" initiative, Eritrea intends to take advantage of Chinese funding and infrastructure projects. The same goes for Guinea-Bissau, where Chinese companies are already very active in forestry or deepsea fishing. The two countries joining the New Silk Roads on the eve of the Dakar summit was described as proof of expansion of Chinese diplomacy, a proof that is also expanding " the big family of Sino-African friendship ".

Since 2009, China has consistently surpassed the United States and Europe as Africa's largest trading partner. As China has emerged as the world's 21st-century factory, its appetite for raw materials has provided a solid bedrock for relations with African nations, and

it is likely to do so for many years to come. Its investment in Africa hit \$200 billion in 2019. Indeed, its "Belt and Road" Initiative has been attractive. In response, the United States is looking to reinvigorate its engagements in the region to counter China's influence where possible. For instance, the Build Back Better World program and the Blue Dot Network are focused on countering China's ever-trumpeted Belt and Road Initiative.

This is spiced with much propaganda about a'China Scare' - a smear campaign against China, Chinese goods, Chinese labour practice and morality, indeed Chinese behaviour. China has virtually conquered Africa in mining, transport infrastructure, construction, oil and gas, and manufacturing. And while China is not very much interested in political values, the US seems to be more interested in conquering Africa as part of their politico-security calculus. They are interested in bases and lily-pads, the latter of which they have thirty-nine in Africa. They are also interested in tuning Africa to Western political orientation.

Arguably, this myopic focus by the US on countering China's economic engagements has blinded the United States to its own unique strengths. The prime example of this is the African Growth and Opportunity Act (AGOA), due to expire in 2025, a non-reciprocal trade program that gives 39 eligible African countries duty-free access to U.S. markets. This has had catalytic effects on African industrialization, and many of the African manufacturers taking

advantage of AGOA are exporting lowtech goods, like textiles, that they could not hope to export to China, as China still has jobs to protect in those same industrial sectors. Incidentally, Chinese firms are re-locating to Africa in order to take advantage of AGOA.

It is interesting that Dakar has hosted within a period of two weeks two giant Summits - a US-Africa Forum and FOCAC. This is indicative of the importance Africa plays in the geo-political calculations of these nations.

It is clear that Africa needs to steer a course that would be advantageous towards her development. In 2009, for example, President Abdulai Wade of Senegal hosted a US-African Forum on the theme "The United States of Africa and forum on the role and place of Africa in global governance". He saw an opportunity to play the African card - African Unity. He called on Africa intellectuals to help turn such fora on the immediate needs of Africa. . "For far too long, African intellectuals do not come out to support African leaders on how to move the continent forward," he said. .For Wade then, Africa's integration should be a priority not what the Americans wanted. The forum led to the birth of two pro pan-African associations, namely the Provisional Pan African Scientific Council on the United States of Africa, a body made up of scholars and other stakeholders in African high education and research, and a Pan African Youth Alliance on the United States of Africa, comprising youths from 15 countries in Africa, the Caribbean and Europe.

START THE WEEK WITH CYNTHIA STACEY Safety first....but are t he strategies working?

REETINGS for the week, which finds me annoyed with myself looking at a newspaper cutting for the 13th October on my notice board put there so as not to forget it....which is of course exactly what I did!

.....the 13th International Day for Disaster Reduction wasn't an effective reminder if I can't recall it, but the message of public risk limitation is always relevent.

But let's check on the reality of various past disasters etc. August 2009 was a cheerless month, notorious for the appalling deaths of twelve schoolgirls, burnt to death in a boarding school inferno caused by a candle.

Such terrible events are often described as "accidents" but given the fact that the girls couldn't escape as they were locked in at night.... so what was accidental about that?

It was this aspect of the tragedy that made it even worse, rating a mention on the BBC World Service, as did the road death statistics at the time.

This shocking school fire caused speculation as to whether these increasingly frequent infernos would soon be viewed as almost inevitable as the road fatalaties.

Yet, despite this unforgetable school horror which should have resulted in new legislation and safety checks, seven years later in 2016 after a wave of more school fires in the country, some due to sabotage, then Home Affairs Minister Mwigulu Nchemba challenged the operaters to install alarms, saying "......with modern security systems, it will be easier to avoid such accidents".

This surprised the public, as they automatically expected places like schools, hospitals or seminaries to have basic alarm systems as a pre-requisite of being allowed agement Act No 9 of 1990. This

to function and particularly in the wake of that 2009 horror. Anyway, note the word 'accident' again, and just like the road

tragedies etc. it's a misnomer, as a dictionary definition says "..... anything unexpected....or "..... occurring by chance..."

Yet, the reality as we know, is that many of the vehicle smashes, and headon collision crashes, are often caused by reckless and unqualified drivers, employed by the profit-driven owners who hire such dangerous workers.

It is incomprehensible that a person driving a speeding passenger coach would then overtake a massive truck on a blind corner, regardless of the consequences as so often happens in Tanzania.

So, these factors certainly make the ongoing road deaths very expected indeed, as do so many other 'accident' prone sectors nationwide.

In 2015, the Tanzania Bus Owners Association suggested that buses plying long routes should have assistant drivers and fire alarms. Though it's surprising this wasn't done years ago when the nation's crater pocked roads were exhausting to drive on, requring full time concentration.

So it was good to know that about this time, on journeys of over eight hours, this sensible system was obligatory, and not dependant on the bus companies' whims. Otherwise, it was rather like airlines proudly saying they have fully qualified pilots......so the two driver system shouldn't have been an option..... it was a necessity!

Apart from mayhem on the roads, Tanzania had disasters aplenty, man-made and natural. So it was reasuring to remember that there was a Disaster Man-

came under the Prime Minister's Office where we hoped innovative strategies were being created to deal with the national calamities.

Anyone checking media articles and other sources for stories on road deaths, boats sinking etc. and going back twenty years, will usually find that these could have happened now, so similar are the circumstances behind the tragedies, and the promise from all four phase governments to reduce them.

Yet, today, the 13th of December 2021, fatalaties are still taking a terrible toll, with bodaboda deaths at many hundreds a year acros the country, caused by out-of-control riders, with police seemingly at a loss to halt them.

.....so it's a pity to read in a popular tourist blog..... "Tanzanialovely country ...lovely beaches.....and lovely people......but scary road safety record." This means that remedial action

is needed now.....and permanently on-going! It seems a long time ago since mass road building took off all over the country, the population rapidly increased, cars became readily available and thousands took to the highways, causing urban traffic jams as upcountry buses plied the roads, driven like 'racing cars "..... turning into "commuter killers".

.....And the policy planners presumably planned.....but what?

In 1997, in a move way ahead of its time, the then Minister for Communications and Transport William Kusila tried to improve safety standards. He especially wanted bus operators to pay compensation and medical costs for any passengers who'd entrusted themselves to their care, but were injured if a coach crashed due to operational problems, or driver incompetence.

"Entrusting yourself to their care"....that's what

you are doing every time you board a bus, plane or boat, and especially a three wheeler "bajaj".....or a motor bike 'boda boda".

But twenty one years later, is there workable legislation enforcing this rational proposal? If not, then the planners and the 'parliament people' are reneging on their basic duties...... as are our Kenya neighbours when it comes to some aspects of their public transport sector.

Years ago when I travelled on a 'matatu,' Kenya's version of Tanzania's 'dala dala, it was the nearest I'd come to 'dancing with death'. And the pleasure from that visit was almost cancelled out by the chaotic "matatu madness" as some of the witty locals named them.

With memories of this still in my mind, a newspaper heading of "Body builder of killer bus probed" caught my eye.

It seemed that the Kenyan Director of Public Prosecutions had ordered investigations into the builder of a bus, and the company that insured it, after the vehicle rolled over killing 58 people and injured 15.and plans were arranged to have a stronger enforcement of the so called Michuki rules.

These rules were introduced in 2003 by then Cabinet Minister the late John Mchuki and were to be implemented with "discipline and ruthlessness" as fellow ministers said.

.....so had they lapsed in the last 15 years, or been negligently applied...it's a mystery. But it shows the uselessness of legislation if not correctly implemented, or even not at all.

Well, time to go and with the safety subject in mind, I'll close by sayingstay fit and healthy till next week which means don't drive or board a bus, boat or train, swim in polluted rivers, purchase fake goods, etc., or involve youself in hazardous activities which pass for normal living in this part of the world.....actually, just build yourself a wall and stay at home.....but is your house in a safe area?

Cultural and people-to-people exchanges between China and Africa bear rich fruits

Chinese people and African people share the aspiration of making their homelands beautiful places where people can live in harmony with nature. As a result, they have worked together to pursue green, low-carbon, circular and sustainable development and protect the lush mountains and lucid waters as well as living beings.

Digital journalism has transformed thanks to the Covid-19 pandemic

I the past decade, smartphones and mobile technology have altered newsrooms, transforming news gathering, live broadcasting and content distribution. Trained on an iPhone 4s at the University of Sheffield in 2011, I was one of the first mobile journalists in the UK. Over the course of my career broadcasting live, from war zones in Iraq to tornados in the US, mobile technology has been the primary vehicle for capturing, curating and distributing packaged and live content.

Now the media world has again shifted due to the Covid-19 pandemic, with new challenges, different restrictions and innovative storytelling approaches emerging.

Research by journalists and academics from around the world confirms that technology and social trends are driving changes in how and where news is created and consumed. These changes have had an impact on the way journalists operate, enabling them to work alone or remotely. Reporter requirements have also altered, with sharp social media and digital skills expected as the norm.

Some of the smartphone journalistic trends that were gaining momentum before Covid were accelerated during the pandemic. This means greater autonomy for reporters, but also more pressure and responsibility, more ways to broadcast live and greater audience involvement in the news cycle.

Autonomy and freedom

Newsrooms have been downsizing in the UK and US over the past 15 years. In newspapers, for example, publishers have had to face the spiralling decline of print sales, forcing them to embrace new platforms and technologies. With fewer specific roles and multiskilling key to surviving in the industry, many reporters find themselves becoming videographers, editors and social media producers all rolled into one.

So much more is now being asked of broadcast and digital journalists, but with that has come greater freedom to source and create stories. Fewer editors, videographers, lighting and sound technicians mean journalists are more in control of the way they weave and distribute their news. Coupled with that is the removal of traditional PR "gatekeepers" and the rise of media-savvy figures who understand the importance of being accessible via social media and directly engaging with journalists.

Dutch media scholar Mark Deuze has cautioned against this shift from specialised roles, describing it as "leaving newsrooms full of empty chairs". Deuze believes that asking more of fewer journalists results in a loss of identity, teamwork, mentoring and guidance.

In the course of my research, I interviewed more than 40 journalists in India, Switzerland, the US and the UK between 2018 and 2021. All had the same concern: while this freedom was welcomed, reporters feared the lack of support would put pressure on their ability to gather stories and create content. **Reporter skills**

Post-pandemic, many journalists are expected to focus on mobile journalism and develop new skills in smartphone technologies and deal with new technical and editorial challenges. In some cases, this has put older journalists under increasing pressure to get to grips with new technologies.

With the transition to remote working, Zoom interviews and mobile and app editing, younger content creators excelled during the Covid crisis while older and less tech-savvy journalists were marginalised. The National Union of Journalists (NUJ) in the UK has supported these reporters in their efforts to bridge the gap through streaming online classes. Some national broadcasters, including ITV, have provided remote and office-based workshop training in production and editing skills for new staff.

The huge demand for constant content and live streaming has turned traditional TV reporters into walking cameras.

This may enhance coverage and encourage audience engagement on social media, but it also places added strain on young, inexperienced and overworked reporters who have entered the field during a time of uncertainty, resulting in health risks and safety concerns. It is paramount that cub reporters are properly inducted, mentored and guided to pro-

duce balanced and rounded news gathering.

Engaged audiences

Whether self-shooting at home, filming video interviews on the go or making novelty content with their pets - a huge hit for sports commentator Andrew Cotter - TV, radio, podcasting and social media audiences have themselves become more creative and involved during the pandemic.

roadcasters have capitalised on user-generated content throughout Covid - video interviews on phones, tablets and laptops became the norm, as once-passive news consumers became producers.

In sports broadcasting the absence of crowds allowed for fan-generated media to bridge the gap and satisfy supporters' appetite while club media became more dynamic, offering insights into players and coaches' personal lives. These trends were already evident in my research in 2018 and 2019, but during 2020 and 2021 the landscape shifted. Media educators and news organisations now must work more closely to align teaching and work experience to support graduates into the media industry's newsrooms - whether real or remote.

Trust in news media has been in decline since the Leveson

inquiry examined the ethics, culture and practices of the British press. But data on social media journalism and trust from the latest Reuters Digital Report demonstrates that the pandemic put journalists back into a place of respect in homes and communities - where it had previously been waning.

Newsrooms need to continue the good practices established during the pandemic, which saw editors and producers supporting and harnessing the skills of younger and more dynamic reporters to create balanced and ethical content.

It is crucial good practice feeds down into higher education, so that this accelerated digital transformation of news gathering, broadcasting and content creation maintains ethical standards and ensures the wellbeing of reporters if young people are to be encouraged into the industry.

Busy container ports herald China's robust foreign trade

HINA'S container shipsector registered

steadfast growth this year amid headwinds from the COVID-19 pandemic and container shortages, indicating the country's robust foreign trade and economic resilience.

Cargo throughput at China's ports totaled 12.87 billion tonnes in the first 10 months, up 7.8 percent year on year. During the period, container throughput reached 235 million twenty-foot equivalent units (TEUs), expanding by 8.4 percent from a year earlier.

As domestic ports have been bustling with containers, China's foreign trade in the first 11 months surged 22 percent year on year to 35.39 trillion yuan (about 5.56 trillion U.S. dollars), customs data showed.

The figure, already surpassing the 32.16-trillion-yuan total for all of 2020, marked a 24 percent increase from the pre-pandemic level in 2019.

Effective epidemic prevention and control measures adopted by the Chinese government contributed significantly to stabilizing industrial chains, boosting the overseas shipping orders of Chinese companies.

Praising the successful implementation of China's epidemicprevention strategy, chairman of China's state-owned shipping giant China COSCO Shipping Corporation Limited (COSCO Shipping) Wan Min said the company handled around 22.45 million TEUs of containers in the first 10 months, representing year-on-year growth of 5.7 percent.

"China's potent epidemic-containment efforts and fast resumption of work and production accelerated the growth of demand for cargo transportation, and brought about hope for global shipping companies," said Liu Wen, assistant general manager of the Shanghai branch of Singapore-based Pacific International Lines (PTE) Ltd.

were dispatched to operate in the Chinese market, Liu added.

When the container shortage hampered China's container shipping industry, government organs and businesses adopted multiple measures to boost supply and ensure the smooth flow of goods.

Under coordinated government actions led by the Ministry of Transport, shipping giant COSCO official data showed.

Most of the company's vessels Shipping transported 13,469 empty containers back to domestic ports in March, quenching the country's container thirst.

The supply of new containers has also been boosted by container manufacturers accelerating production. In September, the monthly container production capacity in China surged from 200,000 TEUs to a record high of 500,000 TEUs,

The constant introduction of favorable policies also propelled China's foreign trade growth. The business environment has been optimized with a slew of reform measures including facilitating cross-border trade and promoting trade and investment in pilot free trade zones.


This has not only boosted the confidence of market players, but at investment, administrative apalso helped to further strengthen provals and financial support for

China's opening up, said Bai Ming, a researcher with the Chinese Academy of International Trade and Economic Cooperation under the Ministry of Commerce.

ARIMO outlines feats earned 60 years after independence

AS Tanzania marks 60 years of independence, Ardhi Institute Morogoro (ARIMO) is proud of its graduates involving themselves in huge strategic projects in speeding up the country's industrial development to attain middle income status.

ARIMO principal, Huruma Lugalla says most of its graduates are employed in various public and private sectors to spur the country's industrialisation agenda for swift development.

In an interview, the institute's principal reveals that the graduates have been employed in ministries, public corporations, local government authorities and private urban and rural surveying and planning companies.

Other employers included construction companies for buildings, road infrastructures, airports, railways, ports, oil pipe lines, water dams and electricity and water distribution.

He says the institute has been at the fore front in implementing various government aims, policies and plans, adding that the institute provides training in two fields, geometrics and urban and regional planning.

According to him, originally, the institute was providing training on only one field - land surveying in certificate level spanning six months.

However, in 1979 the training was changed from six to one year, and added that further changes were made in 1983 when the land surveying field at certificate level was extended to two years.

The official notes that ARIMO received accreditation by the National Council of Technical Education (NACTE) in 2009, and later established new curricula for technicians in urban and rural planning beginning 2018/2019.

He also views the institute achievements by looking into the increase of students' enrolment and courses being taught and employment of its graduates as well as their contribution to the country's national development in various fields - social, economic, infrastructural and security.

The institute has increased the number of students admitted from 61 students in the 2008/2009 academic year to 554 students in the 2020/2021 academic year.

In the academic year 2021/2022, he reveals that the number of students enrolled is 501 where boys are 346 (69 per cent) and girls are 155 (31per cent).

In 2018, ARIMO introduced diploma course in urban and regional planning and so far, there are 33 diploma graduates.

According to Lugalla, the Morogoro-based institute has been involved in formalizing unplanned settlements in Morogoro, Iringa, Moshi municipalities; Arusha and Dar es Salaam cities; and the towns of Rombo, Same, Mangaka and Nanyumbu where a total of 30,188 plots have been surveyed. Another benefit is a citizen with a certificate to be able to get a loan using his/her certificate and thus help him/her to grow economically.

ARIMO recognizes the current needs of the labor market driven by changes in science and technology in day-to-day operations. In that context, the college has made several improvements to

the curriculum, teaching materials and equipment.

Lugalla says the institute's curriculum has been improved to meet current needs.

"This is evidenced by the changes made by the college, from the knowledge-based education and training system to the competence-based education and training system."

Forty years (1978 - 2018), ARIMO was teaching only one course-Land Surveying, but later in 2018, the institute rolled out a second course-urban and regional planning.

On ARIMO future plans, Lugalla says: "Based on the current trend of surveying each piece of land to facilitate industrial growth, ARIMO prepared a Five Year Strategic Plan (2017/2018 - 2021/2022) to improve infrastructure and human resources with the aim of keeping pace with growth of the country's socio-economic development."

The institute is in various stages of implementing the objectives contained in the strategic plan; where some of its goals are to increase student enrollment, increase the quality of graduates based on market demand and technology growth by conducting regular review of the teaching curricula.

ARIMO also intends to develop a 32-acre site located on Mount Kola in the outskirts of Morogoro Municipality with the aim of reducing infrastructure challenges.

The college also plans to train students and its staff at masters' level with the aim of building professional capacity.

The institute has three sets of state-of-the-art satellite surveying equipment (GNSS Receivers) used for teaching and conducting professional consulting work.

Noorjehan Niaz and Zakia Soman: Bonded to change the Trajectory of muslim women in India

NEW DELHI

ISCRIMINATED in society and concerned about the discrimination of women in their homes, the two women who co-founded the Bhartiya Muslim Mahila Andolan (BMMA) started the movement to further Muslim women's leadership and help them reclaim their rights.

In an exclusive interview with IPS, Dr Noorjehan Safia Niaz and Zakia Soman say they started the BMMA or the Indian Muslim Women's Movement to address communal tensions and prejudice within India and the inherent patriarchal prejudices faced within their homes and beyond.

Both Niaz and Soman say the 'communal' tensions, parlance for prejudice and violence against the Muslim minority in India, shaped their understandings of gender and identity. This led them to stand firmly on principles of gender justice and reforms - leading to the formation of BMMA. Since 2007 this movement has grown to more than 50,000 women.

Soman says she became conscious of her Muslim identity while interacting with women survivors of the Gujarat riots in 2002 in Ahmedabad. During these riots, many Muslim women were singled out and subjected to sexual violence.

"Gujarat riots were preceded by 9/11 (the attack on the World Trade Centre in New York in 2001) and the so-called war on terror. I felt a huge burden of my identity. My Muslim name invoked curiosity wherever I went," Soman says. She realised she was not alone, and many Muslim women shared her feelings.

"On the one hand, there was communalism and communal violence coupled with state neglect. On the other hand, we faced discrimination at home and within the family, wrongly in the name of religion."

Soman says she was in an "abusive relationship", and she and other Muslim women "decided to join hands and take charge of our situation."

The BMMA was born out of these sentiments to change a communal, patriarchal world.

For Niaz, the journey began in 1992, just after Babri Masjid, a mosque in Ayodhya, was demolished. What followed was communal violence across the country. Eighteen Muslims were murdered in Ayodhya following the demolition and houses and shops torched. Across the country, including in Mumbai, around 2,000 people were killed.

This communal violence and insecurity were the reasons Muslim women emerged as community leaders, she said.

"By this time, there was also a deeper understanding of all issues, especially of the core basic need for education, livelihood, health, security," Niaz says. "Additionally, we also had seen from close quarters the legal discrimination that Muslim women faced because of lack of a codified Muslim family law."

This became the core demand of the BMMA because "we knew that if we don't demand it, nobody else will. 'Our Struggle, Our Leadership' became our slogan. Muslim women must lead based on the values of the

Holy Quran and the Indian Constitution. (She must) demand her rights which emanate from her religion and her identity as a citizen of this country," Niaz says in an exclusive interview with IPS.

"Zakia approached me with the idea of a national platform, and that is how it all began. We worked for two years on the vision, mission, objectives, values and principles that would govern the movement, with other women leaders," she said.

After speaking to other Muslim

women leaders in various states and after two years of deliberations, in 2007, BMMA was formally launched. Since its formation, BMMA has been leading change from within on various fronts.

Soman and Niaz recall the various victories and associate these with the relentless struggle of the members who continued to fight for their rights despite little to no resources and often felt the community's ire for "daring to demand their rights'. One such victory was the Haji Ali

judgement which reversed a prohibition of women's entry into the sanctum sanctorum of the religious shrine, Dargah/Shrine. BMMA had filed the Public Interest Litigation or PIL to stop the discriminatory practice. It was a victory endorsed by the Supreme Court of India and paved the way for women from other communities to demand the end of discrimination at religious places.

Another significant achievement was the filing of a PIL against triple divorce, polygamy and halala. The BMMA was a significant group that had the practice of triple divorce, a method where Muslim men could divorce their wives by merely pronouncing the term 'Talaaq' or divorce, thrice to them, abolished in 2019.

Forming Darul-Uloom-e-Niswaan and training 20 women to become qazis or religious scholars is a first in India and considered by both as a major achievement.

"Some of the women whom we have trained have even performed Nikahs (religious weddings), challenging patriarchal norms," adds Niaz.

Despite the resource crunch and criticism, the leaders in the states

that has ruled over the community mindsets for decades. Neither is it easy to fight a discriminatory communal order in the face of state apathy," says Soman.

"I do not care about the opinions of vested interests. I am satisfied when I look at how dozens of the riot survivor women have turned out to be fiery activists in the last two decades," Soman says. BMMA has created leaders across the country.

"These women were voiceless in the cacophony of conservative men of religion. (The leaders) have now shown the whole world that gender justice is intrinsic to Islam. They have changed the perception about their religion in the eyes of ordinary Indians," she says.

The path chosen was never easy. They were asked why the State should be involved in matters of shariah. They were insulted and called stooges of the right-rightwing Hindutva. This criticism came from both religious groups and the so-called secular-liberal feminists

With the additional challenge of COVID-19, Niaz is confident that the path chosen is the right one.

"Amid the heightened Islamo-

and members continue to work with the most marginalised women, addressing issues ranging from applying scholarship schemes for their children and training them in livelihood skills to empowering them with information on Constitutional and Quranic rights

Most of the leaders run centres from their homes, many in poor ghettos to reach those in most need.

The movement and its leaders have been criticised for addressing women's rights when Islamophobia and communal violence are on the rise.

Change and reform are slow and equire continuous efforts and suport from the larger community and progressive forces, according to boman.

"It is not easy to take on the patriarchal religious establishment

phobia, lynchings and open calls for annihilating the community by the state and state-backed Hindutva forces, how can BMMA continue to speak for family law reforms in favour of Muslim women," they were asked

"Because if we don't continue to speak and highlight the issue, nobody else will."

The two women and the leaders from the Indian states, bound by shared objectives of empowering and uplifting Muslim women, find strength in each other. Niaz reflects on this relationship.

"We bond with each other within BMMA. I would like to believe we are soul-mates born with a common divinely sanctioned purpose. Just being with each other, talking to each other gives us strength."

A third of borrowers now on CRBs blacklist

NAIROBI

A third of Kenyan loan accounts are negatively listed as defaulted with the country's credit reference bureaus (CRBs) in an economy where Covidinduced job cuts and business closures have pushed thousands of people into a debt trap.

NTRODUCTION of new disciplines in railways and marine engineering by National Institute of Transport has been welcomed by Deputy Minister for Communication, Transport and Works, Mwita Waitara.

Waitara said in Dar es Salaam on Friday during the 37th graduation ceremony that the introduction of new courses on naval architecture and marine engineering as well as courses on railway transport is an important milestone in the country's development. Waitara stated that the introduced courses will help foster rapid economic growth.

He noted that the three courses will help reduce the burden on the government in sending students

accounts negatively listed stood at 4.6 million out of the 15 million accounts, reflecting a jump from 3.2 million accounts in April last year. The bulk of the new listings is for mobile digital loans despite the government having frozen the blacklisting of defaulted loans below Sh1,000 from April to December last year.

The suspension was aimed at cushioning Kenyans from the economic fallout that came with Covid-19. The defaulted loan accounts were listed this year. Workers and businesses defaulted on bank loans worth Sh93 billion in the year to February following the imposition of stringent measures to contain the spread of the coronavirus.

Data from the Central Bank of Kenya (CBK) shows that non-performing loans (NPLs) rose from Sh351 billion in February 2020 to Sh444 billion at the end of February this year – the sharpest oneyear increase in recent history.

But this excludes defaults from unregulated digital mobile lenders who were also barred from forwarding the names of loan defaulters to CRBs. It followed public outcry over widespread misuse of the credit information sharing (CIS) mechanism by the unregulated digital mobile lenders. Their freeze from CRBs signals that blacklisted loan accounts could have been higher.

"The number of Kenyans currently negatively listed are 4.6 million against the total records of 15 million," said Joseph Nyaga, the CEO TransUnion, one of Kenya's three CRBs. He said the majority of the negative listings were for loans tapped through mobile phones. The rising number of blacklisted loan accounts will jeopardise the chances of millions of Kenyans being able to borrow more to grow their businesses or for projects.

But the CBK has offered the blacklisted borrowers breathing space after it froze the sharing of information of those who have defaulted on loans of below Sh5 million up to end of September next year.

The CRB listing relief is part of a stimulus package to cushion distressed

cuts and unpaid leave for retained staff as profitable firms moved into losses. This saw workers who had tapped mortgages and unsecured loans for purchase of goods such as furniture and cars and expenses like school fees default. Unsecured loans are given on the strength of one's salary.

Firms that had borrowed based on the forecast of cash flows have also been struggling to repay their bank loans. Nearly 730,000 jobs were lost last year when Kenya imposed coronavirus-induced lockdowns that led to layoffs and pay cuts, but the country's economy is presently recovering. Growth slid to negative 0.3 percent last year from 5.0 percent in 2019.

Recovery has started, but there are fears the pace could be curbed by a shortage of Covid-19 vaccines and new waves of infections. Growth is expected to be 6.1 percent this year and 5.6 percent in 2022, according to the CBK. The non-performing loans dropped from Sh444.2 billion in February to Sh435 billion in September.

The CBK has warned that commercial banks could restart rationing loans following the suspension of blacklisting of defaulters with Sh5 million loans and below. The regulator says banks may shun lending to individuals and small traders at a scale last witnessed between September 2016 and November 2019 when Kenya capped interest rates.

Bankers say a lack of credit reference could contribute to soaring costs of loans and stall lending to businesses due to incomplete borrowers' information. The suspension is the second since Kenya reported the first case of Covid-19 last year.

The CBK ordered a six-month suspension of CRB listings in April last year as part of the measures to cushion borrowers hit by the pandemic. The moratorium lapsed in October, allowing financial institutions to start sending names of defaulters to the CRBs. Lenders, however, offered defaulters 90 days from October 1 to start repaying their loans or get blacklisted.

Edtech propels Southern Africa PC market to record high

The upsurge in the adoption of education technologies (edtech) in Southern Africa lifted the personal computing device (PCD) market in the third quarter (Q3) of 2021, as demand reached record levels. In the quarter, the PCD market recorded a year-on-year growth of 44.4%.

The latest quarterly PCD tracker from International Data Corporation (IDC) says shipments in the market reached over 920 000 in Q3 2021, the highest volume recorded in almost five years. Southern African learners, like many across the world, had to resort to remote learning to keep up with the academic year, which IDC says prompted high demand for devices.

"A huge backlog of orders and rising adoption of education technologies to support online learning were the key commercial growth drivers, while retail sales spurred consumer growth. Demand remained high across the region but education deal in South Africa,'

vendors were unable to fully meet it, so they prioritised the supply of devices to commercial end-users," says Grace Munyi, a research analyst at IDC.

Munyi says despite the continued global stock supply challenges caused by a shortage of components and chipsets, the Southern Africa PCD market recorded a strong performance during the quarter.


In the PC category, IDC says, HP remains the dominant player in the Southern Africa market, accounting for 27.9% of total PC shipments in the quarter, up from 24.8% a year earlier. During the same period, the IDC report says, local brand Proline moved up to second place with 18.8% share, a significant increase on the 1.3% share it gained in the third quarter the previous year.

"This strong performance by Proline was driven by the massive notebook volumes it delivered for phase two of the National Student Financial Aid Scheme (NSFAS)

says IDC. The laptops were part of COVID-19 relief efforts by government to assist students during the lockdown period.

The NSFAS contract was expected to benefit 430 000 students in 26 universities and 300 000 students in 50 TVET colleges across the country. A total of 730 000 laptops were set to be procured. Lenovo slipped from second to third in Q3 2021, with Dell falling to fourth place despite recording a slight year-on-year (YOY) increase in its share.

In the tablet category, IDC says, Samsung continued to dominate the market in the quarter. Apple moved up from third to second, while Lenovo went the other way after seeing its share decline by 4.1 percentage points. Workstations recorded the market's highest YOY growth, with shipments up 103.2% in Q3 2021. Notebook shipments increased 89.1% over the same period, while desktop shipments were up 65.2%.

Global farmers facing fertiliser sticker shock

ROME

Key crops, from Brazilian corn to Malaysian durians, are at risk after tight supplies and blistering prices of fertiliser have caused farmers to scrimp on vital crop nutrients, adding to global food security and inflation fears.

Fertiliser costs soared this year amid rising demand and lower supply as record natural gas and coal prices triggered output cuts in the energy-intensive fertiliser sector. Urea surged more than 200% this year while diammonium phosphate prices have nearly doubled.

With global food prices at their highest in more than a decade, rising fertiliser costs will only add to pressures on food affordability, especially in import-reliant economies, while stretched budgets leave little room for government subsidies, said Frederic Neumann, HSBC's co-head of Asian economics research.

"At a time when COVID-19 already decimated the lives and livelihoods of untold millions, start the new year very low on

soaring food costs are hitting the poor especially hard," he said. "This raises the risk that higher fertiliser costs will not only hit farmers but will also be passed on to consumers via higher food prices."

Worse before it gets better

With the United Nations Food and Agriculture Organization's (FAO) food price index at its highest since 2011 - when high food prices helped foment the "Arab Spring" uprisings the world's farmers are already under strain to increase food supply. But analysts say fertiliser supply

tightness will worsen early next year. European, North American and North Asian farmers all need to step up purchases ahead of spring planting, while key producers China have curbed exports to ensure domestic supplies.

"Most stockpiles of urea are now secured, meaning global producers will be 'sold out' until January 1," said US-based Josh Linville, director of fertiliser at StoneX Group Inc. "Producers

unsold inventories and they will be met by sizeable global demand in Q1 as US, Canada, Brazil, Europe, Asia all step forward to purchase." In response, farmers across the world are either delaying purchases or reducing fertiliser use to save money.

India and Egypt - both major farm economies - increased government subsidies in November, with India's fertiliser ministry boosting supplies to districts with low stocks to ensure availability for winter-planted crops. No crop spard

So far, high crop prices have cushioned the blow for many growers, and some can switch from nitrogen-hungry wheat and corn to soybeans next season. But in 2022, few crops or farmers will be spared, sources say.

In Germany, farmers hit by price increases are likely to reduce fertiliser use, which could lower harvest volumes "depending on the scale that this takes place," said Bernhard Kruesken, secretary-general of German farming association DBV. "Crop types which achieved higher producer prices in past months will be in consideration for sowing," Kruesken added.

Brazil, the world's top soybean grower and third-largest corn producer, feeds 10% of the global population. The country has warned of a fertiliser shortage next year that is predicted to slow soy, corn and cotton farm expansions.

"Soy partially dodged it because a lot of inputs had been (already) purchased, but the second corn crop of the cycle is going to run head-on into that rise in fertiliser costs," said Andre Pessoa, partner at Brazilian agribusiness consultancy Agroconsult. "For the 2022/23 cycle, I would say we are going to have some problems. I've

told farmers the problem isn't even price anymore. Now it's guaranteeing availability." Even in North America, home to some of the world's wealthiest farmers, growers have delayed purchases they usually make ahead of spring plantings, hoping prices drop.

Smallholders suffer

Although weather conditions, disease, pests and water supply also are crucial in determining how crops develop, fertilisers are among the most potent production factors that farmers control.

But many growers, and especially the millions of smallholders who produce a third of the world's food, will have little choice but to reduce fertiliser usage in 2022. In Southeast Asia, which produces most of the world's palm oil, growers are bracing for higher output costs with industry players already seeing disruptions in fertiliser procurements and lower imports.

Support for UK PM Johnson sinking amid scandals - poll

LONDON

SUPPORT for British Prime Minister Boris Johnson and his ruling Conservative Party has plummeted after a series of scandals, with a majority of voters thinking he should now resign, according to a poll published on Saturday.

Johnson has found himself facing criticism on a number of fronts in recent weeks from the funding of the refurbishment of his Downing Street flat to a claim he intervened to ensure pets were evacuated from Kabul during the chaotic Western withdrawal in August.

The most damaging has been reports that a party was held at Downing Street during a 2020 Christmas lockdown when such festivities were banned, with a video emerging this week which

showed staff laughing and joking about The Opinium poll for the Observer newspaper found support for the Con-

servatives, who have held solid leads in polls since winning a landslide victory in a 2019 election, had fallen four points to 32 percent, while backing for the opposition Labour Party rose to 41 percent, its biggest lead since 2014.

Johnson's personal ratings were also at their lowest point since the election, with his approval rating at -35 percent, down 14 points from two weeks ago. The poll also showed that 57 percent of voters thought he should resign, up from 48 percent two weeks ago.

There has been growing talk of dissatisfaction with Johnson's leadership among Conservative lawmakers according to political commentators, and it is of Political Polling at Opinium.

"The findings of our latest poll are certainly dramatic, with a devastating fall in both support for the Conservatives and approval for the prime minister," said Adam Drummond, Head

Assange one step closer to extradition to United States

LONDON

WIKILEAKS founder Julian Assange on Friday moved a step closer to facing criminal charges in the United States for one of the biggest ever leaks of classified information after Washington won an appeal over his extradition in an English court.



US authorities accuse Australian-born Assange, 50, of 18 counts relating to WikiLeaks' release of vast troves of confidential US military records and diplomatic cables which they said had put lives in danger.

Assange's supporters cast him as an anti-establishment hero who has been persecuted by the United States for exposing US wrongdoing and double-dealing across the world from Afghanistan and Iraq to Washington.

At the Royal Courts of Justice in London, the United States won an appeal against a ruling by a London District Judge that Assange should not be extradited because he was likely to commit suicide in a US prison.

Judge Timothy Holroyde said he was satisfied with a package of assurances given by the United States about the conditions of Assange's detention, including a pledge not to hold him in a so-called "ADX" maximum security prison in Colorado and that he could be transferred to Australia to serve his sentence if convicted.

Further hurdles remain before Assange could be sent to the United States after an odyssey which has taken him from teenage hacker in Melbourne to years holed up in the Ecuadorian embassy in London and then incarcerated in a maximum-security prison.

The legal wrangling is almost certain to go to the Supreme Court, the United Kingdom's final court of appeal. Assange's fiancée, Stella Moris, said his legal team would

appeal the decision.

"How can it be fair, how can it be right, how can it be possible, to extradite Julian to the very country which plotted to kill him?" she said. "We will appeal this decision at the earliest possible moment."

Supporters of Assange gathered outside of the court after the ruling, chanting "free Julian Assange" and "no extradition". They tied hundreds of yellow ribbons to the court's gates and held up placards saying "journalism is not a crime".

Judge Holroyde said the case must now be remitted to Westminster Magistrates' Court with the direction judges send it to the British government to decide whether or not Assange should be extradited.

Helicopter attack

Assange, who denies any wrongdoing, started out as a teenage hacker with the nickname Mendax - a classical Latin word for "liar" - but a few decades later would expose some of the United States's darkest secrets.

WikiLeaks came to prominence when it published a US military video in 2010 showing a 2007 attack by Apache helicopters in Baghdad that killed a dozen people, including two Reuters news staff.

It then released thousands of secret classified files and diplomatic cables that laid bare often highly critical US

More than 100 feared dead as tornadoes rip through US states

MAYFIELD, Ky -

AT least 100 people were feared dead in Kentucky after a swarm of tornadoes tore a 200-mile path through the US Midwest and South, demolishing homes, levelling businesses and setting off a scramble to find survivors beneath the rubble, officials said Saturday.

The powerful twisters, which weather forecasters say are unusual in cooler months, destroyed a candle factory and the fire and police stations in a small town in Kentucky, ripped through a nursing home in neighboring Missouri, and killed at least six workers at an Amazon warehouse in Illinois.

Kentucky Governor Andy Beshear said the collection of tornadoes was the most destructive in the state's history. He said about 40 workers had formed in northeast Arkansas.

First United Methodist Church partially collapsed. Mayfield Fire Chief Jeremy

Creason, whose own station was destroyed, said the candle factory was diminished to a "pile of bent metal and steel and machinery" and that responders had to at times "crawl over casualties to get to live victims.'

Paige Tingle said she drove four hours to the site in the hope of finding her 52-yearold mother, Jill Monroe, who was working at the factory and was last heard from at 9:30 pm.

"We don't know how to feel, we are just trying to find her,"

she said. "It's a disaster here." The genesis of the tornado outbreak was a series of overnight thunderstorms, including a super cell storm that been rescued at the candle That storm moved from Arkansas and Missouri and into Tennessee and Kentucky. Unusually high temperatures and humidity created the environment for such an extreme weather event at this time of year, said Victor Gensini, a professor in geographic and atmospheric sciences at Northern Illinois University. "This is an historic, if not generational event," Gensini said. Saying the disaster was likely one of the largest tornado outbreaks in US history, President Joe Biden on Saturday thing.' approved an emergency declaration for Kentucky. He told reporters he would be asking the Environmental Protection Agency to examine what role climate change may have played in fueling the storms, and he raised questions about the tornado warnvin Day. ing systems. Beshear said 189 National Guard personnel have been deployed to assist with the recovery. The rescue efforts will focus in large part on Mayfield, home to some 10,000 people in the southwestern corner of the state where it converges with Illinois, Missouri and Arkansas.

Video and photos posted on social media showed brick buildings in downtown Mayfield flattened, with parked cars nearly buried under debris. The steeple on the historic Graves County courthouse was toppled and the nearby

One person was killed and five seriously injured when a tornado tore through a nursing home with 90 beds in Monette, Arkansas, a small community near the border with Missouri, according to Craighead County Judge Mar-

"We were very blessed that more people weren't killed or injured in that. It could have been a whole lot worse," Day told Reuters.

A few miles away in Leach-

ville. Arkansas, a tornado destroyed a Dollar General Store, killing one person, and laid waste to much of the city's downtown, said Lt Chuck Brown of the Mississippi County Sheriff's Office in Arkansas.

"It really sounded like a train roaring through town."

In Illinois, at least six workers were confirmed killed after an Amazon.com Inc warehouse collapsed in the town of Edwardsville, when the winds ripped off the roof and reduced a wall longer than a football field to rubble.

Amazon truck driver Emily Epperson, 23, said she was anxiously waiting for information on the whereabouts of her workmate Austin McEwan late Saturday afternoon to relay to his girlfriend and parents.

"We're so worried because we believe that, you know, he would have been found by now," she told Reuters.

In Tennessee, the severe weather killed at least three people, said Dean Flener, spokesperson for the state's Emergency Management Agency. And two people, including a young child, were killed in their homes in Missouri, Governor Mike Parson said in a statement.

The National Weather Service's Storm Prediction Center said it received 36 reports of tornadoes touching down in Illinois, Kentucky, Tennessee, Missouri, Arkansas, and Mississippi.

The weather forecast was broadly clear for Saturday night, but temperatures were expected to drop and thousands of residents lack power and water after the storm. As of Saturday afternoon, nearly 99.000 customers in Kentucky and more than 71,000 in Tennessee were without power, according to PowerOutage. US, a website tracking power outages.

THE first shipments of the Sputnik Light Covid vaccines have been delivered to Venezuela, Russian Ambassador to the republic Sergey Melik-Bagdasarov told TASS Saturday.

"The second plane carrying the Sputnik Light has just landed in Caracas," he said. Earlier, Venezuelan media reported the arrival of the first batch of the Russian vaccine.

Venezuela approved the use of the Sputnik Light earlier in May. The vaccine will be used for revaccination of previously vaccinated patients.

"The shipments of the Russian medication are being carried in unprecedented timeframe: the ordered 7 million doses of the vaccine ordered by Caracas will be delivered in full in the upcoming days," the Russian embassy said in its press release.

According to Venezuelan authorities, over 80% of people have already been vaccinated. Since the beginning of the pandemic, 437,000 people have contracted the disease, with 5,229 deaths. Agencies

The State Council of China recently Beijing's sub-center to embrace high-quality development

issued a guideline on supporting the high-quality development of the Beijing Municipal Administrative Center (Beijing MC), or Beijing's sub-center, in Tongzhou district of Beijing, specifying development goals of the administrative center during the country's 14th Five-Year Plan period (2021-2025) and for the period before 2035.

The guideline put forward a package of targeted and workable policies and measures in a bid to support the high-quality development of the Beijing MC, said Cong Liang, deputy head of the National Development and Reform Commission of China, at a press conference held by the State Council Information Office on Dec. 1.

By 2025, Beijing's sub-center will

basically have the functions of a green city, forest city, sponge city, smart city, cultural city and livable city, according the document.

By then, municipal-level Party organizations and government organs as well as administrative institutions in Beijing will be relocated to the subcenter. Meanwhile, the Beijing MC will see notable results in undertaking the non-capital functions of the city and housing new residents, and basically establish a quality system for development

A modern sub-center of Beijing will be basically built by 2035, when its role in performing the non-capital functions of the city and helping with population transfer will be fully demonstrated, said the document.

Besides, the sub-center's quality system for development will become mature, and important results will be achieved in the integrated high-quality development of the sub-center and its surrounding areas, according to the guideline.

To drive the sub-center's high-quality development through innovation, the guideline proposed enhancing its scientific and technological innovation through measures including supporting the implementation of suitable policies of the new round of pilot reforms of core areas of the Zhongguancun National Independent Innovation Demonstration Zone at the sub-center.

It also called on encouraging law firms and accounting firms familiar with international laws and norms to set up offices in the sub-center to facilitate the innovative development of financial technologies in the Beijing MC.

The sub-center should be infused greater development momentum and vitality and given more autonomy in development. According to the guideline, the sub-center should promote the rational conversion of the types of land uses in different industries and try to increase the supply of mixed-use land for industries.

It should pilot policies on highlevel trade and investment facilitation and carry out pilot programs for international talent service and management reforms and international vocational qualification recognition in key areas.

The sub-center and Xiong'an New Area in north China's Hebei province serve as two new "wings" of Beijing and are assigned the important task of relieving the non-capital functions of the city.

In January 2019, the first batch of 165 units of 35 departments of Beijing municipal government moved their offices to the sub-center officially. Based on the guideline, Beijing

has listed 66 specific tasks to support the high-quality development of its sub-center, and made lists of projects and policies related to these tasks, noted Cui Shuqiang, a member of the Standing Committee of the Communist Party of China (CPC) Beijing Municipal Committee and executive vice mayor of the municipal government of Beijing, at the press conference.

Beijing plans to relocate the second batch of administrative institutions to the sub-center by 2022 or the year after that. It means approximately 30,000 more people will move to the sub-center, which is believed to ease the population pressure on the core areas of Beijing's central urban areas, Cui said.

Palestinians vote in local elections in West Bank

THE Palestinians on Saturday held the municipal elections in the West Bank despite the opposition of the Islamic Resistance Movement (Hamas), which has been ruling the Gaza Strip since 2007.

The local vote came after Palestinian President Mahmoud Abbas cancelled the parliamentary and presidential elections in the Palestinian territories earlier this year.

Hana Nasser, chairman of the Palestinian Central Elections Commission (PCEC), told a news briefing that more than 405,000 Palestinians have the right to cast ballots for representatives in 154 village councils in the West Bank.

The polling stations were opened to voters in the 154 West Bank villages on Saturday morning, and closed at 7 pm local time (1700 GMT). Municipal votes in the major West Bank cities had been postponed.

Nasser called on the Palestinians, who have the right to vote, to participate in the municipal elections, saying all necessary arrangements had been made to facilitate the arrival of the voters to the polling stations.

"Around 1,600 local and international observers were watching the polling and will do the counting right after the ballots are closed in the evening," Nasser told reporters. "The results of the votes counting will be immediately declared."

In September, the Palestinian government of Prime Minister Mohammed Ishtaye decided to divide the municipal elections into two phases, with the first on Dec. 11 and the second in March 2022.

The first phase of the municipal vote was held in the West Bank only, excluding the Hamas-ruled Gaza. The elections won't be held in East Jerusalem either because of Israel's rejection.

Hamas and the less-influential Palestinian Islamic Jihad said in two separate statements that they reject the exclusion of the Gaza Strip from the Palestinian municipal elections.

The two Islamic groups called on President Abbas to abide by the previous understandings to hold the general elections in all the Palestinian territories, including East Jerusalem.

THE notion of democracy and its true principles are far beyond its Western definition, an Ethiopian political analyst has said.

Speaking to Xinhua recently, Henok Tilahun, an independent political analyst, questioned the U.S. administration's attempt to divide the global community on the pretext of democracy through its so-called "summit for democracy."

"This summit is ... ridiculous ... how come the U.S.A. got the moral authority and moral position to invite and reject or classify nations based on their democratic, human rights efficiency? Because, both domestically and internationally, democracy is all about rule of law," Henok said.

The United States is hosting the socalled "summit for democracy" this month, in which the guests are selected according to America's definition and standards of democracy.

Describing the Western definition of democracy as "a very narrow way" of understanding true democracy, the analyst stressed that democracy is not only about human rights as the United States and other Western countries often tout.

"Western-defined democracy is based on civil and political rights, while Eastern-defined democracy is based on social and economic equality. So, it is not a universal meaning ... What the U.S.A. uses or other Western countries use of the definition of democracy is based on their interest and their understanding," he said.

He further underscored the need to realize equality of opportunities in the United States, which he labeled as the

basis for the fulfillment of true democracy.

Notion of true democracy far beyond Western definition - analyst

"If you go to the U.S., a lot of people suffer from inequality of income, inequality of wealth, inequality of opportunity. So, without the equality of opportunity, how come nations talk about democracy, and human rights?" Henok said.

The analyst stressed that recent attempts by the U.S. administration in bringing together like-minded countries based on its standard of democracy will only affect genuine discussion on the issue.

"The U.S. gathered and grouped nations with the mentality of cold war based on their definition, not based on universal understanding of democracy," he said. Concerning recent negative hu-

man rights records in the United States, he said "since 2012, how many human rights violations have happened in the U.S.?

How many American institutions systematically marginalize and violate human rights and democracy? It is a very clear and obvious sign of how the U.S. violates human rights."

The analyst pointed out that China's whole-process peoplecentered democracy ensures that all sectors of its society always enjoy equal democratic rights.

"Talking only about human rights or elections is not enough to meet the satisfaction of the people. So, the Chinese version of democracy is, I think, the right

version of democracy," he noted. Henok advised developing countries, Africa in particular, to take China's version of democracy as the true form of democracy. "When you think or focus on economic equality, social equality, it is all about people centered. The Chinese version of democracy is, I think, a very crucial understanding for other Africans and developing countries because the government strives to keep the safety and the convenience of people in the nation," he said.

Granting professional titles to self-taught experts gives impetus to rural vitalisation in China

NOT long ago, 196 folk artisans and new-type professional farmers in Luoyang city, central China's Henan province, were granted junior professional titles including assistant agronomist and junior artist by the municipal human resources and social security bureau of Luoyang.

The bureau carried out an activity to offer on-site professional title certification services to grassroots talents, allowing them to apply for the certification and receive their title certificates right in the fields.

The certification was an unexpected surprise, said these self-taught experts, who added that obtaining professional titles

failed to attract talents.

In the fight against poverty, a number of industries with distinctive rural characteristics have enjoyed rapid growth and become important magnets for talents. For example, Queshan county in Henan province has offered great support for people who returned to their hometowns to start their own businesses and encouraged people to establish violin workshops, developing violin making industry from scratch.

More than 60 luthiers have returned to their hometowns in Queshan county one after another, exerting a strong influence on local residents and the

course, it is not that every project is allowed [in Greece], for example, we are building a nuclear station in Akkuyu in Turkey, but, unfortunately, nuclear energy is forbidden in Greece," he explained.

Putin's press secretary noted that Russia holds the decisive role of Turkish President Recep Tayyip Erdogan in high esteem. "He is the type of man that is being appreciated by President Putin because when President Putin says something he means it and he does it. This is important."

As for the differences between Russia and Turkey on a number of issues, the Kremlin official said that "it's impossible not to have them," pointing out that in Syria, the two countries used to have quite tense moments where their interests were colliding in several spheres.

"But every time the two presidents found it possible to come together, to sit for five, six, seven hours and not going in front of the press without reaching a solution. Every time they managed to do it," the spokesman noted.

In response to a question as to whom Russia would support in case of an armed incident in the Aegean Sea, the Kremlin official said that "the last thing we would like to see in the Aegean or in the Mediterranean Sea is us being closer tween the ships of two countries," stressing that it is desirable to avoid any repetition of similar incidents in the future.

According to him, Russia would like to support the resolution of issues between Greece and Turkey in the Aegean Sea.

"We would like to support a solution," he said, noting that Russia would like to see both sides proceed taking the reality into account "because every solution is a two-way street, with the reciprocal wish to reach the solution."

In response to a question whether Greece may expect Russia's full support against Turkey's actions in the Aegean and Mediterranean Seas, the Kremlin official said that Turkey insisted that the provisions of the UN Convention on the Law of the Sea and Greece's demands to establish the internationally recognized width of the continental shelf of inhabited islands in the Aegean Sea as well as the scale of the exclusive economic zone would definitely harm Turkey's national interests and deprive it of its right to use the natural resources of the region.

"So, we call for both sides to be calm and to be reasonable in solving the problem," Putin's press secretary concluded. makes them more confident about settling in rural areas.

With the steady implementation of China's rural vitalization strategy, the country's rural talent teams have been constantly expanded and strengthened. However, the development of rural areas is still hindered by problems including the difficulty in attracting, cultivating, using, and retaining talents.

Though with rich practical experience and skills, many rural specialists have been constrained from achieving better career development by their academic background.

In an effort to address the problem, many provinces in the country have actively explored the possibility of granting professional titles to grassroots talents in rural areas for the purpose of breaking the bottleneck in their development and motivating farmers to better master techniques for agricultural production and management.

Offering professional title certification to rural talents is believed to be helpful for retaining outstanding talents and creating

a virtuous cycle for gathering talents in the countryside.

Such certification requires special arrangements for evaluation, specially designed professional titles, specially formulated evaluation standards, specially organized certification activities, as well as special policies on the benefits for holders of professional titles.

Northeast China's Jilin province tailored nine professional titles for talents in rural areas, including agricultural economist, agrotechnician, and agronomist; east China's Shandong province has piloted a professional title certification system for new-type professional farmers since 2018, which is now officially implemented across the province; in east China's Zhejiang province, new-type farmers can apply for senior professional title, which is equivalent to professorship at a university, just like personnel who work in agriculture-related public institutions and scientific research institutes.

Professional title certification has brought a sense of honor in work to talents in rural ar-

eas. Some farmers who have obtained professional title certificate can enjoy certain government subsidies, preferential policies on technical services, project cooperation, and bank loans, training in national conditions as well as special treatment including vacation and recuperation.

The implementation of a series of policies and measures has exerted considerable influence on rural areas, motivating more college graduates, ex-servicemen, people who returned to their hometowns in rural areas to start their own businesses, and individuals who play a leading role in increasing farmers' income to devote themselves to rural vitalization.

Talents hold the key to rural vitalization. To further attract and retain talents, rural areas need to consolidate the foundation of industries so that talents can put their abilities to good use.

Weak industrial foundation limits the development of talents, which is one of the reasons why some rural areas in China development of the violin making industry. As a result, more and more local farmers started to make violins as a sideline.

So far, there are more than 150 violin making-related enterprises in Queshan county. With an annual output of more than 400,000 violins, the industry has provided jobs for more than 2,600 local people.

While consolidating industrial foundation, rural areas also need to improve platforms and services for talents and promote the two-way flow of production factors between urban and rural areas.

Efforts should be made to set up one-stop service windows, rural industrial parks for innovation and start-up firms, incubation and training bases, among other platforms, provide highquality services for entrepreneurs and help them formulate plans for business development and solve problems in financing, technology, and employment, so as to provide a solid guarantee of success for rural talents who try to start their own business.

Saudi crown prince ends fruitful Gulf tour to consolidate GCC unity

SAUDI Arabia's Crown Prince Mohammed bin Salman ended on Saturday a successful Gulf tour of Oman, the United Arab Emirates (UAE), Qatar, Bahrain and Kuwait, aiming to boost cooperation in the region to face common challenges.

The visit was intended to bridge differences among members of the Gulf Cooperation Council (GCC), strengthen relations between Saudi Arabia and its neighbors, and coordinate their policies on Iran and other issues in preparation for the GCC summit to be hosted by the kingdom on Dec. 14, Saudi officials said ahead of the trip.

The Saudi crown prince has achieved fruitful results during this round of visits. On the political level, all five leaders of the visited countries described their relations with Saudi Arabia as solid.

The joint statement issued by Saudi Arabia and the UAE vowed to strengthen their coordination to ensure security and stability in the region. The Saudi crown prince was also awarded the Zayed Medal, the UAE's highest honor.

Kuwait's Emir Sheikh Nawaf Al-Ahmad Al-Jaber Al-Sabah awarded Mohammed bin Salman the Order of Kuwait. Oatar's Emir Sheikh Tamim bin Hamad Al Thani said the crown prince's visit would strengthen his country's ties with Saudi Arabia, which is particularly important for the current regional situation. Analysts noted that the Qatari emir was invited to attend the 41st GCC summit hosted by Saudi Arabia in January, leading to the normalization of their ties which were cut off in 2017. During the Saudi crown prince's visit, the two sides spoke highly of the bilateral relations, indicating that the impact of the 2017 crisis has been basically eliminated and they will return to cooperation in various fields.

On the economic level, Saudi Arabia and Oman jointly announced the opening of the first land crossing between the two countries, a 725-km road which they said "will facilitate the smooth movement of our citizens and the smooth integration of our supply chains."

Companies from the two countries signed 13 memoran-

dums of understanding for cooperation worth 30 billion U.S. dollars, while Saudi Arabia's Public Investment Fund announced it would invest 5 billion U.S. dollars in Oman.

During the Saudi crown prince's visit to Bahrain, the two countries announced a feasibility study on the establishment of a Saudi-Bahrain Holding Company which aims at establishing joint investment projects.

In the energy sector, Saudi Arabia and Bahrain reviewed cooperation between Bahrain's Oil and Gas Holding

Company and Saudi Aramco, with a focus on oil and gas, circular economy, and hydrogen production technology.

Meanwhile, Kuwait hailed its close cooperation with Saudi Arabia within the framework of OPEC Plus to safeguard stability of the global oil market, while highlighting the importance of continuing this cooperation and the need for all participating countries to adhere to the OPEC Plus agreement.

Analysts believe that Crown Prince Mohammed's visit to the five Gulf states reflects Saudi Arabia's policy direction of attaching more importance to building its ties with its neighbors.

"Neighboring countries are crucial to the revitalization of Saudi Arabia. We have to work with our neighbors to ensure their prosperity," Mohammed said during his visit to Bahrain. Li Shijun, a Chinese visiting scholar at the Saudi Center for Research & Intercommunication Knowledge, said that Mohammed's Gulf tour is a trip of "seeking friendship in proximity and seeking future in GCC countries." **Xinhua**

Olympic leaders criticize FIFA as activists target meeting

OLYMPIC leaders aimed their ire at FIFA's president over his push for staging more World Cups, during an IOC-hosted meeting that Tibetan students tried to interrupt on Saturday in a protest against the Beijing Winter Games.

FIFA president Gianni Infantino's plan to stage men's and women's World Cups every two years instead of four was previously criticized by the IOC which put it on the agenda for the annual "Olympic Summit" debate of influential sports bodies.

"The attendees voiced serious concerns over proposals from FIFA for a biennial World Cup and the impact on the worldwide sport event calendar," the International Olympic Committee said in a statement.

Before the heated words inside the online meeting that Infantino attended, several activists from the Students for a Free Tibet group tried to get into the IOC headquarters.

"We have engaged multiple times with peaceful protestors and explained our position," the IOC said in a statement, "but we will not engage with violent protestors who used force to enter the IOC building and injured a security guard badly by doing so."

Local police were called to help block the activists who continued to sit at the front doors and hold up banners including "Boycott Genocide Games" next to the iconic Olympic rings symbol outside the building.

Pro-Tibet groups are part of a wider alliance of activists fueling opposition to the Feb. 4-20 Beijing Olympics over China's human rights record, including treatment of its Muslim-minority Uyghur people, democratic rights in Hong Kong and military harassment of Taiwan.

In recent weeks, the IOC and its president Thomas Bach have been more widely criticized for seeming too close to China over the uncertain safety of tennis player Peng Shuai after she made sexual assault allegations against a former senior government official.

Bach chaired the meeting Saturday to discuss "subjects of significance for the future of the Olympic movement." It came two days after Bach said the IOC had no direct consultation with FIFA since the biennial World Cup proposal was formally announced three months ago.

Under questioning from several delegates, Infantino explained "ongoing discussions in FIFA were broader in scope than a biennial World Cup, and that what had been presented so far was only the preliminary results, which are still under discussion," according to the IOC statement.

FIFA did not immediately respond to a request for comment.

The IOC has previously said doubling the number of World Cups would affect the calendar of "tennis, cycling, golf, gymnastics, swimming, athletics, Formula One and many others."

It would also potentially put a men's 2028 World Cup, likely earning FIFA billions of dollars in commercial income, almost directly against the Los Angeles Olympics which open July 21, 2028.

Former Barcelona youth coach investigated for sexual abuse

BARCELONA, Spain

BARCELONA coach Xavi Hernández is "surprised and stunned" the former director of Barcelona's youth teams has been accused of sexually abusing dozens of former pupils at a public school where he also worked.

Xavi spoke on Saturday shortly after authorities in northeastern Spain said they were opening an investigation after newspaper ARA reported that over 60 of his former students accuse Albert Benaiges of having sexually abused them while he was a physical education teacher at a public school in Barcelona. ARA said Benaiges has denied any wrongdoing.

It seems none of the former players for Barcelona have joined the accusations.

The 71-year-old Benaiges was a key member of Barcelona's youth training academy from 1991-2011, coinciding with a generation of the club's best players, including Andrés Iniesta and Xavi.

After stints abroad with foreign clubs, Benaiges returned to Barcelona last year following the return of Joan Laporta to its presidency. He resigned last week for personal reasons, the club said.

"I don't have any information that there have been any type of these episodes, although that does not mean that they did not happen," Xavi said at a routine pre-match news conference. "He was my coach and I never had any suspicions. I am very surprised and stunned, I didn't expect it.

"This is a very delicate, very complicated issue," Xavi added. "I have spoken with the coaching staff because we love Albert Benaiges very much. It has surprised us a lot. We always had an excellent relationship, and he left a very good legacy. It is the justice system that will have to decide."
