

Samia joins others, applauds Ruto for victory in election

PRESIDENT Samia Suluhu Hassan is among the African leaders who yesterday sent congratulatory messages to Kenyan Presidentelect William Ruto (pictured) for winning the

Samia's message came a day after the result was announced late Monday by Independent Electoral and Boundaries Commission (IEBC) chairman Wafula Chebukati, while losing presidential candidate Raila Odinga and four IEBC commissioners rejected the results

In his announcement on Monday, the IEBC chieftain stated that the President-elect along with Deputy President-elect Rigathi Gachagua won 7,176,141 votes, representing 50.59 percent of valid votes cast; beating the rival candidacy of Raila Odinga and running mate Martha Karua who polled 6,942,930 votes (48 percent).

In her twitter handle, President Samia said: "I congratulate the people of Kenya on their peaceful general election and the subsequent announcement of Dr @WilliamsRuto as President-elect. We look forward to continuing working together with our brothers and sisters in Kenya to strengthen our historical close ties. Tuko pamoja."

Uganda's President Yoweri Museveni also congratulated Ruto and affirmed Kampala's commitment to continue working with Nairobi.

"Further to my telephone call last night upon your victory, I wish to reassure you of Uganda's commitment to continue partnering with Kenya in advancing regional and continental agenda through the East African Community, African Union and other multilateral platforms.

"Our bilateral cooperation will tremendous achievements and I look forward to working more closely with you. God bless Kenya. God bless East Africa.'

Ten die, scores injured after truck hits bus, lorry, saloon

TEN people have died and an undetermined number injured after a truck carrying a consignment of gold concentrates rammed into three vehicles after its brakes failed at Inyala on the outskirts of Mbeya city.

The three vehicles were a passenger bus

cargo truck and a saloon car, police said.

Regional Police Commander Ulrich Matei told reporters that the accident occurred early yesterday as the cargo truck T.387 DFJ hit the vehicles due to failing brakes, pushing them out of the road as it crashed into a ravine.

Many of the dead were in the bus, with

MOUNT Kilimanjaro climbers will now communicate with ease following the installation of 4G broadband internet services on Mt Kilimanjaro, Africa's highest peak.

Nape Nnauye, the Information, Communication and Information Technology minister, made this affirmation here yesterday when launching the service on the slopes of the mountain.

Using his verified Twitter handle, he said the move will enable tourists who climb the mountain to communicate globally with no obvious hurdles, expecting that the facility will serve 800 to 1000 tourists per day.

He asked the Tanzania Telecommunication Co. Ltd (TTCL) and the Tanzania National Parks (TANAPA) to liaise in ensuring that the services are reliably available.

"Strong communication facilities at mountain top will improve business and promote tourism," he said, noting that communication challenges must be addressed in other tourist spots. This will improve safety and increase the number of tourists, he affirmed.

The 5,895m mountain top is going to be served by the communication boost centre located 3720 meters above sea level, ensuring climbers of the mountain access to internet and phoning services

"Several times, I have heard tourists and other visitors complaining that they take a long time registering due to low internet speed; this should come to an end," he said.

The service will now allow tourists to take digital photos, videos and other communication services and send them anywhere in the world, enhancing the destination's visibility, he stated, highlighting that the government is pursuing plans to ensure that 80percent of the population is linked to digital communication services by the end of 2025.

He asked the RC to ensure the infrastructure installed is protected, while TTCL director general Peter Ulanga said efforts to take the services to Uhuru Peak were at an advanced stage. The


Minister lays accent on work supervision, tax compliance

REGIONAL administration officials in Ruvuma and elsewhere need to make sure they conduct strict supervision of work performance of public officials in order to enhance economic targets, in the wake of better opportunities arising from higher numbers of tourism and foreign investments.

Jenista Mhagama, Minister of State in the President's Office (Public Service Management and Good Governance) made this appeal here yesterday when addressing Ruvuma regional administration officials.

The minister was officiating at an event to voice support of efforts intended to facilitate



increased national income through 'The Royal Tour' documentary, a film initiated by a United States broadcaster where President Samia Suluhu Hassan featured extensively.

She said senior officials and other public servants are supposed to work diligently with a patriotic spirit and upright ethical conduct, as making Tanzania a reliable investment destination lends support to President Samia's efforts in advertising the country's tourist attractions and investment opportunities.

As for revenue collection in the region, the minister who is also a legislator from the region (Peramiho constituency) reminded the regional officials to use information technology tools to expand the revenue collection, while mobilizing traders to voluntarily tax compliance so as to fund development projects.

Similarly in focus in the minister's address was the need to acutely supervise the subsidized Fertiliser distribution procedure, to ensure that this initiative by President Samia to increase agricultural production is put to good use.

Independent observer group accepts Kenya's presidential poll results

A group of independent observers has said that the just concluded Kenya's presidential election corresponds to their own tally.

The observation group by name of ELOG said they had dispatched over 5,000 observers across 290 constituencies in 47 counties in the whole of Kenya.

"ELOG notes that the results transmission system worked much better than expected with over 99% of scan images of the 34a and the with more than 7.1 million, the 34b posted on the IEBC web portal. However, we are extremely concerned about the chaos that broke out at the national tallying centre at Bomas as well as the split within the IEBC leading Premier Raila Odinga can see him to some commissioners quitting the tallying process and issuing their own statements prior to the announcement of the presidential results," said Anne Ireri, ELOG Chairperson.

ELOG further reiterated that it is up to the Supreme Court of Kenya to validate the declaration made by the chairperson of the Independent Electoral and Boundary Commission Wafula Chebukati.

Four of the seven electoral commissioners of Kenya's presidential election told journalists Monday they could not support the "opaque nature" of the final phase of the voteverification process.

They spoke just before the declaration of Deputy President William Ruto as the winner of the election over five-time contender Raila Odinga. "We are here not at Bomas of Kenya, where the result is going to be announced, because of the opaque nature of how this phase has been handled," the vice chair Juliana Cherera said.

"We cannot take ownership of the result that is going to be announced," she added, without giving details.

Ruto received 50.49% of the votes chairman said, while Odinga received 48.85% with more than 6.9 million in last Tuesday's peaceful election.

KENYAN opposition figure Raila Odinga said he would challenge the results of the close presidential election with "all legal options" after Deputy President William Ruto was declared the winner.

"What we saw yesterday is a travesty and a blatant disregard of the Constitution," Raila Odinga said.

"We will pursue all legal and constitutional options available to us. We will do so in view of the many flaws in the elections," he said, in his first address since the results were announced the day before.

The announcement brings further uncertainty to a country where last Tuesday's poll was widely regarded as the most peaceful.

The construction of the Wami Bridge costs about 75bn/- from the government funds and is implemented by Power Construction Corporation for a period of 48 months.

Uluguru spice programme improves lives of over 1500 farmers in region

THE implementation of the Uluguru Spice Programme (USP) in Morogoro Region has transformed lives of over 1500 farmers in various villages with essential new skills and knowledge on sustainable spice cultivation as well as marketing strategies.

Implemented by the Sustainable Agriculture of Tanzania (SAT) with support from the Austrian Development Agency (ADA), the fiveyear USP focuses on working with farmers in the catchment area of Ruvu river in the Uluguru mountains.

In an interview with this paper recently Eliminata Marmetus, USP field facilitator said the project has greatly helped to install organic spice farming knowledge and skills to thousands of farmers, something which has helped improve individual income, villages and the country at large.

"We commenced the project in 2017 and we have reached a good number of farmers who are currently reaping big from their activities due to the skills and knowledge given by SAT experts," she said. She said the farmers are also benefiting well from the project due to the launch of a new factory to collect and process the species.

Eliminata said apart from receiving skills and tools support in farm preparation, cultivation and harvesting, the farmers are also assured of a reliable market of the produce to the presence of the factory which is located at Mtamba village in Kisemu ward, Morogoro District in the region. The factory was constructed by the SAT's Holistic Group Limited.

She noted that SAT Holistic Group Limited is a social business, coowned by small-scale farmers in Tanzania and affiliated with the NGO "Sustainable Agriculture Tanzania (SAT)".The company's business directly connects farmers to lucrative local and international organic markets, promoting sustainable farming practices and reducing poverty.

According to her, farmers in the slopes of the Uluguru Mountains who have been engaging in spice farming country.

with many of them started to earn more income and as they are assured of a reliable market of their produce.

SAT's communication manager Joseph Masonda said the organisation has been implementing various projects to support farmers with adequate knowledge and skills especially in organic farming so as to promote mass production and consumption of non-chemical products in the country.

He named some of the projects as the Farmers and Pastoralists Collaboration (FPC) which aims to instill organic farming knowledge and skills among the groups thus promoting natural and conservation farming which eventually helped to improve income and reduce farmers and pastoralists conflicts.

"In this, SAT train farmers on conservation farming as well as smart livestock keeping, thousands of farmers and herders from Morogoro and other parts of the country have benefited from various organised trainings and changed their mindsets, we have projects that touches all groups and bringing positive impact in the communities and nation at large," he said.

He added; "We also have a new project dubbed Organic Value Chain Project (OVCP) which aims to support and empower farmers and small-scale entrepreneurs to increase production of organic foodstuffs as well as improve and certify the products."

Some farmers who visited SAT's pavilion at the ended Farmers exhibitions in Morogoro expressed their appreciation to SAT and all its partners for bringing the projects to the villages as they have greatly helped them improve their income with their lives changing for better.

Dodoma inaugurates m-mama programme

DODOMA region has launched m-mama, a programme that uses mobile technology to connect pregnant women to emergency transport.

At the core of m-mama is a costeffective emergency transport system to significantly reduce maternal mortality in areas with limited or inefficient ambulance services.

The system uses a network of local taxi drivers to act as 'taxi ambulances' in areas where ambulances are rarely available:

When the patient makes a free call to a 24/7 dispatch centre, a call handler assesses the patient's condition using the m-mama app, which indicates whether the patient needs transferring to a health facility.

If healthcare is required, the nearest taxi ambulance driver is identified on the m-mama app and receives a request to take the woman to the closest health facility.

On safe arrival, the driver is paid instantly for the journey via M-Pesa (Vodacom's mobile money transfer system).

The development comes at a time when records show that the region recorded 63 maternal deaths between January and August, 2022. It has managed to reduce the deaths to 74/100,000 in 2021, down from 102/100,000 in 2020.

The m-mama, use mobile technology to connect pregnant women to care when they need it the most, and working to reduce rates of maternal mortality, identified as the number one health challenge by the United Nations' Sustainable Development Goals.

The mobile service has developed by Vodacom Tanzania Foundation and Vodafone Foundation that provides emergency transport for pregnant and postpartum women.

Speaking during the launch, Vodafone Foundation's m-mama Director, Dolorosa Duncan said the program was co-created by Vodacom

Tanzania Foundation, Vodafone Foundation and the government and was successfully piloted in six districts including Shinyanga and Sengerema.

She said it was initially planned for 15 regions but funds have been increased and it will now be rolled in 26 regions in the country.

"We are grateful for the cooperation shown by regional officials on this launch and expect successful implementation within the given time frame."

Meanwhile, the Dodoma Regional Commissioner, Rosemary Senyamule, thank Vodafone for the collaboration aimed saving lives of women in the region and the nation at large.

She said the effort is in line with the government's effort to reduce maternal death as was directed by President Samia Suluhu Hassan.

The RC expressed optimism that from the reported success in Shinyanga, the programme will help bring the needed changes in Dodoma region.

"Urgent transport for expectant mothers and newborns is an important service that helps save lives and this initiation will help save money lives too," she said.

Regional Administrative Secretary, Dr Fatma Mganga noted that the programme launched in Dodoma in April, 2022 is real stakeholders' initiatives to improve maternal

"A lot of roads and bridges are at risk of totally being destructed, trucks are passing in these roads with huge cargo, we are worrying that our roads can

Farmers in Mbeya praise govt for fertiliser subsidy

FARMERS in Mbeya Region have showered praise on the government for initiating fertiliser subsidy claiming that subsidy will assist them in increasing the production of crops.

Speaking to this paper early this week, some of the farmers said they have started registering themselves with the system.

Fabian Mwaluke, one of the farmers said the system will assist in bringing down fertiliser prices for them, different from how it was in the previous season.

He said as for now they have been told that they will now be buying the farm input at 70,000 per bag as opposed to 130,000/- during the previous season. "During the last season we failed to take care of our crops well due to the anyone buying a bag of the fertiliser high fertiliser prices, some opted to grow crops that do not need much

fertiliser," he added.

Another farmer, Julius Sanga, said the government has greatly assisted them through the reduction of farming costs, adding that in the last season there weren't any crops that generated

He said in addition to high fertiliser prices, crop prices were very low, and many farmers were barely able to recoup their farming costs.

Launching the fertiliser subsidy initiative in Mbeya during the Nanenane Agricultural Exhibition early this month, Agriculture Minister Hussein Bashe said all farmers should register themselves to benefit from the subsidy.

He said all fertilisers to be subsidized by the government will have special identification and added that information will be transmitted to the government.

He added: "For the business community, the census is a basic source for demographic reports and commodity markets growth in all world countries. "All businesses need statistics in regard to the population as a basic means in making investment decisions." The PM showered praise on the media for their "great participation in mobilising the public on the importance of the census exercise."

He said according to NBS, 98 percent of Tanzanians recognise census exercise this year.

Earlier, welcoming the prime minister to address the meeting, the Minister of State in the Prime Minister's Office (Policy, Parliament and Coordination), George Simbachawene said so far the census preparations are 95 per cent complete. "The remaining five per cent should not be disregarded, because we will make efforts to attain the required 100 per cent in the remaining time," he said.





THE government is set to establish a single window of empowerment to allow all people who want to start a business to get all the necessary services under one roof to improve ways of doing business.

Kigahe noted that in making things easy for small businesses, "we have reduced more than 30 tax barriers out of 60, and that gives them chances to conduct business in countries such as Kenya, Rwanda, Burundi, Malawi, Zambia and DRC Congo."

He further noted that more doors to reduce obstacles will be opened as one of the major challenges facing African their goal.

Dar residents decry food price increase

RESIDENTS of Kawe ward, Kinondoni District in Dar es Salaam are complaining on the increasing prices of key products such as food, something which affects their progress.

In separate interviews in different market outlets in the city over the weekend, they called upon the government to intervene and take immediate measures which will help lessen the prices.

They said if the situation persists, then they will not be able to execute important development initiatives.

Asha Juma, a consumer and resident of Ukwamani in Dar es Salaam said: "Every day the prices of products are increasing, this situation costs us a lot, look at the rice, sugar and wheat, you can't touch them now, life has been so difficult to me and my family."

She said prices of key products such as rice, flour, edible oil, sugar, fish and other farm produce have sharply risen, which affect people as many of them can't afford them.

"We were purchasing rice at 1200-1500, but now we get it at 2500-2900, flour is also high, edible oil price has increased by 4000/- per one litre, the price of fish has also doubled," he

Noshady Kweka, a shopkeeper at Ukwamani said they are also buying the products at high price which forces them to increase the price to at least get a profit.

"We are not choosing to raise the price on our own, no, the price has changed in the places where we go to buy at wholesale prices," he said.

Another trader, Msukuma said the increase of price in products has also affected flow of customers in the shops and the sales have greatly decreased.

"Previously, we were experiencing customers queuing to get services at my shop, but the situation has now changed as I serve very few customers in a day, sales have decreased," he said.

Mama Hassan, a fishmonger and resident of Ukwamani said she has been forced to stop her business due to the rising prices of fish and edible oil, something which has chased away customers.

"I am no longer doing the business, an amount of fish which I was selling for a day, is currently sold for three days, prices are high and customers are not coming anymore," she said.

The traders are calling upon the government to take measures to help address the situation as low income people who are the majority are the asserted. ones suffering from the challenge.

End of water woes facing Tanga residents in sight

WATER woes are set to end in Tanga Region following the implementation of a \$500million-Exim funded water supply project in four towns-Korogwe, Muheza, Pangani and Handeni.

The water will be drawn from Pangani River to be implemented by Handeni Trunk Main (HTM) Water Supply and Sanitation Authority.

HTM Water Supply and Sanitation Authority Managing Director, Yohana Mgaza said the project is currently not doing well due to various factors including over population and wornout of infrastructures.

He said the project which was designed in 1974 through National Water Utilities aims to supply water in two districts of Korogwe and Handeni and was projected to make 180,000 people access clean and safe water as of 1974.

"Until recently the project was not doing well because the infrastructure had not undergone major rehabilitation since it was constructed about the past 48 years and also the population density that depended on water from that source increased," he said.

'The expectation was to serve about 180,000 people but according to the 2012 Housing and Population census, there are about 400,000 people for about 78 villages of Handeni and 5 villages of Korogwe depending on HTM," he said.

He further explained that the infrastructures currently produce and supply about 5.5 million litres of water per day while the requirement is about 14 million litres per day.

"Implementation of this 28 towns water project will boost the HTM to produce about 52,000,000 litres of water per day that will end water woes facing residents of Handeni towns and neighbouring villages," stated Mgaza.

Tanzania and Indian companies on June 6, this year signed contracts for implementation of water projects worth \$500 million with an aim of improving access to clean and safe water in 28 towns in Tanzania Mainland and Zanzibar by 8 percent.

The agreements were signed between the government and JW INFRA Ltd, AFCONS Infrastructures Ltd, Larsen and Toubro, Megha Engineering and Infrastructures Ltd, China Civil Engineering Construction Corporation and Jandu Plumbers Ltd.

WHO, Macron, African leaders appeal for closer cooperation in production of various vaccines

THE European Union's (EU) and African leaders, including Emmanuel Macron and Paul Kagame, on Tuesday, called for "technology sharing" and "innovation support" to produce more vaccines locally in the world to combat pandemics.

The French, Rwandan, South African President Cyril Ramaphosa and Senegalese President Macky Sall, German Chancellor Olaf Scholz and World Health Organisation (WHO) Director-General Tedros Adhanom Ghebreyesus raised these concerns in an article published in Le

"It is high time to intensify collaboration, promote local production and build confidence in locally produced products, in order to be better prepared for the next crisis,"

Africa is the world's least vaccinated continent against Covid-19, with less than 20% of its 1.2 billion people receiving two doses of the vaccine. Africa's first messenger RNA vaccine factory opened in

June in Rwanda, with the aim of producing treatments for Covid-19 and other diseases for millions of people across the continent by early 2024. South Africa also opened a Covid vaccine factory in

January. Senegal is also set to become a regional hub for

vaccine manufacturing. "It is difficult to build a vaccine production unit, but it is even more difficult to ensure its sustainability," said the signatories of the forum.

They call for more training of personnel, more regulation, in Africa and elsewhere in the world, and more investment

"in pandemic preparedness". mRNA technology can also be "adapted to fight other diseases, such as HIV infection, tuberculosis, malaria and leishmaniasis", they note.

Africa ought to have more dynamic food systems for national economies

hungry people in the world could increase by more than 100 million this year, according to WFP estimates.

"Without massive improvements in the food supply chain, many fragile nations are set to become increasingly vulnerable to financial volatility and climate shocks," WFP said.

For particularly fragile countries, a slide towards famine is a real risk, it warned, noting that in many countries, the socio-economic effects of the pandemic – particularly loss of earnings and remittances - are heightening existing threats linked to conflict and climate change.

The UN food agency said it has unparalleled experience in buying and distributing food as it yearly increases the amount of food it procures locally from smallholder farmers, providing training in post-harvest storage and in how to access markets.

It said the need for concerted action to improve agricultural production while enhancing global supply chains and ending food waste is reflected in this year's World Food Day theme: "Grow, Nourish, Sustain. Together".

Food security is a measure of the availability of food and individuals' ability to access it. Affordability is only factor. There is evidence of food security being a concern many thousands of years ago, with central authorities in ancient China and ancient Egypt being known to release food from storage in times of famine. At the 1974 World Food Conference the term "food security" was defined with an emphasis on supply.

Food security, they said, is the "availability at all times of adequate, nourishing, diverse, balanced and moderate world food supplies of basic foodstuffs to sustain a steady expansion of food consumption and to offset fluctuations in production and

Later definitions added demand and access issues to the definition. The final report of the 1996 World Food Summit states that food security "exists when

HE number of acutely all people, at all times, have physical and economic access to sufficient, safe and nutritious food to meet their dietary needs and food preferences for an active and healthy life".

Household food security exists when all members, at all times, have access to enough food for an active, healthy life. Individuals who are food secure do not live in hunger or fear of starvation.

In the years 2011-2013, an estimated 842 million people were suffering from chronic hunger. The Food and Agriculture Organisation of the United Nations, or FAO, identified the four pillars of food security as availability, access, utilization, and stability. The United Nations (UN) recognized the Right to Food in the Declaration of Human Rights in 1948, and has since said that it is vital for the enjoyment of all other rights.

The 1996 World Summit on Food Security declared that "food should not be used as an instrument for political and economic pressure.

The UN World Food Programme (WFP) has called for joint efforts from all stakeholders to improve food security in Eastern Africa.

WFP Eastern Africa regional director, Michael Dunford, made the call over the weekend in a statement issued to mark the World Food Day.

He said that the region is home to four percent of the global population but has 20 percent of the total number of acutely food insecure people in the

"There is a huge potential to improve food security across the region but this will require all stakeholders working closely together and adopting new ways of working if we are to build a future without hunger in Eastern Africa," Dunford said

WFP, which last week won the Nobel Peace Prize for its efforts to fight hunger also called for global action to improve the systems that produce and distribute the food we eat, so that they can better withstand shocks including the COVID-19 pandemic that can spark alarming surges in the level of hunger in the world.



Ten efforts to decolonise aid in Africa

HANGING practices around funding, leadership, narrative and identity. Since the Black Lives Matter movement re-emerged in 2020, there has been a lot of talk about decolonising aid but not as much clarity about what it means in practice.

While ideological differences in the debate remain entrenched, many initiatives are underway to further the decolonisation agenda in practical

Here are 10 of them.

decolonisation initiatives missed, please add them to this open database for others to read about.

Organisations like Mama Cash, the Decolonising Wealth Project, Thousand Currents, Global Giving, Give Directly, the African Visionary Fund, and the Trust-Based Philanthropy Project offer more participatory ways of channelling funding to grassroots organisations. They aim to rebalance the power between funder and grantee, invest in quality relationships, and place greater trust in those doing the work. Similarly, in the humanitarian sector, the Survivor and Community-Led Crisis Response approach - developed by the Local to Global Protection Initiative and used in East Jerusalem, Haiti, and Ukraine, among other places - seeks to give small cash grants to community groups to design and implement their own projects.

IPAS, a global reproductive health and rights organisation, has developed a roadmap to transform itself into a networked global organisation with authority, power, and leadership dispersed and shared across a network of offices rather than centralised in the United States. For its part, CARE has shifted from being a group of 10 members from the Global North to a confederation of 21 organisations, including eight in the Global South. The Start Network is shifting its membership from a centralised model to a series of national and regional hubs.

Outlined by USAID Administrator Samatha Power in November 2021, this new policy seeks to: attract people from more diverse backgrounds, including through a new Chief Diversity Officer; be more focused on the voices and needs of the most marginalised; and listen more to its partners in the countries where it works. It aims to provide 25 percent of its financial assistance to local partners within four years, and to spend at least half of its money on programmes where local communities co-lead the project, set priorities, drive implementation,

philanthropic foundation described "USAID taking up the localisation banner" as one of the biggest recent successes of the localisation agenda, though observers are already wondering what will happen to the commitment when Power moves on.

DA Consulting, run by Somali-

American aid worker Degan Ali, has created a framework to help international NGOs understand how to "get out of the core business of service delivery" and transition towards a solidarity role that advocates for changes to the foundational problems If you're working on interesting in geopolitics that make aid necessary in the first place. The framework guides NGOs through changes to their resources, finances, programming, and executive leadership. Ali is now considering creating a similar framework for donors. Meanwhile, the Start Network has launched its own "anti-racist and decolonial framework". Developed by Filipino aid worker Arbie Baguios, the founder of Aid Reimagined, it involves managing risk differently, providing interpretation at events, and defining success from the affected community's point of view.

> A framework developed to help the Start Network address racism and colonialism in its work.

> Still in the works, this index - being built by a voluntary collective of Black, Indigenous, and people of colour claims to be the first accountability tool for racial equity within the global development sector. After inviting aid organisations to submit their data to gauge how they're doing, it seeks to be a barometer of how well international NGOs are measuring up against 11 indicators of racial equality, based on a mapping of community definitions around the world. Its first iteration aims to be live by mid-2023 (Listen to one of its co-founders on this episode of the Rethinking Humanitarianism podcast).

The Good Humanitarian Donorship grouping of 42 key government and multilateral donors discussed decolonising aid at their highlevel meeting in December 2021 - the first time the topic was raised at a humanitarian donor forum. International Development The Innovation Alliance, which brings together eight bilateral agencies and three foundations, also discussed the topic at a December meeting. Many foundations and governments have been having discussions internally too. The Belgian Ministry of Foreign Affairs launched a project to map the colonial aspects present within the institutional structures, processes, and cultural behaviours of Belgian development practice. Finland and Denmark have N. Hilton Foundation is funding the

for the NGOs they fund to demonstrate how their projects build local capacities and how affected people are included in planning and implementation (others, like Norway, have long had this requirement). The UK's Foreign Commonwealth and Development Office's Rapid Response Facility now is now instructs grantees to include overhead costs for their local partners. In their budgets, recognizing that they too need to finance the running costs of their organisations.

Many international NGOs are humanitarian food chain, and more withdrawing from 18 countries, in part and more thought is going into how the role of "intermediaries" should evolve. For CARE Australia, it's about being a broker rather than a doer. For Oxfam GB, it's about shifting towards a global social justice network (as their CEO outlined in this podcast). The rethink has even led to a new acronym: RINGO (Re-Imagining the INGO). Aid agencies are also considering their composition and staffing. Médecins Sans Frontières led a consultation process during which thousands of staff discussed "The MSF We Want To Be"; while the International Committee of the Red Cross held town halls in different languages for staff to express their experiences of racism.

Spearheaded by Degan Ali, CEO of Adeso, and Mary Ana McGlasson, director of the Centre for Humanitarian Leadership, this informal grouping brings together the CEOs of several international NGOs for frank conversations about their organisations' role in maintaining neocolonial structures in the global aid system and strategies towards decolonisation. They will soon be announcing a pledge that looks at three specific areas: visuals (ie. poverty porn), language (ie. disempowering vocabulary), and partnership. Oxfam, one member of the collective, recently published its strategy for shifting power, outlining how its commitment to decolonise will be integrated into planning processes and shape: how they recruit and support diverse talent; how they tell stories; the way they fund Southern partners; and how they hold themselves accountable.

In 2020, the British anti-poverty charity Comic Relief announced it would stop raising funds by sending celebrities to African countries: "African people don't want us to tell their stories for them," its co-founder Lenny Henry said. In 2021, Africa No Filter published a handbook for the development community with eight tips for more ethical storytelling about the continent. The Conrad

or evaluate its impact. The CEO of a recently strengthened requirements development of a toolkit on improving storytelling practices in the social impact and philanthropic sectors, which is being produced by M&C Saatchi World Services. And as above, many NGOs are changing the way they tell stories about the work they do.

After watching "international organisations capitalising on a crisis" when Tropical Cyclone Pam hit Vanuatu in 2015, the Australian Red Cross shrank its international humanitarian operations significantly, laying off 100 of its 140 internationally focused staff to make room for local rethinking their roles in the leadership. In 2020, Oxfam began to "shift power closest to those we exist to serve". Ignacio Packer, the executive director of the NGO consortium ICVA, has announced he'll be stepping down in 2023 to make way for new leadership from the Global South. In an interview with the Rethinking Humanitarianism podcast, UN Under-Secretary-General for Humanitarian Affairs Martin Griffiths also expressed hope he would be the last Brit in the job. The composition of "Humanitarian Country Teams", the main inter-agency coordination bodies in crises, has also shifted in recent years to include much more local representation.

> While some of these efforts have been underway for years, the COVID-19 pandemic and the war in Ukraine have both created opportunities for acceleration. COVID was arguably not as transformative as expected, but the humanitarian response in Ukraine has shown some signs of a more "decolonised" approach. The Disasters Emergency Committee, a fundraising network for UK charities, has allowed recipients of its funds to work with Ukrainian partners without doing their own due diligence (a practice known as "due diligence passporting"); and a collection of international charities has partnered with the UK Humanitarian Innovation Hub and Ukrainian organisations to set up a localisation learning and innovation hub in Ukraine. In what would be a precedent-setting move, the UN's emergency aid coordination body, OCHA, is also considering giving funding from its pooled fund directly to volunteer organisations. We'll be watching to see if these new ways of working last beyond this particular crisis

most countries, money laundering and terrorist financing raise significant issues with regard to prevention, detection and prosecution.

crime is Sophisticated techniques used to launder money and finance terrorism add to the complexity of these issues. Such sophisticated techniques may involve different types of financial institutions. Money laundering is, however, a fundamentally simple concept. It is the process by which proceeds from a criminal activity are disguised to conceal their true origin. Basically, money laundering involves the proceeds of criminally derived property rather than the property

OUSED in a detention center in southern England, Aladeen says he risked his life to travel thousands of miles from his homeland of Syria to escape being forced to fight in the military of President Bashar al-Assad.

Now the 21-year-old is battling to stay in Britain and avoid being sent across the world again, this time to Rwanda where the British government wants to send migrants who turn up illegally on its shores.

"It's the end of the world for me, I can't imagine it," he told Reuters by phone through an interpreter and declining to give his full name while his asylum claim is considered.

Aladeen, one of about 130 migrants initially given a ticket to Rwanda and now left in legal limbo, is caught in the British government's struggle to control its borders and manage voters' post-Brexit migration demands.

He is among more than 20,000 migrants to have made the precarious 20mile journey from France to Britain this year on small boats across the English Channel, crossing one of the busiest shipping lanes in the world.

The status of migrants like Aladeen will be the subject of a legal challenge in London's High Court in early September when a coalition of human rights groups and a trade union will argue that the Rwanda policy is unworkable and unethical.

Governments across the world are wrestling with how to deal with an influx of refugees fleeing war-torn countries or persecution in their homelands. Britain is the latest country to attempt to outsource the settlement of asylum seekers.

Australia pioneered the concept and European governments have in recent years paid countries like Libya to stop migrants on their behalf. Denmark has signed a similar agreement on deportations with Rwanda, but has yet to send any migrants there.

Britain has portrayed its policy as humane, saying it will smash the business model of the people smugglers and end the emergency which has seen at least 166 people die or go missing, with 27 drowning in the worst accident in Nov.

But it has attracted widespread criticism - from lawmakers across the political divide, the United Nations and even heir to the throne Prince Charles - while the European Court of Human Rights issued injunctions to force the cancellation of the first deportation flight hours before it was due to leave in June.

The policy is also dwarfed by the scale of the challenge.

So far Rwanda has also only set up one hostel to accept UK arrivals, with capacity for about 100 people, representing 0.35% of all the migrants who arrived in Britain last year.

A British official said the government was in talks to acquire another three or four hostels in Kigali, but even those would only provide accommodation for about 1.6% of last year's arrivals.

"I'm not going to pretend that the Rwanda policy is the single magic bullet, in 2018, contributing to the 1.5 billion

several years. In 2021, 28,526 people were detected arriving on small boats - with the highest number from Iran followed by Iraq, Eritrea and Syria. That was up from 8,466 in 2020, 1,843 in 2019, and 299

Johnson said officials earlier this year believed a record 60,000 asylum seekers could arrive in Britain this year.

Asked why he had not sought asylum in France, a question often posed criminal. I am not a criminal, all I am by supporters of the Rwandan policy, he said he understood he would not be treated fairly there.

"I don't have family there to support Rwanda, he said: "I'm not sure - my ing hazardous journeys to Britain and me, all the family I know, everything life is ended."

I know - all the human rights ... that's why I came to the UK," he said.

In the northern French port of Calais, he says his family paid a people smuggler - he was not sure how much - and he made a seven-hour trip with 18 others on a small boat in mid-May.

Many others pulled out, too fearful to get into the boat.

On arrival in Britain, he was taken to a holding facility before being moved to a detention center. He was initially given a ticket to Rwanda but said his lawyers had been able to can-

FTER another miserable day, 11-year-old Alyas calls out at the top of his voice in a Kabul street. As the sun sets, he takes his last opportunity to sell what remains of the melting ice cream in his cart.

"I'd rather be at school instead of selling ice cream on the street," Alyas said. Since last month, he and his elder brother have dropped out of school to work in However, their average income of less than 60 Af-

ghanis a day looks like a drop in the bucket in face of As poverty and unemployment rise across the

country, the number of beggars in Afghanistan's capital Kabul grows every day. Some 3 million Afghan children like Alyas have dropped out of school to earn money to support their families.

Mohammad Hassan Khan farms about 4 hectares in east Afghanistan's Khost province. Or he used to, but today there is no water for his fields, fertilizers must be imported and the prices are too high for anyone to afford -- so he's now a porter in the streets of the capital.

Afghanistan, which is in urgent need of post-war reconstruction, has been facing a worsening humanitarian crisis, economic depression and terrorist attacks since the takeover by the Taliban on Aug. 15 last year. The United States, which hastily withdrew from Afghanistan in disregard of its responsibilities and obligations, deserves much blame for the mess it left behind. "We reported late last year that an estimated

mid-2022, and regrettably, that number is being reached faster than anticipated," said head of the United Nations Development Programme Achim Steiner earlier this year. Afghanistan is facing a non-reversible economic collapse.

A frozen banking system and liquidity shortage mean as many as 80 percent of people are in debt. Assets worth more than 9 billion U.S. dollars have been frozen by the United States as part of its sanctions against the new gov-

In addition, 20 years of war left severe shortages of infrastructure, power supplies and professionals. According to Abdul Nasir Rishtia, chief executive of Afghanistan steel mills union, 5,000 steel mills in Afghanistan are facing a shortage of key technical personnel.

"The United States has brought death and blood to Afghans for 20 years. The tragedy they made here is still going on," said Najibullah Jami, a professor at Kabul University. He blames the U.S. for the humanitarian crisis.

During the 20-year war, the United States chose to fight terrorism according to its own geopolitical goals, which led to an increase in the number of terrorist organizations in Afghanistan.

"If the interest of the United States requires, it will add any group in the list of terrorists and if its interest requires to exclude a group from the list, it will also do so," said Abuzar Khapalwak Zazai, a professor from Kabul University, adding what the United States has left the Afghan people is a difficult position to get out of.

Since August last year, no major fighting has been reported in Afghanistan. However, the Islamic State has launched dozens of attacks. In Kabul alone, there is a bomb attack every two or three days. The Taliban-run administration has generally achieved stability national wide, but it is difficult to eradicate extremist and terrorist groups. Xinhua

NE act was central to converting what had already been a week of killing and confrontation at Marikana in 2012 into a massacre. That was the instruction for the police to launch the operation against the strikers on the afternoon of 16 August. This led directly to the police killing 34 people and seriously injuring many others.

In the days before, there had been many other acts of violence. Three strikers had been killed by police. Seven other people, including two police, were murdered allegedly by people associated with the strike.

The Marikana Commission report provides a list of matters to be referred to the North West Director of Public Prosecutions for investigation "to determine whether there are bases for prosecution." One of these is "the possible liability of senior officers in the South African Police Services" for the shootings that took place on 16 August.

The National Prosecuting Authority (NPA) has initiated prosecutions for some of the killings that took place before that day. But 10 years after the incident, the NPA still has not indicated whether it will prosecute anyone regarding the 34 deaths.

Several South African Police Service (SAPS) 'tactical units' – among them the National Intervention Unit and the Tactical Response Team – were deployed at Marikana. They were armed with R5s, a high-velocity rifle developed by the country's arms industry for use in the border wars of the 1970s and 1980s. Of the 34 miners killed at Marikana on 16 August, 33 were shot by R5 rifles.

There were over 600 SAPS members, including roughly 300 from the tactical units. They were facing a group of around 3,000 strikers, more than 300 of them armed with spears and other weapons. This was not a conventional public order operation intended to the operation. But police doubted they preparations gave no serious attention lets fired at strikers could easily have

could defend themselves effectively if attacked by the strikers. The deployment of the tactical units with their R5s was intended to ensure that the police could get the upper hand if the public order officials were attacked.

There was no immediate need for the operation to be launched that Thursday afternoon. Knowing there was a possibility of major bloodshed, and stun grenades were involved in the police went ahead. Their plans and dispersing a crowd of 3,000, R5 bul-

to minimising the risk of police relying on the weapons carried by the tactical units.

The police envisaged being involved in multiple confrontations with armed strikers. If the operation had unfolded this way, more than 34 people could have been killed. Given that they were struck many others in the vicinity who were not confronting the police. Police could also have died in the R5

The operation at Marikana didn't go according to plan. Instead, it appears that the police opened fire when there was no attack against them. However many of the police who killed strikers that day, at both Scene 1 and Scene 2, may have believed the miners were attacking or shooting at them.

This doesn't diminish the culpability of the senior SAPS commanders involved. Considering the massive potential for loss of life, the decision to proceed was reckless and grossly irresponsible.

Regarding accountability, one must consider the role of Zukiswa Mbombo, the North West SAPS provincial commissioner at the time. She was the most senior police member present at Marikana on 16 August and issued the instruction to start the operation.

It's widely believed that the decision to launch it that day emanated from a political directive approved by police leaders the night before. Nevertheless, Mbombo was informed of the risk of serious injury but insisted the operation go ahead. According to the Marikana Commission report, the provincial commissioner was warned that the action "would involve bloodshed. She reconciled herself to the fact that this was so merely asking for an assurance that it would be kept to the minimum."

Although she was likely acting on the instructions of her superiors and their political bosses, she seems to have failed to properly consider the consequences. In her 31-year policing career, Mbombo had only been involved in operational activities during her first year. After that, she held administrative and financial positions until she was appointed provincial commissioner in 2005.

Perhaps this lack of operational experience meant she did not appreciate the nature of her responsibility in the situation or the scale of the risk. Despite this, she should be one of those who face a formal legal process of accountability.

South Africa's criminal justice institutions face a heavy burden. They must deal with high levels of violent and other crimes, hold to account those who orchestrated the July 2021 unrest and pursue many corruption cases, including the numerous leads provided by the Zondo Commission.

Notwithstanding this workload, the unresolved accountability issues in relation to Marikana must be addressed if efforts to build the rule of law in South Africa are to have genuine credibility. **DM**

Ending violence against women: Using the law as a mechanism for prevention and justice

AS part of her PhD research, Pretty Mubaiwa wanted to understand the intricacies of African customary marriages and why they expose women to violent and discriminatory practices and experiences.

As part of her PhD research, Pretty Mubaiwa wanted to understand the intricacies of African customary marriages and why they expose women to violent and discriminatory practices and experiences.

Lobola creates rigid gender roles, skewed beliefs of entitlement and ownership of women's lives and bodies, as well as asymmetrical power relations. This is what Pretty Mubaiwa, a recent PhD graduate; found based on her research, which critically interrogates the relationship between culture, violence against women (VAW), and the practice of human rights in Africa.

As part of Women's Month commemorations, UCT News interviewed Mubaiwa on her research, which specifically delves into the cultural practice of bride price (also known as Lobola) to understand whether the practice is a cause and/or consequence of VAW in family

With her dissertation topic titled, "Human Rights, Modernity and Culture: Do the current hu-

man rights frameworks and discourse include traditional African practices such as Lobola as a form of violence against women?", Mubaiwa wanted to understand the intricacies of African customary marriages and why they expose women to violent and discriminatory practices and experiences.

Different tribes and countries practise it differently, which makes it more complex. Mubaiwa decided to keep it closer to home. "Of course, that is too wide a topic, so I decided to look at what is familiar to my Shona culture (among others) roora, also known as Lobola. This is such a hot topic among the youth in Southern Africa and a recurring discussion on social media platforms as well," said Mubaiwa, who graduated with her PhD in Public Law in July

"I wanted to bring together my ... academic training from the social sciences and law to critically investigate the correlation or causality between the practice [of Lobola] and VAW. My research was based on four country case studies: Zimbabwe, Malawi, Zambia and Uganda. Inherently, African cultural practices are not devoid of the history of colonialism and the outsider gaze, which is usually demonising without being critical of the role these practices

play in communities. In this case, roora - before colonial and modern influences - was an act of bringing families together to symbolise marriage; it was not monetised. Over time, this practice has evolved and has created different entitlements and power dynamics that expose women to violence."

In short, Mubaiwa's research found that roora or lobola in and of itself is not a form of VAW.

However, the results from her analysis showed that lobola creates rigid gender roles, skewed beliefs of entitlement and ownership of women's lives and bodies, as well as asymmetrical power relations.

"Secondly, the legal dimension of my thesis established that international, regional and local laws have gaps that continue to leave women vulnerable to suffering from violence that they may suffer in marriage," she said.

In addition, she said, historical and patriarchal concerns dissuade various stakeholders from questioning the role of culture and tradition in the perpetuation of violence against women on the continent. Asking whether the younger generation coming into roles of leadership will actively work to change this, Mubaiwa said she would like to

"From the research coming out from different institutions around the world on African cultural practices, young academics are providing new lenses to these studies including through using feminist and decolonial approaches. There is hope and it is refreshing!'

Born in Harare, Zimbabwe, Mubaiwa attended Marondera High School before she came to South Africa to enrol for her BA in International Relations at Nelson Mandela University in 2008. She moved to Cape Town in 2012 to start her BA Hons in International Relations at UCT.

"It was a different pace, but I loved the vibrancy of academia at UCT. I worked in Zimbabwe for two years after my honours in order to find where exactly my passion was - and then I finally returned to UCT in 2015 to join the Department

of Public Law, where I completed a Master in Philosophy, specialising in human rights law," she said.

Pretty Mubaiwa is passionate about women's rights and being an advocate for the elimination of violence against women and girls in Africa.

"During my master's courses, I met Professor Rashida Manjoo, who became my supervisor for my thesis on the effects of the changing nature of electoral violence on women in Southern Africa. She nurtured my passion for women's rights and being an advocate for the elimination of violence against women and girls in Africa. During my master's graduation, Professor Manjoo told my mom that we would one day be back at the Sarah Baartman Hall for my PhD graduation, and on Friday, 22 July 2022, we certainly were back celebrating."

The highs and lows of a PhD journey

Her PhD journey has been a "character-building experience", Mubaiwa said. "The highs have definitely included having an amazing supervisor like Professor Manjoo, who is so knowledgeable and not afraid to share her experiences and opportunities with her students. Another high was going through the journey with a whole village around me, including Canon Collins Legal and Academic Trust, friends, family and fellow students."

Another highlight, she noted, was the support she received from her parents, Chipo and Emanuel. "I always had a dream, and they did everything they could to support me to achieve my dream of becoming an academic doctor, despite where they came from, they never allowed that to be a barrier to achieve my dreams."

"Looking back, the journey stretched me to my core and

Mubaiwa said, however, that she feels "there aren't many mechanisms to access when you are experiencing trouble with writing, academic loneliness, opportunities to share your research and to learn from the wider academic community". "I am certain this is a sentiment most of my fellow PhD students shared," she said.

"However, looking back, the journey stretched me to my core and limits while reigniting my passion to eliminate and contribute to eliminating VAW in our lifetime by using the law as a mechanism for prevention and justice."

TALIRI director for Southern Highlands Zone Dr. Edwin Chang'a said the organic feed supplements are safe, don't have chemicals which may cause diseases and are more nutritious.

Citing an example of Afri Bio Solution he said organic farming has brought needed revolution for animal feed impacting their overall health, wellness and the environment.

"Organic feed uses natural materials, they are nutritious and environmentally friendly, don't have antibiotics, they are natural and it works faster compared to other supplements," he said.

He said his research institute is currently studying more on organic feed supplements to get fast and precise solutions for livestock production in the

country. We have collected several samples and are currently conducting research to come up with more organic feed supplements before introducing them to the public, he said.

"There are some organic feed supplements that have been tested and show that they are safe, and increase production for chickens and cattle within a very short time," he added.

For his part, Regional Director for Afri Bio solution Paluku Emmanuel said nowadays the world has been connected by technology. It has changed, many livestock keepers have moved from chemically made animal feed to organic feed supplements.

tion of aid for trade to achieving the Sustainable Development Goals requires a resolute focus on the "where" and "how" of delivering development results. This means a focus on those countries whose trade and development needs are highest - particularly Least Developed Countries and fragile/ conflict-affected countries - and regional initiatives like African Continental Free Trade Area, to ensure they become stepping-stones to wider and more inclusive regional value chains and trade-led growth.

It means partnership across international organizations. The WTO, UNCTAD, and ITC already collaborate on initiatives like the Global Trade Helpdesk, which simplifies market research by bringing key trade and business information into a single portal, as well as on support to cotton-exporting countries in Africa.

Last but certainly not least, it means mobilizing public and private finance. The IFC estimates a worldwide US\$300 billion financing gap for women, and the global trade finance gap has nearly doubled from an already-staggering \$1.5 trillion. Without access to finance, firms cannot grow, diversify or formalize.

Journalism under attack by neo-populist governments in Central America

RACTICING journalism in Guatemala, Nicaragua and El Salvador is becoming increasingly difficult in the face of the persecution of independent media outlets by neo-populist rulers of different stripes, intolerant of criticism.

The most recent high-profile case was the Jul. 29 arrest of José Rubén Zamora, founder and director of elPeriódico, one of the Guatemalan media outlets that has been most critical of the government of right-wing President Alejandro Giammattei, who has been in office since January

The union of Guatemalan journalists and the reporter's family say the arrest is a clear example of political persecution as a result of the investigations into corruption and mismanagement in the Giammattei administration published by the newspaper, which was founded in 1996.

"I definitely believe it is a case of political persecution and harassment, and of violence against free expression and the expression of thought," Ramón Zamora, son of the editor of elPeriódico who has been imprisoned since his arrest, told IPS from Guatemala City.

A case out of the blue

The 66-year-old journalist is one of the most recognized in Guatemala and in the Central American region, and has been awarded several times for elPeriódico's investigative reporting.

Zamora is being charged with money laundering, influence peddling and racketeering, al-

though the evidence shown at the initial hearing by prosecutors "are poor quality voice messages that show nothing," according to Ramón.

The preliminary hearing ended on Aug. 9 with the judge's decision to continue with the case and keep Zamora in pre-trial detention. Prosecutors now have three months to present more robust evidence before taking him to trial, while the defense will seek to gather evidence in order to

"We are going to clearly demonstrate as many times as necessary that this case was staged, that the evidence, or rather the evidence they have, cannot be stretched as far as they are stretching it," said Ramón, 32, an anthropologist by profes-

He added that from the beginning President Giammattei showed signs of intolerance towards criticism of his administration.

"We knew he was an angry person, authoritarian in the way he acted, but we never thought he would go this far," he said.

Since the arrest, Ramón said that his father is in good spirits, upbeat, although he has had problems sleeping, while the newspaper continues to be published in the midst of serious difficulties due to the temporary seizure of its bank accounts and liquidity problems to pay the staff and other costs.

On Friday Aug. 12, elPeriódico gave key coverage to a decree approved by the Guatemalan legislature that gives life to a Cybercrime Law, which could become another governmental tool to silence critics.

The newspaper quoted the organization Ac-

ción Ciudadana, according to which article 9 of this law "contravenes free access to sources of information - a right stipulated in the constitution; furthermore, it violates the Law of Broadcasting of Thought, restricting freedom of information."

Zamora Jr. regretted that in Central America iournalistic work is restricted and persecuted by governments and other de facto powers, as is happening in Guatemala with Giammattei, in El Salvador with the government of Nayib Bukele, and in Nicaragua, with that of Daniel Ortega.

"Ortega, in Nicaragua, is a mirror that we all have in front of us in the region, it is worrisome," he said.

Press freedom in free fall

In these three countries there is an openly hostile policy against the independent media, whose journalists suffer harassment, persecution, blackmail, intimidation and restrictions of all kinds in the line of duty.

Central America, a region of 38 million people, faces serious economic and social challenges after leaving behind decades of political strife and civil wars in the 1970s and 1980s, specifically in Nicaragua, Guatemala and El Salvador.

Further progress towards democracy is undermined by attacks on or harassment of media outlets that criticize corrupt governments, according to reports by national and international organizations.

In this regard, the World Press Freedom Index 2022 report by Reporters Without Borders (RSF) points out the decline suffered by Nicaragua, which dropped 39 positions in the ranking to 160th place out of 180, and El Salvador, which lost 30 positions, dropping to 112th place.

"For the second year in a row El Salvador had one of the steepest falls in Latin America," the report states.

And it adds that since he took office in 2019, Bukele, described as a "millennial" leader with a vague ideology and an "authoritarian tendency...is exerting particularly strong pressure on journalists and is using the extremely dangerous tactic of portraying the media as the enemy of the people."

Other will include establishment of a vegetable nursery to produce seedlings to assist in the development of vegetable farms and the provision of vegetable gardens with wells, tread pumps and seedlings in a large number of new dwellings as well as skills training for local youths, focused on brick laying and carpentry, as part of the construction of relocation dwellings, with a view to such youths being employed as part of construction and operations at Chilalo.

Evolution says has also completed several studies on how best to deliver the RAP, including a first-ever health impact assessment for the area, a water availability study,

a cultural heritage study, vulnerable persons assessment, human rights impact assessment, and a local biodiversity and ecosystem impact assessment.

The Chilalo Graphite Project is located in southeast Tanzania, within the Mozambique belt, which is well known for hosting some of the world's highest grade and coarse flake graphite deposits.

More than 30,000 skilled youths benefit from ILO apprenticeship

MORE than 30,000 Tanzanians have benefited from the International Labour Organisation (ILO) led Recognition of Prior Learning (RPL) 2021/22 apprenticeship programme.

She said since 2014, ILO and the government through VETA and the Prime Minister's Office endorsed RPL as a successful process of identifying, documenting, assessing and clarifying informal learning against formal education and training standards.

"The training cuts across different sectors from food production, hospitality, construction and works. RPL gives employers access to qualified and skilled workers; it targets at improving workers' self-esteem and respect in business circles and wider society. However, RPL allows workers in the informal sector to meet regulatory requirements in specific sectors," said Belinda.

In line with the programme success stories, Belinda said there are challenges in expanding it.

She said there is a shortage of local trained RPL experts such as facilitators, assessors, moderators and developers. There is low participation of women in the programme that forms

about 15 percent of all beneficiaries. There are no common regional guidelines especially for the SADC region for graduates to explore unlimited opportunities.

On the way forward, the programme's development objective is to continue supporting the government in implementing the National Skills Development Strategy 2016/17 to 2025/26 which aims to develop and maintain a skilled and competitive workforce.

"A competitive workforce capable of effectively fostering inclusive and sustainable social-economic transformation for timely attainment of middleincome status by 2025," she noted.

Oil price decline in global slowdown, supply increase

TEXAS

OIL price declined for a third day as a deepening global slowdown looked set to coincide with an increase in supply from OPEC producers.

West Texas Intermediate futures slid below \$89 a barrel after falling around 5% over the previous two sessions. Mounting signs of an economic downturn swept through

markets on Monday as bearish US data including rapidly cooling manufacturing followed weaker-than-expected Chinese numbers.

Investors are also facing the prospect of rising supply as demand moderates, while prompt time spreads are signaling concerns over tight global markets are easing. Libya is pumping more and Iran is edging closer to reviving a nuclear deal that will likely see higher crude flows.

"Oil prices are being weighed down by a weaker macroeconomic outlook due to poor data from China as well as possible new supply from Iran," said Sean Lim, a Malaysia-based oil and gas analyst at RHB Investment Bank Bhd. "However, even if the Iran deal passes, any ramp-up in oil production could still take time, so its immediate effect might not be too strong.'

Crude is trading near the lowest level in six months after giving up all of the gains following Russia's invasion of Ukraine, which upended trade flows and drove prices as high as \$130 a barrel. The market has also been gripped by bouts of volatility recently, exacerbated by the lower levels of liquidity.

While the market is backwardated, a bullish pattern

Adavale's eyeing aerial searches for nickel deposits in Tanzania

ADAVALE Resources is taking to the skies, launching a helicopter-borne electromagnetic survey at its Kabanga Jirani and Luhuma nickel projects in Tanzania.

The survey will test nine high-priority areas across 18 conductive targets generated from a recent gravity survey, illuminating around 2000km of ground to 500m below surface.

The survey is using high powered Time Domain EM, designed specifically to target nickel mineralised conductors

Adavale's Kabanga Jirani and Luhuma projects will be watched closely by those in the industry given their proximity to what is the largest development ready nickel deposit in the world at the nearby Kabanga project.

Kabanga, owned by a London-based company of the same name, received a capital injection of \$50 million from the world's biggest miner BHP earlier this year.

It makes Tanzania a great postcode for a nickel explorer, with Adavale planning to use the HEM data in conjunction with an existing exploration database to prioritise targets for RC and diamond drilling starting late in the September quarter.

"We are delighted that this Heli EM program is now underway. With c.2000km being flown over 10 to 14 days, the program has been designed to allow our technical team to receive and interpret the data regularly so we can identify and then prioritise potential drilling locations," Adavale executive director David Riekie said.

"Drilling will be coordinated with local drilling contractors for the RC and DD campaign. Funding from the recent capital raise will enable us to be actively drilling over the coming months. We look forward to keeping the market informed of these important exploration activities and their outcomes."

More startups lining up for **Mbadala Impact Fund's cash**

THE Dar es Salaam-based SSC Capital said has started receiving and considering applications from start-ups seeking funds to expand their businesses, after mobilizing \$5million (11.66billion/-) for its Mbadala Impact Fund.

Mbadala, which was introduced to the general public two months ago, is an impact fund targeting to support start-up enterprises established with financial viability, compliant with environmental, social and governance (ESG) models.

Founder and Chief Executive Officer of SSC Capital, Salum Awadh (pictured) told The Guardian during an interview over the weekend in Dar es Salaam that the \$5million will be extended to the maximum of 15 qualified start-ups with tickets worth between \$150,000 (349.79million/-) and \$350,000 (816.30million/-).

"The process could last almost three months from now. Mbadala fund targets at empowering enterprises start-ups in food and agribusiness, renewable energy, healthcare, education, technology and water, sanitation, and hygiene,

Awadh said the fund is a sector-agnostic using a holistic approach to promote 17 sustainable development goals

He said selected applicants will be awarded as high as \$500,000 just depending on the stipulated criteria such as financial position of the applicant and detailed business

According to him, other criteria for accessing the funds called for enterprises that have been operational at least for one year, post-revenue, with strong financial logic, must have a scalable business model and must address one or more sustainable development goals (SDGs).

"The applicant must have a great working team, potential exit in a particular business or field for three to five years, applicant to embed the environmental, social, governance (ESG) model and must demonstrate innovation," he added. Speaking of venture capital and private equity develop-

ments in Tanzania, he said it is a fairly new industry. He said there's a need for all stakeholders to join forces in increasing investment flow, and unlock the industry, which

currently stands at around 17 percent of U\$2.4bn, which is the regional industry size.



Only 19pct Ugandas borrow from formal financial institutions

KAMPALA

ONLY two out of ten Ugandans borrow from formal financial institutions, according to Ministry of Finance permanent secretary Ramathan Ggoobi (pictured).

Speaking during the Financial Inclusion and Financial Literacy Forum in Kampala last week, Mr Ggoobi said that whereas the number of Ugandans who borrow from formal financial institutions was still low, it almost doubles that of sub-Saharan Africa, which stands at 10 percent, and far above some countries such as

Tanzania - 4 percent. Therefore, he said, there is

need to improve financial inclusion, which will result in an increase in uptake of formal financial services, noting that while the poor have made progress, they still lag behind the rich while, according to the Uganda National Household Survey, the level of education remains a key determinant in financial literacy and inclusion.

For instance, the survey indicates 65 percent of Ugandans without a primary level education have no access to financial accounts, compared to just 23 percent of those with a secondary level education.

Mr Ggoobi also noted that, ac-



cording to the World Bank's Findex database, the share of Ugandans with access to a financial account - either with a formal institution or a mobile money provider - has risen from 59 percent in 2017 to 66 percent in 2021, although it remains below Kenya's 79 percent.

"Our target is to increase this number to 80 percent by 2027. We must redouble our efforts to ensure all Ugandans have access to essential financial services and the skills they need to use them,"

Digital innovations and technology have become central to financial inclusion, allowing at least 61 percent of Ugandans, according

to Bank of Uganda, to use digital payments, up from 51 percent in 2017. Out of these, at least 47 percent use mobile phones or internet to access a financial account, which is more than double the average sub Saharan Africa of 21

The progress has been achieved through different interventions such as Profira - the Project for Financial Inclusion in Rural Areas - which, as of June 30, according to Mr Ggoobi, had supported establishment of 15,000 community savings and credit groups and strengthened 3,000 existing groups, 76 percent of which are composed of women.

DR Congo opens oil and gas auction round

THE Democratic Republic of Congo will allow carbon credit and cryptocurrency companies to bid in an oil and gas licensing round that has been criticised by environmentalists who say drilling in the country's rainforests and peatlands would risk releasing vast quantities of carbon dioxide.

Last month, Congo put 30 oil and gas exploration blocks up for auction. Some of the exploration areas are in Virunga National Park and the Cuvette Central, the world's largest tropical peatland, which naturally absorbs carbon from the

Companies have until February to submit bids.

Didier Budimbu (pictured), the hydrocarbons minister, told the Financial Times he would accept bids for exploration rights in the rainforest and peatlands from carbon market start-ups with no links to oil and gas majors as long as they had solid financial backing.

Rather than explore for hydrocarbons, such groups propose keeping any oil and gas in the ground and instead generate revenue by selling carbon credits to companies looking to offset their emissions.

"If it can help our economy and the country, why not?" Budimbu said. "We're not doing this to destroy the rainforest, we're doing it for economic gain...With or without oil, what's important is that we earn [money].'

Congo produces about 25,000 barrels a day of crude oil from a small number of onshore and offshore blocks along its Atlantic coast. The government's long-held ambitions to produce oil in other parts of the country's interior have previously been held back by environmental concerns, corruption and a lack of export options.

Those challenges mean it remains uncertain how many oil and gas companies plan to participate in the licensing round. France's To-



talEnergies, which has a project in neighbouring Uganda, and Italy's Eni, which is active in other parts of Africa, have both told the FT they will

Flowcarbon, a start-up co-founded earlier this year by WeWork cofounder Adam Neumann, is among the carbon credit groups to have expressed interest.

Phil Fogel, Flowcarbon's head of cryptocurrencies, said the company had contributed staff and resources to RedemptionDAO, a campaign organised over messaging platforms Telegram and Discord and founded two days before the auction launched in July.

RedemptionDAO aims to buy at least one of the blocks in partnership with an oil company or through crowdfunding, and use it to issue "avoided emissions" carbon credits. It hopes to raise at least \$50mn, but has so far only raised \$2.57mn and obtained pledges of \$74,000, both in USDC, a so-called stablecoin digital currency pegged to the dollar.

Venture capitalist Thomas Annicq said he had contacted the Congolese government separately on behalf of another coalition of carbon market companies that wanted to mount a joint bid on the blocks.

However, there is at present no official methodology for bringing credits from foregone oil and gas exploration to market and analysts say that developing one could take up to two years.

Taxation on winning bets decreases by Sh1.4 billion

NAIROBI

WITHHOLDING tax on winning bets, which was paid to the Kenya Revenue Authority in the year ended June, dropped by Sh1.42 billion reflecting a slump in an industry amid clamping down on the addictive sector.

The taxman said it collected Sh5.67 billion in withholding tax from winning bets in the period under review reflecting a drop of 19 percent from Sh7.09 billion a year earlier.

The fall reflects a slowdown in the industry on increased taxation on gamblers as the government moves to tame the betting craze mostly among the youth and iobless Kenvans.

Gamblers pay 20 percent of every winning bet in addition to a 7.5 percent tax on each betting stake that was re-introduced in July last year.

Betting Control and Licensing Board (BCLB) chief executive Peter Mbugi says the heavy taxation has served the government's intention of clamping down on the

"Licensed operators are increasing but most of them are doing zero-sum business. The market is no longer expanding. The average amount spent by gamblers also reduced last year compared to three years when the industry was at its peak," said Mr Mbugi.

A drop in the tax can be attributed to a reduction in winning bets or a decline in the number of bets placed

The taxman takes WHT which is calculated at the rate of 20 percent on the winning bet after subtracting the amount staked.

The government also re-introduced a 7.5 percent tax on every betting stake meaning that for every Sh100 staked, KRA takes Sh7.5.

Betting firms pay tax at a rate of 15 percent on the gross gaming revenue- turnover minus winnings paid out. They also pay corporate tax on profits at a rate of

The government also formed a multi-agency team that draws memberships from the betting regulator, KRA, and the Financial Reporting Centre among other State agencies.

Data from the KRA shows that tax on gross gaming revenue rose 13 percent to Sh3.294 billion in the year ended June from Sh2.907 billion a year earlier.

Gaming is popular among the youth with some funding their betting addiction through digital loans. The jobless have also turned to the craze in the hope of striking it rich.

Betting peaked in recent years as jobless Kenyans and the youth used billions of shillings to place bets in the hope of making quick money to pay their daily bills.

Safaricom revealed that punters pushed Sh169 billion through M-Pesa to bet in the year ended March, translating to Sh469 million per day highlighting the extent of the habit that prompted strict regulation and increased taxation from the government.

US monkeypox cases on sharp rise 'due to government setbacks'

LOS ANGELES

MONKEYPOX cases in the United States have kept climbing rapidly, topping over 11,000 cases, while media and experts have been blaming the Biden administration's response to contain the outbreak.

A total of 11,177 monkeypox cases had been reported across the country as of Friday, according to the latest data from the US Centers for Disease Control and Prevention.

New York had the most cases, with 2,295, followed by California with 1,945 and Florida with 1,085.

So far, the United States has the world's highest tally of monkeypox

Since the CDC confirmed the first

monkeypox case in the United States in a Massachusetts man on May 18, the country has seen a continuous surge of cases, according to the trend map on the CDC website.

Health experts said given the testing bottlenecks in the United States, monkeypox cases are likely being tremendously undercounted.

A series of setbacks in the Biden administration's response to addressing monkeypox allowed the disease to gain a foothold in the country, said a report of Politico.

The setbacks include clunky early testing protocols, slow vaccine distribution, a lack of federal funding to help state and local governments respond to the outbreak, and patchy communication with communities sis, said the report.

THE collective West is purposefully destroying the European security system, Russian President Vladimir Putin said in his address to participants and guests of the Moscow Conference on International Security.



"The so-called collective West is purposefully destroying the European security system, putting together more and more new military alliances," Putin said.

"The US and its vassal states grossly interfere in the internal affairs of sovereign states through organizing provocations, coups, and civil wars. They use threats, extortion, and pressure to force independent governments to obey their will and follow rules that are foreign to them,"

Putin stressed, "All this is being done with one goal - to maintain its dominance, the model that allows to feed off the entire world, as it was centuries before, and this model can be maintained only by force."

He drew the attention of the conference participants to the fact that the NATO bloc is moving to the East, bolstering its military infrastructure, including the deployment of missile defense systems and increasing offensive forces' attack capabilities.

"On paper, this is hypocritically declared as a need to boost European security, but in reality, the exact opposite is happening. At the same time, Russia's proposals from December last year were simply ignored once more," Putin concluded. Agencies

EU working to increase economic, security ties in Pacific

WELLINGTON

THE European Union is working to boost its presence in the Pacific through economic ties and new security commitments as geostrategic competition in the region intensifies, the bloc's ambassador to Pacific Island nations said

Ambassador Sujiro Seam told Reuters in an interview during a visit to New Zealand the EU had long been seen as a development partner in the Pacific and that it wanted to be perceived as an economic and strategic partner as

The EU's push comes as major powers are vying for influence in the region.

"The geostrategic importance of the Pacific is recognized by everyone, including the European Union," Seam

The European Union has long had a presence in the Pacific, mostly via France's ties to French Polynesia.

In 2021, the European Union set out a formal Indo-Pacific strategy and announced a 300 billion euro (\$305 billion) global infrastructure fund that Seam said was helping to boost ties.

The EU has several development projects underway in the region and is looking at more, he said, noting it is finalizing plans to spend 5 million euros on a feasibility study for a wharf on Kiritimati Island in Kiribati.

However, when countries make decisions on who to partner with it is important they assess the consequences such as whether they are being offered development aid

Part of the strategy to boost the EU's presence in the Pacific is to provide economic opportunities, Seam said, and it has signed a number of trade partnerships with Pacific governments and is negotiating a similar agreement with

Tonga to allow it better access to European markets. He said the EU also planned to step up its footprint in maritime surveillance in the Indo-Pacific. The French military, which often has assets in the region, has been used

to provide EU support in the past. **Agencies**

'Some US politicians 'openly play with fire' regarding Taiwan issue'

QINGDAO

CHINESE State Councilor and Foreign Minister Wang Yi on Monday met via video link with visiting diplomatic envoys of developing countries from Asia and Africa to the UN Office at Geneva

Wang said that China is willing to uphold the vision of a community with a shared future for humanity, and work in solidarity with other developing countries to achieve common development and prosperity and to make the planet even more beautiful.

"In the face of the ongoing COV-ID-19 pandemic, the turbulent international situation and the resurgence of the Cold War mentality, we need a strong UN more than ever," he said.

He said all sides should firmly uphold the international system with the UN at its core, the international order underpinned by international law, and basic norms governing international relations based on the purposes and principles of the UN Charter.

The representation and voice of developing countries should be enhanced and multilateral institutions should not be reduced to tools for certain countries or groups of countries to manipulate and decide international affairs, the Chinese diplomat stressed.

He introduced China's achievements in the development of human rights cause, saying that China is willing to carry out human rights exchanges and cooperation with other countries on the basis of equality and mutual respect with an open attitude, so as to learn from each other and make progress together.

He expounded on the historical facts of the Taiwan question and China's solemn position, stressing that China must make the necessary and legitimate responses to every blatant provocation by the United States.

This is exercising the legitimate right to safeguard national sovereignty and territorial integrity, as well as safeguarding the principle of non-interference in other countries' internal affairs, he said.

The envoys lauded China's worldrenowned achievements and strong leadership, commending China's efforts on promoting development, progress and social equality.

They said the one-China principle established by the United Nations

CIA sued over spying on lawyers, journalists who met Assange

WASHINGTON

A GROUP of journalists and lawyers sued the CIA and its former director Mike Pompeo over allegations the intelligence agency spied on them when they visited WikiLeaks founder Julian Assange during his stay in Ecuador's embassy in

The lawsuit said that CIA under Pompeo violated the privacy rights of those American journalists and lawyers by allegedly spying on them. The plaintiffs include journalists Charles Glass and John Goetz and attorneys Margaret

Kunstler and Deborah Hrbek, who have represented Assange

representing the plaintiffs.

ment on the lawsuit, is prohibited from collecting intelligence on US citizens, although several lawmakers have alleged that the agency maintains a secret repository of Americans' communications data.



High Court in London to block his extradition to the United States to face criminal charges in a legal battle that has dragged on for more than a decade.

Monday's lawsuit was filed in the US District Court for the Southern District of New York.

The filing said the journalists and lawyers were required to surrender their electronic devices to Undercover Global SL, a private security company which at the time provided security to the embassy, before their visits to Assange. The lawsuit alleged the company copied that information and provided it to the CIA, which was then headed by Pompeo. Assange spent seven years in the embassy before being dragged out and jailed in 2019.

Pompeo and Undercover Global SL could not immediately be reached for comment.

Assange is wanted by US authorities on 18 counts, including a spying charge, related to WikiLeaks' release of confidential US military records and diplomatic cables. His supporters say he is an antiestablishment hero who has been victimized because he exposed US wrongdoing in conflicts in Afghanistan and Iraq. Agencies

Kenya braces for legal battle after Ruto declared election winner

KISUMU/NAIROBI

KENYA braced yesterday for a protracted legal battle after William Ruto was declared the victor in a closely fought presidential race over the objections of more than half the electoral commission, stoking fears of political

In the western city of Kisumu and Nairobi's huge Kibera slum, both strongholds of rival candidate Raila Odinga, calm returned to the streets after protesters battled police and burned tyres on the road overnight.

The dramatic events of Monday, which saw Ruto declared president by a tiny margin as a split emerged in the electoral commission overseeing the Aug 9 vote, has raised fears of bloody violence like that seen after previous disputed polls.

The veteran opposition leader, making his fifth bid for the presidency, is under local and international pressure to seek peaceful legal remedy for any concerns over the election outcome. The United Nations and the US embassy in Kenya both urged all parties to work together.

The four commissioners who disowned the election results also said the parties should seek resolution through the courts.

Businesses were open as normal in most of the country, and people in areas that voted overwhelmingly for Ruto were still in a celebratory mood.

Kenya, East Africa's richest and most stable nation, has a history of post-election bloodshed, with over 1,200 people killed in widespread violence after the 2007 presidential vote.

More than 100 people were killed after the Supreme Court overturned the

result of the last presidential election in 2017 due to anomalies in the voting

Odinga's next move

Odinga supporters have denounced Monday's result although Kisumu Governor Anyang' Nyong'o called for calm as protests in parts of the lakeside town turned violent after Ruto's victory was declared.

Makau Mutua, the head of Odinga's campaign think-tank, said officials of his Azimio La Umoja (Declaration of Unity) Alliance were discussing a course of ac-

"We are consulting among ourselves," Mutua told Reuters by phone. "It is a top line issue ... all options are on the table. No option has been ruled out at this moment."

He said the message sent by the four commissioners who disowned the results, was that "the chair of the commission does not have the authority to decide unilaterally the final results of the election".

Neither the chairman of the electoral commission, Wafula Chebukati, who declared Ruto the winner with 50.49 percent of the vote against Odinga's 48.5 percent, nor the four commissioners who disowned the results responded to a Reuters request for comment.

Ruto, the current deputy president and head of the Kenya Kwanza (Kenya First) Alliance, had appeared to be leading Odinga as Kenyans awaited final results of the election.

Once in office, he will have to confront an economic and social crisis. Poor Kenyans already reeling from the impact of COVID-19 have been hit by global rises in food and fuel prices while a devastating drought in the north has

left 4.1 million people dependent on food aid.

The 55-year-old had made Kenya's class divisions the centerpiece of his campaign to become Kenya's fifth president, promising to reward low-income "hustlers."

Anxious wait

In Kisumu, the mood was subdued, with many shops shuttered and roads dotted with large stones and marks from burned tyres.

Some residents said they were waiting for Odinga's signal.

Nancy Achieng arrived on Tuesday morning to find the wooden stall from which she sold foods at the side of the road in the Kondele neighborhood destroyed.

"I've lost the election and I've also lost my business," said Achieng, who had been selling beans, chapati and roasted maize there for two years. "I don't even know where

I'm going to get the cash from (to rebuild)." Across the road stood a supermarket with its windows broken.

Achieng said she might protest on Tuesday, depending on what sort of statement Odinga and his party made.

"We need him to speak soon ... there is a lot of anxiety," she

UK first to approve Omicron COVID shot with Moderna nod

LONDON

BRITAIN, the first country to approve a coronavirus vaccine in late 2020, has now also given the first green light to a variantadapted shot that targets both the original and Omicron version of the virus

The UK medicines regulator gave the so-called bivalent vaccine made by US drug company Moderna conditional approval as a booster for adults on Monday.

Later on Monday, the UK's Joint Committee on Vaccination and Immunisation backed the use of the variant-adapted shot in the country's booster campaign starting September.

The MHRA's Moderna decision was based on clinical trial data that showed the booster triggered "a strong immune response" against both Omicron (BA.1) and the original virus, it said. Moderna in June said trial data showed that when given as a fourth dose, the variant-adapted shot raised virus-neutralizing antibodies by eight-fold against Omicron.

The MHRA also cited an exploratory analysis in which the shot was found to generate a "good immune response" against the currently dominant Omicron offshoots BA.4 and BA.5.

According to Moderna, trial data showed its variant-adapted booster generated virus-neutralizing antibody levels against the subvariants that were 1.69 times higher than those given the original booster.

However, the correlation between neutralizing antibody levels and vaccine effectiveness against disease - in particular severe disease - remains unclear. No serious safety concerns were identified with the new Moderna formulation, the MHRA added on Monday. While existing COVID-19 vaccines continue to provide good protection against hospital

admissions and death, vaccine effectiveness has taken a hit as the virus has evolved.

"What this bivalent vaccine gives us is a sharpened tool in our armoury to help protect us against this disease as the virus continues to evolve," MHRA Chief Executive June Raine said in a statement

However, the virus is unlikely to stand still and Omicron-targeted immunity might push the virus down other evolutionary paths, added Jonathan Ball, professor of molecular virology at the University of Nottingham. European Medicines Agency officials expect COVID variantadapted vaccines to be approved in the European Union by September, and have signalled the regulator is open to using shots targeting the older BA.1 variant this autumn, given those specifically targeting newer subvariants are further behind in clinical de-

Ethiopia inaugurates Chinese-built major road project in capital

ETHIOPIA on Monday inaugurated a Chinese-built major road project in the capital Addis Ababa.

The Alexander Pushkin Square-Gotera Interchange Road Project, which is a 3.8 km road that incorporates three segments and construction of a two-lane 320 meters tunnel, was contracted by China First Highway Engineering Co., LTD (CFHEC). Adanech Abiebie, Addis Ababa city Mayor, said during the road project inauguration that the project is a manifestation of Ethiopia's commitment and dedication to undertake vital development projects in a short period of time with higher quality.

"This road project, in addition to setting a good example of an excellent road project execution for the city and our country, will also tremendously improve the traffic flow in this highly congested part of the city," Abiebie said.

"We would like to appreciate the Chinese people and government for this magnificent project, both in terms of financing and executing the project," the mayor added. She further emphasized that the newly inaugurated road project not only alleviated the traffic flow across its surroundings but also added another aesthetic to the

Culture of 'Gypsies of the sea' well protected in China's Hainan province

THEY live on junks and boats. They build boat dwellings and make a living by fishing. They are the Tanka people, also known as the "gypsies of the sea."

The Tanka people are Han Chinese. Living on seawater for generations, they have developed unique customs different from those on land, such as wedding ceremonies hosted on the water and Tanka ditties, a type of short simple song that expresses the emotions of the Tanka people.

In Xincun township of Lingshui Li autonomous county in the southernmost province of Hainan, there are several "floating villages" inhabited by the Tanka people. At present, the township is home to 456 seafood farms and 1,475 junks. There are over 5,000 Tankas living and working on the sea in the township.

At the port of Xincun township, rows of houseboats are floating by the shore, and beyond them are many seafood farms, which are made of net cages. These houseboats and seafood farms, adjacent to each other, form a broad "floating village."

As small as these houseboats are, they have everything from living rooms and bedrooms to kitchens and bathrooms. They offer a place for fishermen to rest after spending a tiring day on the sea.

To better facilitate transportation in the floating village, the Tanka people invented "taxi boats" that shuttle between seafood farms and the port, and the taxi boats are

students and tourists.

The Tanka people living at the Xincun port pursue their traditional livelihood of fishing. Fishermen go fishing at dawn and return to the port just hours later to sell their harvests, while their family members staying at home sort the catches, wash seafood farms and weave fishing nets.

The Tanka people always sing the Tanka ditties, or the "salt-water songs," one of the most known types of folk music in Hainan province. The ditties carry the memories and express the emotions of the Tanka community.

To protect and inherit the Tanka culture and make it into a cultural industry, Lingshui Li

great efforts to restore the marine ecology and encourage fishermen to move onshore, as well as develop deepwater fishery and seaside leisure businesses. The county, combining culture and tourism, is striving for both ecological and economic benefits.

Cleaning the polluted seawater and tidying up the seafood farms, the Xincun port has gone through drastic changes and is embracing an increasing number of visitors.

A museum of Tanka culture is currently under construction and B&Bs with Tanka characteristics are also developing. It is reported that the museum, together with other tourist attractions in Hainan, frequently taken by villagers, autonomous county has taken such as the Nanwan Monkey

Island and the Xinying Mangrove National Wetland Park, will jointly form a network that promotes local tourism clusters and enhances regional economic strength.

Shen Xiaoming, Party chief of Hainan, said during an inspection tour to Lingshui Li autonomous county that the autonomous county should shoulder the responsibility of protecting and developing the Tanka culture and develop new business models centering on the characteristics of the Tanka community.

According to him, Lingshui Li autonomous county will develop a series of tourism projects to better inherit and protect the Tanka culture.

Russian military commanders strictly follow Geneva conventions, Shoigu says

THE observance of the Geneva conventions during the Russian special operation in Ukraine is the priority for Russian Army's commanders at all levels, Russian Defense Minister Sergey Shoigu said yesterday.

"I would like to separately speak about the humanitarian aspects of the special military operation," Shoigu said speaking at the 10th Moscow Conference on International Security. "The observance of the Geneva conventions on the rules of warfare in the focus of commanders at all lev-

"Since the launch of the operation relevant orders were issued stipulating the guidelines for military personnel's conduct in regard to civilians and enemy's prisoners," he

According to Shoigu, Russian troops are actively involved in deliveries of humanitarian cargo to the liberated

territories, in the restoration of the infrastructure and maintenance of the public order.

"This is how it was in Syria, in Nagorno Karabakh and this is how is now in Donbass," the minister stat-

Shoigu also said that the ministry is very grateful to the United Nations and The International Committee of the Red Cross (ICRC) for their constructive and depoliticized cooperation in regard to the humanitarian aid deliveries during the special military operation.

The situation along the line of engagement in Donbass escalated on February 17. The Donetsk and Lugansk People's Republics (DPR and LPR) reported the most massive bombardments by the Ukrainian military in recent months, which damaged civilian infrastructure and caused civilian

On February 21, President Vladimir Putin announced that Moscow was recognizing the sovereignty of the Donetsk and Lugansk People's Republics. Russia signed agreements on friendship, cooperation and mutual assistance with their leaders. Moscow recognized the Donbass republics in accordance with the DPR and LPR constitutions within the boundaries of the Donetsk and Lugansk regions as of the beginning of 2014.

Russian President Putin announced on February 24 that in response to a request by the heads of the Donbass republics for assistance he had made a decision to carry out a special military operation in Ukraine. The Russian leader stressed that Moscow had no plans of occupying Ukrainian territories, noting that the operation was aimed at the denazification and demilitarization of

The DPR and the LPR launched an operation to liberate their territories under Kiev's control.

Ten Hag discovering the mess he has inherited at Man United

MAYBE Ralf Rangnick was right, after all. Maybe Manchester United does require soccer's equivalent of "open-heart surgery" to fix the glut of issues currently afflicting England's biggest club.

That was the blunt assessment offered in April by Rangnick, United's interim manager at the time, as he prepared to hand over the coaching reins to Erik ten Hag ahead of this season.

And it's taken just two painful Premier League games for Ten Hag to understand quite the mess he has joined.

Underperforming and – in certain cases unmotivated players. An imbalanced, poorly assembled squad. A faltering recruitment team unable to bring in its primary targets. American owners increasingly loathed by the fans.

Ten Hag, meanwhile, is adding to his own problems with some questionable decision-making in his first weeks in English soccer.

"Rubbish" was one of the words the Dutchman used to describe United's abvsmal performance in its 4-0 loss at Brentford on Saturday that marked a new low point in the club's recent history.

Moments after the final whistle at Brentford Community Stadium, as the joyous home fans celebrated one of their team's best ever results. Ten Hag was seen standing motionless on the touchline, both arms behind his back, unable to believe what had transpired.

Ten Hag didn't flinch as a moody-looking Cristiano Ronaldo walked past, or as he was serenaded with chants of "You're getting sacked in the morning" from Brentford supporters.

Sunday was supposed to be a day off for United's players but Ten Hag insisted they come in for training, with British broadcaster Sky Sports reporting that the manager wanted to make his players run 13.8 kilometers, matching the difference in total distance the two teams ran during Saturday's match.

These are still very early days in the Ten Hag era but the problems are mounting, some of them of the Dutchman's making.

"Obviously we always want to win our games and especially at home," Liverpool midfielder James Milner said after the match. "I thought we started pretty well and then we lost our way a bit in the middle. They've obviously got quality, they're always going to cause you problems on the break, which we could have defended better.'

The result leaves Liverpool in 12th place on two points from their first two matches, four behind leaders Manchester City, while Palace sit in 16th with a single point.

Why Premier League would be foolish to ban Tuchel, Conte for full-time feud

WATCHING Antonio Conte and Thomas Tuchel square off at the final whistle following Chelsea's 2-2 draw with Spurs on Sunday, the mind went back to another handshake gone bad involving Conte at Stamford Bridge.

It was October 2016 and Conte was in charge of Chelsea, who had just thrashed Jose Mourinho's Manchester United 4-0. Like on Sunday, Conte was looking for a quick shake of the hands, nothing more, and like on Sunday, the opposing manager wouldn't let go until he had given him a piece of his mind. Mourinho told Conte, who had celebrated long and hard after each goal, that it was inappropriate to behave like this after such a big victory -- advice of the "act like you've been there before" variety.

Unlike on Sunday, Conte simply looked nonplussed and a little confused. But it was the first spark in a what would turn into a nasty, needling feud that would degenerate into Mourinho saying he "did not need to act like a clown" on the sideline, Conte suggesting his rival was suffering from "senile dementia" (Chelsea would later suggest he meant "amnesia" instead), Mourinho referring to Conte's fourmonth ban for failure to report match-fixing (even though he was later acquitted) and Conte saying Mourinho was "a small, small man."

That felt like real aggro -- genuine bile between two men who don't like each other. In wrestling parlance, this was no work, but a genuine shoot.

Tuchel and Conte? Not so much, which is why it would be silly if the Premier League were to follow up with a touchline ban after both men were sent off. It's not as if their anger at the final whistle wasn't real, because it was; it's just that this is unlikely to devolve into anything like the Conte-Mourinho feud. It came and it went. These two guys are too laser-focused and not calculating enough to play mind games via the media or mess with each other's heads. They are more alike than they care to admit.

Willian's exit from Corinthians due to threats, online abuse should be a lesson for Brazilian football

AFTER an admittedly disappointing spell with Arsenal, Brazilian winger Willian had a romantic idea of going back home and joining Corinthians, the Sao Paulo club where he developed before heading to Europe in 2007. His time back home was not an unmitigated disaster on the field. He probably expected to score more than one goal. Injuries did not help. But he had his moments and Corinthians, while never brilliant, have at least been solid.

But it is all over. Willian (pictured) had a contract until the end of next year. But last week he ripped it up. He will not be back, he said. Not with Corinthians, or with any other club in his native country. He hopes to return to London, where he has been linked with Fulham.

The priority, though, is to find a new club outside of Brazil -- and the sincerity with which he is dealing with the subject is both entirely positive and a warning to Brazilian football.

"I'm leaving because of the threats that I and mainly my family suffered," he told Globo Esporte last week. "The threats never stopped. Whenever Corinthians lost, and if I hadn't played well, my family would receive threats and curses on social media. It happened to my wife, my daughter, and after a while they started attacking my father and my sister.

"I didn't come to Brazil to be threatened or to have my family threatened. It caused a big impact and a mental cost, especially on my daughters."

He was by no means the only player in his team to suffer this kind of treatment. But in his case there is an important difference. He was away for 15 years. Coming back quickly for holidays is one thing. Returning to play for a big fclub like Corinthians is quite



another.

The country he left in 2007 is not the one he went home to in 2022. While he was making his name at European clubs Shakhtar Donetsk. Chelsea and Arsenal, social media was making its presence felt.

The problem here is the space and the impact that social media gives to certain fans who mistake online abuse and criticism for passion. All too often, conventional media also finds its agenda driven by this type of interaction -- the spectacle means nothing, the result is the "be all and end all." The force of passion, its potential dangers ignored, becomes seen as a virtue in itself.

For this reason, one of Willian's observations is especially important.

"The situation is becoming normalised," he said, "and agressions are being romanticised."

An absence of a decade and a half gave Willian perspective. Threats and aggressions were unacceptable, and in his time with Corinthians he would go down to the police station to register complaints. But like frogs slowly being boiled in water, too many in Brazilian football have become accustomed to the rising temperature in which the game is being played and watched, and excesses of anger have come to be seen as unremarkable expressions of the passion that keeps the circus on the road.

And it is not just words. Teams are being attacked by fans on the way to the stadium, including by their own supporters. They are being attacked by their own fans at airports after flying back from a disappointing game. They are being attacked by their own fans at the training ground.

Kagera Sugar has been a tricky opponent for Azam FC in recent seasons, the latter have lost two of their last five matches against

Last season Kagera Sugar claimed a 1-0 home win in Bukoba, while the return game ended in a thrilling 0-0 draw at Azam Complex Stadium.

Last season was a disaster at Azam Complex Stadium, but Azam FC did ultimately secure CAF Confederation Cup qualification on the final day of the campaign.

Ahead of his first full campaign in charge, Azam FC head coach Abdihamid Moallin called for decisive action in the transfer mar-

There has been a flurry of transfer activity at Azam FC and a person would expect them to start the new campaign with high hopes. Azam FC will be pleased with what they have done so far in the window, nine arrivals, couple these signings with a series of departures, and the squad is going to look very different in the 2022/23

Azam FC has built up a lot of expectations for the coming season, given the number of players they have recruited and the upgraded technical bench at the helm, the onus is on the team to mount a credible title challenge and Kagera Sugar will be their first test of the season.

The official noted: "The team is gelling together on the pitch with every passing day. We don't know what Kagera Sugar is, we don't know what to expect, what changes they have made while they have watched us and have a better chance to analyze and prepare to battle against us... we have to work to do against them.

Zakaria said: "However football is about two things, one is making sure your opponent does not score more goals than you and the second is not conceding more than your opponent."

In his second over, Adersh Dileep of Alliance Caravans consumed Kamania by having him caught and bowled for just one run with the team score at six runs.

Riken Patel drove straight to Jitin Pratap Singh from the bowling of Suraj Kumar when the team score was 18 runs.

He could not score in double digits and due to some excellent and economic bowling, batsmen who followed too could not score freely.
