Samia extolls borrowing in **SGR Phase III** ning event

PRESIDENT Samia Suluhu Hassan yesterday defended the government's borrowing trend saying it was the only way to fast track development insisting that she will seek more concessional loans for infrastructure projects.

At a signing ceremony for contracts to build the 294-kilometer section of the Standard Gauge Railway (SGR) from Makutupora to Tabora, the president said she will use

every means including borrowing to ensure strategic projects started by her predecessor are completed.

"I have noticed there are efforts to discourage us from loans. Even developed countries borrowed and managed to do what they have done. We cannot use levies to carry out huge projects like SGR; it will take time so we will borrow," she affirmed.

The government was pursuing all in its

UNESCO marks semi-centennial anniversary of biosphere preservation

The UN cultural agency commemorated on Monday the 50th anniversary of its Man and the Biosphere Programme (MAB), which created in 1971, has been promoting a long-lasting connection between people and nature.

"This is really a programme for the people, because people are part of nature...so they are incorporated in nature protection, but also in the sustainable use of natural resources," was the landmark declaration by the United Nations Educational, Scientific and Cultural Organisation's (UNESCO) in a statement at its Geneva headquarters yesterday.

Miguel Clusener Godt, Secretary for the Man And the Biosphere (MAB) programme at the UN Agency, an intergovernmental scientific programme that aims to establish a scientific basis for enhancing the relationship between people and the living environment as a whole, made this assertion in marking 50 years of global activity anchored in this programme.

"Today 727 biosphere reserves integrate nature conservation and sustainable development in 131 countries, including 22 transboundary sites," he stated, noting that in Africa there are 86 sites in 31 countries. Arab States harbour 35 sites in 14 countries; Asia and the Pacific having 168 sites in 40 countries. Europe and North America have 306 sites in 24 countries; and 132 sites are located in 24

Sitting in the '45 Minutes' interview programme aired on ITV at the weekend, IGP Sirro said this year criminal and road traffic offences dropped by 3.5 and 14 per cent respectively compared to last year, crediting achievements made possible by collaboration between the police and other defence and security organs, along with numerous law abiding citizens.

In the Kibiti Special Police Region faced incidents in recent years that have not recurred, he pointed out; underlining that Tanzania isn't quite an island of peace. "We still have work to do as peace has to be propped up jointly, as once you release the pressure, people grab the opportunity to commit crime," the police chief intoned.

"In the past, if you go a bank and withdraw say 40,000/- you become restless as you walk in the streets, but now we are going on well. I congratulate all good citizens, as there are others who hate us because of their bad deeds, but my job is to stand by the law," he affirmed.

If police officers are seen violating the laws by engaging in criminal activities, citizens should report on them to any government offices for stern measures to be taken against them, he urged.

He remarked that in community policing, local councils have issued bylaws to organise those activities, asserting that every Tanzanian has the responsibility,

producers can only bring up 88.5m chicks annually.

The decision comes a few months after easing importation permits for importers of day old chicks, as part of long-term plans of the Ministry of Livestock and Fisheries to uplift the poultry subsector.

Grandparent stock that can be used to produce either hatching eggs or chicks are targeted in the liberalization exercise, as despite government efforts to ease importation, those imported and the local producers failed to meet current levels of demand, he stated.

He said Tanzania just like other countries in the region faces similar challenges posed by the pandemic, causing a mismatch between demand and supply of day

Once global poultry breeder companies open branches in the country, it will be easy to produce hatching eggs for producing chicks, the director noted, underlining that grandparent stock companies need to open branches in the country.

That will make it easier to access male and female parents' line, as the eggs produce yield chicks for domestic needs and even for export, he said, elaborating that the targeted companies have opened branches in Egypt, South Africa, Ethiopia and Nigeria, among others.

> Statistics indicate that the poultry subsector registered around five percent growth per annum in recent years, while Tanzania is currently estimated to have 87.7m chicken, where 40.36m are indigenous fowls and 47.34m are exotic types.

The livestock sector makes up 7.1 percent of the Gross Domestic Product (GDP), with poultry accounting for 1.9 percent of GDP, on the basis of a study titled: "The Poultry Subsector in Tanzania: A Quick Scan" commissioned by the Netherlands embassy.

It was prepared by Matchmaker Associates and Transcend Enterprises, showing that the potential of the poultry sector investments to revamp the sector and related industries.

Despite availability of ample land for growing grains and soya to provide enough raw materials for chicken feeds, the commercialization of the poultry sector is lagging, the study noted, blaming unorganized markets for poultry and poultry products.

It also pointed at unreliable supply of chicks, lack of reliable supply of quality poultry feeds, high veterinary and poultry feed costs and lack of poultry processing industries.

A chaotic and unorganized distribution system and lack of thirdparty logistic cold chain for poultry and poultry products' movements from farm to consumers affects the growth of the industry, the study added.

means to finalise strategic projects timely as failing to do means the money already used on the projects will have been wasted, she declared, reiterating the necessity to borrow as financial markets are everywhere essential for development.

"We are taking concessional loans because they take time to be repaid and we are doing so to fast track development and repay little by little," the president explained, noting that the Standard Gauge Railway (SGR) and other strategic projects will be finalised by loans and not levies as suggested by some people.

"Loans are important. It depends on how you spend them; they can be bad if you misuse them," she said, highlighting that the government has already invested 14trn/- in the project, expressing intent to see all sections of the projected completed in a timely manner.

Three other members of the East African Community (EAC) are set to engage the African Development Bank (AfDB in talks to secure loans for extending SGR to their borders for a more expeditious import and export link, she stated.

Completing the railway sets up a

good foundation for infrastructural development as a whole and the movement of goods and services, she elaborated, pointing at the need to ensure that all strategic projects initiated under the fifth phase government are duly implemented.

For his part, the Tanzania Railways Corporation (TRC) managing director Masanja Kadogosa said the signing of contracts for the Makutupora -Tabora was the third component of the Dar es Salaam-Mwanza SGR route.

The first phase is the Dar es Salaam- Morogoro which is now 95-percent complete, the Morogoro-Makutupora portion which is now 75-percent complete and the newly signed Makutupora -Tabora part, after which the Tabora -Mwanza portion will follow.

The project is worth 14trn/-in total and next month the government will sign contracts for starting work on the Tabora - Mwanza section which is now in the tendering stage, Kadogosa added.

If bioreserves worldwide were to be put together, they would be equivalent to about five per cent of the world's surface, spanning 6,812,000 km² or "around the size of

Examples of this activity include the diverse vegetation and unique fauna in Tanzania's Gombe Masito Ugalla Biosphere Reserve, the principal chimpanzee sanctuary in the country, tied with Gombe National Park, forest land reserves and a part of Lake Tanganyika, the statement noted.

Faunal species in the area include elephants, ornate frogs and eight primate species, while flora there includes a species discovered in the location and thus named Gombe. The biodiversity of Lake Tanganyika encompasses over 300 fish species, 250 bird species, and reptiles such as the water cobra and the Tanganyika

The Maolan in China was listed as a biosphere reserve in 1996, lying in the Qiannan Buyi and Miao Autonomous Prefecture in Guizhou Province and covering an area of 20,000 hectares, with the forest coverage of 88.61 per cent.

Renowned for its "hugging trees" which cling tenaciously to the rocks of the mountain landscape, the rich biodiversity also includes pheasants, orchids and magnolias. The local Yao, Buyi and Shui

indigenous peoples value their region's environment and cohabit harmoniously with nature. As the trees provide them with vital resources, for over 1,000 years local communities have performed ceremonial practices and rituals to care for the trees.

Located on the western slopes of the Mount Lebanon range and overlooking the Mediterranean Sea, the 6,500-hectare biosphere reserve of Jabal Moussa encompasses the

'Mount of Moses' - an important site to Christian pilgrims - and its seven villages.

Moussa's landscape, Iabal preserved through the centuries, conceals the markings of a region at the meeting point of civilizations, which archaeologists are still unearthing.

Only 40 km to the north-east of Beirut, the biosphere reserve is three times as large as the city, and together with the Shouf and Jabal Rihane biosphere reserves forms an ecological corridor running along Lebanon's mountainous backbone.

Located in south-east Uruguay, Bañados del Este harbours a remarkable complex of ecosystems, including white sand beaches, dunes and lagoons along the Atlantic coast and is home to diverse wildlife that remains almost intact both on land and at sea.

The biosphere reserve covers 12,500 km² of Uruguay's eastern coast and is also home to the state's highest summit, Cerro Cathedral in

Hidden among the dunes, this tourist destination is among the most popular in the biosphere reserve and the perfect spot to connect with nature. Due to its remoteness, there is no connection to the local grid or landlines, but the local population is able to access mobile networks and

In Spain, transitioning to clean energy at the El Hierro Biosphere Reserve exemplifies ongoing efforts to live in harmony with nature.

The biosphere reserve covers the entire island and some of its waters, with 60 per cent of the island integrated into the core zone and buffer areas.

El Hierro is aiming to produce 100 per cent of its electricity from renewables, meanwhile as at least 2,604 species of flora and fauna have been recorded on the island, and the reserve is a safe-haven for species of friendly sea-faring mammals, the statement added.



Police arrest teenager on suspicion of murder

POLICE in Mbeya Region has arrested a teenager and three others on the hunt for suspicion of murder in three separate incidents in the region.

Regional Police Commander, Senior Assistant Commissioner of Police, Ulrich Matei identified the suspect as Masele Lige (30) a resident of Jerome village in Chunya district.

He said the young man who is a gold miner in the village is accused of killing his fellow miner, Mhojamadale Mihambo (30) and that the source of the killings was a food fight.

RPC Matei said the murder took place on December 24 this year at around 12:30 am when the suspect in collaboration with a colleague who has the same name as Clement continuing to question Lige and that killed Mihambo by stabbing him.

"It is alleged that the suspects were accusing the deceased of not providing food, but he was only eating the food of others. Clement escaped after carrying out the killing," said Commander Matei.

More wagons increased to transport passengers - TRC

TANZANIA Railways Corporation (TRC) has increased the number of passenger's wagons from 10 to 20 to meet customer demand traveling to and from the northern regions during Christmas and New Year festivals.

TRC acting operation manager Fokasi Sahani told reporters in Dar es Salaam that the increase in number of passengers had been recorded for the first time compared to previous years.

Sahani said TRC has also increased the number of scheduled routes from four to six per week to reduce congestion and meet the customers demand.

He said initially there were four scheduled routes from Dar es Salaam to Moshi and back Dar es Salaam but due to that the routes have increased to six per week.

"About 2500 passengers left for the Kilimanjaro region from Dar es salaam to celebrate Christmas and New Year festivals. We hope the same number will board a train on their way back. I would like to assure our esteemed customers that TRC will work hard to ensure they travel safely from one destination to the other," he said.

Sahani said that from January 2nd to 10th next year, more efforts will be made to transport more passengers from Arusha, Moshi back to Dar es Salaam. He said unlike in buses, the cost by

train from Dar es Salaam to Moshi was 16,500/- to enable all people to "Traveling using the train is

best since it is not only a matter of traveling but a part of tourism via Sadani national park," he added. For his part, Ringo Mbona,

Passengers' train manager said that the aim of increasing the number of wagons was to solve transport challenges during high season. He said TRC will increase the

number of wagons and routes when needed to do especially during high seasons.

customers enjoy services offered by our train," he added.

On October 04, last year, Arusha residents were treated to a rare spectacle after the arrival of the passenger train as part of its maiden trip to Arusha.

The historical trip brought more than 600 passengers to the region, who left from Dar es Salaam station.

The Tanzania Railway Company (TRC) Director General Masanja Kadogosa said that the train will be plying between Arusha and Dar es Salaam, four times a week.

"If need be, we will increase the number of routes between the two regions taking into account that we are approaching high season," he

He, however, urged Arusha residents to make the most of the train, saying the state-owned company had slashed down its fares to enable Tanzanians to capitalize on the once-in-a-lifetime opportunity.

Police arrest 51 Ethiopian, Sudanese for illegal entry

POLICE in Dodoma have arrested 51 Ethiopian illegal immigrants at Bereko area in Kondoa district following information from wellwishers on 27th December, 2021.

Speaking to journalists yesterday, Dodoma Regional Police Commander, Onesmo Lyanga said the migrants were under escort of two Tanzanians who were also

He explained that police on patrol at the Dodoma-Arusha highway while travelling in Canter, Fuso model with registration number T.593 AUE driven by one Ignas S/O Mgosi (23), resident of Mafinga-Iringa, assisted by Fafari S/O Idd (39), resident of Arusha.

"We got information about the group of people from well-wishers, laid a trap and finally arrested them at Bereko area in Dodoma region" said the RPC.

He said their hosts put them inside a lorry, covering them with boxes in effort to deceive officers that the lorry had boxes for carrying tomatoes, adding that they were travelling from Moshi- Kilimanjaro to Iringa.

The regional police boss added that such activities are driven by lack of patriotism and greed for money, making Tanzanians engage in human trafficking, a global crime.

He said the police is in the region is keenly investigating and closely following up on the whole network of those involved in the crime, adding that their information is available already.

The RPC noted that police in the region is vigilant at this festive season as the nation moves towards New Year celebrations.

Dodoma Regional Immigration Officer, Adam Mkuya while speaking at the same press

conference noted that according to Immigration Act 2005, penalty for illegal immigration is 500,000/- or six months' imprisonment.

He explained that anybody found guilty of transporting illegal immigrants faces a 20m/- fine, twenty years in jail or both penalties. "I urge all residents of the region

to be watchful for illegal immigrants that are increasingly becoming a major problem in the region" said, urging them to report any of such cases when realized.

He said it is the responsibility of every member of the public to be watchful on illegal businesses like human trafficking, among others, adding that immigration department in the region in collaboration with other security forces is on the watch out.

The acting regional immigration officer noted that Tanzania does not reject visitors, however warned that any one visiting the country should follow legal processes.

Dodoma region continues with strategies against Covid disease

DODOMA Region continues to take measures against Covid-19 including making sure the ready availability of medicines, medical devices and oxygen cylinders at health centres.

The remarks were made here on Monday by Dodoma Regional Medical Officer, Dr Best Magoma to the Regional Consultative Committee sitting.

Dr Magoma said other strategies include directives to the region's local councils and zonal hospitals to take precautions against Covid-19 infections at health provision centres include the washing of hands with soap and running water, use of sanitizers and wearing of masks.

"Local councils are directed to enhance supervision in the implementation of measures against

washing of hands with soap and running water, use of sanitizers and wearing of masks at all public places and institutions including schools, markets and avoid unnecessary congestion of people," said Dr

Regarding Covid-19 vaccination, he said the Region received a total of 50,000 doses on August 3 this year and the region launched vaccination campaign and by October 5, all the doses were used up.

"In the circumstances, the Region requested for more doses of the vaccine from regions where the vaccination drive was low, whereby Geita Region supplied us with 5,000 doses and Iringa 1,515 doses," he added.

He further said by October 2021 52,599 people received Jansen Jansen shots.

He added that the Region received

infectious diseases including the 50,390 Sinopharm doses to continue with the vaccination exercise.

"The vaccination exercise is so far as follows: In Dodoma City 17,831 people have been vaccinated against Covid-19, Chamwino District 6,767, Kongwa 5,554, Kondoa 5,472 ,Mpwapwa4,869 ,Chemba 4,389,Bahi 4379 and KondoaTown 3,338," said Dr Magoma.

Regarding nutrition, Dr Magoma said Dodoma Region is among the regions with high malnutrition rate especially on women at pregnancy age and children under five years of

"Statistics show that Dodoma has 37.2 per cent of children with stunting problems despite efforts by the government in collaboration with various stakeholders on nutrition, the problem is still grave hence more efforts are needed," stressed Dr Magoma.

Arusha DC inaugurates 105 school classrooms

ARUSHA District Commissioner, Said Mtanda, has inaugurated 105 classrooms, built with funds from the Tanzania COVID-19 socioeconomic response plan (TCRP) programme worth 2.1bn/-.

Inaugurating the classrooms, at Themi secondary school in Arusha, Mtanda, said 89 classrooms have been completed, 16 upper classrooms (for storey apartment) are nearing completion and before the first month of the year they will be completed.

He said in order to be successful in the education sector the people must stick to their government.

Mtanda also called on all leaders to be united in their work to bring development to the people.

"Let's go and work, if some money comes in we will work together again to address the shortage of desks if 1000 desks, we have made it in all secondary schools in Arusha City and 800 in primary schools, let's not let gossip, lies, intrigue mean nothing," he said.

Mtanda said he could not be the District Commissioner to listen to the words or the words, but to work together to build the country and the district with the aim of bringing development.

"When citizens come to government offices they know their rights, including the reception of humility, the hearing of their grievances and the resolution of grievances and not otherwise, let us go and serve the people properly,"

Arusha City Council Director Dr John Pima, said the construction of 105 classrooms was in line with the construction of 5,250 desks which are all 100% complete, with the exception of the 16 upper classrooms which are in the process of being completed.

He thanked President Samia Suluhu Hassan, as all students selected to join the first form in 2022 for Arusha City all have seats and each class is expected to accommodate 45 to 48 students, with the government's expectation of 50 students per class.

"There will not be any nuisance of classrooms in our city because 105 classrooms that did not exist at all are many in addition to those left by Form Four graduates,' said Dr. Pima.

However he said education in the city, is growing as teachers provide better education for students and in a friendly learning environment, so they believe they will continue to do better in the education sector

Dr. Pima said the presence of these desks, will help eliminate the problem of preventing first form students from entering the classroom as those who are required to enter the classroom will enter after the school opens.

City council's Secondary Education Officer, Valentine Makuke, said the launch of the classes would eliminate the backlog of 11,223 students, who have successfully completed Form One and all need 223 rooms already.

"We will have five additional rooms as we have 228 rooms in addition to those left by Form Four graduates this year, which will facilitate the performance of teachers, students and ultimately improve performance," Makuke.

Arusha city mayor, Maxmillian Iranqhe, said the city of Arusha is still facing a shortage of teachers, so he asked the district commissioner to resolve the issue, so that students can get a better education and bring development to the community.

He said the City of Arusha; they have planned to be the first in everything, to bring development, if in education they have been rising every year.

"As a result of the construction of these classrooms the children will study better and understand, the performance will increase further," said Iranqhe.



MORE than 3,000 girls between the ages of 10 and 19 in Iringa Region have been identified with pregnancy for the period from January to October 2021.

The national coordinator for reproductive health and gender from the Ministry of Health, Community Development, Gender, Elderly and Children, Gerald Kiwhele unveiled this when speaking yesterday at the launch of the National Accelerated Action and Investment Agenda for Adolescent Health and Well Being. He said that the challenge has been increasing the burden of upbringing for these girls in return

for their efforts to secure education. Kiwhele noted that the challenge of early pregnancy in Iringa region was huge, a situation that the government had to deal with in collaboration with various stakeholders to come up with a lasting solution to that challenge.

He said that in the statistics conducted by the government for 3,000 girls in Iringa got pregnancy between January, October this year the period January to October 2021 problem of teenage pregnancies keeping boys and girls in school and

they found that there are more than 3000 girls pregnant in Iringa region which is an indication that the challenge of early pregnancy is huge in the region.

Kiwhele added that due to the growing challenge of early pregnancy the government has come up with a permanent strategy for the national investment agenda for youth development and health.

The Ministry for Health in collaboration with Iringa Region has rolled out and disseminated the agenda at the regional and district level the National Accelerated Action and Investment Agenda for Adolescent Health and Well Being (2021 / 22- 2024/2025) with the facilitation of SOS Children's Villages Tanzania.

Victor Mwaipungu, project manager for children with children (CwC) Iringa region, which is being implemented by SOS Children's Villages Tanzania, said that the violence, improving nutrition,

in Iringa region is serious and that is why they have come up with the girls' project being implemented in 19 out of 106 wards of all of Iringa region.

He said that before starting the project in the region they had identified more than 600 girls with children from 19 wards of the project.

Mwaipungu said the National Accelerated Action and Investment Agenda for Adolescent Health and Well Being (NAIA-AHW 2021 / 22-2024/2025) launched by Prime Minister Kassim Majaliwa Kassim on 17/04/2021, is in line with the objectives of their CwC project. National Accelerated Action and Investment Agenda for Adolescent Health and Well Being (2021 22- 2024/2025) covers six pillars including preventing HIV, preventing teenage pregnancies, preventing physical, sexual and emotional

developing skills from meaningful economic opportunities.

Rural Bangladesh saw 22pct increase in food insecurity during pandemic - IFPRI

AROUND 22.3 percent more rural Bangladeshi households reported food insecurity -- 18 months after the onset of the Covid-19 pandemic than prepandemic times, according to a survey by International Food Policy Research Institute (IFPRI).

In the pre-pandemic period, 54.3 percent of rural households -- surveyed

secure, whereas during September-October of 2021, that percentage stood at 32, states the report.

The report is the result of IFPRI and Cornell University's three rounds of socioeconomic phone surveys in rural areas of Bangladesh in June 2020, January 2021, and September-October

in the study sample -- were fully food- 2021. The surveys were conducted in order to document the experiences of Bangladeshi households during the Covid-19 pandemic.

> The proportion of the households reporting any food insecurity (mild, moderate or severe) increased from the pre-pandemic average of 45.7 percent to 87.8 percent in June 2020. It declined to 70.9 percent in January 2021 and 68 percent in September-October 2021.

The surveyors benchmarked the collected data against data from the Bangladesh Integrated Household Survey (BIHS), a national-level rural survey collected through in-person interviews in 2018-2019.

For this analysis, a sample of 1,951 rural households was interviewed across all

Dimensions of food insecurity including consuming less diverse diets, unable to eat healthy or nutritious food, and above all, worried about not having enough food increased dramatically at the start of the pandemic and have remained elevated, the report added.

The campaign is being carried out in Haut-Lomami, South Kivu and Tanganyika provinces-the most affected by cholera since August–and will cover 13 health zones with about 4 million doses delivered by the Global Task Force on Cholera Control. World Health Organization (WHO), United Nations Children's Fund and other partners are supporting the health authorities to roll out the campaign. Gavi, the Vaccine Alliance, provided

Around 3600 health workers including vaccinators and community mobilizers have been deployed to carry out the campaign which will run for six days. Since the start of the year, the Democratic Republic of the Congo has reported at total of 8279 suspected cholera cases and 153 deaths in 16 of the country's 26 provinces.

"Cholera is a dangerous infection that can kill within hours if untreated, but it is predictable and preventable. In addition to the vaccines, which are one of the effective measures against the disease, it's also very important to provide clean water and to reinforce hygiene and sanitation in order to prevent the outbreak from spreading further," said Dr Amédée Prosper Djiguimdé, WHO Officer in Charge in the Democratic Republic of

The ongoing vaccination is the second massive campaign in the country this year. In March and July, more than 1.4 million people were vaccinated against cholera in Haut-Katanga province in the south-east of the country.

Cholera is a highly contagious disease transmitted through contaminated water or food. It causes severe diarrhea and dehydration that must be treated immediately to prevent death, which can occur in just a few hours, and to prevent the disease from spreading on a large scale in a high-risk environment.

Disease surveillance, improved water, sanitation, and hygiene services as well as early detection, treatment and vaccines are crucial in preventing cholera and containing infection spread. Coverage with a full tworound dose of oral cholera vaccine provides up to a fiveyear protection.

All eggs in one basket in the free electoral **Commission and new** constitution debate

President Samia around. Suluhu Hassan moved to take note of some of the proposals or demands of human rights activists and political parties with a new appointment to the country's electoral commission, a good part of the stakeholders' fraternity was scarcely paying attention. They were engaged in what at a preliminary level is a fruitless debate as to whether the country needs a free electoral commission first and then a new constitution, or vice versa. The pundits seem to be agreed about a new constitution, and also a free polls commission; the issue is which begets the other - and in that regard, it is expected that the government (or in this case really, the state) will do the bidding of the debate's outcome.

Those who remember the way in which the 2014 Constituent Assembly was organised might remember that the exercise started from nearly that same format, where the issue of a free electoral commission wasn't primary but a new constitution. Activists saw issues in terms of organising a large conference of stakeholders where the ruling party would be just another interested party, same for the legislature, etc. Only when they formally convened at the Nkrumah Hall of the University of Dar es Salaam did reality start dawning on the majority of them, that a constitution is painfully negotiated, not proclaimed by an assembly of non-governmental organisations with ruling party representation,

are some variations between that period and the present period, and just like at that time ministers said the country did not need a new constitution but high level voices differed, so it is this time

The difference is that the government at that time did not have clear focus on major policy and ethical issues, so it's a give and take with opposition parties was visible in various areas. Now the case for solidity of the state, cohesion of institutions and proper conduct of political activities is more acknowledged, not seeing the issue as mode, or fashion.

For one thing, the whole push for a new constitution lacks a socioeconomic agenda, and if it exists it is implicit rather than being embedded in a visible manner with what is identified as a new constitution. Similarly, the argument for a new constitution as different from constitutional amendments is wanting in the very least, and here a psychological reason is visible, that one takes a constitutional format written by a specialized assembly (like the Warioba Commission) and adopts it as it is, without having to debate point by point what needs to be altered in the 1977 Constitution. As it was the case in 2014, all these issues will come back to face legions of activists, where their simplistic outlook starts withering.

If we stick with what is current, let us hope that the revamping that the new chairman of the polls organising body will be conducting shall meet expectations of transparent polls. President Samia expressed regrets at the way nomination papers of opposition candidates were cast aside for what was said to be minor spelling mistakes in their names etc., and recently polls misconduct was rectified in Zanzibar where the MP-elect who was yet to be sworn in stood down. We may not have to admit the length and breadth of what happened in recent polls but we need to prepare to rectify this.

Night ravel feasible with vast road improvements

government to find ways of formalising night travel especially for long haul buses, as this was proscribed nearly three decades ago after a spate of highway accidents, especially at night. There are two stumbling blocks, that there are still so many accidents even without formalised night travel, and the problem of assessing if night travel will be much safer than it was the case in the past, because road conditions have improved. It is an issue which needs to be examined at some depth, and few stakeholders have ready-made answers at the moment.

In a sense, formalisation of night travel is in the same frame of policy thrust as making businesses be free to operate for 24 hours, without a special mandatory license to that effect. The late President John Magufuli was at a certain point steering policy in that direction, by an appeal to city authorities, one reason being the need to make Dar es Salaam more convenient for tourists, as they have varying preoccupations and ways of using time during an extended holiday. The idea that everyone works from nine in the morning to five in the evening is a schoolmaster formula that is often irrelevant, as people have different ways of earning their daily bread, different work and resting times, sleep levels, etc.

A singular impediment to night travel is that it is convenient for speeding, and without physical discouragement or impediments on the way, some drivers may do it excessively, aware that their passengers have every reason to wish to arrive early. While in theory an accident can occur anywhere, in practice some highway spots are known for being prone to accidents and more can be done in those areas, if the regulatory and law enforcement institutions had the right frame of mind. Traffic police too often refuse to insist on road bumps or stretched out tarmac corrugated road sections; they prefer road signs, sweet flowing speedy roads, and hidden police officers directing a speed torch at a car, as well as slapping fines.

Were it that it is regional administrations and local governments who demand night travel formalisation so speed up economic activities, they would also list road spots where prevention of accidents is important, while traffic regulators merely place road signs and collect penalties for breaching. This attitude facilitates accidents and it compels continued prohibition of night travel and troublesome breaching of the rule by some bus operators, despite those accidents are somewhat scarce. It is routine accidents in urban commotion that are more visible, with vastly improved upcountry roads.

In the past several weeks there have been stringent calls for the labeling of the marauding bandits in the Northwest and North central parts of the country as terrorists. In the past the call was restricted to some politicians in the Southeast who felt the labelling of the Indigenous People of Biafra (IPOB) as terrorists was hasty and unjustified. In recent times, however, it has spread to their counterparts in the north including other notable Nigerians.

The list includes all the 36 Speakers from the State Houses of Assembly, governors of Gombe and Katsina, along with their Kaduna State counterpart Mallam Nasir el-Rufai, who not only backed the call but also urged the National Assembly (NASS) to compel the federal government to declare a state of emergency on the security situation in the country. Both houses of the NASS have since issued their separate resolutions calling for the classification of the bandits as terrorists.

The media, too, were not left out of the fray. In their separate editorials The Guardian, Vanguard and The Punch newspapers in particular were bullish in making the same call. In its editorial published on 21st October The Punch asserted that the federal government may be constrained in its reluctance to 'officially designate' the bandits as terrorists because of America's insistence that the Super Tucano warplanes recently delivered to Nigeria should only be used against the Boko Haram terrorist group, and not what the paper called the "the so-called bandits entrenched in the forests and ungoverned areas of the North-West and North-Central regions".

The renowned Femi Falana SAN who, as expected, also joined the debate and quoted generously from the extant provisions of the Nigeria Terrorism Prevention Act in making the same call. With due respect to Falana, however, almost all the sections of the Act he cited, like the perspectives of the governors and the NASS, merely focused on the impact of the various violent acts loosely classified as "terrorism" but not the causal or motivational factors behind them which could have enhanced the quality of the debate one way or the other.

Falana and the other parties may also not be aware that although the Office of the National Security Adviser (ONSA) published the National Security Strategy (NSS) of the administration in 2019, Nigeria still has no National Security Policy (NSP) on which any robust strategy to tackle our security challenges should been predicated. Indeed, we have never had one since our

independence.

That serious flaw in our national security architecture was apparently lost on all the parties - including the NASS - who have expressed their outrage on the alarming security situation in the country. They have instead opted to snipe at the symptoms of the obvious dissonance in the nation's security system which is manifested in the frequent embarrassing security breaches have experienced nationwide.

The adoption of NSP is fundamental and should have preceded the NSS for the following reasons. When properly conceived, the policy is expected to encapsulate the basic visioning and scope of the security threats confronting the nation along with various forms of the kinetic or non-kinetic actions label. required to counter them. It will also allow for the common ownership of the nation's security threats along with their probable solutions. It confirms the often-cited cliché that a nation's security is the collective responsibility of all its citizens. But I digress, somewhat.

I also read the opinions of some scholars and religious organizations which were often laced with unhelpful bigotry and partisanship. Some drew parallels between the secessionist agitations in the Southeast and the Southwest to allege bias on the part of the federal government in its handling of the secessionist agitation of IPOB. Some even went further to include the agitations in the South-south which are driven mainly by economic deprivation into the narrative to prove the same allegation.

It never mattered that while the militancy in the South-south resulted in a peace deal - as imperfect as it may be to some stakeholders from the region; in the case of IPOB, it remains either Biafra or burst!

Also, unlike the militants in the South-south, the violence unleashed by IPOB, including the establishment of its military wing, has grown in intensity in a manner that openly challenges the legitimacy of the federal government and its capacity to guarantee the security of all Nigerians in their sphere of operations.

Regardless, the intensity of the calls was such that the federal government has found itself on the defensive. In his response to the relentless barrage, the Defence Minister has claimed the bandits were yet to be classified as terrorists because of the need to comply with due process without elaborating on what the process actually entails. That has tended to add to the confusion a trite. But either way, they all have my sympathy.

The controversial question of who can be classified as a "terrorist" and what constitutes acts of "terrorism"

has been subjects of intensive debate among criminologists, scholars and politicians globally in the past several decades.

As of 2006, there were no fewer than 109 different definitions of terrorism, while every attempt to adopt a universally accepted definition of both terms have always ended in a bewildering cul-de-sac for a variety of reasons.

For instance, in the wake of the massacre of athletes during a siege on the Munich Olympics Games Village in 1972, the United Nations (UN) unsuccessfully attempted to conjure a universal agreement for both terms but was unsuccessful because many nations from Africa, Asia and the Middle East, disagreed with the pejorative aspects of the

In their considered opinion, the West too had committed similar activities to the one perpetrated by the Palestinian group responsible for the Munich Massacre. One man's terrorist, as it is often said, could be another man's freedom fighter, depending on the context and geopolitical dynamics of the contending issues in the conflict.

Like I earlier hinted, at the core of the controversy is the contentious issue of legitimacy in the use of violence for multiple ends. The same is true for both the state and non-state actors of terrorism which all the commentators in their hasty prognosis failed to take into account. But that is a story for another day.

In the absence of a consensus among its members on what constitutes terrorism, the UN adopted 12 piecemeal conventions and protocols with the principal goal of 'criminalizing' certain acts of violence only to the extent that they are effective in the various counterterrorism initiatives of its members states. The UN General Assembly resolution 49/60 on the subject was adopted on the 9th of December,

In 2007, the UN drifted towards a more academically agreeable concept and interpretation of both terms which emphasized the combination of violence, politics, sociology and psychology among the traits which are largely consistent with the provisions of the Nigerian Anti-Terrorism Act referred to by Femi Falana.

The first trait recognizes terrorism as a violent act that leads directly produces widespread disproportionate emotional reactions such as fear and anxiety which impacts or influences attitudes or the patterns of behavior of the victims. This is abundantly obvious from the changes in the travel plans of Nigerians including the impact on farming and rural communities where the bandits are mainly domiciled.

In the second trait, the violence perpetrated is both systemic and unpredictable in the targeting of symbolic targets for maximum effect. Here again, the alleged downing of the NAF aircraft along with the recent sabotage of the Abuja to Kaduna rail lines fits the definition snugly.

In the final trait, the violence is designed to convey unmistakable messages and threats calculated to communicate or achieve social control in any given context associated with the term. Again, recent reports suggest that the bandits have started appointing chiefs and even determined when mosques and markets should reopen in the Northwest parts of the country.

We have no such complications when it comes to the definition of banditry. A bandit, according to the Merriam-Webster dictionary, is someone who operates outside the confines of the law and lives by plunder. He could act alone, or belong to a band of marauders.

The Oxford dictionary of English and Spanish also traced the use of the word "bandit" to the 16th-century Italian term 'bandito', meaning "outlaw" or "banned". Where things get complicated is when the same Oxford dictionary went further to define a terrorist as a person who uses unlawful violence and intimidation, especially against civilians in the pursuit of political aims. Clearly, this definition fits IPOB and Boko Haram like a glove.

Regardless, soon after the September 11, 2001 attacks on the World Trade Center in New York, the UN rehashed its protocols on dealing with terrorism. Like the previous protocols, the sole aim was to assist member states in their counterterrorism measures by 'criminalizing'

Today, as the debate on the issue continues, the example of the UN should provide a lesson and a guide as to where the pendulum should swing one way or the other in the search for labels and adjectives for our marauding bandits. Instructively, the UN released the new protocols even while much of the contentious issues on the definition of terrorism remained unresolved.

I have listened to the argument in some quarters that the bandits need to be classified as terrorists because the Super-Tucano ground attack military aircraft the Americans reluctantly sold to Nigeria cannot be used against them unless they are regarded as such because of the extant pre-sale agreement between both nations.

But then, curiously, the same people who made the argument do not want the aircraft used against IPOB. Their hypocrisy confirms the needless partisanship which seems to have characterized some of the views aired on the subject so far.

Effective seed policy reforms needed to ensure food security

GRICULTURE is still one of the key sectors integral to economic transformation Tanzania. The sector employs over 70 per cent of the Tanzania population and comprises mostly of smallholders who cultivate at least 90 per cent of the arable land.

In order to feed the world population by 2050, the World Bank and the UN Food and Agriculture Organisation (FAO) say that food production must increase by half. A figurative war is fought regarding the approach to increase production, but the biggest victims will be smallholder farmers.

Seed is the foundation of agriculture and without seed there can be no agriculture and hence no food for human survival.

Tanzania has adopted a couple of national agricultural strategies since attaining independence that include Agricultural Sector Development Strategy I in 2001, Kilimo Kwanza in 2012, and the second Agricultural Sector Development Strategy II (ASDS II) adopted in 2014, all geared towards transforming agriculture sector from subsistence to commercial.

The Tanzania Development Vision (TDV) 2025 also envisages raising the standard of living of Tanzanians to medium income country by ensuring food security, improving incomes and increasing export

According the Changing Seed and Plant Variety Protection Laws in Tanzania Report published by the African Centre for Biodiversity (ACB) in 2016, the seed supply for agriculture in Tanzania is derived from both the formal and informal (the latter also known as local or farmer-saved seed system). Over 90 per cent of the seed originate from the farmer managed seed system while 10 per cent comes from the formal seed sector. The farmer-saved seed system however remains unrecognized and unsupported despite providing at least 90 per cent of the seed used by farm-

Studies conducted by the ACB in 2014 in Morogoro and Mvomero districts found that over 80 per cent of local maize, legume and rice seed in use was non-certified and the majority of farmers kept recycling seed from the previous

Famer-saved seed systems are guided by local technical knowledge and standards and by local social structures and norms.

In Tanzania, farmer-saved seed systems remain predominant with the majority of farmers still growing old varieties while practicing recycling.

According to the USAID Report 2013, famer-saved seed system is another important source of seed in Tanzania accounting for about 75 per cent of the seeds available in Tanzania while the formal sector contributes only 25 per

In Tanzania, it is estimated that only 4 per cent of the sorghum seed originates from the formal seed system, with the balance of 96 per cent being seeds sourced by farmers from infor-

About 95 per cent of the area planted with common beans consists of by farmers while the remaining 5 per cent is supported by the formal seed

It is also estimated that only 2 per

proved planting materials while 98 per cent is planted with recycled or shared stem cuttings.

Tanzania's seed legislation however does not recognize farmer-saved seed systems and local varieties and doesn't allow participation of smallholder farmers in seed production.

Policy-makers stress that there are no restrictions regarding the manner in which farmers use, save and exchange their own seeds, as long as the seeds don't enter the commercial

The Tanzanian seed system has grown over the years as observed from the increase in seed enterprises, improved seed support services and overall increased volumes of certified

The Seed Law reform however neglected farmer-managed seed systems and their contributions to the seed sector in Tanzania. According to the Tanzania Alliance for Biodiversity (TABIO) Coordinator Abdallah Mkindi, reviewing the Seed Act will help to preserve traditional seed species from extinction.

"The Seed Law should be reviewed to provide exemptions for farm-saved seeds and restrict only those persons who sell traditional seed species that are not certified as certified," Mkindi said.

He noted that there has been an increase in diseases due to consumption of foods that have been produced using farm inputs like pests and fertilizers.

"Long time ago, diseases like heart attack and diabetes were uncommon because people consumed healthy and safe foods. We need to go back to the drawing board and use our traditional farming practices that includes using farmer-saved seeds," he

Bakari Mongo, Chief Executive Officer of the Tanzania Organic Agriculture Movement (TOAM) said that there is need for a nationwide sensitization campaign to educate farmers on the health risks of rampantly using farm inputs like pesticides and

"There should be a long-term strategy to ensure that farmers use farm inputs as cautiously as possible so as to protect their own health and that of consumers," he said.

Mongo said that there is need for various players in the agriculture sector value chain to play their part so as to ensure sustainable food production.

"There is no shortcut to food safety and security. Everyone needs to play their part to ensure that agriculture production meets all the safety requirements," he said.

Establishment of traditional seed

Deputy Minister for Agriculture Hussein Bashe while officiating at the Second National Ecological Organic Agriculture Conference organized by TOAM in Mtwara Region in October this year hinted that plans were underway for Tanzania to create a bank for traditional seeds in a move aimed at promoting indigenous farming.

Bashe noted that the creation of the traditional seeds bank would go along with the establishment of a department that will specifically deal with organic farming.

The Tanzania Agricultural Research Institute (TARI) will be tasked to research and produce traditional seeds with a view to conserving seed varieties for organic farm-

It is equally important for the government to continue monitoring and evaluating various seed systems in the country to manage their contribution to sustainable food production.

New initiative seeks to increase productivity for entrepreneurs

S salaried employment opportunities in the formal sector become scarcer as the world battles Covid-19 pandemic, selfemployment in the informal sector is the only option for the majority. According to the Organization

for Economic Co-operation and Development (OECD), informal work accounts for two-thirds of nonagricultural employment in sub-Saharan Africa. In the case of Tanzania the figure is even higher, with 76 per cent of the non-agricultural workforce subsisting outside the formal economic framework.

However, for many, productivity remains low due to a myriad of challenges including limited skills, crude tools of production and lack of capital.

Against this backdrop, the Dar es Salaam Institute of Technology (DIT) has partnered with Tanzania Gender Networking Programme (TGNP-Mtandao) in a new project that seeks to increase productivity for group members of Knowledge and information Centers (KCs), including women and youth who are self-employed.

KCs are community-organized groups facilitated by TGNP and through them, the organization offers education and awareness to women on different matters touching their day-to-day lives in a bid to alleviate poverty.

Opening a training session in Dar es Salaam recently, Head of Programmes at TGNP-Mtandao Shakila Mayumana said that everyone in the world has something special and unique, including creativity that if used properly in society, can change lives.

"Everyone is special in our families, communities and even at the national level; you can produce something that is going to change the behaviour of people in the society," she said.

"We want people to continue grabbing opportunities around their areas so that at the end of the day, they create solutions to problems facing them. Instead of waiting for the government to allocate budgets and do everything for them, community members can bring changes and development in their own areas."

Florah Ndaba, a facilitator from TGNP made a presentation on capacity building for community-based initiative works and innovations that are particularly productive in social activities and add value to products.

She said that if community members jointly work together with their local leaders, they can come up with solutions to their challenges, and as a result the country will reduce donor dependency and national debts.

She said that TGNP in collaboration

with COADY International Institute of St. Francis Xavier University of Canada has already empowered over 400 Tanzanian women to turn challenges into opportunities.

"Members of KCs from Mabwepande, Saranga, Kivule and Majohe are beneficiaries of this programme ending next year need to change their ideas and be creative by turning community challenges into opportunities," she said.

Anna Sunyai, member of Kivule KC said they are working on the idea of producing alternative charcoal by using charcoal residues but the challenge but the main challenge is that they don't have a simple machine that

can make production in a large scale.

She said in their area, the big challenge is how to recycle garbage which for a long time has been a problem to the environment and through that project, they can make a difference.

"Later we found a machine at Small Industries Development Organization (SIDO) which sold at between 150,000/- to 200,000/- and that was ten years back. As a group we didn't have that money," she said.

"But we have to strive to get it though it might cost more now; we can recoup our investment because one bucket of alternative charcoal sells 14,000/-."

Mwajuma Kikumbi, member of Mabwepande KC said their group has an idea of processing and adding value to pepper for their community and later national and export markets.

"We process peppers by first we boil and putting packing the product in plastic bottles but without branding and as a result our customers don't know where to find our products,' she said.

Zakaya Enock, KC member from Majohe said that through the project, they learnt a lot including tailoring and how to make carpets by using pieces of textile fabric which they sale in the various formal markets and streets.

Sakina Msonde, DIT trainer told members of KCs that the doors are open for them anytime, if they need to get more practical training in order to add value to their products.

"Prepare yourselves and bring up potentially profitable business ideas that are likely to make changes to you, your families, communities and country," she said.

Blue ocean solutions for climate resilience and accelerated development

eychelles' 115 islands are an exotic ocean ecosystem of beaches, coral reefs, and unique plant and animal species. Concerned with the impacts of climate change, the country has committed to decarbonize by 2050.

As climate change threatens food security, livelihoods, sustainable and inclusive economic growth, countries with coastal blue carbon ecosystems are increasingly looking into the ocean for climate change and business solutions.

Angelique Pouponneau, CEO, Seychelles' Conservation and Climate Adaptation Trust, says for these countries, "the blue economy, sectors dependent on healthy marine and coastal resources, is at the heart of their updated Nationally Determined Contribution (NDC) submissions."

Under the Paris Agreement, countries revise their NDCs every five years to cut greenhouse gas emissions to limit the earth's temperature rise and commit to implementing solutions to adapt to the effects of climate change.

Seychelles made a most ambitious commitment in its NDC to decarbonize its economy entirely by 2050, making it one of the few developing countries to do so.

"Seychelles developed a national blue economy road map anchored on identifying sectors of the blue economy industry that can generate wealth and sustainable management of marine resources. Priority areas include aquaculture to help build resilience among local communities and accelerate sustainable development," says Pouponneau in an interview with IPS, adding that sustainable fishing and building ocean-based enterprises are crucial to the success of this Indian Ocean archipelago.

"Building ocean-based enterprises, providing a regulatory framework for sustainable businesses, and financing research and development activities are the three pillars of the blue economy roadmap."

Seychelles launched the world's first sovereign blue bond in 2018. The blue bond, Pouponneau says, is an innovative financial tool to support sustainable marine and fisheries start-ups and SMEs and the key to unlocking ocean-based sustainable business.

According to the Seychelles government, the bond is a pioneering financial instrument that raised US\$15 million from international investors. The success of the bond demonstrates the potential for

countries to harness capital markets for financing the sustainable use of marine resources.

Similarly, as part of the Nature Conservancy's Blue Bonds for Ocean Conservation program, Belize signed a Conservation Funding Agreement, also known as the Blue Bond.

"Our Blue Bond is similar to Seychelles'. However, Belize's is larger and has a more comprehensive set of targets," Beverly Wade, the Policy and Planning Advisor in the Ministry of Blue Economy and Civil Aviation, tells IPS.

"The bond establishes a Conservation Fund of USD 180 million, to be accessed over 20 years, to support the implementation of coastal and marine conservation projects by government and nongovernmental partners."

Wade, a representative on the Belize National Climate Change Committee, says the ministry is finalizing the framework for Blue Economy for the South American country.

"This is a five-year multisectoral policy, strategy, and plan. Belize is one of the countries in the Mesoamerican Reef region involved in the Smart Coasts Project that promotes ecosystem-based adaptation and climate smarting of Marine Protected Areas and Coastal Development Plans," she tells IPS.

Belize, a leader in marine spatial planning and habitat mapping, has updated

Marine Habitat Map by processing satellite imagery and artificial intelligence to classify critical marine habitats such as seagrass and corals.

The Blue Bond, she says, will facilitate the completion of a comprehensive Marine Spatial Plan (MSP) for Belize's entire Blue Space, an urban design term for visible water.

Overall, 163 nations have submitted their NDCs to the United Nations Framework Convention on Climate Change (UNFCCC) under the NDC Partnership.

The NDC Partnership is a global initiative to help countries achieve their national climate commitments through financial and technical assistance through the Climate Action Enhancement Package (CAEP).

The Partnership supports countries with a coastal blue carbon ecosystem to "enhance the quality, increase the ambition, and implement NDCs, every five years since the first round of NDC were submitted in 2016. With a footprint across 62 member countries and nine institutional partners since October 2017, the NDC Partnership holds significant experience, resources, and expertise to ensure that countries achieve NDC objectives.

This support is timely and critical. World Bank data shows the global ocean economy is valued at an estimated \$1.5 trillion per year. Approximately 80 percent of international trade by volume is carried by sea, and an estimated 350 million jobs across the globe are linked to fisheries.

The report, NDCs-A Force for Nature? notes that 105 out of 114 updated NDCs submitted by October 12, 2021, included nature-based solutions in their roadmap to limit global warming.

Through CAEP, launched in 2019 with the technical and financial support of 46 partners, the NDC Partnership is currently supporting 67 countries to submit enhanced NDCs and fast-track their implementation.

The CAEP aims to catalyze change towards resilient, sustainable, and low-emission development, supporting the objectives of the Paris Agreement for member countries of the NDC Partnership. It also assists developing member countries in enhancing NDCs and fast-tracking their implementation, including providing in-country technical expertise and capacity building.

The NDC policy commitment, Pouponneau says, is a "robust, realistic, measurable and achievable yardstick against which Seychelles is evaluating its progress towards climate change resilience and sustainable development."

"NDCs are a planning, finance and resource mobilization and accountability tool. And there is a commitment right from grassroots to the international level

to achieve set targets."

Wade agrees. She explains that through the NDC updating process, the National Climate Change Office, with support from the World Wildlife Fund and PEW Charitable Trusts, a National Blue Carbon Working Group was established.

"The group provided oversight for the research activities conducted in support of establishing realistic mangrove mitigation and adaptation targets for the updated NDC," she says.

"The NDC also identifies concrete targeted actions to meet these obligations. And provides a space for bringing together planned and ongoing activities from existing national strategies as well as plans for target achievement."

Both local communities and most of the Seychelles' urban areas and infrastructure are concentrated next to the shore; therefore, the country's economic activity relies on the sustainable management of marine resources.

"blue economy's primary challenge is the lack of understanding between the use of ocean-based resources, climate change resilience, and sustainable development. There is a need to educate local communities on why it is no longer business as usual," Pouponneau says. "This education will go hand in hand with financial incentives to help local communities use ocean resources sustainably."

ORE doses of COVID-19 vaccines have been delivered the EU, the UK and the United States in the six-week run up to Christmas than African countries have received all year, new analysis from the People's Vaccine Alliance reveals yesterday.

As COVID-19 clouds a second Christmas season in uncertainty and fear in many countries, campaigners warn that governments risk trapping the world in an endless cycle of variants, boosters, restrictions and even lockdowns, if low vaccination rates are allowed to persist in the global south.

Low and middle-income countries must be allowed to manufacture vaccines themselves to end vaccine inequality and prevent variants from derailing future Christmases, campaigners warn.


Between 11 November and 21 December 2021, the EU, UK and US have received 513 million doses of vaccines while countries in Africa received just 500 million throughout the whole of 2021.

The UK government, facing a rapid surge in Omicron variant, has a target of administering one million booster doses of COVID-19 vaccines a day in response, equivalent to vaccinating 1.46 percent of the population every day.

If every country was able to vaccinate at the same rate as the UK target, it would take just 68 days to deliver a first dose to everyone who needs one, leaving no one unvaccinated by the end of February 2022.

Just 8.6 percent of people in Africa have been fully vaccinated to date and at the current rate of delivery by vaccine manufacturers, it won't be until April 2023 that everyone will receive their first dose. Recent research found that 78 percent of people in Africa are willing to get vaccinated, higher than in many rich countries.

Rich countries receive more vaccines in run-up to Christmas than African countries have all year

the uncertainty and fear that is once again clouding Christmas. By blocking the real solutions to vaccine access in poorer countries they are prolonging the pandemic and all it's suffering for every one of us.

Experts have raised concerns that low vaccine coverage in the global south created conditions where a variant like Omicron was likely to emerge. Nine months ago, a survey of leading epidemiologists warned that persistent low vaccine coverage in parts of the world increased the risk of vaccine resistant variants emerging within a year or less.

Nick Dearden, Director of Global Justice Now, said: "If we ever want to have a normal Christmas again, we need to vaccinate the world. But right now, the UK and EU are holding back international efforts to use and expand manufacturing and distribution capacity in low and middle-income countries. It's reckless and risks trapping us in an endless cycle of variants,

boosters, restrictions and even lockdowns."

In October 2020, India and South Africa proposed a waiver of intellectual property rules on Covid-19 vaccines, tests and treatments to allow low and middle-income countries to manufacture these life-saving tools. Despite most countries, including the United States, supporting a waiver, the UK, EU, and Switzerland have prevented progress.

Maaza Seyoum from the African Alliance said: "Leaders in the global north have so far chosen the obscene profits of pharmaceutical companies over the lives of people in Africa.

But the Omicron variant shows that vaccine inequality is a threat to everyone, everywhere. Boris Johnson, Olaf Scholz, and European leaders need to finally support an intellectual property waiver and let Africa and the global south unlock its capacity to manufacture and distribute vaccines. Otherwise, humanity will never beat the race against the next variant."

Human Rights Watch and Médecins Sans Frontières identified over 100 manufacturers that could produce mRNA vaccines if intellectual property barriers were removed and pharmaceutical companies transferred the technology and knowhow needed.

Despite already making billions in profit, Pfizer and Moderna continue to refuse to share the new generation of vaccine technology with the WHO's mRNA hub in South Africa. WHO scientists are now attempting to reverse engineer Moderna's US-taxpayer-funded vaccine, a process that could take two years longer than if the company shared its vaccine recipe. Every major vaccine provider

has boycotted the WHO's Covid-19 technology access pool (C-TAP), a technology transfer programme established in May 2020 to share the recipe and knowhow needed to manufacture coronavirus vaccines, tests and treatments.

Blanket COVID boosters risk prolonging pandemic - WHO director general warns

THE World Health Organisation chief has warned that the rush in wealthy countries to roll out additional COVID-19 vaccine doses was deepening the inequity in access to jabs that is prolonging the pandemic.

WHO Director-General Tedros Adhanom Ghebreyesus insisted on Wednesday that the priority must remain to get vaccines to vulnerable people everywhere rather than giving additional doses to the already vac-

Omicron complicates holiday travel plans across

"No country can boost its way out of the pandemic," he told reporters.

The UN health agency has long decried the glaring inequity in access to COVID-19 vaccines.

Allowing COVID-19 to spread unabated in some places dramatically increases the chance of new, more dangerous variants emerging, it argues.

"Blanket booster programmes are likely to prolong the pandemic, rather than ending it, by diverting supply to countries that already have high levels of vaccination coverage, giving the virus more opportunity to spread and mutate," Tedros told

He said the priority must be to reduce deaths

and help all countries meet minimum vaccination targets that many still have not reached. And he noted that "the vast majority of hospitalizations and deaths are in unvaccinated people, not unboosted people."

Months ago, Tedros called in vain for a moratorium on booster doses to vaccinated, healthy people until at least 40 percent of people in all countries had received a first jab.

He pointed out Wednesday that while enough vaccines had been given to people globally this year to reach that target, distortions in global supply meant that only half the world's countries had

According to UN figures, about 67 percent of people in high-income countries have had at least one vaccine dose but not even 10 percent in low-income countries.

"It's frankly difficult to understand how a year since the first vaccines were administered, three in four health workers in Africa remain unvaccinat-

ed," said Tedros. Tedros renewed a call for manufacturers and other countries to prioritise the COVAX programme to get doses to needier nations and "work together to support those who are furthest be-

"Unless we vaccinate the whole world ... I don't think we can end this pandemic," Tedros said.

But he added that authorities now know the virus better and have effective tools to fight it; "we need to add to that comprehensive implementation and equity, and hope 2022 will end this pan-

Omicron in 106 countries

His comments came as the

Omicron variant's lightning dash around the globe since it was first detected in South Africa last month dampened hopes the

worst of the pandemic was over. The new variant is spreading at unprecedented speed and has already been detected in 106 coun-

tries, the WHO said. Early data, before peer-review, has indicated that it could be better at dodging some vaccine protections, spurring the rush to provide boosters.

But Tedros insisted Wednesday that "the vaccines we have remain effective against both the Delta and Omicron variants."

"It's important to remember that the vast majority of hospitalizations and deaths are in unvaccinated people, not un-boosted people," he said.

The WHO's Strategic Advisory

Group of Experts (SAGE) on Immunisation also recommended on Wednesday against blanket booster programmes, insisting additional doses should be "targeted to the population groups at highest risk of serious disease and those necessary to protect the health system".

So far, 120 countries have begun implementing programmes to administer booster vaccines or additional doses, it said - but none of them was a low-income country.

As case numbers surge, the UN health agency also called on countries and individuals to take all necessary precautions to halt the spread of the virus heading into the Christmas holidays.

"Boosters cannot be seen as a ticket to go ahead with planned celebrations," Tedros said.

Maria Van Kerkhove, the WHO lead on the COV-ID pandemic, stressed that people now know what they need to do, from wearing masks to physical distancing.

But she acknowledged the frustration of changing holiday plans.

"There are very difficult decisions that need to be had in terms of making sure that we keep ourselves safe," she said.

How can we end systemic racism in the US legal system?

ystemic racism in the US has had devastating consequences for generations of individuals from diverse backgrounds. Our legal system, which is intended to be color-blind, should be an essential tool in eliminating racism. But instead-despite legislative, educational and social efforts aiming to provide equal access to justice–the US ranks only 21st in the World Justice Project Rule of Law Index 2020.

Access to justice is tragically unequal depending on one's race. The list of injustices is long, and includes inequitable attorney and judicial behaviors, unfair bail practices, and legal outcomes decided by arbitrary factors like the defendant's income. Furthermore, specific failures within the legal system contribute to and reinforce widespread inequities across the entire criminal justice system, including policing, pretrial detention, sentencing, parole and the collateral consequences

Top-down legislation hasn't succeeded in fixing these problems. The legislative process is laborious and moves at a snail's pace; even the best intentions are inevitably diluted by partisanship and politics.

How can these problems be solved? In a word: innovate. Grassroots measures that attack and eliminate specific inequities at the ground level are needed. Those involved in these efforts to must be able to easily connect and collaborate to share

No single measure can turn the US legal profession into a body as diverse and inclusive as the population it serves. However, a new initiative by LexisNexis is aimed at developing and implementing a multitude of innovative solutions and inclusive practices that address specific racial inequities. This access disparity is a disadvantage that drives down the pool of African Americans."

Inequitable advice in consumer bankruptcy

Emony M. Robertson's project focuses on a different but equally vexing problem: reducing racial bias in consumer bankruptcy He points out that consumer bankruptcy has a clear racial disparity. African Americans are disproportionately advised by their attorneys to file Chapter 13 versus Chapter 7 petitions. "Chapter 7 bankruptcy offers many advantages, including the possibility of debt being totally discharged. Chapter 13 filings, by contrast, can result in the perpetuation of debt," he said. Robertson created a simple solution: bankruptcy filing checklists that attorneys can review before engaging with African American clients, and literature that explains the disparate outcomes.

Failures in self-representation

individuals When charged with misdemeanors attempt to represent themselves, the attempt to save costs works against them. They are far more likely to plead guilty. The fallout can have a lasting impact on the rest of their lives, including their ability to secure housing, employment, or federal funding for upperlevel education. Oscar Draughn, a student at Florida Agricultural and Mechanical University College of Law developed a digital tool that teaches individuals charged with low-level misdemeanor offenses how to defend themselves when adequate counsel is not available. His app will include a knowledge database, tutorials, and interactive modules. This tool will reduce the probability of conviction for reasons unrelated to the facts of the case.

One goal, many path-

There is no single road towards eliminating racism in the legal system. Approaching this problem from multiple angles will accelerate change. Targeted strategies, training, technology and collaboration can provide the collective power to break down the barriers of systemic racism in the legal system, once and for all.

Ethiopia protests US decision to revoke duty-free access

ADDIS ABABA

Ethiopia has said it is "saddened" by a US decision to revoke duty-free access for the East African country's exports.

The announcement by Ethiopia's trade ministry on Monday came after the Biden administration on December 23 terminated the country's eligibility for benefits under the African Growth and Opportunity Act. The US cited its disapproval of the war in the Tigray region for the action.

"The Ethiopian government is saddened over the decision by the US to remove it," from the preferential trade benefits, the ministry said. It asked the US to reconsider its decision. "Ethiopia is carrying out various initiatives aimed at bringing peace and stability, political consensus and economic development in addition to conducting reforms in line with the long-standing relationship between the two countries," it said.

The US withdrew the country's eligibility for the trade benefits despite pleas by a few US legislators and Ethiopian lobby groups who asked the Biden administration to give the country more time to comply with US demands.

The decision against the African nation was made over its failure to end a nearly year-long war in the Tigray region that has led to gross breaches of human rights, said the White House. Guinea and Mali will also be barred from receiving the trade benefits as of

The Africa Growth and Opportunity Act provides sub-Saharan African nations duty-free access to the US on the condition they meet certain requirements, including eliminating barriers to US trade and investment and making progress towards political plural-

The US and the UN say Ethiopian authorities have prevented lorries from delivering desperately needed food and other aid into Tigray. Scores of

people have starved to death, the Associated Press has reported. In September, President Biden warned that his administration would levy sanctions if Ethiopian Prime Minister Abiy Ahmed

Ethiopia in recent years had one of Africa's fastest-growing economies, but the war in Tigray has dampened that momentum.

Canadian audit firm warns against optimism at Buckreef Gold project


ANZANIAN Gold Corporation which jointly owns Buckreef Gold Mine project in Geita jointly with State Mining Corporation is not a going concern after all and has been incurring losses since inception.

An independent audit report conducted by Vancouver based Dale Matheson Carr-Hilton Labonte LLP for the year ended August 2021 said TanGold's accompanying financial statements were prepared with the assumption that the company will continue as a going concern.

"The company has not generated revenues since inception, has incurred losses in developing its business, and further losses are anticipated. The company requires additional funds to meet its obligations and the costs of its operations," said Dale Matheson Carr-Hilton Labonte LPP in its re-

"These factors raise substantial doubt about the company's ability to continue as a going concern," the audit firm warned while adding that TanGold's financial statements present fairly, in all material respects, the financial position of the company as of August 31, 2021 and 2020 and September 1, 2019 and its financial performance and its cash flows for the years ended August 31, 2021, 2020, and 2019, in conformity with International Financial Reporting Standards.

"We are a public accounting firm registered with the Public Company Accounting Oversight Board (United States) and are required to be independent with

respect to the company in accordance with the U.S. federal securities laws and the applicable rules and regulations of the Securities and Exchange Commission and the PCAOB," the Vancouver based audit firm added.

The audit firm further noted that the audit included performing procedures to assess the risks of material misstatement of the financial statements, whether due to error or fraud, and performing procedures that respond to those risks.

"Such procedures included ex-

amining, on a test basis, evidence regarding the amounts and disclosures in the financial statements. Our audits also included evaluating the accounting principles used and significant estimates made by management, as well as evaluating the overall presentation of the financial statements," the auditor noted.

"In its review and evaluation, management determined that there were no indicators that the carrying amount of mineral properties and deferred exploration, which has a carrying value of

\$38,618,000 as of August 31, 2021, may not be recoverable," the audit report warned.

The audit firm also identified the assessment of unproved mineral properties for potential impairment indicators as a critical audit matter due to the materiality of the balance, the high degree of auditor judgment and an increased level of effort when performing audit procedures to evaluate the reasonableness of management's assumptions in determining whether indicators of impairment are present.

In its fourth quarter results published in November this year, Tan-Gold said there was significant exploration potential following the discovery of two new gold bearing shear zones in the Buckreef West and Anfield Zones.

The company said assuming successful exploration results from ongoing diamond drilling, both new zones and the Buckreef Main Zone have the potential to significantly add to the 2.0 million ounces of gold in the measured and indicated mineral resources category and 0.6 million ounces of gold contained in inferred mineral resource category.

Commenting on the development, TanGold's CEO, Stephen Mullowney said, "We closed 2021 on a strong note. Buckreef Gold has been repositioned to have significant exploration potential with an increasing production profile. We are enthusiastic about continually developing our high return-low cost projects and are very excited about the drilling prospects at Anfield and Buckreef West.'

Kenya is banking on the World Bank loan to speed up its vaccine programme to inoculate the entire adult population by end of next year. The loan would allow Kenya to buy vaccines to complement the COVAX programme and bilateral donations to support the vaccination

move Kenya even closer to its objective of vaccinating 10 million people by end-2021 and all adults by end-2022.

The government has received 23.2 million doses of Covid-19 vaccines and has inoculated 8.9 million adults out of 47 million Kenyans. About 5.3 million Kenyans have had a first jab and only 3.5 million are fully vaccinated, according to the Ministry of Health.

The World Bank financing will help Kenya buy vaccines through an African Union facility set up for that purpose, as well as through COVAX, the global scheme for sharing vaccines equitably. The cash will also be used to boost Kenya's cold chain facilities for storage of vaccines, training of health personnel and other associated activities.

Kenya requires Sh34 billion to ship in 36 million doses of Covid-19 vaccines by June next year when it expects to have 16 million people inoculated. Donors will provide Sh20 billion, leaving Kenya to seek Sh14 billion from taxes and donors like the World Bank.

COVAX, which is led by the GAVI vaccines alliance along with the WHO and other partners, aims to deliver over 1.3 billion doses to 92 lower- and middle-income countries, covering up to 20 percent of their populations. Kenya will offer the Covid-19 vaccine shots free of charge to its citizens, but will pay \$7.70 (Sh853.70) per shot of the vaccines as negotiated under the COVAX facility.

IMF praises Mozambique for prudent policies

The International Monetary Fund (IMF) has praised Mozambique's prudent economic management at a time when the country faces severe challenges.

Following an IMF Staff Visit to Mozambique, which concluded on 16 December, a statement released by the head of mission, Alvaro Piris, pointed out that "the Mozambican economy is recovering from a sharp contraction, following several years of economic shocks".

Piris added that "a modest but broadbased recovery is taking hold in 2021. After real GDP contracted in 2020 - the first contraction in 30 years - growth resumed in early 2021 and is expected to reach 2.2 per cent for the year. Robust growth in agriculture and mining was complemented by a modest recovery in services as COVIDrelated restrictions were eased. Seasonal factors, supply-chain constraints, and international food and fuel price increases led inflation to rise to 6.8 per cent year on year in November, remaining within the Bank of Mozambique's target of less than ten per cent."

Mozambique has been hit by the twin crises of the Covid-19 global pandemic and islamist terrorism in the northern province of Cabo Delgado, and Piris pointed out that "the Covid pandemic, and the conflict and humanitarian emergency in the north of the country are intensifying fragility."

"Two large waves of Covid infections in the first and third quarters of 2021 prompted strict confinement measures, lowered incomes, and resulted in the loss of schooling for an already vulnerable population", Piris added. "Terrorist attacks have caused thousands of deaths and displaced more than 800,000 people in the northern province of Cabo Delgado, with many in the northern region suffering food insecurity."

IFC signs deal to insure Bank of Africa SME loans

NAIROBI

The International Finance Corporation (IFC) has signed a deal to provide Bank of Africa Kenya with cover against losses on loans to SMEs as the lender looks to scale up its funding for small businesses.

The IFC, which is the private sector lending arm of the World Bank, said that the facility will cover 50 percent of losses on all eligible loans that Bank of Africa Kenya (BOA Kenya) extends to SMEs, up to the shilling equivalent of \$5 million (Sh650 million).

The agreement will also see the IFC provide the tierthree bank with advisory services on how to mitigate risk as it shifts into the SME ending segment, which is deemed one of the riskiest in the banking sector.

"IFC's risk-mitigation product, combined with general and targeted advisory services support, will help BOA Kenya decrease risk and scale up its lending to SMEs in its most challenging markets. Also, it will help us transform into an SME-focused bank with branches across Kenya," said BOA Kenya managing director Ronald Marambii. The loans under guarantee

will largely target womenled businesses and those focused on addressing climate change. BOA Kenya, which by the end of 2020 held a market share of 0.72 percent in the Kenyan banking industry, held a loan book of Sh15 million as at September 2021, having shrunk from Sh17.23 billion a year earlier.

It reported a profit after tax of Sh4.58 million in the nine months to September 2021, reversing a loss of Sh217.9 million reported in the corresponding period in

2020. The IFC programme is supported by the Global SME Finance Facility (GS-MEF), which is a partnership between IFC and the UK's Foreign, Commonwealth and Development Office and the Netherlands Ministry of Foreign Affairs.

Also lending support is the Women Entrepreneurs Opportunity Facility (WEOF), a global finance facility dedicated to expanding access to capital for women entrepreneurs, was launched in 2014 by IFC through its Banking on Women program, and Goldman Sachs 10,000 Women.

The best-selling smartphones of 2021

More than 1.04 billion smartphones were sold in the first three quarters of this year, almost 88.6 million more than in the first nine months of 2020, according to technology research and consulting company Gartner.

After a double-digit surge on a yearly basis in the first two quarters of 2021, global smartphone sales declined by 6.8 per cent annually in the third quarter of this year. The Covid-19 pandemic-induced shortage of key components such as radio frequency and power management integrated circuits, delayed smartphone production globally that led to a decline in sales in the July-September period, according to Gartner. "This disrupted the supply-demand equilibrium and end-users were burdened with limited choices at point of sale," it said.

Despite the prevailing market constraints, challenging business ecosystem and dismal business outlook, some smartphone models have continued to perform

strongly. Here are the top seven best-selling smartphones in the first three quarters of the year, according to industry observers Counterpoint Research and International Data Corporation, whose research did not reveal the exact number of units sold for each model.iPhone 12

Apple's iPhone 12 became the world's best-selling 5G smartphone in the first nine months of the year, according to industry data. Despite a delayed launch owing to the coronavirus-led supply chain disruptions, the 5G-enabled iPhone 12 managed to attract more customers. It was released on October 13 last year, along with three more models - the iPhone 12 mini, iPhone 12 Pro and iPhone 12 Pro Max.

Galaxy A12

Launched late last year, Galaxy A12 is one of the Samsung's mostselling budget smartphones.

With a 16.5cm display and quad-camera system on the rear, the A12 model has a powerful battery of 5,000 milliampere-hour that is enough to last more than two days between charges. The

China imposes new curbs on offshore IPOs from restricted sectors

BEIJING

Chinese firms in industries banned from foreign investment will need to seek a waiver from a negative list before proceeding for share sales.

China will impose new restrictions on offshore listings by firms in sectors that are off-limits to foreign investment, a move that could plug a loophole long used by the country's technology industry to raise capital overseas.

Chinese firms in industries banned from foreign investment share sales, the National Development and Reform Commission and the Ministry of Commerce said in a statement on Monday. Overseas investors in such companies would be forbidden from participating in management and their total ownership would be capped at 30%, with a single investor holding no more than 10%, according to the updated list effective January 1.

The overhaul represents one of the biggest steps taken by Beijing to tighten scrutiny on overseas listings after ride-hailing giant Didi Global proceeded with its New York initial public offering despite regulatory concerns over the security of its data. While regulators stopped short of a ban on IPOs by companies using the so-called Variable Interest Entities (VIE) structure, the new rules would make the process more difficult and costly.

"For companies that seek to list under the VIE structure, the move may affect their decision as to choosing the listing destinations," said Xia Hailong, a lawyer with Shanghai-based Shenlun law firm. "They used to have no obstacle to overseas listing, but now they'll surely face much tougher scrutiny and the path to overseas IPOs will be much more difficult."

VIEs have been a perennial worry for global investors given their shaky legal status. Pioneered by Sina Corporation and its investment bankers during a 2000 IPO, the VIE framework has never been formally endorsed by Beijing. It has nevertheless enabled Chinese companies to bypass rules on foreign investment in sensitive sectors, including the internet industry. The structure allows a Chinese firm to transfer profits to an offshore entity - registered in places like the will need to seek a waiver from a Cayman Islands or British Virgin negative list before proceeding for Islands – with shares that foreign investors can then own.

The requirements apply to new share listings and won't affect the foreign ownership of companies already listed overseas, according to the nation's economic planning agency. The move comes days after the China Securities Regulatory Commission proposed on Friday that all Chinese companies seeking IPOs and additional share sales abroad would have to register with the securities regulator. Any company whose listing could pose a national security threat would be banned from proceed-

Companies using the so-called variable interest entities structure would be allowed to pursue overseas IPOs after meeting compliance requirements, the securities regulator said, without providing further details.

paign to curb the breakneck growth of China's internet sector and what Beijing has termed a "reckless" expansion of private capital. Curbing VIEs from foreign listings would close a gap that's been used for two decades by technology giants from Alibaba Group Holding to Tencent Holdings to sidestep restrictions on foreign investment and list offshore.

UN chief calls for global solidarity to stop infectious diseases

UNITED NATIONS

UNITED Nations Secretary-General Antonio Guterres on Monday called for global solidarity to stop infectious dis-

In his video message for the International Day of Epidemic Preparedness, which falls on Dec 27, the UN chief said that building global solidarity would "give every country a fighting chance to stop infectious diseases in their tracks."

COVID-19 continues to demonstrate

how quickly "an infectious disease can sweep across the world," pushing health systems to the brink and upending daily life for all of humanity, the UN chief said.

"It also revealed our failure to learn the lessons of recent health emergen-

cies like SARS, avian influenza, Zika, Ebola and others," said the secretarygeneral.

"And it reminded us that the world remains woefully unprepared to stop localized outbreaks from spilling across borders, and spiraling into a global pandemic," he said.

Noting that infectious diseases remain "a clear and present danger to every country," Guterres maintained that COVID-19 would not be the last pandemic for humanity.

Even as the world responds to this health crisis, he spelled out the need to prepare for the next one.

"This means scaling-up investments in better monitoring, early detection vaccines for all people and ... achievand rapid response plans in every coun-

try - especially the most vulnerable,"

"It means strengthening primary health care at the local level to prevent collapse... ensuring equitable access to lifesaving interventions, like ing universal health coverage."

The first International Day of Epidemic Preparedness, marked on Dec. 27, 2020, was called for by the UN General Assembly to advocate the importance of the prevention of, preparedness for and partnership against epidemics.

Historical roots strengthen China's plan for future

THERE is no greater guide for the path we find ourselves on today than the road which we have already traveled.

While China has increasingly become synonymous with innovation and a future-oriented outlook, the momentous milestones reached in 2021 had a single underlying theme of an entirely dif-

ferent nature -- history. In 2021, China celebrated the centenary of the Communist Party of China (CPC), launched a campaign for encouraging the study of the Party's history, and convened a pivotal meeting at which a landmark resolution on the Party's century-long history was passed.

This declaration marked the country's successful elimination of absolute poverty, a scourge that had plagued the Chinese people for millennia.


Back in 2012 when Xi was elected to the Party's top post, there were nearly 100 million Chinese living under the poverty line. Since then, a monumental antipoverty campaign was launched on a scale unseen anywhere in the world. Over the eight years, the final 98.99 million impoverished rural residents had all been lifted

Combined with its povertyreduction results since the late 1970s, China is responsible for over 70 percent of the global reduction in poverty over the period, World Bank statistics showed.

out of poverty.

In 1921 when the CPC was founded, it had just over 50 members. Today, with more than 95 million members in a country of more than 1.4 billion people, it is the largest governing party in the world with tremendous international influence.

Yet the remarkable achieve-



ments of the Party did not come from nothing; they were earned through persistent struggle and made possible by the great strength drawn from its founding

At the Party's centenary gathering, Xi spoke at length on this founding spirit. Russian-Slovenian relations develop despite COVID-19 pandemic – envoy

LYUBLYANA

THE ties between Russia and Slovenia have developed despite the COVID-19 restrictions which were in effect in 2021, Russian Ambassador to Slovenia Timur Eyvazov told TASS yesterday.

"Despite the conditions that we had, primarily due to the COVID-19 restrictions, despite all these challenges we have managed to achieve a lot and, in general, the Russian-Slovenian relations are developing well," the Russian envoy

Speaking about the significant events, which took place in 2021, Eyvazov mentioned the annual ceremony at the Russian Chapel under the Vrsic Pass, which was attended by numerous representatives of Slovenia's political, cultural and social circles, including President Borut Pahor.

The Russian delegation was headed by Deputy Speaker of the Federation Council of the Federal Assembly Konstantin

This, in my opinion, is a very important and major event, which reflects the positive ties are supporting between the peoples of Russia and Slovenia," the envoy said.

Eyvazov also recalled the Moscow talks between the Russian and Slovenian top diplomats, Sergey Lavrov and Anzhe Logar, which took place in May this year.

According to the Russian ambassador, in 2021, several rounds of inter-ministerial consultations were held, including at the level of deputy ministers.

DR Congo launches cholera vaccination campaign targeting 2 million people

KINSHASA

THE Democratic Republic of the Congo (DR Congo) on Monday launched a massive cholera vaccination campaign targeting 2 million people aged one year and above in three eastern provinces to halt an outbreak of the disease, according to health officials.

The campaign is being carried out in Haut-Lomami, South Kivu and Tanganyika provinces, the most affected areas by cholera since August, and will cover 13 health zones with about 4 million doses delivered by the Global Task Force on Cholera Control.

Around 3,600 health workers, including vaccinators and community mobilizers, have been deployed to carry out the campaign which will run for six days. Since the start of the year, the DRC has reported a total of 8,279 suspected cholera cases and 153 deaths in 16 of the country's 26 provinces.

"Cholera is a dangerous infection that can kill within hours if untreated, but it is predictable and preventable. In addition to the vaccines, which are one of the effective measures against the disease, we are also providing clean water and reinforcing hygiene and sanitation to prevent the outbreak from spreading further," said WHO Officer in charge in the DRC Amedee Prosper Djiguimde.

The ongoing vaccination is DRC's second massive campaign this year. In March and July, more than 1.4 million people were vaccinated against cholera in the southeast-

ern Haut-Katanga province. Cholera is a highly contagious disease transmitted through contaminated water or food. It causes severe diarrhea and dehydration that must be treated immediately to prevent death, which can occur in just a few hours, and to prevent the large-scale spreading of the disease in a high-

risk environment. Disease surveillance, improved water, sanitation, and hygiene services as well as early detection, treatment and vaccines are crucial in preventing cholera and containing the spread of the infection. Coverage with a two-dose oral cholera vaccine provides up to five-year protection.

Indonesia says detects first locally transmitted Omicron case

JAKARTA / SYDNEY

INDONESIAN health authorities were conducting contact tracing yesterday after detecting the Southeast Asian country's first case of the fast-spreading Omicron coronavirus variant in the community, health ministry official Siti Nadia Tarmizi said.

The first confirmed case was a 37-year-old male who was from the city of Medan and had visited a restaurant in Jakarta's central business district earlier this month, Tarmizi told a news conference.

The man had no recent history of overseas travel or contacts with international travelers, Tarmizi said, adding he was asymptomatic and was in isolation at a Jakarta hospital, after he had initially isolated at home.

Earlier this month, President Joko Widodo urged people to stick to health protocols after authorities said that an employee at an isolation hospital in Jakarta had tested positive for the variant.

Health authorities say that there have been 47 confirmed cases of Omicron in Indonesia, mostly imported cases of the variant, which experts say in initial studies appears to be more contagious but less virulent than previous variants. Australia

Australia recorded another surge in COVID-19 infections on Tuesday as an outbreak of the highly infectious Omicron variant disrupted a staged reopening of the economy, while state leaders argued over domestic border controls.

The three most populous states, New South Wales, Victoria and Queensland, reported just under 10,000 new cases between them the previous day, putting the country on course to eclipse the previous day's record total of 10,186 cases.

The country's five other states and territories, which have also been experiencing flareups of the virus, were yet to report figures.

The new outbreak has also fueled a resumption of fractious domestic politics which defined much of the pandemic as some states resist calls to remove internal border

NSW, home to Sydney and a third of Australia's 25 million population, called on neighboring Queensland to shift from mandatory clinical testing to on-the-spot rapid antigen testing for people travelling to the tourist-popular state following complaints of hours-long wait times.

NSW Health Minister Brad Hazzard said a quarter of his state's PCR tests were "tourism tests", causing enormous pressure of the health system, extraordinary long testing queues and wait times for results, sometimes for days.

Queensland has promised to review its border testing rules from Jan 1, but Hazzard urged Queensland to drop the rule immediately.

Tutorial system to improve competence of young rural officials

TO accelerate rural vitalization, Puyang city in central China's Henan province has piloted a tutorial system targeting grassroots officials including chiefs of the Communist Party of China (CPC) branches of villages with a relatively weak collective economy and newly elected village

Party chiefs. The new system is aimed at giving play to the exemplary role of outstanding officials and helping relevant villages with Party affairs, administrative affairs of village, industrial development,

as well as village governance. A total of 410 villages in 32 townships of six counties (districts) have been selected for the pilot system, under which 482 officials were designated as "tutors" and 483 officials as "students".

"Don't rush into construction after land transfer. You must make a good overall plan first," Li Liancheng, an experienced Party chief of Xixinzhuang village, Puyang county, Puyang city, told Liu Enzhao, chief of the Party branch of Shuocun village, Puyang county, while teaching the latter how to make solid plans and increase the collective income of his village.

"The planning process may sound like a lot of work, but with reasonable planning, you will see your project go smoothly with nothing needing to be redone. In this way, you are actually moving faster," Li explained.

Liu planned to transfer landuse rights in the village so as to concentrate the land for developing industrial projects. However, the 31-year-old newly elected Party chief lacked experience in formulating high-quality plans for projects.

Under Li's guidance, Liu has led officials of his village to make steady progress in promoting

the development of relevant projects. They first established specialized farmers' planting cooperatives and integrated about 26.67 hectares of scattered cultivated land, and then planted seedlings of over 20 tree species for afforestation, laying a solid foundation for increasing the village's collective income as well as the income of villagers.

"Thanks to the guidance from Lu Wushen, our village has avoided some detours in the construction of the edible mushroom base and found viable paths to development and increasing people's chief of Lishawo village, Qingfeng county of Puyang city.

Lu, secretary of the CPC branch of Xizhaolou village, Qingfeng county, played a leading role in the building of edible mushroom base in the village, and has been providing guidance for Liu to speed up the development of the collective economy of Lishawo village since the pilot tutorial system was launched.

Besides assigning outstanding officials to help with the development of villages with sluggish collective economy, Puyang city has also arranged for professionincome," said Liu Jiufeng, Party als and technicians to provide

guidance for village officials and help solve problems in financing, technical support, and the sale of products, effectively facilitating the development of characteristic industries, stimulating the economy of villages, and increasing the income of villagers.

Report: Fires erupt in Syria's Latakia port after Israeli attack

CAIRO

FIRES erupted in Syria's Latakia Port's container storage area following an Israeli missile attack, Syrian state media reported vesterday.

The attack, the second in December, damaged facades of a hospital, some residential buildings and shops.

"The Israeli "aggression" caused big materialistic damages and assessing its results is still a work in progress", the Syrian defense ministry said in a statement.

Israel has mounted frequent attacks against what it has described as Iranian targets in Syria, where Teheran-backed forces including Lebanon's Hezbollah have deployed over the last decade to support President Bashar al-Assad in Syria's civil war.

Live footage aired by the Syrian State TV showed flames and smoke in the containers area.

"Fire fighters are trying to put the fires off while ambulances arrived at the scene," the state TV reporter said.

Latakia, a Mediterranean port, is Syria's main commercial port.

Russia, which has been Assad's most powerful ally during the war, operates an air base at Hmeimim some 20 km (12 miles) away from Latakia.

On Monday, Syria condemned Israeli plans to double within five years the number of Jewish settlers in the Golan Heights captured from Syria in 1967 as a "danger-

ous and unprecedented escalation".

Israel's cabinet approved a blueprint on Sunday to build some 7,300 additional housing units on the strategic plateau in a move that could tighten its hold on the territory.

"Syria strongly condemns the dangerous and unprecedented escalation by the Israeli occupation authorities" in the Golan, the state-run SANA news agency said, adding Damascus would seek to use all legally available means to retake the territory.

Speaking to Syrian TV station al-

Ekhbariya, foreign minister Faisal Mekdad called Israel's actions against Syria "criminal" and said they violated the 1981 UN Resolution 497 declaring Israel's effective annexation of the Golan as "null and void."

Mekdad also said that the United States is stealing natural resources from Syria and imposing illegitimate

The US forces, with the help of the Syrian Democratic Forces (SDF) militia, continue to steal the Syrian oil, wheat, and cotton, he said.

He said the SDF, with the assistance of the US forces, is holding 60,000 people in the al-Hol refugee camp in northeastern Svria, noting that the SDF is stealing the aid that is sent to the refu-

He also claimed that US sanctions against Syria are "illegitimate" and aimed at destabilizing the country.

CHINA will implement provisional import tariffs lower than the most-favored-nation (MFN) rates on 954 products starting from Jan. 1, 2022, announced the Customs Tariff Commission of China's State Council on Dec. 15.

To ease the financial burden on patients and improve people's well-being, the country will eliminate tariffs on a radium chloride injection, a new anticancer drug, and reduce tariffs on some imported medical products, including intracranial stents and prosthetic joints.

To satisfy people's needs for a better life, conform to the trend of consumption upgrading, as well as encourage more people to engage in ice and snow sports so as to create a sound atmosphere for the upcoming Beijing 2022 Olympic and Paralympic Winter Games, China will cut import tariffs on high-quality aquatic products like salmon and cod, baby clothes, dishwasher, skiing gear, and some other consumer goods.

Besides, it will implement zero tariffs on oil paintings that are more than 100 years old and other types of artwork to meet people's demands for cultural consumption.

To improve environmental quality and promote green and low-carbon development, the country will lower customs duties on imported gasoline particulate filters and electronic throttles, which can

improve the fuel efficiency of vehicles and reduce their exhaust emissions, as well as peat that can be used for soil remediation.

To drive the optimization and upgrading of the manufacturing industry, China will cut import tariffs on high-purity graphite accessories, highvoltage cables for high-speed trains, membrane electrode assemblies and bipolar plates of fuel cells, and other key components.

The country will also cut the

import tariffs on raw materials required by the food processing, daily chemical, and leather manufacturing industries, including cocoa beans, essential oils from plants, and animal fur. Besides, it will reduce import duties on pyrite, pure

potassium chloride, and other resource products in short supply at home.

Such tariff adjustments, which are based on China's development needs, help maintain the safety and stability of domestic industrial and supply

chains, supporting the crosscycle smooth operation and long-term sound performance of the economy, optimizing resource allocation, facilitating scientific and technological innovation and industrial transformation and upgrading, and pushing ahead with green and low-carbon development, pointed out Xu Guangjian, a professor at the School of Public Administration and Policy,

Renmin University of China. To continuously advance higher-level opening-up, China will, according to the free trade agreements and preferential trade arrangements signed with relevant countries and regions, impose conventional tariff rates on some products from 29 countries or regions next year.

China will also lower its tariffs under its free trade agreements (FTAs) with New Zealand, Peru, Costa Rica, Switzerland, Iceland, South Korea, Australia, Pakistan, Georgia, Mauritius, and the Asia-Pacific Trade Agreement.

The Regional Comprehensive Economic Partnership (RCEP) and China-Cambodia FTA will take effect on Jan. 1, 2022, under which the country will cut tariffs on imports from relevant countries.

Under the high-profile RCEP, China and Japan will carry out tariff reduction arrangements for the first time, which will undoubtedly bring about new op-

portunities for both countries, according to Cui Fan, a professor at the School of International Trade and Economics, University of International Business and Economics.

After the RCEP agreement takes effect, the tariff reduction among members will help promote regional trade and investment growth, elevate the level of economic integration in East Asia, consolidate and promote the integration of regional industrial, supply, and value chains, and boost members' confidence in post-COVID-19 economic growth, Cui said.

The RCEP will also enable China to give full play to the advantage of its super-large market, actively participate in reshaping the global industrial chain, build a globally oriented network of high-standard free trade zones, and advance higher-level opening-up, he added.

Starting from July 1, 2022, China will implement the seventh MFN tariff concession on 62 products covered by the Information Technology Agreement expansion. After the adjustment, China's overall tariff level will remain at 7.4 percent, the same as that of 2021.

Next year, China will continuously apply preferential tariff rates to goods from the least developed countries that have established diplomatic relations and completed the exchange of notes on establishing diplomatic relations with China.

Brighter days should be ahead for the **NBA League**

THE Utah Jazz leads the NBA League in a handful of categories. Most 3-pointers, just like they did last season. Most points per game. Most rebounds per game. They are also last in use of the word

It is not accurate – yet – to say every team in the NBA has had a coronavirus problem this season.

No Jazz player has been on the league's health and safety protocols list vet this season, making Utah the only team yet to lose a player to a virusrelated issue.

That is particularly impressive considering what's happening. Right now, 27 of the league's 30 teams are currently waiting for at least one player to come off the list, with some of those teams waiting for way more than one player to be cleared.

"I don't feel any particular pride," Jazz coach Quin Snyder said when asked about being the last team standing in the protocols race.

"I think we've been fortunate. We've tried to be smart about a lot of things. A lot of teams have done that, just in terms of raising a level of awareness. I think we've been fortunate. I also think it's kind of a knock-on-wood situation on some level.'

He doesn't really think the run of luck will last. Snyder knows it's an "inevitability" that the Jazz will join the rest of the NBA.

The numbers around the league indicate that day is coming sooner than later.

December 2021 was a difficult month for the NBA, by any measure, probably the most difficult since March 2020.

That was when the decision to shut down happened on the night that Jazz center Rudy Gobert became the first player to test positive for COVID-19.

More than 500 players took the floor this month, a record for any month in league history.

Well over 100 players went into the protocols and

the list of postponed games grew to nine. The NBA had no choice but to basically allow teams unlimited hardship contract slots, agreeing to not have the emergency call-ups count against a team's salary cap or luxury tax numbers.

But just like any new year should, January will likely bring newfound optimism.

The league now has a shorter return-to-play plan

in place for those who have tested positive. It's reasonable to think the percentage of players who have received booster shots – 65% was the last

known figure – will rise soon, especially since every team was ordered by the NBA to have an event to make them available to players, staff, and family members by Friday. And even while well over 100 players tested positive in December, few were known to have

in large part due to the league's 97% vaccination "We all want to get this all behind us," said Portland assistant Scott Brooks, who will coach the Trail Blazers while head coach Chauncey Billups is

Player-of-the-match Boland claimed the remarkable bowling figures of six wickets for seven runs as Australia beat England by an innings and 14 runs before lunch on the third day of the third Ashes Test at the Melbourne Cricket Ground on Tuesday.

More importantly, the massive victory meant Australia retained the Ashes with a 3-0 lead in the five-match series.

Trailing by 82 runs on the first innings, England resumed on Tuesday on 31-4 and was bowled out for 68.

"We need to put some pride back into the badge and we need to give people back home something to celebrate," Root said.

Root praised his bowlers for keeping his side in the match by restricting Australia's first-innings lead to under 100.

But Root admitted his side's batting was not good enough and questioned whether England's domestic compepreparing players for the challenges of the five-day game.

"We have to stay strong and look at the next two games to take something from the tour," Root said at the post-match cer-

emony. Players from both teams were tested for COVID-19 overnight Monday after four persons from the England touring group tested positive, delaying the start of play on the second day.

But play started on schedule on Tuesday after all the players had negative results - and proceeded for about 80 minutes until Australia quickly clinched the series.

Ralf Rangnick's Manchester United honeymoon is over, as struggles at Newcastle proved

RALF Rangnick now knows the true magnitude of the job he has taken on as interim manager at Manchester United.

When he was not shaking his head on the touchline during a dismal 1-1 draw at Newcastle on Monday, Rangnick was rubbing his forehead in frustration.

The only positive for the man who replaced performance was better than its first -- but it would have been virtually impossible for Man now do is find a way to United to have been any worse.

"I didn't like the performance at all," Rangnick said. "Today we didn't control the game apart from a few moments. It's all about energy, physicality and who wins the second balls. In all those areas we weren't at our best. The good thing is performance needs to be better.



Group C has former CAF Champions League champions and DR Congo football giants, Tout Puissant Mazembe, Coton Sport of Cameroon, Al Masry of Egypt and Congo Brazzaville's AS Otoho d'Oyo.

The draw for 2021/22 TotalEnergies CAF Champions League Group Stage was conducted at CAF Headquarters in Cairo the same day.
