
RESIDENT Samia Suluhu Hassan yesterday received an honorary doctorate degree (Honoris Causa) from Jawaharlal Nehru University in India, and in turn dedicated it to children, girls in particular, living in difficult surroundings in

Prof Santishree Dhulipudi Pandit, chancellor of Jawaharlal Nehru University, said the university has bequeathed President Samia with the degree in recognition of her contribution in boosting Tanzania-India relations, economic diplomacy and everyday lives of Tanzanians, and her achievements regionally and internationally.

India's External Affairs minister, Dr Subrahmanyam Jaishankar said the degree is a sign of improvement in Tanzania-India ties, with university authorities affirming that since its establishment in 1969, only two other world leaders have been bestowed with the honour at JNU, namely President Vladimir Putin of Russia and the late former Japanese premier Shinzo Abe.

Receiving the degree, her first from another country, President Samia expressed gratitude to JNU for the honour, saying she is dedicating it to Tanzanian girls living in hard surround-

NEMC evaluating gold mine seizure

THE government is working on taking over Sunshine Mining (T) Ltd gold mine in Chunya District, Mbeya Region whose chemical discharge has for some years been a threat to Matundasi villagers, estimated at upwards of

Dr Samuel Gwamaka, the National |Environmental Management Council (NEMC) executive director, said in an interview yesterday that the council was hiring a consultant on the costs of restoring the mining zone environment.

After the study is completed, the government envisages taking over the gold mine with its immovable and movable properties for sale to another company, for the proceeds to be used in environmental restoration.

He said the original firm before opting to quit the area sought to sell the mine to a local company, where NEMC intervened as the local firm would not be aware of the burdens the mining firm has left, and would not bear the costs of environmental restoration.

Interviewed villagers said, people are threatened with cancer and giving birth to deformed children owing to contamination of water sources by discharged chemicals

He said STREPHIT will help the Tanzania Plant Health and Pesticide Authority (TPHPA) to improve the protection of the country's crops



NEMC evaluating gold mine seizure

The gold mine has been discharging toxic chemicals from its dams storing toxic mud that filters to Lupa River, on which more than 9,000 people in the area are dependent, they said.

The river in turn flows into Lake Rukwa, with chemical residue becoming a threat to a wider range of users among residents, livestock and even plants watered from water drawn from

The mining firm extracts gold from 1.84 sq km of area with a mining license ML 588/2018 earlier expiring on March 10, 2028.

The director noted that the council was aware of the situation, thus took initial measures to stop production activity in the mine, and then reports of the company seeking to quit were heard.

NEMC has been seeking to create awareness on the best ways to avoid problems caused by discharges, with the chemical spoiling of farming land and toxins in water used by the people in the area are the main grievances, with Sunshine Mining (T) Ltd as the main culprit, the villagers affirmed.

A 65-year-old Ambakisye John from the same ward said last year he lost several cattle, while fish and frogs were also dying in big numbers in the river due to its water being contaminated by chemicals from the gold mine.

"Many people do not know where to go, to which office, they do not know the location of the environment offices or even the office of the District Commissioner," he said, in response to what

steps were being taken by residents against the threat.

"The officials also do not come to us to see for themselves and talk to the villagers, to tell them of the dangers they

"When it rains, the toxic water also flows into water sources from which Lupa River draws its water that we use for drinking and cooking," he said.

John Mwalukaga, another resident said that hands, legs and faces contract burns and itch, raising worries that after some years we will get seriously

"Even the food we eat is also dangerous because we eat the meat of the cattle that drink the toxic water, we do not know what will happen to us later on."

Yohana Ngurukila, the district environment officer said that the mining company had an Environmental Impact Assessment (EIA) certificate, and were employing an environmental management programme (EMP), except that there were traces of water flowing that I think was coming from a spring," he said.

NEMC also made much effort taking samples for testing even though the results thereon have not come out, he

Salum Said Kassim, the Sunshine Mining human resources manager said the dams with toxic mud have special pipes and we set the water level. "When the dams are full of water, water cannot flow out, it will be recycled back to the plant for storage," he added.

AT LEAST 294,661 women and young people have been empowered through the 'Mwanamke Imara' project to curb gender-based violence, strengthening their participation in leadership and governance as well as increasing their access to justice.

The three-year project which is funded by the USAID aims at addressing violence and structural discrimination against women and young people in Mbeya, Njombe and Kilimanjaro re-

The project, which concludes in December this year, is implemented by a consortium of Tanzania Women Lawyers' Association (TAWLA), Women

WiLDAF, Tanzania Network of Legal Aid Providers - TANLAP and Kilimanjaro Women Information Exchange Community - KWIECO.

Speaking during a review meeting, the project manager, Mary Richard, said through a number of interventions they managed to empower women and young people to overcome stumbling blocks in social, economic, political development as well as cultural life.

She mentioned a number of factors that contributed to violence against women and girls in the country including ineffective systems of accessing justice, limited access to resources and economic instability at the family level.

Other factors were outdated social

and young people in decision-making processes, and low levels of awareness among women and young people on their rights and how to counter vio-

TAWLA's executive director Tike Mwambipile, who is a lead party in the Mwanamke Imara project, said they have increased women and girls' access to justice on issues based on inheritance, land and property rights, as well as on gender-based violence.

Moreover, she said, women and young people's participation in leadership, decision-making structures and governance also increased. The project has strengthened women and youth economic groups with enhanced ac-

sources by financing the women groups to undertake economic projects.

For his part, USAID project management specialist, Adam Lingson said they injected \$4million in the project for active participation of women and youths in roundtable discussion as well as to increase women's access to resources, education, information and decision making.

Opening the review meeting, Director of Gender Department in the Ministry of Community Development, Gender, Women and Special Groups, Badru Rwegarulira expressed the government's commitment to addressing gender based violence and other challenges facing women and youths.

Moro has 2000-km of enviable all-weather roads, says TANROADS

THE Tanzania National Roads Agency (TANROADS) said here vesterday it is proud of Morogoro Region's 2,071.23-kilometre all-weather road network and called on users to cooperate in preserving the costly infrastruc-

Reporting on the agency's role in building and maintaining the road network in one of Tanzania's key foodproducer regions as short rains are around the corner, Morogoro TAN-ROADS manager Lazeck Kyamba, said durability of roads essentially depends of proper use, appropriate and timely maintenance.

"Road users, too, are important stakeholders in preserving the roads," he said

"We are proud of this enviable network. Remember our region is the nation's doorway linking the coast and Tanzania's central regions. So, we have ensured these roads are in good shape and are passable the year round. We appeal to all users to join us in preserving the roads," he told journalists reporting on the region's preparations before the short rains start later this

The TMA has warned that the com-

ing rains will be average or above average and has called for keen precautions to stave off vulnerability of the population and damage to roads.

Eng. Kyamba explained that the region has 849.42 kms of trunk roads -384.55 km tarmac and 464.87 km gravel. The regional roads network, he said, has a total of 1,221.81 kms -out of which 1,054.31 kms tarmac and 167.50 kms gravel.

The agency has constantly its eyes on Kiyegeya Bridge because, he said, it is an important link between their region and other regions in central Tanzania.

He said the agency is providing convenient services to cargo and other transporters at Mikese, Dakawa and Mikumi weigh bridges and appealed for cooperation from transporters in observing weight limits.

He said the government is committed to building good and durable roads so existing roads have to be preserved and protected. KOICA donates assortment of items to Dar's orphanage

Agency (KOICA) has donated an assortment of items, also cooking and sharing food with children at Maunga Orphanage Centre in Kinondoni District, Dar es Salaam Region.

Over 100 children from the local community and at the centre joined the lunch event which was full of Korean dishes with an aim to strengthen relationships and create a culture of volunteerism.

Speaking during the event at the weekend in Dar es Salaam, KOICA Tanzania programmes manager, Minjung Son said the event also meant to improve the living environment of the centre, install five new solar powers and celebrate Korean Culture Day for Children.

To start with, briefly explaining, KOICA dispatches volunteers, global cooperative doctors, advisors, and KMCO (KOICA Multilateral Cooperation Officer) through World Friends Korea (WFK) programme to more than 40 developing countries around the world, including Tanzania.

Minjung said KOICA currently dispatches about 30 volunteers in four different regions of Dar es Salaam, Zanzibar, Mwanza, and Arusha, working in various sectors, such as education, health, community development, and social works.

They usually work in their own organizations in each field and run their own projects as well.

"However, our volunteers sometimes cooperate and organize meaningful activities. For example, recently there was "preventing sexual violence against student" project held in Mwanza. Also, there are "special training for medical staff at hospitals" and "wash hand education for early childhood."

"We hope that children who joined this volunteers' activity have great memories and they enjoy and dream of the future in an improved environment. 

FUO implores government to review current policy on Nile perch business

THE fishers Union Organisation (FUO) has urged the government to review the current policy on Nile perch business in order to recognize the value of fish maws and thus bring win-win situations between fishermen and processors.

According to the union, currently processors are the ones who are benefiting immensely more than fishermen and the government from the Nile perch business due to the maws available in the product.

Fish maw also known as swim bladder is a white hard membrane found inside the body of the Nile perch.

The FUO executive chairperson Juvenary Matagili said that fishermen have been selling whole fish to processors who then produce other products from the catch for sale and earn more money.

In an interview with this paper, more valuable products, were not

in the policy caused the government to lose its due revenues to the precious fishery products.

Citing an example, Matagili said that with processors getting fillets from fish, they also get maws, skins, oil and shells that are used for decorations to mention just a few.

"In that regard business of Nile perch should principally be in two categories with the number one being maws as they are selling highly and then comes to fillets," he said.

He said that it is high time now the government should recognise and formalise the trade in fish maw so as to ensure that it contributes fairly to the well-being of the fishermen and country at large.

Matagili pointed out that upon establishment of fish processing industries in the country, in the lake zone as early as 1990s much attention was put on Nile perch fillets for export and the fish maws, which are considered.

"This shows that there was something hidden by processors on the products as they could define what to do with the fishery material from the start but it came to be known that are more valuable than fillets and other fishery products later on", he noted.

He said that if a segment of fish maws was in the fisheries policy, the government could collect its due revenues from the products accordingly since the industries started

Processors should pay fishermen extra money for fish maws and unlike now when they just buy whole fish based on weight to get fillets and remain with other products," he insisted. "Big business for Nile perch are maws and not fillets, which is why the materials are selling at higher price than anything else from that aquatic organism," Matagili said.

He added that if the Nile perch will not be sold separately from their maws it is quite obvious that fishermen who spend sleepless nights on the lake fishing will continue to be exploited by processors with the government also losing revenues in tax.

New envoy to China has plenty to learn as to reviving Friendship Mill

strategic exchanges are likely to be heard in Tanzania as the government awaits to hear from the new ambassador to China, Khamis Musa Omar, tasked to solve challenges facing some crucial projects. One is the Mchuchuma coal and Liganga iron ore projects, which are almost inextricably linked, and similarly, facilitating the revival of the Friendship Textile Mill. Reports say that Mchuchuma and Liganga projects were supposed to be carried out by a Chinese investor, but have stalled for more than a decade.

The proverbial coal and iron ore sites in Ludewa District, Njombe Region would in a different environment have enabled the country to begin an iron and steel industry a long time ago, but there were no strategic conditions for that situation, and it doesn't strictly speaking exist.

It would demand a fairly closed economy where the country is seeking to industrialise from its own resources, fairly divorced from world market mechanisms. Again, the structure of public expenditure would reflect that reality, of a frugal situation as it was in China.

It is doubtless that the relevant ministry here has conducted ground work in that direction, as Dr Hashil Abdallah, the Industry and Trade permanent secretary, reviewed the issue with the new ambassador. It is unclear if there are specific Chinese investment proposals that are on the table, as the matter is far from new, just like the TAZARA refurbishing project. Given that President Samia Suluhu Hassan was in China not so long ago, and the coal and iron project as well as Friendship Textile mill remain

LENTY of academic and unsolved, there is a structural problem. If anything, the issue is the time lag that there is in how the projects were initiated in the mid-1960s and how this fits into the global strategic map at present. What is noticed is that Tanzania is mirrored in largely the same mood as at that time, while China has been changing over that period, and sees the two projects in entirely different mirrors compared to ourselves. What the permanent secretary talked about was cooperating with investors, but for cloth?

> One elementary issue that his Chinese hosts might inform the envoy is that every industrial project has two facets, its productive activity or total value of investment, and the land it is sitting upon (or located). When a productive facility is no longer competitive in the market, its land can be used for some other activity if market mechanisms are working. That is the snag here, that the land belongs to the government so its value is unnoticed, and it isn't part of the business discussion but a textile factory. How does it compete, here or outside?

> There are obviously many business people from China that the ministerial authorities could cooperate in their suggestions, but they aren't convinced that they should produce clothing. Indeed under current conditions the government can look for a local investor with a ready market like the controversy a few years back on police or other uniforms. It appears the right group to talk to is SUMA JKT rather than Chinese businessmen, and if there are issues like debt that hasn't been cancelled, the government could take that up. It isn't firstly a diplomatic effort with the new envoy but finding the right sort of local investor.

Mental health crisis tied to emptiness, need for regular paying jobs for youth

demands investment to avert a nationwide mental health crisis, planners and legislators will not have easy answers on the issues. Unlike a pandemic where it is the public health environment that is at issue, mental health relates to failure to individual failure to cope with the demands of life. How does the government invest in such a manner that people cope up with life, as failure to cope is a crisis of the social system, leading to generalized drunkenness, when people have little to care for.

Often times there has been a loud cry about declining morals, which has been seen as a problem of moral infiltration via internet fashions and role models. There is plenty in that, especially where it is actively encouraged but it can also be linked with mental health situations, the sort of desperation that youths meet when they can't rely on family, often without a second parent, and no income in a regular manner to live on their own. What this needs is regular allowances for the unemployed and being involved in regular public works where possible, etc.

BBT agro-sector initiative has yet to yet absorb even 10,000 youths whereas there are more than one million youths living between hope and desperation, Health sector investments would focus on mild drugs if there is pain, and community health workers who could advise on those issues as well. Much of that can be medically addressed as it is socially backed, not when desperation is at

This suggests specialised health centres specifically for mental health, while all that can be done at the moment is to add a few mental health specialists in some hospitals. So many dispensaries and health centres lack equipment and staff, and from there to specialized mental health hospitals is decidedly a tall order.

The minister noted remarkably that orkers at workplaces face the threat of non-communicable diseases apart from mental health issues. As a matter of fact, mental health is an additional non-communicable disease, but its origin isn't exactly lifestyle or failure to do physical exercises. Here the matrix of issues is different, as while NCDs usually have to do with relative luxury, mental health dislocation has more to do with desperation in life, and poverty can cause it too.

HIS week, member states of the United Nations Human Rights Council in Geneva will vote on creating a mechanism to investigate alleged crimes by the parties to the conflict in Sudan. This would lay important groundwork for holding perpetrators to account.

September, nearly In Sudanese, regional, and international organizations called for the UN's top rights body to take this clearly warranted action in Sudan.

Since fighting erupted in the capital, Khartoum, in April 2023, both the Sudan Armed Forces and the Rapid Support Forces (RSF), an independent armed group, have repeatedly violated international humanitarian law, launching indiscriminate attacks in densely populated areas, destroying critical infrastructure, and blocking

million people have been displaced.

In West Darfur, the RSF and allied Arab militias have targeted Massalit and other non-Arab communities, killing and injuring civilians - including fleeing women and children - and burned down towns. They have committed sexual and gender-based violence against women and girls, targeting them because of their ethnicity and at times for their activism. Reports of expanded recruitment and foreign military support point to a broader

We have seen such atrocities before in Sudan, particularly in

humanitarian assistance. Nearly five Darfur, for which there was never any of a desperately needed, robust accountability. This has helped fuel the current violence and sent perpetrators the message that there will be no

consequences for their actions. This week, Human Rights Council members will have the opportunity to contribute to correcting course by supporting a resolution on Sudan that will create an independent mechanism to ensure atrocity crimes are investigated, vital evidence is preserved, and recommendations for accountability are made.

Establishing an investigatory body will not end abuses or deliver justice on its own. It is, however, a vital part

international response. It could bolster and expand upon existing accountability efforts, including those being undertaken at the International Criminal Court and elsewhere. It would also offer an opportunity for the many Sudanese to have their stories heard.

Human Rights Council members have an opportunity - and a responsibility - to use their vote to send a message of deterrence to the warring parties and, importantly, of solidarity with Sudan's people and hope to survivors, victims, and their

families. They should do precisely that.

The case for increasing family planning uptake to cut maternal mortality

REATING awareness on contraceptive use to communities can bring about positive results in terms of promoting good health, thereby scaling down maternal mortality rates which have remained stubbornly high over the last decade, at around 500 per 100,000 live births.

This could in turn improve our country's development and create wealth amongst communities by increasing production of goods and services which in turn contribute to economic growth.

Dr Mzee Nassoro, acting assistant director in the reproductive and maternal health department in the ministry of health said this at a recent discussion centred on family planning and its importance in scaling down maternal mortality rates.

He pointed out that the government through the ministry of health was partnering with various stakeholders to scale up FP uptake in order to reduce maternal mortality.

Among the stakeholders partnering with the government on the initiative, he said include Jhpiego, Marie Stopes Tanzania and many other health-oriented organi-

"As government, we are committed to providing family planning awareness from primary and secondary schools as well as universities," he said at the event organised by a media outlet in Dar es Salaam.

Dr Nassoro said strengthening FP services in public and private health facilities would not only reduce early pregnancies, but also ensure that youth spend a lot of time in creation of wealth.

The Tanzania Demographic and Health Survey (TDHS) 2022 report points out that maternal mortality is still unacceptable higher in the country. It says the effective use of family planning could prevent maternal deaths by more than 30 percent.

However, the report states that prevalence of family planning uptake is still low especially in rural areas despite the services being provided at no cost in all public facilities.

Tanzania is set to reduce maternal mortality rate to 292 per 100,000 births come 2025 by ensuring it increases the uptake on family planning methods especially in rural areas, according to health reports.

The move would not only ensure that it prevents unwanted pregnancies which most often leads to illegal abortion and loss of lives, but as well ensure good health to mothers before deciding when to conceive.

Dr Nasoro noted that health experts and various stakeholders need to create awareness to ensure there is no stigma, humiliation and discrimination when accessing family planning services.

"Family planning is one among many ways that can scale down maternal mortality by reducing unwanted pregnancies amongst youth, thereby reducing illegal abortions that result into deaths," he said.

Tanzania through the ministry of health has been proincluding the use of pills, condoms, injectables, female



sterilization and insertion and removal (implant) method.

The country has also come up with various supportive policy frameworks for the provision of family planning services which emphasize scaling up and strengthening contraceptive use as a priority. The National Population Policy 2006 also recognizes the need to educate women about the importance of family planning.

Dr Gloria Shirima, a family planning specialist with Jhpiego said her organisation is working closely with the government to improve FP uptake and scale down maternal mortality by at least 30 percent.

"We collaborate with the government to create guidelines to health experts on family planning to ensure that they abide by

their ethical guidelines in serving the communities," she said. She added that her organisation is working more closely with communities in the Lake Zone region after discovering abnor-

mally high maternal mortality rate in the zone. "Health experts have been talking to pregnant women and moting numerous contraceptive methods to women, their partners during visits to clinics and health facilities in general on the importance of family planning. This has allowed

clients to decide in the right method of contraceptive to better space their children," she said.

The Jhpiego expert also pointed out that the focus of her organisation and the government is to ensure that married women can have a spacing of at least two years after giving birth.

Such awareness, she said, has been so far achieved in Lake Zone due to the fact that most of women deliver their babies at health facilities where they come into contact with health experts and receive counseling and awareness on contraceptives use.

"We managed to get to hard-to-reach areas and created awareness on family planning and we have seen uptake increase the Lake Zone which has been badly affected and this also cuts down maternal mortality," she said.

Evidence shows that low uptake of family planning contributes to high fertility rates, which is as one of the risk factors for maternal mortality. Low uptake of family planning services in most Sub-Saharan countries is associated with inadequacy in health literacy among women of childbearing age, according to health

The family planning awareness is therefore one of the most sig-

nificant social determinants of health and is, thus, essential in changing people's attitudes towards accepting and taking various recommended family planning methods.

Commenting during the discussion, Dr Elizabeth Sanga, a public health practitioner said it is also important to look at blood loss in pregnant women during delivery, infections after and before delivery and high blood pressure besides family planning as far as maternal health is concerned.

"Our clinics and health facilities also need to give proper attention to pregnant women if we are to talk about scaling down maternal mortality rate," she

Geofrey Sigalla, Senior Programme Officer at Marie Stopes Tanzania said the organisation is working with the government to build capacity to health workers and it runs family planning campaigns in schools and communities.

William Mbaga, a participant, asked health stakeholders to create awareness on sexual reproductive health before embarking on literacy awareness on contraceptive use to the public.

He said lack of awareness on sexual reproductive health in the communities among the reasons most people hesitate to buy the idea due to lack of understanding on the importance of contraceptives in planning and spacing their families.

Lilian Lema, a digital content developer based in Dar es Salaam who was a participant in the session raised the issue of youth-friendly family planning services as one of the hindrances to up-

She added that lack of proper information on contraceptives deny the youth an opportunity to visit clinics and access contraceptives, citing stigma as being among the reasons.

On a positive note, Tanzania has recorded a significant increase in the utilization of modern family planning methods among women from seven percent in 1991 to 31 by last year, 2022. According to the World Health Organization, almost 60 percent of women of childbearing age use family planning methods globally.

OPULATION censuses traditionally conducted by countries every ten years are not done for fun given the financial resources they gobble up. Accurate census data is valuable and essential for economic development, healthcare, education, business planning, transportation and decision making.

This is because census plays an essential role in giving detailed information on the population density. But conducting a census and having the data is one thing and disseminating its report for public consumption is

Anne Makinda, Commissioner of the 2022 Population and Housing Census, is of the view that journalists and media outlets in Tanzania are largely responsible for the unprecedented success of the latest census.

Makinda who is former Speaker of the National Assembly spoke in Mwanza Region recently while opening a training organized by the National Bureau of Statistics (NBS) to impart skills to journalists from Kagera, Mara and Mwanza regions about census data reporting.

"The 2022 Population and Housing Census results are for integrated plans and development of the country and guide allocation of resources at all levels based on actual population", she said.

She commended the role played by journalists in the entire census exercise, noting that the awareness created through reporting made a good number of the citizens positively respond to the enumeration, enabling the 99 percent success of the targeted goal.

"I am very glad to see a good number of women journalists here. In the past when I was the information minister and Pan African News Agency chairperson, the situation was worse. Women's journals were marginalized. I think this has remained a history. There is equality in the media fraternity," she said.

But she was quick to note that although the awareness part was excellently done, reporting the data obtained from the 2022 Population and Housing Census is yet to be done.

She said that the government invested heavily in information and communication technology to ensure the success of enumeration countrywide, explaining that 99.9 percent of all households in Tanzania were counted.

NBS have done a commendable job. You journalists are now challenged to use the census data to critically inform the uninformed," she said.

Said Amir, information and communications expert at NBS said that NBS is the central depository for all official statistics in the country, responsible for collection, compilation, analysis and dissemination of official statistics.

"Our work is professional and accurate. You can't judge the data by using mere open eyes. If there is someone in doubt of our statistics, they are welcome to go ahead with research to prove us wrong,"

The 2022 Population and Housing Census released on 31st October 2022 shows that Tanzania has a population of 61,741,120 people out of which 59,851,347 are in mainland Tanzania and 1,889,773 are in Zanzibar.

Dar es Salaam is the country's most populous region, with 5.38 million people, followed by Mwanza with 3.69 inhabitants. Of the 61,741,120 people, women are 31,687,990 equal to 51 percent and men are 30,053,130 equal to 49 percent, according to the census report.

The data show that just 10 years ago when the preceding census was released, Tanzania had a population of 44,928,923, meaning there has been an increase of 16,812,197 people which corresponds to a growth of +3.2 percent per year between 2012 and 2022.

According to the World Population Prospects 2022 of the United Nations, more than half of the projected increase in global population up to 2050 will be concentrated in just eight countries, namely the Democratic Republic of the Congo, Egypt, Ethiopia, India, Nigeria, Pakistan, the Philippines and Tanzania.

The populations of the Democratic Republic of the Congo and Tanzania are expected to grow rapidly between 2 percent and 3 percent per year over the 2022-2050 period.



China-sponsored programme empowers young train drivers in Africa

ADDIS ABABA/ZHENGZHOU

ANKETSEBRHAN Girma, a 28-year-old train driver at the Ethiopia-Djibouti Standard Gauge Railway, has long dreamed of becoming one of the pioneer modern train drivers in Ethiopia.

"When I saw trains, especially trains of China, on TV and online, I thought it was very cool. How to operate a train as it is so long? I really wanted to figure that out," Girma said of her childhood dream.

In 2018, Girma went through fierce competition and entered the Ethiopia-Djibouti Standard Gauge Railway Share Company after graduating from Adama University, becoming the first female to drive an electrified train in the East African country.

Since July this year, Girma, an assistant driver with three years of experience, has been in China along with 27 colleagues to receive a sixmonth training for electrified train driving.

During the training at Zhengzhou Railway Vocational and Technical College, Girma sensed the warmth from her Chinese teachers. "When I felt sick, my tutor drove me to the hospital and accompanied me all the time. They are both my teachers and my friends," Girma said.

In 2019, the college in Zhengzhou signed an agreement with the Ethiopia-Djibouti Standard Gauge Railway Share Company to train electric locomotive drivers for the Ethiopia-Diibouti Standard Gauge Railway, or shortly Ethiopia-Djibouti Railway.

The 752-km railway, also known as the Addis Ababa-Djibouti Railway, is the first electri-

fied transboundary railway in Africa, a flagship project under the framework of the China-proposed Belt and Road Initiative.

The first group of 34 trainees have fully commanded the skills of driving, monitoring, diagnosing and maintaining electrified trains, and have the capability of independently driving them after eight months of study in the col-

After returning to their homeland, they have quickly become the backbone of the Ethiopia-Djibouti Railway, safely chauffeuring across the vast East African plateau.

As one of the 34 trainees, Dejen Gezu is among the first in the country to get a license for electrified trains issued by the Ethiopian Ministry of Transport and Logistics.

He is now tasked with dual responsibilities of safely chauffeuring the Chinese-built Ethiopia-Djibouti Railway and supervising fellow train drivers such as Girma in their pursuit of fully mastering the trains.

"Before I came to China, I dreamed of becoming a train driver who could drive the trains independently like Gezu," Girma said.

The Chinese operation team has always attached great significance to the construction of the operational capacity of the Ethiopia-Djibouti Railway, and has endeavoured to provide the local employees with technology transfer and skill training.

With the help of Chinese technology, the railway has cut the shipping time for goods from more than three days to less than 20 hours, and reduced the cost by at least one-third, substantially facilitating the imports and exports of

Africa. "As Ethiopia has no sea or port, it takes a few days to deliver goods to and from Djibouti by road transport, which is a waste of time and energy. The Ethiopia-Djibouti Railway can greatly

THE country's coffee consumption has increased from five to seven per cent while the government puts strategies to increase the consumption level to 15 per cent by 2025/26.

In addition, the present average production of the strategic crop in the country has increased from 50,000 tonnes to 82,000 tonnes this year.

Speaking on Monday on the completion of preparations for 2023 Coffee festival slated for October 27 to 29 this year in Moshi town, Kilimanjaro region, the Director General of Tanzania coffee Board (TTB) Primus Kimario said that in order to attract more coffee drinkers and production, it is the government intention to spur production to reach 300.000 tonnes per year.

"We intend to produce 20,000 coffee seedlings every year and this will help us to increase production to 300,000 tonnes.

"This prominent crop is cultivated in 17 regions at the moment. The regions that have grabbed the opportunity to grow coffee on a large scale include Katavi which was not a coffee producer in the past.

What governments need to do to end child marriage in Africa

LMOST one third (32%) of women aged 20 to 24 in Eastern and Southern Africa - around 50 million were married before 18 years old. To address this pervasive problem, the Southern African Development Community (SADC) Parliamentary Forum has adopted the SADC Model Law on Eradicating Child Marriage and Protecting Children Already in Marriage, a legal framework providing a comprehensive, integrated approach to ending child marriage and protecting children already married.

New research reveals that while some SADC countries have taken commendable action to strengthen legal protections in this area, other Member States have made little or no progress.

These findings feature in new policy briefs produced by Equality Now in partnership with the United Nations Population Fund (UNFPA) and the Southern African Development Community Parliamentary Forum (SADC PF). Ending Child Marriage In Southern Africa: Gaps And Opportunities In The Legislative Frameworks and Domesticating The SADC Model Law On Child Marriage analyzes laws across the 16 SADC countries and identifies positive legal advances, best practices, and

A third brief, Ending Child Marriage in Eastern and Southern Africa: Challenges in Implementing Domestic Laws and the SADC Model Law on Child Marriage, examines the implementation of domestic and regional laws on child marriage, focusing on Malawi, Uganda, and Zambia as case studies.

While the SADC Model Law is having a positive impact, its success depends on effective implementation and enforcement by states. To assist governments, the briefs also provide recommendations on strengthening elimination efforts through good application of child marriage laws and policies.

SADC model law

Child marriage severely harms girls and exposes them to various human rights violations. It impedes their right to education, as marriage often entails being forced to drop out of school to assume adult responsibilities. This lack of education perpetuates a cycle of poverty, limiting girls' opportunities for personal development and financial independence.

Early marriages increase the likelihood of early pregnancies, posing significant health risks to girls whose bodies aren't mature. This can result in complications during pregnancy and childbirth and is associated with higher maternal and infant mortality.

Moreover, child brides are often subjected to domestic violence and marital abuse as they lack the power to assert their rights, and alternative safe spaces are rarely available.

The SADC Model Law defines a child as any person below the age of 18 and recognizes that child marriage violates children's rights, including the right to education, health, and protection from harm. It calls for prohibiting child marriage, creating prevention and response mechanisms, and promoting birth registration. Other components include supporting child

brides and their families and ensuring access to education and healthcare.

The Model Law sets 18 as the minimum age for marriage for both boys and girls without exception and is applicable to all types of marriages - whether under statutory, religious or customary law - with marriages involving a child declared null

To address the complex root causes contributing to child marriage, the Law promotes a comprehensive, multi-sectoral

approach based on coordination and collaboration between legal, education, healthcare, and social services sectors.

Inconsistencies and weak implementation of laws

It is important to recognize that some progress in reducing child marriage has been achieved in Eastern and Southern Africa. However, progress is too slow as the prevalence rate has only reduced from 39% to 32% over the past 25 years, while other regions have made much faster progress.

At the current trajectory, it is estimated that child marriage in the region won't end until 2240.

Concerningly, most progress in Sub-Saharan Africa has occurred amongst the wealthiest families, while in poorer communities, there has been a rise in child marriage. This perpetuates an unacceptable and deeply entrenched divide along socio-economic lines and demonstrates how governments need to focus more on prioritizing elimination of child marriage.

Problems include a lack of adequate resourcing to programs addressing child marriage and a general lack of effective implementation of laws and policies, which feeds into low prioritization of decision-making and lack of action on child marriage.

Out of the 16 countries in Southern Africa, only six countries - DRC, Malawi, Mauritius, Mozambique, Seychelles, and Zimbabwe - set 18 as the minimum age of marriage for both boys and girls, with no exceptions.

Five countries - Angola, Botswana, Comoros, Madagascar, and Namibia - set the minimum age as 18, but allow exceptions for customary and religious marriages and for marriage with consent from judicial or other government officials

Statutory law in the remaining five countries - Eswatini, Lesotho, South Africa, Tanzania and Zambia - provides for a minimum age ranging between 15 and 18. These are different for boys and girls, with the boys invariably having a higher

In addition, all five countries allow for judicial or parental consent to lower the age of marriage even further, and in Eswatini and Lesotho, there are exceptions for customary law that permit marriage from the age of puberty.

These domestic laws violate the international and regional human rights standards that SADC countries have signed on to. Deeply entrenched cultural practices, poverty, and limited access to education and sexual and reproductive healthcare are slowing progress and hindering reform efforts.

Such is the case in Tanzania. In 2016. the Tanzanian High Court gave a landmark ruling that struck down sections of the Marriages Act of 1971, which set the marriage age at 18 for boys and 15 for girls, with additional exceptions allowing marriage at 14 with court approval.

Despite the ruling being upheld by the Court of Appeal in 2019, Tanzania's government has thus far failed to amend the law accordingly.

However, there is encouraging progress elsewhere.

In Zimbabwe, the Constitutional Court ruled in 2016 that child marriage is in-

In addition, the country's National Action Plan and Communication Strategy to End Child Marriage requires registration of all marriages.

In February 2023, the Constitutional Court of Uganda issued a ground-breaking decision in the case, Kirya Martins & Aboneka Michael v. Attorney General, striking down provisions of customary and religious law, including in Hindu and Muslim family laws, that conflicted with the minimum age of marriage set out in the Constitution.

Prioritizing legal reforms to end child marriage

Contradictory provisions in different laws on child marriage create confusion in the application of the law and the inconsistencies make jurisprudence difficult to interpret and implement. All SADC countries must prioritize legal reform and enact robust legislative and policy frameworks that comply with international and regional human rights obligations. This means setting the minimum age of marriage at 18, without any exceptions.

While legal reform is crucial, governments must close the divide between legal approaches and those aimed at influencing social and community norms. Prosecution and punishment of perpetrators should be accompanied by a multi-sectoral approach with an ample budgetary allocation.

Community awareness-raising is key and requires comprehensive sexuality education and behavior change campaigns that foster understanding about the negative impact of child marriage on girls and the wider society.

So too is the empowerment of girls through education and other opportunities that increase their agency and decrease their vulnerability to human rights violations.

Child marriage prevention must also be fully integrated into climate change mitigation and disaster response strategies. Africa is bearing the brunt of global warming, with extreme weather events, prolonged droughts, and food shortages intensifying economic hardships, conflicts, and forced migration.

Girls are especially vulnerable, as families may view marrying daughters as a strategy to cope with financial difficulties and as a way of protecting them from the heightened risks of sexual violence and exploitation found in unstable environments.

Having the right laws in place is the foundation upon which access to protection and justice is built. But only through a multifaceted approach championed by governments can we create a future where every child and young woman in East and Southern Africa can reach their full potential, free from the shackles of child marriage and early motherhood.

The UN commemorates International Day of the Girl Child on October 11 -- an annual and internationally recognized observance that empowers girls and amplifies their voices.





Energy solutions multinational partners local firms in bid to cut costs

A multinational specialist in distributed energy solutions, Clarke Energy, has partnered with industrial companies in providing selfgenerated gas power plants by using natural gas.

The company has emerged with over 45 MW already installed natural gas-to-power solutions to offset the national grid supply.

Speaking recently at the power generation networking and cocktail evening in Dar es Salaam, the Clarke Energy Managing Director for Africa, Yiannis Tsantilas said that they have now delivered over 45MW of installed power generation capacity in the country.

"These solutions provide resilient and reliable selfgenerated electricity supply for manufacturing and processing and independent power producers (IPP) who sell power as a service (PaaS) to other industries. the existing customer base are notable players are in the steel, glass, flour mills, tobacco and oil and gas industries," he said.

He added that the en-

gines installed by the company are supported by in-country service capability and several spare parts warehouse facilities.

"We were delighted to hold this networking evening and engage in project discussions whilst exchanging thoughts on emerging trends in the energy sector in Tanzania." He said.

On the other hand, the General Manager of Clarke Energy, Emile Hamman, clarified that aside from reliability, an additional benefit of self-power generation utilising natural gas includes significant cost savings compared to generating electricity from other fuel sources.

"Most companies in manufacturing and processing, including food & beverage, cement, plastics packaging, textile, pharmaceuticals, and mining, can save up to 15-25 per cent off energy costs by adopting gas-to-power solutions. The savings can double if the customer requirement includes heat recovery, which means utilising waste heat from the exhaust to generate steam, hot water or

He said, once a gas power plant has been installed, it is connected to a network of gas pipelines or bottled variants transported as compressed natural gas (CNG) or liquified natural gas (LNG) to the customer site by a gas supplier. The locally based team of Clarke Energy engineers will commission the power plant, hand over the gas genset to the customer, and kick off the service maintenance plan.

Currently Tanzania's total power installed capacity is 1,605.86 MW (2021), mostly generated from natural gas dropower (31percent), petrol (18percent), solar (1percent), and biofuels (1percent).

Natural gas production increases by 16 per cent

Production of natural gas among two producing sources including Songo Songo and Mnazi Bay gas fields, increased by 16 percent to 81.4 billion standard cubic feet during the financial year 2022/2023, from 70.29 billion standard cubic feet recorded in 20211/2022.

Data by the Tanzania Petroleum Development Corporation (TPDC) shows natural gas production at Songo Songo gas field, which accounts for 58.4 percent of produced gas increased by 16 percent to 47.65 billion standard cubic feet, compared with 40.99 billion standard cubic feet respectively.

On the side of Mnazi Bay gas field, which has 41.6 percent of production share, natural gas

produced also went up by 15.7 percent to 33.91 billion cubic feet in 2022/2023, compared to 29.30 billion standard cubic feet produced in 2021/2022.

On Consumption, TPDC data

shows also increased by 13.6 percent to 80.88 billion standard cubic feet during the last financial year, compared to 71.21 billion cubic feet produced during the 2021/2022 financial year. Power generation plants,

which consume 85 percent of total produced natural gas, increased their consumption by 18 percent to 68.78 billion standard cubic feet in 2022/2023, compared with 58.22 billion standard cubic feet in 2021/2022. However, on the side of in-

dustries, which accounts for 14.8 percent of total natural gas, consumption decreased by 7.3

percent to 11.99 billion standard cubic feet in 2022/2023, compared to 12.93 billion standard cubic feet consumed during the previous year.

The consumption by vehicles increased by 96 percent to 87.4 million standard cubic feet during the last financial year, compared to 44.6 million standard cubic feet recorded in 2021/2022. However, vehicle consumption of natural gas is still lower than 0.2 percent of total consumption.

Households' consumption nearly doubled to 4.7 million cubic feet from 2.1 million standard cubic feet, while others consumption went up by 7.3 percent to 11.3 million standard cubic feet in 2022/2023, from 10.6 million standard cubic feet recorded in

SINGAPORE

OIL prices eased on Tuesday after rallying more than 4 percent in the previous session, with traders cautious as they watched for potential supply disruptions amid military clashes between Israel and the Palestinian Islamist group Hamas.

Brent crude fell 56 cents, or 0.6 percent, to \$87.59 a barrel at last check, while U.S. West Texas Intermediate crude eased 56 cents, or 0.6 percent, to \$85.82 a barrel.

Both benchmarks surged more than \$3.50 on Monday as the clashes raised fears that the conflict could spread beyond Gaza into the oil-rich region.

Hamas launched the largest military assault on Israel in decades on Saturday, while fighting continued into the night on Monday as Israel retaliated with a wave of air strikes on Gaza.

"There is still plenty of uncertainty across markets following the attacks in Israel over the weekend," said ING

analysts on Tuesday, adding that oil markets are now pricing in a risk premium.

"If reports of Iran's involvement turn out to be true, this would provide another boost to prices, as we would expect to see the US enforcing oil sanctions against Iran more strictly. That would further tighten an already tight market," the ING analysts added.

While Israel produces very little crude oil, markets worried that if the conflict escalates it could hurt Middle East supply and worsen an expected deficit for the rest of the year.

Israel's port of Ashkelon and its oil terminal have been shut in the wake of the conflict, sources said on Monday.

Iran is complicit even though the United States has no intelligence or evidence that points to Iran's direct participation in the attacks, a White House spokesperson said on Monday.

"If the US finds evidence directly implicating Iran, then the immediate reduction in Iran's oil exports becomes a

reality," said Vivek Dhar, an energy analyst at CBA.

"We continue to believe that Brent oil will ultimately stabilise between \$90-\$100/ bbl in Q4 2023," said Dhar, adding that the Palestine-Israel conflict raises the risk of Brent futures tracking at \$100/bbl and above.

In a more positive sign for supply, Venezuela and the US have progressed in talks that could provide sanctions relief to Caracas by allowing at least one additional foreign oil firm to take Venezuelan crude oil under some condi-

USAID support helps school to enhance financial stability

BUNAZI Primary School, located in Missenyi District Council, Kagera Region, is a rural primary school serving more than 1,000 students.

The school serves as an excellent example of how the implementation of the Facility Financial Accounting and Reporting System (FFARS) can lead to significant improvements in financial management and ultimately, student achievement.

For a number of years, the school struggled with financial instability and ineffective allocation of resources.

All that changed in 2017 after the school started using the (FFARS) to monitor income and expenditures.

The USAID Public Sector Systems Strengthening Plus (PS3+) Activity collaborated with the President's Office - Regional Administration and Local Government (PORALG) to roll out FFARS with the aim of helping facilities better manage Direct Facility Financing (DFF).

Introduced in 2017, DFF dramatically changed the way schools-and other public facilities-received funding.

Mkama Waswa, Head teacher at Bunazi Primary School, praised FFARS for its impact on the school's financial planning and decision-making, stating that "With the help [of] FFARS, the school has managed to plan their spending and prioritize urgent needs of the school."

He said that before DFF, government funds to facilities passed through Local Government Authority (LGA) offices where LGAs planned and allocated funding to facilities without considering the priorities and needs of

Now, public facilities receive funds directly from the government While DFF reduced misuse of funds and empowered public facilities to manage their own funding,

Initially, Bunazi Primary School administrators struggled to manage DFF and, as a result, suffered from financial instability and inefficient allocation of resources, though not a planning tool itself, FFARS has allowed school administrators to gain better visibility into school finances which has in turn allowed them to make more informed decisions when it comes to setting school financial priorities.

The head teacher said since the introduction of FFARS, Bunazi Primary School has been able to undertake several important improvements, including installing electricity in the headmaster's and teachers' offices and in the classrooms, renovating school buildings damaged by an earthquake, and improving the school's toilets.

FFARS has also helped school ad-

ministrators better ensure essential school supplies like chalk, paper, and pens are stocked and available to teachers and students.

Teachers at Bunazi also attribute gains in student achievement to changes brought on by FFARS which have improved both the learning and teaching environment.

Mkama said, "Over time, the school has seen significant gains in student achievement, with many students achieving at or above average levels.

The average performance of grade seven students in the national exam from 2017 has been grade A six years in [a] row, while the performance before the introduction of FFARS was grade B, C, and D."

PS3+ continues to collaborate with PO-RALG on FFARS and provides mentoring, advising, and assistance to the government in managing technical support helpdesks.

Currently, more than 28,000 facilities in mainland Tanzania are using FFARS to manage their day-to-day expenditures and produce financial



Coal industry faces job losses from global energy transition

NEW YORK

THE global coal industry may have to shed nearly one-million jobs by 2050, even without any further pledges to phase out fossil fuels, with China and India facing the biggest losses, research showed on Tuesday.

Hundreds of labour-intensive mines are expected to close in the coming decades as they reach the

end of their lifespans and countries replace coal with cleaner low-carbon energy sources.

But most of the mines likely to shut down "have no planning underway to extend the life of those operations or to manage a transition to a post-coal economy," US-based think tank Global Energy Monitor (GEM) warned. Dorothy Mei, project manager for

GEM's Global Coal Mine Tracker, said

to ensure workers do not suffer from the energy transition.

"Coal mine closures are inevitable, but economic hardship and social strife for workers are not," she said.

GEM looked at 4 300 active and proposed coal mine projects around the world covering a total workforce of nearly 2.7-million. It found that more than 400 000 workers are em-

governments needed to make plans ployed in mines set to cease operations before 2035.

> If plans were implemented to phase down coal to limit global warming to 1.5 °C, only 250 000 miners - less than 10 percent of the current workforce would be required worldwide, GEM estimated.

China's coal industry, the world's biggest, currently employs more than 1.5-million people, GEM estimated.

Of the one-million global job losses expected by 2050, more than 240 000 will be in the province of Shanxi alone.

China's coal sector has already undergone several waves of restructuring in recent decades, with many mining districts in the north and northeast struggling to find alternative sources of growth and employment following pit closures.

Kenya plans to scrap taxes on cooking gas

NAIROBI

KENYA has revealed a fresh plan to scrap all taxes on cooking gas and cylinders amid multi-billion shilling investments in the sector in the latest effort to fast-track the country's transition to clean energy

President William Ruto's Cabinet on Monday proposed the tax cuts meant to make the fuel affordable to more households.

"The following have been proposed; removal of the taxes on locally manufactured cylinders, on liquefied petroleum gas (LPG) product as well as on the cost of the cylinder revalidation," said a Cabinet dispatch last evening.

The only tax currently charged on LPG is the Petroleum Development Fund Levy at a rate of Sh0.40 per kilogramme while LPG cylinders attract six taxes, including Value Added Tax (VAT) at a rate of 8.0 percent, Import Declaration Fee of 3.5 percent and Railway Development Levy (RDL) at a rate of 2.0 percent of the cost, insurance and freight (CIF) value.

port duty at a rate of 25 percent of the CIF and excise duty at 35 per-

The proposal comes days after retail prices of cooking gas jumped by at least Sh260 for the 13-kilogramme cylinder to Sh3,160 from Sh2,900 in July. The cost of the sixkilogramme cylinder has also increased to Sh1,380 from Sh1,200 at city stations.

The sector has attracted a growing number of investors, with the latest being the Taifa Gas, owned by Tanzanian tycoon Rostam Aziz.

Taifa Gas plans to build a 30,000-tonne LPG handling facility, setting the stage for a battle for control of the Kenyan cooking gas market that is controlled by a handful of investors, including Mombasabased tycoon Mohamed Jaffer.

The energy regulator, the Energy and Petroleum Regulatory Authority (Epra), said recently it had received more than 13 new applications from existing and new entrants wishing to build berths for handling cooking gas imports

Other taxes on cylinders are im- in Kenya, as the country moves to open up the sector ahead of the price control regime in 2025.

Kenya is currently pursuing an ambitious strategy to increase the number of households using cooking gas by 2025 as part of efforts to curb air pollution and reduce the health complications related to use of kerosene, firewood and charcoal.

Parliament had in July 2021 reinstated a 16 percent VAT on cooking gas, ending a five-year period when the tax had been frozen as the government sought to lower prices and boost uptake.

Removal of the taxes harks back to the Mwai Kibaki era when LPG was tax-free, helping keep prices at an average of Sh1,600 for the 13-kg container in 2007.

The Finance Act 2023 that took effect from July exempted cooking gas from the 8.0 percent VAT, the 3.5 percent IDF and the 2.0 percent RDL. The price of cooking gas had dropped by Sh430 for the 13-kilogramme container and Sh150 for the six-kilogramme cylinder in July following the tax cuts.

Guo Jia, director of business development of Adora Cruises, which operated the cruise, said that the ship carried more than 2,500 passengers on departure, which was close to full capacity.

"The 'Mediterranea' will make four voyages in October to meet the demand of tourists from north China," Guo added.

A tourist surnamed Xu decided to spend the Mid-Autumn Festival and National Day holiday on the cruise, together with his family. The ministry said in a notice that local transport authorities at the ports where cruise ships dock should formulate plans for restoring international cruise transportation and proceed with the work of resumption after obtaining approval from local governments.

The voyages now being undertaken by many cruise ships demonstrate the rapid post-pandemic recovery of China's cruise tourism industry.

On Sept. 27, the cruise ship "Dream" left its home port of Tianjin for a voyage to the island of Jeju, the Republic of Korea. On Sept. 29, the cruise ship "Blue Dream Star" set sail from Qingdao, carrying nearly 1,000 passengers on a journey to the island of Jeju and east China's Shanghai.

"China's international cruise tourism sector is fully recovering step by step," said Ye Xinliang, deputy dean of the School of Management, Shanghai University of Engineering Science.

Chu Jiayi, head of Tianjin Nebula Holiday International Travel Agency, said that once the cruise-operation plan for the "Mediterranea" was released, they cooperated with the cruise company and booked some of the tickets in advance for sales. "We sold all of our booked tickets in early September. Most of the tourists came from outside Tianjin," Chu said.

As the largest cruise home port in northern China, Tianjin International Cruise Home Port has received over 880 international cruise ships and handled more than 4.26 million inbound and outbound passengers.

Dong Zichen, deputy general manager of Tianjin International Cruise Home Port Co., Ltd., said that from Sept. 27 to Oct. 6, the home port received five international cruise ships and about 12,000 tourists.

Europe stocks rise on US dovish fed remarks

LONDON

EUROPEAN shares rallied after dovish comments by Federal Reserve officials brought some risk appetite back to global markets as investors continue to evaluate the potential impact of the Israel-Hamas conflict.

Treasuries jumped, catching up with Monday's government bond rally, when cash trading in the US was closed. The yield on the policy-sensitive two-year Treasury dropped by the most since the end of August, while the benchmark 10-year had its best day since March.

US equity futures edged higher and the dollar was steady after four days of declines.

The Stoxx Europe 600 index climbed more than 1 percent, heading for its best day in a month. Travel and leisure shares led the advance, while basic resources underperformed amid a plunge in iron ore. Energy was the only sector in the red as oil prices dipped after the biggest jump in six months on Monday.

Fed Vice Chair Philip Jefferson said Monday officials could "proceed carefully" following the recent rise in Treasury vields, and Fed Bank of Dallas President Lorie Logan said the surge in long-term rates may mean less need for further tightening. Another slate of Fed speakers today may add to the picture.

"The latest comments from Fed speakers have had a clear risk-on influence on the market," said Benjamin Melman, global chief investment officer at Edmond de Rothschild Asset Management. "There's been a clear change of tone."

At the end of last week, traders had boosted bets on another Fed hike this year as data showed US employment unexpectedly surged in September.

That narrative switched on Monday as central bank officials tamped down speculation of another rate increase in 2023.

The tensions in the Middle East, however, may escalate further after the Financial Times reported a top US general warned Iran to "not get involved" in the Israel-Hamas conflict.

The latest Middle East conflict comes at a time of ongoing geopolitical concerns, with markets also facing a period of moderating global economic growth, according to Solita Marcelli, chief investment officer Americas at UBS Global Wealth Management.

"Against this backdrop, we continue to prefer fixed income to equities," Marcelli said. "We see a better riskreward profile for fixed income, and we recommend investors consider buying high-quality bonds in the fiveto 10-year maturity range. We foresee further cooling in inflation and slower global growth."

Liu Zinan, chairman of Royal Caribbean Cruises Asia, said the company launched the 2024 international cruise line from Shanghai on June 29. Zheng Weihang, executive vice president and secretary general of the China Cruise & Yacht Industry Association, said that after two to three years of recovery, China's cruise market will usher in the "second golden development decade," showing the common development of the whole industry chain.

"We look forward to taking the resumption of cruise ships as an opportunity to accelerate the attraction of international shipping capacity, the development of cruise lines, the innovation of cruise products, the expansion of cruise ship supply, and the competition for attracting passengers, to promote the high-quality development of the cruise industry in Tianjin as well as the northern region in China," Dong said.

Israel-Hamas fighting casts shadow over \$43bn in assets

LONDON

THE conflict between Israel and Hamas has turned the spotlight on billions of dollars in Israel-linked fund assets, as money managers gauge the toll on businesses operating in the war-stricken country.

At least \$43 billion is held in Israeli stocks or bonds by passive and actively managed funds tracked by Bloomberg. And that's taking into account only the funds that have 70 percent or more of their exposure in Israeli securities. Among the products are US-listed iShares MSCI Israel ETF and ARK Israel Innovative Technology ETF, both of which slumped in Wall Street trading on Monday.

Israel's stocks tumbled with the shekel and local bonds following the sudden attack by Hamas over the weekend. Local assets, traditionally seen as a stable spot in the Middle East, had already been rocked this year after government efforts to weaken the judiciary and ensuing mass protests unsettled markets. Concerns about an escalation of the war are rife.

"Ultimately, it will depend on how long the conflict lasts but investors will demand a bit of a risk premium to invest in Israeli assets for a while," said Shane Oliver, head of investment strategy and chief economist at AMP. "The question is whether it ushers in a new round of severe terrorist activity or not, and then whether Iran may get involved."

Israel's stock benchmark plunged 6.5 percent on Sunday, its biggest drop in more than three years, before edging higher in the next session. The shekel weakened to the lowest since 2016 against the dollar even after the Bank of Israel unveiled an unprecedented \$45 billion program to defend

The market turmoil brought about the worst day since March 2020 for BlackRock's \$132 million passive fund on Monday. Ark's fund and the VanEck Israel ETF slumped more than 4 percent.

With factories and other physical assets looking increasingly vulnerable as the war drags on, investors are watching for disruption to business activities and the earnings fallout. There are more than 100 Israel-domiciled companies listed on US exchanges including several technology firms, according to data compiled by Bloomberg. Cybersecurity firm Check Point Software Technologies Ltd., Bank Leumi Le-Israel and chip supplier Nova Ltd. are among those commonly held by foreign investors.

NEW DELHI

Amid the fierce onslaught by Israeli forces on Gaza following the Haas terror attacks, Prime Minister Narendra Modi yesterday had a telephonic conversation with his counterpart Benjamin Netenyahu and reaffirmed his support to the people of the country.

Taking to his official handle on X, PM Modi shared details of his conversation with Netanyahu, posting, "I thank Prime Minister @netanyahu for his phone call and providing an update on the ongoing situation. People of India stand firmly with Israel in this difficult hour. India strongly and unequivocally condemns terrorism in all its forms and manifesta-

Saturday, expressing solidarity with Israel in the wake of the deadly rocket strikes by Hamas, Prime Minister Modi said his thoughts and prayers, and that of his fellow countrymen, were with the innocent victims and their families.

"Deeply shocked by the news of terrorist attacks in Israel. Our thoughts and prayers are with the innocent victims and their families. We stand in solidarity with Israel at this difficult hour," PM Modi posted on X.

Thanking PM Modi for his support, Israel's Ambassador to India, Naor Gilon posted on X, "Thank you again PM @ narendramodi-ji. Since we get SO MUCH support from our Indian brothers and sisters, I'm unfortunately unable to thank each and every one of you personally. Please accept this as my gratitude to all our friends."

At least 900 Israelis have, so far, perished, in the Hamas attacks while over 2,616 were injured, according to latest

In a war update shared by Israel Defence forces (IDF) on X, the IDF said that about 30 hostages have been held by Hamas in Gaza in the ongoing conflict.

It also stated that about 4,500 rockets have been fired from Gaza on Israel after which the Israeli defence forces struck 1290 Hamas targets in Gaza.

The Israeli Air Force continues to extensively attack many targets of the terrorist organizations in the Gaza Strip.

An IDF Spokesperson has confirmed 123 soldiers have been killed in the fight ing, and 50 families have been informed that a relative was kidnapped by Hamas.

As part of its retaliation against Hamas, Israel has mobilised 3,00,000 troops in the last 48 hours. Rear Admiral Daniel Hagari informed about the mobilisation and said the IDF "has never mobilized so many reservists so quickly -- 300,000 reservists in 48 hours.

"This is the largest mobilisation since the 1973 Yom Kippur War when Israel called up 400,000 reservists, Times of Israel reported.

The Israel Defense Forces said it had finally regained control over the border with the Gaza Strip, 72 hours after Hamas terrorists blew through sections of the barrier and launched an invasion that saw over 1,000 Israelis slaughtered or kidnapped.

On Monday Israeli Air Force aircraft attacked several targets of Hamas terrorists in the Gaza Strip. The aircraft attacked a building used by the Hamas in investigations and an operational infrastructure located inside a mosque. In addition, an underground tunnel shaft of the terrorist organization and military infrastructures used by the Hamas were

Desmond Tutu's modest car reminds S. Africans of his values

SOUTH Africa's anti-apartheid hero Desmond Tutu could have chosen practically any car in the world when billionaire Warren Buffett offered to buy him a

But in 2008, the archbishop picked a modest Toyota Corolla with manual transmission over the luxury BMWs and Mercedes Benz favored by government ministers. He gave the cash left over from the US investor's present to the poor.

The Desmond Tutu Intellectual Property Trust, which manages his legacy, has put the old car on show along with his books and possessions in honor of Tutu's 92nd birthday, which he would have celebrated on Saturday.

"We hope this lesson ... by the Arch about us not being tempted by opulence, by being sensitive to the least amongst us is the takeaway people (who have) seen that car will make," Trust chairperson Mamphela Ramphele told Reuters, referring to Tutu by his nickname.

"We cannot but keep that prophetic voice alive to remind us that we can be better, as he would tell us, that we are designed for better things," Ramphele

The car, displayed in Cape Town, the city where the archbishop lived for most of his later life, became a symbol of Tutu's values.

Former president Nelson Mandela, who died in December 2013, described his long-time friend as "the voice of the

Desmond Mpilo Tutu, awarded the Nobel Peace Prize in 1984 for his non-violent opposition to white minority rule, died in 2021.

Moscow clarifying whether Russian nationals present among Hamas hostages in Gaza – Kremlin

MOSCOW

RUSSIA is taking measures to clarify whether any Russian nationals may be among the hostages being held by the radical Palestinian movement Hamas, Kremlin Spokesman Dmitry Peskov said.

"We are in touch with the Palestinians," the Kremlin official told journalists. "Indeed, there was some information that individuals with Russian citizenship are purportedly among the hostages," he said.

According to Peskov, "the necessary interaction is maintained in order to find out whether it is true or not, and what the future fate of these people is."

The Hamas Palestinian radical group is maintaining interaction with Russia because several hostages taken to the Gaza Strip have Russian the Gaza Strip. According to him, the



citizenship, Hamas official Mousa Abu Marzouk told the Al Jazeera TV channel on Monday. On October 8, he claimed that at least 100 new hostages had been captured.

The Palestinians insist that they include not only civilians but also Israeli servicemen, including some senior officers.

Earlier, Ziyad al-Nakhalah, Secretary General of the Islamic Jihad, said that over 30 Israelis had been captured during an operation near

hostages include Israeli soldiers and Jewish settlers.

Tensions flared up again in the Middle East on October 7 when Palestinian militants from the Hamas movement attacked Israeli territory from the Gaza Strip. According to the latest official data, almost 700 Palestinians have been killed since the renewed outbreak of violence, while over 3,700 have suffered wounds. In Israel, more than 900 people have lost their lives and about 2,600 have been wounded.

Hamas described its operation as a response to the aggressive actions of the Israeli authorities against the Al-Aqsa Mosque in the Old City of Jerusalem. Israel has declared a state of readiness for war and announced a total blockade of the Gaza Strip, home to 2.3 million Palestinians.

"Approximately 1,500 bodies of Hamas (militants) were found in Israel around the Gaza Strip," Richard Hecht, Israeli Defence Forces (IDF)'s international spokesperson said in a briefing to reporters.

Hecht said security forces had "more or less restored control" over the area of the security fence around Gaza, which was breached on Saturday by Hamas militants. He added that 35 battalions were deployed in the area around the coastal Palestinian enclave.

The evacuation of residents of communities adjacent to the border had been "nearly completed," he added.

The death toll and injuries from Israeli attacks on the Gaza Strip have risen to 687 and 3,726, respectively, according to the latest update by the Palestinian Health Ministry on Monday. Israel's state-owned Kan TV reported that the death toll from Hamas' attack on southern Israel rose to more than 900.

Following Hamas' surprise attack on Saturday, Israel intensified its air strikes in Gaza on Monday and imposed a "complete siege" on the Palestinian enclave.

"I've ordered to move (from defense) to a massive offensive on a scale never seen before," Israeli Prime Minister Benjamin Netanyahu said in a live address to the nation on Mon-

Later on the same day, the Al-Qassam Brigades, the military wing of the Hamas movement, said that Israel's raids on the Gaza Strip led to the killing of 4 Israeli prisoners and their captive members.

The death toll and injuries from Israeli attacks on the Gaza Strip have risen to 687 and 3,726, respectively, according to the latest update by the Palestinian Health Ministry.

On the other hand, Israel's stateowned Kan TV reported that the death toll from Hamas' attack on southern Israel rose to more than

Al-Qassam Brigades also said that a new air defense system stationed in Gaza has been activated against ongoing Israeli offensives.

It said in a brief statement to Xinhua that it had introduced "a homegrown air defense system of the Metbar 1 model" into "Operation Al-Aqsa Flood" to confront Israeli aircraft.

A short video released on the Bri-

gades' website showed a number of masked members launching missiles using the air defense system.

At night, Israeli Energy Minister Israel Katz announced that "all the water supply pipes from Israel to the Gaza Strip have been disconnected." Israel also halted the passage of goods, electricity and food to the Strip.

"Israeli air strikes hit 86 towers in the Gaza Strip and this led to various damages," told an official in Palestine Telecommunications (Paltel) Company.

Meanwhile, Israeli media outlets said that the Israeli army is pursuing over 40 "terrorists" in Israeli towns.

Citing Israeli military estimates, Israeli media outlets reported that the surprise attack starting on Saturday morning had been planned for a year, and some 800 to 1,000 Al-Qassam fighters had entered 20 villages and 11 bases in Israel.

'No hostage swap talks'

In response to the Israeli threats, Hamas' military wing's spokesman Abu Obeida warned in an audio statement that "any targeting of our people in their homes without prior warning will be regrettably faced with the execution of one the hostages of civilians we are holding."

Gaza's militant groups said about 130 hostages were in Gaza, including dozens with dual citizenship. Thailand confirmed that 11 Thai nationals are held captive by Hamas.

Israel's Foreign Minister Eli Cohen said in a briefing that the hostages include toddlers, women and the elderly, adding that his country was committed to bringing the hostages back home.

The Israeli military also confirmed that both civilians and soldiers had been kidnapped by Hamas militants but did not provide the exact number.

Earlier on Monday, a Hamas official said the Gaza-ruling group has held talks with Qatari mediators over the release of Israeli women in exchange for Palestinian female prisoners held in Israeli jails. Israel later denied that negotiations on

the release of hostages in the Gaza Strip have been taking place, according to an Israeli government official, who spoke on condition of anonymity.

"No negotiations have been taking place," the official said.

Relief and aid

Israel's state-owned Kan TV reported on Monday that at least 900 were killed by Hamas militants in Israel, while the death toll from Israeli airstrikes in Gaza rose to 687, including 140 children and 105 women, according to the Palestinian Health Ministry in Gaza.

The United Nations Office for the Coordination of Humanitarian Affairs (OCHA) announced on Monday that "more than 17,500 families, including more than 123,538 people, were dis-

In this regard, Palestinian President Mahmoud Abbas stressed during a phone call with the UN Secretary-General Antonio Guterres the importance of delivering relief and medical aid to the residents of the Gaza Strip to prevent a "humanitarian catastrophe" in Gaza.

Guterres said that the United Nations is making efforts to provide urgent humanitarian relief aid to the residents there, according to the Palestinian News Agency (WAFA).

Attacks on border

On Monday, Netanyahu said the Israeli military was enhancing security along the northern border, where militants in southern Lebanon had fired mortar shells toward northern Israel on Monday afternoon.

Al-Quds Brigades, the military wing of Palestine's Islamic Jihad Movement, claimed "its responsibility" for the operation carried out on the border with occupied Palestine, injuring seven Israeli soldiers.

COP28 Presidency unveils steps supporting women's leadership in climate diplomacy

THE COP28 Presidency has announced measures to support the representation and participation of women at the UN Climate Change Conference COP28 in th UAE.

The measures include financial assistance to encourage stronger attendance of women delegates, technical training sessions, and support for an international conference.

"Historically, the perspectives and leadership of women have been underrepresented in many spheres of public life and climate diplomacy is no exception," said Razan Khalifa Al Mubarak, UN Climate Change High-Level Champion for COP28, who is also President of the International Union for Conservation of Nature (IUCN) and the second woman to lead the organisation in its 75-year history.

"The COP28 Presidency is mobilising for an inclusive COP. These steps to support women's leadership and participation get us closer to our goal and, I believe, will also have a positive impact on future rounds of the climate talks and on climate activism in general."

The COP28 Presidency will also provide financial support to a Night School for Women Delegates, run by the Women's Environment and Development Organisation (WEDO). The financial support will cover logistical, travel and other associated costs for women delegates attending COP meetings. Founded in 2009 and run by the WEDO, the initiative focuses on climate capacity-building for women from the least developed countries and small island developing states.

Bridget Burns, Executive Director of WEDO, said, "Women's equal participation in climate change decisionmaking is fundamental to just policies that reflect and respond to the needs of the global community. Via the Women Delegates Fund program, this support goes towards strengthening women's leadership and diplomacy skills - particularly women leaders from countries and regions most vulnerable to climate impacts - through knowledge and capacity strengthening on technical issues related to the negotiations, including running mock sessions and practice in drafting interventions."

The COP28 Presidency will also offer financial support for the Global Conference on Gender and Environment Data, run collaboratively by COP28, UN Women, WEDO, UNFCCC, IUCN and UN Climate Change High Level Cham-

The two-day event will take place on 28th and 2th9 November 2023 in Dubai. Speakers and participants will include UN agencies, government officials and policy makers, leaders and commitment makers of the Feminist Action for Climate Justice Action Coalition and the Gender Environment Data Alliance (GEDA), private foundations, civil society organisations, indigenous leaders and local communities and academia.

The goal of the conference is to provide a platform to exchange best practices, leverage innovation and find solutions to common challenges to produce and use data on the genderenvironment nexus.

This assistance will help gather a broad array of speakers, including representatives from academia, civil society, Indigenous Peoples and local communities who may otherwise not be able to travel to the UAE.

COP28 UAE will also host the Arab Women Leaders' Summit in collaboration with WiSER (Women in Sustainability, Environment and Renewable Energy), a global platform that champions women as leaders of sustainable change.

World Mental Health Day: Mental Health is a Universal Human Right says WHO

WHO Regional Director for South-East Asia, Poonam Khetrapal on Tuesday said that this year's theme of the World Mental Health Day, Mental Health is a Universal Human Right, calls for WHO, Member States and partners to accelerate efforts in mental health in

a human-rights based approach. She said, "The focus of human rights has historically been on needs such as food, shelter, and healthcare. However, mental health stands as a critical pillar for

that mental health is a universal human right is acknowledging the relationship between mental health and the overall quality of

Khetrapal added, "Mental health, as defined by the World Health Organization (WHO), is a state of well-being in which an individual realizes their abilities, can cope with the normal stresses of life, can work productively and is able to make a contribution to their community. It is not merely the absence of mental disorders

human well-being. Recognizing but a positive state of mental and emotional well-being. This definition aligns with the broader conception of human rights as not only freedoms from harm but freedoms to lead a fulfilling life."

She emphasised that every individual, regardless of their location, occupation, or identity, is entitled to achieve the highest attainable level of mental well-being. This encompasses the entitlement to safeguard oneself from mental health risks, access to mental health care that is readily available, easily accessed, and of high

quality, as well as the entitlement to freedom and involvement within their community.

Khetrapal said, "It is also crucial to recognize that mental health intersects with various aspects of life, including education, employment, housing, and social participation.

A person's mental well-being impacts their ability to exercise other rights, such as the right to education and the right to work. When mental health is protected, individuals are better equipped to engage meaningfully in society."

"For mental health to be recognized as a universal human right, there must be a transformation of societal attitudes and government

All necessary steps should be taken to protect populations from the risks of mental health conditions that include overarching issues such as climate change, humanitarian emergencies, social factors such as inequity and poverty," she added.

Khetrapal asserted that there needs to be awareness and education to destigmatize mental health

issues. Discrimination and stigma are major barriers that prevent individuals from seeking help and support. Also, mental health services and facilities must be accessible to all, regardless of socioeconomic status, location, or other circumstances.

She said, "Despite mental health being vital to our overall health and well-being, one in seven people are living with mental health conditions in countries of the WHO South-East Asia Region. Mental, neurological and substance use disorders and self-harm (MNSS)

accounts for 23% of all the years lived with disability (YLD) in this Region. Anxiety and depressive disorders were the commonest conditions among both men and women, contributing to almost 50% of the total number of people living with mental disorders in the WHO South-East Asia Region."

The WHO South-East Asia Regional Office has continued to work with its partners to ensure mental health is valued, promoted, and protected, said a release from WHO.

Woven on silk: Stories of civilisation exchange along Silk Road

ILK originates from silkworm cocoons on mulberry trees. Through intricate weaving, it can be made into

Over 5,000 years ago, the ancient Chinese invented mulberry cultivation, sericulture and silk weaving. More than 2,000 years ago, silk initiated economic and cultural exchanges between the East and the West, witnessing the journey of the splendid Eastern civilization entering the world stage.

Today, as an integral part of the fine traditional Chinese culture, silk culture shines ever more brilliantly on the inter-

In ancient Greece, the pattern of the winged horse was created based on Pegasus in Greek mythology. The pattern, displayed on ancient Greek pottery, "flew" all the way across Persia and Sogdiana to China.

Encountered the westward spread of silk, the winged horse became a popular pattern woven on silk products along the

Silk brocade pieces with the winged horse pattern were unearthed along the Mediterranean coast, Central Asia, as well as China's Xinjiang, Qinghai and Gansu. Similar brocade collections can also be found in the China National Silk Museum, the Museum of Textiles and Decorative Arts in France's Lyon, and the Horyuji Temple in Japan's Nara.

This mythical creature, which has appeared in various materials at different times and places, carried people's pure imagination and longing for freedom, speed and strength. To commemorate the successful inscription of the Routes

Network of Chang'an-Tianshan Corridor of the Silk Road on the UNESCO World Heritage List, which is a 5,000 km section of the extensive Silk Road network crossing China, Kazakhstan and Kyrgyzstan, the China National Silk Museum launched an international cultural exchange activity titled the

Silk Road Week in 2020. The activity is held annually in different countries or Chinese provinces along the Silk Road, and has attracted over 20 million visits and more than 200 cultural organizations from 22 countries to participate for four years in a row.

The iconic image of the winged horse inspired the logo design of the activity, showcasing the implication of the Silk Road in charming image of the goddess of flowers

promoting cultural exchanges between China and foreign countries, and mutual learning between Eastern and Western

Spanning thousands of miles, the Silk Road lasts for thousands of years to date. In the 2nd century AD, top-quality Chinese silk sold in Rome was priced at 12 ounces of gold per pound, meaning 454 grams of silk was equivalent to 340 grams of gold. Therefore, silk was known as "soft gold" and once became the most valuable textile

The National Archaeological Museum of Naples in Italy houses a Pompeii fresco titled "Cosiddetta Flora," which depicts the

in silk attire.

Historical records also document how Western nations acquired silk production technology over time. For example, the Great Tang Records on the Western Regions written by Chinese Buddhist monk Xuanzang recorded a story of a princess bringing silkworms to an ancient state in the West.

With the spread of sericulture and spinning techniques, people of different nations innovatively created colorful and diverse clothing cultures according to local conditions. Today, the traditional attire of many countries like the sari in India and Southeast Asia, the Ao Dai in Vietnam, and the robe in the Arab world, still favor silk as the fabric of choice.

China is the first country to invent and utilize silk, and its sophisticated techniques and cultural wisdom nurtured in sericulture and silk production have gained increasing global recognition.

In particular, the sericulture and silk craftsmanship of China, as well as the craftsmanship of Nanjing Yunjin brocade, have been inscribed on UNESCO's Representative List of the Intangible Cultural Heritage of Humanity, which represents the highest standards of ancient textile craftsmanship worldwide.

Additionally, numerous nationallevel intangible cultural heritages, such as Shu embroidery, Song bro-

cade, Zhuang brocade, kesi craftsmanship, Suzhou embroidery, and Shen embroidery, among others, also carry and inherit the history of Chinese silk culture.

On the global stage today, silk dazzles in spectacular fashion, displaying both innovation in silk production and vibrant artistic creativ-

The opening ceremony of the 31st summer edition of the FISU World University Games harnessed technology to visually portray a magnificent brocaded path using Shu embroidery and Shu brocade, alluding to youth worldwide joining together to build a better future.

The medal ribbons at the 2022 Beijing Winter Olympics were woven using the traditional mulberry silk method. Those high-density silk ribbons boast a smooth, soft texture and outstanding tensile strength.

Looking back at history, silk has gone through thousands of years, evolving from a commodity to a bond linking China and foreign nations across vast distances along the lengthy Silk Road. Looking ahead to the future, silk will continue to thrive with vitality on the international stage.

China to open up wider, offering opportunities to world

HINA'S State Council has recently issued a statement outlining its guidelines regarding further optimizing the foreign investment environment and intensifying efforts to attract foreign investments, making more efforts in attracting and utilizing foreign investment.

The statement has aroused active responses from the international community. Many observers said the 24 measures delineated in the document place emphasis on both the macro and micro issues, "offer conveniences for foreign businessmen's work and life in China in detail", and "help boost the economy."

Such comments have fully proven that China, which has continuously expanded high-standard opening up, holds great appeal to the rest of the world. Despite the rise of global protectionism and the reckless push of "decoupling and breaking the chain" by certain countries, the international community still desires to advance open cooperation and share opportunities offered by China.

"China still presents opportunities that cannot be ignored," noted a recent article published on the website of RBC Wealth Management, a large wealth management

firm in Canada. "With its GDP accounting for 18 percent of the global total, we think the size of China's economy alone demands attention from multinationals. The country has the world's largest middle-income class," wrote the article, pointing out a major reason why foreign institutions are increasing investment in China amid lackluster global economic recovery and sluggish cross-border investment.

Data showed that China has managed to keep foreign investment relatively stable in the first half of this year, when foreign direct investment (FDI) into the Chinese mainland, in actual use, totaled 703.65 billion yuan (\$96.66 billion). From January to June, 24,000 new foreign enterprises were established in the country, which represented a year-

on-year increase of 35.7 percent.

During the period, the country witnessed continuous improvement in the quality of foreign investment, with high-tech industries and the high-tech manufacturing sector seeing FDI growth of 7.9 percent and 28.8 percent, respectively.

China is not an "option", but a "must-go" destination brimming with immense opportunities. This is a shared view among multinationals, which consistently emphasize their commitment to continuing nurturing and expanding their presence in the

Chinese market.

The opportunities offered by China stem from the country's efforts to steadily promote institutional opening up, constantly optimizing its market-oriented, law-based, and internationalized business environment.

Since the beginning of this year, various Chinese departments have intensified efforts to ensure better services for foreign investment. They have strengthened regular communication with foreign firms and business associations to promptly address difficulties in business operations and

project implementation, striving to provide greater convenience for for-

eign traders and investors in China. In January, China's new Catalogue of Encouraged Industries for Foreign Investment officially took effect, with a historic number of 239 new items further widening the scope of foreign investment.

In June, the General Administration of Customs rolled out 16 new measures to optimize the country's business environment, further bolstering foreign entities' confidence in investment and development in China.

The opportunities offered by China result from the country's efforts to align with high-standard international economic and trade rules and constantly promote trade and investment liberalization and facilitation.

This year marks the 10th anniversary of China's pilot free trade zone (FTZ) construction. Since the establishment of the first pilot FTZ in the eastern Chinese metropolis of Shanghai, the country has so far set up 21 FTZs, which have become an important factor driving China's indepth reform.

Trade and investment facilitation measures, such as the shortened negative list for foreign investment, the Single Window system for international trade, and free trade accounts, were trialed, explored and refined in FTZs before being applied nationwide. To date. a total of 278 institutional innovations piloted in the FTZs have been replicated and promoted na-

The Regional Comprehensive Economic Partnership (RCEP) agreement took effect, spurring opening up and cooperation among member countries across

more areas, at higher levels, and in greater depth. China and Singapore have completed "substantive negotiations" on the upgrade of bilateral free trade agreement, the third round of negotiations on Version 3.0 China-ASEAN Free Trade Area (FTA) was successfully held, the negotiations for a bilateral free trade agreement between China and Honduras were launched, and China and Nicaragua completed the substantive

Thus, while Simba SC and Yanga have been unfortunately drawn into particularly tricky groups, it is hoped that they will nevertheless still give their all once the ever-pulsating Group Stage of this season's CAF Champions League kicks off later this year.

Kounde picked up a left knee injury while playing for Barcelona in the Spanish league on Sunday. Upamecano injured his left hamstring this weekend with Bayern Munich.

Their withdrawals follow that of Arsenal defender William Saliba, who was replaced Sunday by Jean-Clair Todibo in France's squad.

France leads Group B and will qualify for the tournament hosted by Germany next year if it beats the Netherlands, or if they draw and Greece loses against Ireland.

Palestine team withdraws from tournament in Malaysia

THE Palestine soccer team has withdrawn from a tournament in Malaysia, amid ongoing fighting between Israel and the Palestinian Islamist group Hamas, the Football Association of Malaysia (FAM) said on Tuesday

Israeli TV channels said the death toll from the Hamas attack at the weekend had climbed to 900 Israelis, with at least 2,600 injured, and dozens taken captive.

Gaza's Health Ministry said at least 687 Palestinians had been killed in Israeli retaliation air strikes on the blockaded enclave since then.

The Palestine soccer team had been

scheduled to compete in the Merdeka Cup - an international friendly tournament in Malaysia - from Oct. 13-17 along with India, Tajikistan and hosts Malaysia.

"The Palestinian team had to withdraw from participating in this 42nd edition because they could not fly to Kuala Lumpur due to the tense situation in the country at the moment," FAM said.

The Palestine team are due to play 2026 World Cup qualifying matches against Lebanon and Australia in November.

They have also qualified for next year's edition of the Asian Cup in Qatar, which will run from Jan. 12 to Feb. 10. Reuters

The Guinea forward scored a hat trick in Stuttgart's 3-1 win at Wolfsburg on Saturday, taking his tally to 13 goals in only seven league matches. It also erased any concerns of a barren patch after he failed to score in his previous game.

No other player has ever so scored so many goals at this stage in the league.

"It's a good one, because we know a lot of very good players played in the Bundesliga, (Robert) Lewandowski, so many players," Guirassy said.

"I'm happy with this record but this means nothing for me because, like I say, I take (it) game by game. We want to win games, fight. Of course, it's difficult. Every Bundesliga game is difficult."

Guirassy's form has helped Stuttgart make a strong start to the season with only one loss and six wins from its opening seven games.

It also won its opening German Cup game against fourth-division club TSG Balingen in August. Guirassy scored then too

Kane, who joined Bayern Munich for a Bundesliga-record 100 million euros (\$106 million) in the offseason, has eight Bundesliga goals so far, three of them from penalties.

"We have to fight like we did today, and I hope we can continue like this," the 27-year-old player said.

Stuttgart's form this season is all the

more remarkable because the team was fighting relegation when coach Sebastian Hoeneß took over in April.

Just one loss in its remaining eight games last season earned Stuttgart its place in the end-of-season relegation-promotion playoffs, where the team clinched survival with wins over Hamburger SV, which had finished third in the second division.

"Serhou is, of course, the figurehead of the success at the moment," Hoeneß said, "but there are others who have contributed significantly to this, on and off the field." Chris Führich is one. The 25-year-old midfielder scored two goals and set up five more, and was rewarded with his first call-up for Germany last week.

Führich is part of the squad that will play the United States in East Hartford, Connecticut, on Saturday, and Mexico in Philadelphia four days later.

Guirassy, who was born in Arles, France, to parents from Guinea, has already scored more league goals than he did last season – or any season before.

He joined French club Lille in 2015 and spent the second half of that season on loan at second-division team Auxerre, where he scored eight goals.

Cologne signed the player in 2016, but his goals couldn't prevent the team's relegation from the Bundesliga in 2018.

Guirassy scored two goals in Germany's second division before returning to France in January 2019 to join Amiens.

Guirassy then joined Rennes in 2020, scoring the team's first Champions League goal, and finishing with 24 in all competitions before joining Stuttgart – initially on loan – last year.

Guirassy's recent goal-scoring exploits are sure to bring the attention of other clubs, but Hoeneß is certain the increased fame will not have any affect on the player.

"He's a respectable, normal guy who keeps things in perspective," Hoeneß said. "There's no danger of it getting to his head."

Former Brazil national team coach Tite takes over at Flamengo

FORMER Brazil coach Tite took over at Flamengo on Monday, signing a contract that will run until the end of 2024.

The Rio de Janeiro club said on its social media channels that Tite's staff would include the assistant coaches who worked under him during this six years in charge of Brazil's national team.

The 62-year-old Tite, who has been out of work since Brazil's World Cup quarterfinal elimination last December, will take control of his first match for Flamengo when it meets Cruzeiro in a Brazilian championship game on Oct. 19.

Flamengo fired Jorge Sampaoli on Sept. 28 after the Argentine coach

failed to win a trophy for the club. He took over in April from Vitor Pereira, who spent only three months in the job.

Flamengo was eliminated by Paraguay's Olimpia in the round of 16 at the Copa Libertadores, lost the Brazilian Cup final to Sao Paulo and is currently fifth in the Brazilian championship with 44 points from 26 matches,

11 behind leader Botafogo.

Tite led Corinthians to a maiden Copa Libertadores title and a Club World Cup crown against Chelsea in 2012. AP

ASIA is set to start its 2026 World Cup journey, giving the lower-ranked teams such as Afghanistan, Bhutan and Pakistan a chance to grab some attention and secure matches against soccer's continental heavyweights.

The Asian Football Confederation's 20 lowest-ranked teams compete in two-leg, home-and-away series on Thursday and next Tuesday, with the 10 winners advancing to the second round of the qualifying group stage.

Afghanistan, ranked 158th, takes on No. 183 Mongolia. Getting to the next stage, where each team will have six games, is not just valuable financially but also in terms of experience.

"It's very important for us to get past Mongolia into the second round as we would play India, Kuwait and Qatar," Afghanistan coach Abdullah Al-Mutairi told The Associated Press. "We need as many games as possible, and these are strong teams, but we have the quality to show what we can do."

With little in the way of domestic soccer in Afghanistan, Al-Mutairi has tapped into the country's diaspora and selected talent based in Europe, Asia and Australia to fill the national team's roster.

"We have six or seven local players

and we want more in the future but there has not been a regular league in Afghanistan for two years," Al-Mutairi added. "Most come from Europe and Asia such as Singapore, India, Indonesia, Georgia, England and Sweden."

Due to the security situation in Kabul, Afghanistan will play its home game against Mongolia in neighboring Tajikistan.

"The weather is similar to Europe and we hope that the Afghan people living there will come and support us," Al-Mutairi said. Yemen, ranked 156th, is another

team unable to play on home soil and will take on Sri Lanka in Saudi Arabia. Sri Lanka is Asian football's lowestranked nation at No. 202 on FIFA's global list of 207 members.

The Sri Lankans are, however, happy to play at all after FIFA lifted a ban in August that was imposed in January for government interference in the running of the federation.

Indonesia and Hong Kong are the two highest-ranked teams in the first round at 147th and 148th. Indonesia is taking on Brunei, and Hong Kong is the clear favorite against Bhutan.

Singapore and Guam will play off to go into a second-round group with South Korea, while Myanmar and Macau will meet to decide a spot in a second-round group against Japan, which beat Germany 4-1 last month.

Pakistan's hopes of winning a first ever World Cup qualifier have im-

proved with the news that the AFC has allowed Islamabad to host the second leg of the series against Cambodia, for what will be a first home game for eight years.

With no domestic league since 2018, Pakistan's English coach Stephen Constant

With no domestic league since 2018, Pakistan's English coach Stephen Constantine, appointed just 13 days before the first qualifier, has a difficult job in his attempt to take the team, ranked 197th, to the next stage.

"Everything is an area of concern in my opinion – defense, midfield and attack," said Constantine, who has had two spells in charge of India. "The most important thing is for the players to understand their roles in the system.

"If we get the combination right, watch out." In other games, Maldives will play Bangladesh, Taiwan is against Timor-Leste and Nepal takes on Laos.

The second round of Asian qualifying will feature 36 teams divided into nine groups, with the top two teams in each group advancing to the third round.

With the expansion from 32 to 48 teams for the 2026 World Cup, Asia is guaranteed eight places at the tournament being staged in the U.S., Canada and Mexico.

Mwakinyo handed one-year ban

TANZANIA Professional Boxing Regulatory Commission (TPBRC) has banned boxer Hassan Mwakinyo from taking the ring for one year inside and outside the country for one year and a fine amounting

The TPBRC banned Mwakinyo due to his decision to boycott his fight that was to be held at Ubungo Plaza in Dar es Salaam on September 29.

Mwakinyo was earlier scheduled to fight Kenya's Rayton Okwiri and there was, later, a change of the opponent a day before his fight night as the Kenyan suffered an injury.

The Tanzanian pugilist was then slated to trade punches with Namibia's Julius Indongo, alias 'Blue Machine'.

Despite the changes, Mwakinyo agreed to fight on one condition- it should not be under the promotion firm that arranged it, given the pugilist had differences with the firm's officials and some pugilists slated for undercard bouts.

Mwakinyo had to pay 4,000 US Dollars for the International Boxing Association (IBA) Light Middleweight title to promote his fight in place of the anonymous promoter the boxer is yet to reveal.

The flamboyant pugilist, alias Tornado, appeared during the weight-in on September 28 and announced his decision to opt out of the bout later that evening due to differences with the promoter. Mwakinyo, whose official name is Halfan Hythani

Hamza, has won 20 fights out of the 23 bouts he has fought since making his debut in 2020 against compatriot, Alibaba Tarimo, on November 29, 2015.

The pugilist has had 23 fights- winning 20 (14 of which are KOs), and three loses.

The Tanga-born boxer is a former World Boxing Federation (WBF) Intercontinental Light Middleweight title winner and held the title twice in 2020 until recently when he was stripped of the title.

He, consequently, rose to the global limelight after clinching the WBF Intercontinental Light Middleweight title twice in 2020.

Mwakinyo boasts a decorated trophy cabinet that includes the Universal Boxing Organization (UBO) International Super Welterweight title won in 2018.

The boxer further clinched the WBF Intercontinental Super Welterweight title in 2020, and the African Boxing Union (ABU) Super Welterweight title

THE 2023 CECAFA Zone Qualifiers champions, JKT Queens of Tanzania, have been drawn against tough opponents in the CAF Women's Champions League slated for November 5-19 in Cote d'Ivoire.

JKT Queens won the CECAFA Zone Qualifiers to reach this stage. They defeated AS Kigali Women's FC of Rwanda, New Generation FC of Zanzibar, and 2021 CAF WCL CE-CAFA Zone Qualifiers winners, Vihiga Queens of Kenya, to progress to the semi-finals at the top of their

They overcame Burundi's Buja Queens FC in the last four and defeated CBE Women's FC of Ethiopia on penalties in the final to qualify for the first time.

They are Tanzania's representative for the second successive finals after Simba Queens which finished fourth in the 2022 edition that took place in Morocco.

In the draw conducted on Monday evening, Esther Chaburuma-

coached JKT Queens were drawn in Group A alongside tournament hosts, Athletico FC d'Abidjan, inaugural champions Mamelodi Sundowns Ladies, and SC Casablanca of Morocco.

Athletico FC d' Abidjan are the 2022-23 Côte d'Ivoire Women's Premier League Champions.

They went undefeated through their league campaign last season, winning 17 games and drawing just one. They won their final 11 league games of the season.

Their WAFU B Zone Qualifiers participation ended with a third-place finish but they qualified for the continental tournament as hosts.

Mamelodi Sundowns Ladies are one of two teams to have reached every final along with AS FAR Women's FC.

They have been to all five finals at major competitions including three COSAFA WCL finals and two CAF Women's CL finals. They have won the last four South African top-flight titles.

SC Casablanca is Morocco's second representative at the finals, joining AS FAR Women's FC.

They won the UNAF Zone Qualifiers, defeating Afak Relizane 4-3 in their opening game, then 3-1 against Tunisian side, ASF Sousse, and Egypt's Wadi Degla 6-1 in their final game.

Chaymaa Mourtaji was SC Casablanca's top scorer in the qualifiers with five goals. The team from Casablanca was only formed in 2019 and has qualified for the side's debut finals.
