THE United Nations Food and Agriculture Organization (FAO) has expressed its satisfaction with the design and execution of the "Building a Better Tomor-

FAO director general, Dr Qu Dongyu made this affirmation yesterday in a meeting with Prime Minister Kassim Majaliwa at the organisation's headquarters in the Italian capital of Rome.

The premier stood in for President Samia Suluhu Hassan at the four-day World Food Forum (WFF) agri-food systems conference, where he explained the grand plan to empower educated youths by active participation in commercial agriculture.

FAO will extend support for the project to widen to help fulfill the goal of raising young people to gainful employment in agriculture, the top executive

noted, saying the matter will be on the agenda at the FAO executive meeting later

He praised the president for efforts to develop the agricultural sector and improving relations with international partners, affirming that he would visit Tanzania next year to see agricultural sector progress at close range.

The visit would also enable him to expand the scope of discussions with the government on how to further facilitate agricultural sector growth and the blue economy.

EAC launches council for media regulators

THE East African Community (EAC) yesterday launched the East Africa Press Councils (EAPC), an umbrella body bringing together media regulatory authorities within the region.


Dr Irene Isaka, the EAC Secretariat director of social sectors, standing in for secretary general Dr Peter Mathuki, said that the EAPC draws its membership from media and press councils in the EAC Partner States

It will promote free, independent, professional and accountable media in the sub-region, raising hope that the institution will contribute to promoting the tenets of democracy, social justice and respect for human rights.

Independent and professional journalism is the cornerstone of democratic dispensation, without which freedom of expression is jeopardised, and so are the basic rights of members of society, the secretariat intoned.

"A vibrant media is essential for the attainment of social justice, rule of law, accountability, equality and protection of hu-

WFP: Sorghum farmers have vast global markets

In the semi-arid region of Dodoma, most smallholder farmers rely on the sorghum they grow to feed their families, but low yields have regularly pushed people into hunger

SORGHUM farmers in the central zone need to increase production to meet rising

market needs in the region and the global grain market as a whole. William Lasway, the World Food Pro-

gramme (WFP) country monitoring offic-

er, issued this encouragement here yesterday, addressing a forum for sorghum crop stakeholders including farmers, buyers, seed producers and input distributors.

Rosemary Senyamule, the regional commissioner, officiated at the forum tailored to enable the participants to brainstorm over the development of the vital agricultural sub-sector.

The WFP official said the UN agency plans to purchase at least 200,000 tonnes of sorghum locally each year, noting that WFP needs the produce as part of its relief activities among refugee communities and strife torn countries.

He said Tanzania has favourable agroclimatic zones and suitable soil for the cultivation of the crop, but efforts are needed to assist farmers to engage into vast and professional production of sorghum.

WFP has for a long time collaborated with the government to assist local farmers to increase production in the crop subsector, while Meshack Panga, the Farm Africa project officer, affirmed that the NGO was running a project to scale up production of sorghum in all Dodoma Region districts.

"Through the robust project, we have so

far managed to reach out to 30,000 farmers across the districts and the initiative continues to support the farmers until 2028 where it will phase out," he expressed.

Improved quality had also enabled prices to increase substantially to 800/- per one kilogram, nearly four times the price less than a decade ago, he said.

Patric Byeshulilo, an officer from Apeck International Ltd linked with producers in several countries in the region, told the forum that his company was working to search for vast markets for the crop in different countries, saying they have so far managed to get a market for at least 6,000 tonnes in Burundi.

Mwanahamisi Msangi, the Cereals and Other Produce Board of Tanzania (CPB) quality assurance officer, said the board is the major buyer of local sorghum.

During the 2020/21 harvest season upwards of 1,000 tonnes were purchased rising to 3,000 tonnes during the 2021/22 season.

The board has expectations for at least 10,000 tonnes to be purchased next season, she elaborated, while Ezekiel Noah, the Tanzania Agricultural Seed Agency (ASA) agricultural and marketing officer, said

the agency has in stock 200 tonnes of improved seeds for assisting the farmers. ASA indicative prices specify a price of 3,000/- for one kilogram of the seeds, he said.

In her closing remarks, the RC said each district has been directed to set aside 2,000 hectares for professional cultivation of the crop, to meet market demand.

Dan Collison, the Farm Africa CEO at Farm Africa is implementing a robust project to help introduce 100,000 sorghum farmers in the region to climate-smart agriculture techniques.

With the generous funding packages from Irish Aid, the Mastercard Foundation and the World Food Programme, by enabling the farmers access to better seeds and improved post-harvest practices.

"Despite facing dry conditions in 2023, through the project, the beneficiary farmers have achieved an incredible 300 percent increase in sorghum production. And they're now selling their sorghum for up to 780/-per kilo this year, from 250/per kilo three years ago," he said.

THE government is readying regulations for the introduction of cable transport to boost mountain tourism.

Habibu Suluo, the Land Transport Regulatory Authority (LATRA) director general, made this affirmation to the media in Dar es Salaam yesterday, noting that a study had been conducted for potential areas for cable cars transport.

Final procedures are being awaited before the Minister for Transport approves the regulations, he stated, underlining that to ensure that the area performs well, LATRA is setting up a cable transport unit to ensure that the required conditions are observed, to provide tourists and other users an attractive experience.

He said many countries worldwide are now adopting innovative transport to attract tourists keen on pleasure rather than taxing climbing efforts when visiting various attractions, citing South Africa, Algeria and Nigeria as providing cable transport services.

expressing the view that starting test will have 100 questions which nology (ICT) outlays for enhanced cable transport will attract more investors to provide such services from within and outside the coun-

He said this policy shift is complementary to efforts of President Samia Suluhu Hassan in boosting the tourism sector, as innovative services such as cable transport widen the breadth of potential visitors.

"We are going to put regulations and guidelines to ensure that our investors operate smoothly, but also customers have a brilliant experience," he asserted.

Those seeking to be involved in the recently reintroduced 24-hour upcountry bus operations are required to sit for a special test prepared by the regulator to be granted with the permit.

"We want to ensure that public transport remains safe regardless of the hour," he said, noting that the drivers need to sit and pass before being certified to do the running.

A digital monitoring apparatus will be installed for those obtaining the permit, to enable tracking their driving conduct on the road, he said, noting that so far 1,617 upcountry drivers have passed the test, with 615 drivers presented with the digital monitor tied with the permit to operate at night time.

Passenger buses were banned from travelling at night in 1992 following notorious incidents of bus hijacking, passengers being robbed and humiliated, along with numerous bus accidents.

This spate of deaths and permanent disabilities, property loss and damage to other parties led to rescinding the permit for passenger buses to operate at night.

LATRA seeks to boost its information and communications techmonitoring operations, coming after e-ticketing, vehicle tracking system (VTS) and speed governors for upcountry buses.

The agency needs a unified digital system for optimal services to passengers, operators as regulatory needs where movement of buses, fares and other issues will be put in one application for all concerned people to access, he said.

Various measures taken by LA-TRA brought in revenue during fiscal 2022/23 amounting to 34.17bn/from 28.53bn/- recorded during fiscal 2021/22.

Hanya Mbawala, the LATRA director for railway services, said the government is also developing regulations for private operators in the state-run railway infrastructure. This will greatly stimulate the provision of quality services and increase the national income, he added.

the people. It should not lead to the strangling of media through undue control and over-regulation, it asserted.

"When media regulators understand this, and they come together in solidarity to champion the promotion of accountable and independent media, then a great stride has been made," the secretariat emphasized.

Emmanuel Mugisha, EAPC treasurer and Rwanda Media Commission executive secretary, disclosed that Rwanda was using media literacy to ensure that youth and members of the public are adequately prepared to use media space, especially social media, responsibly.

62 injured after trains collide head-on in Dar

SIXTY-two people have been injured in an accident involving a passenger train and freight train collided head-on in Dar es Salaam on Tuesday.

In the accident involved a Dar es Salaam commuter train popular as "Mwakyembe train" and the cargo train that was carrying copper involved in head-on collision, leaving two people more seriously.

According to the Tanzania-Zambia Railway Authority (TAZARA), in the incident, the freight train collided with a commuter passenger train, resulting in the injury of the persons where the two with serious injuries have been hospitalized at the referral hospital.

TAZARA head of public relations, Conrad Simuchile said 60 of the casualties got minor injuries and have since been discharged from the hospital. He said preliminary investigations indicate that the accident occurred when two trains were erroneously allowed onto the same track leading to the head-on collision of the commuter and a copper-carrying freight train.

The authority announced the temporary suspension of services of the Dar es Salaam commuter train until Monday, October 23, this year.

Tanzania, US seal pact on commercial dialogue

TANZANIA and the United States of America (USA) have signed a Memorandum of Cooperation for a commercial dialogue between the two countries.

Speaking at the signing ceremony yesterday, Minister for Trade and Industries Dr Ashatu Kijaji said the signing was the continuation of the efforts by President Samia Suluhu Hassan to open doors for business.

"Trade between Tanzania and the U.S is still small and does not reflect the kind of opportunities that Tanzania has to the American

market through the African Growth with their counterparts in the U.S. and Opportunity Act (AGOA)," he said.

The minister said in the year 2022, Tanzania's exports to the U.S. were \$74.5 million while imports were \$93.7 million saying more efforts are needed to expand it even more.

Among the key areas agreed upon in the MoU include digital Economy, market access, regulatory and business climate reform, and trade mission.

The minister called upon the private sector to use the opportunity to identify areas that challenge them in doing business

US ambassador to Tanzania Michael Battle said the MoU marks the beginning of a new phase in the economic relationship between the two countries.

"This commercial dialogue is a demonstration of the importance that governments of the two nations place on the trade between them, at the heart of this dialogue is the commitment by both governments to build a stronger, more robust, and equally beneficial trade relationship," he said.

He said the MoU underscores the pivotal roles of the public and

the private sector in deepening the trade relationship between Tanzania and the US noting that the agreement also ensures that companies from both countries play a significant role by providing input and advice on how the two governments can better prepare, assist, and bolster the private sector to expand and to conduct trade.

The envoy said bilateral relationship between Tanzania and the US is broad and varied adding that the US invests in the people of Tanzania through engagements on health and education among others.

Tanzania collects 900 agricultural seed types for future preservation

THE World Vegetable Centre in association with the Tanzania Plant Health and Pesticide Authority (TPHPA) has managed to collect 900 types of endangered agricultural seeds from both the mainland and isles, kernels that will be kept in special storage.

The centre's Director General, Dr Gabriel Rugalema said here yesterday that the project involves collecting and storing seeds and is being undertaken to prevent these important farm inputs from becoming extinct. "We have dried the kernel for long-life preservation," said Dr Rugalema, adding that the consignment of the collected seeds is quite big and requires ample time for their treatment.

The move comes just as the country is also working to establish a proper national kernel storage facility.

The development comes at the time when there is raising concern regarding the disappearance of variety of vegetable and plant seeds, many going extinct due to effects of climate change among other reasons.

Dr Rugalema was speaking at the closing session of the recently held training workshop on germ-plasm conservation and quality management.

The course gathered more than 40 delegates in person, and another 100 participants who attended virtually online, representing national gene banks from more than 15 countries in sub-Saharan Africa.

The sessions were held at the World Vegetable Center's Eastern and Southern Africa regional office in the Usa-River area of Arusha.

The event took place at the time when the World Vegetable Center is preparing to commemorate the organization's Golden Jubilee.

The World Vegetable Center operates four regional centers, with projects in more than 50 countries worldwide.

It was discussed during the Arusha training that most plant breeders around the globe have now discovered the importance of having access to an extensive set of germ plasm for their breeding needs.

The World Vegetable Center is the only global entity that works exclusively on vegetable research and development.

The Center is helping to overcome malnutrition and poverty, and is improving the health of both rural and urban people by increasing the production, quality and consumption of nutritious vegetables.

He pointed out that if a vehicle or motorcycle is insured; the insurance will cover loss or harm that will occur in case of an accident.


He said that insurance is a security for any investment, noting that when investment is done without having insurance it is like losing the properties as they cannot be recovered in case of any

Cultivate habit of protecting wild birds for healthier environment, Nature Tanzania executive pleads

NATURE Tanzania has called on Tanzanians to develop a habit of protecting birds and their habitats as they are an important species in promoting the health of environments.

The agency Executive Director, Emmanuel Mgimwa, made the call here at a special event to introduce the bird of the year at the College of African Wildlife Management-Mweka (CAWM-Mweka).

According to him, many communities have parted away from initiatives to protect birds in their surroundings thus making the species safety to be at risk.

He said Nature Tanzania; a national conservation Nongovernment organization (NGO) with interest in biodiversity conservation is implementing a conservation programme aimed to address illegal killings of birds (IKB) using White Storks as flagship species.

The Conservationist further explained that Tanzania is rich in biodiversity and therefore very important for conservation.

"The country has recorded over 1,200 species of birds. We are using birds as indicators of ecosystem health and a tool for biodiversity conservation. We are working with communities, the private sector and the government in areas identified as Important Bird and Biodiversity Areas (IBA) and Key Biodiversity Areas (KBA)," Mgimwa explained.

He said that this year they competed five different birds namely Lesser Flamingo, Grey Crowned Crane, Lappet-faced vulture, Common Bain-owl and the African Spoonbill to get the 'Bird of the year 2023' and the Grey Crowned Crane won through public votes.

Increase productivity, WFP advises sorghum farmers in central zone

SORGHUM farmers in the central zone have been urged to increase productivity in order to meet the increasing market in the region and the demand for grain in the world market.

William Lasway, Monitoring Officer at the UN's World Food Programme (WFP) made the call here yesterday when speaking at the special forum which attracted stakeholders in the country's sorghum crop, including the farmers, buyers, seeds producers as well as those involved in the fertilizer sector.

The gathering was graced by the Dodoma Regional Commissioner (RC), Rosemary Senyamule, and was tailored to provide a useful podium for the participants to brainstorm over the development of the vital agricultural sub-sector.

Lasway said that his organisation alone plans to purchase at least 200,000 tonnes of sorghum from Tanzania per season.

He said WFP has been purchasing a huge quantity of sorghum with an eye to roll out humanitarian support to the population in need into different countries across the continent, especially in Sudan, Somalia and Burundi.

"Tanzania has been endowed with a favourable agroclimatic zone and suitable soil for the cultivation of the crop, but much efforts are needed to be put in place to assist the farmers to engage into vast and professional production of sorghum," he observed.

Lasway noted that the WFP has for a long time been working collaboratively with the government to assist the local farmers to increase production and productivity in the sub-sector, being in efforts to enable them getting the needed tonnes in each season.

Meshack Panga, Farm Africa's project officer informed that the international organisation was running a specific project to scale up production of sorghum among the farmers in all districts of Dodoma Region.

"Through the robust project, we have so far managed to reach out

for the crop in different countries. saying they have so far managed to get a market for at least 6,000 tons in Burundi.

The Quality Assurance Officer at the Cereals and Other Produce Board of Tanzania (CPB), Mwanahamisi Msangi, said the state-owned Board is the major buyer of the sorghum produced by the local farmers.

She briefed that during the 2020/21 season CPB bought a total of 1,000 tonnes, while in the 2021/22 season they purchased at least 3,000 tons.

"During 2022/2023 we purchased a total of 3,000 tonnes and our expectation is to purchase at least 10,000 tonnes come next season," she expounded.

Agricultural and Marketing Officer at the Tanzania Agricultural Seed Agency (ASA), Ezekiel Noah said for the current season, the Agency has in stock a total of 200 tonnes of improved seeds for assisting the farmers.

He detailed that, as per the Agency's indicative prices, one kilogram of the seeds will be available to the growers at a patriotic price of 3,000/-.

In her closing remarks, the Dodoma Regional Commissioner (RC), who chaired the forum expressed that the government in the region has directed that each municipal council to set aside a total of 2,000 hectares to support professional cultivation of the crop in order to meet markets demand.

To further improve performance of the sector, FARM Africa is implementing a robust project to help introducing at least 100,000 sorghum farmers in Dodoma region to Climate-Smart Agriculture techniques.

With the generous funding packages from Irish Aid, the Mastercard Foundation, and the World Food Programme, the ambitious project gives the farmers access to better seeds and improved post-harvest practices, among others.

"Despite facing dry conditions in 2023, through the project, the beneficiary farmers have achieved an incredible 300 percent increase

THE Dodoma-based Benjamin Mkapa Hospital (BMH) has awarded its four sections for excellent performance, as the Central Zone Referral Hospital marked eight years of service at the weekend.

BMH Executive Director Dr Alphonce Chandika said over the weekend that the awards were meant to motivate members of staff at the hospital. The awards included a special plaque plus cash.

"BMH rewards the best-

performing sections every month to motivate members of staff," said Dr Chandika during the 8th anniversary event of the BMH. The public hospital started providing services in 2015.

In 2019, BMH became the second health facility in the country to introduce kidney transplant service, but it remains the only hospital to perform the lifesaving operation by using its local medics.

Dr Chandika mentioned the best performing sections as paedriatics, which became the best in world on the sickle cell disease

documentation and Urology ward burden and ranks third in the (customer care), while laboratory emerged as the best hospital section in the clinical audit category.

Dr Chandika named the best hospital section in IPC category (Infection Prevention and Control) as Urology ward. "Hospital will continue to reward its best sections every month in order to motivate members of staff to efficiently serve the people," he said.

According to Dr Chandika, Tanzania is placed fourth in the African continent.

He said since the inception of Bone Marrow Transplant services to patients suffering from Sickle Cell complications, already three children have been treated and their health was progressing well.

He said already, the hospital had received over 40 patients who were on the waiting list. Medical experts say, life expectancy of people suffering from Sickle Cell shows that 50 to 90 per cent die before the age of five.



to a total of 30,000 farmers across the districts and the initiative continues to support the farmers until 2028 where it will phase out," he expressed.

Apart from assisting the sorghum farmers, according to him, the vital initiatives also work to capacitate the seeds producers.

"When we started the project, the price of sorghum ranged between 200/- and 250/- per kilogram but we sensitised and assisted the farmers to improve their production quality to the good extent that currently, the prices have substantially increased to 800/- per one Kg," he informed.

Patric Byeshulilo, an officer from Apeck International Limited told the forum that his company was working to search for vast markets

in sorghum production. And they're now selling their sorghum for up to 780/-per kilo this year, compared to just 250/- per kilo three years ago," Dan Collison, the Chief Executive Officer (CEO) at Farm Africa expressed during his special tour of the farmers.

He expressed that, in the semiarid region of Dodoma, most of the smallholder farmers rely on the sorghum they grow to feed their families, but low yields have regularly pushed people into hunger.

Dream of EA monetary union: Any chance, with deeper globalisation?

East African monetary union and a single currency is in the news yet again, with the East African Community (EAC) secretary general and a senior executive in charge of preparations for that eventuality having lately discussed the matter.

One view sees that eventuality in three to four years, while the other slates it for 2031 at the earliest. This more removed date has been informally accepted as a more workable projection.

especially Those fervently supporting the formation of an EA monetary union are making an effort to reaffirm the old date of 2024 as the set timeline, although they admit that preparations are inadequate for the matter to be on board.

However, those more skeptical on the subject are not saying that by 2031 they are persuaded the matter will have been concluded. They seem to be suggesting that preparations can be pursued definitely, but the issue won't be of much political relevance before 2031

Experts have for a whole decade described the "twin" monetary union and single currency ideas as constituting the third pillar in the EAC integration process, alongside the customs union and the common market, some of whose building blocks are just being completed.

By and large, immense political was needed to bridge the gap traditionally separating the three major actors in the quest for integration, and this is just being brought to a conclusion.

In typical common market spirit. Tanzanian firms are winning major public construction and energy supplies outlays in neighbouring countries.

Meanwhile, each partner state is perceived to be making some effort to make its environment attractive

ALK on the pursuit of an enough to foreign investments. This would suggest that the states are indeed in some form of competition, which some observers may view as making the quest for an EA monetary union lose much of its vitality.

The thrust of monetary union is two-fold, first to obtain wider unified economic space attracting foreign investments as well as landing greater access to opportunities by regional firms. The firms are otherwise reluctant to set up shop, largely owing to restrictions and obstacles to enter other markets.

This outlook, commonly known as the protectionist spirit, has been in the vogue for decades and partly underlines the customs union protocol - as collective protectionism.

To some observers, the enactment of the African Continental Free Trade Area (AfCFTA) before the common market sees the light of day diminishes some of the CM's importance and more or less freezes the monetary union. Global linkages in investments are the rule at present.

The recent initiative where the Bank of Tanzania will be purchasing local gold (and many think other gemstones as well) for a local reserve that can be released to the world market if urgent hard currency supply could also provide useful lessons.

The scarcity of the dollar makes it necessary for each country to prime itself for the best results it can fight for and get - but without easily standing as a recipe for a monetary union.

AfCFTA has vastly changed the situation, reinforcing the likes of the European Banking Authority, the Belt and Road Initiative, and AGOA.

Also of concern here is the impact these and other manifestations of globalisation may be having on our very own aspirations such as relates to the realisation of the much-longedfor East African destiny complete with local firms alive and kicking.

N independent media is at the heart of a democratic society. But in more and more countries, the media are under pressure. And so is democracy, says Austria Presse Agentur (APA) **CEO Clemens Pig. In his recently** published book "Democracy Dies in Darkness", he describes the key role of news agencies in the fight for independent media and democracy. Here he talks to Martin Fröhlich, WAN-IFRA's Director of the Digital Revenue Network, in part about the current dangers to media and democracy. Excerpts:

Q.: How did you come up with the title for your book?

'The media are under heavy pressure - as is democracy'

pressures. We are currently seeing a concentration in the newspaper market in Central Europe. In Western Europe and Scandinavia, this concentration has already taken place. It also means less diversity of opinion as several voices become one. How do you view this development?

It has to be viewed critically. In Austria, we are currently witnessing two more newspapers, the Wiener Zeitung and the operations. The mixture is toxic.

can help media companies in the development of AI?

There are about 140 news agencies worldwide. Only about 20 of them are independent of the state. They are joint ventures owned by the media themselves. There are 11 of them in Europe, in Scandinavia, the DACH (Germany, Austria and Switzerland) region, Benelux (Belgium, the Netherlands and Luxembourg), the UK and Italy. At the same time, up to two-thirds Oberösterreichisches Volksblatt, of all daily mass media information shutting down their daily print comes directly or indirectly from these news agencies. That's where

We also have to work with quality seals and be able to deliver images and video in a way that allows the end user to check with their own apps whether it is verified material all the way back to the source. If we want to buy organic food in the supermarket, we as consumers must also be able to trust that the label is true. Clean news, like clean drinking water, is fundamental to democracies. We need easy-to-use technologies for users. It's about traceability to the sources. Where does the news come from?

TPA has every reason to ensure a rise in productivity at all ports

Authority is moving to open offices in various regional trading associates known to use Dar es Salaam Port, this chiefly in response to challenges felt in competing with other service providers.

Port executives appear convinced that this will ease transportation of goods from the port to those countries, namely, Rwanda, Burundi, Uganda, Zambia, Malawi and the Democratic Republic of Congo.

It is widely expected that firms in those countries will find it easier to liaise with local TPA offices than doing so from a distance as currently obtains.

Meanwhile, as Transport minister Prof Makame Mbarawa was explaining, the office will be working on challenges faced by firms of those countries using Tanzania's major port.

Here it is evident that whenever emergencies or dissatisfaction arises, port officials stationed in those other countries will communicate with the relevant departmental heads without major hitches.

That adds to assurances that both port authorities and the government are mindful of the needs of port clients.

In his remarks, the minister referred to wider opportunities in economic links between and among the respective countries, which technically leads to the presence of value chains including in transporting goods from the port.

It also involves sounding out markets for regional exports, within both SADC (Southern African Development Community) and AfCFTA (African Continental Free Trade Area).

Thus, whichever way the argument runs, port is a key link. As the minister aptly acknowledged, the rise in the use of Dar es Salaam Port by nearby countries makes it imperative for the port authorities to resolve challenges

Tanzania Ports still being encountered in using the port. Obviously, this leads to some technical initiatives where linkages are needed not just between the particular port and these inland destinations for goods landing at the port but also in respect of where the goods originate.

While it is clear that some solutions aren't easy to take up in terms of partnerships, they can be obtained via a leasing of software at a price and the deployment of advanced inspection technology like scanning in a rapid manner.

That is precisely what neighbouring states want, and it is understandable seeing the port authorities rapidly moving in that direction.

As Tanzanian port officials and higher administrators often admit, or assert for those who are not sufficiently aware of the situation, Dar es Salaam Port serves the needs of neighbouring countries to a considerable extent.

This leads to searching for methods to assure neighbouring countries that everything is being done to improve services at the port, including fighting to resolve challenges as swiftly and comprehensively as resources allow.

For instance, officials point at a major programme to improve services at port 'gates' number 12 to 15 - whose handling capacity and ship anchorage by size are now being widened.

There is also a plan to use dry port facilities placed under the Export Processing Zone Authority, complete with a massive yard for vehicles storage, warehouses and cold storage facilities for perishable goods.

There are also efforts to link the work of diplomatic missions in nearby countries with the TPA thrust, which are seen extending the leverage the all-important facility has on business expectations. In sum, the efforts in progress are well-intentioned, laudable and meriting as much support as practicable.

A.: I borrowed the title from the Washington Post, which chose this slogan in 2017 after the election of Donald Trump as US president. The title expresses how important the media are for democracies and that the media are the first targets when autocrats or dictators seize power for themselves. They know about the important role of a free media.

How dark is the current state of democracies?

In recent years, we have seen how the phenomena of disinformation, fake news and conspiracy theories, which until the (Covid-19) pandemic we knew mainly from the US, have spread to Europe. They have been swept from the digital fringes of society into the centre. Let's think of the anti-Corona demonstrations. We, the media, are particularly challenged. We must not only look at the harsh censorship in Russia or other Eastern European countries. If we look at democracy as a whole, as we have experienced it in the global boom since the Second World War, we have to realise that this model is unfortunately no longer in the majority. Democracies are being dismantled everywhere. The media are under massive pressure.

In what way?

They are under pressure from the autocratic states themselves, which are abolishing the media and their free reporting. On the other hand, the difficult economic environment for independent private publishers is also a development that we have to keep an eye on. Free media need an appropriate economic framework to be able to report independently. We are in the midst of a pandemic, disinformation and the question of what AI means for us media companies and journalism.

You talk about economic

Advertising money is flowing away to the digital giants. At the same time, media production costs have exploded in the wake of inflation. The third issue is that the delivery of daily newspapers in rural areas is no longer guaranteed. The stakes are high. We are talking about the democratic importance of the media as the fourth estate.

Democracies are not just about voting. In order to establish a constructive, factual and verified formation of opinion, a clean media discourse is indispensable. When the media are under pressure, democracies are also under pressure and in danger.

Is it an opportunity or a threat?

We talk a lot about the threat but, as media, we also have to recognise the opportunity of the century. What we have seen so far in terms of new technologies is at best a teaser. There is much more to come. There will be much more disinformation in digital spaces. That is a potential danger. But if the media and independent news outlets recognise these opportunities, we can strengthen our brand profiles. However, we have to be careful about the economic protection of the content. It must not happen again that we are not compensated for our content. Third-party AI providers must not use our expensively produced content to train their solutions while we look the other way. We in the media must join forces to network better in terms of infrastructure and technology and create protected data spaces over which we have sovereignty. We have to be forwardlooking and courageous. So the book is very timely.

As the head of a national news agency, where do you see the key role of these agencies in the battle for the facts and how they

their power lies. They massively determine media coverage and thus the image we have of the world.

What do you mean?

In the background, there is a battle for the air sovereignty of international news flows. In the Western hemisphere, in North America and Europe, this is done by independent state agencies. In the East, on the other hand, a huge network of state agencies has developed - as in Russia, Turkey and China. The Chinese alone have about 13,000 employees, far more than all the independent agencies in Europe put together. As the arteries of global information flows, agencies are also the transformation heads of digital transformation, because the media are directly connected to them. The agency of the future is a news technology agency. With technology solutions and multimedia content, they will be the Swiss army knife of the media industry.

What do politicians need to do guarantee the framework conditions for the independence of the agencies?

The copyright issue, the ancillary copyright with a view to global platforms, is central. We need remuneration for editorial content. Increasingly, EU legislation is being adopted in national legislations. The next step is to ensure the necessary commercial remuneration. We also need the AI Act. It will come, but it will come too late. We have to keep an eye on the commercial protection of our content, for example through collecting societies. What will happen to our content? We must not let this technological revolution pass us by.

What else can the media do?

how we expose young people to this issue. And it would be in the interest of the states to provide an appropriate education programme. Yes, it's a marathon, but you have to start somewhere. This book is a contribution to that. Media consumers need to be more in touch with our brands, with our fact-checking and our technologies in the digital use of social media. Then I definitely see the glass as half full, not half empty.

The war of aggression in Ukraine shows how difficult it is to provide facts. The Russian agency Tass and the Ukrainian agency Ukrinform are staterun, or at least close to the state. How important is it to have independent foreign media on the ground here?

I am very grateful that there are agencies that do their international work directly on the ground. Unfortunately, we always have to mourn deaths in the process, such as the recent death of a colleague from the French news agency AFP. We know that in war, truth is the first casualty and propaganda is used at all levels: The credibility and diversity of sources is central to our newsroom and difficult to establish in a war situation. That is why neutral sources on the ground are so important. The factual situation in war reporting is often diffuse. Agency reports often end with the sentence "This source has not yet been definitively verified". As the facts change, so must the reporting. Transparency and the culture of error must be improved. The loss of trust that some people have in the media - we should also report on that, especially when the facts change.

Proper procedures of selling mortgaged landed property

PART from bonds, debentures and various guarantees that have been used for years as security for one to be granted a loan, land has commonly been used too. The use of land as security or collateral is recognized as mortgage.

In this kind of arrangement there are mainly two parties, namely the mortgagor who in simple terms is the one who mortgages property and the mortgagee as the one to whom the property is mortgaged.

Due to the seriousness and necessity of this issue the Land Act has a special part which governs mortgages. This is found under Part X of the Land Act CAP 113 R.E 2019 (herein after referred to as Land Act).

Once one has signed the mortgage deeds and the same is dully registered, upon default by the borrower, the mortgagee has several remedies in respect to the mortgaged land. Section 126 of the Land Act provides for four remedies that the mortgagee has against the mortgagor in respect of the mortgaged land.

These are either to appoint a receiver of the income of the mortgaged land, lease or sublease the mortgaged land, enter into possession or lastly sale the mortgaged land.

Even the said remedy of sale of mortgaged land has various ways. One is to



sell it to oneself (mortgagee) or sale it privately or by bid or by way of public auction. This Article touches on vital issues to be conducted while auctioning a mortgaged land by way of public auction and the effect of failure to adhere to the same.

Section 127 of the Land Act provides that once there is a default, the mortgagor must be issued with a 60-day notice of default. This goes in line with section 132 of the Land Act which provides in-

ter alia that sale ought to be conducted after 60 days has lapsed. The essence of this is to

ensure that the mortgagor is given enough time to remedy the situation and if possible regularize the default back to the right track as agreed between the parties.

In the case of Margareth Mukasa vs Akiba Commercial Bank Ltd & 4 others, Land Appeal No. 02 of 2020 at pg. 13, the court stated that it was

improper for the bank to proceed with sale while the statutory 60 days had not lapsed.

Further, in the case of Beatus Issack Asev (T/A Assay Traders) vs EFC Tanzania Microfinance Bank Ltd & 2 others, Land Case No. 267 of 2017 faced with a scenario that notice was not issued among other issues.

The court nullified the sale since the purchaser had not finalized transfer of title process. Section 127 (2) of the Land Act provides how or what issues should be contained in the said notice such as nature and extent of default, intention to proceed with mortgage action to be taken and after lapse of the 60 days then all amount will be due and the property will be liable for sale. These are basic things that ought to appear in the said manda-

tory notice.

Secondly, after one has issued notice and still the mortgagor has not cleared his or her arrears, definitely auction procedures will have to follow, mostly the bank will appoint auctioneers or others to proceed to the next stage.

In this stage, section 134(2) of the Land Act provides that the mortgagee shall have a duty to make sure that before conducting a public auction, the same is publically known. In line with the said section 134 of the Land Act, another piece of status is the Auctioneers Act, Cap 227 which under section 12 provides that in case of immovable landed property; mandatory 14 public notices ought to be issued.

This has the intention to call among others, the mortgagor to redeem his or her property if he or she wants so and also attract best price from the public. Thus, if the mortgagor appears before the auction and clears the arrears, then the auction ought to be cancelled.

There are some basic tice was stressed as well as things which an auctioneer ought to know while doing the sale by way of public auction. These are under section 133 of the Land Act. The mortgagor while discharging his or her right to auction the mortgaged land shall do the same with duty of care to the mortgagor, meaning they must find the best price in the sale by way of auction.

Secondly, valuation to establish the value of the property is vital since it assists or establishes the market price at the time of auction.

Lastly, the purchase price ought not to be below 25 per cent of the current market price. This is as per section 133(2) of the Land Act as held by the court in the case of Mbaruku Msangi vs Tanzania Women's Bank Ltd, Land Case No. 7 of 2016.

The court has on several times stressed the necessity of notice. In the case of NMB Bank Plc vs Neema Lyatuu & 2 others, Land Appeal No. 98 of 2021, the court stated among other the necessity of 14-day notice to give time to the mortgagor to redeem his or her prop-

erty.

Failure to abide to the same sometimes can nullify auction. For example, in the case of Andrew Anthony Sindabaha vs Akiba Commercial Bank & 3 others Land Case No. 56 of 2017, the necessity of noin the case of Registered Trustees of the Africa Inland Church Tanzania vs CRDB Bank & 3 others, Commercial Case No. 7 of 2017. All these ruled inter alia that 14-day notice is mandatory. They only differed on the effect of non-

adherence to the same. There are scholars who are of the view that if there is noncompliance of procedures in auction and an auctioneer had been appointed, then the auctioneer is to cover the liability. This approach is used mostly in Nigeria.

But in our jurisdiction, section 134 (2) of the Land Act states that the bank has not been exonerated since it has to make sure that compliance of the law is done.

Further, there has been debate about whether noncompliance can affect the sale. This too depends on how one approaches the court since some judges and justices stand that noncompliance vitiates all sale while for others it depends on whether the purchase was finalized and transfer of land effected or not.

Recently, in the case of

Civil Appeal No. 25/17 of 2017 the Court of Appeal stated that if there is default and there is noncompliance, that one cannot nullify sale. Rather, the mortgagor is entitled to institute suit against the mortgagee to claim for damages. This position reiterated in the recent case of Margareth Mukasa vs Akiba Commecial Bank Ltd & 4 others, Land Appeal No. 02 of 2020. In conclusion, both par-

EEING a sitting president is only easy on television. But physically, and at spitting distance that comes with photo opportunity, many try it for months or even years across the world, unsuccessfully. For, a very strong reason

Market visit gives traders rare opportunity to rub

of 5,000/- just to buy fish, wondering if most families have extra cash to buy the maize flour and spices.

In their response, the traders said they too obtain fish at high prices from a major fish market in the region where a small fish fetches up to 2,000/-.

At a food kiosk operated by a woman, she inquired on the progress of the business and the trader recounted that currently, her business was not faring well as she could not get enough customers. Perhaps aware that golden chance never comes twice, when the president was bidding farewell to the trader, the food vendor asked for a support of 100,000/- working capital to boost her business and revamp the kiosk. "I will give you 500,000/- for capital and your Member of Parliament who is here will take care of the improvement of your kiosk," the president said and left the woman awestruck. She proceeded to another kiosk also run by a woman who sells various groceries. Here, the president bought vegetables and various cooking ingredients before proceeding to fish mongers and had a chat with them on the status of their business and how they can improve the same. President Samia instructed some of his aides to take note of the needs of the women traders and work on their requests. As I noted earlier, just a simple word from a sitting president can shake up things tremendously. Transformation of livelihoods requires programmes that seek to root out challenges facing the people. Granted, but if you look at it analytically, the president's gesture was meant to inspire and encourage. Was it a coincident that most of her stops were at stalls operated by women? Yes and No. Yes because most market vendors are women. No because as the first female president, she is aware of the plight of women and therefore chose to inspire and encourage them. Various studies outline barriers to women's economic inclusion in the economy such as unpaid labour (spending so much time on household chores) and lack of landed assets and access to financial services.

must be provided beforehand through aides and the same carefully examined before access is granted.

This 'difficulty' is important to protect both the person holding the position at the time and the sanctity of the office. In our case, the president serves as both head of government, namely the nation's chief administrator and head of state which refers to the symbolic embodiment of the nation.

This is because a word or directive of a president can bring unexpected goodies, resume stalled projects or see some underperforming officials packing.

Generally, for ordinary people like market vendors, seeing a president is a big thing. Today, some folks in Nzega Township, Tabora Region, are prominent in their own right. This is after President Samia Suluhu Hassan visited their market and rubbed shoulders with them.

For market vendors to appear on TV and front page of newspapers with the Head of State means a lot to them. Presence of a president gives hope when there none and momentum when things slow down. And traders at the market in Nzega are now a happy lot because the president not only pledged to boost their businesses; she did actual shopping for groceries there.

But meeting ordinary people, especially by charismatic individuals is also a very good leadership strategy. This allows them to utilize their charm and interpersonal skills to inspire, motivate and influence their followers.

President Samia who is in a working tour of the region said she wanted to talk to the people and hear their challenges. As she walked past the crowd that gathered alongside the road, she was received with rapturous applause from the delighted traders.

The president asked traders questions on the price of food at the market where she was surprised to hear that fish sell at higher prices compared to meat, with food vendors selling a plate of food at between 1,500/- and 2,000/- while fish (usually Nile Perch) sells at 1,000/- a piece.

She remarked that food prices were just too high as a family of five would need upwards

South Asian community health workers say their work is 'work'

PROFESSIONALLY, I am still where I was 23 years ago when I started working as a lady health worker (LHW)," said a disgruntled Yasmin Siddiq, 47, from Karachi. "I will probably retire in the same capacity, as a Grade 5 government servant, without any hope for upward mobility."

The idea behind the Lady Health Worker Programme (LHWP), the brainchild of Pakistan's late prime minister Benazir Bhutto, began in 1994 with the purpose of "training women as community health workers (CHWs) to improve the dismal maternal and child health scores of the country and build a bridge between the village woman and the formal health sector," said Dr Talat Rizvi, a public health physician with a vast experience in Maternal and Child Health with a particular focus on communitybased projects and who designed the programme.

Siddiqi's day starts at 9 am, and she must go door-to-door, covering between 5 to 10 homes within the 1 km radius of her home. "Initially, my tasks included making married women (of reproductive age) aware of the benefits of family planning and informing and providing them assistance about contraceptives, ensuring they go for antenatal checkups when pregnant and their tetanus shots. I had to keep an eye on under-five children of that family and get them vaccinated," she said. Over the years, her workload has expanded.

"We were asked to help fight TB, handle refusals by parents on administration of polio drops, ensure every child under five gets immunised against childhood diseases, which have now increased to 12 vaccines, and recently during the COVID-19 pandemic, we helped with vaccinations," said Bushra Bano Arain, chairperson of All Pakistan Lady Health Workers Union. "And as if health is not enough, we are asked to carry out our duties on election day," disclosed Arain, an LHW supervisor.

"Over the years, the focus got diluted from primary healthcare when more and more responsibilities were added to the LHWP's boat, and the boat sank," said Rizvi.

"The original programme of ensuring the health of mother and child took a backseat," agreed Dr Shershah Syed, a gynaecologist and obstetrician. "LHW was perhaps started with good intention but had become a politicised entity

The same is the case with the LHWs, said Musarrat Basharat, an LHW and the general secretary of the Punjab LHW's Union. "Whatever time of the day or night it is, we must accompany a woman in labour to the health centre and be with her till she delivers. Same with a sick child. If the baby has diarrhoea and is dehydrated, we must rehydrate and be with the family for six hours until the child is out of danger. We are not shirking from our duty, but at least pay us for overtime or make some provision for it," she said.

However, of the CHWs in the three countries, over 100,000 LHWs have won significant gains in getting themselves recognised as workers, securing a wage and registering their unions, Kannan Raman, secretary PSI, South Asia:

"In Nepal and India, they are considered volunteers and not offered decent wages or better working conditions."

"It took us 20 years to get ourselves noticed when the Supreme Court of Pakistan asked the government to bring us into the fold of formal work and make us permanent employees in 2014," said Haleema Leghari, central president of All Sindh Lady Health Workers and Employees Union, working as a supervisor in the LHW programme. But even after nine years, they continue working without a job structure or rules that go with that. "We rejected the service structure made for us as it was found to be discriminatory," said Leghari, adding: "Recognition from the government is mere lip service."

Even for those who started in

1994, like Arain and Leghari, who have become supervisors, their grades have been marginally improved from Grade 5 (which is for LHWs) to Grade 7 (which is for the supervisor). "While in other sections of the health departments, those who have worked as many years as us and are as educated as us have reached Grade 14; why have we not been upgraded?" Arain asked.

Although their salary was increased by 35 percent in June, Leghari said: "We do not want these ad-hoc increments; we want promotions like other government servants are promoted based on work performance, education and years of service, as these impromptu increments can also be taken back anytime."

In addition, she said that those

who have retired after attaining 60 years of age, are sick, or have died should be compensated. They or their families should be paid the pension in arrears," she added. Today, the LHWs want the 20 years of contract work to be accounted for, which they say "everyone seems to have forgotten".

According to Leghari, in other government departments, when an employee retires or meets with an accident, is sick or dies, a family member gets the job in that department. "We are missing out on these benefits because the rules have not been approved in the absence of a service structure," she said.

"Their main demand is foolproof security," said Mir Zulfiqar Ali, executive director of Workers Education and Research Organisation. "You know so many LHWs have been killed by extremists," he said. His organisation is working with the LHWs and training them about labour rights, health protection especially during crises and pandemics, and workplace safety and how to lobby effectively with the government to get their demands accepted, coordinating the PSI CHW project in Pakistan.

Siddiqi's monthly payment is now Rs 44,000 from Rs 37,000 since June, but given the skyrocketing food, electricity and fuel prices, she said this was certainly not enough for a single mother with two school and college-going kids.

"The provincial health departments have time to meet all the international NGOs and donor agencies, but for holding a meeting to address our grievances, they can never find time," said Arain.

"The invaluable work community health workers do work that has delivered immeasurable value to communities and public health, is not valued, simply because it is carried out by women, and

with many women recruited by MPAs and MNAs as ghost workers, in the Sindh province especially," he added.

The situation is no better for the over a million Accredited Social Health Activists (ASHAs) in India or the 52,000 Female Community Health Volunteers (FCHVs) of Nepal, who have, over the years, been lumped with more and more tasks, according to Public Services International, a global trade union federation, which helped the women CHWs in Pakistan, Nepal and India come up with a Charter of Demands to "address injustices and advocate for better working conditions".

According to Jeni Jain Thapa, PSI's project organiser in Nepa, the FCHVs "have no fixed working hours and must be on standby 24/7".



women's care work is routinely devalued, even when it saves lives", explained Kate Lappin, the Asia Pacific regional secretary for PSI.

With new climate catastrophes imminent, Lappin said Pakistan will need the services of LHWs even more, as was proved during the pandemic and the 2022 floods that disrupted the already fragile health system. "They [CHWs] are the first line of defence in a crisis." She was in Pakistan recently and met with LHWs from some remote parts of Pakistan. "It was clear that they are often the only source of support to women in the most underserviced areas."

NVESTING efforts to improve reproductive, maternal, new-born, child and adolescent health in the country is a critical matter which needs combined efforts from the government, development partners and stakeholders.

To complement the government's initiatives aimed to address maternal and child mortality, as well as to improve the overall health and well-being of mothers and children in the country, Marie Stopes Tanzania in collaboration with stakeholders has been backing up efforts by providing sexual and reproductive health (SRH) education to health workers and the public in general.

Head of Clinical Quality at Marie Stopes, Dr Selemani Mbyallu said that Tanzania was among countries which have signed a number of various agreements to ensure that reproductive health is managed to reach various people.

"Until Tanzania agrees to an international agreement, it means something that they are committed and will supervise to ensure that goals are reached to ensure that it properly manages their various agreements that they set for themselves as a member country in the aspects of ensuring that Tanzania stands up to the health issues which include ensuring that Tanzanians are accessing family planning," Dr Mbyallu detailed this recently at an interview with this paper.

He said sexual and reproductive health policies are vital to empowering women and the youth, thus constituting a cornerstone of sustainable development, speakers said today as the Commission on Population and Development continued its general debate.

Dr Mbyallu said providing adolescents with evidence-based comprehensive sexuality education is a concrete way to prevent unwanted pregnancies, prevent the spread of sexually transmitted infections and foster gender equality.

According to him, through an

outreach model which serves high impact clients, particularly adolescents and those living in poverty, in difficult to reach areas, the organization works closely with the government to improve access to high quality contraception and sexual reproductive health services and information to people in rural and remote communities of Tanzania.

He said provision of sexual and reproductive health education is aimed at equipping help women and girls to make terprise approach to expand

young women entrepreneurs with self-awareness making them to conduct better decisions throughout their life.

Lack of accurate and adequate information about sexual and reproductive health leads young people to engage in risky behaviours and thus expose themselves to sexually transmitted diseases, HIV, teenage pregnancy and other problems," he added.

Recently, Minister for health Ummy Mwalimu said the government has been implementing various international agreements by incorporating SRH in various national plans for a healthy and wellinformed society.

She cited some of the programmes as the National Plan for Reproductive, Maternal, Newborn, Child and Adolescent Health & Nutrition-2021/2022 - 2025/2026 (One Plan III), National Accelerated Action And Investment Agenda For Adolescent Health And Wellbeing - NAIA-AHW) 2021/22 - 2024/25) and Tanzania's Health Sector Strategic Plan- 2020/21-2025/26, among others.

She said that in the period between July 2022 and March 2023, the government bought and distributed 2,538,247 contraceptive pills equal to 89 percent of the target, Depo-Provera contraceptive injections 2,564,691 doses equal to 94 percent of the target and 552,494 implants equal to 81 percent of the target.

Minister Ummy also said that the government has continued to deliver the services to the people through outreach services to ensure that they reach even those in remote areas.

She said due to the investment, there is an increase in the use of modern contraceptives from 32 percent in 2015/16 to 38 percent in 2022/23, according to the Tanzania Demographic Health Survey 2022 (TDHS).

"Currently, 38 percent of married women are using contraceptive methods, 31 per cent are using modern methods, whereas 7 per cent use traditional methods, roughly the same as reported in the 2015/16 TDHS," she noted.

Ummy said: "Along with providing family planning services, the Ministry has continued to prepare various guidelines, regulations, policies and laws that promote provision of reproductive health rights."

Xi Jinping announces major steps to support joint pursuit of high-quality Belt and Road cooperation

HE Chinese President Xi Jinping (pictured), has announced major steps China will take to support joint pursuit of high-quality Belt and Road cooperation (BRI) objectively targeted to create an inclusive developed world.

He gave the remarks yesterday as he officiated the official opening Ceremony of the Third Belt and Road Forum for International Cooperation dubbed: Building an Open, Inclusive and Interconnected World for Common Development held yesterday in Beijing China.

He said the BRI is targeted in building a multidimensional Belt and Road connectivity network that will speed up high-quality development of the China-Europe Railway Express, participate in the trans-Caspian international transportation corridor, host the China-Europe Railway Express Cooperation Forum, and make joint efforts to build a new logistics corridor across the Eurasian continent linked by direct railway and road transportation.

"I wish to announce eight major steps China will take to support our joint pursuit of high-quality Belt and Road cooperation one being on how we will vigorously integrate ports, shipping and trading services under the "Silk Road Maritime," and accelerate the building of the New International Land-Sea Trade Corridor and the Air Silk Road," he said.

He also said that BRI is dedicated in supporting an open world economy as it establishes pilot zones for Silk Road e-commerce cooperation, enters into free trade agreements and investment protection treaties with more countries.

"We will remove all restrictions on foreign investment access in the manufacturing sector. In light of international highstandard economic and trade rules, we will further advance high-standard opening up in cross-border service trade and investment, expand market access for digital and other products, and deepen reform in areas including the state-owned enterprises, digital economy, intellectual property and gov-



ernment procurement," he added.

According to him, China will hold the Global Digital Trade Expo annually. In the next five years (2024-2028), China's total trade in goods and services is expected to exceed \$32 trillion and \$5 trillion respectively.

He further stressed on how China will promote both signature projects and "small yet smart" livelihood programs highlighting on how The China Development Bank and the Export-Import Bank of China will each set up a RMB 350 billion financing window.

"We are also eying on promoting green development. We will continue to deepen cooperation in areas such as green infrastructure, green energy and green transportation, and step-up support for the BRI International Green Development Coalition," he said.

He also noted on advancing scientific and technological innovation that will

continue to implement the Belt and Road Science, Technology and Innovation Cooperation Action Plan, hold the first Belt and Road Conference on Science and Technology Exchange, increase the number of joint laboratories built with other parties to 100 in the next five years, and support young scientists from other countries to work on short-term programs in China.

"We will support people-to-people exchanges. China will host the Liangzhu Forum to enhance dialogue on civilizations with BRI partner countries. In addition to the Silk Road International League of Theaters, the Silk Road International Arts Festival, the International Alliance of Museums of the Silk Road, the Silk Road International Alliance of Art Museums."

He further strengthened on promoting integrity-based Belt and Road cooperation. Together with its cooperation partners on releasing the Achievements and Prospects

of Belt and Road Integrity Building and the High-Level Principles on Belt and Road Integrity Building, and establish the Integrity and Compliance Evaluation System for Companies Involved in Belt and Road Cooperation likewise strengthening institutional building for international Belt and Road cooperation.

President Xi said when COVID-19 struck, the Belt and Road became a life-saving road. China provided more than 10 billion masks and 2.3 billion doses of vaccines to other countries and jointly produced vaccines with over 20 countries, making a special contribution to BRI partners' efforts in fighting COVID-19. And China also received valuable support from more than 70 countries when it was hit hard by the pandemic. Russian President Vladimir Putin, also stressed on cementing its ties with China in the business area pledging on the other hand to support the education sector as

they enrol youth in China in different programs.

Kenyan President William Ruto hailed the mutual ties between his country and China perceiving it as a win- win cooperation.

Reacting to the rhetoric that China's aid to Africa is dept trap' Ruto said that African countries have been able to negotiate for themselves what they think is balanced and fair for the African people and to China as a partner.

"There is a myth, there is a rumor, there is a perception. The reality is that our largest debt is not to China. We have a huge obligation to the World Bank, the International Monetary Fund, the European Union, the United States and many other organizations," he said.



Dar city to turn household waste into cash

THE Dar es Salaam City Council in partnership with Mazingira Plus Institute and Tanzania Alliance for Climate and Sustainable Society (TACSS), have launched an Inclusive Climate Action project (ICA) that aims to turning household waste into business opportunities.

Through the project, waste pickers will be educated on how to add value into household wastes by turning them into livestock foods and decorations, for improving their lives economically.

Speaking at the launch of the project yesterday in Dar es Salaam, the city Mayor Omary Kumbilamoto, said the goal of the project is to reduce or curb accumulation of wastes in landfills, which results in to generation of methane, the major source of greenhouse gases.

The project will involve foods and other solid waste generated from households.

He said 60 percent of the waste produced at home can be reused; so they have thought it is good to provide education to groups of street waste pickers at the local level that will enable them use the opportunity to earn incomes.

He said they have chosen to work closely with the group in recognition of their great contribution to keeping the city clean by collecting waste from houses, despite the challenges they are facing.

"Dar es Salaam recognizes the importance of working and empowering informal communities and informal workers to collectively create policies and sustainable plans for waste management," he said.

He thanked the Global Community of Mayors (C40's) for funding the project through the ICA fund to achieve



the implementation of the project, which will also strengthen cooperation with waste pickers and achieve the goals they set for themselves.

The city council's Chief Environmental Officer, Monica Mosha, said the project will be implemented for one year, starting at Vingunguti ward before rolling out to other areas, depending on the availability of the funds.

Monica, who is the coordinator of the project, said that they have started with the Vingunguti ward because

it has informal settlements whose infrastructure is not easily accessible by large waste collection contractors, which is resulting into delays in collection of waste.

"We are also expecting to conserve environment, because when it is clean, there are lots of benefits such as clean air, prevention of diseases like cholera," said Monica.

The Operations Manager of TACSS, Dativa Asemwe, said they will participate on project by providing education to waste pickers on how to use the opportunity to generate income and make the city clean.

Waste picker, Elizabeth Ndunguu, said the project will give them an opportunity to learn on turning waste into cash, something she was not aware of before.

She is also expecting to get modern equipment that will facilitate the performance of their work and prevent them from various diseases they face from time to time by using poor equipment in collecting waste.

World Bank bans Vietnamese construction firm over 'fraud'

WASHINGTON

The World Bank has announced the 41-month debarment of Vietnam based HTC Construction and Advanced Technology Joint Stock Company (HTC), a construction firm, in connection with fraudulent and obstructive practices under the World Bank-financed Coastal Cities Environmental Sanitation Project; the Da Nang Priority Infrastructure Investment Project; the Medium Cities Development Project; and the Irrigated Agricultural Improvement Project, (collectively the "Projects"), in Vietnam.

The debarment makes HTC ineligible to participate in projects and operations financed by institutions of the World Bank.

It is part of a settlement agreement under which the company acknowledges responsibility for the underlying sanctionable practices and agrees to meet specified corporate compliance conditions as a condition for release from debarment.

According to the facts of the case, at the time of bid submission, HTC misrepresented its financial statements and inflated the values of its past contracts in order to mislead procurement officials into awarding the company contracts under the Projects.

Furthermore, during the inves-

tigation conducted by the World Bank's Integrity Vice-Presidency (INT), HTC consistently denied the applicability of the World Bank's inspection and audit rights and refused to provide INT with evidence, thereby materially impeding the investigation.

HTC's conduct constitutes fraudulent and obstructive practices under the World Bank's 2010 and 2011 Procurement Guidelines.

The settlement agreement provides for a reduced period of debarment in light of the company's admission of wrongdoing and voluntary restraint from bidding on World Bank funded Projects. As a condition for release from sanction under the terms of the settlement agreement, HTC commits to implementing integrity compliance measures that reflect the principles set out in the World Bank's Integrity Compliance Guidelines.

In addition, any affiliate that the company controls, directly or indirectly, will be required to similarly implement appropriate integrity compliance measures. The company also commits to continue to fully cooperate with INT.

The debarment of HTC qualifies for cross-debarment by other multilateral development banks under the Agreement for Mutual Enforcement of Debarment Decisions that was signed on April 9, 2010.

The 20,000km of railway that criss-cross South Africa once symbolised the nation's mining might, carrying trains loaded with coal and iron ore destined for India, China and other markets under the state's Transnet freight monopoly.

HSBC Holdings Plc has nearly doubled the size of a loan arrangement to part of Indian billionaire Mukesh Ambani's (pictured) business empire, bolstering its bet on Asia's richest person.

The London-based bank originally provided a £60 million (\$73 million) loan facility to a subsidiary of Reliance Industries Ltd. shortly after it acquired the Stoke Park estate in southeast England for £57 million in 2021, according to UK registry filings.

It has since extended the arrangement three times, with the latest disclosed increase in December taking it to £115 million, the filings show. HSBC has been



China's property stocks drops to lowest since 2009 on rise in stress

BEIJING

Chinese property stocks tumbled to close at the lowest level in 14-years, as weak home sales and rising debt woes for major developers deepened.

A Bloomberg Intelligence gauge of developer shares fell 2.5 percent Wednesday, with China Evergrande Group and Times China Holdings Ltd. leading the decline. The gauge has plunged 44 percent so far this year, outpacing major benchmarks onshore and in Hong Kong.

Pressure is mounting after Country Garden Holdings Co., China's former top builder, signaled it is headed for a firstever default as a grace period to meet an interest-payment deadline ends. Weak property investment and sales, which was a laggard during an otherwise upbeat Chinese economic data release, highlights the need for stronger measures to contain an unprecedented housing crisis.

"The market is turning more bearish with Country Garden's potential dollar bond default," said Patrick Wong, a



Bloomberg Intelligence analyst. The future of the industry "really depends on any further easing measures to support the housing market."

Country Garden, which is at the center of China's property crisis, must pay \$15.4

million coupon on a dollar bond by the end of a 30-day grace period Oct. 17-18 or a default can be called. The company hasn't clarified which day marks the official end of the period, given the initial missed deadline of Sept. 17 fell on a Sun-

day.

Meantime, Evergrande faces the onceunthinkable possibility of asset liquidation on Oct. 30 when a key court hearing takes place. A ruling to wind up the firm would wreak havoc on the struggling real estate giant that's trying to finalize a restructuring plan to pay back creditors.

Latest data showed that China's property slump remained a drag on the economy in September despite several steps taken by authorities in recent months to bolster the sector.

Property investment, a key driver of economic activity, contracted 9.1 percent in January-September from a year ago, a bigger drop than the 8.8 percent decline in the first eight months of the year.

Home sales continued to slide, falling 3.2 percent year-to-date, while construction of new homes plunged almost 24 percent in the period.

In more bad news for cash-strapped builders, funding for property development dropped 13.5 percent on-year in the first nine months, after plunging 12.9 percent in the January-August period.

THE United States on Wednesday vetoed a Security Council resolution that would have called for humanitarian pauses in Gaza.

The Brazilian-drafted resolution won the support of 12 of the 15 members of the Security Council. The United States, which has veto power, was the only council member that voted against it.

Britain and Russia abstained. Before voting on the Brazilian draft, the Security Council voted separately

on two amendments to the Brazilian draft submitted by Russia. The Russian amendments - on a call

for an end to indiscriminate attacks on civilians and civilian subjects, and a call for a durable humanitarian cease-fire, instead of humanitarian pauses contained in the Brazilian text - were unable to pass as there was not enough support by council members.

The US was the only council member that voted against the Russian amend-

In an explanation of vote, US ambassador to the United Nations Linda Thomas-Greenfield said her country "is disappointed this (draft) resolution made no mention of Israel's right of selfdefense".

French UN ambassador Nicolas de Riviere told reporters after the vote that his country does not see any contradiction between supporting Israel after Hamas' attack and protecting civilians, granting humanitarian access, calling for full respect for international humanitarian law and Geneva Conventions, which were basically the Brazilian draft all about.

Russian UN ambassador Vassily Nebenzia blasted the US for its "hypocrisy and double standards."

Brazilian UN ambassador Sergio Franca Danese regretted the fact that his country's draft resolution was vetoed.

"Sadly, very sadly, silence and inaction prevailed - to no one's long-term interests," he said. "While we deeply regret

collective action is made impossible in the Security Council, we do hope that efforts by other actors will yield positive results. Hundreds of thousands of civilians in Gaza cannot wait any longer. Actually, they have waited for far too long."

China's UN ambassador Zhang Jun said his country was shocked and disappointed at the result of Wednesday's voting.

Certain countries voted on Monday against a Russian-drafted resolution, which would have called for a humanitarian ceasefire. Those countries said they wanted more time to seek consensus on the basis of the Brazilian-drafted resolution. Brazil and many other council members showed a constructive attitude and agreed to postpone the voting for 24 hours, and again till Wednesday, he

said.

In the past 40 hours, those countries have neither commented on nor expressed opposition to the Brazilian draft, making people believe that the council would be able to adopt a resolution on Wednesday. The final result is unbelievable, said Zhang.

"Certain countries talked about the importance for the council to take the right actions. However, the way they voted only makes us question their willingness to let the council take any actions and their sincerity to find a solution to the problem," he said.

The Security Council on Monday failed to adopt the Russian-drafted resolution. The draft resolution failed to win enough votes in favor for adoption. The US, together with Britain, France and Japan, voted against it. Xinhua



China, Russia agree to advance ties

BEIJING

PRESIDENT Xi Jinping underlined China's readiness to enable a higher and deeper level of regional cooperation between the Belt and Road Initiative and the Eurasian Economic Union, during talks with Russian President Vladimir Putin on Wednesday.

The two leaders met shortly after the conclusion of the opening ceremony of the third Belt and Road Forum for International Cooperation in Beijing. It marked the 43rd meeting between the two leaders since 2013; their last meeting was held in March, when Xi made his ninth visit to Russia.

Xi started the conversation by calling Putin "my old friend", saying that Putin's attendance at the Belt and Road Forum for the third time in a row demonstrated Russia's support for the initiative.

"Our political mutual trust is deepening, our strategic cooperation is close and effective, and our bilateral trade volume has reached a historic high, moving steadily toward the goal of \$200 billion that we jointly set," he said.

Meanwhile, major infrastructure projects, including the China-Russia east-route natural gas pipeline, have been put into operation, delivering tangible benefits for people of the two nations, he said.

Furthermore, the two leaders have also established "a good working relationship and a deep friendship" over the past decade, Xi noted.

China hopes that the China-Mongolia-Russia natural gas pipeline project and cross-border tourism cooperation along the Great Tea Road will make substantive progress in an effort to develop the China-Mongolia-Russia Economic Corridor into a route of high-quality connectivity and development, Xi said.

He emphasized that developing a China-Russia relationship featuring permanent good-neighborliness, comprehensive strategic coordination and win-win cooperation is a long-term commitment rather than a temporary fix.

With both sides set to celebrate the 75th anniversary of bilateral ties next year, Xi emphasized Beijing's readiness to work with Moscow to accurately grasp the overall trend of history and continue substantiating cooperation based on the fundamental interests of both peoples.

China supports the Russian people in pursuing a path of national rejuvenation based on their own choices and safeguarding national sovereignty, security and development interests, the president said.

He also highlighted the need for the two nations to promote high-quality development of bilateral pragmatic cooperation, actively explore cooperation in strategic emerging industries, and take the upcoming China-Russia Cultural Year as an opportunity to organize more cultural exchange activities.

Xi expressed support to Russia in hosting a successful BRICS Summit next year and is willing to continue strengthening communication and cooperation with Russia within multilateral frameworks such as the United Nations, Shanghai Cooperation Organization and G20, he said.

Addressing Xi as "my dear friend", Putin said the evolution of the international landscape fully vindicates Xi's strategic judgment that the world is facing major changes unseen in a century.

India extends sugar export restrictions until further orders

NEW DELHI

INDIA has extended the restrictions on the export of sugar beyond October 31, 2023, and until further orders, according to a notification by the Directorate General of Foreign Trade issued on Wednesday.

The raw sugar, white sugar, refined sugar, and organic sugar are under export restrictions.

The restriction is, however, not applicable to sugar being exported to the EU and the US under the concession (CXL) and TRQ quota as was announced last vear.

Initially, the restrictions were imposed starting June 1 to October 31, 2022, and

later extended by a year till October 31, 2023. A tariff rate quota essentially is a quota for exports at relatively low duties. Once the limit is exhausted, a higher tariff applies to additional shipments.

The idea behind the sugar export restriction initially was to make prices of sugar stable domestically.

Earlier, in July, India prohibited the export of non-basmati white rice to check the domestic prices and ensure domestic food security. While amending the export policy, DGFT maintained that the export will be allowed on the basis of permission granted by the government to other countries to meet their food security needs and based on the request of their government. By that virtue, India

has allowed the export of non-basmati white rice in varying quantities to Nepal, Cameroon, Cote d'Ivoire, Republic of Guinea, Malaysia, Philippines, Seychelles, UAE, and Singapore.

West African country Benin is one of the major importers of non-basmati rice from India. Other destination countries are UAE, Nepal, Bangladesh, China, Cote D' Ivoire, Togo, Senegal, Guinea, Vietnam, Djibouti, Madagascar, Cameroon Somalia, Malaysia, and Liberia. In late August, India also introduced additional safeguards by way of imposing a minimum floor price on exports of basmati rice so as to prevent exports of non-basmati white rice, which was already under the prohibited category since July.

Last week, the central government extended the 20 per cent export duty on parboiled rice till March 31, 2024, an official notification said. Rice which is partially boiled with husk is called parboiled rice.

Initially, the duty was introduced on August 25, 2023, and was due to remain effective till October 16, 2023, aimed at maintaining adequate domestic availability and checking its price.

India in September 2022 banned the exports of broken rice and imposed a 20 per cent duty on exports of non-Basmati rice, except for parboiled rice amid concerns about low production due to a fall in area under the paddy crop. It later lifted the ban in November. ANI

MINISTER of State (MoS) for External Affairs V Muraleedharan on Tuesday said that if required, more flights will be operated on the basis of the upcoming situation, noting that five flights have already arrived in the last few days.

"As of new, 5 flights have come and if required we will operate more flights on the basis of the situation that emerges," Muraleedharan said.

"During the last, almost 4-5 days, we have flown aircrafts from Israel to India," he added.

Following the Hamas attack on Israel, the Indian embassy issued an advisory and requested the Indian citizens living in Israel to be cautious and to register their names in the Indian embassy.

BRUSSELS

MINISTERS from across the European Union said yestersday that member states must screen migrants and asylum seekers better and expel those deemed a security risk more quickly, after Islamist attacks highlighted persistent difficulties.

Interior and justice ministers were meeting on Thursday in Brussels to discuss what steps to take following deadly attacks in Brussels and France, at a time of heightened security concerns linked to the Israel-Hamas conflict.

"It's important that those individuals that could cause a security threat to our citizens be returned forcefully, immediately," EU migration commissioner Ylva Johansson told reporters ahead of the meeting.

"We need to be more efficient, close the loopholes and be quicker on decisions to carry out returns."

The 45-year-old Tunisian gunman who killed two Swedish football fans in the Belgian capital on Monday was staying there illegally after his asylum request had been denied.

He reached the EU via the Italian island of Lampedusa in 2011 and also lived in Sweden. He was shot dead by Belgian police.

The 20-year-old, Russian-born Islamist Ingush accused of stabbing to death a teacher in northern France on Friday was known before the attack to be a possible security risk but could not have been expelled under current legislation, France said. "We realize there's still a bit naivety either in the institutions of some countries or in the EU," French Interior Minister Gerald Darmanin said as he arrived for the EU meeting, calling for the swift implementation of much-discussed EU migration rules, and for faster decisions on asylum requests.

Proponents of this looming overhaul of the EU's migration policies - expected to be finalised this year - say it would improve the situation, including by facilitating quicker repatriations of foreigners with criminal records.

The attack in Brussels underlined persistent failings of the EU's troubled migration and asylum systems, including security gaps and ineffective returns. Only about a fifth of people whose asylum cases fail in Europe are actually sent away.

Thursday's meeting will also be the ministers' first chance to exchange views in person since the Oct 7 attack by Palestinian militant group Hamas that killed at least 1,400 Israelis, mostly civilians, and to which Israel has responded by bombarding Gaza.

Conflict in Israel, Palestine may grow into full-scale war, says Medvedev

MOSCOW

THE conflict in Israel and Palestine can grow into a full-scale regional or even global war, Deputy Chairman of the Russian Security Council Dmitry Medvedev said in an article for the Izvestia daily.

"The Middle East is seeing another war. A cruel war without rules. A war based on terror and the doctrine of disproportionate use of force against the civilian population. As it is said today, both sides have gone 'berserk,'" he wrote.

"Of course, it is more important for us to achieve success in the special military operation in our fight against the neo-Nazi in Ukraine, but what is going on in Palestine and Israel cannot but cause concern," he stressed, adding that "wars often have close causes and unfold under the principle of interconnected vessels."

"The current conflict between Palestinians and the Israelis is no exception. This conflict has all the chances to grow into a full-scale regional war. Or even into a global war if the situation develops in a bad way," he pointed out.

China to work with partners to bring stability to world, says Xi

BEIJING

CHINESE President Xi Jinping yesterday called for working together to inject more certainty and stability into the region and the world, when he met with leaders and officials various countries who are in Beijing for the Third Belt and Road Forum for International Cooperation.

During his meeting with Egyptian PM Mostafa Madbouly, Xi said China and Egypt are good friends who cherish the same aspirations and trust each other.

China stands ready to work with Egypt to jointly safeguard international fairness and justice and the common interests of developing countries to inject more certainty and stability into the region and the world, he said.

On the current situation between Palestine and Israel, the Chinese leader stressed that the top priority is to ceasefire and stop war at an early date. It is crucial to prevent the conflict from expanding or even losing control and causing a serious humanitarian crisis, he added.

The fundamental way out of the recurring Palestine-Israel conflict lies in implementing the "two-state solution" and establishing an independent State of Palestine, so as to realize the peaceful coexistence of Palestine and Israel, said Xi.

He said China appreciates the important role played by Egypt in deescalating the situation and supports Egypt's efforts to open humanitarian corridors.

China is willing to enhance coordination with Egypt and Arab countries to facilitate a comprehensive, just, and lasting solution to the Palestinian issue at the earliest possible opportunity, he said.

Madbouly said that Egypt and Arab countries commended China for its consistent and fair stance on the Palestinian issue and look forward to China's more significant role in resolving the current crisis.

More dividends to Cambodian people

President Xi said China stands ready to advance the synergy of the Belt and Road Initiative with Cambodia's Pentagon Strategy and let China's development bring more dividends to the Cambodian people.

Namibia defends decision to kill problem-causing lion

WINDHOEK

In a move that has drawn international attention, Namibia's Ministry of Environment and Tourism on Wednesday confirmed the euthanasia of a problemcausing male lion in the Kunene Region that had been responsible for livestock killings.

This came after animal rights advocates sharply criticized the decision, claiming that the incident is indicative of broader issues with Namibia's approach to wildlife management.

However, Namibia has firmly defended its practices, emphasizing the need to balance the rights of its people with conservation efforts. "Our conservation successes are aided by the fact that community members have accepted to co-exist with dangerous predators and animals that at a time cause damage to their properties and, in unfortunate events, loss of human lives.

On the basis of this, we cannot afford to overlook the plight of the farmers to satisfy the emotions of animal rights groups," said Romeo Muyunda, chief public relations officer at the ministry. The male lion, estimated to be seven or eight years old, was declared a problem-causing animal and subsequently destroyed in the Palmwag area of the Kunene Region on Oct. 10.

According to Muyunda, the lion had been collared for monitoring purposes, and had killed 14 goats in July and a Brahman bull in the Plamfontein area. While efforts were made to manage the conflict, with various mitigation measures implemented by the lion rangers, the lion persisted in preying on livestock, causing increasing concerns among local communities and farmers, Muyunda said, adding that the government's decision to euthanize the lion also has an economic aspect.

Animal rights groups, claiming that the trophy-hunted lion was the last blackmaned desert-adapted lion, are demanding an investigation into the killing. According to Muyunda, the adaptability of lions to harsh desert environments, often referred to as desert-adapted, is not a result of genetic differences but rather their proficiency in navigating the terrain, exceptional mobility, and physical endurance; these lions are of the same species as those found elsewhere in the country, scientifically known as "Panthera leo." "Strictly speaking, the concept of desert lions is a marketing gimmick which has been used to imply endangerment or imminent extinction of these lions.

These lions are not at risk of extinction at all. In fact, their numbers have increased to the highest level in at least half a century over which aerial surveys were done, or credible estimates were made, "he said.Muyunda highlighted the growing concern about human-wildlife conflict and the ministry's continuous dedication to finding sustainable and respectful solutions to address this issue, aiming to safeguard the country's conservation and tourism successes.

Amrouche calls on clubs to give goalkeepers and strikers opportunities

TANZANIA's senior national men's football team head coach, Adel Amrouche, has advised the local clubs to provide opportunities to local goalkeepers and attackers to keep up with healthy competition.

Amrouche voiced the issue in his pre-match conference after Tanzania drew 1-1 in a friendly clash against Sudan at King Fahad Stadium in Saudi Arabia on Sunday.

The Belgo-Algerian gaffer said so after his team's attackers had squandered open chances, with the team experiencing a lack of options for the striking force on the bench.

Taifa Stars have the same options in 2023 in Kibu Denis, Simon Msuva, and Mbwana Samatta on the front three, while other strikers have failed to challenge the trio for permanent spots, with most of the remaining fail-

ing to keep up with consistency. Stars have scored six goals in their last 10 games, which is a low ratio per national team standards, with the last five games ending in 1-1 versus Sudan, and 0-0 against already qualified Algeria.

The team grabbed a 1-0 win against Niger, conceded a 1-0 loss when confronting Uganda, and had earlier won 1-0 against Uganda in AFCON group qualifications.

The tactician noted: "We need more games to test our players but especially we need to learn that we can't develop in the national team. That's the work of their respective clubs which is the same story with our keepers.'

"In Tanzania, most outfits are happy to have foreign goalkeepers but we all saw today how challenging it is when you don't

give our goalies opportunities."

"Without competition it is different, we now suffering with my challenges, I hope the federation is working out but it's not about the federation it's about clubs to help the national team because we are not playing for the city team or something like that we are playing for Tanzania," the coach added.

The gaffer queried: "How many strikers do we have in Tanzania that can score? I am not going to develop strikers in a few days, we can play well in the midfield but what about the front areas?"

"I don't see a striker who can score goals as many as possible, if I give an opportunity and no one delivers, I am sorry I will change."

The tactician stressed: "In the national team we should have our players ready, we don't develop players in the national

team.'

Amrouche weighed up his concern ahead of the 2023 Africa Cup of Nations (AFCON) finals in Ivory Coast next year, in which Tanzania has qualified for the third time.

The Tanzania envoys, slotted in Group F, will have to clear hurdles of Morocco, DR Congo, and Zambia, to earn a chance of marching beyond the group phase.

Taifa Stars will launch their Group F campaign with a tense match against Morocco on January 17 and, later on the same day, DR Congo will face Zambia.

On January 21, Morocco will play against Congo DR while Zambia will meet Tanzania. The last Group Stage fixtures have been scheduled for January 24 when Tanzania will confront DR Congo and Zambia take on Morocco.

Jadon Sancho has one last chance to save his **Man United career**

THERE are times when Jadon Sancho locks the door of the academy team dressing room, alone with his thoughts, and must wonder how it has come to this.

A £73 million move to Manchester United from Borussia Dortmund in July 2021 was supposed to provide the platform and exposure for the England winger to take his game to the next level.

But, of all the expensive signings who have funnelled through Old Trafford in the post-Sir Alex Ferguson era, few have found the going as tough or delivered as little on their promise as Sancho.

Sancho was given three months away by Ten Hag last season to address his physical and mental condition and now, for very different reasons, he finds himself working alone again. This time he is exiled from the first-team squad after a feud with the manager that is about to extend into a seventh week and shows no immediate signs of ending, despite the efforts of team-mates, staff and executives to break the impasse.

Visit United's Carrington training base on any ordinary day and, away from the noise and bustle of the under-18 and under-21 teams, let alone the first-team squad, you will find Sancho working one-to-one with individual coaches.

It is a sad sight and some details, in particular, point to the extent of the separation and isolation, which in itself feels uncomfortable given what Sancho worked through personally last season. Banished from the first-team set-up while he refuses to apologise to Ten Hag over his public outburst at the start of last month, Sancho must change in the academy dressing room.

But because strict safeguarding rules prevent him from sharing a dressing room with those academy players who are still classed as minors, the 23-year-old must change alone and with the door locked so there is no risk of anyone entering.

After a truncated last season and now this, it does not feel like Sancho does what he is paid to do very often these days and the longer his exile persists the more fans may wonder if they will see the player in that famous red shirt again.

There is, it should be said, a route back at Old Trafford for Sancho, or at least the pretence of one.

Ten Hag does not just want Sancho to say sorry in private, he requires a full public apology to mirror the action that saw the player take to social media and effectively accuse his manager of lying over the reasons for his absence in the 3-1 defeat at Arsenal on Sept 3.

According to Ten Hag, Sancho was omitted because of his "performance in training", to which the player reacted by telling his 2.2 million followers on X (formerly Twitter) that there were "other reasons" and that he had been made "a scapegoat for a long time which isn't fair". There have been other battles with Sancho. not least around his time-keeping, but speak to those with visibility of the situation and they will say such matters have been resolved. It is that social media post and its contents that remain at the crux of the problem.

Benzema, French minister clash over 'Muslim Brotherhood' claim

PARIS

HE lawyer of Karim Benzema has hit back at France's interior minister after he accused the French football star who plays for Saudi team Al-Ittihad of links to the Muslim Brotherhood Is-

lamist group. Interior Minister Gerald Darmanin made the accusations after the reigning Ballon d'Or winner and former Real Madrid forward posted a message on social media about the conflict between Israel and Palestinian militant group Hamas.

"All our prayers are for the inhabitants of Gaza who are once again victims of these unjust bombings which spare no women or children," Benzema wrote on X, formerly Twitter.

Hamas on October 7 launched shock raids into Israel, killing 1,400 people, mostly civilians, and seizing about 200 hostages.

Israel has since then launched wave after wave of retaliatory air strikes, killing more than 3,000 Palestinians in Gaza.

Darmanin, speaking on the CNews Channel, alleged that Benzema "has a notorious link with the Muslim Brotherhood", a Sunni Muslim Islamist group with

its origins in Egypt that is now banned by Cairo.

"This is false! Karim Benzema has never had the slightest relationship with this organisation," Benzema's layer Hugues Vigier said in a statement.

He said that Benzema was expressing "natural compassion" with "what many today describe as war crimes being committed in Gaza, but which does not detract from the horror of the terrorist acts of October 7, something not open to discussion".

The lawyer added that he was planning to file a complaint against Darmanin for his comments.

- 'Intolerable exploitation' -A source close to Darmanin doubled down on the minister's comments, criticising Benzema over an alleged "drift" towards a tougher interpretation of Islam over the last years.

But his lawyer Vigier said:

"We are once again witnessing an intolerable exploitation of Karim Benzema and the 'symbolic figure' that we like to make him."

Benzema, 35, who was born in France to parents of Algerian origin, has been one of the standout French stars of the last decade.

He joined the Saudi club on a hugely lucrative three-year deal this year after 14 seasons with Real Madrid where he lifted five Champions Leagues, four La Liga titles and three Copas del Rey.

But after a stellar 2021-22 season when he led Real to Champions League glory and was rewarded with the Ballon d'Or for the world's best player, he was troubled by injuries that ruled him out of France's World Cup campaign in Qatar last year.

Darmanin, 41, has carved out a reputation as a hardliner in the mould of his political mentor ex-president Nicolas Sarkozy and makes no secret of his own presidential ambitions.

French hard-left figurehead and three-time presidential candidate Jean-Luc Melenchon weighed in on the controversy to back Benzema while admitting: "I don't know you and I don't know anything about football."

"The government and its friends have chosen to demonise you," he said, accusing the authorities of seeing Benzema as "French only on paper".

Meanwhile, Liverpool and Egypt football star Mohamed Salah called for humanitarian aid to be allowed into Gaza on Wednesday as he pleaded for an end to "massacres" in the conflict between Israel and Palestinian militant group Hamas.

Gazans have been facing dire shortages as the territory was effectively sealed off in the wake of the October 7 attacks by Hamas militants on Israeli communities and military posts that claimed 1,400 lives.

On Tuesday, a deadly rocket strike hit a Gaza hospital that Hamas blamed on Israel. However, Israel denied responsibility, claiming the strike was caused by an er-

rant rocket fired by Palestinian militants. A Champions League and Premier League winner with

Liverpool, Egypt captain Salah, 31, is one of the most popular athletes in the Arab world.

"It is not always easy to speak in a time like this. There has been too much violence and too much heartbreak and brutality," Salah said in a video posted to his 62.7 million followers on Instagram.

"The escalations in recent weeks is unbearable to witness. All lives are sacred and must be protected. The massacres need to stop, families are being torn apart."

After a visit by US President Joe Biden to Tel Aviv on Wednesday, Israel said it had agreed to his request to allow aid into the besieged Gaza via Egypt due to mounting concern about dwindling supplies and warnings of a humanitarian catastrophe.

"What is clear now is that humanitarian aid to Gaza must be allowed immediately. The people there are in terrible conditions," Salah added.

"The scenes at the hospital last night were horrifying. The people of Gaza need food, water and medical supplies urgently.

"I am calling on world leaders to come together to prevent further slaughter of innocent souls - humanity must prevail."

CALL it a belated birthday present, perhaps. Sir Jim Ratcliffe turned 71 on Wednesday. For those who have amassed such riches, it is less a question of what others buy them and more what they buy for themselves. And in Ratcliffe's case, at a cost of £1.3bn, the answer may be a quarter of the club he has supported since he was a child in Failsworth. There are details to iron out and no deal will be finalised just yet but the Manchester United board will vote though probably not on Thursday - whether to accept Ratcliffe's offer.
