

Tourism Day, indoor travel show on today

N annual World Tourism Day memorial will be held alongside the second edition of East African's premier indoor travel and tourism show starts here today, climaxing on Wednesday.

Marcel Leijzer, the technical cooperation manager for the United Nations World Tourism Organization (UNWTO) is expected to be in place for this event, accompanied by top government officials from the responsible ministry, officials said.

Dustan Kitandula the Natural Resources and Tourism deputy minister and permanent secretary Dr. Hassan Abbasi, are expected, hosted by the regional commissioner, John Mongela.

The high-profile congregation that draws hundreds of tourism players from around the world, are partially in a better position to appreciate the country's endowments thanks to the impact of 'Tanzania: The Royal Tour' documentary prominently featuring President Samia Suluhu Hassan.

The World Tourism Day memorial and the indoor tourism and travel fair in the East Africa region are being organised by the Rethinking Tourism Africa (RTA), a travel consultancy, in partnership with the prestigious Institute of Accountancy Arusha (IAA).

IAA rector Prof. Eliamani Sedoyeka said that as a public academic institution IAA is duty-bound to partner with the community to share ideas, knowledge, research and innovation for sustainable development. The institute is collaborating with RTA to host events to mark World Tourism Day, he stated.

RTA official Edna Foya said that organisers are optimistic that this year's delegates and exhibitors will surpass the 400 received last year, thanks to international tourism market

BoT purchases gold, expects reserves boost

THE Bank of Tanzania (BoT) has begun implementing a plan to buy gold from small-scale miners and larger firms to simplify the country's mineral trade.

Emmanuel Tutuba, the governor, made this affirmation over the weekend when speaking with journalists at the BoT pavilion at the ongoing mining technology exhibition here.

BoT ia all out to boost internal reserves and increase the country's access to foreign currency, he said, noting that the government hast taken up a long time appeal from small miners and the country's gold miners to check the situation of not having a reliable market.

"We have started buying gold from small miners at the global market price," he said, affirming that even within the precincts of that exhibition, BoT has already bought 418 kgs at the main gold market.

He discounted the threat of BoT incurring massive losses like various banks that went bust after purchasing large amounts of counterfeit gold, as BoT buys processed gold at plants that add value at internationally accepted standards, thus it has no fear it will commerce with unscrupulous gold traders.

Traders and other members of the public who had deposited money in banks that went bankrupt need to take their documents to BoT to be repaid their deposits.

Dr Doto Biteko, Deputy Prime Minister doubling as Energy minister, opened the show. It was dominated by gold mining at the weekend, remarking that the central bank has been tasked with setting up the Tanzania gold reserve.

Already the government has taken a major step, asking members of the public and miners specifically to use this opportunities provided by the government to see their processed gold output.

Minerals minister Anthony Mavunde said that the mining sector's contribution to national income was growing, reaching 9.8 per cent at the end of the past year and leads in contributing to foreign currency earnings, set at 56 per cent of total earnings.

"During fiscal 2022/23 we sold gold and other minerals valued at 3.3bn/-," he said, pledging to enhance efforts to make the minerals sector increasingly the leading source of income for a breadth of the public.

The association's chairperson, Muhammedraza Dewii said in collaboration with the Muhimbili National Hospital (MNH) and the Ocean Road Cancer Institute (ORCI) they conducted breast cancer check-ups for 241 women while 163 others underwent cervical cancer testing.

He said the three-day camp was successful as it recorded a high turnout of people who visited to get medical services and education on Imam Hussain's teachings.

"Due to this huge turnout, we think of adding three more days for next year's camp so as to help more people," Dewji

Government unhappy with sensational reporting on the social media platforms

THE government has expressed dismay over the recent video that depicted a sevenvear-old child being punished with both hands and legs being tied up and left hanging in a high compound.

Dr. Nandera Mhando, Commissioner for Social Welfare in the Ministry of Community Development, Children and Special Groups made the remarks when responding to the recent video that went viral in various social media platforms, causing pensive mood to the public.

She said that displaying such kinds of videos is a sensational reporting that portrays acts of violation and children's rights which is contrary to section 9 of the Child Act of 2009.

She said: "The government had prohibited parents and media stakeholders not to capture and post pictures which portrays cruelty against children below 18 years old in an online platform or television or published in print media."

Dr. Nandera is of the view that such kinds of videos cause shock and furthermore creates an emotional move and anger which is likely to result in bloodshed in the community or among family members. asking those who take video and post in the social media to stop doing so.

RC gives RUWASA three days to connect water to villagers

NJOMBE Regional Commissioner Anthony Mtaka has given three days to the Rural Water and Sanitation Authority (RUWASA) in Ludewa District to make sure it connects water services to the project initiated by the people at Luvuyo village.

The project was suspended to pave way for the big Igongwi Water project that supply Njombe town in the region.

The RC issued the ultimatum at a public meeting at Luvuyo village held at Madope

Ward in Ludewa District. RC Mtaka said Luvuyo village already had enough water hence before the water is pumped to other areas, RUWASA is required to make sure water is available in the village within three days.

"Since the water here does not need miracles as it is always available, stop the water supply so that it first comes here to enable the residents to use the commodity," said RC

He added that the government cannot ignore the villagers' expectations in regard to water while the possibility for its supply exists as they have reliable water sources.

Ludewa District RUWASA manager, Eng. Jeremiah Maduhu said Luvuyo village has an old water project built under Roman Catholic Church sponsorship in 2012.

Maduhu added that the project's water ceed and finish the project," Simba said.

Some Luvuyo villagers in Madope Watd, Ludewa District, Aneth Sang'anile, Nico Mgogo and Adelina Mtega thanked the government by its intervention in the long time water challenges facing the village.

"We raised funds from among ourselves so that the project is completed but we are surprised to see the government building another project from our own water source higher up thereby denying us with water supply," Mtega said.





"We want to ensure justice for everyone, we will carefully supervise the sector for buyers to get what they deserve. It is the responsibility of citizens to respect country laws and defend their rights," he added, noting that land officers in big cities such as Mwanza, Dodoma Arusha, Dar, Mbeya and Coast region also conduct land clinics for purposes of providing education to the public.

NSSF collects 56bn/- from Geita Region's members contributions

THE National Social Security Fund (NSSF) has collected contributions totalling 56bn/- from Geita Region in the financial year that ended June 2023.

NSSF Director General, Masha MshombaMshomba said this when briefing the Deputy Prime Minister and Minister for Energy, Dr Doto Biteko who visited the fund's pavilion at the ongoing Sixth International Exhibition of Mining Technology at EPZA grounds, Bombambili in Geita Region.

NSSF is taking part at the exhibition because it is the only fund responsible for registering members from the private and informal sector which includes small-scale miners.

This year's theme for the exhibition is 'The use of the right technology in uplifting small scale miners economically and protecting the environment'.

"When President Samia Suluhu Hassan came to power, NSSF was collecting 29m/- from member's contributions in Geita Region alone, the amount has doubled in two years of the sixth phase government; this is a great success and we are optimistic that the amount will continue to increase in coming years," said the NSSF boss.

He noted that in the financial year that ended in June 2023, the value of collected contributions was 1.66trn/- which is higher compared to 1.48trn/- in the financial year ended June 2022.

ITILIMA District Council has embarked on a reproduction sensitisation campaign on family planning among the Sukuma tribe targeting at controlling ectopic pregnancy incidents occurrence.

The district has between January and August this year recorded ten ectopic pregnancy incidents of which one expectant mother lost her life. Briefing journalists yesterday in Itilima District, Magreth Mabebe, Itilima District reproductive and child health coordinator said that ectopic

pregnancy incidents in the district are attributed to poor adoption of family planning methods whereby the majority of women conceive within twelve months after giving birth.

According to her, adoption of family planning methods has jumped to 32 percent in August this year from 27 percent in August 2022 following the intervention of the USAID Afya Yangu-Reproductive, Material, Newborn. Child and Adolescent Health (RMNCAH project.

The district targets at attaining 45 percent of family planning methods uptake by 2025 as stipulated in the National Health Policy 2007.

The USAID Afya Yangu-RMNCAH is a five-year project implemented between January 2022 and January 2027 in collaboration with the government at the tune of \$66,835,592 (167.153bn/-).

"Ectopic pregnancy incidents have been happening because men don't give their wives enough time to recover from delivery;

With facilitation from the USAID Afya Yangu-RMNCAH thee district is sensitising men on the implications of conceiving before the recommended two-year lactating period after having birth," said Mabebe.

According to her, the district council in collaboration with USAID had in April this year trained four medical doctors and three midwives on professional skills required in attending women with ectopic pregnancy.

The experts have in turn extended the same skills to 30 health experts including nurses, midwives, community health workers and a few medical doctors on best practices of taking care women with ectopic pregnancy.

"The sensitisation campaign and training also targets at encourage pregnant women to start attending clinical sessions at earlier stages of pregnancy," said Mabebe.

She said ectopic pregnancy incidents are likely to be contained by giving mothers enough time to recover from delivery.

Mabebe asserted that the trained health experts came from Ikindilo Health Center, Nkoma Health Center and Itilima District Council Hospital. She said the district fertility rate stands at 1:8 which means one woman gives birth to an average of eight children.

Mabebe said the district fertility rate is supposed to be 1:5.

"We now have trained health experts to deal with ectopic pregnancy cases. We have so far attended one woman with ectopic pregnancy case,'

Itilima town was last month treated from ectopic pregnancy at Nguno Health Center, another health facility with trained health experts. She said on 9th August around 10pm she felt abdomen pains that led to

Nseka Ndabuya (30), a resident of Lung'wa village, 44 kilometers from

bleeding through are sexual organs. She was immediately rushed by her brother to Neema dispensary 20 kilometers away from the village.

She was further referred to Nguno Health Center in the midnight. "I was bleeding all the way on a motorcycle to the health center. I finally

fainted and found myself in caecilian room the next day," said Ndabuya. She said that her pregnancy was coming close to three months. Her husband was away on the day of the incident.

"I thank God for saving my life. I further thank the USAID Afya Yangu-RMNCAH for the intervention that had facilitated the training on ectopic pregnancy treatments know about to the district health experts," said

Kinyawanga Ndabuya (28), Nseka's brother said that his sister's treatment cost the family over 300,000/-. The treatment took two weeks and Nseka is capable of conceiving.

"My sister has three children. The last one is about to turn three years old. She now okey. We are grateful to USAID for the training to health centers health experts," said Ndabuya.

Kwandu Kidayi (22), Lung'wa village Community Health Worker said that her role is to sensitise the community on the importance of family planning for the women's health and prevention of ectopic pregnancy

"It's my hope the community will keep changing the perception towards family planning," she said.

Policy brief TRANSFORMING MATERNAL CARE IN TANZANIA THROUGH A DIGITALLY-ENABLED DEMAND-SIDE FINANCING MODEL

Data from 3-year maternal care program shows improvements in key maternal health indicators:







THE CHALLENGE: FINANCING QUALITY MATERNAL CARE FOR ALL IN TANZANIA

Tanzania has made huge progress in recent decades in improving maternal, neonatal and child health (MNCH) care, with programs such as routine immunization and prevention of mother-to-child transmission of HIV. Yet, Tanzania's Maternal Mortality Ratio remains stubbornly high at 524 per 100,000 live births1 - far above the UN Sustainable Development Goal target (70 deaths).

The government has implemented several policies to advance Universal Health Coverage (UHC). In 1992, cost sharing was introduced, with several health reforms adopted since then, including health insurance for the formal sector (National Health Insurance Fund - NHIF) and informal sector (Improved Community Health Fund - iCHF). These schemes have ensured financial protection for millions, however, iCHF's package does not cover antenatal care (ANC) and while the NHIF's package does, it only covers 8% of the population². In total, only 15%3 of Tanzanian's have health insurance and Out-of-Pocket (OOP) health expenditure has recently increased4 to 25%.

Along with care for the elderly and children under 5, maternal services are free in Tanzania, funded through taxes and donors through the basket fund. However, the current 'supply-side' financing model comes with leakage, inefficiencies and poor tracking of resources. For many low-income mothers, this means that services and funds are not available when they need them. Staff and commodities are often unavailable, equipment may be dysfunctional, and women therefore turn to private facilities where they are often required for pay to access parts of the services. This combination increases women's distrust towards service quality, while costs make them delay or forego seeking services, contributing to poor outcomes for mother and child.

For government, healthcare providers and partners, there is also limited reliable data on the financing and delivery of maternal care services. Data which is urgently needed to prevent health complications and ensure that scarce funds are maximized and channeled efficiently to those that need them most.


To improve MNCH indicators, mothers need access to quality, affordable and regular ANC visits, skilled-birth delivery and post-natal care (PNC) in a way that is transparent to all actors in the health ecosystem. In 2019 the development organization PharmAccess launched 'MomCare' in Northern Tanzania to achieve precisely this. The alternative financing model was implemented together with local government in the Manyara and Kilimanjaro Regions, at 40 healthcare facilities (public and faith-based). The following sections highlight the results and the key lessons learned for healthcare policy.

INTRODUCING THE MOMCARE MODEL

MomCare is digitally-enabled 'care bundle' that expectant mothers can sign up for. Once enrolled in the program, women received a MomCare card which is linked to a prepaid virtual money account. With this card, pregnant women could access quality maternal care services throughout their entire pregnancy, including facility-based delivery and postnatal care. In essence, MomCare is a 'smart-contract' between expected mothers, contracted clinics, and health service funders at predetermined cost and quality. Adherence to contract conditions is made transparent to all stakeholders using digital tools, and generated data triggers actions to providers and patients to improve the care process.

Mothers know up front which services they are entitled to and are empowered to choose where they want to access care. Healthcare providers use the MomCare card to charge for the services they have provided, with all services captured in a digital application. After submitting digital claims to the administrator, facilities are paid based on pre-agreed prices and services. All data submitted for payment were also analyzed and used to monitor the services provided to ensure it adhered to clinical guidelines, while helping medical staff uncover health disparities and manage high-risk patients. Since healthcare facilities were precontracted, they could use payments to purchase medical supplies and commodities for maternal care from MSD or a prime vendor, knowing they will attract more women to their facility for providing quality care.

Overall, the data showed that women enrolled in the MomCare program have safer pregnancy journeys due to the continuity of (quality) care, by following maternal guidelines and ensuring that clinics are continuously working and investing in quality improvement. MomCare thus contributed to better and safer antenatal and postnatal care, as well as an increased and improvement of referrals and skilled deliveries, reducing the risks Improvement was seen across all participating clinics when comparing the baseline (when they joined MomCare) to the endline (January, 2022). The graph on the right shows data for all mothers enrolled across 40 project health facilities, with improvements seen for key maternal health indicators, such as Early enrollment, ANC Profile tests and 4+ ANC visits, among others. In addition to quantitative data, the impact has also been validated by qualitative data through interviews with healthcare providers, patients

The MomCare model has shown a proof of concept for how a digitally-enabled demand-side financed mode can provide an efficient and transparent way of financing maternal care while empowering tens of thousand men and improving key maternal health outcomes

Crucially, the model provided accurate data, which can be used to track individual pregnant women (see Figure.1 above) or provide aggregated data for pregnant women accessing services at a facility or administrative area. The availability of these data is important to track quality of services provided to women and cost of

By paying facilities directly based on services they provide, we also found that healthcare providers are empowered to purchase required supplies as per their needs and minimize supply chain challenges, hence ensure availability of stock at all times. Furthermore, the direct payment has allowed facilities to make long lasting investments to their infrastructure and equipment, to ultimately strengthen the entire healthcare system. And, as services improved, patients' trust towards these services increased, making them more

likely to access services in the future and increasing their willingness to contribute towards health insurance

Since independence, the government has implemented several strategies to reduce maternal deaths in the country. Although there is recorded improvement, the number of maternal deaths is still disturbingly high So far, the maternal care financing in the country has been using supply-side model since independence. The results from MomCare suggest that perhaps it is time to think about changing the current model to a (digital-enabled) demand-side financing model. With the digital developments, it is now possible to target women and make sure the funds reach their digital wallet at almost zero costs.

The model also shows how mobile and digital technology can serve as an enabler to accelerate UHC and build trust and transparency in the healthcare system for healthcare provides, payers and patients. If scaled further, digital models such as MomCare should be integrated with government's digital systems (including electronic medical records) for interoperability, while government will also need to invest further in digital infrastructure in line with the National Digital Health Strategy 2021-2024.

VP was spot on: Global war economy crushing the poor

IT is not new that statesmen all over the world as well as researchers in international peace and security raise concern and even alarm over massive production of weapons and skyrocketing military spending. The argument is that this tendency fuels armed conflicts and has habitually compromised national visions and global promises made to the most vulnerable portions of humanity. They see their lives worsening, and at times the sky just caves in.

Vice President Dr Philip Mpango has made similar observations when addressing the 78th plenary session of the United Nations General Assembly in New York on Thursday. He pointed at what the massive trade in weapons and upsurge of wars around the world means for the most affected, who are children, women and the aged, who depend on the utmost efforts of others to have tolerable lives. He said that efforts be directed to build a better world and create opportunities for all, referring to the UN theme of leaving no one behind.

There are things that the VP mentioned which need some explanation, and that is also to say without facing a few issues in the face, finding a way to reaffirm global peace as a United Nations vocation is on trial. The VP said peace is being threatened by various factors including the withering away of historical solidarity and commitment to the principles of non-interference. The principle of equality between nations bequeathed by UN founding fathers is threatened.

functional, it has to be reinforced. It means there are variable standards as to what is good conduct at global level, which is often tolerated when it comes to economic policies, not when it means caring or not caring if one million people or slightly fewer will die in a conflict. If pleas for patriotism don't work, some systemic changes would help

A FLURRY of scaring news items on the way corruption is raging in various public institutions has caught the public eye lately, calling for answers that hardly anyone is in a position to provide. There were sharp remarks by a senior cabinet minister on how far people go about in paying millions of shillings to get jobs in the central bank or revenue authority. President Samia Suluhu Hassan raised public concerns over the way a syndicate was formed to interfere with a digitised revenue collection system in Mbeya Region; examples abound.

Similar observations were made by Prime Minister Kassim Majaliwa when ending a three days tour of Kigoma Region, directing his office to form a probe team to investigate the use of funds meant for various development projects in the regional municipality. There were unavoidable impressions of vast graft where the two examples the premier cited add up to nearly one billion shillings. It follows that appeals to patriotism and good governance fall on deaf ears; that miscarriage of development oversight needs strong arm rule to fully dissipate.

One area where problems are rife is the position of the district executive director, whom the current format of local government makes him a czar in the use of funds. How does one explain that the municipal council had received 500m/- from the ministry (President's Office, Regional Administration and Local Governments) which remained in the account and later disappeared to an unknown direction? It means no one in the place, or region, could follow it up.

Similarly, the sum of 447m/- was disbursed but its withdrawal was blocked by the DED and more than one year later the government is following up with previous district council leadership as to what happened to the funds. It is a sort of indication that even 500m/- disbursed to the district is their secret and can use it in the way they wish, and if misused, it takes a year for anyone to notice. What is remarkable is that no stakeholders are known to question this system.

There is a theme running as an undercurrent of global development partnership summed up by the notion of good governance, whose central aspect is civic rights, and belatedly, the fight against corruption. Usually the latter is grasped in terms of actually bribing public officials for personal advantage, but the way holders of public office, especially at executive level, gang up and sabotage public finances is singularly unknown in this outlook. It looks like an accident.

Owing to community and even political solidarity, punishing graft in public office has routinely proved to be a problem. Academic researchers and even administrators are aware that the more an operation is conducted entirely between public agencies, the easier it is for gross misconduct to be tolerated. When the private sector is involved, errors and misconduct are possible but on a much lower level; public agencies tend to be more eagle eyed in that direc-



Ten years on, China-Tanzania Belt and Road cooperation has yielded fruitful results

IN September and November 2013, Chinese President Xi Jinping proposed the building of the Silk Road Economic Belt and the 21st-Century Maritime Silk Road successively, which are known as the Belt and Road Initiative (BRI).

Focusing on policy coordination, facilities connectivity, unimpeded trade, financial integration and people-to-people bonds, the BRI has been transformed from ideas into concrete actions and from an initiative to an international public good as well as a platform for global cooperation with worldwide popularity.

Up to now, China has signed over 200 cooperation documents with 152 countries and 32 international organisations under the BRI framework.

The BRI originated from China, but its opportunities and fruits belong to the world. In the past decade, worldclass major projects have been completed one after another under the BRI framework.

They include the China-Laos Railway, Jakarta-Bandung High-speed Railway, the Hungarian-Serbia Railway, the Haifa Port of Israel, and the Piraeus Port of Greece.

The industrial chain and supply chain cooperation has become increasingly closer. From 2013 to 2022, the annual import and export volume of trade in goods and non-financial direct investment between China and the countries along the Belt and Road had increased by 8.6 per cent and 5.8 per cent on average, respectively, while the cumulative two-way investment had exceeded US\$270 billion.

According to a report of the World Bank, the BRI increased the trade volume and foreign investment in participating countries by 4.1 per cent and 5 per cent, respectively, and increased the GDP of low-income countries by 3.4 per cent.

Africa is an active and important BRI participant. During the past decade, the cumulative volume of China-Africa trade has exceeded US\$2 trillion, and China's imports of African agricultural products have grown at an average annual rate of 11.4 per cent.

Sixteen agricultural products from 11 African countries have gained access to the Chinese market through the "green lanes", and 21 African countries have been granted zero-tariff treatment for 98 per cent of their taxable items exported to China.

Over the past ten years, China's FDI flows to Africa have exceeded US\$30 billion in total, and Chinese companies have participated in the construction of over 6,000 kilometers of railways, 6,000-plus kilometers of roads and more than 80 large-scale power facilities in Africa.

China and Tanzania have been strengthening their Belt and Road cooperation in recent years. The Chinese

government and the three successive governments of Tanzania led by President Jakaya Mrisho Kikwete, President John Pombe Magufuli, and President Samia Suluhu Hassan, in that order, have been firmly supporting each other, increasing high-level exchanges, and promoting synergy between the BRI and Tanzania Development Vision 2025, thereby providing strong political driving force to the development of bilateral relations and the economic

In particular, during President Samia Suluhu Hassan's historic visit to China in November 2022, President Xi Jinping and President Samia Suluhu Hassan jointly announced the elevation of China-Tanzania relations to a comprehensive strategic cooperative partnership.

and trade cooperation.

They also agreed to deepen the high-quality Belt and Road cooperation between the two countries, thereby ushering in a new stage in the development of the bilateral relations and friendly cooperation.

In addition, China signed memorandums of understanding with Tanzania on strengthening investment cooperation in the field of the digital economy and deepening cooperation in the blue economy.

In the field of infrastructure building, we have created landmark projects, and achieved fruitful results in facilities connectivity.

Chinese firms have participated in such strategic infrastructural projects as the Standard Gauge Railway (SGR), Julius Nyerere Hydropower Station, the East African Crude Oil Pipeline (EACOP), and the J. P. Magufuli Bridge.

Additionally, Chinese companies have completed with high quality a series of major infrastructure projects in Tanzania.

These include the Mtwara-Dar es Salaam Natural Gas Pipeline, Upgrading and Expansion of Dar es Salaam Port, Terminal 3 of Abeid Amani Karume International Airport in Zanzibar, Tanzanite Bridge in Dar es Salaam, and the National ICT Broadband Backbone Network (NICTBB). These are making outstanding contributions to the improvement of infrastructure in Tanzania.

Currently, China, Tanzania and Zambia are exploring ways to revitalise the TAZARA (Tanzania-Zambia) Railway. It is hoped that this "Friendship Railway" will gain new vitality in the future and become a major transport corridor of the region as well as a "Development Railway"

In the field of the economy and trade, we have deepened cooperation and improved both quality and efficiency. In 2022, our bilateral trade volume reached US\$8.31 billion, up by 23.7 per cent year-onyear and by 125 percent over the past decade.

China has remained Tanzania's largest trading partner for seven consecutive years. It has granted zero-tariff treatment to 98 per cent of Tanzania's taxable items exported to China and approved Tanzania's export of avocados, wild aquatic products, and high-quality and featured agricultural products to

As a result, the volume and value of Tanzania's exports to China have continuously expanded. Meanwhile, China's investment in Tanzania has achieved remarkable results. By the end of 2022, China's investment stock in Tanzania grew to 2.5 times that of 2012, thus providing a large amount of funds for the development of such industries in Tanzania as manufacturing, mining and agriculture.

In recent years, the investment volumes of many Chinese-invested projects, such as Keda Ceramics, Maweni Limestone Ltd., and Sapphire Float Glass Factory, have all

exceeded US\$100 million, creating a large number of jobs for the locals.

In the field of people-to-people exchanges, we have promoted personnel exchanges and further consolidated the foundation for popular support and public opinion.

With the help of China, Tanzania is implementing the National Occupational Standard Development Project, which will train a large number of technical talents for its industrialisation.

Cultural exchange brands such as Luban Workshop and Confucius Institute have gradually taken shape and are effectively enhancing understanding and communication between our two countries. The "Small but Smart" development aid projects have also yielded fruitful results.

During the Covid-19 pandemic, China donated 5.61 million doses of Covid vaccines to Tanzania, effectively supporting that country's drive to fight the pandemic.

Over the past decade, China has implemented a large number of urgently needed livelihood projects for Tanzania, including the Kagera Vocational Training and Service Centre and the University of Dar es Salaam Library.

Since 2013, China has meanwhile provided a total of 3,489 degree-programme scholarships and short-term training opportunities to Tanzania.

In October this year. China will host the Third Belt and Road Forum for International Cooperation, and the delegates of partner countries will gather in Beijing to discuss development and cooperation plans. It is hoped that the convening of this forum will offer guidance and blueprints for China-Tanzania and China-Africa cooperation in the

At present, geopolitical conflicts are intensifying, the global economic recovery remains weak and the world has entered a new period of turbulence and transformation.

China is willing to take the Third Belt and Road Forum for International Cooperation as an opportunity to address challenges and seek common development together with Tanzania - and write a new chapter in China-Tanzania cooperation.

We are ready to deepen "hard connectivity" in infrastructure and enhance "soft connectivity" in rules and standards with Tanzania.

We will also increase the volume and value of imports from Tanzania, expand mutually beneficial cooperation in such areas as green development, the digital economy and the blue economy as well as raise the level of bilateral economic and trade cooperation.

I believe that, with our joint efforts, the China-Tanzania Belt and Road cooperation will carry great practical significance, progress steadily, and endure in the long run.

The ocean offers very rich solutions for climate change

FOR the people of Seychelles, the ocean is more than just a source of livelihood. It is also a way of life. About 80% of our homes and infrastructure are located along the coast and those homes and infrastructures are impacted by the ocean in various ways.

We depend on our ocean and we need to figure out how to make this relationship work. The relationship I believe should be reciprocal where we continue to understand our actions towards our ocean and eventually what our oceans can do for us.

As one of the Small Island Developing States (SIDS), we face a unique set of vulnerabilities that impede our ability to achieve sustainable de-

Structural factors, including our size, remoteness, limited resource base, market size, exposure to climate risks and natural disasters, influence socio economic outcomes and our ability to achieve the SDGs.

Coordinated international actions, including dedicated international financing mechanisms, are needed to address the vulnerabilities of

The main threats facing Seychelles and other small island developing states are credited to climate change. These include: changes in rainfall patterns leading to flooding or drought, increase in sea temperature, changes in acidity and damage to marine ecosystems, increase in storms and storm surges and sea level rise to name a few.

In order to counter these global threats, a collaborative approach is needed, particularly where mitigation and adaptation efforts are concerned. One key driver to assist in the fight against these threats is how we collaboratively manage our ocean.

The ocean must be a key piece of this collective action. It is our planet's greatest connector and offers solutions to reducing emissions, addressing vulnerability, and building resilience.

The issues that SIDS faces today require innovative solutions pushing us to rethink the way we go about our daily activities. Major climate change actions are required in terms of where and how we focus our finite resources, especially our ocean resources.

Small Island Developing States (SIDS) are suffering the consequences and the cost of human-induced climate change and yet we are the least responsible for these.

A recent report commissioned by the High Level Panel for a Sustainable Ocean Economy (Ocean Panel) found that climate solutions from the ocean can deliver up to 35% of the annual greenhouse gas (GHG) emission cuts needed in 2050 to limit global temperature rise to 1.5°C.

This is based on solutions that are ready-to-implement now, not future solutions we may achieve if the technology catches up. The world cannot fail in finding solutions to this global crisis. The major actors need to step-up and play a more significant role in the development of innovative solutions that will allow small islands state to survive.

If not addressed, economic activity within the Seychelles will be diminished, lost beneath the rising tides, along with the coral islands of the archipelago that make up our Republic.

From the people on the front line of this crisis, our message is simple: We must act now.

As SDG 14, the ocean goal, remains the least funded of all the SDGs, investments must also increase significantly. The Ocean Panel report estimates that fulfilling the ocean's potential in emissions reductions will require a global trajectory towards US\$2 trillion of targeted investment into sustainable ocean solutions between 2030 and 2050.

Reading: The lost culture we must rebuild by all means possible

 Γ is widely rumoured that we as a society have no reading culture, namely reading as a habit. Simply put, many of us read mandatorily for educational purposes meaning upon graduation, we say bye to

But according to experts, this is bad for our personal as well as national development. This is so much so in a fast-changing globalized world where things and concepts are introduced every day.

Experts say reading is good because it improves one's focus, memory, empathy and communication skills. It can reduce stress, improve mental health and hence help a person live longer. It is only through reading that one can acquire new skills that improve work and relationship with others.

A reading culture is an environment where reading is championed, valued, respected, and encouraged. When there is no reading culture, the people and society remain static instead of dynamic, conservative instead of liberal, archaic instead of modern and hence underdeveloped.

Education minister Prof Adolf Mkenda was recently quoted expressing his disappointment with the declining reading culture in the country. Speaking in an interview with reporters, the economics guru said there was a need to prioritize books over buildings when it comes to libraries.

The minister's remarks came at a time when reports from academic corridors show that pupils and students spend a lot of time on social media via their smartphones and other electronic gadgets instead of reading books available either in soft or hard copies.

According to the latest study, in Sub-Saharan Africa, the old habit that used to involve turning the page over with a flick of the finger, not the click of the mouse is slowly dying a natural death.

Reading has faded alongside moral values because much of the morals are found in books. The bad news is that the habit does not develop suddenly; it increases gradually depending on exposure and background. This exposure can be through, for instance, people reading for leisure, knowledge, information or interest. In order to develop a reading culture in a society, people require knowledge to utilize existing information materials and resources.

Attitudes towards information use are vital to improving the reading culture in Tanzania. Reading culture determines the success of a person and the nation as a whole, signaling the need to explore opportunities for developing a reading culture among students.

Reading culture in Tanzania is affected by the education system which hardly outlines policies and strategies that support reading among students as an important aspect of education curriculum, thanks to the newly proposed competence-based curriculum.

Reading has been associated with passing examinations and seen as a way of accomplishing academic success. This view does not inspire students to read during their free time since they associate reading with school.

Generally, people see reading as an activity they are forced to do in a school environment, meaning after school, one regains the lost freedom and books become a reminder of the painful past.

In my opinion, our exams-oriented education system is one of the obstacles to creating a reading culture. Being a professional teacher, having sat before academicians for most of my life starting from pre-school through primary, secondary and tertiary education, I have gathered enough knowledge to arouse a debate

among teaching professionals. I strongly believe that for most of those who attended primary and secondary education before the advent and widespread of television, pupils and students moved around with story books in their bags or had them at home. People used to exchange books and there were many reading clubs.

It was common to hear people speak about the books they had read and those they were looking forward to reading in the near future. There were many book lov-



ers and book shelves were a must somewhere in the house.

As a result of this spontaneous reading competition, it was a challenge to writers who worked hard to meet the demands of their readers. Thus, you had publications like those of the African Writers Series where you got works of great writers like Chinua Achebe, Ngugi wa Thiong'o, Okot p'Bitek and Wole Soyinka to mention but

From my point of view, the fiction books by these writers served some major functions that I see missing in the current society. The main missing contribution is the promotion of writing creative stories that are not only entertaining but also educat-

Through reading the story books either in Kiswahili or English, some readers discovered and developed their talents for writing creative stories too. This is largely in the bygone era reading as a habit.

Together with the writing talent building, reading story books served as a way of developing creative thinking in a person. Most of the stories acted as a medium for imparting cultural knowledge to a new generation. That is also gone.

Besides the above-mentioned benefits of reading story books, there is also the aspect of language improvement. Fiction writers usually apply formal language when explaining events and only in rare

cases they use colloquial language, especially in conversational instances.

In this way, language was improved whereby many readers applied the new vocabularies or expressions they had read from the various books to everyday usage. As a result of that, even someone who had not read that word or was oblivious of it became aware of it.

Sadly, the situation is totally different in this world of electronic moving-picture stories. The culture of reading books, let alone school books, has greatly been cur-

Our pupils and even university students read only for the sake of exams. This has become a big problem because all knowledge has to come from the teacher. The atom bomb to the love of reading is the stories narrated through movies. A story that would take one a week to finish, takes only one and a half hours.

So, a person basically sees no reason to spend days scrutinizing a 120-page book when it could only take him or her two hours at most to digest the whole story. It is a good way of time use and get the required entertainment but it greatly affects true knowledge acquisition.

This poses a challenge to education experts who are endowed with the appropriate knowledge to devise better ways of enticing learners to develop love of reading not only for the sake of exams but also for discovering new ideas for their own as

well as for the society's benefits. Since literature courses at higher level of secondary education have proved unattractive to students, another method should be emploved.

I am of the opinion that literature lessons should begin at an earlier level in one's education journey. Preferably, this can begin from standard five where pupils should be given a good number of story books to go through for each year until standard seven. This should continue up to secondary level.

I believe in so doing, by the time they finish standard seven, pupils will have developed the habit of reading for the sake of knowledge acquisition and not only embracing curricula-stipulated books where they only search for where possible questions would come from and read only those pages.

There is a need to have an environment that supports reading culture or road map to counter the effects of education system on the reading culture amongst pupils and students.

The reading enabling environment should include provision of supplementary readers involving stakeholders who support reading programmes and allocating a lot of time to class timetables for reading lessons. Eventually, this will lead to improved literacy, lifelong learning, language development and high performance in class amongst students.

Promotion of a reading culture in Tanzania and other African countries must therefore go hand in hand with the promotion of reading as a pleasurable activity which means that pupils and students must start to read for fun and not just because they have to prepare for examinations.

Additionally, experience shows that a child who views reading as entertainment, instead of an activity through which certain skills are taught, would have a more rapid development in relation to literacy.

To support the idea, Prof Mkenda advocates for a shift in priorities. He said the key role of the Tanzania Library Service Board (TLSB) should be to ensure libraries are well stocked with enough and relevant books to enable Tanzanians access knowledge. Instead of allocating funds for the construction of new library buildings, the focus should be on acquiring and distributing books to libraries across the country. I agree with him.

More Ghanaians benefit from free cataract surgery by Chinese doctors

ACCRA, Ghana

IT is an early September morning in the Ghanaian capital of Accra, where many people are engaged in their daily chores to earn a living.

In the theater of the city's LEKMA hospital, commonly known as the China-Ghana Friendship Hospital, two Chinese ophthalmologists are attending to patients.

In a single morning, the pair has already performed free cataract surgeries on three patients to restore their vision, which had been impaired by the eye disease.

Lei Peng, the eye specialist from the Guangdong Second Provincial General Hospital, has teamed up with her colleague Tang Xiaodi, a member of the 12th Chinese medical team in Ghana, to perform free phacoemulsification cataract surgeries for locals since Sept. 11.

The two-week outreach programme is part of a free cataract surgery project named "Seeing The Beautiful World," initiated by the previous Chinese medical team in November of last year, with support from various Chinese businesses. The pair said that Saturday, they had completed 71 surgeries, bringing the figure closer to the project's target of 100 cases.

Lei was a member of the Chinese medical team that worked in Ghana in 2016, and out of his love for the West African country, he decided to return to support the current team in performing more free cataract surgeries.

"Cataract surgery gives people light. If they are completely blind, they become a burden to their family. But if they can outcome," said Senam Aidam, head of the ophthalmology unit

makes a huge difference," he said.

Since 2009, China has dispatched 12 medical teams to Ghana, comprising over 100 medical professionals who have provided vital assistance to the West African country.


Georgina Addy, 79, was one of the Ghanaian beneficiaries of the free surgery to reverse the cataract she had developed five years ago. Addy said that after undergoing her procedure that she had sought help at other hospitals for her eye problem, but the high cost had prevented her from having the surgery.

"My eye has been painful, and a neighbor recommended the LEKMA Hospital to me. I visited here in August and reported with my laboratory reports yesterday. Today, they brought us to the theater, and they performed the surgery for me, and I am okay now," she said.

The pensioner expressed her gratitude to the Chinese doctors who attended to her medical needs promptly. "I am relieved from my financial burden. They are helping Ghanaians, so we thank them sincerely."

Cataract is a reversible cause of visual impairment and a common disease among Ghanaians. The high cost of the surgery, however, prevents many low-income locals from accessing the treatment to restore their vision. The free surgeries performed by the Chinese medical team, therefore, provide great relief to the beneficiaries and their families.

"Doctor Lei worked with us in 2016 and then returned to China but decided to come back to help us perform more surgeries. The results are good, and our clients are satisfied with the now see, they can work and bring income to the family. That at LEKMA Hospital. "They are all very happy," Aidam added.

Sino-African palace of culture and art, a bridge between two cultures

ACROSS the People's Palace and the Martyrs Stadium, two landmarks in the Democratic Republic of the Congo (DRC), sits another China-aided project -- Central African Cultural and Arts Center that is taking shape, which, according to Alexis Gisaro Muvuni, Minister of State for infrastructure and Public Works of the country, is "another flagship project for the cooperation between the two countries.

"My father once worked and lived in Africa, so I have felt some kind of connection with the continent. When I heard this project in Africa, I really wanted to be part of it." said Chinese architect Tang Wensheng, chief designer of the project in Kinshasa, the Congolese capital.

Tang works for Central-South Architectural Design Institute Co., Ltd., which undertakes the design work of the China-aided centre.

Most striking in Tang's office is a series of design blueprints and panoramic renderings showcasing the ingenious architectural concepts of central buildings such as theaters and school facilities.

The main structure of this building consists of a cultural center and National Institute of the Arts, which includes a large theater with a seating capacity of 2,000, a smaller theater with 800 seats, and a campus for the National Academy of Arts that can accommodate 2,000 students.

The exterior design of the core building, the cultural center resembles the shape of a round African drum, which comes from Tang's own experience.

Tang learned about African drums from his father, who assisted with the construction of farms in Somalia in the 1980s as a member of the Chinese engineers' team.

"In Chinese culture, the circle represents reunion. As the project is an embodiment of China-Africa friendship, I think the shape of a circle is most fitted to this project," he said.

The design of the National Institute of the Arts also exudes a harmonious blend of Chinese and African elements. The Chinese design team found that incorporating traditional Chinese designs can make the spatial layout of the school buildings better suited to the local climate and environment.

The traditional Chinese sheltered walkaways provide both rain shelter and sun protection, together with the modified narrow courtyard, which was originally supposed to be broad, rightly suitable for the local hot and rainy climate with strong sunlight.

On the facade of the buildings, the local river sand from the Congo River was used as part of the wall paint. For interior decoration, local craft of copperplate etching, based on rich cooper resources, is widely applied, reflecting the local artistic style.

As a key project of "eight major initiatives" put forward at the Beijing summit of the Forum on China-Africa Cooperation held in 2018, the Central African Culture and Art Center project has long been highly prized by the Congo side, with President Felix Tshisekedi personally laying its foundation stone in 2019.

After that, the president paid several visits to the project and the construction personnel. In 2021, Tshisekedi said during a visit that he believed that the project, when completed, would play an important role in cultural exchanges between Africa and

In May, during Tshisekedi's state visit to China, the two countries announced the decision to upgrade bilateral ties to a comprehensive strategic cooperative partnership with the DRC side highly appreciat-

ing China's support for the project of Central Afri-

can Cultural and Arts Center. "We are looking forward to moving to the beautiful building," said Mwendanga Musengo Desire-Salomon, General director of National Institute of the Arts, adding that he is deeply impressed by the architectural design of the center that combines

cultural richness and practicality. Once the center is completed, the faculty and students of the academy will move there to work and

Culture and art possess a profound power that can bridge the hearts and minds between peoples, Mwendanga said, adding that the project will play a significant role in nurturing more artistic talents and promoting international cultural exchanges in the future.

He voiced hope that artists from Africa and China will have the opportunity to perform together and engage in artistic exchange in the building.

UN meets on effective responses to loss and damage ahead of COP28

FRICAN countries are increasingly in the eye of deadly climate-induced disasters. Recent devastating extreme events include intense shattering earthquakes in Morocco, followed shortly by catastrophic floods in Libya this September that left 11,300 people dead, according to Libya's Red Crescent.

A quarter of Libya's Port City of Derna - the epicentre of this tragedy was wiped off the map. Planet warming pollution made the tragedy in Libya 50 times more likely to occur and 50 percent worse.

"As global warming intensifies, the outlook worsens, losses and damages increase and become increasingly difficult to avoid, the projections are dire - regional disparities and food security are poised to affect tens to hundreds of millions of people in low- and middle-income countries, flood risk is anticipated to result in an additional 48,000 deaths of children by 2030," said Dr Adelle Thomas, lead author on the Sixth Assessment Report of the United Nations Intergovernmental Panel on Climate Change (IPCC) - the sixth in a series of reports which assess scientific, technical, and socio-economic information concerning climate change.

"For small islands and coastal communities, both slow onset and extreme events threaten to render these places uninhabitable. In this context, we find that current financial and institutional structures are failing to comprehensively address losses and damages, particularly in vulnerable developing nations. More than 50 percent of the debt increase in vulnerable nations is linked to funding disaster recoveries and reconstruction. It is an unjust and unsustainable predicament with those least responsible for climate change are shouldering the burdens and costs of loss and damage.

Speaking during a special UN meeting on loss and damage on September 20, 2023, Amina J Mohammed, the Vice Secretary-General of the United Nations, said that this is an issue that the Secretary General of the United Nations "always got fire under our feet for and to make sure we deliver as we go to COP28. The imperative to act urgently and collectively, we all know, cannot be overstated, and this special meeting is taking place on the margins of the secretary general's Climate Ambition

Stressing that the global community must come together, redouble its efforts in rapidly reducing greenhouse gas emissions in line with the Paris Agreement and significantly enhancing adaptation resilience in the face of these inevitable changes. It is also equally imperative that the global community address the irreversible impacts that have already

"Many nations, particularly those which are least responsible for the current climate crisis, find themselves at the frontline of its effects. To address the climate injustice, a historic decision was taken at COP27 to establish new funding arrangements, including a fund for loss and damage. It is possible to have a world that is secure, where no one is left behind. Keeping the promise of the 2030 agenda and also of the Paris Agreement," Mohammed emphasised.

The special meeting on loss and damage supported efforts by the Transitional Committee in line with the mandate that was given to them by the parties of the Paris Agreement. Emphasizing that urgent action was needed as the least polluting countries were in the frontline of a FCCC) emphasised that climate inaction



deadly climate crisis.

"More than 110 million Africans are being directly affected by climate and water-related hazards in 2022, and that caused more than 8.5 billion dollars in economic damages. Our global projected economic cost of loss and damage are to be in the range of hundreds of billions by 2030," Mohammed expounded.

At the same time, unsustainable debt burdens, spiralling inflation and currency fluctuations are adding to the difficulties and hardships that the most vulnerable countries face. Initiatives such as the SDGs Stimulus to Deliver Agenda 2030 are now in place to keep the 2030 promise by offsetting challenging market conditions faced by developing countries and accelerating progress towards the SDGs.

Genaro Matías Godoy González, a youth representative from YOUNGO the official children and youth constituency of the United Nations Framework Convention on Climate Change (UN-

should pay a price and that "the call for loss and damage finance is inherently a call for both climate action and climate justice. It means the hope of reparations for the billions of people whose livelihoods are lost and the responsibility of decision-makers to fix the pathway of a monetary and financial system that helps our world to expand its growth but fails to account for planetary boundaries on how we should direct growth."

González spoke of the need for transformative change - recognising the climate and ecological debt to the people and ecosystem. To rebuild and regenerate the lost livelihoods - international financial institutions have a moral imperative to be part of the transition and transformation of our global financial

"Central banks must include the risk of financial inaction in the risk assessments of its monetary policy, report accordingly, and the right incentives put in place. Climate financing for addressing loss and damage must not come at the expense of other forms of climate financing to support comprehensive climate action. It must be new and additional and aligned with SDGs, conservation of nature and climate resilience development. They should not create more debt burden for developing countries that are already trying to survive the climate crisis while being strangled by debt and being forced to extract nature," he said.

To underpin the need for effective financial models for loss and damages, Thomas delivered a dire warning from the heart of the Sixth IPCC assessment report - "Human-induced climate change has inflicted widespread and severe losses and damages - disproportionately affecting developing countries and the most vulnerable among us. The numbers paint an alarming picture about 3.3 billion people reside in highly vulnerable countries, exposing them to the most severe climate impacts. Human mortality from extreme events was 15 times higher in highly vulnerable re-

"Millions of people are grappling with acute food insecurity, concentrated in Africa, Asia, Central and South America, least developed countries and small islands. Severe droughts have resulted in nearly six million children in the developing world becoming underweight. Extreme events are resulting in billions of dollars in damages - at times, exceeding the GDP of developing countries," Thomas added.

Losses and damages have wrecked greater economic havoc and impoverished regions and among more vulnerable populations, including the poor, women, children and indigenous peoples. The scientific evidence is undeniable - urgent, comprehensive and transformative action is imperative to respond to the escalating levels of loss and damage.

While water flow resumed in several areas late on Friday (September 22) numerous homes on higher ground were still dry last night (September 23).

In a statement, the city said law enforcement agencies were being engaged and that "the elements of sabotage are suspected after technical teams discovered an air valve in a water pipeline that was tampered with and another valve was vandalised".

DSE's Q3 turnover surpasses Q2, ahead of quarter ending

With only one week ahead of the end of the third quarter, the Dar es Salaam Stock Exchange (DSE) total turnover has reached 29.4bn/-, which is slightly higher than 28.6bn/- recorded during the second quarter.

The market report shows that during the third quarter, local investors are dominating both selling and buying activities, with 97.26 percent and 52.47 percent of total values respectively.

However, total turnover for the third quarter of this year is still lower than 40.1bn/- recorded during similar quarter of last year.

The market report shows, foreign investors have so far recorded a net outflows amounting to 13bn/-, after selling shares valued 13.8bn/- against buying value of 805mn/-.

During the second quarter of this year, foreign investors bought shares valued 16.9bn/-, which was equivalent to 59.20 percent of total buying value and they sold shares valued 17.2bn/- or 60.32 percent of total value of shares sold, which translated into 300mn/- net outflows.

The largest transactions during the ending quarter were conducted on Wednesday, 20th September, after recording a turnover of 7.1bn/-, which was nearly 25 percent of the current quarterly total market turnover.

During the day, the market report shows, on block trade pre-arrangement board, Tanzania Breweries Limited (TBL) counter transacted a block of one million shares valued 6.5bn/- traded in two deals, at a discounted price.

In the same day, Tanzania Cigarette Company (TCC) counter also transacted a block trade of 30,770 shares, while Vodacom Tanzania counter traded a block trade of 670,000 shares.

The market report shows, foreign investors sold shares valued 313mn/during the day, which was equivalent to 4.36 percent of total value of shares sold and all shares were bought by local investors by 100 percent.

Market analysts are expecting continued sellout by foreign investors due to foreign exchange (shortages of US dollar), increased interest rates in developed world's financial markets and prevailing global economic conditions.

hinese lenders will provide more than half of the US\$3 billion debt that Uganda requires to build a crude oil pipeline after financiers from the West backed out following strong opposition from environmental groups.

According to Uganda's Ministry of Energy and Mineral Development, the East African nation expects to finalise talks with the China Export & Credit Insurance Corporation (Sinosure) and the Export-Import Bank of China (Eximbank) by next month to finance the construction of the East African Crude Oil Pipeline (EACOP).

Irene Bateebe, the ministry's permanent secretary, said Sinosure, the Chinese state-owned provider of export credit insurance, is working with Eximbank to provide funding for the pipeline, which "is the largest portion - above 50 per cent of the debt".

"We are at the tail-end of the discussions [with Chinese lenders] for financial close. We are confident that by the end of October of this year, we will close the debt component and we would have mobilised most of the funding for the project," Bateebe said on Friday.

Uganda needs about US\$5 billion for the pipeline running from Lake Albert's oilfields to a storage and loading terminal in the Tanzanian port of Tanga.

Financing is set at a 60:40 debt-to-equity ratio, meaning US\$3 billion will be secured as debt with the remaining US\$2 billion to be financed by shareholders through equity contributions.

TotalEnergies controls a 62 per cent interest in the pipeline; the Uganda National Oil Company holds 15 per cent; Tanzania Petroleum Development Corporation has 15 per cent; leaving 8 per cent for Chinese oil giant China National Offshore Oil Corporation (CNOOC).

The 1,443km (896-mile)

pipeline would transport crude oil from Uganda's Lake Albert oilfields in northwest Uganda to Tanga in Tanzania on the Indian Ocean where the oil would then be sold onwards to world markets.

Besides the Chinese lenders, Bateebe said Uganda expects to get some funding from Saudi Arabia's Islamic Development Bank and some African banks, including the African Export-Import Bank.

Bateebe said initially many Western-backed lenders had expressed interest in financing the pipeline but pulled out due to strong opposition from environmental and human rights groups who have said the oilfields and pipeline threaten the region's fragile

ecosystem and the livelihoods of thousands of people. Further, environmentalists say Uganda is going against the global push for energy transition away from fossil fuels.

"We did see some Western banks withdrawing from supporting the project but we always say look at your other friend. We had other friends who were willing to come on board. We became Eastlooking," Bateebe said. She added that, previously, a large portion of the debt was to come from Western lenders.

In 2006, British company Tullow Oil discovered commercially viable oil deposits on the shores of Lake Albert in western Uganda at the border with the Democratic Republic of the Congo. Uganda has an estimated 6.5 billion barrels of crude oil - the equivalent of 1.4 billion barrels of recoverable oil.

But it was only last year that the partners announced a US\$10 billion final investment decision for the project, which includes the oilfield development and the construction of the pipeline to carry crude oil harvested from Hoima in western Uganda.

CNOOC operates the Kingfisher oilfield, located on the eastern shores of Lake Albert in Uganda. It will invest an estimated US\$2-3 billion to develop the oilfield that would produce 40,000 barrels per day at peak production.

The other, larger oilfield is the Tilenga, operated by French oil multinational TotalEnergies, which is estimated to cost between US\$4 billion and US\$6 billion to develop. It will produce 190,000 barrels per day.

In support of Uganda's projects, the Chinese embassy in Uganda last year criticised the European Union for trying to interfere with the development of Uganda's oil ambitions. Chinese ambassador to Uganda Zhang Lizhong said the EU "should not use the excuse of environmental and human rights issues to block development" of the oilfields and the pipeline.

Singapore emerges as largest property investor in Japan

Singapore became the biggest investor in Japan's real estate sector this year, lured by the yen's weakness and growing demand in logistics and hospitality industries, according to Knight Frank LLP.

Inflows from the city-state totaled almost \$3 billion so far in 2023, followed by investors from the US, Canada, and the United Arab Emirates, according to a report published this month.

Singapore's sovereign wealth fund GIC Pte's purchase of six warehouses in Japan from Blackstone Inc. for \$800 million contributed significantly to that, said Christine Li, Knight Frank's head of Asia-Pacific research, in the report.

GIC Chief Investment Officer

Jeffrey Jaensubhakij recently described Japan as a "very cheap" market where value can be realized, and with a long way to run. International investors are also attracted to its low borrowing costs, and putting more money into hotels because of a post-pandemic tourism boom.

Foreign investors, including Goldman Sachs Group Inc., KKR & Co., Blackstone Inc., have spent a combined \$2 billion on hotel deals in Japan so far in 2023, the most compared with any other sector in Asian commercial property, according to MSCI Real Assets

Japan's surge in hybrid work arrangements and rising supply has eroded investors' appetite for the office sector, Knight Frank said in the report.

Digital assets markets shaken by hawkish **Federal** outlook

Digital assets tentatively sold off this week in response to the Federal Reserve indicating another rate hike may come this year, despite deciding to keep interest rates steady on Wednesday.

Projections released by the central bank show median rates of 5.6 percent before year's end, up from the current range of 5.25 percent to 5.5 percent. The suggested hike garnered support from 12 Federal Reserve officials and opposition

"We want to see convincing evidence really that we have reached the appropriate level, and we're seeing progress, and we welcome that," Fed chair Jerome Powell told reporters at a press conference following the decision. "But, you know, we need to see more progress before we'll be willing to reach that conclu-

According to CoinMarketCap, \$30B was wiped from the combined capitalization of crypto assets, which now sits at \$1.05T following the 3 percent retracement. BTC has since dropped 2.5 percent, and ETH is down 3 percent after both assets regained 1 percent in the past

September's close will also coincide with the expiry of \$3B worth of quarterly BTC options and \$1.8B in contracts tracking Ether.

Luuk Strijers, the chief commercial officer at crypto options exchange Deribit, told The Defiant that quarterly contracts are typically "the most significant in terms of volume and value," estimating institutions represent 85 percent of activ-

The low activity has been attributed to the prolonged downturn in the NFT market and the buzz surrounding memecoins dying down.

However, the retracement in on-chain also coincides with Layer 2 transaction throughput setting new highs multiple times in recent weeks. Ethereum's L2 ecosystem processed an average of 64.2 transactions per second (TPS) on Sept. 14, compared to 12.4 TPS on the Ethereum mainnet.

Core inflation rate gauges are falling in US, Europe zone

Policymakers on each side of the Atlantic are likely to take comfort this week from a slowdown taking hold in key underlying measures of consumer-price growth.

In the US, the annual core metric that strips out food and energy from the Federal Reserve's preferred inflation measure may have fallen below 4 percent in August for the first time in nearly two years.

Meanwhile the euro region's own annual gauge of underlying price growth is expected to have slowed to 4.8 percent in September – a 12-month low.

Such coinciding evidence would reassure officials from the Fed and the European Central Bank after a week when each signaled monetary tightening may be done or at least paused for now, shifting focus to keeping interest rates durably high to fully squash inflation.

They do have reason for caution however, with the prospect that crude oil heading toward \$100 barrel could yet fuel further price growth.

Some recent increases in energy costs are already having an effect. The overall personal consumption expenditures price index that the Fed favors is expected to pick up on a monthly basis to one of the strongest readings this year when that report is released on Friday.

Headline euro zone inflation, which will be released the same day, is still likely to have weakened drastically however – reaching 4.5 percent, a two-year low.

"The Fed's optimism isn't likely to be dented by data in the coming week. Even as income and spending rose at a decent clip, August PCE inflation likely continued at a pace close to the Fed's 2 percent target for a third straight month. That said, we do expect to see further signs of labor-market weakening in the consumer confidence report," said Anna Wong, Stuart Paul and Eliza Winger, economists.

Elsewhere, appearances by the Fed and ECB chiefs, along with rate decisions from Hungary to Mexico, will keep investors busy.

US and Canada

In the US, the PCE report may be the last government figures that policymakers see for some time ahead of a likely shutdown that would start Oct. 1. When the government was closed in 2013, figures like the employment report and others were delayed. Other data this week include those on new-home sales,



Ford offers Unifor wage increases up to 25pc

■ord Motor has offered Canadian union Unifor wage increases of up to 25 percent in its tentative agreement, the union said on

The agreement provides a 10 percent wage increase for the first year followed by increases of 2 percent and 3 percent through the second and third year and a \$10,000 productivity and quality bonus to all employees on the active roll of the company, Unifor said.

The proposals also include an increase in the monthly basic benefit and special allowance in all class codes across defined benefit and hybrid pension plans and investments to help transition from traditional internal combustion engine (ICE) vehicle production to electric vehicle (EV) assembly facilities.

Unifor, which represents about 5,600 Canadian auto workers, on Friday said that its Ford leadership group has voted unanimously to support the tentative agreement.

Ford is also in the midst of contract negotiations in the US with a strike by the United Auto Workers (UAW) union at its at the automaker's Wayne, Michigan assembly plant.

The UAW began strikes on Friday against 38 parts distribution centers across the United States at GM and Stellantis, extending its unprecedented, simultaneous strikes that began with one assembly plant each of the Detroit Three. The addi-



tional facilities added about 5,600 workers to the 12,700 already on strike.

The UAW said on Friday that Ford had improved its contract offer, including boosting profit sharing and agreeing to let workers strike over plant closures but said the union still has "serious issues" with Ford and its workers would remain on strike at the automaker's

Wayne, Michigan assembly plant. Unlike UAW, Unifor chose one of the Detroit Three as a "target" to negotiate with first - in this case,

Ford - in a pattern bargaining tactic

used to set the tone for subsequent deals with other companies. UAW President Shawn Fain said in a Facebook live event that by targeting distribution centers the

strike becomes a nationwide event.

He said he expected talks to continue through the weekend.

London-listed miner says Mali Lithium project not hit by law

London-listed Kodal Minerals said its lithium project in Mali won't be impacted by new legislation that entitles the state to a greater share of the West African nation's mining assets.

On August 29, Mali's military head of state Assimi Goita signed the law, which doubles the stake the authorities can acquire to 20% and sets aside an additional 5% of shares for "national investors." The authorities had already said the updated law won't apply to the established gold operations that have long dominated the country's mining industry - such as Barrick Gold Corp.'s Loulo-Gounkoto and B2Gold's Fekola assets.

Mali's National Directo-

rate of Geology and Mines has confirmed that Kodal's license to mine the Bougouni lithium project will be "administered in accordance" with the terms of the previous law, the firm said in a statement Friday.

The boom in lithium, a key battery metal, has kickstarted a race for deposits. Mining heavyweights, battery manufacturers and automakers from Rio Tinto Plc to Tesla Inc. are chasing deals as they look to secure future supplies.

Kodal is vying with Australia's Leo Lithium Ltd. to bring Mali's first lithium mine to production. Kodal was awarded its license in late 2021, while Leo Lithium was given the right to develop the Goulamina asset in August 2019.



China stimulates Ghana's gas sector

China has made significant contributions to Ghana's utilization of natural gas resources, which has acted as a catalyst for improved economic development, a Ghanaian energy official has said.

Victor Sunu-Attah, general manager of the state-owned Ghana National Petroleum Corporation (GNPC), made the remarks during the 2023 Ghana Oil and Gas Conference in Accra, the capital of Ghana, Tuesday.

In an interview with Xinhua, Sunu-Attah commended China for its financial support and technical expertise in helping establish Ghana's first gas processing plant, Ghana Gas, located in the Western Region. This facility, along with associated gas pipelines, transports natural gas to thermal plants in various parts of the country.

"Gas utilization is one of the success stories of Ghana's oil and gas sector. When we were building Ghana Gas, we had a facility from China, and they helped us build the gas infrastructure," he said.

The official highlighted the China Petroleum and Chemical Corporation (Sinopec) as a leading partner in building this worldclass gas processing facility, saying the Chinese firm not only helped construct the plant but also trained local Ghanaians in managing it, ensuring that Ghana could harness natural gas to power its economic activities

Sunu-Attah also noted that the Chinese firm played a pivotal role in developing the local human resource base necessary for the ongoing and future management of

such a facility.

"When Sinopec completed the construction and operation of the facility after several years, they transferred knowledge to our Ghanaian operators, technicians, engineers, as well as individuals in the legal and finance sectors. Today, when you visit Ghana Gas, you will find that the workforce is predominantly Ghanaian, and Ghana has benefitted immensely,' the official added.

He emphasized that initial collaborations with countries possessing expertise, including China, have enabled Ghana to acquire knowledge and use it as leverage to build local capacity.

Sunu-Attah described the development of gas resources as a game changer for the country in various aspects, especially its contribution to the stability of power generation.

One of the challenges the country faced was the cost of fuels to power electricity plants, he said, adding that these plants used to rely on light crude oil or diesel, which was expensive, and as soon as gas became available, the country could build the gas processing plant and pipelines.

Although the gas sector is relatively new in Ghana, the country has efficiently harnessed its resources, making it one of the success stories of the oil and gas industry and a significant driver of economic development.

"Ghana may not have abundant gas resources like Nigeria or Equatorial Guinea, but we are making excellent use of the resources we do have to support economic activities," Sunu-Attah concluded.

"The Americans and the Europeans, who are used to looking down their noses at the rest of the world, are eager to make promises and undertake commitments, including written and legally binding ones, but are reluctant to fulfill them," Lavrov (pictured) said.



"As Russian President Vladimir Putin has said, the West is truly an 'empire of lies," the top Russian diplomat continued.

Lavrov went on to say that many

of those who spoke from the UN rostrum before him expressed the idea that "the planet is going through irreversible changes."

"A new world order is being born right before our very eyes," he added. "The future is taking shape in the process of a standoff between the global majority, which demands fairer distribution of global riches and advocates diversity within our civilization, and between the few who employ neocolonial methods of subjugation in an attempt to save their fleeting domi-

World leaders call for faster progress for achieving SDGs

UNITED NATIONS

WORLD leaders attending the 78th session of the UN General Assembly's general debate have emphasized the need for intensified efforts toward achieving the Sustainable Development Goals (SDGs), with midpoint assessments falling short.

The UN Secretary-General's 2023 SDGs Report: Special Edition shows that about 12 percent of targets are on track; more than half, though showing progress, are moderately or severely off track. Some 30 percent have seen no movement or re-

gressed below the 2015 baseline. On Friday, Bangladeshi Prime Minister Sheikh Hasina stated that the prolonged impacts of the pandemic and the consequences of the climate crisis have significantly hindered the attainment of SDGs in developing

Looking ahead to next year's Summit of the Future to reset the global push to attain the SDGs, she said: "We must make all efforts to collectively address the common challenges of humanity to secure a peaceful, prosperous, and sustainable future

"Are we going to be too late for the SDGs?" Prime Minister of Barbados Mia Mottley questioned on Friday, urging leaders to "summon the determination to make the fundamental governance changes."

Highlighting the SDGs as "the conferral of dignity on our people," she expressed concerns about achieving the goals given the challenges like the climate crisis and rising global

South Korea opposition leader ends 24-day hunger strike

SEOUL

SOUTH Korea's opposition leader ended a 24-day hunger strike on Saturday, a party spokesperson said, two days after parliament voted to let prosecutors serve an arrest warrant against him for alleged bribery.

Lee Jae-myung, (pictured) leader of the Democratic Party of Korea, will maintain a schedule including court attendance while hospitalized for the time being, the spokesman told reporters.

Prosecutors this month sought the warrant in an investigation into bribery allegations concerning a development project.

Prosecutors accuse Lee of asking a company to illegally transfer \$8 million to North Korea when he was the governor of Gyeonggi Province.

He is also accused of breaching his duty over losses of 20 billion won (\$15 million) by a municipal development corporation when he

was mayor of Seongnam city. Lee, who lost South Korea's presidential election to conservative Yoon Suk-yeol last year, has denied wrongdoing, calling the allegations "fiction" and a "political conspira-

He began his protest on Aug 31, citing the government's economic mismanagement, threats to media freedom and the failure to oppose Japan's release of wastewater from the wrecked Fukushima nuclear

plant, among other reasons. Thursday's surprise vote by parliament, controlled by Lee's party, has caused an uproar among his supporters.

Police on Saturday detained a man in his 40s who had posted the names of more than a dozen lawmakers outside Lee's party faction, writing "gotta search for the sniper rifle at home", said an official with the Gyeonggi Nambu Provincial Police. Police will seek an arrest warrant against him for intimidation, the official said.

Canada needs 'foreign policy reset" amid worsening ties with major powers -report

OTTAWA

AMID worsening bilateral ties with New Delhi in the wake of Prime Minister Justin Trudeau's allegation of Indian involvement in the killing of Sikh separatist leader Hardeep Singh Nijjar, it is perhaps time for Canada to implement a 'foreign policy reset', shedding off its 'middle-power approach' and focussing more on 'Indo-Pacific diplomacy', Japan Times reported.

Prime Minister Trudeau's allegation of an Indian role in the assassination of Khalistani leader Nijjar on Canadian soil, triggered a broader deterioration in relations between Ottawa and New Delhi, the report noted.

Notably, a similar episode also led to a deteriorating trend in China-Canada relations, the report stated, adding that Michael Spavor, a businessman, and Michael Kovrig, a former diplomat, were arrested by Beijing on espionage charges. The two were arrested following the detainment of Huawei executive Meng Wangzhou in December 2018 at the request of the United States, Japan Times reported.

This was followed by serious accusations of Chinese electoral interference and threats against Canadian lawmaker Michael Chong, the report stated, adding that this translated into record-low favorability ratings of China in Canada and an atmosphere in



which discussing anything about engagement between the two nations is "radioactive".

Canada's relations with Russia are also no better as Ottawa continues to provide deep support for Ukraine in the ongoing conflict, the Japan Times reported.

Ottawa has manoeuvred itself inadvertently into the position where it has alienated the first and second most populated nations on the planet and Russia, a declining but disruptive power determined, to weaken the international rules-based order that Canada relies on for its peace and prosperity, the report stated.

Another major concern for Canada is the possible return of Donald Trump and his 'America First' policies in the US in 2024, the Japan Times reported, adding that if Trump wins the presidency. Canada could be faced with a situation in which its most important economic, security and political partner may not be aligned with its goals, the second largest economy on the planet could become alienated and a country that is critical for Canada's Indo-Pacific strategic engagement may become estranged if relations between the two countries deteriorate.

Further, according to the Japan Times report, Canada needs a "realistic, pragmatic, and interest-based approach" to how it's engaging in the Indo-Pacific and more broadly on the global stage. Ottawa can no longer pursue a foreign policy based on an outdated idea of a middle-power identity that is based on values-oriented diplomacy. This is a practice that evangelizes ideas and values that continue to be important for Canada's domestic audience but not so much for those in the Indo-Pacific region, it added. Canada also needs to

strengthen partnerships with reliable allies and friends such as Japan, South Korea, Australia, and Singapore, in order to avoid mistakes of the past and to be an effective and dependable partner in the broader Indo-Pacific region, the report noted.

Horn of Africa nations urge action on climate change

DURING the 78th session of the UN General Assembly's general debate on Saturday, nations from the Horn of Africa passionately called for action to combat the imminent climate threat and to overhaul the currently outdated and unjust global financial framework.

Leaders from Somalia, Ethiopia, Djibouti and Eritrea depicted a bleak scenario of a world severely affected by climate change. Their message was unequivocal: This pressing crisis requires a swift and united effort.

Hamza Abdi Barre, prime minister of Somalia, highlighted the "power of solidarity and cooperation" in an interconnected world and urged leaders to accelerate action to achieve the Sustainable Development Goals

For his part, Ethiopian Deputy Prime Minister Demeke Mekonnen Hassen asked world leaders: "Do we have the necessary political will to choose global partnership over geopolitical competition (and) are we prepared to work together towards a promising age of shared prosperity?"

Hassen pointed out the unsettling reality that current policy decisions are heightening tensions, with poverty and hunger rising and the SDGs being undermined.

He showcased Ethiopia's efforts for sustainable development and climate action, noting that its 10-year development plan aligned with the SDGs and the national Green Legacy Initiative to ensure development through rural and urban green programs.

Regarding global security, the leader from Ethiopia underscored the importance of a system that honors the sovereignty of UN member states and prevents conflicts.


"Reforming the Security Council is not a choice but an absolute necessity," he stressed, calling for permanent seats for Africa.

Mahamoud Ali Youssouf, Djibouti's foreign affairs minister, highlighted the importance of bolstering multilateralism and global collaboration.

There is a tendency to "group together into clubs," Youssouf said, adding that this "minilateralism" results in resistance to change in international institutions, thus worsening inequality and compounding geopolitical

Although this trend isn't irreversible, he noted that it demands significant investment to establish a system that reflects present geopolitical dynamics and strengthens close collabo-

Foreign Minister Youssouf also mentioned that Djibouti has achieved significant strides in diminishing mal-

UN: Ethiopia struggles to cope with effects of Sudan conflict

THE United Nations Population Fund (UNFPA) said Friday that conflict, displacement, climate-related shocks and persistent disease outbreaks continue to be the major drivers of need in Ethiopia.


The UNFPA said in its humanitarian response situation report issued Friday evening that malnutrition remains a public health problem in various regions of the East African country plagued by food insecurity, inadequate water, sanitation and hygiene services, and disease outbreaks.

According to the Humanitarian Response Plan 2023 for Ethiopia, over 20 million people are estimated to be in need of humanitarian assistance, including 4.5 internally displaced persons (IDPs).

UNFPA said cholera cases continue to rise and spread with outbreaks reported in many Ethiopian regions.

It said climate-related events caused by heavy rainfall and floods have resulted in new displacements in the Oromia region while water shortage due to drought continues to impact the Somali region.

Hamas: Israeli forces kill two Palestinians in West Bank raid

WEST BANK

ISRAELI forces killed two Palestinians, including a fighter from the Islamist group Hamas, during a raid on a refugee camp in the occupied West Bank early yesterday, emergency workers and Hamas said.

Israeli forces raided the Nur Shams camp near the city of Tulkarm and a gun battle ensued with Palestinian fighters, medic Najeeb Adeeb said.

The Israeli military said it conducted "counterterrorism activity" in the camp, dismantled an operational command center, and uncovered dozens of explosive devices and bomb-making components.

"During the activity, suspects opened fire and hurled explosive devices at the forces, who responded with live fire. Hits were identified," the military said in a statement.

Hamas said one of those killed belonged to its armed wing. There was no immediate word on the identity of the other man reported to have been killed.

The military said an Israeli soldier was moderately wounded.

Violence in the West Bank has raged for more than a year, with stepped-up Israeli military raids, increased settler assaults on Palestinian villages and a spate of Pales-

tinian attacks on Israelis.

As day dawned on the Nur Shams camp, residents took stock of the roads, infrastructure and buildings damaged during an operation that witnesses said lasted around six

The military said special engineering vehicles dug up roads in the camp, uncovering a large number of concealed bombs and setting off at least one roadside bomb.

Some 13,519 people are registered in Nur Shams camp with the UN agency for refugees, descendants of Palestinians who were forced out or fled their homes during the 1948 war surrounding Israel's creation.

Russian forces destroy Westernmade weapons in Kherson area

MOSCOW

RUSSIA'S Battlegroup Dnepr has destroyed Ukraine's Western-made weapons in the Kherson area, the Russian Defense Ministry said in a statement.

"Russian artillery units continue to perform their combat mission in the special military operation, hitting the Ukrainian armed forces' artillery positions, wiping out defenses, suppressing enemy command points and firepower. Msta-B crews of Battlegroup Dnepr destroyed Western-made weapons and equipment of the Ukrainian army by counter-battery fire in the Kherson area," the statement reads.

The Defense Ministry added that Russian forces were using high-precision munitions to cause as much damage as possible to the enemy's armored vehicles and troops. Drone operators monitor the work of howitzer crews, adjusting fire and reporting the results of attacks to those in firing positions in real time.

"[They] mostly try to cross [the Dnieper] at night; most of the action and the work take place during the night as we try to prevent the enemy from reaching this bank," said a crew commander with the call sign Cuba.

The Msta-S is a self-propelled 152 mm howitzer designed to wipe out and suppress various types of enemy combat hardware and troops, destroy defensive sites and deny the maneuver of enemy infantry and tank reserves. The Russian Defense Ministry has repeatedly released video footage showing these howitzers hammering enemy targets in the special military operation in Ukraine.

BRICS members strongly condemn terrorism in all forms, commend India's G20 Presidency

NEW YORK

THE Foreign Ministers of BRICS member nations held their annual meeting on the margins of the 78th Session of the United Nations General Assembly on September 20, chaired by the Russian Federation in its capacity as the incoming BRICS Chair for 2024.

The Ministers expressed their firm view that the G20 should continue to function in a productive manner and also commended the successful hosting of the 18th G20 Summit in New Delhi under the Indian Presidency. They also welcomed the African Union as a permanent member of the

"They noted the opportunities to build sustained momentum for change by India, Brazil and South Africa presiding over the G20 from 2023-2025 and expressed support for continuity and collaboration in their G20 presidencies and wished them all success in their endeavours. Therefore, they reiterated their commitment to a balanced approach by continuing to amplify and further integrate the voice of the global South in the G20 agenda as under the Indian Presidency in 2023 and the Brazilian and South African Presidencies in 2024 and 2025," the media statement read.

Ministers expressed strong

condemnation of terrorism in all its forms and manifestations whenever, wherever and by whomsoever committed. They recognized the threat emanating from terrorism, extremism conducive to terrorism and radi-

They committed to combating terrorism in all its forms and manifestations, including the cross-border movement of terrorists, and terrorism financing networks and safe havens. They reiterated that terrorism should not be associated with any religion, nationality, civilization or ethnic group.

"They reaffirmed their unwavering commitment to contribute further to the global efforts of preventing and countering the threat of terrorism on the basis of respect for international law, in particular the Charter of the United Nations, and human rights, emphasizing that States have the primary responsibility in combating terrorism with the United Nations continuing to play central and coordinating role in this area," the statement read.

The Ministers also stressed the need for a comprehensive and balanced approach of the whole international community to effectively curb terrorist activities, which pose a serious threat, including in the presentday pandemic environment. They rejected double standards in coun-



tering terrorism and extremism conducive to terrorism. "They called for an expeditious finalization and adop-

tion of the Comprehensive Convention on International Terrorism within the UN framework and for launching multilateral negotiations on an international convention for the suppression of acts of chemical and biological terrorism, at the Conference of Disarmament.

They welcomed the activities of the BRICS Counter-Terrorism Working Group and its five Subgroups based upon the BRICS Counter-Terrorism Strategy and the BRICS Counter-Terrorism Action Plan. They looked forward to further deepening counter-terrorism cooperation," the statement added.

The Foreign Ministers also supported a comprehensive reform of the UN, including its Security Council and supported the legitimate aspirations of Brazil, India and South Africa, to play a greater role in the UNSC. "The Foreign Ministers also supported a comprehen-

sive reform of the UN, including its Security Council, with a view to making it more democratic, representative, effective and efficient, and to increase the representation of developing countries in the Council's memberships so that it can adequately respond to prevailing global challenges, and supported the legitimate aspirations of emerging and developing countries from Africa, Asia and Latin America, including Brazil, India and

South Africa, to play a greater role in international affairs, in particular in the United Nations, including its Security Council," the statement further added.

The Ministers recalled the consensus during the 15th BRICS Summit on guiding principles, standards, criteria and procedures on the BRICS expansion process and the decision on inviting the Argentine Republic, the Arab Republic of Egypt, the Federal Democratic Republic of Ethiopia, the Islamic Republic of Iran, the Kingdom of Saudi Arabia and the United Arab Emirates to become full members of BRICS from January 1, 2024.

During the meeting, the ministers were also briefed on the preparations for Russia's upcoming BRICS Chairship in 2024.

"Brazil, India, China and South Africa extended their full support to Russia for its BRICS Chairship in 2024 under the theme 'Strengthening of multilateralism for the purposes of just global development and security' and the holding of the 16th BRICS Summit in Kazan, Russia," the media statement read.

The statement added that the Foreign Ministers look forward to the standalone meeting of BRICS Ministers of Foreign Affairs/International Relations in Russia in 2024.

Infrastructure to boost East Africa's 2027 AFCON hosting bid, says official

THE Federation of Uganda Football Associations (FUFA) Head of Marketing and Broadcasting, Rodgers Byamukama, believes Kenya, Uganda, and Tanzania's infrastructure gives East Africa's pursuit of hosting the 2027 Africa Cup of Nations (AFCON), known as 'East Africa Pamoja Bid', a

Speaking on the recent developments within the region, Byamukama stressed that even if the region fails in the bid, which he is 'sure' will go through, the level of sporting infrastructure would move up another level.

"Even if we do not win the bid, which I am sure we will win, the works that are ongoing in terms of stadium infrastructure improvement will ensure that it does not stay the same, it will improve," Byamukama said.

Byamukama borrowed a leaf from Kenya's bid to host the 2018 Africa Nations Championship (CHAN), which allowed for the construction of stadiums such as Kinoru in Meru and Bukhungu in Kakamega.

The official noted: "When Kenya bid to host CHAN, that is when we saw stadiums like Bukhungu coming up, that is when we saw Kinoru Stadium in Meru coming up."

"They may not have been complet-

ed in the proverbial 100 days, but you can see every country is doing a football facility. The bid is about improving facilities."

Byamukama also believes that some of the medical facilities in the region do not compare to the rest of Africa, which will give it an edge in the battle to win the bid.

"Apart from stadiums, we have all the other necessities in East Africa, be it hotels, security, hospitals. A Lot of people come from all over Africa to come and get treated here," the official said.

"Some of them never make it back, but they come here. There's a lot of medical service on offer here."

The official noted: "In Tanzania, Muhimbili Hospital is the only facility that gives heart transplants, did you know that? So we have a lot of capacity to do it."

Byamukama dismissed people who are pessimistic about the region's chances of hosting the tournament without 'even understanding' the criteria that could make CAF award the bid to the region for the 2027 AFCON.

The official noted: "We find ourselves disappointed to see people who do not believe in this bid without even understanding what it is in the bid. But we are on track and we look forward to enjoying the extravaganza in 2027.

Pundits divided over German coach bolting from Singida Fountain Gate FC

HOCK was written all over the faces of members of the Premier League fraternity in Tanzania as German coach, Ernst Middendorp, resigned from his position as head coach of Singida Fountain Gate FC, two weeks after his arrival.

There were murky circumstances of his departure, worsened by the inability of the club's officials to say precisely what happened, at the time that the news leaked he had depart-

He then talked to the South African media where his remarks went viral and aired everywhere.

Xavi hails Barca's new 'winning character' after 'epic' Celta comeback

BARCELONA coach Xavi Hernandez praised his side's "winning character" after a sensational 3-2 comeback to beat Celta Vigo on Saturday and move top of La Liga.

The coach, who signed a new deal until 2025 this week, celebrated with his 50th victory in La Liga, as Robert Lewandowski's brace and Joao Cancelo's late winner helped his team triumph despite entering the final 10 minutes two goals behind.

Jorgen Strand Larsen and Anastasios Douvikas struck for the visitors, who seemed on course for a surprise win against the champions, but Barcelona produced a comeback which Xavi called "epic".

"We didn't play well (but) came up with the epic, showing winning character," Xavi told reporters. "Historically we have lacked that ... this shows the generational change we have, they didn't give up, two nil

"I think this generation fights until the end ... what happened today is a tremendous turning point of winning character, we didn't play well but it's about character, faith, the epic.'

Wily Celta coach Rafa Benitez set up in his typically defensive fashion, unlike Barcelona's recent visitors Real Betis and Royal Antwerp, whose attacking intent made them lambs to the slaughter.

Barcelona hit 10 goals in their previous two matches, with Xavi saying it was the best they had played in his reign, but this performance was largely at the other end of the spectrum.

"(Winning) tastes good, but is it better than the day against Betis or Antwerp? No, because this is not our path," said Xavi. "Our path is the other day, playing well, moving the ball around high up the pitch -- when we lower our intensity, this team suffers a lot."

AFTER spending £175 million on signings this summer, Manchester United's inspiration to end their run of worrying defeats came in the form of Jonny Evans, their 35-yearold free agent who had been back at Carrington in pre-season while he looked for his next club.

On Friday, Tanzania will entertain Ivory Coast in the reverse fixture at Azam Complex Stadium in Dar es Salaam, with the winner on aggregate slated to face either Djibouti or Togo in the next round of the qualifiers.

The tactician said: "I am satisfied with the performance of my team and I have strong belief that we are going to score three goals at home. This is possible because we are now aware of their strengths and weaknesses."

Shime stressed: "In Ivory Coast, we went with a plan to defend and use counterattacks to search for goals but, at home, we will be attacking throughout while, at the same time, not giving them a chance to get an away goal."

Should Twiga Stars emerge as the aggregate winners of the two-legged qualifier, they will face either Djibouti or Togo in the second round, slated for November 27 and December 5.

The 2024 Women's Africa Cup of Nations is officially known as the 2024 TotalEnergies Women's Africa Cup of Nations for sponsorship purposes and as WAFCON 2024 for short.

The showpiece will be the 15th edition of the biennial African women's football tournament organized by the Confederation of African Football.

It will be hosted by Morocco

in consecutive editions, having hosted the previous edition two years before. South Africa, also known as 'Banyana Banyana', is the defending champions.

Morocco qualified automatically as hosts, while the remaining spots will be determined by the qualification rounds, whose draw was conducted on July 6, 2023, at the Mohammed VI Complex in Rabat, Morocco, and commenced in August.

Nigeria is the most successful nation in the history of the tournament since it became full-scale in 1998, winning 11 of the 14 editions so far.

Equatorial Guinea won as hosts of the 2008 and 2012 editions and incumbent champions, South Africa, with one title.
