Targeting local residents, members of Indian Diaspora

HE Indian High Commission in Dar es Salaam has said it is embarking on a marathon run of cross-country consular camps.

Bishwadip Dey, the high commissioner, said here over the weekend that the diplomatic mission expects to organize up to six consular camps annually to engage parts of the communities having significant interests in the south Asian country.

The incoming envoy said that as he takes up his duties, he "intends to travel across various regions and engage more proactively with local residents," to bring the diplomatic mission closer to Tanzanians and the Indian Diaspora outside Dar es

At the Indian Cultural night of

Kalakendra, the envoy said that the first such consular camp shall be organized in Tanga next month, with the Kalakendra night cultural performance tying up with the 78th anniversary of Indian independence.

The night was first observed in Dar es Salaam, followed by Arusha and expected to be staged in Zanzibar as well, he said, in the presence of Emmanuela Kaganda, the Arumeru district commissioner who graced the occasion.


THE Tanzania Revenue Authority (TRA) has urged heads of regional administration to strengthen districts tax advisory committees for effectiveness in addressing tax-related conflicts.

Yusuph Mwenda, the TRA commissioner general, issued this appeal here over the weekend at a familiarisation visit with local business leaders and regional officials.

He emphasised TRA's readiness to assist in enabling the committees to function effectively, enhancing revenue collection and sorting out taxpayer compliance disputes

Digital health: Z'bar hires two firms for networking services

DIGITAL applications will be more available in due course in the provision of health services in Zanzibar following the signing of a memorandum of understanding (MoU) with Tancloud Co. Ltd, a local cloud computing firm and Electronic Health Network, a UK firm, to build digital networks in the Zanzibar health sector.

Nassor Ahmed Mazrui, the Zanzibar Health minister, said after signing the agreement here over the weekend, that this arrangement is meant to modernise and effectively provide online health services countrywide.

With the networking system, Zanzibar residents will receive prompt medical attention tailored to their health needs, a move promising significant benefit for the community.


He pointed at a range of reforms expected further improve health sector services,

with intent to make the noted tourist destination also a hub for medical visitations from across East Africa.

The major focus is to enhance investments in quality infrastructure and competent medical staff to facilitate the provision of quality health services, he said, outlining government objectives of aligning the services with wider regional and international standards.

He picked the Indian example as a sector role model, where the government also seeks to provide equivalent care for f residents opting to seek medical care outside Zanzibar.

With the changes, Zanzibaris will have far less need to seek medical treatment abroad, while also seeking to attract people in the neighbourhood to consider Zanzibar for upgraded medical care, he said.

The government will ensure health protection for the vast majority of people "and everyone should understand that their health is their investment because, without health, there is no investment," he stated.

Zanzibar will be recognised as a centre of health investment, he said, projecting that shortly there will be significant changes in healthcare services, "transforming the provision of health services for everyone to receive reliable care promptly, satisfied with the services they receive.'

He discounted assertions on the role of the private sector, affirming that the government has not privatized health services in district, regional or referral hospitals. Instead, it is collaborating with the private sector to enhance hospital management and improve efficiency, he ex-

Many people prefer seeking private hospital services, often spending substantial amounts of money while those who cannot afford such costs rely on donations, he said.

The government compensates the private sector for providing treatment in government hospitals at no cost to patients, he said, stressing that this initiative reflects compassion on the part of health authorities under the leadership of President Dr Hussein Ali Mwinvi.

Patients receive free treatment while the government reimburses the private institutions sector involved for their services, the minister noted, saying of the agreements as aiming to introduce modern technology in hospitals and health centres.

This includes systems for drug procurement and distribution, where Dr Sumeya Okod, the Tancloud Co. Ltd director, stating that the firm is prepared to provide top-notch technology, efficiently aligning with the ministry's objectives.

The six-year agreement is valued at over \$170m, where the primary focus will be on utilising advanced digital technology to enhance healthcare services, she added.

He cited Mara Region as pivotal in tax collection both from its economic activities and busy Sirari border post, servicing trade flows with Kenya and Uganda.

Tax advisory committees relate to TRA's broader strategy to improve tax collection through enhanced taxpayer education, curbing smuggling as part of combating tax evasion, he said.

TRA expects to improve tax collection by enhanced taxpayer education and control of smuggling, ensuring compliance while preventing illegal tax practices, he elaborated.

Col. Evans Mtambi, the regional commissioner, said at the event that businesses often struggle after their founders pass away or there is a policy shifts, explaining the gaps as arising from a lack of business education.

Urged TRA to find friendly ways to support business growth, he said the agency needs to explore ways to provide business education, build a solid foundations for enterprises to ensure their sustainability. This will prevent frequent enterprise closures which impacts on government revenues, the administrator intimated.

A more workable procedure for delivery and maintenance of electronic fiscal devices (EFDs) would ensure their constant availability, quick repair if damaged, helping to reduce loopholes for bribes and tax evasion, he said.

TRA also needs to closely monitor tax payments in small-scale mining operations to ensure comprehensive government revenue collection, while polishing its strategies to address the smuggling of minerals.

"I commend the TRA staff at the Sirari Customs Post for their efforts in combating smuggling," the RC stated, vowing greater liaisons between the regional security committee with anti-smuggling initiatives at the border post.

India's 78th Independence Day: Govt for stronger ties

THE government has assured India of its commitment to enhancing bilateral relations across various sectors, including trade, in order to boost foreign exchange and create additional investment opportunities for mutual benefit.

Dr Damas Ndumbaro, Minister of Culture, Arts and Sports, made the statement in Dar es Salaam at the weekend during the celebrations to mark India's 78th Independence Day held at the Swami Vivekananda Cultural Centre (SVCC).

The event was attended by various envoys representing their countries in Tanzania, Members of Parliament, leaders from various institutions and members of the Indian diaspora.

Dr Ndumbaro said that India remains a crucial trade partner for Tanzania, with trade volumes between the countries having risen significantly.

The minister commended the Indian government for its ongoing support to Tanzania in sectors such as water and education.

He highlighted a notable project from 2022, where six Indian companies signed a contract for a \$5 million, a water development initiative, set to provide clean and safe water to over four million people upon completion.

Bishwadip Dey, Indian High Commissioner to Tanzania, said that bilateral relations have reached a significant milestone, further strengthened by President Samia Suluhu Hassan's visit to India in October, last year.

He noted that trade between the countries has surged, with trade volume reaching \$7.9 billion in 2023, according to available statistics.

Dey also mentioned the visit of three Indian naval ships to Tanzania this year, which participated in joint naval exercises with the Tanzanian Navy, underscoring the robust nature of security partnership.

Reflecting on India's Independence Day, Dey said: "India gained independence on August 15, 1947, and has since made remarkable progress in various sectors. Today, India is the world's fifthlargest economy and one of the fastestgrowing."

He added that under Prime Minister Narendra Modi's visionary leadership, India aims to become a developed nation by 2047 and is committed to empowering its citizens to achieve self-reliance.

ICT experts urge Tanzanians to embrace digital economy

THE government through Tanzania National Business Council (TNBC) ICT Working Group has called on Tanzanians to get prepared for implementation of a digital economy plan to smoothly align with global demands driving economic transformation.

Mohamed Abdulla, Permanent Secretary in the Ministry of Information, Communication and Information Technology who is TNBC working Group Chairman, has said that embracing digital technology would significantly drive eco-

nomic growth and stimulate rapid growth of sectors of the economy such as agriculture, trade and tour-

Speaking in Dar es Salaam shortly after the group meeting at the weekend, Abdulla said there was need for more emphasis on leveraging internet for businesses to simplify service access and accelerate economic growth.

"During our meeting, we discussed implementation steps of digital economy plan through cooperation between the government and private sector," he said, noting that the government under was committed to implementation of digital economy.

He said members discussed recommendations on implementation and how to monitor and evaluate digital economy plan to enable stakeholders review them as part of preparing for the plan's execution.

"The government is all out to make Tanzania a leading digital economy and enhance our global competitiveness," he said, calling for all Tanzanians to join hands to embrace digital economy.

"We now see progress in accessing services; one can now purchase goods and services from home digitally. We want to reach that level with other services to ease daily life.'

The group co-chairperson Jackline Uiso from the private sector stressed the significance of digital transformation in communication sector, saving it could drive growth across industries as part of the plan's strategy.

She noted that the 10-year strategy includes guidelines for each sector to prepare for the economic changes and that Tanzania's financial sector was thriving, adding that the focus must shift to inte-

grating other sectors such as agriculture, health, media, construction, and education into the digital economy to fully capitalise on available opportu-

Dr Godwill Wanga, TNBC's Executive Secretary, said the meeting involved various stakeholders who approved recommendations for the way forward and that the group's experts would visit each sector to ensure the plan is well known, provide education and encourage implementation.

AMR 'bigger' health threat than HIV/Aids, TB, malaria combined

THE likelihood of falling ill or dying from diseases that resist treatment has escalated in Africa, with children and other vulnerable groups being most at risk, according to a new report by the Africa Centres for Disease Control and Prevention (Africa CDC).

"The continent faces the highest mortality rate from antimicrobial resistance (AMR), with 27.3 deaths per 100,000-exceeding the combined death toll from HIV-AIDS, tuberculosis and malaria," said the 'African Union Landmark Report' launched over the weekend.

Africa bears a significant burden of infectious diseases, accounting for approximately 95 percent of malaria deaths, 70 percebnt of people living with HIV, and 25 percent of TB deaths

globally, said the report. "We must not ignore this silent threat that disproportionately impacts the most vulnerable among us," said Africa CDC Deputy Director General, Dr Raji Tajudeen.

AMR occurs when microorganisms like bacteria, viruses, fungi and parasites develop resistance to antimicrobial drugs, a process hastened by human behaviours such as the misuse and overuse of these drugs in healthcare, agriculture and food systems. This renders antibiotics and other antimicrobials less effective, causing treatment failures, increased disease spread, severe illness, disability and higher mortality rates.

Despite the estimated USD2-6 billion needed annually for an effective AMR response across Africa, current funding is only a tenth of that allocated to other major diseases. This underfunding makes AMR a significant barrier to sustainable development, hindering progress toward the Sustainable Development Goals (SDGs) and the African Union's Agenda 2063.

An estimated 700,000 people die annually from drug-resistant infections globally. Without timely intervention, this number is projected to reach 10 million by 2050, with Africa accounting for 4.5 million.

"Fighting disease requires resources and working with member states and our partners we need to do all we can to save lives," said Dr Tajudeen, speaking at the launch of a report on AMR in Africa. The event also initiated discussions on a roadmap and targets to advance Africa's battle against AMR. The outcomes are expected to inform the upcoming United Nations General Assembly High-Level Meeting in September-a crucial platform for global action on this escalating crisis.

Dr Huyam Salih, the director of the African Union-Inter African Bureau for Animal Resources (AU-IBAR), emphasized the critical role that the AU must play in combating AMR. "Antimicrobial resistance is not just a health issue-it is a threat to our agrifood systems, food safety, food security, livelihoods, and economies," she

USADF releases 250m/- grant to improve quality of coffee in Hai

THE US African Development Foundation (USADF) has awarded a grant of 250m/- to Lukani-Losaa Agricultural Marketing Cooperative Society (Amcos) to help tackle challenges affecting production of coffee destined for international markets.

The Amcos located in Hai District, Kilimanjaro Region, which has 580 members is implementing a five-year strategic plan (2024/2029) aimed at boosting production by encouraging new farmers and expanding farms, as well as establishing a digital system for recording and managing business information and the cooperative's ac-

Speaking about the project's implementation here at the weekend, Gilliard Nkini, USADF Resident Project Coordinator in Tanzania, said that the organization collaborates with the government to enhance efficiency in coffee subsector.

"We fully understand that for a nation to achieve productivity in farming and for farmers to truly benefit, they must join cooperative groups that are closely managed by the Registrar of Cooperatives," he said.

USADF operates in 22 African coun-

tries, focusing on improving incomes of farmers and agricultural processors, recognising that this is crucial for the economies of African nations.

Ebenetho Munuo, chairman of Lukani-Losaa Amcos, said that the grant reflects the cooperative's solid strategic plan for coffee development through cooperative system.

"The primary conditions of this grant include directing project funds

towards constructing of production and processing infrastructure, enhancing irrigation systems, promoting environmental conservation and strengthening systems for disseminating knowledge and essential information about quality of coffee," he said.

He said the overall aim of the project is to increase both the volume and quality of coffee, raise coffee prices and farmer incomes and ultimately

improve the quality of life for coffee farmers and their communities.

The projected harvest for the 2025/26 coffee season is expected to be 150,000 kilogrammes.

According to the cooperative's reports, opportunities in international markets have expanded, with direct markets now established in Japan, the United States, Australia and China.

Equipment worth 173m/to expand rice production

THE Food and Agriculture Organisation of the United Nations (FAO) has procured modern equipment worth \$65,000 (173m/-) to enhance sustainable rice production in the country.

Implemented in partnership with the government of Republic of Korea, this is part of capacity development and experience sharing for rice value chain through the South-South and Triangular Cooperation (SSTC) project which began in 2020 and is scheduled for completion by December this year.

Diomedes Kalisa, SSTC project coordinator, said that \$15,000 (40m/-) of the total amount has been used to acquire agricultural equipment, land levelling tools, technical planting and harvesting equipment.

Speaking at the weekend here, Kalisa said that the tools are designed to help farmers level their fields and conduct planting and harvesting more professionally to tackle some agricultural challenges, including rice losses during harvesting.

He said that unlevelled fields hinder effective water distribution, particularly in sloped areas, and contribute to crop losses due to uneven plant heights during harvesting.

"Further purchases of over seven ad-

ditional pieces of equipment valued at \$40,000 (106m/-) will be made and delivered before project completion. We collaborate with Tanzania Agricultural Research Institute (TARI) to ensure that the expertise gained from various training reaches specialists who will then pass it on to farmers and agriculture officers at village level for sustainable agriculture through technology to uplift the sector across Tanzania," Kalisa said.

Kulwa Furahisha, TARI-Ifakara Centre manager, emphasised the importance of promoting effective agricultural practices for rice to boost productivity.

He said that using a rental system for agricultural tools help farmers access the tools to improve rice production efficiency.

Furahisha also mentioned that using plant protectants instead of chemicals, cultivating rice on raised beds and employing soil spreading equipment will help reduce water usage and address the challenges posed by high water consumption and climate change impacts.

Jabir Makame, Gairo District Commissioner, said that rice is Tanzania's second most consumed food crop after maize, with Morogoro Region being among the major producers, hence needing adequate education to advance production.

He identified low productivity as a major issue, with large cultivation areas

yielding minimal outputs due to poor farming practices and limited use of technology.

Makame said that training aims to build the capacity of experts to train farmers on how to increase the use of modern technology in rice farming, allowing them to cultivate smaller areas but achieve higher yields and efficiency in the rice subsector.

Lena Sanga, Mbarali District Agriculture Officer, thanked FAO and TARI for the valuable training, which she said will significantly benefit farmers.

She committed to sharing the knowledge to improve the use of agricultural tools and enhance rice production in the country.

The project is implemented in Tanzania, Ivory Coast, and the Philippines, with activities in Tanzania based in Dakawa and Ifakara areas of Morogoro Region.

WHO donates 12 motorcycles to boost health surveillance efforts

THE World Health Organization (WHO), with funding from the Irish Fund has donated 12 motorcycles to Tanzania to boost effectiveness of district surveillance officers in monitoring and mentoring health facilities, to improve adherence to integrated disease surveillance and response strategies.

The handover event was held the weekend in Dodoma, whereby WHO Country Representative, Dr. Charles Sagoe-Moses, expressed gratitude to the Tanzanian government for its proactive measures to strengthen the health system.

"We extend our sincere thanks to the Irish government and the Irish Embassy for their financial support and commitment to the

'Health for All' agenda. This collaboration exemplifies our shared dedication to building resilient health systems," he said.

Tanzania has faced numerous health emergencies, including cholera and Marburg virus outbreaks, highlighting the need for improved resilience at the sub-national level. The donation is part of the broader project 'Strengthening Health Systems Resilience for Enhanced Health

Emergency Response at the Sub-national Level' funded by the Irish government.

The project aims to bolster healthcare capacity to effectively respond to emergencies.

Dr Wilson Mahera, deputy permanent secretary in the President's Office (Regional Administration and Local Government) acknowledged the significant challenges related to transportation infrastructure that districts face, which affects surveillance operations.

"The support from WHO is invaluable for our emergency response efforts," he said. "It will greatly enhance our ability to monitor and manage health crises, aligning with our health for all goals," he said.

In addition to the motorcycles, the project supports several other key initiatives, including development of the National Action Plan for Health Security (2024-2028), maintenance of influenza sentinel sites, and strengthening emergency response capacities.

Margaret Gaynor, Head of Development Cooperation at the Irish Embassy, said: "This initiative underscores our joint commitment to enhancing resilience of Tanzania's healthcare system and ensuring a robust response to health emergencies."

Efficient disease surveil-

lance is essential for early detection and control of public health threats. However, inadequate transportation infrastructure often hampers effective supervision and monitoring at the district and health facility levels. The new motorcycles will address these challenges, enabling more regular and efficient supervision, mentorship, and adherence to event-based surveillance protocols.

Southern African countries call for urgent action against mpox

LEADERS of the Southern African Development Community (SADC) on Saturday urged the regional bloc's secretariat to convene an urgent meeting of health ministers to assess the impact of mpox in the region.

The summit also urged member states to strengthen disease surveillance, diagnostic testing, clinical care and infection prevention and control, SADC Executive Secretary Elias Magosi said when delivering a communiqué at the end of the 44th Ordinary SADC summit of heads of state and government here in the Zimbabwean capital.

"The summit directed the secretariat to convene an urgent meet-

ing of health ministers to assess the impact of mpox and facilitate a coordinated regional response to control the spread of the disease," he said.

He said the summit had noted the mpox situation on the continent and in the SADC region and the declaration by the World Health Organization (WHO) of mpox as a public health emergency of international concern.

The summit extended solidarity and support to member states affected by mpox and further requested WHO, the African Centers for Disease Control and Prevention and partners to avail resources towards the mpox response in the region, Magosi added.

UN emphasizes human rights ahead of September summit

THE United Nations in Tanzania has underscored the importance of adhering to human rights and social justice as it strategises its engagement with Civil Society Organisations (CSOs) towards the Summit of the Future 2024 in September.

According to the UN, the Summit of the Future 2024 is a once-inageneration opportunity to enhance cooperation on critical challenges and address gaps in global governance. It will reaffirm existing commitments, including to the Sustainable Development Goals and the United Nations Charter, and move towards a reinvigorated multilateral system better positioned to impact

people's lives positively.

Shabnam Mallick, Head of the UN Resident Coordinator's Office, said this in Dar es Salaam at the weekend during discussion at a meeting dubbed 'High level Multi Stakeholder consultation towards Summit of the Future: Stakeholders Solutions for better Tomorrow and Safeguarding the Future'.

She said as they prepare for the summit scheduled for September 22nd and 23rd this year, it was time to recommit, deepen partnership, listen, support and work with civil society in building a brighter, shared vision and a common future for all.

"The promotion and protection of human rights remain at the core

of the United Nations' mission. Civil society plays an important role in defending these rights, advocating for those who are most vulnerable and holding institutions accountable. Your work in this area will be essential in shaping policies that are grounded in justice and equity," she said.

"Achieving the Sustainable Development Goals (SDGs) requires innovative approaches and strong partnerships. We need to continue building on the progress made and address the gaps that remain, particularly in areas such as climate action, poverty reduction and gender equality. Your grassroots initiatives provide invaluable insights and solutions that must be integrated into

global strategies.

"We must continue to work together to ensure that governance at all levels is inclusive and participatory. This involves not only engaging diverse voices but also ensuring that those voices have a meaningful impact on decision-making processes. Your role in advocating for transparency, accountability and inclusivity is more critical than ever."

Ibrahim Bakari, Executive Director of the United Nations Association of Tanzania (UNAT), quoting the late Julius Nyerere's speech at the United Nations General Assembly (UNGA) in 1994, said that development should be people-centred as they are the target, creators and

beneficiaries of anything known as development.

"People cannot be developed by others; but they can develop themselves. But external forces can prevent them from developing themselves. Among those forces are wars and conflicts, and ither external forces which can occur locally or abroad, and can be military or economic power."

Joseph Malekia, Senior Economist in the President's Office (Planning Commission) underscored the transformative role of CSOs in Tanzania's development.

Food vendors in Kibaha trained on clean energy use, financial literacy

SEVENTY food vendors in Kibaha District, Coast Region, have been equipped with essential skills to help them improve their operations by adopting clean cooking and business practices to attract more customers and boost their income.

The training marks the second phase of the Mpishi Hodari programme following the successful implementation of phase one which saw 50 food vendors in Dar es Salaam receive training.

The one-day session focused on health, environmental and economic benefits of transitioning from traditional cooking methods as well as empowering vendors to access financial services.

Speaking at the opening of the training at the weekend here, Kibaha District Commissioner Nickson Simon commended the organizers of Mpishi Hodari initiative and other projects benefiting women, youth, people with disabilities and Tanzanians in general.

The programme targets 5,000 food vendors in urban, rural and peri-urban areas across Dar es Salaam, Coast, Morogoro, Urban West, Dodoma and Lindi regions

"I am pleased to see Tanzanian-owned organisations leading the way in promoting clean energy in Tanzania. These initiatives align with the government's efforts to promote clean cooking, with 2034 identified as a pivotal year for clean cooking in Africa," he said.

He promised that the government will provide

necessary support to advance the campaign to reach more Tanzanians.

Pamela Mushi, representative of the organizers, said that Mpishi Hodari initiative aims at raising awareness about benefits of clean cooking methods.

She noted that phase two of the programme includes experiential learning through participatory training, interactive displays and exhibitions of improved stoves, cooking demonstrations by clean energy vendors and educational workshops on the benefits of clean cooking.

The phase also involves stakeholder engagement with the government, NGOs, private and international partners to enhance policy and technical support and provide incentives such as improved stoves to food vendors.

Beneficiaries of the training expressed their satisfaction, noting that using clean energy not only improves health but also reduces the time and costs associated with meal preparation. Clean energy sources like electricity or gas are more convenient and eliminate the need for additional preparations such as heating charcoal or firewood.

Kanyusi added that besides processing birth and death certificates, RITA also handles applications from students seeking birth certificates to meet one of the requirements for higher education loans.

He appealed to students applying for higher education loans to use the remaining time wisely to verify their birth certificates in order to qualify for the loans.

He said the application process for certificates will soon be closed and encouraged students to submit their applications through RITA's social media channels to understand the requirements for their applications.

UN welcomes Sudan's decision to reopen border crossing with Chad for aid delivery

UN Secretary-General Antonio Guterres has commended Sudan's decision to reopen the Adre border crossing with Chad for humanitarian aid to enter the war-ravaged Darfur region, his spokesperson said at the weekend.

The secretary-general commended the decision to reopen "the most direct and efficient route for humanitarian aid to reach the millions in Darfur facing record levels of acute hunger,' Stephane Dujarric said in a statement.

Guterres underscored the importance of concrete and sustained measures to facilitate humanitarian access and protect civilians, in accordance with the obligations of Sudanese parties under international humanitarian law and previously agreed modalities, said Dujarric.

"Humanitarian organizations must have full, safe and unhindered access to reach all civilians in need across Darfur, and across the country as a whole," the statement said, adding that the United Nations remains fully committed to working with all relevant stakeholders to help end the conflict and alleviate the suffering of the Sudanese peo-

Sudan's Transitional Sovereign Council on Thursday decided to reopen the Adre border crossing with Chad for three months to allow the delivery of humanitarian aid to those affected by the country's ongoing conflict.

Sudan has been witnessing a deadly conflict between the Sudanese Armed Forces and the paramilitary Rapid Support Forces (RSF) since April 2023, resulting in the loss of at least 16,650 lives.

In February this year, the Sudanese government stopped the delivery of aid through Adre, accusing the RSF of using the crossing to transport weapons.

Minister unveils novel six-year regional industrialisation drive

MINISTER for Industry and Trade Dr Selemani Jafo has directed all regions to establish factories to implement the six-year (2025-2030) Industrialisation Programme meant to create jobs and boost economic

Dodoma while unveiling the Viwanda Tanzania programme which is guided by the slogan 'Our factories, our jobs, our economy'.

Explaining the mode of implementation of the programme, Dr Jafo said that each region is required to establish three large industries, five medium industries, Dr Jafo said this at the weekend in 20 small industries and 30 artisanal

factories whereby all regions will have a total of 78 large industries and 130 medium ones annually.

He said there will be 520 small industries, 780 very small industries, and a total of 1,508 industries per year which will generate 173,160 direct jobs and 911,300 indirect jobs per year. He also said that in the period 2025-2030 through the programme, there will be a total of 468 large industries, 780 medium industries, 3120 small industries, 4,680 very small industries, and a total of 9,048 industries that will generate 1,038,960 direct jobs and 5,467,800 indirect jobs.

TRC officials and their PCCB colleagues have been laying out elaborate controls including the use of identification cards in buying tickets and scanning them on journey starts and arrivals.

What they haven't started addressing is where the traditional railway comes into this equation, if it is left to transport cargo while passenger traffic shifts to standard gauge railway.

There is also a lingering problem of bus operators, who now face exclusion as train is far cheaper.

The chaotic situation in ticketing raises a few issues about the business plan, how far there is income projection and the way it would start being from the word go.

There is a belated correction of the ticketing scenario even if it is exaggerated in its precautions, but scarce analysis seems to have been made on the link between cost recovery and tickets, or how the government optimises SGR revenues by offsetting some of the transport needs to traditional modes. Speed trains look like a communal service where all are invited, hypothetically because we are all on hurry and have poor means.

This situation to an extent shows why public-private partnerships are helpful as no PPP-run speed train services would have people travelling virtually for free for two to three weeks.

Just why that situation persisted for a fortnight or so before anyone woke up to the situation, with the PCCB solicited to come in or doing so on their own, is awkward. Yet there is a plausible scenario where such a situation can come up, in the sense of systemic chaos on revenues, as it was the case with the city run rapid bus transit years ago. The revenue quotations were guesswork at a public meeting.

That should make someone at a higher stage more alert as to how things are likely to run, at least since correcting the ticketing scenario is not the same thing as rectifying the reflex in accounting or controls which brought it up in the first place.

The key element is that chaotic revenues are part of what may internally be imagined, noticed in the lack of fore planning, for instance purchasing tickets cheaply and selling them exorbitantly.

When this is narrated from the outside, one might think it is clever passengers or 'mission town' youths doing that. However, on second thoughts, one sees the potential from the inside.

All this harkens us back to the 4Rs national philosophy, often seen as personal axiom by the Union president, where rebuilding ties up with completing SGR as modernisation, resilience its productivity and profitability.

Reform has to do with managerial shifts to avoid chronic chaotic scenarios that are unaccountable to the public authorities.

This is much just as we need reconciliation as willingness to learn and to accept that undiluted public sector monopoly has shortcomings.



Why #EndBadGovernanceInNigeria protests gained traction

THOUSANDS of Nigerians have taken to the streets to protest against bad governance, corruption, soaring inflation, and the rising cost of living, in what has been termed "10 Days of Rage" and believed to mirror Kenyan protests organized by the youth.

Nigeria, Africa's most populous country and a major exporter of crude oil, citizens claim that the benefits of the country's resources do not trickle down to the masses but to a group of corrupt politicians.

The demonstrations, slated for the first ten days of August, gained momentum on social media, with the hashtag #EndBadGovernanceInNigeria accompanied by the slogan "10 Days of Rage."

This follows the protests in Kenya, where young people engaged in six weeks of demonstrations over an unpopular bill that sought to raise taxes. Under pressure, President William Ruto retracted the bill and announced a cabinet shake-up.

There is no organized leadership for the Nigerian protests, but some of the demands include a total overhaul of the Nigerian system, including the reversal of economic policies implemented by President Bola Tinubu from his first day in office.

A group is also clamoring for the unconditional release of Nnamdi Kanu, a leader of a proscribed secessionist group who was arrested in Kenya, extradited to Nigeria, and detained since June 2021. In the northern state of Kano there were demands the president step down.

Tinubu eliminated the contentious fuel subsidy and requested the central bank to stabilize the naira and control inflation, which experts say may improve the economy but has ultimately impoverished millions of Nigerians.

To appease Nigerians before protests began, the government hastily approved an increase in the minimum monthly wage from 30,000 naira (approximately USD 18.55) to 70,000 naira (USD 43.29) following pressure from labour unions.

Observers note that this raise is negligible in the face of soaring inflation, which has exceeded 34%—its highest level in nearly 30 years—resulting in one of the nation's most severe cost-of-living crises. Politicians promised to slash their salaries by 50% to help solve Nigeria's hunger crisis.

Tinubu also held several closed-door meetings with leaders from across the country to appeal to Nigerians and quell the protests. Job advertisements in government institutions also made headlines.

Agabi Yusuf, a civil rights activist in Sokoto, Northwest Nigeria, argues that all of the "fire brigade"approaches to appeal to Nigerians to stop the demonstrations will not work because "Nigerians are hungry, and this time they have been pushed to the wall."

"You don't expect them to keep their mouths shut," he told IPS.

Brutal Force

Yusuf is worried about the government's brutal response to the protests. Human rights group Amnesty International reported that on the first day of the protests, at least 13 people were killed in clashes between protesters and police forces in various cities. Local media provided differing death tolls, with one newspaper claiming that up to 17 people were killed.

A 24-hour curfew was imposed in many parts of the country, including the northern state of Kano, which is the second-largest state and one of the country's major voting blocs, following the looting of government and public properties there.

People defied the curfew, waving the Russian flag and chanting in the local Hausa language, calling on the president to step down and for the military to take over power. The police responded by killing no fewer than 10 people. The Sokoto-based Yusuf, who was detained by Nige-

ria's secret police on July 25 for attempting to organize youth to protest peacefully, said the threats and brutality from the government can only help but make things spiral out of control.

Yusuf told IPS that the security agency claimed he was part of those allegedly plotting to topple the government of Tinubu through the protests.

"The officers were just yelling at me. They locked me up in a very smelly room for about eight hours. In fact, they threatened that if anything went wrong during the protest, I would be held responsible," Yusuf, a leader with the Northern Advocate for Good Governance, said.

Yusuf is not the only one who has been threatened and detained. According to Amnesty International, nearly 700 protesters, including journalists, have been arrested across the country while nine officers have been injured during the protests. The authorities are wary that the protests may mirror the deadly End-SARS demonstrations against police brutality in 2020, which resulted in deaths and injuries after security forces opened fire on unarmed protesters.

Oludare Ogunlana, Professor of National Security at Collin College in Texas, shares Yusuf's views. He told IPS that suppressing people from protesting will result in very deadly repercussions.

"As we are appealing to the protesters to be orderly, we expect the security agencies to be cautious. If you use deadly weapons on people, then it will escalate and become uncontrollable. The people are simply telling the authorities to address their concerns, but the government has been indifferent."

Nuredeen Hassan, a political analyst in Nigeria, argued that though the protests may have been inspired by what happened in Kenya, there were already signs that Nigerians may soon storm the streets. He noted that "people are really angry about the state of the country."

"While Tinubu has only been president for about a year, his party has held onto power for nine years and only a few of the promises made over the years have been fulfilled. The country is getting worse and this has infuriated Nigerians," he told IPS.

In the administrative capital Abuja, where residents

In the administrative capital Abuja, where residents are angered about the rising cases of kidnapping for ransom, police chased protesters and threw canisters of tear gas at them, injuring many. Security agencies shot live rounds at journalists and protesters, and indiscriminately arrested dozens.

Yakubu Muhammed, a reporter with Premium Times, a daily paper in the country, told IPS that while he was trying to film police officers arresting people, he was hit with the butt of a gun and dragged into a van. "Despite explaining that I am a pressman, they arrested me and seized my phone. In the van, I met four people. I was released some moments later," he said.

Critics accused the security agencies of failing to protect protesters but rather choosing to give cover to allegedly government-paid thugs who, all over the country, are raising placards saying, 'Say No To Protest'.

In Nigeria's economic capital Lagos, thugs threatened and chased protesters while the police watched.

The Race For 2027

President Tinubu addressed the country on the fourth day of the protests. He pleaded for an end to the demonstrations but insisted that he would not reverse any of his economic policies.

His speech did not go well with the opposition who slammed him for not addressing the demands of the protesters. A former Vice President of Nigeria, Atiku Abubakar, said that Tinubu's "speech neglects the pressing economic hardships that have besieged Nigerian families since the very beginning of his tenure."

Ibrahim Baba Shatambaya, a lecturer in the Department of Political Science, Usmanu Danfodiyo University, Sokoto, Nigeria, is concerned that the President made no reference or condemned the killing of protesters in the country by security forces, despite his promise to hold onto the tenets of democracy and human rights.

"The protest is just one event which is an outcome of the poor performance of the government. If the government does not do the needful in actually reversing the trends of economic hardships in this country, the tendency is that the ruling political party may not likely have a field day come the subsequent round of elections in 2027," Shatambaya said.

Ethnic Tensions

Peter Obi, a former governor of Anambra State in southeast Nigeria, was criticized by Tinubu's media aide, Bayo Onanuga, for allegedly leading his supporters to organize the protests to remove the president from power. He referred to Obi's supporters as members of the proscribed pro-secessionist group Indigenous People of Biafra (IPOB) led by the detained Kanu. IPOB is agitating for an independent Biafra Republic which would be made up of Nigeria's southeastern states-the home base of the Igbo tribe. Onanuga claimed Obi, a presidential candidate in the last elections, is unhappy that he lost to Tinubu in a very tight race.

Obi has denied this claim and has taken legal action against Onanuga for defamation. Observers like the political analyst Hassan say this is just a reflection of the level of 'Igbophobia' meted out against the Igbos by some actors in the government and, if care is not taken, could lead to an ethnic crisis.

Organized Igbo-led groups in Nigeria's southeast denounced and pulled out of the protests before they began, fearing there would be a bloody backlash against them if the protest spirals out of control. They fear that, just like in 1966, when thousands of Igbos were blamed and massacred for allegedly leading a revolutionary coup that saw the deaths of many influential leaders and eventually led to a nearly three-year civil war, they could be targeted for actively calling for Tinubu's resignation.

Meanwhile, in the Yoruba ethnic-dominated Southwest, Tinubu's home base, there are growing calls for Igbos to leave the region, which has been condemned by the national government.

Elsewhere in the north, where the protests have become extremely violent with many cities shut down, and workplaces, hospitals, and schools closed, rumors are spreading that the northerners, the majority of whom are from the Hausa and Fulani ethnic groups, are actively protesting against the government because they want Tinubu, a Yoruba man, to step down for one of their kinsmen.

"Some Yorubas are defending Tinubu like they are not seeing this hardship only because he is their kinsman. The Hausas and Fulanis that called protests un-Islamic are now at the forefront of violent protests. They want to make Tinubu a one-term president like

Raising \$400m for southern Africa drought measures possible, via PPP

THE United Nations World Food Programme (WFP) is battling all manner of challenges as it seeks to raise \$400m for a comprehensive response to a dire southern Africa drought situation.

The UN agency is preparing a response of its own, which implies a lack of comparable involvement with other humanitarian agencies in the sense of this emergency being seen as a food issue. If cast in a wider context, that is as a development or sustainability challenge, it is different

For example, there is a global facility related to environmental financing - and that is precisely what a sharp drought is all about.

That applies especially when it is compounded by a hurricane, tornado or storm destroying even the little that could still be harvest.

It would be right suggesting that UN agencies are not seeing this situation in its broader context, as it appears to be up to the specific countries to initiate appropriate action. If they are just seeking food gap covering tonnage, the response mechanism could be complicated.

There is wisdom in the expression that one should not worry as to where one fell but instead ought to check where one actually tripped - before the fall.

That is what a massive food shortage is all about - that is, that there is a scenario policymakers believe will work and have not even started mapping out logistics or allocate resources for a different scenario. Even if such a scenario involves food tonnage, UN agencies can assist local efforts, within a wider reassuring policy view that this situation will be tamed soon enough.

Policymakers at the regional level seeing this scenario need not just see the WFP face sharp difficulties collecting the large sum of money to purchase grain anywhere around the world, think 'outside the box' to admit that the problem lies elsewhere.

It is first a matter of not having given the various agencies enough rope with which to swing into action. They definitely need to convince their respective boards and key contributors that what is scaled up for provision adds to sustainability and not merely to local resources.

There is an axiom a respected economist formulated after intense research in the early 1970s - that no country that has a free press has ever suffered a massive drought that killed millions of people.

Ordinarily such situations arise from straitjacket agriculture and state grain purchasing, where private sector initiative is minimal and where there are no large grain storage facilities.

Under such conditions, we all risk finding ourselves forced to appeal to UN agencies to do something instead of undertaking reforms.

That would be for the simple reason that reform means altering this or that traditional structure or mode of privileges, which would be seen threatening to rock the dignity of key political actors. That must change.

YOUTH EMPOWERMENT

Access to sexual reproductive health and rights is key in promoting gender equality

EDUCATION and awareness on Sexual Reproductive Health and Rights (SRHR) is crucial for young people to ensure their health and wellbeing. Empowering youth with such education and access to comprehensive sexual and reproductive health services helps them make informed decisions concerning their bodies, relationships and future.

This includes access to information about sexually transmitted infections (STIs), and guidance on sexual health, which can prevent unintended pregnancies as well as reducing the spread of STIs.

Youth who have access to SRHR are likely to stay in school and pursue higher education, avoiding early pregnancy, for instance, can help young people complete their education and improve their economic prospects, thus breaking the poverty cycle.

Ensuring that both young women and men have equal access to SRHR is a key aspect of promoting gender equality. Investing in SRHR for youth lavs the foundation for healthier, more equitable and empowered societies.

In an effort to empower youth with knowledge on SRHR, Tanzania Men as Equal Partners in Development (TMEPiD) launched a special programme to educate young people from various districts across

The primary goal of the training programme is to enable youth to transfer the acquired knowledge to their fellow peers. When young people are well educated, they understand their rights and actively participate in decision-making processes related to reproductive health.

Youth involvement in decision making allows them to voice their needs to health governing committees and ultimately gain access to the services and the support they require.

Sabina Lister, a 25-year-old resident of Kigamboni in Temeke District, Dar es Salaam Region is one of 78 youth who have benefitted with the provided education. Other participants came from Shinyanga, Dodoma, Mara, Simiyu, and Zanzibar-both Pemba and Unguja Islands.

TMEPiD conducted the training under its Safeguard Young People (SYP) programme with funding from the United Nations Population Fund (UNFPA).

Among other things, participants were also educated on how to prevent themselves from being infected with HIV/Aids as well as avoiding early pregnancies. They were equipped with entrepreneurship skills and how they can access loans from banks and financial

According to Lister, the training has brought significant changes for youth in the District, as they now have the opportunity to participate in health governing committees and present their needs.

With the knowledge and skills gained from TMEPiD, beneficiaries have established an eight people group in Kigamboni District whereas they collaborate with medical officer to raise awareness about SRHR among their fellows. The education is offered at health facilities.

Through the group, youth get chances to discuss health issues, address challenges they encounter in their communities, and advocate for their rights.

She commended TMEPiD and UNFPA for initiating the programme, noting a significant increase in the number of youth visiting health facilities to obtain information on SRHR, access youth-friendly health services, and receive vaccinations.

"TMEPiD should think of expanding the programme to other districts with Dar es Salaam since there are many vouth who are unaware of SRHR, something which contributes to higher rates of teenage pregnancy, new HIV/Aids infections and other sexually transmitted diseases," said Lister.

Cuthbert Maendaenda, TMEPiD Director, told The Guardian that the training has been successfully implemented through SYP programme which is financially supported by UNFPA.

"We have chosen to focus on youth because most of them are unaware of their sexual and reproductive health rights," said Maendaenda, noting they are pleased with what has been achieved in all the regions. Youth representation in health facilities has now reached 30 percent.

He elaborated that under the programme, youth were trained on how to advocate for their rights, participate in decision-making processes-particularly within health facility governing committees-express their needs, and follow up on development initiatives within their communities.

Before this intervention, it was a challenge for youth to demand for their reproductive health rights, he told The Guardian, adding that in some regions, the number of male participation in reproductive health issues has also increased as men are visiting health facilities with their wives to get education on reproductive health services and family planning-something that was uncommon in the past.

Men are now game changers, they do no longer fear to test for HIV as they are comfortably visiting the Care and Treatment Centres (CTC) for HIV/Aids testing and counselling.

"The situation has now improved with more men

going for HIV testing," he added. TMEPiD introduced the programme to empower beneficiaries and allow them to share knowledge with their fellows. This has helped in ensuring they push for their health rights and prevent themselves from sexually transmitted diseases and early pregnancies.

He said youth are also capable of challenging harmful gender norms, thus reducing disparities in health outcomes. The education they have acquired helps them in preventing of Gender-Based Violence (GBV).

Education and awareness about SRHR can help prevent genderbased violence by promoting respect for individual rights and boundaries, and by providing resources and support for those who experience violence.

He said they are working closely with the government and UNFPA to ensure it increases its budget for reproductive health issues under the FP2030 commitment.

Under this commitment, UNFPA will provide \$2.6 million annually, with the government contributing 1 percent in each financial year to ensure successful implementation of the FP2030 commitments.

N August 12 each year the world marks International Youth Day. This is a platform through which the youth in various parts of the world can share their aspirations, innovations and collaboration towards achieving sustainable development and also the challenges facing them and how to address them.

This year's theme was "From Clicks to Progress: Youth Digital Pathways for Sustainable Development". The 21st century is referred to as the digital era, which is characterised by a fusion of technologies. These technologies have changed the way people think, behave, work and interact.

It is the era of a rapidly evolving world which needs new coping skills and competencies that are not taught at school, but are acquired through experience, training and practice. ILO in its World Employment and Social Outlook Trends 2024 report suggests that with emerging technologies like artificial intelligence (AI) labour market entry barriers for newcomers created by large digital monopolies have been significant obstacles to faster technological adoption, in particular in low-productive sectors and developing countries. This situation aggravates the incidence of unemployment and poverty.

The youth need to develop new coping skills and competencies such as critical and innovative thinking, complex problem-solving, the ability to collaborate, and socio-emotional skills (knowledge society skills) because they are crucial to the future labour market. These skills and others make a person not only employable, but also even if is not employed, he or she can create jobs and employ himself or herself.

Mahmud and Wong (2022) in their article titled "Stakeholder's Perspectives of the Twenty-First Century Skills" refer to knowledge society skills as 21st century skills, which they say include, but are not limited to, working independently, problem-solving, verbal communication, allocating time efficiently, and ability to function well in stressful situations. These skills and competencies are needed for the youth of the 21st century or of the digital era.


The authors say in the workplace, employees with these skills can collect, organise, and understand data as well as predict outcomes, experiment, summarise, and communicate the results. Nevertheless, they suggest, lack of these skills in a significant number of employees hinders economic development.

One of the areas complained about is how pupils and students are groomed for the future, that when they graduate find themselves unemployed because they lack employability (soft) skills as mentioned above or there is no room to employ them because due to operational reasons an organisation or company has only a lean team it can afford to employ and

Suarta et al. (2017) in their article titled "Employability skills required by the 21st century workplace: a literature review of labour market demand" suggest that: "The workforce in the 21st century not only requires graduates with high academic qualifications as represented by the subject and degree class, but also equipped with a number of skills and attributes. Employer surveys indicate that occupation-specific skills are no longer sufficient for graduates to meet the needs of national labour markets." Soft or employability skills are considered a missing link between education and training and the workplace and there is a need to maintain them through up skilling and reskilling to improve proficiency.

The SDG Digital Acceleration Agenda launched by International Telecommunication Union (ITU) and United Nations Development Programme (UNDP) in 2023 looks at digital technologies as "improving financial inclusion, increasing the effectiveness of government and public service delivery, and providing

people with platforms and channels to ensure their voices are heard." Thus, digitalisation is seen as transforming countries, communities, economies, and societies, and facilitating the attainment of Sustainable Development Goals (SDGs).

The youth in different parts of the world marked International Youth Day with hope and uncertainty. The hope the youth have is that it is them taking charge of things after seeing for many years that they haven't been moving in the right direction and they want to ensure that what they do makes a difference in their communities, countries and in their own lives. The uncertainty they have is how they are going to be absorbed into the labour market.

Emerging technologies create new opportunities and challenges. In this digital era, there are jobs which will be replaced with automation and others will be created and these will need new skills to do them. As some studies suggest, the problem with

it is not that people will not have jobs, but that they will lack skills needed to do the jobs created by emerging technologies.

In light of this, the youth will be better placed if they develop skills and competencies that will make them absorbed into the future labour market (also called the global digital economy). UNCTAD in a report entitled "2024 Digital Economy: Shaping an environmentally sustainable and inclusive digital future" says: "It is important to ensure that the human rights impacts and the unique challenges confronting women and girls, youth, indig-

the future labour market is that, enous peoples and other groups at risk of being left behind, are not overlooked. For instance, nearly 12.9 million women and many children work in the informal sector managing waste from digitalisation, which makes them significantly more likely to be exposed to potential negative consequences for their health.

> Thus, International Youth Day gives the youth food for thought on how they are going to cope with this rapidly changing world and remain relevant, while at the same time they are threatened by the unemployment challenge.

According to the ILO report, unemployment is expected to

rise modestly in 2024 as labour force participation rates decline and employment growth slows, while global unemployment will rise by 2 million, pushing the global unemployment rate from 5.1 per cent in 2023 to 5.2 per cent in 2024.

The global jobs gap, though improving, remained elevated in 2023, at about 435 million. In the circumstances, the youth's mind remains unsettled given future job uncertainties. Thus, this year's International Youth Day challenges youth to be more innovative to cope with the rapidly changing world and remain relevant to this digital era.

Green market boosts agricultural trade, social well-being in Namibia

WINDHOEK

ESTLED on a bustling street in Windhoek, Namibia's capital, the Green Market draws crowds every Saturday. This vibrant marketplace is more than just a gathering spot for friends and families; it also provides a crucial platform for farmers to sell their natural prod-

Established in 2004 by members of the Waldorf School to replicate the success of a similar market in South Africa, the Green Market has since become a dynamic hub for local entrepreneurship and a catalyst for agricultural trade.

Operating every Saturday, the Green Market offers a diverse range of natural farm produce, fashion, cultural items, arts, and both international and local cuisine. Its unique selling point is its consistent weekly operation, which distinguishes it from other markets.

Initially managed by a group of school parents, the market is now overseen by a team of five trustees. "We aim to promote further ecofriendly practices that have a positive impact on the environment," said Bettina Meierhofer, who has managed the market for the past seven years with the support of the trustee team.

The market has expanded significantly from its beginnings with just four stalls to over 40 vendors today. Stall fees start at 100 Namibian dollars (about 5.6 U.S. dollars), with costs varying based on the size of the stall and the nature of the business and products. In the past, the Green Market used to take a commission from the profits earned by exhibitors on Saturdays.

Occasionally, the market provides free trade space for startups

as part of the commitment to reinvest in the community and address market access gaps, said Meier-

Nearly 20 years on, exhibitors like Angela Iilonga, who specializes in textile and fashion design, have attributed business growth to the Green Market. Iilonga was one of the first four entrepreneurs to exhibit products at the Green Market in 2004.

"Before this, I struggled to find a suitable place to sell my products, including accessories and other wildlife-themed items," she said. "The market allowed me to reach my target clientele, including tourists. I never left," Iilonga

The market serves not only as a trading space. "It also serves as a platform for exchanging ideas, networking, and learning best practices from fellow vendors," she said.

In addition to its diverse range of products, the market also features a range of international cuisines and products, adding to its diversity, said Meierhofer.

To sustain and grow the market, the team employs robust marketing strategies on social media and other platforms to attract more exhibitors and visitors. They also apply strict criteria to ensure vendor products meet high standards and satisfy a growing clientele.

"We don't accept any products; we assess if it is within the standards, ensuring that their products meet the demand of a growing clientele," said Meierhofer.

Looking ahead, the Green Market envisions becoming even more eco-friendly, with plans to eliminate plastic use and increase opportunities for farmers and other

BOUT 68 million people in Southern Africa are suffering the effects of an El Nino-induced drought that has wiped out crops across the region, the regional bloc SADC

The drought, which started in early 2024, has hit crop and livestock production, causing food shortages and damaging the wider economies.

Heads of state from the 16-nation Southern African Development Community (SADC) were meeting in Zimbabwe's capital Harare to discuss regional issues including food security.

Some 68 million people, or 17% of the region's population, need aid, said Elias Magosi, SADC executive secretary.

"The 2024 rainy season has been a challenging one with most parts of the region experiencing negative effects of the El Nino phenomenon characterized by the late onset of rains," he said.

It is Southern Africa's worst drought in years, owing to a combination of naturally occurring El Nino – when an abnormal warming of the waters in the eastern Pacific changes world weather patterns – and higher average temperatures produced by greenhouse gas emissions.

Countries including Zimbabwe,



Africa seeks digital solutions for better revenue collection

AFRICAN governments have been trying to introduce new taxes – in part to pay off heavy foreign loans – amid economic headwinds that include rising global prices for food and energy.

In June, the Kenya government introduced Finance Bill 2024, which sought to collect more money from the public and businesses.

The move triggered weeks of angry protests that prompted President William Ruto to withdraw the bill and fire his cabinet.

On Monday, Kenya's outgoing finance minister, Njuguna Ndungu, said the government does not need to introduce new taxes.

"From this notion that high taxes will raise high tax revenue, the reality

is the opposite," Ndungu said. "... So, because high taxes cannot bring you high tax revenue, what do we need to do? We need to study how we can

optimize each tax instrument." One way is to improve collection rates on taxes already on the books.

One company, N-Soft, has helped the Democratic Republic of Congo, Sierra Leone, and several other nations supervise technological services and collect fees and taxes automatically.

N-Soft says that by setting up monitoring of the DRC's telecom sector, it improved tax collection in that field by 60%. Prakash Sabunani, the senior vice president and partner of N-Soft, said Africa is losing a lot of revenue in the digital space.

"Governments need to utilize digital tools. Digital tools are today the future. Everything today, as you can see, is converging toward AI. Mobile operators, mobile, telecom solution providers, device manufacturers, everybody is today focusing on AI," said Sabunani. "And that's where the new economy is actually targeting their new streams of income."

N-Soft is urging African governments and tax authorities to focus on collecting taxes from phones with SIM cards, pay TV services, online financial services, and the online gaming and betting industries.

By doing so, these governments could raise more money to fund their development goals. Sabunani said African countries need to improve the tax collection system so they can avoid burdening themselves with loans.

"We encourage local governments to look at their own inner space and their own economic space to first optimize that revenue before going out of their borders to claim money or to request for loans," said Sabunani. "They don't need to because if they were optimized in their data, in collecting their revenue and in optimizing their sources of collection, believe me, they

wouldn't need to borrow any money." McDonald Lewanika, the country director at Accountability Lab, an organization that promotes good governance for Africa, said "poor prioritization" of where resources are deployed are leading to "poor performance by governments" and "poor dividends for ordinary people." Why, he asked, should people have to pay debts "that we were not supposed to incur in the first place, in order for them to pay for corruption and bad governance at the end of the day?" At minimum, adopting digital tools to collect taxes may keep countries out of financial situations like Kenya's, and help them avoid the kind of protests that brought down President Ruto's cabinet.

ANZANIA is poised for a significant overhaul in its education sector with the introduction of a new public-private partnership (PPP) blueprint, recently announced by Prof Adolf Mkenda, Minister for Education, Science and Technology during a recent engagement with private sector stakeholders. Prof Mkenda underscored the blueprint's goal of enticing increased private investment into education.

This initiative is not merely about financial influx but it focuses on elevating educational standards and expanding access to quality services. By fostering a collaborative environment between public and private entities, the blueprint aims to tackle current challenges, enhance infrastructure, and drive innovative solutions, thereby ensuring a more effective and equitable education system for all Tanzanians.

Public-private partnerships have emerged as a critical strategy for governments worldwide seeking to leverage the expertise and efficiency of the private sector to deliver high-quality services.

These arrangements involve private entities taking on part of the service delivery responsibilities traditionally managed by the government, while also assuming the associated risks. Payments to the private sector can come from user fees, government budgets, or a combination of both.

The newly announced blueprint by the government seeks to address challenges faced by private investors in the education sector by providing a structured framework to guide investment.

Prof Mkenda highlighted that the plan's goal is to encourage private sector involvement in education, underlining that the blueprint will offer a detailed guide on how to achieve this objective. "It is the government's commitment to utilize private sector resources to enhance education. This document will guide how to achieve this goal," Mkenda asserted.

According to Prof Mkenda, the blueprint aims to address various challenges currently facing the education sector by ensuring that private investors can navigate issues such as tax regulations, fees, and other investment-related concerns. The plan is part of a broader policy document

prepared by the Ministry of Industry, Trade, and Investment, which has been instrumental in creating a framework to improve the business environment in Tanzania.

The new blueprint will mirror the successful models used in other countries, aiming to refine Tanzania's approach to education investment. Despite some advances, private education providers in Tanzania have faced significant hurdles, particularly concerning high taxation imposed by the Tanzania Revenue Authority (TRA).

The Tanzania Association of Owners and Directors of Government Schools and Colleges (TAMONGSCO)

has voiced its dissatisfaction with the tax regime, despite recent reductions in educational taxes by the government. The association argues that Section 64(8) of the Income Tax

Act stipulates that educational service providers should be exempt from certain taxes, given that some are not profit-oriented.

Currently, private schools are required to pay over ten different taxes, including property tax, land tax, corporate tax, value-added tax (VAT), local government taxes, work permits, and occupational health and safety regulations.

Stakeholders have reported that TRA has received complaints from private education investors and is working to address these issues, although the requirement for tax compliance remains.

Private school owners have also expressed frustration with the delays in issuing Tax Identification Numbers (TIN) and charitable status for

schools. TRA insists that TIN and charitable status are essential, treating schools as businesses subject to similar tax obligations.

Additionally, school owners are calling for the removal of work permit fees for teachers from East African Community (EAC) countries who already hold teaching licenses from any of the partner

If approved, the new blueprint promises to address these concerns effectively, according to the minister, who has directed the Permanent Secretary to expedite the processing of this crucial initiative.

The World Economic Forum defines PPPs as voluntary collaborations between various stakeholders from different sectors, working together towards a common goal or to fulfill a specific need involving shared responsibilities, resources, and capabilities.

Historically, it has been the government's responsibility to provide education across all age groups as mandated by law. However, various forms of PPPs have existed in the education sector, including government-assisted private schools.

For instance, in the 2006-07 period, a significant proportion of secondary and primary schools in various regions were managed by private institutions with substantial financial support from local governments.

A World Bank study titled 'Public and Private Secondary Education in Developing Countries' revealed that students in private schools achieved better academic outcomes compared to their public-school counterparts.

The study found that the cost per student in private schools was lower than in public schools, and private institutions had greater autonomy in decision-making and a stronger emphasis on student success.

PPPs in education can be implemented through three main areas: infrastructure provision, support services, and educational services. In infrastructure provision, a private partner constructs, owns, and operates facilities, which the government then utilizes under a long-term contract.

The private partner secures funding and is responsible for building and maintaining the infra-

the end of the contract, ownership often reverts to the government, though other models may retain private own-

The 'Building Schools for the Future' program in the UK is an example of a Private Finance Initiative (PFI) for constructing secondary school buildings. Under this scheme, private partners fund and build school facilities, maintaining them for a 30year contract period. Performance criteria are established to ensure the maintenance of these schools, with payments made quarterly based on performance.

In support services, a private partner provides specific services such as school meals, IT equipment, laboratories, gyms, and transportation. These services can be integrated with infrastructure or provided separately. The benefit is that a private partner with expertise in specific areas can deliver these services more efficiently and cost-effectively than if schools manage them independently.

For example, IT services are provided in many government schools in regions such as Tamil Nadu, Karnataka, and Andhra Pradesh, with private partners managing all equipment and service administration. Payments are made by government schools based on the availability of these services.


In the area of educational services, a private partner establishes and operates an entire school, including building classrooms, providing support services, and delivering educational services. The private partner has complete management control, including hiring teachers and staff.

The government sponsors student enrollment and pays fees per student based on performance criteria such as student and teacher attendance, teacher qualifications, infrastructure maintenance, student learning outcomes, and examination results.

Since 1981, Chile has implemented a voucher system allowing students to enroll in private schools, with the government paying monthly fees directly to these schools. There is a price variation between private schools depending on location and education quality. Families can choose their schools, although schools are not obligated to accept every student. Vouchers are paid directly to the schools.

Public-private partnerships offer a transformative opportunity to revitalize the education sector by harnessing the expertise and efficiency of private institutions. This innovative approach is set to revolutionize educational delivery and related services, paving the way for significant improvements and driving substantial positive change.

By learning from successful global models, Tanzania is on the verge of a major overhaul in its approach to private investment in education. The new blueprint aims to create a more favorable investment climate, boost educational outcomes, and ensure a more robust and dynamic education system. This strategic shift promises to benefit students, educators, and all stakeholders, marking a pivotal advancement toward a more effective

NFRA inaugurates state-of-the-art silo complex in Babati

The National Food Reserve Agency (NFRA) has inaugurated a state-of-theart silo complex in Babati district, Manyara region, aimed at enhancing the processing and storage of various crops produced across Tanzania.

This ultramodern facility, valued at 18bn/-, focuses on crops such as maize, sunflower, barley, soybeans, and sorghum.

The new complex has attracted a significant number of customers, including crop traders from neighboring countries like Uganda and Burundi, drawn by its advanced technology and efficiency.

According to Efraim January, head of the complex, the facility offers cloudconnected quality assurance systems that set it apart from other processing centers.

"Our computerized complex provides fast services, capable of processing a 30-ton truck of maize grains within just 30 to 40 minutes," Eng. January revealed in an exclusive interview during a special tour of the project.

The facility is equipped with a range of digital equipment designed for various stages of crop processing. These include machines for grain sampling, cleaners, dryers, as well as packaging

and storage facilities. Ianuary emphasized the complex's commitment to ensuring that crops are processed to meet both local and inter-

Discussing the maize grain cleaning process, which is a major activity at the center, Eng. January explained that the facility uses a modern automated system to remove fine dust, threads, and broken grains. The refined maize is then packed and stored under optimal moisture conditions of 13.5 percent.

"Our vision is to deliver processed and packaged crops to consumers in the best possible condition, adhering to recommended health standards," he

January also highlighted NFRA's broader mission, which involves purchasing surplus crops from farmers at' fair prices and storing them professionally to ensure national food security.

The Babati-based complex features eight modern silos, each with a storage capacity of 3,425 tonnes, bringing the total storage capacity to approximately 27,400 tonnes.

The facility also includes five centers dedicated to the professional procurement of maize grains from local farmers, with NFRA purchasing based on government-recommended standards.

NFRA currently operates 72 purchasing points across eight regions: Dodoma, Dar es Salaam (Kipawa), Njombe (Makambako), Songwe, Rukwa (Sumbawanga), Arusha (Babati), Shinyanga, and Songea. The agency's purchasing strategy includes buying from farmers, large-scale traders, and cooperative so-

Tanzania's current account deficit decreases by 49.5 pc

anzania's curaccount deficit sharply decreased half, falling to US\$2.5 billion in the year ending June 2024, down from US\$4.96 billion recorded during the same period in 2023, making it the lowest deficit recorded since July 2023.

According to Bank of Tanzania's monthly economic review for July, the improvement resulted from substantial increase of exports of goods and services, driven by gold and tourism sector, as well as decline of goods im-

Exports of goods and services grew by 14.9 percent, reaching US\$14.68 billion during the year ending June 2024.

This growth was fueled by higher earnings from tourism, gold exports, and increased sales of traditional and horticultural products.

"The improvement in

the external sector was driven by the global economy's recovery from previous shocks, enhanced export performance, and effective import management amidst favorable global commodity prices," said the central bank review. Traditional exports surged by 41.8 percent to US\$1.07 billion, thanks to higher volumes of cashew nuts, cotton, and coffee, despite some price fluc-

Tobacco exports saw a remarkable 140 percent increase during the year, driven by both higher vol-

tuations.

umes and prices.

Exports earnings from tobacco reached the historical high of US\$438.5 million, which accounted for nearly 44 percent of total earnings from traditional exports.

Additionally, prices for agricultural commodities such as coffee, palm oil, sugar, rice, and tea rose during this period, with coffee prices particularly benefiting from strong demand and lower harvests due to adverse weather conditions.

Non-traditional exports also improved, rising particularly from freight

to US\$6.37 billion from US\$6.20 billion in the previous year.

This increase was largely attributed to gold, which made up 49 percent of non-traditional exports, as well as horticultural products, fish and fish products, and oil seeds.

Exports earnings from gold amounted to US\$3.1billion, from US\$2.6 billion recorded during the year ended in June

Notably, horticultural exports increased to US\$415.4 million, up from US\$294.1 million the year before, driven by higher vegetable exports. Oil seed exports grew by 26.4 percent, reaching USD 295.3 million by June 2024.

Service receipts totaled US\$6.81 billion in the year ending June 2024, a 25.5 percent increase from the previous year. This rise was mainly due to travel receipts, which accounted for 53.5 percent of total service income, followed by transport services,

charges

The improvement in service receipts was closely linked to an increase in tourist arrivals, which rose to 1.99 million in June 2024, up from 1.64 million in June 2023.

On the import side, Tanzania's imports of goods and services fell to US\$16.03 billion in the year ending June 2024, down from US\$16.98 billion the previous year.

This reduction was mainly due to lower global commodity prices and reduced freight costs.

Service payments also decreased by 11.5 percent to US\$2.24 billion, with lower freight costs for imported goods accounting for 53.2 percent of total service payments.

Meanwhile, foreign exchange reserves strengthened to US\$5.35 billion by the end of June 2024, sufficient to cover 4.4 months of projected imports of goods and services, meeting both national and East African Community (EAC) benchmarks.

Tanzania urges India to strengthen trade and investment ties

Tanzania has called on the Indian government to continue enhancing trade relations between the two nations to further business connections, increase foreign currency inflows, and expand investment opportunities.

Dr. Damas Ndumbaro, Tanzania's Minister of Culture, Arts, and Sports, made this appeal last Thursday while addressing ambassadors, heads of international organizations, members of the diplomatic corps, the Indian diaspora, and government officials at the 78th Independence Day reception held at the Swami Vivekananda Cultural Centre (SVCC).

Dr. Ndumbaro emphasized that India remains a crucial trading partner for Tanzania, with bilateral trade volumes significantly increasing from US\$1.6 billion in 2020 to US\$3.1 billion in 2023.

This growth solidifies India's position as Tanzania's largest export

In addition to trade, India has become one of the top three sources of foreign direct investment in Tanzania and ranks among the top five investment sources overall. These investments have created 600 jobs and are valued at US\$3.7 billion.

Dr. Ndumbaro also expressed gratitude for India's longstanding

cultural and sports partnerships with Tanzania. He urged Indian ambassadors to further support collaborations between Tanzanian and Indian health institutions, particularly between the Indian Institute of Medical Science and Muhimbili University of Health and Allied Sciences. He also commended India's ongoing assistance in the water and education sectors.

In 2022, six Indian companies signed an agreement to undertake a water development project in Tanzania valued at US\$5 billion. Once completed, this project is expected to provide clean water access to over 4 million Tanzanians, a significant improvement in the quality of life.

India's High Commissioner to Tanzania, Bishwadip Dey, highlighted the progress in bilateral relations, which were elevated to a Strategic Partnership during President Samia Suluhu Hassan's state visit to India in October 2023. Since then, four high-level Tanzanian delegations have visited India, further solidifying ties.

According to Dey, bilateral trade reached US\$7.9 billion in 2023, making Tanzania India's secondlargest trading partner in Africa. This success underscores the collaborative efforts of both govern-

In addition to trade, India and Tanzania have deepened their defense cooperation. This year,

three Indian naval ships visited Tanzania and participated in joint maritime exercises with the Tanzanian Navy, as well as the second India-Mozambique-Tanzania trilateral naval exercise.

India continues to share its expertise with Tanzania through the Indian Council for Cultural Relations (ICCR) and Indian Technical and Economic Cooperation (ITEC) programs.

Reflecting on India's 78th Independence Day, Dey remarked on India's progress since gaining independence on August 15, 1947.

Today, India is the world's fifthlargest economy and one of the fastest-growing. Under Prime Minister Narendra Modi's leadership, India aims to become a developed

nation by 2047, striving for selfsufficiency and independence in all sectors.

India has also made significant strides in renewable energy, ranking fourth globally in installed capacity, with a goal of achieving 500 GW of non-fossil fuel-based energy by 2030.

Additionally, India boasts the world's third-largest startup ecosystem, substantial advancements in healthcare and pharmaceuticals, and leadership in real-time digital payment systems.

Dey praised Tanzania for its stunning landscapes, rich culture, and warm hospitality, noting that the country has recently become a favored destination for Indian celebrities.

He expressed excitement about his new role as High Commissioner, having arrived in Tanzania two weeks ago, and emphasized the importance of engaging with the Indian diaspora, one of the largest

As part of his mission, Dey plans to visit various regions across Tanzania to strengthen ties with local communities.

The Indian High Commission intends to organize six consular camps annually in different regions, beginning with Tanga in September, followed by Mbeya in November, Arusha in January 2025, Mwanza in March, Dodoma in May, Morogoro in July, and Shinyanga in September 2025.

Dangote refinery set to disrupt European fuel markets

The Nigerian oil industry has had a roller coaster of a year. In January, Shell announced that it would be exiting the West African nation's onshore oil industry after nearly a century of operations as a result of unstable and unsavory operational

British supermajor Shell is just the latest western company to pull out of Nigeria's oil industry, which now finds itself in rapid decline.

At the same time, however, Nigeria is getting ready to open up one of the world's largest oil refineries with the potential to be a major player in global oil markets.

Nigeria's oil sector has been plagued with troubles for years now, pushing major oil interests to pull out of the oil rich nation.

According to reporting from the US News & World Report, Shell's

decision to sell off its Nigerian subsidiary for \$2.4 billion was due to the fact that the company "has struggled for years with hundreds of onshore oil spills as a result of theft, sabotage and operational issues that led to costly repairs and high-profile lawsuits."

Shell's decision to pull out of Nigeria comes on the heels of similar decisions from Houston-based Exxon Mobil, Italy's Eni and Norway's Equi-

In the wake of the West's exodus from the Nigerian oil sector, the industry remains in a state of heightened flux and uncertainty.

The country's energy landscape, which includes the 11th largest proven oil reserves in the world (just behind the United States), "has grappled with poor governance, weak institutions, deteriorating security conditions, spiraling economic decline, and uninspired leadership"



according to an analysis from the Center for Strategic & International

The weakening of Nigeria's oil production capacity also comes at a time that the nation is preparing to bring the massive Dangote refinery online.

Once the plant is up and running

at full capacity, Dangote will be able to process 650,000 barrels of crude oil a day, making it competitive with the United States' largest refineries and over 50 percent bigger than the largest refinery in Europe.

This spells trouble for the feedstock of the refinery, as the plant's backers had intended for the plant to

refine domestically produced crude in order to bolster the heavily oil-dependent local economy, which has been marked by crisis and severe hardship in the recent term. Shell's recent exit from the market will make the country's goals of reversing its declining production rates particularly difficult to achieve. In the meantime, Dangote has looked to foreign markets to buy the crude it needs to fill demand, but sufficient supplies for the massive operation have proven hard to come by.

Despite these struggles, the sheer scale of Dangote will nonetheless turn Nigeria into an "oil market juggernaut" according to a recent Bloomberg headline.

While the plant is not yet fully operational, it's already making waves in global markets. "During the past few weeks, actions by the country's massive Dangote refinery have moved prices," the Bloomberg report detailed, "with purchases of US barrels initially boosting the crude futures curve before a decision to sell them sent oil tumbling."

Aliko Dangote, the billionaire Nigerian businessman who has spearheaded the refinery's construction and development, has said that the plant will start producing gasoline this month. Other experts say that September is more likely.

In either case, it's going to cause a splash in a tight oil market. "Once the site starts churning out gasoline, it will transform fuel markets in the region and upend long-established trade flows, particularly in Europe, where Nigeria currently purchases much of its supplies," Bloomberg went on to report.

What's more, Europe will now have to compete with Nigeria to buy crude oil on a very tight global market, indicating significant disruption

Board invites local investors into sisal processing

he Tanzania Sisal Board (TSB) has called on local investors to install decorticator machines in Korogwe sisal plantations owned by Agriculture Marketing Cooperatives Societies (AMCOS).

This invitation comes in response to concerns raised by small-scale sisal growers, who have found it costly to transport their harvested sisal to processing facilities at Hale and Magunga farms in Korogwe district.

TSB's board chairman, Theobald Sabi, visited the farms to witness the challenges firsthand. He discovered that many of the existing decorticator machines were nonfunctional due to old age.

Following the tour, Sabi emphasized that inviting private investors into the sisal sector would not only improve efficiency but also boost the processing

"The private sector plays a key role in local capacity building, technological upgrading, and investment promotion. Our decision aims to provide a permanent solution that will allow farmers to enjoy their work without worrying about the shortage of sisal processing factories," Sabi said.

He assured that the board would take urgent steps to ensure that all activities related to the sisal value chain proceed smoothly, contributing to increased productivity for farmers, the board, the country's economy, and the Gross Domestic Product (GDP) at large.

TSB Director General, Saddy Kambona, explained that the purpose of the visit was to build capacity and raise awareness about the entire sisal production value chain, from planting and processing to marketing. The visit also aimed to address the challenges facing smallholder farmers and find solutions to improve the sisal agriculture sub-sector.

Kambona noted that the decorticator machines installed by private investors at Hale and Magunga Amcos farms have greatly helped farmers process their sisal leaves.

In contrast, machines owned by Sisalana are outdated and not functioning well, leading to significant losses as many fibers end up as waste.

TSB board member, Naweed Mullah, expressed gratitude for the tour, noting the positive developments in the sector and calling on the board to provide better services to farmers at affordable prices.

He highlighted the need for more processing factories, given that sisal was recently reintroduced as one of the country's five strategic cash crops.

Shedrack Lugendo, Chairper-

son of the Magunga Agriculture Marketing Cooperative Society and representative of all five Korogwe Amcos farms, thanked the board for their visit.

He urged the board to prioritize installing new decorticator machines instead of repairing the outdated ones owned by Sisalana, which have proven inef-

"We are hopeful that your visit will lead to positive changes. Many Amcos have requested investment in processing factories with new technology decorticator machines, and your approval will be a significant step towards supporting smallholder farmers," Lugendo said.

The Union of Korogwe Amcos operates five sisal plantations-Hale, Magoma, Magunga, Mwelya, and Ngombezi-which involve 7,551 registered small-scale farmers.

According to the TSB database, these farmers currently contribute to the production of about 36,000 tonnes of sisal fiber annually.

TSB aims to increase sisal fiber production to 120,000 tonnes annually by 2025. Data from the Ministry of Industry and Trade shows that sisal fiber was the leading product Tanzania exported to the African Continental Free Trade Area (AfCFTA) over the past year, with 426.4 tonnes sold to Nigeria, Ghana, Morocco, and Egypt.

Tanga Region gets 97.9bn/- for construction of health facilities

Tanga region has received a total of 97.9bn/- for the construction of health facilities including hospitals, health centers, and dispensaries.

This was said by the Regional Commissioner, Ambassador Batilda Burian, during the opening of Mama Samia Eye Clinic, which provides eye care services for two days in Muheza District, sponsored by the non-governmental organization Mo Dewji

"As a region, we have received 97.9bn/solely for the health sector. We have managed to build 72 dispensaries, more than 23 health centers, six new hospitals, renovate three district hospitals, and make other improvements," said Dr Burian.

The coordinator of eye care services from the Mo Dewji Foundation, Amina Ramadhan, said that in one day, they managed to register 1,800 citizens with eye problems. Over the three days they will be providing services, the number will surpass that, and they will

She said that the Muheza camp is the seventh this year, and a total of 26,000 citizens have received services in camps held in various areas, with the activities continuing every month. A total of 1,800 citizens have undergone cataract surgery in the seven camps that have been held.

Young people unemployment in China jumps to 17.1pc in July

Youth unemployment in China ticked up to 17.1 percent in July, official figures showed, the highest level this year as the world's second-largest economy faces mounting headwinds.

China is battling soaring joblessness among young people, a heavily indebted property sector and intensifying trade issues with the West.

Chinese Premier Li Qiang, who is responsible for economic policy, called Friday for struggling companies to be "heard" and "their difficulties truly addressed," according to the state news agency Xinhua.

The unemployment rate among 16- to 24-year-olds released Friday by the National Bureau of Statistics (NBS) was up markedly from June's 13.2 percent.

The closely watched metric peaked at 21.3 percent in June of 2023, before authorities suspended publication of the figures and later changed their methodology to exclude students.

Nearly 12 million students graduated from Chinese universities this June, heightening competition in an already tough job market and likely explaining July's sharp increase in joblessness.

In May, President Xi Jinping said countering youth unemployment must be regarded as a "top priority."

Among 25- to 29-year-olds, the unemployment rate stood at 6.5 percent for July, up from the previous month's 6.4 percent.

For China's workforce, the national unemployment rate was 5.2 percent.

However, the NBS figures paint an incomplete picture of China's overall employment situation, as they take only urban areas into account.

The new unemployment figures come on the heels of other disappointing economic data from Beijing, including figures showing dampened industrial production, despite recent government measures aimed at boosting growth.

Industrial production growth weakened in July, with the month's 5.1 percent expansion down from June's 5.3 percent and falling short of analysts' predictions.

China's major cities also recorded another decline in real estate prices last month, a sign of sluggish demand. Demand for bank loans also contracted for the first time in nearly 20 years, according to official figures published earlier this week.

International challenges are also mounting, with the European Union and the United States increasingly imposing trade barriers to protect their markets from low-cost Chinese products and perceived unfair compe-



Leaf tobacco merchant plants 1.06m trees in Nzega

The tobacco leaf merchant, Alliance One Tobacco Tanzania Limited (AOTL), has planted 1,062,500 trees in the Ngukumo tree farm project in Nzega district, Tabora region, at the cost of 980m/-.

The company's forest controller, Rashid Salum, revealed this in his brief address to the visiting Uhuru Torch delegation at the forest planted for the purpose of various uses by the surrounding tobacco farmers, including tobacco cur-

He said that the move was a continuation of the company's strategy to plant trees in various tobacco growing areas.

The initiative started by a joint forest management programme in Kasulu, Kigoma region in 2014, where millions of trees were planted in 450 hectares area.

"After seeing that Tabora region, where we source most of our tobacco has a big problem of forest destruction, due to the felling of trees for curing tobacco, charcoal and firewood, we decided to look for land in Nzega district council and they gave us this land, which totals 469 hectares and we have planted trees in five different blocks," said Salum.

He said the company entered into a memorandum of understanding with Nzega District Council to start a tree planting project, with the 80 by 20 percent ownership arrangement, with the company owning a majority.

He said the project officially began in December 2022/23 by land clearance, digging holes as well as planting Mfudu-

fudu trees commonly called Thite Teak, which are fast growing tree species that normally take up to seven years to ma-

He said the company had three tree planting programs, the first one being to encourage tobacco farmers themselves to plant trees in their surrounding in-

cluding homes. The trees are for use for curing their tobacco leaves, instead of cutting down natural grown trees, which by and large have greatly contributed to the destruc-

tion of some forests. He named the second program as a communal commercial tree planting, whereby, the company assists the farmers with tree planting with at least 40 percent, and then the farmers are free to use the trees when matured for various uses including curing of tobacco leaves.

"The third program is like this one here and we call it a joint forest mmanagement, in which the AOTL establishes a farm and plants trees like this forest here at Ngukumo in Nzega district, and upon maturity we allow the communities to

use it sustainably," he elaborated. The leader of the uhuru torch delegation this year, Godfrey Mnzava, said the sustainability of tobacco farming should go hand in hand with tree planting.

"The Uhuru torch sends this message

to all tobacco companies in the country that from now onwards, they should emulate Alliance One on their very special initiative in restoring the green on our planet earth," he noted. He also urged the tobacco farmers and non-tobacco farmers in the country to

continue planting trees as well as contribute effectively to the protection of the existing forests by not destroying them with their human activities. On his part, the representative of the Executive Director of Nzega District Council, the Nkiniziwa Ward Executive Officer, Maria Katema said the introduc-

tion of the tree farm at their area will greatly restore the forest cover which was destroyed by human activities in the Katema said that the land given to

AOTL to plant trees was once a large forest, but was slowly destroyed by human activities, including making charcoal, wood for curing tobacco, farming as well as animals grazing.

"The project has brought good news alongside it, including employment to more than 300 people from different areas of the ward," said Katema

A villager, Joseph Mshine congratulated the the company for establishing a forest farm in their area, which had lost natural vegetation due to environmental damage while urging his fellow residents not to bring livestock into the young

Global Uranium prices remain under pressure

Uranium prices have been under pressure recently, trading within a narrow range and slightly lower due to limited trading volume and liquidity.

However, as per analysts at Citi Research in a note dated Monday, this weakness in uranium prices is expected to subside as demand for nuclear energy continues to rise, while supply struggles to keep pace.

Analysts at Citi remain tactically bullish on uranium in the near to midterm, with projections indicating a potential price rebound to \$98/lb later this year.

Citi has adjusted its uranium price forecasts in response to the recent market softness. The analysts now expect uranium prices to average \$94/lb in 2024, with potential upside momentum during the third and fourth quar-

Looking further ahead, Citi forecasts uranium prices to average \$110/lb in 2025, reflecting continued bullish sentiment driven by the increasing demand for nuclear energy.

Uranium production has seen a significant increase in 2023, rising by over 10 percent or 14 million pounds.

This growth has been primarily driven by the expansion of existing mines, with Kazakhstan playing a

key role. production Kazakh has been slightly revised upwards, with an expected output of 59 million pounds this year, as issues with sulfuric acid are anticipated to be resolved. In Canada, the Cigar Lake and McArthur River mines are showing improved performance and are like-

ly to reach their produc-

tion plateau this year.

Cyril Ramaphosa signs electricity regulation amendments into law

President Cyril Ramaphosa (pictured), has signed into law the much-anticipated Electricity Regulation Amendment (ERA) Act, which lays the legislative foundations for the establishment of a fully independent Transmission System Operator (TSO) in the coming five

The ERA Bill was approved by lawmakers ahead of the May 29 elections and the President's assent on August 16 has come amid some concern about the constitutionality of provisions that could affect the authority that municipalities currently have over electricity distribution. Nevertheless, the reforms included in the Act, which amends the Electricity Regulation Act of 2006, are otherwise broadly supported by stakeholders, including organised business.

These stakeholders argued that the legislative changes are urgent to level the playing field between Eskom and independent power producers, as well as to align the electricity supply industry with the unfolding energy transi-

Significantly, the new Act provides for the establishment, duties, powers and functions of a Stateowned TSO, which must be established as an independent entity within five


It also requires the development of a market code that will establish rules to govern the future competitive market, and outlines the process through which the code will be approved.

The legislation also provides for market operation as a new activity that may be licensed by the National Energy Regulator of South Africa (Nersa).

"To ensure a level playing field for competition between multiple electricity generators, the Act provides that the system operator shall not discriminate between different generators or customers in relation to dispatching or balancing the system, except for objectively justifiable and identifiable reasons approved by the regulator.

"Access to the transmission and distribution power system must be objective, transparent and non-discriminatory," the Presidency highlighted in a statement confirming that the ERA had indeed been signed.

The Act states that the National Transmission Company of South Africa, which began trading as a separate Eskom Holdings subsidiary on July 1, will act as the TSO in the interim.

Trump says Harris easier than Biden to beat as race for Pennsylvania heats up

WILKES-BARRE

REPUBLICAN presidential candidate Donald Trump said on Saturday he believed Democrat Kamala Harris will be easier to beat than President Joe Biden even as some polls showed her edging ahead in the race for the Nov 5 presidential election.

Trump, the former president, spoke at a rally in Wilkes-Barre in northeastern Pennsylvania, a state looming large in the campaign. Vice-President Harris will conduct a bus tour of western Pennsylvania starting in Pittsburgh on Sunday, ahead of the kickoff of the Democratic National Convention on Monday in Chicago.

"I believe she will be easier to beat than him," said Trump, referring to her as "radical" and a "lunatic."

Trump has sought to portray Harris as far left on a number of policies. At the rally, he highlighted her previous call for a ban on fracking, an industry important to the state. Harris' campaign has recently indicated she would not support a ban.

He also continued to attack Harris on personal terms, even as some political analysts say such comments could hurt Trump with moderate voters.

"Have you heard her laugh? That is the laugh of a crazy person," Trump said, adding that he was displeased by the illustration of Harris on the cover of the latest issue of Time magazine. "I'm much better looking than her."

nuch better looking than her."
In a meandering speech, Trump re-

peated his false claim that he lost the 2020 election due to fraud, dismissed the threat of climate change and said his plan to impose across-the-board tariffs on foreign goods would not act as a tax on US consumers, an assertion that most economists contest.

The Mohegan Sun Arena, where Trump appeared, has a capacity of roughly 8,000 and was nearly full when he started speaking. But the crowd began to thin after the one-hour mark. He spoke for more than 100 minutes in total

Trump said Harris should have done more to tackle inflation and other issues since she and Biden took office. If reelected he said he would sign an executive order directing cabinet secretaries and agency heads to take action to lower prices.

"Another rally, same old show," Joseph Costello, a spokesperson for the Harris campaign, said in a statement responding to Trump's rally speech, which he described as filled with "lies, name-calling, and confused rants."

Pennsylvania was one of three Rust Belt states, along with Wisconsin and Michigan, that helped power Trump's upset victory in 2016. Biden, who grew up in Scranton, Pennsylvania, flipped the trio back to the Democrats in 2020.

With 19 electoral votes out of the 270 needed to secure the White House, compared with 15 in Michigan and 10 in Wisconsin, Pennsylvania may be the biggest prize in this year's election and potentially tip the balance for either

candidate.

Harris' entry into the race after Biden ended his reelection bid last month has upended the contest, erasing the lead Trump built in the final weeks of Biden's campaign. Harris is leading Trump by more than two percentage points in Pennsylvania, according to the poll tracking website FiveThirtyEight.

Blanketing airwaves with ads

Trump won Pennsylvania in 2016 by about 44,000 votes, a margin of less than one percentage point, while Biden prevailed by just over 80,000 votes in 2020, a 1.2-point margin.

Both campaigns have made the state a top priority, blanketing the airwaves with advertisements. Of the more than \$110 million spent on advertising in seven battleground states since Biden dropped out in late July, roughly \$42 million was in Pennsylvania, more than twice any other state, the Wall Street Journal reported on Friday, citing data from the tracking site AdImpact.

Democratic and Republican groups have already reserved \$114 million in ad time in Pennsylvania from late August through the election, more than twice as much as the \$55 million reserved in Arizona, the next highest total, according to AdImpact.

The Harris campaign said on Saturday it planned to spend at least \$370 million on digital and television ads nationwide between the Labor Day holiday on Sept 2 and Election Day.

The battleground states - seen as critical for winning the election - also include Arizona, North Carolina, Nevada and Georgia.

New polls published on Saturday by the New York Times found Harris leading Trump among likely voters in Arizona, 50 percent to 45 percent, and in North Carolina, 49 percent to 47 percent, and narrowing the former president's leads in Nevada, 47 percent to 49 percent, and in Georgia, 46 percent to 50 percent. A pollster from the Trump campaign said the poll results underestimated the Republican candidate's support.

Trump will give remarks on the economy at a campaign event in York, Pennsylvania, on Monday. His running mate, US Senator JD Vance, will hold an event in Philadelphia that day as well.

Trump's trip to Wilkes-Barre in Luzerne County was aimed at solidifying support among the white, non-college-educated voters who lifted him to victory in 2016. The blue-collar county voted Democratic for decades before swinging heavily toward Trump in 2016, mirroring other similar regions around the country.

Harris and her running mate, Minnesota Governor Tim Walz, will make multiple stops across Allegheny and Beaver counties on Sunday, the campaign said. The tour is the first time Harris, Walz and their spouses have campaigned together since their first rally as a presidential ticket in Philadelphia earlier this month.

US authorities have embarked on path of total censorship – ambassador Antonov

WASHINGTON

THE US authorities have definitively embarked on the path of total censorship, persecuting all over the country those who allegedly work for the Russian government, Russian Ambassador to the US Anatoly Antonov said commenting on the search of the home of American political scientist and Chan



political scientist and Channel One host Dmitry Simes in Virginia.

According to the diplomat (pictured), "the US authorities' raids on the Channel One host are one of many facts of the "witch hunt" unfolding here with renewed vigor.

"All this is going amid the presidential election campaign. All over the country, there is a persecution of those who allegedly work for the Russian government in violation of the law on foreign agents," Antonov said as quoted by the press service of the Russian diplomatic mission.

"Local ruling circles have definitively embarked on the path of total censorship. Freedom of speech in the modern United States is sacred only if this word is pro-American

All dissenters are subject to political inquisition, especially when it concerns those who fight against the imposition of one-sided and biased views on Russia," the diplomat stressed, noting that the Russian embassy "is concerned about what is happening."

According to Antonov, Washington "is steeped in double standards in the area of democracy and freedom of speech."

"Hundreds of people are declared undesirable simply because they dare to contradict the administration's policies. They are forbidden to have their own point of view. Breaking into homes, searches, confiscation of documents - this is a short list of the actions of the American special services," the diplomat went on.

According to him, the American authorities "easily violate their own canons, provided for by the First Amendment" to the American Constitution, "reprising dissent has become the norm."

"In the meantime, officials continue to lecture the entire world on democratic values and human rights," the ambassador stressed. According to him, all this "is reminiscent of the dark times of McCarthyism."

Antonov stressed that he personally knows Simes "as a talented political scientist with deep knowledge of the US political system, domestic and foreign policy of the state."

"I used to be a guest at the NGO "Center for the National Interest" headed by him. There I argued about the fate of Russian-American relations. All this was part of civilized discussions with a respectful attitude to the opinion of the opponent," the head of the Russian diplomatic mission said.

Search in Simes house

Earlier, the Federal Bureau of Investigation confirmed raiding a US house of American political scientist Dimitri Simes in Virginia.

Simes told TASS that he had not been officially notified of the FBI search, which was conducted on August 13.

The Department of State has not yet responded to a TASS correspondent's request for comment on the incident

Political scientist, historian and TV presenter Simes was born in 1947 in Moscow. In 1973 he emigrated to the United States. Last year, he moderated a plenary session with Russian President Vladimir Putin at the St. Petersburg International Economic Forum, and in June he participated in a closed meeting with the head of state after his speech at the Foreign Ministry.

China implements strict monkeypox protocols amid rising global cases

BEIJING


CHINESE authorities have intensified efforts to prevent the import of the mpox virus as global cases continue to rise.

Effective from Aug 15 for six months, arrivals in China from countries and regions with confirmed mpox infections must declare their condition to customs if they have been exposed to mpox or exhibit symptoms such as fever, headache, back pain, muscle pain, swollen lymph nodes, or rashes.

For such individuals, customs officers will implement medical measures and conduct sampling and mpox testing, according to China's General Administration of Customs.

Vehicles, containers, cargo and other items from countries and regions with reported mpox cases will be sanitized if they are contaminated or potentially contaminated.

The National Disease Control and Prevention Administration and the National Health Commission have urged their local branches to strengthen col-

laboration and information sharing with customs and other relevant authorities to promptly detect and handle mpox cases.

The mpox virus is transmitted mainly through close physical contact, particularly during sexual activity, while daily contact poses a lower risk, according to the Chinese Center for Disease Control and Prevention.

Those who have been exposed to mpox or experience symptoms should seek medical attention immediately, said Li Tongzeng, an infectious disease specialist at Beijing Youan Hospital.

Earlier this week, the World Health Organization (WHO) declared mpox a public health emergency of international concern, activating its highest level of global alert for mpox for the second time in two years.

"This is something that should concern us all ... The potential for further spread within Africa and beyond is very worrying," said WHO Director-General Tedros Adhanom Ghebreye-

US business leader says latest CPC plenum sends positive signals on China's economic growth

WASHINGTON

A U.S. business leader welcomed the economic policies from the third plenary session of the 20th Central Committee of the Communist Party of China (CPC), noting that these measures will help expand domestic market demand, improve market exit mechanisms and promote technological innovation and green development.

"I am excited by the recent third plenum ... It appears that macroeconomic policy is headed in the right direction," Craig Allen (pictured), president of the U.S.-China Business Council (USCBC), told Xinhua in a recent interview in Washington D.C..

He applauded the measures introduced at the plenum

aimed at boosting consumption and expanding domestic demand, viewing these practical measures as a positive signal that the Chinese government is moving in the right direction.

Regarding the "overcapacity" issue alledged by the West, the U.S. business leader said that China's manufacturing exports are currently thriving, with banks significantly increasing loans to manufacturers and substantially reducing loans to the real estate sector, but meanwhile Chinese manufacturers are facing challenges such as low profitability and low capacity utilization.

Allen added he is very pleased to see that the plenum discussed revising the bankruptcy law, which can help poorly performing companies exit the market through bankruptcy, benefiting the overall development of China's economy.

He also took notice of the strong emphasis on technology and innovation at the plenum. As China's research and development (R&D) investment already accounts for 2.6 percent of its GDP, he expected this percentage to increase significantly, which he said is significant for U.S. businesses.

"There was an emphasis on innovation and the green economy. And both of those are useful and important focal points for the American economy, for American companies, and we can contribute to both," said Allen.

Currently, the USCBC has



over 200 American member companies doing business in China. Allen told Xinhua that these U.S. companies are very eager to continue strengthening cooperation with China in areas such as climate change, health care, tourism, education, finance, and entertainment

Taking health care as an example, Allen said that as

China's population ages, its people become wealthier, and private health insurance plans become more popular, U.S. companies are excited about the opportunities for collaboration with China in the sector.

There was further discussion on a unified national market and issues of provincial protectionism at the plenum, he said. "We strongly support that, as it will lead to yet more opportunities for strong Chinese companies as well as foreign companies."

"We are pleased that the government is heading in that direction," he added.

Allen also pointed to the measures outlined in the document released after the plenum to strengthen intellectual property protection, improve

standardization processes, and ensure fair treatment for foreign enterprises in government procurement, saying that the implementation of these measures will benefit everyone including American companies. "I think that there's much to be positive about over the medium and the longer term," and that cyclical issues unfolding now are being addressed by the Chinese government, said Allen.

The U.S. business leader observed many "really exciting" growth areas in the Chinese market, which U.S. companies are pleased to explore with their Chinese partners across various sectors.

He mentioned that the US-CBC's member companies are confident in the long-term development of the Chinese market and have made substantial investments in China, hoping to contribute to its long-term economic growth.

"We're bullish about the future. We want to be a good partner to our Chinese corporate partners and to Chinese consumers," said Allen.

"We're in China for the long term. We're deeply invested in China, and we wish to contribute to China's long-term sustainable economic growth. And in doing so, that will benefit U.S.-China relations in a very significant manner," said Allen.

Regarding the position of the Chinese economy in the global economy, Allen voiced confidence that China will remain a key engine of global economic growth. *Xinhua*

Israeli strike kills at least 17 Palestinians in central Gaza, health officials say

CAIRO/GAZA

AT least 17 Palestinians were killed and dozens wounded in an Israeli strike in the central Gaza town of Zawayda on Saturday, health officials said, as Israel issued new evacuation orders, citing Hamas rocket fire nearby.

Israel also announced the names of two soldiers Israeli media reported were killed on Saturday afternoon when a roadside bomb exploded in the central Gaza Strip, and an air strike in the occupied West Bank that it said killed two senior Hamas militants involved in the killing of an Israeli.

Most of the people killed in Zawayda were from the same family and they included eight children and four women, according to health officials in the Hamasadministered enclave.

"They were asleep in their beds, kids and babies, then three missiles targeted their place," said Abu Ahmed Hassan, a neighbor. The owner of the house was a known merchant, he said. "There are no military activities here at all," he added.

The Israeli military said in response it had struck militant targets in an area from which rockets were fired at its troops. It said the incident was under review.

Israel's military spokesperson posted instructions in Arabic on X on Saturday for people in parts of central Gaza, including in the Maghazi district near Zawayda, to evacuate to a designated humanitarian

Reuters could not immediately verify whether Zawayda was among the places ordered to evacuate and whether people there had received the military's instructions. Residents said thousands were streaming out of Maghazi.

On Friday, two sections of the southern Gaza city of Khan Younis within what Israel has designated as a humanitarian zone were deemed dangerous by the military, which ordered people to evacuate them, saying militants had been regularly firing rockets from there.

The United Nations Office for the Coordination of Humanitarian Affairs (OCHA) said Friday's orders, which also included other areas of the enclave outside the humanitarian zones, had affected around 170,000 displaced people.

"This is one of the largest evacuation orders affecting the zone to date and it shrinks the size of the so-called 'humanitarian area' to about 41 square kilometres, or 11 per cent of the total area of the Gaza Strip," an OCHA report said.

In the central part of the enclave, residents said Israeli tanks advanced further on Saturday into the eastern area of Deir al-Balah, an area they had not entered before, where hundreds of thousands of displaced Palestinians are sheltering.

The Israeli military said that since Friday its forces had killed dozens of militants, including some who had fired rockets from central and southern Gaza.

Most of Gaza's 2.3 million population has been displaced by the 10-month-old Israeli offensive, which has laid waste to much of the enclave.

Another Israeli airstrike on a car in the occupied West Bank city of Jenin on Saturday killed at least two more Palestinians, one an 18-year-old, the Palestinian health ministry said.

Ceasefire talks

Negotiations on a ceasefire between Hamas and Israel in the Gaza Strip will resume on Wednesday in Cairo, Egyptian sources told Xinhua on Saturday.

The delegations of the three mediators Egypt, Qatar, and the United States -- and Israel's delegation will attend the talks scheduled for Wednesday and Thursday, according to the sources, who required anonymity.

Meanwhile, representatives from Egypt, the United States, and Israel are currently still in Doha, which hosted the recent ceasefire negotiations earlier this week, to discuss "the technical points" of the ceasefire agreement in preparation for the talks in Cairo, said the sources.

In Doha, officials from the four countries engaged in intensive talks with the aim of concluding an agreement for a ceasefire in Gaza, including the release of Israeli hostages and Palestinian detainees.

The three mediators announced in a joint statement on Friday that a "bridging proposal" had been presented to Hamas and Israel, which is consistent with the principles of UN Security Council Resolution No. 2735 that calls for an "immediate, comprehensive, and thorough" ceasefire in Gaza.

A senior Hamas official on Saturday accused Israel of obstructing all efforts to finalize a Gaza ceasefire agreement.

"The Israeli occupation continues to obstruct all efforts to complete any ceasefire agreement," Sami Abu Zuhri said in a press

Abu Zuhri also accused the US administration of "fully adopting Israel's position" and claimed that Israel is retreating from previous clauses. He noted that Washington is trying to "deter any moves" in the region against Israel.

"We are not facing a real agreement or negotiations, but rather the imposition of American dictates," he said, saying that talking about reaching a ceasefire agreement is "an illusion."

Nearly 68 million suffering from drought in Southern Africa, says regional bloc

HARARE

ABOUT 68 million people in Southern Africa are suffering the effects of an El Nino-induced drought which has wiped out crops across the region, the regional bloc SADC said on Saturday.

The drought, which started in early 2024, has hit crop and livestock production, causing food shortages and damaging the wider economies.

Heads of state from the 16-nation Southern African Development Community (SADC) were meeting in Zimbabwe's capital Harare to discuss regional issues including food security.

Some 68 million people, or 17 percent of the region's population, are in need of aid, said Elias Magosi, SADC executive secretary.

"The 2024 rainy season has been a challenging one with most parts of the region experiencing negative effects of the El Nino phenomenon characterized by the late onset of rains," he said.

It is Southern Africa's worst drought in years, owing to a combination of naturally occurring El Nino - when an abnormal warming of the waters in the eastern Pacific changes world weather patterns - and higher average temperatures produced by greenhouse gas emissions.

Countries including Zimbabwe, Zambia, and Malawi have already declared the hunger crisis a state of disaster, while Lesotho and Namibia have called for humanitarian support.

The region launched an appeal in May for \$5.5 billion in humanitarian assistance to support the drought response, but donations have not been forthcoming, said outgoing SADC chair Joao Lourenco, President of Angola.

"The amount mobilized so far is unfortunately below the estimated amounts and I would like to reiterate this appeal to regional and international partners to redouble their efforts... to help our people who have been affected by El Nino," he told the summit.

The drought is a major talking point at this year's summit, alongside issues such as the ongoing conflict in eastern Democratic Republic of Congo, which Lourenco said was a source of great concern.

US should immediately negotiate with Russia, Ukraine – presidential candidate

WASHINGTON

THE United States should immediately sit at the negotiating table with Russia, Ukraine and other stakeholders, said Jill Stein, who was approved as the Green Party's US presidential candidate earlier in the day.

"We need to decompress this conflict as quickly as possible, and we need to get back to negotiations with Russia, Ukraine and other players. What Russia essentially wanted was neutrality from Ukraine. That is absolutely simple," she said at a new conference following her nomina-

"We need to engage in basic diplomacy. This is not rocket science. This is basic diplomacy. It's basic conversation that could readily avert a catastrophic conflict here," she added.

In her opinion the conflict "would readily have been averted had the US sat down to negotiate in advance" or "had the US not sabotaged the peace agreement that was established shortly after" Russia began its special military operation in Ukraine.

She also believes that the incumbent administration's policy is, in essence, "the exercise of the military industrial military industrial complex and its intention to basically gin up business for itself by creating war, after war, after war. "And the American people need to put an end to it," she said.

Stein, a 74-year-old physician and an environmental activist, was offi-



cially nominated as the Green Party's presidential candidate for the upcoming election during a party convention on Saturday. Her running mate is Professor Butch Ware. The US presidential election will

be held on November 5. The Democratic Party was supposed to be represented by incumbent President Joe Biden, but after his failed performance in his June debate with Republican candidate Donald Trump, calls for the incumbent head of state to pull out grew louder among Democrats. On July 21, he decided to withdraw from the race and endorsed Vice President Kamala Harris for the country's top office.

Turkish bath tradition remains alive in Ankara

ANKARA

IN the Old City of Turkish capital Ankara, a hammam, or Turkish bath, offers a glimpse into history within its Ottoman setting.

Oner Aydin, the owner of the Karacabey hammam, said it is the oldest and largest hammam in Ankara, which was a small Ottoman town before becoming the Turkish Republic's capital in 1923, providing an authentic Turkish bath experience for centuries.

"The construction of this historic bath began in 1427 and was completed in 1440. It has been in service since then," Aydin said. According to Aydin, the hammam was closed for some time, before his company undertook repairs and resumed its operations in 1989. The Turkish bath typically features a spacious, circular marble main steam room with high ceilings. It is heated by a furnace, with hot air flowing through conduits beneath the floor.

In the center of Karacabey's steam room, an elevated circular platform allows bathers to lie down and enjoy the heat, as well

as receive massages and scrubs.

Individual sinks are installed in the surrounding walls, each with hot and cold water taps. Users can adjust the temperature to their preference and use copper bowls to pour water over themselves.

Hammams have waned in popularity over time. Despite the growth of spa and wellness culture, many Turkish cities still maintain hammams, which was introduced by the Ottomans. However, since the outbreak of the COVID-19 pandemic in 2020, interest in hammams in Türkiye has surged as people have become more health-conscious.

According to Aydin, Turkish baths have many health benefits. "Hammams are cru-



TFF can scale competitions to axe qualification duplication, skipping

WITH Premier League sides vastly improving in their player registration abilities, which also means stronger sponsorships and a solid operational base, organising how the top sides participate in regional competitions can now be improved. The perennial case of this confusion is the top league sides being invited to take part in the Mapinduzi Cup, and as it is clear they would meet in case they are both there, one side skips the tourney. In a recent event, the top sides skipped Kagame Cup regional club tournament now

This is precisely what needs to be avoided in planning for the season's competitions, so that the now more able clubs know what they can gun for, as the premier league overall championship cannot be gunned by every competing side. So far, just the continental contests provide the satisfaction that those not winning the title can pride themselves with, whether or not they reach far in the tournament. The same thing could be done for other contests, the less profitable or less famous outings, for a club to at least be able to show to its supporters that it aimed at one tournament, or similarly did something there.

The restoration of Kagame

Cup for instance appears to have been somewhat sudden, as it appeared to target the cup contenders who are also slotted in continental tourneys. Only after they rejected the tourney in favour of pre-season travel arrangements did other sides be asked to fill the gap, which was not ideal, as being aware from the start they would have a tourney would have propelled better pre-season readiness.

The timing of the contest can't be altered owing to the charged calendar, so it is the clubs that can be redesigned, to take off the leading sides as they have more preseason travel options,

That is why, owing to the fact that local clubs are increasingly cutting an imposing figure in regional football, we can have a more open arrangement where the top sides aren't being asked to take up all competition chances. It means we should follow the same rules that we have for the CAF championships for the other tourneys so that they obtain the value they deserve. The first two sides can be picked for the big continental tourneys, while the next two qualify for Mapinduzi Cup, and two for Kagame Cup.

The NBC Premier League has a situation where even start-up sides appear ready and happy to sign good players from beyond the border, or veteran coaches from Europe who have coaches here or nearby, even top South African sides.

peeped into continental competition and even arrived at the

Local soccer analysts treat some of the leading clubs in our neighbourhood as middle ranking by comparison with local premier league sides, one being Vital'O that was claiming, via its talkative spokesman, that he was sure they would floor Young Africans SC. Scarcely any fans here or back home are likely to have believed him, and that means our club sides matter.

This implies that there would be more guesswork about who goes to compete in this or that tourney, with the Mapinduzi Cup at mid-season skipping over the city rivals, to find sides that wish to prove something in that tournament, not just the best sides. Or at least a club can be asked if it wishes to compete, and definitely not both the two top city sides as they would always wish to skip a derby for any reason, since a derby can change the club atmosphere and put pressure on the leadership or the coach, whether or not the side had up to that point rolled up some neat successes. This is always the case.

Making these auxiliary tournaments also a matter of qualification could help improve their standings among the local fans, as well as solidify fans' expectations for upcoming club sides. Some of them have once

peeped into continental competition and even arrived at the stage or close to that feat like Namungo FC some years back.

Yet even those listed for CAF tournaments were in the preseason middle or late stages and not quite prepared for competitive football, the way Coastal Union FC failed to make a good impression at the Kagame Cup tourney. It was a haphazard invitation, not an awaited occasion where their fans would have been hoping for something, to boost their morale.

While the local Premier League and the CAF tourneys will remain the more exciting engagements, the other contests stand a chance of being acknowledged as calendar events in their own right. They would complement the FA Cup and the Charity Shield in comparable importance, where the two city sides do not hesitate from being pulled to a derby in pursuit of any of those titles, whereas Zanzibar clubs prize the local top context and Mapinduzi Cup as an auxiliary, or a local version of the Charity Shield,

In the days where local club appearances in continental tourneys were limited in scope by and large, the regional club tournament or its national team version used to be more important. It shows why scheduling teams for participation could

"We dominated the first 15 minutes, which was our game plan. We anticipated their high-intensity approach and were able to counter it effectively during that period," Ouma stated.

However, Coastal Union's early control unraveled as Bravos Do Maquis began exploiting their defensive vulnerabilities.

"Their long diagonal passes exposed our defense. The first goal came from a long ball that bypassed our defense, and our defender failed to clear the danger.

"The second and third goals followed similar patterns, which is unacceptable for a team with our defensive objectives," Ouma lamented.

Coastal Union now faces a daunting challenge in the second leg as they look to overturn the threegoal deficit.

Despite finishing fourth in the Tanzanian Premier League with 37 points from 11 wins, four draws, and 13 losses, the team will need a significant improvement in performance to secure a positive result.

The return leg is scheduled to take place at Benjamin Mkapa Stadium on August 23.

Coastal Union will need to put forth a remarkable effort to advance, as the winners of this tie will face FC Lupopo from the Democratic Republic of Congo in the next round.

Coastal Union's journey in the second leg will be closely watched by fans and analysts alike, as they strive to bounce back and continue their progress in continental competition.
