UK ex-premier in Dar, pledges to link us with vaccine firms

PRESIDENT Samia Suluhu Hassan yesterday discussed various issues with former British Prime Minister Tony Blair who promised to help Tanzania secure Covid-19 vaccines.

The meeting took place at the State House in Dar es Salaam where the former premier said he would connect Tanzania with vaccine manufacturers.

Blair is the founder and chairman of the Tony Blair Institute for Global Change which focuses on government advisory practice, and at present it has dedicated its activities to the fight against Covid-19 after its outbreak, as the organisation is currently focused on Covid-19


testing and vaccine access.

The global change entity is currently working in 16 African countries to help government implement certain priorities but for the past year and half in the wake of the Covid-19 challenge.

President Samia welcomed the Tony Blair Institute in its vocation to help the government implement its various development initiatives, the statement indicated, noting that the president outlined the government's Covid-19 control plan, including coordinating a mass vaccination

Samia hails late Mghwira for diligent public service



PRESIDENT Samia Suluhu Hassan has mourned former Arusha Regional Commissioner Anna Mghwira who passed on yesterday, saying she served her country diligently

Mgwhira (pictured) died yesterday at Mount Meru Regional Referral Hospital where she was receiving treatment. The cause of her death was not immediately released.

The president said she received the news of Mgwhira's death with deep sadness, noting that she made immense contributions in the building of the nation, a State House statement noted.

"The president sends her heartfelt



condolences to the family of the deceased, friends and all Tanzanians at this difficult moment."

The late Mghwira was born on January 23, 1959 at Mungumaji Ward in Singida town, joining Nyerere primary school from 1968 to 1974 and Ihanja secondary school from 1975 to 1978. She joined the Lutheran Seminary for advanced level secondary education from 1979 to 1981.

She pursued theology at Tumaini University, Makumira Campus and then worked for an LLB at the University of Dar es Salaam, than obtained a master's degree in law from Essex University in England in

Mghwira has worked for international and local organisations attached to women's empowerment, community development and assisting refugees.

Her political journey started in early youth, as a member of the party youth league, but she scaled back her participation in politics at the end of the 1970s to focus on education, eventual career and family.

She returned to politics in 2009, when she joined Chadema and in March, 2015 left Chadema for the newly formed ACT-

Mbowe shifted to Dar, police retain 15 cadres

POLICE in Mwanza yesterday admitted to be holding 15 Chadema cadres who were arrested Wednesday morning, hours before a planned conference to demand a new constitution.

Regional Police Commander Ramadhani Ng'anzi told reporters here that Chadema national chairman Freeman Mbowe who was also arrested alongside the 15 cadres was immediately taken to Dar es Salaam for interrogation "in relation to a separate criminal investigation."

"Once the ongoing interrogation is complete in Dar es Salaam, he (Mbowe) will be brought back to Mwanza," he said.

Among the main opposition party's cadres who were arrested alongside Mbowe are the party' youth wing (BAVICHA) national chairman John

A statement released by the RPC listed 15 suspects other than Mbowe, whom the police said was arrested together with them during a raid well before daybreak.

Hours after this proclamation, Regional Commissioner Robert Gabriel made an announcement banning all meetings in the region except religious congregations "as a containment measure against Covid-19.

Govt finalises electronic issuing of work permits

AN integrated electronic system for application and issuance of work permits is set for launch next month and billed to attract more investors in the country.

Labour Commissioner Brig. Gen. Francis Mbindi (pictured) said at an awareness meeting with members of the Confederation of Tanzania Industries (CTI that the e-system enables applicants to lodge documents from anywhere in the

It has thus reduced the number of days spent in seeking a work permit, from 14 to



only one day, he explained, noting that the system is based at the Labour Commission in the Prime Minister's Office while being linked to BRELA (the Business Registration and Licensing Agency), TRA (the Tanzania Revenue Authority) and the Immigration Department,.

He said the new system will replace manual applications where one was required to deliver to the commissioner's offices in Dodoma. The launch of the system is part of reforms to facilitate foreign investments, which goes together with amending the Labour Act of 2015.

"The new system will reduce costs and time, vested with an easy top carry smart card with details of the holder instead of a whole file as it used to be," he state, noting that this was part of new policies to address structural and legal challenges impeding

Authorities in Zanzibar destroy over 30m/worth goods unfit for human consumption

GOODS valued at more than 30.7m/- including 5.6 tonnes of rice has been destroyed in Pemba by Zanzibar Fair Competition and Consumer Protection Commission (ZFCCPC) after they were found to be unfit for human consumption.

Addessing reporters here after destruction of the goods at Pujini Kisiwani in Pemba, the Director of Consumer Protection Division in ZFCCPC, Emanuel Juma said the goods were seized from various markets, shops and warehouses through the commission's routine operations.

He said the Division has been conducting crackdowns at market places and from traders to verify the quality of the goods to protect the lives of the people for the months of April to June this year.

He said even though the expiry date of the rice destroyed had not passed, it was found to have gone bad and unfit for human

freed," the secretary intoned.

He said they operate under the provisions of Sections 63 and 64 of the 2018 law (No 5) that gives them the mandate to remove from the market any expired goods and those unfit for human consumption.

He called on all traders to be careful in storing their goods in their warehouse as it was found out that many of the goods are badly stored.

He advised them during storage they should not place together food

He also called on the people to adopt the habit of first checking expiry dates on goods they purchase before they pay for them.

For his part, Ali Omar Massoud, a ZFCCPC official stationed in Pemba said it would be better for the people to be extra careful to avoid using goods whose dates have expired to protect their health.

He said using bathing soap whose date has expired may harm the user's skin.

MV Mafanikio maintenance nears completion - TEMESA

FERRY services for residents of Msangamkuu and Msemo in Mtwara Region are set to resume as maintenance of MV Mafanikio nears completion.

Chief Executive Officer of the Tanzania Electrical, Mechanical and Electronics Services Agency (TEMESA) Eng Japhet Maselle made the revelation here yesterday during his tour at the Songoro Marine yard in Kigamboni, Dar es Salaam where the maintenance job is being carried out by Songoro Marine Transport Limited.

Speaking to journalists shortly after inspecting the on-going repair job, Eng Maselle said the contractor has been urged to speed up the work and ensure maintenance is completed within schedule for the residents to start enjoying the ferry services.

"We have brought the ferry for repair at Kigamboni because it is cost effective compared to the prices of buying and transporting spares from Dar es Salaam to Mtwara. Working on it from Mtwara would have taken a longer period,"

said the TEMESA boss.

He said they have embarked on a programme to renovate all the ferries operating under TEMESA to ensure safety and security of passengers. He said experts recommend regular maintenance of ferries because vessel's bodies may be damaged by salted Ocean water.

"We always take our ferries for repair after a certain period. Mtwara Residents should be patient as we work to ensure them with convenient marine transport services," he said adding the agency has now provided them with alternative boats—MV Tangazo and MV Kuchele.

Director of the Songoro Marine Transport Limited, Khalid Songoro said the repair job has now reached 85 per cent, and that they are expecting to complete the job by August 15th 2021.

"We are finalizing the work. We will hand over the ferry to TEMESA within schedule," he said.

MV Mafanikio has the capacity to carry 100 passengers, six vehicles and 50 tonnes of cargo. It operates between Msangamkuu and Msemo in Mtwara town.

Two die after falling asleep with burning charcoal stove in the room

TWO people said to be lovers - Bentho Mbatha (23) a bus tout and Njombe town resident and Jazila Said (27), resident of Namtumba in Ruvuma Region have died after they slept with a burning charcoal stove in their room to keep them warm.

Confirming the incident, Njombe Regional Police Commander Hamisi Issah said it happened on July 17 at around 11:00 pm in National Housing Corporation (NHC) housing estate in Njombe town.

"After they met their death no body new about that," said the RPC, and added that the cause of the death was the burning charcoal stove they placed in their rooms for warmth, and added that this is the practice of people in Njombe to protect themselves from bitter cold.

He called on the people of Njombe to stop the practice, and find other ways to keep warm from cold as burning charcoal stoves produce toxic fumes (carbon dioxide) that are dangerous.

Narrating the incident, the owner of the house the deceased duo slept in, Amani Samson Mwalongo said "I found them dead as I decided to go and visit them in their room."

One of the neighbours said the deceased used to come here to collect fire and chips saying he had a visitor, but after some days he was not to be seen and after one day we saw the police descending on the house.

Police in Lindi holding five over marijuana cultivation

POLICE in Lindi Region have detained five people, including a woman all residents of Namkongo Village, Mapingo Ward for allegedly being involved in the cultivation of marijuana.

Lindi Regional Police Commander Mtatiro Kitinkwei told this reporter during the exercise to destroy the farms in Mangalanganda forest.

He mentioned those detained as Salum Mtopwa (70), Saidi Mohamedi Songea (43) Somoe Mohamedi (31), Seif Issa (20) and Mudhihili Omari (20), all of who are alleged to own four farms of marijuana with a total of seven acres.

RPC Kitinkwi said one of the suspects, Salum Mtopwa, apart from being involved in the cultivation of the illicit drug, also owned a firearm - a rifle.

The RPC said it was suspected that Mtopwa was using the firearm contrary to the conditions of the permit as he was found that he was making his own ammunition, instead of buying the same from legally authorized dealers.

"We are still conducting investigations on this firearm, whether it was legally acquired or not," he added.

During the exercise to set fire to the farms, the police, with assistance from good citizens, impounded several bags of dried marijuana hidden in various areas of the forest.

RPC Kintinkwi said all the suspects will appear in court after investigations are completed.

Don't spread rumour that PLWHA are prone to COVID-19, NACOPHA chairperson calls upon Tanzanians

THE National Council of People Living with HIV (NACOPHA) Chairperson Leticia Kapela has urged Tanzanians to refrain from spreading rumors that people living with HIV/Aids (PLWHA) are susceptible to Covid-19.

Kapela made the call yesterday when speaking to journalists in Dar es Salaam, saying that a person living with HIV/Aids is the same as other people as there are those who have suffered from Corona disease, but with proper treatment from health professionals and following instructions, they have recovered.

"Because people living with HIV, have CD4 deficiency, they are more at risk of getting Corona infection which is not true as PLWHA is like anyone else can deal with this disease if they follow the rules and procedures as issued by health practitioners," said Kapela.

The official requested the

government to provide adequate education on the Covid-19 vaccine to various groups, especially PLWHA on its availability, benefits, side effects, and even its quality to build a good foundation and help those who need to make the right decisions to get the vaccine.

Kapela called on religious leaders and the media to ensure that they continue to play a role in providing appropriate education to the surrounding community and the general public on Covid-19 and also to alleviate their concerns with misinformation or intimidation.

She also instructed all NACOPHA staff, leaders, and coordinators, facilitating groups, medical consultants, and their families to take precautions and adhere to the instructions of experts and the statement of president Samia.

She tasked them to heed the instructions and take all precautions not only in the workplace but also in their homes as a whole and also to protect those who serve them

The council also has advised PLWHA to ensure that they continue to receive appropriate HIV services throughout the period without being affected by the presence of Covid-19 and we urge PLHIV to report as soon as they see any changes in the provision and availability of health services in our areas, from anyone else.

NACOPHA also commended President Samia Suluhu Hassan for setting up a special Covid-19 Committee in April 2021, which continues to provide technical advice on various controls and prevention strategies based on the ongoing Coronavirus infection worldwide.

"I'd like to urge and encourage PLWHA, our families and Tanzanians in general to protect themselves from this pandemic because prevention is better than

According to Ollomi, the organic coffee world market is expanding day to day, appealing Kilimanjaro coffee producers to switch themselves to organic farming.

"Apart from high demand of organic coffees in the world market, its production is also very low as farmers are not buying industrial fertilizers in their production, thus they are using only ecologically based pest controls and biological fertilizers derived largely from animal and plant wastes and nitrogen-fixing cover crops.

Ollomi who is also a coffee producer at Lyamungo village, in Hai district, Kilimanjaro region further explained that producing coffee through organic farming is cheaper than using industrial fertilizers and other agriculture inputs like coffee pest controls which are sold at high prices, and the world market for organic coffee is expanding everyday.

Avoiding unnecessary gatherings can't stop infections, but it's vital

Salaam on Wednesday, Prime Minister Kassim Majaliwa appealed to the public to avoid unnecessary gatherings as a way of taming the Covid-19 pandemic.

He said the effort was decisive as the country awaits a mass rollout of vaccines, noting that the spread of the disease can only be controlled if people adhere to containment measures recommended by health experts.

No one can contest or belittle the need to continue washing hands regularly with soap and running water, using hand sanitisers and wearing face masks recommended - and approved - by the relevant authorities.

There are truisms that can't be avoided, with the sort of experience so far gathered in the fight against Covid-19. Unfortunately, there are doubts whether the public is ready to take up and dutifully observe the premier's assertion that it is the duty of all Tanzanians to observe social distancing as a means of denying the virus ease of spreading.

Nor. Indeed, is it evident that many of those in the more luxurious category can rapidly build a culture of exercising in the knowledge that keeping fit means an immense lot in the war on the pandemic.

Exercises help to keep at bay all manner of infections although, admittedly, there is sometimes a constraint in terms of availability of

The level of the effectiveness of some precautions is also at times imperilled by the availability of public transport and other resources.

Nor, again, can be it said that all of a sudden people will lose

> $buses\, or\, attending\, the\, same\, prayers.$ This matter was debated last year as Covid-19 broke out and the government attained considerable success in that area. It is however unclear how far the headway made was due to the measures taken and how much was just luck.

> There is now a third wave of the pandemic though public impressions are that we are still doing relatively well despite reports of rising numbers of infections hospitalisations.

Slightly over two months ago, the Dar es Salaam Catholic Archdiocese head remarked in a church sermon that, going by how people sit or stand in commuter buses, the number of those putting on face masks is virtually negligible.

While cases are reported rising in some parts of the country, there is altogether no panicky atmosphere generally - including in the commercial capital, Dar es Salaam.

It well might be this that makes people relax and observe fewer precautions, which is bad, but it is also an environment where people don't live in fear of the disease as an all-encompassing menace.

The issue is how far this will remain the case as preventive efforts help but infections elsewhere show that the recommended social distancing and the washing hands with soap and running water are no magic wand. We all need to take greater heed of expert advice.



Kenya brings together youth in supporting war on malaria

Kilifi, Kenya

RESIDENT Uhuru Kenyatta (pictured) of Kenya on Thursday launched the Kenya Malaria Youth Army (KeMYA), a social movement that brings together young people from all the country's 47 counties determined to champion nationwide malaria control and elimination.

The movement will support advocacy, communication, innovation and community efforts geared towards ending the killer disease, improving maternal and child health, and advancing access to universal healthcare.

The unveiling of the Kenya Malaria Youth Army (KeMYA) builds upon the bold and ambitious agenda by President Kenyatta - the chair of African Leaders Malaria Alliance (ALMA) - to eliminate the disease in Africa.

In his four-point agenda, Kenyatta envisioned an 'ALMA youth army'. This is meant to ensure that, at the continental, regional and national levels, young people are mobilised through existing structures into a 'youth army' movement to contribute to ending malaria and expanding universal health coverage.

"Now is the time to leverage the potential of young people to eliminate malaria by 2030 and work with them for faster and more effective delivery of health services at all levels," said Kenyatta.

"Young people constitute the majority of our population, partnering with youth was a missing link in our concerted efforts as leaders to defeat malaria," he

KeMYA will consist of young people aged between 15 and 35 and will draw its membership from existing youth platforms, including youth groups, youth alliances, youth councils, youth societies and youth associations in Kenya.

The army will be open to diverse cadres of young people, among them students, young professionals, young leaders in political realm, public service and private sectors, and any other young persons willing to volunteer their time towards the malaria fight.

To fulfil its mandate, the youth army will support awareness raising, community sensitisation activities and dissemination of malaria messages in a bid to drive action towards elimination of the disease.

The army will advocate



resource mobilisation and policy implementation while supporting community-level malaria prevention and control efforts.

include community-These facing actions, including the distribution of insecticide-treated bed-nets, spraying larvicides at malaria mosquito breeding sites and performing indoor residual spraying of homes in the lake and coastal malaria-prone counties of

The youth will also take a lead in innovating and scaling up the delivery of proven tools that will prevent, diagnose or treat malaria infections in a bid to save lives.

At the launch, President Kenyatta called on young people to amplify their voices in crusading for greater accountability from government decision-makers and the private sector as well as for the strengthening of health systems.

He underscored the need for young people to crusade for improved malaria surveillance and data sharing as well as for malaria decision-making spaces to get more inclusive.

"There has been no better time for the young generation to advocate their own future - now is the time to own the malaria agenda," he said.

The president noted further: "I encourage the malaria community to leverage the #KenyaNiMimi youth campaign, the Sawazisha Gumzo by the National Youth Council, and other initiatives for youth dialogue and engagement in social, economic and leadership processes in the country to contribute to malaria and the broader health and development agenda."

Upon launching the movement, President Kenyatta urged young people to support malaria prevention and control activities at the grassroots level.

The youth army will leverage on existing frameworks such as the National Youth Service (NYS) and the Kazi Mtaani initiative to perform indoor residual spraying of homes in malaria-prone counties of Kenya.

The newly launched Kenya-Cuba project in the Health ministry will also engage young people in spraying larvicides at mosquito breeding sites.

National Youth Council CEO Roy Sasaka Telewa meanwhile said: "Every two minutes, malaria claims the life of a child. This deadly disease has been stealing our future for far too long. From today, we shall demonstrate that as young people that if we come together, we are the generation that will eliminate malaria in our lifetime."

During the launch, the President witnessed a demonstration on the use of drone technology in spraying mosquito breeding sites - an initiative of the End Malaria Council. The initiative demonstrates the use of public-private partnership in end-malaria efforts.

With the launch, Kenya has become the first country in Africa - and globally - to have a national malaria youth army.

KeMYA has been established upon the premise that, while significant progress has been made to combat malaria, action must be taken to accelerate progress and overcome

challenges related to Covid-19. The youth army is also built on the idea that meaningful engagement of young people is essential in driving the gains realized towards better health and wellbeing for all.

Malaria remains the leading cause of illness and death in Kenya and accounts for over five million outpatient visits reported in health facilities in the country - with the most-at-risk population for the disease being pregnant women and children under the age of five years.

ALMA is a ground-breaking coalition of African Union Heads of State and Government working across 55 African countries with various partners including Regional Economic Communities and development partners to eliminate malaria by 2030.

On assuming the coalition's chairmanship for the 2020-2022 period, Kenyatta set an agenda outlining four key results-based priority areas.

The first is digitalisation meant to provide real-time access to healthrelated data, including sharing of Scorecards for Accountability and Action at country level to facilitate evidence-informed policies and programmes.

Two: engagement with Regional Economic Communities as the key pillars to implement AU Malaria commitments.

Three: establishing End Malaria councils and Funds to boost multisectoral action, accountability, resource mobilisation accountability.

Four: creating an ALMA Youth Army to create a broader social movement to fight malaria, improve maternal and child health, and improve access to universal health-

Nair of celebration must South Sudanese firm. be high in Tanzania's grain marketing circles with the country having sealed accords for grain exports to Kenya and South Sudan, while making progress in seeking market outlets elsewhere.

Latest reports say that Tanzania will this harvesting season export over 200,000 tonnes of cereals maize and sorghum - to Kenya and South Sudan. This follows a oneyear agreement signed between our Cereals and Other Produce Board (CPB) and Kenya's Grain Industries Limited that allows Tanzania to export 144,000 tonnes of grain worth 7.5bn/-.

This convivial atmosphere follows an ironing out of differences with Kenya regarding trade in general and cereals trade quite specifically, with CPB reporting that 1,000 tonnes of maize have so far been transported to Kenya.

The amount expected for the whole year is quite high seeing that the board is allowed to export a monthly 12,000 tonnes of maize across the border.

Reporting the crisis in Myanmar: Lessons from the ground

YANMAR faced the largest uprising in its history this year. Since the military coup in early February, activists say that by early June about 850 civilians had been killed and more than 5.000 arrested - including 87 journalists.

The Myanmarese junta immediately sounded the death knell for what limited freedom of the press Myanmar had, hard won during the country's ten years of civilian rule.

In order to control the media and discourse, the junta banned the word "coup" from use, and in early March intensified its crackdown on journalists.

During the week of March 8 alone, five media outlets had their licences revoked and another was prosecuted. Most continue to cover the news from secure locations, which sometimes requires leaving the country.

"I depend on NGOs and my local contacts for sources, but at least I report the news freely," said one Myanmarese journalist in exile. After covering the country for 12 years, this press agency employee had to leave his country because of the increasing danger.

"I no longer felt safe in Myanmar, firstly, as a Myanmarese citizen and secondly, as a journalist," he said, adding: "There is no longer any rule of law in the country. Many people know that I work for the press, I could be reported (top the junta) at any time." The reporter did not wish to give his name or his current location, which he says he does not share with anyone, even his sources: "For my interviews, I paid for an option on Skype, which locates my phone number in the US."

Covering Myanmar is as much about protecting oneself as it is about protecting one's sources. Anyone who talks to a reporter there is at risk. Getting an initial contact



may seem difficult, while interviewing someone often requires an introduction by a third party. Aye Min Thant, an American-Myanmarese journalist confirmed this: "People really want to talk, as long as they have a safe way to do it. I give them a direct way to contact me via an encrypted application."

Because of Covid-19, journalists were already accustomed to reporting remotely. Since the coup, however, they have conducted all of their work on the internet.

Like China, Myanmar has an intranet: the

junta actively controls the web, while social networks such as Facebook, Twitter or Instagram have been banned since the coup, and cuts occur regularly.

Although banned, though, the use of VPNs remains relatively widespread and platforms such as Twitter are still widely used to talk politics, often under the hashtag #WhatshappeninginMyanmar.

But journalists report that, while people involved in the anti-coup movement are actively using social networks and the encrypted app Signal, it remains difficult to reach certain people, especially in rural areas.

"Sometimes it takes several days to interview people, especially as they change locations, phone numbers... it greatly delays the release of articles," said American journalist Emily Fishbein. "Most of my stories are from nalist based in Taiwan. Her work has anonymous sources," said Min Thant. Journalists must be careful to gain their contacts' trust, and take precautions to protect their sources.

"I present myself clearly and as transpar-

Fishbein, adding: "I let interviewees read their quotes and don't insist when they don't want to talk to the press."

Far from the field, journalists must do their best to gather information. "I have adopted a collaborative work model," not-

Meanwhile, exiled Myanmarese journalist Maung Moe, a pseudonym, relies mainly on user-generated content - for example, photos and videos posted on social networks. She also discussed teamwork with local contacts: "My friends in Myanmar all have two, or even three, cell phones.'

She added: "One has a VPN with all the forbidden applications and stays at home, while the others can be used to go out. So there is no problem in case of control. Also, all their files are sent to me on the cloud, so they can quickly delete them in case the military organises a raid at their houses."

Taiwanese freelance journalist Pei-hua Yu, who specializes in Southeast Asia, recounted her own experience reporting from Myanmar.

"At first I thought there were already a lot of journalists covering the events," she said, adding: "But after receiving a message from an activist asking me to put her in touch with journalists, I realized that a number of stories on the ground were not being heard by the international press.'

The young reporter, who then began writing about Myanmar, insisted on the need to humanise the crisis. "The first week, there were a lot of papers analysing the causes of the coup, but we didn't see many human stories. I wanted to report on how the events influenced people's lives."

The press has never been free in Myanmar; the coverage of the crisis is the result of courageous collaboration between journalists both on the ground and outside the country. "Keep on covering Myanmar. Even from a distance, we will happily help you," urged Moe.

Innovator puts Tanzania on the map in the world of engineering

KONO-1, a locally developed 3D-printed functional prosthetic hand, has for quite some time given Tanzanian amputees an affordable solution for improved mobility and independ-

Charged by a simple mobile phone battery, the hand was developed by Tanzanian medical doctor Atish Shah and his RoverLabs cofounders to empower people with upper limb amputations.

The innovator, now, also a biomedical engineering master's candidate, put Tanzania on the map in the world of engineering in the Africa Prize Engineering for Innovation (APEI) organised by the UK Roval Academy of Engineering.

He is the fifth Tanzanian alumnus of the Africa Prize since 2015. That year, Tanzanian chemical engineer Doctor Askwar Hilonga won the Prize for his Nanofilter innovation, a low-cost sustainable water filtration system, to provide clean

and safe drinking water.


In Tanzania, prosthetics are unaffordable for those in middle and low-income communities, and no other battery-powered prosthetics are being developed in the region.

Across Africa, as little as 17 per cent of people with amputations can afford prosthetics or rehabilitative devices.

Mkono-1 is the first locally designed and manufactured myoelectric hand in Tanzania. The technology amplifies the electrical impulses of the amputated limb's muscle tissue, and these signals are processed to allow the user to move the hand.

Shah and his team at the Dar es Salaam-based RoverLabs are passionate about helping amputees regain access to economic opportunities as well as the confidence and independence that come with improved mobility.

Mkono-1 is manufactured using high-performance servomotors to mimic the movement of each finger, and multifilament braided high-tension strings to function as



tendons. The microcontroller is the heart of the circuit.

It is battery-powered and can be recharged with a mobile phone charger. It requires minimal maintenance, and spare parts are readily available. The RoverLabs team has tested three prototypes and continue to improve their design. Current development includes incorporating artificial intelligence and machine learning algorithms, which will improve response time, giving users quicker reflexes.

The team is also looking to expand its market across East Africa and move into Central Africa, where up to 96 of every 1,000 people has an amputated limb.

Dr Shah and his colleagues said in a recent statement: "We found that the communities most likely to suffer major injuries like amputations are often those who can least afford prosthetics. Mkono-1 is our first step in providing more affordable options to people with mobility challenges, and we hope it will significantly change our customers' lives."

Rwandan farmers pin hopes on new tech to tackle food losses

WANDA is trying to reduce post-harvest loss by relying on new technologies to increase the amount of food available for consumption and help smallholder farmers confront some challenges caused by the overproduction of staple

For over 20 years, Cyriaque Sembagare, a maize grower from Kinigi, a mountainous village in Northern Rwanda, had survived on farming to feed his extended family but struggled with the loss of a significant portion of his harvest to rot. High levels of aflatoxin prevent farmers in remote rural Rwanda from selling maize to high-value

"I have been selling maize on the market, but I was given a low price because of the harvests highly perishable nature," the 56-year-old farmer told IPS in an interview.

Post-harvest losses are high in Rwanda, with smallholder farmers losing an average of 27.5 percent of their production annually.

A comparison with the global and African scenarios indicates that Rwanda does well on preventing food loss and wastage (72.5 percent). The country is slightly lagging on average in sustainable agriculture (71 percent). It is among the lowest performers while tackling nutritional challenges (71.2 percent), according to the Barilla Center for Food and Nutrition (BCFN) sustainability index.

To boost resilience and reduce post-harvest losses, the government and different development partners have supported thousands of farmers facing several barriers, ranging from a lack of knowledge to poor market access.

The initiatives include innovative solutions in postharvest handling to improve food security in this East African country. The country is ranked 59th among 67 countries on the latest Food Sustainability Index (FSI), developed by The Economist Intelligence Unit with

While Rwanda is ranked on top among nine low-income countries, especially in Sub-Saharan African, the country is lagging in addressing food waste.

FSI research by the Economist Intelligence Unit, based on data from the UN's Food and Agriculture Organization (FAO), indicates that in terms of annual food waste per head, Mozambique comes on top of African countries with 1.2kg, followed by Rwanda (1kg).

This high level of waste has prompted the government and partners to promote modern technologies to tackle post-harvest losses, including two types of dryer machines: Mobile grain dryer machines and Cob Dryer machines that tested successfully on maize, rice and soybean

"The aim was to reduce the risk of crop degradation or

contamination by different fungi which occurred when dried naturally and affects the availability of food," Illuminée Kamaraba, the Division Manager in Post-Harvest Management and Biotechnology at Rwanda Agriculture Board, told IPS.

During the implementation phase, Rwandan researchers had embarked on testing Cob dryer machines on other crops like Roselle (Hibiscus). Some 400kg were dried before samples were taken to the laboratory to verify if the nutrients remained intact. This method focuses on limiting the harvests' exposure to aflatoxin.

Before expanding the technology countrywide, a study to measure the impact

of these innovations, especially the use of dryer machines, is planned for testing this

"The new technologies are complementary with some traditional methods for food preservation," Kamaraba said.

Currently, Rwanda has acquired ten mobile dryer machines for the pilot phase to

process 57 to 84 tons of well-dried and cooled cereals per day.

The mobile grain dryers mostly use electricity but could be connected to tractors to run on its dieselpowered burner where there is no electricity supply system.

For the cob dryer machine, its burner and fan depend on the supply of three-phase electricity and Liquefied Petroleum Gas (LPG) gas, while the cob container (the wagon) is a tractor-drawn vehicle.

According to official projections, the new technology, promoted through private and public partnerships (PPP), aims to help Rwanda achieve 5 percent of post-harvest losses by 2024 - down from the current 22 percent for cereals and 11 percent for beans.

Jean de Dieu Umutoni, one of the experts from Feed the Future Rwanda, Hinga Weze, a non-government organisation working to increase the resilience of agriculture and food systems to the ever-changing climate in Rwanda, told IPS that the idea behind this innovation was to increase access to post-harvest equipment and solutions

"This has been conducted through different channels such as grants, especially for smallholders' farmers," he said.

Both Umutoni and Kamaraba are convinced that for Rwanda to implement the public-private partnerships to reduce post-harvest losses, gaps in knowledge of smallholder farmers, especially in remote rural areas, need to be filled.

So far, Hinga Weze and Rwanda Agricultural Board (RAB) have worked together in developing some guidelines that allow the private sector to use the new technologies. Experts say, however, that the biggest challenge for farmers is that they lack information on how to access suppliers. In contrast, the suppliers lack information on the growers that need the equipment.

Outbreak of avian flu seen compounding the plight of Ghanaian poultry industry

THE outbreak of avian influenza compounded the plight of Ghanaian

poultry sector, said some farmers.

Michael Nyarko-Ampem, president of the Greater Accra Regional Poultry Farmers Association, said that the flu outbreak coupled with the existing challenge of shortage and high cost of feed constituted double jeopardy to the industry.

"It is indeed a kind of double jeopardy that has hit us on both sides. There is an Akan proverb that says a double slap makes you dizzy, and that is what we are going through," Nyarko-Ampem said.

"Before this outbreak, we have been dealing with the unavailability of maize, wheat bran, and soya bean cake. In addition to that, these things have increased in prices."

"We are worried and concerned, particularly about the way the flu could spread, so it is critical that with the help of government and other agencies, we stem the spread of the disease immediately," the farmers' group leader said.

Although the impact of the flu at the moment was significant only on the individual farms and their employees, he said a further spread of the outbreak could have dire economic consequences for the industry, for jobs, and the entire Ghanaian economy. "The impact on the industry will increase when people are not well

informed and educated, and they start avoiding chicken and eggs. Once they do that, there is going to be a loss to the industry as eggs and birds could pile up and go bad," he stressed. And with that, he said, "People will lose investments, and for people

who took bank loans to stock their farms, the interests may pile up, and they would find it difficult to fulfill their parts of the obligation to their As happened in all previous outbreaks, Nyarko-Ampem was confident

that the state would compensate all farmers who would lose their birds He encouraged Ghanaians to continue patronizing poultry products

since all the affected birds had been destroyed, suggesting that people

should boil their chicken and eggs well before

"But farmers are resilient, so we shall ride it out despite the challenges that are besetting us. We will ride it out, but we need the cooperation of everybody," he added.

According to Patrick Abekeh, director of the Veterinary Services Directorate of the Ministry of Food and Agriculture (MOFA), seven farms reported the avian flu outbreak from the Greater Accra, Volta, and Central Regions. And more than 10,000 poultry birds had been lost to the

outbreak in Ghana this time.

Mary Arthur, owner of the Countryside Farms at Klagon near Accra, the capital of Ghana, told Xinhua she had lost all her birds. She said officials from the veterinary department had destroyed all the birds and their feed due to the flu outbreak.

"Through this poultry business, I have been able to fend for my family since my husband is a retiree and now bed-ridden. But I have lost all that now, and I have to start all over again," she told Xinhua.

After contracting a bank loan recently to expand the farm, Arthur did not know how to pay back the loan with all the birds gone.

She urged the government to come to the rescue of the affected farmers to restore their livelihoods.

The veterinary department of the Ministry of Food and Agriculture has been fighting to contain the bird flu outbreak in the West African

Climate change threatens food security of many countries dependent on fish

MILLIONS of people in countries around the world could face an increased risk of malnutrition as climate change threatens their local

New projections examining more than 800 fish species in more than 157 countries have revealed how two major, and growing, pressures -- climate change and over-fishing -could impact the availability of vital micronutrients from our oceans.

As well as omega-3 fatty acids, fish are an important source of iron, zinc, calcium, and vitamin A. A lack of these vital micronutrients is linked to conditions such as maternal mortality, stunted growth, and pre-eclampsia.

Analyses by an international team from the UK and Canada and led by scientists from Lancaster University reveal that climate change is the most pervasive threat to the supply of essential micronutrients from marine fish catches, and threatens the supply of vital micronutrients from fisheries in 40 per cent of countries. Fisheries micronutrient supplies were found to be less vulnerable to overfishing.

Countries among those whose fisheries micronutrient sources are at risk from climate change tend to be tropical nations and include East Asian and Pacific countries such as Malaysia, Cambodia, Indonesia, and Timor Leste, as well as Sub-Saharan African countries such as Mozambique and Sierra Leone.

This vulnerability to climate change for these nations' fisheries is particularly acute given dietary deficiencies in calcium, iron, zinc, and vitamin A are particularly prevalent in the tropics. And these tropical countries are also less resilient to disruptions of their fisheries by climate change because they strongly rely on fisheries to support their national economies and their population's diets and have limited societal capacity to adapt.

The study, which is outlined in the paper 'Micronutrient supply from global marine fisheries under climate change and overfishing, is published today by Current Biology.

Previous studies, most notably research into the micronutrient content of fish, which was led by Professor Christina Hicks and published by Nature, showed that fish are unequal when it comes to their nutritional content. A range of factors, such as diet, sea water temperature and energetic expenditure influence the amount of micronutrients that fish contain. Tropical fish tend to be richer in micronutrients than cold water

When it comes to resilience to climate change and fishing, again not all fish are equal. Earlier studies by Professor William Cheung and colleagues have shown large fish species that have a small range tend to be more vulnerable to climate change. While species that take longer to reach maturity and grow slower, are more vulnerable to fishing -- because it takes longer for their stocks to replenish.

Their findings show only a weak link between the micronutrient density of an individual fish species' and its vulnerability to climate change or overfishing.

However, when the scientists looked at countries' overall fisheries catches then their findings revealed a clear impact from climate change on the overall availability of micronutrients for around 40 per cent of nations -- threatening the food security of millions of people living in these

A key reason for why climate change is such a threat comes down to the species of fish that the countries are targeting as part of their

Some tropical nations' fishers are targeting micronutrient-dense species that have an increased vulnerability to climate change, such as Indian and short mackerels (Rastrelliger kanagurta and Rastrelliger brachysoma), bonga and hilsa shads (Ethmalosa fimbriata and Tenualosa ilisha) and dolphinfish (Coryphaena

hippurus).

However, there is a silver-lining to the study's findings which offers some hope for the future. Some countries may be able to adapt their fisheries to switch from vulnerable species and instead target alternative micronutrient-rich species that are also resilient to both climate change and overfishing, but which are currently under-represented within catches.

Dr Eva Maire, of Lancaster University and Lead author of the study, said: "As climate change and overfishing are significant and growing pressures on global fish stocks, it is essential for the dietary requirements of millions of people to know the extent that these pressures will have on the availability of micronutrients in our seas in the future.

"We have shown that climate change is the most pervasive threat to the supply of vital micronutrients for many countries around the world, and in particular in the tropics

This study draws on the 'FishNutri-

ents' model, a recently released finfish nutrient composition database.

"These data open up a whole new area of research and are crucial to address global food security challenges" said co-author Aaron MacNeil, Associate Professor in the Ocean Frontier Institute at Dalhousie University. "Our research highlights that efforts to improve food security and to tackle malnutrition there is a need to integrate fisheries, climate and food policies to secure these micronutrients for existing and future generations."

Professor William Cheung, co-author from the University of British Columbia, said: "As well as highlighting the growing threat of climate change to the food security of millions of people, our study also offers hope for the future. Armed with nutritional information about different fish species, many countries have the capacity to adapt their fisheries policies to target different more resilient fish species. By doing this then these nations can ensure a more reliable supply of micronutrients for their people.'

Africa's smallholder farmers the linchpin to economic success

FOOD is the most basic of needs. It decides not just the health of individuals but also the health of communities which affects the health of our economies. Underpinning the food we eat, is agriculture which accounts for at least 23% of sub-Saharan Africa's GDP with about 40% of the workforce engaged in the sector.

At the heart of Africa's agriculture are the smallholder farmers. These are millions of hardworking men and women typically farming on less than a hectare of land. They grow staple crops such as maize, wheat, rice, cassava and sorghum.

And history has shown us that no society makes the transition to a modern economy without first modernizing its agriculture.

The pathway to the bright socio-economic future that we all desire for Africa is through an inclusive agriculture transformation agenda. As such, my conviction is that driving Africa's economic transformation through the lens of agriculture, should be a top priority that must take precedence over all other policy considerations at the continental level.



When I took over the leadership of Ghana, my country needed solutions for hunger, malnutrition, poverty and a host of other problems. Understanding the potential of agriculture to address these challenges, my administration worked to deliver a more efficient and productive agricultural base that would become the engine of the economy by providing food security, ushering in industrialization, creating jobs, and increasing

The results speak for themselves, between 2002 and 2005, cocoa production in Ghana, the world's second largest producer, doubled from 350,000 tons a year to 734,000 tons a year, a record in more than a century of cocoa farming in the country.

Altogether, my administration worked tirelessly to support irrigation, improve seeds and crop diversification, infrastructure, storage for harvest and created an enabling environment for farmers to access mechanization like tractors.

In 2007, during my second term in office, the late Mr. Kofi Annan, launched the Alliance for a Green Revolution in Africa (AGRA), an African institution that sought to support governments to catalyse transformation of smallholder agriculture by advancing uniquely African solutions to sustainably raise farmers' productivity and connect them to a growing marketplace. AGRA has evolved into a powerful force and tool for the transformation of our continent.

AGRA's approach to fostering an inclusive agricultural transformation approach has been to convene, catalyse and broker local partnerships to support African governments to prioritize agriculture, allocate adequate resources to support smallholder farmers to access information, appropriate technology, and sustainable market and at the same time; creating enabling business environment to leverage private sector

Over the last decade, including Mali, Rwanda, Ghana and Tanzania, I have seen countries where AGRA has been supporting governments, come through on their AUC CAADP Malabo targets by committing 10% of national expenditure to agriculture. A select number of these countries have each successfully achieved an annual growth rate of 6% with their respective agricultural sectors. A couple more are striving to achieve SDG 2 (zero hunger) by end of 2021.

With various ongoing efforts thus far at national levels in strengthening Africa's agricultural sector, I have no doubt we could achieve a food secure Africa by 2030 if African institutions like AGRA and its partners continue to proactively double-down on their efforts to make that happen.

Given the urgency of ensuring the food security for Africa and its people, we cannot afford any delays in implementing the right policies to ensure success. Africa cannot wait. Now is the time for an African agriculture transformation. This requires an efficient eco-system that unlocks the right policies, public investments and private sector engagement; spurs rural-sector economic growth and; which can deliver broad and accelerated impacts for all.

At the level of the smallholder farmer, there is a need to develop a digitized extension system, across which the continent's smallholder based agro-industry, can in turn, enable a seamless transition from subsistence farming to profitable agriculture.

What fate for vaccine firms if criticisms by 'anti-vaxxers' were validated?

JAN Jekielek, executive producer, senior editor and host of New York's Epoch Times' American Thought Leaders Programme on NTD Television, interviews mRNA vaccine pioneer/inventor Dr Robert Malone on what would happen to the vaccine enterprise meaning paediatric vaccines, the fundamental bedrocks of public health - if criticisms by those labelled anti-vaxxers were validated. [Now, anti-vaxxers are people who believe that vaccines are unsafe and infringe on their rights. They typically deny the existence or validity of the science supporting the use of vaccines in the general population.] This includes questions surrounding the Covid-19 vaccines and repurposed drugs, as well as the bioethics of experimental vaccines.

JEKIELEK: You're, of course, an outbreak specialist. You're the inventor of mRNA vaccine technology. You're also a biostatistician, which is an interesting collection.

DR MALONE: I would say that I've been trained in some biostatistics. To be a biostatistician, for me, that's a step above where I'm at. But I do epidemiology and biostatistics, among other things.

Q.: I want to touch on this whole censorship question, but before we do that, let's talk about where you stand right now when it comes to treatment for Covid-19 or vaccination for Covid-19, given everything we know as we speak and given your rather unique background.

That's a good tee-up because you're talking about both treatment and vaccines, and I've actually been primarily focused with the team that I've been working with on repurposing drugs for Covid-19. We're trying to launch three clinical trials right now, one in India and two in the United States, under IND (Investigational New Drug) for a drug combination involving anti-inflammatories that we've developed. It's already been tested and was initially discovered in a small hospital in Beloit, Wisconsin.

I made an initial threat assessment in January, as we were discussing. I got a signal out of Wuhan and decided that the time needed was not available to develop new vaccines and get them safety-tested in a timely fashion to mitigate the risks of the Covid-19 pandemic. So even though I'm a vaccine specialist, I also have started a company focusing on drug repurposing for Zika (virus). I have this background, and so I've seen both sides of what's going on and how it's rolled out.

My take on the vaccines is that we have some new technologies in the mRNA vaccines. We have a fairly well-established genetic vaccine technology related to RNA, but using the gene therapy vector called recombinant adenovirus. We have two examples of those right now. People call them the Astra-Zeneca and the J&J (Johnson and Johnson) AstraZeneca, Sanofi, Oxford is that cluster that's not licensed in the United States. Right now in the US, we have patients, and everybody has access to three genetic vaccines.

There is a more traditional vaccine that's about to gain emergency use authorisation from Novavax. That has also showed greater than 90 per cent protection against disease and death. So that's in line with what the genetic vaccines are showing. That one offers options for those that are uncomfortable with the genetic vaccine strategy. A lot of people who have been contacting me are interested in having an option. They're uncomfortable with the genetic vaccines, and



they're interested in having an alternative that they can use. Novavax could be a suitable alternative for them.

Worldwide, there is a number of more traditional vaccines, inactivated virus vaccines, and many that are coming online that involve purified subunits, often at very low cost with more traditional adjuvants. We have the vaccines coming from the Soviet Union and also from China. Those are more traditional and have lower efficacy - efficacy being these endpoints of death or disease in a structured clinical trial.

So for the vaccines, there are more options worldwide. In the United States, the options are currently restricted to the genetic ones. Many people are uncomfortable with those for various reasons and might be more comfortable with the Novavax product. I have no financial ties to Novavax, just to mention any potential conflict of interest. I'm just expressing what I perceive to be the vaccine landscape.

In terms of therapeutics, I sit on the ACTIV (Accelerating Covid-19 Therapeutic Interventions and Vaccines) committee at the US National Institutes of Health (NIH), which is the Foundation for NIH committee. I'm not a voting member, I'm an observer. This is the committee that is managing these inpatient and outpatient trials for new agents and now repurposed agents. They've just opened ACTIV-6, which is the first ivermectin trial that's federally sponsored, to the best of my knowledge, here in the US. It's an outpatient virtual trial structure.

With our group from the Department of Defence (DOD), we attempted to include an Ivermectin-included arm in the trial that we have pending with the agency as an IND right now, but the FDA (US Food and Drug Administration) raised so many objections and asked us to do some fundamental studies about demonstrating the mechanism of action of Ivermectin, that the DOD decided that it just wasn't worth the delay in time to get the trial started. So they dropped the

Ivermectin arm.

The landscape right now for the therapeutics and prophylactic drugs looks like - I'm going to stick my neck out, but I'm in close contact with Andrew Hill, who's doing the metaanalysis, and the work of Tess Lawrie, who has now published another meta-analysis from worldwide Ivermectin data - and the data keep getting stronger and stronger in favour of ivermectin as having some protective activity within a safe dosing range. That seems to be impacting on various emerging economies that don't have access to vaccines and is impacting on the event rate for severe Covid-19 disease and death.

There are some great epidemiologic studies or data coming out of India where certain Indian states had been on Ivermectin. The incidence of attack rate of disease was low. Then they withdrew it for political reasons. There was a change in regime. It went up. Then they re-implemented it. It went back down again. So that's pretty strong evidence.

There is also reasonable evidence for the use of Ivermectin as a therapeutic, but there are many others. It's just the one that has gotten a lot of press, in part because of Pierre Kory's Senate testimony.

What many people often don't understand about Covid-19 is that we have the SARS-CoV-2 virus infection event. And, typically, that leads to a disease of varying severity at something in the range of four to seven or eight days afterwards. But that disease only happens in a subset of patients, maybe 80 per cent, maybe 50 per cent of patients taken across all age groups, maybe even fewer. The disease is the hyperinflammatory response to the virus

The disease is really our reaction to the virus. The good news is that we have this rich library of anti-inflammatory drugs that appear to be quite useful against keeping people out of the hospital, if it's used early enough, or treating them once they're in the

hospital.

With Remdesivir, the antiviral that has been licensed in the United States, the WHO is not recommending it globally. Many physicians in the United States find Remdesivir to be of limited use in special situations.

So the idea of using antivirals for this is really not panning out. And there are multiple other antivirals that have been tested. This is often the case with respiratory viruses.

So we all know about Tamiflu and influenza. Tamiflu, in theory, should be good. It may be that it has an impact, but you have to take it within 24 to 48 hours of first getting influenza. During that period, often you don't know that you have influenza. So it's a little bit of a catch-22. Likewise with Remdesivir, it appears.

The other agent that has gotten a lot of attention is Dexamethasone that comes out of the recovery trial in Oxford. That trial actually shows that the utility of Dexamethasone is very limited. Now, here in the United States, a lot of doctors have kind of gone all in. You may even recall that the president (Donald Trump) when he was infected, it wasn't that severe, and yet they put him on Dexamethasone.

Now the actual indication of Dexamethasone, based on the recovery trial, you should already be on oxygen and a high flow oxygen or even intubated. So it appears that in the United States, Dexamethasone is being overused. This is often the case when Dexamethasone is often a first-line go-to when you have a new inflammatory disease.

Then, over time, additional agents come in that are more specific - and Dexamethasone drops. The problem with Dexamethasone is that it's super non-specific, and it hammers the lymphocytes. It hammers a lot of the cell populations that you actually need to recover from Covid-19 long-term. So cynics might say that Dexamethasone is a great way to get patients out of the hospital over the short term, but whether or not it's actually help-

ing them over the long term, that has actually never been studied. So that is the landscape as I see it.

Obviously, the RNA vaccines have gotten a lot of attention. They're remarkable. The adenovirus-vectored vaccines probably produce more protein over a longer period of time. They came out fairly early and were identified as associated with coagulation problems. Those coagulation problems are now being seen more with the RNA vaccines.

And there's an odd spectrum of symptoms. Governments across the world have largely denied that there are any safety concerns with the RNA vaccines. Now, that's not so tenable.

We had the CDC (US Centres for Disease Control and Prevention) come out last week, talking about the Pericarditis and other Cardiomyopathies that are showing up in the pediatric population - up to the age of 18. That is a significant safety risk. That was only recently identified about two months ago. It has taken two months for the CDC to verify it.

There appear to be a number of other adverse events that are buried within the admittedly flawed databases we have. We are datamining to identify adverse events that are associated with the RNA vaccines. These include Thrombocytopenia (low blood platelets) and that can be associated with bleeding or other problems.

Clearly, there is a signal relating to blood clotting abnormalities, again, as with the adenovirus-vectored vaccines. There is cerebral venous thrombosis. That's a big fancy word, but what it means is blood clots in the veins draining your brain. So you can imagine that's not a very good thing to have. It's kind of related to stroke.

There's a good chance that we're having some of these cardiac symptoms in older age cohorts, but they are subject to what is called masking. This is a problem of looking at databases of epidemiology, and you have a confounding variable. For instance, I am in an age cohort where cardiac events are not rare. The problem is that if you have a relatively rare event associated with a drug or a vaccine, and it's in an age population that has a high background for related things, it's really hard to pick out the stuff that's coming from the new drug, as opposed to the background levels it is masking.

It may turn out over time that we can pick out the cardiac signals that we're seeing in the adolescent population because they have such a low background level. There's very little noise, and it's easy to see the signals.

In older age groups where there's more noise, it's harder to find the signals. But a lot of cardiologists and others are reporting things that are making people uncomfortable. **To be continued.**

PSSSF LOOKS FOR TENANTS FOR ITS COMMERCIAL BUILDINGS AND APARTMENTS TO RAISE REVENUES

HE Public Service Social Security Fund (PSSSF) is looking for tenants for its commercial buildings and modern apartments to raise revenues that would help it to provide improved services and pay retirees.

The fund's senior estate officer, David Mnkande told Property Watch yesterday that they have commercial buildings and modern apartments with office and hotel space, shops, restaurant, malls and conference facilities.

PSSSF has nine commercial buildings in Dar es Salaam, two in Dodoma, one in Arusha, one in Mwanza and one in Mtwara. The modern apartments are located in Dar es Salaam and Arusha regions.

"Customers are willing to rent apartments of their choice being it at Haile Selassie street Dar es Salaam, Kaloleni and Olorieni estates in Arusha city," he said adding the Arusha apartments are located some 4 kilometres from the city centre.

Mnkande added that prices at each of the buildings is negotiable and affordable, noting both the commercial buildings and apartments are fully furnished.

PSSSF public relations manager, James Mlowe added that PSSSF was established by the Public Service Social Security Act of 2018 with the aim of collecting contributions and payment of terminal benefits to employees in public service.

He said members include employees in the public service employed after the commencement of PSSSF Act, employees who are members of the former schemes at the time of commencement of the PSSSF Act and employees employed after the commencement of the act in any specified corporation (company or corporation where the government or its agent owns more than 30% of the share).

Mlowe said the fund offers various benefits to its members including the sickness benefit, death gratuity, unemployment benefit, survivor pension, old age pension, invalidity pension and access to mortgage.

Highlighting on mortgage, he said members can access home mortgages loans from banks using their benefit entitlements as collateral.

For a member to qualify for the loan, he/she must be Tanzanian and has contributed to the fund for at least 10 years.

He said the amount of money to be provided as loan should not exceed 50 per cent of the special lump sum amount where the member has less than 180 months of contribution.

Affordable housing opportunities in Kenya buoyed by government spend and developer incentives

BUOYED by significant government investment in the 2021-22 national budget, combined with attractive incentives for private developers, the affordable housing sector in Kenya is well set to provide attractive opportunities to investors. This is according to Vivian Ombwayo, Director of Research and Valuation at Broll Kenya.

"The affordable housing sector in Kenya offers developers an opportunity to diversify their portfolios, especially those concentrating mainly commercial-user space. It means they are able to diversify into the residential sector, thanks to attractive government incentives," comments Jess Cleland, COO Outside of SA, Valuations & Intel at Broll. Ombwayo and Cleland presented a research report on the sector at the eighth annual East Africa Property Investment (EAPI) Summit from 5 to

Ombwayo highlights that the abundant housing opportunities in Kenya also allow complementary users to be included in affordable housing projects, such as retail, office, institutional and also medical. This means that, at the end of the day, despite having to manage their revenue and cost carefully, private developers are able to achieve a healthy return from comprehensive affordable housing projects.

Another factor to be considered is the social impact of affordable housing, stresses Ombwayo. "We have so many developers, such as those in the private equity space, heavily involved with the social benefits that such projects afford local communities. There are no better projects than affordable housing in this regard."

She elaborates: "It starts off by



elevating the living standards of end users, especially with the Covid-19 pandemic given that health is associated with housing. It also increases the country's employment rate, reduces the crime rate from the community receiving social revenue from such projects and facilitates overall community integration. The associated training and development programmes are also highly beneficial to local communities."

While there is no formal definition of what constitutes affordable housing in the Kenyan property market, according to the Kenya Mortgage Refinance Company Plc (KMRC), the ceiling for a typical three-bedroom unit is four million Kenyan shillings (KES). "However, it is very much dependent on the developers themselves, who often base the definition of affordable housing on not cost alone, but also on the proximity to socioeconomic amenities," notes Ombwayo

The demand base of low- to middle-income earners, which accounts for more than half of the economically active urban population, lends a real impetus to the demand for affordable housing. For example, an online affordable housing platform developed by the government, known as Boma Yangu, has clocked up over 320,000 subscribers to date.

"While private developers are finding it very tight to maintain the ceiling of KES 4 million, we are not really seeing any projects offering anything above the standard typology of three-bedroom apartments," adds Ombwayo. The cost of land within the major urban centres is increasingly pushing developers to the outskirts, where the main attraction is the ready availability of relatively cheaper land.

"The lion's share is being taken up by government projects at the moment. This is mainly driven by availability of land. Land cost is a very important aspect when it comes

to affordable housing, coupled with innovative ways of minimising overall projects costs, such as alternative building technologies. The private sector is yet to catch up, but there has been a lot of traction in recent years, especially as the private sector attempts the tricky balance of cost versus the final price of a unit," explains Ombwayo.

In conclusion, Ombwayo highlights that her outlook for the sector remains "very promising". This is largely due to the fact that, as part of the Affordable Housing Initiative contemplated under the Big 4 Agenda, the Kenyan government has set aside KES 13.9 billion for the Affordable Housing Programme.

"The trying times of the pandemic has opened our eyes to the importance of quality housing as it is linked to health and well-being. The affordable housing sector not only offers scope for developers to add to their revenue base, but also to play a significant role in managing the spread of Covid-19," concludes Ombwayo.

TELECOM NETWORK IN SEYCHELLES TO UNDERGO MAINTENANCE AT WEEKEND

EYCHELLES expects interruptions in telecommunication services from this Saturday evening to midday Sunday when the Seychelles Cable Systems Company undertakes maintenance work.

The company said on Wednesday that according to measurements conducted in May it was determined that there is substantial signal degradation on the land sections of the Seychelles East Africa System (SEAS).

"The cause of the degradation is a land joint in the beach manhole at Beau Vallon in Seychelles and a land joint in Dar es Salaam, Tanzania. The supplier Alcatel Submarine Networks has confirmed that both joints have to be replaced as soon as possible as the signal is continuously degrading and it is highly probable that traffic will cease in a matter of a few months," added the company.

Seychelles Cable Systems Company said that it is also expected that there will be a negative impact on the quality of service on telecommunication services nationally during this period.

Meanwhile, the principal secretary of the Department of Information Communication and Technology, Benjamin Choppy, told SNA on Wednesday that Seychelles expects to see the landing of the second submarine communication cable system - the Pakistan East Africa Cable Express (PEACE) - by the end of the first quarter in 2022.

The second submarine cable system will provide Seychelles, an archipelago in the western Indian Ocean, with connectivity security.



PEACE will run from Pakistan, go up to Europe and come down to Africa. The branch connecting Seychelles will come from Kenya.

Systems Company Limited is expected to cost \$20 million.

"The system has already been manufactured and right now there The project which is being undertaken by the Seychelles Cable are certain planning taking place relating to its deployment," said

"We need to fit ourselves in the timetable of the larger system. Based on the most recent plan of work we have received from Huawei Marine Network, the contractor undertaking the project, our cable will land towards the end of the first quarter of next year, assuming that there will not be any adverse conditions internationally. Commercial operations are expected to start soon after," he added.

The signing for the installation of the cable took place in 2018 and work was expected to start in 2019 and be completed in 2020, however, this was pushed to July 2021 and now to March 2022.

The second submarine cable will land at Perseverance - a man-made island on the north-eastern coast of the main island of Mahe - and at the moment, the new Cable Landing Station is being built and expected to be ready by the end of this month so as to receive equipment that will come in by next August.

Currently, Seychelles has only one fibreoptic cable, built under the Seychelles East Africa System (SEAS) in 2012 connecting the main island - Mahe - to Dar es Salaam, Tanzania.

SEAS supports over 90 percent of internet traffic in the country with the amount on the satellite being minimal.

"The main rationale of the second cable is to provide connectivity security as we currently have only one cable. Should a problem arise on the current cable, we will lose connection and go in the dark. It will be difficult for operators to switch to satellites with the amount of traffic that we have on the current cable," said Choppy.

Govt has not imposed tax on fertiliser -**Prof Mkenda**



CDC INVESTS \$36 MILLION IN DIVERCITY FOR SUSTAINABLE HOUSING IN SOUTH AFRICA

DC Group, the UK government's development finance institution, has invested \$36 million in Divercity Urban Property Fund (Divercity), a platform dedicated to building affordable housing and focusing on the regeneration of South African cities. AfDB's US\$6 million grant cash kicks off desert-to-power **West Africa regional**

THE Board of Directors of the African Development Bank Group has approved a \$6 million grant to launch the initial phase of the Desert to Power West Africa Regional Energy Program. Desert to Power, an initiative led by the Bank, is expected to transform the Sahel by harnessing the region's abundant solar potential.

The grant funding, sourced from the African Development Fund's 15 (ADF-15) Regional Operations Envelope, will go to the West African Power Pool (WAPP) to conduct pre-feasibility studies for the construction of the Sahel Transmission Backbone that will link regional solar parks in all five countries. The Economic Community for West African States (ECOWAS) Centre for Renewable Energy and Energy Efficiency (ECREEE) will also receive financing to expand decentralized energy systems as part of an ECOWAS Regional Mini-Grid Program. The board approval was made on 1

The financing will also help de-risk energy investments by preparing transmission infrastructure to link countries in the Sahel region and harness a larger share of electricity from solar power. This is expected to pave the way for power trading on a regional electricity market. The G-5 Sahel countries are Burkina Faso, Chad, Mali, Mauritania, and Niger.

'The Sahel Backbone is synonymous with the West African Power Pool's drive to reinforce interconnectivity among the ECOWAS national power systems, increase coverage area beyond the ECOWAS geographical space and augment the component of renewable energy within the energy mix," the Secretary General of the West African Power Pool, Siengui Apollinaire Ki said. "The approval of funding by the African **Development Bank represents a** concrete step towards leveraging the solar potential of the Sahel region."

Bah F. M. Saho, acting Executive Director of ECREEE, said: "The funding for the Desert to Power initiative will allow ECREEE to upscale efforts on clean energy mini-grids and improve the availability of locally qualified personnel through the certification of technicians."

The West Africa Regional Program will contribute to the overall target of 10,000 MW of new solar generation capacity, providing electricity access to 250 million people by 2030.

Egypt, Ethiopia compete to export power to Africa

A new battle between Ethiopia and Egypt has surfaced against the backdrop of the dispute over the Grand Ethiopian Renaissance Dam (GERD). The two African countries are now fighting over export of electricity to Africa.

Ethiopia is poised to fulfill its ambition to export electricity from the GERD. Ethiopian Ambassador to Uganda Alemtsehay Meseret held talks with Burundi's minister of water, energy and minerals, Ibrahim Uwizeye on July 7. During the meeting, Uwizeye affirmed that his country is waiting for the completion of the dam to buy electricity from Ethiopia.

Ethiopia is working to generate about 6,000 megawatts (MW) of electric power from the GERD. In 2014, it announced its plan to export 5,000 MW of electricity to neighboring countries and Africa within 10 years.

In June 2020, Ethiopian Prime Minister Abiy Ahmed confirmed at a parliamentary session that "Ethiopia will start exporting electricity from the GERD in 2023."

In turn, Ethiopian Minister of Irrigation Seleshi Bagli announced in April 2021, "The production of electric power from the GERD will start in August, after the completion of the second filling of the dam's reservoir."

Ethiopia already exports electricity to its neighbors Kenya, Sudan and Diibouti. In a report in 2015, Reuters reported that Ethiopia "has signed deals to send power to Tanzania, Rwanda, South



larly from hydropower."

However, Addis Ababa aims to scale up its production and export of hydroelectricity to African countries through the GERD.

Meanwhile, Egypt is making contacts with African countries, especially those Ethiopia aims to export electricity to. Egypt is trying to supply these countries with electricity by helping them establish power plants and exporting electricity to them.

Burundi is one of these African countries and Egypt had offered to invest in the field of electricity in the country. Egyptian President Abdel Fattah al-Sisi stressed, during talks with Burundian President Evariste Ndayishimiye in March 2021, Egypt's keenness to

needs, especially in the electricity sector, by maximizing the investments of specialized Egyptian companies.

In a related context, the Egyptian private company, Orascom, is part of the joint venture constructing the Jiji and Mulembwe hydropower project on Burundi's Jiji River. The project aims to generate a production capacity of 50

In February, Egyptian Ambassador to Burundi Yasser al-Atwy expressed to Uwizeye his country's desire to provide assistance and support to raise the production capacity of electricity in Burundi, and to train Burundian engineers and technicians in the field of electricity.

Egypt also turned to Djibouti. support Burundi's development Sisi visited Djibouti in May and

agreed with his counterpart to increase Egyptian investments and to allow Egyptian companies to contribute to infrastructure pro-

jects, inter alia electricity projects. In February, a delegation comprising a number of Egyptian contracting companies and companies operating in the field of solar energy visited Djibouti. The visit aimed to discuss ways to establish solar energy plants and power plants and encourage the Egyptian private sector to invest in the construction of power plants in Djibouti.

In 2018, the Djiboutian minister of energy and Natural resources, Yonis Ali Guedi, visited Cairo. Guedi concluded a memorandum of understanding on an electricity deal with his Egyptian counterpart, Mohammed Shaker. The cooperation in the field of electricity and establish solar power plants.

Ethiopia exports electricity to Sudan. It showers Khartoum with promises that it will expand exports thanks to the GERD electricity. However, the Egyptian-Sudanese cooperation in the field of electricity, most notably through the electrical interconnection project, has somewhat alleviated the power crisis hitting Sudan. In March, the two countries signed an agreement to raise the capacity of their electrical interconnection from 80 to 300 MW.

Egypt is also helping Tanzania - which had signed contracts to purchase electricity from Ethiopia in 2016 - in the construction of the Julius Nyerere Dam. The dam includes a hydroelectric power plant, the largest in Tanzania, with an capacity of 6,307 MW-hours annually.

Several African countries suffer from an electricity crisis. To fill its power shortage, Kenya agreed to buy 400 MW of energy from Ethiopia. This did not keep it, however, from seeking cooperation with Egypt. Kenya asked Cairo to urge its specialized companies to invest in the field of electricity generation and energy.

In December 2019, Sisi announced his country's readiness to export electricity to African countries at a low price. This came as part of Egypt's plan to expand electricity exports to Africa.

Abbas Sharaki, a professor of water resources at Cairo University, told Al-Monitor that Egypt is

> In statements during his June meeting with President of the Republic of South Sudan Salva Kiir, Egyptian Minister of Irrigation Mohamed Abdel Aty challenged Ethiopia's claims that the GERD will provide electricity to Ethiopia and its neighboring countries.

> Abdel Aty pointed to contradictory statements by Ethiopian officials. He noted that they stress the importance of the GERD in providing electricity to the Ethiopian people who are deprived of electricity, while the Ethiopian government is seeking to export this electricity abroad.

> In a report published in October 2020, the London-based newspaper The Independent had confirmed that half of Ethiopia's population does not have access to electricity.

In first six months in office, Biden faces setbacks, gains

MARKING his first six months in office on Tuesday, U.S. President Joe Biden saw a mixed bag of setbacks and gains.

On controlling the pandemic, millions of Americans have gotten their vaccine jabs. But in other areas, from crime to spending, the president is encountering a headwind. Legislations on gun control, voting rights and police brutality have hit a wall, while a massive bipartisan infrastructure bill is still stuck in the evenly split Senate.

HANDLING THE PANDEMIC

While vaccine distribution got off to a rocky start under former U.S. President Donald Trump, it has accelerated in the first six months during Biden's presidency. As of the July 4th holiday weekend, 67 percent of the population have received at least one dose.

"Dealing with the pandemic has been Biden's biggest accomplishment in the first six months," Clay Ramsay, a researcher at the Center for International and Security Studies at the University of Maryland, told Xinhua.

However, the more contagious Delta variant is spreading across the country, especially in areas with low vaccination rates.

Speaking at a meeting marking his first six months in office on Tuesday, Biden acknowledged that the United States has a long way to go in fighting the pandemic, noting that his administration's focus is on pushing to get the rest of the population vaccinated.

According to data from Johns Hopkins Uni-

versity, the United States has seen more than 609,000 deaths and 34 million cases.

CRIME SURGE

The pandemic has stirred a nationwide crime wave that shows no signs of abating. Many experts, police officers and ordinary Americans fear that multiple U.S. cities will once again plunge back into the wave of violent crime that characterized the early 1990s.

Biden has told states and cities they can use 350 billion U.S. dollars in federal stimulus money to shore up police departments. But even the president himself said he predicts a bloody

More than 180 people were shot dead nationwide over the Fourth of July weekend, as major U.S. cities continue to see a surge in violence, according to data gathered by the Gun Violence Archive, a database that tracks the latest acts of gun violence.

Much of the violence is occurring in Democrat-led cities, and Republicans have lambasted Biden for the crime surge.

James, a retired police officer outside New York City who declined to give his full name, told Xinhua that many police officers are retiring early because of anti-police sentiment in the wake of the 2020 protests and riots over the killing of George Floyd, an unarmed black man, by a white police officer in Minnesota. For his part, Biden said the problem is too many guns on the street.

"I've been at this a long time, and there are things we know that work to reduce gun violence and violent crime," the president said in



a recent speech.

Experts applaud the president's passage of the 1.9-trillion-dollar American Rescue Plan, aimed at bringing relief to the beleaguered economy, which last year suffered the worst recession since the Great Depression nearly a century ago.

"Legislatively, his biggest win thus far has been passing the massive coronavirus relief plan. This fulfilled a major campaign promise and gave an early boost to the economy," Christopher Galdieri, assistant professor at Saint Anselm College, told Xinhua.

Desmond Lachman, resident fellow at the American Enterprise Institute and a former official at the International Monetary Fund, applauded Biden for reinvigorating the U.S. antitrust policy and shining a light on the monopolistic practices of a number of large U.S. tech companies. That offers the prospect of a more competitive U.S. economy that

should be to the consumer's advantage, he told Xinhua. Meanwhile, Lachman, together with some other economists, blasted the president for what they called over-spending.

Biden's main mistake on the economic front has been "excessive public spending," Lachman said, warning that could lead the economy to overheat and could bring an unwelcome burst of inflation in its wake.

IMMIGRATION

Biden and the Democrats are also facing fierce criticism from Republicans on the situation at the southern U.S. border.

U.S. authorities have arrested over one million migrants crossing illegally over the U.S.-Mexico border so far in fiscal year 2021, according to the U.S. Customs and Border Protection (CBP). That's the most since the year 2000.





Biden says he fully realised he was US **President during meeting with Putin**

NEW YORK

US President Joe Biden has fully realized that he was the leader of the American administration during the meeting with his Russian counterpart Vladimir Putin. He stated this during his town hall meeting in Cincinnati, Ohio on Wednesday aired by CNN.

Biden said that the moment it sank in that he was now president, "the leader of the free world," occurred when he was sitting across from Putin as equal. "He knows who I am. I know who he is," Biden said.

The talks between Russian President Vladimir Putin and his US counterpart Joe Biden took place on June 16 in Ge-

This was their first face-to-face meeting as heads of state and also the first Russian-US summit since 2018. In a joint statement, the leaders emphasized that the parties intended to launch an integrated bilateral strategic stability dialogue "that will be substantive and robust."

Additionally, Moscow and Washington intend to begin consultations touching on cybersecurity, an exchange of prisoners, and arms control.

'More than 4 million children' in US infected with COVID-19

MORE than 4 million children in the United States have tested positive for COVID-19 since the onset of the pandemic, according to a latest report of the American Academy of Pediatrics (AAP) and the Children's Hospital Association.

As of July 15, almost 4.09 million children have been infected with COVID-19. After decreases in weekly reported cases over the past couple of months, the country began to see increases in cases in July, according to the report.

Children represented 14.2 percent of all COVID-19 cases in the country, and 0 to 0.26 percent of all COVID-19 deaths, according to the report.

COVID-19 cases, hospitalizations and deaths were all up double digits in recent weeks as the highly contagious Delta variant spreads across the US.

US President Joe Biden said the Centers for Disease Control (CDC) is likely to advise that kids who haven't been vaccinated should wear masks when they return from summer holidays to school in the fall.

He also said that those under 12 years old will be able to get inoculated "soon".

Biden urged more Americans to get vaccinated against COVID-19, saying that the coronavirus is only raging among those who have not received their shots.

New York City will begin requiring vaccinations or weekly testing of all workers in its public hospitals and clinics in an attempt to slow an increase in cases.

Iran opens oil terminal in Gulf of Oman to bypass Strait of Hormuz

IRAN has opened its first oil terminal in the Gulf of Oman, President Hassan Rouhani said yesterday, to allow Iranian tankers to avoid using the strategically vulnerable Strait of Hormuz, which has been a focus of regional tension for decades.

"This is a strategic move and an important step for Iran. It will secure the continuation of our oil exports," Rouhani said in a televised speech. "This new crude export terminal shows the failure of Washington's sanctions on Iran."

Rouhani said Iran aimed to export 1 million barrels per day (bpd) of oil from Bandar-e Jask, a port on Iran's Gulf of Oman coast, just south of the Strait of Hormuz.

Iran has often threatened

to block the Strait if its crude exports were shutdown by US sanctions, reimposed by Washington three years ago when then president Donald Trump abandoned Tehran's nuclear deal with six major powers.

Tehran and US President Joe Biden's administration have been in indirect talks in Vienna since early April to revive the deal, under which Iran agreed to curb its nuclear program in return for the lifting of most international sanctions. "The implementation of the

Goreh-Jask port crude oil transfer project took place with about US\$2 billion investment," Iran's Oil Minister Bijan Zanganeh said, according to the ministry's SHANA website.

'Pairing assistance' programme in China introduces fruits from Xinjiang to rest of the country

IN midsummer as northwest China's Xinjiang Uygur autonomous region is filled with fragrances from various kinds of ripe fruits, a steady stream of trucks fully loaded with fresh fruits leave major logistics centers in the region for buyers

across the country. Limited by long transport distances and poor logistics, Xinjiang had difficulty introducing forest products and fruits to other regions of China. Fortunately, many Chinese provinces and cities have given full play to their respective advantages of markets and resources to help the region sell its characteristic agricultural products through

online and offline channels under China's "pairing assistance" program in which they have paired up with Xinjiang to assist

it with development. While helping sell forest products and fruits of Xinjiang, these provinces and municipalities have facilitated the agricultural structure adjustment and increased the income of farmers and herdsmen in the region.

Fruit grower Maimaijiang Abudureheman in Hongqipo Farm, Aksu city, Aksu prefecture of Xinjiang, who used to feel anxious about the sale of his fruits during harvest season, now see buyers come to his orchard when fruits are still on the branches.

In July 2020, Abudureheman signed a contract with a local agriculture company to have all the fruits produced in his orchard purchased by the company and then sold in cities across the country via the "ten cities, one hundred stores" project jointly launched by Xinjiang and east China's Zhejiang

The project aims to, through multiple cooperation models, build public warehouses in 10 prefecture-level cities in Zhejiang for featured products from Aksu prefecture of Xinjiang and form more than 100 retail outlets for the marketing of these

products, according to Chen Haitao, deputy head of the command center of Zhejiang province for providing pairing assistance for Xinjiang.

From the beginning of 2020 to June 2021, Zhejiang province sold 350,000 tons of agricultural products from Aksu prefecture and the 1st division of Xinjiang Production and Construction Corps via online and offline channels of the "ten cities, one hundred stores" project, with the sales volume reaching five billion yuan (\$771 million).

In June this year, officials dispatched from Shenzhen city in south China's Guangdong province to assist Xinjiang's development hosted a livestreaming show in Amanla village, Awati township, Kashi city, Xinjiang, to sell apricots for the village.

Within two hours, the apricots of the village were sold out and the total sales exceeded 60,000 yuan. It was the second consecutive year that these officials hosted livestreaming promotion for local products in Xinjiang.

Besides actively establishing online marketing platforms together with many companies, the command center of Shenzhen for providing pairing assistance for Xinjiang has

also set up dedicated counters for agricultural products from Kashi city in gas stations and service areas, and facilitated the entry of agricultural and sideline products from Kashi into the purchasing system of supermarket chains in Shenz-

Last year, Shenzhen helped sell 11,600 tons of agricultural products worth of 230 million yuan from Kashi.

Since 2018, the command center of east China's Shandong province for providing pairing assistance for Xinjiang has implemented an innovative project to reduce poverty in Xinjiang through promoting

consumer spending on products from poor areas in the region.

Under the project, more than 100 agricultural product processing and marketing enterprises in Shandong and Xinjiang have been motivated to establish a supply and marketing cooperative alliance, and set up front-end warehousebased sales platforms for characteristic agricultural and sideline products from Kashi.

Products sold on these platforms are purchased directly from their planting bases and transported through a unified logistics system.

China rejects 'compromised' WHO plan for virus origin study

CHINA cannot accept the current version of the second phase investigation into the origins of the CO-VID-19 virus launched by the World Health Organization, for the plan has been compromised by political manipulation and disrespect of scientific facts, Zeng Yixin, deputy head of the National Health Commission, said at a news briefing yes-

Zeng said the plan has listed the hypothesis that China had violated lab regulations and leaked the virus as one of the major research objectives, which left him "very shocked" after reading the proposal.

Zeng said Chinese experts have voiced their concerns and suggestions for improving the investigation plan to the WHO.

What has been carried out in the first stage of origin tracing, especially those that have reached a clear conclusion, should not be repeated, Zeng said.

"We hope the WHO can carefully consider the advice by Chinese scientists, take investigating the origin of the COVID-19 virus as a scientific question free from political interference, and proactively and properly conduct sustained investigations into the origin of the virus in various countries across the world," he

Only by conducting sciencebased origin-tracing of COVID-19 virus, can we uncover the real truth, said Xu Nanping, vice-minister of Science and Technology, at the

Experts attending the news conference also called for the international scientific community to con-

duct multifaceted, dynamic, and wide-ranging investigations around the world on the origins of the CO-VID-19 virus, and not limit their options to a couple of hypotheses and destinations.

Liang Wannian, team leader of the Chinese side of the WHO-China joint expert team, said the place of origin and transmission of the CO-VID-19 virus is more complicated and puzzling than previously anticipated, as countries around the world have reported finding traces of the virus in clinical samples and environment months before their first reported COVID-19 cases, with some dating even earlier than the first reported case in China in late December of 2019.

Liang said it was key to investigate other countries and regions concurrently to better understand the early clinical cases, genetic sequence of the virus, as well as its methods of transmission including natural spillover, spread through intermediate host, and the role of cold-chain logistics.

Claims against Wuhan lab 'based on thin air'

Meanwhile, Chinese expects rejected claims that the Wuhan Institute of Virology had three infected workers, carried out gain-of-function research and engineered the

Yuan Zhiming, a researcher at the institute in Wuhan, Hubei province, said the institute had not come in contact, stored or researched the virus before Dec 30, 2019. Yuan is also the director of the National Biosafety Laboratory in Wuhan.

"The infrastructure, management, team composition and work-

ing protocols at the institute's P4 biosafety laboratory are the same as other P4 labs in operation," he said at the news briefing "Since the laboratory began operating in 2018. no laboratory leaks or human infections have ever occurred."

Yuan said the laboratory has stable and reliable biosafety precautions in place, and has established a set of complete biosafety management systems and a professional team to bolster, manage and maintain its operation.

Refuting the allegation that three workers at the institute were infected with the disease in November 2019, Yuan said people propagating the claim were never able to provide names of the alleged researchers. "The claim has been created out of thin air," he said.

He said unfounded accusations that implicate the institute as the source of the outbreak has disturbed the institute's scientific research work and disrupted international communication and coop-

China 'shared all data' with

Earlier this year, Chinese and international experts visited Wuhan to study the origin of the virus, which was organized by the WHO.

China allowed the experts to visit all places they wanted to go and meet all people they wanted to see during the visit, Zeng noted.

The results of the WHO-China joint study are able to stand the test of time, said Zeng.

China had presented sufficient data in accordance with the requests by experts from the WHO mission, said Liang from the Chinese side of the joint expert team.

He said China had shared clinical data of early COVID-19 patients, information from epidemiological surveys, and lab test results with the expert team for joint study and analysis, and the findings were later published in the WHO report.

However, Liang said the data contained personal information and it is against relevant laws and regulations in China to allow the data to be taken to other countries.

The Chinese side had explained the situation to foreign experts, and after reaching a consensus, the data was made available to the joint expert team during their mission, but experts could not take photos or make copy of the raw data, he said.

China has not purposefully withhold data from the research team, and the credibility of the conclusions from the joint report is not undermined simply because China wants to protect its citizen's privacy by not allowing experts to take their personal data with them to other countries, said Liang.

During their visit, the joint expert team conducted field visits at the Wuhan institute, and in particular, learned about the institute's implementation of management and safety regulations, as well as its past and current research projects, Liang said.

The mission had reached the conclusion that it is extremely unlikely that the virus originated from a laboratory, he said.

Chinese researchers suggested that more probe should be directed to countries where P4 laboratories had not been visited by international experts, reviewing possible safety risks and laboratory incidents there, Liang said.

The region that reported the earliest cases is not necessarily where the virus jumped from animals to humans, Liang noted.

Evidence showed the possibility of the virus transmission through cold chain, said Wang Chen, an academician of the Chinese Academy of Engineering.

ROK: US hoping for DPRK's response to offers of talks

SEOUL

THE United States is hoping that the Democratic People's Republic of Korea (DPRK) responds to its offer to re-open talks on denuclearization, the Republic of Korea's (ROK) presidential office said yesterday, citing US Deputy Secretary of State Wendy Sherman.

Sherman, a veteran diplomat with extensive experience in dealing with the DPRK, met President Moon Jae-in after arriving in Seoul late on Wednesday from Tokyo on her second stop on a tour of Asia.

The DPRK has rebuffed proposals from the new US administration of President Joe Biden for talks, raising new doubts about prospects for pressing it to give up its nuclear weapon and missile

"We are hoping that North Korea will respond to our offers of talks at an early stage," Moon's office quoted Sherman as telling the the ROK's president, who has also been trying to encourage negotiations. The DPRK is also referred to as North Korea.

Moon asked Sherman to try to re-engage with the DPRK, stressing the allies' shared goals of complete denuclearisation and peace on the Korean peninsula, which were reaffirmed in talks with Biden in May.

Sherman called for more cooperation on other issues including climate change, Moon's office said.

Sherman is scheduled to hold bilateral talks with the ROK's Vice Foreign Minister Choi Jong-kun yesterday before leaving for Mon-

SUGGESTIONS that the novel coronavirus was circulating in Europe months before China officially confirmed the first case in Wuhan have been revived by a new study of blood samples collected in Italy

as early as October 2019. Cancer researchers at Istituto Nazionale dei Tumori in Milan reported in a paper published on Monday that renewed tests of pre-pandemic blood samples at two laboratories were found to have antibodies normally associated with the COVID-19 infection.

"The results of this retesting suggest that what we previously

reported in asymptomatic patients is a plausible signal of early circulation of the virus in Italy," Giovanni Apolone, one of the researchers, told the Finan-

cial Times. "If this is confirmed, this would explain the explosion of symptomatic cases observed in Italy. SARS-CoV-2, or an earlier version, circulated silently, under the surface."

Before the pandemic started, Italian researchers had screened 959 individuals for lung cancer, and last year they retested those samples looking for coronavirus-linked antibodies. They claimed they had found traces of COVID-19 infection in some samples.

The World Health Organization asked for further testing to be carried out, and the samples were sent to the VisMederi laboratory in Siena, Italy, and to a facility at Erasmus University in the Netherlands, affiliated

with the WHO.

Positive readings Three samples from

the new tests were found by both Erasmus and Vis-Mederi to have positive readings for the COVID-19-linked antibody IgM, according to the Financial

Lab researchers retested 29 of the Italian samples, including some positive and some negative. They also retested 29 control cases

from 2018. The paper has been published as a preprint on the science website medRxiv and has not yet been peer-reviewed. Marion Koopmans, head of virology at Erasmus University, said the new research may not be conclusive.

She said results from the new study were "interesting", but according to the university's strict criteria, none of the samples provided conclusive proof of prior COVID-19 infection.

"We use a rather stringent threshold and cannot rule out that some of the observed reactivity is real," she was quoted as saying by the FT. "However, for confirmation of earlier circulation, we would recommend studies of patients with unexplained illness for virological confirmation. That does not mean it is impossible ... Just that you would like to see other pieces of evidence."

The study stated that

none of the samples contained "high enough levels of each of the three types of antibodies" that Erasmus requires to be considered proof of infection.

Gabriella Sozzi, one of the Italian researchers, said that in nine samples that VisMederi said were positive for infection, "levels of IgM antibodies were below the cutoff point set by Erasmus".

The virus may have been "less aggressive or contagious" in the prepandemic period, Sozzi told the FT, adding that this made it "necessary to use highly sensitive tests despite the risk of finding 'false positive'

Change of coach at Fenerbahce uplifts Samatta, successor hits at KRC Genk

VISITING the country just over one month ago, Tanzania's senior national soccer team 'Taifa Stars' captain, Mbwana Samatta, was still unsure of his playing destination either at the start of the new season or at the expiry of his loan transfer to Turkish giants, Fenerbahce, from England club, Aston

Things are more than clear at this moment but in a direction that could only be roughly gauged at that time, and with additional inputs that help to uplift the situation for the ace forward now closing in on the half-decade in the European premier league circuit.

The new situation has to do with Fenerbahce assigning a new coach, who is warmer to Samatta's game.

Not that Samatta's game has been poor at any level, as he was first instrumental in bringing up well-rated Belgian club, KRC Genk, even to the UEFA Champions League, and in his first year there, the EUROPA League.

This brought him to being noticed by scouts of England Premier League clubs, so Aston Villa brought him on as a stand-in player, for whom they paid around 8m dollars at midseason recruitment period, and then beefed up the squad with a 25m euro signing like Oliver Watkins, clearly an inspiration for the club's performance in the past season. The relegation threat was relegated deep and far.

In that case, Samatta proved to be inspirational at KRC Genk and that is why he was tapped for Aston Villa, but they did not rate him too highly and were not mistaken, he scored a goal in his half-season there despite coming close to score against Liverpool in a league game at the point of his arrival.

It is not hence surprising that he has largely been middle of the road at Fenerbahce, as the Turkish league is slotted a shoulder above the Belgian league where Samatta was truly inspirational.

And definitely, it stands below the England Premier League where one could easily say that Samatta was part of 'also rans' at Villa Park.

Still, it was not a straightforward issue whether he remains at the top of the cards Turkish premier league side or is placed on another loan, in the unlikely event of a full return to Aston Villa with the beefing up recruitments performed last season.

What is heartening is that Fenerbahce has a new coach who appears to take more seriously the performance of the Taifa Stars captain, and he has reportedly convinced the club administrators to give him a three-year contract extension.

Those observant of options in a game and squad building shall realize that such an extension is an expression of full confidence, nothing short of that, as a one-year contract is itself an expression of confidence; three years is even to overdo it.

At the same time, Samatta has heartwarming news that a Tanzanian player, Kelvin John, is doing well as a newcomer at his old club, KRC Genk, with local newspapers reporting that he had started scoring at his debut.

That would have been big news were it not that it was a scoring spree, thus creating opportunities for several players to make it to the list of scorers, whereas remarkable goals are those which attest to individual skills that make a difference in the game, not a spree.

Kelvin John has a potentially good future at the club as he is still youthful, unlike Samatta who went there at midcareer, in which case it is a matter of how the coach shall be able to obtain the best in him, if the techniques match with his abilities, it can't be fore-told

This playing level is indicative of the fact that Tanzania is beginning to be dotted with players who can besides.

make a difference, and even in the local premier league, their ability to compete with foreign recruits or 'professionals' is beginning to be felt.

While Meddie Kagere was in past years undisputed top scorer at Simba SC, just like Emmanuel Okwi had done earlier, this year it is John Bocco who topped the scoring charts.

It is an illustration of the fact that with good academies and training there is no reason for local players not to put up good competition to foreign recruits, and this uplifts the level of play as a whole.

There is another player who only partially carries the Tanzanian image while not having the flag as he has a different passport, but he makes the point by having his shirt in the Danish national side identifying him as Yusuf rather than Poulsen, his proper clan name in Denmark.

As he attempted to find out if he could feature for Taifa Stars despite having the Danish nationality- as it is a matter of opting for which country one plays for, not a choice of citizenship based on FIFA rules - it is right to keep remembering that he has a part of his heart with Tanzania.

So he forms part of our image outside like others if they appear for nearby or far off clubs, like TP Mazembe next door, Maccabi Haifa 'across the street,' and others besides.

Q&A with USMNT's McKenzie: Racial abuse 'happens a lot more than people think'

IN June, the United States men's national team defeated Mexico 3-2 in the CONCACAF Nations League final. It was a moment to savor for U.S. Soccer, lifting a trophy at the expense of its biggest rival.

But there were countless more headlines written about what followed: Defender Mark McKenzie was subjected to racial abuse on social media in the wake of that win. There have been several more stories of a similar nature in the past month, notably the racial abuse Black England players received after their Euro 2020 final defeat to Italy.

Last month, ESPN's Jeff Carlisle spoke at length with McKenzie to discuss that Mexico game, the prevalence of racial abuse, the ways he's working to increase awareness and combat racism, and much more.

(Editor's note: This interview has been edited for brevity and clarity.)

ESPN: How are you holding up?

McKenzie: It's what comes with the territory, right? As a professional athlete, there's always going to be eyes and ears on you when you play in high-stakes moments. Things happen. And as a young player, I try not to [dwell] too much ... Everyone's going to make mistakes, and as a defender, those things are more costly than others. So playing against Mexico, I give a bad pass and it turns right into a goal.

We got punished for it, and ultimately, all eyes turned on me and how I would react. So yeah, it was a moment that in retrospect you can always look back on and wish things had happened differently, but I think I try to take the best out of it, because it's a learning experience for me on understanding the occasion, how to deal with certain things and then ultimately figuring out if I had the fortitude, the resilience, the character to really fight, to really put myself back into the game.

I held my own, but again that mistake. These are mistakes that people are going to put a spotlight on, and emphasize. Now it becomes. "Mark McKenzie can't play at this level. He's not meant to be on the national team, and he's not ready to compete in these big important matches." And I spoke to my dad, and he was like, "Look, the speed, the rate at which people will love you is the same rate at which people will hate you, and criticize you." So you got to take that with a grain of salt because some could never play in the same shoes that you're in. They could never deal with the same situations that you're in.

At the end of the day, I know myself. I know what kind of player I am. I know that one mistake doesn't define me, that 63 seconds doesn't define me. I know I have an extremely high ceiling that I'm still just tapping into. There's areas of my game I still need to improve on. So by no means am I saying I'm this well-rounded, perfectly slated player, as I showed in the match. And that's something I look forward to, to challenging myself to step into that room of, "Where do I need to improve?" and bringing up my game even more. So again, it's a learning experience for me, and one I'm extremely thankful and blessed that I played in that situation, played in a CONCACAF final for my national team.

ESPN: You experience the euphoria of the Nations League win, then you go on Instagram and you see some of the racist comments directed at you. How often does that happen?

McKenzie: It happens a lot more than people think. And people will say -- and I keep using the general term "people" because I don't want to say it's one person or another person -- but people in general have the perception that I was posting about these racial comments and racial slurs like, "Ah, it's not a big deal. It's just a comment." But

that's the reason why I feel like we've gotten to this point is because we automatically, as soon as something happens, we want to get it over with as soon as possible [and] not be faced with the fact that this is a long-term issue. This is a problem that will not get dealt with unless it's on the front of our minds. When we put it to the back of our heads, we now become complacent, lackadaisical, it's not a priority anymore.

But why is it now that when these comments and slurs come up, that when we post them, it seems to be a problem? Why is it that when we have these issues that pop up in our society around these race, racial sensitivity or homophobic insensitivity or whatever issues we were facing in society, why is it that now when you post about it, it becomes, "Ah, you know, you guys keep doing the same thing. It's just a comment." Yeah, if it's just a comment, then why do we keep coming back to it? Why is it that this is still plaguing [society]? Why is it still this common theme that we find out that we see on a regular basis? If it doesn't become a priority then it's just going to become a normality in our lives, right? So, me posting about it -- in my eyes, at least -- is not giving these people attention, but to remind us that this is still going on.

I have comments going on, "Hang yourself. You suck and you don't belong on the national team," this, that and the other. All over 60 seconds, and in a sport that I've loved and I've sacrificed my entire life for.

In a way I'm entertaining thousands of other people with my teammates, and then the other team. We're doing this because we love the game. And as a byproduct we are entertaining many others. But the moment something happens out of your control, something happens that you're not pleased with, now it becomes a "Pick this guy out and really get at him. Eat him [alive]."

We're humans too, man. That was my biggest thing, not to highlight the mistake, but to highlight the fact this is a commonality. It's one thing to critique my game -- I understand I made a mistake, I'll learn from it, that's no problem -- but to dig at somebody for something so degrading, to use comments and slurs that are demoralizing, that are making people feel belittled is too far. It's way too far. Critique my game all you want, but don't attack my family, and don't attack me for my race. It's unnecessary. It's completely unnecessary. Let's keep this where it belongs and keep us in the game, and not take it over the line.

ESPN: Do you think people think you're only dealing with it for the first, the fifth or the 10th time, as opposed to the 500th or the 1,000th or the 10,000th time? Do you think there's a lack of recognition of that?

McKenzie: Yeah, I think because for me, I try not to overly saturate my media outlets with these issues sometimes, because I feel like at some point, it can become overwhelming for people. People can only handle so much, right? They can digest only so much at one time. So when the moment is right, I choose that moment, I go hard at it, allow it to sit, saturate, so that people can really, really feel where I'm coming from. I really feel this on a level that's going to be beneficial. And if I keep going over and over again, sometimes people will now turn a blind eye like, "You're going overboard with this." But that's sad, because this has happened to me over 50 times.

ESPN: After a game

McKenzie: After games, I'll get messages. This is not uncommon. It's sad to say, but it's the sad reality. This is a common theme that we've seen, and I'm not the only player at the camp who received racial slurs and racially insensitive comments following the match. So again, I don't want to overwhelm people, but I also want people to understand this is like, this is the daily thing, this is a more common theme than you would ever know. Also me posting this is just one instance. For the same tournament, I could have gotten 100 other comments as well that I didn't post about. So it's about understanding that this is a reminder: Let's not get comfortable, because the more you get comfortable is the moment you leave the door open for more. And that's why you know it's so important for us to continue to fight.

ESPN: To what degree are efforts with the national team or Black Players for Change continuing, and how hard is it when you're overseas to stay connected to those efforts?

McKenzie: Yeah, it's difficult because the time difference, man, is plus-six hours. It gets difficult because the meetings will be at 7 o'clock in the evening [ET], but it's almost 2 a.m. where I'm at. I still speak with guys in MLS about the issues, about ideas and ways we can continue to push things in the right direction and to keep applying pressure to these issues.

It's still going on, not only in our game but in society. Also getting active in Europe, finding ways where I can now play a role in advancing these dilemmas, that [we] still have faced in Europe. Let's not take away from the fact that the same way that racism goes on in America, there's still racism in Europe as well. There's still the comments, after games and whatnot. Reggie Cannon was going through it in Portugal a few months ago so let's not get away from that.

Connecting with my teammates, connecting with different organizations here in Europe, I think has been also very important. So that way, now we can kind of create a bridge between the two worlds. Now you can merge ideas or create different ways of attacking the issues, because sometimes going through one way may not do it. But I see it from another perspec-

tive, you may actually hit it on the head, or you may get an idea from this perspective that now triggers the addressing of an issue in this area here. So there's so many ways that we can really connect. So I think me establishing my life in Europe as well, but also having had a life in America, in working with different nations has given me the ability to work from both sides. It's extremely important that we continue to have these conversations from across the pond.

ESPN: To what extent have your white teammates in Belgium, and even your former teammates who are white back in MLS, reached out to try to shoulder some of this responsibility?

McKenzie: Yeah, they've been extremely, one, supportive, but two, active, and trying to find ways to be active when these issues arise. I think, one, my team back in MLS, having real conversations with them, the uncomfortable conversations as this has really been the place that it started, in the locker room, talking and hearing the stories from people you care about, people you work with on a daily basis. And these raw stories, not stories that are filtered and sometimes can get portrayed in a different way, but were all instances that are unfiltered, and will make you feel emotionally. I think that's where it all started.

And they've been active, donating towards resources that will provide opportunities for those to hear and learn. [My teammates], they came to me and really wanted to hear about individuals to speak to, whether it be those at the Boys and Girls Club, or local resources to provide opportunities for those in more difficult situations, those in inner-city communities. How can I help create this bridge? How can I make these individuals feel like I care about them? How do I make these kids feel like it's real, you can have a real talk, not feel like I'm talking at a wall? How can I really get involved? I don't want it to just be me going out and speaking with parents and then never come back. I want to be that guy that kids can lean on and shoot them a message, "Hey, I'm going through some stuff. Can you talk?" That was real for me. I think that's a real way of getting involved in the community.

So I was talking to my dad, a karate teacher, and who is a former police officer, and he explained both situations. One, how these inner-city community kids have a difficult time seeing the police, and two how the police just want to go home [every day]. To deal with those situations, and then how I'm working with some local individuals here on creating that here in Delaware, and wanting to have the opportunity to bridge that connection between the community and law enforcement, because I have family in law enforcement, but I also have individuals who I know have gone through some instances with law enforcement that have scarred them. So that's something that I'm trying to work on.

Here in the States, it's in your face, and it's very prevalent. So I think a lot of my white counterparts, teammates, acquaintances, friends, they've been very open to dealing with the uncomfortable situations, and the uncomfortable conversations. And then my teammates in Belgium, it's a very diverse locker room we have. So me bringing my American experience, but also providing some of the perspective that I've heard from my European teammates, of how they've been affected, and how the kneeling in England has caused boos from fans and supporters and that's the exact reason why they're kneeling.

ESPN: With kneeling in mind, what did you make of England and Ireland players getting booed for doing so earlier this summer?

McKenzie: So I think that's one instance why we're kneeling. For me, I didn't want it to become just a part of the pregame ritual, but I wanted it to have purpose, and the boos have kind of reinvigorated that purpose of the kneeling, why it's so important, and why the activism can't stop. Why we have to constantly keep the foot on the gas with these issues because when it becomes a commonality, and when you feel like it becomes a formality, and you see it all the time ... that's what I meant when I said overwhelming. You know when people get tired of seeing it, they'll let you know. But that's the exact moment where you then have to retreat and say, "Hey, don't forget."

So, yeah, I think the whole England situation, I think they've been handling it top-class. Again, it's a wake-up call for a lot of people to reassess their values. You love the national team, but do you love the Blackness of the national team? Is that uncomfortable? Is it uncomfortable having a national team speak up on instances, on issues that you're not comfortable with? If that's the case, then that's the exact reason why you should really start to wake up.

ESPN: Is social media worth it?

McKenzie: To be honest, I go through periods during the year where I'll just disconnect from it altogether because it's a lot. It's a great way to connect with people you haven't connected with [before], or individuals or network or established business relationships. On the other hand, we see the difficult side, the negative side of social media, and how it can be this depressing, overwhelming reminder that there are still many who haven't come to grips with the fact that social media is supposed to be a uniting force. I had teammates who altogether deleted profiles and delete their accounts just because it's too much.

You could have those in your agency, or whoever, take over your social media, but it's supposed to be coming from you. It's supposed to be a representation of you as a player, as a person, and you want to have some role in that. But on the other end, it can be too much, because if you spend too much time on it, you'll find what you don't want to find sometimes. It's difficult. It's a difficult one.

So for me, I try to disconnect from it. And I think everybody should do that. I think we spend so much time on our phones now. We need to look around. Work has bogged us down so much that it feels like we have to stay connected at all times. But at the same time it's extremely important for us to remind ourselves of all the things going on around us, remind ourselves that there's a lot more to life than this little 7-by-3-inch device, or laptops or iPads or whatever it is. I have so many devices. I've got my iPad next to me, man. Like, for what?

I can't express it enough, that's extremely important for us, to remind ourselves of the things that are really important in our lives. And that at the end of the day, we're not going to be able to make everyone like us. It's difficult. It's difficult for me to say; it's difficult for just about anyone. Everyone is not going to like you, and that's just the reality of it. So why spend so much time trying to impress people who may not ever like me when I got what I need right here in front of me? I'm trying to make somebody living in the other part of the world like the fact that I play for this club, or that I have a Nike contract or that I travel to Hawaii. Enjoy Hawaii, man. Enjoy the trip. Enjoy the fact that you are able to do what you love to do on a daily basis. Don't forget that each day is a blessing, and I think this period here has really taught me that, how to just enjoy this. It's going to come with ups and downs. It's going to come with difficult situations, adversity. But I got what I need. I'm blessed to say that, and there's a lot more going on as well than just on social media, so kind of wake

ESPN: Was it jarring for you to go from the U.S. -- with the George Floyd trial and the protests of the past year -- to Belgium?

McKenzie: Yeah, I think it was a lot to take in. Just because, for me personally, I see it, you know, "What if that was me?" That's the biggest theme I get across to people who ask about the situation. And then to have everything happen and to then leave, having a lot of time and thinking to myself ways that I could be even more active, ways that I can help even more. But it was a lot. It was a lot in that period of time, and with COVID, it was a lot to take in. So that gave me perspective, because I needed to get even more active, I need to take a more active role. It was a wake-up call for myself that I wasn't doing enough, that I could do more. So I tried to take that, and run with it

I'm very, very sad, and that it had to be with the death of George Floyd and people saying, "He died for this." No, he didn't die for this. He wasn't sacrificed for this. This is something that we as a society, as a human race, could have done so much more. We've had instances where people have lost their lives, but what were we doing before then to really get this issue fixed, to find some kind of resolve? No, he wasn't sacrificed for this. He didn't have to lose his life, and we could have taken steps prior to that incident to keep that incident from happening. And there's a number of situations where that individual didn't have to lose their lives for us to take action.

And unfortunately after those instances, we took action for a period and then we stopped taking action. And that's why we continue to have these issues, to have these situations that pop up. So yeah, I think that that was for me the biggest thing, not wanting this to be the trend again, to go through the hashtag. Nobody should be a hashtag. It's sad that social media has turned this hashtag into ... that's not the way it should be and it's never the way it was meant to be.
