## Alarm as extensively mutated COVID-19 new variant spreads out

#### **By Guardian Reporter**

A NUMBER of countries where Covid-19 restrictions have been relaxed are starting to reintroduce them in the wake of isolating a new, heavily mutated variant discovered in South Africa and was fast-spreading to neighbouring countries and abroad by means of travel. England and Wales suspended direct flights from South Africa as well as other African countries where the variant was detected, namely Namibia, Zimbabwe, Botswana, Lesotho and Eswatini. News agencies said the variant was also detected in Hong Kong. The flights were suspended until a hotel quarantine procedure is in place, with an official announcement that travellers

THE government has appealed to the country's development partners to extend financial and technical assistance to support the forthcoming 2022 Population and Housing Census.

Finance and Planning minister Dr Mwigulu Nchemba issued this appeal in Dar es Salaam yesterday at the opening of a strategic dialogue meeting with the development partners, a high-level meeting involving ministers, envoys, the private sector and key civil society groups.

He praised the various development partners for the contributions in the preparatory stages of the census as a vital national development initiative, urging them to sustain this support.

The country needs important statistics to be able to plan and implement development strategies effectively, as accurate information will support social sector reforms, enabling local government authorities allocate resources according to needs, thus stimulating social and economic development.

The meeting is intended to focus on policy issues and ongoing plans, while the development partners use that occasion to shape their participation in implementing the plans on the basis of a prior monitoring exercise and the strategic dialogue.

The meeting involved the private sector and civil society as key stakeholders in development, also reflecting government intention to create an enabling environment for private sector growth, creating jobs and boosting incomes, he stated.

The UK's decision to reimpose travel restrictions on South Africa comes not long after the country was struck off the red list in October. Optimists said that a number of variants looked bad on paper earlier but haven't taken off and caused devastation, but the pernicious Delta variant is still causing mayhem with parts of Central Europe imposing lockdowns once again.

umbrella think tank, under the theme "Domestic and Export Markets: What are the Opportunities and Challenges Facing Agriculture Smallholder Producers?"

Activists in the agriculture smallholder producers group want the government to take up the declaration in earnest, with the director affirming that while the agricultural sector is the means of life for around 65.3 per cent of the population, budget allocations for the sector hover around 6.0 per cent in the past five years.

Smallholder farmers are central to an inclusive development process so the government should consider investing in their

technical capacity to enhance efficiency, compete favourably in local and foreign markets," he said.

The government needs to come up with an enabling mechanism to bring up inclusive and supportive agricultural policies so as to ensure sustainability of the agriculture sector, he stated, underlining that small holder farmers contribute over 80 per cent of food requirements.

Tanzania in the 2020/2021 financial year recorded a food surplus of 3.7m tons of cereals and 2.1m tonnes of non-cereal crops, while the livestock sector grew by 5 per cent in 2020 and contributed 1.7 per cent of the country's Gross Domestic Product (GDP), he

"Since 2008, dairy production has grown on an average of 5.3 per cent per annum. Consumption of milk is low at 49 litres per capita while the World Health Organisation (WHO) guidelines require 200 litres," he asserted, pointing at horticulture industry as attaining 9.0 per cent to 12.0 per cent annu-

The sector employs about 2.5m people of whom more than two thirds are women, while its export value grew from \$64m in 2005 to \$779, in 2019, he elaborated.

He similarly urged small holder farmers to ensure value addition to their products to make them competitive at the local and regional level in particular, challenging the youth to embrace agro-sector opportunities. Their interest in agriculture would trigger surplus production in the long run, he

Deo Shayo, the small and medium enterprises (SMEs) development officer for the Tanzania Trade Development Authority (TanTrade) pointed at numerous unexploited agro-sector opportunities.

TanTrade in partnership with other government agencies and embassies abroad will be coming up with a one stop online platform to give information on available opportunities for investors outside the country, he told the gathering.

"We will continue working with smallholder producers to ensure that they take advantage of these opportunities at district and regional levels," he added.

# TMDA to augment clinical research ethics, medicines regulatory capacity

THE Tanzania Medicines and Medical Devices Authority (TMDA) has started to improve its systems for up-scaling of clinical research ethics and medicines regulatory capacity to monitor and regulate medical researches and trials in the country.

The improvement of systems is conducted through the ASCEND project: "Moving Tanzania's Clinical Research Ethics and Medicines Regulatory Capacity to the next level: Fostering Medicine Quality, Safety and GCP Clinical Trials.

TMDA Director General Adam Fimbo said this in Dar es Salaam yester-ASCEND Project annual implementa-

The meeting brought together project consortium institutions.

"The project expected to strengthen pharmacovigilance systems to increase reports on adverse events and reactions originating from clinical trials and establishing an effective system for information sharing," he said.

Fimbo applauded the European Development Countries Clinical Trials Partnership (EDCTP) for funding the project worth Euro 498,750 where the process of funding acquisition began in October 2019.

TMDA manager clinical trial & pharmacovigilance, Kissa Mwamwitwa said the project will help to day when giving an overview of the improve the efficiency and quality of the work of the national research eth-

trial reviews and pharmacovigilance.

She said the project intends to "Moving Tanzania's clinical research ethics and medicines regulatory capacity to the next level: Fostering medicine quality, safety and good clinical practice on Clinical trials."

Director of Kilimanjaro Clinical Research Institute (KCRI) Dr. Blandina Mmbaga said: "We (as part of the project) are involved in conducting various studies and we know the importance of research. We have been able to create a curriculum for research ethics, the curriculum is used by universities in the country."

Dr. Ame Masemo Director of Research, Coordination and Promotion from Zanzibar Health Research

# Acute smuggling plundering Lake Tanganyika fish

Ester Mahawe pointed at smuggling of fish products as a major reason for the poor contribution of fisheries in the Gross Domestic Product (GDP). A loophole somewhere leads to the low contribution, she said, noting that smuggling is the main drawback.

At the World Fisheries Day marked annually on November 21, DC Mahawe said Kigoma district and the municipal council recently received an income report from the Fisheries Department of 300,000/- earned from each area and wondered why the sector earns so low.

One sack of 100kg sardines

sells at 3.5m/- with a kilo sold at 35,000/-, in which case 300,000/- generated income for that activity is too small. "There must be a problem somewhere that needs to be clarified," she said.

Smuggling of lake products to different areas is a major challenge thwarting earnings and growth of the fishing industry in the lake, she stated.

Lake Tanganyika is the second of the great lakes in the region, the deepest water body on the continent, the second-largest by volume and the second-deepest after Lake Baikal in Russia, while it is also the world's longest freshwater lake.

# Making and maintaining friendship in the wildlife

BRENDEN Simonson is only 29 years old, but says he has lived long enough to be able to converse with wild animals, elephants to be precise.

"I speak with elephants, they listen and understand everything that I say, they recognise my voice regardless of where they might be within the wilderness," he said in an interview yesterday.

He was born inside Tarangire National Park in 1992. Since then, Brendan's childhood would be spent among wildlife and he grew to understand most spe-

"Mine should be the most outstanding happening in the 60 years of the country's Independence, as far as conservation is concerned." he stated

Tarangire, mapped within Arusha, Manyara and Dodoma regions, is famous for its larger than life elephants. These Jumbos have since become his best

Except for the fact that his family lived in thatched huts located adjacent to the Tarangire Safari Lodge, Brendan could almost have mimicked Tarzan's life-

He is also proud to be the 'jungle boy' moving

around the park taking pictures of animals and gossiping with the beasts in the process.

His father, the late Ion Simonson, an American by origin and who started out at Ilboru in Arusha, established the Tarangire Safari Lodge in 1985 and it was the first such facility to operate in the Tarangire National Park. Brendan recalls that when he was only three, there used to be an extremely huge elephant which liked to visit their lodge.

"My father named it 'Thor' after the Greek God and this is the animal which introduced me to the jumbos," he said, holding a framed photo of himself, his father and the giant elephant.

There is a family of elephants which pays a visit to the lodge, a property which Brendan runs now, following the death of his father.

The Jumbo family comprises Mother Doris (Mama Tembo), Mponda, Ahsanta and Ronaldo.

"The Elephant named Ronaldo has this habit of kicking everything in his path," explained Brendan.

Apart from speaking to animals, Brendan also speaks fluent Kiswahili and Maasai language. In fact, he earned a Maasai name, Mollel from the residents of surrounding villages.

## Dr Mwinyi instructs ZAWA to immediately find solution to water woes facing residents

ZANZIBAR President Hussein Ali Mwinyi has instructed the Zanzibar Water Authority (ZAWA) to immediately find solution to water woes facing residents in some parts of the Island.

President Mwinyi gave the directive yesterday during his tour to inspect water sources and a project which upon completion is expected to increase availability of the precious liquid in Zanzibar Urban.

According to him, most of the water infrastructures in Zanzibar Urban are dilapidated, the thing that results in poor water services in some areas.

He urged ZAWA officials to work on the water challenges and make sure the proposed project is completed as scheduled as most of the required equipment has been imported. The President added that it is ZAWA's respon-

sibility to install water distribution infrastructures to ensure residents in Miwani, Kizimbani and Bumbwisudi areas get clean and safe water.

He challenged them to also push water from some of its seven deep water wells to enable residents in Miwani, Kizimbani and Bumbwisudi to access the vital liquid at their near vicinity.

He said the project at the time of its inception did not consider including the people living in the areas surrounding the sources, thus making them struggle to get water.

President Mwinyi said the government is currently working to start implementing various road and electricity projects to improve provision of social services, assuring Islanders that the government will address all the challenges they face. He also commended ZAWA technicians for successfully restoring the system that caused the pipes to collapse and caused water shortage in some parts of Zanzibar town.

ZAWA Director, Dr Salha Mohamed Kassim said the by the Authority requires a lot of funds to execute its duties including payment of compensation to the people resident near the sources and salaries for security guards at its water

Some of the people living near the sources expressed their concerns over lack of clean and safe water services for the entire period since the urban water project was launched.

They also complained about poor road infrastructures and electricity services.

## 'Micro small and multi-national corporations partnership help to unlock SADC business'

THE Southern African Development Community (SADC) region has a great potential to become a successful hub for exporters of finished goods if Micro Small and Medium Enterprises (MSME) and Multi-National Corporations (MNC) work together.

Speakers at the SADC industrialisation Week 2021 currently underway in Lilongwe, Malawi made their remarks urging that if large manufacturing firms work together with the small firms in value addition, SADC could become the net importer of processed foods to that of an exporter. An economist at Genesis Consulting, Lauralyn Kaziboni, said for

regional growth to be inclusive, local firms together with big firms, need to be able to participate and effectively compete in regional value chains through innovation and effort, investment, quality Kaziboni cited poultry farming in several SADC member states

as an example where multinational corporates have completely dominated the market and in the process pushing away small and medium enterprises to the brink of extinction.

She said the region remains a huge net exporter of sugarcane, but a net importer of processed sugar confectioneries and baked goods, adding that when MNCs and MSMEs closely worked together, they would inevitably empower MSMEs to become processors of sugar confectionaries themselves and reverse the current trajectory.

Duncan Samikwa, Senior Programmes Officer in the Directorate of Food Agriculture and Natural Resources at SADC Secretariat said that the MNCs need to play an important role to ensure skills transfer and mentorship of MSMEs to improve the quality of their products to make them competitive for export.

He said this can be realised if regional governments also capacitate agro-processors to produce improved quality products for ex-

"The move to become net processed food export can work if governments attract and facilitate private sector investments in new agro-processing activities and ensure that investors function optimally," said Samikwa.

He said provision of tax, cost-recovery incentives both in plants and equipment and other investment incentives are capable of changing the status quo for the better.

Samikwa underscored the need to promote product traceability mechanisms for specialised markets and exports and on identified products while also emphasizing the need to improve cross border logistics and trade systems; such as the Tripartite Transport System Project and One Stop Border Posts.

## Zanzibar liquor board counselled to do its responsibilities transparently

THE Zanzibar Liquor Control Board has been challenged to carry out its responsibilities transparently as required by liquor number 9 of 2020 as directed by the Zanzibar House of Representatives.

Human Rights and good governance activist Ali Makame Issa made the call when speaking to reporters in Zanzibar about the board's silence in floating tenders for liquor importing companies when the 2020/21 fiscal year ends.

"Last year the liquor board announced

a tender in October, but sadly when the financial year comes to an end no bid was heard. There're some rumours that the process to get those companies secretly, something which is illegal," he says.

Makame said that when the Zanzibar President Dr Hussein Ali Mwinyi dissolved the board and information were availed to the media, but the new board chairman and members were appointed silently, something that deny public right to know them.

According to him, liquor board activities should be transparent, including the issuance of licenses to companies that import

liquor and bar licenses every financial year so that dissenting people have the right to file their objections.

"The board is required to carry out its activities transparently, including announcing all licensed bars in each district as well as the company's import bids. The tender must be advertised in the media, and the process must be competitively contested," said Makame.

He said the origins of the previous board dissolution were due to the violation of Act No. 9 of 2020 section 33 (1) after the issuance of liquor import permits to more than eight companies instead of three, contrary

to the provisions of the law. "The law clearly states that the owner of the import company must be a Zanzibaris, the taxpayer has a warehouse and a delivery truck but sadly, they are now being given until foreign investors import illegal liquor," he said, calling on the anti-corruption and economic sabotage authorities to closely monitor the process of licensing companies that are to import alcohol to avoid violations of the law as it emerged in

2020/2021 fiscal year. The Zanzibar-based activist explained

that in accordance with section 28 (k) bars licenses are required to be issued after bars being 1,000 meters from community service areas such as schools, hospitals, houses of worship and residences but these provisions of the law have been violated in the financial year 2020/2021.

"Act No. 9 of 2020 has been enacted to eliminate the influx of bars in residential areas, that's why the tax has been increased from 2m/- to 4.7m/- and for each bar to be 1,000 meters away from social services but we are witnessing many bars exist close to social services," he said.

## WHO commends efforts to increase access to essential curative services for kidney disease

THE World Health Organisation (WHO) has commended Tanzania's effort to increase access to essential curative services for kidney diseases.

Dr. Tigest Ketsela Mengestu, WHO Tanzania country representative made the appreciation mid this week at the opening ceremony of the 7th Annual Conference of the Nephrology Society of Tanzania (NESOT) in Dar es Salaam.

Kidney diseases affect one out of every ten individuals worldwide, accounting for around 700 million people. Chronic kidney disease is predicted to affect 14 percent of people in Sub-Saharan Africa.

Studies conducted in Tanzania, found a community prevalence of 7-15 percent, with a higher burden in urban areas. According to the STEPS Survey, a national study conducted in Tanzania in 2012, involving people aged 25 to 69 years

kidney diseases such as diabetes affected 9 percent of the population, and 1 in every 4 people had high blood pressure (hypertension).

"In responding to the growing burden on kidney diseases and insufficient access to services, Tanzania established haemodialysis units in more than ten regions, and in every regional referral hospital. Tanzania is now on the list of a few African countries that do offer kidney transplantation services at Muhimbili National Hospital and Benjamin Mkapa Hospital," she said.

Dr Mengestu said Tanzania has also invested in developing skilled personnel to deal with kidney and related medical practices, whereas in 2012 Tanzania had only four Nephrologists against 31 currently.

According to WHO, global resources are still insufficient and disproportionate to meet the current burden. The glob-

old, revealed disorders that may lead to all nephrology workforce density stands at nine nephrologists per a million people. Developed countries have a density of 28.5 nephrologists per million people, while developing countries are at a ratio

> Tanzania has established a Nephrology training program at Muhimbili School of Medicine and Allied Sciences and recently has also introduced a postgraduate training for nurses specialising in kidney diseases.

> "The continuous efforts of this country, the government, and the Nephrology Society puts Tanzania at a higher chance of increasing the number of nephrologists in Africa, who are still in short supply," said Dr Mengestu.

In his opening remarks, former President Dr Jakaya Mrisho Kikwete challenged the NESOT and the health sector in general to continue networking for technical cooperation with nephrologists in other countries.

## How Congo's EAC membership will bolster bloc's potential

BY Democratic Republic Congo (DR-Congo) joining the East African Community (EAC), the six-member bloc will open the corridor from the Indian Ocean to the Atlantic Ocean, as well as North to South, hence expanding the economic potential of the region.

This observation is made in an EAC document, containing a summary of findings of the verification exercise launched by Congolese President Felix Tshisekedi on June 25, in Goma, the capital of the vast country's North Kivu Province.

At the time, the verification team earlier appointed by the EAC Council of Ministers had embarked on a 10 day trip there to establish DR- Congo's level of conformity with the criteria for admission of foreign states into the bloc in accordance with the EAC Treaty.

On the potential to strengthening integration within the region, the report also notes that DR-Congo has bilateral and multilateral cooperation arrangements with regional countries in various areas that include customs, infrastructure, productive and social sectors.

In terms of geographical 

and geopolitical location, it is noted, the country has potential to open an Indian Ocean to Atlantic Trade Corridor and link the region to North Africa, Central Africa and other continental sub regions.

It is stated that DR-Congo's population of 92 million has the potential to contribute to expanded market and investment opportunities, and that its macroeconomic indicators "are not far from those of EAC Partner States."

Regional ministers in charge of EAC Affairs on Monday, November 22, recommended for consideration by the EAC Heads of State the report of the verification team and also recommended that the EAC Heads of State direct the commencement of negotiations with the DR-Congo, in accordance with the findings of the verification team.

"In the spirit of widening the EAC markets, DRC joining the EAC will be a huge milestone towards strengthening our economic agenda," EAC Secretary General, Peter Mathuki, who followed all deliberations in the Council meeting, told The New Times on Thursday, November 25.

The EAC on Wednesday launched a new regional tourism media campaign as part of plans to implement the six-member bloc's tourism recovery plan and industry players are buoyed by news about DR Congo's likelihood to join the Com-

Jeannette Rugero Murekatete, a Rwandan tour guide and driver who has been the tourism industry since 2016 is excited by the prospect of DR-Congo becoming a member of the EAC.

## TARI to produce 770,000 grape seedlings to bolster productivity

THE Tanzania Agriculture Research Institute (TARI) has produced more than 770,000 grapes seedlings to improve productivity of the vital economic cash crop in the country.

The seedlings produced at the Dodoma - based TARI- Makutupora centre and at the famous Chinangali II vineyard include a mixture of table, wine and dry grapes.

The impression development attained within a period of five months is part of efforts by the state- owned institution to comply with directives from Prime Minister Kassim Majaliwa to revive performance of the key sub-sector.

National coordinator for viticulture research program at TARI, Saada Hussein said the target was to produce at least 1million seedlings in

She said of the produced seedlings, 17,000 are for table grapes and 160,000 for wine and the remaining 600,000 seedlings at the Chinangali II farm are mixture of both, table and wine grapes.

She said the government has so far provided 80m/- out of the 200m/- it pledged for the purpose of supporting the sector.

With mandate to disseminate technologies and best agronomic practices towards the farmers and processors, Saada said the Makutupora centre has launched a fresh strategy to train the farmers and extension officers.

"We have so far managed to train

70 students from the Sokoine University of Agriculture (SUA) on the best agronomic practices for grapes cultivation as well as 73 extension officers from Mpwapwa and Kondoa districts," she said.

She added that a total of 26 extension officers from the Dodoma city council were also trained at the recently established centre for Agricultural Technology Hub (ATH) and 450 farmers trained at the Makutupora and Nanenane centres.

The target is train 500,000 farmers, she said.

TARI Director at the Makutupora centre, Dr Cornel Massawe said they are expecting to introduce four new wine varieties from South Africa namely, Cabinet Saviugnon, Pinotage and Merlot.

However, he said the centre was currently carrying a special trial of about five new varieties of table and grapes wine, being efforts to ensure farmers are equipped with enough

He named the varieties under the trial as Syrah (wine grape) whereby table grapes include Black Rose, Queen of Vineyard and Alphonse Lavallee, and Ruby Seedless (dry

Elirehema Swai, coordinator for research and innovation at TARI Makutupora centre said to fetch the intended results, the institute has decided to dedicate more efforts in building farmer's capacity on how professional to prepare the farms, preparation of seedlings, uses of fertilizer and other needed inputs.

"The plan is to ensure farmers adopt modern agro- practices, including use of cement, iron and plastic pillars instead of using tree pillars. We want to empower farmers with sounding knowledge on irrigation systems, pesticide as well as how to mitigate common grape diseases as powdery and down mildew," he stated.

He also spoke over the plan to conduct a regional wide survey to collect reliable data on the number of available active farm-

Daines Sanga, researcher (natural resource management) said the centre was also in the process to improve its seedlings nursery to provide the farmers with improved and quality seedlings. Marry Hassan, principal agriculture field officer (PAFO), said there was good response among the farmers in adopting cultivation of table grapes, ever than before.

Tanzania is placed second after South Africa for brewing best wines within the continent, but there are only two wine grape varieties grown in the country, Makutupora Red and Chenin White, a situation which limits production of wider varieties of wines.

Research proved that Tanzania has potential weather to produce grapes with high sugar contents, which is useful in processing wines of high alcoholic per cent (from 12 to 14 per cent), more than the rest counties in the world where the crop

## Young mothers and pregnant girls on the desk, exams: So any issue?

several days been experienced in the airwaves in particular, where critics of the move to change policy with regard to pregnancy in schools appear to predominate, while in organised expression, among non-governmental organisations, scarcely is there a voice of dissent. In other words, the rules against sitting in class while pregnant or returning thereafter, even for exams, were popular with the broad public and unpopular with activists, so there is a question of leadership. Does it amount to just doing what is popular, or rather at times a leader has to show the way, even by listening to 'adversaries'?

The reason for this opposition is that traditional authoritarian culture, which many parents rely upon to check adventurist inclinations of their daughters for that matter, has been lashed at by the policy change. Now there is a more sympathetic inclination as to a school girl becoming pregnant, especially as in most cases it is due to psychological pressure, from ordinary material wants to growing up urges that prove hard to contain. Those of a different genetic makeup thus appear to be disciplined, while it isn't the

Critics seem to be aware that letting go of this limitation on schooling for a more tolerant attitude in that regard leads to a generally tolerant outlook, and in that sense psychologically uplifts other marginalised groups. They will suffer less visible contempt despite that getting pregnant will not be a plus, and it will always

EXTENSIVE debate has for be an issue of opprobrium privately, at family level, but official tolerance shall help to modify attitudes in that regard as well. In addition, mothers' roles will be uplifted by the change in attitude, as public authorities now acknowledge that what the girls need is support and counseling, not punishment.

> Usually mothers have been tolerant when girls become pregnant, whether out of circumstance or really out of habit, while fathers too often maintain traditional intolerance. Many take their religious values or expenditure on the schooling of a child as the reason for ferocity. but closely examined, this view doesn't hold water. It is in actual fact a negligent attitude, wishing to avoid any further spending on the child, as punishment for her errant ways, which masquerades as breaking rules a father gave, or religious advisers.

So far it isn't clear what method shall be applied in bringing to fruition a return to school, if it is special schools and exam centres in like manner as repeating of a class or re-sitting an exam or a simple return to school as most NGOs would wish to believe, but which administrators are likely to resist. There is hence grey matter on the edges of the momentous announcement but it is still of major significance, that schools and local government authorities will be looking for ways to accommodate such girls, whether in the same schools or special centres. They aren't just pushed there but with a conducive learning envi-

## Municipal authorities need not start a war about empty bottles

radical reduction of the presence of small traders preliminarily achieved in most parts of the city, those which aren't around market centres in particular, municipal authorities in the city of Dar es Salaam seem to be coming up with new ideas. Street and ward level authorities were told to make thorough clean up after petty traders leave - now that cleanup is being taken to mean cleanliness in general.

Throwing bottles into the streets is now a battle zone, with fines likely to start raining that soon.

Not everyone believes that there is a big problem in that direction, as whatever the scale of the problem it is not of the making of those who live on the streets, especially petty traders.

While local authorities and their FM radio interviewers are at home talking about dustbins and other waste collection facilities, there is clearly an effort to spare the municipal administrators from the full implications of their inef-

Rarely is a waste collection vessel placed and emptied on time; it is left that way when it is full, such that it becomes part of waste itself, as once it is filled up, the waste has to be restored to street throwing

The city RC was for instance at pains in his mid-October interventions on the petty traders to express the sort of anguish that authorities feel when they see dirt being piled up in waste water tunnels con-

WITH the clearing out or structed during the road building exercise of the past few

That was the acme of local authorities' play on public feelings, as people will never collect together and put it to municipal officials that they never once cleaned the tunnels, and dirt is taken away by rainwater.

At the moment, following the full covering of the tunnels, everywhere one passes, with the steaming air it is clear cesspits are now emptied into the tunnels.

That isn't what municipal authorities talk about, and if a situation arises where they are tasked with ending that sort of situation, it is clear they will turn it into a cornucopia of 'clemency payments,' to avoid drawing up charges against home owners emptying human waste into roadside tunnels. But that is a tale for another day, and at the moment, municipal officials prepare to embark on a war against those who throw bottles on the roads, wishing to step up fines etc. - an easy way to make some cash.

The point here is that those bottles are part of a wider ecosystem which takes care of itself when people search for bottles to earn bits of cash, cushioning difficult livelihoods, and often grandchildren who have no parents to assure them a livelihood depend on the grandmothers picking bottles. So here is no need for a campaign on bottles as it is an asset that is usually collected and properly disposed. The new fines being readied are needless.

## Harvesting deaths from air pollution

The United Nations Children's Fund (UNICEF) has again shaken the table with grave statistics that children below five years old in Nigeria are dying, needlessly, of (outdoor) air pollution-related pneumonia and of household air pollution-related pneumonia. UNICEF's staggering figures put Nigeria as having the highest number of air pollution-related child pneumonia deaths in the world. The signs and symptoms of pneumonia, according to scientists, may include cough, fever, shortness of breath, sharp or stabbing chest pain, loss of appetite, low energy, and fatigue.

The grim revelation by UNICEF, at this year's World Pneumonia Day, is that almost 185 children under the age of five die every day from pneumonia due to air pollution in Nigeria - the majority of them from air pollution in the household, including that from cooking over open fires or cooking stoves in the home. According to Peter Hawkins, UNICEF Representative in Nigeria, "this is a travesty - for their families and for Nigeria - especially because the vast majority of these deaths are preventable."

The Global Burden of Disease said that 78 per cent of air pollution-related pneumonia deaths in Nigeria are among children under-five - the highest proportion across all countries. In 17 countries across Africa, air pollution contributes to more than 50 per cent of pneumonia deaths. Most of these deaths are among children and due to household air pollution - though deaths from outdoor air pollution are rising, according to the GBD. Deaths of Nigerian children underfive due to overall air pollution-related pneumonia were 67.416 in 2019, while deaths of Nigerian children under-five due to household-specific air pollutionrelated pneumonia were 49,591 during the same year.

Only recently, a report by Stakeholder



Democracy Network (SDN), an international resource watchdog group, said Nigeria has some of the worst air pollution in the world, with dense clouds of choking soot hanging over gridlocked cities, leading to a rise in serious health conditions. Cities that the report listed as mostly affected are Port Harcourt, Aba, Onitsha, and Kaduna where poor air quality has reached crisis levels of pollution in recent years. There is irrefutable evidence of cause to effect, considering the rising cases of asthma, and respiratory diseases.

Researchers also focus on the bad quality of fuel imported and used in the country, as well as the equally bad quality fuel refined illegally in the creeks of Port Harcourt and is of higher quality than the imports. Regardless, the unsophisticated refining process adopted in the creeks sends up impurities into the atmosphere and this is driven by strong sea wind to where it can do damage to unsuspecting resi-

In most Nigerian cities, vehicles with unacceptable emission standards clog the streets, oozing impurities unchecked. Majority of these are used vehicles that are close to end-of-life, meaning they are forbidden in the streets of the European and American cities from where they were exported to Nigeria. More of these vehicles are expected on the shores of the nation in the years ahead, as the de-Bayelsa, which, from investigation, veloped world increases its switch to

electric vehicles that are more fitting for the global quest for a reduction of emissions of CO2 that is implicated in global warming.

Nigeria's air quality is expected to be governed by the National Environmental (Air Quality Control) Regulations, 2014.

The purpose of these regulations, according to the government is to provide for improved control of the nation's air quality to such an extent that would enhance the protection of flora and fauna, human health and other resources affected by air quality deteriorations.

The regulation is expected to guarantee everyone's right to clean air. But the government seems hesitant to enforce the regulations or lacks the political will to do so.

## Protecting environmental water from antimicrobial resistance

The overuse and misuse of antimicrobial medicines and chemicals has become the main driver of antimicrobial resistance (AMR) and drug-resistant infections that threaten human health and the global economy.

Given that development, the UN designated November 18-24 as World Antimicrobial Awareness Week, to remind us all to handle antimicrobials with greater care.

Antimicrobials - which range from antibiotic and antiviral medicines to disinfectant and antiseptic chemicals - help prevent or treat human, animal and plant infections and have contributed immensely to health and progress worldwide.

Now, however, common antibiotics, as well as first-line antimicrobials for infectious diseases such as HIV and ma-

laria, are becoming less effective. The World Health Organization re-

ports that 700,000 people die from drug-resistant diseases every year. If this threat continues unchecked, 10 million people are predicted to die every year and the world will lose USD

\$100 trillion by 2050. Most worrying, an estimated 90% of the world's urban growth is anticipated in Africa and Asia, where populations are most vulnerable to drug-resistant bacteria. Increasingly, multilateral organizations and national governments are adopting measures to reduce unnecessary antimicrobial use by humans, including in our food chain.

From 2000 to 2015, human consumption of antibiotics increased 65%, led by low- and middle-income countries (LMICs) where GDP has risen in parallel with antibiotic use, overuse and misuse.

Meanwhile, antimicrobial use in animal farming is nearly triple that of human consumption and is on track to reach 200,235 tons in animals and 13,600 tons in aquaculture by 2030 as producers work to reduce infection and increase animal growth.

Data on antimicrobial use in plants is limited, but the presence of resistant bacteria has been detected on 25% of plant-based foods from all world regions, indicating that food likely is contributing to greater AMR.

The excessive use of antimicrobials in humans, animals, and plants also puts environmental health at risk. But environmental transmission via soil, air, or water receives relatively little attention as an AMR driver.

Depending on the drug, humans and animals can excrete waste with up to 90% of antimicrobial compounds or metabolites still active, which can end up untreated in the environment.

Unsafe disposal of antimicrobials and wastewater from hospitals, pharmaceutical manufacturers, municipal treatment plants, and farms are recognized as hotspots for the introduction and evolution of more resistant strains (i.e., superbugs).

This pollution can consequently compound human AMR exposure through contaminated soils and water supplies that sustain our environment, or are used to produce food, for drinking, cleansing and recreation.

Increasing access to safe water, sanitation and hygiene (WASH) and raising capacity for wastewater treatment are the primary environmental interventions to reduce the spread of AMR.

However, current statistics paint an alarming picture of whether these efforts are enough to address environmental risks, as a quarter of humanity does not have access to safe water and just over half of the world's wastewater is treated. Of particular concern are large swathes of Africa, Asia, Latin America, the Middle East, and Eastern Europe, which report limited treatment of, or have no data on, domestic and industrial wastewater flows.

## Legal consequences of using abusive language, sexual annoyance

E live in a world in which we often don't take the trouble to understand what the law prohibits, commands or permits us to do when we are alone or with other people. Now, because we don't know what to do in such circumstances, we also don't know the action to take when, for instance, a person insults us.

Sometimes we are so selfish that we don't care to help when a person near us is insulted because we mind our own business and we would like other people to mind

If anything, when a person insults us we are likely to let it go. After all, we don't have time to waste, running up and down the streets to look for a police station where we can report the person who has insulted us and make sure he or she is held accountable. You might be one of those people who don't care about what happens to others or you are among those insulted in public and you might not have known what to do under the circumstances.

Just imagine vou are travelling with your parents, grandparents, Penal Code (Chapter 16, R.E 2019). spouse, parents-in-law, friend,

neighbour or children and all of a sudden you or any member of your family or even fellow passengers are insulted by one of the passengers or passersby! You may take courage and tell the person insulting you to stop it, but the person may continue because he or she knows you cannot do anything against him or her.

You may want to keep quiet and seeing that, the person may continue repeating the words that are offensive to you because he or she knows that other passengers mind their own business. Hardly anybody can take any legal action when they are insulted in public. As usual, if you happen to be serious and threaten to take legal action, there will be people to calm you down so that you let it go. "You are a man, don't be so naive to mind it," one of them may say.

After that, you too may decide to keep quiet. But not taking action has made us almost uncritical of the situation we happen to find ourselves in. Well, sexual assault on persons and indecent assault on women or sexual annoyance is prohibited by law, according to sections 135, 138A and 138D of the

There are people who tend to see



themselves as having more rights than others or who think are superior to others especially to women and girls and so they can insult or humiliate them in front of others by uttering abusive words or showing signs that intend to cause sexual annoyance or harassment or indecent assault on them.

Women too may do so to men. In any case, sexual annoyance or indecent assault on any person is prohibited by law and where it is proved that a person has insulted 

another person, the offender is liable on conviction to imprisonment for a term not exceeding five years or to a fine not exceeding Sh300,000 or to both.

Where a charge for sexual assault relates to a boy or girl aged below 18 years, it shall be no defence to the charge that the boy or girl consented to the act constituting the assault. As regards gross indecency between persons, the offender is liable on conviction for a term of not less than one year and not exceed-

than Sh50,000 and not exceeding

Where the offence committed involves a person aged 18 or below 18 years, a pupil or a student of a secondary school, the offender shall be liable on conviction to imprisonment for a term not less than 10 years, with corporal punishment, and shall also be ordered to pay compensation of an amount determined by the court to the aggrieved person. Sexual harassment is also prohibited by law.

So, a person, who causes sexual annoyance or harassment to another person commits an offence of sexual harassment. Such a person is liable on conviction to imprisonment for a term not exceeding five years or to a fine not exceeding Sh200,000 or to both. He or she may also be ordered to pay compensation of an amount determined by the court to the aggrieved person. Whoever utters any word, makes any sound or gesture, or exhibits any object intending to insult the modesty of any woman, including any female or male organ, or intrudes upon the privacy of the woman, he or she too commits the offence of sexual harassment.

ing five years or to a fine not less it is rare not to hear such words or see signs shown which are intended to insult or humiliate other persons in front of fellow passengers. Those words may be uttered by the driver or his conductor, but they may also be uttered by any passenger or passerby against a fellow passenger or passerby. Sometimes there are those who boast that you may go and report it to anywhere you want, but they won't be prosecuted.

> If the commuter bus is owned by a police officer, a soldier or any other government official or a famous businessperson, the driver or his conductor behaves even worse, knowing that with the title of their boss nothing will be done against them. But for sure if those insulted in public take action, it will deter other people from insulting others. We can make public transport more comfortable and respected if we all decide to take action when a person is insulted before us.

## A case for women to be more involved in politics

S Tanzania readies for celebration of 60 years of independence next month, one of the areas that still need more efforts is involvement of women in politics.

Political parties for instance, are mostly led by men, yet, when it comes to campaigns and actual voting itself, women are the force to reckon with.

To reverse this, stakeholders have called upon for party leaders and other organs with decision-making powers to be sensitized to understand the importance and rights of women and other special groups within their political parties.

Speaking in Dar es Salaam during a three-day seminar organised by Tanzania Gender Networking Programme (TGNP) in collaboration with Tanzania Women Cross Party Platform (T-WCP)-ULINGO recently, the guest of honour, National Coordinator of ULINGO, Dr Ave-Maria Semakafu told fellow women leaders from the 19 political parties with permanent registration that regardless of their political affiliations and ideologies, women are the primary caretakers of children and glue that hold family together.

Dr Semakafu said: "Women are caretakers of families, we therefore, have to ensure we are part and parcel of decision-making organs. We need women leaders who can speak for our rights and challenges facing us. Always, we need to focus on our slogan that states 'Agenda for a woman, is a veto for victory'."

She said that what is important is women's visibility. Women leaders need to ensure that all matters touching on their affairs are included in their political parties' manifestos.

TGNP Executive Director Lilian Liundi said that the main objectives of organising that seminar were to groom women political leaders and have a collective understanding on the importance of women to participate in decision making and leadership within their political parties.

Also, to brainstorm and assess progress made on gender issues in different structures of political parties with permanent registration as well as to build collective understanding on Political Parties Act.

Furthermore, it sought to establish collective strategies on how to increase the pace of implementing all gender equality within political parties.

"Our target are women and young girls in political platforms," she said.

"We know there are women issues incorporated in political parties' manifestos and policies, but they have left a lot to be desired because their implementation is very low."

strong and vigilant so as to remove the barriers caused by patriarchal system. "Women matters have no political affilia-

tion," she said. She said that women participation in deci-

sion making circles was still at 30 per cent, below the Maputo Declaration that needs 50/50

Secretary of CCM's women wing in Dar es Salaam Region Grace Haule commended her Party for recognising the importance and role played by women.

Tanzania Labour Party Vice Chairperson Dominata Rwechungura urged women to understand that they have an important role to play in all spheres of life, including political

"Women are born as leaders naturally; the way we bring up our children, care for our

families and the society at large is a proof of that," she said. Susan Lyimo from CHADEMA called upon fellow women leaders from other political parties to participate fully in politics because it matters. But for this to happen, she stressed the importance of education.

"When women are educated, they become in a better position to enter in decision-making organs such as the National Assembly," she said.

Mwajuma Mirambo, National Women Coordinator with the Union for Multy Party Democracy (UMD), said that gender equality should start within a given political party.

She argued that if decision-making organs within a political party have no gender balance, it will be impossible to attain the desired 50/50 representation.

Mirambo believes that any good house needs good foundation, therefore, the foundation of a strong political party the number and quality of women it has.

"But women alone cannot attain gender equality; we have to involve men," she said.

ADA-TADEA women's wing Chairperson Diana Rose said: "A woman is a natural leader; if she is included in decision-making organs, the family and the society will prosper."

## Gaddafi Jnr's bid for president signals waning influence of ICC

t'S almost 10 years to the day since the streets of Tripoli rang out to a rally of celebratory gunfire by Zintani militiamen. After several false sightings, Saif al-Islam Gaddafi, the fugitive son of late ruler Muammar Gaddafi, had been captured in the south of Libya.

Now, after six years of being held by tribal militias and in defiance of an International Criminal Court (ICC) arrest warrant, he has declared his intention to run for president. Libya's election commission may derail his move with a ban on Gaddafi and 24 other candidates from standing. This could however be overturned on appeal.

The man once considered a reformer was indicted by the ICC for crimes against humanity – particularly his alleged role in the brutal crackdown by Libyan state security on protesters ahead of the 2011 up-

Gaddafi Jnr's presidential ambitions seem to be another example of a leader thumbing his nose at the ICC. But does anyone care? The fact that the ICC hasn't responded officially to Gaddafi's carefully choreographed announcement, preceded by hints in a New York Times interview of his presidential ambitions, is

Gaddafi is also not the only man eyeing the presidency despite charges hanging over him. Warlord and former head of the Libyan national army, General Khalifa Haftar, faces both civil and criminal charges. These include committing or presiding over acts of torture during the 2016 Benghazi siege. Like Gaddafi, who was sentenced to death in absentia, he's also wanted by Libya's domestic courts, which Libya analysts say is far more likely to influence voters than the ICC indictments.

Many commentators consider Gaddafi's (for now) thwarted bid for the presidency to be symbolic and even a sinister reminder of the violent legacy associated with the Gaddafi dynasty. But what does it say about the state of international

The audacious move by the younger Gaddafi is a reminder of Uhuru Kenyatta's case at the ICC. He bid for the Kenyan presidency in 2013 while charged by the international court with five counts of crimes against humanity, following the post-election violence that ripped Kenya apart in 2007/8. The charges were subsequently withdrawn in 2015.



wasn't the subject of an arrest warrant and 'cooperated' with the ICC just enough to avoid censure. And while Kenya is a signatory to the Rome Statute and must work with the court, Libya hasn't signed up – and has barely hidden its disdain for the ICC.

The country was one of only two 'situations' the United Nations Security Council (UNSC) referred to the ICC under UNSC Resolution 1970 in 2011. The other was Darfur in Sudan. At the time, Libya's allies said the UNSC But unlike Gaddafi, Kenyatta was encroaching on the country's sovereignty. Still, the

resolution passed – driven by the responsibility to protect principle and fears of a humanitarian crisis. The assumption that the ICC could deter future atrocities or influence Libya's conflict hasn't come to pass.

In one of her final acts as chief prosecutor of the ICC, Fatou Bensouda warned the UNSC that "the failure to execute arrest warrants" was "blocking efforts to ensure justice for the victims of serious crimes perpetrated during a decade of conflict and strife." She said her office continued to receive reports of "disappearances in Libya and arbitrary detention, murder, torture and sexual and gender-based violence."

The fact that in 10 years "not a single person in Libya has been prosecuted by the ICC is scary," says author and international justice scholar Dr Mark Kersten, a Senior Consultant at the Wayamo Foundation. While he concedes the ICC has no relevance for most people in Libya, he sees an opportunity for the court to pivot.

In his view, charges issued by the ICC shouldn't "raise expectations of immediate action." Instead, Kersten says these should be seen as "placeholders for potential justice ... but justice that requires a constellation of actors to come together." Put simply, the ICC needs to matter domestically for it to have influence.

The pledge by political rivals of Sudan's Omar al-Bashir that the former leader will be handed over to the ICC is perhaps an example of this. Whether political opportunism or realpolitik, it underscores Kersten's point.

The relationship between the ICC and the domestic context mattered in Kenya. In 2013, opposition to the ICC became an election campaign issue for Kenyatta, as he sought to galvanise support against a "neocolonial court". An active civil society and truth commission helped keep the alleged crimes the ICC was pursuing in the public domain. That pressure – despite the eventual collapse of the Kenyan cases – arguably led to numer-

ous domestic cases through Kenya's civil courts.

In Libya the situation is different, argues Kersten. "Once the civil war ended, so did the pressure to pursue atrocity crimes. Civil society just does not have the same voice inside Libya and the pressure for accountability had largely come from out-

The Libyan and Kenyan experiences offer a lesson to the ICC – to better frame the court's function as a driver of deterrence. The ICC's primary role is to provide justice and accountability, even if it results in domestic courts pursuing cases, such as with Gaddafi's former spy chief Abdullah al-Senussi.

Despite al-Senussi being indicted by the ICC, he was tried by a Libyan court. Both he and Gaddafi were sentenced to death. Al-Senussi is still in jail following a trial that drew criticism that due process wasn't fol-

The ICC may have to exercise some strategic patience and finetune its messaging. Its prosecutors know that the court doesn't exist in a political vacuum. Only if it suits domestic agendas, as seen in Sudan, will the ICC recover some strength, symbolically rise from the ashes and find favour among those committed to international justice.

## Community tree nursery, garden brings ray of hope to Zimbabwean villagers

TO get to Nyamukondiwa village in Guruve district in rural Zimbabwe, you have to navigate through 170 kilometres, or 106 miles, of mountainous terrain from the capital, Harare.

Along the road, people carry bundles of native timber for commercial use. To fire a kiln to produce 20,000 bricks takes about three cartloads of zebrawood and mopane wood.

A stack of 1,000 bricks retails for \$35, a needed source of income for villagers. To power Zimbabwe's lead as the largest producer of tobacco in Africa (and No. 6 worldwide), it takes 15 carts full of firewood per hectare (or six carts per acre) to cure tobacco leaves.

Zimbabwe harvested and sold an estimated 200,000 metric tonnes of tobacco this year, up 11% from last year, according to latest data from the Tobacco Industry and Marketing Board.

Now, with woodlots in Guruve vanishing rapidly, farmers

are traveling deeper into the mountains to find more trees, and households that rely on firewood for cooking are running out of the resource.

However, away from the environmental ruin, the birth of the Kufunga Ndomunhu Project is bringing hope to the village through a women-led reforestation and community garden project that benefits 21 families from three different

The project addresses deforestation loss from the tobacco industry and feeds around 600 villagers, including school-age children, to reduce dropout rates due to hunger.

"We started a garden community of young and elderly women with the assistance of resources and ideas by Perseverance Ganga, a son from the village, now based in Harare," said Isiah Makoshori, the Guruve village head. "We get water from his solar-powered borehole to sustain our gar-

new members are expected to ioin.

When it rains in December, the dry riverbeds start filling up and tobacco farming gets into full swing. After seedbeds and transplantation into fields are completed in late November, the labor-intensive harvesting commences.

A sizeable number of villagers, including women, grow the cash crop, a major foreign currency earner for Zimbabwe. Tobacco contributed 10% of the country's GDP in 2018. By 2025, the government anticipates turning the tobacco industry into a \$5 billion industry.

However, the production of tobacco is eating away at the environment and native trees in particular.

These trees are favoured for their ability to burn longer than exotic species, such as gum (Eucalyptus robusta). Some 30 out of the 600 residents of the village of Nyamukondiwa are tobacco farmers, each cultivating about 2 hectares (5 acres) per season.

Despite the tangible returns of tobacco farming to the economy, the effects of deforestation in Guruve are glaring. Local plantations don't grow enough gum trees to supply the need for firewood to cure the tobacco leaves.

This has had an impact in Guruve, which only had 4.7% tree cover in 2000 and lost 8.1% in 20 years despite multiple reforestation initiatives.

According to Zimbabwe's Forestry Commission (FC), the country is losing 300,000-350,000 hectares (741,000-865,000 acres) of forests each year, approximately the size of 350,000 soccer pitches.

Community reforestation intervention

To replenish the native woodlots, the Kufunga Ndomunhu Project created a native tree nursery along with a community garden.

Fed by a regular supply of water from the borehole, the villagers collect mahogany, mopane and zebrawood tree seeds from the forest, including the soil where the trees originally grow, to create their own woodlot. Native trees are favoured over exotic species because they're more resistant to pests and diseases, adapt easily to the local climate, and require minimum caring and watering.

"We are focusing on training women on planting trees found in the area to create a sustainable agroforestry system," said Perseverance Ganga, the borehole owner.

After one year in operation, the plantation has 200 budding trees, and members of the community anticipate planting 2,000 more by the end of this year. So far, the community is benefiting from the help provided by both private and state agricultural and environmental experts, including Ganga's philanthropy.

"The first step is to plant more trees, shrubs, flowers, grasses and climbers," said Shamiso Mupara, founder of Environmental Buddies Zimbabwe (EBZ), an NGO that promotes sustainable use of forest resources. "Then, they must prevent on-going veld fires from destroying both old and young trees."

According to Greatman Gunha, an environmental scientist at Midlands State University of Zimbabwe, the garden project brings hope to Guruve's forests. However, he said there's also more that needs to be done as tobacco production continues to grow in the country.

"There is also a need to substitute sources of fuel to cure tobacco in order to preserve woodlots," he said.

The garden, with water from the solar-powered borehole, now provides vegetables to 21 families. Inside the fenced garden, members engage in multicropping, including the cultivation of okra, a delicacy for many, that can withstand dry spells. Tomatoes, watermelons and herbs are also grown, accessing the same perennial source of water. Some of the vegetables are sun-dried so that they can be eaten later

when vegetables are in short supply.

Members use hoes, pitchforks, shovels and pick to prepare allocated plots, adding animal manure. To preserve moisture in this hot weather, the women use grass for mulching. Crop rotation is strongly encouraged to control diseases and pests, including the growing of droughtresistant varieties.

"Each member is allocated specific plots of land to plant vegetables to sell at the market and feed their families," said Dolis Makoshori, the village head's wife, who leads the garden project.

The provision of other sources of income for the community that are environmentally sustainable aims to reduce deforestation, Mupara said.

In the year that they've been working on the project, the members have collectively saved \$700 by selling vegetables, and plan to reinvest the money in farming.

## Stakeholders call for specific policy on environmentally sound management

ENVIRONMENTAL stakeholders are calling for the government to come up with a specific policy on Environmentally Sound Management (ESM) of Waste Lead acid Batteries (WLABs) synonymously known as Used Lead Acid Batteries (ULAB) to comply with the international conventions which prohibits importation of hazardous wastes and controlling trans-boundary movement of the items.

This is in line with the Bamako and Basel conventions which have been ratified by African nations including Tanzania.

They said although Tanzania has the hazardous waste control and management regulations of 2020, the laws are not specifically addressing the challenges associated with the disposal of ULAB. The regulation recognizes the used lead acid batteries as hazardous but does not provide guidelines on how to handle them to avoid health and environmental impacts.

Dr Daniel Sabai, Senior Lecturer at the Dar es Salaam University College of Education (DUCE) said: "In Tanzania we don't have a strategy and policy for the management of waste lead batteries. We need as a country to have a specific policy, our recommendations towards its establishment and environmentally sound management of ULAB are based on the guidelines outlined in the Bamako and Basel Conven-

Dr Sabai said as the nation, there is a need to use the guidelines as well as stakeholders recommendations because they are professional. He warned that failures to utilize them may result to people and the environment being affected by poor handling of ULAB.

The experts' recommendations were given during workshop organized by Pure Earth in collaboration with the United Nations Environment Programme (UNEP) disseminate the Policy and Strategy Recommendations on Environmentally Sound Management (ESM) of WLABs in Tanzania and Guidance Manual on ESM of WLABs in Africa.

He said the only additional legislation that would strengthen the ESM of ULAB is the introduction of Extended Producer Responsibility (EPR) and that would place the responsibility for the ESM of ULAB on the battery manufacturers or

importers of the batteries. "Impact of poor waste batteries management is more noticeable in receiving bodies like soil, water and air where they are dumped. There is a need for the country to develop an environmentally sound management system which incorporates EPR in the Lead Acid Batteries (LAB) and waste lead acid batteries practices," said the university don.

Ummy Madimbwala, Health, Safety and Environmental Manager at GAIA Eco Solutions Tanzania Limited which deals with recycling of ULAB was concerned that since the management of hazardous wastes including ULAB is difficult hence the need for specific policy and strategies.

Ummy said: "The government should support the efforts by stakeholders in improving the

management of ULAB because they are assisting to ensure a safe environment and protect the health of Tanzanians.'

Jamal Baruti, Environmental Management Officer at National Environment Management Council (NEMC) said: "As the government, we are in support of the stakeholders' recommendations towards improving the management of ULAB and come up with a policy and laws

that will directly address the management of ULAB."

Baruti added: "When you have a specific policy or law you can go more deeply into dealing with the problem; we currently use the available legislations to manage the hazardous wastes including used lead acid batteries; we also adhere to guidelines by international conventions which have been signed."

The policy, according to re-

search recommendations would help to protect human health and environment through the environmentally sound management of ULAB, ensure compliance with national, international, environmental, health and safety conventions, legislations, standards, regulations and international guidelines, ensure all stakeholders handle ULAB in a sustainable manner and eliminate the indiscriminate dumping of ULAB electrolyte.

It will also ensure that stakeholders are responsible for the ESM of ULAB through the supply chain, that is, collection, temporary storage, transportation and finally recycling, provide additional support the environmentally sound domestic recyclers in Tanzania by facilitating the import of ULAB in compliance with the Bamako and Basel conventions, ensure an effective formal ULAB collection system, proper sensitization and awareness for the general public and the importance of securing the ESM of ULAB.

Most of the ULAB collected in the country are taken to scrap metal companies such as, Keko Mwanga and Steelcom Limited. Steelcom in turn, sells the ULAB to secondary lead smelters such as Gaia Eco Solutions Tanzania Ltd, OK Plastics Ltd and Gravita Tanzania.

Domestic recycling of ULAB generates and maintains jobs in a country that lost about 140,000 jobs during the COVID 19 pandemic, domestic employment opportunities should

not be lost. All the refined lead recycled in Tanzania is exported mainly to Asia. Exporting lead ingots not only commands a higher price than the export of ULAB, but lead ingots are also not classified as a hazardous waste and so exports are not subjected to the terms of the Basel or Bamako conventions.

In 2020/2021, Tanzania imported automotive batteries from 25 countries with Kenya securing 37 per cent of the market share followed by the Republic of Korea at 21 per cent, China 16 per cent and Thailand 8 per cent.

## How collaboration and new drugs could beat malaria

**ALARIA** affects half the world's population, killing more than 400 000 people a year. Almost all these deaths are in Africa, where a child dies every two minutes. Those individuals who survive are often unable to work or attend school, either due to symptoms or because they have to care for relatives; this traps communities in a vicious cycle of poverty that is hard to break. Overall, this "disease of poverty" slows economic growth in some African countries by about 5% every year.

#### A fight in progress

The world is making progress in its fight against malaria, averting 1.5 billion cases of the disease and preventing 7.6 million deaths since 2000. This is largely thanks to a combination of several vector control tools, including insecticideimpregnated bed nets as well as antimalarial drugs.

While the aim remains to eradicate malaria, fighting the disease is difficult. Progress to meet the target of 90% reduction in cases by 2030 has slowed, particularly in the wake of the COVID-19 pandemic. "The challenge in Africa is how to get from controlling malaria to eliminating it," says Professor Tiaan de Jager, Director of UP's Institute for Sustainable Malaria Control. "Malaria parasites are becoming more resistant to antimalarial drugs and insecticide resistance in vectors is increasing, presenting another problem for malaria control."

A shape-shifting menace

Perhaps the biggest challenge of all is the disease complexity itself. Malaria is caused by a Plasmodium parasite, which is spread by Anopheles mosquitoes. Plasmodium hides in the liver for weeks before infecting the bloodstream, which is when people begin to feel ill. Without antimalarial drugs, victims can experience delirium, high fever and, if left untreated, death. "Antimalarials save lives, but while they target blood-stage infections, they are poor at targeting other forms of the parasite such as transmissible gametocytes," says Prof Lyn-Marie Birkholtz, Department of Science and Innovation (DSI) and National Research Foundation Research Chair in Sustainable Malaria Control at UP.

Researchers at the Universities of Pretoria and Witwatersrand, the Drug Discovery and Development Centre (H3D) at the University of Cape Town, and the Council for Scientific and Industrial Research have been working together to outwit Plasmodium falciparum, which is not only the most common type of malarial parasite, but the one responsible for the most deaths.

Plasmodium parasites are "shape shifters" capable of taking on multiple forms, some of which cause the disease; while others allow the parasite to be transmitted back to mosquitoes and continue the life cycle, Prof Birkholtz explains. This makes them tough for our immune system to identify and target. One form, called gametocytes, makes it possible for malaria to be transmit- ners, this box was screened for efted from humans back to mosquificacy against liver-stage parasites,



Compound interest

The massive collaborative effort across South Africa enabled scientists to grow gametocytes in the lab. By establishing this technology in the country, the team could expand drug discovery efforts beyond the blood stage, then look for new chemical compounds also capable of killing these gametocytes.

One recent approach has been to use the Medicines for Malaria Venture and Drugs for Neglected Diseases initiative's Pandemic Response Box, which contains a collection of 400 diverse drug-like molecules with previously reported activity against bacteria, viruses or fungi. With international part-

blood-stage parasites and gametocytes, enabling them to pinpoint compounds with potential for further development towards new drug candidates.

The team discovered two potent compounds capable of targeting processes that are essential to the parasite's survival, which they describe in a study published in Nature Communications. Unlike most antimalarials, these chemicals can kill several stages of the parasite and stop them from infecting the mosquitoes. "It's the first time that we have chemicals that selectively block the transmission between humans and mosquitoes," Prof Birkholtz says.

A potential game-changer

spread of the parasite. For example, a patient could be treated for malaria symptoms at a clinic, but if any blood-stage parasites escape the treatment to form gametocytes, the new compounds could be "added on" to kill the gametocytes when they develop. This combination treatment offers hope in the face of drug resistance, because even if parasites evade compounds intended to kill them in the blood stage due to resistance, there is another chance to beat them as gametocytes.

The future fight

South Africa aims to eliminate malaria by 2023, while the United Nations hopes that by 2030 the deadly disease will be consigned to history. This will be possible only with a multi-pronged strategy, which will likely include new drugs and a highly effective vaccine. In October 2021, the World Health Organisation approved the first malaria vaccine for widespread use among children in high transmission areas. While this offers some hope to families, the technologies behind the COVID-19 vaccine could also aid in the future fight against malaria. For example, BioNTech, a biotechnology company that worked with Pfizer on a COVID-19 vaccine, aims to develop the first mRNA-based vaccine for malaria prevention.

Prof Birkholtz says the large collaborative team's breakthrough is the result of five years of technology establishment in Africa and she hopes it will enable more discoveries in the future, with the help of the group's transdisciplinary approach. At UP alone, all faculties are involved in advancing the fight against the disease. "Everybody has specific experience that they can add and apply to malaria," Prof De Jager explains. He believes that using innovative tools such as educational children's books, hightech fabrics and new drugs, malaria could be beaten within our life-

## 5G, industrial internet give a leg up to traditional mining industry

IN recent years, 5G and industrial internet have seeped into the development of China's traditional mining industry, driving the upgrading of the sector and ensuring safe and orderly production. They have injected new impetus into the high-quality development of the mining industry.

Two-hundred meters under a coal mine of Jinneng Holding Group in Datong, north China's Shanxi province, coals are excavated, screened, loaded and transported under the collaboration of multiple devices.

All the work is completed remotely by operators on computers in a ground control center, where a big screen is showing real-time videos of each underground channel and checkpoint, as well as all relevant indicators.

The integration of 5G and industrial internet not only ensures more effective and precise remote control for coal mines, but also significantly improves the efficiency of relevant enterprises' safety inspection. He Junying is an employee of Bin County Coal Co., Ltd. who works in the Jiangjiahe coal mine of the company in Bin county, Shaanxi province. He received an alert from a smart big data platform the other day that said abnormal vibration was detected on the suspension arm of a coal cutter. He immediately contacted the technology center in Shanghai that's responsible for analyzing the data on the platform, and experts from Shanghai informed him of the analysis result and gave him advice on maintenance via a remote analysis system. Shaanxi Shengwei Building Materials Group Co., Ltd. developed an intelligent selfdiagnosis system at the end of the last year. The system checks devices every five minutes with sensors deployed in places that manual inspection is not able to reach. General manager Wang Yong of the company told People's Daily that 5G and industrial internet have brought immediate changes as the incidence of unexpected machine shutdowns dropped 70 percent after the system was installed, and the maintenance cost has also been cut by 30 percent.

"What really makes inspections smart is real-time monitoring," said Lyu Le, director of 5G technology for energy businesses of China Mobile's Shanxi branch. The company has specifically developed technology of synchronized timing by 5G stations for underground work, which has a precision of less than 100 nanoseconds.

"I had a rough time when I worked as a truck driver in coal mines in the past years, as I had to endure the coldness of winter and the heat of summer," said Li Mingxin, an autopilot truck dispatcher of a cement company under a coal mine group in central China's Henan province. Now the man works in front of a computer in an office building and is able to manage over 20 autopilot trucks just with clicks on the mouse.

"The computers can automatically plan transport routes, and control the trucks via 5G signals," Li said, adding that such approach is highly efficient.

General manager of the cement company Xiao Zhanding introduced that 5G, internet of things and Beidou navigation technologies are advancing the smart construction of coal mines. Tackling human-machine and machine-machine collaboration problems caused by lagged signal transmission, the company has made all mining procedures unattended and controlled remotely, including excavation, transport and monitoring. It has improved both the safety and efficiency of the work.

From unattended operation to automatic monitoring, automated devices are getting more and more synergetic. "Shared data is the key," said Li Shouging, director of the industrial internet business division under the Shanxi branch of China Unicom.

For instance, all the data of the 18 sub-systems in the Jiangjiahe coal mine is shared in all procedures to conduct real-time monitoring of the operation of each system and the underground environment, and analyze abnormal data, he introduced.

"The analysis result is timely sent to a dispatch center, which has further enhanced the capability of the coal mine of dispatching, emergency handling, and decision making," the director said. People's Daily

WITZERLAND is confident of luring its people to come and invest in Tanzania but calls for further policy and law reforms that will guarantee investors inject their money in different economic projects.

"I must be honest with you that if Tanzania is to host investors especially from Switzerland our people look for predictable laws and policies," said Danzi.

According to her, one of the aspects of the programme is to see how Switzerland can open up opportunities for youth in terms of skills advancement by scaling up different programmes that also involve vocational training.

Peter Bieler, Head of Eastern and Southern Africa Division at the Swiss Agency for Development and Cooperation (SDC) said on equipping small enterprises and entrepreneurs,

the programme will focus on changing the mindset from quick money making approaches to growth and sustainability.

"Reshaping entrepreneurs" mindset is vital in making the businesses they establish sustainable with focus of leaving footprints for the coming generations. The ideas are there so execution should consider a number of diverse issues," said Bieler.

On her part, Ambassador Liberata Mulamula, Minister for Foreign Affairs and East African Cooperation who graced the launch, said that Tanzania and Switzerland have been enjoying excellent relations and development cooperation for decades.

She said that Switzerland has remained one of the strategic partners to Tanzania.

"We acknowledge a remarkable contribution done in health and private sector development by Swiss Agency for Development and Cooperation;

This role is critical to foster an equal society, support economic growth that is inclusive of all citizens, and reduce poverty in poor regions in accordance with Tanzania's national development framework," said Mulamula.

She asserted that over the past 40 years, Tanzania has received more than U\$1billion from the government of Switzerland dedicated to improving the lives of Tanzanians.

She underlined that SDC has been a front-runner in the fight against Malaria, which is the leading life threatening disease in the country.

"Of a particular interest to economic development support, there has been promotion of the private sector in agriculture, with special focus being centered on women and youth through promoting vocational skills development.

To this end, the government and private sector are working closely to formulate policies that will protect and facilitate the private sector to grow," she stressed.

Further, she added, the government is in the final stages of revising the Investment Policy of 1996. This process is undertaken through a participatory approach which involves both reliable development public and private sectors.

## Universities with jobless graduates to miss State funds

## **NAIROBI**

**PUBLIC** universities whose graduates fail to secure jobs within a year face reduced cash from the State under a proposed funding formula based on performance.

The formula recommended by the Universities Fund –which guides the allocation of State funds to public universities - is based on five performance indicators, including absorption of an institution's graduates in the job market, research and training on financial management for top officials.

This is a departure from the present formula that is based on the number of students and the cost of courses at the universities.

The formula signals reduced

courses that are not marketable in the job market.

The new funding structure comes in a period when Kenya has witnessed a jump in the number of universities and campuses as well as degree courses, most liberal arts, that offer little opportunities in the competitive jobs market.

funding "Performance-based is funding aimed at allocating a portion of universities education budget according to specific performance measures. It makes funding allocating more transparent and more competitive," UF's board says in the draft.

"The key performance indicators to be considered will be fouryear graduation rate, graduate

allocations to the universities with employability rate (one year after graduation) and research inputs."

Kenya is currently grappling with a large number of jobless graduates in an economy that is struggling to create new jobs.

The number of students enrolled in Kenyan universities has surged in recent years, buoyed by State financing of students in private institutions and the setting up of new campuses. Public universities had 452,089 students last year, up from 412,840 a year earlier, the Economic Survey says.

Kenya has 102 public universities and campuses - which posted a deficit of Sh6.2 billion in the year to June and received nearly Sh70 billion from the Treasury to run their

The State has come under pressure from the World Bank to close and merge some of the cashstrapped public universities, citing duplication of courses and the need to cut spending.

The rise in university enrolment puts pressure on the government to create jobs for the graduates whose number stood at 62,000 in 2002 amid a slowdown in the creation of new jobs. Before the onset of Covid-19, which shed thousands of jobs last year, the economy had been generating less than 100,000 private sector positions. The economy added 69,600 formal private sector jobs in 2019, coming at a time when the government sought to tame its bloated wage bill through a freeze in

up looking for work, disheartened by reduced opportunities in a tough economy that has seen many businesses downsize operations in a bid to survive.

Data by the Kenya National Bureau of Statistics (KNBS) covering the quarter ended March 2021 shows that 1.23 million out of the total of 2.49 million jobless Kenyans aged between 15 and 64 - and who qualify for the labour force – were not actively looking for employment.

The majority of those who have given up on employment are aged between 20 and 24 at 363,018, followed by 25- to 29-year-olds at 232,146.

The 20-24-year-old demographic consists mostly of fresh graduates

Half of jobless Kenyans have given whose job-seeking efforts are hurt by a lack of experience and a mismatch between skills and job openings.

The large numbers of new entrants into the job market every year have also led to limited opportunities, forcing many to seek alternatives such as setting up small businesses.

Since March 2020, many businesses have been unable to take more workers due to the economic problems caused by the Covid-19 pandemic, with many resorting to lay-offs or wage cuts to survive.

Public universities have come under financial strain in recent years as a result of rapid expansion amid a dip in student enrolment to lucrative parallel degree programmes in which students paid fees based on market rates.

## Taxation is now means to achieve environmental sustainability

FISCAL policy has always managed to influence consumer behaviour. In one of my recent articles, I write about the dual role of tax policy that of having a balancing role to increase a country's revenue and at the same time incentivising investment into the country. As a country becomes more competitive from a fiscal perspective, it should be able to attract more investment, whether from internal or external sources, and hence increase government revenue. Apart from the impact on government revenues, fiscal policy has the power to influence consumer behaviour. More importantly, it has the power to influence the behaviour of large corporations.

We have seen countries introduce taxes to deter consumers from buying sugar-based products, we have seen tax incentives introduced to attract students and the work force to industries which were the priority of certain countries. Taxation has always been used as a means to influence behaviour towards achieving the long term, economic vision of the country introducing such

Fiscal policy has a clear role to play in achieving the environmental sustainability and goals, currently being discussed at COP26 in Glasgow.

We have heard a lot about 'green' and 'ecological' taxation, particularly in recent years as the fight against climate change has become a priority of most countries and as citizens continue to push their leaders to take imminent and drastic action against the oil and gas industries. ## Rise in park charges set to take effect from January

Kenya Wildlife Service will in January revert to the 300 percent hiked park charges that had been suspended last year following a public uproar, as it moves to generate additional income to run national parks.

Tourism and Wildlife Cabinet Secretary Najib Balala said the park charges that had been gazetted last year that were to take effect on July 1 and later suspended will start applying from January 1, 2022.

But the new prices will run on a seasonal basis, with the new rates being applied during the high season from November to March and discounted rates for the low season between April to Iune.

KWS in April 2020 announced

new rates rising up to 300 per- Sh1,500 up from Sh1,000 before cent to take effect on July 1, 2020, but suspended amid public uproar citing coronavirus.

"Our effected new park entry fees are going to be effective from January 1, 2022. We had given a 50 percent discount in July 2020 for international visitors and locals and that has now been reviewed and is going to be upward," Mr Balala said. He was speaking ahead of the commemoration of Nairobi parks at 75.

"The parks need resources to run because it is not easy, so we need to revert back to the new prices.'

This means entry fees to Nairobi Park will be Sh1,500 during peak seasons representing a 300 percent jump from Sh500 before the review, while charges to Nakuru and Amboseli parks will the review.

The CS also revealed that KWS will fully shift to online ticketing and digital payment across all parks by July 2022, aimed at reducing pilferage and delays at the gates

The majority of parks under KWS are already accepting mobile payments.

"We are making all entries electronic. Nairobi National Park started piloting for revenue management system to allow payment through mobile money services like M-Pesa or credit card and bookings to made online," he added.

"When a visitor comes here they don't have to waste time spending 10 minutes or one hour to go through the gate. The shift will start here in Nairobi then Amboseli and Nakuru National Park. By July 1, 2022, all parks will be digital to reduce the delays."

Kenya depended on inter-

national travellers for tourism revenues, but this was cut short with the hit of pandemic, which led to reliance on domestic tourists to stay afloat.

The industry anticipates recovery of travel industry next year and resumption of flight increasing number of tourists in the country.

The industry has recorded 600,000 visitors between in the 10 months to October, Mr Balala Said, and expects to hit a million people by December with the reopening of global economies and vaccination, adding that they are already recording full bookings in December.

## Safaricom invites bids for Kenya Power's smart anti-theft system



**NAIROBI** 

AFARICOM has invited bids for firms to install anti-theft systems and smart electricity meters for Kenya Power's consumers in a deal aimed at curbing power theft and leakages and fixing weaknesses on the utility firm's transmission network.

The telco has asked firms to tender for the provision of the hightech systems.

This is part of a Sh31 billion intelligent system that will connect 330,300 electricity meters to a central location and track electricity use, power outages and load on transformers as well as read meters remotely.

"The primary objective of this Expression of Interest is to identify reputable and qualified vendors who will provide a transformer vandalism monitoring system to prevent cases of transformer vandalism by detecting, alerting and prompting response," said Safaricom in internal documents seen

by Business Daily.

The vandalising of electricity distribution equipment is among the leading causes of power outages, undermining the quality of power supply to customers and contributing to reduced productivity in industries.

The Safaricom-backed system is expected to help Kenya Power bring down the share of electricity bought from generators such as KenGen that does not reach home and businesses, technically known as system losses, from 23.93 percent to eight percent, earning Kenya Power additional revenues of Sh71 billion in eight years.

Safaricom said the high-tech system will able to give the location of a transformer on demand and send alerts if the transformer is being moved from its current location.

"It should be able to detect proximity movement for prolonged duration next to the transformer as well as any climbing of the pole," said Safaricom.

# Young tech enthusiasts driving platform for money transferring

WHEN he was pursuing his university studies at Seoul National University in Korea, Adolphe Niyigena would have difficulties in transferring money to his loved ones or for him to receive upkeep.

He says it would often take over 24 hours to receive transfers. He realized he was not the only one facing the challenge with many people having difficulties in money transfer services especially on

"For example, if I had to send money for an emergency purpose, for instance a person is sick and they need to get him or her to the hospital. It was also very costly to transfer money, I then found how serious the problem was," he told Doing Business.

That's what inspired him to implement the idea he has harbored ever since he was a university school student to set up a fast, secure and affordable money transfer service accessible to all Rwandans and worldwide he dubbed' TM Money Transfer'.

Niyigena (28-year-old) is currently the CEO and founder of TM Money Transfer. A digital money transfer platform that is currently involved in offering fast and affordable money transfer services in several countries across the

Originating in Rwanda, TM money transfer was launched officially on November 1, 2019. It is currently working in over eight countries including all East African Community member countries plus Zambia and Malawi as well as South Korea.

Asked about their specialty, he stated that their platform also works with all financial institutions in East Africa. Adding that they offer money delivery services to people who are not able to go to those financial institutions to get their money by delivering money wherever one is.

"On our website there are a few simple steps to follow, this prompts funds to be moved to your account and be transferred according to your destination country in five minutes. After that, the receiver will use his/ her national identity card to any financial institutions and receive his money right away," he explained how TM Money Transfer works.

"TM Money Transfer has been able to make good progress, and we are working hard to go higher. We strive to boost money transfer services with a new technology that is super-fast. For now with TM Money Transfer, the transfer took only one minute to reach Rwanda from South Korea," he told Doing

He also noted that they have started receiving positive feedback and that they are glad their business is making a meaningful impact in the community.

How it started

When he reached Korea in 2014, Rwandans who lived were just a few and not close. He says it was very hard for him to find any information regarding the money transfer service. After finalizing his university electrical engineering studies in 2018, Niyigena went to an electrical company, but for the love and passion he has for doing business he kept looking for ways he can start his own busi-

"My dream was to help Rwandans who live in Korea and bevond. I was very driven by business ideas but after going through all these challenges. I directed my business idea to solve this problem but especially to help the Rwandan community in Korea,"

In 2019, He approached his two friends Uwamahoro Jeanette who is in charge of finance, and Adriel Niyodusaba who is the brain behind the technology they are using to make their transfers, they started as a team of three.

## What we know about the new coronavirus variant now spreading

## 1 What's different about this vari-

SCIENTISTS say B.1.1.529 carries a high number of mutations in its spike protein, which plays a key role in the virus' entry into cells in the body. It's also what is targeted by vaccines. Researchers are still trying to determine whether it is more transmissible or more lethal than previous strains.

#### 2 Where did it come from?

There's only speculation so far. One scientist at the UCL Genetics Institute in London said it likely evolved during a chronic infection of an immunocompromised person, possibly in an untreated HIV/AIDS patient. South Africa has 8.2 million people infected with HIV, the most in the world. The beta variant, a mutation identified last year in South Africa, also may have come from an HIVinfected person.

#### 3 How widespread is it?

The UK issued a temporary ban on flights from six African countries, and others followed suit. ## Japan economic security minister says business must be free

IAPAN'S new economic security minister downplayed concerns about regulations that could hamper international commerce, saying repeatedly the country's commerce was based on a flourishing free market.

"First of all, the basic principle is that business is free," said former finance ministry official Takayuki Kobayashi, who was appointed to the position in Prime Minister Fumio Kishida's cabinet last month.

"Our country can't prosper without that. When looking at areas to be protected or strengthened, like supply chains, we must communicate with private sector companies," he told Bloomberg News in an interview Thursday.

Kobayashi is charged with adding an economic perspective to national security strategy and drawing up legislation on bolstering supply chains, ensuring the safety of core infrastructure, nurturing advanced technology and protecting patents.



## S. Africa detects new virus variant with 'very unusual' mutations

#### **JOHANNESBURG**

SOUTH African scientists have detected a new COVID-19 variant in small numbers and are working to understand its potential implications, they said on Thursday.

The variant - called B.1.1.529 - has a "very unusual constellation" of mutations, which are concerning because they could help it evade the body's immune response and make it more transmissible, scientists told reporters at a news conference.

Early signs from diagnostic laboratories suggest the variant has rapidly increased in the most populated province of Gauteng and may already be present in the country's other eight provinces, they said.

South Africa has confirmed around 100 specimens as B.1.1.529, but the variant has also been found in Botswana and Hong Kong, with the Hong Kong case a traveler from South Africa. As many as 90 percent of new cases in Gauteng could be B.1.1.529, scientists believe.

"Although the data are limited, our experts are working overtime with all the established surveillance systems to understand the new variant and what the potential implications could be," South Africa's National Institute for Communicable Diseases said in a statement.

South Africa has requested an urgent sitting of a World Health Organization working group on virus evolution on Friday to discuss the new variant.

## **Putin signs decree bestowing six Kuzbass** rescuers with Orders of Courage

## **BELOVO**

RUSSIAN President Vladimir Putin has signed a decree to bestow six rescuers from the Listvyazhnaya coalmine in Kuzbass with Orders of Courage, five of them are being awarded posthumously. Russia's acting Emergencies Minister Alexander Chupriyan told journalists.

"Today, the president signed Decree No. 776 to award mine-rescue workers - six individuals and one of them is Alexander Anatolyevich Zakovryashin who was found alive. All the others received the Orders of Courage posthumously," he said.

The tragedy at the Listvyazhnaya coalmine in the Belovsky District of Kuzbass occurred on Thursday morning. Based on the latest data, 51 people were killed, including rescuers. According to Russia's Deputy Prosecutor General Dmitry Demeshin, the accident could have been caused by a methane gas explosion.

#### **European Commission proposes 9** months validity of COVID-19 vaccination

## **BRUSSELS**

A COMPLETE vaccination against COVID-19 will grant European Union (EU) citizens free movement within the bloc for nine months, starting from the date of the last shot, said Didier Reynders, European Commissioner for Justice on Thursday.

Reynders was presenting a proposal of the European Commission to update travel measures during the

The proposal to give full vaccination schemes a validity period takes into account the latest risk assessment by the European Centre for Disease Prevention and Control (ECDC) released the day before, saying that vaccines against COVID-19 show a decrease in efficiency after six months.

The nine months period proposed by the European Commission gives an additional three months to EU member states to administer a booster dose on time.

The validity of the booster will be assessed once enough data has been collected, said Reynders, but is likely to be longer than the primary vaccination.

This standard validity for vaccination certificates should ensure a coordinated approach to travel within the EU, according to the proposal.

"Member States should not refuse a vaccination certificate that has been issued less than 9 months since the administration of the last dose of the primary vaccination," said the European Commission in a press

"Member States should immediately take all necessary steps to ensure access to vaccination for those population groups whose previously issued vaccination certificates approach the nine-month limit," added the commission.

This means that travel measures will now switch from an area-based to a person-based approach.

A traveller presenting a COVID-19 certificate with a complete vaccination of less than nine months should be able to travel freely within the EU, no matter where they come from.

The ECDC map will stay relevant for travellers coming from a dark red zone, and who are not vaccinated or haven't recovered from the disease.

They will need to undergo a pre-departure test and undergo quarantine upon arrival, according to the press release. The European Commission expected its proposal to be adopted by the EU Council soon, and enter into force in January 2022.

## Thousands protest against deal between Sudan PM and military

**KHARTOUM** 

THOUSANDS of Sudanese protested in the streets of Khartoum and other cities on Thursday, keeping up the pressure on military leaders after they struck a deal to bring back a civilian prime minister deposed in a coup one month ago.

Prominent political parties and Sudan's powerful protest movement have opposed Prime Minister Abdalla Hamdok's decision on Sunday to sign the accord with the military, with some calling it a betrayal or saying it provides political cover for the takeover.

"The revolution is the people's revolution. The army back to the barracks!" chanted protesters in Al Daim, a working class district of Khartoum. They called for justice for "martyrs" killed in earlier demonstrations.

Protesters also closed a main road in the Sahafa neighbourhood of the capital.

Carrying Sudanese flags, they chanted "Burhan you won't rule. Down with military rule," referring to Sudan's military leader Abdel Fattah al-Burhan. Live streams on social media also showed protests in

Geneina. While Hamdok's reinstatement was a concession by military leader Burhan, key political parties and civilian groups say the army should play no role in politics. University student Osama Ahmed said he was protesting against Burhan because he wants to bring down the

## China's 'low-carbon' campaign penetrates every area of people's life

CHINA has pushed ahead with allround carbon emission reduction to promote comprehensive green transition of economic and social development, not only carrying out major reforms in key industries, but seeking green-oriented changes to the trivial details of people's life.

Carbon emission reduction, as many people know, is more often than not considered a task of such industries as energy, transportation, and manufacturing. China, while cutting carbon emissions in these industries with major energy consumers and major carbon emitters, is also paying attention to greening the service sector that is more closely related to people's every-

A few days ago, a friend of mine who often goes to the theater told me that paperless e-tickets have become more widely seen in recent years.

At first, my friend wasn't used to etickets as he considered elaborately designed and beautifully printed tickets collectable. Later, however, he gradually found e-tickets more convenient.

"Printing paper tickets means energy consumption. So we are actually doing our part for carbon emission reduction," he said.

Data from a ticketing platform show that it has sold 23 million e-tickets in the past three years, which are equivalent to cutting carbon emissions by about 1,400 tons and electricity consumption by about 1.4 million kWh.

China has seen results in reducing carbon emissions in the service sector, a good example of which is the ecological benefits brought by the 23 million e-tickets.

From a broader perspective, since the service industry concerns numerous consumers, every little change in their consumption link, when accumulated, will have an effect that cannot be ignored.

Besides, promoting the reduction of carbon emissions at small areas of the service sector is less difficult. While the renovation and upgrading of factories requires a lot of manpower, materials and funds, carbon emission reduction in the service sector has lower requirements of equipment upgrading and process reengineering and relies more on companies' operational concepts.

The efforts to promote carbon emission reduction in the service sector have exerted a strong influence on the Chinese society. As the concept of green development prevails, seeking low-carbon approaches has gradually become a conscious decision of service providers.

At the same time, the little changes in the service sector are changing consumer psychology in China and enabling consumers to foster a better environment for green development together with service providers.

In recent years, China has taken plenty of measures to conserve energy and reduce carbon emissions, including calling on people to set air conditioners at a higher temperature in summer and not to ask for disposable tableware when ordering takeout food online, as well as encouraging the application of e-bills and waste recycling.

It is believed that the country will surely witness more fruits in carbon emission reduction as long as it maintains the current momentum.

## **US threatens escalation with** Iran at IAEA next month

THE United States threatened on Thursday to confront Iran at the International Atomic Energy Agency next month if it does not cooperate more with the watchdog - an escalation that could undermine talks on reviving a 2015 big-power deal with Iran.

Tehran is locked in several standoffs with the IAEA, whose 35-nation Board of Governors is holding a quarterly meeting this week.

Then-president Donald Trump pulled Washington out of the 2015 agreement that lifted sanctions in return for restrictions on Iran's atomic activities. He re-imposed debilitating sanctions, after which Tehran progressively expanded its nuclear work and reduced cooperation with the IAEA. Iran is denying the IAEA access to re-install sur-

veillance cameras at a workshop at the TESA Karaj complex. The IAEA also wants answers on the origin of uranium particles found at apparently old but undeclared sites, and says Iran keeps subjecting its inspectors to "excessively invasive physical searches". "If Iran's non-cooperation is not immediately rem-

edied...the Board will have no choice but to reconvene in extraordinary session before the end of this year in order to address the crisis," a US statement to the Board of Governors said. It said it was referring "especially" to re-installing

IAEA cameras at the Karaj workshop, which makes parts for advanced centrifuges that enrich uranium.

That workshop was struck by apparent sabotage in June, which Iran says was an attack by its arch-enemy Israel. One of four IAEA cameras installed there was destroyed and its footage is missing. Iran removed all the cameras after the incident. Israel has not commented on the incident.

IAEA chief Rafael Grossi said on Wednesday that he did not know if the workshop was operating again, and that time was running out to reach an

An extraordinary Board meeting would most likely be aimed at passing a resolution against Iran, a diplomatic escalation likely to antagonize Tehran.

That could jeopardize indirect talks between Iran and the US on reviving the 2015 deal, which are due to resume on Monday. Agencies

The central referee will board the bus, again at his fare and then be reimbursed later.

He will then be given 350,000/- for the entire trip, but the assistant referees get less than that.

So who told Tanzania's football officials that local football could not succeed without a match organizer and what exactly is he or she coordinating?

CAF has appointed the personnel due to their current system of governance including the main match management center, whereas TFF and the TPLB do not have the centers.

Now, what wonders does the local organizer bring and to whom does he/ she report?

**T**HILE football analysts were still pondering what is happening in the NBC Premier League, especially following the questionable penalty given to Young Africans SC, alias 'Yanga', and even the manner it was taken in its Namungo FC encounter, enabling it to register fairly positive results in the last minutes of the game.

This issue has been extensively discussed as it merely touches on the referee's intentions or abilities, while earlier troubling situations where Simba SC faced far more than its fair share of fouls wasn't being aired.

To wit, players of opposing sides were being motivated to do all they can to win, fair or foul, for a generous cash bonus.

It was getting increasingly obvious that this motivation could not have come from inside the club as it is an unwise investment for players to seek three points against Simba SC, above all else.

They could allow such encounters to slide and obtain better results with more manageable sides, but there was an inspiration to get the points from Simba SC, and what's more, it did not come from club leaders in the first place.


It seemed to stem from the regional leadership when the team was in play, how could they prom-

FOOTBALL, for many years, has been traditionally considered a male sport.

In challenging the community beliefs that undermine women's participation in football in Tanzania, Organization for Community Development (OCODE), a non-governmental organization, currently provides an opportunity for talented girls who may wish to make football their career.

The OCODE operates the project under one of the organization's programs, which aims to promote and facilitate the use of sports as a developmental tool among out-ofschool adolescent girls and schoolgoing children in primary schools.

The organization has organized a football competition for more than 150 girls in Kibamba District, Dar es Salaam.

The OCODE Program Officer, Jeremiah Mmbena, disclosed the tournament, known as the 'Inter Bonga Competition', is part of a 10-month circle project that empowers out-of-school adolescent youths aged 13-19 who, due to various reasons, have not progressed in the formal education system.

Mmbena revealed tournament includes girls who are in the organization program and who wish to make football their

The official noted: "The Inter Bonga Competition kicked off on November 15, bringing together 10 girls' teams aiming at helping them

Irene Peter Pela, aged 19, one of the footballers that took part in the tournament, expressed her happiness over getting the chance.

She disclosed: "I can now play football the same way boys do and I am enjoying what I am doing.'

"Football has become part of me and I have realized that my body is stronger and fit now."

"Football has enabled me to network with different people in different leagues such as Dar es Salaam Women league, East Africa virtual competitions which all together have increased my self-esteem."

"They have further enhanced my understanding on various issues such as Poverty, Sexual Reproductive Health, Hygiene, and Sanitation, following the follow-up seminars held after the tournaments.'

Stephania Kabula, Tanzania Football Federation (TFF) women soccer official, who graced trophy handover ceremony, stated: "We are so impressed with such an organization like OCODE which decided to empower girls' participation in soccer."

Stephania noted: "I know that girls have so many ways to be empowered so they should focus on soccer since there are a lot of opportunities and one might get employment through soccer."

## Africa expected to endorse plans for World Cup every two years

#### **JOHANNESBURG**

AFRICAN member countries are expected to overwhelmingly support plans to increase the frequency of the hosting of the World Cup to every two years -- and back the creation of a Super League when the Confederation of African Football (CAF) holds an extraordinary congress in Cairo on Friday.

Support for holding the World Cup every two years in place of the current four-year cycle has already been expressed by CAF president Patrice Motsepe and the usually compliant congress is expected to endorse FIFA president Gianni Infantino's plans.

"One of the biggest beneficiaries of a World Cup every two years is the developing countries," Motsepe said at a news conference last month, and will, reportedly, advance the argument that additional World Cup revenue will trickle down to African members and boost their coffers.

This comes despite the threat to the continent's flagship event -- the African Cup of Nations. It is held every two years, because it used to bring in 80% of CAFs revenue before the confederation starting receiving financial grants from FIFA.

Motsepe has become a close ally of Infantino, who has pushed hard in recent months for acceptance of his plan to increase the frequency of the World Cup but has met with considerable opposition from Europe and South America.

CAF is also expected to ask for the formal approval of plans for a Super League -- another Infantino idea -- that will see a permanent roster of some 20 teams with one or two changes every

"The super league for Africa is a new competition because all of those other competitions are locked into agreements and the money they get is not enough," Motsepe said.

Similar plans for a Super League in Europe failed spectacularly but, despite this, Africa has pressed forward with its own version.

Friday's gathering is an extraordinary congress and the second this year for CAF's 54 members after Motsepe was elected president in Rabat in

The Premier League giants have identified the German, 63, who is currently head of sports and development at Russian club Lokomotiv Moscow, as a potential short-term successor to the Norwe-

Michael Carrick took charge of the side for Tuesday's Champions League win at Villarreal, which secured progress to the knockout stages, but the club want to bring in a more experienced figure until the end of the season.

United are planning to make a permanent appointment at the end of the campaign, with Paris Saint-Germain boss Mauricio Pochettino strongly linked to the job.

The Athletic reported that Rangnick, the former RB Leipzig manager, had reached agreement with United to take over, saying the agreement was subject to Lokomotiv agreeing to release him from his contract.

But it said he would not be in charge in time for the game at Chelsea this weekend due to work

"All my energy and my mind at the moment is on Sunday. I control what I can control," said Car-

"Everything else is not for me to worry about and get involved with because I need to win a game of football and that is what I am looking forward to doing."

Solskjaer was sacked on Sunday following his side's embarrassing 4-1 defeat to lowly Watford.

They are eighth in the Premier League after losing four of their past five matches, 12 points behind leaders Chelsea and six points adrift of fourth-placed West Ham.

Solskjaer struggled to get the best out of a richly talented squad after the additions of Cristiano Ronaldo, Jadon Sancho and Raphael Varane in the summer transfer window.

It remains to be seen whether Rangnick is the right fit for an under-performing collection of individuals.

He has built his reputation as the Godfather of modern German coaching on an intense pressing style normally with younger, less heralded, players.

THIS is a tale of the improbable, the sort of story that happens very rarely but just often enough to nourish our wildest aspirations and give a dusting of meaning to our existence.

This is a story of a young man who (as he admits himself) drove home drunk in a rusted jalopy on the night of his brother's wedding, flew off an unpaved road into the fields and lay in the mud, waiting to either die or be saved.

Of a kid who dominated village tournaments in the countryside outside the city of Belo Horizonte in Brazil and on a good day would get paid in cases of beer, but when he made the giant step into the big time -the academy of Cruzeiro, where the original Ronaldo made his debut -he realized he wouldn't make the grade. After three seasons chasing a professional contract, on the eve of his 20th birthday all he had to show for it was a place in the seventh tier of the Brazilian football pyramid at a club called Ideal (which was anything

Of a man who realized, aged 20, that football is great and fun and so are dreams, but with a young wife and child, reality bites and bills must be paid. And so he emigrated to Italy, joining his brother, where his first job was -- literally -- polishing bricks recovered at demolition sites for 20 cents a pop and his second was delivering kitchen appliances (toasters on a good day, refrigerators on a bad

one.) Of a guy who realized

that working building sites, getting your hands dirty, out in the open air and doing so to support your family is the peak of fulfilment, more so than playing football, which had become, as he puts it "a pastime, not a goal." That said, when a team of fellow immigrants, albeit from Peru, persuaded him to join their club, Sport Warique, in Turin's adult recreation leagues, he could not say no.

Of an undocumented economic migrant who, like most, knew that his story would end one of two ways: with a bureaucrat finding his application amid the backlog of cases, sending it to a judge and getting the green light to stay or with people in uniform knocking on his door. The day after he received his residency visa, he signed with Casale, a club in the fifth tier of Italy's football pyramid. He was delighted, but it had to make sense for him and his family, which is why he turned down the club's first ofary of €1,500 a month, slightly more than what he was earning making deliveries.

Of an Evangelical Christian who, if those papers hadn't come, was ready to quit football -- or, more precisely, his dimension of football at the time, local Turinese rec league stuff, playing with the Peruvian waiters and factory workers -- and instead devote his weekends and free time


in the knockout phase alive. Of the 62 goals he has scored since returning to football, it's only the fourth time he has scored with his head.

Of an attacking midfielder on a relegated team who signed for Milan on loan in August in the final hours of the transfer window, largely because they needed an extra body off the bench and had failed to land their top targets in that role. And, indeed, he had featured just twice, for a total of 51 minutes, before coming off the bench Wednesday with 25 minutes to go.

This is the improbable story of Junior Walter Messias and if you think it's made up, I wouldn't blame you. Heck, even his name sounds biblical. But Messias himself told the story not long ago. And you yourself may well have seen him rise up to meet Franck Kessie's cross and score the winner for Milan.

This is football. This is sports. This is where the improbable lives and, every so often, pops up out of its hiding place to make us fall in love all over again.

## Premier League Board defends referees

TANZANIA Premier League Board (TPLB) has stated mistakes committed by referees in recent NBC Premier League fixtures are humane, contrary to what people think.

The statement was made by the body's Chief Executive Officer, Almasi Kasongo, after complaints were lodged against the referee, Abel William, who officiated the match between Namungo FC and Yanga, which took place at Ilulu Stadium, Lindi on November 20 and ended in a 1-1 draw.

"According to our system, at the end of every game, we meet to go through a series of events, so it is up to the committee to come up with answers to what they have identified," said Kasongo noted.

With the 2021/22 NBC Premier League's seventhround fixtures having started yesterday, referees are to be under pressure given many stakeholders are increasingly complaining about the decisions of some referees, who officiated in previous matches.

In another development, Mbeya Kwanza FC head coach, Haruna Harerimana, has warned Yanga, urging them to brace for stiff opposition from his outfit.

The clubs will face off in the domestic topflight encounter at Sokoine Stadium in Mbeya next week.

The Mbeya Kwanza FC coach pointed out the outfit is planning to make history as the first league newcomer to beat Yanga.

Harerimana noted he derives his confidence from the fighting spirit that exists in his players regardless of the opponents they face.

"We know we are going to play against a prominent club but that will not scare us. We are determined to contain them and that is possible due to the quality of my young players compared to those of our opponents," the Burundian gaffer noted.

The Burundian coach said the number of points they currently have is not enough to give them respect so in the November 30 game they are determined to make sure they leave with three points at Sokoine Stadium.

It has also won one Challenge Cup and also won the Community Shield in Zambia once.

In continental competitions, Red Arrows FC has been less of a threat as the side has not qualified for at least the group stage since its inception, and the squad was eliminated from the knockout stages in the previous three outings in 2005, 2009, and 2012.

In 2005 it represented Zambia in the CAF Champions League and bowed out of the second round, four years later it crashed out of the first round of the CAF Confederation Cup and, in 2012, it was eliminated from the preliminary round.

The club's qualification for the CAF

Confederation Cup playoffs this season, in which they will face Simba SC, is their biggest achievement so far that the former has ever achieved internationally.

The team has been wearing red jerseys for its home matches and blue jerseys for away matches and the squad also has a white third kit.

Red Arrows FC secured a ticket to the CAF Confederation Cup after finishing third in the Zambian Premier League last season behind champions, Zesco United, and second-placed Zanaco FC.

In the preliminary round of this season's CAF Confederation Cup, they were scheduled to face the Young Buffaloes of Eswatini and in the first match at home, the former emerged with a 2-1 win and drew 0-0 away.

In the showpiece's first preliminary round, they met Primiero de Agosto of Angola and started at home with a 1-0 win, and a rematch ended in a 0-0
