SADC army chiefs see besieged Goma

KINSHASA

TOP army officials from the southern Africa regional bloc at the weekend visited Goma, main city in the eastern part of the Democratic Republic of Congo, amid the fighting between government troops and M23 rebels.

The chiefs of defence staff of the Southern Africa Development Community (SADC) countries held a high-level meeting in the city of Goma, capital of the embattled North Kivu province.

Gen. Sylvain Ekenge, Congolese army spokesman, said the meeting focused on assessing the progress of operations on the ground, and finetuning strategies for strengthening the various units.

Somalia signed the treaty of accession at the Entebbe State House back

Within six months after signing the treaty, Somalia was required to deposit the instruments of ratification with the EAC Secretariat, meanwhile as the Council of Ministers was tasked to develop a roadmap for the integration of Somalia into EAC or-

A report of progress in that direction was to be presented to the next meeting of the summit for evaluation by the other partner states, namely Burundi, DRC, Kenya, Rwanda, South Sudan, Uganda and Tanza-

The visit by the chiefs of staff was a strong signal of the commitment and determination of SADC and Burundi alongside the DRC, he said, noting that it was their first coordination meeting since the deployment of SADC troops in North Kivu.

It came two days after SADC armoured vehicles were hit during an M23 attack on Friday, as the generals visited the strategic town of Saké, when the rebels threw five in the ongoing fighting, with Muisa bombs killing and wounding several

Placide Nzilamba, a member of Goma civil society said the city residents welcome the presence of the SADC generals, expressing the view that the visit has enabled them to understand the situation, "having experienced the reality on the ground in terms of insecurity."

But some Goma residents were not sure that the visit would make a difference in changing the odds

Christian, a resident, saying that the future of Congolese security can only come from internal strategies from the FARDC (the DRC armed forces) rather than the SADC countries.

M23, seen by many as an autonomous unit of the Rwandese army, launched a major offensive back in 2021 and has since captured large swathes of North Kivu province, displacing hundreds of thousands of local residents.

Aid organisations fear a new humanitarian crisis in the region, as M23 advance threatens to cut off the city of Goma and leave millions of people struggling for food and medical help.

He urged the government not to use much force in addressing the challenge but rather sit down calmly with the service providers, to avoid impacting health services delivery.

He said that m claims raised by private hospitals have a grain of truth and that the new package rolled out by NHIF relating to various charges were unfair to private entities, "so being overly aggressive on the issue will only end up affecting the lives of people."

"Being too harsh to the private hospitals forcing them to provide quality services at a cost that is not appropriate with the service. means that either the patient will have to pay additional funds or be subjected to inadequate care,: he

"What is going on isn't healthy at all and we urge the government to think on this matter wisely," he emphasized, while Godlisten Malisa, the UTG chairman, said that it is better for the government to suspend the new NHIF package "as allowing it to continue will greatly affect health provision in the coun-

"It is better for the committee to review the new package and closely engage stakeholders including experts from the ministry, NHIF, public and private hospitals as well as members of the fund in order to come up with a package which will be fair for all," he elaborated.

He similarly appealed to the government to ensure that all the funds taken from NHIF as loans are repaid.

He also demanded that the gov-

ernment to take stern measures on public officials cited in the report of the Controller and Auditor General (CAG) last year over embezzlement within NHIF. The 146 officials listed by the

CAG over embezzlement of 14bn/should be punished, including sending them to court, he further stated. The activist also wanted the government to cover operational

costs of the fund in order to ensure that the funds collected are used to cover treatment services and not misdirected. UTG activists similarly want the formation of an NHIF members'

council which will involve representatives from those imsured with the fund, to monitor service provision and ensure the funds are properly spent. The opposition ACT Wazalendo

urged the government to address the ongoing dispute between NHIF and the Association of Private Health Facilities in Tanzania (APH-FTA) to restore provision of quality health services.

Its Health shadow minister, Dr Elizabeth Sanga asked NHIF to stop the new packages, revisit the universal health insurance law for it does not remove the problem of financing and sustainability, "does not save NHIF nor help provide relief to the people."

Meanwhile, NHIF delegation on Saturday visited the Regency Medical Centre in Dar es Salaam and talked with the management where they agreed that the hospital provides services while other issues are being addressed.

Led by NHIF director general Bernard Konga, the delegation arrived at the hospital to inspect how services for NHIF members are progressing at the hospital.

He apologized to NHIF members for the inconvenience they experienced, assuring them that they have already spoken to the hospital management and assured them that services will be maintained.

Tanzanians urged to appreciate role of waste pickers

TANZANIANS have been called upon not to look down on waste pickers since they play a vital role in environmental protection.

The call was made in Dar es Salaam at the weekend during an event to commemorate Global Waste Pickers Day which brought together officials from PET Recycle Company Limited (PETpro), JUZA Waste Pickers Initiative and Human Dignity and Environmental Care Foundation (HUDEFO). Nicholaus Ambwene, PETpro Country Coordinator said the event aimed to address the negative perceptions the society has towards waste pickers, adding that such individuals do a good job of keeping the environment clean.

"Without waste pickers, garbage of all sorts would be scattered all over the place. The event intends to show we support them. As a private institution, we have handed over equipment to 80 individuals to help them overcome the challenges they face in waste collection. The equipment is expected to also help the society recognize and acknowledge them rather look down on them," he said. "This serves as a call for the government to see how it can support these people. As environmental stakeholders, we strive to address their challenges and make this initiative sustainable and alleviate stereotypes held against them by society."

Ambwene said the theme for this year was 'kazi kama kazi zingine', meaning job just like any other job. Through waste picking, he said pickers generate income, take care of their families, pay bills, school fees, and pay house rent, suggesting that the

government should make a law to guide waste producers so that they support waste pickers to protect the environment and the waste picking value chain.

Killian Haule, owner of Haule Bottle Recycling Center shared his account of how waste picking changed his life from a waste picker to a businessman owning a recycling facility in Dar es Salaam.

"Waste picking is an honest income generation activity just like any other form of self-employment. Through it I have managed to start my own waste collection and management centre which enables me to take my children to good school. This activity has changed my life for the better," he said. Haule called on the government, non-government organizations and public institutions to support initiatives to help people collecting waste materials, adding that loan packages should be created to aid waste pickers so that they can improve their activities. Nasibu Katibu, chief executive officer of JUZA Waste Pickers Initiative, said that there have been talks with other stakeholders on how to convince the government to formalize waste picking because it is an activity that employs a large number of youth, noting that through collaboration with other stakeholders, some youth who graduated from drug rehab had been trained on how to collect waste materials as an income generation activity.

PETpro is a company created by seven beverage companies and one plastic packaging production company collaborating in the management of plastic waste materials. They are Nyanza Bottling, Coca-Cola Kwanza, Bonite Bottlers, SBC Pepsi, Sayona Drinks, Cool Blue, A-One Products & Bottles Ltd and SilAfrica Ltd.

Cleric calls for joint efforts to identify people with mental health issues

EFFORTS are needed to identify and report individuals with symptoms of mental illness as a measure to decrease crimes committed by sick people.

The call was made by Rev Fr Dennis Ngowi, head of child protection affairs in Arusha Catholic Archdiocese pointed out threats as among the symptoms of a person with mental disorder.

"Lifestyle, child upbringing and lack of accountability towards the society are the causes of mental disorders. As a church, we have started to address this problem from its early stages rather than superstition as a source as widely but wrongly believed," he said.

Fr Ngowi said that residents of Arusha Region are supposed to take action to identify people with symptoms of mental illnesses including those who threaten other people, adding that in recent years, the city has witnessed many violent incidents that have left families in grief.

He added that the institution has decided to protect children since they do not have the ability to express themselves like adults who have the cognitive capability to identify and report whenever they feel threatened. Fr Ngowi said

that initial measures taken include awareness building through seminars for pupils in primary and secondary schools and meetings with parents on special days every month when they visit their children in schools.

"The results of awareness and capacity building have been fruitful. However, more needs to be done to reach more people," he said

"Parenting is a major problem. I would say that parents are to blame for young men and women who have turned out to be bad examples in the society because of poor childcare by parents which leads to indiscipline."



Herders want help as 'strange' disease kills livestock

THE government has been urged to conduct immediate study on a strange livestock disease that has emerged in some parts of Arusha Region.

This was raised here at a special forum which brought together ecological farming stakeholders at the weekend, an event which was organized by Island of Peace, a non-governmental organisa-

Speaking on behalf of his colleagues at the forum, one of the livestock herders from Longido District, Nambori Nabaki, said that the disease which mostly affects goats and sheep causes sudden death of animals.

Nabaki said that pastoralists in the areas have nicknamed the disease as 'Ormilo' and that if immediate measures are not taken, it can inflict big economic dam-

age to individual herders and the into poverty. region as a whole.

"Goats and sheep in Longido vanish rapidly because of this strange disease. We have done all we could to identify the cause of the disease but we have not succeeded," he said.

He asked the government to take immediate measures to identify and control the disease as delays threaten to plunge many families in the Maasai herder community

"What we have found is that brains of animals that die from the strange are consistently full of water. It is hard to control currently because the signs of sickness do not last long before the animal dies," he said.

"We appeal to the government to deploy experts in the affected areas to conduct an investigation to

find out what causes the disease." Dr Linus Prosper, Arusha Dis-

trict Council Livestock officer, said that such diseases always attack animals like sheep, goats and dogs. According to him, the disease comes from dogs that he said have parasites that attach themselves onto the small intestine of dog and develop into adult tapeworms.

He added that then goats and sheep get infected by consuming parasite eggs deposited with dog faeces onto grazing pasture or wa-

He said once a sheep or goat is infected with the disease, they start to feel dizzy until they die.

The expert however said that no treatment has been identified for the parasitic infection once it has settled into the brain of an infected animal.

He urged the pastoralists to ensure that their animals are always prevented from diseases taking all their dogs for vaccination.

Live and let live best to end NHIF cards use disputation

sions that legal action was awaiting private hospitals refusing to provide health services to National Health Insurance Fund (NHIF) card holders.

This was widely feared to be setting the stage for a stand-off between the government and the private sector and, even more accurately, between the bureaucracy and private hospitals.

A number of policy, legal and even moral issues are being raised, including as to whether making a profit in medicine is decent or more generally - acceptable.

It is this sort of debate that Health minister Ummy Mwalimu risked in one aspect of reactions to reluctance or outright refusal by private hospitals to serve NHIF clients. The first reaction heard from the public in reporting from at least two regions is that those visiting or seeking medical consultations in private hospitals with NHIF cards finally had to resort to public health facilities.

That doing so entailed - or even induced - immense discomfort is easy to comprehend, but whether it is something to touch off a crisis is subject to discussion.

There possibly would be no problem were it merely that the issue was getting patients treated, as there is no policy left or right that such and such a patient ought to be treated in a private hospital.

The case would thus be that anvone wanted medical attention in such facilities, that particular person (alone or with members of his or her family) would know where to take out an insurance policy.

The scenario would be would be similar to that of employers - including the government - wishing their staff to be treated in private hospitals. Trouble lies elsewhere, though, in that NHIF wants to fill its coffers by getting everybody on private health facilities.

THERE have lately been impres- board when it levels out charges in most hospitals. The recent ministerial statement on this issue had elements of wishing to live in peace with private hospitals by declaring that doors for dialogue were wide open - while insisting that they insisting that they continue accepting NHIF card holders.

The latter aspect had a corollary, in asking the registrar of private hospitals to issue a notice on apparent regulatory acceptance of NHIF cards in all hospitals, and all reference to the registrar implying that non-compliance would automatically mean deregistration.

If that was a clearly figured out option, to restore the status quo ante (that is, before hospital administration was liberalised in 1992), there would be no point in also hinting at legal action against non-compliant hospitals.

The way the reference to such action was made was to hint at criminal pursuit in connection with negligence of a patient in need of being treated, etc.

On might however argue that it would in reality be a civil suit, the issue being whether a service provider had no freedom to place tariff limits to accessing services.

It would thus stand as refusal of access on a non-tariff basis that would constitute discrimination, even legal claims. While the regulatory authorities aren't there yet, and are unlikely to go that far, there is a temptation on their part to restore the 1977-1992 modalities, where there were two types of public hospitals: those run by the government and those run by religious organisations.

Even now this scenario is emerging, as institutions run by the various denominations show willingness or even readiness to comply with the NHIF sets of charges or packages, unlike individually-run

Our neighbours rightly cherished President Mwinyi's trade reforms

NOT surprisingly, African leaders and range of members of the diplomatic corps this past week joined Tanzania in mourning former president Ali Hassan Mwinyi, who died in a Dar es Salaam hospital on Thurs-

A few voices were especially noticeable, not only those of the likes of Kenyan President William Ruto and opposition leader Raila Odinga but also 'ordinary citizens' with sound memories of the mid-1980s.

It was not just Tanzania that came out of the rut of living with biting shortages in most of what people routinely need but neighbouring countries as well.

This was vivid from reactions elicited from a raft of people interviewed on various local, national and international media outlets.

When too few goods for comfort were available in the Tanzanian market or could only be imported with impossibly prohibitive tariffs, the fresh air of free importation of home use goods was unfathomable in its positive impact.

This is something that was evident in what most of the people interviewed said, with most crediting it almost exclusively on the late former president.

Even if fronting tinges of "wellmeaning" exaggeration, even distortion, some had the feeling that all this had to do with President Mwinyi's treatment of neighbouring countries. For the major point for many observers was the regional impact of free imports of goods - as then the neighbours could easily obtain such goods, changing the atmosphere appreciably. It was in the spirit of the adage of welcoming the

stranger to save the native. This kind of impact is one area of unspoken efficacy of neigbbourliness, not just in serving as role models of how the future ought to be organised or designed by imitating policy action but also in opening up opportunities hitherto absent.

By implication, while founding president Mwalimu Nyerere had a much heralded role in the subregion with his steadfast support for liberation movements, his economic policies locally were also stressful for the region. Rather to the contrary, his successor (Mwinyi) took the region to new heights in living up to popular expectation with respect to the availability of literally all basic necessities, that is from basic needs like food and clothing to "luxury items" like TV. The problems that caused Mwinyi immense discomfort right towards his final years as president included the public bitterness experienced when he started moving in the direction of a profound restructuring of the country's parastatal sector.

A speech he gave to the national legislature in 1994, outlining successes in that direction, showed that the country had something like 525 state-owned firms.

Since at present there are upwards of 350 such entities, from which the government habitually reaps profits and dividends, it implies that roundabout 200 were disbanded, sold or turned into joint ventures. There are lessons researchers have usually refused to draw and indeed even study - as to which companies succeeded after being privatised and which failed, and why.

Rwanda-DRC conflict looks set to widen into regional war, pulling in South Africa

IN the eastern Democratic Republic of the Congo (DRC), South African, Burundian and Tanzanian troops are fighting against the Rwandan army, which has deployed in support of the rebellion by the March 23 Movement, or M23.

Soldiers from South Africa and Burundi, as well as from the United Nations (UN) peacekeeping mission, have recently suffered casualties. In the crossfire, civilians have fled: 7 million Congolese are now displaced due to this and multiple other crises in the DRC.

Diplomats are concerned: the conflict in the eastern DRC was the subject of a special meeting at the United Nations Security Council on 20 February 2024 and a minisummit on the sidelines of the African Union annual meeting of heads of state on 16

Rwanda, which has denied backing M23, says the Rwandan rebel group Forces Démocratiques pour la Libération du Rwanda (FDLR), which includes combatants who participated in the 1994 genocide, has been fully integrated into the Congolese army. It also claims that the Congolese government is engaged in "massive combat operations" aimed at expelling Congolese Tutsi civilians.

The Congolese government has mounted a campaign against Rwanda. In December, while he campaigned for re-election, President Félix Tshisekedi compared his Rwandan counterpart, Paul Kagame, to Adolf Hitler and accused him of expansionist aims.

In January, the Burundian president Évariste Ndayishimiye closed his border with Rwanda and accused the country of backing rebels against him. He stopped just short of calling for Kagame's ouster.

We have been working on the conflict in the DRC for around 20 years. This wave of violence resembles previous ones, but is also different. At the root of the M23 conflict are countries such as Rwanda and Uganda, intent on projecting power and influence into eastern DRC, while the Congolese government seems incapable and often unwilling to stabilise its own territory. Donors and UN peacekeepers provide humanitarian aid, but do little to transform these dynamics.

Resolving this crisis will require less hypocrisy from foreign donors, the end of Rwandan aggression and a more accountable Congolese government. But the hopes of a grand bargain are far off, for now. The current peace processes - a "Nairobi process" for domestic negotiations and a "Luanda process" for regional talks - are dead or on life support.

The upcoming elections in Rwanda (July 2024) and the US (November 2024) will likely not help cool heads or focus minds. But it is clear that ending the violence will require a new approach, one that places the lives of innocent Congolese civilians at its centre. Beginning of regional escalation

During the early days of his presidency, Tshisekedi's army collaborated intensely with the Rwandan army, allowing troops

to conduct operations against the FDLR on Congolese territory in 2019 and 2020. In late 2019, his government even recommended dropping charges against the M23 commanders, then in exile.

Less than three years after winning power, however, Tshisekedi changed his approach, breaking his coalition with his predecessor, Joseph Kabila, and moving to cement his position in power. He declared a state of siege in two eastern provinces, shuffled generals around in the army and sidelined key securocrats. He also shifted gears in his regional relations.

By mid-2021, Tshisekedi had begun to privilege relations with Uganda, then a bitter rival of Rwanda. Notably, Tshisekedi gave permission to the Ugandan army to deploy somewhere between 2,000 and 4,000 troops to hunt down Allied Democratic Forces rebels, an Islamist Ugandan rebellion based in eastern DRC. Shortly after that, he did the same for the Burundian army, which had its sights on RED-Tabara, rebels based in the DRC seeking to overthrow the government of Ndayishimiye.

Rwanda suddenly felt isolated, even vulnerable, surrounded by hostile neighbours. According to UN investigators, it probably resumed throwing its weight behind the M23 in November 2021. It is, above all, these regional tensions, coupled with its goal of maintaining influence in the Congo, that pushed it to move.

Since then, the regional fault lines have shifted. Rwanda has patched up relations with Uganda, and the East African Community intervention force - Kenyan, South Sudanese, Burundian and Ugandan troops - that deployed in 2022 to help quell the violence was asked to leave just a year later. This is because their hosts saw them as dragging their feet, if not complicit with the M23. Tshisekedi, who came into office seeing East African countries as allies, has now

turned southwards.

Military changes in eastern DRC Beginning in late 2023, a new force from the Southern African Development Community (SADC) began deploying troops from South Africa, Tanzania and Malawi to take the fight to the M23, alongside the Burundian

army. Already, these forces have begun to take casualties. Two South African soldiers were killed on 14 February by a mortar strike; two others were injured when their helicopter took fire. Some sources indicate that Burundian soldiers have taken heavy losses.

The rising degree of military sophistication also raises eyebrows. The US government has accused Rwanda of deploying surface-to-air missiles; UN officials have reported armed drones striking their bases; while Tanzania has sent Soviet-era BM-21 Grad rocket launchers. The DRC has bought nine Chinese CH-4 combat drones (three of which have reportedly been shot down already).

Meanwhile, the Congolese army has partnered with private security contractors as well as with an array of local militia, collectively dubbed Wazalendo (patriots), who are poorly trained and disciplined. There are credible reports from late 2023 that, as in the previous year, they are also partnering with the Rwandan FDLR

And yet, the Congolese government has been unable to make much headway. In early February, M23 forces surrounded the lakeside town of Sake, just 30km west of the provincial capital Goma. This most recent push has displaced another 135,000 people towards Goma; there are around half a million displaced people around the town now.

Mixed signals

Unlike the previous M23 crisis, influential foreign actors have sent mixed signals. At the UN Security Council on 20 February, the US and France called on Rwanda to withdraw their troops from the DRC. The US has gone the furthest of all of Rwanda's donors, sanctioning a Rwandan general, suspending all military aid and attempting to broker a ceasefire in December 2023.

And yet, the US remains, by far, the largest donor to Rwanda, which receives the equivalent of around a third of its budget in aid. Other countries have pushed much less or not at all. While the M23 rebellion was going on, the British Commonwealth held its big biannual meeting in Kigali in 2022 and the UK struck a controversial asylum deal with Rwanda.

The EU gave \$22-million to support the deployment of the Rwanda Defence Force in Mozambique. On 19 February, the EU announced a deal to boost mineral exports from

This last piece of news caused an uproar in the DRC, touching on the popular belief that minerals are the root of the crisis. While the causes of the violence are far more complex than that, they have a point: the largest export from Uganda (56% in 2021), Rwanda (23%), and Burundi (29%) in recent years has been gold, almost all of which is smuggled to their countries from the DRC.

In the long term, the DRC government will need to undertake a host of reforms to quell these cycles of conflict. They include reforming the Congolese army, a new demobilisation programme for armed groups, an economic development programme that would allow Congolese to benefit from their resources, a plan for communal reconciliation, and an end to discrimination against Kinyarwanda speakers.

But none of that can happen as long as Congo's neighbours continue to destabilise it.

Shinyanga green gram farmers appeal for urgent policy reforms and market revival

I the heart of the Shinyanga Region in Tanzania, green gram farmers find themselves entangled in a web of challenges, ranging from a scarcity of markets to a controversial voucher system.

John Mgui, a prominent green gram farmer, expressed deep concern over the current situation, highlighting the stark absence of buyers in the region.

This plea for intervention resonates across the fields as farmers not only grapple with a market drought but also contend with the perceived pitfalls of the warehouse receipt sys-

Mgui urgently appealed to Agriculture Minister, Hussein Bashe to intervene and revive the green gram market. The crisis is exacerbated by the widely criticized warehouse receipt system, acting as a stumbling block for farmers facing significant challenges and left with surplus produce

and no avenue for sales. "At present, the price of the crop has significantly dropped. Since they announced the warehouse receipt system, it's been a problem. I have financial difficulties to sustain myself and my family. The price is extremely low, around 700/- per kilogram instead of 1000/-," shared Mgui, encapsulating the dire financial straits farmers find themselves in.

Green gram, both a staple food and cash crop, is rich in protein and essential minerals such as phosphorus and calcium, holding promise for sustenance and economic viability.

However, the prevailing challenges have cast a shadow over its potential. Proper cultivation can yield between 400 to 900 kilograms per acre, contingent upon soil quality and weather conditions.

Rahael Masatu Machumu, an influential figure in the agricultural landscape, criticized the warehouse receipt system, citing uncertainties about the timing of fund disburse-

The plea for government intervention reverberates, with farmers seeking relief from the clutches of poverty intensified by the challenges inherent in agriculture. The prohibition of traders from purchasing greengram directly from farmers exacerbates the struggle.

Vincent Charles lamented the closure of all gates for selling crops, leaving farmers in a quandary. The call for transparency from the government takes center stage, with farmers urging authorities to communicate their intentions regarding crop procurement to avoid unnecessary hard-

The Secretary of the CCM in Shinyanga Region, Richard Masele, urged farmers to be patient, stating that President Samia's goal are to ensure farmers' benefit. He emphasized that the warehouse receipt system is not intended to harm farmers but to ensure they benefit, and the government is committed to addressing their concerns.

Farmers place the blame on Agricultural Marketing and Cooperatives (AMCOS), alleging that introduction of the warehouse receipt system has only worsened their plight.

Their grievances reached a crescendo when they visited the CCM offices in Shinyanga on February 29th, seeking a solution to the deadlock.

Former President Jakaya Kikwete appointed the late Kamala

The plea for the continuation of trading practices that were more favorable to farmers echoes through the corridors of the CCM offices.

Farmers are resolute in their demand for a minimum price of 2,500/-, emphasizing the profound impact on their families and children due to the lack of buyers. The fear that greengram has been sold, and the money has not reached them, intensifies the urgency. The Chairman of CCM in Shinyanga urges patience as the government grapples with finding a resolution.

Juma Shija sheds light on the financial challenges faced by cooperatives, suggesting that leaders should come forward to explain the steps needed to overcome this issue. The intricate web of challenges extends beyond the fields to the cooperative structure, adding another layer to the multifaceted agricultural

The situation mirrors a similar episode in 2021 when Zainab Telack, the former Shinyanga, Regional commissioner directed officials to educate greengram farmers about the warehouse receipt system.

The hope was to prevent premature sales and provide buyers with certainty about obtaining large quantities of produce. The first auction of greengram for the 2020/21 season saw 47,564 kilograms sold through the Tanzania Commodities Exchange (TCE).

Beyond the market woes, greengram stands as a nutritional powerhouse. Originating from India and introduced to Tanzania by Arab traders in the 1880s, greengram boasts drought tolerance and quick maturation. Rich in protein, phosphorus, and calcium, green gram promotes heart health, aids digestion, and contributes to bone strength.

Ongoing research initiatives at the Tanzania Agricultural Research Institute (TARI) focus on developing greengram varieties with high iron content. Dr. Beatrice Mwaipopo, a Greengram Researcher at TARI Ilonga, underscores the demand for greengram domestically and internationally. The research aims to address iron deficiency in pregnant women and children under five.

Dr Geofrey Mkamilo, the Director-General of TARI, emphasizes the importance of legumes like greengram for all age groups. With a budget exceeding 15 billion Tanzanian Shillings allocated for seed development, TARI's strategic focus extends to crops such as sunflower, maize, and greengram.

As the Food and Agriculture Organization (FAO)

underscores the significance of legumes as an alternative protein source, green gram's potential extends beyond the plight of Shinyanga farmers. Dr. Kusirye Ukio, the Chief Medical Officer in the Morogoro region, emphasizes the role of a balanced diet, including legumes, in addressing nutritional deficiencies.

The challenges faced by greengram farmers in Shinyanga Region transcend the immediate market woes. The intricate interplay of government policies, cooperative finances, and market dynamics paints a complex picture.

As farmers await resolution, the call for systemic change and sustainable agricultural practices echoes-a plea not just for Shinyanga but for the broader agricultural landscape in Tanzania.

The future of greengram, a crop deeply rooted in history, hinges on the collective efforts to circumnavigate these challenges and pave the way for a resilient and thriving agricultural sector.

Air quality sensors boost Nairobi's fight against air pollution

DEBORAH Adhiambo (43) has been battling mild asthma since 2022, a condition she describes as "both a health and economic burden." The mother of three lives within Dandora Estate, nine miles east of Kenya's capital, Nairobi. Dandora is home to Kenya's largest open landfill, which receives more than 2,000 metric tonnes of waste daily.

For five years, Adhiambo operated a makeshift restaurant near the dumpsite, where her main clients were waste pickers working within its environs.

"Working near the dumpsite exposed me to the heavy smoke that billows from the dumpsite. I started developing chest pains gradually and would take painkillers to subdue the pain. It was later that I was diagnosed with asthma," said Adhia-

Adhiambo's doctors told her that prolonged and constant exposure to toxic fumes was the root cause of her asthma. She was forced to close her business since she could not venture out of her house early in the morning, late in the evenings or during cold seasons.

"The closure of my business due to sickness crippled me economically as it was my only source of income. Getting medication and feeding my family has been hard because now I have to rely on my husband, who also works at the dumpsite," she says.

Nairobi's Air Quality

More than 70 percent of Nairobi's 5.3 million residents live in informal settlements like Dandora, which analysts say have the worst air quality, with vulnerable populations,

particularly women and children, bearing the brunt of polluted air. Vehicles, open burning of waste, and industrial emissions are cited as the major sources of air pollutants in Nairobi. Motor vehicles contribute an estimated 40 percent of Nairobi's particulate matter (PM2.5) air pollution concentrations, with illegal dumping and open waste burning contributing 25 percent.

And as both the population and economic output of Kenya's capital keep expanding, the demand for energy from fossil fuels is also on the rise. The rapid expansion of Nairobi has taken an environmental toll on the city, which is evident in the worsening air pollution levels. Air pollution in Kenya's capital is 4.2 times higher than the World Health Organization's (WHO) recommended average annual concentration levels.

According to the World Health Organization, Nairobi's air pollution is 2.4 times higher than recommended levels, with 19,000 poor air quality deaths being reported in Kenya an-

Tech and Data

To enhance her efforts in combating air pollution, the City of Nairobi has been incorporating the use of technology. The city management has been installing low-cost air quality monitors and sensors to gather and share data on the levels of air pollution trends across the city. The data collected is then analyzed and guided in the formulation of policies and legal frameworks to combat air pollution, even as East Africa's economic giant works towards realizing her ambitious target of becoming a net-zero green city by 2030.

Dubbed AirQo monitors, the lowcost air quality sensors developed

by a team of young engineering and computer science students at Uganda's Makerere University are in use in eight countries, including Kenya.

Engineer Bainomugisha, an Associate Professor of Computer Science at Makerere University and lead developer of the AirOo monitoring system, says Sub-Saharan Africa lacks usable air quality data that can help in the formulation of proper and effective policies to combat air pollution. AirQo monitors collect information about air pollution levels, types of air pollutants, and air quality

Bainomugisha explains that the air quality monitors main aim is to "close the existing gap in air quality monitoring." AirQo air quality monitors collect air samples, which are then analyzed through a light scattering technology that quantifies the particulate matter concentration.

The information is then relayed to a cloud-based network that determines the pollution levels in a specific area. The devices measure the air particulate matter PM2.5 and PM10, which is a mixture of solid particles in the air. They also capture ambient meteorological conditions such as humidity and atmospheric pressure

"The air quality monitors run on a 2G GSM-enabled network configuration for loT sim cards and are optimized to work in areas with unstable internet and power connectivity," says Gideon Lubisia, AirQo's international operations embedded systems and network support engineer.

AirQo has also developed a mobile app that allows people to receive periodic and real-time updates on the air quality in their city. The monitors are mounted at strategic points within the city's Central Business District, industrial areas, markets, along major city highways and in select residential areas. while others are mounted on motorbikes that move from one location to another, collecting data.

Data and Policy Formulation

With the monitors in place, Nairobi City has been able to develop two air quality collocation installations and infrastructure reference grade monitors, according to Nairobi City County Deputy Director in Charge of Air Quality and Climate Maurice

"The one-stop center collocation enables our research teams to compare air quality data collected from various points within the city, which is key in developing appropriate action," Kivai explained.

"The availability of periodic data collected by the monitors enables the city to establish the extent of pollution in particular areas, identify the causes, and develop necessary actions," he said.

Through air quality data collected through the monitors and establishing the extent of air pollution in the city, Nairobi has been able to develop a city Air Quality Action Plan as well as enact the Nairobi City County Air Quality Act which have become critical policy and legal assets in tackling the problem of air pollution.

AirQo monitors are now in use within select cities in eight African countries, including Uganda, Kenya, Nigeria, Cameroon, Burundi, Ghana, Mozambique, and Senegal.

Global Push for Clean Air

During the Climate and Clean Air Conference(CCAC) 2024 in Nairobi between February 21 and 23, 2024, ahead of the sixth session of the UN Environment Assembly (UNEA-6), member states and partners launched a Clean Air Flagship effort to provide, among other things, dataled policy action towards combating air pollution

Inger Andersen, UNEP's Executive Director, said, "We need to push harder on superpollutants. Just as you need a superhero to defeat a supervillain, we need super solutions to face down super pollutants. And we need you to mastermind these solutions."

Speaking on the sidelines of the CCAC, Kenyan environmentalist Elizabeth Wathuti observed that "the very essence of life starts with a breath, a gasp of air that signifies the beginning of our journey on this Earth. Yet, for too many across our globe, this fundamental act of breathing has become a hazard, a risk, and a gamble against the odds of pollution and climate-induced adversities." According to Wathuti, the commitment to clean air and a stable climate is not just an environmental cause but a fight for the very right to

The World Health Organization estimates that 99 percent of the world's population lives in places with poor air quality, leading to nearly seven million premature deaths per year, primarily in low- and middle-income countries.

According to UNEP, in Africa alone, ambient air pollution caused an estimated 400,000 premature deaths in 2019, while indoor air pollution caused more than one million premature deaths in the same year. Some of the leading air pollutionrelated ailments that contribute to these premature deaths include pneumonia, heart disease, stroke, diabetes, chronic lung disease, and lung cancer. Ambient air pollution and household air pollution are associated with 6.7 million premature deaths annually.





US, Europe inflation rates stand elevated

LONDON

Inflation remains elevated in the US and euro-zone, supporting assertions from central bankers in both regions that it's too soon to start cutting interest rates.

The Federal Reserve's preferred gauge of underlying inflation rose in January by the most in a year, while price pressures in the euro-area eased less than anticipated in February.

Elsewhere, China's factory activity shrank for the fifth straight month in February, suggesting weak demand remains an obstacle for the world's second-largest economy.

In US, the so-called core personal consumption expenditures price index, which strips out the volatile food and energy components, increased 0.4 percent from December, the most in a year. Inflation-adjusted consumer spending dropped for the first time in five months after a robust holiday shopping season.

Consumer sentiment faltered in late February as current views of the economy and the outlook deteriorated, marking a reversal from earlier in the month that showed a pickup in optimism. The intramonth drop was the biggest since March 2020.

Euro-zone inflation eased in February by less than anticipated, supporting European Central Bank officials who don't want to rush into lowering interest rates. While policymakers are optimistic that inflation is headed toward their 2 percent goal, they remain concerned that elevated increases in wages and labor costs risk stoking price pressures for longer.

Russia plans to reduce daily diesel exports from its key western ports by 11 percent in March, after its refineries lowered crude-processing amid Ukrainian drone attacks. Russia no longer sends diesel to Europe due to Western energy sanctions.

However, the drop in flows from one of the top global diesel exporters could create further pressure for the European market, which has been shaken by the disruption of shipments in the Red Sea and maintenance at regional refineries.

Asi

The official manufacturing purchasing managers index for last month edged lower to 49.1, the National Bureau of Statistics said. A gauge of nonmanufacturing activity rose, adding to signs of an uneven recovery in the

world's No. 2 economy.

India is chipping away at China's dominance in electronics exports in some key markets as manufacturers diversify supply chains away from the world's factory to other parts of Asia, a new study shows. The impact is most pronounced in the UK and US, where geopolitical tensions with China have increased in recent years.

South Korea set a fresh record for the world's lowest fertility rate as the impact of the nation's aging demographics looms large for its medical system, social welfare provision and economic growth. The number of births also slid 7.7 percent to 230,000, setting a new low for comparable data in a nation of about 50 million people.

North Korea has shipped containers that could hold millions of artillery shells to Russia, a top South Korean official said, allowing President Vladimir Putin to maintain his assault on Ukraine as Kyiv's stocks of ammunition dwindle. Russia in return is providing North Korea with food, raw materials and parts used in weapons manufacturing, the official said, which is helping Kim Jong Un stabilize prices for necessities.

Emerging Markets

Indonesia plans to propose a wider budget deficit for next year to fund new policies by the incoming president, which may include Prabowo Subianto's free lunch program. The program has raised concerns over Indonesia's fiscal health.

World

Breaking into the top 1 percent of wealth in the US is getting harder. It now takes at least \$5.8 million to join the richest echelon in the world's largest economy, almost 15 percent more than about 12 months ago, according to research from Knight Frank. Monaco retains the top spot for the highest threshold worldwide at \$12.8 million, while in Luxembourg and Switzerland one needs more than \$8 million to

Israel's central bank opted against another rate cut out of concern that inflation might reaccelerate as the war against Hamas continues. Nigeria's central bank, in its first policy meeting since July, announced a super-sized hike to tackle runaway inflation and stem the collapse in its currency. Hungary cut at a faster pace after inflation slowed more than expected, while New Zealand and the Dominican Republic left rates unchanged.

DSE indices end the week low as cement stock prices decline

he Dar es Salaam Stock Exchange (DSE) indices closed last week in red, following the decline of cement companies' stocks prices.

The market report shows the Tanzania Share Index, which measures the prices movements of local companies, closed at 4,399.19 points, a decrease of 2.32 points compared to Thursday's close, while the all share index (DSEI) slightly went down by 0.74 points, after closing at 1,770.20 points.

The Industrial and Allied Index (IA), which measures the performances of manufacturing sector, including cement stocks, also declines by 5.41 points after closing the week at 5,195.03 points.

The report shows the Tanzania Portland Cement Company (TPCC) share price slightly dropped by 0.46 points after closing the week at 4,340/- compared to 4,340/- recorded a day before, pushing down its market capitalization to 780.87bln, from 784.46bln/-.

The share price of Tanga Cement Company Limited, which closed last year as top mover, closed 1.64 percent down at 2,400/- on Friday last week, from 2,440/- recorded on Thursday close, which also lowered its market capitalization to 152.81bln/- from 155.36bln/-.

Generally, the market reported the transaction of 5.1 million shares valued 2.2bln/- traded in 113 deals.

Top mover during the day was CRDB Bank Plc counter, which recorded the transaction of 3,837,036 shares valued 1.9bln/-, of which 3,083,339 shares were moved through block pre-arranged market board, at a price ranging from 52/- to 540/- per share in 65 deals.

TCCIA Investment Company Limited (TICL) emerged as the

second mover after its counter recorded the transaction of 1,262,335 shares valued 239.9bln/-, of which 1,261,259 were moved through block pre-arranged market board, traded at a price ranging from 195/- to 200/- per share

Tanzania Portland Cement Company (TPCC) counter recorded the movements of 25,306 shares valued 109.8mln/- transacted at a price of 4,340/- per share in six deals through normal trade.

in 13 deals.

Other active counters during the last day of the week were DCB, DSE, NICO, Swissport, Tanga Cement (TCCL) and Vodacom Tanzania (VODA).

Local investors dominated the activities, after accounting for 99.47 percent of total value of shares sold and 100 percent of total value of shares bought.

Foreign investors participated the market by selling shares valued 12.02mln/-, which was only 0.53 percent of total value of shares sold.

On debt market, the value of government bonds traded during the day included the face value of 20.52bln/- and transaction value of 24.41bln/-, while the corporate bond recorded the face value of 576.50mln/- and transaction value of 516.64mln/-.

TFS, Land Commission sign MoU for villages land management

THE Tanzania Forest Services Agency (TFS) and the National Land Use Planning Commission (NLUPC) have officially signed a Memorandum of Understanding (MoU) for the implementation of Integrated Landscape Management in the Dry Miombo Woodlands of Tanzania in 14 villages.

Through \$6,875,882 funding from the Global Environment Facility (GEF), the project will be executed in Kaliua landscape, known as the Tabora Zone, and the Mlele Landscape of Katavi.

The MoU was signed last weekend at the TFS's Headquarters in Dodoma between the Director General (DG) of the National Land Use Planning Commission (NLUPC) Professor Wakuru Magigi and the TFS Conservation Commissioner (CC) Professor Dos Santos Silayo.

The partnership is meant to ensure the initiative is executed to fetch the intended end-results, addressing existing problems entailing land degradation and loss of biodiversity within the country's southwest dry Miombo Woodlands.

In his remarks during a brief signing ceremony, Prof Magigi said the project will play a meaningful role in helping halt and reverse negative trends of land degradation and biodiversity loss in degraded areas of the Miombo woodlands in the south-west of Tanzania by applying an integrated landscape management approach.

He also said the initiative will serve as a crucial podium to deal

with land disputes, as well as human-wildlife conflicts.

"The forest and beekeeping sub-sectors in Tanzania are seriously haunted by several challenges, especially encroachments of unfriendly human activities into the forests reserved areas, and this is greatly fueled by the fact that most of the villages at the vicinities of reserved forests are yet to be surveyed," Prof Magigi observed.

And he noted that through the well-designed 'Join Resource Management Plan Approach,' the Commission stands ready to work in close sync with TFS in the implementation of the project to attain proper land planning and use, together with professional preservation and fruitful management and harvesting of forest resources.

TFS Conservation Commissioner (CC) Professor Dos Santosi Silayo extended his gratitude to GEF for bankrolling the project, as well as the Food and Agriculture Organization of the United Nations (FAO), and the Vice President's Office (Environment).

Prof Silayo said TFS has been encountering diverse setbacks in its daily role to foster the performance of the forest sector, which includes the increasing wave of destruction of forest resources across the country, caused by ownership challenges and the lack of collaborative land use plans for villages bordering forest reserves.

"These challenges led to the presence of invasions for various human activities such as housing, cultivation of short-term and permanent crops in forest reserved areas," he unveiled.

To help overcome the challenges, he said, TFS embarked on a special mission to seek financial resources, saying in 2018 the Institution started the process for the implementation of the Integrated Landscape Management in Dry Miombo Woodlands of Tanzania, being funds from GEF through

"This project is based on a program implemented in at least 11 countries, including Angola, Botswana, Malawi, Mozambique, Namibia, Zimbabwe, Tanzania, Kenya, Burkina Faso, Mongolia and Kazakhstan," he informed.

He added that, as per the program, every country will be measured by the expectations they have set for themselves, where in Tanzania the set measures incorporate the good conservation of the Miombo Forests and finally bring productivity to the entire chain of Bee Products and Community Life (Sustainable Honey Production from Miombo Woodland).

Prof Silayo said the process for the project started in 2018 where the idea was developed through the Office of the Vice President, the coordinators of the project.

"During 2021-2022, the project was signed by GEF and FAO whereby in January 12, 2023, Tanzania also signed, and in August 2023, all financial processes were completed," he detailed.

Prof Silayo noted that the meetings of experts (STC) and decisions (TC) were held in September and November 2023 in readiness for the implementation of the project.

Marula acquires 60pc stake in Kenyan manganese mine

Nairob

Battery metals miner Marula Mining has signed a binding term sheet with Kenyan manganese mine operator Gems and Industrial Minerals (GIM) to acquire a 60 percent commercial interest in the Larisoro mine, in Samburu Country, Kenya.

The shallow openpit Larisoro mine started operating in 2012, with manganese ore grades having ranged from 18.82 percent to 55 percent between 2018 and 2024, with 33.41 percent being the average.

The mine currently crushes and screens ore to produce a 37 percent manganese saleable product that is mostly sold to Asian markets.

The term sheet provides that, subject to GIM entering into a technical support agreement and commercial agreement, Marula will invest \$1.5-million in buying new mining and processing equipment for the

Marula expects the equipment to help the mine increase its production to between 5 000 t and 10 000 t of saleable high-grade manganese

ore over the next three to six months.

The company expects the additional agreements to be signed in mid-March.

On signing the term sheet, a

consideration of £300 000 became payable to GIM, which Marula will provide through the issue of 2.4-million new ordinary shares to the company

On signing of the technical support and commercial agreements, Marula will pay GIM £200 000 in cash or shares, as well as a further £300 000 on completion of an initial exploration programme.

A final payment of £750 000 will become payable once the mine achieves sales of 50 000 t of manganese ore

Moreover, the term sheet provides a 12-month option for Marula to increase its commercial interest in the Larisoro mine to 70 percent through the payment of £1.25-million in cash

or shares, at Marula's election.

Marula has already completed a detailed due diligence work programme, which, together with independent assay reports, have confirmed the high-grade nature of the manganese mining operation.

The company has also advanced discussions with a potential offtaker in Europe for 100 percent of the saleable product produced by the mine.

Marula expects its payback of the initial investment in GIM and the mine to happen within the next 12 to

Others were Tanzania Wildlife Authority (TAWA) and Tanzania National Park Authority (TANA-PA) staff from Mkomazi.

The beneficiaries were trained on SMART approach, the evidenced-based data collection.

"Previously, a ranger had to be equipped with a GPS, camera, and notebook but currently all these are embedded in SMART", said Emanuel Kivuyo, the WWF Lion project manager.

According to WWF's Wildlife species expert, Prof. Noah Sitati, the Spatial Monitoring and Reporting Tool (SMART) is a combination of software, training materials and patrolling, that helps conservation managers monitor animals, identify threats such as poaching, diseases as well as make patrols more effective.

He said, for wildlife to thrive, water was very important,



hence, the idea of WWF embarking on the project of constructing big charcoal dams to provide water sources to animals in their natural habits, reduce the risk of wildlife entering invading surrounding communities to destroy water infrastructure.

"These charcoal dams have been constructed in areas which have a history of scarce rainfall and droughts, features which severely impact wildlife populations; the areas are situated in Same, Mwanga and Rombo ", he noted.

Commenting on the SMART training workshop, Prof. Sitati, said it aimed to provide education to wildlife managers on how to collect data using modern technology in order to obtain accurate data that will enable the relevant authorities to deal with challenges related to wildlife.

On his part, the Same district

elephants and rhino's experts, Kolady Kayanda, said that the knowledge gained will enable wildlife managers to obtain and store natural resources information well.

"In the past, they used tools such as notebooks which sometimes led to the loss of important information related to natural resources needed to face challenges related to various issues such as the invasion of wild animals", he said.

He added, "This knowledge will empower wildlife management experts in villages and wards to use modern technology to collect information and submit them to the relevant authorities in time; this will give light to the relevant authorities to deal with those challenges quickly".

The Same District Wildlife Officer, Thomas Katunzi thanked the WWF organization for facilitating the training.

Katunzi said the training will bring about a big revolution in the preservation of information related to natural resources and residents living in areas that have been affected by the invasion of wildlife, especially elephants.

"This training is very important for enhancing data management for monitoring conservation impacts; it will also give us (officers) residing from different districts, the opportunity to communicate and cooperate practically in all activities related to natural resources', he said.

"Regarding the training of modern technology, the training will help us to get the knowledge of storing data for a long time due to the fact that in the past we used to store documents such as notebooks that could be misplaced or damaged easily", he said.



AfDB calls on **African states to boost efficiency** in resource use

African Development Bank (AfDB) has called for African countries to take urgent, concrete measures to adopt circular economy practices and boost efficient resource use for sustainable production and consumption.

"Africa is brimming with potential for circularity and industrialization with a market valued at \$250 billion. Unleashing this potential requires creating the right environment and policies for the private sector to lead the continent's industrial revolution", emphasized Dr. Anthony Nyong, Director of the AfDB Climate Change and Green Growth Department, ahead of the Bank's participation at UNEA 6.

As global leaders gathered in Nairobi to address the connected challenges of climate change, biodiversity loss, and pollution, the African Development Bank is underscoring the imsource use through the circular economy to address these pressing issues while also supporting Africa's sustainable industrialisation.

The 2024 Circularity Gap Report released in January 2024 by the Circle Economy Foundation and Deloitte, highlights several data points that heighten the urgency of action.

For instance, in 2023 alone, 500 gigatons of materials including freshwater, land, and minerals were consumed, representing 28 percent of all materials used since 1900.

As 83 percent of Afri-

can countries rely heavily on their own natural resources, this rapid depletion poses a major threat to the continent.

Collaboration is key for the African continent to leverage the benefits of circularity and should therefore be prioritized at every level: "The Paris Agreement emphasizes the need for global cooperation, with wealthier countries providing support to lower-income countries in the form of financial resources, technology transfer, and capacity-building. This is essential to aid their efforts in mitigating and (crucially) adapting to climate change," as stated by the Circularity Gap

Davinah Milenge, Principal Program coordinator represented the Bank Group at a side event hosted by the Global Alliance on Circular Economy and Resource Efficiency (GACERE) on February 27.

During the event, on the pivotal role that financial institutions can play in accelerating the economies, Milenge reiterated the Bank's commitment to drive the mainstreaming of circular economy across Africa in line with the African Union Commission's Continental Circular Economy Action Plan 2024-2034.

The Bank Group has been actively working to advance circularity across Africa. In 2022, it established the African Circular Economy Facility (ACEF), a multi-donor grants trust fund that is mainstreaming the circular economy as an inclusive green growth strategy in its regional member countries.

Demand surges as bitcoin hits above \$60K

NEW YORK

Bitcoin smashed past \$60,000 last week for the first time since November 2021. Demand for digital currency surged so much that it even led the crypto-trading platform Coinbase to crash on Wednesday.

After the brutal crypto winter that began in 2022, bitcoin could soon shatter its previous records as investors pour money into newly created bitcoin spot ETFs or exchange-traded funds.

The price of ether, the native token of the ethereum network, also soared past \$3,300 – levels not seen since April 2022 - as investors speculated that ethereum ETFs will eventually win approval from the US Securities and Exchange Commission (SEC), as well.

As billions of dollars pour into bit-

coin ETFs daily, is it time to get in on the party? Proceed with caution.

Less than a year ago, 75 percent of Americans who'd heard of cryptocurrency said they weren't confident in its safety or reliability, according to a Pew Research Center survey.

But the price of the world's largest cryptocurrency began climbing again in late 2023 after a federal appeals court ruled that the SEC wrongfully rejected an application from Grayscale Investments to convert its Grayscale Bitcoin Trust into a spot bitcoin ETF. The SEC said in October that it wouldn't appeal the court ruling.

And in January, it gave the OK to nearly a dozen new exchange-traded funds called spot bitcoin ETFs. Spot ETFs own the underlying asset – like gold, silver, or now bitcoin - and closely track its price, minus trading



"There have not been any ETFs like this before," said Ric Edelman, founder of the Digital Assets Council of Financial Professionals. "There are ETFs that invest in stocks of companies that do business in the crypto industry, such as exchanges and miners, and there are ETFs that

trade futures in bitcoin, which is like buying equity options instead of stocks, but until now there have not been any ETFs that directly invest in and own bitcoin."

The SEC's decision allows investors to get direct exposure to bitcoin without going through a crypto exchange or dealing with the headache

of storage or security issues. Instead, investors can easily gain bitcoin exposure by owning shares in their brokerage accounts, including individual retirement accounts (IRAs).

"The new spot bitcoin ETFs are widely viewed as the safest from a custody perspective because the ETFs are regulated by the SEC, and they handle the safeguarding of your bitcoin for you," Edelman said.

With all the hype surrounding bitcoin, it's understandable if you're tempted to buy in. But there's a lot you need to know first before you try to profit off the skyrocketing price.

It's still a speculative asset

Bitcoin and other cryptocurrencies are speculative investments, which are assets that people put money into, hoping the price will rise rapidly. Sometimes, speculative

assets are called nonproductive assets because they don't generate any income, like interest, dividends, or earnings. Investors who buy speculative assets are typically seeking to profit off short-term price fluctua-

"Normally, the way you think about a financial asset is you're providing capital to the company," said Michael Finke, a professor of wealth management who holds the Frank M. Engle Distinguished Chair in Economic Security at The American College of Financial Services. "The company uses that capital to make something, and the people buy it. That creates profit. You can value the company based on the profitability you expect in the future."

"With bitcoin, it's not producing anything, so the valuation is entirely speculative," he said.

China's economic activity rebounds in 2023, IMF says

BEIJING

China's economic activity rebounded in 2023 following the post-COVID reopening with real GDP estimated to have grown broadly in line with the authorities' growth target of around 5 percent, the executive board of the International Monetary Fund (IMF) has said.

The IMF made the statement in a recent press release after concluding its annual Article IV review of the Chinese economy.

According to the statement published on the IMF website, the recovery was driven by domestic demand, particularly private consumption, and assisted by supportive macroeconomic policies, including the further relaxation of monetary policy, tax relief for firms and households, and fiscal spending on disaster relief.

The statement said that while inflation fell in 2023, largely due to decreased energy and food prices, it is expected to increase gradually to 1.3 percent in 2024 as the output gap narrows and the base effects of commodity prices recede.

Decisive policy action, including accelerated restructuring in the property sector, could boost confidence and lead to a better-than-expected rebound in private investment, the statement said.

An IMF team visited China from Oct. 26 to Nov. 7 to undertake the 2023 Article IV consultation.

The team held constructive discussions with senior officials from the government and the People's Bank of China, as well as private sector representatives and academics, to exchange views on China's economic prospects and risks, reform progress and challenges, and policy responses.

Trump wins Michigan, Missouri, Idaho caucuses

GRAND RAPIDS, Michigan

DONALD Trump on Saturday easily won the Republican caucuses in Michigan, where the party has been riven by infighting that some Republicans fear could hurt his campaign in the key battleground state as he gears up for the general election in November.

The former US president also won the Missouri and Idaho Republican caucuses on Saturday, according to Edison Research.

In all three states Trump trounced Nikki Haley, his last remaining rival for the Republican presidential nomination, moving him closer to becoming his party's White House standard-bearer and a likely general election rematch with President Joe Biden, a Democrat.

In Michigan, Trump beat Haley in all 13 districts taking part in the nominating caucuses, according to the state Republican Party.

Overall, Trump won with nearly 98 percent support: 1,575 votes to just 36 for Haley.

Pete Hoekstra, the Michigan Republican Party's chair, called it an "overwhelming, dominating victory."

More than 1,600 party insiders participated in the presidential caucus in the western Michigan city of Grand Rapids, where they were choosing delegates for Trump or former UN Ambassador Haley for the party's national nominating convention in July.

Haley is fast running out of time to alter the course of the Republican nominating race. Next up is Super Tuesday on March 5, the biggest day in the primaries, when 15 states and one territory will vote.

With victories in Iowa, New Hampshire, Nevada, the US Virgin Islands, South Carolina, and now Michigan, Missouri and Idaho under his belt, Trump is far and away the frontrunner in the race, with Haley hanging on thanks to support from donors keen for an alternative to the former president.

For this election cycle, Michigan Republicans devised a hybrid nominating system, split between a primary and a caucus. Trump won the primary convincingly on Tuesday, securing 12 of 16 delegates up for grabs. He took all of Michigan's remaining 39 delegates at stake on Saturday.

At one of the 13 caucus meetings, the participants - knowing Trump would win easily - decided to save time by simply asking anyone who backed Haley to stand up. In a room of 185 voting delegates, 25-year-old Carter Houtman was the only person who rose to his

"It was a little lonely," Houtman told Reuters in an interview afterward.

Houtman said he would likely vote for Trump in November's general election if he is the nominee but felt it was

important to stand up for his beliefs on Saturday.

"I didn't like the way that Trump handled himself after the last election," Houtman said.

Dennis Milosch, 87, a Trump supporter, said the former president's dominating win on Saturday underscored how the party has been transformed from one aligned with big business to one focused on the working class.

"Wherever he goes, whatever he does, he pays attention to, responds to, the average person," Milosch

Rift in Michigan party

The contest in Michigan on Saturday had held the potential for confusion. Internal turmoil has been percolating in the party for months, pitting backers of Michigan's former Republican Party chair, Kristina Karamo, against the faction of party members who voted to oust her on Jan 6, and installed Hoekstra as chair.

Hoekstra, whom Trump backed as chair, was overseeing the convention in Grand Rapids. Karamo had been planning to chair a dueling gates respectively. Agencies

convention in Detroit on Saturday, but that was canceled after a Michigan court this week affirmed her ouster and an appeals court denied her request to stay the ruling.

Pro-Karamo party chairs for at least two districts held caucus meetings in separate locations from Grand Rapids in protest. However, the results from those are unlikely to be accepted by the Republican National Committee, which last month formally recognized Hoekstra as state party chair.

Hoekstra was the US ambassador to the Netherlands during Trump's presidency. Speaking to Reuters on the sidelines of the caucus meetings, he said he was confident the Michigan Republican Party would unite around the objectives of winning the White House and a US Senate seat up for grabs and retaking the state House of Representatives.

"There is not a philosophical divide or an issue divide," Hoekstra said. "This is about getting the party ready to win in November. ... The focus is on beating Joe Biden."

Trump's victories in Missouri and Idaho netted him 54 and 32 dele-

Indians need to take more interest in foreign policy, says EAM Jaishankar

NEW DELHI

EXTERNAL Affairs Minister S Jaishankar, while commending India's foreign policy, highlighted the crucial need for individuals to be well-informed about global affairs.

He emphasized that it is essential for the average person to actively engage with foreign policy matters.

"Certainly, all Indians need to take more interest in foreign policy. it is very common all over the world, there is a belief that foreign policy is something complicated, esoteric, that should be left to certain people to deal with... which is not entirely without some justification," Jaishankar (pictured) said at an event in Delhi on Saturday.

He said, "...But, to me, a number of events happened that showed why it's important for the average person to get involved, pay more attention to foreign policy...and some of those events, if you look, were the Covid."

The EAM said that Covid showed that even if a person had no interest in the world, the world had decided to not "leave you alone."

"Covid showed that if you were a person in some remote part of India, with absolutely no interest in the world. The world had decided to not leave you alone, the world actually entered your doorstep, so the idea that there is a world, and there is a home...it is necessary for us to put that behind us," the EAM said.

"The Indians who go out should be aware that something can happen in the world..." Jaishankar emphasised adding that "even people who may not think they are professionally connected to the foreign policy should take an interest in foreign policy."

Coming out in wholesome praise of Prime Minister Modi's leadership and his outreach towards India's global partners in times of distress, External Affairs Minister S Jaishankar said New Delhi demonstrated to the world that it could not only look after itself but could also 'save the world' in times of need.

Speaking at an event at Hubli in Congress-ruled Karnataka on Wednesday, Jaishankar said at a time when the world was worried about India's response to the COVID-19 pandemic, the country stood up as a provider for the globe and shipped vaccines and other life-saving drugs to

Military leaders meet in DRC for campaign against M23 rebels

KINSHASA

STABILITY hangs in the balance in the eastern Democratic Republic of the Congo (DRC), where military leaders from five regional countries have been meeting for days to devise a coordinated military strategy to end hostilities that risk escalating into a regional conflict.

For days, military leaders from the DRC, Tanzania, Malawi, South Africa and Burundi have been meeting in Goma, the capital of North Kivu province in the DRC, to assess and strengthen joint operations against the violent hostilities, particularly around the strategic town of Sake.

This town is considered the last barrier to Goma, and it is here that the Congolese army, along with partners including the military elements of the Southern African Development Community (SADC), have positioned heavy artillery to halt the advance of the March 23 Movement (M23) rebels. The rebel group, which resurfaced in late 2021, has triggered conflicts and humanitarian crises and seized major strongholds on Congolese soil, including several locations in the mountains overlooking Sake.

This meeting is seen by DRC military authorities as a pivotal moment in regional efforts to stabilize the volatile region, which, according to the Special Representative of the UN Secretary-General in the DRC, Bintou Keita, "risks extending the conflict on a regional scale."

"The presence of these military figures underscores the regional commitment to peace and security. It also reflects the collaborative spirit of the SADC forces," an official from the Congolese army in Goma told Xinhua on Friday.

According to the Angolan government, whose President Joao Lourenco currently holds the rotating presidency of SADC, Tanzania, Malawi and South Af-

rica have already deployed their military elements in eastern DRC as part of a joint SADC operation, which is mandated to conduct offensive operations against the rebels, particularly the M23.

The primary objective of this meeting was to address the urgent challenges posed by the M23 rebels and their supporters, an official present at the closeddoor meeting told Xinhua, emphasizing the collective determination of the SADC and its partners to support the Congolese army in ending the rebellion's activities in the region.

After several hours of closed-door discussions on Friday, Congolese military sources stressed that the meeting highlighted the urgent need for a coordinated military strategy.

Peace hanging in balance

While the SADC is mobilizing for operations on the ground, the situation in the Sake area remains highly

volatile due to the daily bombardment by M23 rebels from the mountains overlooking the

On Thursday, four people, including a Tanzanian soldier deployed as part of the SADC mission, were seriously injured in Sake by bombs fired by the rebels targeting the military base and surrounding villages. Local sources reported that two armored vehicles belonging to the Tanzanian contingent were targeted by bombs during a reconnaissance mission.

On Friday, around 10 bombs were fired again by the rebels, resulting in injuries and the death of at least three civilians, shortly before the arrival of the five military leaders in Mubambiro, at the eastern entrance to Sake, for a field inspection.

According to General Sylvain Ekenge, spokesperson for the Congolese military, these bomb attacks did not deter the determination of the Congolese army and the military leaders of the contributing countries, who remained in the region. "The terrorists attempted to deter them by dropping bombs, but they did not weaken the determination of the defense force leaders, who arrived in Mubambiro and refined strategies to end the activities of these M23 terrorists," Ekenge

In a press release published in mid-February, the United Nations High Commissioner for Refugees (UNHCR) expressed concern about the fate of around 135,000 internally displaced persons who fled Sake toward the provincial capital Goma due to bombs falling on civilian shelters, including the Zaina camp in Sake and the Lushagala camp in Goma, where nearly 65,000 displaced persons have found refuge. **Agencies**

Putin has clear plan of country's development, 85% of Russians say

MOSCOW

OVER 80% of Russians polled who followed Russian President Vladimir Putin's annual State of the Nation Address to the Federal Assembly, think that the incumbent president has a clear plan of the country's



development for several years ahead and is capable of implementing it, according to a nationwide survey conducted by Russia's top pollster.

The poll was conducted by the Russian Public Opinion Research Center (VCIOM) among 1,600 adult Russians on March 1.

"Among those who followed the address, 85% said that Putin has a clear plan of action and a strategy for the country's development for several years ahead. Every tenth respondent (10%) thought that there are no strategy or plan," the agency said in a statement. The majority of those surveyed, 86%, think that the president can implement this plan fully or partially, and every second person was completely sure of it. The State of the Nation Address to the Federal Assembly took place on February 29 and lasted over two hours. Out of those who followed it, 86% said that the address made a positive impression with every second respondent expressing complete certainty.

Every second respondent who listened to the address liked all the ideas and proposals voiced by the Russian lead-

The Russians particularly approved of such subjects as support for young families (21%), infrastructure and new housing and roads (13%) and the "Family," "Long and Active Life" and "Human Resources" national projects, among others (12%). Generally, those polled had a positive attitude toward the address. Their emotions included "trust (36%), hope (35%), sense of security (33%), respect (32%) and pride (29%)," according to the survey results. **Agencies**

CHINA is projected to make about 100 space launch missions this year, which will set the country's new record, said a blue book released by the China Aerospace Science and Technology Corporation

(CASC) on Feb. 26. China plans to carry out a series of major space missions this year. The China Space Station has entered the normal operation stage and within 2024, there will be two cargo spacecraft missions, two manned spaceflight missions and two return missions

China is set to launch Queqiao-2, a relay satellite for communications between the far side of the moon and Earth, and the Chang'e-6 lunar probe, a mission to collect samples from the far side of

China to make around 100 space launches in 2024 the moon, the first of its kind in human history.

A detection satellite for ocean salinity is also on CASC's task list, which will empower China with highresolution and high-precision ocean salinity detection capabilities.

Newly developed Long March-6C and Long March-12 carrier rockets will execute their maiden flight missions.

Besides, China's first commercial spacecraft launch site is expected to have its first launch mission in 2024, and the country will accelerate the networking and construction of multiple satellite constellations.

In 2023, China carried out

67 space launch missions, with this number ranking second in the world, and put 221 spacecraft into space, already setting a record for China.

Among them, the Long March series of carrier rockets were launched 47 times with a 100 percent success rate. breaking through 500 launches cumulatively, and other commercial rockets were launched 20 times.

Looking back on the past year, China's space industry has implemented high-density launch missions in an orderly manner with a high success rate, and the number of spacecraft developed and launched has rapidly increased, with a

significant improvement in development capabilities.

In terms of technological innovation, China has made continuous breakthroughs in fields like carrier rockets, manned spaceflight, lunar and deep space exploration, communications, navigation, remote sensing satellites, and scientific and technological experiments.

China's capabilities in accessing, exploring, and utilizing space have grown stronger, and the country has achieved many scientific and technological accomplishments.

Based on space infrastructure like satellite communications, satellite remote sensing,

and satellite navigation and positioning, China's space industry has developed a relatively complete application system. This has offered solid support for various national strategies and the country's "dual carbon" goals, and widely served different sectors of the national economy.

In terms of international cooperation, China's space industry has carried out various forms of international exchanges such as seminars, discussions, data sharing, technical cooperation, application services, and space culture education, promoting the highquality development of the Belt and Road Initiative, and contributing to the building of a community with a shared

future for mankind. People's Daily

What to expect at 'two sessions' in pivotal year

BEIJING

THE upcoming annual sessions of China's top legislature and political advisory body will offer the world a window to observe the country's development and understand its policy direction for the following year.

The second session of the 14th National People's Congress and the second session of the 14th National Committee of the Chinese People's Political Consultative Conference will open on March 5 and 4, respectively.

The year 2024 marks the 75th anniversary of the founding of the People's Republic of China and is a crucial year for the realization of the goals and tasks of the 14th Five-Year Plan (2021-2025). In such a significant year, what issues are especially worthy of attention at the "two sessions"? Here are some advices.

Economic goals

At the "two sessions" each year, the annual economic development goals of the world's second-largest economy are among the most anticipated announcements.

The development goals for 2024 are expected to be unveiled in the government work report, which will be deliberated at the NPC's annual session. The report usually includes the country's targets on gross domestic product growth, inflation, the ratio of deficit to GDP, employment, and foreign trade and investment, among others.

Last year, the Chinese economy rebounded for the better, high-quality development was solidly advanced, important progress had been made in the construction of a modern industrial system, and the foundation for safe development was consolidated.

China's provincial-level regions recently unveiled their growth targets for 2024 in government work reports delivered to local people's congresses. Their 2024 GDP growth targets vary

from 4.5 percent to 8 percent, with the majority expecting to expand their economy by over 5 percent.

"The economic goals should be both in line with our development potential and within an appropriate range, and more importantly, it should give priority to the quality of growth," said Han Baojiang, professor of the Party School of the Communist Party of China Central Committee (National Academy of Governance) and a national political advisor.

New growth drivers

"New productive forces", an emerging catchphrase in China's policymaking, is expected to be a hot topic garnering much attention.

The concept refers to a new form of productive forces derived from continuous sci-tech breakthroughs and innovation that drive strategic emerging industries and future industries in a more intelligent information era.

The Central Economic Work Conference, held late last year to chart economic development in 2024, said China would "promote industrial innovation through technological innovation... to foster new industries, new models and growth drivers, and develop new productive forces."

"New productive forces are crucial to promote self-reliance in high-level science and technology," said Yuan Yuyu, NPC deputy and chairman of Medprin Regenerative Medical Technologies Co., Ltd, adding that his focus at the "two sessions" will be how to strengthen sci-tech innovation, especially original and disruptive innova-

High-level opening up

China's attitude and plans concerning its opening up are among the most closely watched in the world.

At the Central Economic Work Conference, China pledged to expand high-level opening up and reinforce

the stable performance of foreign trade and foreign investment. A series of recent policy measures sent a clear signal that China is firmly committed to expanding opening up. For example, the country announced that it will remove all restrictions on foreign investment access in the manufacturing sector, and five new measures are already facilitating the entry of foreign nationals into China for business, education and tourism.

Zhang Junkuo, a national political advisor and former deputy director of the Development Research Center of the State Council, said amid rising anti-globalization sentiment and intensifying geopolitical tension, "it is particularly important for China to respond to uncertainties in the external environment with its certainty in opening up."

Reforms in key areas

Advancing reforms in key areas and crucial sectors will also be a focus of attention for national lawmakers and political advisors.

Accelerating the building of a unified national market is a concern of Jin Li, a national political advisor and vice-president of Southern University of Science and Technology.

"It's important to break down local protectionism and market segmentation," Jin said, calling for accelerating the establishment of unified market institutions and rules in such terms as property rights protection, market access and fair competition. Many are also concerned about further boosting the confidence of private enterprises.

Gao Zicheng, NPC deputy and president of the All China Lawyers Association, said it was necessary to further optimize the development environment and stimulate internal driving forces and the innovation vitality of private enterprises.

Whole-process people's democracy

The "two sessions" displays China's whole-process people's democracy in action, as national legislators and political advisors - ranging from farmers to state leaders - gather in Beijing to deliberate on bills or discuss the affairs of the state.

This year also marks the 70th anniversary of the founding of the NPC and 75th anniversary of the founding of the CPPCC.

The people's congress system is a foundational political system for upholding the unity between leadership by the CPC, the running of the country by the people, and law-based governance.

The CPPCC is an important organ for multiparty cooperation and political consultation led by the CPC. It is a major channel for socialist consultative democracy and a specialist consultative

PM Modi contributes Rs 2000 to BJP, urges people to 'donate for nation building'

New Delhi

Ahead of the Lok Sabha polls, Prime Minister Narendra Modi yesterday contributed to the Bharatiya Janata Party to strengthen the efforts of building a Viksit Bharat and urged everyone to donate and help the efforts of the saffron party in nation-building.

The Prime Minister donated Rs 2,000 to the BJP party fund.

"I am happy to contribute to @BJP4India and strengthen our efforts to build a Viksit Bharat. I also urge everyone to be a part of #DonationForNationBuilding through the NaMoApp," the Prime Minister posted on X.

The call to donate money comes after the Supreme Court in February delivered a unanimous verdict, striking down the Electoral Bonds scheme as unconstitutional. While the Opposition parties hailed the Apex court decision, the ruling BJP said that the scheme was brought in for transparency in electoral funding.

The CJI while reading out his judgement said that the Supreme Court holds that anonymous electoral bonds are violative of Right to Information and Article 19(1)(a).

The Supreme Court said that information about corporate contributors through Electoral Bonds must be disclosed as the donations by companies are purely for quid pro quo purposes.

The purpose of curbing black money is not a sufficient justification to anonymise the identities of donors and the details of the contributions in the Electoral Bonds scheme, the SC said while striking down the Centre's Electoral Bonds scheme.

An Electoral Bond is an instrument in the nature of a promissory note or bearer bond which can be purchased by any individual, company, firm or association of persons provided the person or body is a citizen of India or incorporated or established in India. The bonds are issued specifically for the purpose of contributing funds to political parties.

Data elements contributing to China's industrial manufacturing innovation

WHAT is the role of data n industrial product creation, from R&D to manufacturing?

Recently, a three-year action plan was published by 17 government departments, including the National Data Administration (NDA), to promote the use of data as a factor of production and let data play a more significant role in driving economic and social development. According to the action plan, the data use will be boosted in 12 sectors, including industrial manufacturing.

Innovating R&D models, promoting collaborative manufacturing, enhancing service capabilities, and strengthening regional coordination, China's industrial manufacturing is accelerating efforts to leverage the multiplier effect of data, in order to better drive innovative development.

In the past, the development planning of products in the consumer durables industry relied heavily on manual market research. This resulted in long cycles, limited information, and low efficiency. Data elements can play a significant role in improving this process.

For example, when developing a new dryer, the R&D team of Midea Group, a Chinese home appliance giant, spotted consumers' demands for "fast drying" and 'space saving" by leveraging big data from public opinion, market, user, and business. They also discovered a stronger demand for drying children's clothes that require frequent washing.

As a result, the team developed a compact dryer targeting young parents and emphasizing instant drying and disinfection functions. As expected, the product was well-received in the market as soon as it was

An executive in charge of



noted that digitalized planning helps with the constant generation of innovative concepts in different product categories.

"It improves the efficiency of product planning by 75 percent, reducing the time for concept discovery and validation research from the previous average of two months to two weeks now," the executive

Data elements are playing an increasingly important role in the manufacturing pro-

At a plant of Chongqing Tsingshan Industrial Co., Ltd., automated guided vehicles were transporting materials along the automotive transmission assembly line, and industrial robots swinging their arms in coordinated motion as transmissions came off the production line orderly.

"We focus on improving digital capabilities around our business operations, shifting from experience-driven management to data-driven management," an executive of the company told People's Daily.

An MIIT official said the scale of the equipped with 5G improved supporting industries for smart manufacturing, including intelligent equipment, industrial software, and system solutions, exceeded 4 trillion yuan (\$555.66 billion) in 2022. The technology of 5G has been piloted in nearly 2,000 factories, making China the world's largest application market for smart manufacturing. In 2023, the industrial internet achieved full coverage across all major industrial categories.

Russia supports African Union's steps to stabilise situation in South Sudan, diplomat says

GENEVA

MOSCOW supports international steps to stabilize the situation in South Sudan, including the African Union's mediation efforts, Russia's delegation to the 55th session to the UN Human Rights Council in Geneva said.

"We welcome the achievements of South Sudan's leadership in forming the governments of states and the chambers of a transitional parliament, draft a constitution and create a national human rights council," Ilya Barmin, the head of the Russian delegation, said.

He pointed out that the transitional period had been extended to February 2025 based on an updated peace agreement on South Sudan, and a roadmap had been

adopted. "We support international steps to stabilize the situation in the country and strengthen peace and security, including the African Union's mediation efforts," Barmin stressed.

Russia believes that the human rights situation in South Sudan will improve after the domestic conflict is finally resolved, he noted. Moscow "strongly rejects attempts to use international platforms, including the Human Rights Council, to put political pressure" on South Sudan, Barmin added.

The 55th session of the UN Human RIghts Council is taking place in Geneva from February 26 to April 5. Although Russia is not a member of the council, it is taking an active part in its meetings.

HERE was a science fiction (sci-fi to bona fide veterans) fad in the last decades of the past century, known as 'time travel', playing around with what is known as relativity to move into the past, or the future.

Much of that occurs by imagination but sometimes efforts are made to create instruments that can travel inside time, to no avail.

Pochettino feels unloved by Chelsea's frustrated fans

MAURICIO Pochettino admitted he feels unloved at Chelsea after frustrated fans called for his sacking during Saturday's 2-2 draw at Brentford.

Pochettino's side led through a Nicolas Jackson header, but were pegged back by Mads Roerslev's close-range strike after half-time.

Shortly after Yoane Wissa put Brentford ahead with a spectacular overhead kick, Chelsea supporters packed into one corner of the stadium began chanting for Pochettino's dismissal and singing the name of former Blues manager Jose Mourinho.

Axel Disasi scored a late equaliser to spare Chelsea another embarrassing defeat in a troubled first season in charge for Pochettino.

But it was hardly an enjoyable afternoon for the former Tottenham and Paris Saint-Germain manager on his 52nd birthday.

Asked if he had heard the Chelsea fans' taunts, Pochettino said: "I've been told, I didn't hear to be honest, it's difficult for me to understand.

"But it's normal, we were losing the game 2-1 and they expressed their frustration. I am one of the ones responsible, I'm the coach. I was asked before if I feel the love from the fans? No."

Pochettino has failed to revitalise Chelsea after arriving in the close-season to clear up the mess left by his predecessors Graham Potter and Thomas Tuchel. Chelsea have spent over £1 billion (\$1.2 bil-

lion) on signings since Todd Boehly's consortium bought the west London club from Roman Abramovich in 2022.

But the spree has left Chelsea with an unbalanced and underachieving squad who are languishing in 11th place in the Premier League.

The Blues, who have not won a domestic trophy since 2018, were beaten by Liverpool in last weekend's League Cup final despite facing an inexperienced line-up.

Pochettino is certain to suffer more terrace jibes amid mounting speculation that he will be axed by the end of the season. But the Argentine, yet to win a trophy in English football, is adamant he can cope with the vitriol.

"I'm not worried. We need to accept this relationship. You win your relationship through winning games," he said. "I will continue to work and try to change this perception. We need to manage some reality. We are working really hard to try to win games, the team is fighting.

"If it doesn't work and the fans are disappointed I need to respect their opinion. I think the relationship is good. If they did what they did, fans are emotional.

"I am fighting with all my sense to try to provide a team to play in the best way to score goals and win games. Today is my 52nd birthday, I know this business, but I'm going to fight."

There were wild and expressive remonstrations with the officials after a couple of robust challenges from a petrified Orlando backline. That dramatic battlefield limp quickly (and suspiciously) cast aside when he sprang to life to convert those early chances.

And, of course, the 37-yearold was escorted from the field by teammates at half time after an altercation involving that same assistant referee and the Orlando bench. Provided 'Bad Suárez' doesn't come too strongly to the fore, the first half typified why he may be Inter's most important signing from an on-field perspective. Because the winner's mentality has not diminished.

A terribly kept secret, Saurez was an offseason arrival from Brazilian club Gremio, where he captained the club to an historic season, scoring 24 goals and notching 17 assists. Gremio narrowly missed out on a first Serie A title since 1996, losing out Palmeiras by just two points.

But his transformative effect was evident, just as it was at Liverpool more than a decade ago. Suárez found the net 31 times in the Premier League as Brendan Rodgers unfancied side came heartbreakingly close to ending Liverpool's already epic title drought in 2014; before his successor Jürgen Klopp's team finally did so in 2020.

At Barcelona, surrounded by similar talents, Suárez did not require quite the same talismanic feats, although Barca fans learned all about them when a spurned Suárez delivered the title for Atletico Madrid with 21 goals in 2020/2021.

However, it was the old Nou Camp trio of Suárez, Jordi Alba and Messi who combined to fashion a fourth goal for Inter early in the second half.

Suárez' one-two with a surging Alba saw Orlando defender Robin Jansson crash the ball against the bar in a desperate effort to clear the fullback's goal bound shot. Messi scrambled home the rebound. Minutes later Suárez put a left-wing cross on an unmarked Messi's head for the fifth.

Suárez, who has said Inter Miami will be his final stop before retirement, was withdrawn on 67 minutes, to a standing ova-

While Messi's arrival undeniably predicated all that has transformed Inter Miami from MLS also rans to the league's most unmissable team, it is likely to be the last bullets in the chamber of El Pistolero's career that will be imperative if club is to complete the immediate championship transition the team was built to achieve.

"I hope the Miami fans are so happy," said Suárez, with a wink after the game.
