### Motorcyclists' arrests: Lugola sets strict code

#### By Polycarp Machira, Dodoma

HOME Affairs minister Kangi Lugola yesterday reiterated his warning against police officers who without proper cause, arrest commercial motorcycle riders, 'boda boda."

The minister told the National Assembly that there is an ongoing trend by some officers who arrest boda boda riders and take their motorcycles to police stations, only to end up losing some spare parts.

Lugola (pictured) was responding to a supplementary question by Special Seats MP Rehema Migilla (CUF) who said most motorcyclists get arrested and fake cases filed against them, this being forced to pay certain amounts of money rapidly. When they delay they find some parts of their motorcycles missing.

"Let the minister tell us here who steals parts of the motorcycles in police custody and if it is the police themselves, what is

the government doing to end the vice?" she demanded.

While responding to the question, he said it is only motorcycles involved in criminal activities, accidents and those without owners which can be confiscated by the police.

He said those found guilty of other offences, including driving without helmet should not be taken to police stations but be fined, and the fine be paid within seven

"The motorcycles held at police stations are always registered and in cases where any part is missing, the person who arrested the person should be liable for the loss," said the minister.

He told MPs that in the past he used to wonder why vehicles in police custody always come out with some parts missing, noting that the trend is on motorbikes too.

Earlier, the deputy minister for Home Affairs, Hamad Yusuf Masauni, said the Road Safety Act section 168 reviewed in 2002 gives police officers the power to stop any motorist, inspect the vehicle, stop it or arrest the owner.

THE International Fund for Agricultural Development (IFAD) has set aside 127.3bn/- for funding agriculture projects in the country for three years beginning January 2020.

A State House statement said that IFAD president Gilbert Fossoun Houngbo revealed this yesterday when he held talks with President John Magufuli.

Houngbo who is in the country for threeday official visit hailed President Magufuli's government for the strong efforts in implementing various development projects including those funded by IFAD.

He said after setting aside the funds aside, IFAD is now waiting for the Tanzania government to indicate key areas for the money to be allocated, noting that he hopes the projects will be implemented since Tanzania is a peaceful country, and given the way the government has shown its commitment.

In his remarks President Magufuli thanked

the international agency for the support and promised that the working relations existing since 1978 between Tanzania and the agency will continue for the country's benefit.

President Magufuli said the money will be used in key areas which are of interest to the agro-sector including the use of technology in production, seed production, solving market challenges and improving livestock keeping. He thanked IFAD for not attaching to it some terms and conditions.

The Head of State directed the Ministry of Agriculture to immediately list key areas for the funds to be allocated.

Houngbo landed in the country on Sunday to discuss with President Magufuli key issues on better ways to improve food and nutrition security, jobs for rural youth and poverty reduction.

The talks were also expected to dwell on the role of smallholder farmers in ensuring food security, the challenges posed by climate change, opportunities agriculture can offer to rural youth and the need for more investments to transform agriculture into a highly productive and competitive sector.

Although Ndugai did not state exactly what Masele allegedly told higher authorities, a video clip posted by Masele on social media showed that the bone of contention are differences between the Tanzanian lawmaker in his capacity as PAP first vice president and PAP's Cameroonian president, Roger Nkodo Dang.



DESPITE the rapid scale-up of antiretroviral therapy (ART) since 2000, HIV/AIDS is still the most common cause of death in sub-Saharan Africa, according to data from the Global Burden of Disease.

A new scientific paper reveals striking variation in HIV prevalence Africa and 60% of people in West and Malawi, Uganda, and Tanzania where at provincial and district levels. The paper, published in Nature, provides precise geographic estimates of HIV prevalence and numbers of people living with HIV to identify priority areas for health care support to reduce the burden of HIV.

"Changing the trajectory of HIV/AIDS in Africa requires that we continue to seek better ways to know the epidemic. This paper will support policymakers and health care providers in locating hotspots of HIV/AIDS at national and subnational levels, and will help guide smart investment of scarce resources for diagnosis, prevention, and treatment," said Dr. John Nkengasong, director of the Africa Centers for Disease Control and Prevention (Africa CDC).

The study, conducted at the Institute for Health Metrics and Evaluation (IHME) at the University of Washington, is the first to map HIV prevalence among adults ages 15-49 comprehensively at a granular, subnational level for all 47 countries in sub-Saharan Africa. The results show high variation in prevalence and changes in prevalence over time within countries.

Since 2015, the World Health Organization has recommended ART for all people living with HIV, because early treatment enables them to live longer and healthier lives and reduces the potential for transmitting the virus. Despite the rapid scale-up of ART, 34% of people in East and Southern

## New research finds some African nations have fivefold disparities in numbers of people infected with HIV

Central Africa living with HIV are not currently on treatment, according to UNAIDS. Growing population size and continued high incidence of HIV infection, combined with increased life expectancy among people living with HIV (PLHIV), has led to an increase in PLHIV in sub-Saharan Africa: between 2000 and 2017, the number of people aged 15-49 years living with HIV in sub-Saharan Africa increased by 3 million, even as HIV prevalence declined.

"Global funding for HIV/AIDS has declined since 2013, but our research shows the substantial burden that still exists and reveals where geographically targeted interventions might make a big difference. Our goal is to provide robust data that can be used to help prevent future infections and ensure appropriate care for people living with HIV," said IHME's Dr. Laura Dwyer-Lindgren, lead author and Assistant Professor of Health Metrics Sciences.

Key findings from the study include: Most countries (36 of 47) had a more than two-fold difference in prevalence between second-level administrative subdivisions (such as districts or departments) in 2017. In one-fourth of countries, the largest difference was more than five-fold.

While the country-level analysis shows a clear divide between countries in Southern sub-Saharan Africa and the rest of the continent, subnational-level analysis reveals areas outside Southern sub-Saharan Africa with high HIV prevalence, including parts of Kenya,

prevalence exceeded 10% in 2017.

Both the direction and rate of change in HIV prevalence from 2000 to 2017 varied between and within countries, highlighting the changing landscape and underscoring the need for current, local data.

The spatial concentration of people living with HIV (PLHIV) was highly variable. While a large number of PLHIV were concentrated in a small number of areas, an equally large number were widely distributed in areas with lower spatial concentrations of PLHIV.

The Bill & Melinda Gates Foundation funded the study, part of a five-year grant that enables IHME researchers and collaborators globally to map a range of health metrics in 5x5 square kilometer units. The research is part of the Local Burden of Disease project at IHME led by Dr. Simon I. Hay, Director of Geospatial Science at IHME and Professor of Health Metrics Sciences at the University of Washington.

The estimates highlight transnational trends, suggesting that international collaboration could help address persistent high prevalence in some areas. "The work done at IHME and on the Local Burden of Disease team is supported by a large network of collaborators, who play a critical role in the analysis of data and the use of published data in policy. We are always seeking to build our collaborative network and are very grateful to all who contributed to this study," said Dr.

THERE is a shortage of 8,882 teachers for schools with special needs in the country, as the department enrols at least 706 pupils every year, the House heard yesterday.

The rvelation was made yesterday by the deputy minister for Industry, Trade and Investment, Stella Manyanya on behalf of the ministry of Education, Science and Technology.

She was responding to a question from Special Seats MP, Grace Tendega (CHADEMA) who had wanted to know what the government move to ensure there are enough teachers in schools for pupils with special needs.

"Pupils with special needs need more attention unlike their counterparts, what is more trainees.

the government doing in order to have more teachers specialised in special education so as to help them get education too?" she asked.

In response, the deputy minister said by December 2018, some 5,556 teachers with special education graduated with degrees, diplomas and certificates from different colleges in the country including Patandi and University of Dodoma (UDOM).

She said in order to increase the number of teachers enrolled for the course, the government has completed expansion of Patandi Teachers College to accommodate

"The college has also introduced special certificate course in education for the 2018/19 intake aimed at increasing the number of teachers for special education and reduce the existing shortage," she added.

She also noted that the government has been taking various measures to alleviate shortage of teachers with such specialisation in the country.

However, Manyanya noted that the challenge of teachers for pupils with special needs is due to positive perceptions of the society, realising that children with disabilities deserve education just like the rest.

## Tanzania sells 600 tonnes of tea via Dar warehouse

LAST Monday, and for the first time, Tanzania sold 600 tonnes of tea at the Mombasa Tea Auction ex-RVTS Tea warehouse recently established in Dar es Salaam by the DL Group of Companies, the DL Group Chief Executive officer, Stephen Bett said yesterday.

Basking in first success, Bett said for the first time Tanzania's tea was bought from Tanzania's own warehouse established for that purpose.

"This warehouse will help the Tanzanian Tea Producers have an easy Platform for offering their teas through the well-established and internationally recognized Mombasa Tea Auction," he said, adding that it will also offer more advantages to Local Tea Producers especially the Small to Medium indigenous Producers. Hence better competitive Prices and lower selling & distribution losts like transport & logistics resulting to better returns to the farmers.

The CEO said the established warehouse tea tasting facility also acts as a point of quality assurance, standardization and capacity building through quality comparison with high quality marks and will help the small Producers to improve and standardize their produce to internationally acceptable tea standards.

Bett said the company sent to Mombasa tea samples only from the warehouse, "and big buyers nodded in approval. They appreciated the quality of Tanzanian tea and bought a total of six hundred tones. It is our success --- as a company and as Tanzania," he said in a very relaxed mood of success.

Only last month, Dr David Langat the Executive Chairman announced in Nairobi his company's determination to make Tanzania, Africa's tea growing and marketing hub in the next few years, saying Tanzania has highly competitive tea and a huge potential of increasing tea production.

Referring to Monday sales, the chairman said buyers at the Mombasa auction had justified their company's dream. He mentioned that the Teas were absorbed by buyers for the UK, Russia, Middle east, Egypt, South Africa and Sudan markets amongst others. Some of the Teas purchased were done on a follow-up basis after the auction, hence buyers rushed to the selling Brokers to fill up their consignments lying in Dar es Salaam warehouse for ease of logistics.

"This is saving the Tanzania Producer the cost of Transporting the Tea to Mombasa and having the Tea in Mombasa warehouse awaiting sale at the same time giving the Producers access to the Brokers services at the auction," he said. He thanked the government for supporting

the initiative and commended the cooperation between their company and the Tanzania Tea Board. He said there was strong cooperation between the board and their company adding: "this cooperation is bearing fruits."

The Chairman requested for more collaboration between two governments to shorten the time it takes for Teas to Move from Dar es Salaam to

According to the chairman, Burundi, Rwanda and Malawi tea growers have shown their interest in using Dar es Salaam warehouse and tea testing room to Market their teas.

The chairman also appealed to the government to remove logistical barriers so that tea from the three countries can flow freely to the Dar es Salaam warehouse for onward auctioning.

The Ministry of Agriculture has designated tea as one of the eight key traditional cash crops alongside cotton, pyrethrum, cashew nut, sisal, sugar, coffee and tobacco.

The ministry said tea production in 2018/2019 year was expected to increase thus a need to improve on quality of the Greenleaf and made tea, market access and cost reduction which will result in better performance of the tea sector which is a major foreign income earner to the government and a major source of employment.

### Lands sector faces serious shortage of workers - govt

#### By Polycarp Machira, Dodoma

LANDS sector faces acute shortage of workers, derailing various developments, deputy minister for Lands, Housing and Human Settlements Development, Angelina Mabula said here yesterday.

She said the department has a shortage of 1,411 employees nationwide, saying it is the reason behind the slow pace of land formalisation process currently going on in the country.

The deputy minister was responding to a question by Tunduru North MP,Ramo Makani (CCM) who had wondered when the government would post land officers in Tunduru district council.

He also asked when the government would relocate about 2000 hectares of land to residents of the district council, claiming that land was wrongly taken from them.

"In addition to increasing the number of land officers, when shall the government return the land to people of Nambarapi village among others in Tunduru district?" he asked.

In response, the deputy minister noted that the demand for land officers is currently 2,957 for different councils in the country, noting that the present

number of workers is 1,546.

However, she explained that according to the 2016 workforce requirements, every district council is supposed to have three land officers, three planning officers and three valuation officers as well and four assistants.

Mabula said Tunduru district council has four employees in the land sector who are two planning officers, land valuers and land officers and assistant land officer.

"The government continues to set a side budget to employ more land officials every year in efforts to meet the required standards", she said, adding that the ministry will post them, depending on funding from the central government.

On the lands to be relocated to people, the deputy minister noted that the conflict started in 2003, a situation that led to the case number 03/2016 lodged at the Tunduru Land Commisssion.

She said the case was between TAMCU Limited against some four residents, namely Hassan Mussa Ismail, Ismail Mussa Ismail, Sophia Mussa Isnail and Said Ndekelo whereby the cooperative society won the case.



#### Hotspots, not trouble spots: Africa seeks tourism boom

AFRICA draws just five percent of the world's tourists despite boasting attractions ranging from the Pyramids and Victoria Falls to wildlife safaris and endless strips of pristine beach.

But the continent's huge potential can be unlocked by eco tourism, cultural experiences, domestic travel and political stability, said experts at an African tourism conference hosted by Airbnb in Cape Town last week.

"When you look at the success stories, it's those countries who've embraced trends," said the African Tourism Association's (ATA) managing director Naledi Khabo who spoke at the summit.

"When you look at some countries which have made sustainability a focal point, like Tanzania, or Rwanda, they're very attractive for certain travellers."

Eco-friendly safaris and carbon-neutral lodging draw increasing numbers of tourists from Europe and North

The number of tourists visiting Tanzania has more than doubled since 2006 to above one million contributing 14 percent of the country's gross domestic product (GDP), according to Tanzania Invest.

Khabo, who speaks for the African tourism sector, said other success stories included South Africa, "which is promoting the diversification of their products beyond the

South Africa has witnessed a boom of experience-based tours, taking travellers to disadvantaged township and rural communities as well as wine farms and game lodges.

Abigail Mbalo founded the 4RoomEkasi concept to showcase food and lifestyles in South Africa's black communities to visitors

"We tapped into the development of tourism in rural and township spaces," she said. "We are now starting to see cultural inclusivity. Those areas have been untapped."

Tourism is a major employer of poor black South Africans and accounts for nearly 700,000 jobs -- a rare success story in a country with an unemployment rate of almost 27 percent.

The World Bank, which spoke at the tourism summit, praised the emerging trend for community-based travel projects like Mbalo's for creating opportunities for women and young people. "Every new business, destination, route or visitor creates opportunity for local people," said the World Bank in a statement.

While many African destinations have courted foreign visitors' hard currency, Kenya has invested heavily in promoting "staycations".

The country moved to promote domestic travel after dips in foreign arrivals following violent unrest and criminal attacks in recent years."We have managed to develop the domestic market. Twenty-one percent of Airbnb occupancy is domestic market. It's benefiting us," said Kenya's Tourism Minister Najib Balala at the conference.

Tourism, now the second largest driver of Kenya's GDP growth, was worth \$1.2 billion in 2017.

But many countries on the continent have struggled to woo foreign visitors fearful of political instability and violence.

"The biggest challenge is perception," said Khabo. "Sometimes there is a real threat and sometimes it's just perceived."

Rwanda is one country that has successfully transformed its global image. The small east African nation was torn apart by a genocide in 1994 but has since established itself as a highend destination.

"Tourism is the number one foreign exchange earner, which is amazing to see in a country like Rwanda," said Rosette Rugamba who was appointed by President Paul Kagame as head of Rwanda Tourism from 2003 to 2010. "It is a huge contributor to the image-building of our country."

Zimbabwe, which is home to some of Africa's best game and Victoria Falls, has enjoyed a boost in visitor numbers since long-serving despot Robert Mugabe resigned in November.

While the number of foreign visitors to Victoria Falls jumped nearly 50 percent in the first quarter of this year, the country still operates far below its tourist potential.

"The onus is on African governments and tourism boards to be more proactive in addressing perceptions," added Khabo. One African country that has seen its tourism industry

squeezed is Egypt, once a magnet for travellers that has since the 2011 revolt seen visitor numbers plummet, despite the huge draw of the Pyramids and the Red Sea.

aspect of its economy as it is Tanzania's largest export crop. Tanzanian coffee production averages between 30-40,000 metric tons annually of which approximately 70 per cent is Arabica and 30 per cent is Robusta.

The country has nine main growing regions of Arabica are while The main growing region of Robusta is the Bukoba area of the Kagera Region. Harvest time is traditionally October to February.

Ninety per cent of the nation's coffee farms are smallholder, with the remainder being plantations. The industry estimates are approximately 270,000 personnel involved in the coffee industry. Coffee was introduced into the Tanzanian region from modern day Ethiopia in the 16th century. Coffee was not really brewed in the region but was used as a stimulant.

Brazil is the largest coffee producing country in the World, and history comes from the last 150 years. Vietnam is the second largest producer of coffee after Brazil with total production of about 1,300,000 tons per year.

Ivory Coast is West Africa's largest producer, and the third largest in sub-Saharan Africa. Ethiopia, which is the origin of Arabica coffee, is renowned for its unique Yirgacheffe, Sidamo and Harar Arabica varieties, while Kenya's fine Arabica beans grown at high altitude near Mount Kenya are in equally high demand.

It was recently reported that the country's coffee production is projected to dwindle by 23 percent in the 2019-20 season. Africa's fourthbiggest coffee producer, according to the report overall production in the country.

OFFEE production in coffee would drop by 23 per cent in Tanzania is a significant the next period due to delayed rainfall in northern regions, according to the Tanzania Coffee Board.

> The crop for the season that starts in July may decline to 50,000 tons, the Tanzania Coffee Board said in an emailed response to questions. It said last month that the country had experienced dryness in many growing areas, and that farmers would start collecting crops in May in the Kagera and Mara regions, Bloomberg reported.

> After missing earlier targets to boost production, the country has said it's considering distributing seedlings to farmers in an effort to double supply in five years. Arabica coffee accounts for more than half of Tanzania's output, and it mainly ships coffee to Japan, Italy, the US and Belgium.

> A lower cycle will follow a bumper harvest this season. Auctions for the 2019-20 crop will start in Moshi at the end of July, the board said. As far as the importing of coffee is concerned, Japan is the leading importer of Tanzania's coffee.

> The decline in productivity is caused by a number of factors including low applications of fertilisers and poor investment, according to Tanzania Coffee Board's acting director general, Primus Kimaryo. The Tanzania Coffee Industry Development strategy 2011-21 aims at increasing production to 100,000 tonnes annually.

## Hints on journalistic investigation of extrajudicial killings

XTRAJUDICIAL killing murder carried out by state actors or by non-state ✓ vigilantes with the cover of state sanction - is the ultimate abuse of power and violation of rights. Reporting on such murders poses specific challenges to investigative iournalists.

Journalists have to figure out how to sort the truth from rumours, bear witness for powerless people and identify lines of accountability when they have been obscured.

Rappler's investigative reporter Patricia Evangelista from the Philippines and Pulitzer Prize-winning special correspondent for Reuters Clare Baldwin both have experience covering such difficult subject matter

they have fearlessly reported on president Rodrigo Duterte's war against drugs since he took office in 2016.

Duterte's hardline stance and public call for citizens to eliminate drug traffickers has resulted in thousands of deaths of alleged drug-dealing suspects, some killed by vigilantes and others murdered by cops themselves (the death tally varies widely according to which agency is counting).

Duterte's government has also been releasing corrective issuances over the past few years to justify its extreme anti-drug policy. To tackle this monstrous human rights violation, Evangelista and Baldwin shared their tips for digging deep into extrajudicial

One: Collect and map the data. When data are not readily available, collect them. To get an estimate of the number of suspected drug-related murders, Baldwin travelled to different police stations in the Philippines and took pictures of handwritten police records as well as collected electronic data from police databases. The information she collected was useful as it had the names of victims, GPS coordinates of the killings and narrative descriptions of what happened.

Piecing together all the information she retrieved was labour-intensive, but it allowed her to establish a record of what had happened. "Mapping the killings is important because you can then look for the concentrations," she said.

Two: Data are more than just numbers. As the drug war progressed, Baldwin's colleague, a Reuters' photographer, realised that it was getting increasingly difficult to take pictures of bodies at the crime scenes because they were being whisked away to hospitals very quickly.

Baldwin and the photographer were equally perplexed. "We thought: These people were quite dead; why are the bodies going to the hospital (instead of

Surprisingly, they discovered that instead of declaring the victims "dead on the spot" as it had occurred, the police records stated that these victims had been "dead on arrival" at the hospital.

"Dead on arrival, dead on the spot... We treated those terms as data and established the lexicon of terror, the language Duterte used to kill people," Baldwin said.

By mapping out these common phrases, she was able to establish that in the beginning, a greater proportion of drug suspects were recorded as shot dead on the spot, while later there were a lot more dead on arrival. This helped lay the foundation for her story suggesting that the police were sending corpses to hospitals to cover up summary executions.

Three: Interrogate the data. There can be more than one story hidden in the data. Rappler and Reuters both asked the question "Which police station racked up the most drugrelated deaths?" and came to the same conclusion. Batasan Police Station 6 in Quezon City turned out to be the most

Baldwin took a closer look at Station 6 and discovered that the officers who formed the core of the anti-drug unit there were either from or near Davao, the hometown of president Duterte.

Lethal Squad: The anti-drug unit at Station 6, who called themselves Davao Boys, killed 108 people in the drug war campaign's first year.

Four: Reverse data patterns also tell a story. While it is natural to focus on the number of deaths and location of extrajudicial killings, Rappler decided to flip the narrative.

Evangelista said they first mapped where people died with big red dots, which turned out to be a lot of slum areas. Using the same map, they also highlighted the places where people did not die - the privileged zones, places where people could afford private education, gated communities and prime real estate.

"Where people did not die proved that this is not a war on drugs. It is a class war, a war against the poor and most vulnerable."

Five: Find the emotive angle. If the media reports on massacre after massacre, there comes a point where the public might get numb to such stories.

Consider other angles with an emotional arc. "Tell the stories of families seeking justice, the extent of what lengths they will go to for their family," Baldwin suggested. For example, she shadowed and reported on a family's entire process of finding answers from beginning to end, from the funeral parlour to a second autopsy.

Reuters also used screen grabs from the footage of four surveillance cameras to give the public an idea of how these killings are carried out. "It was the first time people could see what really happens. Showing them what it looks like is important as well."

Six: Get expert analysis on crime scene photos. Medical investigators or forensic scientists can tell you a lot about what happened from crime scene photos. Compare their expert analysis to official police records to see if things check out.

Baldwin cited an example of a police drug raid that caused the death of several men. Police accounts stated that the victims were shot while fleeing a gun battle. The crime scene photos, however, suggested a different

"The victims suffered shots through their hands," Baldwin said, adding: "Those are typically defensive wounds. They were probably not firing a gun but trying to defend themselves." Other clues that didn't add up included the bloodstain patterns and the clustering of gunshot wounds.

Forensic Analysis: Gunshot wounds and bloodstain patterns of several drug suspects did not match the police's account of the incident.

Seven: Accuracy is key. The stakes are high for covering extrajudicial killings. By their nature, they are difficult to prove, especially when authorities are complicit. Police reports may be questionable. "So layer witness testimony upon testimony, get paranoid as hell and bulletproof your story," Evangelista stressed.

Eight: Know when to walk away. You are the person uninvited at the crime scene. You are present at the worst moment of a person's life. How you approach that person will matter to them, and it will also matter in the long term because that is how they will decide whether to talk to you in the future," Evangelista said. She advised journalists to be patient in waiting for the next of kin to grant permission for an interview.

"If they tell you that they are afraid and that talking to you might put their lives in danger, do not force them," Evangelista noted, elaborating: "Say 'I'm so sorry, my condolences' and walk

If they consent to an interview, avoid asking questions like "How do you feel?", "Is your son guilty?" or "Do you feel guilty for not being able to look out for your child?" Instead, Evangelista suggested, start by asking them what they had for breakfast, their names, jobs, their son's age, or how many children they have, because facts are the easiest things to answer.

Nine: Protect your witnesses. Protecting witnesses doesn't just mean changing witnesses' names or blurring

their faces in the final publication. Evangelista emphasized. She said it is important to explain to them that once the story goes public, people may eventually figure out who they are. "The moment people know who the victim is, it is possible to find out who the wife is or who the children are."

Make sure they are aware of that and have a way to call you or somewhere to run in case something happens. Connect them to people (and organisations) that can protect them. Ten: Keep yourself safe and your

communications secure. Evangelista and Baldwin agreed that journalists should not cover extrajudicial killings alone. "Make sure you have someone

with you, a photographer, a fixer or someone else," Evangelista stressed. Baldwin added that it is imperative to keep a point of contact informed at all times about your whereabouts and who you are meeting. Varying your daily routine is also

a good security measure. "Stay in different hotels, go out at different times of day. The more irregular your schedule, the better," Baldwin said.

As a standard practice, journalists should also be encrypting everything from emails to text. "It is also important not to tell your sources which other sources you are talking to, particularly when these sources might kill other sources," Evangelista said.

At the end of the session, both journalists talked about how they manage to stay focused and not go off the rails while covering such traumatic

Baldwin said that having regular conversations with her colleagues helped keep her sane. "We talk about logistics, hotels. Just having someone to bounce ideas off and talk to is important."

Evangelista agreed that having a "tribe" to talk to is important. She also swears by this personal practice: "I only read books and watch movies with happy endings."

Cultural diversity is the quality of diverse or different cultures, as opposed to monoculture, the global monoculture, or a homogenisation of cultures, akin to cultural decay. The phrase cultural diversity can also refer to having different cultures respect each other's differences. The phrase 'cultural diversity' is also sometimes used to mean the variety of human societies or cultures in a specific region, or in the world as a whole. Globalisation is often said to have a negative effect on the world's cultural diversity.

Diversity refers to the attributes that people use to confirm themselves with respect to others, that person is different from me. These attributes include demographic factors (such as race, gender, and age) as well as values and cultural norms. The many separate societies that emerged around the globe differs markedly from each other, and many of these differences persist to this day.

more obvious cultural differences that exist between people are language, dress and traditions, there are also significant variations in the way societies organize themselves, such as in their shared conception of morality, religious belief, and in the ways they interact with their environment.

Cultural diversity can be seen as analogous to biodiversity. By analogy with biodiversity, which is thought to be essential to the long-term survival of life on earth, it can be argued that cultural diversity may be vital for the long-term survival of humanity; and that the conservation of indigenous cultures may be as important to humankind as the conservation of species and ecosystems is to life in general.

The General Conference of UNESCO took this position in 2001, asserting in Article 1 of the Universal Declaration on Cultural Diversity that "...cultural diversity is as necessary for humankind as biodiversity is for nature."

In the same manner that promotion of poverty in underdeveloped nations as cultural diversity is unethical. It is unethical to promote all religious practices simply because they are seen to contribute to cultural diversity. With the onset of globalisation, traditional nation-states have been placed under enormous

Today, with the development of technology, information and capital are transcending geographical boundaries and reshaping the relationships between the marketplace, states and citizens. In particular, the growth of the mass media industry has largely impacted on individuals and societies across the globe.

Although beneficial in some ways, this increased accessibility has the capacity to negatively affect a society's individuality. With information being so easily distributed throughout the world, cultural meanings, values and tastes run the risk of becoming homogenized. As a result, the strength of identity of individuals and societies may begin to weaken.

Some individuals, particularly those with strong religious beliefs, maintain that it is in the best interests of individuals and of humanity as a whole that all people adhere to a specific model for society or specific aspects of such a model.

## Reimagining utilities as a way to end energy poverty

F the world is to provide electricity to all by 2030, utilities and off-grid renewable energy providers must join forces.

For over a century, countries have struggled to find affordable and sustainable ways to ensure that all citizens have access to reliable electricity

In sparsely populated regions in sub-Saharan Africa and developing Asia, utilities, in particular, have grappled with the challenge of finding a financially viable way to deliver affordable, reliable power to the unelectrified using centralized generation and transmission.

In fact, all but two utilities of 39 in sub-Saharan Africa are lossmaking ventures. The majority of sub-Saharan Africa suffers grid inefficiencies that affect billions of people every day, including transmission and distribution losses as high as 50 percent, and service interruptions of over 500 hours per year in some

At the same time, a reliance on the centralized utility model to deliver energy to rural and peri-urban areas has left nearly 1 billion people without access to

Stepping into this market gap, hundreds of private-sector companies (focused on household solar and mini-grids) have emerged in the past decade to offer a different and decentralized approach. The companies have raised \$1.7 billion to help end energy poverty (70% of that since 2016) and provided improved electricity to as many as 360 million people.

Yet utilities and the private sector rarely communicate with each other or collaborate on electrification projects, either viewing each other as competition or worse, inconsequential to national electrification plans.

This is one reason why the total number of unelectrified people hasn't seen a significant shift. Clearly, working in silos is not creating the desired global development outcomes.

If the world is to succeed in ending energy poverty by 2030 (the aim of Sustainable Development Goal 7), utilities in low energy access countries and private sector companies must join forces to permanently "move the

Developing countries have the unprecedented opportunity to create smarter grids, increase energy consumption and accel-



erate access, while cutting state losses and better serving consumers.

Advancing a future of energy that is digitized, decentralized and data-driven will enable grid and non-grid energy to better collaborate, in order to maximize connections and improve human lives. This is not a traditional utility-scale approach; this is Utilities 2.0. Utilities 2.0, a framework for the future of energy in emerging markets, conceptualized by Power for All and a coalition of partners including Umeme, is seeking to accelerate the end of energy poverty.

Utilities 2.0 is rooted in the belief that energy markets can be designed today that combine centralized and decentralized

energy into an integrated, intelligent and interactive energy network that can deliver customer-centric, clean energy solutions at the lowest cost, in the fastest time.

Despite encouraging progress in recent years, we have not seen fundamental movement in absolute electrification levels since the 2012 launch of "Sustainable Energy for

Decentralized solutions have much to offer centralized power providers, including a comprehensive access strategy for unelectrified rural populations. Indeed, as data accumulates about the value of technologies like mini-grids in accelerating connections, more low energy access countries are developing policies to speed decentralized connections in peri-urban and rural areas.

At the same time, utilities have a great deal of experience to offer decentralized companies, including how to deal with the challenges of scaling-up electricity infrastructure with low-consumption customers.

Accustomed to working with donors on large-scale, big-budget projects, incumbent utilities are savvy to the realities of regulatory oversight for energy infrastructure, and can help the private sector mature and prepare to expand to the level needed to achieve universal access.

Alone, neither centralized or decentralized energy is purpose-built to end energy poverty at scale. Together, however, innovative private companies and established utilities have the power to create a new frontier in the fight to end energy poverty.

In Uganda, Umeme and a handful of leading private companies not only believe in this vision - we are trying to make it a reality.

E'RE vetting Ganduje's bribe videos -At the end of the inquiry, Muffet in his report advised the Regional Government that Sir Muhammadu Sanusi I should resign. He therefore tendered his resignation to the Governor of the Northern Region, Sir Kashim Ibrahim on 28th of March 1963.

Muffet as sole commissioner.

It will appear that the present Emir, Sanusi Lamido Sanusi is facing same circumstances. He has made some salient points on the economy and some policies Governor Ganduje sees as offensive.

As a successful banker and risk manager with track records in the industry, Sanusi Lamido Sanusi, now Muhammadu Sanusi II, became the Governor of the Central Bank of Nigeria from where he later mounted the throne as the Emir of Kano after being suspended from office as CBN governor by the then Nigeria's President, Goodluck Jonathan when he alleged that \$20b was missing from the treasury.

The power elites in Kano state then, led by the Governor, Rabiu Musa Kwankwaso, who has now also turned into a political adversary of Governor Ganduje, despite public resistance by the public, were clearly instrumental in the selection of Sanusi II as the 14th Emir of Kano. He was turbaned on 8th of June 2014 after the death of his grand uncle and 13th Emir of Kano Alhaji Ado Bayero 1930-2014.

#### Sanusi's 'sins'

Sanusi II is known for his criticisms on matters of social and economic development in Kano and Nigeria at large, offering advice and suggestions even when they seem to be displeasing to the political powers especially on the Girl

Child Education and issues on family planning. His ordeals with the Kano state governor dated back to

In one of such bold reactions on government plans in April 2017 Sanusi II challenged the Kano state governor, Dr Abdullahi Ganduje while delivering a keynote address at a function in Kaduna, on the governor's plan to secure a loan of \$1.85b from a Chinese Development Bank that would fund 85% of a Light Rail project to be constructed by a Chinese company CR18G-CRECG. The project was for the construction of a 74 kilometer facility in the state with the intention of reducing traffic on the roads and to ease commercial activities.

Rubbishing the plan, Sanusi II said that the plan to build the Light Rail project was built on a shaky foundation. He said, "we have governors, they go to China and spend one month on a tour and come back with MoU on debts.

"China will lend you \$1.8b to build light rail. This light rail will be done by workers from China, the trains will come from China, the engines will come from China, the labor will come from China while the driver is Chinese.

"At the end of the day, what do you benefit from them? Your citizens will ride on a train and when you ride on a train in northern Nigeria, in a state like Kano or Katsina, where are you going to? You are not going to industrial estate to work. You are not going to school. You are not going to the farm. You borrow money from China to invest in trains so that your citizens can ride on them to go for weddings and naming ceremonies."

This did not go down well with the political powers in the state and in a swift reaction, the State House of Assembly accused Sanusi

II of spreading false information against Governor Ganduje on his trip to China. He was also accused of spending the funds of the Emirate without the approval of the governor or the House of Assembly. As

> a result, a probe was established

with a view to indicting him and

subsequently dethroning him.

It was clear that Sanusi II was going to have problems with Governor Ganduje. On the day INEC declared Governor Ganduje winner of the inconclusive election, the APC supporters trooped to the Government House Kano to celebrate with the governor. In the course of the wild celebration they chanted songs calling for the removal of Sanusi II saying; "Tsohon gwamna sabon sarki" meaning "we support the incumbent governor and want a new Emir". They didn't stop there, they went to the Coronation House where the governor addressed them and they destroyed portraits and pictures of Emir Sanusi II.

However, Sanusi II managed to survive with the intervention of some dignitaries in the country among whom were Vice President Yemi Osinbajo, Sultan of Sokoto and former Presidents Ibrahim Babangida and Abubakar Abdulsalam. Following this intervention, the State Assembly as well as the Public Complaints and Anti-Graft Commission closed the case.

In a swift reaction, Sanusi II had no choice than to apologize to Governor Ganduje at a grand reception he organized in his honor at his palace asking him to be a forgiving

#### **Creation of new Emirates**

Thereafter, the state government in a political move meant to cut Emir Sanusi II to size by creating four new Emirates of the same first class status as his as well as indict him for alleged misappropriation of funds in order to dethrone him. The State House of Assembly would, on one hand, ensure that the powerful Emirate was broken into five Emirates of the same status while, on the other hand, the State Public Complaints and Anti-Corruption Commission would reopen an earlier probe on the issue of the Emirates funds.

With this plan in place a petition by some legal practitioners in the state led by Mr Salisu Ibrahim called on the state Assembly to cre-



ate four new Emirates by amending the Emirate law thereby cutting down the size of the Kano Emirate and revisiting history to upgrade some old chiefdoms. The assembly immediately consented and adopted it. Four additional first class Emirate Councils were then created by the Assembly within 48 hours in Karaye, Rano, Bichi and Gaya making Kano the fifth. Out of the former 43 local government areas under the Kano Emirate, only 10 are now under it in the new

As the Assembly was deliberating on the Bill, the state governor revealed to newsmen that he would sign it to law as soon as it gets to his table. Subsequently the Assembly passed the amendment into law and the governor assented to it thereby making it the fastest law ever in this part of the country.

This action was however not without opposition from some concerned Kano citizens

A member of the royal house stated that Ganduje had erred by involving the institution of the Emirate arguing that the governor should have limited his action to Sanusi II by simply dethroning him and not breaking the Kano Emirate into five

Other concerned Kano citizens then went ahead to institute a suit against the move by the state Assembly. Ruling in an ex parte motion dated May 10, 2019, being Friday, and filed by Hon. Sule Gwarzo, Justice Nasiru Saminu restrained Governor Ganduje, Kano House of Assembly, the Speaker, Clerk of the Assembly, the Attorney General and the state Printer from implementing the division of Kano into five Emirates.

In an order of interim injunction, the court directed all the parties in the suit to maintain the status quo pending the hearing and determination of the motion on notice.

It was not clear if this order was served on the parties concerned on Friday and Governor Ganduje went ahead to make appointments. He then issued staff of office to the newly appointed Emirs in the new Emirates at the weekend, while he received the court order on Tuesday, four days after.

Alhaji Ibrahim AbdulKadir was appointed as Emir of Gaya, Alhaji Tafida Abubakar Ila as Emir of Rano, Dr. Alhaji Ibrahim Abubakar II as Emir of Karaye while the son of the late Emir Ado Bayero, Alhaji Aminu Ado Bayero was appointed as the Emir of Bichi.

On the other hand, the corruption charges were still on. The former Personal Secretary of Emir Sanusi II, Isah Bayero is among those to be quizzed by the panel even as as he is now seen as a strong supporter of the moves by Governor Ganduje to unseat Emir Sanusi.

Isah was said to have evidence which would be used by investigators to prosecute the Emir who is charged with spending N6b without the consent of the state government or the Assembly. Some structures in palace were said to have been modernized by destroying the artifacts inherited from past Emirs.

Dangote's intervention saves Emir

Interestingly, there was no intervention from the Arewa Consultative Forum, the Sultan of Sokoto, other state governors or the Presidency on the matter. Sanusi II was therefore left to However, the business tycoon Aliko

Dangote was said to have been the only one who, from the beginning pleaded with Governor Ganduje not to remove the Emir but Ganduje insisted. Sources from government said the

governor gave Dangote some conditions which must be met in order to save the Emir since the Emir would not stop criticising the government.

The source said "Governor Ganduje's response was that he told Dangote to go back and tell the Emir that he should choose from three alternatives: to resign on his own, to be removed from office or for the government to create additional Emirates in the state. Ganduje assured Dangote that one of the three options would be implemented by government since the Emir would not stop playing partisan politics. But for the quick intervention by Dangote, Ganduje would have dethroned the Emir", the source revealed.

## Diplomatic spat escalates over Philippines, Canada trash row

**MANILA** 

HE diplomatic spat between Manila and Ottawa has taken a turn for the worse after Canada failed to meet the May 15 deadline imposed by the Philippines to take back the tons of trash that the North American country illegally dumped in the Southeast Asian country from 2013 to 2014.

A day after the deadline lapsed on May 16, Philippine Foreign Secretary Teodoro Locsin tweeted that he ordered the Philippine ambassador and the consuls general to pull out of Can-

On Friday, Philippine Ambassador to Canada Petronila Garcia landed in Manila, according to the Philippine media."We shall maintain a diminished diplomatic presence in Canada until its garbage is ship bound there," Locsin

The "trigger," he said, was Canadian officials' failure to show up at a meeting with Philippine customs officials on May 15."The fact alone that (Locsin) has recalled our diplomats there (Canada) shows that we are not only serious, but we're warning them that we're going to sever diplomatic relations with them," Philippine Presidential Spokesman Salvador Panelo said in a press briefing.

"Their refusal to bring back the garbage to their shores is disruptive to our diplomatic relations," he added.

Global Affairs Canada spokesperson Brittany Fletcher said on Friday that Canada is disappointed by the Philippines' decision to recall its top diplomats. However, she said in a statement that Canada will continue to closely engage with the Philippines to ensure a swift resolution of this important issue.

The garbage has been sitting in the Philippines for about six years. In 2013 and 2014, a private Canadian firm exported 103 shipping containers of garbage to the Philippines. Only 69 shipping containers are quarantined in two ports in Manila and Subic Freeport north of Manila.

Thirty-four of the containers were already disposed of.Even the ship-

ment was marked as recyclable scrap, the Philippine Bureau of Customs found the containers were consisting of household trash, plastic bottles and bags, newspapers, and used adult dia-

From March 2014, the Department of Foreign Affairs of the Philippines (DFA) has been appealing to the Canadian embassy in the Philippines to ship the garbage back to Canada.

After three months, then Canadian ambassador Neil Reeder responded to DFA that his government "has no domestic or international authority to compel the shipper to return the shipment to Canada.

However, he said Ottawa "would like to explore with the Philippines options for processing the rest of the shipment - in accordance with Philippine law - in the Philippines."Philippine environmental protection groups slammed Canada for its inaction.

Canadian Prime Minister Justin Trudeau, during his first visit to the Philippines to attend the Asia-Pacific Economic Cooperation (APEC) summit in November 2015, assured the Philippine government that Canada was trying to come up with a solution to the issue but made no promise that the North American country can bring the

Two years later, when Trudeau visited Manila again to attend the ASEAN summit on November 2017, the Canadian prime minister said Canada amended its regulations in 2016 so that it was "theoretically possible" for Canada to bring back trash container in the Phil- Rodrigo Duterte: ship back the rotting garbage and

However, he also said there were a 'dump site' for several obstacles like "who will pay for, Canadian waste where the financial responsibility is, where the consequence is."

This April, Philippine President Rodrigo Duterte chastised Canada for failing to take action on the waste issue, threatening to forcibly ship the waste back to Canada and dump some at its embassy in Manila if the Canadian government continues to refuse to resolve the long-running issue.

Duterte's tirade forced the Canadian government to issue a statement, saying it is committed to that it will pay the full cost of shipping back the 69 shipping contain-

Later, Duterte set May 15 as the deadline for Canada to bring back the trash.The Department of Finance of the Philippines said in a statement on May 7 that Ottawa informed Manila there will be several weeks delayed because "bureaucratic red tape in the Canadian government has slowed down the process of re-exporting the trash

back to (Canada)."

As the Canadian government told its Philippine counterparts, the North American country missed the deadline and caused the recall of the Philippine diplo-

Aaron Rabena, an associate research fellow from the Philippine Council for Foreign Relations said the Philippines has reason to be angry with Canada's longtime inaction."Trash or garbage itself has an apparently negative conno-

As the Philippine Senator Panfilo Lacson said, it has something to do trash to the Philippines, Philippine dignity and identity are being disregarded and debased," he told Xinhua in a written interview.

It's a long-existed issue that foreign countries, especially developed countries, keep exporting hazardous waste to the Philip-

Environmental experts say importers of foreign garbage falsely declared by private firms as recyclable plastic scraps.Reynaldo San Juan, the deputy executive director of local environmental group Ban Toxics told Xinhua that "technical smuggling" of waste is "quite rampant" in the Philippines."

It is a widespread practice and is used as a common tool to bypass customs officials to allow contraband items, such as the Canadian trash," he said.

"This practice continues because of money. It is cheaper to dispose of the waste in developing countries like the Philippines, where labor is cheap, environmental and health regulations are difficult to enforce.

Thus, rich countries take advantage of their economic position to leverage poorer countries to accept the waste, in the guise of recycling," he said.

San Juan said "poorer countries need to provide jobs to its people, and they think recycling toxic waste or harmful garbage is a way to generate jobs. It is unfortunately a misguided policy that is pushed by countries like Canada."

The Philippine environmental group also accuse Canada of violating the Basel Convention on the Transboundary Movement of Hazardous Wastes, a 27-year-old international treaty designed to reduce and control the movement of hazardous wastes between countries.

It specifically prohibits the export of hazardous wastes from rich to developing countries, like the

with national dignity. By sending Philippines.Both the Philippines and Canada are parties to the Basel Convention. "Canada is actually in violation of international law for the past six years.

> Under the Basel Convention, Canada should have taken back their waste six years ago when the Philippines asked them to take it back," San Juan added."For all its bluster as a good global citizen, Canada is a hypocrite when it comes to its observance of its Basel Convention obligations," he said.

The Chinese government has introduced a tightened ban on solid waste imports. Thirty-two types of solid waste have been banned from imports since the end of 2018.

According to the General Administration of Customs of China, imports of plastic, paper, and metal waste totaled 2.65 million tons in the first two months of 2019, down 22.9 percent from the same period last year.

San Juan said the Philippines should follow the China example, adding that "China has been a leader in protecting its borders from toxic waste.""We think the Philippines will be well served to follow China to ensure protection against toxic waste dumping, and also plastics import ban.

China and the Philippines should work together with other Asian countries to protect Asia from toxic waste dumping," San

The Philippine government and its people hope the trash issue between Canada and the Philippines can be solved rapidly. Local experts agree that through this protracted bilateral dispute, more and more Filipinos start to notice and pay attention to the garbage importing issue. Rabena said he believed that in the future "there will be stricter laws and regulation" in the Philippines for the foreign company to export garbage to this Xinhua country.

## African governments called upon to strengthen disaster risk governance

AFRICAN governments have been urged to understand disaster risk, strengthen disaster risk governance, invest in resilience, and enhance disaster prepared-

Special Representative of the United Nations Secretary-General (SRSG) for Disaster Risk Reduction (DRR) Mami Mizutori made the call here during the ongoing sixth session of the Global Platform for Disaster Risk Reduction (GP2019) will take place in Geneva, Switzerland. The meeting has been organized by the UN Office for Disaster Risk Reduction (UNISDR) and hosted by the government

of Switzerland.

She said that to realize that governments should come up with better strategies to manage risks to human life and material property, ranging from air pollution and biological hazards, through to earthquakes, drought, and climate change.

The UN official said that there is an urgent need for governments to take practical action on the implementation of Sendai framework for Disaster Risk Reduction 2015-2030, which outlines seven clear targets and four priorities for action to prevent new and reduce existing disaster risks

Mizutori said the Sendai framework set five targets and

seven indicators, and 192 agreed to implement for the betterment of their people and economic.

She noted that the UNDRR global assessment report on disaster risk reduction outlines major potential risks to human life and property, including climate change, air pollution, biological hazards and prolong drought.

According to her, the report points out what should be done to reduce risk sand having sustainable plans for infrastructures and urbanisation. She also warned that unsustainable patterns of economic activity hide the build-up of systemic risks across sectors citing for example, dangerous over dependence on single crops in an age of accelerating global warming.

"We witness severe inequalities of burden sharing between low and high income countries, with the poorest bearing the highest toll and greatest costs of disasters. Human losses and asset losses relative to GDP tend to be higher in the countries with the least capacity to prepare, finance and respond to disasters and climate change, such as in small island developing States.'

There is growing potential for one disaster to produce or exacerbate another as happens often in the case of heavy rains which trigger landslides and mudslides following wildfires or periods of long drought, she said

"If governments do not adopt appropriate strategies to manage risk, then these threats could slow or even reverse progress towards the SDGs, notably eradicating poverty and hunger, and action on climate change," she added.

"The human race has never before faced such large and complex threats. The doubling of extreme weather events over the last twenty years is further evidence that we need a new approach to managing disaster risk

if we are to limit disaster losses. Economic losses are making it an uphill battle to hold on to development gains in low and middle income countries," said Mizutori.

"At the same time, the resilience gap between rich and poor is made worse by poorly-planned urbanisation, environmental degradation and population growth in disaster exposed areas which add to a complex cocktail of risk which drives internal displacement and migration in search of a better life."

Adopted by UN Member States in 2015, the Sendai Framework aims to reduce the impact of disasters in terms of mortality, numbers of people affected, and economic loss. It requires.

#### **Nutrition and agro-ecology project** relieves villagers from poverty trap

ASHA Ramadhani one of villagers in Ntondo village, Singida Rural District who have benefited from a three-year project known as Singida Nutrition and Agro-ecology Project (SNAP).

The project was established in the district to promote agro-ecology and gender equality involving women famers, promote food security and enhance women's role at household and community level.

Implemented in 20 villages in Singida district, SNAP is coordinated by ActionAid Tanzania with support from US-based McKnight Foundation.

For Asha, who is a mother of four, SNAP is an eye-opener in her life. Through the project she is able to feed her family, pay school fees for her children, built modern house (by village standards).

After attending several training on the project, Asha is now able to train other villagers on agro-ecological farming, gender equality and nutrition issues. She also trains other women on how to cook nutritious foods for children from six months to 2 years to reduce stunting rates and malnutrition among children at home.

"I'm thankful for the SNAP project; right now, I can make a wide range of nutritious food including making Bajia snacks from cowpeas, soybeans, pigeon pea, and other crops and sell it in different schools within the village to raise income and help people improve their nutrition status something which wasn't the case in the past," a 34-year-

old woman says, adding: "The money I get from selling bajia snacks

and agro ecological farming activities, I used to build a modern house, four cows, ox plough for agro ecological farming and paying school fees for my children."

In her 6 acres of land, Asha grows bambara nuts, sorghum, maize, ground nuts, pigeon pea, and cowpeas for domestic and commercial use. Asha is among thousands of farmers in the district who are benefiting from the project, which provided room for villagers to engage in agro-ecology farming.

Apart from engaging in business, and farming, Asha has managed to set up a women's group that comprise 30 women at Ntondo village and train them on how to keep their environment clean and all issues related to nutrition.

"I have decided to train them on environmental issues after discovering that majority of women in the village were not cleaning their houses, something which contributed to diseases. To me, environment is everything and has a big contribution to children health," she says, lauding ActionAid Tanzania and other players for coming up with the project that has changed women's mindsets.

Abdi Juma, a 24-year-old farmer also expresses his satisfaction over the project, saying before the project, villagers were very difficult, people were eating one meal per day, stunting rate was very high, food was very few and low dietary diversity and farmers have a little knowledge, there was high levels of gender inequality and high workloads for women.

"Right now my life has changed, I can eat two-three meals per day," he says.

During the implementation of the project, farmers were trained on agro ecological

methods, gender equality and nutrition issues as well received assorted varieties of legumes seed to plant in their farms.

Under the SNAP project, the smallholder farmers were trained by experts from ActionAid Tanzania, Cornell University, Nelson Mandela University and Ilonga Agricultural Research Institute on agro-ecology methods, gender equality and nutrition issues.

So far the project has provide room for villagers to enhance food security at household level, improve soil fertility in their farms, improved their lives and nutrition status of children at ly improved due to the legumes which they eat than in the past years.

Farmers were trained on how to make traditional pesticides to control pests that destroy their crops in farms and utilize it, process flours from different legumes and utilize it at home, improve nutrition status and set up extra small businesses to raise their income.

Some of the beneficiaries managed to build modern houses, purchase traditional carts for carrying water, food as additional business, raise food production and other issues.

IN East Africa, a region with some of the world's fastest-growing economies, six countries - Burundi, Kenya, Rwanda, South Sudan, Tanzania, and Uganda - are increasingly interconnected. Lower tariffs, freer movement of goods and people, and reduced bottlenecks such as restrictions on services, have helped many businesses expand operations.

In Kigali, Rwanda, for instance, business is booming for Bakhresa, a company that pro-

zania 44 vears ago, Bakhresa expanded its operations into Rwanda in 2010. Its entrance into the market lowered the price of wheat flour, making it an easily accessible commodity for all in Rwanda. The effects reverberated across the local economy as entrepreneurs prospered and jobs were created.

Hanifa Nyiragumuriza is a food vendor who lives in Kigali. Her workday begins shortly after sunset and ends only as the sun begins to rise over the lush hills of Rwanda's capital. Nyiragu-

duces wheat flour. Originally founded in Tan- muriza prepares steaming batches of chapatti and mandazi (doughnut-like pastries) throughout the early-morning hours to satisfy hungry workers finishing late-night shifts.

> The baked goods are a treat for her customers. For Nyiragumuriza, 52, and her family, they're a steady source of income that's helping build a better future. "This business has helped me pay school fees for my 10 children," says Nyiragumuriza, serving customers in her dimly lit food stall.

Today, flour is a key ingredient in the foods

on Nyiragumuriza's daily menu. But for many years this basic commodity was too costly for her - and most other street cooks in Rwanda.

Until recently, one company only controlled Rwanda's flour production and it couldn't meet the country's demand for wheat. Because of the lack of choice and high prices, flour was simply unaffordable for many food vendors like Nyiragumuriza, who would sell mainly vegetable- and meat-based dishes. "I sold fried potatoes, cassava, and chicken for many years, but their popularity was gradually waning, and

I had to think of new ways to get my customers

Bakhresa noticed that wheat was in short supply - and saw an opportunity to enter the Rwandan market.

Timing was everything. In 2011 the government of Rwanda had set up a special economic zone (SEZ) to encourage new businesses, and Bakhresa Rwanda was one of the first to set up: It established a subsidiary, Bakhresa Rwanda, in Kigali's SEZ.

## Eschewing politics of deception in Ethiopia

HERE is a broad consensus that party politics in Ethiopia, which dates close to half a century, has by and large been the anti-thesis of democracy. From left-leaning parties responsible for Red Terror, one of the darkest chapters in modern Ethiopian history, to the parties existing today the vast majority are alien to the fundamental principles of democracy.

Parties that live up to their name are wellsprings of policy alternatives; they are institutions articulating the views and interests of the public and the birth place of future leaders; they enable individuals and groups to pursue different political goals in an organized manner; they serve as platforms for the unfettered expression of diverse ideas; they are forums guided by a certain school of thought and course of action which gain acceptance after critical discourse; and they epitomize transparency and accountability. Are present-day parties prepared to embody these attributes? Do they possess the capacity eschew the politics of lies and deliver good governance. These and similar other questions demand an answer.

Though it's undeniable that political parties play a vital role in the process of democratization, the fact that over 100 registered parties are operating in Ethiopia has sparked an intense conversation. The merger of like-minded parties in recent weeks has given rise to hope that such consolidation will eventually result in the survival of a few strong parties and bodes well for the country and its people.

This said political parties of all stripes must first and foremost practice democracy internally. Preaching about democracy without living it first is the height of hypocrisy. It's an open secret that practically all parties are the personal properties of their founders or



leaders. Such a state of affairs needs to be fundamentally changed if they are to become democratic themselves and adopt a pragmatic program reflective of the reality on the ground. The journey to democracy cannot succeed with the usual politics of lies.

A party conversant with the tenets of democracy and is committed to their implementation continually strives to deepen the political consciousness of its members and keeps abreast of local and global developments to help it make the right decision; its door is always open to frank discussions so as to forge a unity of purpose and action among members; it institutes a transparent and accountable system which has no place for rumor-mongering, conniving and backbiting; it enlists professionals and researchers to generate policies and strategies that appeal to voters; and it engages in a deliberate effort to purge itself of outdated habits and takes up attitudes and action in keeping with the times.

This is instrumental in ensuring that

its members are informed, principled and set a positive example. Ethiopia has no need for ignorant parties that are intolerant of anyone who does not subscribe to their belief. An uninformed politician is akin to a rudderless ship. Sticking with the tired politics of deception is bound to rob one of credibility. A party lacking credibility can barely survive as a viable entity let alone accomplish

its objectives. These days the proponents of citizen politics and ethnic politics are engaged in animated discussions. It's sad and indeed a weakness to turn the differences between the two ideologies into an acrimonious battle. Isn't it possible to conduct a civilized dialogue among the advocates of both sides without name calling or labeling? Can't the divergence between them be accommodated democratically?

rival schools of thought need to become sources of intractable conflicts. As the public is the ultimate arbiter of which one it wants to go with the defenders of each camp ought to best the other with superior ideas.

It's impractical to engineer the hegemony of one of the ideologies but try wipe out the other. The objective conditions in Ethiopia now allow the free expression of all sorts of ideas.

Given the relatively broader political space prevailing in the country therefore resorting to bigotry is essentially not only undemocratic, but also irrational. Neither the public nor the nation has any use for parties which brandish democratic-sounding names but in practice reek of totalitarianism.

Ethiopia does not need a plethora of feeble political parties. The member parties of the ruling There is no reason why these Ethiopian Peoples' Revolutionary Democratic Front (EPRDF) and its allies are in preparations to form a single national party. Meanwhile, some seven parties merged last week to create a new national party and a further five parties did the same this week. The consolidation is expected to continue apace and in due course winnow down the number of parties to a

This goes a long way towards ridding Ethiopian politics of archaic attitudes and traditions and putting an end to the longrunning politics of deception perpetrated at the hand of parties comprised of cheats and selfserving individuals with an axe to grind. What Ethiopia needs are a few strong parties committed to serving the public, not a horde of weaklings that thump their chests whenever elections come around and disappear when they are over. If Ethiopia is to steer on the right path which benefits its people the politics of deception must be eschewed.

Ethiopia officially the Federal Democratic Republic of Ethiopia is a country in the Horn of Africa. It shares borders with Eritrea to the north, Djibouti to the northeast, Somalia to the east, Sudan and South Sudan to the west, and Kenya to the south. With over 102 million inhabitants, Ethiopia is the most populous landlocked country in the world and the second-most populous nation on the African continent. It occupies a total area of 1,100,000 square kilometres (420,000 sq mi), and its capital and largest city is Addis Ababa

Afroasiatic-speaking populations settled in the Horn region during the ensuing Neolithic era. In the first centuries AD, the Kingdom of Aksum maintained a unified civilization in the region, followed by the Ethiopian Empire circa 1137. During the late 19th-century Scramble for Africa, Ethiopia was one of two nations to retain its sovereignty from longterm colonialism by a European colonial power. Many newly-independent nations on the continent subsequently adopted its flag colours. The country was occupied by Italy in 1936 and became Italian Ethiopia (part of the Italian East Africa) until 1941. Ethiopia was also the first independent member from Africa of the 20thcentury League of Nations and the United Nations. In 1974, the Ethiopian monarchy under Haile Selassie was overthrown by the Derg, a communist military government backed by the Soviet Union. In 1987, the Derg established the People's Democratic Republic of Ethiopia, but it was overthrown in 1991 by the Ethiopian People's Revolutionary Democratic Front, which has been the ruling political coalition since.

Ethiopia and Eritrea use the ancient Ge'ez script, which is one of the oldest alphabets still in use in the world. The Ethiopian calendar, which is approximately seven years and three months behind the Gregorian calendar, co-exists alongside the Borana calendar. A majority of the population adheres to Christianity (mainly the Ethiopian Orthodox Tewahedo Church and P'ent'ay), whereas around a third follows Islam (primarily Sunni). The country is the site of the Migration to Abyssinia and the oldest Muslim settlement in Africa at Negash.

## Gap between rich and poor 'keeps growing'

THE gap between the rich and the poor keeps widening, the Organisation for Economic Cooperation and Development (OECD) says.

In its 34 member states, the richest 10 per cent of the population earn 9.6 times the income of the poorest 10 per

There is no standard measure of inequality, but most indicators suggest it slowed or fell during the financial crisis and is now growing again.

The OECD warns that such inequality is a threat to economic growth.

The report says this is partly because there is a wider gap in education in the most unequal countries, which leads to a less effective workforce.

OECD member states include most of the European Union as well as developed economies such as the US, Canada, Australia and Japan.

One of the factors that the OECD blames for growing inequality is the growth in what it calls non-standard work, which includes temporary contracts and self-employment.

The OECD says that since the mid-1990s more than half of all job creation in its member states has been in nonstandard work. It says that households dependent on such work have higher poverty rates than other households and that this has led to greater inequal-

It also says that tax and benefit systems have become less effective at redistributing income.

On the other hand it says that one of the factors limiting the growth in inequality has been the increasing number of women working.

The report says that one of the few areas where inequality has not been growing in the last 30 years has been Latin America, although levels of inequality were much higher there to start with.

The main theory the OECD puts forward for why inequality and growth are negatively correlated is that poorer people invest less in their own education and self improvement - which is why its main anti-inequality prescriptions are government investment in



promoting better quality jobs.

Strikingly it isn't saying that the best way to greater equality and faster growth is to soak the rich. Instead it wants activism focused on raising the living standards of the poorest, especially the poorest 40 per cent.

It calculates, therefore, that if living standards in the UK for poorer people were raised to the relative levels of France - that if so-called "bottom inequality" was reduced by half of a standard deviation (to use the jargon) - annual growth in national income or GDP would rise by 0.3 per cent every vear for 25 years.

That's not to be sniffed at. It would represent increasing our current growth rate by around 13 per cent.

One of the best-known commentators on inequality is Prof Joe Stiglitz from Columbia Business School. He told BBC News that the problem was not just with lack of training and education.

"What we've seen, particularly in the last 15 years, is that even those who are college graduates have seen their incomes stagnate. The real problem is the rules of the game are stacked for skills and education, and a focus on a the monopolists, the CEOs [chief executives] of corporations."

"CEOs today get pay that's roughly 300 times that of ordinary workers - it used to be 20 or 30 times. No increase in productivity justifies this change in relative compensation."

Behind the OECD averages there is a considerable range in the degrees of inequality in each country.

showing how well income is distributed across a country. A coefficient of zero would mean everybody was paid the same amount, while one would mean all the money was earned by one person.

The average across the OECD was 0.32. Chile had the highest at 0.50, indicating that income distribution there was the most unequal, while Denmark was the lowest at 0.25, making it the most equal.

The UK and US were both near the top of the rankings with coefficients of 0.35 and 0.40 respec-

tively. One of the report's authors,

Mark Pearson from the OECD, told BBC News: "It's not just income that we're seeing being very concentrated - you look at wealth and you find that the bottom 40 per cent of the population in rich countries have only 3 per cent of household wealth whereas the top 10 per cent have over half of household wealth."

"So that combination of both wealth and income being very The Gini coefficient is a figure concentrated, it means there is no equality of opportunity in many societies and that undermines our growth."

> Research from the Institute for Policy Studies found that in 2014, bonuses paid to Wall Street employees had been double the total annual pay earned by all Americans who worked full-time at the federal minimum wage.

I crunched the numbers and it turned out that the same was true for the UK.

But is this actually a good measure of inequality? If a load of people earning minimum wage suddenly received a pay rise then bonuses would become an even

greater multiple of minimum wage salaries.

One of the most commonly used measures of inequality is the Gini Coefficient, which gives countries a score between zero and one. A score of zero would mean that everybody in the country earned the same amount while one would indicate that all of the country's income was earned by one person. It can also be used to measure wealth inequality.

The Gini Coefficient is more than 100 years old now, and attention in inequality has been turning recently to measures that concentrate more on comparing extremes in the population - for example, looking at what proportion of wealth is held by the richest 1 per cent of the population and what proportion is held by the bottom 50 per cent.

Earlier in the year, Oxfam predicted that the combined wealth of the richest 1 per cent would overtake that of the other 99 per cent of people next year. There were problems with the way the charity extrapolated that conclu-

sion from previous years' figures, but the conclusion was not im-

The figures were based on some research by Credit Suisse, which estimated the distribution of wealth across global populations. A third way to think about inequality is in terms of poverty measured by relative incomes.

The Office for National Statistics (ONS) had figures out on Wednesday based on the definition that people were in poverty if their income was below 60 per cent of the median level (to find the median income, line up all the people in the country in order of income and take the middle one).

It found that almost a third of the UK population had experienced poverty in at least one of the years between 2010 and 2013, which is very high by European standards.

The OECD sets out a summary of what has happened to examples of all three of these measures. Across its 34 member countries, the Gini Coefficient rose gradually from 1996, fell slightly for the financial crisis and then resumed its upward path.

Relative-income poverty grew steadily over the period and a comparison of the top 10 per cent and bottom 10 per cent showed growing inequality that paused briefly for the financial crisis before accelerating.

So while there are a number of different ways of calculating inequality, each of which have their own strengths and weaknesses, they seem to agree that inequality has been growing in recent years.

But these measures tell us little about other inequalities such as health, education or opportuni-

## Uber not disclosing amount paid as drivers, appreciation rewards following listing in US

ASH payments given to Uber subscribed drivers in the country following the ride hailing company's listing in the US will not be disclosed due to contract privacy restrictions.

Nairobi based Uber Communications Manager for West ad Sub Sahara Africa, Francesca Uriri said in a written emailed response that although some local drivers received the bonus payments, contracts signed between the parties restrict disclosure.

"Due to global data privacy and protection laws, we are unable to share specifics of the driver appreciation rewards in Tanzania," Uriri said in the statement while responding to Smart Money's questions relating to the

"We fully remain committed to impacting the lives of driver-partners and riders in Tanzania," she added in her brief statement which also did not give numbers of drivers who have benefitted from the payments locally.

Soon after listing at New York Stock Exchange last month, Uber drivers globally received some cash payments as a result of the ride hailing company's share appreciation after listing with some \$300 million shared among them globally.

Uber member drivers in the US, Europe and South Africa received up to \$40,000 each in compensation after the listing. Some local

Uber drivers however said that they received payments

However, Uber South Africa has disclosed the figures of the money remitted in this way. The Uber based company had said in a statement in April that it would pay around \$300 million to its more than a million drivers worldwide.

"To acknowledge drivers who have participated in our success, we are paying a one-time cash driver appreciation reward to qualifying drivers in jurisdictions where we operate through owned operations," Uber South Africa said in a statement published late this April.

Uber drivers in the US received one of six different cash rewards based on the number of trips they have completed. Drivers received \$100 if they completed 2,500 trips by April 7th this year, up to \$40,000 for 40,000 trips. One of Uber's drivers in Dar es Salaam Abdallah Hafidhi (48) said he received 37,000/- through his mobile phone accompanied by a massage that indicated that the money was sent by his employer as an appreciation of his contribution to the company.

Shaban Juma (35) also said he received 54,000/- also through his mobile phone.

"I have worked for almost a year and without expecting, I received 54,000/- as a reward for working with Uber," Juma said. Uber Tanzania officials also rejected to give details of the payments.



## Kenya borrows Sh210bn in third **Eurobond loan**

KENYA has finally floated its planned third Eurobond issue, raising Sh210 billion (\$2.1 billion) in two tranches of seven and 12 years.

Treasury CS Henry Rotich said in a notice on Thursday that Kenya will pay interest at seven percent for the seven-year tranche and eight percent for the 12-year paper, although he did not disclose the split of the debt between the two tenors.

The bond was arranged by JPMorgan and Standard Chartered, and will be listed on the London Stock Exchange. A significant part of the money raised will go towards refinancing maturing debt, he said, with the rest meant to fill part of the budget deficit of Sh635.5 billion for the 2018/19 fiscal year.

"The proceeds from this issuance will be used to finance some of the development infrastructure projects, the general budgetary expenditure (in accordance with the applicable legal requirements) and to refinance part or all of the obligations outstanding under the \$750 million (Sh 75 billion-2014 Eurobond) due on June 24, 2019 and potentially part of the other debt obligations," said Mr Rotich in the notice.

External borrowing

Kenya's budget sets out external borrowing for the current fiscal year at Sh321 billion, part of which had already been met before Wednesday's Eurobond sale through bilateral loans and syndicated debt.

This is Kenya's third Eurobond. The country sold its debut \$2.75 billion (Sh275 billion) bond in June 2014 that

## **MTN Nigeria stock** jumps after listing

**LAGOS** 

MTN Nigeria made a big splash yesterday, when it finally listed on the Nigerian

It took just 16 minutes for the group's stock to jump 10% to 99 naira, from the listing price of 90 naira, which is the maximum possible move under Nigerian Stock Exchange rules, according to Bloomberg.

That values the telco at about two trillion naira (\$5.6 billion), making MTN Nigeria the second-biggest company on the NSE, after Dangote Cement and pushing Nestle Nigeria into third place.

The company's stock only traded for a short time on the bourse because a lengthy ceremony and speeches reportedly delayed the start of trade to 2:14pm local time, leaving only a brief window before the market closed for the day at 2:30pm.

The telco's stock on the Johannesburg Stock Exchange (JSE) ticked up 1.14% vesterday on the back of the Nigeria listing, closing trade at R100.65 per share.

The listing of MTN Nigeria Communications Plc also helped the Nigerian All-Share index to close on a slight gain yesterday. Nigerian stocks have been struggling lately and are down 9.5% this year, according to Bloomberg data. They were on track for their ninth straight day of losses until MTN Nigeria's shares began trading and the All-Share closed up 0.5%, its best performance in almost a month.

The MTN group owns almost 79% of the Nigerian business and has been planning to list the Nigerian operation on the Lagos stock exchange for almost three years. It is now doing so in two parts, the first of which took place yesterday to allow existing Nigerian investors, who previously traded over-the-counter, to now trade publicly

At a still unknown future date, MTN will also sell more shares to the public, as it reportedly looks to increase local ownership of MTN Nigeria from just over 19% currently, to around 35%.

However, first the company needs to sort out a \$2 billion tax row with Nigeria's attorney general, which according to Reuters, is delaying a further sale of shares and a public offering. A court case between MTN and the attorney general over the matter was first scheduled for 8 November 2018 but has since been postponed a number of times and is now set for 26 June.

The Central Bank of Nigeria in August 2018 demanded MTN repatriate \$8.1 billion to Nigeria, which the bank said the company had sent abroad in breach of foreign exchange regulations, which MTN denied. In December 2018, MTN agreed to make an almost \$53 million payment to resolve the dispute, without admission of liability.

MTN Nigeria accounts for a third of the Johannesburg-based group's core profit and the telco had 60.3 million subscribers in Nigeria at the end of March 2019. The telco recently announced its earnings for the first quarter of 2019, recording 13.4% growth in service revenue in Nigeria and a 32.4% increase in data revenue.

Back in 2016, the mobile giant promised to make a secondary listing on the NSE as soon as it was commercially and legally possible as part of a 330 billion naira fine settlement arrangement with the Federal Government of Nigeria. The settlement came after MTN was slapped with a 1.04 trillion naira fine by the Nigerian Communication Commission in October 2015 for failing to meet a deadline to disconnect 5.1 million unregistered SIM cards in Nigeria.

MTN's primary listing is in South Africa on the JSE, and in May 2018 it also floated a 35% stake in its Ghanaian business on the Ghana Stock Exchange



ALIBABA'S posted quarterly revenue and earnings that topped analyst estimates as personalised recommendations drive consumer spending across its shopping sites.

Revenue at China's biggest e-commerce company rose 51% to 93.5 billion yuan (\$13.6 billion) in the three months ended in March, above the 91.7 billion-yuan average of analysts' estimates compiled by

Adjusted earnings-per-share was 8.57 yuan, topping projections for

6.5 yuan. The Hangzhou-based company predicted revenue in recommendation-based the current financial year of more than 500 billion yuan, short of projections for 509 billion yuan.

Recommendations to users based on their preferences are now driving more sales than traditional search, boosting Alibaba's ability to provide targeted advertising for merchants on its main Taobao platform. That's helping the e-commerce operator generate more revenue at a time escalating US-Chinese tensions threaten to dampen the world's No. 2 economy.

"testing of advertising indicates monetisation will kick in soon, supporting faster earnings recovery," Binnie Wong, a Hong Kong-based analyst with HSBC, said in a report ahead of the results. The new features could help improve the conversion rate for merchants, Wong wrote.

Shares of Alibaba rose as much as 4% in pre-market trading in New York. The stock had gained 28% this year through Tuesday's close compared with an 13% gain for the S&P 500 Index. Earlier on

Wednesday, rival Tencent posted earnings that topped estimates even as revenue growth slowed to the lowest since its 2004 initial public offering.

Alibaba's full-year revenue rose 51% to 376.8 billion yuan, toward the bottom of its forecast range of 375-383 billion yuan. The core commerce business posted revenue of 78.9 billion yuan, a jump of 54%.

Alibaba's main shopping app Taobao started testing an ad product known as "super recommendations" in April,

## Modi's coalition will sweep to victory in India, exit polls show

PRIME Minister Narendra Modi's ruling coalition is poised for victory in India's general election, exit polls showed, which would give it another five years running the world's fastestgrowing major economy despite a jobs crisis and struggling rural sector.

The polls released on Sunday night showed his Bharatiya Janata Party-led National Democratic Alliance will win between 267 and 350 seats in India's 543-seat parliament, with most well above the 272-seat majority mark. The opposition Congress-led United Progressive Alliance coalition will win an estimated 82-132 seats, the polls forecast. Votes will be counted on May 23.

"If these predictions hold, the BJP will benefit in a big way in that it will have a strong electoral mandate and ample policy space to once again

#### Russia calls on BBC to press authorities for answers regarding Salisbury case

THE British Broadcasting Corporation (BBC) should press the country's authorities for answers in relation to the poisoning of Sergei and Yulia Skripal instead of making films about the Salisbury incident, the Russian embassy in Great Britain said on Twitter.

"Fully agree with The Sunday Times: rather than creating fiction films, the BBC would do better service to the public if they pressed authorities to provide answers and proofs of what actually happened in Salisbury," the embassy said, commenting on an article criticizing the BBC's plans to make "a two-part prestige drama about... the novichok poisonings in Salisbury."

According to London, former Russian military intelligence (GRU) Colonel Sergei Skripal, who had been convicted in Russia of spying for Great Britain and later swapped for Russian intelligence officers, and his daughter Yulia suffered the effects of an alleged nerve agent in the British city of Salisbury on March 4, 2018.

Claiming that the substance used in the attack had been a Novichok-class nerve agent developed in the Soviet Union, London rushed to accuse Russia of being involved in the incident.

Moscow rejected all of the United Kingdom's accusations. Chief Executive of the Defense Science and Technology Laboratory (DSTL) at Porton Down Gary Aitkenhead said later that British experts had been unable to identify the origin of the nerve agent used in the attack on the Skri-

On June 30, 2018, 44-year-old Dawn Sturgess and 45-yearold Charles Rowley were hospitalized in critical condition in the British town of Amesbury.

The Metropolitan Police claimed the two had been exposed to Novichok. Sturgess died on July 8, while Rowley was discharged from the hospital on July 20.

On September 5, 2018, British Prime Minister Theresa May told the country's parliament about the conclusions that investigators looking into the Salisbury incident had come to, saying that two Russians, believed to be GRU agents, were suspected of conspiracy to murder the Skripals. The Metropolitan Police published the suspects' photos, saying their names were Alexander Petrov and Ruslan

STARBUCKS has opened a "silent cafe" in Guangzhou, where about half of the staff are people with hearing loss, as part of an initiative to support the employment of people with disabilities.

"This might be the quietest Starbucks of over 3,800 shops on the Chinese mainland," said Leo Tsoi, chief operating officer of Starbucks China.

Fourteen of the 30 staff at the shop, located in Yuexiu district and officially opened over the weekend, are hearing impaired. The shop has a speciallydesigned ordering system that allows people to place orders without saying a

For example, all the drinks and food are numbered to facilitate the ordering, and customers can

also choose to write down their specific needs.

"We cannot hear you but would like to share a tasty coffee with you," said Chen Siting, who works at the store. "I believe more people like me could find a career they are passionate about in the future."

Zhu Jieying, Starbucks' first coffee master with hearing loss in China, is among three of the hearing-impaired managers at the store.

Having worked for Starbucks for seven years, Zhu hopes the store could be a platform for people with disabilities to show themselves and explore more possibilities in their life.

"We hope this could be an opportunity to promote employment equality," said Fan Yitao, vice chairman of the China Association of the Deaf and Hard of Hear-Xinhua

## Algerian political parties call for negotiation to end crisis

POLITICAL parties and prominent persons in Algeria have announced proposals for edging further toward solving the political stalemate in the north African country following the resignation of former President Abdelaziz Bouteflika.

The majority of the proposals appear to reject the presidential election planned on July 4 while calling for the end of the current cabinet and the interim president to open the way for a transitional period of at least six months led by reliable personnel ahead of

organizing fair and free elections. The latest proposal was an-

nounced on Saturday by three figures, including former foreign minister Ahmed Taleb Ibrahimi, former leader of Algerian Human Rights League Ali Yahia Abdennour, and retired general Rachid Benyelles.

The three men signed a common statement urging the army to initiate dialogue with political parties, social forces, unions and representatives of the protest movement, in a bid to reach consensus to the crisis while meeting the aspirations that have been chanted for three months by the people.

The statement said that cancelling presidential polls of July 4 and instating a short term transi-



tion period are inevitable steps before enabling the people to practice their choice through free and fair elections to build democratic rule of law.

The proposal is likely to be adopted by the army given that the majority of the protesters have expressed their rejection to participate in July 4 election.

## Sweden requests detention order for WikiLeaks' Assange

#### **COPENHAGEN**

SWEDISH authorities yesterday issued a request for a detention order against WikiLeaks founder Julian Assange, who is now jailed in Britain, a Swedish prosecutor said.

Prosecutor Eva-Marie Persson says if the Swedish court decided to detain Assange "on probable cause suspected for rape ... I will issue a European Arrest Warrant."

The development sets up a possible future tug-of-war between Sweden and the United States over any extradition of Assange from Britain.

Assange was evicted last month from the Ecuadorian Embassy where he had been holed up with political asylum since 2012. He was then immediately arrested by British police on April 11 and is currently serving a 50week sentence in Britain for jumping bail in 2012.

The Australian secret-spiller also faces a US extradition warrant for allegedly conspiring to hack into a Pentagon computer.

Persson said yesterday that British authorities will decide any conflict between a European arrest warrant and US extradition request for Assange.

On May 13, Swedish prosecutors reopened a preliminary investigation against Assange, who visited Sweden in 2010, after two Swedish women said they were the victims of sex crimes committed by Assange.

While a case of alleged sexual misconduct against Assange in Sweden was dropped in 2017 when the statute of limitations expired, a rape allegation remains. Swedish authorities have had to shelf it because Assange was living at the embassy at the time

and there was no prospect of bringing him to Sweden.

The statute of limitations in the rape case expires in August next year. Assange has denied wrongdoing, asserting that the allegations were politically motivated and that the sex was consensual.

According to the request for a detention order obtained by The Associated Press, Assange is wanted for "intentionally having carried out an intercourse" with an unnamed woman "by unduly exploiting that she was in a helpless state because of sleep."

The request added there was "an aggravating circumstance" because Assange didn't use a condom.

The 47-year-old Australian met the two Swedish woman in connection with a lecture in August 2010 in Stockholm. One was involved in organizing an event for Sweden's center-left Social Democratic Party and offered to host Assange at her apartment. The other was in the audience.

A police officer who heard the women's accounts decided there was reason to suspect they were victims of sex crimes and handed the case to a prosecutor. Neither of the alleged victims has been named publicly.

Assange faces a maximum of four years in prison in Sweden if he is convicted of the rape.

Persson said the day and time for the detention hearing regarding Assange at the Uppsala District Court north of Stockholm that will make the decision has not yet been decided.

"However, in my view, the Swedish case can proceed concurrently with the proceedings in the UK," Persson said in a statement.

#### Russian embassy in US ready to organise briefing on arms control for US congressmen

#### **WASHINGTON**

RUSSIA'S embassy in the United States has said that it is ready to organize a briefing for US lawmakers on issues of arms control, disarmament and non-proliferation of weapons of mass destruction.

The statement came as a response to the criticism voiced by US Senator Robert Menendez of Under Secretary for Arms Control and International Security Andrea Thompson's speech at a Senate committee hearing.

"You'll have to ask Russia', is a pretty incredible response from a Senior State Department official about the Trump Administration's views on Russia's nuclear capabilities.

The Senate Foreign Relations Committee needs answers so we can make informed policy decisions," Menendez wrote on his official Twitter account on Wednesday.

"Senator Menendez, we are ready to organize a background briefing on Arms Control, Non-Proliferation, Disarmament, INF (Intermediate-Range Nuclear Forces) Treaty and New START (Strategic Arms Reduction Treaty) for the US senators, congresswomen, congressmen, staffers.

Russia and the US have special responsibility for strategic stability and security," the Russian embassy wrote on its official Twitter account.

#### China backs Huawei as tech giant says security updates to continue

CHINA'S Foreign Ministry yesterday voiced support for Chinese enterprises to defend their legitimate rights following Google's partial suspension of Huawei services, while Huawei Technologies Co said all its existing products will still get security updates and support.

Foreign Ministry spokesperson Lu Kang said: "We have read reports and noted that Google has suspended business with Huawei requiring the transfer of hardware, software and technical services and suspended the provision of relevant services to Huawei."

"We will formally confirm this matter and follow the development of the situation. At the same time, China supports Chinese enterprises to take up legal arms to defend their legitimate rights," Lu added.

In a statement, Huawei said that it will continue to provide security updates and after-sales services to all its existing Huawei and Honor brand smartphone and tablet products, covering those that have been sold and that are still in stock globally.

Alphabet Inc's Google confirmed on Monday that it has restricted Huawei's access to updates of its Android operating system and some mobile services as it complies with the US

ban on Huawei.

Huawei said it has made substantial contributions to the development and growth of Android around the world.

"As one of Android's key global partners, we have worked closely with their open-source platform to develop an ecosystem that has benefited both users and the industry," Huawei said in a statement.

"We will continue to build a safe and sustainable software ecosystem, in order to provide the best experience for all users globally," the Chinese technology giant said in a state-

## As US-Iran tension simmers, rocket fired near Iraq's US Embassy

#### **BAGHDAD**

A ROCKET was fired into the Iraqi capital Baghdad's heavily fortified Green Zone, which houses government buildings and diplomatic missions, on Sunday night, falling near the U.S. Embassy but causing no casualties, the Iraqi military said.

The attack came two weeks after U.S. Secretary of State Mike Pompeo warned Iraqi leaders during a surprise visit to Baghdad that if they failed to keep in check Iran-backed militias, which are expanding their power in Iraq and now form part of its security apparatus, the United States would respond with force.

His visit came after U.S. intelligence showed Iran-backed Shi'ite militias positioning rockets near bases housing U.S. forces, according to two Iraqi security sources.

A U.S. State Department official noted that there had so far been no claim of responsibility, and that no U.S.-inhabited facility was impacted.

"But, we take this incident very seriously," the official said. "We will hold Iran responsible if any such attacks are conducted by its proxy militia forces or elements of such forces, and will respond to Iran accordingly."

The Iraq military said the Katyusha rocket fell in the middle of the Green Zone, near the Monument of the Unknown Soldier.

The monument lies in open ground about half a kilometer (a third of a mile) north of the sprawling, riverside U.S. Embassy compound. The blast was heard across central Baghdad, according to Reuters witnesses and residents. The embassy in Baghdad and U.S. consulate in the Iraqi Kurdish regional capital Erbil has already evacuated non-emergency staff, out of apparent

concern about perceived threats from Iran. Iran's Iraqi allies rushed to condemn the attack and stressed that a war between Tehran and Washington would be bad for Baghdad and the whole region.

Militia leader and politician Hadi al-Ameri, whose electoral block holds the second largest number of seats in Iraqi's parliament, urged Iraqis in a statement overnight "not to be the fire that fuels this war" that would "burn everyone".

His sentiment was echoed by Qais al-Khazali, another prominent Iranbacked militia leader, who tweeted that a war would be neither in Washington's nor in Tehran's interests.

#### **IRAN-U.S. TENSION**

Tensions between Washington and its Gulf Arab allies on one side and Tehran and its proxies in the region on the other, have been flaring for weeks.

On Sunday, U.S. President Donald

#### Sudan's military council resumes talks with protesters

#### **KHARTOUM**

SUDAN'S ruling military council resumed meetings with protesters on Sunday to discuss the country's political transition after talks were halted for three days while roads were cleared outside the main sit-in in the capital, Khartoum.

The two sides have held several rounds of talks since the military overthrew President Omar al-Bashir last month, ending his 30-year reign after four months of mass protests and sitins, which are still underway.

The deputy head of the military council, Gen Mohammed Hamdan Dagalo, better known as Hemedti, meanwhile said late Saturday that security forces have arrested those behind an attack on the protesters last week that killed at least five people, including an army officer. Both the military and the protesters had blamed the attack on al-Bashir loyalists.

"The assailants who opened fire (on protesters) have been caught. Their confessions will be broadcast on TV," said Dagalo, who heads the paramilitary Rapid Support Forces.

He hailed the Forces for the Declaration of Freedom and Change, which represents the protesters, for their role in al-Bashir's military overthrow

"We want the democracy they are talking about. We want a real democracy, fair and free elections. Whoever the Sudanese choose will rule," he

The military council had called for the roads outside the sit-in in front of the military's headquarters in Khartoum to be opened. The protesters appear to have

agreed to the demand, as the roads were cleared without incident on Thursday.

The protesters also agreed to open the railway that crosses the area of the sit-in for five hours a day.

## Superstitions lead to killing of 11 tigers in India's central state since 2018

THE police in India's central state of Madhya Pradesh are learnt to have found out that people belonging to the tribal community allegedly killed as many as 11 tigers over the past one year for superstitious reasons, an English daily reported yesterday.

The police arrested as many as 19 tribals who during interrogation revealed that they offered body parts of big cats to their deities under the superstition that the practice would ward off the evils from their homes and lives, and bring in good fortune.

"Body parts of the big cats, like claws, teeth and whiskers, were being offered to local deities in the superstitious belief that they would help ward off the evil eye, improve health and bring prosperity," the English daily Hindustan Times quoted the officials of the Wildlife Department as saying.

#### Major pan-African institutions crafting guideline on land-ethnicity-conflict nexus in Africa

#### **ADDIS ABABA**

THE African Union (AU), the United Nations Economic Commission for Africa (ECA), and the African Development Bank (AfDB) are jointly crafting guidelines addressing the nexus between land, ethnicity and conflict in Africa.

The three major pan-African institutions recently brought together African land-policy experts to develop the guidelines under the leadership of the Afri-

can Land Policy Center (ALPC), a tripartite consortium composed of the three continental organizations, the ECA said in a statement on Sunday.

"It is expected that the guidelines will offer insights into land policy reforms by addressing ethnic dimensions to land, the different types of conflicts, how to mitigate them and the best ways of securing land rights in order to build peaceful and cohesive communities," the state-

According to the ECA, the guidelines "will be used by governments, land policy reform institutions, peace builders, researchers, and ordinary citizens" to address ethnic dimensions to land as well as the compounding different forms of

African experts, who were recently in Kenya's capital Nairobi, developed guidelines on land and ethnicity conflict in the African continent, the statement

"The guidelines are expected to support the implementation of inclusive land policies and land governance practices as key factors in conflict prevention, peace building and sustainable development," it said.

Joan Kagwanja, coordinator of the AU-ECA-AfDB joint initiative, commended "the commitment of African professionals to develop homegrown guidelines to prevent and address landrelated conflicts in Africa," the statement said.

"Violent land-related conflicts in Africa are often caused by competition over access to and use of land and other natural resources," Kagwanja noted. "Once the guidelines are endorsed by the African Union, they will serve the needs of many stakeholders who are engaged in developing policies and implementing land reforms at continental, regional, national and sub-national levels," she

## **English clubs sitting pretty** atop European football

WHAT an absolutely extraordinary football season it has been for English clubs in European football!

Indeed, such was the breathtakingly epic scale of the dominance enjoyed by English outfits over the two foremost tournaments on the European football patch: the moneyspinning UEFA Champions League and its lesser cousin the Europa League that it has doubtlessly set tongues a-wagging in earnest right around the globe.

In case you are just awakening from a pleasantly lengthy slumber like a certain famous fictional character in Rip van Winkle, perhaps a brief recap of what I have been alluding to thus far is in order.

A few weeks ago, four high-flying sides from England's top flight rewrote the history books in the Champions League and Europa

The first two English clubs to soar to hitherto unexplored heights were Liverpool and Tottenham Hotspurs.

Indeed, after coming through decidedly tricky and arduous semi-finals unscathed, both Liverpool and Spurs advanced to the final of the UEFA Champions League, which, as is well known, is arguably the most cherished and lucrative football championship in global football.

This admirable football feat achieved by both the Reds (Liverpool's nickname) and Spurs marked the very first time since 2008 when there would be an all-English final in the much coveted UEFA Champions League.

However, the aristocratic outfits of English football were not done yet with their impeccable exertions on the European

Just as English fans were preparing to launch themselves into unconstrained revelry, Chelsea and Arsenal soon gave them many more reasons to engage in merrymaking with abandon.

Indeed, in what seemed like a scene straight out of a blockbuster movie in which the underdog triumphs somehow against

impossible odds. Both Chelsea and Arsenal overcame their respective semi-final opponents to progress

to the Europa League final. Brilliantly, it marked the first time in history that there would be an all-English final in

the Europa League, which despite being admittedly the second tier championship of European football, has nevertheless still seen its stock rise higher and higher with each passing season.

Needless to say, the blazing of the glory trail by these four EPL heavyweights: Spurs, Arsenal, Liverpool, and Chelsea has left millions of football fans globally scratching their heads in complete befuddlement.

Indeed, with a who's who of respected and prominent football commentators both inside and beyond the country scrambling frantically to find answers, which can help to

explain this fantastically rewarding.

European football campaign for the muchtouted sides of the EPL whose exceptional exploits are the heart of this commentary, I, myself, would like to hold court on this issue

Looking back, I recall a particular time during the EPL's ascension to the very top of the popularity stakes when there was such a loud outcry from EPL stakeholders about the fact that only precious few English youngsters were being given the opportunity to rise up through the ranks at the really mammothsized outfits of the EPL such as the Arsenals, Manchester United and Spurs et al.

No action was taken at all until this outcry had reached such a crescendo, which is when the Football Association (FA) of England felt compelled to act.

Following somber deliberations upon this weighty issue, the FA created a law, which mandated that each club in the EPL should have a certain number of English youngsters training at their academies.

This specific rule would prove to be especially significant later on as we shall

However, at the time that the rule was created, stakeholders were pleased that it would provide talented English youngsters with the golden opportunity to break into the first team of all EPL sides.

Zooming forward to the present-day, we can already see that the rich fruits of this F.A policy change are being reaped at both the youth and senior levels of English football.

You might ask, Dear Reader, why on earth would I mention English youth football in connection with the main theme of this discussion.

Well, merely two years ago, England's U-17 national team triumphed at the FIFA U-17 World Cup and hot on the heels of that historic victory, the England U-20 national team also carted home the trophy at the FIFA U-20 World Cup!

Indeed, yet more evidence of the positive move taken by the F.A a long time ago came last year during the World Cup in Russia when the England national team were able to progress to the semifinals of the tournament for the first time since 1990.

Strikingly too, the senior England team that featured so quintessentially at last year's World Cup benefited from the valuable contributions of young talents such as Raheem Sterling, Ross Barclay and defender Chris Smalling among others.

This all brings me to the present-day when four English clubs have succeeded in wowing the global football fraternity.

Granted, it may be difficult to determine the exact impact of that FA policy change so long ago.

Nonetheless, I reckon that the F.A's ruling in question must have helped in some ways to usher in these last three years of arguably unprecedented success for English clubs and for the England's senior national team.

BROOKS Koepka has gone from being an afterthought to the most dominant player in golf over the last two years, the quiet assassin who speaks softly but carries a big stick.

Among still active players, only Tiger Woods (15) and Phil Mickelson

beat most of them, and then from there (five) have clocked up more.

"Phenomenal," said Koepka. "It's been a hell of a run. I'm trying not to let it stop. I mean, four of eight, I like the way that sounds."

While Koepka is back in the spotlight after his latest feat, he feels his performances over the past two years have not received the accolades they deserved.

"I get Tiger was back, so it's a little bit different," he said, referring to Woods' Masters victory in April that ended a decade-long major drought.

"It was just at a point where I'd felt like if other players had done that, it would have been a way bigger deal.

"But I think you've got to find a chip (on your shoulder) or you've got to find something to motivate yourself and give you that extra little something going into a tournament or going into an event, whatever it might be, to really want to push you over that

## Kompany to leave Man City and join Anderlecht as player-manager

LONDON

BELGIAN defender Vincent Kompany said on Sunday he would be leaving Manchester City and joining Anderlecht as player-manager after helping the Premier League club to become the first team to win the English domestic treble.

Club captain Kompany, 33, leaves having won four Premier League titles, two FA Cups and four League Cups with City. He played 360 matches in all competitions and scored 20 goals.

"We've just seen the close of an incredible season. My 11th as a Blue. I cannot believe I'm writing this but... also my last as a Blue," the City captain wrote in an open letter to fans on his Facebook page (www.facebook.com/pg/vincentkompany/).

"Man City has given me everything. I've tried to give back as much as I possibly could. How often does someone get the chance to end such an important chapter, representing a club with such great history and tradition, in such a great fashion?"

"The time has come for me to go

The central defender said in the second part of his letter released shortly afterwards that he would be taking on a new challenge at Belgian club Anderlecht.

"I choose to be grateful for the past but remain ambitious and driven for the future. For the next three years, I will take up the role of player-manager of RSC Anderlecht," he added

"It's the most passionate yet rational decision I've ever made. As a footballer, I was born and raised at Anderlecht. Since the age of six, I have been one with that club. A history of 34 league titles, they are second to none.

"I want to share my knowledge with the next purple generations. With that, I will also put a bit of Manchester in the heart of Belgium."

City crushed Watford 6-0 in the

FA Cup final on Saturday to complete the unprecedented treble of league championship and both domestic cups, after which Kompany said they were the best team in the world.

Kompany scored with a thunderous long-range strike to decide their penultimate league match of the season against Leicester City, a key moment in their retaining the Premier League title.

"It's cliche to say it but it's also so true: without my team mates I would have never been here today," he added

"We fought many battles together. Side by side. In good times and in bad. So to all of you, from the 2008-2009 squad to today's domestic Treble winners: I owe you guys!

"A special word also to (manager)
Pep (Guardiola) and the backroom
staff: you've been superb. You've
followed me through so much
hardship. You made me come back
stronger every time. Thank you so

City midfielder Kevin de Bruyne led the tributes for his compatriot, describing Kompany as a "big player, big personality and big leader" in

Youngster Phil Foden wrote on Instagram: "Looked after me from day one. Led by example, showed everyone what it means to be a leader, wear their heart on the sleeve and give everything for this club."

Club chairman Khaldoon Al Mubarak said that Kompany was the "lifeblood, the soul, and beating heart" of City.

"There have been many important contributors to Manchester City's renaissance, but arguably none are more important than Vincent Kompany," he added.

"A booming voice in the dressing room yet a quiet and measured ambassador off it, Vincent can be as proud of himself as we are of him."

### Kylian Mbappe issues PSG ultimatum at Ligue 1 awards

PARIS

PARIS Saint-Germain's Kylian Mbappe has called his future with the French champions into question after he won the National Union of Professional Footballers' (UNFP) Ligue 1 Player and Young Player of the Year awards on Sunday.

The France international has 32 goals and six assists from 28 matches this season and still has one final Championnat match left to prevent Barcelona's Lionel Messi from winning the Golden Shoe by overcoming a four-goal deficit.

Mbappe, still just 20, beat off competition from the likes of teammates Neymar, who was absent from the ceremony, for the senior prize -- he then made an even greater stir during his acceptance speech.

"I think that it is a very important moment for me as I feel that I am approaching a first, or second, turning point in my career," said the former Monaco man. "I have discovered a lot of things here and I feel that it is perhaps time for greater responsibility.

"I hope that it will be with PSG, which would be with great pleasure, or maybe elsewhere with a new project. However, I would like to say thank you."

Mbappe followed that up by explaining in a mixed zone for the award winners that he knew exactly what he was doing and intended to send "a message"

to send "a message."
"I said what I had to say," he said.

"When you are at such an important event, you can send messages -- I think that I sent mine.

"If I say more, it will become too much. It will not be the same and that is not the message that I want to send."

Mbappe also added that he felt that it was the right moment for him to say what he said just after his double-prize success.

"If I say more, I think that it will be going too far," he said. "I said what I had to say at the ceremony.

"No, there was no hesitation -- I think that it was the right moment for me to say it. I am somebody committed, so when I say something, I believe it. It was the right moment, so I said it."

Mbappe is one of the youngest players to win the Player of the Year award, while his young player title is his third consecutive in that category.

The Frenchman also made it into the best XI for the season alongside teammates Neymar, Angel Di Maria, Marco Verratti, Thiago Silva and Marquinhos.

Elsewhere, PSG coach Thomas Tuchel was beaten to Coach of the Year by Lille's Christophe Galtier, as LOSC's Parisien-raised Mike Maignan also came out on top of Alphonse Areola in the goalkeeper

Lille's Loic Remy took Goal of the Season, while Real Madrid's Karim Benzema was voted best Frenchman playing abroad.

# Inside Man City's stunning season: How Pep Guardiola & Co. won the treble

LONDON

IT is never easy to put history into context just as it's being made, so it may be many more years before the real magnitude of Manchester City's domestic Treble can be properly judged. But by inflicting a 6-0 defeat on Watford in the FA Cup final on Saturday, Pep Guardiola's City achieved what no men's club has done before by winning the Premier League, FA Cup and Carabao Cup in the same season. However you feel about it, their place in history is certainly assured.

Saturday's Cup final win against Javi Gracia's team was City's 50th victory of the campaign, in their 61st game, and they took their goals tally to 169 and equalling Bury's 116-year record for the biggest-ever FA Cup final winning margin in the process. It's clear that the record books are in need of some rewriting.

English football has produced some iconic sides over the years -- the Double winners at Arsenal, Tottenham and Liverpool, or the Treble winners (Champions League, Premier League and FA Cup) at Manchester United -- but City's class of 2019 are now in the same bracket as those illustrious greats of yesteryear.

With the club currently being investigated by UEFA and Premier League for alleged financial fair play transgressions, and similar probes being carried out by FIFA and the Football Association due to allegations of wrongdoing in the signing of underage players, City's achievements may yet be tainted depending on the outcome of those investigations. But as Guardiola said last week, the club is "innocent until proven guilty" and their success this season can only be judged by what we know now.

While the domestic treble is the greatest achievements in the club's history (so far), it is by no means a story that only began in the days after last summer's World Cup, when the players returned to the Etihad to be told by Guardiola that they had to meet the challenge of defending the Premier League title.

The reality is that this season's success began as far back as the summer of 2015, 12 months before Guardiola took charge of the club. At that point, he was preparing for the third year of his contract at Bayern Munich, yet sources have told ESPN FC that Raheem Sterling completed his £49 million move from Liverpool to Manchester City that summer after being told how highly he was rated by Guardiola.

Kevin De Bruyne was another who made the move to City in 2015, with the Belgian leaving Wolfsburg for the Etihad because of the prospect of working with Guardiola a year later. In short, the building blocks have been carefully laid over recent years in order to put City in the position that they are now in.

Players were signed and staff were recruited -- Guardiola's assistant coach, Rodolfo Borrell, the man who nurtured Lionel Messi, Cesc Fabregas and Andres Iniesta as a youth team coach at Barcelona, was hired as far back as March 2014 -- as every effort was made by the City hierarchy to make the club ready for Guardiola,



whom they'd been attempting to hire since his departure from Barcelona in 2012.

Year 1 at City was turbulent under Guardiola, with the club finishing third in the league and ending the season without silverware. But huge recruitment in the summer of 2017, which saw the key arrivals of Kyle Walker, Benjamin Mendy, Ederson and Bernardo Silva, sparked the incredible run to the 2017-18 Premier League title, which was won by amassing a record 100 points.

All of the above is the backstory to the tale of this season's success. A long-term project, with improvements every year, culminating in a campaign that has seen City sweep the board domestically: they even called themselves the "fourmidables" and counted the Community Shield, won against Chelsea last August, as part of their haul.

The Carabao Cup was won against Chelsea in February after a penalty shoot-out victory at Wembley, while City held off Liverpool's spirited challenge in the Premier League to emerge as champions with 98 points -- the second-highest total in league history behind last year's 100-point mark. On the way to winning the Premier League, City had more goals (95), shots (683), passes (26,581) and touches (33,593) than any of their rivals, and they also won more games. Liverpool pushed them hard, but City were unstoppable in the end.

So how did Guardiola drive his players on to become the first team since Manchester United, in 2009, to retain the title, but also clean up in every other competition in England?

When Sir Alex Ferguson guided United to the club's first title in 26 years back in 1993, he walked into the dressing room at the start of the following season and told his squad he had three envelopes containing the names of those players he believed would let him down by resting on their laurels.

Whether those envelope existed or not, it proved to be a motivational masterstroke, with United going on to win a league and FA Cup Double that season, also reaching the EFL Cup final, as his players proved to their manager that they had the hunger and desire to build on their previous success.

There were no envelopes for Guardiola, but there was a key preseason moment when he made it clear that he expected last season to be merely a staging post to greater things rather than a high watermark.

"People say now we have to forget what we did last season," Guardiola said last summer. "No way. I don't want to forget what we have done last season. I know exactly what we did to achieve that, and that is where we start from.

"That's the basic principle. Now, when I say something to them [the players], they know exactly what we have to do. We will have bad moments, but at a club where you win titles, winning another one helps for the future. It is impossible to win titles if you just have quality players—if they believe their quality is enough, then you cannot win—not even a friendly game."

And City's players work hard. Driven by Guardiola to train at all times of the day -- City train in the evenings before night games to prepare their minds and bodies, such is the manager's determination to have every detail covered -- their levels of fitness continue to leave opponents stunned. One player who has faced City over the past two season told ESPN FC that Guardiola's players "kill you with the ball, but they also run as hard in the last 10 minutes as the first."

It all stems from Guardiola. When Mendy turned up late for treatment on his injured metatarsal last September, after spending the previous night in London watching a world title boxing fight, the French defender was told to stay away from the training ground for a week by a furious Guardiola, who was determined to deliver a message to both Mendy and the rest of his squad that he expected full focus and commitment from every player. Kyle Walker, the full-back whose power down the right flank has been crucial to City since his arrival from Tottenham two years ago, attributes the team's success to Guardiola's character.

"Intense" is how the England international describes the City manager, while captain Vincent Kompany admitted after the title-clinching win at Brighton last week that Guardiola's demanding personality is why City have be-

come serial winners

"He starts everything off," Kompany said. "He sets the standards. If he is too nice, we don't go and win back-to-back titles, but I knew we could do that, straightaway.

"The first meeting of the season, it was all about trying to get back-to-back [league titles]. He had done it before [at Barcelona and Bayern Munich], and I felt we could do it from the first moment. I felt the desire."

City's domestic record during 2018-19, with the team winning 32 of their 38 league games, suggests a serene run to success, but there have been blips along the way. And while the 9-0 Carabao Cup win against Burton and 7-0 Champions League victory against Schalke point to the ruthlessness of Guardiola and his players, the league defeats against Crystal Palace and Leicester, and the loss at Newcastle in January, say more about their qualities.

After the back-to-back defeats against Palace and Leicester, City steadied the ship and then earned the ultimately decisive 2-1 win at home to Liverpool in January that reduced the gap to Jurgen Klopp's team to four points. A defeat would have left City trailing by 10, but the loss at Newcastle three weeks later was the pivotal moment

From that moment on, City didn't drop a point in the Premier League, but it was only after Guardiola issued a rallying call in a training session the day after the defeat against Rafael Benitez's team. He was convinced that Liverpool would drop points, but told his players that they couldn't afford more slip-ups if they were to challenge Klopp's side.

"We spoke in the last [few] days," Guardiola said at the time. "We didn't recognise our team. They know it, they felt the same way in the last game against Newcastle." The Newcastle defeat was a line in the sand. From then on, City won every Premier League game -- 14 on the spin -- to beat Liverpool to the title.

The Champions League proved elusive, with Spurs edging an epic quarterfinal on away goals after a 4-4 aggregate draw, but Guardiola refocused his players by calling for one last, winning surge in the league and cup. Sergio Aguero's goal then crossed the line by millimetres in a 1-0 win at Burnley, and Kompany netted a stunner from 35 yards in another tight 1-0 victory against Leicester as City held their nerve in the face of incessant pressure from Liverpool.

Man City just rolled on, fighting back from a goal down to clinch the title with a 4-1 win at Brighton, before ending the season in emphatic fashion against Watford, making more history on the way. It was ruthless and brutal at times, but City have become a winning juggernaut thanks to Guardiola.

The concern for the rest is that he will be back next season, demanding more from his players. Only a fool would dare suggest that he won't manage to take City to even greater heights.

## Robben and Ribery's status as Bayern legends assured, but are they irreplaceable?

FOR one final time, the most important duo of wingers in Bayern Munich's history graced the Allianz Arena pitch and scored as second-half substitutes in a 5-1 win over Frankfurt to help the club to a seventh consecutive Bundesliga title. Then they showed everyone how much they differed as characters after the game.

Whereas Franck Ribery was overcome with emotions and broke down in tears in front of the Sudkurve stand, Arjen Robben bemoaned not finding the net for a second time in a TV interview -- it would have been his 100th Bundesliga goal -- and admitted that he had done everything to get one last run-out before his farewell.

"It was important to me to play one more time, I was totally up for the game," said the 35-year-old, who had missed most of the campaign with a series of injuries. They didn't call him "ego shooter" for nothing in the local tabloids.

Even as all of Munich was swept up in nostalgia as the end of a decade dominated by his and Ribery's spell-binding brilliance, Robben retained his own perspective: first person, first and foremost. The Dutchman's self-obsessed outlook, nigh-pathological commitment in training and single-mindedness on the pitch neatly mirrored Bayern's win-at-all-cost philosophy and hard-nosed professionalism.

However, the crowd found it easier to connect with Ribery: an uncontrollable, complicated bundle made up of roughedged genius, warrior-attitude and puerile humour. Scarred by an accident in his childhood, the Frenchman was an unashamed anti-hero who embraced adversity and made other people's derision work



in his favour. Defenders and fans of rival clubs hated him, which only made Bayern supporters love him all the more.

Club president Uli Hoeness, his biggest fan, cried in the VIP area after the 36-year-old's irresistible solo run for the Bayern's fourth goal on Saturday. "Someone up there wrote the script today," Hoeness said, adding that "Rib und Rob" (Abendzeitung) should be seen as Bayern all-time greats among Gerd Muller, Franz Beckenbauer, et al

Their place in the club's pantheon of superstar icons is indeed assured. The duo did not just magically combine to produce the most crucial goal in Bayern's recent history—the 2-1 winner over Borussia Dortmund in the Champions League final in 2013—they were also instrumental in lifting the Bundesliga behemoths back to the spheres of the European elite after a few years in the second-rank doldrums.

Ribery's pacy, unpredictable style immediately added another dimension to final third attacks after his €25 million transfer

from Marseille in 2007. A couple of years later, Louis van Gaal's insistence on balance saw Robben arrive from Real Madrid for around the same price. Seen as big risk because of his persistent injury problems, the Bedum-born Flügelstürmer (winger) was an instant sensation, providing inverse wingplay class on a level which had not been seen in Germany's top flight for quite some time.

A combined tally of 185 league goals has gone some way to help Bayern win eight Bundesliga titles in 10 seasons. Their deepest impact, however, was on the team's identity. Germany's most successful side had traditionally relied on dominant players in the centre: sweepers, all-action box-to-box specialists and powerful centre-forwards. Robben and Ribery made Bayern's game lateral.

Attacking space and defenders with the ball on their feet, they set off tremors of panic in the opposition and excitement in the stadium; a rush that echoed football's pre-modern roots as a gallant battle of individual dribblers hell-bent on making inroads into enemy territory.

The new-found emphasis on wing-play begot a more structural approach in mid-field which now had to provide defensive cover and a regular supply of passes to the dangermen out-wide. Thanks to "Robbery"'s domineering influence, the team's all-important metamorphosis into a position-possession team was both smooth and inevitable. The final step to Champions League-winning excellence was made when they started working much harder to hunt down the ball and protect their full-backs at the beginning of the 2012-13 treble-winning

In recent years, Robben and Ribery were no longer able to perform consistently

in line with their gigantic wages and pronounced self-importance; the club's regression since coach Pep Guardiola's departure in 2016, can partially be explained by the duo's waning powers to make a difference against top opposition.

Hoeness himself came close to admitting that the club's reluctance to let them go earlier could have cost Bayern the championship this season. The dressing room will certainly feel a lot more spacious following the departure of the two super-sized egos, but Kingsley Coman and Serge Gnabry, their heirs-apparent, will do well to get close to their sustained levels of mastery.

"Back in the day, I used to watch them on YouTube; learning from them has been amazing," Gnabry told ESPN recently.

The Germany international, 23, has closely watched the veterans' positioning and taken a cue from their relentlessness in front of the box. "They are always on the attack," he added. "They don't ever shy away from an opportunity to go one against one. Whereas I would have said to [myself] before that you sometimes have to go back [with the ball], they helped me to just go again and again, saying that 'eventually, you will break through' [the defence.] Mentalitywise, they have defined an era here. Just to be around them has been been brilliant."

If Bayern are to get back to the world-beating heights of the first half of the decade, the successors to the most devastating doubleact since Paul Breitner and Karl-Heinz Rummenigge in the early 1980s must become nothing less than world-beaters, too.

That's a tall order, though, and explains why Saturday's title-celebrations were tinged with sadness -- perhaps even fear. Robben and Ribery might well prove irreplaceable.
