Govt readying universal insurance rules, key fund

Many of these issues stem from employers prioritizing profit over the well-being of their workforce, which ultimately undermines employees' ability to deliver productive services and achieve desired outcomes

THE government is finalizing regulations for the Universal Health Insurance legislation to facilitate its effective implementation, including the setting up of fund to support vulnerable groups.

Ridhiwani Kikwete, the Labour, Youth, Employment and Persons with Disabilities state minister in the Prime Minister's Office (PMO) made this observation at the launch of the HIV/AIDS and non-communicable diseases (NCD) workplace policy guidelines for private sector employers over the weekend in Dar es Salaam.

The guidelines were prepared by the Association of Employers Tanzania (ATE) in partnership with various stakeholders, including the International Labour Organization (ILO),

Stressing the importance of health for all, he said that the government enacted laws during fiscal 2023/24 to improve access to quality health services, an initiative geared to provide equitable healthcare access for

Those most at risk of being marginalized are especially targeted, as by establishing a sustainable framework for universal health coverage, the government is committed to reducing health disparities, he said.

It focuses on improving overall public health and enhancing the well-being of every individual in the country," he said, affirming that the guidelines are vital for employees facing health challenges that hinder their performance.

Chinese firm ready for ten Dar city ring roads

THE government is holding talks with a Chinese company that has expressed interest to invest upwards of \$1bn in a city traffic decongesting project slated for Dar es Salaam city centre.

David Kafulila, the Treasury executive director for publicprivate partnership (PPP) said at a weekend press confer-

ence that the China Overseas he stated. Engineering Group Co. Ltd. (COVEC) is expected to build outer and inner ring roads in the commercial capital under the PPP mode.

COVEC has made an informal expression of interest to the government to invest in an infrastructure project of the sort, where a pre-feasibility study for the proposed project has already been completed,

The investor is requesting a memorandum of understanding (MoU) with the government to complete a full feasibility study for the project, with tentative project capital expenditures (CAPEX) cost pegged at about \$1bn, he stat-

Voice, data SIM cards' 5.4 pc rise last quarter

REGISTERED person-to-person SIM cards increased from 76.6m to 80.7m in the three months ending September, reflecting a 5.0 per cent rise, the regulator says.

The Tanzania Communications Regulatory Authority (TCRA) says in its latest quarterly communication statistics report that "mobile and fixed-line subscriptions across five telecom companies" rose from 75.6m to 79.6m, equivalent to a 5.4 per cent increase during the period, a 1.7 per cent increase on average,

Machine-to-machine SIM cards, receiving data on cellular networks, grew from 995,494 to 1.02m, representing a 4.8% increase, it said, indicating that Dar es Salaam had 14.8m SIM cards in use, with Mwanza a



Organic seed production sufficiency 'on the horizon' We are now producing 78.6 percent of ker-

TANZANIA is inching towards self-sufficiency in seed production as it now growa79 percent of kernels used in the farm sector.

Enock Chimagu, the ministerial director of crop development, made this observation at the launch of an expansion project for the Enza Zadenorganic seeds farm here over the weekend.

The firm is an outfit which de-

nels used in the country, as we produced *71,356 tons of seeds during fiscal 2023/2024* velops quality kernels for export,

hosting the ministerial executive who affirmed that dependency on imported seeds was being reduced each year.

"We are now producing 78.6 percent of kernels used in the country, as we produced 71,356 tons of seeds during fiscal

2023/2024," he said, underlining that spearheading horticulture was a priority, as a reliable vehicle for agricultural development

Stanislaus Nyong'o, the Planning and Investment state deputy minister in the President's Office, stated that since horticulture is a

big employer for women and the youth, it is appropriate for boosting exports and ensuring the country's food security.

Horticulture production grows at the rate of 11 percent annually, while the entire agricultural sector moves at the rate of 12 percent, he stated, citing data that horticulture export value stood at 668.7bn/- from 175,000 tons of produce shipped overseas during the period. A total of 340bn/- was earned from horticultural exports for 2021, he said.

Enza Zaden, a Netherlands firm is a vegetable-breeding outfit taking up over 30 new vegetable varieties, including lettuce, sweet peppers, tomatoes, cucumbers and onions. The firm employs more than 400 people, mostly women and youth, officials said.

Wiebe de Boer, the resident Dutch ambassador, hailed the firm as an exemplary Dutch company doing the country proud

Arusha was third with 4.9m, Mbeya showing 4.6m and Dodoma indicating 4.3m registered SIM cards.

North Unguja had 73,743 SIM cards, South Unguja elevated at 110,970 and South Pemba shoeing 124,472 SIM cards, are regions showing the fewest registration of cards, the report noted.

There was a ten per cent annual growth rate in the number of SIM cards and a nine percent annual increase in the penetration rate of SIM cards among the population, it said.

Penetration reached 111 per cent by end of last year, where for every 10 residents, there were 11 SIM cards, with phone costs remaining largely unchanged, it said.

The cost of making calls within and outside networks, local SMS, international SMS, and data hovering at the same cost levels.

Call charges for East Africa decreased by 2.0 per cent while charges for other countries increased by 4.00 per cent, which analysts say it implies cost recovery for reducing sensitive EAC inward calls, by augmenting costs for less sensitive calls.

All service providers charge 30/- per minute for calls within and outside the network, except Halotel, which charges 10/- per minute within the network and 20/- outside the network.

"The average voice service rates within a network for the quarter ending September 2024 remained as in the quarter ending June 2024. International voice service rates varied among providers, with the average voice service rate per minute for East Africa standing at 696./68 and 1,948.22 for other countries," the report said.

July 2024 recorded the highest number of voice minutes compared to other months in that quarter with 41.1bn minutes used in the quarter ending September 2024, compared to 39.6bn minutes in the quarter ending June 2024.

However, the number of minutes within the network was higher within each network on average compared to those outside the network in the quarter ending June 2024, it added.

Ever-shifting political alliances fuelled Kenya's impeachment saga

LOSING a deputy just two years after being elected on a joint ticket could be seen as a big blow for a president, but not this time in Kenya.

As soon as Rigathi Gachagua was seen to be undermining William Ruto, he moved swiftly to remove his second-in-command.

He had seen for himself how a rift between Kenya's top two can lead to government dysfunction after he had fallen out with his former boss Uhuru Kenyatta.

The unprecedented political changes in Kenya, played out on live television, may have looked orderly and seamless to the outside observer.

The process of impeachment has had many following with interest as the two houses of parliament, the courts and finally the executive appeared to carry out their roles following a carefully prescribed legal process.

But to many Kenyans, it has been a rollercoaster that elicited strong views from across the country.

There was initially a sense of betrayal and disappointment especially from Gachagua's home region of Mount Kenya, but by Friday morning this was replaced by a sense of acceptance as the man chosen to replace him, Kithure Kindiki, is from the same region.

Mount Kenya played a big role in Ruto's defeat of former Prime Minister Raila Odinga in the closely fought 2022 presidential election.

Odinga was running with a powerful former Justice Minister, Martha Karua, who hails from the region, and backed by Kenyatta, the then outgoing president, also from

But in the event, Ruto, with Gach-

agua on board, won by a landslide in that part of the country.

For context, Kenyan politics is largely driven by regional - some would say ethnic - blocs and Mount Kenya carries about a quarter of the country's votes

It is no surprise that three of the five presidents since independence - Jomo Kenyatta, Mwai Kibaki and Uhuru Kenyatta - came from the region. This is why the two front-runners in the last presidential election Ruto and Odinga - chose running mates from there, as they were both from elsewhere in the country.

Upsetting the region could therefore be political suicide for a president in his first term.

But Gachagua's attempts to consolidate his hold on the bloc actually proved to be his undoing.

He was accused by parliament of, among other things, promoting ethnically divisive politics when he was expected to be a national unifier.

He coined the phrase "usiguse mlima", which means "don't touch the mountain", fashioning himself as a fierce defender of the Mount Kenya region and a gateway to it.

Clips were played during the impeachment proceedings which showed him suggesting that the government would prioritise those areas that had voted for the winning ticket, although Ruto had also made similar statements.

Legislators from other areas passionately condemned such sentiments.

Ruto remained silent as his deputy was taken through the impeachment, despite pleas for the president's intervention, including even asking for forgiveness "if he [Gachagua] had wronged" him.

There was a very recent precedent of the chaos caused when a president and his deputy fall out.

During Kenyatta's second term, Ruto, then deputy president himself, complained of being sidelined and persecuted.

The victim card endeared him to many, including in the then president's own political backyard.

But he needed more than sympathy to win the 2022 presidential election - he had to choose his running mate from Mount Kenya.

While many expected the president to pick his long-time ally, law professor Kithure Kindiki, Ruto pulled a surprise move when he chose to go for the then one-term member of parliament Rigathi

Gachagua. Kindiki was already well known in Kenya, having served as deputy speaker before being removed from the post in a purge instigated by

Kenyatta against Ruto's allies. MPs in Ruto's party voted overwhelmingly for Kindiki, three times they said, when he sought their involvement in picking a running mate. Gachagua came second but was, in the end, Ruto's choice.

The replacement, therefore, does not come as a surprise.

That he comes from "the mountain", albeit one of its smaller ethnic groups, has helped to calm the feelings of anger and betrayal.

Many locals who spoke on television have been calling for acceptance of the president's choice to avoid dividing the region.

This is what it all boils down to - forging ahead with the next elections barely three years away.

But it will no doubt still dent the president's support in Mount Kenya.

The success of this process has also relied heavily on Ruto's new alliance with his bitter enemy from the last election, Odinga, whose MPs and senators voted overwhelmingly to remove Gachagua from office.

JK: Julius Nyerere Leadership School symbol of unity in Tanzania, beyond

FORMER President Jakaya Kikwete has said that establishing the Mwalimu Julius Nyerere Leadership School (MJNLS) represents a symbol of unity in the country, Africa and beyond.

He made the observation at the weekend here during a commemorative dialogue in honour of Mwalimu Julius Nyerere, the founding father of Tanzania and a prominent advocate for African liberation.

According to him, the aims is to bring together former African liberation movements that, in solidarity, shed blood to fight for the liberation of countries such as Angola, Zimbabwe, Namibia, South Africa and Mozambique.

Kikwete noted that the ruling parties of the aforementioned nations such as Angola's FRELIMO, Zimbabwe's ZANU(PF), Namibia's SWAPO, and South Africa's ANC operated from Tanzania for an extended period, benefiting from its political and military support.

"For those unaware, FRELIMO was established in Dar es Salaam on June 25, 1962 following Mwalimu Nyerere's diplomatic efforts to unify three nascent Mozambican political move-

ments seeking Tanzania's assistance in their fight for independence," he said. He named the three movements that came together to form FRELIMO as the Mozambican African National Union (MANU), the National Democratic Union of Mozambique (UDE-NAMO) and the National African Union of Independent Mozambique (UNAMI) with Dr Eduardo Mondlane as the elected president.

He further illustrated the profound Pan-African cooperation between Tanzania's then-ruling party, the Tanganyika African National Union (TANU) which merged with Zanzibar's Afro-Shiraz Party (ASP) in 1977 to form Chama cha Mapinduzi (CCM) and various liberation movements.

He said that Tanzania provided its territory and military expertise for training the movements' military

"We began with Mozambique's FRELIMO whose fighters were trained at various camps in Kongwa, Dodoma Region and as far south as Mgagao in Iringa with FRELIMO's operational headquarters at the historic Farm 17 in Nachingwea, Lindi Region. This location was ideal for training, logistics, and deploying FRELIMO fighters to Mozambique," he said.

He highlighted the strategic cooperation among the MPLA, ZAN-UPF, SWAPO, ANC, FRELIMO, CCM and the Communist Party of China (CPC) during the liberation struggle from the 1960s to the late 1980s. He pointed out that the current national armies in Zimbabwe, Angola, South Africa, Mozambique and Namibia were all trained in Tanzania.

"A good number of their soldiers speak Kiswahili, the language used during their training by Tanzania People's Defence Force (TPDF) at various training camps," he said, adding that the CPC also collaborated with TPDF in supporting liberation movements across the region.

"In light of this rich history of collaboration among TANU (later CCM), MPLA, SWAPO, ZANUPF, ANC and the CPC, we recognized the urgent need to establish an institution that fosters unity despite our different national contexts. Thus, alongside retired South African President Thabo Mbeki, we initiated the creation of the Mwalimu Julius Nyerere Leadership School, named after this remarkable son of Africa," he said.

He outlined two primary objectives of the school: to serve as an archive for the history of the African

liberation struggle and to provide training for leaders from the six parties, supported by the CPC to govern as they envisioned during their fight for independence.

The event, themed 'Mwalimu Nyerere and the Liberation Movements: Reflections on Solidarity, Leadership, Pan-Africanism and African Unity' featured nine presentations.

Topics included 'Mwalimu Nyerere's Role in the Liberation Struggle' by Col (rtd) Joseph Simbakalia and 'The Role of Ideological Education in Preserving Nyerere's Legacy' by Dr Charles Mubita, a member of SWAPO's Central Committee.

Zimbabwe National Army Commander Lieutenant General Anselem Nhamo Sanyatwe presented on 'Challenges and Opportunities in Upholding Nverere's Vision: Perspectives from the Six Sister Parties'.

Prof. Palamagamba Kabudi moderated the international dialogue which also included a presentation by veteran politician Stephen Wassira, a member of CCM's Central Committee on 'Nyerere's Vision for Africa's Economic Self-Reliance'.

Kikwete appeals for stronger clean cooking crusade to protect forests

RIDHIWANI Kikwete. Minister of State in the Prime Minister's Office (Labor, Youth, Employment and Persons with Disabilities) has underscored the need for enhanced clean cooking campaign to protect both people's health and forests.

Kikwete who is legislator for Chalinze Constituency raised the mater, stating that 88 percent of charcoal used in Dar es Salaam comes from his constituency in Coast Region.

He spoke at the weekend in an event to handover 200 gas cylinders and stoves to nurses who care for mothers with premature babies at Chalinze District Hospital. He said the gas cylinders provided by Onyx Gas Tanzania Limited in collaboration with the Doris Mollel Foundation, would enable beneficaring for the mothers instead of spending hours collecting firewood in the bush.

Kikwete acknowledged the significant contribution in supporting the government's efforts to promote clean cooking energy.

"Our nurses will now have enough time to take care of mothers with premature babies in our hospital. One could spend hours cooking with firewood and charcoal, but using gas requires time," he said.

He said the stakeholders are not only support the government's initiative to promote clean cooking energy but also help protect ing clean cooking energy the environment as people

no longer have to go to the forests for firewood.

He highlighted that ciaries to spend more time over the past four years, 88 percent of the charcoal supplied to Dar es Salaam come from Chalinze, prompting the need for special patrols to monitor activities inside the Wami Mbiki Conservation Area where most of trees are cut for charcoal.

> "We are working closely with authorities in the Wami Mbiki Conservation Area to ensure protection of the environment," he said.

> Alice Mwakatika, Project Manager at Doris Mollel Foundation, said that in collaboration with Oryx, they distributed gas cylinders to nurses with the goal of promotwhich is a global cam

paign that has received strong support from President Samia Suluhu Hassan.

"We have given these cylinders to nurses because we know they spend a lot of time with patients, especially mothers. Our focus is on maternal and child health. Many of the nurses are midwives taking care of babies in the wards. They will become ambassadors of clean energy as they share the importance of clean energy with pregnant women and other patients," she said.

Gabriela Mtwale, Chief Nurse at Chalinze District Hospital expressed gratitude for the gas cylinders, promising to continue educating patients on the importance of using cleaner energy.

Ngorongoro relocations: Tanzania rebuffs existence of 'ancestral land'

TANZANIA has reiterated its position that all tribes in the country possess equal rights under the law and that no tribe holds greater rights than another.

This comes after some people raised concerns about the relocation of people from Ngorongoro Conservation Area (NCA) as abuse against indigenous people.

Prof Hamis Malebo, Executive Secretary for the National Commission for the United Nations Educational, Scientific and Cultural Organization (UNESCO), made the clarification during the 79th session of the United Nations General Assembly while responding to a report by the Special Rapporteur on Indigenous

During a session of the Third Committee on Indigenous Peoples' Issues. Special Rapporteur José Francisco Calí Tzav raised concerns about the relocation of people within Tanzania.

Prof Malebo asserted that Tanzania does not recognize the existence of ancestral land, tribal land or customary land, emphasising that the information presented by the rapporteur did not align with Tanzania's domestic laws, leading to potential misrepresentation.

He also noted that the rapporteur's discussion on land and indigenous peoples overlooked the sovereignty of member states. "Why address land ownership issues while ignoring relevant

domestic laws?" he questioned. He stressed that, according to Tanzania's law, the concepts of ancestral land, tribal land, or customary land does not apply. He urged the rapporteur and the international community to recognize that these matters are absent in Tanzania's legal framework. He further explained that the recent developments in the Ngorongoro area involve voluntary relocations, facilitated by community education, allowing residents to consent and register voluntarily for the move to support conservation efforts.

He reminded attendees of the significance of the Serengeti-Mara ecosystem, the last remaining wildlife migration system in the world.

Prof. Malebo highlighted that Tanzania comprises 31 administrative regions with 26 on the mainland and five in Zanzibar. According to the constitution and laws of the country, any tribe is free to reside anywhere in Tanzania.

He used the Maasai tribe as an example, noting that they inhabit 22 regions, making up 71 percent of all regions in Tanzania, where they maintain their pastoral and cultural lifestyles.

He emphasized that Tanzania's current land policy grants citizens the right to access and own land anywhere, ensuring their constitutional right to travel and reside freely. This policy has fostered a culture of peace and harmony among Tanzanians.

Prof Malebo invited the special rapporteur to visit Tanzania, specifically Kilimanjaro, Serengeti, Ngorongoro and Zanzibar to witness coexistence of over 120 tribes living together in harmony. 'School feeding scheme elevates academic performance in Meatu'

THE introduction of a school feeding initiative in Meatu District, Simiyu Region, has led to notable improvements in academic performance among pupils.

Addressing a news conference at the weekend here, Meatu District Commissioner Fauzia Ngatumbura highlighted the positive impact of the programme, noting a significant reduction of absenteeism since its introduction.

"We are very grateful to our donors for offering meals at no cost and we also appreciate the parents who contribute additional food," she said.

The feedback from pupils, parents and teachers has been positive.

Zuhura Ntandu, head teacher at Mshikamano B Primary School said that the initiative has resulted in increased academic performance and decreased absenteeism.

"Pupils are more focused and no longer skip school due to hunger. Their attentiveness in class has greatly improved," she

At Mshikamano B Primary School, 427 out of 1,022 pupils receive meals, and Ntandu anticipates that the number will grow. She called on other donors and businesses to support similar school feeding programmes.

Rameki Mboje, a parent shared his experience of contributing food for his child, encouraging others to participate in the initiative.

"Our school lacks a sponsor but our contributions have positively influenced pupils' understanding and engagement," he said.

Leah Silasi, a pupil at Mshikamano Primary School, said that the meals help enhance exam performance by improving focus in class.

At Makao Primary School, a total of 856 pupils benefit from free meals provided daily through a project funded by the Friedkin Conservation Fund via Mwiba Holdings Ltd which allocates approximately 20.5m/per month.

Aurelia Mtui, Community Development Projects Manager at Friedkin Tanzania, said that they have also constructed a modern kitchen for the school at a cost of 28.1m/and implemented a rainwater harvesting project valued at 30.8m/-.

Minister calls on cooperatives to transact business with new bank

AGRICULTURE minister Hussein Bashe has encouraged cooperative societies under his ministry to take full advantage of growing financial sector in the country to transact business.

Bashe (pictured) made the call here at the weekend when officiating at the newly-formed Co-operative Bank of Tanzania (CBT) shareholders annual general meeting.

He tasked the Registrar of Cooperatives to ensure all agricultural transactions, including cashewnut sales in southern regions, are managed



through CBT which seeks to expand its reach with branches currently in Moshi and Tandahimba and new branches scheduled to open in Dodoma and Tabora.

Bashe also pledged that the government will make sure all money go through CBT as the main trading bank for all crops dealers and cooperative societies.

According to the minister, during 2024/25 fiscal year, projected payments for cashewnut farmers alone is expected to be 1.2trn/- while combined input expenditure for lead cash crops: tobacco, Cashewnut and cotton stand at over 620bn/- and between 800bn/-900bn/- to be generated out of cash crops exports.

"These staggering figures prove that CBT has a strong business platform. An important point to note is that the transactions will be under CBT trade domain as no single crop buyer will be licenced without operating a main transactions account with CBT," he

In August this year the government approved a total of 5bn/- to be made available to CBT from state coffers to enable the bank meet the Bank of Tanzania regulatory requirements as by the time it had no sufficient liquidity to launch its operations.

Dar residents commend NIDA for customer service centre upgrade

DAR ES SALAAM residents have lauded National Identification Authority (NIDA) for upgrading its customer service centre which now features updated hotline numbers designed to address inquiries more effectively.

They have welcomed the initiative, saying it is a significant step towards better customer engagement and satisfaction to reflect NIDA's commitment to addressing needs Tanzanians.

The commendations came few

days after NIDA announced the enhancements, including significant digital upgrades to the customer service centre and an increase in the number of service providers to reach a broader audience.

One of traders at Mabibo Market Yassin Chuma said NIDA's improvements enable Tanzanians to access their personal information being processed by the authority. He noted that for traders, particularly small business owners, the enhancements were timely due to the demand for NIDA numbers for various uses.

"This information comes at a crucial time when many people lack NIDA numbers or identification cards. The introduction of hotline will assist those who have not registered to reach out to service providers for guidance," he said.

Atupele Mwakalinga, a university student, said that the new NIDA hotline will significantly assist students to obtain loans from the Higher Education Students' Loans Board (HESLB) as having a NIDA number is one of the eligibility criteria for securing loans.

"Many students are unable to

obtain higher education loans due to lack of NIDA number or identification card. The introduction of this customer service hotline will help students acquire their NIDA numbers or identification cards, enabling them to access loans," Mwakalinga said.

Anna Msuya, a resident of Kigamboni, said that the improvements would be beneficial since some people do not have the time to visit the authority's offices, thus saving time and costs.

"Nowadays things are processed digitally. The enhancements at and this will help address various needs of citizens in a timely manner," she said.

Geofrey Tengeneza, NIDA spokesman and Head of Public Relations, recently said that they had launched an online registration system, allowing citizens to initiate registration process via website and enabling them to track status of their applications.

He added that the enhancements include changes to phone numbers, with the new contact number being 023221 0500 (TTCL) that

REA to spend 18bn/- electrifying 150 villages in Dodoma Region

Loopholes with sabotage or 'case dismissed' laws worth reviewing

BRIGHT ideas keep coming in with respect to efforts to enhance the level of the rule of law in our

Notably, the Law Reform Commission reports that it has identified several loopholes in eight laws, including those governing economic sabotage and organised

According to the Court of Appeal judge who chairs the commission, that aspect looks a bit unlikely to succeed. Reformers could try but, with its being a civic matter, it is problematic.

Where there is a better chance in law reform is in targeting rectification of rules somewhat freely used by law administrators, often in view of vested interests surfacing when law enforcement needs to be seen to have been done.

The law review panel's opinion, the absence of a dedicated body to manage and coordinate protection issues for informants and witnesses is compounded by inconsistencies between the protection regulations for informants and witnesses and relevant protective

While there are areas pointed out where review looks somewhat more practical, one may still worry about the background of some of the ideas, given that activists passionately yearn for the dismantling of customary law.

The fear more commonly surfaces when one hears of deficiencies in laws governing property and joint rights - not when it relates to companies and shares but in matrimonial property or suchlike. On the contrary, bail or compliance with legislation is less tied to customs but good offices.

Perhaps the most captivating of the panel's observations was in

relation to presumed shortcomings in applying the Criminal Procedure Act regarding the dismissal of court cases.

There are also issues relating to laws or the spirit of legislation governing penalties for offences. This is not to speak of awards in civil cases, how far those demands are consonant with equity, other than vengeful ruin of contentious adversaries.

A portion of civil society will be keen to hear what the panel has to say in connection with contentious issues noticed in maritime transport regulations, land transport and road transport in particu-

There have been persistent appeals to traffic police to exercise controls available under the law but for years these have not been sufficiently effective, as most fatal accidents occur in unguarded hours, where speeding is the norm. That is why civic parties are eagerly waiting to hear if someone says low penalties push accidents.

There was some optimism as the minister received the report, or listened to the presentation, but rightly cautioning that extensive and in-depth research was required to exhaustively labour the social appropriateness of suggested rectification.

That would also apply in view of what is expected in other laws, the spirit of laws - for instance, freedom liberty as opposed to a set of legal designations which everyone is supposed to obey as a citizen.

Laws aren't intended to ensure that everyone does the right thing as one often hears in passionate contributions, but rather acts without any malice or deliberate intent to harm, thus one is observant and not crushed by law.



Special Interview (II)

How to embrace the vital CEO role: A talk with physician Daniel Vasella

LEADERSHIP is never easy - not for nothing did Shakespeare write: "Uneasy lies the head that wears the

The top job can be hard indeed. The job of leader may seem even more imposing these days given a range of social, economic and geopolitical forces - both micro and macro. But amid the challenges, there is always the opportunity for growth. Indeed, as Novartis AG (Swiss multinational pharmaceutical corporation based in Basel, Switzerland) former chairman and CEO Daniel Vasella explains, leaders can take pleasure in competing - while honing the personal qualities needed to succeed in the role and rally an organisation.

Vasella has counselled hundreds of global CEOs through his involvement with McKinsey's Bower Forum and sits on a number of corporate boards. As a physician who has been recognized for his research on neglected diseases of the developing world and as a global executive, he has touted the importance of authenticity, vulnerability and a range of other "softer" attributes required to innovate and grow as a leader.

In this recent interview with Ramesh Srinivasan, a senior partner in McKinsey's New York office, Vasella discusses the challenges and opportunities for today's leaders and why being a CEO is still "the best job you can have". What follows is an edited version of their conversation:

Ramesh Srinivasan: It's true that many CEOs are gifted. At the same time, they have to be mentally, physically and emotionally fit to do such a complex and demanding job. How can they stay strong through the journey?

Overall, I would say that you don't get to that position if you don't have a certain level of resilience even before you become a CEO. So the first question is, how do you gain resilience? I think some is given by Mother Nature - your biology. But having gone through very tough periods and deep challenges, I also found that after the bad days come good days. Knowing that after the rain, the sun will appear again is a very important perspective that helps one become more resilient. A certain realistic optimism is helpful.

This reminds me of Jack Stafford, who was the CEO of American Home Products many years ago. When I became CEO, I went to see him. He had the reputation of being very experienced and tough. We talked about a lot of things, but one thing he said stuck in my mind. He said: "Dan, you can't trust anybody but your wife.'

That was a very stark viewpoint, but it wasn't entirely wrong. Family or other trusted confidantes become an important pillar of your stability because you can really be open with



be with others in an organisation, portant for leaders to develop, even if you have close allies. It's **and how can they use it to drive** important to remember that when you're in the CEO position, the day will come when you will leave that role, but your family and friends will remain.

Second, you need to give yourself quiet time so that you can reflect. For me, that meant thinking about a challenge and running through possible approaches for how to solve it. A rumination process can be productive. I went for long walks with my dogs, for example. This gave me time to think.

You've noted that having a diverse set of experiences can help leaders build resilience. Can you share examples of how this works and what it looks like whether in your own life or in the lives of other leaders you've worked with?

Yes, one simple example is working at a multinational company and being able to move around a bit. Living in different cultures with different beliefs and languages tends to open the mind. And even when you come back home, you can discover your own country in new ways.

That's a company example, but there is also the example of people being grounded in some topic or industry, knowledge-wise and capability-wise, that gives them a strong foundation for a career. Then they can add onto that various roles, various geographies. You may also become more innovative or creative because you look for alternatives you didn't think of before. At the same time, there can be disadvantages. If you move roles or companies a lot, maybe you're not as expert in one field or at one organisation as you might like to be. It's useful to realise that in any career, it's not possible to have everything. So you make choices - some planned and some unplanned.

We discuss empathy in our

culture and performance?

Empathy is critical for learning. You also need it in very specific moments. One may be confronted with a colleague who just lost a child or a spouse or who had an accident. These are moments when having the emotional understanding of what is going on in another person's life will help you address the situation in a much deeper and more supportive way. It's important to just be human.

Some people have more empathy than others. I tend to believe that these people have suffered more in life or have had experiences of suffering. They can imagine what goes on inside an organisation or, more specifically, inside an individual.

You may have empathy and decide not to act upon it and not to show it because you think it's not appropriate for various reasons. Or, as has happened to me frequently, you have to give negative news to someone. You can have empathy, and you can imagine how difficult it is for the person, yet you still have to do it. In my previous profession as a doctor, I sometimes had to reveal bad diagnoses to patients. It's always tough.

In an organisational context, you may have to tell someone his or her job is being eliminated in a restructuring. You must transmit this information while being attentive to the feelings of that person. At the same time, you can't lose the capacity to act despite your feelings of empathy. I think for CEOs generally, they should understand that acting with empathy, whether in routine circumstances or in crises, builds connections that can strengthen the organisation.

Let's talk a little bit about worklife balance. Do you think the workhorse mentality is changing, especially as younger generations move into the workforce?

I believe that things have changed to some degree. While younger people all work hard, they often don't view that as the right way to live their lives. They are much more oriented towards balancing work, life, and life at work.

My experience was very different. Being a physician, there was no question that one worked whenever one was needed. We had a day shift, a night shift, and a workday without pausing. That was a given. And that has changed. At least in Switzerland, the rules of the hospital have changed. When it comes to my children, they tell me that their lives don't just consist of work. They want their hobbies too. In the beginning, it was a bit difficult for me to understand, to be honest.

My oldest son is going to do a fellowship in reconstructive surgery. And he decided to stop working a few months before taking the new job. When he said he would take a sabbatical, I thought: "A sabbatical? Why?" He replied that it was a unique opportunity between two intense jobs to take some time off. I probably would never have done it, but then I realised it was totally

I can see that these are positive changes that can help people learn from a different set of circumstances and experiences. It will help them build a sustainable career as people live longer, healthier lives. I think the trend of younger people taking breaks, trying to have worklife balance and looking for different paths are all welcome changes.

What advice do you have for **CEOs trying to manage modern** organisations with so many demands and stakeholders?

First of all, my advice would be to enjoy it. Being a CEO is the best job you can have. It's a wonderful job, even with all the challenges and negatives.

My other advice relates to coaching. In the past, coaching was viewed as something that a leader might do if something went wrong. Not anymore. Having productive conversations with someone from outside the company is valuable. I see that at many organisations where the top executives all have coaches.

This is part of the broader idea of getting help. Leaders may have a yoga instructor or a therapist. These changes reflect how views of leadership are evolving, away from the classic authoritative type of leader to a more collaborative approach. Most recognize that we can use help and support. This shift also supports how Gen Z views leadership, and how it may evolve in the future. Continues on page 9

Invasive weeds now choking NCA could push the relocation initiative

WHILE strident efforts to get most residents of a specific zone in the Ngorongoro Conservation Area (NCA) may not be bearing fruit as much as most observers would wish see or hear, a new factor is being noticed.

Strictly speaking, it is not new, as invasive weeds threatening natural vegetation have been noticed in a number of areas in conservation areas within the northern tourism

Rather, the issue is how far or how quickly the Tanzania Forestry Research Institute (TAFORI) could address the challenges posed by these weeds

The government's wish is for TAFORI to collaborate with other authorities in assessing the situation within NCA and proposing effective ways to control the invasive

Given the way academic institutions operate, that looks not like a three-month task but a three-year assignment, which raises the problem of the sustainability of livestock in the area - if it is the wild variety or domesticated livestock that can

While academic and other authorities prepare to take to battle invaders tied up with resilience of some species in the face of climate change, other decision makers may have less of a choice to make if the weeds become rampant in habitual grazing areas.

It all depends on the intensity of invasion compared with what livestock in the area need for feeding and if livestock keepers have 'Plan B' under which they could purchase cattle feed from elsewhere meanwhile as scientists work on the 'snake grass', which could take

The wider issue is how far NCA, as a UNESCO world heritage site renowned for its stunning landscapes and rich biodiversity, might be under threat owing to these weeds.

While livestock keepers have some options if they have savings, it is hard to say if random bales of grass can be dropped for animal feed in particular instances if the weed invasion starts hampering ability to feed.

Nor is it feasible as large mammals have feeding capacity that no artificial input could possibly make up for, thus making weeds imitate drought, where the final solution is culling big mammals to stem the food imbalance. Those unable to exercise 'Plan B' would likely have no choice but to leave.

This bleak perspective is a little removed from the thrust of the midweek discussions in Arusha city focused on how an increase in innovative tourism strategies and effective management of natural resources could harvest from the area's potential to significantly enhance its contributions to our country's economy.

But climate change is also imposing bigger 'investment' outlays than was expected, if the conservation teams and academic colleagues start mapping what it may cost to take full control of destructive invasive weeds.

Nor are their civic part adversaries secluded from the soul searching, as they need to ponder if the supposed perfect alignment of livestock keeping with the natural environment hasn't added to the burdens nature faces, to the benefit of the weeds as a species. It could prove tricky and taxing coming up with a conclusive way out.

HE eco-schools programme helps raise an environmentally aware generation by embedding sustainable practices and environmental education into the everyday lives of pupils, teachers and communities.

In Tanga's Amani Division, Muheza District, Nature Tanzania with support from the USAID Tuhifadhi Maliasili (Preserve Natural Resources) project implemented the programme at six primary schools-Zigi, Kambai, Kwemdimu, Kwezitu, Antakae and Msasa IBC. The schools completed the seven-step eco-schools framework and awarded the green flag award.

The six schools around the Amani-Nilo Forest corridor received the internationally recognized green flag award-an internationally trusted sign of good environmental practices at their schools, showcasing the school's commitment to protecting the planet.

The seven steps include form an eco-committee to lead programmes, complete an environmental review of the school, prepare an action plan, linking the work to at least three areas of the curriculum learning, informing and getting others involved, monitor and evaluate the positive impacts of the projects as well as creating an eco-code, which is a call to action for all.

Through the programme pupils are encouraged to take an active role in environmental management within their schools. Eco-schools encourage students to involve their families and communities in environmental initiatives, thus extending environmental awareness beyond the classroom and promote collective responsibility in protecting the environment.

Gladness Masonda is the environmental teacher at Kwezitu Primary School, she said the school is proud of being among those involved in the programme as the school's environment has completely changed, having a greener look.

Before the programme, which was implemented by Nature Tanzania, the school's environment was poor with soil erosion taking place around buildings, she

"We were experiencing significant soil erosion almost all over the places surrounding our school; things started to change after receiving the programme and being educated on environmental conservation. The situation has changed completely as we have planted grasses to prevent erosion and improved the school's environment significantly," said Masonda.

"Now, no one dares to pass through the school grounds because the surroundings are well-maintained, and people feel ashamed to disturb it. We have also put in place rules to hold each other accountable when someone goes against what we are doing," said

Masonda added that apart from environmental conservation education, the project has also provided them with knowledge on beekeeping, adding they have been provided with 20 beehives, with 17 of them already occupied by bees.

Ramadhani Issa, is also a teacher at the school, he said the eco-school programme was highly beneficial to both the school and surrounding community. He wishes it could be expanded to more primary schools

across the country.

Issa emphasized that it helped children to understand the importance of environmental conservation at childhood.

The eco-schools programme connects students, teachers and local community, allowing them to come together in formal meetings aimed at enhancing conservation activities.

"Under the programme, each class selects two students as representatives. The community also selects two people whereas these four, together with two teachers, form a special committee that regularly meets to discuss the project," Issa explained.

Jackline Shetui, a Standard Six pupil at Kwezitu primary school and member of the eco-school committee, said the environmental education she acquired has helped her beboth at school and home.

Dastan Kajembe, another committee member representing Standard Four pupils expressed his excitement about the programme, promising to use the acquired knowledge to educate his fellow students on the importance of caring for the environment. He said caring for the environment has enormous benefits because humans depend on it to survive.

At Msasa IBC primary school, George Luena, who is the supervisor of the school's eco-school's programme said: "Our school was one of those experiencing soil erosion, thanks to Nature Tanzania for coming up with this good idea as the situation has changed.

He said pupils and teachers engaged fully in tree planting as well as growing grasses surrounding the soil erosion.

Luena noted that if they had not received the project in 2022, the school grounds would have been completely eroded by now.

"We normally receive a lot of rains annually which contributed to continuous soil erosion. Without taking these measures, the situation would have been worse," he said, adding under the programme, they have started a beekeeping project and have already placed 20 beehives on trees surrounding the school, 16 of which are occupied by bees.

Msasa IBC primary school Head Teacher, Barnaba Mloka, noted that despite challenges such as inadequate toilets, classrooms, desks, text books, and office buildings, the school's environment is being conserved accordingly.

When you talk about taking pleasure in the competition and in the CEO role, is that something that you felt you did from the start of your career? Or did it take a long time to feel that way?

I had that feeling right from the beginning, even in previous positions where I was not

As head of development, for example, it was fun and challenging to be faster at bringing new products to the market. I retained that feeling as I moved up the ranks.

In my CEO coaching now, we develop trusted one-on-one relationships that last months and often years. I see how very talented people take pleasure in most aspects of the job but still have things that bother them. In fact, the biggest challenges are often not about strategy or financial issues. Often it boils down to personal relationships - someone who is difficult on a team, or how and whether to confront someone or not.

Taking pleasure in the job is such an important concept. During the Olympic Games this summer, we saw how American gymnast Simone Biles worked through challenges. Facing and overcoming obstacles must make the medals so much more satisfying.

For CEOs, what drives satisfaction? What makes them want to stay in the role and improve their organisations? These are essential questions. I would say the answer is a mix of elements we've discussed: articulating a common purpose around which the organisation can rally, understanding oneself and what motivates one so that one can understand how to lead others, relying on family, friends, colleagues, and coaches for their views and support, being empathetic towards others, and asking for help when one needs it. And, finally, knowing that sometimes one will lose. But if one never loses, the game wouldn't be as interesting, right?

Tanzania on 'no one shall die of malaria' commitment

ANZANIA is among the 11 African countries which account for more than 70 percent of the global malaria burden. Others are Burkina Faso, Cameroon, the Democratic Republic of Congo (DRC), Ghana, Mali, Mozambique, Niger, Nigeria, Sudan and Ugan-

These countries have adopted a "high burden high impact" (HBHI) approach to malaria eradication. The ministers of health of these countries met in Yaoundé, Cameroon, on March 6, 2024 signed a declaration to accelerate a reduction in malaria mortality and pledged to hold each other and their countries accountable for the commitments outlined in the declaration they made in categorical terms "none shall die of malaria". The declaration was signed by then Minister for Health Ummy Mwalimu.

"We commit to a functional accountability mechanism through the establishment of digital platforms for tracking progress within our countries and on the continent. We endorse the need for an action plan and monitoring and evaluation framework as the basis of this accountability mechanism for the commitments outlined in this declara-

Recognising the progress made over the past years in responding to malaria and ending the disease in Africa, including the best practices on malaria elimination as recently witnessed in Cabo Verde (which has been certified by WHO as a malaria-free country this year), committed to concerted action to end malaria deaths.

The ministers of health did this by reinforcing the HBHI approach to sustainably and equitably address malaria by building on four pillars, namely 1) political will, 2) strategic use of information for action, 3) better technical guidance, and 4) coordination and two enabling platforms: functional national health systems and the adoption of a multisectoral approach.

They recalled Agenda 2063: 'The Africa We Want', a regional agenda for sustainable development published by the African Union, and Agenda 2030 for sustainable development, which calls on world leaders to end the epidemics of malaria and other communicable diseases by 2030 (SDG

During their meeting they acknowledged the urgency of addressing the root causes of this stagnation, such as changing ecology and vector behaviour, low access to and insufficient quality of health services, including genderrelated and financial barriers within households.

They also acknowledged global economic downturn and inadequate domestic funding, humanitarian crises, including conflicts, natural disasters and migration, climate change, and biological threats such as insecticide and drug resistance as well as emerging malaria vectors.



Subscribing to the fundamental principle that, despite the prevailing high case incidence, and declaring that "none shall die of malaria" in their countries, they said they stood united in their resolve to prevent every malaria-related death.

World Malaria Day 2024 with the theme "Accelerating the fight against malaria for a more equitable world" was marked on

"In 2022, there were 249 million malaria cases worldwide - 94 per cent of them in sub-Saharan Africa. Without access to treatment, these infections can be deadly. In malaria-endemic areas, families with children face the grim reality that their child may not survive a malaria infection. In 2022, 76 per cent of the 608,000 malaria deaths worldwide were in children under 5," says Malaria Results Report 2024 published by The Global Fund in Geneva, Switzerland.

The report suggests that to meet sustainable development goal (SDG) 3 target of ending malaria as a public health threat by 2030, countries aim at meeting global targets to reduce malaria case incidence and mortality rates by at least 90 per cent by 2030 compared to 2015 levels. "Malaria must also be eliminated in at least 35 countries, and a resurgence of malaria in all countries that are malaria-free must be prevented. The gap between these milestones and reality has been widening over the last several years."

At the local level, more public awareness is needed to eradicate malaria through community participation. During the first phase of government, there was a public awareness campaign on how to destroy malaria breeding sites. Schoolchildren as well as adults were made aware of how to

destroy malaria breeding sites like clearing tall grass near homes, covering water pools, as well as the use of mosquito nets to prevent mosquitoes causing malaria (female Anopheles mosquitoes) from spreading the disease. Malaria can be eradicated if community members are involved in the malaria eradication campaign.

Tanzanians should heed health experts' recommendations on how to prevent themselves from malaria bites and on the national malaria control programme. There are also personal initiatives (as additional efforts) that can help reduce malaria bites. Environmentalists suggest growing in our compounds natural mosquito repellent plants such as citronella and lemongrass, lavender, marigold, basil and lemon balm plants.

An open education resource shows that citronella and lemongrass' fragrance re-

pels mosquitoes. The plants can be planted in a garden or around the house. Lavender's calming scent is pleasant to humans, but deters mosquitoes and other insects. Marigold's strong scent can deter mosquitoes and other garden pests. A basil plant has a pungent smell. Its leaves are unpleasant to mosquitoes, making it a family's mosquito control strategy. Lemon balm is a great natural mosquito repellent as it produces a strong lemon scent that mosquitoes dislike.

As of January 12, 2024, there were five African countries which had been certified by World Health Organisation (WHO) as malaria-free with the year of certification in brackets: Algeria (2019), Cabo Verde (2024), Lesotho (malaria has never existed or disappeared without specific measures, 2012), Mauritius (1973) and Seychelles (malaria has never existed or disappeared without specific measures, 2012).

It's interesting to contrast this with the relationship between Labour and Conservative voting in the election. Their correlation was strong and negative (-0.54), indicating that they were clearly rivals. When Labour did well, the Conservatives did badly and vice versa. Rivals or allies? Constituency level votes

Why does the positive correlation show that Reform was an ally of the Conservatives in the election rather than a rival taking votes that would have gone to the Conservatives? The answer lies in the detail. The two parties did well in the same constituencies but appealed to different demographic groups within those constituencies. If they were campaigning for support in the same group of

voters they would be rivals, but for the most part they relied on support from different

This is illustrated in the chart below which looks at the social characteristics of constituencies using data from the 2021 census. It shows how different groups supported the two parties in the election.

The chart shows the correlations between the size of a particular group and voting for Reform and the Conservatives in the election. It looks at the 575 parliamentary constituencies in England and Wales, since the Scottish data is not yet available.

The relationships between constituency characteristics and voting in 2024

We observe large differences between support for the two parties among the different groups. For example, looking at the percentage of people in constituencies over

the age of 64, most of whom were retired, we see a big difference. There is a strong positive correlation between this measure and voting Conservative (0.45), indicating that the Tories did well among older people. The opposite is true for Reform, since the relationship is negative (although relatively weak at -0.17). Reform did not rely on older people's support in the same way as the Conservatives

A similar point can be made about the percentages who worked in professional and higher management occupations. The Tories did well in this group, whereas Reform did badly. Among constituencies with high levels of unemployment, the reverse was true. A high proportion of unemployed people boosted the Reform vote and undermined the Conservative vote.

If we look at ethnicity, a high proportion

of ethnically white people in constituencies helped Reform, but it weakened support for the Conservatives. This seems surprising at first sight until one remembers that many of them voted for Labour, the Liberal Democrats and Greens. The Tories lost a good proportion of the white vote in the election.

The census provided information about the numbers of people who had moved into constituencies from abroad in the previous year. Not surprisingly, given their anti-immigration positioning, large numbers of newly arrived migrants helped both parties, with Reform doing better in these areas than the Conservatives. That said, the correlations were modest and so did not play a large part in explaining the overall results.

Finally, the 2021 census asked people about their national identities and in this case there was an interesting difference

between respondents who claimed they were exclusively "English" rather than 'British' or some other identity. Englishness helped both parties, but it helped the Conservatives more than Reform. It appears that the Tories are more of an English National Party than Reform.

The next general election is a long way off, but these results mean that if the Labour government fails to deliver growth and curb illegal immigration, it will face a pincer movement from the Conservative and Reform. The Tories will pick up votes in constituencies with a high proportion of prosperous, middle class, retired people and Reform will pick up votes from deprived areas with high levels of young unemployed people.

WE want to choose our own representatives to hold them accountable. We cannot hold someone accountable whom we have not chosen; they will serve to satisfy the one who chose them, not us," says Nawaz Ahmed, an advocate with albinism who works tirelessly for

Her frustration stems from the current political system, where the easiest path for people with disabilities to secure a position in the House of Representatives is through special seats.

Special Seats are reserved for individuals from specific groups, such as women or people with disabilities, and are allocated based on the percentage of votes won in the general election.

This means that the winning party decides how many positions are set aside for these groups since it's almost impossible for individuals with disabilities to directly contest for those seats and succeed. This structure leaves little room for true representation, making it difficult to hold other elected representatives accountable.

"They end up serving the interests of those who put them lenges, the issue of underrepre-

According to the 2022 Population and Housing Census, Zanzibar has a total population of 1,889,773, of which 215,434 are people with disabilities, accounting for 11.4 percent.

Statistical data from the Office of the Chief Government Statistician (OCGS) Zanzibar for 2023 indicates that there are 8,100 people with disabilities aged 0 to 65 in Zanzibar, while there are 6,843 individuals aged 15 to 65.

This is a considerable portion of the population that requires equal representation in the political sphere, especially in the House of Representatives and the Parliament. Out of 76 members of the House of Representatives, only three seats are currently occupied by people with disabilities: two from special seats held by Mwantatu Mbaraka Khamis, who represents the CCM women wing (UWT), and Aza Januar Joseph from the ruling party par-

Additionally, Anna Athanas Paul, another woman with a disability, was appointed from a list of ten individuals chosen by Zanzibar President Dr Hussein Ali Mwinyi, to represent the council.

Beyond the numerous chal-

sentation is more complex than just numbers; there is a pressing need to grant real access to political power for people with disabilities. The majority of individuals with disabilities are effectively shut out of the political sphere due to existing party systems that are not entirely accommodating and due to social stigmas that result in discrimination, marginalization, and exclusion. This leaves many wondering whether their needs will ever be fully addressed at the legislative level.

Salma Haji Sadat, Chairperson of the Zanzibar Women with Disabilities Association (JU-WAUZA) says: "Political parties and the community are two different sides; it could be possible that the community wants to elect an individual with certain disabilities, but the party may not accept them."

Salma emphasizes that political parties and the community must work together.

"If political parties establish a better environment for people with disabilities and the community accepts it, it will become easier for them to attain leadership positions. However, acceptance in politics remains a significant challenge that requires substantial effort to achieve," she noted.

Ussi Khamis Debe, the Executive Secretary of the Zanzibar National Council of PWDs urges that progress has been made, but there is still much work to be done.

"Our ministry has worked to ensure that disability communities have a voice in politics, but it is clear that more needs to happen. We need to see disabled people in constituencies, not just in special seats designated for women," he stated.

Debe added that political parties must take proactive steps to include people with disabilities in leadership roles.

"Political parties have the responsibility to create an inclusive environment where candidates with disabilities can thrive," he con-

In light of ongoing advocacy efforts, Zanzibar is known for its long history of numerous associations dedicated to advocating for people with disabilities. Each of these organizations has played a significant role in elevating the voices and demands of the disabled community in various ways. However, Adil Mohamed Ali, the Zanzibar Association of the Blind (ZANAB) coordinator believes that these associations have not yet formed a unified voice, which is necessary to bring significant pressure to the governing system, the Zanzibar Electoral Commission (ZEC), and political parties.

"The issue of cooperation among associations for people with disabilities, in my view, is lacking a unified voice," the coordinator said.

These organizations have yet to come together to agree on this matter and recognize its

"They have yet to plan how to collectively present a proposal that triggers one strong voice so that the whole system can incorporate it into policies, laws, and guidelines," he suggested.

This perspective is particularly important in this discussion, as it highlights the broader need for systematic change in how people with disabilities are represented. Such insights emphasize the importance of establishing dedicated constituencies for people with disabilities and critically addressing the gaps in the current political framework.

In addition to the ongoing discussions around the representation of people with disabilities, perspectives from key figures shed

light on the expectations for future changes. Bakar Hamad, an advocate for people with disabilities who has worked in various organizations for many years, emphasizes the importance of contesting for political posts. He suggests that media outlets should take the lead in this effort, stating that, if possible, radio, television, and social media should create special programs to help individuals with disabilities convey their messages and campaigns without the need for direct interaction with the public. This approach would serve as a way to leverage technology for people with disabilities and boost more representation, making it easier for them to connect and engage. Meanwhile, Sada Hamad Ali, a member of the Zanzibar Federation for People with Disabilities, voices her concerns regarding the special positions for women within the council.

"It is also the right of men with disabilities to have opportunities to enter there," she said. These viewpoints highlight the complexities of representation and the need for inclusive dialogue, reminding us that the quest for equity extends beyond non-disabled individuals.

Sada Hamad Ali's call for equal opportunities for women with disabilities highlights the ongoing need for true inclusivity. "It is also the right of women with disabilities to have opportunities to enter there," she said. Her statement emphasizes that efforts to include people with disabilities must consider both men and women. Equally. All stakeholders need to work together to ensure that the voices of people with disabilities are heard and their needs fully addressed.

TCAA due to let NIT start providing pilot training

THE Tanzania Civil Aviation Authority (TCAA) has announced that it is in the final stages of granting a license to the National Institute of Transport (NIT) to provide pilot training in the country.

TCAA director general Salim Msangi (pictured) unveiled this over the weekend when speaking at the second international conference on logistics and transport.

Msangi highlighted that NIT has already acquired two training aircraft and is following standard procedures to complete the licensing process.

To obtain an aviation training license, applicants must pass through five inspection stages to ensure compliance with international standards.

"The institute must meet all criteria so that any pilots it trains will adhere to international flying standards," Msangi

He added: "Aircraft do not have a designated area for stopping in the air; therefore, based on our inspections, NIT has completed four stages, with only one remaining. If they meet the requirements, we will issue them a certificate to commence training."

Msangi emphasized that passing inspection would enable NIT to receive both a certificate and a license to train pilots, thereby addressing the shortage of qualified pilots in Tanzania.

He also discussed the TCAA's role in overseeing regulations and laws gov-

erning the aviation sector and providing short course training.

"While NIT offers longer courses, we have our own institute providing short courses that adhere to global aviation curricula," he noted.

Msangi mentioned that TCAA provides guidance services for all aircraft entering the country and manages the airspace of Burundi due to its lack of certified equipment.

"Burundi has delegated airspace management to us, and we oversee all aircraft entering from there," he said.

TCAA also supervises airports and local airlines, issuing licenses for drone operations and handling their registration. "Our role is to ensure that drone operators receive training and are reg-



istered like any other aircraft. Participation in this conference ensures that all aviation service providers operate within

the law," he said. Msangi reiterated the importance of compliance with international standards, stating, "We are prepared to issue a certificate; having reached five inspection stages, we can grant a training license if we confirm their compliance. Our country truly has a shortage of professionals in this

AWIRA Njiru, Founder and CEO of Food for Education, is on a mission to feed millions of schoolchildren across Africa. Currently, her organization provides 450,000 meals daily to over 1,200 schools across Kenya. Ahead of World Food Day on 16 October, the award-winning Njiru spoke with Kingsley Ighobor about her ambitions, the importance of nutritious meals for children, the impact of climate change on agricultural productivity, and more. Here are excerpts from the interview:

I'm the founder and CEO of Food for Education (F4E). I started the organization because of the simple belief that hungry children can't learn. The reality is that one in four people in the world will be African by 2050, and many of them, right now, are children. We have about 400 million children on the continent, and most of them do not get a minimally acceptable diet. You can't do anything when you're hungry.

What we do is streamline the entire process of providing school lunches to around 450,000 children every single day in about 1,263 schools [in Kenya].

We've seen a huge impact in that the children are able to learn and stay in school. There has been increased enrollment and attendance, and we've seen kids being nourished and able to live up to their full potential.

How severe is malnutrition among children in Kenya?

It is very severe. On the continent, millions of children are malnourished. In Kenya specifically, one in four children is stunted because of malnutrition. Stunting means you're too short, your weight is not enough, and your IQ has not reached its full potential because you didn't get adequate nutrition when you were under the age of five. This creates a human capital limitation.

Does the situation in Kenya reflect other parts of the continent?

In some countries, yes, the situation in Kenya reflects that; but in many countries, it's better or worse.

We started in Kenya because I'm Kenyan. Our team is majority Kenyan. We began in the home and community where I grew up. But this is not just a Kenyan problem; it's a continent-wide problem, and we Africans need to be at the forefront of solving our own problems.

We've launched what we call an African strategy for school feeding, expanding and making sure it reaches other children across the continent. We will be scaling to other countries across Africa in the future.

Do you find people in other countries interested in learning from your experience so they can replicate it in their communities?

Yes, many people want to learn how to feed their communities in places like Nigeria, Zambia, and the DRC. We've learned a lot about both failing and succeedingwhat works and what doesn't. Now we're looking at how

to share that knowledge to help others build kitchens, source supplies, distribute food and more. Africans are known for giving back to their communities.

When I started Food for Education, I traveled to India to learn from an organization called Akshaya Patra Foundation, which has scaled its operations significantly. Not everyone can go to India, so we are happy to share our knowledge and experience.

How does Food for Education fit into efforts to tackle poverty in Kenya and on the continent as a whole?

Poverty is the inability to live to your full potential or to provide yourself with basic needs, such as food, shelter, water and clothing. Food and water are the most critical needs for humans. You can't afford food if you're living in poverty.

By providing nutritious meals in school, we're helping those living under the poverty line–those struggling to feed themselves and their families. If they send their child to school, that child will get a nutritious meal, be educated and potentially help the family out of poverty.

Where do you get the resources to feed 450,000

children a day? We have a strategic alliance with parents, government and philanthropy, and we see those three contributors as critical. Parents have the biggest stake in their children's wellbeing because, of course, they want their kids to eat

We meet them where they're at by subsidizing the amount they contribute for their children to eat, with the subsidy provided by the government. We work with county governments across Kenya that give us resources to subsidize meals.

Then there's philanthropy. Some gaps can only be filled by philanthropic capital, such as when we're setting up kitchens or making technology investments. Philanthropy can catalyze school feeding programmes before the government and parents take over the daily operations.

You plan to feed one million children in Kenya by 2027. How is that going?

It's going well. Feeding a million kids in Kenya is one of our main focuses, alongside expanding to other African countries, where we aim to feed an additional two million children. We started with just 25 children. So, it's not an overnight success. It's taken 12 years to get here, but now. with a stronger team, we see opportunities to accelerate our efforts and scale faster.

In your work, do you keep in mind SDG 2, which aims to achieve zero hunger by 2030?

Yes, SDG 2 aligns closely with the work we are doing. But when I started Food for Education 12 years ago, there were no SDGs. I was 21 years old, but I knew that achieving zero hunger was essential. Hunger is very limiting-when you're hungry, you're irritable, and you can't focus on any-

What are some of the challenges you've faced so far?

It's taken 12 years to get to where we are now. Initially. we had to understand the nutritional composition of the meals we provide. I'm a nutritionist and food scientist by training, so it's important to me that kids get the right nu-

So, getting the menu right, contextualizing it and ensuring it served the kids and that they found it delicious were critical. Another challenge is that no matter how many kids we feed, there are always more in need. Scaling up fast enough to meet the need is an ongoing challenge. Our goal is to feed a million children every day. While we're feeding 450,000 now, the continent has 400 million chil-

Resource mobilization, building partnerships, and assembling the right team are what we will need to do as we continue to grow and reach more children.

Seventy-five percent of your employees are women. Why is that?

Yes, 75 percent of our staff are women, and that has had a huge impact. In every place we operate, parents are involved, and many of them are employed to cook for their

In the beginning, we saw that more women than men were interested in working in the kitchens, but that's starting to change now.

How does climate change impact your work?

When I think about climate change, I think about its impact on communities across the continent. Rising temperatures, droughts, and floods are becoming more frequent, disrupting food production and driving up food

As a result, the food plate is getting smaller and less nutritious, with kids missing out on essential proteins and vegetables. The body doesn't stop needing nutrition just because the climate is changing.

Climate change is something we should all be concerned about. It tends to affect the poorest people the most, so we must help them adapt.

You've been speaking lately around the world about the need for nutritious food for school children. Are people receptive to your advocacy?

I had the opportunity to speak about our work at the UN General Assembly this year. I'll be at the World Bank in a few weeks for the fall meeting. We also won the award at Oxford. UK, earlier this year [Skoll Award for Social Innovation]. The reception has been very positive because people understand that children can't survive, let alone thrive, without food.


All the speaking engagements and platforms have allowed us to highlight the importance of school feeding in the broader conversation. If we're thinking about climate change, Africa's future, the future workforce, or human capital, school feeding is a key solution.


What message would you give young Africans, particularly women, who see you as a role model?

My message to young Africans is that there's so much potential within us. Our continent needs us. It needed us yesterday, it needs us today, and it will need us tomorrow.

We are the ones who can bring change to our communities. Don't think of yourself as small or incapable. There's no right age to start something. Whether you're young or older. you can start something and succeed.

I was 21 years old when I started. I was an international student, struggling to pay my school fees in Australia. But I started small, hoping it would grow one day-and it has.

USAID-funded project boosts health services

A project funded by the United States Agency for International Development (USAID) has made significant contributions to improving health services in

The \$48 million (130.45bn/-) initiative, which has been implemented from 2016 to 2024 under the Global Health Supply Chain-Technical Assistance (GHSC-TA-TZ) program, focused on providing technical assistance to strengthen supply chain systems in critical health areas.

Dr. Jema Bisimba, USAID Tanzania's Senior Health Policy Advisor, emphasized that the funding was crucial in enhancing the country's health supply chain, particularly in combating diseases such as malaria, HIV/AIDS, and tuberculosis.

The project also supported family planning, reproductive health, and maternal, newborn, and child health services.

"During the project, 58 million HIV test kits and antiretrovirals (ARVs) were procured and distributed, benefiting 1.5 million people. Over 1.3 million people have been confirmed to be living healthier lives as a result," Dr. Bisimba

She also highlighted the project's contribution to malaria control, reducing the disease's prevalence from 14 percent to 8 percent. Approximately 36 million people were treated for malaria during this period.

As the project draws to a close, Dr. Bisimba reaffirmed the US government's commitment to working with Tanzania and the private sector to address key challenges in the health sector. USAID remains dedicated to improving the well-being of Tanzanians by supporting a robust health management system and ensuring sustainable progress in healthcare.

Philip Kamutenga, GHSC-TA Tanzania's Chief of Party, outlined the project's four key objectives: providing strategic planning and implementation assistance, improving the delivery of health commodities, increasing stakeholder engagement with the supply chain system, and strengthening environments conducive to improved supply chain performance.

One of the project's significant achievements was the development of the Information for Performance Analysis and Continuous Transformation (IMPACT) approach—a people-centered, data-driven initiative focused on quality improvement.

"The rollout of the IMPACT approach has been extensive, reaching over 2,300 healthcare professionals across various levels of the healthcare system," Kamutenga explained.

These professionals, including medical officers, pharmacists, lab technologists, nursing officers, and social welfare officers, were selected from regional health management teams (RH-MTs) in 26 regions and council health management teams (CHMTs) in 184

Mavere Tukai, Director General of the Medical Stores Department (MSD). praised the project's impact on health

In 2021, the Ministry of Health, with technical assistance from USAID, developed a Data Quality Assessment (DQA) protocol to address data-related challenges across various health programs, including HIV, malaria, reproductive health, and tuberculosis.

The DQA has greatly enhanced data utilization for decision-making at all levels. Tukai also noted that the project addressed the over-ordering of Artemether/Lumefantrine (ALu) tablets by health facilities, using the electronic Logistics Management Information System (eLMIS) to resolve discrepancies between patient reports in eLMIS and the DHIS2 system.

Issa Ng'imba, Director of Human Resources at the Ministry of Health, acknowledged the project's role in implementing key interventions, including the development of a health supply chain e-learning module.

Since its launch, over 3,700 healthcare workers have accessed the module, with an average of 540 workers per

Africa urged to grasp smart, advanced manufacturing to adding greater value

frican countries have been urged focus on modern manufacturing technologies and creating smart factories, to add greater value of its local industry.

"When looking at manufacturing value-add by region, developed regions such as the EU and North America, and developed nations such as Australia and New Zealand, have a very large component of manufacturing value added to their GDP," said Professor Theuns Pelser, executive director of nonprofit Toyota Wessels Institute for Manufacturing Studies (TWIMS).

He said Africa contributes about 2 percent of global GDP, but provides about 30 percent of global raw materials.

"Complex manufacturing requires diverse industries and ecosystems involved in making the high-value products. Only producing raw materials or semiprocessed goods removes the need for complexity and the industry then does not need further skills, which leads to a decline in value addition in manufacturing," he said during the Manufacturing **Enterprise Solutions Association** (MESA) Africa 2024 Summit, held in Sandton, Gauteng.

He added that sub-Saharan Africa could view this as an opportunity to leapfrog, through the creation of smart factories, to get to the developed world's manufacturing value-add trajectory.

Companies in the fast-paced and globalised world need to

adopt technologies to enhance their competitiveness.

Key to this technology drive was to determine how the application of technologies would benefit individuals and organisations, and how the combination of technologies could create a smart factory, he emphasised.

He gave six examples of how companies can drive advanced manufacturing and how these technologies would benefit organisations, such as additive manufacturing providing companies with new scope to customise their products, while Industrial Internet of Things sensor networks and analytics can help to prevent machines from breaking down and leading to stoppages.

Further, he highlighted that digitalisation of older equipment and factories could make factories smart.

For example, UK beet sugar products manufacturer British Sugar, which has traditional processes and old-fashioned boilers, uses sensors on critical equipment to prevent breakdowns and manage its processes across the diverse range of products it pro-

However, while technologies could benefit organisations, companies should be more concerned about using technology to drive things such as local production, product customisation and resource efficiency, he emphasised.

He said there are lots of inefficiencies in African manufacturing in terms of resource use, and it is critical to consider how smart factories can increase resource efficiency in organisations.

"South Africa is on a downward path in terms of the complexity of products that we are exporting, and is deindustrialising. To overcome this, we need to make manufacturing 'sexy' and attract new talent into new careers in industries to create more complex industrial ecosystems," said

Africa, for example, manufactures only 4 percent of the materials and parts for the automotive value chain used around the

Therefore, there is scope to increase this by establishing smart factories, which will enable manufacturers in the supply chain to move up from being basic materials suppliers to Tier 2 and then Tier 1 suppliers.

To create Tier 2 and Tier 1 manufacturers, growth is required in skills so that technologies can be used to produce these more complex goods for customers.

"[South Africa] should move away from Tier 3 manufacturing, which is where we only get punched. For example, owing to the carbon intensity of our manufacturing, such as steel or aluminium production that relies on coal-fired power, we are at a problematic disadvantage in terms of EU and North American markets," he said.

Smart manufacturing helped to reduce carbon footprints and boosted efficiencies across a range of resources, processes and products, benefitting the bottom line of companies and the value of the industry, he added.

"A core challenge is that companies cannot effectively use technologies without upskilling people. People also need to be provided the relevant context and reasons for technology deployments so that they understand how they will benefit from them," said Pelser.

There are also concerns that smart factories will lead to people losing jobs, but an illustrative data point is that, by 2030, 230-million jobs in Africa will require at least

Sustainable charcoal production progressing across Tanga Region

A total of 123 individuals in the Pangani, Kilindi, and Handeni District councils of Tanga Region are now engaged in sustainable charcoal production after receiving training aimed at preventing deforestation and enhancing liveli-

Athuman Lugendo, the forest-based enterprises officer for the Tanzania Community Forest Conservation Network (MIU-MITA), provided this update during an assessment of the Integrated Forest **Biomass Energy Solutions** for Tanzania (IFBEST) project in Kilindi District.

The assessment brought together various stakeholders, including environmental conservation officers, village leaders, and representatives from organizations like the Tanzania Forest Services Agency (TFS) and the Tanzania Conservation Group (TFCG).

Under the IFBEST project, villagers from Gendagenda, Mapanga, Mswaki, Mseko, and Mkalamo were trained on legal procedures for commercial timber and charcoal harvesting, which included guidelines for selecting trees and maintaining a

of 50 centimeters.

Participants learned to prepare the Improved Basic Earth Mound Kiln (IBEK) for sustainable charcoal production, including safety measures for harvesting and processing logs.

This initiative is funded by the European Union, which has contributed 5.4 billion Tanzanian shillings through the Ministry of Finance to support the efforts of TFCG and MJU-MITA.

Lugendo expressed pride in the community's progress, stating that their approach has shifted from indiscriminate tree cutting

minimum cutting height to sustainable forest management. This new mindset has led to the adoption of IBEK techniques for charcoal production and sustainable harvesting practices within village

forest reserves.

As a result of the training, 59 individuals from Kilindi District's Mapinga, Mswaki, and Mmbogo villages have become sustainable charcoal producers, along with 20 from Mseko in Pangani District and 44 from Mkalamo and Gendagenda in Handeni District. Lugendo urged district authorities to continue educating producers about legal harvesting pro-

Currently, five sustainable charcoal producer groups, comprising 123 members, are awaiting registration from TFS.

However, challenges remain, including concerns about securing profitable markets for charcoal amid government pushes for clean energy. This has created hesitancy among producers to participate in training due to fears of potential arrests.

Peter Mtoro, the community-based forest management officer for TFCG, reported that 2,304 hectares of forest have been allocated for sustainable charcoal harvesting across the three districts. Specifi-

cally, Kilindi District has 549.1 hectares, Pangani 695 hectares, and Handeni 1,060 hectares designated for this purpose. Production estimates suggest Kilindi will produce 185 tons, Handeni 233.3 tons, and Pangani 133.2 tons of sustainable charcoal per year.

The IFBEST project's primary goal is to promote environmental sustainability through improved forest management and wood-fuel production in Tanga Region, currently implemented in eight villages across Handeni, Pangani, and Kilindi District councils.

Conservationists have emphasized the need for better resources for forestry and wildlife officials and proposed placing signboards in designated village land forest reserves to enhance community awareness.

They also recommend improving grazing pastures and integrating community-based forest management education into village meetings to combat forest degradation. Additionally, scaling up the Village Savings and Loan Association (VSLA) in other villages could help broaden the benefits and reduce deforestation.

Census experts urged to share expertise with young graduates

ne Commissioner for the 2022 Population and Housing Census, Anne Makinda, has urged census experts to pass on their knowledge to young graduates, ensuring their expertise benefits future generations in producing professional census reports.

Makinda made this call on Saturday during the launch of the thematic reports drafting exercise for the 2022 Population and Housing Census, held in Dar es Salaam.

The drafting process marks a key activity in the third phase of the census, which is conducted every ten

She also encouraged ministries, heads of departments, government agencies, and local government authorities to continue using census data as the foundation for all development-related decisions.

Makinda highlighted that about 24 reports have been issued so far. However, she noted that the earlier reports provided general informa-

tion without delving into sector-specific thematic areas, as prescribed by United Nations guidelines.

The government plans to prepare 15 thematic reports based on the 2022 census results. The first phase will involve the preparation of five thematic reports, focusing on fertility and nuptiality, mortality and health, disability, population dynamics, and education and literacy.

The remaining ten reports will be prepared in subsequent phases.

"These reports will serve as a foundation for policy decisions, as well as planning for both the government and the private sector," Makinda

She added that the reports will help track and measure the implementation of various national, regional, and international development agendas.

The reports will contribute to key national plans such as the Third Five-Year National Development Plan (ending in 2025/26), the National Development Vision 2025, and will support the formulation of the National

Development Vision 2050.

Internationally, they will aid in monitoring the progress of the Global Sustainable Development Agenda 2030, the African Development

Agenda 2063, and the East African Development Vision 2050.

Chief Statistician Dr. Albina Chuwa emphasized that the thematic areas selected for detailed analysis are based on the need for relevant information critical to the country's development.

According to Dr. Chuwa, the initial draft of the five reports is expected

to be completed within 14 days, after which they will undergo review by the National Bureau of Statistics (NBS) and the Office of the Chief Government Statistician (OCGS).

The drafts will be presented to stakeholders, including policymakers, for further input and refine-

The project is being carried out by the government in collaboration with the United Nations Population Fund (UNFPA) and the UK's Foreign, Commonwealth and Development Office (FCDO).

Salum Kassim Ali, Chief Statistician for Zanzibar, called on the assigned experts to complete the reports within the scheduled timeframe, noting that both the government and development partners are awaiting the results to inform strategic development decisions.

"I am confident that the assignment of experts to each team will yield positive results, ensuring timely completion of this important work," said Ali.

Digitalisation helps in fight against illicit gold trading

The integrity of the global gold supply chain has been the subject of intense scrutiny of late, following a damning report by Swiss nongovernmental organisation SwissAid earlier this year, which claims that illicit gold trade amounts to between \$23-billion and \$35-billion a year.

However, the duction of technologies such as the geoforensic passport, optical AI and blockchain - along with the updated Responsible Gold Guidelines (RGG), the more stringent Know Your Customer (KYC) Guidelines and the Organisation for Economic Cooperation and Development's (OECD's) Due Diligence Guidance for Responsible Supply Chains of Minerals from Conflict-Affected and High-Risk Areas - means that much of the framework needed to stymie illicit gold trade already exists.

Gold247 is meant to enhance supply chain management, while simplifying gold trading processes and increasing access for all stakeholders, including central banks, bullion centres, subsistence gold miners, smaller refineries and potential investors, explains WGC CEO David

He says that the ultimate goal is a "truly global network where anyone who sits outside the database should be very worried, as the very thought of procuring gold from outside of the system would be unthinkable".

The realisation of such a network is nearly in sight, although both Tait and Argor-Heraeus co-CEO Robin Kolvenbach agree

that general fragmentation, both from a regulatory and technological perspective, leaves room for improvement. An integral part of the Gold247 vision is the GBI platform. which encourages the adoption of technology to enhance transparency and traceability throughout the entire supply chain.

The GBI pilot - which was jointly launched by the London Bullion Market Association (LBMA) and the WGC and ran from March to July 2022 - helped define the scope of the platform's database. It also revealed longer-term goals, such as expanding the platform to include other gold products, secondary market materials and other precious metals, in addition to incorporating KYC requirements and other due diligence processes when onboarding customers.

More than 30 participants took part in the pilot, including Rand Refinery and Argor Heraeus.

"We see the GBI as a crucial step forward in preventing ingress of illicit material into the LBMA gold ecosystem," says Rand Refinery CEO Praveen Baijnath.

Argor-Heraeus co-CEO Hans



Deutsch agrees, expanding on his company's involvement in the GBI by citing its work with Swiss software company aXedras and USbased software company Alitheon - both of which are recognised by

He notes that the company uses aXedras' Bullion Integrity Ledger, which helps to create "immutable provenance information", while Alitheon's software allows it to verify and trace its physical products.

"If you put these puzzle pieces together with geoforensic data analysis, you get strong systems that can ensure that no illegal gold is entering that supply chain," adds Deutsch.

To illustrate the benefits of Alitheon's optical AI solution Feature-Print, Alitheon CEO Roei Ganzarski compares it to a human fingerprint.

"Fingerprints are unique; they are inherent and they are persistent," he says, explaining that rather than using proxies, "like barcodes, stamps, tags, markers or tokens" which can be removed, or faked or stolen to pass off counterfeit goods as the genuine article - FeaturePrint essentially creates a "digital fingerprint" based on the attributes and features that are inherently unique on each product owing to the manufacturing tolerances of that specific product.

Even gold bars produced by the same machinery in the same refinery, using the same moulds, have unique, inherent characteristics that are undetectable by the human eve, making them distinct from all others, "just like human identical twins still have slightly different fingerprints".

While the bars are made to specific tolerances - in terms of weight, size and gold content - the individual products can fall anywhere within the manufacturing tolerance

FeaturePrint combines machine vision and patented algorithms to codify these inherent attributes to create a unique digital identity that can be used to "irrefutably identify, authenticate, and trace" a bar of gold or any other physical item. Any company or individual with the software can use a standard offthe-shelf digital camera or a mobile phone to identify, authenticate and trace an item.

Boeing proposes wage hike to end strike

Instead, Boeing would raise its contributions to workers' retirement savings plans. The company would make a one-time contribution of \$5,000 into the 401(k) plans of all eligible workers, and fully match their contributions of as much as 8 percent of

WTO: Geopolitical tensions expected to hurt int'l trade

GENEVA

Geopolitical tensions, notably those in the Middle East, remain the main risk to international trade, World Trade Organization (WTO) Chief Economist Ralph Ossa has said.

Escalating Middle East tensions could lead to supply shortages and a resulting spike in oil prices, Ossa told Xinhua. "Increased oil prices would then affect macroeconomic activity and also international trade." In a report released in early October, the WTO projected global merchandise trade volume to grow by 2.7 percent in 2024, a slight increase from its April forecast of 2.6 per-

One significant update in the new report is the regional outlook. "We see Asia doing stronger than we had expected ... Europe was doing weaker than we had expected," said Ossa, adding that "Asia continues to be the main driver of international trade, both on the import side

and the export side." Meanwhile, exports in

Asia are expected to grow by 7.4 percent in 2024 compared with a 4.3 percent rise in imports, he said.

"We were expecting a recovery of trade in April, and continue to expect a recovery of trade today, (which) is in large part due to the normalization of inflation and the corre sponding easing of monetary policy," Ossa said.

China showed a strong performance on the export side, and the recent stimulus policy carried out by the Chinese government could prop up domestic demand in China and help rebalance international trade, he said.

In order to tackle multiple challenges, Ossa called for defending the multilateral trade system with the WTO at its core, adding that it is also important to make the WTO fit for the 21st century.

Speaking on the impact of artificial intelligence (AI), Ossa highlighted AI's potential to reduce trade costs, overcome language barriers, and expand digitally delivered services.

Gold price sets new record high

NEW YORK

Gold set a record high last week as uncertainty surrounding the US election and rising Middle East tensions prompted higher demand for safe-haven assets, while easing monetary policy environment also kept prices

Spot gold hit an all-time high of \$2,696.62 per ounce earlier before pulling back to \$2,686.52 at noon ET for a 0.5 percent intraday gain. US gold futures saw a similar increase, trading at \$2,704.80 per ounce in New York.

Bullion has now risen by more than 30 percent this year, setting multiple record levels along the way, with the precious metal driven by prospects of further Federal Reserve rate cuts and ongoing geopolitical risks.

"On top of the concerns in the Middle East, you are also nearing the US election, which is looking like a very closely contested election. And that generates a whole host of uncertainty, and gold often is the place to go in times of uncertainty," said Nitesh Shah, commodity strategist at WisdomTree, in a Reuters note.

Xi stresses leveraging national development strategies to advance Chinese modernisation in Anhui

HEFEI

CHINESE President Xi Jinping has urged east China's Anhui Province to apply the new development philosophy on all fronts and leverage its role in multiple national development strategies to write an Anhui chapter in Chinese moderniza-

Xi, also general secretary of the Communist Party of China (CPC) Central Committee and chairman of the Central Military Commission, made the remarks during an inspection tour in the province from Thursday to Friday.

On Thursday afternoon, Xi inspected Tongcheng City, where he visited the Liuchi Alley, a historical cultural site known for a story from the Qing Dynasty (1644-

The story -- of an official and his neighbor both moving back their walls by a meter to resolve their disputes over property boundaries -- is an example of neighbourhood comity and harmony.

At the site, Xi urged efforts to strengthen the protection of history and culture, develop advanced socialist culture, promote revolutionary culture and carry forward fine traditional Chinese culture. He told local residents and tourists that the alley demonstrates the wisdom of ancient Chinese in resolving disputes.

He called for efforts to leverage its educational function to carry forward the

traditional Chinese virtues of comity and peace. At his next stop, Xi visited the Hefei Binhu Science City, where he examined an array of major sci-tech innovations attained by the province and exchanged views with researchers and corporate executives.

Xi took a close look at high-tech products in the fields of intelligent connected vehicles, new-generation information technology, new energy, artificial intelligence, and health and life science.

Noting that sci-tech innovation is an essential path to Chinese modernization, Xi called for accelerated efforts to achieve greater selfreliance and strength in science and technology, and encouraged scitech researchers to be more innovative in helping build the country's

strength in science and technology. On Friday morning, Xi was briefed on the work of the CPC Anhui

provincial committee and the provincial government, and made instructions for the province's future work.

He urged efforts to expedite sci-tech innovation, accelerate industrial transformation and upgrading, expand international exchanges and cooperation in science and technology, and establish mechanisms that support comprehensive innovation.

He stressed the importance of developing new quality productive forces in light of local conditions while accelerating the transformation and upgrading of traditional industries and fostering the growth of strategic emerging industries.

Xi emphasized the need to push for in-depth reform and pursue high-standard opening up, calling for fostering a world-class business environment that is market-oriented, law-based and internationalized. He also called on Anhui to actively engage in advancing high-quality Belt and Road cooperation, and redouble its efforts to attract and stabilize foreign investment.

Highlighting the need to focus on creating a new pattern of integrated urban-rural development, Xi said it is important to expand the coverage of such services as education, medical and elderly care, social security and public culture in rural areas. Xi urged efforts to further promote the integrated development of culture and tourism, and build cultural tourism into a pillar industry.

While stressing the need to uphold Party leadership and consistently strengthen Party building, Xi also demanded all-out efforts on the economic work in the fourth quarter to achieve the economic and social development goals for the whole year.

How US export curbs are undermining EU's chip ambitions

DUTCH semiconductor equipment maker ASML lost up to 60 billion euros (65.25 billion U.S. dollars) after its shares plummeted over 20 percent in just two days this week, primarily due to lower-than-expected 2025 sales and bookings.

The company is feeling the pinch of U.S.-induced geopolitical tensions, as Dutch export restrictions, at the behest of the U.S. government, are weighing heavily on the tech giant's outlook for 2025. According to a CNBC report, ASML anticipates a decline in sales from China next year, citing U.S. export restrictions as a significant factor.

EXPORT LOSSES

Since 2019, the United States has pressured the Dutch government to implement strict controls on exporting advanced chip-making equipment to China, citing "national security" concerns. Initially focused on ASML's advanced extreme ultraviolet lithography machines, the ban was expanded

earlier this year to include several midrange deep ultraviolet lithography machines.

China, one of the world's largest semiconductor markets, has been crucial to ASML's business, with 49 percent of its sales coming from the country in the first quarter of 2024. However, amid these export restrictions, ASML now expects revenue from China to drop to around 20 percent of total sales next year, said ASML's Chief Financial Officer Roger Dassen.

ASML CEO Christophe Fouquet has criticized the U.S. restrictions, stating that the campaign to limit exports to China, originally framed as a national security measure, has increasingly become "economically motivated." This trend raises concerns among tech companies that adherence to U.S. restrictions could severely damage normal trade relations, disrupt the global semiconductor supply chain, and hinder the expansion of the EU's semiconductor industry.

IMPACT ON EU

The U.S.-led campaign to restrict

high-tech equipment exports, particularly to China, has disrupted ASML's operations and undermined the EU's chip ambitions.

However, the company's struggles are not isolated. In September, chipmaking giant Intel announced delays in building two factories in Germany and Poland due to "lower demand than anticipated.'

These planned investments, worth tens of billions of dollars and previously considered vital for the EU's semiconductor production goals, are now uncertain.

Similarly, expansion plans from companies like Taiwan Semiconductor Manufacturing Company (TSMC), Infineon, and Wolfspeed in Europe remain stagnant, with no concrete progress visible.

In 2023, TSMC announced a joint investment with Bosch, Infineon, and NXP to create the European Semiconductor Manufacturing Company (ESMC) in the German city of Dresden, a key hub for chip manu-

Although construction officially began in August and production is expected to start in 2027, a recent visit by Xinhua reporters to the site revealed little activity, with overgrown weeds and only sparse monitoring stations present.

Manfred Horstmann, managing director of GlobalFoundries' Dresden plant, has underscored the risks of starting from scratch on a greenfield site. "Typically, there is a lack of infrastructure, suppliers, and essential services," he noted.

DREAM VS REALITY

With robust legislation and funding in place, the EU has set ambitious goals for advancing its semiconductor industry.

In 2022, the European Commission introduced the EU Chips Act, aiming to mobilize over 43 billion euros (46.76 billion dollars) from public and private investments to achieve strategic independence from semiconductor imports and improve supply chain responsiveness.

Youth entrepreneurs key in tackling climate change in Africa

I AM a proud Nigerian and a proud African. I am also a philanthropist and entrepreneur-and I have seen firsthand that to effectively tackle climate change within the African context, from Egypt to Nigeria to South Africa, we must look to the people it impacts.

Too often our businesses have not created value on our continent or traded commodities for short-term profit, not long-term investment. Fostering entrepreneurship, sustaining young entrepreneurs, who will grow businesses and create sustainable employment, is a crucial pathway to achieving long-term climate solutions.

In 2010, my wife and I had an idea. Concerned with escalating poverty, we founded the Tony Elumelu Foundation (TEF) and committed \$100 million to identify, mentor, and fund young African entrepreneurs-young people with brilliant ideas and the drive to tackle the continent's most pressing challenges. They lacked capital, connections, and mentors. They lacked luck. We wanted to change that. It was a bold bet aimed at empowering Africa's most vulnerable and populous demographic, encouraging them to create wealth rather than relying on aid. And the bet paid off.

Since its inception, the foundation has empowered 20,000 entrepreneurs across 54 African countries. These entrepreneurs have created 400,000 direct and indirect jobs and generated over \$2.3 billion in revenue. We have also provided access to business training to more than 1.5 million young

Given the scale of the task, we partner with the United Nations Development Program (UNDP), the International Committee of the Red Cross (ICRC), the European Union (EU), and other partners to deepen our reach and impact. We provide funding, mentorship, business training, and advocacy support to entrepreneurs in fragile regions, conflict zones, and underserved communities.

Together, we address challenges like youth unemployment, poverty, and insurgency through entrepreneurship. In 2022, we partnered with UNICEF Generation Unlimited (GenU) and IKEA Foundation, to launch a Green Entrepreneurship Program that empowers youth whose businesses address the triple planetary crisis. Of the 20,000 young men and women entrepreneurs that TEF has empowered, more than 500 are directly or indirectly solving challenges related to climate change, and over a third (35%) working in the agricultural sector.

By empowering young people, we are establishing a dynamic engine that drives economic growth and development across the continent. These entrepreneurs also become vital pillars of support within their communities. They are not only creating essential jobs and income but also uplifting families and breaking the cycle of poverty. And now, more than ever is the time to bring a climate lens to this entrepreneurship.

Africa is warming more quickly than the rest of the world. By 2030, an estimated 118 million Africans are projected to face drought, and rising sea levels threaten coastal regions, potentially displacing millions. Climate change is impeding access to necessities: water, power, food, and education. But these challenges also offer extraordinary opportunities for those with an entrepreneurial mindset to tackle climate change, while simultaneously creating significant economic

For instance, how can we enhance the sustainability of smallholder farmers, who comprise 80% of all farms in sub-Saharan Africa and employ 60% of the continent's workforce? What strategies can be employed by African nations with vast forests-such as Gabon, Liberia, Guinea-Bissau, and Congo-to effectively leverage these critical carbon sinks?

To unlock the full potential of green solutions in Africa, we must nurture entrepreneurship-and this cannot be achieved by governments alone. We need to integrate government incentive schemes, with the opportunities presented by the private sector. We must unite philanthropies, policymakers, and businesses. I refer to this movement as "Africapitalism"-a call for partnership led by the private sector, focused on fostering prosperity for all.

Britain's King Charles visits Australia on first major trip since cancer diagnosis

HUNDREDS of well-wishers greeted Britain's King Charles and Queen Camilla in Sydney yesterday as the royal couple attended church, with the king saying it was a "great joy" to return to Australia in his first visit to an overseas realm as sov-

Charles' 16th official visit to Australia, where he attended school for six months as a teenager in 1966, is also his first major foreign trip since being diagnosed with

"What a great joy it is to come to Australia for the first time as sovereign and to renew a love of this country and its people which I have cherished for so long," he said in a speech at the New South Wales parliament.

New South Wales state lawmaker Kellie Sloane, whose electorate covers some of Sydney's most famous beaches, wrote on social media platform X after chatting with the king that he "sends his best to the 'amazing' surf clubs at Bondi Beach".

The royal couple were earlier greeted at St Thomas' Anglican Church by the arch-

bishop of Sydney, Kanishka Raffel, and children from the church's Sunday school who waved Aus-

Camilla was given a flower bouquet by the minister's wife, Ellie Mantle, who asked if they had recovered from jet lag after the long flight to Austra-

lia on Friday. "Sort of," Camilla replied. Inside the church, Charles and Camilla signed two bibles, including one that belonged to Australia's first minister and chaplain of the First Fleet of ships that took convicts from Britain to the penal colony of Australia in 1788.

Outside, the royal couple shook hands and chatted with a large crowd of cheering fans, some singing God Save the King.

It was the public's first opportunity to meet Charles and Camilla since they arrived in Australia's biggest city on Friday night, and several hundred wellwishers outnumbered a dozen protest-

Traveling across Sydney Harbour, Charles visited the New South Wales parliament, marking the 200th anniversary of Australia's oldest legislature.

The king presented the lawmakers with an hourglass to time their speeches, and highlighted the fundamental role of strong parliaments to democracies that serve today's diverse societies.

"Democracy has, I believe, an extraordinary capacity for innovation, compromise and adaptability as well as stability," he said.

The royal couple will travel to Canberra on Monday to meet Prime Minister Anthony Albanese at the national parliament and visit the Australian War Memorial.

Albanese met the couple on Friday at Admiralty House, the historic government harbourside residence where they are staying, for what he said was an informal drink and chat.

The king will attend the Commonwealth Heads of Government Meeting in Samoa after the six-day Australia tour.

Charles had made a significant personal donation to create a skills program to tackle climate change and boost higher education in small island states, including the Pacific Islands, the Association of Commonwealth Universities said yesterday.

Mid-career professionals and civil servants will benefit from the fellowships, in a program that aims to retain talent in small island states and bolster resilience to the impacts of climate change such as rising sea levels.

Türkiye's Erdogan, Germany's **Scholz meet on escalating** Mideast conflict, bilateral ties

ISTANBUL

TURKISH President Recep Tayyip Erdogan met with visiting German Chancellor Olaf Scholz here on Saturday to address various issues, including the escalating conflict in the Middle East and bilateral relations.

At a joint press conference following their meeting, Erdogan highlighted that the conflict in the Middle East is entering a period of escalation, which urgently needs an immediate ceasefire.

"Initially starting in Gaza, it has now spread to Lebanon, where, unfortunately, Israel continues its massacres mercilessly," he said. "It is essential that we do everything we can to achieve a lasting ceasefire and to exert the necessary pressure on Israel.'

Erdogan also reaffirmed Türkiye's commitment to welcoming refugees. "Especially during this time of war, we keep our doors open for those

who may come to Türkiye, including from Lebanon."


For his part, Scholz said de-escalation and a ceasefire are crucial to prevent the conflict from spreading

He also underscored the importance of a two-state solution, reaffirming Germany's commitment to working toward a peaceful resolution that supports both the Palestinians and Israel.

The two leaders also discussed bilateral cooperation, particularly in the defense industry.

Erdogan noted that bilateral trade has reached \$50 billion, with a goal of reaching \$60 billion.

"We wish to move past some of the difficulties experienced in the procurement of defense industry products in the past and to develop our collaboration," Erdogan added, praising Scholz's efforts to remove Germany's restrictions on arms supplies to Türkiye.

THE United States is provoking tension in the world by deploying weapons in Asia, threatening Russia and China, President Vladimir Putin said at a meeting with the heads of leading BRICS media.

According to the president, Western countries, led by the United States, have caused the ongoing Ukrainian crisis and have started the war back in 2014. He also pointed out that Ukraine's statements about creating nuclear weapons are just another provocation.

TASS has gathered the key statements made by the Russian president.

US provocations

The United States is igniting tensions in the world by deploying weapons in Asia, where they threaten Russia and China: "They are creating additional centers of tension, deploying serious weapons

that are threatening countries of the region, including China and Russia." The United States interferes in Asian affairs itself and pulls its NATO allies along "like little dogs on a leash."

Ukraine

Western countries, led by the United States, have caused the ongoing Ukrainian crisis and have started the war back in 2014: "Let me remind you once more: back in 2014, Western states, led by the US, have either organized or supported the coup d'etat [in Ukraine]. This is what started the entire crisis. And, after that, they have been pushing NATO into this crisis for years."

Ukraine's statements about creating nuclear weapons are just another provocation: "This is a dangerous provocation, as, of course, any step in this direction will be met with an appro-

priate response." Russia is able to monitor any movement towards obtaining nuclear weapons by Kiev, it is "impossible to conceal." Russia is ready to hold a dia-

logue on a peaceful settlement

of conflict in Ukraine, but only based on the Istanbul agree-Russia is aware that the conflict around Ukraine is an "irritant" in international affairs

peacefully as soon as possible. Russia wants peaceful settlement in Ukraine especially because it cares for its soldiers.

The Ukrainian crisis is far from being over: "The situation is not easy. The Ukrainian crisis is far from being over."

Sanctions

The United States should think of souring relations with Russia and of the adverse effect for the dollar from its sanctions.

Global order

Russia is not seeking to rearrange the world and the emer-

gence of new centers of power is a natural process: "This is happening naturally. We merely say that this is an inevitable process and we must react to it correspondingly."

Settlements in national currencies

Russia did not abandon the dollar as a universal currency but was denied in using it, and 95% of trading operations with partners are now in national currencies. Russia will offer BRICS partners to use digital currencies in investments.

The Middle East

Israel will not be able to resolve the Palestinian issue via material stimuli for the Palestinians alone, as spiritual matters are equally important: "I believe that, in addition to purely material issues, there are also issues, connected to the spiritual sphere, with history, with aspirations of one or another nation living on

certain territories. This issue is much deeper and much more complicated.'

"The Palestinians will not go away, this is their land, and one must understand this."

No one is interested in the conflict in the Middle East and it is quite possible to find a solution to it.

The situation between Israel and Iran is fairly tense. Russia is in contact with both countries and hopes that the "endless exchange of attacks" between them will be brought to an end. **BRICS** potential

The economies of Russia,

China, India and Saudi Arabia will demonstrate growth, while it will be advanced in African and Southeast Asian nations. "BRICS makes up 45% of the

planet's population, accounting for 33% of the landmass. It represents a constant growth of trade turnover." "In some areas, human race

cannot exist at all without the BRICS countries – I mean food markets, energy, but also in high-tech areas, in particular in the development of artificial intelligence and its use, we are not only acquiring competencies, but in certain areas we are becoming leaders.'

The number of BRICS members and supporters is growing, the interest in the association's activities is very great.

At least 30 world nations want to join BRICS' activities this or that way: "But at this point, we together with all members of the organization should consider our position on the [association's] expansion. Definitely, we will push away no one. Our door is definitely open."

Consensus among BRICS nations is needed to make a decision on the association's further expansion: "Of course, consensus is needed on this matter. And we will tread this path carefully, being guided by two principles, with the first being multilateralism, and the

second one – the organization's efficacy."

Coach Gamondi's tactical mastery secures Yanga's narrow derby victory

A LAST-MINUTE own goal by Kelvin Kijili sealed a dramatic 1-0 victory for Young Africans (Yanga) over arch-rivals Simba SC in the highly anticipated Dar es Salaam Derby at the Benjamin Mkapa Stadium on Saturday.

The intense encounter, which lived up to expectations, was decided by an unfortunate moment for Simba, with Kijili's attempt to clear a dangerous ball leading to his own goal.

The decisive moment came in the 86th minute when Clatous Chama's powerful free kick caused chaos in the Simba box. Goalkeeper Moussa Camara struggled to clear the ball, which rebounded in front of Young Africans' Max Nzengeli. Kijili, trying to avert the danger, accidentally directed the ball into his own net, leaving Simba fans in shock.

The goal sparked wild celebrations from Young Africans' supporters, as their team moved to second place in the NBC Premier League standings with 15 points, extending their unbeaten run to five matches.

Simba, on the other hand, suffered their first defeat of the season, dropping to fourth place with 13 points.

Young Africans' head coach Miguel Gamondi, now with a perfect record in the Dar es Salaam derbies, secured his third consecutive league win over Simba since taking charge last season. After the match, Gamondi expressed his delight but emphasized that the victory was for the fans.

"We are very happy, but this victory is for the Young Africans fans. They deserve this joy. I want to congratulate my players; they were fantastic today, following the game plan perfectly." said Gamondi in his post-match inter-

Reflecting on the match, Gamondi acknowledged Simba's strong start but praised his players for adapting well.

"We knew Simba would come out aggressively in the first 15-20 minutes, and they did create some chances. But we settled and played well," he added.

Gamondi pointed out that his team improved in the second half, creating more chances and executing their

strategy. "It was a close match, but derbies are often decided by a single moment, and today we took that moment.

He also commended Simba's tactical improvement under head coach Fadlu Davids. "Simba have improved tactically, and it was a fantastic derby. I congratulated Coach Fadlu because it's great to have high-level derbies in Tanzania.'

For Simba, the loss marked their first setback of the season after six matches. Despite dominating early spells and creating chances, they failed to break down Young Africans' defense.

One of Simba's best chances came in the sixth minute when winger Joshua Mutale set up Leonel Ateba. However, Young Africans' goalkeeper Djigui Diara made an impressive double save to deny them the lead.

Young Africans grew stronger as the game progressed, with Pacome Zouzoua's set-piece delivery in the 20th minute giving Prince Dube a header chance that was spectacularly saved by Camara. Nzengeli then squandered a follow-up opportunity by blasting the ball over the crossbar.

Simba continued to threaten, but Young Africans' defense held firm. In the 41st minute, Pacome beat several Simba defenders and set up Aziz Ki, but Camara again made a crucial save to keep the game level.

With the victory, Young Africans sit second in the table with 15 points from five matches, just one point behind leaders Singida Black Stars, who have played six matches.

Young Africans' upcoming fixtures include home games against JKT Tanzania, followed by trips to Coastal Union and Singida Black Stars before a crucial home clash with Azam FC.

Simba, now in fourth place with 13 points, will aim to bounce back with fixtures against Tanzania Prisons, Namungo FC, JKT Tanzania, and Mashu-

As the NBC Premier League heats up, both Young Africans and Simba remain in the title race, with 25 matches left to play. Gamondi, however, remains focused on the long-term challenge ahead.

FIFA gives Lionel Messi, Inter Miami a spot in 2025 Club World Cup

FIFA president Gianni Infantino announced Saturday that Inter Miami will receive a spot in the 2025 Club World Cup, a 32-team, first-of-itskind tournament set to take place in the United States next summer.

Infantino appeared out of nowhere at Inter Miami's victory ceremony on the final day of the MLS regular season – after a 6-2 Miami win and a Lionel Messi hat trick – to make the announcement.

He also said that Miami would host the opening game of the tournament at Hard Rock Stadium, even though Inter had not qualified via any previously announced criteria.

The other 31 teams – Manchester City and Real Madrid, Monterrey and Pachuca, Al Hilal and others – qualified or will qualify on clearly defined sporting merit, mostly by winning their continental championships between 2021 and 2024.

When FIFA finalized the criteria and format last year, though, it left one spot open to a team from the host country, the U.S. It never said how that spot would be allocated.

When asked by Yahoo Sports and others recently when that decision would be made, FIFA spokesmen did not say. People with second-hand knowledge of discussions, however, privately speculated all along that FIFA was searching for a way to get Messi and Miami into the tournament - which has struggled to attract sponsors and broadcasters amid resistance from the European soccer establishment.

When he grabbed a microphone at Chase Stadium to make the announcement, Infantino said that Miami earned the berth by winning the Supporters' Shield, the MLS regular-season title, with a record tally of 74 points.

"Based on this outstanding performance of this year, you deserve to be, and you will be, qualified for the FIFA Club World Cup 2025," Infantino said.

MLS, however, crowns its champion via playoffs, which begin next week. Miami is the top seed, but the Columbus Crew are the defending champions. None of the league's 29 clubs entered the 2024 season knowing that the most points throughout the regular season would earn them a spot in the Club World Cup.

Messi's presence will surely boost the tournament's attractiveness, but will rankle many who believe the final spot should have been awarded based on criteria announced prior to the season or to the MLS champion.

Inter Miami missed out on its one other chance to qualify when it lost to Monterrey in the 2024 CONCACAF Champions Cup quarterfinals.

The only other MLS team qualified is the Seattle Sounders. They secured their spot by winning the 2022 CONCACAF Champions League, and will host all three of their group games at Lumen Field in



Simba coach Fadlu Davids: 'We deserved more against Yanga'

SIMBA Sports Club head coach Fadlu Davids has expressed disappointment following his team's narrow 1-0 loss to arch-rivals Young pecially in such a crucial match." Africans SC (Yanga) on Saturday at Benjamin Mkapa Stadium. Despite the result, Davids believes Simba played well and deserved more from the encounter.

Speaking after the match, Davids highlighted that Simba had several promising moments that could have changed the game's outcome. He pointed out one key opportunity when Lionel Ateba found himself in a good position early in the first half but failed to capitalize.

"We controlled large parts of the game and created some clear chances, especially that moment with Ateba," said Davids. "It's frustrating not to have made the most of that opportunity, as it could have shifted the momentum in our favour."

The South African coach was also critical of the refereeing, suggesting that a key decision went against Simba, affecting the result. He highlighted an incident involving Kibu Denis, who he claims was fouled in the penalty area but did not receive the penalty he felt was deserved.

"There was a clear penalty when Kibu was brought down in the box," Davids explained. "Human error from the referees cost us in that moment, and it's difficult to accept, es-

Despite the defeat, Davids remains optimistic about Simba's progress. He emphasized that his team is steadily improving and heading in the right direction to build a stronger, more competitive side. He acknowledged that while his

players showed promise, the lack of experience in high-pressure matches played a part in their inability to secure a better result.

"We started the game well and had rare chances to go one-on-one with their goalkeeper," he said. "But unfortunately, our lack of experience in finishing off matches let us down. These types of games are important learning experiences for the players, and I believe we are taking steps forward."

Davids added that the team's development compared to previous performances is evident. He remains confident that, with time, the players will continue to grow and gain the experience needed to compete at the highest level in critical matches.

"We're maturing with every game, and I can see the improvement," he said. "Our players are learning and gaining the experience that will help us in upcoming fixtures."

Looking ahead, the Simba coach stressed that it is too early to lose hope in the title race. With many games still to play, Davids urged fans, members, and club officials to stay united and focused on the longterm goal of securing the champion-

"There's no need for panic or frustration after this loss," Davids advised. "It would be a big mistake for our supporters to dwell on the result against Yanga. The season is a marathon, not a sprint, and we are still on track to finish strongly."

Davids also hinted at possible squad reinforcements during the January transfer window to address some of the areas where Simba is currently facing challenges. He acknowledged that certain positions need strengthening to boost the team's competitiveness.

"We'll definitely make some improvements in the squad come January," he said. "We're already identifying areas that need attention, and we want to make sure we are stronger in those positions moving

As Simba SC turn the page on the Young Africans defeat, the team faces a challenging schedule ahead. They will play three more tough matches before the end of the month, all of which are crucial to keeping their title ambitions alive.

Next up for Simba is a tricky away fixture against Tanzania Prisons at Sokoine Stadium in Mbeya tomorrow. After that, the team will return to Dar es Salaam for back-to-back matches against Namungo FC and JKT Tanzania, both of which will be played at the KMC Complex.

With matches coming thick and fast, Davids emphasized the need for full support from fans and club stakeholders as Simba prepare for this demanding stretch. The players will need to recover quickly and remain focused as they compete every few days.

The loss to Young Africans sees Simba drop to fourth place in the NBC Premier League standings, with 13 points from six matches.

As the team regroups for the upcoming fixtures, Davids and his players remain hopeful that they can bounce back and keep their title hopes alive.
