'End all the politicking, as polls are past history'

PRESIDENT John Magufuli yesterday called on Tanzanians to put aside politicking and focus on building the country's economy, saying elections behind are "well and surely behind us".

Dr Magufuli and Vice President Samia Suluhu Hassan took the oaths of office at different times at Dodoma's Jamhuri Stadium, a ceremony that was witnessed by thousands of Tanzanians alongside foreign dignitaries.

He became the first president to take the oath in Dodoma before Chief Justice Prof Ibrahim Iuma, Chief Secretary John Kijazi and his cabinet of ministers, party leaders and foreign guests on the podium.

Addressing the gathering, Dr Magufuli thrice

declared that the election is over and that it is time to focus on building the economy by working hard to ensure all projects in place are implemented as planned.

In brief remarks, Dr Magufuli stated that there was no time to waste haggling about the polls, and it is time for nation building.

"Elections are over. I repeat elections are over. Let us work hard to build this nation, we have a great task ahead," he declared.

The Head of State said his government will immediately work on issues that are crucial for the country's development as promised during the CCM campaign, vowing to work for the country and protect the constitution. "I promise to work with all Tanzanians in building



Pomp and pageantry as JPM takes oath of office

IT was pomp and pageantry as thousands thronged Jamhuri Stadium in the capital to witness a historic moment as President Dr John Magufuli took the oath of office for his second and final term.

CCM supporters who attended the ceremony arrived in their tens of thousands at the stadium, wearing the bright yellow and green colors of the party and waving prototypes of the national flag.

A military band serenaded heads of state from several African countries, including Uganda, Zimbabwe and the Comoros.

"I do swear that I will always, truly and diligently serve the people of the United Republic of Tanzania," Dr Magufuli said, holding the Bible.

Vice President Samia Suluhu Hassan then took the oath, also administered by Chief Justice Prof Ibrahim Juma.

Witnessing the oath were Speaker of the National Assembly Job Ndugai and Chief Secretary John Kijazi, among others.

There was heavy security at the event in which police and special branch officers were at hand for crowd control and any unseemly event, as the stadium gradually filled to capacity, while big screens were insdtalled outside the stadium for other participants to watch.

The military band entertained the crowd as soldiers paraded in different styles to make the event even more colorful, with Dr Magufuli entering the stadium at around 09:42 am in an open military vehicle and went round waiving to the crowd.

Museveni, Mnangagwa hail Tanzania's liberation efforts

UGANDAN President Yoweri Museveni and his Zimbabwean counterpart Emmerson Mnangagwa yesterday spoke fondly of Tanzania's role in the liberation of other

Speaking at the swearing in ceremony for President Magufuli at Jamhuri Stadium, President Mnangangwa who graced the occasion said his country sees Tanzania as a mother of their independence.

He said Tanzania has always stood with Zimbabwe in difficult times, including leading the campaign for the removal of sanctions

against the country by Western powers.

"Tanzania was a centre of Pan-Africanism since those days and Zimbabwe will never forget that, but Tanzania has continued to stand with us all the time including the time of drought when you gave us maize," the Zimbabwean leader said.

President Museveni said he has been a follower of founder president Julius Nyerere, whose the focus was people-centred leadership.

"It is high time Africa formed political parties that put direction on what next after elections because our leaders in the past were in the forefront of putting the African agenda on top of everything,"

ZANZIBAR President Dr Hussein Mwinyi has appointed Suleiman Ahmed Salum his Secretary.

In a statement issued by Chief Secretary of the Revolutionary Government of Zanzibar, said that the appointment has been done as per article number 53 of the Isles' constitution of 1984.

According to him, prior to the appointment, Suleiman was serving as assistant director in the Joint Finance Commission.

Meanwhile, Dr Mwinyi has appointed Mohammed Mahfoudh Nahaat director general of the Zanzibar Ports Corporation (ZPC).

Prior to the appointment, Nahaat worked in various institutions in the private sector.

According to the Chief Secretary, the appointments were effective from November 4, 2020.

On Tuesday, the newly elected president appointed Dr. Mwinyi Talib Haji the new Attorney General (AG) for Zanzibar, replacing Said Hassan Said, who served under the seventh phase government.

According to the statement released by Zanzibar State House and signed by Chief Secretary Dr. Abadulhamid Yahya Mzee, the AG's appointment follows under section 55-1 of the Zanzibar Constitution of 1984.

Prior to the appointment, Dr. Haji served as Deputy Permanent Secretary in the Union Ministry of Foreign Affairs and East Africa Cooperation.

This was Dr. Hussein's first appointment after taking over as Zanzibar President on Monday. He won the top leadership position by 76.27 per cent of the votes in the General Election.

GROUNDNUTS growers have in Dodoma have been called on to accord priority to the crop as it can withstand climate conditions in Dodoma Region.

The advice was given here yesterday by a retired agricultural officer from Chamwino District in the region, Aidan Chaula at a training seminar on groundnuts farming conducted in collaboration with the Naliendele Centre of Tanzania Agricultural Research Institute (TARI-Naliendele) and Tanzania Official Seed Certification Institute (TOSCI).

Chaula said groundnuts is among crops that grows in abundance in Dodoma and if it well managed production could increase substantially.

He said 'mnanje' and 'mangaka' types of groundnuts grow well in Dodoma opportunity in growing groundnuts.

He said the seeds thereof are available at TARI-Naliendele Centre based in Mtwara Region.

He said if groundnuts seeds are planted in December, the farmer is assured of harvests in the following

"The road section is part of the 19 km Likwidi-Mtama road and we residents continue with their economic activities," said Kanyagha.



Ten CCM members get ready to contest top Bunge positions

TEN CCM members are vying for nomination to contest for the posts of Speaker and Deputy Speaker in the next Parliament while one withdrew in last minutes.

Those who vie for nomination include the outgoing Speaker Job Ndugai and his Deputy Dr Tulia Ackson who are defending their previous positions.

Others are David Meshack, the party's Kibamba Parliamentary aspirant who came up 36th in the preferential votes, Stamina Mdolo, Member of CCM Central Committee for Dar es Salaam Region and prominent lawyer.

However, names have not been obtained of those who picked forms from the Dar es Salaam CCM office, while Abdallah Mwinyi who collected forms from Zanzibar CCM office and vied for Speaker's post later opted out.

Speaking to reporters here yesterday after collecting nomination forms Meshack said his aim was to have the opportunity to serve parliamentarians and Tanzanians in general.

"It's not that I'm opposing Ndugai to the position, my aim is to serve

Tanzanians, and if I failed to the nomination to vie for MP, this is my other chance to keep that pledge for Tanzanians," he said.

He said in case he was elected as Speaker; he will ensure the House is managed by standards that abide by its

Speaking after closure of the exercise for collecting nomination forms, CCM Assistant Secretary General Solomon Itunda said until yesterday noon a total of 10 CCM members collected nomination forms.

"The exercise begun November 2 this year and closed today (yesterday) after the party's Secretary General extended the period by one day to enable many more CCM members collect forms to serve their party," Itunda explained.

However, he had no names for other CCM members who had collected nomination forms from the Dar es Salaam CCM office.

On Wednesday. The party's Secretary General Dr Bashiru Ally said the party's Central Committee meeting will be convened tomorrow to pick up candidates for Speaker and Deputy Speaker.



Local govt leaders detained by wildlife officials, set free

AUTHORITIES in Mwanga District, Kilimanjaro Region have released three local government leaders who were detained by the wildlife authorities for allegedly fueling chaos after elephants killed a school teacher in their localities.

Local leaders from villages of Kwakoa, Ngulu and Mkongea in Mwanga District, were detained early this week for inciting villagers to attack wildlife officials when a herd of elephants stormed into their villages killing a school teacher.

Those who were released include Abdalah Hasani, village executive officer of Kwakoa village, Hashim Waziri (VEO) of Ngulu village and Salehe Juma, a local leader at Mkongea village.

Speaking on the incidence, Tanzania's Wildlife anti-poaching unit (KDU) in northern zone Goodluck Nnko urged the public to provide needed support whenever wild animals invade their areas.

Nnko said that leaders of the local government authorities (LGAs) should be in the frontline to influence community members to support to control and take them back to the wildlife activities especially when

animals storm into their settlements.

The leaders were arrested some days ago when a herd of elephant stormed into their areas recently and killed a Kwangu secondary school teacher.

According to him, the villagers caused chaos and restricted wildlife officials from taking the deceased body wanting the elephants also to be killed.

"We will continue educating the public on the importance of cooperating during hard times, whenever elephants storm into villages, the members of the public raise their angers towards wildlife officials, this is not fair because, we have been working hard to fight these incidents," he said.

Nnko said that in the incident, villages attacked and destroyed cars of wildlife officials who went in the village to take the deceased body for further


"In the agreement entered between wildlife authorities and the residents wants the villagers to participate fully in protecting national parks for the country's development," Kayanda

Was World Tsunami Awareness Day - Nov 5 - property marked?

the Japanese words 'tsu' (meaning harbour) and 'nami' (meaning wave). A tsunami is a series of enormous waves created by an underwater disturbance usually associated with earthquakes occurring below or near the ocean.

Volcanic eruptions, submarine landslides, and coastal rock falls can also generate a tsunami, as can a large asteroid impacting the ocean. They originate from a vertical movement of the sea floor with the consequent displacement of water mass.

In 2020, World Tsunami Awareness Day encourages the development of national and community-level, local disaster risk reduction strategies to save more lives against disasters. This year's observance promotes "Sendai Seven Campaign," target.

By the year 2030, an estimated 50 per cent of the world's population will live in coastal areas exposed to flooding, storms and tsunamis. Having plans and policies in place to reduce tsunami impacts will help to build more resilience and protect populations at risk. We therefore ought to you have a national or a local plan in place to anticipate a tsunami?

In December 2015, the UN General Assembly designated 5 November as World Tsunami Awareness Day, calling on countries, international bodies and civil society to raise tsunami awareness and share innovative approaches to risk reduction.

World Tsunami Awareness Day was the brainchild of Japan, which due to its repeated, bitter experience has over the years built up major expertise in areas such as tsunami early warning, public action and building back better after a disaster to reduce future impacts. UN Disaster Risk Reduction facilitates the observance of World Tsunami Awareness Day in collaboration with the rest of the United Nations system.

Tsunamis are rare events but can be extremely deadly. In the past 100 years, 58 of them have claimed more than 260,000 lives, or an average of 4,600 per disaster, surpassing any other

HE word 'tsunami' comprises natural hazard. The highest number of deaths in that period was in the Indian Ocean tsunami of December 2004. It caused an estimated 227,000 fatalities in 14 countries, with Indonesia, Sri Lanka, India and Thailand hardest-hit.

> Rapid urbanisation and growing tourism in tsunami-prone regions are putting ever-more people in harm's way. All earthquakes do not cause tsunamis. There are four conditions necessary for an earthquake to cause a tsunami: The earthquake must occur beneath the ocean or cause material to slide into the ocean. The earthquake must be strong, at least magnitude6.5 on the Richter Scale. The earthquake must rupture the Earth's surface and it must occur at shallow depth - less than 70km below the surface of the Earth.The earthquake must cause vertical movement of the sea floor (up to several metres).

> A landslide which occurs along the coast can force large amounts of water into the sea, disturbing the water and generate a tsunami. Underwater landslides can also result in tsunamis when the material loosened by the landslide moves violently, pushing the water in front of it.

> Although relatively infrequent, violent volcanic eruptions also represent impulsive disturbances, which can displace a great volume of water and generate extremely destructive tsunami waves in the immediate source area.

One of the largest and most destructive tsunamis ever recorded was generated in August 26, 1883 after the explosion and collapse of the volcano of Krakatoa (Krakatau), in Indonesia. This explosion generated waves that reached 135 feet, destroyed coastal towns and villages along the Sunda Strait in both the islands of Java and Sumatra, killing 36,417 people.

Tsunamis caused by extraterrestrial collision (i.e. asteroids, meteors) are an extremely rare occurrence. Although no meteor/asteroid-induced tsunamis have been recorded in recent history, scientists realize that if these celestial bodies should strike the ocean, a large volume of water would undoubtedly be displaced to cause a tsunami.

There just cannot be durable peace with natural resources, ecosystems destroyed

Preventing the Exploitation of the Environment in War and Armed Conflict is an international day observed annually on November 6. The International Day for Preventing the Exploitation of the Environment in War and Armed Conflict was established on November 5, 2001 by the United Nations General Assembly, during Kofi Atta Annan's tenure as Secretary-General. Of this observance Secretary-General Ban Kimoon has since written, "We must use all of the tools at our disposal, from dialogue and mediation to preventive diplomacy, to keep the unsustainable exploitation of natural resources from fueling and financing armed conflict and destabilizing the fragile foundations of peace." Various calendars found on the World Wide Web reference November 6th in abbreviated fashion as 'World Day to Protect the Environment in War'.

Though humanity has always counted its war casualties in terms of dead and wounded soldiers and civilians, destroyed cities and livelihoods, the environment has often remained the unpublicised victim of war. Water wells have been polluted, crops torched, forests cut down, soils poisoned, and animals killed to gain military advantage.

Furthermore, the United Nations Environment Programme (UNEP) has found that over the last 60 years, at least 40 per cent of all internal conflicts have been linked to the exploitation of natural resources, whether high-value resources such as timber, diamonds, gold and oil, or scarce resources such as fertile land and water. Conflicts involving natural resources have also been found to be twice as likely to relapse.

The United Nations attaches great

THE International Day for importance to ensuring that action on the environment is part of conflict prevention, peacekeeping and peace building strategies, because there can be no durable peace if the natural resources that sustain livelihoods and ecosystems are destroyed.

On 27 May 2016, the United Nations Environment Assembly adopted a resolution which recognised the role of healthy ecosystems and sustainably managed resources in reducing the risk of armed conflict, and reaffirmed its strong commitment to the full implementation of the Sustainable Development Goals listed in General Assembly resolution "Transforming our world: the 2030 Agenda for Sustainable Development".

Six United Nations agencies and departments (UNEP, UNDP, UNHABITAT, PBSO, DPA and DESA), coordinated by the UN Framework Team for Preventive Action, have partnered with the European Union (EU) to help countries identify, prevent and transform tensions over natural resource as part of conflict prevention and peacebuilding programmes.

The Environmental Law Institute (ELI), United Nations Environment Programme (UNEP), and the Universities of Tokyo and McGill initiated a global research programme to collect lessons learned and good practices on managing natural resources during post-conflict peacebuilding. This fouryear research project has yielded more than 150 peer-reviewed case studies by over 230 scholars, practitioners and decision-makers from 55 countries. This represents the most significant collection to date of experiences, analyses and lessons in managing natural resources to support postconflict peacebuilding.

F vou read the obituary of Sir Harold Evans, who attained great fame as the Editor of the London Sunday Times and died on 23 September 2020, at the age of 92, you will find an answer to the question. Harold Evans was the journalist par excellence. He'd always wanted to be a journalist, and when he left school at the young age of 16, he enrolled in a shorthand class where all the other students were girls! Ever a lad with a strong mind, he completed the course, undeterred by the teasing of friend and

His first job was on a tiny news paper, the Reporter, published at Ashtonunder-Lyne. Among his assignments on the paper was being sent to cover a visit by General George Carpenter of the Salvation Army.

"When the great man asked the assembled Salvationists whether they had been saved, I explained that I was from the press," Evans recalled later. "But you can still be saved!" said the Salvation Army general.

Evans did not reveal what he would have done, in his days as a great editor, with a story about a Bible-puncher. But he unashamedly became a "missionary" of sorts, himself, when he was appointed, in later life, to edit some of the greatest newspapers in the world. His career in journalism followed service in the British Air Force, during the 2nd World War, and a University course at Ddur4ham.

His most celebrated campaign was one that sought to obtain compensation for the families of children born with deformed limbs, because their mothers had taken a drug called "Thalidomide"

that was widely prescribed to pregnant women in the UK to cure them from "morning sickness".

The drug was distributed by very wealthy drug firms which callously refused to accept responsibility for the children's deformities. When Harold Evans committed The Sunday Times to fighting them on behalf of the distressed families, Evans met with very expensive lawsuits that were instituted against his paper for libel. Both his reputation and his career came under threat because the forces he fought against were so powerful.

He will be remembered for this famous exposé, about hundreds of T

After leaving

Evans fought the companies all the way to the House of Lords, and lost. He could not believe that British judges could shut their eyes at the plight of hundreds of children who were born without limbs, just because powerful drug companies had been negligent.

The cases against the Sunday Times lasted for about a decade. But Evans continued the fight - he took the case all the way to the European Court of Human Rights in Strasbourg. This is what he wrote about what happened

"It was one of the most memorable days of my life when ... I sat in Strasbourg on April 26, 1979, and listened to the conclusion of 'L'affaire Sunday Times'," (Evans wrote). "Twenty judges of the European Court had deliberated. ... Nine of them were against us, including the British judge, but eleven carried violation of Article 10 [of the European the appropriate time.

Convention of Human Rights].

"This meant the House of Lords injunction had infringed our rights to free speech and that the law of contempt would have to be liberalised in Britain in the spirit of the Convention", Evans added.

An obituary in the London Guardian noted that following this victory,"Evans's reputation was at its height. For a decade, he and the team of talented and aggressive journalists he led at the Sunday Times pulled off one triumph after another."

There was the revelation of Kim Philby as the highest-placed Soviet spy in the history of British intelligence; the showing-up as a fraudster of the MP and publisher Robert Maxwell; and the publication, in defiance of the secrecy laws of the British public service, of Richard Crossman's diaries. Evans also became the first British editor to ignore a "D"-Notice that prevented the media from following certain stories allegedly related to "national security".

Evans set up an "Insight" team, made up of very courageous journalists selected from the paper's news staff, whose job was to spend more time than usual, assiduously digging up stories of skulduggery throughout the world.

I had the honour of being commissioned to do two stories for the Insight team - one dealing with Liberian-registered Portuguese oil tanker whose captain sold the oil the boat was carrying, and then deliberately scuppered the boat in West African waters. How I managed to get to Liberia and get the whole story out of the lawyer appointed to defend the court: 'We find there has been a the Portuguese captain, will be told at

I also covered another good story for the paper from Liberia - the Samuel Doe military coup of 1981.

Another story The Sunday Times sent me to do was in Lome, where I was asked to investigate the crashing, at Lome airport, of an aircraft that was carrying a secret cache of arms and - a large amount of currency. The Togolese authorities had hushed the matter up - for obvious reasons! So it was perhaps the most dangerous story I ever covered. For next thing I knew, the Togolese had stationed agents at the Aflao border to arrest me and charge me with espionage (!) when I was leaving Togo! When I got wind of this, I left Lome and got to Accra - by

Certainly, the courage and intellectual honesty of Harold Evans would be difficult to find in any other editors of the 20th century - and that includes the Washington Post editors who blew up Nixon's presidency. For the people whose caused were taken up by Evans and his staff were mostly, the helpless and the cheated.

These included Timothy Evans, a man convicted and hanged in England in 1950, for a murder he did not commit. After Harold Evans and the Sunday Times took up what they considered his wrongful conviction, Timothy Evans was granted a posthumous pardon. His case was one of the factors that persuaded the British Parliament

to abolish the death penalty. No wonder Harold Evans was given a knighthood by the Queen. To him, though, the greatest honour must have been the vote for him, by readers of the UK Press Gazette, that accorded the accolade of "The Greatest Editor That Ever Was."

I am a client of the 2 biggest banks in the country, and I have come to hate their customer care service. However, I need the banks, so I have nowhere to run to.


In the first bank, getting anything done takes hours of queuing. Getting an ATM card replaced just takes

Sundaram said that if the 2008 financial crisis was about digital disintermediation and the 2010 healthcare crisis was about physical disintermediation, the 2020 crisis has been about supply chain or physical distribution chain getting disintermediated.

He elaborated: "Several intermediaries in the ads in the paper through physical value chain would disappear going forward. A countrywide largely distributed product in the physical space like a newspaper has had its challenges during the time of physical disruptions. Some of the changes would be permanent."

evant businesses".

However, he felt that the next big phase of growth in the industry would come not from advertising but from reader revenue, something he said that media houses have "historically been terrible at doing".



Tunisia's political impasse which has resulted in a fragmented Parliament and difficulty in forming a government undercuts any effort at economic reform. Many educated Tunisians want to leave the country and foreigners don't invest.

Tunisia needs a food security policy that doesn't undermine the productivity of its agricultural sector

A large public wage bill and significant subsidies on fuel, food and housing continue to strain government coffers and drive social and regional inequality. This is because of the dispropor-

try, its average incomes are tionate way in which these subsidies benefit the middle class and wealthier sections rather than the poor.

Agricultural vields also remain low (under two tonnes per hectare) despite agriculture consuming 80% of the country's natural water resources. This is especially striking because Tunisia has been experiencing water stress that is projected to worsen with the impact of climate change. So reliance on food imports has steadily increased, leaving Tunisia vulnerable to external shocks such as fluctuating international prices and disruption of supply chains amid declining foreign reserves and COVID-19.

OMAN TO BROADEN FOREIGN INVESTOR ACCESS TO ITS PROPERTY MARKET

man is opening up its real estate market to foreign investors further by allowing them access to a wider selection of residential properties as part of reform measures aimed at improving the country's fiscal position. The move is outlined in the Sultanate's Medium-Term Fiscal Plan, which also confirmed it is looking at introducing a personal income tax on higher earners.

"The Ministry of Housing and Urban Planning is adopting a package of measures that will

work to revive the real estate market in the Sultanate," according to the plan. This includes "opening the door to non-Omanis to own real estate residential units in multistorey commercial residential units in certain areas."

Non-GCC nationals can currently buy property in Oman, but only within integrated tourism complexes (ITCs) such as the Al Mouj and Muscat Hills resorts in the capital and the Salalah Beach Resort. There are 13 ITCs in the Sultanate, according to the tourism ministry's website. The new rules grant rights "to own limited lands and properties within multistorey buildings", explains Aditi Gouri, head of strategic consulting and research at Cavendish Maxwell.

"There are still certain restrictions, whereby the percentage of sale to expats should not exceed 40 per cent of the units in a commercial and residential building, or 20 per cent of a single nationality," she said. Other measures aimed at improving the property market include licensing rent-to-own schemes and allowing payments by instalments.

The real estate market in Oman has "been under

pressure since 2015," as a result of lower oil prices and has been affected further by the Covid-19 pandemic, according to Matthew Wright, head of consultancy at Savills Oman. "Residential rental values in Muscat dropped by an average of 30-40 per cent from 2014 to 2019 and have seen further reductions of 10-20 per cent over the course of 2020," he said.

One key difference with the proposed rules is that residential properties within ITCs provide residency rights, but buying outside will not, which could limit their appeal, Mr Wright said. "We

understand that the Ministry of Housing & Urban Planning may re-assess whether purchasing a property outside an ITC project should include residency rights for non-GCC nationals in the future," he said.

Oman's Medium Term Fiscal Plan sets out a series of measures aimed at reducing the Sultanate's budget deficit by cutting spending and diversifying revenues. Alongside proposals for the income tax on higher earners, Oman will introduce VAT at a rate of 5 per cent from April next year, improve tax administration and collection and look to improve returns from state-owned companies. Reforms to the labour market are proposed to make it more flexible and the Sultanate is planning to allow visa-free entry to more than 100 nationalities to boost tourism.

Oman's economy is projected to shrink 10 per cent this year and 0.5 per cent in 2021, according to the International Monetary Fund's latest forecasts. The fund estimates the Sultanate will run a fiscal deficit of 18.3 per cent this year and that its debt-to-GDP ratio will rise to 81.3 per cent by the end of the year.

According the

government's Medium-Term Fiscal Plan, efforts already undertaken to cut government spending by 10 per cent this year will help reduce the budget by 870 million Omani rials (\$2.26bn). Cutting water and electricity subsidies to zero by 2024 in line with the fiscal plan, will help the sultanate reduce spending by 2.07bn rials and increase revenue by 1.39 billion rials. By adopting measures in the plan, the sultanate hopes to be able to keep debt-to-GDP at about 80 per cent by 2024. Without the measures, it forecasts an increase in the ratio to 128 per cent.

Joe Biden edges closer to victory as Trump mounts legal challenge

WILMINGTON/WASHINGTON

DEMOCRAT Joe Biden moved closer to victory in the US presidential race yesterday as election officials tallied votes in the handful of states that will determine the outcome.

Incumbent President Donald Trump alleged fraud, filed lawsuits and called for recounts in a race yet to be decided two days after polls closed.

The presidential race was coming down to close contests in five states. Biden, 77, held narrow leads in Nevada and Arizona while Trump, 74, was watching his slim advantage fade in must-win states Pennsylvania and Georgia as mail-in and absentee votes were being counted. Trump clung to a narrow lead in North Carolina as well, another must-win for him.

Should Biden win Arizona, he would be only the second Democratic presidential candidate to win the state in 72 years. Trump won it in 2016.

Trump's campaign fought to keep his chances alive with the demand for a Wisconsin recount as well as lawsuits in Michigan and Pennsylvania to stop vote counting. Michigan Secretary of State Jocelyn Benson called his team's lawsuit "frivolous."

His campaign filed a lawsuit in Georgia to require that Chatham county, which includes the city of Savannah, separate and secure late-arriving ballots to ensure they are not

It also asked the US Supreme Court to allow Trump to join a pending lawsuit filed by Pennsylvania Republicans over whether the battleground state should be permitted to accept late-arriving ballots.

The maneuvers amounted to a broad effort to contest the results of a still undecided election a day after millions of Americans went to the polls during the coronavirus pandemic that has upended daily life.

While fighting to stop the count in states where he feared losing, Trump blasted news organizations that projected losses in Arizona and Nevada, states he thought he should be winning. He tweeted his consternation over mail-in vot-

"They are finding Biden votes all over the place -- in Pennsylvania, Wisconsin, and Michigan. So bad for our Country!"

Biden said, "Every vote must be counted. No one's going to take our democracy away for us, not now, not ever. America's come too far, America's fought too many battles,

Biden won Michigan by 67,000 votes, or 1.2 percent, while he was ahead in Wisconsin by just over 20,000 ballots, or 0.6 percent, according to figures from Edison Research, which projected Biden as the winner in Michigan. Several news outlets projected Biden as the winner in Wisconsin,

Wisconsin law allows a candidate to request a recount if the margin is below 1 percent, which the Trump campaign immediately said it would do.

In response to the Michigan lawsuit. Ryan Jarvi, a spokesman for the state attorney general, said the elections had been "conducted transparently."

Voting concluded on Tuesday night, but many states routinely take days to finish counting ballots, bolstered by a surge in mail-in ballots nationally because of the coronavirus pandemic.

Other closely contested states, including Arizona, Georgia, Nevada and North Carolina, were still counting votes, leaving the national election outcome uncertain.

In Pennsylvania, Trump's lead dropped to around 164,000 votes as officials gradually worked their way through millions of mail-in ballots, which were seen as likely to benefit

Tump campaign manager Bill Stepien called the president the winner in Pennsylvania. Biden said he felt "very good" about his chances in the state.

If victorious, Biden will face a tough battle to govern, with Republicans appearing poised to keep control of the US Senate and likely block large parts of his legislative agenda, including expanding healthcare and fighting climate change.

Police arrest 10 in Portland, 50 in NY over post-election violence

PORTLAND

POLICE in the city of Portland made arrests and seized fireworks, hammers and a rifle after late night demonstrations, as Oregon Governor Kate Brown activated the state's National Guard in response to "widespread violence" on the night after voting in the US presidential election.

Portland Police said it arrested ten people in the demonstrations after declaring riots in the city's downtown area while the New York Police Department (NYPD) said it made about 50 arrests in protests that spread in the city late on Wednesday.

"All of the gatherings that were declared riots were downtown. We have made 10 arrests", a Portland Police spokesman told Reuters in an emailed statement.

Demonstrations were also seen in a few other US cities on Wednesday night as activists demanding that vote counts proceed unimpeded rallied in several cities, including Atlanta, Detroit, New York, and Oakland.

Earlier on Wednesday, about 100 people gathered for an interfaith event before a planned march through downtown Detroit, in the battleground state of Michigan, to demand a full vote count and what they called a peaceful transition of power.

Local partners of Protect the Results - a coalition of more than 165 grassroots organizations, advocacy groups and labor unions - have organised over 100 events planned across the country between Wednesday and Saturday.

Heading into the Nov 3 elections, the United States had seen months of protests following the death in May of George Floyd, an African-American who died after a Minneapolis police officer knelt on his neck for nearly nine minutes.

The protests once again picked up momentum following the police shooting later in the year of an African-American named Jacob Blake in Kenosha, Wisconsin and more recently of 27-year-old Walter Wallace Jr. who was gunned down by two officers in Philadelphia.

Portland has seen several demonstrations since Floyd's death, particularly in the city's downtown area, with protests occasionally turning into clashes between demonstrators and police as well as between right- and left-wing

The anti-racism protests have demanded an end to police brutality and racial inequality while the more recent demonstrations surrounding the Nov 3 vote have demanded for a full count of the votes cast on Tuesday

SYRIAN President Bashar al Assad said billions of dollars of deposits held by his countrymen in Lebanon's financial sector that were blocked after a major financial crisis were a main cause of Syria's deepening economic crisis.

Lebanese banks, fearing capital flight and grappling with an acute hard currency crunch, have since last year imposed tight controls on withdrawals and transfers abroad, drawing outrage from local and foreign depositors unable to access their savings.

Assad (pictured) said anywhere from US\$20 billion to US\$42 billion of Syrian deposits could have been lost in the once vibrant banking sector that held over US\$170 billion in foreign currency deposits.

"This figure for an economy like Syria is terrifying," he said

"It's the money they put in Lebanese banks and we paid the price this is the core of the problem that no one talks about," Assad added, speaking during a tour of a trade fair broadcast on state media.

Last month the government faced severe fuel shortages and has been forced to raise bread prices as wheat stocks dwindle, leading to growing disenchantment by a weary population battered by a decade of war.

According to satellite observation, a quarter of the newly added forest areas in the world from 2000 to 2017 came from China, and the country was the largest contributor to global net gain in forest area. The Global Forest Resources Assessment 2020 issued by the Food and Agriculture Organization of the UN fully recognized China's contribution to afforestation and forest protection, and the Australian Financial Review also remarked that China's 40-year and billion-tree project is a role model for the



MANCHESTER United manager Ole Gunnar Solskjaer may have dismissed Roy Keane's suggestion this week that the players would cost him his job but the manner of Wednesday's Champions League defeat supported the former United great's claim.

The Daily Mirror's headline "Dumb and Demba" summed up the embarrassment of the United defence.

They allowed 35-year-old Demba Ba the freedom of the pitch to score Istanbul Basaksehir's opening goal as the minnows of the Champions League group ran out 2-1 winners.

The expensively-assembled defence were exposed again before half-time for Basaksehir's second handing United their first defeat in this season's competition and leaving Solskjaer in deep trouble.

"You wouldn't see this on Hackney Marshes (in amateur football)," said Solskjaer's former United team-mate Rio Ferdinand on BT Sport.

"Where is the defending? There is zero organisation. Where is the person organising that?

"I hope Ole is telling them they are embarrassing him.

Doctor says Maradona recovering well after brain surgery

BUENOS AIRES

DOCTORS treating Argentine football legend Diego Maradona, who had successful brain surgery to remove a blood clot, are "amazed" at the rate of his recovery, his physician said Wednesday.

Surgeons at a private clinic in Buenos Aires spent 80 minutes removing the clot on Tuesday night. "I just saw him, he's switched on,

in a very good mood. We are amazed at how he's healing," said the doctor, Leopoldo Luque, who provided an update on the 60-year-old's condition.

"But we have to be careful because we are still in the post-operative period," he cautioned.

"It is clear that he has no neurological complications," said Luque, speaking to reporters through a mask.

"There are other parameters that we are waiting to evaluate, because it is still very early. But the recovery is excellent.'

The comments sparked loud cheering and chanting from fans of Maradona who have hung banners depicting his glory day outside the

"Once more his health has played a trick on him but he has antibodies to recover with the help of the people," fan Oscar Medina told AFP.

World Cup winner Maradona had been taken to hospital in La Plata -- where he is the coach of topflight side Gimnasia y Esgrima -- on Monday for a series of tests after feeling unwell.

A scan revealed the blood clot, and on Tuesday he was transferred to the clinic in a northern neighborhood of the capital.

"We managed to successfully remove the clot. Diego coped well with the surgery," Luque said in an earlier update. Maradona, who turned 60 on

Friday, has suffered ill health before. He has survived two heart attacks, and also contracted hepatitis and underwent gastric bypass surgery. Following this surgery, fellow

Argentina football star Lionel Messi sent him a message of support.

"Diego, all the strength in the world. My family and I want to see you well as soon as possible," said the Barcelona forward, who like Maradona in his pomp wears the No.10 jersey.

had contributed to his condition. "He's an elderly patient

with many pressures in his life. It's a time when we must help him. It's very difficult to be Maradona," Luque said of the star.

He said it was a condition that also affected Vice President Cristina Kirchner when she was president.

"It breaks my heart to see him like this," Giannina tweeted the next day.

Maradona has difficulty retaining iron due to gastric bypass surgery he underwent in 2005 to lose 50 kilograms (110 pounds), leaving him prone to anemia, Luque said.

Though he has recovered from a welldocumented addiction to hard drugs, Maradona takes medication in the form of tranquilizers and anxiolytics.
