IDA loan finances vehicles for south tourism circuit

WITH the target of making the southern regions a new destination for tourist arrivals, the Ministry of Natural Resources and Tourism has secured 12 tour guide vehicles as part of the resilient natural resource management for tourism and growth project, dubbed 'Regrow.'.

The vehicles will be used to strengthen national parks management by combating poaching in the southern circuit of national parks and game

Handing over the vehicles for the Nyerere National Park tour guide team of the Tanzanian National Parks Authority (TANAPA) priced at 1.2bn/-, Permanent Secretary Dr Allan Kijazi (pictured) said the government expects a rise in tourist arrivals via the project.

A total of 35vehiles are being procured for the Nyerere, Ruaha, Udzungwa and Mikumi national parks traversing Morogoro, Lindi, Ruvuma and Coast regions, where 14 vehicles were procured at 1.6bn/- in the first phase of the plan, nine vehicles in the second part worth 1bn/-, thus using up3.8bn/- ,with the project expected to be extended to Njombe and Mtwara regions, he said.

"The vehicles will contribute in strengthening management of the

PCCB admits: 147 cases are framed

THE Prevention and Combating of Corruption Bureau (PCCB) has dropped 147 cases chiefly made up of trumped up charges against various individuals, President Samia Suluhu Hassan has declared.

The president made this observation yesterday at the official launch of a police uniforms factory in Dar es Salaam, built through force accounts to the tune of 680m/-.

She directed the police to analyze, evaluate and drop charges against various individuals placed in custody when there is no evidence against them.

"I have spoken to PCCB and they have dropped 147 cases which they have trumped up against various individuals. You should also carry self-evaluation and drop the charges if you have no evidence so that we minimize congestion in our prisons," she told the gathered officers.

The president directed the police department to rearrange itself in combating crime, especially armed robbery, noting that she will use someone's ability to control armed robbery to appoint and suspend senior police

President Samia also directed the police to take a look at the law which requires that a victim of an accident or crime gets a PF3 form before such person can be attended by

MPs talk of 'favouritism' Govt endorses expansion in road building projects drive by Kilombero Sugar


THERE are no clear criteria for fairly deciding which regional roads to be built; leaving the room for lobbying and thus favouritism in allocation and disbursement of funds, a section of lawmakers say.

Debating estimates of the Ministry of Works and Transport for the next financial year yesterday, the MPs, including those whose constituencies don't have a single kilometer of tarmac road, cited broken promises running back to the second phase government of President Ali Hassan Mwinyi as illustrating that there is no clear guideline on making decisions on road construction.

Some constituencies and regions have hundreds of kilometers of tarmac roads with more being built alongside regular maintenance, insisted the lawmakers, asserting that "the rumoured favouritism in road construction is not far from the truth."

Godwin Kunambi (Mlimba) said criteria used by the ministry to allocate and disburse funds for roads construction are not known, leaving more questions than answers on the decision-making process.

"What criteria do you use?" he demanded.



The lawmaker was compelled by the Deputy Speaker, Dr Tulia Ackson to withdraw his statement which alleged tribalism and regionalism.

"The tarring of Singida-Hydom-Ilongero road was first promised by President Ali Hassan Mwinyi when I was in standard three. President Benjamin Mkapa came and went; his successor Jakaya Kikwete came and went and finally John Magufuli," said Abeid Ighondo (Singida North).

"The government keeps making promises every financial year but nothing comes out of these pledges."

Kunti Majala (Special Seats) said that the construction of the 461 kilometre Kilindi-Kiteto-Chemba-Singida road was promised by President Mkapa and later President Kikwete as well as the late Dr Magufuli but no work has as yet begun.

"The road has been on the CCM manifesto for decades but nothing has happened so far. There isn't one kilometer of tarmac in Chemba constituency," she said, insisting that "there is favouritism."

Dunstan Kitandula (Mkinga) said his constituency has less than 25 km of paved road heading to Horohoro border, and the rest is gravel or dirt roads. However, despite promises by successive government to improve infrastructure in the constituency, there is no good news as in other constituencies. "There is this talk of favouritism and it cannot be ignored," he declared.

Innocent Bilakwate (Kyerwa) said that despite being one of the main producers of banana and coffee, the state of roads in the constituency is worse compared to many

KILOMBERO Sugar Company (KSC), in which Illovo Sugar Africa holds 75 per cent and the Government of Tanzania 25 per cent of the shareholding, has announced the government's approval of a 571.6 billion/- (US\$238.5 million) sugarcane plantation expansion project.

In line with the country's strategy towards achieving self-sufficiency in sugar supply by2025, the development will increase the firm's sugar production by 144,000 tonnes - from the current level of around 127,000 tonnes per year to 271.000 tonnes.

Gavin Dalgleish of Illovo Sugar Africa has accepted the plan as well as the Treasury Registrar, Athumani Mbuttuka who oversees government shares in the firm, the company said in a media statement vesterday.

This accord was reached at a shareholders meeting held in the city last Friday, with details on the government's position expected later this week, it said.

Expanding sugar manufacturing will require almost a three-fold increase in

Govt endorses expansion drive by Kilombero Sugar

sugarcane supply from Kilombero's small-scale growers, that is, from the current 600,000 tonnes to 1.7m tonnes.

Noticeably, the firm's proposed new sugar factory has been sized so that all of the available cane will be crushed by the end of December each year, the idea being to minimise disruptions and losses often caused by the onset of the rainy season.

The expansion project has been under discussion and planning by the KSC board of directors for several years, the statement noted, underlining that this project takes into account the need for more than doubling sugar production in order to meet increasing customer

Implementing the project will further involve the construction of additional sugar storage and packaging facilities, to reduce costs and increase the company's branded pre-packaged capability, it said.

Also envisaged is the co-generation of electricity for the KSC manufacturing complex and a surplus for feeding into the national power grid, it further noted.

There will be a 4,000-kilolitre increase in the production of ethanol at the adjacent ethanol distillery, bringing the total annual production to 16,000 kilolitres - thus meeting growing local and East African export demand for potable alcohol, it stated.

"The announcement demonstrates the continued support of Associated British Foods, Illovo Sugar Africa's owner, and their confidence in the continued growth of Illovo in the African sugar market," the company

KSC board chairman Ami Mpungwe said that President Samia Suluhu Hassan's profound commitment to the creation of a conducive environment for accelerated private sector growth had encouraged the adoption of

"Underpinned by firm protective measures for Tanzania's sugar industry, it has been decisive in securing theapproval of the shareholders for this transformational project in the country."

Sugarcane growers in Kilombero District, Morogoro Region, will be major beneficiaries as a significant increase in cane supply is required to drive the sugar manufacturing expansion.

Within five years of the commissioning of the new KSC factory, sugar cane volumes supplied by Kilombero growers will triple and thus amounts of money paid to them are slated to reach around 270bn/- by 2028, he said.

The number of small-scale farmers supplying cane to the expanded company sugar factories will rise from 7,500 to anywhere from 14,000 to 16,000 and hence indirectly benefiting an additional 50,000 people in the Kilombero valley covered by sugar sector operations.

There will be an increase in direct employment of over 2,000 jobs at the company and through an expanded grower cane supply line.

The current total taxes of 66.8bn/- paid by the company are estimated to increase three-fold as a result of expansion and improved business performance by

KSC's annualcontribution to the national economy will more than double - from the current 340bn/- to an estimated 750bn/-.

Speaking at the shareholders' meeting, Illovo Sugar Africa shareholding executive Dalgleish said that investing in the expansion project was far the firm's biggest in Africa.

"We are tremendously proud to be partnering with the Tanzanian people in what is a landmark investment aimed at reducing the amount of sugar which has to be imported into the country every year, to meet consumption demand," he said.

"By effectively reducing sugar imports by 144,000 tonnes, our estimates are that Tanzania will be saving \$71m in foreign exchange annually."

The project construction phase is expected to take 25 months, with completion expected in July 2023.

The KSC board and management have commended the project's co-investors and Kilombero sugarcane growers for their involvement in the project.

Studies on the feasibility of more than doubling Kilombero's sugar production began late 2017 and were in tune with the government's national development agenda, the company executive intoned.

More recently, the critical need to further promote foreign direct investment has been reinforced by President Samia's assurances on a conducive environment for large taxpayers and foreign investors generally, he stated.

KSC, which was privatised in 1998, has made significant investments in the business, totalling more than \$166m, for slightly over 20 years.

This has involved various cane and sugar production expansions and the commissioning of a state-of-the-art distillery currently supplying 12 million litres of highquality alcohol to the local beverages industry.

KSC, one of four major local sugar producers, sources half of its sugarcane supply from around 7,500 smallscale farmers in the vicinity of its installations.

The volume of cane bought from local farmers has grown from 140,000 tonnes in 1999 to over 620,000 tonnes at present, with the price paid to farmers put at three times higher than growing rice as a cash crop.

"The price is determined by a revenue sharing arrangement based on total revenue earned by KSC from selling its sugar and molasses, a sugar production byproduct," officials noted.

The government has over the years taken a series of actions towards supporting the local sugar industry, particularly since 2017, with controls on imports the key

KSC's current direct contribution to government revenues comes to about 66.8bn/- (\$29m) in taxes (including VAT, corporate tax, duties, PAYE and the skills development levy) annually.

The firm has also been supporting local schools and hospitals and has facilitated, through its charitable trust and donor funding, the construction of 150kms of roads to help sugarcane farmers transport their cane to KSC factories.

Kikwete calls on Africa to invest heavily in information, communication technologies

FORMER President Jakaya Kikwete has urged the government and stakeholders to invest heavily in Information and Communication Technologies (ICTs) which include connecting schools to the internet so as to facilitate provision of quality education.

According to him, the move also will also facilitate smooth teaching and learning and thus produce well equipped and competent graduates to serve in various fields.

In his remarks to officiate the three-day International Quality Education Conference (IQEC) in Dar es Salaam Dr Kikwete acknowledged that the education sector is still facing various challenges which also need collective efforts to address.

Organised by the Tanzania Education Network (TENMET), the forum brought over 200 participants including key leaders and officials from public, private sector, and Civil Society

Organisations from inside and are not in school due to various outside the country.

He said that if the nation is to achieve its development goals, then investing in quality education is a matter of paramount.

"We should ensure that majority of people at least have secondary education, we should not only base in primary education forgetting the upper education which produces the national workforce," Dr Kikwete said adding; "We don't have any other option, but to strive to improve our education system."

He wanted colleges to invest in technology and skills development so as to produce competent human resources.

The former president acknowledged that most of the developing countries are still lagging far behind developed countries in terms of quality education, something which needs serious efforts to improve.

Dr Kikwete said that despite strides made to improve the education sector, there is still a good number of children who

reasons.

He noted that reports show that globally, 264 million children who were supposed to be in schools are out of school whereby 100 million are from Africa.

"Let us put our efforts together to ensure that our quality children receive education with essential skills to enable them participate well in the country's development once they graduate," he added.

He furthermore urged the government to also consider coming up with ICT solutions to enable sustainable learning of children even during disasters.

"For example when the Covid-19 pandemic erupted, in the developing world, schools were completely closed, but in developed countries, children continued learning smoothly from home, this is because they have invested much in technological systems which enable provision of education even during hard times and disasters," he said.

Nyerere National Park in terms of security, plying of tourists and supervision of road construction projects in the park," he said, elaborating that commercial poaching of wildlife will be further tamed.

By such facilitation the ministry intends to increase the number of tourist arrivals in the southern circuit, as the bulk of current tourist arrivals peaking at 1.5m in 2019 are have the northern circuit as the key destination.

By 2025 tourist arrivals will have crossed the two million mark, with a significant portion of arrivals directed to the southern circuit. It wasn't clear how much the southern circuit could contribute in the project to boost collections from \$2.4bn in 2019 to way over three billion dollars in 2025.

International The Development Association (IDA), the soft loan window of the World Bank, issued a \$150m loan to finance the project endorsed by the government in June 2018, implemented for a period of six

The Regrow project seeks to strengthen the management of national parks and game reserves, promote naturebased tourism in the southern circuit and contribute to the diversification of livelihoods in selected communities. It also highlights tourism related infrastructure.

"It is the government's expectation that the project will open a new chapter for tourism in the southern highlands," Dr Kijazi intoned, expressing the belief that the project shall widen tourism scope now centered in the northern circuit. "Areas with tourist attractions must be developed and placed in the spotlight," he specified.

William Mwakalema, Deputy Commissioner for conservation and business development for TANAPA, said that the project is being implemented with the Tanzania Tourist Board (TTB), the Tanzania Forest Agency (TFS), the National Irrigation Commission (NIC), the board of the Rufiji Basin Development Authority (RUBADA) and THE

Tanzania Wildlife Research Institute (TAWIRI).

the project covers Ruaha, Udzungwa, Mikumi Nyerere, with the three parks already provided with vehicles and other requirements, he said.

The TTB board chairman Judge (ret) Thomas Mihayo urged TANAPA to make good use of the vehicles so that expected results are met, uplifting the Julius Nyerere brand name.

The Nyerere National Park formerly known as Selous Game Reserve is the largest on the African continent, covering an area of 54,600 square kilometers comprising a vast wilderness with forests, grassy plains, mountains and open woodlands.

It was established in 1922 and in 1982 it was declared a UNESCO World Heritage Site thanks to its rich diversity of wildlife and uninterrupted nature. The Tanzanian National Park Authority (TANAPA) in 2019 was authorised to change its identity such that it is today known as the Nyerere National

others.

"Our roads connect to a neighbouring country. The other side looks like Europe but ours is like a dingy street. (The late) President Magufuli pledged that the Omurushaka-Murongo road will be paved and I have seen 3bn/-in the budget; the question is: will it be built?" he asked.

"Some say there is favouritism and there is no reason to believe otherwise," he similarly asserted.

Salma Kikwete (Mchinga) said her constituency is one of those without a single kilometer of tarmac road despite being key producer of cashew nuts and

"There is only a small section which is privately owned," she told MPs.

The former first lady also raised the issue of Kilwa-Kibiti-Mtwara road which she said lacks maintenance despite being vital to trade in the southern corridor as well as linking up with neighbouring countries.

"I have not seen any allocation for the maintenance of this road. This is not fair," she said.

Timotheo Mnzava (Korogwe) said that despite that the Korogwe-Bumbuli road was on the CCM election manifestoes for 2010, 2015 and 2020, and money was allocated for its feasibility study, there is nothing taking place on the ground.

"In his budget speech the minister didn't say anything concrete about this road," he said.

(The late president) Mkapa personally promised the construction of Kibena-Mdete to tarmac level and leaders who followed made the same promise but nothing has happened, said Edwin Swale (Lupembe)

The other issue that featured in the debate is the damage of key roads in cities during rainy seasons. Mariam Kishangi (Special Seats) raised the issue

of Bagamoyo Road which she said is well-built but turns into a river when it rains heavily, leaving a trail of damage that requires costly maintenance. "Was a feasibility study properly conducted

prior to the construction of the road," she queried, raising the issue of headquarters of Ubungo and

Kigamboni districts in Dar es Salaam which she said are new and not easily accessible due to bad roads. Mrisho Gambo (Arusha Urban) said the

constituency has high-quality roads ofy Arusha bypass and Sakina-Tengeru but the problem is that whenever it rains, these roads turn into rivers and are easily eroded.

"We appeal to TanRoads to divert waterways that discharge water on these roads to save costly infrastructure," he urged.

Vedastus Mathayo (Musoma Urban) raised the issue of expansion of Musoma Airport to which 4.2bn/-was released last year to compensate those being evicted but the money remained idle in a bank account. The residents remain in limbo, not knowing whether to continue with economic activities or they are being evicted at any moment, the MP observed.

"The law says that after six months a new valuation must take place. The current minister was the permanent secretary who released the money that is lying idle in a bank account in Musoma," he added.

medical personnel. noting that people lose their lives due to this requirement.

A few weeks ago the president directed PCCB to drop baseless corruption cases as well as those where the evidence was being cooked up.

She also asked the police force to set up a traffic violation identification system wherever a vehicle is passing so that such drivers can be apprehended at their next stop or meeting a police checkpoint and be subjected to appropriate penalties, including revocation of licenses.

She however said that completion of the factory honours the late Dr. John Magufuli, urging other sections of the armed forces to make their uniforms at the factory and cut costs of importing such garments.

Earlier, Inspector General of Police (IGP) Simon Sirro said the construction of the factory has expanded capacity from 70 sewing machines to 130 and increased the sewing to 125,000 uniforms annually.

The police department intends to establish the Tanzania Police Corporation as an income generating unit for the department, he stated.

The IGP assured the president that the country was safe but said however that there are small incidents of crime which are socially based. The police are currently working more closely with police agencies in eastern and southern Africa to control cross border crimes, including drug trafficking and terrorism, he emphasised.

He said crime has decreased from 13.5percent in January to April this year compared to the same period last year and accidents also decreased by 29.1percent.

Funds to construct the factory were generated by internal revenues from security services the police offer to banks and other institutions, he stated.

The factory has the ability to take 250 staff, with 200 sewing machines in readiness, as a basic investment of the Tanzania Police Force Corporation.

Khamis Chilo, the deputy minister for Home Affairs said the country was safe and that Tanzanians continue with economic activities.

"We insist that our people follow what the law says so that we maintain the prevailing peace," he added.

WORLD Wide Fund for Nature (WWF) has donatesd seven motorcycles to the Ednuimet Wildlife Management Area (WMA) and Lake Natron ecosystem to heighten conservation efforts.

The motorcycles are to be used by wildlife rangers at the village level on the patrol to deal with poachers and illegal loggers.

Provision of motorcycles is an implementation of the WWF climate change project aimed at building the capacity of wildlife communities and the people living within the reserves to meet the challenges posed by the effects of climate change including drought and floods.

The Honda motorcycles model weres handed over to Longodo District Commissioner Frank Mwaisumbe whereby three motorcycles are for the Enduimet WMA and four for the Lake Natron WWF issues seven motorcycles to WMA and Lake Natron ecosystem

Handing over the motorcycles, WWF officer Novat Kessi said the organization provided the motorcycles in the belief that they would help in ending poaching in protected areas, but also dealing with illegal loggers and charcoal makers.

"These protected areas are large and have wildlife and forest resources that require village-level wildlife officers to walk long distances in difficult conditions to track down poachers, so we are confident that the motorcycles will facilitate their movements and

keep the areas safe," he said.

DC Mwaisumbe said the time has come for the district to face many incidents of environmental degradation while the district is receiving a small amount of rain which is a sign of the coming drought, urging those entrusted with such equipment to make sure they use them for their intended purpose.

He stressed the need for the district to have a land-use plan as one way to address recurring conflicts between humans and wildlife and promised to work with stakeholders including the WWF

to start early implementation of the plan.

"In her inaugural address, President Samia Suluhu Hassan stressed the issue of environmental protection, and we (Longido District) are practicing it to protect existing resources, including Lake Natron, which is internationally renowned," said DC Mwaisumbe.

For his part, Enduimet WMA manager Peter Milanga lauded WWF for the support which he described as a catalyst for tackling poachers who have grown up, hence using motorcycles will help in curtailing poaching.

Apart from the motorcycle support, WWF is also assisting with various capacity-building including projects, construction of livestock watering dams and the use of innovative stoves to reduce the use of firewood and deforestation, and modern beekeeping.



"The country target is to be in top 50th by 2025, we are still having a long way to go but we are definitely on the way," he said.

According to the deputy minister, the government had made progress in terms of growth of innovation local ecosystem.

He said the report shows that the number of innovation spaces 100 at this moment, noting that it was a good sign that the country was moving in right directions.

Minister warns corrupt officials

THE Minister of State in the Prime Minister's Office (Investment), Geoffrey Mwambe has threatened to immediately sack any official from his ministry who will request corruption from investors.

He also warned some of the staff who gives penalties to investors before even having a discussion with them to know their difficulties after misconduct.

Mwambe made these remarks yesterday in Dar es Salaam when speaking to the management and staff of Tanzania Investment Center (TIC).

The minister said government's services are provided for free and where payment is required should of course be done according to the regulations.

On the other hand, he also warned some of the investors who try to bribe TIC staffs so as to get special treatment regarding investment procedures.

"When I was the Director of TIC some investors tried to corrupt my officers here but they were trustful they came and inform me so I took the money and dealt with them accordingly, it was a big lesson for them not to practice that again," he said.

"I urge you to continue with that hardworking and faithful spirit because this has been our way of doing things for a very long time," he intoned.

Mwambe said even though TIC has limited staff, they must continue to work hard to fulfill the dreams of President Samia Suluhu Hassan by attracting more investment in the country and nourishing the private sector.

Mwambe encouraged TIC

management to collaborate with Tanzania National Business Council (TNBC), to conduct regular dialogue with investors and the business community so that they can find their obstacles.

He said one of the tasks they were given by president Samia is to build trust with investors and the business community so that the government policy on investment could be predictable.

"If you think there is a problem somewhere it is better you call the investor and discuss what went wrong instead of penalizing them without any discussion, we must work hard to ease the way of doing business in our country because otherwise, investors will move elsewhere," he said.

The minister also directed TIC management to make sure they reopen all regional offices by June this year so that it can be easy for the upcountry business community to access TIC services easily.

He said there is a need to promote TIC services by producing public awareness programmes in different media channels.

Deputy Minister William Ole Nasha said their tour at TIC was intended to look at how they can ease the way of doing business in the country.

Young entrepreneurs in Arusha 'drilled' on online marketing skills

TWENTY-five young entrepreneurs in the Arusha region have benefited from training on digital trade organized by the Ubuntu Hub in collaboration with its partners Smart Core Enterprises, Young African Leaders Initiative (YALI), and United States Agency for International Development (USAID).

The one-month training was aimed at equipping young entrepreneurs with online marketing skills—an accelerator that aims to help entrepreneurs from all sectors including agribusiness, retail, juice production to use digital technology to grow their businesses.

Co-founder of the Ubuntu Hub, Collins Kimaro told this paper that Tanzania is gifted with young entrepreneurs who are gifted with good ideas and full of passion but lack sustainable support to help them grow.

"Digital technology is the key to unlocking the doors of many opportunities," he said. Because once trained, they can continue learning on their own," he said.

He also said that digi trade is very important because it serves as a catalyst for economic development. Also because the world is already in the 4th industrial revolution and if we do not develop our capacity we will be behind.

"Especially with the Covid-19 pandemic and its numerous barriers, this calls for a need for people with lesser or no knowledge about the digi trade to be more empowered so as

to effectively do business," he said.

Collins said that digi trade is essential because it will help these young local entrepreneurs to operate efficiently at the low cost because instead of spending huge sums of money to engage in marketing traditional marketing, these entrepreneurs can easily advertise their products online which as a consequence can attract international markets.

He added that their expectations from the trainees are very high as they are hoping that after the training they should be able to grow market and revenue-wise that could lead to job creation and improved service and product delivery.

"Also we are hoping to have a good community of young local Tanzanians who are using digital to be role models for other entrepreneurs in the country," he

Kimaro also calls for a consultative approach from the government so that they can work together to provide a conducive environment for young entrepreneurs. "It takes an ecosystem to raise an entrepreneur," he added.

He encouraged women entrepreneurs to multiply efforts in attending activities organised to help entrepreneurs despite their enormous responsibility in society.

It should be noted that this training which was officially launched last year is organized every month by Ubuntu Hub. Apart from the digi trade training the hub also offers an online sensitization campaigns and markets for database designers and developers.

"Other includes Maternal and Child Health services (MCH), and our target is that the facility will be completed within one year," said Mwira.

He said, apart from the

workforce, every citizen with the ability to work, contributes 24,000/- as well as income from the sale of their resources including sand, stones, and rubble.

"In the construction, I will donate 20 bags of cement and I have already donated five, while MP Prof Sospeter Muhongo has also started by donating 50 bags, and we ask other stakeholders to support us," he said.

ICT Commission: Tanzania has technological infrastructure to put in place modern economy

Pemba to have two ice making plants for preserving fish catches

Tanzania launches strategy to meet demand of China's lucrative soya beans market

THE government has embarked on a special strategy to push for mass cultivation of soya beans in all regions where the economic cash crop flourishes in a move aimed to enable the country to meet the crops' vast market demand in China.

Tanzania has entered into a contract to annually export a total of 400,000 tonnes of soybeans to China but the country's production of the legume crop remains low, only at 14,000 tonnes in a year, the lackluster production which cannot enable the country to service the China contract.

To that end, the government has tasked the Tanzania Agricultural Research Institute (TARI) to coordinate a special strategy which will see mass production of soya beans within the country.

Giving an exclusive interview to The Guardian, National Coordinator of Grain Legume Research at TARI, Meshack Makenge, said the on-going strategy incorporates production and multiplication of enough varieties of soya beans as well as training the farmers on recommended agronomic practices.

He informed that the stateowned institute was currently working round the clock to ensure for mass production of soya beans seeds varieties at it different centers, added: "The focus is to produce pre-basic seeds and distribute them to the Agricultural Seed Agency (ASA) and other seed companies for the seed's multiplication at the level of certified seeds and basic certified seeds,"

Moreover, he stated that the

move will also see the farmers imparted with key knowledge on how to produce quality declared seeds in order to curtail the shortage of soya beans seeds at different areas.

He said presently, TARI has already inverted and produced at least four varieties of soya beans, namely Uyole Soya 1, Uyole Soya 2, Uyole Soya 3 and Uyole Soya 4, however added that other seed producing companies in the private sector have also produced other varieties of the economic cash crops.

"Production of soya beans in Tanzania is currently standing between 2.5 to 3 tonnes per hectare through the use of improved seeds, whereby local varieties are usually producing between 0.3 to 0.5 tonnes in a hectare," he unveiled.

According to him, the regions with friendly weather and soil to support cultivation of soya beans in Tanzania include Mbeya, Iringa, Songea, Ruvuma, Manyara, Arusha and Morogoro.

"Soya beans flourishes well in areas of sandy loam soil which receives rainfall of at least 400 to 800 millimeter," he observed.

Tanzania is the third country in the world for the production of legume (pulses) after India and Myanmar.

According to Deputy Minister for Agriculture, Hussein Bashe, in March this year Tanzania exported the first consignment of 140 tonnes of soybeans to China. China annually spends more than USD40m/- to import soybeans and Tanzania is among the 12 countries so far greenlighted to export the crop to China.



Experts' recommendations valid, but vaccines issue not that easy

of coronavirus vaccines has now been properly recommended by a panel of experts essentially based at the Muhimbili University of Health and Allied Sciences (MUHAS), which has a well established department of epidemiology and infectious diseases as a whole. There is also no doubt as to where international opinion and expectations stand at the moment, given fairly strict terms of travel from one country to another, and especially in intercontinental travel, where 'vaccine passports' are coming into daily use. Older testing, quarantining is relatively out of fashion save for neighbouring states.

What remains is a situation where people will be making individual decisions regarding being vaccinated or not taking the jab, with wider logistics likely to determine which jab or more will be available at the local level, their pricing and all. It doesn't seem that pricing will be quite at issue, as global efforts are very much underway to make plenty of vaccines available for African countries, and some are already some steps ahead in accessing jabs. We have a wider choice here as coronavirus isn't quite visible in most neighbourhoods, at any rate compared with some of the horror stories that we watch on foreign channels.

The mainstay of the report that the team of experts handed to President Samia Suluhu Hassan at a State House function early in the week had to do with more practical issues of updating coronavirus data and being open about the issue. The way we handled the issue more or less corresponded with overall caution with what the media can report online on their own without

LLOWING importation having the matter or data verified by top level authorities, which stifled any meaningful follow up on those issues. But as they say, actions speak louder than words, thus if there was a widespread pandemic no one could hide it, and the fear would be visible.

> What is unsettling about the situation at the moment as compared to elsewhere in the world is that we are relatively safe but we dare not proclaim ourselves that way, as more robust variants of the Covid-19 original virus are being hatched on a day to day basis. What is worse; experts say that vaccinated people are safe only in regard to the original virus against whose 'spike protein' the vaccine was made, and that exposed to other variants, their safety level can be compromised. It is also due to this reason that earlier formulas that it is those above 65 who were more in danger is rapidly being scaled back, to wider caution.

> That is why it is hard to think of a vaccination effort that anywhere compares with what is happening in the major Western countries where the pandemic has perhaps been more intense, apart from India and Brazil for that matter. In the United States it has now been decided that children above 12 years of age can also be vaccinated, and there are open - and often hidden - reports of complications arising from vaccination for all sorts of groups or individuals. The blood clotting phenomenon has received plenty of attention but there are other drawbacks, like significant impairing of neuro-physiological inputs among those exposed to the vaccines. No one knows which type is more virulent for which drawbacks and for what sorts of ages or blood groups, as all these vaccines are mostly experimental, used as an emergency.

Cashing in on cashews: Africa ought to add value to its nuts

FRICA grows most of the world's raw cashews, but only processes a fraction of them, missing out on opportunities offered by rising global demand, according to a report by the United Nations Conference on Trade and Development. In Tanzania, the cashew crop is usually cultivated in the southern coastal regions of the country, near the towns of Mtwara, Kilwa and Dar es Salaam. The sale and marketing of the product is run by the Cashewnut Board of Tanzania, through various farmer

The global market for cashews is booming, but the African countries growing more than half the world's supply aren't cashing in due to their lack of processing industries, the **UNCTAD** report titled Commodities at a Glance: Special issue on cashew nuts said.

Cashew nuts have been grown in Tanzania on a commercial scale since the 1950s. Due to developing infrastructure and lack of jobs in the southern region, cashew cultivation was highly favoured. The zone was also previously used as part of the failed Tanganyika Groundnut scheme. The industry's production peaked in 1973, when the total output exceeded to a record breaking 145,000 tonnes.

Tanzania is one of the largest cashew producers in Africa, with exports providing 10-15 per cent of the country's foreign exchange. The country is the eighth-largest grower of cashew nut in the world and ranks fourth in Africa. The country provides 20 per cent of Africa's cashew nut and only trails in production of Nigeria, Cote D'Ivoire, and Guinea-Bissau, according to figures released in 2012 by United Nations Food and Agricultural Organisation (FAO).

The country has been engaged in the production of the cash crop since before independence in the years 1960s however, poor regulation and lack of reliable payments to farmers have posed significant challenges to the cashew nut farming industry in Tanzania. Guinea-Bissau, a country a tenth of the area of Tanzania's, has a significantly greater yield.

The cash crop is usually cultivated in the southern coastal regions of the country, near the towns of Mtwara, Kilwa and Dar es Salaam. The sale and marketing of the product is run by the Cashewnut Board of Tanzania, through various farmer co-operatives. More than ninety per cent of the exports are destined for India and almost entirely in raw form. The lack of domestic processing firms costs the country vital foreign revenues and thousands of jobs. The Tanzanian government has been facing challenges for finding potential investors in order to revive the cashew processing industry in

About 20 million jobs are at risk in Africa as the continent's economies were projected to shrink in 2020 due to the impact of the coronavirus pandemic, according an African Union study. Up to 15 per cent of foreign direct investment could disappear, the study found.

Between 2000 and 2018, world trade in raw cashew nuts more than doubled to 2.1 billion kilogrammes, and African producers - led by Côte d'Ivoire - accounted for almost two-thirds of the growth. But the continent's farmers and exporters receive only a fraction of the final retail price, the report said.



How long will a healthy older person live? A substance in blood could provide a clue

evels of a substance in the blood of nonagenarians (aged between 90 and 99) and centenarians (aged at least 100) accurately predict how much longer they're going to live. The substance comes from the brain.

The findings, in a study published in Nature Aging, could prove useful in developing life-extending drugs. They also raise questions about the brain's role in aging and longevity.

The study, conducted by Stanford investigators including neuroscientist Tony Wyss-Coray in collaboration with researchers in Denmark and Germany, zeroed in on a substance whose technical name is neurofilament light chain (abbreviated as NfL).

A structural protein produced in the brain, NfL is found in trace amounts in cerebrospinal fluids and blood, where it's an indicator of damage to long extensions of nerve cells called axons.

Axons convey signals from one nerve cell to the next and are critical to all brain function. You'd rather they remain intact

High NfL levels in the blood have previously been associated with Alzheimer's disease, multiple sclerosis, Huntington's disease, amyotrophic lateral sclerosis (Lou Gehrig's disease) and other neurological disorders. But the people monitored in the new study were generally pretty healthy for their age.

The researchers first looked at 122 people whose ages ranged from 21 to 107, and found increasing blood levels of NfL - as well as increasing variation among individuals - with increasing age.

Next, the scientists followed the fates of 135 people aged 100 or over for a four-year period. Most of those centenarians were in good shape to begin with, as shown by their performance on standard tests of mental ability and by a measure of their capacity to meet the routine demands of daily living.

Not unexpectedly, those whose mental tests indicated impairment had more NfL in their blood than did those with the sharpest minds. And those with low levels were substantially more likely to live longer than those with high levels.

A look at people in their 90s confirmed the findings in the over-100 group. Blood NfL levels among 180 people aged 93 not only predicted the duration of these folks' survival but also did so better than did mental or daily-coping test scores.

The investigators showed that blood NfL levels in mice too increase with age. But cutting their caloric intake, beginning in young adulthood - already known to prolong the lives of mice and numerous other species - chopped the little creatures' blood levels of this substance in half in old age. However, this new finding doesn't prove that lowering NfL blood levels causes increased longevity, but it's consistent with it.

At a minimum, NfL appears to accurately flag the approach of mortality. That means that it might be possible to monitor it as a surrogate marker for remaining life expectancy, much as blood cholesterol levels are used as proxies for cardiovascular health. If so, it could someday help drug developers assess life-extending interventions' efficacy.

Clinical trials of interventions believed to enhance longevity have been impractical, because it would almost certainly take so long to get a statistically significant result that such trials would be hugely expensive a major hang-up for pharmaceutical firms considering investment in longevity drugs.

But monitoring a proxy such as NfL could cut years off the duration of such trials, perhaps encouraging drug developers to dive into the clinical arena with life-prolonging pharmacological candidates.

Possibly most intriguing of all: The new findings hint that maintaining a healthy brain in old age is the best route to a long life.

"It will be interesting to see how and why the brain might be so important in counting down our final years and months," Wyss-Coray said.

The other brain you didn't know you had...

magine, if you will, a recipe you know well. Something delicious you've never made yourself but have seen your mother or some other person make many times.

Let's assume it's pumpkin pie. The recipe calls for canned pumpkins, heavy cream, eggs, cornstarch, sugar and, maybe, even a touch of nutmeg.

You've seen that person make it more times than you can count. Geez, you could practically make it yourself from memory.

But what if in reality, as it turns out, that the person's pumpkin pie also requires sardines. Almost as much of sardines as pumpkin. And, to your dismay, the pie just won't work, it just won't taste like pumpkin pie, without it.

In a way, that's kind of the situation with the brain. Most people know that the brain consists of a huge interconnected network of neurons.

More often than not neurons are equated with the term 'brain cell', and used interchangeably. But this is not just misleading, it's completely wrong.

Neurons are, of course, the critical players that determine how the brain learns and processes information. But they are by all means not the only type of cell in the brain.

There are roughly 85 billion neurons in a typical adult brain. But there are also another 86 billion cells in the brain that are not neurons.

The main non-neuronal cell type are glial cells. They are the unexpected sardines in our pumpkin pie.

There are three major classes of glial cells. Oligodendrocytes speed up electrical signalling in some neurons. Microglia act as the immune cells of the brain and spinal cord, because the normal immune cells and antibodies in your blood don't have access to the isolated chemical environment of the central nervous system. Astrocytes are the third important class of glial cell.

Roughly speaking, there are about as many glial cells in your brain as there are neurons. And roundabout 20 to 40 per cent of glial cells are astrocytes.

It's the astrocytes I want to focus on here. Without them, neurons would not be able to function properly. But more than that, astrocytes contain the molecular machinery capable of listening in on neuronal signalling, and modulating it.

They form a very large network onto themselves, capable of communicating with each other at the same time that they cross-talk with the neuronal network.

We literally have a second net-



work in our brains that plays a critical role in maintaining brain health but which also affects learning and information processing in ways we do not yet understand.

If you haven't heard of astrocytes, or only have in passing, you're in good company. This is because the truth is that even though we know quite a bit about their molecular biology, biophysics and chemical makeup, neuroscientists still have no real idea how they interact and influence neuronal signalling and information processing.

There are a number of ideas and hypotheses, as well as accumulating data, but we lack anything close to a coherent mechanistic understanding of their computational role in the brain. This is one of the most exciting areas of neuroscience at the very boundary of our knowledge about the brain.

German pathologist Rudolf Virchow first described neuroglia in 1858 as a "substance... which lies between the proper nervous parts, holds them together and

gives the whole its form in a greater or lesser degree".

The term 'glia' meanwhile has the same origin as the word 'glue', since it was initially thought that neuroglia were just there to bind neurons together.

Of course, glial cells do much more than that. In particular, the classical role of astrocytes is providing homeostatic support for neurons. These cells support and maintain a chemical environment around neurons that allows them to function properly.

Because neurons are electrically excitable cells - they communicate between each other by passing signals and messages encoded as fluctuating changes of electric potential across the cell membrane - they are susceptible to becoming overly excited and activated, leading to an inability to function properly.

For example, lingering amounts of neurotransmitters, the signalling chemicals that pass messages between neurons, or excess amounts of sodium and

potassium ions, the carriers of electric charge in neurons, run the risk of confusing how neurons interpret messages, and can also over-excite them to the point that the cells can dio

Astrocytes form a network onto themselves, separate from the neuronal network. In order to maintain a homeostatic environment for neurons, astrocytes 'mop up' these excess chemicals and shuttle them internally through their network to blood vessels.

The cells that make up the last layer of the astrocyte network send out processes called endfeet that come into close contact with blood vessels. These 'waste' chemicals are effectively dumped into the blood stream and whisked away.

In the reverse direction, astrocytes shuttle glucose and related energy byproducts from the blood stream to areas of high neuronal activity, where neurons hard at work need energy the most.

But the functional role of astrocytes extends beyond homeostasis. In the early 1990s neuroscientists recognized that the neurotransmitter glutamate, one of the most important and ubiquitous excitatory neurotransmitters released by neurons, was capable of activating astrocytes and inducing long-range

signalling within astrocyte networks.

In other words, it turns out that

astrocytes have the ability to eavesdrop and listen in as neurons talk to each other. However, while neurons communicate with each other via electrical excitation, astrocytes communicate via waves of calcium activity.

What's arguably even more amazing is that astrocytes don't just detect neurotransmitter signalling between neurons but they also have the capability to release neurotransmitters that reciprocally affect how neurons respond.

In effect, astrocytes have the ability to modulate and shape information processing in the brain. When neurotransmitters are released by astrocytes, they are referred to as gliotransmitters in order to differentiate them from the neurotransmitters secreted by neurons. But they are chemically the exact same thing.

The intimate association between neurons and astrocytes is mediated by a concept referred to as the tripartite synapse, or three-part synapse. A synapse is the connection point where two neurons meet and pass signals between each another.

When a neuron becomes electrically excited, a wave of electrical

activity propagates down its axon until it reaches the synapse, which in turn triggers the release of neuro-transmitters that act as a chemical message.

In a tripartite synapse, a part of the astrocyte wraps around the neuronal synapse in order to listen in and participate in the signalling process.

And as if this weren't enough, a single astrocyte can extend multiple tentacle-like arms to different synapses, so it can participate in many tripartite synapses.

One implication of this fact is that an astrocyte may have the potential to functionally connect pairs of neurons that normally would not be connected.

It's possible that synaptic signalling at one tripartite synapse that has an effect on the astrocyte leads to its modulating a different synapse the astrocyte it is connected to, even though the pair of neurons in the second synapse isn't actually connected to the first pair. In effect, an astrocyte can 'short circuit' the neuronal network.

Admittedly, though (again), to what degree astrocytes modulate neuronal signalling and what ultimate affect they have on how the brain processes information - how it learns, or how it influences your decision making - is subject to speculation at this stage.

We just don't understand this aspect of the brain well enough yet. By extension, we have even less understanding of what roles astrocytes might play in complex neurodevelopmental and neuropsychiatric disorders such as autism or schizophrenia.

Astrocytes can even modify synaptic plasticity - the 'strength' of the connections between neurons.

Beyond neuroscience and the biological brain, incorporating astrocytic-like elements into artificial neural networks might have implications for future instantiations of machine learning and artificial intelligence.

In fact, there are some early indications in attempts at building neuronal-astrocyte-like artificial neural networks that suggest an improved performance on classification tasks. Machine learning and artificial intelligence in general have much to learn from the biological brain.

The brain has a long history of challenging neuroscientists in their attempts at figuring out how it works, and how it fails in diseases. Nowhere is this more true than in our attempts at understanding what the humble and quiet astrocyte is actually doing.

Ending violence and harassment against domestic workers crucial

ONSERVATION, Hotel, Domestic and Allied workers Union (CHODAWU) has called on the government to put in place mechanisms that will regulate and provide legal protection for domestic workers.

The Union said because they are poor, many domestic workers don't know their rights, as such they are constantly being harassed and their rights violated without legal aid or protection.

CHODAWU coordinator for Zanzibar Francisca Cammilius said recently during a meeting in Dar es Salaam that the government should also regulate young girls working as domestic workers to protect them from regular violence and harassment.

She said there are a number of young girls and even boys who are forced to move from rural areas to urban in search for domestic work where they experience harassments and torture but end up helpless and in abject poverty.

She said some girls are trafficked to go and work abroad especially Arab countries where they are abused and their rights violated. Some are picked up from rural areas to go and work in urban areas without knowing their rights hence end up being exploited. "Many times you will hear people saying I want you to bring me a house girl who is still young. I don't want old woman. I want young girl who don't know anything so that I can manage her. This means that these helpless

children end up being exploited continuously," she said.

"Besides violence and harassments, many teenagers are not paid, and live desperate life and even when they want to go back home, they are never helped anyhow," he said.

Normally domestic workers suffer from poor working conditions and that their isolation makes it difficult for the government and other stakeholders from making intervention.

"We need to improve working conditions of domestic workers. They have their rights like any other human being. They need to have contracts so that they can be legally protected," she said.

In a separate interview, Fatuma Mohamed, a woman from Ilongelo village, Singida region said a couple of years ago, she came to Dar es Salaam to work as a house girl. She experienced violence and harassment. She was regularly beaten until she developed hearing-impairment. She was then fired from work without payment. She went back to the village with the help of other people and since then, she has never got legal aid to claim her rights.

"My parents divorced, I lived a very difficult life, I decided to sell firewood to raise some money and came to Dar es Salaam. I ended up being a house girl. But the children and relatives of my boss especially boys were bullying, abusing and beating me and even after being fired, I did not get paid," she narrated.

Commenting on violence and harassments, Advocate Annery Nahum said there is a need to

raise awareness and to educate

the general public on their right as

advocated in different international conventions.

He said there is also a need to ensure the international convention on violence and harassment is respected. According to him, the ILO C. 190 seeks to ensure rights of the people and that justice is done at work places. The leaders, employers and the employees must all together and individually prevent, refrain from, and address violence and

harassment at work places.

"The convention points out that people need to promote an environment of zero tolerance to violence and harassment at work places," he stressed.

laces," he stressed. Women and local rights programmes oversight Manager at Actionaid, Amne Manangwa said the convention on violence and harrasment is so important for the general public to understand because it touches social welfare and the life of communities regardless of their status or nature of their work.

"It focuses on raising and providing protection to all employees regardless of their employment arrangements whether formal or informal to ensure that working environment does not attract any form of violence and harassments," she said.

Goal 5 of the 2030 Agenda includes as targets: ending all forms of discrimination against all women and girls everywhere, eliminating all forms of violence against all women and girls in the public and private spheres

Do the police make South Africa safe?

here is almost no research evidence that policing in South Africa reduces crime or improves feelings of safety. Does this mean that police have no positive impact? Not at all. Rather, the link between their activities and goals has not been competently shown. But working together, South Africa's police and research community can change this.

In the 2019/20 financial year, the South African Police Service's (SAPS) 187 000 employees spent roughly 365 million hours and R96 billion trying to achieve their goals. Among their many reported activities, they stopped and searched 6 289 939 vehicles and 3 802 393 individuals.

Police carried out 5 736 264 visits to shopping complexes, 4 519 733 visits to spaza shops, and 5 736 246 visits to ATMs. They convened 32 769 roadblocks, and arrested 1 133 891 people for 'serious crimes'. Did these activities make South Africa safer? Possibly, but nobody really

Researchers and police tend to interpret their observations in a way that supports their preconcep-

For the past three years, the Institute for Security Studies (ISS) has been encouraging the generation of research evidence related to police work in South Africa, or evidencebased policing, including through three new reports. Unlike in a criminal investigation, 'evidence' in this case means knowledge gained through critical thinking and observation. It requires curiosity and scepticism from police, collaboration with researchers, and a willingness to be proven wrong.

For example, if a commander has the sense that vehicle theft declines when patrol officers keep their blue lights on, this should be tested. When careful observation and evaluation suggests a relationship between visible police lights and vehicle theft, these tactics should

be encouraged. When research and assessments don't support intuition, practices must be rethought, retested or abandoned.

South Africa is not short on crime and policing research. However, almost none of this work demonstrates a link between police activities and four areas of change that are key to measuring impact: levels of crime, fear of crime, feelings of safety or trust in police. We know plenty about things that aren't working well in South African policing, but neither law enforcement officials nor researchers have rigorously shown what works to achieve specific goals.

Police experience and intuition aren't enough for deciding how to spend a R100 billion budget

To change this, police and researchers must find a common language for collaboration. They must craft questions that seek to demonstrate the relationship between different police activities and their intended impact and partner to explore them. Results should be written up and disseminated in ways that make them useful and accessible to police.

Such research needs to be more intentional and methodologically rigorous than much of what has come before. This is because all of us - researchers and police included - have a strong tendency to interpret our observations in a way that supports our preconceptions.

For example, if a police commander sees a drop in crime after a

change in deployment strategy, they will probably assume the difference is a result of their actions. However, a critical review of the data and context may reveal the cause to be something else - perhaps officers chose not to record all reported crime, or weather conditions meant fewer people on the street, or the closure of a local liquor shop.

This is not to say that police experience and intuition aren't crucial they are. But when deciding how to spend over R100 billion, manage almost 190 000 employees, and fill nearly 400 000 000 hours of occupational time, the focus must be on effectively and efficiently improving public safety while causing as little harm as possible. This objective is even more important given the budget cuts facing the SAPS in the current financial year.

South Africa needs to promote a police culture based on evidence and critical thought

For this, we need evidence generated through intentional, careful observation and research. Only studies that explore a causal relationship between a particular police activity or strategy and a dependent variable (e.g. crime levels, safety perceptions, fear of crime and/or satisfaction with police) can determine what works in policing and what doesn't. This is the approach that South Africa's police and researchers should pursue.

Flour price goes up Sh⁹ driven by expensive maize

The price of flour has increased by up to Sh9 for a two kilogramme packet on high cost of maize, a move likely to spark a rise in inflation.

Millers are not getting sufficient grain at the market as farmers horde their produce in anticipation of high prices in future, pushing a two kilogramme packet of Jogoo brand to Sh109 from Sh102 last month, while Soko is retailing at Sh110 from Sh105 in April with Ajab going for Sh114 from Sh107 previ-

A 90kg bag of maize has now hit Sh3,000 from Sh2,500 a month ago as millers grapple for limited stocks in the market. "Farmers are not releasing maize to the market after the restrictions were imposed on Uganda and Tanzanian maize, pushing up the cost of the raw material," said Ken Nyagah, chairperson of the United Grain Millers Association.

Producers are anticipating that the price of maize will go up in the coming days following a low flow of imports from Uganda and Tanzania with Kenya having received a relatively good harvest last year. Data from the Ministry of Agriculture indicated that growers

have been holding 16.7 million bags of maize as at the end of April out of 17.7 million bags that was in the country.

High cost of food is set to put pressure on inflation, which dropped marginally to 5.76 percent last month from 5.98 percent a month earlier, in what the Kenya National Bureau of Statistics attributed to a decline in food prices. In consumer basket, food and non-alcoholic beverage forms the bulk at 32.91 percent. This means a person with Sh100 will spend Sh33 on food.

Other key drivers of inflation include fuel and electricity. Last month the government froze an increase of fuel prices following an outcry from the public. However, the price of petrol was increased in the latest review with a litre of petrol going up to Sh126 from Sh123 previously.

African rainforests slow climate change despite record heat, drought

Africa's tropical forests appear more resilient as carbon sinks than Amazonian rainforests - mopping up planet-warming carbon dioxide even when sizzling El Nino heat halted absorption in other parts of the world, researchers said on Monday.

They studied the impact of the worst El Nino weather event on record - in 2015-16 - on intact rainforests in six

African nations: Democratic Republic of the Congo, Gabon, Cameroon, Ghana, Liberia and Congo Republic.

El Nino is a warming of ocean surface temperatures in the Pacific that occurs every few years. It affects wind patterns and can trigger both floods and drought across the world. The new study found that trees in the African forests continued to remove carbon dioxide from the atmosphere, despite experiencing drought

and a warming of 0.92 degrees Celsius above the 1980-2010 average temperature.

"We saw no sharp slowdown of tree growth, nor a big rise in tree deaths, as a result of the extreme climatic conditions," said Amy Bennett, lead author of the study and a professor at Britain's University of Leeds, in a statement. "Overall, the uptake of carbon dioxide by these intact rainforests reduced by 36%, but they continued to function as a

carbon sink, slowing the rate of climate change.'

According to the research, the forests across Africa still removed 1.1 billion tonnes of carbon dioxide annually during the 2015/16 El Nino period - equivalent to three times Britain's CO2 emissions in 2019. Researchers said their findings were surprising because similar conditions in rainforests in the Amazon and Southeast Asia had led to a temporary halting or reversal

of carbon dioxide absorption.

"This is the first on-theground evidence of what happens when you heat and drought an intact African rainforest," said Simon Lewis, the study's senior author and also a professor at the University of Leeds. "What we found surprised me. African rainforests appear more resistant to some additional warming and drought compared to rainforests in Amazonia and Borneo."

It was difficult to determine the temperature that the forests would completely stop absorbing CO2, said researchers, but a previous study showed they started to lose carbon at around 32.2C (90 degrees Fahrenheit). The study's findings highlight the important role that African rainforests play in combating climate change, but also the need to ensure they are protected, said the reports'

"The resistance of intact African tropical forests to a bit more heat and drought than they have experienced in the past is welcome news," said co-author Bonaventure Sonke, who is a professor at University of Yaounde I in Cameroon. "But we still need to cut carbon dioxide emissions fast, as our forests will probably only resist limited further rises in air temperature."

Heineken makes move on Distell, owner of Hunter's, Savanna

Heineken, the world's second-largest brewer, has approached South African wine and spirits maker Distell Group. In a statement, the local company said Heineken wants to buy the "majority of Distell's business."

Distell owns brands like Savanna, Hunter's and Klipdrift. "Shareholders are advised that Heineken N.V. has approached Distell regarding the potential acquisition of the majority of Distell's business. Bearing in mind that there can be no certainty that an agreement will be reached, shareholders are advised to exercise caution when dealing in their Distell securities until a further announcement is made," Distell said in a statement.

Distell has a market value of about R31.8 billion. A takeover would be Heineken's most significant transaction since 2018, when it agreed a partnership with China Resources Beer Holdings, maker of the country's best-selling beer. A transaction would add to \$7.4 billion of deals announced in the global beverage industry this year, according to data compiled by Bloomberg. That's about 15% less than at this point in 2020, the data show.

Heineken is emerging from one of the beer sector's toughest crises. Despite gains in Vietnam and Mexico, the brewer is still facing setbacks in key markets such as Brazil and the UK where restrictions on movement and sales have hurt demand. Earlier this year, the company laid off 8,000 employees. Still, it surprised analysts in April with stable first-quarter sales, as emerging markets made up for declines in Europe.

South Africa was one of Heineken's best-performing markets, which is surprising given the country's recurring ban on alcohol. Another driver was China, where bars and restaurants have reopened than elsewhere in the world.

Any deal for Distell would see Heineken Chief Executive Officer Dolf van den Brink, who took charge last June, accelerate the decades-long strategy of his predecessor Jean-Francois van Boxmeer. During his tenure, van Boxmeer sought to tap growth opportunities in Africa, investing hundreds of millions of euros in promising markets such as Cote d'Ivoire, Nigeria and South Africa.

Tourism revenues will remain subdued in 2021 even in the most optimistic scenario, resulting in a slower growth in tourism-dependent economies, according to the Institute of International Finance (IIF).


The economic recovery in countries dependent on the industry will be slower as external pressures are set to rise on weaker domestic revenues but rebounding imports as economies emerge from pandemic-induced lockdowns.

"While the situation remains difficult for the tourism industry at this point, there appears to be some hope of recovery due to vaccination efforts gaining momentum and fewer (travel) restrictions being discussed for vaccinated individuals," the report said. "However, we find that even a relatively fast rebound of tourism would leave many countries in a precarious position in 2021, both with respect to economic growth as well as external vulnerabilities."

travel recovering later next year or earlier in 2023, tourism numbers are likely to remain 70-80 per cent below pre-pandemic levels in many countries this year, the report said.

The slow recovery of the sector will also have a major impact on tourism-dependent countries. Although many emerging markets have witnessed an improvement in current account balances because imports fell alongside exports, the collapse in tourism revenues in countries such as Thailand, was much greater than the fall in imports than in many of its peers.

"These current account improvement[s] reduced external financing needs in a time of risk-off sentiment in global financial markets. However, import volumes are increasingly recovering from the

France to lend Sudan \$1.5bn to clear IMF debt

KHARTOUM

France will lend Sudan \$1.5 billion to help it clear its debt to the International Monetary Fund, the French government said.

On Monday, Paris hosted a conference to support Sudan's transition to democracy after decades of authoritarian rule under dictator Omar Al Bashir, who was ousted in 2019. Khartoum hopes the talks in Paris will help it clear some of its foreign debt, estimated to be at least \$60bn, after decades of isolation.

Sudan's Prime Minister Abdalla Hamdok listed a series of significant economic challenges his transitional government inherited, including a collapsed economy, empty treasury, and severe shortages of basic commodities such as fuel, bread and medicine.

He also mentioned the challenges

faced by rampant inflation - currently above 300 per cent - and a weak exchange rate, problems exacerbated by Covid-19 and devastating country-wide floods last autumn. His government has put in place a series of economic policies in recent months, including a managed flotation of the Sudanese pound - a key demand of the IMF.

About 38 per cent of Sudan's debt is owed to the Paris Club, a body made up of major creditor countries. "It's important that the direction of courageous economic reforms you have started implementing continues to guide the transition," French President Emmanuel Macron said.

"The reduction of the Sudanese debt that we'll start soon is a first result of these reforms and the return of Sudan in the international community must be strengthened at the economic and political level." Mr Hamdok said sustaining peace in Sudan required "a functioning if not strong economy".

"Therefore addressing the geopomic

"Therefore addressing the economic crisis has become our top priority," Mr Hamdok said. He pledged a "clean break" with the past in an effort to achieve long-term development and peace, and said the removal of Sudan from the US list of state sponsors of terrorism was a "game changer."

But Mr Hamdok lamented the vast number of Sudanese people who have attempted to cross the Mediterranean Sea in search of a better life in Europe. "I can't stress enough the need to build a productive economy ... creating jobs for our young people is one of the most important priorities.

"We would like to create those opportunities for our young talent to stay in the country and build it with us, rather than taking this extremely difficult and dangerous journey across the

Mediterranean. General Abdel Fattah Burhan, the head of the ruling sovereign council, praised a "historic opportunity" for Sudan and shared a "message of peace and of co-operation."

Mr Macron described Sudan's transition as "an inspiration". The international community, he said, had a collective responsibility to help the country achieve its ambitions. "Despite the difficulties, considerable progress has been made since the fall of the old regime," Mr Macron said.

French Finance Minister Bruno Le Maire expressed similar sentiments. "Rebuilding an attractive and resilient market takes time but today I hope we will convince private investors that the fundamentals for business are fully there," he said. Speaking before the conference, Mr Hamdok said he was seeking investment to help rebuild Sudan's devastated economy.

World's oranges, coffee at risk as Brazil runs out of water



oils are parched and river levels are low in the nation's Center-South region, a powerhouse of agricultural output. Brazil, the world's biggest exporter of coffee, sugar and orange juice, just had a rainy season that brought hardly any rain.

Soils are parched and river levels are low in the nation's Center-South region, a powerhouse of agricultural output. The drought is so severe that farmers are worried they'll run out of the water reserves that help keep crops alive over the next several months, the country's

Mauricio Pinheiro, 59, started irrigating his Arabica-coffee crops in March, two months earlier than normal, after his 53-hectare (131-acre) plantation got less than half of the rain it needed. He's using so much water for the plants that there isn't enough left for his home. In order to keep the showers and faucets running, he's had to search for another

"My irrigation reservoir is drying up now – that usually happens in August," said Pinheiro, who lives in Pedregulho in

the Alta Mogiana region, in Sao Paulo state. "I'm really concerned about running out of

water in the coming months." The prospect of withering orange trees and coffee plants is coming at a time when agricultural crops are rallying to multiyear highs, which has fanned fears of food inflation. Higher food costs may exacerbate hunger, a problem around the globe that the Covid-19 pandemic has made more acute. Coffee and raw-sugar contracts on the ICE Futures exchange in New York have already touched four-year highs.

If even irrigated areas can't get enough water, Brazil's coffee and orange output may decline for a second year in a row. Brazil's current orange crop shrunk 31% from the previous season, the most in 33 years, and production of Arabica coffee, the high-end kind used by chains like Starbucks Corp., is also dropping sharply.

Rainfall was disastrously low for many areas in Sao Paulo and Minas Gerais from January to April, said John Corbett, Chief Executive Officer at a Where Inc. The worst hit areas received less than half of normal precipitation, at a critical time when coffee plants need moisture for the beans to grow. It is also a period when the soil stores water to cope with the dry season. That came on top of adverse drier-than-normal conditions in some parts last year, notably in Sao Paulo and Parana, said Paul Markert, meteorologist for Maxar Technologies Inc. in Maryland.

While a dry spell is typical for this time of vear in Brazil, it's expected to last longer than usual, adding to concerns. Regular rains will return to the region between October and November, instead of September, said Celso Oliveira, a meteorologist at Somar Meteorologia. About 30% of Brazil's orange crop and 15% of arabica coffee fields are irrigated. "The levels of rivers and lakes has been very concerning," said Regis Ricco, director at Minas Gerais-based RR Consultoria Rural.

Francisco Sergio de Assis, a coffee grower in Monte Carmelo, a municipality in the Cerrado region of Minas Gerais, started irrigating his fields a month early, and doesn't think his water reservoirs will last if it doesn't rain by September.

The situation is becoming critical for orange groves. Emerson Fachini, an orange farmer who cultivates 45 hectares in Palestina municipality in Sao Paulo state, said he's had irrigation systems turned on for most of the time since January. "Water reservoirs are drying up, depleted just ahead of the dry season," Gilberto Tozatti, of Sao Paulo-based GCONCI-Group Citrus Consulting, said by phone. "The situation is affecting most of Sao Paulo state and still harming next season's crop."

Rishi Sunak confronts Joe Biden tax plan over lack of levy for digital tech firms

Britain's Chancellor of the Exchequer Rishi Sunak is pushing for a fairer way to tax the digital economy following US President Joe Biden's call for a global minimum business tax rate of 21 per

Mr Sunak is concerned the rate may be too high in the long term, despite the UK's pledge to increase corporation tax to 25 per cent in 2023 to help Britain's coronavirus-ravaged economy recover. While the government supports a multilateral approach to this behaviour. After a year in achieve a coherent international tax system that fairly taxes large multinational digital companies, it has also led international efforts to ensure large digital businesses pay more tax in the countries in which they operate.

"The UK has been proactive in pressing for an international solution to the tax challenges posed by digitalisation of the economy for a number of years. And the Chancellor has made it a key priority of the UK's G7 presidency," a Treasury representative said.

"We welcome the US administration's renewed commitment to reaching a solution to these challenges through the OECD (Organisation for Economic Cooperation and Development). It's also crucial that any agreement includes changes to ensure digital businesses pay tax in the UK that reflects their economic activities." Under Mr Biden's plan, the world's 100 most profitable multinationals would pay taxes to national governments based on the sales they generate in each country, no matter where they are based.

The blueprint would see the establishment of a global minimum tax rate to help bring an end to profit-shifting, where companies base themselves in countries with lower tax rates. Tax campaigners said the Biden administration plan would raise £13.5 billion (\$19.04bn) a year for the UK by US

tech companies operating in the country, such as Facebook, Amazon, Apple and Google owner Alphabet, paying higher tax bills and helping to "level the playing field" for British businesses. "Nothing angers the British public more than multinationals like Amazon, Google and others paying ultralow levels of tax," Tax Justice UK

"The Biden plan is a once-ina-generation opportunity to put that right. The US president has proposed a new global minimum tax rate for companies to tackle which many big tech firms have done well, we need to build back better and move beyond our outdated global tax system."

Britain's Treasury said that finding an international solution to taxing the digital economy is a key priority as the UK looks to put in place a competitive tax regime that not only supports growth but also reinforces the UK's attractiveness as a place to do business. At a Wall Street Journal summit last week, Mr Sunak said Britain's approach to a digital tax was about "finding a way of appropriately and fairly taxing large international digital companies.'

While talks led by the Organisation for Economic Co-operation and Development are under way, with finance ministers from Germany, France and the Netherlands welcoming the move as a way to prevent tax avoidance by big companies and digital firms, tax campaigners say Britain has been quiet on the matter.

Paul Monaghan, chief executive of the Fair Tax Foundation, said Britain was the "laggard" of the Group of Seven allies, and that Mr Sunak's proposed higher headline rate of UK corporation tax was "an irrelevant distraction." "We're talking about a minimum," he said. "It would mean it wasn't worth anyone's time shifting profits to Ireland or the Cayman Islands."

Israel-Gaza violence shows signs of slowing as global diplomacy ramps up

GAZA/TEL AVIV

MORE than a week of fighting between Israel and Hamas showed few signs of abating yesterday despite intense U.S. and global diplomacy to stop the region's fiercest hostilities in years.

The Israeli military said late on Monday that Hamas and other Palestinian groups had fired about 3,350 rockets from Gaza - 200 of them on Monday alone - and that Israeli air and artillery strikes had killed at least 130 militants.

Gaza health officials put the Palestinian death toll at 212, including 61 children and 36 women, since hostilities began last week. Ten people have been killed in Israel, including two children.

Amid seemingly fruitless diplomatic efforts to stop the violence, the top U.S. military officer, Army General Mark Milley, warned that the violence could spread.

"My assessment is that you risk broader destabilization and you risk a whole series of negative consequences if the fighting continues," Milley, chairman of the Joint Chiefs of Staff, told reporters before landing in Brussels on Monday for talks with NATO allies. "It's in no one's interest to continue fighting."

Israeli air strikes on the Palestinian enclave continued overnight. Soon after dawn, missiles struck two buildings in Gaza City, sending plumes of thick smoke into the air.

Militants in the Strip fired rockets early yesterday that set off sirens in southern Israeli cities, sending thousands running for bomb shelters.

There were no immediate reports of injuries on either side.


The overnight rocket fire from Gaza appeared to be less than in previous nights. There was a six-hour lull in rocket fire overnight before they again began being launched at dawn, according to rocket siren information from the Israeli military.

A Reuters correspondent also reported a lull in overnight rocket fire from Gaza, an enclave home to two million Palestinians.

Diplomatic efforts

US President Joe Biden expressed his support for a ceasefire during a call with Israeli Prime Minister Benjamin Netanyahu on Monday, the White House said in a statement.

But Netanyahu told Israelis earlier that strikes against militant sites and



leaders in Gaza would carry on.

"The directive is to continue to strike at terror targets," he said in a televised speech, after meeting with military and intelligence chiefs. "We will continue to act as necessary to restore peace and security to all residents of Israel."

The armed wing of Hamas promised more rockets in return: "The criminal Zionist enemy intensified its bombing of homes and residential apartments in the recent hours, and therefore, we warn the enemy that if it did not stop that immediately, we would resume rocketing Tel Aviv," said spokesman Abu

US Secretary of State Antony Blinken urged all sides to protect civilians. Although stressing that Israel had the right to defend itself, Blinken said he had not seen any evidence from Israel about its suggestion that Hamas was operating out of a building housing media outlets - including the U.S.-based Asso-

ciated Press - which was destroyed in an Israeli missile strike at the weekend. Hamas denied having offices in the building. "These are false allegations and an attempt to justify the crime of targeting a civilian tower," said Hamas spokesman Fawzi Barhoum.

Egypt and U.N. mediators also stepped up diplomatic efforts, while the U.N. General Assembly will meet to discuss the violence on Thursday.

The Biden administration approved the potential sale of \$735 million in precision-guided weapons to Israel, and congressional sources said on Monday that U.S. lawmakers were not expected to object to the deal.

Communal violence

Hamas began its rocket assault last Monday after weeks of tensions over a court case to evict several Palestinian families in East Jerusalem, and in retaliation for Israeli police clashes with Palestinians near the city's al-Aqsa Mosque, Islam's third-holiest site, during the Muslim holy month of Ramadan.

The hostilities between Israel and Hamas-controlled Gaza have been accompanied by an uptick of violence in the West Bank, where the Palestinians have limited self-rule.

There have also been clashes between Israel's Jewish and Arab communities

in mixed areas. Israel's president has warned that tension between Jewish and Arab Israelis

could devolve into "civil war". General strikes are planned for Tuesday in Arab towns within Israel and Palestinian towns in the West Bank, with posts on social media urging solidarity "from the sea to the river."

Spain deploys army to Ceuta after Morocco migrants break in

MADRID

SPAIN has deployed troops to Ceuta to patrol the border with Morocco after thousands of migrants swam into the northern African enclave amid heightened diplomatic tensions, Interior Minister Fernando Grande-Marlaska said vesterday.

Footage from local Faro TV channel showed soldiers in armoured vehicles guarding the enclave's beach as dozens of migrants emerged from the water while hundreds of potential migrants stood on the order on the streets. One per-Moroccan side of the fence between the enclave and Mo-

Soldiers started patrolling the border along with Spanish police, Grande-Marlaska told state broadcaster TVE. As many as 6,000 Moroccans, including about 1,500 minors, swam into Ceuta on Monday and Tuesday, he said.

A spokesman for Ceuta's government delegation said soldiers will also work with police in sensitive locations within the enclave to maintain

The arrival of the migrants took place at a time of increased tension between Spain and Morocco over the fate of Brahim Ghali, the leader of the Western Sahara's Polisario Front, who is in hospital in

Morocco's Foreign Ministry issued a strongly worded statement last month deploring what it said was Spain's decision to admit Ghali under a false identity without informing Morocco, adding that the situation would have repercussions for bilateral relations between the countries.

The United States in December recognised Moroccan sovereignty over the Western Sahara territory, which is also claimed as an independent state by the Polisario Front.

Young entrepreneurs from Hong Kong, Macao flock to S China's Guangdong to start up businesses

YOUNG entrepreneurs from China's Hong Kong and Macao Special Administrative Regions are flooding into entrepreneur hubs in south China's Guangdong province as China speeds up the construction of the Guangdong-Hong Kong-Macao Greater Bay Area (Greater Bay Area).

With a series favorable policies and supportive measures, they are going all out to pursue their dreams in this megalopolis that consists of nine cities in Guangdong province and the two special administrative regions in South China.

Three years ago, young entrepreneur Shay Liu from Hong Kong came to Guangdong with a new optical material her company had independently developed. Now, she has become a star entrepreneur at the Guangdong-Hong Kong-Macao Greater Bay Area (Guangdong) Innovation and Entrepreneurship Incubation Base.

"The Greater Bay Area has created an extremely huge development platform for young people from Hong Kong and Macao. Young people like me should try our best to not fail the times," she said.

At the Guangdong-Hong Kong-Macao Youth Innovation and Entrepreneurship Workshop, an entrepreneur base located in Futian district of Shenzhen, Guangdong province and covers an area of 3,500 square meters, every startup can enjoy individualized services that cover the whole industrial chain.

The young entrepreneur base, which is less than three years old, has attracted 21 business teams that have close connection with Hong Kong and Macao, in AI, Internet of Things (IoT), medical technology, and new materials industries. Six of them have generated over 10 million yuan (\$1.55 million) of output.

At the entrepreneur base, Ding Ke, a graduate of the Chinese University of Hong Kong, founded the Shenzhen HinYeun, Technology Co., Ltd., a firm that develops AI products.

The entrepreneur base enjoys a series of advantages, such as a solid industrial foundation, complete supply and industrial chains, rich sci-tech resources, and a sound environment of entrepreneurship, Ding told People's Daily. Xie Zhiheng from Hong Kong runs a company that has deployed business teams in Hong Kong, Shenzhen and Dongguan, Guangdong province.

According to him, the Hong Kong team, in cooperation with local universities, is responsible for algorithm researches, while the Shenzhen team focuses on software designing. The Dongguan team manages production and supplier relations. Now his products have been purchased by over 60 hospitals.

As a frequent traveler among the three cities, the man now calls the Greater Bay Area his home. "Sci-tech innovation is a synergetic process, and it's not very possible that a single city can meet all demands," he said.

After graduation, Zhang Siyuan from Macao joined the ZLF Law Office in Hengqin New Area, Zhuhai, Guangdong province as an apprentice lawyer.


The law firm is run under Chinese mainland-Hong Kong-Macao cooperation, and has three lawyers from the mainland, 11 from Macao and 16 from Hong Kong.

The abundant opportunities there are drawing many young people from Macao, Zhang pointed out, adding that he hopes it can be a place where his dreams come true. In recent years, a comprehensive transport network has been taking shape in the Greater Bay Area, enabling a "one-hour traffic circle" for major cities in the region, which has ushered in a new era for the integrated development of Guangdong, Hong Kong and Macao.

The Guangzhou-Shenzhen expressway, which was officially put into operation on July 1, 1997, the day that marked Hong Kong's return to the motherland, is the first expressway jointly invested in and constructed by Guangdong and Hong Kong.

Connecting Guangzhou and Shenzhen's Huanggang port with just a 1.5-hour drive, it not only bridges the two metropolitan areas of Guangzhou and Shenzhen, but also serves as a "gold channel" that facilitates the flow of innovation resources and production factors among Hong Kong, Macao, and the nine cities in Guangdong involved in the Greater Bay Area.

The busy expressway is of great significance for powering the economy in Guangdong province and Hong Kong, said Wang Wei, an executive with the Guangzhou-Shenzhen-Zhuhai Expressway Co., Ltd., the operator of the ex-**People's Daily** pressway.

UK jobless rate falls again, hiring up as lockdown eases

LONDON

BRITAIN'S unemployment rate fell again to 4.8% between January and March, when the country was under a tight lockdown, and hiring rose further in April, according to data that showed employers gear-

ing up for the easing of curbs. Some of the fall in the unemployment rate - the third in a row - was due to a rise in people not looking for work, with inactivity rate among men hitting a record high, echoing a pattern seen during Brit-

ain's first lockdown last year. But analysts said the data showed

the labour market was preparing for the end of many of the curbs imposed by Prime Minister Boris Johnson in January, thanks to the country's swift COVID-19 vaccination programme.

"As the economy prepares to re-open fully and economic activity picks up, businesses have increased their hiring to meet the rise in demand," Yael Selfin, chief economist at KPMG UK, said.

The unemployment rate was likely to peak at 5.9% in the three months to December, after a jobs furlough programme ends in September, she said.

The number of people in employment in the first three months of 2021 jumped by 84,000, the first increase since the pandemic hit Britain and a bigger rise than the Reuters poll forecast of a 50,000. Those classed as unemployed fell by 121,000.

APRIL HIRING INCREASE

Separate data for April showed a further improvement in the labour market with people on company payrolls up 97,000 from March.

The rise was driven by hiring in the administration and support and the finance and insurance sectors, although the fall in hospitality - which partially reopened for outdoor service in April - was the smallest during the pandemic.

That narrowed the drop in payrolls numbers from February 2020 to 772,000, the Office for National Statistics said.

The Resolution Foundation think tank said that gap, combined with an estimated drop of 270,000 self-employed workers and 3.1 million workers still on furlough, meant Britain still had a 4.2 million 'COVID employment gap' to fill.

The payrolls data chimed with other recent signs of a hiring pickup and there was a rise in job offers in hospitality and entertainment.

However, some employers are struggling to fill vacancies with many foreign workers no longer in the country after the on-off closing and reopening of many firms over the past year, and as a result of Brexit.

The Bank of England this month slashed its forecasts for unemployment to show a peak of 5.4% in the third quarter after finance minister Rishi Sunak extended his jobs protection programme - which has cost more than 60 billion pounds (\$85 billion) so far - until the end of September.

Britain's budget forecasters projected unemployment of 10% made shortly after the epidemic began.

Britain's headline measure of pay growth, including bonuses, rose 4.0% in the three months to March, slowing from 4.5% in the three months to February due to lower bonuses than a year ago.

The ONS said total pay growth, adjusted for a drop in the number of lower-paid and part-time jobs which have been hit hard by the pandemic, stood at 2.5%.

Biden administration approves 735m USD arms sale to Israel - media

WASHINGTON

THE Biden administration greenlighted 735 million U.S. dollars sale of precision-guided weapons to Israel, U.S. media reported on Monday.

Citing sources familiar with the matter, the Washington Post reported that Congress was officially notified of the proposed sale on May 5, nearly a week before the conflict escalated between the Israeli forces and Palestinian militants in Gaza.

The proposed sale includes the joint direct attack munitions (JDAM) and GBU-39 small diameter bombs, according to the report.

The Hill noted in a piece that the window for Congress to block the sale is all but closed. "The notification earlier this month set off a 15-day clock for Congress to act. There are

four days left in that window, and it takes 10 days once a resolution of disapproval has been introduced before someone can force a vote to bring it to the floor.

"Some Democrats raised concerns about the sales as the Israeli military continued its airstrikes in Gaza, causing civilian casualties.

"While I have supported security assistance to Israel, including by funding the Iron Dome defense system, I have serious concerns about the timing of this weapons sale,' House Democrat Joaquin Castro said in a statement."

The message it will send to Israel and the world about the urgency of a ceasefire, and the open questions about the legality of Israel's military strikes that have killed civilians in Gaza," he added. Xinhua

Russia decides not to block Twitter after company deleted over 91% of prohibited content

MOSCOW

THE Russian authorities decided not to block Twitter after the social network had removed over 90% of the illegal content, the Federal Service for Supervision of Communications, Information Technology, and Mass Media said on its website on Monday.

The watchdog decided to stop decelerating Twitter's loading speed for desktop traffic, but to keep the slowdown for mobile traffic.

"The check showed that Twitter moderators removed over 91% of the prohibited information. At the moment, 563 posts with child pornography, drugs and suicide related content, calls on minors to participate in unauthorized mass events and also extremist and other pieces of content prohibited on the territory of the Russian Federation remain undeleted," the regulator says.

The watchdog decided not to block the service, remove restrictions on access to it on desktop computers, while maintaining the slowdown of social network traffic on mobile devices.

The agency stressed that in order to completely remove the restrictions the social network should remove all identified prohibited materials, as well as respond to the department's requirements no later than 24 hours from the moment of their receipt.

The agency mentioned a letter it received from the company. In that letter Twitter administration confirmed that it shares attempts to combat prohibited content and will take all necessary measures to remove it. It emphasizes that the management of the social network is interested in building a constructive dialogue with the Russian regulator.

The agency praised the efforts Twitter had already made to comply with the requirements of Russian legislation.

The watchdog also said that measures to restrict traffic, similar to those used in relation to Twitter, can be extended to Facebook and YouTube. This will happen if the services do not remove illegal content.

On March 10, the media watchdog announced that it had begun to initially decelerate Twitter's loading speed in Russia because the service did not remove content prohibited in the country. The agency promised to take further measures to influence the social network even going as far as imposing a block).

On April 5, the watchdog decided to extend the slowdown measures until May 15. The decision was made after the social network had begun a dialogue and removed a significant part of the prohibited content.

By the time the agency took these initial measures of the beginning of the application of restrictive measures, the department demanded that the social network remove more than 4,100 prohibited pieces of content identified since 2017. In addition, since the start of the service traffic slowdown, about 1,800 new prohibited posts have been identified.

100 years on, memories for Chinese communist pioneers still cherished in Europe

PARIS/MONTARGIS/LYON

NEARLY a century after the founding of the Communist Party of China (CPC), some of the party's pioneers, who were then just young students studying abroad, were still remembered by many in Europe with fondness and respect.

As the CPC celebrates its centenary this year, Xinhua revisited some of those places with footprints of the party's founders and early leaders across the continent, to dig out stories about the early days of the world's largest political

PARIS

A small room on the ground floor of Hotel Neptune in downtown Paris witnessed the life of Zhou Enlai, the first premier of the People's Republic of China (PRC), in his youth.

Zhou, born in 1898, lived here from 1922 to 1924 when he was among the thousands of progressive young Chinese who went to Europe under the Diligent Work-Frugal Study Movement to search for the future of the then-impoverished China.


In this small room which could barely accommodate a bed, a desk and a chair, Zhou studied and worked tirelessly, writing for a progressive newspaper based in north China's Tianjin to promote new ideas he learned in Europe, and organizing communist activities.

Nearly 100 years later, now the hotel is run by Chinese-French Li Jianle, who believed that it is his obligation to protect the historic building and present it to both Chinese and foreign guests when he bought the hotel in 2001.

Today, with a bronze statue of Zhou carved by noted French sculptor Paul Belmondo in 1979 on its wall facing the street, the about 160-year-old building on rue Godefroy, Paris remains intact, standing to tell the story of its former tenant.

MONTARGIS

It was also in France that late Chinese leader Deng Xiaoping, the architect of China's reform and opening-up, estab-



at the museum of Franco-Chinese Friendship in Montargis, France. (Xinhua)

lished a lifelong friendship with Zhou. has also briefed them on the history Deng, six years younger than Zhou, was among the more than 200 Chinese students who worked at Hutchinson factory by then on the outskirts of Montargis, a small town about 100 km south of Paris, said Wang Peiwen, president of the China-France Friendship Association in Montargis.

"My grandfather used to work there, too," said Lea Pereira, a high school student at Lycee en Foret in Montargis.

In an interview with Xinhua, Pereira said her grandfather told her about Deng and other young Chinese communists. At 18, Deng lived in a wooden shed with his colleagues, worked 10 hours a day from Monday to Friday, and a half day on Saturday, for an hourly wage of one franc.

"I'm impressed by the horrible working conditions that Deng had to endure," said Pereira's classmate Flavien Gavoille. "I also admire him because he was never discouraged, and he successfully achieved his goals: by having completed his study in France and coming to know the communist ideology."

The two teenagers are among dozens of Chinese language learners at of the Chinese students who worked and studied in their hometown Montargis.

The small town with a population of 15,000 bears marks of that period of history: the square in front of the central railway station is named after Deng Xiaoping. A massive monument was erected there in 2019 to mark the 100th anniversary of the Diligent Work-Frugal Study Movement.

At Durzy Park, a black-and-white photo records a meeting held here in July 1920, when Chinese students in France gathered for five consecutive days discussing ways to save the Chinese nation. They proposed the founding of a Marxist party to lead the country.

At the end of the five days, Cai Hesen, a student leader, reported their ideas to his friend Mao Zedong, who readily accepted the proposal. A year later, the CPC was founded. Jean-Louis Rizzo, a retired history professor of Paris Institute of Political Studies (SciencesPo), compared the students' ideas in Montargis to "leaven" and an "embryo" of the CPC.

"It is a fantastic story: you initially Lycee en Foret. Their Chinese teacher have young people, little politicized,

who arrived in France where politics was gaining in importance, with port and mine workers going on strikes," said Rizzo. "The agitated social atmosphere in France had its impact on these young Chinese who were then working in French factories and enduring the same plight as the workers on strike."

As a result, the young Chinese became more politically sensitive and learned to analyse the political situations before they were drawn by Marxism, he said.

LYON

For Sonia Bressler, a French philosopher and essayist, the Chinese students' stay in France and their encounter with Western culture helped introduce new ideas to China. "This page of history also highlights the deep root of the friendship between the two countries," she said.

This period of history also left its traces in Lyon, the third largest city in France where some Chinese students once fought for their right to study in 1921, when they were rejected by the Franco-Chinese Institute, a school built with funds from China and exclusively for Chinese

"It was a fight for equality and justice, as the students were fighting for their own rights to study," said Alain Labat, head of the Federation of Franco-Chinese Associations and vice-president of the New Franco-Chinese Institute.

US to share COVID-19 vaccines with other countries under mounting pressure

WASHINGTON

THE United States will share 20 million more doses of its COVID-19 vaccines with the rest of the world by the end of June, said President Joe Biden on Monday.

The announcement came under mounting international pressure that Western wealthy nations which have stockpiled vaccines far more than they need should share more doses with countries struggling with the pandemic.

"We have the vaccine. We've secured enough supply to vaccinate all adults and children above the age of 12," Biden said during a White House address. "We know America will never be fully safe until the pandemic that's raging globally is under control," said Biden, whose administration had initially been reluctant to send any doses overseas.

World Health Organization (WHO) Director-General Tedros Adhanom Ghebreyesus on Monday repeated his calls for manufacturers and high-income countries to share their doses with COVAX."There's a growing disconnect. Some countries with high vaccination rates appear to be in the mindset that the pandemic is over, while others are



experiencing huge waves of infection. The pandemic is a long way from over, & it won't be over anywhere until it's over everywhere," tweeted Tedros.

The vaccines Washington is to ship overseas will consist of leftover doses from either Moderna, Pfizer-BioNTech or Johnson & Johnson, which are authorized by the U.S. Food and Drug Administration to use in the country. Earlier, the Biden administration has made commitment to send 60 million AstraZeneca vaccine doses overseas. The AstraZeneca's shot has not been cleared by FDA yet.

Biden said on Monday that the 80 million doses will represent 30 percent of the vaccines produced by the United States by the end of June.

As of Monday morning, the United States has administered more than 272 million COVID-19 vaccine doses and distributed more than 344 million, showed data from the Centers for Disease Control and Prevention advantages, then the virus gets

The Biden administration has

set a goal of getting 70 percent of the country's adult population to receive at least one dose of a COVID-19 vaccine by July 4. The FDA expanded its emergency use authorization for Pfizer's CO-VID-19 vaccine to include people 12 to 15 years old last week. The country's confirmed CO-

VID-19 cases went further down over the weekend. The nationwide average is at about 33,200 new cases per day, the lowest level since late June, showed data compiled by Johns Hopkins University.

Global cooperation, instead of competition and confrontation, is the only choice to end the CO-VID-19 pandemic, Tedros said last week when addressing the disparity in access to vaccines worldwide.

"The shocking global disparity in access to vaccines remains one of the biggest risks to ending the pandemic," said Tedros. "We cannot defeat this pandemic through competition, we can't. If you compete for resources, or if you compete for geopolitical advantage," he said.

India's COVID tally passes 25m, cyclone complicates efforts in Modi's state

AHMEDABAD

INDIA total COVID-19 caseload surged past 25 million yesterday as a powerful cyclone complicated the health crisis in one of the states where the disease is spreading most quickly.

COVID-19 tests were administered to 200,000 people evacuated from coastal districts of the western state of Gujarat before the cyclone struck late on Monday and efforts were being made to try to limit any spread of infec-

"Masks have been arranged for people shifted to shelter homes," said Sandip Sagale, a top official in Ahmedabad, the main city in Gujarat.

"Efforts are also made to

maintain social distancing."

India's total tally of coronavirus cases surged past the 25 million mark with 263,533 new infections over the past 24 hours, while deaths from COVID-19 rose by a record

Only the United States has had more cases, or a worse single day death toll, when it lost 5,444 people on Feb. 12. But whereas the epidemic peaked months ago in the United States, there is no certainty that India's infections

Though the official count shows new infections subsiding, there are fears that the new, highly infectious B.1.617 variant, first found in India, is running out of control and many cases, particularly in rural areas, are going unreported due to lack of testing. This advertisement has not

Gujarat Chief Minister Vijay Rupani said oxygen manufacturing and distribution was not disrupted. Out of the more than 1,400 hospitals designated for treating COV-ID-19, power failures were reported in 16, and restored in 12, while the remaining four moved to back-up generators.

'STRUGGLING' VACCINA-**TION DRIVE**

In neighboring Maharashtra state, which was sideswiped by the cyclone on Monday, 1,000 coronavirus deaths were reported overnight - the worst toll nationwide. The infection rate in

Maharashtra has soared 15% in the last two weeks, government data showed.

The pace of vaccination in Maharashtra has fallen 30% since peaking in early April, according to data from the government's Co-WIN portal. Since April 1, 269 doctors have died of COVID-19, 78 of

them in the mostly rural state of Bihar, according to data released by the Indian Medical Association. "The surge has been very devastating," Jayesh Lele, sec-

In the northern state of Uttar Pradesh, home to more people than Brazil, rural areas have been severely hit, as healthcare systems have struggled to cope.

Incensed by scarce testing and tracing, a state court remarked on Monday the situation was turning to "God's mercy," and hurtling towards a "third wave."

"If this is the state of affairs of five districts, one can guess where we are leading people of this state to, i.e. (a) third wave of the pandemic," the state's Allahabad High Court

Chandrakant Lahariya, a public policy and health systems expert, said in the Hindustan Times newspaper that India's vaccine policy urgently needed a reset.

"For six weeks now, India's vaccination drive has been struggling. How long must one wait before acknowledging that what was planned is

not working?

"Part of the problem seems to be the fact that there is political decision-making in the areas that are purely technical. The political leadership should give a free hand to technical experts to decide and implement new strategies."

U.S. President Joe Biden announced on Monday that his administration would send at least 20 million more CO-VID-19 vaccine doses abroad by the end of June. Biden has been under pressure to share vaccines to help contain worsening epidemics from India to Brazil, where new, more contagious coronavirus variants have become rampant

lar, and important, goals scored by the men whose job is usually to prevent them.

Barca exploring Koeman replacements - sources

BARCELONA

BARCELONA are exploring replacements for Ronald Koeman, but president Joan Laporta doesn't want to sack the Dutch coach without having a successor in place, multiple sources have told ESPN.

Barca had the destiny of the La Liga title in their own hands before facing Granada on April 29, but one win in five games has seen them lose ground on Atletico Madrid and Real Madrid with one game to go.

Sunday's 2-1 defeat at Camp Nou against Celta Vigo officially ended the Catalan club's hopes of winning the league and increased the doubts surrounding Koeman's future.

However, Koeman, who led Barca to Copa del Rey success earlier this season, still has one year left on his contract. Sources at the club told ESPN he could still fulfil his deal if none of the alternatives convince.

The same sources told ESPN that Barca are keen to avoid a repeat of what happened after Ernesto Valverde was sacked in 2020 without a substitute

Suarez puts Atletico on brink of thrilling La Liga title as Barca regret letting him go

You think it's over? You really think that because Atletico Madrid only need to beat bottom-three Real Valladolid to win their third La Liga title in 44 long years, and that because they Harry Houdini-ed their way out of frightful peril at the weekend, we've already had our last Glenn Close "She's not dead yet!" twist in the tale?

Where on earth have you been these past few years? Are you serious? This is Spain. Literally anything could happen on Saturday when the champions, reigning Zinedine Zidane's Real Madrid host the Yellow Submarine out of Villarreal and championselect Atleti drive 120 minutes northwest to creaking, crumbling Valladolid where a win would guarantee them being crowned champions -- where, in fact, any result that matches Madrid's will have the same

The subplot to which I hope to be the first to lay claim is that Florentino Perez, Madrid's haughty billionaire president, calls the president of Valladolid, one Ronaldo Nazario de Lima, and tells him: "Ronnie, it's Atleti, and I need Valladolid to beat them. Get your boots out and pull those shorts on again!"

Ronaldo remains one of Perez's great deals. Straight off the "Galactico" conveyer belt, the downright stubborn, unmesmerisingly brilliant to ruin not only Atleti's footballer who used to cut corners in training and who put the "When can we have the next one?" in fiesta. He also remains someone for whom Madrid's president has massive affection. Little wonder.

I'm telling you right now, Ronaldo (once "O Fenomeno" but now "El Presidente" at the 92-year-old club he owns) was so talented that if he registered himself in time and donned one of the moderately more roomy first-team strips, he probably could nick a goal or two against Atleti next weekend despite being 44 and gently moving in body shape towards his permanently larger-than-life personality. This is Spain, don't rule it out.

And if you think that I'm being too fanciful, then let me just add fuel to your fire by saying it's only a little more ridiculous than the Luis Suarez scenario. I only hope that the halfwit who forced the Uruguay forward out of Camp Nou last August, former Barcelona president Josep Maria Bartomeu, was watching as the Blaugrana made a catastrophe out of losing at home to Celta Vigo while Suarez produced one of the great moments of recent Spanish football.

One of this sport's true beauties, one of the things that makes us so addicted, is that it creates theatrical drama liant analytical brain



that cinema and TV struggle to realistically emulate. And that's what happened on Sunday.

The morning dawned with headlines across Spain quoting Suarez complaining that during his last few months at Barcelona, he constantly had to listen to those who employed him telling him -- or, worse, making snide remarks behind his back -- that: "I wasn't able to compete for important trophies and that I was no longer fit for the top level."

Mingled in with Suarez's gleeful but-lookat-me-now! tone came the phrase from his present manager, Diego Simeone: "We are entering the Luis Suarez zone." Atleti's manager was underlining that his meaty, built-for-battle forward was precisely the sort of player upon whom you'd stake your life when the chips were down. The Argentinian coach would prove to be right, too.

Osasuna's During Brazilian striker was a mannerly decision to try weekend but their entire season, things got down and dirty. Early in the match, Suarez was merely moving through the gears to ramming speed, it would transpire, but he hit the keeper, hit the post and was caught offside in scoring positions which did Simeone's blood pressure no favours

in Bilbao, Ma-Up drid drawing. were No goals had been exchanged and Athletic Bilbao were looking as if they would be just delighted to to trip up Los Blancos again, having knocked Zidane's side out of the Spanish Supercopa semifinal in January.

Then, suddenly, a cascade of lava-like drama erupted and kept on sputtering out fiery goblets for the final 22 minutes of Sunday's football.

At San Mames, an overly elaborate corner routine eventually found young Rodrygo, who'd scored last week from a similar position, on the ball in Athletic's penalty area. Knowing his place in the hierarchy, he shunted the ball about three metres right to Casemiro instead of shooting. The Godfather of Madrid's Brazilian clan slashed a Hail Mary effort across the front of Unai Simon's goalmouth. Karim Benzema, hugely offside, was momentarily tempted by his predator instincts but, instead, let his brildominate innate reactions. He stayed stock still and didn't touch the ball, thus keeping out of the action and rendering his offside immaterial, allowing Nacho to neatly knee the ball in.

There's a momentary hiatus while the VAR computers have another of football's "2001: A Space Odyssey" moments, but "Hal" says: "It's OK, Dave, the goal must stand." Once all that reviewing is done, there are fewer than 22 minutes left.

At that stage Madrid and Atleti are tied on 81 points, meaning Los Blancos are top and will win the title if it remains tied the following week because they have an aggregate 3-1 lead over Atleti in the two derbies they played this season. The baseline numbers, 37 weeks into the season, are just remarkable. With Madrid 1-0 up and Osasuna drawing 0-0 at Atleti, La Liga's top two sides have identical games won, drawn and lost while their goals-scored/conceded reads: Madrid 65/27,

Atleti 63/23. Then, suddenly, Ruben Garcia unleashes his left boot. He's terrifically gifted off that foot, but you might not actually it consider his special one. And why not? On the outside of his right thigh he's got a stunning tattoo of Joaquin Phoenix as Arthur Fleck -- the Joker.

The Valencian identifies with Phoenix's version of Joker because, as he explained this season, "Arthur Fleck was a victim despised by society. The conclusion from that film is that we must support those who suffer from a mental illness or who are more vulnerable".

Garcia also happens to be one of the most strident and bravest football voices on the subject of empathy and tolerance: "I want all boys and girls to be treated with gender equality and not have to look at whether the person they have fallen in love with is male or female. Perhaps no footballers have 'come out' because they are afraid of not being accepted. If a teammate told me that he was homosexual, I'd encourage him to speak out publicly and help normalise it."

Bravo, Ruben. This is an afternoon for special footballers.

His booming cross soars over Stefan Savic and Renan Lodi at the back post, where the "Swan of Zenica," Ante Budimir, is gliding in. The Croatia internationalsignedonloanfrom Mallorca last summer, immediately contracted Covid, didn't play or train with his teammates until the end of October and, on debut, scored in a 3-1 defeat to Atleti. He then scored nine more times before Sunday, eight of them coming in victories, one in a draw, making him the principal reason Osasuna are comfortably staying up.

As I mentioned, this afternoon is for special players.

Budimir smashes a header in towards Jan Oblak's right-hand post and the guy who's faced the most shots yet conper minute this season is beaten. We require football's version of Hal the Computer to confirm it but VAR proves that the ball is clearly over the line before Oblak paws it away.

Madrid 1-0 up, Atleti 1-0 down. Suddenly it looks like utter disaster for Simeone, Suarez and Los Rojiblancos. Banana-skin match? An entire plantation. Up in Bilbao, Madrid's

subs, seated in the San Mames tribune above the dugout, celebrate and try to communicate to the rest of the squad. "Atleti are losing!" Back in his Barcelona penthouse overlooking the south of the city, ex-President Bartomeu is praying -- Atleti stumbling and Suarez not scoring

is partial redemption for him.

Sadly for Barto, Simeone has shrugged off his straitjacket of conservatism. For once, Atleti's manager makes not only shrewd but attacking substitutions. On come Joao Felix and Lodi, plus Hector Herrera and Moussa Dembele. Wit, width, wisdom and "watch out, here comes a big bear of a centre-forward.'

With eight minutes left and the title slipping out of view, Atleti level it. Lodi rampages forward down the left wing and Joao Felix dinks a lovely little sand-wedge ball into his path. The Brazilian instinctively looks for Suarez but he's offside. Lodi pretends he's going to centre it but, instead, launches a shot high into the Osasuna net and it's 1-1. Mayhem erupts. Suarez doesn't waste time remonstrating with the teammate who hasn't passed to him (for once) and rushes to collect the ball nestling behind Sergio Herrera.

Simeone's subs have title chase, on its head. But, so far, we haven't been in the Suarez zone -- "El Pistolero" has hit ceded the fewest goals the keeper, hit the post and picked the ball out of the opposition net to hurry things up.

> Five minutes later, Lodi erupts forward again. Where has this been all season? The ball flows from

left to right on the pitch and, suddenly, Yannick Carrasco is in the penalty area -- threatening. They key here is that Dembele is in the centreforward position, tying up two Osasuna defenders. Suarez, his lizard brain working without thought, pure instinct, has held back -- his position is perfect if the Belgium winger delivers a cut back ... and he does.

Who among you is surprised that the man Barcelona pushed out, the man who Lionel Messi believes could

have helped the Blaugrana win this league, simply stepped onto the chance and buried it in the bottom corner? No one? Thought not.

Suddenly, everyone who's collecting a salary from Atleti is running and shouting and bumping into one another. Suarez is at the bottom of a dangerous-looking pile-on -- it's a heap of writhing limbs, a collision of five octopi would probably look like this. Simeone suddenly assumes his "minimise risk" personality again. He's screaming at his assistant, Nelson Vivas, to get Geoffrey Kondogbia stripped and ready to come on in order to use up some time. Vivas. in the bedlam, is completely confused.

Madrid win, Atleti win and Osasuna stumble off looking bemused and unimpressed by destiny intervening. La Liga moves forward to its "And Then There Was One" weekend. And here's the thing about all great sporting drama: Like the tension in a Hitchcock movie, it's not best when it's unexpected; it's best when you want it to come, you see how it might come but it seems implausible -- perhaps even impossible.

The thing about this particular drama is that everyone saw it coming -- Suarez, Simeone and me, to name but three. Everyone except Bartomeu.

Last summer he was picking senior players at the Camp Nou to tell: "You won't have to put up with Suarez anymore, I'm in charge and he's out." It was an act of ego, tipped the game, and the an act of football vandalism and it has played a huge part in costing Barcelona the title. The Uruguay international's 23 combined goals and assists across 2,400 La Liga minutes mean he's created or scored one every 105 minutes on average. That's a remarkable return for a guy who his former club treated like dirt and pushed out the door. More fool Bartomeu, more fuel for Atleti.

> It's not done yet, but unless Valladolid have the surprise of all surprises in store for us on Saturday (with or without President Ronaldo up front), then there will be red-and-white ribbons on the trophy and it'll be Suarez 1-0 Bartomeu.

See you at the winnertakes-all weekend. It won't be for the faint of heart -- or friends of Barcelona's former president.
