

Govt seeks format for blue economy strategy

Tanzania, with support from the EU, is implementing a blue economy programme focusing on (environmental protection and climate resilient, sustainable management of coastal ecosystems

THE Vice President's Office (VPO) is formulating a national blue economy policy and its implementation strategy, for an integrated system of management and development of marine resources.

Abdallah Hassan Mitawi, acting VPO permanent secretary made this affirmation when opening the blue economy and climate change seminar for several ministries handling different sectors in the capital yesterday.

A VPO statement said that the plan seeks to promote economic growth and sustainable development, adding that blue economy is a concept that shapes economic growth by



Samia: Use current subsidies to widen farming, uplift lives

PRESIDENT Samia Suluhu Hassan has encouraged Tanzanians to invest in the agriculture sector by expanding farms, producing multiple types of crops as the government is well prepared to provide all needed relief to support their efforts.

Addressing a rally at Barafu grounds in Igunga District, Tabora Region yesterday as part of a two-day tour of the region, she said that the government is providing subsidies to enhance the capacity of farmers to buy fertiliser for themselves in the future.

The government would purchase all their crops as it seeks markets especially in foreign countries, she said, stressing that the government will procure all the produce at a fair price and store it for future use.

She was specific that the provision of subsidised farming inputs will take up to 2025, in which case farmers need to produce enough crops and use the sale proceeds to transform their lives.

The subsidies will not last forever, so the cash needs to be used wisely to build a good future in agriculture sector families, she stat-

She laid a foundation stone for the Vocational Educational and Training Authority (VETA) centre in the district, telling the rally that the government decided to construct vocational training colleges in all districts, providing a variety of technical and vocational skills plus entrepreneurship.

VETA colleges will provide needed skills of various fields including agriculture, livestock keeping, poultry and processing thus produce competent youths to serve in those areas or set up own projects, she said.

Hussein Bashe, the Agriculture minister, said the government has commenced deep designing work for modern irrigation scheme extending 3000 hectares at Wembere basin.

"We also have major irrigation projects in Simbo ward of 700 hectares, Mamapuli (3500 hectares), Igurubi (1800 hectares) and Buhekela (334 hectares)," he said, noting that the government is also working on a key water project to facilitate farmers in Tabora to use water from Lake Victoria for irrigating farms.

Batilda Buriani, the regional commissioner, said the region has benefited from various disbursements from the government to implement water, health, agriculture, education and other projects

The government has issued funds to construct five new district hospitals, rehabilitate Urambo Hospital and build dispensaries and health centres, she elaborated.

A total of 87bn/- has been disbursed for 17 new secondary schools and 17 primary schools, 47 dormitories, teachers' houses and hiring new teachers, greatly helping to improve performance of schools in national examinations, she added.

SAFE digital space including artificial intelligence (AI) is among key issues in activities of this year's civil society organisations (CSOs) week slated for Arusha.

The forum will provide stakeholders with an opportunity to discuss the use of technology and safe digital space in relation to artificial intelligence to accelerate national development, he stated.

Up to 500 participants are expected to attend the event, with the coordinators directing their efforts towards ensuring optimum participation of actors from diverse sectors,

The week-long event is a vital moment for multi-sectoral development actors concerned with steering the development of people, communities and the nation in general, he said.

CSOs Week sessions will be set on exploring technology solutions to development problems and climate smart digital tools for agriculture and market access to smallholder farmers, he explained.

Digital transformation has drastically changed societal communication and social frameworks, with the potential to further reshape o the world in profound ways, he

"The civil society sector works closely with people in communities through the implementation of interventions that support the advancement of gender equity, inclusion of people with disabilities, democracy, youth participation, peace and social cohesion," he asserted.

He laid emphasis on the view that discussions on intersection of technology and society are vital to understanding change, navigating the challenges they pose and leveraging opportunities they present.

"Our world is changing rapidly due to the digital revolution we are living through and has the potential to modify social conventions even more," the activist intoned.

"Understanding these changes, overcoming the difficulties they create and taking advantage of opportunities they present needs conversations focused on the junction of technology and society," he elaborated.

SADC to reinforce measures associated with food safety

THE Southern African Development Community (SADC) is working to foster regional coordination and harmonisation of food standards and regulations to prevent foodborne diseases, reduce the risk of food contamination, and safeguard the integrity of food.

In his official opening remarks at the 14th SADC Food safety technical committee meeting Lusaka Zambia yesterday, SADC Director for Industrial Development and Trade (IDT), Dhunraj Kassee said one in ten people in the world falls ill and 420,000 people die every year after eating contaminated

He said 40 percent of children under five years of age carry the burden of foodborne diseases, with 125,000 deaths every year.

"SADC Member States commit to cooperate in developing and implementing effective measures that respond to threats of food contamination to protect lives and livelihoods while at the same time reducing differences in these measures, which may result in barriers to trade," he said.

The meeting is jointly organised by the SADC secretariat, through the European Union (EU) funded Trade Facilitation Programme (TFP) and the African Union Commission (AUC) to promote the protection of public health, economic development, and international trade.

Truck carrying hazardous sodium cyanide overturns on a highway

RESIDENTS of Kagongwa in Shinyanga Region have been cautioned to stay away from an incident scene after a lorry carrying sodium cyanide - a hazardous compound used for dissolving gold in mining sites lost control in the area draining the chemicals.

The vehicle, a Scania with registration number T124 ECX was involved in an accident around 9- am causing panic among residents.

Shinyanga Regional Police Commissioner Janeth Magomi said she received information at around 9:30 am that a vehicle belonging to Taifa Transport and Logistic was involved in an accident.

She said security organs were working on the matter to control effects of the chemicals to people around the area in case they come into contact.

"When I arrived at the scene I found

that the drivers who were 10 were given first aid but also precautions were taken to ensure that the chemicals do not cause harm to the people," she said.

She called upon residents to collaborate with security organs and issue information on such incidents to avoid health risks that may result from the chemicals.

Head of the Fire and Rescue Brigade in Kahama Edward Seleman said they received information on the matter and were prepared to rescue in case there was an emergency.

Chairman of Kashime ward Emanuel Mabula said they were in panic because the chemicals had a label 'poisonous do not touch'.

Project manager for Taifa Transport and Logistic Hapiness Nyiti said they received the information while at Buzwagi mining site and were forced to visit the area.

She said the materials were being taken to Buzwagi, Bulyankulu and North Mara mining sites where they are used for gold smelting.

She hailed security organs for controlling movements around the accident's scene, saying up to now there are no effects to humans.

She said the company has been conducting training to drivers transporting chemicals on how to handle them when such incidents happen.

APHFTA pleads for formulation of body to regulate health insurance

THE Association of Private Health Facilities of Tanzania (APHFTA) has called for the formulation of a special body to regulate health insurance in the country to create fairness and address challenges including delaying of payments offered by private hospitals.

Speaking at APHFTA zonal meeting in Dar es Salaam, Chairperson Dr Lazaro Wambura said the new body would act as a referee to replace the National Health Insurance Fund (NHIF) which is currently doing all the mandates including regulation.

"Currently NHIF is the referee, a player and the lineman, a move which causes conflict of interest because what is happening now has led to the closure of businesses for many of our members," he said.

Chief Justices from 16 African countries to convene in Arusha

SIXTEEN Chief Justices from various African countries are expected to attend the Southern and Eastern African Chief Justices Forum (SEACJF) slated for Arusha from October 23 to

Briefing reporters here yesterday, Dr Paul Kiwhelo, Judge of Tanzania Court of Appeal, who is also head of Lushoto Institute of Judicial Administration (IJA) said the aim of the meeting is to exchange experience on judicial administration systems.

He also said they aim to boost relationship between parliament and the judiciary, enhance economic democracy and the use of modern technology on the digital systems for the dispensation of justice, of which Tanzania now leads.

However, he said SEACJF was established in 2003 in assisting to have independent judiciaries, democracy, respect of the rule of law and human rights, transparency and accountability.

He added that the forum has also been able to establish a Judiciary College located in South Africa for the training of judges.

Judge Kiwhelo further said that the participants of the forum will support the Royal Tour documentary film which President Samia Suluhu Hassan starred by visiting some of tourist

attractions in the country's northern tourism circuit.

For his part, Tanzania Judiciary administrator, Prof Elisante Ole Gabriel said the meeting is held every year in member countries and is coordinated by SEACJF that sits in Lusaka, Zambia.

He added that the meeting will be preceded by a meeting of judiciary administrators from the 16 member countries that will be held for one day on October 22 in Arusha.

"Since the inception of this forum, Tanzania has many things to be proud of including its being the leader in operating our judiciary digitally," Prof Ole Gabriel said.

He said the participants of the forum come from Tanzania, Kenya, Uganda, Zambia, South Africa, Namibia, Lesotho, Zimbabwe, Eswatini, Botswana, Malawi, Mauritius, Angola, Mozambique, Seychelles and Zanzibar.

He said the meeting will also involve exhibition by various judiciary stakeholders including TPA, TANAPA, IJA and the Attorney General's Office.

He named other stakeholders in the exhibition as including Mzumbe University, ATCL, Moshi Prisons College, Ministry of Industry and Trade, NCAA, TTB, LATRA and NDC.

"The aim to invite the stakeholders to show our various services offered in the country in advertising our country's tourism attractions," he said.

He said that statistics show that women account for 28.6 percent of the ministers, deputy ministers, permanent secretaries and heads of public institutions; a good achievement towards achieving the 30 percent of representation of women in leadership posts.

"Despite gender inclusivity in public services, some public institutions have not included gender issues in some matters including budget. This led to government failure to attain its goal."

He said the government prepared the guidelines in collaboration with United National Development Programme (UNDP).He called on the Uongozi Institute to continue involving men in the programme to make it effective.

Uongozi Institute CEO, Kadari Singo said the institute conducts training to women to build their capacity in matters related to leadership. He said a total of 800 women within and

outside the country submitted their application but only 100 were selected.

Uongozi Institute was established in 2010 by the government to inspire and equip Tanzania and African leaders to deliver inclusive and sustainable solutions.

This is done through the provision of high-quality executive education, facilitation of policy dialogues, actionoriented research and technical assistance for public and private institutions.

SAGCOT was created in 2010 as a public-private partnership that seeks to develop Tanzania's agricultural sector by fostering responsible agri-business investments, but currently SAGCOT focuses on the southern regions.

SAGCOT uses a cluster system to promote people's livelihoods. A cluster groups together three or four regions. The meeting was informed that a cluster is a geographic concentration of interconnected companies, specialised suppliers, service providers and associated institutions. In a cluster small farmers get timely what they need to enhance farming productivity, while direct and indirect jobs are created simultaneously.

TIB Bank 980.7bn/- loans big uplift for agribusiness

NE way to thematically the TIB Bank Development financing of up to 980.7bn/- for small and large-scale projects in numerous production fields in the regions like agriculture, mining, transport, communications, energy, water, health and industries is a simple relocation of resources. Most revenue that is allocated to TIB Bank for production sector loans is generated in urban areas, while rural areas can't raise such financing. It is a thorn the government seeks to solve while financing the sector.

A top TIB Bank executive was lately setting out the bank's plans at a meeting with members of the Editors Forum in Dar es Salaam, highlighting plans to start investing heavily in strategic projects such as railways, dry ports, mining, roads and energy. Obviously this is positive for the government's development plans but raises questions of effectiveness or viability of the bank's strategies since being structures at the start of the year. Such questions are not raised directly by the Treasury as it properly understands the bank's functions and limitations.

That is perhaps where the 'public relations' issue comes up, as often times there are wars of words between different government agencies on such issues, which usually leaves onlookers bewildered. In the past two to three years, upwards of 80 per cent of loans issued by TIB in its traditional format were classified as underperforming, and it was soon restructured and recapitalized. Does it mean that it will be more efficient, or has these concerns been brushed aside already?

Definitely the new format of a corporate bank and a development infrastructure projects such as land surveys, upgrading agricultural

markets and developing small businesses looks like it is a roaring success. That is the impression the top executive conveyed, especially as its loan portfolio had disbursed a total of 334bn/- to support agriculture sector projects, with 253 projects supported in 23 regions. Had these projects been loaned by commercial banks it would be easier to project a healthy return

When the bank talks about envisaged strategic projects as including ship rehabilitation projects, expansion of sugar factories, construction of pipe production industries and expansion of dry ports, the issue is how far these projects were seen as commercially viable.

When such a distinction is made, an auxiliary question emerges, as to whether commercially viable projects avoided to seek loans in commercial banks and tapped on TIB Bank resources instead. It is a question of the justification of public assistance with working capital, or even startup capital in certain cases, if it was altogether justified in all cases.

TIB Bank projections of economic impact of the loaned projects assert that those investments help to create up to 10,000 job openings, as the financing includes loan capital for 12 financial institutions, 78 savings and credit cooperatives (SACCOS) and 128 companies supported through loans.

Assuming that more than half of these entities will eventually be viable and sustainable, the wider economic goals would appear feasible even with low repayment projections if it depends on profitability. One such parameter is water sector projects accessing 14bn/- loans for 66 projects, six water authorities and 60 water user associations in rural areas. These institution financing local government entities can't easily be projected to pay up, or that there will be political pressure to do so.

That also shows why Bangkok was selected at the location of such a factory as Thailand has both the taste of glitter and relatively high average incomes, such that glittering dresses become a regular stock in trade for supermarkets and glitz shops. Duplicating the facility in the country could make it easier to use other trade enhancing statutes like the African Growth and Opportunity Act (AGOA) in the United States, or its European Union equivalent, Everything But Arms (EBA). The two facilities may not last for a decade longer as the world treats Africa more commercially.

It is likely that the ministerial delegation that toured Thailand and visited his SK Export factory, and moving to acknowledge its relevance even for the minerals export strategy sees plenty of opportunity in that sort of product in global markets. The Tanzania Investment Centre (TIC) has allocated a plot of more than 1,000 acres for factory outlays at the Mlandizi area in Kibaha District. Most drawings of the prospective factory have already

The investor talked of mobilizing funds to start construction, without suggesting that there any overseas partners for the purpose, or expects credit arrangements by local banks. With his accolade and product novelty, he may not stand long in the queue, decidedly, as an example of how we are also capable of global by innovating on using minerals in dressing, cheapening them in glitzy markets. To end child marriage in Southern and East Africa, governments need to strengthen laws, implementation

LMOST one third (32 pc) of women aged 20 to 24 in Eastern and Southern Africa - around 50 million were married before 18 years old. To address this pervasive problem, the Southern African Development Community (SADC) Parliamentary Forum has adopted the SADC Model Law on Eradicating Child Marriage and Protecting Children Already in Marriage, a legal framework providing a comprehensive, integrated approach to ending child marriage protecting children already married.

New research reveals that while some SADC countries have taken commendable action to strengthen legal protections in this area, other Member States have made little or no progress.

These findings feature in new policy briefs produced by Equality Now in partnership with the United Nations Population Fund (UNFPA) and the Southern African Development Community Parliamentary Forum (SADC PF). Ending Child Marriage In Southern Africa: Gaps And Opportunities In The Legislative Frameworks and Domesticating The SADC Model Law On Child Marriage analyzes laws across the 16 SADC countries and identifies positive legal advances, best practices, and challenges.

A third brief, Ending Child Marriage in Eastern and Southern Africa: Challenges in Implementing Domestic Laws and the SADC Model Law on Child Marriage, examines the implementation of domestic and regional laws on child marriage, focusing on Malawi, Uganda, and

Zambia as case studies. While the SADC Model Law is having a positive impact, its success depends on effective implementation and enforcement by states. To assist governments, the briefs also provide recommendations on strengthening elimination efforts through good application of child marriage laws and policies.

SADC Model Law

Child marriage severely harms girls and exposes them to various human rights violations. It impedes their right to education, as marriage often entails being forced to drop out of school to assume adult responsibilities. This lack of education perpetuates a cycle of poverty, limiting girls' opportunities for personal development and financial independence.

Early marriages increase the

likelihood of early pregnancies, posing significant health risks to girls whose bodies aren't mature. This can result in complications during pregnancy and childbirth and is associated with higher maternal and infant mortality.

Moreover, child brides are often subjected to domestic violence and marital abuse as they lack the power to assert their rights, and alternative safe spaces are rarely available.

The SADC Model Law defines a child as any person below the age of 18 and recognizes that child marriage violates children's rights, including the right to education, health, and protection from harm. It calls for prohibiting child marriage, creating prevention and response mechanisms, and promoting birth registration. Other components include supporting child brides and their families and ensuring access to education and healthcare.

The Model Law sets 18 as the minimum age for marriage for both boys and girls without exception and is applicable to all types of marriages - whether under statutory, religious or customary law -- with marriages involving a child declared null and

To address the complex root causes contributing to child marriage, the Law promotes a comprehensive, multi-sectoral approach based on coordination and collaboration between legal, education, healthcare, and social services sectors.

Inconsistencies and implementation of laws

It is important to recognize that some progress in reducing child marriage has been achieved in Eastern and Southern Africa. However, progress is too slow as the prevalence rate has only reduced from 39% to 32% over the past 25 years, while other regions have made much faster progress.

At the current trajectory, it is estimated that child marriage in the region won't end until 2240.

Concerningly, most progress in Sub-Saharan Africa has occurred amongst the wealthiest families, while in poorer communities, there has been a rise in child marriage. This perpetuates an unacceptable and deeply entrenched divide along socio-economic lines and demonstrates how governments need to focus more on prioritizing elimination of child marriage.

Problems include a lack of adequate resourcing to programs addressing child marriage and a general lack of effective implementation of laws and policies, which feeds into low prioritization of decision-making and lack of action on child marriage.

Africa, only six countries - DRC, Malawi, Mauritius, Mozambique, Seychelles, and Zimbabwe - set 18 as the minimum age of marriage for both boys and girls, with no exceptions.

Five countries - Angola, Botswana, Comoros, Madagascar, and Namibia - set the minimum age as 18, but allow exceptions for customary and religious marriages and for marriage with consent from judicial or other government officials.

countries - Eswatini, Lesotho, South Africa, Tanzania and Zambia - provides for a minimum age ranging between 15 and 18. These are different for boys and girls, with the boys invariably having a higher age limit.

In addition, all five countries allow for judicial or parental consent to lower the age of marriage even further, and in Eswatini and Lesotho, there are exceptions for customary law that permit marriage from the age of puberty.

These domestic laws violate the international and regional human rights standards that SADC countries have signed on to. Deeply entrenched cultural practices, poverty, and limited access to education and sexual and reproductive healthcare are slowing progress and hindering reform efforts. Such is the case in Tanzania. In 2016, the Tanzanian High Court gave a landmark ruling that struck down sections of the Marriages Act of 1971, which set the marriage age at 18 for boys and 15 for girls, with additional exceptions allowing marriage at 14 with court approval.

Despite the ruling being upheld by the Court of Appeal in 2019, Tanzania's government has thus far failed to amend the law accordingly.

However, there is encouraging progress elsewhere.

In Zimbabwe, the Constitutional Court ruled in 2016 that child marriage is inconsistent with the Constitution. A new Marriage Act enacted in 2022 prohibits marriage for those under 18 in all cases, including for customary marriages, and allows up to five years imprisonment for offenders.

In addition, the country's National Action Plan and Communication Strategy to End Child Marriage requires registration of all marriages.

In February 2023, the Constitutional Court of Uganda issued a groundbreaking decision in the case, Kirya Martins & Aboneka Michael v. Attorney General, striking down provisions of customary and religious law, including in Hindu and Muslim family laws, that conflicted with the minimum age of

Out of the 16 countries in Southern marriage set out in the Constitution.

Prioritizing legal reforms to end child marriage

Contradictory provisions different laws on child marriage create confusion in the application of the law and the inconsistencies make jurisprudence difficult to interpret and implement. All SADC countries must prioritize legal reform and enact robust legislative and policy frameworks that comply with Statutory law in the remaining five international and regional human rights obligations. This means setting the minimum age of marriage at 18, without any exceptions.

While legal reform is crucial, governments must close the divide between legal approaches and those aimed at influencing social and community norms. Prosecution and punishment of perpetrators should be accompanied by a multi-sectoral approach with an ample budgetary allocation.

Community awareness-raising is key and requires comprehensive sexuality education and behavior change campaigns that foster understanding about the negative impact of child marriage on girls and the wider society.

So too is the empowerment of girls through education and other opportunities that increase their agency and decrease their vulnerability to human violations.

Child marriage prevention must also be fully integrated into climate change mitigation and disaster response strategies. Africa is bearing the brunt of global warming, with extreme weather events, prolonged droughts, and food shortages intensifying economic hardships, conflicts, and forced migration.

Girls are especially vulnerable, as families may view marrying daughters as a strategy to cope with financial difficulties and as a way of protecting them from the heightened risks of sexual violence and exploitation found in unstable environments.

Having the right laws in place is the foundation upon which access to protection and justice is built. But only through a multifaceted approach championed by governments can we create a future where every child and young woman in East and Southern Africa can reach their full potential, free from the shackles of child marriage and early motherhood.

URAL women are about 2.1 billion, a quarter of the world's population and 43 percent of the world's agricultural labour force is made up of women and 50 percent of which are in Eastern and Southern African countries

Less than 15 percent of landholders worldwide are women. Closing the gender gap in agriculture can improve productivity by 30 percent and could improve the livelihood of over 180 million people.

Step into any local market in a rural setting, and you'll meet women vendors with baskets full of fresh produce and homemade goods to trade. Since time immemorial, rural women have been the primary food producers, harvesting, processing responsible for growing staple foods, fruits, vegetables, and managing livestock.

They have been the custodians of our diets and recipes, ensuring that families and communities have access to nutritious and diverse diets. In many societies, women are the primary vendors at local markets. By selling their produce, they not only contribute to local economies but also ensure food accessibility to a broad-

At the primary family set-up, rural women play a pivotal role in ensuring their families' nutritional needs. Whereas women play a critical role in making decisions about food purchases and meal preparations, affecting the health and well-being of their family members, the gender gap limits women in access to financing and credit facilities due to cultural and traditional norms. Moreover, the average income of female- headed households is lower than those headed by men exposing women headed households to a higher risk of poverty.

As we mark this year's International Day of Rural Women, understanding the role of rural women in food transformation is vital to achieving food security, promoting sustainable agriculture, and ensuring resilient rural communities. The reality is that women perform the bulk of unpaid care and domestic work within families and households in rural areas, make significant contributions to agricultural production, food security and nutrition, land and natural resource management, and building climate resilience but suffer disproportionately from multi-dimensional poverty.

As much as they may be as productive and enterprising as their male counterparts, they are less able to access land, credit, agricultural inputs, markets, and highvalue agri-food chains and obtain lower prices for their

Traditionally, women are the key players in seed preservation and biodiversity, contributing to adaptation of crops to changing climate conditions and pests. Women have played the role of seed selection which directly promotes the preservation of the world's genetic seed variety for generations to come.

Women hold the key to success of pastoralism in Africa

OMEN in pastoralist areas of East Africa are critical to the health of livestock in their communities, holding the key to effective animal vaccination campaigns meant to protect herds against deadly diseases.

They are, therefore, an important part of any vaccination strategies designed to guard the animals against killer outbreaks and need to be involved in such efforts for them to be successful.

Achieving the goals of such campaigns has become increasingly important as the effects of climate change introduce new diseases that threaten the sector and, by extension, household incomes.

It has become critically important to integrate females in such health campaigns, and one barrier to their success is the failure of authorities and development agencies to

While women, due to cultural reasons, do not commonly own livestock, they act as caregivers when the animals are sick, and with incidents of disease outbreaks rising, involving them, in the end, ensures improved food and financial security for families.

Besides, an increasing number of households in the region where livestock keeping is the economic mainstay are being headed by women who also act as providers to their

Unsurprisingly, as many as 43 percent of livestock insurance policyholders in northern Kenya and southern Ethiopia, where the policies have been introduced in the recent past, are women, scientists at the International Livestock Research Institute (ILRI) say.

"Besides taking care of animals when they are sick, women influence the allocation of resources at the household level, determining things such as how money should go to buying vaccines, for example. Therefore, a strong gender strategy to allow women access to disease control is very important," said Dr Bernard Bett, ILRI Senior Scientist, Animal and Human Health Program.

In its disease surveillance and response strategy, ILRI engaged "community disease reporters," local leaders, and village women's champions, including women heads of households, to gather information on outbreaks and to create awareness about vaccination campaigns, says Bett.

At times he noted, women got intimidated in queues by men during mass vaccination exercises, making them lose valuable time for other chores at home as they waited for their turn in the queue.

Authorities and organizations carrying out the missions have responded by enforcing a first-come-first-serve policy in the interest of fairness and increased animal health personnel staffing levels for orderly vaccinations, he ex-

plained.

Recognizing that conflict with household tasks was a permanent reality for women, ILRI practiced and advocated for early communication to enable better planning through community messaging while actively supporting females' role in caring for livestock, he added.

Climate change, evidenced by frequent droughts and flood incidents in arid and semi-arid areas of East Africa that are the home of pastoralism in the region, Bett observed, presented a major disease burden with incidents of outbreaks of diseases such as Rift Valley Fever being

a major threat. "Highly climate-sensitive diseases causing pathogens attracted by changes in weather conditions, including those caused by vectors such as ticks and tsetse flies, become common. Efficient delivery of disease control measures, including vaccinations, is therefore important," he told a recent media briefing in Nairobi.

Owing to the nomadic nature of pastoralists in search of pastures and water in times of shortage it is women are the ones who take care

of households when the men are ioned against possible malnutrition, away with cattle and camels, while women are left behind caring for goats, calves, and vulnerable animals, making them also effectively in charge of their households.

Like their counterparts in the crop farming areas of the region, women pastoralists are faced with the challenge of providing food for their families, which is made worse by lack of income due to livestock deaths, noted Dr Rupsha Bernerjee, ILRI senior scientist attached to livestock and climate initiative.

"Whenever there are shocks such as droughts which in turn lead to food shortages, women skip meals to ensure their families are fed. It is therefore important to promote social inclusion in livestock health programs to ensure no one is left behind," she said.

The impressive uptake of livestock insurance among women increases the resilience of herder communities, enabling them to cope with climate-induced risks, she added.

"Payments made to herders when droughts are very severe help in reducing distress sales of livestock guaranteeing that families are cushthus the importance of women livestock health," she told the briefing at the global body's Nairobi head-

In appreciating the important role in the health of livestock IDRC, Global Affairs Canada and the Bill & Melinda Gates Foundation established the Livestock Vaccine Innovation Fund (LVIF), which supports the development and production of innovative vaccines to improve livestock health and the livelihoods of

The agency notes that worldwide, more than 750 million people keep livestock as a source of income, 400 million being women, but animal diseases, such as Newcastle disease in chickens and peste des petits ruminants (PPR) in goats, create widespread devastation, with women disproportionately affected because "they are less likely than men to be able to access vaccines to prevent such losses.'

"Millions of women livestock holders face financial and animal losses when diseases sweep through their farms. These infections are often highly preventable with a simple vaccination, so what is preventing women from taking measures to protect their assets?" the IDRC poses.

To answer find answers to the imbalance, the partners launched a regional livestock vaccine initiative called SheVax+ research project was launched in 2019, bringing together Cumming School of Veterinary Medicine at Tufts University-US, the Africa One Health University Network (AFROHUN) together and implementing partners, Makerere University, University of Nairobi, and University of Rwanda.

Helen Amuguni, the SheVax+ principal investigator, identifies three primary barriers to livestock vaccine uptake among women smallholder livestock farmers in East Africa, including gender norms, which lead to women having less access to information on vaccinations, animal health, and livestock management practices.

Stereotypes, she says, affect the way women are viewed in relation to livestock ownership, leading to their exclusion during vaccination information campaigns. Power relations also mean some women require permission from the male household head to attend training or control livestock-related resources.

As a result, many women lack understanding of, among other things, the availability and importance of vaccines, while those who do have awareness may be prevented from acting upon it, she explains.

Besides carrying out disease control and management initiatives insuring livestock, as happens with the Index-Based Livestock Insurance pioneered by ILRI to 'de-risk' the sector, was a critical component of cushioning the sector's well-being and incomes for households, according to Bernard Kimoro, head of climate change and livestock sustainability in the Ministry of Agriculture and Livestock Development, Kenya.

Operational in northern Kenya and southern Ethiopia, the insurance utilizes satellite data to determine and read the conditions of the vegetation, where herders get compensation when the vegetation turns brown/yellow to indicate drought or shortage of foliage.

Desperation in the pure livestock systems in the region due to frequent climate change-linked droughts in the region called for both new animal disease control and feeds and nutritional strategies, he said.

The droughts have led to keepers using unsustainable feeds with high methane gas levels owing as the owners tried to keep animals alive during the dry spells, the official

"We have done a small research and discovered that educated youth are leading in the use of illicit drugs while others studying in the US and Tanzania's universities, the situation that may leave the country with no experts due to the use of improvised chemicals as illicit drugs," he said.

He added the adverse effects from the use of these drugs are immense that may result in foreigners taking various positions in various fields, hence he called on the sellers of these drugs to be careful of what they are engaging

He added that reports on the global illicit drugs situation from 2017 to 2021 show increased trafficking of such drugs as a good volume had been seized by various drug control

The seized drugs include 298.9 tonnes of Tramadol, 260 tonnes of Morphine, 33.3 tonnes of fentanyl, 6.6 tonnes of kentamine and 352.4 barbiturates.

He said these were seized in North African countries, West Africa, the Middle East and

"During this period more than six Tanzanians were arrested in foreign countries involved in the trafficking of these chemicals including 100 kgs of ephedrine and pseudo-ephedrine used to make medicines for treating colds and coughs," he said.

He further said in order to boost the fight against the use of harmful chemicals as alcoholic drugs, GCLA, TMDA, MSD and Tanzania Pharmacy Board have continued to involve the private sector in the fight.

"In implementing the strategy so far we have entered into and signed MoU with more than 50 firms and two communities involved in human medicines with more than 300 members," he said.

FAO assesses impact of disasters on agriculture and food security

IN a groundbreaking revelation, the world now has an assessment of the consequences of disasters on a global scale: Over the past three decades, the agricultural sector has incurred losses amounting to approximately \$3.8 trillion (equivalent to around €3.6 trillion).

According to a report released by the Food and Agriculture Organisation (FAO), nearly half of these costs can be attributed to droughts, while floods, storms, pests, health crises, and conflicts are also significantly contributing to this growing impact.

"Disasters are producing unprecedented levels of damage and loss in agriculture around the world. Their increasing severity and frequency, from 100 per year in the 1970s to around 400 events per year in the past 20 years, affect agrofood systems across multiple dimensions, compromising food security and undermine the sustainability of the agriculture sector," Maximo Torero, chief economist, FAO.

Asia is the hardest-hit region, but on a global scale, average annual losses amount to 116 billion euros, equivalent to 5 per cent of annual agricultural gross domestic product, almost equal to losses experienced in Africa, Europe and the Americas put together.

Nevertheless, compared to the estimated counterfactual production, losses appear to be particularly significant in several parts of Africa, primarily eastern, northern and western Africa

The continent also gets the short end of the stick when it comes to climate related hazards, with a registered 70 percent of all global wildland fires.

The Food and Agriculture Organisation of the United Nations (FAO) notes a significant increase in the number of disasters, from around a hundred a year in the 1970s to around 400 in recent times. With climate change on the horizon, these impacts are expected to intensify, further exacerbating existing social and environmental vulnerabilities.

LL eyes are now on Xi Jinping as the Chinese president hosts state leaders, business executives and scholars from around the world for the third Belt and Road Forum for International Cooperation.

In just 10 years, the Belt and Road Initiative (BRI), Xi's signature vision for global development, has become one of the world's most popular public goods, bringing many developing countries chances for leapfrog development.

The gathering in Beijing offers a historic opportunity for all BRI partners to build on the initiative's remarkable achievements and progress toward common prosperity.

Why did Xi propose the BRI? What's behind the initiative's success? And what does Xi hope to achieve with it?

BOOST DEVELOPMENT FOR GLOBAL PROSPERITY

In the late 1960s, a teenager trudged into a small village hidden on China's Loess Plateau after three days of travel by train, truck and foot. He was among the "educated youth" sent to the countryside to be "re-educated" with the rustic virtues of China's farmer majority.

He was astonished by the stark challenges of life in Liangjiahe -- sleeping in flea-infested cave-houses, laboring for long hours and wrestling with hunger. He soldiered through the difficulties over seven years, leading his fellow villagers to a much better life.

That young man was Xi. "There was no meat in our diet for months," Xi recalled decades later during a visit to the U.S. city of Seattle as Chinese president. "One thing I wished most at the time was to make it possible for the villagers to eat meat to their heart's content."

The bitter taste of poverty reinforced Xi's conviction: Development holds the master key to solving poverty problems. But how?

Xi has chosen to put China's development on wheels. "Roads first, then prosperity." Xi often cites this popular Chinese saying to elaborate on how infrastructure construction can stimulate development. In his understanding, changing a cableway or repairing a section of road, in some impoverished areas in particular, can open the door to poverty alleviation and prosperity of the masses.

anping, recollected how Xi, who then served as a village leader, repaired the road connecting the village with the outside. "It used to be a narrow and winding path that couldn't even accommodate a wheelbarrow and was then transformed into a broad road," Wang said. The road helped the village kickstart its development.

When Xi took over the helm of China, the country had just risen to become the world's second-largest economy and faced numerous challenges. Opening up has been considered an essential engine for China's miraculous economic rise over the past four decades. Xi has reaffirmed the nation's dedication to further opening up.

The BRI has become "a new toplevel design for China's reform and opening-up, and it represents opening-up at a higher level and resonates with the pursuit of high-quality development," said Wang Yiwei, director of the Institute of International Affairs at Renmin University.

While the BRI aligns with Xi's commitment to greater openness, it has played a vital role in connecting the world's most urgent development needs with what China excels in -- building roads and bridges for greater connectivity. Xi has a good understanding of the needs of developing countries. He once told the Wall Street Journal in a written interview that from 2010 to 2020, the annual shortfall in funding for Asian infrastructural development was around 800 billion U.S. dollars. A report from the Asian Development Bank finds that developing Asia needs to invest 1.7 trillion dollars a year in infrastructure until 2030 to maintain its growth momentum.

The BRI "leverages China's unequaled experience and competitive advantages in constructing infrastructure: rail, roads, ports, airports, power plants, telecom," said Robert Kuhn, an American expert who authored the book "How China's Leaders Think.'

frastructure. It is a Chinese solution kilometers to borrow a copy of Faust, to global development issues, said a White Paper on BRI development. The current deficit in peace, development and governance poses a daunting challenge to humankind, offering an opportunity for the BRI to step in.

For the Chinese leader, just as China cannot develop in isolation from the world, the world needs China for its development.

A villager from Liangjiahe, Wang Xi-marily driven by his eagerness to cultures of both the East and the West share China's development experiences with the rest of the world," said Wang.

As Xi put it, pursuing the BRI "is not meant to reinvent the wheel." Instead, it aims to complement the development strategies of the countries involved by leveraging their comparative strengths. "The BRI I put forward aims to achieve win-win and shared development," Xi said.

REINVIGORATE COMMUNICA-TION BETWEEN CIVILIZATIONS

Villagers in Liangjiahe still remember that Xi brought two suitcases full of books when he arrived in the village in 1969. Xi loves reading -- a fixture in his daily life. He once walked 15

a masterpiece of Johann Wolfgang von Goethe.

"Reading invigorates my mind, inspires me and cultivates my moral force," Xi said. Even after assuming the top leadership post, he still keeps reading despite a busy schedule and has also encouraged government officials to read.

Sharing the story with the audience at Nazarbayev University in Kazakhstan in 2013, Xi said, "Today, as I stand here and look back at history, I seem to hear the camel bells echoing in the mountains and see the wisps of smoke rising from the desert."

Spanning thousands of miles and years, the ancient silk routes were more than routes for trade. The circulation of goods spurred the communication of cultures. Waves of caravans, travelers, scholars and artisans traveled between the East and the West as cultural envoys. The bustling pathways connected the birthplaces of the Egyptian, Babylonian, Indian and Chinese civilizations and the lands of major religions.

Countless relics discovered along the ancient routes, including the millennia-old "gilt bronze silkworm" displayed at China's Shaanxi History Museum and the Belitung shipwreck discovered in Indonesia, are the embodiments of the Silk Road spirit, which promoted peace and cooperation, openness and inclusiveness, mutual learning and mu-

"History is the best teacher," Xi says, that reviving and carrying forward the Silk Road spirit and promoting cultural and people-to-people exchanges is integral to the

"We should establish a multi-tiered mechanism for cultural and people-to-people exchanges, build more cooperation platforms and open more cooperation channels," Xi said while addressing the first Belt and Road Forum for International Cooperation in 2017.

Xi can always combine theory, history and reality and draw inspiration from the nation's outstanding traditions, said Martin Albrow, a fellow of the British Academy of Social Sciences. For Xi, civilizations do not have to clash, and no civilization reigns supreme. "Civilizations only vary from each other, just as human beings are different only in terms of skin color and the language used," he said.

"In pursuing the Belt and Road Initiative, we should ensure that when it comes to different civilizations, exchange will replace estrangement, mutual learning will replace clashes, and coexistence will replace a sense of superiority. This will boost mutual understanding, mutual respect and mutual trust among different countries," Xi stated while addressing the first Belt and Road forum.

That is why he proposed to hold the Conference on Dialogue of Asian Civilizations and put forward the Global Civilization Initiative.

"We should keep our civilizations dynamic and create conditions for other civilizations to flourish." Xi said. Xi's vision of civilization has been shared by many.

"The BRI has revived the Silk Road spirit. By activating the spirit, different civilizations can return to a harmonious state of mutual learning. That is how civilizations should get along," said Wang Yiwei.

Former Greek President Prokopis Pavlopoulos said, "Chinese President Xi Jinping is a great leader who knows well about civilizations, about the essence and mission of civilizations."

INSPIRE BUILDING OF A BETTER WORLD

"Mankind, by living in the same global village in the same era where history and reality meet, has increasingly emerged as a community of shared future in which everyone has in himself a little bit of others," Xi told a rapt, packed audience at Moscow State Institute of International Relations in 2013.

It was Xi's first overseas visit after he became Chinese president. During that trip, Xi first proposed building a community with a shared future for mankind. The idea has become a fundamental principle of China's foreign policy. Several months later, Xi introduced the Belt and Road Initiative, widely seen as a significant step towards realizing his vision of a better world.

Over the past decade, the world has witnessed rising anti-globalization sentiments, lackluster global economic growth, and widening wealth gaps between the rich world and the least-developed countries.

When some countries in the West are blustering about de-coupling in the name of so-called "de-risking," China, under Xi's leadership, insists on win-win cooperation and genuine multilateralism. He fully understands that "only when people all over the world live better lives can prosperity be sustained, security safeguarded and human rights solidly grounded."

Xi has made personal efforts to ensure that countries benefit from the opportunities the BRI provides. One example is the revival of Greece's Piraeus Port, which was once on the verge of bankruptcy but has now become one of the busiest shipping hubs in the world.

Starting in 2014, Xi repeatedly brought up this flagship Belt and Road project during his meetings with Greek leaders. When visiting Greece in 2019, he made a special tour of the port.

"Seeing is believing," Xi said feelingly when witnessing this port being given a new lease on life. "The BRI is not a slogan or tale, but a successful practice and brilliant real-

Being fully aware of the mounting development needs of the Global South, the Chinese leader has always paid heavy attention to supporting the implementation of the United Nations Sustainable Development Goals. To that end, Xi proposed the Global Development Initiative in 2021. He called on the international community to ensure every country is included in global modernization.

In fact, Xi's emphasis on bridging the development gap in the world can be traced back to when he served as a local Chinese official.

As governor of China's southeastern Fujian Province, Xi supported numerous anti-poverty initiatives. Among these, the Juncao program was a flagship project involving cultivating edible mushrooms that can be used to feed animals and minimize soil erosion.

Knowing that poverty remains a global challenge, Xi has consistently advocated the Juncao technology during his visits to the South Pacific, Africa and South America. "He has paid great attention to the project as he knows very well what this small plant can offer," recalled Lin Zhanxi, chief scientist for the Juncao technology.

Lin's team provided the technology and personnel training for Juncao, which has been introduced to 106 countries and included in UN development plans due to its ability to solve problems such as food shortages. Some residents have even adopted the Chinese name "Juncao" for themselves, while others call it "grass of happiness."

"Attention should be paid to some urgent projects that benefit local people." That is Xi's clear-cut demands for all BRI projects. European opinion-maker Modern Diplomacy commented in a recent opinion piece that the BRI has contributed significantly to transforming developing economies in Africa through developing infrastructure, reducing unemployment and improving trade, among other things.

"China does not aim to exploit Africa as the Western world imagines, because along with developing African infrastructure, the Belt and Road Initiative is helping Africa transform itself," it noted.

And the initiative's benefits are believed to reach even more corners of the world in the years ahead. According to a World Bank report, increased trade via Belt and Road cooperation "is expected to increase global real income by 0.7 to 2.9 percent," and BRI projects "could help lift 7.6 million people out of extreme poverty." Another report by global economic consultants Cebr estimated that the BRI. whose benefits "are widespread," "is likely to boost world GDP by 7.1 trillion U.S. dollars per annum by 2040."

For former Thai Deputy Prime Minister Phinij Jarusombat, the BRI "is a farsighted, world-class initiative," as it "brings peace, cooperation, development and sharing to the world. It reduces contradictions and conflicts, making people turn to seek exchanges and cooperation in the fields of culture, trade and travel."

"I have met leaders of many countries. In my eyes, Chinese President Xi Jinping is a broad-minded leader with poise and unswerving determination," he commented.

Panamanian economist Eddie Tapiero, author of the first systematic study of the BRI in Latin America, said, "The BRI inherits the spirit and essence of the ancient Silk Road, advocating peace and emphasizing seeking common development through dialogue and cooperation."

"My friends once asked me, 'What's the point of studying this?" he said. "I told them: 'It's for a better world." **Xinhua**

National parks earn 463.3 billion/- from visitors in 2022/23

NATIONAL parks in Tanzania earned a total of 463bn/- during the financial year 2022/2023, an increase of 43.4 percent compared to 323.2bn/- earned in 2021/2022, provisional data by Tanzania National Parks Authority (Tanapa) and Ngorongoro Conservation Area Authority (NCAA) ha said.

The amount was four times higher than 108.1bn/earned in 2020/2021 during the pandemic and more than eight times of the earnings reported during 2019/2020, when the world was at a standstill due to lockdowns and travel restrictions.

The increase of earnings resulted from an increased number of visi-

million last financial year from 1.8 million visited in 2021/2022 and 815,740 during 2020/2021.

The highest revenue growth was recorded in Lake zone of Tanzania mainland, with 99 percent to 169.4bn/- during the financial year 2022/2023, compared to 84.75bn/- recorded during previous financial year.

The report shows, Lake Zone accounts for 36 percent of national parks' revenue and 23.8 percent of number of visitors.

However, northern zone still dominates national parks tourism activities as it accounts for 65 percent of total visitors and 58.7 percent of revenue.

During the financial year 2022/2023, number of visitors to zonal parks intors by 17.9 percent to 2.2 creased by 7.9 percent to 1.4

million in 2022/2023 from 1.3 million in 2021/2022, while earnings from visitors jumped by 20.9 percent to 271.98bn/- compared to 224.99bn/- respectively.

Number of visitors to central zone was second highest with 54 percent to 115,443 in 2022/23, compared with 74,977 who visited in 2021/2022, while revenue was third highest with the growth of 74.7 percent to 5.08bn/- compared with 2.9bn/- respectively.

According to NCAA and Tanapa data, southern highlands zone recorded the highest growth of number of visitors with 97 percent to 44,175 visitors during the last financial year, compared to 22,424 in 2021/2022.

However, southern highlands accounts for only 2.7 percent of visitors and 0.9 percent of total revenue from national parks. In south eastern zone of Tanzania, which accounts for 3.9 percent share of visitors and 2.7 percent of revenue, number of visitors went up by 45.7 percent to 86,722 in 2022/2023 from 59,511 in 2021/2022 while revenue jumped by 98 percent to 12.6bn/- compared with 6.6bn/- respectively.

Likewise, the number of visitors and earnings from museums improved relative to the preceding

The number of visitors to museums increased by 6.3 percent to 78,946 in 2022/23 from 74,267 registered in the preceding year.

Accordingly, earnings rose by 64.8 percent to 892mn/-. Dar es Salaam zone continued to account for the largest share of both the number of visitors and earnings at 63 percent and 79.5 percent, respectively.

South eastern zone museums recorded the highest growth of visitors with 70.3 percent to 7,448 during last financial year from 4,374 visitors in 2021/2022, while revenue growth by 1.2 percent to 53.8 million compared to 53.2mn/- respectively.

Provisional data for 2022/2023 show number of visitors to Dar es Salaam museums slowed by 8.7 percent to 49,762 compared to 54,504 who visited in 2021/2022 while revenue went up by 72 percent to 709mn/- compared to 411.1mn/- respectively.

Koreans invest in cashew nuts shell liquid extractions

SOUTH Korea based company-Tan-Ko Mirae Green Co. Ltd has built two state-of -the art manufacturing factories worth US\$ 5 million at Dundani village in Mkuranga District, Coast Region to produce eco-friendly Cashew Nut Shell Liquid (CNSL) oil that has huge market in South Korea for power plant and cashew kernel for export in other countries.

Youngwoong Kim, Tan-Ko Mirae Green Co.Ltd, managing director named two factories as Cashew Nut Shell Liquid (CNSL) manufacturing factory and cashew processing factory, all these factories is located at Dundani Industrial Park of Mkuranga District.

CNSL manufacturing factory has capacity to produce 3,000 tons of CNSL oil per year, while cashew processing factory has capacity to produce 3,500 tons of cashew kernels per year.

"We are exporting CNSL oil to South Korea, this oil is used for power plant for producing electricity," he said.

CNSL manufacturing factory was officially established in June last year and has managed to create employment for 50 people in the processing facility.

While construction work of cash-

ew processing factory is underway at Dundani industrial park, will start operation at the end of December this year to produce cashew kernels for export market in abroad.

The plant will assist farmers in Mkuranga District and other parts of the country to have a reliable market for their commodities and the company will access the raw materials from farmers.

In a bid to meet the market requirements in abroad and South Korea, the company has brought a sample of Nousbo's Controlled Released Fertilizer (CRF) from South Korea to Tanzania as well as show Cashew Nut Board of Tanzania (CBT)'s management and TARI-

Naliendele, center director to see how farmers can utilize the fertilizer tto increase their income and cashew nut production.

Also the company is now looking for 30,000 hectares of land from CBT to enter into cashew nut plantation to meet the market demand.

So far they have been able to meet with Francis Alfred, Cashew Nut Board of Tanzania (CBT)'s director general with whom they discussed about what they are doing, Nousbo Controlled Released Fertilizer (CRF) and how can secure 30,000 hectares of land for investment to enter into cashew nut plantation in Tanzania to increase cashew nut production.

"As company we are very glad for what has been achieved so far because CBT's management is now looking for 30,000 hectares of land so that we can enter into cashew nut plantation and were also impressed with the fertilizer," he said.

CBT has agreed to support them to secure land because they want to boost cashew nut industry, boost Tanzanian economy, help farmers move from traditional farming to modern farming, raise their income and strengthen the business links between Tanzania and South Ko-

He named advantages of using Nousbo CRF fertilizer as yield increase more than 40 percent compared to conventional fertilizer, reducing dosage per tree by more than 70 percent, reducing labor cost and reducing dosage per tree it will be reducing shipping cost.

"Before the construction of the factories we carry out an in-depth feasibility study of cashew- value chain in Mtwara Region, Mkuranga District and other regions to see how we can contribute to Tanzania cashew nut industry," he said.

Also they had a meeting with Prime Minister Kassim Majaliwa in South Korea in 2017 and have a face-to- face discussion about what we are doing and plans they have and he said, he will provide full support to them.

WFP challenges Tanzania to boost sorghum production

THE UN Agency has challenged Tanzania to increase production of sorghum, in order to cater for the skyrocketing demand of the grain and pro-planet crop in the world market.

The Monitoring Officer at the UN's World Food Programme (WFP), William Lasway unveiled that demand by the world's largest humanitarian organization was to purchase at least 200,000 tons of sorghum from Tanzania each season but the country has failed to carter the demand.

He said WFP has been purchasing a huge volume of sorghum for humanitarian support to the population in need into different countries across the continent, especially in Sudan,

He raised the concern during a special forum which attracted the stakeholders in the country's sorghum crop, including the farmers, buyers, seeds producers as well as those involved in the fertilizer sector.

Convened in Dodoma Capital City, the forum tailored to provide a useful podium for the participants to brainstorm over the development of the vital agricultural sub-sector.

"Tanzania has been endowed with a favourable agroclimatic zone and suitable soil for the cultivation of the crop, but many efforts are needed to assist the farmers to engage into vast and professional production of sorghum," he observed.

Lasway however revealed that WFP has for a long time been working



collaboratively with the government to assist the local farmers to increase production and productivity, being in efforts to enable them getting the needed tonnage in each season.

"Most of the involved growers are still far from reliable access to improved seeds varieties, the existing gap which needs to timely be contained, as well

as improving interventions towards the value addition to the crops produced," he urged. Speaking for his part, the Project

Officer at the Farm Africa, Meshack Panga said that the international organisation was running a specific project to scale up production of sorghum among the farmers in all districts of Dodoma Region. "Through the robust project, we

have so far managed to reach out to a total of 30,000 farmers across the districts and the initiative continues to support the farmers until 2028 where it will phase out," he expressed.

"When we started the project the price of sorghum ranged between 200/- and 250/- per kilogram but we sensitized and assisted the farmers to improve their production quality to the good extent that currently, the prices have substantially increased to 800/- per one Kg," he informed.

Patric Byeshulilo, an officer from Apeck International Limited told the

forum that his company was working to search for vast markets for the crop in different countries, saving they have so far managed to get a market for at least 6,000 tons in Burundi.

The Ouality Assurance Officer at the Cereals and Other Produce Board of Tanzania (CPB), Mwanahamisi Msangi said the state-owned Board is the major buyer of the sorghum produced by the local farmers.

She briefed that during the 2020/21 season CPB bought a total of 1,000 tons, while in the 2021/22 season they purchased at least 3,000 tons.

"During 2022/2023 we purchased a total of 3,000 tons and our expectation is to purchase at least 10.000 tons come next season," she expounded.

Agricultural and Marketing Officer at the Tanzania Agricultural Seed Agency (ASA), Ezekiel Noah said for the current season, the Agency has in stock a total of 200 tons of improved seeds for assisting the farmers.

Access to capital now mining's second-biggest risk after ESG

WHILE environmental, social and governance (ESG) remains the biggest risk to mining companies, executives are now ranking capital as the second-biggest risk as the sector grapples to fund the expansions required to meet increasing demand for minerals crucial to the energy

This is according to EY's recently published 2024 top ten business risks and opportunities for mining and met-

Capital has moved up to number two in the latest ranking, up from number eight last year.

EY notes that the sector will require access to significantly more capital if it is to mitigate the looming deficits of minerals needed for the energy transition. Yet, capital raised through debt and equity has remained steady at \$178-billion in the first seven months of the year.

Global mining and metals leader Paul Mitchell says it appears that capital is moving to new commodity markets rather than solving what is already a significant risk.

Iron and steel, gold and coal companies have attracted the most capital since 2022, but investment is increasing

Dollar mixed vs major peers; UK pounds slips

LONDON

THE US dollar swayed in a tight range on Tuesday as traders took stock of developments in the Middle East and braced for speeches this week by central bank officials, while the pound dipped as data indicated a softening labour market.

The yen briefly surged but quickly trimmed gains after a media report that the Bank of Japan was considering raising its core CPI forecast for the 2023 and 2024 fiscal years but maintaining the inflation outlook for 2025.

The yen last fetched 149.47 per dollar, having risen as high as 148.75 after the report, as analysts said the kneejerk reaction to higher inflation forecasts in the near term was negated by the longer-term projec-

"Central banks are not trying to hit the CPI targets in the near term," said Colin Asher, senior economist

"For my part, I see a decent risk that the BoJ is underestimating the risks of the CPI remaining elevated into FY25, which is one reason why I expect that the BoJ will be forced to tighten policy in the New Year," Asher added.

Investors were also on edge for any signs of intervention by the Japanese authorities as the ven traded close to the 150 level that prompted officials to step in to buy the currency in 2022.

Japan's top financial diplomat Masato Kanda said the yen was still perceived as a safe haven asset like the dollar and the Swiss franc despite its recent weakness, and was benefiting from demand due to the conflict in the Middle East.

Valentin Marinov, Credit Agricole CIB global head of G10 FX research and strategy, said the main drivers in broader currency markets continued to be tensions in the Middle East and elevated global bond

"The key question for the markets remains the scope for further escalation," Marinov said.

"As long as oil prices remain well behaved in the face of geopolitical tensions, that will mean that costpush inflation may not re-accelerate and, by implication, the Fed could stick to its recent more-dovish rhetoric ruling out further rate hikes."

The dollar index, which measures the US currency against six peers, fell 0.1 percent to 106.13, after dropping 0.4 percent on Monday.

Investor attention will firmly be on Federal Reserve Chair Jerome Powell, who is due to speak on Thursday, during a busy week of speeches by regional bank heads. Fed officials will enter into a blackout period on Oct. 21 before the central bank's Oct. 31-Nov. 1 meeting.

Federal Reserve Bank of Philadelphia President Patrick Harker said on Monday the central bank should not create new pressure on the economy by increasing the cost of borrowing.

"To avoid disclosure missteps and make the best use of resources, miners will need a better view of high-quality ESG data, with strong governance and controls in place to ensure appropriate sign-offs and processes," says Mitchell.

Licence to operate (LTO) is the third biggest risk for miners, with mining and metals companies facing higher expectations than many other sectors. Miners typically operate on land that is licensed, not owned, and navigate a range of formal and informal conditions around how minerals are extracted.

EY says that in the past, LTO was focused on Indigenous trust and reconciliation. Today, its scope has expanded to encompass trust at a societal level.

Sixty-four percent of survey respondents said community impact was the top ESG issue facing scrutiny from investors in 2024. Executives say their understanding of sustainability-related matters has increased significantly over the years – but now they realise they cannot tackle all matters at once. The big question is what to prioritise to create real and lasting impact.

"Licence to operate is increasingly challenging, with a broadening range of stakeholders and issues – creating a long-term focus on value beyond life-of-mine and working with communities to co-develop solutions is key," says Mitchell.

Following ESG, capital and LTO, the list of top-ten risks is completed by climate change, digital transformation and innovation, cost management and productivity, geopolitics, cybersecurity, new business models and workforce dynamics. Cybersecurity has re-entered the ranking for the first time since 2020, as companies experience increased attacks due to a more complex threat landscape that spans both information technology and operational technology. The survey also highlights a growing concern from miners around intellectual property, as they broaden their thinking from cyber threats being a technology problem to a business risk. With only 40% of mining and metals boards confident they understand the biggest cyber threats facing their organisation, it is clear that cyber requires greater attention.

THE Israel Defence Forces spokesman said US President Joe Biden's visit to Tel Aviv will not affect or complicate the ground operation in Gaza, The Times of Israel reported yesterday.

"I think the president also said that 'Hamas needs to be destroyed,' and that is exactly our military aim," the publication citing a CNN report quoted the IDF

Biden will make a wartime visit in the latest demonstration of Washington's overwhelming support for Jerusalem following the October 7 Hamas onslaught.

He will be the first head of state to visit Israel since the conflict began. He delivered a passionate speech last week in which he expressed his horror over the brutal Hamas assault, winning over Israelis across the political spectrum.

US President Joe Biden is set to visit Israel on Wednesday at a time when the country is facing its toughest battle with the terrorist group Hamas.

US Secretary of State Antony Blinken while addressing a press conference here on Tuesday said that President Biden is coming to Israel at a "critical moment" and will reaffirm the US' solidarity with Israel.

"US President Joe Biden will visit Israel on Wednesday. He is coming here at a critical moment for Israel, for the region, and for the world. President Biden will reaffirm the United States' solidarity with Israel. President Biden will again make clear, as he's done unequivocally since Hamas's slaughter of more than 1,400 people, including at least 30 Americans, that Israel has the right and indeed the duty to defend its people from Hamas and other terrorists and to prevent future attacks," he said.

He further added by saying that President Biden will continue to coordinate closely with the Israeli partners to secure the release of hostages taken by Hamas.

"President Biden will underscore our crystal clear message to any actor, state or non-state trying to take advantage of this crisis to attack Israel, don't. President will continue to coordinate closely with our Israeli partners to secure the release of hostages taken by Hamas...The United States and Israel have agreed to develop a plan that will enable humanitarian aid from donor nations and multilateral organizations

to reach civilians in Gaza," he said. Blinken noted that President Biden will also receive a comprehensive brief on Israel's war aims and strategy.

BEIJING CHINESE President Xi Jinping yesterday called for more cooperation in the Belt and Road Initiative, as he met with various international leaders, who are in Beijing to attend

During his meeting with Tokayev, Xi said he is very happy to meet his old friend again. A sound, stable and vibrant China-Kazakhstan relationship is conducive to the development and revitalization of both countries as well as to regional peace and stability, Xi said.

China supports Kazakhstan in safeguarding its independence, sovereignty and territorial integrity, Xi

No matter how the international situation changes, China and Kazakhstan should pass on the concept of good-neighborliness and friendship from generation to generation, and promote further development of China-Kazakhstan permanent comprehensive strategic partnership, Xi said.

Xi called on the two sides to strengthen cooperation, promote the Belt and Road cooperation to achieve more results, and deliver more benefits to the people of the two countries.

China is willing to continuously facilitate trade and investment with Kazakhstan, expand imports of high-quality and green agricultural products from Kazakhstan, and broaden green energy cooperation with the country, Xi said.

The two countries should promote exchanges in digital technology including cross-border e-commerce, artificial intelligence, big data and blockchain. Xi said.

He also called for stronger people-to-people and cultural exchanges and closer cooperation at the local level, noting that a mutual visa exemption agreement between the two countries will take effect and that the Kazakhstan tourism year will be launched in China next year.

He noted that China is ready to improve connectivity with Kazakhstan and increase the transport capacity, scale and efficiency of China-Europe freight trains.

Xi said China and Chile should deepen traditional cooperation in economy, new drivers of growth for cooperation on clean energy, digital economy, and scientific and technological innovation, to make Chile a leading country in high-quality Belt and Road cooperation between China and Latin America.

China welcomes more high-quality agricultural products and specialties from Chile to enter the Chinese market, he said.

Xi said that both China and Chile belong to the Global South. China is willing to strengthen communication and coordination with Chile to uphold solidarity and cooperation among developing countries, and safeguard true multilateralism and free trade.

Russia to retaliate if US deploys medium, short-range missiles to Europe – MFA

UNITED NATIONS

RUSSIA has made it clear that it will inevitably take retaliatory measures if the US deploys intermediate-and shorter-range missiles to Europe, Vladimir Yermakov, director of the Russian Foreign Ministry's Non-Proliferation and Arms Control Department, said.

"Russia's unilateral moratorium on the deployment of land-based intermediate-and shorter-range missiles is directly linked to what the US does in this regard.

The unambiguous statements about the inevitability of our retaliatory measures that the Russian authorities made when announcing the aforementioned moratorium leave no room for any other interpretation," he noted in an interview with Russian reporters, when asked if Russia would deploy similar weapons in response to Washington's potential deployment of intermediate-and shorter-range missiles in Europe.

The senior Russian diplomat stressed that the current confrontation between Russia and the US had been triggered by Washington.

"In general, given the aspects of the current standoff between our countries, which was triggered by Washington, Russia has to take certain steps in the strategic field that remove, or at least reduce, the existing and emerging imbalances. In my view, such steps include the decision to deploy Russian nuclear weapons to Belarus in response to NATO's practice of 'joint nuclear missions,' as well as the potential withdrawal of our ratification of the Comprehensive Nuclear-Test-Ban Treaty (CTBT), aimed at mirroring the stance taken on the document by the US," Yermakov emphasized.

Earelier, Russian President Vladimir Putin said at a plenary session of the Valdai Discussion Club that Moscow could revoke its ratification of the CTBT because the US had failed to ratify the document.

It is up to the State Duma (lower house of parliament) to make a decision, the president added. State Duma Chairman Vyacheslav Volodin, in turn, said that the move to revoke CTBT ratification was fully in line with Russia's national interests.

The Russian leader made the statement during separate telephone conversations with Raisi, Sisi, Syrian President Bashar al-Assad, and Palestinian President Mahmoud Abbas, in which the leaders discussed the recent escalation in the conflict between Israel and Palestine.

He noted that Russia's draft resolution, recently proposed to the United Nations Security Council, calls for the implementation of an immediate humanitarian truce, adding that the resolution is not politicized in any way.

Putin reiterated that a long-term fair solution to the conflict should provide for the establishment of an independent Palestinian state coexisting in peace and security with Israel.

The leaders further expressed extreme concern over the escalation in hostilities between Palestine and Israel, particularly the "catastrophic increase" in the number of civilian casualties and the deepening humanitarian crisis in the Gaza Strip.

Humanitarian aid

Tens of trucks loaded with humanitarian aid, medical supplies, food and blankets are lining up on Tuesday at the Rafah crossing, waiting for access to the coastal enclave of Palestine from the Egyptian side.

"Trucks moved from Arish city in north Sinai in the early hours of Tuesday to the Rafah crossing," Shihata Saber, a truck driver told Xinhua.

"I'm proud to be part of the covey. We are ready to enter aid to our brothers in Palestine," said Saber, who had waited for nearly four days after loading the aid

After crossing Rafah, the trucks will head to the Kerem Shalom border crossing to be inspected by the Israeli side before moving to Gaza, an Egyptian security official told Xinhua on condition of anonymity.

Shipments of aid from Jordan, Türkiye and the United Arab Emirates had arrived at the Arish airport, 50 km west of Rafah, together with medical supplies provided by the World Health Organization.

"Since the beginning of the conflict, Egypt attempted to keep the Rafah crossing bordering with Gaza open to deliver aid in coordination with the United Nations," said Egyptian Foreign Minister Sameh Shoukry in a joint press conference with his French counterpart on Monday.

"(However) The Israeli government has not taken any measure from the side of Gaza to allow access,"

Civilian evacuation

Also on monday, twenty-six countries have requested Cyprus' assistance in repatriating their nationals from both Israel and the Gaza Strip, said Konstantinos Letymbiotis, spokesman for the government of Cyprus.

"We are responding to the best of our abilities," Letymbiotis said.

Earlier on Monday, Cyprus' National Council examined the situation in the region and possible developments that could affect Cyprus.

Cyprus has activated a national emergency plan and mobilized government services and non-governmental organizations to provide assistance to thousands of people who are expected to arrive in Cyprus. Portugal, the United Kingdom and Denmark have already evacuated aboard military transport planes from Tel Aviv to Cyprus around 600 people, of whom 447 have already departed from Cyprus on commercial flights.

The Royal Australian Air Force has joined the effort to repatriate Australian citizens stranded in Israel.

Richard Marles, the minister for defense and deputy prime minister, Penny Wong, foreign affairs minister, and Bill Shorten, the minister for government services, on Monday evening announced that two Air Force aircraft joined a government-supported charter to fly 255 Australian citizens from Tel Aviv's Ben Gurion Airport to Dubai on Monday.

Cypriot authorities have also provided assistance to another 2,500 people, mostly Israelis, who arrived on commercial flights.

UNGA President calls for 'immediate release' of hostages, aid to civilians in Gaza

NEW YORK CITY

UNITED Nations General Assembly (UNGA) President Dennis Francis (pictured) on Monday called for the release of hostages taken from Israel and providing uninterrupted access of ci-



vilians to humanitarian aid in Gaza.

In a post on X, Francis has echoed the UN Secretary-General Antonio Guterres' appeal for the "immediate release" of hostages from Israel.

"I join the @UN Secretary-General @antonioguterres in his appeal for the immediate release of all hostages taken from Israel & for the unimpeded access of humanitarian aid to civilians in Gaza in line with international law," posted the UNGA President on X.

"Civilians have been suffering the horrific consequences of violence since the attacks by Hamas against Israel on October 7. I join the Secretary-General Antonio Guterres in his appeal for the immediate release of all hostages taken from Israel and for the unimpeded access of humanitarian aid to civilians in Gaza in line with international law," the post

Earlier in the day, Secretary General of the United Nations, Antonio Guterres called on Hamas to immediately release the hostages without keeping any sort of conditions.

In a post on social media platform X, Guterres made two humanitarian appeals amid the present situation in the Mid-

dle East. "As we are on the verge of the abyss in the Middle East, I have two humanitarian appeals: To Hamas, the hostages must be immediately released without conditions," he post-

"To Israel, rapid & unimpeded access for humanitarian aid must be granted for the sake of the civilians in Gaza,'

"Each one of these two objectives is valid in themselves. They should not become bargaining chips and they must be implemented because it is the right thing to do," Guterres said in a statement, adding that "Gaza is running out of water, electricity and other essential supplies," The Times of Israel reported.

According to the latest update, 1300 people have been killed, with over 3600 injured, reported The Jerusalem Post. Defence Minister Gallant said that on an estimate, 150-200 Israelis are being held hostage by Hamas in the Gaza Strip, adding, "We are making every effort to locate them even in this great complexity."

According to the latest update, 1,300 people have been killed and over 3600 injured in the Hamas terror attacks, reported The Jerusalem Post. As Israel continues to retaliate against Hamas, Israel Prime Minister Benjamin Netanyahu on Sunday said that Hamas thought Israel would break, but "We will break Hamas," reported The Times of Israel.

During the weekly cabinet meeting, the Prime Minister along with ministers stood in silence for a minute and paid tribute to those who lost their lives in the deadly Hamas at-

"Hamas thought we would break; we will break Hamas," Netanyahu said.

He further stressed that Israel is working in unity and it conveys a clear message to Hamas and to the world.

"We are working around the clock as a team, with a united front," he says. "Our unity conveys a clear message to the people, the enemy, and to the world," he added.

The ministers shared a moment of silence, during which, Netanyahu said, "In memory of our brothers and sisters who were murdered in cold blood, and our heroic warriors who fell in battle."

Netanyahu noted that it was the first meeting of the emergency war government and that five members of the National Unity Party were present Benny Gantz, Gadi Eisenkot. Chili Tropper, Gideon Sa'ar, and Yifat Shasha-Biton.

Moreover, he emphasized that the entire nation is behind the front-line warriors of Israel.

"I saw our wonderful warriors who are now on the front line. They know that the entire nation is behind them," he said.

A 45-year-old Tunisian gunman suspected of killing two Swedish football fans in Brussels died yesterday after being shot by police in a cafe, Belgium authorities said, while Sweden's prime minister called for stronger EU border The attacker, who identified him-

self as a member of Islamic State and claimed responsibility in a video posted online, is suspected of killing two Swedish nationals and wounding a third in central Brussels on Monday night.

"The perpetrator of the terrorist attack in Brussels has been identified and died," Interior Minister Annelies Verlinden posted on X, hours after Prime Minister Alexander De Croo called Monday's shooting a brutal "terrorist attack".

The shooting came at a time of heightened security concerns in some European countries linked to the Israel-Hamas conflict, though a Belgian federal prosecutor said there was no evidence that the attacker had any link to the renewed conflict between Israel and Palestinian militants.

In August, Sweden raised its terrorism alert to the second-highest level and warned of an increase in threats against Swedes at home and abroad after Koran burnings outraged Muslims and triggered threats from jihad-

reported.

Swedish Prime Minister Ulf Kristersson told a news conference on Tuesday that security should be beefed up and Sweden and the EU needed better border controls.

"I understand that many Swedes are afraid and angry," Kristersson said, adding: "This is a time for more security, we can't be naive.'

The suspected attacker, who unsuccessfully sought asylum in Belgium in November 2019 and was living in the country illegally, was known to Belgian police in connection with people smuggling, Justice Minister Vincent Van Quickenborne said earlier on Tuesday.

In a video on social media, the suspected gunman called himself Abdesalem Al Guilani.

Belgium's Verlinden said earlier that she could not rule out that he had had accomplices.

The gunman fled the scene after the shooting on Monday as a football match between Belgium and Sweden was about to start, triggering a massive manhunt and prompting Belgium to raise the terrorism alert in its capital to its highest level.

"The perpetrator targeted specifically Swedish supporters who were in Brussels to attend a Red Devils soccer match. Two Swedish compatriots passed away. A third person is recovering from severe injures," de Croo

De Croo posted on social media that Belgium was "now

making sure the Swedish soccer fans can travel back home safely". Sweden's Sapo security police said they were in contact

with international counterparts.

"We are in a serious situation ... Sweden has (over time) ended up in an increasingly clear focus of violent Islamist extremism," a Sapo spokesperson said in a statement.

French President Emmanuel Macron said on Monday that Europe was "shaken". France is deploying 7,000 extra troops on to its streets after a teacher was fatally stabbed on Friday in an attack Macron condemned as "barbaric Islamic terrorism".

Video footage of the Brussels attack posted on the Het Laatste Nieuws newspaper website showed a man in an orange jacket on a scooter at a street intersection with a rifle first firing five shots, then following people fleeing into a building before firing again.

The newspaper said on Tuesday that police were looking for an accomplice who filmed the attack.

According to a media transcript of the video message recorded by the self-declared perpetrator, the attacker said he had killed Swedes to take revenge in the name of Mus-The European Commission, which is based in Brussels.

Miquissoine (pictured), has not had a strong start to his second spell at Simba SC, he has so far managed to register assists in all competitions he has played for the outfit this season.

A section of Simoa SC supporters have begun to worry whether they will ever see the first version of Miquissoine when he was in his first spell at the club, such a concern comes with the reference to many players who have experienced the same fate.

Sometimes a person has to move elsewhere because things do not go the way such a person expects, he/she attempts to put things back in order but such an attempt is no longer possible.

It happened to Belgian winger, Eden Hazard, during his spell at England's Chelsea and, thereafter, the winger left for Spanish football giant, Real Madrid.

Hazard is a winger who has left many debates on how best he was in comparison with various great players including Messi, Neymar, and Mohamed Salah.

Things, though, have fallen apart for the Belgian winger and now he has retired at 32 years old after Real Madrid terminated his contract.

It also happened to Brazilian midfielder, Philipe Coutinho, during his breakout year at English outfit, Liverpool.

He was regarded as the next breakout star behind English midfielder, Steven Gerrard, and Uruguay's forward, Luis Suarez, but he left for Barcelona without reaching his pinnacle at the English club.

As Andres Iniesta's successor at Barcelona, it did not go as planned for Coutinho, he was loaned to Bayern Munich where he struggled for game time despite winning the Champions League with the German side.

Bayern did not exercise the loan clause for teh Brazilian and he returned to Barcelona which made his services available on the transfer market.

Aston Villa signed Coutinho from the Catalans. A few years ago, it was Aston Villa's dream to sign the Brazilian but now the outfit effortlessly landed the former



Liverpool man and, yet, he failed to break into the English outfit's first team.

Once a soccer lover reflects, he/she might wonder what would have happened if both Coutinho and Hazard never left Liverpool and Chelsea respectively. Is this what is happening to Miquissoine?

I know Simba SC fans wish he never left the outfit in 2021 but nothing could stop him as he was quite popular in the transfer market and top clubs in Africa were after his services.

The sign-on fee for the winger was huge and his salary was expensive for any club to afford. Above all, he joined CAF Champions League winners, Egypt's Al Ahly.

After several loan spells, while playing for Al Ahly, Simba

SC has retained Miquissoine from the Egyptian football powerhouse and he has turned out to be a player who is a different version of the footballer the Tanzanian club sold to Al Ahly.

He was said to be fat, once he made his way back but later he was said to be not physically fit and, thereafter, he worked on his weight and became slim.

Was the weight holding back his prowess? Such a question comes about because even after being in good shape, some of the Msimbazi Street club's fans have not seen the prowess and impact he is known to have brought to the team.

In the past NBC Premier League game, which saw Simba SC take on Singida Fountain Gate FC, the Mozambican winger came off the bench and, a few minutes later, Singida Fountain Gate FC right-back, Nicholas Wadada, attempted to set up an offside trap for him.

Miquissoine left Wadada 20 meters from the center of the pitch and was one against one with goalkeeper Beno Kakolanya.

What happened is Wadada managed to run back and keep Miquissoine in check, the former felt the Mozambican winger had the pace but, in the eyes of the fans, he lacked the pace he has been known to have.

Miquissoine, again, was a substitute in the tie, at his best, he was the first XI player- the kind of a player that a football enthusiast would think of when lining up Simba SC's starting line-up.

Long wait for fans held in stadium after Brussels attack

BRUSSELS

WORRIED, but relieved, spectators at the Belgium-Sweden Euro 2024 match left the Brussels stadium shortly before midnight after being held there for two-anda-half hours following the killing of two Swedes in a nearby attack, with the gunman still at large.

"I was stressed, I wondered how we were going to get back, because we came by metro," Manon Antoine, 21, told AFP, accompanied by her brother.

The Swedish supporters were the last to leave the King Baudouin Stadium, where some 35,000 fans of the two teams had turned out for the Euro 2024 qualifier.

Manu Leroy, CEO of the Belgian football association, said police had escorted the Swedish fans and players to "go straight to the airport and leave" because the perpetrator, who was said to be inspired by the Islamic State group, was still on the run and being sought by police early Tuesday.

According to investigators, the Swedish nationality of the victims was a "probable motivation" of the attacker, according to his video

Several Belgian media outlets said the two individuals killed were wearing football shirts belonging to the Swedish national team.

The area around the stadium, located about five kilometres (three miles) from the scene of the attack, was being monitored by police, and traffic past the ground had been halted.

- 'The safest place' -

About 10 minutes before kickoff, match organisers learned that "something serious had happened", Leroy said on RTBF.

"At first it was decided that the match should go ahead because the stadium was the safest place for the fans, especially the Swedish fans so that they would be safe," he

But at halftime, the match was halted with the score at 1-1 and did not restart.

UEFA said the decision to abandon the game was taken after consultation with both teams and the Belgian authorities.

"I am terribly sad. We agreed 100 percent not to play the second half because of the conditions and out of respect for the victims and their families," said Sweden coach Janne Andersson, quoted by the Swedish news agency TT.

Held inside the stadium as a security precaution, the fans braved the cold and the anxiety by singing songs in honour of Sweden and chanting "All together, all togeth-

"I think that we all tried to keep our spirits up. We also sang little songs for the Sweden supporters because it is especially for them that it is a very sad evening," said football fan Jacques Decoq outside the stadium.

"THEY never do things the easy way."

"We tried to stay warm with a little bit of atmosphere."

Finally, shortly before midnight, Red Devils fans began to leave the stadium, the authorities having chosen to evacuate the Belgian supporters stand by stand to avoid

Meanwhile, French prosecutors on Monday launched a preliminary investigation into a top-flight footballer on suspicion of "glorifying terrorism" after he reposted an allegedly anti-Semitic message on social media relating to the Israel-Hamas conflict.

Youcef Atal, an Algerian international who plays for Ligue 1 club Nice, is suspected of sharing a video from a Palestinian preacher on Instagram purportedly calling for violence against Jewish people.

Football officials, politicians, a Jewish group and the mayor of Nice have all condemned the message, which Atal deleted before apologising.

AFP has not been able to independently verify the content of the original post.

France, which has large Jewish and Muslim populations, ramped up security after Hamas launched a massive attack on Israel on Octo-

And officials put the country on high alert for potential attacks after a teacher was stabbed to death on Friday by a former pupil, in what politicians have said was Islamist terrorism.

The Nice prosecutor's office confirmed in a statement it was investigating Atal under laws covering the "glorification of terrorism" after being notified by local politi-

The prosecutors said police would also assess if the post amounted to incitement to religious hatred or violence.

The French Football Federation (FFF) said on Sunday its ethics committee would investigate the player, with FFF president Philippe Diallo denouncing the

contents of the post. OGC Nice "is taking the situation very seriously and plans to meet with Youcef as soon as he returns from international duty," a club source told AFP.

Atal responded to the criticism on Sunday, telling his Instagram followers he would "never support a message of hate", without explaining why he had shared the

SUBSTITUTE Marcel Sabitzer scored from the penalty spot shortly after entering the game to secure a 1-0 win for Austria at Azerbaijan and send his country to next year's European Championship in a day overshadowed by a deadly shooting in Brussels which saw Belgium's game against Sweden halted at halftime.

"Due to the incidents in Brussels earlier tonight, play is suspended. Our thoughts are with all those affected," a post from the Belgian national team read on X, formerly known as Twitter.

European soccer governing body UEFA confirmed the Group F match had been called off following consultation with both teams and local police.

The score was 1-1 at the time. Viktor Gyokeres gave Sweden a 15th-minute lead, but Romelu Lukaku had Belgium level just after the half-hour.

Belgium had already qualified for Euro 2024 while Sweden's chances of a top-two place had been ended by Austria's victory earlier.

AUSTRIA ADVANCES

After losing 3-2 to Belgium in Vienna last week in the fight for Group F supremacy - Austria's only defeat in seven qualifying games so far - Sabitzer and his teammates knew a win in Baku would secure a spot at the tournament hosted by Germany.

With several key players sidelined because of injuries, Austria struggled to create real chances in the first half. It was awarded a penalty just minutes into the second half after a hand ball. Sabitzer was clinical in converting

Man United Sale: Ratcliffe bid, Sheikh Jassim withdrawing, Glazers could remain in control

MANCHESTER, England

NEARLY a year after Manchester United was put up for sale, the storied English soccer club could still remain in the hands of the Glazer family - much to the dismay of the team's most fervent supporters.

News on Saturday that Qatari banker Sheikh Jassim bin Hamad Al Thani was withdrawing from the bidding process appeared to leave the door open for British billionaire Jim Ratcliffe. However, the owner of petrochemicals giant Ineos is reportedly only looking to buy a minority 25% stake in United, which would leave the Glazers as majority shareholders.

"Someone coming in as a minority partner and propping up the Glazers indefinitely is a nightmare scenario," Manchester United Supporters Trust spokesperson Chris Rumfitt told The Associated Press. "What the club needs is real change and it needs real investment and we struggle to believe that can happen whilst the Glazers own the majority of the shares permanently. Twentyfive percent for Ratcliffe could be OK, but only if it was the start of a clear path to 51%."

The Glazers, an American family that also owns the NFL's Tampa Bay Buccaneers, announced plans last November to seek new investment and instructed U.S. merchant bank Raine to oversee the process, which included the potential of a full sale.

Raine had previously conducted the sale of Chelsea to Todd Boehly and Clearlake Capital for 2.5 billion pounds (\$3 billion) plus a commitment of 1.75 billion pounds (\$2 billion) of further investment.

While the Glazers were prepared to consider offers for an outright buyout, United said at the time it planned to "explore strategic alternatives," which always included the possibility of taking on new investment without the owners ceding control.

The late tycoon Malcolm Glazer bought United in 2005 for 790 million pounds (then about \$1.4 billion). United supporters have been critical of the leveraged nature of the Glazers' buyout that loaded debt onto the club, as well as a perceived lack of investment and the dividends taken out by the owners.

The team still had a series of successes on the field. Under the Glazers, United won the Champions League title in 2008, five Premier League titles, one FA Cup, five League Cups and the Europa

INTERESTED PARTIES

Ratcliffe, who was born in the Manchester area and has been a United fan since childhood, has long-harbored ambitions to buy the club. Through Ineos, he initially planned to buy out the Glazers' share of about 69% and spoke of a "modern, progressive, fan-centered approach to ownership."

He was also focused on helping United win the Champions League for the

first time since 2008 and making it the "No. 1 club in the world once again." Sheikh Jassim is the chairman of Qatar Islamic Bank and the son of a former Qatari prime minister. He was bidding to take 100% ownership of United, which appealed to fans who are desperate to rid the club of the Glazers. He also vowed to clear the team's debt, while investing in the stadium,

training center and playing squads in a bid to "return the club to its former glories both on and off the pitch."

Ratcliffe and Sheikh Jassim were the only two bidders to publicly declare their intention to take control of United, while other minority investors were also reported.

DELAYS

It was anticipated the process would be concluded in time for the offseason transfer window, which opened in June, after a series of rounds of

It appeared to be a straight battle between Ratcliffe and Sheikh Jassim over who would be chosen as the preferred bidder. But as the process dragged on, fans became increasingly impatient and staged protests outside Old Trafford, while chants of "Glazers out" are regularly heard at games

News of Sheikh Jassim's plans to withdraw came after months of silence and uncertainty around the process, which raised questions about whether

the Glazers intended to sell. **BREAKDOWN**

On Saturday, the news came that Sheikh Jassim was withdrawing from the process. While the size of his bid was not confirmed, a person with knowledge of his proposal told the AP it was almost double United's current market valuation of \$3.2 bil-

The person spoke on condition of anonymity because of confidentiality restrictions around the process.

While concerns had been raised about Qatar's human rights record and the potential that United could be used as a "sportswashing" project, fans wanted to see the club compete with the exorbitant spending of Abu Dhabi-backed Manchester City.

RATCLIFFE'S CREDENTIALS

Ratcliffe is one of Britain's richest people and is said to be worth \$15.1 billion.

He previously tried to buy Premier League club Chelsea and already owns French club Nice, cycling franchise Team INEOS, is one-third shareholder of the Mercedes-AMG Petronas Formula One team and competes in the America's Cup with sailing team INEOS Britannia.

Reports say he would seek to take over soccer operations at United after a sustained period of decline since the retirement of former manager Alex Ferguson. United has not won the Premier League since Ferguson's last title in 2013.

Over the past decade, the club has been overtaken by City, which won three trophies last season – the Premier League, Champions League and FA Cup. Liverpool has also won the Premier League and Champions League in recent years.

United has endured a turbulent period the post-Ferguson era. Erik ten Hag is its fifth permanent manager in that time.

TP Mazembe to host Espérance in AFL clash in Dar

PARTICIPATION of Congolese football big gun, TP Mazembe, in the inaugural African Football League (AFL), is no longer at risk after the government tampering had put it in jeopardy.

A statement released by Tunisia's Espérance de Tunis has revealed that the first leg of the outfit's AFL quarterfinal clash, which was set to see it play against TP Mazembe in Lubumbashi, will be held at the Benjamin Mkapa Stadium in Dar es Salaam at the end of this week.

TP Mazembe, the five-time CAF Champions League champion, was poised to take on Espérance de Tunis in Lubumbashi.

However, the DR Congo club revealed on Sunday that the country's authorities had seized all necessary broadcast equipment from CAF for the encounter and also failed to issue the appropriate visas for the confederation's dignitaries.

TP Mazembe is believed to have even asked the Congolese Association Football Federation for assistance but to no avail.

It seems that with CAF's assistance, TP Mazembe, nicknamed 'The Ravens', has now found a solution

The Congolese side will, in this case, host the first leg in Dar es Salaam, with Espérance de Tunis, alias 'The Beast of Africa', set to host the decisive encounter in Tunis.

The AFL is set to kick off this Friday with Simba SC (Tanzania) and Al Ahly (Egypt) set to get the proceedings underway before the TP Mazembe versus Espérance de Tunis match.

In the tournament's other fixture, the third quarterfinal clash, Enyimba FC of Nigeria will meet Wydad Casablanca of Morocco.

The fourth of the last-eight fixtures in the showpiece will see Petro Atletico of Angola lock horns with Mamelodi Sundowns of South Africa.

The newly established eight-team competition is happening for the first time on the continent and will be launched in Dar es Salaam on Friday.

This is another privilege for Tanzania to be in the spotlight for becoming the first country to stage the opening match of the palatable contest.

The 60,000-capacity Benjamin Mkapa Stadium is currently undergoing final touches of rehabilitation ahead of the commencement of the AFL and the opening ceremony rehearsals are also underway.
