'Ngorongoro will recover relocation funds quickly'

FUNDS spent by the government for the relocation of a section of the pastoral community from Loliondo to Handeni district in Tanga region will be recovered within a short time, the Ngorongoro Conservation Area Authority (NCAA) has declared.

The relocation exercise was progressing well and by July 18 a total of 757 households had voluntarily registered to relocate to Msomera village.

Relocating families are given a modern three bedroom house within two and a half hectares space, farms and livestock feeding areas.

Dr Christopher Timbuka (pictured), the NCAA acting conservation commissioner said here that the government plans to spend 700bn/- in the exercise, with projected gains likely to be much higher than what was spent in the exercise.

Spending that amount was not a big deal as NCAA was likely to get the money from revenue accrued from tourism in a short period of time, he said, noting that plenty was being said about the whole process and why the communities have to be relocated.

PRESIDENT Samia Suhulu Hassan has received backing both at home and abroad for her plans to implement reforms in the criminal justice delivery system to improve good governance.

The president last week tasked a 12-member team of experts and veteran administrators to review operations of security organs to recommend reforms removing drawbacks in criminal justice mechanisms.

The team will be led by former Chief Justice Mohamed Chande Othman as chairman and retired Chief Secretary Ambassador Ombeni Sefue as vice chairman. It will begin work on the Tanzania Police Force, proceed to the Prisons Department, and other security

Several stakeholders have publicly voiced their support for the criminal justice reform agenda, with Norway's former ambassador to Tanzania, Hanne-Maria Kaarstad, making clear remarks on her Twitter handle.

"Important initiative by Tanzania's President Samia Suluhu Hassan! Very competent team (of Judge Chande and Ambassador Sefue."

14.6bn/-, 300 houses to shift all villagers in graphite zone

OVER 1,000 villagers in Ulanga District, Morogoro Region are sharing out benefitting from an investor's 14.6bn/- issued in compensation after agreeing to shift so that graphite mining can start.

Faru Graphite Corporation (FGC) chief executive officer Alimiya Osman said the beneficiaries are Mdindo, Kisewe, Makanga and Nawenge villagers, with compensation being done along with the construction of 300 houses for resettling people at Ndoto Yetu in Idenke area, largely within Mdindo village.

At a function to roll off compensation payments to residents touched by the Mahenge-Ulanga project, set to take three days, appealing to the residents to use the funds for meaningful economic projects. This will improve individual wellbeing and community prosperity as a whole, he stated.

So far the project has used up 70bn/- (\$39m) and projected take up 290bn/- by the time it is completed, yielding 5.1trn/- (\$2.2bn) earnings per year, he stated, noting that international metallurgical laboratories say the graphite



there is among the best ore worldwide, with 212m tonnes reserves of 7.8 measure on the trading card grading method, and 70m tonnes of 8.5 grading of the same measure chiefly used in Australia.

The project area has 212m tonnes in graphite reserve likely to be exhausted in 27 years, an average of 340,000 tonnes output annually, he stated.

Four phases are projected, the first targeting an average of 83,000 tonnes per year, growing to 340,000 tonnes per year, making it a ranking graphite project in Africa and around the world, he explained.

The government holds 18 per cent shares in the project while Black Rock Mining of Australia has 82 per cent shares, a project that is expected to make heavy direct contributions to the Treasury via various taxes, levies and dividends. It will greatly benefit the surrounding communities in regular and irregular jobs, he stated.

Beneficiaries marveled at the sums they were receiving seldom touching up to one million shillings in their lives, and now being paid in multiples of millions of shillings.

Ulanga MP Salum Almas told the residents that the firm will not make everyone a rich person, but enable them to pursue own economic wellbeing, urging the firm to observe bylaws governing investment by ensuring that people in the vicinity of the mine have better access to jobs there.

Ulanga district commissioner, Ngolo Malenya said at the event that those receiving compensation need to exercise great care with the money for the benefit of their families, by initiating viable economic projects

AGRUCULTURE minister Hussein Bashe has inaugurated the first farm of 11,436 acres for block farming involving youth in Mlazo and Ndogoe villages in Chamwino District, Dodoma region.

He inaugurated the farm as a first step for clearing it as well as the installation of vital infrastructures in the area including setting aside the farm area that has been split in 2,500 smaller farms.

During the launching event, Bashe

TICTS' contract future: Stakeholders want new competitive tendering

THE debate on whether or not the Tanzania International Container Terminal Services (TICTS) should be renewed continued on social media yesterday as more people asked the government to launch an international competitive tendering.

The debate gain momentum at the time when TICTS' leasing contract is to come to an end next month.

Commenting on the ongoing debate, ACT-Wazalendo national leader Zitto Kabwe advised the government to launch a competitive bidding if the leasing contract on TICTS was ending.

On his twitter handle, Kabwe called on the Tanzania Ports Authority (TPA) to act on the matter immediately and if the current container management firm will meet the conditions, then should be granted with the new contract.

"Isn't the contract ending? If yes TPA should announce a competitive bidding. If they win again, let them continue. Tanzania has to benefit from its geographical position. It can't go like this anymore," he said.

Some people in the social media wanted the government to announce a new bidding as well as assess on why TICTS's performance was poor.

"We should first investigate why they are performing poorly before punishing them, we should find out the major pushing factors for them to not provide best services, many be the environment is not friendly,' one of the online commentators said, adding:

"I one of the customers there as I am a truck driver taking cargo containers there, these people are not serious, it's too bad because you don't get your service on time."

commentator introduced himself as Joe said: "I remember I worked in a certain company in Mwanza from 2016 to 2018, bosses there were using the Mombasa port to pass containers due to bureaucracy at the Dar es Salaam port, so authorities here in our country should change this."

Ali Mohamed a Dar es Salaam-based resident said; "TICTS is doing a good job there, I am an agent and I know these guys for years, they have been serving us well, and without it, maybe our port could have died, because they have modern equipment of handling cargos, so I think we not mix politics in

The online critics wanted the government to find another competent investor or if TICTS' contract is renewed, then new strong conditions should be put because they have been conducting their activities very poorly.

As the contract is winding up, there is intense lobbying for the government

to extend the lease agreement for another five years despite TICTS woefully failing to meet key contractual obligations, which include ensuring the growth of container traffic at the Dar es Salaam port by more than a third each year.

According to the current lease agreement signed in 2017 between TICTS and the Tanzania Ports Authority (TPA), the renewal of the contract for another five years upon expiry in August/September 2022 would be strictly subject to TICTS "meeting at least 80 per cent performance of each of the key performance indicators"

One of the key performance indicators is for TICTS to deliver at least 37 per cent growth of container traffic at the Dar es Salaam port annually.

However, latest data from TPA shows that last year, TICTS managed to deliver a mere 0.8 per cent growth of container cargo at the port.

In 2021, TICTS handled 606,169 twenty-foot equivalent units (TEUs) of container cargo, from 601,654 TEUs in

Over the past five years, while rival ports in the region have posted an impressive growth in container cargo, Dar es Salaam port has been underperforming.

In 2017, TICTS handled only 482,836 TEUs, increasing marginally to 519,776 TEUs in 2018 and 605,002 TEUs in

In comparison, Mombasa port in neighbouring Kenya recorded container traffic of 1.4 million TEUs in 2019 and plans to increase the volume of container cargo to 2 million TEUs

In South Africa, authorities have launched an ambitious plan to modernise the port of Durban, which will triple the port's container cargo handling capacity from around 3 million TEUs to 11 million TEUs.

Experts say Zanzibar's strong blue economy a solid foundation for building other sectors

EXPERTS who have visited recently Zanzibar say if Zanzibaris and their government will build a solid foundation of the declared blue economy, successful implementation of projects other sectors of the economy will be natural thing.

In an interview with delegates on their return from Zanzibar, most of delegates felt that focused use of Isles' sea natural resources and elimination of vices like corruption he wants to give better and bigger and inefficiency will catapult Zanzibar to unprecedented economic development heights.

"Zanzibar is endowed with natural sea resources. If Zanzibaris will rally behind their current government, eliminate corruption, red-tape, inefficiency and implement their blue economy strategy there is no doubt economic growth will be rapid and poverty will alleviated," Mr Joseph Sichware said, adding "remember Zanzibar has an extra advantage of having a small population. Planning development for a small population is less complex... you need proper mobilization and organization of people and resources and of course beneficiaries should be responsive. Proper use of such indexes will guarantee you success.'

Dr Zubeda Salim Abdallah described the blue economy strategy as Zanzibar's correct path to a modern economy. "Blue economy means exploitation and proper use and management of natural resources found in the sea surrounding Zanzibar. This means a strong blue economy is the foundation for building successfully other sectors of the economy; it is the foundation for building a modern economy for Zanzibar," she said.

She said proper implementation of

the blue economy strategy will give the government revenue to execute projects in sectors like fisheries, industries, physical infrastructure, communications, education, health and others.

Sadiki Mbarouk Mahmudu said since 2020 President Hussein Mwinyi made it clear that he will use natural resources found in and around Zanzibar to build a strong economy and alleviate poverty. He has paid attention to use of sea weed farming to employ people, fishing boats and gear to anglers and farmers should do beneficial farming. "Zanzibar has changed," he said.

EAC summit has set a new tone for integration agenda

EADERS of member states of the East African Community, now expanded to seven countries, are becoming more rule-based and predictable in what is discussed or likely to be achieved. For one thing, the widening of membership from three original member states to five at a certain point and now to seven makes the setting more organizational and less bilateral in character, and when this is the case, it is more tuned to international conventions than bilateral settings. So this procedural dividend is just being noticed.

One area where progress was visible was the degree to which each of the summit participants, the Heads of State or high level representatives, expressed their devotion and interest in a proper unfurling of the EA Common Market agenda. The summit was to put out a roadmap for the goal, whether it is just a joint communique or a roadmap agreed among the council of ministers and then adopted by the Heads of State, but seemingly this is a goal for a future summit. The more recent members, South Sudan and Democratic Republic of Congo, will be key players in that quest, and have still poor links with the rest of EAC zone.

Another soothing feature was the formal invitation and plenary session participation of newly elected Somali President Hassan Sheikh Muhammad, an indication that there is a benevolent eye to his accession and prospects of his country's admission to the trading bloc. Ordinarily there would be reservations on its admissibility on account of instability and lack of territorial control in relation to the Mogadishu authorities but a more proactive outlook is equally advisable. It is to see EAC membership as a factor

EADERS of member states of the East African Community, now expanded to seven of stabilization in Somalia, with various sections of the population adhering to more peaceful social agenda.

For one thing, with the African Continental Free Trade Area (AfCFTA) pact already in place and being implemented, the EAC has to go a higher step in integration efforts for it to remain relevant, and indeed with a coordinating organization and civil instruments, etc. In like manner, the continental pact and efforts to free up economies from decades-long protectionist methods that have retained most countries in poverty owing to poor productivity of a dominant public sector and its traditional agro-sector alter ego, setting up regional and continental instruments instills order in public aspirations. It reins in appetites.

When countries agree that competition is the best way to optimize productivity in each country instead of protecting local producers who are comparatively inefficient, and set up structures for competition in production and commerce between companies rather than countries, plenty of divisive energies are soon tamed. They will no longer be directed at setting up communal political movements targeting influential cultural groups with a promise that their members will be put in charge of corrupt regulatory agencies to take their fill. These are hidden parameters of competitive politics in non-liberalised economy, where all aspects of economic policy and trade regulation are inward, or bilateral in character. That is what EAC leaders are trying to put aside, and painfully at that, so that peace, democracy and social progress may be assured as when attained, it will no longer be possible that they are reversed by insurgencies,

been taking place at the Dar es Salaam exhibition for higher learning institutions, with one notable area of such exchanges being course innovation and types of outputs in various colleges and universities. It is unclear how far the various institutions have a common agenda, and how far each is trying ground-breaking innovations arising from in-house intuition at departmental, faculty and college level readiness or consensus attained so far. For one thing, the point of departure is less a redefinition of national needs but realism about market needs, and solving either issue is different.

At an earlier stage of national political life and development effort, it was the definition of education in view of what the country was seeking to do especially on the African stage and even globally, as schisms in that direction could harm national unity. Those were times of intense budgetary hardship, reliance on foreign assistance and conversely, virtually assured job placing in the field that one has studied, also creating the impression that at that time people read well and fitted into jobs. There are gaps in this kind of reasoning as current graduates are largely employable if with some adaptation phase, but jobs are few.

So there is a situation where the national authorities are giving free leg room for institutions to design what they think is best, and admittedly the focus is on colleges and universities as their output doesn't aspire to higher levels of education but jobs. Doing a second degree is a private matter that doesn't involve public soul searching as to its relevance, unlike in the case

That is were the higher learning institutions seek to innovate, and the range is admittedly winded, broad.

Even within the precincts of a particular specialization, the range of issues to be taken note of in such design can be prohibitive, for it really is a wish to produce specialists rather than graduates. Those who finish degrees or other qualifications are expected to have a certain level of knowledge which enables them to grasp tasks that will be assigned to them, not that they can do those tasks expertly already. But the foundation was ensnared in concerns with attitudes, mixing patriotism with simplistic interpretations of economic and administrative life - or conduct of authorities - thus building attitudes of resentment, etc.

With global reform having put paid to these views of reality, a more technical attitude is demanded from all sorts of employers, even without a keen setting out of the problem. That is why those with memories of the past need to go back to education of the pre-1967 period and compress it, some topics be brought down to even lower levels of primary school.

Some broad topics like world history can be brought out at primary school (intermediate) level, plus streaming into liberal arts, basic science, or creative arts, sports. At that point, secondary schools would be specialized into those streams, just adding bits of this and that. Keeping numerous school courses just for attitudes up to college, then add computers clearly won't work.

Libya: A country in need of a king?

ESTORING a symbolic monarch may sound anachronistic, but after a decade of division and chaos, it makes perfect sense to many Libyans.

More than a decade has passed since the fall of Muammar Gadhafi in 2011, but the Libyan Uprising is no closer to a happy ending. After three attempts at holding elections without a constitution - or, for that matter, any legal framework - the UN tried, in a last-ditch effort, to hold an "urgent constitutional dialogue" in Egypt last month. Unsurprisingly, the talks failed.

Libya is back to square one. It has "two Prime Ministers", one who refuses to give up power while the other struggles to acquire legitimacy. Violent clashes have started in Tripoli, and oil and gas exports are once again being interrupted by militias. This has followed years of political stalemate and instability, stemming from an inability to elect a government recognised by the East, West and South of the country - the three distinct regions that came together to form Libya in 1951. These geographic divides continue to play a major role in political life and animate debates regarding the allocation of resources and political equality. Many Libyans feel another civil war is just around the corner.

Libya today is a country without a social contract. As in the Gadhafi years, authority derives from force rather than trust; it is about the monopoly of violence rather than the national interest. Those who have been successful in garnering power are those who have resorted to force over consensus, and who have turned to violence rather than risk losing power in an election. It is no way to run a country, and certainly no way to build one. Libyans have no trust in any individual or institution in Libya, and rightly so; they have not earned it. The burning down of Tobruk Parliament and the houses of numerous politicians by protesters in early-July attest to that sentiment.

Peacebuilding efforts to date have focused on creating something new, such as writing a constitution not grounded in Libyan's historical experiences or relying on leaders who do not have the consensus of the people. UN-led efforts have emphasised elections over all else. Yet over and over, these processes have ended in war. Over and over, they have led to an impasse, as local actors string the international community along until opportunities arise to seize power through force.

With the mandate of UN Secretary-General's Special Adviser for Libya, Stephanie Williams, set to expire, there is no better occasion to change course. It is time for more local and authentically Libyan approaches to take centre stage, and the good news is that there is already an alternative available: Libya's Independence Constitution.

Back to the future

Libya's "birth certificate", as it is known in the country, was the drafted by the UN in 1951. It included freedom of the press, freedom of expression, equality before the law, an elected parliament, and regular elections. At its heart was a largely symbolic monarchy, led by the Libyan hero Idris al-Senussi, who served as father of the nation and King of Libya until his overthrow in a coup led by Gadhafi in 1969.

Over half a century later, there is growing talk in Libya of restoring the independence constitution. And with good reason. It would solve many problems in one fell swoop. It would create a framework for holding elections. It would give us a constitution that we could use as starting point from which to modify and develop. It would give us a sense of national identity beyond the shadow of Gadhafi. While many may see a return to monarchy as anachronistic, a suitable symbolic leader could unite the country and bring competing factions together with assurances that their concerns will be heard.

Restoring a symbolic monarchy

would have other benefits too.

First, it would prevent the need for the creation of a ruling Presidential Council that would enthrone Libya's current crooked political class. Those pushing for this as a solution are simply looking for a way to guarantee their individual interests.

Second, it would give us the historical continuity we need to build a nation, a continuity that has been obfuscated by 42 years of dictatorship and 11 years of chaos. This instability has, most concerningly, led to a lack of national identity and unity, and a situation in which powerful parties only seek to promote their own interests at the expense of the Libyan state.

And third, it would put the future of Libya in a clean pair of hands. Though King Idris' reign was far from perfect, a new monarchy would not be implicated in a civil war in which it did not participate. It has not killed, abducted, and tortured. It has no opponents on the battlefield.

Instead, it has the unique potential to reconcile the nation's past with its future, and the ability to reconcile Libya's minorities. Despite decades of anti-monarchy propaganda under Gadhafi, the late King Idris and his son Prince Hassan are still seen positively. Their pictures can be found at every protest across the country. Many Libyans who came of age in 1969 lament the coup to their grandchildren as a terrible mistake and urge them to repair it. The Senussi family - now led by King Idris' 59-year-old grandson

Mohammed - also has impeccable Islamic credentials and offers a genuine chance of reconciling secular and Islamist actors.

Restoring Libya's independence constitution would not be straightforward. It would have to happen by consensus, and the exact mechanisms would need to be agreed by various parties. An Afghan loya jirga model in which tribal leaders make decisions by consensus would be one model to consider.

Such a plan would also likely face resistance from those who currently enjoy a degree of power in Libya. However, support for this solution has grown to the point it cannot be ignored much longer. The independence constitution is finally a serious topic of conversation, validating what Libyans like me have been saying for years. It is now critical that Libya's birth certificate not get hijacked by actors working for their own interests and who seek to spoil Libyans' last chance for peace and reconciliation.

DUCATION is one priority areas for Tanzania. Primary education has been free and compulsory since independence in 1961. The government has since extended free education to include secondary education from form one to form six.

The move by the government aims at enabling as many pupils as possible access education with a view to creating an enlightened and competitive nation in the 21st century.


Vocational training and higher education can be accessible to any person who needs and affords it, but plans are underway to accommodate technical colleges in the free education programme, according to Minister for Finance and Planning, Dr Mwigulu Nchemba's speech on government revenue and expenditure estimates for the fiscal year 2022/23 presented in the National Assembly in Dodoma in June this year.

Article 11(2) of the Constitution of the United Republic of Tanzania stipulates that "Every person has the right to access education, and every citizen shall be free to pursue education in a field of his [or her] [choice to his [or her] merit and ability, the highest level according to his [or her] merits and ability."

Tanzania Development Vision 2025 stipulates that, Tanzania of 2025 should be a nation imbued with five main attributes: 1) high quality livelihood, 2) peace stability and unity, 3) good governance, 4) a well-educated and learning society and 5) a competitive economy capable of producing sustainable growth and shared benefits.

On the fourth attribute, Tanzania Vision 2025 stipulates that "Tanzania would brace itself to attain creativity, innovativeness and a high level of quality education in order to respond to development challenges and effectively compete regionally and internationally, cognizant of the reality that competitive leadership in the 21st century will hinge on the level and quality of education and

knowledge."

Yet, the provision of education has not yielded anticipated outcomes. Critics say the type of education provided in schools does not equip students with the skills needed in the labour market in today's rapidly changing and competitive world. This has resulted in an upward trend of youth unemployment.

According to Trading Economics global macro models and analysts, the unemployment rate in Tanzania is expected to reach 9.70 per cent by the end of this year. Last year, it was 2.65 per cent, a 0.12 per cent increase from 2020. Although unemployment is a global problem, its solution can be sought at local level depending on each country's needs.

A broad cross-section of literature suggests a paradigm shift in teaching

from traditional teacher-centred to student-centred learning, also known as flexible learning, experiential learning, self-directed learning, autonomous learning and collaborative learning.

This is a new teaching (learning) approach in education which is suited to today's rapidly changing world. It is an approach which makes students more active than passive learners and it seeks to improve student achievement in both increasing learning skills and intelligent or critical thinking.

Author Angele Attard (Ed) in a book Student-Centred Learning: Toolkit for students, staff and higher education institutions (2010) argues that studentcentred learning provides skills for life, creates independent learners and responds to the changing and differing needs of individual students. Learning skills in the 21st century, some pieces of literature suggest, encompasses 4 Cs: Critical thinking, Creativity, Collaboration and Communication.

An article entitled Employability skills required by the 21st-century workplace: a literature review of labour market demand published in an international journal called Advances in Social Science, Education and Humanities Research Vol. 102 in 2017, talks about employability skills.

It says employees are expected to have additional skills and attributes (employability skills) namely communication skills, problem-solving and decision-making skills as well as teamwork skills. It says these are the attributes of employability skills with the highest importance level.

It further says graduates are also expected to have the following

personal attributes: self-awareness, self-confidence, independence, emotional intelligence, flexibility and adaptability, stress tolerance, creativity and initiative, willingness to learn, reflectiveness, lifelong learning and professional

behaviour. "Employability skills are considered one missing link between education and training and the world of work. Labour market as one of the driving forces of the content and quality of education attributes high value to international recognition of qualifications and education. Since the labour market uses and applies learning outcomes in real life, the quality of education and training policy cannot exist separately from it. The pressure of global competition means that graduates need to offer an employer more than academic skills traditionally represented by the subject and degree class," reads the document.

Eight skill groups to describe and define employability skills include (1) communication skills, (2) teamwork skills, (3) problem-solving skills, (4) initiative and enterprise skills, (5) planning and organising skills, (6) self-management skills, (7) learning skills and (8) technology skills.

Personal attributes, which are non-skill-based behaviour and attitudes, include loyalty, commitment, honesty and integrity, enthusiasm, reliability, personal presen-

tation, commonsense, positive self-esteem, a sense of humour, balanced attitude to work and home life, ability to deal with pressure, motivation and adaptability.

UNESCO Framework for Transversal Competencies consists of five broad domains of skills, competencies, values and attributes. These are (1) critical and innovative thinking, (2) interpersonal skills, (3) intrapersonal skills, (4) global citizenship and (5) media and information literacy.

These skills, according to the authors of the above cited article, cut horizontally across all industries and vertically across all jobs at all levels and are also required by the 21st century workplace which is necessary for career success at all levels of employment and for all levels of education.

This sends a strong message to our policy makers and learning institutions that traditional teaching which emphasises the teacher's role in the transfer of knowledge is no longer sufficient. It suffices to say that our learning institutions must impart learning skills to students so that they become active learners and competent in today's workplace and rapidly changing world.

Tanzania has made great strides in education in terms of laying down school infrastructure but what now needs to be done is to invest more in student-centred teaching and learning to enable students to be active learners who will in the long run find solutions to their own problems and the problems of their communities and country. For, for this is the very purpose of education.

DEPUTY Permanent Secretary at Ministry of Investment, Industry and Trade, Dr Hashil Abdallah has said the government will continue improving the investment environment in the country to attract the private sector.

Dr Abdallah said in Dar es Salaam over the weekend during the launch of Sichuan Kairui Tanzania's latest air conditioners technology called V8 VRF Series that the coming of the ACs into Tanzania market is a clear sign of improved business environment.

He said the government is committed to improving investment and business environment to attract more investors, grow national economy, and improve lives of Tanzanians through employment and increase national income

"The launch of this technology shows how business environment is improving and the country is opening up for more businesses. Through business, there is tax collection, employment opportunities and improvement of lives to many Tanzanians," he said.

Dr Abdallah added that the government has reserved enough areas for investment in all the regions and argued the company to think of establishing assembling plant here in Tanzania instead of importing everything from China.

Speaking during the same event, Sichuan Kairui's Board Chairperson, Emmanuel Metta said the company is in the process of building a plant to manufacture spare parts within of international standards in the country before 2025.

"Due to the evolution of science and technology, increase in the number of people and adverse climate change, Midea has been at the forefront to address the challenges by bringing World-class solutions that are eco-friendly and offer value for money," Metta said.

hoever becomes 10 Downing Street's newest resident will inherit a maelstrom of economic problems.

UK inflation running at the fastest pace since the early 80s. The Bank of England's tip-toeing on rate hikes relative to its peer across the Atlantic. Festering labor and supply-chain wounds left by Brexit.

All of that has sterling languishing near levels last seen when the Covid-19 panic and lockdowns were at full force.

Add in the UK's long-term bugbear of falling productivity, and "the new UK government is taking over in a difficult situation," said Ulrich Leuchtmann, head of currency strategy at Commerzbank AG. "There is always the risk of a nasty spiral of higher inflation and a weaker

currency."

Investors and strategists agree: regardless of whether it's Foreign Secretary Liz Truss or former Chancellor of the Exchequer Rishi Sunak who prevails in the leadership race, the forces behind the pound's slide may prove beyond their powers to address.

Volatile energy prices and a tight labor market have already left BOE policy makers teetering between aggressive interest-rate hikes and the need to cushion the economy from surging prices. With its open economy and huge current-account deficit, the UK is vulnerable to global strife. Inflation will top the pace in any of its major European peers over the next two years, according to economists surveyed by Bloomberg.

Since Brexit, sterling has become a more "peripheral" component of investors' currency holdings, according to Bank of America strategist

Kamal Sharma. That leaves it particularly exposed to souring investor sentiment globally as Russia's invasion of Ukraine grinds on and China's Covid fight hurts the domestic economy.

Using world equity markets as proxy, the pound has become steadily more sensitive to global risk appetite.

As Britons feel the pinch of a feebler pound when shopping for goods shipped from overseas, the nation's central bankers watch the impact on price growth as costly imports fan inflationary

A slump in Bank of England's preferred gauge of pound strength this year has added about 0.5 percentage points to the pace of inflation, according to Bloomberg Economic's SHOK model.

"Even if the economy scrapes by in the positive column for GDP growth for now, things will feel very recessionary," wrote Standard Bank G-10 strategist Steven Barrow in a note to clients

this week. Barrow envisages a surge in strike action amid the kind of "union militancy" last seen in the 1970s and 1980s.

More than 120 farmers from Tabora, Sikonge and Kahama visited the factory to see the crop is

Tabu Shaban, a farmer from Urafiki village, Usangu ward in Sikonge district who represented Urafiki primary cooperative co-operative union (Amcos) said she will share the experience learned from the visit to his fellow members back

Tabu said tobacco farming has enabled her to pay fees for her children, build a house and buy draft animals used in farming.

On his part, Alliance One Managing Director Ephraim Mapoore told farmers that the company will continue to collaborate with them to improve the crop quality to meet international standard.

France's Eutelsat to buy UK satellite company OneWeb

LONDON

The UK government is set to become a minority shareholder in a listed French business, as France's Eutelsat nears a deal to acquire OneWeb, the space-based internet company rescued from bankruptcy by Boris Johnson's

According to people involved, a deal will be announced as soon as Monday and involve a takeover of OneWeb by Eutelsat, which already owns a 24 per cent stake in the UKbased company. Expecting heavy political scrutiny, the deal will be presented publicly as a merger of equals.

Combining the two companies will bring together the UK, French and Chinese governments as well as Indian billionaire Sunil Bharti Mittal as common shareholders in one of the world's biggest satellite operators.

The French state owns a 20 per cent stake and China's sovereign wealth fund owns 5 per cent in Eutelsat. The UK has just under 18 per cent of OneWeb. After the deal, shareholders from both sides will be diluted.

Paris-listed Eutelsat has a market value of €2.4bn and has roughly €3bn of net debt. In its most recent funding round, OneWeb was valued at \$3.4bn.

The deal values the UK government's One-Web stake at \$600mn, two people with knowledge of the details said, which is \$100mn more than it initially invested in 2020. Mittal, who has a 30 per cent stake in OneWeb, will be one of the largest shareholders in the combined group.

The UK will retain its special rights over OneWeb as part of the deal. Those rights include a veto over certain customers deemed undesirable for national security reasons as well as a say on supply chain and launch decisions. One UK official said that Eutelsat would seek a secondary listing on the London mar-

funding still required to deliver the company's second generation satellite network.

The greater financial firepower will be needed in the competition with Elon Musk's Starlink and Jeff Bezos' Project Kuiper for low earth orbit, the new frontier for commercial space.

OneWeb, which has 428 satellites in orbit, was a pioneer in the field but its current technology is acknowledged to be out of date. Musk's Starlink has more than 2,000 satellites in orbit with newer technology.

"The deal recognises that this is a highly competitive global race. It will allow the two companies to compete with SpaceX and emerging rivals from China as well. This is a good story for Britain," the official said.

Falling launch costs and cheaper satellites are enticing hundreds of private companies into a global space market estimated to be worth \$1tn by 2040.

The UK's initial investment into OneWeb in 2020 was highly controversial and championed by Johnson's former adviser Dominic Cummings.

The government ignored advice from senior officials when it decided to invest \$500mn alongside \$500mn from Bharti Global, part of the conglomerate controlled by Mittal, to bring the business out of Chapter 11 bankruptcy in the US.

OneWeb collapsed in 2020 after its main backer SoftBank refused to fund yet another financing round, in a sign of significant cash funding requirements needed to take low earth orbit constellations to commercial operation. SoftBank still remains a substantial shareholder in OneWeb.

Since its bankruptcy the group has raised \$2.7bn. Eutelsat paid \$550mn for a 24 per cent stake in OneWeb last year.

Rothschild is working with Eutelsat, while Barclays is advising OneWeb, people close to the deal said. Bloomberg earlier re-

WHO declares monkeypox global public health emergency

GENEVA

THE World Health Organization officially declared on Saturday that the current multicountry monkeypox outbreak outside of the traditional endemic areas in Africa has already turned into a public health emergency of international concern.

After reconvening the WHO Emergency Committee on Thursday concerning the monkeypox outbreak, WHO Direcotr-General Tedros Adhanom Ghebreyesus made the decision at a press briefing on Saturday to sound the highest level of alert that the global health authority can issue for the time being, even without a consensus of the committee.

"So in short, we have an outbreak that has mittee, even without a consensus; fourth, scien-

spread around the world rapidly, through new modes of transmission, about which we understand too little, and which meets the criteria in the International Health Regulations," said Tedros.

"For all of these reasons, I have decided that the global monkeypox outbreak represents a public health emergency of international concern," he noted.

He cited five reasons behind the decision. First, the information provided by countries shows that this virus has spread rapidly to many countries that have not seen it before; second, the three criteria for declaring a PHEIC under the International Health Regulations have been met; third, the advice of the Emergency Com-

tific principles, evidence and other relevant information which are currently insufficient and leave us with many unknowns; and fifth, the risk to human health, international spread, and the potential for interference with international traffic.

However, he added that for the moment the monkeypox outbreak is concentrated among men having sex with men, especially those with multiple sexual partners.

"That means that this is an outbreak that can be stopped with the right strategies in the right groups,"

Tedros first convened the WHO Emergency Committee in late June, after which the latter advised him then that the event had not constituted a PHEIC.

According to Tedros on Saturday, the outbreak has continued to grow atypical. **Agencies**

to see more than 16,000 cases from 75 countries and territories reported to WHO, including five deaths.

Monkeypox, first detected in laboratory monkeys in 1958, is assumed to transmit from wild animals such as rodents to people, or from human to human.

Multiple clusters of the monkeypox virus have been reported within the past few weeks in several European countries and North America, which are regions where the virus is not normally found.

According to WHO, endemic monkeypox disease is normally geographically limited to West and Central Africa.

The identification of confirmed and suspected cases of monkeypox without any travel history to an endemic area in multiple countries is

Russia Foreign Minister visits Egypt, part of Africa trip amid Ukraine war

RUSSIAN Foreign Minister Sergey Lavrov is in Cairo, the first leg of his Africa trip, as his country seeks to break diplomatic



isolation and sanctions by the West

Russian Foreign Minister Sergey Lavrov met with Egyptian officials in Cairo for talks yesterday as his country seeks to break diplomatic isolation and sanctions by the West over its invasion of Ukraine.

Lavrov (pictured) landed in Cairo late on Saturday, the first leg of his Africa trip that will also include stops in Ethiopia, Uganda and the Democratic Republic of Congo, according to Russia's state-run RT.

The Egyptian Foreign Ministry said Foreign Minister Sameh Shukry was holding talks with Lavrov on Sunday

The Russian chief diplomat was scheduled to meet later on Sunday with the Arab League Secretary General Ahmed Aboul Gheit. He will also address the permanent representatives of the pan-Arab organization, RT report-

Russia's war in Ukraine has had dire effects on the world economy, driving up oil and gas prices to unprecedented levels.

Ukraine is one of the world's largest exporters of wheat, corn and sunflower oil, but Russia's invasion of the country and naval blockade of its ports have halted shipments. Some Ukrainian grain is transported through Europe by rail, road and river, but with higher transportation costs.

The war has disrupted shipments of Russian products because shipping and insurance companies did not want to deal with Western sanctions on the country.

African counties are among those most affected by ripples of the war. The prices of vital commodities skyrocketed and billions of dollars in aid have been directed to help those who fled the war in Europe. That has left millions of people in conflict areas in Africa and the Middle East suffering from worsening growing shortages in food

Lavrov's meetings with Egyptian officials and Arab envoys in Cairo come less than two weeks after U.S. President Joe Biden's Mideast trip. Biden met with the leaders of Israel and the Palestinian Authority, before convening a summit with the leaders of Arab Gulf countries, Egypt, Jordan and Iraq in Saudi Arabia.

Egypt, the Arab World's most populous country, refused to take sides since the war in Ukraine began in February as it maintains close ties with both Moscow and the West. Egypt is among the world's largest importers of wheat, with much of that from Russia and Ukraine.

Egypt's President Abdel Fattah el-Sissi has cultivated a close personal rapport with Russia President Vladimir Putin. Both leaders have strengthened bilateral ties considerably in the past few years.

Lavrov's visit to Cairo came as Russia's state-owned atomic energy corporation, Rosatom, began last week the construction of a four-reactor power plant it is building in Egypt.

Sunak said EU law would be scrapped or reformed by the next election, which is expected in 2024. Truss leads Sunak by 62 percent to 38 percent among Conservative Party members, according to a YouGov poll on Thursday.

Biden has sore throat, body aches, but symptoms improving

PRESIDENT Joe Biden's COVID-19 symptoms continue to improve and now include "less troublesome" sore throat, runny nose, loose cough and body aches, his physician, Dr. Kevin O'Connor, said in a memo on Saturday.

Biden's lungs remain clear and his oxygen saturation "continues to be excellent on room air," the doctor said.

Biden, 79, tested positive for COVID on Thursday, when the White House said he was experiencing mild symptoms. His diagnosis came as a highly contagious subvariant of the coronavirus drives a new wave of cases in the United States.

"The President continues to tolerate treat-



ment well. We will continue PAXLOVID as planned," he said, referring to the Pfizer Inc antiviral drug the president is taking.

Biden speaks about protecting access to reproductive health care services at the White House in Washington

Biden is not experiencing shortness of breath, O'Connor said. "The BA5 variant is particularly transmissible and he will continue to isolate," O'Connor said. "We will continue to monitor him closely, during this very common outpatient treatment regimen."

The White House has sought to underscore Biden's ability to work through his illness. On Thursday it released a video of the president reassuring Americans he was doing fine, and on Friday he participated in virtual meetings

with White House staff.

His schedule showed no presidential events over the weekend. The president's wife, first lady Iill Biden, is at their home in Wilmington, Delaware. She tested negative for COVID-19 on Saturday morning, according to her spokesperson, Michael LaRosa.

The White House has not said where Biden contracted the virus. He recently returned from a trip to the Middle East and held public events before that trip in which he had close personal interactions with scores of people.

Biden's diagnosis is the latest challenge he has faced amid threats to his policy agenda on Capitol Hill and high inflation putting his fellow Democrats at risk of losing control of Congress in the November midterm elections.

Kremlin disavows any criticism over delayed return of turbine for Nord Stream **MOSCOW**

ANY blame directed at Russia due to the delayed return of the turbine for the Nord Stream pipeline from Canada is groundless, Kremlin Spokesman Dmitry Peskov told report-

Earlier Reuters reported citing sources that the turbine got stuck during transit in Germany, allegedly because of lack of a permit from Russia.

Peskov recalled the statement by President Vladimir Putin, on the night of July 20 in Tehran, that as of that time, Moscow had not received any legal, technological, or any other documentation on this turbine.

"Therefore, any sort of admonishment [against Russial is utterly unfounded, in this case it's the wrong sources," the Kremlin spokesman said.

He stressed that in this story "the primary source" should be referred to, which is Gazprom.

Peskov also pointed to the data of foreign media sources that claimed the Russian side allegedly did not provide information on where exactly the turbine should be brought to.

"This is complete nonsense, because Siemens knows perfectly well where this turbine is installed. That is, this is just an absurd report from sources," Putin's press secretary em-

Since mid-June, the Nord Stream project has been operating at 40% of its maximum capacity due to the delayed return of gas compressor units from maintenance work. One of the turbines built by Siemens Energy in Canada was sent to Montreal for an overhaul.

'CPC has demonstrated admirable wisdom, courage in pursuit of national development'

"THE Communist Party of China (CPC) has demonstrated admirable wisdom and courage in its pursuit of national development," said Bhaskar Koirala, the Director of Nepal Institute of International and Strategic Studies, during a recent interview with People's

He said the CPC, always following a people-centered approach and being courageous to face up to challenges, has explored a development path that suits China's national conditions.

It offers new ideas for other developing countries on their way to pursue development and is worth learning by the

latter, including Nepal, Koirala added. Koirala made multiple visits to China as a scholar in the recent years and was

deeply impressed by the drastic changes taking place in the country.

"Every time I came to China I saw surprising changes. These changes were a result of the huge efforts made by the Chinese people under the leadership of the CPC," he told People's Daily.

Koirala is a closer follower and studious learner of the development philosophy raised by Chinese President Xi Jinping. He read through the Nepali edition of the second volume of "Xi Jinping: The Governance of China" soon after the book was released, and always leafs through the English version of its third volume.

"The book contains China's development experience and the CPC's wisdom," Koirala said.

Having had a close look at Xi's assertion that lucid waters and lush mountains are invaluable assets, Koirala found that ecological conservation and economic growth are not contradictory against each other, which has been proved by China's development.

He said the impacts from ecological conservation and economic growth on social and livelihood progress shall be thoroughly evaluated in different stages of economic development, and attention must be paid to the medium- and long-term influence from environmental issues.

"The bluer skies and cleaner waters are making China more and more charming," Koirala said, adding that the tremendous changes in China's ecology are what impress him the most.

During an academic visit to east China's Zhejiang province, he found that high-pollution enterprises were upgraded with new equipment and techniques, which greatly reduced the emission of pollutants. Besides, a lot of hills in the province turned green again, and some of them were planted with highvalue crops, becoming a new growth point for local economy.

"China's measures in environmental protection are worth learning from and are of important significance for Nepal," Koirala told People's Daily.

Koirala is amazed at China's poverty reduction achievements. "The Chinese government has made unprecedented achievements by eliminating absolute

poverty as scheduled, which is astonishing," he said.

The Nepalese studied China's targeted poverty alleviation policies and was impressed by the mechanism of stationing officials in villages to work on

poverty relief. "To understand China's poverty alleviation achievements, we must recognize the painstaking efforts made by young CPC members," he said, adding that these young CPC members made household visits for surveying on a daily basis to promote industries and investment in poverty-stricken areas.

"They managed to create development opportunities for these areas from their capabilities, bringing new hopes to the people living in poverty,"

Koirala noted.

China has proved to the world with concrete actions that poverty elimination is no longer an "impossible mission". And this will be an inspiration for other developing countries also challenged by poverty issues, including Nepal, Koirala said.

"We should learn more from China's development experience, from poverty reduction and environmental protection to investment attraction and economic development," he remarked.

Apart from pursuing its own development, the CPC is also actively joining international cooperation to promote joint development and green development, Koirala told People's Daily.

One of the most recent openings came from Suriname, which opened a consulate in Dakhla.

Many countries have further renewed their support for Morocco's sovereignty over Western Sahara on the sidelines of their participation at the US-Africa Business Summit, which is occurring until July 22 in Marrakech.

Gambia, Liberia, the Comores, and Malawi have all reiterated their support for Morocco's Autonomy Plan as the only credible and serious basis to end the dispute over Western

AS the restructuring of the global supply chain is picking up pace under the impacts of multiple factors, China is gaining an edge for its complete industrial chain in the manufacturing sector.

As a vital part of the global supply chain system, China actively develops the manufacturing industry and volunteers to shoulder the international industrial transfer, in an attempt to integrate more deeply into the global supply chain system.

Transnational investment in the global manufacturing industry saw a fluctuating downward trend between 2017 and 2021, while the Chinese manufacturing sector remained relatively stable in the use of foreign capital. Last year, the actual use of foreign capital in China's manufacturing sector grew 8.8 percent year on year. The growth was 1.1 percentage points higher than that for the global manufacturing sector.

The actual use of foreign capital by Chinese high-tech manufacturers maintained rapid growth. In particular, the absorption of foreign investment in the manufacture of special equipment for the electronic industry and the manufacture of universal instruments in 2021 surged twofold and 64.9 percent, respectively, from a year ago.

The constantly optimizing investment structure and sound management efficiency are making China an important destination of investment for transnational companies.

The low-cost edge, which made China a world factory and the center of the global supply chain, is gradually fading, but the country still holds core competitiveness, such as rich human resources, high labor productivity, and complete industrial chains.

According to the International Labor Organization, China's labor productivity stood at \$16,512 per employed person last year, much higher than that in Vietnam, India, Thailand, Indonesia, and the Philippines.

"China has a complete industrial chain. It's easier to find reliable and cost-efficient suppliers in China than ented manufacturing reached 38.8 percent and

in any other part of the world," said Yin Zheng, Executive Vice President of Schneider Electric and President of Schneider Electric China.

"At present, in China, Schneider Electric has achieved 90-percent localization of its supply chain. The localized supply chain can help us better respond to the changes in market demands amid the pandemic," Yin said.

As the Chinese government keeps taking steps to promote reform and opening up and development transition, China is building and has already built new competitiveness supply chain-wise.

For instance, China's manufacturing industry is showing a sign of acceleration in its digital transformation, with a number of new-generation information technologies seeping into the sector, such as 5G, big data, cloud computing, and artificial intelligence. The country is home to over 150 large industrial internet platforms that serve more than 1.6 million enterprises.

The numerical control rate of key processes reached 55.3 percent among industrial enterprises above designated size, and the popularizing rate of digital R&D tools reached 74.7 percent. The proportion of enterprises engaged in internet-based collaboration and service-ori29.6 percent, respectively.

China is the country with the greatest number of "lighthouse factories" in the world. Twelve of the 44 "lighthouse factories" listed by the World Economic Forum are in China. Such new advantages will further help multinational companies achieve better development in China.

The global supply chain system cannot be divided due to its complexity and high dependence, as well the incompleteness of the industrial systems of countries around the world. China will keep contributing to the stability and smooth operation of the global supply chain, so as to shape a new future featuring openness, sharing, and prosperity.

Land-sea trade corridor sees robust development

THE New International Land-Sea Trade Corridor, a major trade channel between western Chinese provinces and other countries, has witnessed growth in freight volume for four consecutive years since its opening in southwest China's Chongqing municipality in 2017.

According to statistics, 379,000 TEUs were shipped via the route in the first half of this year, up 33.4 percent year on

The passage extends primarily from Chengdu, southwest China's Sichuan province, and Chongqing to Beibu Gulf Port in south China's Guangxi Zhuang autonomous region and Yangpu Port in south China's Hainan province. It provides western China with a shorter and faster route for overseas exchanges.

ASEAN countries have also found a faster track to send their products to western China, and further ship these products to Europe via China-Europe freight trains.

Seven new railway service stations joined the New International Land-Sea Trade Corridor this year, bringing the total number to 106 located in 14 provinces, autonomous regions and municipalities, said China Railway Nanning Group Co., Ltd. Over 640 categories of goods have been sent to 319 ports in 107 countries and regions around the world.

Yu Bo, head of the overseas business department of SMW Motors based in Chongqing, said it took about a month to export goods produced in western China to ASEAN countries via river-sea routes, but now they can be transported to Vietnam via the new land-sea corridor in just four days.

"We exported over 3,000 vehicles via the New International Land-Sea Trade Corridor last year and the number is expected to exceed 4,000 this year," he told People's Daily.

The corridor network has kept expanding in various transportation means. Chongqing launched freight train services bound for Vientiane soon after the China-Laos Railway was put into operation, and now the trains are running normally once a week.

On March 26, a new freight train route was opened between Chongqing and Vietnam's capital Hanoi, bringing new opportunities for cross-border trade between the Chinese municipality and ASEAN countries.

Besides, China's first sea-rail automated container terminal was recently put into operation in Guangxi's Qinzhou, and the Beibu Gulf Port is now linked to over 60 container shipping routes.

ASEAN has maintained the largest trading partner of Chongqing for three years in a row. Last year, trade volume between the two sides stood at 129.2 billion yuan (\$19.19 billion), up 15.2 percent year on year. Chongqing's actual use of foreign capital from ASE-AN countries grew 124 percent from a year ago to nearly \$1.64 billion, while its investment in ASEAN countries hit \$46.73 million, up 41 percent year on year.

Chongqing and Hainan jointly launched an initiative with Indonesia, Vietnam and Laos on the promotion of international cooperation on the new land-sea corridor for further trade and investment facilitation.

Besides, a comprehensive cross-region operation platform is taking shape for the corridor. So far, a number of state-owned platform enterprises from Chongqing municipality, Guangxi Zhuang autonomous region, Guizhou province, Gansu province, Ningxia Hui autonomous region and Xinjiang Uygur autonomous region have joined the construction of the platform.

Ba Chuanjiang, director of the ports and

logistics office of the Chongqing municipal government, introduced that the corridor becomes an important driver for the opening up of western

China. The stability and efficiency of the corridor are attracting more enterprises to enhance their cooperation with ASEAN countries, and a crossborder industrial and supply chain is shaping up by international enterprises.

More than 20 projects and organizations, including the Lao-China Economic and Trade Promotion Association, have set up offices in Chongqing. Many Chongqing-based enterprises have established plants in Indonesia and Thailand, such as Chongqing Sokon Industrial Group and Zongshen

Kwembe said that as the years go unable to work.

Raphinha strikes again as Barca beat Real Madrid 1-0

RAPHINA made it two goals in two matches as Barcelona defeated Real Madrid 1-0 on Saturday in their Las Vegas Clasico.

Raphinha, signed from Premier League Leeds United earlier this month for around \$60 million, followed up his debut in a 6-0 thrashing of Inter Miami with the lone goal of the high-profile clash at Allegiant Stadium, the \$1.97 billion, 65,000-seat home of the NFL's Las Vegas

The Brazilian was perfectly placed to intercept an illadvised pass from Real's Eder Militao along the top of the area. After one touch to settle he lashed a left-footed shot over Thibaut Courtois into the top right corner of the net to put Barcelona up 1-0 in the 27th minute

The fourth edition of the Clasico to be played outside of Spain -- the second ever held in the United States -featured all the intensity of the long rivalry.

Real Madrid, playing their first pre-season friendly, nearly opened the scoring in the 18th minute but Federico Valverde was denied by the post in the 18th minute, seizing the ball after a poor clearance by Jordi Alba and blasting a volley from 25 yards out that beat Marc-Andre Ter Stegen only for the upright to intervene.

Two minutes later it was Barcelona who saw a chance get away when Eduardo Camavinga lost possession to Pedri in front of Real's goal. Pedri found Fati, who pulled Real keeper Thibaut Courtois off his line but put his shot just wide of the far post.

Overall it was Barcelona -- energized by the debut of Polish striker Robert Lewandowski after his move from Bayern Munich -- who controlled the tempo in the first half against the reigning Champions League and La Liga title holders.

The first half ended on a testy note after Jordi Alba's sliding tackle on Militao that earned a yellow card.

Some jawing and shoving escalated, with players having to step in and separate Madrid newcomer Antonio Rudiger and Barcelona's Ronald Araujo.

Lewandowski's night ended without a goal as he was departed at the half, replaced by Pierre-Emerick Aubameyang as part of a raft of changes at the midpoint.

Aubameyang had a chance just two minutes into the second half with a header from the center of the area off a cross by Raphinha but missed it left.

A back and forth between substitute Marco Asensio and defender Lucas Vazquez gave Real Madrid a golden opportunity in the 59th minute, but after Vazquez played the ball back to Asensio in front of goal he pulled his shot wide.

They pressed desperately in the closing minutes for an equalizer, but Carlo Ancelotti's side clearly missed French star Karim Benzema, who was granted an extended holiday by the club and sat out the contest after joining up with his teammates in Los Angeles just days before.

Real Madrid continue their US tour on Tuesday against Mexico's Cub America at San Francisco's Oracle Park baseball venue while Barcelona take on Italian giants Juventus in Dallas on the same night.

Both play again on July 30, when Barcelona take on Major League Soccer's New York Red Bulls and Real Madrid play Juventus.

Haaland debut goal lifts Man City to 1-0 friendly win over Bayern Munich

ERLING Haaland launched his Manchester City tenure with a goal as Pep Guardiola's men beat Bayern Munich 1-0 in a weather-disrupted friendly at Lambeau Field in Wisconsin on Saturday.

Two delays because of lightning in the area -- one before kickoff and one in the first half -- saw the contest shortened to 80 minutes.

It was plenty of time for City's new \$61 million striker Haaland to make an impression in his first appearance after Guardiola declared him over the injury "niggles" that kept him sidelined during City's 2-1 victory over Mexico's Club America in Houston on Wednesday.

Manchester City had threatened twice before a closerange strike by Bayern's Serge Gnabry's was disallowed by a narrow offside call in the seventh minute.

Five minutes later Haaland struck. After Riyad Mahrez's free kick was blocked Kevin De Bruyne managed to corral the ball and slip a pass through for Jack Grealish, who whipped it across to Haaland to connect from close range.

Frustratingly, another round of electrical storms brought proceedings to a halt, with players exiting the field and the near sellout crowd of 78,128 at the iconic home of the NFL's Green Bay Packers instructed to seek shelter in the concourses.

The start of the match had already been delayed almost 20 minutes because of dangerous weather condi-

The disruptions didn't dampen the festive atmosphere for the first professional soccer match ever held at Lambeau, with a few hardy fans even braving the pounding rain and risk of lighting to remain in their seats during the stoppage.

Play resumed with 27 minutes left to complete a 40-minute first half and Haaland quickly energized City fans in attendance, bursting through behind the Bayern

Hazard talks to ESPN about his injuries, Real Madrid future: 'I'm just ready to play'

HREE years into his Real Madrid reer, it feels as though Eden Hazard still hasn't really got started. Signed from Chelsea in 2019 as arguably the Premier League's best player, and fully expected to fill the void left by Cristiano Ronaldo's departure a year earlier, the Belgium international has instead become an afterthought in LaLiga and, to some, a punchline.

Hazard, 31, has won two Spanish titles and a Champions League with Real Madrid, but he played a supporting role in those successes. After arriving overweight -- by his own admission -- in the summer of 2019, things only got worse from there, as an ankle fracture in November 2019 was followed by surgery in March 2020 and the insertion of a metal plate in his right fibula.

If 2019-20 was, in Hazard's words, "the worst of my career," then 2020-21 wasn't much better. More injuries followed, and he ended the campaign irritating the club and fans when he was pictured joking with former teammates after a Champions League defeat to Chelsea.

He was a bit-part player again last term, with his preferred position on the left of the attack monopolised by the season's breakout star, Vinicius Junior. By March, feeling sick of ongoing ankle discomfort and related muscular injuries, he opted for more surgery to remove the plate that had been inserted two years earlier.

came when he took an unexpectedly high-profile role in Madrid's trophy celebrations in May. "Madridistas, I've been here for three years, with a lot of injuries," he said, after grabbing a microphone to exuberantly address the crowd of fans gathered at the city's Plaza de Cibeles. "But next year I'll give everything for you!"

They're just words, of course, and Hazard will need to do his talking on the pitch. Nobody doubts his talent; there have been questions about his attitude toward training and whether injuries have robbed him of his ability to beat defenders. But there are some reasons for optimism. Hazard is said to have returned for preseason in shape and free of pain. In an unusual, demanding year -- nobody knows how players will be affected by the midseason World Cup -- and with Madrid not planning on signing a forward after missing out on Kylian Mbappe, he might get his chance as a back-up for Karim Benzema.

"My idea is to try Eden in [the false No. 9] posimanager Carlo Ancelotti said last week. "With the qualities he has, it can be good for us to have him there."

As Real Madrid begin their preseason tour of the United States -- staying at Los Angeles' Beverly Hills Hotel and training at the UCLA campus -- Hazard spoke to ESPN's Mauricio Pedroza about his hopes for this season and why

> Hazard: It's been a few seasons that I've not been playing that much, so for me, it's like the [first] full one now with this club. I just want to show what I can do on the pitch. That's my only target.

ESPN: What is the biggest challenge of this season, considering that the World Cup will be played in the middle of it?

Hazard: To be competitive in every competition. It's going to be a tough season, that's for sure, because we are also champions of Europe, and you know that when you are champions of Europe, everyone wants to beat you. But we are ready for that. We have a good team. Some new players came, so we're just ready for this new season.

ESPN: How do you feel in this preseason -- in terms of your health, in terms of your shape -- compared to what you had to go through in the past couple of years?

Hazard: I'm good. I'm healthy, you know, thank you for that. I can play -- I can do what I want on the pitch. So I hope I'm going to stay fit [for] two or three more years, I still want to enjoy my game, and that's why I'm here.

ESPN: Because injuries seem to be part of the conversation around vour career at Real Madrid, how have you been able to cope with that

Hazard: Believe me, it's not that easy. You know, when you play football, you just want to be on a pitch. You try to know **ESPN:** How would you what's happening, because was something new for me. You have to learn how to take care of your body in a different way, but it's a good challenge. Like I just said: I'm healthy, so I'm just ready to play.

> **ESPN**: What changes did you make personally with your routine during the offseason, once the Champions League finished? Do you do anything different to get into the very good shape that you're on right

> **Hazard:** Not that much. You know, I spent two weeks with Belgium at the end of the season. I was able to play four games, not 90 minutes. And then in my mind I was like: "OK, I can play, I don't feel it. I don't feel any pain anymore. So let's go forward, you know, and then I just enjoyed my holiday." I work a bit be

ESPN: You pointed to your head [when giving that answer], which is **interesting, because it's** know? It's like he's been at to go back and train, but he's scoring more goals, how tough is it for a player like you that the mental aspect is also on point while you're dealing with this injuries?

Hazard: Yeah, but like I just said, it's not that easy, especially when you don't know why you were injured. I've been injured at times with Chelsea, but not like those three years with Real Madrid. I knew something was wrong with my body, so that's why I asked to do surgery at the end of the season.

ESPN: When you see your club succeed like last year, winning La-Liga and the Champions League, but you're not having the minutes that you want to have on the pitch, how would you describe that mix of feelings?

Hazard: It's a mix just like you said; you're happy for the boys, you're happy

for the club, you're happy for the fans, but you know inside you, it's like I can't show I'm not happy [to not be involved], you know? Football is a collective thing, but inside me I was like: "OK, I want good things this season, but I was not playing that much, so let's show that I can play and we can win with me involved on the pitch."

ESPN: What's the biggest strength of this Real Madrid squad?

Hazard: I think it's that we play well together, we have experienced players and we have newer players ... we have a mix of generations. You know it when you see us on the pitch. We look like a real team. You know last year, we had a fantastic Champions League, but we were behind in so many games and just never gave up. We tried to just play until the end, and there were so many game like that. So I think it's like a mix of things: a mix of generations and talent also, because we have plenty of talent in the squad and we're just happy to be together.

ESPN: That's a strength. Give me one weakness.

Hazard: We don't have it! Sometimes we got tired a bit, but that's it.

ESPN: If you were to present Karim Benzema as a candidate for the Ballon d'Or, what would you say on his behalf? Hazard: Karim? I think

he deserves it. You know, there's no doubt about it. But I think he deserves it not just for that season, but for his whole career, you which is why people just want him to win this Ballon d'Or, but I think he deserved it before, like five years ago. He's our captain now and he's also, like, a really good guy, you know? He's not talking that much on the pitch, doing what he wants. He's our leader. So we just pushed him to go for the Ballon d'Or.

ESPN: Part of the history of Real Madrid is that they have a strong squad and are always looking to make it even stronger with new signings. Were you surprised when Kylian Mbappe decided not to join Real Madrid?

Hazard: I think that is in the past now; we're just focusing now on this season. He's a player at Paris Saint-Germain, and that's it. He made a choice and we have to respect it. And that's it. We look forward to the season.

ESPN: Speaking of the next season, your rivals Barcelona are making a big splash with signings. Do you guys need your biggest rival to be strong again?

Hazard: It's better for LaLiga when these kind of matches are like, "Wow, what a Clasico." You know, [when Barcelona have] better players, it's even more fun to beat them. But we are ready for this chal-

ESPN: Have you guys reached out to Gareth Bale here in L.A.? Have vou had any contact with him now that he's playing here at LAFC?

Hazard: I just spoke with him yesterday, just to ask him to come to say hello. He hasn't answered, though, so maybe he's coming soon.

ESPN: He hasn't replied

Hazard: Nah, he's replying, but he didn't come yet. He's going to, for sure.

ESPN: OK, what did you make of his move to MLS and LAFC?

Hazard: I don't know because he was [thinking about it] when we were talking last season. I think it's a good challenge for him because he's also going to the World Cup, so he just wants to play, and I think he's in L.A., one of the best spots to be on the pitch, and we know he's been unbelievable for like 15 years and still has a lot of quality to show the world that he's still one of the best.



Brooke Henderson takes 2-shot lead into final round of Evian

EVIAN-LES-BAINS. France

BROOKE Henderson stood over a birdie putt from three feet at the 18th green, a three-shot lead going into the final round of the Evian Championship seemingly at her mercy.

For the first time on Saturday – maybe all week, given her dominance of the fourth women's major of the year – her putting stroke let her down.

Henderson missed it left, to gasps from spectators around the green at Evian Resort Golf Club. The Canadian could not believe it. Probably those hoping to chase her down on Sunday, too.

Seeking her second major title after the Women's PGA Championship in 2016, Henderson had to settle for a 3-under 68 in the third round and a two-shot lead on 17-under par – two off the 54-hole record for the

She is still in a position of strength after opening with two straight 64s, but that missed putt at No. 18 might prove costly.

The closest challengers to Henderson are a former No. 1 and a player breaking new personal ground at a

So Yeon Rvu, a two-time major winner from South Korea, shot 65 after three birdies on her last four holes and was alone in second place.

The top-ranked player in 2017, when she won the ANA Inspiration for her second major, she hasn't been in contention this deep into one of women's golf's biggest five tournaments for three years.

Sophia Schubert ranked No. 283 and without a top-50 finish in a major, was two strokes further back on 13 under.

The American birdied her last four holes for a 66 and was in new territory alone in third place in just her fifth appearance in a major.

Olympic champion Nelly Korda started the third round in second place, three strokes behind Henderson, but could shoot only even-par 71 – the worst score of the current top 20 on a warm and still day when only a few tough pin placements kept very low scores off cards.

Korda was on 11 under overall, six shots off the lead, and in a five-way tie for sixth with, among others, topranked Jin Young Ko (67).

Above them in a tie for fourth place, five behind Henderson were Carlota Ciganda (67) and Sei Young Kim

If the end of the 2021 tournament is anything to go by, there's plenty to play for on Sunday.

Minjee Lee made up a seven-shot deficit to thirdround leader Lee Jeong-eun in the final round last year and beat her in a playoff.
