

## MPs: Pay off ATCL debts in next budget

EMBERS of the Parliamentary Standing Committee on the Budget have advised the government to set aside funds in the 2022/23 budget to pay off all outstanding debts owed by Air Tanzania Co. Ltd (ATCL) before its re-

cent revival to clear the airline's financial books.

Presenting recommendations for the proposed National Development Plan 2022/23, committee chairman Daniel Baran Sillo (Babati Rural) said this is the only way the government would make ATCL strong as it embarks on a long term revival plan.

The committee found out that the government had no plan to rescue ATCL from effects of the Covid-19 pandemic as it has been done in other countries, he said, pointing out that the Tanzania Government Flight Agency (TGFA) has continued to charge \$1.5m monthly "even for flights that were grounded."

"ATCL owes the government 86.4percent of all the debts in its records despite the fact the state has already used 557.8bn/- in the first quarter of 2021/22 budget to support the transportation sector including ATCL,"

"The committee met the ATCL management and was briefed on the key challenges hindering its operations and loss minimizing strategies, he stated, also querying the TGFA requirement that ATCL set aside 1.2bn/- guarantee fee monthly for maintenance "while the real maintenance is done

# Ginger cash trapping key rain forest range

GINGER farmers around Chome natural forest reserve within the Pare Mountains are reportedly making a fortune from the spice, but at the expense of the protected area whose encroachment is now worrying agro-sector authorities.

Officials here say that villagers have already trespassed into parts of the forest reserve, locally known as Shengena Forest, to extend their ginger farms. But worse, they are chopping down trees in large numbers as the auburn crops don't thrive in shade, requiring clear open spac-

Same District game warden Prisca Sima said at the weekend that ginger flourishes under low temperatures as found on the Chome Hills, but the crop also needs clear space, so trespassers clear the slopes and turn them into farms.

"Environmental destruction is mostly defined at Msindi and Mshewa wards," she said, noting that ten wards and 27 villages surround Shengena woodlands.

Between 2020 and 2021 demand for ginger shot up, as the crop was being

Ginger grown in Same District is sold to as far as Ukraine after being packed in Arusha or Zanzibar, local sellers say, meanwhile as ginger farming worries more than 300,000 people in Kenya and Tanzania who rely on the water flowing from the Pare

Mountains. Ngereza Msaro of Kisiwani admits that water flowing from the highlands was decreasing, pushing farmers and livestock keepers downhill to fighting over the little resource.

"And it is also the major cause for human-wildlife conflicts as feeds the adjacent Mkomazi National Park," the resident noted.

The woodland under threat is the largest forest block in the South Pare mountainous range. It is also rich in biodiversity and a major water tower in the region.

The Chome mountain forest with patches of heath, montane grassland and moss-draped elfin woodland, feeds water to irrigation schemes in adjacent lowlands, but it is imperiled as gold and bauxite mining adds to farmland encroachment, wildfires and illegal logging.

Ginger cultivation is seen by activists as the last straw, with farmers stopping at nothing to ensure they benefit the most from the highly paying crop.

Chome forest reserve perched on the South Pare Mountains around the Shengena Peak in Kilimanjaro Region was established in 1951. The woodland is an important part of the eastern arc mountain range where forest covers around 14,283 hectares on a 67 kilometer stretch, the district official remarked.

## Govt allots 4.5bn/- to cattle markets

THE government has allocated 4.5bn/- in the financial year 2021/22 to the construction and rehabilitation of infrastructure at 19 livestock auction markets close to the country's trading border posts.

The auction markets are those of Magena (Mara region), Igunga-(Tabora), Buhigwe (Kigoma), Ipuli (Tabora),

Wasso (Arusha), Gendi (Manyara), Kileo (Kilimanjaro), Meserani (Arusha), Nyanguge and Nyamatala (Mwanza). Others are Pugu (Dar es Salaam), Mkiu (Coast), Mtukula (Kagera), Horohoro (Tanga), Ndelema (Tanga) and Malampaka (Simiyu),

Abdallah Ulega, the deputy minister for Livestock and Fisheries, made this observation in the National Assembly late last week, responding to

a question by Longido MP Dr Steven Kiruswa who wanted to know when the government will carry out the renovations on the auctions. The MP identified such infrastructure as including the construction of fences, levy and tolls collection offices, modern livestock yards and breeding areas, to which the

The flight lease contract between TGFA and ATCL demands that the airline starts paying rental fees soon after being handed the planes even if it has not started operating, he said, urging that the government looks into the possibility of reviewing the flight rental fees "so that the company can start operating profitably."

The move should go together with scrapping the rental fee for the two years of Covid-19 shortcomings, he said, noting further that the pace of renovating airports countrywide was slow compared to the speed of purchasing new planes. The government ought to quicken the pace of renovations and improvements, the committee emphasized.

The committee similarly lined up ten recommendations on how to improve the agriculture sector as it employs the majority of the population, so as to eradicate poverty.

Increasing the budget allocation from 294.1bn/- in 2021/22 to at least 450bn/- in the 2022/23 budget to add value to the sector was its principal recommendation.

Analysis shows that fast growing sectors such as construction (14.4 percent annual rate of growth) achieved this growth as a result of massive investments by the government in those sectors, the committee noted.

The committee report said that it was sad to note that agriculture which contributes 26.9percent of GDP was growing at the rate of three to four percent only.

"It is evident that if the government invests heavily in agriculture including promoting irrigation, facilitating the timely availability of inputs at a friendly price, producing quality seeds and 'strengthening investment routes into the sector' then the sector will be the new gold," he said.

The committee insisted that these steps will eradicate poverty as the sector employs 66.3 percent of Tanzanians, lining up other agro-sector proposals as removing levies and fees which lead to high prices of inputs and ensuring that irrigation is practiced in all-year farming season.

The government should also set aside specially cited water sources meant for agriculture, establish large farms for produce that is often imported, like wheat, edible oils and sugar, it said, furthering that employment of more extension officers backed by the necessary infrastructure including transport to conduct their job is equally vital.

"The government should subsidize fertilizer and other inputs but also take steps to control the increasing prices of the commodity to help farmers," the report intoned, demanding that the country makes use of the wide available markets for horticulture

The government should improve irrigation by establishing water dams and developing seed production centres especially for drought resilient crops, it added.

deputy minister said the project was kicking off this month and completed February next year.

"The government will continue to improve infrastructures at the various livestock auction markets in accordance with budgetary abilities," he said.

In a supplementary question, the MP wanted to know measures the government was taking to ensure meat factories get access to enough raw materials needed for cattle fattening, saying Elia Foods factory faces a shortage in raw materials, hindering its operations. He said experts will

be contracted by the meat factories making the factories eligible for a reduction of various levies in accessing raw materials, with the deputy minister affirming that the government is prepared to deploy over 500 experts to help with cattle fattening countrywide.

But Matthew McKinnon, a spokesperson for the Climate Vulnerable Forum, which draws support from 48 developing countries, told a conference newsletter that discussions on support for those on the frontline of the climate crisis were not progressing well enough.

Despite a flurry of pledges on phasing out coal and cutting emissions in the first week of the UN climate conference, announcements on helping developing countries adapt and respond to droughts, flooding, cyclones and sea level rise have been less forthcoming.

The UK presidency made adaptation, loss and damage the theme for discussions on Monday but it was unclear what wealthy nations will bring to the table. Unlike discussions dedicated to finance and energy, no major announcements have been trailed in advance, observers noted.

Jennifer Tollmann of 'think tank' E3G told the same newsletter that what happens on Monday would play a huge role in ensuring that the conference succeeds.

The US said last week it would dedicate \$3bn/- annually for adaptation finance by 2024 pending approval by its legislature. That alone won't be enough to reassure vulnerable nations, which have grown increasingly frustrated with the lack of high-level attention adaptation received.

"They are calling for at least a doubling of adaptation funds to help them cope with climate impacts," one expert stated, indicating that on top of adaptation finance, developing countries are calling for additional and dedicated funds.

Such funds would help them recover from loss and damages caused by climate impacts affecting them now, a proposal said to be following a precedent set by Scotland at the start of the talks.

Aiyaz Sayed-Khaiyum, the Fiji minister for the economy and climate change, told reporters on Friday that the talks need to establish a financing mechanism for those that are losing the most.

"This needs to go beyond access to insurance and risk transfer arrangements to have the impact required," he said, elaborating that "it must be additional and separate to the annual financing target."

Frances Fuller of Antigua and

Barbuda, an advisor to the Alliance of Small Island States (Aosis), told the newsletter that littoral states will be facing strong challenges, citing push back from donor coun-

What wealthy nations deliver on at the start of the week in support for vulnerable ones will "set the tone for how things progress in the week," she said, noting that finance is a critical part that has not made as much progress "and we'd like to see some more there."

Wealthy nations arrived at the talks not expecting to meet a longoverdue commitment to mobilize \$100bn a year from 2020 or before 2023, thus putting finance discussions on a back foot.

In a submission to the conference on Friday, the African Group of Negotiators (AGN) called out donor countries that haven't reported on their climate finance provisions to do so by early next year.

"It's pretty clear that we are so far off the \$100bn projection," he declared, underlining that the issue is important as "it is about the quality [of the finance] as well," they said

Developing countries have repeatedly called for a 50/50 split between adaptation and mitigation finance, with speakers underlining that in 2019, only a quarter of all finance went to help communities adapt to climate impacts.

"In 2021, we are a lot further behind than we need to be. The response to the challenges that small island developing states are facing is entirely inadequate," Fuller said.

Inside the negotiations, talks on a post-2025 climate finance goal and on defining a global goal on adaptation have been difficult.

Some donor countries are resisting a tighter definition of climate finance, including specific targets for grants as opposed to loans and sub-targets for adaptation or loss and damage.

This lack of predictability of longterm adaptation finance flows is holding hostage parts of the negotiations on carbon markets.

The African Group of Negotiators is demanding that a share of revenue from carbon trading deals between countries go to the adaptation fund but the US strongly opposes it, slamming the proposal as a tax.

"The whole world is suffering from climate impacts... it's not just an African issue," Mohamed Adow, director of NGO Power Shift Africa, told the newsletter. "It's in our own interest to detoxify these negotiations and collectively build resilience," he added.

## Villagers benefit from lango wa A savings, loans group

MEMBERS of the Kipumbwi Beach Management Unit (BMU) in Pangani West, Tanga Region have expressed the importance of joining the village savings and loans (VSL) groups saying they have been able to build houses, expand their businesses and purchase fishing boats.

In an interview with The Guardian, group members, mostly fishermen said they have been able to secure loans for development activities as well as boosting their business capital.

Mwanaidi Mwinyi Hamisi said: "I had received 500,000/loan which I used to improve my business. I am now earning enough for my family."

She said her business capital had increased, and she is now supplying fish to clients in both Pangani and Handeni districts.

Ame Makame Juma, a fisherman at Pangani and members of BMU said that through VSL he has been able to purchase two fishing boats. He said the groups are important because most of them do not need to apply for loans from financial institutions and banks.

"We have been able to improve our businesses and transform our lives and income," he added.

Before establishment of the VSL schemes, a total of 22 Community Based Trainers (CBT) from pilot districts were trained on how to establish and operate the groups. Trainings were conducted in Dar es Salaam and Tanga regions.

Currently, there a total of 174 VSL groups with a total of 4, 222

members. Of the number, 2,780 are female (66 percent) and 1,444 male (34.2 percent).

The Ministry of Livestock and Fisheries is implementing a sixyear project, the South West Indian Ocean Fisheries Governance and Shared Growth (SWI-OFish) project, which is funded by the World Bank.

Commenced in 2015, the overall SWIOFish project development objective is to increase economic, social, and environmental benefits to coastal communities from sustainable marine fisheries.


It is also geared to improve the management effectiveness of selected priority fisheries at regional, national and community level.

This being the case, the project complements implementation of the Tanzania National Five Year Development Program, Fisheries Sector Development Program (2010) and National Fisheries Policy (2015).

The main project beneficiaries are the artisanal fishing communities of the Tanzanian coastal zone, with women being mostly engaged in processing and marketing.

Women not only constitute about half of the workforce but also have an important role in managing household finances, credit and savings, shore collection of marine organisms and seaweed aquaculture.

To date, the project has enhanced coastal communities access to finance through establishing village savings and loans scheme, together with providing business and enterprise skills related training.

## With world coffee production rising, Mbeya RC calls for quality cultivation

KILIMANJARO Regional Commissioner Stephen Kagaigai has said reports from the International Coffee Organisation (ICO) show that world coffee production was increasing as compared to coffee drinking, and called on coffee farmers to produce quality coffee to withstand competition in the world

RC Kagaigai (pictured) made the remarks here yesterday read on his behalf by

the Moshi District Commissioner, Said Mtanda at the competition to get the best coffee from farmers - Tanzania Fine Coffee Competition organized by Tanzania Coffee Board (TCB).

He said due to production increase, buyers have been selective; hence it is important to produce high quality coffee.

"Our country depends on the foreign market for its coffee by more than 90 per cent and we do not hold big sway in the coffee market hence every farmer has to ensure he produces quality coffee," he added.

He said according to ICO statistics, three billion cups of coffee are drunk every day in the world and Tanzania being one of the coffee producing countries, has the opportunity to win by producing high quality cup of coffee by increasing its quality.

He added that the aim of the contest is to see how to motivate farmers to compete among themselves to sample the coffee they produce.



"Both within and outside the country what was being contested for is coffee quality, hence this contest helps farmers to make sure their coffee can compete in the world market," RC Kagaigai added.

For his part, Acting TCB Director Francis Kajiru said in they received 65 coffee samples for the contest from

farmers in three coffee categories - Robusta, Arabica and Dr and semi Dry Arabica.

Kajiru said the contest known as Tanzania Fine Coffee Competition helps to bring up high quality coffee producers as well as advertising their talents in the market

Announcing winners, Kajiru said in the Arabica Coffee category, the first winner was Amkeni Coffee Group from Kilimanjaro Region, followed by Itumpi Amcos Ltd and Shilanga Amcos Ltd, both from Songwe Region.

In the Robusta coffee category, the winner was Karagwe District Cooperative Union Ltd from Kagera Region, the second and third was Jad Kagera Farmers (T) Ltd also From Kagera Region.

In regard to the Dry and Semi Dry Arabica category, the winner were farmers from Mara Cooperative Union Ltd from Mara Region, second was Aviv (T) Ltd from Ruvuma Region and third Monduli Coffee Estate from Arusha Region.

## Tanzania capable of producing 138,000 tonnes of honey - TFS

DESPITE Tanzania's good environment for beekeeping with the capability to produce more than 138,000 tonnes of honey per year, still the level has not been attained, with the actual production being an average of 34,000 tonnes of honey.

In addition, despite the country capacity to produce an average of 92,000 tonnes of beeswax per year, but the current production is only at the average 1,843

This was revealed by Caroline malundo, the Eastern Zone Manager of Tanzania Forest services agency (TFS) in her greetings read on behalf of TFS Chief Executive Officer Commissioner Prof Dos Santos Silayo to the Malinyi District Commissioner Mathayo Massele, in Morogoro Region just before the latter launched a modern beekeeping project for the youth of both Malinyi and Ulanga districts in Morogoro Region.

The project managed by Acla honey under the SET Programme and implemented by Swiss Development Corporation (CDC).

He said has 48.1 million hectares that is fit foe honey production and nearly 90 per cent of beekeeping activities is done through traditional practices including making of beehives using tree barks thereby contributing to small honey production.

Prof Silayo added that the establishment of the project will assist in improving hives making, honey harvesting and that the company will assist them in accessing honey markets.

#### Ex-DED appears in court over abuse of office

FORMER Geita District Executive Director Margaret Nakainga (60) has appeared in Geita District Court facing two counts of conspiracy to commit a crime and abuse of office.

The accused appeared in court on Friday before Senior District Magistrate Samuel Maweda, charged with awarding a tender for making animal fodder at Buhalahala area to Runazi General Supplies Ltd without the sanctions of the Tender Board and the District Planning Committee

Earlier, Attorney from the Geita Region Preventive, and Combating of Corruption Bureau (PCCB) was alleged in court Kelvin Murusuri, assisted by Attorney Antidius Rutayuga claimed in court that on divers dates between January 7 and 26, 2015 in Geita Town, the accused, being the District Executive Director, deliberately conspired with two other officials to commit a crime and abused their office.

Rutayuga alleged that in the second count the accused abused office by providing the tender for preparation of animal fodder area to Runazi General Supplies Limited, without the permission of tender Board and the Financial Planning Committee which she knew, or ought reasonably to have known to be

Muheza District Council Agriculture and Cooperative Officer, Hoyange Mbwambo said agricultural products contribute about 70 percent of the district revenues.



# DODSAL ENGINEERING & CONSTRUCTION GROUP SET TO EMERGE AS OIL & GAS AND MINING CONGLOMERATE

#### Oil & Gas

Dodsal Resources will shortly complete a 481 sq-km 3D programme on its Ruvu licence, one of the largest and potentially prolific licences in onshore Tanzania. The project is the first onshore 3D seismic project in Tanzania and was acquired with the latest wireless nodal recording system using a Compressive Seismic (CS) acquisition technique developed by In-Depth Geophysical. The first time this technology has been used in Tanzania.

To deliver the project Dodsal contracted BGP, who sourced 20000 advanced recording nodes, more than 30 drilling units and 20 GPS instruments to help complete the project before the year end. The performance of the project has broken several records including the highest daily recording production of all BGP overseas projects with explosive-seismic over the last 30 years.

Early results from the fast-track processing, using Houston's In-Depth Geophysical proprietary processing methods are already yielding promising results and Dodsal expects to be ready in December 2021 with its next set of drilling locations based on interpretation that will be provided by Houston based Rose and Associates.

The Ruvu licence covers some 4195 sq-km, including a 764 sq-km Appraisal Area over the 2015 Mambakofi-1 gas discovery. To date Dodsal have drilled 3 wells and acquired 2139 Lkm of 2D over the area, where Yet to Find estimates range up to 5 tcf of gas. Dodsal aims to start its next Exploration programme in early 2022 after the initial results from the 3D area are ready in December 2021.

### **Mining**

Exploration drilling on Dodsal's licenses in southwest Tanzania has revealed gold mineralization, and resources for the entire area are now estimated at up to 60,000 ounces. Mining and further exploration activities are planned to start in 2022.

## Agro-bank to enhance credit to grape value chain in Tanzania

THE Tanzania Agricultural Development Bank (TADB)'s central and northern zonal manager Yodas Mwanakatwe has affirmed the banks intention to scale financing to the grapes value chain in Tanzania.

Speaking during the Dodoma Wine Festivals held in Dodoma over the weekend, Mwanakatwe was explaining the bank's strategic plans to the press during the event which Prime Minister Kassim Majaliwa was a guest of honour.

"We understand that grapes have been established as one of the strategic crops by our government. Thus as the bank with the mandate in transforming the agricultural sector, it is in our mandate to catalyze transformation in the grape value chain," Mwanakatwe explained.

One of the challenges experienced by grape producers is the fact of lack of processors of grape concentrate. As identified, most farmers harvest together at once. This creates high demand for market for processors. However, many fail to sell the grape fruits and thus grape post-harvest loss.

"TADB is ready to support farmers by enhancing value addition of the grapes by financing grapes processors," Mwanakatwe emphasized. To date TADB has extended about 784m/- to grapes value chain and benefit directly about 186 producers. Hundreds more have benefited indirectly from

As the latest strategic crop declared by the government in August, among the challenges facing the grapes productivity, access to credit to small-medium enterprises (SMEs) has been identified.

"This brings TADB as an important stakeholder to ensure access to credit is achieved," commented Mwanakatwe.

While it is reported that Tanzania grape products like wine to fair well in the global market as it compete with world renowned wine producers like Italy and France. A report by the Ministry of Agriculture shows that Tanzania has the capacity to produce up to 150,000 tonnes yet currently producing an average of 16,000 tonnes only.

"With this in mind we want to support more producers, grape concentrate producers and wine producers. Our research institute TARI is already investing well in the seedling production. We want to ensure farmers and processors with this available opportunity," emphasized Mwanakatwe.

Tanzania's grapes production stood at 16,139 tonnes in 2018/19, compared to 7,527 tonnes in 2014/15, marking an increase of 114%, as reported by the Ministry of Agriculture. About 11,552 tonnes of the total production in 2018/19 were sold to local and foreign markets, 65% of which were sold to Tanzanian wine production factories, 19% were sold on the Tanzanian retail market, and the remaining 16% were exported to the neighboring country.

### **Avoid using advance** payments for projects on high-priced goods, local contractors told

THE Contractors Registration Board (CRB) has urged local contractors to avoid using advance payment for the construction project to buy luxurious things before they complete project when they win

The caution was made over the weekend by CRB Registrar Eng. Rhoben Nkori, when he was closing the three days training for southern local contractors on business skills in Iringa.

He said contractors must respect contract they sign with their clients by making sure that they complete the project within agreed time, standards and not otherwise.

"When you are trusted and awarded tender you must respect the contract because experience shows that some of us when we are given advance payment we use that money in some issues not concerning the project and eventually you fail to complete the project within agreed time and standard," he said

Eng. Nkori insisted that contractor is a very serious business which need proper management especially financial skills and the owner of the firm need to adhere to ethics so that he or she maintain the client trust for the future benefit. "You cannot get profit before the completion of the project, never. In order to get profit you must be straight to your working timetable and complete the project even before the agreed time in your contract to reduce operation cost in paying your manpower and machines you have hired," he insisted

One of the contractors who participated the training, Emmanuel Mshana of LABA construction said the training has come at a very right time and has helped many of them on how to handle their projects.

"We have learnt a lot from this three days example on how to prepare working plan, to read between the lines contractor we sign and how to use e-procurement system TANePs" he said He said the three days training has opened their eyes in many areas including on how to put their records properly and maintaining their clients by making sure there are continuity of communications among them.

Another contractor, sward Kikoti commended CRB for regular training for local contractors which he said has help them in many ways on how to fill tenders properly and compete with foreign companies.

He said they are also taught on how to face different challenges they would face during the implementation of construction projects. "They have taught us on how to fill tenders using e procurement system TANePS and for sure it has helped us a lot because we don't waste time anymore to rush for tender submission," he said

Ummy said that there has been a challenge to know the full number of people with disabilities and thus the government has to find challenges in strategic planning and various projects ranging from education, health and the economy.


She said that according to the 2012 population and housing census it was found that people with visual impairment accounted for approximately 3.8 percent of all persons with disabilities however that number is high and accurate statistics can be obtained by participating in the census next year. The number of visually impaired people is big people, so the government in collaboration with stakeholders has put in place various strategies to prevent eye problems in the country including the introduction of eye projects in regional hospitals and referral," she said. She added that through next year's census the government will be able to identify the magnitude of the problem of blindness and thus enable the government in collaboration with stakeholders to

make effective plans to address the challenges facing blind people in the country. However, he said that eye problems can be prevented if early diagnosis is made and so the government has finalized the guidelines for early diagnosis and appropriate interventions for children with disabilities in the country, including those who are blind.

She added that the main purpose of the guide is to provide specific direction and information that will enable the whole community to identify early children with disabilities and

children at risk of disability so that they can receive appropriate care. ## There is something we can learn from US diversity visas process

THERE was a low key notice in the past month that the United States embassy in Dar es Salaam had issued a statement informing the Tanzanian public that it would start receiving applications for diversity visas for year 2023 starting from early-October. The closure date was about a month later, specifically November 9, 2021 which basically implies that a portion of the public and especially relatively educated youth would already be in the know in relation to the programme. Wishing to shift to America and starting to figure out if one has the right qualifications for a diversity visa consideration isn't something one imagines at one moment and picks up the mouse to download applications forms or make inquiries.

Not much feedback has been aired since then, except perhaps in social media networks, as to how many prospective applicants made the move, and if any reactions had been received or aired by the embassy. The more notable point is how the US, perhaps among few other countries worldwide, has a specific programme to invite talented individuals from around the world, especially those pursuing higher learning in various colleges or already have such qualifications, when they don't have valid contracts with their sponsoring organizations, etc. The US issues 55,000 immigrant visas, intended for permanent stay on that basis, applying the maxim of recruiting from countries which habitually have had low numbers in the US.

It is not easy to say which other

countries have active diversity visas but the traditional ex-colonial states have specific arrangements with people having their roots in the former British or French Commonwealth to be part of the country if the need arises. Chroniclers for instance affirm that when Ugandan dictator Idi Amin tore up passports of Ugandan Asians and expelled them, a senior spiritual leader overseas, His Highness the Aga Khan, lifted the phone and raised the matter with then Canadian Prime Minister Pierre Trudeau. What followed was that a majority of them soon landed in Canada, and some in Britain itself.

Things aren't that easy for those wishing to move from conflict ridden areas, as the United States was itself discovering the difficulties it faces trying to resettle Afghan civilians who mainly worked with the former government in Kabul or were linked with the US presence in one way or another. Experience with refugees for instance from the decade long atrocious Syrian civil war shows that at times migrants take with them the genes of the chaotic situations back home, and become a pain for those who give them sanctuary. So the US is being careful in diversity visas, so as to avoid blame for any incidents much later.

While the US actively pursues talent especially in technology, computer and other learning fields, the government can set up another avenue to diversity, not to seek places for youths outside but actively invite foreign investors at a certain threshold to be granted long residence permits. It works and is usable.

## Environmental destruction in conflicts a threat hovering above many people

ACTIVIST circles were towards the end of the week marking the International Day for Preventing the Exploitation of the Environment in War and Armed Conflict. It is observed annually on the 5th of November since the start of the past decade, adopted by the United Nations General Assembly on November 5, 2001 while the legendary Ghanaian diplomat, the late Dr Kofi Annan was secretary-general., From his troubled experience as a deputy secretary general for peace keeping missions, he kew first hand what the pursuit of environmental destruction to win wars implies for civilian popu-

lations. |From a historical perspective, crushing environmental sustainability of the war effort on the other side was a cardinal instrument of conventional warfare, but as the world is gradually adopting humanistic ways even in the thick of conflict, progress has been made since the UN system was set up in 1945. Still the motion hasn't been rapid as humanistic concerns grew out of the carpet bombing especially of Germany and then the atom bombs over Hiroshima and Nagasaki in Japan to secure the surrender of the Emperor of Japan, in August 1945. But 20 years later at the start or acceleration of the Vietnam War, the use of napalm (poison) bombing of forests to get out guerrillas hidden in thick outgrowths became standard US war tactic, and the harrowing tales of impairment of skin and bodies added to global outrage.

That doesn't mean however vironments as war shie that no moral standards were being observed in that war, as cern; it won't end easily.

scholars point out that the US did not destroy the North Vietnam irrigation (dykes) system to make it incapable of pursuing the war. At the same time, industrial installations processing natural products like oil refining or storage have retained their usual categorisation as strategic objects that can be legally hit during war operations, unlike poison bombing of forests or phosphorous bombing of populations, chocking life in rivers, lakes etc. Surprisingly, it is in the peaceful activity of mining metals that water is poisoned, and less in warfare.

There is an element in the General Assembly resolution and on the basis of remarks by Secretary General Annan at that time. He said "we must use all of the tools at our disposal, from dialogue and mediation to preventive diplomacy to keep the unsustainable exploitation of natural resources from fueling and financing armed conflict and destabilizing the fragile foundations of peace." No control is possible on how warring parties use environment in war tactics, in the destruction of the human environment for instance the frequent bombing of hospitals and such care-giving in the Yemen war, to repeated pro-

Some progress has been made over the past two decades, since September 11, 2001 to control the flow of financial resources to terrorist organizations, or sympathetic to terrorist groups. But the use of displaced people or build environments as war shields in various spots is a point of con-



## Population immunity behind vaccine mandate for civil servants in Nigeria

The quest for population immunity is the underlying reason for the vaccine mandate Nigeria rolled out on 13 October for federal civil servants to increase the number of persons immunised against Covid-19.

Secretary to the Government of the Federation and Chairman, Presidential Steering Committee on COVID-19, Boss Mustapha announced the requirement for federal employees to vaccinate or ensure they bring negative vaccine tests from three-days-prior validity. It seemed like a tall order pointing in only one direction. The regulation would take effect from 1 December 2021, more than six weeks from now.

Mustapha's words stated: "With effect from 1st December 2021, Federal Government employees shall be required to show proof of COVID-19 vaccination or present a negative COVID-19 PCR test result done within 72 hours, to gain access to their offices, in all locations within Nigeria and our Missions. An appropriate service wide advisory/circular will be issued to guide the process.

Officials explain that the vaccine mandate for civil servants is necessary owing to the nature of their job that requires constant interface with citizens from various walks of life. They are thus a priority for control efforts.

Dr Faisal Shuaib, Executive Director of the National Primary Health Care Development Agency, NPHCDA, the agency in charge of vaccination, stated at a press briefing that the measure is not punitive but seeks the protection of the larger populace. Nigeria is following global best practice, aspiring to acquire herd immunity when 70 per cent of the population is vaccinated.

Dr Shuaib gave a clarification: In making a pronouncement that by 1st December, all federal government employees would have to show proof of vaccination or negative PCR test. We are clearly aware that we have to put in place all of the machinery, all of the processes and allow federal government employees access to get these vaccinations in locations that are nearest to them.

"You should also be mindful of the fact that a lot of these federal government employees have already gotten the vaccine anyway, but of course this is a small fraction, a minority of these employees that are not taking the vaccine, continue to pose a risk to other colleagues. These are the people that we need to be sure are negative before they have access to the institution. So, we have to emphasize the fact that there is an option for people to take.

"It is not that people are being forced to take the vaccine. You have the option of not taking the vaccine but actually showing negative PCR test so that you cannot be among the people that are infecting others."

Mustapha added an advisory and



caution as citizens prepare for large religious observances by both Muslims and Christians.

"The PSC wishes to put Nigerians on notice that two major religious festivities (Salah and Christmas) are approaching, and we shall be experiencing increased passenger traffic in and out of the country. Similarly, events of large gatherings are likely to hold. While the PSC prepares to escalate surveillance and other control activities, we urge the States and all Nigerians to also increase their vigilance and take measure to moderate activities", Mustapha cautioned.

Nigeria had by 13 October 2021 vaccinated four million citizens. Two million six hundred thousand (2,645,020) persons have received the first dose of AstraZeneca vaccine and 1,407,736 eligible persons got the first dose of Moderna vaccine.

Shuaib stated: "To end this pandemic, we must achieve enough level of population immunity when the virus essentially becomes a nuisance and no longer a threat. The only way to achieve this is if eligible persons come out for vaccination and observe the non-pharmaceutical interventions. The COVID-19 vaccines remain the most effective tool against this virus."

He noted that vaccine mandates have become a global practice. "With the increasing number of cases of COVID-19 globally, we are beginning to see countries instituting vaccine mandates. Some countries have begun asking workers to either present a proof of vaccination or provide weekly COVID-19 PCR negative re-

sults to be allowed into public offices", he stated.

The NPHCDA boss points to science and empirical data in support of the measure. "A recent study by the United States Centre for Disease Control which examined 600,000 COVID-19 cases, revealed that people who were unvaccinated were about four and a half times more likely to contract COVID-19. It further showed that those who are not vaccinated against COVID-19 were eleven times more likely to die of the disease and ten times more likely to be hospitalized with the disease. We should also be mindful of the long-term effects of COVID-19 infection, which is characterized by blood clotting disorders, lung, and kidney problems".

Federal health officials tread carefully in managing Covid-19. They are careful to dispel any doubts about the efficacy and necessity for vaccination against the backdrop that nature has spared Nigeria from a feared tsunami.

Shuaib emphasised the necessity for the vaccination. He also asked officials at all levels of the chain and citizens to be careful with the vaccines available. For one, do not mix the vaccines for the first and second doses. If you take AstraZeneca for the first dose, officials must ensure that the second dose is also AstraZeneca.

"Let me emphasize that all COV-ID-19 vaccines are safe and capable of protecting people against the disease. We do not promote preference of one vaccine brand over the other, and we strongly discourage mixing

of vaccine brand for first and second doses", said the NPHCDA boss.

The Federal Government urges states to take full control of the vaccine doses they receive and ensure compliance with regulations. Foremost is the fact that vaccination is free to all citizens. No state should charge for vaccination. States also need to ensure they do prevent situations where medical personnel circumvent procedures to sell vaccines or vaccine certificates.

Shuaib issued the Riot Act. "Any State found to be condoning acts of corruption will no longer be allocated vaccines. We have received reports of people trying to procure cards from health workers. These reports are being investigated and anyone found wanting would be prosecuted. It is important to emphasize that it is in the interest of public safety and collective well-being of Nigerians that the Federal Government has made available these vaccines free for all eligible persons".

The NPHCDA boss also informed Nigerians that corporate vaccination had be instituted to make it easier for workers who are too busy at their workplace to receive the vaccination at their office premises. He stated that the corporate vaccination for Ministries, Departments, Agencies, public and private corporate organizations will be provided free of charge. States and Local Governments are also reminded that no fees/levies should be demanded from the corporate bodies when teams are sent to provide these services.

## China-aided Africa CDC project running smoothly with 'full force,' says expert

CONSTRUCTION work on the China-aided future headquarters of the Africa Centers for Disease Control and Prevention (Africa CDC) is running "very smoothly with full force," a long-serving African Union (AU) expert has said.

Fantahun Hailemichael, coordinator of the Africa CDC headquarters project at the AU, told Xinhua in a recent interview that the construction of the landmark project is presently progressing smoothly and as planned.

Construction work started in December last year in the Ethiopian capital, Addis Ababa, as part of the evergrowing China-Africa cooperation in the public health sector.

"Currently, the project is running very smoothly with full force. The foundation has been almost finished, and the project is now coming up. Most of the technical ground work has already been finished," he said.

The project, covering an area of 90,000 square meters and with a total construction area of nearly 40,000 square meters, is expected to be completed within 25 months. It will be equipped with modern office buildings, high-end laboratories, and accessories.

"The project is the outcome of generous support from China to support Africa as a true and trusted

partner of African countries and the African Union," said the expert.

He noted that the project envisaged improving the public health service in Africa, particularly in terms of boosting Africa's capabilities in controlling and managing infectious diseases.

He said that African countries in particular and the continent in general do not have adequate capacity, which has been evident in the advent of the ongoing COVID-19 pandemic that wreaked havoc on a global

"That's why the government of China came in as a good friend to support Africa to tackle 'corona-type' diseases, in which African countries do have serious challenges to protect their own citizens and to make necessary investigations, find necessary medications and vaccinations and provide the necessary medical care," he said.

China's support is "credible, achievable and very concrete," he said.

Recalling China's trustworthy partnership with Africa that saw the successful completion of the AU headquarters back in 2012, the veteran AU expert said the future Africa CDC headquarters project will be another manifestation of the ever-growing China-Africa Xinhua



#### CALL FOR INDIGENOUS GROWTH-SEEKING BUSINESSES IN DAR, ARUSHA, ZANZIBAR, MBEYA, MWANZA AND DODOMA TO JOIN THE AFRAP FRANCHISE DEVELOPMENT PROGRAM

AFRAP's franchise development program is an intensive six-stage training, coaching and mentoring program. Training covers: general issues around franchising, what it is, how it works, benefits to the country, franchisor and franchisee, conducting franchise-specific market research and developing franchise-specific strategic plans, protecting your Intellectual Property (IP), developing a strong support team at head office to support your franchise system, financing your franchise development scheme, prototyping, franchise systems development, testing and documenting into franchise operations, procedures and training manuals, protecting your franchise system through legal instruments-the non-disclosure document, the franchise disclosure document and the franchise agreement- franchise system marketing and selling and franchise system roll out. Prominently, the program includes matching selected businesses with providers of cheap capital needed by the prospective franchisors to franchise their brands.

The training is arranged in six phases of a minimum three days each, with the initial training leading to selection of the 100 businesses being an intensive 6-day Empretec Entrepreneurship Training Workshop (EETW), after which selected businesses proceed to the five-phase franchise development program, all spread over the next twelve months. After each training, AFRAP and AFRAP-trained subject-specific consultants, hand-hold each participating brand to build the structure of their desired franchise system, before finally rolling out their franchise systems. Brands which go through this program can expect to become big players in the market currently opening up under AfCFTA. Businesses that successfully finish the franchise development program shall be encouraged to join the Franchise Association of Tanzania (FATA) to help grow the sector.

Well, a newspaper heading says it all, when Ummy Mwalimu, the Minister of State in the President's Office, recently stated that "there are too many dubious deals in development projects countrywide, and corruption is rampant in many government

But by this time in the UK, the sale of Christmas decorations and all manner of commercial things it relates to, will have started months ago, exploiting the fact that Jesus can almost be said to be 'hosting' the event.....thereby sanctioning its profiteering as the spiritual message is yearly diminishing.

You could say that Magufuli inherited big time his nation's own particular strain of the "big C", with the subject constantly in the media, along with public perception that it was everywhere, in state service sectors, with three out of five people surveyed, saying they'd been asked for bribes many times.

Then as always of course, there were opposing views....."petty corruption was going down"...though...

AMBO and greetings, for the "graft" was increasing etc. and going up, and some time earlier, the prime minister had assured investors that the corruption fight was being won.

> A week later, in a rare burst of honesty, the Deputy Minister for Home Affairs said the increased number of road accidents could be directly attributed to traffic police, "who though meant to be safeguarding the law, were compromised by bribes"..... what a delicate way for the Deputy to describe such shocking behaviour... ..."compromised by bribes"....!.

At the same time, a spokesman for the Zanzibar President's Office told a press conference that corruption was in .....hospitals, the judiciary, the police force, and many others in the civil service. ....though since this was well known; perhaps the revelations were possibly just an honest damage limitation exercise, to keep his policemen happy!

Well, Kenya also had an erratic record on the big "C", with many vowing to fight it, then reneging on the promise soon after. A Kenvan journalist tellingly wrote: "new terms have become part of the language, like 'private developer'...and 'millionaire businessman'.

## Partnership launched to upskill Joburg's informal waste reclaimers

NSURANCE quote comparison website Hippo.co.za, in collaboration with Urban Surfer, hosted an event in Johannesburg on Thursday to launch their partnership, which aims to improve and recognise the work by informal waste reclaimers in Johannesburg.

"From research, we know that between 80% to 90% of South Africa's paper packaging waste is recycled by informal reclaimers making a living from collecting, sorting and selling recyclable waste," said Bradley du Chenne, the CEO of Hippo.co.za.

"Informal reclaimers in South Africa have a 57% collection rate of recyclables... among the highest in the world. A special big thanks and well done to the waste pickers; you make a real difference in saving the planet and our country."

Hippo.co.za, with Urban Surfer - a team of specialists in informal recycling - welcomed 50 informal waste reclaimers to the event. Urban Surfer is teaching them recycling skills. All are from poor socioeconomic backgrounds and communities and survive by gathering and sorting waste like plastic, boxes, cans and glass to sell to recycling entities.

Palesa Mathibedi, director for pollution and waste management at the Gauteng Department of Agriculture and Rural Development, said sup-

porting the initiatives of informal waste recyclers is one of the province's goals. However, they are lim-

term 2030 goal to divert and clean at least 40% away from landfills and clable material at no cost to the municipality or the government. You are saving us about R700 per tonne of waste that you collect. Your work is very important to us.

"To show that the work is very important to us we have projects set up to support yourselves, but the budget is very small and we do need collaborations, sponsorships and partnerships."

Mvuselelo Mathebula, the head of Johannesburg Waste Management and Regulation, said: "The city is currently left with four landfill sites that are left with a five-year lifespan.

"If we don't do anything, in no time we will not have landfills in the City of Johannesburg. We have started working with the waste pickers, including the South African Waste Pickers Association (Sawpa) and the African Reclaimers Organisation (ARO) to empower the waste pickers."

Sifiso Gumbi, a former informal reclaimer and now recycler relations

officer at Urban Surfer, said: "Often the public looks at us as dirty people; we are looked down upon and not allowed in certain spaces. Even more, the ongoing stigma that we are good for nothing and most probably hooked on drugs does not make things better.

"The public forgets that actually we are also trying to make a living, with most of us having families looking up to us for everything from food to clothing and putting children through school."

At the end of the event Hippo. co.za handed over waste management trolleys and personal protective equipment (PPE) to better equip the 50 informal reclaimers currently employed by Urban Surfer.

Informal waste reclaimers Kagiso Munesi and Malindi Mvaka were grateful for the PPE sponsorship.

Munesi said, "This will give us access to some companies, buildings and neighbourhoods, because often when we are dirty and in our clothes we get dismissed. The uniforms give us identity."

Myaka said access to more places would enable them to make more money to take care of themselves and their families.

"Even though I enjoy my job I don't want to pick up waste for the rest of my life. Maybe in the long run, when I have enough funds, I will start my own waste picking company," said Myaka.

## 'Nasty cocktail': Addis Ababa looks about to fall?

OREIGN governments earlier this week urged their citizens not to travel to Ethiopia and to escape the country as soon as possible if they were there, as Tigrayan rebel forces advanced rapidly on the capital, Addis Ababa. Some countries began evacuating their diplomats.

Rumours intensified that the city could fall within days or even hours, bringing to a dramatic and possibly even deadlier close an already bloody civil war between the federal government and the Tigray People's Liberation Front (TPLF), which has raged for just on a year as at 3 November.

Desperate but defiant, Prime Minister Abiy Ahmed - ironically the winner of the 2019 Nobel Peace Prize - fobbed off peace envoys, declared a state of emergency and urged residents of the capital to arm themselves to repel the Tigrayan forces if they reached the city - an implicit acknowledgment that his own Ethiopian National Defence Force (ENDF) was not up to the challenge of defending the capital.

The US bluntly advised its nationals: "Do not travel to Ethiopia due to armed conflict..." and gave its nonemergency officials permission to leave. Its practical advice to those US citizens who opted to remain included "draft a will" and "leave DNA samples with your medical provider..." The UK and other governments also advised their nationals to get out or not to visit.

But Ethiopia's ambassador to South Africa, Shiferaw Menbacho, speaking from Addis Ababa, contemptuously dismissed the rumours of an imminent fall of the 

capital. "The empty wish declares the final burial ceremony of the rebel group," he said.

The ENDF had marched triumphantly into Ethiopia's northern Tigray province in November last year and captured the provincial capital Mekelle from rebelling TPLF forces - with the important support of the invading Eritrean Defence Force. Abiy intended a brief war to restore federal authority. But the TPLF retreated to the mountains and fought back. And over the past few months, now allied with the Oromo Liberation Army (OLA) from Abiy's own province, Oromia, it has dramatically turned the tide of war, driving the Ethiopians and Eritreans back and advancing to within 300km of Addis Ababa.

Diplomatic efforts to establish a ceasefire seem to be failing as both sides still seem to believe they can win the war. The African Union's special envoy, former Nigerian president Olusegun Obasanjo, and US President Joe Biden's special envov for the Horn of Africa, Jeffrey Feltman, are in Addis Ababa, urging peace. Obasanjo declined DM168's request for comment on his pro-

This week Feltman told journal-

ists in a phone briefing from Washington that: "Without question the situation is getting worse, and we're - frankly, alarmed by the situation... There has been insufficient access to Tigray since late June, early July." He said the UN estimated that only about 13% of humanitarian needs to the federal state of Tigray have been met. There were several reasons for that, including the fighting. "But it's mostly government restrictions ... that have prevented the type of humanitarian access from getting to the people of Tigray, and we see

signs of famine and near-famine conditions.

"There are over five million people in conditions of food insecurity now whose needs could be addressed if the government would allow the assistance to flow. And at the same time, you see the TPLF ... has moved out of Tigray, south into Amhara, [has] taken strategic cities of Dessie and Kombolcha...

"So we're calling on all parties to this conflict to find ways to de-escalate the situation, allow the humanitarian access to flow to those in need ... and move toward a negotiated ceasefire. The situation is dire, and as I said, it is getting worse..."

Will Davison, Ethiopia expert at the International Crisis Group (ICG), told DM168 that he thought Addis Ababa was more likely to fall within a few weeks rather than a few days, as he believed the Tigrayan forces would first try to capture the corridor from Addis Ababa to Djibouti, Ethiopia's vital access to the sea. "But who knows? Things are moving very fast these days," he added.

Davison emphasised that such chances as there were, at this late stage, of stopping the Tigrayan advance on Addis Ababa depended on Abiy's federal government making some concessions to the Tigray-

The most important concession would be to end the blockade on Tigray. "So the restoration of services, banking and telecommunications, electricity. And the facilitation of aid to alleviate humanitarian conditions. That would by no means solve all the problems. But it could be a way to get some initial cooperation by the Tigray leadership to stop their advance, particularly its advance towards Addis Ababa." But Davison suggested Feltman and Obasanjo faced an uphill strug-

It wasn't helpful for the US simply to call on the Tigrayans to halt their advance, as Washington did last weekend. "That's not going to have any effect."

On the other hand, there were no signs that Abiy and his allies were ready to make the kind of concessions to the Tigrayans he believed were necessary to persuade them to stop their advance.

Abiy's call on Addis Ababa residents to take up arms could be very bloody for civilians - if the call was answered, which Davison was not sure would happen. Though there was clearly a lot of opposition to the TPLF and the OLA, it was not clear that it would translate into effective popular resistance in Addis

Ababa.

And even if it did, the Tigrayans had simply rolled over popular resistance before and kept on advancing.

"But there is a real concern about attacks on Tigrayan civilians in Addis and in other cities... There is also likely to be considerable rebellious activity in Amhara region should the Tigrayan forces and the OLA take control of Addis as well,' said Davison.

Ironically, the Tigrayans "don't really want to be part of Ethiopia anymore, let alone governing Ethiopia", Davison thought.

They were aiming to capture Addis Ababa not essentially to run Ethiopia but to secure Tigray's interests as they saw them. This meant resuming the flow of trade, services and aid to Tigray and having a federal military that did not threaten them.

And the Tigrayans also needed to conduct a referendum on Tigray's independence.

"So their dilemma is how do they secure their interests without exerting considerable federal power in Addis. It's not really conceivable..."

The Tigrayans would need to avoid looking as though they were repeating Ethiopia's post-1991 politics which the TPLF dominated after its dominant role in the revolution which toppled the brutal regime of President Hailemariam Mengistu.

The victors put in place an ethnic-regional federation that kept the country together for over two decades. It was Abiy's efforts to unravel that ethnic-regional federation and centralise power that sparked the conflict with the TPLF.

## CIIE to open new markets, create new opportunities

HE Chinese market is a huge magnet for foreign smalland medium-sized enterprises (SMEs).

At the ongoing 4th China International Import Expo (CIIE) in Shanghai, 1,200 businesses among the 3,000 joining the event come in delegations.

There are nearly 50 foreign delegations, and their members are from over 40 countries and regions who are mostly SMEs and are engaged in a wide range of industries.

Besides, more than 30 least developed countries have attended the event to exhibit their agricultural and consumer products.

An official with the CIIE Bureau told People's Daily that a number of enterprises from Belt and Road countries and regions, Central and Eastern Europe, as well as Africa joined this year's CIIE despite the impacts from COVID-19, which has further enlarged the "circle of friends" of the event and highlighted the event's nature as an international public good for the world to share.

Polish dairy company Vici Group entered the Chinese market in 2019 at the 2nd CIIE. According to statistics, the sales of Polish milk, powdered

milk and cheese products in China surged 70 percent in 2020, making China the fastest-growing market for Polish dairy exports.

The CIIE benefits the whole world, said Andrzej Juchniewicz, chief representative of the Polish Investment and Trade Agency in China who has encouraged some 30 Polish companies to join the 4th CIIE.

The Japan External Trade Organization established a trade delegation consisting of over 100 enterprises to the CIIE this year, and a Japanese commodity base opened to consumers earlier this month at the Honggiao Import Commodity Exhibition and Trading Center in Shanghai, a permanent trading platform of the CIIE.

Among the 46 exhibitors that come to the 4th CIIE with the Singapore Business Federation, 18 are engaged in finance, logistics, infrastructure and education sectors.

The members of the delegation organized by the German Chambers of Commerce Abroad are mostly engaged in frontier sectors. Clas Neumann, Chairperson of the Board of Directors of the German Chamber of Commerce in China, said that the CIIE is a platform where German enterprises can demonstrate their ability to make constant innovations to Chi-

nese consumers.

The CIIE is also a fruitful event for purchasers, too. "Last year we purchased \$10 million worth of equipment at the CIIE, and our newly increased output value this year is expected to exceed 200 million yuan (\$31.26 million)," said Liu Zhongiie, a project manager of HISEMI Electronic

Technology in Chizhou, east China's Anhui province.

Liu said the CIIE is a timely information platform for enterprises that enables the latter to follow the trend of industries. "Before coming to the 4th CIIE, we have negotiated with several foreign enterprises, and we are planning to purchase over 100 million

yuan worth of equipment this time,"

"Enterprises have witnessed the development of industries and frontier technologies at the annual event, and learned advanced technologies and standards to make better commodities, technologies and brands of their own," said Wang Beilei, an official

with Xiangcheng district, Suzhou, east China's Jiangsu province.

She believes that to promote the upgrade and innovation of Chinese enterprises by applying new equipment, commodities and services in their development is an important part of the CIIE's spillover effect. This year, Xiangcheng district has organized a trade delegation of over 1,000 people to the CIIE, and its 230 participating enterprises are expected to reach deals totaling over \$60 million.

Yao Hai, an official with the Shanghai municipal government, noted that since the 1st CIIE, Shanghai and its districts, as well as their industrial parks and enterprises have been working together to turn exhibits into commodities, exhibitors into investors, and purchases into traders, and a series of major projects have been implemented in Shanghai, the Yangtze River Delta and even other larger

This year, the cooperation and communication office of the municipal government of Shanghai has established a purchasing group, which is joined by over 300 enterprises, to make the spillover effect of the CIIE benefit more cities, enterprises and people, Yao said.

## TDL chief says committed to back smallholder grape farmers turned commercial producers

N a bid to ensure that smallholder grape farmers who provide the raw material used in wine making, Tanzania Distilleries Limited will continue investing in the group improves on quality and yields.

TDL's General Manager, Timea Chogo said the Tanzania Breweries Limited's subsidiary is committed to ensure that the grape farmers who constitute its supply chain, are skilled, connected and financially empowered so that they can have better livelihoods whilst the distiller continues to have access to high-quality grapes.

She noted that the contracted farmers benefit from market-related off-take agreements, linkage with financial institutions, chemical and fertilizer suppliers but also receive training in good agriculture practices from South African experts.

She explained that in order to ensure that farmers are skilled, agronomic support is provided from TBL's viticulturist and agronomic team; grape research trials take place with AB InBev's R&D team and Tanzanian Agricultural Research Institute.

"The whole process means that the farmers are also given grape cultivation guidelines through use of SMS which provides farmers access to agronomic and market information," the TDL chief executive noted.

During the wine festival participants and visitors learned about the history of winemaking in Dodoma, types of grapes and farming procedures. The country has more than 60 unique local wine brands. TDL's brands include

Dodoma Dry Red, Dodoma Dry White, Dodoma Natural Sweet and Dodoma Rosé. Under its fortified wines brand, Imagi, TDL has two brands, namely, Imagi Fortified Sweet Red and Imagi Fortified Sweet White.

TDL's vision for the Tanzanian wine industry is to support small-holder talented farmers to enable them become large scale commercial producers of the high-quality grapes that the distiller will use to produce internationally competitive wines.

## State investments in aviation attracting more foreign private players into sector

CONFIDENCE in the rapidly growing aviation industry led by state-owned Air Tanzania Company Limited and the easing of the coronavirus outbreak have convinced Celebi Tanzania Aviation Services Limited to invest in ground handling services at airports.

Celebi Tanzania, a subsidiary to Celebi Aviation, last week became the third ground handling company operating at Julius Nyerere International Airport (JNIA) in Dar es Salaam alongside rivals, Swissport Tanzania Plc and Nas-Dar Airco.

Speaking in Dar es Salaam during a breakfast meeting with aviation stakeholders, Celebi Aviation's Executive Sales and Marketing President, Thomas Konietzko said investments being made by the state in the industry point to a bright future.

"We have been closely following initiatives taken by the government since the past five years in strengthening the growth of the aviation industry. We have seen much interest of the government in investing in the national carrier by purchasing new planes," Konietzko said.

He explained that the investment being made by the government is providing confidence to the private

sector to take part and play its role because the future is bright. According to Konietzko, his company has so far held negotiations with a number of airlines to handle their freight at

The Celebi Aviation chief further said the company has an experience of handling a number of big airlines such as Ethiopian Airlines, Flydubai, Emirates, Qatar Airways and KLM in other counties where they operate and had already won their trust. As of now Celebi has a presence in other five countries of Turkey, India, Hungary, Germany and Austria where it operates in 41 airports.

"We have so far invested about U\$2million in terms of ground equipment and personnel in the country. But we have also trained about 60 local personnel and we look forward to enhancing airport ground handling services in the country to reach world-class standards," Konietzko added.

In remarks at the event, Celebi Global Marketing and Communications Manager, Funda Eraslan affirmed that the company is not focused on competition, but rather what to deliver in the market. Eraslan pointed out that Celebi is well positioned to strike agreement with airline partners seeking quality ground handling services.

The government recently disclosed that it plans to procure five new passenger and cargo planes for the national carrier to increase the fleet to 16 for ATCL. In addition to two new Airbus A220-300s received this month, ATCL has two Boeing 787-8 Dreamliners, two Airbus A220-300s and five Bombardier O-400/Dash 8-400s.

## Diageo to make whisky in China to woo premium drinkers

BEIJING

Diageo Plc is investing \$75 million into building its first whisky distillery in China, aiming to turn more local drinkers into whisky lovers in a spirits market long dominated by baijiu makers like Kweichow Moutai Co.

The British alcohol giant will next year start construction on a 66 000 metre facility in Yunnan province, aiming for completion in 2023, it said in a statement Tuesday. The distillery will produce Diageo's first Chineseorigin, single malt whisky targeting the country's so-called "premium" drinkers, the statement said.

Premium alcohol – including

Moutai's prized baijiu and Budweiser Brewing's premium and super premium brews – has significantly outperformed China's overall liquor sales in the last few years, even as the pandemic kept consumers away from restaurants and bars.

"China continues to be an attractive market for us with the increased consumption occasions, the fast-growing middle class and the rising appreciation for whisky," Sam Fischer, president of Diageo Asia Pacific and Global Travel, told Bloomberg in an interview

International retailers are upgrading their offerings to meet the demands of a growing Chinese mid-

dle class eager for more expensive products from luxury handbags and cosmetics to higher-end beer and imported steak. Global firms operating in China are increasingly looking toward future growth in the world's largest consumer market, as the pandemic – now fuelled by the delta variant – drags down sentiment in other areas of the world.

Fischer said some details of Diageo's new whisky – including pricing and launch information – hadn't been decided, as the liquor will need to mature for at least three years following the Yunnan distillery's completion, according to Diageo. Still, it will be priced "well above" a

whisky jointly produced by Diageo and Chinese baijiu distiller Jiangsu Yanghe Brewery Joint-Stock Co in 2019, which sells at about \$50 for a half-litre bottle.

Diageo's China ambitions are based on whisky's solid sales growth in the mainland over the last five years. The country's \$1.7 billion whisky market – though far smaller than the \$150 billion local spirits category mostly composed of baijiu – posted high-single digit growth annually from 2016 to 2019, with just a slight drop last year amid the pandemic, according to Euromonitor International

Rival Pernod Ricard SA in 2019

also announced plans to debut a new made-in-China line of malt whisky by 2023 at the earliest and build its first malt whisky distillery in the country, in Sichuan province.

Diageo, the owner of Johnnie Walker and Singleton, faces a key challenge in China: making whisky a desirable option for group gatherings and gift-giving holidays where baijiu has long played a key role. "Specifically, there are cultural occasions in China such as Chinese New Year and Mid-Autumn festival," Fischer said. "Now our goal will be to make whisky more relevant to those occasions as well." The distillery will be carbon neutral and recycle the

water it uses, the company said, and will have a visitor centre for whisky fans.

Earlier this year, Diageo opened a new logistics centre in Shenzhen, and announced the construction of a Shanghai-based research and development centre it said would strengthen the ability to develop premium products catering to Chinese tastes.

"Our performance has been super on the back of that belief over the last three, four years in China," Fischer said. "We'll continue to invest to develop our brands so that we can play into that long-term growth



## CBN finally gives "approval in principle" to Airtel and MTN to operate banks

The Central Bank of Nigeria has given an "approval in principle" to Airtel and MTN to operate Payment Service Banks (PSBs) in the country in its bid to increase financial inclusion

This is coming about two years after the apex bank issued approval-in-principle to three Payment Service Banks (PSBs) - Hope PSB, Money Master PSB and 9PSB in 2019. The three PSBs got their final approvals in August 2020 and they have already started operations.

Corroborating the story, MTN issued a statement, signed by the company secretary Uto Ukpanah, saying: "MTN Nigeria Communications Plc (MTN Nigeria) as promoter, received an approval in principle (AIP) dated 4 November 2021 from the Central Bank of Nigeria (CBN) for a license application for the proposed MoMo Payment Service Bank Limited.

This is the first step in the process towards a final approval, subject to the fulfilment of certain conditions as stipulated by the CBN. The decision to issue a final approval is firmly within the regulatory purview of the CBN and we respect their right and judgment in that regard.

MTN Nigeria affirms its commitment towards financial inclusion agenda of the CBN and the Federal Republic of Nigeria and continues to explore means whereby it can contribute to its fulfilment. While we look forward to the eventual grant of a final PSB licence, we will continue to communicate material information in accordance with regulator obligations and guidelines."

Airtel Africa's Simon O'Hara also said that his company had also been notified of the "approval in principle" received for its own PSB - Smartcash. According to Segun Ogunsanya on the development, "| am very pleased that Smartcash has been granted an approval in principle to operate a service bank business in Nigeria. We will now work closely with the Central Bank to meet all its conditions to receive the operating licence and commence operations."

"The final operating licence will enable us to expand our digital financial products and reach the millions of Nigerians that do not have access to traditional financial services. I am looking forward to working closely with the Government, the Central Bank and traditional financial institutions to expand financial inclusion and meet the evolving needs of our customers and the economy."

The PSB initiative was introduced by CBN in 2019 as a measure to increase financial inclusion in the country particularly in rural areas. According to the CBN, a major objective for the establishment of PSBs is to leverage mobile and digital platforms to enhance financial inclusion in rural areas, especially the underserved parts. This is expected to be achieved by increasing access to deposit products, payments and remittance services to small/micro businesses and low income households.

The Central Bank of Nigeria introduced the National Financial Inclusion Strategy (NFIS) in October 2012 to provide Payment Service Banks across Nigeria with the aim of breaking the traditional barrier preventing financial inclusion and promoting low cost, secure and convenient financial services across the country. The CBN's vision was for 80 per cent of Nigerian adults to be financially included by the year 2020.

The EFInA Access to Financial Services in Nigeria 2020 Survey shows that only 64% of Nigerian adults were financially included by the end of 2020. This means that 36% of Nigerian adults, or 38 million adults, remain completely financially excluded.

## Mozambique all out to avoid debt restructuring inspite of gas delays

Mozambique ruled out reworking its sole \$900 million Eurobond, even as delays in giant liquefied natural gas projects because of an Islamic Statelinked insurgency cost it revenue, the Finance Ministry said.

TotalEnergies SE in April suspended work on its \$20 billion project, Africa's biggest private investment yet, due to an escalation of violence in the gas-rich northern Cabo Delgado province where it operates. It is now targeting first production in 2026 - two years later than originally planned.

Mozambique has been counting on gas revenues to boost development and help pay down government debt that the International Monetary Fund sees reaching 133.6% of gross domestic product this year, the third-highest ratio in sub-Saharan Africa. The Eurobond coupon payments, which jump to 9% in March 2024, from 5% now, were structured in anticipation of TotalEnergies starting

gas production by 2024. "The macro-fiscal assumptions that under-

pinned the renegotiation of Eurobonds with the creditors' committee remain unchanged," the ministry said in reply to emailed questions. "There are no reasons to anticipate the scenario" of having to restructure the dollar bonds, which have already been through two reworkings since 2016, it said.

Still, its debt continues to mount. The government projects the budget deficit at 13.5% of GDP in 2022,

a 4.4 percentage point increase from this year's target. While the biggest source of funding will come from grants, the government also plans to borrow 11.7 billion meticals (\$183 million) externally, and 53.1 billion meticals internally, according to the ministry.

The ministry didn't comment on whether the nation is considering asking the IMF for funding following so-called Article IV consultations from September 27 to October 15, the first such mission since 2019.

hina's inflation risks are building while new Covid-19 outbreaks are dimming the outlook for economic growth, throwing the spotlight back on policy makers as the Communist Party's top leaders gather for a crucial political meeting this week.

Trade data on Sunday will provide clues on the strength of global demand, and whether it can continue to prop up the recovery as domestic drivers weaken. Exports likely grew at a double-digit pace in October, although at a slightly slower pace than in September, due to a higher base of comparison from last year. Import growth probably accelerated because of higher prices and seasonal de-

That's followed by in-

flation data Wednesday, ripple through industries which is set to show another surge in factory-gate prices to a fresh 26-year high and a pick-up in costs for consumers. More companies are starting to pass on higher raw-material costs to customers, while vegetable prices have recently spiked because of bad weather.



the backdrop of a highprofile meeting of the Communist Party's decision-making Central Committee from Monday through Thursday, in which President Xi Jinping could lay the foundation for extending his term as leader. slowed sharply in recent months as efforts to rein in the property market from construction to commodities. # J&J renews strategy to halt baby powder suits by evoking bankruptcy

Johnson & Johnson is seeking to revive its strategy for resolving tens of thousands of lawsuits alleging its baby powder caused ovarian cancer and other health problems in women.

The company ended a two-day trial in Charlotte, North Carolina, on Friday to decide whether to temporarily halt 38 000 lawsuits aimed at J&J and about 250 retailers and insurance companies. The judge said he would announce his ruling next week when J&J's bankrupt unit returns to court.

of J&J's strategy to pay at least \$2 billion to end all current and future claims related to baby powder and other talc-based products. To do so, J&J executed a legal strategy known as the Texas Two Step, creating a unit in Texas to hold all of the lawsuits, then transferring that unit to North Carolina and placing it in bankruptcy. If the lawsuits continue "outside of this court, it will effectively end this reorganisation in its infancy," company attorney Greg Gordon said.

The company decided earlier this year to employ the tactic in order to deal with the lawsuits now, in one place, instead of spending millions every month for decades fighting in courts around the country, said John Kim, the J&J lawyer leading the company's ef-

One of the main reasons: it often takes many years for some of the diseases caused by asbestos and other harmful substances allegedly in baby powder to develop, he told US Bankruptcy Judge Craig Whitley. "If litigation continues for the next 60 years," and victims keep winning huge awards, "no company could survive that," Kim

The move angered lawyers for

alleged baby powder victims, who say J&J is trying to block cancer victims from having their day in court. The lawsuits against J&J's bankrupt unit, LTL Management as well as the operating company that once sold baby powder in the US, have already been halted as part of standard Chapter 11 bankruptcy rules. It also caught the attention of Congress. The House Judiciary Committee voted Wednesday to advance a bill banning the strategy.

Now, Whitley must decide whether to stop the cases against J&J as well. Under certain cir-Stopping the suits is a key part cumstances, a non-bankrupt parent company can benefit from a bankrupt unit's lawsuit stay. Last month, Whitley declined to immediately protect J&J from the lawsuits and asked the company to return to present more evidence.

> Next week LTL Management will be back in Charlotte for a hearing about whether its case should be moved to a different bankruptcy court. Last month, just days after the Chapter 11 was filed, Whitely said he was considering sending the case to Delaware or New Jersey, in part because he has so many other, big Texas Two Step cases.

if he intends to issue an injunction protecting J&J from the lawsuits while LTL is in bankruptcy. Whether he moves the case "could have an impact on what we do with the injunction and how long it lasts," Whitley said.

If Whitley refuses to halt the cases, J&J will lose a key benefit of the Texas Two Step. Under the strategy, which is being employed in Charlotte by several other companies, victims are pressured to negotiate a deal that would set up a trust fund to pay them, instead of allowing any lawsuits to con-

# Israeli PM against reopening of US consulate in Jerusalem

**JERUSALEM** 

ISRAELI Prime Minister Naftali Bennett said Saturday that he was against the possible reopening of a US consulate for Palestinians in Jerusalem.

Bennett spoke at a press conference in Jerusalem a day after the Israeli parliament passed the annual budget for 2022.

"There is no room for another consulate in Jerusalem," the Israeli prime minister said he told the US administration.

US State Department Spokesman Ned Price said at a news briefing on Wednesday that the United States had "been very clear" about its intentions to reopen the consulate for Palestinians.

Up until 2018, the United States had two consulates in Jerusalem, one for Palestin-

ians and one for Israelis. After former US President Donald Trump "recognized the city as the capital of Israel," the two consulates were merged and housed in a new embassy.

Relations between the US and the Palestinians soured during the Trump adminis-

After US President Joe Biden entered the White House, he made several moves to improve relations with the Palestinians. One of the steps was the decision to reopen the consulate in Jerusalem for Pales-

Jerusalem, which hosts sites holy to Judaism, Islam and Christianity, is the most explosive subject in the decades-old Palestinian-Israeli conflict.

### **Iraqi PM survives assassination** attempt by drone bomb

IRAQI Prime Minister Mustafa al-Kadhimi was unharmed in an assassination attempt carried out by a drone targeting his official residence yesterday, the Iraqi military said. The media office of the Iraqi Joint Operations Command said in a statement that an unknown drone bomb hit al-Kadhimi's residency at dawn in the heavily fortified Green Zone in the center of the capital, but the prime minister escaped the attack unhurt.

"The prime minister did not suffer any harm and he is in good health," the media office said.

Iraqi security forces are taking all necessary measures toward the assassination attempt, the statement said without giving further details.

In a tweet on his official page, al-Kadhimi said he was "fine" and called for "calm and restraint from everyone for the sake of Iraq." "The rockets of treason will not shake the steadfastness and determination of our heroic security forces to preserve the security of the people and enforce the law," al-Kadhimi said.

The attempted assassination followed protests against the results of last month's elections. Friday's protests turned into a clash later with the security forces outside the Green Zone, which houses some of the main government offices and foreign embassies.

The clash left two protesters killed and dozens of protesters and security members wounded, according to official figures. In the parliamentary elections on Oct. 10, the Sadrist Movement, led by prominent Shiite cleric Moqtada al-Sadr, took the lead with more than 70 seats, while the al-Fatah (Conquest) Coalition garnered 17 seats compared with 47 in the 2018 elections.

## IMF official China has been an important contributor to the recovery of global trade

THE International Monetary Fund (IMF) recently projected that the global economy recovery continues but momentum has weakened in its latest World Economic Outlook. However, "China's share of the world economy has risen increasingly and the country's economic recovery has supported global growth directly." Krishna Srinivasan, Deputy Director of Asia-Pacific Department at IMF told People's Daily in a recent written interview.

According to the latest statistics from the General Administration of Customs of China (GAC), China's foreign trade in goods registered a total value of 28.33 trillion yuan (\$4.4 trillion) during the first three quarters of 2021, up 22.7 percent year on year. The global market shares of China's total foreign trade, exports as well as imports have increased, and China remained the world's largest trading nation in goods.

"China has been an important contributor to the recovery of global trade." Srinivasan commented that China's import and export performed well this year and the higher growth in China's trade has strong spillover effects on the glob-

al economy. "Upholding the policy of reform and opening up and rebalancing its economy towards a more sustainable growth model, China will continuously contribute to the global economic growth."

Last September, China announced a concrete long-term target of peaking carbon emissions before 2030 and reaching carbon neutrality in 2060 at the UN General Assembly.

Srinivasan thought highly of China's important role played in the global fight against climate change in the interview.

This year, China's national carbon market has started online trading. From his point of view, China's continuously promoting high-quality development, shifting away from investment-led to consumption-led growth and supporting the expansion of services and high-tech sectors, are all conductive to lowering carbon emissions.

According to IMF's newly released Asia & Pacific Regional Economic Outlook, China's experience with e-CNY (its digital currency) could hold useful lessons for those considering issuing central bank digital currencies, as long as these are backed by prudential safe-

Srinivasan praised on China's significant efforts made in devel-

oping its own central bank digital currency in recent years. China's e-CNY has started large-scale tests in a number of cities and regions.

He stressed that China's e-CNY has the potential to promote financial inclusion and improve payment efficiency, and it can expand the coverage of payment services to unbanked households and lower transaction costs for households and small firms.

"China's e-CNY can also provide targeted fiscal support and improve transparency in public fi-

### NATO in no hurry to decide who will represent alliance in Moscow - Russian diplomat

#### **MOSCOW**

NATO countries are in no hurry to decide who will represent the alliance in Moscow, Russian Deputy Foreign Minister Sergei Ryabkov told TASS on Saturday.

"Belgium's embassy in Moscow used to deal with these matters but it doesn't mean anything, they can decide differently. Since there are no relations and no dialogue, they seem to be in no hurry. We are okay with that, we don't care about not being aware of it. Once they make up their mind, we will hear from them," he

According to Ryabkov, the Russian Foreign Ministry has made it clear

that NATO needs to decide which of its member states will represent the alliance and inform Moscow of its decision.

On October 6, NATO decided to cut the size of Russia's mission to the alliance from 20 to 10 people, revoking the accreditation of eight diplomats and eliminating two vacancies.

NATO gave the Russian envoys time until late October to leave Brussels. In response, on October 18, Russian Foreign Minister Sergey Lavrov announced that Moscow would suspend the work of its permanent mission to NATO starting in early November, while the operations of the NATO Military Liaison Mission Moscow and the NATO Information Office in Moscow would be frozen.

## CIIE great opportunity for global firms amid COVID-19 -Vietnamese exporter

### Probe underway after stampede claims 8 lives at music festival in US Houston

#### **HOUSTON**

THE investigation into the stampede leaving at least eight people dead and many others injured on Friday night at the Astroworld Festival in Houston, U.S. state Texas, has been underway, Houston Mayor Sylvester Turner said on Saturday afternoon.

"This incident is being thoroughly investigated and reviewed thoroughly. It is important for us to ascertain from last night what took place, what happened, where missteps may have occurred," Turner said at a press confer-

Seven of the eight dead aged from 14 to 27 years old, said the mayor. The eighth's age is not yet available at that time. No one has been reported missing from the concert.

Up to 25 people had been transported to the hospital following the incident, and 13 of them were still being hospitalized, including five people under the age of 18, according to the

The patients also included a 10-yearold child who was in critical condition, according to media reports. "Organizers held the event to bring people together for music, but it sadly ended in tragedy," the mayor said on Twitter.

Investigators will review video from the scene and look at how the venue was laid out and whether it had enough exit points so as to explore "what caused, one, the issue of the crowd surge, and two, what prevented people from being able to escape that situa-

## AI trainer - a brand new profession in China that sees bright prospects

AI (artificial intelligence) trainer is a new job that comes with the wide application of AI technology. The duty of the job is to make AI perform better in understanding and serving humans.

Data analysis and annotation, algorithm selection and optimization, model training, and project design are all within the scope of work of AI train-

It took only four years for the job to have developed into a profession from a notion. At present. China is home to over 200,000 AI trainers, and the number is expected to hit five million globally in 2022.

Wei Zimu is an AI trainer and engineer from Haizhi Technology, a Beijing-based data company. According to her, the company's AI training system is generally deployed on the private cloud networks of its customers.

"Recently, together with the financial project team of the company, I'm using AI technology to evaluate and predict user behaviors, so as to help banks assess anti-fraud, antimoney laundering, and postloan risks," Wei told People's Daily while simulating how AI is trained on a demo system.

She said the systems of the banks always come with a large amount of data, so it needs all-rounded investigation into the features of the banks' users and how data should be exploited. That's why Wei must have, apart from AI technology,

profound understanding of the actual demands of financial businesses,

"The selection of a proper algorithm is the most important task in data analysis," she said, explaining that algorithms are like formulas, and the more they comply with the laws of the data, the more precise prediction they would make.

After selecting a proper algo-

rithm. Wei inputted data into it and started training models, which was a huge task. She told People's Daily that the process of AI computing is like the growth of a tree. At first, the tree only has a trunk and then it grows branches that go toward different directions. After twigs are grown on the branches, the tree becomes lush.

Based on the algorithm, com-

## Virus: Pfizer results open door to new chapter for treatments

THE world needs an easyto-take COVID-19-19 treatment. Pfizer Inc's and Merck & Co Inc's COVID-19 pills may be just that. But questions remain about how well they will work in the real world, how safe they are and whether they will need to be taken in drug cocktails rather than

Pfizer's COVID-19 pill results were hailed as remarkable Friday, the drug reduced the risk of hospitalization or death by 89 percent in pa-

tients. It follows a successful COVID-19 pill trial from rival Merck in October and both drugmakers are now working to get regulatory authorization. That's left even the most skeptical doctors and scientists cheering the moment as a feat for drug development and a possible turning point in the pandemic.

"Just stunning," Ashish Jha, dean of the Brown University School of Public Health, said in a tweet about the results. He added that the "implications of effective therapeutics for ending the pandemic

are very, very large."

Successful development of the Pfizer and Merck pills, drugs known as antivirals, wasn't a given. Viruses use human cells to replicate, creating a challenge for scientists who aim to destroy a virus without harming the cells. While antivirals have been developed for conditions like Hepatitis C and HIV, respiratory viruses have proven more elusive.

The new COVID-19 drugs are intended for patients who are early on in their illness and not yet in the hos-

pital. They work by stopping enzymes involved in the coronavirus' process of replicating and spreading. (Molnupiravir is being developed by Merck in partnership with Ridgeback Biotherapeutics LP. It was shown in a latestage study to cut the risk of hospitalization or death by around 50 percent in highrisk patients.)

If the drugs are authorized by regulators, they are likely to overtake currently-available antibody treatments because it's much easier to take a pill than to get an infusion,

experts said. "We have an overwhelming toolbox right now to combat COVID-19. And this is a phenomenal result. This exceeded any reasonable expectation," said Scott Gottlieb, a former US Food and Drug Administration commissioner and a Pfizer board member, speaking about Pfizer's results on CNBC. He said the end of the US pandemic is "in sight right now."

Yet only limited data on the drugs have so far been shared from trials, and through press releases, not

from the more in-depth journal publications that scientists and doctors typically rely on to vet treatment options. That leaves some questions about drug safety that will need to be addressed in the regulatory review process. Additional research on combining antivirals will likely be needed so doctors know how to best deploy the treatments.

One pill may be preferred

over another for certain patients, or two antivirals might be combined in certain scenarios such as for high-risk, very ill patients, said Amesh Adalja, an infectious disease doctor and senior scholar at the Johns Hopkins Center for Health Security. Doctors may also end up combining an antiviral with an antibody treatment for some patients, he said.

"What we'll need to see is a lot of clinical guidance, and a lot of clinical data," he said.

"When I was playing in Kuwait the chairman used to follow me and asked me to play for their team, but at that time the COVID-19 disease was at its peak and that was the reason for breaking my contract with Al Jahra," he revealed.

He says while in Namungo FC, the JS Saoura leader sought him out again to work with him but the Algerian registration window was closed.

"After the last season of the league they looked for me again and I told my agent to talk to them. They told me to go for a two-week trial, I did and passed and then I signed a three-year contract," the soccer player pointed

Salamba issues advice to other local players, who have been challenged abroad and then returned home not to give up and continue to seek team connections from different countries.

After Salamba pulled a long shot while playing for Al Jahra of Kuwait, the player is currently earning more money at the JS Saoura side.

He disclosed that for a year he is paid 161m/-, also within his contract when they win one match they earn 500 Euros (approximately 1.3m/-) and

sometimes they get up to 600 Euros (approximately 1.6m/-) as a bonus.

"I felt comforted after getting approval in front of my teammates and I already made good friends so I'm not as lonely as I used to be in Kuwait," he

The former Simba striker revealed the food challenge is the same as it was when he was young, he committed to in Kuwait where they eat chapati, pasta, chicken, and meat, while access to familiar delicacies like rice is difficult.

## Solskjaer: Man City defeat 'a big step backwards'

OLE Gunnar Solskjaer has said Manchester United have taken "a big step backwards" after their demoralising defeat to Manchester City.

United had more shots at their own goalkeeper than at City's during a comprehensive 2-0 defeat at Old Trafford on Saturday, and Solskjaer was left to accept that the November international break has come at a good time for his team following a run of just four wins from their past 12 games.

"It is very disappointing, and it feels like after last week we have made a step or two forward resultswise and then a big step backwards," Solskjaer said after the game.

"It is a way of losing that we don't like. When you lose a game against a good team, you want to see a better Man United team than that."

Asked whether he is still confident he can turn things around after a poor run of form, Solskjaer was bullish, responding: "Yes, definitely."

United don't play again until Nov. 20, when they face Watford at Vicarage Road, and Solskjaer wasted no time in issuing a challenge to his players to respond to the set-back against City.

"We are human beings, and when you lose a game of football, there is no better feeling than winning a game," he said.

"Hopefully, the ones that go away do that, and for us it is all about Watford.

"We have to come out against Watford like a proper hurt animal. The short answer is it has come at a good time for us. As a group, we have had a difficult spell. We have come through it, but this was a big step backwards.'

It was a thoroughly dominant display from City, who had 16 shots to United's five, while Ederson made only one save of note from Cristiano Ronaldo in the first half.

Asked afterward why he didn't make any substitutions in any effort to score more goals, City manager Pep Guardiola said pointedly that he believed his team were already in total control.

"I am so demanding, we are so demanding for ourselves, but I am very pleased. This is the game we needed," he said.

"They [Manchester United] are so dangerous. That is why we had a game with a lot of control.

## Man United's drift will continue as long as Solskjaer's in charge

**MANCHESTER**, England

LE Gunnar Solskjaer is customed to being humiliated on the touchline at Old Trafford. Two weeks after being mocked by Liverpool fans during a 5-0 home defeat against Liverpool, the Manchester United manager was once again subjected to merciless ridicule by Manchester City supporters as his team slid to a comprehensive 2-0 defeat Saturday against their local rivals.

Solskjaer is a decent man, someone who earned the affection of United supporters during his playing days at the club, and it's becoming painful to watch him suffer the ignominy of opposition fans taunting him with chants of "Five more years" and "Ole, give us a wave!" But unless the Glazer family, United's owners, and executive vice chairman Ed Woodward turn ruthless during the forthcoming international break by calling time on Solskjaer's 35-month reign as manager, the 48-year-old will limp on and experience more days like this, when his players fail to deliver against top-class opponents and his tactical shortcomings are exposed by elite coaches such as Pep Guardiola and Jurgen Klopp.

United and Solskjaer

by City and Guardiola on Saturday. The final score may have been 2-0, but it could have been another 5-0 if not for the heroics of goalkeeper David de Gea. One senior figure at City told ESPN before the game that "I used to feel sick with nerves coming here, but that only happens at Anfield now." They had no need to worry this time either. Since losing to Liver-

pool, United have won at Tottenham, drawn away to Atalanta in the Champions League (thanks to a last-minute Cristiano Ronaldo equaliser) and been taken back to school in defeat to City. If beating Spurs but losing to Liverpool and City is good enough for the Glazers and Woodward, that gives you an indication of where the bar is now set at Old Trafford. Yet the reality is that the past two years have been no different, and the club's decision to hand Solskjaer a new threeyear contract in July was borne of the diminished standards that have now taken root.

"We are more confident than ever that, under Ole's leadership, we are heading in the right direction," Woodward said on the day that Solskjaer signed his new

Solskjaer had not delivered a trophy for United or come close to challenging for the Premier League title when he were utterly outclassed signed his contract, yet

it was enough for Woodward and the owners. But what progress has Solskjaer made, and are they really any closer to challenging for success? Results this season suggest not, but it's a well-

established pattern. Since Jan 1, 2020, United have lost 10 Premier League games at Old Trafford, collecting 56 points at home during that period. It is, by some distance, the worst home record of the socalled Big Six clubs. Before Saturday's games, City had collected 76 points at home during that time, with Liverpool and Chelsea both amassing 67 points on home turf. Spurs and Arsenal, meanwhile, have both won 61 points in front of their own fans.

Had United not embarked on an incredible away from home, which only ended at Leicester City last month, their home results would surely have placed Solskjaer under greater scrutiny.

Their home record against the Big Six is another indicator of Solskjaer's shortcomings as a winning coach. Since Jan. 1, 2020, they've taken just five points from a possible 27 against their Big Six rivals at Old Trafford. They sit bottom of the Big Six table -- four points behind Chelsea -- with City, Spurs and Arsenal all claiming 16 points in home games between each other.

Incredibly, 21% of United's home defeats in the Premier League era have come under Solskjaer's management. And they haven't kept a clean sheet at home in

tions -- the second-worst home run in the club's history. Those statistics are damning of Solskjaer's credentials, but the United hierarchy continue to suggest that he is the best man for the job.

With no trophies, dismal form at home and their title hopes gone for another season, it's difficult to know how the Glazers can justify their patience with the manager. ESPN reported after the Liverpool defeat that several members of Solskjaer's squad are unconvinced by the manager's tactical ability, and results since have done little to suggest that the Norwegian has won over the skeptics.

United's performance against City was so passive, it was as though they knew they had little 29-game unbeaten run 14 games in all competi- chance of winning. And

once they went behind in the seventh minute, when Eric Bailly flicked Joao Cancelo's cross into his own net, it was obvious United wouldn't win. Bernardo Silva's goal on the stroke of half-time, when Luke Shaw and Harry Maguire allowed a deep cross to reach the Portugal international for an easy tap-in at the far post, simply confirmed City's victory.

Guardiola's team had 68% of possession over 90 minutes. United managed just one shot on target; in fact, they ended up testing de Gea more than Ederson, with Victor Lindelof almost joining Bailly in the own goals with a miskick that was saved by de Gea.

It was a mess, one that grew when Solskiaer threw on substitute Jadon Sancho at half-time and deployed the right-winger out of position on the left, but that is United under Solskjaer. No discernible plan, no sense of direction, and when it comes up against a top team and top coach, it all falls apart.

The owners and Woodward may already realise this, but there is no sign yet of a change being made. The drift will continue until the top four begins to disappear over the horizon, but by then, it will be too late and another season will pass by with United treading water.

A solid batting showing by Kassim Nassor propelled Tanzania's senior national cricket team to an impressive 178-run victory over Cameroon in this year's ICC Men's T20 World Cup Africa Qualifiers match which took place at the Gahanga Stadium in Kigali last week-

Tanzania's cricketers have for that matter kept on staying within reach of securing progression to ICC Men's T20 World Cup Africa Regional Final, having garnered victory in three outings.

In the last weekend fixture, Tanzania's cricketers, once again showed their batting prowess against the spirited Cameroon team by posting 240 runs on the board, losing five wickets in 20 overs, when they went in to bat first.

Kassim Nassoro proved his worth at the crease. notching 59 runs not out which were instrumental in the senior national cricketers' search for an imposing

There were further solid showing that dependable cricketers, openers Abhik Patwa and Ivan Ismail, Jitin Singh, Jatinkumar Darji, and Arshaan Jasani put to

The openers Ismail and Patwa saw to it they command a good start, cracking solid shots and ending

figures, posting 29 runs and 36 runs respectively. The impressive Nassor took the crease and proved to be a threat to Cameroon, registering 59 runs not out

which included six boundaries and three sixes. The West African opponents' cricketers, Fru, had an impressive three wickets, giving away 42 runs in four overs and fellow bowler, Bruno Toube, notched two

wickets conceding 34 runs in four overs. The duo's tenacity nevertheless did not manage to keep Tanzania's cricketers in check.

Keeping things tight for the net run rate, the senior national cricketers made sure to dismiss Cameroon within 17 overs by conceding 62 runs.

It was, ultimately, the batters' show on the day, and Nassoro was in great form with the blistering half-century to be crowned the Man of the Match.
