



Iringa District gets most of its villages into responding to vaccination drive

IRINGA District has reached all 134 villages with sensitization on the importance of receiving vaccine to prevent severe effect of COVID-19, leading to an increase in response to jab uptake.

District immunization services coordinator Sospeter Tiara said in an interview yesterday that people in all the villages have been motivated to the point where some clinics have run out of vaccines and are thus seeking help from other facilities.

"The district council received a total of 5,000 doses of Johnson & Johnson's Janssen jabs and around 3,000 have already been administered to the people," he said.

Jab delivery services attained that point given the preparations before the start of the exercise arising from the health sector accelerated plan for COVID 19 coordinated by the Ministry of Health and the President's

PM tasks govt agencies with realising inclusive economy



PRIME Minister Kassim Majaliwa has said that the government is prepared to implement inclusive economy measures with strategies designed to enable people of all walks of life fully participating in economic activities.

He made these remarks yesterday when officiating at the fifth people's economic empowerment workshop here, citing its priorities as including the strengthening of health services, community protection, water, electricity and implementation of free education.

"Healthy and educated people with enabling infrastructures are essential components of our country's economic growth," he said

Inclusive economic empowerment is a major requirement for sustainable growth, whereby the government has organised the 2025 Development Vision which among other aspects focuses at an enabling environment that will allow the country to benefit economically, socially, politically and culturally.

The 2025 development Vision also focuses at higher standards of living, peace, solidarity, good governance and a robust competitive economy, he remarked, underlining that the government has come up with various policies aiming at sustainable development

Office - Regional Administration and Local Governments (PO-RALG), in which case as a district they were able to provide education in the villages on the vaccine.

"Initially, many people were afraid of the vaccine and many had questions about this vaccine and therefore did not readily respond, but since the start of this programme we have been able to provide education and reach the people where they are, including houses of worship and other places," he said.

On the women's side, the coordinator said that adequate education to the people worked, so women have been able to show up in large numbers. Earlier women believed the vaccine prevents TURN TO PAGE 2

Human-wildlife conflicts team embarks on tour of 10 regions

A high-powered team of eight cabinet ministers recently convened by President Samia Suluhu Hassan to address human-wildlife conflicts in ten regions comprising 920 villages near protected areas across the country began the task

yesterday.

The team, which involves eight ministers in sectors like Agriculture, Water, Defense, Environment, Housing and Settlements, Natural Resources and Tourism as well as Livestock and Fisheries, will tour all the ten regions.

William Lukuvi, the Minister for

Lands, Housing and Human Settlements Development told journalists in the capital yesterday said the team will tour Dodoma, Singida, Manyara, Tabora, Mbeya, Morogoro, Dar es Salaam, Coast, Mara and Geita.

He said the task began yesterday and will run up to October 20 where the team will TURN TO PAGE 2 and an inclusive economy.

Among these policies is the 2004 National Policy of People's Economic Empowerment, which he described as a pilot policy in economic issues, setting strategies to bring about full participation of the people in economic growth.

give a report to the president on the way forward. In Dodoma they will visit Chemba and Kondoa districts, tour Mkungunero area which has been earmarked for an illustrative case, he said.

Preliminary information shows that the 920 villages are close to protected areas and were being invaded by animals while the villagers invade protected areas. The government decided not to remove them from those areas, but a few of them will be removed following assessments showing the areas are dangerous for their safety, he stated.

"This is an opportunity for regional leaders to report if there is a major crisis in their areas. We are going to end the conflicts

residents will not leave those areas soon," he said.

Assessments of those conflicts would be conducted in high-risk areas in Morogoro and Mbeya regions, where the president has ordered that the areas be left for agricultural and livestock activities, he explained.

After the president's decision they will go to assess which areas remain and which settlements should be removed despite that many such settlements are expected to remain in place, he elaborated.

Regional administration ought to prevent invasions from taking place in protected areas, he stated, noting that this exercise will not be done regularly in which case residents must obey the law.

reported in 920 villages whose Habitat Day, the minister said rapid urbanization is a phenomenon that continues in Sub-Saharan Africa, including Tanzania.

Urban growth is a catalyst for economic, social, political and cultural growth but urban sprawl and population growth, if not managed properly, can be a source of environmental degradation.

This problem faces developing countries with a large proportions located in unplanned settlements without basic services like road infrastructure, clean water and sewage systems, or poor solid waste management, he declared.

It is estimated that 70 to 80 percent of urban dwellers in the country live in unplanned settlements where they face the risk of pollution due to poor sanitation, Commenting on the World sewage and traffic congestion.

Extensive use of charcoal and wood as the main source of domestic energy exacerbates the problem, he pointed out.

Recognizing this relationship, the government is readying the houses and buildings census across the country, to be conducted in coniunction with the Population and Housing Census set for August next year, he emphasised.

"This census will help to determine the number and status of housing units, enabling the government and other stakeholders in housing development to take appropriate measures to improve housing in urban and rural areas," he said.

Housing stakeholders, especially urban dwellers, need to support these government efforts to reduce and ultimately eradicate air pollution by 2050, he added

reproduction, he stated.

Kimande Health Center medical officer in charge Salim Salim said that they have been able to work with the Itunundu village authorities in providing education in homes and even places of worship and thus increase the level of motivation among the people.

"We also thank Isimani MP William Lukuvi for coming to the ward and mobilizing Itunundu ward residents, assuring them that the vaccine is safe.

Initially, maternal and child care coordinator Leonida Kalinga said that now mothers have begun to understand as previously they did not know what the vaccine was all about.

When they come to the mother and child clinic educational material was imparted and they were able to access the jab service, putting aside the many questions they were asking earlier, she stated.

At the same time, the government in Iringa region has increased the provision of Covid-19 vaccines from 15 centers to 231 centers to move the service closer to the people and speed up the exercise.

Regional Commissioner Queen Sendiga made this observation when meeting primary health care committee bringing together various stakeholders to map out an education drive to get people turn out for the jab.

Regional administrative secretary

Happiness Seneda said that since the start of education and promotion of COVID 19 vaccination, the number of those being vaccinated has increased.

Religious leaders and other stakeholders commended the government for implementation of the health sector accelerated plan for COVID 19, seeking to increase the number of vaccinated people.

Education should continue to be provided and reach more residents in the region, they added.

Charcoal stove kills 3 people in Busanda

INFERNO caused by a charcoal stove has killed three people at Busanda village in Geita Region.

Geita Regional Police Commander Henry Mwaibambe confimed the incident saying it occurred in the wee hours of Sunday.

Mwaibambe named the victims as Unice Kulwa (25) and her two children saying they lost their lives due to suffocation after they entered the charcol stove which they used to cook beans in their house.

His husband escaped death and has been hospitalised at Katoro health centre.

Earlier, the District Commissioner for Geita Wilson Shimo saying the

incident took place on October, 3 this year at Shilungile village, Busanda in Geita region.

During the incident two children namely Kamuli Kulwa (5) and Jenipha Kulwa (3) died.

It is said, the woman after having supper she started cooking beans in a charcoal stove which she later took into the house and slept.

Neighbours suspected something unusual in the house the following day and decided to throng the house to see what happened.

"They decided to break the door after sometime where they found in a critical condition and three were pronounced dead upon arrival at the hospital.

THE government has called on the public to end violence against older people including killing which denies their constitutional and human rights to participate in economic growth.

Deputy minister for the Ministry of Health, Community Development, Gender, Elderly and Children Mwanaidi Ali Khamis made the remarks over the weekend in Dodoma during the commemoration to mark the International Day of Older Persons.

"Older people have equal rights to live, to be respected and to be given support to participate in the growth of the economy," he intoned.

She said the community should cease negative belief over older people, and begin to value and appreciate their presence in the contribution for national development.

The minister highlighted that the government in collaboration with the Police Force has managed to reduce the killings of older people from 577 killings in 2014 to 54 in 2020. "Our focus as the government is to end all killings of older people by educating the public to respect older people and to use them wisely," she

said.

The United Nations General Assembly by resolution 45/106 designated 1st of every October as the International Day of Older Persons (UNIDOP) which seeks to promote an age inclusive agenda.

The day is basically marked to increase awareness to the public on various issues pertaining to elder people including opportunities and challenges facing the group.

This year's commemoration dubbed "Digital Equity for All Ages" is aimed at recognizing the need for access and meaningful participation of older people in the digital world.

"The theme reminds us that women and older people have been left aside in the digital world, they are not benefiting from the available opportunities in the digital

THE government has begun a procedure to educate the public on the importance of COVID-19 vaccination that would be given to worshippers in churches and mosques soon after prayers.

This was revealed here at the weekend by Prof Abel Makubi, Ministry of Health, Community development, Gender, Elderly and Children Permanent secretary when stressing on the importance of vaccination to workers and staff of the Ministry of Minerals.

Prof Makubi said due to the education given by his ministry on the importance of vaccination, there has been an increase in vaccination response from the people. 'When the vaccination campaign was launched, the number of people receiving vaccination was 20,000 per day, but the number decreased to 1,000 due to negative campaign in the social networks, but as for now, after the ongoing pro vaccination education campaign the number of people being vaccinated per day has risen to 30,000," said Prof Makubi. He said currently, his Ministry has talked with Christian and Muslim leaders of in the country to start educating their flocks on the importance of vaccination in their areas after prayers.

He also said the aim of this education is to make sure the number of people receiving jabs voluntarily increases many fold compared with now, and called on Tanzanians to disregard who have been disparaging the vaccination campaign.

"I must assure all Tanzanians that our medical institutions made thorough verification of the vaccine and it was found to be totally safe, hence those deriding the campaign should be disregarded," he added.

He further assured all Tanzanians that the vaccine being vaccinated is safe even for people suffering from diabetes, cancer, kidney ailments, blood pressure and even pregnant women.

He also urged Tanzanians to grab the opportunity provided by the available vaccines before they all finish up before the coming of more vaccines.

For his part, the Minerals Permanent Secretary, Prof Simon Msanjila thanked the health ministry for providing education on vaccination to their staff.

BUS drivers making trips between Dar es Salaam, Mbeya and Songwe regions have complained on the new timetables provided by Land Transport Regulatory Authority (LATRA), claiming they do not go in tandem with the actual times of arrivals at their destinations.

Speaking to this paper at the Igawa Police Barrier in Mbeya Region, the drivers said after the shifting of the Dar es Salaam main bus terminal from Ubungo to Mbezi, the journey time has been reduced. as well as the congestion that used to take much of their journey time, but LATRA has issued a time table that has increased the time to arrive at

the destinations. Timotheo Nyagile, one of the bus drivers said the decision by LATRA has been creating inconveniences to them as they are forced to stop in the forest along the way waiting

for the time to arrive at inspecting

centres. Another driver, Juma Abdul said the new LATRA timetable also endangers the safety of themselves and passengers as they are forced to arrive at destinations deep in the night. He said quite often when night time falls many lorries enter the highways with some of drivers drunk hence becoming more prone to accidents.

On their part, some passengers said LATRA was not friendly to them

because sometimes they are forced to sleep along the way without any basic reasons.

Alex Muibrania, a bus passenger said for those passengers needing to connect to transport to their homes in rural areas, are forced to sleep at bus stations waiting for transport to their homes in the morning.

Denis Daud, LATRA Senior Officer for the Southern Highlands regions said the new timetable has been set taking into consideration of road safety.

He said the source of these complaints was high speed by bus drivers who find themselves ahead of the times set by the timetable, the situation that was hazardous to themselves and their passengers.

Be extra careful against dubious online business platforms, warns CMSA

CAPITAL Market and Securities Authority (CMSA) has warned investors in the country to be careful of online business platforms that are not approved by authorities to avoid unnecessary loss.

Speaking in Dar es Salaam yesterday when launching the World Investor Week (WIW), the CMSA Executive Director Nicodemus Mkama said that the awareness programme will enable investors to make informed decisions.

He said recently, there has been an emerging tendency of some investors to join pyramid schemes without consulting responsible authority and as a result end up in complaints and loss.

"Some investors have lost their money after investing in the online pyramid schemes. It is our hope that the WIW will play a crucial role in raising awareness to the investors so that they can make right decisions," he said.

Mkama said the objective of the week is to increase public awareness on the opportunities and benefits of using capital markets in financing development projects.

Furthermore, promote effective implementation of the National Five-Year Development Plan 2021/22-2025/26 III) (FYDP which is premised on a theme of "Realizing Competitiveness and Industrialization for Human Development" aiming at building a competitive and industrial economy for human development.

He said the week will increase investors' participation in the capital markets thereby promoting implementation of the National Financial Inclusion Framework 2018 - 2022 and National Financial Sector Development Master Plan 2019/20 -2029/30.

The executive director noted that in its endeavor to commemorate the WIW, CMSA will undertake various activities focusing on awareness, accessibility, usage and protection of investor's interests on the capital market from October 4th to 10th this year.

For his part, the representative from the Dar es Salaam Stock Exchange (DSE) Ibrahim Shimbo said low awareness among Small and Medium Enterprise (SMS's) as a result fail to utilise available opportunities in the capital market.

"During the WIW, we have planned to conduct a programme to increase awareness to the public and SMS's to increase uptake and usage of capital market products and services, " he said.

directors and teachers' union leader noted that teachers were initially very skeptical about health insurance, especially due to contribution deductions on their meagre salaries.

She said it was through serious awareness campaign that they came to understand the importance of the fund. However, she said their inquisitively helped to improve a lot of services.

"It is high time the government increases public education on health insurance since majority of people rush for the service once they have patients or have fallen sick," said the MP.

She also expressed provision of health services to the elderly, saying some of them, especially those in the rural areas hardly have access to drugs, more so if they are not available in their nearest health facility.

Former NHIF board of directors' chairperson, Prof Lucian Msambichaka also noted that the main challenge the fund faced right from the beginning was poor understanding among people, mostly on contributions.

"Many people did not understand how health insurance works and when they were told of contributions, things even got worse but with constant education thing started changing and more people were being enrolled," he said, adding that without proper education, a lot of challenges will be realized in the universal health coverage.

Officiating the event, minister for Health, Community Development, Gender, Elderly and Children, Dr Dorothy Gwajima noted that currently only 14 percent of Tanzania population have access to health insurance and only eight percent, equivalent to 4.5 million people are members of NHIF.

"There is still a great job to ensure that many people are registered for health insurance services and NHIF should be prepared to cope with the new changes," she said, adding that the fund should improve all areas of service provision.

Dr Gwajima challenged the fund to have in place strategies to reach ruralbased population, most of whom do not understand health insurance services and others who just ignore because services are not closer to them.

Z'bar academicians and activists identify flaws in Kadhi Court Act

ZANZIBAR academicians and rights activists have said that the Kadhi Court Act of 2017 has many shortcomings that need to be addressed to ensure that a woman who has divorced gets her share in properties she earned during marriage.

Zanzibar University (ZU) lecturer Dr Yahya Khamis Hamad made the remarks yesterday when presenting findings of a study conducted on women's rights and the distribution of property to couples and child care at the time when a marriage falls apart.

For instance, he said the law does not examine the criteria for a person to be eligible as a mediator but also does not specify the actual payment of a divorce decree after the marriage is dissolved.

"There must be a decision on the payment of the farewell gift and the division of marital property," advised Dr Yahya at the session held at the Tanzania Media Women's Association (TAMWA) Zanzibar Offices in Tunguu.

Dr Hamad, who heads the law department at ZU, said forcing a woman to have a receipt to prove her contribution to the marital property is not fair and deprives women of their rights.

He said it was unacceptable for a married woman to be deprived of the marital property immediately after the marriage broke up.

Dr Sikujua Omar Hamdan, a lecturer from State University of Zanzibar (SUZA), said the Kadhi Court Act of 2017 is also silent on children's rights when parents are separated.

She said the Act did not address the issue of custody of a child with special needs if his or her parents are separated which results in difficult life and deprivation of their basic rights including access to education.

She proposed the enactment of a new law on Islamic family law to reduce the burden on the Kadhi Court and expedite the implementation of Kadhi Court rules. Women and children rights activists and religious leaders said the challenge was the result of the limited implementation of the Kadhi's court which resulted in women losing their marital rights after a marriage breakdown.

Tamwa-Zanzibar director, Dr Mzuri Issa said the report focused on Zanzibar to better understand the barriers that women face in claiming part of their properties.

Dr Mzuri said women continue to be deprived of property if their marriage breaks down while children suffer more and lose their basic rights.

It's estimated that 1,457 divorce cases were filed in the Kadhi Court in Zanzibar in 2020 compared to 2019 where the cases increased to 1,515, with 1,271 cases (87.2 percent) being ruled and 186 (12.8 percent) not yet been ruled.

FARMERS have been urged to formulate strategies aimed at promoting domestic coffee consumption as a way of expanding the local market.

Speaking over the weekend during a three days coffee festival dubbed 'Kahawa festival 2021' Kilimanjaro regional commissioner, Stephen Kagaigai said by promoting local consumption of the crop farmers will increase their income by having well-established coffee markets within and outside the country.

Kahawa Festival event which started at Uhuru Park in Moshi Municipality went together with various coffee products exhibitions, seminars and workshops on high quality coffee productions, coffee research, cupping and barista completions, among many series of activities. "Local consumption of coffee in Tanzania is estimated to be 7-percent while in Ethiopia domestic consumption of coffee is more than 60 percent, so we have to promote it in our country to at least 15 percent," the RC said.



Prehistoric remains don't feature too high in those demands as they belong to a cobweb of scientific findings and partnerships, but things are changing.

> There is also something quite interesting in its naming, by the German part of the research team in Lind, that it will be known as the 'Dysalotosaurus lettow-vorbecki,' embedded in deposits of the 'middle dinosaur member' (MDM) of the Tendaguru fossilferous formation, a place with rich heritage of prehistoric fossils in Lindi. The name is tied to the German World War I commander in the then German East Africa, Gen Paul von Lettow-Vorbeck, whom it is certain is scarcely being taught in our schools. The naming reminds chroniclers of a linguistic debate on such fossil finds earlier, where a translation like 'mnyamakale tendaguru' would scarcely live up to scientific classification whatever efforts are put into it. The prefix to the German commander is crucial to mapping out its type and fossil order, in the first place.

hen a feral dog bites your child on the way to school, what does it tell us about the balance between human and natural health in Africa? As it happens, a great deal. We poison predators who harass our livestock. The loss of those scavengers leads to more feral dogs roaming our streets, creating the potential for rabies to pose a more significant threat to human health.

Rabies kills tens of thousands every year, mainly in Asia and



World Teachers' Day: Still big tasks remain in local teaching profession

ORLD Teachers' Day, also known International Teachers Day, is an international memorial event observed annually on October 5, starting from 1994, where it was intended to commemorate the signing of the 1966 UNESCO/ILO recommendation concerning the status of teachers worldwide. It is a standard-setting instrument that addresses the status and situations of teachers globally, despite the vast differences that they experience in various countries, but with a standards-setting instrument. It outlines rules or objectives on education personnel policy, recruitment and initial training as well as continuing education of teachers. It similarly covers their employment and working conditions.

World Teachers' Day aims to focus on appreciating, assessing and improving the 'educators of the world' and to provide an opportunity to consider issues related to teachers and teaching. With teachers being the highest group of public employees in number, and having scores of their fellow exteachers in public office at all levels, they scarcely lack representations, though their demands aren't always met. Still they will have something to celebrate in this year's event on account of recent changes, reinstating thousands of them to finish their careers as they were able to do their jobs, despite queries.

To celebrate World Teachers' Day, the UNESCO and Education International (EI), a nongovernmental organisation, mount a campaign each year to help give the world a better understanding of teachers and the role they play in the

Teachers' development of young people and society. With private sector partners like the media, the campaign focus on different themes each year, where in 2017 it was "Empowering October 5, Teachers," where the discussion here it was norate the now being leveraged on higher education, usually left out.

While the country marks this event, professionals will remember that there are many gaps in what can be said to be objectives of the various levels of education, and answers can hardly said to have been foung. There is an ongoing initiative launched by the sixth phase government to revisit the whole educational structure to see if learning can be revamped, the stream of subjects diminished (as plenty is now available on the hand or television, newspapers etc) and the focus be directed at handy subjects where careers can be constituted. Practical orientation is going to be given higher presence, but there is an impression that liberal arts like performance arts of various sorts, games and sports are not being properly represented, and there is so much of electronics, business modules, etc.

Last but not least is the language debacle, where for three decades experts have insisted that training is difficult because students meet with English in secondary schools instead of continuing with Kiswahili. They have never suggested that pupils start with English from primary one, and learn it efficiently thereafter. Virtually all parents want their kids learn in English, but policy makers look askance. Yet with greater integration in the EAC zone and with foreigners coming in, this liability is somewhat intolerable. Africa. Around 40% of people bitten by potentially rabid animals are children under 15, according to the World Health Organization (WHO). In up to 99% of cases, domestic dogs are responsible for rabies virus transmission to people. Rabies affects both domestic and wild animals. It not only kills. It is costly too.

Treating a rabies exposure, where the average cost of rabies post-exposure prophylaxis (PEP) is around US\$ 40 in Africa and US\$ 49 in Asia, can be a catastrophic financial burden on affected families whose average daily income is around US\$ 1-2 per person. When more than 15 million people worldwide receive a post-bite vaccination, the costs add up.

Understanding complex connections between the environment, human and animal health is critical for safeguarding nature and protecting human and animal health in Africa in the era of the Covid-19 pandemic as attention to the threat posed by zoonotic diseases grows.

Understanding more about nature's role in supporting human health in Africa is at the heart of a new report, "Nature, the Environment & Health in Africa," by WWF and the Smithsonian's Global Health Program.

Boosting our understanding of the links between nature and human health is especially important in Africa, where nature brings economic prosperity and wellbeing to more than a billion people.

We know that animals and humans pay a high price for environmental degradation and biodiversity loss. Last year we not only had the outbreak of COVID-19 but two Ebola outbreaks in the Democratic Republic of the Congo (DRC) and Nigeria's most severe Lassa fever outbreak on record. Most of East Africa is predicted to see a 20% increase in the risk of schistosomiasis - a water-borne disease - over the next 20 to 50 years due to climate change.

Our forthcoming report highlights five key priorities to pay attention to.

Firstly, we know too little about the dangers of environmental degradation to human health. We need to plug those gaps in our knowledge.

Secondly, nature's broader role in supporting health remains undervalued. We are paying a high price for the degradation of Africa's natural capital.

Thirdly, the health risks posed by environmental degradation cause disproportionate harm to Africa's poorest and most rural populations, who live in closest association with biodiversity and natural ecosystems. Fourthly, we need to educate everyone better about the bond between human, animal, and environmental health.

Fifthly, the connections between nature and health are rarely factored into sustainable development policy or public health policy in Africa. Again, that comes at a high price.

We need to talk more. To research more. To measure more. We need greater awareness. We need more evidence. We need new partnerships. We need better policies.

From pollution, poverty, pathogens and pesticides to parasites and pandemics, the links between animal health, human health, and environmental health are evident everywhere.

Our analysis shows that the collapse of ecosystems and the services they provide that support health represent a much more pervasive threat to our wellbeing than just emerging diseases such as COVID-19. This is because once degraded; ecosystems lose their ability to regulate burdens of infectious and non-infectious disease and their ability to remove pollutants, provide food and water security and the ingredients for pharmaceutical products, and support spiritual and mental health. We also found evidence

that extensive environmental degradation stemming from rapid urbanization, increased expansion and intensification of agriculture, and ongoing economic transformation, pose an increasingly severe threat to public health on the continent.

Efforts to promote the protection and more sustainable use of lands and waters should be treated as preventative medicine.

In much the same way that reducing air pollution is seen as a public health priority for preventing respiratory disease, halting deforestation, restoring degraded habitats, and promoting biodiversity and alternative livelihoods can prevent future global health crises. While the importance of health to human wellbeing and sustainable development is evident, the critical role of nature in human health, especially in the African context, is still under-appreciated. Africa can boast unparalleled achievements in human health, wealth, and wellbeing in recent decades. Declines in poverty, an increase in food security, and the reduction and eradication of many diseases have transformed the lives of millions. But these advances are not always equitable or without cost.

Much of recent human

development has come at the expense of nature, undermining ecosystems, fragmenting habitats, reducing biodiversity, and increasing our exposure and vulnerability to emerging diseases. As we push deeper into tropical forests and convert more land to agriculture and human settlements, the rate at which people encounter new pathogens that may trigger the next crisis will continue to increase.

The close connection between human health, environmental health and animal health is encapsulated in the concept of One Health. Global organisations are moving in the right direction by creating the One Health High-Level Expert Council to "collect, distribute and publicize reliable scientific information on the links between human, animal and environmental health".

In this context, a high-level panel that included the President of the Republic of Costa Rica Alvarado Quesada and officials from the WWF, FAO and Global Environmental Facility at the International Union for Conservation (IUCN) World Conservation Congress in Marseilles discussed the link between conservation and agriculture and how land health can be achieved. Sustainable agriculture restores land health, conserves soil biodiversity and maintains ecosystems that provide many services to society, including climate regulation and water supply.

Prevention is better than cure. And less costly too. Harnessing the power of nature to protect health is not only smart. It is the path to sustainability.

Strong vitality of BRI wins wide praise

N Oct 3, 2013, President Xi Jinping proposed building the 21st Century Maritime Silk Road during a speech at the Indonesian parliament. A month earlier, he had put forward the strategic framework for building the Silk Road Economic Belt.

The Belt and Road Initiative, as the two together are known, has become the most well-received international public good and the largest platform for international cooperation over the past eight years. As of Aug 23, more than 200 cooperation agreements with 172 countries, regions and organizations have been signed under the BRI framework.

As the world faces the combined impacts of changes unseen in a century and the COVID-19 pandemic, the BRI has demonstrated strong vitality and creativity and will continue to provide impetus for the global economic recovery and contribute to global sustainable development, observers said.

Despite the pandemic, China's nonfinancial out Xie Fuzhan, president of the Chinese Academy of Social Sciences, said that Belt and Road construction, which aims for the common development and prosperity of all, has brought concrete benefits to countries and regions along the routes.

The outcomes in the past eight years have shown that the BRI conforms to the trend of the times, the law of development and the interests of all countries, thus enjoying broad prospects, Xie said at a seminar in September.

Statistics from the Ministry of Commerce show that from 2013 to 2020, the trade volume of goods between China and countries participating in the BRI surpassed \$9.2 trillion. China's direct foreign investment to participating countries reached \$136 billion, and 330,000 local jobs were created by BRI programs invested in by Chinese companies.

"Thanks to the BRI, East Africa now has its first motorway, the Maldives has built its first inter-island bridge, Kazakhstan is connected to the sea, Southeast Asia is constructing a high-speed railway, and the Eurasian (region) is benefiting from the longest-distance freight train service," Cong Peiwu, the Chinese ambassador to Canada, said in June.

The fruitful results reflect President Xi's comments at a welcoming banquet in honor of guests attending suspended due to COVID-19, according to

the first Belt and Road Forum for International Cooperation in 2017.

"The Belt and Road Initiative embodies our shared dream for a better life. The initiative weaves into a common vision the dreams of different countries and peoples. We will work to translate this vision into reality and deliver greater happiness and well-being to our people," Xi said.

bound direct investment in 58 countries participating in the BRI rose 18.3 percent to \$17.79 billion in 2020, and none of the key projects involved in the BRI have been Chinese authorities.

The Belt and Road is also being developed into a model of health for protecting people's safety and wellbeing, as BRI participant countries helped each other to effectively alleviate the shortage of medical supplies amid the pandemic.

As of May, China has offered anti-pandemic assistance to more than 120 BRI partners and provided vaccines to more than 90. The China-Europe freight train, an important part of the BRI, had transported a total of 11.05 million items of medical material as of the end of March, according to the Foreign Ministry.

Xu Xiujun, a researcher at the Chinese Academy of Social Sciences' Institute of World Economics and Politics, said that the principles for BRI cooperation openness, inclusiveness and transparency and of extensive consultation, joint contribution and shared benefits, have been highlighted amid the pandemic.

"Countries are increasingly aware that mankind is a community with a shared future, and the BRI is one of the important platforms to build this community," Xu said.

As President Xi has said on various occasions, the BRI is a public road open to all, and all interested countries are welcome to cooperate and share in its benefits.

Speaking via video link at the opening ceremony of the Boao Forum for Asia Annual Conference in April, Xi said that going forward, China will continue to work with other parties in high-quality Belt and Road cooperation.

"We will follow the principles of extensive consultation, joint contribution and shared benefits, and champion the philosophy of open, green and clean cooperation, in a bid to make Belt and Road cooperation high-standard, people-centered and sustainable," he said.

Luo Zhaohui, chairman of the China International Development Cooperation Agency, said that China's foreign aid will make new contributions to the joint construction of the Belt and Road.

China's international development cooperation will continue to give priority to the countries involved in the BRI and provide stronger impetus, greater space and better paths for Belt and Road construction so as to make it an important "propeller" for global sustainable development, Luo said at the Sustainable Development Forum 2021 on Sept 27.

Nadia Helmy, a political science professor at Egypt's Beni-Suef University and an expert on Chinese politics, told CRI Online that, through the BRI, China is providing a new way for realizing international business prosperity and deepening regional cooperation, thus making the process of globalization more inclusive.

The BRI is an epoch-making initiative and a path to win-win cooperation, she said.

Why alternative to mercury is urgently needed to save miners, communities

S mercury remains the dominant 'technology' used in gold recovery by artisanal miners in the country, the government is racing against time to reduce and finally eliminate its use to minimize health, environmental and socioeconomic risks amongst artisanal miners and communities around the mines.

An estimated 7.2 million people in Tanza-

tween 13.2 and 214.4 tonnes per year, used mostly by artisanal miners who number about 1.2 million people. Between 10 and 20 per cent of all the gold produced in Tanzania is from small scale miners of whom 30 per cent are women.

"Mercury is informally imported into the country through Sirari, Namanga, Dar es Salaam and Tunduma," said Kamkuru, adding that measures are taken to ensure construction of sluicing boxes at the mines. He said the move is likely to control water contamination as the amount used to wash gold concentrates is directed to designated streams. Miners are mostly affected by mercury during gold capturing where the chemical is added to extract the gold by forming an amalgam, he added. Benjamin Mchwampaka from the National Environment Management Council (NEMC) Said it is high time for the country to come up with alternative gold processing technologies for artisanal miners because mercury use is expected to end in 2032.



nia depend on small-scale mining activities directly and indirectly.

Tanzania introduced the five-year National Action Plan (NAP) for Artisanal and Small Scale Gold Mining (2020–2025) as part of efforts to reduce the use of mercury among small scale miners by 30 per cent, increase public awareness on the impact of mercury, promote adaptation of mercury control and capture technologies as well as introduce mining technologies that do not require mercury use.

The control and elimination measures that are being undertaken by the government are in line with the Minamata Convention on Mercury whereas as one of the signatories, Tanzania ratified the international treaty on October 5th 2020 with the intention of protecting human health and the environment.

It first signed the convention in October, 2013. A total of 134 countries have so far signed the protocol.

According to an Environmental Engineer in the Vice President's Office, Kamkuru Maganya, mercury is also used in production of medical equipment, researches, industries and laboratories. He was addressing participants of a two-day seminar on the Minamata Convention held in Dodoma Region recently. The meeting brought together environment stakeholders and journalists under the umbrella of the Journalists' Environmental Association of Tanzania (JET).

In regard to the Minamata Convention, Kamkuru said the government has established a number of policies including the Minerals Policy of Tanzania (2009), the National Environment Policy (1997) and the National Health Policy (2007). The government also come up with a number of laws on environment, minerals and chemicals.

He said the government has been conducting research to come up with an alternative gold processing technology for artisanal miners instead of mercury as well as ensuring that small scale miners applying mercury in gold processing use personal protective equipment (PPE). He said although the government has not banned the use of mercury, its importation is informal as there are no official records based on the information provided by the Government Chemist Laboratory Authority (GCLA).

Mercury use in the country stands at be-

"Mercury will not be produced anywhere in the world after 2032. We need an alternative to it to ensure continued gold production by artisanal miners because large companies are already using other technologies such a cyanide, shaking tables and concentrators," said Mchwampaka

He said researchers at the University of Dodoma are working on a new smelter which is likely to facilitate direct smelting. He said the government intends to come up with a technology that is environmentally friendly with its equipment available locally at affordable prices.

Mchwampaka added that the new technology known as borax, which is essentially smelting, is expected to replace mercury. He said the technology is now used by a small number of miners at isolated places.

Abel Madaha, an environmental expert from Tanzania Mining Commission (TMC) said some of the symptoms that people affected by mercury are likely to exhibit or feel include headache, weak body, shaking, memory loss and reduced thinking capacity. Between 25 to 33 per cent of small gold miners in the country have been affected by mercury, he said.

Inhaling mercury vapour is most dangerous, and those that manipulate the mercury directly in the process of gold extraction, especially by burning mercury, are therefore most at risk. Through the use of contaminated soil and water for livestock and crops, mercury can also enter the food chain. Communities near artisanal mining locations can therefore gradually accumulate mercury in their bodies, which is especially dangerous for pregnant women, children and the elderly.

Extended exposure to mercury can cause

can damage kidneys, impair hearing, vision, and balance. In extreme situations, it can cause people to become comatose or even claim lives. Often time those who are most vulnerable, young children and elderly, are those most prone to fall victim to the effects of mercury.

Madaha said the government through the State Mining Corporation (STAMICO) has established three centres of excellence (processing plants) at Itumbi area in Chunya District, Lwamgasa in Geita Region and Katente in Bukombe District in Shinyanga Region. The districts were chosen by considering the high number of miners involved in the sub-sector.

"Small scale miners are al-

mercury poisoning, and lowed to process their gold at Joseph said: "We are aware of these established plants," he said.

> Mariam Omary, one of the small scale miners at the Chikoa/Noli mine in Dodoma Urban District said: "Some of us cannot afford protective equipment; we use mercury to extract gold with our bare hands."

Omary who has been working at the mine for four months, said she is paid between 4,000/- and 5,000/- per day depending on availability of work. She said women are not involved during gold capturing as most of them are specifically employed to crush the goldbearing gravel and wash the gold concentrate powder at sluicing boxes.

Another miner, Christina

the health and environmental risks posed by mercury and that's why we don't engage ourselves in gold capturing."

Zebedayo Machande, Manager at the Chikoa/Noli gold mine said the mine has operated for five months since its establishment and that most of the miners, especially those involved in gold capturing, are aware of the health and environment risks posed by mercury, and that they always wear protective gear during the process.

"We have four sluicing boxes here, water used to wash gold concentrates is properly managed and directed to designated streams. We do this to avoid contaminating water with mercury. Having

the sluicing boxes has really helped to protect us and the environment," he said, adding they have already drilled a well which is the main source of water for miners.

Geita Region leads in the use of mercury at 4,489 kilogrammes per year. It is followed by Mbeya (1,854kg), Katavi (1,234kg), Shinyanga (1,456kg) Tabora (1,112kg), Singida (1,048kg), Kwanza (1,696kg), Kagera(1,840kg), Mara (886kg), Iringa (870kg) and Kigoma (899kg).

Official statistics indicate that casual workers at mines earn between 80,000/- and 150,000/- per month per person depending on the availability of work. However, the monthly income can rise to over 2m/- per individual worker.

Lake Chad Basin security crisis heightened by rise in community violence

HE Lake Chad Basin region is plagued by insecurity. In addition to the terror inflicted by Boko Haram, organised crime and kidnappings for ransom in the area, it's feared that Cameroon's community conflicts could spread, further destabilising the entire region.

Land and water are at the root of the inter-communal rivalries in Cameroon's Far North that have claimed the lives of 15 people and injured 50 since May. The availability of illegal homemade or manufactured weapons makes the clashes deadlier.

People in these areas make a living from livestock, agriculture and fishing. These livelihoods are concentrated around rivers and streams that offer grazing, water and arable land. Climate change increases the competition for scarce resources, which, fueled by identity-based politics, leads to bloody conflicts.

Many communities live in the large cross-border areas shared by the four Lake Chad Basin countries - Cameroon, Chad, Niger and Nigeria. For example, the Kanuri, Shuwa Arabs and Boudouma can be found in all four countries, while the Kotoko and Musgum reside in Chad and Cameroon. The borders are extremely porous, especially when located on rivers or the lake.

On 11 August, the Shuwa Arab Musgum communities and clashed over land in El Birké canton in the Logone-Birni district. Twelve people died and 48 were seriously injured. Since then, more than 11,000 people from Cameroon have crossed the Logone River to seek safety in Chad's Ondouma and Ngama Kotoko areas.

Conflict zones in Cameroon's Far North Region

middle of the rainy season when extensive flooding makes it difficult to get emergency aid to the refugees. This is on top of the growing humanitarian needs caused by the protracted Boko Haram crisis.

In June, bloody conflicts over land pitted the Shuwa Arab against the Kotoko community in the Aboudangala canton, also located in Logone-Birni. Two people were killed and four seriously injured. In May, a dispute over access to water led to battles between the Kanuri and Chuwa Araba in Waza. One person died and four were wounded.

These communal tensions are not new. Clashes between the Kotoko and Musgum in Zina in 2007 left eight people dead and 60 wounded. Similarly, violence between the Shuwa Arabs and Kotoko in Kousseri in 1992 left 68 people dead and 395 wounded.

Almost all those involved in these conflicts live in Cameroon and Chad, and along the border between the two countries. The Shuwa Arab also live in parts of Borno State in Nigeria, and in Niger. During the latest August conflict, Institute for Security Studies research revealed an influx of people from various Chadian communities into the Cameroon conflict zone to join forces with their families. Porous borders in the area, especially rivers, make this movement easier.

There's a strong likelihood that these problems could worsen regionally. Security issues in the Lake Chad Basin often become regional because of the anthropological, historical and economic proximity of the people living in the area.

The circulation of firearms in the hands of former rebels, national army members and smugglers is nothing new because of the long-standing armed conflicts in Chad, Sudan, Libya, Nigeria and the Central African The attacks occurred in the Republic. But the increasing use

of guns in community clashes in this already volatile region requires urgent attention from Lake Chad Basin governments.

The Cameroonian authorities have already stepped up with the launch of a disarmament operation after the August violence in El Birké. This should be maintained and extended to the entire conflict zone and coordinated with other Lake Chad Basin countries to effectively 'silence the guns' in the region.

Finally, responses to the local rivalries should be reassessed. The reconciliation initiatives led by Cameroon's government, while attracting media attention, are unlikely to resolve the disputes. They consist of official meetings of community leaders under the aegis of higher authorities, and as such, remain merely protocol. A long-term approach is needed that addresses the nature of the conflicts and their historical and economic underpinnings.

Understanding the underlying causes of the clashes rather than their sporadic manifestations would help craft sustainable solutions. Transitional justice mechanisms are also worth exploring to address prosecutorial concerns, truth-seeking, reconciliation and healing of the affected communities. Investigating and prosecuting the alleged perpetrators of attacks and compensating the victims could help quell the thirst for intra- and inter-community reprisals.

The role of traditional authorities (village and community chiefs and religious leaders) and the means they use to manage resources and prevent and resolve conflict, must also be strengthened. Because of their social standing and their vital roles as guarantors of tradition, these leaders are best placed to organise reconciliation processes that their communities will trust and participate in. **DM**

"The knowledge and skills you have acquired are your most important ingredients to strengthening your banking carrier and financial service industry," Professor Luoga said, imploring the graduands to continually learn to widen their understanding.

He assured of the collective efforts of the central bank, licensed banks and financial institutions in building the capacity of TIOB as its members and guarantors remain a key contributor to the growing numbers of skilled professional bankers in the country.

RESIDENT Tayyip Erdogan's belief that a shock interest rate cut will stoke up Turkey's economy ahead of elections is instead likely to backfire as hot inflation and a lira selloff stall growth.

Sources close to the presidency told Reuters that Erdogan pushed the central bank for months - both publicly and privately - to deliver the monetary stimulus in order to boost lending, exports and jobs despite soaring inflation.

On Sept. 23, the bank delivered, unexpectedly lowering its policy rate by 100 basis points to 18% sending the lira currency to all-time lows.

Investors dumped Turkish bonds and said the move marked the latest blow https://www.reuters.com/ business/turkish-central-banksurprises-with-rate-cut-sought-byerdogan-2021-09-23 to the central bank's tattered credibility, given inflation had jumped above 19% amid global price pressures that leave emerging markets like Turkey uniquely vulnerable.

Consumer prices were up 19.6% in September from the same month last year, the biggest rate of increase in 2-1/2 years, data showed on Monday.

In interviews, several Turkish economists said the rate cut was a grave error that would likely sink Turks deeper into economic distress ahead of elections that must be held by mid-2023.

"The sense of gloom, the exchange rate, is exposing that economic governance is in shambles," said Refet Gurkaynak, chair of Bilkent University's economics department, in Ankara.

Yet Erdogan - sliding in opinion polls - had grown impatient for a rate cut after installing a new central bank chief earlier this year, and he was surprised that inflation had marched higher, two Turkish officials said.

Still, one official close to the presidency said the rate cut was worth it despite the risks and inevitable criticism.

"This decision was necessary to increase exports, to generate employment and to open the way for new investments," the person said, requesting anonymity. "There may be negative effects, but it had to be taken ... to achieve these benefits."

The president's office did not immediately comment on whether it pushed for the rate cut and why. The central bank declined to comment on whether Erdogan applied pressure.

Erdogan, a self-described enemy of interest rates, said on Friday that inflation will drop to single digits, but he did not address the interest rate cut.

His government has blamed supermarkets for unfair practices, while on Sunday Erdogan promised to open 1,000 new markets across the country to provide "suitable" prices for goods.

'FALSE ASSUMPTIONS'

The central bank said easing was needed since inflation is temporary and a core measure had dipped, and also since lending suffered after six months of the policy rate being held at 19% - among the highest in the world.

But Turkey's relatively low foreign reserves, heavy imports and a "real" inflation-adjusted interest rate becoming more negative are all red flags for the currency. Adding to the risks, lira depreciation drives inflation higher.

All this, combined with companies' high foreign debt, means that exports benefit little from rate cuts, while private banks would rather shrink wealth. than expand credit again, said Gurkaynak, a former U.S. Federal Reserve

Board economist.

"If the policy change is based on the belief it will help economic activity, there are false assumptions," he said.

Selva Demiralp, director of the Koc University-TUSIAD Economic Research Forum, said Turkey's "trial and error" policy is reckless given the Fed and other major central banks are moving to tighten policy to head off inflation, including the recent energy-price shock.

"The rest of the world correctly analysed the Fed's guidance ... but this decision will cause large damage to Turkey's economy," she said. Past Fed policy tightening cycles have pulled funds from Turkey and other emerging market economies. Benchmark debt yields jumped after the rate cut, signalling little faith that the central bank can lower inflation. Nevertheless, money market prices show traders expect more cuts before the policy rate returns to 18%-18.5% in a year.

SLIDING POLLS

After a currency crisis in 2018 and smaller selloffs, the lira has shed two-thirds of its value in five years, eating into the earnings of Turks who have also faced doubledigit inflation for most of that period.

This has alarmed Erdogan, whose conservative AK Party has ruled for 19 years on a reputation of strong economic growth and household

Polls show the party has 31%-33% support, down from 42.6% in 2018 elections. Its nationalist ally the MHP has also slipped, suggesting Erdogan would lose control of parliament in a vote.

Erdogan looms large over the central bank after firing its last three governors over policy differences. He turned up the heat in June when he said he spoke to Sahap Kavcioglu, the current chief, about the need for a rate cut after August.

Even as inflation jumped to 19.25% in August, Kavcioglu began giving dovish signals on Sept. 1 investor calls, Reuters reported, citing participants. He reinforced that in a speech on Sept. 8 that, according to a separate source, the bank hastily decided should be made public only the night before.

Another official with knowledge of the matter said Erdogan was told that a cut could come in July or August. When it didn't, "the president continued to have a serious expectation that rates should be lowered," the person said.

Erinc Yeldan, acting dean of Bilkent's economics faculty, said the AK Party is attempting to build a new economic growth story "whatever the cost" ahead of elections.

HE United States is making progress against the current surge of the COVID-19 pandemic, but the country is not out of the woods yet, the medical advisor to the White House Anthony Fauci told ABC on Sunday, two days after the national death toll of the coronavirus surpassed the grim milestone of 700,000.

"We certainly are turning the corner on this particular surge," said the nation's top infectious disease expert. "But we have experienced over now close to 20 months surges that go up and then come

In New York State, as of Thursday, 92 percent of its more than 625,000 healthcare workers were inoculated, up from the 73 percent on Aug. 16 when the Sept. 27 deadline was set for vaccinations, according to Governor Kathy Hochul.

Since former Governor Andrew Cuomo announced a vaccine mandate for New York healthcare workers more than a month ago, hospital employees in the state have been getting vaccinated at more than twice the rate as all New York adults, according to data provided by the state health department and the CDC.

The CDC released recommendations on Saturday for the upcoming holiday season, including the idea of using a window fan to keep air at an indoor party as fresh as possible.

A second prize is also awarded for Innovations that Empower Youth in Agriculture and Food Systems. The prize for each award is \$30,000, allowing winners to take their business to the next level.

This year's award for Digitalisation and Innovation for Sustainable Food Systems went to Ifarm360, a startup enabling investors to crowdfund smallholder farmers in Kenya. In addition to access to finance, Ifarm360 offers smallholder farmers crop advice and supervision, as well as farming inputs and equipment, such as solar irrigation kits. Ifarm360 connects smallholder farmers, the crowd investors and offtakers, creating a win-win business model.

Special mention was given to Enveritas for using digital technology and innovation to conduct sustainability verification of unorganised and underserved smallholder coffee farmers globally. The Innovations that Empower Youth in Agriculture and Food Systems award was split this year between two projects, both of which received equally high rankings from the Screening Committee.

Access Agriculture AISBL was recognised for enabling young people individually or as a team, to use solar-powered technology to show farmer-to-farmer training videos in local languages in remote villages with no electricity, no internet access and poor mobile signal. Access Agriculture is working with local communities across the Global South, while also improving the environment using agroecological principles.

Access Agriculture shared the prize with Bountifield International, which offers young people in rural areas new opportunities as postharvest technology entrepreneurs providing a fee-for-service to farmers to process, preserve and sell their crops. Bountifield's 'business in a box' model equips them with needed technology, access to financing and information they need to drive agribusiness value addition, to reduce food loss, and to increase growth across rural Africa.

QU Dongyu congratulated the winners, adding that the award "highlights the importance of innovation and youth as key drivers to transform agri-food systems. FAO is working to engaging and empowering youth to transform our agri-food systems."

"I wish to convey my appreciation to the Government of Switzerland for the effective partnership which has led to this successful outcome. It also affirms the value of our shared goal - to encourage game-changing solutions by innovative approaches and people," he said.

Christian Hofer, director-general of the Swiss Federal Office for Agriculture, said, "The Swiss-FAO International Innovation Award aims at honouring already existing projects that proved to be successful and have a potential to scale up or spill over to other parts of the food systems. Taha, UNDP link smallholder ginger farmers from Same to Ukrainian supermarket chain

SMALLHOLDER ginger farmers in Same district of Kilimanjaro region are making millions of shillings in windfall profits from exporting the commodity to a Ukrainian based company thanks to support from Taha Group and UNDP.

Through a local company called Akida Group Limited which is a subsidiary of Ukraine based ATB Market LLC, the farmers have recently sold 22 metric tons of ginger earning 18m/- in payment for their commodity which is then shipped to European supermarkets.

"We are making inroads in the ginger farming in Same district, where, to start with, we have purchased a total of 22 metric tons from Mamba Miamba village for export to Ukraine," said Akida Group's official, Dr Promise Isaac.

ATB Market LLC is one of the leading retail trading companies in Ukraine with over 1,500 supermarkets. Dr Isaac said currently, his company needs two fully loaded containers of ginger with an overall weight of 29 metric tons every week.

Headwinds mount for the global economy into year's final stretch

HONG KONG

THE global economy is entering the final quarter of 2021 with a mounting number of headwinds threatening to slow the recovery from the pandemic recession and prove policy makers' benign views on inflation wrong.

The spreading delta variant continues to disrupt schools and workplaces. US lawmakers are wrangling over the debt ceiling and spending plans. China is suffering an energy crunch and pursuing a regulatory crackdown, while markets remain on edge as China Evergrande Group struggles to survive. Fuel and food costs are soaring worldwide, combining with congested ports and strained supply chains to elevate price pressures. Labour shortages continue to plague some employers.

Although the expansion seems intact, such a backdrop is fanning fears of a mix of weaker growth and faster inflation to come, threatening to complicate nascent efforts by central banks to dial back stimulus without rattling markets.

"Expectations of a swift exit from the pandemic were always misplaced," said Frederic Neumann, co-head of Asian economic research at HSBC Holdings Plc in Hong Kong. "Full recovery will be measured in years, not quarters." Economists at Barclays Bank Plc warned of "gusts of headwinds that could eventually take their toll on activity."

Here's a breakdown of the major risks: China crunched

China's energy travails have forced manufacturers to curb production and prompted economists to cut their growth forecasts. Bloomberg Economics expects the power shortages to have the biggest hit to expansion since a nationwide lockdown when the pandemic first erupted.

Regions impacted by the curbs represent about two-thirds of the economy and include the top five provinces in terms of gross domestic product -- Guangdong, Jiangsu, Shandong, Zhejiang and Henan. In a sign of what's to come, factory activity contracted in September for the first time since the pandemic began.

That's compounding a drag from the crisis engulfing Evergrande, the world's most indebted developer, and a broader slowdown in the all-important housing sector. President Xi Jinping's push for tighter regulations of industries including technology is also unnerving investors.

Costlier food and energy

The price of oil passed \$80 a barrel for the first time in three years and natural gas is the costliest in seven, helping to push the Bloomberg Commodity Spot Index to its highest level in a year. TotalEnergies SE Chief Executive Officer Patrick Pouyanne said the gas crisis that's affecting Europe is likely to last all winter. It could get even worse. Bank of America analysts are telling clients there is a chance of oil reaching \$100, spurring an economic crisis.

PANDORA PAPERS: Leaked records reveal financial secrets of world leaders and politicians

THE secret deals and hidden assets of some of the world's richest and most powerful people have been revealed in the biggest trove of leaked offshore data in history.

Branded the Pandora papers, the cache includes 11.9m files from companies hired by wealthy clients to create offshore structures and trusts in tax havens such as Panama, Dubai, Monaco, Switzerland and the Cayman Islands.

They expose the secret offshore affairs of 35 world leaders, including current and former presidents, prime ministers and heads of state. They also shine a light on the secret finances of more than 300 other public officials such as government ministers, judges, mayors and military generals in more than 90 countries.

The files include disclosures about major donors to the Conservative party, raising difficult questions for Boris Johnson as his party meets for its annual conference.

More than 100 billionaires feature in the leaked data, as well as celebrities, rock stars and business leaders. Many use shell companies to hold luxury items such as property and yachts, as well as incognito bank accounts. There is even art ranging from looted Cambodian antiquities to paintings by Picasso and murals by Banksy.

The Pandora papers reveal the inner workings of what is a shadow financial world, providing a rare window into the hidden operations of a global offshore economy that enables some of the world's richest people to hide their wealth and in some cases pay little or no tax.

There are emails, memos, incorporation records, share certificates, compliance reports and complex diagrams showing labyrinthine corporate structures. Often, they allow the true owners of opaque shell companies to be identified for the first time.

political leaders in the world.

They include the ruler of Jordan, King Abdullah II, who, leaked documents reveal, has amassed a secret \$100m property empire spanning Malibu, Washington and London. The king declined to answer specific questions but said there would be nothing improper about him owning properties via offshore companies. Jordan appeared to have blocked the ICIJ website on Sunday, hours before the Pandora papers launched.

The files also show that Azerbaijan's ruling Aliyev family has traded close to £400m of UK property in recent years. One of their properties was sold to the Queen's crown estate, which is now looking into how it came to pay £67m to a company that operated as a front for the family that runs a country routinely accused of corruption. The Aliyevs declined to comment.

The Pandora papers also threaten to cause political upsets for two European Union leaders. The prime minister of the Czech republic, Andrej Babiš, who is up for election this week, is facing questions over why he used an offshore investment company to acquire a \$22m chateau in the south of France. He too declined to comment.

And in Cyprus, itself a controversial offshore centre, the president, Nicos Anastasiades, may be asked to explain why a law firm he founded was accused of hiding the assets of a controversial Russian billionaire behind fake company owners. The firm denies any wrongdoing, while the Cypriot president says he ceased having an active role in its affairs after becoming leader of the opposition in 1997.

Not everyone named in the Pandora papers is accused of wrongdoing. The leaked files reveals that Tony and Cherie Blair

The Russian president, Vladimir Putin, whom the US suspects of having a secret fortune, does not appear in the files by name. But numerous close associates do, including his best friend from childhood - the late Petr Kolbin - whom critics have called a "wallet" for Putin's own wealth, and a woman the Russian leader was allegedly once romantically involved with. None responded to invitations to comment.

The Pandora papers also place a revealing spotlight on the offshore system itself. In a development likely to prove embarrassing for the US president, Joe Biden, who has pledged to lead efforts internationally to bring transparency to the global financial system, the US emerges from the leak as a leading tax haven. The files suggest the state of South Dakota, in particular, is sheltering billions of dollars in wealth linked to individuals previously accused of serious financial crimes.

The offshore trail also stretches from Africa to Latin America to Asia, and is likely to pose difficult questions for politicians across the world. In Pakistan, Moonis Elahi, a prominent minister in prime minister Imran Khan's government, contacted an offshore provider in Singapore about investing \$33.7m.

In Kenya, the president, Uhuru Kenyatta, has portrayed himself as an enemy of corruption. In 2018, Kenyatta told the BBC: "Every public servant's assets must be declared publicly so that people can question and ask: what is legitimate?'

He will come under pressure to explain why he and his close relatives amassed more than \$30m of offshore wealth, including property in London. Kenyatta did not respond to enquiries about whether his family wealth was declared to relevant authorities in Kenya.

The Pandora papers also reveal some of the unseen repercussions of previous offshore leaks, which spurred modest reforms Pamela Duncan in London; Ben Butin some parts of the world, such as the BVI, which now keeps a record of the real owners of companies registered there. However, the newly leaked data shows money shifting around offshore destinations, as wealthy clients and their advisers adjust to new realities. Some clients of Mossack Fonseca, the now defunct law firm at the heart of the 2016 Panama papers disclosures, simply transferred their companies to rival providers such as another global trust and corporate administrator with a major office in London, whose data is in the new trove of leaked files. Asked why he was migrating the new company, one customer wrote bluntly: "Business decision to exit following the Panama papers." Another agent said the industry had always "adapted" to external pressure. Some leaked files appear to show some in the industry seeking to circumvent new privacy regulations. One Swiss lawyer refused to email the names of his high-value customers to a service provider in the BVI, following new legislation. Instead, he sent them by airmail, with strict instructions they should not be processed in any "electronic way". The identity of another beneficial owner was shared via WhatsApp. "The purpose of this way to proceed is to enable you to comply with BVI rules," comment and it is unclear if he remains a the lawyer wrote. Referring to Mossack

Fonseca, the lawyer added: "You are obliged to keep secrecy for our clients and to not make feasible at all a second 'Panama papers' story that happened to one of your competitors.'

Gerard Ryle, the director of the ICIJ, said leading politicians who organised their finances in tax havens had a stake in the status quo, and were likely to be an obstacle to reform of the offshore economy. "When you have world leaders, when you have politicians, when you have public officials, all using the secrecy and all using this world, then I don't think we're going to see an end to it.'

He expected the Pandora papers to have a greater impact than previous leaks, not least because they were arriving in the middle of a pandemic that had exacerbated inequalities and forced governments to borrow unprecedented amounts to be shouldered by ordinary taxpayers. "This is the Panama papers on steroids," Ryle said. "It's broader, richer and has more detail."

At least \$11.3tn in wealth is held offshore, according to a 2020 study by the Paris-based Organisation for Economic Co-operation and Development (OECD). "This is money that is being lost to treasuries around the world and money that could be used to recover from Covid," Ryle said. "We're losing out because some people are gaining. It's as simple as that. It's a very simple transaction that's going on here.'

Ethiopian leader secures new mandate as conflict rages on

ETHIOPIA'S new parliament reappointed Abiy Ahmed as prime minister yesterday following his party's landslide election



win, giving him a five-year mandate to tackle the fallout of a civil war that's triggered an economic and humanitarian crisis.

Abiy (pictured), who first assumed his post in 2018, initially won investor acclaim for opening up the insular economy and a Nobel Peace Prize for ending a long-running conflict with neighboring Eritrea.

He's fallen from grace since ordering a federal troop incursion into the dissident Tigray province after forces loyal to the northern region's leaders attacked an army base. Fighting has dragged on for 11 months, leaving thousands dead and 5 million in need of aid.

Fostering peace and national unity will be among the new administration's top priorities. Abiy intends to convene a national dialog to bring political parties together, although it's unclear whether it will include his main foes - the Tigray People's Liberation Front and the Oromo Liberation Army.

Abiy was assured of retaining his post after his Prosperity Party secured an outright majority in the House of People's Representatives in the August elections. The vote was postponed to Sept 30 in some of the 547 constituencies due to security concerns and logistical problems and results from those regions have yet to be announced, but they won't affect the final outcome.

Besides having to bring an end to the war, the new administration needs to contain rampant inflation and finalize a program to restructure some of the nation's almost \$30 billion foreign debt under the so-called G20's Common Framework. That plan, which was first announced in January, spooked investors, with yields on Ethiopia's 2024 Eurobond reaching record highs this month.

It will also need to renegotiate a new program with the International Monetary Fund to replace an extended credit facility, which had been agreed but lapsed before the money was disbursed. In September, the Washingtonbased lender said it was "too soon" to engage with Ethiopia over new programs.

Abiy's attempts to secure external funding could be complicated by threats by US President Joe Biden's administration to impose sanctions on individuals and entities involved in the conflict.

The files were leaked to the International Consortium of Investigative Journalists (ICII) in Washington. It shared access to the leaked data with select media partners including the Guardian, BBC Panorama, Le Monde and the Washington Post. More than 600 journalists have sifted through the files as part of a massive global investigation.

The Pandora papers represent the latest - and largest in terms of data volume - in a series of major leaks of financial data that have convulsed the offshore world since 2013.

Setting up or benefiting from offshore entities is not itself illegal, and in some cases people may have legitimate reasons, such as security, for doing so. But the secrecy offered by tax havens has at times proven attractive to tax evaders, fraudsters and money launderers, some of whom are exposed in the files.

Other wealthy individuals and companies stash their assets offshore to avoid paying tax elsewhere, a legal activity estimated to cost governments billions in lost revenues.

After more than 18 months analysing the data in the public interest, the Guardian and other media outlets will publish their findings over the coming days, beginning with revelations about the offshore financial affairs of some of the most powerful saved £312,000 in property taxes when they purchased a London building partially owned by the family of a prominent Bahraini minister.

The former prime minister and his wife bought the £6.5m office in Marylebone by acquiring a British Virgin Islands (BVI) offshore company. While the move was not illegal, and there is no evidence the Blairs proactively sought to avoid property taxes, the deal highlights a loophole that has enabled wealthy property owners not to pay a tax that is commonplace for ordinary Britons.

Water supply project in south China's Guangdong province important guarantee of stable supply of fresh water to Hong Kong

THE Dongjiang-Shenzhen Water Supply Project, which stretches from Qiaotou township, Dongguan city, south China's Guangdong province, all the way south to the Shenzhen Reservoir in Shenzhen city of the province, has greatly guaranteed a safe and stable supply of fresh water for the daily life and production of about 24 million residents in Dongguan, Shenzhen, as well as Hong Kong.

The project transfers water from Dongjiang River, which originates in east China's Jiangxi province and flows to the Pearl River Delta in Guangdong, to the three cities.

The original main route of the

project was 83 kilometers long and was then shortened to 68 kilometers after enclosed transformation in 2000.

Put into operation on March 1, 1965, the project had supplied Hong Kong with 26.7 billion cubic meters of water as of the end of last year.

Such a remarkable result wouldn't have been realized without the efforts of tens of thousands of construction workers in the project. They have borne in mind their mission, toiled away during the construction, and selflessly devoted themselves to the project, contributing to safer wa-

ter supply for Hong Kong.

Hong Kong is surrounded by the sea on three sides, and suffered from serious shortage of fresh water resources.

In 1963, Hong Kong was struck by a severe drought unseen in a century, and had to control water supply for residents. During the most difficult period, the region supplied water to residents once every four days and four hours each time. At that time, the life of several million Hong Kong people was in a plight.

After the Chinese General Chamber of Commerce (CGCC) in Hong Kong and the Hong

Kong Federation of Trade Unions (HKFTU) asked the government of Guangdong province for help, Zhou Enlai, then Premier of China, approved a fiscal fund of 38 million yuan (\$5.86 million) for the Dongjiang-Shenzhen Water Supply Project at the end of 1963, in a bid to draw the water of Dongjiang River to quench the thirst in Hong Kong.

To tackle Hong Kong's water issues at the root, Guangdong came up with a bold idea of channeling the water of Dongjiang River from Qiaotou township through the riverway of the Shima River to the Shenzhen Reservoir, and eventu-

ally to Hong Kong via steel pipes.

The plan was in fact quite challenging, considering the technologies at that time. To use the riverway of the Shima River, which flows from the Danaoke Mountain in Shenzhen towards the opposite direction of that of the main route of the project, water levels at the upstream part of the project must be lifted by 46 meters, so that the diverted fresh water could then flow 86 kilometers to the Shenzhen Reservoir.

On Feb. 20, 1964, the water supply project kicked off. During the peak construction period, over 20,000 construction workers

worked on the front line of the project.

As the construction advanced during the flood season, builders had to stay five to ten meters below the surface of the water for many foundation works, and sometimes were faced with inclement weather like rainstorms and typhoons.

On Oct. 13, 1964, a college student named Luo Jiaqiang lost his life when he persisted in his work at an over-seven-meter-high pier at a construction site in stormy weather.

Russia, US discuss mutual recognition of vaccination certificates

GENEVA

RUSSIA and the US discussed the issue of the mutual recognition of COVID-19 vaccination certificates in Geneva on Saturday. American representatives "heard Russia's arguments," Russian Health Minister Mikhail Murashko told journalists at a briefing following talks.

"They heard the arguments, they realize that this is rational because the approval of a vaccine to be sold on the market and the approval of a jab for the prevention of the COVID-19 disease directly are different processes," the health minister noted.

"I think that [our] colleagues are very competent, informed, and they will evaluate our remarks, and we will return to this conversation," the health minister stated.

The health minister specified that he is talking about "the recognition of certificates, not vaccines, as well as about the effectiveness of preventive measures."

The Washington Post reported earlier that in November the US authorities may not permit entry for those foreigners who were inoculated with the Russian Sputnik V vaccine against coronavirus.

According to the newspaper, in order to enter the US, foreign citizens will have to be inoculated with vaccines approved by the US or the WHO.

Starting in November, foreign citizens entering the US will be required to show proof of complete vaccination against COVID-19, White House COVID-19 Response Coordinator Jeff Zients reported earlier.

According to him, a proof of vaccination should be presented upon boarding a plane to the US. Additionally, those foreign citizens wishing to visit the US should provide negative test results for the presence of COVID-19 obtained no earlier than three days prior to traveling. **Xinhua**

Indian farmers to step up protests after 8 killed in clashes

NEW DELHI

FARMERS in India vowed yesterday to intensify their months-long protests against laws aimed at liberalizing agriculture as tension flared a day after eight people were killed in clashes between growers and ruling party supporters.

Four of the eight were killed when a car linked to a senior ruling party official crashed into protesters in Uttar Pradesh state, protest leaders said.

Police said they were investigating the crash and had registered a case against 13 people including a son of a minister of state in the interior ministry, Ajay Kumar Mishra.

An alliance of protest groups called in a petition to President Ram Nath Kovind on Monday for a courtsupervised investigation of the violence.

"We'll intensify our agitation in Uttar Pradesh and other parts of the country to highlight the plight of innocent farmers," Dharmendra Malik, a senior leader of the Bharatiya Kisan Union, told Reuters.

"The government might try to discredit the 10-month-long movement, but we will remain peace-ful in our struggle," Malik said.

We're signing many new cooperation agreements with customers and partners," said Steven Lien, president of Honeywell China and Aerospace Asia Pacific. China is the U.S. aerospace giant's second-biggest market.

"The wider opening up of China and its economic vitality will enable us to do even more of what we've been doing for the past decades here, and we are sure to continue to accelerate," Lien added.

NEVER-ENDING PURSUIT

Exploring the sky and universe has been a never-ending dream of the nation.

Thanks to the unremitting efforts in the space exploration and aviation sector, the dream has gradually come true. At the airshow, a long queue lined up at the booth of the China National Space Administration (CNSA). Lunar soil, together with the Chang'e-5 re-entry capsule and the sealed container that brought the lunar soil back to Earth, attracted thousands of visitors every day.

"The booth has been a super popular spot since the opening of the airshow as countless introductions were given every day. Kids and teenagers are so excited to see what's on the moon," said a guide. The Mars exploration mission is also a carrier of this Chinese dream. On May 22, China's first Mars rover Zhurong drove down a ladder and landed on the surface of Mars, making China the second country after the United States to operate a rover on the red planet.

Zhurong's small steps on the red planet marked a huge leap for China's deep space exploration.

According to Wu Yanhua, deputy director of the CNSA, China has operated 152 launch missions, sending 341 spacecraft into orbit, and signed 44 space cooperation documents with 14 countries and two international organizations over the past five years.

India's longest-running farm protests pose a risk for the re-election prospects of Modi's Bharatiya Janata Party when Uttar Pradesh, India's most populous state, goes to the polls early next year.

Since Sunday, several opposition politicians have tried to reach the Lakhimpur Kheri sugar cane-growing district where the violence took place.

"For many months, farmers have been speaking out, saying that they are being wronged but the government is not willing to listen," said Congress party leader Priyanka Gandhi Vadra.

I then saw Salum feature for the national team in a qualifier tie against Madagascar at home. I have seen him when he featured for Yanga against Zanaco FC in a friendly, which was a culmination of the 'Wananchi Day'.

I have moreover seen him play for Yanga in this season's CAF Champions League's preliminary round clash against Rivers United FC of Nigeria.

I also saw Salum play for Yanga in a Community Shield clash against Simba SC, before playing for Yanga in a 2021/22 Premier League clash against Kagera Sugar, in which he scored.

He is a good player but he assisted just one goal in all six matches and an assist that produced a goal against Zanaco FC.

Salum scored just one goal in a game against Madagascar, an average of one goal in six matches and his credentials are two different things.

The player who plays behind the striker should have the numbers to carry, One should expect to see him with at least 10 goals per season. One has to see him score goals from seven

to 10 per season.

These numbers were last seen in the Mainland Premier League, having been posted by Iddi Suleiman at Azam FC, Clatous Chama, and Luis Miquissone that were by then playing for Simba.

THIS year's National Open Boxing Club Championship starts at Dar Live Hall in Temeke District today, Tanzania Open Boxing Federation (OBFT) disclosed.

Lukelo Wililo, OBFT secretarygeneral, said the showdown will involve 12 outfits from various regions.

The outfits are JKT Mgulani, MMJKT, JKT Mbweni, Ngome JWTZ, Band Coy, Iringa Boxing Club, Mwanza Boxing Club, Morogoro, and Singida boxing clubs, Arusha Boxing Club, Black Eagle, and Magereza.

Tanzanite Manyara is the tournament's defending champion, but the OBFT leader stopped short of disclosing if the club will attend the event, which is expected to end on Saturday.

He said Temeke Member of Parliament, Dorothy Kilave, is expected to be the guest of honour at the showdown's opening.

The National Open Boxing Club Championship will be used to select four boxers to represent Tanzania in the International Boxing Association (AIBA) World Boxing Championship for Men slated for October 26-November 6 in Belgrade, Serbia.

Currently, Tanzania so far has two boxers Alex Isendi and Yusuph Changarawe that have qualified for the world championship.

"The National Open Boxing Club Championship will take place tomorrow at Dar Live Hall in Temeke, the championship will also be used to select four boxers who will join the two boxers, who qualified for AIBA Championship which will be held in Serbia," the OBFT leader revealed.

"We have eight boxers who are top-ranked so the qualifying events' trials will be among them, the best will be selected for the AIBA World Boxing Championship," he said.

The OBFT had failed to send boxers to the past AIBA World Championship editions due to financial constraints the federation faces.

Wililo said this time he is confident that the boxers will travel to the event as the government announced its commitment to promoting sports.

The OBFT official pointed out: "We thank the government for its commitment to see that sports make progress in the country and also its commitment that it will fund national teams which have foreign assignments." "We know we will benefit from this funding and the other good thing is that boxing is among the five sporting disciplines which the government will support in its first phase of a sports development initiative," he said.

The last time the AIBA World Championship took place was in 2019 in Ekaterinburg, Russia, but OBFT failed to send pugilists to the championship.

Seleman Kindunda is the last boxer to have represented the country at the AIBA World Boxing Championship, he competed at the 2013 event in Almaty, Kazakhstan.

The Serbia event will be overseen by Serbia's President, Alexander Vucic, who heads the Local Organizing Committee (LOC).

AIBA president Omar Kremlev is reported to have said the AIBA Men's World Boxing Championship will show determination to provide boxers around the world a platform to achieve their full potential.

"We are confident that the tournament will be conducted safely given the successful implementation of COVID-19 countermeasures throughout the year," he said.

Clinical Salah shows Man City what they are missing

LONDON

TWO moments of magic from Mohamed Salah ensured Liverpool remain the only unbeaten side left in the Premier League this season after an enthralling 2-2 draw with Manchester City on Sunday.

For 45 minutes City's collective brilliance threatened to blow the Reds away and inflict a first league defeat at Anfield in front of supporters since 2017.

However, for all the beautiful football put together by Pep Guardiola's array of creative midfielders, the English champions cannot call on a clinical finisher in the same league as Salah.

The Egyptian showed the other side to his game in creating Liverpool's opening goal for Sadio Mane with a perfectly-weighted pass after skipping beyond Joao Cancelo.

But it was his finish for his side's second that will live long in the memory.

Cancelo was this time one of four City defenders left trailing as Salah shrugged off the attentions of Phil Foden and Bernardo Silva before turning Aymeric Laporte and firing high past Ederson on his weaker right foot.

"Only the best players in the world score goals like this," said Liverpool manager Jurgen Klopp. "Absolutely exceptional.

"Because this club never forgets anything, people will still talk about this goal in 50-60 years when they remember this game."

Salah has now scored in seven consecutive games and has nine in as many matches this season, evoking memories of his sensational 44-goal debut season at Anfield in 2017/18.

"Right now he is as sharp and as good as I've seen him," former Liverpool defender Jamie Carragher told Sky Sports.

"I don't see anyone playing better in the world at this moment in time. His record and his start to this season

has been absolutely outstanding." Liverpool will need their main man to maintain those standards if they are to take the title back from City.

Eight days on from schooling Chelsea on their own patch, Guardiola's men also had Liverpool chasing shadows for the first-half.

However, not for the first time this season, City did not make their dominance show on the scoreboard without a natural striker as chances came and went for Foden and De Bruyne.

Both midfielders made amends to equalise in the second-half and keep the early running for the title race tantalisingly poised.

Chelsea top the table by a point from Liverpool with City and Manchester United just one point further back after seven games.

Liverpool were the only one of the four realistic title contenders who did not spend over £100 million (\$135 million) in the transfer window.

Ibrahima Konate's arrival for £36 million was the Reds' only summer signing and they may lack the depth of squad over the long haul, particularly with Salah and Mane set to depart for up to a month for the Africa Cup of Nations early next year.

Instead, Liverpool have invested heavily over the past two years in tying down their key players to longterm contracts with one notable exception.

Jordan Henderson, Trent Alexander-Arnold, Andy Robertson, Alisson Becker, Virgil van Dijk and Fabinho are among those to commit their future to the club.

Salah's current deal is set to expire in 2023 and the 29-year-old knows his worth to Klopp's men as negotiations over a new deal have dragged

Liverpool will have to splash out to get Salah to extend his stay, but on this form he is worth it as the man who could win them the league.

Liverpool-Man City rivalry one of the Premier League's best

LIVERPOOL, England

THERE are more backslaps and hugs between players than flying pizzas and tunnel bust-ups when Liverpool take on Manchester City, but while this fixture lacks the animosity and belligerence of old Manchester United-Arsenal clashes, the sheer quality displayed during Sunday's 2-2 draw at Anfield showed that the rivalry is as intense as when Sir Alex Ferguson and Arsene Wenger's greatest teams locked horns two decades ago. For many, nothing will ever match

the sense of occasion and needle that accompanied the majority of those United-Arsenal encounters between 1998 and 2004, when the two clubs won seven Premier League titles between them.

But nostalgia has a habit of making everything seem as though it was better in the past, instantly dismissing whatever the present day can offer as a poor imitation.

And while those games of yesteryear evoke memories of great goals and moments by legendary players such as Thierry Henry, Wayne Rooney, Ruud van Nistelrooy, Patrick Vieira and Roy Keane, Liverpool and City's recent history has its own back catalogue of unforgettable contributions, which were added to at Anfield when Sadio Mane, Mohamed Salah, Phil Foden and Kevin De Bruyne scored sensational goals.

The effort of Salah, in particular, was up there with the greatest the league has seen. With his back to goal, the Egypt international received the ball just outside the City penalty area, before escaping the attention of several defenders and turning Aymeric Laporte to fire past Ederson from a narrow angle.

"Only the best players in the world score goals like this," Liverpool manager Jurgen Klopp said. "It was the first touch, the first challenge he wins, then going round and putting it on his right foot, finishing the move as he did. Absolutely exceptional."

The goal restored Liverpool's lead after Foden's tidy finish had cancelled out Mane's opener, created by another Salah run. Anfield was alive as home fans sensed another win against the champions, but De Bruyne's finish from a fast City break earned Pep

lations Liverpool and their players. That's why the last years both teams were fighting to win the Premier League."

The quality on display at both ends of the pitch went beyond the four second-half goals. In the Liverpool goal, for example, Alisson Becker produced the kind of saves that Peter Schmeichel and David Seaman once pulled off for United and Arsenal respectively.

Meanwhile, Rodri's late block denied what looked certain to a Fabinho winner for Liverpool; it was a fitting moment to cap a personal duel that showed that, while the game's evolution has taken away physical confrontations that defined the battles of Keane and Vieira, there is still room for tough-tackling and cynical challenges in any modern rivalry.

Yes, Liverpool and City have yet to degenerate into the post-match buffet being thrown among rival players, as happened when United beat Arsenal at Old Trafford in 2004. And, true, Klopp and Guardiola embraced at the end of this game as opposed to offering cursory handshakes a la Ferguson and Wenger, but this game has become the fixture that stops clocks in the Premier League.

It is the first to do so over a sustained period for some time. The Manchester clubs' rivalry, sparked by Sheikh Mansour's 2008 takeover at City, has subsided with City's dominance since Ferguson's retirement in 2013, but Guardiola's team has been trading blows with Klopp's Liverpool for four intense years.

Since the start of the 2017-18 season,

time, with four draws. Moreover, the occasions have always been vital.

There was Liverpool's epic 4-3 league win at Anfield in January 2018, which was followed by a seismic Champions League quarterfinal triumph for Klopp's men three months later. City, for their part, have collected 5-0 and 4-0 successes en route to winning three of the last four English titles; Liverpool won the other.

The two sides have been inches apart for many years. In 2018-19, when a John Stones clearance was pivotal in a vital City win when the sides met, Liverpool amassed 97 points and finished second, one point behind Guardiola and Co.

And Liverpool, while pressed back for much of the game, showed their razor-sharp cutting edge when scoring through Mane and Salah.

When history judges this era, it will be measured in terms of trophies won. City have claimed everything domestically under Guardiola -- several times over -- while Klopp has made Liverpool champions of England, Europe and the world.

Man Utd legend Park: Stop singing my song SEOUL

FORMER Manchester United and South Korea midfielder Park Ji-Sung has asked supporters to stop singing a song about him that contains a negative stereotype about his homeland.

Park, who spent seven years at Old Trafford between 2005 and 2012, says the song is insulting because it suggests Korean people eat dog meat.

The words also include a derogatory reference to people from Liverpool and was sung from the stands during United's 1-1 draw with Everton on Saturday. "That particular word [dog meat] is very discomforting for Korean people, and I really feel very sorry for the younger players who heard that kind of song," Park said in an interview for the UTD Podcast.

"In Korea, things have changed a lot. It is true that historically we have eaten dog meat, but these days, particularly the younger generation, they really hate it. The culture has changed. "I really request the fans to stop singing that word. It causes discomfort to Korean people when they hear that song. It's time to stop."

Park won four Premier League titles during his time at United and was capped more than 100 times by South Korea before retiring in 2014. He says he has been keen to speak out about the song after hearing it sung by United fans at Molineux in August when Wolves unveiled summer signing Hwang Hee-chan.

Euro kings Italy welcome big hitters to Nations League Final Four

MILAN

ITALY face their first true test since winning Euro 2020 this week when Roberto Mancini's side host the Final Four of the Nations League with three of Europe's best ready to pounce.

The Azzurri face Spain in the first semi-final on Wednesday, with the San Siro awaiting a repeat of the Euro last-four clash with Luis Enrique's side which ended with a penalty shoot-out victory for Italy.

The other semi-final, on Thursday, features world champions France and Belgium, ranked the planet's best side despite also being eliminated from the summer's European Championship by the Italians.

Italy have been on a high after beginning a memorable summer of sport for the Mediterranean nation by beating England in the Wembley final of the Euro.

Mancini has largely stuck with the heroes of that tournament for the Final Four, initially picking 22 of the Euro squad and adding in-form Roma midfielder Lorenzo Pellgrini.

He has since been forced to drop starting striker Ciro Immobile who has picked up a thigh injury and has drafted in Juventus striker Moise Kean, who shone in Italy's last match, a 5-0 hammering of Lithuania during last month's 2022 World Cup qualifiers.

Rafael Toloi of Atalanta is also out injured with AC Milan's Davide Calabria called up.

France go into the tournament still smarting from their last-16 exit at the hands of Switzerland in the Euro and underwhelming performances in last month's World Cup qualifiers.

Their 2-0 World Cup qualifying win over Finland last month was their first victory after a run of five draws, not what is expected of a team packed with some of the world's best players. Coach Didier Deschamps will be
