Presidential election: Six parties face cash crunch

By Guardian Reporters

SIX opposition presidential candidates face a dilemma of whether to pursue their bids for the October 28 general election due to intense financial hurdles.

With a solid month remaining ahead of polling day, candidates said the campaign trail is thorny and potholed, disabling them to reach voters in all 26 regions countrywide.

The National Electoral Commission (NEC) set August 16 for political parties start campaigning for the presidency along with parliamentary and councillorship seats, up to October 27.

In separate interviews, the candidates said that as of yesterday they have only been able to cover a few regions in the Mainland and

United People's Democratic Party (UPDP) candidate Twalib Kadege said: "We have so far completed the first 30 days of campaigning. I am not sure of being able to conduct campaign rallies in all the regions. These activities require a lot of funds, but our party doesn't receive government subsidy. It is only members' contributions that keep it going."

The decision was reached by the content committee over what was aired by the radio station, which it considered to have violated pertinent provisions in stipulated regulations.

7,000 villagers in Kaliua and Uyui districts benefit from ten water projects

MORE than 7,000 villagers in Kaliua and Uyui districts, Tabora Region have benefitted from water projects which included construction of bore holes in more than 10 villages.

Speaking to officials from the Ministry of Water who were in a tour to assess the project implementation, villagers acknowledged government for establishing the Rural Water Supply and Sanitation Agency (RUWASA) for up-taking water projects in rural areas.

Katuga Mohamed, a resident of Kazana-Upate village at Igagala ward in Kaliua District, said the project had benefited more than 2,000 people in the village.

He added that reliable accessibility of clean and safe water had resulted into more villagers concentrating in income generating activities whereas previously they were spending too many hours in search of the precious

He said the villagers are now engaging on activities such as livestock keeping, farming and construction of houses.

Kazana-Upate village committee chairman, Sadick Abeid noted that the project had facilitated water availability to more than 5,000 people in seven villages within Igagala and Kamsekwa wards.

He said availability of clean and safe water would also protect the villagers from waterborne diseases.

Mrisho Bakari, a resident of Ideka village at Mabama ward in Uyui District said that previously they were drinking unsafe water from shallow wells.

"More women are now engaging in income generating activities; some of them had established food kiosks and shops. They are no longer walking long distances in search of water", he

Tabora Rural Urban Water Supply and Sanitation Agency (RUWASA) regional manager, Eng Kapufi Hatari said that in the 2019/2020 financial year, a total of 33 water projects worth 960m/- were undertaken, adding that 28 out of them had been completed.

He added that the agency plans to implement more projects including construction of water dams in remote areas. He said the dams are likely to help the villagers to improve their welfare as well as having reliable water sources for their cattle.

Assistant director in the Ministry of Water (Policy and Planning), Teddy Mwaijumba applauded RUWASA and the Tabora Urban Water Supply and Sanitation Authority (TUWASA) for improving water availability in the

She said the projects had been implemented at required standards and that there is value for money. She said all the completed projects had been executed in accordance with the

provided guidelines. Mwaijumba commended authorities from the Lake Tanganyika Basin Water Board for their involvement in identifying and conserving water sources in Tabora.

According to her, the government intends to end water woes in all the districts within Tabora Region calling upon the villagers and stakeholders to cooperate in protecting the infrastructures.

CLIMATE change that had contributed to the increase of rains in Dodoma Region this year is among the reasons for the drop of the region's grapes production this season.

At the weekend a reporter visited areas with grapes farms in Mpunguzi, Mbabala and Hombolo wards and witnessed insignificant grape production compared to previous seasons and farmers said this year production was not good and the harvests had all been sold away even before the end of the season.

"This year the harvest was insignificant due to too much rains, the seedlings were destroyed before flowering, whilst other did not bear the fruit at all, said Maneno Joseph, a grape farmer.

wait for a long period of time to collect the Kusasya admitted the drop of grapes harvests required quantity.

Zawadi Manzije, a grapes buyer said: "Customers know that the grapes are grown here and sold cheaply, hence if one is compelled to buy at 1,000/- or even 2,000/compared to the past price which was between 300/- and 500/- only."

Archard Kato, owner of Alko Vintages wine factory said the demand for grapes had been great despite low production from farmers, and added that wine factory owners have been greatly affected as well.

Government already adopted electronic budget preparation, presentation system - ministry

THE government has fully adopted electronic budget preparation and presentation system, directing all the public and statutory organisations to use it in the 2021/2022 financial year.

The system dubbed, PlanRep, a web based planning and budgeting system will replace the manual excel computer system that has always been used by the government agencies, institutions and corporations.

A popular user-friendly planning and reporting database that has been in use by the local government authorities (LGAs) since 2017/18, designed to incorporate strategic plans, revenue projection, budgets, fund received and track expenditure and physical implementation will now be used by all the public organizations under TR's office.

"I hereby direct the Treasury Registrar not to analyse any budget prepared and presented in any other system other than PlanRep" said the deputy Permanent Secretary in the Ministry of Finance and Planning, Mary Maganga

Maganga said this while officiating the opening of a five -days training for 80 participants from 20 different government organisations.

They are part of the 944 officials from the 236 public organisations attending the capacity building training on the electronic budgeting system. The training is running concurrently in Dar es Salaam and Morogoro and Dodoma regions.

She called on administrative heads in all government agencies, institutions and corporations to adhere to the directive, saying the government had invested a lot of money in their organisations, thus the need for a strong control system.

The deputy PS noted that the government had invested 59.6tr/- in public institutions where it owns 266 shares by June,2019, terming it a big investment that calls for strong administration to help trigger economic growth through non tax revenue. She observed that in efforts to realise successes

in public funds management there is need for a strong electronic system that will make the management of such resources easier.

"Existence of this system will reduce revenues loss, strengthen accountability, budget analysis

and follow up hence increasing revenues in the

"PlanRep will be a very working tool for the office of the treasury registrar and I hope other ministries and institutions in the central government will adopt the same system for efficient performance," she added.

She thanked the office of the treasury registrar for the good work of strengthening management of public funds in government agencies, institutions and corporations.

The deputy PS also commended the development partners, who through the Public Financial Management Reform Programme (PFMRP) which had enabled the building of the system by strengthening cooperation with the government.

Speaking earlier, the Treasury Registrar (TR), Athumani Mbuttuka said his office in collaboration with the ministry of State, President's Office, Regional Administration and Local Government in 2019/20 initiated PlanRep, web based planning and budgeting system to be used by government institutions.

He said the system which had been in use by the local government authorities since 2017/18 had been improved for use by all organisations under the treasury registrar's office.

He explained that PlanRep has been built by local experts bearing in mind the Government Financial Statistic- GFSM-2, Chart of Account that as reviewed, organisation and structure of institutions and other specific needs for the government.

The TR noted that at the building stage of the system, a total of 32 organisations including those doing businesses, services and control were engaged in user acceptance test whereby their recommendations were adopted.

Mbuttuka said the system will help strengthen management of public funds in the organisations as well as easier and timely access to right information. "The system will help increase efficiency in management and monitoring of investments by the government organizations and corporations, increasing performance and increasing government revenue "he said.

He added that in addition the system, TR's office is also improving performance through electronic having built the Financial Analysis and Reporting System (OTR-MIS) and GIS/BIS.

Tarime resident to serve 20 years in jail for possessing govt trophies and weapons

District, Mara Region has been sentenced to 20 years in jail after he was found guilty of illegal entry to Serengeti National Park and possessing traditional weapons and government trophies.

The weapons included a spear and cables for animal traps as well as two legs of wildebeest valued at 1.84m/-.

Tarime District Reading the judgment magistrate Visensia Balyaruha said the sentence meted out should serve as warning to others who illegally enter wildlife reserves for poaching.

Earlier, State Attorney Bulembo Kasika prosecuting, alleged in court that the accused on February 14, this year was arrested by wildlife wardens inside Serengeti National Park without a

valid permit.

The accused pleaded not guilty to the charges CHACHA Mwita Magoko (20), resident of and the prosecution called in four witnesses and Karagatonga village in Ingwe Ward, Tarime the exhibits he was found with, while the defense side did not produce any witness.

> TANAPA prosecutor Kasika prayed to the court for a stiff sentence to serve as lesson to others who may commit similar crimes.

> District magistrate Visensia agreed with the prosecution and found him guilty.

TARURA calls for review of all rural roads construction projects under Agri-Connect

CHIEF Executive Officer of the Tanzania Rural and Urban Roads Agency (TARURA) Eng Victor Seff has ordered for the review of all rural roads construction projects under Agri-Connect to ensure they meet the set standards.

Eng Seff said the review will enable the agency to identify some incomplete road sections and provide room for improvement.

He made the directive in Mbeya Region during a tour to inspect the projects under 'Agri-Connect' which are funded by the European Union (EU) under the supervision of TARURA.

"We had some architectural challenges in almost all the Agri-Connect projects, we have resolved the problems and we are now ready to repair all the incomplete road sections", he

He said that in Rungwe District, a total of

11 kilometers of roads had been constructed (916.7kms) in Mbeya Rural District. at tarmac level. He said the contractor, GS Contractors Ltd is proceeding with the construction of the 4.9 kilometer's road from Masebe DSP-Mpuguso-TCC to Bugoba Kibaoni.

Eng Seff noted that the contractor, Summer Construction Ltd is constructing the Masebe-Lugoba-Lutete (7.2kms) which is expected to be completed in December, this year.

"Both contractors have promised to complete the projects by end of the year. Completion of the projects will facilitate transportation services in the city", he said adding that the Tanzania National Roads Agency (TANROADS) is also constructing a number of trunk roads.

TARURA boss The expressed disappointment over the contractors,M/S on time the 10 kilometers road from Lupeta-Wimba-Zumbwe and Milembe Construction Ltd road project from Inyala to Simambwe

"I am not satisfied with the pace of construction in Mbeya Rural District' I have directed engineers from the agency headquarters to cooperate with the contractors to ensure all the roads are constructed at the required standards and completed on time", he noted.

He said that most of the projects in the district have been completed by 20 per cent.

Eng Seff directed TARURA coordinator in Mbeya Region as well as the agency management in all the districts to start repairing all the ring-roads as most of them have been damaged.

The Agri-Connect project aims at facilitating smooth transportation of farmer's crops from farms to markets. Most of the cash and food Canopies International Ltd failure to construct crops cultivated in the region include coffee, tea, vegetables and fruits.

SCIENTISTS and agricultural experts have called on the government to put in place massive technical and financial investments in the management of post harvest losses.

Post harvest losses in Tanzania causes huge monetary loss in cereal grains, legumes, tuber and horticultural crops on annual basis due to poor storage infrastructures and lack of latest processing technologies.

Speaking in Morogoro during the 2nd National Post-Harvest Management Conference, stakeholders said post harvest loss is a critical problem that affects multiple value chains and is a potential threat to overall food security in the country.

Honest Mseri from Agricultural Non State Actors Forum (ANSAF) said without significant interventions such as massive investments to reduce postharvest losses, it will be difficult to offset the food deficit in some regions and achieve national food security.

Scientists urge govt to put more effort in management of post harvest losses

He said the government must fulfill the promise made in the National Post-Harvest Management strategy where it plans to contribute 41 percent of the total budget.

"In the National Post Harvest Management Strategy, government set aside 111bn/- from 2019-2024 which means 20bn/-each year, and development partners 59 percent. But if we make assessment, how much has been contributed so far?, he asked.

He said there is also a need for greater investment in public goods and infrastructure to facilitate the development of post-harvest systems.

for increased investment into the post harvest tools and processing technologies to reduce crop losses along the value chain.

HE Food and Agriculture thousands of years ago. After gathering Organisation of the United Nations (FAO) stressed that Africa must transform or modernise its agriculture, primarily to feed itself and reduce dependency on imports for agricultural and food items, while fostering the sector to drive the industrialisation process.

Speaking on the topic, "Accelerating Sustainable, Economic Transformation in Africa's Agriculture Value Chains," at the Africa Sustainable Agriculture Summit 2019, held in Nairobi, Kenya, FAO Subregional Coordinator for Eastern Africa, David Phiri highlighted that hunger and malnutrition are on the rise again in Africa, after two decades of progress. Africa is now home to over 256 million people who are in dire food insecurity, of which over 132 million are in Eastern Africa.

"Governments should create an enabling policy environment, where the private sector, including in agriculture, thrives and creates jobs, particularly for the youth and women. Agricultural policies that spur farm productivity, commercialisation and the agroprocessing industry are crucial for agricultural transformation," Phiri remarked.

Agriculture is the science and art of cultivating plants and livestock. Agriculture was the key development in the rise of sedentary human civilisation, whereby farming of domesticated species created food surpluses that enabled people to live in cities.

Agriculture is one of the economic drivers in Tanzania with the country benefitting from a diverse production base that includes livestock, staple food crops and a variety of cash crops. While the sector's GDP has more than tripled in the last 10 years, farmers and private sector actors still face considerable challenges. Declining export revenues; land acquisition hurdles; and smallholder farmers struggling to access economically viable technology, adequate storage facilities, markets and credit have affected private investment.

THE United Nations, UN, commenced activities marking its 75th Anniversary on Monday, September 21, buoyed with floods of mainly and eggs. Over one-third of the world's congratulatory speeches in a world drenched in increasing despair and cynicism.

Its predecessor, the League of Nations had been born on June 28, 1919 under the Versailles Peace Treaty which ended World War I. Thirteen of the 15 parts of the Treaty, punished defeated Germany. The Treaty forced the disarmament of Germany, imposed on it heavy reparations, seized some of its territories and gave them to Poland, Czechoslovakia and Belgium.

They also confiscated (instead of granting independence) to Germanv's agriculture-related colonies in China, the Pacific and Africa. These included Togo, Cameroun, Namibia and Tanganyika(Now part of Tanzania) and Botswana.

However, the League of Nations was consumed in the hellfire-like flames of the second European conflagration in 22 years which the conquerors styled the Second World War.

In truth, it was not the world that was at war; rather, the Europeans with their American cousins who had conquered the world as colonialists

hottest battles took place in colonies like Myanmar (The Burma War).

Some of the fiercest battles were fought in North Africa where the Germans led by the colourful "Desert Fox", Field Marshall Erwin Rommel, locked horns with the British led by Field Marshall Bernard Law

After the Second World War in 1945, some countries met to sign the UN Charter in San Francisco, United States, based on the principles of equality, human rights for all, peace, security and development in a shared world. Ironically, for the first time in its history, the UN could not gather in New York this year for its annual General Assembly due to the Covid-19

Assembly, Tijjani Muhammad-Bande of Nigeria explained that: "World leaders cannot come to New York because they cannot come simply as individuals. A President doesn't travel alone, leaders don't travel alone" and it is impossible

universal good, but to borrow a phrase the Nigerian Presidency used for a former president, American President Donald Trump rather than work for global unity, is playing the role of 'Divider-in-Chief'.

On Monday, Trump failed to deliver the expected American video speech; Vice President Mike Pence did not, neither did Secretary of State Michael Pompeo nor the US ambassador to the UN, Kelly Craft. Rather, Pompeo and Craft chose that day to hold a press conference attacking Iran, announcing new sanctions and generally putting the world on notice that America is ready for war.

Iran dismissed the American address. The acting Deputy United States ambassador, Cherith Norman Chalet had to address the ceremony live from UN headquarters.

However, the next day when the American COVID-19 deaths topped 200,000, Trump sent an address pronouncing China guilty of having "unleashed this plague onto the world" and asking that it be punished.

Some countries in their speeches verbally attacked the US. Venezuelan President Nicolas Maduro, denounced "the world of hegemony, the world of imperialism" declaring that:

"Venezuela supports a multipolar world, a renewed UN system, a system that knows how to enforce international law and protect the people of the world." In his speech, Cuban Foreign Minister Bruno Rodriguez Parrilla said: "It seems that (the US) is at war with the planet... and its inhabitants".

Turkey's President Recep Tayyip Erdogan , whose country assumed the UN General Assembly Presidency,

lamented that 820 million people in the world are hungry, 170 million people are in urgent need of aid and protection, while more than 70 million people had to flee their homes due to conflicts and oppression.

He argued that: "Despite the ideals that have been set out, the United Nations system can neither prevent conflicts nor end those that have already begun." In reference to the UN Security Council, he argued that:

"A Council with a structure that leaves the fate of seven billion people at the mercy of five countries is not fair, and it is not sustainable either... The world is greater than five."

Nigeria's President Muhammadu Buhari agrees, saying: "The demand for the reform of the United Nations Security Council is just and a place for Africa in the very strategic organ of the organisation is long overdue." South African President Cyril Ramaphosa and Eygpt concurred, with the latter demanding two permanent seats for Africa with full powers, including the

The European Union, EU, said its commitment is preserving and strengthening multilateral relations with its partners across the globe, with the United Nations at its core. The UN General Assembly President Volkan Bozkir, focused on the body's achievements which he said includes arms control to prevent nuclear conflict, peacekeeping and electoral assistance.

Secretary-General Antonio Guterres told members: "It is now time to mobilise your resources, strengthen your efforts and show unprecedented political will and leadership, to ensure

the future we want and the United Nations we need".

The President of the UN Economic and Social Council, ECOSOC, Munir Akram, said humanity is drifting towards erosion of structures that have been built to preserve peace and promote prosperity, and risking a "tragedy of epic proportions for all mankind". He called for a reversal.

Chinese President Xi Jinping's focus was on COVID-19 which has infected at least 31 million persons and killing about one million. The pandemic, he said, is a grave test for the entire world. Russian President Vladimir Putin supported China on the issue that the world puts up a united fight against COVID-19.

President Emmanuel Macron of France said: "The world today cannot be reduced to the rivalry between China and the United States, irrespective of the global weight of these great powers."

One of the most touching speeches came from Lebanon, the fractious, economically devastated, fire-ravaged but proud country. Its President, Michel Aoun, said despite all its suffering, Lebanon stands for multilateralism. This is in contrast to Trump's insistence on unilateralism. He had told the UN: "Only when you take care of your own citizens, will you find a true basis for cooperation."

The UN depends on multilateralism, so the American insistence on unilateralism including exiting the UNESCO, defunding the WHO, rejecting the Paris Climate Change Agreement and repudiating the Iran international nuclear deal, is a grave threat to its

Reducing food loss, waste requires the attention and actions of all

climate-smart

THIS year we observe the first ever observance of the International Day of Awareness of Food Loss and Waste which is held on September 29 annually. It also comes during the global COVID-19 pandemic, that has brought about a global wake-up on the need to transform and rebalance the way our food is produced and consumed.

Reducing food losses and waste is essential in a world where the number of people affected by hunger has been slowly on the rise since 2014, and tons and tons of edible food are lost and/or wasted every day. Food loss and waste also puts unnecessary pressure on the natural resource base and on the environment, depleting the natural resource base and

generating greenhouse gases. Globally, around 14 per cent of food produced is lost between harvest and retail. Significant quantities are also wasted in retail and at the consumption level. When food is loss or wasted, all the resources that were used to produce this food -, including water, land, energy, labour and capital go to waste. In addition, the disposal of food loss and waste in landfills, leads to greenhouse gas emissions, contributing to climate

Therefore, actions are required globally and locally to maximize the use of the food we produce. The introduction of technologies, innovative solutions including e-commerce platforms for marketing, retractable mobile food processing systems , new ways of working and good practices to manage food quality and reduce food loss and waste are key to implementing this transformative change. Reducing food loss and waste requires the attention and actions of all, from food producers, to food supply chain stakeholders, to food

industries, retailers and consumers

Food waste or food loss is food that is not eaten. The causes of food waste or loss are numerous and occur throughout the food system, during production, processing, retail and consumption. Global food loss and waste amount to between one-third and one-half of all food produced. In low-income countries, most loss occurs during production, while in developed countries much food - about 100 kilogrammes per person per vear - is wasted at the consumption stage.

Food waste is a major part of the impact of agriculture on climate change. The Food and Agricultural Organisation estimated in 2014 that food waste lost causes a global economic, environmental and social cost of \$2.6 trillion a year and is responsible for 8 per cent of global greenhouse gas emissions. Moreover, food waste that is not handled or reclaimed properly, i.e. through composting, can have many negative environmental consequences. For example, landfill gas from anaerobic digestion of organic matter is a major source of the greenhouse gas methane, and un-reclaimed phosphorus in food waste, leads to further phosphate mining. Moreover reducing food waste in all parts of the food system is an important part of reducing the environmental impact of agriculture, by reducing the total amount of water, land and other resources needed

to feed the global community. The international community has identified reduction of food waste as an important part of developing a sustainable economy with Sustainable Development Goal 12 seeking to "Halve global per capita food waste". Moreover, climate change mitigation strategies prominently feature reducing food waste; for example Project Drawdown describes reducing food waste as one of the more effective ways to reduce carbon intensity.

As the politicians want to be seen as problem solvers, they will immediately do all the best they can to make sure that everything is under control to ensure that the bogus healers are content.

During election seasons it is time for the wizards to change their outlooks, some can even dress in crocodiles, black cow skins, some strange local regalia, wearing big necklaces with some beads, cowry shells, lion and vultures claws embroideries. In many cases, the 'waganga' walk with many assistants.

If you watch the candidates some are given special words to mutter whenever they come across their opponents, it is called a tool to rattle their adversaries.

How to make nutritious food affordable for the 1 billion Africans

ADDIS ABABA

NE of the biggest revelations of the COVID-19 pandemic has been that people with pre-existing, diet-related conditions such as obesity, heart disease, and diabetes, are more at risk of suffering severe forms of the disease leading to a need for intensive hospitalization.

In Kenya, for instance, the Ministry of Health in July reported that 16 percent of seriously ill COVID-19 patients had diabetes, while diabetes and hypertension alone accounted for 47 percent of the COVID-19 deaths linked to preexisting conditions.

According to WHO data, these chronic diet-related conditions were among the main risk factors for illness and mortality in Africa prior to COVID-19. The current crisis is simply throwing fuel on the fire. It has highlighted the criticality of diet as the key determinant of health of individuals and populations, particularly in urban areas, where an increased uptake of highly-processed and unhealthy foods is increasingly undermining regional nutrition

In fact, data from countries in East and Southern Africa published in the Journal of International Development show that highlyprocessed foods now account for more than one third of the purchased food market. Not all of these foods are unhealthy, but many are, and combined with the availability of cheap, convenient and tasty street foods, the result is cheap food that is high in saturated and trans fats, salt and sugar.

Long-term solutions must be sought, a process that demands the involvement of all the world's leaders from communities, governments, civil society and the private sector. The challenge is clear: how to incentivize food producers, processors, distributors and marketers to make nutritious food more available and af-

To change these devastating trends fresh foods such as vegetables, fruits, high-protein legumes, nuts, eggs and fish must become more widely available and much more affordable in Africa's food markets. Healthy diets are often inaccessible to most of Africa's popula-

The UN estimates that 74% of Africans cannot afford healthy diets. That is nearly 1 billion Africans. This is shocking and unacceptable. These numbers are only likely to rise during this time of a pandemic, where job cuts have greatly reduced people's spending power and lockdowns have broken food supply chains, further increasing food prices, especially the prices of perishable fresh foods.

Temporary and very partial workarounds



include the expansion of social protection programmes such as in Nigeria providing targeted transfers to poor and vulnerable households. These financial packages help the vulnerable to meet their minimum dietary and nutritional needs, but they are not a complete or sustain-

able solution. Long-term solutions must be sought, a process that demands the involvement of all the world's leaders from communities, governments, civil society and the private sector. The challenge is clear: how to incentivize food producers, processors, distributors and marketers to make nutritious food more available and af-

First public policy needs to be aligned with this goal. Too many policies are working against this aim. For example too few food production and consumption subsidies are going to nutritious foods; too little public agricultural research development and farmer extension focuses on these foods; too often public food procurement disfavours these items and infrastructure development ignores cold chain development.

Agriculture in Africa is a key economic driver and supporter of livelihoods. Productivity needs to be increased, biodiversity promoted and climate resilience attained. Is this possible? Yes. Already, farmers in countries like Zambia are recording up to a 60 percent increase in yields through the application of ecosystem-based adaptation techniques.

Elsewhere, in Burkina Faso, farmers have reclaimed 200,000 to 300,000 hectares of degraded lands by digging shallow pots in barren land and filling them with organic matter. The reclaimed land now produces an estimated 80,000 to 120,000 additional tonnes of cereal for the Burkinabe. The challenge is to replicate these successes throughout the continent.

Second, private investment into these more nutritious foods needs to be incentivised. Of the \$200 billion impact investment fund industry, GAIN estimates less than 0.3% goes to nutritious foods in Africa. Fund facilities that

stimulate private investment in small and medium sized companies that produce nutritious foods for low income populations need to be established that offer loan rates that are lower than market while targeting nutrition

Institutional investors such as pension funds need to signal to the bigger companies with extensive value chains in Africa that they will favour companies producing more nutritiously beneficial foods.

Third, consumer demand needs to be shifted towards healthy foods. Too often healthy food campaigns pale in comparison to private sector campaigns for highly processed foods: they lack imagination, humour and flair.

Healthy eating campaigns must be engaging, aspirational and memorable. Food environments-where consumers come face to face with food-are stacked against the consumption of healthy foods which are often consigned to unattractive spaces in markets and stores. This needs to change too.

Fourth, civil society campaigns can hold businesses and governments accountable for promoting healthy foods. Civil society activism is particularly essential to focus attention on silent crises such as unhealthy

Together these four levers can incentivize businesses and other stakeholders to innovate and develop business models, products and services that make nutritious and safe foods more available, affordable, desirable, and sustainable. Africa cannot move ahead smoothly if 1 billion of its people cannot afford a healthy diet.

The approaches defined above are not exhaustive, but if well implemented will bring the continent closer to better nourishment, further improving the prospects of properly fighting emerging health challenges such as COVID-19, both from a health and economic perspective.

Why so many older people are thriving


June 2019, the UN released the World Population Prospects 2019 report. Some of their findings were that "life expectancy at birth for the world, which increased from 64.2 years in 1990 to 72.6 years in 2019, is expected to increase further to 77.1 years in 2050," and, "by 2050, one in six people in the world will be over age 65 (16%), up from one in 11 in 2019 (9%)....The number of persons aged 80 years or over is projected to triple, from 143 million in 2019 to 426 million in 2050."

How much of an impact the coronavirus pandemic will have on those statistics remains to be seen. However, even if all the confirmed deaths were above the age of 60 - equating to nearly a million deaths, statistically that is unlikely to change the trajectory of the trend towards a larger older popu-

The UN credits the growth of an older population to "the advancement of public health, medicine, and economic and social development, and their contribution to the control of disease, prevention of injury, and reduction in the risk of premature death," as well as a declining birth rate.

Outside of conditions such as dementia and Alzheimer's, it is also no longer taken for granted that significant memory decline is part of the ageing process

A number of studies show a close link between lifestyle choices and cognitive decline among seniors. In 2016, the University of Texas' School of Behavioral and Brain Sciences,



published an analysis of major ageing research of the past 50 years.

One of their key findings was that, "as research developed, a multitude of variables were recognized to con-

tribute to age-related memory deficits. The shift from early single-mechanism views to involved multifactorial models is striking, and these intricate cognitive models mirror the vast complexity of the aging brain."

Simply put, the level of memory decline in old age is not a given, but rather something that is affected by a multitude of factors, many of which are being continually discovered.

An article published by Harvard Medical School's Harvard Health Publishing website in 2010, broke it down to practical steps that can help guard against memory decline, stating that "experts think that advanced education may help keep memory strong by getting a person into the habit of being mentally active...Many people have jobs that keep them mentally active, but pursuing a hobby or learning a new skill can function the same way. Read; join a book group; play chess or bridge; write your life story; do crossword or jigsaw puzzles; take a class; pursue music or art; design a new garden lavout."

In addition, they highlight the importance of diet and exercise, as well as guarding against diabetes, high blood pressure, sleep apnea, depression, cholesterol, and an underactive thyroid.

On the positive end, the increase in longevity as well as the implementation of healthy habits, is likely to result in a healthier population above the age of 60. While many might be looking forward to retirement at 60, the possibility of another 20, 30, or 40 years of life and minimal cognitive decline, might put into question the idea of retiring at 60.

If indeed, as the body of research suggests, ageing is in fact informed by various conditions, and not all 65 year old or even 80 years olds are in the same state of health or cognitive decline, how fair then is the mandatory retirement age of 60 or 65 that is implemented by many companies? And what of the very real economic

conditions? As reported by Ruan Jooste for Daily Maverick in September 2019, "A key issue that crops up often in retirement research is mounting financial pressure, which is preventing people from saving enough or at all for their golden years. Findings aligned very closely with a widely quoted National Treasury statement that only 6% of the country's population was on track to retire comfortably."

Work also provides a necessary sense of purpose for many. A 2017 study, by professors from Harvard T.H. Chan School of Public Health, titled Association Between Purpose in Life and Objective Measures of Physical Function in Older Adults, concluded that, "Purpose in life was prospectively associated with a decreased risk of developing weak grip strength and slow walking speed, although the findings were more robust for walking speed than for grip

These findings suggest that a sense of purpose in life, a modifiable factor, may play an important role in maintaining physical function among older adults.'

Judging by the UN's report, the world's population will continue to get significantly older. Are the current systems in place - be they company policies with regards to retirement age, or youth-obsessed marketing strategies, or public services geared towards seniors - ready for the healthy, and mentally fit elder in the room? If not, are they getting ready?

Africa scales up digital transformation to cope with COVID-19 crisis

FRICA'S digital economy has found a silver lining in the ongoing COVID-19 pandemic as more people opted for online shopping to halt the spread of the virus. The digital transformation on the continent has been further expedited by Chinese players, including e-commerce titan Alibaba and telecom giant Huawei. Before long, African

entrepreneurship passion will be lifted to a record high, as the 2020 Africa's Business Heroes prize competition, a program established by the Jack Ma Foundation's Africa Netpreneur Prize Initiative, is set to reveal its 10 finalists this fall.

EXPONENTIAL GROWTH

The African people have had their first taste of success in digital transformation as e-commerce on the continent has been experiencing exponential growth amid the COVID-19 pandemic.

Facilitated by Alibaba's Electronic World Trade Platform initiative, an online promotion event for Rwandan coffee via live streaming was held recently to help Rwandan coffee farmers pull through difficulties caused by the pandemic. Some 3,000 bags of coffee beans from Rwanda Farmers Coffee Company were sold out in a second. "Alibaba came at a time when it was needed the most. In a world that runs digitally, we have to adapt ourselves to e-commerce, and thanks to Alibaba Group, we are tapping into the opportunity since it's one of the best platforms in the e-commerce sector," Pie Ntwali, spokesperson of Rwanda's National Agricultural Export Development Board, told Xinhua.

To mitigate the economic impact of COVID-19, African e-commerce platforms such as SafeBoda, a motorcycle (bodaboda) taxi hailing app connecting market vendors with customers, are giving a boost.SafeBoda and other e-commerce platforms have seen a triple-digit increase in business following the outbreak of the pandemic, the United Nations Conference on Trade and Development (UNCTAD) announced in August.

Governments in Africa are helping these e-commerce platforms flourish by fostering an enabling environment for e-commerce and the digital economy, in line with recommendations of an UNCTAD eTrade Readiness Assessment.

In Kenya, revenue streams generated by music aggregators, such as local platform Mdundo, have helped mitigate pandemic-related losses, through the download of artists' music tunes and ringtones for mobile phones. Mdundo, which is expanding its presence in 15 African countries and featuring more than 60,000 African artists, has more than 5 million active users. "Music downloads have been rising steadily with a 26-percent uptick in 2020's second quarter on the first quarter's 33 million downloads," Mdundo's CEO Wanjiku Koinange said, adding that COVID-19 was also changing the way creative content is being produced.

Under lockdown, the power of online technology has prevailed, making life easier for African residents to access essential services and household basic essentials like food, drinks and hygiene products by means of different online platforms, Alex Ntale, ICT chamber CEO of Rwandan Private Sector Federation, told Xinhua.

Kauthar D'Souza, a Tanzanian housewife residing in Kariakoo, a major market area in Dar es Salaam, said COVID-19 had doubled her online shopping needs. "Since the outbreak of the COVID-19 pandemic I have been buying all my basic needs including food and clothing online," she said. "Online shopping is the best way of avoiding mass gathering as a way to protect ourselves against the COVID-19." "The e-commerce has showed great potential and it will be the best model of business in the future of commerce," said Ntwali.

HUGE POTENTIAL

industry, said the culture of online buying and home delivery in Tanzania that had been accelerated following the outbreak of COV-ID-19 should be maintained even after the disease was contained.

Experts and policymakers have called on African leaders to "think digital" during a virtual session of the African World Summit on the Information Society (WSIS) implementation meeting held early this month under the theme of "COV-ID-19: A Catalyst to Achieving WSIS Outcomes." "This is a great opportunity for the continent to transform itself. The digital economy is an important sector, so we need to embrace technology and leapfrog if we are to survive," Head of the Information Society Division at the AU Commission Moctar Yedaly said, adding the Digital Transformation Strategy developed by the African Union is key to transforming Africa.

"Building a digital future is crucial if the continent is to become globally competitive, survive and claim the 21st century," read the outcome statement issued by the UN Economic Commission for Africa (UNECA) after the meeting.

The participants also agreed harnessing digital technologies and innovation to transform Africa's societies and economies as a crucial impetus is "not only to promote Africa's integration but also generate inclusive economic growth, stimulate job creation, bridge the digital divide and eradicate poverty to secure the benefits of the digital revolution for socioeconomic development." "The Information and Communications Technology (ICT) is an important engine for achieving sustainable development goals," said Jean Paul Adam, director of the Technology, Climate Change and Natural Resources Management Division at the UNECA. "However, our main challenge remains. The digital divide is widespread in Africa with a very low rate of connectivity. We can never meet the 2030 target if we do not urgently address the issue of connectivity across the continent," said Adam.

CHINA'S EFFORTS

The good news for Africa is that China is helping the continent to shape the e-commerce ecosystem in a way not seen before, by pro-

viding e-commerce platforms, mobile payment technologies and smart phone devices.

E-commerce outlets in Africa such as Jumia are already achieving tremendous growth due to its connectivity with Chinese online firms, notably Alibaba and others. "China-Africa ecommerce partnerships are scaling up the digital dream that Africa has had, and helping the continent move towards innovation, technology and competitiveness," Edward Kusewa, economics lecturer at St. Paul University in Nairobi, Kenya, told Xinhua. Chinese smart phones have led to a social media boom especially among the continent's youth and have played a big role in the growth of Africa's ecommerce industry, according to Kusewa. Mobile money tools such as M-pesa have made digital shopping seamless, thanks to mobile devices made in China.

On Sept. 24, Joseph U. Ibeh, senior analyst at Space in Africa, made public his latest research report on mobile money, saying that there are currently more than 290 mobile money services deployed across 95 countries, mainly in Africa, Asia and Latin America. Citing the Global System for Mobile Communications Association (GSMA) State

of the Industry Report on Mobile Money, Ibeh said "Sub-Saharan Africa is not showing signs of slowing down in mobile money adoption as the GSMA forecasts that the region will surpass the half-billion mark by the end of 2020."

Africa's digital footprint has benefited greatly from China's technologies and digital platforms provided by both Chinese startups and the Chinese government, said Kusewa. Satellite communication, cable networks, telecommunications equipment, software development and hardware capabilities are some of the advancements that African technological infrastructure has gained over the past three decades from China. "The presence of Chinese firms like Huawei has assisted African nations scale up their uptake of the digital economy," said Kusewa.

On Sept. 16, Huawei Kenya kicked off this year's Seeds for the Future program, which seeks to develop ICT talent amid growing China-Kenya ties. Will Meng, CEO of Huawei Kenya, said that the program will be held virtually for the first time amid the COVID-19 pandemic, providing a fiveday intensive training to 60 participants from around the

They will study 5G, big data, artificial intelligence, cloud computing to empower them to catch up with the latest technology trends. "By sharing ICT expertise and experiences in the global business environment, young people from different countries can learn about advanced technologies in the ICT industry and accumulate ICT expertise and skills through the Seeds for the Future program, contributing to the progress of the global ICT industry," said Meng during the virtual launch.

The program, which started globally in 2008, has so far benefitted almost 200 students in Kenya since 2014 and is moving forward this year despite the disruptions from the COVID-19 pandemic. "We truly believe that talent is the key to success

It is why we invest so much in supporting Kenyan ICT talent which will not only drive the ICT industry but power every other industry," said Zhou Pingjian, Chinese Ambassador to Kenya.

"Prior to the entry of Chinese firms, Africans relied on technology from western nations whose price was beyond the reach of most governments and private sector firms," said Kusewa.

"Today, African digitization efforts are growing rapidly and are largely associated with investments from China. Firms such as Huawei, ZTE, and China's Telecom have already started working to build core systems of ICT infrastructure across the continent," said Kusewa.

Further, China has called on all states to put equal emphasis on development and security, and take a balanced approach to technological progress, economic development and protection of national security and public inter-

"We welcome governments, international organizations, ICT companies, technology communities, civil organizations, individuals and all other actors to make concerted efforts to promote data security under the principle of extensive consultation, joint contribution and shared benefits," said Chinese State Councilor and Foreign Minister Wang Yi on Sept. 8 during the International Seminar on Global Digital Governance.

"Africa is witnessing a robust digital infrastructure that is helping to spur innovation among small businesses. The continent has also realized that through partnerships with China, it can lower the cost of communication across African countries," said Zambian social economist Kelvin Chisanga.

Media experts want special taskforce to review community radio charges

EXPERTS have called for the creation of a special task which will review charges being imposed onto community media outlets, to enable these non-commercial information broadcasters to operate in a friendlier environment and thus be able to reach out to a wider audience base.

The chairperson of the Tanzania Network of Community Radio Stations (TADIO), Prosper Kwizige was on view that, the Ministry of Transport and Communications; the Ministry of Information, Culture and Sports; the Ministry of Finance and the Tanzania Communications Regulatory Authority (TCRA) should form a joint task force which start common dialogue to aid that mission.

"The National Constitution through Act 18, recognises the right of all citizens to get information through proper channels but this is crippled by myriad of charges imposed on local media outlets, including community radios that could serve an important mission of taking services into rural villages," pointed out Kwizige.

The TADIO chair was speaking in Arusha, where the occasion to observe this year's International Day for Universal Access to Information (IDUAI) was hosted at national level.

It was pointed out during the meeting that running of services oriented media outlets such as community radio stations and news-

papers that usually don't sell advertising space or airtime is already an expensive venture, but when added charges get imposed, then the whole venture becomes unmanageable.

Held annually IDUAI which takes place on the 28th of September of each year, was designated by the United Nations Educational Scientific and Cultural Organization (UNESCO)'s General Conference.

The UNESCO country representative in Tanzania, Tirso Don Santos said his organisation will continue to work in partnership with both the government and local media outlets for the sole mission of ensuring that all people access proper information.

For his part, Arusha Region Commissioner Idd Kimanta who graced the occasion said his office is open to work with all media organisations. He later launched a special website which will serve as new portal.

The International Day for Universal Access to Information was inaugurated in November 2015 and was first held on 28 September 2016.

The day has been recognised as International Right to Know Day since 2002 and was developed by international civil society advocates as from the year 2012. The UNESCO resolution creating the day was pushed by African civil society groups seeking greater information transparency.

So far, despite its importance, only about 7 African Union member states have adopted national right to information laws.

He said the villagers were suspicious after the suspect asked them to assist him with shelter so that he can hide from the police. He said that upon receiving the information, police officers arrested him and he was brought to Zanzibar on August 4, 2020.

Issa was arraigned at the Vuga High Court in Zanzibar on August 28, 2020. His case will again be mentioned on October 9, this year.

It is almost seven months now since Hajra was murdered in Paje South-Unguja Region on February 26, 2020. Hajra's mother, Lela Leo commended the police force for arresting the suspect.

In view of the situation, TAMWA Zanzibar appeals to law enforcement agencies to ensure justice to the incident in order to uphold the

rule of law and end such oppressive acts against women.

TAMWA Zanzibar has so far recorded 17 murder cases involving women in four years from 2016 to 2020. Of the number, only four cases including that of the late Hajra have been brought before the court of law. According to the information that TAMWA Zanzibar has received, the cases are still pending due several reasons including failure to trace the suspects and lack of evidence.

There three similar cases going on at the High Court in Vuga, Unguja-Urban West involving the murder of Wasila Mussa (21), Samira Sultan (56) and Zawadi Paulo

Women, peace and security: Is SA a global champion but domestic loser?

ENDER-based violence and women's empowerment are enormous challenges in South Africa. President Cyril Ramaphosa's words in June 2020 illustrated the seriousness of the problem: "As a country, we find ourselves in the midst of not one, but two, devastating epidemics ... At a time when [Covid-19] has left us all feeling vulnerable and uncertain, violence is being unleashed on women and children with a brutality that defies comprehension."

Amid this national crisis of violence against women, South Africa in August adopted its long-awaited national plan to implement United Nations Security Council Resolution 1325. This is the most important global policy on strengthening the role of women in peace and security situations.

South Africa's plan is long overdue considering that Resolution 1325 was passed 20 years ago. Despite the delay, the country has - during its current term on the Security Council - actively worked to improve women's participation in peacebuilding and their protection in situations of armed conflict.

South Africa thus faces a dichotomy: It is seen as a global champion in this area, but at home, its women face extreme violence on a daily basis and the country has until recently lacked its own Resolution 1325 action plan.

In comparison, other states championing the women, peace and security agenda - such as Sweden and Canada - have published multiple versions of their own national action plans. African countries like Liberia and Rwanda adopted their plans over 10 years ago. Canada has even appointed an ambassador exclusively dedicated to women, peace and security.



South Africa's plan is nevertheless unique, as it's neither entirely a foreign policy tool nor a domestic policy - it's a mix of both. It acknowledges that the country's international engagements on women, peace and security cannot be separated from the violence women experience within its borders. It is an important step in ensuring that progressive foreign policy improves the lives of South African women.

The absence of a plan to implement Resolution 1325 didn't prevent South Africa from making important strides at the national level on women's em-

powerment, however. Its Constitution provides full rights to women and every foreign minister since 1999 has been a woman.

Moreover, 43% of its parliamentarians, 31% of the defence force and 37.2% of police are women at both tactical and strategic levels. South Africa's Phumzile Mlambo-Ngcuka is the head of UN Women, the leading UN agency on gender equality.

Women, peace and security were arguably South Africa's most visible priority during its two-year term on

negotiations on Resolution 2493 during its first presidency month, in October 2019. Despite being unanimous, the resolution was agreed only after fierce negotiation by the South African mission to the UN. The talks overcame reservations from China, Russia and the United States about the use of language on human rights and sexual and reproductive rights.

The resolution asked UN member states to provide further information on the progress and setbacks on the women, peace and security agenda, the Security Council. The country led pushing them to strengthen the prac-

tical steps needed to improve the position of women. One of South Africa's focus areas on the council was pushing for implementation and member state accountability.

Back home, however, women face many challenges. Despite not being in a conflict situation, South African women are far from secure. There is a high prevalence of genderbased violence, with 26% of women reporting intimate partner violence in their lifetime.

While initially driven largely by the Department of International Relations and Cooperation, other sectors of society were involved in developing South Africa's Resolution 1325 implementation plan. The aim was to produce a strategy that would acknowledge the country's foreign policy priority as well as the daily needs of and threats to women.

Beyond international relations, the process brought together departments such as defence, and women, children and people with disabilities. A range of academics, women's rights activists, policymakers and civil society also took

It was an important lesson for developing inclusive and accountable foreign policy. By framing what is essentially a foreign policy plan around its domestic problems, South Africa can legitimately debate gender violence across the world, whether societies are in conflict or not.

But South Africa needs to reduce gender violence at home if its global commitments are to go beyond rhetoric. With the plan adopted, the country must take action. The focus should be on identifying who will do what, budgeting for projects now and in the future, monitoring implementation and evaluating results.

The plan will only be effective if it is embraced by South Africa's government and society as a whole - not only by the international relations department. This means all relevant government departments, civil society and the business community must work together. Coordination with other initiatives on violence against women will avoid duplication and blind spots.

South Africa needs to demonstrate change on the empowerment and safety of its women. If not, the country risks being seen as a superficial global champion. For the sake of South African women and society as a whole, this is a battle that must be won on all fronts.

China's tourism market to see robust recovery over combined holiday for National Day, Mid-Autumn Festival

HINA'S tourism sector is expected to receive a ages of 26 and 45 accounting for 80 percent of the total. further boost during the upcoming eight-day combined holiday for the National Day and the Mid-Autumn Festival, which will run from Oct.1 to 8.

This year's Mid-Autumn Festival falls on Oct. 1, coinciding with National Day, adding an extra day to the seven-day National Day holiday.

From Aug. 31 to early September, the number of people searching online for train tickets for trips during the upcoming holiday surged by 83 percent from last year. Tickets for certain trips during the holiday are all sold out, according to data from qunar.com, a leading online travel services platform in China.

Data from Chinese online travel services and social networking platform Mafengwo showed that the first small travel peak of this year's combined holiday for the National Day and Mid-Autumn Festival is expected to start ahead of Sept. 26, as many young people plan to ask for four days' leave so that they can enjoy more than 10 days of travel.

The major travel peak will arrive on Sept. 30 and Oct.1, while some tourists who plan to enjoy short and mediumdistance tours will start their trips on Oct. 3 to avoid the travel rush, suggested Mafengwo.

80 percent of the people surveyed by aoyou.com, a Chinese travel services website, plan to travel during the upcoming holiday, with white-collar workers between the

It's also worth noting that modes of travel such as smallscale group tours, customized tours and road trips have become popular as people are now more aware of the necessity of epidemic prevention and control.

Customized tours are witnessing rapid development and rocketing popularity, with more than 40 percent of tourists preferring this novel way to travel for the eight-day combined holiday, according to relevant data.

The number of orders for customized tours during this year's Golden Week holiday has increased by 24 percent year on year, indicated data from Mafengwo.

In addition, because of the COVID-19 pandemic, more and more Chinese people have shown increasing preference for road trips which are freer and safer. Online searches on the topic "road trips during National Day holiday" have seen a 153-percent month-on-month surge, suggested big data from Mafengwo.

Southwest China's Yunnan province, Guizhou province, Sichuan province, Chongqing municipality, Tibet autonomous region and east China's Jiangsu province, Zhejiang province, Shanghai municipality, Shandong province, and Fujian province are the top 10 popular domestic tourist destinations for the combined holiday, with Yunnan being the most popular among tourists.

In addition to the traditional popular travel destinations





Sightseeing tours of destinations such as deserts, great rivers and Danxia landforms as well as activities including camel-riding camel and visits to the ruins of the ancient Silk Road in northwestern China have become popular choices this year, suggested data from Ctrip.

This combined eight-day holiday will be the last statutory holiday in China this year, which is also one of the main reasons for the growing enthusiasm of Chinese people for

With more tourists going out to enjoy their travels during the upcoming holiday. China's tourism sector is set to see a faster recovery, said Luo Jun, co-founder of Tujia, a Chinese online platform for vacation rentals, and Sweetome, a Shanghai-based global accommodation sharing operator.

UAE consumers expect a fully cashless society by 2030



THE Covid-19 pandemic has accelerated the UAE's transition to a cashless society as a growing number of businesses and individuals have stopped using physical cash due to safety and hygiene concerns, according to a new survey. Almost two-thirds of people in the UAE, or 64 per cent, expect the country to become fully cashless by 2030, the poll by Standard Chartered found.

The survey, which was conducted globally among 12,000 respondents aged 18 and above from August 17 to 21, also found that 73 per cent of the UAE's respondents believe Covid-19 has made them more positive about online shopping. However, prior to the pandemic, 72 per cent of consumers preferred to shop in-person versus less than a

Almost half (47 per cent) of UAE respondents said they also prefer making online payments now rather than using in-person cards or cash payments, according to the survey. "The UAE is on a fast track in adopting digital banking and cashless payments and the pandemic has accelerated the digital drive," said Sonny Zulu, head of retail banking at Standard Chartered UAE.

This resonates with the findings of a Mastercard survey in April, which found that 82 per cent of UAE consumers prefer to make contactless payments due to safety and hygiene concerns amid the coronavirus pandemic.



Although 46 per cent of consumers in the UAE reported spending more in July, 89 per

cent of people in the Emirates say the pandemic has made them more careful with their expenditure against a global average of 75 per cent. "We see consumers in the UAE spending more on basics, such as groceries, healthcare and digital devices than they did prior to the pandemic, and they expect this increase to continue in the future," Mr Zulu said.

TGT women graduates given working tools, entrepreneurial skills

WOMEN graduates of Tanzania Growth Trust's 'Mkubwa' Project received working tools to enable them run their businesses while also adopting a saving culture through Vicoba.

TGT's CEO, Anna Dominick said in Dar es Salaam over the weekend during the tools handing over ceremony that 'Mkubwa' which is done in collaboration with We World Tanzania, has ensured growth of women most of who are single mothers and struggling. "We found these mothers incompetent and unable to send their children to school, we linked them and gave them entrepreneurship skills through training while explaining to them the importance of sav-

ing through Vicoba," Dominick said. She explained that the program was set up with the aim of reaching out small and medium-sized business women but later found out that there is a large group of women left out and who are struggling to

Dominick stated that the women entrepreneurs who have been groomed by 'Mkubwa' will be monitored by their mentors so that they can grow in terms of income and be able to send their children to

The training which started in 2019 involved 20 young mothers, 10 from Temeke and 10 from Kinondoni Municipalities but this year, the number has increased to 57, 24 from Temeke and 33 from Kinondoni. The TGT chief executive further noted that next year, they aim to reach 60 mothers.

In remarks at the event, We World Tanzania Manager, Nyawaye Gesirari said in the three years of implementation the 'Mkubwa' program, they have been able to reach 140 households the majority being mothers who were unable to pay school fees for children. "We are currently aiming to enter the third phase of the program and plan to increase the number of beneficiaries to bring about better results," Gesirasi said.

Universities urged to produce job creating graduates, not job seekers

NSTITUTIONS of higher learning including universities should produce graduates who will establish businesses that create jobs for non-graduates and unskilled labourers other than job

Principal of Tengeru Institute of Community Development, Dr George Bakari said last week during the 13th graduation ceremony of MS Training Centre for Development Cooperation that global dynamics of employment have changed much such that graduates who lack enterprising skills to establish businesses end up frustrated while looking for employment in a saturated labour market.

"Modern university graduates should establish businesses that create jobs, pay government taxes and contribute to economic growth as soon as they get out of school," said Dr Bakari while commending MSTCDC for discharging competent graduates into the market.

He said part of graduates training at universities should include creativity and innovation to equip students with skills to

become entrepreneurs other than job seekers because the labour market globally has no room to absorb all new graduates annually.

"These graduates who have been here for the past three years should have requisite knowledge and skills to come up with bankable ideas that will create businesses that employ others. Graduates from higher learning institutions should assist the country's economy grow rapidly through their innovative contributions," the TICD chief added.

He named some of the potential areas where graduates can start businesses as horticulture with vegetables and fruits being on high demand in urban centres and abroad; establishing small agro-processing plants to add value to commodities and poultry farming.

Addressing parents and graduates during the ceremony, MS TCDC Director of Programs, Sara Teri said among the graduates were 10 from outside the country who qualified to occupy senior leadership positions in community service and social administration anywhere on the African continent.

"We ensure that our graduates can self employ themselves and help governments address the problem of unemployment and poverty prevailing on the African continent," Teri said while noting that the graduates will also help create value in the private sector. She said the institute had to complete courses online because of challenges brought about by the coronavirus outbreak. One of the foreign students who graduated, Vicent Otieno from Kenya promised to mobilise idle youths waiting for white or blue collar jobs to start own businesses and contribute to growth of the economy.

"I hope to mobilise and give knowledge and skills to youths so that they can play an active role national development and democratic governance," Otieno said adding that he hopes to be a solutions presenter to the community.

Established in 1967, MS TCDC is a joint project of Norwegian international aid agency, ActionAid Denmark and the host government aimed at producing graduates who can offer practical solutions to community development and social service administration.

Bank invites guardians, students to get cheap loans for fees

PARENTS and guardians of students at all levels of education can access loans to pay school fees timely and avoid inconveniences from school administrators.

Katagira said the decision was made to appreciate to the parents and guardians their choice of the Dar es Salaam based private school. "But

Belgium scraps Covid-19 test for arriving travellers from Rwanda

KIGALI

PEOPLE returning to Belgium from Rwanda will no longer be obliged to undergo testing for the novel Coronavirus (Covid-19) on arrival to the European country.

They are also not required to remain in quarantine, according to the latest updates to the interactive map on the country's Foreign Ministry's website.

Rwanda and South Korea are the only countries that travellers returning to Belgium won't require mandatory testing and quarantine. Until now, Belgium had banned non-essential travel outside the European Union, the United Kingdom, Switzerland, Liechtenstein, Iceland and Norway.

While Brussels strongly advises against visiting countries and regions coded red for Covid-19, it is no longer banning travel to such areas. It is also complying with European agreements on safe countries outside Europe.

However, of the 10 countries on the EU safe list, only Rwanda and South Korea are listed as orange by Belgian authorities. The others are coded red, so the Belgian foreign ministry strongly advises against travel to those countries or bans it in cases where the country concerned does not accept visitors from Belgium.

Meanwhile, Rwanda was a few weeks back put on the list of the European Union Council's epidemiologically safe countries. Other countries include Australia, Canada, Georgia, Japan, Morocco, New Zealand, South Korea, Thailand, Tunisia, and Uruguay. These are basically countries for which EU member states should gradually lift travel restrictions at the external border.

When the outbreak emerged, Rwanda instituted strict measures, including total a lockdown which lasted for close to two months. The country has also deployed massive testing across the country, with daily Covid-19 tests, mainly targeting high-risk areas across the country.

The testing is also greatly supported by the deployment of testing labs in different parts of the country, from just one, when the pandemic broke out in March this year. In recent days, testing has reduced, and this, according to Rwanda Biomedical Centre, is attributed to the fact that there are fewer contacts being traced to Covid-19 cases.

As of Saturday, September 26, the country had conducted 486,735 tests of which 4,779 cases have been diagnosed, and from these, 2,995 have already recovered. The national death toll stands at 27. As business slowly gets back to normal, Rwanda is easing some measures including the planned reopening of schools.

Air travel has been allowed to resume for nearly two months now, with RwandAir gradually expanding its travel network as demand picks, having started at the beginning of August, following the reopening of Kigali International

Having initially started with the Dubai route and other destinations on the African continent, the national flag carrier is expected to resume Brussels flights in Belgium on October 3. On the same day, flights to London's Gatwick International Airport will resume.

Timber cost shoots 60 percent on State's school desks project

NAIROBI

A FOOT of cypress wood that retailed at Sh160 before the government announced the Sh1.9 billion stimulus package for artisans, currently goes for Sh250.

The cost of timber has increased by up to 60 percent, triggered by government's plan to buy school furniture from local carpenters. A foot of cypress wood that retailed at Sh160 before the government announced the Sh1.9 billion stimulus package for artisans, currently goes for Sh250.

Timber merchants have also increased the price of mahogany wood from Sh380 a foot before the announcement, to Sh500 currently. "The suppliers increased prices immediately the advertisement was put out," said Mr Justus Mwika, a carpenter operating on Ngong Road, Nairobi. This means consumers will pay more for finished timber products as carpenters pass on the cost to stay afloat amid the Covid-19 pandemic.

The carpenters have been grappling with low cut timber supply following an anti-logging ban in public and community forests since February last year. "The ban and now the government call for supply of school furniture has increased cost of wood by a big margin," said Mr David Munue, who uses timber imported from Congo.

He said a six by four bed that retailed at Sh6,000 currently goes for Sh7,000. The State invited carpenters to register with Deputy County Commissioners to be considered for supply of public schools desks ahead of reopening.

Aside from timber, the price of metal tubes (3/4 furniture pipe grade 16 to 18), an essential raw material for making school desks and chairs, increased following the announcement. "We are being told there will be 700,000 orders for desks but now the suppliers of those raw materials have hiked prices," said Mr Richard Muteti, the chief executive of the Kenya National Federation of Jua Kali Associations.

French PE firm opens local office with eye on SMEs

"The entrepreneurial ecosystem is very dynamic in the region, and yet it appears that only a few investment funds are keen to invest amounts within IPAE 2's target range, most favouring larger deals," said Mr Noorani.

I&P has already invested in Afribon, a Kenyan food flavours business, African Management Institute, a Kenyan management training company, and Finance Trust Bank, a Ugandan lender for micro entrepreneurs and small companies.

Since 2002, the fund has disbursed amounts ranging from Sh127 million to Sh636.6 million—which is its investment band—to over 90 SMEs in 16 countries in sub-Saharan Africa. I&P aims to invest equity and quasi-equity in start-ups and small businesses in West and Central Africa as well as in East Africa and Madagascar as a minority shareholder.

With headquarters in France, I&P has sponsored five African impact funds, which have together invested in more than 90 companies located in 16 African countries. I&P was created in 2002 by Patrice Hoppenot and managed since 2011 by Jean-Michel Severino. The fund employs 50 people working in Paris and seven African offices.

Mantra says uranium mining at Mkuju River to start 2023

THE country may have the first consignment of uranium minerals produced from the flagship Mkuju River Project in 2023 if all goes well, says Alexander Ryabchenko, Chairman of the board of Mantra Tanzania Limited. Ryabchenko recently told Smart Money in an interview that global market prices for the commodity have delayed the project, excerpts:

Why have you decided to merge the two companies?

There was no decision to merge companies, there was an overall Rosatom's decision to take all the companies, which are a part of the group, under one brand, so it will be more recognizable and less confusing to business partners.

Does this apply globally wherever Mantra and Rosatom have operations or it's in Tanzania

This applies globally wherever Rosatom operates.

What exactly is being merged here, managements of Mantra Tanzania and Uranium One?

Nothing was merged, the corporate and management structures are the same, even the company name (Mantra) remained the same. It is just a change of logo and public brand.

Will this merger mean any major changes in the market in terms of corporate identity with new colours or logos?

The logo of each company, which is a part of Rosatom Group, changes began from August 2020.

Will there be any layoffs of employees?

As the legal entity stays the same and is not affected by any changes, this switch is not affecting Mantra's

After this merger what next in relation to implementation of the Mkuju Project because your ownership permits ends in 2025?

The change of company's brand will not affect any future plans for the



development of Mkuju River Project, which are continuous and have a long term perspective.

How much has been invested so far at Mkuju?

Mkuju River Project is an important uranium mining project for Rosatom. Of course, during the low uranium market price, which we have been experiencing during last 5-6 years, the management was trying to reduce investments to save the project's profits for the future, however the investments are being made without interruptions and our intention is to increase the amount during the next year.

I recently saw a Mantra announcement seeking a contractor for Mkuju Project, have you picked one?

Mantra Tanzania decided to start its' pilot production designing process, that is why we started seeking for a contractor, which would be able to prepare the design project for further construction. Nowadays we have picked reputable contractors for the design stage and the

mining activities start at Mkuju?

Mining activities at Mkuju are highly dependent on the market price of uranium, however we are planning to start construction of our pilot plant in 2021/22 fiscal year with further pilot mining and pilot production in 2023, so we see that Tanzania will be able to announce its' first uranium production soon.

What major obstacles are you facing in speeding up production at Mkuju Project?

We can say that the only obstacle is the global market price of uranium. The government of Tanzania is helping this project to start as soon as possible, so the only thing we have to wait for is the market force.

Girls are quitting school to work in virus-battered rural Asia

BANGKOK

ONE of the first cutbacks that many poor families consider during tough financial times is education for their daughters. During the pandemic with in-class learning shuttered, some girls in rural areas of Asia countries are being pushed to drop out.

Lina, an 11th-grade student in Cambodia who dreamed of obtaining an accounting degree, is among them. Her parents want her to leave school and find work to help the family pay down its debt. Lina's story was shared with Bloomberg by Room to Read, a non-profit organization that promotes literacy and gender equality in developing countries. The group changed her name to shield her identity.

To determine the impact of the virus outbreak on girls' education, Room to Read conducted a survey of 28,000 girls in Bangladesh, Cambodia, India, Laos, Nepal, Sri Lanka, Tanzania and Vietnam. It found that 42% of girls surveyed reported a decline in their family's income during the Covid-19 pandemic and that one in two girls surveyed was at risk of dropping out.

"When families can't afford school and have to choose, they will often send boys," said John Wood, founder of Room to Read. Financial hardships and cultural stereotypes about gender roles play a major part in keeping girls in less-developed countries from completing their education, he

Although the full scope of the problem isn't yet clear because many schools remain closed for inperson classes, groups that promote girls' education including the World Bank and the United Nations' agency UNICEF are closely monitoring the situation worldwide.

"More disadvantaged families are going to have particular struggles because of the economic impact. This will make it particularly difficult for them to send their children to school," said Toby Linden, the World Bank's education practice manager for East Asia and Pacific. "One of the lessons from the pandemic is the important role the families have in supporting their children's education."

This is expected to exacerbate the education deficit for girls in poorer countries, where the rate of female secondary school enrollment was low before the pandemic. It risks setting back years of progress for girls' education and gender equality in some of the world's poorest na-

The 2014 Ebola outbreak in West Africa showed how devastating a loss of income was to girls' education. Poorer families needed their children to make money during the crisis, and children who found work were rarely encouraged to return to school when it reopened.

The female education deficit is one of the key factors hindering women's workforce participation and their wages. An extra year of secondary school education for girls can increase their future earnings by as much as 20%. Barriers that prevent girls from completing 12 years of education and limited learning opportunities cost countries as much as \$30 trillion in lost lifetime productivity and earnings.

"The worrying trend is that the reopening of schools doesn't automatically mean that all children will be back in schools," said Francisco Benavides, regional education adviser at UNICEF East Asia and Pacific. "The pandemic has a high economic impact for the region. If girls don't have access to learning opportunities, it's very likely that the families and society will be less able to adapt to economic shock."

Educating girls also has been shown to lead to greater gender equality. For example, in Thailand, women hold 32% of senior management roles, compared with an average of 27% globally, according to Grant Thornton data published in 2020. They make up 24% of chief executives and 43% of chief financial officers. Although Thailand is an outlier, it shows what can be achieved when women are educated.

A green compliant ship recycling facility comes to South Africa

JOHANNESBURG

GROWING environmental and labour concerns in the global ship breaking industry present a desperate need for green compliant ship recycling facilities.

The global ship recycling industry is dominated by ship breaking yards in South East Asia. In 2019, approximately 90% of all obsolete ships ended up on beaches in India, Pakistan or Bangladesh. These ship breaking yards demolish obsolete vessels under rudimentary conditions through a practice termed "beaching."

Beaching inevitably pollutes the ocean and its surroundings and creates unsafe working conditions, as most of the work is done manually. The demolition of ships is a hazardous and labour-intensive process. It can present great risks to the maritime environment and to the labour rights of its employees if the vessel is not recycled in a safe and sustainable manner.

With a combination of changing environmental legislation and increased stakeholder pressure, green compliant facilities that offer competitive vessel purchase prices are gaining increased prominence in the global ship breaking industry.

The shift in the industry is further promoted by shipping companies implementing their own internal stringent ship recycling regulations that ensure that their end-of-life vessels are recycled in compliant facilities.


"We have audited and selected specific shipyards to recycle vessels up to our standard and have our own team on the ground to check if they operate in line with our policies," said Vice President of Chartering, Global Shipping Company.

This changing market dynamic will continue to open opportunities for certified green ship

recycling facilities in key locations. The planned ship recycling facility - 34South - located along the West coast of South Africa in the Saldanha Bay Industrial Development Zone offers a prime location for end-of-life vessels passing through the Cape of Good Hope and bypassing the tolls of the Suez Canal.

The 34South facility will maintain state of the art equipment by making use of a ship lifting system, ensuring that vessels are decommissioned in an environmentally safe manner compared to the rudimentary method

The ship lifting system will support a common user philosophy and can create economies of scale by accommodating more than one vessel at a time. The 34South planned facility is supported by the Industrial Development Corporation (IDC) of South Africa, as its largest shareholder.

ALTHOUGH pharmaceutical products are currently manufactured in countries such as South Africa, Kenya, Morocco and Egypt, as a whole Africa currently imports more than 80% of its pharmaceutical and medical consumables. It is unsustainable.

But as far back as 2007, the New Partnership for Africa's Development (now the African Union Development Agency, Auda-Nepad) sought to address Africa's overreliance on imports of pharmaceutical products when it developed the Pharmaceutical Manufacturing Plan for Africa (PMPA), as mandated in the Assembly of AU heads of state decision of 2005.

Pooled procurement

In 2012, the Assembly of Heads of State endorsed a PMPA business plan which consists of a package of technical solutions to some of the critical challenges confronting the continent's pharmaceutical industry.

Some of the proposed solutions include strengthening the regulatory systems and establishing a one-stop-shop for information, data and business intelligence for industry players-governments, the private sector, regional economic communities and so on. To boost local pharmaceutical production and

in turn improve public health outcomes, the PMPA business plan strongly encourages the

procurement of medical products from Africabased companies. In addition to strengthening the procurement

and supply chain management systems, the plan recommends the use of pooled procurement as a mechanism to incentivise local manufacturers to address maternal, new-born and child health. Improved access, quality, availability and affordability of pharmaceutical products, as well as increased economic benefits through sustainability, competitiveness, and self-reliance of the industry, are some of the objectives of the business plan.

Challenges

The PMPA business plan underscores the urgency in addressing the challenges facing the industry. One such challenge is a lack of affordable financing and modern technology, which hampers business expansion. Other challenges are Africa's small fragmented markets and weak regulatory frameworks.

Inadequate human resource capacity also impedes the growth of Africa's pharmaceutical sector as do poor procurement and supply

chain systems and policy incoherencies in countries' trade, industry, health, and finance departments. Due to a lack of financial capacity, companies make little or no investments in research and development and in protecting intellectual property.

No single company, government department or organisation can by itself address these challenges; it is precisely why the PMPA business plan advocates for multisectoral and multistakeholder collaboration. The good news is that some opportunities are available to be explored.

For example, the African Continental Free Trade Area (AfCFTA), if successfully implemented, will address the challenge of small fragmented markets that have for a long time disincentivised pharmaceutical manufacturing

African manufacturers, currently operating in small fragmented markets, cannot compete with their Asian counterparts that operate in vastly larger markets and therefore enjoy economies of scale. Economies of scale help businesses save money due to higher production volumes.

When all African countries ratify the AfCFTA, it will integrate a market of 1.3-billion people and potentially 2.2-billion people by 2050. African manufacturers can be expected to enjoy significant economies of scale and scope. Free trade under the AfCFTA should begin in January 2021. A pooled procurement mechanism encourage leading global generic

pharmaceutical manufacturers to build plants in Africa or partner with African pharmaceutical companies to manufacture generic products. There is a need for this form of strategic support for Local Pharmaceutical Production (LPP).

Russia and Bangladesh are examples of countries that have deliberately and successfully supported the development of LPP. As a result, these countries have experienced an increase in foreign direct investments in the sector. They have also benefited from training and skills development, accelerated technology transfer and job creation.

Inadequate human resource capacity also impedes the growth of Africa's pharmaceutical sector as do poor procurement and supply chain systems and policy incoherencies in countries' trade, industry, health, and finance departments.

Africa should be expected to reap these kinds of benefits were it to fully embrace strategic support for LPP. Besides, it would compel countries to strengthen regulatory systems. Already African manufacturers of pharmaceuticals have been brought into a federation to enable them to share information and business intelligence and to have a unified voice. And plans are underway to establish a fund for the sector, which will cushion companies' financial inadequacies.

US President Donald Trump paid extremely little in income taxes in recent years as heavy losses from his business enterprises offset hundreds of millions of dollars in income, the New York Times reported on Sunday, citing taxreturn data.

The Times reported that Trump, who is seeking re-election in November, paid just US\$750 in federal income taxes in both 2016 and 2017, and paid no income taxes in 10 of the last 15 years, despite

receiving US\$427.4 million through 2018 from his reality television programme and other endorsement and licensing

Trump was able to minimize his tax bill by reporting heavy losses across his business empire. The Times reported Trump claimed US\$47.4 million in losses in 2018, despite claiming income of at least US\$434.9 million in a financial disclosure that year.

Trump denied the report on Sunday, calling it "total fake news" at a White House news conference.

LONDON'S world-famous Big Ben clock tower is about to become visible for the first time in three years after a multimillion dollar face-lift project completed a critical phase, authorities at the Houses of Parliament announced on Sun-

The chiming clock in the Elizabeth Tower, one of the most photographed structures in the world, has been shrouded behind scaffolding and screens due to the intricate renovation work.

Over the course of the next six weeks, the newly restored tower will slowly be revealed. An expert team of scaffolders will work to take down the metal scaffolding in the restricted space around the Tower.

"Three years after the structure was scaffolded, this is a significant moment in the timeline of this complex conservation project," said a spokesperson for the parliamentary

Lindsay Hoyle, speaker of the House of Commons, said: Like everyone else, I have been looking forward to seeing the scaffolding come down on Elizabeth Tower, so the un-

veiling of the roof will be a memorable moment." Extensive work has restored both the inside and the outside of the Elizabeth Tower, including the 3,433 roof tiles and the spire with its intricate flowers, cross and orb. The conservation work addresses crucial problems in the tower, including crumbling stone and a leaky roof.

The tower's signature metal cross and orb, which sits 96 meters above ground level, has also been repaired, with a team of expert gilders spending weeks to ensure the ornate details match the original design from 1859.

The Big Ben tower is a focal point of the culturally-protected Palace of Westminster which forms a part of a UN-ESCO World Heritage Site. Xinhua

Amid declining COVID-19 infections

and fatalities in Egypt, the country resumed international flights on July 1, after they had been suspended since March, as part of a coexistence plan to maintain anti-coronavirus precautionary measures while resuming econom-

"More than 250,000 tourists from 15 countries have visited South Sinai and the Red Sea since the return of tourism and flight resumption on July 1," the tourism minister told reporters in Sharm el-Sheikh.

Al-Anany said he was proud of the country's earnest implementation of the anti-COVID-19 precautionary measures at airports, hotels and tourism facilities, noting that he has recently vis-

ited several countries to reassure them about the safety of tourism in Egypt.

Egypt's tourism sector, a main source of national income and foreign currency for the country, has been greatly affected by the lockdown over the COVID-19 pandemic. Egypt's tourism revenues hit a record high of 13 billion U.S. dollars in 2019.

Those working in the tourism field in Egypt had mixed feelings of hope for tourism recovery and happiness with its gradual return after nearly five months of suspension.

G20 leaders to hold virtual summit during Nov 21-22

THE G20 leaders summit will be held virtually during Nov 21-22, Saudi Arabia said yesterday, as the COVID-19 pandemic thwarted Riyadh's hopes of hosting the gathering in the kingdom to boost its international standing.

The summit will be chaired by Saudi King Salman bin Abdulaziz Al Saud, the Saudi G20 presidency said in a statement.

According to the statement, the Saudi G20 presidency will "build on the success of the extraordinary virtual G20 Leaders' Summit held in March and on the outcomes of over 100 virtual working groups and ministerial meetings.'

Under the theme of "Realizing Opportunities of the 21st Century for All", the summit will focus on protecting lives and restoring growth by addressing vulnerabilities uncovered dur- ments due this year.

ing the pandemic and by laying down foundations for a better future, according to the statement.

Saudi leaders had hailed the kingdom's G20 presidency as proof of its leading role in the global economy, but the majority of the meetings have been held virtually due the novel coronavi-

G20, the world's premier platform for international economic cooperation, is leading the fight against the global COVID-19 pandemic.

"The G20 has contributed over US\$21 billion to support the production, distribution and access to diagnostics, therapeutics and vaccines," the statement reads.

Cooperation key to prevent global recession

INTERNATIONAL cooperation is a crucial driver of global growth and a key solution to preventing the global economy from falling into a deep recession, senior economists

The global economic outlook has been dimmed by the COVID-19 pandemic, and this has seriously disrupted business and social activities as the virus has not been effectively and fully controlled globally

Major international agencies and some economists have raised their forecast on global growth this year, given the better-than-expected recovery pace, but they warn that the global economy still faces immense uncertainties and the international community may experience the worst economic recession since the World War II if governments fail to adopt effective policies.

Boosting international cooperation and collaboration among governments is the only way out for the global economy, said Chen Wenling, chief economist at the Beijingbased China Center for International Economic Exchanges.

Chen warned that the global economy is threatened by risks including high debt levels, high government leverage ratios, the possibility of ruptured global supply and industrial chains and a rising unemployment rate.

"Countries around the world face a critical test, which is whether we can reach consensus that international cooperation is the biggest driver of global growth and a key solution to preventing the economy from falling into a deep recession," Chen said on Friday at the sixth Global Think Tank Summit, held by the China Center for International Economic Exchanges. Forum participants shared that view and called for greater international collaboration in pressing for technological innovation and breakthroughs to fight the ongoing pandemic and to inject fresh impetus into global economic growth.

Wang Yiming, a senior economist and a member of the National Committee of the Chinese People's Political Consultative Conference, said countries should accelerate cooperation in the digital economy and promote green development, which are two important drivers of the global economic recovery.

Wang also said countries should make full use of multilateral platforms, including the International Monetary Fund, the World Bank and the G20, to strengthen dialogues and resolve debt and financial risks globally.

The United Nations Conference on Trade and Development said in its latest report that the global economy is likely to contract by 4.3 percent this year and the contraction will leave global output by the end of the year over US\$6 trillion short of economists' expectations before the COVID-19 pandemic. That contraction and shortfall would be the equivalent of a complete wipeout of the Brazilian, Indian and Mexican economies. The UN agency also warned that global trade will shrink by about one-fifth this year and foreign direct investment flows by up to 40 percent.

Liu Yuanchun, vice-president of Renmin University of China, said at the forum that the technological revolution is one of the most crucial factors for the world to escape a lasting standstill in economic growth and countries need to break barriers and remove frictions that have arisen in trade, digital governance and the competition for talents.

Supporting development of nuclear industry is Russia's priority - PM

MOSCOW

RUSSIAN Prime Minister Mikhail Mishustin congratulated the nuclear industry workers on their professional holiday and assured that support for the industry is an absolute priority for the state.

"The nuclear industry is one of the key sectors in the Russian economy. Supporting and developing it is an absolute priority for the state," he said in an address written to mark



the 75th anniversary of the nuclear industry.

Mishustin (pictured) noted that the industry fulfills strategic tasks related to the country's energy security and its defense capabilities, makes Russia a leader in the world market, makes it possible to apply innovative technologies and developments in all spheres of human life - from nuclear medicine to nuclear icebreakers, and floating nuclear power plants.

He thanked the veterans of the nuclear industry, who laid down the industry's traditions and pass them on to the new generations of Russian nuclear workers.

Hegemonic practices will not last long

US Supreme Court nominee Barrett would have final say on recusal calls

WASHINGTON

Democrats are urging U.S. Supreme Court nominee Amy Coney Barrett to recuse herself from any election-related cases because of President Donald Trump's comments that he expects the justices to potentially decide the outcome, but there is no way to force her to do so.

Although U.S. law requires justices to step aside when there is a conflict of interest or genuine question of bias, it leaves the individual justice to decide whether such a conflict exists. Aside from direct financial and personal conflicts, they rarely do so.

Trump on Saturday nominated Barrett to the vacancy created by the death of liberal Justice Ruth Bader Ginsburg on Sept. 18. If confirmed by the Republican-controlled U.S. Senate, Barrett would give the court a 6-3 conservative majority.

On Wednesday Trump said he wanted the full complement of nine justices on the court as soon as possible in part because he believes the court will determine the outcome of the Nov. 3 presidential election.

"I think this will end up in the Supreme Court, and I think it's very important that we have nine justices," he told reporters at a White House event.

The Supreme Court has determined the outcome of a U.S. presidential election only once, in 2000, leading President George W. Bush to the White House.

Trump indicated that the Supreme Court would rule in his favor with nine justices on board. He alleged they would respond to an unspecified "scam that the Democrats are pulling" in relation to increased use of mail-in ballots as a result of the coronavirus pandemic.

Trump has repeatedly and without evidence attacked mail-in balloting, a longstanding feature of U.S. elections.

'ETHICAL COMPLICATION'

Senate Democrats say they will probe Barrett on the subject during her confirmation hearing before the Senate Judiciary Committee in the hope she will pledge to step aside in election-related cases.

Democratic Senator Cory Booker, who serves on the committee, said on Sunday he would ask Barrett about recusal when he meets her.

"If she does not recuse herself, I fear that the court will be further delegitimized," he said on NBC's "Meet the Press.'

There are no indications Republican senators share those concerns. with Republican Senator Mike Lee, speaking on ABC's "This Week," saying that recusal decisions would be up to Barrett.

During previous Senate hearings, Supreme Court nominees have routinely declined to commit on how

they would approach cases that could come before them. Federal law requires a justice to

step aside from cases "in which his impartiality might reasonably be questioned." In a 2011 report, conservative Chief Justice John Roberts said he had "complete confidence in the capability of my colleagues to determine when recusal is warranted."

US Supreme Court nominee Amy Coney Barrett

Legal experts told Reuters that under the way the law has been interpreted up until now, the new justice need not recuse herself from any election issue.

But New York University School of Law legal ethics expert Stephen Gillers noted that should a decisive election issue come before the justice, Democratic candidate Joe Biden could be justified in filing a motion asking her to recuse.

"I believe that would be a persuasive argument in this unique circumstance," he said.

He noted that in 2000, when the Supreme Court decided the election in favor of Republican Bush, none of the justices were appointed by either candidate, although Democratic candidate Al Gore was vice president to President Bill Clinton, who appointed both Ginsburg and Justice Stephen Breyer.

This time, there would be three justices on the bench appointed by Trump himself.

Both liberal and conservative justices have been pressed by critics in the past to recuse themselves in cases with perceived conflicts. Litigants can file motions seeking recusal but rarely

In 2004, the Sierra Club environmental group asked conservative Justice Antonin Scalia to step aside in a case concerning then-Vice President Dick Cheney, a friend of the justice. Scalia refused, saying his impartiality could not reasonably be questioned.

During the 2016 presidential race, liberal Ginsburg criticized then-candidate Trump as a "faker," prompting cries by conservative critics of bias. Ginsburg later expressed regret for her remarks but did not step aside from any case involving Trump.

Despite calls from some conservatives for her to recuse herself, liberal Justice Elena Kagan participated in a 2012 ruling upholding President Barack Obama's Affordable Care Act the healthcare law dubbed Obamacare. Kagan had served as Obama's top Supreme Court advocate when the law was enacted in 2010 but said she played no role in its conception.

Kagan, appointed to the court by Obama in 2010, recused herself from other cases on which she had worked in Obama's administration.

Justices routinely step aside when they have financial conflicts, such as owning stock in companies with cases before the court.

It is important to focus efforts on the construction of innovation systems so as to overcome such problems as decentralization, inefficiency, and repetition. The country should also optimize the allocation of superior resources, and advance research on core technologies in important areas.

The Finals are set: LeBron, Lakers will meet Butler, Heat

LAKE BUENA VISTA, Fla.

LeBRON James vs. the Heat.

Pat Riley vs. the Lakers.

Get ready for the NBA Finals – a title series like none other, to end a season like none other.

The matchup is set, with the Miami Heat and the Los Angeles Lakers emerging as the last two teams standing in the chase to be crowned champions of the most tumultuous season in NBA history. The Heat won the Eastern Conference title Sunday night, finishing off Boston a day after the Lakers won the Western Conference crown.

So, for the first time – well, excluding the league's inaugural season – two franchises that missed the playoffs the previous season will meet in the NBA Finals. Game 1 of Heat-Lakers is Wednesday night at Walt Disney World.

"We know why I came here," said Lakers All-Star forward Anthony Davis, whose first finals trip comes in his first L.A. season. "We want to win a championship. We're four wins away, a step

 $James\ is\ bidding\ for\ a\ fourth\ NBA\ championship,\ as\ well\ as\ a\ title\ with\ a\ third\ different\ franchise$ – and he's about to become the first player to win a Finals MVP award with one team and then face that same team in a future championship series. His first two titles were with Miami in 2012

and 2013, the highlights of a four-year stint with the Heat that ended in 2014. That, not coincidentally, was the last time the Heat had reached this stage. James left to return to Cleveland earlier than the Heat figured he would, Chris Bosh began his fight with blood clots – a condition that ended his career – not too long afterward and Miami descended from magnificent to mediocre in a hurry.

No more. With a young core led by Bam Adebayo and Tyler Herro, the veteran savvy of Goran Dragic and the addition a year ago of Jimmy Butler the Heat got back to title contention quicker than probably anyone envisioned, themselves included.

Then again, Riley - who won four championships in a seven-year span as coach of the "Showtime" Lakers – isn't known for patience.

He thinks big. That's why he and the Heat landed James and Bosh to play with Dwyane Wade in 2010. That's why they got Butler in 2019, even when the team had no free-agent money to spend. That's why they swung a deal to add Andre Iguodala, Jae Crowder and Solomon Hill in February, trading them for Justise Winslow, James Johnson and Dion Waiters; Waiters, oddly enough, ended up with the Lakers and will now face the Heat in this title series.

"To fit in here, you've just got to care about winning," Butler said earlier in this playoff run. "That's the No. 1 thing. Trying to win a championship. And we've got a group of guys that want that, night-in, night-out, every single day. There's only one goal in our mind, and that's to win it." The Lakers have that same goal, of course.

Their motto in these playoffs has been "Leave A Legacy," a nod to the great Kobe Bryant – the Lakers legend who died, along with his daughter Gianna and seven others, in a helicopter crash on Jan. 26. The last Lakers' championship was in 2010, when Bryant got his fifth and last title. James has been in the finals every year but once since. There never was a LeBron vs. Kobe finals, to the dismay of many, but in its place comes a finals trip where James and the Lakers will play with Bryant in very much in mind.

At Fenerbahce, Samatta has chance to do a Romelu Lukaku somersault

CHANGE was in the air for Tanzania's senior national football team 'Taifa Stars' captain, Mbwana Samatta, as it became clear that he would have little playing time at his English Premier League club side of Aston Villa, and he more or less promptly joined famed Turkish soccer club, Fenerbahce S.K. on a 12-month loan.

While the record keepers have a thing or two to say as to this speedy loan transfer, it must at least be said that outwardly it looks quite remarkable, as players spend months -at times yearson the bench.

It is not just because he was available but top clubs wanted him on Aston Villa terms, first.

Local reports said other details of the loan remain sketchy still but it will cool nerves for his local fans after Aston Villa went on a spending spree after they narrowly avoided relegation.

While the other point of note in the preliminary local review of the transfer underlined that reports from Istanbul say the striker, who spent the past six months at Villa Park, will wear jersey number 12 at his new club, a rapid check showed something different.

It has to do with naming of the squad. The squad players were named on an online blog as (26) Marcel Tisserand, (37) Filip Novak, (4) Serdar Aziz, (32) Zanka, (35) Nazim Sangaré, (3) Mauricio Lemos, (20) Luiz Gustavo, (7) Ozan Tufan, (23) Deniz Türüc, (8)Mert Hakan Yandas, (5) José Sosa, (6) Tolga Cigerci, (10) Mbwana Samatta, (11) Garry Rodrigues, (16) Ferdi Kadioglu, (13) Enner Valencia, (27) Mame Thiam.

The list leaves a guessing problem on its significance, as jersey number 12 did not say much on the player's significance at the Turkish hard battling side, unlike this list which suggests that Samatta is lined up for number 10, but as some numbers are



not positions, it can be so affirmed.

Yet from this citation alone, and the brouhaha around Mbwana losing a regular or even assured substitute position at Villa Park and the rush with which the Turkish giants went for his signature if only on loan says a few things about how well he is rated there.

That cannot be surprising as the Turkish premier league is in a sense comparable to the Belgian premier league where Samatta was playing earlier, in which case he is likely to be seen as a dependable front striker there.

With any luck and evidently with plenty of effort he could still produce a rare sparkle by that transfer.

There is also an interesting display of speed with which the new player was being accustomed to being part of the team, where a club Twitter page showing the number of jersey he will wear throughout the loan period was accompanied by words of welcome.

More significantly, the video is reported to begin with a journey on Istanbul metro train heading to Fenerbahce's headquarters 'and later shows the door to its ükrü Saraco lu Spor Stadium opening leading he has achieved everything, to the changing rooms', and then to the Fenerbahce's and more. People keep asking

locker room with jersey number 12 hanging with Samatta's name on it.

How long does it take here to print a jersey with the player's name on it? A month?

This transfer definitely underlines where the player's more comfortable playing environment is likely to be, that is, in 'Serie B' premier leagues in Europe, having advanced above the upper limit in DR Congo's TP Mazembe in what were agewise probably his best playing days, that is, from age 22 to 24 when he moved to KRC Genk then at 26 shifted to Villa Park, and now, before clocking 28 takes the metro train at Istanbul.

Clearly for a local player

whether Mbwana's level of play is rather inadequate for having failed to maintain a regular playing positionand even expected regular substitute - at Villa Park, but the competition tells a better story. The local newspaper reporting the shift said the club went on a 'spending spree' having just avoided relegation, and in that context it is clear Samatta would not be an object of transfer for an English Premier League (EPL) side on spending spree.

He was recruited for a paltry 8.5m pounds, whereas recent recruits include a 17m pounds transfer from Olympique Lyon, a side that reached the semi-finals of the UEFA Champions League in the past season.

Another is a 30m pounds transfer and a 24m pounds signing, one of whom was England young footballer of the year (golden boot) in previous season. Samatta succeeded to arrive at the EPL, not to stay there.

Yet the player is not off the radar yet, as he can be counted upon to make some headlines there, much as it is a little out of the main theatre of local soccer interest, focused on the EPL, the Champions League and Europa League.

Many will now start looking at the Turkish premier league owing to the player, which improves our level of cultural globalization, uplifts the betting a bit, and may as well see him in European circuit at whatever chase or stage. 'Watch this space.'

AT MANCHESTER CITY, there had been a growing acceptance that signing Messi for free was impossible, so they turned their attention to a negotiated settlement. After several days of crunching numbers, a source told ESPN that "if Barcelona let him leave for €100 or 150m, Messi will be a City player." City were also willing to include players of interest to Barca, such as young defender and La Masia product Eric Garcia, in a deal, although ESPN was told that others, including Gabriel Jesus, Bernardo Silva and Rivad Mahrez, would not be included.

All of that depended on Barca being willing to budge. Messi waited and maintained his silence, even skipping coronavirus testing ahead of a return for preseason training with new coach Koeman. Board members who'd been critical of Messi felt he should be fined for that; Bartomeu believed doing so would escalate the crisis. As Barca drafted burofaxes of their own to correspond with their absent captain, sources told ESPN that some versions specified that there would be no punishment, while others left the option open.

On the morning of Sept. 2, Messi's father and agent, Jorge, flew from Rosario, Argentina, to Barcelona for a meeting with Bartomeu that evening, but no progress was made. Bartomeu had one important thing as leverage: Messi could not stomach a legal battle. He was determined to leave, but not if the process descended into lengthy litigation. City were reluctant to take that road, too.

Everything changed on Sept. 4. In an interview with Goal's Ruben Uria, Messi announced his decision to stay. "The president told me the only way to leave was to pay the €700m clause, which is impossible, and that the alternative was going to court," Messi said. "I would never take Barca to court because it's the club I love."

Manchester City defence exposed by Leicester City, but help is on the way

MANCHESTER

MANCHESTER City are fortunate they have already agreed a deal for Ruben Dias because Benfica might have been tempted to put the price up after Jamie Vardy ran riot in Leicester's 5-2 victory at the Etihad Stadium.

Dias is set to move to Manchester in a deal that will cost around €71 million while Nicolas Otamendi is heading in the opposite direction in a separate agreement worth around €15m. For Pep Guardiola, it cannot be completed quickly enough.

Against Leicester, he watched City lose their opening home game of a top-flight season for the first time since 1989. He also watched Vardy turn it on against his team again.On a day when Guardiola was forced to start without a recognised striker because of injuries to Sergio Aguero and Gabriel Jesus, Vardy showed the value of a bona fide poacher. He scored three times -- two from penalties he won himself -- to take his tally against Guardiola's City to nine. No player has scored


"We struggled with Vardy," said Guardiola afterwards in an early attempt at understatement of the season.

It looked like City were heading for a routine home win when Riyad Mahrez scored against his former club after three minutes with a spectacular strike which arrowed into the top corner. Then Vardy took over.

Ten minutes before half-time, the 33-year-old was bundled over after a clumsy challenge from Kyle Walker and dispatched the penalty high into the net. His second shortly after half-time was the best of the lot.

He looked short of space when Timothy Castagne's low cross from the right reached him at the near post but it didn't matter as he produced an impudent flick to lift the ball over a bemused Ederson. Vardy's third was another penalty as City failed to deal with his lightening movement again and Eric Garcia -- having a good game up until that point -- clipped his heels. This time he went to Ederson's right to become the oldest player to score a Premier League hat trick since Teddy Sheringham in 2003.

James Maddison came off the bench to make it four by beating Ederson from 20 yards and although Nathan Ake pulled one back with his first City goal, Leicester made it 5-2 with their

third penalty of the afternoon after Benjamin Mendy had fouled Maddison. Vardy had already limped off so the responsibility fell to Youri Tielemans to ensure Leicester became the first team to score five goals against a side managed by Guardiola in his 686 games as a coach. Leicester, meanwhile, are top of the league after three wins from three.

"We played really good in the first 30 minutes," said Guardiola. "We scored early on and I think they defended so deep, so it was not easy.

"In this situation it happened many times so we have to control the counterattack and I think today the problem was that we put extra pressure on ourselves to score the second or third one when they just didn't want to play, they just wanted to defend and play on the counter-attack and just in that position we have to be

"Of course when you have the players to attack the box that we need. We were anxious to attack and say we are not creating chances, we got nervous and after we gave three penalties away. And when you do that you cannot do it."

Guardiola will hope the solution to his problems is already on the way. City looked at Napoli's Kalidou Koulibaly and Atletico Madrid's Jose Gimenez to strengthen the defence but after being put off by the price tags, director of football Txiki Begiristain has instead turned to Dias.

The Portugal international has been scouted by Manchester United in the past but City are the ones who will prise him away from Benfica -- helped in part by their willingness to take Otamendi.

Aymeric Laporte will help, too. The Frenchman is yet to play this season sorts of problems. after testing positive for COVID-19 over

the summer and was only fit enough for a place on the bench against Leicester. After another full week of training, he can expect to be back in the team for the trip to Leeds United on Saturday. Judging by Guardiola's almost constant instructions to Ake, the Dutchman -- a £40m signing from Bournemouth -- is taking time to get up to speed.

It didn't help Ake and the rest of the defence that Guardiola decided to swap Fernandinho for 17-year-old striker Liam Delap with the score at 1-1 but the Spaniard cannot be held responsible for the absence of basic defending. All three penalties were conceded after his players got the wrong side of a Leicester attacker.

Asked after the final whistle about Dias' impending arrival, Guardiola said: "It's not official. Let me wait until it's official, then I'll give you a statement." After a disastrous day, he will hope it's sooner rather than later.

Meanwhile, Manchester City manager Pep Guardiola has criticised Leicester's tactics after seeing his team suffer a 5-2 home defeat.

City dominated after former Leicester midfielder Riyad Mahrez gave them an early lead but their game plan crumbled after Jamie Vardy netted a 37th-minute penalty.

"They didn't want to play, they

defended so deep and just wanted to counter-attack," Guardiola said after seeing a side he has managed concede five goals for the first time in his 686th game in charge. "They scored the first time they arrived

Suarez enjoying new lease of life after stunning Atletico debut

LUIS Suarez said on Sunday he needed a change when he left Barcelona after marking his Atletico Madrid debut with two goals and an assist.

Suarez's sensational 20-minute cameo came as Atletico started their La Liga season with a thumping 6-1 victory over Granada.

He set up a goal two minutes after coming on as a substitute, his sumptuous pass finished off by Marcos Llorente, before scoring himself with a powerful header at the back post.

The 33-year-old then added another in injury time, following up his own shot to make it six for a rampant Atletico at the Wanda Metropolitano.

"Sometimes it is important to have a change as a player," said Suarez.

"I've come to a club that has given me a spectacular welcome, it shows in the atmosphere, you get a good impression from the beginning, and you can see that on the pitch."

Diego Costa said with a smile: "It's great. One of us bites, the other one hits."

Costa had earlier given Atletico the lead but it was the 31-year-old who made way for Suarez, and he raised doubts about his future after the match.

"I leave my future up to the club. I spoke with the club, with the coach, I made it very clear what was happening, that if I am here, I will fight," said Costa. "If they see the possibility of me leaving, I'll ac-

IN a last-minute ruling, a Brazilian court overturned an earlier decision and allowed a league match featuring top club Flamengo to go ahead Sunday, despite 19 players testing positive for coronavirus. The ruling, which came 10 minutes

before kickoff, was the latest twist in a dramatic saga around the match between Rio de Janeiro-based Flamengo, the reigning Brazilian league and South American champions, and Sao Paulo side Palmeiras.

Despite being forced to call up a raft of emergency substitutes from their under-20 side, Flamengo managed to hold their rivals to a 1-1 draw.

The match almost didn't happen. On Saturday, the labor court for the state of Rio de Janeiro suspended the fixture, ruling it was impossible to guarantee that more Flamengo players and staff were not infected.

But the Brazilian Football Confederation appealed, arguing the outbreak at Flamengo was "an isolated incident that cannot be attributed to the Brazilian Football Champion-

Federal labor judge Vieira de Mello Filho ruled the Rio de Janeiro court had "exceeded the limits of its jurisdiction," given that the match was being played in Sao Paulo.

Both clubs had already headed to the stadium in case the match went ahead. Flamengo, Brazil's wealthiest club, had joined far-right President Jair Bolsonaro in pushing for the resumption of play after football was suspended for the pandemic.

But when hit by a massive outbreak of Covid-19, they changed their tune, seeking to have the Palmeiras match postponed.

Flamengo were already forced to use multiple substitutes at their last match, against Ecuadoran club Barcelona Tuesday for the Copa Libertadores, after seven players tested positive for the virus, where the Brazilian club nevertheless won 2-1.

They faced a flurry of criticism when pictures emerged showing players socializing onboard the club plane without face masks, even as more positive test results rolled in.
