Saudi Fund issues a \$13m loan for transmission line

THE Saudi Fund for Development (SFD) has issued a \$13m loan (32bn/-) for the construction of Benaco-Kyaka power transmission line connecting Kagera Re-

gion to the national grid.

Treasury permanent secretary Dr Natu El-Maamry Mwamba signed the accord yesterday in the Saudi capital of Riyadh, with Sultan Almsarshad, the SFD executive director.

The ceremony was held on the sidelines of the Saudi-Arab-African Economic Conference bringing together financial, business and investment executives from the public agencies, the private sector, trade blocs, international organizations, opinion makers and think tanks.

The 32bn/- loan agreement will facilitate construction of a 220kV transmission line from Benaco in Ngara District to Kyaka, Bukoba District (166.17km) and

Airports agency starts to run KIA

From 2010 KADCO ran the airport through the leasing agreement whose legal validity has expired

OPERATIONS at the Kilimanjaro International Airport (KIA) have been taken

over by the Tanzania Airports Authority (TAA) after 25 years of the Kilimanjaro Airport Development Corporation

Last week, MPs asked the government to inform the legislature why KADCO was still operating at KIA while its contract

has ended. Transport minister Prof Makame Mbarawa tabled a report on the move. saying KADCO, a company registered on 11 March, 1998 under the Companies Act, Chapter 212 of the laws of Tanzania, was handed the KIA operational franchise as part of the privatisation policy during the third phase government.

"The government decided on July 6, 1998 that KIA operations be run by the private sector," he said, explaining the decisions as relating to high running costs for the airport "as the Tanzania

buses found violating traffic regulations, including speeding.

LATRA director general Habibu Suluo told journalists in Dar es Salaam yesterday that the fining will be done via a vehicle tracking system (VTS) to be installed in all buses.

This will greatly help to prevent accidents triggered by speeding during the end year festive season, he said, affirming that the government via its agency, the traffic police division, has been working hard to fight reckless driving "but some drivers are still averse to adhere to the rules."

Many buses are now caught speeding on the road especially since the government allowed 24 hour travel services, he said, suggesting that automatic fining well boost safe journeys.

Drivers who will be found speeding will fall into automatic fines paid electronically through the government control number, he stated, insisting that the mechanism is for monitoring, recording and imposing fines directly.

Before commencement of the new modality, LATRA and the traffic police will convene a meeting with bus operators "to inform them on the decision and how it will be implemented," with envisaged fines set at 30,000/- to 50,000/- for reach recorded mistake.

LATRA has suspended transportation licenses for 36 upcountry passenger buses and licenses of ten drivers for allegedly tampering with the VTS apparatus leading to relaying false information or incomplete reports.

"In the one month period since night travel services started, out of 246 buses with permits to travel during night, 197 have a speeding challenge," he said, noting night travel without acute measures can lead to more disasters.

In total 756 buses have been found tampering with the VTS including day time buses, to which traffic police commander SACP

Ramadhani Ng'anzi said the force will not remain silent as speeding claims lives and imputes disability.

In the operation, police officers caught 666 buses in excessive speeding and the drivers punished with fines. 50 were issued warnings while 32 were hauled to court and cases are proceeding, he stated.

Drivers whose licenses were suspended will be required to sit for an examination at traffic police premises before being handed back their licenses.

"The automatic fining system will be of great help as it will exert pressure on bus drivers to be vigilant while they are on long trips," he said, underlining that the safety of passengers is uppermost.

Priskus Joseph, the Tanzania Bus Owners' Association (TABOA) secretary general, commended LATRA for the measures that they are taking to halt reckless driving, intimating that the bus owners will heighten own controls.

He appealed to LATRA too avoid revoking bus operating licenses but deal with the drivers as they are responsible for the wrongdoing.

"Punishing owners for drivers' mistakes isn't good, so we call upon LATRA to think on this in order to enable the public to obtain transport services more reliably," he

Airports Authority (TAA) was not established by then."

KADCO and the government entered three contracts also involving a shareholder and a leasing agreement, he said, elaborating that on May 14 2009, the government decided to buy shares in KADCO and that eventually KIA should be handed over to TAA. "From 2010 KADCO ran the air-

port through the leasing agreement whose legal validity has expired," he stated.

"As KIA is owned by the government through TAA and the contract for running the airport has ceased, KIA will now be run by TAA as Parliament demanded," he declared.

KIA is the third busiest airport the shareholders rejected any after the Julius Nyerere International Airport (JNIA) and the Abeid Amani Karume International Airport, and the gateway to the country's main safari tourism hotspots in the northern circuit.

Informed sources said that sometimes in the past the government sought a review of the terms of the concession agreement, but amendments.

In 2009, the government decided to buy out the shareholders of the company and acquired 100-percent ownership of KADCO.

It remains unclear how much the government actually paid the shareholders to relinquish statutory control of the company, interviewed officials intoned.

ACTIVISTS on women's rights, gender equality, democracy and leadership have underscored the need to review election laws so that they are gender-sensitive, thus creating a safe environment for all candidates especially women with disabilities.

They made the appeal yesterday when speaking in Dar es Salaam at the four-day 15th gender festival, which is in line with celebrating 30 years of Tanzania Gender Networking Programme (TGNP) Transformative Feminist Movement.

The activists called on the government through the Ministry of Constitution and Legal Affairs to send various election laws to the National Assembly for review.

Presenting the Declaration of Women's Claims in the 2024/2025 Election prepared by the Women and Leadership Network, facilitator from TGNP, Deogratius Temba said the network and other stakeholders have already submitted proposals

conducted studies to identify policy, legal and systemic shortcomings, which prevent women from fully participating in leadership and decisionmaking positions. We hope that if changes are made, we will remove obstacles for women, young people and people with disabilities to participate in elections as candidates and voters," said Temba.

He added: "This manifesto is aimed at calling on the government, institutions and all bodies involved in elections to be responsible for complying with agreements, protocols, international and regional declarations as well as the

for amendments to the laws to the constitutional principles specified in the National Vision 2025, to take deliberate steps to remove obstacles that perpetuate discrimination in our participation in elections as voters, or candidates vying for various competitive positions and finally, to be eligible to participate in leadership in various aspects of our society."

Temba added that the laws they proposed to be amended include the Election Law (CAP.343) (R.E.2015) which does not emphasize the implementation of the principle of equality in the selection of candidates by political parties without transparent criteria, and the observance of the principle of equality specified in the law of political parties.

On Special Seats, he said the system introduced the basis of discrimination women against

who entered parliament through it, adding this system. The Ministry should take into account the ethical recommendations of the system as included in the Constitution proposed by the Special Assembly in October 2014. With the Law on Election Expenses (CAP 288 (R.E 2015)) which burdens all candidates with the burden of expenses, regardless of economic differences between women and men.

He said that another law that requires a review is the Political Parties Act (CAP 258 (RE 2015).

He said Despite the relevant law specifying the basis of gender equality as a pillar to strengthen democracy, it has not specified the responsibility of political parties in implementing the outlined basis in the leadership of the relevant parties and the selection of candidates.

housing credit for low,

This follows the release of a report on Housing Microfinance Tanzania-2023 showing that the majority of Tanzanians (70 percent) are not living in decent houses due to poor access to low interest loans.

Conducted by Habitat for Humanity International (HFHI) and Tanzania Mortgage Refinance Company (TMRC), the study aimed to dig deep and to understand low-income that barriers households' face in accessing affordable housing finance in the country.

Speaking during the launch of the report in Dar es Salaam vesterday, HFHI country director, Fortunata Temu said that creating the soft loans for the low-income Tanzanians and those working in the informal sector will enable them to easily purchase affordable and decent houses as well as build or upgrade their homes.

"Many lenders are currently putting high amount housing loans which exceeds 50m/- but many low- and middle-income earners can afford to take and repay small loans from 1m/- to 10m/-, so this is what we are trying to push and encourage financial institutions to think on this group," she said.

The situation pushes low income earners to fall into exploitative loans in the streets which are not formal things which do not help them improve their lives but rather push them into poverty due to high interest rates and harsh conditions of the loans.

She noted that Tanzania has one of the fastest growing economies in the world, however many families still struggle to access adequate and affordable housing.

and middle-income "Low-Tanzanian households face a number of housing challenges, including insufficient housing supply, overreliance on insecure, inadequate self-build informal housing, rising building materials costs, irregular income making it harder to plan for housing-related spending and/or access housing finance, and difficulties servicing outstanding loans," she said.

TMRC chief executive officer, Oscar Mgaya said that the two firms are working hard to engage financial provisions of short-term housing loans to low-income earners in

Building on the foundations of housing finance set up by the World Bank and International Finance Corporation for the promotion of housing finance for low-income families through TMRC, Habitat for Humanity's support aims to further expand access to housing microfinance in the country through this partnership," he said.

He said: "The Company believes there is tremendous potential in Tanzania's housing finance market to reach low-income families. As a wholesale lender we are eager to build a case for housing microfinance in the country and explore how the financial institutions we invest in can tap into this market through tailored loan products.'

He noted that the Tanzanian housing demand which is estimated at 200,000 houses annually and a total housing shortage of 3 million houses has been boosted by populations and access to mortgages but now what is needed is to have multi-housing loan products for low income populations.

Daniel Mhina, associate director housing finance- Africa at Habitat for Humanity International said current financing gaps in the Tanzanian market when it comes to low-income communities and their housing needs are high due to rapid population increase in relation to the number of houses in Tanzania as indicated by the Tanzania census

"Many Tanzanians want access to small loans with low interest rates and soft conditions to enable them to conduct repairs in their houses such as door, colouring, change iron sheets or but modern windows, but many financial institutions are not offering the services as they only focus on large loans," he explained.

He said that many investors are deterred in investing in this product because of the lack of collateral backing these loans.

THE National Council for Technical and Vocational Education and Training (NACTVET) has suspended operations of the Mbeya Training College following violation of registration rules, which includes providing training of unregistered courses.

The council has directed the college management to submit a detailed report explaining why it offered unregistered courses. Failure to submit the report, stringent measures will be taken, including being deregistered.

Decisions to suspend its operations were reached mid this week when the Mbeya District defence and security committee accompanied by NACTIVET officials from the Southern Highlands regions held a meeting with the college management and students.

NACTIVET Manager in Southern Highlands regions. Joha Zabron said the college was registered in February this year to provide training on hotel management, secretarial, computer and business administration

He said the college has violated terms of registration by providing courses such as laboratory specialists whereas some students registered for the courses do not have qualifications.

"NACTIVET Executive Secretary has directed us to take action by suspending operations of the college as an initial step; owners have to explain why we should not completely de-register the college," said Zabron.

NMB now ups its single-borrower limit to 420bn/-

NMB Bank, one of the largest lenders in the country, single borrower limit (SBL) has increased by 29 per cent to hit a historic level thanks to the lender's solid performance.

Filbert Mponzi, bank's chief of retail banking said the amount increased to 420bn/- in the third quarter of this year from 325bn/-, which was the highest single borrower ever issued by a financial institution in the history of the country.

"Our capital base as at 30th September has now reached 1.94trillion/- which translates into the SBL of about 420bn/- as per regulations of Bank of Tanzania which allows commercial banks to lend 25 per cent of its capital," Kimori said before signing a MoU with the Zanzibar Private Partnership under the President's Office Labour, Economic Affairs earlier this week.

The SBL figure is the legal credit limit the bank can now lend to a single borrower.

"We have so far recorded a robust year in terms of performance during the first three quarters this year and all indicators show that we will be having yet another historic year. Our ambition is to continue growing our asset base. Overall, we forecast that our assets will hit the 12trn/- mark before the end of this financial year," Kimori said.

According to the bank's Q3, 2023 financial results released recently, the bank posted a solid performance after its total assets surged by 22 % to reach 11.53trn/- as compared to 9.46tn/- posted during the same period last year.

Kimori noted that the bank will continue to play a leading role in accelerating the transition from cash to digital payments as part of the bank's commitment to enhance financial inclusion.



Mwandosya suggests policy formulation to control AI use Commission said

FORMER Minister Communications and Transport, Prof Mark Mwandosya has advised the government to formulate a policy to control the use of artificial intelligence (AI) to prevent people from abusing the technology.

He made the plea yesterday in Dar es Salaam, during a public forum on technology, business and regulations organized by the College of Business Education (CBE) at its Dar es Salaam campus.

Prof Mwandosya said without control of the technology, people could misuse it and cause chaos in businesses like to flourish where society by doing things that are not pleasant.

He said since the world's technology grows faster, some countries are using AI technology to make devices such as computers and cars.

"If you look at many factories in developed countries, machines are now doing the jobs that were previously done by humans and they are doing those jobs faster and with better quality without problems," said Prof Mwandosya.

"There could be people who can take advantage of technology and misuse it. It is time to have a policy because experience shows that Communication

there is no policy or control," he said.

Prof Mwandosya, who is the Chairman of the Energy and Water Utilities Regulatory Authority (EWURA) said the world is now shifting from manufacturing cars that use petrol and diesel to electric cars that use batteries.

"Tanzania should develop a policy for the use of electric vehicles because we have discovered minerals that will be used to make batteries used in electric vehicles," he said.

Dr Nkundwe Mwasaga, Director General of Information and Technologies should increase creativity and stimulate various economic activities.

"We should ensure technology increases knowledge of Tanzanians and to ensure the systems are safe and reliable. To create an inclusive digital economy, we must ensure that issues of innovation, creativity and digital entrepreneurship are used properly," he said.

Government calls on Kagera War veterans to submit particulars

THE government has asked all elders who suffered different kinds of disabilities when fighting for the nation during the Kagera War and are not receiving free medical services and disability pension to submit their personal information so that they are included in the list.

According to Home Affairs deputy minister Jumanne Sagini, available statistics indicate that about 272 disabled elders were receiving disability pension.

The Deputy Minister was responding to a question by Special Seats Member of Parliament (MP), Fakharia Shomari (CCM), who had demanded the government's statement over the fate of elders who had suffered during the battle between Tanzania and Uganda in 1979.

In response, Sagini who acted on behalf of the Minister for Defence and National Service, noted that until yesterday, 272 elders with disabilities were on the paylist, insisting that immediately after the Kagera War, the government started taking care of all persons who fought during the war.

"Many of those fighters were recruited and later permanently employed in different defence and security organs especially the Tanzania Peoples' Defence Forces, Tanzania Police Force and the Tanzania Prisons Service," said the Deputy Minister, adding that others however, were not employed due to different reasons.

The Uganda-Tanzania War, known in Tanzania as the Kagera War and in Uganda as the 1979 Liberation War, was fought between

Uganda and Tanzania from October 1978 until June 1979, culminating in the overthrow of Idi Amin's regime.

Amin installed himself as President of Uganda and ruled the country under a repressive dictatorship. Uganda also disputed its border with Tanzania, claiming that a section of Kagera -a 720 square mile stretch of land between the official border and the Kagera River, 18 miles to the south, should be placed under its jurisdiction, maintaining that the river made a more logical border.

This triggered war between the two countries after the late Father of the Nation, Mwalimu Julius Nverere, who was also Commander in-Chief of Tanzania Armed Forces could not tolerate such nonsense.

After that war it came into limelight that some persons had suffered different kinds of disabilities as a result of that war. Yesterday, the Deputy Minister said all disabled elders who participated during that war continue receiving medical services at different health facilities owned by the army.

"They are equally receiving pension and gratuity pay as per the pensions and gratuity regulations, and the ministry is still following up on the statuses of elders who fought for the country," he noted.

In the House, Speaker of the National Assembly, Dr Tulia Ackson asked the Internal Affairs Minister to convey the parliament's message to his counterpart in the ministry of Defence and National Service, insisting that there was a dire need to have a track record of these elders who fought for the country so that they are well treated at their old age.

THE Tanzania Wildlife Research Institute (TAWIRI) has urged Tanzanians to venture into beekeeping enterprises due to its countless benefits including creating sustainable employment.

Dr Wilfred Marealle, TAWIRI top researcher made the call yesterday here when briefing journalists on the forthcoming 50th International Federation Beekeepers' Associations (APIMONDIA) conference that will be held in Arusha in 2027 and expected to bring on board over 6,000 beekeeping stakeholders worldwide.

Dr Marealle said that the meeting brought on board beekeepers, scientists, honey traders, agents for development, technicians, and legislators to listen, discuss and learn from one another.

He said that the meeting which will be accompanied by great opportunities for tourism, various businesses and important discussions of the bee industry and its products.

"We ask all stakeholders not to miss this conference because it is important to bring together various experiences that will help productivity and great profits in the bee industry, we ask the beekeepers themselves to plan not to miss it due to the great importance of the conference," he said.

"That's why I want Tanzanians to use this opportunity of bees and its products, to be self-employed, to lead a life and to find the country's income," he said, noting: "Investment in this sector is easy, it does not require a lot of capital, you just put the hive in the right place, the bees make honey with no investment cost."

Dr. Marelle said Tawiri helps with beekeeping education for farmers, harvesting, the right place to put the

that have been researched and recommended for productive use.

"Natural beehives last only two seasons and are easily broken while researched tanks are environmentally friendly and last more than 10 years if professionally maintained," he said.

On other bee products, Dr Marealle said that Tawiri has now bought modern equipment for harvesting bee venom, without affecting him, which along with the plans to complete a modern bee laboratory, they will start providing education on how to harvest the crop to increase production and productivity for the country and breeders. one gram is sold between 20,000/- and 25,000/-.

He mentioned that other products are bee milk, glue and pollen which have a good price in the market and the demand is high.

"Bee products such as milk, its venom and pollen (pollen), these are claimed to treat diseases such as diabetes, cancer and rheumatism, researches on this treatment I cannot talk about in detail because there are researchers," said Dr Mareale.

Tanzania is the 12th country in the world for honey production and the 2nd in Africa. It has 48.1 million acres of forests, 9.2 million bee colonies with the capacity to produce 138,000 tons.

Currently, Tanzania produces 30,800 tons, preceded by the country of Ethiopia that produces 45,000 tons.

"The country has recorded 200,000 sickle cell cases and around 11,000 children are born with the disease on an annual basis," said Dr Mollel indicating that the disease transmitted through inheritance from the genetics of a

The Deputy Minister noted statistics from the Health Management Information System (HMIS) show that around 86,990 sickle cell patients received

According to him, the ministry has been embarking on a campaign to encourage engaged couples to test for sickle cell before wedlock.

"Tanzania has been ranked the fifth to record the highest number of sickle cell cases globally and the third in the African Continent," stated Dr Mollel.

Similarly, the government aims to carry out the diagnosis of every child who is born in the country to know the magnitude of the problem.

Every year more than 11,000 children are born with sickle cell disease in the country. HU alone has the potential to prevent to prevent one out of every three deaths caused by the disease and almost all forms of disabilities.

"The factory is expected to be completed in 2026, and is anticipated to promote major innovations by coming up with new technologies for manufacturing

and create young talents among the youth who will get the opportunity to work there," said Byabato.

The minister said execution of economic diplomacy has brought about a major revolution in the area of science and technology, thereby contributing to the socio-economic development of the country.

He went on to reveal that economic diplomacy is part of the implementation of the foreign Policy which involves critical plans and strategies aiming to benefit the country economically, socially and politically through collaboration with other countries, regional and international integrations.

Among the strategies include searching for foreign markets, attracting trade, investment and tourism and concessional loans and looking for scholarships outside the country and transfer of stateproduction sectors like industry, agriculture and energy.

Expounding further, he said economic diplomacy has helped to promote the production sector by securing markets for the country's products.

"As of September 2023, Tanzania had sold 13,708 tons of meat as compared to 1,777 tons which were sold in the year 2020/2021. The markets have been secured in countries including China, Kuwait, Oman, Qatar, Vietnam and the United Arabs Emirates (UAE)," he

TAEC issues caution to unauthorised importers of radioactive minerals

Lazaro Busagala, the Tanzania Atomic Energy Commission (TAEC) director general has warned importers of unauthorised radioactive minerals, saying that the risk facing tough legal action.

Prof Busagala made the comments recently during an event to observe the International Disaster Reduction Day, held at the national level in Dodoma.

He said there has been an increasing wave of unauthorised importation of various radioactive minerals, which poses a threat to national security and the health of citizens.

Prof Busagala stated that they have detected and legally dealt with a total of 17 incidents of such illegal activities at different regions along the country's borders.

He provided an example of a notorious incident where a resident of Dar es Salaam was caught illegally importing over 9kg of processed Uranium (U238 Uranium, 2.6× 109Bq/g), through their intelligent system.

He said that despite the vital benefits socioeconomic radioactive minerals, including Uranium, if not handled professionally, they can have negative effects on the human body such as destruction of body cells, serious eye diseases and blindness, loss of fertility and other environmental damage.

Radioactive minerals are minerals that contain radioactive isotopes, which are atoms of an element with an unstable nucleus that decays, or breaks down, over time. This decay releases energy in the form of radiation, which can be harmful to humans.

Prof Busagala also said that during the 2021/2022 financial year, TAEC had increased inspections of imported food products to 66,609 inspections, which is a 274 per cent increase

compared to the total of 7,817 inspections conducted during 2016/2017.

Tanzania has been a member of the International Atomic Energy Agency (IAEA) since January 6, 1976 and has received numerous benefits through this membership, including technical and facility assistance for implementing projects in the health, agriculture, livestock and energy sectors.

TAEC is the regulatory body responsible for all atomic energy matters in the country. It runs a programme to provide necessary knowledge on the proper handling of radioactive materials to various institutions in the public and private sectors.

programme The institutions that use radioactive mineral technologies in their operations including those in the road construction, health and water, mining, crude oil pump construction and nuclear power generation sector.

Senior Research Officer at TAEC, Jerome Mwimanzi emphasised that the handling of radioactive materials requires technological awareness and precautions to prevent environmental and human disasters.

He mentioned that there have been at least 30 cases of disasters in the past due to the illegal trafficking of radioactive sources in the country.

Mwimanzi added that illegal importation and marketing of uranium have contributed to the outbreak of dangerous disasters. TAEC is working with other likeminded institutions to curb this trend by implementing key initiatives.

To address the situation, the Commission has developed important regulations including the Regulation on Radiation Safety in the Mining and Processing of Radioactive Ores and the Packaging and Transportation of Radioactive Materials of 2011.

ORMER South African imagines that it is all courtesy of Vice President Phumzile Mlambo Ngcuka was chief guest at the opening of the 15th gender festival organised by the Tanzania Gender Networking Programme (TGNP), recently held in Dar es Salaam.

She had incisive remarks on the problem of gender-based violence, with a section of the media understandably highlighting what she had to say on the need for men to join in the campaign against GBV in Tanzania and elsewhere.

By their very nature, appeals of the kind are directed at an individual conscience, whereas the hope is often directed at the collective level by writing laws to stop such violence.

Efforts have over the years been directed at ensuring blanket stoppage of GBV, but the nature of such relationships makes it that cessation of violence presumes cessation of stable affinities and at times an effort at striking an affinity is seen as GBV and therefore liable for a penalty.

That was sort of the gist or spirit of the 1998 legislation, here known as Sexual Offences (Special Provisions Act) and often disregarded except in substantive cases of rape - not merely glancing at a woman three times, hurting her feelings.

With more than two thousand delegates from 14 countries around the world, meeting and exchanging views for two weeks running at the festival, there should be room for plenty of ideas on what to do with respect to the various aspects of the GBV issue.

To an extent, it should not be a forum where justice can be done about the different aspects and manifestations of GBV - for instance, the methods women use to put aside their formal conjugal companions

Experts: Urban agriculture should be climate-smart

RBAN agriculture has immense contributions to food security but should be climatesmart, urban agriculture experts underscored at the inaugural edition of the African Conference on Agricultural Technology (ACAT) held in the Kenyan capital. Nairobi, from October 30 to November 4, 2023.

It was organised by the non-profit Africa Agricultural Technology Foundation (AATF).

The meet was attended agricultural researchers, policymakers, industry leaders and innovators from around the world to discuss agricultural productivity in Africa.

Urban agriculture can help increase access to fresh, nutritious food for city residents, said Margaret Gill, emeritus professor at the UK's University of Aberdeen.

However, if not managed properly, urban farming exacerbate climate change by emitting methane from decomposed wastes from urban farming plots, she said.

She elaborated: "Besides, urban farming and gardening can affect water resources in cities and the use of pesticides. The cultivation of non-native species can threaten local biodiversity as well."

Therefore, she added, cities should adopt climate-smart and biodiversity-friendly practices, taking the region and local bio-geographical and climatic conditions into account.

The professor said that urban agriculture has to embrace

like planting drought-tolerant plants, to cut back on the consumption of irrigation water, which is usually scarce in urban

"In the face of rapidly progressing climate change, urban agriculture would play a critical role in ensuring food security, dietary diversity, community cohesion and well-being and ecological benefits, such as hydrological functions, air quality and soil quality, argued Henry Gordon-Smith, founder and chief executive of advisory services and technology firm Agritecture.

But proper management of water and energy as well as access to agricultural technologies are among the burning issues in making urban agriculture climate smart and effective, he pointed out.

Gordon-Smith also brought up hydroponics as a modern agricultural technology boosts urban farming productivity as access to land plots is limited and climate conditions are not favourable for farming without the use of greenhouses. It also helps tackle the issue of soil scarcity.

"Traditional agriculture

environmental-friendly practices, responsible for 75 per cent of the world's fresh water consumption and hydroponic technology could save up to 90 per cent of the water consumed," he said.

> Urban agriculture also involves livestock development, which in turn is associated with climate change, Gordon-Smith noted.

The sector requires the utilisation of natural resources and has its own impact on the global greenhouse gas emissions of methane and nitrous oxide, he added.

In most parts of the world, urban communities keep livestock at their homes, said Gill, mentioning India and Scotland as instances.

Mitigation strategies to reduce emissions from the livestock sector are highly needed, as the increasing demand for livestock products is driven by population growth across the world, she said.

Urban agriculture requires many efforts related to mitigating pollution, climate change and efficient use of water and energy, said Renalda Bernard Mlay, founder of agricultural company Renie Fresh in Arusha, Tanzania. It also requires substantial capacity building efforts and application of appropriate technologies. Urban and peri-urban agriculture

offers a fundamental strategy for building the resilience of a city's food supply, given that 55 per cent of the world's population resides in urban areas, while 79 per cent of all the food produced is destined for consumption in cities, said Sylvia Horemans, member of board of trustees of AATF and chief executive of agricultural company Kamano Seed, Zambia.

"A staggering 800 million people worldwide are involved in urban and peri-urban area activities, while 266 million urban households are involved in crop production in developing countries," she said.

"According to the United Nations, by 2050, an estimated 68 per cent of the world's population will live in urban areas, with the most significant growth expected in small cities and towns in Africa and Asia," Horemans stated.

The rapid urbanisation places immense pressure on food supply chains and underscores the need for innovative solutions, she said. "The impact of global trends in population growth and urbanisation is compounded by other vulnerabilities, including climate change and the lingering effects of the Covid-19 pandemic,' she said.

These factors collectively contribute to an overall increase in food insecurity, malnutrition, and the rise of diet-related noncommunicable diseases, she said, emphasising the importance of stable food production, shorter and simplified food supply chains, and distribution tools that can adapt to changing circumstances.

Nobody picking up tab for flooding risk in small mine dams - after NEMC alerts

ESIDENTS of a number of mining areas are living in fear of the effects of heavy rains falling around the country - that there is a likelihood of flooding leading to loss of lives.

National Environment Management Council (NEMC), whose activities are usually closely tied to what happens in mining areas, has lately aired those concerns.

The agency has gone on and asked mine operators to take safeguards, especially in relation to dams where solid waste is directed or deposited. It has talked of dangers for those dams filling up or breaking on the seams. with clear threat to households.

Top NEMC officials have reminded the public that the Tanzania Meteorological Authority (TMA) has issued alerts on the likelihood of flooding and instances of emergency arising from El Niño rains.

The mining areas and storage of solid waste is one thing, while possible that the mines themselves may be disturbed if there is a disproportionate flow of water underground, chiefly for undercapitalised small mines.

Their often rudimentary tools and lack of usable equipment for use in testing resilience to flooding in this or that particular situations may also cause a few worries, even as the big danger is the more vivid environmental risk.

But even within the ambit of the dams or rather large basins storing solid wastes, this appeal about the need to take precautions essentially speaks of the need for such precautions.

It is not also an indication of its feasibility, as it isn't entirely evident that there is room of capital outlays aside from that preliminary construction - that is, except if it were large miners.

But even here there is often considerable limitation as to what portion of operating capital is put to environmental safety. They close if pushed.

NEMC has talked of the dams being 'very big' and therefore taking up plenty of acreage, which implies that they are largely walled off rather than built to limit outward expansion.

Had the construction been sufficiently inward, chances of massive overflowing would be somewhat limited. However, if they are shallow, the dangers would be magnified for the surrounding communities.

Again, even for areas where visible and somewhat viable preliminary construction has been done, no rush to add to safety regards would be likely if any adds-on to existing structures are big.

As often happens, NEMC alerts related more to elaborating on the responsibility of the relevant investor, and ensuring public awareness is sufficiently raised on the matter.

When it comes to the latter, the snag is that miners are rather unlikely to overstate the dangers or admit them for what they are unless they are actually prepared for additional environmental investments. The record is that they aren't too forthcoming in that regard, in which case they will not make much of it.

But the irony is that NEMC will likely observe that same rule, as it is clear it isn't disposed to take up floodrelated emergency investments.

Thus, it will likely leave the issue to disaster management committees in the Prime Minister's Office. With each pushing aside the costs of safeguards, as it were, we can only hope for clemency from the rains as chances of being prepared for emergencies will be slim indeed.

facing severe ecological threats will go up to 2.8 billion by 2050, according to a report by an international think tank, the Institute for Economics and Peace (IEP). Currently, the number stands at 1.8 billion.

More than half of the hotspot countries facing a severe threat are in sub-Saharan Africa, found the IEP report, entitled Ecological Threat Report 2023.

It looked at global ecological threats and identified the countries and sub-national areas most vulnerable to conflict, civil unrest and displacement as a result of environmental degradation and climate-related events.

The report covered 221 countries and independent territories, which were divided into 3,594 sub-national areas, accounting for 99.99 percent of the world's population. Of these countries and territories, 66 face at least one severe ecological threat.

'2.8bn people may likely reside in area with severe ecological threats by 2050'

The number of countries suffering from severe ecological threats and low societal resilience has risen by three to 30 in the last year. Ecological threats are also considerably higher in sub-Saharan Africa, the report further found.

Of the 30 hotspot countries that face severe ecological threats and have low levels of societal resilience, 19 are in sub-Saharan Africa.

The most at risk countries are Ethiopia, Niger, Somalia and South Sudan, of which Ethiopia and Niger have recently emerged as hotspots. Another new country to join the hotspots is Myanmar, the report found.

Europe and North America are the only two regions where no country currently faced a severe ecological threat, the document

The report focuses on four

natural disasters, demographic pressure and water risk.

There are currently 42 countries experiencing severe insecurity, and nearly four billion people live in areas experiencing high or severe food insecurity, the majority living in sub-Saharan Africa.

Water risk is one of the most significant ecological threats the world is currently facing. Two billion people globally live in areas that lack access to safe drinking water.

While water risk is highest in sub-Saharan Africa, it is also increasing in the Middle East and North Africa, Russia and Eurasia.

A 25 per cent increase in food insecurity, as measured by the report, increases the risk of conflict by 36 per cent.

Similarly, a 25 per cent increase categories of threat: Food insecurity, in the number of people without

access to clean drinking water and natural disasters increases the risk of conflict by 18 per cent and 21 per cent, respectively.

"As we approach the 28th Conference of Parties (COP28) to the United Nations Framework Convention on Climate Change, the Ecological Threat Report provides a timely reminder of the need for leaders to act, invest and build resilience for the future," said Steve Killelea, founder and executive chairman of IEP.

Ecological threats increase the risk of conflict and result in forced migration. Building resilience to these threats will require substantial investment now and into the future, the report said.

The report included many policy recommendations aimed at supporting local communities to improve water capture, agricultural yields and resilience.

What the law says about buying disputed property in good faith

Legally, a person who purchases a property innocently and in good faith without having knowledge of the defects is called bonafide purchaser. The aforesaid word derives its meaning from latin word 'in good faith'.

Legal term bonafide purchaser has been subjected to a number of wrangles of judicial interpretations. However, for the purposes of this article, Court of Appeal of Tanzania, in the case of Suzana S. Waryoba vs Shija Dalawa, Civil Appeal no 44 of 2017, defines bonafide purchaser as fol-

"Bonafide purchaser is someone who purchases something in good faith, believing that he/she has

THIS article is clear right of ownership after the purchase and having no reason to think otherwise. In situation where a seller behaves fraudulently, the bonafide purchaser is not responsible. Someone with conflicting claim to the property under discussion would need to take it up with the seller, not the purchaser, and the purchaser would be allowed to retain the property."

> In simple language, once the bonafide purchaser purchases a property and transferres the same in his or her name without knowledge of its defect, then any claim or whatsoever should be directed against the seller and not the bonafide purchaser.

> In our jurisdiction, various laws were enacted to ensure bonafide purchaser is statutorily protected. Section 135 of the Land Act 1999 provides various conditions for the purposes of the bonafide purchaser to be protected, particularly when a property sold at public auction.

> The protection is only available once transfer of title deed to the name of the purchaser is completed through lawful means. What bonafide purchaser is required to state or plead is that auction was conducted in public on certain date and he or she had no idea of the defect of the property purchased.

Apart from civil protec-



tion, criminally the bonafide purchaser is also protected under section 9 of the Penal Code, Cap 16 R.E 2019. This provision is available to ensure those who purchase properties from sellers without any knowledge either expressly or implied on defectiveness are protected under the defence of bonafide claim of right.

In the Criminal Appeal No 4 of 2022 between Elia Mwatebela vs Subi Patrick Mwamboneka, at the High Court of Tanzania in Mbeya, the appellant was released on the ground that at the time of purchase of the property alleged to have been stolen by the seller, he had no means of having knowledge that the said property was stolen hence the accused released from the criminal liability.

It is settled practices in common law judicial system that courts of law are very reluctant to interfere with right of the bonafide purchaser when it comes to an issue of challenging the ownership of a property which was acquired in good faith unless the said lently and more particularly the purchaser was also integral part of the said unlawful act or had reason to become aware of the said fraud or unlawful act.

In the case of Stanley Katama Masiki vs Chihiyo Kuisia w/o Nderingo Ngomuo (1981) TLR 143, the court held that "The court should be slow to disturb such a purchase and would desist from reviving estate claimed."

What is relevant here is that some of the relevant conditions need to be within legal framework so that one can be protected under the said defence. There is no single condition but always varies from case-to-case basis. However, from our experience of handling such disputes in courts of law and upon going through various laws, we found some of the basic ones which are predominant and need to be met so that the defence of bonafide purchaser can be entertained.

transaction was done fraudu- of title issued by the registrar of title or from authority that he or she is the lawful owner of the property. Motive behind this principle is that in case of any defect or encumbrance on the title, then the name of the purchaser would not be entered in the land registry.

> The law presumes at the time of purchasing the property there were no registered defects. Therefore, it is important for the purchaser to finalise the process so that he or she can be protected under the law. Failure of it, the defence cannot be available to the purchaser.

In the case of Registered Trustees of Africa Inland Church Tanzania vs CRDB Bank Plc and others, Commercial Case 7 of 2017, the court held that protection of bonafide purchaser under section 135 of the Land Act start after the transfer and registration of the said property to the bonafide purchaser.

Secondly, property should be acquired in good faith with-First, the purchaser must be out unlawful intention after registered or hold certificate conducting due diligence on

the property. Here, good faith refers to acting honestly, fairly and without unlawful intent when purchasing the said property.

Due diligence is also important before purchasing the same and this can be done quickly through land registry or if sale is through court order, then file can be perused. In case of failure to conduct due diligence, one may pay purchasing consideration and the purchased property may not be transferred due to the said encumbrance available either from the registry or court order.

Good example is the recent Court of Appeal decision in the case of Hamis Bushiri Pazi and 4 others vs Sauli Henry Amon and 3 others. In this case, a property was purchased through auction conducted by court order handled by a court broker.

The purchaser had developed property into a new and better outlook after purchasing the same. However, Court of Appeal did not accept defence of bonafide purchaser and proceeded to set aside the sale. Among other grounds which inspired the court to arrive at such a decision was that due diligence to the registries was not done to ensure clearness of the property purchased and the court went further and made declaration that even what was developed on the said property should be left to the previous

Thirdly, the purchaser must have no means of having notice of defects or should not be integral part of fraudulent act of the purchasing transaction. As a matter of law or cardinal principal, fraud vitiates everything. The court is not there to bless unlawful acts in either way particularly when the purchaser was integral part of the said unlawful

However, fraud or unlawful act which courts look into are the ones which point that the bonafide purchaser was the integral part of the same or had reasons to know before purchasing the property in question. If one can establish the above three predominant principles, then he or she is good to go and is properly protected by law.

Agriculture: Let's use this 'silver bullet' to shoot youth unemployment

TATISTICS about youth unemployment in our country are startling. What we can do to tackle it is stunningly open secret-investing heavily in the agriculture sector. Why it has taken us so long to do the right thing is puzzling. Now that something is being done is encouraging.

For starters, out of the approximately 900,000 young Tanzanians aged between 15 and 24 who enter the job market annually, only between 50,000 and 60,000 get a decent and salaried employment. The rest struggle to make ends meet, seeing many adults depend on their parents for years.

It should be remembered that Tanzania is one of the countries with the youngest populations in the world. The World Population Review 2022 shows that our country has a median age of 18 years and youth and children account for 31 percent and 44 percent of the population respectively. This is younger than African continent's median age which is 18.8 years.

It is undisputed that youth is the most energetic and productive section of any society. A country's ability and potential for growth is determined by the size and strength of its youth population. It is rightly argued that developing countries with large youth population like Tanzania can see tremendous growth, provided they invest in developing young people's skills.

All manner of studies have been conducted and findings show that Tanzania's agriculture sector-which contributes nearly one-third of our country's GDP but employs over 75 percent of the population-has the potential to increase incomes and improve liveli-

That is why initiatives that focus on agriculture as a means to tackle youth unemployment and achieve economic growth are heart-warming. President Samia Suluhu Hassan is particularly passionate about unlocking the potential of the sector which is rightly described as the sleeping giant.

To transform the agriculture sector, the government has come up with the Building a Better Tomorrow Youth Initiative for Agribusiness (BBT-YIA), which is aimed at promoting youth engagement in modern agro-sector activity for sustainable and improved livelihoods, president Samia said. It is a tool for attainment of the Agenda 10/30 that envisages increasing youth employment by 1.5 million.

Running between 2022 and 2030, BBI-YIA is designed to address many challenges that hinder youth involvement in agriculture, including negative perception towards agriculture, limited agricultural entrepreneurial skills, poor access to land, limited accessibility to financial services, markets; and modern agricultural labour.

BBT-YIA's estimated budget is

356.199bn/- (USD 148,416,167) of which 24 percent of the budget will come from the government. The programme attracted US dollars 500 million (about 1.25tri/-) funding from development partners at the Africa Food Systems Forum 2023 which took place in Dar es Salaam early September this year to fi-

nance its projects in the next six years. BBT-YIA is not just about tilling the land but also involves livestock keeping and fishing as well as the entire ecosystem from input to production, processing and marketing.

The programme is about modernisation and commercialisation of agobased productive activity, demanding heavy investments in mechanisation, irrigation, agro-processing and digital platforms taking up numerous youth groups, the president affirmed.

Digital platforms under BBT assist in accessing agricultural extension services, marketing and enabling smallholder farmers to access credit plus extension services, she stated, expressing gratitude for the .continental lender for the provision of substantive support.

A growing section of the youth is now engaged in the productive initiative, she stated, telling the delegates that as a mother she decided on some of the issues as a private agenda for education and health.

The government has set aside 160,000 acres for the programme and beneficiaries are allocated up to 10 acres each, which they will end up own-

Its formulation process adopted a participatory approach involving the government, the private sector, development partners and other key stake-

In a course of eight years, the government intends to achieve 12,000 profitable enterprises across 12,000 villages in the country through partnerships among the Ministry of Agriculture, private sector, development partners, Tanzania Youth in Agriculture Association and like-minded Non-Government Organizations.

The programme was designed to start by training 200,000 youth, involving 20,000 youth in internship programmes, and mentoring and coaching 15,000 youth-led agribusinesses

through incubation programmes. The selected beneficiaries are categorised into four clusters with cluster one being youth entrepreneurs in established agribusinesses, cluster two youth entrepreneurs whose agribusinesses are yet to be established, cluster three youth trained to be the workforce in established agribusinesses and cluster four youth with no interest in agriculture.

After decades of attempts to tackle youth unemployment, it is as if we concluded that there is no silver bullet with which to do so. We can now use agriculture as a silver bullet to shoot youth unemployment.

ROM the balcony of the house she's lived in for the past weeks, 32-year-old Margarita Ghushunts says she often looks in the direction of her home, in Nagorno Karabakh.

"Every time I look that way, I remember the hellish journey we took to escape from home. It feels like losing it over and over again," she tells IPS.

Also called "Artsakh" by its Armenian former residents, Nagorno-Karabakh was a self-proclaimed republic within Soviet Azerbaijan which had sought international recognition and independence since the dissolution of the Soviet Union in 1991.

The First Nagorno-Karabakh War (1988-1994) ended with an Armenian victory. Azerbaijan would unleash its armed forces in 2020 and take back many of the areas lost years before.

But grievances were still not settled.

September 19, Azerbaijan launched a massive attack against Nagorno Karabakh. All the population – more than 100,000 ethnic Armeniansfled the region for Armenia within a few

Panicked by the Azerbaijani attack, the civilian population rushed to evacuate. The sole road connecting Nagorno Karabakh to Armenia -closed by a 9-month blockade imposed by Azerbaijan- had just been reopened, but it could be closed again at any moment.

After a 28-hour, exhausting ride to the Armenian border from Nagorno Karabakh's capital city Stepanakert, Margarita, her husband Harutyun and their three minor children arrived at her father's house in Tegh village, in southern Armenia.

The village is located right on the Azerbaijani border. Margarita can even see the Azerbaijani military positions and their flags waving from the neighbouring mountain peaks.

"We can also hear the periodic gunshots so my children cannot sleep peacefully. Even when they hear the sound of thunder, they come to me and ask: "Mama, are they shooting at us again?"

Killed and tortured

On September 28, the last leader of Nagorno Karabakh, Samvel Shajramanian, issued a decree dissolving the selfproclaimed Nagorno Karabakh Republic as of January 1, 2024.

Today, the population of the evacuated enclave is spread throughout the regions of Armenia. Some of them are in the accommodations provided by the government, while others rent houses or live in free accommodations offered by caring individuals.

In several public speeches and international meetings, Azerbaijani President Ilham Aliyev has repeatedly emphasized that the rights of Armenians living in Nagorno Karabakh would be safeguarded "with Azerbaijan's national legislation and international commitments".

But there's little trust among the Armenians. Less than 40 remain in the besieged enclave. They are now provided with humanitarian aid by the International Committee of the Red Cross

On October 19, the Armenian Human Rights Defender, Anahit Manasyan, re-

ported that the bodies of the victims in Nagorno-Karabakh during the Azeri attack from September 19-21 showed signs of torture and mutilation.

It matches data issued by Armenia's Investigative Committee on the 31st of October which points to 14 people being tortured by the Azerbaijani military and 64 people dying on the road from Nagorno Karabakh to Armenia.

In an interview with IPS in Yerevan, southern Armenia, International law and human rights expert Siranush Sahakyan notes that previously recorded cases of brutal murders among the civilian population of Nagorno-Karabakh demonstrate the futility of Aliyev's words.

"After the 2020 war, up to 70 civilians

decided to remain in their settlements of Hadrut, Shushi and other regions which came under Azerbaijani control. All these civilians were either captured, taken to Baku, tortured and killed or murdered in their own houses. Their bodies were desecrated," recalls Siranush Sahakyan.

UN also called on Azerbaijan that "Rights and security of Karabakh Armenians must be guaranteed". Other than just making calls, says Siranush Sahakyan, the UN should also create the conditions for

"The first condition is to eliminate hatred against Armenians. Also, an international fully mandated mechanism needs to be deployed in Azerbaijan to protect Armenians in case they face security is-

sues. Without a substantial change in the situation, no one will return," stresses the lawyer.

Fear of new attacks

Margarita Ghushunts's little daughter, Rozi, was born under the blockade of Nagorno Karabakh during which they were deprived of gas, electricity, food, medicine, and fuel, and the healthcare system was almost non-functional.

But it was not the harsh living conditions that forced Margarita to leave Stepanakert.

"We could bear all the cruelty of the blockade to protect our right of self-determination, but as Artsakh's government was forced to surrender arms to save the

civil population, we could not stay there anymore," explains the displaced woman.

Life in Artsakh without its defence army, she claims, "simply equates to death for the population."

Today, Ghushunts her neighbours often ask if they will stay in the village. Her answer, however, is unsettling for everyone. The displaced woman fears Azerbaijani troops "may launch an attack on Armenia at any moment."

It can happen. According to the Armenian MFA, after the 2020 war Azerbaijan has occupied 150 square kilometres of the internationally recognized territories of the Republic of Armenia.

On November 1st, The Lemkin Institute for Genocide Prevention issued a "Red Flag Alert" for the Republic of Azerbaijan in the Republic of Armenia, due to the alarming potential for an invasion of Armenia by Azerbaijan in the coming days and weeks.

Siranush Sahakvan, the International law expert interviewed by IPS, claims that the ratification of the Rome Statute on the International Criminal Court (ICC) by Armenia's parliament on the 3rd of October could open the door to an international investigation of Azerbaijan's crimes against Armenia.

"Non-ratification of the Rome Statute by Azerbaijan creates obstacles to investigate their crimes in Artsakh, but it will fall under jurisdiction for the crimes committed on the internationally recognised territory of Armenia starting from May 2021. This could be one of the ways to protect Armenia from future international crimes," Sahakyan states.

The Avanesyans also left Nagorno Karabakh to settle in Vazashen, another border village in Armenia's north. But they soon decided to move again.

"Our neighbour pointed out the Azerbaijani positions right in front of the village. He mentioned that they could not graze the cattle because the Azerbaijanis were stealing it. The children got scared, so we had to seek another shelter," Lusine Avanesyan, a 35-year-old mother of five children told IPS from Kalavan village.

That's where they moved again after the local guesthouse offered its rooms for the family allowing them to stay as long as they wished.

Romela Avanesyan, Lusine Avanesyan's mother-in-law, began exploring the resources available in Kalavan to start a farm as soon as they arrived.

The displaced 61-year-old remembers the pomegranate garden she planted many years ago but was forced to leave behind. While they were rushing to evacuate Karabakh, she held onto what was most precious to her: the seeds of plants and vegetables from her garden.

"I was urging my grandchildren to pick only the cracked pomegranates and leave the beautiful ones to ripen," Avansesyan tells IPS. Today, she adds, "those pomegranates are lost, and so is our entire homeland."

Digital clubs to push digitalisation

ANZANIA is promoting a culture of innovation and creativity as part of its strategy to mainstream the use of information and communications Technologies (ICTs) in the country, the Permanent Secretary in the Ministry of Information, Communications Information Technology, Mohammed Khamis Abdulla said in Dar es Salaam recently.

Launching a Tanzania Communications Regulatory Authority (TCRA) produced handbook on the procedures for the formation and coordination of digital clubs recently, Abdulla said the ministry had set targets of building talents and innovations from the primary school level.

The ministry was working with the ICT Commission to manage the formation of digital clubs Involving youths at all educational levels, he

The clubs would enable youths to apply their talents and innovation potentials to pursue their dreams while promoting an innovation culture in the country. They would also create employment, build critical thinking skills among youths, address, and overcome their chal-

The Permanent Secretary explained that digital clubs are essential component of the Digital Tanzania Project, which seeks to promote ICT use among Tanzanians. They are platforms for youths in peer groups to improve their awareness of opportunities created by technol-

ogy and digital applications, he explained.

For example, students may identify issues in their locations and discuss ways of addressing them through ICTs and digital applications, he said.

The clubs would improve their skills and readiness to fully participate in the digital economy from lower education levels to universities, he noted.

TCRA would cooperate with other education sector stakeholders, including teachers and students in tertiary institutions and universities in the digital clubs programme, Dr Bakari.

TCRA will review and update the guidebook to accommodate new technologies and their applications, he said.

Dr Bakari assured ICT innovators in the Country that the Government through TCRA would continue offering scarce, valuable resources of frequency spectrum, numbering, domain names and Postcode free of charge to those involved in coming up with new ICT solutions that would benefit communities from different lifestyles.


Grape farmers in Dodoma, wine producers pin high hopes on 6th CIIE

ANZANIAN grape farmers and wine producers are looking to the 6th China International Import Expo (CIIE) in the eastern Chinese city of Shanghai, which runs from Sunday to Friday, with great expectations.

PEOPLE fleeing to Chad have reported a new surge in ethnically-driven killings in Sudan's West Darfur as the paramilitary Rapid Support Forces (RSF) took over the main army base in the state capital, El Geneina.

On Tuesday, a Reuters reporter saw a trail of men crossing from Darfur into Chad at Adre, about 27 km (17 miles) west of El Geneina. Three of those who fled said they had witnessed killings by Arab militias and RSF forces targeting the Masalit ethnic group in Ardamata, an outlying district in El Geneina that is home to the army base and to a camp for internally displaced people (IDP).

The RSF did not immediately respond to a request for comment. Reuters was not able to independently verify the accounts of what took place.

Reports have it that that between April and June this year, the RSF and allied Arab militias conducted weeks of systematic attacks targeting the Masalit, El Geneina's majority ethnic African tribe, as war flared in the country between the RSF and Sudan's army.

In public comments, Arab tribal leaders have denied engaging in ethnic cleansing in El Geneina, and the RSF has said it was not involved in what it described as a tribal conflict.

At talks in Jeddah, the warring parties agreed to facilitating aid deliveries and confidence-building measures, mediators said on Tuesday, but efforts to secure a ceasefire have so far failed.

The attack on the army base in Ardamata started early last week, when militiamen also started shelling homes

in the IDP camp, said Nabil Meccia, a nurse who said he had crossed into Chad after being detained by the RSF at the border and paying to secure his

He said he had seen RSF forces killing civilians as they sprayed gunfire during raids in the Ardamata camp, and lining men up and executing them. Like others, Meccia had moved to Ardamata, where residents hoped for protection by the army, after the attacks elsewhere in El Geneina this year.

An army soldier who declined to be named, who fled the Ardamata base, said a drone attack early on Friday had destroyed its defences and that military commanders had left by Saturday morn-

As army troops pulled out of their base, community leaders in Ardamata collected weapons to try to secure safe passage for civilians, said Meccia and Sharaf Eddin Adam, another civilian refugee who arrived in Chad.

Residents with access to vehicles managed to escape, but others were arrested or forced to labour by the RSF before several dozen were lined up and executed in Ardamata's Kobri district just after midday on Sunday, Adam said.

He said he saw dozens of bodies of civilians lying lifeless in the street and that people were also beaten and flogged.

The war in Sudan has caused a major humanitarian crisis and the displacement of more than six million people, according to the International Organization for Migration (IOM). More than 500,000 people have crossed into Chad,

mostly from West Darfur, the IOM says. Medical charity MSF said the number of refugees arriving in Chad had sharply increased in the first three days of November to 7.000. The refugees were mainly women and children, and many recounted stories of large-scale violence against civilians, it said.UN officials in Chad said thousands more were expected to cross but had been prevented from doing so by RSF forces demanding

Another witness, Mashaar Omar Ahmed, said militia and RSF forces, some in plain clothes and some in uniform, had executed more than 30 men in Ardamata's District B after separating them from the women.

"They asked the men if they were Masalit, and they didn't deny it," she said, carrying her 6-month-old daughter. She said 10 members of her family had been missing since Sunday.

Sarah Adam Idris, a 30-year-old who said her husband, siblings and other men in her family were missing after the attack, said assailants had raided the IDP camp at Ardamata on Sunday morning. Despite tribal leaders seeking assurances for safe passage the RSF had stormed, torched and looted houses, killing men, she said.

The soldier said that when he arrived at the border with Chad he pretended to be a civilian and denied that he was Masalit in order to pass. Another man was taken away after RSF border guards found a picture of him in army uniform on his phone, the soldier said.

Abdel Karim Rahman Yacoub, a truck driver who made it into Chad after pretending not to be Masalit, said he saw the RSF killing two other men based on their identity.

'We won't leave' - ageing apartheid victims continue their sit-in to demand reparations

S rainy weather and biting cold gripped much of the country, senior citizens between the ages of 60 and 80, many battling chronic illnesses, found themselves on the chilly, hard ground outside the Constitutional Court in Johannesburg.

This week, they sat huddled under plastic sheeting in a week-long protest - an annual cry for recognition and redress.

They are part of a larger group of victims and survivors of apartheid abuses who claim to have received no reparations, despite the Truth and Reconciliation Commission (TRC) hearings that aimed to right historical wrongs.

The 29th of October 2023 marked 25 years since the TRC handed its report on apartheid crimes and atrocities to former president Nelson Mandela.

At least 17,000 of the 21,000 victims included in the TRC report benefited from the reparation process, out of millions of black South Africans who suffered under apartheid rule.

These beneficiaries are each said to have received compensation ranging from R10,000 to a maximum of about R30,000 in one-off payments.

Figures from the Department of Justice and Correctional Services reveal that, as of 30 September 2023, R805,159,080 has been paid in reparations to TRC-identified beneficiaries across several cat-

Interim reparation - R53,165,325; final reparation - R497,708,781; exhumation and reburial R4,997,257; higher education and training - R129.174.450 and basic education - R120,113,267.

The President's Fund, established to make reparations to victims of human rights abuses during apartheid, held R2-billion at the last count.

The administration of this fund falls under the purview of the TRC Unit within the Department of Justice and Constitutional Development.

Following the TRC's recommendations, the fund was created to provide reparations in six categories: Once-off individual grants to apartheid victims, educational support for victims and their families, housing provision for victims, financial assistance for exhumations and reburials of deceased victims, access to healthcare and rehabilitation of communities severely affected by apartheid.

However, a majority of the Khulumani Support Group (KSG) members claim to have not received any form of compen-

'No reparation, no vote'

KSG Gauteng chairperson, Nomarussia Bonase, said: "We trusted that the TRC report would be the first step in repairing the damage, but today we still demand redress, justice and reparation for apartheid crimes.

"For two decades, the government has failed to address this issue. Promises are made but not kept. We, as Khulumani members, have decided that we will not vote in the upcoming 2024 elections until our needs are met.

"We will not leave the Constitutional Court. If it means making our stand here, we are prepared to do so. We have already lost one of our own while protesting here last year."

The KSG represents at least 57,000 victims and survivors around the country who are demanding reparations. They insist the government has not delivered on its promises according to the TRC report and recommendations.

Many of the protesters say they deserve reparations and that the list provided by the TRC does not include all the victims. For KSG member Thabo Daniel Shabangu (60), the delay in receiving reparations feels like re-victimisation, as he is forced to carry the physical and emotional scars of the past.

"I bear numerous bullet wounds... some with bullets still embedded in my body, serving as painful reminders of the suffering I endured during the liberation struggle," he recounted.

Nomarussia Bonase added, "I have to live with the fact that my mother was raped while pregnant with me. She was left in a critical condition and both our lives were in jeopardy. She was rushed to Baragwanath Hospital for urgent care, and I survived the attack.

"The trauma of apartheid marked my existence before I even entered this world. The government must provide reparations now, even if only as an interim measure, while they work on a longterm plan for disbursement."

Chrispin Phiri, spokesperson for the Ministry of Justice and Correctional Services, commented on the disbursement of reparations: "The department's mandate is limited to persons identified by the TRC as victims of gross human rights

"This includes victims who made statements to the Commission, those named in statements by relatives or others, and those identified through the amnesty

"The Department is not authorised to extend reparations to individuals beyond these TRC-defined criteria. However, the community rehabilitation programme, one of the TRC Parliamentapproved recommendations, may also benefit victims who suffered intense violence in the past, regardless of their TRC status.'

Phiri said the department conducts annual roadshows to support TRC-identified victims, including the elderly and victims in remote communities. He acknowledged civil society's concerns, particularly from the Khulumani Support Group, regarding the exclusion of many apartheid victims from TRC restitution.

Phiri emphasised the department's

commitment to engaging with stakeholders to deliver services to TRC-identified victims.

"The Department is committed to ensuring cordial stakeholder engagements to deliver services to the TRC-identified victims," he said.

Daily Maverick understands that only the Presidency can adjust the list of victims entitled to reparations to include those who may have been excluded by the commission.

The Presidency referred Daily Maverick's queries back to the Department of Justice. It has often failed to respond to Khulumani Support Group enquiries.

Dozens of members of the KSG remain camped outside the Constitutional Court, resolute in their pursuit of justice.

Their resilience serves as a stark reminder that the wounds of apartheid run deep and will not heal without the reparations they have long been prom-

But time is running out, especially for the elderly victims who promise to keep fighting.

rices of residential properties in Dubai have seen their 11th consecutive quarter of growth, up by 5 percent, according to new data, with apartments in Dubai South seeing a 73 percent increase over the past year.

Property consultancy Knight Frank said average residential property prices rose by 5 percent in Q3 2023, with growth of 30 percent since Q1 2020 and 19 percent annually, but prices are still 7 percent below the peak of 2014.

Faisal Durrani, partner, head of research, MENA, said Dubai's prime markets accounted for 4.8 percent of transactions by total value for the first nine months of 2023, while 51 percent of transactions were for secondary market sales, which he said reflected the high proportion of end users.

Off-plan market sales totalled AED 100 billion (\$27.2 billion) for the first nine months of the year with ready homes reaching AED 104.9 billion.

Apartment prices in Dubai rose by 5.1 percent in Q3 2023, reaching more than AED 1,300 per sq. ft., growth of 26 percent increase since Q1 2020, but still 10 percent below the 2014 peak.

Dubai villa prices experienced

a 4.5 percent increase between June and September, with an average price of AED 1,580 per sq. ft., up 57 percent increase since

Prices of apartments in the Dubai South area had increased by 73 percent over the last 12 months, while those in Jumeirah Lakes Towers grew by 67 percent, and Umm Suqeim Third by 37 percent.

Dubai South villas have also recorded the most significant quarterly price change with prices up by 33 percent during Q3.

The Palm Jumeirah is still the most expensive apartment submarket at AED 3,390 per sq. ft., with prices surpassing Q1 2020 levels by 122 percent, Knight Frank said.

Cash buyers continue to dominate the market, constituting around 80 percent of transactions in Q2 2023, helping insulate the market from rising borrowing costs and contributed to record sales in 2023.



"While cash transactions have been at their highest level on record at 82.4 percent during H1 2023, there's a possibility that many buyers will consider refinancing in the future," the report said.

The agency said the city's population is projected to reach 7.8 million by 2040, meaning a sig-

nificant increase is needed in residential development, especially in prime markets, where only 368 homes are currently under construction, while there are 77,874

homes due for delivery overall by 2028 excluding branded residences, which is significantly below historical building rates.

"In the past, Dubai's residential property market has been affected by an oversupply, which has hindered capital value growth," the report said.

"However, developers have been measured in addressing the current demand, leading to noteworthy price appreciation."

Durrani said: "Our forecasts are not without risk. A global economic slowdown and the knock-on impact on the local economy, combined with the risk of an escalation in regional tensions are medium to high risks, with the latter potentially emerging as a key catalyst for higher oil prices.

"This in turn could fuel global inflation and higher interest rates, which could drive up borrowing rates further and therefore dampen demand."

Improved seed varieties help to boost food security

AGRA Tanzania and the Tanzania Editors Forum (TEF) have challenged the media in Tanzania to play a more proactive role in disseminating critical advancements in seed technology, which could dictate the future of food security and economic resilience in the face of an increasing population and challenges associated with climate change.

In response to a call from the TEF, AGRA (Sustainably Growing Africa's Food Systems) Tanzania successfully hosted a two-day training session for about 45 journalists and media editors last week.

The aim was to deepen the understanding and report the right information on improved seed varieties and agricultural seed systems while also illuminating the truths and potential of hybrid and improved seed technologies in Tanzania.

Vianey Rweyendela, Country Director of AGRA Tanzania, emphasized, "The media plays a crucial role in shaping public opinion and policy. By equipping media professionals with facts, we empower them to inform and educate the wider community, thereby influencing the successful adoption of improved agricultural practices."

AGRA in Tanzania has contributed to the development of 44 new crop varieties of staple foods, including maize, cassava, beans, and soybeans, through collaboration with government research institutions and private sector partners.

About 30 of these varieties have successfully entered the commercial market. Additionally, AGRA has been instrumental in fortifying the seed sector by offering support across the entire seed value chain. This support includes building the capacity of plant breeders, local seed companies and various other stakeholders, contributing to the sector's growth and sustainability.

"The adoption of improved seed varieties currently stands at only 20 per cent, indicating that if a higher adoption rate is achieved, Tanzania will be well-positioned to fulfill its goal of becoming the most formidable food breadbasket in the continent," noted Ipyana Mwakasaka, AGRA Tanzania Program Officer - Seed Systems. The seed deficit is driving the need for seed imports in the country, he said.

"To uplift smallholder farmers in their transition from subsistence to farming as a business, accurate information is vital. Misinformation and myths exacerbate the poverty of smallholder farmers. Equipping them with reliable knowledge catalyzes positive change, enabling sustainable livelihoods. Dispelling myths and promoting accuracy is essential for their success in agriculture."

Deodatus Balile, Chairman of the Tanzania Editors Forum, commended AGRA for their dedication to enhancing the capabilities of Tanzanian journalists in the agricultural sector.

"Equipping our media professionals with an in-depth understanding of agricultural intricacies is vital for Tanzania as it aspires to be Africa's leading food producer," he said. He stressed the importance of these educational programs, advocating for their increased frequency to ensure that journalists can effectively contribute to a well-informed agricultural narrative.

He further emphasized the strategic importance of this knowledge: "Understanding the full spectrum of agricultural issues, from soil and seed science to policy, is fundamental for accurate reporting and can position Tanzania at the forefront of the continent's food industry."

A trainer at the workshop, Plant breeder and research scientist Dr. Emmarold Mneney, was emphatic that for Tanzania to feed Africa, it needs to invest more in seed innovation. "Understanding seed technology and its intersection with climate change is the key to sustainable seed production and a prosperous agricultural future in Tanzania," he noted. He trained the senior journalist on understanding seed, breeding, and multiplication of different seed classes, as well as understanding seed demand and forecasting.

Dr. Geradina Mzena, a Plant Breeder and Molecular Geneticist, who also serves as the Manager of the National Plant Genetic Resource Centre at TARI-HQ, highlighted the importance of seed production technology for maize farming:

"The future of maize farming lies in harnessing the power of hybrid and improved seed production technology to enhance food security and resilience in the face of changing agricultural landscapes."

Dr. Mzena emphasized that hybrids, known for their impressive yield potential, come with a significant caveat. "Hybrids demand new seeds every season," she noted, "making them a costly choice for



farmers who need to purchase seeds frequently."

Dr. Twalib Njohole, Registrar of Plant Breeders Rights, noted that to feed the world, new, improved varieties of plants are an important and sustainable means of achieving food security in the context of population growth and climate change.

'New varieties can be the key to accessing global markets and improving international trade for developing countries,' he said.

He also emphasized the role of new plant varieties in improving lives in both rural and urban areas and fostering economic development.

Zera Mwankemwa, Seed Certification Officer at TOS-CI (Tanzania Official Seed Certification Institute), highlighted the pivotal role of TOSCI in seed development and its significance for Tanzania's agricultural sector. She emphasized that TOSCI promotes a vibrant and dynamic seed sector in Tanzania, working hand in hand with farmers, policymakers, and stakeholders to achieve sustainable agricultural development and contribute to the nation's overall pros-

perity.

Mwankemwa also touched upon the legal framework under which TOSCI operates. She stated, "Our work is guided by the Seed Act No. 18 of 2003, as amended in 2017, along with the Seed Regulations of 2007, which were revised in 2014. This legal framework provides us with the tools and authority to oversee the seed sector and ensure its integrity and performance." Through its stringent certification processes, TOSCI contributes to the production of highquality seeds, which in turn helps farmers achieve better yields, she said.

Baldwin Shuma, CEO of Tanzania Seed Trade Association (TASTA), emphasized the interconnectedness of food security and seed security, stating, "Food Security should be planned together with SEED SECURITY. It's a strategic partnership for a resilient agricultural future." He stressed the critical need for Tanzania to reduce its reliance on imported seeds, stating, "Tanzania must reduce over-dependency on imported seed." He underscored the importance of

self-sufficiency in seed production to ensure food security and agricultural sustainability.

"Empowering local seed producers and enhancing their capacity is essential for building a resilient and sustainable seed sector," he noted.

The training moderators, experienced veteran editors, Nevillle Meena and Jesse Kwayu from Media Brains Tanzania, emphasized the paramount importance for the media fraternity to clearly distinguish between "nafaka" (grains) and "mbegu" (seeds).

This critical distinction ensures accurate reporting and contributes to a deeper understanding of agricultural terminology and practices.

"Through this training, we have come to recognize that seeds are not a mere commodity but a lifeline for our farmers and a cornerstone of our agricultural development," Absalom Kibanda said, emphasizing the pivotal role of informed and precise discussions surrounding the development of seeds

US 30-year mortgage rate sees plunge in 16 months

NEW YORK

The interest rate on the most common type of U.S. residential mortgage plunged last week by the most in nearly 16 months on the back of a rally in the Treasury market that drove down the benchmark yields used to set home loan costs.

The Mortgage Bankers Association (MBA) on Wednesday said the average contract rate on a 30-year fixed-rate mortgage dropped in the week ended Nov. 3 by a quarter percentage point to 7.61 percent, the lowest in about a month. It was the largest weekly drop since late July 2022.

The second weekly decline further pulled home-purchasing borrowing costs down from two-decade highs near 8 percent reached in October when yields on the 10-year Treasury note, the benchmark for U.S. home loan rates, had been charging higher.

That months-long updraft in yields saw a sharp reversal last week after the US Treasury said upcoming debt issuance would be somewhat less than previously expected and the Federal Reserve left its key overnight policy rate on hold for a second straight meeting.

"Last week's decrease in rates was driven by the U.S. Treasury's issuance update, the Fed striking a dovish tone in the November FOMC (Federal Open Market Committee) statement, and data indicating a slower job market," said Joel Kan, the MBA's vice president and deputy chief economist.

The MBA's mortgage market composite index, measuring the volume of mortgage applications for both home purchases and refinancings of existing loans, rose 2.5 percent from the week prior to 165.9.

Purchase applications rose 3percent on the week, but they remain 20 percent below this time a year ago. That indicates prospective buyers are still waiting on the sidelines despite the dip in rates, said Kan. Sellers locked into lower mortgage rates continue to hold their homes, keeping a lid on inventory in the housing market.

OFFSITE CONSTRUCTION SHOULD LEAD THE DIGITAL REVOLUTION

he construction sector historically has been so reticent to embrace new technology. Back in 2016, the government had to issue a mandate to force the industry to adopt BIM Level 2. Now, working for a global modular construction business, I have another perspective on the take up of digitisation globally.

VBC is very much a design-led provider of manufactured buildings and technology is central to that. There is a culture of innovation, and we have a number of board and non-executive directors who are from technology backgrounds.

Digital communications and AI are all around us and, particularly post-Covid, are now vital to integrating teams working in different locations. From video conferencing and document sharing to workflows and automation in manufacturing, digital technology removes administrative burdens and allows project management across different time zones.

Construction needs better planning - too many projects in the UK are still delivered late and over-budget. Better quality information across the board will improve decision making and the management of risk.

Data is critical to a technology-led business like VBC and informs our decision making in every area - design, preconstruction, costing, scheduling, compliance, health and safety in the factory and on site, quality control, environmental performance, and many other facets of building delivery.

AI helps us to analyse that data, simu-



lating human intelligence - learning, reasoning and self-correcting. It is all around us and is extremely well suited to construction and particularly to offsite manufacturing. Some examples:

AI can be tasked with automatically generating tender documents that combine cost, technical and qualitative data removing the need for bid writers to continually recycle the same information.

You can input data and software can produce a design solution using our standardised modular building components. Run multiple design models and you can assess different options to increase building efficiency, optimise use of space and advise on cost implications.

Use data to analyse high-traffic areas in a building and adjust the product specification in the building design for those

For offsite construction to thrive, you

need standardisation and volume. But with data intelligence, you can also incorporate customisation into offsite solutions.

AI can be used to observe health and safety and avoid common issues with near miss reporting. Accurate automated data is collected in real time and fed back into the process.

Post occupancy, AI can 'manage' maintenance and troubleshoot issues which can be fixed when building occupancy is lower - which technology can pinpoint and send in the engineer.

In manufacturing, production lines can be fully automated. An example is VBC's timber-framed modular factory in California, which is robotised and integrated with design. Our wall assembly line is a zero-labour process. We also use AI to manage workflows more efficiently.

One of the biggest challenges of invest-

ing in and running a modular factory is continuity of pipeline. AI could potentially be used to recognise gaps in predicted manufacturing capacity, and then to generate sales leads for a client with a project that will ensure continuity of production.

VBC has ambitions to move towards truly industrialised manufacturing and the most critical factor to achieving this is design. And with the huge shortfall in affordable housing, reducing programme at each stage of construction has an enormously positive impact on local communities with long housing waiting lists.

Automated analysis of site constraints can develop the optimum building scale, mass and tenure mix of a development. We already use parametric design, but AI will take this to the next level. It can simulate building use over time, highlighting inefficiencies and pinch points. It can be tasked with watching how people interact in completed buildings and use this data to inform future design.

This can all be done in real time, rather than having protracted design engagement processes.

Time-intensive tasks can now be automated, such as checking for compliance issues. What this will do is free up design teams to focus on creativity and design excellence, with less time spent on resolving technical issues.

Intellectual property is an issue for modular and MMC - everyone wants to protect their IP. This means there is too much fragmentation across the sector.

However, with a platform approach,

information can be shared between manufacturers and then issues such as fire protection and compliance are much easier to achieve - and there is less risk for the client.

Procurement has created a problem competitive tendering means that modular manufacturers are much less likely to share data, which is a barrier to improving processes. An alternative is for clients to validate capabilities and encourage greater collaboration.

The sharing of information could improve the productivity of the whole modular industry - and by adopting a platform solution, manufacturing capacity could be aggregated.

The construction industry is facing a significant challenge with serious skills shortages that have far-reaching consequences. As we continue to witness a growing demand for infrastructure and housing, the shortage of skilled labour in traditional construction roles, such as carpenters, electricians and plumbers, has become increasingly apparent.

However, this crisis has paved the way for the integration of technology, which presents a unique opportunity for construction to have greater appeal to the younger generation.

Engineers, computer scientists and data analysts will be integral to the construction process to optimise project design, offsite manufacturing, construction management and even maintenance.

Construction will continue to be a relationship-based industry and it is important not to dehumanise it - people do business with people.

China kicks off construction of new telescopes

BEIJING

has recently launched the construction of two 40-meter-aperture radio telescopes in Shigatse, located in Southwest China's Tibet be used to obtain fine radio autonomous region, and in Northeast China's Jilin province, respectively.

The two telescopes, developed by Shanghai Astronomical Observatory (SHAO) under the Chinese Academy of Sciences, are expected to offer technical support for the country's lunar and deepspace probe missions in the future.

Zheng Weimin, a researcher at SHAO, said that the two telescopes will further enhance

the observation capability of the very-long-baseline interferometry (VLBI) network in China.

"VLBI is a radio interferometry technology that can images and precise positions Changbai Mountain area in of cosmic objects, and can perform high-precision positioning of deep space probes," Zheng said.

Unlike conventional techniques, the VLBI technique can combine observation signals from different telescopes for joint processing, he explained.

"In other words, it is a 'virtual telescope' with a size equal to the maximum separation between the telescopes." Zheng added.



China comprises four observatories across the country, located in Beijing, Shanghai, Urumqi and Kunming. The maximum distance from the current telescope baseline in China is about 3,200 kilometers from Shanghai to Urumqi.

However, after the completion of the two new telescopes, the maximum distance from the new baseline in China will be about 3,800 kilometers from Changbai Mountain to Shigatse, which will increase the highest

angular resolution by 18 percent, Zheng said.

"That's why it is necessary to build separate telescopes at Shigatse and Changbai Mountain," he said, adding that the two new telescopes will further extend the VLBI network.

The inclusion of the two new telescopes will also allow simultaneous observation of two targets in different celestial regions, providing stronger support for the lunar and deep-space probe missions in the future.

The construction of the tel-

tember. The Shigatse station, located at an elevation of about 4,100 meters, provides an excellent observation environment for the telescope.

The construction of the telescope at Changbai Mountain began in October and is expected to be completed by the end of 2024. An overall insulation technology is used to ensure the telescope's operation in the cold environment of Northeast China.

MIAMI

FOR the third time, Donald Trump's rivals for the Republican presidential nomination took to the debate stage on Wednesday night in his absence, seeking a way to dislodge the former president from his commanding lead in opinion polls.

While contenders such as Florida Governor Ron DeSantis and former UN Ambassador Nikki Haley briefly criticized Trump, the latest episode did not appear any likelier to alter the dynamics of a race that Trump has dominated for months.

The candidates spent much of the two-hour event assailing one another as they strove to emerge as Trump's chief opponent with less than 10 weeks before the first statewide nominating contest in Iowa. They will have another opportunity on Dec 6, when a fourth debate will take place in Alabama.

For his part, Trump held a rival event nearby, where he mocked the participants and demanded that the Republican Party stop "wasting time" with "unwatchable" debates.

Haley, who has staked much of her candidacy on her foreign policy credentials, faulted Biden for pressing Israel to consider humanitarian

"The last thing we need to do is to tell Israel what to do," she said. "The only thing we should be doing is supporting them and eliminating Ha-

In addition to pushing for a more muscular response abroad, the candidates vowed to punish

Hamas sympathizers at home. DeSantis, for instance, promised to deport any

students who expressed support for Hamas. "If you are here on a student visa as a foreign

national and you're making common cause with Hamas, I'm canceling your visa and I'm sending you home," he said. "No questions asked."

A day after Democrats and abortion rights groups swept to victory in several state elections, the Republicans sought to formulate a winning message on an issue that has bedeviled the party since the conservative-led US Supreme Court last year eliminated a nationwide right to abortion.

Scott said he would support a federal 15-week ban, while Haley noted that any such legislation has essentially no chance of passing the closely divided US Senate. DeSantis - who signed a sixweek ban into law this year - did not address a federal law but said he stood for a "culture of

The candidates attacked Biden over his stewardship of the economy, arguing that his focus on climate change had slowed growth. Haley and Christie said they would raise the retirement age for Social Security benefits for younger workers to help keep the program solvent, while Scott and DeSantis said they would not do so.

US House Speaker Johnson nears choice on avoiding govt shutdown

WASHINGTON

SPEAKER Mike Johnson told key Republican members of the US House of Representatives on Wednesday that he will decide within the next two days on a path to avert a potential government shutdown, according to lawmakers.



Republican-con-

trolled House and Democratic-led Senate have just over a week to agree on a stopgap spending measure to keep federal agencies open after current funding expires on Nov 17. The House could vote on such a plan on Tuesday, three days before the deadline, according to some lawmakers.

Despite signs of some bipartisan discussion between the chambers, Johnson is focused on his own 221-212 House majority, which is struggling to agree on detailed spending plans for the fiscal year ending Sept 30, 2024.

In May, Democratic President Joe Biden and then-House Speaker Kevin McCarthy set a \$1.59 trillion discretionary spending budget. Hardline Republicans later removed Mc-Carthy as speaker and now are pushing for an additional \$120 billion in cuts.

Johnson told top Republican members of the House Appropriations Committee that he would decide on a stopgap measure within 24 to 48 hours, according to lawmak-

ers who met with him behind closed doors on Wednesday. "The speaker said, you know, he's going to make a decision by the weekend," Representative Andy Harris, told reporters.

The choice will test Johnson's effectiveness as the top Republican in Congress, just two weeks after he was chosen following nearly a month of Republican infighting.

McCarthy was ousted on Oct 3 days after Republicans failed to agree on a stopgap measure and had to rely on Democratic support to avert a shutdown.

"They will not change our position by threatening a shutdown. They will not extract any ransom note from us," House Democratic leader Hakeem Jeffries told reporters.

The House has passed seven partisan Republican appropriations bills. But the remaining five are facing headwinds. Republican leaders dropped plans to vote this week on a spending bill for transportation, housing and urban development due in part to an absence of funding for the US passenger railroad Amtrak.

After electoral victories for abortion rights advocates in Ohio and Virginia on Tuesday, centrist Republicans signaled opposition to a financial services appropriations bill over a provision to restrict funding for the District of Columbia over a local law banning employer discrimination against women who seek an abortion or contraception.

The Senate, meanwhile, has passed three appropriations bills with strong bipartisan support and could begin moving forward on a stopgap measure this week.

Sudanese warring parties agree to facilitate humanitarian assistance, says IGAD

ADDIS ABABA

THE Intergovernmental Authority on Development (IGAD), an East African bloc, has announced that Sudanese warring parties have committed to take steps to facilitate increased humanitarian assistance to help ease the suffering of the Sudanese people.

IGAD said in a press release disclosed Tuesday that the Sudanese Armed Forces (SAF) and the Rapid Support Forces (RSF) have also agreed to implement confidencebuilding measures, such as the establishment of communication between SAF and RSF leaders, improvement of each side's official media discourse as well as reduction of mutual inflammatory rhetoric.

IGAD, however, also expressed regret with the inability of Sudanese warring parties to agree on ceasefire implementation agreements during the first round of talks recently held in Jeddah, Saudi Arabia.

"There is no acceptable military solution to this conflict," the statement said, adding that Saudi Arabia and IGAD call upon SAF and RSF to put the Sudanese people first, silence the guns and seek a negotiated end to this conflict.

NATO aspires to expand its geographical boundaries, including into Asia, Russian President Vladimir Putin said.

Putin stated that Moscow and Beijing were tempering their response to Washington's attempts to set up military and political blocs in Asia.

"We see all this and alongside our friends - including, first and foremost, the People's Republic of China - are responding in a calm and balanced manner, bolstering our defense capabilities, including through joint naval and air exercises," the Russian president assured.

Putin specified that such exercises are conducted regularly.

"The level of our cooperation is constantly rising," Putin stated.

The Russian president is convinced that the consultations between the vice chairman of China's Central Military Commission and the Russian Defense Ministry "will be useful and will definitely contribute to enhancing collaboration in this crucial area for our countries."

Earlier, Russian Defense Minister Sergey Shoigu held talks with Zhang Youxia. Shoigu pointed out that bilateral military relations are developing steadily, but this cooperation is not directed against third countries and is carried out solely to

AU calls for concerted efforts to combat drug trafficking, supply in Africa

ADDIS ABABA

THE African Union (AU) has called on public and private actors in Africa to exert concerted efforts to combat drug trafficking and supply in the continent.

The call was made by Angela Martins, acting director for social development, culture and sport at the AU Commission, addressing a continental technical experts' consultation on drug demand reduction, the AU said in a statement issued

"While efforts to combat drug trafficking and supply are undeniably important, we acknowledge that addressing the demand side of the equation is equally critical," Martins said.

"By focusing on prevention, treatment, rehabilitation, and reintegration, we can break the vicious cycle of drug use and dependency, and create healthier and more resilient communities." She underscored the significance of dialogue, knowledgesharing, and cooperation among experts, policymakers, civil society, and stakeholders, recognizing that no single country can effectively tackle the drug menace alone.

Martins also emphasized the need to develop comprehensive strategies that address the root causes and consequences of drug use through collective action and international cooperation.

The consultation on drug demand reduction was strategically formulated to delve into the 2023 Pan-African Epidemiology Network on Drug Use report, which aims to improve health security, and socio-economic well-being of Africans by addressing substance use and treatment.

THE White House has called India a key strategic partner and said the US will leave it to the Indian government, led by Prime Minister Narendra Modi, to decide the country's stance on any particular crisis or contingency around the world.

National Security Council Coordinator for Strategic Communications John Kirby said was speaking about India's stand on the Israel crisis.

"India is a key strategic partner. And I think you saw that on full display when Prime Minister Modi was here," John Kirby said.

"We'll leave it to the Indian government and the Prime Minister to decide, what their stance is gonna be on any particular crisis or contingency around the world, to include the Middle East, but they remain a key strategic partner, and we're dedicated to advancing that partnership, every

single day," Kirby said.

This comes as US Secretary of State Antony Blinken is set to arrive in New Delhi tomorrow to participate in the 5th India-US 2+2 Ministerial Dialogue.

The 2+2 Ministerial Dialogue is a diplomatic summit held every year since 2018, with the Minister of External Affairs and the Defence Minister representing India and the Secretary of State and the Secretary of Defence representing the United States.

The discussions centre on common issues of concern between the two countries

Meanwhile, terming India a crucial "moral voice" across the world, Israeli Ambassador to India Naor Gilon recently urged New Delhi to designate Hamas as a terror organisation in India as well.

He stated that both India and Israel have a "shared war" against terror and counter-terrorism is one of the areas where the countries align.

Speaking during a press briefing,

Gilon said, "Prime Minister Modi Ji was among the first leaders in the world to come out with a clear statement...this was before we had understood the full magnitude of what had happened...I think, that set a very strong tone of clear condemnation of terrorism. It's important to us because India is a very close ally".

"India is also a very important moral voice in the world and when it comes to terror. India is also coming from the point of view of someone who knows what they're talking about being victims for so many years of terrorism," he added.

Gilon cited several countries that have designated Hamas as a terror group

"I think that it's also time to officially designate Hamas as a terror organization also in India. Most of the democracies, the EU, US, Canada, and Australia, I believe have already done this, and I think it's good," he said.

The Israeli envoy further said that

Israel has spoken with relevant authorities in India and the two countries are having dialogue on the issue.

Earlier, India said it sees the attack by Hamas on Israel as "a terrorist attack" and that it has always advocated the resumption of direct negotiations towards establishing a sovereign, independent and viable state of Palestine that lives side by side at peace with Israel.

Replying to questions during the weekly media briefing regarding the situation concerning the Israel-Hamas war, Ministry of External Affairs spokesperson Arindam Bagchi also said there is a universal obligation to observe international humanitarian law and the need to fight terrorism.

"Designation of terrorist organisation under Indian law is a legal matter. I would refer you to the relevant authorities. I think we have been very clear that we see this as a terrorist at-

According to CISM, the inaugural 1st World Military Half Marathon Championships showcased a formidable lineup of participants, including the reigning European Marathon Champion from Poland, Aleksandra Lisowska, as well as prominent athletes like German marathon runner and Olympic contender Hendrik Pfeiffer.

Other nations with strong contenders, such as Bahrain, France, Italy, Saudi Arabia, and Morocco, brought their own chances of securing victory to the competition.

The information further says the opening ceremony enjoyed the presence of notable figures, who included Lucerne City Councillor Franziska Bitzi Staub, Chief of the Swiss Delegation to CISM Colonel Christian Hess, CISM official representative Lieutenant-Colonel Jure Velepec, and Brigadier General Niels Blatter.

CISM was founded in 1948 and has 140 member states. Its motto is "Friendship Through Sport", and competitions are held in 26 different sporting disciplines.

Manchester Utd's latest

WORSE than a defeat that could decide Manchester United's Champions League season, this was almost multiple losses in one as Erik ten Hag's hapless side found new ways to just collapse. Twice.

An evening that had almost everything left United with nothing, and looking so unconvincing. It wasn't quite defeat from the jaws of victory but farce from the semblance of competence.

United somehow lost 4-3 in Copenhagen to leave themselves in danger of going out at the group stage for the third time in eight years. They are currently bottom of the group, but that only comes after they just bottomed out. United had been leading mere minutes from the end of normal time in both halves and, incredibly, twice went in behind. The second was of course the one that mattered, as Ten Hag's side disappeared from view to the soundtrack of raucously celebrating Copenhagen fans. This was one of the greatest nights of their history. It was one of United's most miserable recent results, which is saying some-

There were mitigating factors, such as Marcus Rashford's contentious red card, but they don't fully explain this. It is why the word "somehow" does a lot of the heavy lifting here, in the way United's ponderous midfield didn't.

The blunt truth was that this brought together many of the problems Ten Hag has been enduring from this season. Above anything, beyond the lack of tactical idea, there was the lack of conviction.

That's where the biggest issue lies. It just should never have got to this in the modern Champions League against a club as moderately resourced as Copenhagen. It should never be the case that a serial Champions League winner like Raphael Varane offers up a late pass like that. It said so much about the game, and what was wrong.

The manner of their final two match-winning goals were so easy, and the most damning aspect of that was they almost represented a mirror of how the game started.

The defeat was all the more galling because of how good it looked. United were through and ahead without even doing too much. Aaron Wan-Bissaka was presented with a route down the right that saw Scott McTominay free right by the goal. He so easily squared for Rasmus Hoilund to just slot in. The young Dane was back where he grew up and making himself at home again.

The second was an even easier finish, although did admittedly require more graft to get there.

It had also come out of a situation where there was a warning for United. Copenhagen were beginning to get at their defence more. Openings were appearing. Through that, though, a massive opening appeared behind them. From one defensive clearance, Alejandro Garnacho just surged forward to force a save from Kamil Grabara but there was Hojlund to just tap it in again. It looked so easy but of course came from a pounding run as the rest of the Copenhagen defence was concentrating on Garnacho.

That was an admittedly rare burst, though. It was conspicuous even before that goal that United were trying to cautiously control the game. It was like Ten Hag was trying to build confidence in the gameplan again. They were so studiously keeping possession and looking to construct moves, but without too many strides.

That made what followed all the more ironic. The game quickly went out of all control. Perhaps the two are connected. It might not have got to that had they seized the initiative. But they were 2-0 ahead. It should have been safe.

It ended up coming down to an interpretation over Marcus Rashford's level of control. Either way, the referee judged it was a red card, and off

That happened at 42 minutes, which might have been time enough for United to just see it to halftime. There were instead a massive 13 minutes of stoppage time, although two of those were admittedly for moments unrelated to play. One was when a supporter ran on with a Palestinian flag. Another, shortly afterwards, was when a different fan had to be tended to by medics. The stadium announcer mercifully stated soon afterwards that he was awake and well.

All of that still meant there were more than 20 minutes for United to play through until the break, but they began to fold with alarming speed. Diogo Goncalves had already hit the bar with a free-kick. On exactly 45 minutes, he squared for Mohamed Elyounoussi to finish. The Copenhagen crowd had already been buoyant, especially behind that goal, but they were by now electric.

There was that sense of opportunity.

It was far from the last time that was to happen. It was also a moment that brought another debatable decision - although this admittedly the least of them. The ball struck Harry Maguire's hand in the area, and Goncalves struck his penalty well.

There were a mere 10 minutes between Rashford's red and the penalty decision.

Making the result even worse, they were then granted a reprieve through a decision that was far more debatable. There was another handball that can only be described as a "Champions League decision". Bruno Fernandes at least ensured the penalty was beyond doubt, smashing it into the top corner.

TOC cautions national sports associations on kit sponsors

THE Tanzania Olympic Committee (TOC) has cautioned National Sports Associations (NSA) which will compete at the coming Paris Olympics against entering kit sponsorship without consulting the

TOC vice-president Henry Tandau on Wednesday said it is normal for athletes to put on kits with a log of their sponsors at local and international events, but at the Olympics, the athletes are supposed to put on kits with logs (images) of the sponsors of the Olympics.

He said National Olympic Committees (NOCs) manage local sponsorship programs in non-competing categories to The Olympic Partner (TOP) sponsors that support their sports development activities and Olympic teams.

TOP is a global sponsorship program managed by the International Olympic Committee (IOC) and its aim is to generate diversified revenue to be shared in equal measure between the Organizing Committees for the Olympic Games (OCOGs) and the Olympic Movement.

The TOP program is established for a duration of four years minimum, corresponding to the Olympic quadrennial period.

Currently, Athletics Tanzania (AT) and Women's football national team have their kit sponsors.

Tandau, who will also be the Chief de Mission for the Tanzania team at the 2024 Paris Olympics, advised the two (AT and Women's football national team) to seek advice from TOC.

He said currently TOC negotiations with a potential kit sponsor for local athletes who will qualify for the Paris Olympics are at an advanced stage.

"For now, athletes can wear any kit, but once they qualify for the Paris Games the duty of dressing them is our responsibility. We are aware that Athletics Tanzania (AT) and Women's football national team have their kit sponsors, but they will not be allowed to wear kits of their sponsors at the Olympic Games," he said.

However, Tandau said shoe sponsorship remains

exclusively for the athlete.

The country will feature athletes from five disciplines, namely athletics, swimming, boxing, judo and women football.

Alphonce Simbu and Magdalena Shauri are the only local athletes who have so far qualified for the Paris Olympics.

The Olympic Games are considered as one of the most effective international marketing platforms in the world, reaching billions of people in over 200 countries and territories throughout the world.
