Jane Goodall Institute puts up a museum

A global conservation organization, the Jane Goodall Institute (JGI) has started building a state of the art chimpanzee museum in Arusha city for promoting the conservation culture among the public.

The first-ever such museum in Africa is being built near the Cultural Heritage Centre along the Arusha-Babati highway–a few kilometres from Arusha central business district (CBD).

The museum is being built at the tune of 1bn/and its construction is scheduled to end next

JGI is the working platform of the famous Britishprimatologist and renowned environmental activist Dr Jane Goodall (pictured), who is also the widow of first phase Health Minister, the late Dr Derek Bryceson.

Speaking at the event to lay the foundation stone, Dr Goodall said that the construction of the museum aims at providing an opportunity to Tanzanians and tourists to visit and learn

Nine die as Lands SUV plunges into river

NINE people have been reported dead in yet another road crash after a government vehicle plunged into a river near Ifakara town in Kilombero district, Morogoro

According to authorities, the speeding SUV sank into River Kikwawila on Saturday evening, killing nine of its occupants and injuring three others.

The deceased were employees of the Land Tenure Support Programme (LTSP) under the Ministry of Lands, Housing and Human Settlements Development.

Kilombero District Commissioner James Ihunyo linked the accident to speeding. He said the tragedy left three officers

including the driver seriously injured. They were using a Toyota Land Cruiser

with registration number STK 9444, property of Tanzania Wildlife Management Authority

DC Ihunyo said the officers were in Kilombero district to hand over traditional certificates of occupancy to the villagers. The documents are given to land owners under the LTSP programme implemented in three districts of Ulanga, Malinyi and Kilombero.

He said the three-year programme which includes surveying and provision of title deeds and proper management of land, is scheduled to be completed within this financial year.

Stop travelling, Majaliwa tells DED

PRIME Minister Kassim Majaliwa yesterday cautioned Siha District Executive Director Valerian Juwal over failure to supervise collection of internal revenues, saying he was

frequently travelling. He expressed disappointment with the slow pace of revenue collection whereby the district has only collected 38 percent of its target for the financial year

UTHORITIES in Mwanza region have impounded a consignment of more than 200 buckets of samples of minerals destined to a laboratory for testing.

Mwanza Regional Commissioner John Mongella told reporters yesterday that the minerals belonging to Geita Gold Mine were being transported by a Fuso lorry from Geita region when it was flagged by law enforcers in Sengerema District on Saturday morning.

Police search found 226 buckets of 883 pieces of various types of minerals that were being taken to the laboratory belonging to inspecting company Societe Generale de Surveillance (SGS) for testing but without permits to allow cross-regional movement of minerals, the RC said.

"I've ordered relevant authorities to thoroughly investigate the matter so that the legality or otherwise of the consignment can be established," Mongela said.

The RC stated: "For once, the resident minerals officer at GGM Gasper Kachenge has maintained that permits are not required

for minerals being transported within the

country, something which is impossible." This explanation provided by the minerals officer was not satisfactory because there ought to be some documents to authorize movement of precious metals from one region to another, he emphasized.

He further noted that he was consulting experts in the sector, including the office of the Commissioner for Minerals for advice "and if it is established that there were irregularities in the transportation of the minerals the law will take its course."

Asked by RC Mongela to explain why there were no documents to authorize transportation of the consignment, Kachenge replied:

"The law does not stipulate clearly that permits be issued for consignments of minerals being transported within the country. Permits are required for minerals being transported outside the country."

Sengerema district police chief Bena Msoma said officers asked for documents authorizing the transportation of the consignment and were furnished by only one issued by the owner, namely GGM.

"We suspect that the consignment was being transported in violation of the law because no single document was issued by the government as the minerals officer gave us only a verbal explanation," Msoma said.

"I struggled to save myself: I thank God I wasn't seriously injured despite being in the front seat," he narrated.

Morogoro Regional Police Commander Willbroad Mutafungwa promised to provide a detailed report of the accident after completion of investigations.

Meanwhile, Home Affairs Minister, Kangi Lugola and the Minister for Lands, Housing and Human Settlements Development William Lukuvi have sent condolence messages to the families of the deceased.

Lugola said: "I have received with grief the news about the death of nine officials from the LSTP programme. My heartfelt condolence goes to the families of the deceased and Lands Minister, William Lukuvi."

Lukuvi said in a statement that the nation has lost quality manpower. He assured the public that the ministry was working to ensure all the deceased are transported and buried in their respective home regions.

Mwanza police seize 200 buckets of minerals over permits

Last month, police in collaboration with the Mwanza regional safety and security committee seized 323.6 kilograms of gold at the city's Kigongo Ferry on the shores of Lake Victoria. The gold was to be smuggled out of the country.

Mwanza Acting Regional Police Commander Advera Bulimba said the police have launched a manhunt for other suspected smugglers, noting that they need to eliminate the gold smuggling syndicate.

The arrested suspects whose number and names were withheld on investigative reasons were also found in possession of some 300m/, which was hidden in the boot of a car. "We are determined to end minerals

Police seize 210 million/worth of elephant tusks

POLICE in Morogoro yesterday arrested seven people allegedly in possession of nine pieces of elephant tusks worth more than 210m/-.

Morogoro Regional Police Commander, Wilbroad Mutafungwa told reporters here that the suspects were arrested during the operation carried out across the region.

He said that last week police managed to arrest two suspects in Morogoro Rural District after being found with two pieces of elephant tusks worth more than 36m/-.

"The pieces were hidden in a plastic bag," he said, adding that other five suspects were arrested in different parts of Ulanga District with seven pieces of elephant tusks worth more than 171m/-. According to the regional police



Wildlife stakeholders underscore need for further integration of natural resources laws

ILDLIFE stakeholders have suggested the need for the integration of natural resources laws and give communities more right and flexibility to explore more benefits from the resources without barriers.

The call was made in Dar es Salaam during the debate on challenges of managing natural resources with conflicting legislation: the case study of wildlife Act, organized by Tanzania Natural Resources Forum (TNRF) in partnership with policy forum.

Speaking at the event, Edward Lekaita from Ujamaa community resource team said there is a need for more cross sectoral natural resource management policy and governance.

He explained that conflict of laws and policies have created a serious hindrance to effective implementation of number of laws and more importantly the confusion created by those laws has created confusion in the aspects of benefits, rights, access, control and ownership of the resources to date.

Lekaita cited an example of land law, said that "land law are supreme when it comes to confusion between land and other laws on matters of land".

He explained that it is equally important to note that establishing a private forest reserve or community/village forest reserves does give a village rights to utilize wildlife in given areas.

He cited an example that establishment of Wildlife Management Area (WMA) does not give automatic rights to utilise forest.

Stakeholders have also called for annually national dialogue to enhancing learning and discussion between government, community, civil society organisations and private sector on management of natural resources on regular basis, and build capacity on key institutions to be able to improve both management and governance natural resources.

The forum recommended that future strategies of conserving biodiversity in parks should focus as much on the social economic human dimension of biodiversity conservation as the scientific study of species and habitats in national parks.

Stakeholders have also called for the translation of the important policy, regulations and laws to allow community to easily follow and understand their rights

Babati Rural MP Vrajilal Jituson said that inclusion of local communities in laws enactment procedures would serve the natural resources.

He stressed that local communities should at the first hand benefit with natural resources available in their area, with relevant authorities, including Wildlife Management Areas (WMAs) prioritising distribution of the collected funds to the surrounded people.

"It doesn't sound when local communities suffer from lack of social services while their areas are sources of income in various ways. These people are good conservationists of when involved. They can also be part of expanding tourism contribution to the national economy up to 40 or 50 per cent from the current 17 per cent," said the MP.

For his part, MP for Chambani in Pemba, Yusuph Hussein commented that, apart from involving local people in laws' review, they (laws) should also be put in mother language Kiswahili to make every Tanzanian understand.

The inclusion will also enable people to brainstorm and come up with good ideas on how to use the scarce available natural resources, including the land that has been decreasing following an increase in the population.

Tanzanian and South African experts exchange expertise

Tanzanian delegation touring South Africa has stressed the role of political leadership in the AIDS response and noted the importance of matching policies and legislation to the responses to HIV and tuberculosis (TB).

Led by Oscar Rwegasira Mukasa, the Chair of the HIV and Narcotics Parliamentary Committee of the United Republic of Tanzania, the delegation included Tanzanian Members of Parliament and representatives of the Tan-policies and legislation with technical

zania Commission for AIDS (TACAIDS). programming for HIV and tuberculosis Mr Mukasa said political leaders have an important role to play in uniting efforts in the AIDS response and harnessing domestic resources "so that we can stand on our own feet," during the 13 to 15 February visit.

The United Republic of Tanzania will take over the Chair of the Southern African Development Community (SADC) in August and the parliamentarians indicated they would use that opportunity to engage SADC ministers of health in developing policies on HIV and TB in the region. We need to align

to ensure that we are in synch with the 90 90 90 strategy," Mr Mukasa said.

This was echoed in a meeting with Aaron Motsoaledi, Minister of Health of South Africa, who emphasized the regional nature of the epidemics of AIDS, TB and malaria and called on the United Republic of Tanzania to use its forthcoming leadership role in SADC to advance coordinated policies and actions. Mr Motsoaledi, who is Chair of the Stop TB Partnership board, reminded the delegates of the inextricable linkage between HIV and TB and noted that TB is the biggest cause of

death in South Africa and of people living with HIV.

The delegates explored a range of issues, including the multisectoral response in South Africa, legislation, sustainability and service delivery arrangements, including public, private and community service delivery. The study tour included field visits to a community health centre and a medicine-dispensing ATM.

In a meeting hosted by the South African National AIDS Council (SAN-AC), its Chief Executive Officer, Sandile Buthelezi, told the delegation that HIV is still very much a health emer-

gency. Noting the high burden of the region, but said there was a risk of drug-resistant TB, he said that South Africa was adopting new treatment options. "South Africa has strong political leadership, yet still more needs to be done to reach our targets," he said. Mr Buthelezi stressed the importance of engaging civil society and working with government institutions and the private sector to coordinate efforts and ensure that the needs of people at higher risk of HIV infection and people living with HIV are reflected in HIV programmes. Kenyan farmers' improvised drip irrigation system produces food, protects environment

ON his quarter-acre farm in Athi River, an area to the south of Nairobi, Kenya's capital, Joseph Musyoka farms tomatoes that are currently fruiting.

He is hopeful that he will start harvesting the fruits from the 500 plants before the anticipated long rains season that is expected to start at the end of next month, and make good

A look at the crops shows that they are doing well, yet Musyoka does not water them using the popular drip irrigation system, which a number of Kenyan farmers

improvised his own drip irrigation system comprising of small used plastic bottles

filled with water. The system has not only helped him avoid the high costs associated with drip irrigation system, but is also enabling him to grow food despite the erratic weather in the east African nation as well as protect the environ-

"I paid two garbage collectors to get me the bottles from the nearby Athi River town where they are usually dumped and become an eye sore or end up in River Athi that passes in this area."

"They brought me some 350 bottles of various sizes

The youthful farmer has after two weeks of collect- lars to install a drip irrigaing, and went for me in the neighboring towns like Kitengela and Mlolongo. I paid them 2 shillings (about 0.02 U.S. dollars) for each," he said on Saturday, noting

> he has close to 1,000 bottles. Armed with the bottles, the farmer then planted his tomatoes inside the greenhouse after transferring them from a nursery.

"I then washed the bottles thoroughly and disinfected them to ensure they are free of any diseases. I, thereafter, made small holes on the caps of the bottles, filed them with water and inserted them in the soil near each plant," he explained.

The small holes made on the bottle caps release water slowly into the soil, penetrating to the roots of the plant making it thrive.

"I have been using the method over a year now and it is serving me well because my crops are flourishing especially during the dry season as it is now," he said.

Musyoka fills water in the bottles depending on the stage of growth the plant is

"If about a month-old, as that is when I transfer them from the nursery, I put in the bottle about 100 ml of water and refill after two or three days. If close to three months old when they are fruiting, I fill with 300 ml and refill after two days," he explained.

Though it is a tedious task, it is worth it, he said, adding that he refills after some days to avoid diseases like root rot which attacks the plants when the soil is too

It costs at least 600 dol-

tion system on quarter-acre farm, with the bulk of the money going to a water tank. including mounting it at a higher level, labour and the rest on the drip lines.

"Drip irrigation system is expensive because of its many costs. If you are far from the water source, you have to incur additional costs of pumping the water into the tank using most likely a petrol water pump, before it flows to the plants. This raises expenses," said Moses Andati, a farmer in western Kenva.

Andati is also using the improvised drip system to grow bananas and vegeta-

Beatrice Macharia, an agronomist with Agro-Point, a consultancy in Nairobi, noted that the innovative drip irrigation method is part of permaculture, which utilizes ecologically friendly farming methods.

"In this system, farmers are encouraged to use things that are readily available in their environment to grow food in a sustainable way,' she said, noting however, a majority of those using it are in dry areas which receive little rainfall.

In Kenya, the bottling method is used on food crops and even on trees and flowers especially during the dry spell, according to Macharia.

Through the method, she noted Kenyan farmers are helping the country curb the plastic bottle menace that is chocking east African nation's rivers and the environment by reusing the bottles and later disposing them in a better way.

UNDREDS of youths Dodoma Region have benefitted from an entrepreneurship raining programme aimed at equipping them with life skills and business basics.

THLETES and athletics officials in Tanzania and other African countries have lately been engrossed in an interestind dispute, as to whether the International Association of Athletics Federations (IAAF) was right in changing the rule on participating in women athletics contests. The federation has handed down a rule that limits the level of the testosterone hormone.

Rapidly as it can be seen from its first four letters, it is a hormone that has to do with sex hormone levels, if one is sufficiently female to compete in that

If one is well above normal or admissible testosterone levels as in the case of South African runner Caster Semenya, she is barred.

Semenya is suing IAAF for the change of rules, where some of her supporters are beginning to talk about 'racism' as it appears this is a rule formulated against her rather than for the game as a whole.

That argument doesn't appear sufficiently meaningful as it pretends that it is her colour rather than her frame and figure that is at issue, whereas even a visually challenged observer would admit that there is something out of the ordinary in this case.

In that case it needs to be admitted that IAAF is pursuing fairness, not targeting an individual runner.

To say that it is unwarranted to target an individual simply because of her body is to suggest no rules need to be set up about bodies in athletics, or any other sports for that matter.

A similar rule was at one time set up



Voice of Africa calls for maturity - 1

At the launch of the MDC in 1999 Morgan Tsvangirai got carried away and chanted that infamous "We will remove vou violently" statement that got him in trouble with the law. It was a sign of immaturity that was to be followed by many more similar bloopers, like openly calling on South Africa to switch off electricity on Zimbabwe and so on.

The MDC is turning 20 years in September this year, and it is now under the leadership of Nelson Chamisa. Like his predecessor, Chamisa has shown his own version of immaturity, albeit in a more breathtaking manner.

He started off by calling on the United States to keep economic sanctions against Zimbabwe in place; followed that up by blatantly lying that he had personally met Donald Trump and was promised billions of dollars. He also made outrageously ridiculous promises in the run-up to the July 2018 election, but more importantly he declared that no result of the election other than his victory would be legitimate, regardless of how the election was rated by observers, or how the people voted. His win was the only acceptable arbiter for the legitimacy of the election itself.

Even today, Chamisa sounds more than convinced when he says there is a legitimacy crisis in the country. He believes his absence from Government is in itself a legitimacy crisis, and he looks so serious about it, it's not funny.

When he lost the election by about 400 000 votes last year, he announced he was going to appeal the result at the Constitutional Court, and again he said only one court outcome would be acceptable to him - a ruling in his favour. He said any other outcome would not be acceptable or legitimate, and that he would be left with only one option - to pour sand in the national food plate. His youthful supporters are quite impressionable about this slogan.

When Tsvangirai was giving his maiden speech at the MDC launch in 1999, he was, like many in the then young leadership in the opposition, clearly carried away by the rhetoric of freedom and democracy. This would shape the modus operandi of the opposition for many years to come - the idea that freedoms and liberties to cause trouble are the essence of democracy.

To the then emerging political leadership in the opposition MDC, and to its equally emerging support base the rhetoric about a promised new era of freedom and democracy through "change" created a wayward kind of zeal. It was like a rich kid just discovering the Church of Scientology.

The zeal marked the beginning of

an evangelical road to discovering the wonders of democratic liberties as espoused in the synoptic gospel of international law in general, and human rights law in particular. To most of the MDC activists, human rights law is all about permission to freely hold political rallies and violent street marches the right to deride, ridicule and vilify political opponents without censure, opposition-organised marches.

On January 14 this year we saw that our opposition has sadly regressed back to the politics of immaturity - something that had changed after the election of 2008. So we have a party whose supporters believe free media is media that relentlessly bashes ZANU-PF and forever praises everything and anything

violent and deadly MDC Alliance riots, there has been massive exaggeration, sensationalisation and biased reporting on the State's response to the violence. While there are genuine and meritorious cases of abuse of power by some rogue members of the security forces; including but not limited to reported robberies, extortion, bashing of innocent civilians, and so on, there are also countless of unsubstantiated stories about killings, rape, torture and other atrocities, most of which are very sensational. Tendai Biti has even

The opposition has roped in our erstwhile colonisers, so yet again, in the name of upholding the rule of law, we are seeing a renewed onslaught on the efforts of Zimbabwe to recover its economy and rejoin the family of nations. We hear voices saying we do not qualify for a good economy and a place among the family of nations because our security forces did not allow our hooligans and thugs the freedom to do as they pleased on January 14.

We should have left them to burn the country down until ZANU-PF invites

We are still stuck with an opposition of economic sanctions on our economy - an opposition that openly hails and defends ZDERA, the United States sanctions law. This is a sanctions law that is supremacist in content, and imperialist in application.

It is now almost 20 years after the MDC was formed, and Zimbabwe is grappling with efforts to stabilise the rocking boat that our economy is. We probably sunk to our deepest lowest in 2008, after which the economy showed signs of recovery.

When Nelson Chamisa took over the MDC after the death of Morgan Tsvangirai he clearly was convinced that the only way to remove ZANU-PF from power is to exacerbate the country's economic woes.

So Chamisa leads a party that celebrates cash shortages, a party that cheers government failure, a party that attacks those who condemn sanctions on Zimbabwe, a party that rejoices in the anger of the masses, a party that spreads hate towards authority, a party that is totally committed to sabotage, rebellion, and lawlessness. A party that wishes for the day hospital staff will leave patients to die en mass on their hospital beds; a party that celebrates the day when our teachers desert our schools to leave our children unattended.

So the MDC will attack any country that welcomes our Government, including the UK, and will lobby the EU, the Commonwealth, the World Bank and the IMF to stifle every effort at economic recovery from the Government of Zimbabwe. Nelson Chamisa calls it pouring sand in the national food plate, and he openly brags about it.

Pro-opposition Zimbabweans in the Diaspora strongly back Chamisa's isolationist politics, on whose basis many of them gained entry into Western

countries as asylum seekers. In September 2007 the MDC under Tsvangirai changed course and joined hands with ZANU-PF to pass Constitutional Amendment No. 18 without debate. This was to facilitate the dawn of harmonised elections where elections for local government, Parliament, Senate and the Presidency

all take place in one day. Lovemore Madhuku and his then NCA civic organisation were totally angry for obvious reasons. The MDC was endorsing a Constitution that the NCA was fighting, and that was treachery. The BBC described the opposition's move as a bargain deal; we Zimbabweans saw it as political maturity on the part of MDC MPs. Thokozani Khupe said it was the beginning of the end of the Zimbabwe crisis. Ironically, she has said exactly the same words after a national dialogue meeting recently convened at the State House by President Mnangagwa.

Nelson Chamisa was as expected absent at the dialogue meeting, ostensibly because he does not want to mix with election losers. He came second best, therefore he is not a loser like all others, and no meaningful dialogue can happen without him the man who defines the legitimacy of everything. In 2007 Africa asserted its opinion on the politics of Zimbabwe, effectively taming and rehabilitating the opposition so it could depart from its identity as a Western political project to a truly home-grown African democratic party. It appears all gains made to this effect when Tsvangirai was still alive have been eroded badly since the day Chamisa took over the leadership of the main opposition illicitly.

Back then it took Africa just five months to speak so eloquently and clearly to the MDC, without giving the party a single cent, as would the West whenever they wanted to spur the opposition into some form of action.

ambo for the week, and after the last one gave me so much discomfort writing in the dark at night, courtesy of Tanesco, whilst swatting the mosqui toes with my hand held fan as the food rotted in the warm fridge (also courtesy of the ON/OFF national power supplier) I'm geared up for more of the same this week, but how to explain power cuts to none locals.

...because I've got some visitors arriving soon, who are interested in seeing what's left of Dar es Salaam, hopefully, they might be so shocked, they won't notice the Tanesco torment...which seems to be increasing.

Well, having an office and house clearout recently, I came across my old "dodgy doings" folders. These are bulky records on many misdeeds I've reported on over the years, and after being away for some time, would ask friends "what dodgy doings have happened in my absence"... hence the files name.

Anyway, it seemed some 'doings' reached epic proportions, particularly in the land grab domain, which

became an informal sector 'industry'. In agrarian societies, honest peasants valued land, but in Tanzania, it's often been their urbanised brethren in the guise of the friendly local businessman/investor, that had the will and the bank balance to appropriate whatever took their fancy, in city or village, or perhaps both.

In the same way, they could subvert Master Plans, arrange for structurally sound buildings to be classified as 'unsound'... then demolished, and the empty space 'developed' by them.

Returning here in 2010, with some visitors who used to love Dar's old town centre, and the wonderfully crafted Indian buildings that gave

the city its heart and character, they were shocked that so much of it had gone, and wondered sadly how it was allowed to be destroyed.

Long neglected by the city fathers, their disappointment continued on seeing the neglect of the Botanical Gardens near Karimjee Hall, and recalling how wonderful this oasis used to be

It was my curious visitors, a few years ago, who on leaving the Sea Cliff Hotel asked us to stop and find out why so much of the land nearbye had been 'cleared'. I didn't know the answer, but told them that allocations in such wealthy prime coastal areas, were frequently the result of 'dodgy doings'! After their departure a week later, this 'project' was decried in the media, and was as dubious as it appeared, exposing major malpractice from Kinondoni Municipal Council land officers.

Though the results of their misdeeds were later revoked, by their collusion in apportioning this large beach area in Masaki, the council were maintaining a tradition of unethical land disbursement in the country, the subsequent disputes of which will perhaps still continue to

cause havoc and disruption in the future, and enrich the legal profession in the process.

But surprisingly, defending this action at the time, Lands Minister John Chiligati said "this area could have lain idle, as the council lacked resources to develop it".

However, in the years following these comments, various large waterfront projects appear to have been given the go ahead, and visitors to some of Zanzibars coastal areas are bemoaning the fact that there are now too many beach hotels, making the Spice Isles, less special.

So government policy now appears to be full steam ahead for built up shoreline areas, but with maybe a a few token ones left 'unspoiled' to give a good impression to those caring for the environmental aspects of over building.

But let's imagine a notice to bureaucrats in this sector...

A long term user of this facility, and its glorious beach, I went home to Britain for some time, and on returning, was stunned to find a hotel and bar operating in the now greatly degraded and rubbish strewn area.

The then City Commission ordered the business to be closed, and attending the local court cases I asked in the Guardian of August 1996, "Will Commissioner Charles Keeja be forced to back down on the Coco Beach Hotel, now that the illegal construction has been officially opened by Mrs. Mkapa"?

..the sorry saga continued, but the case finally came to an end in a City Court, as the magistrate ordered its director to pay a 45,000sh fine and closed it down, after the commission had been fighting to achive this for some time.

...the closure duly happened, and I went off to the UK, returning to find it fully functioning once more!

Nearly two decades later, the degradation of this once pristine and perfect tropical beach is complete, and though giving gainful employment for people, the hotel has become a squalid settlement, extending to other areas also, and could best be described as Masakis'... Manzese in the making...but can this be reversed now it's under the auspices of the

Kinondoni Municipal council?

This ugly blot on the landscape, has been a very visible testamenbt of government failure to protect fragile resources, and proves that what has sometimes passed for development in Tanzania, has at best been the result of official ineptitude, at worst corruption...or more often or not, a combination of both...though in these Magufulian times, there's a glimmer

...but where was the so called National Environmental Management Council (NEMC) whilst this was going on for years?!

...time to close on the dictionary definition of "dodgy"----*dishonest...*criminal...*not reliable...*dangerous...that'll do!

...I think I'll keep my visitors away from beaches and cities, and head for the mountains...but with 'development' the buzz word, are there cable cars going up the 'Killi' yet... and maybe a shopping mall at base camp?!

Nigeria and politicking - from Ogunwusis straight to the 2019 presidential election

UCH as ethnic establishments and/or authorities have, for quite a while now, turned into a sad remnant of what it used to be, you can't cancel out how ethnic pyramids have been a wellspring of reference if there is a discussion on political power tussle in Nigeria.

History may have been abridged because of colonialism (add slavery) thus, the new age and possibly, some who are middle-aged won't comprehend when we talk about how politicking has been a piece of our inward culture. Thus, read on, let us go through this together.

Of particular interest in this piece is the story of the Ogunwusi's from Osun. Ile-Ife, Osun is the cradle of the Yoruba race and is usually described in a rustic manner embedded with instances of a filial feud, the most recent being the one between Adetunji Ogunwusi and his younger brother Enitan Adeyeye Ogunwusi-who were engaged in a battle of entitlement to the Ooni of Ife

The procedure for choosing the Ooni was simple; at least, until the feud: the State Government writes to the Ruling House, whose turn it is to provide a candidate. The Ruling House meets, choose their candidates and send same to the State Government.

The Ifa priest also receives this list from the kingmakers, who approves one name and sends to the State Government, where the final approval takes place. Installation, by the kingmakers, follows.

But, Adetunji who was desirous of the revered seat and enjoyed the support of their mother frowned at En-



itan, who was fully supported by their father. And so, the politicking ensued.

The two brothers solicited support from prominent Ife indigenes. This is where influence and 'generosity' towards king makers became a deciding factor. Midway through all these, there were allegations of fraud levelled on the two brothers by the Sijuwade family's estate.

Are you seeing similarities between the top two contenders of the 2019 presidential election yet?

Adetunji had initially thought his younger brother was goofing around and so, confident Enitan's interest will fade out. Besides, Adetunji thought

his brother did not have the financial strength to pursue such a lofty cause. He was left disillusioned when it dawned on him.

As much as we want to recognise the ambition of the 70 other presidential candidates in the 2019 election, it is pertinent to note that two candidates-Muhammadu Buhari and Atiku Abubakar-have led us to reference the story of the Ogunwusi brothers.

Usually, an election in Nigeria begins three years earlier and with the 2019 election, Atiku, who had been an ally of Buhari, reminds us of the power tussle between Daenerys Targaryen and Cersei Lannister in the popular seriesGames of Thrones (yes, go watch it if you have not). Although, the politics is quite different.

Buhari, just like Adetunji, is of the opinion that he is more entitled to Nigeria's highest office and has, therefore, titled his campaign - Next Level.

Atiku, on the other hand, is relying on some other political powers and the perceived failure of the incumbent to provide the 'Change' that he promised in 2015. Indeed, there seems to be an elementary mindset - at surface level - that we can simply look at the two situations and comprehend the whole of Nigeria politics. Yet, we should not forget the way that Nigerian

politics is unreasonably unpredictable for naked comprehension. Nevertheless, it is essentially similar stories that play out every other election year. Without doubts, tricks, hypocrisy and conspiracy is the guideline on which Nigerian politicians depend on.

Also, you cannot leave out the fact that both Atiku and Buhari are from the same demographic population, have widespread influence, have been involved in Nigerian politics from independence, and have shown to have the kind of cult-like following that wins elections in Nigeria.

But who is going to be disillusioned this time around?

Cost of counter-terrorism for civilians in Liptako-Gourma

tates in the Liptako-Gourma region - including Burkina Faso, Mali and Niger - are imposing restrictive measures to try to quell the growing threat of terrorism. These include limiting the freedom of movement in several parts of their territories.

Burkina Faso's government declared a state of emergency in seven of its 13 regions on 31 December 2018 due to increased attacks by violent extremists. In all Liptako-Gourma countries, emergency measures have included banning motorbikes and pick-up trucks, restricting people's movement and closing markets and weekly bazaars in affected areas.

The authorities argue that motorcycles are used by violent extremists to carry out attacks, and that these groups also use markets, especially weekly ones, to buy food supplies. They also suspect that the groups benefit from illicit trafficking such as cross-border fuel smuggling, to finance their activities.

In Central Mali, the decision of the army chief-of-staff on 1 February 2018 to prohibit the use of motorcycles and pick-ups in many areas generated mixed reactions. While the authorities believe this decision has significantly reduced the number of attacks - mainly those carried out by armed individuals on motorcycles - people complain about the constraints caused by the prohibition.

The measures are meant to stop terror attacks, but they are depriving communities of a big part of their livelihoods, and are further increasing their vulnerability.

Between June and September 2018, the Institute for Security Studies (ISS) interviewed community members in Liptako-Gourma to understand the implications of counter-terrorism measures. Results show that the prohibition has negatively affected the movement of people and goods in peripheral areas that rely on pick-ups and motorcycles for transport.

In some places, restrictions on the use of these vehicles has led to a rise in the cost of transport and the price of goods. In the Ténenkou Cercle in Mali's Mopti region, the price of 1 kg of catfish has increased from 1 250 CFA francs (US\$2.15) to 2 250 CFA francs (US\$3.87).

The supply of goods to markets has

been negatively affected as producers from neighbouring villages such as Nouh Bozo and Sènè Bambara are finding it hard to transport their produce. This has increased the risk of food insecurity in the area. Disruption of supply chains has also worsened the livelihoods of farmers who are unable to move their goods to urban markets.

In the south-eastern Diffa region of Niger, where Boko Haram has been active, traffic bans or market closures have been in place since 2015. These measures have since been extended to the Tillabéri area after numerous terror attacks were attributed to armed people who often travel on

In Tillabéri, motorcycles are used for medical evacuations and to supply medicines. The restrictive security measures have made some health workers unwilling to visit areas under the state of emergency. The situation has undermined the operations of integrated health centres or health huts, affecting delivery of, and access to, basic social services.

For most interviewees, the measures haven't stopped terror attacks, and have negatively affected their socio-economic wellbeing. The actions were also taken without consulting local populations to ensure their effectiveness and applicability to specific contexts.

The trend in terror attacks in several parts of Soum province (Burkina Faso) which borders the region of Mopti (Mali) where traffic bans have been in place since March 2017, shows no clear sign that the measures have been effective.

Straight after the restrictions were imposed, the number of attacks dropped, but then rose again, as violent extremist groups adapted. So, despite the restraints

and traffic bans, insecurity linked to the terrorist threat persists, and has even spread to other parts of the Liptako-Gourma region. The figure below illustrates the trends in attacks before and after the imposition of restrictive measures.

The economic impact of the closure of weekly markets has also been significant. Besides the loss in income for traders, markets occupy a central place in people's lives and represent important spaces for social, political and cultural exchanges. They contribute to strengthening social cohesion in areas shaken by inter-community tensions.

The restrictions have not only deprived people of their livelihoods and access to services though - they've increased their vulnerability to violent extremism, as these groups exploit the situation to lure youth into their fold.

Although state agencies see restrictive measures as effective and instrumental in the fight against violent extremism in Liptako-Gourma, on the ground there is frustration and disapproval from local populations. People see themselves as double victims caught between violent ex-

tremist groups and government responses. States in the region need to address the shortcomings associated with these counter-terrorism actions, and improve communication with local communities when they are implemented.

The restrictions should be gradually eased when the security situation allows. This could be accompanied by other efforts such as providing basic social services, including food and healthcare. In offering these services, security and defence forces could provide a social role and compensate for the shortage of state personnel and humanitarian organisations in these areas.

Restrictive counter-terrorism actions can be counterproductive if they make it difficult to build trust between government and citizens. To prevent and counter violent extremism, Liptako-Gourma states need to develop strategies based on communication and consultation with communities. This will strengthen relations between the state and civilians, and increase community resilience to violent extremism

India toxic alcohol deaths jump to 133 - police

GUWAHATI

At least 35 more workers have died in northeastern India after drinking toxic liquor, police said Sunday, taking the death toll from the latest mass alcohol poisoning beyond 130.

The deaths in Assam state came less than two weeks after tainted liquor killed about 100 people in the northern states of Uttar Pradesh and Uttarakhand.

In addition to the latest toll, at least 200 more people were still hospitalised across Assam.

"The death toll has reached 133 in Golaghat and Jorhat districts," Mukesh Agarwala, additional director general of state police, told AFP on Sunday.

"A total of ten people have been arrested. We have sent the samples of the liquor... to a forensic laboratory. The report is awaited," he added.

Police said people started falling sick after consuming a batch of illegally produced liquor late Thursday.

The victims, who include many women, worked at local tea estates in the region.

Doctors said those rushed to hospital in a critical condition were suffering from severe vomiting, extreme chest pain and breathlessness.

Assam Chief Minister Sarbananda Sonowal has ordered an inquiry into the deaths.

Apart from the arrests, two excise department officials were suspended for failing to take adequate precautions over the sale of the alcohol.

Assam health minister Himanta Biswa Sarma vowed those responsible for the tainted liquor would be brought to justice. Hundreds of mainly poor people die each year in India from tainted liquor, which normally costs just a few US cents a bottle.

Cheap, locally made booze is common in rural parts and bootleggers often add methanol -- a highly toxic form of alcohol sometimes used as an antifreeze -- to their product to increase its strength.

If ingested in large quantities, methanol can cause blindness, liver damage and death.

Many drinkers in Uttar Pradesh and Uttarakhand were taken to hospital earlier this month in writhing pain after drinking illicit alcohol.

About 100 people died after consuming the tainted moonshine.

In 2015, more than 100 people died in a Mumbai slum after drinking illegal liquor.

How Rwanda is winning malaria fight

Following the malaria contingency plan that was put in place in 2016, severe cases of malaria and mortality have since decreased by 50 per cent.

There has also been estimated reduction in the country's malaria burden with 430,000 fewer cases recorded in 2017 than in 2016, according to the World Health Organisation report released last year.

These achievements are attributed to many factors and one of these includes the outstanding role played by Community Health Workers.

Information from Rwanda Biomedical Center indicates that more than 50 per cent of malaria cases are now treated by Community Health Workers.

With the introduction of Home Based Management of Malaria (HBM) for both adults and children through Community Health Workers, malaria patients are being diagnosed and treated early.

Before this strategy was introduced, however, patients had to travel to

health facilities, far from their homes, to seek medical services, a hunch that delayed service delivery and in turn limited or rather increased the number of severe malaria cases and mortality.

Dr Aimable Mbituyumuremyi, the Malaria and Other Parasitic Diseases Division Manager at Rwanda Biomedical Centre, said that empowering Community Health Workers through training in fever malaria diagnosis and treatment has been a key to this success.

Before 2015, Community Health Workers could only manage malaria in under-five, but in 2016 results showed that adult people can also be managed by well-trained CHWs.

With a strong supervision of Health Centers in the catchment areas, CHWs are well equipped to manage fever at the community level but also provide other health related services and are trained on how and when to refer or notify any complicated cases, he said.

"CHWs are receiving malaria Rapid Diagnostic Tests and Antimalarial Drugs so that they can easily provide services to those in need. Malaria free of charge services to the poorest people (Ubudehe 1 and 2) at the community level has greatly contributed to increased services seeking," he added.

More key strategies for malaria control include mass distribution of bed nets to the whole population (Universal coverage), routine distribution of bed nets in most vulnerable groups (pregnant women and under one year).

They also include Indoor Residual Spraying (IRS) in the most affected districts, early diagnosis and treatment at community level and educating communities for malaria prevention and services use.

From 2016 to 2018, malaria cases decreased more than 10 times in Nyagatare and Kirehe districts where Indoor Residual Spraying (IRS) has been sustainably implemented.

Malaria continues to represent a real public health concern in Rwanda despite evident progress and numerous efforts being combined for malaria control.

Educational research since 1967: Everything, except the main issue?

Educational research since 1967: Everything, except the main issue? Issa Mcholo Omari (Prof Dr) **Author:** Oxford University Press, Dar es Salaam **Publisher:** Date/Size: 2011/170pp., 28pp glossary

through this publication tell a local observer or visitor if the study or as the author says, experience that is compiled and applied in this study is about Tanzania specifically or it is education research in general, at best with Africa in the background. That is why a critical review ought to approach the work from a localized point of view and examine how the concepts and methods outlined lead to a comprehension, even a reconstruction, of the sort of educational scenario that we have had for the better part of 50 to 55 years. It has by all accounts been a period of steady decline in education output, and ostensibly research never had a let up.

In a way Emeritus Professor Omari is well placed to reflect on the subject, and as contradiction would have it, depict precisely through that reflection what the problem is all about, for the simple reason that the publication more or less

E A D I N G some remarks, or lateral productions that focus on other issues, for instance educational management and budgeted resources, how they have declined over time, or expenditure per pupil or student during the past 50 years. If that parameter is taken into account it becomes evident that there is no crisis of education as a profession but part of a wider environment, of failure.

While the purpose is to

highlight educational research concepts as such, it is only in a specific sense that the concepts are being applied in education, as they cut across social sciences generally, and their origins aren't in any of the sciences but in philosophy. As the latter shed its hegemony to various applied sciences, behavioural research was adopted across the field, with each discipline adapting the concepts to its specific needs, picking the relevant examples, focusing on problems that stem from human life seen from that perspective, for instance in education cused on suicide. The main part of the

study, relating to meaning of research, identifying a research problem and key research operational ideas or 'paradigms' already show the depth of the problem, for being completely general in character rather than set in a specific medium, context or historical framework. The subsequent part of this conceptual mapping of educational research is equally technical in detailing things like sampling, data collection procedures, statistical techniques and how to write a research report. At times phrases that have been made familiar for other reasons come up, like 'evidence-based decision making,' that Uongozi Institute and REPOA are trying to pursue in relation to growth strategies of the fifth phase. Seeking out evidence, or real evaluation?

A series of interesting or key concepts and issues are treated separately in annexes, boxes and figures, which are serialized to seven, six

in passing in the main exposition. As the presentation is a rather hurried overview of all what there is to know in conceptualizing research, with rather limited application to education as such, as in picking up examples of researchable and nonresearchable issues/questions among others, these auxiliary presentation cover areas where the author is aware that students usually have problems in those areas. Graduate students, to be

precise. One can say that the book has to basic uses that are immediately possible or are likely to have been the broad format of using the contents of the book, that for undergraduate students it is a textbook on research methods that they need to have under their laps. It is a way of avoiding having to read too intensely a whole stretch of textbooks as this manual is basically a professor's polished lecture notes corrected and improved over the years, as well as precisions arising from both courses and solving practical problems in the field. For graduate students, the book is closer to what is seeks to be: guide the master's and doctoral student setting out

It is a different issue altogether if one was to venture

to demand what aspect of the book or collection of issues in the wide field of research triumphs over the other, whether it is its textbook and course summary function for a degree course in research methods, or it is its applied function. Views in that area may differ as in either case it will need plenty of complementary material, where the issues are treated in a longer and conceptually more robust manner, not one, two or three lines about a key issue in this or that area. It is this limitation that makes the book approximate what less prominent

educationists do, producing past papers as a learning trove.

The work is in part an illustration of the fact that students are exposed to the main issues in social sciences, and often quite intensively, but the presentation and its use for course purposes and examination bespeaks of that particular failing. That there is no debate to which the professor emeritus is delving into and making a point about it, which would also reflect a wider environment of dispute and clarification on those issues. For instance there is no research being referred to where its mode of conduct would highlight for instance traps in the use of various research concepts or methods. Nor is there a background narrative on educational research in the country as special in one way or another, for instance the ravages of equating farming with learn-

ing in the 1970s. Perhaps Prof. Omari overreached himself with a sense of humour in introducing himself in a preliminary page, 'about the author,' where there is gender bias, fatherly pride, exhaustive sense of success and a bit of jingoism in saying that "he is married to one and the same wife since 1972," as if to poke a finger at those who divorced, etc. He points out that the conjugal partner is an educator as well, holding an MA in Education, and they have three children, one holding a PhD in neuroscience and two daughters, holding master's degrees in environmental management and international development, respectively. While all this is all happy and nice, there is a hidden research or knowledge implication, that with this sort of family, what he says must be right!

he warring parties in South Sudan should hasten implementation of a peace agreement signed late 2018 in order to secure financial support from the international community, experts told Xinhua.

Augustino Ting Mayai, a policy analyst with the Sudd Institute, a Juba-based think-tank, told Xinhua there were limited funds in the state coffers to facilitate implementation of the peace deal hence the need to seek external support.

"We are getting some money from oil revenue but this is not seen in terms of government spending. As we know there has been only 400,000 U.S. dollars available for funding peace," Mayai said on Wednesday.

He said that the government's failure to allocate enough funds to support peace deal's implementation could be interpreted as lack of commitment by the international community.

Michael Makuei Lueth, information minister, disclosed last week that the government is looking for over 44 billion pounds (285 million U.S. dollars) in order to implement the peace agreement.

Makuei revealed the state will be taxing civil servants' salaries for over a four-month period to mobilize cash to expedite the peace process as the pre-transitional period ends in May this year.

The international community has nevertheless adopted a "wait and see" strategy, having seen the 2015 peace agreement collapse during the renewed violence in July 2016.

peace agreement has made the United States, Britain and Norway under the Troika grouping become uei.

Nathaniel Oyet, representative of SPLM/A-IO on the National Constitutional Amendment Committee (NCAC), said the draft constitution violates the peace agreement, since paragraph five in the preamble of the peace agreement calls for federal system as the preferred choice for the people of South Su-

"We do not accept the procedure being used by the chairman of National Pre-Transitional Committee (NPTC). We raised this issue with IGAD and the guarantors of the peace agreement," said Oyet, adding that they are waiting feedback from peace guarantors on the contentious issue.

However, information minister Makuei said the opposition's disgruntlement over the draft constitution was unnecessary, since the document has backing from the regional peace mediators, the Intergovernmental Authority on Development (IGAD).

"These people are just trying The collapse of the previous to create unnecessary (demands) things. IGAD has already endorsed the draft constitution," said Mak-

There are currently more than 400 peace delegates from both the government and opposition being accommodated in hotels in the

Makuei revealed that they are persuading Thomas Cirilo, the leader of the National Salvation Front (NAS) whose group despite having signed the ceasefire agreement continues to fight government and SPLA-IO forces in Yei River and Amadi states in Central Equatoria region, to join the peace process.

"Thomas Cirilo is causing a lot of havoc in the Yei River State, but we have people talking to him to come and join the peace process," said Makuei.

James Okuk, political science lecturer at University of Juba, said that the real work has not been done despite formation of the various committees in place.

"A lot has been done especially on provisions in chapter 1 of the peace agreement. The real work that is needed is not yet there apart from formation of committees," said Okuk.

He disclosed that the key important things that are yet to be worked on include the cantonment of forces, identifying the number of states, demarcation of the borders of the states.

Okuk added that the Cessation of Hostilities (CoH) is being violated in Yei River state forcing some estimated 5,000 people to seek refuge in DR Congo, hence creating doubts on the current peace agreement.

He said NAS under Cirilo are left with no choice but to join the peace deal as regional and international pressure intensifies on them. "They (NAS) are left with no choice but to join the peace process, because I don't know which objective they want to achieve. Even if they



see them achieving their objectives," said Okuk.

He also said the Disarmament Demobilization Commission has not been set up.

Biodiversity loss rapidly pushing the food system towards collapse

he current industrial model agriculture underpinning the global food system is destroying itself - and humankind with it. This is the conclusion one could draw from a just-released report by the UN Food and Agriculture Organisation (FAO) entitled State of the World's Biodiversity for Food and Agriculture.

The report provides some alarming details of the irreversible and catastrophic damage being done to the planet's biodiversity, specifically that which sustains the global food

It outlines humankind's reliance on a small group of species, the destruction of habitat and land-clearing, and the unsustainable use of resources as key factors in the rapid loss of biodiversity that is tearing apart the living systems that feed the planet.

The FAO's exhaustively researched report is the first of its kind, but its subject matter goes to the very heart of Slow Food's mission.

Since 1996 Slow Food has been fighting and crusading for the need to save biodiversity on planet Earth, including creating the Ark of Taste - a catalogue of foods at risk of disappearance, which recently added its 5,000th product.

Also included are creating deed, humankind must turn 575 Presidia, empowering and supporting farmers and food producers who work in harmony with the environment and promote local biodiversity; and campaigning against the current destructive and unsustainable model of intensive in-

dustrial agriculture. Slow Food has long been working with the FAO to develop food and agricultural systems that are better for consumers, producers, and the planet. In fact, Slow Food President Carlo Petrini is a FAO Zero Hunger Special Ambassador for Europe, which highlights the affinity between the two or-

ganisations. Time is running out and, inthings around within the next ten years or risk a total and irreversible collapse.

This relies on combining modern knowledge and technology with its traditional counterparts as well as redefining our approach to agriculture and food production by placing the preservation of biodiversity and ecology on equal footing

with profit and productivity. Action on every level, from small-scale farmers and producers to the highest levels of government and through regulations like those in the EU Common Agricultural Policy (CAP), must be geared towards a food system that protects biodiversity.

Treasury withholds billions in funding for Dar priority projects due to laxity

DISSATISFIED by laxity in executing priority projects including construction of modern markets at Magomeni and Kisutu, Vingunguti slaughter-house, Treasury has withheld the release of 38bn/- allocated to three major projects in Kinondoni munici-

Speaking at the end of her three days tour of the municipality last week, Deputy Minister for Finance and Economic Planning, Dr

Ashatu Kijaji said Treasury is not convinced by the pace of construction of the projects hence her decision to withhold funding.

"We need to pull up our socks and implement these key projects as a matter of urgency," Dr Kijaji said while challenging municipal authorities to put their act together and speed up the process. She said 5.5bn/allocated for the 8.5bn/- Magomeni market will not be released so too is 3bn/- allocated for Vingunguti slaughter-house.

The three projects which also includes

that of upgrading Oysterbay beach which has been allocated 14.1bn/- and Tandale modern market allocated 9.7bn/- and Kibada modern market with a 14bn/- allocation.

"We will not release the funds allocated to implement these strategic projects in the second phase because supervisors of these projects will be the same people," the Deputy Minister added.

"We will only release the funding if we see satisfactory progress being made on the ground," she charged. She urged Kinondoni,

Ilala and Ubungo District Commissioners to strictly supervise the priority projects which Treasury has already released some funding because President John Magufuli wants all municipal councils of the commercial capital to be self sufficient after the projects are

"But equally important is that we should not politicised these strategic projects because they are meant to empower all people economically regardless of their political affiliation," Dr Kijaji stressed.

During her three days inspection tour, Dr Kijaji visited 22 projects which were financed by 147bn/- Treasury grant released in May 2018 which include Kisutu, Mburahati and Magomeni modern markets; Vingunguti modern slaughter-house and Mbezi Louis upcountry bus depot.

She commended Ubungo municipal officials for a satisfactory implementation of Mbezi Louis upcountry bus station promising to back completion of the project on

Johnson & Johnson under investigation over fears its baby powder may cause cancer

LONDON

LET'S be clear: If you know that your baby powder is pure, there's nothing dangerous about slapping some on a newborn or sprinkling a little bit in some smelly shoes. But for Johnson & Johnson, which has come under fire recently due to concerns about contamination in its baby powders, millions of dollars are now riding on a few tricky questions.

The first is: did the company know that its powder may have contained some asbestos when they sold it? And second, if there was asbestos in the baby powder, how much was there, and was it enough to cause harm?

The questions stem from the use of talcum powder in baby powder; talc can sometimes be contaminated with asbestos - a known can-

cer-causer - because the two naturally occurring Earth minerals are often mined in close proximity.

Johnson & Johnson disclosed on Wednesday that federal regulators were raising questions about the company's baby powders in a filing with the US Securities and Exchange Commis-

That federal investigation comes on the heels of a series of lawsuits about baby powder, some decades in the making. The most recent suit was decided in July: A jury in Missouri ordered Johnson & Johnson to pay up \$4.7 billion to 22 women who claimed the company's baby powder caused their cases of ovarian cancer. The company maintains that's not the case.

"Johnson & Johnson remains confident

that its products do not contain asbestos and do not cause ovarian cancer," the company said in a statement after that verdict was announced.

Questions remain about Johnson & Johnson's product

There are clues that suggest Johnson & Johnson baby powder may have had some asbestos in it, and that people inside the company knew about it.

In December 2018, a Reuters investigation revealed internal documents from the company that showed that from at least 1971 to the early 2000s, "the company's raw talc and finished powders sometimes tested positive for small amounts of asbestos."

After that Reuters report, Johnson & Johnson CEO Alex Gorsky said again that there was no asbestos in the company's products. "We know that our talc is safe," Gorsky said in a video message on the company's website. He added that the company uses the "purest, safest, pharmaceutical-grade talc on Earth," and that the baby powder "does not cause cancer or asbestos-related disease."

The US Food and Drug Administration (FDA) conducted a study from 2009 to 2010 that checked 34 different talc cosmetic products, including baby powders, and found no asbestos fibers.

Another study of earlier powders in the 1960s and 70s also found no evidence of asbestos. But Johnson & Johnson has not yet revealed any internal information about asbestos tests or concentrations, and without that specific data, it's hard to know exactly what was or is in its baby powder.

The messy link between talc and asbestos Asbestos miners have been diagnosed with lung cancer for centuries, but the studies investigating whether talc miners get lung cancer are mixed. "To prevent contamination of talc with asbestos, it is essential to select talc mining sites carefully and take steps to purify the ore sufficiently," the FDA says on its web-

Some studies have suggested there's a link between using talc and getting cancer women who use baby powder report higher instances of ovarian cancer than others. But even the researchers behind those studies are skeptical about their results, since most of that research was conducted by surveying women about their powder use years later.

"Our drivers are agents, they can sell insurance to you, they can sell (mobile) airtime, they can pay light and/or water bills, they can do all those little things around that increases that income," he said.

Little, which has a marketing partnership with Kenya's biggest mobile operator Safaricom, is also available to Kenyan customers who do not have a smartphone. The company worked with mobile operators to introduce a code to identify a passenger's location. "About 20 per cent of our rides actually come from nonsmartphones," Mr Budhabhatti said.

with washing of the raw material, before passing it under ultra-violet (UV) light. Rubies naturally fluoresce under UV light, meaning optical sorters can detect the direct individual rubies to separate channels for further sorting and grading.

The use of programmable logic controllers and data software under the UV light to conduct this process is faster, more reliable and more efficient than the human eye. It also allows the identification of a finer material component than before.

A greater number of washing plants the equivalent of washing 10,000 tonnes of ore per day - combined with UV optical sorting account for how throughput will increase exponentially, translating into significantly higher production figures.

Model 3 cars launched in China ahead of schedule

BEIJING

TESLA has started delivering Model 3 cars in China slightly ahead of schedule, as it looks to revive its sales that have been hit hard by Sino-US trade tensions.

The California-based firm has already adjusted prices and added a cheaper Model 3 variant to its line-up to make its US-made cars more affordable in China amid high import tariffs.

The US luxury electric vehicle said in a statement that it held a delivery event in Beijing on Friday which "marked a significant milestone for the market.'

It had initially projected a March start for Model 3 deliveries in China - the world's biggest auto market where overall car sales contracted in 2018 for the first time in more than two decades.

The initial deliveries will go to customers who placed their orders before the end of 2018, Tesla

Buyers that ordered this year will start receiving their cars from end-March. "I see its earlier-thanexpected delivery as an effort to try and seize the market as quickly as possible" amid mounting competition, said Alan Kang, an analyst at LMC

Automotive.

"Many of its potential customers will not only be considering Tesla's Model 3 but also other electric car models like Jaguar's I-PACE or that from Audi and Mercedes-Benz," the Shanghai-based analyst added.

While auto sales in China have waned as the economy slowed, Tesla's business was hit hard after Beijing raised tariffs on US auto imports to 40 per cent in July amid the trade tensions.

China has since temporarily suspended the additional 25 per cent tariff, reducing it to the 15 per cent level.

Tesla currently imports all the cars it sells in China but is in the process of building a factory in Shanghai that will manufacture Model 3 cars in the initial phase and help it minimise the impact of the trade war.

The United States and China are in the midst of talks aimed at resolving their trade dispute. If the two sides fail to reach an agreement by March 1, US tariffs on \$200 billion worth of Chinese imports are set to spike to 25 per cent from 10 per

Tit-for-tat tariffs between the world's two top economies have upended international trade



Tesla's earlier-than-scheduled delivery, however, comes as the automaker was dealt a setback on Thursday after Consumer Reports, an

influential US magazine, withdrew its endorsement for Model 3, citing reliability problems.

The magazine's decision to withdraw its endorsement, less than nine months after recommending the electric sedan, raised questions about quality that Tesla has faced since the Model 3's difficult launch.

Societe Generale mulls job cuts at its investment bank, sources say

PARIS

SOCIETE Generale is drawing up plans to cut jobs at its investment bank and find a partner for its cashequity business in a bid to offset increasing cost pressure from regulation, people familiar with the matter said.

The bank could cut hundreds or even thousands of jobs at its global banking and investor solutions unit, including roles in support functions such as finance and human resources, one person familiar with the situation said.

SocGen is still weighing up which parts of the business would bear the reductions, the person added. Societe Generale declined to com-

The GBIS unit has more than 20,000 employees. One of SocGen's main French labor unions said February 8 that the bank is bracing for "important" cuts to trading jobs. Chief executive Frederic Oudea has said it's too soon to comment on any headcount decisions.

SocGen rose as much as 2.7 per cent in Paris trading and was up 2.6 per cent at 25.63 euros as of 10:01am. Still, the stock has fallen about 8 per cent this year, missing the rebound of Europe's Stoxx 600 banking index.

The Paris-based group is seeking to cut 500 million euros (Dh2.08 billion) of costs and review less profitable investment-banking activities after a gruelling fourth quarter. The organisation said earlier this month that the reductions would focus on some fixed-income and currencies activities.

Mr Oudea reorganised his

top management and hired senior traders from Bank of America Corporation last year to help reboot the global-markets business after the shock departure of investment-banking boss Didier Valet. Deputy chief executive Severin Cabannes is now in charge of the GBIS unit and is readjusting a business plan that was crafted under Valet in 2017 when economic and market conditions were bet-

SocGen's board last year took the step of proposing a new four-year term for the chief executive, and shareholders will vote on it at their annual meeting in May. The bank has so far resisted the trend in France to hive off cash equity and research. However, it is now considering options to set up a joint venture, the person said.

Finding a partner for the stock brokerage business may take weeks or months, and keeping it within the group would be the default solution, the person said.

Several new ventures in equity brokerage could serve as a blueprint. Kepler Cheuvreux has partnerships with European banks including Credit Agricole to secure distribution of its research. Franco-German banking group Oddo BHF struck a deal with Natixis SA in 2017, which left French equity brokerage and research activities with the former, while the latter took on capital markets.

The reshuffles came as the European Union's MiFID II directive forces brokerages to charge clients separately for research and trading, leaving smaller players under pressure to consolidate.





Gold prices rise on subdued dollar; Fed stance limits gains

LONDON, Feb 22 (Reuters) - Gold inched up on Friday as optimism over U.S.-China trade talks pressured the dollar, but signs that the U.S. Federal Reserve could raise interest rates again this year kept prices below a 10-month high hit earlier this

Spot gold rose 0.3 percent to \$1,326.56 per ounce as of 0814 GMT. The metal was headed for a second straight weekly rise, up almost 0.4 percent this week.

U.S. gold futures were up 0.1 percent at \$1,329.1 per ounce.

"The dollar's trajectory and soundings from the Fed will obviously play on gold prices, but the metal's focus is now more on key levels than key events," said Ronan Manly, a precious metals analyst at BullionStar Singapore.

"The main target is still the technically important area between \$1,350 and \$1,360 above which would be a one year high.

The dollar index against a basket of six major currencies was set to decline about 0.3 percent this week, which could be its biggest weekly fall in a month. The U.S. unit has been under pressure on hopes of a U.S.-China trade deal.

U.S. and Chinese negotiators resumed high-level talks on Thursday to hash out a deal that could end their trade war, just over a week before a U.S.-imposed dead-

"On a day to day basis gold is a function

of changing currency markets and the U.S. dollar. Medium outlook is a lot more to do with geopolitical issues and yields" said

"But the fact that it was overbought-driven very much by a new yield environment, tensions around the world especially around geopolitics, is keeping gold prices elevated."

Gold had hit a 10-month high of \$1,346.73 on Wednesday, but minutes from the Fed's January policy meeting indicated there might in fact be a rate hike this year, eras-

ing gains in gold. "Dovish signals from U.S. Federal Open Market Committee officials for the shorter term have kept global equities steady whilst applying bearish pressures on the non-interest bearing asset," Phillip Futures

said in a note. Indicative of investor sentiment toward bullion, holdings of SPDR Gold Trust, the world's largest gold-backed exchangetraded fund, dropped 0.63 percent to 789.51 tonnes on Thursday.

Elsewhere, palladium gained nearly 1 percent to \$1,480.96 per ounce, having surpassed the key \$1,500 level for the first time on Feb. 20.

The autocatalyst metal was on track for a third straight week of gains, up nearly 3 percent.





Oil prices firm on trade hopes, but record U.S. output drags

LONDON, Feb 22 (Reuters) - Oil prices were firm on Friday, supported by OPEC's ongoing supply cuts and hopes that Washington and Beijing may soon end their trade dispute.

Prices however remained just below 2019 peaks reached earlier this week as U.S. crude oil production hit a record 12 million barrels per day (bpd) and its exports also surged.

International Brent crude futures were at \$67.18 per barrel at 1019 GMT, 8 cents above their last close, but below \$67.38 per barrel reached earlier this week. U.S. West Texas Intermediate (WTI) crude oil futures

were at \$57.03 per barrel, up 7 cents, but below this week's \$57.55 per barrel 2019 high. Traders said prices were lifted by hopes that Washington and Beijing could resolve their trade disputes, which have dented global economic growth, before

a March 1 deadline, during negotiations this week. "We'll just have to watch trade talks in D.C. today.

Yesterday, the market was rather dead, volume was low and U.S. data on crude and products was mixed, so the market didn't really react," Olivier Jakob of Petromatrix consultancy said.

"Anything positive today on trade talks will boost the

Prices have also been supported by supply cuts led by the Organization of the Petroleum Exporting Countries (OPEC).

OPEC and some non-affiliated producers such as Russia agreed late last year to cut output by 1.2 million bpd to prevent a large supply overhang from

Goldman Sachs said in a note that it expects OPEC output to average 31.1 million bpd in 2019, down from 31.9 million bpd.

At least in part offsetting that is surging U.S. crude oil production which reached 12 million bpd for the first time last week, the Energy Information Administration (EIA) said on Thursday.

That means U.S. crude output has soared by almost 2.5 million bpd since the start of 2018, and by a whopping 5 million bpd since 2013. America is the only country to ever reach 12 million bpd of produc-

As output surges, U.S. oil stocks are also rising.

U.S. commercial crude oil inventories rose by 3.7 million barrels to 454.5 million barrels in the week ended Feb. 15, the EIA said.

Analysts say U.S. output will rise further and that oil firms will export more oil to sell off surplus stocks.

"We see total U.S. crude production hitting 13 million bpd by year-end, with 2019 averaging 12.5 million bpd," U.S. bank Citi said following the release of the EIA report.

Experts call for efforts to eradicate Africa's healthcare perils, commend China's support

ADDIS ABABA

AFRICAN healthcare experts and policymakers, who gathered in Ethiopia's capital Addis Ababa as part of a high-level continental meeting, called for collective efforts to effectively eradicate major healthcare perils in Africa.

The experts and policymakers made the joint call during a two-day high-level meeting that brought together the African Union (AU), the Africa Center for Disease Control and Prevention (Africa CDC), and the World Health Organization (WHO).

The event was aimed to share information on the Ebola virus disease preparedness, vaccines and therapeutics, as well as the spread of major publichealth perils.

Deputy Chairperson of the AU, Thomas Kwesi Quartey, told African healthcare experts and policymakers that the disproportionate burden of disease faced by Africa, coupled with inadequate health systems and the shortage of health personnel across the continent, "remained a major challenge."

"Overcoming these challenges requires collective efforts both for Africa as a continent and our partners to build the Africa we want as articulated in the Agenda 2063," the AU deputy chairperson said.

According to Quartey, Africa must adopt an integrated and comprehensive approach to the health problems it is facing, with particular emphasis on the diseases crossborder nature.

Quartey further assured "the strong commitment of the African Union Commission to creating the synergy needed to maximize the impact of our interventions for disease control and prevention in Africa."

Deputy Executive Director of the UN Economic Commission for Africa's (ECA), Giovani Biha, also stressed that a committed political leadership, institutional strengthening, investments in health systems, community health and awareness are all crucial to the eradication of the disease from the continent.

The ECA deputy chief said "Africa cannot build strong

and resilient health systems without adequately investing in hard and soft health infrastructure, including the provision of right numbers of health personnel both in urban and rural areas."

Biha, who noted that Africa needs to mobilize adequate resources for strong and resilient health systems, also indicated that strategic partnerships, including the role of the private sector, are also critical for a coordinated multi-sectoral response to health challenges in

She also reiterated the ECA's commitment to healthcare in Africa within the broad framework of economic and social development.

"As a premier knowledge institution, we are building on our unique position and privilege to bring global solutions to Africa's challenges, including Ebola and taking local solutions to the continent," the deputy executive director said.

The call made by the AU and ECA deputy heads is

also shared by the Chairperson of the Governing Board of Africa CDC, Amir Aman, who urged AU member states as well as its partners to share important and latest information on Ebola and other major healthcare

Aman, who is also Ethiopia's Minister of Health, said that if Africa is to save lives by preventing disease outbreaks "we have to share crucial information because without a healthy population we cannot move the continent forward."

The meeting, which concluded on Saturday, created common understanding about the current state of the Ebola virus disease vaccines and drugs, including evidence and practical considerations for application, it

Africa's fight against the life-threatening impacts of the Ebola virus, which was widely considered as Africa's major cross-border public-health threat in recent years in particular, was "significantly" backed by the support from China, Director of the Africa CDC, John Nkengasong, told Xinhua on the sidelines of the high-level

The latest 10th Ebola Virus Outbreak in the Democratic Republic of Congo (DRC) is said to be the second largest outbreak of the deadly virus, after the outbreak that hit West Africa in 2015.

Speaking of China's contribution to Africa's efforts in taming such problems, Nkengasong said that China has deployed experts in neighboring countries of the DRC, which the director said is "important support to detect and stop the spread of the Ebola virus."

"The Chinese government has deployed experts in neighboring countries in Uganda and other countries," he said. "It is very important that we are focusing not only in DRC but we are also focusing in the neighboring countries, just in case the virus escapes.'

He also noted that China has been supporting the Africa CDC which has been taking various activities as part of the response efforts to the latest Ebola outbreak in the DRC.

With regard to China's support to the development of Africa CDC, the director said that two Chinese experts are working together with African experts at the headquarters of Africa CDC to develop the center. Xinhua

Russia's top diplomat rules out peace treaty negotiations with Tokyo on Japan's terms

MOSCOW

MOSCOW has not been negotiating a peace treaty with Japan on Tokyo's terms, Russian Foreign Minister Sergei Lavrov said yesterday in an interview to Vietnam's national broadcaster Vietnam Television (VTV), China's CCTV and Phoenix TV.

According to Russia's top diplomat, solving such complicated tasks requires not only creating a proper atmosphere, but also filling economic, political and diplomatic relations with practical contents.

"If we take a look at the real situation, [Japaissue on Japan's terms. Frankly, I have no idea of where this opinion of his comes from," he said.

"Neither Russian President Vladimir Putin, nor me, nor anyone else taking part in Russian-Japanese consultations has ever given our Japanese colleagues grounds for such statements," Lavrov (pictured) continued.

"The fact that on the sidelines of the G20 summit in Singapore Putin and Abe spoke of the need to speed up the work on a peace treaty on the basis of the 1956 declaration, testifies to the opposite: we are negotiating not on Japan's terms, but on terms of this document."

Lavrov said that in order for the peace treaty to be signed, Japan must recognize the results of World War II in their entirety, including Russia's sovereignty over all islands of the Kuril Archipelago including the four islands of the Lesser Kuril Chain.

"It is weird enough that our Japanese colleagues are not willing to accept the results of World War II the way they are sealed by the UN Charter. It says that everything done by the victorious powers is out of discussion," he said.

"Even if the Japanese have their own interpretation of the San Francisco Peace Treaty and other documents related to this region, they had nevertheless ratified the UN charter, and it would be incorrect to withdraw their ratification now.'

Commenting on Japan's previously announced plan on signing a framework agree-



ment on a peace treaty during Russian President Vladimir Putin's upcoming visit to the country, Lavrov said he would "prefer it to remain on their conscience.'

"There were no agreements, and there can be none, because we have never supported nese Prime Minister] Shinzo Abe, tells the paramy kind of artificial timeframes created for liament that he plans to solve the peace treaty any problem," Russia's top diplomat continued. "Moreover, none of us has ever seen any kind of framework agreement. I have no idea of what our Japanese colleagues mean."

> Lavrov also said that despite Moscow and Tokyo's declared agreement to bring relations to a new level, Japan had joined "a wide range of sanctions against Russia, which can hardly be viewed as a friendly stance."

> Besides, Tokyo sides with US on all UN resolutions directed against Moscow and either opposes or abstains as far as projects proposed by Russia are concerned, Lavrov said.

> "Generally speaking, Tokyo has been coordinating its UN stance with Washington," he said. "We don't mind Japan cooperating with other states, but the United States has designated Russia - naturally, together with China - as its main adversaries.".

Three ministers throw weight behind Brexit delay to stop no-deal

LONDON

THREE British cabinet ministers publicly indicated on Saturday they will back plans to delay Brexit if lawmakers vote down Prime Minister Theresa May's plan for a new deal with the European Union.

Business minister Greg Clark, work and pensions minister Amber Rudd, and justice minister David Gauke signaled in a Daily Mail column that they will side with rebels and opposition parties next week to stop Britain leaving the European Union without a divorce deal on March 29 if necessary, adding their weight to calls for May to rule out a no-deal departure.

May is struggling against the clock to get a deal with Brussels on Britain's exit from the world's largest trading bloc that will pass parliamentary muster. She will meet European Council President Donald Tusk on the sidelines of an EU-League of Arab States summit on Sunday, but EU diplomats are not expecting any imminent breakthrough.

In the newspaper column headlined "If we don't get a deal next week we must delay Brexit", Clark, Rudd and Gauke wrote that a no-deal exit was a risk to business, security and British territorial unity, and accused some colleagues in parliament of complacency.

"Far from Brexit resulting in a newly independent United Kingdom stepping boldly into the wider world, crashing out on

the threat of a new bid for Scottish independence from the United Kingdom.

"Our economy will be damaged severely both in the short and the long term. Costs will increase, businesses that rely on just-in-time supply chains will be severely disrupted and investment will be discouraged," they

But in a further sign of deep division over the issue, May's junior minister for Northern Ireland, John Penrose, wrote a column in the Sunday Telegraph saying removing the option of a no-deal departure on March 29 "could torpedo Brexit completely". Penrose said such a move could lead to further temporary extensions that "would become permanent."

Both May's Conservatives and the main opposition Labour Party are formally committed to delivering Brexit. Labour has recently appeared to soften its

stance on a second referendum, although May has ruled such an option out.

Lawmakers from both parties, however, are deeply split over how or even whether Britain will leave, and no majority has so far emerged in parliament for any comprehensive Brexit strategy.

May has promised that if she does not bring a revised deal back by Feb 27, parliament will have an opportunity to vote on the next steps. Some lawmakers are expected to use that to try to wrest control of the process from the government.

Terrorism, illegal migration to top EU-AL summit - experts

EGYPTIAN political experts believe that the issues of terrorism and illegal migration are among the most important issues on the European Union (EU)-Arab League (AL) summit which will kick off Sunday evening in Egypt's Sharm el-Sheikh city.

The summit, scheduled on Feb. 24-25, will bring together for the first time heads of states and governments from both

The EU President Donald Tusk will co-chair the meeting with Egyptian President Abdel

Jihan Jado, an expert of European Affairs and member of the local council of Versailles, France, said the problem of refugees and illegal migration is one of the most important topics to be discussed at this summit.

"This issue worries the Europeans and costs the Europeans many economic, political and security burdens," she told Xin-

During the summit, the leaders will also discuss the issue of securing the European continent from the threat of terrorism and controlling terrorists whose threats extend from the

Arab region to the European countries.

"The two sides will also discuss the measures that can be taken against some crises, especially in Libya, which is receiving great attention from both sides," she said.

"Egypt, France and Italy also pay great attention to the reconstruction of Arab countries affected by the Arab Spring such as Libya and Syria," she added.

The professor added that one of the topics of the summit is the theme of "investing for stability," where Europe seeks to support stability in the Arab region, especially the countries in crisis.

"Europe aims to inject large investments in these countries. The European continent would prefer to see the Arab region in security and stability, so trade exchange and investments that benefit both sides can keep going and growing," she noted.

"I expect that this summit will produce very important results to determine the priorities of cooperation between the two sides and coordinate positions on many issues, especially in international arenas," the expert

She added that the summit will also help both sides take the necessary measures to control

the hot spots in the Arab countries, namely in Libya, Syria and Yemen. "I also believe that a unified vision will be announced by both sides towards Iran, as many Arab and European countries view Iran as an imminent threat to both the European continent and the Arab region," Jado told

Meanwhile, Hani al-Gamal, director of al-Kenana Center for Political and Strategic Studies, said there are several important issues on the agenda of the first EU-AL summit.

One of these topics is developing the bilateral relations between the two sides, especially in the economic aspect in an attempt to reduce dependence on the United States, al-Gamal said.

"The issue of illegal immigration from the south of the Mediterranean, which worries the European side, especially amid the deteriorating security conditions in Libya and Syria, will also

be discussed," he pointed out. "Fighting terrorism is an issue of common interest for both sides, especially after the series of bombings that rocked different European cities over the past few years and months," the expert told Xinhua.

Al-Gamal said that the Arab countries also need the Europe

support to solve the Palestinian, Syrian and Libyan issues through Europe's backing of Arab solutions on the international level.

"I believe that positive results that will emerge from the summit...we will see more security and intelligence understandings, as well as a common vision between the two sides, especially with regard to American, Iranian and Turkish interventions in Arab affairs," the expert said.

R. Kelly bond on sexual assault charges set at \$1 million, due back in court today

CHICAGO

GRAMMY-WINNING R. Kelly, who has faced years of sexual abuse allegations, was ordered held on a \$1 million bond on Saturday on charges that he sexually assaulted three teenagers and a woman, as prosecutors offered new details in the case.

Cook County court, prosecutor Jennifer Gonzalez said Kelly met one of the teenaged victims during his trial on child pornography charges in 2008 when she sought his autograph after a day in court and repeatedly had sex with her between 2009 and 2010. Kelly was acquitted of the child porn charges.

He met another victim at her 16th birthday party, Gonzalez said, and had sex with her in the first of many encounters in 1998 after telling her to take a taxi from school to his recording studio. A third charge is based on a videotape that purportedly shows Kelly and a 14-year-old girl engaged in sexual acts sometime between 1998 and 2001.

The fourth victim was Kelly's hairdresser, then 24, who said Kelly tried to force her to have oral sex in 2003 before ejaculating on her shirt, according to prosecutors. DNA testing linked the sample to Kelly, prosecutors said.

Cook County Judge John Lyke, who called the allegations "disturbing," set bail at \$1 million for Kelly. The singer appeared in a black hooded sweatshirt and looked down as prosecutors outlined the case against him. He was not asked to enter a plea at what was purely a bond hearing, although his lawyer Steven Greenberg has described Kelly as "an innocent man."

The 52-year-old R&B singer, whose real name is Robert Kelly, was charged with a 10-count indictment on Friday, nearly two months after the Lifetime television network aired a six-hour documentary series "Surviving R. Kelly" in which multiple women accused him of sexual misconduct and abuse.

The judge also ordered Kelly not to have contact with anyone under



the age of 18 and to surrender his old protege, the singer Aaliyah, a passport. Each count carries a maximum of 10 years in prison.

on Monday when a trial judge is expected to be assigned, a spokesman for the Cook County Sheriff's Office said. Greenberg told reporters that he expected his client to secure his release sometime over the weekend and described Kelly as "devastated," even as he also denied the charges.

"We haven't seen any evidence, any reason to believe these allegations credible," are Greenberg said. "He's a rock star. He doesn't need to have nonconsensual sex."

The video in question was apparently obtained by lawyer Michael Avenatti, known for representing porn star Stormy Daniels in her legal battle against President Donald Trump. Avenatti said he represents two victims and turned the tape over to authorities. Kelly, best known for his hit single "I Believe I Can Fly," has for years denied accusations of abuse. In 1994, he married his 15-year-

Star of Mexican film 'Roma' prompts raw discussion of race, class

MEXICO CITY

THE Oscar-nominated film "Roma," which chronicles the life of a young housekeeper in 1970s Mexico, has put an uneasy focus on the nation's sharp class, ethnic and racial divisions, leading to mixed reactions to the indigenous woman cast in the starring role.

Yalitza Aparicio, who is nominated in the Best Actress category in Sunday's Academy Awards, has appeared on the cover of "Vogue," attracted over a million Instagram followers and been celebrated with a towering mural in her likeness over a humble district in Mexico

With her bronze skin and short stature, the 25-vear-old woman from a poor indigenous family in southern Mexico has for many become a symbol of pride. She cuts a stark contrast to the pale women and men with European features who dominate Mexican television and film, despite representing only a sliver of Mexico's overwhelmingly mestizo and indigenous population.

But reactions to Aparicio's leap to fame after her powerful portrayal of a young domestic worker for a middle-class family in "Roma," which is directed by Alfonso Cuaron and nominated for 10 Oscars, have also exposed how deeply prejudice is ingrained.

A telenovela actor disparaged her with crude, racially-charged language, one of many offensive remarks following her Oscar nomination that were especially prevalent on social media. When leading society magazine Hola! featured Aparicio on a recent cover, the actress' skin appeared to have been digitally lightened.

Although Hollywood has been forced to confront its lack of diversity amid #OscarsSoWhite criticism in recent years, Mexico's film industry has rarely turned the mirror on itself.

"We're uncorking this racism that we've been carrying around for centuries," said Itza Varela Huerta, a post-doctoral researcher studying indigenous and Afro-Mexican groups at the Center for Research and Advanced Studies in Social Anthropology in southern Oaxaca state, where Aparicio grew up.

"When we're with an indigenous person, it's always: she doesn't know anything, she can't do anything, she's not pretty, she doesn't know how to act."

The stereotype-busting actress was studying for her teaching degree in the small town of Tlaxiaco when Cuaron discovered her at a local casting call.

R. Kelly indictment is latest case fueled by TV documentaries

LOS ANGELES

FOR years, singer R. Kelly has denied sexual abuse allegations against him and Friday's felony indictment of the performer was delivered weeks after first-person accounts of several accusers aired on television, leading prosecutors to urge potential witnesses to come forward.

The Lifetime network's "Surviving R. Kelly," which aired in early January, marked the latest in a series of TV documentaries that helped spur criminal investigations of prominent figures, from the late pop star Michael Jackson to multimillionaire real estate scion Robert Durst.

As with Jackson, who was charged and ultimately acquitted of child molestation in 2005, and Durst, now awaiting trial on a murder charge, allegations against Kelly were brought into sharper focus when presented as the subject of a made-for-TV narrative.

"Art turns data into experience," Robert Thompson, a Syracuse University professor of popular culture, said of Lifetime's treatment of the sexual misconduct accounts that had surrounded Kelly.

"When you see those stories

embodied in actual human beings, with pretty unrelenting closeups (of interview subjects), that has a rhetorical power that exceeds 'just the facts," he said.

The six-hour Lifetime program, aired over three nights, featured interviews with more than 50 people, including seven women identified on camera as victims of sexual and emotional abuse by Kelly, some when they were underage.

Among those interviewed were his ex-wife, Drea Kelly, the R&B singer's former managers, record producers and others once close to him. The program has had more than 20 million U.S. viewers, Lifetime said.

The documentary also added fuel to the social media movement #MuteRKelly, launched in late 2017 to pressure record companies, concert promoters and others to cut ties with the artist.

At a news conference after the program debuted, Cook County State Attorney Kim Foxx called for anyone alleging abuse by the Grammy-winning star to come forward to authorities.

On Friday, he was charged with 10 counts of sexual abuse involving four alleged victims, three of them under

Kelly's lawyer Steven Greenberg told reporters: "I suspect this is succumbing to public pressure. I think they shouldn't have rushed to judgment. He's an innocent man."

MICHAEL JACKSON

DOCUMENTARY The televised prelude to Kelly's indictment recalled how child molestation charges brought against Michael Jackson in 2004 grew out of accusations made by a boy seen nuzzling and holding hands with Jackson in a documentary about the pop star that aired on ABC and British television in February 2003.

But Jackson himself raised a furor in the documentary, produced by journalist Martin Bashir, when he acknowledged sharing a bed with his young accuser and "many children" while defending the practice as an innocent act of love rather than

pedophilia. Jackson's admission of sleeping with young boys, in both Bashir's documentary, "Living with Michael Jackson," and in a CBS News interview that aired after he was charged, were used by prosecutors as evidence

against him in his trial. The sensational

case ended with a California jury finding the singer not guilty on all counts.

Similarly, Durst's own words came back to haunt him in the 2015 HBO documentary "The Jinx," which examined connections between the enigmatic heir and several slayings, including the unsolved disappearance and presumed murder of his wife in 1982. He was acquitted in 2003 in the killing and dismemberment of a Texas neighbor two years earlier.

But his arrest on a charge of murdering his longtime confidante, Los Angeles writer Susan Berman, coincided with broadcast of "The Jinx" finale, in which his voice was captured on microphone, muttering off-camera: "What the hell did I do? Killed them all, of course."

Prosecutors have since cited Durst's recorded statement in court filings in their case against him.

Despite the role true-crime sometimes documentaries have played in "lubricating the wheels of justice," in the end they belong to the realm of entertainment, Thompson said. "We have to let justice be served by the rule of law."

Three-goal Messi says Barca back to their best

SEVILLE

LIONEL Messi said Barcelona were back to their best following a mid-season slump after he scored a remarkable 50th career hat-trick in a rousing 4-2 win at Sevilla in La Liga on Saturday.

Barca had only won one of five games in February as they kicked off at the Sanchez Pizjuan stadium but after another landmark day, Messi pledged his side would now go all out for a 'treble' of La Liga, Copa del Rey and Champions League trophies.

Having been held to a goalless draw at Olympique Lyonnais in their Champions League last-16 first leg on Tuesday, Barca looked set for another disappointing result when Jesus Navas gave Sevilla the lead.

Yet Messi responded with a stunning volley and although Gabriel Mercado put Sevilla in front again before halftime, Barca's captain again hauled his team back into the game quite brilliantly.

His thumping strike from just inside the area saw Barca equalise midway through the second half before he put them ahead with an ice-cool dinked finish in the 85th minute and then laid on the pass for Luis Suarez to seal all three points.

"Today, we were ourselves again and we produced a great performance," Messi told reporters.

"We went through a spell where, to be honest, we did not play our

harder for us to score.

"You have different moments over a season, and we can't always play at the highest level. But when we manage to get the play to flow, things always happen for us."

Barca's inconsistent results have not harmed their bid to successfully defend the La Liga title and the thrilling win extended their lead at the top of the table to 10 points over nearest challengers Atletico Madrid.

"There is still a long way to go in the season but it was very important to win here and keep the distance with our rivals," added Messi, who leads the scoring charts in Spain and in Europe's top five leagues with 25 goals.

"It's always tough to win here, we know what it is like to come to this stadium and how good Sevilla's players are, they made things very hard for us by taking the lead but we knew how to overcome all that."

Barca now face back-to-back trips to arch rivals Real Madrid, with a Copa del Rey semi-final second leg on Wednesday followed by a league visit back at the Santiago Bernabeu next Saturday.

"Now we have some very difficult games coming up and everything will get harder as the season draws to a close," Messi said.

'Decisive' Messi downs Sevilla with 50th career hat-trick

SEVILLE, Spain

LIONEL Messi scored his 50th career hat-trick to fire Barcelona to a 4-2 win at Sevilla on Saturday after the champions had twice fallen behind, giving the Catalans a 10-point lead at the top of La Liga.

Sevilla, who have only won once in the league in 2019, took the lead midway through the first half through veteran winger Jesus Navas but were soon pegged back by an unstoppable volley from Messi.

The home side capitalised on sleepy defending from Barca to re-take the lead before halftime as Gabriel Mercado pounced in the area.

Barca coach Ernesto Valverde made two attacking changes at the start of the second period by introducing Ousmane Dembele and Sergi Roberto and got the intended reaction when the France winger laid the ball off to Messi just inside the area and the Argentine lashed it into the

Messi, who has struggled for form in recent weeks due to a niggling injury, looked on a mission to grab the winner and after twice coming close he completed his treble to put Barca ahead in the 85th minute, reacting quickly to a poor Sevilla clearance to dink the ball over goalkeeper Tomas Vaclik. Luis Suarez made sure of the points by scoring deep in stoppage time, chipping Vaclik after being played through by a pass from Messi.

Barca lead the standings on 57 points after 25 games while second-placed Atletico Madrid have 47 but can reduce the gap back to seven when they host Villarreal on Sunday. Sevilla fell to fifth, slipping out of the Champions League places behind Getafe.

MESSI DELIVERS

"Messi is decisive and superlative, every team has decisive players but we have the

best in the world," said Barca coach Ernesto Valverde.

"It's not just his goals either, but because he always delivers in the right place at the right time." Sevilla had endured a humiliating 3-0 loss at struggling Villarreal last week but before the game Valverde warned of the Andalusians outstanding record at their Sanchez Pizjuan, where they had thrashed Real Madrid 3-0 and beaten Barca 2-0 in the Copa del Rey this

They took the lead through a lightning quick counter-attack as Wissam Ben Yedder marauded down the pitch and played

in Navas, who took one touch to control and the other to slide the ball through the legs of the diving Gerard Pique and beyond the outstretched Marc-Andre ter Stegen into the bottom corner.

Sevilla's intensity prevented Barca from replicating their usual slick passing game and it took a superb goal from Messi to pull them level, the Argentine swivelling to meet a cross from Ivan Rakitic on the volley, leaving Vaclik with no chance.

Sevilla are Messi's favourite victims, and last year he came off the bench to score twice in two minutes and rescue a 2-0 draw from 2-0 down.

He went one better this time and has now scored 36 times in 37 games against the Andalusians.

"It's always tough to win here, we know what it is like to come to this stadium and how good Sevilla's players are, they made things very hard for us by taking the lead but we knew how to overcome all that," Messi added.

It was his 44th hat-trick for Barca, with 32 coming in La Liga, eight in the Champions League, three in the Copa del Rey and one in the Spanish Super Cup. He has also struck six trebles for Argentina.

Mbappe: 'Scoring goals and breaking records is what drives me'

PARIS Saint-Germain superstar Kylian Mbappe now has 51 Ligue 1 goals after his brace in the 3-0 win over Nimes at Parc des Princes on Saturday and the France international admitted that he is motivated to set new records.

Christopher Nkunku put PSG ahead in the first half but Mbappe added a second-half brace to ensure the threepoint haul for Thomas Tuchel's men who took a provisional 17-point lead at the top of Le Championnat.

"I work every day to help my team as much as possible," said Mbappe after the final whistle. "I want to enjoy my football because it is great fun. Scoring goals and breaking records is what drives me." Mbappe, 20, also praised Tuchel for his role in the victory, citing the German manager's desire for relentless attack and effort as the reason for his and his teammates' impressive form and performances this season.

"The coach transmits [and] motivates us to never give up and to always keep going forward," Mbappe said. "We have players that run for the full 90 minutes -- we do it for him, as well as the supporters.

"We are working well. We have come a long way and we still have a long way to go -- we need to continue like this."

Tuchel himself was dissatisfied by his team's finishing against Nimes and wanted more goals, particularly from Mbappe, although he did recognise their improved second-half showing.

"We had a lot of chances to score throughout the game," said the coach. "We could have won by more -- Kylian could have scored five goals!

"Perhaps we lacked a little concentration, but I think we played really well and defended high up the pitch.

"The second half was exceptional. It was a great win -- the team got stronger and stronger as the game wore on."

Midfielder Marco Verratti, who assisted Nkunku's opener, expressed his delight that his teammate has already reached a half-century of Ligue 1 goals.

"The most important thing is that Kylian keeps getting opportunities," the Italy international said. "Right now, we are managing to find him.

"Kylian is even more decisive when played through the middle and we are happy with that -- I am really pleased that he has already reached 50 Ligue 1

Zahera committed to coaching Yanga

Azam then lost 1-0 to Prisons and the former then succumbed to 3-1 loss to Simba SC but the loss to Simba appears to have been the final straw on the two coaches.

Coach Plujim guided the team to 14 wins, eight draws and three losses. Many fans looked to have taken the news seriously after Zahera was reported on some media outlets claiming that he is to resign from his post at the end of this season.
