'Blood pressure drugs not tied to coronavirus risk'

BENGALURU, India

NEW research offers reassuring evidence to hundreds of millions of people with high blood pressure that popular anti-hypertension drugs do not put them at greater risk of being susceptible to Covid-19 infection as some experts fear.

Two blood pressure-lowering drug classes, called ACE inhibitors and ARBs, came under scrutiny after the US Centers for Disease Control and Prevention reported in April that 72 per cent of hospitalised Covid-19 patients 65 or older had hypertension.

ACE inhibitors and ARBs are thought to trigger activity along the same biological pathways used by the Covid-19 novel coronavirus to attack the lungs.

Researchers at Oxford University had recommended some patients stop the drugs until the risks were better known, while others argued patients should stay on the medications. An expert at the Johns Hopkins Centre for Drug Safety and Effectiveness in Baltimore described the debate as "one of the most important



clinical questions."

The new study made publicly available on Friday found no clinically significant increased risk of either a diagnosis or hospitalisation of Covid-19 with ACE or ARB use compared with other first-line drug treatments for hypertension.

The authors recommended that patients should not discontinue their treatment to avoid the virus, which has infected over 7.5 million people worldwide and killed more than 420,000.

"Our findings are quite reassuring," said Marc Suchard, a biostatistician at the University of California, Los Angeles, who co-led the study. "Taking an ACE or an ARB is just as safe as other first-list hypertension agents in terms of your risk of contracting Covid-19."

The study analysed electronic medical records of 1.1 million patients on antihypertension drugs from the United States and Spain and has not yet been peer reviewed.

It was part of the Observational Health Data Sciences and Informatics (OHDSI program, pronounced Odyssey) response to COVID-19, in collaboration with the US Department of Veterans Affairs, Columbia University Irving Medical Centre and SIDIAP, a Spanish health research

agriculture, livestock rearing and fishing, focusing on enhanced fishing activities in lakes and on the seashore. He promised to ensure timely availability and distribution of agricultural inputs and a coordinated market for agricultural produce.

"I want to assure Tanzanians of improved regional integration with the ratification of the EAC protocol on free movement of persons, goods and services. I will reinvigorate trade relations with the European Union and the East African Community (EAC) through Economic Partnership Agreement (EPA)," he noted.

Through reciprocity, the number of countries that Tanzanians will be allowed to visit without a visa will be increased, increasing the number of tourists coming into the country, he stated.

Nyalandu said his government would allow political parties to freely conduct their activities including gatherings throughout, aiming to provide them with ample time to prepare for subsequent elections.

Msigwa meanwhile, promised to revamp the country's education sector, saying that for a country to develop there must be competent graduates to cope with technological advancements around the world.

He said he would come up with an education system directly linked to national development priorities where students learn to sharpen their knowledge on specific economic sectors. "Students' performance will not be measured by the issuance of certificates, they will learn practically," he emphasized.

"More emphasis would be put on improvement of the country's education sector through innovation. It is only with a proper education system and innovations that we can economically transform Tanzania," the MP observed.

His other priority would be to enhance good governance and accountability, he stated, while promising to set aside enough funds for the agriculture sector since it employs the majority of Tanzanians.

He faulted the current government over failures to allocate enough funds for the sector as it is likely to create a greater number of jobs.

"Instead of prioritising funding for agriculture, the government has been purchasing airplanes," he asserted, promising to revive the stalled writing of a new Constitution for Tanzania.

For his part, Alliance for Change and Transparency (ACT-Wazalendo) national leader Zitto Kabwe has announced the five priorities his party intends to abide by in the government Budget if it wins this October's polls.

One such priority is to make changes to the system of tax deduction on corporate and employee incomes in order to spur consumption in the

Zitto revealed this in Dar es amount exceeding 15m/-, he added.

Salaam yesterday when analysing the government's 2020/2021 Budget estimates tabled last week by Finance minister Dr Philip Mpango.

"This includes officially recognizing the accumulation in salary increases to public employees since 2016 and to put in place a procedure of paying out that accumulation to all workers, including retirees - whose benefits will be improved in accordance to their salary scales," he stated.

He explained that in its budget, the party would analyse drawbacks, using internal and foreign experts, on how best to implement massive development projects in joint venture framework with the private sector.

"Projects like railways, electricity generation and aviation need to be implemented in joint venture with the private sector," he said, adding that an ACT-Wazalendo government would ensure that such ventures adhere to laid-down project timeframes.

This would enable the projects to start generating revenue for debt servicing, where the said analysis would seek to remove the government from at least 50 per cent of implementation costs. It would also direct resources towards improving the lives of the people, he declared.

Zitto further declared that ACT-Wazalendo would formulate tax policies to revive the tourism sector and the rest of the value chain that has been devastated by the Covid-19 pandemic.

This would also help to protect jobs in tourism sector enterprises by paying subsidies to firms that will extend their contracts with employees and to allow workers who were retrenched to be paid terminal benefits from social security funds.

"We would have in place budgetary and tax attractions for irrigation projects and factories that add value to crops," he remarked.

His party intends to put in place a friendly environment for Mchuchuma and Liganga iron ore projects to start at once.

With regard to new income tax rates, Zitto said his party would propose zero tax on gross incomes not exceeding

Tanzania working on feasibility of producing macadamia nuts in Kibaha

TANZANIA is looking into the potential to growing and exporting macadamia nuts overseas and already the Tanzania Agricultural Research Institute (TARI) centre of Tengeru, in Arusha is working on the preparation task.

According to the Manager in-charge of TARI Center of Tengeru, Dr Stephen Uoko, the Macadamia nuts are among the potential and drought and disease resistant crops that can compete with cashew nuts when it comes to profitable agricultural exports.

"And what we are actually doing here at the moment is researching on solution focused seed and seedling

both farmers and country as whole," stated Dr Uoko adding that the institute at Tengeru has a trial academia nuts farm recording bumper produce, therefore Arusha and other rain-fed regions can become good producers of

TARI Coordinator of Research, Alice Kavishe stated that Macadamia Nuts command high prices in international markets, especially in Europe and USA where one kilogram of processed nuts reportedly cost US \$54 equivalent to

productions that yield better profits to seedlings to suffice demands," stated Kavishe adding that other than Macadamia, they also grow other crops' seeds and seedlings as well.

Omary Mgumba, the deputy minister for Agriculture who visited TARI-Tengeru recently, said at the moment Tanzania was working to ensure that the country becomes self-sufficient in edible oil production, of which Macadamia can also supplement.

Tanzania is annually forced to be spending large amounts of foreign currency to import edible oils and sugar. In this respect the ingress of edible oils from overseas cost the country over US

"Tanzania has 17 agricultural research centres, two of which are located in Arusha; we expect these institutions to cooperate in coming up with ultimate solutions to all problems affecting farmers and the entire agricultural industry in the country," Mgumba.

"We need the seedlings and technology to produce Macadamia nuts introduced to local growers so that the production can take roots countrywide," stated the

Macadamia nuts take up to three years from initial planting to final harvest ready for export and it was advised that even the local youth who currently seem to prefer horticulture may find the nuts profitable as well.

Locally one litre of edible oil derived from Macadamia nuts demands over 12,000/- in cash.

So valuable are the nuts such that in 2012 Kenya authorities complained of illegal ferrying of Macadamia from the country, claiming that the nuts were being smuggled into Tanzania for packaging and rebranding for export.

PRESIDENT John Magufuli is this week expected to append his signature to a multibillion dollar of youth rehabilitation, education and health facilities in an integrated Commonwealth network.

To serve as project headquarters and centerpiece of the building of the facilities, the government is inching towards providing a three thousand acre land allocation for the project, supervised directly by a Commonwealth Foundation housed at the Buckingham Palace in the United Kingdom.

The project coordinator is veteran NGOs activist Akilimali Shukuru, the director of the Global Youth Networks project in the country, linked with the Sister Jacinta and Geir Gundersen Africa Foundation, a Swiss NGO with Vatican links, which has since teamed up with the Royal Commonwealth Foundation to push the project forward.

President Magufuli is expected to formally approve of the land allocation, earlier reported as located in Coast Region, where a vast network of facilities is then going to be constructed. A series of architectural designs and mapping out of costs has

President Magufuli has also accepted invitation to serve as Tanzania and Africa patron for the project, and implicitly for the work of the Sister Jacinta and Gier Gundersen Foundation, as it is due to the latter's initiative that the project came up, and is likely bring to Tanzania more than one trillion US dollars by the time it has attained its wider objectives within a decade from now, he stated.

A declaration of Her Majesty Queen Elisabeth II directed at the coordinator as secretary general of the foundation declared the Queen's unswerving support for the work of the foundation and the project as a whole, which helped to convince high government circles that the project was well anchored and has obtained the blessings of the highest levels of the UK state system, he added.

THE Prevention and Combating of Corruption Bureau (PPCB) in Morogoro region has recovered more than 15m/- belonging to Turiani sugar cane farmers in Mvomero district from a primary cooperative.

At an event held at the weekend PCCB deputy head for Morogoro region Victor Swela presented the money to the District Commissioner Mohamed Utaly for giving it back to the farmers.

It was reported that Turiani Farmers Cooperative Union (TUCOCPROS Ltd) owed its members over 210m/- that were embezzled by its officials way money that had been delayed to them

back in 2015. "In following up the in the past five years. issue we discovered that Mtibwa Sugar Factory provided 200m/- cash to the cooperative for payment to all farmers but its officials embezzled part of the money," Swela said.

He said after they were subjected to pressure some of the cooperative officials returned 15.8m/- that will be divided amongst 62 farmers and added that the Bureau was still pursuing the rest of the money.

He said the PCCB still call upon farmers to give cooperation while the verification exercise over their details is continuing to enable them get their

The Mvomero District Commissioner Mohamed Utaly hailed the PCCB for reccovering that amount of money and added that farmers who were yet to get their payments for crops sold will now get back their money.

He said the money was embezzled in 2015/16 season, and many farmers had lost hope but due to their government's efforts, they are pleased to get their money at last.

The farmer hailed the government for efforts to get their dues delayed for over five years and that they were now energized to continue with their farming activities.

Dr Sakafu was speaking yesterday at the hospital's Mloganzila branch to mark the World Blood Donor day where donors were recognized for their commitment towards donating

"With these figures, it is clear that demands are high and it is only through donations that we can be able to save the lives of expectant mothers, road accidents victims and cancer patients who required blood to a large extent," she said.

She added that the state of blood in the country is worrisome saying there is need for more sensitization campaigns on the matter.

Every year on 14 June, countries very high at the hospital saying there around the world celebrate World Blood Donor Day. The event, established in 2004, serves to raise awareness of the need for safe blood and blood products, and to thank blood donors for their voluntary, lifesaving gifts of blood.

SADC statistics protocol in the offing

HEADS of national statistics offices (NSOs) from Southern African Development Community (SADC) have unanimously approved draft Statistics Protocol which is a legal Framework governing statistics activities in the region.

Addressing the media at the end of the 27th SADC statistics committee at the Mwalimu Nyerere International Convention Centre on last Friday, Statistician General Dr. Albina Chuwa said the protocol aimed at enabling and enhancing statistical development and innovation in the region.

She said the protocol is very important instrument for statistical development as it recognises the central role statistics play in development and its importance in planning development agenda in SADC.

Dr. Chuwa who heads the committee explained that the regional statistics protocol will help to bring about political will among Member States on production, dissemination and promote use of statistics in planning, implementation and monitoring of development plans and programs in the region. "Without political will, nothing is possible! Since inauguration of the regional body production, dissemination and use of statistics depended on individual country will but the protocol calls for collective political will of all members states," she emphasised.

Dr. Chuwa elaborated that the protocol will help to ensure harmonisation of concepts, definitions and methodologies as well as harmonisation of compilation and dissemination of official statistics in Member States. "By doing so, it will ensure quality of statistics produced in Members States as they will use common quality assurance framework which include producers and user of official statistics through their respective national statistics systems" She noted.

She said the approved protocol will be submitted to higher

authorities in members states for further consideration. The sixteen-member committee chairperson informed the press that during the meeting members also shared their experiences on how CIVID-19 affected statistics activities in their respective countries and how they approached the current situation without compromising quality of statistics produced. "Today it is corona and tomorrow will be something else so we have agreed to look into other ways of doing our work and move away from traditional way of thinking to modern ways of doing our statistical activities,"

In the Southern Agricultural Growth Corridor of Tanzania (SAGCOT), the CARE-WWF Alliance aims to demonstrate a model of agricultural growth that improves the livelihoods of smallholders while maintaining vital ecosystem functions and conserving globally significant biodiversity through privatepublic partnerships. The SAGCOT Centre Limited (SCL) has the potential to bring together government, businesses, civil society, donor partners and the farming community to pool resources towards a common goal. Many partners have already converged under SAGCOT1. 1.2. About the Southern Agricultural Growth Corridor of Tanzania (SAGCOT)

SAGCOT is a Public Private Partnership that was initiated at the World Economic Forum (WEF) Africa Summit in 2010 with three overarching objectives: 1) Enhance Tanzania's food security and nutrition; and accelerate agricultural transformation and green growth, 2) Safeguard that #1 happens in a sustainable and responsible manner, 3) Improve livelihoods for smallholder farmers and their communities. The mandate of the partnership is to achieve this by catalysing responsible private sector led agriculture development. The SAGCOT partnership includes government, global and local agribusinesses, the Tanzanian private sector, Apex and farmer organisations, Development Partners, Foundations, Research Organisations, Academia and CSOs. Each SAGCOT partner commits to a number of principles of green and inclusive growth contributing to the objectives of SAGCOT. The government institutions have a key role to play in creating a favourable business enabling environment and incentivizing greener and more inclusive agribusiness development through both physical and policy infrastructure development, land use planning, investment promotion, agricultural research and extension services while civil society organisations and academia play a critical role in supporting the SAGCOT initiative in green growth (social and environmental) development. In the context of SAGCOT, inclusive and green growth refers to the development of agricultural value chains that offer strong linkage opportunities to a large number of smallholder farmers and local SMEs, and where the use of environmentally and socially sound and efficient technologies and business models is maximized.

1.3. The Cluster Approach

The SAGCOT initiative is implemented through a "Cluster" Approach to facilitate the development of profitable agribusiness partnerships in 'clusters' along the corridor to achieve economies of scale, synergies and increased efficiency. Clusters are geographic concentrations of interconnected farmers, companies, specialized suppliers, service providers, and associated institutions. Six Clusters were identified in 2010 as part of the design of the SAGCOT Initiative as defined in the SAGCOT Investment Blue Print. The six Clusters are Ihemi, Mbarali, Kilombero, Sumbawanga, Ludewa and Rufiji. SAGCOT Centre Ltd (SCL) started implementation of Cluster activities in late 2015 in the first priority Cluster— Ihemi—which covers the regions of Iringa and Njombe and later Mbarali Cluster which covers the region of Mbeya and Songwe.

The first approach of SCL towards promoting and strengthening inclusive green growth and agricultural transformation within clusters is to design the Cluster Development Framework (CDF) which analyses the current situation, prioritises strategic value chains of focus, and lays out an approach forward, defining initial key actions for SAGCOT and partners within the clusters while engaging key stakeholders. The Ihemi CDF was completed in October 2015 and under implementation since then. while the Mbarali CDF was completed in April 2019. Through the Ihemi and Mbarali Cluster Development Frameworks, SCL has facilitated successful public- private partnerships with specific focus on priority value chains to unlock key bottlenecks and improve the agribusiness policy environment. This was made possible through multi-stakeholder commitments (in a Compact) with a strategic focus to catalyze closer ties, open dialogue on constraints and opportunities for collaboration between Agribusinesses, Regional leadership, Development partners and Non State actors. These interventions have attracted new investments and projects in Ihemi and Mbarali. Equipped with experience from lessons learned in Ihemi and Mbarali clusters, SCL and its partners wish to replicate (and adapt where relevant) the approach used in Ihemi and Mbarali to initiate activities in the Kilombero Cluster (3rdpriority cluster and covers the whole Morogoro region). This cluster was launched by the Minister of Agriculture on 24th November 2019 in Morogoro town.

2. SCOPE OF WORK

The scope of work covers assessment of operationalization of the Ihemi and Mbarali Cluster Development Frameworks (CDF) to inform development of the Kilombero Cluster Development Framework through in-depth analysis of the two CDFs process and their implementation.

2.1. Objectives

The overall objective of this study is to provide well-documented, well-structured and practical lessons learned from the planning and implementation of the Cluster Development Frameworks (CDFs) of Ihemi and Mbarali clusters of SAGCOT, and to identify recommendations based on those lessons learned for the development and implementation of future CDF's, in particular the Kilombero CDF.

The specific objectives of the study are:

- to analyse the processes and products of the CDF's to date to improve design and utility of future CDFs, especially the upcoming Kilombero CDF

Speaking to reporters in Dar es Salaam at the weekend, Haki Fursa managing director Ntimi Charles said the budget has prioritized areas that touch ordinary citizens.

He said the areas include eradication, poverty reducing unemployment to the youth, enhance the against corruption and embezzlement of state funds, maintenance of peace, security and the defense of the people and their property.

He said the budget has put into place strategies in strengthening of the collection of revenue, financing of government activities including the huge strategic projects and improvement of basic social services to increase the pace of development.

Comparing it to those of the other East African countries, Charles said the 34.87trn/- budget reflects its uniqueness in the economic growth when considering the social services and is not dependent. "Social services including

education, health, safe and clean water as well as road infrastructures reached the people in acceptable levels," he said. "As an institution involved

with development issues we saw the availability of the people's basic needs went down from 28.2 percent in 2011.12 to 26.4 percent in 2017/18, while the poverty depth plummeted from 6.7 to 6.2 percent during the same period," he said.

He said the government has been able to put controls to unnecessary expenditure, avenues for corruption and

concentrated itself towards revenue collection.



TANZANIANS have been reminded to continue adhering to the prevention measures against HIV/Aids as statistics show that the disease was still infecting thousands of people every year.

This was said over the weekend by statistics officer from National Aids Control Programme (NACP), Jeremia Mushi, during virtual dialogue organised by Tanzania Youth Alliance (TAYOA) in collaboration with the Health, Community Development, Gender, Elderly and Children.

According to him, current data show that, in every one minute, four people contract HIV infections in the country something which poses an alert for young people and the general public to refrain themselves from dangerous behaviours.

The dialogue dubbed "Timiza Malengo 2020" was held through zoom platform and attracted more than 650 university students, 40 deans of students from more than 32 Higher Learning Institutions from Morogoro, Dar es Salaam, Dodoma and Iringa to discuss challenges and strategies

'Incidence of HIV among adults and youth still high in Tanzania' aimed at advocating for the uptake of do not care to using protection during

HIV related services.

Mushi said that statistics show that about 1.7 million people are currently living with HIV, and approximately 95 percent of them are using ARVs.

He said that every month 6,000 people are infected with HIV in the country which is equivalent to 72,000 people annually.

Eda Charles from NACP said many girls end up getting early pregnancies or even HIV and thus failing to accomplish their education dreams due various reasons including long distances from home to school.

Charles said NACP has been educating gender based education to enable girls in the country know how to avoid temptations which may lead them into contracting HIV/Aids and early pregnancies.

Speaking at the event, coordinator of UMATI, Fredi Turuka said many youth fear early pregnancies than HIV infections and that is why most of them

do not care to using protection during sex. "During sex what they consider mostly is to make sure they don't get pregnancy and most of the time they don't use condom because they believe that they don't enjoy and that is the reason behind the increase of new HIV infections among the youth," he said

He said for the country to have sustainable development, society must be responsible and intensify efforts to protect youth against temptations and harms so as to achieve their dreams.

"You can use contraceptives in an emergency case but it should not be the trend. If you plan to have sex with your partner please take safe measures to avoid HIV and early pregnancies because these contraceptives P2 is not advised for regular use," Turuka said.

For his part, Tayoa director, Peter Masika said his institution initiated the Timiza Malengo 2020 campaign to sensitize the youth and students to protect themselves and achieve their goals and dreams.

Looking for a way to give back? Give blood!

VERY year on 14 June, countries around the world celebrate World Blood Donor Day. The event, established in 2004, serves to raise awareness of the need for safe blood and blood products, and to thank blood donors for their voluntary, lifesaving gifts of blood.

The campaign theme for this year's World Blood Donor Day is "Safe blood saves lives" with the slogan "Give blood and make the world a healthier place". The idea is to focus on the contribution an individual giver can make to improve health for others in the community.

World Blood Donor Day is one of eight official global public health campaigns marked by the World Health Organisation along with World Health Day, World Tuberculosis Day, World Immunization Week, World Malaria Day, World No Tobacco Day, World Hepatitis Day, and World AIDS Day.

Transfusion of blood and blood products helps and save millions of lives every year. It can help patients suffering from life-threatening conditions live longer and with higher quality of life, and supports complex medical and surgical procedures. It also has an essential, life-saving role in maternal and perinatal care. Access to safe and sufficient blood and blood products can help reduce rates of death and disability due to severe bleeding during delivery and after childbirth.

In many countries, there is not an adequate supply of safe blood, and blood services face the challenge of making sufficient blood available, while also ensuring its quality and safety.

An adequate supply can only be assured through regular donations by voluntary unpaid blood donors. The WHO's goal is for all countries to obtain all their blood supplies from voluntary unpaid donors by 2020. In 2014, 60 countries have their national blood supplies based on 99-100 per cent

VERY year on 14 June, voluntary unpaid blood donations, countries around the world with 73 countries still largely dependent celebrate World Blood on family and paid donors.

World Blood Donor Day is celebrated every year by people around the world on June 14. It is celebrated on the birthday anniversary of Karl Landsteiner on June 14. 1868.

World Blood Donor Day brings a precious opportunity to all donors to celebrate and commemorate the birthday anniversary of Karl Landsteiner (a scientist who won the Nobel Prize for his discovery of the ABO blood group system).

Karl Landsteiner was an Austrian biologist, physician, and immunologist. He distinguished the main blood groups in 1900, having developed the modern system of classification of blood groups from his identification of the presence of agglutinins in the blood, and identified, with Alexander S. Wiener, the Rhesus factor, in 1937, thus enabling physicians to transfuse blood without endangering the patient's life. With Constantin Levaditi and Erwin Popper, he discovered the polio virus in 1909.

He received the Aronson Prize in 1926. In 1930, he received the Nobel Prize in Physiology or Medicine. He was posthumously awarded the Lasker Award in 1946, and has been described as the father of transfusion medicine.

ABO blood group system, the classification of human blood based on the inherited properties of red blood cells (erythrocytes) as determined by the presence or absence of the antigens A and B, which are carried on the surface of the red cells.

According to the World Health Organisation, 800 women die every day from pregnancy and childbirth-related complications. Severe bleeding is the cause of 34 per cent of maternal deaths in Africa, 31 per cent in Asia and 21 per cent in Latin America and the Caribbean.

EORGE Floyd's case is just one out of millions that take place literally every single day in our unjust world. The level of agony and pain of this assault are also not very different - the only difference in this case - thanks to the technology and social media - is that the story could not be hidden and left in the dark.

Police brutality and mistreatment across the justice system, discrimination across public services, unwelcoming gestures (micro aggressions) in the school hallways and so on, are just some of the daily phenomena that black people face all around the world. This case is representative of all of the black men and women who die at the hands of the police for doing mundane activities walking dogs, jogging, a broken tail light, and watching TV in one's own home. Racism (and more specifically anti-Blackness) is at the helm of societies all around the world.

Racism is also not limited to countries in the Western world of U.S., Europe, Australia or Canada. In these places systemic racism is practiced, protected, encouraged; it extends beyond to the multilateral and bilateral development and aid agencies, higher education institutions, and other international professional institutions where "merit" and "performance" are abstracted from systemic conditions of racism. Racism, as an instrument of white supremacy, has always eroded the intellectual integrities of institutions.

As men or women of color, especially black people, one has to prove his or herself exponentially more than a white counterpart who is privileged by his or her color in order to access and succeed the same opportunities. Alternatively, some choose to surrender to the white Godfather i.e. to be an "Uncle Tom" in exchange for protection and promotion as one who is complicit with the system. Should you opt for the former, you are always on your toes and rigorously striving to be ahead of the curve in order to simply survive. Even in that situation, if your success is found to set a different precedent, it becomes a threat to the system of white supremacy. (See Black Panthers, Black Wall Street, the assassination of Dr. Martin Luther King Jr. and various post-colonial African independence leaders).

Anti-Blackness often first becomes a reality for black children in schools. Black kids must perform exponentially harder to win not only the trust and confidence of racist teachers in the class, but also for their white classmates who are conditioned by their racist families. To this day capable, hardworking, and joyful black children have to consider dynamics of uncomfortable integration with white kids at school while also dealing with

the usual academic and social strains of early school years. Condescending conversations around affirmative action, racialized athletics teams, and Eurocentric beauty standards are just a few of the other difficult experiences that children of color navigate through. Black kids must face an unimaginable amount of barriers in comparison to their non-black classmates and counterparts.

Around the world, we are all sick and tired of racial violence. Racism of any form should not be tolerated anymore. To use the words of Angela Davis, it is no longer enough to not be racist; it is now the time to be actively anti-racist. Murder, physical assault, or any type of harassment we go through every day are clearly vindictive and hurtful. Moreover, systemic poverty, disenfranchisement, underfunded public services, and mass incarceration are other forms of racial violence that have become normalized to the detriment of black people all around the world; this is black genocide. These forms of violence may not appear so starkly but are fundamental to the system that enables them. The world will know that we will never have peace when such levels of apparent or tactful injustices still exist.

As systematic as the subjugation may be, the remedies should also aim for

structural changes. The anti-dote of the lethal poison should include naming and shaming, among other social pressure. The media plays a central role in this regard and is able to show leadership in defending the rights of minorities all around the world. Media and activists' alignment should go beyond promoting political interest. Nepotism, conspiracy against black intellectuals, through information asymmetry, all other forms sabotages should by no means be tolerated in international institutions where racism is a common practice. Aid and grants should by no means be used as a weapon of threat or a condition for submissiveness on those who stand for their rights and for the rights of others. We call for rejection of such resources that have hidden motives of undermining our natural pride and dignities.

Racism is a present and imminent threat to humanity. Its consequence is a catastrophe like all other global threats, such as terrorism and pandemic. Thus, it requires a similar conviction and commitment across the globe. Racists should not have heaven anywhere to hide in.

Systemic racism is a sophisticated action, designed and devised by capable actors. It is all about conditioning one's habits of thought, hence training or

reforming of institutions as such is a futile exercise. All efforts in change should abe backed by legal action with strong enforcement. It is time for revolution.

Racists have no morals or mercy. They are as sick as bloodsuckers that are keen to do anything to protect their interests, especially if they feel your action will fundamentally shake their supremacy. They are capable of doing anything from defaming to false allegations to writing fake histories, which serve their purposes. It is very unfortunate, our peace and tranquility have always been at risk, just because some want to be more equal than the others. Our democracy, civilization, and all advancement that we brag on are futile and are proving to be incapable of securing our coexistence.

We are determined now more than ever not to be manipulated, divided, subdued and to not accept others' approval for our existence. Enough is enough. This has to be stopped.

It is time for Black people all over the world to unite in this cause. Yes, Black lives matter! So do Black Pride and Dignity!

Building primary health care capacity should be global response to elderly's abuse, neglect

HE United Nations has designated June 15 every year as World Elder Abuse Awareness Day. It represents when the whole world voices its opposition to the abuse and suffering inflicted to some of our older generations. Virtually all countries are expected to see substantial growth in the number of older persons between 2015 and 2030, and that growth will be faster in developing regions.

Because the numbers of older persons are growing, the amount of elder abuse can be expected to grow with it. While the taboo topic of elder abuse has started to gain visibility across the world, it remains one of the least investigated types of violence in national surveys, and one of the least addressed in national action plans.

Elder abuse is a global social issue which affects the health and human rights of millions of older persons around the world, and an issue which deserves the attention of the international community.

It essential that governments and all concerned actors to design and carry out more effective prevention strategies and stronger laws and policies to address all aspects of elder abuse. Let us work together to optimize living conditions for older persons and enable them to make the greatest possible contribution to our world.

It was officially recognised by the United Nations General Assembly in December 2011. Elder abuse can be defined as "a single, or repeated act, or lack of appropriate action, occurring within any relationship where there is an expectation of trust which causes harm or distress to an older person". It is a global social issue which affects the health and human rights of millions of older persons around the world, and an issue which deserves the attention of the international community.

In many parts of the world elder abuse occurs with little recognition or response. Until recently, this serious social problem was hidden from the public view and considered mostly a private matter. Even today, elder abuse continues to be a taboo, mostly underestimated and ignored by societies across the world. Evidence is accumulating, however, to indicate that elder abuse is an important public health and societal problem.

Elder abuse is a problem that exists in both developing and developed countries yet is typically underreported globally. Although the extent of elder mistreatment is unknown, its social and moral significance is obvious. As such, it demands a global multifaceted response, one which focuses on protecting the rights of older persons.

From a health and social perspectives, unless both primary health care and social service sectors are well equipped to identify and deal with the problem, elder abuse will continue to be underdiagnosed and overlooked.

Elder abuse also called elder mistreatment, senior abuse, abuse in later life, abuse of older adults, abuse of older women, and "abuse of older men is a single, or repeated act, or lack of appropriate action, occurring within any relationship where there is an expectation of trust, which causes harm or distress to an older person. This definition has been adopted by the World Health Organisation.

It includes harms by people the older person knows, or has a relationship with, such as a spouse, partner, or family member; a friend or neighbour; or people that the older person relies on for services. Many forms of elder abuse are recognised as types of domestic violence or family violence since they are committed by family members

Just how do we work for an inclusive and just energy transition where no one is left behind?

HE energy transition will profoundly change our energy landscape in ways that none of us has yet fully grasped.

One of the more interesting aspects of the broad renewable energy sector is how quickly things have changed in just 10 years. One result of this is that the worthwhile debates surrounding renewable energy change as quickly.

This presents a problem: governments, incumbent utilities, policymakers and regulators invest resources, time, energy and their lobbying efforts to win the argument, to draft new laws and regulations, but as these efforts culminate in some sort of outcome, the real debate has moved elsewhere. Yet, debates that ought to have been settled, rage on.

Consider this: Already in the 1980s a consensus was building among climate scientists that greenhouse gasses, especially carbon dioxide, from human activity was warming the earth's atmosphere, that it would induce climate change and this change would be harmful. The establishment of the Intergovernmental Panel on Climate Change (IPCC) under the auspices of the United Nations, followed up, in 1992,

by the United Nations Framework Convention on Climate Change (UNFCCC) and the Kyoto Protocol, agreed in 1997, committed signatory countries to reduce greenhouse gasses to combat climate change.

Even under the Trump presidency in the US, which has an overt policy of supporting the coal sector and is hostile to global efforts to fight climate change, there is less coal-fired electricity generation now than when Trump became president in 2016. Low carbon nuclear energy is also in retreat. This is not about issues surrounding climate change, it is about the awful economics of coal-fired and nuclear energy.

However, we should not fool ourselves. An electricity supply system dominated by renewables is quite different to the centralised coal-fired system we have now. A good way to start to understand this is to look at the system from the point of view of the last customers in the system - the household.

Absent load shedding, we get our electricity delivered in the following format: around 230Volts of alternating current (AC) of around 60 Hertz through 20 Amp circuit allowing a 4,6KW load (three phase systems triple

Using this set up, we can run anything from heavy loads required by ovens or washing machines to LED lights. We can have as much (within the limits of the circuit) or as little as we want at any time. For all this, we are charged by the amount of energy (kWh) we consume in

Introducing renewable energy upends all of this fudge. To use one example: coal-fired or nuclear power stations work by boiling water and having the steam turn a turbine to generate electricity. Gas-fired power stations turn a turbine directly.

Racism in our schools is a continuum of our past

must remember that most of the historically elite private schools were founded on Christian foundations, by rich white men who had no issue with being racist, homophobic or chauvinists. Tackling oured and Indian were the oppressed social justice through a lens of race, masses in this country. They were the class and gender thus becomes very important.

As a father of two kids at a private school in Gauteng, a husband to an educator and having a father-in-law who has been a headmaster at a few private schools, I thought I'd weigh in on this question of racism in our schooling system.

I believe that as parents we have failed in preparing our children for these very complex questions on race, gender, identity and class politics. In fact, in some circumstances, I would argue some of us actively fuelled these matters, given our own racist beliefs. After all, we remain products of our racist past. We have to own up and we have to do more.

Given the preponderance of Western culture and US popular culture in particular, it is unfortunate that the murder of George Floyd and not our own Collins Khosa sparked the necessary outrage over racism in our schools. I make this point about preponderance because I do think that our younger generation, particularly in our private and Model-C schools, has appropriated the lexicon of the US without deeper thought analysis.

For example, when I look at some of the demands made by the students at Bishops (Diocesan College), I cannot but wonder why they talk of people of colour (POC), or "minorities", when in fact, unlike the US situation where indeed the average African American person is indeed a minority in that country, we are the black majority in South Africa. And what that means is that we cannot play the continuous victim card, unlike our counterparts in the US, who remain on the back foot having to knock on the master's door, when we, the black majority, are the master – get used to it, start claiming it. We have political power in this country and as such cannot talk about minorities, not even in the private school context.

As for the POC label, this again is appropriated without taking into consideration our own Struggle his-

tory in South Africa. Yes, it goes without saying that indeed the most oppressed and exploited grouping in SA was indeed the black African but this was not wholly at the expense of the so-called coloured and Indian peoples. No, the general BLACK population in SA, made up of African, colslaves, the indentured labourers and the subhumans for the longest time in our history in this country; this is undeniable. Wanting to make any distinction between the severity of such oppression among these groups is missing the point altogether.

In seeking redress and equality one cannot call for a method that is divisive in nature.

In fact, the very reason the apartheid state wanted us to make such differentials is to subscribe to that old strategy of divide and rule. And so, by insisting as you do in your demands, to elevate this matter of "colourism", you are but reinforcing such divideand-rule tactics of the past. I know there are indeed those among the coloured and Indian communities that desperately want to cling to such classifications, but these are confused persons who cling to racist apartheid classifications that are derogatory whichever way you slice it.

I can only but assume the main reason they want to insist on othering is because deep down they actually think it means that they are better than the black person. After all, to be black is supposedly a bad thing throughout the world, as we observe. That's why we must supposedly remind everyone that, "Black lives matter". But I contend that this is an insufficient call to action. What matters more is white brutality and racism. We are black, so we need not remind ourselves that we matter.

We need to be more explicit about white privilege, racism and white supremacy. It matters not that I am black and I have a life. I already value that. I don't need a white person to value that. What matters now is the actions of racists in offending and murdering that life. We must choke the air out of all the spaces that fuel racism. It does not matter at all how a woman dresses, it matters only what the rapist does. This same approach should also be used to fight white supremacy.



of the perpetrators. Call it out, "soft" or hard and cannot sing or read. Our SA Constitution is racism. At the braai, in the workplace, in all our spaces and especially in our schools. Let's make racism a matter that matters for us all. Racists do not believe our lives matter, there is no need to respect them with diplomatic niceties about black lives. "I can't breathe" – must be changed to "You are choking me".

As I read the demands of the Bishops matrics, I could not but help be reminded of what Mandela told us:

"Our struggle was against white supremacy, not against white people.'

And so, let's put our collective knee on racism and snuff it out! But, let's snuff it out in our South African context, it's not OK when a white and black girl sing a song and use the word nigger, and the school hauls the white student before a disciplinary committee but not the black girl, as if to imply it's OK if the black student uses such a derogatory word. A minority in the US may want to own that derogatory word given their specific history, but we don't want it here, just like we don't want to own the word "kaffir" given our history. Our Constitution simply prohibits the use of such derogatory slurs, period.

It's not OK that as blacks we allow white friends to appropriate black culture in music and litera-Let's keep the focus on the actions ture but then want to regulate what they can

very explicit on these matters, racism is racism whether it comes from a white person or a black person. I just get the sense that a lot of what is going on from these schools on social media platforms, for example, is about wanting to discipline whites, wanting to regulate them, wanting them to know their place in society. It's so very pejorative in nature. Is this really what our broader struggle should only be about?

The hair policy matter is something that always comes up time and time again as well – have you ever considered that even though you make these demands at these private schools, there is a certain decorum of hair and neatness at our public, predominantly black schools too? It's not as if every black child is simply allowed to do whatever he/she pleases with regard to school uniform, hair, nails and so on.

In other words, what is distinctly absent from your demands is the class component to your demands. What I mean by this is that there is no due regard to the poor child in our public school system at all. And so you can see how you locate this struggle only within your private school domain, your class strata domain, which I assume you are very comfortable with, but the struggle is much larger than just your private school issues.

It reminds me of the 1980s when we black stu-

dents were demanding free higher education because of our poverty levels in society, when our white counterparts at UCT made their most critical demand more student parking. Our demands could not have been more divergent. Don't fall into this trap.

You have to actively work towards finding each other in these circumstances, and yes, in time many of these issues will resolve themselves, if there's a will. I'm reminded of when my father-in-law appointed the first black geography teacher at Kearsney College many years ago. Almost instantly he received a call from a parent, stating that her son could not understand this teacher because of the way he spoke the English language.

The headmaster reminded the parent that not only will a person with such an accent be the next chairperson of the school governing body, but that the said student will likely be working for someone with such an accent in the near future. The very same boy grew very fond of this particular teacher and spent many a time in the teacher's home village in rural KZN, helping out with teaching underprivileged kids in that community. He grew to appreciate and admire his geography teacher and indeed embrace difference. We can also do this over time.

Evidently, the impact of the transformation and diversity training in our schools is not having the desired outcome and hence more needs to be done as demanded by the students at Bishops. We must remember, the majority of these schools are founded on Christian foundations, by rich white men who have no issue with being racist, homophobic or chauvinists. Tackling social justice through a lens of race, class and gender thus becomes very important.

We must, however, be aware of constitutionally ingrained demands, demands around the LGBTIQ+ communities for example, are allowed to flourish everywhere, not allowing it would be unconstitutional and the school can be challenged in a court of law. I get that what you are actually wanting to demand is a culture change in these schools and that I support fully. But, play the ball and not the player, don't make this about narrow issues of wanting to discipline white students, managers and school administrators, because it shouldn't be about that.

Controversial as this next point might be, I do want to also throw it into the mix, and this is that you must remember that you or your family have chosen to be part of these institutions and hence embracing its institutional culture. Don't get me wrong, no culture can continue to be derogatory, racist or any other form of prejudice, but you knew of its specific culture when you applied to be a part of it.

I raise this because of my own experience at Cambridge University in the UK as a student there. I wanted to be part of and chose to be part of this prestigious institution and therefore had to contend with centuries of culture and practices that at times were so dated and indeed not very politically correct, but it required a certain level of sophistication in tackling some of them. I couldn't simply waltz in there as a black student from a developing country such as South Africa and think they would conform to my needs and demands, saying it was non-negotiable.

New bread baskets emerge in Tanzania's western 'big four'

TANZANIA is making more progress in strengthening its position as one of the most food-secure countries in Africa, having maintained national food self-sufficiency for over a decade and subsequently putting in place a good foundation for the agriculture-based industrialised and middle-income

In a review of four western Tanzania regions, work supported by PiATA-TIJA initiative has contributed to enabling Kagera, Kigoma, and Katavi to emerge as new food basket zones. The work also enhanced further the role that Rukwa region plays as one of the "big four" in food production in Tanzania.

During the last three years, with support of the partnership and others, those three western regions have made strides in becoming dependable net food exporters and are enhancing Tanzania's status as the food powerhouse in East African Community (EAC) and the Southern African Development Community (SADC), according to Vianey Rweyendela, AGRA County Manager for Tanzania.

According to the Bank of Tanzania (BoT) 2018/19 annual report - agriculture, construction, and transport as the fastest growing economic activity, while the 2017/18 puts construction, transport and storage, agriculture, and information and communication activities as the drivers of growth. This underpins the increasing cardinal role agriculture is playing in the development of Tanzania.

It is estimated that production yield (metric ton/hectare) of two key staples-maize and beans increased by 230 % and 100 % respectively in the 4 regions under review, while rice production yield increased by 67 % in Katavi and Rukwa regions, which has led to surplus production and pathway to increased incomes for smallholder farm-

According to Japhet Hasunga, minister for Agriculture, food production has continued to improve in the country. In his 2020/21 budget speech, he reported that in the 2019/20 cropping season, Tanzania will achieve 121percent food self-sufficiency, translating to a surplus of 2.8 million metric tonnes (MT).

The PiATA-TIJA initiative in Tanzania is part of a pan-African Partnership for Inclusive Agricultural Transformation in Africa (PIATA), implemented by the Alliance for a Green Revolution in Africa (AGRA).

The resource partners of PIATA are Bill & Melinda Gates Foundation (BMGF); Rockefeller Foundation (RF); United States Agency for International Development (USAID), Department for International Development (DFID), and German Federal Ministry for Economic Cooperation and Development (BMZ). AGRA invests resources to catalyze partnerships that bring together the central government, local governments, private sector in the inputs and output markets, and smallholder farmers; to enable the development of strong food value chains.

About 550,000 smallholder farmers in the four regions have been impacted by PiATA-TIJA, leading to a marked growth of the private sector along value chains of maize, beans, rice, and cassava. This is thanks to the increased availability of inputs near smallholder farmers due to an increased number of agro-dealers which has translated into increased usage of improved technology and highly enhanced productivity.

The farmers were impacted in diverse extension services and were able to increase income and improve food security thanks to increased productivity, access to market, and finance.

He noted some of the major milestones achieved by the farmers supported by PiATA-TIJA in the three consortia, includes: 230 percent increased maize yield productivity (from an average of 1.125 in 2017 to 3.75 metric ton/hectare, 2019), 100 percent increased bean yield productivity (from an average of 0.675 in 2017 to "We are working very closely with 1.35 metric ton/hectare, 2019), 67 percent increased rice yield productivity (from an average of 3

increase in Agro inputs shops (from 395 in 2017 to 1269 in 2019). Others are 400 percent increased fertilizer sales (4428 MT in 2017 to 22,401 MT in 2019.), 238 percent increased purchase of improved maize seeds sales (from 434 MT in 2017 to 14,54 MT in 2019, 45 percent increased the number of processors in Rukwa/Katavi (from 28 in 2017 to 63 in 2019 and 127 percent increased annual processing capacity for SME processors in Kagera from 7165MT in 2017 to 16265MT in 2019.

It has supported construction of about 10 new warehouses and modernization of over 40 warehouses belonging to the private sector, farmers' groups, and in some cases the public sector. It has also supported 5000 agrodealers with capacity building making it possible for more smallholder farmers to access inputs- seeds, fertilizers, and post-harvest technology.

In supporting the government of Tanzania to beef up agriculture, from 2017 to 2020 AGRA has invested/committed a total of US\$75million. In 2019/ 20, period AGRA is supporting Tanzania in two groundbreaking programs that will enable the scaling-out of the achievements in the four regions to the rest of the country. The first is the support given to the government, through the ASDP-II coordinating mechanism

to develop an Agro-industrialization Development and Investment Flagship (TAIDF), a major component of the Industrialization Drive by the 5th Phase Government. The second is support through TAMISEMI to enable the government to Strengthen the Coordination of ASDP-II by Local Government Authorities (SCALGA).

AGRA is an African-led, Africa-based institution transforming smallholder agriculture from a solitary struggle to survive into farming as a business that thrives. Its goal is to increase incomes and improve food security for 30 million farming households in 11 African countries by 2021.

Youth-led innovations, collaborations are crucial for keeping oceans healthy

PROPER synergy involving youth, innovations, technology and strategic collaborations has been singled out as prerequisites in attaining sustainable conservation of the world's oceans, aquatic resources and its environs.

That was the main message during the event to commemorate the World Oceans Day 2020 held in Dar es Salaam on June 8. This year's theme was "Innovation for a sustainable blue

The event which was held virtually provided an opportunity for different stakeholders to engage in topics around innovations in relation with sustaining oceans.

Aqua-Farms Organisation (AFO), a youth-led organization for conserving aquatic resources including the ocean, has been championing the world oceans day in Tanzania in collaboration with different entities since 2018.

The panel discussion that involved participants from private sector, academia and green entrepreneurs was moderated by Nancy Iraba, Co-founder of AFO and founder, Ocean Literacy Initiative.

AFO collaborated with Western Indian Ocean Marine Sciences Association (WIOMSA), Arena recycling Company, Ocean Literacy Initiative, University of Comoros, and Intergovernmental Oceanographic Commission (IOC) UN-ESCO Africa.

Panelists at the event elaborated some of the innovative works done by their entities to solve myriad of threats facing oceans that includes ocean acidification, climate change, over-exploitation and pollution among other challenges.

Hellen Sailas, founder and Director General at Arena recycling company explained how her recycling venture of turning plastic wastes into Ecobricks works. The lady is among few women globally recognized by the Economic Group World Ocean Initiative for her innovative work.

"I was inspired after seeing our beaches polluted with high number

of plastic wastes," said Hellen adding sues?" he challenged colleagues that they have been working to protect life below water through organizing beach cleanups to collect plastics, sorting and melting them using ecobricks formula.

"This venture is profitable as ecobricks are in demand for construction of houses, toilets and offices," said Hel-

Hellen recommended youth engagement in accelerating innovations for achieving sustainable oceans.

"We need technologies that can track marine debris and clean our oceans to be free from plastics, and tackle climate change by reducing the carbon footprints," she elaborated.

Contributing, Dr Nadjim Ahmed, a lecturer at the University of Comore, Faculty of Sciences and Technology explained how he works with his team to bring innovative solutions in the area of benthic biodiversity which is lagging behind in his country.

"There is little information on benthic invertebrate in my country but we are using little resources available to conduct molecular techniques and and ecosystems in Comoros," he not-

Dr Nadjim is currently building equipment to work on coastal areas and deep-sea. The approach used has been inspired by the SA Agulhas research expedition that used innovative tools to sample underwater benthic organisms.

Dr Mathias Igulu, a Grant Manager at Western Indian Ocean Marine Science Association (WIOMSA) asked panelists trate the possible means of self-emand fellow scientists out there to ask themselves if they are prepared to deal with challenges beyond 2030.

He pointed out areas that need special attention as climate change, managing land-based pollution, ocean acidification, marine litter, and threatened endangered species. He highlighted how different sectors have embraced Artificial Intelligence (AI) and asked scientists to rethink how to make AI to work in fisheries sector for collecting data and addressing important questions.

"We need to position ourselves to utilise technology for the advancement of our oceans as most of the Western Indian Ocean regions are lagging behind," he said, adding this should be a waking up call for the youth and emerging scientists on ways to move forward.

Dr Nadjim was concerned with the lack of interest of youth in his country to engage in ocean sciences and recommended to learn on technologies and innovations practised by other countries for adoption and institution capacity building.

Apart from the main panelists, the event had invited speakers who conmonitoring of benthic communities tributed on challenges and opportunities of innovation in the Western Indian Ocean regions.

Mika Odido, the Africa Coordinator for the IOC UNESCO pointed on the literacy gap and creation of careers in the field of marine sciences.

He demonstrated the existing gap in students understanding the potential opportunities in the marine sciences as well as the gap in the region's academic programs as they fail to illusployment in the sub-sector.

"Institutions and universities offering oceanographic programs should strive to produce job creators rather than job seekers," Odido said, noting ESCO has embedded youth and earlycareer scientists in their plans for the next decade.

Moreover, the President of WIOMSA. "Will we be in a position to tackle Dr Jacqueline Uku emphasized on the need to embrace innovation to tackle the challenges of climate change.

The dilemma of the Liberian youth

FOR the better part of two decades, several friends of mine and I have been engaged in a conversation about Liberia's challenges. We often widened the conversation to include the whole continent. Why do we rank so low on the development ladder--infrastructural, educational, economic, technological, etcetera--and our people so poor despite our rich natural endowments and decades of interactions with the developed world, has been the question that we have been grappling with.

During the last four to five decades, several countries, particularly in Asia, made the successful march from dirtpoor-third-world status to the developed or developing country status. Today, the world is celebrating what may be called the China miracle. A third world country a few decades ago, China is today a rising superpower that is giving the West jitters and that has become most of Africa's destination for investment and development aid.

What makes one nation succeed where so many others are failing is a complex question, but that political leadership plays a critical role cannot

And by leadership I do not just mean the guy at the top; I have in mind a team, that collective that conceives policies and plans and directs programs. The Chinese philosopher Confucius taught that people are like the grass and their leaders are like the wind. Whichever direction the wind would blow, he said, there the grass would bend. Translation: as the people's leaders go, so go the people!

In democracies, the question of political leadership is answered by the people; they determine through their votes who should be their leaders. In today's Liberia, it is what the youths say on this question that matters most since they constitute more than sixty percent of the electorates. So, it seems to me, a serious conversation about Liberia's challenges and future requires a civil conversation with Liberia's youths, thus my reason for writing this piece. I write simply to stimulate a non-partisan conversation with and amongst Liberia's youths about how we might move our country to a better

By virtue of their numbers and our new democratic dispensation, Libe-

whether the sailing would be smooth or turbulent. This is an enormous responsibility, even a burden! Unfortunately, I learned from my interacting with and observing some of our young people during the last more than seven years that it is difficult for many of them to focus on this big picture--that the decisions they make on the issue of political leadership, local and national, do actually impact the future of the country.

One of the major blinders--the one thing that often prevents many from focusing on the big-picture issues--is not educated vs uneducated but rather the high level of poverty in our country. Because so many of our people live in poverty, they are continually occupied with survival issues--money for school fees, food for today, rent for next month, etcetera -- leaving little or no time to think deeply about big national issues.

Poverty is not a new phenomenon in Liberia. I, for example, was one of the lucky few who lived on the University of Liberia's men's dorm on capitol hill when I was attending the university in the 1970s.

At that time, I attended the First Baptist Church of Oldest Congo Town, located on the Congo Town back road. Many Sundays I did not have the 10-cents (20 LD) bus fare to go from the campus to church. I also remember several colleagues who went through the university shacking with friends on the dorm because they had no stable place to live in Monrovia.

But three related things have made poverty a dangerous blinder today for so many.

The first is its sheer level; the civil war and the non-strategic management and investment of public resources since the war ended greatly increased the level of poverty in the country. Second, the economy contracted for the same reasons, thus reducing most of the available employment opportunities to government jobs. And third, the number of persons competing for those few government jobs has increased astronomically, making it difficult for many of the young people entering the job market today to get gainful employment.

We, the young people of my time, persevered through our poverty to get an education because we were reasonably sure of a better life after graduaria's youths practically hold the future tion. About thirty days after receiving of the country in their hands. Where our engineering degrees, two friends



of the National Housing and Savings Bank on Bushord Island, located at the UN Drive and Caldwell Road junction. Many of our liberal arts colleagues also quickly got employed. Today, the situation is starkly different.

So, understandably, many of the young people today have been compelled to turn to politics, the one thing that has been shown to give them a fighting chance to survive, get an education and pursue their dreams. However, this outlet, which has now become the surest path to wealth and luxury for a lucky few, requires a political patron--a political officeholder who will "push" the young person through to a government job.

That sponsorship often comes with a shackle that literally makes the patron the owner of the young person. Where the patrons are unprincipled, the beneficiary young people are mentored/conditioned to often act against their long-term self-interest as they do their patrons' biddings. It must be this phenomenon that the Nobel Laurate, Oluwole Soyinka, had in mind when he said, "Only in Africa will thieves be regrouping to loot again and the youths whose future is being stolen will be celebrating it.'

In the seventies, many of the young people who followed Bacchus Matthews' PAL and Tipoteh's MOJA, the two main advocates for social and economic justice at the time, did so mainly on ideological grounds; they believed that they were working and sacrificing to change the Liberian society for the better; their leaders had no money to reward them

They too were poor, but they apparently managed to look beyond their poverty to see the "better place" that their patrons advocated for. Unfortunately, because that effort was aborted, all one can do today is to speculate whether their patrons could have brought them to this "better place."

How does a young person act today in a way that attends to his/her legitimate need to survive--get an education, pay rent, put food on the table, support a young family--and at the same time support our collective need for a country that lifts all its people?

On the one hand, the former requires the young person to be loyal to a political patron, often with little or no consideration for the requirements of the latter. On the other hand, focusing on the latter often means losing survival support since it would mean being more attentive to issues that disqualify his/her patron for public office, such issues as qualification, competence, capability, etcetera.

The situation is made even more difficult because the young person today sees little or no evidence that focusing on the big-picture issues actually brings benefits since many of the "qualified" adults who talked this talk in the most recent past only lined their own pockets when they were given the opportunity to lead. I concede that this is a difficult position to be in but let me share a few points that I suggest every young person consider as he/she thinks about this dilemma:

First, IT IS A FACT that the political patronage route, which we have been on now for quite some time, will only lift a lucky few out of poverty. Any young person who doubts this needs only to look around and will see the number of people who continue to struggle without a job after investing time and energy doing their patrons' biddings, often including badmouthing their patrons' competitors on social media. During the last more than seven years, I came to know many fine, smart and capable young people in the country, several blessed with quality university education, who were subsisting on the generosity of friends and family in foreign parts because either they had no patrons or their patrons could not secure for them a government job. Others were in this helpless, dependent state because some insecure political officeholder saw them as potential com-

dispensation lifts out of poverty become, as it were, islands of prosperity. And islands of prosperity in an ocean of poverty will always be vulnerable to tidal waves of instability. Thus, the political patronage route threatens our long-term security.

Third, IT IS A FACT that moving our country to that better place requires certain minimum qualifications, we deny this FACT at our own peril. Unfortunately, we often limit our definition of these qualifications to holding university degrees.

As I use the word here, I have in mind more than just academic credentials, as important as these are; I am also talking about a proven track record of integrity (doing the right thing even when no one is looking), transparency, trustworthiness, fairmindedness, empathy (putting one's self in other people's shoes), hatred of public corruption, and a servant spirit. I am not suggesting perfection, only a serious consideration for things that make for effective, accountable, and responsive leadership.

Fourth, IT IS A FACT that while it is true we do not have many adult leaders in our most recent past who exemplified the aspects of qualification alluded to above, people who possess these qualities do exist in our society; they might "bubble" to the surface if we put premium on these qualities when considering who we might support to be our leaders--local and national.

Lastly, IT IS A FACT that we will continue to linger in this wilderness of despair and wishful thinking until we realize, and act accordingly, that our redemption lies with our getting our most able to lead the effort to bring our country to a better place.

I realize that the issue of qualification for leadership is a difficult, complex one, but one upon which the future of any country rests. The choices we make every time we are confronted with this question impact the future of the country, for better or for worse.

In today's Liberia, the burden to get this thing right rests more heavily on the youths because of their electoral

Their opting to focus on the big-picture issues may require some sacrifice in the form of possible loss of support. But sacrificing to get our country to a better place will be well worth it, provided the choices made are based on demonstrated evidence of real qualification, as discussed earlier, and not just on sentiments.

From farm to fork: The women championing agricultural transformation in Africa

ROM Sudan to Mali, Senegal to Mozambique, and Zambia to Mauritania, women are changing the face of agriculture, adapting and innovating to tackle the challenges of climate change, and feeding the continent's growing population.

African women are actors along the entire agricultural value chain, as farmers, livestock breeders, food processors, traders, farm workers, entrepreneurs and consumers.

Through the African Development Bank's Technologies for African Transformation (TAAT) initiative, millions of African women have gained access to new agricultural technologies that have boosted their crop yields, enabling them to tap new markets and increase their incomes.

Improved seeds can help Africa's smallholder farmers, the majority of whom are women, to produce high crop yields even in areas plagued by climate change-related drought, floods and locust swarms that can destroy an entire harvest. Add in the constraints recently imposed because of the COV-ID-19 pandemic, and it's a tough time to be a subsistence farmer.

Fathia Mohamed Ahmed, who belongs to a collective of two dozen women farmers in Sudan's Darfur region is one such farmer. Through the TAAT initiative, her collective has

By African Development been provided with high quality seeds for cultivating sorghum, a grain suited to hot, dry conditions. Sorghum, also known as millet, yields a grain that is rich in carbohydrates, protein and other nutrients that can be made into porridge, flatbreads, and cakes.

As a result of higher yields, collective members have gained opportunities for business expansion, including selling sorghum for cash at local markets. "It is an important breakthrough for the group to start our business," Fathia said. "Our group is still in its infancy, but our focus is to grow and increase our agricultural business activities in the near future."

West across the Sahel in Mali, 54-year-old Dramane Diallo works alongside a group of women who cultivate rice in Baguinéda, in lowlands on the banks of the Niger river.

Thanks to a Bank-funded food and nutrition project, rice and cereal harvests in Mali's "rice bowl" have risen sharply, and farming families are reaping the benefits. "It used to be that you couldn't go near the embankments because they were in such poor condition. We had problems irrigating our fields," Dramane said. "But the irrigation channels have been restored and this has made my work less of a chore."

At the local market, new produce is available. Every evening, stallholder Adi-



growers in their fields to buy vegetables to sell the next morning. One of her customers, Ténin Traoré, is enjoying the new variety of food on offer: "Agricultural products used to be scarce in our market. Despite the demand, what was available from farmers was hasn't been like that for the last two years. Now, we have a modern market, we have everything we need and the quality is good too," she said.

In neighbouring Mauritania, the government partnered with the Bank to roll out a \$12 million irrigation project that has breathed new life into the west Brakna region, which is prone to aratou Traoré goes to meet expensive and poor quality. It droughts, food insecurity and other ef-

fects of climate change.

The development of irrigation systems and dredging of backwaters that flow out of the Senegal River has increased the arable and irrigated farmland from 300 hectares to almost 7,000

The project has benefited local women, including Oumou Salif Diop, president of a cooperative of 150 women

farmers. The women, who grow tomatoes, onions and rice among other crops, have received training under the project.

"We know how to work and how to preserve what we harvest," said Oumou. "We farm better, generating better yields and higher profits. Compared with before, there has been a huge change." Further up the agricultural value

chain is Monica Musonda, a Zambian businesswoman and CEO of food processing company Java Foods(link is external), which produces affordable and nutritious snacks made from local ingredients.

Although African women are well represented in cultivation, primary processing and as market traders, Monica is one of only few female entrepreneurs that have created large, profitable agri-businesses.

One problem is access to finance. The Bank estimates that a \$15.6 billion financing gap exists for African women in agricultural value chains. Women are forced to rely on personal savings and family loans which are rarely enough to fund businesses to scale.

The Bank's Affirmative Finance Action for Women in Africa (AFAWA) adopts a three-pronged approach-improving access to finance, providing technical assistance and strengthening the enabling environment-to close that gap.

As well as supporting women farmers' access to improved seed technologies and irrigation systems, The Bank is also promoting women's transition into the most profitable segments of agricultural value chains. And with good reason: when African women thrive their societies share fully in the dividends.

MultiChoice wants to be a 'one-stop shop'

MultiChoice's new DStv Explora decoder will be the first that will have the "shelf space" capability and come with a carousel user interface display incorporating icon tiles for the Netflix and Amazon Prime Video video streamers as DStv morphs into a pay-TV super-aggregator and a content "one-stop shop" that will carry even more such third-party services in future.

Besides the launch of DStv Streaming, Multi-Choice's "dishless DStv" digital streaming version of its current service that won't require the use of a this year that will be its first to carry and make overthe-top (OTT) services available to DStv subscribers in South Africa and across sub-Saharan Africa in the form of Netflix and Amazon Prime Video.

Since publishing the information as part of their latest 2019/2020 financial results, Multichoice has removed the Netflix and Amazon Prime logos (possibly due to on-going negotiations and other red tape) from the slides that are available to the public.

Talking about content, Imtiaz Patel, MultiChoice Group chairperson, on Thursday in the pay-TV operator's investors' call following the release of its 2019/2020 financial results, said that "the multitude of offerings are leaving customers overwhelmed with what is called the paradox of choice and the need for greater simplicity".

All of this is to be found on a single platform, with a single bill that provides convenience and choice to our customers through a one-stop shop."

Explaining how the Randburg-based pay-TV operator's own subscription video-on-demand (SVOD) service Showmax will sit alongside that of Netflix, Amazon Prime Video and possibly even more in future like YouTube, Disney+, HBO Max and others which are now in existence, Imtiaz Pasatellite disk or installation, MultiChoice also plans tel said that "local content and sport will be a key to push a new DStv Explora decoder to market later differentiator for Showmax and niche and general entertainment content from other providers will offer our customers more choice.

Investors Calvo Mawela, MultiChoice CEO, on the investors' call said that the pay-TV operator had to take the opportunity to "become the platform of choice for people to consume these OTT services." "People will go for where content is available. With the proliferation of all of these OTT's there are people who want to get access to this content and if we are a one-stop shop where they can get all these services we'll be positioned very well in the market for us to gain customers out there."

In terms of DStv set-top boxes and the timing of the roll-out, he said MultiChoice is in discussions with the distributors on how to launch. "There will be a new decoder that will be coming to the market

that will be able to allow this kind of services to be accessible through the decoder. Our current decoders do not support this."

He said that in the year ahead MultiChoice plans to "ramp up our investment in local content" and that "we will also be launching our OTT premium product, DStv Streaming, and focus on growing our paying Showmax subscriber base."

Talking about the strategy of adding video streamers he said that it will ensure that Multi-Choice "continues to be a one-stop shop where people go through us to Prime Video accounts get content - no matter where it comes from from any of the OTT players that are coming to the market. In that way we make sure that we remain relevant and that people find the convenience of paying just one bill".

"We also should not underestimate our ability to collect payment and to collect cash across the African continent - that also helps with the OTT's staying with us on our platform."

The World Health Organisation (WHO) says that the shift to the flavoured, sleek design products is a ploy to capture the younger generation market and in May started the 'World no tobacco day' campaign.

Meanwhile, the Global Forum on Nicotine in its seventh conference this year says move to e-cigarettes is an industry reform targeting the 1.1 billion smokers worldwide with safe nicotine products. GFN is an annual forum held to promote alternatives to smoking to cut tobacco-related deaths.

GFN is promoting use of vapes (e-cigarettes), Swedish snus, nicotine pouches and heated tobacco products as part of the industry's tobacco harm reduction approach. Regular cigarettes, sold in sticks, produce nicotine, a highly addictive substance that causes feelings of temporary relaxation and stress relief when inhaled, through the burning of tobacco.

E-cigarettes, on the other hand, comprises of handheld electronic devices that heat a liquid containing nicotine into a vapour that people inhale. "Smoking is the single biggest cause of non-communicable disease (NCD). It kills half of all those who smoke," GFN

The Global Burden of Disease study estimates that smoking directly accounted for 7.1 million premature

deaths in 2017, with an additional 1.2 million deaths attributed to second-hand smoke. Compared to regular cigarettes, whose health effects have been studied extensively over many years, studies on the impacts of e-cigarettes are still limited as it is only recently that the products gained popularity.

While some smokers have been able to quit, those who cannot are at a huge health risk, GFN says when they continue to use combustible tobacco. The lobby says where available and affordable, safer nicotine products such as vapes and snus give smokers more options.

But health experts warn that all tobacco products are harmful and dissuade people from using them. Globally tobacco control efforts led by international agencies such as the WHO have lowered smoking rates.

However, 80 percent of the world's smokers live in low and middle income countries, least able to implement tobacco control measures and whose healthcare systems are unable to cope with the disease burden of smoking. E-cigarettes are banned in countries such as India, Brazil, Uruguay and Singapore.

COVID-19 triggers visible acceleration towards cashless, digital economies

JOHANNESBURG

THE spread of COVID-19 has accelerated the adoption of mobile financial services, which are increasingly being recognised as a tool to mitigate the use of cash in a world fighting the pandemic.

This trend has been supported by the move by many operators, including MTN Group, to waive or reduce certain fees to ease customers' financial pressures amid a global economic contraction. "To date, as part of MTN's Y'ello Hope response to COVID-19, we have zero-rated 120 million peer-to-peer mobile money transactions with a value of approximately R43 billion," says Serigne Dioum, MTN Group executive for mobile financial services. "This has enabled many consumers and businesses across our 16 MoMo markets to transact and accept payments remotely, allowing them to continue operating despite lockdowns."

The operator believes mobile financial services have grown faster in Africa than anywhere else in the world. "As many countries adopted partial or total

lockdowns, we witnessed an evolution in the type and volume of mobile money transactions," says Dioum. "We saw a significant increase in MoMo Pay merchant and bill payments despite an initial decline in mobile money agent transactions due to the restrictions. However, we have already started to see a gradual increase as restrictions have been eased."

"These changes, triggered by COV-ID-19, have enabled the acceleration and scaling of cashless and digital economies. They support our ambition to transition to an end-to-end platform, creating a digital marketplace and connecting consumers to businesses, and businesses to businesses. We see this as a significant opportunity to change the outlook for affordable, inclusive, understandable and comprehensive financial services in Africa and the Middle East."

MTN says its MoMo Pay offering is live in 10 markets, with 250 000 merchants, 2,1 million active users. At the end of March 2020, the company had 35,1 million active MoMo customers, an increase of 0,4 million from December 2019.

World's 20 largest economies saw record contraction in first quarter, OECD says

The world's 20 largest economies have contracted sharply in the first three months of the year due to the impact of the Covid-19 pandemic and measure to contain the virus, according to the Organisation for Economic Cooperation and Development

The G20 nations' real gross domestic product (GDP), fell 3.4 per cent in the first quarter, the Paris-based global intergovernmental organisation said on Thursday. By comparison GDP fell only 1.5 per cent in the first quarter of 2009, at the height of the financial crisis, the OECD said.

The world's second largest economy China recorded the largest contraction of 9.8 per cent, France and Italy each contracted 5.3 per cent, Germany shrank 2.2 per cent, Canada 2.1 per cent and the UK 2.0 per cent. Brazil's economy decreased 1.5 per cent, the US 1.3 per cent and Mexico 1.2 per cent.

The contraction was less pronounced in Indonesia which shrank 0.7 per cent, Japan 0.6 per cent and Australia 0.3 per cent. India expanded 0.7 per cent and Turkey with 0.6 per cent, the only two G20 economies that recorded growth. The G20 nations, currently led by Saudi Arabia, represent 85 per cent of the world's nominal GDP. The group of 20 biggest industrialised nations include the European Union and 19 other countries.

The coronavirus outbreak has claimed more than 417,000 lives and infected more than 7.3 million people worldwide, according to Johns Hopkins University, which is tracking the

outbreak. Both global infections and morality rate are likely being "significantly underestimated," Angel Gurria, OECD secretary general said this week.

The pandemic had forced governments to close borders and shut all but essential businesses to stem the spread of the virus. Major economies around the world are now opening up gradually, four months after the World Health Organisation declared Covid-19 a pandemic.

G20 governments and central banks have pumped about \$9 trillion into the world economy to revive output, stem job losses and support small businesses. Globally, the output is forecast to contract as much as 7.6 per cent in 2020 in the absence of a Covid-19 vaccine, according to the OECD. The World Bank has projected global output shrinking 5.2, while the IMF forecasts a 3 per cent contraction this year.

The G20 countries were among the first to introduce lockdowns and social distancing measures and those that enforced the most stringent lockdowns, saw the largest contractions in their first

quarter GDP, the OECD said on Thursday.

The economic outlook for the G20 for the remainder of 2020 is not positive, according to Moody's Investors Service. Advanced economies within the G20 group are expected to contract 5.8 per cent this year and even a gradual recovery in 2021 is not expected

to revive their GDP to pre-pandemic levels Moody's said in April.

Emerging economies within the G20 fold, with the exception of China, are expected to contract by 3.5 per cent from a growth forecast of 3.2 per cent prior to the outbreak, according to the rating agency.

While world trade has been already slowing down before the onset of the Covid-19 pandemic, due to trade tensions, the economic and social disruptions brought by outbreak are resulting in a dramatic decline in trade, the United Nations Conference on trade and Development (UNCTAD) said on Thursday.

The value of international trade in goods has declined about 5 per cent in the first three months of the year and is expected to fall a further by 27 per cent in the second quarter. "No region has been spared from the decline," UNCTAD

East Asia and the Pacific regions appear to have fared better than other regions, with trade declines for these regions in the single digits both in the first quarter of 2020 and in April.

Still UNCTAD said "preliminary, data for April suggest a sharp downturn in all other regions with declines of up to 40 percent for countries in South Asia and Middle East regions."

Purchasing Manager Indices (PMIs), also signal further deterioration of international trade in the second quarter. "While PMIs tracking international trade indicate that the pace of contraction has slowed in May, they have remained well below the 50 points benchmark," UNCTAD said.

Zoom under pressure to clarify China ties

WASHINGTON

THREE US lawmakers have asked Zoom Video Communications to clarify its data-collection practices and relationship with the Chinese government after the firm said it had suspended user accounts to meet demands from Beijing.

The California-based firm has come under heavy scrutiny after three US and Hong Kong-based activists said their accounts had been suspended and meetings disrupted after they tried to hold events related to the anniversary of China's Tiananmen Square crackdown.

Zoom said on Friday it was notified of the events and asked to take action by the Chinese government in May and early June. It said it has now reinstated these accounts and will not allow the country.

"We did not provide any user information or meeting content to the Chinese government," Zoom said in a statement. "We do not have a backdoor that allows someone to enter a meeting without being visible." The online meeting platform, which has surged in popularity as the Covid-19 pandemic has forced millions around the world indoors, has seen its downloads soar in China.

The service is not blocked in China, unlike many Western platforms such as Facebook and Twitter, which abandoned efforts to crack China's market years ago due to government demands to censor and monitor content. Twitter on Thursday said it had removed accounts tied to a Beijing-backed influence operation.

Greg Representatives Walden, the top Republican on the house energy & commerce committee, and

Cathy McMorris Rodgers, the ranking member of a consumer subcommittee, sent a letter to Zoom CEO Eric Yuan on Thursday asking him to clarify the company's data practices, whether any was shared with Beijing and whether it encrypted users' communi-

Republican senator Josh Hawley also wrote to Yuan asking him to "pick a side" between the US and China. The three politicians have previously expressed concerns about TikTok's owner, Chinese firm ByteDance, which is being scrutinised by US regulators over the personal data the short video app handles.

"We appreciate the outreach we have received from various elected officials and look forward to engaging with them," a Zoom spokesman said. China's Internet watchdog, the further requests from Chi- Cyberspace Administration na to affect users outside of China, did not immediately respond to a faxed request for comment.

Wang Dan, a US-based dissident and exiled student leader of the crushed 1989 Tiananmen Square protests, had his Zoom account suspended. He said he was shocked to hear Zoom acknowledge it had interrupted meetings he was participating in. His 3 June event with about 200 participants was deactivated midstream, he said.

"Zoom compiled with China's request, preventing us from going about our lives smoothly," Wang said in an e-mail. "It cannot get away with just a statement. We shall continue to use legal means and public opinion to ask Zoom to take responsibility for its mistake."

The company said it is now developing technology to enable it to remove or block participants based on geography, allowing it to comply with requests from local authorities. It said it would publish an updated global policy on 30 June.

Over 100 arrested in central London in violent protests against anti-racism

OVER 100 people were arrested during Saturday's far-right protests in central London, which turned violent later and left six police officers with minor injuries, Scotland Yard said.

A crowd of people, mainly white men, converged on Parliament Square, before moving to Trafalgar Square and other areas in central London on Saturday to "guard" statues as part of counter-protests against anti-racism demonstrations.

Around 200 protesters later broke the police curfew by remaining in the area past 17:00 p.m. local time (1600 GMT), most of whom congregated around the statue of Winston Churchill.

Among those gathered was Paul Golding, leader of the far-right group Britain First, who had called on supporters to descend on the British capital while claiming authorities had "allowed vandalism against national monuments."

The protests then turned violent, with demonstrators pelting bottles and at least one smoke bomb at police officers on foot and on horseback. Chants of "England" rang out around the Whitehall road as many of those present were drinking.

Six police officers and at least 13 other members of the public were injured during the protests, and six of them were taken to hospital, the ambulance service

As of 21:00 p.m. local time, at least 100 were arrested for offenses including violent disorder, assaulting police officers, possession of an offensive weapon, possession of class A drugs, being drunk and disorderly and breach of the peace, Scotland Yard said.

"Millions of Londoners will have been disgusted by the shameful scenes of violence, desecration and racism displayed by the right-wing extremists who gathered in our city today," London Mayor Sadiq Khan wrote on Twitter following

"In the face of attacks and abuse, our police did a fantastic job to control the situation. Thank you," he wrote.

Prime Minister Boris Johnson also condemned the violence on Twitter, posting, "Racist thuggery has no place on our streets. Anyone attacking the police will be met with full force of the law."

"These marches and protests have been subverted by violence and breach

the UK and we must work together to make that a reality," he wrote.

"Any perpetrators of violence or vandalism should expect to face the full force of the law," Home Secretary Priti Patel wrote on Twitter, calling the violence "unacceptable thuggery."

"Violence towards our police officers will not be tolerated. Coronavirus remains a threat to us all. Go home to stop the spread of this virus & save lives,"

Meanwhile, Shadow Home Secretary Nick Thomas-Symonds joined the condemnation, saving the protesters seemed "intent on causing violence and

The latest far-right protests took place after a series of anti-racism demonstrations across the country, sparked by the death of African American man George Floyd on May 25 in the U.S. city of Minneapo-

Floyd, 46, died after a white U.S. police officer knelt on his neck for almost nine minutes until he stopped breathing. In a video footage, Floyd was heard saying "I can't breathe" while three other police officers stood by.

Last weekend, anti-racism protesters in London

in central London, and toppled a statue of 17th-century slave trader Edward Colston in the southern British city of Bristol. They had also arranged further protests this weekend, prompting statues to be boxed up.

In response, Mayor Khan said Friday that key statues and monuments in London, including the Cenotaph in Whitehall, statues of Churchill and Nelson Mandela, are to be covered and protected.

Anthony Glees, former director of the University of Buckingham's Center for Security and Intelligence Studies, told Xinhua in a recent interview that he was not surprised the anger over Floyd's killing spread across the Atlantic to Britain.

"My sense is black people in Britain share the anxieties and resentments felt by American black people, and associate with them very strongly," Glees

"The murder of George Floyd has visibly awakened many people," Brussels Times newspaper quoted Ange Kazi, spokesperson of the Belgian Network for Black Lives Matter, which called for the protest, as saying.

"Many people are fed up with police violence, which systematically affects Blacks," she said.

BREASTFEEDING mothers do not seem to be passing on the new coronavirus to their infants, and based on current evidence the benefits outweigh any potential risks of transmission, the World Health Organization (WHO) said on Friday.

WHO director-general Tedros Adhanom Ghebreyesus said that it had carefully investigated the

risks of women transmitting COVID-19 to their babies during breastfeeding.

"We know that children are at relatively low risk of COVID-19, but are at high risk of numerous other diseases and conditions that breastfeeding prevents," Tedros told a news conference.

"Based on the available evidence, WHO's advice is that the benefits of breastfeeding outweigh any potential risks of trans-



mission of COVID-19," he said.

Anshu Banerjee, a senior advisor in WHO's Department of Reproductive Health and Research, said that only "fragments" of the virus had been detected in breast milk, not live virus.

"So far we have not been able to detect live virus in breast milk," he said. "So the risk of transmission from mother to child so far has not been established."

Beijing tightens control measures as new COVID-19 cases reported

BEIJING

BEIJING has tightened COVID-19 control measures as newly confirmed cases by local transmission have been reported in the past few days in the capital.

The city reported six new domestically transmitted COVID-19 cases for Friday after one case had been reported Thursday, according to the municipal government.

Given the new cases, the city has suspended a major wholesale food and vegetable market and strengthened control measures to resolutely contain the spread of the epidemic.

NEW CASES

Two confirmed cases, both employees of the China Meat Food Research Center in Fengtai District, were reported earlier Friday, and another four were reported between 4 p.m. and midnight Friday, according to a press conference held Saturday morning.

The latest four new cases either purchased goods or worked at the Xinfadi market.

All the new cases have been transferred to designated hospitals in the capital city for treatment, said Pang Xinghuo, deputy director of the Beijing Center for Disease Control and Prevention, at the press conference.

The newly reported cases came after Beijing lowered its emergency response to COVID-19 from the second level posture to the third level on June 6.

Professor Cheng Feng with the Research Center for Public Health at Tsinghua University said people should keep high alert against the occurrence of sporadic cases, but there is no need to panic.

MARKET SUSPENDED

As the new COVID-19 cases were all connected to Xinfadi, the largest wholesale market with fruit, vegetable and meat supplies for Beijing, the market was suspended Satur-

To ensure the market supply, special areas have been designated for sales of vegetables and fruits, according to a statement jointly issued early Saturday by the market

regulation bureau and the health commission of Fengtai District.

Covering an area of 112 hectares, the Xinfadi market has some 1,500 management personnel and more than 4,000 tenants.

All personnel who have had close contact with the market since May 30 will undergo nucleic acid testing, said Gao Xiaojun, a spokesman for the Beijing Municipal Health Commission, Saturday.

According to Gao, the city now has 98 qualified institutions for nucleic acid testing, with the daily test-

ing capacity exceeding 90,000.

Chen Yankai, deputy head of the Beijing Municipal Bureau of Market Regulation, said the city will strengthen inspection of food markets with fresh products, frozen pork, beef, mutton and poultry.

MASSIVE SCREENING

Following the reports of new COVID-19 cases, disease control and prevention staff conducted nucleic acid tests on 1,940 people in the city's wholesale farm produce markets and supermarkets Friday.

Forty-six of them tested positive for

COVID-19.

Of the 517 samples collected from Xinfadi market, 45 were found positive in throat swab tests. Another positive case was from a farm produce market in Haidian District, who was a close contact of a confirmed case in Xinfadi, Pang said at the press conference Saturday.

All the 46 people have shown no symptoms, and they are under strict management and observa-

Meanwhile, Beijing's centers for disease control and prevention at municipal and district levels have organized professionals to carry out investigations in wholesale markets of farm produce and large supermarkets throughout the city.

Positive nucleic acid tests were reported from the external environmental specimens related to the confirmed cases. Preliminary findings suggest these cases may have been in contact with a polluted site in the market or infected people, said Pang.

Putin says US riots show deep crisis in the country

MOSCOW

THE riots in the United States show deep internal crises in this country, Russian President Vladimir Putin said in an interview with "Moscow. Kremlin. Putin" posted on Instagram page of the program's host Pavel Zarubin yesterday.



"What has happened [in the US] is the manifestation of some deep domestic crises," the head of state said, noting that this crisis had been observed for a long time since US President Donald Trump assumed office. "When he won, and his victory was absolutely obvious and democratic, the defeated party invented all sort of bogus stories just to call into question his legitimacy," Putin explained.

The Russian leader noted that he usually tries to "comment carefully or not to comment at all what is happening in other countries."

Putin also said that the key problem of the US political system is the fact that parties place their interests above those of people.

"It seems to me that the problem is that group party interests in this case are placed above the interests of the entire society and the interests of people," the Russian leader said commenting on the events in the United States.

The interview was recorded in the Kremlin during the conversation with the journalist, not in the format of a video conference.

Mass protests and riots sparked in many US states following the death of African American George Floyd. He died in hospital after a police officer used a choke hold during his arrest in Minneapolis, Minnesota, on May 25.

All four involved police officers were fired and charged. The National Guard joined local police in an effort to combat the riots. A curfew was introduced in nearly 40 cities,

More needs to be done to spur Africa's integration - report

ADDIS ABABA

A NEW report jointly published by the United Nations and the African Union (AU) has emphasized that there is much work to be done to spur Africa's integration, so as to enable the continent withstand socioeconomic shocks, such as the ongoing COVID-19 pandemic.

The second Africa Regional Integration Index (ARII 2019) was recently launched by the Economic Commission for Africa (ECA), the African Union Commission, and the African Development Bank (AfDB) with a call to act to to deepen African integration.

The report, among other things, found that "much more needs to be done to integrate regional economies to make them more resilient to shocks such as the current COVID-19 pandemic."

The 2019 index, which builds on the first edition published in 2016, provided up-to-date data on the status and

progress of regional integration in Africa. It also helps to assess the level of integration for every re-

gional economic community and their member countries. The continental integration index showed that the level of integration on the continent is relatively low with an average score of 0.327 out of 1.

The ARII report complements the African Multidimensional Regional Integration Index, which was developed over the last two years by the AU Commission, regional economic communities, national statistics offices and African Central Banks. With the establishment of regional economic communities and the creation of the Africa Continental Free Trade Area Agreement (AfCFTA),

Africa has reinforced regional integration as a major development priority for the continent under the 2012 Boosting Intra-African Trade (BIAT) Action Plan.

The Index also ranked African countries' integration within their respective regional economic communities and also with the rest of the continent.

It also scores across five key dimensions that are trade, productive capacity, macroeconomic policy, infrastructure, and free movement of people. The ARII-2019 ranked South Africa, Kenya and Rwanda as the top three most integrated countries on the continent, while South Sudan, Eritrea and Burundi were ranked as the least integrated African coun-

"Whereas the latest edition has data cut off points in 2019, the present COVID-19 pandemic has reopened the question of whether enough is being done in advancing regional integration as a means to help Africa withstand systematic shocks such as the one being experienced today," said Stephen Karingi, Regional Integration Division Director at the

Countries should shoulder responsibilities, promote solidarity, cooperation to fight Covid-19

US sanctions against ICC officials widely criticised

THE HAGUE

THE international community has bashed U.S. sanctions against some International Criminal Court (ICC) officials investigating possible war crimes committed by U.S. forces in Afghanistan.

The White House said Thursday that U.S. President Donald Trump has authorized economic sanctions against ICC officials "directly engaged with any effort to investigate or prosecute United States personnel without the consent of the United States," as well as the expansion of visa restrictions against these officials and their family members.

Later on Thursday, the ICC said in a statement that the U.S. attacks "constitute an escalation and an unacceptable attempt to interfere with the rule of law and the Court's judicial proceedings."

Noting that the U.S. sanctions represent "an attack against the interests of victims of atrocity crimes, for many

of whom the Court represents the last hope for justice," the ICC, which has 123 member states, vowed it would stand firmly by its staff and remain "unwavering in its commitment to discharging, independently and impartially, the mandate bestowed upon it by the Rome Statute and the States that are party to it."

The United Nations (UN) human rights office said Friday that it is deeply concerned over the United States' planned sanctions.

"The independence of the ICC and its ability to operate without interference must be guaranteed so that it can decide matters without any improper influence, inducement, pressures, threats or interference, direct or indirect, from any quarter or for any reasons," Rupert Colville, spokesperson for the UN High Commissioner for Human Rights, told a

tional humanitarian law and their families have the right to redress and the truth," he added.

The German Foreign Ministry on Friday expressed its deep concern over the U.S. decision."We have noted with great concern the U.S. statement that gives some cases, to introduce additional visa restrictions and additional economic sanctions against officials of the International Criminal Court," the ministry said in a statement.

Noting Germany is one of the strongest supporters of the ICC, the ministry said: "We have full confidence in its work. It is an indispensable institution in the fight against impunity for international crimes, and it is needed today more than it has ever been."

"We reject any attempts to put pressure on the independent court, its staff, and those who work with it," the ministry stressed.

The French Foreign Ministry on Friday urged the United States to refrain from implementing measures targeting ICC officials. The U.S. decision "represents a serious attack on the Court and the States Parties to the Rome Statute, and beyond that, a challenge to multilateralism and judicial independence,"

French Foreign Minister Jean-Yves Le Drian said in a statement published on the ministry's website.

France reiterated its full support for the court, which bashed the U.S. sanctions later on Thursday.

"The Court is the only permanent international criminal court with a universal vocation," Le Drian said.Noting the court plays a vital role in the fight against impunity for the perpetrators of the most serious crimes, Le Drian said "France will strive to ensure that the Court is able to fulfill its mission in an independent and impartial manner."

The ICC in March authorized an investigation into possible war crimes in Afghanistan, including those that may have been committed by the U.S. military and the Central Intelligence Agency, which could lead to the indictment of U.S. military and intelligence

A different graduation season: Chinese college students moves graduation online

THE 8.74 million college graduates in China are facing a different graduation season this year, as the COVID-19 epidemic is moving everything online, from graduation photo shooting, to job seeking, and to thesis defense.

To ensure on-time graduation, Chinese graduates must overcome a series of challenges. Meanwhile, they are gaining more experiences and growth. Facilitated by a slew of measures rolled out by both the country's education ministry and local governments, they feel the meticulous care from their schools and the society.

"We can still recognize ourselves in the photo, right?" Said Zhao Mengmeng, who's about to graduate from Central China Normal University (CCNU), pointing to a cartoon-version graduation photo created by an application in which she and her schoolmates were smiling brightly in "hand-painted" bachelor uniforms at the gate of their university.

Finishing the online graduation photo "shooting," Zhao came to the very end of her college life - to go back to the checkout.

As COVID-19 cases subsides in China, students from multiple universities in Wuhan, including the CCNU, are allowed to go back to schools in batches after June 8. They can live in the dorms after their health codes and nucleic acid test results are verified, and each room accommodates one student.

Zhao's thesis defense, interview of postgraduate entrance exam, as well as job interviews were all completed online. She spent most of her time during the past over four months in front of a computer. She said she had been worried before the online thesis defense, but it went very well. The "cloud thesis defense," in which teachers and students were separated by the screens, according to Zhao, were somewhat warm-

To help students better finish their theses, guarantee the quality of theses and defense. as well as ensure on-time commencement, the CCNU established an online thesis platform and opened multiple electronic data bases. So far, all of the university's 4,400 undergraduates

New oat varieties alleviating poverty in NW China's Wumeng Mountain range Brazil su

VERDANT winter oats are swaying with the wind under the blue sky in Daqiao township, Huize county of southwest China's Yunnan province, unfolding a picturesque scenery that indicates a bumper harvest.

According to experts, the county's 50,000 mu (3333.3 hectares) of winter oats are expected to yield 280 to 300 kilograms per mu, while the high-yield species 400 kilograms.

Dr. Xu Lijun, an oat expert coming to Huize from Beijing for technical guidance, was very glad to see the rolling fields. Since November 2017, she has made nearly 20 trips to the county.

"It was hard at the beginning. as it was not easy for the people here to accept the new oat varieties," she told People's Daily on the phone.

"They don't trust empty talks, so if you want them to accept, you must show them the results. That's what we must do in our efforts to reduce poverty through science and technology and let the people benefit from innovation," she added.

Huize county in the northeastern part of Yunnan Province has a mountainous landscape and a severe climate. With few arable land, the county is stricken by extreme poverty.

Chinese Academy of Engineering (CAE) designated to offer pair assistance for the county began to take actions. Wangbo, an official with the CAE, started working as the deputy head of the county

He set up platforms, invited to oats.

Oats are a traditional commercial crop in Huize county, but the yield was low due to the outdated varieties and inferior technologies. The maximum yield per mu stood at only 60 to 70 kilograms.

As it happened, Wang's wife Xu Lijun is an expert on oat, who

experts, and introduced technologies. After investigations and surveys, he shifted his attention

Xu came to the county in November 2017 for the first time. Under the joint efforts of multiple parties, the couple introduced more than 20 varieties of quality oats and started trial planting in Daqiao township and other places in the county in

As Huize county has more vacant fields and a suitable winter climate, the couple decided to grow winter oats there.

To reassure the farmers, Xu came to visit Huize county every winter. While she was busy working in the experimental fields, she offered technical guidance to the "pioneer" farmers.

In the spring of 2019, Yunnan was hit a severe drought

that led to five consecutive rainless months. Production of local crops, including the oats, dropped significantly, and some were even hit by total failure.

Fortunately, Xu's oats withstood the drought, and two varieties had a yield of over 300 kg

Amazed by the new varieties, more local farmers chose to plant them. With the support of the local government, Xu started offering training courses for farmers, in which she introduced new techniques and varieties to

Testing a new mode of farming, households in eight villages of Daqiao township saw their income increase by 9,000 yuan (\$1,271) on average last year.

Last winter, the new oat varieties were planted on more than 50,000 mu of farmland in 11 townships of the county. The 15,873 people from 4,755 impoverished households planted a total of 16,000 mu.

Brazil surpasses UK in virus deaths, now 2nd in world

BRASILIA / NEW YORK

BRAZIL surpassed the UK on Friday in the number of COVID-19 deaths, becoming the second deadliest epicenter in the world after the US. Data from the states showed 909 new deaths, bringing the total count to 41,828. The UK tally is 41,566. The number of infections rose by 25,982.

Latin America's largest nation and economy trails only the US in number of cases. The University of Washington's Institution for Health Metrics and Evaluation, which the Trump administration has relied on, projects Brazil will overtake the US in per-capita deaths by mid-July.

"The system as such from the data we see is not overwhelmed," the WHO's top emergencies expert Dr. Mike Ryan said, with few areas of Brazil using more than 80% of their hospitals' intensive care bed capacity.

A new study suggests infections in Brazil may be far more widespread than official data suggest. Researchers at the University of Pelotas in southern Brazil estimate six unreported cases for every one confirmed diagnosis across 120 cities studied The conclusion is based on tests and interviews with more than 31.000 people conducted June 4-7.

The Americas are bearing the brunt of the global coronavirus pandemic at present, the World Health Organization (WHO) said on Friday, with North and South America currently having four of the 10 worst hit countries in the

"The virus is actually starting and will wreak more havoc,' said Tedros. Most countries are in the throes of the first wave, and the risk of a second wave is present for any country exiting lockdowns, said Mike Ryan, head of the WHO's health emergencies program.

Ryan said he's concerned by the "upswing" in the Southern Hemisphere, and Tedros said the pandemic is accelerating in low- and middle-income countries. Ryan said there's no guarantee any vaccine will arrive in time.

US cases increased by 20,574 from the same time Thursday to 2.03 million, according to data collected by Johns Hopkins University and Bloomberg News. The 1% increase was lower than the average daily increase of 1.1% the past seven

UK government urged to revise social distancing rule to help pubs survive

PUBS and bars in England may be able to reopen in early July amid the British government's efforts to ease the lockdown, but "further safer working guidance" for these businesses has vet to be announced.

So as to help the industry survive the COVID-19 pandemic, pubs and associations in Britain are calling on the government to review and revise the 2-meter guideline for social distancing.

EXTREMELY DIFFICULT TO REOPEN

"The industry has been given

a target for the earliest possible date for the reopening of pubs. But sadly, if no reduction (on social distancing measures) is made before that, this could result in devastating pub closures and job losses in communities," Emma McClarkin, chief executive of British Beer & Pub Association (BBPA) told Xinhua in an exclusive interview..

According to the figures released by the BBPA, leading trade association representing brewers and pubs, the current social distancing rule means that only about a third of Eng-

a glimmer of hope with July 4 as land's pubs will be able to reopen.McClarkin said the BBPA were hoping that pubs could reach that target date and were working closely with the government in order to ensure a safe environment for the pub staff and customers, but there were still major challenges.

"The biggest challenge we face right now, as a social environment that we have inside our pubs, is social distancing measures," she said, noting the current 2-meter rule in the country will be "extremely difficult" for pubs to operate."No two pubs are the same, it's why we love the great British pub -- it's full of character: nooks, crannies, small pinch-points which will make it extremely difficult for some of our pubs to operate under (the rule of) 2 meters," said

She told Xinhua that the industry had been calling for the government to adopt the World Health Organization (WHO) guidance, which recommends keeping at least 1-meter social distancing.

According to BBPA's estimations, it would allow around 75 percent of England's pubs to be able to reopen, and "would re-

ally get the pub economy going again", if the social distancing measures could be reduced to 1

Some countries including China adopt the 1-meter rule but face masks are mandatory in public places, while some other countries including Germany and Italy have a 1.5 meter rule. But Britain, along with Canada and Spain, insists that people should keep 2 meters apart.

STRUGGLING TO SURVIVE

The BBPA said it's not too late for the government to review and revise its guidance, citing

that insisting the current social distancing measures could have a severe impact on the industry.

The association released findings Thursday that overall sales of beer in the first quarter of 2020 were down by 7.2 percent year-on-year to 1.5 billion pints, the lowest level since the record began two decades ago, as the industry is facing the biggest crisis ever.

"The pandemic has been devastating for the British pub sector. We are really finding it extremely difficult to survive during this time. We've had some government support, but

some pubs have been in receipt of no grants at all," McClarkin told Xinhua.

"We have closed our doors to play our part against coronavirus but now we need to find a pathway to reopening so that we don't lose the great British pub forever," she said.

The BBPA recently ran a poll of their members -- which include pubs and breweries -- to see how many of them would be able to survive the lockdown. It shows only 40 percent of their members would be unable to survive until September, unless government helps them. **Xinhua**

Colonial spectators in bushes and temporary tents off course

FORT WORTH. Texas

MAX Butcher and his buddies felt as if they had front-row seats at Colonial, even in the bushes with no spectators allowed on the course.

The group of five recent graduates from nearby TCU stood in a small gap between a row of shrubbery and a chain-link fence Saturday. They had a view of the fourth and fifth holes during the third round of the PGA Tour's first tournament in three months.

"This is as good as it gets right now, and I can't complain," said Butcher, who has been in that spot multiple days this week.

They had to push through gaps in the bushes to get to there but Jack Kurz, who stood next to Butcher, said the close-up view made it "almost better than getting a ticket."

There were no tickets for anyone, not even for Colonial members. The PGA Tour isn't allowing spectators the first month back after the long hiatus because of the COVID-19 pandemic.

Some of those members did have obstructed views from one of three temporary viewing areas set up in the yards of homes on the edge of the course. One was along the main road that leads to the clubhouse, and two others were near the 15th and 16th holes.

One member watching Saturday from a raised tent across Colonial Parkway with partial views of parts of the second, third and fourth holes. called it "bittersweet."

The member, who didn't want to give his name, wasn't happy to be on the outside looking in, but was glad the tournament was being played three weeks after it was originally scheduled. He said others with him felt the same way. Held since 1946, Colonial is the longest-running PGA Tour event at the same venue.

Cheers from a temporary grandstand erected in a backyard near the 16th tee box could be heard at the far end of the golf course. Nearby in another yard was another raised tent dubbed "Mockingbird Deck" - after the street name.

When Corey Conners hit an approach to about 5 feet at No. 15 in the second round, he got quite a reaction from those outside spectators who could see it.

"Yeah, it was pretty cool," Conners said. "I know we're used to getting applause and whatnot, and cheers when we hit good shots. So yeah, that felt nice. It was definitely different because that's not happening really anywhere else on the golf course. So it put a smile on my face for sure."

Jordan Spieth noticed people peeking through the fence by the No. 1 green and behind the second tee, where some rode up on their bikes. The Dallas native who attended the Colonial at times growing up was asked if he would ever try to sneak on a course.

"I wouldn't try and sneak on. I don't think that's going to go well for you," Spieth said. "But certainly try and get a view."

One man did get through the fence in a corner near those bushes beyond the fourth green Friday and watched some golf before he was forced to leave.

Everyone stayed outside the fence there Saturday, with Butcher and his buddies among about a dozen spectators watching the holes that are part of Colonial's "Horrible Horseshoe" - including that long par-3 fourth hole and the difficult No. 5 hole that runs parallel to the Trinity River. The TCU grads were directly behind the fifth tee box, only a few feet from the players.

"They definitely give us a reaction, they definitely are willing to talk to us and they like having us here even though you can't have fans on the course right now," said Butcher, who had a ball tossed to him Friday from Sebatian Munoz, the No. 9 player in the world.

Chris Zelda, standing in the shade not far from that group, has lived in Fort Worth for 33 years and has been going to the Colonial that whole time. He missed only one day in his unusual viewing spot this week, and planned to be there again Sunday to watch all the groups go by before going home to watch the rest on television.

"Under the circumstances, I'm not disappointed at all. I think the way that this whole thing has been handled has been great," he said. "I'm just glad these guys came, and I think they were ready to come and I think there's people who were ready to come out and see it."



US Open faces D-day amid player uncertainty

THE fate of the US Open is set to be revealed this week when officials decide whether or not the tournament can go ahead as planned amid mounting unease among top players.

The deadly COVID-19 pandemic, which has decimated the international tennis calendar, now has the Flushing Meadows fortnight in its crosshairs.

With New York the hardest-hit city by the US coronavirus crisis, the United States Tennis Association has been scrambling to come up with a plan that allows the tournament to be staged.

But with the French Open postponed to a September 20 start, Wimbledon cancelled and the tennis season in shutdown, the US Open's status has looked increasingly questionable as its August 31 start date looms ever closer.

After considering and reportedly discarding the idea of moving the tournament to either California or Florida, the USTA has settled on staging the event in New York inside a protective "bubble", possibly without fans.

Under safety protocols proposed for the tournament, players would be confined to a hotel outside of Manhattan and would only be allowed to bring one member of their entourage to the event.

Singles qualifying would be eliminated while the doubles tournaments would be drastically reduced from 64 pairings to just 24. The ATP/WTA Cincinnati Masters

event could also be shifted to New York as a lead-in tournament.

"This is the world we are living in," USTA's director of player relations Eric Butorac told ATP and WTA players during a conference call on

"We believe this is a good plan and believe it is good for the sport. It's good for the tennis economy, creates jobs for you, for coaches, for commentators, for so many people.

"And most importantly, this plan keeps you safe.'

So far, however, those words of reassurance have failed to quell unease amongst some of the international tennis circuit's biggest names.

World number one Novak Djokovic said the proposed safety measures

Yet Djokovic's reservations have not won over some of tennis's rank and file. American women's singles player Danielle Collins lambasted Djokovic's public statements about the proposed limits on support staff.

"This is a massive opportunity for players to start making money again, and here we have the top player in the world saying only being able to bring one person with (him) will be too difficult," Collins

"It's easy when someone has made \$150 million throughout their career to try and tell people what to do with their money, and then turn down playing in the US Open," Collins added.

Whatever the USTA decides, the organization, which last week laid off more than 100 employees, is coming to terms with what will be another massive financial hit to revenues, which have already been "shattered" according to

association president Patrick Galbraith. Last year, an estimated \$400 million of the USTA's financial revenues of \$485 million were generated by its flagship tournament, with a large chunk of that money coming from sponsors and people attending US Open matches.

Like other sports competitions getting going again, strict health protocols mean games in Spain are being played behind closed doors, ensuring unusual atmospheres at matches that would otherwise go ahead in front of large crowds like the derby between Valencia and

- The new matchday experience

Without access to stadiums, supporters are still coming together to watch games. However, only a limited number of Barcelona fans could access this supporters' club in the Catalan capital to watch their team's game against Mallorca.

Spaced out to respect social distancing measures, and wearing face masks, they took in Barca's win which allowed the defending champions to extend their lead at the top of the table.

Premier League's international appeal faces coronavirus test

mier League football comes to an coronavirus pandemic. end on Wednesday, the anticipation will be felt as keenly in Mumbai and league's restart more than Liverpool Beijing as in Manchester and Birmingham.

The global reach of the English topflight has helped secure its position as the wealthiest league in world football.

The Premier League's overseas television rights deals for the 2019-2022 three-season cycle hit a record £4.2 billion (\$5.3 billion) and another £2 billion deal has already been struck for Scandinavian rights between 2022 and 2028.

That income will be all the more welcome, with uncertainty over when supporters will be allowed back into stadiums and commercial revenues expected to tumble in a global economic crisis.

However, without the atmosphere generated by baying fans, the Premier League's appeal may be diminished in football's new normal.

"What makes it special in England is the way people react to the game," former Arsenal manager and FIFA's chief of global football development Arsene Wenger told The Athletic.

"It is the best country in the world for the way the fans respond to what's happening on the pitch. That's why I think it will be the most handicapped championship without that."

- Reschedule rebate -

The need to cram the remaining 92 games of the season into a five-and-ahalf week window also means many more midweek games with evening kick-offs in England, forcing fans in the Far East to tune in during the early

However, the excitement over the Premier League's return endures, particularly among the huge number of Liverpool fans, many of whom are awaiting a first league title in their

How will the summer transfer market work after coronavirus?

WITH the coronavirus pandemic pushing back the start of the 2020-21 season until September, there are major changes to the transfer window as the current campaign runs into August.

The window was due to open in most leagues on July 1 and end on Aug. 31. So how will it work? And when will it close? FIFA has produced a lengthy document of temporary measures to cover issues arising from COVID-19.

It is important to note that these are guidelines for specific situations and each individual association will not apply all measures. Here, we run through what it all means.

When will the summer transfer window officially open?

Right now, we don't really know. It will be different across leagues and it is expected to open when the season finishes in each individual country.

That said, FIFA is allowing associations to open their window up to four weeks before the end of the 2019-20 campaign -- though no major league has said it is considering this and FIFA states any player signed during this period will not be eligible to play until 2020-21. The extension allows a country to have a longer window when the gap between seasons is short, and as the wheels in the market move finances can circulate around clubs who need

France, which saw its season curtailed due to the coronavirus, has already opened its domestic window to help Ligue 1 clubs fill the financial void created by the pandemic, and give players the chance to find new clubs. However, the international transfer market remains closed for now. It is up to associations what kind of transfers it allows during its active window periods.

Similar is expected to be confirmed in the Bundesliga, with the season due to complete with the DFB Pokal final on July 4.

Premier League chief executive Richard Masters has stated the window will not open until after the season finishes on July 26. La Liga present Javier Tebas said he expects the window to open at the end of July aligned with other leagues (its season ends on the weekend of July 18-19).

But Serie A has already announced its transfer window will only open on Sept. 1, with the end of the 2019-20 season technically set as Aug. 31. However, we are likely to see many deals being announced in advance once the Italian top-flight season concludes on Aug. 2.

How long will the transfer window last?

FIFA says it can be no longer than 12 weeks, noting that leagues that have had "all or part of an open registration period directly impacted by COVID-19" can request to move the window to new dates during the same season -- which is what we will see in England, Italy and Spain.

The summer window could also be split into two parts of no more than 12 weeks -- so perhaps six weeks starting now, and another six weeks to align with other leagues. However, one condition of this is the first registration period must not have opened. So with Ligue 1 opening its transfer window on June 8, this indicates it must still close by Sept. 1 -- unless the official request had already been lodged and it can argue its registration period has been directly impacted.

At present, no other major European league has officially changed its transfer window dates, as set out in the worldwide registration calendar.

So when will the transfer window actually close? Italy's window will close on Monday, Oct. 5, and it is likely most leagues will fall roughly in line with this. Deadlines between Sept. 30 and Oct. 5 have been mooted for European leagues, with Friday, Oct. 2 mentioned by Tebas for Spain, and also in Germany.

This date is significant as it follows the usual process of a transfer deadline around two weeks before the Champions League begins. The 2020-21 group stage is pencilled in to start on Tuesday, Oct.

With a 12-week transfer window, leagues could open around July 10 (subject to when a season ends) and close on Oct. 2.

When will clubs complete signings?

Clubs can already agree deals to sign players -- for next season. For instance, on July 1 Hakim Ziyech will move from Ajax Amsterdam to Chelsea for €44 million. Also, Francisco Trincao had already agreed to join Barcelona from Braga in a €31m deal.

While FIFA cannot legally prevent deals being completed, it "strongly recommends that priority be given to the former club to complete its domestic season with its original squad." In the case of Trincao, it has been agreed he will stay with Braga until the Portuguese season finishes on July 26.

Can clubs sign any players to play this season? No. Even though the Dutch Eredivisie season was curtailed, which means Ziyech will become a

Chelsea player on July 1, he cannot be registered. This is also the case for any player who is out of contract on June 30. Free agents who are released at the end of the month, say from clubs in France, Germany or the Netherlands, can be signed but cannot play for their new club in July and August in the 2019-20 season. FIFA states that "the engagement of an out-of-contract player is permitted. The player



shall only be eligible to participate in domestic competitions for their new club

in the 2020/21 season." There is one provision that allows a player who is released as a result of COVID-19 to sign for a new club this season, but that player's contract must state "at the end of the season" with no specific reference to any date, which is not how contracts in the major leagues work.

What about players out of contract

or on loan? FIFA has made "recommendations regarding the extension of expiring agreements and delay of new agreements," namely that players should stay with the club that are at now until the 2019-20 season is complete. The same goes for players who are out on loan.

However, that is only a guideline and FIFA admits it is "has no authority ... to unilaterally amend the terms and conditions of [employment] agreements.," so it would need the player and both clubs to accept.

It means some players may return to their parent club on July 1 when the loan agreement expires, and others may not agree to play on for their club if their contract expires on June 30. FIFA has no control over this. For instance, Adam Lallana will continue to play for Liverpool beyond his contract expiry but Nathaniel Clyne will leave Anfield.

There's also the example of William he should not officially move to Saliba, who was on loan at Saint-Etienne from Arsenal. With the Ligue 1 season curtailed he will return to the Emirates. FIFA has created a provision whereby such players can be re-registered with their parent club. .

However, FIFA stresses that registration is "distinct from eligibility to be fielded in matches" and that each national association should "ensure that the sporting integrity of its domestic competitions is preserved." As such, returning loan players would only be allowed to be registered in exceptional circumstances. The Premier League has indicated Saliba will not be able to play for

This also applies to players returning to Premier League clubs from loans in

League One and League Two. Players on loan at Championship clubs who do not have agreements extended into July cannot be re-registered at their parent club.

What about players in the Champions League and Europa League?

The plan is for both tournaments to play out through August, but players will remain with their current clubs and see out the season. Even if Chelsea complete a move for Timo Werner from RB Leipzig, who are in the quarterfinals of the Champions League, FIFA advises

Stamford Bridge until the German club's engagements in Europe are over. Again, technically Chelsea could force the move through if the English transfer window were open but he could not play for the Blues. Players will also not be able to make signings to play in Europe in August.


Has anything else changed?

Yes. Usually players can only play for two clubs in one "season" -- and a season begins in July. FIFA has temporarily changed this to three to account for a player who has played for another club in July and August to finish the 2019-20 campaign.

As an example, Trincao could play for Braga in July, Barcelona in the first half of the 2020-21 and then go on loan to another club in January. But Zivech could not play for Chelsea in the first half of the new season, be sold to another club at the start of January, and move again at the end of January.

It also means a player can finish the 2019-20 season on loan at one club, play for their parent club in the first half of 2020-21, and then move to another team in January. An example here would be Dean Henderson of Manchester United, who is on loan at Sheffield United. He could play for the Blades, then for United at the start of next season before going out on a new loan for the second half.

TOC keen on nurturing competent athletes

TANZANIA Olympic Committee (TOC) has said it is fully committed to seeing to it the country produces athletes who can compete and win medals at international events.

The committee's secretary general Filbert Bayi issued the statement at a meeting the committee jointly hosted with National Sports Council (NSC) and Athletics Tanzania (AT) with the aim of supporting the local athletics body to successfully host the National Championships in August.

He said TOC understands the challenges AT faces and the committee will help the latter financially so as the championships, slated for August 15-16 at the National Stadium in Dar es Salaam, is held successfully.

Bayi challenged all regions, which will battle it out in the showdown, to select athletes who can compete in it, not simply make up numbers.

"We will help AT to successfully host the National Championships, we are doing this because we know that the showpiece is a platform where upcoming athletes are indentified, it's the event which helps coaches identify athletes for the national team," Bayi stated.

"We are asking regional athletics committees to select good athletes who will come here to compete not to participate," he said.

The TOC top official said depending on the availability of resources, after athletics, the committee will

support boxing, then other sporting codes will follow. Henry Tandau, TOC vice-president, said the move is to help the country identify athletes from various parts of the country, who can be drafted into the na-

Tandau stated the country has many athletes but they lack exposure and platform.

"I'm asking AT to make sure that all regions are hosting athletics championships and only qualified athletes are selected for teams which will represent the particular regions at National Championships," he

"The National Championships is the platform where athletes who can represent our country at international events are identified," he said.

Leodegar Tenga, NSC chairman, also said they are ready to support AT so that the National Championships is held successfully.

"The National Championships is the event which attracts cream of athletes from all regions in the country, our aim is to see to it that the country is doing well in sports," he disclosed.

"We will help AT so that the National Championships is held successfully for the country to have many athletes who can compete at international events and win medals for our nation," he said.

Tenga also hailed TOC for the move, saying it has come at a good time when the nation is looking forward to its athletes to win medals.
