Dar, Lusaka solve a third of thorny trade disputes

ANZANIA and Zambia have resolved eight out of 24 business challenges while the remaining 16 may be sorted out before the year ends, the government has stated.

Dr. Hashil Abdallah, the Industry and Trade permanent secretary told journalists at the border town of Tunduma following a twoday joint meeting with his Zambian counterpart Lillian Bwalya that the talks related to trade challenges.

Removing those challenges will decongest trucks at the Tunduma One Stop Border Post (OSBP), he said,

The two countries agreed that products exported from Tanzania through Zambia to other countries with all the necessary permits should be allowed to pass to the respective countries, he said.

Those transporting products and bearing the relevant permits should not be restricted, taking into account trade agreements under the World Trade Organization (WTO) and the Southern African Development Community (SADC) accords, he said.

Public institutions involved in the provi-

sion of services to traders of inter-country transport services need to ensure that they help traders to solve challenges relating to permits, regulations and procedures, he


He urged transporters to ensure that they get the relevant permits before starting the journey to ease transportation of the goods without restrictions and deliver them to the respective countries on time.

The government has agreed to review the railway development charge to conform to the SADC Trade Protocol, he said, elaborating that the government will conduct a review of transport regulations for conformity with tripartite transport regulations applicable in a specific trade area, he said.

Lillian Bwalya, the Commerce, Trade, and Industry permanent secretary for Zambia said the country has agreed to solve the challenges to promote cross-border trade.

Zambia has agreed to improve infrastructure challenges, envisaging road expansion and obtaining permits before arriving at the border to improve the flow of vehicles and

'Step up efforts to export only processed cashews'

VICE President Dr Philip Mpango has called on the Ministry of Agriculture to achieve the goal set by the government to stop selling raw cashews abroad by 2026.

He issued this appeal yesterday when opening the three-day Tanzania International Cashew Conference (TICC) in Dar es Salaam, with more than 500 stakeholders from 33 countries farming or consuming cashews, to promote investment opportunities in the cashewnuts value

Selling unprocessed cashews reduces jobs at the local level, cuts foreign exchange earnings, he said, also pointing at the need to broaden the market for kernels.

He also pointed at the need to push local consumption of cashewnuts and its by-products like

African countries need to strive to reduce consumer prices of cashews in order to promote increased use of cashews and derivatives from the crop nationally and regionally

jam, juice, cashew milk, wine, industrial ethanol, and cashew apple meat.


It is important for the meeting to discuss and share experiences on how to strengthen extension services and provide inputs on time to increase the production of cashews.

The VP asked the participants in the meeting to discuss the ways to access markets of cashew crops on an equitable value chain, pointing at fraud between buyers, transporters and brokers.

This is confirmed by the small number of buyers at auctions showing sufficient knowledge about market prices, undercutting cashew farmers having little market information, he stated, affirming that this causes cashew farmers to be laden with unfair prices.

He appealed for investments in the cashew

DC stops court order to 'demolish houses'

They are now telling us to move while they denied that we were part of the case in the first place

MBEYA Urban district commissioner Beno Malisa has stopped the cutting down of trees and demolition of houses by military and police carrying out court order.

In a press conference, he said that he had to stop that exercise so that a solution is found before the conflict turns deadly.

He said what he saw in the area is that residents have failed in the case. "They are now seeking dialogue with the owner of the land so that they reach a consensus," he specified, while residents talked of being in the process of filing an appeal.

Police had earlier used tear gas and shot in the air to disperse residents of Gombe Street, Itezi Ward in Mbeya Region seeking to prevent city 'militia' from enforcing a court order to demolish their homes.

The residents are immersed in a land wrangle lasting 15 years with S.H. Amon, an entrepreneur, arbitrated by the Land Division of the High Court at the Mbeya registry.

The court recently ruled against the residents, decreeing that houses and other struc-

Minister: Shifting unruly servants causes problems

TRANSFERRING underperforming or badly behaving civil servants from one institution or department to another is doing more harm than good to public service and the country's economy, a top administrator has declared.

George Simbachawene, the Policy, Parliamentary Affairs, Labour,

Employment, Youth and the Disabled state minister in the Prime Minister's Office (PMO) made this affirmation working session for human resource managers and heads of government departments here yesterday.

"Moving a problem from one area to another is not the solution but rather spreading delinquency," he said, noting that when a civil servant misbehaves they have to be punished on the spot.

With about 600,000 public serv-nites conflicts at workplaces. ants, the government has so far approved the promotion of 120,210 workers in addition to approving salary increments to each of them, he said in earlier remarks.

He also expressed dissatisfaction with heads of institutions and departments who mistreat workers and promote individuals on the basis of personal interests, asserting that it stifles development, demoralizes other public servants and ig-

"The yardstick for public service is public interest not personal interest," he reiterated, insisting that when it comes to serving the public, human resources are a vital compo-

"We must take care of our human resources, develop the workers," he emphasised, arguing that it is the responsibility of human resource officers and managers to protect employees in any institution.

Jane Kajiru, the Speaker's Office director of administration and human resources management, said that participants will be introduced to the deployment of information and communication technology (ICT) to ease or speed up services.

People travel long distances seeking services from public offices but with the adoption of e-government, most public offices can be reached from wherever the client happen to be, she added.

INDIA has agreed to purchase pigeon peas amounting to an average 200,000 tonnes in the coming three years bringing new hope to Tanzanian farmers.

Hussein Bashe, minister for Agriculture who was part of the just-conclude President Samia Suluhu Hassan's state visit in India said: "Although India is a big customer of pigeon peas, the market was unpredictable with ups and downs, but with this agreement, the farmers of peas will be sure of the mar-

"Currently, the price of peas is an average of one US dollar per kilo. At that price, we are talking about a business ready to do the job.

Another agricultural area that Bashe said Tanzania will benefit from is that of agricultural tractors where the Mahindra Company has agreed to build a tractor assembly factory that will be able to produce up to 2,000 tractors

Israel pounding Gaza as death tolls on both sides rise sharply

The death toll from five days of ferocious fighting between Hamas and Israel rose sharply overnight as Israel kept up its bombardment of Gaza yesterday after recovering the dead from the last communities near the border where Palestinian militants had been holed up.

In Israel, the death toll from Saturday's shock cross-border assault by Hamas militants rose to 1,200, making it the deadliest attack in the country's 75-year history, while Gaza officials reported more than 900 people killed as Israel pounded the territory with air

Hamas said two of its top officials had been killed, while Israel's military said the bodies of roughly 1,500 Hamas infiltrators had been found

Prime Minister Benjamin Netanyahu has warned Israel's military response to Saturday's attack is only the start of a sustained war to destroy the Islamist

group and "change the Middle East". Fears of a regional conflagration have surged ahead of an expected Israeli ground incursion into Gaza.

At least 30 people were killed and

hundreds wounded as Israel pounded the Gaza Strip with hundreds of air strikes overnight, a Hamas government official said yesterday.

The strikes destroyed several buildings of the Hamas-linked Islamic University in Gaza City, a university official

The Israeli military confirmed it had hit dozens of Hamas targets during the night. It said fighter jets destroyed "advanced detection systems" that Hamas used to spot military aircraft.

They also hit 80 Hamas targets in the Beit Hanoun area of the northeastern Gaza Strip, including two bank branches used by the Islamist group to "fund terrorism" in the enclave, the military

In response to Saturday's attack, Israel imposed a "total siege" on Gaza, suspending supplies of food, water, electricity and fuel to the already blockaded enclave.

Dodoma records 4 pc decrease in mental illness cases in 2 years

CASES of mental health disorders in Dodoma Region has decreased from 35 per cent to 31 per cent between 2020 and 2022, according to statistics.

Acting Dodoma Regional Medical Officer (RMO), Dr Nelson Bukuru made the revelation in his address during this year's World Mental Health Day, held in Dodoma on Tuesday.

Mental illness, also called mental health disorders, refers to a wide range of mental health conditions disorders that affect your mood, thinking and behaviour. Examples of mental illness include depression, anxiety disorders, schizophrenia, eating disorders and addictive behav-

He said the development has been the Mirembe Mental Health National propelled by a substantial increase of the relevant health workers and the experts at the Dodoma-based Mirembe Mental Health National Hospital (MNHMH).

Dr Bukuru added that there's a potential increase in the rolling out of key awareness towards the public over how best to cheat the 'disturbing' mental health disorder.

He however noted that Dodoma leads by having a larger number of the epilepsy patients than any part of the country

"Currently, Dodoma has 19,000 epilepsy patients, equivalent to 79 per cent of the population that have been affected by the seizure disorder illness across the country," he stated.

Deputy Health Minister, Dr Godwin Mollel challenged health workers at Hospital to work diligently and dispense the right therapies to the patients of mental illness.

Dr Mollel urged the health workers to be vigilant at identifying the patients at different stages of the mental disorders and service them accord-

"The government will continue to equip the hospital (Mirembe) with the needed modern equipment and medicines in order to allow the facility to heighten its service delivery since it receives the patients with mental health complications from across the

country," the minister informed. Acting Permanent Secretary in the Ministry of Health, Dr Saitore Laizer expressed that the ministry will stand at the forefront to scale up campaigns on public awareness in order to fur-

ther educate the citizens around the country over how to refrain from the diseases.

The 2019 data from the World Health Organisation (WHO), one in every eight people in the world has mental health issues, whereby in Tanzania, five out of 100,000 people have committed suicide out of mental health problems such as anxiety, depression, anger and drug abuse in the last five years, statistics have shown.

According to health experts, there are different forms of mental illness, including mood disorders (such as depression or bipolar disorder) anxiety disorders, personality disorders, psychotic disorders (such as schizophrenia), eating disorders, trauma-related disorders (such as post-traumatic stress disorder) as well as substance abuse disorders.

HPSS project ends with success of four - tier key components

THE Swiss government-funded Health Promotion and System Strengthening (HPSS) project has come to an end with the successful completion of its four-tier key components.

Funded by the Swiss government and implemented by the Swiss Tropical and Public Health Institute (Swiss TPH) played a key role in transforming the Community Health Fund (CHF) into a functional health insurance system, the "improved CHF" or "CHF Iliyoboreshwa" (iCHF).

The "Jazia Prime Vendor System" established a new channel for the government to procure medicine to quickly react to supply gaps. The project also strengthened the maintenance of medical equipment and worked on empowering communities to actively engage in health

HPSS embarked on its journey as a pilot project in Dodoma in 2011 before expanding to Morogoro and Shinyanga regions. From 2019 to 2023, HPSS rolled out its operations nationwide, covering all 26 regions of mainland Tanzania, with the goal of integrating innovative solutions into the national health system.

At the outset, the HPSS Project chatted a vision for its support to Tanzania to comprehensively address healthcare challenges at various levels and create sustainable improvements in Tanzania's healthcare landscape. HPSS has been among the very first champions of the health system strengthening approaches in

The project's primary commitment was to provide solutions for improving healthcare access, particularly for the most economically disadvantaged. "After an impressive 12-year journey of unwavering commitment to improving Tanzania's health system, the HPSS is now coming to an end, we are very proud be the very first government partner to introduce the health system strengthening approaches in the country that proves to be effective for systemic improvement of the health care delivery", said Ally Kebby, HPSS Project Manager.

"HPSS has made healthcare more accessible, affordable, and effective for all Tanzanians, regardless of their circumstances, and has had a major impact on improving people's health and wellbeing", he said.

The project's most notable achievements include a substantial increase in medicines availability through the Jazia Prime Vendor System program and the enrolment of over 4 million citizens in the affordable "CHF Iliyoboreshwa" insurance scheme.

HPSS project has been instrumental in elevating healthcare delivery in Tanzania through its integrated approach. It played a pivotal role in developing IT systems for managing medical equipment, health insurance, and medicine procurement. Additionally, the project introduced new training courses to bridge skill gaps among medical dispensers, biomedical engineers, and health promotion specialists.

Emmanuel Zongo, leader of the group told the reporter that the scheme was established as a means to encourage blood group identification and encourage society to donate blood to save the lives of people in need of blood.

motorcycles here, you will notice each has a tag with the name of the owner and his specific blood group. We came with this identification scheme because there are circumstances where one of us can crash and having the blood group ID on his bike makes it easier to identify the victim and get help from a Samaritan who matches the victim's blood group, he said.

"One of our members crashed into a lorry and we rush him to the hospital to save his life and eventually over time he fully recovered. That incident

"When you take a look at all these served as an important lesson to us that it is important to have a helmet and to identify each of our members' blood groups. That is when we started this scheme of having names and blood group tags on each member's motorcycle," he said.

He also pointed out that with the scheme they have been encouraging the habit of donating blood among community members, especially during their charity activities of helping communities in need.

The leader also cited that having such a union not only brings people of varying ages, experiences, and professions together but also serves as a means to advocate for safe and responsible motorcycle riding so as to limit accidents that may result in fatal lifetime injuries or casualties among

Taha Noordin, a member of the group said the practice of having blood group IDs patched on the motorcycles also serves the purpose of saving family members or individuals with close ties with one of the group members in case of an accident or sickness.

"Knowing one's blood group not only saves the group members but can also save their family members as well when the need arises. If someone falls sick and you know his/her blood group, it becomes easy to contact someone from the group and ask for help," said Noordin.

He also added that the purpose of the union is to unify motorcyclists from all walks of life and professions who have a zeal for riding performance and noncommercial motorcycles as means of engagement among men and women of varying professions, backgrounds, and nationalities as the group has members from Kenya, Uganda and beyond the African continent who are in Tanzania.

Tanesco announces countrywide campaign to remove all old meters

THE Tanzania Electricity Company (TANESCO), has announced a countrywide campaign to remove all old meters and install new modern meters for its customers as part of its strategies to improve services.

It has said that the exercise of changing the meters starting with numbers 04, 05 is expected to be completed at the beginning of next month and no one will be charged for changing the meter.

Irene Marobe, Tanesco acting communications manager revealed this yesterday in Dar es Salaam in an interview about the improvements made by the organisation to increase access to electricity.

Irene said the corporation has decided to remove all old meters and replace them with newer version adding they expect to change the system, the old meters will not be qualified to adopt the changes.

She said that is why the power utility firm has started a campaign to inform its customers who have such meters to provide information at the corporation's offices or call the customer care service numbers so that they can reach them and remove those

She said the company has information of its customers all over the country but the meters were the first and old version when LUKU's service started in 1996 about 27 years

"During that period, our customers were connected to electricity using a few information such as names and box numbers, phone number information was available to few due to the lack of telephone networks those days," said Irene and added: "During those days our memories were being stored in boxes, there were no technology to store customers information's in a modern way and the situation made difficult for the company to reach many customers," she said.

She said for customers who will not have their meters changed until the end of the campaign which is November 10 this year, the system will block them and they will not be able to buy electricity until they call Tanesco

connect customers to electricity digitally has brought great success as customers have been connected to electricity within three or four days when they file their application in that

he is connected to electricity without having to go to the Tanesco offices as was the case in the past.

"We all know that in the past, to get electricity connection was a problem, you had to fight to get electricity, but those things have become history now because people are excited about our digital services and they are requesting

Regarding customer care, Irene said that in the past, each region had its own emergency call numbers that brought challenges and the corporation decided to establish a single call center, which the whole country uses

Govt, multi-stakeholders' discourse towards abolishing the death penalty

MINISTER for Constitutional and Legal Affairs Ambassador Dr Pindi Chana has highlighted the need for human rights stakeholders to work out on the root course of ongoing killings taking place in the society and recommend to be incorporated in the laws as solutions

The minister said that yesterday in Dar es Salaam when officially opening the multi-stakeholders dialogue towards abolishing of the death penalty.

She said the statistics from the Office of Director of Public Prosecutions (DPP) showed that in 2021, a total of 3,155 murder cases were opened while in 2022 3,548 cases were opened.

alone a total 1,210 murder cases were opened; the situation according to her were still increasing.

"Despite of death penalty, yet the number of murder cases opened are increasing, therefore as a nation, there is a need to look for the root course of the ongoing problem," she said.

She said that the government is ready to work out on the recommendation from human rights stakeholders relating to the death penalty.

According to the minister, the doors are opened for all human rights stakeholders to submit their views relating to a death penalty.

In addition, the minister said that the government is currently reviewing some laws including those

Chana said up to June this year, stakeholders feel that are out of time and need to be reviewed.

TLS president Harold Sungusia called on the government to opt for an alternative decision of coming up with a special fund to support victims whose relatives were killed instead of

concentrating on criminal dealing. He said the government should also think of establishing alternative punishment and establish special

prisons that will be produced. "It is time for the government to come up with alternative punishment that will focus on changing the life of those punished in jail instead of

focusing on criminal issues," he said. He said history has shown that the country had not implemented death penalties for a number of years, therefore it was meaningless for the time being.

"We need to think the best ways if the death penalty can change the life or behaviour of the death penalty imprisonment," he said.

He said the death penalty is irreversible and courts can and actually make mistakes sometimes and there are chances of committing human errors that could see innocent people get executed.

Human rights stakeholders in the country have been pressuring the government to abolish the mandatory death penalty for reasons including violating the right to life which happens to be the most basic of all

human rights. Also it violates the right not to be subjected to torture and other cruel, inhumane or degrading treatment or punishment. Furthermore, the death penalty undermines human dignity which is inherent to every human

Reading culture has never been too high, and is waning further

IGH level opinion makes from academics, politics and the publishing L industry have from time to time lamented the poor reading culture that is apparent in various communities, and for cause. Yet for those with exposure of what people feel about reading in other countries, and indeed in advanced countries, is likely they will agree that a reading culture per se isn't true of any particular country. The reason is that despite variations of culture and tremendous differences in levels of education, we all belong to the same psychological framework of viewing life, etc.

That is what educationists in the country have been expressing a bit loudly of late, but happily from a few positive inputs into the reading culture, like the launching f a number of memorials by top leadership in the past few years. First it was second phase president Ali Hassan Mwinyi, then his successor Benjamin Mkapa and lately former prime minister and retired top diplomat of all time Dr Salim Ahmed Salim. In 1981 an MP asked President Nyerere to write memoirs before or after leaving office; he didn't.

Memoirs are difficult for statesmen to put across because they are supposed to be written in a frank and disarming manner, aware that all those issues are long gone and people can freely talk about them.

In reality that isn't the case as something that happened 50 years ago would touch a lot of people at the moment, if not those who were in public office, it can be those who are identified with them in life. That comes close to attacking the memory around them, so definitely it is to be

In that way, asking Tanzanians to inculcate a culture of reading books as they are always useful in improving one's perception of the reality around him or her, the bigger problem really is to write those books rather than finding people to read them.

There is always a good number of people to read a good story in a newspaper, pamphlet or book and the proof is the extent to which intolerant governments go to put up firewalls not just on radios or television but print media.

So the call by the Education minister to take up a culture of reading is definitely in right order as it may inspire some young people, or even adults, to rekindle their reading habits.

This is especially so in wishing to understand more of what they wish to do in life or are already doing, to widen their skills and perception of issues in the society. Fish maws price part of market practices, not a regulated product EPORTS are suggesting The union says the processors

that a fishermen's union on the shores of Lake Victoria is demanding that the government reviews current policy on Nile perch business. It seeks that a specific item in the fish produce as a whole, fish maws, be accorded different treatment and a pay schedule be set out for it by the government. The reason is the need for a win-win situations between fishermen and processors.

An online entry says that a fish maw - the swim bladder of a fish is one of the most expensive driedseafood products in the world. Seen as a Chinese delicacy, it can fetch \$450 to \$1,000 per kilogram and it is often viewed as a symbol of wealth and prosperity.

At times it is given out as gifts at important events and stockpiled as a speculative investment in foreign markets, and it questionable if fishermen can do that here as well. Thus there is a price gap between selling the fish and the maw.

Yet the issue is much less on the part of the government than on the fishermen themselves, whether they can actually separate the wider fish produce from the maw, and sell it differently. If it is possible then they can do it without having to be allowed by any regulator as fish produce is not regulated like fuel, and if they can't themselves do it, it is unlikely that the government can set up such facilities in order to alter the price of fish. It is really a question of private initiative and how far it is consonant with the market, if the other part of the produce would sell, etc.

benefiting immensely from the Nile perch business due to the maws in the product. The fishermen no longer want to sell whole fish to processors but wish that the maws are treated differently in pricing and policy -that ism for taxation purposes. Yet the government can't tax a produce and an element in it separately, unless someone starts a maws business and seeks a license.

Then the fish will be a raw material to him and there will be no tax on the raw material and how it is disposed, so long as environmental impact conditions are followed.

They say the government is losing revenues as it ought to tax the precious fishery products. Yet this suggestion fails the test of due procedure, as the maws are not countable and adding a tax on a product because of what it contains fails the test of due diligence and upsets the balance therein. The processors know very well what the fish products contains and pay for the fish which includes whatever special edibles it contains. The only maws can be taxed is if it is another business.

If as the union says, the processors get fillets from fish, plus maws, skins, oil and shells can each of these components be taxed alone? They say, just create two categories, for maws as they sell highly and then for fillets, which is clever but arbitrary.

The ball is in the .fishermen's court, to process the fish and sell items separately. They are selling raw materials to processors and get fish prices, period.



Abuse of Nigerian workers by foreigners

■HE plight of Nigerians working in some Asianowned companies operating in the country is worrying. Apparently because of the desperate drive of government for foreign investment and substantially because of the endemic corruption in the country that makes it possible for agencies saddled with monitoring the enforcement of labour laws to be compromised, these workplace abuses are perpetrated with impunity.

There are tales of how our citizens in these companies are forced to work under the most hazardous conditions as most of them are made to carry out dangerous tasks without protective equipment and requisite workplace safety measures. Some of these workers have even lost their lives or become permanently incapacitated in the course of carrying out assigned

In several cases, the affected workers or their next of kin receive

little or no compensation despite the fact that the accidents that led to their deaths or permanent injuries occurred at their places of work and in the course of carrying out assigned duties. Not only are the Nigerian workers in the employ of these companies subjected to inhuman treatments that could be described as modern day slavery, they are also made to work for long hours and paid ridiculous wages that literally cannot take them home.

Meanwhile, the Asian workers brought into the country, many of them with lesser qualifications and many with no work permits, are paid stupendous wages. There are also reports that some of these 'expatriates' are convicts brought in to work as part of their prison terms.

This is not only a breach of the extant labour laws, it is also a contravention of the Nigerian constitution.

Some of these companies are also reported to be in breach of provisions of existing labour laws especially with respect to perpetual casualisation of

some of their Nigerian employees, thereby denying them of job security and appropriate benefits such as health insurance and pension scheme.

General Secretary, the Federation of Informal Workers' Organisation of Nigeria (FIWON), Gbenga Komolafe, lays the problem on casualisation of workers in many sectors and the lack of protection for them.

"We ask that the laxity in labour law that legitimises them should be amended. We will continue to fight for union rights for all workers," said Komolafe. "All these are happening companies. because there is no labour protection. We can't organise them because they are not our members. It is part of the agenda of political reforms that workers get better representation in governance. All workers should have the basic protection of the union while on organised labour to play a key role at work." Unfortunately, the affected workers do not have the luxury of opting out of this enslavement because of the unprecedented level of unemployment in the country today.

They are left with the option of choosing between the devil - in this case, their employers - and the deep blue sea, which is the ever-expanding unemployment market. We strongly condemn these

inhuman and undignifying labour practices and call on government to urgently put an end to the violation of the rights of the Nigerian workers by ensuring compliance with extant labour laws. We believe no responsible government would allow its citizens to be subjected to such dehumanising treatment by foreign

While government may be driving for increased foreign investments, potential investors must be made to understand that we are a nation governed by laws and those laws must be respected at all times. We also call in putting an end to these practices by helping to identify those companies engaging in the abuse of Nigerian workers and reporting them to the appropriate authorities.

Of parents who believe that more notes means effective learning

VERY learner has unique strengths and weaknesses learning. One of the most important activities in the teaching and learning is note taking which serves as evidence that a teacher actually teaches.


Parents normally shout when they don't see writings in exercise books, assuming that their children were playing and not learning. "What is this school which doesn't teach?" most of them shout.

Knowing the importance of notes, teachers strive to make sure that at least in every lesson, there is something that can be noted down by learners. Should writing necessarily mean learning? No. But it is better they see what they want.

At universities, dictation (lecture method) dominates but in lower levels of education, the method cannot be applied due to a number of factors. One is lack of understanding of enough vocabularies. To most learners, especially those who work by force vocabularies, it is a challenge and when a teacher demands them to write what is dictated the struggle.

Another challenge to dictation is the speed of writing. The aim of dictation is always covering a lot of content in a short period of time. For some learners,





moving by the speed of dictation becomes a challenge, making them write incomplete notes. I remember one lecturer who would say "write what you can only read as the notes are for yourself and not any other person.'

For a university student, writing any way cannot be so challenging but for young learners, allowing them to write poorly is bad because notes are marked unlike in universities where assignments, tests and

examinations are what are marked.

When a teacher dictates while writing he or she may hear some learners encouraging the dictation. Those are the ones who are good at writing what they hear than looking on the board and write. Learners who keep quiet are the ones who are good at looking and writ-

It is well established that human beings are not perfect. A teacher applying some techniques in the teaching process may help to hide those weaknesses. For a good teacher, making sure that better results are obtained is a must. Making every learner enjoy the lesson is a good achievement for the teacher. For effective teaching and learning to take place, concentration is of great importance and that is why dictating while writing helps to strike the balance.

There are learners who are easily get off the track. Writing while at the same time dictating helps to make these learners concentrate. Learning is a process which faces a lot of obstacles. One of the obstacles is losing concentration when copying a lot of notes from the board. You remember those learners who would not finish all what the teacher wrote on the board?

Those learners skipping some points find it a challenge when they forget some explanation found in the points which they did not write. If a teacher writes and dictates, learners may be encouraged to write all what a teacher writes on the board. Learners should not shorten notes of a teacher as some concepts need detailed explanation.

Dictating while writing is beneficial in many ways. Firstly, it attracts attention of all groups of learners. This enables a teacher to move successfully with all learners. As learning is a serious activity which demands efforts in discerning what is taught, learners' motivation is

Learners who are good at listening and writing (dictation) save a lot of time in copying notes. This situation makes them enjoy lessons. Those who are good at looking and writing also get an opportunity to try to improve their dictation skills.

Secondly, dictating while writing helps a teacher to focus on what he or she is writing. The teaching and learning process sometimes faces barriers such as noise which may interfere with learning. A teacher's voice helps to contain noise that may come from learners.

When learners get tired in the course of learning, they tend to start talking and try to send a signal to the teacher that the lesson has to end. A teacher's voice becomes an emphasis that the lesson has to move on. When learners' complaints of being tired meet teacher's voice in dictating while writing, learners try to reconcile with the situation and continue learning.

Thirdly, dictating while writing helps learners learn pronunciation of words. Among things which are important in learning is how to pronounce words. This becomes more important in the study of languages. Language is learnt by imitating, therefore, a teacher building a habit of talking while writing is very beneficial to learners.

Teaching is meeting interests of each learner. There are normal things but which count a lot when it comes to making the lesson interesting. A teacher should not ignore things which can make a lesson more attractive to learners. Teaching is talking and writing.

RESIDENT Samia Suluhu Hassan's three-day state visit to India unveiled many unique features and reminisced about historic ties between the two friendly and big trading partners. For starters, this is her first visit to India as President and also the first visit by any African Head of State after the entry of the African Union into

To give it a context, the last presidential visit from Tanzania to India was in June 2015 by then President Kikwete. Then Indian Prime Minister Narendra Modi visited Tanzania in July 2016. The latest high level visit to Tanzania was by Indian External Affairs Minister from July this year, to co-chair the Joint Commission. The Speaker of Lok Sabhalower house of India's bicameral Parliament- Om Birla also visited Tanzania in January this year.

These visits can only mean one thing: Tanzania is a very important country to India and the vice versa is also true. To give you a feel of how India perceives Tanzania, take a look (in part) at the transcript of a 'Special Briefing' of the visit issued by India's Ministry of External Affairs on Monday:

"India-Tanzania relations are on a firm footing. We have robust bilateral institutional mechanisms and these meetings have been held regularly. These include ten rounds of Joint Commission meetings, two rounds of Joint Defence Coordination Committee meetings, four rounds of Joint Trade Committee meetings besides the Foreign Office Consultations and several joint working groups in numerous sectors.

"We also have a robust development partnership with Tanzania. India is the biggest development partner in Tanzania in the development cooperation both in terms of lines of credit, ITEC (Indian Technical and Economic Cooperation) slots and ICCR (Indian Council for Cultural Relations) scholarships."

The advisory adds that India is the largest destination for Tanzania's exports and both countries have a bilateral trade of \$6.4 billion of which India's exports alone amount to the value of \$3.9 billion and the imports from Tanzania amount to \$2.4 billion in 2022-2023. Further, it states that India is the fifth largest investor in Tanzania with about \$3.7 billion investments, covering several sectors and about 630 projects have been executed by the Indian companies and generated about 60,000 jobs locally.

 Γ is not a secret that the world is witnessing rising international tensions and erosion of the global order that has been in place since the establishment of the United Nations. Divisive blocs, which have not been seen since the Cold War, are making a swift return. As a result, our planet is facing severe threats, including a new global arms race, the threat of the use of nuclear weapons, and the proliferation of wars in all formats, including hot, hybrid, cyber, and trade.

In this atmosphere of tension and increasing geopolitical turbulences, it is vitally important to develop new approaches to strengthening inter-civilizational dialogue and trust.

Diplomacy is, undoubtedly, key to facilitating cooperation. Kazakhstan has always supported solving disputes exclusively at the negotiating table based on the UN Charter. Our country has consistently promoted principles aimed at achieving lasting peace, security, and sustainable progress across the world.

Despite best efforts, conflicts remain ubiquitous in many regions of the world.

To build a new system of international security, the world requires a new global movement for peace. I believe the role of religious leaders will be indispensable here. Approximately 85% of the world's people identify with a religion, making it a significant factor in our lives.

Religious leaders therefore have a significant influence on global affairs. Moreover, the sacred value of human life, mutual support, and the rejection of destructive rivalry and hostility are a set of principles shared by all religions. As a result, I am convinced that these principles can form the basis of a new world system.

How can religious leaders help push for world peace?

How can this work in practice?

Firstly, religious leaders can contribute to healing the wounds of hatred following an enduring conflict. Syria is a case in point. Kazakhstan welcomes the fact that hostilities have all but ended in that country. We are glad to have contributed to this through the Astana Process peace talks, which since 2017 facilitated negotiations between representatives of the Syrian government, the opposition, as well as Turkey, Iran, and Russia.

Yet while the hot phase of the conflict is over, the divisions within the country remain. Spiritual leaders can play an important role in healing Syrian society through the power of religion.

Secondly, human nature is contradictory. There will always be provocations and hatred. Recent actions to burn the holy Quran in a number of northern European countries are negative trends that undermine the culture of tolerance, mutual respect, and peaceful coexistence. In this regard, the targeted communication of religious leaders in preventing such situations and trends is crucial.

Thirdly, new technologies are radically changing all spheres of human life. These changes are mostly for the better, including improved healthcare, unlimited information online, and ease of com-

On the other hand, Mchicha seems to be currently flourishing in eastern Europe with Ukraine now becoming the major grower of edible pigweed. It was observed by agricultural experts meeting in Arusha.

On the other hand, the Agriculture Sector in the country and around the world is also facing a serious predicament because most of the seeds currently used to grow food and cash crops are disappearing at an alarming

Dr Gabriel Rugalema, Director of the World Vegetable Centre made the revelation here yesterday during the five-day training workshop on germplasm conservation and quality management.

"It is not just the seeds for food and cash crops that are disappearing, but also other important kernels used for extraction of vital medicines, including cancer treatment," said Dr Rugalema.

According to the expert, the disappearance of vegetables as well as other seeds is among the effects of climate change, taking a drastic toll on the environment and is among the topics of the training.

The course gathered more than 40 delegates in person, and another 100 participants who attended virtually online, representing national gene banks from

The good news is that between 2011 and 2022, more households had access to piped water and those without water have been declining. Over this period, more households had access to a flush toilet while the use of bucket toilets was also reported to have declined. Of the households, the Northern Cape had the highest proportion of experienced water cuts (65.8%), followed by the Northwest (65.2%), Mpumalanga (60.9%), Eastern Cape (59.2%), KwaZulu-Natal (57%), and Limpopo (54.5%). The lowest occurrence of water disruption was recorded in the Western Cape (27.7%) and Gauteng (40.5%) was considered to have the least water interruptions by the census respondents. Most households (about 70.8%) had access to a flush toilet across South Africa, but pit latrines (without ventilation) accounted for 12.5% and 2.1% for bucket toilets.

Power to South Africa The census data did not delve into interruptions to other services, mainly electricity. In a briefing with journalists, Statistics South Africa officials said people who participated in the census were not asked about disruptions to electricity. The question will be asked in a follow-up survey that seeks to verify or correct the

initial census findings. The main finding of the census on electricity is that the proportion of households using electricity as the main source for lighting increased from 84.7% in 2011 to 94.7%. The use of paraffin and candles as the main source of energy for lighting also decreased over this period. Statistics South Africa found that electricity was the main source of energy for lighting across all provinces, with 94.7% of the 17.8 million households reporting so.

Homelessness Another problem that the government is grappling with is homelessness across the country. There were 55,719 homeless people as recorded in the census 2022, with most people without a roof over their heads being in Gauteng (25,384), the Western Cape (9,743), and KwaZulu-Natal (7,768). The main reason given for homelessness by both men and women was joblessness, underscoring the economic and unemployment crisis gripping the nation.

The census 2022 excludes income and expenditure data, mortality, employment, and unemployment data to extrapolate changes in poverty, inequality, and quality of life trends. In the previous census, Statistics South Africa included such data, but its officials said the data is published by the agency separately.

Other findings South Africa's population now stands at 62 million, with all provinces recording a growth in their population since 2011. Gauteng recorded the highest population (15 million), followed by KwaZulu-Natal (12.4 million), while the Northern Cape and Free State reported the lowest population sizes of 1.4 million and 2.9 million respectively.

The 62 million population constituted 51.5% of women while 48.5% were men. Black Africans remain the dominant population group at 81.4%, followed by the coloured population at 8.2%. The white population percentage decreased to 7.3% in 2022 from 8.9% in 2011, while the percentage for Indians/Asians increased slightly from 2.5% in 2011 to 2.7% in 2022. Statistics South Africa officials said the white people population has been declining since 1996 but the reason for this is not known. It could be due to a range of factors, including emigration trends.

South Africa remains a young population with the country's median age increasing to 28 years in 2022 from 25 years in 2011. South Africa is a country that also continues to see an increase in the arrival of international migrants. There were more than 2.4 million international migrants, which equates to 3% of the population. Most of the migrants came from Zimbabwe (45%). followed by Mozambique (18.7%) and Lesotho (10.2%).

The Covid-19 pandemic and subsequent lockdowns delayed the execution and release of the census, which was initially scheduled to be released in 2021. It was also the first census that was conducted digitally, in addition to door-to-door surveying by Statistics South Africa agents. When asked if conducting the census digitally would distort its findings considering that access to the internet remains a challenge in South Africa, Statistics South Africa said this factor was considered. The officials said its online platform for people to participate in its census did not require mobile data/internet because it was zero-rated.



Economic recovery spurs bank's deposits mobilisation

ommercial banks in Tanzania mainland mobilized deposits amounting to 31.14trn/- during the financial year ended in June 2023, an increase of 17.7 percent compared to 26.4trn/- mobilized during the year ended in June 2022.

The new report by Bank of Tanzania (BoT) has said this was due to enhanced use of agent banking services, mobile banking platforms, expansion of bank branch network, and recovery of economic activities.

Banks are currently investing heavily on digital channels, specifically mobile and agency banking, as part of enhancing new customer recruitments, increasing conveniences in services delivery to their customers.

Cash deposits by agency banking countrywide grew by 46.7 percent to 66.7trn/- during the year ended in June this year, from 45.4trn/- in 2021/2022, of which Dar es Salaam zone was leading with 18.8trn/- followed by Lake zone

One of the bankers told the Guardian yesterday that the increased number of banks agents, resulted from the central bank's approval and relaxed requirements that has led into more central banks to establish agency banking services.

"Agency banking has smoothed banking services delivery and reduced time and cost, as customers can now deposit cash, withdraw cash and open accounts from their locality where agents are spreading across the country," the banker said.

Tanzania improves two ranks on Absa's financial markets index for 2023

Tanzania has gained the rank of the Absa Financial Markets Index 2023, after improving to 10th position in 2023, from 12th position in 2022, taking over Egypt and Zambia.

The Absa Financial Market index released on Tuesday shows the country's score remained flat at 55 during the reported period, after scoring more than 50 percent in four out of six pillars including microeconomic environment and transparency (81/100) and access to foreign exchange (54/100).

The Absa Africa Financial Markets Index was produced by Official Monetary and Financial Institutions Forum (OMFIF), an independent think tank for central bankingeconomic policy and public investment in association with Absa Group's Limited.

Other pillar which Tanzania performed above 50 out of 100, include market transparency, tax and regulatory environment (78/100) as well as legal standards and enforceability (55/100).

Bank of Israel interventions reverse shekel selloff

The shekel regained its footing as the central bank dueled short sellers to contain the market fallout from Israel's conflict with militant group Hamas.

The currency strengthened as much as 1 percent in the first half hour of trading on Tuesday and was little changed against the dollar as of 4:42 p.m. local time. The nation's benchmark stock index, which slumped 6.5 percent on Sunday, rose as much as 1.4 percent, before paring gains.

The resolve by the Bank of Israel, backed by a \$45 billion package of measures to smooth out volatility, succeeded in reining in wagers that seek to profit from any turmoil after a selloff took the shekel to the weakest in seven years. At stake is financial sta-

bility in an economy that's bracing for shocks as the conflict between Israel and Hamas entered its fourth day.

"I don't think there are many shorts being set," said Peter Kisler, a Londonbased hedge fund manager at Trium Capital. "Fighting the central bank is probably not a good idea."

Traders are wary of going against a central bank that's amassed nearly \$199 billion in reserves and devised a program of interventions it believed was "too big for speculators."

Policymakers said on Monday they'd sell up to \$30 billion of reserves to support the currency. That's the size of its foreign-currency purchases in 2021 when it sought to rein in the shekel's

Before Saturday's incursions by Hamas, the central bank had resisted supporting the shekel even as it slumped on investor concerns surrounding the government's controversial efforts to weaken the power of the judiciary.

The shekel is one of the biggest losers this year among a basket of 31 major currencies tracked by Bloomberg.

Pressure Points

History shows that the central bank might seek to prevent the currency from weakening past 4.05-4.10 versus the dollar, according to Coex Partners Ltd. The shekel had rebounded after reaching those levels in 2012 and 2015

Expectations from ongoing IMF, World Bank meetings

MARRAKECH

he annual meetings of the International Monetary Fund and World Bank kick off this week against a backdrop of escalating global conflict and debt distress.

A new outbreak of violence in Israel and the grinding war in Ukraine add a grim dynamic to the Washington-based lenders' efforts to rally their members and keep the focus on reforms to bolster their financial firepower.

The gatherings in Marrakech, Morocco – which bring together the world's finance ministers, central bank governors and top commercial banking executives – are taking place in Africa for the first time in 50 years. Kenya's capital, Nairobi, was host in 1973, the same year as the Yom Kippur War in the Middle East. Like the current violence, that conflict caught Israel by surprise at a time of global economic fragility.

The confluence of issues, amid high interest rates and a cautious economic outlook, reminds the estimated 10,000 attendees "how quickly geopolitics can change their calculations," said Josh Lipsky, senior director of the GeoEconomics Center at the Atlantic Council.

Economic clouds

The global economy has been buffeted by inflation, the steepest monetary tightening in a generation, China's property crisis and Russia's invasion of Ukraine, yet expansion keeps chugging along. That has markets rushing to price in a higher-forlonger interest-rate outlook, with 30-year US Treasury bond yields last week punching through 5 percent for the first time since 2007.

In its flagship World Economic Outlook on Tuesday, the IMF lifted its global inflation forecast for next year – 5.8 percent from 5.2 percent seen in July – while shaving 0.1 percent off its growth outlook for 2024, to 2.9 percent.

"Monetary policy needs to remain tight in most places until inflation is durably coming down towards targets," Pierre-Olivier Gourinchas, the IMF's chief economist, said in a briefing. "We're not quite there."

While discussions over monetary policy often overshadow fiscal updates at such multilateral conferences, there may be more attention paid to the outlook for state treasuries this time with many of the world's largest economies still deeply in the red.



Multilateral dysfunction

One again, conflict risks muddying a coherent message from the Group of 20, which represents more than 80 percent of the global economy created after the global financial crisis to seek a shared path forward. After a consensus communique was reached at its leader summit in India last month, the upcoming finance ministers and central bank governors will be facing a new challenge of addressing the conflict in Israel while balancing several, often clashing, stanc-

That was most visible this week in China, as a US congressional delegation headed by Senate Majority Leader Chuck Schumer criticized Beijing's response to the fighting as being insufficiently supportive of Israel. At the same time, the US-China tension will be a common theme through the week, as the IMF warns about the economic costs of worsening political fragmentation.

Debt help

The so-called Bretton Woods institutions, along with the G-20, are at the center of an effort to rewrite the global financial playbook around debt distress. Piles of loans in emerging markets taken out during the era of low rates and China's surge of Belt and Road Initiative lending, have now fallen into distress. But nobody knows yet how to resolve that

The effort, and its very slow progress, comes into focus Thursday during a session of the Global Sovereign Debt

Roundtable, a novel effort to bring together debtor countries along with the so-called Paris Club group of lenders, China and other new lenders, as well as private creditors. Seeking a unified approach to restructuring debt held by such a diverse group has been difficult, and expectations are low for any breakthroughs. Some progress on individual cases may emerge, however, with progress on restructuring agreements expected on Sri Lanka and Zambia.

Bretton Woods reforms

World Bank President Ajay Banga is expected to lay out his vision for the development lender, including efforts that could raise lending by more than \$100 billion over the next decade. IMF Managing Director Kristalina Georgieva intends to raise the fund's so-called quotas, seeking more money from members to help it reclaim its place at the center of the global financial safety net.

Both efforts find their biggest supporters, and obstacles, from the US Treasury Secretary Janet Yellen spurred on the World Bank's so-called evolution road map last year, asking the bank to take on a broader set of challenges and rally the private sector.

Georgieva said this month that she's interested in expanding the role of emerging and developing countries, including adding a third seat on its executive board to represent Africa. She also supports giving China a bigger vote, but that's not on the table until the next five-year review period.

Morocco recovery

The "city of cheerfulness," as Moroccans refer to Marrakech, is still recovering from a devastating earthquake centered in the nearby mountainous region that killed almost 3,000 people.

The meetings find the cash-strapped kingdom in need of \$11.7 billion to pay for rebuilding and potentially billions of dollars more to prepare to co-host the FIFA soccer World Cup in 2030.

With about 60,000 people left homeless, concern is growing with the approach of winter over the living conditions faced by survivors. The Red Cross last week called for "urgent humanitarian needs as winter approaches," including warm shelter, latrines and showers.

IMF says 'weak tail' of banks could struggle in an economic downturn

WASHINGTON

Around 5 percent of banks globally are vulnerable to stress if central bank interest rates remain higher for longer, despite the easing of turmoil in the sector in recent months, the International Monetary Fund (IMF) said on Tuesday.

A further 30 percent of banks - including some of the world's largest - would be vulnerable if the global economy enters a period of low growth and high inflation, or "stagflation," the IMF also said in its semiannual Global Financial Stability Report.

The warning was based on a new, tougher global stress test that the IMF applied to around 900 lenders in 29 countries following the collapse earlier this year of California-based Silicon Valley Bank, Switzerland's Credit Suisse Group and two other US lenders.

"There's a weak tail of banks in many countries," Tobias Adrian, director of the IMF's Monetary and Capital Markets Department, said in an interview conducted last week prior to the attacks by Palestinian Islamist group Hamas on Israel and retaliatory air strikes on the Gaza Strip.

The IMF adjusted this year's stress test to probe the impact of its baseline economic scenario of higher interest rates for longer, as well as the possibility of consumers yanking deposits. Its "severe-but-plausible" scenario envisages the global economy entering "stagflation."

"Under the baseline, it's about 5 percent of banks that are relatively weak in terms of their capital. And in severe stress, that number goes up to 30 percent or sometimes higher," Adrian said.

The IMF did not identify the banks that could be in trouble if those economic circumstances arose, but they included both small and large lenders.

"There's certainly some large institutions that could be under pressure in some scenarios, absolutely," Adrian said, though he noted the recent US banking crisis showed how even smaller bank failures could undermine financial stability.

Governments need to aggressively supervise their banks, and examiners must be more "intrusive" and direct lenders must take more "timely and conclusive" corrective action, the IMF said. It also said there was an "urgent need" to improve bank resilience by boosting capital levels.

The report was issued as global financial leaders gathered in Marrakech, Morocco, for the IMF and World Bank annual meetings.

INFLATION BATTLE

Recent ructions in government bond markets have been orderly, Adrian told reporters at a briefing on Tuesday. "The rise in yields has been quick, but we haven't seen sort of like forced deleveraging or other market dysfunction," Adrian said.

The difference in bond yields between German government bonds and those of southern European countries such as Italy which blew out during the sovereign debt crisis a decade ago remain "well contained", he added.

The US Federal Reserve's interest rate hikes in 2022 and 2023 led to heavy losses on the government bond portfolios held by regional US banks, which in turn spooked depositors and led to a string of failures in March and early May of this year.

The US central bank held its benchmark overnight interest rate steady in the 5.25 percent-5.50percent range last month, but signaled one more quarter-percentage-point hike would likely be needed before the end of this year to cement inflation's downward path, and that the policy rate would probably end 2024 above 5 percent.

Weak banks were considered those whose capital levels fell by more than five percentage points over the course of the IMF's stress test, or below a floor of 7 percent.

Under its baseline, 55 banks representing 4 percent of global assets proved weak. Under the stagflation scenario, that number expanded to 215 banks holding 42 percent of assets.

The report urged central banks to stick with higher rates until inflation cools, but warned that some investors appear to be too confident that inflation will fall quickly. "History cautions against declaring victory too soon and prematurely easing monetary policy," the



Banks reap \$280bn from rising rates, says McKinsey

NEW YORK

Banks globally reaped a \$280 billion profit boost in 2022 thanks to rising rates, in the sector's best performance since the 2008 global financial crisis, McKinsey & Co. said.

An unprecedented series of interestrate increases by monetary authorities across the world has provided the biggest tailwind for the global banking industry in over a decade. The bonanza has prompted several lenders to announce billions of dollars in share buybacks.

Though the return on equity jumped to 12 percent in 2022 from an average 9 percent since 2010, McKinsey struck a note of caution in its Global Banking Annual Review.

"A return to ultralow spreads seems unlikely in the short term, but the outlook for net margins remains uncertain," the New York-based consultancy said.

Banks also face rising competition with transactions increasingly moving to nontraditional institutions that are less regulated than lenders, it said in the report.

Between 2015 and 2022, more than 70 percent of the net increase in financial funds was held by insurance and pension funds, sovereign wealth funds, private capital and alternative investments



rather than banks.

"While the growth of assets under management outside of banks' balance sheets is not new, our analysis suggests that the traditional core of the banking sector – the balance sheet – now finds itself at a tipping point," McKinsey said in the report.

As that trend continues, governments are broadening scrutiny of non-traditional financial institutions as the macroeconomic system comes under stress, the firm said.

There's also a divergence in perfor-

mance, the report said. Financial institutions in the region around the Indian Ocean – including in Singapore, India, Dubai and parts of eastern Africa – are home to half of the best performing banks in the world, while in Europe and the US as well as China and Russia, banks have struggled to generate their cost of capital.

Valuations of banks at 0.9 times price-to-book remain unchanged since the global financial crisis, with a "historic gap" to the rest of the economy, the report said. That reflects the chal-

lenges the sector faces, and potential upside, it said.

But Chinese banks, with major ones trading at 0.5 times book value, are facing tougher times and have "limited prospects" of achieving higher returns, according to McKinsey.

BRI creates new paradigm for international cooperation

CHINA'S Belt and Road Initiative (BRI) has created new engines for global economic growth and a new paradigm for international cooperation, giving a boost to the development of China and other BRI countries.

China released a white paper titled "The Belt and Road Initiative: A Key Pillar of the Global Community of Shared Future" on Tuesday, underlining the initiative as "a Chinese solution to global development issues," which aims to advance modernization in participating countries in tandem, make economic globalization more dynamic, inclusive and sustainable, and ensure that more of the fruits will be shared more equitably by people across the world.

At a press conference held Tuesday on the white paper, several Chinese officials fielded questions ranging from the initiative's current status and cooperation mechanisms to its potential for future development.

NEW PARADIGM

"BRI cooperation has created a new paradigm for international cooperation, rising above the outdated mentality of geopolitical games," said Li Kexin, director-general of the Department of International Economic Affairs of China's Foreign Ministry, at the press conference.

Over the past decade, China has signed BRI cooperation documents with more than 150 countries and 30plus international organizations.

"The circle of friends has grown larger and larger, which fully proves that the initiative does not seek to form any closed and narrow circles," said Li.

"Trade and investment have expanded steadily between China and other BRI countries in the past decade," Vice Commerce Minister Guo Tingting said at the press conference.

From 2013 to 2022, the cumulative value of imports and exports between China and other BRI countries reached 19.1 trillion U.S. dollars, with an average annual growth rate of 6.4 percent, said the white paper.

The cumulative two-way investment between China and other BRI countries reached 380 billion U.S. dollars, including 240 billion U.S. dollars from China.

The BRI has connected the vibrant East Asia economic circle at one end with the developed European economic circle at the other, and includes the countries in between with huge potential for economic development, and also fostered closer economic coopera-

tion with African and Latin American

countries, according to the white paper.

FROM VISION TO REALITY

Since its launch 10 years ago, the BRI has evolved from ideas into actions, from a vision into reality, and from a general framework into concrete projects. It has been welcomed by the international community both as a public good and a cooperation platform, said the white paper.

BRI cooperation has delivered real gains to participating countries. It has contributed to the sound development of economic globalization and helped to resolve global development challenges and improve the global governance system, according to the white paper.

It has also opened up a new path for all humanity to realize modernization, and ensured that the efforts of building a global community of shared future are delivering real results, the white pa-

Guo said in taking the next step China is working to foster new drivers of economic growth, while advancing large key projects as well as some "small yet smart" projects to help BRI participating countries lay a solid foundation for development.

China will create a pilot zone for Silk Road e-commerce cooperation and host the global expo on digital trade to share development dividends with other BRI countries, Guo added.

To facilitate two-way trade, Guo said China will work actively towards joining the Comprehensive and Progressive Agreement for Trans-Pacific Partnership and the Digital Economy Partner-

ship Agreement. Guo said China will also support companies from Hong Kong and Macao to participate in the construction of the Belt and Road and deepen cooperation in the green economy, digital economy and other fields, to achieve sustainable development in BRI countries. Xinhua

Russia ready to make every effort to help settlement between Israel, Palestine – MFA

MOSCOW

RUSSIA is ready to make every effort to help reach a settlement between Israel and Palestine, and is in contact with leading regional players to stabilize the situation, Russian Foreign Ministry Spokeswoman Maria Zakharova said.

"We indeed stand ready to continue to provide comprehensive assistance to the sides in order to de-escalate the confrontation and establish a ceasefire. We are in close contact with the leading regional players, whose role in stabilizing the situation and creating conditions for establishing direct Palestinian-Israeli dialogue is indispensable," the diplomat said at a news conference.

She went on to say that Russia came up with a proposal in April to coordinate approaches as part of the Middle process the countries of the region



East settlement and bring into the

and the Arab League.

"We also proposed to consider holding consultations at the level of ministers and secretary general of the Arab League in Moscow in order to confirm the universal parameters of the settlement and discuss ways to normalize the situation in the conflict zone," she said.

The latest escalation of the situation in the Middle East started on October 7 when Hamas militants moved from the Gaza Strip to attack Israel. Subsequent clashes and shelling killed almost 800 Palestinians and more than 1,100 Israelis so far.

Hamas said it started the attack in response to Israeli actions against the Al-Aqsa Mosque on Jerusalem's Temple Mount. Israel said it was ready for war and has announced a full siege of the Gaza Strip.

Alarm grows on civilian sufferings as Mideast conflict

JERUSALEM/GAZA

MITIGATING civilian casualties amid the Mideast conflict is a key task for the international community as the toll of dead and missing persons, including children, continues to mount following Israel's "total" blockade on Gaza and the Palestinian Islamic resistance group Hamas' threats to kill hostages in retaliation, analysts said.

"The escalation of hostilities, characterized by indiscriminate attacks from both aerial and ground forces, threatens the very survival of the civilian populace. Alarming reports indicate a substantial surge in civilian casualties, even beyond the boundaries of Gaza," Arhama Siddiqa, a Middle East analyst and research fellow at the Institute of Strategic Studies Islamabad in Pakistan, told China

Without international intervention, the escalating conflict portends a grim future, where there may be scarcely anyone remaining to defend. The situation is akin to a selfdestructive time bomb, she added.

According to the UN Office for the Coordination of Humanitarian Affairs, or OCHA, as of Oct 9, more than 1,500 people have been killed – including more than 900 Israelis, and over 600 Palestinians, plus foreign nationals – and more than 5,000 injured since the latest conflict began over the weekend. But on Oct 10 Israel's army said it holds about 1,500 bodies of Hamas militants found in Israel on the fourth day of unprecedented battles.

Moreover, more than 187,000 displacements have been internally displaced in Gaza, the OCHA has said.

The figures include children, and some Palestinian armed groups in Gaza have claimed to have captured over 130 people, whose lives are urged to be protected by the Israeli

Hamas' military wing's spokesman Abu Obeida was cited by Xinhua as warning in an audio statement, that "any targeting of our people in their homes without prior warning will be regrettably faced with the execution of one the hostages of civilians."

Senior Hamas official Moussa Abu Marzouk said the group was open to political dialogue over a possible truce with Israel, which the Russian News Agency Tass and Reuters reported early on Oct 10.

However, "Israel is in a war against the terrorist organizations in the Gaza Strip," Consul General of Israel in Hong Kong Amir Lati said in a written statement to China Daily on Oct

10. "Hamas started this war, and Israel is preparing for a prolonged military response and to operate to restore full control over all the communities and the security fence area on the border with the Gaza Strip, as well as crashing the terrorist infrastructure of Hamas."

He said that "hundreds of terrorists of Hamas" launched a "deadly and barbaric attack with no legitimate pretext or provocative prior action on the part of Israel" in the midst of the Jewish holiday last Saturday, Oct 7, 2023.

Ceasefire appeals have been amplifying after Israeli Defense Minister Yoav Gallant on Oct 9 ordered "a complete siege" on the Gaza Strip, a day after Israeli Prime Minister Benjamin Netanvahu declared war against Hamas and vowed "mighty vengeance".

During a briefing with top Israeli military officials, Gallant said in a video statement that the complete siege on Gaza, which is home to about 2.3 million people, includes blocking electricity, food, and fuel supplies. Gaza has five governorates: Gaza City, Deir el-Balah, North Gaza, Khan Younis, and Rafah. It bordered by Israel and Egypt on the Mediterranean coast.

Hamas has ruled the Gaza Strip since 2007. Besides Israel, the group had been designated as a "terrorist" organization by the United States, as well as Canada, the European Union, and Japan.

Consul General Lati said this attack came after a long period in which Israel strove to bring calm to the Gaza Strip by making extensive efforts to improve the economic situation of Palestinians, with an emphasis on long-term projects in Gaza.

The attackers were "motivated by hatred" and had "the desire to hurt Israeli citizens in every way, and to bring about the destruction of the State of Israel", he said. He even went on to accuse Iran to

bear "responsibility for Hamas' capabilities".

Though Hamas rules Gaza, Israel controls Gaza's airspace and territorial waters, including two of the three border crossing points. The third one is controlled by Egypt.

Imtiaz Gul, executive director of the Center for Research and Security Studies in Pakistan, said the current situation is "very scary".

"It seems that this time the Israelis are determined to decimate Hamas. And this war on Hamas I think is going to be extremely critical for the survival not only of Hamas but of the so-called Palestinian state".

In a press briefing on Oct 9, Chinese Foreign Ministry Spokesperson Mao Ning said China opposes moves that would escalate the conflict and that it "was essential to restart the peace talks" and implement the two-state solution and settle the Palestinian question. She also said that Beijing "will continue to work relentlessly with the international community towards this end".

During a phone talk with Palestinian President Mahmoud Abbas late Monday, UN Secretary-General Antonio Guterres said that the United Nations is making efforts to provide urgent humanitarian relief aid to the residents there, the Palestinian News Agency reported.

Making similar pronouncements were the Arab League and Russian Federation, which called for "cessation of any hostilities between Israel and Palestine" and a return to negotiations. Ahmed Aboul-Gheit, secretary-general of the Arab League flew to Moscow following the Oct 7 attacks.

The two sides vowed to collaborate in ending the bloodshed in the Israeli-Palestinian conflict.

We are moving to full offence, Gaza will never go back to what it was - Israeli **Defence Minister**

ISRAELI Defence Minister Yoav Gallant on Tuesday said the Israel Defence Forces (IDF) is moving to "full offence" against Hamas targets as the counter-offensive in the wake of the terror attacks rages on, The Times of Israel reported.

In an address to troops deployed along the Gaza border, the Israeli Defence Minister said, "I have released all the restraints. We have [regained] control of the area and we are moving to a full offence."

He asserted that Gaza will "never go back to what it was".

"You will have the ability to change the reality here. You have seen the prices [being paid], and you will get to see the change. Hamas wanted a change in Gaza; it will change 180 degrees from what it thought," The Times of Israel quoted the minister as saying in a report.

"They will regret this moment, Gaza will never go back to what it was," the Defence minister said, adding that Israel, with all its might and, without compromise, would eliminate "whoever comes to decapitate, murder women, Holocaust survivors".

Hinting at the ongoing counteroffensive continuing for several months, he added, "We will return here, to Be'eri, in a few months, and the situation will be different. We will resettle the kibbutz until its last me-

After Gallant's address on Tuesday, the top spokesperson for Israeli Defence Forces (IDF), Rear Admiral Daniel Hagari, said killing senior Hamas members was a top priority, according to a report by The Times of Israel.

Informing that the troops were still looking for Hamas terrorists in southern Israel after the multi-pronged terror attacks on Saturday morning, Hagari added, "The directive to the forces is clear. Find terrorists and de-

"We are making a strong defence on the border. There were infiltration attempts today, but the terrorists were eliminated before they reached the fence," he added.

The bodies of 103 terrorists were found in Kibbutz Be'eri, he said, adding that Hamas gunmen murdered more than 100 Israelis in Kibbutz.

Meanwhile, as part of the ongoing counter-offensive against Hamas, dozens of Israeli Air Force fighters struck over 200 targets in the Al-Furqan neighbourhood, a spot from which Hamas launches attacks, according to a report.

In a post shared on X, IDF stated, "Dozens of Israeli Air Force fighter jets struck over 200 targets in the Al-Furgan neighbourhood--a terrorist hotspot from which Hamas devises and executes their attacks. This is the 3rd counterstrike in the area during the last 24 hours, in which 450 targets were struck."

Turkey ready for any kind of mediation - Erdogan

ANKARA

TURKISH President Recep Tayyip Erdogan has offered to mediate in the Hamas-Israel conflict. He said that Turkey continues to step up its diplomatic efforts, Turkey-based Anadolu Agency reported.

Erdogan (pictured) said, "I would like to state that Turkey is ready for any kind of mediation, including prisoner exchanges, if the parties request

"We continue to step up our diplomatic contacts, which we have been maintaining for a while and have intensified even more in the last three days," Erdogan said. He made the remarks after chairing a cabinet meeting in Ankara.

Erdogan's remarks come after the terrorist group Hamas launched a surprise attack on Israel, prompting Israel to declare a state of war.

Turkish President emphasised that the war is subject to a moral and ethical code, adding that the "sides are obliged to comply with. As we always say, 'There are no losers in a just peace'," Anadolu Agency reported.

Erdogan urged Israel to stop its bombing of Palestinian regions and called on Palestinians to stop their harassment of civilian settlements in Israel. He called for acting with a human conscience and added, "This moderate step will also open the door

He said, "We have always said and continue to say that we disapprove of letting a single innocent person get harmed, whether in Israel or Palestine's lands. Our position has not

Earlier on Monday, Erdogan held separate phone calls with Israeli counterpart Isaac Herzog and Palestinian President Mahmoud Abbas to discuss the latest situation in the region.



On Sunday, Erdogan stressed that the realization of an independent, and geographically integrated Palestinian state based on 1967 borders, with East Jerusalem as the capital, could not be delayed any further, according to Anadolu Agency report.

In his remarks at the opening ceremony of Mor Ephrem Syriac Orthodox Church in Yesilkoy, he said, "Lasting peace in the Middle East is only possible through a final settlement of the Palestinian-Israeli conflict."

He said that Turkey is willing to do its part to stop the conflict between Israel and Palestine and reduce the tensions that escalated on Saturday. He called the Palestine issue the root cause of the problems in the region. He added, "Our region will remain craving peace unless a just settlement is reached."

The Israel Defence Force (IDF) spokesperson Lieutenant Col. Jonathan Conricus on Wednesday that 1200 Israelis

First plane laden with US armaments arrives in Israel

TEL AVIV

THE first plane carrying US armaments landed in southern Israel on Tuesday evening, the Israel Defence Forces (IDF) said.

"The first plane carrying US armaments has since arrived at the Nevatim Airbase in southern Israel this evening," posted IDF on X. However, the IDF did not reveal the kinds of weapons or military equipment it received.

As Israel wages war with Hamas, US President Joe Biden's administration has begun delivering munitions to Israel this week.

"The cooperation between our militaries is a key part of ensuring regional security and stability in times of war," IDF's post added. Meanwhile, Israeli President Benjamin Netanyahu on Tuesday held a telephone conversation with US President Biden for the third time.

"I told him (Biden) that Hamas is worse than ISIS - and that they should be treated that way," posted Netanyahu on the social media platform, X, after the talks.

Biden reiterated that the "US stands by Israel" and "fully supports its right to defend itself," the Israeli PM said while thanking him for "unreserved support".

"Since our last conversation, the scale of this evil has only grown. They abducted dozens of children, burned them and executed them. They cut off the heads of soldiers, they murdered the young people who were celebrating at a festival in the wild...We have not seen such barbarism in the entire history of the State of Israel.... Netanyahu posted on X.

As the war against Hamas has completed four days, over a thousand Israelis have been killed, more than 2,800 are injured and 50 are confirmed hostage or missing, IDF said.

It also said that over 4,500 rockets have been fired from Gaza so far on Israel.

On the other hand, over 770 Palestinians have also been killed in air raids after Israel launched a strong counter-offensive. The Health Ministry in Gaza said that at least 770 Palestinians have been killed and 4,000 wounded in Israeli air raids. Among the dead are 140 children and 120 women, a ministry spokesperson said.

Haniyeh also praised Gazans for their fortitude and readiness to die for the Palestinian cause, and claimed that Israel's counter-offensive is a reflection of the "shame of its defeat.

China-Europe freight trains write new chapters of Silk Road cooperation

ACROSS the vast Eurasian continent, the tinkling of camel bells once rang along the ancient Silk Road. Today, the rumbling "steel camels" are running along tirelessly.

After 10 years of development, the China-Europe freight train service has accumulated 77,000 trips, transporting 7.31 million twenty-foot equivalent unit (TEU) containers of goods worth over \$340 billion. It has become an important bridge for international economic and trade cooperation.

Up to now, the China-Europe freight trains connect 112 cities in China and reach over 200 cities in 25 European countries and regions, as well as over 100 cities in 11 Asian countries and regions along the route. It opens up new channels for land transportation be-

tween Asia and Europe. At the China-Kazakhstan (Lianyungang) logistics cooperation base in east China's Jiangsu province, cargos are transferred from freight trains to vessels, waiting to be shipped over-

At a cargo consolidation hub for the China-Europe freight trains in Shenyang, northeast China's Liaoning province, cranes are hoisting containers marked "CHINA RAILWAY" onto

At the Erenhot Port in north China's Inner Mongolia autonomous region, China-Europe freight trains stand ready to depart after inspections and

According to the data from China Railway, the China-Europe freight train service has three main corridors - western corridor, eastern corridor and middle corridor - through six border crossings. There are now 86 routes operating on a routine basis at 120 km/h, forming the network of international intermodal transport between Asia and Europe.

Ports are important nodes along the China-Europe freight train routes, where trains complete procedures such as load switching, customs declaration, customs clearance, and exit.

Over the past 10 years, countries along the China-Europe freight train routes have strengthened the capacity expansion of existing ports, opened new ports, and continuously improved international intermodal transport capabilities to meet the growing demand.

The Manzhouli railway port in north China's Inner Mongolia Autonomous Region, after going through multiple upgrades, has doubled its daily loading capacity to 840 TEUs from the number in 2020, making international intermodal transport more efficient and convenient.

According to data from China Railway, in 2022, the numbers of China-Europe freight trains passing through Alashankou, Horgos, Manzhouli, Erenhot, and Suifenhe ports reached 5,141,

3,150, 4,838, 2,549 and 884, respectively, up by 3,981, 3,080, 4,527, 2,388, and 884 compared to 2016. Over the past decade, China-Europe freight trains have built an all-weather, high-capacity, green and

low-carbon logistics channel, creating a new landscape for international transportation cooperation. Statistics show that the China-Europe freight train service offers a cost advantage of approximately 1/5 compared to air transportation for shipping goods from China to Europe. Additionally, the transportation time is approximately 1/4 of that of sea transportation.

The service boasts high stability, and thus remains a reliable choice for meeting specific logistics needs that prioritize factors such as high value-added services and strict adherence to delivery timelines.

"Not only that, the average carbon emission of China-Europe freight trains is 1/15 of air transportation and 1/7 of road transportation. This plays a positive role in responding to global climate change and achieving sustainable transportation development," said an executive with the freight transportation department of China Railway.

Multimodal transportation of rail-sea, rail-road, and rail-air will better unleash the efficiency of China-Europe freight trains.

According to the National Development and Reform Commission, currently there are 29 routes of China-Europe freight trains starting from coastal ports such as Dalian, Tianjin, Qingdao, and Lianyungang. Cities like Guangzhou and Chengdu have built new rail-air cross-border e-commerce export models relying on the China-Europe freight train service, promoting integrated logistics development.

The range of goods transported between China and Europe via the China-Europe freight trains continues to expand. Starting from China, the trains now carry 53 major categories of goods, expanding from mobile phones and computers initially to vehicles, mechanical equipment, electronic products, and more. From Europe to China, the categories have grown from timber, automobiles and spare parts to electromechanical products, food, and medical devices.

The China-Europe freight train service is seeing robust growth. In the first eight months of this year, 11,638 trips were made, carrying over 1.26 million TEUs of goods, up 10 percent and 23 percent respectively compared to the same period last year. With this momentum, the "steel camels" will bring even more opportunities for international economic and trade cooperation.

Family intrigues threaten Hassan Mwakinyo's boxing career, fan base

HANCES that beleaguered 'ringmaster' Hassan Mwakinyo will pursue his boxing career for much longer are on the balance in the wake of his failure to show up for a scheduled fight, and steps taken by the Tanzania Professional **Boxing Regulatory Commission** (TPBRC).

The regulatory body was apparently in consultations with the National Sports Council (NSC) after both the boxer and the fight promoter were asked to present their defense in the case before decisions were tak-


The circumstances of absenting himself from the fight were peculiar, and invite suspicions of being taken sort of prisoner in domestic feuds eroding his sense of confidence, and professionalism.

Looking at what has been happening around the pugilist, there is reason to worry that he is running out of steam, a bit physically but also psychologically.

There were some controversial boxing events abroad where he won over a boxer named Sam Eggington who suffered a shock knockout defeat to Mwakinyo within two rounds, and then a decision was a sort of snap of legend, as given not long thereafter by the UK Boxing Commission.

On October 31, an entry from a UK newspaper said that the Tanzanian fighter's recent ranking should be ignored due to a computer data error during the tallying. It means he should not have fought in the match in the

'We're not monsters', says Afghanistan coach ahead of **World Cup qualifiers**

HONG KONG

AFGHANISTAN begin their first World Cup qualifying campaign since the Taliban's return to power on Thursday with head coach Abdullah Al-Mutairi looking to push politics aside and let his team focus on beating Mongolia.

Afghanistan, who have never gone close to securing a place at the World Cup, are hoping to advance to the second round of Asia's preliminaries for the 2026 finals but Al-Mutairi and his squad face a number of challenges.

Unable to play in front of their own fans due to the security situation in Afghanistan, they are playing the 'home' leg in neighbouring Tajikistan before facing Mongolia in Ulaanbaatar in the return match on Tuesday.

"Everyone is thinking all of us are monsters but this is not true," the Kuwaiti coach told Reuters of how his team have been perceived since the Taliban returned to power two years ago.

"You cannot judge all of the people because of one or two, or because of the political situation. "We are only a football team. It's so difficult but

we try our best.' The tie is one of 10 taking place across the continent featuring the confederation's lowest-

ranked nations, with the victors advancing to the

second round group phase which features seeded nations such as Japan and Australia. The winner of Afghanistan's playoff will take on 2022 World Cup hosts Qatar as well as India and

Al-Mutairi's native Kuwait, with the top two finishers advancing to the next phase of qualifying. The third and fourth placed finishers in the

group move into a qualifying tournament for the 2027 edition of the continental championship, which will be played in Saudi Arabia.

"Our target is to qualify for the Asian Cup in 2027," said Al-Mutairi. "We will try our best now." Despite the many challenges Al-Mutairi has faced since taking over as coach in April he said he has been succeeded in blending a cohesive and unified squad comprised of players from both inside and outside Afghanistan.

"We try to show everyone in the team that we have the same pain," he said. "We are humans.

"It's not important about background, your culture, where you sleep, where you are resident, where you play. It is not important.

"The most important is we have the same blood, Afghanistan blood. This you cannot change, even if you have another passport, even if you were born outside and have never been to Afghanistan before. None of this is important.

"What is important is the team plays for the country. Before it was a big problem but now we've solved it."

Age not a factor for England's Kane, targets Euro 2028

BURTON-UPON-TRENT, England

HARRY Kane says he is hoping to be in top shape for another eight or nine years and wants to help England win the European Championship on home soil in 2028.

England's top scorer, who will be a month shy of 35 when the 2028 Euros kick off, said it would be a "dream come true" to win the tournament having lost the 2020 final to Italy at Wembley.

"The perception in sport or football is that you hit 30 and people start to think it's the end," the Bayern Munich striker said after the UK and Ireland were named Euros hosts.

"But the way I am looking at it is that I almost have the second half of my career now. "I've had nine or 10 years at the highest level

and I'm hoping for another eight or nine years.

"With recovery, sports science and the way the game has adapted, it has allowed players to play for longer," added Kane, who turned 30 in July.

Kane cited Cristiano Ronaldo and Lionel Messi as examples of players who were still performing at the highest level in their thirties.

"When you look at a lot of the top-level players -- Ronaldo, Messi, (Robert) Lewandowski, (Zlatan) Ibrahimovic -- they have almost got better as they hit 30," he added.

"Everything is maybe settled in your personal life, family, kids. You are comfortable with your body and you are comfortable mentally, where you are at. That just allows you to focus on the football."

Beleaguered Maguire says call from Beckham was 'classy' and 'touching'

HARRY Maguire said a surprise call from former footballer David Beckham three weeks ago was "classy" and "touching", with Beckham offering kind words of commiseration for the beleaguered England and Manchester United defender.

The 30-year-old Maguire has been the target of brutal abuse from angry fans, an experience Beckham knows all too well after his infamous red card during the 1998 World Cup made him perhaps the most hated man in England- the nadir of his mostly illustrious career and a main storyline of his candid Netflix documentary "Beckham".

Beckham reached out after England's 3-1 win over Scotland on Sept. 12, when the toxic jeering by Scottish fans had both Three Lions manager Gareth Southgate and Maguire's mother Zoe lashing out in

"(Beckham's call) meant everything," Maguire told reporters on Tuesday after England's training at St. George's Park.

"I've spoken throughout my career about David Beckham being someone I looked up to and watched when I was a young boy. He was a big role model when I was growing up.

"It shows how classy he is to reach out to me. It was something I really appreciate. It was touching really."

Maguire, who has 59 caps for England, scored an own goal in the Scotland

game in an otherwise solid game and is on Southgate's squad for Friday's friendly against Australia and Tuesday's European Championship qualifier versus Italy at London's Wemblev Sta-

In the four-part Beckham documentary, the former Man United cornerstone and wife Victoria detail the abuse suffered after his World Cup blun-

They received threats to kidnap infant son Brooklyn. A Becks effigy was hung in a pub and rocks hurled at United's bus. Beckham, now 48, said he fell into a deep depression.

Maguire watched the documentary and said he was taken aback by the level of abuse Beckham suffered.

"Every career is so up and down, especially when you reach what I've reached, in terms of being the captain of the biggest club in the world for threeand-a-half years. He's been in that position and knows what it's like."



Tanzania finds itself in Pot 4 alongside Namibia, Guinea Bissau, and Mozambique.

The 24 teams will be drawn into six groups of four from Group A to Group F with a team coming from each of the pots.

It will be the third time Tanzania is participating in the AFCON finals, with the country's national side's first continental qualification having attained in 1980 in Nigeria.

There was a 39-year wait before Tanzania returned to the AFCON finals in 2019, which were hosted by Egypt.
