Economic hardship, alcohol, drugs touch off surge in mental health

THE number of people with mental illness in the country is on the increase, as Dar es Salaam region leads by accounting for 20 per cent of all

Records of the Ministry of Health, Community Development, Gender, Elderly and Children show that the number of patients with mental health problems increased from 301,000 in 2016 and 356,000 in 2018 countrywide.

This figure is however seen as conservative as it excludes current data from the Muhimbili National Hospital (MNH) in Dar es Salaam, Mirembe Hospital in Dodoma and various

specialized centres.

Out of this figure, Dar es Salaam region has 20 per cent of the cases followed by Kilimanjaro (9 per cent), Tanga (7), Morogoro (5), Mwanza (4 per cent) and other regions with much fewer cases such as Katavi with the least cases at 0.1 percent of the national number.

The observation comes as Tanzania joins the rest of the world in marking the World Mental Health Day today. Speaking during an exclusive interview with The Guardian yesterday, the Head of the Mental Health and Substance Abuse Unit at the ministry, Dr Omary Ububuyu, said the increase is caused mainly by economic hardship and excessive use of drugs.

"Environmental factors and excessive use of alcohol and other drugs is the highest cause of mental illnesses and not biological factors among urban residents and rural dwellers," he said.

Dr Ububuyu noted that other causes of mental illnesses include hereditary factors, biological disposition, disasters, injuries that affect the brain and some diseases like malaria and HIV/ Aids that also have side effects on the brain.

Thousands attempt to hack into HESLB loan allocation database

DMINISTRATORS at the Tanzania Revenue Authority (TRA) have been given two and half months to prepare and submit to the Treasury the country's roll of taxpayers, the number of buildings and billboards especially in Dar es Salaam region.

Dr Ashatu Kijaji, the Deputy Minister for Finance and Planning issued the directive in Dar es Salaam early this week during an inspection visit at the TRA Temeke regional tax offices, to hear from TRA staff the challenges they face in collecting taxes.

She said that the government expects that a complete tax collection profile of the city of Dar es Salaam shall have been completed by the end of the year.

In order to increase revenue from property tax the TRA must do the work day and night to ensure the database is completed

Though TRA did well in tax collection for the past month whereby 1.8trn/- was collected, the amount is still small keeping in mind current awareness among the people on paying taxes, she declared.

She reiterated the requirement on TRA to submit data on the increase of taxpayers following the distribution of Identity Cards (IDs) for small traders.

She said earlier that President John Magufuli's aim on the IDs was to widen the tax base to include small traders still raising their business

On the tax on buildings, Dr Kijaji called on TRA to ensure it gets a list of eligible buildings countrywide along with their owners in order to prepare the database to simplify property tax collection.

"In order to increase revenue from property tax the TRA must do the work day and night to ensure the database is completed. It will be used to remind taxpayers thereof through SMS messages on their obligation to pay - just as it is for land rent payers," she elaborated.

She also directed TRA to inspect users of Electronic Fiscal Devices (EFDs) in Temeke tax region to ensure all sellers issue EFD receipts and all buyers demand to be given one, as only

Too much intake of alcohol as well as smoking bhang, even cigarettes strongly reduces the capacity of the brain to perform its tasks.

On the other hand, a hazardous environment with hostility, violence and at times big tragedies like the recent fire accident in Morogoro affects people, leading to traumatic hangovers and mental instability problems.

The mental health expert observed that children are the most affected by hostile environments, as those who live with relatives who have suffered from long illnesses are inclined to go the same

Such mental illnesses entail related diseases like epilepsy, with up to 50 percent of the patients being outpatient, he said.

The two key illnesses are related, on the basis of data from the

ministry as well as PO-RALG (President's Office, Regional Administration and Local Governments) in like manner as data from district hospitals, health centres and various regional hospitals, he stated.

A World Health Organization (WHO) report from a study conducted a few years back indicated that at least one percent of the Tanzanian population suffers from mental illnesses, he added.

She reminded people to elect leaders who abide by leadership ethics, able to serve tirelessly at this time of the fifth government leadership and who are willing to preserve natural resources.


"Let me also urge you to vote for leaders who have the ability to assist national leaders move on with development agenda," she added.

DIT reviews curriculum to produce experts

THE Dar es Salaam Institute of Technology (DIT) has embarked on a process to review segments of its curriculum to produce experts who will fit in the industrialisation era.

According to DIT principal Prof Preksedis Ndomba the aim is to make students use 60-per cent of their stay at the institution doing research, innovation and practical studies. Speaking at the monthly research seminar which was held at the institution on Tuesday, Prof Ndomba said the review process started in 2016 saying it also included staff attachment to indus-

"We have already started this and we believe we will have the best curriculum towards the country's agenda," he said.

The key speaker at the seminar Prof Burton Mwamila who is also the former Vice Chancellor of the Nelson Mandela African Institution of Science and Technology (NM-AIST) said technology institutions such as DIT ought to understand the role of applied research in industrialization.

"Applied research brings solutions to existing industrial challenges facing the country because we need these institutions to bring us fit for purpose graduates to work in these industries," he said.

Prof Mwamila who was the first principal of the College of Engineering of the University of Dar es Salaam (COeT) said the main challenge facing industries is the lack of collaboration between researchers and industrial owners especially on topics to be researched and the challenges on

the ground

"Researchers sit on their offices and choose a topic to be researched on without consulting industrialists on what exactly is affecting their operations hence end up bringing research that is of little solution to the challenges," he added. Prof Mwamila proposed that there should be collaboration from the very beginning of topic selection between researchers and industrialists so that when a study is conducted becomes of great help.

In his remarks, DIT lecturer Dr Ramadhan Kivugo said the institution is now working towards achieving it's mission of solving society needs by producing competent graduates to facilitate achievement of the industrialisation agenda and a middle income economy by 2025.

He said DIT believes that in the next few years it will become one of the best institutions in the county to produce industrial experts who will contribute immensely to the country's economic development. "We want to ensure that as academicians we work together with industry owners and discuss what should be done on the challenges facing industries in the country," he said.

Cooperative unions to open coffee plants in three regions

IN efforts to fuel efforts by the fifth phase government under the industrialisation agenda , agricultural marketing cooperative societies (AMCOS) in three regions of Shinyanga, Simiyu and Geita are expecting to open three coffee processing industries earlier next year.

The envisaged three pilot plants are set to be opened by the Kahama Cooperative Union (KCU) in Shinyanga, Chato Cooperative Union (CKU) in Geita and Simiyu Cooperative Union (SCU) in Simiyu.

Speaking in an interview to The Guardian yesterday, Assistant Registrar of Cooperative Societies and head of marketing and investment section at Tanzania Cooperative Development Commission (TCDC), Edward Massawe said the key development was attributed by efforts by President John Magufuli to revive performance of cooperative societies within the country.

The fifth phase government has so far demonstrated high political will, as well as implementing diverse initiatives to revive performance of cooperative societies in the country, saying the efforts have started to bear fruits .

Massawe explained that cooperative unions are components to help push for different economic sectors, especially the agriculture sector in which the national economy hinges on. "Currently, farmers in different parts of the country are busy forming their cooperatives societies, and this, is after realising that the system is more friendly in assisting them to benefit accordingly from their initiatives, more than working as individuals," he noted.

He said that cooperative societies were of prudent in solving numerous setbacks that often curtailing farmers efforts, especially when it comes to availability of capital, procurement of necessary inputs for markets and better prices.

"For instance, through cooperative unions, the members (farmers) are procuring in-puts through bulk procurement, and the system made them to stand at better stance and position to lobby for better prices for their produced," he observed.

However, apart from attained successes in the whole exercise of revamping the performance of the said unions, he said the key private sector was however stiff facing some challenges,: "Currently some of the challenges haunting cooperative societies include poor awareness among the public as well as inadequate in the number of cooperative officers from regional to districts levels


He added: "When exported one litre of honey costs more than two goats, what is needed is proper packing and must be well strained and here at 4CCP I have seen a very modern straining machinery imported from Norway."

He said due to growing export needs; the Ministry through Tanzania Forest Services (TFS) has a special unit that will be looking foreign markets for the honey.

Aside from honey being of great commercial value, products from bees can be used as a nutrient and medicine for humans, as 80 per cent of consumers believe honey to have curing effects for various ailments.

National women empowerment forum kicks off in Unguja Island

A NATIONAL women empowerment forum kicked-off in Unguja, Zanzibar, providing space for legal aid stakeholders to broadly digest strategies that address women empowerment issues, gender inequality and protection of women and child rights in Zanzibar.

The forum organised by the Ministry of Labour, Empowerment, Elders, Women and Children (MLEEWC) and sponsored by Legal Services Facility (LSF) attracted 200 delegates from government and non-governmental organisations, donor agencies and other human rights and development

Key issues lined-up for discussion at the forum include representation and women participation in leadership roles, equal pay for work of equal value, increasing support for women-owned businesses and companies of all sizes, advancing gender equality and women empowerment in the workplace, marketplace and the wider commu-

Speaking at the official opening of oneday forum, Zanzibar's Minister for Labour, Empowerment, Elders, Women and Children, Maudline Cyrus Castico, commended LSF for their collaboration towards supporting women initiatives in Zanzibar which aims at women's economic empowerment and ending violence against women and girls, eliminating harmful practices.

He reaffirmed the government's commitment in ensuring that women, widely viewed as key pillars in the social and economic development, are given opportunities in education, leadership roles, capacitated to be able to unlock their potentials"

He underscored the importance of women participation in politics with the view to ensure that women are involved in decision-making processes, considering that under normal conditions women have few chances to get involved fully in political decision-making processes in Zanzibar.

The constitutional amendments of 2010 raised the percentage of special seats in the House of Representative up to 40 per cent of the total number of constituency seats in Zanzibar.

"According to latest independent studies, women in Zanzibar constitute 72 per cent of the entire population, but most of them lack legal knowledge on matters related to social justice, thus end up being denied their rights, losing their property, dignity, a tendency that affects the wellbeing of women, children and community at large."

Among other things, the forum would serve as a platform for participants to voice their grievances and ask the responsible government authorities (including the judiciary, the police, DDP and social welfare officers etc) to ensure access to justice and the rights of all women, children and other vulnerable groups in Zanzibar and across Tanzania are respected, according to LSF Chief Executive Officer, Lulu Ng'wanakilala.

Participants would utilize the forum to raise their concerns and call for the elimination of all forms of violence against women and children by raising awareness, strengthening activism and providing a forum for dialogue and strategy making to end violence against women and children (VAWC).

Press Clubs' founder, William Lobulu, to be laid to rest today

VETERAN journalist and media consultant, William Nicholas Lobulu expects to be laid to rest today at his farm in Sanawari area, within the Arusha City suburbs.

The founder of Press Clubs in Tanzania, William Lobulu, and former tutor at the Tanzania School of Journalism, Lobulu also founded and managed the Arusha Times weekly newspaper between 1995 and 2017.

Lobulu passed away at his home in the 'Boma Kubwa,' parts of Sanawari Ward in the early morning of Sunday, the 6th of October 2019 after experiencing constricted breathing due to

Born on the 20th of December 1951, the late Lobulu, who previously also worked for the state-owned Tanzania Information Services, then known as Shirika la Habari Tanzania (SHIHATA) would have been 68 next December. The media expert is survived by wife, Elizabeth Marealle Lobulu and three children.

Together with fellow seasoned journalist, Danford Mpumilwa. Lobulu initiated the first 'Press Clubs' movement in the country when the two established the first such organisation, now known as the Arusha Press Club in 1992 with him serving as its maiden chairman.

Borrowing a leaf from the Arusha Press Club, journalists in other regions followed suit in forming own local media clubs.

Until his death, early this week, the veteran journalist has been working as consultant in a number of media and research related programmes, edited a number of scholar documents and continued to offer advice and guidance to practising

Pastoralists community to benefit from heath centre

MORE than 6,000 people from four villages in Oldonyowas Ward in Arusha district are to benefit from health centre project thereby doing away with the need to walk long distances with expectant mothers giving birth on the way.

The villagers from Losinon, Engutukoit, Kisimiri Juu, and Wiro will benefit from a modern health centre built with funding from Germany through Help for Maasai Children (HMC).

Speaking during the function to lay the cornerstone and handing over the building to Arusha District Council that took place at Losinon Juu village in Oldonyowas Ward, the HMC Director Joseph Kivuyo said the construction of the health centre began on June 26 this year and it has been completed by 85 percent.

Kivuyo said up to now the project has cost 108m/- and upon completion it will have cost 140m/-.

Kivuyo said the wananchi in the said villages have been walking 8 to 12 kms for health services and due to these distances expectant mothers have been giving birth on the way while others in their homes which has increased maternity

"We have partnered with the Arusha District Council in building of this health centre who provided us with centre's plan, after which our donors from Ger-

many, who had earlier visited Oldonyowas Ward to see for themselves the situation facing the pastoralists community, decided to offer financial assistance," Kivuyo said.

The Arumeru District Commissioner Jerry Muro, speaking at the function, congratulated the donors for their financial assistance to various projects in the ward, including education and health.

Muro promised a Landcruiser ambulance for the health centre including renovation of the roads leading to the health

On his part the project's financier who is HMC Director in Germany, Harald Pfeiffer said the construction of the health centre was among his long time dreams that came true in assisting the pastoralists' community in education and health.

He wanted the people in the Ward to put the health centre to good use as intended, to safeguard the infrastructure for future generations.

Two residents from Lasinon Juu village Lightnes Gabriel and Anna John thanked the donors for the health project as it came at the right time as they were facing huge challenges from lack of health services, especially to the women and expectant mothers.

They also pleaded with the government to speed up the remaining work of the project including provision of medical equipment, and personnel.

pecially marginalised and disabled people will get free eye screening or examination, 13,500 patients will get free cataract surgery and restore their sight while 6000 people will get spectacles.

The main goal was to deliver improved eye health to address the leading cause of blindness across the region.

Sightsavers is an international ing that information and services cataract surgeries will restore the organisation that works in more than 30 developing countries to prevent blindness, restore sight and advocate for social inclusion and equal rights for people with disabilities.

He said the project will ensure that eye health services are accessible to everyone, he said notmust be made more accessible so that everyone can get treatment for eye conditions equally including women, elderly people and people with disabilities.

Countries and families worldwide ought to end forced child marriage

NTERNATIONAL Day of the Girl Child is an international observance day declared by the United Nations; it is also called the Day of Girls and the International Day of the Girl. October 11, 2012, was the first Day of the Girl Child. The observation supports more opportunity for girls and increases awareness of gender inequality faced by girls worldwide based upon their gender.

This inequality includes areas such as access to education, nutrition, legal rights, medical care, and protection from discrimination, violence against women and forced child marriage. The celebration of the day also "reflects the successful emergence of girls and young women as a distinct cohort in development policy, programming, campaigning and research."

International Day of the Girl increases awareness of issues faced by girls around the world. Many global development plans do not include or consider girls, and their issues become

More than 62 million girls around the world had no access to education, as of c. 2014, according to USAID. Worldwide and collectively, girls ages 5 to 14 spend more than 160 million hours more on household chores than boys of the same age do. Globally, one in four girls are married before age 18.

On October 11, 2016, Emma Watson, a United Nations Women's Goodwill Ambassador, urged countries and families worldwide to end forced child marriage. Many girls around the world are vulnerable to acts of sexual violence and the perpetrators often go unpunished.

The Day of Girls helps raise awareness not only of the issues that girls face, but also of what is likely to happen when those problems are solved. For example, educating girls helps reduce the rate of child marriage, disease and helps strengthen the economy by helping girls have access to higher paying jobs.

The International Day of Girls initiative began as a project of Plan International, a non-governmental organization that operates worldwide.

The idea for an international day of observance and celebration grew out particular.

Each year's Day of Girls has a theme; the first was "ending child marriage", the second, in 2013, was "innovating for girls' education", the third, in 2014, was "Empowering Adolescent Girls: Ending the Cycle of Violence," and the fourth, in 2015, was "The Power of Adolescent Girl: Vision for 2030."

The 2016 theme was "Girls' Progress = Goals' Progress: What Counts for Girls," the 2017 theme was "EmPOWER Girls: Before, during and after crises," and the theme for 2018 was "With Her: A Skilled

Amended public procurement law bears fruit for economic growth

ROCUREMENT is the process of finding and agreeing to terms, and acquiring goods, services, or works from an external source, often via a tendering or competitive bidding pro-

Procurement generally involves making buying decisions under conditions of scarcity. If sound data is available, it is good practice to make use of economic analysis methods such as cost-benefit analysis or cost-utility

Procurement is used to ensure the buyer receives goods, services, or works at the best possible price when aspects such as quality, quantity, time, and location are compared. Corporations and public bodies often define processes intended to promote fair and open competition for their business while minimising risks such as exposure to fraud and collusion.

Almost all purchasing decisions include factors such as delivery and handling, marginal benefit, and price fluctuations. The government Procurement Services Agency (GPSA) had started recording a number of successes since the public procurement law was amended three years

The law is meant to enable efficiency in regulating procurement processes, to ensure value for money in public procurement and to provide for other related matters.

GPSA Chief Executive Officer, Dr Geraldine Rasheli said that the reviewed law had improved public procurement services as well as better service delivery environment, the situation that made public institutions to work in tandem with the law.

Dr Rasheli unveiled that in the area of procurement of common use items and services (CUIS) by 2018/2019 fiscal year, the government saved around 63bn/-, due to reducing costs in tendering processes.

The costs, according to GPSA boss

include tender announcements, board meetings and tender assessments, and instead, institutions are required to use tenders who had been listed by GPSA.

Citing examples, Dr Rasheli said in 2018/2019, tenders who qualified and given contracts were 9,740.

She also said that in the same year the government saved 4.7bn/through Vehicle bulky procurement. "This is due to reduction of costs embedded in tendering process as well as providing special discount for bulky procurement.

In 2018/19, the government saved 798m/- through Clearing and Forwarding Services, the official said, revealing that the agency has plugged all loopholes that fuels corruption.

All the saved money has been spent in public development projects such as improvement of road infrastructure, health and education sectors," she said, adding that GPSA has been also working closely with entrepreneurs and private companies in building the nation by offering competitive services.

Dr Rasheli cited dilapidated of infrastructures as some of the challenges facing the agency, "but we're determined to work on those challenges to ensure that customers get better services.



Tapping into mobile phones to advance Africa's intelligence on global health and food security

IT is official: With 9.3 billion mobile connections, the number of mobile devices on earth now surpasses the 7.6 billion people population. This creates huge opportunities to advance global health and food security through mobile phones. It may surprise people to learn that this can be done without apps. Here are three main ways to effectively use mobile phones to address issues like infectious diseases, particularly on the African

First, mobile messaging presents the perfect platform to address global problems like infectious diseases. Already 22 billion text messages are sent daily by mobile phone users. Mobile messaging can be used to inform remote communities across Africa about immunisation, one of the most cost-effective public health interventions for prevention of infectious diseases. Mobile messaging should also be used for risk communication - informing individuals about changes they can make to prevent infectious diseases. For example, informing individuals about the benefits of hand washing, stoppage of open defecation and benefits of taking the right vaccines/ drugs before embarking on international travels.

This is sorely needed as globally, more than 50 per cent of all countries are not prepared for an epidemic, according to preventepidemics. org, the world's first website to provide an overall score for a country's ability to find, stop and prevent diseases. In Africa, based on preventepidemics.org rankings, no country is fully prepared for an epidemic. For instance, Nigeria, Kenya and South Africa score 39%, 50% and 62%, respectively.

In terms of agriculture and food security, messaging via cellphones has already been leveraged with much success. Tigo Kilimo, in Tanzania, for example, helps farmers stay ahead of weather by sending crucial weather data via cellphones. In Malawi and Western African Countries, Self Help Africa is using text messaging to warn thousands of citizens about impending weather events that might threaten their crops, or their

homes. In addition, by combining mobile cell phone technology and artificial intelligence, cell phones can detect crop plant diseases, several days before full symptoms are evident. Once plant diseases have been detected, farmers can be messaged via cellphones, allowing them to take the necessary preventative actions.

Second, the talk feature of mobile phones can be useful for the exchange of ideas. When community dwellers come across illnesses that they do not know, how do they report such cases? Who do they report such cases to? This is where talk features of mobile phones could be harnessed. The use of toll-free lines for reporting suspected infectious disease would help health workers nip it in the bud before outbreaks occur.

This is timely as lately, we've seen many infectious disease outbreaks including Lassa fever in Nigeria, cholera in Kenya, African swine flu in South Africa and measles in the U.S. The latest Ebola outbreak in the Democratic Republic of the Congo (DRC) has killed more than two thousand people so far. The risk of spreading infectious diseases is heightened by the ease of international travel. Within 36 hours, an outbreak that began in a remote village can reach major world capitals. Quickly communicating with health workers about these illnesses could keep them from spread-

Similarly, in terms of food security and agriculture, mobile phones can be tapped into to prevent invasive pests that have significant impacts on food security. Take the case of the invasive fall armyworm, a crop pest that invaded Africa in 2016, and significantly affected food security in over 46 African countries. If farmers across Africa had adequately been trained on how to use their cell phones to report unusual pests to their respective departments of agriculture, a lot of the early damage caused by this invasive pest would have been prevented.

With recent research pre-

dicting that threat from invasive pests will continue to increase within African countries, African governments and other stakeholders in the African agriculture sector must tap into mobile phones to help African farmers to anticipate and prepare for future invasive insect pests. It is encouraging to see that researchers are already implementing this. Farmers in Kenya, Ghana and Zambia can get early alerts courtesy of the Pest Risk Information Service. This should continue.

Third, data functionality of mobile phones provide good platforms for providing continuing professional development for agricultural extension and health workers and updates on new and emerging infectious diseases as well as plant diseases and insect pests. A well-educated agricultural extension and health workforce that is capable of detecting and responding to infectious diseases, invasive pests, and other epidemics and disasters linked to a changing climate can saves lives. High speed internet such as the free Google Wi-Fi Hot Spots being rolled out across Africa can be a gamechanger if national public health and agriculture institutes are connected to it. The Google hotspots speed is 30mbps, which is more speed than most African countries offer.

We must take advantage of this widespread penetration of mobile cellphone technology to advance global health security and food security on the African continent.

Study reveals need for intervention to respond to climate change threats in Chalinze

RECENT study on Vulnerability Impact Assessment to climate change conducted in Chalinze district, Coastal region has revealed significant impacts related to extreme weather and climate events. Among the revealed impacts includes prolonged droughts, floods and strong wind, which are projected to increase in frequency and magnitude.

The nine (9) months study conducted by E-Link Consult Ltd, supported by SERVIR project through USAID, has revealed increased temperature and decreased rainfall in the district. Communities in this area are highly vulnerable because they depend on agriculture and livestock keeping as their main economic activities. Climate change has significantly impact on food production; infrastructure maintenance such as roads and bridges; pose health risks hence, posing a big risk to poverty reduction efforts in various parts of the district. This may undo decades of development efforts of the government and the local government authorities in

The Director of E-Link Consult, Shukuru Nyagawa said that vulnerability impact assessment is an important process to reveal the impacts of climate change, and identifying hotspot areas, which leads to more thoughtful and informed decision-making process in formulating area specific appropriate adaptation measures.

The project coordinator Abdallah Henku explained that this study applied both primary and secondary data, including quantitative and qualitative respectively. Quantitative secondary data were gathered from various sources including NBS and TMA at the national level, and UNEP, RCMRD, FEWSNET, UNFCCD, JRC and Landsat or Sentinel at international level, while the qualitative data were gathered during stakeholder's meeting held in the district level.

Data collection was strategically done to ensure that the three main Vulnerability Impacts Assessment components of exposure, sensitivity and adaptive capacity were properly determined, as per the Inter governmental Panel on Climate Change (IPCC) methodology. Each vulnerability component has a number of specific data layers. Programming language was used to assign indicator codes to specific data layers. The analysis involved converting all the original (raw) spatial data layers into grids, inverting indicators, assigning weights to various indicators, rescaling of indicators and development of vulnerability



In respect to the three assessment components of exposure, sensitivity and adaptive capacity the results showed that; the central parts of Chalinze District Council had highest exposure to the associated climate change impacts. Specifically Kimange, Msata, Talawanda and Miono wards fell under this category. The findings indicates that, the most sensitive areas are Msata and Ubenazomozi wards and some villages in Talawanda, Pera, Vigwaza and Mkange wards and finally two wards of Bwilingu and Mandera had high adap-

tive capacity compared to the rest. The overall vulnerability was determined through averaging of the rescaled values from exposure, sensitivity, and lack of adaptive capacity indicators. The Overall vulnerability assessment indicates that Talawanda and Kimange wards were the most vulnerable wards. This vulnerability assessment and hotspot mapping is an essential exercise for implementation of informed project interventions such as climate change adaptation intervention, and can be used as a resources mobilization tool when engaging various development partner across scales and levels in Chalinze District Council.

District Officers Capacity building site

The Vulnerability Impact Assessment (VIA) project provided opportunity for the Chalinze District Officers to be capacitated with climate change adaptation knowledge and concepts. Among them was the natural resource officer, land officer, agricultural officer, environmental officer just to name a few. This opportunity was to link the findings of the VIA report prepared under this pro-

ject and the climate change concepts. This capacity building and awareness raising study visits were done at the end of August this year at Kaloleni village, Ubenazomozi village, Lugoba village, Ruvu river and Wami river. The main sectors looked at were Livestock keeping, Water resources, Settlement, Sand and gravel mining, Agriculture, and Livelihood activities.

Agriculture:

The study revealed that, Chalinze district council depends mainly on rain-fed agriculture with very small percentage of farmers engaged in irrigation. According to the district agriculture officer, the district has been experiencing decrease in rainfall and increased drought. It was added that the district has been experiencing variability in rainfall distribution, such that the onset and ending of rainfall are unpredictable. Moreover, this sector has been invaded with crop diseases, which are difficult to cure with the regular agricultural herbicides. On the other hand, on the low lands of Wami and Ruvu river basins, frequent flooding have caused destruction of agricultural crops and related infrastructures. These have impacted crop growth and productivity, leading into shortage of food and hunger among the communities. It was further mentioned that, Miono Ward was among the areas experiencing shortage of food due to prolonged drought and unpredictable rainfall.

During the visit, it was noted that most of the forests in Chalinze district are degraded due to human activities such as charcoal burning, encroachment for agriculture (farming and livestock keeping) and settlement. The district natural resource officer Mr. Revocatus Samwel explained that the district has been facing with decreased rainfall and increased droughts due to decreased vegetation cover such as forests. Most of the areas that were covered by forests in the past have been converted to other land uses. It was acknowledged that failure to conserve forests would lead to more climate change related challenges in the future.

Regarding the water sector, climate change impacts affected water sector in different angles. It was noted that most of the water sources that existed in the past has disappeared, while some of those that still exist are faced with decreased water flow. The main reasons to these challenges were increased drought, decreased rainfall, increased invasive species in water catchments, unplanned settlement, lack of land use plans and poor adherence to enforcement of legal frameworks such as water and environmental laws and policies.

Livestock

The villagers reported that increased drought and decreased rainfall have impacted negatively the livestock sector. The quality of pasture and animal productivity have decreased, contributing to increased conflicts between farmers and livestock keepers; decreased household income, abandonment of families especially leaving behind women and children; increased land destruction due to overgrazing and general decrease of district economy.

Land is both a source and a sink of greenhouse gases (GHS) and plays a key role in the exchange of energy and water between the land surface and atmosphere. Land ecosystems and biodiversity are vulnerable to the ongoing climate change impacts. Multiple stressors on land such as agricultural activities, unplanned

settlements, poor livestock keeping, deforestation, mining, floods and droughts contribute to land degradation. Furthermore, it has been noted that most of the areas in the district are now experiencing increased gully erosion, which threatens existence of infrastructures such as roads and bridges. With many being attributed to unpredictable rainfall as a result of climate change.

Mining: Sand and gravel mining in Chal-

inze district council are some of the major economic activities. Gravel and sand, which are used for construction projects in various levels, are reported to be the major source of income in the district. The study visit revealed that mining activities in the area contributes to degradation of the environment which may hamper adaptation strategies and be source of emission. Mining activities, which include sand and gravel quarries involves use of machinery, which uses fossil fuels, attracts population increase, resulting into unplanned settlements. Such a scenario makes the community around the mining areas to be at risk of accessing safe water, reliable energy and food security. Increased impacts of climate change exacerbate the vulnerability of these communities. Participants further noted that increased floods impact the mining activities as the open pits (the quarry) are filled with water, restricting operations.

Flooding on the abandoned quarries poses health risks by percolation of unsafe water to underground sources and be source

This risk of contaminating underground water is caused by lack of proper water treatment procedures at the mining sites. Dirty and contaminated water ponds where observed in areas where land reclamation has not yet been done and sand mining operations have stopped.

Participants recommended that proper environmental and land management strategies need to be developed and operationalized in areas where mining activities are done, so as to restore the natural vegetation which increases CO2 sinks, thus contributing to national mitigation efforts. There are a lot of land degradation and air pollution going on, which posses health risks to communities living around

"Changes in the climate have direct effect to our operations because we depend on the functional and liable supply systems such as water, energy, food and human resource. Recently we have been facing with prolonged droughts and unpredictable rainfall which affected our operations and increase costs for maintaining our machinery and other resources," According to the site manager of the Highland estate Ltd, Nasir Nur-

The district Officers said most of the mining companies operating in the district have limited awareness and capacity to respond to challenges related to climate change. It was reported that there has never been any forum or meeting organized by or with the investors (private sectors) to discuss any issues related to climate change to what they are doing. It is important that forum is formulated and encourages investors to support adaptation activities within the district.

The study further revealed that, there a lot of land degradation and air pollution related activities going on around the district, which posse's health risks to communities living around the mines. There is also a risk of contaminating underground water due to lack of proper water treatment procedures at the mining sites. It was observed that there dirty and contaminated water ponds in areas where land reclamation has not yet been done and sand mining operations have stopped.

Unfortunately, the linkage between local government and central government agencies such as the National Environmental Management Council - NEMC was a challenge. It was pointed out that, most of the companies report directly to the central government designated bodies rather than the district council. This being the case, the district officers face challenges in monitoring the mining

It was therefore recommended that, there is need to develop and operationalize proper environmental and land management strategies in areas where mining activities are done, to help restore the natural vegetation as Carbon dioxide (CO2) sinks, thus contributing to national mitigation efforts and adaptation efforts.

Education is a basic right and the foundation for a more just society

ORE than 40 per cent of the 57 million children worldwide estimated to still be missing out on school are thought to have disabilities. However, all youth have the right to learn together regardless of any disabilities or differences they may have.

While progress has been made on achieving this global goal over the last 25 years, there is still more work to be done.

Prof Mel Ainscow is Emeritus Professor of Education, University of Manchester and was a keynote at UNESCO's recent International Forum on Inclusion and Equity in Education.

The event commemorated the 25th anniversary of the World Conference on Special Needs Education that led to the UNESCO Salamanca Statement and Framework for Action on Special Needs Education, arguably the most significant international document that has ever appeared in the field of special education.

Mel has been a consultant to UNESCO on a series of global initiatives aimed at findings ways of including all children in schools. The Global Search for Education asked him to reflect on what has happened over that 25-year period and what lessons could be learned from his experiences in different parts of the world.

Mel, it's been 25 years since the publication of the Salamanca Statement. What progress has been made? What still needs to be done?

I attended the conference in 1994 and recall the enthusiasm that was generated by the discussions that took place. I also remember the splendid social programme organised for the delegates, with banquets, receptions and lots of Spanish wine.

The wonderfully inclusive atmosphere that this created led me to think that by the end of the week those involved would 'sign anything'. That said, I could not have imagined the impact that all of this was to have over the following 25 years.

Although the immediate focus of the Salamanca conference

was on what was termed special needs education, its conclusion was that the aim must be to develop inclusive education systems. It was argued that this can only happen if mainstream schools become capable of educating all children in their local communities.

The years following Salamanca led to many developments in relation to this theme. For example, Italy has closed its special provision; New Brunswick in Canada pioneered the concept of inclusive education; India saw a significant push towards increased enrolment in schools; and Portugal enacted an explicit legal framework for the inclusion of all students.

Significant developments have also occurred in the Pacific region, where inclusive education has been identified as a regional priority by all countries.

Despite these encouraging developments, progress has slowed in recent years. And, significantly, it is estimated that more than 40 per cent of the 57 million children worldwide missing out on school are thought to be disabled.

What achievements are you most proud of that have addressed the inclusion agenda? Can you suggest any relevant resources?

I suppose my greatest pride is my success in bringing people together to address the inclusion agenda. This has involved a series of initiatives to develop practical resources. Recently, one of these led to the publication of the UNESCO Guide for Ensuring Inclusion and Equity in Education. This offers practical support to member states as to what actions need to be taken to promote inclusion.

Drawing on international research, the Guide was developed with the advice and support of a group of international experts. It allows readers to learn from the progress made by other countries towards more inclusive education systems. Examples include how Ghana assesses the inclusiveness of its mainstream schools, how Denmark is developing a sense of community by listening to the views of children,

and Mel Ainscow.

and how students in Portugal help teachers to innovate. These examples advance the right of every learner to be included in schools.

Those involved in taking this challenging agenda forward may also find it useful to use the related resource pack, 'Reaching Out to All Learners', which I developed with colleagues at the International Bureau of Education-UNESCO.

Drawing on international research evidence, these materials are intended to support inclusive thinking and practices at all levels of an education system. Consequently, they are designed to be relevant to teachers, school leaders, district level administrators, teacher educators and national policy makers.

What actions are needed to move education systems in an inclusive direction?

My recommendations are guided by the idea that inclusion should not be seen as a separate policy. Rather, it should be viewed as a principle that informs all policies, guided by six related actions.



Action 1: Establish a clear definition of what is meant by inclusion in education. In some countries, inclusive education is still thought of as an approach to serving children with disabilities within general education settings. Internationally, however, it is increasingly seen more broadly as a principle that supports and welcomes diversity amongst all learn-

The aim is to eliminate exclusion that is a consequence of attitudes and responses to diversity in race, social class, ethnicity, religion, gender, and ability. It starts from the belief that education is a basic human right and the foundation for a more just society.

Action 2: Use evidence to identify contextual barriers. It is important to know who is included, who is segregated and who is excluded from schooling. Without an engagement with evidence in relation to all of these forms of exclusion, there can be no accountability.

In particular, the views of young people must be sought and valued, particularly those from at-risk groups. Their voices can challenge policy makers and practitioners to find more effective ways of ensuring that all children are included.

Action 3: Support teachers in promoting inclusion. Countries where teachers believe their profession is valued show

higher levels of equity in learning outcomes. Therefore, schools need to be reformed and practices need to be improved in ways that lead teachers to feel supported in responding positively to student diversity - seeing individual differences not as problems to be fixed, but as opportunities for enriching learning.

Action 4: Design the curriculum with all learners in mind. In an education system based on the principle of inclusion, all students are assessed on an ongoing basis in relation to their progress through the curriculum.

This allows teachers to respond to a wide range of individual learners, bearing in mind that each learner is unique. It means that teachers and other professionals must be well informed about their students' characteristics and attainments, while also assessing broader qualities, such as their capacity for co-

in ways that will engage all learners. Movement towards inclusion is likely to require some restructuring of education provision. Such changes may be resisted by some of those involved, not least parents who understandably want to do the best for their own children. It is therefore essential to have a shared commitment amongst senior staff at the national, district and school levels

to value differences, invest in collaboration, and commit to providing educational opportunities that are inclusive.

Action 6: Involve communities in promoting inclusion. Governments need to mobilise human and financial resources, some of which may not be under their direct control. Forming partnerships among key stakeholders who can support the process of change is therefore essential.

The engagement of families is particularly crucial. In some countries, parents and education authorities cooperate closely in developing community-based programmes for certain groups of learners, such as those who are excluded because of their gender, social status or impairments.

What does this mean for future developments?

These six actions mean that governments must make a clear and genuine commitment to inclusion, emphasizing the benefits for parents and children, and for the community at large.

Here, it is useful to distinguish between needs, rights and opportunities. While all learners have needs (e.g. for appropriate teaching), they also have the right to participate fully in a common social institution (that is, a local mainstream school) that offers them a varied range of relevant opportunities.

Too often, parents are forced to choose between ensuring that their child's needs are met (which sometimes implies placement in a special school or separate classroom) and ensuring that they have the same rights and opportunities as other learners (which means placement in a mainstream school).

Just to add, like all major policy changes, progress in relation to inclusion requires an effective strategy for implementation. In particular, it requires new thinking that focuses attention on the barriers experienced by some children.

Overcoming such barriers is the most important means of development forms of education that are effective for all children. Inclusion becomes a way of achieving the overall improvement of education systems.

MILING can be an expensive venture in Africa as the continent continues to grapple with several challenges. Access to energy is dismal, a situation that stifles social and economic growth on the

But the continent will likely ultimately have something to smile about, given the formal operationalisation of the partnership between the United Nations Development Programme (UNDP) and leading energy conglomerate Sahara Group.

The collaboration, which was sealed during one of the side events at the recently concluded 74th United Nations General Assembly, portends a brighter future for access to reliable, safe and affordable energy in Africa.

The partnership's overarching goal is to create access to clean and affordable energy in Africa, with a commitment to providing access to clean and affordable energy for 10 million households on the continent.

This is hinged on the fact that sub-Saharan Africa has the lowest energy access rates and, paradoxically, the highest percentage of untapped hydropower potential in the world - at a meagre 11 per cent utilisation capacity.

Ultimately, it is hoped, the platform will galvanise the political momentum needed to record significant progress through strong partnerships, effective regulation and mutual accountability. This will, in turn, lead to the implementation of country-specific energy projects in selected countries.

Over 600 million people in Africa have no access to electricity. This is one indicator the UNDP-Sahara Group partnership hopes to address. Indeed, the UNDP-Sahara partnership is of fundamental importance as it will provide a model for engaging a wide range of stakeholders in addressing the continent's energy-related challenges in line with the SDG framework. This couldn't be truer.

It is noteworthy that the partnership involves Sahara Group whose affiliate, Sahara Power Group, operates the largest privately owned power business in sub-Saharan Africa.

Mvomero district farmers revives coffee growing

FARMERS in Mgeta Division, Mvomero District, Morogoro Region have resolved to revive coffee growing as a cash crop, the activity they used to do in the

Coffee farming in Mgeta Division was famous four decades ago but stopped in the early 2000s after many farmers opted for crops that brought in quick monetary returns as compared to coffee.

Speaking at an entrepreneurship training in various businesses including coffee growing to 35 groups in Bunduki Ward in the district, the Ward's Councilor Prosper Mkunule said they have already planted 30,000 coffee seedlings.

He said in the past coffee farming helped in environment preservation and water sources protection, and due to ensuing environment destruction and climate change they have decided to revert to coffee growing.

He said the crop lost its lustre in the 2000s when people started growing tomatoes, cabbages and fruits whereby many youths uprooted the coffee trees and planted fruits and vegetables instead

The Director of Community Development Trust Fund (CDTF) Henry Ngingi said they have decided to revert to coffee in Mgeta so as to make it sustainable

and reduce the incidences of forest fires that cause environmental pollution.

Mgingi said to start with they set aside 6m/- for training the 35 groups in Mgeta and Bunduki wards on entrepreneurship skills conducted by various experts as well as for preparation of seed beds which have already been planted.

He said CDTF in partnership with Tanzania Coffee Research Institute (Tac-Ri) supplied the seeds and other equipment to the said groups.

"Here in Mgeta the climate is the same as that of Kilimanjaro hence the main cash crop was coffee, people were educated by incomes from coffee but in 2000s when tomatoes came in, local people started to uproot coffee trees to give way to tomatoes, hence we are helping in bringing coffee back," said CDTF Director.

On his part the chairman of Tugendelele Group Stephen Msimbe said after they were supplied with seeds and other equipment TacRi and CDTF, the seedlings they had grown would be distributed to growers in Mgeta for plant-

Speaking to members of the 35 groups the Chairman of CDTF Board of Directors Eng Leon Msimbe, who is also chairman of Tugendelele Group said they have decided to support the government's efforts in assisting them in coffee production.

'Vehicle fires are usually caused by more often by problems with electrical wiring and fuel system'

WHILE some vehicle fires are usually caused by collisions, they are more often caused by problems with a vehicle's electrical wiring, fuel system or even cigarettes left in the car, leaving the engine to catch fire. The best line of defence is to have these systems checked out at every service call.

Tanzania's Fire and Rescue Force has clarified on the causes

of vehicles catching fire while travelling on the roads and how to prevent such disasters.

Speaking at the weekend in an interview, the Force's Assistant Inspector Elnimo Shang'a explained that the main causes of vehicles catching fire are faults of electrical and fuel systems that are not thoroughly inspected before the journey.

These, he mentioned, are the engine, battery, and fuel injection shstems. He called on drivers to Force, Road Traffic Division is col-

ensure that the systems are working properly as well as having fire extinguishers in their vehicles that have been certified to be in working order including having

"The fire extinguishers in vehicles must be serviced at least once per year. We usually inspect them, but many motorists carry them just to avoid being fined by the traffic police," Shang'a said.

Trump allies sought Ukraine gas deal

S Rudy Giuliani was pushing Ukrainian officials last spring to investigate one of Donald Trump's main political rivals, a group of individuals with ties to the president and his personal lawyer were also active in the former Soviet

Their aims were profit, not politics. This circle of businessmen and Republican donors touted connections to Giuliani and Trump while trying to install new management at the top of Ukraine's massive state gas company. Their plan was to then steer lucrative contracts to companies controlled by Trump allies, according to two people with knowledge of their plans.

Their plan hit a snag after Ukrainian President Petro Poroshenko lost his reelection bid to Volodymyr Zelenskiv, whose conversation with Trump about former Vice President Joe Biden is now at the center of the House impeachment inquiry of Trump.

But the effort to install a friendlier management team at the helm of the gas company, Naftogaz, would soon be taken up with Ukraine's new president by US Energy Secretary Rick Perry, whose slate of candidates included a fellow Texan who is one of Perry's past political donors.

It's unclear if Perry's attempts to replace board members at Naftogaz were coordinated with the Giuliani allies pushing for a similar outcome, and no one has alleged that there is criminal activity in any of these efforts. And it's unclear what role, if any, Giuliani had in helping his clients push to get gas sales agreements with the stateowned company.

But the affair shows how those with ties to Trump and his administration were pursuing business deals in Ukraine that went far beyond advancing the president's personal political interests. It also raises questions about whether Trump allies were mixing business and politics just as Republicans were calling for a probe of Biden and his son Hunter, who served five years on the board of another Ukrainian energy company, Burisma.

On Friday, Trump told a group of Republican lawmakers that it had been Perry who had prompted the phone call in which Trump asked Zelenskiy for a "favor" regarding Biden, according to a person familiar with Trump's

Trump's remarks were first reported Saturday by the news site Axios.

While it's unclear whether Trump's remark Friday referred specifically to the behind-the-scenes maneuvers this spring involving the multibillion-dollar state gas company, The Associated Press has interviewed four people with direct knowledge of the attempts to influence Naftogaz, and their accounts show Perry playing a key role in the effort. Three of the four spoke on condition of anonymity for fear of retaliation. The fourth is an American businessman with close ties to the Ukrainian energy sector.

A spokeswoman for the US Energy Department said Perry, a former Texas governor and Republican presidential candidate, was not advancing anyone's personal interests. She said his conversations with Ukrainian officials about Naftogaz were part of his efforts to reform the country's energy sector and create an environment in which Western companies can do business.

Perry was asked about the AP's reporting on Monday while in Lithuania, where he was meeting with officials from Ukraine and other eastern European countries to discuss energy security and cooperation. He said any suggestion that he tried to force a management change at Naftogaz was a "totally dreamed up story."

"We get asked for our recommendations about people who are experts in areas, various areas," Perry said. "Folks who have expertise in particular areas. Obviously having been the governor of the state of Texas, I know a lot of people in the energy industry."

Perry also confirmed he had urged Trump to call Zelenskiy, but said the subject was the potential growth of Ukraine's energy sector.

"Absolutely, I asked the president multiple times, 'Mr. President, we think it is in the United States' and in Ukraine's best interest that you and

sations, that you discuss the options that are there," Perry said, recounting his conversations with Trump.

The Trump and Giuliani allies driving the attempt to change the senior management at Naftogaz, however, appear to have had inside knowledge of the US government's plans in Ukraine. For example, they told people that Trump would replace the US ambassador there months before she was actually recalled to Washington, according to three of the individuals interviewed by the AP. One of the individuals said he was so concerned by the whole affair that he reported it to a US Embassy official in Ukraine months ago.

THE BUSINESSMEN

Ukraine, a resource-rich nation that sits on the geographic and symbolic border between Russia and the West, has long been plagued by corruption and government dysfunction, making it a magnet for foreign profiteers.

At the center of the Naftogaz plan, according to three individuals familiar with the details, were three such businessmen: two Soviet-born Florida real estate entrepreneurs, Lev Parnas and Igor Fruman, and an oil magnate from Boca Raton, Florida, named Harry Sargeant III.

Parnas and Fruman have made hundreds of thousands of dollars in political donations to Republicans, including US\$325,000 to a Trump-allied political action committee in 2018. This helped the relatively unknown entrepreneurs gain access to top levels of the Republican Party – including meetings with Trump at the White House and Mar-a-Lago.

The two have also faced lawsuits from disgruntled investors over unpaid debts. During the same period they were pursuing the Naftogaz deal, the two were coordinating with Giuliani to set up meetings with Ukrainian government officials and push for an investigation of the Bidens.

Sargeant, his wife and corporate entities tied to the family have donated at least US\$1.2 milthe Trump Victory Fund, accord-



In early March, Fruman, Parnas and Sargeant were touting a plan to replace Naftogaz CEO Andriy Kobolyev with another senior executive at the company, Andrew Favorov, according to two individuals who spoke to the AP as well as a memorandum about the meeting that was later submitted to the US Embassy in Kyiv, formerly known as Kiev.

Going back to the Obama administration, the US Energy Department and the State Department have long supported efforts to import American natural gas into Ukraine to reduce the coun-

try's dependence on Russia. The three approached Favorov with the idea while the Ukrainian executive was attending an energy industry conference in Texas. Parnas and Fruman told him they had flown in from Florida on a private jet to recruit him to be their partner in a new venture to export up to 100 tanker shipments a year of US liquefied gas into Ukraine, where Naftogaz is the largest distributor, according to two people briefed on the

During this meeting, Parnas again repeated that Yovanovitch, the US ambassador in Kyiv, would soon be replaced, according to a person with direct knowledge of the gathering. She was removed two months later.

Giuliani, who serves as Trump's personal lawyer and has no official role in government, acknowledged Friday that he was among those pushing the president to replace the ambassador, a career diplomat with a history of fight-

experts identify main drivers behind China's historic transformation

HOW did the People's Republic of China (PRC) transform itself from an impoverished country on the brink of economic collapse into the world's second largest economy in merely seven decades?

Many were asking themselves this question when the PRC celebrated its 70th founding anniversary on Oct. 1.

Hardworking people, political stability, reform and opening-up are among the top factors that enabled the "China miracle," said a group of veteran U.S. experts on the Asian country in recent interviews with Xinhua.

DRIVING PRINCIPLES

China has made two "equally important historic transformations" in the past 70 years alongside its remarkable economic development -- China's "pro-active engagement" with the world community and its "remarkable success in poverty alleviation," said Robert Kuhn, 75, chairman of the Kuhn Foundation.

As regards the remarkable economic development undergirding the two historic transformations, Kuhn said it can be attributed to a set of "driving principles."

Among them, he observed, are a people working long and hard to improve the lives of their families and the destiny of their country, and a system that enforces

political stability and encourages economic freedom.

Also on Kuhn's list are a vision that sets long-term goals, midterm objectives and short-term policies that are monitored and modified continuously, a way of thinking that emphasizes experimentation before implementation, and a willingness to admit and correct errors.

"The free trade zone in Shanghai was operated for three years before the free trade zones were opened in other cities, now more than a dozen, including all of Hainan Province," he said.

"Not just foreigners, I guess for most Chinese people themselves, they had never imagined their country could develop so fast," said Ezra Vogel, 89, a professor emeritus at Harvard University.

"I see Chinese people's livelihood get better year after year," said Vogel, who has been traveling to China "at least once a year" since the 1980s.

During his latest trip in November 2018, he took a bullet train from Beijing to eastern China's Shandong Province, and found the experience "very good."

In Vogel's opinion, China's economic take-off was a direct result of its reform and opening-up policy -- a "terrific decision" made by late Chinese leader Deng Xiaoping in 1978, as the country has since been growing by leaps and

Vogel spent 10 years studying Deng and turned this effort into a book titled "Deng Xiaoping and the Transformation of China." Published in 2011, the over 900-page tome has provided a window for Westerners to gain a better understanding of modern

Vogel believes education has played a vital part in China's success. "The students (who) got enrolled into college (in China) after 1978 were very brilliant," he said. "Their modern way of thinking has brought great changes to the country."

Unlike the former Soviet Union, Vogel said, China has never been afraid of sending tens of thousands of young people to study abroad, which is part of the capacity-building strategy spearheaded by Deng.

"The Communist Party of China (CPC) has done the right thing," said Henry Lee, 81, a forensic expert and professor at the University of New Haven.

"Uniting all the forces that can be united, concentrating on major tasks, pursuing economic development and leading the people to common prosperity is the only correct path for China," he

Praising the "flexibility amongst China's leaders," Sarwar Kashmeri, an adjunct professor of political science at Norwich University, said: "I cannot even imagine how difficult it must have been for a leader of China to (reform and open up) a completely inward looking economy."

"That must have taken so much

courage and so much flexibility ... and to put all of that together into a strategy, which perhaps didn't all come together at one time. But block by block it came together,"

CHINESE PHILOSOPHY AND UNIFIED LEADERSHIP

Looking back at the PRC's history, two major events had changed the country's destiny, said James Hsiung, 84, a professor of politics and international law at New York University.

The successful test of its first atomic bomb in 1964 had made countries including the United States begin to "treat China differently," while the reform and opening-up in 1978 has enabled China's economy to develop "at an unprecedented speed," said Hsiung, who just came back from China in August.

"Much of China's success has been due to its ability to combine two 'opposing' systems -- socialism and market economy and make them mutually reinforcing. To put it simple, 'one plus one is more than two," he said.

"This original idea is originated from the Chinese culture and philosophy," he said. From a Western point of view, he said it was hard to believe that socialism and a market economy could be com-

As "a fundamental concept in Chinese philosophy and culture," the two opposites of yin and yang "attract and complement each other," said the professor, who was born in China's central province of Henan. "The success of the socialist market economy is precisely a result of the wisdom of Chinese philosophy."

"It is undeniable that China's splendid success proves Western capitalism is by no means the only option for a country's development," he said.

Another important factor that led to the success of China's reform and opening-up is "the unified leadership" of the ruling CPC,

Hsiung said. The CPC is "both China's 'mind' and 'heart," and "its unified leadership" guarantees an effective implementation of national policies from the central government on local levels. "This is something totally different from how divided and weak China was before 1949,"

Apparently, China's remarkable achievements in the past 70 years also "made it clear" that Chinese culture and philosophy "got many advantages in national political and economic governance and the Chinese people have every reason to be confident and proud about their history and culture," Hsiung said.

"Without a strong economic foundation, China would not have an important position on the world stage today," said Lee. "China has its own national conditions and must have a political system suitable for China's development."

"Weak countries have no diplomacy, and there must be a strong backing for diplomacy. Therefore, China needs not to be afraid of being criticized by others and does its own things earnestly," he said. "Only by doing so can a strong China have a say in the world."

Kashmeri, also a Foreign Policy Association fellow, attributed China's unprecedented rapid development to its "own way of governing -- socialism with Chinese characteristics."

"I believe a lot of the (Western) theories that have been used to analyze China have been very selfserving," Kashmeri said.

"It should be understandable that China has its own way of governing," he said. "As far as I know, it (China) is not interested in taking its way and changing every country in the world."

"China now is a place that has gleaming infrastructure -- that's the envy of the world. It's a place that is dynamic. It's a place that's energetic," said James Heimowitz, president of the New York Citybased China Institute, who has lived 45 years in China.

"It's a place that knows how to respect its history. But it's not trapped in living in the past. And it's still looking to the future," he Xinhua

UN in the red and staff salaries at risk

NEW YORK

The United Nations has an overall annual operating budget of several billion dollars, covering everything from humanitarian work to disarmament, but right now, it's just trying to make sure its employees get paid after this month.

How did the world body end up more than \$200 million in the red?

The answer: member states who have not paid their expected contributions, including the United States. On Tuesday, Secretary-General Antonio Guterres warned of the "worst cash crisis facing the United Nations in nearly a decade."

He cautioned the UN "runs the risk of depleting its liquidity reserves by the end of the month and defaulting on payments to staff and vendors."

Not paying up

Several member states are behind in their dues payments. The UN will not publicly identify those countries, but sources told AFP the main culprits are

the United States, Brazil, Argentina, Mexico and Iran. In all, 64 countries owe money to the UN. Also on the list of budget delinquents are Venezuela, North Korea, South Korea, the Democratic Republic of Congo, Israel and Saudi Arabia. The last country to have paid up is war-wracked Syria, UN spokesman Stephane Dujarric said Tuesday at his daily press conference.

In a letter sent on Monday to the 37 000 employees at the UN secretariat, which was obtained by AFP. Guterres said the UN had a deficit of \$230m as of the end of September. On Tuesday, he indicated that if the world body had not taken the initiative to cut spending since the start of the year, the hole would have been even bigger in October - possibly \$600m and could have affected last month's General Assembly attended by world leaders.

Travel cuts

In his statement on Tuesday, Guterres thanked the 129 member states who have paid up "and urged those who have not paid to do so urgently and in full." To limit expenditures from now until year's end, the UN chief has raised the possibility of postponing conferences and meetings, limiting all but essential official travel, and reducing services.

A UN official speaking on condition of anonymity said Guterres had raised the budget issues with member states as early as this past spring, asking them to pay up, but they refused. Not including what it pays for peacekeeping operations, the UN's operating budget for 2018-2019 is close to \$5.4 billion (R84bn), with the United States contributing 22%. The portion still owed? Nearly \$1.4 billion.

Washington is also the largest contributor to the UN peacekeeping tab. President Donald Trump's administration has taken a hard line on UN funding, cutting contributions and pushing for cost-saving

Equity Bank Group is set to get a Sh13 billion discount on its purchase of four banks in Rwanda, Zambia, Mozambique and Tanzania from a Londonlisted investment group.

Atlas Mara Limited says through its trading report to the London Stock Exchange (NSE) that it marked down the value of the four banks after the Equity Bank deal prompted a due diligence on their financial health.

Equity Bank will offer 6.72 percent of its shares worth Sh10.9 billion to Atlas Mara, meaning that the valuation of the four banks dropped by more than half. This is a reflection that Atlas had weak

The Kenya lender is set to acquire Atlas via a share swap. It will get 62 percent of the share capital of Rwanda's Banque Populaire du Rwanda and 100 percent of African Banking Corporation of Zambia, African Banking Corporation Tanzania and African Banking Corporation Mozambique.

The lower valuation was big enough to drag Atlas Mara into a net loss of nearly the same amount (Sh13.1 billion) in the half year ended June, according to a trading update by the multinational. Atlas Mara says the deal with Equity triggered a re-measurement of the value of the four banks "to the lower of cost or fair value less cost to sell, resulting in a loss of \$125.6 million (Sh13 billion).'

As a result of this re-measurement. the group reported a net loss after tax for the first half of 2019 of \$126.4 mil-

The four banks to be acquired by Equity had a total of 2,641 employees in 2018 while their customer base and loan book in the same period stood at 822,000 and Sh51.8 billion respectively. They also had deposits of Sh96 billion in the review period.

Mauritian banks are among foreign institutions that lost significant deposits as Kenyans yanked their capital from overseas markets to take advantage of a tax amnesty that ended in June.

Kenyans have wired back some Sh1 trillion from offshore accounts in the past three years, according to the Kenya Revenue Authority (KRA). The returned cash was not to be taxed, according to the amnesty.

Banks in Mauritius have reported significant cash outflows from the policy, revealing that the island nation was one of the top offshore investment destinations for wealthy Kenyans. "With the introduction of the Kenyan amnesty earlier this year, the bank also lost some offshore US dollar

However, the Kenyan market remains a core one for the bank," Port Louis-based Bank One says in its latest annual report. "The financial services sector in Mauritius will continue to consolidate with the impact of ... Kenya Amnesty Scheme now being strongly felt.

"The sector will have to innovate and come up with new services to stay competitive and relevant." The report by the bank in which Kenya's banking group I&M Holdings has a 50 percent stake, covers the year ended December 2018.

Mauritius is seen as attractive to foreign investors because of its favourable tax system. Individuals earning incomes of up to Sh1.9 million, for instance, pay tax at the rate of 10

Financial services offered in Mauritius include bank deposits and investments in global assets such as equities, bonds, hedge funds and private equity. Under the legal amendments allowing the amnesty, funds transferred back to Kenya were exempt from the provisions of Proceeds of Crime and Anti-Money Laundering Act, 2009 or any other Act relating to reporting and investigation of financial transactions.

They will be able to transfer money to mobile network operators up to 2m/-, transfer money from NMB account to other banks, pay bills for free, withdraw cash without an ATM card, and make payment of goods and services at Mastercard QR and Visa on mobile payment points," Mponzi said.

He pointed out that the new brand name for the bank's mobile platform is aimed to ensure that all Tanzanians, from all walks of life can resonate with the mobile banking services and be able to access NMB's banking services easily in the palm of their hands.

FirstRand chair mystified by S. Africa government

JOHANNESBURG

FirstRand chair Roger Jardine says "government's apparent unwillingness to champion the private sector as a growth engine is mystifying". Writing in the 2019 integrated report of the country's largest banking group by market capitalisation, he insists that "there is no plausible plan for South Africa to prosper without the private sector playing a strong role in creating sustainable growth."

It is "time for government to partner with the private sector to drive the developmental agenda", he says. "The private sector has the incentive, skills and resources to build businesses that employ people and build the wealth of the country. It cannot, however, do it on its own. It needs a government that creates policy certainty, is not distracted by trying to keep failing SOEs [state-owned enterprises] afloat and/or running sectors of the economy that can be done more efficiently by the private sector." Jardine is not one to mince his words.

FirstRand has always allowed its chairs to weigh in on matters of national interest, often with a blunt and honest assessment, in the annual report. Last year, then-new chair Jardine used his letter to comment on land reform, income inequality and "broken" SOEs. In 2017, former chair Laurie Dippenaar debunked the myths that local banks are 'too big' and anticompetitive, and that they 'refuse' to transform.

Jardine argues that South Africa's skills and expertise are concentrated in the private sector: "It provides 79% of the country's employment and contributes approximately 50% to the fiscal purse through corporate tax [around 19%] and personal income tax paid by its employees [some 31%].

"FirstRand Bank alone paid R8.5 billion in tax this year. Leveraging private sector balance sheets for infrastructure initiatives can work, as shown by the Renewable Energy Independent Power Producer Procurement programme, where R210 billion was mobilised from the private sector."

He is however under no illusion that a partnership between government and the private sector on its own will be a panacea for growth. He says a "deep reform in the public service must also be implemented." The ability of any state to deliver on its agenda is directly determined by the strength of the public bureaucracy."

The tendency of government to plan itself into paralysis is also criticised by the banking group's chair. "The list of reforms that are necessary has been debated for too long. It includes: policy certainty, increasing competition, [SOEs], reforming improving education, improving health care,

stabilising the electricity supply, expanding road networks, allocating spectrum, developing the tourism industry, developing the agriculture sector, and the list goes on.

"We could also add incentives to lift exports and decrease imports, and provide title deeds to more South Africans. More than one plan to deliver on these reforms has been drawn up and debated, only to be replaced by yet another plan."

He says the response to date "by government and policymakers is, to be frank, perplexing - particularly its current allocation of the country's scarce resources. Effective resource allocation matters profoundly to developing countries, especially when there is little to waste. It's obvious that expenditure must be reined in, and each rand spent needs to generate either a social or an economic return (ideally both). Sadly, too much of government's expenditure delivers neither and, if we continue on this road, it will bankrupt the country."

Jardine cites the proposal for national health insurance (NHI) as just the latest evidence of government's "desire for state-led solutions." He says he is "reasonably confident that it will be very hard to find a South African who does not agree on the desirability of universal access to health care."

"It is, however, incomprehensible that government can propose new NHI legislation without a detailed grasp of its full financial impact on the country. This is particularly of great concern given the fragility of the country's finances. Important elements of the new policy remain unknown and this creates risk to

further investment in the sector. "Moreover, the country's public healthcare system is in disarray

and the private healthcare industry can play a major role in achieving universal access. A meaningful dialogue between government and the private healthcare sector is required to agree on the mix of policy, regulation and incentives to provide all who live in South Africa access to necessary care without financial or other impediments."

Prescribed assets While the introduction of prescribed assets is "gaining increasing political currency", Jardine makes a strong point about pension liabilities. "We seldom talk about pension fund liabilities (particularly with the emergence of defined-contribution funds), but it's the pension liabilities that are the real issue. The average net replacement ratio in SA pension funds stands at 17% - meaning a pensioner can expect to receive only 17% of their final monthly gross salary when they retire.

"On this basis alone it is reckless to contemplate prescribed assets (often with misaligned risk and return) when we are under-saved as a country."

Three ways to drive growth

Despite all these concerns, Jardine acknowledges President Cyril Ramaphosa's "sustained public commitment to rooting out the corruption that has played its part in the country's fiscal and economic decline."

"However, an anti-corruption strategy is not a growth strategy. Notwithstanding the interventions made to date, government needs to move swiftly with further and substantial reforms to accelerate growth." He offers three obvious examples that would yield meaningful results on the

Africa's six wealthiest cities - and where to find the continent's billionaires

JOHANNESBURG

Johannesburg is the wealthiest city in Africa, according to the 2019 Africa Wealth Report by New World Wealth and Afrasia Bank.

"Total wealth" for the purposes of the report, refers to the total private wealth held by individuals living in each city. It includes all their assets - property, cash, equities and business interests less any liabilities. Government funds are not included in the mix.

Most of this wealth in Johannesburg is concentrated in Sandton - home of the JSE and of head offices of most of Africa's largest banks and corporates.

Cape Town comes in second place on the list with its exclusive Africa remains the wealthiest suburbs such as Clifton, Bishopscourt, Camps Bay and Bantry Bay. It is also popular among wealthy second homeowners from around the world.

Cairo in Egypt is in 3rd place. It is home to more billionaires than

any other African city. For the purposes of the report, billionaires are defined as individuals with net assets of \$1bn or more. Lagos in Nigeria is in 4th position. It is also the largest city in Africa in terms of population and gross domestic product - but not in terms of wealth.

In 5th place is Durban (including Umhlanga). It is one of the fastest growing areas in SA in terms of wealth growth over the past 10 years, according to the report. In 6th place is Nairobi in Kenya. It is the economic hub of East Africa and one of the fastest growing cities in the world.


SA the wealthiest country According to the report, South country in Africa in terms of total wealth. Next up is Egypt, followed by Nigeria, Morocco, Kenya, Angola, Ghana, Ethiopia, Tanzania and Ivory Coast. The report notes that larger countries obviously have an advantage in this regard

due to their higher populations.

On an individual basis, Mauritius have the wealthiest people in Africa with an average wealth of \$31 000 (about R465 000) per person. They are followed by South Africans, with an average wealth of \$11 500 (about R172 500) per person. Furthermore, there are 23 billionaires living in Africa, each with assets of \$1bn (more than R15bn) or more.

Total wealth in Africa has risen by 14% over the past 10 years, according to the report. Africa's performance was constrained by poor performance in the three largest African markets, namely South Africa, Egypt and Nigeria.

Total wealth held in Africa is expected to rise by 35% over the next 10 years, reaching \$3trn by 2028. Mauritius, Ghana, Rwanda, Kenya, Ethiopia and Uganda are expected to have the strongest performing wealth markets in Africa over this period.

Trump escalates impeachment fight, barring envoy's testimony

WASHINGTON

ESCALATING his fight against Congress' impeachment inquiry, President Donald Trump flouted Democratic warnings about impeachable conduct Tuesday in blocking a US diplomat from testifying about Trump's dealings with Ukraine.

House committee chairmen quickly issued a subpoena to force the envoy to appear before the House next week and produce documents recovered from his personal devices.

Gordon Sondland, the US European Union ambassador, was barred by the administration from appearing in a closed-door session with three House panels investigating Trump's entreaties to Ukraine. His attorney said Sondland, who had agreed to the interview without a subpoena, was "profoundly disappointed" to be prevented from

Sondland also spoke directly to Trump hours before sending a text message assuring another US envoy that there was nothing untoward about their plans, according to a person familiar with the exchange who spoke on condition of anonymity to discuss the conversation.

Rep Adam Schiff, the House Intelligence Committee chairman, said Sondland's no-show was "yet additional strong evidence" of obstruction of Congress by Trump and Secretary of State Mike Pompeo, Sondland's boss.

Speaking to reporters on Tuesday, Schiff laid out four parameters of the committee's investigation. He said the panel is probing whether Trump solicited foreign help from Ukraine for his 2020 reelection; whether a never-realized White House meeting between Ukrainian President Volodymyr Zelenskiy and Trump was conditioned on Ukraine conducting investigations; whether US military assistance to Ukraine was conditioned on those investigations; and whether the administration has obstructed justice.

Republican Rep. Jim Jordan of Ohio said Tuesday that Trump was simply "doing his job" to prevent corruption in Ukraine. He and other Republicans attacked Schiff for leading what they called an unfair, partisan inquiry.

Across the Capitol, Senate Judiciary Committee Lindsey Graham - one of Trump's staunchest defenders - said he would call the president's personal lawyer Rudy Giuliani to testify about corruption in Ukraine. Giuliani was communicating with Zelenskiy about the investigations that Trump wanted.

"Given the House of Representatives' behavior, it is time for the Senate to inquire about corruption and other improprieties involving Ukraine," Graham said in a tweet.

Giuliani said he was "very interested" in the invitation but would need to review matters of executive privilege and attorney-client privilege before committing to appear.

House Democrats have subpoenaed Giuliani for documents, but Giuliani said he would not cooperate with them.

Text messages released by House Democrats last week show Sondland worked with another of Trump's diplomats, former Ukrainian envoy Kurt Volker, to get Ukraine to agree to investigate any potential interference in the 2016 US election and to probe the Ukrainian energy company that appointed Biden's son Hunter to its board.

There has been no evidence of wrongdoing by Biden or his son.

Covered in blood and bruises, the man was cornered in the metro station while rioters continuously hit him in the five-minute video. Gu's footage "enraged" protesters. They threatened him with malicious comments and messages. Some even wrote they had "daggers ready."

Freedom of speech? Yes, for protesters and those with identical views only. But the answer is no for anyone else. Radical protesters have plastered numerous pieces of graffiti, posters and leaflets on public buildings and shop fronts.

Some urged school children to walk out of class, others carried signs with slander, curses and degrading insults. In Hong Kong these days, even the simple act of cleaning the graffiti and posters takes considerable courage.

MOSCOW has no reason to take steps not included in the UN Human Rights Council's procedures in relation to China's alleged oppression of Muslims in the Xinjiang region, Russian Foreign Minister Sergey Lavrov told reporters following talks with Kazakh top diplomat Mukhtar Tleuberdi yesterday.

"China has repeatedly provided clarifications concerning the accusations you have mentioned. I don't know who voiced them, it must have been our western colleagues," Lavrov said in response to a question.

"We don't have reasons to take any steps apart from procedures that exist within the UN, which I have mentioned, meaning the Human Rights

Council," he added.

The Russian top diplomat pointed out that UN member states used to inform the Human Rights Council of measures to improve the human rights situation under an annual monitoring mechanism. "The monitoring is conducted on an equal basis for each and every country," Lavrov noted.

Xinjiang situation

China's northwestern Xinjiang autonomous territory is populated by Uighurs, most of whom are Muslims. According to the Chinese authorities, separatist groups affiliated with international terrorist organizations are active in the region.

In August 2018, a co-rapporteur from the Office of the United Nations centers and another two million

The authorities did not disclose the number of people residing in those centers.

African countries urged to promote innovative ways to close identity gap

THE United Nations Economic Commission for Africa (ECA) has urged African countries to promote innovative ways to close the existing identity gap across the continent as more than 500 million Africans currently have no legal identity.

The call was made by Oliver Chinganya, Director of the ECA's Africa Centre for Statistics, as he emphasized the need to heavily invest on the promotion of innovative ways so as to close the current legal identity gap across the African content through the provision of all forms of digital identity

"It is important that as a continent we modernize and harmonize civil registration and digital identity systems, which are foundational to legal identity ecosystems," an ECA statement quoted Chinganya as saying on Tuesday.

"Vital statistics systems that enable member States to monitor progress towards the sustainable development goals and Agenda 2063 should be strengthened," Chinganya (pictured) added.

The ECA, which estimated more than 500 million people across Africa have no legal identity, of which about 120 million are children who do not have birth certificates, also emphasized the need to exert concerted efforts to bridge the gap identity. "We need to make sure that we get everyone in the picture.

The ECA made the call ahead of a high-level conference of African ministers responsible for civil registration, slated from October 14 to 18, which is organized by the African Union (AU) in collaboration with the UN-ECA and the African Development Bank.

The high-level ministerial conference will also bring together various UN agencies such as the UN Population Fund, UN Children's Fund, UN High Commissioner for Refugees, as well as World Health Organization.

According to the ECA, the conference "aims to provide strategic and policy guidance on pathways towards holistic, innovative and integrated civil registration and vital statistics and digital identity management sys-

African ministers, who are set to gather from all AU member countries, are also expected "to chart the way forward by identifying key challenges" in the implementation of the Africa Programme on Accelerated Improvement of Civil Registration and Vital Statistics at the regional and national levels and proposing solutions, it was

The continental gathering is also expected to bring about "strong support and commitment from countries and development partners, including the provision of adequate funding and technical support at the regional and country levels, for the continuous strengthening of civil registration and vital statistics systems as the foundation for robust and sustainable legal

identity systems."

The ministers are also expected to reach an agreement on the strategic direction for a comprehensive legal framework, adopting technological innovations, improving interoperability and strengthening institutional capacity and coordination across ministries and agencies for the integrated improvement of civil registration and vital statistics and identity management systems.

According to the ECA, during the conference, AU member states are also expected to declare their commitment to ensuring integrated civil registration and vital statistics and digital identity management systems reach their full potential in line with the global Sustainable Development Goals and the AU's continental development Agenda 2063.

UN chief says UN facing worst cash crisis in nearly 10 years

UNITED NATIONS

SECRETARY-GENERAL Antonio Guterres warned on Tuesday that the United Nations is facing its "worst cash crisis" in nearly a decade because 64 of its 193 members – including the United States, its largest contributor - have not paid their annual dues.

UN spokesman Stephane Dujarric said the secretary-general has written to all members saying "the organization runs the risk of depleting its liquidity reserves by the end of the month and defaulting on payments to staff and vendors."

By the end of September, Dujarric said, member states had paid only 70 percent of the total assessment for the regular budget, compared with 78 percent at the same time last year.

According to the UN, 129 countries had paid US\$1.99 billion in dues for the UN's 2019 operating budget by Tuesday. It said US\$1.386 billion is owed for this year.

In addition to the United States, other countries that haven't paid their dues are Brazil, Iran, Israel, Mexico, South Korea, Saudi Arabia and Uruguay.

Because of the US government's budget calendar, Washington usually pays its dues in October.

According to the UN, the US owes US\$674 million for the 2019 regular budget and US\$381 million for previous

The US is also in arrears in payments for the separate budget for the UN's farflung peacekeeping operations. It owes US\$255 million for peacekeeping missions that have been closed and US\$2 billion for active peacekeeping missions, according to the UN.

Dujarric said measures the UN Secretariat put in place early in the year to align expenditures with cash inflows have averted "major disruptions" but "are no longer enough."

Since the UN Secretariat could face a default in salaries and payments by the end of November, Dujarric said the secretary-general has requested immediate steps including further reductions in official travel and postponing spending for goods and services.

In addition, Dujarric said, events scheduled outside official meeting hours are being discontinued and conferences and meetings may have to be postponed or their services adjusted.

The secretary-general stressed that cash flow is a recurrent problem and the UN is now driven to prioritize work based on cash availability, thus undermining its mandates and obligations "to the people we serve," Dujarric said.

"The secretary-general therefore looks to member states to resolve the structural issues that underlie this annual crisis without further delay," Du-Agencies

China outperforms BRICS counterparts in latest global competitiveness ranking - WEF report

CHINA is by far the best performer among the five BRICS economies in terms of competitiveness, said the World Economic Forum (WEF) Wednesday in the latest annual report assessing the productivity and long-term growth of 141 economies.

China ranks 28th among the world economies, 15 places ahead of the Russia, 32 places ahead of South Africa and some 40 places ahead of both India and Brazil, showed the 2019 Global Competitiveness Report by the WEF.China's position in the ranking was unchanged from last year, but its overreport showed.

The report measured an economy's performance through 103 indicators in 12 "pillars," showing that China has obvious strengths in various areas such as the sheer size of its market, macroeconomic stability, the Information Communication and Technology (ICT) adoption, and increasing innovation capability.

In the ICT Adoption, China outperformed 25 of the 36 member countries of the Organization for Economic Co-operation and Development (OECD).

As to the healthy life expectancy, China scores better than the United

all score increased by 1.3 points, the States and slightly under the OECD average. With a score of 84.8, Singapore took the crown of the world's most competitive economy this year from the United States.

The WEF lowered the U.S. competitiveness to the second place partly due to the country's trade uncertainty, as its trade openness is more than four points lower than that in 2018, according to the report.

China's Hong Kong Special Administrative Region, the Netherlands and Switzerland are among the top five, followed by Japan, Germany, Sweden, the United Kingdom and Denmark the report showed.

UK says chances of Brexit deal slim, EU chides 'blame game'

LONDON

BRITAIN and the European Union traded ill-tempered barbs on Tuesday as the UK said a Brexit deal might be impossible, while insisting it was still working for one with just over three weeks until its scheduled departure from the

British Prime Minister Boris Johnson's office said EU intransigence had led to a breakdown in negotiations, prompting a top European leader to warn against playing a "stupid blame game" - and chide Johnson in Latin.

Johnson's office gave a gloomy assessment after his call with German Chancellor Angela Merkel on Tuesday morn-

In a statement to British media, Downing Street said Merkel had told Johnson that "a deal is overwhelmingly unlikely" unless the UK agreed to let Northern Ireland continue to follow EU customs rules in order to maintain an open border with EU member Ireland.

That is something the British government says it can't accept. Downing Street said that "if this represents a new established position, then it means a deal is essentially impossible not just now but ever." How people and goods will move across the Irish border is the main sticking point to a deal.

The German government confirmed that Merkel and Johnson had spoken but declined to comment on the substance of "confidential conversations."

European Commission spokeswoman Mina Andreeva said "the EU position has not changed. We want a deal. We are working for a deal with the UK."

European Council President Donald Tusk tweeted testily that "what's at stake is not winning some stupid blame

South Korean protesters call for ouster of justice minister

SEOUL, South Korea

THOUSANDS of protesters rallied yesterday in South Korea's capital for the second consecutive week to call for the ouster of President Moon Jae-in's hand-picked justice minister, whose family is at the center of an investigation into allegations of financial crimes and academic favors.

The protest near the presidential palace in Seoul followed a weekend demonstration in which a huge crowd of pro-government supporters occupied streets in front of the state prosecutors' offices to show their support for Cho Kuk, whose appointment last month has deepened the nation's political divide.

The city's streets are now divided between pro-Cho and anti-Cho protesters, who for weeks have alternated with protests and counter-protests in areas separated by the Han River that flows through the capital.

Yesterday's rally came amid a highly-publicized investigation of Cho's university professor wife and other relatives over allegations of shady financial investments and fraudulent activities related to his daughter's admission to a top university in Seoul and a medical school in Busan.

Cho, who previously served as Moon's senior secretary for civil affairs, has denied any wrongdoing and vowed to push ahead with plans to reform the country's justice system, including curbing the powers of mighty state prosecutors, even as they conduct a criminal probe into his family.

Carrying the South Korean flag and banners and signs that read "Arrest criminal Cho Kuk," the protesters poured onto a major boulevard near Gwanghwamun Gate, the same streets where millions marched for months three years ago in unified anger against Moon's conservative predecessor Park Geun-hye. She was removed from office in March 2017 and is currently serving a decadeslong prison term over bribery and abuse of power.

"We need to fight and avenge against a government that has ripped the country in two," Shin Hye-sik, a conservative activist, told the crowd from a stage. "Let's fight! Let's win!"

Chun Gwang-hun, a right-wing Christian pastor and one of the protest organizers, accused the ruling liberals of mobilizing its supporters to defend Cho and called for Moon to step down.

Some of the protesters pushed and shoved with a few Cho supporters who showed up before police broke up the scuffle. There were no immediate reports of major clashes or injuries.

House that his agency's enforcement actions at the border in fiscal year 2019, which involved 977,509 undocumented migrants, are "a staggering 88-percent higher" than those in the previous vear. "These numbers are numbers that

no immigration system in the world is designed to handle," Morgan said. Fiscal year 2019 in the United States ran from Oct. 1, 2018 to Sept. 30, 2019.

The acting commissioner also gave an update on the construction of physical barriers along the U.S.-Mexico border, a signature project for President Donald Trump and a source of political wrestling in Wash-

"To date, a total of 71 miles of new wall has already been constructed," Morgan said. "By the end of 2020, CBP expects to have approximately

"This is unprecedented in terms of what all of us are facing as a community," PG&E Vice President Sumeet Singh said at a media briefing Tuesday night. "We are doing everything we can to minimize the impact on our customers' lives.'

The shutoff will occur in three phases, with the first impacting

Wednesday, the company said in a statement. The second stage will occur around noon and affect 234,000. The last phase is being considered for the southernmost portions of PG&E's service area, impacting 42,000.

As California's climate warms and dries, the massive blackouts could become a new, annual ordeal. The shutoff warning came two years to the day after wildfires tore through Napa and Sonoma counties, and 11 months after one of PG&E's transmission lines triggered the Camp Fire, which leveled the town of Paradise and killed 86 people.

Meanwhile, Edison International's Southern California Edison utility said it was weighing cutting power to 106,000 homes and businesses, most of them in the mountains east of Los Angeles.

Within the Bay Area blackout zones, residents were rushing Tuesday to buy food, water and electric generators -- almost as if a hurricane were approaching. Stores including Rite Aid and Target across Oakland had run out of flashlights and most batteries.

Public officials tried to assure residents that essential services would still be available, while ask-

ing them be prepared regardless. The section of PG&E's website where people can check their home's status was so inundated that it was inaccessible for much of Tuesday afternoon.

PG&E said its website had received eight times the amount of normal traffic and it would work through the night to get it up back online. As an alternative, the company had posted outage maps for the 34 counties on its Twitter

Chinese organisers cancel NBA fan event amid free speech row

HINESE organisers yesterday cancelled a fan event on the eve of an National Basketball Association (NBA) exhibition game in Shanghai, the latest fallout in a row over comments by a team official supporting protests in Hong Kong.

Chinese sponsors and partners have been cutting ties with the NBA after a tweet by Houston Rockets general manager Daryl Morey last week supporting anti-government protests in the Chinese-ruled city.

Shanghai Federation said the cancellation of the fan event ahead of Thursday's game between the Brooklyn Nets and Los Angeles Lakers was due to the "inappropriate attitude" of Morey and NBA Commissioner Adam Silver.

A Wednesday afternoon press conference with both teams was indefinitely delayed, organisers said. Outside the team hotel, workers tore down massive banners advertising the game, according to a Reuters witness.

Silver said on Tuesday the league supported Morey's right to exercise his freedom of expression, further angering authorities and some fans in China and threatening the NBA's business there, said to be worth more than \$4 billion.

Morey deleted the tweet and apologised on Monday, but Chinese broadcasters, sportswear companies and sponsors have said they are reviewing their ties with the NBA, which has had a presence in China since 1992.

The NBA initially described

the anger over Morey's post as the U.S.-China trade war, which from U.S. politicians, who accused the league of putting its China business ahead of free

Silver, speaking on Tuesday in Japan before a preseason game between the Rockets and Toronto Raptors, said it was not up to the league to regulate what players, employees and team owners said.

Column: Freedom of speech has its consequences for NBA

IF the NBA really wanted to make a statement it should have never issued a statement, much less two.

No need to complicate things when two team owners had already genuflected to the irate citizens of China. Or when James Harden took it upon himself to apologize to an entire nation.

The simple path for the NBA was to do what the creators of the show South Park did this week after finding themselves caught between an authoritarian regime that tolerates no dissent and the pile of cash that doing business in China can bring.

Admit what is really important. "Like the NBA, we welcome the

Chinese censors into our homes and into our hearts," Trev Parker and Matt Stone said in a statement of their own. "We too love money more than freedom and democracy."

Talking about plans for her businesses, which include beauty products and shapewear, Kardashian said she was considering opening a factory and investing in Armenia, which her ancestors left for the United States at the beginning of the 20th century.

"I'm excited as tonight I have a meeting and I'm gonna talk about future investments and opening up a factory here and how to really bring this (business) to Armenia," Kardashian said about her plans in the ex-Soviet country.

Kardashian, who has over 60 million followers on Twitter, said she was very determined to complete her studies as a lawyer, although it was "challenging for her" due to her tight schedule.

She wants to promote the hiring of ex-prisoners so they are able to return to the work-

"Some of the (most) enlightened people I've ever met, smartest people, people that know law the best, are people that are spending time in prison," said Kardashian, who in the past has talked about her vocal support for criminal justice reform.

The reality-star-turned-activist said she had no plans to enter politics and does not want to have any more children with her musician husband Kanye West.

Chinese organisers cancel NBA fan event amid free speech row

HINESE organisers yesterday cancelled a fan event on the eve of an National Basketball Association (NBA) exhibition game in Shanghai, the latest fallout in a row over comments by a team official supporting protests in Hong Kong.

Chinese sponsors and partners have been cutting ties with the NBA after a tweet by Houston Rockets general manager Daryl Morey last week supporting anti-government protests in the Chinese-ruled city.

Shanghai Federation said the cancellation of the fan event ahead of Thursday's game between the Brooklyn Nets and Los Angeles Lakers was due to the "inappropriate attitude" of Morey and NBA Commissioner Adam Silver.

A Wednesday afternoon press conference with both teams was indefinitely delayed, organisers said. Outside the team hotel, workers tore down massive banners advertising the game, according to a Reuters witness.

Silver said on Tuesday the league supported Morey's right to exercise his freedom of expression, further angering authorities and some fans in China and threatening the NBA's business there, said to be worth more than \$4 billion.

Morey deleted the tweet and apologised on Monday, but Chinese broadcasters, sportswear companies and sponsors have said they are reviewing their ties with the NBA, which has had a presence in China since 1992.

The NBA initially described

the anger over Morey's post as the U.S.-China trade war, which from U.S. politicians, who accused the league of putting its China business ahead of free

Silver, speaking on Tuesday in Japan before a preseason game between the Rockets and Toronto Raptors, said it was not up to the league to regulate what players, employees and team owners said.

On Wednesday, an editorial in the official English-language China Daily accused Silver of "brazenly endorsing Morey's secessionist-supporting tweet" and giving "a shot to the arms of the rioters of Hong Kong."

"If Silver thinks endorsing the indiscriminate violence the radical Hong Kong protesters are resorting to ... is supporting freedom of expression, then he should think again," it said.

The protests were "a bid to liberate the city" and "a secessionist pipe-dream" peddled by demonstrators the Hong Kong riots are just like "to justify their summer hooliganism," the newspaper

The protests were sparked by opposition to a bill allowing extradition to mainland China, but have since evolved into broader calls for democracy. None of the protesters' five demands is secession or independence.

Some fans expressed dismay at the way the controversy had spread, while voicing their support for Beijing's view.

"I'm patriotic of course. I support that Hong Kong is part of China, but I just don't understand this," said Yu Jie, a outlets across the country, and fan waiting to see the players in Shanghai.

"regrettable," drawing criticism escalated after Washington imposed visa restrictions on Chinese officials on Tuesday.

The Global Times, a Chinese tabloid published by the ruling Communist Party's People's Daily newspaper, accused Silver of caving in to political pressure, saying the NBA was treating the Chinese market with arrogant disregard.

"Tweeting something offensive to the Chinese people before a series of NBA promotional activities in China only shows a lack of intellect, respect, and responsibility," it said.

In a separate report, the newspaper also said that some Chinese internet users had made "disrespectful comments" about the Sept. 11, 2001, attacks on the World Trade Centre in New York and the Pentagon in Washington, D.C.

"(It) should remind Western media that for Chinese people, after the Morey tweet. the 9/11, which is horrible and company distancing itself from can't be justified," the Global Times said.

No one has been killed in several months of protests in Hong Kong, although scores - mostly protesters and journalists - have been hurt. The Sept. 11, 2001, attacks killed 2,996 people and led to the U.S. invasion of Afghanistan.

FALLOUT

Basketball is the most popular sport in China, with about 500 million people consuming NBA content. The league has deals with TV and digital media teams have played exhibition games annually since 2014.

NBA China, launched in 2008

The NBA had planned media events in Shanghai this week ahead of the Nets-Lakers game, but Chinese organisers cancelled an event at a Shanghai school on Tuesday and an open training session with the Nets on Wednesday.

Chinese celebrities had already said they would boycott the "fans' night" before it was cancelled.

State television dropped plans to air the NBA exhibition games in China this week, saying a country's sovereignty and social stability were "not within the scope of freedom of speech." China has accused the West of stirring up anti-Beijing sentiment in Hong Kong.

Some Chinese fans have asked for streaming subscription refunds from exclusive service provider Tencent, which halted broadcast of Rockets games

Tencent isn't the only business dealings with the NBA.

Online travel agency Ctrip said on Tuesday it had stopped selling tickets to NBA games and NBA-related tour packages. Smartphone maker Vivo and sportswear maker ANTA Sports Products Ltd (2020.HK) have also stopped working with the

But the escalating row did not seem to bother some waiting outside Shanghai's Ritz Carlton hotel to catch a glimpse of the NBA players.

"Personal opinions belong to them. It doesn't affect us chasing the stars," Xu Ziyang, a university student from Jiangsu, told Reuters.

Column: Freedom of speech has its consequences for NBA

IF the NBA really wanted to make a statement it should have never issued a statement, much less two.

No need to complicate things when two team owners had already genuflected to the irate citizens of China. Or when James Harden took it upon himself to apologize to an entire nation.

The simple path for the NBA was to do what the creators of the show South Park did this week after finding themselves caught between an authoritarian regime that tolerates no dissent and the pile of cash that doing business in China can bring.

Admit what is really important. "Like the NBA, we welcome the Chinese censors into our homes and

into our hearts," Trev Parker and Matt Stone said in a statement of their own. "We too love money more than freedom and democracy."

The South Park creators, of course, make their millions by being funny. And there's a lot to chuckle about

in a post that, among other things, declares that the leader of China doesn't really look like Winnie the Pooh after all.

There's nothing funny about this for the NBA.

A league that has painstakingly built a reputation for social awareness for the briefest of moments looked no different than any other corporation chasing money in China. A league that embraces personal freedom seemed unable to understand that freedom means something very different in China.

All this while LeBron James and company were speeding their way toward Shanghai and an exhibition game reception that figures to be very different than they were expecting.

If Commissioner Adam Silver's tortured response to the crisis facing the league is any indication, even LeBron will have a hard time

explaining his way out of this one. regret that the Friday night tweet by



Houston Rockets general manager Daryl Morey supporting protesters in Hong Kong had offended the league's friends and fans in China. That not only didn't mollify China which offered a more nationalistic translation for the audience at home – but was attacked on social media as failing to stand up for the right of free

Silver tried again and pretty much Silver's first statement expressed got it right. But that meant further antagonizing a country where the making even bigger profits.

"It is inevitable that people around the world – including from America and China – will have different viewpoints over different issues. It is not the role of the NBA to adjudicate those differences," Silver said. "However, the NBA will not put itself in a position of regulating what players, employees and team owners say or will not say on these issues. We simply could not operate that way."

Give Silver credit for standing up for free speech, albeit a bit late. The commissioner quickly realized how off-tone his first response was and did his best to at least make it sound

Unfortunately for the NBA, though, it's in a lose-lose situation in a country that seems to be aching for a fight.

Workers at a Shanghai gym were seen in a video painting over the Houston Rockets logo, and the team's merchandise has disappeared from stores. State broadcaster CCTV a half century before him.

> will remain a dream. All because of a tweet supporting protesters in Hong Kong, who want nothing more than the same personal liberties that every NBA player and employee enjoy. A tweet that may soon end Morey's employment much the way kneeling during the national anthem ended Colin Kaepernick's time in the NFL.

Freedom of speech does have its consequences. There's a price paid for speaking out, as Kaepernick found out and as Muhammad Ali did

But the price paid for backing down on values of a league that has led the way on social issues would be even worse. That's why it was critical that while Silver said Tuesday in Tokyo that he was sympathetic to the outrage, the league will stick by its principles of free speech.

Yes, there's a chance the Chinese money may be gone. The exposure carefully cultivated over three decades, too.

But Silver had to take a stand for a right held dear by most Americans. He had no other alternative if he and the league wanted to keep their credibility and self-respect.

At least no alternative as funny as that suggested by South Park's creators after the show seemed to vanish in the Chinese media following an episode in which Pooh and Piglet are jailed in China and mistreated after memes comparing Chinese leader Xi Jinping to Pooh circulated online.
