Tourism-dependent villages struggling following Covid-19

COMMUNITIES surrounding national parks and other protected areas whose livelihoods depend on tourism income are struggling to make end meet due to ripple effects of the Covid-19 pandemic.

Wildlife Management Areas (WMAs) in the northern tourism circuit are among the hardest hit by the pandemic, which paralyzed economic activities, especially in the tourism sector.

If the situation of the Burunge WMA in Babati District, Manyara Region is anything to go by, then the villages have lost around a third of their expected annual incomes.

Speaking to journalists during a recent study tour, Burunge WMA secretary Benson Mwahise said incomes of 10 villages surrounding the area have dropped from 103m/- each in 2019 to 76m/- this year due to low tourist arrivals.

The monies are collected from tourism agencies as village fees and disbursed to villages for development projects in

view of encouraging villages to engage in conservation efforts, he said.

Burunge WMA collected 2.3bn/- in the 2018/2019 fiscal year but only a fraction of that is expected this financial year following the Covid-19 pandemic, he

The tour was organized by the Journalists Environmental Association of Tanzania (JET) and the United States Agency for International Development (USAID).

"The number of visitors is still small compared to those who visited the area between April and June last year. We also appreciate the government's efforts in promoting tourism as we have started receiving local visitors," he further noted.

The generated income is spent by villagers on improvement of community social services in education, health, water and roads, he stated.

Conservation efforts have resulted in an increased number of wild animals, as the Burunge WMA encompasses a whole range of wild animals with the exception

JPM tasks ministers on delayed Uvinza projects

PRESIDENT John Magufuli yesterday took three ministers to task over delays in implementation of major development projects under their dockets and directed them to complete works on progress before polling day on October 28.

Addressing a campaign rally in Uvinza District in Kigoma Region, where he made some stops on his way to Tabora from Kigoma, Dr Magufuli tasked the minister in the President's Office (Regional Administration and Local Governments), Suleiman Jafo to disburse 5bn/-

In the next five year, the govt plans to transform the district to a modern trading centre by properly built road connections

for the construction of a 10 kilometer road in the

Dr Magufuli who said he was speaking as president, also directed Trade and Industries minister Innocent Bashungwa to work on facilitating the Uvinza Salt Factory so that it can produce more salt which will be exported to other countries, thus enhancing job creation.

He also expressed his dissatisfaction with the implementation of a rural electrification project in the district, where he directed the Energy minister Dr Medard Kalemani to work on implementing the remaining 61 villages as yet unconnected, as only 17 villages were reached in the past half decade.

"The minister of energy should be informed that am not satisfied with the electrification programme in the district. So he should work on addressing this issue; there is no way people of this district should continue to suffer for

'ADC firm on ending unemployment woes'

ALL;IANCE for Democratic Change (ADC) presidential candidate Queen Sendiga (pictured) says if elected she will ensure she creates 10m jobs in the next five years to eradicate the country's nagging unemployment problem.

Speaking at the weekend during election



campaign rallies in Mkinga and Korogwe districts in Tanga region, she said an ADC-led government will construct infrastructures like roads, improved schools and colleges as well as modernizing agriculture, thus reducing problems in accessing various social services.

ADC will also strengthen the fishing sector and construct many factories for food crops processing in the next five years, she declared, urging the villagers to vote for the party in the October 28 polls.

Speaking about road infrastructures in the two districts, the candidate said she would ensure she joins the districts with Tanga city at tarmac level in order to develop the area's economy. Farmers,

ARUSHA city was thrown into panic at the weekend when another huge elephant stormed Njiro suburb with area residents taking to their heels to save dear lives.

The jumbo entered the southern part of the city on Saturday night, within the same day after another elephant caused confusion here after sending resident helter skelter, and one died trying to follow it and play with its tail.

By late afternoon yesterday, officials of the Wildlife Department were nit responding to explain efforts they were making to drive the animal out of the city.

Hamza Juma Njiku, chairman of Njiro Block J area, where the elephant was seen said that after the animal was spotted "we contacted wildlife officials, but so far nobody has responded in person."

Dr Julius Keyyu, the Director of Research at the Tanzania Wildlife Research Institute (TAWIRI) circulated a message on social media that residents of Njiro must take precautions and not to venture near the elephant which was still loose in their area for hours from early Sunday morning.

This jumbo appearance incident is the second in as many days, suggesting that the animals are in pursuit of some need and trying to use routes that are outside the nearby wildlife conservation areas, as Njiro, Olasiti and other suburbs border vital wildlife corridors.

Some officials suggest that there is a herd of elephants trying to retrace routes

in an extended eco-system stretching from Simanjiro District of Manyara Region to the lower sections of the city.

Early on Friday another jumbo appeared in Korongoni section of Njiro in Lemara Ward, south of the city.

The full grown male elephant caused panic and took the life of a motorcycle rider who tried to play hero in the incident.

Long'ida Mollel (35) reportedly followed the beast into the bush, overlooking the Korongoni gorge, boasting he could control the jumbo. It turned back, lifted him with its trunk and smashed him onto the ground, killing him on the spot.

The Korongoroni area chairman Goodluck Lekanyo and Block J chairman Hamza Juma Njiku castigated the behavior of the motorcycle rider as they approached the jumbo too closely.

Ordinarily wildlife rangers take a paralyzing gun to stun stray large animals to take them back into reserve at a reasonable distance from where the animal was spotted.

While they went off to fetch their equipment, motorcycle riders started to approach the elephant, causing a loss of life. Anti-Poaching Unit officer Michael

Since then he has been a rallying figure for dissent within the ruling party, put to disciplinary suspension early this year, and as his expulsion was imminent at mid-year, shifted to ACT-Wazalendo as a senior adviser and prospective flag bearer in the forthcoming polls.

Records destroyed as fire hits Makerere University

KAMPALA

AUTHORITIES at East Africa's oldest university, Makerere, are struggling to put up p0lans to restore a fire-gutted building to its historic state in the shortest time possible.

Reports said Vice Chancellor Prof Barnabas Nawangwe declared yesterday that the university in cooperation with the Uganda government, are beginning to work on the matter, with Uganda's First Lady Janet Museveni, who is also the minister for Education and Sports, was expected to visit the scene.

Ugandan police have launched an investigation into the cause of a fire that that ravaged the main building of the historic campus.

Policeofficials said the fire which broke out in the wee hours of yesterday is believed to have started from the roof, spreading to floors that house records and the finance department.

"A lot of valuable material has been destroyed. Investigations are ongoing to ascertain the exact cause of the fire," a police statement said.

The VC said it was "a very dark morning for Makerere University. Our iconic main administration building caught fire and the destruction is unbelievable," he said in a tweet. -

152 more contract Covid-19, Kenya's caseload now 36,981

NAIROBI

KENYA's Covid-19 caseload has increased by 152 to 36,981 after the analysis of 2,224 samples over the last 24 hours.

The Health Cabinet Secretary, in a status report yesterday, said that this number of samples raised the total tested in the country to 516,706.

He said that 110 more patients had recovered and that two more had succumbed to the virus, raising the counts to 23,887 patients and 648 deaths countrywide.

Thirty-nine of the recovered patients were in the home-based care programme and 71 at health facilities

across the country, the statement indicated.

Nairobi accounted for 34 of the new patients, Mombasa 24, Kisii 20, Kiambu and Kisumu 19 each and Nakuru 10.

Turkana County recorded eight new Covid-19 cases, Kajiado three, Kakamega, Meru and Embu two each and Kericho, Marsabit, Nyamira, Samburu, Siaya, Uasin Gishu, Taita Taveta, Machakos and Murang'a one each.

Around 135 of the new patients were Kenyans and 17 foreigners, where 84 are male and 68 female, the youngest being just three years old and the oldest 89, the statement added.-

of rhinos, he said.

The district authorities receive 10 per cent of monies fetched from tourism and conservation activities, while the Tanzania Wildlife Management Authority (TAWA) picks up 25 percent of visitors to less than ten per months of the revenues, and 65 percent is even after restarting commercial air equally distributed among the ten villages, the official elaborated.

Burunge is among the first four WMAs to be established in 2003 under a new wildlife sector policy drawn up in 1999, aiming to protect the environment as well as enable villagers to benefit from available resources. There are 32 WMAs countrywide, he pointed out.

The Burunge WMA is made up of ten villages covering an area of 283-squarekilometres. The villages are Sangaiwe, Mwada, Ngoley, Vilimavitatu, Minjingu, Kakoi, Olasiti, Manyara, Magala and Maweni.

The WMA is among areas of high conservation significance since it occupies land having wildlife corridors between Tarangire and Manyara national parks. It is also adjacent to the Manyara ranch.

Dr Bernard Kissui, researcher with Tarangire Lion Project underscored the need for conservation and sustainable wildlife management at Burunge WMA to ensure the presence of wild animals which are crucial in attracting tourists. The key wild animals are lions, buffalos, elephants, rhinos and leopards which are unevenly distributed in the northern circuit.

Dr Kissui where directs the Wildlife Management Centre said there are number of conservation challenges are likely to affect tourism sector activities.

He was concerned with rapid population increase, overgrazing, tree loss through cutting for construction, cultivation and charcoal burning. He said water resources have also been affected as water catchment areas dry up, with deforestation in the upper reaches resulting in the gradual siltation and shallow level of Lake Manyara.

Sangaiwe village chairman Marian Mbere said the decline in revenues has affected implementation of some

development projects, much of the cash was expected from Tarangire Simba Lodge and Sangaiwe Tented Lodge.

The village has 573 households, now feeling the loss of low visitations as the Covid-19 crisis reduced the number travel, he said.

Richard Kwitega, the Regional Administrative Secretary for Arusha, attested that the number of tourists dropped to approximately 100,000 in total since the outbreak of the Covid-19 crisis.

The situation started to normalize between June and July, while prior to the outbreak, the country was receiving up to 1.5m tourists a year, with the bulk of them visiting northern circuit attractions.

Association urges livestock officers to help farmers, herders prize peace

TANZANIA Livestock Keepers Association (CCWT) has appealed to livestock officers in the country's local councils to ensure management grazing areas in districts with livestock keepers to avoid farmers-herders

The association has also called of livestock officials not to charge the levies at livestock auctions.

The appeal was given yesterday by CCWT legal officer Glorious Luoga

when speaking to traditional leaders Wambura said he will stand by all and herders in Monduli District, Arusha Region.

In regard to livestock being charged levies before being sold at auctions, Luoga said that was illegal and called on livestock officials to solvethe challenge

He also used the occasion to call on herders to have good relationship with government officials as the livestock sector is important to the national

herders' rights as it was the country essential sector, and added that during his tenure in WCCT he will establish edible seed processing factories including digging wells in all animals grazing areas that have been officially set aside for the

Earlier, speaking at the meeting, herders Julius Loibos, Yamat Laizer and Oleiboku Ole Kisambu said allocated grazing lands were being invaded by CCWT national chairman Jeremia farmers with no steps being taken to

address the situation.

For his part, Monduli District livestock officer Ommary Sanga pledged to address all complaints regarding invasion of grazing areas.

On livestock levies he admitted charging taxes on livestock that have not yet been sold because herders do not get permits from Ward livestock officers allowing them to transport their livestock, but from now on any herders taking animals to auctions will not be charged the levies.

AT least 300 dogs and cats in Iramba District, Singida Region have been vaccinated against rabies, thanks Education for African Animals Welfare(EAAW), nongovernmental organisation that provided the free vaccination of the animals.

District authority leaders said this as a positive step towards eradicating spread of the deadly virus to people from the saliva of infected animals in the district.

According to the district livestock and fisheries officer, Dotto Thomas, rabies is a dangerous disease in the country and globally since once infection is established, there is no effective treatment as the disease usually causes death.

treatment is quite expensive in the country as only few hospitals can offer such services.

He explanied that most dispensaries and health especially in the villages do not offer treatment for the disease therefore those infected are at high risk.

Dotto said explained that in efforts to prevent the disease, district authorities in collaboration with EAAW conducted a two- days seminar within Kiomboi ward whereby about 300 dogs and cats were vaccinated and plans to cover the whole district are still underway.

"The authorities spread of the disease and through partnership with other stakeholders such as EAAW, we shall win the war," he said. He thanked EAAW for the support, calling on other organisations to follow suit.

Five-year digital strategy to facilitate improvement of health services - govt

THE government is committed to improve the application of digital heath technologies to attain objective to deliver high quality health services to the citizens.

The implementation of previous National e-Health Strategy (2013-2018) which accelerated transformation of the health system by enabling timely access to information and supporting healthcare administrative, financial and clinical operations to enhance decision making says it all.

Director of curative services in the Ministry of Health, Grace Magembe said the digital health strategy and digital library would give stakeholders access to information on existing health initiatives and documents.

The five-year digital health strategy would facilitate digital health and improve health services in the country.

"The strategy establishes the government of Tanzania as a global leader in digital healthcare and paves the way for better patient treatment outcomes," said the director.

He National Digital Health Strategy is in line with the Tanzania Development Vision 2025 and the Health Sector Strategic Plan (2015-2020) thus emphasizing provision of quality health care to all households.

The National Digital Health Strategy was developed as a result of strong government leadership and will help to build consensus on policy, facilitate better use of shared resources and ensure investment in digital skills and infrastructure ultimately leading to more efficient health system and better health outcomes.

One of the critical components of the strategy was governance, which added value to the government's new digital health strategy.

The bodies that will be primarily responsible for implementing the strategy and programme are the National Digital Health Steering Committees (NDHSC) and the National Digital Health Secretariat (NDHS).

To ensure effective implementation of the strategy, Magembe said the government will also launch a technical working group, an online platform that will digitalise activities of health sector technical working groups.

Magembe explained that the new strategic plan interactions of people and technology.

was in line with the Tanzania Development Vision 2025, the Health Sector Strategic Plan (2015-2020) and other key policies advancing the country's efforts to build an end to end interoperable digital health system.

"A national digital health system will enable the government to set aside resources for the most health impact, enable real time data on emerging disease cases to prevent epidemics," she said.

For his part, Director of Information Communication Technology (ICT) in the Ministry of Health, Community Development, Gender, Elderly and Children, Haji Bamisi noted that the strategy built on and directly responded to what was learnt from previous strategies (2013-2018).

He said for the design of the new strategy the government consulted the World Health Organisation (WHO) and the International Telecommunication Union National e-Health Strategy Toolkit.

He added that the strategy identified ten strategic priorities ranging from the need to strengthen digital governance and leadership and the importance of improving the supply chain management of health products.

Bamisi further stated that the strategy will enable the government to advance country's efforts to build an end to end, interoperable digital health system, while cementing the country as a global leader in digital health.

A number of measures have been drawn to ensure smooth implementation of the strategy among others a day to day undertaking by National Digital health Technical Committee which will provide progress updates to promote collaboration and prevent duplication of efforts.

Moreover, the strategy will be implemented in accordance with the national policies, and engage stakeholders, among others.

Regional and districts governing bodies will be engaged to cascade down implementation in the form of regional health management teams, council health management teams, institutional digital health committees and health facility digital health committees.

The Director General appreciated the support received from national educational institutions, the Ministry of Local Government and Regional Administration, TMDA and the Tanzania Bureau of Standards. "Protection of environment is a multisectoral task. NEMC cannot accomplish the task alone," he said.

Tanzania proud as principal lion habitat globally, but care is needed

would have been in a position to know just how much the world owes to Tanzania in wildlife conservation, not firstly for our own efforts but natural endowment. But at present real effort is needed as the world now depends on Tanzania's conservation efforts to maintain, or perhaps also to boost, what is said to be rapidly dwindling lion populations worldwide. Tanzania is said to account for over 50 per cent of the biggest cats on earth, which presents a challenge on resource use, principally.

An example of what lies ahead, though an extreme case, is the way global hopes for conservation of the Amazon Forest both for absorption of carbon dioxide and also for its biodiversity are going up in flames. In other places around the world like the much less spectacular ecosystem in the western parts of the United States are also engulfed in fire for a different reason. In Brazil it is agricultural expansion by leaps and bounds, while in the US experts fault climate change for uncontrollable fires. We are still safe here.

Yet all is now well even in our case especially in relation to biodiversity generally and conservation in particular, with big cats like lions posing a special problem. To be able to maintain a semblance of primacy in conservation efforts, for instance if we are to specialize as the world's biodiversity paradise for the sake of the tourism sector, some things will have to change as expansion of livestock rearing is incompatible with conservation. Settled agriculture is a problem as well, especially when we can't move to intensive farming with high yield capacities, as different from expansive farming and low yields.

The conservation aspect in Tanzania, of big cats on the one hand and of the

JUST a few well exposed observers top five in the world's endangered species generally, is in the second order of governance problems in that sector, the first being human-wildlife conflicts. With rising populations both of herders and farmers, it is hard to maintain conservation zones intact, so the government is having to reallocate portions of less important wildlife zones for farming and cattle rearing. The result is a gradual diminution of cohesive areas for wildlife movement out of seasonal needs, as water sources dry out in some spots and need to use other spots.

> Outside direct reallocation of zones for agro-pastoral use, excessive proximity of settled areas and reserves is a problem, while its other more irritating face is proximity of agro-cultivators and nomadic pastoralists. A pernicious aspect of this problem is that it has a channel of exchanging coins where the sellers of cattle purchase peace from local administrators after any of their often repeated misdemeanors so peace is put at risk. Some will say there are fewer instances of that kind these days, but it still hurts.

Yet a note of alarm was being sounded by wildlife experts in the northern zone that at the rate at which the ferocious cats are being killed in ongoing humanwildlife conflicts on reserved corridors, Tanzania too could soon lose these important, but now endangered creatures. A seasoned researcher in the

Dr Bernard Kissui who studies lions within the Tarangire-Burunge-Manyara eco-system, says that the cats have been suffering attacks from local herders, along the Kwakuchinja wildlife corridor. If in nature substitute options don't exist, when lions need corridors and can't use them, what follows is decimation.

Unsafe abortion hurting Malawi women: Pregnancy termination bill is important piece of legislation

TATE House confirmed recently that the Termination of Pregnancy Bill will be tabled in the current sitting of Parliament. As expected, voices against this bill are already soaring.

For instance, the Malawi Council of Churches, Episcopal Conference of Malawi, Muslim Association of Malawi, Evangelical Association of Malawi and Qadria Muslims Association of Malawi have all spoken against the proposed

But before we stand against this proposed bill, have we really understood what this bill is all about and what problem it intends to solve?

We have a serious health challenge facing our women in form unsafe abortion. Law or no law, our women and girls, every day, are indulging in unsafe abortion and it's destroying their wombs, some are dying and, of course, the country is losing a lot of money in post-abortion care.

For instance, according to a 2009 government study, there were about 70 500 induced abortions in Malawi. Of these, almost half are vounger than 25 years old, four out of five are married and about two-thirds live in rural areas. According to the study, an

severe complications, seven percent had moderate complications and 73 percent had low or no complications. Economically, unsafe abortion is

estimated one in five women had

rearing its ugly head on the country's thin purse. In providing post-abortion care, government loses between \$300 000 (K120 million) and \$500 000 (K200 million) every year. Arguably, this is a challenge we must

handle as a nation. There is no way we can look otherwise when our women are facing a problem.

In solving this problem, we need, in the first place, to ask: What is driving our women to indulge in safe abortion?

There are two major reasons why most women and girls opt for unsafe abortion. One, because safe abortion is costly and, two, because there is a perception that abortion is illegal.

To address this, government has come up with a Pregnancy Termination Bill with a goal to, one, make safe abortion free and, two, expand the grounds of procuring abortion.

But let us face facts, first. Contrary to popular views, abortion, under Section 243 of the Penal Code, is legal in Malawi.

The section says performing an abortion is not a crime if it is done "for

abortion, and may be imprisoned for up to 3 years."

What this means is that despite abortion being legal, the law is very restrictive in the sense that it demands that abortion should be carried out by "any person with reasonable care and skill to carry out an operation to preserve the mother's life."

What we have is that there are no standards and guidelines to guide policy makers, NGOs, the Ministry of Health and medical professionals on how to apply Section 243 of the Penal

This section is vague. For instance, it fails to answer questions such as: who makes a decision that the pregnancy should be terminated between doctor and patient? At what stage can this decision be made? At which health facility? What are the counseling guidelines? What about religious beliefs? What about family planning awareness?

The net effect of this is that there are free-for-all abortions being carried out by many unskilled people. The result is that we have a situation that all complications related to unsafe abortions are ending up in hospitals.

So, hospitals are spending a lot of time and resources providing postabortion care from unsafe abortions. This is in form of providing space in the wards and ICU, operations in theatre and provisions of necessary drugs.

The country needs to open up and start talking about the issue, scale up family planning and reform the law on

This current situation is fueling a lot of unsafe abortions. It is costly to the nation, and the space to access safe abortion is very limited.

If you can ask Malawians now whether women are having abortion almost everybody will say 'yes'. But if you go further and ask them as to 'how' and 'where', there will be a lot of murmuring and hiding of information.

If you go to the hospitals especially gynecological wards they will tell you that 30 percent of the space is being occupied by unsafe abortion patients.

Then you realise there is chaos which should not continue where women are injured and killed. It is time to put in place a proper law that will address the problem and stop women from dying.

This is what the bill, to be tabled in Parliament, wants to address. That is why this bill is important and we should all support it.

The International Day of Peace, sometimes unofficially known as World Peace Day, is a United Nationssanctioned holiday observed annually on 21 September. It is dedicated to world peace, and specifically the absence of war and violence, such as might be occasioned by a temporary ceasefire in a combat zone for humanitarian aid access. The day was first celebrated in 1981, and is kept by many nations, political groups, military groups, and people. In 2013 the day was dedicated by the Secretary-General of the United Nations to peace education, the key preventive means to reduce war sustainably.

To inaugurate the day, the United Nations Peace Bell is rung at UN Headquarters (in New York City). The bell is cast from coins donated by children from all continents except Africa, and was a gift from the United Nations Association of Japan, as "a

reminder of the human cost of war"; the inscription on its side reads, "Long live absolute world peace".

In other words, peace is a concept of societal friendship and harmony in the absence of hostility and violence. In a social sense, peace is commonly used to mean a lack of conflict (such as war) and freedom from fear of violence between individuals or groups. Throughout history leaders have used peacemaking and diplomacy to establish a certain type of behavioural restraint that has resulted in the establishment of regional peace or economic growth through various forms of agreements or peace treaties. Such behavioural restraint has often resulted in the reduction of conflicts, greater economic interactivity, consequently substantial

"Psychological peace" (such as a peaceful thinking and emotions) is perhaps less well defined yet often a necessary precursor to establishing "behavioral peace." Peaceful behavior sometimes results from a "peaceful inner disposition." Some have expressed the belief that peace can be initiated with a certain quality of inner tranquility that does not depend upon the uncertainties of daily life for its existence. The acquisition of such a "peaceful internal disposition" for oneself and others can contribute to resolving of otherwise seemingly irreconcilable competing

interests. The obligation of the state to provide for domestic peace within its borders in usually charged to the police and other general domestic policing activities. The police are a constituted body of persons empowered by a state to enforce the law, to protect the lives, liberty and possessions of citizens, and to prevent crime and civil disorder. Their powers include the power of arrest and the legitimized use of force. The term is most commonly associated with the police forces of a sovereign state that are authorized to exercise the police power of that state within a defined legal or territorial area of responsibility.

At the same time, under Sections 149-151 of the Penal Code, abortion legislation is very restrictive.

Section 149 says "a person who assists a woman to abort is guilty of a felony and may be imprisoned for up to 14 years" while Section 150 provides that "a woman who aborts or attempts to abort is guilty of a felony and may be imprisoned for up to 7 years."



IITA, CIMMYT team up to enhance adoption of CA in southern Africa

THE International Institute of Tropical Agriculture (IITA) and the International Maize and Wheat Improvement Centre (CIMMYT)have launched a project that aims to investigate the drivers and barriers to adoption of Conservation Agriculture (CA) in southern Africa and to develop strategies for achieving adoption and impact at scale.

The project, Understanding and Enhancing Adoption of Conservation Agriculture in Smallholder Farming Systems of Southern Africa (ACASA), will apply social and scaling science to understand the biophysical, socioeconomic, institutional, and policy drivers and barriers to the adoption of CA technologies and practices.

ACASA is supported by the Norwegian Agency for Development Cooperation (Norad) and will be implemented in Malawi, Zambia, and Zimbabwe in collaboration with the CA stakeholders and farmers in the region.

The project was officially launched virtually on 16 September 2020 by the Zambia Minister of Agriculture, Michael Katambo.

Katambo noted it was a timely intervention as the livelihoods and food security of smallholder farmers in southern Africa are increasingly being threatened by climate change and variability that had led to a steady decline in the production of food staples and an increase in the number of food and nutrition insecure people over the last couple of years.

'It is now clear that current produc-

expected to meet our requirements for food and nutrition security. Conservation Agriculture (CA) has a proven potential to increase and stabilize crop yields and to support sustainable and resilience production systems and rural livelihoods,' he said in a speech read on his behalf by Dr Moses Mwale, Director, Department of Agriculture at the Ministry.

CA, a farming system that promotes minimum soil disturbance, permanent soil cover, and diversification of plant species, can efficiently increase agricultural productivity while reducing land degradation and improving soil health for more productive, profitable, and sustainable farming.

Substantial on-farm experimental evidence has been generated on the agronomic and economic benefits of CA, first introduced in the 70s in south Africa. Consequently, a lot of investments have been made by the donor community and national governments to promote and scale CA technologies and practices among smallholder farmers in the region. Despite all these efforts, however, the adoption rate among smallholder farmers remains low.

'We should not let the low adoption of conservation agriculture discourage us. Let us use this opportunity to reflect and identify the missing link and come up with more sustainable solutions to the problem,' said the IITA Director for Southern Africa Dr David Chikoye, speaking at the launch.

'Although adoption of improved practices by most resource-poor farm-

tivity and production levels cannot be ers is primarily determined by the potential immediate benefits on crop yields, profits, risk, and livelihoods, there are a number of biophysical, socioeconomic, institutional, and policy factors that promote or hinder adoption of CA. The project, therefore, aims to identify the adoption drivers and barriers and develop pathways and strategies for inclusive scaling of CA practices,' added Dr Arega Alene, IITA Agricultural Economist based in Malawi, who leads the project at IITA.

Also speaking at the launch, Christian Thierfelder, Principal Cropping Systems Agronomist at CIMMYT, highlighted some of the bottlenecks for CA adoption noting they were linked more to socioeconomic and cultural factors rather than biophysical.

'CA is a viable and proven climate smart farming system. Therefore future research efforts should go towards understanding farmers' decision-making and behavioral change as well as profitability,' he said.

Other key partners include Food and Agriculture Organization of the United Nations (FAO), African Conservation Tillage Network (ACTN) and Centre for Coordination of Agricultural Research and Development for Southern Africa (CCARDESA).

The project launch was attended by policymakers, donors, and members of the national and regional CA taskforces, national and international research institutions, universities, international development institutions, private seed companies, non-governmental organizations, and farmer organizations.



New Asian mosquito could bring malaria to African urban cities, warn scientists

ALREADY grappling with the highest incidence of malaria with more than 90 per cent of global cases, Africa should be wary of an Asian mosquito species that has the potential to spread the disease into the continent's urban areas subjecting an additional 126 million people to risk - a new analysis suggests.

Unlike endemic mosquito species in Africa, which have made themselves at home in warm and wet climes in largely rural areas, this particular mosquito - An. stephensi - has made an appearance in African cities in recent years.

"This mosquito is unlike any other primary malaria vector found in Africa - it can live in urban areas that other species just don't like," said the lead author, Dr Marianne Sinka from the University of Oxford.

population live in urban areas, this means there are a lot of people who are currently protected by their environment that could become exposed - if the mosquito spreads."

this species' Unlike predecessors, who are usually unable to survive in polluted water, An. stephensi is highly adapted to finding man-made water tanks or containers to lay its eggs, with larval site habits similar to Aedes aegypti, the species responsible for outbreaks of vellow fever and Zika.

This similarity could be exploited to bring in control measures that have previously worked for Aedes aegypti, although mosquitoes are notoriously difficult to control in urban areas where suitable water sources are abundant, she

Since 2012, outbreaks of malaria thought to be caused appears to be implicated,

"As about 40% of Africa's by An. stephensi have been the researchers said. reported in Djibouti City, and recently in Ethiopia and Sudan. To predict the spread of the species in Africa, the researchers combined location data for An. stephensi across geography with spatial models that identified the environmental conditions that it finds most suitable.

The results were sobering - 44 out of 68 African cities were predicted to be "highly suitable" locations, putting roughly 126 million urban regions ... could be additional people at a heightened risk of malaria if the species were to proliferate unchecked.

The causes of malaria transmission are evident data show land use patterns, climate change as well as migration and urbanisation all contribute. But in the case of An. stephensi, migration to urban areas, particularly along transport routes,

"We know that migration can bring the parasite to places that have little or no transmission. Global transport has historically moved many species to new locations and caused significant environmental damage over the years. In mosquito terms, notably albopictus, the Aedes primary vector of dengue ... and now An. stephensi," noted Sinka.

"The paper indicates big at major risk, but there's no evidence that this mosquito is there yet," said Prof Chris Drakeley from the London School of Hygiene & Tropical Medicine, who was not involved in the study.

1. BACKGROUND

The World Wide Fund for Nature WWF in Tanzania (WWF Tanzania) with support from Swedish International Development Cooperation Agency (Sida) is implementing a regional programme project aimed at securing Eastern Africa region's forests.

In a bid to ensure Civil Society Organizations (CSOs) are engaging more effectively in regional policy dialogues regarding the management of forest resources, the regional forest programme is seeking to document their insights on challenges, achievements and lessons learnt in the forest sector.

The aim of this TOR is therefore to produce film documentary and book publication highlighting CSO voices in leading the change in Eastern and Southern Africa (Tanzania, Kenya, Uganda, Madagascar and Mozambique).

Mr. President, your government should always try to see that transparency is applied in the awarding of contracts and jobs in all government

All tenders for contracts or vacancies should be advertised in the newspapers for the bidding to be competitive and fair. Government should no longer allow pre-financing of projects like the Banjul roads project with Hadim Gai, which is D1.8 billion. Since there are 12 banks in this country, any future projects that Government has, the banks should be contracted if they can offer any intervention.

Mr. President, it is wrong to go in for a contractor to pre-finance government project as it will not tell well and people will question the rationale.

In recent times, there have been allegations of serious and endemic corruption in the government procurement system involving procurement units of some important government ministries.

If these allegations are found to be true, then it is deeply worrying as the funds involved are either tax payers' money or grants and loans given to the Gambian people.

Mr. President, when such allegations are made, government should not take it lightly as the citizenry expect a thorough and transparent act be conducted by the competent authorities to ascertain the veracity or otherwise of the allegations.

If this is not done, people would justifiably be very doubtful about the good intentions of the leadership for the country. It is alleged by whistle blowers that government contracts are often highly inflated to accommodate kickbacks for government officials and authorities handling such contracts.

Mr. President, the bidding processes are also fraudulent with blatant multiple irregularities. Example, unjustifiable single sourcing to be able to award contracts to the supplier; they can make the most corrupt deals with awarding contracts to a few people who have little or no expertise in what they are supplying, be it goods or services, cutting across several ministries; engaging dubious suppliers both locally and overseas etc. All this is done despite the existence of The New Gambia.

President, the Public Procurement Authority (GPPA) should operate under strict guidelines to ensure that the procurement units of the different ministries including the Permanent Secretaries, who are the accounting officers, strictly adhere to the clearly established procurement

At the end of the day, the buck ends with a honourable minister who should not be oblivious of what's going on within his/her ministry, unless he or she is part of the deal.

The Gambia officially the Republic of The Gambia, is a country in West Africa. Often referred to as 'The Smiling Coast', it is the smallest country within mainland Africa, and is surrounded



by Senegal, except for its western coast on the Atlantic Ocean. The Gambia is situated on both sides of the lower reaches of the Gambia River, the nation's namesake, which flows through the centre of The Gambia and empties into the Atlantic Ocean. It has an area of 10,689 square kilometres (4.127 sq mi) with a population of 1,857,181 as of the April 2013 census. Banjul is the Gambian capital and the country's largest metropolitan area. The largest cities are Serekunda and Brikama.

The Gambia shares historical roots with many other West African nations in the slave trade, which was the key factor in the placing and keeping of a colony on the Gambia River, first by the Portuguese, during which era it was known as A Gâmbia. Later, on 25 May 1765, The Gambia was made a part of the British Empire when the government formally assumed control, establishing the Province of Senegambia. In 1965, The Gambia gained independence under the leadership of Dawda Jawara, who ruled until Yahya Jammeh seized power in a bloodless 1994 coup. Adama Barrow became The Gambia's third president in January 2017, after defeating Jammeh in the December 2016 elections. Jammeh initially accepted the results, then refused to accept them, which triggered a constitutional crisis and military intervention by the Economic Community of West African States, resulting in his exile.

The Gambia's economy is dominated by farming, fishing and, especially, tourism. In 2015, 48.6 per cent of the population lived in poverty. In rural areas, poverty is even more widespread, at almost 70 per cent.

Etymology

The name "Gambia" is derived from the Mandinka term Kambra/ Kambaa, meaning Gambia River (or possibly from the sacred Serer Gamba, a special type of calabash beaten when a Serer elder dies). According to the CIA World Factbook, the United States Department of State, the Times Comprehensive Atlas of the World and the Permanent Committee on Geographical Names for British Official Use, The Gambia is one of two countries whose self-standing short name for official use should begin with the word "The" (the other being The Bahamas). (Habitually, the definite article is sometimes still used when addressing many other countries, including Netherlands, Philippines, Congo, Sudan, Comoros, Central African Republic, Seychelles, Maldives, Solomon Islands, Dominican Republic, Czech Republic, Marshall Islands, the United Kingdom and the United States of America, with varying degrees of accuracy.) Upon independence in 1965, the country used the name The Gambia. Following from this general region during Commonwealth, with Elizabeth

the proclamation of a republic in 1970, the long-form name of the country became Republic of The Gambia. The administration of Yahya Jammeh changed the longform name to Islamic Republic of The Gambia in December 2015. On 29 January 2017 President Adama Barrow changed the name back to Republic of The Gambia.

History

Arab traders provided the first written accounts of the Gambia area in the ninth and tenth centuries. During the tenth century, Muslim merchants scholars established communities in several West African commercial centres. Both groups established trans-Saharan trade routes, leading to a large export trade of local people as slaves, along with gold and ivory, as well as imports of manufactured goods.

By the 11th or 12th century, the rulers of kingdoms such as Takrur (a monarchy centred north) ancient Ghana and Gao had converted to Islam and had appointed to their courts Muslims who were literate in the Arabic language. At the beginning of the 14th century, most of what is today called The Gambia was part of the Mali Empire. The Portuguese reached this area by sea in the mid-15th century and began to dominate overseas trade.

In 1588, the claimant to the Portuguese throne, António, Prior of Crato, sold exclusive trade rights on the Gambia River to English merchants. Letters patent from Queen Elizabeth I confirmed the grant. In 1618, King James I of England granted a charter to an English company for trade with the Gambia and the Gold Coast (now Ghana). Between 1651 and 1661, some parts of the Gambia – St. Andrew's Island in the Gambia River including Fort Jakob, and St. Mary Island (modern day Banjul) and Fort Jillifree – came under the rule of the Duchy of Courland and Semigallia (now in modernday Latvia), having been bought by Prince Jacob Kettler . The colonies were formally ceded to England in 1664.

During the late 17th century and throughout the 18th century, the British Empire and the French Empire struggled continually for political and commercial supremacy in the regions of the Senegal River and the Gambia River. The British Empire occupied the Gambia when an expedition led by Augustus Keppel landed there following the Capture of Senegal in 1758. The 1783 First Treaty of Versailles gave Great Britain possession of the Gambia River, but the French retained a tiny enclave at Albreda on the river's north bank. This was finally ceded to the United Kingdom in 1856.

As many as three million people may have been taken as slaves

transatlantic slave trade operated. It is not known how many people were taken as slaves by intertribal wars or Muslim traders before the transatlantic slave trade began. Most of those taken were sold by other Africans to Europeans: some were prisoners of intertribal wars; some were victims sold because of unpaid debts, and many others were simply victims of kidnapping.

Traders initially sent people to Europe to work as servants until the market for labour expanded in the West Indies and North America in the 18th century. In 1807, the United Kingdom abolished the slave trade throughout its empire. It also tried, unsuccessfully, to end the slave trade in the Gambia. Slave ships intercepted by the Royal Navy's West Africa Squadron in the Atlantic were also returned to the Gambia, released on MacCarthy Island far against leading politicians. The on the Senegal River just to the up the Gambia River where they coup attempt occurred while were expected to establish new lives. The British established the military post of Bathurst (now Banjul) in 1816.

> Gambia Colony Protectorate (1821-1965)

In the ensuing years, Banjul was at times under the jurisdiction of the British Governor-General in Sierra Leone. In 1888, The Gambia became a separate colony.

An agreement with the French Republic in 1889 established the present boundaries. The Gambia became a British Crown colony called British Gambia, divided for administrative purposes into the colony (city of Banjul and the surrounding area) and the protectorate (remainder of the territory). The Gambia received its own executive and legislative councils in 1901, and it gradually progressed toward self-government. Slavery was abolished in 1906 and following a brief conflict between the British colonial forces and indigenous Gambians, British colonial authority was firmly established.

During World War II, some soldiers fought with the Allies of World War II. Though these soldiers fought mostly in Burma, some died closer to home and a Commonwealth War Graves Commission cemetery is in Fajara (close to Banjul). Banjul contained an airstrip for the US Army Air Forces and a port of call for Allied naval convoys.

After World War II, the pace of constitutional reform increased. Following general elections in 1962, the United Kingdom granted full internal self-governance in the following year.

Post-Independence (1965present)

Gambia achieved The independence on 18 February as a constitutional 1965. monarchy within

the three centuries that the II as Queen of the Gambia, represented by the Governor-General. Shortly thereafter, the national government held a referendum proposing that the country become a republic. This referendum failed to receive the two-thirds majority required to amend the constitution, but the results won widespread attention abroad as testimony to The Gambia's observance of secret balloting, honest elections, civil rights, and liberties.

On 24 April 1970, The Gambia became a republic within the Commonwealth, following a second referendum. Prime Minister Sir Dawda Kairaba Jawara assumed the office of President, an executive post, combining the offices of head of state and head of government.

President Sir Dawda Jawara was re-elected five times. An attempted coup on 29 July 1981 followed a weakening of the economy with people who had been slaves and allegations of corruption President Jawara was visiting London and was carried out by the leftist National Revolutionary Council, composed of Kukoi Samba Sanyang's Socialist and Revolutionary Labour Party (SRLP) and elements of the Field Force, a paramilitary force which constituted the bulk of the country's armed forces.

President Jawara requested military aid from Senegal, which deployed 400 troops to The Gambia on 31 July. By 6 August, some 2,700 Senegalese troops had been deployed, defeating the rebel force. Between 500 and 800 people were killed during the coup and the ensuing violence. In 1982, in the aftermath of the 1981 attempted coup, Senegal and The Gambia signed a treaty of confederation. The Senegambia Confederation aimed to combine the armed forces of the two states and to unify their economies and currencies. After just seven years, The Gambia permanently withdrew from the confederation in 1989.

In 1994, the Armed Forces Provisional Ruling Council (AFPRC) deposed the Jawara and banned government opposition political activity. Lieutenant Yahya A.J.J. Jammeh, chairman of the AFPRC, became head of state. Jammeh was just 29 years old at the time of the coup. The AFPRC announced a transition plan to return to a democratic civilian government. The Provisional Independent Electoral Commission (PIEC) was established in 1996 to conduct national elections and transformed into the Independent Electoral Commission (IEC) in 1997 and became responsible for the registration of voters and for the conduct of elections and referendums.

In late 2001 and early 2002, The Gambia completed a full cycle of presidential, legislative, and local

elections, which foreign observers deemed free, fair, and transparent. President Yahya Jammeh, who was elected to continue in the position he had assumed during the coup, took the oath of office again on 21 December 2001. Jammeh's Alliance for Patriotic Reorientation and Construction (APRC) maintained its strong majority in the National Assembly, particularly after the main opposition United Democratic Party (UDP) boycotted the legislative elections. (It has participated in elections since, however).

On 2 October 2013, the Gambian interior minister announced that The Gambia would leave the Commonwealth with immediate effect, ending 48 years of membership of the organisation. The Gambian government said it had "decided that The Gambia will never be a member of any neo-colonial institution and will never be a party to any institution that represents an extension of colonialism".

Incumbent President Jammeh faced opposition leaders Adama Barrow from the Independent Coalition of parties and Mamma Kandeh from the Gambia Democratic Congress party in the December 2016 presidential elections. The Gambia sentenced main opposition leader and human rights advocate Ousainou Darboe to 3 years in prison in July 2016, disqualifying him from running in the presidential election.

Following the 1 December 2016 elections, the elections commission declared Adama Barrow the winner of the presidential election. Jammeh, who had ruled for 22 years, first announced he would step down after losing the 2016 election before declaring the results void and calling for a new vote, sparking a constitutional crisis and leading to an invasion by an ECOWAS coalition. On 20 January 2017, Jammeh announced that he had agreed to step down and would leave the country.

On 14 February 2017, The Gambia began the process of returning to its membership of the Commonwealth and formally presented its application to re-join to Secretary-General Patricia Scotland on 22 January 2018.[38] [39] Boris Johnson, who became the first British Foreign Secretary to visit The Gambia since the country gained independence in 1965, announced that the British government welcomed The Gambia's return to the Commonwealth. The Gambia officially rejoined the Commonwealth on 8 February 2018.

Geography

The Gambia is a very small and narrow country whose borders mirror the meandering Gambia River. It lies between latitudes 13 and 14°N, and longitudes 13 and 17°W.

The Gambia is less than 50 kilometres (31 miles) wide at its widest point, with a total area of 11,295 km2 (4,361 sq mi). About 1,300 square kilometres (500 square miles) (11.5 pc) of The Gambia's area are covered by water. It is the smallest country on the African mainland. In comparative terms, The Gambia has a total area slightly less than that of the island of Jamaica.

Senegal surrounds The Gambia on three sides, with 80 km (50 mi) of coastline on the Atlantic Ocean marking its western extremity.

The present boundaries were defined in 1889 after an agreement between the United Kingdom and France. During the negotiations between the French and the British in Paris, the French initially gave the British around 200 miles (320 km) of the Gambia River to control. Starting with the placement of boundary markers in 1891, it took nearly 15 years after the Paris meetings to determine the final borders of The Gambia. The resulting series of straight lines and arcs gave the British control of areas about 10 miles (16 km) north and south of the Gambia River.

The Gambia has a tropical climate. A hot and rainy season normally lasts from June until November, but from then until May, cooler temperatures predominate, with less precipitation. [43] The climate in The Gambia closely resembles that of neighbouring Senegal, of southern Mali, and of the northern part of Benin.

Red Sea nations must co-operate to ensure waterway stability, say experts

CAIRO

Red Sea coastal nations must step up co-operation to bring stability to the strategic waterway and reduce the presence of regional and global powers trying to carve out spheres of influence there, experts on Thursday told an online seminar organised by a Washington-based think tank.

Equally important, the experts added, was to turn Ethiopia's massive dam on the Nile from a contentious and potentially explosive dispute between Addis Ababa and downstream nations Sudan and Egypt into a catalyst for economic benefits for all three.

Iran, Turkey, Russia and China have in recent years moved to establish a foothold in the Red Sea and Horn of Africa regions, sparking a race for leverage alongside one of the world's busiest shipping routes that link Asia and the Gulf Arab region with Europe to the north or to the Far East.

The conflict in Yemen, where Iranianbacked rebels have for than five years been fighting forces of the Arabbacked legitimate government there, has fuelled tension in the Red Sea and

"We don't welcome their presence," Mr Al Sager said of attempts by Turkey, Iran and Russia to gain a foothold in the Red Sea. Underscoring its interest in enhanced co-operation among littoral states, Saudi Arabia this year launched an organisation grouping nations on the Red Sea and Gulf of Aden.

The newly founded agency groups Saudi Arabia, Jordan, Egypt and Eritrea, Sudan, Yemen, Djibouti and Somalia. Its declared objectives include the protection of shipping lanes, combating illegal migration, human trafficking and cross-border organised crime.

Alexander Rondos, the European Union's special representative to the Horn of Africa, emphasised the potential danger posed by the long-simmering dispute between Ethiopia on one side and Egypt and Sudan on the other over the Grand Ethiopian Renaissance Dam, or GERD.

Egypt fears that the hydroelectric dam could reduce its vital share of the Nile water and has been trying for a decade to persuade Addis Ababa to agree to a legally binding mechanism on dealing with sustained drought and resolving future disputes.

newly introduced electronic system. "Unlike the previous system, the e-filing one enables taxpayers to file their returns without the hassle of travelling all the way to TRA offices.

They can file the returns at the comfort of their offices instead of the former system that compelled them to visit a TRA office to file their returns,"

He pointed out that taxpayers are

no longer compelled to wait for several weeks, months or even years for TRA to login their information before they can pay taxes because with digital filing which started in August, actual assessment is almost conducted instantly thus allowing taxpayers to settle their dues immediately.

"To simplify the process, TRA has also come up with a new set of forms that allow taxpayers to present their information thoroughly," he added while informing ACCA members on the types of taxes for which return filling can be done electronically.

With cybersecurity becoming a hot topic as the world goes digital, Associate Director from PwC, Neemayani Kaduma, reminded the accountants to avoid the allure of falling prey to phishing attacks warning that currently, Tanzanians face the threat of cybercrime as other countries.

"Data from Tanzania Computer Emergency Response Team - which tracks cyberattacks in Tanzania shows that attacks have been on the rise as the world goes digital. This means that we are not immune to cyber-attacks, we all have a role to play towards protection of our devices and information that we share," she warned.

Kaduma further pointed out that as the country and the world go digital, cybercriminals are also flooding the internet with numerous phishing e-mails which accountants must always be aware of.

"Falling prey to phishing e-mails may lead to you disclosing confidential and sensitive information such as passwords to cybercriminals hence as people who deal with confidential information, you need to be extra careful," she added.

LANS are underway to transform Tunduma Township of Songwe Region into a business hub that will serve African regional economic blocks with merchandise coming from Asian countries such as China.

It is high time to implement the plan which will benefit many Tanzanians through trading and employment," he said.

Briefing the PS on the delegation's mission, Songwe Regional Administrative Secretary, Dr Seif Shekhalage said the region has allocated 400 hectares of land for the developing of a Special Economic Zone to attract strategic investors.

Tafori researcher says exotic tree identification good for economy

IDENTIFICATION of exotic tree species found in natural forests will help the country come up with better hybrid trees made from blending such species with other alien species for timber and other uses.

Tanzania Forestry Research Institute Director of Research and Production, Dr Siima Bakengesa said last week that quality timber will be an important raw material for manufacturers of wood products hence contribute to rapid economic

Dr Bakengesa pointed out that re-

search and identification of tree species which Tafori researchers are currently undertaking is an important task befitting a middle income economy that heavily depends on

"We have more than 5,000 samples of trees at our herbariums which we have already identified their traditional names and also scientific names which helps us to know how they can be better used productively," he said.

Dr Bakengesa further noted that such research also helps understand how various exotic species of tree can used for timber, construction, environmental conservation must understand that tree farming mercial forests covering 429,539 and human consumption as traditional medicine.

"Some trees are not supposed to be planted or left to grow at water sources because they absorb much water hence degrade the environment," the Tafori Director added while stressing that hybrid trees made from exotic and foreign species are much better than their parents as they combine qualities of

He also urged the public to invest in silviculture saying tree cultivation is becoming bid business I the country and globally. "Our farmers

is more profitable to them individually but also for national economic growth. They should involve us to get expert advise on which are better species of trees to grow," Dr Bakengesa noted.

The Tafori researcher explained that although it takes between 16 and 20 years for a tree to be matured, farmers leap big when harvest time comes. "When you plant a tree today, by 2036 you will leap big with windfall profits," he added.

Tafori's data shows that Southern Highlands Regions of Iringa, Mbeya and Njombe have extensive com-

hectares; Lake Zone covering Geita, Kagera Mara and Mwanza has 65,734 hectares; Northern Zone covering Arusha, Kilimanjaro, Manyara and Tanga has 34,322 hectares; Eastern Zone with Coast, Dar es Salaam and Morogoro has 12,450 hectares; Central Zone with Dodoma, Singida and Tabora has 6,969 hectares; and Western Zone covering Kigoma, Rukwa and Katavi has 8,105 hectares only. Trump green lights Oracle's TikTok agreement and delays App store ban

NEW YORK

Trump gave his blessing to Oracle Corp.'s for the American operations of TikTok, putting the popular video-sharing app on course to escape a US ban imposed as part of his pressure campaign against China.


"I approved the deal in concept," Mr Trump told reporters Saturday as he left the White House for a campaign rally in Fayetteville, North Carolina. "If they get it done, that's great. If they don't, that's OK

The new company, which will be called TikTok Global, has agreed to funnel \$5 billion in new tax dollars to the US and set up a new education fund, which Mr Trump said would satisfy his demand that the government receive a payment from

the deal. "They're going to be setting up a very large fund," he said. "That's their contribution that I've been asking for."

Oracle plans to take a 12.5 per cent stake in the new TikTok Global, while Walmart Inc. said it has tentatively agreed to buy 7.5 per cent of the entity. Walmart's chief executive Doug McMillon will serve on TikTok Global's board of directors, the retailer said in a statement. Four of the five board seats will be filled by Americans, according to the statement.

During a campaign rally in Fayetteville, North Carolina, Mr Trump told his rally audience that in conversation with leaders of the companies, he said "do me a favor, could vou put up \$5bn into a fund for education, so we can educate people as to real history of our country - the

The president is trailing his opponent Joe Biden in polls and has sought to portray himself as tougher on Beijing than the Democrat.

TikTok said in a statement that it was "pleased that the proposal by TikTok, Oracle, and Walmart will resolve the security concerns of the US administration and settle questions around TikTok's future in the US."

The company confirmed Oracle will host all its US data and secure its computer systems. Oracle's Generation 2 Cloud fully isolates running applications and responds to security threats autonomously, according to the statement, which eliminates the risk of foreign governments spying on American users or trying to influence them with disinformation.

"Oracle will quickly deploy,

rapidly scale, and operate TikTok systems in the Oracle Cloud," said Oracle chief executive Safra Catz in a statement. "We are a 100 per cent confident in our ability to deliver a highly secure environment to TikTok and ensure data privacy to TikTok's American users.'

Oracle will get full access to review TikTok's source code and updates to make sure there are no back doors used by the company's Chinese parent to gather data or to spy on the video-sharing app's 100 million American users, according to people familiar with the matter.

TikTok Global, together with Oracle, SIG, General Atlantic, Sequoia, Walmart and Coatue will create an educational initiative to develop and deliver an online video curriculum driven by artificial intelligence, according to the statement.

TikTok said it's working with Walmart on a commercial partnership and said that it will take part in a TikTok Global financing round along with Oracle before an initial public offering in

which the investors can take as much as a 20 per cent cumulative stake in the company.

TikTok Global will likely be headquartered in Texas and will hire "at least" 25,000 people, Mr Trump said. TikTok will need to hire thousands of content moderators, engineers, and marketing staff that were previously located in China and around the world. The company will also pay more than \$5bn in new tax dollars to the Treasury, according to the statement.

To sweeten the deal for Mr Trump, TikTok promised to hire an additional 15,000 jobs, more than the 10,000 positions the company already pledged to fill earlier this year. It's unclear if there's a timeline to achieve that target, or guarantees that it will follow through. Facebook, the largest US social media company, employed about 45,000 people in 2019, while Twitter employed only 4,900, according to data compiled by Bloomberg.

African-style safari resort now open for overnight stays in Saudi

Giraffes, zebras and ostriches roam the golden plains as open-topped vehicles filled with travellers trundle over the sand. The tourists are on the lookout for wildlife, they are hoping to spot pygmy hippos, white oryx, wildebeest, impala and cheetahs.

This might sound like a scene straight from Africa, but it's actually a little closer to home. This is what awaits anyone checking in at the Nofa Resort Riyadh, a Radisson Collection Hotel.

It is less than 100 kilometres from the Saudi capital, just off the Riyadh-Makkah Highway. The Radisson resort opened in 2018 but was previously only open to members of the hotel's loyalty programme. Now, the family-friendly hotel that overlooks Nofa Wildlife Park is open to the general public and overnight stays start from 1,710 Saudi riyals.

The resort aims to give travellers the feeling of a holiday in Africa. As well as being home to several species, the wildlife park has a conservation arm - eight giraffes have been born through its breeding programme and several endangered species call the Saudi reserve home. Villas at the Nofa Resort

Riyadh have temperature-controlled pools and private villas.

"We have received numerous requests from individual guests wanting to experience the beauty of this Safari jewel in the Saudi desert, and we are excited that the hotel is now publicly bookable and accessible to everyone," said Tim Cordon of Radisson

Accommodation options at the resort include private villas or bungalows, all of which come with African-style thatched roofs and a private swimming pool and garden. There are also two resort pools, including a separate one for women. A Kids Club is on site, while adults can visit the health spa. When it comes to eating, Tswalu serves up all-day dining with an African twist and there's also an African tea room, shisha lounge and two other restaurants for guests to try.

Death of US Supreme Court's Ginsburg raises stakes in battle for Senate control

WASHINGTON

THE death of Supreme Court Justice Ruth Bader Ginsburg has raised the stakes in the struggle for control of the U.S. Senate, forcing embattled Republican incumbents to choose between trying to appeal to moderate voters or hoping to fire up a conservative base.

President Donald Trump on Saturday said he would quickly nominate a successor to the liberal icon. Republican Senate Majority Leader Mitch McConnell has promised a vote, giving the pair a chance to cement a 6-3 conservative majority on the court while their party holds both the White House and a 53-47 Senate majority.

That would raise the chances of

the court overturning the 1973 Roe v. Wade decision that legalized abortion, placing one of the most heated social and political battles in the United States front and center on the campaign trail.

With the court vacancy coming so near the Nov. 3 presidential and congressional elections, Democrats argue that the voters should weigh in before Trump and McConnell rush to fill the seat -- the very argument McConnell employed in 2016 to block a nominee of President Barack Obama's.

"There are those people who have a hypocrisy meter and it just offends them," said Larry Sabato, director of the University of Virginia's Center for Politics, referring to Republicans' changing strategies.

Polls show Democratic presidential nominee Joe Biden leading Trump ahead of the November election, and also give Democrats a chance of unseating enough Republican senators to capture a majority in that chamber.

Now, multiple incumbent Republican senators face the choice of backing Trump's eventual court nominee and potentially losing some moderate voters, or rejecting that person and angering the conservative base.

About seven Republican incumbents and two Democrats face a chance of losing their seats in November's election, according to nonpartisan election trackers. Democrats would need a net gain of three seats for a majority if presidential nominee Joe Biden unseats Trump, meaning a Vice President Kamala Harris would be on hand to break 50-50 ties in the Senate.

One of the most threatened Senate Republicans, Maine's Susan Collins, on Saturday said the Senate should hold off approving a nominee.

"In fairness to the American people, who will either be reelecting the President or selecting a new one, the decision on a lifetime appointment to the Supreme Court should be Carolina's Thom Tillis said in a statemade by the President who is elected on November 3rd,"

Collins said on Twitter.

Colorado's Cory Gardner issued a statement offering warm words about Ginsburg's memory while making no mention of the looming political fight.

"This is an enormous political conundrum," said Paul Sracic, a political science professor at Youngstown State University in Ohio. "You're going to lose someone in this," referring to segments of senators' home-state voters.

Collins and Gardner did not respond to requests for comment.

Adding to the pressure will be independent-leaning Republican Senators Mitt Romney and Lisa Murkowski, neither a vocal Trump backer. If that pair voted against a Trump pick, Mc-Connell would be left with a one-vote margin.

Neither Romney nor Murkowski commented publicly on their intentions following Ginsburg's death, though Murkowski has previously indicated she would be inclined not to back any Supreme Court nominee in the final weeks before an election. Neither responded to requests for comment. Other Republicans in competitive races saw the chance to vote for Trump's third Supreme Court appointee as a winning issue.

TikTok expects three-party deal to resolve US concerns

LOS ANGELES

Video-sharing social networking platform TikTok on Saturday voiced hope that an agreement reached by its Chinese parent company ByteDance with Oracle and Walmart will "resolve the security concerns of the US administration and settle questions around TikTok's future in the US.

The Los Angeles-based company issued a statement Saturday afternoon, hours after US President Donald Trump said he had approved a deal between the three parties.

TikTok disclosed some details about the three-party agreement handed over to the authority Monday and weighted by the White House so far, saying Oracle will become its "trusted technology provider," and Walmart will play a role in "commercial partnership."

As part of this proposal, Oracle would be in charge of hosting TikTok's all US user data and securing associated computer systems to "ensure US national security requirements are fully satisfied," the statement noted.

According to the company, as of June, the total number of TikTok's monthly active users in the country soared to 91,937,040, and based on quarterly usage, 100 million Americans used the app.

The statement also said both American companies will take part in TikTok's global pre-IPO financing round in which they can take up to 20 percent cumulative stake in the company. A business insider familiar with the deal told Xinhua that TikTok had a plan to finish IPO in the US market in one year if possible.

"We will also maintain and expand TikTok Global headquarters in the US, while bringing 25,000 jobs across the country," the company promised, adding "Our team works tirelessly to provide a safe and inclusive platform and we're thrilled that we will be able to continue serving our amazingly diverse and creative community."

Russia to continue efforts for preserving Iran nuclear deal - Foreign Ministry

MOSCOW

RUSSIA will continue efforts to ensure that the terms of the Joint Comprehensive Plan of Action on the Iranian nuclear program remain in place and are implemented, the Russian Foreign Ministry said in a statement yesterday.

"The efforts on preserving and ensuring sustainable implementation of JCPOA will continue," the ministry emphasized. "The UN Security Council Resolution 2231 remains unchanged and the commitments arising from it must be fulfilled in the initially agreed mode and volume on the basis of the reciprocity principle by all states," it said.

Moscow highlights that in August the UN Security Council's members dismissed the US attempts to restore the UN's anti-Iranian sanctions as void. In September, this stance was confirmed and Russia fully agrees with it, the Russian diplomats said.

"To claim now that sanctions resolutions against Iran have been restored is wishful thinking. We hope that US colleagues will be brave enough to finally face the truth and stop speaking on behalf of the UN Security Council," according to the statement. "Illegitimate US initiatives and actions definitely cannot have international and legal consequences for other countries and create their obligations

to limit legitimate cooperation with Iran." However, Washington keeps speculating on this issue claiming that the UN has launched some procedures on restoring restrictions against Iran, it said. The Russian Foreign Ministry dismissed the US steps as a theater performance aimed at turning the UN Security Council into Washington's own tool of "maximum pressure" on Tehran.

"The brazen behavior contrary to JCPOA and UN Security Council Resolution 2231 becomes a serious blow from the United States to the authority of the UN Security Council, a manifestation of open disregard for its decisions and international law in general. This is unacceptable, not only for us, but also for other members of the Security Council." the statement said. "It is not surprising that the gamble launched by the US side with the illegal "reset" of the old UN Security Council sanctions against Iran has failed. "

On August 20. US Secretary of State Mike Pompeo notified the UN Security Council about Washington's plans to start restoring UN sanctions against Iran. According to the US, the sanctions may come into effect on September 20, despite the opposition of other UN Security Council's member-states.

In 2018, the United States withdrew from the Joint Comprehensive Plan of Action (JCPOA) developed by Russia, the US, the UK, China, France and Germany with Tehran to overcome the crisis related to the Iran's nuclear program and initiated then a campaign of 'maximum pressure' against Iran.

On September 11, Russian Foreign Minister Sergey Lavrov told a press conference with his Chinese counterpart Wang Yi that Russia and China together with the majority of UNSC member-states did not accept US attempts to dismantle JCPOA.

Poverty alleviation window on how China's system works - expert

WASHINGTON

CHINA'S approach to poverty alleviation as well as to containing the COVID-19 pandemic is a window for foreigners to understand how the country's system actually works on the ground, said Robert Lawrence Kuhn, chairman of the Kuhn Foundation.

MICROCOSM OF CHINA'S DE-VELOPMENT

"What I recognized in the process of focusing on poverty alleviation was how significant this is to understand China, to understand all of China's development over 40 years of reform and opening-up," said Kuhn (pictured) in a recent interview with Xinhua, while sharing his experiences on filming a documentary on China's fight against

"Poverty alleviation is a microcosm of China's development, as

actually works on the ground," he

Hosted and written by Kuhn of the Kuhn Foundation, directed by award-winning director Peter Getzels, and executive-produced by Adam Zhu, "Voices From the Frontline: China's War on Poverty" has been aired on Public Broadcasting Service (PBS) stations since its premiere on PBS SoCal.

Kuhn and his team followed how six Chinese families struggled to find a way out of poverty with help from local government officials. Director Getzels took a more observational approach, instead of a journalistic one.

"China has brought over 850 million people out of poverty, the greatest developmental success story in human history. It is the China story that must be told," Kuhn said. "When historians of the future write the chronicles of our times, a it showcases how China's system feature story may well be China's



targeted poverty alleviation."

Kuhn noted a striking correlation between China's approach to fighting the coronavirus outbreak and to fighting poverty.

"Although all political systems have trade-offs, the system that effectively contained the coronavirus in China is the same system that has been able to eliminate almost all extreme poverty in a little over commitment and massive mobilization of resources," he said.

plishment of social-engineering," he said.

MASSIVE, HIGHLY TARGETED

The documentary, which took Kuhn and his team three years to complete, revealed a rare, behindthe-curtain glimpse of the poverty alleviation plan in China, the huge government program that has pledged to lift China's most indigent citizens out of extreme poverty by the end of 2020.

Kuhn, who has been closely following China's dramatic transformation for over three decades, said he was fascinated that China's solution was to create a massive, highly targeted, individualized poverty alleviation program.

"To truly understand China, one has to recognize their genuine coma decade. They both take national mitment to eradicate poverty," he said, adding he was impressed by the sheer scope and determina-"This is an extraordinary accomtion of China's poverty alleviation

program, energized by the commitment and intensity of President Xi Jinping.

Like no other on Earth, China's program was based on crafting an individualized plan for every single family below the poverty line, then having them be visited regularly by a young local official who helps them implement new strategies to increase their income, he said, adding that progress is monitored and reports are filed monthly.

"I visited with these young local officials working on the frontlines of poverty alleviation, on some occasions intensely for several days: seeing stark, concrete rooms in which they live and watching them cook their food over simple kerosene burners or even candles. And they are dedicating their lives, often spending two full years in a remote village with no modern conveniences, not even flush toilets," he Xinhua

OPEC member Libya edges closer to reopening battered oil sector

LIBYA moved closer to reopening its battered oil industry after the state energy firm said it would resume exports, though only from fields and ports that are free of foreign mercenaries and other fighters.

The National Oil Corp is ending force majeure -- a legal status protecting a party if it can't fulfill a contract for reasons beyond its control - at "secure" facilities and has told companies to resume production. The shutdown would continue elsewhere until militias leave, the NOC it said in a statement on Saturday.

Some firms that use or operate the OPEC member's eastern ports announced they were restarting work. They included Arabian Gulf Oil Co, which can produce almost 300,000

barrels a day and exports them from Hariga port, and Sirte Oil & Gas Production and Processing Co, which runs the Brega terminal.

It was unclear whether militias would move out of major fields such as Shahara in the south-west, the country's largest deposit and which was occupied by mercenaries from Russia's Wagner group earlier this year. The NOC said last week it would be dangerous to start pumping oil again with armed forces in close proximity.

EU plans to crack down on racism in 'moment of reckoning'

BRUSSELS

European Commission pledged on Friday to take tougher action against member states failing to fully implement EU anti-racism laws, in a move reflecting global outrage at police violence against African Americans in the United States.

Launching its first anti-racism action plan, the Commission said the initiative allows so-called infringement actions, a process that can involve the Commission taking an offending country to the EU Court of Justice.

"We know that progress to fight racism and hate in Europe is not good enough," Vera Jourova, the EU Commission's vice-president for values and transparency, told reporters in Brussels. "The protests sent a clear message - change must happen now."

It is a "moment of reckoning" for Europeans, where racism can no longer be ignored, she said.

The May 25 death of black American George Floyd in police custody has led to weeks of protests in the United States against racism and policy brutality, and prompted more European citizens to

challenge discrimination in society. Under the plan, the 27 EU nations would face closer scrutiny, investiga-

tions and possible infringement procedures if the European measures are not correctly applied. The Commission has also called for a

"new approach on equality data collection" to get a better picture of discrimination in Europe and to push the bloc to cThe EU Commission also plans to review its existing rules to guarantee they are strict enough and possibly present new legal measures in the next five

France, UK, Germany reject US call to return Iran sanctions

NEW YORK / TEHRAN

THE US has no authority to demand a snap-back in sanctions against Iran after quitting the 2015 nuclear deal two years ago, the French Foreign Ministry said in a joint statement with Germany and the UK yesterday.

"We have worked tirelessly to preserve the nuclear agreement and remain committed to do so," the three countries' foreign ministers said in the statement.

Since quitting the nuclear accord in May 2018, the Trump administration has intensified efforts to pressure the Islamic Republic, ratcheting up sanctions. But the US moves have united partners like the UK, France and Germany with Russia and China, who have sought to salvage the accord.

That has left the US isolated on the UN Security Council, with most nations saying America has no authority to demand the return of international sanctions since it's no longer a party to the agreement.

The US says that the broader Security Council resolution that enshrined the accord doesn't require it to still be in the agreement, and that all of the United Nations resolutions on Iran that were in place before the accord -- from a ban on arm deals to restrictions on the Islamic Republic's ballistic missile activity and its nuclear enrichment -- should have gone back into effect on Saturday.

The US expects all UN member states to comply with their obligations to implement sanctions, Secretary of State Michael Pompeo said in a statement late

However, United Nations Secretary-General Antonio Guterres told the Setake any action on a US declaration that all UN sanctions on Iran had been reimposed because "there would appear to be uncertainty" on the issue.

Pompeo said last month that he triggered a 30-day process at the council leading to the return of UN sanctions on Iran on Saturday evening that would also stop a conventional arms embargo on Tehran from expiring on Oct 18.

But 13 of the 15 Security Council members say Washington's move is void

because Pompeo used a mechanism agreed under a 2015 nuclear deal between Iran and world powers, which the United States quit in 2018.

"There would appear to be uncertainty whether or not the process \dots was indeed initiated and concomitantly whether or not the (sanctions) terminations ... continue in effect," Guterres wrote in a letter to the council, seen by

"It is not for the Secretary-General to proceed as if no such uncertainty

Russian scientists create chip that accelerates development of 6G networks

RUSSIAN specialists created a new type of chip that accelerates the development of the sixth generation communications networks, presidential representative on digital and technological development, Dmitry Peskov (pictured) said at an online conference, organized by TASS Thursday.

"I can't tell you where exactly, but one Russian lab has made a breakthrough in 6G just recently, creating a new type of chip that did not exist in the world before. What I'm saying is



that the 6G is already in sight," Peskov said, adding that the lab in question was a civilian one.

Introducing sixth generation communication networks requires solving such technological tasks as deployment of relatively more base stations closer to the subscriber, he added.

"In several years, we will receive mass Internet from space, it will become very close to us. It must be perceived as a basic infrastructure," the presidential representative said, outlining the technological prospects for the Agencies

Multiple major economic indexes of China see positive growth in August

CHINA saw the first positive growth of total retail sales of consumer goods since this year in August, and the total value added of the industrial enterprises above the designated size shifted from negative to positive in the first 8 months of this year, said the country's National Bureau of Statistics (NBS) at a press conference on Sept. 15.

NBS spokesperson Fu Linghui said despite pressures from both the COV-ID-19 fallout and floods, the country's economy has sustained a steady recovery.

Many positive changes happened to China's economy in August. In the first eight months, industrial output expanded 0.4 percent from one year earlier, compared with a decline of 0.4 percent in the January-July pe-

The improved demand drove the growth of industries, said Fu, adding that the country's value-added industrial output, an important economic indicator, went up 5.6 percent year on year in August, accelerating from a rise of 4.8 percent registered in July.

Most productions and industries achieved growth, according to the NBS. In terms of different products, in August, 394 of 612 products increased year on year. In other words, 64.4 percent of these products achieved growth, more than those from a month ago. In terms of different industries, in August, the value added of 29, or 70.7 percent of the 41 major industries maintained a yearon-year growth, 4 more than those in

Apart from industrial growth, China has also seen accelerated steps of upgrading. The high-tech manufacturing enterprises above designated size achieved a growth of 7.6 percent in August, a figure obviously larger than the general growth of the industries above designated size.

New products such as service robots, segways and smart watches all witnessed a production growth above 70 percent, while that of industrial robots stood at 32.5 percent.

Retail sales of consumer goods, a main gauge of China's consumption, returned to growth for the first time this year, rising by 0.5 percent year on year in August.

"August saw a larger pickup of sales from a month ago, which indicated the accelerated recovery of the consumer market," said Zhang Min, a statistician with the NBS.

According to Zhang, China's rural and urban markets recovered simultaneously. In August, the retail sales of urban and rural consumer goods increased 0.5 percent and 0.7 percent, respectively, while they decreased 1.1 percent and 1.3 percent in

Besides, the consumption went through faster upgrading. The sales of automobiles above the designated limit went up by 11.8 percent in August, and the sales of communication equipment, cosmetics, gold, silver and jewelry grew by 25.1 percent, 19.0 percent, and 15.3 percent respectively, up 13.8, 9.8 and 7.8 percentage points from those in July.

New consumption maintained rapid growth. From January to August, the online retail sales of physical goods grew by 15.8 percent, 0.1 percentage point higher than that in the first seven months. Driven by the growth of online shopping, China handled 7.24 billion express parcels throughout August, up 36.5 percent year on year.

Collective action within UN framework needed to tackle global challenges

AHEAD of the high-level meetings of the United Nations scheduled for Monday, the international community expects world leaders to make collective efforts to address global challenges.

This year marks the 75th anniversary of the UN which finds itself standing at another juncture in human history given rising unilateralism and protectionism.

"As we mark the 75th Anniversary of the United Nations, it is clear that the world has high expectations of us, as the

main platform for multilateralism and cooperation on a rulesbased international system," Secretary-General Antonio Guterres said at the opening of the first plenary meeting of the 75th session of the UN General Assembly (UNGA).

Last week, UN member states are expected to adopt a declaration, reaffirming their commitments to a reinvigorated multilateralism. In his opening remarks at the UNGA meeting,

Volkan Bozkir, president of the 75th session of the UNGA, said "the context in which we are working serves to remind us of the necessity of the mul-

tilateral system and inspires us all to make use of the UN Charter to address our collective challenges," in reference to the COVID-19 pandemic.

The disease that has been ravaging across the world has infected more than 30 million people and killed almost 1 mil-

At this critical time, "this is the unprecedented opportunity to build back better and

For Africa, the path we must take is clear. The UN 2030 Agenda for Sustainable Development is a template for global cooperation and partnership,"

South African President Cyril the authority and stature of the Ramaphosa said via a UN videoconference on Thursday.

"Our experience with COV-ID-19 has really demonstrated what can be achieved if we act and work together to address global challenges," said Ramaphosa, also the chairperson of the African Union.

In its position paper on the 75th anniversary of the UN, China reaffirmed its commitment to safeguarding the UNcentered global governance system, the basic norms of international relations underpinned by the purposes and principles of the UN Charter,

UN, and the central role of the UN in international affairs.

Bertrand Badie, a veteran specialist on international relations at France's Sciences Po university, said in face of unilateralism and hegemonism, all countries should be committed to multilateralism by upholding the purposes and principles of the UN Charter and the international system with the UN at the core.

He called for abandoning the Cold War mentality and hegemonism and building a international relationship that is more fair and equal.

"Although the UN needs to be

strengthened and reformed, it plays an irreplaceable role in such fields as promoting security, economic cooperation, and public health cooperation," said Liu Di, professor with the Faculty of Social Sciences of Kyorin University in Tokyo.

Cavince Adhere, an international relations researcher based in Nairobi, said the world is facing challenges across borders, from the COVID-19 pandemic to climate change, underlining that all countries should strengthen solidarity to coordinate their efforts instead of pursuing unilateral moves. Ignacio Martinez Cortes, professor of political science at the National Autonomous University of Mexico, said the world needs China's experience to help other countries emerge from the current public health crisis and needs China to promote multilateralism within UN frameworks, which illustrates the concept of building a community with a shared future for mankind.

"In this 75th anniversary year, we face our own 1945 moment," Guterres said, stressing that "we must show unity like never before to overcome today's emergency, get the world moving and working and prospering again, and uphold the vision of the Charter." Xinhua

On a day of high drama Leeds edged Fulham 4-3 to earn their first top-flight victory since 2004 on Saturday and Everton went top of the table as Dominic Calvert-Lewin scored a hat-trick in a 5-2 destruction of 10-man West Brom

On the second weekend of the new campaign, United were playing for the first time after being given an extra week of rest due to their involvement in the latter stages of last season's Europa League.

But Ole Gunnar Solskjaer's lethargic side were well below their best and Palace took full advantage thanks to Andros Townsend's seventh minute strike and Zaha's double against his former club.

There was a hint of controversy about Zaha's first goal as VAR ruled Victor Lindelof had handled Jordan Ayew's shot even though the ball was hit with force at him from close

David De Gea saved Ayew's spotkick, but VAR intervened again to order a retake as United's keeper had strayed off his line and this time Zaha converted from the spot.

United's only close-season signing Donny van de Beek came off the bench and the former Ajax midfielder reduced the deficit with a debut goal in the 80th minute.

But Zaha, who endured a difficult spell at United before rejoining Palace, showed why the Eagles are so keen to keep him amid speculation over his future as the Ivory Coast winger lashed home in the 85th minute.

For the first time in six years, United were beaten in their opening league game.

It was a chastening start to the season for United, who have come under fire from fans frustrated at their relatively modest transfer outlay compared to their title rivals.

Arsenal capitalised on the chance to open up a six-point gap over United in the battle for a top-four finish despite a poor performance of their

Fulham striker Aleksandar Mitrovic equalised from the penalty spot but Leeds soon retook the lead with a spot-kick of their own, converted by Mateusz Klich.

Patrick Bamford and Costa's superb strike looked have Leeds cruising to their first win back in the topflight by the hour mark.

But Fulham pulled one back in the 62nd minute through Bobby Decordova-Reid and Mitrovic's towering header four minutes later set up a tense finale.

Leeds' opening games have seen 14 goals, which is the most for a topflight side's first two matches since Wolves in 1962-63.

At Goodison Park, Everton's earlyseason optimism was not curbed despite falling behind to Grady Diangana's early goal.

Calvert-Lewin bundled home an equaliser before James Rodriguez put Everton ahead with his first Premier League goal and Albion imploded before the break.

Kieran Gibbs was dismissed for pushing James in the face in first half stoppage-time and then Baggies boss Slaven Bilic was sent to the stands after storming onto the pitch for a furious rant at referee

Matheus Pereira equalised for Albion after the interval, but Michael Keane restored Everton's lead and Calvert-Lewin sealed the points with his second and third goals.

Barca's Bartomeu: I won't go to war with Messi

BARCELONA

BARCELONA president Josep Maria Bartomeu says he will not go to war with Lionel Messi and called for everyone to move on after the forward tried to quit the club last

Bartomeu also said he has no plans to step down from his position despite a motion to remove him -- which was sparked by Messi's request to leave -- gathering more than 20,000 signatures this week.

Messi, 33, returned to training with Ronald Koeman's new-look Barca side earlier this month after failing to engineer a move away from Camp Nou this summer.

When he realised legal action would be required to try and execute a clause in his contract to leave for free, he backed down, although he was critical of Bartomeu in an interview with Goal after the episode ended.

"As president, I will not enter into any conflict with Messi," Bartomeu told TV3 on Saturday. "Messi is our captain, our leader. The issue is parked. What has been said has been said.

"I couldn't allow to let the best player in the world go. The team needs him, he guarantees success. Things have to be discussed at home. You have to support the team and the players.

"We have to congratulate our-

selves that Messi is still with us. He is excited about Koeman's project. The important thing is he plays for Barca, at his home. We want him to retire at the club.'

Messi could yet leave the club for free next summer when his contract expires but Bartomeu could be gone by then.

The president will face a vote of no confidence in the coming weeks if more than 16,520 of the 20,867 signatures against him are

For him to be ousted, two-thirds of voting members would then have to go against him in a referendum, but there have been calls for him to resign before reaching that

"Right now, no-one is considering resigning," Bartomeu said. "The club is not going to stop. I think everyone was surprised by the number of signatures but we respect democracy and the club's laws."

Bartomeu was speaking before Barca's third and final friendly of the preseason on Saturday, a 1-0 win against Elche at Camp Nou.

Midfielder Riqui Puig was a surprise omission from the squad. He watched the match from the stands alongside Luis Suarez, who's not featured in preseason as he looks for a new club, and Koeman later confirmed he's recommended the youngster go out on loan.

Barcelona's members strike back against president Bartomeu: What's next for the club?

EXT time you pop into the FC Barcelona boutique to buy blaugrana pants or more than a pencil, go past the ticket window by the museum or order a coffee at the café in the shadow of Kubala and Cruyff, look carefully at the guy behind the register. It that face looks familiar, that could be because it is. It might be Eder Sarabia, the former assistant coach taking up a new role.

Well, they've got to employ him somewhere.

On Thursday evening, at the end of a day when Luis Suárez had been in Italy, doing a language exam in Perugia to get an Italian passport, engaging in 10 minutes of conversation about family but not football, Quique Setién released a statement. In it, he revealed that he had been informed that he been sacked as Barcelona manager only the night before, on Wednesday -- a month after it had been announced to the world, and almost three weeks since his lawyers had written to the club to ask what was going on.

What's more, Setién said, there had still been no settlement on the 2½-year contract he'd signed eight months earlier. More money poured away, and yet to be paid. As for his staff -- Sarabia, Jon Pascua and Fran Soto -- they hadn't been sacked at all. Instead, he had now been told that they would be "repositioned" at the club, which was news to them.

It had been that kind of day, another one only somehow even sillier, sadder and, as it turned out, more significant. It was the eve of the 20th anniversary of Lionel Messi's arrival at Barcelona, which should have been cause for celebration, but this is a club in constant crisis, and even the fact that he is still there feels a bit odd. Above all, it was another one of those days for a president whose case for being the worst in club history gets more watertight by the hour.

It was a day in which more supposed transfer targets slipped away because -- just in case you didn't know, and somehow there still seem to be people who don't -- there is no money to buy them with. A day when €98m in losses over the past year were confirmed. One in which they still couldn't get rid of the players they publicly said they wanted to get rid of ... and, now it seemed, they couldn't get rid of the manager, either. Not properly, anyway.

Still, at least Setién's statement fit on one piece of paper. The bigger statement was delivered on thousands and thousands of them. And while on the face of it, it deepened the crisis, maybe it actually offered a way out of it -- or, at least, handed back some sense of control to those who care, a little light cast over the club, a glimpse of hope.

A little before 7 o'clock in the evening local time, a dozen people turned up at the Camp Nou. They wore masks, and they brought with them boxes, bags and containers, absolutely full of pieces of paper. On them, over 20,000 people had officially declared their desire that a motion of censure be brought against team president Josep Maria Bartomeu and his board of directors -- a motion that might finally force them

They stood, clapped a bit, and then the boxes were taken inside. For an hour or so, they were checked -someone turned up with coffee -- and officially received, the papers counted. This was the climax (or maybe it was just the beginning?) of a popular movement to push the president out.

While you might not have been aware of it, this had been building for a while. It had begun with Jordi Farré, who will stand at the next elections, and other opposition candidates who joined him; it became a broad movement, a united front in defence of the club. Víctor Font and Lluis Fernández Ala came on board. Fans groups supported them. At the head of one of them, a group called "Manifest Blaugrana," was Marc Duch, with his ponytail and beard.

Together they drove the campaign on and chased signatures all over Catalonia and beyond, under the slogan:

somehow, they had done it too. In a time of pandemic, when people can't meet, they had managed to gather fact. They'd needed only 16,521, 15% of the members. They were 4,000 over that, backed by more than a fifth of the club's membership.

A handful of the papers were not admissible, but a club statement confirmed they had received 20,867, a number that was everywhere the next day, like a winning lottery ticket. The figures were a new record -- this was twice as many signatures as had ever been gathered before (in far more favourable conditions). "Unprecedented," Font called it.

"If I was the president, I would have met the 20,000 socis," Farré said. "Honestly, Bartomeu should resign today."

Duch said: "I'd be trembling in my office and I would resign."

Bartomeu might not do that. In fact, if anyone has learnt anything about him over the past few years and the past months especially, it is that he is a survivor. Holding on is what he does, whatever the cost.

So. The signatures have been received and counted. What happens next?

-- First, Barcelona have to participate in putting together the body that runs and oversees the process.

"More than a moció" ("motion"). And, (The "table," as it's called.) That's made up of the two first signatories on the move to propose a no-confidence motion -- Farré is one of them enough signatures from socis (fans -- two members of the board of direcwho are club members) to force a tors, and a representative of the Catavote, effectively a referendum against lan football federation. They have the president. More than enough, in 10 working days to do that: in other words, by Sept. 29.

-- Then the "table" has to validate the signatures, which they must do within another 10 days. That takes us to Oct. 10.

-- If there are more than 16,521 valid signatures (which there will be), Barcelona will have to set up and arrange a vote of no confidence for the board of directors. It will be a referendum that basically asks: Do you want this president and his board to be sacked, yes or no? That will have to happen within 10 working days as well. All of which takes us to November, though all these things could happen quick-

Then what?

If two-thirds (officially 66.7%) of them are in favour, Bartomeu will have to step down with immediate

And once he's gone ...?

A commission would be put in place while presidential elections are organised and held. Given the timing, those would be held in January or February. Some of the candidates -- Toni Freixa, Joan Laporta, Farré, Font, in all likelihood someone from within the current administration

-- are clear, but some are not confirmed yet.

The socis will vote against Bartomeu, won't they?

Not necessarily, and 67% is of a lot of people to convince. After all, Barca have been in this situation before, and it has not always got over the line. In 1998, only 33.5% voted to kick out Josep Nuñez out (although the damage it did his presidency was decisive). In 2008, Laporta survived, but only just: 60.6% wanted him pushed out. A moció brought against Bartomeu in 2017 didn't get sufficient signatures to reach the referendum stage.

That said ... yes, you would think so now. There are already over 20,000 people who will vote against him, and it's hard to imagine him being able to mobilise sufficient support to survive, even if there will be some members who might not want to push through the no-confidence motion. Not least because there is little point trying to prop him up, as it would be only a temporary reprieve: presidential elections were set to be held on March 15 anyway and he was unable to stand, his term already

Why vote to keep him in for what would be barely a couple of months?

Well, then, why vote against him either? What was the point of all this? If he was going anyway, why do this now? And doesn't it create a vacuum?

Yes, it does, up to a point. But why do it? Well, because they can, which sounds flippant, but isn't.

Simply, they're doing this because it gets rid of Bartomeu faster. It could, although it is unlikely, even remove him before the next transfer window begins and probably will remove him before it ends. (Caveat alert: The consequences of all this in terms of whether he is eventually held accountable for any budgetary shortfall would depend on the general assembly in October, on the final financial figures and on the next administration, all of which remains to be seen.)

They're doing this because it means that he does not get to see out his presidency "normally," or on his terms. Because it holds him accountable, symbolically at least. Because, well, to repeat: because they can; because this is an expression, a rebellion, a statement, a taking back of power by the people, a way of exercising their rights, a sign that while there is only so much they can do, those mechanisms that allow supporters to safeguard Barcelona still stand and, even in the midst of a pandemic, can be applied. That they really do have say in the destiny of their club, that democracy is not dead yet. As the name suggests, it is a censorship motion -- and that matters. It's the chance to censor those who are not worthy of their club.


There will be trouble ahead, for sure, and the situation remains dramatic at the Camp Nou. The new administration will inherit a mess when they arrive, but for all that went wrong, for all the increased embarrassment, Thursday was a day when Barcelona -- as a club, not a board of directors -- recovered some of its dignity. And that is something to celebrate at last. Lord knows, it has taken long enough.
