

#### Dar watersheds uplift: TBL, WWF team up

Climate change is one of the most pressing global challenges of the moment. And beer brewing is closely tied to the natural environment, agricultural products and water being the key ingredients.

It is therefore no surprise that Belgian multinational brewing company, Anheuser-Busch InBev (AB InBev) - the parent company of Tanzania Breweries Limited - has invested in a two-pronged water management project that focuses on water use efficiencies inside the brewery and watershed protection on the outside.

AB InBev and the World Wide Fund for Nature (WWF) have partnered in implementing the Dar es Salaam Water Security Project, which seeks to restore the city's watersheds through bankable naturebased initiatives.

The Dar es Salaam Water Security Project is an integrated water resources management, with particular emphasis on catchment conservation.

The project will contribute to the achievement of the Tanzania's Development Vision 2025 and Africa's water vision for 2025, which is about attaining, "an Africa where there is an equitable and sustainable use and management of water resources poverty alleviation, socio-economic

# Tanzania an excellence centre in census conduct'

TANZANIA expects to continue with its record of conducting a successful census each time it has to do so, above what other countries in sub-Saharan Africa have usually achieved, the top statistician has declared.

Dr Albina Chuwa, the government statistician, told a press conference here yesterday that some countries have not carried out the census exercise for decades while others had their census results rejected by various parties in the specific countries.

"Tanzania has a record of conducting a successful census each ten years and the past five ones were successful," she said, noting that there is no fear that the coming census will be poorly conducted.

She affirmed that preparations for the nationwide event were at a high stage, with the National Bureau of Standards (NBS) completing the training of clerks, supervisors and other officials at the national and regional levels. The bureau was now training census officials at district and ward levels, lasting from July 31st to August 18th which is five days ahead of the census exercise, she said.

Upwards of 205,000 people across the country who applied for census clerk positions were shortlisted for training, the third phase of training after national and regional training

# Ludewa power cuts to end by next February

MADOPE Power Co., carrying out a 12-hour power rationing on 12 villages in Ludewa District from its 1.7MW hydropower station, will now sell its power to the government controlled utility, TANESCO, to end the rationing.

Energy minister January Makamba said the government has decided to buy all the power generated by the company to enable the people to get reliable power supply. At present only 0.3MW is supplied out of the 1.7MW generated, he said, underlining that the company will also get its revenue. The purchase is a solution in regard of the rationing by the power firm set up by the Lugarawa power user community and the Ludewa District Council.

The power rationing arose from the low tension cable for supplying power compared to actual power needs by consumers using electricity for various economic activities. These include sunflower oil processing plants and grain milling.

Addressing Lugarawa village residents, the minister said Tanesco officials will be dispatched to the area later this week to assess power transmission and sign an accord enabling that by next February Ludewa residents will be



getting reliable power supply.

The power station at present has 3,200 consumers, with the power being supplied to health centres, five secondary schools, 19 primary schools and one orphanage centre. Madope hydropower project stakeholders

include the Rural Energy Agency (REA) who provided 4.1bn/- for it to take off. Meanwhile, residents of Makete District

in Njombe Region are happy with start of implementation of the 1.4trn/- hydropower project signed in 1998 on the Rumakali water They told the minister during the visit that

they had already despaired about the project but now their hopes have been restored. Pastor Edna Mwihalagila, a resident of Makete, said women engaging in social activities are in a difficult spot without light

With adequate electricity, we will be able to preserve the environment as we will no longer use wood fuel for cooking."

Nehemia Sanga, a resident of Kipagalo ward where the power station site is slated, said that people are used to hearing about the hydropower project but nothing was going on.

"With this news, the residents of the Kipagalo, Bulongwa and Inio wards are assured that benefits are on the way," she said, noting that many residents will now have an opportunity to employ themselves in various income generating activities.

Project supervisor Toto Sedekiah said feasibility studies were conducted back in 1998 by Fred Power, an engineering firm, along with Mweno Consult, targeting 222kilovolt intensity of electricity. "They recommended the construction of an

Taylor Cofield, a US Embassy human rights officer, applauded the role played by the



government and Courage Worldwide (T) in combating illegal human trafficking and smuggling.

"On July 19th the US government released a report on illegal human trafficking in the world that included research of 180 countries. Tanzania was among the 21 countries in the world that have shown efforts in fighting against illegal human trafficking," he stated.

Janne Williamson, founder and CEO of Courage Worldwide, said organizing

the dialogue involved collaboration with the government, the national organization against human trafficking (TANAHUT), and the Tanzania Relief Initiative (TRI), among others.

"We have Courage House in Tanzania, a long term residential program for minor victims of sex trafficking," she said, describing it as among the first of its kind in Tanzania and Africa.

"There are few resources dedicated to the aftercare of victims. Tanzania has strong laws against the trafficking of children, but the government is

just beginning to enforce the laws, identify victims and look for more strategic ways to prevent the crime," she asserted.

Hundreds of girls are being trafficked nightly in small, rural towns in the vicinity of Moshi in Kilimanjaro Region, where hard data is difficult to find on just how many children are being trafficked and how many are vulnerable to this type of exploitation, the top activist noted.

"Our team is working at this time to collect data. Recently, high level

government officials reported to us that 500 girls were recovered who were trafficked to India, with no safe place for them to go to begin the long journey of healing. We are working diligently to expand aftercare homes and services in this country," she elaborated.

The organization has been present in Tanzania since 2008, becoming a registered Non-Government (NGO) in 2009. In 2011, Courage House (T) was opened and was immediately a home to 10 girls and two babies, she added.

development, regional cooperation, and the environment."

AB InBev and the WWF have previously partnered in different ways on water issues, for more than a decade. In Tanzania, TBL has highlighted its interest to invest in the watershed of Dar es Salaam, particularly in Msimbazi River. TBL has significant challenges with water supply, as water provided by the Dar es Salaam Water and Sewerage Authority (DAWASA) from Ruvu River is not enough, while water from some of the boreholes is low in capacity and quality.

TBL Generally, receives approximately 70 percent of the total water required by the industry. The company recycles and treats wastewater before using it for washing and thereafter discharging to Msimbazi

The Dar es Salaam Water Security Project covers upper Ruvu, lower Ruvu, Kinyasungwe, Wami, Mkondoa, Ngerenge, and the Coast.

The Dar es Salaam watersheds include the coastal and lower catchment of Wami-Ruvu basin. The Lower Ruvu and coast catchments extend from Morogoro to the west of Dar es Salaam, covering an area of about 18,000 square kilometres.

The entire Dar es Salaam watershed ecosystem faces various threats. For instance, Ruvu River, which supplies water to Dar es Salaam city, is facing water availability challenges. The river has been affected by unsustainable agriculture and poor land use practices, livestock incursion, and unregulated water abstractions. Ruvu River is heavily polluted through mining and agricultural activities, and has been affected by deforestation and general catchment degradation.

The river is also under the threat of climate change, and monitoring systems for what has been happening on its waters over the years are inadequate.

On the other hand, both Msimbazi and Mzinga rivers are under the threat of sand mining, flooding, and high pollution, due to wastewater and solid waste disposal, and the subsequent blockage of water flows. Valley cultivation, lack of vegetation along the riverbanks, sedimentation, and infrastructure barriers, add to the challenges

Also, groundwater abstraction in Dar es Salaam is not well managed. There are many unlicensed boreholes, putting water supply at risk.

AB InBev has flagged Dar es Salaam as one of the 'high risk' sites in Africa in terms of water supply. Dar es Salaam features a high demand for water against poor water infrastructure.

The water security project in the city is focused on capacity building, good governance, and finance, to address the quality and quantity of water, which is on an upward trajectory towards the 2025 goal.

The project seeks to establish the quality and quantity of water

in key rivers of the Dar es Salaam watershed, and engage both private and public stakeholders to explore bankable nature-based solutions by the end of 2022. It also purposes to select, manage, and finance scalable watershed management and restoration initiatives to improve water quality and quantity by the end of 2022.

Another key objective is to develop a large-scale bankable nature-based solutions business case to leverage on funding from private, public and development partnerships, for improved water quality and quantity, and restoration of ecosystems, by 2024. A bankable project is one that in many cases uses blended finance, has a positive environmental impact, and generates a positive return for certain stakeholders.

The funding required is \$600,000 to implement the project in a span of three years. In their strategy for a sustainable nature-based solution, the bigger water users - Coca Cola and TBL - have put together interest-free funds for grants and loans to environmental conservation groups and investors in environmental conservation. This is expected to improve the water quality and quantity in the Ruvu, Msimbazi and Mzinga Rivers.

The commitment that AB InBev has shown in this project further reinforces the fact that your favourite TBL brands have embraced sustainability to build a resilient environment for everyone to live in. Improving water availability in high stress areas in Dar es Salaam is one way of ensuring that there is a resilient natural environment, and healthy and strong communities of farmers and beer lovers.

Already, TBL and WWF have fabricated and installed concrete beacons in degraded water sources in the coast and lower Ruvu catchment. Re-vegetation through tree planting on about 200 hectares of land in the coast region and lower Ruvu catchment has been undertaken. Also, five cattle troughs have been constructed in lower Ruvu and eight environmental groups have been formed in the lower Ruvu catchment.

A mapping exercise has also identified the major water users from lower Ruvu and coastal catchments. Already, 15 private sector players have been promoted to create their own bankable projects. Two charcoal dams have also been constructed for water catchment and retention.

# Minister pleads with institute to publicise research findings in world-class journals

FINANCE and Planning minister Dr Mwigulu Nchemba has challenged the Institute of Finance Management (IFM) to come up with a strategy of ensuring its research findings are published in international journals.

In his speech read by the Deputy Permanent Secretary, Ministry for Finance and Planning Amina Khamisi Shabani over the weekend at the IFM Golden Jubilee Inaugural (1972-2022) ceremony, Dr Mwegulu said the institute must also come with strategies to improve its curriculum to produce graduates who are competent in the labour market.

Nchemba said the decision to publish its research in the international journals was very important to promote the institute as well as its students. He said that in the same vein, the institute must be innovative and embark on research that can bring positive changes to country developments.

The minister said the research findings will help to improve curriculum hence enable the institute to produce graduates who are competent in the labour market

"At this juncture, FM must focus to be a centre of excellence by ensuring that its research publications go beyond borders and being published in the international journal," he said.

"The government's target is to see that the institute's core function of conducting research brings positive changes to the country's development and the graduates become competent in the labour market," he said.

Prof Godwin Mjema, the IFM Governing Council chairman said that the institute has invested in improving infrastructure including establishing a new campus and training its human

He said that despite success achieved, the institute was facing a shortage of human resources, especially the lectures for its campuses of Simiyu, Dodoma and Mwanza region.

IFM Acting Rector, Dr Emmanuel Mzava said the institute has recorded a number of successes since its inception including an increase in the number of students enrolled.

He said up-to-date, a total of 53044 students have graduated so far, serving in government offices as well as in private sector.

Dr Mzava said the graduates were from different courses such as Insurance, Finance, Social Security, Business Administration, Computer Science and Information Communication Technology (ICT) to mention the few.

He added that currently, the institute is currently conducting 33 courses from the two courses in 1972 which were insurance and finance.

Also, the number of publications increased from 28 to 84 publications adding that for the past five years, it has published 332.

As one the institute's core functions, it has earned 3.9bn/ from consulting services made to the government.

So far, the institute has 78 PhD holders while 29 others were in different stages of their studies within and outside the country.

The golden jubilee is also celebrated in its campus of Simiyu and Mwanza region. IFM is a public Institution in Tanzania established in 1972.

It stands as the oldest higher learning financial institution in Tanzania. The institute has been involved in teaching, research, and consultancy.

#### **Conservation, sustainable** use of oceans and marine resources decisive - govt

PROTECTION of marine environment and the ocean remains among key government priorities, Foreign Affairs and East African Cooperation minister, Liberata Mulamula has said.

She was speaking over the weekend in Dar es Salam at the closing session of a workshop on the assessment of the state of marine environment including social economic aspects.

Ambassador Mulamula said the government recognises the workshop as an important event in strengthening scientific knowledge on marine environment as a basis for policy making and global ocean governance.

"We are determined to protect the ocean as we also address the issues of climate change. I am pleased to learn that the workshop was a success. There are a number of projects that are geared to protecting oceans and sustainable use of the oceans and marine resources," she

According to her, most of the projects are implemented by Ministry of Blue Economy and Fisheries in Zanzibar.

She said the workshop has been significant in developing innovations needed to address ecosystem stresses and other complex blue economy challenges such as pollution, climate change and overfishing.

"I am aware of the on-going negotiations in New York on the establishment of an intergovernmental legally binding instrument under the United Nations Convention on the Law of the Sea on the Conservation and sustainable use of marine biological diversity beyond areas of national jurisdiction," the Ambassador added.

Mulamula said the instrument is important for ocean governance in high seas.

She said the government remains committed to constructive engagement and support towards the establishment of such an instrument, and reiterates its faith in multilateralism as a pillar in protecting marine environment and ocean governance consistent with the United Nations Conventions on the Law of the Sea.

She commended the UN through the Office of Legal Affairs, Division for Ocean Affairs and Law of the Sea for accepting a government invitation to organize the workshop in Tanzania.

Ambassador Mulamula commended the National Environment Management Council (NEMC) Director, Dr Samuel Gwamaka for the efforts made to ensure the ten days workshop is held in Tanzania.

The workshop was opened by Vice President, Dr Phillip Mpango on July 19th 2022, who called for the world to work tirelessly to protect the ocean against pollution and avoid the climate crisis. He said if efforts are not taken, by 2050 the ocean will be full of plastics.



# Climate change biting, farmers go into fishing

CLIMATE Change not only changes weather patterns and its intensity, but for Manyara Region, its effect has changed farmers into fishermen.

That is the latest discovery in Babati District of Manyara, where it has come to light that two local Lakes of Burunge and Manyara suffer from influx of fishermen, most of them being new entries in the trade having ditched their previous land tilling occupation.

Benson Mwaise, the Secretary of Burunge Wildlife Management Area in Babati Rural says that there have been two excessive spells of weather in the area, all contributing to the destruction of crops and farming areas.

"First we experienced torrential rains that flooded most farms and grazing areas, forcing wild animals to invade households and destroying crops in nearby farms," revealed Mwaise.

As it happens farms were destroyed by excessive rains that submerged a number of farms and human settlements in most parts of Babati and Monduli Districts of Arusha and Manyara, Regions.

Human-Wildlife conflict episodes ensued on that animals' grazing area were submerges displacing the species that were driven to seek new abodes and pastures in farms and residential

Local leaders in the precinct added that after the destructive rains there followed serious dry spells, which means it was no longer possible to farm, therefore most farmers decided to try their hands in fishing.

"It is not just local farmers from nearby villages, but of late we have been experiencing aliens from other districts, far off regions and even from neighboring countries coming to

fish in Lakes Burunge and Manyara," explains Hamisi Gyori of the Chem-Chem Association.

As a result, the two lakes are suffering from serious cases of pollution because fishermen from far-off lands do not adhere to the set guidelines of conducting such activities in and around the water bodies.

Representatives of various media outlets, members of the Environment Journalists Association of Tanzania recently visited the Burunge WMA which operates within the Kwakuchinja Wildlife Corridor linking Tarangire and Lake Manyara National Parks.

The journalists' environment study trip was funded by the United States Agency for International Development (USAID), through the 'Tuhifadhi Maliasili,' project.

Tuhifadhi Maliasili project addresses some of the key drivers and associated threats to improve conservation in Tanzania, particularly in six important wildlife corridors.

The wildlife passageways include Amani-Nilo, Kwakuchinja, Nyerere Selous-Udzungwa, Kigosi Moyowosi-Uvinza, Tarangire-Simanjiro Plains, and Pemba Channel Conservation Area (PECCA)

# Govt set to distribute tablets in all schools

THE government is set to distribute tablets in schools after the end of this year's Population and Housing Census (PHC), Education, Science and Technology Minister Prof Adolf Mkenda has said.

Prof Mkenda unveiled this in Dar es Salaam over the weekend when outlining the ministry's direction, priorities and strategic areas of work for the 2022/23 financial year.

The minister said the tablets will be distributed after the completion of this year's enumeration, which is scheduled for August 23.

The gadgets, according to him will reduce some of the costs that incurred in teaching and learning in schools countrywide.

"We believe that after distributing these tablets, they will help to a large extent to reduce some costs such as the use of papers," Prof Mkenda said, adding: "This will not be a challenge as we believe the National ICT Broadband Backbone (NICTBB) will reach almost all areas including schools.'

According to Prof. Mkenda, the distribution of these gadgets in schools will help increase the effectiveness of teaching and learning in schools.

The 2022 PHC is expected to be done on August 23 and will be done digitally and tablets are the devices that will be used to complete the task. According to the National Bureau of Statistics (NBS), the tablets needed for the entire country to achieve the task are more than 200,000.

Prof Mkenda also said that the ministry has prepared a special programme for to motivate and encourage novel writers in the country be it in Kiswahili or English.

The move is geared towards encouraging the detailed novel writing and those books be sold within and outside Tanzania and the writers earn good and sustainable incomes.

"There are good things that are going on now that have not been written

and if they are written, they will be providing a great lesson to the people, so we have started this program to encourage book writers," said Prof. Mkenda. "There is a section that has been set

aside for this competition, the main goal is that we want these good things that happen in our environment, in our country to be written in depth and based on high quality art."

He said that books that are well written will also be sent to be used in

"We're not saying that the existing books will no longer be used, no, unless we want them to be written with other things that describe the current good environment that many do not know," he said, adding:





Dr Sarfo indicated that the symptoms of hepatitis B one could look out for include, headache, bodily pains and nausea. He warned that when these symptoms persist and remain ignored, the Hepatitis B virus gets to the very chronic stage and starts decolorising the eyes, making them look yellow. "Mostly this is when most people become alarmed and seek medical attention but we must not wait until we become very weak when we start experiencing certain unusual symptoms before we think about seeking help. Rush to the hospital any time you start feeling sick."

According to Dr Sarfo, hepatitis B has become very common in Ghana and was affecting sufferers of the disease and their families badly so there is the need for unvaccinated persons to get vaccinated to protect themselves and their loved ones.

# Africa taken for 'neo-colonial' ride

IKE so many others, Africans have long been misled. Alleged progress under imperialism has long been used to legitimize exploitation. Meanwhile, Western colonial powers have been replaced by neo-colonial governments and international institutions serving their interests.

'Shithole' pots of gold

**US President Donald Trump's** "shitholes", mainly in Africa, were and often still are 'pots of gold' for Western interests. From 1445 to 1870, Africa was the major source of slave labour, especially for Europe's 'New World' in the Americas.

Walter Rodney's How Europe Underdeveloped Africa noted "colonised Africans, like precolonial African chattel slaves, were pushed around into positions which suited European interests and which were damaging to the African continent and its peoples.'

The 'scramble for Africa' from the late nineteenth century saw European powers racing to secure raw materials monopolies through direct colonialism. Western powers all greatly benefited from Africa's plunder and ruin.

European divide-and-conquer tactics typically also had pliant African collaborators. Colonial powers imposed taxes and forced labour to build infrastructure to

enable raw material extraction. Racist ideologies legitimized European imperialism in Africa as a "civilizing mission". Oxford-trained, former Harvard history professor Niall Ferguson - an unabashed apologist for Western imperialism insists colonialism laid the foundations for modern progress.

Richest, but poorest hungriest!

A recent blog asks, "Why is the continent with 60% of the world's arable land unable to feed itself? ... And how did Africa go from a relatively self-sufficient food producer in the 1970s to an overly dependent food importer by 2022?"

Deeper analyses of uncomfortable African realities seem to be ignored by analysts influenced by the global North, especially the Washington-based international financial institutions. UNCTAD's 2022 Africa report is the latest to disappoint.

It does not guide African governments on how to actually implement its long list recommendations given their

limited policy space, resources and capabilities. Worse, their proposals seem indistinguishable from an Africa-oriented version of the discredited neoliberal Washington Consensus.

With 30% of the world's mineral resources and the most precious metal reserves on Earth, Africa has the richest concentration of natural resources - oil, copper, diamonds, bauxite, lithium, gold, tropical hardwood forests and fruits.

Yet. Africa remains the poorest continent, with the average per capita output of most countries worth less than \$1,500 annually! Of 46 least developed countries, 33 are in Africa - more than half the continent's 54 nations.

Africa remains the world's least industrialized region, with only South Africa categorized as industrialized. Incredibly, Africa's share of global manufacturing fell from about 3% in 1970 to less than 2% in 2013.

About 60% of the world's arable land is in Africa. A net food exporter until the 1970s, the continent has become a net importer. Structural adjustment reform conditionalities - requiring trade liberalization - have cut tariff revenue, besides undermining import-substituting manufacturing and food security.

Sub-Saharan Africa accounts for 24% of the world's hungry. Africa is the only continent where the number of undernourished people has increased over the past four decades. About 27.4% of Africa's population was 'severely food insecure' in 2016.

In 2020, 281.6 million Africans

more than in 2000! Another 46 million became hungry during the pandemic. Now, Ukraine sanctions on wheat and fertilizer exports most threaten Africa's food security, in both the short and medium-term.

Structural adjustment Many of Africa's recent predicaments stem from structural adjustment programs (SAPs) much of Africa and Latin America have been subjected to from the 1980s. The Washington-based international financial institutions, the African Development Bank and all donors support the SAPs.

SAP advocates promised foreign direct investment and export growth would follow, ensuring growth and prosperity. Now, many admit neoliberalism was oversold, ensuring the 1980s and 1990s were 'lost decades', worsened by denial of its painfully obvious consequences.

Instead, **'extraordinarily** disadvantageous geography', 'high ethnic diversity', the 'natural resource curse', 'bad governance', corrupt 'rent-seeking' and armed conflicts have been blamed. Meanwhile, however, colonial and neo-colonial abuse, exploitation and resource plunder have been

denied. While World Bank SAPs were officially abandoned in the late 1990s following growing criticism, replacements - such as Poverty Reduction Strategy Papers - have been like "old wine in new bottles". 'home-Although purportedly grown', they typically purvey bespoke versions of SAPs.

With trade liberalization and greater specialization, many African countries are now more dependent were undernourished, 82 million on fewer export commodities.

With more growth spurts during booms, commodity African economies have become even more vulnerable to external shocks.

Can the West be trusted?

Earlier, G7 countries reneged on their 2005 Gleneagles pledge - to give \$25 billion more yearly to Africa to 'Make Poverty History' - within the five years they gave themselves. Since then, developed countries have delivered far less than the \$100 billion of climate finance annually they had promised developing nations in 2009.

The Hamburg G20's 2017 'Compact with Africa' (CwA) promised to combat poverty and climate change effects. In fact, CwA has been used to promote the business interests of donor countries, particularly Germany.

Primarily managed by the World Bank and the International Monetary Fund, CwA has actually failed to deliver significant foreign investment, instead confusion among participating countries.

**Powerful** Organization **Economic** Cooperation **Development** governments successfully blocked developing countries' efforts at the 2015 Addis Ababa UN conference on financing for development for inclusive UNled international tax cooperation and to stem illicit financial outflows.

Africa lost \$1.2-1.4 trillion in illicit financial flows between 1980 and 2009 - about four times its external debt in 2013. This greatly surpasses total official development assistance received over the same period.

Africa must unite

Under Nelson leadership, Africa had led the fight for the 'public health exception' to international intellectual property law. Although Africa suffers most from 'vaccine apartheid', Western lobbyists blocked developing countries' temporary request to affordably meet pandemic needs.

African solidarity is to withstand pressures powerful foreign governments and transnational corporations. African nations must also cooperate to build state capabilities to counter the neoliberal 'good governance' agenda.

Africa needs much more policy space and state capabilities, not liberalization and economic privatization. This is necessary to unlock critical development bottlenecks and overcome skill and technical limitations.

# Nigeria's fragile security architecture is collapsing

burnt out bus is seen outside the Kuje maximum prison following a rebel attack in Kuje, Nigeria, Wednesday, July 6, 2022. At least 600 inmates escaped in a jailbreak in Nigeria's capital city blaming the attack on Islamic extremist rebels. About 300 have been recaptured.

Earlier this month, attacks that took place within minutes of each other in different parts of Nigeria, and the apparent failure of the security forces to respond to them efficiently and in a timely manner, exposed how big of a threat lawlessness and impunity currently poses to the country and its people.

Late on July 5, heavily armed men on motorcycles raided the Kuje Medium Security Custodial Centre on the outskirts of Abuja and released more than inmates, including more than 60 Boko Haram members in detention. The Islamic State West Africa Province (ISWAP) - an offshoot of Boko Haram now allied with the ISIL (ISIS) group - claimed responsibility for the attack.

Just hours before the Kuje incident, another group of heavily armed men had attacked a convoy carrying an advance security team for President Muhammadu Buhari in his home state of Katsina. A presidential spokesperson said the convoy carrying a team of security guards, as well as protocol and media



officers, was on its way to Daura, Buhari's hometown, to prepare for a visit by him when the attack took place. According to the presidency, two people in the convoy sustained minor injuries before the gunmen were repelled. On the very same day, bandits on motorcycles had also ambushed and gunned down Assistant Commissioner of Police Aminu Umar Dayi in another part of Katsina, not far from where the president's convoy was attacked.

Nigerian security forces failed to respond effectively to all three attacks, proving yet again that they don't have the capacity to properly defend themselves, let alone members of the public, against armed

While some of the inmates who escaped from the Kuje Custodial Centre were recaptured hours or at least days after the

attack, many are still on the loose - and those who managed to slip from the grasp of the security forces appear to include some of the most battle-hardened Boko Haram fighters and bomb experts.

The authorities' response to the attack on President Buhari's convoy and the ambush of Assistant Commissioner Dayi and his team in Katsina was equally incompetent. Those who attacked the presidential convoy, like those who killed the assistant commissioner, were not captured but simply "repelled" meaning they got away with what they did and are still free to stage further deadly attacks. According to reports, the very same bandits who attacked Buhari's convoy have already raided a nearby village

All this exposes the current state of

groups raid prisons, attack presidential convoys and brutally murder security officers with ease and impunity.

Indeed, the raiding the Kuje prison was only the latest instalment in the escalating attacks on prisons across the country. In 2021 alone, more than 5,000 inmates escaped thanks to such incidents. And "bandits" the catchall phrase for criminal masterminding frequent bouts of abduction, maiming, sexual violence and killings of citizens have been staging bloody attacks on rural communities without much meaningful push back from security forces for at least a decade in northern parts of the country.

For ISWAP, the attack on the Kuje prison was a spectacular success, not only because it helped free several prominent members of the group, but also because it demonstrated that the group is now confident enough to stage a major assault on a supposedly highly protected prison in the capital city. Much of the group's successes before this year were restricted to the North East, but in recent months, it has moved beyond its traditional influence zone in Borno, left imprints on Taraba, and driven westwards, gaining footholds in Niger, Kogi and even the Federal Capital Territory (FCT). After the Kuje jailbreak, it staged several other attacks on communities around Abuja. Now, there is no debating that even the most important and dearly guarded state institutions in Nigeria's capital city are facing a very real threat from ISWAP.

The attacks on Buhari's convoy and the deputy commissioner in Katsina state, meanwhile, clearly showed that Nigeria's security forces are no longer able to protect themselves - let alone civilians - against bandits in certain areas of the country.

Upon independence, Nigeria inherited a deeply faulty security architecture from the British that was geared towards protecting only the political and economic elites in urban centres and leaving the rest of the population to practically fend for themselves.

Consecutive governments, especially during the military dictatorship between 1966 to 1999, failed to reform this faulty infrastructure which led to the security situation getting worse and worse in the peripheries. In recent years, the country's economic downturn forced the security forces to further narrow the scope of their operations and put all the resources While the July 5 attacks represented they have towards protecting the security architecture.

many ways, they also marked a grim resulted in even the members of security forces themselves becoming overly vulnerable to attacks by "bandits" and armed groups, and perhaps most importantly, large swaths of Nigerians, especially in urban centres, starting to lose any trust they had in their country's security forces.

The apparent collapse of Nigeria's fragile and faulty security architecture may have immediate, and deadly, consequences for the public beyond the emboldening of bandits and armed groups. Namely, the security forces can turn on innocent civilians to protect their dignity and try to regain some respect.

Even before the failures experienced on July 5, we have witnessed some examples of this dangerous behaviour. In late Iune, for example, the soldiers who were sent to Yakurr in Cross River State to restore peace after a communal dispute reportedly turned their guns on the civilian population after one of their colleagues was killed in action. Local media reported that the soldiers shot at anything that moved, killed at least 10 people, and burned down several houses. Several other similar incidents have been reported in recent

After their failures on July 5, Nigeria's security forces are likely feeling more incompetent and under threat than ever before. This could easily lead to many more tragedies where underfunded, underprepared and frustrated members of security forces turn their weapons on those they should be protecting, and collectively punish communities in order to regain respect, power and control.

If Nigeria is to ensure the safety of all its citizens, and effectively counter the threat posed by bandits and armed groups, the government should stop downplaying the failures of the security forces, and focus its efforts on repairing - and perhaps completely reshaping - the country's faulty

# Ruling a major win for media freedom

extraordinary importance for Among other defences, freedom of expression and media freedom in Namibia, that country's highest court has confirmed the development of the common law to give greater protection to the Namibian media so that, as the court put it, its 'important democratic role of providing information to the public is not imperilled by the risk of defamation claims'. Carmel Rickard takes a closer look.

This new judgment illustrates how Namibia's highest court is determined to protect media freedom, given its constitutional importance in that country. But behind the theoretical questions lie disputed facts concerning the fate of three elephants, and a defamation case against the Namibian Sun, arising out of this dispute.

In the High Court, the media company was ordered to pay a total of N\$120 000 in damages after that court imposed an extremely high standard on the journalist who wrote the disputed story. Would the Supreme Court agree that this virtually impossible standard applied, or would it find that a more reasonable standard was required of a journalist?

The original story opened with focus on an urgent court application said to have been filed by Namibia's Environment Ministry, aimed at forcing a game-capturing company to return three elephants illegally transported to

The story also said that the elephants were being kept 'in what the Ministry describes as horrific conditions'.

Johan Lombaard, who had possession of the elephants at the time, was a co-owner of Golden Game CC, and Lombaard and Golden Game were the two applicants in the High Court action, suing for defamation against the media company.

In response to the defamation claim, the newspaper said the statements complained about by Lombaard and his company had been made at a public press conference by the Minister of Environment & Tourism, and by the

new judgment of Ministry's permanent secretary.

newspaper claimed truth and public interest, fair comment and reasonable publication. Senior journalist for the media company, Ellanie Smit, who wrote the disputed article, said she had attended a press conference addressed by the Minister and another ministerial official. They were asked about the plight of the elephants, and their answers were accurately reflected in the subsequent article she had written.

She said after the press conference, but before publication, she made two attempts to reach Lombaard by phone but that his phone was off on both

Lombaard stressed that Smit had not contacted him before publication, and that the published report contained 'untrue and incorrect matter concerning him and Golden Game'. At no stage had the Ministry sought an interdict against him and his company. Further, he denied that the elephants were illegally transported or that they were kept in horrific or deplorable conditions.

The High Court found the article was indeed defamatory in that it attributed illegal activities to Lombaard and his company, and the fact that the story referred to the animals as being kept in horrific conditions was also

It found that the information presented at the press conference was not accurate and that Smit 'did nothing' to investigate the truthfulness of the allegations made at the press

The treatment of elephants was indeed a matter of public interest, the High Court found, but the media company did not establish the defences of truth and public interest, nor fair comment.

In its judgment, the appeal court has now found that reporting on allegations of ill treatment of elephants, made by the political and executive heads of the Ministry constitutionally mandated to enforce provisions of law aimed at the prevention of ill treatment of this protected species, was 'inherently a



matter in the public interest.'

The media company argued that the reporting of factual statements made at an official public press conference 'was reasonable' on its part and it was reasonable to accept the correctness of the factual matter disclosed by these officials as they were 'reliable sources'.

Lombaard's legal team took issue with the failure of Smit to 'test the accuracy of the statements' made at the press conference.

Two calls to Lombaard, made in quick succession before publication, were 'hopelessly inadequate' as an opportunity to respond to the allegations made against him and his company. And there had been 'no effort at all made to test the accuracy of the information given at the press conference.

It was 'insufficient' that Smit regarded

the courses as credible and reliable. According to Lombaard's counsel, Smit 'could and should have travelled to Lombaard's farm near Mariental to see the conditions for herself."

But was this really necessary to establish the defence of 'reasonable publication in the public interest'? Trustco v Shikongo, a groundbreaking Supreme Court decision on defamation, had made it clear that defamation defences previously available under the common law were 'inadequate to protect the right to freedom of expression and the media protected under ... the Constitution.'

The court in Trustco had found that the common law therefore needed to be developed, as had happened in other jurisdictions, 'to provide greater protection to the media to role of providing information to the public is not imperilled by the risk of defamation claims.'

In Trustco, the court said the development of a defence of reasonable or responsible publication of facts that are in the public interest, would provide 'greater protection to the right of freedom of speech and the media protected (in the Constitution) without placing the constitutional precept of human dignity at risk.'

The Supreme Court trawled recent trends in international jurisprudence to satisfy itself about the increasing acceptability of this defence.

In order to establish the defence of reasonable or responsible reporting, said the court, a journalist would need to satisfy herself that her belief in the truthfulness of the allegations is the assure that their important democratic result of a reasonable investigation and

must be a reasonable belief to hold. The list of guidelines in the Trustco

decision was not to be applied rigidly, but rather to provide helpful guidance to courts. Further, the Trustco judges found courts 'should not hold journalists to a standard of perfection.' Account must be taken of the pressure under which journalists work and 'not expect more than is reasonable of them.'

But courts should also not be too willing to forgive manifest breaches of good journalist practice.

Applying these principles to the appeal before it, the Supreme Court found that reporting on allegations of ill treatment of elephants was a matter  $of \, compelling \, public \, interest.$ 

At no stage did Lombaard take issue with the accuracy of Smit's report on the statements attributed to the Minister and other officials. In the view of the court, it was 'unequivocally true' that the appellants had established Smit's conduct in publishing the report to be the actions of a 'reasonable or responsible journalist'.

The Ministry had an investigative, enforcement and supervisory role in relation to granting wildlife permits and ensuring compliance with them. Smit was 'plainly entitled' to accept the accuracy of what both officials said at the press conference without independently verifying the correctness of what they said. There was 'no indication of a casual, slipshod or careless approach' by Smit or her editor. 'The indications are quite to the

What about approaching Lombaard before publishing? The fundamental question was whether the journalist acted reasonably in publishing, the Supreme Court said. And her accurate reporting on the statements of the Minister and officials at the press conference clearly satisfied the test of a responsible journalist.

In conclusion, the Supreme Court held that Smit's defence should have succeeded in the High Court, and the court should have dismissed the defamation action with costs.

# Empowering youths through digital literacy and skills vital

ith the strike dragging into five months, many students have been left stranded at home without vocational skills and at the risk of negative influences with disastrous consequences.

With many courses in Nigerian universities becoming less marketable in the work world and students lacking employable skills when seeking opportunities, the acquisition of digital skills is the right direction for the achievement of digital inclusion. For personal growth and access to job opportunities across the local and international tech ecosystems, students need to migrate to online study platforms and pursue their educational aspirations.

Recently, the Minister of Communication and Digital Economy, Mallam Isa Pantami announced that the Federal Government has signed partnership agreements with tech giants, Huawei and Cisco to establish 300 academies in Nigeria and to train 30,000 citizens in advanced Information Communication Technology (ICT).

In actualizing NDEPS for Digital Nigeria 2020-2030, which was unveiled by President Muhammadu Buhari on November 28, 2019, the conference has enabled the capturing of the agenda of developing digital skills and literacy and enhancing the digital society, as crucial to enabling emerging technologies.

# Somali President urging public to help millions hit by drought

#### **MOGADISHU**

Somali President Hassan Sheikh Mohamud has called on the Somali public to join the government's effort to help millions of people in the country affected by the drought. The U.N. says 7.7 million Somalis have been affected by the drought.

Speaking at a mosque in the country's capital, Mogadishu, Somali President Hassan Sheikh Mohamud called on citizens to join his government's efforts to help Somalis devastated by the worst drought in more than 40 years in the Horn of Africa nation.

Mohamud said those affected the most by the drought are the elderly and children, who are experiencing severe malnutrition.

He says the drought and its circumstances have worsened, and it now has reached a state of famine and death. The livestock are already gone, there was much hunger, he said, but the government has been doing whatever it can to help people, and the world is helping. He emphasized that

Mohamud was elected in May by the country's parliament for a second time, and he announced shortly after taking office that his government's priority was to battle the current prolonged drought that has devastated 90 percent of the country.

He also appointed a special envoy for drought response to facilitate the humanitarian activities in the country.

According to the United Nations office for Humanitarian Affairs (OCHA), 7.7 million Somalis have been affected by the drought, and nearly a million people have been displaced. Droughtrelated malnutrition has killed more than 500 children since January of this

The U.N. Migration Agency (IOM) in Somalia told VOA on Saturday the people displaced from the drought are living under extreme conditions.

Claudia Rosel is the IOM media and communications officer, and she said the numbers of those displaced by

the Somali people and those abroad drought have been steadily increasing

"Those who are newly displaced due to drought are on top of 2.5 million people who were already internally displaced in Somalia due to natural hazards and conflicts over the years," said Rosel. "And now what we are preoccupied with is that in just one year, we are seeing almost 1 million people nearly displaced due to drought conditions and most of them - they won't be able to go back to their communities of origin because they have lost everything."

The Somali prime minister's office said the drought has affected more than 15 million livestock -- 28 percent of Somalia's total livestock population -- while killing more than 2 million other animals.

Somalia's southern Jubaland state minister of planning, Abdirahman Abdi Ahmed, told VOA Somali service that 200 children have died because of drought-related illnesses during the past three months.

# Mangroves key in protecting natural habitat of nations' fisheries resources'

ry year is the International Day for the Conservation of the Mangrove Ecosystem. Tanzania and East Africa is no exception as it has lost large part of the tree species due to human activities especially in coastal areas. Mangroves' cagy tangled roots provide a rich habitat for many organisms such as fishes and crustaceans. Our Correspondent GERALD KITABU interviewed Wetland International Chief Executive Officer, Jane Madgwick, on the state of mangroves and wetlands in general, after her recent visit to the Rufiji Delta: Excerpts:

QUESTION: This is your first time to the mangroves in Rufiji Delta in Tanzania. How was your experience?

**ANSWER:** Rufiji Delta is very impressive in size and diversity of the ecosystems; and many of the mangroves look like they are in good condition. Also, people have

a greater dependency on the Delta and there is a conversation between the communities and government, local authorities on how to resolve it, and Wetlands International is part of that conversation.

Q: To what extent are the mangroves and other wetlands relevant to the achievement of SDGs in developing countries and East Africa in particular?

A: The mangroves have a key role to play both for nature and biodiversity (SDG 14 &15). In terms of SDGs, they are the best natural buffer, protecting cities, settlement and land so that the SDGs can be achieved. They prevent coastline erosion, mitigate the effects of tides and reduce atmospheric carbon, storms, and prevent sea level rise. There are many reasons to take care of mangroves

Q: Do wetlands have a role in managing or reducing effects of pandemics?

A: Ingeneral, pandemics are increasing as we fragment the natural environment. And the key part of

that are wetlands and we have lost more than twothirds of wetlands worldwide. Wetlands are vital for good human health. With pandemics, it's more complex. Wetlands are part of the natural system which is being lost and that contributes to more pandemics. In terms of recovery from pandemics, wetlands can play a vital role in bringing back human health.

**Q:** Wetlands are being degraded and lost due to rising human population and encroachment and other factors. What can governments do to conserve wetlands in these circumstances?

A: What governments need to do is to value the remaining wetlands. They should be treasured. But in many countries, and I think also in Tanzania, there is no good knowledge on those wetlands. If they are not valued, it's easy to lose them due to agriculture or infrastructural development. Therefore, bringing the values into decision making is a critical first step.

Wetlands are responsible for storing carbon. They store much more carbon than any other ecosystem. They capture, purify and deliver water. Water is either too scarce or too much in context of climate change. Bringing wetlands back can help ensure there's enough water for everyone. That's the SDG 6, where there is a target for wetlands restoration. So, unless we put wetlands back in good condition, we will not have enough water for people or control the impact of floods. Population rise is just a factor. But bad decisions on land and water management and fragmented policies for different sectors have much more impact.

**Q:** What is the status of wetlands in Europe and other developed countries?

A: It is very bad. We lost around 80 per cent and now the governments and companies are paying the price because they need wetlands to support their economies. It is very expensive to restore. There is a lot of interest in restoration. To lower temperatures, prevent fires; reduce the impact of heat waves. If you look at the developed world, Africa can learn a lesson that it's better to conserve wetlands than destroy then pay for

restoration.

**Q:** What best practices African governments and communities adapt to safeguard and restore wetlands?

A: Bringing together governments, local institutions, international organizations and other stakeholders to share knowledge on conservation and restoration. Sharing knowledge and experiences really helps to bring change.

Q: East Africa region has transboundary wetlands. Which framework is/are best suited to safeguard and restore these wetlands?

A: The answer is not really frameworks but dialogue. Dialogue is important between countries to share knowledge, have an understanding that they have a shared resource and how to manage it together for the future. That resource is valuable for both or several countries: so if one country depletes it, the others suffer.

O: Climate change is a concern for many. Rains are failing at a high frequency and when sometimes they come. they cause floods. What can local leaders do to galvanise and support their communities to fight climate change effects?

A: First of all, they need to understand what actually climate change is and what is caused by other

factors in the landscape. If this knowledge can get to the local level and people understand the causes, then they can use that knowledge to demand for change. Dialogue is powerful and there is also need for collaboration at different scales and across sec-

Q: In water scarce regions, there are multiple players government, communitybased organisations, civil society, private sector - involved in water resources management and WASH. How can these efforts be harnessed well to avoid duplication and wastage of resources?

A: We have to come together at a landscape or basin level and share knowledge and work out joint solutions for resilience. Water cuts across all sectors and probably the most important one to bring to the table is agriculture. Therefore, collaborative efforts and solutions are needed.

Q: Finally, should the status of a wetland in Tanzania or Kenya, for instance, worry a resident in the UK and vice versa?

A: Of course, it's one planet; it's all connected. Due to globalization, it is important that the efforts of conservation must be collaborative. If one part is affected, obviously another part of the planet will be affected.

# US pledges \$116 million for food and nutrition assistance

he United States will disburse US\$116 million for food and nutritional assistance to over 800,000 people displaced due to the terrorist attacks in the northern province of Cabo Delgado. With this amount, the total humanitarian assistance provided by the US to Mozambique this year amounts to more than US\$167 million.

Zeya added that there are external destabilising factors, such as the Russian conflict with Ukraine, which has caused widespread disruption and significantly increased the price of food and fuel in the world. More than 40 million people around the world are believed to be at risk of food insecurity due to the conflict. That is why, according to Zeva, the United States intends to provide more than five billion dollars in additional aid this year, including more than US\$760 million specifically for global food security. Most of the new funding will go to African nations, including Mozambique.

Meanwhile, President Filipe Nyusi has recognised that the Single Wage Table (TSU), introduced this month in public administration, does not constitute a anti-retroviral treatment in the last two solution to the rising cost of living.

The president was speaking in Maputo, on 20 July, to members and supporters of the ruling Frelimo Party, at a ceremony held to celebrate Mozambique's election as a nonpermanent member of the United Nations Security Council.

The government has decided to postpone until August the payment of most of the new wages in accordance with the Single Wage Table due to some discrepancies in the calculations made for allocation of the new wages.

On 19 July, the Minister of Economy and Finance, Max Tonela, explained that about 21,000 State employees will receive the minimum monthly wage, of 8,756 meticais (US\$137, at the current exchange rate) in July. This is a rise of over 87 per cent compared with the previous minimum. However, everyone paid above the minimum wage will have to wait until August to receive their new salaries.

President Nyusi confirmed that serious inconsistencies discovered in the TSU have forced the government to suspend paying most of the new wages. But the President thought that such difficulties are normal in a complex process. He noted that the TSU could not be regarded as a finished product and inevitably more corrections and adjustments would have to be made. The important point, he stressed, was that the government had decided to reduce imbalances and improve wage conditions in the public administration. "Don't panic because things are being corrected", he urged. "It's like someone carving a sculpture - he improves it whenever he notices some defect".

President Nyusi assured state employees that they will all be paid. Those who, for whatever reason, have not yet been included in the TSU, will receive their old wages, and increases under the TSU will be backdated.

President Nyusi blamed part of the current inflation on the Russian conflict with Ukraine, which had triggered increases in fuel and grain prices. The conflict "has enormous influence on the country's economy, but Mozambicans should not lose focus. It is urgent to accelerate domestic production as a way to reduce dependence on foreign donations", the President urged.

"I would like us to work harder so that we can reduce imports. By reducing imports, we will have a greater capacity to solve our problems", he added.

Half a million HIV-positive people

abandon anti-retroviral treatment About 500,000 people living with HIV in Mozambique have abandoned years, which is an estimated 25 per cent of all HIV-positive people in the country.

The data was made available at an event in Maputo on 19 and comes from a survey conducted by the National AIDS Council (CNCS) and its partners, entitled "Why did you stop?" This research covered 39 districts in Cabo Delgado, Nampula, Sofala, Inhambane, and Maputo provinces.

The document notes external factors that contribute to treatment being abandoned, such as work, side effects of the anti-retroviral drugs, and disapproval by partners. Other factors include socio-economic issues, discrimination, and stigma.

The CNCS Planning Unit Coordinator, Ema Chuva, explained that there is work being done in the communities with partners in order to rescue people who had given up on treatment and bring them back to the health units. "It is being successful. But clearly, we realise that it is not enough just to do the work, we need to be able to solve the reasons that made them stop", she added.

For her part, the researcher and head of the study, Marion dos Santos, highlighted recommendations from the research. "We had as recommendations to broadly discuss the concept of masculinity, and to improve the socioeconomic situation of women so that they don't become more dependent on their husbands", she said. Another recommendation is to look at people's mental and emotional health because it is one of the factors that contribute to low self-esteem and depression in infected people.

Marion dos Santos also pointed out the continuous work within the communities to increase knowledge through the dissemination of clear information about the importance of treatment for HIV-positive people.

Mozambique currently has an estimated 2.1 million people living with HIV, a majority of them women, including about 130,000 children under the age of 15.

Terrorists killed and captured in

Islamist terrorists on 26 July suffered a heavy defeat during a failed attack on the town of Nangade in the northern province of Cabo Delgado. According to reports in the news sheet "Mediafax", all of the attackers were killed or captured by the Mozambican defence forces and their allies from SAMIM (SADC Mission in Mozambique).

The report stated that the terrorists attacked Chitunda, an outlying neighbourhood of Nangade town at nine in the morning. This was the first time Nangade had come under attack, and the first time any district capital had been attacked since troops from SAMIM and Rwanda entered the conflict.

murdered three people while many others fled into the bush. They went on to burn down about 20 houses and loot property. According to the "Mediafax" sources,

The jihadists entered Chitunda and

there were seven people in the terrorist group, only three of whom were armed. The unit of the Mozambican defence and security forces stationed in the town, supported by SAMIM troops from Lesotho, reacted quickly, killing two of

the raiders and capturing the other five. Earlier in the day, the group had been spotted in fields in the area of Nakaindili, about three kilometres from the town. Here one of the terrorists was captured and told the authorities that the other seven were on their way to the town.

"Mediafax" also reported that the Tanzanian contingent of SAMIM has, in recent days, captured 95 youths on their way to terrorist bases. Most of them were captured, not inside Mozambique, but in Mahea village in the southern Tanzanian province of Mtwara.

Some of the youths had taken refuge in the Mahea mosque. Three children who had been out catching birds spotted the movements of the would-be terrorist recruits near the border and tipped off the authorities.

Dozens of terrorists killed at Catupa

Operational Theatre of the Mozambican Armed Forces (FADM), Omar Saranga, has told reporters that dozens of islamist terrorists were killed in the operation that led to the seizure of the major jihadist base of Catupa, in Macomia district, in the northern province of Cabo Delgado.

Catupa was captured in mid-July and was regarded as the most important strategic stronghold of the terrorists, following the fall of their Siri 1 and Siri 2 bases last year. It was located in dense bush and accommodated rebels fleeing from the offensive in which the FADM and its Rwandan allies drove the jihadists out of the town of Mocimboa da Praia in August 2021.

"Our forces killed dozens of terrorists and seized military and computer material", said Saranga. He presented a Mozambican who had been a bodyguard for one of the terrorist leaders, but who had surrendered.

The capture of the Catupa base was initially announced by President Filipe Nyusi on 14 July, who revealed that during the operation one of the jihadist leaders was killed.

President Nyusi invites Italy to invest in northern Mozambique

President Filipe Nyusi has expressed interest in seeing Italy support the Programme for Resilience and Integrated Development of the Northern Region (PREDIN) which aims to promote the recovery of basic conditions for sustainable economic and social development of northern Mozambique, following the islamist terrorism that has been plaguing parts of Cabo Delgado province.

President Nyusi was speaking on 5 July in Maputo, during the state banquet offered in honour of his Italian counterpart, Sergio Mattarella, who was on a state visit to Mozambique. The President explained that, through the programme, the government intends to accelerate the inclusive and sustainable socio-economic development of the northern region of the country, reduce poverty and vulnerability, and discourage young people from being

lured into terrorist groups. "The implementation of PREDIN requires financial resources and we are sure that Italy, always a friend of Mozambique, will play a crucial role", the President said. Experience, said President Nyusi, shows that terrorism cannot be fought only with military operations. Therefore, the government approved PREDIN.

efforts combined the Mozambique Defence and Security Forces and their Rwandan

The commander of the Northern counterparts, as well as the Southern African Development Community Military Mission (SAMIM) and the military training actions coordinated by the European Union, have dictated the recovery of some areas and the destruction of bases previously occupied by terrorists.

PREDIN includes actions aimed at increasing the military capacity of the defence forces, support to countries that commit their forces on the ground, as well as providing humanitarian assistance to more than 850 thousand internally displaced people, and the rehabilitation of infrastructure

"We would like to express our deep appreciation to Italy, which has joined the European Union military training mission, placing itself once again at the side of Mozambique to combat a complex and transnational phenomenon: terrorism and violent extremism", said President Nyusi.

For his part, President Mattarella stressed that there is no indifference when the dignity of people is violated, adding that "Mozambique has always had an intelligent and active partnership on all issues in bilateral relations with Italy, including the fight against poverty and climate change."

In Cabo Delgado, the Italian energy company, Eni, is heading the consortium that owns the Coral Sul floating platform in the Rovuma Basin Area 4 deep-water block, where huge deposits of natural gas have been discovered.

EU approves €89 million for fight against terrorism

The European Union (EU) has approved an €89 million (US\$89.4 million) package for the fight against terrorism that has been plaguing parts of Cabo Delgado, since October 2017. This sum will be invested in the training of the Defence and Security Forces, to make them more operational and selfsufficient, as well as in the purchase of non-lethal protective equipment.

The aid was announced on 13 July by the outgoing Ambassador of the European Union, Antonio Sanchez-Benedito Gaspar, following an audience granted to him by President Filipe

The ambassador, who is closing his four-year term of office in Mozambique, said that "with regard to equipment, the European Union has already approved a package of €89 million for training and purchase of non-lethal equipment for 11 Marine command units that are being trained, including uniforms, vests, helmets, communication systems, drones, vehicles, a field hospital, and other individual protection materials".

# If Britain is serious about ending trafficking, we must learn from Mo Farah

he UK government's response Olympic champion's case is welcome. but we must learn how to treat those with no public platform with as much understanding

Last week, Olympic and world champion British runner Mo Farah revealed that he was trafficked to the UK as a child. His courageous decision to share his experiences has led to widespread support from media and the public - and from the Home Office (UK interior ministry), who described him as "truly inspirational".

However, if the UK government is serious about ending trafficking, it must do more than praise Farah as an individual. As a country, we need to learn from his case and take action. The government's ongoing review of its modern slavery strategy and upcoming Modern Slavery Bill present great opportunities to do so: here are the four key les-



sons we need to implement.

1. We need a trauma-informed system which doesn't penalize survivors for late disclosure.

As Farah's case shows, it can take a long time for survivors to

We need to see a system which acknowledges that delays are not evidence of deception or inaccuracy. We also need trauma-informed processes for disclosure, making it easier for people to share their experiences.

2. We need to create a culture of support, not

Trafficking victims in the UK are at risk of criminalization, even if the crime they committed was as a result of being trafficked and therefore outside of their control. For example, Farah's case involved an immigration offence. Other trafficking victims in the UK are forced to take part in criminal activities such as growing cannabis.

Traffickers know how to manipulate victims' fear of being penalized for these offences. They use it to make sure that victims don't seek help from authorities, warning them that if they report what has happened, they could be deported or otherwise punished. This means trafficking cases slip under the radar as victims and survivors are afraid to come forward.

We need to create a safe environment for victims and survivors - one in which their immigration status is secure and they know they will be treated with dignity and respect if they disclose.

3. We need a humane and dignified approach to immigration - to take power out of the hands of traffickers.


Like Farah, many vulnerable people in the world today are made susceptible to trafficking, often by situations outside of their control - like conflict. He was living in war-torn Somalia, where conflict had recently claimed his father's life. This conflict made him vulnerable to trafficking.

We're seeing similar vulnerabilities right now with refugees who have fled Ukraine and other conflict zones. Many women and children who have escaped Ukraine are running low on resources, making them more vulnerable to false offers of work and accommodation from traffickers. We need to ensure there are safe, legal and accessible immigration routes that prevent people being targeted by traffickers.

4. We need to listen to survivors - not only those with public platforms.

It is right that Farah's courage is acknowledged and celebrated - he's made a powerful impact by sharing his story and putting a spotlight on this issue. It is now time for the UK government to pay similar attention to the experiences of trafficking survivors who are not public figures. Without understanding the reality of survivors' experiences, it will not be possible to create a modern slavery strategy which effectively addresses the problem of trafficking. The UK government now has an opportunity to listen to survivors and create strong solutions.

International Justice Mission has supported survivors of trafficking who were exploited in the UK, and we have seen firsthand the need for robust, trauma-informed support which protects survivors' rights. We know that stopping trafficking is possible - but it can only happen if, as a country, we are prepared to acknowledge the reality of how trafficking happens, and develop robust, humane solutions which protect the rights of vic-While the Home Office tims and survivors.

# **BoA boosts capacity of small and medium businesses in Mwanza**

# Foreign investors records 1.2bn/monthly net outflow at DSE in July



The report shows local investors are continuing to dominate the market as out of 5.3bn/- total turnover recorded in July, they bought 82.82 percent of the value of shares sold and sold 58.36 percent of the value of selling side.

Low income developing economies are expected to record strong real GDP growth of 5 percent this year and 5.2 percent next year.

# Tanzania, Uganda record lowest power losses in EA

THE Energy Regulatory Association of East Africa (EREA) has said Tanzania and Uganda are among the top performers in the region in terms of reducing energy losses.

The details are contained in the EREA report -An Insight to the Region's Energy Industry - for the period between July and Sept, which indicates that Uganda has the second lowest power leakages in the

Tanzania, whose power losses stand at 15.16 percent, tops the list, followed by Uganda, Zanzibar, Rwanda, Burundi, and Kenya in that order.

Power losses in Zanzibar, according to the report stand at 19 per cent while in Rwanda they stand at 19.6 percent. Burundi and Kenya have the highest power leakages standing at 20 percent and 24.1 percent, respectively.

Reductions in distribution losses are a testament to power utilities' efficiencies in ensuring most of

the units that distributors buy from transmission companies reach consumers and are billed suffi-

Energy regulatory authorities factor power losses in the end user tariffs, thus holding the Electricity Supply Industries' investments costs constant.

The lower the losses the more units are available, which translates into lower per unit costs or tariffs.

Ms Diana Naisuna Nambi, the Electricity Regulatory Authority (ERA) manager public relations and consumer affairs, said the reduction in energy losses has been achieved through setting stringent energy loss targets, among other performance parameters, which enables ERA to monitor performance of the industry on energy losses as well as finding remedies for areas with high losses.

One such measure, she said, has been the use of technology, through deploying a pre-paid metering system for the end-user consumers.

"Since some of the energy losses are increasingly

being caused by acts of vandalism of electricity infrastructure, ERA is working together with other stakeholders, including the police to bring the vice to an end," she said.

However, President Museveni has previously castigated players in the energy sector for their failure to bring down energy losses.

Government also recently introduced heavy penalties for any person found of guilty of vandalising electricity equipment.

The EREA report comes after the Renewable Energy Solutions for Africa, a Rome, Italy-based foundation that works to support Africa's goal to achieve Sustainable Development Goal number seven - increase access to clean energy - in February said countries where private participation is possible, existing private operators are outperforming public utilities on reducing distribution losses, lower debt-

to-equity, greater net cash flows and bill collection indicators.

Under the amended terms, the agreement is for the full nameplate capacity of the Lindi Jumbo Mine.

Wogen will distribute the product into the global market, drawing on its substantial expertise and resources in speciality commodi-

Existing offtake agreements with other customers will be renegotiated to reflect this new arrangement. The existing customers are supportive of this approach.

Lindi Jumbo will draw on the considerable market knowledge and relationships Wogen partnering with Walkabout Resources and Lindi Jumbo in 2019.

It is anticipated that Lindi Jumbo's sales book will be more diversified and have greater exposure to shorter-term pricing than previously as a result of the new arrangement.

The average realised pricing of graphite concentrate will be more influenced by short-term market movements while still having some longer duration.

## China agrees on landmark debt relief deal for Zambia

Zambia's official creditors led by China have agreed to provide debt relief to the southern African nation, paving the way for an IMF bailout and setting a precedent for how Beijing could work with other lenders to tackle the threat of a wave of defaults across emerging mar-

A committee of creditors cochaired by China and France said on Saturday that they were "committed to negotiate with the Republic of Zambia terms of a restructuring" under a G20 framework to co-ordinate debt relief. Kristalina Georgieva, the IMF's managing director, said that she was "very pleased to welcome" the commitment by the creditors, which will unlock a \$1.3bn IMF loan to revive Zambia's finances. Zambia still has to negotiate exact terms of the relief and reach a similar deal with private creditors.

"The support from the official creditor committee for Zambia's envisaged IMF-supported programme, together with its commitment to negotiate debt restructuring terms, accordingly, provides the IMF with official financing assurances," Georgieva added.

China is prepared to co-ordinate with other official creditors on restructuring the debts of low-income countries, rather than deal with defaults on its own loans behind closed doors. Zambia has become a test case for countries that also turned to Beijing for financing in recent years, such Sri Lanka, which has already defaulted, and Pakistan.

Zambia became the first African country to default during the pandemic in 2020 when it halted payments on \$17bn of external debt, including \$3bn in US dollar-denominated eurobonds, after years of rising debt distress.

China has emerged as the country's biggest creditor in the last decade, offering an estimated \$6bn of loans as Zambia embarked on ambitious infrastructure projects such as roads, dams, and airports. These soured as the economy slowed.

President Hakainde Hichilema's government agreed terms for a three-year IMF bailout last year within months of coming to power in a landslide poll victory over Edgar Lungu, who presided over the worsening debt crisis.

The deal is an early sign that ment had to wait for assurances from official creditors before it could begin the IMF programme and thrash out terms of a debt restructuring in detail with both private and official creditors.

> "We are confident that together with our partners, Zambia will address the issue appropriately and with the urgency needed to help get the economy back on a sustainable growth trajectory," Situmbeko Musokotwane, the Zambian finance minister, said.

> The Zambian finance ministry on Friday detailed plans to cancel a further \$2bn in yet to be disbursed loans tied to projects - mostly affecting Chinese creditors.

Private creditors such as bondholders will be expected to grant Zambia debt relief that is at least as large as what will be offered by official lenders, under the so-called comparability of treatment principle.

On Saturday the official creditor committee urged other lenders to "commit without delay to negotiate with Zambia such debt treatments that are crucial to ensure the full effectiveness of the debt treatment for Zambia under the common framework.

#### Barrick highlights sustainability milestones, future targets \$26-million on community deised on creating economic

GLOBAL miner Barrick Gold Corporation has given itself a "B" scorecard rating on sustainability performance for 2021, which is measured against a range of metrics and the best practice of its peers.

Chief Executive Officer (CEO) Mark Bristow (pictured) last Friday presented the company's yearly sustainability update presentation to investors, reiterating the company's commitment to reducing emissions by at least 30pct by 2030 - with 2018 as a baseline - and to reach net zero by 2050.

# More oil discoveries boost Guyana's offshore boom

THE former British colony of Guyana, a nation whose economy was hit hard by the pandemic, has emerged as the world's hottest offshore drilling location.

Since 2015 global energy major ExxonMobil as well as its partners Hess Corporation and CNOOC have made a slew of quality oil discoveries in the offshore Stabroek Block which have delivered resources in excess of 11 billion barrels of oil.

This is driving a massive economic boom for Guyana, which was among the poorest nations in Lain America and the Caribbean.

According to the IMF, the micro-state's gross domestic product grew by just under 20 pct during 2021 and is poised for further strong expansion.

The substantial surge in oil prices which sees the international Brent benchmark up by 58 pct over the last year to be trading for \$110 per barrel coupled with the push by big oil to decarbonize its operations are adding considerable momentum to the boom.

Guyana's government is expected to bank over \$1 billion in oil revenues during 2022 which according to industry consultancy Rystad Energy will soar to \$7.5 billion by the end of the decade.

That will deliver a tremendous eco-

economy grow fivefold over that period.

Key to this tremendous economic opportunity is the rapid ramping up of **Irlnidad and Tobago** crude oil production, with Exxon estimating that its operations will have the capacity to pump 1.2 million barrels per day by 2027, which are further oil discoveries.


Exxon and its partners in the 6.6-million-acre Stabroek Block have made over 25 quality discoveries with the crude found being light and sweet with an API of 32 degrees and 0.58 pct sulfur content.

The latest discoveries were at the Seabob and Kiru-Kiru wells in the Stabroek Block to the southeast of the Payara Project. Exxon also announced that production from the Liza oilfield in the Stabroek Block has exceeded the 340,000 barrels per day initially targeted.

Earlier this month it was revealed that Exxon had lodged an application with Guvana's Environmental Protection Agency to drill 35 exploration and appraisal wells in the Stabroek Block.

When the energy supermajor's exploration success in the block is considered along with the five discoveries made in the Stabroek Block earlier this year, the drilling campaign will make additional discoveries boosting the 11 billion barrels already discovered.

per barrel Brent for Liza Phase 1, \$25 a barrel for Liza Phase 2, which recently came online, and \$32 per barrel for the 220,000-barrel capacity Payara Project, which is scheduled to start production

While it is the Exxon-led consortium that is key to driving Guyana's epic oil boom, which will see the Caribbean country become a leading oil producer, other international energy companies are also engaged in exploration drilling.

British driller Tullow Oil, which is the operator of the world-class Jubilee field in offshore Guyana discovered in 2007, announced 37.5 pct partner Repsol, with TotalEnergies holding the remaining 25pct, had spud the Beebei-Potaro well in the Kanuku Block.

That wildcat well, which comes on the back of the 2020 Carapa medium oil discovery in the block where 13 feet of net oil pay was identified, is targeting a prospect that Repsol estimates contain around 200 million barrels of crude oil.

The Kanuku Block lies below the southeastern tip of the Stabroek Block, where Exxon has made nearly all discoveries in offshore Guyana and is believed to lie on the same petroleum fairway.

### Bitcoin, Etherem on track for their best month since 2021

#### **NEW YORK**

BITCOIN and Ether, the world's two largest digital tokens, are headed toward their best month since 2021 amid a revival of risk appetite in global markets and optimism about an Ethereum network upgrade.

Bitcoin is up 28% in July and Ether 70%, though their rallies paused Friday. Both were little changed, with Bitcoin at about \$23,950 as of 5 p.m. in New York and Ether hovering around \$1,730.

Growing signs of a US economic slowdown are leading some investors to the view that the Federal Reserve will be done raising rates by year-end and blowups, such as crypto might even pivot to cutting hedge-fund Three Arrows borrowing costs in 2023.

That in turn would create a more favorable backdrop for speculative assets such as crypto, which has taken a drubbing this year.

"The week has continued a very welcome up trend," Adrian Kenny, senior sales trader at GlobalBlock, wrote in a note. "The crypto, and wider markets in general, have seen somewhat of a relief rally in the last few days."

"I don't think I can continue doing trips with the same rhythm as before," he said in answers to reporters' questions aboard the plane returning to Rome from a week-long trip in Canada.

For the past few months Francis, 85, has been using a wheelchair, a cane or a walker because of knee pain caused by a fracture and inflamed

#### **Biden tests positive for Covid**

US President Joe Biden tested positive for Covid Saturday, and returns back to quarantine, Biden's doctor Kevin O'Connor said in a written statement, adding that



the US leader feels well and experiences no symptoms.

"After testing negative on Tuesday evening, Wednesday morning, Thursday morning and Friday morning, the President tested positive late Saturday morning, by antigen testing," the doctor said, adding that Biden "has experienced no reemergence of symptoms and continues to feel quite well."

However, due to the positive antigen test, "Biden will reinitiate strict isolation procedures.'

O'Connor noted that the President was taking Paxlovid medicine, known for return of symptoms in some patients after negative test results, or, as in Biden's case, positive tests results.

According to the doctor, there "is no reason to reinitiate treatment at this time," but the specialists will continue observing the President's condition. Agencies



Under years of efforts made by scientific researchers, 30,188 corals have been planted on the seabed around Wuzhizhou island, which covers around 50,000 square meters. The undersea "afforestation" efforts are leading to constant improvement of the marine ecosystem. Coral planting has even been made into a scuba diving program for tourists

visiting the island since this year. Since 2013, Sanya has implemented 19 projects to restore marine ecology, including the restoration of coral reefs and shoals, as well as shoreface nourishment. The city has restored 7.7 kilometers of

coastline and a sea area of 51,584 square

Coral planting is a harder form of "afforestation." On one hand, the complicated marine environment creates huge challenges for planting activities, such as the fierce flow of sea water in the South China Sea caused by typhoons between July and October each year; on the other hand, sections of the seabed are differently affected by the environment and human disturbance, and their health levels also vary, so it calls for scientific researchers to make individualized plans.

The underwater "afforestation" relies on technological progress. There are large areas of coral reefs under the sea waters around Hainan province, which makes the province a major planter of corals.

Coral reef restoration technologies have been constantly improved during the coral planting practice in the province.

For instance, the Hainan South China Sea Institute of Tropical Ocean has improved the efficiency of coral planting by applying a stainless steel seedbed; Hainan University has made new breakthroughs in the restoration of fractured coral reefs by combining artificial fish reefs and coral reef restoration.

New methods and technologies are driving new progress in China's underwater "afforestation" and contributing Chinese wisdom to the global protection of the marine ecosystem.

Artificial methods are just a supplement to the restoration, while the reduction of human disturbance remains the

In recent years, China has enhanced its efforts to promote natural restoration of coral reefs, and coral reef protection has been included in a series of laws of the country Besides, China has joined the Conven-

tion on Biological Diversity, the Convention on International Trade in Endangered Species of Wild Fauna and Flora, as well as other international treaties.

The country has established five stateand province-level nature reserves and a special national ocean park involving coral reefs.

So far, nearly 30 percent of the offshore waters and 37 percent of the continental coastline of China have been incorporated into its ecological red lines, which is making the ocean more and more beautiful.

AFRICAN countries and the Shanghai Cooperation Organization (SCO) states understand that any member of the international community can fall under Washington's sanctions, Russian Foreign Minister Sergey Lavrov told reporters on Friday after the SCO Foreign Ministers Council meeting.

"Of course, the African countries and other SCO states are well aware that any member of the global community, if they act in any way that the Americans do not like or dislike, can fall under their sanctions. Already, I think, this idea is quite firmly fixed in everyone's mind," the top diplomat said.

Lavrov noted that during the meeting the parties agreed to make a proposal to the SCO leaders to take concrete actions on the transition to mutual settlements in national cur-

"I think everyone will be thinking about it now. Africa already has this experience. There are common currencies in some sub-regional structures, but they are all pegged to Western currencies by and large. But from next year, they will have a fully functioning continental free trade zone.

# China urges building balanced global, regional security architecture

**UNITED NATIONS** 

CHINA'S deputy permanent representative to the United Nations, Geng Shuang, on Friday called on the international community to build a balanced global and regional security architecture, while saying China will protect its own sovereigntv at all costs.

"All countries should uphold a common, comprehensive, cooperative, and sustainable security concept, attach importance to each other's legitimate security concerns, build a balanced, effective, and sustainable global and regional security architecture, and jointly safeguard world peace," the ambassador told the Security Council briefing on

Geng underscored that "only by attaching importance to the security of others and safeguarding the security of everyone, can our own security be truly realized."

"Putting one's own security above that of others, attempting to strengthen military blocs, establishing absolute superiority, and even shaping the surrounding environment of other countries according to their own standards will only lead to conflict and confrontation, divide the international community, and make themselves less secure," he added.

Talking about the challenges facing the world, the envoy said that "in an era of changes and challenges, no country can deal with them alone, and no country is insulated."

He said that at a time when the international community is in dire need of unity and cooperation to overcome the difficulties together, it is extremely irresponsible and dangerous to cling to the Cold War mentality and bloc politics, to promote decoupling, to erect barriers, to politicize, instrumentalize and weaponize economic and trade exchanges to coerce other countries to take sides, and to deliberately create division and confrontation.

"The international community should be highly alert to this counter

current and resist it together," he said. "We must not let the crisis of Ukraine kick off a new Cold War. We must not repeat the mistakes of history. We must not let humanity experience once again the unbearable scourge of war."

Referring to the importance of upholding the UN Charter, Geng said that "as the legal cornerstone of today's international order, the UN Charter is irreplaceable in its role and unshakable in its status.

Compliance with the purposes and principles of the UN Charter should be consistent, with words matching with deeds, instead of saying one thing while doing another, not to mention double standards or selective applica-

On China's position and will to safeguard its own sovereignty, the envoy said that "while some countries have repeatedly emphasized the principle of sovereignty over the issue of Ukraine, it has incessantly challenged the sovereignty of China over Taiwan and even deliberately created tensions in the Taiwan Strait."

"This is a disregard and an infringement of the purposes and principles of the UN Charter. China has always respected the sovereignty of other countries and certainly hopes that its own sovereignty be respected by other countries," he said.

"China is resolute and firm as a rock in its will to safe-

guard national sovereignty. No one should underestimate the determination and ability of more than 1.4 billion Chinese people to defend its national sovereignty and territorial integrity. I hope the country concerned will see this clearly and not play with fire," he stressed. On the two agreements on shipping grain out of Ukraine and the export of Russian food and fertilizers, Geng said China welcomes the deals.

In the meantime, he said China commends UN Secretary-General Antonio Guterres and all parties concerned for the positive role they played. Geng stressed that since the outbreak of the Ukraine crisis in February, "China has been taking an objective and impartial approach, and proceeding from the historical perspective and the merit of the issue itself."

"China has been standing on the side of peace and on the side of humanitarian efforts, calling for a ceasefire to stop fighting, facilitating a cool-off, actively promoting peace talks, and providing humanitarian assistance," he added.

"We made our efforts in a responsible way to mitigate the spillover effect of the crisis, and will continue to play an active, constructive role in stabilizing international trade and world economic order," the envoy noted.

# Efforts made to ensure better livelihood for relocated residents in Guizhou province

GUIZHOU, a province located in southwest China, is surrounded by mountain ranges and stony deserts. It was once deeply troubled by poverty due to the poor geographical condition.

About 92.5 percent of the area in the province is covered by mountains and hills, and 73 percent is made up of karst landscape. Guizhou is the only province in China without a plain.

At the end of 2015, Guizhou kicked off a large relocation program for poverty alleviation. At that time, the province was home to 9,000 impoverished villages and 4.93 million impoverished residents. It used to be a provincial-level region with the largest population of poor people in China.

In the following five years, 1.92 million impoverished people in the province moved into modern residential complexes from the mountains, and thus ushered in a new chapter of life.

"I had to walk more than an hour to go to school in town in the past, and now it takes only around 10 minutes. At school, we have bright classrooms and fun activities, and we like them very much," said Li Tongtong, a student at a primary school in Qianxi, Guizhou.

In 2018, Li moved from Jinlan village in Qianxi to the city's largest poverty-alleviation resettlement site with her family. The relocation not only offers Li's family a big and safe apartment, but also enables Li to go to a school in the community that was built with the pairing assistance from Huadu district, Guangzhou, south China's Guangdong province.

Education has always been a major concern of relocated residents. Guizhou, taking educa-

tion for the children of school age as a priority, has equipped all poverty-alleviation relocation sites with education facilities. It has put an end to the history when children had to cross mountains and rivers to go to school by providing them with fairer and better educational resources.

The province has invested over 18 billion yuan (\$2.66 billion) to build or reconstruct 669 schools. More than 30,000 teachers are currently assigned at the schools at povertyalleviation resettlement sites, which ensures nearby enrollment for all children from relocated families.

In the Yucai community, the largest poverty-alleviation resettlement site in Songtao county, Guizhou's Tongren, there is a special factory, which is run by a toy manufacturer in the economic development zone of Songtao county and only hires local middle-aged

and senior residents aged over 50. So far, 38 people have secured a stable job at the fac-

"I stitch around 500 toys a day, which earns me 40 yuan," said Zhang Guiying, a 52-year-old worker in the factory.

At large- and medium-sized resettlement sites, Guizhou province has built workshops, launched labor transfer activities, and developed featured industries as a way to support employment and entrepreneurship, optimize industrial structure and enhance skill training. Based on the sizes and locations of the resettlement sites, as well as the age distribution and labor skills of the relocated residents, the province tailored different development and employment plans.

As of the end of this June, nearly 930,000 people from 414,500 households had been employed, which means that at least one

family member with working capabilities has a job.

To ensure that relocated residents enjoy basic public and health services, Guizhou has built and expanded 411 standard medical institutions and newly equipped 759 medical institutions with facilities and medical workers. Public health services have covered all of the province's 949 resettlement sites during the 13th Five-Year Plan period (2016-2020), ensuring that all relocated residents have

access to healthcare. People's Daily

#### **Rocket debris fall back to Earth**

DEBRIS of the recently launched Long March 5B carrier rocket of China fell back to the Earth and ended up in the Pacific Ocean early Sunday morning, with most of the remnants burnt up during the reentry process, the China Manned Space Agency said.

The debris' atmospheric reentry and crash took place around 12:55 am (Beijing time), the agency said in a brief statement, noting the touchdown site is in waters located at 9.1°N and 119.0°E. It did not provide additional details.

Based on the coordinates given by the agency, the site is in the Sulu Sea, close to Palawan Island.

The final return put an end to Western media's speculations on the possibil-

ity of debris crashing over an inhabited area in what they called "an uncontrolled reentry" of the Long March 5B. Zhao Lijian, a spokesman for the Foreign Ministry, said on Wednesday that

China had been closely tracking the movement of the used rocket in orbit and continued to publish its information online. He noted the Long March 5B rocket model has designs and devices that neutralize their debris and impact on Earth and most of its components would be

with the country's Tiangong space station. A Long March 5B is 53.7 meters long, with a core-stage diameter of 5 meters. The rocket is propelled by liquid oxygen, liquid hydrogen and kerosene and

has a liftoff weight of about 849 tons. The rocket model is the most powerful Chinese launch vehicle when it comes to carrying capacity to the low-Earth orbit. It is essential to China's space station program because it is now the only Chinese launch vehicle capable of

carrying large space station parts to orbit.



The debris' atmospheric reentry and crash took place around 12:55 am (Beijing time), the agency said in a brief statement, noting the touchdown site is in waters located at 9.1°N and 119.0°E. It did not provide additional details

According to TFF Information Officer Clifford Ndimbo, the lack of sponsorship for the Women's League had been one of the main challenges facing the development of women's soccer in the country.

Ndimbo stated: "In Tanzania, women's soccer has been limping for a long time due to lack of sponsorship. Since its inception, the Mainland Women's Premier League has lacked financial support to function smoothly like its men's counterpart."

# Nunez upstages Haaland, Alvarez in Liverpool's Community Shield win, but Manchester City's new stars will shake off loss

ERLING Haaland will have better days in a Manchester City shirt, you can be certain of that, but his first taste of English football saw him resoundingly upstaged by Liverpool's Darwin Nunez and City teammate Julian Alvarez as the FA Cup holders claimed a 3-1 Community Shield victory over last season's Premier League champions at the King Power Stadium.

Few players in world football create quite as much noise as Haaland, the 22-year-old forward who moved to City from Borussia Dortmund in a €60 million transfer earlier this summer. The Norway international had his pick of every major club in Europe before agreeing to move to the Etihad and few expect him to do anything but score a truckload of goals on the way to winning trophies galore with Pep Guardiola's team.

But Haaland had a debut to forget against Liverpool. Not only did he fail to score, he barely touched the ball, missed an easy chance in stoppage time when hitting the crossbar from six yards and saw Nunez -- Liverpool's €75 million signing from Benfica -- leave him firmly in the shade with a dazzling substitute performance which delivered a goal, an assist and an exciting showcase of the qualities he will bring to Jurgen Klopp's team this

And then there was Alvarez, the 22-year-old signed from River Plate for €16 million, who gave an eye-catching City debut by scoring the equaliser, cancelling out Trent Alexander-Arnold's first-half opener, after replacing Riyad Mahrez early in the second-half. While

Nunez simply looks a more rounded player, but it doesn't mean he will score more goals and Guardiola insisted that Haaland will deliver in the months ahead.

"He didn't score," Guardiola said. "Another day he will score. He has an incredible quality on that and he will do it.

"He fought a lot, made the movements. It's good for him to see the reality of new country, new league, but he was there. He is going to help us a lot -- he had the

chances, he was there."

Opponents that aren't as accomplished are likely to be blown away by Haaland if he is given the space to hurt them, but ultimately, he has been signed to make the difference in the tight games, against the likes of Liverpool and in the Champions League, so he has still to show he can make that vital step up. It is difficult to envisage Haaland failing to take his game to that level, but he and City have work to do to make it come together.

Liverpool appear to have less to do to make Nunez fill the gap created by Sadio Mane's summer move to Bayern Munich. His header, from Mohamed Salah's cross on 80 minutes, led to the Ruben Dias handball which, after a VAR review, resulted in a penalty from which Salah made it 2-1 to Liverpool. And Nunez than scored his goal with a diving header, four minutes into stoppage time, after Andy Robertson had teed him up in the six yard box.

"We all know they are a special species, strikers," Klopp said. "They all need goals and goal involvements. "He [Nunez] would have been fine without his goal because he created the penalty with his header and had a chance when the goalkeeper reacted brilliantly. "His goal was the icing on the cake, brilliant for him and it's a really good sign after the time he has been with us."

So in the battle of the new signings, Nunez won his first encounter with Haaland and helped Liverpool to their first Community Shield success since 2006. But this is a game that means little in the long term. How Nunez and Haaland do in the Premier League and Champions League is what will truly define the suc-

# Lewandowski talks to ESPN about life at Barca, Bayern legacy and stopping Madrid

ROBERT Lewandowski conquered years in Germany at Bayern Munich, open and ready to help me. but now he's ready for a new challenge. The 33-year-old striker joined Spanish giants Barcelona for around €45 million this summer and is ready to help the Catalan side get back to the top of the European game.

Lewandowski was officially presented as a Barcelona player in Miami, played his first minutes for his new club in preseason matches on U.S. soil and is preparing for a big welcome at Camp Nou on Friday, ahead of the first game of the LaLiga season against Rayo Vallecano on Aug. 13.

The Poland international carries a fearsome goal-scoring reputation and has 509 goals in 676 club matches, has twice won the Golden Boot for Europe's leading goal scorer and finished as runner-up for the 2021 Ballon d'Or, while he beat Bayern legend Gerd Muller's 49-year record of most goals scored in a Bundesliga season, tallying 43 in 34 matches in 2020-21.

However, his exit from Bayern (for whom he scored 344 goals in 375 appearances) came under a cloud as he publicly clashed with the club over his desire to move on. Still leaving with a legendary status, Lewandowski admits his departure was one surrounded by politics and wants to remind Bayern fans of the love he had for the club for so many years. But now he tells ESPN's Cristina Alexander, speaking exclusively in his first interview since moving to Barcelona, that he is ready for the next chapter in his career.

ESPN: How have you felt at Barcelona these first few days? Lewandowski: Well, I have to say

that I'm very happy to be here, to be a part of Barcelona... It has been 10 or 12 days, out here in the U.S., so everything has been extremely fast and quick, but, with my experience, it is a little bit easier to adapt to the team, and every day I try to adapt and be a part of the team. ESPN: How has Xavi helped you

**Lewandowski:** Yeah, he helped me a lot. The conversation between me a problem with communication. And

Even now it was very difficult to decide to go to Barcelona because I know what I did, the comfort zone I had in Bayern Munich already, but for me, I was always open to some-

I heard that Barcelona wanted to sign me, and that was a sign that maybe now is the perfect timing to go to Barcelona, go to LaLiga. I know that I can still play for a few years on the top high level and that's why I decided to go to Barcelona. I'm very happy to be part of this team.

ESPN: What do you expect up front with so many signings that we've seen this summer coming to **Barcelona?** 

**Lewandowski:** We have a very strong team and are ready to think about titles. I'm always the guy who is thinking about winning the game, of course scoring the goals, and with the coach, Xavi, we can do this because I see what we're doing during the training session and how we work hard now in preseason. So for me all the signings mean that we are in a good way and I'm very excited for the start of the season.

**ESPN:** You were talking about the goal scoring and what you want to do as well for Barcelona, and I mentioned that record, with Gerd Muller in the Bundesliga. and him is really good. We don't have **How is Robert Lewandowski going** to take that goal scoring and bring

it to LaLiga, bring it to Barcelona? **Lewandowski:** We have played so

many times in the Champions League against Spanish teams, so it's not that new for me... In international football, if you are on the top, you have to be ready for every challenge, that doesn't matter who you are playing against or how tough it will be. You have to show your best, and I'm experienced, I'm ready for this and I need this challenge to show how my game looks in LaLiga. Also there are more games in LaLiga [38] compared to Bundesliga [34], so maybe I will have even more chances to score goals.

**ESPN:** What do you expect from the rivalry not only with Real Madrid but personally between yourself and Karim Benzema?

**Lewandowski:** Benzema is an amazing player, he showed that in the last Champions League season; what he did during the games against PSG, Chelsea or Man City. He's already, I don't know how many years, 10 or even 12 years in LaLiga. He knows this league a lot. Even in the Champions League, he showed that he's one of the best players, and I think that is very nice to see so many good strikers in LaLiga. For sure that will be more interesting for the fans.

For me, I didn't want to compare with him because for me it will be something new, and I accept this, but for him he's already here [in LaLiga] many years and he has shown already in the last year how good he is. For me, more important will be what we're going to do with the team. How are we

going to play? How can we go from win to win? This is my goal.

ESPN: We know that this is a team that has changed dramatically even in the last year, of course with the loss of Lionel Messi. How does that bring you into the picture leadership-wise? Does this give you an opportunity to be the new leader in the team?

**Lewandowski:** Of course, this is a big opportunity to be the person who can lead on the pitch with body language, to show the guys it doesn't matter how many goals we have already scored, we can score even more. To always think positively, always play forward, to try to do something more to push and work even harder than before.

I see already in Barcelona that there

are players who are thinking about how ing to do with Erling. I am the guy who be here to show my performance. Also I know that my teammates are ready to follow, not only follow me but follow the way we're going to be at the end of

ESPN: How do you take that title from Real Madrid then in LaLiga?

**Lewandowski:** We try to do our best, for sure. We haven't started the season yet, but maybe after one or two months -- because the run here before World Cup [in November] is very short -- maybe after this time we can talk more about the expectations for the end of the season. But for sure, Real Madrid are still going to be very strong; they're going to play very well, and that is a huge challenge for us. We have to be ready and we have to be there if we

want to compete with Real Madrid. ESPN: Robert, I want to go back to what you mentioned, for Bayern Munich, and those last few months. So there was a little bit of, you know, political things going on before, before you left. Reports in Germany suggested that maybe you were a little bit uncomfortable with the fact that Bayern were looking to sign Erling Haaland; did that have anything to do with leaving, did that influence your decision?



#### Poulsen hails midfielder's impact in Taifa Stars victory over Somalia

TANZANIA's senior national football side 'Taifa Stars' head coach Kim Poulsen has hailed the impact of Abdulhamis Suleiman as the Tanzanian midfielder catapulted the squad to a 2-1 win over Somalia on Saturday.

Tanzania saw off Somalia 2-1 in the second leg of the first round of 2023 Africa Nations Championship (CHAN) qualifiers played in the afternoon at the Benjamin Mkapa Stadium in Dar es Salaam.

Taifa Stars advanced to the next round of the African Nations Championship qualifiers with a 3-1 aggregate win.

Suleiman gave Taifa Stars the lead after 34 minutes before Somalia's Farhaan Mohamed made it 1-1 after 48 minutes.

Central defender Dickson Job netted Tanzania's second goal from the penalty spot in the 64th minute.

Suleiman's goal was the difference in the first leg tie which was also played at Benjamin Mkapa Stadium due to Somalia's lack of an approved stadium that meets international standards as required by the Confederation of African Football.

Speaking to the press after the game, coach Poulsen did not shy away from singling out Suleiman's performance in the two games.

The Danish coach stated: "We started a bit nervously, after we scored the nice goal from Abdu Hamis Suleiman I saw some more

Poulsen said: "I think we were in

good control of the game and compared to the last game we did not give any chances away which is important.'

The coach revealed: "On the second the way it started, that's what happens in football sometimes. A deflected shot went into the goal and suddenly Somalia got on fire and maybe got a little bit too much on fire along the game."

Poulsen disclosed: "I still think we tried to control it, we got a clear penalty and scored 2-1. It has been a good experience for our players to have these two games. It is nice to see a player like Abdulhamis Suleiman who had a huge impact in both

The tactician said: "He is growing and growing, and that's what the CHAN is about. It is about our home-based players showing their potential. Over the two matches, he was the man of this round. We are onto the next round and we are all happy."

Tanzania will now face Uganda's Cranes in the second round this month. Cote d'Ivoire will host the CHAN 2022 tournament to be played in January 2023.

At just 21 years old, the prospect of Suleiman becoming a star for both club and country are very real after his recent switch from Coastal Union to Azam FC.

He ended his two-season spell at Coastal Union on a high, helping the club to its first Azam Sports Federation Cup final in over a decade by scoring nine goals including a perfect hat-trick against the winner, Yanga.

# CAF reschedules Tanzania's back-to-back AFCON qualifiers ties against Uganda

TANZANIA's senior national football side 'Taifa Stars' September back-to-back clash with Uganda in the 2023 AF-

CON qualifiers campaign has been rescheduled to next year after the Confederation of African Football Executive Committee approved a revised qualification calendar.

Cup of Nations qualifiers Department press. in September has been postponed to allow the continent's five World Cupbound teams the opportunity for better friendly matches before the tournament takes place in Qatar, the Confederation of African Football said on Sunday.

The postponement had been muted for weeks after CAF confirmed the postponement of the Africa Cup of Nations finals scheduled for the Ivory Coast from June 2023 to January 2024 due to the weather conditions in the West African country.

"This was necessitated by the Executive Committee's commitment to making room for the African nations that have qualified for the 2022 FIFA World Cup Qatar in November/ December 2022 to prepare adequately," reads a part of fifth round to June 12-20

Senegal's head coach Aliou Cisse was among the more vocal critics of the fixtures, which meant his country would have had to play two Africa Cup of Nations qualifiers, home and away against Mozambique, in the final window of opportunity in September when they wanted to play against opposition from other continents ahead of

the World Cup. Cameroon, Ghana, Morocco, and Tunisia are the other African teams who will be playing at the World Cup finals in Oatar.

The 2023 AFCON qualifiers, which started with two rounds of matches in June, still have four rounds remaining.

CAF said match day three and match day four qualifiers have been moved to March 20-28 next year, the

will be played on September 4-12 2023.

Tanzania is sitting third in Group F of 2023 AFCON qualifiers, which will culminate in the finals that will be hosted by Ivory Coast, with just a single point from two games following a 1-1 away draw with Niger and a 2-0 home defeat to Algeria.

Strong favourite, Algeria, is at the top of the table with six points having beaten both East African teams, Niger is sitting second with two points and Uganda is languishing at the bottom with one point.

Tanzania must use the remaining four games, a back-to-back encounter with Uganda in March, a clash against Niger in Dar es Salaam in June, and a trip to Algeria in September to secure second place and qualify for the AFCON finals for the third time.
