

## TCRA disables 17, 300 fraudsters' phone lines

Such incidents and actions taken dropped from 20,939 blacklisted simcards during October to December 2023 to 17,318 deactivated lines

total of 17,318 simcards have been deactivated due to being used in multiple dubious acts as well as online criminal activities over the last three months.

Dr Jabir Bakari, the Tanzania Communications Regulatory Authority (TCRA) director general, made this affirmation at a city press conference to present a sector performance report, noting that the rate of fraudulent incidents on the phone are on steady decrease.

Such incidents and actions taken dropped from 20.939 blacklisted simcards during October to December 2023 to 17,318 deactivated lines during the January to March 2024 period, a 15 per cent decrease.

Regions that were more affected by phone scams during March were Rukwa and Morogoro, with two thirds of the fraudulent acts registered during the month, he said, elaborating that with regions like Mbeya, Dar es Salaam and Tabora the range of suspected criminal acts using phone lines stood at one per cent to ten per

# VP counsels engineers on project delays, corruption

VICE President Dr Philip Mpango has challenged African consulting engineers to craft solutions to the untimely completion of projects and corruption which are derailing efforts to attain African Union's agenda 2063.

Speaking at the Africa infrastructure conference convened by the International Federation of Consulting Engineer (FIDIC) marking its 30th anniversary in Dar es Salaam yesterday, the VP

Key problems include untimely completion of projects, exorbitant pricing due to corruption in mega projects and inadequate technical capacity of local engineers, he said, highlighting other as key to achieving sustainable challenges as late or non-compliance with tax obligations.

AGRO sector exports from Tanzania to France reached an average of \$25.122m annually for the past five years, a senior official has stated

Exaud Kigahe, the Industry and Trade deputy minister, made this observation in Dar es Salaam yesterday at the second French Tanzania business forum, focused on strengthening existing economic ties.

Trade policy at the moment is geared to creating a conducive environment for business and investment in Tanzania, where current initiatives pave the way for increased trade and investment for mutual The data shows that trade flows have

been in favour of France during the half decade (2019-2023), with Tanzanian exports to France standing at an average of \$ 25.1m per year, while imports averaged at \$75.4m per year, he stated.

On our part, major exports to France include coal, tobacco, cotton, locust beans, sea products (frozen fish, fish fillets, shrimps, prawns, octopus), dried leguminous vegetables, coffee, plus fresh or dried vegetables, he elaborated.

Major imports from France include grape wine, petroleum products, dishwashing machines, electrical machines, medicaments, prefabricated building parts, helicopter spare parts, sugar, aircraft engine, and animal feed processing machinery, he stated.

The forum is directed at uplifting President Samia Suluhu Hassan's assurance as to Tanzania's efforts in addressing challenges facing investors, opening up new avenues that will make current and prosperous investors reap their rewards, he asserted. He urged French companies to participate in the 48th Dar es Salaam International Trade Fair, describing it as the largest trade show in East Africa, attracting more than 500 foreign companies annually to showcase advanced technologies.

He cited machinery for processing leather and leather products as sought after devices, underlining that the forum is tailor-made for diverse engagements of an interactive nature with Tanzania ministers, in particular. "I am confident that participants will have fruitful and in-depth exchanges on issues that are crucial for intense economic engagement," he affirmed.

Nabil Hajlaoui, the French ambassador, emphasized the long-standing friendship between France and Tanzania, noting that the forum exemplifies commitment to deepen bilateral relations.

Locations which reported few fraud attempts were mostly in Zanzibar, chiefly North Pemba and the Zanzibar South Region, he said, insisting that the proper and safe use of simcards is paramount to the sustainable growth of the country and improved living standards of the people.

TCRA has ensured successful monitoring and identified fraudulent phone calls, with appropriate steps being taken, thus touching off a decrease in the number of recorded incidents, he said, affirming that the monitoring prevented sales of stolen, lost or damaged phones or those with deficiency of standards.

Sub-standard or counterfeit phone handsets were deactivated as part of mititions, he added.

### Uganda ramps up mass campaign on yellow fever amid vaccine hesitancy

### **KAMPALA**

UGANDA launched a mass vaccination campaign in April against the mosquito-borne disease, yellow fever. They hoped to reach millions of people but vaccine hesitancy has left hundreds of unused doses in hospitals across the coun-

There is no specific treatment for the potentially deadly yellow fever virus. There is, however, a vaccine which can give lifetime protection against the disease according to the World Health Organisation (WHO).

At a university in the outskirts of the Ugandan capital Kampala, these students turned up for their jabs as part of the government's mass vaccination programme.

This was the campaign's second phase, it was supposed to run between April 2nd and 8th but it was extended by a week because of the low turnout.

Last year in June 2023 the government ran a campaign hoping to target 13 million people.

Together the mass vaccination programmes from 2023 and 2024 were supposed to deliver enough jabs to protect 27 million people.

### Papua New Guinea landslide buries over 2,000 people

A Papua New Guinea government official has reached out to the United Nations, indicating that over 2,000 individuals are believed to have been buried alive in the recent landslide by Friday.

This number starkly contrasts with the U.N's estimate of 670 fatalities from the disaster in the mountainous interior of the South Pacific island nation. So far, only the remains of six people have been recovered.

In a communication addressed

"We would like to appreciate the symbolic actions taken by Spain, Norway and Ireland in recognising the Palestinian State as an attempt to save the two-state solution likewise protecting Israel," the envoy declared.

He was concerned that Israelis have not shown any signs of readiness to come to a conclusion of the current situation, the will to have a dialogue on ending its military campaign. This would give a chance for Palestinians to rebuild their nation, he said, highlighting that Palestine and Israel entered into a peaceful process in the past 30 years hoping that this would lead to the solution of being recognised as a people.

"This is not something that we have just been planning to do. We have been doing it within the United Nations, with the Russian Federation, the European Union, the Arab League, the Islamic Organisation and the African Union,"

The envoy pointed at struggles for the last 100 years where the Palestinians have been fighting against aggression and demanding their state rights. "After 1948 when Israel was created by a resolution of the United Nations, that same resolution called for a resolution on the Palestinian State which did not happen," he explained.

"When you talk of a war you have one army on this side and you have another army on the other side. You have almost equal powers but the Palestinian people do not have an army. We do not have states that support us. If we are to talk of the Vietnam and America war, Vietnam had support from other countries." The Gaza Strip has an unfolding humanitarian crisis on account of nearly seven months since Israel launched a devastating offensive in response to October 7 mass attack in southern Israel. Gaza authorities say that more than 34,600 people have been killed in the Israeli offensive which has laid waste much of the Gaza Strip.

## Dar to hold executive director position in group of governors

TANZANIA is expected to hold the position as alternate executive director in the Group of East African governors in the African Development Bank (AfDB) from August,

Dr Natu El-Maamry Mwamba, the Treasury permanent secretary unveiled this here yesterday during the meeting of the governors of the group for East Africa that are members of the AfDB in preparation for the 2024 meetings of the Board of Governors (Ministers of Finance from member countries) that kicked off yesterday in Nairobi, Kenya. The meetings are themed: "Africa's Transformation, African 

Development Bank Group, and Reform of the Global Financial Architecture."

Dr Mwamba explained that the AfDB has established a system of rotation of leadership in the countries of the East African region, which is the executive director and the advisor. "In this meeting we have also discussed the cycle of leaders who are the executive director and advisor and we in Tanzania from August, 2024 will hold the position of alternate executive director in the bank who will be taking the position of executive director during emergency or excuse," said Dr Mwamba.

Dr Mwamba said that the meeting discussed the changes in the country's climate that have recently been causing various disasters and

agreed to establish a disaster fund that will help countries that will be affected by these changes including the unexpected El Nino rains.

"We have also discussed climate change and how to increase capital, but also the countries that experienced floods caused by heavy rains that occurred this year will also be on the agenda to be discussed in the General Meeting," added Dr Mwamba.

The meeting of the group of East African Countries which has involved delegates from nine countries namely Tanzania, Kenya, Uganda, Rwanda, Ethiopia, Somalia, South Sudan, Eritrea and Seychelles, is a prelude to the 59th Annual Meeting of the African Development Bank (AfDB) held in Nairobi.

### **UNITED NATIONS**

UN Secretary-General Antonio Guterres has said that there is a need to embed African participation leadership across the global peace and security

architecture. Following World War II, the mechanisms of global governance, including the UN Security Council, were designed by the most powerful countries at that time when many African countries were still in the process of throwing off the shackles of colonialism. Since then, the world has changed. But global institutions have not, he said.

"Today, African countries continue to be denied a seat at the negotiating table, including at this very council. The impacts of these structural inequalities are plain to see," he told an open debate of the Security Council on strengthening Africa's role in

addressing global security and development challeng-

Africa deserves a voice in the global peace and security architecture. But strengthening Africa's voice can only happen if African countries can participate in global governance structures as equals, he said.

"This must include correcting the lack of permanent African representation at the Security Council. And it must include reforming the global financial architecture, especially its handling of debt, so African countries have the support they need to climb the development

## Police seize car loaded with 25 bags of cannabis in Shinyanga

POLICE Force in Shinyanga Region has seized vehicle with registration number T575 CAF loaded with 25 bags of cannabis and the driver escape from the police.

Shinyanga Regional Police Commander Janeth Magomi said this yesterday when addressing journalists emphasizing that the force continues to search for the car's driver as well its owner in order to answer the suspicions of transporting the drugs.

She said that through a special operation conducted from April 17 to May 27 this year, the force also seized expired human medicines that were being sold in a pharmacy in Shinyanga Municipality.

Regarding the car with drugs, RPC Magomi said they arrested

the cannabis in a car that hit a bull in Bugweto area in the municipality and when the police arrived at the scene for further inspection, they found 25 pieces of cannabis in the car, with the driver fleeing to unknown destination.

She mentioned other seized products as including one television, one scale, one radio, 16 motorcycles and 20 liters of illegal alcohol.

Regarding the Traffic Division of the Tanzania Police Force, Magomi said they caught 6,320 offenses on the motorcycle side while 4,847 on cars, tricycles and 1,473 motorbikes where the perpetrators were held accountable and paid instant fines.

Magomi appealed to the residents in the region to continue to cooperate with the Police Force by providing information on criminals for a safe Tanzania.

## Prof Janabi: Massive investment at MNH reduces deaths by 40pct

THE Muhimbili National Hospital (MNH) has said that due to robust investment done at the emergency department including modern equipment and specialists, patient deaths have decreased by over 40 percent.

Prof. Mohamed Janabi, MNH executive director unveiled this yesterday in Dar es Salaam during the celebration to mark the World Emergency Medicine Day held at the hospital.

He said that patients who die at the emergency department is less than 0.5 percent thus having 99 percent assurance of patient survival as patients receive needed services on time.

Prof. Janabi said the hospital serves 150 to 200 emergency patients per day.

"Every day, we touch the lives of mothers, fathers, children and this is our priority, serving people and restoring smiles to families and the nation," he said.

Prof. Janabi said that the emergency department is crucial as it handles patients with various health challenges, especially accident victims who lose a lot of blood, however, through the emergency department, the lives of the victims have been saved due to the efficiency of skilled nurses and the availability of sufficient modern medical equipment.

He stated that in the past, many patients in this department used to lose their lives, but since the establishment of emergency medicine, although all on-duty doctors gathered in the emergency department, there was no training in emergency medi-

He mentioned that in the emergency medicine departments of all Muhimbili hospitals, there are 63 adult beds and 19 children's beds.

He said that the city of Dar es Salaam is growing rapidly, with the population increasing to six million, and many tall buildings have been constructed. However, there are challenges with rescue equipment when a disaster

"We take the size and population growth of this city very seriously. Our goal is to collaborate with others, such as the fire department, to prepare and have adequate equipment and specialists when a disaster occurs to save lives," said Prof. Janabi.

He added that MNH is also preparing to have proper ambulances equipped with the necessary facilities to help treat patients on the way before they reach the emergency department at the hospital for further treatments.

"We want to have ambulances with essential facilities for the specific illness, not just vehicles without equipment, as we will be able to help the patient on the way or even before reaching the hospital. At MNH, we start with dreams, but we make sure dreams are realized," he said.

Prof. Janabi also called on all MNH staff to always be ready to deal with disasters, especially with the significant increase in various disasters, including natural and man-made disasters worldwide. Prof. Hendry Sawe, executive director of Abbott Fund Tanzania pledged that the foundation will continue working with the government in various areas including building capacity for medical equipment specialists and addressing some of the hitches that will be identified in the future.

He said Abbott Fund has worked with the government since 2001 to strengthen the country's healthcare system. In 2009, after upgrading outpatient care and completing a nationwide hospital lab modernization programme, a partnership commenced introducing medicine in Tanzania.

He added that the Abbott Fund has invested in creating training centres in five regions in the country, including Dodoma, Mwanza, and Mbeya, to ensure the centres provide training and focus on teaching emergency medicine to various health workers to ensure they can offer these training when needed.

The International Emergency Medicine Day is commemorated every year on 27th May where this year's theme is: Climate Change and Health Impact in Emergency Medical Care'.

### 50 young entrepreneurs benefit from UNITAR, BADEA support

FIFTY upcoming young and women entrepreneurs engaged in agri-business activities have undergone training on how to improve their emerging projects.

In addition to the six-month training, they got the opportunity to pitch their projects before a panel of representatives of financial institutions and former beneficiaries of similar programmes.

## Initiatives to boost number of nuclear experts, unveiled

THE government has unveiled strategies to increase the number of nuclear experts in the country.

strategies include launching the guidelines for the rolling out scholarships for students to undertake nuclear science technology studies abroad

Prof Adolf Mkenda, Minister for Education, Science and Technology said this yesterday here when officiating this year's national education, skills, and innovation week.

The launched initiative is part of the Samia Scholarship Programme that is geared towards supporting undergraduate students who achieved high scores in their advanced level national examinations.

Prof. Mkenda said apart from motivating students to undertake science and technology studies, launching of the potential scholarship focuses to plug the existing deficit the government is set to increase the number of nuclear technology experts in the country.

"Nuclear technology stands among sensitive sector to propel socio-economic sector in Tanzania, thus this initiative is for ensuring the country produces enough and skilled experts for the smooth metamorphosis of the sector," he

Prof Mkenda said that the guidelines are in line with

innovation and creativity and are also meant to provide a room for the beneficiaries to get loans towards post graduate diploma in legal practice, diploma in vocational studies, as well as the relevant courses at the high levels of Masters and PhD degrees.

Others are scholarships for first degree in science, technology, engineering, mathematics and health sci-

"The government is very promoting science education, committed to improve science education, innovation skills and creativity as part to attain the much-needed industrial drive, but also to assist students to venture into key self- employed economic projects in order to cheat the increasing wave of unemployment rate," he observed.

Basing on that focus, he said the government has, and will continue to implement a range of useful strategies, including providing needed loans to cater for college fees for the relevant students.

"For instance, the government is currently working to ration, the minister stated that facilitate construction of a record number of vocational colleges across the country in order to expand enrolment of the students in question," he unveiled.

He added, the other ongoing initiatives to help promote the sector include development and implementation of National Digital Education Strategy, National Strategy for Financing Technology, Science and Innovation, among others.

He added, to fuel the aspithe government, through the parent ministry, is working to install a total of 15 campuses to offer competence based programmes in various specialised vocational degrees.

"You have to know that it is an official lending institution, through the website of the Central Bank of Tanzania (BoT), which has listed all the official lending institutions in the country, so you must be satisfied with the registration of the relevant institution before borrowing," said Mihigo.

He said that the government, through the Ministry of Finance, will continue to provide education on financial literacy to the public and various groups to ensure that citizens have a broad understanding of financial issues, including education on contracts, investments, and bad loans.

### 100 people in Ikungi dragged to in court for human trafficking

A TOTAL of 102 residents of in Ikungi District, Singida Region, who are suspected to engage in human trafficking business as well as violence against women and children have been arrested and dragged to

The suspects are the ones alleged to commit the offences between 2021 and 2024.

Neema Mnyokanyoka, Ikungi Primary Court magistrate said due to public awareness and cooperation in the society, a number of culprits who implement violence to women and children have continued to be arrested, something which will help reduce the inhuman acts.

She made the remarks over the weekend here when speaking at a capacity building to 67 community health workers from 18 wards of Singida Municipality.

Mnyokanyoka explained that among the suspects who were brought to court, 95 were linked to allegations of violence against women and children while 14 suspects were accused of human trafficking.

In addition, the magistrate stated that in 2021, a total of 25 people were brought to the court on suspicion of committing violence acts, while in 2022 there were 28 people, in 2023 there were 28 suspects and in 2024, a total of 14 people were brought to the dock on suspicion of illegal trade trafficking people.

Presenting report on the implementation of projects of the Medical Missionary of Mary Community Centre through Faraia Community Based Healthcare Centre in Singida municipality, Severine Laurent, said that in the period of one month, the centre has successfully brought to court between 10 and 15 cases of people accused of human trafficking, where among the cases, 8 to 10 cases won.

Laurent, who is a servant at the Faraja Centre said that more efforts are needed to help eradicate violence as well as human trafficking

According to the servant, the centre has for years been educating the public on the impacts of human trafficking and violence with the majority of victims being youth, women

## NEMC, CGCLA in campaign to curb harmful effects of mercury

THE National Environment Management Council (NEMC) in collaboration with the Chief Government Chemist Laboratory Agency (CGCLA) has embarked on a campaign to educate government officials in Mbeya and Songwe regions about the effects of mercury.

The education on the effects of mercury is provided through a project to control the use of mercury chemicals which is funded by the World Bank (WB) and coordinated by the Office of the Chief Government Chemist.

Speaking during the commencement of the campaign yesterday here, Joyce Njisya,

registration manager of CGCLA laboratory in Dodoma wanted customs and environment officers in the two regions to cooperate closely to control the illegal importation of the chemicals.

She asked them to ensure that they properly manage the legal transportation of mercury and its safe use to avoid the importation of illegal and substandard mercury and to avoid the harmful effects of mercury.

Njisya called on the workers of all places that use mercury to ensure that they use mercury that is registered with (CGCLA) and whoever is caught with mercury contrary to the authorized ownership will be dealt with

"Our country still allows the use of mercury, my advice for companies and individuals involved in the transportation, distribution, and use of mercury chemicals to ensure that they're registered and given permits by the law, if we find that you have violated the law, the fine is up to 200m/- for the company while the fine for an individual it reaches up to 2.5m/-," she said.

Zabibu Nduru, CGCLA senior chemist said mercury is one of the ten sources that most endanger the health of the community due to human activities if it is not properly managed. She said the unsafe use of mercury causes health and environmental effects including damaging the kidneys, liver, and lungs, damaging the nervous system and vital organs of the body.

She said that this condition causes a person to be unable to feel, stiffness of the body, impaired eyesight, inability to work, skin disease, loss of male power, mental stress, skin irritation, and body weakness.

She added that for pregnant mothers it affects the growth of the child due to mercury poisoning and for men it causes infertility, noting that the effects of mercury that occur if a person does not wear protective equipment in the filtering process and when burning the mercury-captured ore to separate it.

He emphasised the importance for miners to use protective equipment when working in order to protect themselves from the effects of mercury.

Tunduma Border customs officer, Menlad Mpangala, thanked NEMC and CGCLA for providing education on the safe use of mercury because that education will help them control the safety of mercury transportation in the Tunduma border.

He urged mercury exporters to stop transporting the product arbitrarily because doing so leads to the sub-standard chemicals entering the country.

He said Tanzanians should stop using the chemical secretly because despite causing the government to lose income it can also cause health hazards.



## Ensure every child gets birth certificate, Chana tells parents

"Birth certificate is an important document and according to the law of our country, any child born in Tanzania has the right to have a certificate," said Dr Chana.

She said that if parents and guardians obtain birth certificates, it will help the government to get statistics for future development plans.

"My land has been invaded by people, I have come here to get advice because a court order was issued for them to leave, but they don't want to leave," said Tweve.

The USAID/Tanzania Heshimu Bahari (Respect the Ocean) Project is a five-year project that aims to improve the ecological resilience and productivity of Tanzania's high marine biodiversity areas. Tanzania's coral reefs are among the world's fifty most climate-resilient reefs based on biological and oceanographic characteristics, and Tanzania's marine and coastal ecosystems support a diverse range of coral reefs, seagrasses, open-ocean pelagic habitats, and mangroves. ### Mobility of land ownership, more than clinics, will reduce wrangles

WITH technological developments and mobile public services as the new buzzwords in service delivery, it was enlightening to hear that financial year 2023/2024 has so far seen 4,565 disputes related to land ownership and use resolved.

According to the Lands, Housing and Human Settlements Development minister, that this has resulted largely from the deployment of mobile land clinics in a countrywide campaign.

The recent observation constituted part of proud moments of the ministry's work as recounted when the minister presented the ministry's Budget estimates for FY 2024/2025 in the National Assembly in Dodoma city.

Just how far this is a revolution compared to the past is not easy to assert but definitely progress is being made, even if its stability and economic usefulness are put in considerable unease by threats of climate change.

The minister's remarks seemed to suggest that mobile land clinics and ongoing surveying and land use planning point to the government's overall vision in that direction.

When this programme is in full swing, it will obviously make a huge difference to a situation where land issues are sorted out communally, where anything is possible depending on customs and circumstances—with the law not quite the determining feature.

There was helpful note in the minister's remarks when he distinguished between chronic and routine land disputes, even as it wasn't clear if these are resolved using the same methods after clearing thousands of queries. The minister said the importance of resolving land disputes was that people need to live freely and peacefully while conducting their economic and other activities unhampered.

The financial year saw the government approve 191 applications for 11,613 hectares of land from local

and foreign investors, while the ministry is seeking 178.57bn/- to move people from game reserves and water sources.

The people targeted will be moved to areas deemed more suitable for settlements but while noting that many flood plains and hilly areas are gradually vacated owing to threats of floods, landslides, etc., impacting on farms and housing.

What is again visible is that the government will have to make more compromises on some lands, as the ravages of climate change makes previous and even current land use plans a bit unreliable.

The fact is that no one knows for sure what year-end rains or the long rains next year will be like.

In a way, there is even a tendency of bridging these rainfall periods into one long rainy half-year - from late October to the outward reaches of May, as in the El Nino phenomenon in the outgoing rainy seasons.

Yet, since 'misfortune never comes alone', vast patches of land are left dry and, for Africa, swathes of some countries including those that have lately alternated between sea-borne cyclones at one point amidst vast drought.

Whether it is on chronic dry land or chronic wetlands, there are millions of people in Tanzania alone who would be glad to exchange their patches of land for reasonable amounts of money to move to more predictable climes.

They need usable options like gardening and poultry or small patches for zero grazing, with possibility of purchasing of cattle feed or growing it periodically on the patches for harvesting and storing.

Public authorities, though, may be thinking otherwise, which could force some people into rethinking their projections, with dreams shattered. This only further underlines the need to keep taking into serious consideration the way land use plans fit into the wider picture of national development.

### National Service's rationale strained in its voluntary, compulsory strands

TOP commanders of the National Service, a wing of the country's defence forces, have been issuing directives to those completing Form Six mid this year to report to training camps between in the first week of next month.

Those who attended National Service decades ago will recall that they were required to be there for threemonth mandatory training - and it was generally both as refreshing as it was in a sense perplexing.

The military training used last six months and the service as such six months, the latter now scrapped and the other part halved, so the total presence in the force has vastly diminished - from one year earlier.

Even then, exposure to the basics of parade discipline and elementary military skills is not irrelevant in shaping the psychology of youths.

However, for the stint is not am financial year 2023/2024ious enough to qualify as actual military training or come up as a specific formation for patriotism or living with people of other classes or ethnic provenance.

National Service is instrumental in moulding our youth through training that corresponds to passing them through 'building a better tomorrow' (BBT) furnaces - in this case through the execution of various forms of development projects but without sidelining defence and general physical, mental and psychological resilience and vigilance.

The capacity to care for wildlife, courtesy of the undergoing of tailor-made training at the likes of Mwika Wildlife College, would possibly make a viable addition to what National Service stints could offer youths.

In other words, it would likely be easier for the government to find the resources or avenues to keep in the BBT framework youths reporting there.

It would also preferably re-formulate the compulsory military training element, even as it is notable that the expectations of some of the National Service 'graduates' being considered for openings to a military career remain understandably sweet dreams.

A BBT framework of skills where one's physical resilience constitutes a significant portion of the tasks at hand is a usable option, particularly with cooperation from military train-

While the logical transposition of the issue looks somewhat outlandish, it is possible to convert the sprawling National Service camps into BBT units, depending on whatever may be the government's projections and expectations.

Zanzibar has for decades had a similar department going by a name aptly suggesting that it is, in fact, an economy building unit.

That comes closer to meaning the desire - indeed, intention - to mould youths ready for gainful 'self-employment'

The government in general and National Service in particular have gathered the experience they need to ensure that every effort is made to make our youths play a pivotal role in shepherding our country into an inviable member of a global community of nations making the grade on all major scores.



## Elections 2024 – What happens next in SA's uncertain journey to a coalition government

SOUTH Africans will elect their seventh democratic Parliament in two days, with the final results expected by 2 June. This will be an anxious week as we await the type of coalition and leadership that will govern for the next five years.

Voting patterns and trends indicate

that after 35 years in power, the African National Congress (ANC) could by 2029 be relegated to the opposition bench. But in the interim, it's likely to dominate Parliament as the largest party by quite a stretch.

Parliament must hold its first session within 14 days of the results' release, likely on 17 June. After Members of Parliament (MPs) are sworn in, they elect a president from among their 400 members. Elected parties are allocated seats proportional to votes received, using the candidate lists submitted before the polls. If there's more than one presidential candidate, voting is by secret ballot. If no one gets a majority, the candidates with the fewest votes are eliminated, and voting is repeated.

In the unlikely scenario that a new president isn't elected within 30 days because two candidates get equal votes, Parliament is dissolved and a new election is called. During this period, President Cyril Ramaphosa and his current Cabinet remain in their positions in an acting capacity.

Once the president is elected, she or he forms a cabinet from among the MPs. There's no time limit for this. The president can nominate two people from outside the National Assembly. Choosing a large cabinet from the limited pool of expertise has been an enduring challenge for successive presidents.

Polls suggest that the ANC will remain dominant, with the largest number of seats in Parliament, but probably without a clear majority. The party will likely need partners in the Northern Cape and Free State provinces, and could find itself on the opposition bench in Gauteng and KwaZulu-Natal. The Democratic Alliance (DA) looks set to retain the Western Cape, even if it needs the support of a smaller party to do so.

Of course, the surveys may get it wrong. South Africans may decide to stay at home or turn out en masse. To date, the trend is for a steady decline in the percentage of South Africans who register and vote. Is there a sufficient sense that 'change is in the air' to turn that trend around on Wednesday? Whatever the outcomes, real negotiations between the various parties can only start once the results are announced.

Rough ride for ANC predicted

That said, there seems little doubt that the largest losers will be the ANC, with an approximately 10 percentage point decline in their support, and the Economic Freedom Fighters (EFF), which could see its support plateau. The new uMkhonto Wesizwe (MK) party and the Inkatha Freedom Party (IFP) have eaten into voter support for both

But MK has a limited shelf-life. The party was formed in December 2023 with former president Jacob Zuma's endorsement. On 20 May, the Constitutional Court ruled that Zuma can't run for Parliament this week due to his 2021 jail sentence. Given his age and disdain for the rule of law, MK will likely either disappear or eventually merge with another, most likely the EFF. In the interim, an EFF-MK alliance in Parliament could provide a voting bloc almost approaching DA levels of support.

Perhaps the only certainty is that the polls will reflect the ongoing fracturing of political support among many more parties, pointing to the need for partners at every level. Our proportional system makes coalition government an inevitable future. The next local government elections in 2026 will surely see an increase in the 66 hung councils after the November 2021 polls.

### Local government stability

Once enacted, the recently published Municipal Structures Amendment Bill will help stabilise local government. It will limit the number of parties allocated seats in a council by requiring 1% of valid

votes cast. Changes of municipal office bearers would be possible only two years after being elected. And the Cooperative Governance and Traditional Affairs Member of the Executive Council (MEC) can change a municipality to a collective executive system if no party obtains a majority of seats.

It remains to be seen what will happen at the national and provincial levels after the elections on 29 May, however.

We need to learn to govern in consultation with one another, as has been happening successfully in some municipalities, although not in metros outside the Western Cape. Already there's talk of professionalising the civil service as part of a broader plan to allow the government to carry on without too much political interference.

If it falls below 50%, it seems likely that the ANC will go into coalition with any number of smaller parties at the national level rather than with larger parties like the DA, EFF or IFP. The question of electing the president will be intertwined with selecting partners, and will be a harbinger of things to come.

South Africans have been here before, with efforts in 1994 to hold the country together after its first democratic elections. After a promising start, the past two decades have been disappointing, although we must recognise the extent and impact of exogenous shocks such as Covid-19.

### Need for unified, developmen-

But South Africa – once a beacon of hope – has squandered much of its national and international goodwill, particularly under Zuma, whose presidency was marred by corruption, incompetence and inaction. Under his watch, the State was decimated, and many Stateowned assets sold off or destroyed. This has left the government with no choice but to turn to the private sector – not a long-term solution for a country with such levels of

poverty and inequality. Recent Nobel laureates in economics Angus Deaton and Joseph Stiglitz, among others, are sounding alarm bells regarding how neoliberal economics have led to populism and increased inequality. South Africa is heading in the same direction, largely due to a lack of alternatives, and will eventually need to recover from the inevitable deleterious effects. We need a strong, developmental state. Large parts of its service delivery in poorer areas should not and cannot be driven by profit.

South Africans need to come together and put ideology, race and other divisions aside if we want to improve livelihoods. We must build a working future that brings all key sectors in public life and the economy together.

A country divided – as we are today –grows slowly. This means the best outcome for South Africa, once the dust settles after the elections, will be a government of national unity and, like other high-growth economies, a laser-like focus on economic growth and development. We need to bring all our considerable expertise together to make South Africa the success it can be DM

foiled a coup against President Felix Tshisekedi's government, resulting in at least three deaths in Kinshasa. The attackers, armed and wearing military fatigues, targeted the residence of ally Vital Kamerhe and breached the Palais de la Nation, although Tshisekedi was absent. Among the attackers was Christian Malanga, a former Congolese army captain and US resident, who led the failed assault.

"At about 4 am local time (03:00 GMT) dozens of men wearing military fatigues and armed with submachine guns and rifles attacked the residence of Vital Kamerhe, a federal legislator who is an ally of Tshisekedi and a favorite to become the speaker of the National Assembly," reported La Prospérité.

The incident unfolded swiftly, with gunfire erupting in the streets of Kinshasa as security forces engaged the attackers. At least three people were killed in the shootouts that ensued, including two Congolese security officials, and the leader of the attackers, Christian Malanga. Some 50 people have been arrested, the Congolese military said, including three United States

The failed coup attempt in the Democratic Republic of Congo (DRC) reverberated across Africa, prompting renewed scrutiny of political stability in regions grappling with similar challenges.

In Burkina Faso, the Gambia, Mali, and the broader Sahel region, the specter of political unrest loomed large, with recent events underlining the fragile nature of democratic governance and the persistent threat of military intervention.

The presence of jihadist groups such as Jama'at Nasr al-Islam wal Muslimin (JNIM) and the Islamic State in the Greater Sahara (ISGS) further destabilized the region, posing a threat to regional security and undermining efforts to promote sustainable development and economic growth.

The African Union and international partners expressed concern over the deteriorating security situation in the Sahel, calling for enhanced cooperation and support to address the root causes of instability and build resilience against external threats. The AU's commitment to democratic governance and human rights underscores its role as a custodian of African values.

ECOWAS, comprising 15 West African nations, is pivotal in maintaining regional peace. Swiftly condemning the DRC coup attempt, ECOWAS upholds democratic principles and governance. Similarly, SADC fosters peace in Southern Africa through dialogue and mediation, enhancing economic development. African leaders prioritize collective action and inclusive governance to make the continent move towards a brighter future.

The failed coup attempt in the DRC served as a stark reminder of the fragility of peace and democracy in Africa. However, it also underscored the resilience of African leaders and regional organizations in confronting such challenges with determination and resolve.

## Resettlement in Ngorongoro: A government initiative to safeguard wildlife and enhance community welfare

OASTAL erosion has been aggravated by climate change and has already destroyed more than 500 houses in the town of Atafona in south-eastern Brazil. Movements led largely by women are working to combat the advance of the sea and generate economic alternatives.

Atafona, one of the six districts of São João da Barra, a municipality of 37,000 inhabitants, is 310 kilometers by road northeast of Rio de Janeiro. It is a town with its own identity. Fishermen, who were joined by middle-class families from nearby large cities, built their vacation homes there

Sonia Ferreira did so in 1980, when she lived in Rio de Janeiro. She moved permanently to Atafona in 1997, when she witnessed the disappearance of the three blocks that separated her house from the beach. In 2008, she saw the town's tallest building–four stories–collapse across the street from her house.

She has photos recording the downfall of the building that housed a supermarket and a bakery on the first floor and a hotel upstairs. Her house would have been the next victim, but the sea granted her an 11-year grace period. "I will only leave when the wall around the house falls," she would tell her family when they pressured her to move to a safer place.

But from 2019 to 2022, the sea level started to rise again. "In 2019, the first piece of the wall fell. I fixed up the little house at the back of the lot and moved in, but I kept the big house with the furniture until 2022, when the water reached the house and the floor gave way," she

"The sea does not hit in overpowering waves, but erodes the sandy soil, infiltrates underneath the buildings, undermines their structures, and the house is basically left hanging in the air," she described.

In late 2022, she decided to demolish the "big house" in a painful process after sadly seeing the wall fall down in pieces. But then she could not live in the small house in the backyard, which was invaded by a large amount of sand, so she was taken in by her daughter. Widowed, she has two other children who live abroad.

At the age of 79, Sonia Ferreira channels her love for the area as president of SOS Atafona, an association with about 200 active residents, mostly women, who debate and lobby the public authorities for solutions to stop the advance of the sea and other problems in the neighbourhood.

### Fishermen suffer climate injustice

"Fishermen have been hit the hardest," she said, as vacationers have resources such as other homes.

The original settlers are the main victims of climate injustice in Atafona. The rising sea level and the intensification of the northeast wind not only destroyed their houses but also exacerbated the siltation at the mouth of the Paraíba do Sul River, limiting the access of boats to the fishing port on the river through a narrow channel.

Faced with the difficulties, the larger vessels prefer to deliver their fish to distant ports, some 100 kilometers to the north or south, at the expense of the local economy, lamented Elialdo Mirelles, president of the São João da Barra Fishermen's Colony.

Meirelles estimates that about 400 fishing families lost their homes on Convivência Island, which was in the Paraíba do Sul River delta, where the problems began.

Only 200 families were given new houses by the government, while the rest were dispersed or have been living for years with the benefit of "social rent," a small sum

from the municipality to help pay for rental housing. That is why he believes that the houses engulfed by the sea in the entire area numbered much more than the 500 or so estimated by the city government and that the erosion actually began before the 1960s, which is the time frame indicated by researchers.

"I was born on Convivencia Island in 1960, where my grandfather and father lived. My father lost two houses there, I lost two, and two of my brothers lost one each. The northeast wind was the cause," he said. In 1976, the government began to remove settlers from the island,

and the last ones left in the 1990s.

Then many families living in Pontal, the end point of the river's right bank, also lost their homes. "Five streets were submerged," he noted. As the island disappeared, that mainland area lost a barrier against the wind, he said.

Meirelles, who sought a new home away from the shoreline on his own, represents 680 registered fishermen in his entire municipality of São João da Barra, 56 percent of whom are from Atafona.

### **Causes of coastal erosion**

"Climate change definitely aggravated the problem unleashed by several factors, especially human action that reduced the river's flow," said Eduardo Bulhões, marine geographer and professor at the Fluminense Federal University.

The main factor was the transfer of water from the Paraiba do Sul river to the Guandu river system, which supplies nine million inhabitants of outlying areas of Rio de Janeiro and was inaugurated in 1954. Since then, there have been expansions that have drastically reduced the flow of water in the river that runs into Atafona

The river rises near São Paulo and crosses almost the entire state of Rio de Janeiro-in other words, a densely populated area of 1,137 km. Its waters, destined for other cities, industries, and hydroelectric generation, lost the volume and strength to carry sediment to the delta at the mouth as a barrier against the sea.

In addition to engulfing Convivencia Island and many blocks of Atafona, the sea advanced upstream, salinizing many kilometers of water table and affecting the municipality's water supply.

The collapse of houses due to erosion is also caused by their irregular construction on dunes that have always existed in the town and are growing on part of the beach, said Bulhões.

The northeast wind, which is intensified by climate change and pushes the waters that erode the constructions and the sands that threaten to clog the coastal road and nearby houses, contributes to this, he said.

A solution to coastal erosion depends on studies to identify long-term feasibility and effectiveness, and the city government is preparing terms of reference to contract the studies, reported Marcela Toledo, São João da Barra's secretary of environment and public services.

### **Women-led projects**

This municipality is also located in an area impacted by oil exploration in the Campos basin, offshore Rio de Janeiro state. Due to environmental requirements, the state-owned oil company Petrobras, the main explorer, is financing the Pescarte Environmental Education Project to mitigate and compensate for these impacts, carried out by the North Fluminense State University (UENF).

In the project, which is focused on fishing as the most affected activity, women constitute the vast majority. The main proposals approved were refrigeration plants, industrial kitchens, fishmeal factories and processing plants, said Geraldo Timoteo, a professor at the UENF and the head of Pescarte.

In the Pescarte team, initially looking at environmental education and now at production, 48 out of a total of 59 employees are women. Of the 14 supervisors, 11 are women

The organization of artisanal fishermen and their families is the central objective of the long-term (2014-2035) project. It also seeks to increase income through expanding the use of fish and providing better access to markets and cooperatives.

Now the idea is to promote aquaculture based on experiments conducted at the UENF.

Pescarte has also accumulated knowledge about the world of fishermen. It conducted two censuses in the 10 participating municipalities in 2016 and 2023, Timoteo told IPS.

In the second one, 46 percent of the people interviewed were

women and 21 percent of them were responsible for 100 percent of the family income. In 37.9 percent of the cases, they shared this responsibility with their hus-

Fernanda Pires is one of the participants of Pescarte in Atafona. Her activism for fish processing as a way of adding value is reflected in her practice as leader of the Arte Peixe cooperative, which produces eight types of fish and shrimp

Founded in 2006 by her mother, Arte Peixe has 20 female members, seven of whom work directly in production. The profits are limited, serving as a supplement to the main income obtained from other work or employment. Pires is a municipal employee, but new markets open up prospects for better profits in the future.

The leading role played by women in overcoming the problems in Atafona, threatened by coastal erosion and the decline in fishing, is perhaps due to the fact that "they study more, and have greater concern for the future, and a stronger sense of community," said Bulhões.

In Pescarte, its directors observe that while men prioritize fishing in itself, upgrading their boats and equipment, and are absent from the city, spending more and more time at sea every day, women take care of processing the fish, sales and adding value; that is, they focus more on the future of the activity and of their lives.

FRICAN Heads of State and Government unitto bolster agriculsustainability and enhance smallholder farmer livelihoods by endorsing the Nairobi Declaration articulating the outcomes of the Africa Fertiliser and Soil Health Summit convened in Nairobi, Kenya from the 7th to 9th May 2024.

In a statement issued yesterday by the African Union Commission here, the declaration signified a transformative step towards improving access and affordability of certified quality organic and inorganic fertilizers across the conti-

In recent years, there has been a significant increase in local manufacturing of mineral fertilizers with over \$15 billion of investments by the private sector.

However, even as Africa's mineral fertilizer production is estimated at 30 million metric tons annually, most of it is exported outside the continent.

Most Member States are still overdependent on imported fertilizers, especially non-phosphate-based fertilizers which expose Africa to external market shocks and price volatility.

To address this, the statement said, Africa has committed to increase investments in local domestic manufacturing and blending of fertiliser harnessing the continent's

Member states will be working to explore financing tools such as trade credit guarantees, working capital, and targeted subsidies to reduce market distortions, reduce costs and strengthen input supply chains.

Increasing the use of fertilizers, both mineral and organic resources, is imperative for increased productivity and soil health restora-

Africa is seeking to enhance the efficiency and effectiveness of mineral and organic fertilizers and other complementary inputs, to increase productivity, maximize profitability and returns on investment, improve soil health, and enhance resilience to climate change.

Thirteen (13) critical points are outlined on the Nairobi Declaration on the implementation of the com-

## The African wild dog: Painted wolf of the savannas

HE African wild dog (Lycaon pictus, or 'painted wolf') is also known as the Cape hunting dog or painted dog—a reference to the striking, multi-colored mosaic patterns of their beautiful coats.

With the unique social dynamics of their packs and highly complex hunting strategies, these highly social and intelligent apex predators have played a vital role in maintaining the balance of African ecosystems. Yet, they are one of Africa's most endangered carnivores.

### From ancestral wolves to nomadic savanna predators

During the Pleistocene, around two million years ago, African wild dogs diverged from a common ancestor they shared with wolves. Although they were once found in desert to mountain habitats throughout the African continent, they have disappeared from most of their geographic range—due mainly to human pressures.

Now, they typically roam the vast open savannas and sparse woodlands of sub-Saharan Africa, where their largest populations are found in Botswana, Zimbabwe, Namibia, Zambia, Tanzania, and Mozambique

African wild dogs thrive in cohesive packs, patrolling huge territories that can stretch over 1,500 square kilometers (580 square miles), and traveling around 50 kilometers (30 miles) in a single day. Their nomadic lifestyle mirrors the dynamic nature of their ecosystems, allowing them to adapt to constantly shifting habitat conditions and herd movements.

### Unique coats and built for speed

The irregular patterns on the coats of African wild dogs are unique to each dog, featuring patches of red, black, brown, white, and yellow fur. Large, rounded ears are designed for keen hearing, and their lean bodies, great lung capacity, and long, slender legs are designed for endurance and agility, enabling them to navigate dense vegetation easily over long distances.

While other canids are five-toed, these dogs have only four toes on each foot with the pads of the middle digits connected by dermal webbing, thought to enhance their speed and maneuverability. Although they're able to reach a top, greyhound-like sprint speed of 72 kilometers per hour (45 mph), their hunts rely on the endurance required to run their exhausted quarries to a standstill. Very sharp, large premolars then allow them to consume large quantities and coordination. of meat and bone swiftly-before other predators such as lions and hyenas can encroach on their kill.

### The power of the pack's communication and cooperation

African wild dogs are highly social, communicating with each other through frequent vocalizations, touch, and other behaviors. Amazingly, it's been discovered recently that African wild dogs use a system of meaningful sneezes to "vote" on group decisions before a hunt, which is characterized by complex, strategic team tactics and coordination.

Their formidable packs number from six to twenty dogs who are among the world's most skillful and proficient hunters, with a success rate of 80 percent as compared to lions' 30 percent. This is attributed to the constant communication maintained

throughout a hunt, during which they check in on their pack mates with vocal calls conveying their own locations and that of their prey to adapt strategies. Success is also due to the close social bonds they've formed with each other. A pack will come to the fierce and courageous defense of every individual.

### Diet and altruistic feeding be-

African wild dogs are opportunistic feeders, preying primarily on small to medium-sized ungulates such as impalas and gazelles, as well as warthogs and wildebeest (which were likely more common when the dog packs were larger). They supplement their diets with rodents and birds, and also scavenge carrion when it's available.

After a kill, all pack members will feed equally regardless of

their rank or whether they participated in the hunt, and pups and yearlings always feed first. Pack members are also altruistic, assisting and sharing food with their weak, ill, injured, and elderly members.

Pack leadership and reproduction dynamics African wild dog packs are led by an older domiant female and a young dominant male, who form

amonogamous breeding pair and dominate subordinates of both sexes. Juvenile males are most likely to stay with the pack, whereas females often emigrate.

While subordinate females may also reproduce, their offspring seldom survive. More often, these females develop pseudopregnancies and may lactate to help care for the pups of the dominant pair.

The dominant female has a litter of two to 20 pups which are then cared for by the entire pack, which regurgitates food to the pups while they're still in the den. At 11-12 weeks of age, the pups are weaned and start to follow the pack.

### Keystone species as ecological architects

Beyond their prowess as hunters, African wild dogs serve as keystone species in their ecosystems. Their regulation of herbivore populations prevents overgrazing and maintains the integrity of vegetation communities.

It also contributes to nutrient cycling, enriching the soil and fostering plant growth. Africa's wild dogs serve the same essential ecosystem function as their faraway wolf relatives, as architects of healthy, balanced biodiversity.

### Cultural significance and enduring symbolism

Highly respected by the ancient Egyptians as symbols of order over chaos, African wild dogs were often depicted on cosmetic palettes from the Predynastic Period. Across the African continent, Indigenous cultures have revered them as symbols of strength, unity, and perseverance.

In traditional folklore, they are frequently depicted as guardians of the land, entrusted with the task of preserving the natural order—an ecological role we now recognize. One prevalent myth portrays these dogs as emissaries of the spirit world, possessing the wisdom to guide lost souls on their journeys to the afterlife.

The Indigenous San people of Botswana (once known as the 'Bushmen') see the African wild dog as the embodiment of the ultimate hunter and believe that shamans can shape-shift into painted dogs. San hunters sometimes apply the bodily fluids of wild dogs to their feet in the hopes that they will be granted the dogs' stamina, agility, and courage.

Through the millennia, their enduring symbolism reflects the deep-seated respect and admiration that humans have held for these unique canids.

### The multifaceted threats for survival

Despite their cultural significance and ecological importance, African wild dogs have been on the IUCN Endangered Species List since 1990, and face myriad threats that jeopardize their survival.

Habitat loss driven by the encroachment of human settlement and agricultural expansion has fragmented their territories and restricted their movements. Predation by lions and competition with spotted hyenas pose additional challenges to their survival, as does the spread of diseases such as rabies and canine distemper.

Although the expansion of human settlements has led to conflict with livestock farmers, significant predation is rare, as the dogs prefer wild prey. Still, in many areas, farmers shoot them on sight or leave poisoned meat at their dens to eliminate entire packs. One of the traits that helped early peoples domesticate wolves was their willingness to join human communities, but African wild dogs have given humans a wide berth.

Climate change has only exacerbated these threats, altering the distribution of prey species and disrupting the dogs' established hunting patterns.

Initiatives for habitat connectivity and conflict reduction

African wild dogs are among the many species that would benefit from the creation of protected wildlife corridors that help connect their increasingly fragmented habitats. Conservation groups are also working on initiatives that reduce conflict between humans and African wild dogs, including educational efforts that offer farmers training in livestock management techniques that prevent predation. 


### Hope through conservation efforts

# Stadium oversight blunder: Expertise gap leads to default on FIFA regulations

HIS is the second part of a special report on the Mkapa Stadium, which supposedly contradicts the promise made by former President Benjamin Mkapa to the nation. Back in 2000, the late President pledged to build an ultramodern FIFA-approved grade 'A' stadium before his term ended in 2005. He considered it a national disgrace for the country to lack a state-of-theart facility.

Construction commenced in July 2005 and wrapped up in June 2007, culminating in its official inauguration in September 2007. Initially dubbed the Tanzania National Stadium, it was later renamed in tribute to President Mkapa, three years after his demise.

The country's FIFA Security Officer, Inspector Hashim Abdallah, and the Director of Information and Marketing at the Tanzania Football Federation (TFF), Boniface Wambura, both members of the CAF audit team, have individually outlined discrepancies noted in their inspection audit re-

These inadequacies encompass insufficient journalist facilities, lack of proper signage directing attendees to their seats, absence of disabilityfriendly infrastructure, and the need for metal detectors to screen for weapons. Furthermore, they highlighted the inappropriateness of having a public road adjacent to the stadium.

All these concerns align with the 89 FIFA criteria necessary to meet global standards, which were expected to be resolved when the stadium was officially transferred to the government on July 3, 2013.

Wambura suggests that a probable lack of expertise or oversight among government officials responsible for the stadium's construction might have led to the neglect of FIFA regulations and essential construction considerations.

He also highlights a critical flaw: the lack of convenient infrastructure for individuals with disabilities. This concern has been emphasized by CAF inspectors, who recommend prioritizing accessibility improvements for this group.

They specifically stress the importance of making pathways, restrooms, and viewing platforms disability-friendly. Additionally, they suggest providing designated parking areas for bicycles or motorcycles to accommodate disabled spectators attending matches.

The issue of weapons inspection poses a significant challenge. Currently, the metal detectors at Mkapa Stadium are only positioned at the VIP entry point. Both CAF and FIFA inspectors have expressed concern over the excessive number of VIP sections, recommending a more streamlined VIP arrangement to address this criticism effec-

Inspector Abdallah is particularly worried about the firearms storage facility. In the past, law enforcement and security personnel brought their weapons onto the field, violating FIFA regulations. This issue arose because the stadium lacked a specific storage area for protective gear. However, steps are being taken to rectify this situation and ensure compliance with FIFA guidelines.

Gerson Msigwa, the Permanent Secretary for the Ministry of Culture, Arts, and Sports, announced that as of April 11 this year, the field's enhancement progress had reached 25 percent completion.

Key improvements include the transition to a digital broadcast system, refurbishment of the players' changing rooms with new flooring, and plans to expand the football field and the athletics section.

"We are overhauling the sewage system, electricity, air conditioning units, and seating arrangements, and repainting the stadium gates," explained Msigwa. At the time the repair contract was finalized on July 27 last year, he served as the Director of the country's Information Services (MAEL-EZO) and Chief Government Spokesperson.

When the Guardian inquired about measures taken against government officials following the confirmation of stadium defects during inspection, Msigwa affirmed that the stadium meets FIFA standards, allowing its use for international matches, such as the CAF Championship of the African Club.

"The flaws identified by CAF inspectors are those they have observed. Their recent visit, three weeks ago, noted certain shortcomings. However, repairs are actively underway," Msigwa stated.

Contrary to Msigwa's assertion that the stadium is used for international matches, FIFA Security Officer Inspector Abdallah emphasized the need for special authorization for such events due to the absence of an alternative FIFA "A" Class stadium in the country.

According to media reports, the tender for the stadium's construction was announced in 2003. The Minister of Sport informed the BBC that the government had allocated US\$60 million for the project.

Initially, 11 construction firms expressed interest. Ultimately, in 2004, the tender was awarded to France-based Vinci Construction with a bid of US\$154 million, approximately 397bn/-.

However, opposition from certain Western countries, including those linked to the Bretton Woods Institutions, led the government to pause the tender process. These institutions oversee the global economy and raised concerns about the financial prudence of such an expensive project for a nation recently relieved of substantial debts.

After terminating the initial tender, the government shifted the project to China, where the field's design was finalized. In June 2004, then-Foreign Affairs Minister Jakaya Kikwete traveled to China and signed an agreement for a \$56 million stadium, with China contributing \$20 million to the project.

On May 2 of this year, The

Guardian reached out to Alice Mcharo, the Chief Procurement Officer of the Public Procurement Regulatory Authority (PPRA), for clarification on several key issues.

The Guardian inquired why the initial tender exceeded the government's budget, why Vinci Construction did not proceed with the stadium construction, and why BCEG later became involved in the project. They also questioned the allocation of a 31bn/- tender to BCEG for stadium upgrades, especially given CAF experts' concerns about meeting inter-BCEG was responsible for constructing the stadium.

The Guardian also sought information on actions taken against government officials responsible for the flaws identified by CAF. However, Alice Mcharo requested a formal letter with these questions, to be addressed by the Director General of PPRA. The Guardian submitted the letter the following day but has yet to receive a response.

When asked about a provision ensuring BCEG future repair or upgrade tenders, the project manager Liang clarified, "There is no such provision. We won the current tender through a competitive bidding process, strictly adhering to all required procedures. Our previous work on the stadium did not influence our selection for this project, which is entirely separate."

Regarding the 31bn/- allocated for stadium improvements, Liang emphasized that procuring necessary equipment significantly influenced the total project costs.

"The addition of 62,000 new seats is crucial, given the stadium currently has only 57,558 seats for spectators, with the rest reserved. Furthermore, the financial landscape has changed since 2004. Equipment prices have risen, contributing to the substantial cost of these enhancements," he explained.

"In our quest for the prestigious Class 'A' FIFA rating, we're elevating the stadium by installing 352 cutting-edge lighting fixtures, surpassing the existing 260. Despite the

contemporary digital activation system, ensuring instant illumination, a stark improvement over the current lights, which demand 15 to 20 minutes for re-ignition.

Addressing the imperative of local content utilization, Manager Liang elucidates. "We prioritize sourcing materials like cement and paint locally in Tanzania. For nonlocal items, we import as necessary."

Rhoben Nkori, Registrar of the Contractors Registration Board (CRB), lauds BCEG as a major player in significant projects, operating in the country for two decades.

Nkori confirms CRB hasn't

received any complaints about BCEG's work on the Benjamin Mkapa Stadium.

In instances of contractor errors, CRB adopts measures such as registration revocation, project suspension for reassignment, or compelling rectifications at the contractor's expense.

Nkori, well-versed in the matter, including CAF directives, asserts that BCEG adhered to client requirements and professional standards during stadium construction.

"The stadium, classified as Class 'B' by FIFA builders, falls short of CAF's Class 'A' stadium mandate for their competitions," he elucidates. Nkori proposes two options: proceeding with ongoing enhancements or constructing a new stadium to meet CAF's criteria.

Paul Bilabaye, Assistant Registrar - Finance and Administration at the Engineers Registration Board (ERB), corroborates Nkori's statement, affirming no complaints against BCEG.

Bilabaye attributes identified issues at Benjamin Mkapa Stadium to a dearth of local stadium experts.

ERB's oversight revealed a deficiency in local expertise during CAF expert inspections. Local experts overseeing stadium construction lacked the requisite skills for international-standard stadi-

Bilabaye underscores that FIFA standards were overlooked during stadium construction, contrasting with the adherence to FIFA guidelines in building TFF sports centers in Tanga and Kigam-

Bilabaye stresses the oversight in adhering to FIFA standards during the construction of the Mkapa Stadium, resulting in its inadequacy to host CAF and FIFA competitions today.

The intricacies of FIFA standards, such as soil assessment for player safety, require specialized expertise, which we currently lack. Consequently, the onus falls on those equipped with the necessary knowledge to elevate the soccer field at Mkapa Stadium to meet these standards. Manager Liang staunchly

refutes allegations of subpar construction, asserting that the stadium meets FIFA grade 'A' standards as per the client's requirements. BCEG executed the project according to the designated designs mandated by the government.

Highlighting the evolution of client needs, Manager Liang emphasizes the imperative to upgrade the stadium to FIFA grade 'A' standards. With its inauguration dating back to 2007, much of the equipment has exceeded its operational lifespan and necessitates replacement.

Mahona, the stadium manager, anticipates the completion of stadium enhancements by August this year, signaling a proactive approach to address deficiencies and align with international standards.

## Agency projects Tanzania's economic growth at 5.6 pc

OCUSECONOMICS, the Barcelona based macroeconomic intelligence agency has forecasted the Tanzania's economic growth of 5.6 per cent this year, although extreme weather events disrupting agricultural production pose a downside risk.

In its consensus forecast Sub-Saharan Africa - May 2024, the agency, which provides insights for 198 economies and more than 30 commodities, says Tanzania's GDP growth is forecast to accelerate slightly this year from last, due to stronger growth in both private and public spending.

"FocusEconomics panelists see GDP expanding 5.6 percent in 2024, which is up by 0.1 percentage points from one month ago, and expanding 5.9 percent in 2025," said Adria Solanes, the agency's

The rate is slightly higher than the projected 5.5 percent by the Bank of Tanzania (BoT) as stated in the Monetary Policy Statement, Mid-Year review for February 2024 and lower than 6.1 percent projected by the African Development Bank (AfDB).

Solanes notes that Tanzania's fixed investment will remain supportive, as IMF-backed reforms enhance investor sentiment; with export growth is forecast to soften.

"Both goods exports and privatesector credit continued to expand at healthy rates in January-February, while inflation remained subdued throughout the quarter," Solanes said in the report.

In 2024, the report says, inflation is forecast to average around 2023's level, staying below the Bank of Tanzania's 5.0 percent target. Commodity price spikes and a weaker-than-expected shilling are upside risks.

FocusEconomics panelists see consumer prices rising 3.8 percent on average in 2024, which is down by 0.1 percentage points from one month ago, and rising 4.2 percent on average in 2025.

On 3 April, the Bank of Tanzania

set its Central Bank Rate (CBR) at structural reforms, the impact of 6.00 percent for O2, up from O1's 5.50 percent, pre-emptive hike aimed to shield the economy from inflation arising from import price volatility.

Inflation slightly increased to 3.1 percent in April, from 3 percent in March, as compared to Uganda 3.2 percent and Kenya 5.0 percent, according to the National Bureau of Statistics (NBS) Consumer Price In-

"The Bank did not provide explicit forward guidance, but our panelists expect additional hikes by year-end. The next rate-setting meeting will be held in early July, says FocusEconomics.

"Our panelists see the central bank rate ending 2024 at 6.65 percent and ending 2025 at 7.35 per-

In its 20th economic update published in March this year, the World Bank also projected similar GDP growth for Tanzania due to resil-

"While annual GDP growth for 2024 is projected at 5.6 percent and offers hope for Tanzania, several threats cloud the economic outlook. Potential risks include slow

climate change on key sectors like agriculture and tourism, and the possibility of a global recession. These risks need to be carefully managed," said Emmanuel Mungunasi, World Bank Senior Economist.

Tanzanian authorities and the International Monetary Fund (IMF) reached staff-level agreement on a reform program earlier this month, to address climate change challenges supported by the Resilience and Sustainability Facility (RSF), and the completion of the third review under the Extended Credit Facility

The RSF will support the authorities' efforts to advance structural reforms and investments on adaptation and mitigation to address risks and challenges associated with climate change.

A staff team from the IMF led by Charalambos Tsangarides, IMF mission chief for Tanzania, held meetings in Dodoma and Dar es Salaam from May 2 to 17, for the third review under the Extended Credit Facility (ECF).

Subject to approval by the IMF Executive Board the review will make available SDR113.3 million or incomplete implementation of (about US\$150 million), bringing

the total IMF financial support under the arrangement to SDR455.5 million (about US\$604.2 million).

The team also discussed the authorities' request to access under the Resilience and Sustainability Facility (RSF) in the amount of 150 percent of quota (SDR 596.7 million, approximately US\$789.6 mil-

At the conclusion of the mission, Tsangarides said in a statement that the Tanzanian economic outlook is favorable with growth expected to pick up to 5.4 percent in 2024, supported by improvements in the business environment and subsiding global commodity pric-

"Risks to the outlook are tilted to the downside, as intensification of regional conflicts, increased commodity price volatility, abrupt global slowdown, prolonged liquidity issues in the foreign exchange (FX) market, and intensification of floods from El Nino, could weigh negatively on economic outlook,"

The government also committed to increase priority social spending and contain the impact of the recent floods on the most vulner-

# Cocoa growers call for swift action as prices plunge by 50 percent

COCOA growers in the Zigi River valley and its subcatchment areas have reported a sudden 50 percent decrease in the prices of their processed seeds. They are urging the relevant authorities to take immediate action to restore the prices to their previous levels.

The farmers expressed shock and dismay at the low prices they recently received from traders. They could not provide specific reasons behind these price fluctuations but emphasized the need for prompt intervention.

Asia's richest man Mukesh Ambani (pictured) is set to enter Africa with a telecom venture, seeking to win mobile broadband customers in a high-growth mar-

Radisys Corp., a unit of Ambani-controlled Reliance Industries Ltd., will provide key network infrastructure, applications and smartphones for Ghana-based Next-Gen InfraCo., according to its Executive Director Harkirit Singh. He described the plans ahead of NGIC's launch announcement on Monday in Mumbai, India's financial hub.

NGIC, which is planning to begin operations by the end of this year, will provide 5G broadband services to mobile operators and internet service providers in

The company "is based on a premise of building affordable digital services in emerging markets," Singh told Bloomberg News.

Other strategic partners in NGIC include Nokia Oyj, Indian outsourcer Tech Mahindra Ltd. and Microsoft



Ghana, a West African country with a population of just over 33 million, has three main operators: MTN Ghana, Telecel Ghana and AT, which changed its name from AirtelTigo last year after Bharti Airtel Ltd. and Millicom International Cellular SA sold their stakes.

NGIC's strategic partners, its technological prowess and the company's possession of Ghana's only 5G license will help it build broadband services at scale, a huge expense for individual mobile carriers, Singh said.

Two African telecom firms - Ascend Digital Solutions Ltd. and K-NET - hold a combined stake of 55% in the new company, said Singh. The Ghana government will own just under 10% of NGIC, while local mobile operators and private investors will retain the remaining shares in the firm. Singh is also the chief executive

Jio launched telecom services in India in late 2016 with low-cost data and free voice calling, forcing some rivals to shut down and others to consolidate. It is widely credited for making mobile data affordable to hundreds of mil-

Jio is currently India's biggest mobile operator with 470 million users.

Thus, regardless of how many accounts we have, we can still easily construct difficult passwords for each of them.

For most users, removable media-such as smartphones, SD cards, USB sticks, and external hard drives-represents their biggest security risk. People are connecting unknown removable media

end up keeping their pass- to their devices without realizing the consequences. This raised the risk of security breaches when it wasn't safe. You should never share removable media, and if you do, make sure to scan it for viruses. If not, ask someone to email you the information.

We don't have free food in cyber security, so avoid free tech-related things like free Wi-Fi, free download, free software, winning a lottery or green card without participating as there are ways to pay without realizing it. And make sure to always lock your computer (device) screen and disconnect the network when you're not using it.

Last but not least, in cybersecurity nothing is "set and forget", keep yourself updated on how to handle new threats and exploits because what is secure now might not be necessary to provide security tomorrow.

## **Business skills** change lives of women in Ulanga

Business education and entrepreneurship skills offered by activists in Ulanga District Council, Morogoro Region have transformed women's lives and helped them to become economically independent to support their families.

Janeth Makwenjula, chairperson of Tanzania Women's Union (UWT) and activist based in Ulanga District Council made the statement yesterday when speaking to journalists about what has been done to transform women's lives from being dependent on their husbands to job creators.

Makwenjula said has visited four wards across the district to create awareness and educate women, youth and men on business education, how to secure loans from financial institutions, entrepreneurship skills, how to set up a business and become an entrepreneur.

Through the knowledge and skills gained from her, a total of 200 women in three wards have been able to secure loans from the financial institutions and set up their own business. She named wards as Milola, Igumbiro and Mavimba.

Among those, 100 women are from Igumbilo, 50 from Milola and the remained 50 from Mavimba ward and are already engaged in vegetable farming, small food vending businesses (Mama Lishe) while others own restaurants, cafe and earn cash to support their families instead of depending on their husband as well as saving their cash.

"As an activist, I am very happy for what has been achieved so far because I have managed to transform women's lives something that was not the case in the past," she said

To start with, seven women are engaged in vegetable farming, seven in small food vending businesses (restaurant) at Milola village, while at Igumbilo ward, five women are engaged in small food vending businesses (Mama Lishe) and 12 are engaged in vegetable

Also in Mavimba ward, five women are involved in fish trade, five in vegetable farming.

Apart from that, Makwenjula has been able to open her own small shop that sold different products at Milola village to allow women, youth and other men to learn from there and later on establish their own shops or business to earn cash to improve their livelihoods.

Under the programme, women in the area were also trained on women's rights, what is gender-based violence against women, the effects it has for them, as well as obtain a chance to identify the main challenges they face in their families.

The training has helped them to set up their own businesses in their localities, we're seeing more women demanding their rights in courts, they help their children to stay in a better shape, they can contest in various political posts at village and ward levels and win,"

"Before Makwenjula intervention, life was so hard and painful for Milola Ward residents, majority of people were very poor, they were at zero in almost everything in-terms of business education, how to set up business, access loans and even how to get their rights and other issues,"

Cecilia Mahundi, a mother of four is among women who have benefited from the training at Milola ward.

She lauded Makwenjula for introducing the awareness campaign in their localities to educate women and other people on business education, entrepreneurship skills, how to access loans and set up business.

Through the knowledge and skills gained from Makwenjula, Mahundi's has been able to open two businesses that includes a small café business selling milk, yoghurt, snacks and charcoal business since November 29th in 2023.

## Global face fear of copper shortage

**BEIJING** 

The global copper market is gripped by fears of a shortage, which has propelled prices to record levels and sparked a \$49 billion takeover battle. But in China, the world's biggest producer and consumer of the refined metal, there's more than enough to go around.

At the center of that conundrum are the nation's ever-expanding copper smelters. The industry is maintaining production at nearrecord levels – defying a scarcity of raw materials – as higher prices unlock more scrap metal for processing.

Smelters had pledged to reduce capacity after their fees collapsed because of a supply squeeze on the imports of ore they use as feedstock. with Shanghai Metals Market.

The prospect of insufficient copper in China is just one of the pillars supporting a barnstorming rally that took the metal above \$11,000 a ton for the first time at the start of last week. But the cuts haven't happened and China's faltering economy isn't able to absorb the excess.

The mismatch between supply and demand has become more glaring in recent days, with prices retreating to just above \$10,300 a ton. Although that's still a 21 percent gain for the year, it suggests that as long as China remains oversupplied, copper will struggle to make further headway.

The availability of scrap from discarded pots, pipes and wires has risen quickly after copper prices surged, said Liang Kaihui, an analyst

Fabricators have been busy turning that into blister, a semi-processed version of the metal, and feeding it back to smelters, he said, where it's used as a substitute for the overseas ore that's now in short

The abundance of scrap is seen in its discount to refined copper, which blew out to 4,615 yuan (\$637) a ton last week, the widest in at least eight years, according to SMM.

The smelting industry, meanwhile, keeps adding capacity. As long as they're profitable, individual firms prefer to defend market share at the expense of margins. Local governments also want them to keep churning out metal so that they can meet their economic growth targets and maintain employment levels.

China's PMI surveys for May will likely show manufacturing continuing to grow at a modest pace, supported by solid production, according to Bloomberg Economics.

Ten years ago almost to the day, while checking out a handful of luxury sedans from one of China's largest automakers SAIC Motor Corp., President Xi Jinping gave a pivotal speech that would set China on the course to dominate the electric vehicle industry.

Chinese industries plan to ask authorities to start an anti-dumping investigation into pork imports from the European Union, the state-run Global Times said, citing information from a "business insider."

## Lagging in polls, UK Conservatives pitch national service at 18

**LONDON** 

BRITAIN'S Conservative Party will introduce mandatory national service for 18-year-olds if it wins the national election on July 4, comprising military or community participation, Prime Minister Rishi Sunak said on Sunday.

Young adults will be able to choose between spending one weekend a month volunteering over the course of a year, or take up one of 30,000 spaces to spend a year in the armed forces, Sunak said.

The announcement followed Labour Party leader Keir Starmer's comments on Saturday that he was in favor of allowing 16 and 17-year-olds to vote.

Sunak's Conservatives lag Labour by a wide margin in opinion polls, which have shown little change in fortunes for the prime minister since his surprise election call last Wednesday.

"Britain today faces a future that is more dangerous and more di- as an example. vided. There's no doubt that our

democratic values are under threat. That is why we will introduce a bold new model of national service for 18-year-olds," Sunak said in a statement.

The Conservative Party said the proposal would be funded by cracking down on tax avoidance and evasion, and by diverting money from the UK Shared Prosperity Fund, which existed to reduce regional economic inequality.

Labour politicians derided the announcement.

"The national service we need from our young people is to vote for change on 4th July," said Andy Burnham, mayor of Greater Manchester.

Interior minister James Cleverly told broadcasters there would be no criminal sanctions for skipping mandatory service but that people will be compelled to do it, without providing further details.

Asked by the BBC if forcing adults to volunteer was at odds with the Conservative Party's liberal tradition, Cleverly said: "We force people to do things all the

## **US and European nations consider** vaccinating workers exposed to bird flu

**CHICAGO/LONDON** 

THE United States and Europe are taking steps to acquire or manufacture H5N1 bird flu vaccines that could be used to protect atrisk poultry and dairy workers, veterinarians and lab technicians, government officials said, moves influenza experts say could curb the threat of a pandemic.

US officials last week said they were moving bulk vaccine from CSL Seqirus that closely matches the current virus into finished shots that could provide 4.8 million doses of vaccine. European health officials told Reuters they were in talks to acquire CSL's prepandemic vaccine.

Canadian health officials said they have met with GSK, maker of Canada's seasonal flu shots, to discuss acquiring and manufacturing a prepandemic bird flu vaccine once its seasonal flu production capacity is freed

Other countries, including the UK, are discussing how to proceed on prepandemic vaccines, scientists said.

The actions follow the explosive spread of a new strain of bird flu that emerged in late 2020 and has caused unprecedented numbers of deaths among wild birds and domestic poultry and has begun infecting many mammal spe-

In March, US officials reported the first outbreak of the virus in dairy cattle, which has infected dozens of herds in nine states and two dairy workers. The US Food and Drug Administration has estimated that 20 percent of the US milk supply shows signs of the virus, indicating a wider spread is

Human exposures to the virus in poultry and dairy operations could increase the risk that the virus will mutate and gain the ability to spread easily in people.

"All of our efforts need to be focused on preventing those events from happening," said Matthew Miller, co-director of the Canadian Pandemic Preparedness Hub at McMaster University. "Once we have widespread infections of humans, we're

in big trouble."

Dr. Angela Rasmussen, a virologist at the University of Saskatchewan. said she has been in discussions with US and Canadian officials about using vaccines to protect workers following the virus' spread into new mammal species.

Dawn O'Connell of the US Administration for Strategic Preparedness and Response said the government is "looking closely" at the possibility of vaccinating farm workers and others in close contact with the virus.

The US has contracts with CSL and GSK to test prepandemic vaccines that more closely match the circulating virus than older H5N1 vaccines in the stockpile. The US is moving forward with the CSL vaccine, a Department of Health and Human Services official confirmed.

Discussions about prepandemic vaccine use are going on at government levels and among scientists in a number of places, including in the UK, said Wendy Barclay, chair in influenza virology at University College London, who also researches avian flu for the UK Health Security

If deployed strategically to dairy farmers, healthcare workers and those in close contact with infected animals, "it would put a pin in the virus," she said, although she said it was not clear if this step was neces-

The UK government did not comment but said it is monitoring the situation in the US.

In Europe, the European Commission's Health Emergency Preparedness and Response Authority is working on a joint procurement of CSL Seqirus's vaccine to "potentially prevent a pandemic" sparked by individuals exposed to infected birds and animals, spokesman Stefan De Keersmaecker told Reuters.

A spokeswoman for CSL, which has contracts for pandemic influenza vaccines with 30 governments, take it."

said the company has been in talks with several governments about procuring vaccines since 2022. Those requests have accelerated with the US outbreak, she

### Prepandemic stockpile

The US maintains a stockpile of prepandemic vaccine candidates and bulk vaccine against an array of influenza strains and conducts clinical trials to support an Emer gency Use Authorization or FDA license in the event of pandemic.

Seasonal flu vaccine makers, including Sanofi, could also be asked to shift to producing pandemic flu vaccines.

The US is in talks with mRNA vaccine makers Pfizer and Moderna about potential pandemic vaccines.

Dr Richard Webby, a St Jude Children's Research Hospital virologist who studies flu in animals and birds for the World Health Organization, said the situation in dairy cattle merits vaccine use.

"If we look at the exposure levels that some of these farmers are getting, it's high," Webby said.

The decision on how and when to use the vaccine will hinge on evidence of increased transmission, severity of disease, cases in people with no link to a dairy farm and mutations in the virus, US Centers for Disease Control and Prevention Principal Deputy Director Nirav Shah said.

Dutch flu virologist Ron Fouchier of the Erasmus MC in Rotterdam, who has conducted experiments mapping the changes necessary for bird flu to spark a pandemic, said Europe's plan is to procure the CSL vaccine for people occupationally exposed to the virus. His lab could well be eligible if a vaccine becomes available, he said, adding, "I would certainly

"Today it is about infrastructure... There was a time when people used to say that India has talent, but regarding production here, they said 'Who will go there, extraction is very difficult, and sending raw material there is very difficult.' In the same India, today, 28 kilometres of highway is built every day, 14 kilometres of railway track is built every day, 8 new airports are built every year, every year new metro systems are built in 2 new metro cities," he added.

He also highlighted a 'positive exception' in India referring to PM Modi's popularity, stating that the other global leaders find it difficult to get re-elected for a second or third term.

"You can also see that there is a lot of instability in the political field all over the world. You will rarely see a country like this where democracy is so difficult. The first re-election of the Prime Minister or President is very difficult, let alone the second. So, we should first recognize that India is an exception, a positive exception in this world environment," Jais-

### **AU reiterates redoubling** continental efforts to realise conflict-free Africa

**ADDIS ABABA** 

THE African Union (AU) has reiterated the crucial need to redouble continental efforts to silence the guns in Africa and realize a conflictfree continent as it marks the 20th anniversary of the AU Peace and Security Council (AU-PSC).

To commemorate the occasion, the AU held a high-level colloquium on Saturday under the theme "20 Years of the AU-PSC as a Standing Decision-Making Organ: The Next Two Decades of the Peace and Security We Want in Africa" in Dar es Salaam, Tanzania, the AU said in a statement.

Addressing the high-level colloquium, Moussa Faki Mahamat, chairperson of the AU Commission, highlighted the council's major contributions in promoting and sustaining peace, security and stability across Africa.

"In the heyday of its development, the council has, over the years, established fundamental principles for continental peace and security," the statement quoted Faki as saying.

He said the intimate link between peace and development, the promotion of African solutions to African problems, the rejection of violent solutions to African conflicts, the promotion of mediation and political dialogue, the rejection of external interference, and the unwavering commitment to the independence, sovereignty, integrity and unity of African states have all become part of the collective imagination under the AU-PSC.

According to the AU, since its establishment on May 25, 2004, the council has been actively engaged in addressing peace and security challenges on the continent. It has made decisions that provide political guidance for conflict or crisis situations, including the deployment of peace support operations, high representatives, peace envoys and the Panel of the Wise for preventive diplomacy, which has led to the de-escalation of a number of crises across the continent.

According to Faki, soft cooperation between the AU-PSC and the United Nations Security Council has gradually been established, eventually providing greater visibility and recognition as a primary instrument in sustaining peace and security in Africa.

The AU Commission chief, however, underscored the urgent need to exert concerted efforts to silence the guns in Africa as a cornerstone for realizing a conflict-free Africa in line with the continental vision behind the establishment of the AU-PSC two decades ago.

He said one of the areas that need collective efforts in this regard is ensuring zero tolerance against unconstitutional changes of government across Africa.

He further called for strengthening continental cooperation against external interference. "As everyone knows, the guiding principle of this honorable organ was to ensure valuebased management of peace and security issues in Africa by Africans themselves.

The background to this was, and remains, the protection of member states against external interference, whether rival or ally," Faki said.

"The notorious lack of inter-African solidarity has left member states beset by insoluble demands for peace and security with no way out. Populism was unleashed, and unconstitutional changes of government quickly proliferated," he said.

According to the AU, the high-level colloquium serves as a unique platform for the council to assess its accomplishments and the challenges faced over the past two decades in discharging its mandate of promoting peace, security and stability in Africa.

## 40 killed in Israeli bombing on camp in Gaza's Rafah

AT least 40 people were killed and some others injured on Sunday evening in Israel's bombing of tents in northwestern Rafah, the southernmost city of the Gaza Strip, the Palestinian official news agency WAFA reported.

Israeli forces fired about eight rockets toward the tents in a newly established camp crowded with thousands of displaced people near the warehouses of the United Nations Relief and Works Agency for Palestine Refugees in the Near East (UNRWA), WAFA added.

Local sources told Xinhua that it

was a "severe and unprecedented" Israeli airstrike on the densely populated area of displaced families, igniting tents made of plastic and tin, as well as civilian vehicles. Video clips circulated on Facebook showed flames rising intensively in the area and fires engulfing tents still inhabited by many, including children and women.

The sources mentioned that the Civil Defense and ambulance crews face significant obstacles in retrieving the bodies due to the difficult terrain. Palestinian security sources told Xinhua that crowded with Gazans, the area had been classified by the Israeli military as a "safe area" before the strike. 

Hamas slammed the bombing as "complete defiance and disregard for the decision of the International Court of Justice (ICJ) that demanded it to stop its aggression against Rafah." 

German coach Hansi Flick is expected to be appointed as Xavi's successor this week.

Xavi warned of the struggle awaiting the next in line. "They should know that they've got a diffi-

cult situation, because Barca is a difficult club and there's an adverse financial situation too -- it won't be easy at all," he told DAZN.

"I think the work we've done has not been valued enough given the adverse situation we

"(Barca) were ninth in the table when we arrived, we finished second... (then) we won a double, and this year we weren't up to the standard but because of four key games."

Barcelona lost both matches against Real Madrid in La Liga and against third-place neighbours Girona, as well as one other match to Villarreal.

top scorer award.


Starting from this season, a tie-breaker system was introduced by the Tanzania Premier League Board, TPLB, to pick out a definitive winner.

According to the tie-breaker system, if two or more players finish with the same number of goals, three criteria will be used to ensure just one name is attached to the season's

If two or more players are tied on the same number of goals, the player with the lowest number of penalties will be deemed the win-

In the event that two or more players have scored the same number of goals and have the same number of penalties, the player who has played the lowest amount of minutes will win.

In the event that there is a tie on the above criteria, the player with the highest number of away goals wins the award.
