

IMF cash: Z'bar eyes 10 hospitals

ANZIBAR is set to build ten quality district hospitals and one regional ⊿hospital through the International Monetary Fund (IMF) emergency financial assistance to scale up health services across the Indian Ocean archipelago.

Zanzibar's Minister for Health, Social Welfare, Elderly, Gender and Children, Nassor Ahmed Mazrui, told journalists at the weekend that this is a major axis of expenditure of IMF funds handed to the ministry.

As part of measures to revive the economy after the Covid-19 pandemic stoppages, the Zanzibar government obtained 230bn/-

from the 1.3trn/- loan from IMF that will accelerate development in the Isles.

A total of 69bn/- has gone to the health ministry, he stated, noting that each of the proposed district hospitals will have 100 beds capacity, along with staff houses to accommodate 16 families.

In Unguja, the hospitals will be built in

Dunga and Makunduchi, while in Pemba they will be constructed at Micheweni and Kinyasini Wete, he stated.

The Zanzibar government will also construct a five-storey regional hospital at Lumumba in Urban West Region with capacity for 200 beds, he said, elaborating that .the

Chumbuni, Magogoni, Kivunge, Pangatupu, facility will feature an outpatient department, inpatient department and will be installed with magnetic resonance imaging (MRI) and Computerized Tomography (CT) scanners, to check the body for tumours).

As the premier acknowledged officials in attendance as per the protocol, he named the group, seated in the front row alongside religious leaders. Their seats were reserved and marked out, and the premier had kind words for the elders.

"Every time we have a function in Iringa, these elders are there and I'm told it won't rain here until this conference is over," he said, sending delegates into a long laughter amid clapping.

Mastercard prizes NMB pay by card leadership

THE government is embarking on an ambitious programme of updating all villages in the country into townships through improving infrastructures, basic facilities and community services.

Mohamed Mchengerwa, the Minister of State in the President's Office (Public Service Management and

Good Governance), explained here at the weekend that the government was heavily investing in projects targeting poverty, ignorance and diseases, and this time right from the village level. "We are building primary

and secondary schools as well as establishing colleges right at village level depending on particular residents' requirements. This also goes in tandem with improving infrastructure, power supplies and other basic needs,"

"We are turning villages into townships, in that everything that is available in urban areas will be made ac-

power through the spirits of our ancestors and our prayers get answered," said council chairman Augustino Motomkali.

"Before colonialism and introduction of new religions, we Africans had our way of praying and that is what we-a section of Hehe community– has maintained," he declared.

He said the group's working relationship with the government is not new, starting since the days of the Father of the Nation, Mwalimu Iulius

"Every time Mwalimu came to Iringa, we received him at the airport; he respected us a lot," the council chairman

underlined. Motomkali affirmed that seum at Kalenga.

all other presidents who followed respected their role and the elders have been taking part in key events attended by national leaders in the region.

Asked why this is unique to Iringa and if he would want to see other communities and regions set up such councils, Motomkali sounded somewhat subdued.

"Every community and region has their own way of life. I do not want to impose what Hehe people do to other communities," he responded.

The Hehe tribe has a peculiar mention in the history of Tanzania as its legendary paramount chief Mkwavinyika Munyigumba Mwamuyinga, known to the Germans and the British later as Mkwawa, put up a prolonged resistance against German pacification of the territory until being defeated and hanging himself in the 1890s.

Based at his Kalenga Fort in Iringa, Mkwawa's warriors dealt a German unit under a junior officer a blow, compelling imperial authorities in Berlin to send over Major Hermann von Wissman with a better equipped army unit, who crushed all remaining resistance from chiefs in Iringa, Tabora, Kilimanjaro and elsewhere.

Instead of surrendering like most war losers do, Mkwawa took his own life in 1898 to avoid the humiliation of being captured. Astonished at his resolve and ability to fight, the Germans severed his skull and moved it to Berlin until 1954 when it was returned. It now resides at the Mkwawa Memorial Mu-

Tanzania has more than 12,000 villages in rural areas that hold over 80 percent of the country's population. Around 10,000 villages are now connected to the national electricity grid, he

Regional Commissioner John Mongella said that Arusha has received 1.5bn/- during October. The first and second phases of TASAF projects executed from 2005 to 2015 benefitted two million people in Lindi and Mtwara regions, holding 5.3 percent of the country's population. In the third phase 743 projects addressing health, water, education and infrastructure development were executed in 13 districts across Arusha and Njombe districts, among others.

DEPUTY Minister in the Vice President's Office (Union and Environment) Hamad Hassan Chande has raised concerns over increased rate of deforestation, a situation which threatens the country's secu-

Chande said this recently when speaking is not controlled, our at the launch of the Sustainable Environmental Restoration and Biodiproject held in Mbeya.

Studies indicate that every year, Tanzania loses an average of approximately 469,420 hectares of forests and that loss has led to significant loss of biodiversity and the risk of extinction of some important species of plant and animal spe-

that deforestation still continues in many parts of the country. We will need 167bn/- to restore the environment, the amount that could be spent in development projects," Chande said.

He said Tanzania is estimated to have 48.1 million hectares of forest equivalent to an average of 51 percent of the total land area which has significant benefits in biodiversity conservation including biodiversity, water resources, helps reduce global warming and more it helps to keep the land fertile.

The deputy minister warned that the government will not tolerate any form of misconduct in the implementation of the environmental restoration and biodiversity project. He said the office of the Vice President will be at the forefront to ensure value for money at each of the specific projects to be implemented.

THE Bill & Melinda Gates Foundation, the Swedish International **Development Cooperation Agency** (SIDA), and UNICEF today announced a \$150 million financial guarantee to help UNICEF procure vaccines and other health-related supplies for low- and middle-income countries (LMICs).

This financing, effective through 2025, will help sustain national immunization programs, including COVID-19 vaccination campaigns, and enable the timely procurement of essential health supplies while domestic financing is mobilized.

Many low- and middle-income countries rely on UNICEF's procurement services to secure access to a wide array of affordable

of their emergency response and to meet routine needs. With the COVID-19 pandemic putting decades of work to improve child survival in jeopardy, this new financing will help improve the sustainable and reliable availability of essential and often lifesaving health supplies, such as diagnostics, syringes, and oxygen concentrators.

"The world cannot have a system in which supplies that are critical to improving the health of all people are auctioned to the highest bidder, forcing poorer countries to go without," said Chris Elias, president of the Global Development Division at the Bill & Melinda Gates Foundation.

The facility will offer specialized services such as ear, nose and throat (ENT) treatment, along with eye and dental clinics, while envisaged hospital facilities will be installed with incinerators.

"These hospitals will help to improve health service delivery and decongest patients at the Mnazi Mmoja Referral Hospital," the minister noted, explaining that continue to improve the Abdallah Mzee Regional Hospital in

"We will also build an

mortuary and digital X-ray, dialysis services, operation theatre room equipment and an oxygen plant to supply oxygen directly to the patient's bed," he explained.

Using the monies, the government will procure 12 four wheel drive ambulances to be distributed to district hospitals and two regional hospitals, while the government purchases five vehicles for distribution of drugs and medical equipment to hospitals and health centres, the minister noted.

"This will reduce transport cost as we are currently spending a lot of money intensive care unit (ICU), to hire vehicles from private firms. Having our own vehicles would also ensure safety of drugs and medical equipment," he stated. Drawings of all these

hospitals have been completed and procurement procedures are underway. Tenders will soon be announced to get contractors who will start implementing the projects early next month, and expected to be completed by mid next

All the health facilities are to be built by local contractors to stimulate Zanzibar's economy, thus local contractors need to grab these opportunity wisely, he added.

US celebrates 5 years of improving HIV, TB and family planning health services

REPRESENTATIVES from the United States government and Tanzania celebrated the achievements of the US Agency for International Development's (USAID) Boresha Afya ("Better Health") North-Central and Southern Zone activities.

Through strong collaboration and enduring partnership with the government of Tanzania, the \$222 milliondollar, five-year Boresha Afya activities improved health outcomes for millions of Tanzanians in 12 regions across the country.

HIV, malaria, and tuberculosis (TB) are among the leading causes of illness, disability, and death in Tanzania. The lack of access to maternal/child health and family planning services for Tanzanian citizens, especially for women and adolescents, also contributes to poor health. Too many Tanzanians are unable to access high quality, inclusive health services, with limited coordination between facilities and communities resulting in inadequate support for patients.

Over the last five years, the Boresha Afya activities employed dynamic and innovative solutions to address these challenges. The activities' primary ob-

jectives were to increase the availability of- and improve access to- quality health services at the community level. To achieve its objectives, the activities combined HIV services with sexual/ reproductive health, TB, and family planning services, and coordinated between health service providers, and communities.

As a result of the Boresha Afya activities, over 8.3 million Tanzanians received HIV testing services of which nearly 340 thousand learned their HIV positive status.

All HIV positive patients were enrolled on life saving antiretroviral treatment. Furthermore, Boresha Afya reached over 10 million clients through the provision of family planning outreach services.

Speaking at the event, USAID Mission Director V. Kate Somvongsiri addressed the guest of honour, Minister of the President's Office for Regional Administration and Local Government, Ummy Mwalimu.

"Honorable Minister, we hope the achievements highlighted in this meeting will encourage your ministry to maintain an enabling environment that will continue to support an integrated approach to health services delivery for all Tanzanians so that these achievements can be sustained."

Minister challenges graduates to venture into their own businesses

INDUSTRY and Trade minister Prof Kitila Mkumbo has challenged graduates to start their own businesses after they complete their studies instead of wasting time searching for white collar jobs in government and private sectors.

Prof Mkumbo threw the challenge over the weekend in Dar es Salaam during the 56th Business College of Education (CBE), graduation ceremony.

The minister said every year over 800,000 students graduate from different universities all over the country so there is no room for all of them to get employment from either government or private sector suggesting that the only solution is to be creative and start their own busi-

"Employment opportunities in government are very limited and we have thousands of graduates each year so the important thing is for you to be innovative and begin you own things. There is

no employment but there are many things you can do by using the skills you have acquired here," said Prof Mkumbo.

He also said that the government recognizes the importance and achievement of the college and also the infrastructure challenges they face but plan are underway to solve them so that the college can run smoothly.

He argue the college management to emphasize on business training for the students, provide short courses for none students and conduct researches which will solve some challenges in business sector.

He said government recognizes the importance of business education in the country's development and the vivid examples are the developed countries like Brazil, Russia, India, China and South Africa which have invested a lot in modern technology and business educa-

Professor Mkumbo said entrepreneurship skills need innovation and participation from others so that it become very easy to reach the intended goals adding that there are abundant opportunities like lakes, ocean, rivers, minerals and natural resources which can be used to create wealthy.

On his part, the CBE Rector, Professor Emanuel Mjema said apart from the increments of the number of courses at the college, they have continued with their development plan to ensure that the college becomes number one in education provision among universities.

He said they provide education by looking at the market demand adding that they have continued to sponsor their lecturers to reach the level of (PhDs) by using internal funds.

Professor Mjema said CBE have 35 lectures with PhDs and still they plan to ensure that many lectures go for more studies adding that currently the college has sponsored 43 lectures to pursue their PhDs studies and other 11 to study master's level.

Professor Mjema asked the government to continue to sponsor the college lectures so that they can be able to advance their carries to the level of PhDs which is important in higher learning institutions.

Professor Mjema also said CBE face the challenge of funds for research activities, but he thanked the government for paying salaries to all college staff.

"This is very important contribution to our college which ensure that CBE as institution run smoothly and that main thing we are doing here is teaching, doing researches and doing consultancies," he said

The Government of Tanzania, through the President's, Office Regional Administration and Local Government (PO-RALG) and the Ministry of Works, Transport and Communication (MoWTC) is in preparation phase of the Msimbazi Basin Development Project with financing of the International Development Association (IDA) credit (i.e., the World Bank). The project will be implemented by Tanzania Rural and Urban Roads Agency (TARURA) and Tanzania National Roads Agency (TANROADS) on behalf of the respective ministries mentioned above.

The project intends to undertake the following:


- 1. Flood Protection and Prevention: Drainage and flood water containment works to enhance river discharge capacity and eliminate spillover into surrounding neighborhoods (to be implemented by PO-RALG) will include strengthening riverbanks at critical locations upstream for erosion control; sand traps at strategic locations upstream; creation of land terraces in the lower Msimbazi flood plain; flood protection and multiple use terraces infrastructure, sites and services for use as wetland park, multi-use recreational area and commercial and housing redevelopment; downstream and upstream river maintenance depots; resettlement of flood affected communities; dredging and widening of the river channel.
- 2. Resilient Transport Infrastructure: Upgrading of transport infrastructure to accommodate increasing intensity of rainfall events and increased storm water runoff resulting from rapid urban development in wider catchment. This includes raising and widening of Jangwani Bridge (to be implemented by TANROADS) and Upgrading/Rehabilitation of roads and bridges to improve mobility while reducing erosion and flooding risk (through greening and other erosion reduction measures) linking with Msimbazi Valley (to be implemented by PO-RALG-TARURA).
- 3. Erosion/Sedimentation/Litter Control and Urban Greening: These measures are intended to protect against clogging of river channel due to erosion/sedimentation and solid waste dumping - and will be delivered in part through a public works campaign that provides training and employment for women and youth (to be implemented by PO-RALG). Activities include reforestation of upstream forest reserves; urban greening along riverbanks and tributaries via public works campaign; revitalization of mangrove area; reinforcement of riverbanks in middle and upper basin (main channel and tributaries); solid waste management collection and litter control program; and routine sediment removal and management.
- 4. Urban Planning, Services and Management: Interventions to implement and sustain the land uses identified in Msimbazi Opportunity Plan (MOP) as appropriate for each respective terrace level in lower Msimbazi Basin and strengthening of city-wide emergency response. This includes participatory land use planning for Msimbazi Special Planning Area within upper and middle basin; and strengthening its development controls as well as management of public urban park in Lower Basin.

This is to notify the public and all stakeholders of the Msimbazi River Basin that a team of experts from the implementing agencies, in collaboration with consultants for carrying out feasibility study, preliminary design and detailed engineering design, environmental and social safeguards will be consulting stakeholders using various methods that include meetings, interviews and questionnaires. Dates and venue for consultation will be communicated accordingly. It should be noted that all COVID-19 protocols will be observed.

Tanzania wins accolades for putting in place national plan of action for ending violence against women and children

TANZANIA has won praise for putting in place a National Plan of Action to end Violence against Women and Children.

The observations were made in Geneva during the 39th session of the Universal Periodic Review Working Group held in Geneva on November 5, 2021.

In her comments, Norway said Tanzania's action to implement a National Plan of Action to end Violence against Women and Children was recommendable.

For her part, Korea commended the move by Tanzania to implement the Plan a move she said will help to combat violence against women and children.

In her recommendations, Namibia called upon Tanzania to strengthen planning, budgeting and institutional mechanisms at the national and sub level to ensure effective implementation of the plan.

For her part, Spain called upon Tanzania to set aside adequate resources for the National Plan of Action to End Violence against Women and Children to strengthen the fight against child and forced marriages.

In 2016, the government in collaboration with various stakeholders managed to put in place The National Plan of Action to End Violence Against Women and Children 2017/18 - 2021/22 to eliminate all forms of violence against women and children in Tanzania.

Among the priority areas of the National Plan is to encourage and support women and children to stand against violence wherever and whenever they see it and effectively engage men in the process.

The National Plan of Action to End Violence Against Women and Children 2017/18 - 2021/22 seeks to modify harmful gender norms that perpetuate harmful traditional practices such as FGM and child marriage.

The report further indicated that most children do not report their experience, few seek services, and even fewer actually receive any care, treatment, or support if they do report

According to the 2010 Demographic Health Survey, 39 percent of women aged 15-49 have ever experienced physical violence since age 15 and almost one-third of women (33%) aged 15-49 experienced physical violence in the 12 months prior to the survey.



He appealed to other development partners to support the government's efforts towards improvement of health services.



THE African Union Mission in Somalia (AMISOM) has confirmed that two of their soldiers have been sentenced to death for killing Somali civilians.

In a statement, the peacekeeping mission said the two soldiers and three others handed 39 years in prison will be repatriated from Somalia to Uganda to serve their sentences

"As soldiers, we have a responsibility to protect lives and property. Our mission in Somalia is to degrade Al-Shabaab and other armed groups. In doing so, we absolutely have every responsibility to protect the civilian population, and this is very clear in our Rules of Engagement," said the Ugandan People Defence Force Contingent and AMISOM Sector 1 Commander, Brig. Gen. Don Nabasa.

The Head of AMISOM, Francisco Madeira, thanked the Government of the Republic of Uganda and the Federal Government of Somalia for their co-operation and support. Ambassador Madeira deeply regrets the killing of the civilians and has, once again, conveyed his and AMISOM's condolences to the bereaved families for the tragic incident.

"As a Mission, AMISOM remains deeply committed to the cause of peace, security and stability in Somalia and the protection of the local population in strict respect of International Humanitarian Law (IHL), International Human Rights Law, and AMI-SOM rules of Engagement. He said if Morogoro District Council was able to allocate 30m/- for finishing construction work of girl students at the school, it should also dish out funds for building the pit latrines.

For his part, the district executive director Rehema Bwasi assured the RC that she will allocate the money for the pit latrines construction at the school.

Earlier, the assistant headmaster of the Mkuyuni secondary school, Reward Kihedu said the school has more than 900 students and 20 teachers, but added that the main problem was the lack of pit latrines, saying they had only one pit latrine for the entire school.

New policies needed to promote agroforestry

vironmental degradation if countries put more effort into promoting agroforestry, an integrated approach combining trees with crop or livestock production.

The agroforestry sector is a significant source both of local commodities such as fuel wood, timber, fruit and fodder for livestock as well as global ones such as coconut, coffee, tea, rubber and gum. Almost half the world's agricultural land has at least 10 per cent tree cover, making agroforestry critical to the livelihoods of millions.

Agroforestry is a land use management system in which trees or shrubs are grown around or among crops or pastureland. This diversification of the farming system initiates an agroecological succession, like that in natural ecosystems, and so starts a chain of events that enhance the functionality and sustainability of the farming system. Trees also produce a wide range of useful and marketable products from fruits/nuts, medicines, wood products, etc.

This intentional combination of agriculture and forestry has multiple benefits, such as greatly enhanced yields from staple food crops, enhanced farmer livelihoods from income generation, increased biodiversity, improved soil structure and health, reduced erosion, and carbon sequestration. Agroforestry prac-

Millions of people could es- tices are highly beneficial in the cape poverty, hunger and en- tropics, especially in subsistence smallholdings in sub-Saharan Africa.

> In 1966, the International Covenant on Economic, Social and Cultural Rights established that, adequate food is a human right. This effectively made access to, and affordability of adequate food a universal human right and protected in the rights instruments. And international cooperation plays a key role in guaranteeing a fair distribution of food. Over the years, concerted efforts have been made towards realizing food and nutrition security for all.

> The right to food is the focus of Goal 2 of the UN's 17 global Sustainable Development Goals (SDGs). Achieving Zero Hunger is still elusive! World hunger has increased since 2014.

With the outbreak of the coronavirus pandemic, the world is now potentially facing the worst hunger crisis in 50 years. Target 2.1 of SDG 2 states that by 2030, we should have eradicated hunger and be able to guarantee all people access to sufficient, nutritious food, all year round. We are now at the beginning of the last decade to the SDGs timeline. Despite this, the UN projects that hunger will not be eradicated by 2030 unless bold actions are taken to address inequity in access to food.

In September 2020, the UN announced that the world is "far from the target" and is rather trending towards a "deterioration".

Glasgow final act points at policy gaps needing resolve

DURING late hours of Friday 12th November, the final day of the United Nations climate change conference (COP 26) in Glasgow in the United Kingdom, a few things had clearly emerged that showed inability to move to 1.5degrees Celsius temperature rise instead of 2.7 degrees that experts say the world is on track to registering late this century.

Not everyone could come on board as to ending the use of coal in power generation, and the countries with the biggest populations, China and India, were pointedly unable to commit themselves to phasing out coal, urgently. Even mentioning fossil fuels was a problem.

An announcement by the delegations of the United States and China of putting aside other differences to work on climate issues signaled substantial areas of accord, for instance spreading new technologies especially for motor vehicles, trains or airplanes.

Some headway was also being made on financing efforts of developing countries or poorer countries for that matter, but efforts to make climate adaptation an issue for global financing rather than national budgeting weren't making much headway.

Massive devastation from cyclones, floods or bushfires will not be compensated by global lenders at any point now or

When it comes to what countries can do to tackle effects of climate change, it is quite evident that the more a country's economy has been reformed to march in tandem with global capital flows and private investments, the more it is capable of taking up technologically advanced energy sources, etc.

This for instance can be cited with regard to India's power production where up to 70 per cent is said to be using coal sources, which is also a massive employer with thousands of labourers carrying coal on buckets put on the head to power stations nearby. Altering this needs massive capital outlays which India can't put up.

The same is noticed in Africa where large peasant populations tiring the soil and cutting down trees for charcoal and firewood need to be reengaged in an urban services economy and industries for land to re-

Government revenues are tied down to servicing drawn out village locations for roads, water, electricity and health centres, and no surpluses remain to do massive reforestation countrywide, and make sure the trees grow, if water is ferried there by trucks, etc.

NGOs are doing what they can in league with local governments; indeed many places have become greener, but water sources are rapidly de-

Thus the calls for changing power generation sources or altering land use to stem deforestation clashes with traditional ways which can't be effectively altered unless these units (energy, agriculture sectors) are part of global flows of capital, can be bought and

Then their technological preferences would be altered as companies with equipment lying in stock without a buyer would take up the firms or land to start using it differently. But countries identify themselves with public ownership, specific patterns of land use and settled populations, unquestionably.

Nigeria needs industrialisation, not infrastructure

INDUSTRIALISATION is the solution to the myriad of problems confronting Nigeria. Great minds build great nations. Great minds listen and learn so as to increase their understanding. They are knowledgeable and are wise. They enjoy the grace of discernment. Many people agree that Lee Kuan Yew, founder of modern Singapore and Mao Zedung of the Peoples' Republic of China were men with great minds. Lee Kuan Yew industrialised Singapore speedily. Mao Zedung initiated the rapid industrialisation of China in 1949. Today, China is a world power. Yew and Zedung did wise things; they imitated things history and science had demonstrated lead to success. One who imitates success cannot fail woefully.

Nigerians agree that Nigeria is faced with myriad of problems especially mass unemployment, poverty, insecurity, indebtedness. Our decades-long curiosity-driven research results showed that it is industrialization that Nigeria needs, not mere erection of infrastructure. What is industrialisation or industrial revolution (IR)?

IR or industrialization in modern history is the process of change from an agrarian and handicraft economy to one dominated by industry and machine manufacturing. The Western industrialisation began in Britain in the18th century. Whereas the term IR was first used by French writers, it was popularized by the English economic historian Arnold Toynbee (1852-83) who used it to describe Britain's economic development 1760-1840.

The features of the IR were technological, socio-economic and cultural.

The technological changes were: the development and use of new basic materials, chiefly iron and steel; use of new energy sources, including both fuels and motive like coal, the steam engine, electricity, petroleum and internal combustion engine; invention of new machines like the spinning jenny and powered looms which facilitated increased production; the emergence of a new work organizational structure known as the factory system which entailed division of labour and specialization of functions; development of advanced transportation and communication systems like the steam locomotive, steamship, automobile, airplane, telegraph, radio; the increased use of theoretical science in production; application of science and technology to improvement in agricultural productivity. These technological changes led to tremendous increase in production of goods.

The socio-economic, political and cultural changes consequent to the scientific and technological changes were many. Some of them were: high demand for labour, child labour; decline of land as wealth and power; wider distribution of wealth; increase in international trade, shift in political power and state policies due to shift in economic power; growth of cities; growth of modern infrastructure; development of working-

class movements (labour unions); workers' acquisition of new skills they became machine operators, no more tools craftsmen and subjected to factory discipline; and great increase in government's revenue.

The region occupied by modern Western Europe was the ancient Gaul. Ancient Gaul was harnessed into the Roman empire in 55 B. C. The western part of the empire broke-up in 406 A. D. From the ruins of the empire, the boundaries of most of the nations in Western Europe today became defined in the period between the 10th and 13th centuries. When Britain achieved the first modern IR, the roads in Britain were still the ones built by the Roman Empire. Following the industrialisation, the nation quickly built canals, railways and other modern transport systems. Agricultural/artisan Britain did not borrow and accumulate debts to erect complex infrastructure before achieving industrialization.

Following the Revolutionary War (1775-1783) in which the Americans colonists became independent of Britain, the Americans wrote the popular American constitution in 1787, adopted it in 1789 and transformed the confederation into the American federation. Britain was clearly more technologically advanced at that time. America did not award big contracts to Britain or Britons to erect complex infrastructure for America so that America can achieve effortless development overnight. Morrison (1974), narrated the American experience in developing infrastructure in the 18th century. By 1790, there were many thriving communities in south New England. It soon became clear that roads wide enough for a yoke of oxen and forest trails for men on foot were insufficient means for the kind of transport such an expanding territory required. It was also apparent that the solution to this problem did not lie in building a network of roads to tie the various parts of the region together. This, the Americans believed would cost a great deal to build and present a continuing difficulty of maintenance. So, a search was made for a reasonable alternative. New Englanders turned in time to watercourses that existed and focused on building canals. The Chinese IR which began in 1949 was again internal.

The Western industrialization which began in England was first manifested in the textile industry. Textile manufacture involves three major activities: spinning of fibers into yarns(s), weaving of yarns into cloth(w) and bleaching/dyeing of fabric(b/d). Eight major scientific and technological inventions and innovations related to textile manufacture improved productivity dramatically in Britain.

They were: One, Hargreaves spinning jenny, invented 1770 to automate spinning(s); two, Arkwright water frame(1771/s); three, Crompton's mule (1799/sw); four, Cartwright's power loom (1785/w); five, Watt's steam engine (1769/sw); six, Berthollet's/Tennant's chlorine bleaching activity (1785/bd); seven, Maudlay's screw-cutting lathe (1797); and 8) Eli Whitney's interchangeable manufacturing practice (1798).

Six of the eight major innovations were developed in Britain. Britain was therefore scientifically most prepared for the industrialisation hence it took place first in Britain.

Thus, in the period between 10th century to 1750, the economic activities of the English and Britons were mainly subsistence agriculture/artisan-industry devoid of theoretical science and marked by very low productivity. But the situation changed as from 1770 when Britons achieved scientific/technological maturity or technological puberty. The great scientific/technological developments occurred in the short period 1770-1799, about 30 years, after a very long time of preparation.

From the developments described above, industrialisation or IR is primarily a scientific process. This explains why economists and other social scientists, accountants, bankers, lawyers, etc., who have been playing central roles in the management of the Nigerian economy cannot promote sustainable economic growth and industrialization (SEGI). Sadly, industrialisation is the solution to the myriad of problems confronting Nigeria. Whereas Lee Kuan Yew and Mao Zedung were not scientists, they through providence and good advice, did scientific things. They mobilized their people for learning and industrialisation. They did not just erect infrastructure.

Our research results also showed that infrastructure is depreciating asset which when erected today is not there tomorrow. Is that not our experience? Learning is the primary basis for achieving SEGI.

The more the people mobilized for learning the sooner a nation achieves industrialisation. Japan mobilised all her citizens 1886-1905 and achieve industrialisation. China mobilised all her citizens for learning in 1949 and achieve industrialisation in the early 1980s.

Mobilising all Nigerians for learning (education, training, career employment and research) and industrialisation is the sure route to making Nigeria a great nation.



Attack on Justice Odili: 'Judiciary had it coming, and must now redefine its future'

N Friday October 29, 2021, armed operatives from different law enforcement and security agencies stormed the official residence of Supreme Court Justice, Hon. Justice Mary Peter-Odili CFR, (pictured) to execute a search warrant issued by an FCT Chief Magistrate. The Supreme Court has described the incident as a "dehumanising treatment". Law enforcement and security agencies, whose operatives participated in the incident have denied that they were part of it, while the Inspector General of Police has reportedly set up an investigation. On discovering that the search warrant signed was used for the search of a Supreme Court Justice, the Magistrate who signed the warrant reportedly revoked it unilaterally.

Reacting to the incident, the Supreme Court, through its Director of Information, Dr Festus Akande, warned that the Judiciary should not be misconstrued by any institution of Government as the "weeping child among the other arms of Government". This response is probably the strongest remonstration against actions of a Government targeted at the Judiciary, there has been. The Judiciary further said that, it has had "a full dosage of this fusillade of unwarranted and unprovoked attacks on our judicial officers and even facilities across the country, and we say it loudly now that enough is enough".

Is this Another Straw in the Wind?

This case has familiar resonance with the past, and anyone familiar with the shenanigans of this Government, can pick the signals of what is likely cooking from afar. Nigeria's President has hardly hidden his politics on the Judiciary. His desire has been to "reform" the Judiciary, and he has often spoken about how the Judiciary has frustrated him again and again,



both before and after he became President. Mr President's reform mantra however, simply provides a peg on which to hang motives that are both parochial and possibly bigoted, but clearly less than altruistic - and it is to forge a new Supreme Court whose loyalty he can count on.

We see this in the way the Presidency recently arm-twisted judicial authorities into recommending Justices favoured by it, for appointment into the Supreme Court. It should, of course, be remembered that the Presidency withheld its approval of four recommended Justices of the Court for about a year - apparently not for any legitimate cause - but so that judicial authorities would "do the right thing"; he only made the appointments just as soon as he thought the "right" people were added to the list, and recommended to the President for appointment. This was in spite of the fact that, over a long period at that time, the Supreme Court was being crushed by the weight of its workload given its lean workforce.

With this regime, it seems reasonably obvious that no barrel is too deep to be scraped once the line has been drawn, and that is why we must ponder, with some trepidation, what the "search" of Justice Mary Peter-Odili's house represents. And, we wonder, because the parallels with past incidents concerning "marked" Su-

preme Court Justices are strikingly familiar. Not too long ago, following "whistleblowing" by an "activist", former Chief Justice, Walter Onnoghen, was ignominiously removed from office, in the most imponderably blatant way.

It may be that this search is a prelude to something more ominous, and, were it not, one would have expected that the body language of the Presidency would be different. The Presidency has, not unsurprisingly, been mute over the harassment of a senior Justice of the Supreme Court. So, we may not have heard the last of the matter.

A Long Road to Perdition

How did we get here? Not even in the despotic haughtiness of military rule was the Supreme Court so disparaged. Why are Supreme Court Justices - and in fact, the entire Judiciary - at the receiving end of repetitively disrespectful and sometimes ruthless behaviour from the Executive? This, after all, is a constitutional democracy, and the branches of Government are independent and ought to enjoy some form of co-equal respect from each other.

It is hardly possible to separate what is happening to the Nigerian Judiciary from the state in which the Judiciary is at the moment, and some may, in fact, interpret this and other events of the last few years, as prophesies foretold. But, we did not arrive here overnight.

Over the course of many years, a once highly-rated Judiciary across the Continent (and notwithstanding the adulatory forms of expression and clichés we apply in composing our protocols for our Judges every time), gradually lost its sparkle, stature and authority. And, then failed to do much to rebuild and reinvent itself. In the absence of hard political power or the authority of its "soft" power, the Judiciary simply became a vulnerable target of predatory Executive power, of the sort this administration is well skilled at.

A weak Judiciary will likely avoid confrontation with Government, and in doing so, shy away from enforcing the rule of law or individual rights, if acting so will place the courts in the crosshairs of Government. In other words, a weak Judiciary will largely be unable to enforce constitutional limits on governmental power, and, even

where it barks, will not bite. Judiciary's Indulgence of Impu-

nity has a Role to Play?

But, there are also social and governance costs of being impassive. The rule of law will always be in danger as long as courts are not spirited in its defence, and while labels - whether "conservative" "moderate" or "liberal" - can count on occasion, they ought to be of no importance when it comes to safeguarding the rights of citizens.

A weak Judiciary too, will not likely receive much political support from civil society if it runs into confrontation with the Executive, because of trust deficits in society's perception of the judicial institution. Where a Judiciary will not enforce citizens' rights, alongside its authority when Government flouts its orders and judgements, and is ever so ready to accommodate impunity in order not to appear confrontational, it loses its moral

capital, and is perceived more as an appendage of Government than a bulwark of liberty. And, civil society will legitimately ask: if the Judiciary will not be there for them in times of trouble, why should they be there for the Judiciary in times of its distress?

Other Constitutional Judiciaries Rising to the Occasion

A Judiciary must be ever so ready to fight for the rule of law no matter how bruising that struggle is, and Judiciaries of constitutional democracies have known that there will be times when their strength, independence and authority are tested. Indian courts have a storied history of resisting efforts by government to control it, whether it be in terms of appointing Judges, or allocating budgets to courts, or enforcing mandatory orders against government. The Indian Judiciary enjoys considerable global respect, today.

Of Palestinian anguish and selective application of international law

HE global arena in which state and non-state actors interact is anarchic.Anarchy is the idea that the world lacks any supreme authority or sovereign.

In an anarchic international system, there is no hierarchically superior, coercive power that can resolve disputes, enforce the law, or order the system of international politics.

International law, which is a system of treaties and agreements between nations that govern how nations interact with other nations, citizens of other nations, and businesses of other nations becomes handy in an anarchic international system.

This is because it supports global order and the attainment of humanity's fundamental goals of advancing peace, prosperity, human rights, and environmental protection.

By becoming parties to international treaties, States assume obligations and duties under international law to respect protect and fulfill human

The obligation to respect means that States must refrain from interfering with or curtailing the enjoyment

of human rights. When a state violates international law, it may be subject to diplomatic pressure, or economic sanctions.

Other states may also adopt unilateral sanctions against those who flout international law provisions. In some cases, domestic courts may

render judgment against a foreign creation of the Israeli state, the United state for an injury.

While this sounds very logical on paper, the enforcement of international law leaves a lot to be desired.

Selective application of the law has been the order of the day and this has resulted in a sad situation where the powerful trample upon the law without any consequences.

Article 2(1) of the United Nations Charter provides that: "The organisation is based on the principle of the sovereign equality of all its members," but a different situation plays out on the ground.

States like the United States enjoy hegemonic status and use their standing as a superpower to dominate other smaller states.

Those that bandwagon with the superpower also exhibits bullish tendencies to states not be singing from the same hymn book with the hegemony.

The story of Israel and Palestine easily comes to mind.

Israel has been a long-time ally of

the US which explains why the latter has played a key role in the decadeslong Israel-Palestine conflict.

US has assisted with arms, financial support and UN vetoes.

On the military front, since the States has provided US\$146 billion in foreign aid, nearly all of it militaryrelated, as of November 2020.

It currently provides US\$3.8billion

per year in military aid to Israel. Research has shown that the United States is the largest seller of weapons to Israel, whose military arsenal now includes 362 US-built F-16 warplanes and 100 other US military aircraft, including a growing fleet of the new F-35s; at least 45 Apache attack helicopters; 600 M-109 howitzers and 64 M270 rocket-launchers.

Some of these weapons have been used to launch attacks on Palestine and the United Nations, the custodian of the UN charter has not reined in

This is despite Article 2 (4) of Charter providing that: "All members shall refrain in their international relations from the threat or use of force against the territorial integrity or political independence of any state, or in any other manner inconsistent with the purposes of the United Nations."

The purposes of the UN include peaceful settlement of international disputes in such a manner that does not endanger international peace and security and justice.

es unprovoked attacks on Palestinian civilians violating international humanitarian law principles the UN replies with its customary response-

This is despite the fact that international law, through 159 Articles of the Fourth Geneva Convention protects civilians in areas of armed conflict and occupied territories.

The Articles theoretically safeguard civilians from murder, torture or brutality, and from discrimination on the basis of race, nationality, religion or political opinion but realistically, Palestinians have not enjoyed this protection.

They have borne the brunt of inexorable Israeli attacks and further compounding the situation is the fact that instead of playing a role in solving the conflict as the 'laboratory of democracy' in the words of Alexis de Tocqueville, US has been protecting Israel.

Washington has exercised its veto in the UN Security Council 82 times, and 44 of those vetoes have been to shield Israel from accountability for war crimes or human rights viola-

In every case, the US has been the lone vote against the resolution, al-However, whenever Israel launch- though a few other countries have occasionally abstained.

> This has contributed to a climate of impunity and exacerbated the cycle of violence affecting both Palestinians and Israelis.

> An April 2021 Human Rights Watch (HRW) report titled A Threshold Crossed: Israeli Authorities and the Crimes of Apartheid and Persecution noted that Israel is guilty of two crimes against humanity in the Occupied Palestinian Territories (OPT) which are: apartheid and persecution.

According to Article 7(2)(g) of the Rome Statute, persecution involves "the intentional and severe deprivation of fundamental rights... by reason of the identity of the group," including on racial, national, or ethnic grounds.

The discriminatory widespread confiscation of privately owned land such as that attempted in Sheikh Jarrah is an example.

In February 2021, the International Criminal Court (ICC) ruled that it had jurisdiction to investigate Israel's alleged war crimes in OPT because crimes against humanity have a peremptory status and Article 53 of the Vienna Convention provides that states are not permitted to derogate from these provisions and must ensure that they comply with their ob-However, despite Israel being in

grave and serious breach of international law provisions, nothing has been done to bring it to book. The world cannot continue to pay a

deaf ear to the cries of the Palestinian people and a blind eye to their teething troubles.

The UN should develop teeth and ensure that war crimes against Palestine are not perpetuated.

The role of the UN in the conflict varies from impotent to accomplice to broker and more over the decades.

It was both venue and player in the complicated international diplomacy that led to the partition of Palestine in 1947 and the creation of the state of Israel in 1948.

It is high time the organisation steps up as noted by Professor of Modern Arab Studies at Columbia University Rashid Khalidi and come up with solutions that do not result in the "dead letters" of Council resolutions on the Palestine problem that have been systematically disrespected since the founding of the United Nations.

COTUL urges academicians to promote reading culture to boost knowledge, skills

ACADEMICIANS, students, researchers, librarians have been challenged to imbibe a reading culture to boost knowledge and skills in their areas of specializations.

Consortium of Tanzania University and Research Libraries (COTUL) deputy secretary, Abbas Mohamed Omar made the call here yesterday when speaking at the ongoing 3rd COTUL Scientific Conference and Workshop 2021.

Omar said: "It's high time for people in the education instituting to inculcate a reading culture of various books,

research papers and other learning materials as a good way of a proper use and utilizing of the resources."

"We're working hard to ensure that academic journals, research findings papers, and books are digitized so that they can offer creative possibilities for expanding access as well as changing learning, teaching and research; but one of the main challenge is utilization of the resources, particularly e-resources."

"Purchasing of the e-resources database is very expensive that's why COTUL has joint-efforts to buy them through various university members, but one of the challenges we have experienced is the low utilizations and uses of the resources in our country compared with other developed countries," he explained.

COTUL has purchased e-Resource Database like Emerald and Ebsco using a very limited funds from some subscription fees and dues from its members, appealing other higher learning institutions and research centres who are not members of the Consortium for sustainable utilization and uses of the academic journals, research findings papers, and books both analogy and digitally.

COTUL Executive Secretary,

Dr Vincent Msonge said that to date his institution has a total of 105 member whereby 75 of them are active members.

He named some active members as University of Dares-salaam (UDSM), ARDHI University, Saint Augustine University of Tanzania (SAUT), Sokoine University of Agriculture (SUA), Mzumbe University, State University of Zanzibar (SUZA), Tumaini University, and Zanzibar University (ZU), among many others.

Moshi Cooperative University (MoCU) Deputy Vice Chancellor (Academic) Prof John Safari said that there are many good research findings journals, books and papers in hardcopy form that need to be transformed in an e-resources format.

According to Prof Safari, new technologies have always been of interest for libraries both for the potential of increasing the quality of service and for improving efficiency of operations, and at present libraries of all kinds whether public, research academic or special libraries are overwhelmingly looking forward to adopt new technologies mostly use of eresources due to its potential for cost savings in operations and the management of collections and Patrons.

"E-Resources are digital objects containing electronic representation of books, journals and other form of reading materials and they are converted into a digitized form in order to be read by a computer. Many Library resources are now available electronically and can be access via the web. You can get the information you want, when you need it, 24 hours a day, 7 days a week," he explained.

"As Academician I know there are so many good learning materials you can find in our libraries in various higher learning institutions that are in form of hard copies that cannot available electronically, so my challenge for all of us here is to create awareness on the importance of using e-resources for sustainable availability of our learning materials Worldwide through digitization," Prof Safari insisted.

"The development of computer and network technology is changing the education pattern and transforming the teaching and learning process from the traditional physical environment to the digital environment. Modern academic libraries, a conglomeration of printed books and journals as well as electronic resources (e- resources) where both forms of documents can be stored, retrieved and delivered as and when required,"

Despite the deluge of net zero pledges in the build up to COP26, new fossil fuel production could take global heating way beyond the goals of the Paris Agreement.

According to the most recent data, governments are planning to produce 57% more oil, 71% more gas and 240% more coal than is consistent with a 1.5°C target by 2030. To even have half a chance of keeping 1.5°C alive, at least 60% of oil and gas and 90% of coal must remain in the ground, never to be burnt. Our survival is worth better odds than a

vast amounts of wealth from fossil fuels, over centuries, that are unwilling to give up their fossil fuelled privilege, ignoring overwhelming evidence that we need to phase out fossil fuels rapidly. Many of these nations are also the loudest and proudest self-declared climate leaders. They talk the talk on reducing domestic emissions, while driving global emissions growth through continued fossil fuel production and exports. Some of the countries most

guilty for this offense are the "Fossil Fuelled 5" - Australia, Norway, Canada, the United States and the United Kingdom. This is a wealthy group of countries that are burning our collective future.

Coal, oil and gas production must fall globally by 69%, 31% and 28% respectively between now and 2030 to keep 1.5°C alive.

The Fossil Fuelled 5, however, are set to increase oil and gas production by 33% and 27% by 2030. While coal production amongst these countries is set to drop, it will drop by only 30% - less than half of what is needed to stop temperatures breaching 1.5°C.

Underlying the gap between rhetoric and action on fossil fuel produc-

Their economies are also incredibly diversified meaning that they are not solely reliant on fossil fuels for future prosperity. In other words, they have the wealth and capacity to move markets and transition fossil fuel industry workers with relatively limited disruption, but they still continue to approve pipelines, grant subsidies and pass out licenses.

Instead, they must be doing the exact opposite: halt further licensing, phase out existing extraction, end financial support for fossil fuel production without caveats and redirect that financial support toward helping developing countries move towards clean energy.

They should also formalise their climate leadership by joining initiatives such as the Beyond Oil and Gas Alliance and the Fossil Fuel Non-Proliferation Treaty.

If we are serious about keeping 1.5°C alive and preventing the worst impacts of the climate crisis, we must address the root of our collective problem: fossil fuels.

For that, we need true policy leadership - not just press releases - from wealthy nations like the Fossil Fuelled 5 to put an end to fossil fuel expansion, start phasing out of existing stockpiles and jumpstart a just transition before it's too late.

Local currency stable against major currencies:BoT report

THE Tanzanian shilling remained relatively stable against major international currencies as of September this year thanks to steady greenback inflows from minerals exports, manufactured goods, cereals and horticultural prod-

Bank of Tanzania (BoT) said in its Monthly Economic Review for October that the stability of the shilling was also supported by low inflation differentials with major trading partners, prudent fiscal and monetary policies sustained over the period, and orderly foreign exchange market operations.

The BoT report indicated that the Tanzanian shilling traded at an average rate of 2,309/- per the US dollar during the month compared to 2,310/recorded during the previous month. "On annual basis, the shilling recorded a marginal depreciation of 0.03 percent from an average rate of 2,309 /- per US dollar registered in September 2020," the report said.

Meanwhile, the Central Bank has projected that inflation in Tanzania will remain within the target of 3-5 percent in the remaining period of 2021/22, hence consistent with East Africa Community

(EAC) and Southern African Development Community (SADC) benchmarks.

The BoT said the projection is bolstered by adequate food supply and stable exchange rate, which are expected to partially dampen the impact of high oil prices. Tanzania's inflation rate however rose to 4 percent in September 2021 from 3.8 percent that was recorded during the preceding month of August

"Core inflation, which accounts for 73.9 percent of overall CPI, rose to 4.6 percent from 4 percent, driven by accommodation, transport, clothing and footwear, recreation, and sports and culture," the report noted.

According to the Central Bank, food inflation in September 2021 remained broadly unchanged, ranging between 3.6 and 4 percent between August and September, on account of low prices of food crops owing to adequate supply in many parts of the country.

"This was reflected by high food stocks held by the National Food Reserve Agency (NFRA) ranging between 107,384-150,057 tonnes in recent months. The food stocks consisted of maize, rice and sorghum," the report added.

Kenyans rush to comply as KRA hunts rich cheats on social media

NAIROBI

Kenya Revenue Authority (KRA) on Wednesday said Kenyans are rushing to verify their tax compliance status following revelations that the taxman is training its guns on rich Kenyans displaying lavish lifestyles on social media but paying little or no taxes. KRA on Wednesday said in a statement that they have recorded a steady rise in the number of individual taxpayers rushing to verify their tax compliance status since the report was published.

"The rise has been attributed to a media article attributed to KRA Commissioner General Githii Mburu published this week confirming that the authority actively utilizes technological solutions for tax compliance surveillance," said KRA in a statement. Business Daily on Monday reported that KRA has a team focused on smoking out tax cheats through social sites such as Facebook, Instagram and Snapchat.

The taxman wants socialites and individuals who display lavish lifestyles

on the interwebs to pay their fair share of taxes as it races to bring more people into the tax bracket. The Authority's Deputy Marketing and Communications Commissioner Ms Grace Wandera said they are actively utilising technological solutions, including social media monitoring tools to ensure compliance.

"Within the confines of the law, we do apply social media scans among other technological tax compliance surveillance systems. This week, we have seen a more than 60 percent rise in the number of tax compliance certificates applications lodged on the online i-Tax platform," Ms Wandera said.

Ms Wandera said the spike means most taxpayers are willing to comply and that KRA "is a very dynamic organisation that will continue providing tax facilitation services to boost compliance." Further, the taxman said continued compliance has seen the country surpass collection targets. In the month of October KRA collected Sh154.383 billion against a target of Sh142.285 billion, a 108.5 percent performance.

Govt calls upon employers to submit their contributions to WCF promptly

MPLOYERS in the country have been urged to submit monthly contributions to Workers Compensation Fund timely to avoid attracting penalty from regulators.

HEALTH stakeholders Tanzania have celebrated the climax of a five-year US funded health mega project known as USAID Boresha Afya, an integrated health service delivery which covered 12 regions.

The United States Agency for International Development funded project executed interventions in HIV/AIDS, tuberculosis, family planning and malaria control has been hailed as a success story as it finally came to an end.

"This is an event that issues hope that we are on the right track towards providing health services to every Tanzanian," said Ummy Mwalimu, Minister of State in the President's Office, Regional Administration and Local Govern-

Mwalimu who was guest of honour at the closing ceremony of Boresha Afya project, noted that it has tremendously impacted on the lives of millions of Tanzanians. "It can be said with sincerity that in the past five years of execution of Boresha Afya, USAID was the actual key implementing agent for health services delivery at our district councils," she acknowledged saying the government also appreciates the capacity building of human resource in the health sector.

The U\$222 million Boresha Afya project was aimed at improving the health status of all residents in the targeted areas with focus on three result areas, namely: improved enabling environment for health services; improved availability of quality, integrated health services at facility level; and increased access to health services at community level.

The project was implemented between October 2016 to September 2021, with funding from US President's Emergency Fund for AIDS Relief though USAID. It was implemented by The Elizabeth Glaser Pediatric AIDS Foundation and Deloite, together with its key sub-partners, Engender Health, MDH and FHI260.

"As a result of Boresha Afya activities, over 8.3 million Tanzanians received HIV testing services of which nearly 340 thousand learned their HIV positive status," said Kate Somvongsiri, Mission Director for USAID Tanzania.

"Changes in the environment, including agricultural intensification, population growth, urbanization, climate change and human encroachment into wildlife habitats are drivers for zoonotic disease emergence," he said.

He stated that the aim of national validations is to give various stakeholders a chance for internalisation and ownership. In remarks to welcome the Deputy Permanent Secretary, a Manager of the Support to Pandemic Preparedness in the EAC Region (PanPrep) project, Dr Irene Lukassowitz, said the relevance of the One Health approach is more prominent following the coronavirus

outbreak.

"It all started as a health issue but quickly developed into a threat for lives and livelihoods of the people and the economy as a whole. It had an impact on several sectors including trade, tourism and education," Lukassowitz said.

She said the EAC is pursuing a wide One Health approach that goes beyond human, animal and environmental health approach applied in many countries and includes all sectors and disciplines in the prevention of and response to events of public health concern.

Lukassowitz commended the government for attaching the One Health Unit to the Prime Minister's Office and thus above sectors. "This should facilitate the implementation and mainstreaming of One Health in the country," the PanPrep chief noted.

equities to our platform to complement our initial offerings of peer-to-peer transactions and cross-border payments," said Ham Serunjogi, CEO of Chipper Cash. "The US market is now easily accessible to

Under the new partnership, Ugandan investors will be able to invest into equities in the US "on a dollar equivalent basis (through fractional shares) in over 6,000 US securities and ETFs" allowing

World Bank blacklists Kenyan consultancy firm over fraud

The World Bank has blacklisted a Kenyan consultancy firm that has undertaken several multimillion shilling projects for top government agencies over fraud.

As Farizon Auto explains, the Homtruck is also capable of connecting to the logistics network's big data platforms to help drivers obtain the most optimal orders in real-time, analyze and track deliveries, and calculate operating costs throughout. of the routes.

The Homtruck's 'brain' can use vehicle sensors to analyze real-time traffic data and receive route recommendations. Meanwhile, Tesla continues to delay deliveries of the Semi - unveiled in 2017 until next year. Elon Musk said it was due to the limited supply of batteries.

Tencent purchases game studio that is behind hit Nintendo Switch titles

TOKYO

Tencent Holdings has quietly acquired a Japanese creative studio with several Nintendo Switch hit games to its name as part of a talent acquisition spree in the home of anime and manga, people familiar with the deal said.

The Shenzhen-based entertainment giant has taken about a 90% stake in Wake Up Interactive for more than 5 billion yen (\$44 million), the people said, asking not to be identified because the transaction is not yet public.

Wake Up owns Tokyo-based Soleil, which helped develop Nintendo Switch hits Ninjala and Travis Strikes Again: No More Heroes. Taking over almost the entire company is unusual for Tencent in Japan, which has so far made smaller investments and mainly aimed to secure international publishing rights for future

The Wake Up purchase, which came in September, is one of several deals that Tencent struck with privately-held game makers in Japan this year. Soleil is known for its track record of helping produce high-quality action games for consoles, PCs and smartphones, which was part of the motivation for Tencent's approach to its parent company.

Ninjala is owned by GungHo Online Entertainment Inc., which led development, and Travis Strikes Again is a product of Grasshopper Manufacture Inc. Representatives of Tencent and Wake Up did not immediately respond to requests for comment.

Tencent and compatriot NetEase Inc. have actively recruited fresh talent in Japan over the past two years, looking to acquire valuable intellectual property in anime and video games as well as decrease their revenue dependence on the domestic China market. This year has made that project all the more urgent as the Beijing government tightened restrictions on playing time and slowed approvals for publishing new games as part of a broader crackdown on its tech giants.

Kadokawa Corp. said last month that Tencent plans to pay about 30 billion yen to take a 6.86% stake in the famous publishing company. Grasshopper Manufacture, led by creator Goichi Suda, is now a part of NetEase.

In addition to a handful of publicly-announced deals, the two Chinese game titans have also either acquired or taken a stake in numerous smaller Japan-based game developers, betting on their potential to produce a smash-hit title and securing a favourable position to then bargain for its global distribution.

Their focus has been on small studios and talented individuals who may be contemplating leaving a bigger company to set up their own creative operation. In most cases, the deals are kept secret from the public. "Tencent sees no advantage in announcing a deal as it doesn't want to alert the competition and give them insight into its strategy," Tokyobased game consultant Serkan Toto said.

WHO warns vaccine alone won't end pandemic

LONDON

THE head of the World Health Organization has stressed that vaccines alone can not end the pandemic.

During a media briefing on Friday, WHO director-general Tedros Adhanom Ghebrevesus said while vaccines reduce the risk of hospitalization, severe disease and death, they do not fully prevent transmission.

"Some European countries are now reintroducing restrictions to curb transmission and take the pressure off their health systems," Tedros said. "We continue to recommend the tailored and proportionate use of testing, masks, physical distancing, measures to prevent crowding, improve ventilation, and more. And get vaccinated when it's your turn."

Tedros' warning comes after 2 million COVID-19 cases were reported in Europe

This is the most in a single week in the region since the pandemic started, the WHO head said, adding that Europe reported some 27 thousand deaths, more than half of all COVID-19 deaths globally

"COVID-19 is surging in countries with lower vaccination rates in Eastern Europe, but also in countries with some of the world's highest vaccination rates in Western Europe," Tedros said. "It's

another reminder, as we have said again are continuing to stockpile vacand again, that vaccines do not replace the need for other precautions."

The WHO noted that with a right mix of measures, it's possible for countries to find the balance between keeping transmission down and keeping societies and economies open.

But Tedros said countries cannot vaccinate their way "out of the pandemic".

He added: "It makes no sense to give boosters to healthy adults, or to vaccinate children, when health workers, older people and other high-risk groups around the world are still waiting for their first dose. The exception, as we have said, is immunocompromised individuals."

Tedros again criticized countries that solve the global vaccine crisis." have high vaccine coverage, and which

cines, when low-income countries are still having to wait.

He pointed out that COVAX, a worldwide initiative aimed at equitable access to COVID-19 vaccines, is working. The initiative has shipped some 500 million vaccines to 144 countries and territories.

"To reach WHO's target of vaccinating 40 percent of the population of every country by the end of this year, we need an additional 550 million doses, about 10 days' production," Tedros said. "Vaccines alone will not end the pandemic, but we cannot end the pandemic unless we

Restoring Normalcy

Liang called for adhering to COVID-19 prevention measures in a scientific way. Prevention policies should be consistently improved aligning with changes in the epidemic situation, he said, adding that risk grades for COVID-19 infection in different regions should be assigned precisely and properly.

Liang also urged efforts in accelerating vaccine and drug development, as well as strengthening the training on epidemiological investigation, treatment, and management.

While the COVID-19 patients and their close contacts might face inconvenience in the short term, swift containment of outbreaks will only help restore normalcy in the economy and society, he said.

Shedding light on the future of China's anti-epidemic strategy, Liang said things will depend on multiple factors such as how the CO-VID-19 situation pans out globally, virus mutation, the seriousness of the disease and China's vaccination

China's epidemic prevention policies are constantly evolving, Liang said, noting that the country will be "closely watching the global pandemic situation, accelerate vaccination and adjust policies in due time."

THE US military covered up 2019 airstrikes in Syria that killed up to 64 women and children, a possible war crime, during the battle against Islamic State, the New York Times reported on Saturday.

The two back-to-back airstrikes near the town of Baghuz were ordered by a classified American special operations unit tasked with ground operations in Syria, according to the report. The newspaper said that

US Central Command, which oversaw US air operations in Syria, acknowledged the strikes for the first time this week and said they were justi-

In a statement on Saturday, Central Command reiterated the account it gave the newspaper that 80 people were killed in the strikes including 16 Islamic State fighters

Austria prepares to lock down unvaccinated as cases spike

AUSTRIA is preparing to implement lockdown measures for unvaccinated people as coronavirus cases spike to record levels.

The plan is expected to be approved Sunday and come into effect a day later, the Austria Press Association reported, citing a draft document.

Under the new measures, people without proof of vaccination or recovery from COVID-19 would only be allowed to leave home for essential activities, including going to work, grocery shopping, medical treatment and exercise.

Salzburg and Upper Austria, states with high COVID-19 rates and low vaccination levels, are expected to introduce the measures themselves on Monday.

State governors will likely meet Sunday to discuss ways to turn around Austria's sharply rising infections, which are increasingly straining medical facilities.

Austria's 7-day average of COVID-19 cases has more than doubled this month to more than 10,000, and its recent rate of infection is among the highest in the world. A record 13,152 cases were reported on Saturday.

Only about 65 percent of Austrians are fully vaccinated, one of the lowest rates in Western Europe. Hospitalizations have climbed, and deaths are averaging the highest levels since March, before vaccines were widely available.

Austrian Chancellor Alexander Schallenberg on Thursday rejected lockdown measures for vaccinated people.

"I don't see that two thirds should lose their freedom because one third is hesitating," Schallenberg said at a press conference. He called Austria's vaccine take-up "shamefully low."

The lockdowns would be enforced by spot checks and the threat of hefty fines.

"We don't live in a police state and are not able -- and nor do we want -- to control every street corner," Schallenberg

Russian agencies, EMA cooperate for Sputnik V vaccine approval - Lavrov

RUSSIAN agencies are collaborating with the European Medicines Agency (EMA) and the World Health Organization (WHO) to approve the use of the Sputnik V COVID-19 vaccine, Russian Foreign Minister Sergey Lavrov told reporters on Friday.

"No, the issue was not brought up today, but we have it under control," the Russian foreign minister said when asked whether the Sputnik V authorization was touched upon at the talks with the French defense and foreign ministers.

"France is among those in the European Union who are waiting for the decision of the World Health Organization (WHO). It is being delayed for some objective reasons, but also for some subjective ones. Our corresponding authorities work alongside the European Medicines Agency and, of course, we work with the World Health Organization," he said.

Lavrov pointed out that a number of European countries had opted for recognizing the Russian vaccine. He added that the pandemic had served to spotlight the need for cooperation between Russia and the European Union.

"We take an interest in working with the European Union. And the fact that there are such issues, and that they are not far-fetched, but quite real and rather thorny is proven in the situation with coronavirus infection, where we need to team up putting aside commercial interests," he said.

Lavrov recalled that Russian President Vladimir Putin suggested this April that patent protection of all vaccines be temporary lifted for the pandemic.

"This has simply gone nowhere, as no reaction followed. And of course, it is frustrating that in the face of such a truly global disaster many try to play to their own advantage and at the expense of others," the Russian foreign minister

Lavrov emphasized that Moscow remains ready to establish constructive relations with the EU, "which have been destroyed by the European Union itself."

Lavrov noted that the talks with EU foreign policy chief Josep Borrell in Moscow this February have not brought about real action in the areas of health, climate, digitalization and green economy.

"However, nothing is working out so far. I think that it is due to the inertia of that Russophobic minority that imposes its policy on all sensible and sane members of the European Union," Lavrov concluded.

Sputnik V was authorized in Russia on August 11, 2020 to become the world's first officially certified COVID-19 vaccine. To date, Sputnik V has been approved for use in 70 countries with a cumulative population of four billion people. On March 4, the EU regulator announced

"The US should correctly view the mutually beneficial nature of China-US relations, adopt a rational and pragmatic policy toward China, work with China to strengthen dialogue and communication, deepen mutually beneficial cooperation, properly manage differences and follow the path of mutual respect, peaceful coexistence and win-win cooperation," he said.

Last-minute climate deal agreed at COP26

NEGOTIATORS agreed on a climate deal at the 26th United Nations Climate Change Conference of the Parties, or COP26, in Glasgow on Saturday night, after lastminute concessions on coal pushed the agreement over the line.

After weeks of mediation, COP26 President Alok Sharma was visibly emotional when he announced the Glasgow climate agreement. A key line in the text pertaining to coal was watered down for the second time this week in order to get the deal done.

"I think we can credibly say that 1.5 C is alive. But it's pulse is weak," Sharma said, referring to the target laid out in the Paris Agreement in 2015 to keep average global temperatures to within 2 and 1.5 degrees Celsius this century.

"I apologize for the way this process has unfolded. I am deeply sorry," Sharma said. "I also understand the deep disappointment but I also think, as you have noted, that it is vital that we protect this package."

Sharma said that a "gulf remained" between what countries have promised on emissions reductions and what is needed to meet Paris goals, though he said he remained hopeful future conferences could make meaningful progress.

"This multilateral process can deliver," Sharma said. "This package sets a course for the world to deliver on the promises made at Paris."

China welcomed the outcome of the conference, calling it "of great significance for safeguarding multilateralism and concentrating (international efforts) on implementation of the Paris Agreement."

Prior to the finalization of the agreement, representatives from several countries including China said that the text was not perfect but that had no intention to

An initial draft had called for nations to "phase out coal" projects this decade, and this language was changed to "phase down", after stiff opposition from Indian negotiators, who said it was unjust for rich nations to require the phasing out fossil fuels in developing nations that are in the midst of industrialization and

"How can anyone expect that developing countries can make promises about phasing out coal and fossil fuel subsidies when developing countries have still to deal with their development agenda and poverty eradication?" India's environment minister Bhupender Yaday asked on Saturday evening in Glasgow.

China's vice-minister of ecology and environment

Zhao Yingmin supported this perspective. "The current global warming has been caused mainly by the industrialization in the past 200 years, mainly involving the developed countries," Zhao said during a news conference late Saturday evening. "This historical responsibility has been clarified by the Paris Agreement, hence the 'common but differentiated responsibilities'. The developed countries, therefore, must take the lead to cut emissions instead of requiring the developing countries to stop consuming coal; it is unfair."

Ex-Trump aide Bannon indicted for contempt of Congress

WASHINGTON

A US federal grand jury has indicted Steve Bannon, onetime adviser to former president Donald Trump, charging him with contempt of Congress after he defied a subpoena by the House select committee investigating the Jan 6 Capitol riot, the Justice Department announced Friday.

The indictment came as Attorney General Merrick Garland has been under pressure to prosecute Bannon after the House voted on Oct 27 to hold the former chief strategist of Trump in criminal contempt of Congress and referred the resolution to the Justice Department.

"Since my first day in office, I have promised Justice Department employees that together we would show the American people by word and deed that the department adheres to the rule of law, follows the facts and the law and pursues equal justice under the law," Garland said in a statement. "Today's charges reflect the department's steadfast commitment to these principles."

Bannon's indictment contained two charges of contempt of Congress, according to the Justice Department, "one contempt count involving his refusal to appear for a deposition and another involving his refusal to produce documents, despite a subpoena from the House Select Committee to Investigate the January 6th Attack on the United States Capitol.'

Each count of contempt of Congress carries a minimum of 30 days and a maximum of one year in jail, as well as a fine of \$100 to \$1,000, the department said, adding a federal district court judge will determine any sentence for the 67-year-old Trump

The House Jan 6 committee subpoenaed documents and testimony from Bannon on Sept 23. He missed both the Oct 7 deadline for documents production and the Oct 14 deadline for deposition.

Bannon's lawyer, Robert Costello, told the committee his client would not cooperate with the investigation because he had been so directed by Trump, who claimed the documents and testimony being sought were potentially protected by presidential executive privilege.

Costello told the committee that "the executive privileges belong to President Trump" and "we must accept his direction and honor his invocation of executive privilege.

President Joe Biden has refused to assert executive privilege with respect to witnesses and documents, citing the extraordinary nature of the attack on Capitol Hill on Jan 6 to stop Congress from certi-

In seeking documents and deposition from Bannon, the Jan 6 committee said in the subpoena that Bannon spoke with Trump in the run-up to Jan 6, that he was present at a hotel in downtown DC used by the Trump team as a command center as the attack unfolded, and that he said on his radio podcast one day prior to the attack that "all hell is going to break loose tomorrow."

The select committee has so far issued subpoenas to 21 former officials in the Trump administration and notoriously difficult to for documents, testimony – or both – related to their involvement in the Capitol riot.

Also subpoenaed by the panel, Trump's then chief of staff Mark Meadows didn't appear for his deposition scheduled for Friday at 10 am ET, risking the invocation of the contempt of Congress procedure by the select committee as it so warned Meadows on Thursday night.

Contempt of Congress prosecutions by the Justice Department often have been both time consuming

succeed, oftentimes ending in acquittal or dismissal on appeal.

The last time the department prosecuted a contempt referral was in 1983, during the Superfund investigation in the Ronald administration. Reagan Then Environmental Protection Agency official Rita Lavelle was charged with contempt but her case ended in acquittal.

Aircraft designer Gu Songfen wins China's top science award

CHINESE aircraft designer Gu Songfen won China's top science award for his outstanding contributions to scientific and technological innovation.

An awards ceremony was held on Nov. 3 at the Great Hall of the People in Beijing to honor Gu, a leading scientist at the Aviation Industry Corporation of China, Ltd., as well as other scientists with major contributions.

Gu, an academician at both the Chinese Academy of Sciences (CAS) and the Chinese Academy of Engineering, was born in 1930 in Suzhou, east China's Jiangsu province. He started working for the aviation industry after graduating from university in 1951.

In 1956, the first airplane design office of the People's Republic of China was established in Shenyang, northeast China's Liaoning province, and Gu was appointed the head of an aerodynamics

It was there that Gu encountered the first major challenge of his career - the aerodynamic design of the jet trainer Shenyang JJ-1, the very first jet aircraft of China.

Gu, who studied propeller-driven aircraft at university, didn't know much about jet aircraft. Therefore, he had to learn new stuffs, day and night. He heard that Beihang University,

previously known as Beijing University of Aeronautics and Astronautics, had the documents that he might need, so he went to Beijing from Shenyang. In order to minimize the disturbance to

students, he searched for and studied the materials in the university's library at night. Finally, he came up with the aerodynamic design criteria for subsonic aircraft and the engineering calculation method for aerodynamic properties, and completed the aerodynamic layout plan for the Shenyang JJ-1.

Following this initial achievement, Gu completed the aerodynamic layout plan for the Nanchang CJ-6, the first Chinese basic trainer aircraft, and established an aerodynamic design system for subsonic aircraft.

Immediately after that, he joined aerodynamic studies of supersonic aircraft, and the aircraft aerodynamic design system he established is still an important reference for Chinese aircraft designers

In 1964, China started developing its first high-speed and highaltitude interceptor fighter jets - J-8, and Gu led the aircraft's aerodynamic design as a deputy chief designer. Later, he was appointed the chief designer of the project.

Sixteen years later, he was again appointed the chief designer of J-8 II, the next generation of the J-8 interceptor that outperforms its predecessor in every aspect. He led over 100 design and manufacturing organizations, and sent the aircraft into the air in only four

Gu said his biggest wish is to never leave the cause of aviation.

In 1986, Gu was transferred to Beijing for work, where his major duty was to make decisions on major national projects and to make suggestions on the aeronautic equipment system construction and the layout of the country's national defense.

He still pays close attention to the development of aircraft, and has joined the making of multiple airplanes, including the narrowbody airliner C919, the fighter jet J-10, the large military transport aircraft Y-20, the supersonic advanced jet trainer JL-9 and the regional jet ARJ21. Besides, he is also actively promoting the development of Chinese seaplanes.

Though the nonagenarian had gone through surgeries, he's still working every day. It takes him longer to cover the distance between his home and his office, which used to cost him around 10 minutes, but he is still punctual.

"To learn the new development of aviation industry is what makes me happy in my twilight years. All I can do now is to read some books, translate some materials and try to offer as much assistance as possible for the young people," he said.

Russia ready to help resolve migration crisis on Belarusian border with EU - Putin

MOSCOW

MOSCOW is ready to facilitate efforts to resolve a migrant crisis on the border between Belarus and the European Union, Russian President Vladimir Putin said in an interview



with Rossiya-1's "Moscow. Kremlin. Putin" show.

"When we hear some statements and accusations against us. I would like to tell everyone: mind your own domestic issues, don't try to shift them to others because it is your related agencies that need to resolve them.

However, we are ready to do our utmost [to help resolve the situation] if there is anything we can do," Putin said in response to reporter Pavel Zarubin's questions.

He reiterated that accusations of involvement in the migration crisis against Russia "point to someone's desire to shift responsibility for the current developments." "What does our Aeroflot air carrier has to do with it?

Did anyone take an Aeroflot flight? I know nothing about it but some people surely could have taken a flight and traveled through third countries. What do we have to do with it?" the Russian president said.

Responsibility for migration crisis

Western countries seek to avoid responsibility for a migration crisis on the border between Belarus and the European Union, Putin said.

"I have already said that we have nothing to do with it, absolutely nothing. Why are some talking about it? Because it is on their conscience. It indicates their desire to shift the blame to someone else," Putin said in response to reporter Pavel Zarubin's questions.

According to the Russian president, it is Western countries that are to blame for the crisis. "I have already explained why, there are political, military and economic

They were the ones who created conditions where thousands, even hundreds of thousands of people left their homes. And now they are looking for someone to blame in order to avoid responsibility for what is happening," Putin stressed.

The Russian president explained that he had learned about the migration crisis from the media. "I never discussed the issue with [Belarusian President Alexander] Lukashenko before. However, we have talked on the phone twice since the crisis emerged," Putin said.

The Russian leader earlier expressed hope that Lukashenko and Acting German Chancellor Angela Merkel would hold a conversation in the near future to discuss the situation because most migrants sought to reach Germany.

Tensions sparked by migrants seeking to enter Poland, Lithuania and Latvia via Belarus exploded on November 8. Several hundred people arrived on the Belarusian-Polish border. EU states claim that Minsk is deliberately escalating the crisis and call for sanctions. Belarusian President Alexander Lukashenko, in turn, blamed the situation on the Western countries whose actions forced people to flee their war-torn homelands.

HANCES that the regional soccer ranking was for once likely to be disrupted with Taifa Stars making a strong bid for Qatar 2022 World Cup are now ruined, which was on the horizon but what can be described as a massive outpouring of faith - or prayers - stood in the way of accepting the thrust of the competition.

One rather misplaced comparison was the recollection that the side won 3-0 over the Uganda 'Cranes' to reach AFCON finals during the tutelage of Emmanuel Amunike, skipping over the fact that Uganda had already qualified and had no reason to play to its actual ability. It would have to have a vendetta to play profusely.

The point that a portion of analysts and a majority of the fans kept avoiding was that DRC had to play to capacity in that encounter, having been forced to a draw in their home game, with Tanzania topping the list on points up to that moment.

On the contrary, the home side was under the impression that they were meeting the same side, and more to it, they had a home advantage - a view unlikely to have been cultivated by an experienced coach like Kim Poulsen but reverberating with the gallery, the stands or the fans.

But even then the edge could have been less intense, though such examples aren't far to seek at club level, etc.

That is why to a portion of observers, the singularly most important lesson of the DRC encounter is that playing at their best and with determination, Taifa Stars stand little chance of a positive score against DRC, though the margin the visiting side was likely to manage could be slightly narrowed.

AUSTRALIA is hoping to get its World Cup qualification campaign back on Tuesday in Sharjah with a win that would almost certainly end China's slim hopes of returning to the Middle East next No-

One point from the last two games has resulted in the Socceroos slipping into second in Group B at the halfway stage, three points behind Saudi Arabia, the two teams drew 0-0 in Sydney on Thursday, and just one above Japan. Only the top two from each of the six-team groups are guaranteed a place at the Qatar World Cup.

Failure to win in Sharjah, the game has been switched from China due to travel restrictions put in place by Beijing to combat the spread of COV-ID-19, could see Australia slip out of the two places that guarantee a place in the Qatar World Cup in each of the six-team groups.

Coach Graham Arnold is staying positive despite the recent setbacks. "We're in a great spot, it's all in our hands," Arnold said. "If you've got something that's in your hands, you're in a great position rather than having to rely on other results."

Australia will be without Harry Souttar as the giant Stoke City defender picked up a knee injury against Saudi Arabia.

China, with just one World Cup appearance in its history, has just four points out of the five games so far to increase pressure on coach Li Tie. Defeat would likely spell the end of any ambitions of finishing third and entering the play-off route to the

Ivory Coast beat Mozambique 3-0 to reclaim the lead of the group by a point from Cameroon.

Cameroon had earlier ruthlessly punished Malawi 4-0 after the Malawians had John Banda sent off in the 21st minute for blocking Vincent Aboubakar's shot with his hand on the goal line.

Aboubakar knocked home the penalty to make it 1-0.

André-Frank Zambo Anguissa hit the goal of the game by controlling a corner on the edge of the area and volleying in to put Cameroon 2-0 ahead. Christian Bassogog scored two goals in two minutes near the end, although Malawi was already well beaten.

Patson Leicester's Daka scored Zambia's first goal in a 4-0 Group B. Fashion Sakala

then took over to net a hat trick. Zambia's hopes of making the playoffs are alive, if only just, as it trails Tunisia and Equatorial Guinea by three points.

Only the 10 group winners reach the playoffs, which will be held in March.

Tunisia is at home to Zambia and Equatorial Guinea travels Mauritania, which has been eliminated.

Tunisia could have decided the group with a win in Equatorial Guinea on Saturday but Pablo Ganet swept home the winner there for Equatorial Guinea with seven minutes to go to shock the Tunisians and set off wild celebrations.

Mali, Egypt, Senegal and Morocco have already made it to Africa's final playoffs, where the five winners of the 10 two-leg ties go to the World Cup in Qatar next year.

France, Belgium win to reach World Cup; Dutch slip to draw

PARIS

Kylian Mbappe's four goals in an 8-0 rout of Kazakhstan ensured defending champion France reached next year's World Cup along with victorious Belgium, the Netherlands failed to join them Saturday after conceding two late goals.

Belgium was less spectacular beating Estonia 3-1 at home but has an unassailable five pointlead over second-place Wales, which beat Belarus 5-1 in Cardiff and has a three-point lead over the Czech Republic for a playoff spot.

After missing out on the last World Cup, the Dutch looked set to go through after leading 2-0 at Montenegro with goals from Memphis De-

Yet Montenegro struck twice in the last eight minutes to make it 2-2, and that gives Turkey and Norway a chance for top spot since they are two points behind with one game left.

"I don't know what to say. Unbelievable," Netherlands captain Virgil van Dijk told Dutch broadcaster NOS. "It's scandalous how we played in the second

GROUP D

France was playing away from its usual home venue Stade de France and took the field at Parc des Princes, where Mbappe stars for Paris Saint-Germain.

He became the first France player since Just Fontaine at the 1958 World Cup to score four times in one game.

"The most important thing was qualifying, and we have players in our squad who have never played in the World Cup," said Mbappe, who starred in the last one. "It's a dream to play in it for your country."

After 32 minutes he had his first international hat trick.

National beach soccer team ready for COSAFA Beach Soccer Championship

TANZANIA's national beach soccer team depart South Africa today to battle it out in the Confederation of Southern Africa Football Associations (COSA-FA) Beach Soccer Championship.

National beach soccer team head coach, Boniface Pawasa, said they are well prepared for the tournament which has attracted seven nations.

The teams which will compete at the event are South Africa, Mozambique, Seychelles, Madagascar, Comoros, Tanzania, and Angola.

He said in his squad he has six new players and retained eight players, he, however, could not unveil the new and retained players in his squad.

"We are well prepared for the tournament, the team is ready and the good thing is that we have met some of the teams before, we know how Mozambique, South Africa, Madagascar, and Seychelles

"We know Mozambique is coming from the World Cup, it will be a tough opponent, we are confident we will do well," Pawasa stated.

The inaugural Beach Soccer Championship was held in Seychelles in 2015 and won by Madagascar, who would go on days later to have tremendous success on the continental stage.

The next CAF Beach Soccer Cup of Nations is scheduled for Mozambique in 2022, which will in turn likely serve as the qualifiers for the 2023 FIFA Beach Soccer World Cup.

At the group stage draw, the teams are split into two pools. Group A will contain four sides and Group B will have three. The top two teams in each pool will advance to the semi-finals.

The draw for the 2021 COSAFA Beach Soccer Championship took place in Durban on Saturday, providing the seven competing sides with a roadmap to regional glory at the November 17-21 competition.

The draw was attended by dignitaries from the City of eThekwini and KwaZulu-Natal Provincial Government, as well as former Bafana Bafana international Mark Fish, who also played beach soccer for South Africa and will be part of the Technical Study Group at this year's tournament.

Hosts South Africa were the seeds in Group A and they have been drawn against Seychelles, 2015 CO-SAFA, and African champions Madagascar, as well as Angola. It appears to be a real Group of Death that will be tough to call.

Group B contains 2021 CAF Beach Soccer Cup of Nations runners-up Mozambique, Comoros Islands, and East African guest nation Tanzania.

Tanzania will not only be participating in the competition but will also be sending two referees to lend their experience, Jackson Msilombo, and Geoffrey Mwamboneke.

The inaugural COSAFA Beach Soccer Championship was played in Seychelles in 2015 and was won by Malagasy. Recently COSAFA signed a three-year partnership with the KwaZulu-Natal Provincial Government and the City of eThekwini to host several annual tournaments in Durban, including the beach soccer tournament.

The agreement runs from August 2021 to December 2023 and provides the COSAFA Cup, COSAFA Women's Champions League, and COSAFA Beach Soccer Championship with certainty over the hosting of the trio of annual events in what are the most uncertain of times.

The three tournaments will be staged in the coastal city each year over that period, making use of the world-class football facilities on offer and the excellent all-around infrastructure in travel, transport, and communications.

"As the City, we are excited to host the COSAFA Beach Soccer Championship. Durban is the perfect host city with our amazing sandy beaches, the warm Indian Ocean, and sub-tropical sunshine," said Musa Mbhele, Acting City Manager, eThekwini Municipal-

"Hosting the championship is a step towards realizing the vision of the City to grow beach sports. We want our beaches to be fully utilized for sports, lei-
