

### Tanzania 'mitigates climate change with more natural gas use' **By Guardian Reporter**

TANZANIA is making strides in cutting emissions of greenhouse gases with the exploitation and use of natural gas in homes, at industries and in motor

Selemani Jafo (pictured), the Minister of State in the Vice President's Office (Union and Environment) told academic staff and students at the University of Glasgow yesterday that this shift from charcoal, coal and petroleum is playing a significant role in conserving the environment.

VPO said in statement that the minister highlighted efforts of introducing gas in homes, in operating industrial plants and in vehicles to replace diesel and petrol was proceeding well, plus its use in wide capacity transit buses in the city of Dar es Salaam.

He said the issue of environment conservation is cross-cutting and involves various sectors so joint efforts are needed in combating degradation to build a clean, safe and sustainable environment for present and future generations. ## Investments, cultural links high in Samia, El Sisi talks

Joint press conference touches on discussion on security, regional issues

PRESIDENT Samia Suluhu Hassan and her Egyptian counterpart Abdel Fattah el-Sisi yesterday held talks which dwelt on economic cooperation between the two countries, among other issues.

A State House statement on a press briefing at the Cairo State House said President Samia underlined that the talks touched on enhancing diplomatic cooperation, tourism, education links as well as sports, where a major focus was the Julius Nyerere Hydropower Station

The project for a 2,115 megawatts power station is billed to produce 5,920GWh of power annually once completed, being constructed by Egyptian firms Arab Contractors and Elsewedy Electric.

The two leaders exchanged views on various security matters, with President Samia expressing gratitude for training and exchange programmes that benefit Tanzania, in remarks on the first day of a three-day visit.

The two countries signed cooperation agreements in education and diplomatic ties, with President Samia commending the good work being done by the Egyptian companies working on the Rufiji River project.

Construction began in 2019 and is expected to be completed next year, for the main dam of 1,025 metres length at

## Heart ailments, diabetes top non-communicable diseases

AS Tanzania observes the Global Week of Non-Communicable Diseases with events being hosted here, at least 3000 people from the city have turned up for free open-air medical check-ups at the Sheikh Amri Abeid Stadium.

The event goes hand in hand with the Covid-19 vaccination exercise, while a casual glance shows that more people scramble for free eye testing and checkups, coordinated by the Tanzania Non-Communicable Diseases Alliance (TANCDA).

Dr Rachel Nungu, a consultant leading the exercise, said that cardiovascular problems seem to be affecting more people compared to other noncommunicable diseases, listing other widespread maladies as high blood pressures, diabetes and eye problems, usually linked with being overweight.

TANCDA says that at least 34 percent of the population, those aged 25 years and above, are overweight, a situation

medical experts say is detrimental to their health.

A study conducted among 2266 residents of the city of Dar es Salaam shows that 40 percent were already suffering from hypertension, while nine percent were diagnosed as being diabetic.

Company executives and religious leaders, church priests in particular, were found to mostly suffer from high blood pressure, compared to other groups of city residents.

Prof Andrew Swai, the TANCDA chairman, said that this situation can be attributed to the nature of their occupations. They work in environments that do not allow them much mobility or physical exercises, the specialist noted.

High blood pressure cases affect up to 40 percent of the population, estimated at anywhere from 55m to 60m, before a proper census is conducted later next vear.

There will be no more water rationing in Dar es Salaam after completion of the project, he affirmed, noting that water and sewerage authorities across the country face a major challenge of water loss, accounting for more than 20 percent of volumes produced, the figure usually stated to the loss level that water authorities face.

Illegal connections in some urban buildings including hotels add to the problem of water loss, he lamented, highlighting that in the past 60 years, access to clean and safe water services in urban areas has increased to 86 percent at present, from 25 percent back in 1961.

Implementation of water projects faces a number of challenges including climate change effects and poor financing as such projects often require billions of shillings to carry out, he said, similarly remarking that water from Lake Victoria will be needed to address water woes in

Rising water demand has followed the fifth phase decision to relocate central government business to Dodoma, so the government is looking into boosting water supplies by piping water from the lake, he stated, pointing at similar projects in Kahama and Shinyanga urban

The minister recalled existence of plans to respond to the effects of

climate change, where the ministry Lake Nyasa water supply project will is readying for the construction of large dams at Farkwa (Dodoma), Kidunda (Morogoro Songwe (on the Tanzania-Malawi border) and Ndembera / Lugoda (Coast Region), along with medium-sized dams in various parts of the country.

The government shall implement projects on reliable water sources on the Great Lakes and major rivers, notably Ruvuma, Rufiji, Kiwira, Songwe and Kagera, to take water from these sources to areas facing water scarcity, he stated.

The Kiwira River water project is slated to supply Mbeya City, while the Ruvuma River water project will take care of Masasi, Mtwara, Nanyamba and Nanyumbu. The serve an estimated 150,000 residents in 30 villages, he elaborated.

Lake Victoria water is expected to reach towns and villages along the lake within Simiyu, Geita, and Mwanza regions, also expected to serve about 2.8m people in 300 villages, he specified.

"So far, 688.81bn/- has been spent on improving water supply in rural areas. Within this year the government is implementing 1,176 projects for clean water and sanitation in rural areas," he asserted.

Through the Covid-19 economic recovery funds for the sector, the ministry has allocated 139.4bn/- to implement 218 projects across the country, he added.

The dam is billed to be the fourth largest in Africa, ninth largest in the world and the largest power station in East Africa, ministerial sources affirm. The 134 metres arched, concrete dam is expected to create a reservoir lake 100 kilometers in length, measuring 1,200 square kilometers (460 sq mi), holding 34bn cubic metres of water.

President Samia said Tanzania was affected by the Covid-19 pandemic and in response it had invested heavily in boosting key sectors such as tourism, thus GDP growth is expected to reach 5.46 percent.

"Tanzania recognizes and appreciates Egypt's technical support, education scholarships that have helped increase the knowledge and experience of many Tanzanians," the president declared, also praising her hosts for allowing Kiswahili to be taught in Africa's largest Arab nation.

Tanzania will send a team of

experts to look at areas that need to be improved in that undertaking, she stated, elaborating that three agreements were signed, tasking ministerial executives to work hard in pursuing negotiations on other pending agreements.

Earlier, President El-Sisi said that their talks focused on how Egypt can help Tanzania in various fields.

"We are ready to cooperate and provide expertise in capacity building through our development agency. We will use our potential to increase trade between these political enhance countries, cooperation, increase Egyptian investments in Tanzania it access markets," he stated.

Substantial growth has been registered in Egyptian businesses in Tanzania owing to the longterm cooperation between these countries, he further noted.

Seven preliminary agreements were signed by the Tanzanian delegation, featuring Education, Science and Technology minister Prof. Joyce Ndalichako and the Foreign Affairs and International Cooperation minister, Ambassador Liberata Mulamula, the statement added.

## Ethiopia 'siege' of Tigray hampering help for rape victims, says report

**ADDIS ABABA** 

The Ethiopian government's "effective siege" of Tigray is preventing victims of rape committed by warring parties during the year-long conflict of getting access to health care, Human Rights Watch charged in a report yesterday.

The HRW claims coincided with a report by fellow campaign group Amnesty International that said Tigrayan rebels raped, robbed and beat up women during an attack on a town in Ethiopia's Amhara region, the latest disturbing testimony from the war.

HRW accused the warring sides of committing widespread sexual violence and deliberately targeting healthcare facilities, documenting the physical and mental trauma of rape victims aged six to 80.

"The government's effective siege of Tigray since June is doubly victimising survivors" by denying them critical medical and psychological care, it said.

The report said victims of rape required treatment for sexually transmitted diseases, broken bones, stab wounds and post-traumatic stress.

"One year since Tigray's devastating conflict began, survivors of sexual violence -- from gang rape to sexual slavery -- remain in desperate need of health care and support services," said Nisha Varia, HRW's women's rights advocacy director.

"Not only have Tigrayan women and girls experienced horrific abuses, they are confronting shortages of food, medicine, and other desperately needed support to rebuild their lives."

The Amnesty investigation, which drew on interviews with 16 sexual assault survivors in the town of Nifas Mewcha, followed an earlier report by the rights group that documented the rape of hundreds of women and girls by Ethiopian and Eritrean soldiers in Tigray.

The report yesterday focused on assaults during an August offensive by the Tigray People's Liberation Front (TPLF), with 14 of the 16 women interviewed telling Amnesty they were gang-raped by the rebels, in some cases at gunpoint and with their children watching.

"The testimonies we heard from survivors describe despicable acts by TPLF fighters that amount to war crimes, and potentially crimes against humanity," said Amnesty's secretary general Agnes Callamard.

"They defy morality or any iota of humanity."

In one of the incidents detailed by Amnesty, Gebeyanesh -- not her real name -- said TPLF fighters gangraped her while her children, aged nine and 10, wept.

"Three of them raped me while my children were crying," the 30-year-old food seller said.

"They slapped me (and) kicked me. They were cocking their guns as if they are going to shoot me."

Many of the rapists used ethnic slurs against their victims, with a 28-year-old mother-of-two telling Amnesty that one of the four men who assaulted her called her a donkey while her daughter watched.

"He was saying: 'Amhara is a donkey, Amhara has massacred our people, the Federal Defence forces have raped my wife, now we can rape you as we want'." Another woman told Amnesty she

fell unconscious after TPLF fighters raped her and beat her, using the butts of their guns. The men also stole her jewellery after assaulting her, she said.

Amhara government officials told Amnesty more than 70 women reported rapes in Nifas Mewcha during the TPLF's nine-day rule over the town.

## 7 killed by crocodile at Ruvu crossing the river

Seven people are claimed to have been killed by crocodiles since January, this year as they were crossing Ruvu river to nearby villages in Mbwawa Ward in Kibaha district, Coast region.

Crocodiles attacks to residents along Ruvu river have become a big threat in the area.

Mbwawa ward Councillor Judith Mluge says the beasts are not only a threat to human beings, but also to the livestock whenever they approach the river bank to drink water.

She added that despite government efforts to send in wildlife personnel to harvest the reptiles, the task has been difficult because they are not easily spotted the situation that has made many people believe that they are associated with witchcraft.

The councillor said they have taken various steps by reporting the matter to the district council and the ministry responsible, but despite the dispatch of wildlife officials, it was difficult to kill the beasts because the permits for the same are often issued when the river's water level is high making the entire exercise hard to accomplish.

However, she said there is an alternative for a bridge to be built in order to solve the

Speaking to this paper, Judith said the complaints have been around for a long time that now needs a bridge, or a ferry, and said already they have referred the issue to TANROADS officials in Coast region.

She said 90 per cent of Mbwawa ward residents depend on farming hence they have to cross the river using crude canoes to attend to their farms on the other side.

## Support local think tanks, VP exhorts private sector

VICE President Dr Philip Mpango yesterday appealed to the business community to start supporting research organizations so as to reduce reliance on foreign donations.

Dr Mpango said private think tanks fail to produce quality studies for national development because of lack of local resources, urging private sector entities to support their efforts.

His remarks came during the officiating of the 25th annual research workshop organised by the economic research outfit, REPOA, themed "Transforming the Tanzanian economy through competitive manufacturing and trade."

He said this year's theme "dovetails very well that of the Third National Five Year Development Plan 2021/22 -2025/26, of "Realizing Competitiveness and Industrializations for Human Development," underlining that it was important for the private sector to start supporting local think tanks to enable them produce quality research.

Dr Mpango hailed contributions made by development partners in supporting REPOA's missions adding that it was a time for the private sector to support the researcher's organizations.

He said since its inception, REPOA has made a notable contribution to policy research which enabled the country to shift to a middle income country.

"I call on the private sector to take the role of supporting our local think tanks to enable them to produce quality research that has a positive contribution to the nation's development," he added.

"We, as a government, will continue to put in place an enabling environment for local think tanks to pursue their missions to produce high quality policy, capacity building and engagement in national policy," he assured.

According to the VP, the government has a strong desire to transform the economy so that we can accelerate the speed towards attaining a higher income status, through industrial development, promoting value chains in agriculture, livestock, mining, and

Dr Mpango urged the private sector to appreciate and proactively support research work in the country noting that in the 21th century you cannot succeed without research.

He said since technology was changing rapidly, global competition was intensifying and every country struggled to overtake the other therefore, it was productive to invest in supporting the local think tanks to inform decision making.

He tasked the think tanks to come up with suggestions to transform small ones into medium and large and to attract larger industries saying that out of 8,477 industrial establishments, 92 percent are small or very small, 5.4 percent are medium, and 2 are large

He said REPOA should also undertake assessments of all strategic crops, forest products as well as minerals to improve value chains that remain under developed and many commodities are exported in raw form

Minister for Industries and Trade, Prof Kitilla Mkumbo said the government has used research in various ways to transform the country's economy adding that it had all the time.

He said the collaboration with local thank tanks signifies the government commitment to engage civil society organizations.

"We're willing to learn from findings presented by our researchers and work to their advice", he said, adding: "We want more research findings that can enable us to transform from relying on natural resources to manufacturing."

According to him, developed countries have embarked on manufacturing from relying on natural resources.

REPOA executive director, Dr. Donald Mmari said out of 7800 research institutes 7.5 percent are in Africa.

He said out of those 30 percent are in danger of being closed due to lack of funds.

## Government ramps up efforts to tackle female genital mutilation

The government has reiterated its commitment to end FGM, child marriage and teenage pregnancies. Deputy Minister for Health, Community Development, Gender, Elderly and Children Mwanaidi Ali Khamis has vehemently castigated female genital mutilation (FGM) and called on the perpetrators to stop the practice at once.

The deputy minister made the remarks here yesterday at the launch of the national strategy against FGM and called upon all stakeholders to continue fighting the vice adding that the government recognizes and appreciates their efforts to rescue young girls.

Female genital mutilation (FGM), also known as female genital cutting, female genital mutilation/cutting (FGM/C) and female circumcision, is the practice of cutting or removing the external female genitalia without medical justification or consent. The practice is found in some countries

from countries in which FGM is common. UNICEF estimated, in 2016, that 200 million women in 30 countries-Indonesia, Iraqi Kurdistan, Yemen, and 27 African countries-had been subjected to one or more types of FGM.

Typically carried out by a traditional circumciser using a blade, FGM is conducted from days after birth to puberty and beyond. In half of the countries for which national figures are available, most girls are cut before the age of five. Procedures of FGM/C differ according to the country or ethnic group. It can include ritual nicking of the clitoral hood or removal of the clitoral hood.

Mwanaidi mobilised stakeholders to continue the fight against FGM to rescue small children from the vice. Earlier, speaking at the event, the Health Ministry's Permanent Secretary (Community Development Department) Dr John Jingu said customs and traditions of Africa, Asia and the Middle East, to prepare girls to adulthood can

and within communities abroad be done without subjecting them to FGM.

> "There are good things in preparing the youth for adulthood, but FGM is not one of them, we have a big task before us to change the society's mind sets and if possible we should find alternative methods to develop our customs and traditions," he said.

Submitting the work plan for implementing the National Strategy Against FGM to the stakeholders, project manager from AMREF Health Africa, Dr Jane Semfano said acts of FGM in the country have gone down saying 1996 statistics the prevalence was 18 per cent while the research done in 2015/16 showed every one girl out of ten underwent FGM.

One of the retired circumcisers from Singida Region, Hawa Hussein said female circumcision was dangerous because she witnessed many adverse effects including deaths in her own hands; hence she called on all circumcisers to down tools.

and bajaj riders who don't obey traffic laws and many of them have no licenses, in turn contriubute to road accidents in the municipality," Abri said, urging RTO to continue providing education to the people because there is a huge congestion of heavy vehicles passing through Iringa Town that is causing traffic problems.

Iringa Regional Police Commander (RPC), Assistant Commissioner of Police (ACP) Juma Bwire mentioned place within the Iringa region, where he urged drivers to be vigilant in the performance of their duties.

According to the 2020 figures, there were 28 accidents in which 48 people were killed including 41 men and seven women but in the year 2021 the number of accidents decreased to 24, where the casualties were 29 women 11 and 18 men.

The issue has been raised again and again in the UPR sessions in 2011, 2016 and now 2021.It is unacceptable for the country to embrace marrying off our young girls at the time where most

Tanzanians are well educated. The court has decided that the age is not valid, the same should be used to amend the law," stressed Urrio.

The Marriage Act through its section 13 (1) is in contradiction with not only the Law of the Child Act of 2009 but also the Convention on the Rights of the Child.

Article 1 of the Convention on the Rights of the Child defines a child as every human being below the age of eighteen years unless under the law applicable to the child, majority is attained earlier.

Concurrently, the Law of the Child Act of 2009 under its Article 2: defines a "Child" as any person who is below the age of 18 years.

The Law of the Child Act, 2009 (Act No. 21 of 2009) (Cap. 13) provides for reform and consolidation of laws relating to children, to stipulate rights of the child.

It is further meant to promote, protect and maintain the welfare of a child with a view to giving effect to international and regional conventions on the rights of the

He said schools were still being faced by the shortage of classrooms, the situation that was causing students congestion, especially in preparatory and primary levels.

He said his ministry has mobilized itself to find permanent solutions to all challenges and the government has set aside 69bn/- for improving the education sector.

## **Govt allocates** 18bn/- for road construction in Geita Region

THE government has set aside 18bn/- for the construction of three roads in Geita Region.

Geita Regional Commissioner, Rosemary Senyamule disclosed this yesterday when opening a oneday training seminar for transport stakeholders on the East African Community Vehicle Load Control Act, 2016 and its 2018 Regulations.

"In its 2021/22 Budget, the Ministry for Works and Transport, through TANROADS allocated 10bn/- for the construction of 50km Nyamirembe-Katoke road, 6bn/- for the 33km Geita-Kahama road, and 2bn/- for 54km Geita-Nzega road," said RC Senvamule.

She called on TANROADS to widen its scope in educating onroad weight laws in order to do away with challenges on road destruction done by overloaded vehicles as the government spends vast amounts of money to repair them.

Reading his report to the official guest, TANROADS Acting Manager for Geita Region, Eng. Gladson Yohana said the seminar on the 2016 East African Community Vehicle Load Control Act and its 2018 Regulations began to be held in Dar es Salaam, Mtwara, Morogoro, Dodoma, Njombe, Mbeya, Rukwa, Kigoma, and after Geita Region other regions will follow.

For his part, Weigh Bridge Supervisor from the Works and Transport Ministry, Leonard Saukwa told reporters that the government has introduced a levy for vehicles

exceeding the permitted load weight to protect the country's road infrastructures.

He added that the levies change after every ten years due to changes in road construction costs.

On their part, transport stakeholders who attended the seminar at different times said what confuses truck owners is for one weighbridge reading different weights to the preceding weighbridge and hoped that via the seminar they will come to understand how and why that happens.

The East African Community Vehicle Load Control Act, 2016, and its 2018 Regulations are being applied by EA Community Member States and officially began operating in March 2019.

## TFA requests govt to provide 1,250acre farm for sunflower cultivation

TANZANIA Farmers Association (TFA) has appealed to the government to provide it with more than 1,250-acre for sunflower seeds cultivation aimed at alleviating the shortage of edible oil in the country, the shortage that compels the government to spend billions to import it.

TFA Board Chairman, Peter Sirikwa made the remarks at TFA shareholders meeting held here

He said they have submitted the request to the Ministry of Agriculture in writing and were waiting for the response.

Sirikwa said to achieve this aim, TFA was also appealing to the government to access to ordinary loans to enable it produce quality sunflower seeds to make them available to farmers at affordable

"Our goal is to increase the availability of quality sunflower seeds at affordable cost in order to increase edible oil production," he

He further said the Association continues to work together with the government in the imports of farm inputs including fertiliser, pesticides to make them easily available to farmers.

He further disclosed that TFA has begun producing various types of farm inputs including fertiliser registered under the name TFA and whose quality has been certified by the farm inputs regulator.

Speaking on behalf of the finance and Planning Minister Dr Mwigulu Nchemba, Mbeya Regional commissioner Juma Homera praised the Association for its creativity in wanting to produce sunflower seeds

in the country at the moment.

Homera said sunflower is among the country's strategic crops which the government has prioritized for its increased production in collaboration with various stakeholders including the private sector.

He said TFA was essential for the

national development from its great

assistance to farmers in accessing farm inputs at affordable cost and called on it to also assist farmers to find markets for their crops.

TFA Vice-Chairperson, Cathy-Elizabeth Long'way said the association has more than 5,000 with not more than 1,500 active members due to various reasons.

She said some of the members despaired years back when the association was making losses and added that they should now return to the fold to develop their shares as saying the seeds were in high demand the situation has greatly improved.

## Weather forecasting has a long way to go

government to modernise weather forecasting includes the setting up of a network of seven weather-specialised radar facilities, where five are in existence and two are billed for construction,, in Dodoma and Kilimanjaro regions respectively. Those already in operation are stationed in Dar es Salaam, Mwanza and Mtwara, often in rural outposts suitable for setting up such facilities. This additional focus shall more intensely cover weather patterns over the respective areas, in which case a modification of weather forecasting can be practiced.

At the moment the pattern of weather forecasting is to collect the data from the various stations and figure out the patterns likely for the various zones, and then issue periodic updates of what to expect in the next month or two, and somewhat longer projections. This has definitely helped to create an overall impression of where the country stands with regard to rainfall prospects, for instance at this moment it is clearly known that the country will be enveloped by a relatively warmer and rather drier period. That is, up to major rains in April (or starting somewhat earlier).

Even without using much time glancing at the news pieces involved aside from an actual weather patterns documentary which is out of reach for the general public - it is clear that the broad intention is the grain cultivation outlook. Grain prospects are vital for economic life as a whole as underproduction of the vital food stock, maize for that

by matter, rattles markets and creates a negative situation for checking inflation as a whole. In the current season there is the background of a bumper harvest before oil prices rose; a poor harvest and oil price rise is risy.

> Yet there is an ares where weather forecasts are equally applicable but are hardly being used, one reason being that they aren't detailed enough, but at the same time the sphere involved, mainly horticulture, is often identified with irrigation farming. So forecasting here may relate to relative supply of water or if any crisis is developing as to sources of irrigation water as horticultural crops often fetch astronomical prices in world markets, and provoke frenetic expansion of farms. It is bad for conservation as villagers and even district authorities push back conservation limits.

There are other areas which could definitely make greater use of weatherforecastingiftheireconomic activities were technologically improved, for instance harvesting grass for later use in case there are good rains during end year periods or long rains season. Cattle can't be grazed on all grassy areas when there is plenty of grass but lack of grass harvesting techniques wastes such resource to dry out, depend on rains for grass to come up again in good time.

With unpredictable rainfall patterns in the climate change context, this can be rectified, but it requires that grazing land be mapped out and leased to individuals for long periods, so that economics can flourish.

## Women's empowerment academy could also focus on bigger markets

heard from women's empowerment organizations the United States working with counterparts in the country, to teach entrepreneurial skills to women in selected spots around the country. So far a batch of 32 women has been put to 13 weeks of training in commerce and entrepreneurship, courtesy of a US Academy of Women Entrepreneurs (AWE) programme. This effort is consonant with usual US targeted development efforts, which have a women's empowerment resonance and quite often targeting youths to access applicable skills.

With statutory initiatives like setting aside 10 per cent of district council earnings for loaning to women and youth, as well as a battery of other instruments by small and medium financial institutions, there is plenty that a woman with usable skills can put herself to do. The overall goal is to make women more visible in independent economic activities that have a good chance of weathering the challenges that start ups ordinarily face, as a dimension of empowerment as a whole. It changes the face of society as it generates more equitable, less violent domestic ties.

When initiatives of this sort are put up, one unavoidable parameter that each prospective unit that the newly fangled entrepreneurs will be putting their minds to sort out is markets. Too often small investment units pile up usable cash into an effort that is somewhat misplaced and soon runs out of steam, abundant examples being in money

TEW efforts are being transfer (taking over from selling mobile phone vouchers at the start), that the supply of innovators soon clouds out effective market need for the service. That is obviously the case within the perimeter where the service is being offered.

At the political level, there is considerable emphasis on agricultural initiatives especially in export-oriented farming, whether it is traditional cash crops or horticultural produce. Here it is easy to notice that the kind of enterprise that women entrepreneurs can more easily pursue are linked with limited possibility of accessing wide expanses of land, which characterises most traditional cash crops. It follows that limited access to rentable farms for instance, or urban business premises for service pursuits, are more suitable for women entrepreneurs, generally.

One area that is hard to fathom by a random effort is how far there is possible convergence between entrepreneurship opportunities and market feasibility, as it is evident that the rate of failure of start ups is usually high. Yet this failure doesn't always reflect limited total demand but poor location or market focus, etc and without widening markets, increased uptake, no science of how to locate markets can help any sort of entrepreneurs, not just women or youth starters as in this case. That is where complex economic issues come up, that instead of just offering training for entrepreneurs, US agencies can set up recyclable loan facilities in banks to ease lending, the acquisition of landed property to enhance overall circulation of money, widening target markets.



## Editors and life beyond the newsroom

HE best of Nigerian editors gathered in Abuja last month for the 17th All Nigeria Editors' Conference (ANEC). The theme was, Media in Times of Crises: Resolving Conflict, Achieving Consensus. It was all about national security including food security, energy security, among others.

The Managing Director/CEO of the Nigeria Incentive-Based Risk Sharing System for Agricultural Lending (NIRSAL), Aliyu Abdulhameed, was one of the resource persons. He spoke on Accessing Capital for Alternative Career Development for Editors. But it was more than

It was an eye opener for Nigerian editors, some of whom are already fiddling with farming but largely on a low scale due to dearth of capital. It was therefore fitting that NIRSAL was on hand not only to encourage editors to look to agriculture for a better tomorrow but also to use their respective platforms to tell Nigerians the good news of a new lease in agribusiness under President Muhammadu Buhari.

For emphasis, NIRSAL was launched in 2011 and incorporated in 2013 wholly by the Central Bank of Nigeria (CBN). It is not a direct money-lending financial institution like commercial banks but it acts as guarantor of loans. It is the unseen hand behind the agriculture revolution that has come to define the Buhari government, a revolution evidenced by the jump in the number of employments created in the agribusiness sector through a deepening of the agribusiness value

The statistics are in your face. By the second quarter of this year, the contribution of agriculture to GDP stood at 23.78 percent, followed by Information and Communication at 17.92%, according to the National Bureau of Statistics, NBS.

Over 12 million Nigerians are today actively engaged in the agriculture value chain. The rice dunes in Kebbi, the busy rice mills in Ebonyi, Edo et al, speak of a new dawn in Nigeria's quest to achieve food security. Add to the list, the revival in cocoa farming and export, the rubber plantations and latex production; rice, cassava, palm produce and many others including poultry that constitute a staple in Nigeria are being produced in commercial quantity with value addition in a manner never before

In a world roiled by climate change, insecurity, hunger and poverty, delivering and deepening the agriculture value chain is touted



ultimately reduce poverty and ship more people out of the breadline.

The World Bank, Food and Agriculture Organisation (FAO), among other relevant bodies have continued to advocate for more people to be mainstreamed into agriculture especially among developing nations. This, they argue can be achieved through structured financing that would reduce loan risks and ensure inclusivity of more players in the value chain.

This is what NIRSAL is doing in Nigeria: Facilitating and de-risking loans. Under Abdulhameed, it has improved the nation's agribusiness, making the 'farm-to-fork' mantra a reality. Statistics showed that NIRSAL has facilitated investment the tune of N165.4billion; created over 590,000 employment; impacted 3.5million lives; provided guidance on the establishment of Risk Sharing Facility (RSF) models for African countries under the aegis of the African Development Bank (AfDB). This is an international endorsement that the Nigerian model of agribusiness risk-sharing model is not only working but a worthy example for other African

On account of the roaring success of the Nigerian model, NIRSAL recently concluded the setting up of the Togo Incentive-Based Risk Sharing System for Agricultural Lending (TIRSAL) locally popular by its French acronym, MIFA. Other African nations including Ghana and Benin Republic are on the queue to benefit from the Nigerian model.

The success of NIRSAL points to a glorious tomorrow for Nigeria, nay Africa, in the march towards food security. Nigeria, especially, is endowed with vast arable land capable of growing an assortment of crops. But the challenge has been the lack of funding for agribusiness. This has also been the challenge of many journalists and other professionals who desire strongly to venture into agriculture on a commercial scale.

But Abdulhameed successfully assuaged the anxiety of editors over availability of funds when he said that so far over N134.64 billion loans and investments had been facilitated by CRG; over 760 projects guaranteed, over N1.4 billion interest draw back paid; and N4.6 billion claims paid to date with N4.09 billion recovered. He presentation outlined the various opportunities and entry points within the value chain where editors can take advantage of and participate actively. And NIRSAL is willing to do more; he assured.

For instance, he said Nigerian editors can be a part of NIRSAL's Agro Geo-Cooperative Formation (AGC) initiative by participating in the AGC formation process. The AGC helps to dimension the agribusiness value chain from production to marketing, making it possible for players to play more than passive roles in the value chain. Benefits of the AGC initiative include: Mechanization, improved inputs, exposure to modern agricultural technologies, mentorship and monitoring, governance and positive peer pressures with concomitant peer review, secure supply for markets (quality and quantity), controlled loan repayment, among others.

Simply put, editors in Nigeria can form their own cooperative for the sole purpose of accessing loans and sundry benefits that accrue from the NIRSAL initiative. It gives the editors a stronger platform for negotiation. It makes them competitive and avails them the opportunity to build

production as well as marketing synergies.

Abdulhameed wants Nigerian editors to take advantage of the inherent opportunities in the nation's agricultural value chain and NIRSAL's agriculture/agribusiness finance facilitation and de-risking value offerings. He is inviting editors to become agribusiness people, playing active roles in production, processing and marketing of agriculture produce. The invitation was handy. It came at a time Nigerian editors were pondering and tinkering with survival strategies for life after the chair; how to still live a good, productive life outside the newsroom.

NIRSAL has evoked huge interest in agribusiness among Nigerians, particularly among editors. And the opportunities and focus are as diverse as the natural diversity of the nation. Opportunities abound in fruits and vegetables, hibiscus (this is beyond flower, it's money wrapped in beautiful red petals), sesame, cashew, ginger, shea nuts (collection and processing), rice, beans, cotton (including processing to thread), livestock (poultry, beef, dairy), maize, soya, potato (sweet & Irish), aquaculture, wheat, sugar cane farming and processing.. It is a long list and it speaks to the unsearchable riches of the Nigerian soil. Those riches beckon on Nigerians, on editors, doctors, engineers, lawyers, etcetera. The strong hand of NIRSAL is outstretched to help them turn potential to produce.

Abdulhameed was all smiles when he extended an open invitation to Nigerian editors, and indeed to other Nigerians. His message was: Take advantage of NIRSAL and let's turn your dream to reality. The ball now rests invitingly in the court of

## Climate Africa: Resilience and adaptation

**66** It is not the strongest of the species that survives, nor the most intelligent. It is the one most adaptable to change". Charles Darwin (1809-1882).

I would like, at the outset, to congratulate Aliu Akoshile, Publisher and Editor-in-Chief and the Team at NatureNews Africa, for making it through what has been, globally, a very difficult year.

Covid-19 has caused havoc to the extent that we can only meet virtually, at least for the time being. One year of existence under the conditions of the coronavirus is something worthwhile to celebrate. Bravo Team NatureNews Africa.

The 26th Conference of the Parties to the United Nations Convention on Climate Change (COP26) is right now in session in Glasgow, Scotland, (Oct 31 to Nov 12).

The expectations are high. I must add that it depends on one's perception of success when it comes to global negotiations on climate change.

My anticipation is measured and is borne out of a long experience of participating in a number of Conferences of the Parties.

I had the unenviable yet unique task of chairing the group of 133+countries, the Group of 77 (G77) and speaking for the G77 and China in 1997 during the negotiations which led to the adoption of the Kyoto Protocol, a multilateral instrument that was the precursor to the Paris Agreement.

I worked closely with Mohammad Sanusi Barkindo (Nigeria), Bernarditas Muller (The Philippines), Rungano Karimanzira (Zimbabwe), Madeleine Diuf (Senegal), Mohamed Salem al Saban (Saudi Arabia), Zhenmin Liu (China), Tuiloma Neroni Slade (Samoa), Buruhani Salum Nyenzi (Tanzania), Eric Mugurusi (Tanzania), Verdiana Macha (Tanzania), and other delegates.

My friend, colleague and fellow university alumnus Abdoulaye Bathily was then Minister for Environment of Senegal.

Background. In 1985, scientists from across the world met in Villach, Austria, under the auspices of the World Meteorological Organisation (WMO), the United Nations Environment Programme (UNEP) and the International Council of Scientific Unions (ICSU) in order to discuss the effect of greenhouse gases on the climate. They concluded that climate change was plausible and its occurrence a serious probability.

From then onwards, a number of studies and meetings have supported these conclusions. Policies for the reduction of greenhouse gases (mitigation) and strategies to minimise the impact of climate change (adaptation) were proposed.

These efforts led to the establishment of the International Panel on Climate Change (IPCC) in 1988 and the inception of World Climate Conferences.

The United Nations took the lead in the matter and the United Nations Framework Convention on Climate Change was signed by 154 states in Rio de Janeiro, Brazil, at the 'Earth Summit' held in June 1992.

The main objective of the Convention is "to achieve stabilisation of greenhouse gas concentration in the atmosphere at a level that would prevent dangerous anthropogenic interference with the climate system"

The objective has a timeframe that is "sufficient to allow eco-systems to adapt naturally to climate change to ensure that food production is not threatened and to enable economic development to proceed in a sustainable manner"

Through the Convention structure, intergovernmental negotiations take place under its Conference of Parties arrangements.

The main objective of these negotiations is to arrive at a global consensus on the setting of, and agreeing upon, the temperature increase beyond which the earth would be propelled into catastrophic circumstances, and how to adapt to the impacts of climate change that are now discernible.

I attended the first Conference of the Parties (COPI) to the Convention which took place in Berlin in March/ April 1995. Angela Merkel, the then Minister of the Federal Republic of



Germany responsible for the environment, nature conservation and nuclear safety, was the president of COP1

The ongoing multilateral discussions on climate change have resulted from the decisions taken at COP1, and specifically Decision 1 of COP1 (the Berlin Mandate).

COP1 reviewed the implementation by member states of their obligations under the Convention and found them inadequate in the quest for the stabilisation of the global climate system.

Therefore, the Conference decided to kick-start a process to strengthen the commitments of developed countries through the setting of quantified limitation and reduction objectives, within specified timeframes.

It was mindful of the global nature of climate change, which calls for "widest possible cooperation by all countries and their participation in effective and appropriate international response, in accordance with their common but differentiated responsibilities and respective capabilities and their social and economic conditions".

The negotiations during subsequent COPs have centred on the review of the commitments and obligations of member states in the furtherance of the objective of the Convention, informed by science. The foregoing provides the context for COP26 meeting in Glasgow.

The industrialised world is responsible for historic emissions concentrations. The Kyoto Protocol did set quantified limitation and reduction objectives within specified timeframes for them.

However, even at that early stage, it was realised that emerging nations, such China and India, were on a trajectory to overtake developed nations in 'current emissions'.

The Paris Agreement has as its goal the limiting of global warming to well below 2 degrees, preferably to 1.5 degrees Celsius, compared to pre-industrial levels. Greenhouse gas emissions peaking before, and neutrality by 2050, is central to the achievement of the temperature

Unlike the Kyoto Protocol, which targeted industrialised countries only in greenhouse gas mitigation, the Paris Agreement embraces all nations within the remit of the Convention. Poverty reduction is the paramount objective for Africa and developing countries in general. Climate change has become an added burden.

Greenhouse gas emissions from them are minimal. According to the Brookings Institute, Africa contributes about 3.8 per cent of global greenhouse gas emissions. Consequences of climate change, however, are more marked and more severe in developing countries owing to their inability to meet the costs of vulnerability and adaptation.

In the book I wrote in the aftermath of Kyoto, I referred to emissions by developing countries as 'survival emissions', those emissions that are absolutely necessary to eradicate poverty and achieve sustainable development.

The Paris Agreement adopts the principle of common but differentiated responsibilities among nations by recognizing that peaking, and greenhouse gas emissions neutrality, will take longer for developing countries to achieve.

Central in the ongoing discussions in Glasgow is the authenticity of goals set by industrialised countries to attain greenhouse gas emission peaking and neutrality. The phasing out of coal is bound to feature prominently.

In respect of coal, it will be interesting to hear the positions of the United States, Australia, Japan, Germany, China, India, South Africa and other coal producers and users.

Low to zero-carbon technologies (and the transition to renewable en-

ergy technologies) and other solutions, which are required in mitigating climate change, should form an important part of the negotiations.

It is worthwhile to bear in mind that the development and ownership of the technologies is largely the preserve of developed countries.

Developing countries constitute a disparate group. They include: India and China; highly populated, huge economies and high greenhouse gas emitting countries; and the African continent.

The classification also includes petroleum-producing countries, mainly members of the Organisation of the Petroleum Exporting Countries (OPEC) and associated petroleum producers.

The main concern of the latter group relates to the sustainability of their economies in the light of future declines in demand for petroleum.

Small island states are highly vulnerable to sea water level rises. They are, and rightly so, the conscience of the world when it comes to forcing the pace of negotiations. They are likely to demand, as they have done so often, that nations take drastic actions, urgently, to avert a looming catastrophe.

Many foreigners consider Africa to be, or think that it is, a country. Perhaps it should be. It is a continent comprising 55 countries of different sizes, geography, natural resources, and wealth and poverty levels.

According to the United Nations Department of Economic and Social Affairs, 46 countries are categorised as Least Developing Countries (LDCs) - 33 of them in Africa.

LDCs are "low-income countries confronting severe structural impediments to sustainable development. They are highly vulnerable to economic and environmental shocks and have low levels of human assets".

They include: Angola, petroleum producing, OPEC member and mineral rich; the Democratic Republic of Congo, mineral rich and bearer of a large forest and carbon sink of global importance; Chad, Burkina Faso, Senegal, Mali and other Sahelian countries.

Also in the category are: Burundi, Rwanda, Zambia, Malawi and other land-locked countries; eastern and Southern African states of Mozambique, Lesotho, Tanzania, Uganda, South Sudan, Sudan Somali, and Ethiopia; and the small island states such as Cabo Verde, Sao Tome and Principe, and the Comoros.

There are many manifestations of long-term climate impacts in Africa. They include: the steady expansion of the Sahara Desert; the shrinking of Lake Chad by a staggering 95 per cent between 1963 and 1998; and the severe floods of Sudan and South Sudan.

Among the others: the drying up of the Lake Faguibine system in Mali; the disappearance of Maziwe Island in the Indian Ocean in coastal Tanzania; the shrinking of the glacier on Mount Kilimanjaro.

Internecine conflicts are now more climate-related than in the past, taking the form of clashes between cattle herders and farmers.

Africa has been resilient to disasters, both human-induced and natural. These have in the past included slave trade, colonialism, internecine wars and pandemics.

African populations have over the centuries shown resilience to climate variability. However, climate change resulting from humaninduced global warming is upsetting life patterns and livelihood.

Water scarcity and the resulting food insecurity are indicators of climate variability and climate change. Water scarcity calls for efficient management of transboundary and internal water basins. The mantra should be 'more produce per less drop of water'.

## Indigenous peoples want to move towards clean energy sovereignty

**GLASGOW** 

n the community of Bella Bella on Turtle Island in the western Canadian province of British Columbia, the indigenous Heiltsuk people capture heat from the air through devices in 40 percent of their homes, in a plan aimed at sustainable energy sovereignty.

"We use less energy, pay less, and that's good for our health," Leona Humchitt, a member of the Heiltsuk

community, told IPS during a forum energy poverty, paving the transion indigenous micro-grids in the tion to cleaner sources and combatso-called Green Zone of the climate summit being hosted by Glasgow, Scotland since Oct. 31. "The project coincides with our view. We need to have a good relationship with nature."

For native groups, these initiatives mean moving towards energy sovereignty to avoid dependence on projects that have no connection to local populations, combating

ing the exclusion they suffer in the renewable energies sector due to government policies and corporate decisions.

The modernisation process that began in the first quarter of 2021 lowered electricity rates from 2,880 dollars a year to about 1,200 dollars for each participating household.

In addition, the switch to heat pumps eliminates five tons of pol-

lutant emissions per year and has reduced the community's annual diesel consumption of 2,000 litres per household, which is usually supplied by a private hydroelectric

Funded by the Canadian government and nongovernmental organisations, the "Strategic Fuel Switching" project is part of the Heiltsuk Climate Action plan, which also includes measures such as biofuel and biomass from marine algae and carbon credits from marine ecosystems.

In 2017, more than 250 remote indigenous communities, out of 292 in Canada, relied on their own electricity microgeneration grids, dependent especially on diesel generators.

The venture in the Heiltsuk community, which is part of the three major Canadian native peoples, is included in a portfolio of indigenous transitional energy initiatives that have been incorporated into the nongovernmental Indigenous Clean Energy (ICE) social enterprise in Canada.

A global hub for soentrepreneurship was one of the initiatives launched in the Green Zone, an open event held parallel to the 26th Conference of the Parties (COP26) to the United Nations Framework Convention on Climate Change (UNFCCC), whose annual session ends Nov. 12.

ICE has a list of 197 projects - 72 in bioenergy, 127 in energy efficiency, and 19 in other alternative sources - with more than one megawatt of installed capacity. These initiatives together represent 1.49 billion dollars in revenue over 10 years.

Mihskakwan James Harper, an indigenous man from the Cree people of Sturgeon Lake in the western Canadian province of Alberta, said it is not only about energy sovereignty, but also

about community power to dispose of their own resources.

"We change our selfconsumption and the communities benefit themselves from the energy, and the earth get benefits as well. Without us, we are not going to reach the climate goals. We show that indigenous peoples can bring innovations and solutions to the climate crisis," Harper, who is development manager at the NR Stor energy company, told IPS.

NR Stor Inc. and the Six Nations of the Grand River Development Corporation in the Canadian province of Ontario are building the Oneida battery storage project - with a capacity of 250 MW and an investment of 400 million dollars - in the south of the province.

The facility, which will prevent some 4.1 million tons of pollutant emissions, the largest of its kind in Canada and one of the largest in the world, will provide clean and stable energy capacity by storing renewable energy off-peak for release when demand rises.

ICE estimates 4.3 billion dollars in investments lectric plant to benefit two are needed to underpin this energy efficiency that would create some 73,000 direct and indirect jobs and would cut carbon dioxide emissions by more than five million tons over 10 years.

### **Slow progress**

The increase in clean sources plays a decisive role in achieving one of the 17 Sustainable Development Goals (SDGs) set out in 2015 by the international community in the 2030 Agenda, within the framework of the United Nations.

SDG 7 is aimed at affordable, modern energy for all.

**But processes similar** to Canada's ICE are proceeding at a slow pace.

Two projects of the Right Energy Partnership with Indigenous Peoples (REP), launched in 2018 by the non-governmental Indigenous Peoples Major Group for Sustainable Development, are being implemented in El Salvador and Honduras.

In El Salvador, the project is "Access to photovoltaic energy for indigenous peoples", carried out since 2020 in conjunction with the non-governmental National Salvadoran Indigenous Coordination Council (CCNIS).

It is financed with 150,000 dollars from the Global Environment Facility (GEF) Small Grants Programme to provide 24 solar power systems to three communities in the town of Guatajiagua, in the eastern department of Morazán.

In Honduras, the Lenca Indigenous Community Council and the Pro Construction Committee are installing a mini-hydroe-Lenca indigenous communities in the municipality of San Francisco de Opalaca, in the southwestern department of Intibucá.

The project "Hydroelectric power generation for environmental protection and socioeconomic development in the Lenca communities of Plan de Barrios and El Zapotillo", launched in 2019, received 150,000 dollars in GEF funding.

Clean alternative sources face community distrust due to human rights violations committed by wind, solar and

hydroelectric plant owners in countries such as Colombia, Honduras and Mexico, including land dispossession, contracts harmful to local communities and lack of free consultation and adequate information prior to project design.

The evolution of energy initiatives has been slow, due to funding barriers and the limitations imposed by the covid-19 pandemic.

"Our main interest is to enable access to affordable renewable energy and for indigenous peoples to participate in the projects," Eileen Mairena-Cunningham, REP project coordinator, told IPS.

"These processes should be led by indigenous organisations. Of course we are interested in participating in the global networks," added the Miskita indigenous woman from Nicaragua.

After the always difficult first step, indigenous communities want to accelerate progress towards these goals.

In Bella Bella, Canada, the hope is to progressively replace diesel with biofuel in vehicles and in the boats that are vital to the fishing community.

"We are not going to electrify transportation overnight," Humchitt said. "But we see an opportunity in biodiesel. We have to go forward on this issue."

Harper concurred with that vision. "Of course we want EVs, as they become accessible and satisfy our own needs. We want to get rid of diesel. The communities have to lead the process of the local transition," he said.

here are high chances that the leaders of the East African Community (EAC) will approve the application by DR Congo to join the regional bloc during the Heads of state summit scheduled to convene before this year ends, it has been learnt.

According to sources, Kinshasa presented a strong case for admission into the bloc. The 21st ordinary meeting of the Summit of the EAC Heads of State, held virtually on February 27 considered the application by DR Congo to join the Community and directed the Council of Ministers to expeditiously undertake a verification mission in accordance with the EAC procedure for admission of new members into the bloc and report to the next summit.

By September, a report by a regional verification mission on the DR Congo's eligibility to join the bloc was ready to be looked at by the Council of Ministers and Manasseh Nshuti, Rwanda's Minister of State for EAC Affairs, at the time indicated that it was positive.

The East African Busi-

ness Council (EABC) also urged EAC Heads of State to direct relevant organs to fast-track the admission of the DR Congo into the bloc.

On Tuesday, November 9, Nshuti told the Press that regional ministers in Charge of EAC Affairs are set to meet from November 26 to 27 in preparation for the Summit and that the "Council will confirm the date after agreeing on substantive issues to be presented to Heads of State."

Besides the exact date of the Summit, a venue will also be confirmed in due course.

Asked specifically about DR Congo's admission chances, he said: "As regards the entry of DR Congo, I am almost sure it [Summit] will approve admission."

Congolese President Félix Tshisekedi on June 8, 2019, wrote to the then EAC Chairman, President Paul Kagame of Rwanda, expressing his country's wish to be a member of the regional bloc now comprising Rwanda, Burundi, Uganda, Kenya, South Sudan and Tanza-

Ordinarily, the EAC Summit is held on November 30, which is EAC Day. The Summit is usually

"The Council will meet next week 26th to 27th; after that, the Chair can call for Summit. The Summit should be held this year."

## Covid-19 risk

Information about the next Summit's agenda is still scarce but the minister noted that leaders will focus on the "welfare of the people of the Community especially in the midst of the Covid-19 pandemic."

Nshuti said: "The impact of the pandemic on our economies and people and how, together, all the six countries, we can manage the situation, will be important. Covid-19 has hit all corners of our countries and we must look at mitigation measures jointly."

"Robust harmonized measures are critical. If, for example, we manage Covid-19 here in Rwanda, and neighbours don't we shall still be affected. We need to rethink how it impacted our economies and how best we can, as a community, respond collectively."

#### **Recruitment issues**

Nshuti also shed light on where things stand as regards efforts to sort out an unresolved recruitment dispute at the EAC Secretariat.

Nshuti noted that a Council meeting is scheduled for November 18 to 26 to look into the matter, again, and wrap things up.

He said: "We are meeting to see how to sort it out. It is an issue, basically about the quota system. It is being worked on. We should get it right this time. There were mistakes which we can be correct-

Ministers in charge of EAC affairs on October 19 pledged to address issues causing a standoff in the ongoing staff recruitment exercise after some regional lawmakers alleged that the process was marred with irregularities and unfair treatment of citizens from some coun-

The ongoing process of the recruitment of staff for the EAC, in general, aims to fill positions that have remained vacant for some years.

More than 15,000 applications were received from all partner states, delegates profiled and candidates subsequently shortlisted but interviews which were to commence on October 18 and end on November 2 could not commence as scheduled due to quorum.

Earlier, Uganda's EAC Affairs minister Rebecca Kadaga, wrote to the Secretary-General demanding that the interviews set for October 18 for various advertised jobs at the EAC organs and institutions be postponed until the Secretariat submits the available quota points for each country as at the time or date of advertising the

## The growth of Chinese traditional medicine in Africa threatens wildlife

Beijing-backed expansion of Traditional Chinese Medicine (TCM) in many African countries risks fuelling the illegal wildlife trade and threatens the future of some of the world's most endangered species, a new report has warned.

The growth of the TCM market, coupled with the perception of Africa as a potential source of TCM ingredients, is a "prescription for disaster for some endangered animal species, such as leopards, pangolins and rhinos", the London-based Environmental Investigation Agency (EIA), which investigates wildlife and environmental crime, said in the report published on Wednesday.

China has been promoting traditional medicine, which dates back more than 2,500 years, alongside its flagship Belt and Road Initiative, which is developing road, rail and other major infrastructure projects across Af-

are plant-based, demand from the industry has been blamed for pushing animals, including pangolins and rhinos, to the brink of extinction.

"Ultimately, the unfettered growth of TCM poses a serious threat to the biodiversity found in many African countries, all in the name of shortterm profit," EIA Wildlife Campaigner Ceres Kam said in a statement.

"Any utilisation threatened species in TCM could potentially

While most treatments stimulate further demand, incentivize wildlife crime and ultimately lead to overexploitation."

The report, Lethal Rem-

edy: How the promotion of some traditional Chinese medicine in Africa poses a major threat to endangered wildlife, said TCM products had never been more accessible in Africa, with TCM companies and clinics established in countries across the continent and Beijing stepping up promotional activities in line with the

COVID-19 pandemic.

It said some retailers were looking to establish complete supply chains from source to sales, and urged stricter oversight of TCM as well as government action to prevent the use of threatened wildlife in its products.

While China has sought to crack down on rare species in traditional medicine, there are still some who prescribe such remedies as aphrodisiacs or to treat illnesses from cancer to skin conditions. The status of a ban on the use of rhino horn and tiger parts imposed in 1993 and suddenly lifted in 2018 before the government made an apparent U-turn, remain uncertain.

"We understand that traditional medicine is integral to many cultures and plays an important role in healthcare in Africa and beyond,"

"Our very real concern is that such a huge expansion of TCM in Africa, as is happening under China's Belt and Road Initiative, will have the knockon effect of drastically increasing demand for treatments containing wildlife and, in turn, cause more species to become threatened or ex-

With the COVID-19 pandemic continuing, healthcare, including strengthening the ties between TCM and traditional African medicine, is likely to be a key issue at the forthcoming Forum on China-Africa Cooperation (FOCAC), which is due to start in Senegal later this month.

The EIA noted that South Africa, Cameroon, Tanzania and Togo were among African countries that had already signed agreements with China to develop TCM while South Africa and Namibia had recognized TCM as of their public health systems.

China replaced the United States as Africa's largest trading partner in 2009, and total trade topping \$200 billion in 2020, according to the Africa Center for Strategic Studies.

## Govt in to make financial sector contributes 10pc to GDP by 2030

THE government is determined to transform the financial Sector so that it contributes 10 percent to the country's gross domestic product (GDP) by 2030.

Presenting a paper recently in Dodoma, Finance and planning ministry assistant commissioner for financial sector. Dionisia Mjema said currently, the sector contributes only 3.7 per cent to the GDP, which is low.

She said: "We're working in a number of strides to reach the target including executing the Financial Sector Development Master Plan 2020/21-2029/30."

In the master plan, increasing financial literacy is one of the key aspects towards meeting the target, Mjema said, noting that the government intends to make 80 percent of the population aware of the financial matters by 2025, as a result of the implementation of the financial education programme.

"In realizing this long-time dream. the ministry, in collaboration with various stakeholders in the financial sector, has prepared a financial education teaching tool which has identified key areas of consideration during the provision of financial education to the public," she said.

These areas include personal finance management, saving, credit, investment, insurance, deposit insurance, taxes and bonds. The official described financial

sector as key in scaling up country's socio-economic development.

"This sector is like blood vessels in the human body," she said, pledging that the government will continue providing public awareness to deepen the financial markets and benefit people.

She said that the plan aims to make the country's financial sector strong and resilient due to its contribution and importance to the economy.

Dionisia said the implementation of the plan through regulatory authorities–Bank of Tanzania (BoT), Insurance Regulatory Authority (TIRA), Capital Markets and Securities Authority (CMSA) and Social Security Funds will make the financial sector grow and contribute to the economy and eradicate poverty.

According to 2017, Tanzania Fin-Scope Survey Of 2017, only 48.6 percent of the labour-force

use formal financial services and therefore many Tanzanians do not benefit from these services leading to missing opportunities to improve their livelihood through various economic activities and ultimately contribute to growth.

Ministry's commissioner for financial sector development, Dr Charles Mwamwaia said: "The ministry has organised the National Financial Services Week aimed at reaching various stakeholders.' Among the stakeholders, according Dr Mwamwaja include public servants, students, teachers, women, youth, people with special needs, small and medium entrepreneurs (SMEs), government organisations, editors and journalists, financial service providers - and the general public.

Financial services include banking, insurance, capital markets and social security schemes.

He said awareness on financial issues for Tanzanians was less than 50 percent, saying that level was causing people fail to understand the principles, benefits and financial strategies to grow their economy and the nation at large.

"It is difficult to find money but it is easy to lose it. Financial education has not reached many people, they have less than 50 percent and this jeopardizes social welfare because money is everything in achieving programmes, for small savings are important in supporting financial circulation," said Dr. Mwamwaja.

He also said the government's plan is to work with the Ministry of Education, Science and Technology, to develop a curriculum that will be specific to educating financially from school, saying that such education will increase awareness of the proper use of digital finance.

"The leading financial sector is through mobile phone companies, many citizens are using this service. The ministry's plan is to see the next 10 years Tanzanians reach out and become aware of services, official empowerment opportunities in our region but also globally," noted Dr. Mwamwaja.

He also said that the lack of awareness on financial issues is causing people to be unaware of their rights in the sector, and called on the public to participate in the ongoing National Financial Services Week in Dar es Salaam.

## UN's 'Indispensable Partners' barred from entering secretariat building

he United Nations has come under heavy fire for continuing a 20-monthlong ban on non-governmental organizations (NGOs)- even though the Secretariat is expected to return to near-normal by November 15 after a pandemic lockdown going back to March 2020.

Louis Charbonneau, UN Director of Human Rights Watch, told IPS: "The Secretary-General has repeatedly spoken of the vital importance of civil society to the proper functioning of the UN. Now he needs to prove he means it by re-admitting accredited NGOs - the only category of UN passholders still barred from entering UN headquarters.'

"We know certain countries are overjoyed that critical civil society voices on human rights and humanitarian issues are currently locked out of UN HQ. They probably want the ban to go on forever," he said.

If the Secretary-General truly considers civil society essential in ensuring the UN is accountable to the people of the world, he should end the ban on NGOs immediately as more than 60 UN member states have called for (at a meeting last week), said Charbonneau.

The staffers who were mostly teleworking from their homes are expected to back in the building next week. While diplomats were never barred from the UN during the lockdown- and while some "essential" staffers were permitted access to the building- all NGOs were banned from the premises. The UN has also refused to renew their passes to enter the headquarters building.


The mounting protests against the continued ban have come from several NGOs, most of whom have been partnering with the UN providing humanitarian assistance in conflictridden countries, including Afghanistan, Yemen, Syria, Libya, Sudan and

Sherine Tadros, Deputy Director of Advocacy, Amnesty International, told IPS: "It's wonderful that Secretary-General Guterres often speaks of how much he values civil society, it's great that he re-iterated recently that we are an integral part of the UN ecosystem".

"But that only makes it more difficult to understand why he continues to allow a situation where we are banned from entering the UN building in New York. We urge him to address this as a matter of urgency, so that we can do our work protecting human rights," said Tadros.

During an event marking the 75th anniversary of the UN Charter last year, Secretary-General Antonio Guterres said civil society groups were a vital voice at the San Francisco Conference (where the UN was inaugurated). "You have been with us across the decades, in refugee camps, in conference rooms, and in mobilizing communities in streets and town squares across the world."

"You are with us today as we face the COVID-19 pandemic. You are

our allies in upholding human rights and battling racism. You are indispensable partners in forging peace, pushing for climate action, advancing gender equality, delivering life-saving humanitarian aid and controlling the spread of deadly weapons. And the world's framework for shared progress, the Sustainable Development Goals, is unthinkable without you', he declared.

In an interview with IPS, James Paul, former Executive Director at the New York-based Global Policy Forum (GPF) said for many years, the UN has placed increasingly onerous restrictions on NGOs, especially with respect to NGO access to the UN headquarters in New York.

Hinting at the UN's political hypocrisy, he said that in spite of regular statements by the Secretary General that NGOs are "indispensable partners" of the organization, the UN has tightened the rules and steadily restricted the possibility for effective NGO action.

So, it comes as no surprise that the recent relaxation of Covid restrictions on delegations, staff journalists and other favored interlocutors has not been extended to NGOs, said Paul, author of "Of Foxes and Chickens", a critical analysis of Oligarchy and Global Power in the **UN Security Council.** 

He said the opening of the General Assembly in late September 2021 saw many journalists, large national delegations and a growing staff presence, but the UN kept the door firmly shut to NGOs.

Now, more than a month later, the portcullis is still down and there have been no encouraging statements from UN leaders that might suggest a lifting of the ban any time soon - or any plausible reasons given for this situation, he noted.

"Protests from the leaders of major human rights organizations have been to no avail. Is this, then, the beginning of the end of NGO active presence at the UN?" he asked.

Currently, there are thousands of NGOs worldwide who are either affiliated with the UN's Department of Global Communications or provided consultative status by the UN's Economic and Social Council (ECOSOC).

The UN says NGOs have been partners of the Department of Global Communications (DGC) since its establishment in 1947. Official relationships between DGC and NGOs date back to 1968.

The Economic and Social Council in its resolution 1297 called on DGC to associate NGOs with effective information programs in place and thus disseminate information about issues on the UN's agenda and the work of the Organization. Through associated NGOs, DGC seeks to reach people around the world and help them better understand the work and aims of the United Na-

Andreas Bummel, Executive Director, Democracy Without Borders told IPS civil society representatives need to be given access to the UN building and meetings on an equal basis compared to other stakehold-

"I cannot remember any time

when they were barred for so long while others had access. There is a growing suspicion that concerns related to Covid-19 safety are used as a pretext for restricting civic space. For too long, the UN Secretary-General has let this happen. It is overdue for him to intervene," said Bummel.

Michael Bröning, Executive Director of the Friedrich-Ebert-Stiftung

(FES) New York, told IPS: "Keeping the UN in New York Covid-free by making it a civil-society-free environment puts a whole new meaning to the notion of diplomatic immunity - and begs the question of protection at what price.'

Paul said some Western media outlets have sought to give the restrictions a false political spin, by claiming that the restrictions are due to the fact that the head of the UN department responsible for NGO accreditation is a Chinese national! This is pure propaganda.

The Western powers - in particular the United States and the United Kingdom - have been quietly pushing for more NGO restrictions and less funding for NGO-supportive UN "focal points" for more than two decades, even while they have been giving lip service to the cause of NGO access, he pointed out.

"This policy has come from dislike of NGO disarmament initiatives, disapproval of NGO social, economic and environmental campaigns, fury at NGO opposition to the Iraq conflict, and much more."

As early as 1999, he said, the Chef de Cabinet of the Secretary General issued draconian guidelines excluding NGOs from open access to the all-important second floor of the headquarters complex. More restrictions were to follow, often pushed by US police and security services as a response to "terrorist threats."

UN leaders started to talk about the "dangerous wave of NGOs," even though there was no measurable increase in NGO numbers, said

"The UN membership more generally has not stood up for NGOs against the pressure of the big powers. These smaller states are today

less supportive or even less tolerant of NGOs than they used to be, seeing NGOs as a source of embarrassment or annoying opposition on one topic or another."

At a time of increasingly right-wing governments, getting rid of opponents is a natural step for the new breed of diplomats. Even among friendlier governments, few are ready to use political capital to defend the creative and essential democratic role of these organizations, Paul added.

Meanwhile, he argued, they have applauded the UN's open door for business representatives, foundation bigwigs and other smooth-talking proponents of the international status quo, especially those with cash to spread around.

"An argument can be made that the exclusion of NGOs has gone so far and become so blatant that it has become a violation by the UN of its own Charter, which in Article 71 calls for the Economic and Social Council to establish "suitable arrangements for consultation" with NGOs.'

The UN leadership now says its "electronic platforms" are suitable, at least for the foreseeable future. But if this is so, why are others able to come and go while even the most respected NGO representatives are turned away?

"This may be the time to bring the UN to legal accountability. Could a case be brought in an appropriate legal body (perhaps the World Court) to test the matter?" asked Paul.

Meanwhile, Dr Agnes Callamard, Secretary-General of Amnesty International and Kenneth Roth, Executive Director of Human Rights Watch, wrote a strong letter of protest to Guterres last week.

Responding to the letter, Maria Luiza Ribeiro Viotti, UN's Chef de Cabinet, said: "I wish to assure you of the utmost importance we attach to civil society engagement in the work of the United Nations at all levels and its active participation throughout the year, including during high-level

"Since the beginning of the COVID-19 pandemic, we have been balancing the safety and security of personnel, representatives of Member States and other stakeholders with the need to ensure that the work of the Organization continues. In March 2020, the premises in New York were closed and the majority of our personnel worked remotely to ensure continuity of critical functions, including intergovernmental meetings, which had to be conducted virtually."

The letter also says: "As the situation in New York has gradually improved, the United Nations has been able to follow a gradual and phased approach to its reopening in order to protect the health and safety of all individuals concerned. Based on medical guidance, we are currently in Phase 2 of our reopening plan with most personnel working remotely for up to four days a week.

This phased approach continues to require limiting the number of persons that can be physically present on the premises and in meetings to ensure compliance with the physical distancing recommendations of our health experts and the guidance issued by the host country authorities.

Preparations are under way to move towards Phase 3, known as our Next Normal phase, which would allow us to increase our overall footprint in the building and to reopen more fully, she said.

## Banker challenges BoT to reign in financial institutions charging double digit in market

ANK of Tanzania officials have been challenged to reign in financial institutions that are charging double digit interest rates despite the central bank's move to reduce it lending rate to banks to 7

Vunjo lawmaker, Dr Charles Kimei said the central bank has a mandate to ensure that interest rates in the market are falling in line with its own move to reduce lending rates to banks. "I'm aware that interest rate is a matter between the lender and borrower but this has to be reviewed because most of the commercial banks are still lending at an average of 16 percent despite the central bank's rate cut," Dr Kimei who retired from CRDB Bank Plc after a 21 year successful spell in 2018, said.

He said despite the changing market conditions including the coronavirus outbreak, people are failing to repay loans which are charging interest rate of up to 16 percent hence rendering the majority to default. The central bank has twice cut the discount rate to 9 percent in August 2018 before lowering to 7 percent earlier this year.

Dr Kimei who also served as Bank of Tanzania Director of Policy before taking over at an almost collapsing state owned

Cooperative and Rural Development Bank in 1996, argued that the central bank has no mandate to audit loan contracts signed between banks and their clients.

He dismissed allegations that some dishonest banking officials collude with clients to give them loans beyond their repaying ability saying, such a scenario is next to impossible. "From my experience, loan appraisal processes are well observed by lenders through special teams and a borrower can hardly collude with a bank employee to negotiate the business secretly along the

process," the Vunjo legislator ar-

He reiterated that issues such as hiked interest rates being charged by financial institutions in the market, can only be addressed squarely by BoT which will also lead to a reduction in non-performing loans which are already threatening the existence of some banks.

Dr Kimei advised that the central bank shouldn't interfere with contracts between lenders and their borrowers under the excuse of controlling a surge in NLPs because such a move will likely threaten borrowers.

"The purpose of introducing a discount rate is to bring affordable loans to ordinary borrowers, which in this case, has failed. Banks are busy lending to public institutions and enterprises which are capable of paying the hiked interest rate of 16 percent because the majority middle class can't afford to pay such interest," he affirmed.

Dr Kimei stated that its abnormal because the prevailing market interest rate has also defied falling inflation rates

saying delays in paying suppliers and services providers by the public sector has also affected loan repayment by the private sector.

In a statement released last week, BoT's Governor, Prof Florens Luoga issued a number of directives to banks in a bid to curb a surge in NPLs. Prof Luoga blamed some dishonest bankers of colluding with likeminded borrowers who get bloated loans beyond their mean to repay.

"To a great extent, employees of some banks and financial institutions are directly responsible through issuing loans without following procedures, fraud/corruption or other practices that are tantamount to lack of integrity," the central bank chief said in his statement.

He said the growing number of NPLs is one of the main reasons pushing up lending rates in the market, a situation that may lead to instability of the banking industry. According to the BoT chief, NPLs slightly dropped from 9.58 percent in 2019 to 9.42 percent in 2020.

## Months of trade wars slash imports from Uganda 34pc

**NAIROBI** 

The value of imports from Uganda dropped 34 percent in eight months to August as trade wars between the two countries took a toll on the flow of goods.

Trade data from Central Bank indicates that the imports from Kenya's landlocked neighbour dropped from a record high of Sh3.2 billion in February to Sh2.09 billion in the review period, hitting a seven- month low. The two countries have had trade disputes now running into the second year after Nairobi banned products like milk and poultry from Uganda.

Kenya's delegation plans to visit Uganda this month to resolve the impasse on trade issues, according to the Livestock Principal Secretary Harry Kimtai."We have been exchanging some correspondence with Uganda and agreed that we shall be going there next month for a fact-finding mission," said Mr Kimtai later last month.

However, export earnings jumped 32 percent in eight months to August to Sh60.4 billion from Sh45.8 in corresponding period last year. In March, Kenya banned maize imports from Uganda owing to high levels of aflatoxin, which exceeded the required limit of 10 parts per billion.

In September, Kenya cut sugar imports from Uganda by 79 percent on its scheduled sugar exports to the country, reigniting trade disputes between the two East African Community members. The Sugar Directorate said traders will only be allowed to import 18,923 tonnes of sugar from Uganda, down from 90,000 tonnes that Kenya had earlier said would be shipped in.

Trade Cabinet Secretary Betty Maina and her Ugandan counterpart had in April agreed that Uganda would export 90,000 tonnes of sugar to Kenya as soon as the verification mission on the country of origin was completed. The forthcoming trade delegation to Kampala comes at a time when Uganda has been allowed to access the Zambian market, giving them an alternative for their commodity.

The Pearl Dairies, makers of Lato milk, have secured annual supplies of milk to Zambia after the company suffered major losses when Kenya stopped exports of its products in 2019. The firm is the largest processor of milk in Uganda with a daily capacity of 800,000 litres.

Most banking applications enable users to add a multifactor authentication feature to their accounts to make it more difficult for bad actors to get their hands on personal information.

The report advises users to avoid mobile banking from easily accessible public WiFi access points; and to use both multi-factor authentication when available and strong passwords. ## In test, UN skirts Taliban to pay Afghan health workers

**UNITED NATIONS** 

THE United Nations has paid nearly \$8 million in salaries to some 23,500 health workers across Afghanistan over the past month, bypassing the Taliban-run health ministry in a test case to inject much needed liquidity into a dire Afghan economy.

The UN development agency UNDP and the Global Fund health aid organization teamed up to resurrect a program that had been funded by the World Bank until it suspended assistance when the Taliban ousted the Western-backed Afghan government in August.

The United Nations has been struggling to get enough cash into Afghanistan to help deliver humanitarian aid to millions of people on the brink of famine and prevent the collapse of the economy and health and education services.

"Someone had to step in. We were confronted not just with a health system that was collapsing, but also a financial system that was collapsing," UNDP Regional Director for Asia and the Pacific, Kanni Wignaraja, told Reuters.

"Global Fund took the financial risk, we took the implementation risk to make these payments happen," she said. "We've shown it's possible, it can work  $\dots$  it goes a huge long way to saving at least the people's economy in the country.'

The Global Fund provided \$15 million, of which nearly \$8 million was used for salaries, while much of the rest was spent on providing basic medical equipment, essential drugs and supplies. UNDP worked out

how to get the funds into the country and into the hands of health workers in 31 of Afghanistan's 34 provinces.

Wignaraja said UNDP wired some of the money to the Afghanistan International Bank and then used a large money service provider, which UNDP declined to identify for security reasons, to distribute the rest.

'Pretty crazy test run'

The health workers paid so far - working in nearly 2,200 health facilities - had money deposited into bank accounts, while another 2,500 health workers will shortly be paid in cash because they are in remote areas.

"It's given hope to these families. It's

reignited healthcare services," said Wignaraja, adding that the program would now be run by the World Health Organization and the UN children's agency UNICEF for the next three months.

"Without this, you literally would have all the Afghan doctors, nurses, technicians, heading across borders,' she added.

Japan's Kishida re-elected

**PM in special Diet session** 

LEADER of Japan's Liberal Democratic Party, Fumio Kishida, was re-elected as prime minister in a special parliament session yesterday after the LDP secured majority of



votes in the House of Representatives election on Oct 31. Having served as the prime minister for around a month

after coming into power on Oct 4, Kishida will launch his second Cabinet Wednesday afternoon as his Cabinet resigned en masse as required by the Constitution prior to the three-day Diet session through Friday.

Kishida is expected to appoint former education minister, Yoshimasa Hayashi, as his foreign minister, who leads a non-partisan parliamentarians' group promoting Japan-China relations.

Most of the current Cabinet members will remain unchanged as it was launched last month.

Toshimitsu Motegi, who has stayed in the post of foreign minister since 2019, became the LDP's secretary general earlier this month to replace Akira Amari.

The powerful chamber elected Hiroyuki Hosoda, a former chief Cabinet secretary, as its speaker, and picked Banri Kaieda, a former industry minister and a member of the main opposition Constitutional Democratic Party of Japan, as vice speaker.

Former prime minister Shinzo Abe will succeed Hosoda as the chair of LDP's largest faction, which he left in 2012 to become the country's leader.

Following the special session, the LDP is looking to convening an extraordinary Diet session later this year to pass a supplementary budget for fiscal 2021, including stimulus measures to alleviate the impact of the COVID-19 pandemic.

The extra budget, expected to be worth 30 trillion yen (\$266 billion), will include distribution of 100,000 yen handouts (\$886) in cash and vouchers to those aged 18 and younger as well as resumption of the government's "Go To Travel" tourism promotion campaign that subsidizes a part of domestic travel spending.

Kishida also aims to achieve salary increases for care workers, nurses and nursery school staff.

In the Oct 31 election, the LDP won 261 seats in the lower house, 15 fewer than it previously held but sufficient to effectively control all standing committees and force through legislation when needed, with Komeito increasing the number of seats to 32 from 29 previously.

## Lavrov points to rising tensions in the field of arms control

**MOSCOW** 

TENSIONS are rising as new challenges and threats emerge in the field of non-proliferation and global arms control, Russian top diplomat Sergey Lavrov said at a board meeting of the Russian and Belarusian Foreign Ministries yesterday.

"We need to discuss the situation in the field of non-proliferation, disarmament and arms control. Tensions and uncertainty are rising as new challenges and threats emerge.



Attempts continue to erode the existing system of international agreements on arms control amid a rise in political and military factors undermining global strategic stability," Lavrov (pictured) pointed out.

According to him, Moscow and Minsk call for restoring trust and constructive dialogue in the Euro-Atlantic region in order to prevent an arms race and a rise in military activities that may harm the long-term security interests of the countries of the region.

"We place great importance on efforts to coordinate our steps, particularly within the CSTO [Collective Security Treaty Organization] and the CIS [Commonwealth of Independent States]," the Russian foreign minister noted.

Lavrov emphasized that Russia and Belarus also planned to discuss the situation following the United States' withdrawal from the Treaty on Open Skies. In addition, Lavrov said that Moscow and Minsk continue to call for searching for ways to ensure predictability and restraint in the field of missiles following the termination of the Intermediate-Range Nuclear Forces Treaty, initiated by Washington.

## Continued internet outage in Sudan negatively affecting economic, social conditions

**KHARTOUM** 

THE internet service in Sudan has not yet been restored, despite a judicial ruling on Tuesday requiring the communication companies to immediately resume the service, which has been blocked since Oct. 25.

Sudanese economic experts and analysts believe that the internet outage for more than two weeks has negatively effects on

the economic and social conditions in the country. "The banking sector is the most affected sector by the outage of internet services," Mohamed Mustafa Ishag, a Sudanese banking expert, told Xinhua. "Those dealing with Sudanese banks suffer from inability to manage their accounts and daily transactions," he said, adding that "many banking transactions requiring dealing via the internet have been disrupted, and most of those transactions are made through liquid money (cash)."

Ali Ismail, a Sudanese economic analyst, pointed to the negative impact of cutting the internet service on the communications companies themselves. "Certainly, the communications companies themselves have sustained great losses, especially if we know that the size of their daily business is estimated at about 6 million U.S. dollars," Ismail told Xinhua. Other sectors have also been affected by the internet outage, such as transportation. "A broad sector of the population of the capital Khartoum suffers from inability to deal with the 'Tirhal' application for transportation due to the outage of internet in mobile phones," he said.

Essam Al-Zein, director of an import and export company in Khartoum, said that it is difficult to work in light of the outage of internet. "Our business has been greatly affected, and there is a significant decline in the movement of export and import due to the lack of internet," Al-Zain told Xinhua. According to unofficial statistics, there are nearly 14 million internet users in Sudan, about 30 percent of the country's population of 44 million people.

## China witnesses surging demand in roadside assistance due to exploding vehicle population

CHINA is seeing a rising demand for roadside assistance as the country's motor vehicle population expands rapidly, hitting 297 million

by September this year. According to statistics, a total of 92.4 million events of roadside assistance were handled across the country last year, and over 200,000 people are currently working in the industry.

Yang Zhi is a roadside service specialist of Chinese electric carmaker Nio. At 9 pm one day, he received an assistance order from a Nio user on his mobile phone. After confirming the location and demand of the user, Yang went for location, he inspected both the him on a roadside assistance ve-

Unlike traditional roadside assistance events, which often happen on expressways, this time, the vehicle needing assistance was in an underground parking lot of an office building.

"The owner of the vehicle said he'd have a long trip by the vehicle tomorrow, but he had no time to charge it. So he invited us to help him, and the whole assistance must be completed within two hours,"

Yang said. After arriving at the designated exterior and interior of the vehicle and then uploaded a video of the inspection. Simultaneously, the inspection system, based on the battery life and available charging facilities near the location, generated an optimal solution - battery swapping and then charging.

Yang looked at his watch after completing all operations and commented, "We're half an hour earlier."

A moment later, Yang's mobile phone rang. "A user's power battery got only 10 percent left, and he's stuck. We must go to him with our mobile charging vehicle," Yang

After a dozen minutes' drive, Yang pulled over in front of the vehicle that needed assistance. He opened the tailgate of his charging vehicle, and two fully charged battery packs were inside.

"They look clumsy, but they charge faster than fixed charging poles," Yang explained, plugging a cable into the charge point, and soon the user's vehicle "revived."

"To help the users overcome their range anxiety is also a kind of assistance, and we'll reach them wherever they are as long as they

need us," Yang told People's Daily. The man traveled over 3,000 kilometers during this year's National Day holiday to offer roadside services for Nio users. "I finished over a dozen orders one day, and there was no time left for me to sleep," he said.

"I've visited almost all tourist sites around Beijing since I started working two years ago," Yang told People's Daily.

"Look, though I need only a phone, a toolbox, and a working suit for my profession, it's never simple. All devices are digital. If you are blind to coding, you'll never get the hang of it. The operation also has standards, and even the torques are set when you turn the screws," he said.

## UN staff members detained in Ethiopia as crisis worsens

#### By Bloomberg

THE United Nations said 16 staff members have been detained in Ethiopia's capital, as a leader of the Tigray rebels warned mediation efforts to end the crisis in the Horn of African nation may fail.

"There has been no explanation" for the detention, UN spokesman Stephane Dujarric told reporters in New York on Tuesday. "Our staff on the ground is working with the national authorities," he said, noting the detentions occurred "over the last few days."

The Ethiopian Human Rights Commission said on Nov 8 that the government was detaining people "in a manner that appeared to be based on identity and ethnicity," following widespread arrests after the state of emergency was declared.

UN security officers "have visited the detained colleagues," Farhan Haq, another UN spokesman, said. Formal requests have "also been sent to the Ministry of Foreign Affairs" seeking "the immediate release of the detained personnel," he said.

Ethiopia has declared a state of emergency as rebel fighters advanced toward the capital, Addis

Ababa. The yearlong conflict between the federal army and the Tigray People's Liberation Front has escalated since the start of October, with the rebels advancing steadily south.

The TPLF downplayed a mediation initiative by the African Union after the special envoy, Olusegun Obasanjo, a former president of Nigeria, met with Debretsion Gebremichael, the leader of the rebel group.

'Doomed to fail'

"Any effort that fails to address the conditions we have put forward is doomed to fail," Getachew Reda, a senior TPLF official said. "It is clear this is mostly about Abiy's survival, not Ethiopia's," he said.

The humanitarian situation is dire in Ethiopia, with an estimated 7 million people in need of assistance. Both parties to the conflict have been accused of committing violations that may amount to war crimes and crimes against humanity, the Ethiopian Human Rights Commission and the United Nations Human Rights Office found in a joint investigation.

The UK advised its nationals to leave the country, after the US did the same last week. A US special envoy, diplomat Jeffrey Feltman, is in Ethiopia to try to advance talks on ending the civil war.

## Obama: Trump stalled climate progress

#### **GLASGO**

FORMER United States president Barack Obama has criticized his successor, Donald Trump, for pulling the country out of the Paris Agreement, which he said stalled US progress on climate issues.

In a speech at the 26th United Nations Climate Change Conference of the Parties, or COP 26, in Glasgow, Scotland, Obama said Trump oversaw "four years of active hostility towards climate science" while president.

"Of course, back in the United States, some of our progress stalled when my successor decided to unilaterally pull out of the Paris Agreement in his first year in office," Obama said on Monday. "I wasn't real happy about that."

But Obama said the US is "once again engaged and prepared to take a leadership role" now that the country under President Joe Biden has rejoined the agreement.

During the World Leaders Summit at the conference on Nov 1, Biden took the unusual step of apologizing for Trump's withdrawal, which he said had left the US "behind the eight ball" on climate issues.

China's special climate envoy, Xie Zhenhua, told reporters last week the US withdrawal had hindered progress toward the agreement's goals, and that leaders had to work together to make up this ground once more.

"Five years have been wasted due to the US' withdrawal (from the Paris it. Agreement). Now, we need to make up the lost time," Xie said.

## **Capitol riot: Judge rules Trump** can't block congressional probe

#### **WASHINGTON**

The US House of Representatives committee investigating the deadly attack on the US Capitol can access former president Donald Trump's White House records, a federal judge ruled on Tuesday in a clear win for congressional oversight powers.

US District Judge Tanya Chutkan in the District of Columbia rejected an argument by Trump's lawyers that telephone records, visitor logs and other White House documents should be hidden from the committee.

"While broad, these requests, and each of the other requests made by the Committee, do not exceed the Committee's legislative powers," Chutkan said in her decision.

Trump had argued that the materials requested by the House committee were covered by a legal doctrine known as executive privilege that protects the confidentiality of some White House communications.

He requested an injunction blocking the National Archives, a federal agency that holds his White House records, from complying with the committee's requests for hundreds of pages of doc-

Jesse Binnall, a lawyer for Trump, did not immediately respond to a request for comment. Trump quickly filed a court notice indicating he would appeal the decision.

The committee has said it needs the requested materials to understand the role Trump may have played in fomenting the riot.

"That's a big deal," US Representative Bennie Thompson, chairman of the House of Representatives select committee, said in an interview on CNN. "I look forward to getting this information. I look forward to our investigators going through it with a fine-tooth comb to make sure that our government was not weaponized against its citizens."

KREMLIN Spokesman Dmitry Peskov slammed Poland's intentions to close the border with Belarus over the migration crisis as

an attempt to stifle the republic. "Such decisions will, naturally, only complicate the situation. These are nothing else but further attempts to stifle Belarus," he said.

Speaking about the allied relations between Russia and Belarus, the Kremlin press secretary said that Moscow had never concealed its readiness to provide all necessary assistance to Minsk in very difficult times. He also stressed that this was what Moscow was doing now.

"First of all, this relates to economic aid but also to all the other required assistance," Peskov said.

As the Kremlin spokesman also specified, Russian and Belarusian Presidents Vladimir Putin and Alexander Lukashenko discussed the migration crisis unfolding in the border area.

"This issue was discussed, of course. The Belarusian president told his Russian counterpart about what was taking place there and they exchanged opinions," Peskov said.

The migration crisis on the border of Belarus with Latvia, Lithuania and Poland, where illegal migrants are seeking to cross into EU territory, escalated on November 8.

Several thousand migrants have approached the Polish border from Belarus and are refusing to leave the area. Some of them have attempted to venture into Polish territory by breaking a barbed wire fence. EU countries have accused Minsk of deliberately provoking the crisis and called for more sanctions against Be-

For his part, Belarusian President Alexander Lukashenko has said that Western countries are to blame for these developments because it is precisely their actions that have caused people to flee countries ravaged by wars triggered by the West.

## WHO warns of shortage of 1-2b COVID-19 vaccine syringes

#### BERLIN / LONDON / **COPENHAGEN**

THERE could be a shortage of one to two billion syringes needed to administer CO-VID-19 vaccinations in 2022 which could also impact routine immunizations and undermine needle safety, the World Health Organization warned on Tuesday.

National health authorities should plan their needs well in advance to avoid the "hoarding, panic buying and type of situation" seen early in the pandemic with the

lack of personal protective equipment, WHO expert Lisa Hedman said.

"We could have a global shortage of immunization syringes that could in turn lead to serious problems such as slowing down immunization efforts as well as safety concerns," she told a UN briefing.

A shortage could lead to delays in routine vaccinations, particularly for children, and other health services, and it could also encourage the unsafe reusing

of syringes and needles, particularly in poorer countries, Hedman added.

About 6.8 billion COVID-19 vaccinations have been administered globally, almost double the number of routine vaccines, Hedman said, compared to total manufacturing capacity of about 6 billion immunization syring-

That means the world could face a shortage of up to two billion syringes next year, unless more factories are shifted to producing the right kind of device for shots, Hedman said.

"If we shift capacity from one type of syringe to another or attempt to expand capacity for specialized immunization syringes, it takes time and investment," she said.

## Brazil, Argentina eye Qatar World Cup qualification

**RIO DE JANEIRO**

BRAZIL host Colombia in Sao Paulo today knowing victory will book their ticket to Qatar with six World Cup qualifiers to spare following a near perfect record so far.

Even a draw for the Selecao would be enough if Uruguay lose at home to Argentina on Friday, and Brazilian media have reported that coach Tite is already planning to head to the Arab Cup in Qatar next month to check out World Cup venues and

Publically, though, Tite is not getting ahead of himself with a trip to face arch rivals Argentina in San Juan on the horizon next week.

"We have two important matches against two teams that, for me, are of the highest level," said

"A good performance and a good result against Colombia will provide us with a good preparation

Tite caused a surprise by recalling Barcelona's Philippe Coutinho to his squad after more than a year out, largely due to a nine-month absence with a knee injury that required three surgeries.

"It feels like it did the first time, that's how I see it every time I'm in the squad. It's an honor to wear this jersey," said Coutinho, who has struggled for playing time this season at his club.

Brazil have dominated the single CONMEBOL World Cup qualifying group, winning 10 of their 11 matches and scoring 26 goals.

Their only blemish was a 0-0 draw away to Colombia last month that brought to an end a nine-

match winning run.

Another tight game is likely against a team on a run of three consecutive goalless draws.

Colombia welcome back playmaker James Rodriguez for the first time in a year despite his ignominious start to life at Al-Rayyan, his new Qatari club.

Lats month, in only his third league match since leaving Everton, the former Real Madrid and Bayern Munich player was bizarrely sent off after picking up two quickfire yellow cards for protesting after he was awarded a free-kick.

James's inclusion is a welcome boost for Colombia, who will be without injured veteran striker Radamel Falcao.

Colombia are currently locked in a tight battle to qualify automatically for the World Cup alongside Ecuador and Uruguay.

The three sides are separated by a single point in the battle to finish in the top four places, with the fifth-placed finishers heading into an interconfederation play-off.

- Messi a doubt -

Like Brazil, second-placed Argentina could also secure qualification this month, although they would need other results to go their way.

And they may have to do without star player Lionel Messi, who is suffering from knee and hamstring problems and has missed his club Paris Saint-Germain's last two matches.

After their trip to Uruguay, Argentina, unbeaten in 25 matches, host Brazil next week and victories in both could be enough to book their ticket to

Uruguay, though, will be out for revenge after their 3-0 capitulation in Buenos Aires last month.

They will be without injured Manchester United forward Edinson Cavani, although Atletico Madrid's Luis Suarez has traveled back to South America.

Having also crumbled 4-1 away to Brazil last month, iconic Uruguay coach Oscar Tabarez finds himself under pressure, with many fans believing the 74-year-old's record-breaking 15-year tenure should come to an end.

He will also have to do without Real Madrid's Federico Valverde amongst eight absentees.

Free-scoring Ecuador, in third, will look to bolster their qualification hopes as they host rockbottom Venezuela on Thursday, before a trip to Chile next week.

Only Venezuela appear out of the qualification picture, sitting nine points behind the top five, although Chile, Paraguay, Peru and Bolivia have some ground to make up with just six qualifiers

Crucially, Paraguay host Chile and Peru entertain Bolivia on Thursday in must-win matches.

## Salah has two goals as African World Cup qualifying intensifies

LIVERPOOL marksman Mo Salah leads Egypt against Angola this weekend with the clear objective of ending his scoring drought to help lift his nation into the final stage of Africa World Cup qualifying.

Qualifying for the 2022 tournament in Qatar intensifies on the continent with the last two group rounds, with victory in Luanda moving Egypt into the next stage as Group F winners.

The two-time African Footballer of the Year wants to get back on the goal trail in Angola having failed to find the net in his last three appearances for the Merseysid-

Before his mini-slump, Salah had scored in 10 consecutive matches in all competitions for Liverpool.

Victory will take Salah and his team into the final qualifying phase to decide which five countries represent Africa in Qatar next year.

Here, AFP Sport highlights matchdays 5 and 6, which run from today through Tuesday, with 21 nations chasing eight final-round places, 17 out of contention and Senegal and Morocco already through.

**GROUP A** 

Mahrez-cap-Rivad tained African champions Algeria and Burkina Faso are heading for a final round showdown on a Blida pitch publicly criticised by both teams as unsuitable for international football.


