# African children to constitute half of world's poor by 2030

CHILDREN in Africa will make up more than half of global poverty by 2030, on the basis of research by the UK Overseas Development Institute and the NGO, Save the Children.

This view is generated by a "perfect storm of slow and unequal economic growth, demographic trends and the depth of current poverty," a report released by the two organisations said last week.

Researchers predicted that 87 million African children will be born into poverty in each year of the next decade, warning in their paper of a "worrying gap" between the scale of response needed from various authorities and the scale of the response

Kevin Watkins, chief executive of Save the Children UK, said: "Put simply, the world's population of children is increasing most rapidly in the region where poverty is coming down most slowly."

By 2030, Africa's share of global births is projected to be 36 per cent. Today, the number of births in Africa accounts for 29 per cent of the world's total whereas its share of the global population is 17 per


But poverty has fallen more slowly in Africa than in other regions, with an estimated 40 per cent of the population living on less than \$1.90 a day, the report

Watkins explained: "These trends are unfolding in full view of the governments who have pledged to eradicate poverty, yet their response to child poverty has been a case study in inertia."


The report found "little evidence" of African governments developing suitable policies to address the crisis, and also criticised the International Monetary Fund, the World Bank and other donor organisations for "failing to put child poverty at the centre of their agendas."

Watkins said that child poverty by itself is "an affront to basic rights and equal opportunity," but it is also a "guaranteed

# Dr Shein urges ICT use to get e-Parliament benefits

ZANZIBAR President Dr Ali Mohamed Shein yesterday called on members of the Commonwealth to invest heavily in promoting the use and teaching of ICT in local communities in order to reap optimal benefits of introducing e-Parliament.

Dr Shein made the remarks when opening of the 50th Commonwealth Parliamentary Association Africa Region conference taking place in the Isles.

The CPA involves MPs and Speakers from Commonwealth member states, where those attending include Justin Muturi, chairman of

Also in attendance was Emilia Monjowa Lifaka, chairperson of the CPA International Executive Committee and Deputy Speaker of the National Assembly of Cameroon.

# Govt gets 1.9bn/- selling 3,262 cubic meters of old teak trees

THE government has collected 1.9bn/- from selling 3,262 cubic meters of standing teak trees from two auctions last week in Morogoro and Tanga regions in an effort to raise government income

The first auction for the highly valued timber species was conducted at Mtibwa forest farm located in Kilosa district Morogoro region, whereby 1162.15 cubic meters of standing teak trees were sold at a price of around 455m/-.

to current technological development and global efforts to promote good governance and democracy.

"Promoting the use and application of ICTs by developing e-Parliament in our countries is a vital step towards enhancing the three core functions of parliaments namely, legislation, representation as well as the power to monitor and oversee various government organs, which legislators simply call "oversight," he said.

Dr Shein said that the implementation of e-Parliament programmes is important in facilitating easy access to a wide range of information and knowledge resources, which are instrumental in making informed decisions, both in parliaments and constituencies.

Through databases, intranets, digital libraries and the internet in general, MPs can have access to resources relating to legislative documents, such as bills and proceedings from almost anywhere, he said.

In addition, he said that through e-Parliament, members of Parliament can easily be connected to their constituencies and the people they

At the same time. Dr Shein said that the people through e-Parliament can express their viewpoints and concerns in a more effective and efficient way by

reducing the cost and paperwork. "Furthermore, we can considerably reduce unnecessary travels, if e-Parliament programmes are properly carried out, thus compensating for implementation of various costcutting initiatives introduced by our governments.

"It is encouraging to note that there are many MPs in different countries who work closely with schools in their respective constituencies to promote the teaching of ICT," he said.

Citing examples, Dr Shein said in Zanzibar, many schools have been provided with desktop and laptop computers by members of the House of Representatives and MPs.

"It is actually a commendable action which should be emulated by other MPs and Representatives who have not yet taken such initiatives. This provision of ICT appliances signals the MPs' and Representatives' positive attitude towards the use of ICT in present day communication, and they instill it on the youths, some of whom may in future become legislative members.

He further said that the Zanzibar government has embarked on e-Government Project and th president officially inaugurated its first phase in

After the successful installation of the relevant ICT infrastructure, the project added.

took off and Isles' government has directed use ICT in all its institutions to keep pace with technological advancements and other changes associated with globalization, he elaborated.

"We have already put in place various e systems regarding government institutions payroll, human resource management, public leaders' ethics, records management, e-tax, e-health, early warning and matters relating to the Directorate of Public Prosecutions (DPP) which are now fully operational," he specified.

In the case of e health, Dr Shein said that in the Mnazi Mmoja Referral Hospital, some medical records are currently being kept electronically. Tele-medicine activities like video conferencing on surgical operations are also taking place at the Neurosurgical Department.

"Likewise, the installation of a Magnetic Resonance Imaging (MRI) machine, digital X-ray and CT scan machines marks a paradigm shift to the engagement of e-health practices. About 170 hotels are connected to e-booking system as a pilot scheme. Blog monitoring and e-tourism are underway," he remarked.

"The implementation of this important project is part of the government's efforts to promote the practice of good governance and democracy by improving efficiency, effectiveness, transparency accountability in service delivery as stipulated in the Zanzibar Public Service Act No. 2 of 2011. Likewise, particular emphasis on the development of ICT has been laid by the government in the implementation of development plans, including the Zanzibar Strategy for Growth and Reduction of Poverty (ZSGRP II), Zanzibar Development Vision 2020 and the CCM General Election Manifesto of 2015 - 2020.

"We are now implementing the second phase of the e-Government Project, whereby the relevant infrastructure has been built in both Unguja and Pemba. About 419 km of the fiber optic network cables have been laid and 102 public institutions, including the building of the House of Representatives are already connected to the data centre through the fibre optic cable."

E-government initiatives have considerably increased the use and application of ICT in the Zanzibar House of Representatives in its daily operations. The Zanzibar House of Representatives intends to enhance the use of e- government for the public to access information from the House at ease. This will help to cement relations between House members and the people they represent, the Isles leader

## **Week showcases** innovation, inspiration and collaboration

**World Water** 

**STOCKHOLM** 

MILLIONS of lives could be at risk unless humankind takes the water crisis and global warming more seriously. This was the main message as World Water Week closed here on Friday amid calls for governments, institutions and companies to start applying the water-based solutions already in existence - and include everyone in the process.

The world's leading annual water event, World Water Week, ended with warnings of looming dangers as well as rays of hope. One-third of the 4,000 participants from 138 countries were under the age of 35 and their presence was highly noticeable throughout the conference.

"It has been very inspiring how we young professionals get to share our knowledge and are increasingly being listened to," said Sara Löwgren from the Water Youth Network at the closing ceremony.

A day earlier, Prof Johan Rockström had turned directly to the young participants, saying: "You are the only ones who can truly speak on behalf of the future." He assured the audience that science says that there is still a chance to save the planet if carbon emissions are cut by half in the coming decade but that this window of opportunity must be put to good use.

Many of the Week's 250-plus sessions focused on water as a solution to challenges such as climate change and food scarcity. With the theme of the event being "Water for Society: Including All", research was presented on the importance of integrating the perspectives of all ages, genders and social groups.

Holmgren, Executive Torgny Director of organisers SIWI (Stockholm International Water Institute), described this as the essence of good water governance, adding: "Compared to previous years, I see a new focus on the role of governments, cities and local communities, with many inspiring

utilization for the Tanzania Forest Services Agency (TFS) Mohammed Kilongo, during auction day at Longuza forest farm.

He said both auctions were legally conducted, in accordance with the Forest Act and regulations of 2004 together with Government Notice no 255 of 28 July 2017 which directed that the selling of standing teak trees will follow prevailing market prices.

TFS is mandated by the government to sell standing teak trees and other forest products.

The revenues obtained will be channeled to the Forest Fund to recover costs incurred in preserving

the balances in the forest ecological

system. "We planned to sell 7,002 cubic meters of standing teak trees from Longuza forest farm but the registered bidders have just bought eight plots out of 23 plots that were kept for auction,"

he said. "Most registered bidders found it impossible to purchase due to the fall of the Rupee (Indian currency) as the country is the main importer of the trees," the director explained.

Most traders who bought the trees used to export to India where there is

large market for the trees," he stated. The procedure for auctioning gives a competitive furniture industry to

the trees for 48 years, and to develop an opportunity to bidders to weigh themselves and purchase the standing teak trees volume which they can pay for harvest within the award letter for

harvesting the trees," he specified. Auctions for the trees are regularly conducted in three to four months in intervals, he said.

He said that the government will continue with auctioning of the trees in its 13 forest farms up to April next year in order to finish the available stock of 1,062,831 cubic meters of the trees.

However, the government is currently preparing modalities for ensuring that the forest resources will benefit locals by supporting them to establish

accelerate industrial development.

Highlighting some of the challenges they face, a representative from Prime Timber Co., Yusuf Ngage said high prices of the trees is what retarded them from purchasing tonnes of the

The quality of trees is currently not promising for the market, making it impossible to win the market.

"We ask the government to improve the business by setting conducive prices which are friendly to traders so that we can win the local and external market," he said.

Dr Cellina Mongo, the chairperson of the auction, said the business has received huge attention from bidders,

appearing in big numbers to register for purchasing the trees.

"But the challenge facing the business is marked price that fluctuates from time to time, causing traders to purchase minimal quantity contrary to government expectations," she said.

Dr Mongo, who is principal forest officer, Forest and Beekeeping Division in the Ministry of Natural Resources and Tourism said that the government is expecting to have audience with traders in the business to see what it can do on pricing and related challenges.

Traders must abide with terms and conditions for the sale in order to benefit from the business, the auction head added.

# Jumbos move into villages in Bariadi and destroy crops

FARMERS in Halawa village, Bariadi district, Simiyu region are calculating losses after stray elephants destroyed their crops over the weekend.

More than 10 jumbos said to have strayed from the neighbouring Maswa Game Reserve, destroyed people's homes and crops.

The group of jumbos stormed the village at around 1 am midnight when people were asleep and destroyed 11 houses of about 50 people.

One of the victims Mwalu Nsulwa said the elephants destroyed his house and eaten all bags of maize which were stored for food security.

"I managed to run away with my family. I thank God we're all alive, but the challenge is where to start as I have no house and no food," he said.

Village Executive Officer Mahenga Matongo said that seven households were destroyed by the elephants' invasion and 42 bags of maize and six bags of potatoes were eaten.

Matongo said that the affected people had been given alternative accommodation by their neighbours.

Bariadi District Commissioner Festo Kiswaga handed over 220 kgs of maize flour, 50kgs of beans and 20kgs of sugar to the affected families.

DC Kiswaga asked management of Maswa Game Reserve to work on the challenge, which has been chronic in recent years.

He however said that the government was working hard to ensure that the affected people are being compensated.

Game Reserve manager Lusato Masinde said that in recent years there are has been an increasing number of elephants in the area, which had destroyed people's homes.

"For almost one week, we've chased groups of elephants into the reserve from Meatu, Itilima and Bariadi districts. This is a challenge that we're facing with, I call on people to report once they see the animals roaming He however said that there were no around their homes and farms," he

The Written Laws (Miscellaneous Amendments) bill number four outlines 11 laws including the Criminal Procedure Act (Cap 20) which introduces plea bargaining system into Tanzania's justice system.

The plea bargaining system allows the prosecutor and accused to agree by the latter pleading guilty to certain charges in return for some concessions from the prosecutor which may lead to lenient sentence or withdrawal of

other counts. The move is targeted at reducing case backlogs which delay justice delivery.

The bill also intends to amend the Advocates Act by introducing a clause that restricts state attorneys and other state law officers from practicing the profession outside their government job. The Written Laws (Miscellaneous Amendments) bill number five seeks to amend seven laws including the **Electronic and Postal Communications** Act by making Sim card registration mandatory for whoever uses it.

# Agricultural stakeholders underscore importance of modern farming practices

AGRICULTURAL stakeholders have appealed for the need for farmers to adopt better agronomic practices if they are to excel in the competitive international markets.

They made the suggestion over the weekend when speaking at the twoday meeting that involved grain traders, processors, warehouse owners, transporters, and farmers from across the country.

Among the good agricultural practices include the use of improved seeds and soil testing and analysis, which will help farmers, recognize soil type, its health and know the type of fertiliser needed before engaging in farming.

The call was made last week by the stakeholders who were attending the two-day's meeting organised by the ministry of agriculture.

Stakeholders were engaged in grain industry while responding a question from the minister for agriculture who wanted to know what should be done to help Tanzania get enough food and surplus to sell in other foreign coun-

"Farmers need to know types of soil, and they should be trained on modern farming practices, which in turn will make them produce high quality grain that will compete in the international markets," said Moses Mwaipopo, Mbeya-based grain processor.

He also called on the ministry of agriculture to develop a database on grains available in the country that will make buyers fully aware of the tonnes of cereals they need to buy for the market demands.

Mwaipopo also called on financial institutions to extend its services to the district level to help small-scale farmers access loans for agricultural inputs to increase productivity.

Patrick Ngowi, a Manyara-based farmer and grain trader also called on banks to support farmers who are working in grain value chain industry. "Banks should start issuing loans to warehouse owners to help them have better storage facilities that meet international standards," he suggested, add-

"Right now the majority of warehousing facilities that farmers use for maize, paddy and other grains storage were not good they lacked the required standards for grains storage.

Ngowi also suggested the need for the government to have business desk officers in every embassy across the world, who will be providing information on what kind of grain is required in the market and how many tonnes are required before traders and processors start exporting the cereal crops.

The two day- meeting involved grain traders, grain processors, warehouse owners and farmers and was organised by the ministry of agriculture.

Agriculture minister Japhet Hasunga said that his ministry will continue to support grain processors, traders, farmers and warehouse owners to help them operate their businesses in a better conducive environment and reduce costs of doing businesses.

Currently, there is huge market of maize grain and other crops in the SADC market; he called on farmers to produce high quality standards that will help traders and processors export grains that meet customer's needs, the minister said.

"We need to ask ourselves the grain that we cultivate and sell it did they meet their standards, do we have the capacity to produce it because our production capacity for maize, paddy is very low," he guerried.

# Tech-based HIV prevention project proves effective for rural African American families

TECHNOLOGY may be a viable option for reducing HIV risk in underserved families in rural communities, according to a new Vanderbilt report.

Researchers designed and evaluated the effectiveness of a technology-delivered HIV risk prevention program, Pathways for African American Success, to address the comparatively high HIV rates in rural African American communities. PAAS is designed specifically to increase informational access to such communities, which are less likely to have access to in-person HIV support and larger cities.

"Our findings suggest that the PAAS technology-delivered program is just as effective as small group in dissuading HIVrelated risk behaviors among

rural African American youths," said lead author Velma McBride Murry. "This fun, interactive program allows families to access sessions at their convenience and own pace, addressing a gap in eHealth digital programs."

Murry, who holds the Lois Autrey Betts Chair in Education and Human Development at Vanderbilt Peabody College of education and human development, collaborated with colleagues at Clemson University and Arizona State University on the study. They found that compared

with families who met with a facilitator in person, those prevention programs found in in the PAAS online group demonstrated significantly parent-child stronger communication, including improved discussion quality, an in-person, facilitator-led clearly articulated norms and parental expectations about risk engagement.

Participants also reported reduced intentions to engage in risky behaviors six months postintervention.

Technology-delivered programs for HIV prevention also are promising because they are more cost effective and less labor intensive than traditional small group-based preventive intervention programs.

"The Pathways for African American Success: Delivery Platform Matter in the Prevention of HIV Risk Vulnerability Among Youth?" is published in the Journal of Adolescent Health.

## Why, indeed, should a govt official ever see need to harass an investor?

Affairs minister Kangi Lugola has just warned officials of the Immigration Department to stop being used by unscrupulous business people in a dirty game where upon the behest of a local investor, a foreign investor is harassed and finally deported. The minister was opening a two-day workshop for senior officers at the Tanzania Regional Immigration Training Academy (TRITA) in Moshi, where he said he was aware that the department was being used to frustrate investors. It is not perhaps too frequent but it tarnishes the country's image.

The minister explained that the dirty game involves Tanzanians who have taken up business joint ventures or partnerships with foreigners as local shareholders, something he said is in certain areas required by law. But after the business picks up, the supposed partners seek the help of unscrupulous officials at Immigration to slap the foreign partner with the dreaded Prohibited Immigrant (PI) notice. With the partner kicked out for some imaginary suspicion or charge the local shareholder remains with the entire business. Evidently the facilitating official would be assured of a tidy commission for the work.

How far such habits can be controlled by ministerial fiat or caution as in the present instance is unclear, as wrong doers look at the full breadth of the law to find space in which to insert mischief. One such areas was alluded to by the minister, namely that in various regards partnerships are required by law, which implies that the foreign businessman is by law a subordinate to the local partner. He has no equal rights with the local fellow so long as his residence rights or ownership of a business is tied to goodwill.

When the minister urges Immigration Department officials to ensure that investors should not be harassed - as one can't say should not be harassed without reason, as this is to stammer, to accept bona fide harassment of some kind - what mechanism is there to ensure that PI aren't just slapped? And is the bad thing about PI notices issued for personal interest and pecuniary consideration just what they imply for the prestige or image of the country? The image is harmed but it also tells a lot about ease of doing business at present, especially if such a victim of wrongful PI was compelled to seek a

It is clear as the minister pointed out that the habit of harassing and then expelling investors impedes efforts by President John Magufuli to attract investors as Tanzania strives to become a middle income economy towards the end of the president's mandate. Immigration Department officials and the Tanzania Intelligence and Security Service cannot be hired by low level individuals but upper class personalities, so it is organised crime. The minister did not say how widespread it is at present, though.

Compelling investors pick partnerships has negative consequences when the level of trust between them is insufficient but only compelled by law. It is a good thing that the government has taken note of that, but relaxing terms of initiating a business is vital as well, as when the security of a foreign investor depends on a local partner, that is an 'invitation to treat' with those who detain stamps and signatures for PI notices. The law is designed to facilitate government decisions, but it may also foster criminality unless properly implemented.



# A tourist at home away from home: A visit to Morogoro

ISITING Morogoro was like entering an atmosphere of another time, when the African National Congress had a unity of purpose and its cadres were driven by the courage of their convictions.

Perched near the majestic Urugulu Mountain Forest just east of Tanzania are lively villages spanning the lush green scenery of Morogoro - the place where freedom fighters took refuge while waging a war against a repressive system back home in South Africa.

I was privileged to form part of the visit led by President Cyril Ramaphosa to Morogoro on the sidelines of his state visit which followed the 39th Ordinary Summit of SADC heads of state and government two weeks ago in Tanzania. It was a privilege because Morogoro occupies a very special place in the hearts and minds of young activists in the African National Congress (ANC).

The pilgrimage was timely, precisely because the current state of our politics is such that we speak unity and practice its antithesis, and serious political discourse has made way for popular slogans. Visiting Morogoro was like entering an atmosphere of another time when the ANC had a unity of purpose and its cadres were driven by the courage of their convictions.

In Morogoro, we began the journey, which will forever be cemented in my heart, with a tour of the Soikone University of Agriculture's Solomon Mahlangu Campus formerly known as the Solomon Mahlangu Freedom College - Somafco. The college, situated in Mazimbu, was established by the exiled ANC in 1978 and it provided educational and vocational skills to young South Africans who had fled South Africa after the 1976 Soweto uprising. As we drove through Mazimbu Campus, past the OR Tambo Primary School, my mind couldn't help but wonder if indeed the children there knew about this revolutionary and Oliver Tambo, a great Son of Africa who, while he lived, bestrode the world like a colossus. What became evident was that while we can selfishly claim our leaders as our own, in reality they were and remain global leaders. Our visit started with the signing of the visitors' book by the President and in that room, a flag of the ANC Women's League stood out like a mural on the wall, and together with other paraphernalia of the governing-ANC and its leagues is kept treasured

as part of the rich heritage. Together community and people of Tanzania for with the leaders of our sister liberation movement Chama Cha Mapinduzi, we then moved towards a large group of locals who were waiting eagerly for a public meeting to engage with the leaders. Among them were leaders of the university, students, and members of the surrounding communities. I was immediately reminded that then ANC President OR Tambo stood in the same place 35 years ago to address the community of learners and educators. On that occasion he said: "The ANC is a force. And why are we a force? Because of you ....We are a force because everywhere we are honest, we are a force because we are fighting the biggest criminals, a regime guilty of crime against humanity, a powerful regime which has failed to destroy us because we are a force. But I say we are a force because of you, because of Mazimbu, because of Somafco, because of what you represent here, because of the community that you have setup here, a community that we can display to the world." These words echoed in my head as if I were there during that address while I sat on the podium gazing at the community of Mazimbu who had come in their numbers to listen to President Ramaphosa. The President expressed gratitude to the a home away from home. As expected,

their support during the difficult period of repression in South Africa. It is with this shared past in mind that, when Julius Mwalimu Nyerere addressed the South African Parliament in 1997, he made the following remarks among other things: "With the end of apartheid and South Africa having joined SADC, this area of Africa is a very solid area. It is an extremely solid area. It is strong, it has serious leaders and these leaders know one another. I know that because where some of them have come from, they have a habit of working together... so let them work together."

Indeed, Mwalimu that knew the leaders of the ANC and Chama Cha Mapinduzi and other liberation movements had a habit of working together and that should continue to be the guide for the leadership in the SADC region and the continent.

We proceeded to the girls' dormitories, whose exterior was a mural of struggle heroine Mama Lilian Ngoyi, before a tour through a carpentry factory where young people are taught how to make furniture. With time running out, on our way out we walked past a structure draped with graffiti of the first logo of the ANC Youth League. The place truly felt like

the visit to the cemetery and seeing all the graves of the freedom fighters who lost their lives and were buried in Morogoro was quite an overwhelming emotional journey. Buried therein are the mortal remains of freedom fighters who came from diverse backgrounds and ordinarily they never would have met, but their paths crossed because they had one thing in common - they hated injustice. Then it dawned on me that they never got to see the freedom that they bitterly fought for, they never got to experience what it means to be back home and walk in the streets without fear of being arrested or tortured. But they died reassured that the ANC was a force that would one day fulfil their aspirations. As we celebrate the 50th Anniversary of the Morogoro Conference, let us remember where we come from and the sacrifices that have been made. Let us remember that there are many who laid their lives for this freedom and democracy we have today, which many of us take for granted. Let us draw lessons from the Morogoro Conference and rebuild the ANC into a force with sufficient stamina to fulfil its historical mission. We dare

## Disease outbreak response strategy is a must for the African continent

EALTH, as defined by the World Health Organisation is a state of complete physical, mental and social well-being and not merely the absence of disease or infirmity. This definition has been subject to controversy, as it may have limited value for implementation. Health may be defined as the ability to adapt and manage physical, mental and social challenges throughout life.

The meaning of health has evolved over time. In keeping with the biomedical perspective, early definitions of health focused on the theme of the body's ability to function; health was seen as a state of normal function that could be disrupted from time to time by disease.

With an acute public health event reported every four days on the continent, it is more important than ever before for African countries to be able to respond to health emergencies.

African health ministers yesterday adopted a 10-year regional strategy that aims to strengthen integrated disease surveillance and response and mitigate the devastating impact of outbreaks, such as Ebola.

Africa has more outbreaks and other health emergencies than any other region of the world, and many of them could be prevented or controlled through proven public health interventions.

Worryingly, recent analysis by the World Health Organization (WHO) indicates that emerging and reemerging infectious diseases and other public health emergencies are on the rise, predictably in certain areas and unpredictably in other places. This increase is largely attributed to the growth of cross-border movements and international travel, increasing human population density and informal settlements along with

climate change impacts and changes in the way humans and wild animals interact. More than 80% of the public health emergencies in the WHO African Region between 2016 and 2018 were due to infectious diseases.

The new strategy aims to ensure that countries can cope with major outbreaks and other health emergencies. It is crucial for all countries to have an effective surveillance system, which can track common diseases and set off alarms for the timely containment of disease epidemics or for early detection and investigation of any abnormal clustering of cases or deaths of a new

The Regional Strategy for Integrated Disease Surveillance and Response 2020-2030 was adopted by health ministers during the 69th session of the WHO Regional Committee for Africa, which is taking place in Brazzaville, the Republic of Congo. The Regional Committee is the governing mechanism involving health ministers from all 47 Member States of the WHO African Region.

The new strategy builds on more than 20 years of working with a comprehensive, evidence-based integrated surveillance system that ensures countries stay a step ahead of

many dangerous pathogens. "The current Ebola outbreak in the Democratic Republic of the Congo is a poignant reminder of the importance of a strong surveillance system," said Dr Matshidiso Moeti, WHO Regional Director for Africa. "Only when every case is promptly detected, quickly hospitalized and offered timely medical care - and all close contacts vaccinated and properly monitored will the Ebola outbreak end. Equally important, devastating outbreaks can be 'nipped in the bud' if cases are quickly detected before they widely spread in communities."

S Ethiopia envisages to become the manufacturing hub of Africa within the coming decade, Chinese-built industrial parks in different parts of the country are now luring world-class investors.

Fitsum Ketema, General Manager of Hawassa Industrial Park, told Xinhua that all the available 52 factory sheds that are available inside the Hawassa Industrial Park have been transferred to 21 international companies, some of which are undertaking their activities inside the few vacant factory sheds to commence their manufacturing operations soon.

The Hawassa Industrial Park, which the Ethiopian government considers as its flagship industrial park in its ambition to transform the country as the manufacturing hub of the African continent by the year 2025, was built by Civil Engineering Construction Corporation (CCECC) and completed back in 2016 in just nine months of construction period.

Noting job creation as the industry park's major ambition, together with its aspiration to lure foreign direct investment (FDI) and technology transfer, Fitsum also emphasized the park's indirect economic imperatives to the Hawassa city and its surroundings.

According to the general manager, the industrial park has so far created 27,000 direct job opportunities to local youth. He also revealed ongoing works to further increase the number of job opportunities when all the 52 factory sheds commence their manufacturing operations soon.

The Hawassa Industrial Park, located some 275-km south of the capital Addis Ababa, is considered as Ethiopia's "flagship industrial park" with its state-of-the-art technologies that are installed inside the premises of the in-

"The Hawassa industrial park has become a model for other industrial parks under construction in Ethiopia and elsewhere in Africa, mainly due to its Zero-Liquid Discharge (ZLD) technology installed inside the industry park, which is also the largest in Africa," Fitsum said.

The ZLD technology currently treats 11-million-litter wastewater on a daily basis, and recovers the treated water for a recycle use, according to the park's general manager.

"Despite the industry park's only 9 months of the overall construction process, investors and policymakers 

often describe the park as world-class infrastructure," Fitsum said.

The East African country, which is presently constructing or has commissioned around 12 industrial parks across the country, is investing its capital and manpower in the development of industrial parks across the country, which will see it a light manufacturing hub in Africa by 2025.

Chinese engagement in Ethiopia's industrial park development endeavor is also injecting the much-needed imputes in Ethiopia's momentum towards becoming a middle-income economy within the coming decade.

The Dire Dawa industrial park, which is also under construction by CCECC, is currently awaiting international investors from multiple sectors including heavy industries, textile and apparel, vehicles assembly and food processing, electronic, paper and allied products, chemicals, according to the Ethiopian Investment Commission (EIC) and the Chinese contractor.

Wang Kun, Dire Dawa Industrial Park Project Manager at CCECC, told Xinhua that works at the Dire Dawa Industrial Park are nearly finished. As it stands, close to 97 percent of the work has been completed, with only remaining water treatment and landscaping works.

Drawing from China's economic growth experience, Ethiopia will have about 15 industrial parks within the coming years, most of which were built by Chinese companies and with

Chinese technologies. The Ethiopian government often said the industrial parks that had been triumphant as they lure world-class companies including PVH - a company known for marketing diversified portfolio of brands including Calvin Klein and Tommy Hilfiger.

Built by another Chinese construction company China Communications Construction Company (CCCC), the Mekelle Industrial Park in northern Ethiopia is also designed to attract textile and apparel producing companies.

China Tiesiju Civil Engineering Group is also building the Kilinto pharmaceutical industrial park (KIP) at the outskirt of the capital, which is under construction with funding from the World Bank.

According to figures from the Ethiopia Investment Commission (EIC), Ethiopia has earned 142 million U.S. dollars in export value from Chinese built industrial parks during the Ethiopian fiscal year 2018/19, which ended on July 7., up 50 percent as compared with the same period in the 2017/18 fis-

# African experts, policymakers and reversal of 'lacklustrer' approach to Paris climate accord

**ADDIS ABABA** 

FRICAN experts and policymakers last Thursday were urged to reverse the current "lackluster approach" in the implementation of the Paris Agreement towards tackling the adverse impacts of climate change.

The experts and policymakers made the call during the eighth edition of the Climate Change and Development in Africa Conference (CCDA-8), which was held at the headquarters of the African Union (AU) in Ethiopia's capital Addis Ababa from August 28 to 30.

The high-level climate-themed conference, which is co-organized by the AU Commission, the UN Economic Commission for Africa (ECA), African Development Bank (AfDB), and the Pan African Climate Justice Alliance, kicked off with strong calls from African ministers and experts to reverse the current uninspiring approach to implementing the Paris Agreement.

"Many African countries have submitted ambitious Nationally Determined Contributions to Climate Action (NDCs), showing that African leaders have made strong commitments to tackle climate change while striving to meet their national development agendas," Frehiwot Woldehanna, Ethiopia's State Minister of Water, Irrigation and Energy, told the high-level meeting.

The Ethiopian state minister also noted that the East African country, whose electricity system is dominated by hydropower, was one of the first

countries to submit its NDC leading up to the Paris Agreement and "was one of the first countries to ratify the agreement."

Woldehanna also stressed Ethiopia's strong commitment in the fight against climate change, in which the Climate Action Summit, which is being organized under nine action areas, one of which is the energy transition being led by Denmark and Ethiopia.

"Yet, despite the efforts on the ground, climate-induced frequent and more intense droughts "are putting our energy security and reliability at risk, with significant economic and social impacts," the state minister

The three-day climate-themed continental conference is being held under the theme "Stepping up Climate Action for Resilient Economies in Africa -- a Race we Can (and must) Win."

James Kinyangi, Chief Climate Policy Officer at the African Development Bank (AfDB), also echoed the Ethiopian state minister's call, as he emphasized the first urgent action is "to build resilience and adaptation to the adverse impacts of climate change for the most vulnerable communities across Africa.'

Having signed and ratified the Paris Agreement, nearly all African countries "are now committed to Climate Action in support of building resilience through early warning systems, comprehensive risk assessment and management, and risk insurance," Kinyangi said.

The Paris Agreement, which was signed back in 2016, is an agreement within the United Nations Framework Convention on Climate Change, dealing with greenhouse-gas-emissions mitigation, adaptation, and finance.

Aida Opoku-Mensah, at the UN ECA, also noted that Africa contributes the least to global emissions but it is "already suffering the most adverse impacts from climate change."

"The continent contributes less than 6 percent of emissions, with per capita emissions of only 0.8 tons per year, well below the global mean of 5 tons, and far lower than for other regions such as Europe and Asia," Opoku-

Opoku-Mensah further indicated 

Change and Development in Africa Conference is a "special event" as it being held ahead of the forthcoming Climate Action Summit, which is calling for urgent and concerted global action to fight climate change.

"This is the last wake-up call to all countries to raise their game and step up climate action for multiple social, economic and environmental wins," she stressed.

# Paralegals help out elderly woman to reclaim land from a rich neighbour

AN 85-year-old Amina Kirua owns six-acre farm in Korogwe district, Tanga region.

She is one of the victims of land grabbing in the agricultural-rich district, whose people rely on farming as the main source of income and food.

Amina, a mother of two, bought the land from her neighbour more than 25 years ago.

As it is to many people in Tanzania's rural settings, Amina depends solely on farming to earn income to sustain herself and take care of her family.

So, the old woman has been engaging in subsistence farming for decades in that six-acre farm, where she grows a wide-range of food crops.

One time, Amina was busy attending to one of her children, who fell sick, the situation that forced her to stop from attending her farm as she used to do for almost two months.

After that period, the woman went to her farm only to find it's invaded by her neighbour who claimed to be the owner of the land. A battle over the land ownership erupted and intensified and Amina was advised to lodge a case at Old-Korogwe Land Tribunal.

"Following the verdict, I lost the land but I did not give up, because I knew that's my property which I bought with my own money," said Amina, adding: "I was also advised to seek legal advice from paralegals in this area. I talked to one of the paralegals, Maimuna Hosea for help, who assisted me to prepare the necessary documents. I lodged an appeal at the District land and housing tribunal and I won the case."

"Since then, the neighbour accepted defeat and has not disturbed me up to now," said Yahaya Seif, Korogwe paralegal who led a team of paralegals who assisted Amina to recover her property.

Seif said: "Specific and special legal aid services should be extended to the elderly in rural areas throughout the country, who are at the threat of being driven out of their land because of their poverty and illiteracy."

One of the activists in the area, Ramadhan Mweli, said: "Actions must be taken--at the local to the national levels, to protect poor women and men from land grabbing."

He said that Amina is one of many women in Tanzania who are the victims of land grabbing and being denied their rights to own properties including land for whatever reasons.

"Elderly women are the main victims of these land-related problems," said land expert charity Mugabi in a recent study.

"Current national land policies and approaches have not been able to resolve these problems," he

RAPID-expanding Mloka village, 75 kilometres East of Nyerere Hydropower plant at Stieglers Gorege in Rufiji, has become Tanesco's biggest challenge in REA rural electrification.

Neither the first nor the second phase of Rural Electricity Agency's (REA) electrification has been able to meet the colossal power connection demands of the village with a population in excess of 5,000 inhabitants.

REA power connection has been highly concentrated in the central areas of the village to coy visiting Government officials while those households located on the outskirts still crippling for the service as they are condemned to eternal darkness.

Mloka village comprise four suburbs of Kwangwazi, Nyakisiku, Mpanga and Mkange. Since the REA phase One electrification kicked off in 2017 here, Mkange has been hardest hit only for a latest move by Tanesco to distribute electric poles ahead of President John Magufuli power plant project launch

at Stieglers Gorge.

However, Tanesco's efforts to silence Mkange residents' power connection woes have been hit by unexpected controversy last month.

Despite quality surveying across the suburb, power connection poles were installed in the most awkward way much to the surprise of everyone here.

Survey and then installation of the poles was done at a broad daylight as Tanesco fieldsmen worked with an incredible pace and precision few days ahead of the Nyerere Hydropower plant project launch.

Before that, people have not seen Tanesco fieldsmen working overnight with that rare speed and enthusiasm.

However, for reasons best known to them, some of the electric poles were installed on bare or rather plain residential plots with no sign of being developed in the near future. Musa Issi, Hassan Buma and Kassim Kitimai are among the most frustrated Mkange residents who

are unhappy with awkward installation of electric poles. More surprise some poles have been left sprawling on the ground for no apparent reason. When Buma tried to query Tanesco fieldsmen over the unattended pole, he was told to 'cooperate' if he wants the pole to be installed close to his house to ease connection. Buma failed to raise the 'cooperation package' sum. The pole is still lying on the ground presumably as'bait' awaiting someone else who would be able to meet the condition.

People are left in complete bewilderment whether prudence and mathematical vectors were observed during poles installation and how Tanesco would recover its return on investment through electric poles installed

on bare plots.

While this was done in Mkange, the nearby fast-expanding Nyakisiku suburb which has over 60 households ready for connection is still in strong need for power poles ahead of

submitting applications in an attempt to fill power-connection

Row erupts over REA power line installation

This controversy has raised eyebrows not only to Nyakisiku residents but even to some of their counterparts in Mkange who have been overlooked in the distribution of power poles. Unless your house has been reached by nearby power pole, then you cannot collect form and fill it for power connection, a condition imposed by Tanesco.

When contacted for comment, Tanesco manager for Rufiji, Said Masoud said the distribution of power poles in Mkange suburb has been done to meet longstanding demand of the area's residents.

Comfortably sipping his Castle- Lite beer at Mloka's famous Puga Bar, Masoud said Mkange residents had voiced their complaints that reverberated across ministerial corridors and there was no way to allocate some of the poles to other demanding suburbs. He also added that Tanesco surveyors worked closely

with Mloka village chairman, Hemed Mlohya who stamped his authority over where and how the poles should be installed. Avoiding more questions Mlohya who appeared in pensive mood and nervous, said Mloka residents should first thank Tanesco for installation of

the poles no matter how.

This controversy has been a talk of the day by Mloka villagers; each is surprised to see power poles have been installed on under developed residential sites while many households are left with in-depth quest for power connection. The poles have been subjected to possible destruction by frequent wildfires outbreak which goes uncontrolled here with an increased frequency.

frequency.
Speculations are rife here that that this blunder was possibly done to suppress owners of households who are likely to challenge and contest the incumbent village leadership ahead of forthcoming local government elections in November.

It is not known whether incumbent chairman Mlohya will seek re-election for a second leader-ship tenure or otherwise.

In related development

Muhiddin Kilalile who resides in Kwangwazi was shocked to see other household owners getting power connection in the quickest of the speeds despite filling connection forms in recent days. Kilalile concluded all formalities for power connection

malities for power connection including payment on July 13, 2019 through receipt number 9910311902411 but was kept on indefinite pending tray, while some of those who made it in August have parted ways with darkness.


He wondered how Tanesco have been connecting power to households with LIFO (Last In First Out) system rather than FIFO (Fist In First Out).

Most owners of households who have been successful to be connected to REA power here are alleged to have in one way or another provided a costly 'cooperation' packages. Owner of hardware shop Said Kioze of Mpanga suburb and his neighbors had tried to 'cooperate' in 2017 but to no power connection avail. Kioze and his neighbors have parted with 800,000/but are still in darkness while in agony of their lost money. Kioze has paid money to one of Tanesco officials whose name is withheld.

The affected party is ready to give details of the dubious transaction should PCCB interrogate him. Another group of residents (Andrea Shija, Hassan Mkumba, Tabu Mkali and Kilalile) in Kwangwazi suburb are desperately organizing 'cooperation' package believing they can get access to REA power.

The situation is terribly pathetic as REA power has not been that much affordable in Mloka. Those who have been successful in power connection are reported to be ridiculing the rest and walks with pomp.

However, Tanesco manager for Rufiji said he would like to have every household in Rufiji connected with power only for budget limitations becoming a stumbling block.

European Commission President Juncker said on this occasion: "The EU has been a strong supporter of the Global Fund since its creation, when the AIDS, malaria and tuberculosis epidemics seemed to be unbeatable.

And today we are announcing a record contribution of a further €550 million. We hope the international community will follow suit and step up the fight to fulfil the Fund's target of ending these diseases' epidemics by 2030."

European Council President Tusk, representing the EU at this year's G7, made the announcement in Biarritz. It comes ahead of the Global Fund donors' conference that will take place with antiretroviral thera tributed 197 million more protect children and fan laria, and tested and tree people for tuberculosis.

in October in Lyon, as more support is needed so that developing countries can improve their health systems, reach universal health coverage and help end the 3 epidemics by 2030.

The Global Fund seeks to raise at least €12.6 billion (US\$14 billion) for the period 2020-2022. By 2023, these funds should help save an additional 16 million lives, avert 234 million infections, cut the mortality rate from AIDS, tuberculosis and malaria in half, and build stronger health systems.

# World War II: We should never allow World War III

UNDAY (September 1) saw the world mark the 80th year since the start of the Second World War - or World War II. It is important for the new generation to know the truth about that war if they are to understand the looming threat to world peace.

After six long years (1939 to 1945) of war that claimed the lives of over 60 million people, it was victory over fascism following which a new global political map emerged and social transformation occurred in Africa and Asia, accelerating the process of decolonisation on the two continents.

History books show that this bloodiest and most destructive of the wars humankind has witnessed involved armies from 61 countries with a total population of 1.7 billion people. That means that some 80 per cent of the world's population (then estimated at 2.1 billion) took to the

The operations of the war engulfed 40 countries, with the number of deaths among civilians by far exceeding that of those killed in active combat.

Historians say that the war took firmer and firmer root right from World War I (1914 to 1918), which did not end with peace but merely with a truce through the Versailles Peace Accord of 1918. Victors Britain and France did not want to part with their acquisitions, while vanquished Germany sought to recover losses.

What occurred after World War I is that the number of dictatorial regimes began to multiply in Europe, igniting the flames of the eruption of a new war. Fascist Italy's 1935 attack on Ethiopia, the fascist insurrection of General Francisco Franco in 1936 and the ensuing civil war in Spain constituted a prelude to the conflagration of the world war that was to

Another important factor was the emergence of the USSR (now the Russian Federation, which assumed the rights and obligations of the Soviet Union after the political changes of 1991). In the eyes of politicians in the West then, this posed a real danger of the spread of socialist ideas which West European countries would never tolerate. 

In Germany, in the wake of economic and political crises after World War I, power passed over to the Nazis - the Nationalsozialistische Deutsche Arbeiterpartei or National Socialist Workers Party of Germany -The Hitler regime was determined

Renowned Scottish historian Niall Campbell Ferguson writes in this regard: "When the Soviets proposed a tripartite alliance of Britain, France and Russia in order to protect not only themselves but also their immediate neighbours from German aggression, they were refused..."

Seeing that it had been left alone in respect of the obvious danger of aggression in 1939, the USSR was forced to sign a non-aggression pact with Germany. Known as the "Molotov-Ribbentrop Pact", it had then foreign ministers Vyacheslav Molotov (USSR) and Joachim von Ribbentrop (Germany) as signatories.

Those now trying to "rewrite" history and claiming that it was this pact that pushed Hitler into war "forget" about the 1938 Munich Agreement. In fact, it is this latter treaty that enabled the Soviet Union to hold back Hitler's attack for almost two years.

So, 80 years ago yesterday, the writing of the first stage of World War II began. Germany attacked Poland, and the capture of Poland turned into a war of global proportions - a world war.

Denmark fell in the path of the German army in April 1940, with Norway following suit soon after. Germany then attacked France through The Netherlands, Belgium and Luxembourg.

The Germans reached the English Channel on May 20, 1940, and the

armies of Holland and Belgium capitulated. Meanwhile, Germany had seized Bulgaria by April 1, 1940 - and Greece and Yugoslavia a short five days later. With that, the whole of Western and Central Europe had literally fallen under Hitler's rule.

From Europe, the war spread to other parts of the world. Italian and German troops launched an offensive in North Africa, the autumn 1941 plan being to begin the conquest of the Middle East and India.

The German attack on the Soviet Union began on June 22, 1941, upon which the second phase of the war began. To ensure the conquest of the Soviet Union, Germany and its allies deployed an invasion army of unprecedented magnitude.

However, the war against the Soviet Union did not go as Hitler and his generals had wished. The plan of a "lightning" capture of Moscow and Leningrad failed.

Come December 1941, the military situation in the Pacific deteriorated even further. Japan attacked the American naval base of Pearl Harbour - and the Americans shot back by declaring war against Italy, Japan and Germany.

Japan then seized part of China, French Indochina, Malaya, Burma, Thailand, Indonesia, the Philippines and Hong Kong. Great Britain, Holland and the United States all suffered great losses in the Java operations.

The battles that began in 1940 in North Africa saw the Anglo-American troops rout the Germans and Italians from Egypt, Ethiopia and the Maghreb in May 1943. Some 1.4 million African soldiers were recruited from colonies and protectorates to fight in the "alien" war in North Africa and Southeast Asia. Among them were about 100,000 from the then Tanganyika.

In fact, the fate of the whole world war was decided in the battle for Stalingrad on the Russian river Volga from July 1942 to February 1943 and in the grand tank battle in the fields near Kursk in the heart of Russia.

In the Battle of Stalingrad both sides deployed a total of more than 2.1 million soldiers, tens of thousands of guns and thousands of tanks and

The Kursk tank battle of between July and August 1943 involved about 2 million people, 6,000 tanks and 4,000 aircraft, and it paved the way for the 1944-1945 great Red Army offensive.

On July 25, 1943 Italy pulled out of the war and the Italian fascist government was liquidated. The new government then declared war against Hitler, heralding the beginning of the crumbling of the fascist union.

In June 1944, the Red Army began operations meant to liberate Eastern European states. It became clear to everyone, and in particular to the German generals, that Germany had lost the war.

On June 6, 1944 the Second Front was opened - at last. A total of 156,000 soldiers from the US, Britain and Canada landed in Normandy on the west coast of France. It was one of the most active actions by the Western allies.

At the end of April 1945 the Red Army entered Berlin, the so-called den of the Nazi beast, and hoisted the Red Banner over the Reichstag (Germany's Parliament Building). Joint action by countries constituting the anti-Hitler coalition had led to the defeat of the German troops and Germany's final surrender.

The war in the Far East and in territories of Southeast Asia ended months later - on September 2, 1945, with the US having deployed nuclear weapons against Japan.

According to authoritative data, 26 million people were killed and 25 million were rendered homeless in the Soviet Union alone. The number of deaths elsewhere: Poland - over 6 million; Germany - 5.5 million; the British Empire - 4.19 million; the French Empire - 2.685 million; Japan - 2.5 million; and the US - over 1.4 million. Many other millions of people are said to have died in China, Indonesia and Indochina.

The world is today witnessing consistent efforts towards what is called "revision" of what occurred during World War II. It is done through newspaper articles, books, movies and radio and TV programmes.

It is clear that the primary intention is to belittle the political and moral authority of the countries that suffered the heaviest losses in the war. But ruins courtesy of the bombardments in Hitler-era Germany by the American military in the allied western forces well after Hitler had already succumbed are there for everybody to see and judge.

From the results and effects of World War II, humankind ought to have learned numerous lessons, one being that a Third World War should not be allowed, as there will surely be no winners.

Among the other lessons: totalitarian regimes with imperial ambitions should not find legroom, there should be collective global security because no country can guarantee its own security at the expense of other countries, and the deepening of mistrust between and among states should not be tolerated.

In order to reach out to and develop local entrepreneurs, NBC has collaborated with Tanzania Trade Development Authority (TanTrade), the Small Industries Development Organisation (SIDO), the Tanzania Investment Centre, the Tanzania Chamber of Commerce Industries and Agriculture (TC-CIA) and Tanzania Revenue Authority in organising capacity building workshops for Tanzanian entrepreneurs.

This partnership is invaluable in that these resource institutions provide entrepreneurs with a wide range of knowledge, spanning from market linkages to machine technology, tax regulations, investment opportunities and financial facilities to help make their businesses tick.

NBC business clubs have thus far been launched in Arusha, Kahama, Mbeya, Moshi and Mwanza, with Sabi saying the long-term plan is to cover Tanzania and outside the continually seek opportunities to be a every region where NBC has a pres-

"Membership in the clubs will mainly comprise NBC's SME customers but also other people at various locations across the country," he says.

The bank has trained over 900 entrepreneurs in the last two years and has spent over 150 million/- since 2017, organising capacity building workshops for entrepreneurs in different parts of the country.

The graduates selected are exposed intense training designed to mould them into competent and skilled workers. Eligible graduates are sourced through an application process following advertisement published in the media.

After thorough screening, the lucky candidates are deployed at various NBC departments based on their qualifications and the departments' needs. The bank has to date employed eight young graduates through this programme.

NBC has gone a step further in empowering young Tanzanians in tertiary education. Last year it enabled five students to pursue higher education under the African Leadership University Scholarship Programme tenable in Kigali, Rwanda.

These were selected through an application process published in the media, followed by rigorous screening. The students are now pursuing their academic dreams at the Rwanda International University in Kigali.

The students have just completed their six-month Leadership Foundation Programme, a must prior to the commencement of three-year academic studies in IT, Marketing, Business Management and Human Resource Management. They ate also just done with their field attachment stints at the NBC Head Office in Dar es Salaam.

# Grain millers urge government to reduce power tariffs, abolish nuisance charges

**B** y Beatrice Philemon

RAIN millers want the government to reduce power tariffs and abolish a number of nuisance charges imposed on their factories which balloons production costs and render their goods expensive.

Presenting recommendations on behalf of grain processors at a meeting of stakeholders which was presided over by Minister of Agriculture, Food Security and Cooperatives, Japhet Hasunga, Chairman of Maize Flour Milling Machine Owners and Manufactures, Oscar Mnisi said they are struggling to compete because of high costs of production in the local market.

Mnisi said among other nuisance charges which they pay include service levy, fire extinguishing equipment fees, storage charges for maize flour, value added tax and hiked transport costs blamed on taxes.

"We want to have better storage facilities charging reasonable fees because currently, most warehouse facilities available in

the country lack the required standards for maize and rice storage while charging highly," he noted.

He said their main goal is produce high quality maize flour and rice that meets international standards so that the products sell anywhere in Southern African Development Community (SADC) market, East African Community and globally.

Mnisi requested Hasunga to convince his Treasury peer, Dr Philip Mpango to abolish 18 VAT charged on imported industrial machinery and equipment which the millers use to add value to maize and paddy rice before supplying markets.

"18 percent VAT charged on imported irrigation equipments including water pumps, spraying machines, weeding machines and milling machines is frustrating us," he added while noting that packaging materials are also charged VAT.

He also urged the government to employ and deploy more extension officers to assist smallholder farmers improve quality and quantity of their commodities used by

millers as raw materials because currently the quality is very poor.

"Please help us to train farmers on how to produce high quality maize, paddy rice to so that the quality of the finished products is also high hence capable of penetrating any market," he argued.

Responding to the numerous observation made by the private sector, Minister Hasunga promised action on a number of issues raised which directly fall under his jurisdiction while lobbying his peers in matters relating to other ministries.

"I will sit down with my ministry's experts and see how we can convince Treasury to waive VAT on imported industrial machinery and equipments as well as fees charged on flour and rice from factories so that we can lower the cost of doing business," he said.

He said his ministry will continue supporting grain millers and traders who work with smallholder farmers to find reliable markets for commodities which get value

# Shareholders yet again reject **MultiChoice's executive pay**

SHAREHOLDERS in Multi-Choice, which was unbundled from Naspers on March 4, rejected the group's executive pay at Thursday's AGM.

Only 50.26% of shareholders voted for the remuneration policy, while its implementation attained only 44.73% of shareholder support. More than half - 55.27% - voted against it, with around 2% abstaining. These are non-binding votes put to shareholders as part of the JSE's listing requirements.

This is the third time shareholders have shot down a JSE Top 40 company's remuneration. In May, 69% of Old Mutual shareholders rejected the implementation of its remuneration

In April it was revealed that 73% of ordinary shareholders voted against Shoprite Holdings' remuneration policy last October, and 69% against its implementation. Because of Shoprite's deferred share structure, both those resolutions passed.

In MultiChoice's integrated annual report, remuneration committee chair advocate Kgo-

motso Moroka notes three issues that were raised by shareholders during engagement in the listing process: Does management have equity participation to align with shareholder interests? Are there performance metrics in the share scheme? Why were executive long-term incentives not included in the pre-listing statement?

The committee provides responses to each of these. It is the reply to the last of these that shareholders may not be content with: "At the time of the prelisting statement, the new MCG [MultiChoice Group] Trust Deed had not been registered to approve new awards."

Big three shareholders

The group's three largest shareholders are the Public Investment Corporation (PIC), which holds 13.81%, Allan Gray, which holds 8.53%, and Prudential Investment Management, with 5.3%. Given the large number of votes against both resolutions, it is highly likely that the PIC voted against them.

Old Mutual Investment Group, a shareholder with a smaller holding, voted against the remuneration policy, but for its imple-

MultiChoice's policy is warranted as: "A significant portion of awards under the new LTIP [long-term incentive plan] are not performance-related, and all awards vest as early as two years from the date of grant." It adds that "the total number of shares reserved for the new scheme exceeds the recommended limit."

Regarding the implementation of the remuneration policy, it says "upon engagement with the company, we have been given sufficient detail on the reasons for the sign-on and discretionary bonuses this year which as a result do not warrant a vote against this resolution."

**Bonuses** 

Chief financial officer Tim Jacobs was paid a sign-on bonus of R3.81 million during the year. The group's remuneration committee says a R556 000 discretionary bonus paid to Jacobs was due to him being "instrumental in the successful listing of MCG since joining MCG in November 2018." Further discretionary bonuses were paid to executive chair Imtiaz Patel (\$22 000) and chief operating officer Brand de Villiers (\$31 000). These were

"to recognise Imtiaz's role in leading the successful listing of MCG and the Naspers unbundling" and "to recognise a significant increase in Brand's portfolio and change in role during the year."

Separately, senior employees participated in the option share schemes while MCG was part of the Naspers group. "Following the unbundling, the vesting dates for the

Naspers option awards were accelerated in line with the rules to the date of the MCG listing on 27 February 2019." Patel made a gain of R14.5 million on his options, De Villiers a gain of R4.8 million, and Mawela a gain of R2.4 million.

# Tax collection from imports, locally made goods and services increases marginally

TAXES charged on imported goods and those levied on locally made goods and services increased marginally during the year ending June 2019 compared to the previous

Bank of Tanzania has said in its latest Quarterly Economic Bulletin that the central government did well in collection of taxes on imports and locally made goods and services but performed poorly on collection of non-tax revenue while grants received were way low compared to

"During the period taxes on imports increased to 1.46trn/- from

1.38trn/- while taxes on local goods of which recurrent expenditure was and services increased to 876bn/from 783bn/- registered the previous year," the report stated. Non-tax revenue declined to 508bn/- from 699bn/- collected during a corresponding period in 2018.

Likewise, local government revenue collection from own sources increased to 189.1bn/- from 150.2bn/-

during the period. In generally, the BoT report stated that revenue collections by central government in total grossed 4.27trn/- during the year compared to 4.36trn/- collected in the corre-

sponding period in 2018. On expenditure, the report stated that the government spent 7.37trn/-, er than 4 percent last year which

4.76trn/- while development expenditure was 2.61trn/- compared to 6.195trn/- in the preceding year.

The Central Bank further said total domestic credit issued by banks, which comprise credit extended to the government and private sector, grew by 17.3 percent compared to 1.5 percent registered in the previous

"This significant growth was on account of increased credit to both the central government and private

sector," the quarterly report added. According to the bulletin, annual growth of credit to the private sector was 7.6 percent which was highreflected the impact of sustained accommodative monetary policy and on-going government efforts to improve the business environment and credit risk measures taken by banks to reduce default rate.

Interest rates charged by banks on loans and offered on deposits were relatively lower during the quarter ending. Overall savings deposit rate increased to 2.45 from 2.13 percent while overall lending rate dropped to 17.07 percent from 17.53 percent during the period.

The spread between one-year lending and deposit rates also narrowed to an average of 8 percent from 9.1 percent in June 2018, the BoT quarterly report noted.

# It's long road ahead for South African retailers

YOU know the economy is tough when Woolworths sees its clothing and beauty sales fall and management still pats itself on the back for a job well done.

"It's a really good set of results," says Woolies CEO Ian Moir. "We took market share in tough conditions." This was despite its fashion, beauty and home division seeing profit fall 1.1% to R1.68 billion for the year to end-June. The drop is however something of a turnaround, as this division plunged 21% to R1.7 billion in the corresponding prior period.

The recovery is even more remarkable when measured against its performance in the first half of its 2019 financial year, which saw this division's sales fall 11.8% for the period.

Even so, Moir does not see the economy coming to the group's aid anytime soon, with sluggish trading conditions expected to persist in South Africa and Australia, its other key market. Uncertainty about the government's plan to boost the economy in SA and the slowing housing market in Australia has dampened consumers' willingness to spend.

Woolies is not the only local retailer that has struggled to find traction in a difficult economy. Big box retailer Massmart and Africa's largest supermarket chain, Shoprite, have also found the going tough. Massmart saw trading profit collapse from R664.4 million to R318.9 million for the half year to end-June. There is a similar story at Shoprite, where trading profit for its South Africa operations fell 9.1% to R6.55 billion for the year to end-June.

The difficulty for retailers can be seen in Statistics SA's latest retail sales numbers, showing just a 2.4% rise year on year for the month of June. Aside from softening consumer confidence, local retailers didn't do themselves any favours; several of them made strategic mistakes that have compounded their problems.

The difficulty at its David Jones chain in Australia, for example, saw Woolworths reduce the value of this asset by Au\$437.4 million (R4.5 billion) this year, following it writing off Au\$712.5 million (R6 927 million) in the previous year.

Woolworths bought David Jones for R21.5 billion in 2014. At the time, the acquisition was part of a broader plan to turn Woolies into a global retail player. Instead, the problems in Australia led to the South African retailer incurring a loss in 2018.

The lengthy redevelopment of David Jones's flagship Elizabeth Street store in Sydney has also not helped. The redevelopment started in the second half of 2017 and is expected to be completed by March 2020.

The renovation is part of several chain-wide initiatives aimed at improving David Jones's performance; others include the implementation of new merchandising, finance and online systems, and the relocation of its head office from Sydney to Melbourne.

Moir says most of these initiatives are complete and the group is now well placed to profit from them. Even so, getting to this point has not been easy. In February, David Jones CEO David Thomas resigned with immediate effect for "personal reasons". Moir, who is based in Australia, has since taken over the running of the chain.

The problems in Australia were further compounded by the sudden resignations of two of its Australian-based board members, Patrick Allaway and Gail Kelly, days later in February. The board has since been boosted with the addition of former Clicks CEO David Kneale, who joined as an independent non-executive director in March.


Tough trading conditions and the lengthy redevelopment of its flagship store saw David Jones's sales collapse from R660 million to R378 million. David Jones is not the only problem Woolies has had to contend with. Its other Australian chain, Country Road, also faced an uphill battle - with profit falling 1.6% to R1 billion, and sales for the year growing just 0.5%.

It was not all bad news in Australia, however. Country Road's online sales rose 12.9%, and now represent 20.3% of total sales for the chain. There was a similar story at David Jones, where online sales were up 46.8% and contributed 7.7% to its total sales.

## Grocery growth

Although a tough year for Woolies, its local food operation has grown in strength - with operating profit up 5.4% to R2.28 billion. The group expects food to continue to grow in terms of volume, and to take market share. The food division accounts for the bulk of the group's profit, followed by fashion, beauty and home at R1.68 billion, Country Road at R1 billion and David Jones at R378 billion.

# KRA seeks 35pc tax on ads placed by betting companies

NAIROBI

THE Treasury and the Kenya Revenue Authority (KRA) want a 35 percent tax imposed on all advertisements booked by betting firms through radio, television, online, billboards, short messaging service and any other medium.

Mr Caxton Masudi, the KRA deputy commissioner in charge of policy told Parliament that the base of taxation should be pegged on the cost of the advertisement. Appearing before the National Assembly's Sport and Tourism committee to present KRA's views of the Gamming Bill, 2019, Mr Masudi proposed that it be amended to cover all media.

"There shall be a tax to be known as the gaming advertisement tax chargeable at the rate of 35 percent on the cost of the gamming advertisement done through radio, television, newspapers, short message service and any other advertisement medium," KRA proposed.

Treasury Chief Administrative Secretary Nelson Gachuhie asked MPs to make it a criminal offence for betting firms that fail to disclose or provide data on betting revenues to the KRA. The recommendations follow similar proposals by the Betting Control and Licensing Board (BCLB) which called for restricted advertisement on betting.

# **UK Prime minister** Johnson threatens **Brexit rebels with** party expulsion

#### **LONDON**

BRITISH Prime Minister Boris Johnson threatened to expel rebel lawmakers from his Conservative Party if they thwart his Brexit plans by voting to prevent a no-deal exit from the European

Johnson's promise to leave the EU on Oct 31 with or without a divorce agreement has propelled the United Kingdom towards a constitutional crisis and a showdown with the 27 other members of the bloc, with an election one of the possibilities.

Conservative Party rebels are plotting with opposition parties to take control of parliament and tie the government's hands with legislation that would block a no-deal exit from the EU which they say would be ruinous to the economy.

With just over 24 hours until parliament returns on Tuesday from its summer break, Johnson's enforcers warned rebels that if they voted against the government they would be giving control of parliament to Labour Party leader Jeremy Corbyn.

"If they fail to vote with the government on Tuesday they will be destroying the government's negotiating position and handing control of parliament to Jeremy Corbyn," said a source in the whips office, which is responsible for party discipline.

"Any Conservative MP (member of parliament) who does this will have the whip withdrawn and will not stand as Conservative candidates in an election," the source said.

More than three years since the United Kingdom voted 52-48% in a referendum to leave the European Union, it is

still unclear on what terms, or indeed whether, Brexit will take place.

Corbyn, Labour's veteran socialist leader, will say on Monday he is ready to do everything possible to stop a no-deal Brexit, describing it as a final attempt to pull "our country back from the brink".

In the parliamentary chess game over Brexit, it is also unclear what Johnson's response will be if the alliance of rebel Conservative lawmakers and opposition parties succeed in defeating the government.

Johnson, the face of the 2016 Vote Leave campaign, has cast rebels as EU "collaborators" who are undermining the government's negotiating hand by blunting his threat of a no-deal Brexit.

"Their (the government's) strategy, to be honest, is to lose this week and then seek a general election," said David Gauke, a former justice minister who is one of the rebel Conservative lawmakers. An election is one of the options under consideration, BBC Political Editor Laura Kuenssberg said.

House of Commons Leader Jacob Rees-Mogg

said any wise party would prepare for an election and that the rebel legislation would be considered a matter of confidence in the government. "It is important for the government to establish the confidence of the House of Commons and this is essentially a confidence matter: Who should control the legislative agenda, Jeremy Corbyn or Boris Johnson?" Rees-Mogg said.

An election would open up three main options: A Brexit-supporting government under Johnson, a Labour government led by Corbyn or a hung parliament that could lead to a coalition or minority government of some kind.

After Johnson moved to suspend parliament ahead of Brexit, opponents of a no-deal exit are seeking to overturn his decision in the courts. Hearings are due on Sept 3, Sept 5 and Sept 6.

Nick Boles, a former Conservative who now sits as an independent member of parliament, said the rebels would seek to force the government to ask the EU for a Brexit delay if it was unable to ratify a revised Withdrawal Agreement by a certaindate in October.

# Texas gunman fired from job before massacre, victim IDs emerge - media

#### **TEXAS**

THE man who killed seven people and wounded 22 others in a rolling rampage across West Texas on Saturday was fired from his trucking job hours before the massacre, media and officials reported.



Details about the Labor Day weekend shooting and the names of some of the victims were emerging online and from officials on Sunday and early Monday. Police continued to comb through 15 different crime scenes in neighboring Midland and Odessa, Texas.

The gunman, identified by police as Seth Aaron Ator, 36, of Odessa, had been fired from his truck-driving job in Odessa on Saturday morning, the New York Times and other media reported.

Hours later, Ator (pictured) was pulled over in Midland by Texas state troopers on Interstate 20 for failing to use a turn signal, police said.

Armed with an AR-type rifle, Ator fired out the back window of his vehicle, injuring one trooper. Then he drove away spraying gunfire indiscriminately, the Texas Department of Public Safety said in a statement.

At one point, Ator abandoned his vehicle and hijacked a U.S. postal van and mortally wounded the postal carrier, identified postal officials as Mary Grandos, 29.

Ator was later cornered by officers in the parking lot of a cinema complex in Odessa. He was shot and killed.

"There are no definitive answers as to motive or reasons at this point, but we are fairly certain that the subject did act alone," Odessa Police Chief Michael Gerke said at a news conference.

Online court records showed Ator had convictions in 2002 for criminal trespass and evading arrest. The Midland Reporter-Telegram newspaper quoted a state lawmaker, Rep. Tom Craddick, as saying he had previously failed a background check.

Gerke offered his condolences to their families of the dead and wounded.

"My heart aches for them all," he said.

Among the dead was Grandos, who various news media reported was at the end of her shift and on the telephone with her twin sister Rosie Grandos.

"She didn't deserve this," a tearful Rosie Grandos said in an interview with CNN late Sunday. "I was talking to her on the phone and she said she heard gunshots but didn't know where they were coming from.

"I heard her screaming," she said. "I was hearing her cry and scream for help. I didn't know what was happening." Rosie Grandos said got in her car and drove to her sister. By the time she arrived, she saw her sister lying on the ground, she said.

The Washington Post reported that others among the dead were Edwin Peregrino, 25, who was killed outside of the home he moved into a few weeks ago.

Also killed was Leilah Hernandez, 15, who had just celebrated a coming of age party, the newspaper reported. Joseph Griffith, 40, was killed as he waited at a traffic light with his wife and two children, the newspaper re-

Among the wounded was a 17-month-old girl, Anderson Davis, who was shot in the face, according to officials and an online fundraising campaign started by her family.

In numerous media interviews, her family that the child underwent surgery and will recover.

# Iran warns of 'strong step' away from deal if no new terms

It remains unclear what further step Iran will take, though it could involve restarting advanced centrifuges prohibited by the deal or further bumping up its enrichment of uranium. Iran insists the steps it has taken so far are easily reversible.

"We will announce implementation of the third step in a letter to the Europeans if the Europeans do not impalement necessary measures by Thursday," said Zarif in a Sunday interview with Iran's parliament news agency, ICANA.

The nuclear deal is meant to keep Tehran from building atomic weapons in exchange for economic relief. It has been complicated by the unilateral withdrawal of the United States from the deal and Washington's increased sanctions on Tehran, which have been taking a toll on the Iranian economy.

That has left the other signato ries struggling to come up with enough incentives to keep Iran in the deal.

Meanwhile Monday, an Iranian oil tanker pursued by the US that has been traveling across the Mediterranean Sea is now off the coast of Tripoli in northern Lebanon. The ship-tracking website MarineTraffic.com showed the Adrian Darya 1 moving slowly just outside the Lebanese territorial waters, after it had stood off the coast of Syria a day earlier.

US Secretary of State Mike Pompeo has alleged the ship is bound for a refinery in Syria, which was the reason that authorities had seized the vessel off the coast of Gibraltar in July.

The US has warned countries not to accept the Adrian Darya, which carries 2.1 million barrels of Iranian crude oil worth some US\$130 million.

# Dorian pummels Bahamas, forecast to threaten Florida

TITUSVILLE, Fla

HURRICANE Dorian, the secondstrongest Atlantic storm on record, pounded the Bahamian islands of Great Abaco and Grand Bahama on Sunday night and was forecast to move dangerously close to Florida in the next two days, US forecasters said.

Hazards for the Abaco Islands included storm surges 5.5 to 7 metres above normal tide levels, with higher destructive waves, the Miami-based US National Hurricane Center (NHC) said.

At 11 pm GMT, the hurricane was about 220 km from the Florida coast, parts of which were being evacuated, as it crawled westward. Farther north, South Carolina Governor Henry McMaster ordered mandatory evacuations for parts of eight coastal counties effective at noon

Georgia Governor Brian Kemp ordered evacuations in all or parts of six coastal counties also effective at noon on

Even a glancing blow from one of the strongest storms ever to menace Florida could bring torrential rains and damaging winds, the NHC said.

"On this track, the core of extremely dangerous Hurricane Dorian will contin-

ue to pound Great Abaco and Grand Bahama islands tonight and Monday," the NHC said. "The hurricane will move dangerously close to the Florida east coast late Monday through Tuesday night."

Dorian is forecast to remain a hurricane for the next five days, the NHC said. Dorian made landfall on Elbow Cay in the Abaco Islands with maximum sustained winds of 295 kph and gusts of more than 354 kph.

Dorian was the strongest hurricane on record to hit the northwestern Bahamas as a life-threatening Category 5 storm on the five-step Saffir-Simpson Wind Scale.

It was tied with Gilbert (1988), Wilma (2005) and the 1935 Labor Day hurricane for the second-strongest Atlantic hurricane on record, based on maximum sustained winds. Allen in 1980 was the most powerful, with 306 kph winds, the NHC said.

Julia Eaddy, 70, in Titusville, Florida, said she and her husband had ridden out several hurricanes before and were not fazed by the forecast. "I think it will be more of the same," she said.

Several gasoline stations around Titusville were closed. Many grocery stores were open but boarded up. Inside, shelves emptied out fast.

#### 'MONSTER STORM'

Like many officials in Florida, Governor Ron DeSantis warned residents against becoming complacent after forecasts began saying on Saturday that the state might escape a direct hit.

"This storm at this magnitude could really cause massive destruction. Do not put your life in jeopardy by staying behind when you have a chance to get

out," DeSantis said, urging people to heed evacuation orders from county officials. Dozens of Floridians who live in boats in marinas in Brevard County were rushing to secure their vessels, strapping them to docks and removing canvas coverings from decks, but some boat residents said they wanted to ride out Dorian. "I will not get off this boat during the hurricane for any reason at all, save a human life," said Ned Keahey,

56. "It's home." Residents on Abaco posted video on social media showing floodwaters halfway up the sides of single-family homes with parts of the roofs torn off. Car alarms blared across the island, which was littered with twisted metal and splintered wood. Forecasters predicted up to 76 cm

of rain. The storm was moving at just 9 kph on Sunday night, prolonging a pummeling expected to last for hours, the NHC said.

Bahamian Prime Minister Hubert Minnis said in a nationally televised news conference that a "deadly storm and a monster storm" was battering the islands. Homes there are built to withstand winds of at least 241 kph, but the expected storm surge was higher than the average roof.

"This will put us to a test that we've never confronted before," Minnis said. "This is probably the most sad and worst day of my life to address the Bahamian people."

Palm Beach County, the third mostpopulated county and home to President Donald Trump's Mar-a-Lago resort, was among those with partial mandatory evacuations. Other counties announced voluntary evacuations.

# Japanese PM plans to reshuffle cabinet next week

JAPANESE Prime Minister Shinzo Abe said yesterday that he intends to reshuffle his cabinet next week with a major revamp expected.

Following a liaison meeting of the government and the ruling coalition parties on Monday, the prime minister, who also heads the ruling Liberal Democratic Party (LDP), is expected to carry out the reshuffle on Sept. 10 or Sept. 12, sources

Sources close to the matter also said the line-up of LDP executives will also be changed, possibly on Sept. 10.

"I'd like to choose a lineup that can ensure both stability and takes on new challenges," Abe said at the meeting.

The prime minister is widely expected to retain his close allies Chief Cabinet Secretary Yoshihide Suga and Deputy Prime Minister Taro Aso, who doubles as finance minister, in their current roles. As for big names that might be on the move, LDP Secretary General Toshihiro Nikai, who has held his position for over three years, and economic revitalization minister Toshimitsu Motegi could find themselves posted to different positions.

Some sources close to the matter also believe that LDP policy chief Fumio Kishida may also be reassigned, while Shinjiro Koizumi, son of former Japanese Prime Minister Junichiro Koizumi, could be in the running for a Cabinet position, sources have said.

Abe, who previously reshuffled his cabinet and LDP executives in October 2018, said at the meeting he intends to respond to the strong public support shown in July's upper house election and to carry out all the policies he has prom-

**NAIVASHA** A FAMILY outing to the world's famous Hell's Gate National park ended on a tragic note after six of them and their guide were swept away by flash floods on Sunday evening.

The six family members who were part of a group of 13 drove pened," said Hayer. from the capital, Nairobi to visit the park that is known for its alluring landscapes including gorges and hills.

The accident came seven years after a similar incident left seven youths from Nairobi dead after been swept by the raging floods.

In the latest incident, the group of hikers that were accompanied by two guides went to the gorge after being assured that it was safe despite the driz-

Family members of the deceased who spoke to journalists in Naivasha narrated the horrific ordeal as the floods swept their kin one after the other as they watched at close quarters.

Ivraj Singh Hayer said he witnessed his wife slide and being swept away followed by his cousin, nephew and niece.

A grief stricken Hayer said all the hikers had been informed that the area was safe and that the guides would control them in case of an emergency.

He said although it began to drizzle, they had been told that it last rained in April and so there was no cause for alarm.

"We did not see any problem with us going down to the gorges and we met others on their way out so it was all safe until the unthinkable thing hap-

He said six of the family members jumped on one side and were lucky the floods did not get to them adding that the rest were all swept away in a horrific style.

"The guide was trying to save my nephew and they both slipped and were swept away by the floods," said Hayer.

The bodies of the dead were found about 30 kms from the scene of the tragedy following a major search and rescue operation conducted by local volunteers and a special team from Kenya Wildlife Service (KWS), Red Cross and Police.

Hayer's brother Dilraj Singh told of how he received a distress call from one of the family members and tried to call officers from KWS but no help was forthcoming.

"We have not received a call from KWS as of now and we are still waiting but we thank residents from this area for their tireless efforts to trace the bodies of our family members," said Singh

Aggrey Maumo, assistant director at Kenya Wildlife Service (KWS) Central Rift region led search efforts in the vast Suswa hills where the dead bodies were found kilometers apart.

Maumo said the tragedy occurred after heavy rains pounded the hilly areas of Longonot with stormwater finding its way to the gorges inside the Hell's Gate National Park.

While terming the incident as unfortunate, Maumo clarified that the park was safe for a visit by local and foreign tour-

"We will not close the gorges contrarily to information out there and this should not deter anyone from visiting this park," said Maumo.

Maenka Ole Kisotu, a community leader, regretted the incident saying it was caused by human activities that had depleted the environment.

Kisotu said massive environmental degradation had taken place in the area with charcoal burning taking a toll on trees and shrubs that could act as a buffer against surface water

run-off. "There is no vegetation here and once it rains we must have casualties and our animals are not spared either," said Kisotu adding that reclaiming Kenya's protected areas is key to boost tourism. Xinhua

# Serena on extent of ankle injury: 'We'll see tomorrow'

**NEW YORK** 

SERENA Williams charged into the U.S. Open quarter-finals on Sunday but it may have come at a price as the six-times champion suffered a right ankle injury.

Williams, who twisted her left ankle during a quarter-final loss at the Australian Open, said she did not think the latest injury serious but added it was too soon to tell.

"I usually know if it's horrible early on. I mean, I had a really bad ankle sprain in January. I was like, instantly, 'No, this can't happen. I'm finally healthy," Williams said after her 6-3 6-4 win over Petra Martic.

"But I'll see tomorrow. So far I'm good. I have been managing it. We'll see tomorrow."

Williams rolled her ankle in the fifth game of the second set, having raced to the net and landed hard on her right foot after a backhand volley that sailed long.

Seeded eighth, Williams took about 15 seconds to get to her feet but won the next two points to earn a crucial break for a 3-2 lead and then took a medical timeout so a trainer could look at her already-wrapped ankle.

Her coach, Patrick Mouratoglou, later told reporters that Williams was not in too much discomfort.

"It doesn't seem – there is the video, but what is more important is how she feels and how the ankle looks. The ankle looks okay," said Mouratoglou.

"She doesn't feel much pain. She feels, but it's acceptable. And we will know tomorrow when it's going to be cold."

Williams, who is seeking a record-tying 24th Grand Slam title and her first since the 2017 Australian Open, will face China's Wang Oiang in the quarter-finals.

Meanwhile, Patrick Mouratoglou, whose courtside coaching of Serena Williams in last year's dramatic U.S. Open final triggered heated debate, said on Sunday he would not change a thing about his actions.

Beaten finalist Williams was given a warning for a coaching violation after Mouratoglou gestured in the stands during the dramatic decider against Naomi Osaka.

The penalty infuriated Williams, who was later docked a point and a game for further code violations before falling in straight sets to Japan's Osaka.

"Do I regret? No, I felt like she was lost at that moment and I tried to help her doing something that everybody does that is the use of the tennis," Frenchman Mouratoglou told reporters

"I would do the same tomorrow. Really. 100 percent."

In-match coaching is permitted at WTA events but not at the Grand Slams or on the

men's tour. Chair umpire Carlos Ramos noticed Mouratoglou making hand gestures from his

seat early in the second set against Osaka. Williams, who was at the opposite end of the court when Mouratoglou signalled, denied she

"Because the player asked the coach to coach them at every match. I'm on tour for 20 years, and we all know that. They all do it because also the players want them to help, you know."

AN early exit by club champions Simba SC has clouded the outlook for this year's competitive season as well as the rivalry between city giants Young Africans SC and their Msimbazi Street opposite numbers, as their roles have suddenly changed.

As the soccer season in the country is really a prolonged test of wits between the city rivals, the tonality of the matter has changed as the nation's representatives are the losers in the premier league title hunt, and the club with the best registration to show around, is now confined to premier league soccer and regional titles when the case arises.

With both sides almost routinely uncertain of participating in the Kagame Cup tournament -they also missed out this year - that showing off window is closed, and the league defending champions may wait for turn of year Mapinduzi Cup to seek some silverware. Perhaps.

The season stands to be saved from a competition viewpoint if the three remaining sides in CAF tourneys put up exceptional performances, so as to reawaken the public mood from its stupor of the Simba exit after two matches, to sentimental inclusion in the tournaments.

The fan base in the country is essentially a city rivals' affair, and despite Azam FC winning titles, hiring the best coaches and recruiting players from an international or regional span

fan base. The whole idea of developing a taste for the club from the commercial products it is linked with was elaborately a fantasy.

That means no club among those who proceeded with CAF tourneys second stage is in a position to revive the rivalry linking continental performance with league prowess, where there is a need to clinch the title so that the clubs proceeds to prove its worth in continental competition. But a snag came up in the preliminary round format of the CAF Champions League, which effectively reduces participating teams to half the number of CAF member states or rather of eligible teams as both clubs could have passed for the premier competition.

Worse, in our case it was the guest appearance which clinched space for the proper tournament, while the more eligible side crashed from an away goal rule, which

isn't a surprise. Were it that it was the guest Champions League inclusion, Yanga who would have been hobbled out of the tournament, it would be hard luck on their side but understandable from a competition point of view, that they

were merely given a second chance. But when it is the champion side this elimination is nearly the same as nonparticipation in this year's tournament, which dampens spirits for the tournament is a sort of mirror, to take the pulse of soccer prowess and

for a number of years, it has built up a scant the position of our clubs on the map. Playing just two matches is not the same as elimination in fans' imagination but closely approximates a disqualification.

That is why the virtual disqualification is dampening interest in the premier league as the aftermath is not assured, as it hinges on passing a stern qualification test, where three billion shillings investments may not be a sufficient reason to believe that anything can be gained.

For it would have been something else to play in groups and see how the team fares, not an opening and return match, as any circumstance factors can upset the balance. The problem wasn't with the team, that it drew twice, but the tournament design.

In that case winning the premier league is still prized but is bracketed as for its proper significance, as in a sense the premier league now involves a foreign team, a checkmate as to who will participate in the CAF Champions

When a club is battling to obtain the title the rival side will just smile, as there is a good chance that, as it recently happened, the champion side is unseated from regional competition and the other proceeds. Worse, the second team provision came up only because Simba reached the finals in last year's tournament, in which case elimination this year would leave the Mainland out of the **SPORTS NEWS**

# Pogba is Man Utd's only world-class player, claims Saha

Having declared in pre-season he was ready for a new challenge after three seasons back at Old Trafford following four years at Juventus, Pogba has been unable to secure a move away.

Despite his own transfer desires, Saha praised Pogba's on-field response after finding himself still wearing a United shirt.

"He could have hidden, said he didn't want to play, but the first couple games he really did perform," he said.

"He represents so much in terms of potential for United that they ask him to be perfect but he can't because he's human."

After having a penalty saved in the Red Devils' draw with Wolves last month, Pogba was subject to racist abuse online with his teammates quick to rally around him.

Just last week, a sign outside of United's Carrington training ground was then also graffitied with the words 'Pogba Out'.

# Arsenal's derby fightback will do wonders for Unai Emery

RESULTS mean everything in football. Managers will always talk up the importance of performances, but supporters are more interested in the cold reality of the final score, which is why Arsenal head coach Unai Emery will have left the Emirates feeling like the big winner of Sunday's pulsating North London derby against Tottenham.

Emery spends most games wearing a pained expression in the technical area, but the Spaniard allowed himself to smile in the closing stages of this one, perhaps because deep down, he knew that he and his team got away with it against Mauricio Pochettino's side by claiming a 2-2 draw after falling 2-0 behind in the first half. "I'm pretty proud of our work," Emery said. "We played with our heart, sometimes more than our head and we need the balance. We need to be clearer in our mind."

That, in a nutshell, is the problem that Emery has to solve at Arsenal. Their football is too chaotic, but right now it is exciting chaos, and that is helping the former Paris Saint-Germain coach win the PR battle, if nothing else. On the pitch there was no victor, with Arsenal and Spurs taking a point each from a game that saw the home side trail 2-1 at half-time before salvaging a draw with a stirring second-half fightback.

In the first half, we saw the Arsenal that we usually see against a "Big Six" rival: outplayed, outfought, out-thought and defensively naïve. Since Emery replaced Arsene Wenger as manager in the summer of 2018, Arsenal have played 15 games against the "Big Six" in league and cup and won just three of them, while losing eight. The old failings of the final years of the Wenger era always seem to be triggered by an encounter with a well-resourced rival and, in the first 45 minutes of this game, it was the same old story.

A week after surrendering their 100 percent winning start to the season with a 3-1 defeat at Liverpool, the Gunners appeared to be going the same way against their neighbours. Yet the second-half was a different story. Determination replaced disarray where Arsenal were concerned, with Alexandre Lacazette's goal in first-half stoppage time providing the platform for the second-half performance, in which Pierre-Emerick Aubameyang earned the draw with a 71st minute equaliser.

Spurs helped their neighbours, by giving them the freedom to chase to the game, but Aubameyang's strike was a big goal for so many reasons.

First of all, it ensured that Arsenal did not lose this

game. Ahead of an international break, it would have almost signalled a mini-crisis at the Emirates had they gone into it on the back of defeats against Liverpool and Spurs, with their top four ambitions under fierce scrutiny. Staving off that kind of knee-jerk inquest was another upside from Aubameyang's equaliser, but for Emery, the goal and the draw also ensured that he could push on with his Arsenal rebuild with this result in the bank.

Supporters will always offer more patience towards a manager and a team when they see their players produce the kind of fightback which leads to a positive result from a seemingly lost cause.

Sending supporters away from a game with smile on their face and spring in their step is crucial at any time, but especially so when a club is in a state of transition and the rebuilding process is not without its difficulties.

Against Spurs, Emery's unsuccessful track record against the "Big Six" began to look like a growing problem during the first half, when Christian Eriksen and Harry Kane (the latter from the penalty spot) put Spurs 2-0 ahead.

All of those questions about Emery's tactical nous were beginning to rear their heads once again, especially after his disastrous ploy of using a diamond formation against Anfield that allowed Liverpool full-backs Andy Robertson and Trent Alexander-Arnold to wreak havoc down both flanks.

Even though Arsenal's defending was typically shambolic at times against Spurs, Emery's bold second-half substitutions, when he introduced Dani Ceballos and Henrikh Mkhitaryan in an effort to pose Tottenham more questions in their defensive third, led to the home side throwing everything forward and being rewarded

for their adventure.

Fortune favours the brave and that certainly applied to Emery and Arsenal, and if the second-half fightback ensures that the supporters spend less time worrying about their defending, the Gunners coach will be certainly happy about that. But he will also know that he cannot allow Granit Xhaka to defend so recklessly in future -- the Arsenal captain conceded a penalty for a ridiculous challenge on Son Heung-Min -- and he needs to find a way to get David Luiz fully focused on defending.

With the attacking talent in their ranks, Arsenal will always pose opponents problems going forward, but their defensive frailties will also lead to more occasions when they have to chase games.

As he embarks on his second full season in charge, Emery still has plenty of work to do, but days like this will only help buy him the time to see the job through.

# Bale scores twice and sent off as Madrid held by Villarreal

MADRID

GARETH Bale scored twice to save Real Madrid from a damaging defeat away at Villarreal on Sunday before capping a dramatic 2-2 draw by being sent off in injury-time.

Zinedine Zidane said in July it would be "best for everyone" if Bale left this summer but it was the Welshman's double that earned Madrid a point from a thrilling contest at la Ceramica.

Villarreal took the lead through Gerard Moreno in the 12th minute and then Moi Gomez 16 minutes from the end but each time Bale pegged them back, first on the stroke of half-time and then four minutes from the end.

Two yellow cards in as many minutes then saw Bale dramatically sent off in the 94th minute but by then his match-saving contribution was complete.

"I am pleased with his goals, of course, and now we have to think about a rest," Zidane said. "Although he won't rest as he's going away with his national team." It was six years to the day that Real Madrid paid 100 million euros (now \$110m) to sign Bale, who now has 104 goals for the club, as many as the Brazilian Ronaldo.

But his heroics could not save Madrid from another slip, which means they head into the international break five points behind early front-runners Atletico Madrid, who had earlier beaten Eibar 3-2.

"We have to improve defensively," Zidane said. "We know we can create chances. The positive is the reaction we showed because it is important not to lose." Asked what was lacking, Casemiro said: "We lacked everything."

After drawing at home to Real Valladolid though, this was not the result Zidane would have wanted, particularly given he threw two new signings into his starting line-up.

Luka Jovic and Ferland Mendy both started, with

Bale on the left of midfield in a 4-4-2, a sign of Zidane's renewed faith in the 30-year-old's defensive capabilities. Zidane has now won only six of the 14 matches

since he returned as coach in March and it remains to be seen if the club make any late additions on the final day of the transfer window on Monday.
