

'I'm tough on public funds'

VICE President-elect Dr Philip Isdor Mpango has declared that he will be tough on issues touching the public interest.

He told his fellow legislators before a confirmation vote was held in the National Assembly in Dodoma city yesterday that his attitude would largely depend on the situation.

"I know you perceive me as a pleasant individual. The truth is that I am not always relaxed," said Dr Mpango, until then Finance and Planning minister and Member of Parliament for Buhigwe in Kigoma Region.

"When wrong things happen, I don't tolerate them. When embezzlement of public funds takes place, I don't keep my cool and to the corrupt officials I'm not polite."

Dr Mpango, who is lined up to take the oath of office in the national capital (Dodoma) today, said he will be frank whenever advising President Samia Suluhu Hassan on issues of national interest.

The economist-turned-politician said he was touched by the fact that millions of Tanzanians are still in abject poverty yet some government officials, who are supposed to uplift the people's standard of living, swindle public funds instead.

"Over 14 million people live below the poverty line. This is unacceptable. I'll deal with those embezzling public funds," he declared, adding: "But I pray that I will not hate or victimise people."

Dr Mpango called upon parliamentarians to accord him cooperation but also be firm on substantive issues.

"People want good health services, they want safe and clean water, and they want security so that they can peacefully engage in economic activities," he said.



THE Minister of State in the President's Office (Investments), Prof Kitila Mkumbo, has warned government officials who issue statements that are unfriendly to investors and businessmen seeking to make investments in the country.

Prof Mkumbo gave the remarks here early this week when opening a task meeting for desk officers charged with implementation of the programme to strengthen the business and investment environment.

There are reports that some officials use foul, threatening language to investors and other business people in their areas when they approach them with investment projects



He said that with the government changing its tone to usher in many more investors, top officials should change their mindset in the entire issue of investment.

"There are reports that some officials use foul, threatening language to investors and other business people in their areas when they approach them with investment projects," the minister charged.

As a country Tanzania must be ready for competition through observing investment basics since it is the only way to attain rapid economic growth, he stated

He said that the 1997 Investment Act that is set for amendments to have in place an efficient investment environment facilitating job creation for Tanzanians.

At present the government was focused on having in place a good working environment for domestic and foreign investment, hence various authorities were supposed to ensure they discharge their responsibilities in such a way as to attract more investors.

Yamungu Jacob, an economist with the Development and Investment Department, said bringing together departmental officials was meant to discuss the investment programme in improving the business and investment climate, an aspect of key policy agenda in place since 2010. Another quest is to make visual inspection of project implementation by World Bank yardsticks to compare Tanzania with 190 other countries on their footprint in world trade.

If I'm confirmed (as VP), these are the issues I'm will help the president in sorting out so that our country can move forward."

After his name was presented to the House as the president's nominee for VP, Dr Mpango was confirmed by a total of 363 votes - 100 per cent of votes cast, and his swearing-in is set for this afternoon at the Chamwino State House.

The VP-elect, who was born on July 14, 1957, served as Minister for Finance and Planning since December 2015. He was first nominated to parliament but vied for - and won - the Buhigwe constituency seat in last year's general election.

Dr Mpango previously held positions as Acting Commissioner General for the Tanzania Revenue Authority, head of the Planning Commission in the President's Office, deputy permanent secretary at the Treasury, Personal Assistant to the President for economic affairs and thus head of the president's economic advisory unit, and earlier as senior country

economist for the World Bank.

He also worked with the African Development Bank (AfDB) as exofficio member of the board of governors since 2015 and with the East African Development Bank (EADB) - again as an exofficio member of the governing council, since 2015. He also served as a member of Joint World Bank-International Monetary Fund Development Committee.

Dr Mpango was a member of the Multilateral Investment Guarantee Agency (MIGA) and an ex-officio member of the board of governors of the World Bank Group since 2015.

He also worked as an ex-officio member of the board of governors of the Trade and Development Bank since 2015.

Formerly the PTA Bank, this is a trade and development financial institution operating in eastern and southern Africa. It is the financial arm of the Common Market for Eastern and Southern Africa (COMESA), although membership is open to non-COMESA states and other institutional shareholders.

Mbungo told a press conference in Dar es Salaam that although it is true that Kakoko's residence was searched by detectives on Monday, the amount reported on social media was highly exaggerated.

"I would like to inform the general public that the information circulating online indicating the amount of money found in Kakoko's home is incorrect. We did the inspection and found only U\$3,000 (over

Unofficial reports went viral on social media that during inspection by PCCB and the police conducted at the suspect's residence, a sizeable amount of US dollars was found but the PCCB director elaborated that the inspection retrieved only U\$3,000 (6,957,093.84/- on yesterday's exchange rate) and a separate 1.5m/-totally at variance with

The inspection was a continuation of investigations on TPA that started one year ago, with the bureau saying it was in its final stages on the task.

Receiving the audit report of the Controller and Auditor General (CAG) on Sunday, President Samia Hassan suspended the TPA director and ordered investigation related to alleged embezzlement of 3.6bn/that went missing from the TPA account.

THE government hs said it plans to improve the livestock sector in FY 2021/22 by constructing 129 cattle dips to add value to livestock products.

"In this area, we have reduced rates for renting out grazing areas to 3,500/- per hectare for herders needing them," he said.

He further said in the current financial year they plan to collect 50bn/- from the sector.

Earlier, the ministry's Permanent Secretary Prof plan would help in increasing

value to livestock products.

He added that in the next budget estimates they plan to ensure to improve the health of the livestock as well as looking for markets of livestock products.

He said already they have obtained investors from foreign countries to invest in the manufacture of fertilizer using animal hair, horns and hoofs.

MORE than 90 per cent of African business leaders support a well-designed global carbon taxation regime as a means to boost green growth and shield communities from negative impacts of climate change, said a survey launched in Nairobi Tuesday.

According to the survey dubbed "Zeronomics" that was carried out by Standard Chartered Bank from September to October 2020, there is a strong support for a carbon tax and strong regulations to spur green growth in the continent.

"Ninety per cent of senior executives believe effective global carbon tax would be an important factor in accelerating their netzero transition," said the survey.

The survey on business leaders' attitudes towards low carbon development was carried out in Ghana, Kenya, Nigeria, Zambia and South Africa.

It said that 78 pe rcent of African executives believe that financing, regulatory and governance bottlenecks had derailed action on carbon emissions hence exposing the continent to adverse impacts of climate change.

According to the Zeronomics survey, 55 per cent of African business leaders worry that their firms were not transitioning fast enough towards carbon neutrality. And 35 per cent of executives pledged support to the Paris agreement while 68 percent said that sustained investments were required to hasten green and inclusive growth in the continent.

Also, the survey said that many companies based in Africa are delaying transition to carbon free growth citing inadequate access to clean technologies and cumbersome regulations. And 32 per cent of business leaders in the continent as opposed to 34 per cent globally felt their companies will hasten progress towards

The survey said that 78 per cent of African executives compared to 59 per cent of their global counterparts stressed the need for extensive organizational change to pave way for low carbon transition.

"Our survey reveals that there is significant opportunity in Africa to pave the way for zero-net carbon emissions," said Sarmad Lone, a senior executive at Standard Chartered Bank.

He said that a consensus among governments, industry and local communities was required to accelerate low carbon development in Africa during the pandemic era.

Govt sets aside 3.15bn/-for production and distribution of oil palm seedlings

THE government has allocated 3.15bn / - in the 2021/2022 financial year for the production and distribution of oil palm seedlings to meet the demand for edible oil in the country.

Agriculture deputy minister. Hussein Bashe made the statement yesterday in the National Assembly when responding to a question by Kigoma North MP, Assa Makanika, who wanted to know the government's commitment towards investing itself in the oil palm crop, instead of leaving it to the councils to address the oil shortage in the country.

In his response, Bashe said that in the period 2019/20 to 2020/21, it has invested 5.8bn/- for the development of palm oil.

He said until January 31, this year, a total of 2,244,935 improved oil palm seedlings were produced and 1,456,111

The deputy minister noted that

the country's demand of edible oil is estimated to be 570,000 tonnes annually, while the country's production is estimated to be 205,000 tonnes, and the deficit is at an average of 365,000 tonnes. The situation has been compelling the government to spend an average of 474bn/- to import cooking oil yearly. "As it is to other crops, the government invests in research, production and access to agricultural inputs, extension services, crop pest control and market exploration," he said.

He further said in implementing the strategy, the government has been working with various stakeholders including local government authorities and the private sector.

As part of the strategy for selfsufficiency of edible oil, he said that in 2018 the government decided to

'April 30 deadline for registering micro financial services groups'

THE Bank of Tanzania (BoT) has said it has begun the registration of community groups doing micro financial services and called upon Village Community Banks (VICOBA) groups to register before April 30 this year.

A press statement issued yesterday by BoT's public relations department said the groups are required to submit their applications for registration to their respective local councils to be dealt by the concerned authorities.

"April 30 this year is the deadline for receiving applications from community groups doing micro financial services. They should channel their applications to the community development officers in wards or local councils nearest to them,' the statement said.

It added: "BoT in collaboration with the Ministry of Regional Administration and Local Government informs all VICOBA groups to submit their applications to respective local council authorities before April 30 this year."

Bot also warned groups that will continue to conduct micro finance business without registration, saying they would be violating the laws and stern action would be taken against them.

"Registration of groups doing micro finance services is in implementation of the Micro Finances Services Act of 2018 that aims to ensure the country's micro financial services sector is well managed to be robust and implement government efforts in the provision of financial services to alleviate poverty levels in the society," the Bot statement elaborated.

"BoT is ready to provide assistance as needed to any registered group, it has prepared an electronic system of registration by incorporating the Ministry of Regional Administration and Local Government," the statement added.

Babati court sentences two to thirty years for possession of marijuana

BABATI District Court has sentenced two people to 30 years in jail each for being found in possession of 200 marijuana sticks, even though one of the accused was absent from the court.

Reading the sentence on Monday in regard to the Criminal Case No 185 of 2018, district magistrate Jumaa Mwambago said the hearing of the case began November 19, 2018 against Alex Laurent (27) resident of Dudiye village and Humpley Charles (25) resident of Dareda Kati village.

Mwambago said on November 8 2018 the duo ware found in possession of 200 marijuana sticks weighing 566.9 grams.

He said the accused contravened Section 5 (ii)(1)(d) of the Drug Control and Enforcement Act (No 5 of 2015).

He said accused Alex Laurent who was present in court was to start serving his sentence immediately and ordered his accomplice, Humpley Charles to be hunted and arrested to start his sentence.

Earlier, Public Prosecutor Assistant Inspector of Police Juma Makanda requested the Court to mete out stiff penalty to the accused to act as deterrent to

AU to buy 400m Johnson & Johnson COVID-19 vaccines

THE African Union (AU) has made a deal with Johnson & Johnson to supply the continent with up to 400 million one-shot doses of its COVID-19 vaccine beginning in this year's third quarter, the producer said Monday.

The virus has killed almost 121,000 people across Africa and infected 4.18 million.

J&J unit Janssen Pharmaceutica NV has entered into a deal with the African Vaccine Acquisition Trust (AVAT) to deliver 220 million doses of its single-dose shot.

AVAT could order an additional 180 million doses through 2022.

The deal follows months of negotiations with the AU, which announced a provisional agreement in January to buy 270 million doses of vaccines from J&J, AstraZeneca and Pfizer-BioNTech.

The status of the talks with the other two companies is not known.

J&J's vaccine came to the market much later than those of AstraZeneca and Pfizer but has recently gained widespread acceptance globally, especially in Africa.

"J&J requires just a single dose, it makes it a very good programmatically to rollout," said John Nkengasong, director of the Africa Centres for Disease Control and Prevention.

He said the price of the J&J's dose is likely to be \$10.

In February, South Africa put the use of AstraZeneca's shot on hold after data showed it gave minimal protection against mildto-moderate infection caused by the country's dominant variant.

Several countries in Europe have suspended using AstraZeneca's COVID-19 vaccine as they investigate a small number of reports of rare blood clotting in people who got the shot. Global

storage and transportation needs than other vaccines, making it more challenging to deploy in warmer climates or in poorer countries.

AVAT said on Monday that many of the AU's 55 member states had shown a strong preference for J&J.

Africa is also grappling with a more-infectious variant identified in South Africa amid concerns about delays in deliveries of AstraZeneca shots via the COVID-19 Vaccines Global Access Program (COVAX) that is aimed at supplying poorer countries. The continent's first COVAX shipment of COVID-19 vaccines was received in Ghana less than five weeks ago on Feb. 24.

The continent is far behind nations, including Israel, the United States and Britain in its vaccination rollout. World Health Organization (WHO) Director-General Tedros Adhanom Ghebreyesus called the divide "grotesque" when talking about differing access to shots between rich and poor nations. Almost half of Britons have received their first dose, while in contrast, only 0.4% of South Africa's population has received one dose.

"We need to immunize at least 60% of our population in order to get rid of the virus from our continent. The J&J agreement enables us to move towards achieving this target," Nkengasong said.

Most of the supplies will be produced by Aspen Pharma in South Africa, AVAT said in a statement.

President Cyril Ramaphosa said on Monday that South Africa will get 30 million vaccines from Aspen's facility while a total of roughly 250 million will be distributed across the continent from the facility.

Aspen has contracted with J&J to manufacture 300 million doses.

A BUMPER harvest is imminent in Southern Africa following the favourable rainfall the region has received during the 2020/21 agricultural season.

According to the latest SADC Food Security Early Warning System Agromet Update released end of February, crops were in good condition in much of the Southern African Development Community (SADC) due to the consistent rainfall experienced so far.

The report notes that crops were between vegetative and maturing stages in Botswana, Eswatini, Lesotho, Malawi, South Africa, Zambia and Zimbabwe, as well as the southern, central

Republic of Tanzania.

The good rains have further positively impacted on livestock, as both grazing conditions and water availability have improved in many parts of the region.

Latest reports from the Famine Early Warning System Network indicate that Malawi expects to achieve above average crop production in the 2020/21 season owing to the consistent rainfall and the increased access to inputs by farmers.

The first round production estimates by the Ministry of Agriculture and Food Security show that Malawi is expected to produce about 4.4 million

is 42 percent above the five-year average and 21 percent above the national requirement.

These prospects may, however, be revised downward due to dry spells in some southern districts of the country.

Reports from Lesotho reveal that the country is likely to have a better harvest than the previous three years despite localised flooding caused by heavy rainfall that occurred in late January and early February.

Although Zimbabwe is yet to finalise the results of its first crop and livestock assessment, preliminary findings indicate excellent conditions countrywide,

and western parts of the United metric tonnes of maize, which with the exception of the southern parts of the country where crops have been damaged by leaching.

> Zimbabwean Information. Publicity and Broadcasting Services Minister Monica Mutsvangwa said in February that an estimated 2.5 to 2.8 million metric tonnes of maize and 360,000 metric tonnes of traditional grain is anticipated in the 2020/21 season.

President's move on bad cases sure to strengthen rule of law

RESIDENT Samia Suluhu Hassan has made initial steps to strengthen the rule of law over excitement on suspicions in tax related areas in particular, with a demand on the Tanzania Revenue Authority (TRA) and prosecuting agencies to drop cases that are clearly can't be prosecuted in court.

There are cases there people have remained in remand prison for several years, and the Director of Public Prosecutions (DPP) fails to bring a sufficient case before the High Court (as in many cases this is economic sabotage crimes), but the suspects remain in prison. There is clear political will that this situation ought to change at present.

As a matter of fact the directive by the president has been in the air over the past month, as during the last week of February, Chief Justice Prof. Ibrahim Juma sent a reminder to the DPP on the issue, more or less citing exactly those same terms.

He demanded that the prosecuting agency take the various suspects to court within the space of one month from the date of notification, or failing to do they should release the suspects, rather than continuing to keep quiet while people languish in prison for offences that simply can\'t be prosecuted. Failing to prosecute is a prior admission of not guilty, and it is what must be entered.


Since this directive has come from the highest possible quarters in the governing of the state, and it was made in public and thus the wider impact of what this portends has already been created, the DPP and other authorities will not have a fallback lever to obviate from what has been demanded.

in what some literary circles would say 'in gold letters' what the CJ had earlier observed, since the difficulty would remain as to whether such a purely juridical measure had the support of top state authorities. Now this aspect has been clarified so we can expect that the matter is speeded up.

President Samia was emphatic in her appeal to judicial and prosecuting authorities to embrace strict fairness in those issues, admitting pointedly that some of these cases had just been fabricated - without going further to say why that was the case. Many people would have grasped that cases are fabricated for purposes of extortion, but in good measure, let it be said that some of those cases are too far flung and of cardinal importance to the nation's image and expectations to be fabricated by police or prosecutors, etc. In that case we might be talking about a certain order of priorities and image, with its cortege of suspects, now proving to be false in what we were assuming took place in this or that case, even embarrassingly so.

It is not surprising either that this reflection and position taking on the part of the president is happening on the edge of the mourning period and reconstitution of government authority following the death of the first fifth phase president, Dr John Magufuli.

The stream of reminiscences and reflection devoted to the mourning and funeral proceedings has a way of rekindling faith where it was lacking, for instance this moment has created a new sense of assertiveness and candor on the constitutional process, which so many people - of different political persuasions - were fond of attacking, lately. So let it be for

Breakthrough in health management systems will do much in TB control

ORLD Tuberculosis R L D Day, observed on 24 March each year, is designed to build public awareness about the global epidemic of tuberculosis (TB) and efforts to eliminate the disease. In 2018, 10 million people fell ill with TB, and 1.5 million died from the disease, mostly in low and middleincome countries. This also makes it the leading cause of death from an infectious disease.

World TB Day is one of eleven official global public health campaigns marked by the World Health Organization (WHO), along with World Health Day, World Chagas Disease Day, World Blood Donor Day, World Antimicrobial Awareness Week, World Immunisation Week, World Malaria Day, World No Tobacco Day, World Hepatitis Day, World Patient Safety Day and World AIDS Day.

24 March commemorates the day in 1882 when Dr Robert Koch astounded the scientific community by announcing to a small group of scientists at the University of Berlin's Institute of Hygiene that he had discovered the cause of tuberculosis, the TB bacillus. According to Koch's colleague, Paul Ehrlich, at this memorable session, Koch appeared before the public with an announcement which marked a turning-point in the story of a virulent human infectious disease. In clear, simple words Koch explained the aetiology of tuberculosis with convincing force, presenting many of his microscope slides and other pieces of evidence. At the time of

Koch's announcement in Berlin, TB was raging through Europe and the Americas, causing the death of one out of every seven people. Koch's discovery opened the way toward diagnosing and curing tuberculosis.

In 1982, on the one-hundredth anniversary of Robert Koch's presentation, the International Union Against Tuberculosis and Lung Disease (IUATLD) proposed that 24 March be proclaimed an official World TB Day. This was part of a year-long centennial effort by the IUATLD and the World Health Organisation under the theme "Defeat TB: Now and Forever. World TB Day was not officially recognised as an annual occurrence by WHO's World Health Assembly and the United Nations until over a decade later.

In the fall of 1995, WHO and the Royal Netherlands Tuberculosis Foundation (KNCV) hosted the first World TB Day advocacy planning meeting in Den Haag, Netherlands; an event they would continue co-sponsor over the next few years. In 1996, WHO, KNCV, the IUATLD and other concerned organisations joined to conduct a wide range of World TB Day activities.

For World TB Day 1997, WHO held a news conference in Berlin during which WHO directorgeneral Hiroshi Nakajima declared that "DOTS is the biggest health breakthrough of this decade, according to lives we will be able to save. WHO's Global TB programme director, Dr. Arata Kochi, promised that, 'Today the situation of the global TB epidemic is about to change, because we have made a breakthrough.

HE damage inflicted on the economy in 2020 as a result of the COVID-19 pandemic turned out to be less severe than generally anticipated.

According to Stats SA, South Africa managed to produce goods and services valued at close to R5trillion during 2020 (at current prices), which was only 2 per cent less than the GDP recorded during 2019.

Unfortunately, inflation swelled the negative growth rate to 7 per cent, which is a bit of a mystery when considering the sharp decline in the consumer price index in 2020 to a level of 3.3 per cent.

Sterling second-half performance

Thanks to a remarkably swift recovery of economic activity in the third quarter (an 18 per cent quarter-on-quarter nominal growth rate) and a further solid performance in the fourth quarter (6.8 per cent growth), the economy managed to produce 3 per cent more between October and December 2020 than in the same period a year earlier (at current prices).

Closer scrutiny of the latest GDP data raises some questions over the accuracy of the value added by the mining sector. According to Stats SA, the latter amounted to R373-

complex due to the conspiracies of various factors that triggered it.

billion in 2020, almost 1 per cent decline of 30 per cent in the cost per cent lower than the 2019 figure. In sharp contrast, the value of South Africa's mineral sales in 2020 amounted to R610-billion, more than 10 per cent higher than in 2019 and a new all-time record. Furthermore, the gross operating surplus of the mining sector also increased by 3.4 per cent in 2020 (at current prices).

Mining is the only sector next to agriculture to have managed this feat in the "year of the pandemic".

From a demand-side perspective, it is clear that the lockdown regulations took a heavy toll on consumption expenditure related to alcoholic beverages, restaurants, transport and recreation.

However, consumers raised their expenditure levels on the categories for food, communication and education. From a significantly lower base induced by the pandemic, the former group of expenditure categories should recover handsomely during 2021.

As expected, fixed investment in new productive capacity (capital formation) fared poorly in 2020, mainly as a result of the unprecedented level of uncertainty surrounding the ultimate impact and duration of the pandemic.

In the absence of a third wave of new Covid-19 infections, the of capital (as measured against the prime rate) will undoubtedly incentivise a recovery of capital formation during 2021.

The stand-out feature of the GDP data for 2020, however, is the dramatic depletion of inventories in the economy, a trend that also occurred in several other countries. An increase in the value of inventories represents higher capital formation and vice versa.

The pandemic has caused the worst ever decline in South Africa's inventory levels - R165-billion in 2020. This figure is more than 10 times higher than in 2019, when inventories declined by R16-billion.

A further perspective on the significance of this decline is provided by the change to inventories during the 10 years between 2010 and 2019, when it amounted to a positive figure of almost R7-billion per annum - not very significant relative to GDP.

Indeed, if inventories had recorded zero change between 2019 and 2020 (a realistic scenario in the absence of a so-called "black swan" event), South Africa's GDP would have increased by 1.2 per cent in 2020, instead of decreasing by 2 per cent (in nominal terms).

Significant growth driver Herein lies an economic growth driver that will supplement the lowest interest rate environment in 50 years, namely the inevitability of a reversal of fortunes for inventory build-up.

When other growth drivers are added, such as the country's new infrastructure drive, public sector job creation programmes and signs of recovery in construction activity (the most labour intensive sector in the economy), it becomes clear that a 5% real growth rate in 2021 is well within reach.

President Ramaphosa and his team assisting the process of economic reforms and enhanced corporate governance in the public sector will be elated by the latest GDP data, as these efforts will be reinforced by higher economic growth and job creation.

The two factions in the ANC remain at each other's throats and, unfortunately, the one represented mainly by people accused of corruption and State Capture still has many sympathisers within the party's ranks.

Areturn to high economic growth will swell fiscal revenues and assist in expediting the government's recovery and reconstruction plan, including the extension of a basic income grant to the unemployed. This should serve to silence some of Ramaphosa's fiercest critics.

Arab region counts cost of devastating COVID-19 pandemic

ORE than eight million people moved onto the poverty line in the Arab region, a conference of Arab and Asian parliamentarians heard.

The hybrid conference, held simultaneously in Beirut, Lebanon, and via video conferencing to delegates in Asia and the Arab region, was a follow up on earlier discussions on the regions' ICPD25 Commitments.

Dr Luay Shabaneh, Regional Director, UNFPA ASRO, said research showed that women were impacted more than other groups - especially as they made up 70% of front-line workers. Women's health and reproductive rights needed to be high on the agenda because the pandemic's mortality rate was higher for women. He called on parliamentarians to take care of reproductive health and rights, ensure laws to punish perpetrators of gender-based violence were enacted, and finance for programmes was available.

"Every two hours, a woman dies while giving birth in Yemen," Shabaneh said. During a recent visit to the country, he met a divorced woman who was 14 years old and a grandmother of 27. Her husband and her mother-in-law abused the grandmother until she decided to leave.

"These case histories were not unusual in the Arab and Asian region," he said and needed addressing. Other delegates at the conference, organised by the Asian Population and Development Association (APDA) and the Forum of Arab Parliamentarians on Population and Development (FAPPD), agreed. The conference heard that in the Arab world, female circumcision impacted 55% of girls aged between 15 and 19 years old, and one in five girls marry before there are 18. The diversion of resources and attention away from ICPD25 commitments impacted child marriages and female circumcisions -

with estimates that 13 million child marriages and two million female circumcisions could have been prevented.

Teruhiko Mashiko, a member of the Parliament from Japan, member of APDA Board of Directors and Vice-Chair of the Japan Parliamentarians Federation for Population (IPFP), reminded delegates the means to fight against pandemic were being developed. It was crucial, however, to keep an eye on population issues to achieve sustainable development. More than 115 million people had been affected by COVID-19, and more than 2.5 million people died globally. However, tens of millions of unwanted children were born every year.

Minister Plenipotentiary Tarek El-Nabulsi, representative of the League of Arab States, said a report on the region had shown the dire implications of COVID-19 and the need to prioritise the ICPD and Sustainable Development 2030 plan.

"The report estimated 1.7 million jobs would be lost in the region, and the middle class would decline," El-Nabulsi said. "Eight million people could move down onto the poverty line."

Moving education onto digital platforms had not benefited the poor who did not have access to technology, and it also disadvantaged people with visual and audio disabilities.

Minister El-Nabulsi said the Arab League had arranged a meeting of high-level officials to enhance national initiatives to control COVID-19 and its impact on vulnerable people. A 15-point plan was set up to reduce its impact on women and girls, protect women, and support and protect pregnant women. The social sector segment also launched an initiative to protect women in refugee camps and women under occupation.

With the support of the UNFPA, an education campaign to confront the coronavirus under the hashtag #COVID-19TalkAboutYourStory was launched. El-Nabulsi was one of several

delegates who expressed concern over the refugees. The refugees in the region placed a heavy burden on the states because it was crucial to extend healthcare services to refugees and displaced.

Asem Araji, an MP from Lebanon, said 1.5 million displaced Syrian refugees and Palestinian people would need vaccinations. He said this should be international responsibility and not just the responsibility of Lebanon.

The impact of the pandemic on education was high on the agenda of the parliamentarians' concerns. Elyas Hankash, an MP in Lebanon, said the COVID-19 lockdowns had a social, psychological, and physical impact on the youth.

"Unemployment and the lack of prospects had impacted their psychological health," he said. This led some to drugs and others to depression. The disruption to education was a disaster, especially as many youths could not connect to the internet and could not participate in the online educational offerings-this resulted in school dropouts.

Lebanon's economy was fragile, and many young people work in the informal sector, lacking worker protection.

Forty-one percent of the country's youth had been negatively affected. Unemployment increased when many businesses closed.

He called on other countries in the region to assist - this was a burden that needed to be shared.

Hankash said that while \$50,000 had been set aside for youth development, what was needed was a proper plan, including a cheaper housing plan.

Pierre Bou Assi, an MP in Lebanon, expressed concern that the pandemic's solution - the vaccine programme was problematic as there was no equality of access between countries. He too feared with two years of education lost, "a generation of children was sacrificed".

Body Deficiency Impeding Children Growth and Development

ll the parents hope that their children are healthy and wellnourished in the process of growth. However, due to congenital or environmental factors, many children manifest deficiency symptoms, including malnutrition and delayed development.

Dry lusterless hair indicating insufficiency of Kidney essence

Black lustrous hair, one of the appearance characteristics of Chinese people, is usually associated with strong physique. But many children's hair is brittle, lusterless, dry and thin, which distresses parents a lot.

It is believed in traditional Chinese medicine (TCM) that Kidney (Note: the organs mentioned in this article are concepts all different from those in Western medicine. For example, the Kidney here is one of the *zang-fu* organs in TCM, the function and location of which differ from those of the kidney in Western medicine) governs the growth and development of hair. *Huangdi Neijing* (Huangdi's Canon of Internal Medicine) stated that "The Kidney manages closure and is the root of storage and the house of essence. The Kidney demonstrates its splendor on the hair." The quantity, color and luster of hair are closely related to the Kidney. With hair compared to the branches and leaves of a tree, the Kidney is the root. Just like the root supports the growth of branches and leaves, strong Kidney qi provides sufficient nutrients for the growth of thick lustrous hair.

Accordingly, hair, external manifestation of Kidney, reflects the condition of kidney essence. Children born with deficient Kidney essence may have dry and lusterless hair that is also thin and easy to fall. Over time, there will be night sweats, enuresis, difficulty in concentration, late fontanelle closure. and even retarded development.



Bushen Heizhima Hu (Kidney-tonifying Black Sesame Porridge)

It is believed in TCM that the storage and discharge of urine is related to the bladder which is regulated by Kidney qi. Children with deficient Kidney qi have difficulty in controlling urination which is often accompanied by low immune function, malnutrition and predisposition to cold.

The effects of TCM treatment based on pattern differentiation for enuresis are significant, such as decoction, acupoint paste, massage, acupuncture and moxibustion, and food therapy.

1. Moxibustion

Moxibustion can be used for enuresis. The following acupoints can be selected, including Baihui (DU 20), Mingmen (DU 4), Pishu (BL 20), Shenshu (BL 23), Pangguangshu (BL 28), Ciliao (BL 32), Qihai (RN 6), Guanyuan (RN 4), Zhongji (RN 3), Zusanli (ST 36), Sanyinjiao (SP 6), etc.

Method: Light the end of the moxa stick and hold it about 3 centimeters above the acupoints until the area becomes suffused with warmth. When it comes to acupoints on the head, the distance should be longer in case the hair be burnt. Moxibustion should be applied for 5-10 minutes once a day for continuous 7 days. Acupoint pressure can be used as a substitute when (Arillus Longan), Gouqizi (Fructus Lycii), For the children whose hair is children don't cooperate. Parents should Danggui (Radix Angelicae Sinensis), lusterless, brittle and thin due to Kidney pay attention to avoid cold because Huangqi (*Radix Astragali*), etc. Common moxibustion should be applied with skin directly exposed.

Blood deficiency in children may cause anemia

Anemia is also a common deficiency disease in children, with paleness of skin, mucosa and fingernails, loss of appetite, fatigue of limbs and other symptoms. Older children may have palpitations, shortness of breath and other symptoms. Anemia refers to "blood deficiency" "withered-vellow complexion" and in TCM. It is believed that the blood production is closely related the function of the Heart, Liver, Spleen, Kidney, especially the latter two. Spleen, governing transportation and transformation, is the foundation of acquired constitution and the source of blood production. Spleen deficiency may lead to blood deficiency. Kidney stores essence, governs bone and marrow, transforms and generates essence and blood. If Kidney is insufficient, essence and blood are deficient.

Therefore, children with blood deficiency need to take traditional Chinese medicine that can tonify the Spleen and Kidney as well as nourish blood. Common Chinese medicines that can strengthen the Spleen and Kidney include Shanyao (Rhizoma Dioscoreae), Lianzi (Semen Nelumbinis), Longyan Rou Chinese medicines that can nourish blood include Danggui (Radix Angelicae Sinensis), E-jiao (Colla Corii Asini), Baishao (Radix Paeoniae Alba), Dazao (Fructus Jujubae), etc. Parents can add the above ingredients accordingly when cooking porridge or soup.



Moxibustion

Walnut

Replenish the stomach: Massage along in water for over 1 hour, then boil them the stomach meridian 50-100 times with the thumb's whorl side.

> Massage along Neibagua: Massage along Neibagua with the tip of your thumb about 100 times.

> Abdominal massage: For children with constipation and food accumulation, rub the abdomen clockwise with the palm for 5-10 minutes; for children with diarrhea, operate counterclockwise for 5-10 minutes.

> Press Pishu (BL 20) and Weishu (BL 21): Press the two acupoints with thumb tip for 50 times respectively.

> Press Zusanli (ST 36): Press ST 36 in both legs 30 times respectively with the thumb's whorl side.

2. Commonly used acupoints and their position

The spleen meridian: located in the tip of the thumb threaded surface.

The stomach meridian: located at the proximal end of the palm of the thumb.

Neibagua: a circle located in the palm, taking the palm center as the circle center and approximately 2/3 of the segment between circle center and the middle finger root as the radius.

Pishu acupoint (BL 20): 1.5 cun lateral digestion and absorption of food, and to the lower border of the spinous insufficient nutrition for growth, resulting process of the eleventh thoracic vertebra (T11).

Directions: Soak the above ingredients until they are soft and tender.

2. Buxue Dazao Tang (Bloodnourishing Jujube Soup)

Ingredients: 5g of Danggui (Radix Angelicae Sinensis), 6-7 Dazao (Fructus Jujubae) or Heizao (Black Fructus Jujubae), and 3g of Jineijin (Endothelium Corneum Gigeriae Galli)

Directions: Boil the above ingredients with water. Drink the soup and eat the jujube.

Note: The above methods should be used under the guidance of professional TCM doctors.

Common symptom of Spleen deficiency: dyspepsia

Children need to take in more nutrition due to the rapid growth of the body. Thus, they are especially dependent on "foundation of acquired constitution", that is, the Spleen and Stomach. But according to the theory of traditional Chinese medicine, children are born with delicate *zang-fu* organs, among which the Spleen is often deficient. As a result, children with undeveloped Spleen and Stomach functions often have digestive problems. In addition, deficiency of the Spleen and Stomach will lead to poor in a series of symptoms of malnutrition.

essence deficiency, emphasis should be placed on tonifying the Kidney in TCM. The following recipe is recommended.

Bushen Heizhima Hu (Kidney-tonifying Black Sesame Porridge)

Ingredients: equal amount of black sesame, Fructus Lycii, Fructus Ligustri Lucidi, soybean and peanut, etc.

Directions: wash and stir fry the above food, grind and mix them. Brew the powder with brown sugar water into paste and take it every day.

Frequent enuresis also indicates **Kidney qi deficiency**

Enuresis (bed wetting) happens in children over 5 years old with uncontrollable urination during sleep at least twice a week for more than 3 months. Parents should pay attention to it as longterm enuresis is harmful to the children.

2. Hetao Zhou (Walnut Porridge)

Ingredients: 10-15 pieces of Hetao (walnut), 100g of Jingmi (Oryza Sativa L.) Directions: Crush the walnuts and boil them with the Jing rice. Take the porridge every morning and evening.

Parents should consult the doctors in time if there is frequent enuresis in children. Delayed treatment because of common misconceptions about bedwetting should be avoided. At the same time, parents need to keep using the above health care methods for long-term effects.

Note: The above methods should be used under the guidance of professional TCM doctors.

Here two recipes are recommended for invigorating the Spleen and supplementing qi, and replenishing and nourishing blood.

1. Jianpi Shanyao Zhou (Spleeninvigorating Shanyao Porridge)

Ingredients: 10g of Qianshi (Semen Euryales), 10g of Yiyiren (Semen Coix), 10g of Lianzi Rou (Semen Nelumbinis), 6g of Shanzha Rou (Fructus Crataegi), 6g Huai Shanyao (Rhizoma Dioscoreae), and appropriate amount of Jingmi (Oryza Sativa L.)

Abdominal distension, anorexia and diarrhea are the common symptoms of children with Spleen deficiency. Over time, there will be emaciation, low height and weight and other symptoms, which will seriously affect children's growth and development. Children massage can be used for the conditioning, and parents can learn some commonly used acupoints and simple techniques to alleviate child's symptom.

For indigestion caused by spleen deficiency, the principle of massage therapy for children is to strengthen the Spleen and Stomach.

<u>1. Common manipulations for child</u> massage

Tonify the spleen: Massage along the spleen meridian 100-200 times with the thumb's whorl side.

Weishu (BL 21): :1.5 cun lateral to the lower border of the spinous process of the twelfth thoracic vertebra (T12).

Zusanli (ST 36): On the anterior aspect of the lower leg, 3 cun below ST 35, one fingerbreadth from the anterior crest of the tibia.

Note: The above methods should be used under the guidance of professional TCM doctors.

Apart from using traditional Chinese medicine in daily health care, it is also important to avoid improper feeding of children. Do not allow children to eat too much, avoid the habit of being picky about food and eating between meals. Eat less raw, cold or sugary products, and ensure regular food intake.

The above are common pediatric diseases. In general, children can easily develop various deficiency patterns due to congenital deficiency or improper feeding. In case the normal growth and development of children be affected, parents should be alert and ensure timely treatment and health care.

African youth urged to tap into agriculture potential

AFRICA has the ability to produce enough food to feed its population and beyond, and develop agribusiness that would offer decent employment to youth.

This observation was made by different pan-Africanists, calling for the development of the entire agriculture value chain.

They were speaking over the weekend during Pan-African Movement (PAM) Youth Commission's Fourth Africa Expects Youth Series webinar that was held under the theme "Youth as Key Drivers to Sustainable Food Security."

They said that there is a need to make sound investment to develop agro-processing so as to add value to farm produce and effectively linking primary producers to industries.

About 250 million Africans are hungry - almost 20 percent of its 1.2 billion people - according to data from the Food and Agriculture Organization of the United Nations (UNFAO).

Meanwhile, according to information from the World Bank, Africa's agribusiness (food and beverage) market is projected to reach \$1 trillion per year by 2030 from \$313 billion in 2013.

Brian Kagoro, Founder and Executive Director of UHAI Africa Group, a Pan African Governance, Leadership and Development consulting firm said that there is a huge market within Africa that is yet to be exploited, indicating that the Africa Continental Free Trade Area (AfCFTA) should be a mechanism to enable and ease the intra-Africa trade bottlenecks.

Kagoro said that the difficulties in trading in Africa are because of the colonial model, arguing that Africa was activated and motivated never to look to itself for selfreliance and relevance.

"AfCFTA must really push us towards a mindset where we build regional value chains; build research and development; invest in locally, nationally and regionally relevant technology for agricultural transformation-affordable, user friendly and accessible and durable)," he said.

"We need to improve market intelligence information and standards; in some countries, the danger is posed by middlemen that exploit primary producers; infrastructure, transportation, storage and logistics are as key as access to risk capital/finance and mentorship and support," he said

Kagoro said that African businesspeople have been thinking that they cannot be successful without selling to Europe.

However, he pointed out that there are Africans such as Nigerian businessman Aliko Dangote who became billionaires thanks to selling to Africa.

"This, he said, is a wake-up call in our thinking about

the value of Africa in the agricultural value chain and also our consumption," he said, encouraging intra-African trade and youth participation in developing agricultural value chain.

Referring to the Covid-19 pandemic that disrupted global supply chains, he said that Africa should strengthen local food production and trade.

"If we have a third and a fourth wave, and Europe and China shut down (a year or year and half of shutdown), and we were not able to do any export, will you as a business survive? But most importantly, will you not be starving?" he challenged Africans.

Regis Umugiraneza, founder of Carl Group - a company engaged in nutritious sweet potato processing for products such as bread - said that Africa's food industry can compete on the global stage if the continent joins force.

He said that Rwanda committed to making the youth the driver of agriculture development and food security by establishing and supporting a Rwanda Youth in Agribusiness Forum (RYAF) in 2016, which currently has more than 12,000 members.

Now, he said, the Government is establishing the manufacturing facility to help the industry recover from the Covid-19 pandemic.

"The requirements to get funding from such initia-



other manufacturers compared to only \$100,000 for agro-processors. This shows how the Government of Rwanda is committed to promote and also to emphasize food security by reducing imports by increasing local production, but also increasing exports," he said.

Quoting AfDB President Akinwumi Adesina, Michael Shyaka Nyar-

tive include having \$10 million for waya, the Commissioner for Youth at Pan-African Movement Rwanda Chapter said that the future billionaires of Africa will not be coming from the oil and gas sector, but from the agriculture, adding that food is critical and that is what Africa has a comparative advantage in.

as Key Drivers to Sustainable Food Security" just because they know that "if we don't have enough food in Africa, we will be having a big problem," calling for efforts to ensure food security on the continent.

"We need an education system that ensures that we have young people who are agriculture professionals because we are heading to technology-led agriculture," he said.

THE Food and Agriculture Organisation of the United Nations (FAO) has told African nations to be on high alert for bird flu after multiple outbreaks of the virus were reported in wild birds across Europe.

The FAO's warning says that the disease has spread rapidly in Western Europe's wild bird population. 70 cases have been reported across the UK, France, Germany and the Netherlands. Commercial poultry farms have also been affected by bird flu outbreaks. Since wild birds act as a reservoir for the virus and will soon begin migrating across Africa, the risk of transmission is growing.

"FAO recommends countries in Africa to be on alert for incursion of H5 highly pathogenic avian influenza (HPAI), following increasing reports from European countries of detections in wild birds over the past week.

"Countries and farms should have in place enhanced measures for prevention, early detection and diagnosis, and for outbreak response," it said in a statement.

"Moreover, it is likely that the virus has already arrived in parts of West and North Africa but remained undetected so far," it said.

The FAO is recommending that African nations increase disease surveillance efforts in wild birds and poultry and limit contact between domestic birds and wild flocks. The organization says to pay extra attention to shared sources of drinking water to prevent contamination. Previous bird flu outbreaks in 2017 threatened the livelihoods and food security of millions in Africa.

On Monday, UK recorded two new outbreaks of avian influenza at a broiler farm and turkey breeding facility, renewing calls for poultry keepers to remain vigilant and keep their birds housed.

The UK's Animal and Plant Health Agency (APHA) has confirmed an outbreak of H5N8 bid flu on a commercial broiler farm near Uttoxeter, East Staffordshire. The agency has also identified an outbreak of H5N3 avian influenza in turkey breeders at a commercial premises near Winsford, Cheshire West and Chester. That outbreak has been confirmed as low pathogenic.

EN-YEAR-OLD Leonardo had not seen his mother in years. His hope, as he set out from Guatemala with his aunt and her young daughter, was that they would all be able to reunite with his mother, Emiliana, in California together.

Instead on Feb. 23, he descended an escalator in the Los Angeles airport for the long-awaited reunion alone. After Emiliana finally embraced her son with tears streaming down her face, Leonardo's first question was: "Why aren't Aunt Rosa and my cousin here?"



While it is too early to say if the proposal will become law, Biden has hired members of the advocacy community as top immigration advisers, and his administration consults with them frequently.

Salvador Zamora, a former CBP official who retired in December, questioned how such a center would work in practice. Verifying the nationality and identity of a person arriving at the border is time consuming, he said.

The process involves backlogged consulates of the migrants' country of origin, who often need to send officials to the municipality the person claims to be from. "How do we verify identity, nationality, let alone familial status within a reasonable amount of time?" he said.

Echoing those concerns, Chad Wolf, who was acting homeland security secretary under President Donald Trump, said changing the policy could encourage smugglers to falsify family relationships.

"I am afraid that the current administration is going to start looking at solutions to speed up processing," he said, "and then with some of those decisions, they could choose expediency over safety."

NOWHERE TO GO

When U.S. authorities separated Leonardo and sent him to a shelter in New York, they expelled his aunt Rosalina - eight months pregnant at the time - and his cousin Marisol to Mexico. The policy used to expel them, a Trump-era public health rule known as Title 42, was implemented in March 2020. Biden has left the rule largely intact, although he has exempted unaccompanied minors. When Rosalina was expelled, she fainted on a street near the international bridge in Ciudad Juarez, Mexico. "I had no idea where I was. I had no idea where to go," Rosalina said in an interview from a Mexican shelter where she is staying after recently giving birth to her baby. She said she fled Guatemala with Leonardo and Marisol after a brutal assault and fears going back. The family asked to be identified by their first names for their safety and so as not to impact their asylum claims While Leonardo had his mother waiting for him, some children separated from their relatives at the U.S.-Mexico border do not. Yliana Johansen-Méndez, legal services director at the Immigrant Defenders' Law Center in Los Angeles. said around 16 percent of the 327 unaccompanied children interviewed by her organization between December and March 24 had traveled with family members who were expelled under Title 42. Some had no other potential sponsors in the U.S., she said. Relatives traveling with children have often raised them for years and are "psychological parents," said Amy Cohen, a child psychiatrist and executive director of nonprofit Every.Last.One, which helps get children released from immigration custody. The separation from these adults is "just as wrenching, just as damaging" for children as separation from their mother or father, she said. Some migrant children may feel closer to the relatives they have traveled with than the family they are joining in the United States, even if they are their parents. When Emiliana fled Guatemala in 2017 to get away from her abusive husband she was only able to cobble enough money together to take one child. She made the painful decision to take her then 2-year old daughter and leave then 7-year old Leonardo behind with his grandmother. After his grandmother died in 2019, Rosalina took care of him. Back now with his mother in Los Angeles, Leonardo doesn't want to leave her side. At times he's jealous of his younger sister, now 5, while his sister also struggles with the new competition for her mother's affections after getting used to being an only child for the past three years. "It's quite difficult," said Emiliana. "If I hug one then the other one gets upset." Leonardo asks about his aunt and cousin constantly, Emiliana said, telling her he is asking God that they be allowed into the United States.

AU, Johnson & Johnson sign deal for 400 million doses of Covid-19 vaccines

ADDIS ABABA

THE American drug maker, Johnson & Johnson, will supply the African Union (AU) with 400 million doses of its single-shot Covid-19 vaccine beginning in the third quarter, the multinational corporation said on Monday, March 29.

In a procurement agreement signed earlier on March 28, a related statement indicates, all African Union member states, through the African Vaccine Acquisition Trust

tion (Africa CDC), and the Africa Medical Supplies Platform (AMSP) notes that there is also the potential to order an additional 180 million doses.

The AMSP is a non-profit initiative launched by the AU as an immediate, integrated and practical response to the Covid-19 pandemic. The online platform was developed under the leadership of the African Union special envoy, Strive Masiyiwa.

Dr John Nkengasong, Director of Africa CDC, said: "The

quickly and effectively, thus saving lives." Cyril Ramaphosa, President

of South Africa, AU Champion for the Covid-19 vaccine strategy and acquisition, and Chairman of AVATT, welcomed the historic agreement, which he initiated directly with the company, during his tenure as AU Chairperson.

It is also a powerful demonstration of African unity and of what we can achieve through partnership between the state sector, the private sector and international institutions that put people first," Ramaphosa said. NAIROBI

KENYA'S Health ministry has now opened talks with the Treasury on a proposal to offer tax reliefs to medical gas manufacturers amid a biting oxygen supply shortage in hospitals due to a spike in Covid-19 infections.

Health secretary Mutahi Kagwe said the oxygen demand was almost outstripping supply after hospitalisation for Covid-related complications surged by more than half in two weeks, forcing authorities to restrict movement

into and out of Nairobi metropolitan area and Nakuru County.

Demand for oxygen for Covidrelated emergency medical care has more than doubled to about 880 tonnes from 410 tonnes last year and 560 tonnes in January, reflecting elevated third-wave infections, which have averaged 20 per cent of testing in recent weeks.

"Because of the emergency nature of the requirement of oxygen, we are going to work with the Treasury to see whether we can increase the oxygen cylinder sup-

ply via reduction of some of the taxes. But this is a discussion that we need to get together with the industry," Mr Kagwe said.

"The situation at the moment is that the (gas manufacturing) industry is completely stretched. If we go any further than that, immediate steps will have to be taken." An ample supply of oxygen is needed for the management of Covid-19 patients, who experience breathing dif-

ficulty.

The surging third wave of Covid-19 in Kenya has seen hospital admissions increase 52 per cent in two weeks by Friday. Currently, 121 patients lay in the intensive care units (ICUs) with 32 on ventilatory support and 82 on supplemental oxygen.

The positive test rate hit 22 per cent last week compared with January's two per cent. This month, an average of seven Kenyans have died each day from Covid-19. up from three a day in January and February. Reduced taxation, which will need Cabinet and parliamentary approval, is part of the strategy the ministry is mulling in a bid to ramp up investments in the medical gas industry.

Some of the country's about 75 oxygen plants have stalled due to challenges related to the supply of spare parts, he said, adding that the ministry would engage the 47 counties and the industry to develop common standards for oxygen plants in future. This came amid pleas by leading gas manufacturers, BOC Gases and Gas Africa, to hospitals and homes holding onto idle oxygen cylinders to immediately surrender them.

"It's a crisis and we need all the help we can get from the patients and from hospitals that are holding the (oxygen gas) tanks. If you are holding cylinders at home or in the hospitals for non-Covid or nonemergency care, please return them to us," said BOC managing director Marion Mwangi.

PFIZER Inc. is demanding that South Africa's health and finance ministers personally sign a Covid-19 vaccine-supply agreement so that it is indemnified from any claims made against it in the country regarding the shot.

The demand is contained in a March 24 letter from South Africa's Health Minister Zweli Mkhize to his finance counterpart Tito Mboweni, seen by Bloomberg and confirmed by the National Treasury. Pfizer was not satisfied by assurances that the signature of the country's health director general was sufficient to guarantee the indemnity, Mkhize

said. The demand threatens to further delay the roll out of South Africa's vaccine program, which is lagging behind that of emerging market peers and a number of African countries, and heightens pressure on the government. The agreement is for the supply of 20 million doses of the vaccine made by Pfizer and BioNTech SE.

The ministerial signatures will give Pfizer the "assurance that the terms of the indemnity clause are acknowledged by govern-

ment and, as such, any liability that may be established will be covered by the fiscus," Mkhize wrote. "You will no doubt agree with me that there is mounting pressure and we can no longer justify publicly any further delays." Mkhize's spokeswoman declined to comment. The National Treasury said in a response to a query that discussions about the signing of agreements were ongoing and confirmed receipt of the letter.

"We are in discussions with the Government in South Africa to provide access to the vaccine," Pfizer said in a response to queries. "These discussions are confidential and we have nothing to announce at the current time." The demand was the last Pfizer would make and, once signed, vaccines would begin to arrive within two weeks, Mkhize said.

With over 1.5 million recorded infections and almost 53 000 deaths, South Africa is the worst-affected country by the coronavirus on the continent. So far only 231 605 people have been vaccinated as part of a study using Johnson & Johnson's vaccine while a wider

vaccination program is yet to begin. The government has said an initial target to vaccinate 40 million people this year will be missed.

On March 26, News24, a South African news website, said larger deliveries of Johnson & Johnson's shots would be delayed because the government had not set up a no-fault compensation fund, citing people it didn't identify. Anban Pillay, a deputy director general in the health department, told Bloomberg there were no delays without giving further information.

New policy to regulate betting industry in the offing



RWANDA'S Trade and Industry ministry has said that it is working on a policy that could regulate betting activities in Rwanda, including online betting. The development follows the growing prevalence of online betting and betting in general in the country, which needs proper regulation and inspection to ensure its safety according to officials.

Samuel Kamugisha, the Director General of Industry and Entrepreneurship Development at the Ministry of Trade and Industry told The New Times that the policy could be available by the end of this year.

While this newspaper has learnt that many betting companies have applied for license to also start online betting, Kamugisha said that there is only one online betting company that was given two-year exclusive license. This license, he said, is due to expire in July this year.

"Once the exclusive license expires, we will sit, do evaluation and

Buffett-supported BYD firm's profits surge by 162 pc on electric-car boom

BYD Co, the Chinese electric-vehicle maker in which Warren Buffett's Berkshire Hathaway holds a stake, said profit more than doubled last year thanks to a recovery in demand in the world's biggest car market.

Shenzhen-based BYD's net income surged 162% to 4.2 billion yuan (\$644 million) in 2020, with operating revenue climbing to 153.5 billion yuan, according to its annual report. The company also estimated first-quarter profit will rise as much as 166%

Total EV sales in China reached 1.37 million units last year, according to China Association of Automobile Manufacturers.

With demand rising, the EV market has become increasingly competitive. Global leader Tesla Inc. is vying with local manufacturers including BYD, Nio and Xpeng, while older local companies including Zhejiang Geely Holding Group Co and SAIC Motor Corp are moving into the space, too. BYD introduced its Han model in July and sold 40,556 units by the end of the year. It also launched its Song Plus, Tang, e2 and e3 models in the second half of 2020.

BYD expects net income of 200 million yuan to 300 million yuan in the first quarter, up from 112.6 million yuan in the year-earlier period. The company cited China's economic recovery as well as strong sales of the Han model.

Covid-19 provided BYD an opportunity to branch out into a new, high-demand area last year: face masks.

The company said last March that it had become the world's biggest manufacturer of the protective gear within two months of the virus emerging in Wuhan. Its other businesses include batteries, handset components, energy storage and urban rail transit systems.

BYD's Hong Kong-listed shares more than quadrupled in value last year, though they've since fallen almost 40% from a January 25 high. In Shanghai, the company's stock climbed 308% in 2020 before slipping 13% so far this year.


INCENTIVE Elumelu to fund innovative ideas in rural Kenya

NAIROBI

UNITED Bank for Africa (UBA) and the Tony Elumelu Foundation are targeting to fund innovative business ideas from rural areas in Kenya as part of its Covid-19 recovery plan this year.

The firm is seeking applications from Kenyans who have "brilliant, scalable ideas." The applications, which opened in January and closes end of this month, comes at a time that most small and medium enterprises (SMEs) are reeling from the economic fallout of Covid-19.

"In 2021, the Foundation, will identify, train, mentor and fund over 3,500 entrepreneurs across Africa. The Programme remains open to all entrepreneurs across Kenya, both new start-ups and existing businesses operating in any sector," acting UBA Kenya chief executive Kehinde Omirinde said in an interview. UBA, Mr Omirinde said, has done aggressive registration drive to reach more ideas in rural areas which are less developed. In 2019, TEF said that about 70 percent of applications come from urban areas while the remaining come from rural ar-

eas. Run by Nigerian philanthropist Tony Elumelu, the Foundation said that it wants to execute the largest Covid-19 economic recovery plan for African SMEs and break the cycle of poverty in Africa. With just a few days to the close of applications, UBA Kenya is calling on young Kenyans to take advantage of the business financing and mentoring to grow their ideas.

"We encourage all young Kenyans with brilliant business ideas or start-ups to apply on tefconnect. com. This year we aim to reach ideas from rural areas through our ongoing aggressive registration drive campaign," Mr Omirinde said. The foundation will give 3,000 awards instead of the usual 1,000 to aid the continent in its Covid-19 recovery.

Selected entrepreneurs get a 12week online training on managing enterprises, mentorship on transforming business at its early stages, a seed capital of Sh500,000 (\$5,000) and networking opportunities.

This is the seventh edition of the TEF's 10-year \$100 million commitment to identify, train, mentor and fund 10,000 African entrepreneurs by 2024.

Global arms trade flat in 2016-2020 after more than one decade of growth

STOCKHOLM

THE volume of international deliveries of major arms was flat over the past five years, ending more than a decade of growth, according to new data.

The volume of international transfers of major arms in 2016-20 was 0.5 per cent lower than in 2011-15, the Stockholm International Peace Research Institute (Sipri) said in a new report. This is the first time since 2001-2005 that the volume of arms transfers between nations did not increase on the previous five-year period, the data showed.

Middle East nations accounted for the biggest rise in arms deliveries. Arms imports by states in the Middle East were 25 per cent higher in 2016-20 than in 2011-15. Four of the top 10 arms-importing countries in 2016-20 are in the Middle East: Saudi Arabia, Egypt, Qatar and the UAE. The US accounted for 52 per cent of arms exports to states in the region, while Russia supplied 13 per cent and France 12 per cent, the report showed.

Globally, the "five largest arms importers were Saudi Arabia, India, Egypt, Australia and China", Sipri said in its Trends in International Arms Transfers report. These nations collectively received 36 per cent of total arms imports in 2016-2020.

Saudi Arabia, the world's largest arms importer in 2016-2020, received 11 per cent of global arms imports, Sipri said. The US provided 79 per cent of the kingdom's arms imports during the period, followed by the UK with 9.3 per cent and France with 4 per cent.

The kingdom increased its arms imports during the five-year period by 61 per cent, the data showed. The UAE has been among the world's top 10 arms importers since 2001-2005 but its imports in the 2016-20 period were 37 per cent lower than in 2011-15, the report said.

"Outstanding deliveries at the end of 2020 - including for 2 frigates from France as well as air defence systems and 38 combat helicopters from the USA - indicate that the UAE's arms imports will continue to be at a high level in the coming years," the report said. The UAE recently signed an agreement with the US to buy 50 F-35 jets and up to 18 armed drones as part of a \$23 billion deal.


BlackRock and Vanguard join net-zero emissions initiative of global investors

PARIS

THE world's largest asset managers have joined a group of investors committing to cut the net greenhouse-gas emissions of their portfolios to zero.

BlackRock and Vanguard Group are among 43 investment firms managing more than \$22.8 trillion of assets that are joining the Net Zero Asset Managers initiative, according to a statement on Monday. By signing up, the money managers are pledging to support efforts to limit global warming to 1.5 degrees Celsius by targeting netzero emissions by 2050 across all their holdings. They also will set a public goal for the proportion of their as-

"If deliveries of these aircraft are implemented as planned, the UAE's arms imports will increase in the second half of the 2020s," the authors said. The world's five largest arms exporters in 2016-20 were the US, Russia, France, Germany and China, accounting for 76 per cent of all arms exports, Sipri said. The US, France and Germany increased their arms exports during the period, while Russia and China saw their exports drop.

At the regional level, Asia and Oceania accounted for 42 per cent of arms imports in 2016-20, followed by the Middle East with 33 per cent, Europe with12 per cent, Africa at 7.3 per cent and the Americas at 5.4 per cent, the report showed. Sipri presents arms transfer data for five-year periods to give a more stable measure of trends given the significant year-on-year fluctuations in international transfers, the research agency said.

The value of global arms transfers last year was exceptionally low - 16 per cent lower than in 2019 and 20 per cent below the annual average for the previous nine years, it said. This may partly be due to the Covid-19 pandemic - which disrupted some arms companies' planned production and delivery schedules - and the related economic crisis, Sipri said.

The drop in arms transfers in 2020 was also due to other factors including national procurement cycles, gaps in deliveries during shifting relations between suppliers and buyers, and economic conditions unrelated to the pandemic, it added.

Sipri said the uncertainty about whether the pandemic was a major cause for the fall in arms transfers in 2020 is underscored by the fact that several states actually had higher levels of arms deliveries in 2020 than in prior years.

sets that in 2030 will be on course for net zero.

Eliminating emissions is becoming a greater focus for investors as activists, clients and regulators push them to move from talk to action and use their influence and resources to hold companies to account. And there is a growing urgency to act since scientists have said emissions need to drop by about 50 per cent by 2030 and reach net zero by the middle of the century to avoid the most catastrophic impacts of climate change.

"Climate change represents a long-term, material risk to our investors' portfolios," Vanguard chairman and chief executive Tim Buckley said in the statement. "As a steward of our clients' assets, we recognise the crucial role we and others play in driving real progress on climate risk over time."

Asset managers' 2030 targets should be commensurate with the 50 per cent global reduction in CO2 that scientists have specified as necessary to limit warming to 1.5 degrees. They should also report annually on their progress towards the recommendations of the Task Force for Climate-related Financial Disclosures. That includes setting an action plan that will be monitored by investor climate groups.

Money managers can contribute to a cooler planet by pressing the companies they own to do more to cut emissions and redesigning their portfolios to support green businesses. While the asset-management industry is under pressure to contribute to the low-carbon transition, BlackRock and Vanguard have faced particular criticisms from climate campaigners who say their large holdings of fossil-fuel companies make them complicit in warming the world, while their track record on proxy voting hasn't signalled a sufficient desire to act on climate change.

"Helping investors prepare their portfolios and capture investment opportunities on the path to net zero is one of our greatest responsibilities," BlackRock chairman and chief executive Larry Fink said in the statement. The Net Zero Asset Managers initiative was started last year with Legal & General Investment Management and UBS Asset Management among its founding members. With the additions, the group now represents \$32 trillion of assets, accounting for more than a third of the total global funds under management, according to the statement.

Other new signatories include Aberdeen Standard Investments, Allianz Global Investors, Brookfield Asset Management, Jupiter Asset Management, Lazard Asset Management and Storebrand Asset Management. "The transition to net-zero carbon emissions is imperative, and we have a responsibility to work together as an industry and a society to tackle climate change," said Andrew Formica, chief executive of Jupiter Asset Management.

BCI's cotton boycott against China is hasty and doomed to fail

GENEVA

SHORTLY after the Swiss-based Better Cotton Initiative (BCI) launched its so-called Xinjiang cotton boycott, the group's Shanghai representative office confirmed last weekend it has never found a single case related to "forced labor" in China's Xinjiang Uygur Autonomous Region.

Though the BCI claims to be "not-for-profit" and "the largest cotton sustainability programme," a close look at its behavior would find that it is anything but professional, independent and transparent.

Firstly, the BCI has proven itself a part of the western smear campaign against China. When some institutions in the United States and Australia fabricated inaccurate reports on Xinjiang last year, the BCI, without any field investigation, immediately suspended its assurance activities in Xinjiang and wrongfully cited concerns about so-called increasing risks of forced labor in Xinjiang.

In fact, the baseless accusation intentionally ignores the fact that cotton production in Xinjiang has already achieved a high degree of mechanization.

After its team in China refuted findings of any incident related to forced labor in Xinjiang, one would expect that since its own branch had a first-hand on-site investigation, the BCI headquarters should have responded promptly by correcting its previous wrongdoings. Instead, the BCI headquarters chose to remain silent and indifferent.

Secondly, though the BCI bills itself as a non-profit, independent organization, one of its major funding partners is the U.S. Agency for International Development (USAID), which bluntly admits that its work "advances U.S. national security and economic prosperity."

For decades, the USAID has repeatedly been accused of interfering in the internal affairs of other countries. Its nature as a tool to maintain American hegemony overseas is self-evident. With such a financial backer, it is hard not to question BCI's independence.

What is more, Marc Lewkowitz, the current chairperson of the BCI Council, is also the president and CEO of Supima, the promotional and marketing organization for American Pima cotton growers. Since Pima cotton and Xinjiang cotton are competitors, one cannot help raise concerns of any conflict of interest.

Lastly, the BCI has serious problems with transparency. Xinhua correspondents were recently refused an interview at BCI's headquarters in Geneva. To the reporters' surprise, its headquarters has just a few rented offices on the first floor of an office building and a few researchers.

In the past year, the BCI repeatedly issued false statements on the issue related to cotton production in Xinjiang without presenting any reliable evidence except botchedup reports by anti-China organizations in the West. It appears the BCI in this regard doesn't have a mind of its own.

The BCI may profess to preach decent labor and high environmental standards, but its own operations are not decent and of low standards. By selling a contemptible lie to the world, the BCI is risking its own credibility. Xinhua

UN chief calls for bold measures to tackle debt crisis

UNITED NATIONS

UN Secretary-General Antonio Guterres on Monday called for urgent, bold measures to address an emerging debt crisis caused largely by COVID-19.

"We are on the verge of a debt crisis. Today's meeting, convened with our partners, the prime ministers of Canada and Jamaica, is a call for urgent action," he told a high-level event on debt and liquidity.

Six countries have already defaulted. One-third of emerging market economies are at high risk of fiscal crisis. And the situation is even worse for leastdeveloped and low-income countries. They face a painfully slow recovery that will put the 2030 Agenda for Sustainable

Development and the Paris Agreement completely out of reach, he warned.

Developing countries need access to additional liquidity to respond to the pandemic and to invest in recovery. The international community must urgently provide the necessary support to all developing countries in need, said Guterres (pictured).

From the start of the pandemic, the United Nations has advocated for a three-phase approach to debt: a moratorium on debt payments, targeted debt relief, reforms to the international debt architecture, he noted.

He welcomed the steps that have been taken, including fresh financing by international



Service Suspension Initiative of the Group of 20, and the Common Framework for Debt Treatments, but said they are far from enough.

"I am, therefore, calling for much bolder and more ambitious measures.

"We strongly believe that the Debt Service Suspension Initiative must be extended into 2022, and made also available to highly indebted, vulnerable middle-income countries that request it.

"The Common Framework for Debt Treatments is facing difficulties. Countries are reluctant to use it because they are concerned that it will have a negative impact on their credit rating. We need joint efforts to address this.

"Additional, targeted debt relief to vulnerable countries, including middle-income ones, will ultimately be needed. A new debt mechanism could provide a menu of options including debt swaps, buy-backs and cancellations," he said.

This is also the moment to tackle long-standing weaknesses in the international debt architecture, from lack of agreed principles, to restructurings that provide too little relief, too late, he added.

"Ultimately, we need a shift in mindsets towards responsible borrowing and lending, accepted by debtor and creditor countries, investors, market participants, credit rating agencies and international organizations. We need a time-bound, open dialogue to build trust and transparency in a systemic, inclusive way. Together, with collective resolve, we can help all countries invest in response, recovery, and a more sustainable and resilient future," said Xinhua Guterres.

China's main economic indicators show substantial increase in first two months of 2021

FROM January to February, China's major economic indicators witnessed substantial growth year on year, according to the latest data released by China's National Bureau of Statistics (NBS) on March 15.

China's national economy has sustained steady recovery on the whole, and the country has the conditions to maintain the overall stability of employment, as shown by the data.

To objectively and accurately take the pulse of country's economic development, the NBS compared the economic data in the first two months of 2021 with those in the same period of 2020 and 2019, respectively.

Meanwhile, the government department introduced a new indicator, the average two-year growth rate, which is

based on the data in the same period of 2019 and calculated by taking the average of growth rates in 2020 and 2021 in a geometric mean.

The high year-on-year growth rates of major indicators from January to February are partly due to a low base of the same period in 2020, said Liu Aihua, spokesperson of the NBS, who explained that China's major economic indicators saw sharp year-on-year decrease at the beginning of last year due to the COVID-19 outbreak.

"That's why we have decided to calculate the average growth rates of economic indicators in the past two vears to cushion the effect of low base numbers last year," Liu pointed out. In the first two months this year, the total value added of China's industrial enterprises above designated size grew by 35.1 percent year on year.

After deducting the base effect, the total value added of industrial enterprises above designated size saw an average growth of 8.1 percent in the past two years.

The country's Index of Services Production saw a year-on-year increase of 31.1 percent, with an average two-year growth of 6.8 percent.

The average two-year growth of investment in fixed assets and the total retail sales of consumer goods stood at 1.7 percent and 3.2 percent respectively, Liu noted, adding that such data signal the overall recovery of Chinese economy.

According to China's Report on the Work of the Government 2021, the country intends to create over 11 million new urban jobs this year.

The continuous and steady recovery of the Chinese economy is believed to stimulate the demand for labor and help stabilize employment. Besides, the Chinese government's policies on stabilizing employment and the development of the service sector will ease the pressure on the job market.

As anti-epidemic measures continue to reap fruits in China this year, the service sector will gain momentum and better play its role as a reservoir for employment, Liu pointed out. It will take some time for invest-

in urban areas totaled 1.48 million in ment in the manufacturing industry to recover, but China's economy has the foundation and conditions to maintain recovery.

In the first two months, the investment in fixed assets (excluding rural households) rose by 35 percent year on year.

The investment in high-tech industry grew by 50.1 percent year on year, with the average two-year growth reaching 11 percent.

The investment in social sectors grew by 48 percent year on year, with an average growth of 8.8 percent in the past two years.

In the past several years, final consumption has contributed increasingly to economic growth, according to Wang Wei, director of the Institute

for Market Economy under the Development Research Center of the State Council of China.

Wang believes it important to expand, unleash and upgrade final consumption demands, push investment and industrial restructuring through consumption upgrading and expansion, and build a more complete domestic demand system, thereby forming a new impetus to support high-quality development.

Guo Liyan, a researcher with the Academy of Macroeconomic Research, noted that the supply side and the demand side are not independent of each other under China's new development pattern.

COVID-19 vaccine hesitancy among Black Americans drops: poll

THE percentage of U.S. Black adults who say they have either received a vaccine shot for COVID-19 or want one as soon as possible rose to 55% in March from 41% in February, a survey by the Kaiser Family Foundation (KFF) showed.

Overall, 61% American adults reported being vaccinated or intended to receive the shot, up from 55% in February, the March report said, adding that the biggest driver in the change was interest from Black adults.

Distrust in COVID-19 vaccines has weighed on U.S. rollout efforts, especially in some communities of color. Black and Hispanic communities have been lagging behind white people in receiving vaccines, a report by KFF showed early this month.

Fewer than half of Republicans said they have either received at least one dose of the vaccine or intend to get it compared to about eight in 10 Democrats, the report said.

This is in line with some recent polls which showed that Republicans have been reluctant to get vaccinated.

Democrats, college graduates and adults aged 65 and over are among the groups most likely to say they have received the vaccine or intend to do so, the survey showed, with young adults and Blacks among groups likely to wait and see.

KFF's survey was conducted from March 15 to 22 among 1,862 adults aged 18 and older. *Agencie s*

Islamic State claims deadly attack on northern Mozambique town

JOHANNESBURG

ISLAMIC State said on Monday its fighters had carried out an attack on the northern Mozambique town of Palma, where dozens were killed, thousands displaced and some remain missing.

Islamist insurgents hit the town, adjacent to gas projects worth US\$60 billion, with a three-pronged attack on Wednesday. Fighting continued on Monday, according to a security source directly involved in efforts to secure the town.

The government confirmed on Sunday that dozens of people had died, including seven when their convoy of cars was ambushed during an escape attempt.

Islamic State claimed the attack via its Amaq news agency, saying its fighters had taken control of the town after days of clashes with security forces.

They had killed at least 55 people, including a number of soldiers, destroyed and taken control of buildings including factories and banks, and seized vehicles, it said.

Reuters could not independently verify the claims. Most communications to Palma have been down since Wednesday.

Officials at Mozambique's defence ministry and its national police could not be reached for comment by phone on Monday and did not immediately reply to text messages.

The country's northernmost province of Cabo Delgado, where Palma is located on the border with Tanzania, has been home since 2017 to a simmering Islamist insurgency now linked to Islamic State.

Justice demanded on Floyd trial eve

MINNEAPOLIS, Minnesota

THE trial over the death of George Floyd was due to open on Monday with calls for justice ringing out from a prayer service held the day before in memory of the African American who died under the knee of a white police officer.

Opening arguments were scheduled to get underway in the murder trial of Derek Chauvin, the former police officer whose alleged killing of Floyd last May ignited protests against racism and police brutality across the United States.

Chauvin, a veteran of the Minneapolis Police Department, faces murder and manslaughter charges for his role in death of Floyd, 46, on May 25.

Floyd's cause of death is expected to be the central issue in the case, and a key piece of evidence is likely to be the bystander-filmed video of his death that went viral and triggered a summer of Black Lives Matter protests.

Chauvin was seen in the video kneeling on Floyd's neck for nearly nine minutes while arresting him for allegedly passing a counterfeit US\$20 bill.

While lying face down in the street, the handcuffed Floyd complains that he cannot breathe and calls out for his mother.

On Sunday night, hours before opening statements in the court, national civil rights leaders appeared at a prayer service alongside several of Floyd's family members. Several dozen attendees congregated in the benches at Greater Friendship Missionary Church, where preachers led worship, a choir sang and members of Floyd's family were joined by the Rev. Al Sharpton and Ben Crump, a civil rights attorney who also represents the Floyd family.

Floyd's family called for justice.

"I have a big hole right now in my heart. It can't be patched up. ... I need justice for George. We need a conviction," Floyd's brother Philonise Floyd told reporters in Minneapolis on Sunday. "I have faith that he will get convicted."

Opening arguments in the case were set to begin at 9 am local time in a heavily guarded Minneapolis courtroom for a trial being closely watched around the world.

The public has been banned from attending the trial because of the COVID-19 pandemic, but it is being livestreamed.

Minneapolis' Star Tribune newspaper called the trial "a defining moment in America's racial history".

Proceedings are expected to last about a month.

Fifteen jurors have been selected, though Hennepin County Judge Peter Cahill was expected to drop one juror on Monday and proceed with 12 and two alternates.

China sees 10.1 million people return or move to countryside to start businesses or pursue innovations in 2020 CHINA has witnessed continuous expansion

The panel seated after two weeks of jury selection is racially mixed: six white women, three black men, three white men, two mixed-race women and one black woman.

The identities of the jurors will not be revealed until after the trial but some details are known.

They range in age from their 20s to their 60s and include a chemist, a social worker, an accountant and a nurse. Two are immigrants to the US.

One is a grandmother, one is recently married and one is a single mother of two teenage boys.

The jury selection process was complicated by the intensive pretrial publicity surrounding the case and all but one of the jurors said they had seen at least some of the arrest video.

"I'm thankful that it is a diverse jury," Paris Stevens, a cousin of Floyd who works as a nurse in North Carolina, said in a telephone interview. "I'm very anxious because you don't know what's going to happen, but I'm just glad that this process is starting."

A conviction on any of the charges second-degree murder,



third-degree murder or manslaughter will require the jury to return a unanimous verdict.

Legal experts have noted that US police officers have almost never been found criminally liable for killing a citizen. Chauvin's lawyers have said they will try to convince the jury that the fentanyl, an opioid painkiller, found in Floyd's blood by the medical examiner played a bigger role in killing Floyd than the officer's restraint.

Eric Nelson, Chauvin's attorney, asked to have the trial delayed and moved out of Minneapolis because of a March 12 announcement that the city had reached a US\$27 million "wrongful death" settlement with the Floyd family.

Judge Cahill rejected the demand.

Three other former police officers Tou Thao, Thomas Lane, and J. Alexander Kueng also face charges in connection with Floyd's death. They are to be tried separately later in the year.

Boat rescues

The total number of dead or missing following the attack remains unclear. Tens of thousands of people may have fled, according to three aid workers.

Nick Alexander, a British-South African contractor, was in a convoy of vehicles attempting to escape a besieged hotel on Friday, his daughter Jayde, who lives in Johannesburg, told Reuters via WhatsApp.

He spent two nights crawling in the bush after the ambush before being rescued, she said, adding that he had grabbed a machine gun from a military vehicle for protection only to find it did not work.

"He is alive and well and on his way home," she said.

Many people fled to the beach in hopes of being rescued, another security source in touch with government-allied forces said. A variety of boats were taking them to the provincial capital, Pemba, about 240 km to the south, an aid worker said.

Government-contracted helicopters have also been rescuing people, the security sources said.

No contact

Relatives of the missing waited anxiously at Pemba's port, hoping to hear news of their family members.

"I have had no contact with my family since Wednesday, my wife, my sons, my mother, my brothers," Pemba resident Patricio Amade told Portugal's state news agency Lusa.

Lusa also reported on Monday that hundreds of people who fled Palma had arrived at the border with Tanzania after walking through the bush for days to get to safety.

Tanzania's police told Reuters they had not so far seen people seeking to enter their territory from Mozambique.

At least one South African was among those killed. Britain's The Times newspaper reported that a British national had died.

French energy group Total said on Saturday it was calling off a planned resumption of construction at its \$20 billion development outside Palma following the attack and would reduce its workforce to a "strict minimum".

The company pulled out the majority of its workforce in January due to security issues. *Agencies*

While marking the largest and fastest growth in the number of people moving back to the countryside to start their own businesses or pursue innovations in China, the year 2020 also witnessed the formation of four major driving forces of entrepreneurship in the country, namely migrant workers, college graduates, exservicemen, and women.

At the same time, more than 19 million rural residents who returned to or stayed in their hometowns secured jobs near their homes in 2020, thanks to the efforts of various local governments, which have taken comprehensive measures to effectively cope with the impacts of the COVID-19 pandemic and make overall planning to support people who returned or moved to rural areas to start their own businesses and seek jobs.

Liang Yongying, a woman born in Shanghang county, Longyan city, east China's Fujian province, returned to her hometown in 2011 after working in Fuzhou, capital of Fujian province for five years since she graduated from a college. She found that people in her hometown, which has been known as the "land of fish and rice", were still using traditional cultivation methods and local specialties hadn't been sold outside of her hometown although modern agriculture was enjoying rapid development.

As the country continuously rolled out favorable policies to support the development of the agricultural sector, rural areas and rural people, Liang eventually decided to return to her hometown to engage in agricultural industry which she has always had a keen interest in.

After returning to her hometown, Liang first became a major grain producer of her hometown, and then owner of a family farm. She has also established a new farmers' association of Longyan city.

She has realized mechanized and large-scale rice farming through transfer of land-use rights, and set up her own processing factory to provide services for local farmers. The rice from her farm has obtained the green food certification and gradually enjoyed increasing popularity.

Today, her farm offers help to 20 families which used to be registered impoverished

households under the "pairing assistance" model every year. Governments across the country are trying to create more opportunities for people who returned or moved to the countryside to start their own businesses or secure employment.

Various areas of the country have made active efforts to expand the capacity of planting and breeding industries for creating opportunities for entrepreneurs and job hunters, the functional value of rural areas, and the room for improving the efficiency and benefits of industries by focusing on implementing policies on stabilizing employment, creating jobs by boosting development of various industries, optimizing services in providing jobs for residents, and offering vocational training to people to help them upgrade skills or switch jobs.

About 20 percent of the people who returned or moved to the country's rural areas mainly engage in large-scale and characteristic planting and breeding businesses, seedling cultivation, and livestock and poultry breeding, or lead or co-run farmers' cooperatives and family farms.

Around 55 percent of these people have established familyowned factories, rural workshops, small and micro businesses and other entities to seek development in such fields as catering, homestay hotels, farm produce preliminary processing, and featured crafts. The rest 25 percent of the group work as temporary or part-time workers, mainly running small businesses or engaging in temporary jobs.

According to reliable statistics, of all the projects initiated by people who returned or moved to the country's countryside, 55 percent have tapped into information technology to run online shops, engage in live-steaming shows and direct selling, as well as contactless delivery business, while over 85 percent feature the integration of primary, secondary and tertiary industries and cover a wide range of fields including production, processing, selling, services, and sectors such as agriculture, culture, tourism, and education.

Last year, each project initiated by people who returned or moved to China's rural areas to start their own businesses or make innovations could provide stable employment for 6.3 people and flexible employment for 17.3 people on average. At the same time, such projects have brought benefits to local farmers based on contracts, in dividend payments, and via shares.

Centering on consolidating and expanding the achievements in poverty alleviation, China is going to further promote the development of rural business projects and cultivate a batch of major entrepreneurship and innovation forces that are rooted in rural areas, create rural industries, and can help local residents increase income, according to Liu Huanxin, vice minister of agriculture and rural affairs. Minister Wang Yi commented on China-Russia relations after he met with Russian Foreign Minister Sergei Lavrov in China's southern city of Guilin. It is also an apt description of the relationship between the two countries amid a time of turbulence.

This year marks the 20th anniversary of the signing of the China-Russia Treaty of Good-neighborliness and Friendly Cooperation. Over the past 20 years, this treaty has laid a solid legal foundation for the long-term and healthy development of China-Russia relations.

One of the most important results of the meeting between Wang and Lavrov in Guilin is an agreement to renew the treaty between the two sides and to make it more relevant in the new era. The meeting has also demonstrated the new heights, new ideas and new results of China-Russia cooperation.

The Guilin meeting is of particular importance against the backdrop of a lingering pandemic and growing global uncertainties. It is also a further confirmation of the commitment of the two countries to strengthening bilateral relations.

The reason why China-Russia relations have withstood the test of changes in international situation and become a stable force in today's world lies in the fact that the two sides always pursue a principle of non-alignment, non-confrontation and non-targeting of third parties.

Besides, they always respect each other's core interests and accommodate each other's legitimate concerns, always act responsibly and uphold justice, and firmly safeguard the international system with the United Nations at its core and the international order based on international law.

Just as Lavrov said ahead of his trip to China, "the model of interaction between Russia and China is absolutely free from any ideological constraints. It is of an intrinsic nature, not subject to any opportunistic factors nor against any third country."

In the spirit of such principles, cooperation between China and Russia has injected valuable stability and positive energy into the global community.

As two permanent members of the UN Security Council, the two sides also shoulder their due responsibilities in safeguarding security and development of the international community, and promoting the improvement of the current global governance system.

After the talks in Guilin, the two sides issued a joint statement on several issues of current global governance, expounding the essence of major concepts such as human rights, democracy, international order, and multilateralism, which reflected the collective demands of the international community, especially developing countries. **Xinhua**

RICHARD Mbulu scored after 16 minutes to give Malawi a 1-0 Group B victory over Uganda on Monday, and qualification for the 2021 Africa Cup of Nations.

The 27-year-old forward headed powerfully past Uganda goalkeeper Denis Onyango off a cross from former Atletico Madrid youth squad member Robin Ngalande.

It was the second time in six days that a goal from the South Africa-based attacker proved decisive as he also scored in last Wednesday's 1-0 win over South Sudan.

The son of a former footballer, Mbulu was based in Mozambique twice and Portugal before signing a three-year contract with South African Premiership club Baroka in 2019.

Hosts Malawi needed maximum points at Kamuzu Stadium in commercial capital Blantyre to secure a first appearance since 2010 while a draw would have sufficed for Uganda.

Victory temporarily took Malawi to the top of the table with 10 points -- they were overtaken three hours later when fellow qualifiers Burkina Faso defeated South Sudan 1-0 in Ouagadougou.

Aston Villa forward Bertrand Traore scored the Burkinabe goal on 50 minutes as the team finished unbeaten a six-match qualifying campaign spanning 17 months.

Popularly known as the Flames, Malawi are ranked 123rd in the world, 40 places below Uganda, and will be making a third appearance at the finals after firstround exits from the 1984 and 2010 editions.

They are the 19th qualifiers after Algeria, Burkina Faso, Cameroon, Comoros, Egypt, Equatorial Guinea, Gabon, Gambia, Ghana, Guinea, Ivory Coast, Mali, Morocco, Nigeria, Senegal, Sudan, Tunisia and Zimbabwe. - Salah scores twice -

The match in Blantyre was the only one of eight staged Monday that involved qualification, with just pride at stake in the others.

Joint leading Premier League scorer Mohamed Salah of Liverpool scored twice as Egypt netted four times in 10 minutes during the first half to hammer the Comoros 4-0 in Cairo and top Group

Kenya claimed a first win in the same section with goals from Hassan Abdallah and Masoud Juma, off a penalty, delivering a 2-1 win in Togo.

Captain Riyad Mahrez scored as Group H table-toppers Algeria finished with a 5-0 rout of Botswana in Blida, which stretched an unbeaten record in competitive and friendly matches to 24.

Zimbabwe, the other qualifiers from the section, fell 2-0 to neighbours Zambia in Harare with Patson Daka netting twice to become the leading scorer in qualifying with five goals.

Both Group D qualifiers lost with Gabon beaten 2-0 by Angola in Luanda and the Gambia going down 1-0 to the Democratic Republic of Congo in Kinshasa.

Manuel 'Show' Cafumana and Loide Augusto scored to end a five-match winless run by Angola in the group while Kazadi Kasengu was the Congolese match-winner, converting a penalty on the stroke of half-time.

The remaining five places will be filled Tuesday with the Central African Republic, who have never qualified for the premier African national team competition, among 12 hopefuls.

Who could Man City sign to replace Aguero long-term?

FAVOURITES to regain the Premier League title this season, Manchester City have won 22 of their 30 games in the Premier League and are 14 points clear. Yet one area where they have not been as dominant as in recent years is in front of goal. They've averaged above 2.5 goals per game in each of the past three league campaigns, yet this season it's down to 2.1.

One reason is the frequent absence of the club's record goal scorer, Sergio Aguero. But with the injury-hit Argentina international confirming that he will depart on a free transfer in the summer, and Gabriel Jesus less than convincing as a replacement, having scored 12 league goals in 30 appearances in all competitions, City will look to land a new striker in the next transfer window.

The COVID-19 pandemic has shaken the global economy and no one is really sure of the shortterm implications, let alone longer term. Even the biggest clubs are strained financially. Although City's Abu Dhabi-based billionaire owners seem to operate in a different environment to the rest, they may still feel the pinch. In July 2020, the Court of Arbitration for Sport (CAS) overturned City's two-year ban from European football that was imposed for breaching UEFA's financial fair play (FFP) regulations, and focus on their finances has never been sharper.

Indeed, manager Pep Guardiola claimed in October that "if you decide to buy a striker, it has to be a striker in the league of Gabriel and Sergio, but we cannot afford it. That is the reality." Yet this is a club that has spent close to £1.5 billion on players over the last decade and even managed over £120m last summer on Ruben Dias, Nathan Ake and Ferran Torres. Although Guardiola has reorganised his attacking set-up to become less dependent on a classic centre-forward, a world-class addition in that position is still tempting given Aguero's success over the years. With the caveat that Barcelona's Lionel Messi is too old (at 34) and most likely too expensive (in terms of wage demands) to make a long-term impact at City, here are five star forwards who could help City back to their free-scoring ways.

Harry Kane (Tottenham)

Tottenham have no desire to let their star striker leave and recent reports that they have set a £150m valuation are wide of the mark, but the club look increasingly likely to miss out on the Champions League next season after a poor campaign under Jose Mourinho. They may find it more challenging to hold out if City come calling this summer.

Kane turns 28 in the summer and it might make business sense to consider offers as his contract expires in 2024, though Tottenham would be loath to let him leave for a Premier League rival. From City's perspective, Kane's skill set and track record as a world-class "No. 9" mean Guardiola would look beyond any tiny technical shortcom-

Aside from the theoretically awkward prospect of PSG's Qatari ownership letting their biggest star move to an UAE-owned rival, the multi-talented Mbappe would obviously improve any club he ends up joining, but City may find themselves out of the loop on this one.

Romelu Lukaku (Inter Milan)

Lukaku has stacked up an impressive 42 goals from 62 Serie A games since leaving Manchester United in summer 2019 for around €80m. Inter look on course to win their first Scudetto in over a decade, though the club may face changes at ownership level soon. Such potentially disruptive developments may have a bearing on the club's ability to hang on to their most valuable players and Lukaku is certainly one of those.

The Belgium international's main forte is his pace and power, but he now appears a better link-up player than when he left the Premier League. In addition, he seems more comfortable using his right foot and also appears more aware in his tactical decision making. At 27, he

The 28-year-old has scored 17 Premier League goals this season as Liverpool have struggled to match the form that saw them end a 30-year wait to be crowned champions in 2019-20. They are seventh in the Premier League table, 25 points behind leaders Manchester City.

Liverpool bounced back from that defeat to win the Champions League a year later, beating Tottenham Hotspur in the 2019 final in Madrid.

Madrid host Liverpool in the first leg of their quarterfinal clash on Tuesday April 6, before the return leg at Anfield on April 14.

Henry on quitting all social media: It is not safe

ARSENAL and France legend Thierry Henry said the time was right for him to leave social media in the wake of increasing instances of footballers receiving racist abuse online, telling the BBC on Monday that "it is not a safe place."

Henry announced last week that he will no longer be using social media until the platforms do more to tackle racism and bullying online as footballers such as Marcus Rashford, Anthony Martial, Axel Tuanzebe (twice) and Lauren James have all been subjected to racist abuse over the past few months. "It was time to make a stand," Henry said on BBC programme Newsnight.

"Things I used to hear in the stadiums and the streets are coming more and more into social media, especially in my community, and the sport I love the most, football.

"I thought it was time to make a stand and time to make people realise it is not OK to get abused online, it's not OK to be bullied or harassed online. "The impact it can have on your mental health is second to none, we know people are committing suicides because of it. Enough is enough. We need actions.

"It is too easy to get an account and get away with it at times."

The English Football Association has also called on social media companies to introduce strategies to curb online abuse on their platforms. Last month, Instagram announced a series of measures to address the problem but Henry suggested more reforms need to be enacted.

Erling Haaland (Borussia **Dortmund**)


Possibly the defining "power forward" of this decade, Haaland is a veritable goal machine whose remarkable numbers speak for themselves: 21 goals from 21 Bundesliga matches with 10 from six Champions League outings this season. While the Norway international doesn't appear quite the refined, elegant, technically gifted striker that Guardiola tends to favour, logically City are likely to seriously discuss the option of signing him, especially given his father Alf-Inge's history with the club as a player.

There's no question that Haaland has improved his link-up play over the past year (one aspect, along with his aerial ability, which needed work). Sure, the 20-year-old is still developing, but the evidence shows he should be able to score, contribute and prosper regardless of footballing style or system. Moreover, from a commercial viewpoint, Haaland is potentially one of the most marketable players in the world (particularly for the post-Cristiano Ronaldo/Messi era), which is another plus point for any top Premier League club. Sources told ESPN that Haaland can leave Borussia Dortmund for €180m this summer, and reportedly has

is at a similar point in his career to Kane, but his history at City's local rivals United may limit his (or the club's) desire for a deal.

Joao Felix (Atletico Madrid)

Surely the most Guardiola-esque player of the lot, the Portugal international is more of a drifting forward than a penalty-area poacher. Signed for €126m from Benfica in 2019, Felix is still some way off justifying that fee (though he's enjoying a fine La Liga season), but at 21, still has time to make good on his immense potential.

Equipped with a lovely touch on the ball, his movements are as sharp as they are fluid and he has an outstanding natural understanding of the game, making him perfectly cut out for City's patient but incisive attacking game.

Typically fielded in a deeper second striker role by Atletico manager Diego Simeone, he's also able to play as a false No. 9, dropping deep to create space and involve the wide and attacking midfielders. Atletico won't want to let him go, and he signed a contract through to June 2026 when he joined so the ball is in their court, but Felix could offer City a different kind of option to the rest.

Simba SC midfielder set to miss AS Vita Club clash

TANZANIA's Simba SC is likely to miss the services of defensive midfielder, Thadeo Lwanga, in the outfit's CAF Champions League's Group A clash against Democratic Republic of Congo (DRC)'s AS Vita Club, slated for Saturday in Dar es Salaam.

The Ugandan player is part of Uganda's national team squad, which confronted Malawi in Africa Cup of Nations qualifiers.

A response from a laboratory in Malawi confirmed Lwanga and two other Uganda national team players have contracted coronavirus.

The midfielder could be missing after COVID-19 tests showed he was among three Ugandan players infected with the disease, with goalkeeper Denis Onyango and midfielder Farouk Miya.

The results of the trio, including Lwanga, was issued shortly before the African Cup of Nations' qualifiers' match between hosts Malawi and Uganda scheduled to be played in Lilongwe.

However, the Uganda Football Federation (FUFA) expressed its dismay and disagreement with the response to the tests, claiming that Lwanga was not infected with COVID-19.

The FUFA revealed: "We are closely monitoring the mistakes made by our team of doctors on Thadeo Lwanga's COVID-19 tests."

"Two tests have produced two different responses. We have written to CAF on this matter," the FUFA statement said.

According to Malawi's immigration system, a person diagnosed with COVID-19 infection should be quarantined for seven days and then tested again.

As a result, Lwanga is set to miss the Simba SC v AS Vita Club match, which will take place at Benjamin Mkapa Stadium.

The statement was released a few days since rumors circulated about the midfielder, who joined Yanga this season from AS Vita Club of Democratic Republic of Congo (DRC), joining Kaizer Chiefs.

Recently chief scout of Kaizer Chiefs, Walter Steenbok, landed in Tanzania and went to visit Yanga's offices and see for himself how the side was faring after receiving reports from Tonombe and compatriot Tuisila Kisinda joining the club this season.

Yanga's Information Officer, Hassan Bumbuli, said that no talks had taken place between Kaizer Chiefs and Yanga regarding Tonombe.
