Govt hiring 9,675 teachers, medics

THE government yesterday announced 10,675 employment opportunities for primary and secondary school teachers and health workers.

Addressing a press conference here yesterday, the Minister of State in the President's Office (Regional Administration and Local Governments), Ummy Mwalimu, said the ministry has obtained an employment permit from within the President's Office (Public Service Management and Good Governance).

Of the total, 2,726 job openings are for health attendants in municipal, district hospitals and health centres, she said, noting that fairness in the recruitment process will be observed.

The remaining 6,949 employment slots are for primary and secondary schools' teachers, she said, cautioning applicants over conmen seeking the paying of bribes to pursue a promise of job placement. Those who come into such situation should inform the minister personally for proper measures to be pursued against civil servants involved in such rackets, she said.

Germany inks 56bn/conservation 'extra'

GERMANY has provided an additional 56bn/- (euros 20m) funding to enhance the protection of wildlife and biodiversity in national parks and game reserves.

This funding is directed to emergency funding for conservation of biodiversity support in Tanzania, based at the Tanzania Wildlife

Poaching went down rapidly during the past five years partly in view of collaboration between the ministry and conservation partners

Management Authority (TAWA) and Tanzania National Parks (TANAPA), partly intended to cushion effects of decreased revenues due to fewer tourist arrivals.

An embassy statement issued in Dar es Salaam yesterday explained that the global pandemic had caused havoc in the tourism sector, noting that it was under immense pressure and revenues from national parks went down.

This additional funding will serve as emergency funding to support Covid-19 repercussions in managing the national park around the Julius

May and the curtains close on May 23rd, with applicants submitting requests online through ajira.tamisemi.go.tz

Employment opportunities laid out are meant to fill in gaps of teachers and health cadres personnel for various levels, thus needing certificate, diploma and degree holders for the various levels, she stated.

Applicants should bear in mind that when applying they must be ready to work in whatever duty station will be assigned to the applicant and no transfer will be issued as employment opportunities are geared towards filling staff shortages in the respective councils, the minister emphasised.

Eligible applicants are those who graduated in teacher training colleges from 2012 to 2019, with primary school applicants being those with certificates and diploma with qualification in special needs education.

Physical education and early childhood education are also relevant, as those to be graded in III-C must poses a Bachelor in education degree majoring in English, History and Geography.

For secondary schools, the minister said the gaps to be filled are Education degree holders and Post Graduate Diploma in Education holders majoring in Physics, Mathematics, Biology and Chemistry.

the general requirement for applicants is that one must be a citizen below 45 years of age, show a national identification number, birth certificate and copies of academic credentials, among other aspects.

Health sector cadres' posts relate to medicine degree holders from recognized universities with one year internship, and registered with the Medical Council of Tanganyika as medical doctors and dentists.

Also diploma holders in clinical medicine, clinical assistant certificate, Diploma in Clinical Dentistry and Clinical Assistants Certificate can apply for a section of the posts.

Pharmacist Others are Degree holders with one-year internship and registered with the Pharmacy Council, a Diploma in Pharmaceutical Technology and those with Certificate in Pharmaceutical Technology.

Listed opportunities also cover holders of diploma or certificate in Health Laboratory Sciences, Diploma in Radiology

or Radiography, undergraduates in nursing, diploma in nursing and midwifery, along with holders of a certificate in nursing and midwifery.

Other job placements relate to needs for physiotherapists, those with a Bachelor's Degree in Environmental Health Science or Advanced Diploma in Social Work, in Sociology, Psychology, Social Protection, Guidance and Counseling, as well as in Theology, Divinity, Child Protection, Social Policy, Early Childhood Development and Social Gerontology.

Yet other relevant fields include Nutrition, Home Economics and Nutrition, Food Science and Technology, while Food Science diploma holders also have a slot in the job openings listed.

Elaborating on NIDA numbers, the minister said the office handling applications has directed that applicants must have their NIDA numbers.

Applicants should be ready to work in the districts they will be assigned, while just selection will be assured and no inducements entertained, she reiterated.

Nyerere Hydropower Project (JNHPP), the Selous Game Reserve and especially the Serengeti, it said.

The German government has been among key partners for Tanzania in protecting wildlife and has spent close to 300bn/-(106m euros) in this sector in the past years five years.

The statement affirmed that saving and protecting Tanzania's worldwide unique nature and wildlife has been and will be at the core of Germany's development cooperation.

"This year we are celebrating the 60th anniversary of successful Tanzanian-German cooperation. For 60 years, Germany is standing firmly at Tanzania's side as a stable partner for development cooperation, it said.

"Germany is committed to work hand in hand with the government and thus supporting the ongoing efforts by President Samia Suluhu Hassan in protecting the rich treasures of Tanzania's fantastic nature,." it observed.

The headmaster told members of the committee that the incidents started last year and he pursued various steps, including calling the named teachers to write down statements and referred them to the school board for further action.

On March 18r the board summoned the teachers but some were forgiven except one the board opted too direct his case to the District Executive Director for procedural action.

"I, as the school board secretary was directed to send this one to the DED so as to be removed from the school, but instead he was promoted and sent to Mtanila

secondary school nearby," he said. The school board chairman Lutangilo Nsemwa said accusations against the teachers came light in 2016 without tangible evidence to enable pursuits against them.

Despite being summoned for explanations they continued with their improper behavior so the school authorities decided to set

a trap.

At that time the present headmaster was not yet the headmaster there, but after he was promoted to the post, he took some two years to start instilling discipline among the staff.

For his part, divisional officer Kirandomala said misunderstanding among the teachers arose at the school as

the matter was being pursued, with the teachers kicking up dust for being tracked on their behavior. The referred teacher said these were false claims to spoil his reputation, meanwhile as the teaching environment there was beginning to sag under the pressure.

DC Mayeka ordered the police to arrest and detain the four

teachers for further steps and called upon other teachers to stop these acts that go against teaching ethics, meanwhile as the teachers were immediately suspended to give way to legal processes.

Some of the girl students who were found to have been involved in having sex with teachers were also placed in custody and had written statements taken. A total of 18 girl students were found to have had sex with teachers, the divisional officer added.

Schools empowered to become fruit growers, future exporters

THE future of Agricultural goods exports seems to be focused on fruits and in respect to that, Tanzania is investing heavily in establishing tree farming in local Primary and Secondary Schools to prepare the institutions for this beckoning lucrative deal. The initiative was hatched by the Apex Institution for the country's Private Sector (TAHA) in association with the Brussels based International Development Organization (TRIAS). The two organizations target combat effects of climate change through massive fruit tree planting exercises but at the same time prepare the country to become future leading exporters of fruits to international markets where the demand keeps rising.

Anthony Chamanga is the TAHA Chief Manager in-charge of Development and he said; "There are many benefits derived from trees, including shade, fresh air and nutrition but we are going beyond that, we want to transform trees into profitable investments!"

Chamanga was speaking in Arumeru District, over the weekend, where TAHA conducted tree planting exercises at Chem-Chem and Kimandafu Primary Schools, where he also promised that his organization will secure market outlets for fruits grown in schools.

It wasn't just tree planting but the event also featured environmental training sessions by the Head of TAHA Production Department, Hilliard Mollel and expert nutritionist Rosalia Aloyce and on proper ways of handling tree seedlings, soil types and how to water the seedlings as well as fruits management.

TRIAS Projects Manager, Lilian Makoi revealed that they have been planting an average of 38,000 trees per annum with the number expected to increase this year.

"Today alone, we have distributed and planted 270 seedlings in the two schools; at this pace soon we shall replenish the country's green cover and combat global warming and related climate change effects," stated Makoi.

She pointed out that, apart from their nutrition and commercial potential, fruit trees were also more effective in absorbing carbon gases from the atmosphere as well as aiding the rain cycle.

TAHA on the other hand, has also been

introducing school gardening programs, a new project which has facilitated creation of school gardens in some six Secondary and Primary Schools in Arusha, Kilimanjaro, Mara, and Simiyu regions where pupils and students are taught best farming skills to enhance yields and provide them with improved nutritious meals.

The project executed with support from the United Nations Development Programme (UNDP) has so far enabled the students to receive necessary good agricultural practices (GAPs) training, especially on how to grow leafy vegetables with high nutritious values as well as steaming process that retains nourishment, healthy for their diets.

Experts see great potential in the country's horticulture industry described to be in position of generating up to US\$ 3 billion per annum, with official reports from TAHA indicating major achievements gained from the horticulture industry, including increases in yields of fruits and vegetables by up to 300 percent as well as the topped export earnings from US \$ 64 million in 2004to over US \$ 780 million as of now.

Tanzania is currently exporting horticulture produce valued at more than US \$ 780 million, however the industry's current potential is estimated to be more than US \$3 Billion a figure which is soon going to be realized with the opening up of new markets abroad.

While fresh cut flowers are the flagship of Tanzania Horticulture Industry, globally it is the fruits that really spell the trade, with the Avocados currently commanding great demand and market value of US\$ 13 billion. Avocado consumption per capita in the United States alone is said to have increased by 400 percent between 1990s and 2017 and counting.

In that respect therefore TAHA seems to start cultivating fruit trees right from grassroots level by introducing seedling in local schools.

"We envision seeing constant Horticulture production in Tanzania for domestic and global markets. This calls for tireless efforts to ensure strong collaboration with a range of stakeholders on identifying buyers, market standards, and quality requirements, entry approaches as well as market trends,' the TAHA Chief Executive, Dr Jacqueline Mkindi had previously stated.



Pemba activists look for new strategies in the war against GBV

STAKEHOLDERS in the fight against gender based violence (GBV) and child abuse in Pemba have joined hands to discuss new strategies to deal with the vices in the society that continue to be a threat each passing day.

Speaking at a meeting organized by Tanzania media Women Association-Zanzibar (TAMWA-Zanzibar) that incorporated magistrates, officials from the office of the Director of Public Prosecutions (DPP), Police Gender Desk and Community Development Officers, they said there was a need for every concerned institution to work together in closely following up cases in order to obtaining timely judgments.

Wete Regional Magistrate Abdalla Yahya Shamhun said in case the society would agree to transform and report these incidents in time and others involved to be accountable it will the beginning for their eradication.

He confessed in the existence of shortcomings in some officials dealing with the cases in the courts and stressed over the need for all government organs to stand firmly against some magistrates who want to mar the cases for their own self interests.

He said; "We confess the existence of shortfall in our ranks, but if right from the beginning the police, doctors and others send witnesses in the right sequence, there wouldn't be any magistrate who can mar the cases.'

Meanwhile the Magistrate said cited Micheweni District in North Pemba region to be leading for cases being dismissed due to refusal by witnessed to testify in court.

"There are very many cases we intend to dismiss through lack of witnesses," he added.

Talking on witnesses, the Deputy Registrar of the High Court in Pemba Abdul Razak Ali said witnesses fail to attend court sessions die to lack of fares which

the courts are bound to provide, for reasons that the courts do not get such funds in time, adding that the problem is caused by both sides.


For his part the Wete Police Gender Desk Coordinator ASP Fakih Yussuf said police officials dealing with these cases are faced by various challenges including lack of the budget to enable them making follow ups of the incidents, hence hindering them to respond to such incidents in time.

ASP Fakih also called upon the society to have in place a procedure in taking quick steps by arresting suspects to avoid the possibility for their running away after committing the vile deeds.

"The society should not wait for the police to arrive to arrest the suspects, instead they should detain them soon after commission of the crime,' he added.

For her part Salma Abdalla Hemed, an activist against GBV and child abuse said the cases take very long time to be finalised, hence dismissing them is a challenge that discourages them in their continual collaboration in following up the cases.

Media advised to devise effective gender policies to uphold equality at workplaces

THE Tanzania Media Women Association (TAMWA)-Zanzibar has urged media organizations in the country to have strong inhouse gender policies so as to promote equality and address violence at workplaces.

TAMWA-Zanzibar director Dr Mzuri Issa made the remarks at the weekend during the stakeholders' virtual meeting which aimed to discuss media freedom and the importance of having the best laws to govern and stimulate the development of the industry.

The meeting was organized by Internews-Tanzania bringing together media stakeholders from various parts of the country.

According to her, as Tanzania would be working comfortably as joined others recently to commemorate World Press Freedom Day, it was now high

time to think and focus more on eradicating violence against women journalists in both Zanzibar and Tanzania mainland. "Majority of media houses don't have gender policies in their organizations, instead they just operate normally, which poses great risk to women workers who remain back always as they face several challenges including

sexual corruption," she said. Dr Mzuri said that by having a strong gender policy which is well supervised by the organization's management and well known to every worker, women journalists

well as acquiring top management positions.

Harous Mpatani, executive director of Zanzibar Legal Service Centre (ZLSC) wanted the government and stakeholders to continue promoting access to information because it is a constitutional right.

Adhere to standards, seek certificates of origin, TRA tells traders in Kagera

THE Business community in Kagera Region has been urged to adhere to standards, seek certificates of origin so as to enable them to easily grab international markets.

Alex Mwambeja, TRA taxpayers' education service officer for Kagera Region made the call recently when speaking during the training provided to journalists so as to enable educate the public correctly on issues of tax.

According to Mwambeja having a 'certificate of origin attests that the product has met several criteria to be considered as originating in a particular country, something which will enable the entrepreneurs to trade freely to a member country, without paying customs or duties.

Mwambeja said the product is

regarded as a member state, only if raw materials made up from outside of the community do not exceed 60 pc of its value, adding that in Tanzania, Certificate of Origin is obtained from TCCIA offices and Customs.

He named the jurisdiction of customs that are main and minor stations, airports and ports, custom stations, and Post parcel offices.

He insisted the traders should know that all products which are eligible for VAT, should pay for that within 21 days since the arrival, and if not so the products will be auctioned by TRA.

"For those who are crossing borders to and fro, shouldn't carry money or anything changeable for example a cheque equivalent to, or more than US\$10,000, unless it is declared and shown to Customs officers, contrary to that the money will be confiscated, and the owner

Mwambeja insisted that traders and entrepreneurs should have all necessary documents which are actual purchase invoice, packing list, airbill/bill of lading and import/export permits, and all required documents for restricted products such as animals, plants, arms, and ammunition.

However, Mwambeja warned unscrupulous traders to stop engaging in illegal business which includes transporting prohibited items as the government was closely monitoring the practices.

Local contractors urged to pay back loans to CAF

THE government has urged local contractors to pay back loans they get from Contractors Assistance Fund (CAF) for its sustainability so that can benefit others.

The call was made over the weekend in Arusha by the Deputy Minister for Works and Transport, Mwita Waitara when he was closing the two days Consultative Meeting between the Contractors Registration Board (CRB) and local contractors of the northern zone.

CRB introduced the fund dubbed Contractors Assistance Fund (CAF), to give loans to local contractors of all classes up to 100m/- to enable them to execute construction projects and pay back.

CRB commended He management for the introduction of the fund which he said if contractors will utilize it efficiently could be a major bridge to their success in their profession.

Waitara said it is unpleasant to witness some of the local contractors who were benefited from the fund refuse to pay back the loans as required in the contract they signed something that might kill the fund and deny others the opportunity to access loans

"My dear colleague I must tell you the truth if you are trusted by people try to be honest and honor the contract you have signed when you take loans, frankly speaking. this trend will kill the fund within a very short time you must change this trend," insisted Waitara

Speaking about the implementation of big projects, Waitara said the government will continue to set aside some projects to build the capacity of local contractors but they have to be honest and faithfully so that they execute them within agreed time and quality.

"When you are awarded construction tenders by the government you must be patriotic

to adhere to agreed standards because it is the people's money so do it to attract the government to award you more tenders," he said

Waitara commended CRB for arranging regular consultative meetings with local contractors which build their capacity to enable them to execute strategic projects in the future, advising the board to continue with more consultative meetings with local contractors because that is the only platform they get feedback from them and plan the way forward.

He directed CRB to inspect all projects that are executed by local contractors and insist them to complete within the agreed time and quality so that government and other client trust them.

"Am happy to hear from the registrar that recently you will visit different projects that are executed by local contractors, you must also visit the project in Kilosa District and speak to your fellows that they must complete the project as soon as it is required so that you build trust," he said.

The CRB Registrar, Eng. Rhoben Nkori told the deputy minister that they have arranged to visit different projects that are implemented by local contractors which were awarded by the government as a move to build their capacity

He added that CRB will address all challenges that hinder local contractors to implement force account projects so that government can award them of that nature.

Engineer Nkori said it is unpleasant to see local contractors are awarded special projects to build their capacity but they fail to complete them within agreed time and quality.

"I urge you to be honest when you are awarded tenders because it is the crucial moment for you to show your ability to your clients and government that you are able to do otherwise you will cause trouble to others when they apply for construction tenders, " said engineer Nkori.

OVER 3000 residents in Bukoba Municipality in Kagera Region are set to benefit from water supply service under the project which is implemented by the Bukoba Urban Water Supply and Sanitation Authority (BUWASA). BUWASA liaison officer, Julieth Shangali said during the councilors' meeting in the municipality that the implementation of the project will bring relief to the residents who have been grappling to access the

precious liquid for many years.

She said that the second phase project of laying water pipes network will now reach new customers in all 14 wards in Bukoba municipality.

According to her, the project's major aim is to ensure that all areas with no access to water in the municipality are reached with the service so as to, among other things, stimulate economic growth.

"The contractor, MS MBESSO Construction Co. Ltd VS COSMOS Engineering Co. Ltd is at final touches before handing over the 2.5bn/ worth project which will benefit 3000 new water users," she said.

Shangali said the project, contract number ME011/2016/2017/W/CONTR/16, started in 2017, will serve Buhembe, Nyanga, Nshambya, Kahororo, and Nyakato wards, scheduled to be completed in 2018, but due to some challenges, the contractor applied for more time and now will complete in December 2021,'

After completion of the project, BUWASA will be serving a total of more than 90,000 water users in 18,000 households.

Currently, the municipality enjoys the supply of 18 million litres of water a day from Lake Victoria, the first phase project municipality.

Eleven cases of COVID-19 variant B.1.1.7 and four of B.1.617.2 variants have been detected in South Africa, Health Minister Zweli Mkhize said last week.

According to Mkhize, the Network for Genomic Surveillance in South Africa confirmed four cases of the B.1.617.2 variant, which was first detected in India, have been detected in Gauteng and KwaZulu-Natal and all the person had a recent history of travelling from India.

Of all the 11 cases of the B.1.1.7 variant which was first detected in the UK, eight were detected in the Western Cape (with two having a history of travel from Bahrain), one was detected in KwaZulu-Natal and two were detected in Gauteng. Mkhize said the British variant

was spreading in communities. "The B.1.1.7 variant has been detected in community samples and this therefore suggests that

community transitions has already set it," he said. The National Institute for

Communicable Diseases (NICD) said that work focusing on the variants is being done.

"We would like to assure the public that the institute is focusing their resources and research efforts towards understanding the variants and what the potential implications are for South Africa," said Prof Adrian Puren, the NICD's acting executive director. South Africa has so far recorded 1,594,817 COVID-19 cases with 54,724 deaths.

Meanwhile, police in Siaya County have launched investigations into a case where a nurse is alleged to have defiled a Form Two student in Gem, Wagai sub-county.

According to a statement from

the county's Health Department, the incident took place last Sunday and was reported by the victim's parents to the area chief the following day.

Gem Sub County Police Commander Charles Chacha indicated that the officers have launched a probe to unravel what transpired. "We only got to learn about this from social media. We traced the parents and took the child to hospital on Monday evening," he said.

The suspect, according to Mr Chacha, is a nurse based at Malunga dispensary, which is located in Malunga West Sub location in the newly created Gem-Wagai Sub County.

The police boss noted that preliminary findings indicate that the nurse was caught in a compromising situation with the 17-year-old girl in his vehicle, which was parked near a thicket.

The report on the incident from the county department of health revealed that the nurse was nearly lynched by an irate mob that caught him in the act.

The report further revealed that the suspect had been warned twice to stop grooming the minor.

According to the report, the nurse managed to escape from the mob after he drove off with the student still in his vehicle.

"The victim was taken to a hospital within the sub-county on Monday for medical examination and later sought further tests at the county referral hospital in Siaya," said Mr Chacha.

Cases of defilement have become common in Siaya County.

Recently, a police officer based in Sigomre was reportedly caught by the mother of a Form One student while defiling the minor in his house. AGENCIES

Extension officers to be trained on proper fertiliser use in areas with high acidity soil

Dodoma

AGRICULTURAL researchers are planning to train the extension officers in regions with high acidity soils over proper types and application of fertilizer.

It has been unveiled that farmers within regions with high acidity soil were realizing low yields due to poor knowledge on the types of fertilizers needed in such areas.

According to special countrywide soil research conducted by the Tanzania Agricultural

at least 21.4 percent.

The regions include Mbeya, Songwe, Kigoma, Mtwara, Geita, Kagera, Tabora, Katavi, Mtwara, and Lindi.

National Coordinator for Soil Research at the Tanzania Agricultural Research Institute (TARI), Dr. Sibaway Mwanga yesterday revealed to the Guardian during an interview in Dodoma Capital City that in the regions in question uses of fertilizers must go in accord with recommended agricultural lime applications.

"The survey established that Research Institute (TARI), 10 in the regions farmers are failing

knowledge on application of needed fertilizer. For instance, most of them are ending up harvesting seven sacks of maize per hectare instead of 30," he detailed.

He expressed that the farmers within the regions have often been using UREA and DAP types of fertilizers which are unfriendly to acidity soils.

"The proper fertilizer which suits in areas with high acid concentration is CAN, which must also be applied in reflect with agricultural lime applications, he insisted.

He informed that the

AU appoints Ghana ex-President John Mahama as its high envoy to Somalia

THE African Union (AU) has appointed former Ghanaian President John Dramani Mahama as its high representative to Somalia, to help mediate between stakeholders who have failed to agree on an electoral calendar and on who should manage the polls.

AU Commission chair Moussa Faki Mahamat made the announcement in a statement on Saturday, saying Mahama will work with Somali stakeholders to reach a mutually acceptable compromise towards an allencompassing resolution to the elections stalemate in the shortest possible time.

"In fulfilling his mandate, Mahama will be supported by the peacekeepers serving under the African Union Mission in Somalia (Amisom) to ensure mediation efforts and the peace support operation work together seamlessly," he said.

The AU hopes the appointment will ensure democracy in Somalia and help curb the threat to the stability of the country and the region as a whole.

Parliamentary elections were initially to take place in 2020 and the presidential election in February 2021, but both were delayed due to squabbles among stakeholders and disagreements on modalities for voting.

Initially, Federal President Mohamed Abdullahi Farmaajo and the Lower House of Somalia's bicameral parliament preferred a one-man, one-vote universal suffrage.

There were some who preferred an indirect election whereby delegates selected from



clans would elect members of Parliament.

discussions between But President Farmaajo and the presidents of the five Federal Member States (FMS) - Galmudug, Hirshabelle, Puntland, Southwest and Jubbaland - as well as the Mayor of Mogadishu in Dusamareb, an upcountry town in Central Somalia, an agreement was signed on September 17, 2020, paving the way for an indirect election to be held in the Horn of Africa nation in 2021.

However, squabbles emerged when the parties started to discuss on how to implement the agreement, particularly when Puntland's leader Said Abdullahi Deni and Ahmed Mohamed Madobe of Jubbaland opposed Farmaajo's position.

A number of attempts to solve the impasse produced no tangible outcomes, even after the Federal Government of Somalia and FMS held meetings in the capital, Mogadishu.

On April 12, a dramatic change occurred when the legislators of the Lower House of Parliament, popularly known as Golaha Shacabka (Peoples' Hall) convened and voted for the extension of Parliament's terms and Farmaajo's ternure, while urging the National Independent Election Commission to hold a one-man, one-vote election in not more than two years.

The move technically abolished the indirect electoral modality enshrined in the September 17 agreement.

The two-year extension granted to Farmaajo immediately generated a heated opposition from Punland and Jubbland as well as other political stakeholders like the Coalition of the (opposition) Presidential Candidates (CPC) that includes former Somali presidents Sharif Sheikh Ahmed and Hassan Sheikh Mohamoud and ex-Prime Minister Hassan Ali

Elders' plight points to need for more systematic reforms

pushed to being become a welfare state on account of the plight underlining the condition of various sections of the population, the latest expression of which came from elders of the city of Dar es Salaam, specifically those who do not live with a viable pension. As most of the population is engaged in agriculture and informal sector activity, elders tend to be dependent on families and wider social amenities, which often reduces them to beggars. This isn't just in seeking medical care where the rule about free treatment is scarcely observed, but even in seeking habitually delayed terminal benefits.


The depth of the crisis can be imagined from remarks by President Samia Suluhu Hassan responding to elders' demand that they receive a minimal pension as it is the case with their Zanzibar fellow elderly citizens. She said that the matter was examined in the past to see how the government could pay 30,000/ per month to each elder and it got cold feet, figuring out how to pay two million elders that sum of money per month, that is, over 60bn/- per month and hence around720bn/per annum. For starters 720bn/was the total amount of local funds in the country's budget in 1998, foreign funds at 400bn/= thus 1.1trn/- total.

While elders are issuing this appeal, and the president says the government will find it difficult to pay 30,000/- to each elder, the leadership of the trade union confederation was asking for 900,000/- minimum wage. Since the government will not be in a position to meet even an additional 100,000/without upsetting its investment

ANZANIA is gradually expectations as a whole, it shows that no welfare gesture is possible on that side either. The elders said they ought to be considered for loans, but adding the group along with women and youths who are struggling to make it in life poses intense difficulties.

What the government is trying to do in that regard is to ensure that free primary and secondary school education remains in place, widen the construction, equipment and staffing of health centres all over the country, and auxiliary programmes like piped water and irrigation projects all over the place. On this basis it is clear that welfare demands are becoming an onerous burden on the shoulders of the government and risk displacing pillars of national unity when the demands get louder. At the same time, efforts to make a living by trade activities yield little, as yields earlier stood on misplaced government expenditure.

That means even traders want a new deal from the government, meanwhile as farmers complain on the lack of markets, while it can't be said that the level of consumption in the country is high enough for us to say we have to rely on exports. The key issue is how to create an adequate internal market for the crops and fruits we produce, for the industries we seek to build so that close to 800,000 people entering the job market each year. That is why reforms that President Samia has promised ought to go far so that land enters into the circulation of money, people wishing their money rise in value in the future scramble to purchase land from peasants, and from hundreds of thousands of urban dwellers. This shall insert large amounts of money into the economy, vastly widening consumption and jobs, and huge




Ethiopia at democracy crossroads ahead of the elections next month

THIOPIA'S Coviddelayed elections take place on 5 June 2021. But the country has a fraught history when it comes to democratic elections. A free and fair election will transform Ethiopia's ossified authoritarian political culture, regardless of whether Prime Minister Abiy Ahmed loses or wins. For the Nobel peace laureate, an honourable loss is better than a fraudulent win.

Ethiopia has a mythical image as an African country not colonised by a European power, except for a brief few years in the late 1930s when it was invaded by Italy. Like all myths, the Ethiopian version is partly valid but conceals much else.

recognised as the leading humanitarian organisation led by volunteers in the country, is legally mandated and capable to provide disaster risk reduction, preparedness, response and recovery services in all branches, guided by the fundamental principles of the International Red Cross.

The International Federation of Red Cross and Red Crescent Societies is the world's largest humanitarian network and is guided by seven fundamental principles: humanity, impartiality, neutrality, independence, voluntary service, universality and unity.

World Red Cross and Red Crescent Day is an annual celebration of the principles of the International Red Cross and Red Crescent Movement. World Red Cross Red Crescent Day is celebrated on 8 May each year. This date is the anniversary of the birth of Henry Dunant, who was born on 8 May 1828. He was the founder of International Committee of the Red Cross (ICRC) and the recipient of the first Nobel Peace Prize.

The idea for an 'annual action that could take hold in the whole world ... that would be a major contribution to peace' was introduced just after World War I. This initiative, known as the "Red Cross Truce", was studied by an International Commission established at the 14th International Conference of the Red Cross.

Ethiopia had a feudal society in which the majority of the population was treated as serfs and subjected to indignities comparable to those characteristic of colonialism. The Ethiopian empire was led by Amhara or Tigray Christian monarchs who treated other cultural groups as savages. Among those subjugated were the Oromos, who constituted the largest cultural group. However, the old order was supplanted when Abiy Ahmed became the country's first Oromo Prime Minister in 2018.

Abiy's Cabinet promised democratic reforms the likes of which Ethiopia had never seen. It allowed all opposition parties to return home and participate in the democratic transformation. In addition, the prime minister signed a peace treaty that ended the bloody frontier war with Eritrea. Abiy was awarded the Nobel peace prize for these remarkable achievements. The challenge now faced by Ethiopia is whether the prime minister and the opposition will be able to maintain the new democracy.

The challenges

The progressive changes were accompanied by divisive political tendencies that fed sectarian ideologies and deepened communal fragmentation. First, the Tigray People's Liberation Front (TPLF), which had dominated Ethiopia since 1991, realised that Abiy would not suffer their manipulation. Consequently, the TPLF retreated to its province, mobilised the population, and held a provincial election not sanctioned by the federal government as the national election had been delayed

for a year due to the Covid-19 pandemic. The election held in Tigray was subsequently annulled by the federal government.

The tension between the government and the TPLF escalated and the Ethiopian Defence Force's main garrison in Tigray was taken over. This caused alarm in Addis Ababa, where it was feared that other provincial elites might follow the example of the TPLF and plunge the country into an existential crisis. The prime minister immediately ordered the defence force to quell the insurrection. Federal forces based in the neighbouring Amhara region mounted a counterattack, which gave the struggle a cultural twist as the Amhara elite had a grudge against the TPLF, which had dominated the country for two decades.

The war escalated and the TPLF used the population as human shields while in some areas the Ethiopian forces engaged in a scorched earth policy. Meanwhile, the TPLF forces fired missiles into Eritrea, claiming that its forces had already entered Tigray. Prime Minister Abiy initially denied all the allegations, but others confirmed the massacre of civilians and Eritrea's intervention. While Tigray was burning, another crisis was brewing in Oromia and other regions. The Oromo political establishment began to fracture shortly after Abiy had become prime minister and the oldest political front, the Oromo Liberation Front, began to challenge his legitimacy and accuse him of hijacking the struggle of the Oromo people. Another major Oromo political activist, Jawar Mohammed, endorsed initially Abiy's leadership, but broke ranks with is very low. Given this tradition,

him and formed an opposition party called the Oromo Federal Congress, while other activists established the Oromo National Congress. Similar centrifugal forces have been at play in other regions, while ethnic-political and regional fragmentation has intensified the mistrust among rival elite factions and increased instability.

A tipping point or a tragedy

The regime claims that it has not stymied the opposition parties from registering their supporters for the vote or to campaign freely, but other sources contest this and critics have registered several concerns. First, they point out that Abiy's party, which controls the regions, is using government resources for the campaign while other parties have to rely on their own means. This gives the governing party an unfair advantage. Second, the opposition claims that, like the old regime, the government is buying votes, particularly in the countryside, as the old regime did. Third, it is believed that the ruling party will rig the election if it feels that it might lose the poll.

Finally, there is growing concern about the effect of the increasingly close relationship between Abiy and Isaias Afwerki, the autocratic Eritrean leader. This bond has led to reasonable speculation that Abiy might be considering the autocrat's three decades tenure rule as a model worthy of adopting.

Since Ethiopia never had a democratic political culture, the idea of compromise is not part of the elite's political imagination. Ethiopian politics is therefore a zero-sum game and trust in the constitution and the justice system

the political fragmentation of regions and communities, and the close association between Abiy and the provincial leaders, the opposition is unlikely to accept defeat in any election.


To assuage the opposition's fears and enhance the credibility of the election, Abiy must seriously engage the African Union and the international community by bringing in as many neutral monitors as possible. Monitors should be present in every region from now until the election is held on 5 June 2021. Their presence will boost public confidence in the poll and ensure that every party has a fair chance of winning.

A free and fair election will transform Ethiopia's ossified authoritarian political culture, regardless of whether Abiy loses or wins. A loss will bring him an enduring historical credit among his people, which is worth more than any Nobel Prize, and historians will count him among Africa's transformational leaders. Such an honourable loss is better than a fraudulent win.

By contrast, a sham win may flatter the egos of aspirant politicians but could be a cataclysmic historical benchmark for Ethiopia. A deceitful win will deepen mistrust among the already fragmented elite and could lead to the country's breakup. A discredited win will require the imposition of authoritarian rule, which will keep Ethiopia in the position which it has been for the past two centuries. The final challenge is the opposition's perverse claim that Abiy's party cannot fairly win the poll, thus pre-empting the will of the people.

Whatever the outcome. challenging times lie ahead.

Hope for rare species as villagers remove invasive umbrella trees in Tanzania

So far, the results are promising. According to Mkongewa,the number of chameleon species in all of the experimental plots has increased from three in 2019 to 24

This includes the East Usambara pygmy chameleon, the Usambara

warbler (Artisornismoreaui). This species lives nowhere else on Earth and, according the International Union for the Conservation of Nature, there are fewer than 250 mature individuals.

Conservationists fear the bird will be silenced forever by the steady march into its territory of invasive umbrella trees. These trees also threaten other local species of endangered birds, reptiles, insects and plants. But now there are glimmers of hope, thanks to a project that has supported local villagers to remove umbrella trees and replace them with indigenous species.

The project was implemented by Nature Tanzania in collaboration with the Tanzania Forest Conservation Group and the village authorities in Mbomole and Shebomeza villages in Muheza district, Tanga region.

Its activities took place in the buffer zone around Amani Nature Reserve, Mbomole village forest reserve and community forests, While the project officially ended in September 2019, activities continue thanks to the villagers' commitment and ongoing support from a local organisation called Amani Friends of Nature.

A spreading problem

The umbrella tree (Maesopsiseminii) arrived in Tanzania in the 1930s, when colonial foresters introduced it in plantations as a timber tree.

It became particularly widespread in the East Usambara Mountains after the Amani Forest was harvested in the 1980s

But large-scale planting created a huge source of seeds and, since then, the tree has become one of the area's dominant species, helped on its way by hornbills and fruit bats that disperse its seeds.

This is a problem for the East Usambara Mountains because they are part of what scientists call a biodiversity hotspot, meaning they have large numbers of species including many that are found nowhere else in the world.

The invasive umbrella trees pose a threat there as they grow fast, outcom-

petenative plants, and reproduce within just a few years. The umbrella tree is especially abundant in the village forest reserves and community forests in the buffer zone around Amani Nature Reserve, as well as on farmland.

It most favours forest edges and open gaps in the forest that result from tree cutting. But by growing in these places, the tree threatens local species that prefer those habitats to life under the forest canopy.

This includes chameleons, insects such as butterflies and the critically-endangered Amani flatwing damselfly, African violets and several endangered bird species.

A 2008 study stated, for example, that the abundance and diversity of bird species were both higher in natural forest than in areas where the umbrella tree was common.

The study said the tree threatened the critically-endangered Long-billed forest

warbler in particular, as the bird favours gaps in the forest that the tree's fast growth rapidly closes.

Other local bird species affected by umbrella trees include the Amani sunbirdand Usambara hyliota, both of which are endangered, and the Uluguru violet-backed sunbird.

Wildlife bouncing back

After the project ended in September 2019, Victor Mkongewa and other local people established a non-governmental organisation called Amani Friends of Nature to continue the work of battling the invasive trees. Under Mkongewa's leadership, the group planted another 700 indigenous trees last vear.

Amani Friends of Nature is also doing censuses of birds and chameleons in the experimental plots, as well as monitoring bird nests in those areas, says Martin Joho, an ornithologist with the organisation.

Joho says this will allow them to assess the impacts of removing umbrella trees and gain a better understanding of the ecology and breeding habits of different species in disturbed and undisturbed

three-horned chameleon and the Giant East Usambara bladehorned chameleon, all of which are endangered species.

The number of bird nests has also increased, from just 2 in 2018 to 14 in 2020. Species nesting in the plots include White tailed crested flycatcher, Collared sunbird, banded green sunbird, Olive sunbird, Little greenbul, Red-capped forest warblerand Sharpe's akalat.

Mkongewa says it is still too early to assess the impact on the critically-endangered Long-billed forest warbler, as the indigenous tree seedlings planted after removal of umbrella trees had not grown mature enough to provide suitable habitat for the bird.

But he says the presence of its close relative, the Red-capped forest warbler, suggests the rarer bird will also recolonise.

"Our efforts over three years to restore natural habitat for critically endangered species and other endemic species have started paying off," says Thomas Peter, one of the farmers from Mbomole village who has been removing umbrella trees. "Natural vegetation and biodiversity have improved and we have managed to see new species, like the four-horned chameleon."

There is still much work to do. Mkongewa warns that if the umbrella trees continue to spread, the Long-billed forest warbler and other rare and endangered species in the East Usambara Mountains will continue to be affected and will ultimately disappear.

But if the Amani Friends of Nature and local communities can sustain their progress, future generations may also hear that metallic peedoopeedoo call and may even catch a glimpse of the elusive bird that makes the call.



This is a wise step to take in the light of the surge of coronavirus infections in those countries. The disease caused by the virus, COVID-19, is ravaging those countries more than other parts of the world.

Medicine Specialities of Nigeria advised the in government to take proactive steps to prevent transmission of variants of the virus from the epicentre of the pandemic. The Presidential Steering Committee on COVID-19 also recommended the travel bans.

Remarkably, Lagos State government is also on alert against the third wave of COVID-19 being triggered the importation of bv mutants of the virus by inbound passengers. It is important that the state government is determined to enforce the federal government's regulations in this respect. Lagos has a long list of countries which are being monitored for the transmission across borders.

From the particular case of India, where a humanitarian disaster looms, Nigeria should learn some urgent lessons.

The unfortunate situation of India has again shown that a country that had displayed remarkable bravery and capacity in the fight against COVID-19 could easily be overwhelmed by the



pandemic.

India is the largest producer of vaccines; but now it does not have enough for its population as unprecedented figures of infections are recorded daily in the country. About 70% vaccines globally are produced in India. The Serum Institute of India (SII) has been producing AstraZeneca vaccine for 64 low-income countries including Nigeria within the framework of the COVAX programme of the World Health Organisation (WHO).

One of the grim implications of the situation in India is that the exports of vaccines to poor countries would be disrupted. The management of the pandemic in those countries would, of course, be negatively affected.

overall medical India's capacity is relatively higher than many third-world countries. Yet medical oxygen has become a luxury in that country. The oxygen cylinders available to patients in critical conditions are not enough. Patients are taken out of the hospitals to join the queue for improvised oxygen cylinders at some production centres.

India has been a destination for medical referrals from Nigeria. In the pre-COVID time, Nigerians who could afford the exorbitant costs sought medical attention in private hospitals and other facilities in India.

The poor members of the Indian society relying wholly on the underfunded public healthcare system are more vulnerable. India spends a meagre 3.9% of its Gross Domestic Product (GDP) on health.

The private hospitals are better developed, offering quality services. But those who lack health insurance cannot afford the huge costs of private hospitals. When public health is underfunded at normal times, the society becomes more vulnerable during epidemics. Little surprise that the India public healthcare has failed to be resilient because it has not been socially equipped for the purpose.

Experts have also explained that age, air pollution and obesity could also be some of the risk factors in India.

So the moral of the Indian COVID story for Nigeria is that the hope on the medical and pharmaceutical options could be dashed because of some insurmountable factors. What is needed in emergency may be unavailable in practical terms.

The country should, therefore, upscale the efforts at prevention.

For instance, if faced with a surge in hospitalisations, Nigeria does not have enough medical oxygen for the patients in critical conditions who may

Universally, a standard cure for the disease is still awaited. Vaccines are available, but the morality of its distribution is questionable. The rich countries seem to ignore the axiom of the pandemic that "no one is safe until everyone is safe." Incidentally, about 20 world leaders echoed this scientifically loaded fact in a joint statement made on March 31, 2021. Yet the myopia of vaccine nationalism is still prevalent among some rich countries. The rich are, of course, reserving the vaccines for their populations. Hence while the United States has vaccinated over 100 million of its population, Nigeria is vet to vaccinate two million of its population. Given the slow rate of vaccination, the journey to the land of herd immunity may be longer than imagined at present.

The matter is made worse by the social viruses undermining the campaign for vaccination. These are the viruses of misinformation, conspiracy theories and vaccine hesitancy. The sociology of vaccination is such a complex one in which even some scientists join in spreading the misinformation to discourage unsuspecting members of the public.

Therefore to avert more deaths in the event of a third wave, Nigeria cannot rely on the capacity for treatment or vaccination. The country's strength should be in prevention by emphasising stricter adherence to the protocols -avoiding crowds, wearing of masks, social distancing, hygiene etc. In the matter of COVI-19, prevention is not only better than cure, it is also cheaper and more readily available. The presidential steering committee and state governments should intensify the campaign for all to embrace the culture of observing the precautions.

Complacency is noticeable on

infections, it is tempting to behave as if the pandemic is over. A few months ago, the figures of infections and deaths were also dropping in India. Today, India reports the highest figures of infections in the world. So the current statistics should not be an excuse to be careless about the virus.

This is no time to lower the guard in the fight against COVID-19.

For Solutions, Look More Inward

Not a few people must have felt the pains of the parents of the 17 students of the Greenfield University in Kaduna. The bandits holding the students captive had threatened to kill them if their parents failed to pay ransom, after they had killed five of their colleagues. Some of the parents of the Greenfield students and those of the Forestry Institute, also in Kaduna, were at the National Assembly yesterday to cry for help.

While the anguish of those helpless parents continued, there were other reports about insecurity from various parts of the country.

It is urgent that the Nigerian state should demonstrate its presence. The public yearning for that presence is palpable. The people need to feel secure for them to believe that the state is present.

It was, therefore, expected that government should engage the people with greater empathy and a deeper sense of accountability. Steps should be taken to keep the public confidence.

Although President Muhammadu Buhari is yet to speak to the nation as many Nigerians expect, the meeting of the National Security Council which began last week continued yesterday and the senate has scheduled a meeting with the service chiefs tomorrow. The House of Representatives tried to calm down those whose children are in captivity.

IMIYU regional commissioner Anthony Mtaka has called on public institutions in the region to ensure that they build the capacity of their employees on the rules and regulations of public procurement to increase efficiency in carrying out their duties.

RC Mtaka (pictured), made the remarks here over the weekend when opening threeday training on public procurement and Tanzania National e-Procurement System (TANePS)

Organized by Public Procurement Regulatory Authority (PPRA), the training brought on board 92 participants from different fields-members of tender boards, heads of user departments, staffs from Procurement Management Units (PMUs), lawyers, internal auditors from all district councils in Simiyu Region.

Mtaka said public institutions have faced many challenges regarding public procurement processes. He said the main reason was that the executives involved in public procurement activities did not have a clear understanding of the rules and procedures for conducting such processes.

"It is very important to take part in this kind of training when you are at work. The challenge is that some government employees, having submitted their certificate and fortunately got a job, then no longer attend any training while at work. This causes a lot of problems in the implementation of projects, as the supervisor or executive of a public institution is not aware of the important things,"said Mtaka.

He called on the region's staff to ensure that they make good use of the training provided by PPRA, to ensure value for money available to projects undertaken in the region aimed at bringing development to the people.

He however directed public parastatals in the region to ensure they provide funds for their staffs who are to attend the Annual Public Procurement Symposium, to be held in Dodoma from May 26-27, 2021 and in Arusha from June 1-3, 2021 as it is a unique opportunity to bring together various public procurement stakeholders to discuss, share experiences, learn and find solutions to the challenges they face.



The UK is one of 28 non-regional members and shareholders of the African Development Bank Group. The report recognises the quality of the UK's engagement with the Bank and acknowledges the Bank's performance in supporting the UK's development priorities in Africa. It also found that the Bank compared well with other development institutions, both in Africa and beyond. Sub-Committee Chair Theo Clarke, said: "Since its inception, the African Development Bank has offered valuable financial assistance to developing countries across the continent."

Dr. Tamsyn Barton of the ICAI spoke positively about the Bank's progress in decentralizing its operations which the UK has encouraged – and about recent policy capacity improvements, as well as the importance of the strong relationships the Bank has established with African governments.

Overall, the report reflects the UK's appreciation on its ability to work with the Bank to deliver funds to all parts of the continent. Debbie Palmer of the UK's Foreign, Commonwealth and Development office said: "We can leverage... funds through our support [for the Bank]. We can reach places that we otherwise may not be able to reach with our bilateral funds. We can support regional investments in the large, cross-country infrastructure projects that Africa desperately needs and that the African Development Bank is investing in."

Through the report, the UK Parliament is encouraging the British government to ensure that it is up to date with capital for the African Development Bank as the UK's "important development partner." It states that one possible action which could improve the prospects for funding African infrastructure is faster disbursement of the African Development Bank's paid-in capital. It notes: "We urge the Government, through its position as UK Executive Director, to consider encouraging this and other possible routes to maintaining financial support for Africa's infrastructure development."

'Covid moment' offers transformation on a plate to advertising industry

he ad industry and the marketing industry as a whole - has a less than stellar track record on the transformation front. A lot of focus has been on shareholding and 'optics'. Shareholding is important but invariably enriches a handful of individuals and optics are entirely the wrong motivation. Looking like you care about having a diverse company is very far away from actually having one.

In some ways, the Covid-19 pandemic and the associated impact on the economy has placed issues of transformation on the backburner for many organisations. As usual, the people who end up carrying the greatest burden of this setback are the very people transformation programmes and laws are meant to help.

Women's careers have been more severely impacted, and many of the worst impacted industries have more female workers. People of colour, who remain poorer within developed countries and fill many of the poorer countries in the world, are more vulnerable to job losses and have less access to medical care. The ability of rich countries to stockpile the Covid vaccine is as vivid an example of inequality as you could hope to find.

But perhaps the most pernicious impact of this pandemic on issues of diversity and transformation is that it is far easier to paint these matters as being of less importance. As with a world war or a huge natural disaster, when people and businesses are fighting for survival, who has time to think about complex, long-term and systemic issues? Equal pay: be glad you're getting any pay! Unfair power distribution: we just need to get things done around here, snowflake.

Time and again when I speak to people of colour in the industry I hear stories about a veneer of change papering over the same iniquity.

And so this "Covid moment" is an important one. It can either take us years back in our efforts to change or it can be the opportunity for change many have been waiting for.

Fluid job market

This is a nice way of saying "a lot of people lost their jobs" last year. In some recent hiring we've done we have been amazed at how many superb candidates there are out there at the moment. For the first time in a very long while it feels like there is some real competition to find work and stay put - at least until the storm clouds pass. This is not only a boon for employers - which it is - but it is also a chance to reshape our staff complements without having to jump through impossible financial hoops or choose from a thimbleful of options.

It's no secret that the pressure to change has created a windfall for certain senior individuals of colour in the industry. The legacy of apartheid combined with a lack of regard for this industry among many black parents has meant older, more experienced black talent has been fairly rare. This has allowed those people of colour who stuck it out in an industry that did everything to break them down to capitalise on that scarcity. There

are some fantastically talented and expert leaders out there, make no mistake, but there are also a lot of people trading on the demographic dividend. That is an obvious consequence of making an arbitrary physical trait - like skin colour - a key part of your hiring criteria.

But things have shifted. As agencies have downscaled, so have many slightly younger people had to search for new roles. These are the next generation of black talent, comparatively plentiful, which means a more normal meritocratic dynamic has kicked in. Thanks to Covid this means the talent pipeline looks a lot closer to the make-up of the South African population. And that is a chance for companies to make meaningful change and for excellent people of colour to snatch up roles as things rebuild.

The new geography

While it's true that quality of internet and computer equipment varies widely, and is linked to affordability, another major change that Covid has brought is to remove the daily commute from many employees' lives. For the people cleaning and making coffee in agencies, this isn't a win. But for anyone who lives far out of Sandton or Woodstock or De Waterkant, the ability to work from afar has been a dramatic game-changer.

It was not uncommon 12 months ago for employees from less fortunate backgrounds (often people of colour) to commute hours into and out of work. This also came with spiralling transport costs, an impact on family life and on psychological wellbeing.

It has proven to many managers and businesses that a talented copywriter or strategist or designer or coder can work from anywhere with an internet line. It has also enabled single mothers and women more generally to balance their parenting commitments and work in a whole new way. Our industry has a chance to lock this in - and in doing so to become an attractive employer of a whole class of fabulous people not having to make insane compromises to work in it.

Following on from what I said above, remote working demands a different model of management, work and accountability. For some, the lack of oversight and communal workplaces isn't working. But for many, this is the flexible, outputsbased, anti-office-politics world they may never have even dreamed possible. It feels like a fairer social contract - no one knows what car you drive, your clothes and appearance matter less, your ability to work the room limited. If the research is to be believed this working model is closer to what many young people want - freedom and a chance to prove themselves on their own terms.

Diversity, ultimately, goes beyond gender and race - although those two domains have needed the most urgent attention. But a workplace, in particular an office, is a petri dish in which discrimination flourishes. Whether it's sexual orientation or introversion or physical appearance or disablement or age, we humans are gifted at othering. In theory, a less physical environment means that's just harder to do.

A much more pronounced version of this is already in play in online gaming where avatars stand in for people of all ages and description and what matters is how you play, not who you are. Work can never be quite so egalitarian but this new style is an improvement.

There are two huge caveats to what I'm saying. First, none of this is to deny the facts I began with. Women, people of colour and poorer people have been hit hardest in this pandemic and for many their lives are not blossoming with opportunity. At best I am pointing to some ways in which we could leave this trauma with long-term improvements. Whether we will or not is uncertain.

South Africa's dual system of government, particracy in confluence with constitutional multiparty democracy, was at the centre of President Cyril Ramaphosa's fables of renewal and resurrection at the Zondo Commission this week.

The inputs revealed that the African National Congress (ANC) accepts that it has committed mistakes of corruption and capture, but that the ANC as a political party is not opening up to public scrutiny of its inner workings in relation to government - even if, in Ramaphosa's words, the way in which the ANC functioned as political party "had an impact on how corruption happened".

Ramaphosa's under-oath evidence at the Zondo Commission of Inquiry shone light, modestly, on questions that have been dogging South African politics for close to two decades. Few of the expositions were new; they tended to offer confirmations of known political praxis. The details nevertheless illuminated the intersection of governing party and government - and how in cases of clashes of interest it has been (and is likely to continue to be) the party that prevails.

Coming from the president of the ANC and South Africa, under oath and under unparalleled public scrutiny, even obfuscated details of South Africa's confirmed dual system of party and constitutional government - which I also detail in my book, Precarious Power - were revealing.

When it came to the interface of party and government, and the shadow ANC structures like the ANC Political Committee (subcommittee to the National Executive Committee) ruling over Parliament,

Ramaphosa laboured to string together words that would not discredit his party. His work as leader of government business at the height of State Capture did not bring him closer to transparency. It was a facilitative, rather than an executive role, he explained. It took deft verbal footwork to answer questions honestly yet remain true to the über power of the ANC, the platform for his own power. Both Deputy Chief Justice Raymond Zondo and evidence leader Paul Pretorius allowed him the leeway.

When it came to the Ramaphosa forte, explanations that a new ANC is rising, he thrived. He recounted the fable of the dying eagle that rejuvenated itself and soared to new heights. He was aided by encouraging questions from Zondo; Pretorius even advised him on intra-organisational discipline and legal matters as they apply to members of volun-

tary organisations.

Ramaphosa fumbled his way through explaining why it took the ANC roughly five years from the time of revelations of Gupta influence in government politics and Cabinet appointments, to the point of the Gupta Leaks, for ANC public representatives to start investigating. Ramaphosa's flashes of discomfort extended into his explanation of vote-buying in the ANC, which entered the Zondo conversation on the back of considering patronage as a distortion of the democratic system. He would merely confess that "we have talked about it". He averred that the ANC's new, streamlined digitised system means membership is no longer subject to human manipulation. He blossomed again when the platform allowed him the space to talk about the political will to rid the ANC of patronage.

Many blank spaces remained after the two days of Ramaphosa's "evidence". A selection of the broad strokes tells the tale delivered by a president who had to be careful not to implicate himself or his party by acknowledging illicit or immoral activities by reference to the specifics of deeds and names.

There was confirmation that members of Parliament are but mere party political agents, subject not to the will of the people but to the ANC's Political Committee. This committee controls, among others, the caucus, chief whip and the speaker. It is the political party that interprets how the will of the people will be represented in Parliament. Individual MPs are only to use their own consciences in rare cases. Ramaphosa confirmed that the ANC MPs, along with other ANC deployees, pay their monthly portion-of-salary contributions to

their deploying agent, the "cash-strapped" ANC.

The ANC party politically has been benefiting from contributions from several state-owned enterprises (SOEs), including Telkom and Prasa. The president's response was, "I agree, that should not happen" (unless money is given across the board to all political parties).

Before Ramaphosa's appearance, the commission had heard a mass of testimony that the SOEs had been captured thoroughly and their states of disrepair and distorted finances probably rendered them cash cows for a hungry ANC. Their board appointments were patronage machines. The president acknowledged that "some things happened". He added that there had been "massive system failure".

On both days of his testimony the president referred to the new Political Party Funding Act as revolucursions into the state coffers. The president explained the delay in promulgating this act - from adoption by Parliament in 2018 to his signing it in 2019 and promulgating it, finally, in 2021 - in terms of intra-ANC and interparty consultation and persuasion processes that had to run their course. He reckoned this act "will save our democracy".

Indirectly the ANC had accessed funding via procurement processes that offered massive gratitude donations. Bosasa was a case in point. The president opined that everything is wrong if a business wants something in return for a state contract, and that it is "a matter that should make us take a second look".

The ANC president conceded that the ANC's functionaries in the time of election campaigns knew that the ANC elections war room was a Bosasa project, but implied that this reality had passed him by. "It never really fully occurred to me" (that Bosasa was funding ANC election campaigns). He added: "I should have been aware." Bosasa, according to Ramaphosa, was "one of those anomalous" happenings.

The Gupta wedding plane landing at Waterkloof "raised eyebrows but it happened and that is how it happened". He agreed that the Guptas donated to the ANC, but was uncertain whether they had funded the ANC's 2012 Mangaung conference – the event that launched his ascendancy into the presidency.

AFA keeps tough terms on Tanzanian maize despite Uhuru directive

NAIROBI

Kenya is yet to relax strict conditions that it imposed on maize coming in from Tanzania even after President Uhuru Kenyatta issued a two-week ultimatum to have stocks held at the borders cleared.

A day after Mr Kenyatta directed Agriculture Cabinet Secretary Peter Munya to ensure speedy clearance of the stocks, sector regulator Thursday issued a statement highlighting the conditions that will be adhered to before clearing the maize.

Agriculture and Food Authority (AFA) said each consignment has to meet the maximum permissible aflatoxin levels of 10 parts per billion, a basis upon which maize from Tanzania and Uganda were barred from entering Kenva.

The guidelines also comprise other stringent requirements such as registration of all importers through the AFA's IMIS system and presentation of a copy of the certificate of registration to the inspector at the border point.

These requirements look set to further delay the clearance of the stocks at the border and test the newly refreshed Kenya-Tanzania ties.

"It's been hard for us to stop this malpractice," he lamented while urging NEMC to come down hard on the defaulters.

African leaders seek vaccine-making sites

Rwanda, South Africa and Senegal are among countries calling for the establishment of full vaccine-manufacturing plants to prepare for future pandemics after Africa found itself at the back of the queue for Covid-19 shots.

While many developed nations are well advanced with their vaccination rollouts,

most African countries are almost out of initial supplies and the continent accounts for just 2% of global administered shots, data from the Africa Centers for Disease Control and Prevention show.

There are fewer than 10 vaccine manufacturers in Africa, based across Egypt, Morocco, Tunisia, Senegal and South Africa, according to the World Health Organisation.

And most of those carry out packaging and labeling rather than manufacturing. That makes the continent illequipped to source and supply doses in times of crisis, as this pandemic has demonstrated. "The only way to ensure

vaccine equity is to produce more vaccines where they are needed," Rwanda President Paul Kagame said this week. "So long as Africa remains

dependent on other regions for vaccines, we will always be at the back of the queue whenever there is scarcity."

Among the biggest barriers local manufacturing to intellectual-property are protections. Almost 100 developing countries led by India and South Africa have petitioned for a waiver and the sharing of recipes for Covid-19 doses, but that's been

opposed by some nations and the drugmakers themselves. The US unexpectedly changed its stance to back the proposal this week, opening the door to negotiations between members of the World Trade Organisation.

"is The campaign understandable given past and present experience of waiting in line to get life-saving medications and vaccines,"

Ngozi Okonjo-Iweala, directorgeneral of WTO, said at a conference last month. WTO members "must increase vaccine production now and also look for pragmatic outcomes" to the intellectualproperty protection issue.

Vaccine manufacturing both significant needs financing and specialised skills to build factories that can be certified as free from

contamination, said Stavros Nicolaou, chairman of South Africa's local pharmaceutical manufacturers industry association. "These skills and expertise are in limited supply on the continent," he said. "It is possible to build further filland-finish capacity, but this requires local manufacturers having guaranteed off-takes and ongoing demand."

Fintech bright spot Africa catches up in bumper funding year

Fintech companies in Africa raised more capital despite the Covid-19 pandemic, standing in contrast to their emerging-market peers such as Latin America that saw a decline.

The continent saw fintech funding, including mergers and acquisitions, grow to \$1.35 billion last year from \$1 billion in 2019, according to a report by BFA Global's Catalyst Fund and Briter Bridges published on Thursday. While Indian and Latin American fintech companies still raised more money than those in Africa, their volumes fell from the previous year as they battled to close later-stage deals.

"The numbers of pre-seed and seed deals in Africa are increasing," the report said. "While Latin America and India are seeing a growing number of mega-deals African markets are only beginning to see a few such late-stage deals."

Investors also see opportunity among its large unbanked population of 350 million, which accounts for 17% of the global total. Most investments on the continent flowed to Nigeria, Kenya and South Africa, according to the report, which surveyed 177 startups and 33 impact investors across emerging markets.

Growing interest

The region's fintechs haven't yet raised funding through an initial public offering but they have enjoyed fast growing merger-and-acquisition activity, with international companies including Visa, Network International Holdings and Stripe growing their interests in the region.

Nigeria has especially benefitted from the financial-technology boom that has put much of Africa at the cutting edge of the revolution in mobile money. In 2020, Stripe paid \$200 million (R2.84 billion) to acquire Nigerian startup Paystack.

Flutterwave, based in Lagos and San Francisco, raised \$170 million this year, becoming Nigeria's second fintech startup with a valuation above \$1 billion, after Interswitch. Of the \$105 billion received by fintech firms in 2020, \$76 billion flowed to the US.

In Latin America, Brazil, Mexico, Uruguay and Colombia made up 99% of regional fintech investment, while India, Singapore and Indonesia were the most popular destination for funds in South Asia and Southeast Asia. India netted \$3 billion for fintechs alone.

EcobankTanzania allocating 10pc of commercial loans to women-led businesses

FEMALE owned and led businesses are a target of Ecobank Tanzania's recently launched flagship 'Women's Programme Ellevate' to empower them with financial and value-added solutions that will help their businesses reach full potential.

Ecobank Tanzania's Managing Director, Charles Asiedu said in Dar es Salaam last week that the growth of women-led and women-focused businesses have been long hampered by a range of impediments, including access to finance.

"We have specially designed Ellevate to meet the needs of women entrepreneurs through the provision of comprehensive, customized and tailor made solutions which include favourable lending rates, smart cash management enablement and a suite of value-added services such as leadership training, mentoring and networking opportunities," Asiedu said adding that the bank is allocating a minimum of 10 percent of its commercial banking loan portfolio to women's businesses.

He said small and mediumsized enterprises (SMEs) account for about 90 percent of all businesses in Africa and women own about a third of all registered African SMEs with one-in-four (25.9 percent) of adult women in Africa start or manage a business. Asiedu further noted that however, women have not enjoyed equal access to high quality, demand driven financial services and it is estimated that women-owned SMEs face a US\$42 billion financing gap. "Women-led businesses are a largely underserved market and Ecobank Tanzania is determined to help them reach their potential, grasp business opportunities and become both scalable and sustainable," he added.

The Ecobank Tanzania chief further noted that the financing will enable women led businesses play a major role in the country's social and economic development, in addition to creating millions of jobs needed by youth.

US support for vaccine patent waiver sets stage for WTO debate

WASHINGTON

'S support for a waiver of intellectual-property protections for Covid-19 vaccines heads to the World Trade Organisation, setting the stage for potentially thorny talks over sharing the proprietary know-how needed to boost global supplies of the life-saving shots.

"In terms of how soon the WTO can deliver - that literally depends on the WTO members, collectively, being able to deliver," US Trade Representative Katherine Tai said in an interview Wednesday. "I am the first one to admit that what we are leaning into is a process that is not going to be easy."

On Thursday the European Union signalled a willingness to take part in the negotiations, as shares of vaccine makers tumbled in the US, Asia and Europe. "The EU is ready to discuss any proposal that addresses the crisis in an effective and pragmatic manner," European Commission President Ursula von der Leyen told a virtual conference in Florence, Italy. "And that's why we are ready to discuss how the US proposal for a waiver

on IP protection for Covid vaccines could help achieve that objective."

Vaccine makers' shares fell in Europe. The depository receipts of Pfizer Inc.'s partner BioNTech SE dropped as much as 19% in Germany. Together, the companies sell the messenger RNA shot that was one of the first to win regulatory endorsement. CureVac NV of Germany, which is de-

veloping another mRNA vaccine, fell as much as 16%.

The WTO's General Council meets again on Thursday, though any final agreement that drugmakers are likely to oppose may take weeks to hammer out. Tai added that she sees momentum from WTO Director-General Ngozi Okonjo-Iweala "to take this opportunity and see what is the WTO capable of."

In a statement, Okonjo-Iweala called it the "moral and economic issue of our time." The Biden administration will encourage other countries to join its position, Tai said. "We are for the waiver at the WTO, we are for what the proponents of the waiver are trying to accomplish, which is better access, more manufacturing capability, more shots in arms," she said.

The waiver has been opposed by drugmakers, who say the plan is ineffective. They argue that few countries have the capacity to produce more vaccines even if they knew the formulas. Also, there's limited global supply of the materials needed, and building new factories with the necessary technology to produce the vaccines could take years, they say.

"This change in longstanding American policy will not save lives," said Stephen Ubl, the president and CEO of PhRMA, the biopharma industry's lobbying

group. "This decision does nothing to address the real challenges to getting more shots in arms, including last-mile distribution and limited availability of raw materials. These are the real challenges we face that this empty promise ignores.'

India and South Africa, two nations struggling to contain fresh outbreaks of Covid-19, have been urging WTO members to temporarily suspend rules on IP rights, arguing that it would be the most efficient and equitable way to address vaccine shortages in poor countries. "We will be exercising our

convening power at the WTO to bring members together to work towards resolving the different viewpoints to bridge the gap so that the WTO can be relevant, the WTO can be a force for good," Tai said.

Other holdouts

The US wasn't the only country with reservations about the waiver. The EU, UK, Japan, Swit-

zerland, Brazil and Norway have also resisted the push. However, supporters of the waiver argue that US leadership on the issue could help sway other holdouts. The timing for approval of the waiver depends on how soon member states can find agreement.

"Given what is at stake, this is the best chance for the WTO to be able to come together to deliver something that is going to help people and make a difference," Tai said. As the US inoculations advanced and outbreaks diminished in recent weeks, the White House came under pressure from progressive Democrats and public-health advocates to take a stance while India in particular suffers from surging deaths and infections.

While inter-agency discussions were ongoing, Tai also met with top executives of vaccine-producing companies and held calls with members of Congress and other stakeholders in civil society and public health.

ECB's Christine Lagarde sounds alarm over use of cryptos for laundering

FRANKFURT

European Central Bank chief Christine Lagarde sounded the alarm over the use of cryptocurrencies for money laundering on Friday as she backed the adoption of digital currencies by central banks.

The ECB president said people were taking a "real risk" by buying cryptos with her comments coming a day after Bank of England governor Andrew Bailey warned investors to buy cryptos only "if you're prepared to lose all your money."

"Cryptocurrencies - these two

While central bank digital currencies, or CBDCs, are not yet in widespread use, more than 60 central banks are now exploring or developing CBDCs, PricewaterhouseCoopers said. Central banks, including the ECB, aim to use the flexibility of digital cash to improve payment systems, ease some of the complexities of negative interest rates and ensure they don't cede too much control to digital currencies. However, the scope and scale

of central bank digital currency research varies from country to country. While The People's Bank of China is in advanced stages



things don't go well together and I totally agree with Andrew Bailey's conclusion in that respect," Ms Lagarde told a virtual webinar, hosted by the European University Institute, in which she quoted the BoE governor.

"There are crypto assets which people are free to invest in and take full risk into and there are particular cryptos that are, in my view, prone to money laundering activities - it's a real risk that people are taking."

Central banks and governments around the world are becoming increasingly concerned over the use of cryptocurrencies for money laundering, financing terrorism and other illegal activities. Bitcoin and Ethereum, the two biggest cryptocurrencies, surged to record highs this year as institutional investors piled into the digital asset space encouraging retail investors to follow suit.

Meanwhile, Meme-based virtual currency Dogecoin soared to a new high this week, extending its 2021 rally to become the fourthbiggest digital coin. Ms Lagarde said crypto assets had nothing to do with stable coins or the digital currencies being considered by central banks, such as the digital euro.

of testing a digital yuan that would be used by individuals and businesses, the Bahamas has a fully working, digital 'Sand Dollar' and Sweden could have a digital currency within five years.

Last month, the BoE pledged to team up with the UK Treasury to examine the potential creation of its own digital currency. Meanwhile, the ECB recently completed a public consultation on a digital euro, with privacy the number one factor demanded by Europeans, followed by security.

The United States decided to quit the Paris Agreement in June 2017 and formally withdrew from the climate change deal on Nov 4, 2020, making it the only nation among nearly 200 signatories that has abandoned this global agenda on combating climate change.

Sinopharm's vaccine is the first COVID-19 vaccine developed by a developing country that has been validated by the WHO, and the sixth vaccine that has been approved for emergency use globally.

Ghebreyesus said the WHO has included this vaccine on the emergency use list because of its "safety, efficacy and quality."

EU tells Biden to export vaccines now, worry about IP later

LISBON

EUROPEAN Union leaders urged US President Joe Biden to lift restrictions on exports of COVID-19 vaccines to address the desperate needs of developing countries before embarking on complex discussions about whether patent waivers might also boost supply in the longer term.

Gathering in Porto, Portugal on Friday and Saturday shortly after the US suggested suspending intellectual property rights to boost the supply of COVID-19 shots, German Chancellor Angela Merkel, French President Emmanuel Macron and Italy's Mario Draghi appealed in unison to the US president to fol-

low the EU example and start shipping significant numbers of vaccines. They argued that any patent waiver will only increase supply in the long term and the world needs a faster solution.

"I hope that now that large parts of the American society have been vaccinated we will come to a free exchange of components and opening of the market for vaccines," Merkel told reporters in Berlin after dialing in remotely to the summit talks. "Europe has always exported a big part of its production to the world and that should now become the regular case.'

"It was a car bomb blast that occurred in front of the school entrance," an eyewitness told Reuters, asking not to be named. He said all but seven or eight of the victims were schoolgirls going home after finishing their studies.

At the Sayed ul Shuhada high school, girls and boys study in three shifts, the second of which is for female students, Najiba Arian, spokeswoman for the Ministry of Education, told Reuters. The wounded were mostly female students, she said.

A spokesman for the interior ministry, Tariq Arian, said the death toll was at least 30 with 52 injured.

At a nearby hospital, staff wheeled in injured students while dozens of distressed relatives searched for their sons and daughters, according to a Reuters witness.

"I do not know what country we are in ... We want peace and security," a grieving relative of one of the victims told Reuters.

Kabul has been on high alert since Washington announced plans last month to pull out all U.S. troops by Sept 11, with Afghan officials saying the Taliban have stepped up attacks across the country following the announcement.

Libya armed groups raid hotel where presidency met

ARMED groups in Tripoli on Friday stormed a hotel where Libya's new Presidency Council meets, the council's spokeswoman said in a social media post, underscoring the continued risks to the unity government.

Unverified images on social media showed armed, uniformed men standing at the entrance to the Corinthia Hotel, but Presidency Council spokeswoman Najwa Wahiba said nobody from the council was in the building.

The groups have voiced anger at the Government of National Unity's Foreign Minister, Najla el-Mangoush.

The Presidency Council, which functions as head of state, was chosen through a United Nationsfacilitated process that selected a new Government of National Unity that took office in March, replacing rival administrations in east and west.

Unity Prime Minister Abdel Hamid Dbeibeh has worked to win support from Libya's many rival factions, forming a large cabinet that included an array of ideological and regional figures.

However, both the Presidency Council and Government of National Unity have faced both internal criticisms and challenges to

their authority.

In eastern Libya, commander Khalifa Haftar and his Libyan National Army (LNA) still hold sway nearly a year after their 14-month offensive to seize the capital collapsed.

Foreign mercenaries remain entrenched on both sides of the heavily fortified front line, despite international calls for the warring sides to pull them from the country.

Last week, Foreign Minister Man-

goush repeated the call for all foreign fighters to leave while standing next to visiting Turkish Foreign Minister Mevlut Cavusoglu.

Turkey says its military presence in Libya is different to that of other foreign forces because it was invited by the previous UN-recognised government and it will not withdraw until others do.

Before the hotel was stormed on Friday, an operations room for the Tripoli armed groups said on social media that it had met to discuss "irresponsible statements" by Mangoush and later called on the GNU to formally reject Haftar.

Indian states impose stricter lockdowns as deaths hit record high

NEW DELHI / YANGON

INDIA on Saturday reported its highest ever single-day COVID-19 death toll, as cases continued to rise and states imposed stricter lockdowns.

India's health ministry reported 4,187 fatalities over the past 24 hours, taking the overall death toll to just under 240,000. Cases rose by 401,078, increasing the total since the start of the pandemic to 21.9 million.

Tamil Nadu, known for its automobile manufacturing, said it would move from a partial to a full lockdown on Monday, stopping public transport and shutting state-run alcohol retailers.

Neighbouring Karnataka state extended a total shutdown late on Friday. The state capital Bengaluru is a major tech hub, home to major offices of companies.

While cases in the country's northern and western areas have borne the brunt of the pandemic, southern states including Karnataka and Tamil Nadu have seen infections surge.

Sri Lanka

Sri Lanka on Saturday approved Pfizer's COVID-19 vaccine for emergency use in Sri Lanka, as the island nation battles a third wave of the virus, while suffering a restricted supply of vaccines from neighboring India.

Dr. Sudharshani Fernandopulle, the minister overseeing the fight against the epidemic, said in a statement the government would order 5 million doses of the Pfizer vaccine.

The island nation reported 1,914 new cases and 19 deaths in the past 24 hours, according to federal health data, and its total number of active cases is higher than any point since the pandemic began. Infections surged after crowded celebrations for traditional New Year last month.

THE inaugural China International Consumer Products Expo (CICPE) kicked off on Thursday in Haikou, capital of the southern island province of Hainan, pooling global highend consumer brands to tap into the second-largest economy's market potential.

Chinese President Xi Jinping sent a congratulatory message to the



unilateralism, and protectionism sentiments are rising, the very first China International Import Expo (CIIE) is witnessing the strengthening of business ties and increasing support for free trade.

Held in 2018 in Shanghai, the first CIIE attracted the participation of more than 3,600 companies from 172 countries and regions, with intended deals worth 57.8 billion U.S. dollars. At the expo, China announced a slew of opening-up measures, including further cutting import duties, relaxing market access for foreign investment, and implementing the system of pre-establishment national treatment plus a negative list, which have all taken place.

New Zealand will lift its partial suspension of a "travel bubble" with Australia from midnight on Sunday as fears of a COVID-19 outbreak in Sydney eased.

New Zealand had blocked travel to and from New South Wales, Australia's most populous state, on Thursday after a couple in Sydney with no links to high risk professions or people tested positive for COVID-19.

The cases prompted a reinstatement of some social distancing measures around Sydney, and a campaign to get more people tested, as authorities scrambled to determine the source of infection.

However, state health officials on Saturday reported a second straight day without a new case, allaying concerns about a wider outbreak in the city.

Meanwhile, New Zealand recorded three new cases of COVID-19 on Saturday, said the Ministry of Health in a statement.

According to the ministry, the three new cases of COVID-19 were recent returnees in managed isolation facilities, while there was no new case of COVID-19 in the wider New Zealand community.

The total number of confirmed cases of COVID-19 in the country reached 2,284.

Japan

The Japanese government said on Friday that it will tighten restrictions on Japanese nationals and residents arriving here from India, Pakistan and Nepal, amid concerns over highly transmissible virus variants wreaking havoc, particularly in India.

The stricter measures will come into effect from Monday, the government said, and will involve requiring passengers arriving from either of the three countries to stay in quarantine facilities designated by the government for six days.

Israel faces widespread criticism over Al-Aqsa mosque clashes

ISRAEL faced international criticism after clashes between police and worshipers at the Al-Aqsa mosque following protests over the potential eviction of Palestinians from a neighborhood in East Jerusalem.

The clashes continued Saturday night, the holiest night of the Muslim holiday of Ramadan.

Bahrain and the United Arab Emirates condemned Israel earlier Saturday. And envoys from the so-called Middle East Quartet said they're closely monitoring the situation and had "serious concern" about the possible evictions inflaming an already tense environ-

ment.

"We call upon Israeli authorities to exercise restraint and to avoid measures that would further escalate the situation," the envoys said in a joint statement. The Quartet is made up of nations and international entities involved in mediating the Israel-Palestinian peace process, including the EU, Russia, the US and the United Nations.

Separately, the US said late on Friday it was "extremely concerned about the ongoing confrontations in Jerusalem," noting that they've resulted in "scores of injured people."

"We call on Israeli and Palestinian officials to act decisively to deescalate tensions and bring a halt to the violence," State Department spokesman

EFUSAL by officials of Yanga to put the team on the ground following a rescheduling of the much awaited city derby with archrivals Simba SC was a massive letdown for millions of fans in the city and around the country waiting for the duel.

Many radio stations in the city had little else to talk about since early hours of the morning if not indeed all of the past week, which was driven to an anti-climax when it was belatedly discovered that the fixture would mess up a presidential function in the city.

It was the launch of a book on the life second phase President Ali Hassan Mwinyi, and the President could not be available before 4pm or thereabouts, and the function crossed the half hour into the game fixture.

There are several points of debate which were being raised by pundits at the material time, first the fact that it was the ministry responsible for sports that raised the issue of rescheduling the match to a late start.

It appears that this gave the Jangwani Street side its battle horse, that it was a sporting decision rather than a political one, as it wasn't announced by the police or central government beyond the sports hierarchy, and presumably that includes the ministry.

This cancellation of the match was another occasion of pretending not to have understood why the match should be pushed forward, where there are no relevant technical reasons

One explanation if that the pre-match meeting had already set out all arrangements, for instance if players will be returning to their hotel camps by 8pm and the dinner be ready within half an hour or so, and all of a sudden this is pushed to two hours later due to the ministe-

rial directive.

Yanga pundits kept reading the matter in a sporting modality rather than its political side, in that by its very nature it couldn't have been predicted the President was going to be too busy to be present at the function by say 3pm so as to allow the fixture to proceed by 5pm.

There is another argument by Yanga pundits that at any rate the match had nothing to do with the book launch event, and thus no reason can be forwarded to justify pushing forward the match starting hour.

This is at best a sort of ingenuity, as the club knows like everyone else that when it comes to the two city giants meeting, there is no serious public function that could be going on and be taken seriously, as all ears and eyes would be on what is happening on the ground.

There is no question that having the derby starting at a moment that the function was scheduled to be continuing would disrupt it mentally from the start, as concentration would be directed to when the match starts, who is on the lineup, who are the match officials and the sort.

This may even have been noticed and thus belatedly canceling the 5pm start.

There is another aspect that may also come up but it isn't yet visible, that there is a relaxed political atmosphere which enables different stakeholders to test the depth of the water in various areas.

It was a point raised at the book launch, when one opens windows, it isn't just fresh air that enters. Flies, too.

Five-star Flick raises the bar for next Bayern coach Nagelsmann BERLIN

HANSI Flick landed a ninth consecutive Bundes liga title for Bayern Munich on Saturday, but his youthful replacement Julian Nagelsmann has already been warned what to expect as head coach of next season's new-look squad.

Bayern secured the Bundesliga title before they even kicked a ball on Saturday.

Borussia Dortmund's 3-2 win over second-placed Leipzig sent the title back to Munich ahead of Bayern's evening home game against Borussia Moenchengladbach.

Flick will sign off with the 56-year-old the hot favourite to succeed Joachim Loew as Germany's next head coach after this summer's Euro 2020 tournament.

He won seven honours in his 18 months in charge, including two Bundesliga titles and the Champions League.

Flick also became the first Bayern coach to win all six available titles available from one season in 2019/20.

Bayern have lost just eight matches under Flick in all competitions.

His record raises the bar high for Nagelsmann, who at 33 has forged a reputation as one of Germany's best young coaches.

It will cost Bayern 25 million euros (\$30 million) to buy Nagelsmann out of his contract at RB Leipzig. who he steered to last season's Champions League semi-finals.

Nagelsmann stands to reportedly earn around eight million euros (\$9.7 million) for each year of his Bayern contract, which runs until 2026.

However, his first task next season will be to win over stars like captain and goalkeeper Manuel Neuer, who is two years older than his new head coach.

- Beckenbauer warning -

Even top scorer Robert Lewandowski is only a year younger than Nagelsmann, who has already received a blessing from a Bayern legend.

"Bayern have made a good choice there. Definitely," said the club's honorary president Franz Beckenbauer.

However, the 75-year-old warned, "It's clear that the team will test him. That's just the way it is. He knows that. He has to be prepared for that."

From next season, Bayern can wear a fifth star on their shirts having now won 30 titles since the Bundesliga started in 1963/64.

The Bavarian giants have been German champions 31 times, but their first title win, in 1932, came in the pre-Bundesliga era.

As well as a new star above their badge, there will be a new coach at the helm.

At 1.90m (6ft 3ins), Nagelsmann makes his presence felt on the sidelines and will not be afraid of ruffling the egos of Bayern's stars.

During matches played behind closed doors due to the Covid-19 pandemic, Nagelsmann's voice can often be heard barking instructions at his players or remonstrating with the referee.

Real, Barca, Juventus defend Super League in face of UEFA 'threats'

MADRID

REAL Madrid, Barcelona and Juventus on Saturday defended the aborted Super League project in the face of "threats" from UEFA.

The three clubs are the only ones from the original 12 yet to renounce the proposed competition that would guarantee its founding members involvement every season, instead of having to qualify.

The nine clubs who have dropped out -- Tottenham, Arsenal, Manchester City, Manchester United, Chelsea, Liverpool, Atletico Madrid, Inter Milan and AC Milan -- were on Friday given a financial penalty by UEFA for their involvement.

UEFA also said it would take "appropriate action" against the three clubs who still support the Super League project.

In response, Real, Barca and Juventus said in a joint statement "the founding clubs have suffered, and continue to suffer, unacceptable thirdparty pressures (and) threats.'

"This is intolerable under the rule of law," they added in a joint statement.

They said the Super League had been launched "with the aim of providing solutions to the current unsustainable situation in the football industry".

The Super League was announced on April 18 but two days later it collapsed as the six Premier League clubs withdrew after angry protests from supporters pressure from the British government.

Sports analyst, Michael Msemakweli, said TFF should be blamed for causing the match postponement.

"The rules are clear that if there is a change of time, stakeholders in this case are Simba and Yanga, and should be consulted and the decision announced before 24 hours of playing," he said.

He said what happened on Saturday is unacceptable, inconceivable and painful to Tanzania football in a good and acceptable the postponement of the and he suggested that TFF should bear the costs.

"People paid their hard earned money to watch the highly publicized derby, but without having any iota of shame and fear, someone decided to postpone the game, TFF has to pay back the money," he said.

He also advised TFF to be open on why the game's kick off time was shifted without following proper rules.

He opined: "Maybe the game playing time was shifted from the initial 5pm to 7pm due to some serious security issues, but TFF should have consulted clubs and inform the public

manner."

He disclosed: "I'm sure if TFF used the clubs to communicate to their fans, people would have waited and watch the game."

Other respected football pundits, Edo Kumwembe and Oscar Oscar, also took to their social media pages to accuse TFF for failing to act professionally and in accordance with the rules.

Meanwhile TFF through its information officer Clifford Ndimbo yesterday issued a media statement, saying the federation has directed Tanzania Premier League Board (TPLB) to come up with a complete report on what led to match.

The federation also called for patience among soccer lovers as they are working hard to establish the root cause of the postponement of the match.

The TFF moreover said they will engage Simba and Yanga to have their views.

The Saturday clash was expected to be a battle of tactical superiority.

The two sides are separated by four points at the top of the 18-team league table.

Simba are positioned at the summit with 61 points from 25 matches, while Yanga are placed second with 57 points from 27 matches.
