## TRA: Stop EFD inspections, no arrests

"Experts of Tanzania Bureau of Standards (TBS) and TRA together have been directed to complete the revision of the information technology system by end of July"

THE Tanzania Revenue Authority (TRA) has been instructed to suspend all operations involving arresting traders as well as put on hold inspections on electronic fiscal device (EFD) receipts for at least one month.

Thobias Makoba, the chief government spokesman, said late yesterday that this was the first point in 15 resolutions from the meeting between the government and leaders of traders associations.

The resolutions directed at the revenue authorities for compliance, came in the wake of a countrywide stoppage of wholesale businesses in key urban centres, and took up previous negotiations and unfinished business especially

with Kariakoo traders, the nerve centre of wholesale business.

The government has halted an exercise to inspect electronic fiscal device (EFD) receipts all over the country as it works on good procedures to use such devices.

Prime Minister Kassim Majaliwa headed the government team after the Treasury had earlier rejected demands to stop EFD receipt inspections saying the system was working as expected.

The talks were held intermittently for four days, where the traders submitted 41 substantial complaints, and in the wake of an inconclusive dialogue with responsible ministers, namely for Finance, Plan-

The government has thus instructed TRA to work out and present an improved system to facilitate issuance of purchase documents for importation of goods, starting from the new financial

The traders have been instructed to present three monthly reports on implementation of the agreed resolutions, contrary to the past where government instructions remained a dead letter.

The TRA has also been directed to invest efforts in a public awareness drive on tax issues, legal requirements for traders and the public at large, also preparing a list of eight products liable for indicative prices as in used car products, he stated.

The products are printed fabrics, shirts, other clothes, cosmetics, precious stones,

## Ministry sets graduate teachers' skills testing

STRICT measures of competence will from next year be conducted on graduate teachers for years waiting to join the public service.

Prof Adolf Mkenda, the Education, Science and Technology minister, made this observation at the 2024 English digital teaching skills competition among primary school teachers in Dar es Salaam late on Tuesday.

He said that the teachers will have to go through special recruitment interviews in the wake of a new recruitment procedure, with the interview method meant to select the best

Their skills will be aligned with global standards acceptable in developed countries as the framework for the provision of quality educa-

response to criticism of the current employment system.

Successful applicants report directly to schools, a method criticized for inefficiency in hiring incompetent teachers and its susceptibility to favouritism, he said.

The new measure starting early will see all teacher candidates undergo testing, including those who have been waiting for employment for years. The latter group needs to continually update their skills and knowledge to excel in the interviews, the minister stated.

The government has invested efforts to transform the education sector, with reforms in policies, laws and curriculum, in-

## 'RCs should not wait for state intervention'

REGIONAL commissioners must adopt appropriate leadership models of solving problems facing the public and not wait for interventions from above, the President's Office has instructed.

Mohamed Mchengerwa, the Regional Administration and Local Governments state minister in the President's Office (PO-

RALG), issued this directive when launching the regional and local governments strengthening programme (RLGSP) here yesterday.

"You have been entrusted by the president to lead the regions, and thus you must trust yourself and take sober decisions and actions in solving all problems that are

brought up," he said. He reminded the key administrators that President Samia Suluhu Hassan was injecting large amounts of money to support different socioeconomic sectors in all regions, and thus it is prudent for leaders in local governments to ensure the patriotic use of the funds.

## **Mwinyi** launches oil, gas storage

ZANZIBAR President Dr Hussein Ali Mwinyi has indicated that Zanzibar can sell oil and gas products to needy countries in the neighbourhood.

Gracing the inauguration of the first liquefied petroleum gas (LPG) terminal at the port in North Unguja Region, the president urged companies to chip in and build more supporting infrastructure including oil and gas depots at the port.

The Oryx Energies terminal will facilitate LPG supply in a reliable and seamless manner to the Zanzibar population, he said, highlighting wider use of the new port facilities.

The government expects to see enough oil and gas storage reserves for sale to firms that can use Zanzibar port instead of going abroad, based in nearby countries.

Gas firms need to put in place robust strategies to help reduce costs of gas in order to enable people to access the product easily, he said, noting that the

Mangapwani area is designated as a new oil and gas tank farm for loading and transfer of fuel and gas products.

It is important for stakeholders to back the efforts by constructing enough storage terminals, he said, elaborating that Mangapwani Port needs involve the con-

struction of berths for liquid bulk goods, containers, fishing vessels and natural gas offshore services.

There will also be backup infrastructure for the rehabilitation of marine vessels, he said, seeing it as a solution to the problems at Malindi Port, while the new terminal enables big ships to dock and spend a short time offloading.

The terminal will stimulate the use of clean cooking energy to help achieve the pivotal goal of bringing 80 percent of households to use clean energy by 2032,

Benoît Araman, the Oryx Energies (T) managing director lauded the Zanzibar authorities for creating a good environment for doing business, in solving challenges faced by businessmen. This is illustrated by making the Mangapwani first LPG terminal a success, he said.

The terminal commenced operations early last month, with the capacity to store 1,300 tonnes of LPG, receiving its first shipment of 1,200 tonnes on May 2.

Tanzania's gas market has witnessed an increase in imports from abroad by more than ten times in the past decade, from

## One-third of adults globally not amply active physically, at big risk of disease

A NEW study has found that nearly one-third (31 percent) of adults worldwide did not meet the recommended levels of physical activity in 2022.

This puts them at greater risk of cardiovascular diseases such as heart attacks and strokes, type 2 diabetes, dementia, and some

It also has a negative impact on mental health and wellbeing.

In addition, the study by the World Health Organization together with academic colleagues, found that levels of inactivity continue to rise.

The authors say the findings show a worrying trend of adults becoming less physically active, with this trend increasing by about 5 percentage points between 2010 and 2022.

If this continues, countries will not meet the global target to reduce physical inactivity by 15 percent by

"We must renew our commitment to increasing levels of physical activity and prioritizing bold action, including strengthened policies and increased funding, to reverse this worrying trend," said WHO Director-General Dr Tedros Adhanom Ghebreyesus.

People are least active in the eastern Mediterranean region and South-East Asia, with levels of physical inactivity in these both regions at 40 per cent.

In contrast people are much more active in other regions, with levels of inactivity in the Western Pacific region (28 percent), European region (25 percent) and African region (16 percent).

Disparities also remain between

gender and age, with women and people over 60 generally less physically active.

The WHO recommends that adults have 150 minutes of moderate-intensity, or 75 minutes of vigorous-intensity physical activity, or equivalent, per week.

On a positive note, almost half of the world's countries have made some improvements in reducing physical inactivity over the past decade.

And 22 countries may reach the global target of reducing inactivity by 15 per cent by 2030, if their efforts in reversing the trend continue at the same pace.

The WHO is calling on countries to strengthen policy implementation to promote and enable physical activity through grassroots and community sport and active recreation and transport (walking, cycling and use of public transport), among other measures.

This was said in Dar es Salaam yesterday by ATCL, Managing Director Ladislaus Matindi when he met and held talks with Ambassador of Oman to Tanzania Saud bin Hilal Alshaidani at Oman Embassy offices in Dar es Salaam.

"Air Tanzania has identified the main sales agent to handle ticket sales in Oman and we have already appointed the manager of the centre," he said.

He said that what remains is to complete arranging the crew, the plane that will be used for the route together with other travel arrangements.

Ambassador Alshaidani said that his talks with Matindi were productive, adding they discussed opportunities available in both passenger and cargo handling

between the two countries.

"With the large number of Omani citizens present here in the country and as business between the two countries continues to grow, it is my expectation that Air Tanzania will benefit from this opportunity," he said.

"We can also focus on export of three types of fruits that are in high demand in Oman namely mangoes, pineapples and avocados. This will benefit both sides."

Air Tanzania currently operates domestic flights to more than 10 routes. For regional and international trips it flies to Dubai (UAE), Mumbai (India), Guangzhou (China), Bujumbura (Burundi), Entebbe (Uganda), Hahaya (Comoros), Harare (Zimbabwe), Lusaka and Ndola (Zambia), Nairobi (Kenya) and Lubumbashi (DRC).

## Govt engages two contractors to upgrade Arusha-based TGC

THE government has signed a 33.4 bn/-contract with two local companies for the expansion of the Arusha-based Tanzania Gemmological Centre (TGC) into eight storey building.

Lumocons Company Limited and Skywards Company Limited have entered into agreement with the Ministry of Minerals to undertake the construction within three years starting yesterday.

Speaking after a brief signing ceremony at the ministry's office in Dodoma yesterday, Deputy Minister for Minerals Stephen Kiruswa said the project is aimed at expanding the centre in efforts to offer more advanced courses.

He explained that the government decided to strengthen provision of training at TGC by expanding its infrastructure to produce many graduates with expertise in matters of value addition to gems and metals in the country.

"The government has released 33.4 bn/- for construction implementation activities to start any time after today's signing of the agreement", he said

If this step is completed,

according to the deputy minister, it will enable the centre to provide training at international level and thus enable processed minerals from Tanzania to access foreign markets.

He said that the government's goal in establishing the centre was to implement the Minerals Policy of 1997 and increase the value of minerals in the country by providing training.

Minister Kiruswa said in order to increase the benefits of mineral resources in the country, the government has continued to take various measures in mining activities to create a friendly environment for investors in the country.

He explained that the measures taken have enabled an increase in mineral exploration activities, mining, mineral value addition, and mineral businesses to thrive, thus creating employment and commercial opportunities for Tanzanians.

Speaking about the challenges in the mining industry, he said that the government recognizes the issue of access to capital for establishment of mineral processing facilities and laboratories. contractor, Lumocons Company Limited Director Andrew Shirima thanked the government for having trust in local companies, noting that such massive projects were initially offered to international firms only.



### Local contractors make case for expanded role in big national projects

LOCAL contractors have appealed for the government to increase trust and provide them with more opportunities to participate in various strategic construction projects to bolster employment and development.

According to the Tanzania United Contractors and Allied Services Association (TUCASA), the country has enough and competent contractors as well as engineers who can implement mega projects and at required quality standards.

Samuel Marwa, TUCASA Chairman, made the appeal in Dar es Salaam yesterday during the opening of a two-day annual general meeting of the association.

He said that many local contractors have requisite expertise and have joined forces to form strong companies which are able to implement mega projects but still there is a growing negative attitude which regards local contractors as inferior and incompetent.

"It is not true that local contractors have no competency needed to implement mega projects; we have all the qualities to do so if trusted, many contractors who have been given sub-contracts in mega projects such as the Standard Gauge Railway (SGR) and Julius Nyerere Hydro-Power Project (NJHPP) perform very well," he said.

He urged the government to continue to review laws and policies to facilitate more participation of local contractors in various projects.

He said that the majority of the big tenders are being executed by foreign companies while the country has enough and competent contractors.

According to him, participation of local contractors in big projects has remained low for years, something

which denies locals an opportunity to benefit from skills transfer.

Marwa said that the association wasn't happy to see all strategic construction projects being executed by foreign companies while the country has a number of experts who can produce quality work and contribute to the economic development.

"The government also takes a long time to pay our arrears. This affects us as we find ourselves in a hard situation. Our capital remains the same for years as we are not paid on time thus affecting our relation with financial institutions as we delay to repay loans but we are happy that this year the budget for paying contractors' arrears has increased," he said.

He further urged contractors to join the association because it is important for all constructors to unite and have one voice which will help to make a difference in the construction industry.

Geoffrey Mkinga, Tanzania Rural and Urban Roads Agency (TARURA) Dar es Salaam Regional Manager, said that the agency was finalising steps to sign contracts with contractors to implement road projects under the Dar es Salaam Metropolitan Development Project (DMDP) phase II.

He said that TARURA implements a strategic plan for construction and rehabilitation of roads in the region to guarantee that the roads remain easily accessible throughout all seasons, thereby fostering economic growth and ensuring convenient access to essential social and economic services.

He further urged contractors to always adhere to professional ethics and whenever given tenders, should implement them effectively and efficiently in order to be trusted in future projects.

## Minister defends plan to fund universal health with 'sin tax'

FINANCE minister Dr Mwigulu Nchemba yesterday sought to defend the government's decision to increase taxes on cigarette, betting, alcohol and gambling to raise revenue for the envisaged Universal Health Coverage.

This came after Iringa urban MPJesca Msambatavangu expressed disagreement with the idea, arguing that it is not proper for Tanzanians, including women and children to be treated by money raised through the so-called sin taxes.

Msambatavangu made the argument in the National Assembly when contributing to the Finance Bill 2024 which was read in the house yesterday.

She said it was not ethical for pregnant women to be treated by funds that are generated from alcohol and cigarettes.

"There is no way we should depend on alcohol, cigarettes and gamblers to treat our people; let us look for other channels," she said.

After the request by the legislator, Minister Nchemba called for the speaker's guidance, saying the government's idea behind the proposal was to discourage smoking, alcohol drinking and gambling.

MP for Kalambo Josephat Kandege (CCM) commenting on the same said the government's move to deduct 382/- per kilo of gas discourages efforts by the country to shift to gas usage.

Kandege said gas usage will be beneficial to the country saying introducing the levy to the sector will derail efforts by the country to shift to clean energy.

The legislator advised that all government vehicles purchased henceforth should be converted to natural gas so that the country moves from using foreign currency in purchasing fuel.

Tanzania has suffered significant losses due to illegal fishing, amounting to about 15.2bn/- between 2019 and 2023, according to the latest report by the Controller and Auditor General (CAG).

The report, covering the period 2022/2023, said that most of the illegal fishing activities were carried out using unregistered and unlicensed vessels in the Indian Ocean, as well as Lakes Victoria, Tanganyika and Nyasa.

Auditing the management of fisheries resources in Tanzania, the report reveals that a concerning 72.99 percent of operating fishing vessels in the country are unregistered and unlicensed.

Out of a total of 28,615 vessels engaged in fishing activities across various water bodies in Tanzania, 20,885 vessels have not been registered or licensed, according to the report.

### Govt promises to support growth of financial sector

THE government has expressed commitment to collaborating with the country's banking sector to enhance efficiency in delivering services to the public.

Mohamed Mchengerwa, Minister of State in the President's Office (Regional Administration and Local Governments), made the pledge here yesterday when speaking at the 8th Mwalimu Commercial Bank (MCB)' Annual General Meeting.

Mchengerwa emphasized the government's desire for substantial growth of the country's financial sector, saying: "It's the true partner in the country's socioeconomic development."

In a speech read on his behalf by Iringa Municipality Mayor Ibrahim Ngwada, the minister noted that the strength of banks like MCB would significantly contribute to the nation's economic development and individual prosperity.

MCB has defied the odds in a challenging financial landscape, reporting significant progress and a remarkable post-tax profit for the financial year ending 31 December 2023.

This achievement comes despite liquidity issues and other sector-wide challenges, showcasing MCB's resilience and strategic acumen.

In 2023, the global economy showed signs of recovery, even as volatile energy and food markets, weak business growth and stringent financial conditions posed obstacles.

The Bank of Tanzania's economic report for the quarter ending September 2023 highlighted these hurdles, yet MCB emerged stronger.

Francis Ramadhani, the bank's Chairman of the Board of Directors reported that MCB recorded a post-tax profit of 11m/-, a significant turnaround from a post-tax loss of 331m/- in 2022. This milestone was underpinned by a 3 percent increase in total revenue.

Interest income surged by 20 percent, driven by strategic investments in long-term loans to shortterm borrowers, while non-interest income grew by 3 percent, he said.

"We must indeed take pride in this new direction in managing our bank; these are no small achievements, they are significant steps towards greater profitability in the future to enable dividend pay-outs," he said.

However, the liquidity crunch in 2023 limited the bank's ability to issue loans, resulting in a 2 percent decrease in the loan book. In response, MCB has developed strategies to address this challenge in the upcoming period.

Efforts to maintain a quality loan portfolio paid off, with the year closing with a non-performing loan rate below 1 percent. Moreover, the customer deposit book grew by 1percent despite liquidity constraints.

MCB concluded the year with two service branches in Dar es Salaam, supported by eight regional offices in Morogoro, Mwanza, Mbeya, Dodoma, Arusha, Kigoma, Rukwa and Mtwara.

Beyond these physical branches, customers accessed services through alternative channels such as Umoja Switch and Visa ATMs as well as mobile banking.

MCB's customer base grew from 58,378 to 60,008 in 2023, reflecting its ongoing efforts to enhance service delivery through modern means.

Looking ahead, MCB aims to accelerate business growth to meet the targets set in the 2021-2025 strategic plans, focusing on strengthening operational systems.

MCB was registered in 2012 in Tanzania under the Companies Act No. 212 of 2002 as a limited liability company. It transformed into MCB in 2025 when it was

## Researchers challenged to help ease NCDs burden, other pressing issues

THE government has challenged researchers in the country to come up with effective ways to deal with various challenges, including noncommunicable diseases (NCDs) to reduce treatment burden.

Prof Carolyne Nombo, Permanent Secretary in the Ministry of Education, Science and Technology made the call in Dar es Salaam yesterday when officially opening the 12th Muhimbili University of Health and Allied Sciences (MUHAS) Scientific Conference that brought together over 400 foreign and local researchers.

She said other pressing issues are to improve ethics at the workplace and the use of technology such as artificial intelligence (AI) in the health sector.

She said that researchers should provide solutions and best approaches to resolve problems, adding that without taking measures, diseases will have a direct negative impact on families as well as the government.

conference theme 'Science as a

Innovation and Collaboration in revenues are improved to make a Improving Resilient Health System' was purposely chosen to honour contribution made by MUHAS former Chancellor, the late Ali Hassan Mwinvi.

"We want researchers to come up with recommendations on how to deal with the above three challenges. Recommendations from the conference must be submitted to the committee tasked to prepare development vision 2050," she said.

"The government is proud of the remarkable success achieved by MUHAS since its inception two years after independence." she added.

According to her, MUHAS research has contributed a lot to positive changes in health guidelines, treatment and policy formulation.

She called on policy makers to collaborate with researchers to work on disseminated research findings to solve problems facing the country.

Dr Harrison Mwakyembe, Prof Nombo said that this year's MUHAS Governing Council Chairman, said that the board story of Life: The Power of Research, will ensure domestic sources of

bigger contribution to research.

Vice MUHAS Chancellor Prof Appolinary Kamuhabwa said that the institution has improved research environment and therefore attracts more organisations seeking collaboration.

"The conference must remind us to assess our researchers' contribution towards improving treatment, policy formulation and consultancies," he said.

"We have every reason to honour the contribution made by former President the late Ali Hassan Mwinyi on best ways to prevent NCDs," he said.

Prof Kamuhabwa said that MUHAS implements a total of 150 research projects, a number that has never been recorded in the institution's history.

He said that plans are underway to establish a new cardiovascular hospital at MUHAS Mloganzila, adding that oral health will follow

"Our future plan is to have MUHAS academic city. We currently build infrastructure and train experts," he said.

### DITF 2024: 60 women-run SMEs to take part after quality justification

A TOTAL of 60 women traders are set to take part in this year's Dar es Salaam International Trade Fair (DITF) which kicks off today under the umbrella of the Equal Opportunity for All Trust Fund

Speaking during closing of training for prospective participants in Dar es Salaam on Wednesday, EOTF Executive Director Stephen Emmanuel said this year's number is low because most women-run SMEs still conduct businesses informally.

He said the fund booked 38 booths for women-run SMEs under a capacity building programme 'Women in Poverty Eradication' to exhibit and sell their products.

"We conducted a vetting process from SMEs applications and considered various criteria such as product quality in line with both national and global standards and we were able to get these 60 who

will participate in the exhibition,"

The women-run SMEs that got the opportunity to participate at DITF this year, according to Emmanuel, are those with quality certificates from Tanzania Bureau of Standards

He added that through Tantrade, the fund has enabled 20 women traders to sell their products abroad through capacity-building training they received.

and specialist in natural foods, said EOTF training enabled her company to improve the quality of its products that are sold outside of Tanzania. "One of the products we sell

abroad is banana flour, which is good for diabetic and overweight people; we have been able to deliver authentic products to the United States, Canada and the United Kingdom," she said.

At the event, EOTF issued 250 certificates to those who participated in the programme

EOTF has been operating for 27 years since 1997 and until recently, the fund managed to enable 6,800 women-run SMEs to generate 1trn/-.

#### UN experts accuse Sudan warring parties of weaponising starvation

rights HUMAN experts working for the United Nations on Wednesday accused Sudan's warring parties of using starvation as a war weapon, amid mounting warnings about imminent famine in the African nation.

Sudan plunged into chaos in April last year when simmering tensions between the country's military and a notorious paramilitary group, the Rapid Support Forces, exploded into open fighting in the capital, Khartoum and elsewhere in the country.

Fourteen months of fighting have killed more than 14,000 people and wounded 33,000 others, according to the United Nations, but rights activists say the toll could be much higher.

There were widespread reports of rampant sexual violence and other atrocities that rights groups say amount to war crimes and crimes against humanity. The conflict created the world's largest displacement crisis with over 11 million people forced to flee their

"Both the SAF and the RSF are using food as a weapon and starving civilians," the experts said, using initials for the Sudanese Armed Forces and the Rapid Support Forces. "The extent of hunger and displacement we see in Sudan today is unprecedented and never witnessed before," they said.

Neither the military nor the RSF returned phone calls seeking

The experts warned that famine has become imminent in the country as humanitarian aid has been blocked and harvest season was disrupted because of the war. They added that more than 25 million civilians in Sudan and

those who fled the country are being starved and need urgent humanitarian assistance.

A report by Clingendael Institute said last month that around 2.5 million people in Sudan could die from hunger by the end of September, with about 15 percent of the population in the regions of Darfur and Kordofan being likely the worst affected.

The independent experts said local efforts in response to Sudan's hunger crisis have been hampered by unprecedented violence and targeted attacks on civil society and local responders. Dozens of activists and local volunteers have been arrested, threatened and prosecuted in recent weeks, they

"The deliberate targeting of humanitarian workers and local volunteers has undermined aid operations, putting millions of people at further risk of starvation," they said. "Local responders are risking their health and lives and working across battle lines."

They urged both sides to "stop blocking, looting and exploiting humanitarian assistance."

The experts are part of the Special Procedures, the largest body of independent experts in the United Nations Human Rights

The fighting has in recent months centred around el-Fasher, the capital city of North Darfur province, trapping hundreds of thousands of civilians. At least 143,000 people have been forced to flee el-Fasher over the past three months, according to the U.N.

The U.N.'s Security Council earlier this month demanded the RSF to immediately end its siege of the city, which is the military's last stronghold in the sprawling Darfur region.

The next day, President William Ruto bowed to pressure and said he would withdraw the finance bill containing the unpopular tax proposals.

Demonstrators had vowed to gather again in Nairobi's city centre to mourn those killed. Some have been demanding the president's resignation.

But the turnout in the capital yesterday was much lower than in the previous protest when people stormed parliament. Groups of protesters have been

trying to enter the city centre but most have been repelled by the police.

Ahead of the protests some had vowed to march to the president's official residence, State House.

But prominent people linked to the protests warned against this because of the risk of further

Roads leading to State House have been blocked, with officers turning away some motorists and pedestrians.

Earlier on Thursday, local television stations showed empty streets in the central business district, with many security forces on patrol.

There have also been protests in towns around the country.

In Mombasa, Kenya's secondbiggest city, large crowds turned out chanting "Ruto must go", with businesses having to close because of some looting and stone throwing.

President Ruto's hometown of Eldoret, which on Tuesday experienced violent clashes, was

But there were some clashes in Migori in western Kenya, where police lobbed teargas as they engaged with demonstrators.

Crowds of demonstrators confronted security officers in Kisumu, also in the west.

Ahead of yesterday's protests, Auma Obama, the half-sister of former US President Barack Obama, told the BBC that young people were going to the streets again because "they still want their voices heard."

Obama, who was tear-gassed as she joined Tuesday's protests, said that the youth were still aggrieved.

Ruto had promised to enter into dialogue with them, but this has not yet happened, she said.

"The grievances are not over. It is way beyond the finance bill now, so a conversation has to happen. There has to be a dialogue. I hope that will happen. We do not want more bloodshed," Obama added.

Ruto won the presidency in 2022 after campaigning to champion the interests of the "hustler" - the ordinary citizen struggling to earn a living.

But since then he has introduced a slew of taxes and raised others, making him unpopular as people complained that they could not afford to pay more when they were already struggling because of the cost-of-living crisis.

The finance bill outlined plans to introduce new taxes this year, including on bread and cooking oil, triggering the mass protests.

The government bowed to pressure and dropped some of the taxes but it did little to assuage the concerns of people, who demanded that the bill be withdrawn entirely.

On Wednesday, the president gave in to their demand, saying that "the people have spoken."

But he defended the finance bill, saying his government had made the tough choices necessary to stabilise the economy and to help ease Kenya out of a debt trap which forces it to spend 61 cents of every tax dollar on repaying its loans.

Ruto now intends to balance the books by introducing a new programme of public austerity, including a cut to spending in his

#### N irony of sorts was responsible for a faulty receipt, as it boils down to who was on duty and

being aired at midweek students at the LUniversity of Dodoma (UDOM) were reported to have innovated a number of systems, or applications, to control examination leakage and facilitate selection of courses using artificial intelligence

The development was reported at a week-long symposium among students and faculty members for computer studies, informatics virtual education, where an innovative programme was unveiled.

The student innovators said their design came in response to a series of challenges facing students, and it is thus clear it faces lecturers or tutors as well.

It is unclear how far even the UDOM authorities were on record as having applauded that innovation, even as definitely no one wants exam cheating to mar the respectable holding and marking of examinations.

Yet there will be people in virtually any field who would wish there are loopholes upon which one could gain by their careful use, without upsetting the applecart as it were.

That is the big issue in shifting to computer-based communication in various areas, as at times hideous drawbacks have been noticed as

The key issue is removing faceto-face interaction, now showing negative aspects in clearly faulty electronic billing and receipt issuance.

What electronic billing involves comes to virtually destroying evidence as to who is actually how error came about.

It takes a lot of time to sort that out, unlike in a situation where a revenue officer hands a receipt to a customer or client.

Presumably, no one would go home with a 3m/-tax receipt whereas the proper amount paid was 24m/-, as a regional commissioner reported having witnessed in a key urban centre recently.

That was in part why there was room for doubting whether students can design a totally fool-proof control app for exams, as universities design fool-proof apps for academic standards - and that sort of thing.

There is a street expression that 'boys will be boys' and thus the hide and seek one may see at play in governance or the corporate world will never be sorted out by designing new tools.

Governance will always have its part in probity, links to the fear of losing one's job or being blacklisted, as no one wants headlines, or rumours all over the place, for the wrong reasons.

So, there are some societal safeguards where people will try to do their best so long as someone is checking and won't smile at deliberate errors or falsehoods.

Trouble may be that it isn't the system - yes, system - that people want, but being free to do whatever they want while those on the outside talk as much as they want.

It might be seen as 'democracy' while it is, in fact, anarchy that could breed a disgruntled Generation Z. Showcasing exam leakage controls sounds nice, but we must guard against being overly optimistic.

## Unable to back down, Israel and Hezbollah move closer to all-out war

By Lucy Williamson

SRAEL has been striking back hard against Hezbollah, killing senior Full-scale war between Israel and Hezbollah would be "a catastrophe", the UN Secretary-General says. But to David Kamari, who lives under near-daily fire on the Israeli side of the border. it would be a solution.

Last month, a Hezbollah rocket fired from Lebanon landed in his front garden in the border town of Kiryat Shmona, cracking his house in several places and filling it with rubble.

He points out the gaping holes where shrapnel sliced through the walls, missing him by inches. And then to the hills above us, where Hezbollah-controlled territory begins.

"Every day, every night: bombs. [It's a] problem," he said. "And I was born here. If you live here one night, you go crazy."

David is still living in his rubblefilled house, pieces of shrapnel entangled with the remains of his television set. Outside is the blackened relic of his car, burned by the fire that swept through his front vard after the rocket hit.

Most of the population of Kiryat Shmona was evacuated after the 7 October Hamas attacks, as Hezbollah rockets began raining down in support of their Palestinian

David is one of the few who stayed. "I've lived here 71 years," he said. "I won't go. I was in the army, I'm not afraid.'

"War with solution? Hezbollah; kill Hezbollah," he says. Hezbollah has sent larger volleys of drones and missiles across the border this month, and threats on both sides have increased. Earlier this week, the group published drone footage of military installations and civilian infrastructure in the Israeli city of Haifa.

Tough talk has long been part of a mutual strategy of deterrence, with both sides seen as wary of all-out

But as the tit-for-tat conflict grinds on, and more than 60,000 Israelis remain evacuated from their homes in the north, there are signs that both Israel's leaders and its citizens are prepared to support military options to push Hezbollah back from the border by force.

The mayor of Kiryat Shmona, Avichai Stern, shows me the site where a rocket hit a street near his office last week.

"I don't think there is any country in the world would accept daily fire

against its citizens," Mayor Stern

"And sitting here like lambs to slaughter, waiting for the day they will raid us like we saw in the south, that's not acceptable. Everyone understands that the choice is between war now or war later."

The dangerous stalemate here hinges largely on the war Israel is fighting more than 100 miles (160km) to the south in Gaza.

A ceasefire there would help calm tensions in the north too, but Israel's Prime Minister Benjamin Netanyahu is keeping both conflicts going, mortgaged by his promise to far-right government allies to destroy Hamas before ending the Gaza War.

Earlier this week even the Israeli military spokesman said this goal may not be realistic.

"The idea that we can destroy Hamas or make Hamas disappear is misleading to the public," Rear Admiral Daniel Hagari told Israeli

On the Lebanese side of the border, where more than 90,000 people have been evacuated, the mood among those who have stayed is similarly grim.

Fatima Belhas lives a few miles (7km) from the Israeli border, near Jbal el Botm.

In the early days, she would shake with fear when Israel bombed the area, she says, but has since come to terms with the bombardments and no longer thinks of leaving.

"Where would I go?" she asked. "[Others] have relatives elsewhere. But how can I impose on someone like that? We have no money."

"Maybe it is better to die at home with dignity," she said. "We have grown up resisting. We won't be how to stop the rockets when its

driven out of our land like the Palestinians.

Hussein Aballan recently left his village of Mays al Jbal, around 6 miles (10km) from Kiryat Shmona, on the Lebanese side of the border.

Life there had become impossible, he said, with erratic communications and electricity, and almost no functioning shops.

The few dozen families left there are mainly older people who refuse to leave their homes and farms, he told the BBC.

But he backed the Hezbollah assault on Israel.

"Everyone in the south [of Lebanon] has lived through years of aggression, but has come out stronger," he said. "Only through resistance are we strong.'

As difficult as this border conflict is for people on both sides, a fullscale war would lift the crisis onto a different scale.

Some residents of Beirut are keeping suitcases packed and passports ready, in case of all-out conflict, and the Hezbollah leader, Hassan Nasrallah, said this week that nowhere in Israel would be spared.

Hezbollah is a well-armed, welltrained army, backed by Iran; Israel, a sophisticated military power with the US as an ally.

Full-scale war is likely to be devastating for both sides.

The UN Secretary-General, Antonio Guterres, said it would be a "catastrophe that goes [...] beyond imagination".

The problem for Israel is how to stop the rockets and get its people back to the abandoned northern areas of the country.

The problem for Hezbollah is

ally, Hamas, is being pounded by Israeli forces in Gaza.

The longer that situation grinds on, the more the risks of a miscalculation increase, and the more Israel's government is under pressure to resolve the situation.

The Hamas attacks on 7 October changed security calculations in Israel. Many of those with homes near the border - and some of those in positions of power - say the kind of agreement made with Hezbollah in the past is no longer enough.

om Perry lives in kibbutz Malkiya, right up against the Lebanese border fence. He was out drinking with friends when a Hezbollah rocket slammed through the front of his house earlier this month.

"I think the Secretary-General's warning is right - [war] will be a catastrophe to the area," he said.

"But unfortunately it looks like we have no other option. No agreement lasts forever, because they want death for us. We are doomed to wars forever, unless Israel can eliminate Hezbollah."

Israel's leaders lost all credibility after the 7 October attacks, he says, and don't have a strategy to deliver

"They need to quit - all of them. The biggest failure of our army and our country was 7 October, and they were our leaders. We don't need these leaders."

Demands for political change are likely to increase when Israel's conflicts end.

Many believe Israel's prime minister is playing for time: caught between growing demands for a ceasefire in Gaza, and growing support for a war in the north.

t 59, Brian is living a very different life from the one he expected. He used to be an electrician making a good living. "Everyone needs an electrician," he says.

But Brian can no longer work. He has a tremor that shakes his body uncontrollably, caused by a brain condition similar to Parkinson's Disease. In his south Manchester flat, he sits surrounded by the model aeroplanes that he used to paint as a hobby but no longer can. His curtains are drawn to give him privacy from the road outside.

He needs help with the simplest tasks, such as feeding himself and dressing, but the care system he and many others rely on has been in crisis for years.

He says the shaking is exhausting. He also has epilepsy.

Perhaps like most people, Brian never expected he would need social care. But in a population that is ageing and living longer with complex conditions, many of us will

AP universal long-term care were dubbed a "death tax" by the Tories. Then, in turn, the Conservatives' 2017 proposals for social care funding were branded a "dementia tax" by Labour.

Boris Johnson's government did set a timetable for introducing an £86,000 cap or limit to an individual's care costs over a lifetime. Originally due in 2023, its introduction in England was delayed until October next year.

Labour and Conservatives have said they would go ahead with this care cap, but experts say the money allocated is already being used to prop up the existing system.

Both manifestos say they will improve pay and conditions for care staff. Labour also pledges to set up a National Care Service within 10 years.

But there is little detail -

particularly when it comes to how care will be funded.

Smaller parties have been more ambitious. The Liberal Democrats and the Green Party have both said they would make personal care free.

The care systems in the rest of the UK have seen some change. They are more generous, and in Scotland there is already free personal care.

But delays in tackling the care system's deep-rooted problems in England have consequences both human and economic.

Brian, for instance, gets four care visits a day. Although the council pays for most of this, he still has to contribute £500 a month towards the total bill. He is on benefits and is now in debt.

"I'm behind on my gas and electric and other bills with paying so much for the care. It is stressful,"

he says.

He's not sleeping at night because of the stress. He believes it is making him more poorly and increasing his shaking, so he now needs more care.

But the council can't provide it, and he couldn't afford to pay more towards it anyway.

As things currently stand in England, anyone with savings and assets of more than £23,250 has to pay for all of their care. The value of their family home is counted if they move into a residential home.

People who fund themselves can end up paying between £1,000 and £2,000 a week for a care home place. Many of them are far from asset-rich. It can devour savings and lead to family homes being sold.

At a care home in the Wirall, 86-year-old Imelda dances around her room with her daughter Nicola Hurst

In the background, Frank Sinatra croons "I've got you under my skin" as they sway to the familiar music.

Imelda has dementia and has lived in the home for about four years.

She is part of a large, close family and her daughter or one of her other relatives visit her most days.

Imelda had no savings and didn't own her own home, so in theory her council pays for all her care.

But in reality, the amount provided by the council doesn't cover the care home's £1,200 weekly fees, so Nicola and her brother pay a £2,200 top-up each month to allow their mother to stay in the place she is familiar with.

"What keeps me awake at night is the thought that I now won't have enough in my savings pot to pay if I ever need to go into care," says Nicola, who is retired. "And therefore, that financial burden will pass to my children."

She is involved with the group Rights for Residents and campaigns for more recognition of the importance of families in social care.

"Successive governments accept that this is crisis," she says. "They accept that this is something that has to be addressed. And yet, they do nothing."

But in England, at least, money continues to be a stumbling block, according to Sally Warren, Director of Policy at the King's Fund. She used to be a civil servant and helped draw up plans for the care cap.

"Political parties are really anxious about making any commitment to improve the system and having to find the money," she says.

Last year £28bn was spent on social care in England and reform would cost several billion pounds more.

There has been some mention during the campaign of cross-party talks to agree a way of funding social care in the long term. Sally Warren sees that as a red herring that would slow things down.

"What you need is a government that's prepared to take action, that will legislate when it is needed, and will follow through and implement," she says.

Whoever wins the general election there will be tough choices about money and the danger is that once again social care is placed on the "too-difficult-to-handle" pile.

But continuing to do nothing is also expensive, leaving the under-pressure NHS and families picking up the

And so when it comes to the election, Brian has little time for politicians.

"I don't think they support us, I don't think they care," he says. I ask him if he feels angry about this.

"Yeah', he replies, then quickly tells me he's getting agitated. "They don't treat us right."

Nicola Hurst is even blunter. She wants politicians to "do their job".

## Youth-led protests force Kenyan president's hand of tax bill

**NAIROBI** 

n a historic first, Kenya's youth have mobilized in large-scale protests to demand that the political establishment listen to them. The Finance Bill 2024, which proposed new taxes across several sectors, was the catalyst for the protests, igniting outrage among a youth demographic that feels betrayed by decades of political promises. These protests, driven by economic and social grievances, escalated dramatically, culminating in clashes with police that led to numerous deaths and widespread unrest.

The streets of Kenya's major towns and cities became battlegrounds, showcasing a remarkable display of youth agitation. Hundreds of demonstrators faced illegal arrests and detentions, with many others sustaining injuries in the chaos.

Amidst these tumultuous scenes that gripped Kenya, young female protesters emerged as a force to be reckoned with, standing shoulder to shoulder with their male counterparts in defiance of punitive tax measures. Their presence in the chaotic protests was not just significant; it was transformative, as they marched fearlessly into the fray, determined to have their voices heard.

ThWanjiku Stephens, donning a luminous green raincoat, became an emblem of bravery as she marched towards a police water cannon. Her act of standing in solidarity with a fellow protester shocked many.

"I was somewhere behind when I saw a young guy hit by the water cannon. A young and energetic guy who not only believed in himself but in the people. That is when I said I have to speak up as a woman," she recounted, her voice tinged with a mix of fear and resolve. Wanjiku couldn't pinpoint where her courage came from, only that she found herself on the front-lines, unwavering.

Shakira Wafula boldly confronted the anti-riot police, mirroring Waniiku's spirit

"I am here for Kenya, for my people. I am here for your rights. Push me," she declared defiantly, clad in black, raising her fist up and holding a Kenyan flag.

Shakira's frustration was palpable as she described her encounter. "The police tried to control how I was moving. This raised my pressure," she explained.

Wanjiku also highlighted the specific grievances of women regarding the Finance Bill. "If you look closely at the Fi-

nance Bill, a lot of things are affecting us as women. From sanitary towels to anything involving the household, which is the woman's responsibility," she pointed out.

"In other countries, sanitary products are free, so why not in Kenya? Why are we being charged for having periods, something we didn't choose?" she asks.

e current government claimed that the previous administration had borrowed heavily from foreign governments, so the Finance Bill sought to increase and introduce new taxes to pay off this debt while simultaneously making Kenya less reliant on foreign debt. This was to bridge the debt gap and also raise revenue to finance the government's move to subsidize agriculture inputs. The taxes on basic necessities, such as bread and sanitary towels, infuriated the youth and Kenyans.

Unlike previous demonstrations marked by stones and crude weapons, these Gen Z protesters opted for peaceful chants, documenting their protests on their phones and even live-streaming to reach a wider audience. Their approach was a testament to a new wave of activism, one that harnessed technology and peaceful resistance to amplify their message.

As these relentless women took their stand, they not only fought against economic injustice but also redefined the role of women in Kenya's fight for a fair and just society. Their courage and determination became a powerful symbol of the youth uprising, inspiring countless others to join the cause.

The proposed Finance Bill is seen by many as a burden on ordinary Kenyans, deepening their financial struggles, while expanding government spending. The youth, already facing high unemployment despite being educated, view this bill as a direct assault on their economic prospects. Their frustration is palpable, and their actions speak volumes about their desperation and determination.

In a bid to suppress the protests, law enforcement officers resorted to firing live ammunition, wielding batons, deploying water cannons, and using tear gas grenades. This heavy-handed approach resulted in a significant number of deaths and injuries, though the precise count remains uncertain.

According to the UN Code of Conduct for Law Enforcement Officials (1979) and the UN Basic Principles on the Use of Force and Firearms by Law Enforcement Officials (1990), only the minimum force necessary should be used for legitimate law enforcement purposes during an assembly. These international standards highlight the excessive nature of the force used against the Kenyan protesters, raising serious human rights concerns

The anger and determination of the youth reached a peak as they occupied the parliament precincts, one of the most protected zones in the country. They managed to breach security and gain entry into the bicameral house, leading to chaotic and unprecedented scenes.

At least four protesters were shot dead as police struggled to disperse the rioters. The situation escalated further

as protesters vandalized windows and set fire to the new wing of the parliament building, causing significant damage and forcing MPs and parliamentary staff to scramble for safety.

The use of live ammunition to quell the riots, along with reports of arbitrary arrests and the intimidation of activists, has drawn sharp criticism from lawyers and human rights groups. They argue that such measures are not only excessive but also violate the fundamental rights of the protesters.

President William Ruto's response to the protests has been equally controversial. In a Tuesday 9 pm national address, he condemned the protesters as criminals and called for military intervention, failing to acknowledge the deaths caused by police action.

As the dust begins to settle, the broader implications of these protests for Kenyan society and politics become clearer. The targeting of businesses perceived to be aligned with politicians supporting the Finance Bill underscores the deepseated frustration and mistrust among the youth. The potential for future unrest looms large as the young generation continues to demand justice and economic fairness.

In a surprising turn of events, Ruto succumbed to mounting pressure from Gen Z, millennials, and the public, leading him to make an unprecedented decision. The president announced the withdrawal of the contentious 2024 Finance Bill, a move that the protesters, who flocked to the streets in record numbers, had fiercely demanded.

"Listening keenly to the people of Kenya who have said loudly that they want nothing to do with this Finance Bill for 2024, I concede. Therefore, I will not sign the 2024 Finance Bill, and it shall subsequently be withdrawn. I have agreed with these members that this becomes our collective position," Ruto declared in a nationally televised address on Wednesday.

However, this decision sparked a debate on its legality. Rarieda Legislator Paul Otiende Amolo, who played a key role in crafting the 2010 constitution, pointed out that the president cannot unilaterally withdraw a bill since he is not a member of parliament.

"To constitutionally nuance this, the legal way is for the president to register reservations on all aspects of the bill, including the title, then send the bill back to parliament within seven days. Parliament then votes to adopt each reservation, effectively nullifying the bill," explained lawyer Waiko Wanyoike.

Human rights advocates quickly weighed in on the matter. Wangeci Grace Kahuria is the Executive Director of Independent Medical Legal Unit (IMLU) and convener of the Police Reforms Working Group.

"It's not the protesters who are treasonous but the president's acts. Ac-

cording to Article 241/2/c of the constitution, which requires the National Assembly's approval but never did, the Kenya Defense Forces (KDF) deployment was illegal and made the killings worse," according to Kahuria.

Joshua Changwony, Executive Director of Constitution and Reform Education Consortium (CRECO), noted the widespread nature of the protests, emphasizing that 67 towns across the country participated, making it a national movement rather than a localized Nairobi issue.

Speaking to IPS on the phone, legal expert Willis Otieno commented on the political implications, stating, "Parliament, as it were, already stands impeached in the eyes of the people of Kenya. This is a response to the people exercising their Article 1 right to the constitution by demanding a rejection rather than withdrawal."

He argued that the people had effectively 'impeached' parliament, rendering it powerless in this context. The Finance Bill is revenue-raising legislation, which means the amendments made last year will remain in effect. This forces the government to return to the drawing board and reduce the budget."

For Otieno, the two press conferences done by the president and his deputy in different locations confirm that "we do not have a functioning government."

"The legislators refused to listen to the people who gave them their views. The same legislators clapped when the president withdrew the bill, yet they are the ones who passed it," remarked Otieno.

Deputy President Gachagua blamed the National Intelligence Service (NIS), yet the people did not elect the security spy agency.

"They should not play blame games and must take ultimate responsibility. The president and his deputy owe Kenyans one duty: to vacate their offices and resign because, by their admission, they are shirking responsibilities to others whom the people of Kenya did not elect," reiterates Otieno.

As Kenya navigates this critical juncture, the voice of its youth continues to echo through the corridors of power, signaling a profound shift in the nation's political landscape. The collective action of a generation has not only forced a significant policy reversal but has also sparked a broader conversation about accountability, governance, and the power of the people.

#### Flamingos under threat: Climate impact ILLIONS of pink flamingos transform the alkaline risking delicate balance of Lake Natron waters of Lake Natron in northern Tanzania into a dazzling sea of fluttering feathers every



forms of life, with surface temperatures soaring up to 40 degrees Celsius. However, these are perfect habitats for flamingos. These lakes, filled with caustic soda and hypersaline water, deter most predators but provide an unexpected haven

lakes. Lake Natron in Tanzania and Lake

Bogoria in Kenya are hostile to most

for fascinating migratory birds. Lake Natron, a Ramsar site on the Tanzania-Kenya border, has a unique composition of warm waters and salt, caustic soda, and magnesite deposits that provide ideal conditions for flamingos to thrive. However, this delicate equilibrium is increasingly being upset.

Several factors, including agriculture, pollution, and climate change, are threatening the beauty of this unique ecosystem, according to John Sule, a senior ecologist.

"Climate change is altering water levels and salinity, making it harder for flamingos to find suitable nesting sites. The population of flamingos on Lake Natron is steadily declining as fewer birds return each year due to extreme weather and encroachment," he said.

Extreme weather is causing frequent flooding, compromising the lake's salinity, according to the ecologist. "The reduction in salinity disrupts the growth of specific algae that serve as a food source for flamingos. The birds' feeding patterns and breeding success are being adversely affected, posing a serious threat to their population," said Sule.

Conversely, prolonged dry seasons are also causing water levels to drop dangerously, concentrating the lake's salinity beyond what algae can tolerate and resulting in flamingo food shortages.

In 2006, an Indian company

proposed a soda ash extraction project at Lake Natron, which sparked global outrage and was ultimately abandoned in 2008. The threat, however, persists.

"Flamingos are incredibly sensitive to changes in their environment," said Edmund Shayo, an environmental activist specialising in bird habitats. "The rising water levels are diluting the soda lakes, which drastically affects the cyanobacteria that flamingos feed

According to Shayo, min-

ing activities near the lake are detrimental to the birds. "The disruption caused by mining activities would most likely force them to abandon the lake. Flamingos need a quiet and undisturbed environment for nesting and any significant disturbance could drive them away, threatening their ability to reproduce and sustain their population," he said.

#### **Community efforts**

Despite the challenges, local communities are actively working to protect their pinkfeathered neighbours. Yohanna Mlai, a resident of Magadini village, believes that education plays a crucial role in these efforts. By teaching pastoral communities about sustainable water practices, they aim to ensure that the lake remains a viable habitat for both flamingos and the people who depend on it.

This initiative is helping to balance the needs of wildlife with those of the local human population, fostering a sense of stewardship and coexist-

"The importance of Lake Natron's flamingos extends beyond their ecological role. They are a major attraction, drawing thousands of tourists every year," Mlai said. Tourism accounts for 17.2 per cent of the country's gross domestic product and 25 per cent of foreign exchange rev-

Flamingos' struggle for survival in Tanzania is part of a broader global pattern. Across Africa's Great Rift Valley, flamingos face similar threats at other critical breeding sites. Rising water levels and invasive plant species, fueled by climate change, are disrupting these habitats.

"These birds are vital environmental indicators," said Flower Msuya, a marine biologist at the University of Dar es Salaam. "Their well-being is a reflection of the overall health of the ecosystem. When flamingos face difficulties, it indicates larger environmental issues that must be addressed."

To protect Tanzania's flamingos, comprehensive and coordinated efforts are required. Conservationists advocate for stricter environmental regulations and increased public awareness.

"Protecting these birds requires a holistic approach," said Msuya. "It's about preserving their habitat, controlling pollution, and ensuring that any development around the lake is sustainable. Communities must be at the forefront of conservation efforts. Their involvement and cooperation are crucial for any long-term suc-

We must act now, urged Sule. "If we don't address these issues, we risk losing one of nature's most spectacular phenomena," he said.

## Age anxiety hangs over first Biden-Trump debate

or Joe Biden and Donald Trump the two oldest candidates ever to seek the US presidency - age is an election issue neither can escape.

On Thursday, the current Democratic president, 81, and his Republican predecessor, 78, will face off in Atlanta, Georgia, for the first of two debates ahead of November's vote, offering Americans a rare, split-screen comparison of the two men's physical and mental

For 90 minutes, under the glare of the highdefinition cameras, President Biden and former President Trump – who remain nearly tied in national opinion polls – will spar on issues ranging from the economy and foreign wars to immigration and the future of democracy. One slip-up, stumble or verbal miscue could cement concerns about their advanced age, with the potential for reshaping an already tight presidential race as voters begin to pay attention.

But delivering a vigorous performance may be more critical for Mr Biden, the nation's oldest president who has been dogged by questions about his stamina and mental fitness since he took office.

"There's no hiding the fact that Biden's 81, there's no hiding the fact that Trump's basically the same age," said Jim Messina, a Democratic strategist who managed Barack Obama's 2012 presidential campaign. "It's not a contest of age, it's a contest of policy and character."

"Part of what needs to happen on Thursday night is just to begin the conversation about the differences between them," Mr Messina

Polling shows that voters are far more concerned about Mr Biden's age than his opponent's. But if Trump wins, he would break Mr Biden's record as the oldest president before the end of his term.

A March New York Times/Siena College poll suggested 73% of registered voters believed Mr Biden was "just too old to be an effective president". Voters of all age groups expressed these concerns about the president's fitness for office, including those 65 and older, according to the survey.

Just 42% of registered voters said the same about Trump, despite a mere three-and-ahalf-year age gap.

"It ought to be about both of them, but Biden looks his age," said Larry Sabato, the director of the University of Virginia Center

Mr Biden was declared "fit for duty" earlier this year by a White House physician, but concerns about his age have persisted since he took office. Signs of his aging have become more notable in recent years, including a softer speaking voice, occasional memory lapses and a "stiffened gait" which his doctor partly attributes

As president, he is "covered almost every moment he is out in public" which means he endures more scrutiny than his challenger, Mr Sabato said.

Videos of routine actions - walking up and down Air Force One's stairway, crossing a stage at public events - are watched closely online and in conservative media.

When Mr Biden tripped and fell at an Air Force Academy graduation in June 2023, the tumble made national news. After being helped to his feet, he continued to

stand and walk as normal. His team said he had tripped on a sandbag on the stage, and the president later told reporters at the White House, "I got sandbagged!"

Some Democrats have publicly and privately expressed reservations about the president's age, but they rallied around him in February, when justice department special counsel Robert Hur released his investigation into Mr Biden's handling of classified documents after his term as vice-pres-

The report did not recommend prosecuting him, but Mr Hur's description of the president as an an "elderly man with a poor memory" made headlines.

But when Mr Biden gave his annual State of the Union address a few weeks later, pundits gave him high marks for an energetically delivered speech.

At a Saturday rally in Pennsylvania, Trump complained of a double standard between the media's treatment of himself and Mr Biden.

Both campaigns have sought to shape the narrative around their opposing candidate through social media, amplifying video snippets of verbal gaffes, memes and in some cases, deceptively edited footage.

More recently, Republicans and rightwing media have intensified attacks on Mr Biden's mental competence, circulating a flurry of edited video clips including one of the president appearing to wander off during the G7 summit of world leaders in Italy. The unedited footage showed Mr Biden was walking to greet paratroopers during a skydiving demonstration.

Days later, conservative critics shared footage online of the president at a Los Angeles fundraiser, standing on stage before Barack Obama reaches for his arm and they walk off stage together. Donald Trump and other Republicans claimed it was evidence that Mr Biden had frozen up and had to be led off stage. But allies of the president pointed to longer clips that appeared to show Mr Biden smiling and taking in the crowd's applause.

The Biden campaign has responded with a rapid response effort on social media, sharing content that appears to similarly raise questions about Trump's mental acuity. They've posted clips of Trump appearing to walk off stage before he is supposed to and being redirected by others including former Vice-President Mike Pence and Israeli Prime Minister Benjamin Netanyahu.

Young voters won't like what they see

Yet even as some of these videos are easily disproved, voters' reservations around Biden's age continue to be one of his biggest vulnerabilities. This is particularly true

for younger voters, who are traditionally a more important demographic to Democrats than Republicans in national elections, organisers say.

Watching the debate could be an "eye-opening experience" for younger voters, said Amanda Litman, a Democratic strategist and founder of Run For Something, an organisation that trains and supports the next generation of Democratic candidates.

"I think it is indicative of a structure of politics that has privileged an older generation to stay in power for a long time," Ms Litman said of the candidates' ages. "It is one of many reasons why, especially younger voters, feel disengaged. They don't see themselves reflected in leadership."

Brandt Williams, a 23-year-old accountant from Connecticut, said he will support Mr Biden again in 2024. He sees Mr Biden as a statesman who has a strong handle on foreign policy, and he supports the president's economic policies.

"The one issue is pretty common," Mr Williams said. "His age."

Though he planned to tune into Thursday's debate, Mr Williams said he wished that he could vote for a "younger person, not only for vitality, but to represent all Americans, both young and old".

In the critical battleground of Georgia, where the first debate will take place, Democrats told the BBC they sense apathy among their party's young voters, with age a sticking point for many.


"Biden is stuck in a position where the younger generation wants action... they don't want a speech about how we're better as a nation," said Titus Nichols, a 39-year-old attorney who is active in the Cobb County Democratic Party.


While the president "is the more mature, steady person, that's not what people are looking for", he added.

On Thursday evening, millions of people will be tuning in not only to hear the candidates' ideas and arguments, but to judge the nominees' stamina for themselves.

For Mr Biden, delivering a punch is critical if he wants to quell fears about his age, according to Ms Litman, the Democratic strategist.

AfDB launched the UMDF in 2019 in response to growing demand from countries and cities for urban development support. It receives contributions from the

Nordic Development Fund and the governments of Denmark, Spain, and Switzerland, as well as the Walloon Export and Foreign Investment Agency.

The Fund provides financial and technical assistance to national and local governments for improving governance, and planning, and to prepare investments in sustainable urban development for more climate resilient, resilient, liveable, and productive cities, underpinning national socio-economic development and poverty reduction.

UMDF will provide funding for each of the six cities over several months, including a detailed analysis of the strengths and vulnerabilities, especially regarding economic, social, climate, and gender issues. The goal is to identify transformative infrastructure projects that can attract public and private sector investments.

The committee also reviewed the Fund's progress and approved its 2024 work program, allocating over \$4.7 million to identify and

It is hoped that the Fund will act as a catalyst in boosting access of African municipalities to public and private finance, a priority defined by the President of the AfrDB Group, Akinwumi Adesina, at the Africa Investment Forum 2023 Market Days in Morocco.

## Practitioners seek removal of impediments to Africa's real estate

EXPERTS have advocated removal of impediments to cross border transactions and collaboration among real estate professionals in Africa as a means to grow the sector.

They also stated the urgency to implement accessible and affordable mortgage rates in the continent, while calling for the removal of other critical impediments to free movement of trade and real estate services across the regions.

The experts spoke at a Pan-African Real Estate Webinar series 2024 entitled: 'Cross Border Collaboration in Promoting Real Estate Practice across Africa organised by the Nigerian Institution of Estate Surveyors and Valuers (NIESV), Lagos branch, also made case for the utilisation of Artificial Intelligence (AI) to ensure sustainable real estate development.

Leading the call, a fellow of Nigerian Institution of Estate Surveyors and Valuers, Mr Chudi Ubosi, argued that professionals in the continent need governments to provide an enabling environment for affordable mortgage as the issue of high mortgage



rate appears to be a general development in Africa.

He lamented a situation whereby mortgage in Nigeria is limited as commercial loans range between 30 to 35 per cent and fewer years. He, therefore, stressed the need for a change through collaboration and advocacy by the professionals alongside the government to make housing accessible to the citizens as witnessed in advanced nations.

The Managing Director/ Chief Executive Officer, Abri Group of Companies, Mrs. Vicky Sampah, observed that mortgage loans in Ghana are unaffordable as only those working with the government and private sector benefit, while the informal sector is locked out. She disclosed that the mortgage rate in Ghana is within 12 to 20

per cent based on dollar and local currency (Cedis)

Sampah said practitioners in Africa must embrace Property Technology (Proptech) and AI to enhance property listing by real estate agents and proper description of available homes for purchasers.

She added that the technologies will give extra service to make the industry better and won't threaten available jobs. Sampah, however, warned that there must be ethical considerations in deploying the tools in real estate activities.

According to her, there was a need to engage in regular discussions, collaboration and actions that are critical to grow the African real estate sector, as well as learn from experiences from the global market. To her, one crucial way to remove impediments to cross border transactions is through education and advocacy with relevant

stakeholders.

The Chairman, Governing Council, Real Estate Institute of East Africa, Uganda, Mr Vincent Agaba, explained that cooperation, building trust among professionals is key to grow real estate service, adding that this will further help the continent to develop momentum for harmonious legislation.

He also lamented the high mortgage rate of 10.5 per cent (for foreign currency) and 22.5 per cent (for local currency) in Uganda.

## **EU** requests easing of S. Korea's automobile certification proced

THE European Union (EU) automobile industry asked the South Korean government to simplify the complex automobile certification procedures and establish measures to promote trade.

The Korea-EU Free Trade Agreement (FTA) Automotive and Parts Working Group meeting was held in May this year, bringing together relevant South Korean ministries such as the Ministry of Trade, Industry and Energy, the Ministry of Land, Infrastructure and Transport, and the Ministry of Environment. During this meeting, the European Union (EU) automobile industry asked the South Korean government to simplify the complex automobile certification procedures and establish measures to promote trade.

The EU pointed out that the current certification system for vehicle safety standards, emission and noise standards, and fuel efficiency standards is burdensome and lengthy, limiting the development of automobile trade. "The certification system for vehicle safety standards, emission and noise standards, and fuel efficiency standards is burdensome and lengthy, limiting the development of automobile trade," stated an EU representative during the meeting.

In addition to simplifying certification procedures, the EU requested that South Korea implement trade

facilitation measures that could expand EU automobile exports. Essentially, the EU is asking South Korea to relax related regulations to increase automobile exports to South Korea.

Another issue raised by the EU was the predictability of South Korea's electric vehicle subsidy guidelines. The Ministry of Environment annually sets and announces the criteria and amounts for electric vehicle subsidies. This year, the vehicle price threshold to receive the full subsidy was lowered from 57 million won (approximately \$42.200) to 55 million won. However, few electric vehicles from EU automobile brands in South Korea are priced below 55 million won. For instance, Volkswagen set the price of its ID.4 model at 54.9 million won, 2 million won lower than before, to meet the criteria for receiving the full subsidy.

The EU raised concerns about the difficulty of immediate response, as the subsidy criteria for the year are only announced in January or February each year. Furthermore, the EU criticized the criteria related to charger installation for subsidy payments. The government provides 200,000 won for electric vehicles from manufacturers that have installed more than 100 fast chargers in the past three years and 400,000 won for electric vehicles from manufacturers that have installed more than 200 fast chargers.

### **UNEASINESS RAGES OVER MUSHROOMING OF URBAN FILLING STATIONS**

aimuna Hussein (26) a Dar es Salaam resident, has found herself repeatedly relocating from one part of the city to another owing to the mushrooming of fuel filling stations which she claims to disturb her respiratory system.

The mother of a son told this journalist early last month that with her husband were forced to relocate to Goba Street in Ubungo district in April this year from Sinza Street in Kinondoni district following the commencement of a petrol filling station construction project next to the house they rented.

Maimuna said that the relocation was the third one from the second in August 2023 when she relocated from Banana Street in Ilala district and the first in March 2023 when she relocated from a rented house at Tabata Bima Street in Ilala district of Dar es Salaam due to construction of new fuel stations nearby the houses she rented.

"I have been trying to get healed from asthma for six years now. I face difficulties in breathing when I smell petrol or diesel. I can't survive places with a heavy smell of petroleum products," she said.

According to her, she always puts her car's air conditioner on for full time fresh air when she is driving to and from her working place at Posta central business district in the city.

"I don't know until when I will be relocating from one place to another escaping the mushrooming fuel stations. I wonder what the government is doing to control the increment of fuel stations within human residents," said Maimuna.

She asserted that pollution is taking shape through the establishment of fuel stations within human settlements thus interfering with the right to a healthy environment.

Maimuna's complaints come

at the time when NEMC and officials from land use planning departments in district councils blame each other on the issuance of permits as conflicts of safety and health interests increase between people and the government that seeks to earn handsome revenues in taxes from investors in the petroleum products business.

This journalist has learned that the mushrooming of fuel stations within people's residence is against Section 4(1) of the Environment Management Act No. 20. 2004 which states: 'Every person living in Tanzania shall have a right to a clean, safe and healthy environment.'

However, the scenario jeopardizes Section 6 of the same Act which states: 'Every person living in Tanzania shall have a stake and duty to safeguard and enhance the environment and to inform the relevant authority of any activity and phenomenon that may affect the environment significantly.

The scenario further goes against the United Nations Sustainable Development Goal 7 which emphasizes on access to clean energy supplies and transformation.

Nehemiah Nnko, Medical Doctor at Magu District Hospital in Mwanza region said inhalation of excessive air filled with the smell of fuel can cause throat irritation, stomach ache, and nausea and sometimes leads to vomiting and difficulty breathing.

"If this situation continues for a long time, the person becomes at risk of suffering from diseases of the respiratory system such as TB, Asthma and severe flu," said Nnko.

Musa Thabiti (24) a bachelor's degree student at the Institute of Social Work in Dar es Salaam expressed his worries on human lives and property safety with the mushrooming of the petrol filling stations in the

He said that just two months ago, a traditional food restaurant adjacent to the Institute was demolished to pave the way for construction of a new petrol station.

He said the demolition has triggered disturbances for students who used to have their lunch at the restaurant and are now forced to walk to Africasana Street about half a kil-

"This petrol station has been constructed in a space of two months. As you can see it is very close to the Institution's build-

I'm just imagining what will happen in case of a fire outbreak. This is not safe anymore. I wonder if the government really cares about environmental issues?" said Thabiti while pointing at the new petrol sta-

of State in the Vice President's Office (Union and Environment) has powers to issue the Environment Impact Assessment Certificates for development of petrol station projects after the investor had obtained the change of land use permit from the respective district council.

Speaking to this reporter late April this year, Titus Kaguo, EWU-RA's Public Relations Manager said that the authority issues projects development licenses after investors had gone through all procedures at the district councils and the NEMC.

Jamal Baruti, NEMC Manager for Review of Environmental and Social Impact Assessment said that district councils have been ignoring NEMC in the process of issuing change of land use permits and title deeds to investors seeking to establish fuel stations.

On the other hand, Aquilinus Shiduki, Head of Communication at Kinondoni Municipal Council said that for Kinondoni, all procedures are observed before the change of land use permit issuance.

Shiduki said the municipal office has been working hand in hand with NEMC to ensure that environmental laws are observed in setting up petrol station projects.

According to the latest EWURA's report as of March this year 2,522 petrol and diesel fuel stations were licensed countrywide to run fuel businesses up from 2,297 in March 2023 an increment of 9.8 percent.

The report shows that of the total fuel stations, 434 are in rural areas increasing from 287 (51.22 percent) in March 2023.

The report states that through the Bulk Procurement System (BPS) by the Oil Marketing Companies (OMCs) 6.28 billion liters of petroleum products were imported into the country between July 2023 and March 2024.

Of the imported petroleum products, diesel accounted for 3.77 billion liters, petrol 2.29 billion liters while Jet A-1 or Kerosene ac-

However, of the 6.28 billion liters, 3.37 billion liters (53.7 percent) were destined for the domestic market while the remaining was for transit to landlocked countries.

EWURA states that there are 75 OMCs of which 18 are pre-qualified in the bidding process through BPS where only five are active and effective in the bidding process.

Joshua Kweka (34) Mwanjelwa resident in Mbeya city told this journalist that he remembers the government had halted issuance of permits for construction of fuel stations in

"I wonder when the government resumed the issuance of the permits without thorough screening. Petrol stations are flooding the streets;

My house is next to a fuel station and I have no other option but to stay though I'm worried of possible fire incidents outbreaks," said

On November 10, 2022 the government suspended the issuance of filling stations construction permits for the period of three months to January 2023.

The government also suspended issuance of residential houses building permits to owners of plots or pieces of land, who didn't match the city, municipality and town councils' plans.

The then minister for Land, Housing and Human Settlement Development, Dr Angeline Mabula said that the decision targeted to improve the planning process and better manage urban growth moving forward.

She also said that the decision aimed at ensuring city; town and councils' master plans are observed.

Anastasia Masare (27) resident of Kwa Mrombo Street in Arusha city was of the view that far from safety and health risks posed by fuel filling stations in people's residence, tankers have been destructing street roads most of them are meant not to be used by vehicles with the weight that exceeds ten tons.

"Roads don't last longer and are being regularly repaired in this neighborhood because heavy long vehicles on transit stop by for filling fuels," said Masare.

HE prevalence of unplanned settlements in urban areas of the country has been cited by the Fire and Rescue Force as among huddles in responding to fire outbreaks that claim human lives, loss of wealth and properties.

In its 2023 annual report, the Force underscore that far from operational ineffectiveness attributed to lack of fire rescue and fighting equipment, unplanned settlements have been a major challenge when it comes to containing fire outbreaks in slums and quartered residents.

"Land use planning must be a key priority for authorities regulating the development of new settlements for such places to be passable in case of fire outbreaks," reads part of the report.

The report states that fire incidents caused deaths of 38 people and injuries to 146 victims in 2023 up from 32 deaths with 66 injured people as recorded by the Force in 2022.

The report emphasizes that the planning of residential and commercial properties must be designed in a manner that provides easy access for the Fire and Rescue Force in all areas.

The report shows the Force had attended 2,076 fire incident outbreaks in 2023 compared to 1,854 fire outbreaks recorded in 2022. The Force had approved 2,431 drawings of construction maps in 2023 doubling the 2022 approved maps.

The Force had conducted 728 radio and television programmes to sensitize communities on fire-fighting know bouts compared to 602 programmes conducted in 2022.

The Fire and Rescue Force has been facing shortage of operation equipment but this time around this journalist has discovered from the Force's annual reports that unplanned settlements also jeopardizes operations for containing fire outbreaks.

This publication dated April 2, 2024 had published a special report that highlighted the Force's

struggle to effectively respond to fire incidents.

Following the widespread dissemination of this report, on April 4, 2024, Geoffrey Pinda, Deputy Minister in the Ministry of Land, Housing, and Human Settlements Development informed the parliament on measures that the Ministry of Home Affairs is taking to address the problem.

However, in a session held on June 6, 2024, the National Assembly convened for nearly two hours to discuss solutions to the challenges faced by Force and came up with five resolutions on the way forward.

This is the case when just last month a residential house of 12 rented-rooms burnt to ashes on May 2nd, 2024 at Tabata Kisiwani suburb in Dar es Salaam city as the fire tender couldn't make its way to the burning house due to unplanned settlements that have blocked street roads.

Mabusi Peter, Ilala Regional Senior Assistant Commissioner of the Fire and Rescue Force said that the patrolling fire tender had arrived within ten minutes at the incident scene but couldn't make it to the burning house because there were no passable roads.

"Most populated areas in Dar es Salaam are unplanned thus challenging operations by the Fire and Rescue Force in case of fire outbreaks," said Peter.

According to him, Section 22 (2) of Fire and Rescue Force (Amendments) Act Cap 427 R.E 2021 and Article 14 (1) of the Fire and Rescue Force Regula-

tions 2014 obligates regions and districts residential planning authorities to consult the Force to verify land planning prior to issuance of housing development projects but it is done the opposite way.

Alfred Mbyobyo, Dar es Salaam Residence Planning Officer said that it is unfortunate that the most populated areas of the city are still unplanned and there is no way the government can forcefully evict people from their own lands without compensation.

"We have been working closely with the Fire and Rescue Force in sensitizing people to observe land planning before they set up residential and commercial properties. This is obviously done prior to issuance of project development permits,"

said Mbyobyo.

Jerry Silaa, Minister for Lands, Housing and Human Settlement Development, when tabling the 2024/25 ministry's budget in the National Assembly last month said that as of earlier May this year, 4,024 villages (32.67 percent) of the 12,318 total country's villages had been approved with land use planning permits.

According to Silaa, the ministry through the Land Tenure Improvement Project (LTIP) has set targets of preparing 1,667 land use plans during the said financial year.

"During 2023/24 a total of 407 villages were surveyed of which 320 have been granted land use plans. However, a total of 62,200 plots of land were regularized in Dodoma city, Chalinze district, Kigoma municipality, Nzega town, Kahama municipality and Shinyanga municipality," said Silaa.

He asserted that the government has since 2023/24 allocated 8.2bn/- for the National Land Use Planning Commission 9NLUPC) to execute land use plans across the country as at the end of 2025.

This is the case when the Population and Housing Census 2022 results by the National Bureau of Statistics (NBS) show that Tanzania Main land has 13,907,951 properties.

According to NBS, of these properties, 4,132,438 an equivalent of 29.7 percent are in urban areas and 9,776,513 an equivalent of 70.3 percent are in rural areas.

However, of the total properties, 12,717,893 an equivalent of 91.4 percent are residential properties, while 470,476 an equivalent of 3.4 percent are both residential and commercial properties.

The remaining 719,582 properties, an equivalent of 5.2 percent, are used for other various pur-

poses. The census results further state that the country's human population grew to 61.74 million, a 27.23 percent increase from the 2012 population that stood at 44.93 million.

The writer of this article has learned that the Controller and Auditor General (CAG) report for Local Government Authorities 2019/20 reveals that during the audit on land ownership it had found out that 27 district councils were possessing land valued 1.14trn/- which had not been surveyed and granted land use plans thus didn't own title deeds as required by the law.

"The negligence of not surveying, planning and formalization of land can lead into conflicts especially on land owned by district councils against host communities," recommended CAG Charles Kichere in the report adding;

"I suggest that the respective district councils survey their land, so that it can be owned legally."

On the other hand, 57 percent of Tanzanians do not own the land they live on as per findings of the FinScope Tanzania 2023 Survey administered by the Financial Sector Deepening Trust (FSDT).

In other words, as per the Population and Housing Census 2022 results 57 percent means that 35.17 million Tanzanians live on the land that they don't legally own.

The findings of the survey conducted in an interval of every six years dubbed 'Insights that drive innovation' shows that in 2017 an estimated 56 percent of Tanzanians didn't own the land they lived on.

According to the survey only 37 percent of interviewed respondents said that they personally own the land they live on. In 2017, 30 percent of respondents said that they personally own the land they lived on.

Of the total respondents picked from a sample of 10,005 aged 16 years and above conducted across 667 enumeration areas (EA) with 15 interviews per EA, shows that only six percent of Tanzanians own the land with someone else. In 2017, 15percent of Tanzanians owned the land with someone else.

#### KIGALI

Rwanda continues to witness accelerated urbanisation, and as a result, the country has attracted a sizable number of mega real estate projects mainly in the capital Kigali.

According to the Rwanda Housing Authority, Kigali was expected to achieve 15,000 housing units by 2024, with the majority of the projects to be built in the medium-term.

However, affordability remains a key concern, but this has not prevented the country from maintaining its position as one of leading destinations for business, leisure, and residence.

According to Damien Murwanashyaka, CEO of Ultimate Developers Ltd (UDL), one of the largest real estate developers in the country, the government is prioritising companies projects aimed at building affordable housing, so that residents can get homes at a cheaper and affordable price.

"UDL, in particular, is developing several projects, one of which is an affordable housing project called Vision City Two, which will be the first estate to incorporate green, smart, and wellness concepts," he said.

UDL, a subsidiary of Rwanda Social Security Board (RSSB), is the developer behind Vision City, arguably considered one of the high-end residential estates in the country.

Below, The New Times' Jessica Agasaro highlights some of the major residential and commercial real estate projects.

Located in Gacuriro, a suburban neighborhood, it will comprise of more than 1,500 units, and it is expected to be three times the size of the phase one, according to the developers.

The development of the project is currently underway.

This will be Rwanda's first Leadership in Energy and Environmental Design (LEED) gold-rated and mixed-use complex, with 29 retailers and the tallest skyscraper in the country.

The construction area will be 67,041 square metres, with multipurpose space including a bank, retail space, office space, and 430 parking spaces.

The project is located near Kigali's main roundabout, opposite the Kiyovu

The Zaria Court project in Kigali is a Giants of Africa (GOA) basketball development project in Africa that is now underway in Gasabo District.

Located in Kigali's new sports and entertainment zone, next to the newly constructed BK Arena and the under-construction Amahoro National Stadium.

President Paul Kagame and Masai Ujiri, President of the Toronto Raptors and co-founder of the Giants of Africa, laid a foundation stone at the construction site whose development is slated to be completed in November 2024, with activities beginning in February 2025.

Zaria Court will have an 80room boutique hotel, restaurants, a rooftop club, a fitness center, wellness areas, co-working spaces, and a podcast studio. A multi-purpose court in the center of the property will host

sporting events, festivals, performances, markets, and other activities.

This is a Chinese governmentfunded building project to restore and enlarge Masaka District Hospital, which will also serve as the new home of Kigali University Teaching Hospital (CHUK).

It is one of the megaprojects to be launched in Rwanda's health development hub, Masaka sector, which also houses the Africa Research Institute against Digestive Cancer (IRCAD Rwanda).

The Masaka hospital project will be finished by July 2025, and it includes the scaling up of the hospital capacity to accept 2,000 patients per day.

Construction of the multi-million-dollar shopping mall Inzovu Mall is underway and projected to be completed in September 2025, making it the largest shopping center in the City of Kigali.

The commercial mall, being built by French firm Groupe Duval through Duval Great Lakes, is located on the old Ministry of Justice premises in Kimihurura, opposite the Rwanda Parliament.

The project is expected to cost around \$68 million (approximately Rwf81 billion), and a multidimensional structure will be developed to complement the Kigali Convention Center and surrounding shopping centers such as Kigali Heights (KH) and Kigali Alliance Business Centre.

The development of the modern Kigali International Finance and Business Square (KIFBS) in the heart of Kigali's core business area began in June 2022.

The construction, a twin tower by Equity Bank Group, will cost \$100 million and will be completed within 24 months, implying that Kigali would have another high-rise skyline structure by the end of this year.

## Understanding basic hygiene and its role in public health

#### KIGALI

Personal hygiene aims to promote standards of cleanliness within the setting of the conditions where people live. Personal hygiene includes bathing, clothing, washing hands after the toilet, care of nails, feet, and teeth; spitting, coughing, sneezing, personal appearance, and other healthy habits.

Hygiene, as defined by the WHO refers to the conditions and practices that help maintain health and prevent the spread of diseases. This means more than just keeping ourselves clean. This means shunning all practices that lead to bad health. Throwing garbage on the road, defecating in the open, and many more. By adopting such a practice, we not only make ourselves healthier but also improve the quality of our lives. As is commonly said, cleanliness is next to Godliness.

Personal hygiene involves several key practices to maintain cleanliness and health. Hand hygiene, such as washing hands with soap for at least 20 seconds, is essential to prevent illness. Oral hygiene includes brushing, flossing, and regular dental visits to avoid cavities and gum disease. Daily bathing, using soap and water, and wearing clean clothes ensure body hygiene. Hair hygiene involves regular washing to prevent dandruff and maintain scalp health, nail hygiene focuses on keeping nails short and clean to avoid infections. Clothing and laundry hygiene require wearing and washing clothes regularly. Respiratory hygiene, like covering the mouth and nose when coughing or sneezing, helps prevent the spread of germs.

Maintaining good hygiene doesn't require much, it just needs access

to water, and soap-cleanliness is a mindset. Clean clothes, trimmed nails, and covering your mouth while coughing or sneezing are simple yet effective practices. Regular washing of clothes and ensuring they are properly cleaned contributes to overall cleanliness. Good hygiene is more about a consistent mindset and attention to basic practices rather than complex routines or expensive products.

Studies in developing countries evaluating interventions to promote personal and domestic hygiene in addition to safe water and food practices have documented improved health outcomes with improved hygiene practices. If we think of public health as a toolbox, then access to safe water and sanitation, along with the practice of good hygiene, are public health tools that can be leveraged to achieve the goal of good health and well-being for all.

Other tools in this toolbox include vaccinations and proper nutrition. A study in Rwanda examined the association between sociodemographic factors and diarrhoea in children under five years using the data of 7,474 households in the 2014-2015 Rwanda Demographic and Health Survey.

The overall prevalence of diarrhoea in this study was 12.7% in children under five years of Age. Another study showed that diarrhoeal disease is ranked as the third leading cause of mortality in children under five years and was responsible for 18.3% of childhood deaths in 2015 in Rwanda. A study on factors contributing to diarrhoeal diseases among children less than five years old in Nyarugenge District showed that lack of clean water and inadequate hygiene and sanitation were the biggest contributors.

## **Sunak and Starmer clash** in testy final UK TV debate

**LONDON** 

BRITISH Prime Minister Rishi Sunak and Labour leader Keir Starmer went head-to-head on Wednesday in their last debate before an election next week, with both launching highly personal attacks over their and their parties' credibility.

With Sunak's Conservatives trailing Labour by around 20 points in the polls, the prime minister went on the attack, accusing Starmer of not being straight with the country on migration, tax and women's rights, and urging voters not to "surrender" to the Labour Party.

Starmer responded that Sunak was too rich to understand the concerns of most ordinary Britons. A snap YouGov poll said the debate had been a tie, with both on 50

percent. On immigration, one of the top concerns for British voters, Sunak rejected Starmer's argument that he would seek to return migrants to their home countries, saying many had arrived in Britain from Iran, Syria and Afghanistan.

"Is he going to sit down with the Iranian Ayatollah? Are you going to try and do a deal with the Taliban? It's completely nonsensical. You are taking people for fools."

Polls indicate that Labour's Starmer is on course to win the election with a large majority, ending 14 years of Conservative rule. The two leaders have met at several debates or public sessions with voters, increasingly focusing on who was better suited to lead the country.

Starmer argued the country was ex-

"chaos", and that he would better understand the challenges of many families who have struggled under soaring inflation and a cost of living crisis.

"Part of the problem we have with this prime minister is that his lived world is millions of miles away from the lived worlds of individuals across the country, the businesses and the families that they're trying to support," he said.

Heavy criticism

Sunak's campaign has struggled since the beginning. He launched the election in pouring rain in Downing Street and hausted after 14 years of Conservative was heavily criticized for failing to at-

tend a D-Day memorial event.

He has also had to contend with a betting scandal after five party officials, including two candidates, were investigated over bets that were placed on the timing of an early election.

Starmer has also faced criticism at public events, being accused by voters of sticking to a script and being robotic, and failing to give enough information on how he would fund much-needed improvements to public services.

One questioner, Robert, seemed to speak for much of the audience when he set out his feelings. He called Sunak



### Security Council hears first-hand account of war's impact from former child soldier

**UNITED NATIONS** 

THE UN Security Council on Wednesday heard a personal testimony from a former child soldier, shedding light on the brutal reality of war in conflict zones like the Democratic Republic of the Congo (DRC).

Speaking anonymously and through an interpreter, the 16-year-old recounted harrowing experiences of abduction and forced conscription into an armed group. The child urged the council to enhance protection and security in conflict areas to ensure that children are safeguarded from the horrors of war.

"I was born into a country

conflicts," the child began. "I was forced to join an armed group while walking to school.

Two months ago, the child said, armed attacks on nearby villages targeted children for abduction, forcing them into armed groups or holding them for ransom. Schools and hospitals, the child said, are frequently attacked and repurposed as military bases.

Describing personal ordeals, the child spoke of being kidnapped and forced into an armed group, enduring beatings, looting, and the constant threat of death. "We cried and begged to return home, but they wouldn't lis-

already plagued by armed ten. They whipped us and kept us in the bush, heavily guarded, with orders to kill anvone attempting to escape," the child recalled.

Girls, the child added, were taken as "wives" by soldiers, while survival depended on meager rations of dry cas-

After three years, the child managed to escape and found support through the Congolese Government's child demobilization program. Now back in school, the child advocates for children's rights through the children's parliament. "I urge the UN Security Council to provide assistance to children affected by conflict," the child said.

The testimony was part of the Security Council's open debate on children and armed conflict, which reviewed the UN secretary-general's annual report. The report revealed extreme levels of violence against children, with unprecedented numbers of killings and maimings in 2023.

#### NATO won't be part of Ukraine conflict, it won't cross this line, says Scholz

NATO is not and will not be part of the conflict in Ukraine, Germany's Chancellor Olaf Scholz said.

"The NATO summit will discuss the strengthening of its role in coordinating support for Ukraine and training [the Ukrainian armed forces]," Scholz said at the Bundestag in regard to the EU and NATO summits, due to be held on June 27-28 and July 9-11 respec-

"It is simultaneously obvious and I find it important to state that due to what we are doing, NATO will not be part of the conflict. We will not cross this line and we are not crossing it," he said.

The chancellor claimed that NATO was unanimously concerning this issue.

"Transatlantic security is of central importance, including when we think about



Ukraine's security prospects," Scholz said. The next NATO summit will be held in the US capital on July 9-11. US officials have repeatedly stated that Kiev will not receive an

invitation to join the North Atlantic Alliance

at the Washington summit.

On July 11, 2023, the NATO summit in Vilnius adopted a final statement asserting that Ukraine's future is in the alliance, but adding that the invitation to Kiev to join NATO could be extended "when Allies agree and conditions are met." However, no possible timeline for admission was specified.

Prior to the Vilnius summit, Kiev had been making persistent statements about its aspiration to receive the membership invitation. Ukrainian President Vladimir Zelensky even said that he might not attend the summit if it made no decision to invite Kiev, but afterwards he still opted to travel to Vilnius.

In September 2022, Ukraine applied for fast-tracked admission to NATO. The alliance has repeatedly said that it is impossible to join NATO as long as the country is in a state of an armed conflict.

### US surgeon general declares firearm violence a 'public health crisis'

**HOUSTON** 

US Surgeon General Vivek Murthy issued a landmark advisory on Tuesday, declaring firearm violence in America a "public health crisis".

"Our failure to address it is a moral crisis. To protect the health and well-being of Americans, especially our children, we must now act with the clarity, courage and urgency that this moment demands," Murthy (pictured) said in a video announcement posted on YouTube.

The advisory marked the first time the nation's leading voice on public health – the same office that in the 1960s highlighted the lethal consequences of cigarette smoking – has issued an urgent pronouncement on deaths related to firearms.

Murthy said the impetus for the advisory stems from the increase in gun violence, especially mass shootings since 2020, which he said exact a profound toll on the nation's well-being.

"I want people to understand the full impact of firearm violence in our country, and I want them to see it as a public health issue," Murthy said in an interview with The Washington Post. "I know it's been polarizing, and I know it's been politicized, but if we can see it as a public health issue, we can come together and implement a public health solu-

Murthy said that as a doctor, he has witnessed the consequences of firearm violence up close, and the 40-page advisory he put out "outlines the urgent threat firearm violence poses to the health and well-being of our country".

While many applauded the advisory, gun rights groups and individuals attacked it with profanities in their social media posts.

The Firearm Policy Coalition also used profanities and called

According to the advisory, firearm-related injuries have experienced a sharp rise since the pandemic. They have surpassed car accidents to become the leading cause of death for Americans ages 1 to 19 since 2020. More than 4,600 young people died of firearm violence in 2022, 1,000 more than in 2019

In 2022, a total of 48,204 people died from firearm injuries, including suicides, homicides and accidents. That was 8,000 more than in 2019, and 16,000 more over 2010, according to the advisory.

"Fifty-four percent of adults in America report that they or a family member have experienced a firearm-related incident, whether they've been personally threatened with or injured by a firearm, lost a family member, witnessed a shooting, or shot a firearm in self-defense," said Murthy. The findings are from a recent survey.

Murthy said that firearm-related trauma and fear are contributing to mental health challenges. "Nearly 6 in 10 US adults the advisory "a joke" under the say they worry about a loved

one being a victim of firearm violence," he said.

Across all firearm-related deaths in 2022, more than half - 56.1 percent – were from suicide, while 40.8 percent were from homicide.

While the numbers fluctuate year to year, the overall trend is worrisome, according to the advisory. It noted that when measured over a decade from 2012 to 2022, children and the young populations experienced a staggering increase in firearm-related suicide rates: 43 percent for 25-34-year-olds, 45 percent for 15-24-year-olds, and 68 percent for children ages 10-14. Overall, firearm suicide increased by 20 percent across the population.

The advisory compared US firearm violence with 28 other high-income nations and said that in 2015, the overall firearmrelated death rate in age groups across the 29 countries was 11.4 times higher in the US.

In that year, 83.7 percent of all firearm-related deaths across the countries studied occurred in the US, which accounted for about 31 percent of the combined population.

Mass shootings and school shootings create collective

trauma and fear, the advisory said. It cited data by the Gun Violence Archive that the US experienced more than 600 mass shooting incidents each year between 2020 and 2023, up an average of less than 400 annual mass shootings between 2015 and 2018.

As a result, 51 percent of US teens ages 14-17 said they worry about a shooting happening at school, and 79 percent of adults said they experienced stress from a possible mass shooting, while a third said the fear of a mass shooting kept them from going to certain public places or events.

Of all firearm-related incidents, active shootings result in a large number of deaths and injuries in one incident. According to the FBI, such incidents are also on a sharp rise based on data from the past decade.

The agency released data on Monday showing that 229 active-shooter incidents occurred from 2019 to 2023, representing an 89 percent increase over the 121 such incidents from the previous five-year period of 2014-

The FBI recorded 48 active shooter incidents for 2023. Although the incidents decreased by two over 2022, the number of active-shooter incidents increased 60 percent since 2019, when there were 30 incidents.

The 48 active-shooter incidents in 2023 occurred across 26 states and happened in five location categories, including open space, commerce, education, healthcare and residence, according to the FBI.

Overall, 244 victims were shot by active shooters last year, with 139 injured and 105 killed.

The worst 2023 active-shooting incident happened in Maine in October, which left 18 people dead and 13 injured.

## Bolivian general accused of terrorism after failed coup

**LA PAZ** 

THE attorney general's office of Bolivia has accused former general commander of the Army Juan Jose Zuniga of terrorism and armed rebellion, following a failed coup against President Luis Arce on Wednesday, according to media

The office issued a warrant for Zuniga's arrest after he was detained in the city of La Paz in an operation coordinated and presided over by Deputy Interior Minister Jhonny Aguilera.

Arce also reportedly named new heads of the military. At least 9 people were wounded by bullets in the attempted coup, local media quoted the country's Interior Ministry as saying.

The Prosecutor's Office for the Department of La Paz immediately formed a commission of prosecutors to thoroughly investigate the attempted coup. Jose Luis Tarquino, head of communication of the Attorney General's Office, announced the beginning of a criminal investigation against Zuniga and others involved in the attempted coup.

"Given the latest events that occurred in the city of La Paz, the Attorney General ordered the initiation of all legal actions that correspond to the criminal investigation against Gen. Juan Jose Zuniga and all other participants in the events," Tarquino said, adding that an immigration alert was issued against Zuniga to prevent his possible escape from the country.

Amid the tension and uncertainty, Arce and his cabinet reaffirmed their

firm stance against any attempts at destabilization, and pledged to maintain peace and order in the country.

Arce, flanked by his cabinet and Vice President David Choquehuanca, also called on the Bolivian people to mobilize against an attempted coup and defend democracy on Wednesday.

Zuniga, led the troops at Plaza Murillo and other groups of uniformed men who forcibly entered the old Government Palace, adjacent to the government headquarters.

Wearing a war uniform, the military leader got out of an armored vehicle and told journalists at the scene that the move was in response to an alleged atrocity against the Armed Forces.

"Enough of impoverishing our country, enough of humiliating the military. We have come to express our annoyance," he said.

The incident happened just hours after a rumor circulated that Zuniga was being relieved of his position as commander of the Armed Forces for having made controversial political statements against former president Evo Morales.

The presence of armed troops has generated a strong response from citizens, who have begun to gather in the streets surrounding Plaza Murillo, the epicenter of Bolivia's political power, to denounce the military move.

Representatives of social organizations in different parts of the country also demonstrated in defense of democracy, joining the president's call to protect the constitutional order.

#### Zimbabwe on course to end cholera outbreak

**HARARE** 

ZIMBABWE may soon declare an end to the cholera outbreak that has affected all 10 provinces if the current trend of declining cases continues, Minister of Health and Child Care Douglas Mombeshora said Tuesday.

At least 87 people have been confirmed to have died from the waterborne disease since an outbreak was first reported in February 2023, according to the ministry. Some provinces have not reported any cases of cholera for more than a month, which is a good sign that the country is on course to end the outbreak, said Mombeshora in an interview with Xinhua over the phone.

"If we have zero cases for a month,

then we declare the outbreak over. So yes, in some provinces we can say we have no problem anymore. We have areas that have gone more than six weeks with no cases," he said.

The latest cholera situation report published by his ministry Monday showed that nine provinces had not reported any cases of either suspected or confirmed cholera that day, while Harare Province had one suspected case. As of Monday, the country has recorded a cumulative total of 34.547 suspected cholera cases and 4,217 laboratory-confirmed ones.

In November 2023, Harare, the capital of Zimbabwe, declared a state of emergency following an upsurge in cholera

## Nevada judge denies release of ex-gang leader ahead of trial in 1996 killing of Tupac Shakur

**LAS VEGAS** 

AN ailing former Los Angeles-area gang leader has been denied release from a Las Vegas jail ahead of his trial in the 1996 killing of music legend Tupac Shakur, despite a bid by a hiphop music figure to underwrite his \$750,000 bond.

A Nevada judge rejected house arrest with electronic monitoring for Duane "Keffe D" Davis, 61, saying she wasn't satisfied with assurances that Davis and his would-be benefactor - Cash "Wack 100" Jones - weren't planning to reap profits from the sale

of Davis' life story. A Nevada law prohibits convicted killers from profiting from their

Clark County District Court Judge Carli Kierny said in her ruling issued Wednesday that a review of Jones' financial records also did little to address her concerns that Jones might be a "front' or 'middleman' for the true bond poster."

Davis has sought to be released since shortly after his arrest last September made him the only person ever charged with a crime in the killing, which has drawn intense interest and speculation for 27 years.

Prosecutors allege the gunfire in Las Vegas that killed Shakur stemmed from competition between East Coast members of a Bloods gang sect and West Coast groups of a Crips sect, including Davis, for dominance in a musical genre known at the time as "gangsta rap."

Davis has pleaded not guilty to first-degree murder. His trial is scheduled for Nov. 4. If convicted, he could spend the rest of his life in prison.

After a 45-minute hearing Tuesday, Kierny said she was left with more questions than answers after Davis' legal team tried to demonstrate the source of the funds.

Prosecutors have argued that Da-

vis intends to benefit from retelling his story about the killing of Shakur and played a recording of a jailhouse phone call in which Jones describes to Davis a plan to produce "30 to 40 episodes" of a show based on his life

"It is an illegal benefit, profiting from this crime," prosecutor Binu Palal told the judge. Palal didn't respond to an email seeking comment Wednesday on the judge's decision.

Jones, a music record executive who has managed hip-hop artists including Johnathan "Blueface" Porter and Jayceon "The Game" Taylor, offered sworn testimony Tuesday by video from an unspecified place in

He said he paid 15% of the bail amount, or \$112,500, as "a gift" from his business accounts to secure Davis' release.

Davis' attorney, Carl Arnold, didn't respond to emails or phone calls left at his office Wednesday seeking comment. A spokesperson for Arnold didn't immediately have comment when reached by email.

The judge said in Wednesday's 2-page order she wasn't convinced the bail money was not being paid "out of profits from Mr. Davis discussing the killing of the victim in

this case." While Jones testified he was bonding out Davis because Davis was fighting cancer and "had been a pillar of the community," previous interviews "suggested another motive," Kierney

She said Jones indicated there were "stipulations" on the bond and "that Mr. Davis would be signing a contract regarding the rights to his life story, ostensibly including the shooting of Mr. Shakur."

She said that was supported by a recorded phone call at the jail when Jones "insisted that a contract be signed before the bond premium was paid." AP

## The areas Simba's rebuild must address

AST season when Fabrice Ngoma, Luis Miquissone and others were signed, Simba assumed they were winning the league already. One fast season forward they are rebuild-

Rebuild. That's the buzzword following Simba around wherever they go at the moment as they desperately try to put another dismal season behind them and build towards reclaiming their lost glory.

Deadwood are currently being cast aside and replaced with new names that will seamlessly click together and take the club back to the summit of the domestic game.

This time there can be no failure. Things have gotten so bad for Simba that real change is needed now, throughout the entire football club.

There is a lot for the club to consider and that's why the club investor, Mohamed 'Mo' Dewji, is back again at the front and center as they look to put building blocks in place to get back to the top.

Simba have got plenty of work to do to return to their competitive best. The priorities to get the club back on track next season start with sorting the technical bench as soon as possible.

It is perhaps a cause for concern that Simba are still no closer to appointing a successor for coach Abdelhak Benchikha, who exited the club almost two months ago.



Getting the head coach appointment right and as soon as possible is a necessity if Simba are to kick start their pre-season in the best shape possible. Hiring the right coach is an immeasurably important first step in the arduous battle ahead.

It is not hard to see where the squad needs an upgrade. The spine of the team - Che Malone Fondoh, Ngoma, Clatous Chama and Denis Kibu - is actually decent in the Premier League.

However, Young Africans possess a level of depth and quality in all areas of the pitch that Simba simply does not have. The Msimbazi Street-based side had weaknesses in many areas, which made it tough for them to sustain the pace of Miguel Gamondi's team throughout the

Simba's recruitment from 2018 to 2021 was almost flawless, but since then it has come in for some criticism as the squad depth has not been well covered pushing the club to over-rely on players at the wrong end of the age spectrum.

The unexpected exit of Inonga Baka has left more for the club to do. Lameck Lawi is an exciting addition but he is one of the future. Ideally, the player who replaces Baka in the squad from 2024/25 onwards will be somebody capable of partnering with Che Malone on the biggest of occasions.

Mohamed Hussein certainly needs more competition in his left-back role. Duchu, who was brought back last season, is not close to pushing Tshabalala to

Defensive midfield remains one of the most important issues for Simba to get right. How they have not bought an

upgrade on Taddeo Lwanga in the last two years speaks to a big recruitment problem highlighted by three underwhelming seasons.

For all his quality, Ngoma is not the man that shields his side's defence from attacks. That is the most pressing issue for Simba in this transfer win-

Babacar Sarr came in during the last transfer window and has been a fine addition. However, the team still lacks a firstteam defensive midfielder who is capable of shielding the defence singlehandedly.

The attacking force also needs some polishing. While the jury is still out on Freddy Koublan, the team certainly needs a striker who can bail them out of trouble consistently.

It is probably around more than seven players that Simba needs. But the real task will be merging them with what is already there and integrating them into the kind of system the incoming coach wants to

There have been plenty of cautionary tales concerning a drastic squad overhaul in the past that Simba would do well to remind themselves of. That suggests that patience is required, along with a coordinated and strategic plan of attack in the transfer market.

It will not be easy and it almost certainly won't be cheap, but Mo Dewji and Co will need to deliver possibly their biggest transfer window yet if they are to get Simba back to where they need to be.

The quartet's withdrawal has seen the number of participants reduced to 12 down from the initial 16 teams that had been expected to participate.

CECAFA could consider replacing teams that have withdrawn from the competition, with Police FC of Rwanda said to be the latest addition by the or-

ganizers. With more teams withdrawing from the tournament, Singida Black Stars have also been included in the tournament to replace Azam.

Young Africans are expected to play in Europe, South Africa, and Kenya during their pre-season preparations.

### **Belgium advances** to last 16 at Euro 2024 after 0-0 draw, Ukraine eliminated

STUTTGART. Germany

BELGIUM got the best out of a 0-0 draw at the European Championship on Wednesday, advancing to the last 16 while Ukraine became the first team with four points in a group to be eliminated.

The downside for the Belgians at Euro 2024 is they will next face France and Kylian Mbappe on Monday in Duesseldorf.

"We go to win. We are here and qualified for this Euro to be part of the best teams. Now, we face a top team," Belgium coach Domenico Tedesco said. "That's why we qualified, otherwise we could stay at home. These are the games we're looking for, and everything is possible.'

All four teams in Group E finished with four points. Romania ended up first, followed by Belgium and Slovakia. Ukraine was last on goal differ-

Romania and Slovakia drew 1-1 in Frankfurt and both advanced to the knockout stage.

Playing at Euro 2024 against the backdrop of Russia's invasion, Ukraine came agonizingly close to advancing and will finish with more points than at least one of the four best third-place teams. The 3-0 loss to Romania in the team's opening game proved

"In the last two games, we showed the character of our nation. But this is life, you make some mistakes, but then it's important how you react." Ukraine coach Serhiy Rebrov said. "I'm very proud of the players. Of course, everyone is unhappy with the result, but there are no questions for the play-

There was nearly a different ending when Ukraine substitute Ruslan Malinovskyi tried to score directly from corner late in the match. Belgium goalkeeper Koen Casteels managed to save the effort at the

The third-ranked Belgians had another scare when Georgiy Sudakov ran into the box but shot right at Casteels.

Belgium, which lost to Slovakia in its opening game, struggled to get its offense going again with Romelu Lukaku failing to make the most of his team's best chance in the first half.

The Belgian fans booed their players at the end of the game at Stuttgart Arena, while Ukrainian supporters, who earlier held up a banner of a fallen soldier named Nazariy Hryntsevich, showed their appreciation to the national team.

"We wanted to bring them joy, to make them proud. We left it all on the field, but it wasn't enough," Ukraine defender Oleksandr Tymchyk

Belgium will likely need to improve against France, which was the runner-up at the 2022 World Cup in Qatar.

### Venezuela advances to Copa America quarterfinals with a 1-0 win over Mexico on Rondón goal

INGLEWOOD, Calif.

ARRIVING at Copa America seeking redemption after disappointing performances in the World Cup and in the CONCACAF Nations League, Mexico is on the verge of an early exit.

Salomón Rondón scored on a penalty kick in the 57th minute, and Venezuela advanced to the Copa America quarterfinals with 1-0 victory over Mexico on Wednesday night.

.Venezuela, which opened with a 2-1 win over Ecuador, is assured finishing among the top two in Group B. Venezuela faces already eliminated Jamaica on Sunday at Austin, Texas.

"I'm happy that we were able to give some joy to the people in Venezuela, we played for that, but we need to remain calm and with our feet on the ground," Venezuela coach Fernando Batista said. "We are going to enjoy this tonight, but tomorrow we are going to be focused on Jamaica."

Mexico began with a 1-0 victory over Jamaica and has three points along with Ecuador, which defeated the winless Reggae Boyz 3-1 earlier Wednesday. Mexico plays Ecuador at Glendale, Arizona, on Sunday, and needs a victory to advance.

"It's a learning experience, but I'm proud of the team because they never stopped fighting. Now it's up to us and we just talked about it in the locker room," Mexico coach Jaime Lozano said. "The next game will put us in the next round, we are hurt now, but playing like this, it's going to be hard for us to lose another game."

Meanwhile, in Las Vegas, seventeen-year-old Kendry Páez scored in first-half stoppage time, Alan Minda added another goal late in the second half and Ecuador beat winless Jamaica 3-1 on Wednesday night in the Copa America.

Ecuador, which rebounded from a 2-1 loss to Venezuela, won its first Copa America game since a 4-0 victory over Haiti in 2016, stopping an eight-game

Jamaica became the first team eliminated from the 16-nation tournament when Venezuela beat Mexico 1-0 later Wednesday.

For Napoli forward Kvaratskhelia, the win even surpasses his club's historic Italian title last year.

"This is the best day in my life because it was more difficult to do it with the Georgian team than with Napoli," he

A banner at the Georgian fans' end of the stadium said "Believe," and they did.

The Georgians needed a win to reach the knockout stage at Euro 2024 and got their opening goal after only 93 seconds.
