Electronic exam marking tool to check irregularities

N ELECTRONIC system for marking examination papers has been installed at a cost of 550m/- to control errors in marking and lock out cheating, the government has stated.

Prof Adolph Mkenda, the Minister for Education, Science and Technology disclosed this yesterday when addressing reporters on achievements attained during the one year of leadership by President Samia Suluhu Hassan

The locally created system is said to be the first in Africa, where every examination marker will have a tablet or a computer, mark one question that will be verified by another marker and thereafter given a mark without knowing the name of the candidate or their index number, he said.

This innovation is meant to minimize marking errors, with the Minister expressing pride for its local sourcing as earlier the ministry had to use external experts. Now they will be Tanzanians themselves, he stated.

Glancing at schools for talented students, the Minister said he will be making a follow up on students earmarked to join schools with special talents, going through the lists after NECTA makes allocations for those schools.

'TRA, law enforcers bribery cases fewer'

A VAST majority of interviewed members of the public (77 per cent) believe that the level of corruption in the country decreased over the past year, saying this has to do with efforts by the government and stakeholders to fight the vice

A new Afrobarometer survey released by the leading economic research outfit, REPOA yesterday says bribery incidents had declined in public agencies like the Tanzania Revenue Authority (TRA), the Prevention and Combating of Corruption Bureau (PCCB), the judiciary and the police.

The 2021 report of the opinion survey outfit says that popular perceptions of corruption in key public institutions show a decline across

Tourism players meet, lash at Kili car project

OVER 500 players in tourism industry met here yesterday to discuss government plans to install a cable car for sight-seeing on Mount Kilimanjaro, opposing the idea due to projected massive job losses and environmental degradation.

During the meeting a total of 558 tourism players in northern Tanzania voted against the million dollar cable car project on the mountain, arguing that the business plan of the cable car project does not make commercial sense for the country's economy.

Its ecological damage overhang outweighs expected benefits, while it will not create substantial employment for those now depending on mountain climbing to earn a living.

Mwinyi opens editors' meet

Blue Economy focus drawing editors from six other countries

ZANZIBAR authorities have lauded the role of the media in the Isles saying that the government depends on the contribution of the media in achieving key development priorities including the blue economy agenda.

Zanzibar President Dr Hussein Ali Mwinyi declared yesterday that this vital agenda calls for the sustainable use of ocean resources for economic growth, when opening the sixth general meeting of the Tanzania Editors Forum (TEF).

He said TEF was the best platform for journalists to

pursue the country's development agenda while informing the general public in simple language to convey what blue economy agenda was all

Journalists and media practitioners need to make use of such forums to seek to understand the issues involved and advise on how

best to implement development priorities, he affirmed.

This is the time to review laws hindering the realization of media freedom as it is essential in working to achieve development priorities, he stated.

"This effort is intended to make sure they are qualified to join those schools, and if I find a person has inserted his son/daughter without valid criteria, I will remove the name and put another one. I will be very strict on this," the Minister declared.

Ministerial consultants are still reviewing the curricula, with a team of experts currently present in Morogoro for the task, to issue a draft of recommendations to be referred to the stakeholders' forum in May, he explained.

"We are going through our curricula and policies; we are still debating whether the basic schooling period should be up to Std Seven or Std Ten, and what will be of existing infrastructures and teachers. We do not want to go to our stakeholders emptyhanded, but with a draft so that it is debated and improved," he elaborated.

The ministry does not want to decide on the matter by itself and that is why the government has opened doors to all stakeholders to give their views on the structure of primary and secondary education, whether it responds to current needs, how we can remove our children from cramming things they do not apply anywhere later, he pursued.

New schools being constructed are around 245 ward schools costing 180bn/-, while in the capital a boarding secondary school housing more than 1,000 students is being built, at 17bn/- estimated cost, he

Vocational education colleges will also be built in various areas countrywide, with a flagship college in Dodoma taking up 17.9bn/-, to increase the capability for those graduating to employ themselves, he asserted.

Plans are also afoot to establish a new campus of the University of Dar es Salaam (UDSM) in Lindi, in the wake of a directive from President Samia Suluhu Hassan. VETA colleges will also be built in Lindi and Mtwara regions, the minister added.

Museveni's son **Muhoozi retiring** from the army

KAMPALA

The Uganda People's Defence Force's (UPDF) Commander of Land Forces, Lt Gen Muhoozi Kainerugaba, on Tuesday announced that he is retiring from the army after more than two decades of service.

"After 28 years of service in my glorious military, the greatest military in the world, I am happy to announce my retirement," the powerful Ugandan First Son wrote on Twitter, a platform that has recently become his major tool of public communication.

Muhoozi who rapidly but vertically rose through the ranks of the army March 8 said "he and his soldiers have

achieved so much.' Available records indicate that Muhoozi, who if released could become one of the youngest people at his rank to be granted retirement from the army, became a serviceman in 1999 as a cadet officer.

"I have only love and re-

spect for all those great men and women that achieve greatness for Uganda every day," the man elevated to the rank of a Major General in 2016 observed.

Mainstream social media services including Twitter and Facebook remain dominated by messages touting First Son Muhoozi as the next Ugandan president although the 47-year-old has not publicly declared interests.

Meantime, his intent to retire remains a subject of the army's approval under the UPDF Act, 2005.

"An officer may in writing tender the resignation of his or her commission to the board but shall not, unless otherwise ordered by the Chief of Defence Forces, be relieved of the duties of his or her appointment until he or she has received notification, in writing, of the approval of his or her resignation by the board," reads section 66 (1) of the Act.

the board, and the proportion of Tanzanians who approve of the way the government is handling the war on corruption has nearly doubled since 2017.

Eight in 10 Tanzanians say the level of corruption has decreased somewhat or a lot over the past year, with two-thirds (65 per cent) of those interviewed saying that the Office of the President is free of corruption. Around half (51 per cent) said the same about the legislature. Fewer respondents than in 2017 see government officials as corrupt, it asserted.

Just one-fourth (23 per cent) of citizens say most police officers and perhaps all of them, are involved in taking bribes, down from 36 percent in 2017. About one in 10 respondents say most or all judges and magistrates, civil servants and tax officials are corrupt, the report noted.

Speaking during the presentation event in the commercial capital yesterday, REPOA executive director Dr Donald Mmari said that the findings show that Tanzanians are satisfied with the way the government is working to fight corruption and graft.

The data was released as the government continues to wage war against economic sabotage, registering record revenue collections by the TRA, while PCCB recovered public funds which could have been embezzled, he said.

The survey findings suggest that the government's intensified anti-corruption efforts are paying off. Many government agencies which were widely perceived as corrupt have improved and this continues to build public trust, he stated.

More Tanzanians believe that they can make a difference in the fight against corruption but the ties.

majority says people are afraid of retaliation if they report bribery incidents to authorities, it said.

"The fear of reporting incidents of corruption remains a barrier to an effective anti-corruption fight," the director underlined.

Dr Omari Mzee, the control assistant director at PCCB commended RE-POA for its investment in research which helps the country to measure successes in addressing challenges facing the society, noting that political will, preventive approaches and strengthening accountability systems are among major factors in the decline of corruption in the country.

THE National Institute of Transport (NIT) has urged female students to pursue science subjects as a move to improve gender balance in major areas of concern.

Somalia's worst drought in decades escalates - study

Somalia is in the middle of its worst drought in decades, with millions of people in need of aid and thousands on the brink of starvation. The United Nations estimates 4.3 million Somalis are affected by the drought and more than half-a-million displaced.

Baidoa already hosts over 400,000 internally displaced Somalis but more people affected by drought are flocking to the town every day in search of food, water, and shelter.

Somalia's southwest state is one of the areas worst hit by a record drought not seen in decades.

Forty-seven-year-old Ali Adan Hassan's livestock died in the drought, and in late February his family of seven ran out of food.

A blockade by al-Shabaab insurgents made it impossible for aid to reach his district in the Bakok region. So Hassan set out on foot to Baidoa, a journey that took two weeks.

have a car or money to pay for a donkey cart, so they trekked more than 200 kilometer for 15 days to reach Baidoa. During the journey, he said, his wife and 3-year-old child died from hunger and thirst. He had to bury them along the way Baidoa is battling water

shortages and an influx of villagers like Hassan, fleeing drought and starvation.

Single mother Mumino Moalim Osman, 40, lives in one of the Baidoa's internally displaced persons camps with her 10 children. Her husband died seven years

She told VOA they arrived in late February after walking for two weeks from Bokoro village.

They had a mother camel for milk, said Osman, but it died and only the baby camel remains.

She feeds the baby camel the same tea she gives her children, said Osman. The camel is her life, said Osman, of income is livestock, which

He said his family didn't and it must survive.

Adan Farah is an adviser for U.K.-based aid group Save the Children. She told VOA millions of Somalis are in dire need.

"According to rapid needs

assessment conducted by Save the Children, 3.9 million people across Somalia are not able to access food, in which 1.8 million people are facing severe food insecurity," she said. "The ongoing drought has plunged the majority of the population into food insecurity. The key drivers of acute food insecurity in Somaliaincludethecombined effects of consecutive seasons of poor and erratic rainfall

distribution and conflict." Daud Adan Jiran, Somalia director for the U.S.-based aid group Mercy Corps, recently visited Baidoa and met with displaced families.

"Somalia's situation is deteriorating," he said. "There is a severe water and food shortage. Most of these communities' primary source

has died. Crops have failed, so there is no food. Families have depleted what little reserves they had. If we don't get rain in April, we may be on the verge of a repeat of the 2011 famine disaster."

The U.N. says the 2010-12 famine, at the time the first in nearly a decade, killed a quarter-million Somalis, half of them children under the age of 5.

Baidoa community activists Nadeef Abdishakur Mohamed told VOA there is still time to prevent another famine.

"The government and humanitarian agencies must act now to avert a crisis

similar to the famine of 2011," Mohamed said. "As someone who is working with the people on the ground, I am here to tell everyone that it's not too late to provide. They can provide emergency water trucking, medicine for the dehydrated and malnourished, and fodder for the livestock of nomads.

Govt finds solution for dying livestock due to the drought

LIVESTOCK and Fisheries minister Mashimba Ndaki has said in order to fight the issue of dying livestock due to lack of fodder, they have come up with a solution - a new technology dubbed Juncao to be distributed to

Ndaki made the remarks in Dar es Salaam yesterday when opening a meeting for discussing the Juncao technology that will soon start to be used by herders countrywide.

He said Tanzania wanted the technology to be used because they want to close a gap brought about by shortage of animal fodder.

He said they had asked for assistance from China and talks have reached at advanced stage in regard to being provided with the technology.

He said it would be re-

struck in some areas of the country that saw livestock dying due to lack of fodder and water.

He added that the technology will help animal fodder producers to increase production as well as increasing the quality of livestock for more economic benefits.

Ndaki added that after the meeting, a process in procurement Chinese government permit will be made and believes that the process will be finalised within one month.

He said thereafter, they will begin providing education on Juncao technology to all stakeholders, universities, colleges and other government institutions, after which they will go to livestock keepers.

TANZANIA is determined to become the champion in gender statistics in Africa after commencement of three years program called the 'making every woman and girls count' to further develop gender sta-

Statistician General Dr Albina Chuwa unveiled this in Dar es Salaam yesterday when speaking at the WiDS Africa Hybrid Conference, which was about the role of data science in women's health and safety held at Data Lab offices in Mikocheni.

She said the main objective of UN Women funded project is to ensure that gender statistics are available, accessible, analyzed to inform policy making for delivering gender equality and women's empowerment.

Dr Chuwa said the primary responsibility of the national statistics body is to produce quality statistics including in gender and avail them to policy makers, decision makers and other stakeholders for applica-

"Through data we can reveal gender inequality and gender gaps in terms of implementing various gender inequality programmes to enable policy and decision making," she said.

She added that gender data has increasingly been recognised as fundamental to achieving the sustainable development goals.

"This recognition is the acknowledgement that there will be no progress if we do not understand the lived experience of women and girls in all their diversity including their challenges and contributions," she said.

Either, she said gender data illuminates the path forward and can help ensure that the rights of all communities are upheld, protected and respected.

She said the three years programme has helped them to align gender statistics to the national development agenda and it is important to understand that gender data goes well beyond sex disaggregation.

She said contrary to popular belief, gender data is not only on women or women's issues but it encompasses the full

range of the life cycle intersecting with all sectors from getting a decent job and feeling safe at home and in public spaces.

She added that gender data also pays specific attention to women and men's different realities and how those interact with other forms of individual characteristics.

"For instance, data shows that more than 70 percent of women in Tanzania are engaged in agriculture sector, 3.4 percent of women are employed in the manufacturing sector and in services industry they occupy 26.4 percent," she said.



"This recognition is the acknowledgement that there will be no progress if we do not understand the lived experience of women and girls in all their diversity including their challenges and contributions," she said.

She added that through such data, key stakeholders can make informed decisions that would affect real people adding that as data community they recognize that they must bring voices of communities to life in the road to achieving the Sustainable Development Goals (SDGs).

She said among the goals are to encourage girls to pursue science subjects and increase the number of women employed in the engineering industry.

Speaking about the digital economy and the role of women, she elaborated that in order to make sure we are not left behind in the age of the fourth industrial revolution and digital revolution Tanzania has made great strides in engaging a digital economy.

"I commend dLab for their great job in digital economy, we have been working closing with them for the past four years now together with other partners in creating a data roadmap that is among frameworks needed to take us there," she

African farmers need investment

nvestment in agriculture is a key for economic growth and job creation among Africa's farmers, but significant constraints remain before they can fulfill that potential. Lack of funding is one of the main challenges faced by Tanzania's agriculture sector. Though the sector employs over 84 per cent of the local population, banks have shunned it arguing that it is risky, a situation that has affected its growth and left its huge potential largely unexploited.

However, this financial challenge could be addressed if government and the financial sector embraced priority sector lending approach. This approach is an effective tool in achieving developmental goals of an economy whereby government gives priority to a particular sector(s) to acquire funding loans at low interest rates. Therefore, under priority sector lending banks give priority to particular sectors when giving loans.

In developing countries, priority sectors could include agriculture sector, small scale industries, cottage sector, handicrafts, entrepreneurship projects, exports sector, infrastructure projects, low-cost housing, and other areas based on developmental goals of economy.

Tanzania being a country had attained middle class economy has to achieve developmental goals, including improving agriculture and related sectors as a part of its inclusive growth

The country's agriculture sector has high potential and is one of the top three contributors to Tanzania GDP and exports growth, but a lot of this potential is unexplored. The sector has a high percentage of smallholder farmers that has left it largely underdeveloped.

This can also be attributed to challenges like small farm size, low productivity, dependence on seasonal rains, lack of required infrastructure, and unskilled manpower. The smallholder farmers need to access finance to enhance their potential and contribution toward national development.

In addition, within the local agriculture sector, there are some potential unexplored projects that can

contribute towards rural development. Initiatives like increased use of greenhouses, drip irrigation, as well as land conservation, watershed projects, and intensification of crop cultivation and animal husbandry are not fully explored. Other areas are building the technical and organisational capacity of farmers, promoting commodity chains and agribusiness.

The major source of finance to agriculture in Tanzania include Saving and Credit Co-operatives (SACCOs), micro-finance banks, co-operatives, commercial and development banks. Of these, SACCOs are the main source of finance for rural agriculture sector, other sources provide only small portion of loans to agriculture, especially smallholder farmers.

Financial services are also unevenly distributed in the country, and rural areas, in particular, are still underserved.

Instituting a priority sector lending policy can help in solving financial need of agricultural sector development in

So, there is need for priority sector lending policy to ensure commercial banks and development banks lend to farmers as a part of inclusive growth strategy.

Major elements of priority sector lending in banks should be provision of certain percentage of their loans to agriculture sector and other priority sectors; opening of rural branches or hard-to-reach and remote areas in the country; while loans to agriculture should be subsidised and at low interest

Loans could be divided into shortterm, medium-term and long-term. Under such an arrangement, SACCOs could cater for short-term loans, commercial banks for medium-term and agriculture development banks for longterm loans.

This model of priority sector lending was adopted by India as a part of agriculture development and financing strategy in 1970s and has been very successful in helping growth and modernisation of rural economy.

Chief Justice slams prosecution bosses in Lesotho treason trial

wo advocates of the Lesotho High Court, involved in a high-profile treason and murder trial, have become the latest to experience torture, death threats and other ill-treatment at the hands of the local police. As Carmel Rickard explains, reference to their experience was made by Chief Justice Sakoane Sakoane in an extraordinary judgment refusing to recuse himself from presiding over the trial.

In his decision he was scathing about the behaviour of the country's Director of Public Prosecutions, and her colleague, controversial South African advocate and former prosecutions boss, Shaun Abrahams. He laid out their behaviour and its potential for further delaying the start of the trial, mentioning that the two advocates had not been in court on a certain day because one was recovering from police torture and the other was in hiding from police death threats. However, alarming as these two incidents may be, they are just the latest examples of police brutality, an ongoing problem in Lesotho. There could be a difference this time though: the police targeted counsel and so the issue is back on the radar of the Chief Justice, known to be a strong opponent of such behaviour.

It comes as a shock to read a judgment by no less a person than the Chief Justice of Lesotho, and find him stating as fact that an advocate who should have appeared in court before him on a certain day, did not do so because he was recovering from torture at the hands of the country's police.

A second advocate was said by the Chief Justice, Sakoane Sakoane, to have been absent from the same court session because of police threats

But that is an indication of the growing problem of police brutality, often amounting to sheer lawlessness, in Lesotho.

The reference to police treatment of counsel emerged last week, when the CJ delivered a hard-hitting decision in response to an application that he recuse himself from presiding in a high-profile murder and treason case.

The recusal application was brought by the Director of Public Prosecutions, Hlalefang Mary Motinyane. She said that she brought the application because the CJ 'has not and will not bring an impartial mind to bear' on the case. Justifying her application, she gave an account of what had happened in court when the trial of former Lesotho defender force commander,

In his judgment on the recusal application, the CJ made scathing comments about the behaviour of both Motinyane and the lead prosecutor handling the case, Motinyane's controversial former South African

He explained his decision to bar Abrahams from further appearance in the case, and said that there was no

He said Abrahams had absented himself from court, without permission from the court, and had 'double booked' (been involved in another case at the same time). He had done so, said the CJ, after originally committing to the trial dates of 10-21 January, fully realising 'that doublebooking is a sanctionable professional misconduct.

When the DPP had later made an application for postponement of the case because Abrahams was not there, 'misleading information' was put before the court in support of her application and, said the CJ, Abrahams had been the source of that misleading

Much of the CJ's judgment and its findings was placed in the context of the Speedy Court Trials Act, under which an entire trial could be 'dismissed' by a court if it found that the prosecution improperly delayed the start of a case. The law also allows the court to bar a

if there has been double booking that contributes to delays.

When Abrahams was absent from court on 10 January, and another member of the prosecution team asked for a postponement, the CJ warned of the possible consequences, under the Speedy Court Trial Act, should the application be unsuccessful. Counsel then immediately withdrew the postponement application.

The CJ also made it clear that, in her application for his recusal, the DPP was basing her reconstruction of what had been agreed to in relation to dates and counsel's appearances, on what Abrahams had told her, rather than on what the record disclosed.

Given the extraordinary nature of this judgment and its serious findings against Lesotho's top prosecuting officials, as well as the high-profile trial itself, with prominent former members of the military among the accused, it would be understandable if a reader missed the CJ's reference to police torture in the judgment.

It came in the course of his decision, when the CJ explained that on 10 January there had been a postponement until 14 January to allow counsel for one of the accused to bring an application to quash his indictment. However, said the CJ, 'Unfortunately, argument on that day was not heard because of the absence of two defence lawyers, Mr Mafaesa and Mr Letuka, who had been tortured and threatened respectively by the police.'

Although that was the only reference to the police detention and torture of Mafaesa, a prominent human rights lawyer, in the CJ's decision, he has in fact dealt with it on other occasions.

When Mafaesa's detention and torture were raised in court to explain his non-appearance, the CJ responded angrily and asked what the DPP was doing about the police torture, saying they should immediately be prosecuted.

He also asked why the Lesotho law society had merely 'negotiated' with the police over Mafaesa, writing a letter to the police commissioner, instead of bringing court action against the

In the case of Mafaesa's colleague, Kabelo Letuka, he was threatened with death by police after he filed an urgent application against the police for Mafaesa to be brought from detention to court. Letuka then went into hiding.

Local media report Letuka as saying that he still did not feel safe, even after the High Court issued an order against the police that barred them from mistreating him in any way.

Mafaesa, who was treated in hospital after his release, confirmed his unlawful handling by police and commented: 'Sometimes human rights lawyers get to taste the same medicine given to your clients.'

Mafaesa was arrested by police after a client, interrogated and tortured by police in relation to a robbery charge, falsely implicated Mafaesa to get the police to stop their torture. The police wanted to know the whereabouts of the gun used in the robbery, and the client said that he had given it to

Speaking after his release, Mafaesa said that his client had been tortured before and that he (Mafaesa) had obtained a court order against the police, barring them from doing so again. Armed with this court order, he took his client back to the police who were looking to arrest him again. However, the police did not heed the order, and repeated their assaults.

These incidents of police brutality are just the latest in a long history of similar behaviour in Lesotho. Despite strong words from the courts and high damages awards made against the police, the unlawful interrogation methods have not stopped.

The latest incidents, in which two advocates were directly affected, seems to have raised the ire of the CJ, well known to be strongly opposed to police brutality. Whether he will be able to find a way to hold the police to account this time remains to be seen.

Chronic kidney disease is still major health challenge in Africa

lose to three million people from chronic failure the world receive renal replacement therapy every year. But between 4.9 million and 9.7 million more still need treatment. And at least two million die because they cannot

Experts say kidney diseases do cost households dearly because most people discover about their conditions after the disease had reached advanced

We should aim at increasing education and awareness about effective symptoms management and patient empowerment.

Statistics show that ten per cent of the global population has some form of kidney problems.

Although there are no recent statistics on the situation in the country - a 2004 study on kidney diseases found that 6.7 per cent of the population had a chronic kidney problem, with the main reason being low awareness of kidney

Most chronic kidney patients seeking MNH treatment are those who have reached the fourth and fifth stages - and, hence, needing blood dialysis or kidney transplant. In stages one to three, the patient is tested, treated and recovers. Stages four and five are when the patient must be put on blood purification or kidney transplant.

It is advisable for people to come forward for testing and treatment in the early stages. Chronic kidney disease is complex and expensive but can be prevented or treated in the early stages.

According to experts at an advanced stage, the disease kills quietly because a person can have it up to 90 per cent without seeing any symptoms. This is why it is crucial to go for check-up, and contain the disease in its early stages,

Also experts warn that those having high blood pressure and diabetes must check their sugar and salt intake. Symptoms include swelling of the face (eyes), swelling of the legs, loss of appetite, nausea, becoming anaemic

and fatigue, The medics revealed that, at MNH currently, the number of people on dialysis was about 1,000 while 50 were about to undergo kidney transplants.

Community radios: Tools of empowerment, development at grassroots

OMMUNITY play a significant at grassroots level for rural development, highlighting issues such as poverty, local politics, agriculture, gender inequality, education and health.

Speaking at a Policy Forum breakfast debate with the theme 'The Role and contribution of community radio in fostering accountability for development: Challenges and successes' held in Dar es Salaam last weekend, stakeholders called for more investment in such stations especially where there are none.

Malekela, Gerald Programme Director at Iringa-based Nuru FM said community that communities to enable discuss root causes of development challenges they face instead of just complaining about symptoms.

He said that community radio stations look for solutions and assume the responsibility of finding solutions for the same unlike in the past when communities just waited for authorities at national levels to solve problem at the grassroots.

"Community radio stations are more effective when local people produce and broadcast their own programmes and participate in runing the station. It is a community space for people to meet and collaborate.

Yusuph Hassan, broadcaster at Dodoma FM, said that the community radio has played a crucial role in enhancing awareness on major obstacles to the region's social, cultural, economic, political and general development issues.

He said that the station in particular and others across the country have done a good job and merit assistance so that they continues with their role of helping make life in Tanzania communities more meaningful.

Baraka Jamal of Mtwarabased Safari FM said that the station brought to light many incidents of injustice and criminality at the grassroots level that previously went unreported by the mainstream media. Some of the issues the station reported and action taken by authorities include cases of gender based

violence. "We have been attending village meetings and raising awareness on issues touching on peoples' daily lives. When their voices are heard, they feel empowered," he said.

Community radio stations are owned, operated and wholly or partially funded by the communities they serve. They are mostly non-profit and provide a mechanism for enabling individuals, groups, and communities to tell their own stories, to

share experiences and, in a mediarich world, to become creators and contributors of media content.

The stations facilitate several capacity-building activities within a community through exchanging information, networking of groups, provision of skills and training as the key elements of developing a community.

Jamal added that indigenous community radio stations around the globe serve an important role in delivering relevant information to communities in indigenous languages that directly impact their lives. Such stations are constantly adapting to technological challenges, such as going from AM to FM, and from analogue to digital.

Many also access information via superhighway that is the internet, although often with limitations. Internet access is an issue that radio stations continue to discuss and demand.

Despite economic limitations such as lack of infrastructure, low and poor quality connectivity and content competition, the community radio stations that have been able to access the internet are now expanding their coverage and engaging with a broader audience and expanding their reach.

Policy Forum Manager fpr Advocacy and Engagement Elinami John said that community radio do not only continue to be key media for transmission and revitalization of indigenous languages, cultures and worldviews, they also continue to be primary media to inform and communicate issues that affect and interest the constituencies they serve, especially rural communities where reliable internet access is lacking.

"A community radio should be used to sensitise gender issues and amplify voices for the voiceless," he said.

He called upon community radio sttions to continue sensitizing citizens and enable them hold their leaders accountable. John further noted that it is high time for the communities to

use these stations to uncover serious issues happening at the grassroots but that go unreported.

The relatively low cost of setting up a physical radio station for immediate use makes radio advantageous over digital radio. In addition, broadcast radio serves as one of the main means community of its interest. It is for accessing audiences who do not have internet access, he said.

Makumba Mwemezi from HakiElimu said that the media in general have a duty to bring about accountability in local and national governance, hence development.

"The media act as a bridge between citizens and the service providers. Therefore, citizens have the right to reach the media they want," he said.

"A community radio seeks to help people become responsible. It seeks to help people go beyond silence and complaining to assuming responsibility for the problem and trying to solve it."

Studies have shown that community radio in Africa have presented themselves as efficient media capable of serving rural communities where they are based by touching on their occupational needs.

This is chiefly in agriculture, animal husbandry and fishing for residents of areas along the coast, in lake zones and near rivers, from where they have been waging the war against poverty, illiteracy, diseases and other social and economic ills.

Community radio in this regard provides a set of participatory communication techniques that support agriculture extension services by using local languages to communicate directly with farmers, herders and fishers.

Through media skills training and access to the airwaves, a community radio facilitates a number of capacity building activities. The exchange of information, networking of groups, provision of skills and training are key elements of developing a community.

A radio for a community facilitates provision of awareness of community

groups and facilities in the area as well as providing the avenue for the empowerment of groups to use radio to promote themselves and to speak directly to the community.

Thanks to proximity to its clients, a community radio serves a local accessible to the community in terms of ownership, decision-making and programme output. In the majority of cases, programming is produced by the community with focus on local concerns and issues. Unlike in the case of the mainstream media, rather than merely talking about the community, the people themselves make the programmes.

This strengthens local culture with the recognition that this is their station; it becomes a forum for a diversity of local opinions and views. Therefore, women are more likely to benefit from technology-mediated opportunities for development if they themselves produce content that contributes to their advancement rather than simply consuming information provided by

So far, Zambia, Ghana, South Africa and Tanzania are the only countries in Africa known to have enacted laws through their legislatures to allow community radios to operate. Community radio in Africa has been of immense benefit to the society by bringing people and communities together partly through religious events as well as by resolving land and other disputes, creating job opportunities, promoting education, health and democracy, as well as helping the government in combating corruption and other forms of crime.

However, most of the community radio stations have been facing crippling financial constraints that have seen most limp on only thanks to support from local and foreign donors and volunteers too committed to the cause than to seek greener pastures elsewhere.

Changing a system that exploits nature and women, for a sustainable future

6 Pachamama (Mother Earth) is upset with all the damage we are doing to her," says Hilda Roca, an indigenous Peruvian farmer from Cusipata, in the Andes highlands of the department of Cuzco, referring to climate change and the havoc it is wreaking on her life and her

From her town, more than 3,300 meters above sea level, she told IPS that if women were in power equally with men, measures in favor of nature that would alleviate the climate chaos would have been approved long ago. "But we need to fight sexism so that we are not discriminated against and so our rights are respected," said the Quechua-speaking farmer.

The link between climate change and gender is the focus of the United Nations' celebration of this year's International Women's Day, Mar. 8, under the theme "Gender equality today for a sustainable tomorrow".

The aim is to "make visible how the climate crisis is a problem that is closely related to inequality, and in particular to gender inequality, which is expressed in an unequal distribution of power, resources, wealth, work and time between women and men," Ana Güezmes, director of the Gender Affairs Division of the Economic Commission for Latin America and the Caribbean (ECLAC), told IPS.

Latin America is highly vulnerable to the climate crisis despite the fact that it emits less than 10 percent of the greenhouse gases that are warming the planet.

In addition, climate injustice has a female face in the region: lower-income population groups, where the proportion of women is higher, are more exposed to climate effects due to their limited access to opportunities, despite the fact that they are less responsible for

The extreme poverty rate in the region increased from 13.1 percent to 13.8 percent of the population - from 81 to 86 million people - between 2020 and 2021, according to data released by ECLAC in January. Women between 25 and 59 years of age are the most affected compared to their male counterparts. This situation is worse among indigenous and rural populations, who depend on nature for their livelihoods.

These aspects were highlighted at ECLAC's 62nd Meeting of the Presiding Officers of the Regional Conference on Women, held Jan. 26-27, whose declaration warns that women and girls affected by the adverse impacts of climate change and disasters face specific barriers to access to water and sanitation, health and education services, and food security.

And it is women who are mainly responsible for feeding their families, fetching water and firewood, and taking care of the vegetable garden and animals.

"That is why we maintain that

the post-pandemic recovery must be transformative in terms of sustainability and equality," Güezmes emphasized from ECLAC headquarters in Santiago, Chile.

To this end, she said, this recovery "must untie the four structural knots of gender inequality that affect the region so much: socioeconomic inequality and poverty; the sexual division of labor and the unjust organization of caregiving; the concentration of power and patriarchal, discriminatory and violent cultural patterns; and the predominance of the culture of

Reconciling with Mother Earth

Luz Mery Panche, an indigenous leader of the Nasa people, discussed the need to incorporate a gender perspective into the climate crisis. She talked to IPS from San Vicente del Caguán, in the department of Caquetá, in the Amazon region of Colombia, a country facing violent attacks on defenders of land and the environment.

For her, more than sustainable, "it is about moving towards a sustainable future."

"We need to change the conditions that have generated war and chaos in the country, which is due to the hijacking of political and economic power by an elite that has been in the decision-making spaces since the country emerged 200 years ago,"

Panche is a member of the National Ethnic Peace Coordination committee (Cenpaz) and in that capacity is part of the special high-level body with ethnic peoples for the implementation of the peace agreement in her country. She is a human rights activist and a defender of the Amazon rainforest.

She argued that to achieve a sustainable future "we must reconcile with Mother Earth and move towards the happy, joyful way of life that we deserve as human beings."

This, she said, starts by changing the economic model violently imposed on many areas without taking into account the

use of the soil, its capacities and benefits; by changing concepts of economy and the educational model; and by organizing local economies and focusing on a future of respect, solidarity and fraternity.

Panche said that in order to move towards this model, women "must have informed participation regarding the effects of climate

"Although we prefer to call Mother Earth's fever 'global warming'. And it is up to us to remember to make decisions that put us back on the ancestral path of harmony and balance, what we call returning to the origin, to the womb, to improve coexistence and the sense of humanity," she said.

Changing times: another kind of coexistence with nature and equality

Lilian Celiberti, Uruguayan ecofeminist and founder of the non-governmental Cotidiano Mujer and Colectivo Dafnias, told IPS from Montevideo that governments have the tools to work on gender equality today in order to have a sustainable future tomorrow, as this year's Mar. 8 slogan states.

But against this, she said, there are economic interests at play that maintain a development proposal based on growth and extreme exploitation of nature.

She called for boosting local economies and agroecology among other community alternatives in the Latin American region that run counter to the dominant government approach.

"But I believe that we are at a very complex crossroads and that only social participation will be able to find paths of multiple, diverse participation and collective sustainability that incorporate care policies and awareness of the eco-dependence of human society,"

Celiberti said "we are on a planet of finite resources and we have to generate a new relationship with nature, but I see that governments are far from this kind of thinking."

ECLAC's Güezmes emphasized that social movements, especially those led by young indigenous and non-indigenous women in the region, have exposed the multiple asymmetries and inequalities that exist.

"We have an intergenerational debt, where young women have put at the center of the debate the unsustainability of the current development style that has direct impacts on our future at a global level and direct impacts on their livelihoods, territories and communities," said Güezmes, who is from Spain and has worked for years within the United Nations in several Latin American

She recognized the contribution of feminist movements that focus on a redistribution of power, resources and time to move towards an egalitarian model that includes the reduction of violence.

And she warned that from a climate perspective, the window of opportunity for action is closing, so we must act quickly, creating synergies between gender equality and climate change responses.

Güezmes said that "we are looking at a change of era" with global challenges that require a profound transformation that recognizes how the economy, society and the environment are interrelated. "To leave no one behind and no woman out, we must advance synergistically among these three dimensions of development: economic, social and environmental," she remarked.

The expert cited gender equality as a central element of sustainable development because women need to be at the center of the responses. To this end, ECLAC plans to promote affirmative actions that bolster comprehensive care systems, decent work and the full and effective participation of women in strategic sectors of the economy.

Shealsoraised the need to build "a renewed global pact" to strengthen multilateralism and achieve greater solidarity with middleincome countries on issues central to inclusive growth, sustainable development and gender equality.

"We have reiterated the urgent need to advance new political, social and fiscal pacts focused on structural change for equality," Güezmes stressed.

She stated that in this perspective, the participation of women in all their diversity in decision-making processes is very important, particularly with regard to climate change.

To this end, she remarked, it is necessary to monitor their degree of intervention at the local, national and international levels where asymmetry persists - and to provide women's organizations, especially grassroots ones, with the necessary resources to become involved in such spaces.

"It involves strengthening financial flows so that they reach women who are at the forefront of responses to climate change and who are familiar with the situation in their communities, and boosting their capacities so that women from indigenous, native and Afro-descendant peoples participate in decision-making spaces related to the environment to promote the exchange of their ancestral knowledge on adaptation and mitigation measures," she said.

Güezmes highlighted the contribution of women environmental activists and defenders to democracy, peace and sustainable development. It is necessary to "recognize their contribution to the protection of biodiversity and to development, despite doing so in conditions of fragility and exploitation and having less access to land, productive resources and their control," she said.

For her part, Roca, who like other local women in the Peruvian Andes highlands practices agroecology to adapt to climate change and reconcile with Pachamama, calls for their voices to be heard.

"We have ideas and proposals and they need to be taken into account to improve the climate and our lives," the indigenous farmer said.

Coffee Research and Development Milestones in Tanzania

Introduction

Tanzania Coffee Research Institute (TaCRI) was incorporated in 2000 as a company limited by guarantee as per Companies Act (Cap. 212) and was legally operational on 1st September 2001 with the purpose of contributing industry with the new emphasis of stakeholder-led and demand-driven RESEARCH FOR DEVELOPMENT (R4D). The TaCRI vision is to contribute to the transformation of the Tanzanian coffee industry to sustainable prosperity. The mission is to develop and promote appropriate technologies

for improving coffee productivity and quality within a supportive policy environment. This will increase the competitiveness of Tanzanian coffee in the world market, increase farmers' income, reduce poverty and improve the livelihoods of coffee growers.

Last September was TaCRI's 20th to the revitalization of the coffee Anniversary; but our celebrations were limited by, among other things, the threat of the Covid 19 pandemic. We only made publications, to be out soon, outlining the achievements and milestones during that period. This article summarizes the most notable milestones programmewise, salient challenges and future prospects.

Crop Improvement

This area involves coffee breeding, pathology and biotechnology. Its thrust is to develop, evaluate, produce and promote coffee varieties (Arabica and Robusta) with high yields, disease resistance, large bean size and acceptable cup quality.

The Programme inherited, rejuvenated and invested on old researches that were hitherto going on at a low pace and, by the year 2006, we had already released 10 improved hybrid Arabica varieties with the above attributes. Those varieties, termed first generation tall, are N39-1, N39-2, N39-3, N39-4, N39-5, N39-6, N39-7, KP423-1, KP423-2 and KP423-3. New TaCRI researches brought about five other varieties, the second generation tall, have been back-crossed to strengthen the disease resistance more than the first generation. These are N39-8, N39-9, N39-10, N39-11 and N39-12, officially released in 2013. As these are all hybrids, the preferred method of propagation is clonal, by the use of cuttings.

We initiated the programme to develop compact hybrids and in the year 2015, some 4 varieties were released, namely TaCRI-1F, TaCRI-3F, TaCRI-4F and TaCRI-6F. In addition to resistance to CBD and leaf rust, these varieties have excellent cup quality and higher yields. Their productivity is about 3-4 times the traditional varieties and about 2-3 times the new tall varieties. Having morphologically distinct tall and compact varieties opened an avenue for research on hybrid seeds; which we undertook and made a breakthrough. Already hybrid seeds have been sought-for as an easy and fast way to raise many seedlings. As of now we have developed a capacity to produce an average

of 1.5 tons (1500 Kg) of the hybrid seeds equivalent to 6 million seedlings

Coffee wilt disease (CWD) has beeen a threat to the Robusta coffee in Kagera! First reported in 1997, the disease has been causing an enormous loss of about 300 tons annually, whose value may exceed 200,000 USD! TaCRI has mounted meticulous research and released four (4) Robusta varieties resistant to this stubborn disease, namely Marukul, Maruku2, Bukoba1 and Muleba1. The improved varieties, nicknamed "Redeemer varieties" by farmers, have had positive impact on productivity, farm profitability and farmers' livelihoods. All the 23 varieties are registered, with Plant Breeders Rights owned by TaCRI.

Research on drought tolerant varieties is one of the lates challenges brought about by climate change. The research is going on well

in trials located in Rombo, Tarime, Kasulu and TaCRI 3F. These are among those already and Mbozi Districts. Preliminary results indicate that out of the nine varieties being tested in those areas, three (3) have shown some resilience to drought: N39-3, N39-10

registered with the Ministry of Agriculture. Further research is going on for the six (6) others.

Good Agricultural Practices Research

his area involves soil fertility and plant nutrition, pest management and plant management practices. Following the release of new varieties, the trust of this programme is to develop appropriate agronomic practices to go with them so they can stay healthy and produce to their potential.

One of the key milestones in soil fertility management is the soil fertility survey and determination of potential expansion areas in 17 regions namely Ruvuma, Njombe, Iringa, Mbeya and Songwe, (in collaboration with TCB and Technoserve), Rukwa, Katavi, Kigoma, Kagera, Mara, Manyara, Kilimanjaro, Arusha, Tanga, Geita, Mwanza and Morogoro (TaCRI's own effort under the EU Trade and Agriculture Support Programme). Soil fertility reports, including recommendation for soil fertility management, have been submitted to the respective district councils for use by extensionists. Potential area for expansion has been established as slightly over 15,000 ha. TaCRI encourages farmers to check the fertility status of soils in their farms on a regular basis, and has a state-of-the-art laboratory for that purpose.

We started a botanical garden in 2003 with fishbean (Tephrosia vogelii) and neem (Azadirachta indica). By the year 2007, the garden had expanded to about 1 ha, with as many as 8 different species. Three bioassay tests were done in 2010 against antestia bug, and we noted that a minimum of 1200 grams per litre

fresh leaves is not significally different from the Selecton check. Researches on coffee berry borer (CBB) traps show that a 1:1 mixture of methylated spirit and water on one hand, and local brews like mbege, dengelua, ulanzi and rubisi on the other, have great potential as lures to the pest. This technology has already become common among both large and small farmers. We have also researched and recommended for the control of white coffee stem borer (WCSB) which is a threat to the coffee industry countrywide.

In the area of coffee agronomy, we evaluated patterns of coffee-banana intercropping and came up with 3:1 pattern for tall varieties (3 coffee rows between 2 banana rows) in 2004; and 4:1 pattern for compact varieties in 2021. These patterns have been well accepted by farmers as strategies to increase productivity of both crops. We evaluate different farm rehabilitation techniques; whereby stumping, followed by grafting, came out as the most appropriate technique, which also opens avenues for converting traditional varieties into improved ones. These techniques, and many others related to coffee husbandry, have been compiled into books entitled "Kanuni Bora za Kilimo cha Kahawa ya Arabika" (1st edition, 2011; and 2nd edition, 2018), "A review of Coffee Pest Management in Tanzania" (1st edition, 2011; and 2nd edition, 2020) and "The coffee soils of Tanzania: Their properties and potential for sustainable production" (awaiting publication).

Technology Transfer and Training

he thrust in this area is to promote and disseminate proven coffee technologies among growers for increasing productivity, improving quality and enhancing growers' income. This is done through our network of substations located at Lyamungu (Hai), Maruku (Bukoba), Mbimba (Mbozi), Ugano (Mbinga), Mwayaya (Buhigwe) and Nyamwaga (Tarime), district and ward coffee subject matter specialists, and farmer promoters who have received special

Training on GAPs and seedling multiplication was done to a total of 377,496 farmers and the exercise is ongoing. We have published and disseminated messages through 185,707 leaflets. A total of 10,865 extension officers and 3,849 farmer promoters were trained on GAPs countrywide. This is also an ongoing process which needs to be done time after time, as new extension officers come on board.

A total of 400 nurseries were established countrywide for the multiplication of improved seedlings since 2002. In collaboration with various stakeholders, we produced 51,323,308 seedlings of the improved varieties, which can cover a total of 38,560 ha; and provided them to farmers for field and nursery establishment.

Livelihood and income security

The TaCRI-affiliated farmers have become role models in GAPs, with their farms converted to demonstration plots. Many such farmers maintain visitors' books, as evidence that they receive many visitors from within and outside their villages to learn about coffee. This has earned them more social respect and recognition.

Most of these exemplary farmers have been able to improve their premises by building modern houses, others to acquire means of transport and invest on other ventures like keeping of grade cattle. Farmers' ability to contribute resources to social development projects have increased. Many have acquired ability to pay school fees for their children. These are measurable criteria to indicate social and financial improvement. Farmers who adopted the TaCRI technologies are, indeed, happy farmers!

National and international recognition

TaCRI has forged smart research partnership with local institutions such as Sokoine University of Agriculture (SUA), the Nelson Mandela

Seed Certtification Institute (TOSCI), Tanzania Agricultural Research Institute (TARI), Tropical Pesticide Research Institute (TPRI), Plant Breeders Rights Unit of the Ministry of Agriculture ; and international ones like CIFC (Portugal), CIRAD and Nestle (France) and CABI (Britain). For six years consecutively since 2010, the TaCRI Chief Executive Director was honoured to be a rare African member of the Board of Directors of the "Association for Scientific Information on Coffee - ASIC" based in Geneva, Switzerland.

TaCRI has uplifted Tanzania to among eight (8) countries globally, and three (3) countries in Africa, renowned for outstanding coffee research. We have shared 57 research communications in international conferences; 19 publications in peer reviewed journals and two chapters in books. During the year 2011 the Commission for Science and Technology (COSTECH) awarded TaCRI a total of 20 million TZS, for being the best institution in Tanzania undertaking research and giving appropriate solutions to stakeholders' challenges. Two times 2006 and 2017, the Confederation of Trade Unions (TUCTA) has acknowledged TaCRI's contribution by awarding us the "researcher of the year". The institute has been getting clean auditi reports from internal and external auditors.

Challenges

Successes and challenges are "literal twins". Research challenges facing TaCRI are related to climate change, lika changes in the behaviour of pests and diseases. This calls for intermittent review and adjustment of our research focus in line with the current situations. Fortunately, as concerns resistance to diseases, the ongoing follow-up has confirmed the stability of the

Institute of Technology, Tanzania Official released varieties so far. Emerging research areas include drought and heat tolerance, resistance to insect pests, climate-smart

Technology transfer challenges include demand for improved seedlings exceeding the capacity of TaCRI to multiply and distribute. From the very outset, stakeholders had insisted that seedling multiplication should be a sole responsibility of TaCRI for quality assurance sake. In the third and fourth SAP, we were advised to outsource partners to undertake extension and seedling multiplication so that TaCRI, with merely 61 staff, remains with the core responsibility of research, technology transfer and advocacy. This has not yet been possible, and therefore stakeholders still depend on TaCRI for extension and seedling multiplication. To address this challenge, we have expended our seed farms and put more effort in the distribution of hybrid seeds to farmer groups (with the know-how related to raising of seedlings) and this has shown to work to some extent.

Future prospects

Next year we will review the SAP IV and develop SAP V. As usual, the preparation of SAPs is a participatory process whereby stakeholders are invited to express their challenges and research priorities which become the basisi for the given SAP. We will obviously continue with all research related to climate change, including ISFM, IPM, plant population, number of bearing branches per tree, etc. Our thrusts will remain the same, to develop and promote appropriate technologies that will increase productivity and quality, improve the livelihoods of individual farmers and the national GDP, while enhancing the competitiveness of Tanzanian coffee in the world market.

'Brutal' discrimination adds trauma to Roma as they flee war-torn Ukraine

refugees fleeing war-torn Ukraine are facing discrimination on both sides of the country's borders at the end of often harrowing journeys across the country, rights groups have claimed.

Russia's invasion Ukraine on February 24 has sparked what the UN has described as the fastest-growing refugee crisis in Europe since WWII, and as of March 9, an estimated 2 million people had left the country.

These include Roma who, like other refugees, abandoned their homes and communities as fighting broke out across the coun-

But having reached borders of neighbouring states, they have found themselves subject to what some groups helping them have described as "brutal" discrimination.

"Groups working on the ground at borders in Slovakia, Romania, and Hungary have confirmed discrimination to us, and also media reports have backed this up. Roma are facing discrimination both by border guards, and then local people once they get out of Ukraine. It's very sad and disappointing, but not surprising," Zeljko Jovanovic, Director of the

Roma Initiatives Office at the Open Society Foundation (OSF) told IPS.

Roma living in Europe are among the most discriminated and disadvantaged groups on the continent. In many countries, including Ukraine where it is thought there are as many as 400,000 Roma, significant numbers live in segregated settlements where living conditions are often poor and extreme poverty widespread.

Health in many such places is also bad with research[1] showing very high burdens of both infectious and non-communicable diseases and significantly shorter lifespans than the general population.

Incidents of discrimination of Roma have been reported at the borders of all countries that are taking in refugees,

according to the OSF and the European Roma Rights Centre (ERRC).

These have included being made to wait much longer in lines, sometimes tens of kilometres long, in freezing weather, than ethnic Ukrainian refugees, before they are processed.

"They are always the last people to be let out of the country," said Jovanovic. Media reports have quoted refugees

being refused transport by volunteers, and being refused accommodation. Jaroslav Miko, founder of the Cesi Pomahaji (Czechs Help) NGO, who has transported more than 100 Roma

crossings in other countries,

including incidents of Roma

refugees from the Slovak-Ukrainian border to the Czech Republic, told IPS he had seen "discrimination of Roma among the volunteers who were picking people up at the border". He said volunteers were picking up some refugees in vehicles and taking them to other places, but that Roma families were being turned away if they asked for help.

In another incident, the head of a firefighting station in Humenne, in eastern Slovakia, where many Roma refugees have been sent to a holding camp, told a reporter that the refugees had "abused the situation". "They are not people who are directly threatened by the war. They are people from near the border, they have abused the opportunity for us to cook them hot food here and to receive humanitarian aid," the firefighter allegedly said, adding that Ukrainian Roma should not be allowed across the border.

Slovakia's Interior Minister Roman Mikulec and national fire brigade officials have refused to comment on the claims.



Academic paper: loans have become game changer for SMEs prosperity

ICRO, Small and Medium Entreprises (MSEMs) business owners have said they are considering loans as "game changer" to their economic activities, the academic study has revealed.

Most of the micro and small business owners featured in the study say loans increases levels of business income, causes increase of sales volume and stock of turnover and profit obtained helps to cover medical and children education expenses for families.

According to dissertation submitted in partial fulfillment of the requirements for the degree of masters of Business Administration at Open University of Tanzania by Godfrey Nyamwihula, there is a need to increase the amount/size of the loan offered to small businesses to enhance their performance and financial sustainability.

The study examined the effects of microfinance loans on performance of Small and Medium Enterprises (SMEs) in Tanzania, taking a study of Kinondoni SMEs in Dar es Salaam, covering borrowers of the amount ranging from 100,000/- to 10mn/-.

As a result, micro-loans have enabled low income earners in Dar es Salaam to expand and develop their income generating activities, enhancing their bargaining power and interests, thereby contributing to the welfare of their household.

Results from the study indicated that there were significant increases of up to 30 percent in the average monthly gross profit of SMEs after employing loan obtained from NMB over time.

Furthermore, the contribution of microfinance loans in the growth of SMEs as indicated by the field results shows creation of employment with 3.89 mean and increase in level of business income with 4.38 mean.

Other were accumulation with 3.79 mean. improve borrowers living standards with 4.40 mean, create awareness to borrowing and resettlement with 4.40 mean, and promote



the total sample responses.

"Borrowing and using micro-loan has overcome financial vulnerability" the findings note. "Many credit users have met household and business needs like medical, education and expansion of their businesses hence improvement in their standards of living.'

Moreover, the researcher concludes that a micro-credit facility is, no doubt, a good innovation for developing low income earners of Tanzanian society, as it enhances the productive capacity of the SMEs to participate in income generating activities.

For a long period of time commercial banks neglected the poor members of the society who lack conventional collateral security like land ownership document,

respect and social dignity with 4.67 mean of building ownership document, equipment and third part guarantee.

On realizing this gap, Microfinance increased the capacity of the poor to Institutions (MFIs) should come in to extend affordable and easily payable loans to SMEs through micro-loan schemes.

The study has called upon the government undertake the preparation of an appropriate way for credit lending institutions to further penetrate and reach out even to the poorest of the poor in both rural and urban areas since the study has found out that micro-credits greatly improve the wellbeing of entrepreneurs at

There is also a need for the government to appreciate the socio-economic conditions, knowledge, attitudes, perceptions, cultural beliefs and practices of credit borrowers and a critical consideration of these issues

will have a high impact in enabling lending institutions to tailor their financial services to the needs of the clients and low income earners in developing communities.

It has also been apparent that microcredit institutions provide important services for clients neglected by the formal banking sector.

This study also calls for immediate measures to revamp micro-credit policies in the country (Tanzania).

It is also recommended that microcredits, in their present form, should not only be considered for their alleged poverty alleviating qualities, but also as subsidies in support of an alternative smallscale banking sector.

As long as social development funds are directed to microfinance institutions, qualitative and quantitative indicators of social progress achieved through microcredit lending should be among the basis of assessment of growth and social development.

A core issue in this respect is the working conditions of micro-entrepreneurs and their employees.

"It is not enough to know that loans have been repaid but micro-credit institutions should also account for the social and economic impact their programs have on their clients," the study notes.

For the case of Micro-loan providers, the study explains that they should be able to expand their loan facilities to reach out the vast majority of the poor population in the country, both in rural and urban areas.

In realizing this gap, Microfinance Institutions (MFIs) should come in full force to capture this niche and extend affordable and easily payable loans to the poor people through micro-loan schemes.

UAE bank lending set to grow in 2022 amid recovery, S&P says

BANKS in the UAE are expected to record an increase in lending this year as the Arab world's second-largest economy charts a strong recovery from the Covid-19 pandemic, according to a new report.

Higher oil prices, supportive government policies and improving economic sentiment could lead to a faster return to pre-pandemic levels, S&P Global Ratings said in a report.

"We have raised our assumption for Brent oil prices to an average of \$85 in 2022," S&P Global said. "We expect nominal gross domestic product to reach pre-pandemic levels supported by activity from the ongoing Expo 2020 in Dubai and a recovering hydrocarbon sector."

Oil prices surged on Thursday after the Opec+ 23-member alliance of producers stuck with its production plans for April and the Ukraine-Russia crisis continued.

Brent, the global benchmark for two thirds of the world's oil, rallied to more than \$119 per barrel on Thursday, its highest level since May 2012. West Texas Intermediate, the gauge that tracks US crude, also surged to more than \$116 a barrel, its highest since 2008.

Prices receded late on Thursday and by 12.36pm UAE time on Friday Brent was trading at \$110.7 and WTI at \$108.1.

Banks in the UAE, including First Abu Dhabi Bank, Emirates NBD, Abu Dhabi Commercial Bank and Dubai Islamic Bank, among others, have all reported higher 2021 profits as the country's economy recovers from the pandemic, helped by higher oil prices and fiscal stimulus measures.

Combined net profit of the country's four largest banks was up 31 per cent to \$8bn in 2021. Lenders in the UAE are expected to return to pre-pandemic levels of profitability in the next 12-18 months amid stronger net income, a decline in non-performing loans and improved

the economy improve. S&P Global also estimated that the UAE Central Bank will mirror the US Federal Reserve's planned interest rate hikes, a move that could benefit local banks' profitability. The Fed is convening on March 15-16 when it is

expected to raise rates by 25 basis points. "We calculate a 15 per cent increase in net income and 1.4 per cent rise in return on assets for every 100-basis-points increase (parallel shift) based on the top 10 banks' disclosures," the ratings agency said.

Increased profitability is also expected to further strengthen the banks' capital buffers with many expected to start paying their dividends at pre-pandemic levels this year, the

But the ratings agency does not expect lending growth to outpace its current projection.

NBC's small businesses financing scheme tops 60bn/- this year

THE National Bank of Commerce (NBC) has increased its allocation for financing Small and Medium Entreprises (SMEs) by 12bn/- to 60bn/- this year, in an efforts to support businesses growth, job creation and economic

Speaking to this paper during the launch of the Women Entrepreneurs Exhibitions held in Dar es Salaam at the weekend, the NBC bank Head of SMES Mussa Mwinyidaho (pictured) said during last year the bank spent 42bn/- for the same purpose.

He said apart from the funding, the bank will be investing in offering training in partnership with Tanzania Trade Development Authority (TanTrade) to equip business owners with business and financial skills. A total of 7,000 SMEs have benefited from the programme.

Mwinyidaho noted that the bank has simplified the procedure for SMEs to secure loans, adding that existing bank's customers, holding

economy to grow, SME must also grow, that is why we have come up with an ambitious financing strategy," he said.

The bank late last year also announced plans to finance SMEs in taking part in the country's mega strategic investment projects, as part of its efforts to support the Government's Local

The NBC Director for Business Development Elvis Ndunguru said the bank has come up with two tailor-made products includes 'Supplier Finance' and 'Purchase Order Finance' to cater for the interests of SMEs who need cash flow to support their businesses.

"As a bank, we realised that many SMEs were having trouble securing finances to support their businesses due to many terms and conditions set by various banks, include depositing assets in order to secure loans," he said.

Ndunguru said that with the bank's new product that supports local content drive, SMEs will only need to produce Local Purchase Orders (LPOs) or service agreements as a guarantee to secure loans.

"We have finally listened to the long time outcry of many SMEs and decided to accept LPO agreements and service agreements as guarantees for loans to ensure SMEs without assets can get the required finances to support their secured business contracts," he said.

He encouraged SMEs to embrace the bank's tailor-made product adding that the bank

will be offering short-term loans of 90 days to three years depending on the interest of the potential borrower.

"We will continue to invest in research in order to come up with other cluster banking products to address the needs and interests of various SMEs in the country," he added.

The National Bank of Commerce (NBC) had a wonderful year in 2021 as its profit before tax ballooned to a record 60bn/-.

The amount translates to a 702.39 percent improvement compared to the profit before tax of 7.48bn/- that the bank recorded in 2020.

The money was largely due to a rise in the interest income stream which rose from 132.7bn/- in 2020 to 158.3bn/- in 2021.

The bank's assets now stood at 2.26trn/- at the end of the fourth quarter of 2021 as compared to 2.16trn/- at the end of third quarter of last year.

According to the statement, NBC's loans and advances increased by 10.8 percent to 1.38trn/in fourth quarter of last year, courtesy of strong growth in its key market segments including agri-business, SME and Personal Loans.

Russia's banks turn from global ambitions to survival

LONDON

IN the run-up to Russia's invasion of Crimea in 2014, VTB Bank, the country's secondbiggest lender, dedicated an entire floor at its Imperia Tower headquarters in central Moscow to financing the country's war machine.

Given the sensitive nature of the operation, foreigners were forbidden access to the floor, according to former employees of the bank. The ban even extended to the foreign executive supposedly overseeing the business unit.

"There was always a great deal of mystery about what

went on in that department, but everyone knew it was funding military-industrial complex," said a former senior VTB executive whose lift pass denied him access to the floor.

In 2018, the Kremlin transferred defence lending to a smaller bank in an attempt to protect VTB – as well as the country's biggest lender Sberbank, which also financed the military – from sanctions.

But Russian president Vladimir Putin's full-scale invasion of Ukraine has meant that both VTB and Sberbank have now become targeted in a western campaign aimed at choking the country's financial

Sanctions – which have frozen VTB's assets and will kick the group off the global Swift payments system, while Sberbank has been blocked from using the dollar – have already started to bite. Sberbank has been forced to pull out of central and eastern Europe, and VTB is making plans to wind down its European operations.

German authorities are monitoring VTB's Frankfurt operations closely, according to people familiar with the matter, aware that a disorderly departure could cost the country's deposit insurance scheme billions of euros.

lenders had close to 1mn retail customers across Europe, while also managing accounts for local governments and hundreds of businesses. Their pullback from Europe, already under way before this year's sanctions, marks the end of a two-decade strategy among Russian banks to expand internationally. But it is at home, where the

Coffee processor explains how SIDO lending changed her life

AMDA Mwebea, a 41-year-old entrepreneur is among 13,776 small and medium entrepreneurs who have benefited from financing, trainings and advice services provided by the Small Industries Development Organization (SIDO) from 2016 to 2021.

The journey started in 2009 when Mwebea joined SIDO- Shinyanga Regional Office where she acquired a number of skills-on food processing, entrepreneurship, business management, financial record keeping, marketing and advice on how to start a business and products packaging.

Through the knowledge and skills gained from SIDO, Mwebea has been able to set up her own company-Tausi Coffee General Supplier Company which was officially established in 2012.

Apart from attending classroom training, Mwebea has been able to secure a loan from SIDO as seed capital to purchase raw materials for coffee processing, that in-turn has helped her to transform her life from being a fruit and vegetable vendor /seller to a job creator.

Mwabea's company received its first loan worth 5m/- from SIDO in 2012/2013.

So far, the company has employed 30 staff in a small coffee processing plant located at Ndala ward, Shinyanga Municipal council, about 3 kilometer from Shinyanga municipal council.

The company has capacity to process 15 metric tons of coffee per month and she is now selling her products in shinyanga, Kagera, Dodoma, Geita and other regions.

Mwebea, a mother of four, lauded SIDO to introduce the programme which she explained as an eye-opener as it has completely changed her life.

So far, she has been able to build a modern house, paying school fees for



her children, produce high quality coffee products, improve her livelihood, be recognized for what she produce within and outside Shinyanga Region.

Also income growth of 65 to 70 percent annually is being experienced by Mwebea. Mwebea holds a Standard Seven Certificate obtained from Mabamba Mission Primary School in Kibondo District, Kigoma

Region in 1996. Before attending training, she was fruit and vegetable vendor supplying her products in various areas within and outside the region.

Meanwhile, SIDO's Director of Marketing and Investment, Shoma Kibende said loans worth 26.6bn/- has been disbursed to 13,776 small and medium entrepreneurs.

Among those, 13.3bn/-loans were issued to 1806 women entrepreneurs engaged in food processing sub-sector, spices and honey processing, batik, soap making and other businesses.

The loans were disbursed from 2016/2017 to December 2021 through the National Entrepreneurship Development Fund (NEDF).

Through the loans, about 35,391 employment opportunities in agriculture, livestock keeping sub sector, business, food processing, fishing industry, mining and tor. other businesses were created and among those, 53 percent were created by women entrepreneurs.

She said women entrepreneurs get loan services for investment and working capital through both groups and individuals.

Kenya central bank lifts freeze on loan prices after IMF notice



THE Central Bank of Kenya has begun approving lenders' applications to increase the cost of loans based on customer risks, setting the stage for expensive credit for small traders and workers in the informal sector.

Equity Bank is the first lender to publicly reveal that the CBK has approved the risk element in its lending formula, pricing its loan at between 13 percent and 18.5 percent compared to the current average of 13.5 percent.

Multiple bank executives had late-year protested to the International Monetary Fund (IMF) over the CBK's reluctance to approve their applications to raise the cost of loans following the scrapping of interest rate controls on November 7, 2019.

Banks have been eager to annualised and on reducing

price loans to different clients based on their risk profile but this flexibility remained a mirage after the CBK stepped in as the de facto controller of cost of credit

Equity Bank on Monday said the regulator had approved its risk lending models following two years of talks, indicating CBK has now started allowing banks to gradually raise rates.

"Interest on loans will now be based on the risk of the client. We are using sovereign risk as the base, then adding the risk of the individual sector and then within the sector the specific client risk and then we add operational costs," Mr Mwangi said.

"So instead of the previous [pricing model] where we had loan appraisal fees, and all the rest, we are now saying here is one rate of interest and it is balances. We have simplified and removed the fees and combined the rate into one based on the sovereign risk."

Mr Mwangi said the new pricing model will have base of 13 percent, which matches the average rate charged on government bonds of over five years

Small businesses will get loans at between 14 percent and 16 percent rate from Equity Bank while unsecured loans will attract as much as 18 percent.

"There are corporates like the blue chip firms which will be able to get as low as the sovereign rates. Those with higher risk will go all the way to 16 percent, and then there is the SMEs from 14 percent to 16 percent. The unsecured individual lending micro, small and medium enterprises from 16 percent to 18 percent," Mr

Mwangi added.

Other tops banks such as Cooperate Bank, KCB Group and NCBA Group remained tightlipped on their applications to the CBK for review of their lending rates. Bankers fret talking publicly for fear of CBK reprisals.

"Getting approval is a nightmare. CBK has taken a more customer protection approach as opposed to the industry needs," a bank CEO told the Business Daily in an earlier interview.

Banks say that the delayed shift to risk-based lending has forced many of them to deepen investment in government securities and restrict lending to high-quality customers with a lower risk of default.

This emerged at a time supply of loans to the private sector grew by 8.6 percent in the

year to December 2021, which is below the ideal rate of 12-15 percent needed to support economic growth.

"With an ample capital position and strong deposit growth, banks are positioned to extend credit to the economy to support the recovery, though they may face some headwinds," said the IMF.

"Banks' holdings of government securities stand at a relatively high 31 percent of assets and are expected to rise further in the coming year."

The IMF says that Kenya's lending rates have remained little changed when compared to the period the State controlled bank loan costs.

The lending rates averaged 12.38 percent in November 2019 when the rate cap was repealed, with the Central Bank Rate (CBR) then at 8.5

Australia, New Zealand banks bounce back as predicted

AUCKLAND

THE country's banking sector has roared back from the pandemic with record profits fuelled by a red hot housing market and a reversal of the provisions made last year for possible losses caused by Covid-19.

Business advisory company KPMG's latest review of the sector showed the total profit of the banks rose 48 per cent, \$1.99 billion, to a record collective tally of \$6.13

Much of the increase came from a \$1.69 billion gain as the banks reversed the money they had set aside for bad and doubtful debts the year before, which did not

KPMG head of banking John Kensington said the past two years had been an aberration given a more than 20 per cent drop in profits in 2020 as the banks feared the

"As we look back now with the benefit of hindsight, the negative impact of Covid-19 was greatly overestimated, and resulted in provisioning levels that have not been required."

The other big driver of profits had been the insatiable demand for housing finance, which had resulted in a near 7 per cent rise in bank lending, while their margins had risen slightly, and cost of funds had fallen.

Kensington said the Government's support measures and rock bottom interest rates had driven mortgage de-

"This gave Kiwis the confidence to continue their love affair with housing at a time when many other avenues for spending were curtailed. These factors saw phenomenal mortgage growth off the back of them."

He said it was likely that the strong growth in the bank finances would flatten out as the heat comes off the housing market through higher rates, tighter lending rules, and the dampening effect of the Credit Contracts and Consumer Finance Act (CCCFA) on applications and approvals for finance.

"What you'll see is fewer loans written and perhaps not continued growth, it might go flat, it might even go backwards a little and it may be a year when the stars don't align and the banks will have to work harder, it won't fall into their lap like it did last year."

However, even if the volume of business slowed, Kensington said he expected that rising interest rates would likely result in bigger margins for the banks.

He hoped the government would be quick to respond to concerns about the CCCFA's effect on lending, which has resulted in delays in processing and previously good borrowers being refused finance.

Kensington said it could be that with a slowing economy through high inflation, disruptions, and rising interest rates that businesses and household living off their own resources might turn to the banks for finance, which a restrictive CCCFA could deprive them of.

UN rights chief concerned over killings of Black people in US

GENEVA

PEOPLE of African descent die at the hands of law enforcement in disproportionately large numbers in many countries, especially in the United States, a United Nations human rights official said on Tuesday.

Michelle Bachelet, UN High Commissioner for Human Rights, said in her annual report to the ongoing 49th session of the Human Rights Council that in the United States, civil society groups have

advanced a figure of 266 killings of people of African descent by the police in 2021.

This indicates that they are "almost three times more likely to be killed by police than white people", Bachelet said, adding that "other research suggests the figure could be even higher."

"I urge national authorities -- in all regions of the world -- to ensure prompt and effective accountability for deaths at the hands of law enforcement,"

The UN Human Rights Council has in recent

Omicron infections are contagious for at least 6 days

SANTIAGO / BERLIN / OTTAWA / WASHINGTON

PATIENTS infected with the Omicron variant of SARS-CoV-2 remain contagious for just as long as patients infected with earlier variants, according to a small study.

Researchers took blood samples from 56 newly-diagnosed patients, including 37 with Delta infections and 19 with Omicron infections. All were mildly ill, such as with flu-like symptoms, but none were hospitalized.

Regardless of which variant or whether or not they had been vaccinated or boosted, study participants "shed live virus for, on average, about 6 days after symptoms (began), and... about one in four people shed live virus for over 8 days," said Dr Amy Barczak of the Massachusetts General Hospital in Boston, who coauthored a report posted on medRxiv ahead of peer review.

"Although it is unknown exactly how much live virus is needed to spread the disease to others, we take these data to suggest that people with mild COVID-19 infection may be contagious on average for 6 days, and sometimes longer," Barczak said. "Decisions about isolation and masking should take such information into account, regardless of variant or prior vaccination status."

Canada

Transport Canada announced Monday that cruise ships are set to come back to Canadian waters in April, outlining the COVID-19 rules for passengers and crew members.

According to the rules, all passengers and crew must be fully vaccinated against COVID-19. Only passengers under 12 and those with medical exemptions do not need to be vaccinated.

Passengers will be required to show a negative COVID-19 test to board a ship. A molecular test, like a PCR, will be accepted if taken within 72 hours before boarding, or an antigen test taken within one day of boarding.

Mask rules will be in place according to local/provincial health guidelines, and cruise ships are also required to have testing facilities on board so that passengers can take another COVID-19 test before disembarking the ships.

"We welcome cruise ships, an important part of our tourism sector, back to Canada, and we will continue working with partners to support this important industry," Transport Minister Omar Alghabra said.

The cruise ship sector contributes more than 40 billion Canadian dollars (\$32 billion) to the Canadian economy and employs some 30,000 people.

The measures banning cruise ships against COVID-19 were initially announced on March 19, 2020.

Scientists have pinpointed 16 new genetic variants in people who developed severe COVID-19 in a large study published on Monday that could help researchers develop treatments for very sick patients.

The results suggest that people with severe COVID-19 have genes that predispose them to one of two problems: failure to limit the ability of the virus to make copies of itself, or excessive inflammation and blood clotting.

The scientists said their discoveries, published in the journal Nature, could help prioritize the likely treatments that could work against the disease. Agencies

Former British Speaker Bercow suspended by Labour after

JOHN Bercow, who served as speaker of Britain's House of Commons (lower house of Parliament) during fraught debates over Brexit, has been suspended from the Labour Party, local media reported on Tuesday.

Bercow's membership has now been suspended, pending the outcome of an internal Labour probe, according to the Independent

and Sky News. He joined the Labour Party in 2021. His suspension came after a report published earlier in the day by an Independent Expert Panel (IEP) described him as a "liar" and a "serial bully". In a damning 89-page adjudication, the panel reprimanded Bercow for his conduct while he held the highest office in the country's Par-

He faced 21 allegations made by three senior House of Commons staff members.

The IEP sub-panel, headed by eminent High Court Judge Stephen Irwin, found Bercow's conduct to be so serious that he should never be allowed a pass to the parliamentary estate.

The panel added that if he were still an MP (Member of Parliament) they would have recommended expelling him from the House of Commons.

The bullying and harassment

policy was breached repeatedly and extensively by Bercow, the panel said.

Announcing the decision, the panel said: "In all, 21 separate allegations were proved and have been upheld.

The House may feel that his conduct brought the high office of Speaker into disrepute. This was behavior which had no place in any workplace. Members of staff in the House (of Commons)

should not be expected to have to tolerate it as part of everyday life." "His behavior fell very far below that which the public has a right to expect from any Member of Parliament," the report concluded. Bercow served as an MP for Buckingham from 1997 to 2019 and as a speaker from 2009 to 2019, chairing often rowdy debates during clashes in the House of Commons over Britain's departure from the European Union. US de facto wages economic war against Russia, Kremlin says

THE United States of America is de facto waging an economic war against Russia, Kremlin Spokesman Dmitry Peskov said on Wednesday, commenting on the statement by US Under Secretary of State for Political Affairs Victoria Nuland that from the point of view of the US "this Ukraine gambit is a strategic failure for Putin."

"The US, undoubtedly, declared an economic war against Russia and they are waging this war. Yes, de facto this is exactly what it is," the Kremlin official

In response to a question as to what are Moscow's chances not to lose this war considering that the US is attempting to get the entire world involved in sanctions against Russia, Putin's press secretary said that it is necessary to do "what in the best way corresponds to our interests." He declined to divulge any details on the possible retaliatory sanctions.

On February 24, Russian President



Vladimir Putin said in a televised address that in response to a request by the heads of the Donbass republics he had made a decision to carry out a special military operation in order to protect people "who have been suffering from abuse and genocide by the Kiev regime for eight years.

The Russian leader stressed that Moscow had no plans of occupying Ukrainian territories. Following this, the US, the EU, the UK and a number of other countries announced the introduction of sanctions against Russian legal entities and private individuals.

'Sanctions baton won't bring peace': China slams US-led crusade to ban Russian energy

COMPLETELY nixing Russia's exports of oil and gas will trigger economic dilemmas that are bound to severely impact all sides, Chinese Foreign Ministry Spokesman Zhao Lijian told a briefing yesterday.

"China is definitely against unilateral sanctions that are not based on international law. Brandishing a sanctions baton will not bring peace and security. It will only lead to serious issues for the economy and the quality of life in the corresponding countries," he cau-

"In this situation, everyone loses. Sanctions will only intensify division and confrontation," the diplomat

"China and Russia maintain stable cooperation in the energy sector. And we will continue to pursue normal trade interaction based on the principles of equality, mutual respect and benefits, and this includes the oil and gas sector," he concluded.

US President Joe Biden signed a de-



cree on Tuesday, banning energy imports from Russia and new investment in the Russian energy sector.

China urges safe implementation of humanitarian corridor in Ukraine

CHINA hopes that Russia and Ukraine will overcome the difficulties in safely implementing a humanitarian corridor negotiated by the two countries, the Chinese permanent representative at the United Nations, Zhang Jun, told the UN Security Council on Monday.

The top priority now, Zhang said, is to avoid further massive casualties and a humanitarian crisis. The envoy said that Chinese State Councilor and Foreign Minister Wang Yi had publicly put forward a six-point initiative on preventing a humanitarian crisis in Ukraine aimed mainly to promote synergy among the international community and avoid a further deterioration of the situation.

As a peace-loving country, China laments the fact that the situation in Ukraine has come to this stage, Zhang said. China supports all efforts to ease the escalation and strongly opposes any action that is not conducive to promoting a political settlement but rather fuels the fire and escalates the situation, he said.

Zhang insisted that escalating sanctions will only further complicate and amplify the situation and not solve problems.

"Sending offensive weapons and even mercenaries into Ukraine could exacerbate the situation and bring greater risks," he continued.

China has advocated dialogue and negotiation since the very start of the conflict. On the second day of the conflict, President Xi Jinping called for solving the crisis through negotiations in a phone call with Russian President Vladimir Putin.

Zhang reiterated that China's position of safeguarding the sovereignty and territorial integrity of all states and abiding by the purposes and principles of the UN Charter has been consistent. "We also encourage the United States, the North Atlantic Treaty Organization (NATO), and the European Union to engage in equal-footed dialogue with Russia, face up to the contradiction and problems accumulated over the years, pay attention to the negative impact of NATO's continuous eastward expansion on Russia's security, and seek to build a balanced, effective and sustainable European security mechanism in accordance with the principle of indivisible security," he said.

Scant progress evacuating Ukrainian civilians despite Russian ceasefire promise

WASHINGTON/LVIV

UKRAINE must hold off Russia's attack for the next seven to 10 days to deny Moscow claiming any sort of victory, said a senior government official, as more than 2 million refugees fled the biggest assault on a European country since World War Two.

Vadym Denysenko, adviser to Ukraine's interior minister, said Russia was desperate for at least some kind of victory, citing the cities of Mariupol or the capital Kyiv as the most likely targets.

"They need at least some victory before they are forced into the final negotiations," Denysenko wrote on Facebook (NASDAQ:FB).

"Therefore our task is to stand for the next 7-10 days."

Russia said it would provide humanitarian corridors on Wednesday for people fleeing Kyiv and four other Ukrainian cities. The only operating corridor is that from the city of Sumy, which opened on Tuesday.

About 5,000 people rode buses out of the northeastern city on Tuesday after Moscow and Kyiv agreed on the corridor, said Sumy regional governor Dmytro Zhyvytskyy.

About 1,000 cars were also able Poltava, he said, adding the corridor would continue to function yester-

Zhyvytskyy said separately that Sumy's residential area had been bombed overnight, with one bomb killing 22 civilians. He called the inci-

Biden announces imposition of energy embargo on Russia

WASHINGTON/KYIV/MOSCOW/ COPENHAGEN

US President Joe Biden on Tuesday announced the imposition of an energy embargo on Russia, banning US imports of oil, liquified natural gas and coal from Russia over its ongoing military operations in Ukraine.

The move came as Ukrainian President Volodymyr Zelensky said his country is ready to hold a dialogue with Russia on security guarantees and the future of Donetsk, Lugansk and Crimea, said a press release posted on the official website of the Ukrainian president Tuesday. Announcing the embargo on Rus-

sia from the White House, President Biden said: "This means Russian oil will no longer be acceptable to US ports.'

He claimed the move will deal a "powerful blow" to Russia's ability to sustain funding for its military operations, while also admitting that it will backfire on Americans at home by causing continued price hike at gas stations.

The gas price at the pump, Biden said, "went up 75 cents" since Russia launched the military operations. "With this action, it's going to go up further," he added.

The average price for US gasoline hit a record high of \$4.173 per gallon on Tuesday, according to the American Automobile Association, whose data showed the price was 15 percent higher than a week earlier and 21 percent higher than a month earlier.

Meanwhile, the European Union, which relies on Russia for some 40 percent of its natural gas supplies, announced earlier Tuesday a set of comparatively limited measures, reducing imports of Russia natural gas by two-thirds this year and aiming to

Stakeholders urged to motivate women to take up sporting activities

the world celebrated International .Women's Day on Tuesday, Mwanaidi Ng'itu, the first Tanzanian woman to compete at the Paralympics, says a lot should be done for many of the country's women to take part in sporting activities.

Mwanaidi represented the country at the 2004 Athens Paralympics and she competed in 100m and 200m sprints.

She said many sportswomen, especially those with disabilities, face several challenges.

The athlete said the challenges are many, especially in rural areas where people consider that involving people with disabilities in sports is inhuman.

According to her, villagers do not value the importance of sports to people with dis-

She said after some people noticed potential in her, they encouraged her to start training and she was training with male and female soldiers at Mgulani camp in Dar es Salaam but the main challenge was accessing bus fare to and from the training base.

"There are many women with disabilities who are good in sports, but they are not encouraged by the community they live in.'

"In my case, if I was in my home village in Nachingwea, Lindi, I don't know if I would have been an athlete today."

"The story is a bit different especially here in Dar es Salaam where the community encourages a person with a disability to take part in sporting activities, the only challenge here is that we lack resources like bus fare and equipment."

Mwanaidi disclosed many people still believe that a person with a disability cannot be a professional athlete.

"They treat us amateurs, the prize money given to a normal plyer is completely different from that which is handed over to a sports person with a disability," she said.

Sauda Njopeka, who represented the country at last year's Tokyo Paralympics,

also lamented the treatment which

"I went to Tunisia for Tokyo Paralympics qualifiers, it was not good... we were not given any allowance, coach Bahati Mgunda used his resources to help me."

"But now thanks to that we have heard that the allowances have been harmonized, unlike in the past when able-bodied athletes were given high allowances while we were given peanuts," she said.

National wheelchair tennis squad's player, Rehema Suleiman, also shared Mwanaidi's sentiments saying female players with disabilities should be given special attention.

"It was not easy to reach where I am today, I took on all challenges which I faced, I targeted to be an athlete while in primary school in Morogoro, I was involved in different sporting activities.

"I was introduced to wheelchair tennis at Salvation Army Primary School in Dar es Salaam since then I'm a wheelchair tennis player," she disclosed.

"The challenge is that I can not manage to raise bus fare every day to and from home, our association has no reliable means of income, we ing ground at Dar es Salaam Gymkhana Club without eating," Rehema, who is pursuing a diploma at the Institute of Social Work, noted.

(TPC) disclosed it knows the challenges that many women with disabilities face.

Ramadhan Namkomveka, TPC secretary-general, said they value the contribution Para female athletes have made to the country and they are in the process of forming a women's commission.

He said the commission will advance women with disabilities' participation in sporting activities and speak out on their concerns and challenges

"In TPC executive committee, we have four women namely Nyamizi Mhoja, Berdina Nyenyembe, Mariam Mteve, and Marian Mponji, they represent the interests of Para female athletes, we are also in the process of forming a women's commission, the aim is to see that women are well represented," he said.

Barcelona and sharp-again Aubameyang in **Europa League** trophy hunt

BARCELONA

BARCELONA and a rejuvenated Pierre-Emerick Aubameyang and Europa League specialists Sevilla will spearhead Spain's challenge in the last 16 of the competition today.

Sevilla host English side West Ham in the first leg while Barcelona take on Turkish club Galatasaray at the Camp Nou, in two of the most attractive ties of the round.

Five-time European champions Barcelona are still adjusting to the unfamiliar surroundings of the continent's secondary competition after crashing out of the Champions League in the group stage for the first time in 18 years.

They face Galatasaray at Camp Nou on the back of their best run of the season after four victories in a row, including an impressive 4-2 win away at Napoli in the previous round.

They sit third in La Liga and have not lost in the league since December, boosted by a busy January transfer window in which they signed Aubameyang from Arsenal as well as Ferran Torres and Adama

Aubameyang and Torres have scored seven goals between them in Barca's last five games.

"We have four wins in a row and this hasn't happened for a long time," said coach Xavi Hernandez on Sunday. "The players believe in what we are doing. We are on the right path."

The Europa League is still Barcelona's only realistic hope of winning a trophy this season and there remains a defensive fragility that will offer opponents encouragement.

But Barca will be heavy favourites against a Galatasaray side that have struggled recently, winning only twice in their last 15 matches.

Sevilla, who have won the Europa League four times in the last eight seasons, will face a West Ham side who are battling for a trophy.

The Hammers' chances of finishing in the top four of the Premier League are slipping away, with Arsenal now firm favourites to secure the final Champions League spot and Tottenham and United still battling too.

West Ham captain Mark Noble said his team's fighting performance in the 1-0 defeat to Liverpool last Saturday would restore belief after a rocky patch in which they were also knocked out of the

"That performance will give us a lot of belief and hopefully we can take that into the Europa League now," Noble said on the club's website.

Sevilla return to **Europa League** against West Ham wondering what might have been

A PROMISING season for Sevilla could be in danger of petering out but it would be no surprise if they finished with a flourish in the Europa League.

Their last-16 tie against West Ham starts at the Ramon Sanchez Pizjuan today, pitting two of the tournament's favourites against each other in the first round of the knock-out stage.

But while West Ham have enjoyed an impressive season in the Premier League, where until recently they were challenging for the top four, Sevilla's Europa League pedigree is unparallelled.

They have won the tournament six times, twice as many as anyone else, with four of those successes coming in the last eight years alone. Apart from Barcelona, Sevilla are surely the team to beat.

Yet there was hope this season could also bring something more - lifting the Copa del Rey, a deep run in the Champions League or, most tantalisingly, winning La Liga.

Atletico Madrid showed last term how crisis at Barcelona and the sense of an era ending at Real Madrid has created an opening, a rare chance for Spain's traditional challengers to become champi-

Even Sevilla have appeared to smell an opportunity, shifting the emphasis of their transfer strategy away from planning for the future and more towards achieving in the present.

They turned down huge bids for star players like Jules Kounde and Diego Carlos, targets for Chelsea and Newcastle respectively, and instead brought in Anthony Martial on loan from Manchester United.

Last summer, they traded the promising Bryan Gil for 30 million euros and the more established Erik Lamela.

For most of the season, Sevilla have thrived, cementing themselves as Real Madrid's only challengers while Barca and Atletico have been scrapping to regain their place in the top four.

'Overconfident' Liverpool edge through despite defeat to Inter

LONDON

OHAMED Salah admitted might suffered from complacency as they crept into a fourth Champions League quarter-final in five years despite a rare 1-0 defeat at Anfield to Inter Milan on Tuesday.

The Italian champions were unable to scale the mountain they had to climb after losing the first leg 2-0 at home three weeks ago despite Lautaro Martinez's sensational strike into the top corner just after the hour mark.

Alexis Sanchez's red card shortly afterwards punctured any Inter momentum and Liverpool comfortably held out with the extra man despite slipping to just a third defeat in 44 games in all competitions this season.

The Reds had been on a 12-game winning run to keep alive their hopes of a historic quadruple of trophies.

After lifting the League Cup last month, Jurgen Klopp's men are now into the last eight of both the Champions League and FA Cup and have a game in hand to cut Manchester City's six-point lead at the top of the Premier League.

And Salah hopes they can learn from a rare off night in front of goal as they failed to score for just the fourth time this season.

"We lost the game and maybe that will give us a push,"

Bayern blast into Champions League quarters as Lewandowski hat-trick sinks Salzburg

Lewandowski Champions League quarter-finals with a 7-1 win at home to Red Bull Salzburg on Tuesday.

The Polish striker had three goals to his name by the 23rd minute -- the earliest anyone has ever completed a hat-trick in a Champions League game -- as Bayern shook off their early nerves to crush Salzburg.
