

Samia: Courts need to deploy best technology, digitise all data

Judges and magistrates have a role to play in ensuring peace and tranquillity reigns in the society

PRESIDENT Samia Suluhu Hassan yesterday called on judicial administrators in Africa to deploy the latest technology and digitise court data for effective performance, networking, information sharing and record keeping in synchrony with the modern age.

The president issued this appeal when opened the Southern and Eastern Africa Chief Justices' Forum, its conference and annual general meeting taking place here.

"Modern technology also brings ordinary people closer to the judicial system, making it easier for them to access justice, make appeals and even learn about the laws and their periodic reviews right from the palms of their hands," she stated.

Modern technology in legal matters also helps to solve conflicts amicably, she af-

firmed, while Namibian Chief Justice Peter Shivute, the chairman of the Southern and Eastern African Judicial Administrators Association, pointed out that as time goes by, it is ordinary people who will be in charge of judicial dispensation, as they are increasingly empowered to that effect.

"Judges and magistrates have a role to play in ensuring peace and tranquillity reigns in the society," he said, with host Chief Justice Prof Khamis Juma asserting that all matters involving legal systems are cross-cutting.

They affect practically every person in the society, he said, affirming that it is why judges from all over the continent are gathering to discuss justice delivery and judiciary independence.

The forum discussed the role of national judiciaries in dispute resolutions under the Af-



ZANZIBAR President Dr Hussein Ali Mwinyi has said that the government has come up with a new system to engage the private sector in providing services in public hospitals to further strengthen access to quality healthcare.

He made the statement yesterday here during the launch of North A district hospital in Kivunge which is one of the 10 hospitals constructed with support of the funds released by the International Monetary Fund (IMF) to help finance Tanzania's urgent balance of payment needs stemming from the outbreak of the COVID-19 pandemic.

Dr Mwinyi however said that some people are unhappy with the reforms that are effective in bolstering provision of better and faster health services to the people.

He said the government will not be ready to see health services declining due to various challenges. That's why it has welcomed the private sector in the hospital to boost provision of quality medical services and reduce disease burden.

According to Dr Mwinyi, the government has granted some private entities a role to

in various public hospitals so as to strengthen provision of timely medical check-ups to

"We have do this due a major challenge which has been facing many of our public hospitals of the long procedure in producing medical devices, this is a big challenge because if devices in laboratories are damaged, the government procedure wants a hospital to follow the procurement law which takes time to be completed and it hurts people, no patient can wait until the procurement process is completed," he explained.

He wanted the private organisations which have been given the role to operate in public hospitals to fulfil their responsibilities effectively by providing timely and quality services to people including availability of medicines and medical equipment.

President Mwinyi also allayed fears among public workers saying that the new system will not affect their employment and the

health sector by ensuring that the society is free from disease.

He added that the government has been improving health infrastructures such as constructing new hospital buildings in all districts of Unguja and Pemba and purchase of modern medical equipment and engaging the private sector by outsourcing some of the operations like medical lab, for increased efficiency.

Nassor Ahmed Mazrui, Minister for Health in the Isles said that the North A district has a total of 162,000 people with 15 basic health centres, 15 private hospitals and 11 private medical shops.

The new district hospital, equipped with modern equipment, has been built at a cost of 5.5bn/- where the medical tools cost

The hospital is run in collaboration with the private sector which are the Saifee and Lancet institutions from India and it started providing services in May, this year.

MNH gynaecologist issues an alert on uncontrolled use of antibiotics

THE Muhimbili National Hospital (MNH) gynaecologist has issued an alert over uncontrolled use of antibiotics linked with the increase of urinary tract infection (UTI) cases.

Dr Lilian Mnabwiru, MNH gynaecologist said yesterday when speaking at one-day seminar on a number of health issues. The training was organised by the Ministry of Health on the importance of clinical and laboratory services to enhance proper

According to Dr Lilian, females were the most affected group followed by children adding that unless checked the problem might escalate.

UTI is a common infection that happens

when bacteria, often from the skin or rectum, enter the urethra, and infect the urinary tract. The infections can affect several parts of the urinary tract, but the most common type is a bladder infection

Dr Mnabwiru said another reason as lack of awareness on how to prevent themselves against the disease including proper hygiene practices, stressing that if not treated properly, UTI can sometimes be life-threatening advising all those found with symptoms to take action of going to hospital for medical checkup.

"At this juncture, self-medication is not the right decision. We call on the community to take action by reporting to the nearest health facility when they feel any condition that is not normal,"she said.

She further advised the community to avoid attending in unregistered laboratories (street laboratories) instead must attend in hospitals and always follow the experts' prescriptions for their health.

She however said that the community can prevent itself from the UTI infection by drinking plenty of water and taking preventive antibiotics.

According to her, the public must attend to health facilities for body tests and diagnosis to identify the problem before starting using drugs.

She said UTIs in older women may be associated with decreased estrogen levels during menopause, forgetfulness, memory loss or other age-related cognitive declines which lead to decline in good hygiene and health procedures.

Scientists and researchers urged to invest in more innovative initiatives

SCIENTISTS and researchers in the country have been urged to invest more in innovative initiatives to grab opportunities in the emerging technologies which will produce helpful solutions in the society.

Andrey Avetisyan, Russian Ambassador to Tanzania made the call in Dar es Salaam yesterday during the opening of the two-day Robotics Forum for students of technical universities, high school and colleges in Tanzania.

He noted that a few decades ago, modern robots seemed like something out of the realm of science fiction but now they are firmly embedded in a person's life helping in production, perform surgical operations, and are used in intelligence operations.

He said scientists and researchers should utilise the emerging technologies by coming up with innovative that solutions address challenges in various fields such as agriculture, health, mining and others.

He further said that as Tanzania is interested in building satellites, having enough and competent scientists was a matter of paramount importance that's why Russia has chipped in to educate the students and various young innovators on the emerging technologies.

He further said that the forum will also dig deep on the use of robots in space research.

"This is a platform for the exchange of experience and knowledge between specialists from the Russian Federation, teachers, students and students of the United Republic of Tanzania to further

to spur development," he said.

"We can promote these new technologies to help address challenges and boost development. We are coming to Tanzania not just for trade but also to promote and support various development initiatives," he said.

The ambassador robots can be designed and used to bring efficiency in various fields including agriculture, health, hazardous environment, medical and many other areas.

Aldin Mutembei from the University of Dar es Salaam (UDSM) said young scientists have a role to ensure that they focus their initiatives in creating robots to support development of various sectors including agriculture.

He said these technological tools, which replace human power, save time and labour, speed up the production process and increase product quality efficiency consistency in certain settings.

"Robots in agriculture can help automate processes such as plant care, irrigation, fertiliser to speed up production processes and reduce human error rates, this is very important in this fast changing World, adopting solutions to help speed up our work is very important," he explained.

The robotics forum for students of technical universities, high school students of colleges and schools in Tanzania is today expected to take place at the Russian House in Dar es

Swiss Ambassador roots for programme to align women empowerment initiatives

THE Swiss Ambassador to Tanzania, Didier Chassot, has talked of the need to have a special programme to align women empowerment initiatives with international laws and regional gender protocols.

Ambassador Chassot made the suggestion yesterday during a stakeholder meeting for Civil Society Organisations (CSOs) involved in democracy and human rights which was held in Arusha.

The envoy hailed Tanzania for being the best among countries in Africa implementing the Maputo Protocol including recognising the importance of gender equality.

"Tanzania is doing very well in implementing the Maputo Protocol because it has various opportunities for women, we have seen that they are doing a good job and they have been successful," he said.

Ambassador Chassot said through the protocol, women have been empowered as there are more initiatives to ensure women are given the opportunity in all the platforms.

Head of the Africa Democracy Human Rights Centre, Hannah Foster said there is a need to enhance promotion of as stipulated in various regional their wellbeing," he said.

He said the protocol mentions women rights and the violences that they get in their daily life adding that there is a need for the 45 African countries which have ratified the protocol to implement its contents.

"Women have the role to protect African values as outlined in various regional and continental documents by taking into consideration equality, peace, human rights and democracy," she said.

She said the Protocol guarantees extensive rights to women, including the right to take part in the political processes, to social and political equality with men, improved autonomy in their reproductive health decisions, and an end to harmful traditional practices such as female genital mutilation, among others.

President of the East African Court of Justice (EACJ) Nestor Kayobera said there have been worries about over implementation of human rights in relation to international law in many countries which have ratified the protocol.

THE government has reiterated that it is committed to eradicate child labour in the country while promoting environmental awareness to facilitate access to decent jobs.



'Mineral sector contribution to the national economy is set to increase'

MINERAL sector contribution to the national economy is set to increase as the government embarks on a survey to detect its full potential by 2030, it has been

Minister for Minerals, Anthony Mavunde, said here at the weekend that only 16 percent of the entire country's land had so far been surveyed, and that with current minerals in Tanzania, his ministry collected 678bn/- in revenues during the 2022/23 financial year.

He said this in request to President Samia Suluhu Hassan to allow the ministry conduct a High Resolution Airborne Geographical Survey to determine the amount of minerals in the whole country.

He said, once the survey is completed, the government, miners and other stakeholders in the sector will be able to know exactly where different types of minerals are found.

"Just imagine we managed to collect that amount with only a portion of 16 per cent of the land, this means, if we intensify Geophysical Airborne Survey, we will hike our economy through the sector as well as improving the lives of miners," he said.

In her response, the head of state, agreed on the request and tasked the ministry to go ahead with the in order to precisely detect the potentiality of minerals.

According to experts, airborne geophysical surveys are performed with the aid of fixed-wing aircrafts or helicopters. These measurements can show different properties of the bedrock or soils, from ground level down to several kilometres depth, depending on the method used.

The Head of State said the survey is a milestone as it will hike revenues obtained from the mining sector, thus reducing national budget deficit, donor dependence as well as cutting down loans appetite.

Mgaya said the project began to be implemented in January 2016 and will be completed in December this year.

Once it is over, it will enable Tanzania to procure electricity energy, sell or transport from one point to the other.

He said that upon completion, the project translates the idea of transmitting electric energy from the "Cape to Cairo" of African leaders.

The manager said currently, the testing and commission was taking place before other handing over procedures.

He said by connecting the country to the EAC power pool, Tanzania is also connected to the southern power pool.

Mgaya noted that in case one country purchases power from Ethiopia, the country's infrastructure will be used to transmit charged concession fees.

Apart from that, the project will improve power distribution for Kilimanjaro and Tanga Region through Njiro substation.

This can be done by converting 400 kilovolts to 220 kilovolts at Lemguru power station before being distributed to neighbouring regions.

Tabuchi Somoyoshi, Second Secretary at the Japan Embassy in Tanzania said that Japan has been supporting the implementation of the energy sector in the country which is of great significance.

Industries database can push forward credit, supply chains

initiated by the Tanzania Industrial Research and Development Organisation (TIRDO) for a database on industries in the country and the state of their operations. The data would be placed in a welldesigned access mode for users of such data, especially local and foreign traders and businessmen. Database information will include the location of a particular industry, environmental aspects of operations, along with details on supply of raw materials. Other features are expected to be water, roads and communication infrastructure, alongside the right picture of human resources in an industry, etc.

Well placed TIRDO officials underlined the need for each industrial premises to have accurate information that is verified by regulatory agencies, presumably, alluding to the need for accurate information on industries and the locations that investors wish to place their funds. This allusion is in part an observation as to the source of the need for such a database, that foreign investors are lost as to what there is in the country, as data is sparse and disjointed, relating to uncoordinated surveys. The data is enough for some regulatory bodies; less so for new investors.

The sources affirmed that after the database is compiled to ensure that anyone can access the database, reports on industries and investments will be fathered from the database, The main areas being watched are Dar es Sslaam, Morogoro and Coast regions as they have more than 50 per cent of industrial capacity in the country, while the database will indicate optimal production capacity in the various industries and why it is not being realised. That would

are being assist policy makers to figure out what measures need to be taken to boost production, with reference to specific types of goods, while learning on the workforce level; gender structure.

While having a database is always helpful for decision making at the level of private sector planning and public agencies, whether regulatory or other, for instance in accuracy of academic research or political representation, it may have its other side. If the database is collected to enable seizing up of drawbacks to investors and how to clear then, it will be a great idea, but if it is meant to be used for regulatory purposes where the government imposes operational conditions on the private sector, it can impede industrial take up. It can be 'industrial espionage.'

That doesn't mean there is no need for a database on how regulatory aspects on industries are observed. Far from it, as the issue is who raises the demand, that if it is workers on the spot they have avenues and options. Regulators are less flexible as they are less keen on the survival margins of industrial operators, are likely to be more concerned with workers' welfare and government revenues to the detriment of margins of competitive ability in the market, and even attraction to invest

One particular area being sought after in the database is how far an industry has shown that it qualifies to be in the country. It is an aspect rapidly tempered by an observation that those operating below par could be assigned credit channels to help them boost their operations. There is an additional note that anyone wishing to start a factory or such industry will have to seek registration in the database system so that the industry's data becomes available to the public and to other regulators

voiced satisfaction with the newly signed port concession agreement between the government and the Dubai based DP World, a ports investment and operational firm. For the first time the public reaction on the agreement was short of its being divided down the middle for biases, for and against the deal in relation to wider political or social loyalties. It was an altogether different atmosphere that will reduce the tensions otherwise stocked by the dispute.

Experts in communication will differ as to what indeed changed from the first draft agreement to the three agreements signed at the weekend, if it was altered content or communication on the issue was improved somewhat.

There are elements of both, as in preliminary negotiations the stronger party may seek onerous protective clauses, and when this is seen to be burdensome, shifts gear to minimally facilitating a workable agreement, optimal as to the local prerogatives on the newly contracted operational firm. So the picture is that investment interests were ceded somewhat for greater transparency, visible limits on contractual engagement, profit sharing mechanism or more accurately the distribution of gross revenues, etc.

Experts were at pains to point out that without a port investment deal, the strategic market of the Democratic Republic of Congo, whose market size and economic potential makes it the largest economy in the sub-region in the not so far future, to rival ports in Angola or Congo Brazzaville. This would hurt not just the port but its

EY opinion makers have attendant complementary railway infrastructure, the standard gauge railway, which can only be optimally used with assured priority of Dar port for nearby landlocked countries. With the proverbial stroke of a pen, all this is now largely guaranteed.

While some opinion makers were still keen on following up to see how much of popular opinion demands had indeed been taken up, the wider impression was that the key issues raised in popular discussion had indeed been taken into consideration. There is likely to be a continuing dispute as to what was actually being demanded by the public as a whole and what areas of emphasis came up from special groups. There is also the issue of how far they are likely to persist in their demands, which is unavoidable, so long as the sentiment of the vast majority is at peace with the protocols thus signed.

It will be a major input to harmony, and a reminder to naysayers on the ability of those in office to listen and to guide, that this ability remains in place even in the thick of challenges. The DP World pact was ruefully antithetic to plenty of what the country has always stood for, and many wished that it is brushed aside and the ports remain safe in local hands without concessions.

It was to forget that the ports need to do business, and that the anchor of port business isn't what is needed in the city of Dar es Salaam and even less so, by inland regions. Sealing the pact is an assurance to neighbouring countries that the country is willing and ready to do business, is mindful of competition, and will safeguard investor interests. **The Guardian Limited Key Contacts**



How about declaring drug abuse a truly national state of disaster?

drug substance abuse affects development in an emerging economy like Zimbabwe that is on an unprecedented path to success is not an understatement.

As the problem grows in Zimbabwe, many are now realising how communities are watching helpless as young people and in some instances the elderly indulge in the illicit drugs that come in various types, some home-made, while others are smuggled from across borders.

A major problem now in Zimbabwe, if not addressed drug and substance abuse can lead to catastrophic results on the country's development agenda.

President Mnangagwa's government is fully aware of consequences, the President has set up the National Committee on Drugs and Substance Abuse chaired by Defence Minister Oppah Muchinguri-Kashiri.

There is also the Inter-Ministerial Taskforce on Drug and Substance Abuse for which experienced health expert Dr Agnes Mahomva will be appointed the national coordinator.

The National Committee on Drugs and Substance Abuse is made up of various stakeholders, including Government, the police, the Medicines Control Authority of Zimbabwe and the Zimbabwe Revenue Authority.

Last week, Cabinet received and approved a report by the Inter-Ministerial Task Force on Drug and Substance Abuse that Minister Muchinguri-Kashiri presented.

The national committee has frequently met in light of the observed increases in drug and substance abuse cases.

The pillars of this national committee chaired by Minister Muchinguri-Kashiri include supply reduction, demand reduction, harm reduction, treatment and rehabilitation, psycho-social support community re-integration, and the media and information pillars.

After establishing these steps towards eradicating the drugs scourge, the next step should be the declaration of the problem as a national state of disaster.

This is because drugs have

affected the whole nation, with means more funds have to be the potential to reverse the developmental gains being scored by the Second Republic.

Declaring the drugs problems a national state of disaster will trigger emergency powers which enable the Government to triple efforts to mitigate this disaster.

This will give the Government additional powers to respond to the crisis, with fewer bureaucratic delays and less oversight.

There is indeed a huge link between development and drugs, and the link is not helpful at all.

Drugs have a huge potential to derail development in many ways.

Apart from disrupting the flow of developmental programmes, drugs are a security threat to the nation and this could explain why President Mnangagwa had to appoint the Minister of Defence to chair the national committee on drugs and substance abuse.

It is clear from the recent experiences in Zimbabwe that youths are the most affected by drugs, although many other elderly are now taking them too.

Yet, youths should be the major drivers and beneficiaries of development as their full participation is vital. Drugs do not discriminate on the basis of one's gender, education, or any other qualification. People from various walks of life are taking drugs.

The drugs problem has ceased to be just an individual matter, but a cause of concern for the whole country.

This is because the impact of drugs is easily felt on health, development security and peace.

Many of the youths who are into drugs are compromising their health, in the end overwhelming the health delivery system as they seek treatment and rehabilitation.

There were reports recently that the majority of those in rehabilitation centres in Zimbabwe were mainly youths suffering from the effects of drugs. These young people, who are the most affected, have their future soiled as they may be unable to realise their potential to contribute or benefit from development.

In fact, it is now known that drugs can overwhelm various systems of governance as resources are diverted to deal with their effect on individuals. The more people indulge in drugs

directed towards law enforcement as crime is set to increase because of the reckless behaviour that is associated with getting high.

this week, Commissioner-General Godwin Matanga revealed that criminal cases dealt with by the police rose 12 percent during the first eight months of this year compared to the same period last year, with most of the extra caseload being linked to drug abuse.

The justice delivery system, mainly the courts, are in turn inundated with cases emanating from crimes committed under the influence of drugs.

As pointed above, the healthcare system has to fork out more resources, both financial and human, to attend to those whose health is negatively affected by the drugs.

No person can give their all to an assignment when they are high on drugs, and this means affecting productivity in industries and on farms, with devastating consequences on the nation's economic progress.

Communities become no longer safe as cases of violence, murder and robbery increase because of those in the habit of taking drugs.

This calls for a systematic fight against drug and substance abuse and the national committee and the inter-ministerial taskforce on drug and substance abuse have been established for just that purpose.

In the matrix of fighting drugs abuse should be the media, which has the potential to either bring relevant messages that turn people against the drugs or inflame the situation.

It is time the media in Zimbabwe, both print and broadcast, reexamine their programming and content to ensure anything that appears to incite people to take drugs is eliminated from reaching their audiences. But it is unfortunate that some, especially radio stations, have been found wanting on this front and need to have a re-look at how they conduct their business.

Some radio presenters have been bringing guests in studio whom listeners can adjudge to be high on drugs, while the presenters themselves worsen the situation by appearing to acclaim

It is now common to hear a radio presenter saying to a guest on air: "Aaaah mudhara makatobatwa ka imi" (elder you are high on drugs).

In the end, the conclusion coming out of such a discussion appears to condone the taking of drugs, as it ceases to be a campaign against the vice.

Apart from the media, law enforcement agents should up their fight against drugs, ensuring that all the so-called "drug bases" are destroyed.

Drugs do not start with those who take them, as there are a lot more people involved.

There are the drug lords themselves and their runners who bring the illicit product to the consumers. These should be identified and dealt with without fear or favour.

In short, the battle against drugs has to be multi-pronged including arresting and prosecuting dealers, producers, smugglers suppliers; cleaning up the mess that the drug trade leaves in its wake and trying to persuade as many people as possible to stop experimenting with drugs.

There are physical signs which experts note can indicate someone is taking drugs.

Anyone has the potential to take drugs despite their status in society. This gives everyone a duty to watch over potential indicators that some may have started taking

Physical signs to watch for include mood swings, irritability, unjustified anger, delusions or hallucinations, inability to focus or make decisions, paranoia, depression, anxiety and violent tendencies.

Individuals who take drugs can suffer from loss of appetite, disrupted sleep patterns, increased risk of heart attack or stroke and lung or heart disease. Health experts also note that drugs can cause a diminished immune system function and infection, gastrointestinal issues, respiratory problems, liver damage, kidney damage and neurological issues.

Imagine all these health problems or even some of them, affecting one person. The result is in most cases death. This calls for a holistic approach to the drug and substance abuse, lest the problem continues to affect the country and in the process hindering development.

Communities and conservationist bring endangered gorillas back from the brink

ROSS River gorillas - once believed to be extinct - are experiencing something of a population revival in the southwest of Nigeria thanks to joint conservation efforts by the nine communities surrounding the Mbe Mountains where the gorillas are prevalent.

Leading the efforts is Jonathan Eban, the Wildlife Conservation Society's project manager at the Mbe Mountains - along the borders of Cameroon and Nigeria – who has been working as an eco-guard for the past 12 years. During this time, his team has monitored the gorillas and conducted patrols to ensure none were killed by poachers.

"We have been doing this for the past 12 years. We discovered that the number of gorillas was actually increasing. Though we haven't conducted a census yet, we have camera footage in Mbe Mountain that shows babies and infant gorillas. That is a clear indicator that the gorilla populations are increasing," Eban said.

"[In] 2012, there was a census projected by the IUCN [International Union for Conservation of Nature] gorilla action plan, that put the population between 25 and 30. Since then, we haven't conducted a formal census to really know the number at present. However, we capture a lot of footage on camera traps, and the estimate is at 35 or 40," Eban said in a call from his base in the Mbe Mountains.

According to the IUCN Red List, the Cross River gorilla has been considered critically endangered since 2016 because of its declining population. The gorilla's dwindling numbers are closely linked to poaching, while habitat loss from agriculture, logging and road construction, alongside snares targeting other species, has also been a contributing factor. It's estimated that there are about 100 to 250 mature Cross River gorillas.

Eban said that in the 1980s, Cross River gorillas were thought to be extinct – until a hunter from a community near the Mbe Mountains captured a baby Cross River gorilla. International conservation bodies learnt of this, which sparked the Wildlife Conservation Society's Mbe Mountains project.

"There haven't been gorilla killings since the inception of this project, but people still hunt to sustain their said.

livelihood. Hunting and the expansion of agricultural land are a threat. But it can be fixed if handled properly with long-term conservation in mind," Eban

The Wildlife Conservation Society also works with local communities to explore livelihoods such as beekeeping, snail farming and supplying improved cocoa varieties.

Zanzibar seaweed farmer dreams big as her products head to 6th CIIE

visit to Bweleo, a stone's throw away from the Indian Ocean coastline in Zanzibar, finds soft-spoken Saphia Hashim Makame busy selling her seaweed products in her tiny

Saphia, 58, a mother of six children, has been a seaweed farmer since 1998. She was happy to learn that seaweed products will for the first time be exhibited at the 6th China International Import Expo (CIIE), to be held in Shanghai, China, from Nov. 5-10."I am overjoyed over this good news.

The expo will definitely open doors for seaweed products to the huge Chinese market," she told a team of Xinhua journalists as she arranged her seaweed products in her shop. The products she makes from seaweed include soap, spices, skin jelly, hair oil, lip balm, shampoo, shower jelly, body lotion, cakes, juices, and buns.

"With the exhibition of seaweed products at the expo, my journey to finding global markets has just begun," said Saphia, wearing a broad smile, adding that she currently sells her products to some institutions in Tanzania's port city of Dar es Salaam, in addition to individual customers.

Saphia, who owns three hectares of seaweed, said she started farming the crop in 1998 and in 2006 she started making various products from seaweed after she was trained by experts from the Philippines and Indonesia in collaboration with Zanzibar's Institute of Marine Science of the University of Dar es Salaam.

She said seaweed farming has benefitted her a lot."I get between 1,500,000 Tanzanian shillings (about 600 U.S. dollars) and 2,000,000 Tanzanian shillings a

I have built my own decent house. I pay for my children's medical bills and I have also paid fees for my children to university level without borrowing a single cent from anybody," said Saphia. With the anticipated Chinese market for seaweed products, she was looking forward to creating a huge production structure because "seaweed is like gold and diamonds."

"The 6th CIIE is an entry point to Tanzania's Zanzi-

bar seaweed products," said Aboud Suleiman Jumbe, sector have shown interest in coming to Zanzibar and principal secretary in Zanzibar's Ministry of Blue Economy and Fisheries."When we look at the Shanghai expo, we look at it with extremely high expectations," Jumbe said, noting that he hoped the Shanghai expo would propel Zanzibar's strategic seaweed market, especially in the area of the blue economy.

He told Xinhua that by the end of 2022, Zanzibar had already been producing about 12,594 tonnes of seaweed annually, with exports of close to 14,000 tonnes of seaweed per year, adding that once Zanzibar secured the Chinese market the production of seaweed would double."

Currently we have 23,000 seaweed farmers in Zanzibar and 90 percent of them are women," said Jumbe, noting that the farmers are cultivating mainly two types of seaweed -- eucheuma cottonii and eucheuma spinosum."

Zanzibar has been involved in growing the crop at a commercial level, specifically focusing on these two varieties," he said.

The Chinese government and the Chinese private

developing new varieties of seaweeds that are used for various economic, medicinal, and biotech purposes in China and other parts of the world, he said.

Zanzibar's seaweed farming began to gain pace in the late 1980s when new varieties of commercial seaweed crops were imported from the Philippines and other areas from the Far East,

Jumbe said, adding that seaweed has been a historic crop for many centuries for many people and it has been used in various ways in terms of food and pharmaceuticals.

Since then, he said, Zanzibar has been transformed from an archipelago where seaweed used to grow in the wild into a modern-day commercial and production hub of seaweed crops in the western Indian Ocean region.

He said that since 2020, the Zanzibar government has been transforming the seaweed industry through various programs, including supplying new fiberglass boats to seaweed farmers.

China sees fruitful outcomes in international space cooperation

THROUGH in-depth space cooperation, China and many countries in the world have jointly built a broad and magnificent "space silk road," contributing to the development and utilization of space resources and the progress of human civilization.

The constellation of the Beidou Navigation Satellite System (BDS) is working around the clock in the space. Since the system's commissioning more than three years ago, the application models of the BDS has been enriched, with its fields of application getting wider

According to statistics, the BDS-3 has provided accelerated positioning and high-precision service to more than 1.5 billion users in more than 230 countries and regions, winning more and more recognition from the international community.

In Xai-Xai, Gaza Province of Mozambique, there is a 20,000-hectare rice farm, the largest rice planting cooperation project in Africa. To plough the fields, and plant, manage and harvest crops on such a huge farmland was once a big challenge for local rice growers.

It was the innovation in agricultural technologies utilizing the BDS that benefited local rice growers. They can now control sprayer drones via mobile applications, thanks to the geographical positioning enabled by the Chinese positioning system.

Obtaining real-time geographical information through the BDS, sprayer drones are able to apply pesticides according to preset flight paths. Compared with traditional spraying methods, which rely on manual effort and can only cover a couple mu (667 square meters) each hour, BDS-enabled sprayer drones can treat over 100 mu of land every hour. Moreover, the drones can operate at night, dramatically improving efficiency.

The Sarez Lake in eastern Tajikistan is the world's highest quake lake. It houses the highest and biggest natural dam in the world. Monitoring the deformation of the dam situated in a seismically active zone and thus protecting the safety of local residents remains an important issue.

A Chinese research team developed a deformation monitoring service platform for the dam based on the BDS, with a millimeter-level precision. With this platform, researchers can remotely monitor the deformation of the dam and send science-based warnings. The system has also been employed to monitor express-

way side slopes in Kyrgyzstan and snow slides in Tajikistan.

According to Chen Gucang, deputy director of the China Satellite Navigation Office, the BDS is applied in a wide range of fields, and has played a significant role in the construction of the China-Kyrgyzstan-Uzbekistan highway as well as the operation of China-Kazakhstan crude oil pipeline and the China-Europe freight

Two China-funded prototype satellites of the MisrSat II satellite project were delivered to the Egyptian side in June this year, making Egypt the first African country with the capacity to assemble, integrate and test satellites.

In December 2014, China and Egypt signed an agreement to carry out cooperation on the development of remote-sensing satellites. According to the agreement, China would build Egypt's first satellite assembly, integration and test center.

The two countries signed

an agreement for the MisrSat II satellite project in January 2019, based on which China would provide the Egyptian side with a small remotesensing satellite, a ground measurement and control station and a ground application system. Besides, China would also train Egyptian aerospace

Prior to that, Egypt did not have its own satellite assembly, integration and test center, nor satellite development capabilities. It could only import complete foreign satellites. The completion of the China-funded center has provided Egypt with world-leading aerospace infrastructure. Egyptian Minister of Inter-

national Cooperation Rania Al-Mashat noted that these advanced technologies and equipment are important to not only Egypt, but also entire

China has established cooperation with many countries and regions in jointly developing and launching communi-

cation or remote-sensing satellites, as well as constructing satellite ground receiving stations and other space infrastructure. These efforts have played a positive role in the development of local sectors such as communication, agriculture, culture, environmental protection, and meteorology.

The China National Space Administration said that China is committed to promoting global technological progress and the sharing of innovative achievements, with an aim to enhance the capabilities of people around the world to explore and utilize space.

Ghana floods: 'My entire farm is under the water and so is my house'

AWUSIFE Kagbitor paces anxiously on a dry patch of land overlooking her collapsed and completely submerged three-bedroom home in Mepe in Ghana's Volta Region.

She says she saw water gushing into her house from a nearby stream, and within 10 minutes the water level had reached her neck. On hearing that his mother's home was flooding, her son Kenneth rushed to the scene and swam his way through the rising waters to save his mother and young siblings.

The 56-year-old farmer is one of thousands of victims of the floods in south-east Ghana. It is a disaster she is struggling to come to terms with. They were taken unawares and could not salvage anything, she tells me as beads of tears roll down her face.

"My entire farm is under the water and so is my house. I was only able to take my clothes. It took me about 14 vears to build this house - there is nowhere to go, there is no other land to build on," Ms Kagbitor said.

Her fate is shared by nearly 26,000 others, displaced by floods caused by the controlled spillage of excess water from the Akosombo and Kpong hydro-electric dams near the south-

ern tip of Lake Volta.

What caused the floods?

Ghana has been experiencing unpredictable rainfall patterns for months now, which many scientists say is the result of climate change.

Heavy rains have significantly increased the volume of water in the two dams, and officials of the Volta River Authority, the electricity company that

manages the dams, started the "controlled spillage" of the facilities a month ago.

They say that the maximum safe operational level of the Akosombo dam is 277.5 ft (84.6m). If the water behind the dam reaches any higher, it could burst.

The water level recently peaked just below this - around 277.26 ft, compelling them to "spill" excess water to prevent a catastrophe which could have dire consequences.

The Akosombo and Kpong Dams generate about a third of Ghana's energy mix. The authorities say they will reduce the rate of spillage of the dams while monitoring the volume of water upstream.

The Akosombo dam was built in the 1960s, a project championed by Ghana's first President Kwame Nkrumah to provide much-needed energy to industrialise the country. Its construction flooded parts of the Volta River Basin in the eastern region of southern Ghana and around 80,000 people had to be relocated.

It also led to the creation of the Volta Lake, the largest man-made lake in the world by surface area.

The dam has subsequently been spilled when needed, with limited impact on communities. However, this year's flooding is one of the worst to hit the more than 100 communities living downstream since the dam's creation.

How serious are the floods?

The National Disaster Management Organisation estimates that eight districts have been affected since the flooding started on Wednesday 11 October.

Many homes have been completely submerged and authorities are only beginning to assess the impact of the floods. About a quarter of the Mepe community in an area we visited has been seriously impacted by the water.

Toilet facilities, cemeteries and refuse dumps have all

been flooded, raising serious concerns about the outbreak of disease. Essential services like water and electricity are no longer reaching the affected areas.

Local official Ahorsu Amos Borlor said that residents ignored his repeated warnings to take precautionary measures when the spillage started.

"There are about 15 communities in the lower Volta basin. Eight of them have been greatly affected, farmlands have been washed away, so economic activities have been greatly affected. We are feeling bad, our livelihood has been taken away, this is not how we live," said Mr Borlor.

Local resident Brian Foekpa is still reeling from the disaster. He says the flooding happened so quickly he could not take any of his belongings and could only save his family. "The bike I use for my okada [motorcycle taxi] business is in the room that collapsed, so it has affected me. No food to eat. My farm has been washed away by the floods. As I'm talking to you, these clothes I have on me now are the only ones I have."

The Volta River Authority says it warned residents in the area ahead of the spillage. The power company also carried out simulation exercises with some communities about how to deal with a potential disaster, but that does not seem to have lessened the impact of the floods.

Ghana's navy has been assisting with rescue efforts. It says it has rescued more than 8,000 people so far.

The Deputy Director General of the National Disaster Management Organisation (Nadmo), Seji Saji, attributes the floods to heavy rains brought about by climate change.

"The heavy inflows from upstream of the Volta dams can only be explained by the volume of water that we are receiving from Burkina Faso to the northern region because those form the catchment areas of the Volta dams,"

ICT experts push for 5G adoption in Africa to drive economic growth

KIGALI

INFORMATION and communications technology (ICT) experts attending the Mobile World Congress 2023 (MWC2023) in the Rwandan capital of Kigali have said African countries need to strengthen and speed up efforts in the deployment of 5G networks across the continent to revolutionize industries, enhance connectivity, and drive economic growth.

The meeting, held on October 17-19, brought together more than 2,500 delegates, including political leaders, government officials, experts, representatives from the United Nations and the African Union, as well as dozens of technology companies and start-ups, among others, from across Africa and the world.

"The rollout and deployment of 5G is expected to contribute

to the growth of Africa by creating jobs and improving incomes. The ecosystem surrounding the 5G economy is much more powerful than any other technology that preceded it in the realm of digital communications," Amir Abdelazim, a partner expert with Detecon Consulting, said in an in-

He added that African countries should put in significant efforts to ensure the rapid deployment of 5G networks, unlocking unprecedented opportunities for innovation and economic development on the continent.

"It is remarkable to see how startups in Africa are working to find innovative solutions that can catalyse the rollout of 5G."

Elizabeth Migwalla, vice president of international government affairs for Qualcomm said that the 5G standard is designed to enable new services and use cases across

all sectors of the economy.

"It is the capabilities of 5G that make this transformation possible. When properly deployed and used, every sector of the economy can benefit from 5G, spanning from education and health to governance and transportation in Africa," she added.

While addressing the 5G session on the sidelines of the MWC2023, Li Tao, president of Huawei Southern Africa Wireless Business, emphasized that 5G technology has substantial potential to drive economic growth in Africa.

He noted that Huawei plays a crucial role in delivering 5G technology to the African continent. "5G can stimulate and promote the 5G industry further by enhancing various aspects, such as devices, ecosystem, and network.'

The momentum for 5G is growing in Africa. However, the initial focus for 5G deployment is on urban areas and industrial locations, where there is a greater need for the technology, according to Mobile Economy Sub-Saharan Africa's latest report by Global System for Mobile Communications, a global organization that unifies the mobile ecosystem.

Community radio: Young South Africans helping to shape news

THE number of South African internet users has nearly doubled in the past decade. One 2023 study of 45 developed countries suggests that South Africans even lead the world when it comes to the amount of time spent in front of screens, at 58.2 per cent of the day.

This digital transformation has significant implications for the country's media. Particularly for newsrooms that want to engage online audiences in a time when news production has evolved towards greater participation of citizens and civil society. More and more, listeners are contributing to media processes.

During protests, for example, news outlets often invite people at the scene to use WhatsApp groups to share firsthand observations, images or videos. These are verified and incorporated into news coverage. (Indeed, WhatsApp emerged as South Africa's most popular social media platform in 2022.)

This shift is at the heart of our recent broadcast and community media study. We examined two community radio stations - Zibonele FM and Bush Radio - in South Africa's Western Cape province. way that young people interact with the stations, and how radio is adapting to meet them online.

In the study it was found that the stations have embraced social media apps and are actively using them to shape content. Young people are increasingly participating in citizen journalism to influence this content.

This could keep community radio relevant - and that matters.

South Africa is home to over 290 community radio stations, far outnumbering the 41 commercial and public service stations. Community radio emerged with democracy in South Africa in the 1990s, providing a platform for alternative voices and grassroots organisations. It's able to address issues often overlooked by mainstream media.

Zibonele FM and Bush Radio stood out for us. This is because of their youth-focused content, multilingual broadcasts, diverse audience segments and robust use of digital technologies in news production and programming.

Zibonele FM is based in Khayelitsha, a vast township (black residential area) on the outskirts of Cape Town. The station broadcasts mainly in the local Xhosa language.

Our data analysis revealed that young audiences on X and Facebook used these platforms to hold journalists accountable, forcing them to re-evaluate their reporting.

One producer said: "Any mistake leads to immediate corrections. This caution improves our content quality and accuracy, benefitting from feedback from our social media followers.

The participants in our study stressed the importance of WhatsApp voice notes as a feature of social media that enabled greater engagement from youth audiences. Young listeners are actively shaping the content production process by sending questions as voice notes. This shift diminishes the power traditionally held by presenters and producers.

One producer elaborated: "When we interview guests, we inform our audiences that we have a question, and they actively engage with it. During interviews, we encourage young diverse voices on air, as people often prefer sending voice notes, sometimes in the form of questions."

Our research underscores how Zibonele FM and Bush Radio have empowered young listeners to engage with journalists actively. This allows them to question and challenge news content. Station managers reported in-

creased engagement on social media, reinforcing the effectiveness of these strategies in expanding reach and enhancing audience participation. Young audiences, for their part, also used social media to hold journalists accountable, fostering a culture of transparency and trust.

Empowering women smallholder farmers in Africa with climate-resilient and nutritious maize varieties

IN the vast landscapes of sub-Saharan Africa, where agriculture is the backbone of many communities, the quest for improved maize varieties is a vital step for ensuring food security in the face of climate change.

Women, who represent approximately half the clients of maize breeding programs, have been essential in the realm of agricultural research. While significant genderbased differences in trait preferences exist in many African-staple crops, these appear less drastic in maize.

However, there are gendered differences in management practices and productivity in maize-based systems.

Recognising the need to bridge this gap, the National Agricultural Research and Extension Systems (CIMMYT-NARES) regional maize breeding networks in eastern and southern Africa have embarked on a transformative journey to empower farmers, especially women, through their innovative approach to maize breeding.

The breeding networks are focused on ensuring smallholder farmers have access to a steady stream of climate-resilient and nutritionally enriched maize varieties that thrive in today's stress-prone environments.

To ensure these new maize varieties meet the needs of diverse users, including women, the breeding networks continue to adapt approaches to increase gender-responsiveness.

Testing the performance of potential new maize hybrids coming from the breeding pipelines within farmers' realities is critical to the ultimate success of these new varie-

In collaboration with over 400 farmers in southern Africa, the CIMMYT-NARES maize breeding network conducts extensive

on-farm trials to evaluate the performance of these new maize varieties. A similar approach is adopted in eastern Africa.

What sets these trials apart is the fact that over 40% of these trials are led by female plot managers. Farmers evaluate these varieties within the context of their own realities, including their own management practices, and provide valuable feedback to the breeding teams on the potential of new varieties.

By involving women in decision-making processes, CIMMYT-NARES networks ensure that their preferences and needs are considered when selecting the most promising hybrids for product advancement, announcement to partners, varietal releases and ultimately commercialization.

This inclusive approach not only empowers women but also harnesses the collective knowledge and experience of the farming community.

CIMMYT's research recently showed that there is a relatively high degree of joint management within maize plots, and since 2022, the on-farm trials included a target of approximately 30 per cent jointly managed plots.

Gender is only one axis of social difference that impacts agricultural production, variety selection, and end uses. Social differences including marital status, age, education level, ethnicity, wealth, access to capital, market access and livelihood orientation do play a role in the adoption of new varieties and farm productivity.

By embracing the diversity within farming communities, CIMMYT-NARES networks are actively working towards understanding different farm types, while ensuring that the improved maize varieties are tailored to meet the diverse demands of the regions.

As the CIMMYT-NARES maize breeding



networks continue to make innovative ture but also empowering individuals and strides in breeding climate-resilient and nutritionally enriched maize varieties, they are not only transforming agricul-

communities.

Through collaborative efforts, with the woman farmer at the heart of the approach, they are paving the way for a future where farming communities can thrive and contribute to food and nutritional security.

Seniors thriving through plastic waste in Zimbabwe

HEY do not have a pension nor financial support from families or relatives, but they have themselves. Now they have become collectors of plastic waste, which they turn into products as they battle for survival - earning money from the growing plastic pollution in Zimbabwe.

Such are the lives of the country's senior citizens, like 76-year-old Tabeth Gowere and 81-year-old Elizabeth Makufa, both hailing from Harare's Glenora high-density suburb, where they become famous as plastic waste collectors.

Gowere and Makufa, thanks to plastic waste, now care for themselves financially despite their old age, so they said.

"At first, we saw plastic waste just being flown around by the wind, and we started to pick these, cleaning the environment, burning it, but later realized we could make something out of these plastics and earn money. So, using plastic waste, we started weaving different things, including mats to decorate sofas. Many people were impressed by our work, and they started placing orders for the plastic products we were making," Gowere told IPS.

Makufa, like Gowere, has also seen gold in the dumped

"We say this is waste, but from it, we find something that is helping us to sustain us in life. I make 30 US dollars daily at times from selling the products I make from plastic waste, which means at least I get something to survive," Makufa told IPS.

The young are learning from the lessons from the senior plastic waste entrepreneurs - like 40-year-old Michelle

"Weaving things using plastics is a skill I learned from my mother-in-law, Mrs Gowere. We spend time together daily, and because of this, I ended up learning the skill from her; this is helping me to, at least, help my children with food to carry in their lunch boxes when they go to school," Michelle told IPS.

To Michelle's mother-in-law and many others, the environment has been the secondary beneficiary of the geriatrics' initiative collecting plastic waste.

"You would see that in our area, waste collectors from the council rarely come to empty the refuse bins. So, as we use plastic waste to make our products, we are making our environment clean," Michelle told IPS.

Zimbabwe Environmental Management Agency (EMA) about 1.65 million tonnes of waste are produced annually in Zimbabwe, with plastic making up 18 percent of that.

However, Makufa says it was not the love of money that swayed them into getting into plastic waste but improving the environment.

"It was not because we lacked money that we turned to collecting plastic waste, but we copied some people who were doing it, and we started doing the same. We thought of removing plastic waste from our environment, and we told ourselves if we could take those plastics and weave them together, we could have impressive products that we could sell and earn some money," Makufa told IPS.

As the group of elderly people are making a difference in collectively fighting plastic waste, the local authorities welcome their contribution but add that it is everybody's responsibility to care for the environment.

"The job of caring for the environment is not a responsibility of the council alone. In fact, it is the duty of everyone to make sure where they live there is cleanliness. As a council, we thank people who are beginning to realize that there is money in plastic waste. It's not every waste that should be dumped; there is what we call recycling, and some people make money from it, but the duty to take care of our surroundings is not a prerogative of the council, but ordinary people as well," Innocent Ruwende, Harare City Council spokesperson, told IPS.

Priscilla Gavi, director of Help Age Zimbabwe, a non-governmental organization mandated to take care of the elderly's needs, says the elderly, too, are critical in the fight against plastic waste.

"Old age does not make someone incapable of supporting their families and taking care of themselves. It doesn't stop the aged from working for their country. In fact, old age gives people opportunities to use skills gained during their prime ages, and they, for instance, make use of plastics, producing different things for sale from plastic waste as they also rid the environment of the plastic waste," Gavi told IPS.

Yet for many like Makufa, collecting plastic waste has

also turned out to be therapeutic in addition to being an economic venture.

"These things that we make with our own hands using plastic waste help us to rest from mental stress owing to problems we have these days that strain us psychologically. So, this helps us to be always occupied and refrain from overthinking about things we don't have control over," said Makufa.

According to the Environmental Management Agency (EMA), an estimated 1.65 million tonnes of waste are produced annually in Zimbabwe, with plastic making

up to 18 percent of that.

Gowere and Makufa and other elderly recyclers and plastic entrepreneurs have drawn the admiration of organizations like EMA.

"This is a commendable initiative that is promoting upcycling of waste and upscaling recycling as a business. This reduces the amount of waste that ends up in landfills and the environment. Plastic waste takes hundreds of years to decompose, and it releases harmful toxins into the environment when burned," Amkela Sidange, spokesperson for EMA, told IPS.

Global billionaire taxing could yield \$250bn - study

PARIS

OVERNMENTS should open a new front in the international clampdown on tax evasion with a global minimum tax on billionaires, which could raise \$250 billion annually, the EU Tax Observatory said on Monday.

If levied, the sum would be equivalent to only 2 percent of the nearly \$13 trillion in wealth owned by the 2,700 billionaires globally, the research group hosted at the Paris School of Economics said.

Currently billionaires' effective personal tax is often far less than what other taxpayers of more modest means pay because they can park wealth in shell companies sheltering them from income tax, the group said in its 2024 Global Tax Evasion Report.

"In our view, this is difficult to justify because it risks to undermine the sustainability of tax systems and the social acceptability of taxation," the observatory's director Gabriel Zuc-

man told journalists.

Billionaires' personal tax in the United States is estimated to be close to 0.5 percent and as low as zero in otherwise high-tax France, the Observatory estimated.

Growing wealth inequality in some countries is fuelling calls for the richest citizens to bear more of the tax burden as public finances struggle to cope with aging populations, huge financing needs for climate transition and legacy COVID debt.

US President Joe Biden's 2024 budget included plans for a 25 percent minimum tax on the wealthiest 0.01 percent, but that proposal has since fallen by the wayside with lawmakers in Washington preoccupied with government shutdown threats and looming funding deadlines.

Though a coordinated international push to tax billionaires could take years, the Observatory pointed to the example of governments' success in all but ending bank secrecy and reducing opportunities for multinationals to



shift profits to low-tax countries.

The 2018 launch of automatic sharing of account information has reduced the amount of wealth held in offshore tax havens by a factor of three, the observatory

A 2021 agreement between 140 countries will limit multinationals' scope to reduce tax by booking profits in low-tax countries by setting a global 15 percent floor on corporate taxation from next year.

"Something that many people thought would be impossible, now we know can actually be done," Zucman said. "The logical next step is to apply that logic to billionaires, and not only to multinational companies."

In the absence of a broad international push for a minimum tax on billionaires, Zucman said a "coalition of willing countries" could unilaterally lead the way.

Although the end of banking secrecy and the corporate minimum tax have put an end to decades-long competition between countries on tax rates, numerous opportunities remain to reduce tax bills, the report said.

For example the rich increasingly park wealth in real estate instead of offshore accounts while companies can exploit loopholes in the 15 percent corporate tax mini-

Meanwhile, governments are increasingly competing for investment through subsidies even though that is less harmful to their tax bases than competing only on low tax rates, the Observatory said.

Tanzania beats Kenya as best investor destination

NAIROBI

TANZANIA has beaten Kenya on the best investment destinations for investors eyeing the region in the next two

Fourteen percent of the respondents in a survey conducted by advisory firm KPMG on 150 C-suite level and senior executives in the region said they would consider investing in Kenya, tying the country with Ghana in fourth spot of preferred destinations of capital, behind South Africa (50 percent), Nigeria (30 percent) and Tanzania (15 percent).

Dealmakers expect to ramp up investments into sub-Saharan Africa in the next two years, with economies such as South Africa, Nigeria and Kenya that serve as regional investment hubs expected to benefit the most from this positive trend.

The survey findings show they expect the oil and gas, consumer goods, mining, fintech and industrial sectors to attract the bulk of inward investment.

The respondent group was divided equally between domestic investors (based in SSA) and international investors, comprising a 70 percent to 30 percent mix of strategic and financial investors respectively.

Analysis by KPMG shows that the SSA region reported mergers and acquisitions worth \$19.2 billion (Sh2.87 trillion) last year, from a reported 297 deals.

"Just under three-quarters of respondents (74 percent) say they are considering an acquisition or investment in SSA in the next two years, including 71 percent of in-

Climate-aware investing is crucial to financial security

THE emissions covered by decarbonisation pledges rose by 70 percent of global emissions between 2017 and 2022, according to data from the International Energy Agency.

Now investors must play their part, not only by reducing their own portfolio carbon footprints but also by holding governments, issuers and asset managers accountable to those pledges.

Each investor's journey will be different, with some at more advanced stages than others. Many are constrained by regulations, while others may choose to prioritise alternative corporate objectives. Fiduciary duties may also influence the speed at which asset owners decarbonise their investment portfolios, along with the level of beneficiary and client scrutiny, the organisational assetliability profile and available resources to implement changes, which will ultimately meet the goals of the Paris Agreement.

Decarbonisation techniques

There are two main avenues towards net zero for investors decarbonising the aggregate investment portfolio and investing in climate solutions. In the first instance, a modular approach to decarbonise portfolios offers investors four levers to influence climate outcomes (Figure 1). These tools can be applied on their own but are generally used together to optimise results.

Investing in climate solutions includes products and services for ensuring a smoother energy transition. Issuers in this category focus on two goals - wider adoption of existing ways to mitigate and adapt to climate change, and innovations required to meet net zero targets. These strategies generally focus on five broad industry groups: transportation, power, industry, buildings and consumer.

How investors choose to gauge their climate-aware investing strategy depends on their initial baselines and portfolio ambitions.

Unsurprisingly, a proliferation and volatility limits. of portfolio emissions regulations, policies, guidelines and other tools have emerged globally over the past decade to help strengthen the reliability, transparency and indicators. However, they can be difficult to decipher.

Greening portfolios

US dollar increases on high-bond yields

SINGAPORE

JAPAN'S yen weakened briefly on Monday to the 150-per-dollar level, as elevated US Treasury yields kept the dollar supported across the board but without pushing it too much higher.

Investors are waiting for several events this week, including the European Central Bank meeting, and the release of US GDP data and the Federal Reserve's preferred inflation gauge.

Besides that, the risk of Israel's war on the Islamist group Hamas becoming a wider regional conflict is keeping markets on edge, as Israeli air strikes battered Gaza early on Monday, and the United States dispatched more military assets to the region.

US Treasuries are also at the forefront of investors' minds, with 10-year yields around 4.982 percent, having briefly popped above 5 percent last week after Federal Reserve Chair Jerome Powell said

the US economy's strength and hot labour markets might warrant tighter financial conditions.

The dollar index firmed a fraction to 106.23, with the euro down 0.1 percent at \$1.0586, and sterling flat at \$1.21620.

Even though it hasn't risen lockstep with yields, the dollar has been underpinned by the steady rise in yields at the long end of the US Treasuries curve, driven by widening term premiums on expectations of stronger growth and fiscal slippage.

Since mid-July, the trade-weighted dollar index is up 6.7 percent but has been nearly steady this month.

"On paper, it should be a good week for the dollar. US GDP should come in at over 4 percent and the Fed's preferred measure of inflation should still be running hot," said Chris Turner, ING's global head of markets.

"In Europe, PMIs and the ECB bank lending survey should show an economy mired in stagnation, if not recession."

Israeli forces mass near Gaza as Netanyahu warns Hezbollah

JERUSALEM / CAIRO

ISRAEL was stepping up its attacks on the Gaza Strip ahead of an anticipated ground invasion of the Palestinian enclave, said the Israeli military on Sunday, amid escalating tensions also on the country's northern front and in the occupied West Bank.

Israel Defense Forces (IDF) Spokesman Daniel Hagari said the military was "intensifying air strikes on the Gaza Strip," adding that "dozens" of Hamas militants were killed overnight, including Muhamad Qatmash, who was identified as the deputy head of Hamas' artillery array in Gaza.

Hagari also updated the number of known hostages being held in the Gaza Strip to 212. In addition, the ongoing Israel-Gaza conflict, as it entered the 16th day, has led to more than 6,000 deaths on both sides.

The death toll of Palestinians from Israeli airstrikes on the Gaza Strip has risen to 4,651, the Hamas-run Health Ministry said on Sunday. It added that 14,245 Palestinians were wounded in the coastal enclave.

More Israeli soldiers were kitted out in full combat gear along the security fence with Gaza in preparation for a possible ground offensive against the Palestinian

Meanwhile, the Gaza-ruling Palestinian Islamic Resistance Movement (Hamas) continued its strikes on Israeli forces despite the odds of a broader war seeming perilously high.

In a press statement, Al-Qassam Brigades, the military wing of Hamas, said its fighters carried out "a tight ambush" against Israeli troops "east of Khan Younis," a southern Gazan city, on Sunday, killing at least one Israeli soldier.

In an interview with the local MTV channel on Sunday, Lebanese Foreign Minister Abdallah Bou Habib reaffirmed that Hezbollah will not intervene in the Israel-Hamas conflict unless Israel launches a large-scale invasion of Gaza or a heavy attack on Lebanon.

Meanwhile, the Israeli military said in a statement that it carried out four rounds of attacks, including two drone attacks, targeting Hezbollah posts after anti-tank missiles were fired from Lebanon toward Israel.

Indonesia presidential aspirant Prabowo picks Jokowi's son as VP

JAKARTA

INDONESIA'S defense minister and presidential candidate Prabowo Subianto on Sunday announced incumbent leader Joko Widodo's eldest



son as his running mate for next year's election.

The choice of Gibran Rakabuming Raka, 36 (pictured), could be a boost for Prabowo's campaign due to Jokowi's huge popularity, even amid outrage this week over a court decision to change an eligibility requirement that would have prevented Gibran from running.

Speaking after a meeting of his party and its coalition partners, Prabowo told a press conference there had been an agreement to nominate him as presidential candidate and Gibran Rakabuming Raka as vice-presidential candi-

The world's third-largest democracy will hold simultaneous presidential and legislative elections on Feb 14, with nearly 205 million of Indonesia's more than 270 million population eligible to vote.

Prabowo, 72, has led most opinion polls this year, including two this week, albeit by a narrow margin over the ruling party's Ganjar Pranowo, a former Central Java governor, with ex-Jakarta governor Anies Baswedan a distant

Ganjar and Anies, both 54, had signed up for the race on Thursday, the opening day of registration for presidential candidates.

Jokowi said this week he had no involvement in presidential candidates, but political insiders have said the outgoing leader is seeking to retain influence and has been covertly marshalling support for former rival Prabowo, having earlier appeared to have backed Ganjar as the candidate of his PDI-P party.

Support base

Asked about the possibility of his son's nomination earlier on Sunday, President Jokowi said he will be "leaving it to the political parties' coalition," adding that a parents' job is to pray for their children and give their blessings.

The alliance with Gibran could transfer some of Jokowi's support base to Prabowo and in turn boost the outgoing leader's chances of determining his own legacy by ensuring completion of key economic programs he initiated, some analysts say.

Gibran, the 36-year-old mayor of Surakarta city, stoked controversy following a ruling from a top court that changed the eligibility rules which paved the way for him to stand as a vice presidential candidate.

Political insiders say Gibran's nomination is a way for Jokowi, as the outgoing president is commonly known, to retain influence and say he has been covertly marshalling support for Prabowo, whom he beat twice to win the presidency in 2014 and 2019.

There was no immediate comment from the ruling Indonesian Democratic Party of Struggle (PDI-P), of which the president and Gibran are listed as members.

Prabowo said he plans to register his candidacy to the election commission on Wednesday Oct 25, which is the last day for registration.



According to him, Pimax Nanchang is thriving thanks to the local VR industry cluster and the sound collaboration among relevant enterprises.

The revenue of the company stood at 11.31 million yuan in 2022 and is expected to reach 20 million this year.

In Jiangxi province, VR and relevant technologies are now applied in a number of scenarios, boosting the development of various industries. For instance, students can "repair" a vehicle with VR controllers, and with VR equipment, R&D personnel can significantly improve their work performance and efficiency.

"Learning a skill well requires a lot of practice, and simulation training helps us make up for the lack of handson experience," said Zhou Tao, a student majoring in urban rail transit operation and management at Jiangxi Modern Polytechnic College, who joined a half-month training at the national vocational education virtual simulation demonstration training base

in Nanchang. "Through VR technology, we can familiarize ourselves with the structures of vehicle equipment components in the

classroom," he added. At present, the base provides training for 26 vocational education courses in nine major categories including equipment manufacturing, transportation, and healthcare. Upon full operation, the base

will be able to train 100,000 people each year and bring an enormous market of at least 200 million yuan. A demonstration agriculture

base in Jiangxi province has developed a metaverse online shop that allows customers to "pick" fruits and vegetables on their mobile phones.

After customers enter a virtual version of the farm on a mobile application and select the fruits and vegetables they want, robots would pick, pack and then mail them to customers.

China's green BRI illuminates a greener future for world

BEIJING

IN Uzbekistan, a nation blessed with more than 300 sun-drenched days each year, photovoltaic (PV) panels from China are transforming the abundant sunshine into a valuable resource.

"Uzbekistan boasts more than 8 million households with the potential to install rooftop solar power systems, and many government buildings have embraced PV panels," said Durbek Otajonov, a local staff member of LONGi Green Energy Technology Co Ltd, China's solar technology giant.

As Otajonov sees it, a green transition is unfolding in his homeland, facilitated by China's technological advantages and greater connectivity brought by the Belt and Road Initiative (BRI).

In August, a train loaded with PV modules left Xi'an, northwestern province of Shaanxi, for Uzbekistan's Tashkent. These modules will serve a 1-gigawatt PV project in the central Asian country, which will produce 2.4 billion kWh of clean energy annually, helping cut carbon emissions by up to 2.4 million

It was the first special train for exporting PV modules of the Chang'an China-Europe freight train service launched in 2013 when China first proposed the BRI.

For Otajonov and billions of people in BRI partner countries, a greener future is awaiting.

Endeavoring to build a green Silk Road and make green a defining feature for BRI cooperation, China is committed to promoting global green development, in alignment with its domestic efforts of prioritizing sustainable and high-quality development that protects the eco-envi-

China, with a vision of building a community with a shared future for humanity, has been vigorously promoting BRI cooperation in green infrastructure, green energy, and green transportation.

As the BRI cooperation enters into a new stage following a decade of development, China further made "promoting green development" one of the eight major steps to support high-quality BRI

During the third Belt and Road Forum for International Cooperation (BRF) concluded last week, China has pledged efforts including stepping up support for the BRI International Green Development Coalition, continuing to hold the BRI Green Innovation Conference, and establishing dialogue and exchange mechanisms for the solar industry and a network of experts on green and lowcarbon development.

UN Secretary-General Antonio Guterres commented that investments flowing from the Green Silk Road are an important opportunity to fast-track sustainable and climate-resilient development to protect lives and livelihoods.

"The Green Silk Road is an important tool that can help us all pull us out of the dead ends of the past, and set us on a new pathway that benefits people and the planet alike," the UN chief said.

In Abu Dhabi, the United Arab Emirates (UAE), a UAE-China cooperative solar power plant project is expected

to help Abu Dhabi slash its annual carbon dioxide emissions by 2.4 million tonnes.

In Kenya, the China-financed Garissa Solar power plant, the largest solar plant in East Africa, puts the country on the path to achieving green energy suf-

"Renewables are expected to make up half of all power generation by 2050 with China leading the way," reads an article published on the website of the Brookings Institution. It goes on to say that China's clean energy investments through BRI look poised to utterly transform the global clean energy industry.

In September, Chinese new energy vehicle (NEV) manufacturers and suppliers made a strong presence at the bustling showrooms of this year's International Motor Show in Munich, Germany, washing the world with a new wave of technological innovations in green transportation.

Green products, such as NEVs, have gradually replaced traditional cargos of machinery as the main exports carried by the Chang'an China-Europe freight train service, said Yuan Xiaojun from Xi'an Free Trade Port Construction and Operation Co Ltd.

Official data showed that, in 2022, China's NEV exports increased 1.2 times year on year to 679,000 units. In the first eight months of this year, the country exported 727,000 NEVs, an increase of 110 percent from a year ago.

As noted by Zhu Yaming, a consultant with Ernst & Young China, the evolving trend in China's NEV export model is shifting away from exporting complete vehicles and components. It now encompasses the entire industry chain, including research and development, production, supply, and sales.

An official with the Palestinian Red Crescent Society in Gaza confirmed to CNN that these trucks have been admitted and are currently being offloaded to proceed to the Gaza storage facilities of UNRWA, the United Nations agency for Palestinian refu-

Earlier on Saturday, US Secretary of State Antony Blinken emphasised on Friday that facilitating the movement of aid into Gaza was among his top priorities over the past week. He noted that they worked diligently with the governments of Israel and Egypt.

Operation Ajay: Sixth flight with 143 passengers, including two Nepalese citizens, arrives in New Delhi

AS Israel's retaliatory strikes on Hamas in Gaza, following the terror attacks of October 7, entered its 15th day, a sixth flight carrying 143 Indian citizens arrived in New Delhi under 'Operation Ajay' on Sunday

The evacuees, who returned by the Indian aircraft, included two Nepalese citi-

Sharing an update from his official handle on X, the spokesperson for the Ministry of External Affairs (MEA), Arindam Bagchi, posted, "6th #OperationAjay flight lands in New Delhi. 143 passengers, including 2 Nepalese citizens arrived onboard the flight. Welcomed by MoS @SteelMinIndia & @MoRD_GoI @fskulaste at the airport."

The passengers were received by the Ministry of Steel, the Ministry of Rural Development, and Faggan Singh Kulaste at the New Delhi airport.

The sixth flight carrying Indian nationals departed from Tel Aviv for Delhi on Sunday evening.

'Operation Ajay' is an ongoing Indian operation to evacuate citizens caught up in Israel amid the raging conflict with the terrorist organisation Hamas.

Earlier, the fifth flight carrying 286 Indian nationals, including 18 Nepalese citizens, arrived in New Delhi on Tuesday late

So far, about 1,200 passengers, including 18 Nepalese citizens, have been flown back

safely from Israel under 'Operation Ajay' and more flights could be sent as per the requirements, the Ministry of External Affairs informed earlier.

MEA spokesperson Arindam Bagchi said

the central government was assessing the

situation in Israel amid the ongoing war with Hamas. He refuted any reports of Indian casu-

alties in Gaza, adding, however, that one Indian national was injured in the attacks.

"I thankfully have not received any reports of any casualty...one Indian national had been injured and is receiving medical care, and I understand her condition is now stable," he said.

The MEA spokesperson stated further that around four Indian nationals are in Gaza while another 12-13 are in West Bank.

"There are around four Indian nationals in Gaza...we don't have exact numbers and are coordinating. There are 12-13 Indian nationals in the West Bank...It's a little tough to get out from Gaza. There are some reports that some have already got out of there, but we will wait for confirmation," he said.

The Indian nationals applauded the ongoing operation to repatriate citizens caught up in the conflict, saying there was support from the Indian embassy and the evacuation process was "nice and quick".

Following the Hamas attacks on Israel, the Indian embassy issued an advisory requesting citizens to be cautious and register their names with the consulate. ANI

Fabrice Ngoma and utility player needs at Simba SC

IN the wake of an exquisite performance at the Benjamin Mkapa Stadium in Dar es Salaam, nicknamed 'Estadio Lupaso', where the African Football League (AFL) opener saw city giants Simba SC put up equal play with legendary continental champions, Al Ahly of Cairo, an extensive revisiting of the match has been taking place in city airwaves.

One feature emerging was the key role of ace midfielder Fabrice Ngoma, who starred in the proverbial defensive midfield role, where pundits generally agreed it either makes or unmakes match

The trouble is that it is hard to remember who guessed he could do that.

There was, for instance, a contest of playing lists at one or two talk shows the day before the match as to who would make the local side lineup, and to the extent that memory helps, the key midfield role was being given to Mzamiru Yassin, rather than the Congolese all-

Yet he not only held the position of defensive midfielder but was frequently visible as an overlapping fullback, diminishing chances of a rally from deep midfield to exploit backline openings.

It was also a failure of analysis in the sense that hardly anyone could secondguess the coach.

At the same time, it was an illustration of the difference between the local city giants, where the Jangwani Street-based Yanga has a remarkably narrow choice of key players, despite that the scoring can be done from any forward line position.

There was a time that a limited rotation gesture was conducted and Yanga lost to their low-lying nemesis, Ihefu SC of Mbeya, and the Jangwani Street club's fans were furious at the rotation as explaining the three points surrender.

Msimbazi Street-based club's technical bench officials have a lot more to choose from, for instance, between Sadio Kanoute and Louis Miquissone.

That sort of squad depth is helpful for the coach, as even then many were uncomfortable with the lack of fielding Moses Phiri, often sealing encounters.

The game reinforced the confidence that the fan base has in head coach Roberto Oliveira, alias Robertinho, although some critics claimed that their views had been vindicated by the fact that at a late stage, the coach put Shomari Kapombe for Israel Mwenda.

As the coach doesn't have to explain why a player is benched, diversity of sentiments or hasty conclusions is unavoidable, as a player can be brought in for particular skills at a certain position.

It is this aspect that an avid pundit would say ought to have been expected, though it is in rare cases as recently with veteran captain, John Bocco, that there was a tactical substitution and it appeared to have paid dividends.

For the most part, substitutions are made to inject vigour into the play as no player fails to lose some of the touch or deftness after 70 minutes, the usual ideal time to make changes

It similarly appears that each encounter has its rules, which arise from the psychological interplay of the two teams, defensive and offensive skills, or player morale, and how that fits into a particular situation.

In that case at a recent league encounter it came out that Bocco was the answer, while this time around, with Al Ahly, it was undeniably Kanoute who made a noticeable difference.

In another context, there is a way lessons repeat themselves when scarcely anyone is paying attention or waiting for such a turn of events.

While for a spate of two or three months of the season, the scoring hopes were being laid upon Jean Baleke, Moses Phiri, and more recently Clatous Chama, when it came to big-time soccer it was last season's club top goal scorer Saidi Ntibazonkiza who rose to notoriety, in the company of Sadio Kanoute.

It is also a matter of tactical flexibility, of the extent to

which a player can adapt to different competition or perhaps ball control skills, etc.

There is still a test in Cairo within hours from the last whistle of the fanfare-laden opener, as only two days of rest were available and travel on the third day, or a day of rest and travel the following day for light exercise and match the following day.

Even then, coach Robertinho demonstrated the tactical ability to handle highlevel pressure, reinforcing an impression that has often radiated from the performance of his side in the past few years.

It plays in line with the challenge it faces, such that one does not have the same Simba SC side in the local league and international encounters, an issue noticeable even at professional premier league sides abroad.

The performance by the local AFL participants left their next street rivals largely speechless as it wasn't possible to show the sort of faults they could, in turn, have corrected, had they been in the game.

This profound respect for the game put up by the archrivals mirrored their disquiet in the prelude to the game, where their more adoring or stubborn fans were inaudible, silenced, or something.

Teen Guiu 'won't sleep' after snatching Barca win over Athletic

BARCELONA

TEENAGE debutant Marc Guiu said he will not be able to sleep after snatching champions Barcelona a 1-0 win over Athletic Bilbao just seconds after coming on from the bench on Sunday in La Liga, taking the Catalans up to third.

Xavi Hernandez's Barca will face leaders Real Madrid next Saturday in the Clasico just one point behind their bitter rivals, and second-placed Girona, who beat Almeria 5-2 earlier on.

For a long time it seemed like Barcelona would not find the breakthrough against their Basque visitors but striker Guiu, 17, netted under a minute after being thrown on by Xavi.

The forward was slipped in by the silky Joao Felix and slotted past Unai Simon, who got a hand to his shot but could not keep it out.

"Tonight I won't sleep," Guiu told DAZN. "I can't believe it, I can barely breathe, I'm enjoying the moment."

Guiu became the latest on a conveyor belt of youths to make their debuts for Barca as their La Masia academy continues to

produce gems. "It surprises me that they aren't scared, I see them with a spark, they look at me with a face saying 'Put me on, you'll see that it will go well'," said Xavi. "I saw that with Gavi, Balde, Lamine, Fermin, and with Marc, he doesn't look afraid.'

Xavi started Inigo Martinez at the back against his former club and 20-year-old Fermin Lopez on the left of the attack, another academy product, with Barcelona down to the bare bones.

Champions League resumes Tuesday at Manchester United in mourning for soccer great Bobby Charlton

THE Champions League resumes today at Manchester United where one of the competition's most storied clubs is mourning its all-time great Bobby Charlton.

Charlton, who died Saturday aged 86, survived the fatal air crash at Munich in February 1958 that devastated the then-champion of England on its journey home from a European Cup game.

He lifted the trophy 10 years later as captain of a team rebuilt by manager Matt Busby who had been seriously injured at Munich, where eight players died.

Charlton was a beloved director on the Man United board when it was European champion again in 1999 and 2008 under another Scottish manager, Alex Ferguson, who he had helped bring to the club.

The main stand is named for Charlton at Old Trafford where Man United will host Copenhagen on Tuesday and pay tribute to a man who helped define its illustrious history

Charlton "was a hero to millions," the club said in a statement. "Not just in Manchester, or the United Kingdom, but wherever football is played around the world."

Manchester United was the first English team to play in the European Cup, and Charlton first played in the competition in that 1956-57 season. He scored against Real Madrid though a 2-2 draw in the semifinals, second leg in Manchester meant the defending champions advanced.

The "Busby Babes" had just qualified for another semifinal the next season, eliminating Red Star Belgrade, when the team airplane stopped at Munich to refuel. The plane overshot the runway and caught fire on its third attempt to take off in heavy snow.

Charlton was thrown clear of the

wreckage and suffered only minor injuries in an accident that eventually took the lives of 23 of the 44 people on board.

Restoring Manchester United to greatness was a quest for Busby and Charlton, who scored twice in the 4-1 extra-time win over Benfica in the 1968 European Cup final at Wembley Stadium. England's national stadium in London stages the next Champions League final on

EARLY EXIT?

Manchester United started this Champions League campaign in Munich and it has not been a happy return after playing last season in the second-tier Europa League.

Back-to-back defeats - 4-3 at Bayern Munich and twice wasting leads in a 3-2 loss at home to Galatasaray - have left United last in Group A and added pressure on manager Erik ten Hag.

Home and away games against Copenhagen in a 16-day spell ahead of the next break for nationalteam games are likely to be key to United's chances of advancing.

One bright spot for Ten Hag is three goals in the group by 20-year-old forward Rasmus Højlund, who Copenhagen sold 21 months ago for a little over \$2 million to Sturm Graz. His value had increased 40-fold when Manchester United agreed an \$80 million transfer fee with Atalanta in Au-

Arsenal also lost three weeks ago, 2-1 at Lens and now has backto-back games against Sevilla, starting Tuesday in Spain. The Europa League title holder fired its coach José Luis Mendilibar after a slow start to the season including draws in its first two Group B games.

NEWCASTLE SOARS

Newcastle also had a slow start to the season but has surged to an eight-game unbeaten run - including a 4-1 beating of Paris Saint-Germain - ahead of hosting Borussia Dortmund on Wednesday.

In its first Champions League campaign for 20 years, Newcastle is top of the blockbuster group that

also includes seven-time champion AC Milan, which plays at PSG on Wednesday.

Defending champion Manchester City is cruising to the knockout rounds with two wins before going to Swiss champion Young Boys on Wednesday.

BAYERN ROLLS ON

If the Champions League group phase often seems predictable, Bayern Munich is one reason.

The German champion hasn't lost a group game since 2017 and hasn't dropped a point since 2020, though needed an 83rd-minute winning goal at Copenhagen three weeks ago. Next up Tuesday in Istanbul is Galatasaray.

In Germany this week, Leipzig hosts Red Star Belgrade on Wednesday after losing 3-1 to Man City.

Union Berlin's debut Champions League campaign has been a story of heartbreak, losing to both Real Madrid and Braga on goals scored deep into added time. Union next hosts Napoli on Tuesday, when Madrid is at Braga.

POINTLESS SO FAR

Benfica is along with Manchester United perhaps the biggest surprise among teams with no points after two games.

A quarterfinalist last season, and top-seeded in the group-stage draw, Benfica lost at home to Salzburg before a 1-0 defeat at Inter Milan. The Portuguese champion now hosts Real Sociedad.

Celtic aims to get off the mark at home to Group E leader Atletico Madrid. Royal Antwerp hosts Porto at its 100-year-old Bosuil Stadium where a two-goal lead was given up in a 3-2 loss to Shakhtar Donetsk.

Sir Bobby Charlton: England's greatest ever player and the artist of 1966

TWO elderly men were suited. In one case, he was much smarter than normal, dressed up for the occasion. He was the taller, more angular, with the more pronounced Northumbrian accent, but the resemblance was nonetheless apparent. He was the older, too, and had long referred to a knight of the realm as "Our Kid". He adopted a slightly more formal approach, while seemingly choking up. "Bobby Charlton is the greatest player I've ever seen," he said. "He's me brother."

It was 15 years ago, when Jack Charlton presented his younger brother with the Lifetime Achievement Award at the BBC Sports Personality of the Year award. The clip has an added poignancy after Bobby's death at 86; three years ago, a couple of months after his 85th birthday, Jack had died.

The brothers were different players and very different characters the wisecracking, outspoken Jack was more of a man of the people, but Bobby's quiet dignity gave him a statesmanlike air.

They were not always close but their achievements will live on. There have been 22 men's football World Cups and only two sets of brothers have won the most prestigious of prizes: Fritz and Ottmar Walter for West Germany in 1954, Bobby and Jack Charlton at West Germany's expense in 1966.

It remains the most famous year in English football history; perhaps it always will. At the heart of it was Bobby Charlton: the 1966 FWA Footballer of the Year and Ballon d'Or winner, named by France Football - in the days before Fifa had an official award - as the best player at the World Cup. Gary Lineker, who was a goal away from equalling Charlton's long-standing national record of 49 for his country, called him England's greatest ever player, Gary Neville, one of his successors as Manchester United captain, deemed him the greatest ever English player.

They are not necessarily the same: but in Charlton's case, he could be both. Perhaps only the

other immortal Bobby - Moore, the 1966 captain - can challenge him for the title of the finest in an England shirt.

Charlton was the second English footballer, and just the third man, to reach 100 caps. His 106th and last, in the 1970 quarter-final against West Germany, set a world record that Moore - and then many others - subsequently passed. He straddled eras - his first cap came alongside Tom Finney, who debuted in England's first match after the Second World War, and one of the last alongside Emlyn Hughes, who represented his country in the 1980s - but defined one, a time of glory. Thirty years before Frank Skinner and David Baddiel sang about football coming home, Charlton brought it back. Their lyric - "Bobby belting the ball" - conjured images, some in colour, some in black and white, of a figure with a combover hairstyle and the cannonball shot striking the ball with beautiful ferocity, often rising throughout its way into the net.

Decades before the invention of expected goals, Charlton was scoring unexpected ones. Consider his opener against Mexico, England's first of the 1966 World Cup, from such a distance that the chance of it going in was statistically low, except for one factor: that Charlton, with such power on either foot, was hitting it. He was the master of the long-range hit: if most of Lineker's 48 goals were predatory finishes, many of Charlton's 49 were spectacular.

Such a clean striker of a ball was not a striker at all: largely a left winger in his younger days, later the attacking-midfield fulcrum of Sir Alf Ramsey's 'Wingless Wonders'. He began in the old W-M formation, ended up as, in effect, the tip of a midfield diamond. It was a tactical shift, a belated move into modernity that Ramsey brought.

If there was a pragmatism to England's World Cup win, Charlton was the artist. With his brace against Portugal in the 1966 semi-final - like another double against Portuguese opposition, Benfica, in the 1968 European Cup final - he illustrated his talent could shine on the biggest of occasions.

The 1966 semi-final was not seen by his father, Robert, a coal miner working a shift underground in his home town of Ashington; "his duty", Bobby

subsequently, and remarkably, reflected. On the grandest stage of all, the 1966 final, he was sacrificed, Charlton and Franz Beckenbauer deputed to man-mark each other.

They received the same assignment in the 1970 quarter-final; England's era of ascendency ended when Ramsey removed Charlton with 20 minutes remaining to save him for the semi-final, the 32-year-old distracted by the prospect of his withdrawal as Beckenbauer ran forward to reduce England's lead to 2-1; without him, they lost 3-2.

Ramsey thanked him for his service on the plane back from Mexico: Bobby knew his England career, like Jack's, was over.

It could have been still more glorious: keep Charlton on and maybe England would have prevailed in

But for Garrincha's brilliance, Charlton wondered if England would have been victorious in the 1962 quarter-final against Brazil, and then the tournament as a whole. He went to four World Cups in all, not taking the field in his first: time has rendered it more extraordinary that his England debut came in 1958, a couple of months after the Munich air disaster.

He scored, too, but if a poorer performance on his third cap was understandable - it came in Belgrade, scene of the Busby Babes' last game before Munich - it cost him his place in Walter Winterbottom's starting 11 in Sweden. Were Duncan Edwards, Roger Byrne, Tommy Taylor and Eddie Colman to have lived, perhaps England would have won more and

But it was Charlton who became the emblem of English football; the face of what is now a bygone age. In its own way, it felt appropriate that a man who carried a huge responsibility for decades was the last survivor among the players at Munich; now it may be fitting that Geoff Hurst, who had the final say in 1966, is the last of Ramsey's chosen 11, forever charged with paying tributes to his fallen comrades. And Bobby Charlton, the greatest player Jack ever saw, the greatest to have Three Lions on his shirt, took England to the summit of the global game.

Can Petro overturn Sundowns' deficit in AFL last-eight rematch in Pretoria?

PETRO de Luanda faces a massive task when they travel away to Pretoria to take on Mamelodi Sundowns in the return fixture of the African Football League (AFL) quarterfinal today.

Petro has a 2-0 deficit from the first leg played in Luanda and has to win the game by a margin of more than three goals to make it to the semi-finals.

The Brazilian came off the bench in the first leg. and with goals surely needed in Pretoria, Santos will call on his most experienced forward.

Meanwhile, the Sundowns approach the match with less pressure. Any draw or loss of less than three goals will be enough for them to make the semi-finals.

However, coach Rulani Mokwena says the tie is far from over, and pointed out they will approach the return leg with a 0-0 mentality.

The tactician gave an example of his side's defeat against TS Galaxy in the Carling Black Label Cup in South Africa, where they came from 2-0 down to tie the game 2-2 but lost on penalties.

He has challenged his players to ensure their concentration levels are high throughout the match.

The last visit by Petro to Sundowns was in April

Simba SC faces date with destiny in Cairo

Simba SC's head coach Roberto 'Robertinho' Oliveira has acknowledged that they face a massive task against the African football giants but remains optimistic and confident they can get the desired results.

The Brazilian gaffer noted: "It's an im-

portant match for us. We must be well prepared for it and showcase our abilities and potential. We will allow all players to participate."

"We have a lot of respect for Al Ahly and we are sure Al Ahly will reciprocate the same respect, especially since we displayed an excellent performance in the first match on our home ground," he said.

The same sentiments are shared by attacking midfielder Willy Onana, who said they cannot be scared of the expected huge turnout.

The Cameroonian winger has called on his teammates to bring their A game on against Al Ahly, and he reckons they can get a good result playing away from home.

"The presence of the crowd tomorrow is something we are accustomed to, it is not new to us. We have come here fully aware that there will be significant fan presence and, as the coach mentioned, we will give our best and strive to return with a victory," Onana told the Cairo press ahead of the game.

Another **NBC Premier** League coach bites the dust

JUST six games into the 2023/24 NBC Premier League season, a third head coach has parted ways with his club.

The latest coaching casualty is erstwhile Namungo FC head coach Cedric Kaze who officially threw the towel on Sunday after a largely disappointing start to the season.

Kaze had been in charge of the Ruangwa-based side since July. The Burundian coach joined Namungo FC after a two-year successful spell as Young Africans SC assistant coach.

He stepped down from his role at the Jangwani Street squad following the exit of head coach, Nasreddine Nabi.

He took over the Namungo FC job from Dennis Kitambi but has endured a poor start to the 2023/24 season.

Another uninspiring display in Saturday's 3-1 home defeat against Singida Fountain Gate FC was the last straw for the former Young Africans coach as Namungo FC slipped into the relegation

The 'Southern Killers' have only three points from six games this season, just one point above bottom-placed Mtibwa Sugar.

They remain one of the three sides that are yet to taste victory this season. Namungo FC spent on a couple

of new signings in the last transfer window as Kaze's wishes for reinforcements were acceded to. However, the Burundian coach

was unable to transform his side's fortunes and his three-month tenure is now over.

"I have decided as of today to resign as Namungo FC head coach. I would like to take this opportunity to thank the management, my colleagues of the technical staff, and the players for their support, and commitment," Kaze wrote a brief statement on his official Instagram account.

"I would finish by thanking the fans who have always been supportive. I wish the team the best of luck in the future," the gaffer noted.

Kaze follows Zubeir Katwila. who parted ways with Ihefu SC despite a decent start, and Habib Kondo who was sacked by Mtibwa Sugar as coach to have been axed this campaign.

Katwila has since moved to rejoin Mtibwa Sugar, a squad he left in 2020 to cross over to Ihefu SC.

Ihefu SC has since replaced Katwila with the appointment of Ugandan coach Moses Basena who has previously had a spell with Simba SC.

Namungo FC hierarchy is already in the market for a new coach the officials hope will change their outfit's poor fortunes.

Congolese Mwinyi Zahera's job as Coastal Union head coach is under increasing pressure and he could soon join the list of casualties.

The Coastal Union's hierarchy is concerned about the squad being dragged into a relegation battle having failed to win any of six opening games so far.
