

## **MPs: Competitive sectors merit heavier investments**

ELIBERATE initiatives are needed to heavily invest in areas where Tanzania has competitive advantage, in sectors like agriculture, tourism, livestock and mining, a parliamentary committee has urged/

Daniel Sillo, chairman of the standing committee on the Budget in the National Assembly, said that the strategy would increase investments and achieve intended development goals.

Presenting views of the committee on the state of the nation's economy and national development plan plus the budget estimates for fiscal 2023/24 he said the committee wants the government to prioritize engineering procurement, construction and financing mode of contract along with publicprivate partnerships in major projects.

These methods have been effective in various parts of the world, he declared, affirming that allowing private investors to take the lead in major construction projects has in-built advantages.

Investors take the bulk of the risks, enabling the projects to be implement-

### 'Adding 80/to imported petroleum oils a burden'

THE proposal to introduce excise duty of 80/- per litre on petroleum oils needs to be reconsidered by the government, an expert has declared. Beatrice Melkiory, an associate partner at Ernst and Young Tax Advisory Services, said at a discussion event organized by the tax consultants and the Economic and Social Research Foundation (ESRF) that current prices are already high before a new tax measure is added.

Adding other costs will be a burden to businesses and final consumers, she said, while underlining that there was in the budget measures more action to protect local manufacturing industries and discourage importation.

This could be attested to the government's move to reduce tax rates on various locally manufactured goods and inputs, while raising tax rates on imports, she said.

### **'Don't lose focus on major issues in Dar port project'**

LEADING voices in the private sector have appealed for a business approach to the port operation arrangement rather than extraneous issues which belittle the matter being discussed

Angelina Ngalula, chairperson of the Tanzania Private Sector Foundation (TPSF), said at a high level roundtable discussion in Dar es Salaam yesterday that it was high time the government allowed the private sector to run the economy of the country.

Noting that the country's geographical location was capital

which needed to be capitalized upon, she said the port of Dar es Salaam was operating in a way which needs much investment in new technologies for cargo handling and storage.

Rostam Aziz, a former head of department in the CCM Secretariat and noted businessman,

said he was concerned with the nature of discussion on the port arrangement, pointing out that the debate has descended to religion and tribalism which was dangerous for the country.

"We are at the centre of a serious debate involving the country's economic welfare, but there are emerging voices which are divisive," he stated, cautioning that this is not the right way to discuss the issue.

Prof Kitila Mkumbo (Ubungo MP) said the company invited to take up port operations would among other things operate the dry port at Kwala, develop a new container berth, develop ICT systems to provide training to TPA employees to run the port efficiently and in a modern way. It is not operating the entire port as is being propagated, he said, affirming that if the

The good intention of the government in promoting investment will be jeopardized if it fails to reconsiders some of its proposals seen to be unhealthy for the manufacturing industry, she said. She commended the government's plan to emphasize on productive sector investments, saying it will fuel the growth of the country's economy. Finance and Planning minister Dr Mwigulu Nchemba, tabling the national budget for fiscal 2023/2024 last week, proposed the introduction of an excise duty rate of 20 percent on beer.

### Samia to grace World Drug Day on June 26

PRESIDENT Samia Suluhu Hassan is expected to grace this year's International Day Against Drug Abuse and Illicit Trafficking, or World Drug Day, on June 26. Arestas Lyimo, commissioner general for the Drug Control and Enforcement Authority (DCEA) told journalists at a press conference yesterday that the day is marked each year to strengthen action and global cooperation in achieving a world free of drug abuse.

The event to be held at the national level in Arusha will see the start of this year's campaign to raise awareness about the importance of treating people who use drugs.

The campaign will focus on the need for respect and empathy along with providing evidence-based, voluntary services for all plus offering alternatives to punishment. Prioritizing prevention and leading with compassion in assisting those falling victims of drug abuse is vital, he said. The campaign also aims to combat stigma and discrimination against people who use drugs by promoting language and attitudes that are respectful and non-judgmental, the commissioner stated. Meanwhile, nearly one thousand bags of marijuana along with 3,878 pellets of heroin methamphetamine

(531.5grams), 3,878 pellets of heroin. 138 pellets of cocaine along with 200.5 grams of heroin were seized by drug enforcers in the past three months. Drugs seized include 978 bags of marijuana, netted from March to June this year in a special operation conducted in various regions, leading to the arrest of 109 suspects including three foreigners.

Other seized drugs included 3,840 milliliters of pethidine,

while enforcers managed to destroy 1,093 acres of marijuana farms, working with investigators from the International Narcotics Control Board (INCB). The operation was conducted from March 25 to June 19, with some of the suspects set to be arraigned when legal processes are finalised, he said. In that operation, the agency

"Since Tanzania has succeeded in securing markets for food products in various countries in Africa and since the price of food products, especially grain in the global market is rising due to huge demand, the committee advises the government to encourage the production of food and commercial crops," he stated.

The government also needs to increase the value of grain purchased in the country, as analysis shows that out of 9.49m tonnes of grain produced in the country, only 13,062 tonnes are processed, he said.

From 2018 to 2022, the Tanzania Mercantile Exchange (TMX) conducted sales of crop produce totaling 107.06m tonnes worth 223.26bn/-, he said, noting that it was still a limited supply of commodities.

The list of crops for sale in TMX needs to be increased as well as the number of buyers participating in the market, to increase farm productivity and foreign exchange earnings, he said. The committee suggested building new warehouses and renovating existing warehouses, increasing availability of cold room facilities for storing fish, vegetables, fruits and flowers for export, he said. During the current financial year vegetables and flowers sales value attained \$289.6m, declining from \$378.6m recorded in 2021/22, a 23.5 percent slide, he said The government needs to accelerate processes to revive flower, vegetable and fruit farms in Arumeru District in Arusha Region, he said, insisting that the recovery of these farms will boost foreign income and restore more than 2000 lost jobs. The government needs to apply the public-private partnership approach in the development of irrigation schemes to help increase crop farming and processing in competitive sectors abroad, to increase

foreign currency earnings, he said, Currently, irrigation schemes under the Irrigation Commission depend on the government's budget, so attracting the PPP mode in improving irrigation infrastructure will facilitate stable farming throughout the year, increasing yields and income, he further noted.

Debating the estimates, some MPs urged the government to ensure that it puts in place deliberate measures to facilitate implementation of goals highlighted in the development plan.

Dr Medard Kalemani (Chato) urged the government to increase investments in the mining sector with more mineral selling centres, processing plants and buying minerals from artisan miners.

contract will be productive then there is need to increase the area of operations

He described the debate in Parliament in Dodoma as having been misdirected by opponents making arguments that CCM is selling the port. "That issue is now starting to be understood that there is no issue of selling the port, as not only the port but no part of the country can be sold," he emphasised

He said it was normal for countries to enter into agreements, noting that a negotiated

parliamentary agreement was an agreement and not a compromise on the issue.

MPs were seeking to be clear about the issue for the future of the country, he told the panel, elaborating that the agreement was about development and improvement and not the sale of the port, something that is not true.

He explained that the port arrangement is being discussed in specific areas namely for handling car imports, mixed cargo, containers, barge (auxiliary ships) and passenger platforms.

He said the president and the security agencies would not allow the country to enter into port negotiations where the security agencies will not be there to o check the security of the country in its operations.

A cross-section of participants focused on better ways to operate the Dar es Salaam Port in collaboration with the Dubaibased port management firm, DP World.

Zitto Kabwe, the ACT-Wazalendo party leader, underscored the need to form a port operating company to form a joint

venture set up with DP World in operating Dar es Salaam port, to facilitate involvement of local investors in that arrangement.

A joint venture arrangement will enable local firms to gain the capacity to run the port and eventually take over the whole company.

Long-serving journalist Jenerali Ulimwengu said privatization of public entities commonly lacks transparency in contracts and agreements involving long term investments.

Appealing for transparency in the whole process he pointed at

the need for more public awareness on what exactly is going to happen with the port agreement with DP World (Tanzania).

Fr. Dr Charles Kitima, the secretary general of the Tanzania Episcopal Centre (TEC) said that there is need to take up local investors in the expanding the country's ports.

"We have invested more than 1trn/- in port development, therefore why can't we begin from there to operate before we engage foreign investors," he queried.

Charles Mwijage (Muleba North) suggested that the government strengthens participation of the private sector in productive sectors to boost development.

"Fighting bureaucracy in public institutions serving investors should be a major priority to attract more investors, local and foreign," he said.

Sophia Mwakagenda (Special Seats-Opposition) wanted the government to come up with improved systems to fight dishonest agents leaving farmers in great sorrow and loss with unfair processes of purchasing crops at low prices.

"The lives of the majority of our farmers are dire," she stated, noting that they spend a lot in farming but what they get after harvesting is disturbing.

Agents are in the middle between farmers and wholesalers, so the government needs to take action and ban these agents," she insisted.

Yahya Massare (Manyoni West) wanted the government to repeal its plan of reducing tax for imported unprocessed edible oil as this is going to affect local sunflower oil producers.

### 30m people in 5 African countries may need food aid this year - report

THE escalating hunger crisis in African countries needs urgent intervention as up to 30 million people in five countries in the continent are projected to require humanitarian food assistance this year, according to a report.

The Intergovernmental Authority on Development (IGAD) is a regional economic community and comprises eight member states: Djibouti, Eritrea, Ethiopia, Kenya, Somalia, South Sudan, Sudan and Uganda.

The IGAD Climate Prediction

and Applications Centre (ICPAC) released the IGAD Regional Focus of the Global Report on Food Crises (GRFC) 2023 on June 14, 2023 in Nairobi.

The population facing acute food insecurity in the IGAD Member States has rapidly increased since 2020, by more than 10 million additional people each year, the report found. The projections are available for five of the eight IGAD countries: Kenya, Somalia, South Sudan, Sudan and Uganda.

The report used the Integrated Food Security Phase Classification (IPC) scale for acute food insecurity. The five-phase scale

provides common standards for classifying the severity of acute food insecurity and global hunger. According to the report, in 2022, an alarming 55.45 million people across Djibouti, Ethiopia, Kenya, Somalia, South Sudan, Sudan and Uganda needed urgent food assistance (IPC Phase 3 or 'crisis'). Unfortunately, no data was available for Eritrea.

Over 301,000 people in Somalia and South Sudan are struggling with IPC Phase 5, also called 'catastrophe'. Over 8.7 million people are in 'emergency' phase (IPC Phase 4), the report said.

Ethiopia, Kenya, Somalia, South

Sudan and Sudan all had the largest populations facing high levels of acute food insecurity in the seven-year history of the Global Report on Food Crises (GRFC).

The compounding effects of multiple shocks, including drought, macro-economic challenges and conflict, drove rising levels of acute food insecurity across the IGAD region.

Weather extremes were considered the primary driver of acute food insecurity in Ethiopia, Kenya, Somalia and Uganda, where a total of 35.85 million people faced high levels of acute food insecurity.

found out that drug dealers are innovating in their methods, by starting relationships with Tanzanian women and use them to distribute drugs. They later deny those affinities when enforcers catch up with them, he stated, urging local women befriending foreigners to take precautions, similarly cautioning those who receive luggage to carry without knowing the contents.

Drug enforcement legislation stipulates that it is illegal to transport or be found in possession of drugs, stipulating 30 years imprisonment for such breach, he said.

DCEA intends to raise public awareness, linking up with the Prevention and Combating of Corruption Bureau (PCCB) to use its clubs in anti-narcotics sensitization campaigns, he emphasized.

### Oil tanker-passenger bus collision leaves one dead and eight injured

YOHANA Mwamlima (40), resident of Temeke in Dar es Salaam died and eight others injuried in road accident that involved an oil tanker and a passenger bus along the Dar es Salaam - Morogoro highway.

Acting Commander of Fire Brigade and Rescue Services, Emmanuel Ocheng said the accident happened at 11:00 pm on Sunday at Kingolwira in Morogoro municipality involving oil tanker Reg. T690DSV travelling from Dar es Salaam to Morogoro driven by Nkandi Konokwa a resident of Nzega which collided with a passenger bus Reg T728EBT travelling from Musoma to Dar es Salaam driven by Ahmed Salum (32) a resident of Mwanza.

For his part, the coordinator of cure and research at Morogoro regional referral hospital, Dr Abdallah Issa they received the body of the deceased and eight injured persons at 2:00 AM yesterday including two men and three women.

Dr Issa, who is also acting doctor in charge at the hospital said the condition of one of those injured was critical and doctors were continuing with treatment.

Vaileth Joseph, one of the injured persons admitted at the hospital said she was in the bus travelling from Musoma to Dar es Salaam and felt that the bus was travelling too fast and decided to fasten her seat belt and slept, and was awake when the accident had already happened, and sustained injuries.

Commander Alex Mkama confirmed about the accident and were holding the driver of the oil tanker, Nkandi Konokwa. RPC Mkama said five out of eight of those injured were treated at the hospital and discharged while three others were still in hospital receiving treatment.

He named the those injured as Onesmo Malegesi (35) resident of Lindi, Anastazia Manyerere (19) resident of Musoma and John Ngewe (25) resident of Kibaha.

Mkama said the cause of the accident was the driver of the oil tanker Konokwa whose vehicle veered off the road without taking necessary precaution.



DEPUTY Health minister, Dr Godwin Mollel has instructed regional and district medical officers to make sure specialist doctors at the national and zonal hospitals not to wait to be approached by patients, they should instead follow them where they are for treatment.

Opening the two-day camp for specialist doctors from the United States established at Pohama village, Ngimu Ward, Singida District and after witnessing an influx of people seeking treatment which necessitated for the exercise to run for three more days, Dr Mollel said in order to identify diseases affecting the people, the time has now come for doctors to do away with the concept of waiting for patients to approach them.

"But now we want our regional hospitals to adopt this practice which is a presidential directive and the Health Minister Ummy Mwalimu had also given similar instructions," he said.

According to the deputy minister, if the specialist doctors will follow patients at small hospitals, there is a big chance for many Tanzanians to be found with diseases affecting them before they become serious.

For her part, Singida regional medical officer, Dr Victorina Ludovick said Singida Region has a total of 259 health centres in all its seven districts.

However, she said the health services delivery in the region continues to be strengthened including the availability of drugs now standing at 92.5 per cent.

Singida District medical officer, Dr Grace Charles named health services provided in the period January to June this year as including maternal services whereby a total of 34,062 pregnant mothers were provided with various health services.

The creator of Siouxland Tanzania Educational Ministries Medical (STEMM), former Singida North MP Lazaro Nyalandu said that since its establishment in the entire country, it has sponsored 15,000 secondary and university students.

TANZANIA Railways Corporation (TRC) has finalised feasibility study and pre-quantity survey for the construction of 1,000km Mtwara-Mamba-Bay Standard Gauge Railway (SGR).

This was disclosed here yesterday in Parliament by Atupele Mwakibete, Deputy minister for Works and Transport when responding to a question from Masasi MP, Geoffrey Mwambe (CCM).

In his question, the legislator asked when will the government start building the 1,000km SGR from Mtwara to Mbamba Bay-Songea-Ludewa.

Responding to the question, Mwakibete said the report on the feasibility study and pre-quantity survey shows that the project can also be implemented through public-private-partnership (PPP).

He said the step so far reached is to hire a transactional adviser to go through the feasibility study completed in 2016 in order to prepare tender documents to obtain investors.

In a supplementary question, Ndanda MP Cecil Mwambe asked when will the government compensate people along whose land the project will pass. Answering the question, Mwakibete said when the hired Transactional Advisor will issue guidelines for the payments through the government chief valuer.

### Z'bar govt allocates 12bn/- for public workers salary increase

ZANZIBAR government says it has allocated 12bn/- for improving benefits for public workers including salary increase and allowances for better work performance.

This was disclosed here by the Zanzibar minister of State in the President's Office (Good Governance, Constitutional Affairs and Public Service) Haroun Ali Suleiman as he addressed reporters as part of celebration to mark World Public Service Day to be observed June 24. He said the government has taken these efforts on salary increases in order to instill good performance in public servants when serving the people diligently.

He said there is no reason for public servants to fail to in-

still achievements at their work places because all basic issues, including allowances and other benefits have been adhered to.

He added that it has been discovered that in regard to public employees there have emerged acts of indiscipline including coming late to work and absenteeism.

In regard to public employees losing diligence and trust, he said the Report of the Controller and Auditor General (CAG) has clearly shown the continuation of these acts including non-

adherence of work ethics. He said the CAG report also shows that in regard to Covid-19 funds including the construction of schools and hospital projects, a lot of funds was embezzled including through procurement.

He added that the Zanzibar Government expects to submit a amendment Bill on Zanzibar Economic Crimes Authority (ZAECA) to give it more powers to fight public employees who embezzle funds.

### Government plans to provide more dialysis services to district hospitals

THE government plans to provide dialysis services to district hospitals in the country, thanks to the increasing budget allocation to the ministry of Health, the Parliament heard yesterday.

Dialysis is a process of removing excess water and toxins from the blood of people whose kidneys are

not functioning- is a costly service in Tanzania and elsewhere.

Deputy minister for Health Dr Godwin Mollel said the government is looking into ways of establishing more dialysis centres across the country as a way of reducing the burden on patients who are forced to travel long distances to referral hospitals to access the service. He noted that currently the service is offered at Muhimbili National Hospital in Dar es Salaam, all zonal and regional referral hospitals and some special others, including the University of Dodoma's hospital.

Dr Mollels was responding to a question asked by the Special Seats MP, Lucy Sabu(CCM), who had wanted to know what the government was doing to bring services to people with low income.

The lawmaker asked, "What is the government doing in order to provide dialysis services to poor people in the country?".

She also argued that currently, a patient must part with 300,000 /- to get a single session of dialysis, whereby three sessions are recommended by doctors per week.

In response, the deputy minister explained that the government provide the service to all Tanzanians of all walks, stating that there are always procedures for those who cannot afford the charges to get free treatment.

He said those who are unable to pay for such services are required to get introduction letters from their respective ward of village executive officers and submit to the hospitals. "I appeal for those with low income to follow the procedures for exemption of treatment charges, including for dialysis" said the deputy minister.

He maintained that the government was committed to see service charges reduce to as low as 90,000/- for a single dialysis session.

### Theft of Chunya farmer's maize: RC orders police to nab suspects

POLICE in Chunya District, Mbeya Region have been given one week to hunt for and put into custody people suspected to have stolen maize from two acres of Lupatingatinga farmer in the district.

Mbeya Regional Commissioner Juma Homera issued the instruction during the visit by the region's Defence and Security Committee to inspect various development projects and listen to people's complaints.

RC Homera said he received the report that the thieves recently stole

the maize whilst in the farm thereby i made a huge loss to the poor farmer.

He added that the farmer had spent a lot of money to produce the maize including fertiliser and costs for the labourers he hired.

He said in order to stamp out these acts, the police should hunt those involved and take stern legal steps against them to act as lesson for others harbouring similar intentions.

He also directed the police to hunt for muggers who cause havoc to the residents of Chunya Town by stealing their belongings and sometimes break into houses to steal various

items.

Some residents of Chunya town claimed that the town has muggers who steal from them during the night as they walk along the streets.

He said Chunya District residents are hardworking people in productive activities but the existence of thieves and muggers can be an obstacle to their endeavours, hence they will address the issue as soon as possible.

### Farm inputs subsidies will continue if funds available, government declares in Parliament

AT LEAST 799,937 farmers have received a total of 349,922 tonnes of the subsidized fertilizer by April, 2023, Deputy minister of Livestock and Fisheries, David Silinde told the Parliament yesterday.

Responding to a question on behalf of the Ministry of Agriculture, he said the government has also disbursed a total of 48,033 litres of pesticides to control pests, 1,823,688 tons of pesticides on cotton, 2,684,470.5 tonnes of those for cashew nuts, 1,004 tonnes of sunflower seeds and 61,486,981 seedlings of different crops through subsidy.

Silinde said the subsidy system on farm inputs to farmers will continue to be implemented, depending

The deputy minister said these in response to a question asked by the Arumeru West MP,Noah Suputu(CCM), who had wanted to know what the government was doing to reduce prices of fertilizer and other inputs in order to increase productivity.

In response, the deputy minister maintained that the government was undertaking various measures aimed at reducing prize of fertilizer and other inputs to farmers in order to increase productive production of agricultural crops.

He cited some of the efforts as subsidy on fertilizer prices, provision of improved sunflower seeds, availability of improved avocado, tea, coffee, and palm seedlings as well as pesticides for cotton and other crops.

"The aim is to ensure control of insects and pests that attack crops, fruits and rats" said Silinde, adding that the services will continue in line with the government's budget.

On Tuesday, Agriculture minister, Hussein Bashe urged farmers to utilize the government's subsidy on fertilizer prices to boost production as the plan aimed at supporting all farmers in the country.

He made the call in the Parliament yesterday, noting that the move is to ensure help farmers improve production and increase agricultural sector performance.

Bashe noted that the government this fiscal year (2022/23), committed itself to provide Sh150 billion as a subsidy package for fertiliser, to smallholder farmers, a response to the world's commodity price upsurge.

He added: "The government has also reintroduced the Fertilizer Bulk Procurement System (FBPS) through which a price cap for fertiliser will take effect, to stop businesses from hiking prices as witnessed in recent months".

The minister told the Parliament that all farmers in the country are eligible to benefit from the programme, adding that horticulture farmers can arrange themselves in group and seek the input.

ILALA District Administrative Secretary (DAS) Charangwa Selemani has advised parents and guardians to protect their children against unlawful television or online content.

Selemani made the advice over the weekend at Nguvu Mpya secondary school grounds, Chanika on the outskirts of Dar es Salaam when celebrating the International Day of the African Child.

She said this year's theme is "Eliminating Harmful Practice Affecting Children "has brought together more than ten non-government organisations and civil society organisations led by SOS village Tanzania.

She said parents have a big role to ensure their children are protected by censoring TV or online contents that are unfit for children's consumption.

Selemani said that if parents do not play their role, more children will be at risk of watching online contents that are against customers and norms.

"We as parents, our major role is to ensure we take care of our children and teach customs and norms. Let's us not leave children free to watch unlawful TV or online content that can change their behaviour, "she said.

"Increase in community awareness on the right use of TV and online content is very important to avoid moral decay, "she added.

According to her, TV and online content have a great contribution to change children's behaviour and therefore parents must be very careful.

She said parents must ensure children attend religious training sessions in schools and in Churches or madrasa to shape their behaviors.

Both Bestina Bosco and Selemani Juma pupils at Mzambarauni primary school in Ilala District council said children must be protected against online abuse.

She said that currently, online abuse against children is a growing problem in the country.

DEPUTY minister for Home Affairs, Jumanne Sagini has challenged the Tanzania Prisons to disseminate to the public useful education and awareness over the parole law to curtail the negative spate of stigmatisation towards prisoners.

The minister also urged the country's key army to set a patriotic system of making a close-follow up of prisoners who have been pardoned by the president and those set free as per other Parole regula-

tions. He said the move will help to ensure they are not involving themselves in crimes.

Sagini made the remarks over the weekend at a special seminar for members of the Foreign Affairs, Defense and Security Committee that was held in Dodoma Region. It was aimed to impart the lawmakers with an insightful understanding of the Parole law to assist them make a sober monitoring and reinforcement over the vital regulations in their constituencies.

He expressed that there has been a negative attitude among people across local communities to undermine and stigmatize prisoners who are being paroled by the government.

"Tanzanians should understand that the prisoners deserve to be treated equally and must receive all their statutory rights. People should not perceive or treat them badly," he said, noting experience has proved that most of the released prisoners recur to their past deeds due to the negative reception and perception

from their societies.

The deputy minister urged members of the parliament to use the one-day seminar to acquire key understanding and educate their people on the need to stop stigmatizing released prisoners.

He underscored the need for journalists to be equipped with enough understanding on the Parole law.

Earlier, Commissioner General of Prison Service, Ramadhan Nyamka expressed optimism that the MPs will make patriotic use of the seminar to get key knowledge to

enable them become good ambassadors of the Parole law in their constituencies. Nyamka added the seminar was meant to help educate Tanzanians through their lawmakers.

"Due to poor understanding over the law, some people have been complaining seeing some prisoners in the streets, thinking that they have been released through bribes," he said, adding the Tanzania prison will continue to create awareness over the regulation to the public.

The Ugandan military and their Congolese counterparts launched joint operations against the rebel group in November 2021 shortly after the ADF launched bomb attacks in Kampala, the capital of Uganda.

Earlier, Cristina Wuiya, instructor from Mati Ilonga Centre appealed to the youth under three-month training that ends July this year to understand how to solve farm challenges, saying they should not despair, because farm activities need a lot of perseverance and determination.

She said Mati Ilonga Centre teaches students middle level farming practically and instructed them to abide by the training given.

One of the youth, Bili Kaduma, who is BBT Youth Secretary thanked the government and ASA for the training provided to them for the production of seeds for cowpeas, rice, sunflower and oil palm. He said they also learned how to fight farm challenges including invasion by herders.

He added pledged to the government to depend on them because, he said the agriculture "fire" implanted in their hearts will be used in order to attain achievements.

### Marriage Act still calls for more serious action

A NUMBER of non-governmental organisations raised eyebrows lately with what they said was a 'special walk,' not a demonstration in the city of Dar es Salaam. They wished to sound the urgency of amending the Marriage Act of 1971 to remove provisions enabling marrying off young girls. They want a High Court ruling to that effect be made into law.

The good thing about that act of protest was that it was calibrated not to cause any perceptible disturbance, merely bring people to take notice that it has occurred, and media outlets to help carry the message across. That has by and large been carried out, but neither the NGOs nor anyone in particular expects that anything will change overnight - or in the foreseeable future. NGOs know there are safeguards in that direction already, but are hammering on that point.

Marrying off a girl aged less than 18 years implies that the girl isn't in school, as the law is stern on any attempt to marry a school going girl child. With secondary schools being free of school fees, there is arguably no reason why a girl who dreams of education would be restrained at home after her name appears in lists of those moving to secondary school. By and large that safeguard is sufficient, only demanding enabling moves upon leaving school.

What the NGOs are suggesting obviously is that these safeguards don't hinder a situation where a young girl not yet and not in secondary school is given in marriage. That point is valid but it avoids parental obligation, shifting it to the government; parental input is vital where the schooling safeguard isn't in place, as there are other sources of law relating to marriage accommodated in the law of marriage. NGOs can't insist that this accommodation is abrogated, not at all.

Insistence on ending child marriage is understandable from the viewpoint of rights of the girl child, but it isn't the only 'narrative' that the government is compelled to pay attention to their demands or ideals. There is a sphere of interaction between law and culture that has to be carefully handled so that it doesn't provoke undue tensions. That is why parents and guardians have to shield daughters either to be in school or in skills training, to 18 years of age


Back in 1978, founder president Julius Nyerere was answering questions at the Nkrumah Hall of the University of Dar es Salaam, where someone touched on what he thought was discrimination against him for reasons of tribe. One can say that the entire audience was persuaded the complaints were irrelevant and far-fetched. But the president treaded carefully to elaborately clarify tribalism.

Illustrating his argument with an example from military ranks or promotions, he said if the leadership saw only merit, tied with education, commissioned officers would soon be from two or three regions mainly, and the non-commissioned from other areas.

That would be to plant a time bomb of untenable cohesion in future, so policy changed to include anyone who reaches top non-commissioned rank and the army needs him, be promoted to captain. ### Worrying lack of urgency as Gauteng health sits on money earmarked for urgent outsourcing of cancer treatment

#### By Khanyisa Mapipa

IT is almost three months since partly through the efforts of SECTION27 and Cancer Alliance - money was made available to the Gauteng Health Department to outsource radiation oncology services and address surgical backlogs in the province.

In our article dated 10 March 2023, we indicated that Gauteng Treasury made available an amount of R784 million for the outsourcing of radiation oncology services as well as to service other surgical backlogs. Since then, we have been advised by the Gauteng Department of Health that, of the R784 million, an amount of R250 million has its updated backlog list.

They, however, confirmed that approximately 300 patients have been serviced since the Cancer Alliance backlog list was compiled in 2022, which places the backlog list at approximately 2700. Some patients may in the meantime have been added to the backlog or passed away, so the real number could be a bit higher or lower.

This lack of urgency and intention shown by the Gauteng Department of Health in the slow manner in which they are handling this matter is cause for great concern.

While radiation oncology is not in itself a cure for cancer, it is an important and crucial step in the treatment protocol and one which cannot be replaced with any

RECENT studies conducted in Tanzania have revealed that about 71 per cent of urban households use charcoal while about 19 per cent use firewood for cooking with just a fraction of them using other sources of energy such as Liquefied Petroleum Gas (LPG) and electricity.

The situation is even worse in the country's commercial capital of Dar es Salaam; a home to about five million people, where the study showed that 91 per cent of the households use charcoal whereas 3 per cent consumed firewood.

This year the government announced to cease the use of firewood and charcoal in public and private institutions in Tanzania mainland that prepare food and feed more than 100 people per day by January 31, 2024.

It has also directed the institutions that prepare food and feed more than 300 people to cease the use of firewood and charcoal by January 31, 2025.

The institutions will be required to use safe and clean renewable cooking energy.

The government intends to reduce environmental, health, social and economic impacts resulting from the use of firewood and charcoal and it already has prepared a National Vision for the Use of Clean Cooking Energy as well as a Strategic Plan for the Implementation of the Vision for the period of 10 years until 2033.

Accessibility of charcoal and firewood is easy but their uses affects the users health by causing diseases resulted by inhaling dirty air that affects the lungs, heart and respiratory systems especially to children.

We need to build an industrial economy, so the use of renewable cooking energy will provide an opportunity for factories to produce alternative charcoal in parallel with producing standardised and efficient stoves for the efficient use of such energy.

Charcoal has long been the main fuel for cooking in households and restaurants throughout Tanzania. Households nearly entirely in Tanzania still prefer firewood and charcoal over gas and electricity as fuel. As a result of their dependence, Tanzania loses at least 46,942 hectares of its forests annually, thus putting at risk the government and stakeholders' efforts to adapt to climate change.

Energy sources in developing countries remains a major issue as a big percentage of the population continues to depend on firewood and charcoal for their fuel needs.

According to the 2009 World Bank report, Dar es Salaam alone uses approximately 500,000 tonnes of charcoal annually. This amount is estimated to surge in the coming years. Over 90 per cent of Tanzanian households use charcoal or firewood as their primary source of fuel.

Of all the wood produced every year in sub-Saharan Africa, 90 per cent is used as fuel, posing a major sustainability challenge. Woodfuel, primarily firewood and charcoal, is the main source of energy for cooking for two-thirds of households in Africa and Tanzania is no exception and is a critical element in maintaining food security. Millions of households depend on woodfuel production to make a living, but heavy reliance on it makes for social, economic, environmental and health concerns. With such complex issues, a broader approach is needed.

Based on current trends and progress towards SDG 7 - Affordable and Clean Energy - by 2030 there will still be more than 2 billion people, mainly living in Africa, relying on traditional biomass for cooking. The conference, Sustainable Woodfuel Value Chains in Africa: Governance, Social, Economic and Ecological Dimensions, will raise awareness of the consequences of current practices with woodfuel production and consumption, as well as possible pathways towards sustainable forest management and restoration in support of green energy transition.

How we got here: the three-step process

On 27 March 2023, Cancer Alliance and SECTION27 met with the Gauteng Department of Health and the provincial treasury to discuss and solidify the steps to be taken to, with the money made available, ensure the urgent realisation of the outsourcing project.

At this meeting, it was agreed that the Gauteng Department of Health would embark on a threestep process whereby it would update the list of patients awaiting radiation oncology services to reflect the current backlog.

As indicated in our previous article, Cancer Alliance in March 2022, had, at its own cost, employed the services of an independent consultant and with the consent of Charlotte Maxeke Johannesburg Academic Hospital, compiled a list of patients awaiting radiation oncology for over a year. At the time, it was found that there were approximately 3 000 patients awaiting radiation oncology services.

So, the first in the three-step process Gauteng Health was set to embark on, involved updating this backlog list to include patients who had not been serviced in 2022 and to remove those who had received radiation oncology services in the meantime.

To date, the Gauteng Department of Health has not produced qualifying criteria for those who will be referred to the private sector, depending on what is decided in the briefing with the private sector.

The third step of the process is to conclude contracts with private sector providers to provide radiation oncology services.

#### More undertakings

The plan is to ensure that patients are treated through this outsourcing programme by the beginning of August 2023.

When asked, Gauteng Health acknowledged that the tender process would take longer than the outsourcing process and its success also depends on the response received from the market. However, by comparison, the outsourcing project would guarantee that patients like Noluthando are able to access the service from the private sector as soon as it is concluded.

At the meeting of 2 June 2023, the Gauteng Department of Health agreed to obtain a deviation from the normal tender process by Friday 9 June 2023. Following this, the department would hold a briefing session with prospective service providers within a two-week period. This would mean by Friday, 23 June 2023.

The prospective service providers will then be given a period of two weeks to return with proposals, by Friday, 7 July 2023. These proposals will be assessed by a committee and the final award will be made by 21 July 2023. The plan is to ensure that patients are treated through this outsourcing programme by the beginning of August 2023.

Our hope is that the Gauteng Department of Health will, this time, live up to its undertakings. It is worrying that despite being provided with resources to help ensure access to radiation oncology services for the thousands of patients, very little has been done to date to ensure that these cancer patients get the long overdue care that they need. The department must and can do better.

### Why was Ramaphosa's security detail grounded in Poland - pro-Russia perceptions, or underprepared securocrats?

AMBIAN President Hakainde Hichilema had a total of 24 officials - of whom about a dozen were security officers - travelling with him on the African peace mission to Ukraine and Russia on Friday and Saturday.

Comorian President Azali Assoumani was accompanied by two security officers and four other officials, other sources said.

Senegalese President Macky Sall probably had about the same number of security guards as Hichilema.

As a result of having such small security contingents, these and the other three state officials participating in the peace mission were able to travel with their guards to Kyiv to meet Ukrainian President Volodymyr Zelensky on Friday and to St Petersburg to meet Russian President Vladimir Putin on Saturday.

#### Security overkill

President Ramaphosa, meanwhile - with a huge security detail numbering about 120, plus about 12 containers of weaponry (reportedly including heavy arms fit for combat, not just personal protection) - couldn't take them either to Kviv or St Petersburg, because the small South African army caused such alarm along the way.

Particularly to the Poles. The Polish government grounded the South African Airways charter aircraft at Warsaw airport, refusing to allow the guards or the weapons off the plane.

Eventually, about 26 hours later, the security personnel - plus about a dozen journalists on the plane, who had become "collateral damage" as one of them put it - were allowed to disembark and were taken to a hotel in the city, without their luggage.

Ramaphosa's head of security, General Wally Rhoode fulminated about the Poles trying to sabotage the peace mission and being racist. He said it was because the Poles demanded originals instead of copies of the necessary clearance certificates.

Ramaphosa, Sall and Assoumani were the only three presidents on the mission, while the four other African governments involved were represented by their

officials. Of these, the most senior was Egyptian Prime Minister Mostafa Madbouly, who had quite a substantial security detail - though nothing like Ramaphosa's, diplomats said.

Uganda and the Republic of Congo were represented by lower-ranking officials, and their security details were small, the sources said.

So, was the grounding of President Ramaphosa's security team a Nato plot to frustrate South Africa's participation in the peace mission, as Rhoode seemed to be hinting and some South African officials also seemed to think? Was this because South Africa is increasingly seen by Nato countries as pro-Russia?

### Making the impossible possible: Chronicles of an ambassador's lifelong frontline battle to end leprosy

#### NAIROBI

N 1974, Yohei Sasakawa accompanied his father to a leprosy hospital he had funded. He saw leprosy patients inside the hospital still and expressionless. The smell of leprosy filled the air, the smell of pus from open sores.

His father sat with the patients, touched their hands and faces, and encouraged them to be hopeful. Treatment was within reach, and they would live. At that moment, Sasakawa wondered about the life that awaited these patients outside the hospital - a difficult life of discrimination and alienation, with many ostracized from society. He silently vowed to



affected by the disease, as well as his meetings with policy-makers, government leaders, and heads of state to advocate for a renewed commitment to the fight against leprosy, including measures to protect the human rights of those it affects.

"For as long as I can remember, I have made a point of repeating three messages in every meeting, conference, or press conference that I attend. The first message is that leprosv is curable. The second is that free treatment is available everywhere around the world. And the third message is that discrimination against people

dedicate his life to ending leprosy.

In his newly published book, Making the Impossible Possible, he chronicles face-to-face encounters with an ancient disease shrouded in many myths and misconceptions. His travels to leprosy-endemic countries as WHO's Goodwill Ambassador for Leprosy Elimination started in 2001 and has involved over 200 trips to nearly seventy countries.

"Nearly all of my destinations have been remote locations where people live in quite desperate conditions. It has always been my belief that the place where the problems are happening is also precisely where the solutions will be found," he says.

"I am also a firm proponent of the Neo-Confucian idea that knowledge is inseparable from practice. I want to be a man of deeds. I became involved in my international humanitarian work out of a passionate desire to be involved on the front lines until my last breath, and I am the first to admit that my work is done, in that sense, for my own personal satisfaction.'

As he retraces a remarkable journey on the frontlines of fighting the leprosy scourge, the Bergen International Conference on Hansen's Disease by the Sasakawa Leprosy (Hansen's Disease) Initiative and the University of Bergen in Norway will kick off on June 21, 2023, and end the following day.

The conference is a nod to February 28, 1873, when Norwegian doctor Gerhard Armauer Hansen discovered Mycobacterium leprae, the causative agent of leprosy. To commemorate the historic anniversary, the conference seeks to highlight that 150 years later, leprosy is not a disease of the past.

Leprosy still exists as a neglected tropical disease in more than 120 countries worldwide, with at least 200,000 new cases reported annually. Nevertheless, progress over the last half-century has brought the world closer to the goal of a world without leprosy.

The Bergen conference is an opportunity to draw on the knowledge, experience, and wisdom of many people at the place where Mycobacterium leprae was first observed, and to build momentum to complete the last mile in leprosy, the hardest part of the journey.

Sasakawa's book is a treasure trove of challenges, triumphs, best practices, lessons learned, and insights into what it will take to finish the last mile in the decades-long marathon to eliminate the ancient disease.

The book is the most detailed account of Sasakawa's quest to work for a world without leprosy and the discrimination it causes.

It is an account of his travels to remote communities around the world to hear directly from those

affected by leprosy has no place," Sasakawa affirms

"These messages are very easy to understand. But the third one, the message that discrimination has no place, is extremely difficult to put into practice. The habits of a lifetime and ingrained unconscious attitudes are not easily dispelled."

Similarly, these messages will reverberate throughout the two-day conference to spread the message that today, leprosy is treatable with multidrug therapy (MDT), but if treatment is delayed, leprosy can cause progressive impairment and result in lifelong disability.

Delayed treatment and consequent disability have largely contributed to the persistent stigma surrounding the disease and the discrimination that persons affected by leprosy and their families continue to face. Discrimination is also a barrier to new case detection, discouraging people from seeking treatment.

Through sustained concerted efforts, many countries and international organizations, led by the WHO, are now aiming for zero leprosy-zero disease, zero disability, and zero discrimination.

Achieving this goal will require stakeholders to cooperate closely. To this end, the conference will bring together key leprosy stakeholders from around the world for two days of discussions focused on three pillars: medical, social, and historical.

Notable dignitaries scheduled to deliver messages at the event include Dr Tedros Adhanom Ghebreyesus, Director-General, WHO Volker Türk, United Nations High Commissioner for Human Rights, and Ingvild Kjerkol, Minister of Health and Care Services, Norway.

Keynote speakers include Professor Paul Fine of the London School of Hygiene and Tropical Medicine and Dr Alice Cruz, the UN Special Rapporteur on the elimination of discrimination against persons affected by leprosy and their family members.

The conference is part of the "Don't Forget Leprosy/Don't Forget Hansen's Disease" campaign launched by the Sasakawa Leprosy (Hansen's Disease) Initiative in 2021. It follows the 2022 Global Forum of People's Organizations on Hansen's Disease held in Hyderabad, India, the 2023 International Symposium at the Vatican on Hansen's Disease incorporating the Global Appeal 2023 to End Stigma and Discrimination against Persons Affected by Leprosy, and 150-anniversary events.

HINA'S Shenzhou-16 manned spaceship was successfully launched on May 30. Ten paintings by teenagers from 10 African countries were carried to space with the three taikonauts.

The 10 paintings were awarded entries in the "My Dream" Painting Competition for African Youth, which was co-hosted by the secretariat of the Chinese Followup Committee of the Forum on China-Africa Cooperation, the China Manned Space Engineering Office and some Chinese embassies and consulates in African countries. The competition received drawings from 2,000 African youths.

The 10 entries won the Tianhe Award, which is named after the core module of China's space station, and flew into space together with the Shenzhou-16 crew. They will be exhibited in the space station.

"I'm just a normal youth from rural Nigeria. I never thought that my drawing could be taken to space by a Chinese spaceship and exhibited to the whole world. It's wonderful," said 20-year-old Nigerian Prosper Sania Dania.

The theme of the competition was mankind's dream of exploring the vast universe. In Dania's painting, a round pattern comprised of the national flags of Nigeria and China is displayed, symbolizing the friendship and solidarity between the two countries.

"Mankind has always been aspiring to explore the universe, and young Africans are no exception. China has made tremendous achievements in aerospace. The pioneering spirit of Chinese taikonauts is encouraging African adolescents to chase their space dream," Dania said, explaining the idea and inspiration of his work.

He told People's Daily that he was deeply touched by the remarks by Chinese taikonaut Jing Haipeng that the space exhibition will sow the seeds of science, friendship, and dreams on the China Space Station.

Jing's story of chasing dreams in space also made the young African realize that it's important for young people to not only have a dream, but also work for it, Dania said.

"I know that many cooperation platforms built by China have been supporting young Africans to show their creativity, though I've never been to the country. China and Nigeria, as well as other African countries, share de-

Rawda Ahmed Ali Al Shawadfy, 18, is a freshman studying Chinese at the Suez Canal University in Egypt. After a few months of study, she could introduce her award-winning entry titled "China is Africa's Hope towards Space"

"The handshake between the Chinese and African taikonauts on the moon is a symbol of the close cooperation between China and Africa. The five conspicuous stars on Earth behind them represent China's leading position in aerospace," she explained.

She said China has made admirable achievements in science and technology, hoping that African countries and China can launch more cooperation on aerospace and make progress together.

Shawadfy told People's Daily that the first-ever exhibition on China's space station would not only give these paintings a new connotation of Africa-China friendship, but also bring mankind's dream to space.

"The exhibition helps promote international exchanges and cooperation, and strengthen mutual understanding among people from different countries. It also encourages more young people like me to pursue dreams," she said.

Shawadfy has been interested in traditional Chinese culture since she was a child. She chose to major in Chinese at university to understand China more profoundly.

"I hope I can go to China one day to visit the majestic Great Wall and see the lovely pandas. I also want to pursue further studies there and then be a Chinese teacher or translator, so that I can contribute to Africa-China friendly cooperation," she added.

Hope Mafiko, an 18-year-old from Zimbabwe, is another winner of the Tianhe Award. After learning that his work was going to space, he immediately shared the excitement and joy with his family and friends.

In Mafiko's painting, which is abundantly covered by green and dotted with yellow and red, two African women are looking up to the sky, expressing mankind's aspiration for the universe. "Green, yellow and red are colors that typically represent Africa," Mafiko said, adding that he hopes the painting can mirror Africans' passion for exploring the vast universe.

The young man was touched by the greetings that Chinese taikonauts made to African adolescents. "It was very heartwarming to hear such kind words. Many young people are being inspired by moments like these and hopefully become a generation of visionaries," he said.

### UN Cybercrime Convention: Could the cure be worse than the disease?

F you've never heard of the Cybercrime Convention, you're not alone. And if you're wondering whether an international treaty to tackle cybercrime is a good idea,

Negotiations have been underway for more than three years: the latest negotiating session was held in April, and a multi-stakeholder consultation has just concluded. A sixth session is scheduled to take place in August, with a draft text expected to be approved by February 2024, to be put to a vote at the UN General Assembly (UNGA) later next year. But civil society sees some big pitfalls ahead.

#### **Controversial beginnings**

In December 2019, the UNGA voted to start negotiating a cybercrime treaty. The resolution was sponsored by Russia and co-sponsored by several of the world's most repressive regimes, which already had national cyberinternational cooperation. But this doesn't necessarily need a new treaty. Experts have pointed out that the real problem may be the lack of enforcement of current international agreements, particularly the 2001 Council of Europe's Budapest Convention.

When Russia's resolution was put to a vote, the European Union, many states and human rights organisations urged the UNGA to reject it. But once the resolution passed, they engaged with the process, trying to prevent the worst possible outcome a treaty lacking human rights safeguards that could be used as a repressive tool.

The December 2019 resolution set up an ad hoc committee (AHC), open to the participation of all UN member states plus observers,

including civil society. At its first meeting to set procedural rules in mid-2021, Brazil's proposal that a two-thirds majority vote be needed for decision-making - when consensus can't be achieved was accepted, instead of the simple majority favoured by Russia. A list of stakeholders

was approved, including civil society organisations (CSOs), academic institutions and private sector representatives.

Another key procedural decision was made in February 2022: intersessional consultations were to be held between negotiating sessions to solicit

use the space to influence the treaty process, including as part of broader coalitions. Given what's at stake, in advance of the first negotiating session, around 130 CSOs and experts urged the AHC to embed human rights safeguards in the treaty.

One of the challenges it that, as early as the first negotiating session, it became apparent there wasn't a clear definition of what constitutes a cybercrime and which cybercrimes should be regulated by the treaty. There's still no clarity.

The UN identifies two main types of cybercrimes: cyberdependent crimes such as network intrusion and malware distribution, which can only be committed through the use of information and communications technolo-

disagreement about whether the treaty should focus on a limited set of cyber-dependent crimes, or address a variety of cyber-enabled crimes. These, human rights groups warn, include various content-related offences that could be invoked to repress freedom of expression.

These concerns have been highlighted by the Office of the UN High Commissioner for Human Rights, which has emphasised that the treaty shouldn't include offences related to the content of online expression and should clearly and explicitly reference binding international human rights agreements to ensure it's applied in line with universal human rights principles.

A second major disagreement concerns the scope

to an action that constitutes a crime in both the country making an extradition request and the one receiving it - state authorities could be made to investigate activities that aren't crimes in their own countries. They could effectively become enforcers of repression.

Civil society has pushed for recognition of a set of principles on the application of human rights to communications surveillance. According to these, dual criminality should prevail, and where laws differ, the one with the higher level of rights protections should be applied. It must be ensured that states don't use mutual assistance agreements and foreign cooperation requests to circumvent domestic legal restrictions. IPS

### Kenya signs EU trade deal in effort to boost **Brussels'** Africa ties

#### NAIROBI

ENYA and the European Union have signed a trade deal in a coup for Brussels as it seeks deeper economic ties with Africa in the face of competition from China.

Kenyan President William Ruto presided over a ceremony in Nairobi on Monday to mark the formal conclusion of negotiations for the EU-Kenya Economic Partnership Agreement.

Once ratified and entered into force, Kenva will receive duty-free and quota-free access to the EU, its biggest market where it sends roughly one-fifth of all its exports.

Imports from the EU to Kenya such as chemicals and machinery will receive progressive tariff reductions over a period of 25 years, but some sensitive products will be excluded.

"Today is a very proud moment for Kenya, and I believe a very proud moment for the European Union," Kenyan Trade Minister Moses Kuria said after signing the accord with EU Trade Commissioner Valdis Dombrovskis.

Kenya's main exports to the EU are agricultural products, including vegetables, fruits and the country's famous tea and coffee.

More than 70 percent of Kenya's cut flowers are destined for Europe

Ruto, who said the EU was "the second most important development partner for Kenya after the World Bank" said the country's farmers could be "assured of a predictable market" and the agreement provides new opportunities to boost this trade.

"It ensures a stable market for industrialists, for our farmers, and also industrialists in the European Union," he said.

Dombrovskis said EU companies had invested 1 billion euros (\$1.1bn) in Kenya in the past decade but that there was "a strong appetite" to do more business.

"With this deal in place, we have the right platform to do so," he said.

It is the first broad trade deal between the EU and an African nation since 2016 and follows a spending spree by China on lavish infrastructure projects across the continent.

The EU has taken steps to counter China's Belt and Road programme, announcing in February it would increase investments in Kenya by hundreds of millions of dollars through its own Global Gateway initiative.

It is part of a trend of African nations being wooed by Western partners in recent years as Russia and China increasingly gain a foothold in Africa.

Dombrovskis said the East African powerhouse was "a beacon of dynamism and opportunity", echoing the international perception of Kenva's relative stability in what remains a turbulent region.

In a briefing with reporters before Monday's ceremony, Dombrovskis said Africa was a "priority region" for the EU, and he hoped the Kenya deal would "be a boost" to future trade links with Africa. The Kenya deal is the culmina-

### 'Effective use of EFDs, ETS to govt boost revenue in 2023/24'

INANCE and Planning minister Dr Mwigulu Nchemba has unveiled several strategies to increase revenue in 2023/24 including proper use of digital revenue collection systems such as Electronic Fiscal Devices (EFDs) and Electronic Tax Stamps (ETS), among others.

Nchemba (pictured) made the call last Thursday when tabling the budget for the 2023/24 financial year in the National Assembly.

He said that it is high time the devices are effectively used to increase efficiency in tax collection and make the government meet its development target.

EFD machines record sales and issue fiscal receipts in the form and manner prescribed by Tanzania Revenue Authority (TRA), while ETS is managed and operated by SICPA-a Swiss company that has high end operations. ETS machines are set up in a way that manufacturers are also able to monitor their own output and pay tax accordingly in real time.

According to Nchemba, the use of the devices increased domestic revenue to 24.40trn/- in 2021/22 from to 20.59trn/- in 2020/21. In addition, from July 2022 to April 2023, domestic revenue collection reached 21.67trn/-, whereas in December 2022, TRA collected 2.63trn/, which is the highest monthly collection since its establishment in 1996.

"This impressive trend is a sign that the government is committed to implement strategies for increasing revenue collection in accordance with laws, guidelines and procedures, strengthening revenue collection systems and improving the business environment and investment in the country," he said.

He also stated other measures to boost revenue collection including improvement of investment and business environment and continue with the amendment of various laws to increase the private sector participation in business and investment, widening the tax base by registering businesses and new taxpayers as well as continue implementing various measures so as to reduce tax evasion and creation of public awareness on voluntary tax payment.

Nchemba noted that the government intends to strengthen and encourage the use of ICT systems for the collection of government revenue; continue encouraging the use of the Government Electronic Payment Gateway (GePG) system by ministries and other government institutions and ensure usage of control number in all government transactions.

"We'll also continue to strengthen systems and management of public institutions, agencies and entities to increase efficiency and ensure dividends and eligible



contributions are timely submitted to the Consolidated Fund as well as continue to raise public awareness to encourage investment in the domestic government bonds market," he said.

He said the government intends to strengthen cooperation with development partners including implementing contractual agreements so as to facilitate access to grants and loans as planned and utilize opportunity resulted from credit rating exercise to raise additional resources from international financial and capital markets for investing in strategic development projects; and continue to implement the Strategy to Finance Development Projects Using Alternative Project Financing (APF) to increase the scope of access to funds for the implementation of Development projects.

The minister stated that the government continues to implement prudent monetary policy as well as the Blueprint for Regulatory Reforms to improve the business environment in the country. "This has resulted to a decline in interest rates on bank loans, whereas for the year ending April 2023, the overall

lending rate decreased to an average of 15.91 percent from an average of 16.58 percent in April 2021," he added, noting the decline in interest rates has contributed to an increase in credit to the private sector to 22.5 percent in April 2023 compared to 4.8 percent in April 2021.

### Negotiations must accelerate climate action and save vulnerable countries

ULNERABLE countries, banking on robust climate negotiations, want an inclusive funding package to help them with the devastating impacts of climate change.

The poor progress at the 2023 Bonn Climate Change Conference, known as the 58th session of the Subsidiary Bodies of the United Nations Framework Convention on Climate Change (UNFCCC), has dampened hopes for successful climate negotiations at COP 28.

SB58, which closed in Bonn, Germany, last week, was marked by wide disagreements, including the adoption of the agenda. The session ended without concrete outcomes on an array of key issues, such as the operationalization of the Loss and Damage Fund, the mitigation work programme, the global stock take (GST), and the global goal on adaptation (GGA).

"Even when we do not like the pace that the negotiations have gone, we have to find a way to a solution sooner than later; human existence is at stake," Yamide Dagnet, Climate Justice Director at Open Society Foundations (OSF), told IPS.

The foundation has been supporting the climate change community in pushing for solutions.

"We need to see more efforts to make the whole society more resilient."

She said having a financial package for investment and development aligned with the Paris Agreement was crucial.

Dagnet said there was an urgent need to support building resilient communities because climate change impacts are becoming more frequent and severe, destroying lives and livelihoods, particularly in vulnerable countries. Furthermore, the extreme weather events have also destroyed communities and cultures and damaged property.

"We need to work hard, sweat, and speed the pace of negotiations on our ability to find common ground and avoid a zero-sum game," said Dagnet, a former climate change negotiator. She underscored that the Bonn meetings matter because they are laying the ground for discussions at COP28 and highlighting areas of cooperation and division.

The Intergovernmental Panel on Climate Change (IPCC), in its recent report, has called for accelerated action to adapt to climate change while cutting greenhouse gas emissions, warning of a huge gap in actions currently underway and what is needed to deal with the increasing risks.

Developed countries have called for the inclusion of adaptation in the GST.

Ephraim Mwepya Shitima, Chair of the African Group of Negotiators (AGN) developing countries' commitment to mitigating climate change, should be recognized. He called for an additional message in the GST to acknowledge this "strong demonstration of commitment by vulnerable countries in the face of inadequate international support."

Vulnerable countries want mitigation and adaptation to be included in a negotiated package at COP28, Dagnet said, noting that the G7 should fulfill their promise to provide adaptation finance.

"The financing of the Loss and Damage is part of the

we can bring in money to that fund, and such money should not be increasing debt for vulnerable countries," she noted. Climate finance is a nagging

issue for vulnerable countries of already suffering the impacts of of climate change. They need is to adapt and mitigate against climate change by shifting to

cleaner energy and making food systems resilient to the impacts of droughts, high temperatures, and floods. Developed countries, wary of

liability, have not delivered the finance they pledged to help vulnerable countries reduce emissions and adapt to climate change. The \$100 billion a year



financing pledged 20 years ago has not been delivered, and prospects are dim that it will. The envisaged Loss and Damage Fund–if COP28 operationalizes it–will help vulnerable countries cope with climateinduced disasters.

Dagnet says there is a need for innovative financing for loss and damage, such as tapping blended finance, philanthropy, taxes, and levies on some economic sectors, such as fossil fuels and aviation.

UN Secretary-General Antonio Guterres recently proposed that rich governments tax fossil fuel companies' windfall profits.

The Marshall Islands have also proposed levies on shipping through the International Maritime Organization.

At the same time, other ideas for funding adaptation have included levying a small fee on international flights–which contribute to climateheating emissions–and a global tax on financial market transactions, which the new fund could distribute.

financing package that is needed. But we need to focus on everything, including mitigation and adaptation for vulnerable countries; otherwise, COP 28 will not achieve anything," she said, highlighting that countries must develop more ambitious climate plans.

The Paris Agreement, adopted in 2015, agreed to keep the increase in the global average temperature to well below 2° C above pre-industrial levels and to pursue efforts to limit the temperature increase to 1.5°C above preindustrial levels.

However, scientists have warned that the world is off target in emission reduction, and the influential UN Intergovernmental Panel on Climate Change (IPCC) has indicated that going beyond the 1.5°C threshold risks unleashing severe climate change impacts, including more frequent and severe droughts, heatwaves and rainfall.

The agreement also recognized that developed countries should take the lead in providing financial assistance to poor and vulnerable countries while encouraging voluntary contributions by other Parties.

"Climate justice is to be fought for. This is a process, and if we are to make progress in the operationalization of a fund created at COP 27, we need to get clarity on how

While COP 27 prioritized the establishment of the Loss and Damage Fund, COP 28 is not about cherrypicking an issue to progress on, Dagnet argues, suggesting that the state of the Paris Agreement is key in climate negotiations.

"We need to deliver on all pillars of the Paris Agreement and demonstrate progress," she said. "We are far from the Paris Agreement goals. The push for energy efficiency targets is really good, but at the same time, we cannot have the message that we will continue business as usual with fossil fuels."

### **WEALTH MIGRATION:** What motivates the world's wealthiest to move

'igh-net-worthindividual migration statistics speak volumes. Affluent families are extremely mobile, and their transnational movements can provide an early warning signal in terms of a country's economic outlook and future country trends.

Like the proverbial canary in the coal mine, they alert us to dangers that may lie ahead as they are more sensitive to potential threats to their wealth and usually have the resources to take a corrective course of action to preserve their legacies.

An increasing outflow of millionaires often points to a drop in confidence in a country, since high- and ultra-high-networth individuals have the means to leave and are usually the first to exit and vote with their feet when circumstances deteriorate.

Along with their families, millionaires bring to their host countries their wealth, their networks, and the taxes they pay, which is why losing them can be detrimental to the economies of the countries they migrate from.

In some cases, affluent

attracting, and retaining them is an important endeavor for any nation state.

In general, wealth migration trends look set to revert to prepandemic patterns this year, with Australia reclaiming the top spot for net inflows as it did for five vears prior to the Covid outbreak. and China seeing the biggest net outflows as it has each year for the past decade.

Besides Australia, the highest proportion of wealthy families relocating this year are opting for the UAE, Singapore, the USA, and Switzerland.

#### The top priorities of the wealthiest


Political stability, low taxation, and personal freedom have always been key metrics for millionaires when it comes to deciding where to live.

However, the priorities of affluent individuals are shifting to the intangible but equally vital elements that impact; their children's prospects, the quality of their lives, and the legacies they leave. Wealthy families want to ensure that their offspring have access to top-tier academic institutions to pave the way for their success.

They are looking for optionality to move to cities that are more resilient to climate change and that offer a good quality of life, and to put down roots in countries where their capital can be protected for many generations to come.

Singapore, Switzerland, and the UAE have all built their repu-



### Namibia to light up slums through AfDB Fund grant

#### WINDHOEK

THE African Development Bank's Urban and Municipal Development Fund (UMDF) has approved a grant of \$485,000 for a solar electricity project in Namibia that will power some 50,000 households in the capital city.

The "Informal Settlement Renewable Electrification and Upgrading Program" will directly benefit around 200,000 people in Windhoek, where around 20% of the population does not have electricity.

The Urban and Municipal Development Fund helps governments to invest in sustainable urban development for more climate resilient, resilient, livable and productive cities, underpinning national socio-economic development and poverty reduction.

In Windhoek, one consequence of rapid and uncontrolled urbanization is the rise in informal settlements, characterized by nonelectrified neighborhoods and underdeveloped economic activity, severely hindering the quality of life for residents.

The Municipal Council of Windhoek requested the Fund's support to upgrade services in its informal neighborhoods, a key priority under the metropolis' Strategic Plan. Installing electricity in informal settlements is considered a crucial investment to unlock the economic potential of these areas and substan-

### Brazil joins move to support cotton production

HE government of Brazil has rolled out diverse farm implements, valued 700mn/-, to support the Tanzania Agricultural Research Institute (TARI) Ukiriguru Centre in Mwanza region to execute the Cotton Victoria Project (CVP) more professionally.

The on-going robust project is a partnership between Brazil, Tanzania, Kenya, and Burundi, with the goal to increase the institutional capacity and human resources training in the use and dissemination of technology in the cotton production sector.

Several stakeholders in the cotton value chain from within and outside the country are bridging up efforts in the implementation of the vital initiative in several regions around Lake Victoria, including Mwanza region.

The stakeholders include the Ministry of Agriculture of Tanzania, the Brazilian Cooperation Agency (ABC), the Brazilian Cotton Institute (IBA), the Federal

University of Lavras (UFLA), the Tanzania Agricultural Research Institute (TARI-Ukiriguru) and the Tanzania Cotton Board (TCB).

Speaking during a brief event tailored for the official hand over of the modern implements to TARI- Ukiriguru headquarters, the Ambassador of Brazil to Tanzania, Gustavo Martins Nogueira, expressed that the support gears to heighten quality of the project's activities, as well as the involved beneficiary farmers.

"It is a great pleasure and honor for me to be here today to take part in this symbolic handover ceremony of farm implements and tools donated by the Government of Brazil to TARI-Ukiriguru under the "Cotton Victoria" project," he said.

The Envoy unveiled that the timely initiative focuses to benefit 8,500 cotton smallholder farmers in the districts of Misungwi, Kwimba, and Magu in Mwanza region.

"Since its inception, six years ago, this project has been providing training, technical assistance and demonstration plots

to thousands of cotton farmers who have been working hard to improve their crop management and increase their yield," he expressed.

Under this project, he informed that nine cisterns have been built in

the targeted areas to improve communities' access to water for household use and gardening.

He disclosed the donated agro implements as tractors, ploughs, planters, sprayers, harvesters, and ginning machines.

"These tools will help to mechanize some of the labor-intensive tasks in cotton production, such as land preparation, planting, weeding, spraying, and harvesting," he observed.

Nogueira expressed that despite being a strategic crop, cotton production and productivity in Tanzania has been crippled with numerous setbacks in recent years, such as poor agronomic practices, pests and diseases, low quality seeds and lack of access to markets.

"That is why the Cotton Victoria Project was conceived, to address these challenges and to enhance the competitiveness of the cotton sector with the production of a greater amount of high-quality cotton," he detailed.

Moreover, he added that the project also aims to improve the quality of cotton lint by reducing contamination and increasing efficiency in ginning.

"I hope that you will make sober use of these farm implements for effective and sustainability of the project's beneficiaries and partners in order to achieve the set objectives and outcomes, which are aligned with the national pri-

orities and policies of Tanzania in promoting agricultural development and food security," the Envoy added.

Dr. Geofrey Mkamilo, the Director General of TARI, who received the donation on behalf of the agriculture minister Hussein Bashe, hailed the Brazilian partners for their timely lucrative support.

He said the US\$5.8 million project, the Victoria Cotton Project, and Beyond Cotton Project, all under the financial auspices from Brazil have so far played a great role to heighten the performance of the sector in the country.

"The initiative has trained the cotton growers over recommended new planting space of 60 centimeters from row to row, and 30 centimeters from hole to hole, bringing the number of the cotton plants to 44,444 per acre from the formal 22,222 plants," Dr. Mkamilo detailed.

Dr. Paul Saidia, the Director of TARI Ukiriguru Centre, said apart from training, the ambitious project has been helping the cotton farmers to adopt modern agro machinery, the development which has so far scaled up their production and productivity.

The world's riskiest sovereign bonds are having a moment as Wall Street investors seek out high yields from countries showing early signs of market-friendly pivots.

Junk-rated government dollar bonds from El Salvador to Nigeria and Turkey are outperforming this month as money managers take on risky bets in exchange for outsized returns. The question now is whether orthodox policies can keep luring capital as major central banks reiterate their commitment to bring down inflation.

"There is still significant scope for these assets to rally," said Thys Louw, portfolio manager at Ninety One UK Ltd., referring to sovereign high-yielders. "But the next leg of the rally is likely to be tougher as there's still uncertainty with regards to how risk assets will handle continued tightening in global liquidity."

RUSSIA expects that an agreement on a free trade zone (FTA) between Iran and the Eurasian Economic Union (EAEU) will be signed before the end of the year. Deputy Prime Minister of Russia Alexey

"Now, indeed, the EAEU has come very close to concluding such an agreement with Iran. According to him, the EAEU is developing a number of FTA agreements with several more states, with which negotiations are also underway.

"[We are in talks with] Egypt, India, Indonesia, and the UAE. All these countries are friendly to us, they are growing markets, so respectively the economic center of the new multipolar world is moving in their direction," Overchuk said.

He drew attention to the fact that even in a bilateral format, negotiations on free trade zones are "very difficult, and they take years.'

"Negotiators need to take into account a lot of different interests. In our case, the interests of all five EAEU member states, their businesses and consumers are involved here. All this should be taken into account by our negotiators. This is a complex process," the deputy chairman of the Russian government concluded.

Member-states of the Eurasian Economic Union (EAEU) are Russia, Armenia, Belarus, Kazakhstan and Kyrgyzstan.

### Uganda ADF school attack: 'Gospel songs interrupted by screaming'

#### MPONDWE

PUPILS in Uganda were singing gospel songs before a deadly attack by Islamist militants on Friday, a woman who lives opposite the school says.

"Then I heard screaming," Mary Masika told the BBC. The vicious attack in Mpondwe left about 40 people dead.

Islamic State-linked militants have been blamed for the attack.

The Allied Democratic Forces (ADF) was created in the 1990s and took up arms against President Yoweri Museveni, alleging persecution of Muslims.

They are now largely based in neighbouring Democratic Republic of Congo

The Mpondwe Lhubiriha Secondary School attacked on Friday is close to the border.

Ms Masika says she and other residents have been left terrified by the attack which lasted about 90 minutes.

"I have been unable to eat or sleep since then," she told the BBC in Swahili.

The students usually sing before bedtime - and at first she and her daughter thought the noise that interrupted their songs at around 22:00 (20:00 GMT) suggested that they were having a bit of fun.

But it soon became clear that something horrific was under way at the school, which had around 60 boarders living in a small compound.

ADF rebels had entered dormitories, setting fire to them and using machetes to kill and maim students.

One family in Mpondwe held the funerals on Sunday for a father and son killed in the attack - 47-year-old security guard Elphanas Mbusa and 17-year-old Masereka Elton.

Their other son, 15-year-old Brian Muhindo who was also attending the school, is missing. They do not know if he is among the six boys kidnapped or one of those whose bodies cannot be identified because they have been so badly burned.

Hurubana Kimadi Onesmus told the BBC he found it difficult to understand how the attackers were able to infiltrate the school where his son, the security guard, worked and where his grandsons were studying.

"There is a very heavy military presence in the area," the 69-year-old said. Now there is a lot of security at the school - and the BBC team was given

only a few minutes to take some photos of the burnt buildings. It was a devastating and upsetting

#### scene.

Lots of dried blood is still on the ground outside the girls' dormitory - they had been attacked with machetes and others shot dead as they ran away.

The boys' dormitory had been locked they had either refused to open it to the rebels or they were locked inside by them. The militants poured fuel on the building

and set it alight. Inside, the smell of death is unmistakeable - beds have been reduced to wire mesh with pieces of flesh still stuck to them. Masika said towards the end of the attack, at around 23:30, she heard one of the assailants talking at her gate and asking a fellow fighter if "the job was done".

They were talking in Swahili - the lingua franca in the region - and afterwards began

shouting "Allahu Akbar" meaning "God is greatest". She said after these chants one of them added: "We have succeeded in destabilising Musev-

eni's country." In response, President Museveni vowed to send more troops to Rwenzori Mountains, which are along the border between Uganda and the DR Congo, saying: "Their action... the desperate, cowardly, terrorist action... will not save them.\*

The area around Mpondwe seems to be a mix of Christians and Muslims. Some of those attending the funerals on Sunday were dressed in traditional Muslim attire.

Other funerals for the pupils killed in the attack were held in villages across the region, with most people dumbfounded and pained by the brutality of the assault.

### Rwanda helps refugees beat adversity, forge paths to success

#### KIGALI

ESPERANCE Musanganire, a native of the Democratic Republic of the Congo (DRC). fled her war-torn homeland and arrived in Rwanda in 2012, in search of safety and a better future.

Despite numerous challenges facing refugees like her, Musanganire is determined to rebuild her life and contribute positively to her new community in Kigeme refugee camp, in Nyamagabe, a district in Rwanda's Southern Province.

Using savings from working at construction sites, she started with an initial capital of 20,000 Rwandan francs (about 17.6 U.S. dollars), selling sacks of Irish potatoes outside the refugee camp.

Her endeavors received a boost from "Jya Mbere," a Rwandan government proiect aiming to empower refugees by offering them the opportunity to start their own businesses.

Through financial assistance and permission to work, refugees like Musanganire are defying the odds and turning their lives around.With the support of "Jya Mbere," she was able to secure a loan of 4.8 million Rwandan francs from Inkomoko, an advisory firm and impact investor, after completing an entrepreneurship course.

She used the money to invest in plots of land outside the refugee camp." I am now the proud owner of a house constructed outside the refugee camp in Kamonyi district, Southern Province," Musanganire told Xinhua in a recent interview. The house she spent 14 million Rwandan francs to build is now rented out. Musanganire also owns to matching grants and set up businessa plot worth 7 million Rwandan francs in Gasabo, a district in Kigali, the Rwandan capi-

"Jya Mbere' played a significant role in assisting me by partially refunding the loan obtained from Inkomoko. This means a great deal to me. Despite (us) being refugees, this country has been kind to us, offering us hope and equal opportunities," she said. Musanganire now hires nine individuals, some at her hair salon, others at a restaurant. Four of them are fellow refugees.

Alain Gustave Ngwije, a Burundian refugee in Mahama, Kirehe district, Eastern Province, expressed his gratitude for the support he received.

The "Jya Mbere" project helped him take care of his family, he said, adding that he refugees from neighboring countries has been fortunate to have secured a job as a refugee."Living in a refugee camp is challenging, with hardships and inefficient services.

Without a job, life becomes even more difficult for refugees, presenting additional migrants evacuated from Libya living in challenges. However, through my role as an agronomist with Sabana farmers' coopera-Rwanda. tive, I help farmers enhance productivity by imparting knowledge on improved farm-

ing practices, such as the use of fertiliz ers," Ngwije said.

Jeannette Uwimana, acting project manager of "Iva Mbere," spoke of the generosity of Rwanda in hosting refugees and emphasized the shared basic services, such as water supply, education, healthcare access, markets, and roads that promote cohabitation and shared environments.

"Jya Mbere' was created to allevi ate the pressure that the presence of refugees puts on host communities. It provides access to finance for refugees and host communities through matching grants," she said."Capacity-building is a crucial part of the project, enhancing the entrepreneurial skills of refugees and host communities living together," Uwimana said.

Through the project, she said, the Rwandan government allows refugees to engage in business activities, leading to a significant number of successful refugee-run businesses in the country.

Musanganire's is one of the many success stories where refugees enjoy access es that also employ members of the host community."Jya Mbere," run by the Ministry in Charge of Emergency Management (MINEMA), is being implemented in six districts hosting refugee camps, namely Gatsibo, Gicumbi, Gisagara, Karongi, Nyamagabe, and Kirehe.

According to MINEMA data, as of May 31, 2022, Rwanda hosts a total of 127,369 such as the DRC and Burundi. There are also refugees from Afghanistan and

### Why BRICS membership appeals to more countries?

MORE countries are showing interest in joining BRICS, demonstrating their confidence in the group's capabilities to provide real developmental opportunities, Egyptian experts said.

On Wednesday, Russian Ambassador to Egypt Georgy Borisenko confirmed in an interview with Russian News Agency TASS that Cairo has submitted its application to join BRICS.

On Thursday, Algerian President Abdelmadjid Tebboune, during a meeting with his Russian counterpart Vladimir Putin in Moscow, called for an acceleration of Algeria's accession process to the bloc, Russian news agency Sputnik reported.

Also on Thursday, Syrian Finance Minister Kanaan Yaghi told Sputnik that Damascus intends to apply to join BRICS and the Shanghai Cooperation Organization.

On May 10, Naledi Pandor, South Africa's minister of International Relations and Cooperation, said many countries have shown interest to join BRICS.

According to media reports, those countries include Saudi Arabia, Iran, the United Arab Emirates, Bahrain, Argentina, and Indonesia. BRICS is an acronym of five major emerging market economies -- Brazil, Russia. India, China, and South Africa, whose leadership holds an annual summit since 2009 to discuss economic cooperation and political coordination.

This year's summit will be hosted by South Africa in August. Nourhan el-Sheikh, a professor of international relations at Cairo University, said BRICS is one of the most attractive international blocs to many countries."It pre-

sents equitable developmental opportunities to its members and has the ability to offset the negative influence of other international institutions that have drowned many countries into debts and exhausted others with tough conditions," el-Sheikh told Xinhua.

Waleed Gaballah, professor of financial and economic jurisdictions at Cairo University, said that BRICS has an international weight and a promising future in trade exchange and international cooperation.

Meanwhile, el-Sheikh said she has observed a certain arrogance and prejudice on the part of Western countries when they offer loans with political and economic conditions amid rising unilateralism and protectionism.

In comparison, BRICS is a very important mechanism that respects the special developmental experience of each country, she said. The political expert said that BRICS provides development tools based on partnership and joint growth, against the Western model that pursues its own interests while ignoring those of developing countries.

El-Sheikh said BRICS doesn't enforce a particular growth model or path, but rather leaves it up to each country to make its own choice in light of its special characteristics. BRICS will help to diversify those countries' partnerships and draw a big strategic balance in their policies, according to the political expert.

She lauded the BRICS suggestions of trading with local currencies, asserting that the U.S. dollar dominance is jeopardizing the world's economies as the United States has used its currency as "a tool for political pressure." "BRICS is a significant step for breaking the U.S. dollar hegemony," she Xinhua said.

### **Amrouche avoids criticism over** team selection in 1-0 home win

AIFA Stars head coach Adel Amrouche, and more so the leadership of the Tanzania Football Federation (TFF) have avoided a backlash from pundits and the fans over the way the senior national side was selected to face Niger in a vital home match of the Africa Cup of Nations Qualifiers.

Taifa Stars won 1-0 and thus sidestepped an already emerging undercurrent of dissatisfaction with the side, and controversy on the methods used.

It was unclear if the methods are either those of the head coach or those belonging to TFF officials, so to speak.

The impression that TFF sees the senior national team as a club that is run from Karume Stadium offices has always been visible as the organization is excessively involved with the selection, the planning, the tactics, etc, and at times one wonders what precisely is the role of the head coach.

At times he seems to be simply a spokesman for what TFF officials are doing, instead of pursuing his plan.

And the core of the TFF's official stance over Taifa Stars is visible all the time, in the idea of a project.

There is hardly a year that has passed without this project being repeated, though those efforts are less pronounced than in the past.

The TFF at a certain point used funds for soccer development to organize a nationwide competition, basically fielding schools and districts, to find talent for the senior national side.

It is what can be said to be alchemy, that there is raw talent out there that has not been noticed by clubs, and a place some aged ones and pro-

bring it up. It was a low point in professionalism.

At present, this method is being pursued differently, by trying to include regular players that are known to some key officials in the hope that in the future they will form a cohesive and well-drilled side.

Not frankly a bad idea but then there is an issue of technique, and that is where the fans come

The fans want the best players at that particular moment to be included in the national team, and the coach finds the right techniques to push the team to a win. It isn't a project but a method.

Some pundits have picked examples from far and near to show what one or other generation of players did for this or that national team, which is hard to pin down as valid.

The generation idea would empty the national side of veterans when they lose in a final or group stage, and start a project, instead of adding players to re-

tournament of that kind would ceed. The method of adding and subtracting players on the senior national side is permanent, and that is what the fans want to see.

Put differently, there are options in club soccer that a coach is allowed to work with but they don't apply to national teams, for reasons of intermittently playing together.

A senior national side needs to field a successful player where he plays, seeing the league involved is good enough for a national team player, and the whole idea of what sort of tactics the coach wants ought to be secondary. A national side coach has no time to teach a brand of football, just use ample talent.

Reports said that Amrouche wished Taifa Stars' first-choice goalkeeper Aishi Manula a speedy recovery, but then he proceeded to ignore the secondchoice goalie, Ali Salim, to go for well-known veterans who scarcely play for their clubs.

Goalkeepers picked are Beno Kakolanya (Simba SC), Metacha Mnata (Yanga), Zubeir Foba (Azam FC), and Vuai Makame (KMKM) whereas Salim won the

respect of the fans with his performance in the Simba SC final run of matches in the 2022/23 CAF Champions League.

How can TFF and the coach ignore this feat, including stopping penalty spot kicks, and pick four veterans except for the idea of a project?

There was an auxiliary problem of at least two noticeably good players that have not been playing in their clubs of late, which the then Taifa Stars' head coach Kim Poulsen ignored about Simon Msuva in the past.

Amrouche and TFF did not use that reasoning to include George Mpole (the previous season's Mainland Premier League top goal scorer now at Lubumbashibased FC Saint Eloi Lupopo) or Feisal Salum. It would be a matter of coach testing match fitness, not simple exclusion.

All this refusal to take heed of what the fans expect, that the best players will be there for the battle, pushed TFF to keep the squad under covers until a late hour as media outlets were demanding to know who is included.

Had the team failed to either score or win these issues would have come up strongly, but as the team won over Niger the omissions became irrelevant, and even appear to validate the project approach used. There were other players missing and complaints rising.

Nor was it clear what exposure means in enlisting players that the coach has no intention of using, as it isn't necessary to call 30 players to prepare for a match since the usual number is 18.

The higher number is applicable for registration of players for a season, and even then some get no room to play even as substitutes for the last 10 minutes and often seek other climes to get playing time.

Next time either TFF or the coach should call the 18 best players and let others prove their worth later.

### **US hero Balogun** tells Arsenal 'no more loans'

ARSENAL striker Folarin Balogun found the target as the United States won the CONCACAF Nations League on Sunday and then took aim at his club's hierarchy, saying he will not accept another loan move.

Balogun, who switched his national team allegiance from England to the US last month, spent last season on loan at French Ligue 1 club Reims where he impressed with 21 goals.

He further added to his growing reputation with a clinical strike on Sunday to seal a 2-0 win for the US against Canada, winning a medal in just his second game for his new team.

The 21-year-old said he now plans to take some vacation time but made clear he is not in the mood for another temporary transfer.

"What I can say is that I definitely won't go on loan again," he said.

"I'm not sure (about) the discussions that are going to take place, I'm not sure what's going to happen. But I'm just committed to now, I try to stay present. I obviously want to enjoy the moment with my team and my family," he said.

The New York-born striker moved to England aged two and joined Arsenal's youth system, spending a six-month spell on loan at Championship club Middlesbrough in 2022.

Despite his breakthrough season in France, he will face a tough battle to break into the starting line-up at the Emirates where Brazil international Gabriel Jesus is the first choice centre-forward.

Arsenal also have another promising young striker in Eddie Nketiah and that situation has led Balogun to be linked with European clubs such as Inter Milan and AC Milan.

Balogun's goal against Canada, where he latched on to a through ball from Gio Reyna and confidently fired home a first-time effort, crowned an impressive start to his life with the US team.

After making his switch in May, he joined the team in Los Angeles for a short training camp and then made his debut in a 3-0 win over Mexico on Thursday before Sunday's trophy success.

"It's amazing. It's amazing. I mean, it's a dream scenario for me," said Balogun.

"To be here now, the transition is amazing. I'm just overwhelmed with delight," he added.

The striker said he had been able to fit in quickly with his team-mates but said he had been impressed by the quality of the team he has joined.

### US surges past a rising Canada squad to capture another Nations League crown

### **Dutch footballer Promes** sentenced to jail for stabbing

#### AMSTERDAM

A DUTCH court sentenced former Netherlands international footballer Quincy Promes to 18 months in jail Monday for stabbing his cousin at a family party.

The Spartak Moscow forward, 31, who pleaded not guilty, was not in court in Amsterdam for the sentencing as he currently lives in Russia.

Promes stabbed his cousin in the leg at the end of a family birthday party in 2020 in a row over a stolen necklace, the court found.

Anyone convicted of the offence would normally get a sentence of at least a year but Promes got a heavier jail term because of his public profile, it said.

"The court took into account that the suspect is a professional football player and well-known Dutchman, and therefore has an exemplary function," the court said in a statement.

"The court also blames the suspect for not taking any responsibility for his act."

Prosecutors, who had demanded a two-year sentence, last year dropped a charge of attempted murder against Promes.

The investigation was triggered by a phone tap from a separate probe into a drug-smuggling case involving Promes.

Promes was charged in May with importing several hundred kilos of cocaine through the Belgian port of Antwerp in 2020.

Promes has been capped 50 times, scoring seven goals, and was part of the national team at the Euro 2020 championships, played in 2021 due to Covid, but has not worn the orange jersey since.

He joined Amsterdam's Ajax in 2019 from Sevilla in a 15 million-euro (\$16.4 million) transfer, before going back to Spartak in 2021, where he was named Russia's footballer of the year in 2017 during a previous spell. AFP
