Minister says police will ensure peaceful campaigns, voting

HOME Affairs minister George Simbachawene (pictured) yesterday warned political parties to ensure their aspirants vying for various posts in the forthcoming general election adhere to the country's laws and promote peace throughout the campaigns.

He directed the police force to ensure peaceful elections by taking stern action against anyone violating the law, ordering police officers at ward, district and regional level to immediately take action instead of waiting for orders from above.

Addressing delegates of the defence and security committee for Kigoma Region, the minister asserted that the police will take action against any candidate regardless of the political party he or she belongs. While in the region, the minister is expected to visit the various refugee

NSSF-financed Kigamboni road set for handing over

RESIDENTS of Kigamboni District in Dar es Salaam are joyous as the road that links the headland to the state-of-the art Nyerere Bridge reaches final stages.

Jenista Mhagama, the Minister of State in the Prime Minister's Office (Policy, Parliamentary Affairs, Labour, Employment, Youth and the Disabled) inspected construction work yesterday, declaring that the road will soon be open for use. The minister was accompanied by top officials

PM wants land surveyed to raise value, attract investors

Speaking in Ruangwa District, Lindi Region yesterday, the premier said it is easy to convince



investors to put up projects on surveyed land as opposed to parcels whose demarcations and ownership are not clear.

"Even when it comes to selling, those with surveyed plots stand a better chance of finding buyers than those with undocumented parcels," he said.

The premier made the call shortly after laying a foundation stone for a saw mill and furniture processing factories. He also inspected the construction of a cashew nut processing factory.

Majaliwa said the furniture factory is the first to be built in the district, urging residents of

LARGE tonnage ships from around the world have begun docking at the port of Dar es Salaam following the construction of modern roll on-roll off (ro-ro) terminal in the ongoing upgrade of the facility.

Touring the port yesterday, Works, Transport and Communication minister Isack Kamwelwe said this brings to an end the tedious process where large ships with cargo destined to Tanzania had to dock at the port of Mombasa for freight to be reloaded onto smaller vessels for Dar es Salaam port.

"We are going to save a lot of money by stopping transshipment. We have already received large ships from Europe and Asia," the elated minister noted.

The ro-ro terminal allows the docking of large tonnage ships carrying vehicles, which can be driven on and off the ship on their own wheels or using a platform vehicle. This is a shift from the port's lift off- lift on (lo-lo) model, which mostly used cranes thereby limiting its capacity and efficiency.

Kamwelwe said that works to deepen the port's berths from eight metres to 15

was going on well, affirming that when completed, the port of Dar es Salaam will serve as a strategic facility for regional trading blocs.

"When the ongoing expansion works are completed, our vehicle storage capacity at a go will increase from the current 170,000 units to 300, 000," he stated.

Tanzania Ports Authority (TPA) Director General Deusdedit Kakonko said the number of vessels docking at the port per month has increased from 180 at the end of last year to 250.

In his 2017/18 budget proposals, Finance and Planning Minister Philip Mpango scrapped value added tax on transit goods. The move was intended to win back importers from landlocked countries who saw this tax as an additional cost to their business.

Under the port upgrade contract, which is funded by a World Bank loan, the construction of the ro-ro terminal will come along with the ongoing deepening of Dar es Salaam port's seven berths in order to accommodate larger container

'Mozambique strong enough to fight terrorism'

THE Mozambican state is strong enough to fight against terrorism in Mozambique, particularly in the northern province of Cabo Delgado, where a jihadist group with ties to the self-styled "Islamic State" is operating, declared Defence Minister Jaime Neto on Thursday.

Speaking at a Maputo press conference with Interior Minister Amade Miquidade, Neto said that the foreign aid Mozambique needed is surveillance of the borders "to prevent bandits from entering our territory".

He denied that the terrorists have effective control over the town and port of Mocimboa da Praia. What had happened, he claimed, was that terrorist groups had infiltrated some neighbourhoods in the town.

They had slipped into the town disguised as civilians, and Neto admitted that they had received support from some of the local population. Then, from positions inside the town, they attacked the units of the defence and security forces stationed in Mocimboa da Praia.

"The result was the vandalisation of the infrastructures of Mocimboa town", said Neto. "Right now the defence and security forces are trying to control the situation. The situation remains tense and fluid, and the entire Mozambican state should be committed to normalising the lives of people who have been so devastated by terror".

He stressed that the Mozambican forces "have shown courage, a spirit of sacrifice and combative morale".

But despite all the efforts of the government's forces "the bandits are there", Neto admitted. Despite the losses they had suffered, in clashes with Mozambican naval forces, the terrorists were still in Mocimboa da Praia port, and had received reinforcements in men and material from bases outside Mozambique. If true, these reinforcements could only have reached Mocimboa da Praia by sea, and presumably from Tanzania (although the Tanzanian armed forces

say they have launched an offensive to drive bandits out of forested areas on the border with Mozambique).

Neto guaranteed that every effort will be made to ensure that all of Mocimboa da Praia town is liberated. He said the Mozambican state will take all necessary measures to ensure that the situation in the northern districts of Cabo Delgado is not repeated anywhere else in the country.

The government's forces will continue to defend Mozambican sovereignty, he pledged, and would fight to prevent Cabo Delgado becoming "a generalised stage of disorder, chaos and the violation of the most elementary human rights".

Fighting has been going on in and around Mocimboa da Praia since 6 August. Piecing together reports from various sources, it seems that the Mozambican forces were obliged to retreat when they ran out of ammunition.

Miquidade ruled out declaring a state of siege in Cabo Delgado. "We're not even close to declaring a state of siege", he told the reporters.

"Fighting is going in various parts of Mocimbioa da Praia and in surrounding areas", he said, but the scenario was not such as to justify declaring a state

commendable standards."

Namkonjera and surrounding villages to make the most of it by supplying it with raw materials.

"These two factories will promote agriculture and use of products of forest conservation. The presence of the factories will enhance the cashewnut value chain, enabling Ruangwa to be a leader in cashewnut production," he said, pointing at the need to establish factories to process sesame, green peas and other crops cultivated in the region.

Ongoing investment in Lindi Region goes hand in hand with the government's commitment to establish and develop industries to boost the economy, ensure sustainable development and reduce poverty among the people, he stated.

In five years, the government has succeeded to strengthen the economy especially industrial production where a total of 8,477 new factories have been built,, he said, noting that this has increased employment opportunities with 482,601 school leavers and graduating youth getting direct and indirect jobs.

Industrial sector contribution to national income has been rising annually to 8.5 percent in 2019 from 8.05 percent in 2018. In 2019 where commodities worth 10.2trn/- were manufactured, from 9.6trn/-worth of such goods a year earlier.

Earlier, Agriculture Deputy Minister Omar Mgumba linked successes in the industrial sector with President John Magufuli's supervision of the ruling party's 2015 election manifesto.

The government is determined to promote and expand cashew nut farming to one million tonnes by 2025 from the current 300,000 tonnes, he said.

Ruangwa District Commissioner,

Hashim Mgandilwa commended the investor- Orascom Construction and Engineering Company (T) Ltd for the ashew nut processing factory as it will boost the local economy and improve the education sector.

"Investors should prioritize giving back to the community," the DC emphasized.

Orascom (T) executive director, Magira Masegesa said construction of the factory is a joint venture project between Orascom and city-based firm, Yukos Enterprises.

He said they have so far employed 150 people Tanzanians, with the manufacturer putting out low cost furniture.

"We have injected 5bn/- in the first phase which includes purchasing of raw materials, log harvesting and processing machines. The factory's capacity is to process logs measuring 10,000 meters per year," he said.

"We have also injected 5bn/- in the first phase construction of the cashew nut processing factory," he elaborated.

Revenue statistics show that 204,500 tonnes of cashew nuts were exported during August, September and October 2019, from 225,000 tonnes collected.

A report by the Cashewnut Board of Tanzania (CBT) states that cashewnut farmers earned 484.756bn/- from 181,273.23 tonnes of raw cashewnuts during the period from October 31, 2019 to December 22, 2019.

With 17 per cent of the world population, Africa has about five per cent of confirmed cases and three per cent of deaths. With population considered, the continent also has the second-lowest rate of death of 19 deaths per one million people, which is about 34 times lower than North America's, the region with the highest rate.

Minister orders arrest of REA's contractor for Monduli District

minister Dr Medard Kalemeni has instructed the directors of both the Tanzania Electric Supply Company (Tanesco) and Rural Energy Agency (REA) to revoke the contract agreement with Nipo, the contractor given the tender to supply electricity in 67 villages of Monduli District in Arusha Region.

Dr Kalemeni also directed the defence and security organs to arrest and interrogate the director of Nipo over expenditure of project's funds.

The minister issued the directive at the weekend moments after he inspected the implementation of REA project at Lendikinya village in Monduli District.

He also instructed the District Commissioner to arrest and interrogate

the company's agent for failure to and award tenders to contractors frame.

"Arrest the agent of the contractor as you continue looking for the managing director, question them about the funds provided by the government as the project had stalled for a long time now," he said.

Dr Kalemani also instructed Tanesco Arusha regional manager to remove the engineer who was supervising the project for failing to do his job as required.

He gave 14 days to the newly appointed Tanesco engineer to ensure the project is completed in time, else he will also be removed like his predecessor.

Dr Kalemani also called on directors of Tanesco and REA to abide by procedures governing procurement

complete the project within the time with the necessary qualifications for the job.

He also instructed the officials to deduct 10 per cent from the contract costs so as to pay the new contractor to do the job.

He also told them to make sure by September, this year 67 villages in Kilimanjaro Region and five in Monduli District get electricity.

During his visit Dr Kalemani was accompanied by the high profile officials of the ministry including Tanesco's managing director, REA director and managers from the northern zone.

Mondulki District Commissioner Edward Balele said implementation of the project began in 2018 and had stalled for the past three months.

"After completion of the research, the government will announce new rules and regulations, so I am providing a grace period for the fishermen to continue using generators. The aim to come up with new fishing light is to ensure that we allow fishing activities to continue but also projecting marine resources for the suitable development," he said.

The minister wanted the fishermen to ensure that the value the interests of the current generation but also think also on the future generation.

He also commended the ministry for setting aside 1.7bn/- for the improvement of the Ferry fish international market, something which will also improve service provision in

For his part, Feisal Ali, the secretary of the small-scale fishermen union also commanded the minister for allowing the use of generators during the transition period.

"We also hail the government for allowing us to use one licence to conduct fishing activities in the Indian Ocean, previously we were forced to have licence in every district council that we go to fish, this is a huge relief to us as it will allow most of the fishers to invest in their work and reap big to improve their income and the country's development," he said.

Feisal also commended the government for reducing export levy for small fish from US\$1 to US\$0.16 under the newly released regulations.

"We real also commend the government for reducing expenses of the export license for fishing products from US\$2,500 to US\$250 per year, this is a great step in the sector," he added.



Fuel sector must end smuggling, arbitrage

IMBABWE petroleum sector pricing policies, financing, supply chains and stock accounting need to be fixed quickly to prevent the growing risks of smuggling, arbitrage and deliberate defiance of foreign currency pricing

Opportunities abound for dishonest profiteering and smuggling, yet it would now be relatively easy, thanks to the reforms of the monetary systems, to fix many of the problems in a way that makes it impossible for further cheating with very little pain to the ordinary consumer.

Smuggling is a problem, and has been a problem. We are now getting reports that fuel is even being double smuggled, with corruption extending across three countries.

It is now believed there has been a smuggling ring buying fuel in Mozambique, escaping Mozambican duties and Zimbabwean duties when smuggled into Zimbabwe and then avoiding South African duties when smuggled down south and sold there through criminal channels to dubious service stations and other users.

This was only caught when customs officers working for Zimra actually examined tankers bringing in soya bean oil and finding that the contents were petroleum fuels. How many other tankers of soya oil had come in with the wrong contents is anyone's guess, with the only certainty that the caught tankers were not the first.

In the second half of 2018, when Zimbabwe's official exchange rates

were so far below reality, there was a huge jump in fuel purchases in Zimbabwe, with no corresponding increase in vehicle traffic.

The only explanation was that wellorganised rings were buying large quantities of fuel in Zimbabwe dollars and smuggling it into neighbouring states where they were selling it for foreign currency. That was fixed by a one-off jump in

local pricing using the excise duties, but a similar temptation must have been building up during the first half of this year, with the huge premiums on the Zimbabwean black market in foreign exchange.

And even now, there are sharp differences in prices according to the formulas set by energy regulator Zera between directly-imported fuel sold in US dollars and fuel sold in local currency.

Part of that gap is explained by different tax rates, but even with the intensifying competition in the US dollar market pushing down US dollar denominated prices, there is still a practical gap of 12.5 percent even when auction rates, rather than black-market rates are used.

The possibilities for arbitrage obviously exist, with fuel bought for Zimbabwe dollars being sold in US dollars. We do not know if checks are being made and, in any case, it is very difficult to look at a litre of petrol and decide whether it was imported by the central import system or as a private import.

There are obviously several steps that can be taken to eliminate smuggling, eliminate arbitrage, and rationalise the

whole system so that in the end it will not matter what currency is used.

Smuggling can be eliminated by simply checking the contents of every tanker entering Zimbabwe that could be carrying fuel, regardless of what the paperwork savs.

A good sniff would work. Secondly Zimbabwe is not a fuel exporter, so no tankers of fuel should be going out over

Fortunately, tankers need to use proper roads and bridges: they cannot be smuggled over mountain paths or rafted across rivers. So checking the contents of every vehicle that could be carrying bulk fuel is simple and possible.

If there is a desire to retain the present dual system of fuel imports, then legislation already exists to force all fuel to be stained.

There is even provision for the cost of staining in the price formulas. This would at least stop green coloured Zimbabwe dollar fuel being sold in foreign currency, and pumps of US dollar service stations should be delivering red.

And if anyone is selling brown fuel we know someone is mixing the two supplies.

But with the success of the auction system set up by the Reserve Bank of Zimbabwe, perhaps the time has now come to move the financing of fuel imports out of direct RBZ allocations and put it through the auctions, the oil companies having to join other bidders while the RBZ moves what it allocates from the reserves to the auctions.

With the process of price discovery now almost complete, with gaps of

less than 10 percent between top and bottom successful bids and an even narrower gap for more than 90 percent of trading, oil companies should be able to get their bidding fairly accurate.

Zera could continue enforcing a pricing formula, and basing this on the average weighted rate to encourage oil companies to bid very tightly indeed.

At the same time the tax structure could be modified to make taxes equal, regardless of currency, and then the Government and the RBZ would need to enforce the recent rules of dual pricing using the auction rate, with the motorist queuing for fuel having the option which one to use.

That change and that enforcement would be necessary because otherwise the higher profits inherent in the formulas for directly imported fuel would encourage cheating.

To make matters move more smoothly, we cannot see any problem with major exporting companies with large nostro balances being allowed to hire an oil company to import their fuel, with the nostro holder paying the landed cost in foreign currency.

This would simply stop large monthly fuel orders causing unnecessary strains in the auctions.

There might be many other ways of bringing fuel into the increasingly normal Zimbabwean economy. Certainly at the moment it is easily the largest sector still in theory under the old systems, with the recent addons possibly causing more problems than they solve, and certainly opening the doors to arbitrage, cheating and

smuggling.

The shameful, barbaric and inhumane lynching must stop. We are in the 21st century please

ast week, the entire nation was thrown into a state of shock by another gruesome murder, this time, the lynching of a 90-year-old woman Akua Denteh at Kafaba, in the Savana Region.

The woman was accused by fellow women of witchcraft. In the video widely circulated two women were seen shamefully and unspeakably molesting the woman that nature has blessed with long life. A fetish priestess is reported to have identified her as the cause of woes in the town and therefore paraded the fragile woman before a huge crowd and subjected her to severe molestation and beating which resulted in her untimely death.

The incident has sparked off a huge public sphere and a wide-spread condemnation from across the country. Former Presidents John Mahama and John Rawlings, Government and officials as well as Civils Society Organisations and individual women advocates and activists have condemned the wicked and barbaric acts.

The president of the land, Nana Addo Dankwa Akufo Addo has in no uncertain terms condemned the action of the people who committed the atrocious crime against the 90-year old woman. Until quite recently, Women of ancient Africa often led powerful, spiritual, and traditional roles that garnered them respect and admiration from society. In our traditional parlance, when there was a very difficult situation, the community runs to the old woman Old women took on positions as oracles, spirit mediums, seers, and advisors,

Each voice such as the Minister for Such Gender, Children and Social Protection, Cynthia Morrison, has condemned the lynching and demanded an "immediate investigations and prosecution of all the perpetrators of this gruesome murder in accordance with our laws." Others have also called for justices and in some cases, suggestion means to help eradicate these primitive acts in this 21st century.

Local and international media reports on the case suggest that this practice is prevalent in the Northern part of Ghana and currently there are hundreds of women accused of witchcraft by relatives or members of their community are living in 'witch camps' after fleeing or being banished from their homes.

It is believed that there are around 800 women in these camps who live under very poor conditions and have little or no hope of a normal life. These women have fled discrimination, threats, or even mob justice as has happened to the innocent Akua Denteh.

This woman is not the

first victim and perhaps would not be the last if this is not checked. Several women have been murdered in similar wicked circumstances. At least we recalled the mother of three who was beaten and set on fire after being blamed for making a child sick through witchcraft some six years ago. In 2010, the case of a 72-year-old woman who was also set on fire and killed made headlines around the world.

In some of these unfortunate incidents, women are the most vulnerable, does of a witch in fiction. for advice and direction. that depict that women are the only people in this world who are witches?

PEPFAR activities are conducted in close collaboration with the Tanzania Ministry of Health, Community Development, Gender, Elderly and Children; and the President's Office of the Regional Administration and Local Government (PORALG), through the Regional and Council Health Management Teams.

Working together, the Southern Highlands Program (SHL) currently supports 177,380 people on antiretroviral therapy (ART), and nearly one million people have received counseling and testing services. WRP-T has enrolled more than 51,000 adolescent girls and young women in Tanzania into the DREAMS program, keeping them Determined, Resilient, Empowered, AIDS-Free, Mentored, and Safe. SHL supports more than 373 health facilities in Mbeya, Rukwa, Katavi, and Songwe regions. These collectively represent a catchment area of about 5, 200,00 million people. The TPDF Program supports 22,000 clients across 47 Military (TPDF) health facilities in both Tanzania mainland and Zanzibar, eight of which are zonal hospitals.

In October 2015, the World Health Organization supplied guidance on what it calls the treat-all approach in which they recommended antiretroviral therapy (ART), for everyone living with HIV regardless of the CD4 cell count, generally known as Test and Start; this approach initiates patients on ART straightaway after an HIV-positive diagnosis in an effort to improve health outcomes¹.

Aiming to achieve the UNAIDS 90-90-90 targets, countries intensified their efforts focusing on high HIV burden areas². Tanzania adopted the Differentiated service delivery models (SDM) to address the UNAIDS targets. The SDM allows stable clients to come to clinics less often than others for drug pick-ups and other consultations. HJFMRI/WRP-T introduced the model in May 2018. Some of the essential aspects that pose challenges and need to be addressed in the face of SDM implementation include management of client's appointments, monitoring of HIV viral load, and ensuring drug adherence.

The plan is to build a scalable SMS reminder platform that will address the challenges above and the evolving needs of the program. Observations noted include the fact that some of the clients miss their appointments because they forget the appointment date/day, while some forget to ask for their lab results during their appointment. Furthermore, sometimes results are missing from patients' files, so clinicians let them go without proper counseling, while lab results are already at the facility.

he early stages of the COVID-19 pandemic have been linked to a "wet" market in Wuhan, in the Hubei province of eastern China. Wet markets are common in Asia, Africa and elsewhere, selling fresh fruit and vegetables, poultry, fresh meat and live animals, including wildlife. Reports initially indicated that the coronavirus which causes COVID-19 may have been transmitted to people from wildlife at this wet market because of unsanitary conditions.

The pandemic has led to some wildlife conservation organisations to call for blanket bans on wildlife trade on public health grounds. They include bans on commercial trade in wildlife for human consumption and calls from 200 organisations to close down live wildlife markets. More extreme calls include ending the keeping, breeding, domestication and use of all wildlife, which also covers traditional medicine.

But blanket bans are unlikely to benefit people or wildlife, and are unfeasible because they overlook the complexity of the wildlife trade. The COVID-19 outbreak should not be used opportunistically to prescribe global wildlife trade policy. A more appropriate response would be to improve wildlife trade regulation with a direct focus on human health.

Wildlife is used globally on a daily basis, from medicinal plants and edible fungi, to wild meat in Europe, North America,

Bans are seldom the answer Unquestionably, wildlife trade regulations require review in response to COVID-19 for public health reasons. ty. Typically, prohibition does not deter all traders in marketplaces. This would mean that trade in some products would likely continue illegally. Traders would be motivated by financial profits, with an increased risk of trade being controlled by organised crime.

Bans may not stigmatise consumption either, especially where products are socially desirable, meaning consumer demand for many products would persist. This is a public health concern because, unregulated, such trade would

likely be clandestine and, if unsanitary, could pose the risk of transmitting disease from animals to humans. Bans, especially where they remove legal supply options, such as captive breeding, could raise perceptions of scarcity, and drive up black market prices and increase incentives for poaching. This could accelerate the exploitation and extinction of species in

the wild. The outcome for wildlife economies would also urgent priorities.

be uncertain. For example, the wildlife "breeding economy" in China is estimated to involve 14 million people and be worth more than US\$74 billion annually. The fate of animals under human care and the people employed in these industries would require consideration. In China, bamboo rat and badger farmers are to be compensated and given grants for new businesses following the closure of almost 3,000 farms in response to COV-

To be effective, bans would need to be largely in step with local social norms and well enforced. But this is unrealistic in many parts of the world where law enforcement is cripplingly under-resourced in terms of technology and manpower. Local people may also challenge the legitimacy of any bans. Requiring agencies to enforce comprehensive bans in these circumstances would most likely overwhelm them.

Even where there are strong laws and enforcement, implementation is challenging and illegal trade still occurs frequently, such as the harvesting and trafficking of the European eel in Europe. It is also unlikely that law enforcement would receive the financial investment necessary to enforce bans in the long term, due to political constraints on spending and other more Better regulated trade

Banning all wildlife trade is a knee-jerk and potentially self-defeating measure. A more appropriate response would be improving regulation of wildlife markets, especially those involving live animals. This should include full consideration of public health and animal welfare concerns to ensure there is low risk of future animal-to-human disease outbreaks.

This could be achieved by focusing on highest-risk species and improving conditions along supply chains and in markets, such as health and safety and sanitation, and regular animal health checks. These practices could draw on existing standards that apply to regulations for transporting live animals by air.

Like bans, any new or revised regulations would require enforcement. But approaches such as "smart regulation" could be used to aid the process. This could ensure that new measures are culturally appropriate and incentivise local people, traders, buyers and law enforcement agencies to comply. Devising regulations in this way would mean they are more likely to be effective, rather than undermined which a blanket ban would do.

Rushing to indiscriminately ban all wildlife trade in response to COVID-19 would not eradicate the risk of animal-to-human disease outbreaks. It could also have a severe impact on livelihoods and biodiversity. Improved regulations that focus on health, if implemented well, would avoid these effects while ensuring a low risk of future disease outbreaks.

Addressing members of the Tanga Dairies Cooperative Union (TDCU) here, Mpina wanted the cooperative union to be established and start operating by October, this year.

"Through their union, TDCU has been able to get modern dairy farming equipment as well as a loan amounting to 236m/- from TADB, this a very huge step, so if a national union for livestock keepers will be formed, then, majority of our pastoralists will reap big from their activities," he

He directed the ministry department of research, training and extension in collaboration with the Private Sector's desk, Tanzania Dairy Board (TDB), Tanzania Meat Board (TMB) and Heifer International to form a special task force which will supervise the establishment of the union.

"The union the pastoralists' cooperative union will bring together all pastoralists, including those faring goats, sheep, dairy cows, beef cattle, poultry, pigs, dogs, donkeys, rabbits. This will enable them to have a common voice and be able to benefit from various things including training,

credit and marketing of the products they produce," he noted.

During his meeting with the management of Tanga Fresh and TDCU, Mpina urged them to prepare a strategic plan so as to purchase modern dairy farming equipment so as to increase milk production from the current 40,000 litres per day to 120,000

"The ministry's director of production and marketing in collaboration with the dairy board, TADB and Heifer International should sit down and form a joint task force and submit to the ministry a report on how to start importing the best dairy farming plants which will be distributed to various dairy cattle farmers in the country. This should be done within one week," Mpina emphasized.

For his part, TDCU chairman Hamid Mzee commended the government for taking various efforts to support Tanga Fresh Company as it was facing several challenges.

"We really appreciate the government's support, the factory almost died due to various conflicts but the government rescued it, we have been benefiting from various services including loans from TADB," he said.

Japhet Justine, TADB director said that the bank has supported the union with loans totaling 236m/- pledging to continue supporting the farmers.

In his remarks, Tanga Fresh managing director Innocent Mushi commended the government's move to support the factory saying that they continue working closely with farmers to ensure that they increase production of milk for their development.

The same healthcare sector and environment that should be improved to handle Covid-19 is fraught with corruption and malpractice in the procurement and supply personal protective equipment (PPE). The new emergency Covid-19 procurement approach is doing more harm than good. This is the harm that Corruption Watch, in April, warned the National Treasury about.

Corruption concerned about the potential of looting corruption under a procurement system that is an exception to the obligations in terms of section 217 of the Constitution. Section 217 requires state procurement to be fair, equitable, transparent, competitive and cost-effective.

"Given the rampant corruption that has characterised procurement, procurement under the emergency instructions must subject to tight scrutiny," said Corruption Watch's David Lewis. Speeding up the procurement processes created a fertile ground for corrupt opportunists.

Allegations abound of the abuse of power for private gain, and public loss resulting from suboptimal decisions in procurement choices or nefarious overspending on project implementation. The truth is that South Africa is in the belly of the beast of corruption. and our leaders are falling to corrupt activities like dominoes instead of being at the forefront of taming the beast. Government officials, politicians and high-ranking members of the African National Congress (ANC) are said to be wallowing in the benefits of the sea of Covid-19 corruption.

"One of the shameful achievements of the African National Congress in its 25 years of governing post-apartheid South Africa is that it's living up to the political stereotype of what is wrong with postcolonial Africa - unethical corrupt African leaders who exercise power through patronage," as Mandisi Majavu wrote in The Conversation.

The allegations Covid-19 corruption are mounting. A report last week in Daily Maverick alleged that "the Free State provincial treasury has awarded contracts worth R2.7-million to the sons of ANC secretary-general and former Free State premier Ace Magashule". How to tame the Covid-19 corruption beast?

are a few Below interventions I propose:

First, let there be no holy cows in the application of the law and justice.

This intervention has been much talked about by our public officials. For instance, it was reported by Daily Maverick in 2018 that Nhlanhla Nene, then reappointed finance minister, declared that there would be no holy cows in the fight against corruption.

The government has declared that combating corruption is a national priority, while acknowledging that "corruption in both the private and public sector has a detrimental effect on the government's effort to deliver effective services to the people".

There is one problem though: in law, we often talk of appreciation of the status of things and acting with such appreciation. Unfortunately, Covid-19 tender scandals have shown that the state and our leaders are failing to act in accordance with the ill of corruption in Zondo Commission being and prosecution of those among their ranks. To refer to the ANC

spokesperson, Pule Mabe, money and other resources answering questions about out of the public purse, Ace Magashule's sons' Covid-19 contract - not that I believe him - "we won't tolerate any looting of public resources". Not believing him stems from taking the easy way out of challenging "anyone to go and lay charges if the matter is criminal". The "no holy cows" approach to fighting corruption means that the government and leaders of political parties cannot cling to the comrades-in-arms mantra as an excuse not to abhor corruption.

Instead, they must send a clear and strong message against kleptocrats their ranks. This entails supporting the law enforcement agencies in their investigations and allowing the National Prosecuting Authority (NPA) to conduct the prosecution of members of the political elite or their families and acquaintances.

But, again, not much can be written home about our law enforcement agencies, which are captured by politicians and have a fetish for low hanging fruit (an example is the Hawks jumping to investigate the Masondo and Gigaba stories, contrary to its real mandate of combating organised crime).

Third, implement the country's anti-corruption laws indiscriminately.

South Africa is not short of legal and regulatory frameworks to deal with corruption relating to the procurement of medical supplies and PPE. Since price gouging or price inflation in the provision of PPE may give rise to criminal and civil liability, use of this legislation will set a firm precedent for asset forfeiture orders against the corrupt.

The Prevention Combating of Corruption Activities Act of 2004 contains clear provisions on how to deal with active and passive corruption. Nothing prevents the NPA from using this act to deal with cases of corruption and bribery, including fronting, kickbacks, and brown bags or underthe-table payments to

Further, under-thetable payments made to government and public officials who rigged Covid-19 procurement contracts attract evasion laws. South Africa's organised crime and anticorruption legislation imposes severe criminal and civil penalties on offenders. Yet, for some reason, there is always an excuse given to avoid enforcing the legislation against corrupt figures.

Fourth, reimagine our procurement processes and measures.

A study by PwC on Identifying and Reducing Corruption in Public Procurement in the EU, prepared for the European Commission, noted what has been done across the EU to prevent corruption in public procurement. "[A]dministrative data on tenders, bidders, projects and contractors collected and stored in a structured way, accessible for controls, investigations and analyses," states the report.

Fifth. maintain transparency rules during public emergencies.

In light of section 217 of the Constitution, public procurement is generally presumptively fair and transparent. The reason is simple: public money is being spent and taxpayers have a right to know how their money is used, even during a Covid-19 emergency. Exemptions from transparency in public procurement during Covid-19, if maintained, should be properly managed. Public procurement transparency is a critical anti-corruption mechanism, even under normal circumstances.

president Cyril Ramaphosa's despatch of envoys to Zimbabwe in a bid to defuse the latest crisis, in which the government has engaged in a vicious crackdown on opponents, journalists and the freedoms of speech, association and protest, has been widely welcomed.

Such has been the brutality of the latest assault on human rights by President Emmerson Mnangagwa's regime that something had to be done. And, as the big brother neighbour next door, South Africa is the obvious actor to do it.

It may be guaranteed that Ramaphosa's envoys - Sydney Mufamadi, a former government minister turned academic, and Baleka Mbete, a former deputy president of South Africa, former speaker of the National Assembly and former chairperson of the African National Congress (ANC) - were sent off to Harare with a very limited brief. They were accompanied by Advocate Ngoako Ramatlhodi and diplomat Ndumiso Ntshinge.

The mission quickly ran into trouble. The envoys returned to South Africa without meeting members of the opposition.

Observers and activists are rightly sceptical about how much will come out of it. The best that is seriously hoped for is that South African diplomacy will bring about immediate relief. This would include: the release of journalists, op-

position figures and civil society activists from jail; promises to withdraw the military from the streets; perhaps even some jogging of the Mnangagwa government to meet with its opponents and to make some trifling concessions.

After all, the pattern is now well established: crisis, intervention, promises by the Zanu-PF regime to behave, and then relapse after a decent interval to the sort of behaviour that prompted the latest crisis in the first place.

But in a previous era, South Africa once made Zimbabwe's dependence count.

South Africa has done it once Back in 1976, apartheid South Africa's Prime Minister John B. Vorster fell in with US plans to bring about a settlement in then Rhodesia, and hence relieve international pressure on his own government, by withdrawing military and economic support and closing the border between the two countries.

Ian Smith had little choice but to comply. Today, no one, not even the most starry-eyed hopefuls among the ranks of the opposition and civil society in Zimbabwe, believe that Ramaphosa's South Africa will be prepared to wield such a big stick. The time is long past that Pretoria's admonitions of bad behaviour are backed by a credible threat of sanction and punishment.

So, why is it that Vorster could bring about real change, twisting Smith's arm to engage in negotiations with his liberation movement opponents that eventually led to a settlement and a transition to majority rule, and ANC governments from the time of Nelson Mandela onwards - have been so

If we want an answer, we need to look at three fundamental differences between 1976 and now.

First, Vorster was propelled into pressuring Smith by the US, which was eager to halt the perceived advance of communism by bringing about a settlement in Rhodesia which was acceptable to the West. In turn, Vorster thought that by complying with US pressure, his regime would earn Washington's backing as an anti-communist redoubt. Today there is no equivalent spur to act. It is unlikely that US president Donald Trump could point to Zimbabwe on a map.

Britain, the European Union and other far-off international actors all decry the human rights abuses in Zimbabwe. But they have largely given up on exerting influence, save to extend vitally needed humani-

As the leading liberators of their respective countries, they believe they represent the true interests of the people. If the people say otherwise in an election, this can only be because they have been duped or bought. It cannot be allowed that history should be put into reverse.

Former South African president Thabo Mbeki played a crucial role in forging a coalition government between Zanu-PF and the opposition Movement for Democratic Change (MDC) after the latter effectively won the parliamentary election in 2008. But South Africa held back from endorsing reliable indications that MDC leader Morgan Tsvangirai had also won the presidential election tion. But we have been against Robert Mugabe.

As a result, Tsvangirai was forced into a runoff retreated into irrelevance, presidential contest, supposedly because he had won less than 50% of the poll. The rest is history.

Zanu-PF struck back with a truly vicious campaign against the MDC, Tsvangirai withdrew from the contest, and Mugabe remained as president, controlling the levers of power. PF governments have become increasingly militarised. Mnangagwa may have put his military uniform aside, but it is the military which now calls the shots. It ultimately decides who will front for its power. There have been numerous statements by top ranking generals that they will never accept a government other than one formed by Zanu-PF. The African Union and Southern African Development Community have both outlawed coups, but everyone knows that the Mnangagwa government is a military government in all but name.

Lamentably inadequate So, it is all very well to call for a transitional government, one which would see Zanu-PF engaging with the opposition parties and civil society and promising a return to constitutional rule and the holding of a genuinely democratic electhere before.

The fundamental issue is how Zimbabwe's military can be removed from power, and how Zimbabwean politics can be demilitarised. Without the military behind it, Zanu-PF would be revealed as a paper tiger, and would meet with a heavy defeat in a genuinely free and fair election.

According to Ibbo Mandaza, the veteran activist and analyst in Harare, what Zimbabwe needs is the establishment of a transitional authority tasked with returning the country to constitutional government and enabling an economic recovery. Nice idea, but a pipe dream.

No one in their right mind believes that a Ramaphosa government, whose own credibility is increasingly threadbare because of its bungled response to the coronavirus epidemic, its corruption and its economic incompetence, has the stomach to bring this about. We can expect fine words and promises and raised hopes, but lamentably little action until the next crisis comes around, when the charade will start all over again.

Any relief, any improvement on the present situation will be welcomed warmly in Zimbabwe. But no one in Harare - whether in government, opposition or civil society - will really believe that Ramaphosa's increasingly ramshackle government will be prepared to tackle the issue that really matters: removing the military from pow-

Taxi-motos go digital, here are five things you should know

KIGALI

tarting Saturday, August 15, taxi motos will phase out cash based payment and adopt digital payment platforms. All passenger motorcycles will be required to have a smart meter, which determines how much a client pays.

The GPS-enabled meter will allow three different modes of digital payment: MTN Momo Pay, Airtel Money and Tap&Go cards. As of Friday August 14 at least 21,600 of the estimated 26,000 taxi moto operators in Kigali had bought the taximeters, according to Rwanda Utilities Regulatory Agency (RURA).

There are about 46,000 grouped in 146 cooperatives, which are grouped under their Federation, FERWACO-

TAMO. Three companies, namely AC Group, Pascal Technologies and Yego Moto were authorised by RURA to power the fleet of motorcycles with the tech-

The move is seen as a game-changer in Rwanda's ambitious plans of becoming a digital economy and establishing smart cities. As the move is being implemented these are some of the things that you know about it.

The decision to modernise the sector was approved by the cabinet in July last year. It is part of the national motorcycle transport strategy intended to set up digital payments system, following the success story on public buses with Tap and Go cards. According to AC Group, there are about 2 million Tap & Go cards in circulation in Kigali.

"Kigali is a smart city," said Anthony Kulamba, Head of Transport Division in RURA, referring to the transformation journey from messy mini-buses to enormous, cashless commuters dedicated to different zones. To him, the GPS-enabled devices will provide RURA with accurate data, which will inform decision making on industry policy. "Data is wealth," he adds.

The importance of data was reiterated by Malik Shaffy, Chief Operations Officer of Tap & Go Ride, a subsidiary of AC Group. "We will be collecting transport data, monetary data and safety data," he said, explaining that the meter would record every journey, how much the rider earns per day and the passengers' preferred mode of payment.

Traffic report by the Rwanda National

Police indicates that in 2019 there were 184 fatalities caused by motorcycle accidents countrywide. About half of moto accidents occur in Kigali city.

Since the meters are GPS-enabled, they provide speed data in real-time. For instance, the device supplier will be able to know when a particular motorist over speeds. He said that the system would be expanded to send notifications to the over speeding rider. Also, there is a plan to rank motorists according to their traffic behaviour, an exercise that would inspire them to strive for safer service.

What are the benefits to motorists? According to Daniel Ngarambe, the President of FERWACOTAMO, the busi-

The passenger is allowed 10 minutes of waiting time free of charge, while each extra minute will be charged Rwf21. Shaffy, however, noted that prices might vary a bit from what clients were used to, going a little low for some journeys or a little high for others.



Fed officials say rush to reopen the US economy has backfired

BOSTON

senior Federal Reserve officials lamented the US failure to control the coronavirus pandemic, which stood in poor comparison with efforts in other advanced countries and was undermining the nation's economic recovery.

Drawing a strikingly unflattering contrast with the experience of Europe, Federal Reserve Bank of Boston President Eric Rosengren said US over eagerness to reopen commercial activity without sufficiently containing the spread of Covid-19 had backfired. "Limited or inconsistent efforts by states to control the virus based on public-health guidance are not only placing citizens at unnecessary risk of severe illness and possible death, but are also likely to prolong the economic downturn,"



Federal Reserve Bank of Boston President Eric Rosengren, left, said on Wednesday that further stimulus efforts should be combined with public health actions to bring the Covid-19 pandemic under

Mr Rosengren told the South said, is likely to continue, Shore Chamber of Commerce in Massachusetts on Wednesday.

Mr Rosengren said resurgences of the virus have led to a slowdown measured by high-frequency economic data. That slowdown, he

causing him to worry that an increasing number of temporary layoffs may turn into permanent job losses despite significant fiscal and monetary policy interven-

"Even as official restric-

tions relax, many people may prefer to continue avoiding activities that require social interaction in order to protect their own health," he said. "With such a pattern of behaviour taking hold, momentum in the economy toward returning quickly to full employment would likely fade.'

Deaths caused by Covid-19 topped 164,000 as of August 12, with confirmed cases rising 4.1 per cent in the past week, according data collected by Johns Hopkins University. The US labour market continued to improve in July as employers added 1.76 million jobs, but Mr Rosengren pointed to fresh data on consumer activity showing retail spending was falling again in areas where the virus was spreading most rapidly.

The Boston Fed chief compared the US's poor performance in containing the virus to Europe, where many countries cracked down harder on mobility and public activity, causing a sharp economic downturn but leading to a quicker, stronger recovery.

"As a result of this more virus-containsuccessful

ment policy, visits by Europeans to retail and recreation locations have now experienced a more robust recovery compared with American visits to such locations and are close to their pre-pandemic levels," he said. Dallas Fed President Robert Kaplan sounded a similar note.

"The rebound continues but, with the resurgence of the virus in a number of locations in the United States, that has muted the rebound," he later told the Lubbock Chamber of Commerce. "A number of countries around the world have gotten the virus transmission rates to relatively low levels and are recovering at a very rapid rate."

Mr Kaplan called on US officials to push harder for the widespread adherence to protective behaviours, especially the use of face masks, and said it would also

help the nation avoid having to pile up debt. "I would much rather have a healthcare discipline and follow these protocols than keep spending a trillion dollarsplus every three months of money that we're just going to have to pay back later," he said.

In a question and answer session that followed his remarks, Mr Rosengren said he "strongly" supported taking additional fiscal action to help businesses and households survive the crisis despite mounting federal government debt. But, he added, more spending should be combined with more robust efforts to contain the virus.

"Taking strong fiscal actions and taking very few public-health actions is completely the wrong mix," he said. "If you want to actually make sure the debt doesn't explode you have to make

Tencent's second quarter profit up as more users sign up to streaming services

Tencent's year-on-year profit grew by 37 per cent in the second quarter as new subscribers to its music and video-streaming services helped boost revenue. Profit attributable to equity holders in the three months to June 30 surged to 33.1 billion Chinese yuan while revenue grew by 29 per cent year on year to 114.9bn yuan, the company said.

As the Covid-19 pandemic disrupted economies, the Shenzhen-based company used it as an opportunity to expand its services

"During this challenging time, we utilised our platforms and technologies to help users adapt to the new normal via online tools, to support enterprises in conducting digital upgrades and to broadly contribute to economic recovery," the company said in a statement on Wednesday.

The number of fee-based subscriptions increased 20 per cent year-on-year to 203 million, primarily due to the growth in video and music content subscriptions, the company added. Video subscriptions increased 18 per cent annually to 114 million, whereas music subscriptions rose 52 per cent to 47 million as Tencent Music increased the scope of its paid music library in recent months.

Subscription income contributed 65bn yuan (57 per cent) of quarterly revenue. This was followed by 29.9bn yuan (26 per cent) of FinTech and business services revenue

and 18.6bn yuan (16 per cent) from online advertising.

FinTech and business services revenue increased 30 per cent year-on-year, which "mainly reflected revenue growth from commercial payment due to increased average daily transactions and value per transaction", the company said. Online revenue increased by 13 per cent, which the company said was due to a growth in mobile advertising, increased traffic and a greater mix of higher-priced video content.

Tencent - a leading investment corporation and a rival of Chinese e-commerce giant Alibaba - runs WeChat, the messaging and payment platform that constitutes the core of China's internet, and is China's largest technology company by market capitalisation.

Last month, Tencent launched an integrated advertising platform, which the company said allows advertisers to more efficiently place ads across its various platforms, including its mobile advertising network. "This new platform will enhance bidding efficiency and provide smarter targeting for advertisers," the firm said.

Last week, the US administration passed an executive order, signed by President Donald Trump, to ban US residents from doing business with Tencent's WeChat. It erased \$30bn from the internet giant's market value that time and sent the yuan to its biggest slump in two weeks. The executive order is due to come into effect next month.

Trump says he is considering pardon for leaker Snowden

WASHINGTON

PRESIDENT Donald Trump said on Saturday he is considering a pardon for Edward Snowden, the former U.S. National Security Agency contractor now living in Russia - whose spectacular leaks shook the U.S. intelligence community in 2013.

The Republican president's comments followed an interview (here) Trump gave to the New York Post this week in which he said of Snowden that "there are a lot of people that think that he is not being treated fairly" by U.S. law enforcement.

U.S. authorities for years have wanted Snowden returned to the United States to face a criminal trial on espionage charges brought in 2013.

Snowden fled the United States and was given asylum in Russia after he leaked a trove of secret files in 2013 to

domestic and international surveillance operations carried out by the

Trump's softening stance toward Snowden represents a sharp reversal. Shortly after the leaks, Trump expressed (here) hostility toward Snowden, calling him "a spy who should be executed."

"I'm going to start looking at it," Trump told reporters about a possible pardon, speaking at a news conference at his Bedminster, New Jersey golf club.

Trump said he thinks Americans on both the political left and the right are divided on Snowden.

"It seems to be a split decision," Trump told reporters. "Many people think he should be somehow treated differently. And other people think he did very bad things."

Some civil libertarians have praised Snowden for revealing the extraordi-

nage operations including domestic spying programs that senior U.S. officials had publicly insisted did not exist.

But such a move would horrify many in the U.S. intelligence community, some of whose most important secrets were exposed. Trump has harshly criticized past leaders of the U.S. intelligence community and FBI, and on Thursday took aim at the bureau's current director Christopher Wray, his own appointee.

The U.S. Justice Department filed a lawsuit last September against Snowden, arguing that his recently published memoir, "Permanent Record," violated non-disclosure agree-

The Justice Department said Snowden published the book news organizations that revealed vast analyscope of America's digital espiowithout submitting it to intelligence agencies for review, add-

ing that speeches given by Snowden also violated nondisclosure agree-

Trump's use of his executive clemency powers including pardons often has benefited allies and well-connected political figures.

He last month commuted the sentence of his longtime friend and adviser Roger Stone, sparing him from prison after he was convicted of lying under oath to lawmakers investigating Russian interference in the 2016 U.S. election to boost Trump's candidacy.

Disarmament in South Sudan faces challenges amid insecurity - expert

South Sudan's efforts to undertake civilian disarmament are facing challenges due to prevailing pockets of insecurity in the youngest nation, an expert said on Friday.

Augostino Ting Mayai, political analyst at the Juba-based Sudd Institute, a think tank, said that it's hard to undertake a successful disarmament process amid prevailing insecurity as South Sudan emerges from the more than six years

"It's human nature for any of us to feel secure before we can hand down anything (arms) that protect us. Disarming the population without first putting in place guarantees, is going to be resisted because the government has not provided sufficient protection for the civilians," he told Xinhua in an interview in Juba.

His remarks came after violent clashes broke out on Aug. 8 between the military and armed civilians when the latter attempted to conduct disarmament in the Tonj East area of Warrap state, leaving more than 148 people killed including soldiers. Mavai observed that the government should focus on holistic disarmament, rather than conducting in particular areas.

South Sudan since winning independence from Sudan in 2011 has been rife with persistent inter-communal violence which often manifests in form of cattle raiding, child abduction and revenge killings. Some of these local militias have often also clashed with government troops. "You need to cover the entire country at the same time.

Selective disarmament is going to face some challenges and push back. What we saw in Tonj is not that people don't want to hand over their arms to the government, it is just that the government has not provided enough security for them," added Mayai.

"The ubiquity of arms in the hands of civilians is definitely causing insecurity issues within the communities, and there is no question about it being an issue to handle. Nevertheless, one would not underestimate the daunting task of making that happen," he said.

Mayai noted that chronic poverty and other underlying issues such as local security matters are pushing the youth to retain their weapons.

"A disarmament practice that is put in the hands of army generals is not going to be sufficient, especially when the population knows that some of these generals are violent," he noted.

"As you are aware the youth will have to defend themselves because the people coming to them are known for violence and not a discussion that will lead to nudging these young people to hand down their arms," said Mayai.

He disclosed that disarmament takes incentives, adding that forceful disarmament is bound to inflame the situation. "There has to be a government policy that integrates all the views from the community members, youth, community leaders, policymakers and NGOs.

It's not going to be an overnight reaction to the violence by the government because without a strategic plan, you cannot succeed rather you will always inflame the situation," said the expert.

South Sudan is currently implementing the 2018 revitalized peace deal signed in Ethiopia to end more than six years of conflict since the outbreak in December 2013.

UN demands probe into human rights violations in Cameroon

UNITED NATIONS

THE United Nations wants the authorities in Cameroon to begin an investigation into reports of serious human rights violations, including a shocking video allegedly showing the brutal murder of a woman, a UN spokesman said on Friday.

"We strongly and unequivocally condemn this atrocious act of violence," said Stephane Dujarric, spokesman for UN Secretary-General Antonio Guterres.

"We call on the authorities to swiftly launch an investigation into these allegations, and to ensure that those responsible are brought to justice," the spokesman said. "We call on armed actors to refrain from attacks against civilians, to respect international humanitarian and international human rights law."

The Cameroonian army said Thursday that its troops have captured three armed separatists suspected of murdering the woman in Muyuka, a locality in the troubled region of Southwest. The woman was kidnapped, brutalized, and beheaded on Tuesday by armed separatists who accused her of conniving with government forces to leak their hideouts. The murder was widely condemned in Cameroon after the suspects filmed the gruesome act and posted the video online.

Historical memories should not fade, 75 years

This year's Aug 15 marks the 75th anniversary of Japan's unconditional surrender in World War II

For most people in Asia, Aug 15 is a special date that will never be erased from their memories. The war of aggression initiated by Japan brought untold sufferings to the people in Asia. China alone suffered 35 million casualties and 600 billion US dollars in economic losses in the War of Resistance against Japanese Aggression.

"The tragedies of Hiroshima and Nagasaki and the suffering caused by them must not be repeated," he said. However, Abe said nothing about the reasons for the bombings and their background.

In the annual World War II memorial ceremony on Aug 15, Abe's speeches, since he came to power on mourning for the Japanese soldiers who died in the war of aggression, avoiding talking of Imperial Japan staging the brutal aggression war and the colonial rule.

He has also evaded repeating Japan's responsibility for wartime atrocities mentioned by his predecessors starting from former Prime Minister Tomiichi Murayama, showing no intention of reflection and apology.

Chinese mainland makes great efforts to help Hong Kong fight COVID-19 resurgence

In mid late July, the COVID-19 situation in Hong Kong, which had once been easing, suddenly became serious. While calling on citizens to make concerted efforts to combat the epidemic, the HKSAR government rolled out a series of epidemic prevention and control measures.

The central government dispatched people to help build makeshift hospitals in Hong Kong and assist the city in conducting nucleic acid tests, which has quickly increased the number of hospital beds and would play an important role in the epidemic prevention and control in Hong Kong, said Henry Fan Hung-ling, chairman of Hong Kong's Hospital Authority (HA).

The spread of COVID-19 in Hong Kong is beyond the capacity of local medical resources, said Pan Pey-chyou, chairman of Hong Kong Medical and Health Care Staff General Union, noting that the assistance from the Chi-

with the HKSAR government. In February, Chinese diplomats communicated with relevant parties and coordinated efforts to help HKSAR government bring several hundred Hong Kong passengers stranded on the novel

At the onset of the epidemic, the central government responded promptly to Hong Kong's needs and immediately made efforts to ensure the supply of the materials for Hong Kong, including deploying 17 million face masks to the

Meanwhile, various mainland bases providing supplies for Hong Kong had operated at full capacity to ensure that food materials like vegetables, dairy products, eggs, grain, and cooking oil could be supplied to Hong Kong continuously.

Third stage of Russia's coronavirus vaccine research may begin in 7-10 days

MOSCOW

THE third (post-registration) stage of the research on the coronavirus vaccine developed by the N. F. Gamaleya Federal Research Center for Epidemiology and Microbiology of the Russian Health Ministry, may begin in 7-10 days, its Director Alexander Gintsburg told TASS.

Several tens of thousands of peo-

ple are expected to take part in this research.

"On Monday, we will present the first version of the protocol on post-registration research. Given this great interest and attention of the public and the press, I think that the Health Ministry won't delay the process and will approve the protocol within a week. So, I believe within seven or ten days at maximum everything will begin," Gintsburg

Earlier, the press service of Russia's public health watchdog, Roszdravnadzor, said some 2,000 people would take part in the clinical trials after the drug's registration.

In his turn, Gintsburg said several tens of thousands of people were expected to be involved by the third stage. The research will be conducted in the Moscow Region.

Lebanese president says Beirut aid should go where needed

BEIRUT

LEBANESE President Michel Aoun said on Saturday that international aid pledged following a massive explosion in Beirut last week that killed 178 people and made 300,000 homeless should go where it is needed.

In an interview with French news channel BFM TV, Aoun said all hypotheses remained open in the investigation into the blast at the port of Beirut that wrecked huge swathes of the capi-

"I have asked that aid sent by foreign countries be given exactly where it is needed," he said, adding that he had not considered resigning, after the government quit earlier in the week.

The United Nations has launched a \$565 million aid appeal, whose priorities include stabilising the grain supply after the explosion destroyed a huge grain silo at the port.

Six hospitals and more than 20 clinics were damaged and more than 120 schools destroyed, the UN says.

"We would like to be able to rebuild the three hospitals that were completely destroyed," U.N. humanitarian coordinator Najat Rochdi said earlier.

The United States called for a transparent and credible investigation into the disaster.

The Aug. 4 blast, which authorities say was caused by more than 2,000 tonnes of ammonium nitrate that had been unsafely stored at the port for

"We can never go back to an era in which anything goes at the port or the borders of Lebanon that had to contribute to this situation," said David Hale, U.S. Under-Secretary of State for Political Affairs, after visiting the port.

He said FBI agents would arrive this weekend, at the invitation of Lebanon, to help investigate what led to the explosion.

The blast has fuelled anger at Lebanon's ruling politicians who were already facing criticism over a financial meltdown that has sunk the currency, demolished the value of savings and left depositors unable to withdraw their money.

Some Lebanese doubt the authorities can carry out a proper investigation and say foreign countries should intervene.

"We can't trust this government. They will lie to us. They should form an international committee to investigate this," said businessman Jimmy Iskandar.

Aoun has said a probe will look into whether the blast was caused by negligence, an accident or "external interfer-

He said in his interview that the investigation would not be as quick as he had hoped because it was complex and

would involve an independent magis-

Asked why he did not want an international investigation, he said foreign experts, including from France and the FBI, were helping with the Lebanese probe.

"They won't do a thing in an investigation and the whole world knows that," said painter Mohammed Khodr, as he helped repair a restaurant damaged in the blast.

The heavily armed, Iranian-backed Lebanese group Hezbollah, which is listed as a terrorist organisation by the United States, said on Friday it would wait for results of the official Lebanese investigation into the blast.

But if it turns out to be an act of sabotage by neighbouring Israel then it would "pay an equal price", Hezbollah leader Sayyed Hassan Nasrallah said in a televised address. Israel has denied any role in the explosion.

Putin on Friday proposed a video summit with the United States and the remaining parties to the nuclear deal -Britain, France, China, Germany and Iran - to try to avoid further "confrontation and escalation" at the United Nations over Iran.

"The issue is urgent," Putin said in a statement, adding that the alternative was "only further escalation of tensions, increasing risk of conflict - such a scenario must be avoided."

Asked if he would take part, Trump told reporters, "I hear there's something, but I haven't been told of it yet." French President Emmanuel Macron is open to taking part in a video summit, the Elysee palace said.

The United States has argued that it can trigger a sanctions snapback because a U.N. Security Council resolution enshrining the nuclear deal named Washington as a participant. But the remaining parties to the deal are opposed

to the move. Putin said Russia, an ally of Iran in the Syrian civil war, remained fully committed to the nuclear deal and that the aim of a summit would be to outline steps aimed at avoiding "confrontation and escalation of the situation in the Secu-

rity Council." Trump has said he wants to negotiate a new deal with Iran that would prevent it from developing nuclear weapons and also curb its activities in the region and elsewhere.

Nearly half of Brazilians say Bolsonaro not to blame for coronavirus death toll, poll says

SAO PAULO

ALMOST half of Brazilians think President Jair Bolsonaro bears "no responsibility at all" for the country's more than 100,000 dead from the coronavirus pandemic, the world's second highest death toll, according to a new Datafolha poll.

The poll was published on Saturday in Brazil's Folha de Sao Paulo newspaper and says 47% of Brazilians do not assign him any blame for the body count, whereas 11% do.

Brazil has the world's worst outbreak outside of the United States and Bolsonaro's response to the pandemic has been widely condemned by health ex-

Right-wing Bolsonaro has pushed for the use of unproven anti-malarial drug hydroxychloroquine to fight the disease, replaced health ministers who opposed his agenda, encouraged Brazilians to oppose lockdown measures and shown indifference to the rising



death toll.

Bolsonaro himself and several members of his family have gotten coronavirus. His current wife, Michelle Bolsonaro, got the disease in late July and her grandmother died from the disease

Bolsonaro's fourth son, Jair Renan, who is 22, tested positive for coronavirus, his mother said on Instagram on

"He is doing very well, taking hydroxychloroquine and will soon recover," the president's second wife said in the post, still signing her name as Cristina Bolsonaro.

Still, Bolsonaro is currently enjoying the highest popularity rating of his administration, according to the same Datafolha poll.

Thirty-seven percent of Brazilians rated his term as great or good, compared with 32% in June.

The poll said that the spike in popularity can be explained by emergency payments the government has been making to low-income and informal workers set to expire in September. The government is currently considering whether to extend the payments.

As of Friday, Brazil had 106,523 deaths and 3,275,520 confirmed cases.

AS the total mileage of China's high-speed rail exceeds 35,000 kilometers and accounts for over 2/3 of the world's total, the Chinese people are enjoying increasingly rapid and convenient transportation.

However, there are still 81 pairs of slow public service trains running across the country, picking up passengers at every stop in the country's remote mountainous areas at minimum charges.

Train No. 6063/6064 is one of the 81 pairs of slow public service trains running between Guangyuan, southwest China's Sichuan province and Baoji,

northwest China's Shaanxi province. Helping poverty alleviation and carrying students to schools, the rail line, running for over 60 years, is a guarantee of and witness to the wish for a better life of the people along its

Selling agricultural products from mountainous areas to the outside is an important approach for rural residents to shake off poverty.

To facilitate the agricultural trade of them, the train has particularly offered an information board to match the supply and demand sides, where prices of

crops are listed.

A woman surnamed Li from Guangyuan always takes this train for restocking peaches in Yanzibian township, Hanzhong, Shaanxi province.

"The purchase price is 2.6 yuan (\$0.37) per kilogram, and I can sell the fruits at 4 yuan per kiligram back home. The small business gains me extra income and makes my life better," Li

Switching players, administrators and coaches tells awful lot on capacity building

N what now looks like a game of ladders, city archrivals Simba SC and Yanga have had occasion to exchange players, a top administrator and a coach, where one side is the pace setter and the other the recipient. What is interesting is that in all these cases those involved are foreign nationals, which means their positions were not being evaluated against others on the local stage but in all those respects they excelled, the only issue being their club loyalties. And that easily exchanges vocal pleads for cash.

Ordinarily each position whether in the field, the technical bench or club offices, when it falls vacant, there ought to be a number of individuals contesting to fill that position, and who have fairly significant chances of being selected. In that case there was always the chance that a good player or the best player in the Yanga line up abandon the club for greener pastures somewhere, but the problem is how Msimbazi Street bigwigs worked overtime to purchase his disloyalty to erstwhile employers, and signature. It spoke a lot about the player being a sort of superstar in the premier league, reminding fans of other cases earlier.

Such contention for foreign professionals was noticed during the period of superstardom of Ugandan ace Emmanuel Okwi, were the best for the job at hand, while Zimbabwean Donald Ngoma changed clubs but wasn't a hot potato for technical benches. There was Haruna Niyonzima and others with ability to mesmerize city rivals' technical benches such that they break all the rules to undermine the other club's hold on the player and net his signature. The trouble is that there

in what is being contested, and a cash inequality.

What sparks interest and disillusion on this series of exchanges of club personnel or rather shifts of key personalities is that in all those instances no local aspirant for any of those positions appeared to be in contention. That wasn't due to any discrimination but reality, since the persons making those decisions weren't favoring the foreign recruits or aspirants, for a good player to be recruited, a club administrator or a new coach. In all those instances they at least on the basis of the club leaders handling the matter, and definitely they didn't give them a favor to disorient their next door

side were "not setting any limits" after their stunning win over Manchester City on Saturday set up an unlikely Champions League semifinal against Bayern Munich.

The French team defeated Pep Guardiola's men 3-1 in the 'Final Eight' in Lisbon with a late brace from substitute Moussa Dembele deciding the game after Kevin De Bruyne's goal had cancelled out Maxwel Cornet's opener.

Their victory against much-fancied City comes after they ousted Italian champions Juventus on away goals in the previous round. But they will now have to see off an ominous Bayern team on Wednesday if they are to make the final.

"We know who we are coming up against next," said Garcia.

"We eliminated a Juventus side who were one of the contenders to win the Champions League, and a Manchester City side who were contenders to win the Champions

"Bayern will be exactly the same, but on the basis of what the players have shown logically we can still hope to get through another round and that is what we are going to prepare to try to do.'

Lyon finished seventh in the curtailed French season, a desperately poor showing from France's second-richest club meaning they have to now win the Champions League just to qualify for Europe again in the new campaign.

They have appeared in continental competition in each of the last 23 seasons, but they have never gone beyond the semi-finals of the Champions League.

That has happened just once before, when they lost to Bayern in the last four in 2010.

City's latest Champions League nightmare a result of Guardiola's tormented tactics

IS there another manager who turns the Champions League knockout stages into an existential battle for his soul quite like Pep Guardiola?

The only time Manchester City appeared likely to win Saturday's quarterfinal against Lyon was when they looked like themselves: A dominant 20-minute, second-half spell that coincided with Guardiola abandoning an unfamiliar 3-5-2 shape in favour of their conventional back four, a sumptuous Kevin De Bruyne equaliser and concerted pressure thereafter.

Yet, City went behind as a result of Guardiola's early conservatism and they were knocked out of the competition due to Lyon exposing the defensive vulnerabilities he hitherto sought to protect with his initial formation.

No wonder Guardiola looks so exasperated on these nights.

Guardiola and Manchester City will surely one day try to win the Champions League on their own terms, prioritising the free-flowing, expansive football that overwhelms so many weaker opponents. The need to do something different against better opponents on the biggest stage is seemingly a thought that consumes Guardiola on an annual basis.

Since Chelsea mugged his Barcelona side on the way to winning the 2012 crown, Guardiola has faltered under the weight of expectation to deliver the Champions League trophy, an expectation heightened by the domestic supremacy he enjoyed at Bayern Munich and with City.

A warning came in the form of the two group stage meetings with Lyon last season, as the Ligue 1 side won at the Etihad Stadium and were only denied a double by Sergio Aguero's late equaliser, sitting deep and counterattacking to devastating effect. Maxwel Cornet scored in both matches

Recovery or separation for Messi as Barcelona face up to change

LIONEL Messi's body language said it all as Barcelona were sent into fullblown meltdown in their historic Champions League quarter-final humiliation at the hands of Bayern Munich on Friday.

He could only look on helplessly as the club to which he has brought so much glory succumbed to a record 8-2 defeat in Lisbon.

By the end, even with the ball he could not make anything happen -he was robbed of possession in his own half to start the move which brought Bayern's seventh goal at the Estadio da Luz.

Earlier, in a photo taken through the door of what appears to be Barca's changing room at half-time and which has widely circulated online, Messi can be seen sitting alone at the end of his bench, turned away, wearing both the captain's armband and a look of total resignation.

He looked beaten as he stared at the floor with his shoulders drooping, deflated, done, exhausted, perhaps even, old.

Bayern were 4-1 up at that point, but there was no chance of a comeback in the second half and instead it became Barcelona's worst


ever defeat in Europe. The hope had been that Messi would erase all logic by beating arguably the most formidable club team in the world right now on his own, and in spite of everything around him.

"We are in the final preparations of receiving our international players. There have been rumours suggesting we have missed out on several targets that have gone to our rivals but let me assure our fans, that is not true," he said.

"Unfortunately it seems everybody that is landing in Tanzania is linked to Yanga. The truth is we have not missed any player that we were interested in. Larry Bwalya was not in our plans."

"Nobody can predict who will sign next, we are keeping things tight at the moment. We are not in a hurry to announce our signings."

Simba signed Bwalya from Zambia Super League side Power Dynamos. Bwalya became the third foreign player to have signed for the back-to-back Mainland Premier League champions so far.

"Zambian midfielder Larry Bwalya has joined Simba from Power Dynamos. He is best known as 'Locomotive' and is a box-to-box midfielder, a magician left-footer," Simba announced on their social media pages confirming the arrival of the star from Kitwe.

After the disappointment of early exit in CAF Champions League last season, Simba are rebuilding their team with the hope of making it to the money bracket for a third time in their history.

On Friday Kenyan defender Joash Onyango was recruited on a two-year contract as well as Ghanaian winger Bernard Morrison who controversially crossed over from their rivals, Yanga.

Two locals additions have already been confirmed, namely center forward Charles Ilanfya from Premier League side Kinondoni Municipal Council FC and right full back David Kameta from relegated Lipuli FC

Simba team manager, Patrick Rweyemamu, has provided an update with regards to where the club currently stands with their plans to return to training.

"We expect to resume training on Monday (today) in preparation for 'Simba Day', Community Shield and the Premier League in general," he stated.

"Any player that has been unveiled is in Dar es Salaam and that means all players that were announced during the weekend are ready to start serving the club and will be part of the training camp," he disclosed.

Atif Salim, Tanzania Cricket Association (TCA) information officer, stated that Chui Challengers sailed through to the final given they had a better net run rate.


Chui Challengers were positioned second in the 2020 APL table, having notched three wins, lost two games to collect six points.

one to amass eight points.
