Govt to build 14 universities for peripheral **regions**, 2026

The university faces financial challenges and was thus unable to construct the needed dormitory

PRIME Minister Kassim Majaliwa said yesterday that the government is determined to establish 14 university campuses in peripheral regions.

Addressing lecturers and graduates at the 26th graduation ceremony at Iringa University, standing in for President Samia Suluhu Hassan, he said the new campuses are slated for Kigoma, Ruvuma, Singida, Mwanza, Kagera, Tanga, Njombe, Tabora, Manyara, Simiyu, Shinyanga, Lindi, Rukwa and Katavi.

"The move is part of deliberate efforts to

accelerate economic growth in peripheral areas. We also aim to increase opportunities for technical education, knowledge and life skills in specific areas," he stated.

Construction of the new campuses would increase the scope of access to educational enhancement and employment opportunities, while improvement of infrastructure at universities like lecture rooms, laboratories, lecturers' houses and libraries was being pursued, he said.

GCLA has during fiscal 2021/22 and 2022/23 procured eight high technology laboratory diagnosis facilities and 134 small scale diagnosis facilities, altogether costing 9.3bn/-.

Dr Fidelis Mafumiko, the chief government chemist, said at the event in Dar es Salaam yesterday that among the procured diagnosis facilities are inductively "Samples related to crime are not lim- coupled plasma optical emission spec-

cal technique to determine the magnitude of certain elements in a sample.

Other purchased facilities are transesophageal echocardiography (TEE) and transthoracic echocardiography (TTE), sound-based analytical instruments used in the diagnosis of androgenic anabolic steroids (AAS), largely prohibited stimulants among athletes.

"These facilities will greatly complement the provision of sample diagnosis and other related laboratory services," he said, elaborating that the authority had during 2021/22 administered the diagnosis of 155,817 samples, well above the targeted 111,349 samples.

During fiscal 2022/23, 212,306 samples or 133.90 percent of the targeted 158,600 samples were tested, he said, noting that efficiency in diagnosis of samples and

'Average income of surveyed poor well below poverty line'

A NEW report assessing the second phase of the poverty alleviation programme has shown that average daily spending for targeted households in 2022 stood at 1,149/-, well below the poverty line of 1,859/- for the Mainland.

George Simbachawene (pictured), the Public Service Management and Good Governance state minister in the President's Office, made this observation here yesterday when launching a report by the Tanzania Social Action Fund (TASAF).

The findings shows the average spend-



ing for a single household per month was 152,621/- in which food took the most share with 113,256/- equivalent to 74.2percent of household spending, he said.

"The monthly spending for targeted households is down compared to monthly household spending in Tan-

zania," he affirmed, noting that most households spend the money given to them through the programme on food instead of investing in revenue generating activities.

The government will now focus on offering education so that the money given to them is invested in revenue generating activities, he said, pointing out that 50-percent of the targeted families are involved in farming, 22 percent in paid activity and 15percent are self-employed.

Upwards of 57 -percent of food consumed in beneficiary households is

Sweden hands 210bn/-grant, education support partnership

THE government has signed a grant agreement for \$84 million (210bn/-) with the Swedish International Cooperation Agency (SIDA) for implementation of the teachers support programme.

Charlotta-Ozaki Macias, the resident Swedish ambassador said at the Treasury signing ceremony yesterday in Dar es Salaam that the grant was made in liaison with the Global Partnership for Education (GPE), a Washington-based multi-stakeholder organisation.

She said that beyond professional development, the global partnership is not only pursuing improved education quality but also easing the burden on educators.

"Teachers are agents of change. They play a pivotal role in supporting children to learn, as well as in motivating parents to participate in the teaching and learning processes," the envoy noted.

Dr Natu Mwamba, the Treasury permanent secretary, said the overall objective of the GPE teachers support programme is to improve inclusive pupil-based learning.

It will focus on the transformation of teacher workforce planning and management, ensuring gender equality and inclusion, plus an appropriate teaching and learning environment, she said, pointing out that it addresses overcrowded classrooms by establishing model pre-primary classes, reducing class sizes from 113 to 50 pupils.

The programmatic scope and coverage is based on the need to transform the basic education sector for improved, inclusive pupil-based teaching for quality learning

ment intends to build 34 dormitories, 130 lecture rooms and classrooms, 23 scientific conference halls, teaching laboratories and farm infrastructure, the premier noted.

Completion of the above mentioned projects is expected to increase the number of students enrolled for science, engineering, technology and mathematics (STEM) courses from 40,000 students in 2020 to 106,000 by 2026, he said.

Responding to a request from students for construction of a girls' dormitory, he said the government will take up the quest, after the university council chairperson, Lilian Badi-Manara appealed for the president to help the campus construct a dormitory for female students.

The university faces financial challenges and was thus unable to construct the needed dormitory, she said, noting that when girls stay in hostels they feel safer and more disposed to learn.

Most of them have rented rooms in the neighbourhoods the council leader noted, while General Venance Mabeyo (retired), the university dean, awarded certificates to 1,994 graduates including 108 who graduated with Master's degrees in education, business administration and management, social and project development.

Other graduates are in fields like counselling psychology, community development, information and communications technology (ICT) plus international criminal law and human rights.

Still, it takes a maximum of 27 days to find results for a DNA sample test, he said, pointing out that registration of stakeholders in the chemical industry value chain attained 3,371 in 2022/23, up from 2,125 stakeholders in fiscal 2020/21.

The issuance of chemical importation and transportation permits has gradually grown during the past three fiscal years, as in 2020/21 a total of 40,270 permits were issued, climbing to 55,780 permits in 2021/22 and 65,432 permits during 2022/23, he affirmed.

The growth of strategic chemicals business in the country was in 2020/21 and 396,982 tonnes facilitated during the past three in 2021/22, he said, citing that so-

home-grown or given as gifts from relatives while 43 percent of the food is purchased, he said.

"With these results, I would like to encourage the beneficiaries of the TASAF programme to ensure that they produce food by using opportunities provided by the government or other stakeholders where they live," he appealed.

As rains fall all over the country this is an opportunity to grow rapidly maturing crops such as green vegetables, corn and others, to diminish food shortages, he said.

The survey results show that the beneficiary households live in an unsatisfactory environment, with 38 percent of them having houses with clay walls, he said, directing TASAF and ward level leaders, plus village and neighbourhood levels to monitor that environment.

They should extend helpful advice on how to build at a low cost and use other government agen- he added.

cies such as the National Housing Corporation (NHC) to see how this group can be put on priority list to improve the habitats they live in, he said.

"The government will work on the housing problem in the next plan to see how we can put these beneficiaries in a better environment," he said.

Four percent of programme beneficiaries had visited a bank or other financial institution to open or close an account, he said, elaborating that nine percent of households have accounts in financial institutions.

COP28 opens with calls for accelerated action against climate crisis

DUBAI

THE United Nations Climate Change Conference COP28 opened yesterday with a resounding call to accelerate collective climate action.

The conference takes place in what is already known to be the hottest year ever recorded in human history and as the impacts of the climate crisis wreak unprecedented havoc on human life and livelihoods around the world.

COP28 in Dubai, United Arab Emirates (UAE), from 30 November to 12 December 2023, is a decisive moment to act on climate commitments and prevent the worst impacts of climate change.

UAE has the presidency for COP28, with Dr Sultan Al Jaber as this year's president.

UN Climate Change Executive Secretary Simon Stiell said: "Over 160 world leaders are headed to Dubai, because only cooperation between nations can get humanity

back in this race. But COP28 cannot guided by the north star of keeping be just a photo-op. Leaders must deliver - the message is clear. And as leaders leave Dubai after the opening summit, their message to their negotiators must be equally clear: don't come home without a deal that will make a real difference."

Stiell added: "The reality is that without much more finance flowing to developing countries, a renewables revolution will remain a mirage in the desert. COP28 must turn it into a reality."

Stiell emphasized the need for collaborative efforts to combat climate change, an area in which nations can work together effectively to ensure a sustainable future both for people and the planet.

COP28 President Dr Sultan Al Jaber said: "We don't have any time to waste. We need to take urgent action now to reduce emissions. At COP28, every country and every company will be held to account, fully operationalized and funded."

"All parties should be prepared to deliver a high ambition decision in response to the global stocktake that reduces emissions while protecting people, lives and livelihoods," Al Jaber added.

We cannot achieve our common goals without having everyone on board, most importantly the Global South. This year's COP marks the a catalyst for greater ambition in inclusive transition to renewable conclusion of the "global stock take", the first assessment of global progress in implementing the 2015 Paris Agreement.

The findings are stark: the world is not on track to limiting temperature rise to 1.5°C by the end of this century. It does recognize that countries are developing plans for a net-zero future, and the shift to clean energy is gathering speed, but it makes clear that the transition is nowhere near fast enough yet to limit warming within the current ambitions.

A report recently published by UN Climate Change shows that national climate action plans (known as nationally determined contributions, or 'NDCs') would collectively lower greenhouse gas emissions to 2 percent below 2019 levels by 2030, while the science is clear that a 43 percent reduction is needed.

The global stock take must be

meeting the Paris Agreement's goals as nations prepare to submit revised national climate action plans by 2025.

It lays out actions on how to accelerate emissions cuts. strengthen resilience to climate impacts, and provide the support and finance needed for the transformation.

Climate finance stands at the heart of this transformation. Replenishing the Green Climate Fund, doubling financial resources for adaptation and operationalizing the loss and damage fund are key to keeping 1.5°C within reach while leaving no one behind.


Progress on climate finance at COP28 will be crucial to build trust in other negotiation areas and to lay the groundwork for an even more ambitious "New Collective Quantified Goal" for climate finance, which must be in place next year. It will also set the stage for a just and

WHO celebrates the role of communities in driving progress towards ending HIV/Aids

AS the World AIDS Day is celebrated today, the World Health Organization (WHO) has joined international partners to acknowledge the resilience, and innovation dedication exemplified by community leaders and organizations in the response to the HIV epidemic.

From fighting stigma and discrimination, to advocating for access to affordable interventions, and community led services that put people with lived experience at the centre, communities have shaped the HIV response for decades.

Director-General of the World Health Organization Dr Tedros Ghebreyesus said: "People living with or affected by HIV have left an indelible mark on the world with their activism."

"The affected He added: communities who fought for tools to prevent, test and treat HIV enabled 30 million people to access antiretroviral therapy, and helped to avert an unknowable number of infections. We stand together with communities to help end AIDS as a public health threat by 2030." Several decades of investments

and learning from the HIV epidemic have catalysed broader advancements in global health and national health systems.

The response to HIV strengthened healthcare systems and increased access to services beyond HIV testing and treatment. Investments and infrastructure from the HIV response enabled strong and swift responses to many diseases including COVID-19 and DOX.

Despite significant progress, HIV remains a pressing public health issue

Globally, 9.2 million people do not have access to the HIV treatment that they need. Each day 1700 lives are lost from HIV-related causes, and 3500 people are infected, with many not knowing their status or having access to treatment.

Innovations in HIV tools, such a powerful once a day pill for HIV treatment and accessible viral load testing, have enabled significant progress. The fact that people living with HIV, who take their HIV treatment as prescribed and have

have zero risk of transmitting HIV treatment for children living with to their sexual partners, is just one such example.

This was the result of years of advocacy and investment, and is a reminder that the target of ending AIDS as a public health threat by 2030 is achievable, provided there is sufficient political will and sustained investments.

Funding, criminalization, and limitations placed on the roles of community champions hinder the progress achieved by community leaders and slow global progress to ending AIDS as a public health threat. Many communities, such as key populations of men who have sex with men, transgender people, sex workers, people who use drugs, and adolescents, still lack access to the prevention, treatment, and care services that they need and deserve. These inequalities continue to drive the uneven progress on HIV.

With less than 7 years to reach this goal, there is still an urgent need for continued funding to HIV programmes so that community leaders can continue reaching those affected.

These efforts are essential to no virus detectable in their blood, close the gaps in diagnosis and

HIV, and help all countries move closer to the 95-95-95 targets, which aim for 95 percent of people living with HIV knowing their status, 95 percent of those diagnosed receiving antiretroviral therapy and 95 percent of those on treatment having suppressed viral loads. WHO will continue to work with partners and call on leaders to prioritize the needs of affected populations.

"We call for global solidarity with communities today and every day," said Dr Meg Doherty, WHO Director of Global HIV, Hepatitis, and STI Programmes. "The leadership of affected communities has been vital to moving forward the HIV response, despite the legal, economic and social barriers they face."

Partnership with people living with and affected by HIV is critical to the sustainability and ultimate success of the HIV response. WHO stands with global partners to applaud the role of the communities in closing the testing, treatment and care gaps for those left behind and in driving progress towards ending AIDS as a global public health threat.

Mining firm wins government praise for empowering people economically

THE government has congratulated the Barrick North Mara and Bulyanhulu mines for generating jobs, empowering young people economically and achieving social projects.

A team of five directors from various units in the Office of the Prime Minister's Office made a working visit to the Barrick North Mara and Bulyanhulu mines where they expressed their satisfaction with the good work being done by the mines, in providing jobs for Tanzanians, empowering youth economically and achieving social projects.

TAMWA has to take up new tasks, eclipsing 1987 agenda ENDER enthusiasts in systematic scaling down of employees

Salaam city were in a festive mood at midweek.

This was in line with the two successive days spent marking 36 years of the founding of the Tanzania Media Women's Association (Tamwa), without doubt the oldest and so far most inspiring of gender-related media organisations.

While there was plenty to celebrate, onlookers may not be surprised to find that it is outside the media context that the organisation had it most noticeable impact. Newsrooms were less their sphere of battle than its anchor.

Remarks made by current Tamwa leaders suggest that there is an aspect in which they also worked to redress errors or grievances in various newsrooms at various points during the period under review.

There was intimation that much remains to be done in that direction - which is quite valid, as the matter cannot entirely be exhausted, including in relation to the 50-50 expectations.

It all presumably applies in an all-round way, whether in boards of directors, managements and newsrooms or indeed elsewhere.

More directly, the newsroom scenario has changed such that problems facing women journalists once they graduate are similar to those young men seeking to eke out a livelihood from the media profession encounter. There is now a shift to what is generally classified as artificial intelligence, things like spellchecking or downloading, apart from enormous proliferation of social media propping up of events.

Clearly and surely, formal news outlets are becoming more of institutional outlets, stakeholders seeking hard data.

At the time Tamwa was being established, employment in media organisations was relatively plentiful.

To add to that, owing to close interactions in newsrooms, most of the

media houses across Dar es in most newsrooms - and these having to survive market pressures.

In that context, newsrooms retained people they really need, or thought they could afford, and implicitly had no gap to cover as regards professional respect or their work being relevant or of utmost utility.

Situations where people mingled in large numbers either in the civil service or in the private sector tended to diminish in the years Tamwa has been in operation. The association's work has been less of crusading for the rights of women in the media but, rather, in the larger society.

But even in that regard, the crucial issue wasn't that this or that right was not recognised but rather that women needed to be empowered.

This is the pivotal parameter of various gender-oriented organisations in our country, first working to raise awareness among women as to their capacities, and facilitating it.

When Tamwa and other agencies move into what are essentially 21st century challenges of working in the media industry, the situation and what ought to be pursued may have to be altered in scope or perspective.

The fact is that many journalists are only partially in employment, given wider room to seek out other legitimate ways of making a proper living, which isn't always easy. But those who are industrious enough or have the skills to seek out clients for what they can professionally deliver are at times even more successful than when spending plenty of time in newsrooms.

This atmosphere is more attuned to professional independence than to collective gender unionism. Thus, it should still be that the recipe of choice for success in media practice, as in other professions, remains a combination of competence, having enough legroom to perform, diligence and having the necessary resources - and not otherwise.



good news: New treatment paths are being initiated at the Muhimbili National Hospital, with the likelihoods of spreading to regional referral hospitals.

This is as the government enhances and consolidates specialist medical capacity, complete with having a specialised fund for the purpose.

The hospital is initiating knee and hip bone replacement surgery, assisted by Global Medicare, a diagnostics firm based in South Asia, with 14 patients being the first attended to.

The new initiative being conducted at MNH's Mloganzila branch should appreciably uplift the hospital's image as a truly modern facility.

An official has said patients were drawn from various regions alongside one from a neighbouring country. They spent not more than three days to have an operation and be released.

The operations were led by a specialist from a Queen Elisabeth Hospital, of which there are quite a few in the UK and elsewhere in the Commonwealth. One of the UK-based medics has confirmed that doctors at Mloganzila have world-class expertise but the facility ultimately ought to have a full-fledged unit to run the service to satisfaction.

None of these critical causes is that directly a lifestyle issue in nature, implying that preventing them isn't merely a matter of education.

Only a professionally run treatment facility qualifies for the work and, with the rise in motor vehicle use at times in a reckless manner, chances of more people needing such attention stands to rise.

Apart from the camp treating only three dozen or so patients, it was a learning environment for doctors or specialised surgery staff from the likes of Temeke Referral Hospital, disability rehabilitation centre CCBRT and the Mbeya Zonal Referral Hospital.

"I have long admired the man who fled the Nazis as a young boy from a Jewish family, then fought them in the United States Army," Bush said in a statement.

"When he later became (US) Secretary of State, his appointment as a former refugee said as much about his greatness as it did America's greatness," added the former president.

Kissinger served two presidents, Richard Nixon and Gerald Ford, and dominated foreign policy as the United States withdrew from Vietnam and established ties with China.

In China, Foreign ministry spokesperson Wang Wenbin called Kissinger an "old friend and a good friend of the Chinese people, and a pioneer and builder of China-US relations".

Many on social media in China mourned Kissinger's passing. State broadcaster CCTV shared on social media an old segment showing his first secret visit to China in 1971, when he broached the possibility of establishing US-China relations and met then-Premier Zhou Enlai.

Kissinger exerted uncommon influence on global affairs long after he left office. In July, for instance, he met Chinese leader Xi Jinping in Beijing while US-Chinese relations were at a low point.

Criticism of Kissinger, who was awarded the Nobel Peace Prize for his role in negotiating a ceasefire in Vietnam in 1973, was especially strong on social media, where many posted celebratory videos in reaction to his death.

A Rolling Stone magazine headline said: "Henry Kissinger, war criminal beloved by America's ruling class, finally dies".

Ear, a scholar at Arizona State University who studies Cambodia's political economy, wrote on The Conversation.

"The cluster bombs dropped on Cambodia under Kissinger's watch continue to destroy the lives of any man, woman or child who happens across them," Sophal Ear noted.

Youk Chhang, the head of the independent Documentation Centre of Cambodia, described Kissinger's legacy as "controversial" though not widely debated in the country.

He said well over half of Cambodia's population was born after the Khmer Rouge were ousted in 1979, and even those who lived through the civil war and the group's brutal rule recall the US involvement and its B-52 bombers, "but not Henry Kissinger".

Kissinger initiated the Paris ultimately negotiations that provided a face-saving means to get the United States out of a costly war in Vietnam.

Nixon's daughters, Tricia Nixon Cox and Julie Nixon Eisenhower, said their father and Kissinger enjoyed "a partnership that produced a generation of peace for our nation".

"Dr Kissinger played an important role in the historic opening to the People's Republic of China and in advancing détente with the Soviet Union, bold initiatives which initiated the beginning of the end of the Cold War," the Nixon daughters

said in a statement.

'shuttle "His (Kissinger) diplomacy' to the Middle East helped to advance the relaxation of tensions in that troubled region of the world," the Nixon daughters added in the statement.

Former British Prime Minister Tony Blair meanwhile said he was "in awe" of Kissinger.

"Of course, like anyone who has confronted the most difficult problems of international politics, he (Kissinger) was criticized at times, even denounced," Blair said.

He added: "But I believe he was always motivated not from a coarse 'realpolitik,' but from a genuine love of the free world and the need to protect it. He was a problem solver, whether in respect of the Cold War, the Middle East or China and its rise.'

For his part, Israeli President Isaac Herzog said as he met US Secretary of State Antony Blinken in Tel Aviv that Kissinger "laid the cornerstone of the peace agreement, which was later signed with Egypt, and so many other processes around the world I admire."

Blinken said that Kissinger "really set the standard for everyone who followed in this job" and that he was "very privileged to get his counsel many times, including as recently as about a month ago".

"Few people were better students of history. Even fewer people did more to shape history than Henry Kissinger," Blinken said.

Russian President Vladimir Putin said in a message to Kissinger's wife that he was "a wise and far-sighted statesman".

He elaborated: "Kissinger's name is inextricably linked with a pragmatic foreign policy line, which at one time made it possible to achieve détente in international tensions and reach the most important Soviet-American agreements that contributed to the strengthening of global security."

French President Emmanuel Macron wrote on X, formerly known as Twitter, that "Henry Kissinger was a giant of history", adding: "His century of ideas and of diplomacy had a lasting influence on his time and on our world."

Leaders of Kissinger's native Germany paid tribute to the former diplomat, a Jew who fled Nazi rule with his family in his teens.

"His commitment to the transatlantic friendship between the United States and Germany was significant, and he always remained close to his German homeland," Chancellor Olaf Scholz wrote on X.

In a message of condolences to Kissinger's family, German President Frank-Walter Steinmeier wrote that "with his détente and disarmament policy, Henry Kissinger laid the foundation for the end of the Cold War and the democratic transition in eastern Europe" which led to Germany's reunification.

'nequality is a well-known and accepted fact of life because human beings cannot be equal financially, thinking capacity, wealth, working environment and many other aspects of life. However, despite the said differences in our ordinary life, this is not a hindrance for people to enter into business or joint income generating activities as they deem fit.

In doing business in the form of either partnership or limited liability company, differences might occur such as division of profit or the manner of running the entity.

In a company setup, subject to rights which may be attached to certain class of shares (for example preferential or founder shares) ordinarily, powers of making decision for the company, voting rights and general day-to-day running of the company is attached to the extent of shareholding percentage which a person or an entity owns in that company

It is not uncommon for minorities to feel like they are being ignored or their opinions are not being taken into consideration or regarded in the same priority compared to their majority counterparts. This is due to the fact that their investment in the entity is minimal and consequently, their extent of loss is also minimal compared to the majority shareholders.

In case of differences which parties fail to resolve amicably, the aggrieved shareholder can seek intervention of the court of law through legal process so that each person can be comfortable with his or her investment in the company. Just like the most celebrated principle of democracy that majority rules and minority rights, in order to safeguard minority rights in a company setup, company law has put in place the concept of unfair prejudice in which rights of minority or any interested person in the affairs of a company who forms an opinion that the company operations are prejudicial to him or her can seek protection by knocking the doors of a court of law. This article discusses the above concept at length with-





in the parameter of the company law.

Unfair prejudice

The concept of unfair prejudice allows minority shareholders to seek remedies for any violation against majority shareholders in case there is reasonable grounds to believe affairs of the company are being conducted in a manner which is unfairly prejudicial to their interest.

In the landmark case of Ebrahimi vs Westbourne Galleries Ltd (1973) AC 360, the court recognized that the fiduciary relationship between shareholders and the company is not limited to the majority shareholders. Rather, minority shareholders have legitimate expectations regarding company affairs. In simple language, unfair prejudice is just oppression against the minority shareholders in a company. This doctrine is available in section 233 of the Company Act No 12 of 2019.

Unfair prejudice can be in various forms such as breach of the article and memorandum of association where majority shareholders deliberately opt to devalue company shares, excessive award of the directors without any good

basis, mismanagement of the company, company operating at loss, diversion of business to another company in which the majority shareholders hold interest, abuse of power in discharging company transactions, failure to hold annual general meetings, failure to divide dividends to the shareholders when there is justification of super profit in the company. This list is infinite and varies from case to case/

Elements to prove unfair prejudice

Granting or denying an order of unfair prejudice is a discretion power vested upon any trial court invited by petitioner to issue the said order. However, when a trail court exercises its discretion power, it cannot act arbitrarily or haphazardly but within established sound principles of the law.

Four elements are required to be proved so that the trial court can exercise its discretionary power to grant an order of unfair prejudice. These were well stated in the Misc Commercial case No 20 of 2022 between Velisas Elizabeth Deflosse Ingleton vs Joseph Ignature Nuronha and others.

They are (i) the conduct of the com-

pany affairs whereby the court looks at whether the claim is premised on the article of association (constitution of the company) or signed agreement which bind either shareholders or directors of the company and see whether there is violation of the same or not.

Next is (ii) prejudice whereby the court examines the act itself if it is oppressive to the petitioner. Prejudice can be in various forms such as exclusion from decision-making, dividend discrimination, breach of fiduciary duty or oppression of minority rights.

Another one (iii) is unfairly which tests if action or omission done is unfair or not objective. Courts normally regard prejudice claim as unfair if a hypothetical reasonable bystander would believe it to be unfair. Further, fairness is judged in the context of commercial relationship and contractual terms which are set either in the memorandum and articles of association

And (iv) is petitioner interest as a member of the company. There should be a link between the claim and interest of the petitioner in the company. In short, locus is obtained to present the claim once you establish an interest in the company.

Remedies

Once it is proved that operations of the company is unfair prejudicial to a member of the company, the court of law is vested with discretionary power to issue a wide range of orders with the purpose of ensuring that affairs of the company are operated fairly to members of the company and in accordance with the law.

The orders may include injunction or refraining the company from doing or continuing to do what has been complained about, restoration of shares if the same was taken away, damages in

terms of monetary compensation and the most common which is share buyout. This is an order against the majority shareholders to purchase minority shares in the company. Many other orders may be issued by court depending on the circumstances of the case presented.

How to institute a case

Any shareholder (minority or majority shareholders) or any interested person such as legal representative may bring claim of unfair prejudice in court of law. The law stipulates that such a case should be preferred to the High Court which it is the court with mandate to deal with such disputes.

The application is taken to court by way of petition and the claimant is called the petitioner. Grounds which show the unfair prejudice should be well particularized in the petition intended to be filed in court.

Lastly, apart from having in place proper article of association, shareholders may enter into agreement in which various affairs of running a company are provided. It is one of the important legal documents which courts of law look into in case of any dispute between the shareholders.

Salvadoran rural communities face climate injustice

OR decades, poor fishing and farming communities in southern El Salvador have paid the price for the electricity generated by one of the country's five dams, as constant and sometimes extreme rains cause the reservoir to release water that ends up flooding the low-lying area where the families live.

Dozens of communities located in the Bajo Lempa area in southern El Salvador suffer year after year from flooding during the May to November rainy season, when the river overflows its banks and floods corn, beans, and other crops, as well as affecting fishing and other livelihoods.

The ecoregion is the lower stretch of the Lempa River basin, which runs through three Central American countries: it originates in Guatemala, crosses part of Honduras, and then enters El Salvador, where it meanders from the north until flowing into the Pacific Ocean in the south of the country.

The Lempa River basin covers 18,240 square kilometers, shared with Honduras (30 percent) and Guatemala (14 percent). In El Salvador, it stretches across slightly more than half of the territory of just over 21,000 square kilometers.

are left with nothing," said Menjívar, 41. In addition to subsistence farming, a group of some 50 families set up a cooperative for the organic production of cashew nuts, which they were able to export to the United States, France, and the United Kingdom after achieving certification as organic producers.

But rising production costs and competition from cheaper prices, especially from India, have hampered exports in the last two years. The cooperative is therefore looking to promote new products, such as pistachios and peanuts.

"We have made an effort to ensure that the farmers can at least sell their cashew seeds" on the domestic market, the cooperative's administrative coordinator, Brenda Cerén, told IPS.

Impact on the most vulnerable

Most of the residents of Bajo Lempa were part of the Farabundo Martí National Liberation Front (FMLN) guerrillas, who settled on the riverbanks after receiving land in the region as part of the demobilization process at the end of the civil war in 1992.

El Salvador's bloody civil war (1980-1992) left some 75,000 people dead and 8,000 missing in a country that currentson did not produce flooding because the storms began late, and this meant that the drainage channels, located along the road leading to the area, did not fill up and were able to handle the rainfall at the end of the rainy season in November.

Increasingly unpredictable and extreme rainfall periods, due to climate change, generate intense storms in short periods of time, and, as a consequence, the reservoir's capacity is easily exceeded and water releases are authorized.

Hence, the poor families of Bajo Lempa pay the cost of the dam's ability to generate electricity for other parts of the country, including those that generate the most income, such as industrial groups and real estate consortiums, whose business activities are among those that have the greatest impact on the environment.

This situation falls under the category of climate justice, or, actually, climate injustice: vulnerable groups are more heavily impacted by extreme weather events fomented by others, whether at the national or global level.

"Certainly there is climate injustice: richer people or sectors of the country, Mitch, a category 5 hurricane, the most lethal, caused such heavy rains that the hydroelectric dam filled in a matter of 36 hours and went from discharging 500 cubic meters per second to 11,500 cubic meters per second, according to a study on flooding in the Lower Lempa.

"During Mitch, I lost 40 heads of cattle; they drowned," Luis Avilés, a farmer from the Taura community, told IPS.

"Where we live is like living with a chronic illness; year after year we have this anxiety: wondering whether it will flood a lot this year, if I'll lose my crops, not knowing whether to plant or not," said Avilés, 53.

Embankment on the verge of collapse

A crucial issue in the impact of the floods is the damage that has been suffered over the years to the levee built with Japanese aid funds years ago and which has not been repaired since then, residents of Bajo Lempa told IPS.

The elevation made of different materials on the river bank to contain the overflowing waters runs 18 kilometers along the right bank of the river, from the Cañada Arenera community, in the municipality of San Nicolás Lempa, to the community of La Pita, near the river's mouth. "This wall protects the communities of Santa Marta, San Bartolo, Rancho Grande, Taura, Puerto Nuevo, Naranjo, and La Pita, and if it were to collapse, it would be a great tragedy," said Avilés, also a former guerrilla fighter.

The deterioration of the stone embankment is clearly visible along its five-kilometer length.

The rest of the dike is not a stone wall but an earthen elevation about two meters high, and it is also damaged.

The repair and maintenance of the embankment is one of the main demands of the inhabitants of Bajo Lempa, but it has never been efficiently addressed by any of the past governments.

Compensation for damage

Avilés said it is obvious that the country needs to generate electricity "because many sectors, factories, industry, and homes depend on it, but we should also consider the cost that we pay down here," referring to the energy produced by the 15 de Septiembre power plant.

This dam and the other four in the country are managed by the state-owned Comisión Ejecutiva Hidroeléctrica del Río Lempa (CEL). For this reason, he and the other people interviewed argued that the government should take responsibility for the damage and losses caused to the families of Bajo Lempa and create an indemnity or compensation fund.

Avilés said that last year, when there was light flooding, he lost his crop of plantains or cooking bananas, which he had planted on a two-hectare plot. He went to claim compensation from CEL for the 15,000 dollars he had invested.

"They told me that they had nothing to do with it, that the dam was above us and the flooding was below," he said.

Environmental activist Gabriel Labrador, of the NGO Salvadoran Ecological Unit (UES), told IPS that these families have every right to demand an economic compensation fund for losses and damage.

"It is an injustice—the discharges, the vulnerabilities to which people and territories are exposed—which is a systematic practice that is un-

An estimated 5,000 families live in the 900-square-kilometer Bajo Lempa area. They are dedicated to subsistence farming and fishing and non-intensive cattle ranching, although there are also some families from other regions of the country, with more money, who have acquired land to grow sugar cane.

"In the 32 years that I have lived here, I have been affected just like the rest by many floods," Celina Menjívar told IPS. She is a farmer in San Bartolo, one of the settlements or communities of Bajo Lempa.

"I plant corn, sesame, and cushaw squash (Cucurbita argyrosperma) on a small family plot, but when the floods come, everything is lost, and in the end we ly has 7.6 million inhabitants.

"Most of the flooding is not due to the rains per se, but to the discharges from the reservoir," said Menjívar, referring to the state-owned 15 de Septiembre hydroelectric plant, the country's largest, located upstream between the departments of San Vicente and Usulután, in central El Salvador.

Another resident of San Bartolo, Manuel Mejía, added: "When there are floods here, everything is lost: crops, livestock, even household goods, everything."

Mejía, a 77-year-old former guerrilla fighter, told IPS that this year's rainy sea-

A light rain that falls for two or three days generates releases from the dam and the overflowing of the Lempa River, which floods the settlements. But of course, the most tragic floods have been caused by tropical storms or hurricanes, such as Hurricane Mitch in October 1998.

"We are in the most vulnerable area of the riverbank, the one that receives the strongest impact of the Lempa, because up there it makes a turn and then it flows down with force," said Avilés, standing on the damaged infrastructure: a wall of rocks tied together with wire, about four meters higher than the level of the river.

This segment of the five-kilometerlong levee is indeed the most damaged; the flow of the river has been undermining the base of the wall more and more. just and ends up burdening the most disadvantaged people with more damage and losses," he said.

Meanwhile, the residents of Bajo Lempa, already accustomed to the floods, know that they have no choice but to continue fighting, despite the adversities.



WFP-funded climate-smart agriculture project in Dodoma makes members of a family 'smile'

LIKE most parents, Alex and Grace embrace every opportunity to improve their family's quality of life. Being small-scale farmers in Dodoma, Tanzania, those opportunities have at times been few and far between.

Increasingly unreliable rainfall makes farming a risky business in this area. 'If you plant sorghum or sunflower, and then you fail to get the rains, the crops will fail, so there is a total loss because there has been an investment in seed,' Alex explains.

They also face challenges getting their produce to market and, having overcome that hurdle, there is another: 'the market is selective, so if the product is not of great quality, you can't access it', says Alex.

Alex and Grace aren't people who give up easily though, so when the opportunity arose for Alex to take part in Farm Africa's Climate-Smart Agriculture project, funded by the World Food Programme (WFP), two years ago, they seized it. Alex received training on how to improve the soil, proper use of fertiliser and pesticide, marketing and how to farm crops that are drought resilient, including

sorghum. Before joining the project, I was using local seeds. They

SADC holds stakeholders' consultative workshop on setbacks seen at Zambia's Kasumbalesa border post

THE Southern African Development Community (SADC) Secretariat, in collaboration with the Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ), has conducted a three-day stakeholders consultative workshop bringing together delegates from the Democratic Republic of Congo (DRC) and Zambia.

The workshop was held in Kusaka, Zambia, and was attended by representatives of the two Member States responsible for trade, trade facilitation, customs, security, infrastructure, transport, migration, private sector, transporters associations and International Cooperating Partners (ICPs).

Director of Industrialisation and Trade Department at the SADC Secretariat, Dhunraj Kassee, informed participants that the workshop was being convened in response to the decision of the 43rd SADC Summit of the Heads of State and Governments, in August 2023 in Luanda, Angola, that directed the Secretariat to "constitute an Inter-Ministerial Task Force to find a lasting solution to the continued challenges faced by transporters and drivers at the Kasumbalesa border post,"

Dhunraj Kassee underscored the strategic importance of the Kasumbalesa border post in facilitating the cross-border movement of goods in the SADC region given its location at the confluence of several trade corridors in the region.

These include the North-South Corridors, Dar es Salaam Development Corridor, Walvis Bay-Ndola-Lubumbashi Corridor, Beira represented the GIZ reiterated Development Corridor, and the Lobito Development Corridors.

He indicated that the two countries have made progress in implementing the joint Communique of 6 March 2023 although more still must be done. He specified that the development and upgrading of satellite border posts such as the Sakania border post is part of an integral strategy of diverting traffic away from the Kasumbalesa border post and there contribute towards decongesting the border post.

At the same event, Director of Domestic Trade from the Ministry of Commerce, Trade, and Industry of Zambia, Mrs. Margaret Moonga-Chikuba, indicated the importance that trade has to regional growth and that trade facilitation at Kasumbalesa border post is vital for growth of the two economies. Failure of emergency protocol blamed for deaths of miners

HEN being hoisted to the surface at the end of a long shift underground, a miner generally breathes a sigh of relief. The dangers that lurk in the depths recede as the "cage" which is what it effectively is – ascends to the surface.

On Monday afternoon, 86 Implats mine workers would have been looking forward to returning to the surface and taking a shower. They were spread out among the three levels of the cage, which has a capacity for up to 145 workers. The miners in the bottom level of the cage were unaware that they were in the worst place possible.

Shortly before 5pm on Monday, Implats says, the conveyance lift in 11 Shaft – which is about 1,000m deep, with operations across 20 levels – began its scheduled ascent to 17 Level.

"The conveyance unexpectedly reversed direction and began descending back down through the shaft. The emergency protocol for such an incident was immediately and automatically activated. Regrettably, although the winder rope remained intact, the emergency protocol failed to immediately arrest the lift's rapid descent," the company said.

The winder counterweight became snagged for some reason, which resulted in what Implats described in a statement as an "almost instantaneous deceleration".

It went on to say that the force of this "impacted the 86 employees who were standing upright in the three levels of the lift at the time. Given that the lift was still attached to the winder rope as it slipped, the lift was not in free fall."

"We have 11 people who have lost their lives. We are mourning the passing of these mineworkers and sympathise with the families. This is a disaster which will require a thorough investigation in line with the Mine Health and Safety Act. It has dented our efforts to move to zero harm," Mantashe was quoted as saying in a statement.

"Zero harm" refers to the noble industry, labour and government goal of making mining so safe in South Africa that no one dies on the job.

It would be an understatement to describe it as an elusive target, but massive strides have been

means that at least 52 miners have been killed on the job in 2023, so this year will not be a record year for safety. It is of more than pass-

ing interest to note that much of the safety drive has been focused on preventing "falls-of-ground" (FOG) accidents – which means that a rock above literally falls on you with crushing impact. These have long been the leading cause of death, accounting for almost 40% of mine fatalities in South Africa from 2000 to 2021.

The roll-out of safety netting and bolting in the roof of underground mines has been one of the key factors behind a sharp decline in FOG fatalities. Mechanisation, where South Africa's arduous geology allows it, has also paid huge safety dividends, as it replaces humans with machines in hazardous areas.

But when you are in the cage, you don't expect a rock to fall on your head. There have been accidents involving them, but they are comparatively rare.


On 1 May 2008 - Workers' Day, no less – nine employees at Gold Fields' South Deep mine west of Johannesburg were killed when the conveyance cage they were travelling in dislodged and plummeted more than 60m.

That incident triggered a safety drive under Gold Fields' former CEO Nick Holland, who had just assumed that role at the time. South Deep is now a totally mechanised and heavily automated mine with a sterling safety record. But humans still descend 3km down - and 3km up – the shaft there and do so safely.

Implats said. That means the accident was preventable, but it is too late for the 11 who died and their families, and the 75 survivors who must have had a harrowing time during the rapid descent and its bone-shattering halt.

This point was not lost on the Association of Mineworkers and Construction Union (Amcu), which last year signed a five-year wage deal with Implats, signalling a new era in the union's often combative relationship with capital.

"Amcu has been calling for the amendment of the Mine Health and Safety Act for these company bosses to be really accountable, especially to be charged with culpable homicide. GLOBAL FIRMS COMPETING FOR LITHIUM ASSETS IN TANZANIA

NEVADA

he leading global companies are competing for the development of high-value lithium properties in Tanzania, plus elimination of all cash obligations after transfer of property rights of Titan Lithium, Inc, an emerging company based in Nevada.

Craig Alford, CEO of Nevadabased lithium explorer and developer-CDSG, noted "The results from the initial geochemical sampling are staggering. The size and strength of the Lithium anomaly at Titan 1 is particularly exceptional as it is within an area that has had no previous exploration and both sample lines ended at their northern limit within some of the highest grades of up to 2.79 percent Li2O. These very strong results are being followed up by ongoing sampling and exploration on the Titan 1 Project area."

More results will be announced in the coming weeks, he said.

According to him, vigorous quality control of the samples was maintained and all samples were prepared and analyzed at the independent and ISO 9001-certified African Minerals and Geosciences Centre (AMGC) based in Dar es Salaam.

As part of the work on the largest CDSG Project, Titan 1, two lines of surficial geochemical soil surveys were collected over a section of the nearly 115 square mile (300 sq km) central Prospecting License ("PL").

The lines were run approximately

Northwest-Southeast and spaced 3kms apart.

Results from both lines returned very high Lithium values over extensive distances, two zero values were returned from each line, however, the positive geochemical results indicated lithium values ranging from 100 ppm to highs of 13,000 ppm with average values of 0.55 percent Li2O (2,569ppm Li) over 7.4 miles (12 km) for the westernmost line and 1.14 percent Li2O (5,300ppm Li) over 3.7 miles (6 km) for the eastern line.

Values for sodium, potassium, and magnesium broadly mirror and confirm the distribution of the anomalous lithium values.

Potassium oxide (K2O) values ranged as high as 3.6 percent in the results.

The CDSG Titan 1 PL is centered over a vast, sparsely vegetated, flatlying 'playa' covered by a thin layer of alluvium overlying volcano-sedimentary basin fill.

The area is morphologically and depositionally somewhat similar to the company's WEL project claim area, containing mudstones much like the TLC project (American Lithium Corp.) and the Thacker Pass (Lithium Americas Corp.) projects of Nevada.

The CDSG project is part of a Definitive Agreement with Kilimanjaro Lithium Inc., a private corporation domiciled in Tanzania, whereby CDSG has the exclusive right to earn up to a 100 percent interest in two large Lithium projects, Titan 1 and 2.



Presently, the company has already fulfilled the requirements for 80 percent of the total earn-in on both projects.

To simplify the business descriptions of Titan Lithium (CDSG) and Barrel Energy (BRLL), and how they associate with each other, CDSG is the company's lithium resource holdings company and BRLL is the technology company.

"Management of both companies is very excited to continue the announcements of advancements in Lithium resources, especially, in sharing the completion of the agreement relating to our claystone extraction technology," the company statement says.

On November 22nd, CDSG announced that the companies' board of directors is presently evaluating strategic proposals for future rapid development of the Titan projects in Tanzania.

Due to the uniquely strong Lithium results returned during exploration, CDSG has received several proposals in relation to the development of the Titan projects.

Both Titan 1 and Titan 2 have attracted a high degree of interest from a number of potential strategic partners, including global industry leaders in the mining industry.

In reviewing the received proposals, the management and board of directors of CDSG are deeply committed to both maximizing value for shareholders of the Company, as well as for the communities near the projects, and for the viability of an actual robust production timeline for these world-class projects.

Management expects that any potential strategic partner will be

committed to contributing to the success of CDSG, supporting the interests of Tanzania, and contributing in a major way to the supply chain to major Electric Vehicle markets.

On November 20th CDSG announced that as a result of restructuring, the company has no further cash payment obligations for 100 percent ownership of the Titan 1 and Titan 2 Prospecting Licenses and that all claims to Net Smelter Return ("NSR") holdings have been relinguished.

The restructuring will result in a \$6,275,000 reduction in payments and potential ownership of NSRs for the company on the projects.

"The Titan Lithium Projects are proving to be world-class standouts in both size and grade," commented Craig Alford, CDSG CEO.

"Gaining full ownership of the projects is an enormous step forward for the Company and its shareholders."

On November 17th CDSG made a major announcement reporting it has completed the full transfer of 100 percent interest in the Titan 1 and Titan 2 Prospecting Licenses in Tanzania into the company's' Kilimanjaro Lithium Ltd subsidiary.

Mineral rights in Tanzania are held under a number of types of licenses granted under the country's comprehensive mining act.

Exploration projects are held by a Prospecting License ("PL") which allows the holder to conduct a wide range of exploration work until

such a time as a mining license is required for exploitation.

The vendor completed the transfer of 100 percent of the two Prospecting Licenses for Titan 1 and Titan 2, PL 12353/2023 and PL 12338/2023, into CDSG on November 14, 2023.

The Prospecting Licenses that were transferred were duly recorded pursuant to section 123(1) of the Mining Act in the central register on November 16, 2023.

The two PLs are considered prospective to the discovery of sediment-hosted lithium-style mineralization within a country rich in mineral resources.

Tanzania is endowed with many types of minerals including gold, iron ore, nickel, copper, cobalt, gemstones, industrial minerals as well as rare earth minerals.

Tanzania is the fourth largest gold producer in Africa and home to advanced critical mineral projects such as graphite, lithium, and the high-grade nickel-copper-cobalt Kabanga deposit.

Earlier this year, under a Presidential plan to fast-track such deposits, Tanzania signed agreements worth \$667 million for graphite and rare earth projects with several Australian mining firms.

Also, in February 2023, EV maker Tesla signed an agreement under which it will purchase between 17,500 to 35,000 tons per annum of Anode Active Material (AAM) from a producer in Tanzania.

Bread-making makes PLWH in Iringa lead improved lives

People living with HIV/ Aids in Iringa Region are leading much-improved lives now through earning income, after establishing a bread baking project based in Isoka street, Mwangata Ward, in Iringa municipallity.

Akiba Lwisa, Itika Group's secretary said this recently when briefing journalists and USAID mission director who visited the group to see the impact of the "Hebu Tuyajenge" project as part of commemorating 20th anniversary of the US President's Emergency Plan for AIDS Relief (PEPFAR) achievements in the fight against HIV/Aids in Iringa region.

This has been possible

implemented by the National council of People Living with HIV/Aids in Tanzania (NACOPHA) with funding from the PEPFAR and the United States Agency for International Development (USAID).

He said Itika group is among 32 empowerment groups in Iringa Region benefiting from USAID and

PEPFAR support.

NACOPHA trained beneficiaries on how to make high quality bread, save money, obtain loans from the Village Community Bank (VICOBA), financial management, marketing and business plan writing.

They were also encouraged to enroll for National Health Insurance scheme, assess the nutritional status in their family especially low-income earners.

and skills gained from the project, they have been able to establish a bread baking project and establish a Village Community Bank (VICOBA).

> "The fund we get from selling bread products, enabled register for the National Health insurance scheme to 14 members, repay loans obtained from Iringa Municipal council, pay rent, purchase school supplies and pay school fees for children," he said.

The breads production has increased from one 25kg bag of wheat flour to three 25kg bag of wheat flour per day.

Members have also abled to deposit 700,000/- into the bank account, and a total of 650,000/- loans have been disbursed to members to set up their own

Loans benefiting members are involved in poultry farming, snacks and bites baking, bakery and food commodities trade.

Also the group has received bakery equipment worth 2mn/- as a seed capital from PEPFAR to set up business that will also improve their nutritional status.

They have also received a generator from NACOPHA to be used in case of a power cut, to prevent discontinuation of baking activities. He lauded USAID, PEP-FAR and NACOPHA for introducing the project because has changed their lives.

He further said, members are now eating three meals a day and set up income generating activities. For her part, Emma Lu-

person lauded USAID and PEPFAR to help people living with HIV/AIDS to obtain treatment.

"Right now we are looking for donors to help us obtain transport facilities, so that we can distribute our bread products," she said.

Deogratius Rutatwa, NACOPHA's chief executive officer says, the project is implemented in 65 district council in Tanzanian mainland.

So far, 32 empowerment groups of people living with HIV/Aids have been established in Iringa Municipal Council.

Members have been able to set up income generating activities and are now involved in farming activities, handcraft business, batik tie and dye, horticulture, grains business, tailoring, bakery, animal rearing, lending and saving schemes.

Hebu Tuyajenge project focuses on increasing utilization of HIV testing, treatment and family planning services among adolescents and people living with HIV, strengthening capacity of people living with HIV organizations and structures, as well as improving the enabling environment for the HIV response through economic empowerment.

He said 4,525 groups of people living with HIV/Aids have been established, 1,792 treatment advocates and 1,150 community action teams that includes youth, women and men living with HIV from 185 districts of Tanzania mainland .

ity for businesses.For instance, in Lagos, many businesses are shying away from rigid long-term leases and upfront costs associated with conventional offices, opting instead for the flexibility and costefficiency inherent in co-working spaces. As of 2020, Nigeria boasted 60 entrepreneurial co-working spaces, surpassing other African nations, with Egypt (59) and South Africa (58) following suit.

The shared amenities offered by coworking spaces eliminate the financial burden of maintenance costs and renting space that isn't used constantly like meeting rooms, enabling businesses to scale up or downsize in response to their requirements without being bound by prolonged leases.

The imperative for affordable housing Africa is grappling with a severe housing deficit, marked by a shortage of at least 51 million housing units (Centre for Affordable Housing Finance in Africa).

Urbanisation and population growth are the prime catalysts for this crisis, leaving governments struggling to meet the surging demand for affordable housing.

On average, over 40,000 people migrate to African cities every day, most of whom cannot afford formal housing or access mortgage loans. This presents an excellent opportunity to provide affordable housing units to address this burgeoning demand.

While Africa remains the most rural region globally, it is urbanising rapidly, exerting immense pressure on urban land and housing provision in the coming decades. Scaling up affordable housing



initiatives can boost national economies, create jobs, revitalise the construction industry, and enhance living conditions and overall well-being for the continent's inhabitants.

For instance, in Nigeria, inadequate housing affects between 14 and 16 million people, while South Africa grapples with a housing shortage of approximately 3.7 million units.

Conversely, Kenya experiences an annual housing demand of 250,000 units but manages to supply only around 50,000 units each year. Various governments have introduced diverse, affordable housing models, but much work remains to satisfy the demand.

The Kenyan Government, for example, launched the Affordable Housing Program in 2017 to deliver 500,000 units

by December 2022. However, it's worth noting that this initiative has struggled to attain its full potential due to financial constraints arising from inadequate budgeting, resulting in various projects stalling.

To further bolster this programme, the Kenyan government has established the National Housing Development Fund (NHDF) to provide funding, targeting the construction of 200 units per constituency.

Data centres

The demand for data centres is also soaring across countries like South Africa and throughout the continent as the world progresses towards a more interconnected and automated future. With the rise in online retail, catalysed largely by the pandemic, requirements for data centres have flourished across the continent.

Data centres provide a cheaper and more efficient IT capability than inbuilt servers, which is aiding their popularity. They also offer cloud services and allow organisations to focus on their core functions.

The African data centre market is projected to experience significant growth in terms of investment, with a Compound Annual Growth Rate (CAGR) of approximately 15 percent from 2020 to 2026. In 2020, the market size in terms of investment was valued at US\$ 2bn, and it is anticipated to reach US\$ 5bn by 2026. Investors such as the Agility Logistics

Park (ALP), have already recognised the burgeoning demand for data centres in Africa. The firm recently launched four master-planned data centre campuses in Egypt, Ghana, Saudi Arabia, and Kuwait.

Upon completion, these campuses will contribute a substantial 275,000 sqm of cutting-edge centre capacity to ALP's existing infrastructure in the Middle East and Africa.

However, there is still more work to be done to meet the continent's expanding digital needs. Currently, Africa represents less than 1 percent of the global colocation data centre supply, with South Africa being the main contributor to the continent's capacity.

According to The African Data Centres Association (ADCA), Africa requires approximately 1,000MW of power and at least 700 additional facilities to address the growing demand. This underscores the untapped potential in the African data centre space, which is primed for further development and investment to bridge this digital divide and foster the region's technological advancement.

Overall, untapped opportunities abound in diverse facets of the African real estate sector, with particular emphasis on co-working spaces, affordable housing, and data centres. With Africa's population poised to double by 2050, these opportunities must not be overlooked. Other opportunities lie in specialised residential developments, such as retirement homes, addressing the needs of a growing middle-class elderly population in Africa.

Mumbai property registrations increase over 3pc

MUMBAI

Mumbai's real estate market reported 9,255 property registrations in November, according to data from the Maharashtra Inspector General of Registrations and Stamps (IGR), as of 11 am on November 30. The state also raked in Rs 677 crore in revenue from property registrations during the period.

In November 2022, the number of registrations stood at 8,965.

Revenue collection, though, saw a minor 1 percent fall from Rs 684 crore in November 2022 to Rs 677 crore this year, according to the Maharashtra government data.

This comes on the back of a strong showing a month earlier. In October 2023, 10,244 properties were registered in Mumbai, a 21 percent year-on-year spike over October 2022. Revenue collections rose 11 percent in October this year to Rs 809 crore from Rs 723 crore in October 2022, according to the data.

Of November's overall registered properties, residential units constituted 80 percent, going by from Knight Frank India. According to the real estate consultancy, the month reported 9,000-plus property registrations despite fewer working days due to a slew of holidays given the festival season.

"In November 2023, Mumbai is set to achieve its most successful November in the past 11 years for property registrations, highlighting the enduring strength of the residential real estate sector. This success is driven by factors such as increasing income levels and a

positive outlook on homeownership, reflecting the unwavering trust of property purchasers in the city's real estate market," Knight Frank India said in its report.

Of the total properties registered, the city's central and western suburbs together constituted over 75 percent as these locations are a hotbed for new launches offering a wide range of modern amenities and good connectivity, according to a Knight Frank India analysis.

Eighty-six percent of western suburb buyers and 85 percent of central suburb purchasers opt to buy within the micro market they were already residing in. This choice was influenced by the familiarity of the location, along

with the availability of products that align with their pricing and feature preferences, the analysis added.

2023 performance

In the 11 months of 2023, the city achieved a registration count of 114,069 units, resulting in a substantial revenue accumulation of Rs 9,895 crore for the state treasury. This stands as the highest within the same timeframe since 2013, said the Knight Frank India report.

This surge in property registrations has notably bolstered the Maharashtra government's coffers. The elevated revenue growth can be attributed to factors like registration of highervalue properties and augmented stamp duty rate, according to the Knight Frank India report.

Outlook 2024

In its report Outlook 2024 released on November 29, Knight Frank India stated that the residential, office and warehousing markets will remain buoyant next year. It said that Mumbai is expected to see a 5.5 percent increase in prime residential prices in 2024, driven by high demand and strong economic growth.

"The residential sector exhibits substantial growth potential, underscored by sustained demand over the past few years. Notably, there is a pronounced demand for mid- and high-priced residential properties. The resilience of the Indian economy has also

High-value transactions Further, the Knight Frank India analysis for November 2023 property registrations in Mumbai said that in recent years, there has been a consistent upward trend in the percentage of registrations for properties valued at Rs 1 crore or more. This proportion has risen from 51 percent in January to November 2020 to approximately 57 percent in January to November 2023.

"The increase in property prices, combined with a significant 250 basis point rise in the policy repo rate during the last two years, has had a negative impact on the registration of properties below the Rs 1 crore threshold. However, registrations for properties valued at Rs 1 crore and above have shown a relatively limited impact of these changes," the analysis said.

CHINA'S SHATTERED PROPERTY BOND MARKET FINDS HOPES IN SUNAC DEAL

BEIJING

or two hours on an early February morning, Sunac China Holdings Ltd. Chief Financial Officer Gao Xi delivered a tirade against bondholders — hitting the table as he told them the distressed developer had already made its best offer.

The negotiations were fraught enough that some creditors considered walking away during lunch. But Gao returned that afternoon with an apology, paving the way for a restructuring deal that took effect last week and marked the first of its kind by a major Chinese builder since Beijing's deleveraging push three years ago set off a historic industry crisis.

With much of China's financial world now fixated on the troubles at rivals including China Evergrande Group – which faces potential liquidation in a court hearing on Monday - Sunac represents a glimmer of hope for the \$194 billion dollar-bond market for Chinese developers. The company's rocky path to an agreement, pieced together from accounts by more than 10 people familiar with the negotiations, offers a potential roadmap for dozens of distressed developers.

"Sunac just shows restructuring can be done," said Richard Ong, co-chairman of RRJ Capital, one of the creditors. "They should

The deal was noteworthy because it reduced Sunac's debt, instead of just bond payment extensions as commonly in other talks, with Sun's stake diluted to under 25% from almost 40%, according to S&P Global Ratings.

"As bondholders, we are more than willing to work cooperatively with companies like Sunac which has been proactive in its approach toward finding a solution that takes into account the challenges faced by the property sector in China but at the same time, balances the interests of the bondholders and other stakeholders," said Sandeep Gupta, managing director at Broad Peak Investment Advisers Pte Ltd. White list

In a sign that Beijing wants to put a floor to the distressed sector, regulators are drafting a list of 50 developers eligible for a range of financing, Bloomberg reported Nov. 20. It's not known if Sunac is

on the list.

While the news sent developer stocks rallying, bonds of distressed companies were largely unchanged, an indication of the pessimism among creditors. All the bonds of Evergrande are trading under less than two cents on the dollar, while Sunac's newly-issued debt are at between nine cents to 16 cents on the dollar, according to Bloomberg-compiled data.

Still, other developers are following in the footsteps of Sunac. Yuzhou Group Holdings Co. may finalize a debt restructuring plan in months, people familiar with the discussions said. Yuzhou didn't reply to Bloomberg's query. China Aoyuan Group said it obtained sufficient support from creditors on Tuesday for a restructuring plan.

Sunac, however, still faces the fraught challenge of generating steady cash flows in a market where demand for homes has plummeted. It needs to achieve at least 15 billion yuan in monthly sales, said Xu Liqiang, fixed income deputy director from Shanghai Silver Leaf Investment Co., citing a presentation made in July.

The company posted just 4.76 billion yuan in contracted sales for October.

Sunac will probably get on the list for state support, which may "create a positive feedback loop on its home sales and funding access," said Zerlina Zeng, senior credit analyst with CreditSights. "That said, for the company to survive and thrive over the longer term, we still need to see a more sustained recovery of home sales and a stabilizing of prices in the secondary markets."

Briefing The Guardian yesterday over the development, the training chief facilitator, Justin Elly Mgeni expressed that, among oth-

ers, the training was tailored to help building awareness from the negative mindset about bees and beekeeping itself among the participated staff.

And he explained that, bee makes excellent pollinators because most of their life is spent collecting pollen, a source of protein that they feed to their developing offspring.

"The most important thing that bees do is pollinate. Pollination is needed

"When a bee collects nectar and pollen from the flower of a plant, some pollen from the stamens-the male reproductive organ of the flower-sticks to the hairs of her body. When this happens, fertilization is possible, and a fruit, carrying seeds, can develop," he detailed

Dubai bucks global dip in super-prime house sales

DUBAI

Bucking a global downward trend in super-prime residential sales, Dubai again led the world ranking of quarterly deals in this category of residences priced above \$10 million.

A super-prime intelligence report by global property consultant Knight Frank on home sales across 12 markets covered in the three months to September finds that along with Dubai, four other markets saw volumes rise through the last quarter on a year-on-year basis, beating the general decline in this sector.

In Q3, global super-prime residential sales fell 2.4 per cent on a yearon-year basis, with 362 sales across

the 12 markets covered in the three months to September compared to 371 in the same period last year.

"Dubai once again leads the ranking of quarterly sales, a position it has held since Q4 2022. London follows in second position, with Hong Kong sitting in third place," Knight Frank said in its study.

The super-prime market is driven more than most by new-build completions. "Strong sales volumes in 2021 were flattered to an extent by delayed completions in 2020. As we move into 2024, the tailwind from new build sales will weaken as the lower volume of new projects starts through the pandemic begins to be felt.

The volume of super-prime homes sold in Dubai, priced at over \$10 million, totalled \$1.59 billion during Q3, according to Knight Frank's finding.

PNC Menon, chairman of prime property developer Sobha Group, said the data is not surprising as Dubai remains one of the most sought-after destinations for the world's super-rich, thanks to the city's overarching appeal as a safe and splendid melting pot of diverse nationalities and cultures.

"The remarkable growth of Dubai's property sector could be attributed to factors like economic stability, consistent innovation, infrastructure development, and a cosmopolitan lifestyle. The outlook for the city's realty sector is very bright as Dubai will continue to witness a steady surge in population over the years," said Menon.

"Demand for luxury homes in Dubai remains resilient and supply continues to stubbornly lag demand. The total number of \$10 million home sales in Dubai for the first nine months of the year has hit 277, a record high with three months of the year still left to run. This builds on Dubai's emergence as the world's busiest \$ 10 million+ sales market during H1, ranking ahead of New York (125), Hong Kong (109), and London (99)," said Faisal Durrani, partner-head of Research, Middle East & Africa.

The cessation of all military activities and the entry of humanitarian aid to Gaza will continue, according to the statement.

In another statement to Qatar News Agency, the spokesperson confirmed that efforts aimed at reaching a permanent ceasefire in the Gaza Strip were ongoing.

Only eight hostages will be released by Hamas on Thursday, according to several Israeli media, as the two Israeli-Russian women released by Hamas earlier on Wednesday will be included in the hostage list for Thursday. In exchange, 30 Palestinians will be released from Israeli prisons.

Overnight, both sides just completed the sixth round of release as part of the truce agreement. A total of 14 hostages, including 10 Israelis and four Thais, were freed on Wednesday night and received by Israeli hospitals for treatment and monitoring on Thursday morning, while 30 Palestinians were released from Israeli prisons.

Meanewhile, amid talks to extend the ceasefire in Gaza, Israeli Prime Minister Benjamin Netanyahu reiterated on Wednesday that his country will resume the military campaign to eradicate Hamas.

"There is no situation in which we do not go back to fighting until the end. This is my policy," Netanyahu said in a video statement Wednesday afternoon, adding that the entire security cabinet and government, the soldiers, and the Israeli people are all "behind it."

"From the start of the war, I set three goals: eliminating Hamas, returning all of our hostages, and ensuring that Gaza will never again go back to being a threat to the State of Israel. These three goals still stand," he stressed.

Netanyahu noted that in the past week "a very great achievement" was made, referring to the return of dozens of hostages, among approximately 240 kidnapped by Hamas militants in their deadly attack on southern Israel on Oct 7.

With the truce set to expire on Thursday, intensive discussions are underway to secure a second extension to the ceasefire that will see more hostages released, and more humanitarian aid delivered to Gaza.

On Wednesday, Turkish President Recep Tayyip Erdogan said Türkiye will step up its efforts for the release of the hostages and establishment of a lasting truce in the Gaza Strip.

"We will accelerate our contacts to release the hostages and make the ceasefire permanent," Erdogan said on X, formerly known as Twitter, on the occasion of the International Day of Solidarity with the Palestinian People.

The Turkish government continues to dispatch humanitarian aid for the people of Gaza and has so far sent 12 relief planes and one ship to Egypt, according to Erdogan.

A second ship carrying 1,500 tons of humanitarian aid set sail earlier on Wednesday, according to the Turkish president.

Former US secretary of state Henry Kissinger dies at age 100

NEW YORK

FORMER US secretary of state Henry Kissinger died on Wednesday at home in Connecticut at the age of 100, Kissinger Associates, Inc said in a statement.

As Secretary of State under presidents Nixon and Ford, Dr Kissinger "played central roles in the opening to China, negotiating the end of the Yom Kippur War in the Middle East, and helping to bring America's role in the Vietnam War to a close," said the statement.

Dr Kissinger has written 21 books on national security matters, it said. "Considered one of America's great statesmen, Dr Kissinger was regularly consulted by American presidents of both political parties and scores of foreign leaders after he finished government service in 1977."

Fifty-two years ago when China and the United States were at a crucial inflection point, Chairman Mao Zedong, Premier Zhou Enlai, President Richard Nixon and Dr Kissinger, made the right decision for China-US cooperation and launched the process of normalizing the China-US relationship.

Kissinger visited China more than 100 times, the most recent one being in late July this year, about two months after he celebrated his 100th birthday, during which Chinese President Xi Jinping met him in Beijing.

On Oct 24, Kissinger was honored at the annual Gala Dinner of The National Committee on US-China Relations in New York City. All guests gave the distinguished centenarian a standing ovation when Kissinger was



wheelchaired onto the stage. And most of them kept standing up until he finished his over 10-minute speech.

He reaffirmed Egypt's continued efforts to accelerate the delivery of humanitarian aid to the Gaza Strip in order to alleviate the worsening humanitarian crisis there.

Separately, two young men were killed by Israeli gunfire in the West Bank city of Jenin on Wednesday, raising the death toll of Palestinians in the region to four, sources said.

Israel receives 6th batch of hostages released by Hamas, says assault will resume as truce ends

JERUSALEM

THE Israeli government confirmed late Wednesday night that the sixth batch of hostages released from the Gaza Strip by Hamas has returned to Israel.

The 16 hostages, including 12 Israelis -- some holding dual citizenship -and four Thai nationals, will undergo an initial medical examination before being escorted by security forces to hospitals to reunite with their families, according to statements issued by the Israeli Prime Minister's Office and Israel Defense Forces (IDF).

The four-day humanitarian ceasefire between Israel and Hamas, scheduled to expire on Tuesday morning, was extended by two days, the Qatari Foreign Ministry said on Monday.

Israel did not comment on the extension, but said early Tuesday that it approved the release of 50 more female Palestinian prisoners if "more Israeli hostages are released."

More than 200 hostages were taken to Gaza by Hamas militants during their Oct. 7 surprise attack on Israel,

which retaliated by launching deadly airstrikes and a ground offensive in the Gaza Strip.

Israel was widely reported to have insisted that all women and children be released under the framework of the current ceasefire deal, which provided for 50 Israelis to be freed in the first four days of the truce, and the release of 10 Israeli captives for an extra day's pause.

In a first, newborn star's spinning disk seen in another galaxy

WASHINGTON

Our sun and other stars form when a dense clump of interstellar gas and dust collapses under its own gravitational pull. Once a star is born at the center of such a cloud, leftover material forms a swirling disk around it that feeds stellar growth and often gives rise to planets.

Newborn stars with these circumstellar disks had been observed by astronomers only in our Milky Way galaxy - until now. Researchers said on Wednesday they have spotted such a disk around a star larger and more luminous than the sun residing in one of

our nearest neighboring galaxies, the Large Magellanic Cloud.

The star, growing and accreting material from the surrounding disk, is about 10 to 20 times more massive than the sun and perhaps 10,000 times more luminous.

As material is drawn by gravity toward a forming star, it flattens into a spinning disk. The newly observed disk has a diameter of about 12,000 times the distance of the Earth to the sun, or roughly 10 times larger than the one that encircled the sun when it formed approximately 4.5 billion years ago. The star, which also is unleashing

a large jet of material into space, is around 160,000 light years from Earth. A light year is the distance light travels in a year, 5.9 trillion miles (9.5 trillion km).

"This is very exciting," said astronomer Anna McLeod of Durham University in England, lead author of the study published in the journal Nature.

"While we know of many stars like this one being formed in the Large Magellanic Cloud and other galaxies, we have never before observed a circumstellar accretions disk outside of the Milky Way, mainly due to lacking technology. Observing these disks in other galaxies is very important because it tells us about how stars form in environments different from that of the Milky Way," McLeod added.

The detection was made using the Atacama Large Millimeter/submillimeter Array (ALMA) telescope in Chile's Atacama Desert. Until now, circumstellar disks had been detected only within about 6,500 light years of Earth.

The Large Magellanic Cloud is considered a satellite galaxy of the sprawling Milky Way, as is another galaxy called the Small Magellanic Cloud. Both are smaller than our galaxy and offer different galactic conditions. The

"The EU is also launching a helicopter deployment for hard-to-reach areas in Somalia via the European Humanitarian Response Capacity. This deployment is expected to be launched in December 2023 and last for two months," it said in a statement reaching Xinhua.

The El Nino-induced heavy rains and flash flooding have killed nearly 100 people and affected more than 2.3 million others in Somalia, according to the Somali government. In Ethiopia, the EU said 1.1 million dollars will support humanitarian partners already present in the flood-affected areas.

"The support will be mainly through multi-purpose cash transfers and the distribution of shelter and essential items, including for water purification and treatment," the EU said.

It said the latest funding is in addition to the immediate assistance already being provided on the ground in the Somali, Oromia, and Southern Nations, Nationalities and People's regions.

The raging floods have left at least 46 people dead in Ethiopia while more than 50,000 others have been displaced across the country. According to the EU. 548,000 dollars was allocated to Kenva where heavy rainfall and landslides have particularly affected areas previously hit by a severe drought -- the northeast part of the country.

Nearly 270 people have been killed and more than 900,000 displaced by floods caused by ongoing rains in the Horn of Africa, said the Climate Prediction and Applications Center (ICPAC) of the Intergovernmental Authority on Development Wednesday.

Kenya, Ethiopia and Somalia are the worst hit by the current El Nino rains and the Indian Ocean Dipole weather phenomena, the ICPAC said in a report, stressing that Somalia and Kenya have borne the brunt of these climate-induced rains, ongoing for over a month.

"The Horn of Africa is currently facing intense rainfall and flooding attributed to El Nino. This has resulted in the loss of lives, both human and animal, and significant displacement in Somalia, Kenya and Ethiopia," the institution said. Local authorities reported nearly 100 deaths in Somalia, 120 in Kenya and 46 in Ethiopia due to the severe weather.

The ICPAC said that Somalia has the most displaced individuals at 700,000, followed by Kenya at 136,000 and Ethiopia at about 50,000. The total population affected by floods, according to the ICPAC, is estimated to be over 1.5 million in Somalia, 950,000 in Kenya and 101,890 in Ethiopia. The report also indicated extensive destruction of farmlands due to the floods across the three countries.

As an "enabler" for social development, AI primarily serves to enhance human wellbeing, thus it is important to ensure the robustness and safety of AI technology, said Zeng Yi, director of the International Research Center for AI Ethics and Governance of the Institute of Automation of the Chinese Academy of Sciences.

China explicitly emphasizes a people-centered approach in the Global AI Governance Initiative, which proves that the initiative is globally oriented and aims to benefit all humanity, Zeng added.

"The risks associated with AI technology are characterized by their hidden nature, cross-domain impact, global reach, and long-term effects. Capital's pursuit of profit may lead to the alienation of technology, necessitating sustained, systematic, and collaborative governance efforts at the international level," said Zhang Xin, director of the Digital Economy and Legal Innovation Research Center, the University of International Business and Economics.

In the Global AI Governance Initiative, China proposed that countries should adhere to the principle of developing AI for good, respect the relevant international laws, and align AI development with humanity's common values of peace, development, equity, justice, democracy, and freedom. They should work together to prevent and fight against the misuse and malicious use of AI technologies by terrorists, extreme forces, and transnational organized criminal groups.

China is a major player in the AI sector. Statistics show that the scale of China's core AI industry has exceeded 500 billion yuan (\$70.42 billion), with the number of AI enterprises surpassing 4,300 and innovative achievements continue to emerge.

According to the World Intellectual Property Organiza-

In the Global AI Governance Initiative, China proposed that countries should gradually establish and improve relevant laws, regulations and rules, and ensure personal privacy and data security in the R&D and application of AI. It said countries should put ethics first, establish and improve ethical principles, norms, and accountability mechanisms for AI, formulate AI ethical guidelines, and build sci-tech ethical review and regulatory system.

Besides, it is also important to adhere to the principles of fairness and non-discrimination, and avoid biases and discrimination based on ethnicities, beliefs, nationalities, genders, etc.

A study by the International Monetary Fund found that AI and other new technologies may lead to increased investment in developed economies that have already achieved automation, thereby further widening the gap between wealthy and impoverished nations. Experts noted

that in the field of AI, there exist a digital divide and a governance gap between developing and developed countries.

That's why China, in the Global AI Governance Initiative, proposed that all countries, regardless of their size, strength, or social system, should have equal rights to develop and use AI.

Countries should increase the representation and voice of developing countries in global AI governance, and ensure equal rights, equal opportunities, and equal rules for all countries in AI development and governance. Efforts should be made to conduct international cooperation with and provide assistance to developing countries, to bridge the gap in AI and its governance capacity.

According to Zhang Li, a researcher with the China Institutes of Contemporary International Relations, the Global AI Governance Initiative responds to the widespread concerns and attention of the international community, especially developing countries, regarding the development of AI.

China's advocacy for governance in the field of AI represents a voice for developing countries and demonstrates its role as a responsible major country in improving global governance, Zhang added.

Arsenal show how the **Champions League** and Newcastle take note...

IT probably wasn't Mikel Arteta's pre-match team talk, but it could have been. "Forget brinksmanship. Group stage drama is for amateurs and also-rans. Just go out, do the job and wait until the Champions League's proper action starts in February." Perhaps it would have been emphasised with lots of hand gesticulations, had he taken that approach.

After the week's earlier drama involving fellow Premier League teams, Arsenal fans might have been feeling a little left out in that regard, but they shouldn't be. Their side is far more complete, far further along the team-building process and far more prepared to go far in a major European competition. It's probably also fair to note they have a far more routine group, certainly than Newcastle at least.

This 6-0 drubbing of a distinctly second-rate RC Lens showed as much, as does the far more important fact of Arsenal qualifying for the last 16 with a game to spare.

Sevilla collapsing to lose to PSV in the earlier kick-off felt as though it might give more of a contest at the Emirates, perhaps create more of a hint of jeopardy, but in truth it was never the case. A win still guaranteed top spot and in any case, there was more than a mere gulf between these sides.

The early knockings told the truth of the expectation of a home win: Lens fans made the noise but Arsenal had all the control. Takehiro Tomiyasu roused the crowd with a blockbusting run down the flank to nowhere; Kai Havertz dropped a header wide after the Japanese international crossed deep. If he might have done better that time, Havertz did so only a minute later: following a cross into the area, the German got enough of a touch on Gabriel Jesus's clever header into the six-yard box to prod past Brice Samba and over the line. And that was effectively that.

A tempting line to pursue would be of the goal settling the nerves, but none had been on display. Arsenal were assured and competent throughout, clear by 25 minutes and able to bask in a quite literal glow as Lens fans lit a succession of bright red smoke flares at that point, with at least one hurled upwards into a home fans' section above them.

Gunners fans responded with a verbal volley of their own, informing the visitors they appeared to be rather similar in quality to some near north London neighbours, and suggesting they were not particularly good... in rather more rudimentary terms. If the former quip bore no semblance to reality this season, the latter was unfortunately accurate. Lens were a mile off the quality, intensity and even strength of their hosts in the first half, timid and reactive, absurdly out of their depth despite mathematics suggesting they still had a shot at a last-16 place. They don't any more.

ANCHESTER United are facing elimination from the Champions League in the group stage after squandering a two-goal lead to draw 3-3 with Galatasarav in Istanbul on Wednesday, while Arsenal and PSV Eindhoven secured qualification for the last 16.

Three-time European champions United needed a win in Turkey, against opponents who beat them at Old Trafford last month, in order to keep qualification for the knockout rounds in their hands.

Erik ten Hag's side appeared in control when Alejandro Garnacho's early opener was followed by a stunning strike by Bruno Fernandes on 18 minutes.

Hakim Ziyech pulled one back with a free-kick, only for Scott McTominay to restore the visitors' two-goal advantage early in the second half.

Yet Galatasaray were again given hope when another Ziyech free-kick was fumbled into the net by United goalkeeper Andre Onana, and the hosts equalised thanks to a brilliant 71st-minute strike by Kerem Akturkoglu.

United have now conceded 14 goals in five European matches and this result, combined with FC Copenhagen's 0-0 draw away to alreadyqualified Bayern Munich, leaves the Premier League side bottom of Group A with one game remaining.

In order to go through they must now beat Bayern at home next month and hope

Tanzania moves up in latest FIFA world rankings

THE world football governing body, FIFA on Thursday, officially published its latest men's national team global rankings, with Tanzania's senior national soccer team, coached by Adel Amrouche, having climbed one place.

Taifa Stars are now placed 121th in the world. They now occupy 32nd place on the continental rankings, moving above Malawi and Cyprus.

In the 2026 FIFA World Cup qualifiers played in November, Taifa Stars opened their Group Stage campaign with a 1-O away win over Niger before falling to a 2-0 home defeat to Morocco.

As a result, Tanzania remained with the same number of points but moved up by one place due to other nations' results going in their favour.

The Comoros Islands are the biggest movers. The Islanders enjoyed back-to-back wins against the Central African Republic and Ghana in the World Cup Qualifiers.

e two victories helped Comoros make a significant move up the rankings with 30.88 points, moving them nine places up to 119th, their highest-ever position.

Guinea-Bissau (103rd, up seven spots), Libva (120th, up six), and Rwanda (133rd, up seven) are the other big African movers in the November ranking.

Meanwhile, Morocco remains the number one ranked African side, followed by Senegal, Tunisia, Algeria, and Egypt in the top five.

Amongst the East African countries, Uganda (19th) remains the best-ranked in the CECAFA region followed by Kenya (110th).

World champions Argentina once again lead the pack, with France also unmoved in second place. But Brazil have dropped two places below both England and Belgium into fifth spot, having failed to win any of their last four fixtures.

Initially scheduled for June and July 2023, the Africa Cup of Nations Cote d'Ivoire was postponed to be held from January 13 to February 11, 2024, to avoid the matches taking place in the middle of the rainy season.

Tanzania qualified for this 34th edition of the African Cup of Nations by finishing second in Group F of the qualifiers with eight points behind Algeria who dropped just two points in six games.

Amrouche and his charges will play their group stage matches in the town of San-Pédro, 350 km from Abidjan.

They will play on the fifth day of the tournament, January 17, at 6:00 p.m. as they take on World Cup semi-finalist Morocco.

Three days later, they will take on neighbours Zambia on Sunday, January 21 before concluding their games on 24 January with DR Congo.

Group winners, runners-up, and the best four thirdplaced teams will advance to the round of 16.


Namtumbo District has been scheduled to trade jabs with Niga Mwakaluba of Kyela District in a six-round, 60kg fight.
