

UN, AfDB launch appeal for quick action on SDGs

NEW YORK

WITH an estimated 390 million people living in extreme poverty, hunger and food insecurity, Africa is in a race against time to deliver on its regional and global development

On the sidelines of the UN General Assembly on Sunday, African heads of state and government met to emphasize urgent collective action and the need for greater collaboration between the United Nations and the African Development Bank to fast-track Africa's development.

The meeting, convened by the African Development and the United Nations, is the first of its kind between the two institutions taking place at UN headquarters, UN Deputy Secretary-General Amina Mohammed said.

Underscoring the strong convergence between the continent's 2030 Agenda for Sustainable Development, the UN Sustainable Development Goals and the African Development Bank High 5s agenda, the top UN official said it was time to join forces to deliver.

"We are entering into the decade of action to deliver the SDGs...The investment requirements are vast," she said. "The



role of the African Development Bank is crucial...to help de-risk investments and attract investment flows.......Africa's premier institution needs much more support," she

The leaders called for additional resources to drive the urgent task of Africa's development.

Akinwumi Adesina, the AfDB president that the clock was ticking fast for Africa, "yet we still have time left on the clock. We can still close the gap. I am fully convinced that with a change of pace, driven by a greater sense of urgency, and global collective responsibility, Africa can still achieve the SDGs".

The two-hour meeting, moderated by AfDB, was attended by seven African presidents from Chad, Democratic Republic of Congo, Ghana, Guinea, Ethiopia and Lesotho, in addition to representatives of some 30 governments.

The leaders spoke of what had worked in their countries - including mainstreaming development goals into national plans, scaling up initiatives, and implications of harmonizing policies and strategic entry points for the implementation of development goals at national, regional and global levels.

NBS starts collecting data on size of informal sector

THE National Bureau of Statistics (NBS) is conducting a countrywide survey to ascertain the scope of the informal sector and its contribution to the national economy.

The survey uses modern technology in data collection and analysis, like tablets and global positioning system (GPS) to capture respondents' information including places of abode and business premises.

Addressing participants at a statistical awareness workshop for editors and senior



journalists, NBS Senior Statistician Opiyo Mamu said phase one of the survey is already going on in Dar es Salaam Region and phase two in other regions will follow later.

Mamu noted that data collection and analysis for phase one will conclude at the end of this month and the report will be ready next month.

"The outcome of the ongoing Informal Sector Survey 2019 will help policymakers make key development decisions, "he declared.

The statistician elaborated that the report will inform the government on how to develop the

THE government is set to launch a nationwide plan to contain the alarming spread of Non-Communicable Diseases (NCDs) in the country.

This comes amid revelations that NCDs are now becoming the leading killer, being responsible for 44-percent of deaths and projected to be the cause of about 55-percent of all cases of mortality by 2025 if the situation remains as it is.

Speaking at a Research Dissemination Symposium at the Muhimbili University of Health and Allied Sciences (MUHAS) yesterday, the Deputy Minister of Health, Community Development, Gender, Elderly and Children Dr Faustine Ndungulile said the plan, set for launching on October 16th in Dodoma, will include key components of health education, plus the prevention and treatment of NCDs.

"This is an alarming situation which calls for government intervention. The problem is that most patients come when they are 70-percent affected, so the programme will

come up with strategies for civic education as well as provision of health education for lifestyle change," said Dr Ndungulile.

The deputy minister said the increase in those cases was the sign of a health system failure in the first place, as such patients pose challenges for treatment because it takes a long time.

The first approach in the plan will be to seek data in the first phase of project implementation, like the number of Cancer cases and other diseases, to forge ways of proper intervention.

In his remarks the president of the Medical Association of Tanzania (MAT), Dr Elisha Osati said the increase in NCDs has alerted medical experts and the association has prepared a strategy on how to go about

Kijaji: Govt lowered tax to help out business community and investors

THE government has vowed to solve various challenges faced by the business people as in this financial year it has made significant amendments to various laws aiming at improving the environment of their businesses.

The Deputy Minister for Finance and Planning Dr Ashatu Kijaji said this yesterday as she was speaking at a meeting to evaluate challenges faced by the business people in Songea, Ruvuma region.

Dr Kijaji said among the tax laws that

people have been reduced.

The Deputy Minister explained that in the past business people with gross sales from 4m/- to 7m/- per year used to pay 150,000/- but after the amendments the rate has been lowered to 100,000/- per year.

For business people with gross turnover from 7m/- to 11m/- used to pay 318,000/- tax but after the amendment the rate was lowered to 250,000/- per

Dr Kijaji further said for those with turnover between 11m/- to requirement to start paying tax when was amended is the Income Tax Act, 14m/- used to pay 546,000/- but they have not commenced business,

in which tax rate for small business now they will be paying 450,000/per year.

> Deputy Minister Kijaji also clarified that other challenges that was solved in that Act is the one that required to pay tax even before a businessman starts doing business, and now they will start paying the tax within 6 months after commencing business.

"If I say the government is bent on removing obstacles facing business people, you must understand that it is well intentioned. In the past many businessmen were complaining the but in this financial year it will no longer be so," stressed Kijaji.

The advisory meeting between the government, investors and business people is among the implementation of President Magufuli's directives last June when he met with members of the business community at State House during which he directed the Ministry of Local government and Regional Administration (TAMISEMI), and all other regions involved with business people and investment to listen to their challengers in the aim of finding solution thereof.

In Tanzania that the programme started in Arusha, Kilimanjaro, Tanga, Morogoro, Iringa, Dar es Salaam and Njombe regions whereby 40 schools with 34,561 pupils are affected. They have been drinking milk with support from donor agencies, the government and other stakeholders.

The government intends to make this programme a national one, the premier indicated, noting that in collaboration with other stakeholders, the government through the Ministry of Livestock and Fisheries will continue to promote milk drinking culture in our schools, he said.

Speaking earlier when he toured Asas dairy factory during his working visit in Iringa Region, the premier said the government of President John Magufuli will continue to control the import of various goods to protect our domestic industries.

Africa, 2nd fastest growing tourism region in the world

TRAVEL and tourism remained one of the key growth drivers of Africa's economy, contributing 8.5% of the GDP in 2018; equivalent to \$194.2 billion.

According to the 2019 Jumia Hospitality Report Africa, this growth record placed the continent as the second-fastest growing tourism region in the world, with a growth rate of 5.6% after Asia Pacific and against a 3.9% global average growth rate.

"Our focus is to continue showcasing Africa as a continent full of beauty and opportunity. Through this report, we want to help draw attention to the vast potential of the tourism industry,

that we believe is an untapped lever of 44% international expenditure. economic growth," said Jumia's Head of Travel, Estelle Verdier.

She was speaking during the official release of the annual report at the Africa Hotel Investment Forum (AHIF) in Addis Ababa, ahead of the 2019 World Tourism Day.

Africa received 67 million international tourist arrivals in 2018, to record a +7% increase from 63 million arrivals in 2017 and 58 million

This gradual increase is attributed to the affordability and ease of travel especially within the continent, with spending among domestic travellers accounting for 56% as compared to

Additionally, leisure travel remains an important component of Africa's tourism industry, taking up a majority 71% of the tourist expenditure in 2018.

Verdier notes that implementation of the African Continental Free Trade Area (ACFTA) is expected to further boost domestic

"To realize the full potential gains will require cooperation from all industry players. Governments have to be willing to eliminate visa requirements for African nationals traveling to their countries. Ministries and other responsible partner organizations should create campaigns that will

promote their local travel destinations (7.1% of total GDP) in 2017. and tourism offerings to attract more regional travellers. At Jumia, we will continue to offer diversified products at affordable prices including resident rates for regional travelers booking through our platform".

THE report, now in its third edition, shows that while pay-at-hotel remained the most popular mode of payment among travellers booking via Jumia's travel platform, its percentage use went down from 65% in 2018 to 62% in 2019 (down -5%). Card transactions gained popularity with +24% within the same period, "and this reflects an increased trust in our booking platform," Verdier affirmed.

On the other hand, the use of mobile money and travel agencies decreased by -11% and -20% respectively. The mobile, as a source of traffic on the Jumia Travel platform, accounted for a record 74% in 2019 from 57% in 2018, seen as a result of the increased mobile penetration in the continent. While Africa's passenger traffic increased from 88.5 million in 2017 to 92 million in 2018 (+5.5%), it's world share was only 2.1% (down from 2.2% in 2017). It is when we work together, pool our resources, partner and share our best knowledge that we can do much more," stated South African Tourism's Acting Chief Executive Officer Sthembiso Dlamini through her insights on the report.

In terms of top airlines generating most revenue in the African airspace, the report sites Emirates at the top of the list; earning over \$837 million with popular flights from Johannesburg, Cairo, Cape Town and Mauritius. Africa's most profitable air route between April 2018 and March 2019 was from Johannesburg in South Africa to Dubai, generating \$315.6 million in revenue; while state-owned Angola Airlines and South African Airways were the only two African airlines that made it to the top 10 Africa's highest revenue air routes within the same period. Respectively, the two airlines generated \$231.6 million flying from Luanda to Lisbon and \$185 million flying between Cape Town and Johannesburg.

Govt gives 14 days ultimatum for alternative bags producers

MINISTER of State in Vice President's Office (Union and Environment), George Simbachawene has issued 14 day ultimatum to producers and suppliers of alternative bags to ensure that they comply with all set standards including putting manufacturer's label.

Speaking in Dar es Salaam shortly after touring the Dar es Salaam port, Simbachawene said the presence of illegal producers of the bags has denied revenues to local registered producers in particular and the government in general.

"We must know who is producing and supplying these alternative bags, the legally recognized producers registered in the country are missing out revenues

due to illegal producers and suppliers," he said.

Apart from the order in question, Minister Simbachawene said after the grace period a thorough inspection will be conducted to uncover the unscrupulous people behind the move who are defying set standards and their products would be destroyed.

Simbachawene ordered National Environment Management Council (NEMC) officials dealing with inspection of imported good to work 24 hours at the port of Dar es Salaam in collaboration with other government agencies to ensure that no illegal goods are imported.

"The port efficiency is measured on its keenness in handling imported and

force should be beefed up to make sure that the desired efficiency is met," he said.

According to the minister, stone would be left unturned when it comes the issue of dishonest workers who sabotage government efforts in stimulating revenue collections.

He pointed out that regulations governing the matter stipulates that whoever imports, exports or produces alternative package bags should make sure that the bags conform to the standards set by Tanzania Bureau of Standards (TBS).

Since the government announced the ban of polythene bags various measures have been taken to make sure that high quality alternative bags are exported goods. If necessary labour adequately supplied to bridge the gap.

Manager of Kilosa-based Msimba farm of Tanzania Agriculture Seed Agency (ASA), Jacob Chiwanga said the move will help farmers increase crop production per acre; hence ensure country's food security and industries' raw materials demand.

Chimwanga made the call in an interview with this paper following farmers' outcry on reduction of crop yields in the last farming season due to changing weather pattern.

"We're not opposing the use of traditional seed varieties, but the world right now is grappling with impacts caused by climate change. Our

why most of researchers have decided to modify the seeds that have shown to increase productivity," he said, adding: "That's why farmers needs to change and adopt the use of improved seeds which are susceptible to climate change.

For his part, Agricultural Research Institute (ARI) Ilonga lead researcher for cereals crops, Meshack Makenge said: "We're aware of the farmers complaints and as institute we've developed improved seeds, which perform well in harsh weather conditions."

According to Makenge, ARI-Ilonga traditional seeds have failed to cope produces wide range of improved seeds

beans, and peas.

"Most of our seeds are drought and disease resistant, hence assures farmer high productivity.'

Dr Joel Meriyo, director of ARI-Ilonga said his institute was working on an new strategy aimed at empowering farmers with skills that will make them grow crops despite the changing weather patterns.

For his part the TARI manager in Dakawa, Dr Andrew Ngereza, said the centre has been developing improved rice seed varieties including SARO 5 (TXD 306), which has high productivity, whereby per acre a farmer can get more than 40 bags of rice.

She said: "I know there are many projects reached by TIC by 72 percent hence I want them to quickly go to Ruvuma region especially to these two coffee factories, for the purpose of identification and to explain to them the opportunities and importance of registration with TIC so as to enhance their contribution to the country's economic development."

TIC director of planning and research Maftah Bunini said in improving the institution's performance they have opened seven zonal offices in the country in order to easily access the local investors.

"And in this, that is why the size of investment capital vary between foreign and local investors. A local investor must have a capital of USD 100,000 whilst the foreign one the figure is USD 500,000.

On his part, the manager of MCCCO Jonas Mbunda has assured the minister that they will continue to improve the work environment of its workers and increase the quality of their coffee products as well as to ensure the community around the factory benefit.

On his part, the DAE managing director Dunstan Komba who is also a coffee grower congratulated the minister for her visit at the factory and explained to her on the challenges they face in regard to coffee markets and pleaded with the government to continue assisting local investors.

IGP Sirro is right to question some officers short on ethics, discipline

John Magufuli has been applying for quite a while are beginning to have an impact in the manner in which other heads of the pillars of government as well as law enforcement are conducting their duties. First it was Chief Justice Ibrahim Juma who floated a suggestion to change the law on unbailable offices, and the president has now responded with an overture for plea bargaining, for all sabotage suspects.

The move by Prime Minister Kassim Majaliwa to make an extensive tour of Morogoro region and unearth scores of instances of negligence and dereliction of duty was a sort of repetition of what the president earlier did in Mwanza region, and to an extent in a tour of Southern Highlands regions much earlier. In all these tours there was an in-depth look into what is happening and taking measures to solve those problems, even scolding top officials for negligence, letting issues hang until top leaders appear.

Inspector General of Police Simon Sirro has come out in the same outlook, to tell top officials of the police force that ethical standards and discipline among the police force rank and file was becoming a headache. He was frank that higher police officers were often to blame.

The IGP was addressing a three-day meeting of a task force of senior police officers at police headquarters. The task force includes regional police commanders (RPCs), convened to present performance evaluations for the past two and half years.

There was a political aspect to the issue, as the meeting was also meant to draw rules of conduct in relation to overseeing forthcoming local government elections. It was make sure that political overtones are kept

ETHODS that President at a minimum, as they embarrass the force when ghastly incidents of police violence occur.

The IGP harnessed fairly intense psychological energy to ask senior police officers in attendance whether they can stand up to events like the shooting of Daudi Mwangosi in September 2012 and the death of Akwilina Akwilini in February 2018 and say the police did their work properly.

He mentioned those two instances as civic polls are coming up, and he pointedly accused some police officers of political exhibitionism, as if they wished to be elected. He also queried parading crime suspects, as it is pointless.

The message of the IGP was that the pOlice should focus on professionalism, not exhibitionism and wishing to be commended by public antics that deviate from Police Force Regulations. He signaled clear awareness of where the problem starts, saying the deterioration of standards in regard to police training was appalling, illustrating that a police officer rushes to an incident of crime and then posts unintelligible things in social media platforms.

He pointed at the piling up of exhibits up to headquarters level, saying this was incomprehensible as each of those cases has stations and have their own commanders. It means the rank does not take its responsibilities and tends to push upwards.

But isn't that due to some habitual interference from upwards, to influence outcomes? On the whole the IGP was frank about the challenges, from the level of training to adopting civilian habits like posting things on social media, to avoiding tackling cases, by pushing issues to higher levels. The IGP is unlikely to clear out half of that bill, but still it would make a difference.



World Maritime Day is celebrated in many countries worldwide, including Australia, Canada, the United Kingdom, and the United States. The IMO's original name was the Inter-Governmental Maritime Consultative Organization (IMCO) but the name was changed in 1982 to IMO. The IMO focuses on areas such as safety, environmental concerns, legal matters, technical co-operation, maritime security and the efficiency of shipping. World Maritime Day was first held on March 17, 1978 to mark the date of the IMO Convention's entry into force in 1958.

At that time, the organization had 21 member states. It now has about 167 member states and three associate members. This membership includes virtually all the nations of the world with an interest in maritime affairs, including those involved in the shipping industry and coastal states with an interest in protecting their maritime environment.

crude and dangerous, who have incited the latest wave of attacks seem to be able to descend into Trumpian forms of politics without consequence. They are not recalled from their positions by their parties, civil society does not picket their offices, trade unions do not promise to go on strike until they are removed from power.

The inevitable consequence of the normalisation of xenophobic rhetoric by politicians means more street violence, and more impunity for the escalating violence. In this crisis it is vital that we are able to build the largest possible coalition against xenophobia, with mass-based organisations such as trade unions, social movements and community organisations in the lead, backed by progressive civil society, faith-based organisations and progressive academics.

If we are not able to build such a united front, and to make it a powerful force in the national debate and in the streets, the xenophobes will continue to effectively spread their poison on social media, and to engage in violence on the streets. We cannot assume that this problem will be resolved by the state. The small groups calling for xenophobic violence engage in hate speech with impunity. Attacks

by watching, making no attempt to intervene.

It is clear that this crisis cannot be resolved by the state and that, if we are able to resolve it, the political commitment to do so will have to come from within society.

To fully understand the current crisis we must understand that since 2004 there have been escalating popular protests, many targeting local councillors. These protests have posed a serious challenge to the legitimacy of the local state, sometimes resulting in "no vote" campaigns or support of independent candidates at elections.

In Durban, sustained organisation has led to a vibrant alliance of shack dwellers, flat dwellers and street traders that has mounted effective opposition to former mayor Zandile Gumede, the remains of the Zuma faction in the city. Well-known grassroots activists like Des D'sa, S'bu Zikode and Verushka Memdutt have become significant players in the city's politics.

For corrupt local officials and politicians, turning popular anger against migrants makes perfect political sense. It deflects growing popular anger towards scapegoats who are not easily able to defend

Hitler's anti-Semitism in the 1930s. It is the logic of the anti-migrant politics of Donald Trump and Boris Johnson today. It is not always fascism in the classical sense but it is always a deeply reactionary form of politics with some clear links to the basic logic of fascism.

Any society in which armed mobs hunt fellow residents in the streets with effective impunity is a society in which, along with basic human rights, democracy is at serious risk. In India the far-right project, often termed fascist, that now runs the state has its roots in the 2002 pogrom against Muslims in Gujerat, and, before that, the destruction of the 16th-century Babri Mosque in the city of Ayodhya, in Uttar Pradesh in 1992.

The entry of the mob backed by powerful political elites into politics is always the end of meaningful democracy for vulnerable groups. The end result doesn't have to be uniform totalitarianism but often results, as in India, in democracy for some and authoritarianism for others. This is where we are now headed. It is a matter of serious urgency that we build a powerful united front against xenophobia, against attacks on women and for genuine democracy.

Can you give us an South Africa relationship?

I think that is a good starting point. We all are aware of the role that Nigeria played during the apartheid regime in South Africa. There is no doubt about it and sensible South Africans appreciated it. However, they have comparative advantage in manufacturing and industrialisation over Nigeria. And that was very clear when we started to engage with South Africans in 1992. We could see very clear that South Africa, from a technical point of view, was well ahead of the game. South Africa also has a much better structure. Their department of Trade and Industry was one that has pushed aggressively around the whole continent for trade and investment opportunities. These were the things we didn't do. All we wanted was to sell our oil and cocoa. Our strength is in areas like fashion, music and culture and all those things that have to do with

I cannot put a value to all these investments, but certainly it should big. We have over 100 South African firms in Nigeria that are registered. So these attacks on Africans are simply from the attitude that "things are not working out very well for me and you foreigners seem to be doing very well. I can't reach the leadership of my country who I really want to fight and you are the nearest." For me, the attacks are completely unacceptable and South Africa's government must stand up and deal with it. Otherwise the repercussion at the Pan- African level could be quite significant and ow things are beginning to evolve. For example, President Paul Kagame of Rwanda walked out of the World Economic Forum that was hosted in South Africa and some other individuals didn't attend. imagine the saying that the world teaches those not taught by their mothers.

What does it really mean? Have any teenagers thought about it or experienced common things that challenge one but never told by his or her parents or guardians?"

Nineteen year old boy (name withheld) from the British School in Dar es Salaam posed this expression when asked to comment on the recent court case in Rukwa region where over 20 secondary school boys were arraigned for impregnating primary school girls.

The under-20 boy talks vividly that in this modern Tanzania teenagers in schools are challenged by poor communications about sexual matters and they mostly learn sex issues from friends, TV, Youtube channel, music, peer groups and sometimes on their own.

"Is this the way the world has started teaching us or the Rukwa boys? As young learners we don't understand what it really entails because in most cases there is nobody to expose us to the truth about sex," he says.

Some students join the discussion and challenged parents and guardians to find ways to teach sex education to teenagers in schools and not to let them learn it from the world as it has happened in Rukwa.

According to media reports (Sunday September 22, 2019) primary school girls aged between 14 and 16 years were forced to drop out of school and become mothers, because their boyfriends mostly aged around 17 years impregnated them.

The British School students believe that the situation wouldn't have been so much bad, if the girls and boys had significant knowl-

"Their parents and guardians do not tell them about sex," says one of them, her name withheld.

Bishop William Mwamalanga of the Pentecostal Evangelical Church (PEC) when asked if parents or guardians of today communicate with their children about what sex is, was skeptical.

Bishop Mwamalanga says in most cases they don't and that is perhaps the reason that most young girls and boys don't understand that indulging in premarital sex is bad because they do not have any background that sexual immoralities can lead to lifelong desperation.

He affirms that young learners in primary and secondary schools learn about sex from other than parental and guardians bases.

"I believe that as parents and protectors of our children we must uphold our responsibilities to support our children to know values, sex and outcome of sexual immoralities in order

to keep the hope alive in our next generation," says Bishop Mwamalanga.

Modesta Lyimo, a second year student from the Institute of Social Work in Dar es Salaam, feels that parents cannot talk to their children about sex matters because of culture and at the same time they don't have the knowledge and the meanstechniques to speak about it.

Modesta admits that there is a communication gap between parents, guardians and teens, saying it as a reason why many girls became pregnant at the first semester of their first year at universities

She challenges 'old style' explanations and instructions to girls and boys about puberty and sex issues saying that they should go beyond assigning 'dos' and 'don'ts' or giving empty signals for precautions.

She wants parents to move away from explanations like 'do not do this' for example boys are simply told don't show your

private parts to girls or young boys or you should stop taking a bath with your

sisters,etc.

Some are seriously warned 'do not' touch a girl as it will take you to 30 years in jail, and girls are cautioned 'do not' play with men. Those are old ways of explaining things and the method does not teach; instead it stirs up curiosity among the teenagers.

The issue of morals deteriorating among the children in society, with reports of frequent child pregnancy, abortion, sex in schools and drug abuse are things happening where as a nation, Tanzania needs to teach so as to change children (teenagers).

And in this case, the appropriate measure is to formulate a comprehensive curriculum on Reproduction Health and Sex Education, that should be taught in higher institutions, says Dr. Godfrey Telli.

The recent trend of immoralities among our teenagers in the society, students in schools, shows that there is a gap between our parents, guardians, teachers and our children. "But all in all we mostly emphasise on abstaining from sexual intercourse," he observes.

Dr Telli, the Twaweza, Uwezo coordinator for 'What Works in Education' program says Tanzania needs a well-established curriculum which encompass all issues related to puberty, sex, pregnancy, abortion, morals, values, ethics, etiquettes and confidence.

The contents of each class should be designed to align with grades, age and level of comprehending in such a way that each grade will have its subjects and issues.

Dr Telli admits that because of cultural barriers parents and guardians are unable to talk to their children about sex or puberty, but it can happen on the blackboards (schools).

"But that well designed curriculum should not only talk about sex. It should as well tell the children in schools much more, can be about puberty, concep-

In this stage a boy in school should be taught by the teachers about puberty experiences and girls should as well be informed about their menstruations periods before they start their firstly monthly periods.

The syllabus should observe that as the children mature they should be taught about what is wrong and which is right when it comes to sex.

They must be taught about outcomes of sexual thing we want to be told is

Form Four classes, higher levels and what will be the impacts of illicit behavior in their lives, adds Dr. Telli.

The syllabus should explain straight what is wrong when school children or teens start doing sex at a younger age or before marriage and explain what will be the consequences of doing unsafe abortion.

Doctor Telli, an expert in curriculum development, policy, administration and gender issues in education.said during an interview with The Guardian, that students should be told about how the pregnancy occurs and how influences like peers, media, music and boyfriends get them into sex and how important it is to reject it.

"Teachers should take time to inform students about how conception occurs... not to learn from boyfriends, peers and not even from the short messaging services in mobile phones," says Dr. Telli.

The boys should as well be taught in schools about how their reproductive organs work and most important how they can make girls pregnant in a few seconds and how the law can act upon the teenagers when it comes to school pregnancy.

Issues of sexually transmitted diseases (STIs) are important and the most common ones like HIV, AIDS gonorrhea, syphilis and their symptoms, should be part of that curriculum which Tanzania has to design now.

"Again, they have to learn in schools about deadly vectors like 'Hepatitis B' that cause liver cancer, that it is transmitted through sex as well," he says.

And the most important

all schools from class one to immoralities for example at about sexual abstinence in order to prevent such diseases and all other evil that will affect their lives in schools and colleges," observes Dr. Telli.

> The evidence is already there that there is unsafe sex which results in school and teen pregnancies and also unsafe abortion. All these are bound to the spread of STIs including HIV and AIDS among young learners.

> "That is why it is not good to frequently ignore the consequences of not introducing young learners to contraceptives. The syllabus should teach issues like condoms and other contraceptive methods," he empha-

> "An equally important thing that the teenagers should be taught in schools is avoiding unsafe abortion, how it happens and its consequences on human lives," he stated.

> Doctor Telli concludes that the curriculum should have components that teach Tanzanian school children morals, values and confidence to make them upright people who can make the right decisions, thus be able to encounter evils and pressure from the surrounding environment.

> During a media training session on unsafe abortion organized by UMATI and other stakeholders, medical officials said that despite that abortion is not discussed much it is commonly alleged that things like cassava straws, bicycle spokes, herbal juices obtained from neem (nim) and alovera plants are used to induce abortions particularly among school girls.

Although abortion is illegal it is secretly done and in so many cases it is fatal.

rofessor Ottmar Edenhofer, one of the world's leading experts on the economics of climate change, has said that climate policies will play an increasingly important role in the future, and that he expects closer cooperation in this field between Europe and China for the benefit of mankind for safeguarding

multilateralism. Edenhofer is director and chief economist of the Potsdam Institute for Climate Impact Research (PIK). Between 2008 and 2015 he was co-chair of Working Group III of the United Nations Intergovernmental Panel on Climate Change (IPCC). He contributed heavily to the shaping of the Fifth Assessment Report on climate change mitigation, provided scientific basis for the Paris Agreement.

"Climate change apparent increasingly around the world. The coral reefs are disappearing, extreme weather events are increasing, and temperature is rising. Climate change is causing inequality because it has a much stronger impact on poor people," Edenhofer said in a recent exclusive interview with Xinhua.

Leading German climate expert sees great potential in closer cooperation with China



Despite a decision to streamline activities, the recent meeting trappings of a regular summit. File climate change has become one of the priority topics in Germany and also across Europe. People from all walks of life are talking about it, and the green parties in Germany and many other European countries are gaining popularity in polls and in this May's European Parliament elections.

Faced with the public's increasing concern about climate change, European governments and the EU are gearing up to tackle the issue. The EU's 28 national leaders meeting in Brussels on Thursday are likely to embrace a more ambitious stance by committing to net zero

carbon emissions by 2050. Germany has established a Chancellor Angela Merkel to address the issue. Last week, Merkel visited the PIK for a discussion with Edenhofer and other climate experts that lasted more than two hours. They focused on CO2 pricing, which is a hot topic in Germany and which the country's government is considering introducing.

"That is huge progress," said Edenhofer, adding that all parties except the right-wing populists are talking about how the issue should be addressed. Ten years ago, people were still talking about whether this issue should be addressed at all.

"I am pretty sure that the issue of climate change will play an increasingly important role in "climate cabinet" headed by future politics," said Edenhofer.

Edenhofer considers Carbon pricing the best way to cut emissions, as it is a big issue for coal-fired facilities but makes clean technologies more profitable and hence incentivizes innovation and upscaling in energy sector, such as battery technologies, and artificial intelligence in the electricity sector. CO2 pricing will also make the use of fossil fuels less profitable, said Edenhofer, who believes that the goal of carbon neutrality by 2050 will only be achieved by phasing out coal.

Germany is undergoing an energy transition, a key effort to address climate change. Today, electricity from renewable energy sources accounts for 38 percent of the country's total German government has decided to phase out coal by 2038, but according to Edenhofer this should happen faster.

Meanwhile, as climate change is a global challenge, there is need for stronger international cooperation.

that we need cooperation, coordination and action to address climate change," said Edenhofer, adding that although the United States is not friendly to climate in multilateralism. China issues, Europe and China could join forces. China has already made great efforts to address climate change.

"Within the IPCC I worked very closely with the Chinese colleagues and I always felt they were very aware of the problems. I feel very confident in China addressing climate change," said Edenhofer.

Edenhofer called for more regular exchanges between universities and research institutes to enable them to jointly develop new low-carbon technologies. He also expected Germany, Europe and China to cooperate in integrating their carbon markets, which will give a huge push to the ongoing international negotiations.

"Over the last 10 years, I have experienced that China is one of the important forces for multilateralism. In all the negotiations within

climate system result in new weather patterns that last for at least a few decades, and maybe for millions of years. The climate system comprises five interacting parts, the atmosphere (air), hydrosphere (water), cryosphere (ice and permafrost), biosphere (living things), lithosphere (earth's crust and upper mantle). The climate system receives nearly all of its energy from the sun, with a relatively tiny amount from earth's interior. The climate system also gives off energy to outer space. The balance of incoming and outgoing energy, and the passage of the energy through the climate system, determines Earth's energy budget. the IPCC, China was very When the incoming energy productive, constructive, is greater than the outgoing budget is positive and the climate system is warming. If more energy goes out, the energy budget is negative and earth experiences cooling.

As this energy moves through Earth's climate system, it creates Earth's weather and long-term averages of weather are called "climate". Changes in the long term average are called "climate change". Such changes can be the result of "internal variability", when natural processes inherent to the various parts of the climate system alter Earth's energy budget. Examples include cyclical ocean patterns such as the wellknown El Niño-Southern Oscillation and less familiar Pacific decadal oscillation and Atlantic multidecadal oscillation. Climate change can also result from "external forcing", when events outside of the climate system's five parts nonetheless produce changes within the system. Examples include changes in solar output and volcanism. Human activities can

also change earth's climate, and are presently driving climate change through global warming. There is no general agreement in scientific, media or policy documents as to the precise term to be used to refer to anthropogenic forced change; either "global warming" or "climate change" may be used. The first describes the average effect on a global scale, whilst the second describes how different geographical regions are differently.

WWF says it did not push for rhino relocation process where 11 died

NAIROBI

THE World Wildlife Fund has rejected the findings of a Kenyan parliamentary inquiry that said the conservation group pushed Kenyan authorities to speed up a botched relocation of 14 rhinos last year that led to the deaths of 11 animals.

The black rhinos died of salt poisoning following the decision by the Kenya Wildlife Service (KWS) to ignore water test results in Tsavo East National Park, the committee's report said.

The deaths of the endangered animals, being moved to a more secure home in the face of the threat from poachers, were a major embarrassment to Kenya, which sells itself as destination for wildlife tourism.

The inquiry said WWF, which donated \$1 million for the relocation in June 2018, applied pressure on KWS to speed up the process in a bid to generate positive publicity and secure funding for itself from Germany.

WWF denied the allegations in the inquiry report, which was made public last week, saying KWS had carried out hydrological surveys and given assurances the park was safe and suitable.



"At no point either before or during the translocations were any issues raised about the quality of the water on the site," WWF said by email.

"We would never push for a translocation to go ahead against the recommendations of the relevant experts. This was a tragedy we hope will never be repeated.'

The parliamentary committee's inquiry said the relocation took place during a period in 2018 when the term of one KWS board had ended and before a new one had begun, creating a lack of oversight.

The report said KWS's former board of trustees had rejected the relocation three times in part because of the high salinity levels of the drinking water in the park.

The report said Najib Balala, the minister of tourism and wildlife, should take overall responsibility for the rhinos' deaths because he delayed the appointment of the new KWS board.

The minister's spokesman declined to comment.

"There is tight effort at the borders to ensure that such things do not come in again," he said, adding that no country had been able to stamp out smuggling

According to customs officials in Nigeria, agents seized 927 kg of pangolin goods in 2016, 402 kg in 2017, and then seizures rocketed to 12.3 tonnes in 2018.

"Sometimes Nigeria is just a point of convergence," said Sule.

Oliver Stolpe, the United Nations Office on Drugs and Crime (UNODC) representative for Nigeria, said the problem was that pangolin trafficking was just one in a long list of criminal activities facing the authorities in the West

African country. "Nigeria is fighting crime on so many fronts," Stolpe said. "It's simply too many

Experts say it's hard to draw definitive conclusions from data about seizures. A surge in interceptions could just mean law enforcement agencies were doing their job better, rather than there being a major increase in

trafficking. But TRAFFIC's Sone Nnoke said the sheer number of seizures of pangolin products that have come via Nigeria points to the country now being the main hub for the illegal trade.

"Because of porous borders it's very easy to take those products to Nigeria," said Nnoke.

seizures very likely only represent about 10% of the actual trade in pangolin scales so the surge in intercepted cargos from Africa was a worrying trend.

According to TRAFFIC, which tracks seizures of more than half a tonne, 67.6 tonnes of pangolin scales from Africa have been seized throughout the world this year, already almost double the amount in 2018.

The Tikki Hywood Foundation, which rescues pangolins in Zimbabwe and Cameroon, estimates 1,666 of smaller white-bellied pangolins need to be killed for one tonne of scales. When it comes to the giant pangolin, that drops to 277 animals.

So the 67.6 tonnes of scales from Africa seized this year and tracked by TRAF-FIC would have needed anywhere from 18,725 to 112,620 pangolins to be killed, depending on the species.

'HUGE AMOUNTS'

The economic motivation for smugglers is strong. In Nigeria, a whole pangolin can sell for as little as \$7. But once in China or Vietnam, the scales from one animal alone can fetch \$250, according to UNODC.

Yet Nigeria is not just a staging ground where pangolin parts from around Africa are amassed before being shipped to Asia. The country has its own population of the furtive creatures, living mainly in the thick forests of the southwest.

Here, generations of families have hunted, traded and made medicine from "akika", the Yoruba name for pangolins.

Many of the traders, particularly those dealing in animals hunted in the surrounding forests, said foreigners they believed to be Chinese were buying pangolins or their parts in ever greater quantities.

"They pay huge amounts of money," said Agbetuya Babatope Samuel, traditional healer and trader in the town of Akure in Ondo state. "When I get their money I laugh to the bank,' he said. "I wish it would continue for a long time."

The high demand is taking its toll.

When the sun has set, Sule Ayinla stalks the dark, thick forests of Ondo Akoko in southwest Nigeria for pangolins, a torch fixed to his head. Hearing a rustle, he fires his long-barrelled gun at a tree, to no avail.

"We used to hunt pangolin here," Ayinla said, lowering his weapon. Taught to hunt by his father, he said the trade was getting tougher and it was becoming rare to find pangolins hiding in the trees where they typically find cover.

Why socialism thrives nowhere, except at universities

embedded in especially at arts and humanities departments. Student journalists, too, view capitalism in a strongly negative light, despite powerful empirical evidence that it has improved the quality of life of rich and poor alike, and that socialism leads to poverty, stagnation and famine. Why is this so?

Iohan Fourie, associate professor of economics at the University of Stellenbosch, wrote a revealing column (paywalled) after talking to a group of journalism students about capitalism. Most of the students believed capitalism to be a system that exploits people, impoverishes them and takes away their freedoms.

Fourie's PhD was in economic history, so he was on solid ground when he pointed out that the global rise in prosperity over the last two centuries can largely be attributed to private property rights, democracy, press freedom and free markets. In the past 40 years alone, extreme poverty has declined from 44% of the world's population to less than 10%, because of the spread of economic freedoms.

Why, asked one student, have they not been taught this view of capitalism? This question is pertinent, and reflects badly on the ideological orientation university faculties, especially in the arts and humanities.

University faculties lean strongly leftwards. In the US, academics who identify as Democrats outnumber Republicans by five to one. In the liberal arts, the ratio is eight to one. In sociology, the ratio is 44 to one.

The great triumph of the Cold War is that Western liberalism proved to be more successful than Soviet communism. The great tragedy of the Cold War is that it condemned so many countries newly liberated from colonialism to Marxist authoritarianism and poverty.

The notion that colonial oppression was never a capitalist enterprise and contradicted liberal values, and could be fought entirely on classical liberal terms, never penetrated the hallowed halls of academia or the corridors

Outside of business schools and commerce departments, universities almost universally taught some version of Marx's historical materialism, which argues that society's organisation and development is primarily a product of its material conditions and the struggle between different social classes, and not of thoughts, principles, beliefs and ideals. Marx explicitly rejected the notion of rights, such as the right to life, liberty and property which are the hallmarks of Western liberalism.

intellectual Marxism's successor is critical theory, which eschews objective attempts to study society and culture in favour of critique which aims, in the words of Max Horkheimer, one of its founders, "to liberate human beings from the circumstances that enslave them."

Critical theory is explicitly concerned with critiquing forms of authority and injustice that accompanied the evolution of industrial and corporate capitalism, abandoning all pretence at political neutrality or objectivity. It extends Marxist thought to all social sciences, including geography, economics, sociology, history, political science, anthropology and psychology.

It is inherently subjectivist, emphasising concepts such as "self-reflection" and "lived experience". It elevates language, symbolism and social construction over empirical research knowledge. It views meaning itself as unstable and dependent on ever-changing social context.

Ultimately, critical theory is a nihilist doctrine. It focuses so much on critiquing the shortcomings of the existing social, economic, political and scientific order that it fails to offer political solutions or a

clear way forward. It is, of course, easy to be a theoretical Marxist when you're a tenured professor unafraid of losing your job, earn a lavish salary paid for by taxpayers, and have never left the comfort of the ivory tower of academia to labour among the crass commercial classes.

There is also a self-selection bias that results in ideological bias at universities. Intelligent people that are well-disposed to market capitalism generally find opportunities in the professional or business world. Intelligent people who aren't, are more likely to gravitate towards academia.

These are the people that drill the socialist mantra into students at universities, caricaturing capitalism merely as a power structure that undermines social justice and perpetuates oppression.

Having thrown objectivity out the window, it is no surprise that journalists, who probably never took so much as an introductory course in economics, take such a negative view of capitalism.

Professor Fourie's defence of capitalism undermines academia's worldview of capitalism as a structure of immiseration and oppression which only makes the rich richer and the poor poorer. Yet the facts contradict the Marxists and support Fourie.

Capitalism's critics tend to focus on inequality because they dare not point to the indisputable fact that capitalism has lifted the majority of the world's population out of poverty in the last two centuries, and continues to do so.

They argue that not all socialist experiments have failed, as those in the Soviet Union, Mao's China, Cambodia, Zimbabwe and Venezuela did so spectacularly, accompanied by so much misery, starvation, repression and death. Just look at the Scandinavian countries!

In reality, the Scandinavian countries are very far from socialist. The Fraser Institute publishes an annual report on the economic freedom of the world. It ranks countries based on numerous metrics, broadly grouped into five categories: size of government, legal system and property rights, sound money, freedom to trade internationally, and regulation.

In its 2019 report, published last week, Norway, Sweden, Denmark and Iceland all rank in the top quartile of most free countries. That they have used their prosperity to establish large welfare states does not TO BE CONTINUED make them any less capitalist.

The report notes that nations in the top quartile of economic freedom had an average per-capita GDP six times higher than those in the bottom quartile. The average income of the poorest 10% in free countries was seven times higher than in unfree countries and exceeded the average percapita income in the least-free nations. In the top quartile, 1.8% of the population experience extreme poverty, compared to 27.2% in the lowest quartile.

Infant mortality is much lower and life expectancy much higher in economically free countries compared to unfree countries. Political and civil liberties are considerably higher in economically free nations than in unfree nations. Gender equality is greater in economically free nations. Happiness levels are higher in economically free nations.

Fourie is right to note that students, instead of being taught to merely critique modern society from a Marxist perspective, ought to be taught the practical origins of prosperity, well-being and poverty.


They should be taught the moral basis of classical liberal values being rooted in individual freedom from state control and repression. They should be taught how decentralised markets lead to superior outcomes when compared to central planning, even though intellectual elites often labour under the conceit that their theoretical plans are better than the choices people make for themselves.

If they were, they would view free-market capitalism, for all its shortcomings, in a far more positive light. That universities teach otherwise has a long history, but it is both factually incorrect and morally dangerous.

Socialism is a range of economic and social systems characterised by ownership of the means of production and workers' self-management, as well as the political theories and movements associated with Social ownership can be public, collective or cooperative ownership, or citizen ownership of equity. There are many varieties of socialism and there is no single definition encapsulating all of them, with social ownership being the common element shared by its various forms.

Socialist systems are divided into non-market and market forms. Non-market socialism involves replacing factor markets and money with engineering and technical criteria based on calculation performed in-kind, thereby producing an economic mechanism that functions according to economic laws from those of capitalism. Non-market socialism aims to circumvent the inefficiencies and crises traditionally associated with capital accumulation and the profit system. By contrast, market socialism retains the use of monetary prices, factor markets and in some cases the profit motive, with respect to the operation of socially owned enterprises and the allocation of capital goods between them. Profits generated by these firms would be controlled directly by the workforce of each firm, or accrue to society at large in the form of a social dividend. The socialist calculation debate concerns the feasibility and methods of resource allocation for a socialist system.

Socialist politics has been both internationalist and nationalist in orientation; organised through political parties and opposed to party politics; at times overlapping

CBK flags suspicious Sh1,000 notes in wheat purchases

NAIROBI

Kenyans with a huge stash of the old Sh1,000 notes are opting to buy commodities over exchanging the cash in banks for the new currency in a bid to conceal their identities.

The Central Bank of Kenya (CBK) Tuesday revealed a rush to buy agricultural commodities like wheat in Narok using the old notes ahead of the September 30 deadline set for their withdrawal.

The older versions of smaller denominations will remain in circulation alongside the new ones launched June 1, but after October 1, the older Sh1,000 notes would be invalid in changes initiated to tackle illicit financial flows and counterfeiting.

"Let's just say those transactions are quite a concern for us. I don't want to say more but I think it's important for you to know we are following things around the country."

Official data indicated that more than 40 per cent of the Sh540 billion in circulation on June 1, when the old currency withdrawal notice was issued, were Sh1,000 notes. Its relative preference by Kenyans in transactions has also seen it favoured by those making fake currency and dealers hiding illicit cash outside the banking system.

Dr Njoroge yesterday said that 58 percent of the older notes returned to the banking sector in the three months to September were below Sh500,000, a pointer that people with huge amounts of dirty money ignored the system in their quest to dispose of the Sh1,000 notes.


"A lot of conversions are small. Small in value and small in number," said Dr Njoroge. "The numbers are small, the values are small and also the pace has come down." Under the CBK rules, those seeking to exchange more than Sh5 million require the regulator's approvals. A basic assessment will be done on source and ownership before authorisation is granted.

The central bank's nod will also be required for those seeking to exchange at least Sh1 million and have no bank accounts. "For between Sh1 to Sh5 million, you will need to go to your bank where they know you, your type of business and they will still ask the usual questions and you sign the usual declaration forms just like it has been done before," Dr Njoroge said.

"Those who do not have bank accounts and want to exchange this amount will need to contact the CBK. We will then endorse them and they can go to a designated bank branch." This stringent rules could have discouraged those with illicit money from exchanging the old notes in banks.

The central bank has not quantified the volume of illicit flows but there has been enough evidence to force the authorities to act, the governor said. Dozens of Kenyan government officials and business people have appeared in court since May 2018 on charges relating to the alleged theft of hundreds of millions of shillings from public coffers.

ARLIER this week, Bank of Tanzania slapped a 1.8bn/- penalty on five commercial banks for violating regulations which encouraged money laundering.

In a statement, BoT named the penalised banks as BancABC, Equity Bank, I&M Bank, UBL Bank and Habib African Bank. The central bank said the five banks had filed suspicious transaction reports to the Financial Intelligence Unit (FIU), a branch of the central bank.

"The Bank of Tanzania has imposed monetary penalties on five banks for breach of regulations 17, 22 and 28 of the Anti-Money Laundering Regulations, 2012 for failure to conduct proper customer due diligence and filing suspicious transaction reports to the Financial Intelligence Unit," the statement stated.

This latest central bank punitive action comes hardly a week after Tanzania Bankers Association introduced a Code of Conduct for the country's banking industry which according to TBA's Chairman, Abdulmajid Nsekela, is a document developed by bankers themselves with BoT

Speaking during the TBA Code of Conduct's launch in Dar es Salaam, both Minister of Finance and Economic Affairs, Dr Philip Mpango and BoT's Governor Professor Florens Luoga commended the bankers for coming up with the self regulatory document which they said will go a long way in restoring customer confidence in the industry.

Dr Mpango who launched the TBA Code of Conduct said took issue with micro-lenders who are charging low income people who include civil servants, high interest rates of over 30 percent.

He revealed that a few days ago, he was summoned by Prime Minister, Kassim Majaliwa who informed him about a microlending firm that charged civil servants 30 percent interest rate after borrowing from banks at 20 percent.

"These micro-lending loan sharks should abide by this banking industry code of conduct," Dr Mpago ordered while directing Bank of Tanzania to undertake a countrywide audit of such institutions which are preying on the poor who cannot access bank

"When I asked this microlender why he was charging such a hiked interest rate, he said its because of a large percentage of defaults and his small capital," the ex-chequer chief charged warning that Treasury will reign in all rogue lending institutions including banks.

"This code of conduct is the best thing to have happened today because it will restore the public's confidence in the banking industry," the Finance and Planning Minister added while stressing that BoT should also work with banks to ensure that the current interest rates are lowered because they are prohibitive to anyone wishing to borrow

for investment. In his remarks at the same gathering, Professor Luoga backed Minister Mpango's orders and promised to work together with TBA to ensure that ethical behaviour and professionalism are restored in the banking in-

Prof Luoga said despite the fact that the country has over 50 banks of which the majority are foreign, consumers are not transacting through the banking system because of a number of factors which BoT is currently studying.

"Banks need public confidence and this code of conduct is an important milestone towards such a goal," the central bank chief argued while stressing that many people borrow money and wire money abroad through nonbanking systems.

"Globally, the banking industry is facing issues of public scrutiny, even the Swiss banking industry is shrouded in the controversy of keeping looted money from countries," he noted.

Seconding the duo's observations, TBA chair who is also CRDB Bank Plc's Managing Director, Nsekela said the idea of the code of conduct was jointly developed with BoT collaboration because of the need to restore public confidence in the banking industry which is crucial in

support modern economic growth through investments.

"None of us should ignore this code of conduct because any violations will have consequences as it has been agreed by all of us," the TBA chief underlined. Among other things, the code denounces money laundering, poaching and other forms of organised crime whose proceeds have for sometime been channelled through banks.

The 16 pages TBA Code of Conduct also stated that, "TBA and its members also recognise that banking institutions are trustees and custodians of public money and in order to fulfil their fiduciary role as well as other obligations and responsibilities, they have to win the trust and confidence of the general public.'

The TBA said its members are aware that in order to realize the general objectives of an ever-growing and stable banking sector, it is imperative to raise and maintain the level of quality of banking products and services; use available resources appropriately, preventing unfair competition; thus, formulate and regulate relations of banking institutions with each other as well as their relations with customers, shareholders and employees in line with ethical principles.

"Therefore, TBA and its members acknowledge the need to uphold and maintain at all times the highest level of professionalism, honesty, integrity, impartiality and diligence by all its members and their employees. As a fraternity, it is also conscious of the reputation it carries amongst the body of its customers generally and individually and the public at large; and thus endeavours to do all it can to set the level of standards of conduct, improve and maintain the same in its discharge of obligations in the economy," the code added.

TBA and its members desire to formulate, adopt and implement an effective Code of Conduct, which shall among other things prescribe standards and levels of expected and desired conduct of members and their employees, in terms of principles, obligations and manners of enforcing

adopted and implemented with the overall objective of ensuring strict adherence to best banking practices and strong commitment to adherence to highest ethical and professional standards in the banking industry in Tanzania. It shall thus extend and be applicable to all members, as institutions, their directors (both nonexecutive and executive), managers at all levels and howsoever

designated, employees, including permanent, temporary, part-time, casual and in-sourced personnel of independent contractors. And, appropriately and as the context requires, the terms of this Code of Conduct shall equally apply to all TBA stakeholders, either directly or indirectly relating to a member," the code noted.

Among the key objectives of the Code of Conduct as per TBA, include to uphold the highest level of professionalism, integrity, honesty and fairness amongst all its Members and their employees. Thus, it endeavours to do all it can to improve and maintain this course.

"Accordingly, the objectives of this Code of Conduct are to ensure strict adherence to best banking practices and continued commitment to ethical conduct and professional standards by all its members and their employees in order to foster TBA's core values, namely integrity, professionalism, customer-centricity, unity teamwork," the coded added.

Among the TBA members' obligations are: Adhere to the honesty principle in their relationships with customers, employees, shareholders and other members of the general public; Introduce internal regulations providing measures and sanctions for the prevention of employees from defrauding and taking advantage of customers; and, or involving themselves in fraudulent and corrupt practices, among others.


In conclusion, TBA said the Code of Conduct shall be enforceable and binding to all members and their employees. "Every member shall accept and subscribe to this Code of Conduct by signing the prescribed attestation form and cause it to be read, understood and acknowledged by its employees. The TBA Secretariat shall keep record of the attestation form duly signed by a member.

The Code of Conduct and enforcement shall be executed and enforced by the Governing Council of TBA. It shall be the duty of every member to ensure compliance with the Code and provide cooperation to TBA and other members to enforce it.

Under sanctions, the Code stated "Therefore, this Code of Conduct is that the Governing Council may impose any of the following sanctions to its members for violating this Code of Conduct: Warning, censure, suspension and finally report to the regulator.

"A member shall be responsible for the enforcement and imposing appropriate sanctions to its employees for violating this Code in accordance with its internal disciplinary procedures and underlying employment and labour laws," the Code concluded.

Be careful what you wish for: **Impeachment inquiry poses** risks for 2020 Democrats

WASHINGTON

THE crowded field of Democratic presidential candidates were nearly unanimous in praising House Democrats' decision to begin an impeachment inquiry into Republican President Donald Trump over accusations he sought foreign help to smear a political rival.

Now comes the hard part.

With impeachment set to overshadow the Democratic presidential primary race, how will candidates draw attention to their key policy issues, ranging from universal healthcare to income inequality?

After months of resisting pressure from fellow Democrats, House Speaker Nancy Pelosi announced the launch of a formal impeachment effort on Tuesday, accusing Trump of seeking foreign help to damage Democratic presidential front-runner Joe Biden ahead of the November 2020 election.

Trump had pressured Ukrainian Pres-

phone call to investigate Biden and his son Hunter, who had worked for a company drilling for gas in Ukraine.

The impeachment inquiry ensures a partisan fight in Congress and on the presidential campaign trail in the com-

Kurt Meyer, Democratic party chairman for three rural Iowa counties north of Des Moines, the state's most populous city, said he expects the impeachment proceedings to energize the Democratic

"If a highly motivated person drags her mother and her husband and her second cousin twice removed to the polls, then it makes a difference," Meyer

But in a sign the probe could energize Trump's base as well, his re-election campaign raised a quarter of a million dollars in just 15 minutes on Tuesday in the immediate aftermath of Pelosi's announcement about the probe.

Trump was quick to portray himself as the victim of partisan Democratic at-

fundraising appeals to his supporters on Tuesday pegged to the impeachment launch.

There is also a risk that any substantive policy discussions among the 19 Democrats running for the party's nomination to take on Trump in the 2020 election will be drowned out in the growing battle between allies and foes of Trump, several Democratic strategists and experts said.

"Trump has been the elephant in the room, but the democratic debates so far have been really policy centered. I think impeachment now takes center stage," said Erin O'Brien, associate professor of political science at University of Massachusetts,

Doug Heye, a Republican strategist who worked with congressional leaders, said Republican messaging just got simpler, if less positive.

"For Democrats running for president, breaking through on healthcare or the economy just got a lot tougher," he said. "Impeachment will be the dominant topic for a long time."

'SUBJECT OF TRUMP'S AFFECTION'

Biden, who leads polls in the Democratic race ident Volodymyr Zelenskiy in a July 25 tacks, while his campaign sent repeated to pick a challenger to Trump, said on Tuesday he

would back impeachment if the Republican president fails to comply with congressional requests for information on Ukraine and other matters.

Trump has raised unsubstantiated charges that Biden improperly tried to halt a Ukrainian probe of a company with ties to his son, without providing any evidence of wrongdoing by either.

Later on Tuesday as he called into a fundraiser in Baltimore, Maryland, Biden said he "can take these

"And the reason I am being attacked is that most polls show me beating him by 10 to 15 points. I am not at all surprised I have become the object of his affection and attention," he said.

Biden leads Trump by about 5 percentage points in a hypothetical general election match-up against Trump, according to the Sept. 23-24 Reuters/Ipsos opinion poll released on Tuesday.

In a sign that Biden's supporters are largely standing by their candidate so far, 20% of Democrats and independents said they would vote for him in statewide nominating contests that begin next year according to the latest poll, up 1 percentage point from a similar poll that ran last week.

Trudeau's brownface-blackface controversy erodes his public support in Canadian election campaign

JUSTIN Trudeau's blackface images released ahead of next month's general election could imperil his attempt to obtain a second term as Canada's 23rd prime minister, polls showed on Tues-

On Tuesday, global polling company Ipsos reported that Trudeau (pictured) and his Liberal Party is now trailing the official opposition Conservative Party by 4 percentage points following the release of two photos and one video last week that show the 47-year-old prime minister in brownface and blackface dating back to 2001 and before.

If the Canadian election were held now as opposed to on Oct. 21, 36 percent of decided voters would choose the Conservative Party while 32 percent would opt for the Liberal Party, according to the Ipsos poll that was conducted for Canadian media network, Global News.

Meanwhile, another survey conducted by Canadian public opinion researcher the Angus Reid Institute and released on Monday, found the governing Liberals 5 percentage points

behind the opposition Conservatives.

The release of images of Trudeau wearing dark makeup, which made international news headlines and was pilloried on U.S. talk shows, was "too big to not have an effect,"said Darrell Bricker, chief executive officer of Toronto-based Ipsos Public Affairs.

"The damage done is to his credibility as a leader and his fitness for office, not whether he should be forgiven for what he did," said Bricker, explaining why public support for Trudeau and his party is slipping.

Ipsos found that 60 percent of Canadians disapprove of the Trudeau government's performance and 64 percent believe it's time for another political party to form the next government -- four years after the Liberals ended the Conservatives' near decade-long

However, only 20 percent of respondents in Ipsos's poll believe the prime minister should resign over what Trudeau himself acknowledged to be racist behavior before he first won a seat in Canada's Parliament nearly 11 years ago, 45 percent felt his



apologies last week were sufficient. Trudeau's own popularity has suffered too since the brownface-blackface issue surfaced.

Last week, Trudeau enjoyed a seven-point lead over lowerkey Conservative Party leader Andrew Scheer as the preferred choice among Canadians for prime minister, according to

This week, Trudeau leads

Scheer by only two points: 33 percent-versus-31 percent.

Bricker, who briefly served as director of public-opinion research in former Canadian Progressive Conservative Prime Minister Brian Mulroney's office, expects more conservatives than progressives will vote in the October election because they will be "enthusiastic" to topple Trudeau.

The reverse was true in 2015

when more liberal-minded voters turned out at the polls because they saw Trudeau as an agent of change, said Bricker, who sees the turn against the prime minister the broader result of a "confluence of bad things that have happened to him since January."

In his first interview since the controversial images emerged last week, Trudeau told Global News on Tuesday that he has not darkened his skin since 2001 when he appeared in a photo as a brownfaced character from Alladin, which Time magazine published Wednesday.

But the Canadian Liberal leader declined to answer a question as to whether he has any other "skeletons in the closet." "We've all done things that we're unhappy with and things that we learned from. I'm no different than anybody else," Trudeau told Global News' national anchor Dawna Friesen. "People know I'm not perfect. **Xinhua**

Find a way out for Hong Kong

HONG KONG has been put in chaos for about 100 days. While many of the arguments of the violent protesters become increasingly invalid, the truth gradually comes out in the wash. What actually happened in Hong Kong? Where is the way out?

If what they want is merely to oppose the amendments to the extradition law, then the protesters already got their wish three months ago.

But they continued with protests and constantly escalated violence, indicating that those who planned, organized and supported the violent protests must have some ulterior motive at the very beginning.

The demonstrations that took place in the past were basically staged in a peaceful manner, where the protesters immediately stopped after they made their points.

This time, however, these radicals don't seem to give up until they destabilize or even destroy Hong Kong to realize the ultimate goal of putting China in a mess and hindering the progress of the country.

Under such circumstances, the first priority is still to stop the violence, end the chaos and restore order.

The situation is already very clear. The current chaos in Hong Kong has nothing to do with human rights, freedom or democracy. US launches strike in southern Libya as UN warns of escalation

CAIRO

U.S. forces said yesterday they killed 11 suspected militants in their second air strike in a week near the southern Libyan town of Murzuq, as the U.N. envoy warned of a growing risk of armed escalation and rights abuses in the country.

The strike comes as rival factions have been locked in a battle around the capital Tripoli, about 500 miles (800km) to the north, which forces loyal to easternbased commander Khalifa Haftar have been trying to capture since April.

The U.S. attack, carried out on Tuesday deep in Libya's southern desert, followed a Sept. 19 strike that the U.S. said had

killed eight suspected militants.

"This air strike was conducted to eliminate ISIS (Islamic State) terrorists and deny them the ability to conduct attacks on the Libyan people," Major General William Gayler (pictured), director of operations for U.S. Africa Command, said in

a statement. Some Islamic State militants retreated south into Libya's desert as the group lost its stronghold in the coastal city of Sirte at the end of 2016.

The U.S., which has carried out occasional strikes in desert areas, has said it will not allow militants to use the fighting

around Tripoli for cover. The offensive on Tripoli by Haftar's



Libyan National Army (LNA) upended U.N.-led plans to broker a political settlement in Libya and soon stalled in the

capital's outskirts. The conflict has spread outside Trip-

oli, with air and drone strikes against the port city of Misrata, Sirte, and Jufra in central Libya, U.N. Libya envoy Ghassan Salame told the U.N. Human Rights Council yesterday.

It had also triggered a "micro-conflict" in Murzuq, where more than 100 civilians are reported to have been killed over the past two months, he said.

"The conflict risks escalating to fullblown civil war," Salame said by video link. "It is fanned by widespread violations of the U.N. arms embargo by all parties and external actors.'

"Serious violations of human rights and humanitarian law have been committed with total impunity, including increased summary executions, enforced disappearances, torture and ill-treatment as well as conflict-related sexual

violence." Libya has been divided between rival factions based in Tripoli and the east since 2014, three years after a NATObacked uprising ended Muammar Gaddafi's four-decade rule.

Haftar's LNA is battling forces aligned with the Government of National Accord (GNA), which was set up in 2016 following a U.N.-brokered deal.

Kenneth Bagamuhunda, director general of customs and trade at East African Community (EAC) said in Nairobi that for most EAC countries, their main trade partners are not another member of the trading bloc and intra-regional trade stands at less than 13 percent.

"A single currency regime is expected to lower the cost of trading transactions among partner states and hence boost level of imports and exports within the region," said Bagamuhunda during a media briefing on the upcoming high-level conference on trade Integration in the

Johnson heads home early to face political heat after dramatic day in UK highest court

LONDON

BRITISH Prime Minister Boris Johnson cut short his visit to a crucial UN general assembly summit in New York Tuesday to head back to London after judges ruled his shutdown of the Houses of Parliament was unlawful.

He is expected to face immediate demands to turn up at the House of Commons to address politicians after a day of high drama in the Supreme Court, the highest court in Britain.

Johnson was made aware before he left the U.S. of growing demands for him to quit 10 Downing Street after 11 of the country's most senior judges ruled he was wrong to prorogue, or suspend parliament for five weeks.

They unanimously decided that Johnson's advice to British monarch Queen Elizabeth II on proroguing parliament was unlawful, void and of no effect.

Legal experts had been anticipating a ruling that left Johnson with some wriggle room to escape the full wrath of the law. In the event the court decision could not have been worse for Johnson.

Within hours of the judges handing down their ruling, the Speaker of the House of Commons, John Bercow, announced parliament would re-open at 11:30 a.m. Wednesday, weeks be-China's national willpower is fac- combine confidence, cheerfulness fore the scheduled State Opening by Queen Elizabeth on Oct. 14.

RUSSIA supports all legitimate bodies of power in Venezuela, including the institution of presidency, and President Nicolas Maduro's dialogue with the opposition forces. Russian President Vladimir Putin said at a meeting with the Venezuelan leader yesterday.

"Russia consistently supports all the legitimate bodies of power in Venezuela, including the institution of presidency and the parliament. And we, undoubtedly, support the dialogue, which you, Mr. President, and the government are holding with the opposition forces. We consider any refusal to hold a dialogue as irrational and harmful for the country and as posing only threats to the popula-

tion's well-being," Putin said. Moscow always supports legitimate bodies of power, Putin added.

The Russian leader also noted cooperation between Moscow and Caracas in the military and technical sphere, which is primarily related to Russia's commitments to provide maintenance for Russian-made armaments purchased by Venezuela. This relates to delivering spare parts and setting up maintenance

"All this work is proceeding pursuant to the schedule, in strict compliance with our agreements," the Russian president said.

UNITED NATIONS

SOUTH Korean President Moon Jaein on Tuesday proposed transforming the demilitarized zone (DMZ) between the two Koreas into an international peace zone.

"Today ... I would like to propose to the United Nations and all the member states the idea of transforming the DMZ that cuts across the midriff of the Korean Peninsula into an international peace zone," Moon told the UN General Assembly General Debate. "The DMZ is a colossal green zone

that stretches 250 km from east to west and 4 km from north to south. Its borders define a tragedy spawned by 70 years of military confrontation. But paradoxically, it has become a pristine ecological treasure trove," he said. "It has also become a symbolic space steeped in history, which embraces both the tragedy of division as embodied by the Joint Security Area, guard posts and barbed-wire fences as well as the yearning for peace."

"The DMZ is the common heritage of humankind and its value must be shared with the whole world. Once peace is established between the two Koreas, I will work together with North Korea (the Democratic People's Republic of Korea, DPRK) to inscribe the DMZ as a UNESCO World Heritage Site," said Moon.

He put forward the idea of designating the area connecting the border village of Panmunjom and Kaesong in the North as a peace and cooperation district, and making the DMZ a center for research on peace, peacekeeping, arms control and trust-building.



China hails Russia's accession to Paris climate agreement

THE Chinese government welcomes Russia's decision to adopt the Paris Agreement on climate change, Foreign Ministry Spokesperson Geng Shuang told reporters yesterday.

"China welcomes Russia's adoption of the Paris Agreement on climate. We believe that this shows Russia's constructive stance and responsible approach to climate change. This will contribute to our common efforts on fighting this problem," the spokesperson said.

Russian Prime Minister Dmitry Medvedev signed a government decree related to Russia's accession to the Paris Agreement on climate action on Monday. Russian Deputy Prime Minister Alexei Gordeyev announced plans on developing and adopting the required acts on fulfilling the country's commitments under the deal.

The Paris Agreement was signed on December 12, 2015 after an international climate change summit in the French capital city. The ratifying states agreed to take efforts to keep the increase in global average temperature below 2 ° C above the preindustrial levels by 2100. I

n June 2017, US President Donald Trump announced that the US was going to pull out of the Paris climate accord, thus rendering the target under the agreement unachievable.

World leaders call for multilateral approach towards common challenges

UNITED NATIONS

WORLD leaders attending the ongoing General Debate of the 74th session of the United Nations General Assembly (UNGA 74) on Tuesday voiced strong support for multilateralism and called for international cooperation to tackle common threats and challenges together.

Croatian President Kolinda Grabar-Kitarovic said that "joining forces" should be the fairly simple way to respond adequately to emerging threats.

"It is upon us to address the greatest challenges of the globalized 21th century: climate

change, sustainable development, migration, terrorism, weapons of mass destruction and new technologies," said the Croatian president.

South Korean President Moon Jae-in also called for international cooperation, noting that "the Sustainable Development Goals of the United Nations and the Paris Agreement on climate change are major tasks that we must achieve through multilateral coopera-

"We come here in recognition of a simple reality - this General Assembly is vital to meet the dangers and seize the opportunities of our world," said King Abdullah

Collective action is "the promise" of the United Nations, he said.

"This organization was created by the specific, individual actions of member countries, coming together to shape a better future," the king added.

"And today, we still urgently need each and every member country to act - to act together with our global neighbors and achieve the better, safer world all of us need," he said.

"The world faces enormous and diverse cross-border challenges between peoples and states and that imposes on us multilateral action, especially when it comes

to risks threatening international peace and security, environmental issues, sustainable development, asylum and immigration," said Qatari Emir Sheikh Tamim bin Hamad Al Thani.

"In the situation of international peace and security, nothing can replace the wisdom of leaderships, especially those of the major powers, who are capable of embracing the purposes of the United Nations Charter," he said.

"We have no means at our disposal other than activating the mechanisms adopted by the international community in the field of collective security, deterring international law violators,

ensuring the respect for the sovereignty and security of states, prohibiting the occupation and annexation of the lands of others by force or changing their nature, and preventing armed conflicts by means of peaceful resolution of disputes," he added.

"We stand for multilateralism in international relations, as it alone contributes effectively to the world's peace and security," said Angolan President Joao Lourenco.

"For this reason, it is never too much to insist on the need for a deep reform of the United Nations Organization, so that it can better fulfill its great responsibility for conflict management and resolution and war prevention," said the president.

Portuguese President Marcelo Rebelo de Sousa stated his support for "an effective multilateralism, based on international law and the Charter of the United Nations and its legal extension to new global realities such as the environment and climate change, the oceans, data protection, cybersecurity, combating terrorism and artificial intelli-

gence.' "Nobody is an island and nobody can, alone or with a handful of allies, address the increasingly complex problems affecting eve-


rybody," said the president. "The world and life change so

much and we have seen a great deal of geostrategic change in less than 40 years. We and our descendants will witness many more, ever faster changes in the next 40 years," he added.

"The most prudent stance is to support this institution [UN] which is about to celebrate its 75th anniversary, and strengthen its financial sustainability, its ability to act and facilitate networking, dialogue, conflict prevention, and match initiatives in areas of common interest," he added.

Domingo withdraws from Met Opera after harassment reports

NEW YORK

THE Metropolitan Opera announced Tuesday that Plácido Domingo had agreed to withdraw from his slate of scheduled performances at the opera house following allegations of sexual harassment made by multiple women in two Associated Press stories. The opera legend indicated that he would never again perform at the Met.

Domingo had been scheduled to sing the title role in the season premiere of Verdi's "Macbeth" on Wednesday night, which would have been his first performance in the United States since the AP reported that numerous women had accused him of inappropriate behavior, including one soprano who said he grabbed her bare breast.

The Met had been under increasing pressure to cancel Domingo's appearances, but general manager Peter Gelb reiterated to performers after a dress rehearsal Saturday that the opera house was awaiting results of investigations by the LA Opera, where Domingo has been general director since 2003, and the American Guild of Musical Artists, the union that represents various opera staff.

Domingo, who had sung in rehearsals, issued a statement saying his Met career was over after what the company said was 706 performances as a singer, plus 169 as a con-

"I made my debut at the Metropolitan Opera at the age of 27 and have sung at this magnificent theater for 51 consecutive, glorious years," the star said. "While I strongly dispute recent allegations made about me, and I am concerned about a climate in which people are condemned without due process, upon reflection, I believe that my appearance in this production of 'Macbeth' would distract from the hard work of my colleagues both on stage and behind the scenes.

"As a result, I have asked to withdraw," he added, "and I thank the leadership of the Met for graciously granting my request. I am happy that, at the age of 78, I was able to sing the wonderful title role in the dress rehearsal of 'Macbeth,' which I consider my last performance on the Met stage."

In its statement, the Met said the long-married, Spanish-born superstar had "agreed to withdraw from all future performances at the Met, effective immediately."

Opera and Dallas Opera previously canceled upcoming concerts starring Domingo after the AP stories were published. But his reception has been far different in Europe, where he received lengthy ovations after concert performances of Verdi's "Luisa Miller" at the Salzburg Festival in Austria on Aug. 25 and 31,

Angela Turner Wilson, the singer who allowed the AP to use her name in accusing Domingo of grabbing her breast, said she was "relieved" by the Met's action, but criticized Gelb for previously asserting that the opera house could not act without corroborated evidence and that all of Domingo's accusers

"a major concern to me and many others who wish to see the current culture of sexual harassment and retaliation removed from our industry. It is time."

Another of Domingo's accusers, Patricia Wulf, also called the withdrawal a relief.

"I feel like we accomplished something," said Wulf, who accused Domingo of repeatedly harassing her during performances at Washington Opera in the late 1990s, while he was general director of the company.

"The Met finally stepped up and did the right thing," she told the AP.

In addition to announcing Domingo's withdrawal, Gelb said the Met was suspending tenor Vittorio Grigolo pending the outcome of an investigation opened Tuesday by The Royal Opera in London, which said he was alleged to be involved in a Sept. 18 incident when he sang the title role in Gounod's "Faust" on tour

Grigolo, 42, was scheduled to sing six performances of Alfredo in Verdi's "La Traviata" at the Met in February and March. He did not immediately respond to an email seeking comment.

The Met fired conductor James Levine in March 2018 after an investigation by a law firm retained by the company found evidence of sexual abuse and harassment. Levine, the company's music director from 1976-2016, was music director emeritus at the time and denied the allegations. He filed a breach of contract and defamation lawsuit that was settled last month.

Domingo made his Met debut in September 1968 and is known to many beyond opera for his performances as part of The Three Tenors with Luciano Pavarotti and José Carreras. Singing far beyond the retirement age of most singers, he shifted to baritone parts in 2009, extending his repertoire to more than 150 roles. He sang 21 opening nights at the Met, breaking Enrico Caruso's previous record of

Domingo's next scheduled performance is in Verdi's "Nabucco" at the Zurich Opera on Oct. 13. He is not slated to sing in the U.S. until Donizetti's "Roberto Devereux" at the LA Opera, which opens Feb. 22.

Zeljko Lucic, originally scheduled for later in the run, will replace Domingo and sing all six performance of "Macbeth" at the Met. Domingo also had been scheduled for four performances as Sharpless in Puccini's "Madama Butterfly" at the Met in November.

Outside the Met entrance Tuesday night, a poster advertising the "Macbeth" production had Domingo's name whited out, with the name of his replacement covering it.

Column: From orphan in China to playing with pros at Pebble

KAYLI Lucas is headed to Pebble Beach to play in a PGA Tour Champions event, a dream week for a 17-year-old girl from Tennessee who knew nothing about golf until a friend from church invited her out for a lesson at

She liked how the club felt in her hands. Like so many others brought to golf, she found that the greatest appeal was the individual test to get better.

"I'm goal-oriented," she said. "I wanted to prove to myself how far I can go on my own." How far she can go?

It's how far Kayli already has come that makes her appearance in the Pure Insurance Championship so amazing.

Her mother calls the trip to Pebble Beach a "once-in-a-lifetime deal." Kayli was among 78 participants from The First Tee chapters around the country who were selected to compete alongside PGA Tour Champions players like Bernhard Langer and Mark O'Meara, Vijay Singh and Davis Love III.

But then, everything about Kayli is once in a lifetime.

For starters, she doesn't know exactly where she was born, or even when. She was an infant when she was found outside an equipment factory in Nanjing, China, and taken in as an orphan. That's about the time Lisa Lucas

showed up as part of a 20-month process to adopt a baby girl.

The orphanage sent her a picture, and Lucas could see in the baby's eyes something was not quite right. No matter. She wanted her. When they arrived in Nanjing and switched the girl out of her clothes, her entire body was covered with scabies, which had led to a staph infection. Lucas said the baby was rushed to a hospital.

"They said two weeks longer and I would not have had my child," Lucas said. "She's a miracle all the way around. She was about 9 months when we got her and from lack of human touch, she could barely hold her head up. Two weeks before we left, she was sitting up on her own."

Her muscles were underdeveloped. She had a bald spot in the back of her head through elementary school.

Kayli knows her story now.

Her mother waited until she was old enough to understand that she was born in China and was very sick, that they have no idea about her birth parents and never will. The orphanage had a rough idea of Kayli's age when they found her, so Lucas chose Oct. 14 as her birthdate for the official record.

"I'm not brought up in an Asian-oriented household. I don't necessarily think about it," Kayli said. "I don't think I fully understood it until five years ago. I never Googled the city where I was found, or born, until a school project. We had to do an autobiography."

Hers, no doubt, was different

from her classmates. Lucas remarried and moved to Gallatin, about 30 miles northeast of Nashville. She wanted her daughter to be more active, whether that was gymnastics or something else. Her friend invited her to The First Tee, and Kayli asked her stepfather, Greg Borchers, to at least show how her how to swing a club before her first lesson.

She was hooked.

Josh McCade, the executive director of The First Tee of Tennessee, could tell she was different. Sure, he heard enough conversations over the years to piece together Kayli's story. What he saw was someone who made the most of opportunities, and golf was no different.

"She had this eagerness to learn the game of golf," McCade said. "That was something you could tell. After class, she'd be hitting balls on the range, putting and chipping on her own. You can separate kids from who's there because they want to be there. She has a great spirit about herself."

Kayli says Borchers has invested the most time in her game, how to treat the course and manage her game. The teachers at The First Tee and Gallatin High have honed her swing. "Without them, my swing would be a hot mess," she said with a laugh.

FIFA president lambasts Italian soccer for 'hiding' racism

FIFA president Gianni Infantino lambasted Italian soccer authorities for "hiding the truth" about racism in a scathing assessment Tuesday following a complete lack of punishment after three cases of discriminatory chants during the four opening rounds of Serie A.

Three black players - Inter Milan's Romelu Lukaku, AC Milan's Franck Kessie, and Fiorentina's Dalbert Henrique - have been targeted by racist chants but no sanctions have been handed out by the Italian league, federation or police.

"I don't see why we have to hide the truth, not talk about what happens or say that it is not serious. No, that's not how you go about it," Infantino said in an interview with Sky Italia. "It's unacceptable, absurd and surprising.

"It's upsetting, because Italy is a country that people love, where you can live and eat well, where there's culture," added Infantino, who is the son of Italian immigrants to Switzerland. "This is supposed to be a modern, civil, polite country. And I think it's moving in the wrong di-

Infantino suggested identifying fans responsible of racism and throwing them in jail, calling on the Italian federation to work with its clubs and local police.

Likewise, the Italian government's new sports minister vowed to eliminate racism "with more severe and efficient sanctions.'

"I will dedicate myself toward eliminating it from stadiums during my mandate - even at the cost of making unpopular decisions," Vincenzo Spadafora, the minister, told Spanish newspaper El Pais.

"The time has come for everyone to assume responsibility: institutions, politicians, federations and

Atalanta's 2-2 draw with Fiorentina on Sunday was suspended briefly during the first half due to chants aimed at Dalbert.

However, the Italian league's judge announced Monday that he has yet to decide whether Atalanta warrants punishment. Judge Gerardo Mastrandrea said in his weekly disciplinary report that Dalbert needs to be interviewed before his decision is made.

Following FIFA's "three-step process" for handling racism inside stadiums, referee Daniele Orsato ordered a warning to be read over the stadium's loudspeaker that the match would not resume until the chants ceased.

The FIFA process requires the referee to briefly pause a match at the first hint of discriminatory chants and request an announcement over the stadium public address system asking fans to stop. If the chanting persists, the referee can suspend the match and order the teams into the changing rooms until it stops. If that doesn't work, the referee can stop the match definitively.

While the FIFA process is straightforward it has rarely been implemented in Serie A.

"The problem is, we have some laws stipulating that if it's a concrete number of people we stop the match. If it's 2, 3 persons or 10 persons then we cannot stop the match," Danilo Filacchione, the Italian football federation's international relations director, told The Associated Press in Ljubljana, Slovenia, after attending a UEFA meeting.

UEFA announce Champions League finals in Saint Petersburg, Munich, London

THE 2021 UEFA Champions League final will be played in Saint Petersburg, European football's governing body announced on Tuesday.

The venues for the next three finals were revealed at UEFA's Executive Committee meeting in the Slovenian capital Ljubljana, with Munich being awarded the 2022 showpiece and the 2023 final being given to Wembley.

In awarding the venues for the next three years, UEFA have had to take into account not just the likely demand for match tickets but also the importance of hotel rooms and transport infrastructure.

That means there are a limited number of cities around Europe capable of successfully staging a match of such magnitude.

"The chosen venues have proper mobility, hotels and everything else. Where we have a problem, and probably will have a problem anywhere, is that sometimes hotels take advantage of the fact the Champions League final is in a certain city," admitted UEFA president Aleksandar Ceferin.

"I am sure that if you check those three cities in half an hour you will see that hotel prices have already started to rise.

"This is a problem but it is hard

"Those venues are big cities, interesting cities, accessible for the fans and with very nice stadiums," he added, although he said he "cannot do any promises for now" in terms of increasing ticket allocations for supporters.

the 68.000-capacity Gazprom Arena in Saint Petersburg.

The venue, complete with a retractable roof, was built ahead of the 2018 World Cup held in Russia. It hosted seven matches at that tournament, including France's semi-final win over Belgium and will also host four games at Euro 2020.

It will be the second Champions League final to be played in Russia This season's final will be played after Manchester United beat Chelsea

in Moscow to win the trophy in 2008.

The 70,000-seat Allianz Arena in Munich is also a host venue for Euro 2020 and staged the 2012 Champions League final when Bayern Munich lost on penalties to Chelsea.

The 2023 final will be the eighth to be held at Wembley, with the iconic 90,000-seat London venue also hosting the semi-finals and final of next year's European Championship.

Meanwhile, European football's governing body also revealed that the 2021 Europa League final will be played in Seville, at Sevilla's Ramon Sanchez Pizjuan stadium.

The Spanish city was chosen ahead of Georgian capital Tbilisi as the game returns to western Europe -after being staged in Baku last season, next year's final will go to the Polish city of Gdansk.

The 2021 UEFA Super Cup match -- between the winners of the Champions League and Europa League -- will be played in Belfast.

UEFA said VAR, which made its Champions League debut in the last 16 last season, will be introduced to the Europa League for the knockout rounds this term.

A third European club competition that is set to start in 2021 will be known as the UEFA Europa Conference League.

Why 16-year-old Camavinga already has Europe's top clubs on high alert

SINCE the beginning of August, Stade Rennais have seen two things experience massive growth in their day-to-day operations as a football club and both of them are related to one player in their squad.

The first thing is the requests for match tickets from scouts all over Europe, which have soared. The second is the solicitations for sitdown interviews, which have also multiplied. All this for a 16-year-old kid who still can't drive his own car. is still going to school, still lives at the Academy and has played only 12 Ligue 1 matches in his career.

Eduardo Camavinga has just enjoyed the best month of his life. The midfielder was named Ligue 1's best player in August after stellar performances against Montpellier, Strasbourg and Paris Saint-Germain. He bossed the PSG midfield like few players do in France, let alone at 16. He outplayed Marco Verratti and Marquinhos and made a real name for himself that night but nothing about Camavinga's success feels like

Eighteen months ago, at the age of 15, Camavinga was already playing with the Rennes reserve team in the French fourth division and making a difference. Landry Chauvin, the former Rennes academy director, saw the phenomenon up close.

"Since he joined us at 10 years old from a local club, he was destined for great things. He was always ahead of everyone else in his age group but also everyone else one or two age groups above [him] in terms of talent, intelligence and maturity," Chauvin told ESPN FC.

Camavinga's prodigious talent was there for everyone to see. At the beginning of 2019 when he started to train with the first team, some were gobsmacked by what he could do.

"We were like 'wow," Hatem Ben Arfa, who played with Camavinga last season at Rennes, told ESPN FC. "He was incredible. Technically and physically, he is a monster. Everything he does is perfect. For me, he is the modern midfielder by definition. There is nothing he can't do. He can defend, tackle, head the ball, create, score, assist. He is powerful but gifted technically with his left foot. He is intelligent, elegant.

"You would have rarely seen a player like him at his age. Because let's not forget: he's still 16."



Camavinga's superb start to the Ligue 1 season has led to all kinds of player comparisons even though his position in the heart of midfield differs from that of other French prodigies. To one old coach, he's the next Kylian Mbappe. Chauvin compares him to Ousmane Dembele, expecting his career to take a similarly steep trajectory as Dembele, who moved from Rennes to Borussia Dortmund to Barcelona in just two years, but also admits that Camavinga is already more serious, disciplined and professional than Dembele has ever been.

His manager, Julien Stephan, is doing his best to keep his young star midfielder grounded. "He has huge potential and, if you can believe it, we didn't want to rush him into the first team," he said. "But there is a moment when you realise that there is no need to wait any longer because he is ready and he will bring a lot to the team even in Ligue 1.

"I just hope he will continue to work hard, continue to learn and to develop. We will certainly put him in the right environment for that."

Born in Angola to Congolese parents, Camavinga arrived in France with his family when he was 2. He grew up with his parents and five brothers and sisters on the outskirts of Rennes, where the club spotted him playing for local side AGL Drapeau Fougères. When he was young, the Camavingas' house burnt down and they lost everything, a tragedy that made Eduardo even more determined to succeed. Although he excelled at judo as a kid, football quickly became his thing and making it to the top was always his dream.

"He has always been dedicated about football. He has a football IQ way above average but he will not rest on his laurels," added Chauvin. "There are a lot of talented young players in the world but he has

something special because his talent comes with maturity as well despite his young age.'

The diamond from Rennes is, predictably, already attracting the interests of bigger clubs. Real Madrid, Barcelona, Arsenal, Tottenham, Manchester City, Bayern Munich and Borussia Dortmund, to name just a few, have been following Camavinga for a while but have stepped up their interest in recent weeks after seeing how much of an impact he's already having in Ligue 1.

"Talent like this, so precocious but already so mature, doesn't come along very often in football. [Camavingal has been so impressive. I don't think there is anyone as strong as him in Europe in his age group," a scout of a top European club told ESPN about the Rennes prodigy.

If you need further proof of how good Camavinga is, he's been at the heart of a huge battle from Europe's top agents to secure his representation. Mino Raiola (agent to Paul Pogba and Zlatan Ibrahimovic), Jorge Mendes (Cristiano Ronaldo, David de Gea), Giuliano Bertolucci (Marquinhos, David Luiz) and others have been knocking at his door, sources tell ESPN FC. He ultimately chose Moussa Sissoko, Dembele's agent, who lives in London and is quickly becoming more and more influential at top clubs.

Before thinking about his next move -- and there will be plenty of opportunities next summer -- the young midfielder is hoping that his French passport will finally arrive. His request should come through quickly now after waiting for years. Once he officially becomes a French citizen, Didier Deschamps will surely be quick in giving him a first call-up for Les Bleus.

"He is like a brother for him. The image for the two is not about the colour of the skin. "He took a picture of Benjamin


