# **USAID** signs \$10m portfolio guarantee for Amana Bank

THE US government through the Agency for International Development (USAID) yesterday signed a \$ 10 million (22.9bn/-) financing portfolio guarantee agreement with Amana Bank to strengthen its ability to provide financing to agro-sector businesses.

Speaking in Dar es Salaam at the signing ceremony, USAID Deputy Assistant Administrator for the Africa Bureau, Dr Diana Putman said the financing guarantee will benefit micro, small and medium enterprises as well as women and youth-owned businesses.

"The guarantee agreement is intended to strengthen Amana Bank's ability to provide financing to agribusiness in Tanzania. We anticipate this program to contribute to sustainable growth of agriculture-related

businesses," she said.

In addition to supporting increased access to credit, Putman said the agreement expands access to customers and regions throughput Tanzania, including Zanzibar.

The administrator noted that the agreement with Amana Bank is the first in partnership with an Islamic Bank in sub-Saharan Africa.

The US government supports business development and the role of the private sector in contributing to Tanzania's development and capacity to achieve self-reliance.

Amana Bank Managing Director Dr Muhsin Masoud said the signing is historical as it marks another milestone in Amana Bank efforts to push for access to finance.

He cited limited access to finance as impeding the growth of women-owned businesses in developing countries, noting that the scheme will help to curb many challenges in agribusiness that women and youths face.

# Transit motor vehicles at Dar port in sharp increase

THE number of imported on-transit motor vehicles that pass through Dar es Salaam port to neighboring land-locked countries rose to 159,639 from January this year, the Tanzania Ports Authority (TPA)

Landlocked countries that use the Dar es Salaam port to ferry vehicles are Zambia, Malawi, Burundi, Rwanda, Uganda, DRC and Zimbabwe.

TPA Director General Deusdedit Kakonko attributes the increased number of consignments with higher efficiency and interventions by the port authority to curb tampering of goods amongst port officials. Statistics indicate that the number of vehicles passing through Dar es Salaam

port in the 2017/2018 financial year stood at 132,035 after having dropped to 93,000 in 2016/2017. About 164,000 cars were ferried through Dar port in 2014/15 and 127,335 in 2015/2016.

Kakonko told journalists over the weekend that the drop was due to increased pilfering with motor vehicles, which is an aspect of corruption that pushed transit importers to shun Dar port.

"The drop was a shock. I had to go on a campaign to sensitize our neighbours to continue using Dar port after we successfully controlled such practices and improved efficiency. I met with stakeholders in Lilongwe (Malawi), Uganda, Zimbabwe and Lubumbashi in the Democratic Republic of Congo (DRC).

# IDA boosts TASAF III with \$450m soft loan

THE implementation of forthcoming second phase of the Tanzania Social Action Fund (TASAF-III) programme will focus more in providing poor households with prerequisite entrepreneurship skills and income-earning opportunities to enable them establish small-scale business and projects for poverty

RESIDENT John Magufuli yesterday expressed his shock over the high rates of pregnancies for school girls in Rukwa Region where more than 200 girls became pregnant in 2018 alone, directing security organs and social welfare groups to come up with a proper strategy to ad-

dress the situation. Speaking at a rally at Sumbawanga, the president said it was shameful to see Rukwa on top of the list of regions with the highest number of school girls who were impregnated, where it last year alone had 229 girls becoming pregnant.

"I call upon religious leaders and local authorities to take time out and sensitize surrounding communities on the matter, otherwise efforts to educate these girls will be in vain," he said.

In 2017, President Magufuli announced that secondary school students who get pregnant will not be allowed back to school after giving birth. That would not happen under his leadership, he had famously declared.

The move sparked reactions from various NGOs in empowerment for girls drive, saying it was tantamount to shattering their dreams.

Discussion on the ban exposed how the subject was divisive and the gap that women and rights organizations needed to cover to bridge the gender sensitivity gap.

Data shows that 69,067 primary and secondary school girls dropped from school for reasons like pregnancy, absenteeism, deaths and other challenges in 2017.

In February 2016, the Ministry of Education and Vocational Training issued guidelines on how to enable pregnant schoolgirls resume their studies.

The move was part of efforts to implement the Education and Training Policy (ETP) of 2014, which emphasised access and equity to quality education for all.

Chapter three of the guidelines, made a provision that affected girls would be accorded one re-entry opportunity per school cycle and will be required to resume schooling within the year.

He cited other challenges as property rights and control over assets, regulations and customary laws which often restrict women's access to and control over assets that can be accepted as collateral, such as land or livestock.

vulnerability remain developmental challenges that the government is strongly committed to address using various mechanisms including social protection.

"This phase builds on first phase achievements and will especially focus on productive and financial inclusion, through support services such as public works, savings groups, training and livelihood grants."

He further asserted that PSSN II will support the Social Action Fund to enable many extremely poor households "not simply to temporarily move out of poverty, but to progressively build their asset base, human capital and resilience necessary to keep themselves out of poverty for the longer term."

He further highlighted that the government over the years has taken a number of measures in poverty reduction, including established TASAF at the turn of the century to pursue focused work in poverty alleviation.

"The first phase was implemented in 40 most poor districts in Mainland and Zanzibar whereby a total of 1704 community projects worth 72bn/- were implemented, while reaching 7.3m direct beneficiaries. The second phase of TASAF was implemented from 2005 to 2013 whereby a total of 12,347 projects worth 430bn/- were implemented, reaching at least 18.7 million people in 126 poor districts," he said.

Bella Bird, the World Bank country director hailed the implementation programmes in ending poverty in Africa.

Tanzania's earlier social safety net programme helped beneficiaries to save more money and obtain more assets. As a result, many had more food and access incorporated a necessary component of to better education and health care, the director noted.

"Still, this new support will be critical to improve the lives of many more people in need and overall raise the country's human capital index, which is still very low at 0.40," she further stated.

"We will continue to work with the government and engage with ordinary people and other stakeholders on the complex set of development issues facing the country and its people," she emphasized.

# RC calls upon land officers and urban planners to address unplanned settlements

DODOMA regional commissioner Binilith Mahenge has called on land officers and urban planners in the country to help addressing squatter settlements, noting that there is increasing growth in urban areas.

He said urbanisation processes of rural areas and small town development had attracted considerable attention which is instrumental in rural poverty reduction.

In a speech read on his behalf by the Mpwapwa District Commissioner, Jabir Shekimweri, while officiating the opening of spatial planning training in Dodoma, he noted that proper planning of urban areas can spur economic growth.

The training organised by the Nairobi-based African Institute for Capacity Development (AICAD) brought together land and planning officers from Dodoma, Singida, Morogoro and Iringa regions.

"As we are all aware, Dodoma just like other urban areas in the country is growing very fast, thus the need to have proper methods and technology for urban planning" he said. He thanked AICAD, an institute working under support of the three East African countries of Tanzania, Kenya and Uganda for the decision to have the training in the country, noting that it will help empowering urban planners and land officers in the country to improve in their duties.

The institution has held similar trainings in Kenya and Uganda, aimed at helping solve problems caused by poor planning in the three countries.

" I am glad to hear that such trainings in the neigbouring countries have brought tremendous changes, I hope the same will happen in Tanzania, especially in Dodoma where the government has recently relocated to" he added.

According to the RC, research has shown that growth of small urban areas and towns open opportunities for development compared to big towns and cities like Dar es Salaam.

Speaking earlier, AICAD's Executive Director, Prof. Dominick Byarugaba said lack of proper land use plan is majorly the main cause of land conflicts in many parts of the country.

"The aim of spatial training is to empower land and planning officers with the right skills on analysis, preparation, budgeting, implementation, monitoring and evaluation of

development planning" he said. He said AICAD, in keeping with African Union Agenda 2063, AICAD is out to promote speedy integration and fulfill the expectations of researchers by linking knowledge to application within communities in order to reduce poverty on the continent.

# Ministry to bring on board retired veterinary officers

THE Ministry of Livestock and Fisheries has decided to bring on board its retired veterinary officers to influence their wisdoms and knowledge that will bring new insights of improving the sector apart from acting as mentors of graduates of the livestock profession.

The ministry's decision to collaborate with veterinaries at a time that the country keeps millions of cattle but missing its real output. The ministry said at a meeting with 40 retied veterinaries and 20 livestock experts from the private sector held yesterday in the city,

Permanent Secretary, Prof Elisante Ole Gabriel, said that the ministry is collaborating with the retired offices so as they can go around colleges and universities to share their experiences with students taking courses based on livestock.

"We need experienced mentors for our students in universities and colleges. It is obvious that today's graduates on livestock can't even afford to raise chicken. We have decided to collaborate with you so us you can help us in shaping graduates and bringing new insights on how we can make the sector more productive and competitive in the continent" Prof Gabriel told the veterinaries.

According to him, the Livestock Training Agency (LITA) will also use the retied veterinaries as special invited guest speakers at its colleges of Tengeru and Mpwapwa so as to share their experiences to students on how things are done practically.

"We are now creating a database of all veterinaries so as even private colleges in need of experts to share experience to their students can be easily accessed" said Pro Gabriel.

He said the number of cattle was 32.5million as of June this year, there are 20million goats, 5.5 million sheep, 2 million pigs, chicken are 79.1 million while eggs they lay amounted to 4billion. The figures are promising in achieving the industrial economy, but it is important that all resources are processed for value ad-

"There are only 1.28million milk cows out of the 32.2 million in the country which produces 2.7billion liters a year but we only 70 million liters while Kenya processes up to 803 million liters and Uganda 600 million liters," he said.

He said Tanzania needs at least cattle of 700kg and above to attract milk production. He said the government is investing heavily in educating the pastoralists not to practice ordinary ways of livestock keeping but embark on new models that are scientific. According to him, ordinary methods of livestock keeping just focus on the price of selling without considering the expenses incurred in raising the same. In 2018/19 fiscal year the livestock contributed 8 per cent of the national income and its growth rate stood at 5 per cent.

"The problem is, majority of Tanzanians do cherish foreign manufactured products than local ones. A population of an estimated 56million is quite enough for local manufacturers to have their product sold out compared to im-

# TRC to faciliate cotton bales transportation

DIRECTOR General of the Tanzania Railways Corporation (TRC) Masanja Kadogosa has said the corporation has facilitated transportation of cotton bales by rail so as to reduce expenses borne by ginneries.

Apart from reducing these costs, he said, rail transport is m ore trusted and also safe as even during the rainy seasons the goods will arrive safely at destination and promised that TRC will put up friendly infrastructure for the task.

Kadogosa said this yesterday when he toured cotton ginneries owned by Alliance Ginnery in Kasoli Ward and NGS Ginnery in Bariadi District in Simiyu Region, and added that apart from transporting cotton, the wananchi are supposed to use the opportunity to better their economic wellbeing in general.

In another development, Kadogosa said the wananchi should think of building meat processing factories so that instead of transporting livestock, they transport meat as Simiyu region is home for big livestock keepers in the country.

The Simiyu Regional Commissioner Anthony Mtaka said there are huge challenges faced by business people especially in transporting bales of cotton as they are forced to use trucks which carry small loads at huge cost.

On his part. the Chama Cha Mapinduzi (CCM) chairman for Simiyu pegion Enock Yakobo called on the busi-

ness people to see the importance of rail transport as the service has been brought nearer to them and will assist them in reducing transport cost and loss of their bales of cotton.

He also said the construction of storage facility for bales of cotton at Malampaka should be given priority.

The Registrar of Cooperative Societies in Simiyu Region Ibrahim Kadudu said it was estimated that the region would producve 180 million kilograms of cotton up to September 22 this year, and 148,836,601 kilograms was collected by the cooperatives, and 116,391,208 kilograms has already been transported. He said the cotton that has already been paid for out of that which was transported was 875,166,453 kilograms.

He added that 31,106,818 kilograms of cotton was moved without being paid for, while 32,445,393 kilograms is still in godowns.

Alliance Ginnery manager who is also secretary for cotton buyers association in the country Boaz Ogolla said production has increased which has spurred great demand of trucks for transporting bales of cotton.

He gave an example of Alliance Ginnery which produces 400 bales per day out of which only 200 bales are moved each day, hence with the advent of rail transport the challenge would be eased, as a railway wagon can carry up to 90 bales while a truck carries only 25 bales.

# PM disappointed over construction of Ndago health centre in Iramba

PRIME Minister Kassim Mjaliwa yesterday expressed disappointment ov er the construction progress of Ndago health centre in Iramba district, Singida region insisting the building is not well worth the money spent on it.

PM Majaliwa was talking to Ndago residents shortly after he inspected the construction of the health facility.

"There is no value for money; the buildings are old and half-finished. I have visited similar projects across the country, but nothing tangible had been done here, you have spent our monies inappropriately," said the Prime Minister vividly annoyed by the way officials have supervised the project.

When asked on the amount of

funds spent so far on the project, Iramba District Executive Director, Leno Mwageni said they have finished all the 400m/- allocated for construction of the health

Majaliwa said the government was aware of health challenges facing the residents, and that it working to improve provision of social services including medical treatment to the people of Iram-

ba.

"We are constructing health centers across the country; we want to bring services closer to the people. Tanzanians should not travel long distances in-search of medical services, we want the health centers to provide all the services equally those provided at regional and district hospitals", he told the residents.

He explained that more money

will be allocated for the project specifically for construction of a mortuary, theatre, mothers and children ward and a doctor's house. The Premier insisted that the government will take stringent measures against officials failing to implement development projects in their specific areas.

Earlier, Iramba Member of Parliament, Mwigulu Nchemba informed the Prime Minister that he contributed 400 cement bags to the project and that the residents assisted in collecting stones that were used during the construction. Briefing journalists on Monday last week, Singida Regional Commissioner Rehema Nchimbi said that the Premier will be in the region for a week from October 4th 2019. She said the Premier visit Manyoni, Itigi, Ikungi districts and Singida mu-

nicipal before going to Mkalama and Iramba districts.

He is also expected to visit and inspect regional and national projects including the construction of a 400kV transmission line from Singida to Isinya in Kenya through Babati, Arusha and Namanga which upon completion will enable the country to sell power to the neighboring country of Kenya.



### PRESS RELEASE

On 14th June, 2018, the Minister for Finance and Planning announced a tax amnesty order under The Tax Administration (Remission of Interest and Penalty) Order, 2018 for taxpayers with outstanding tax liabilities and those who voluntarily disclosed or affirmed their tax liabilities and were ready to settle their outstanding principal taxes due within the period and conditions prescribed by the Order.

The tax amnesty order was designed to operate within a limited period of time commencing from 1st July, 2018 and ending on 30th June, 2019 and would apply to outstanding tax liabilities.

However, the Government through The Tax Administration (Remission of Interest and Penalties) (Extension of Period of Payment) Order, 2019 extended the period for payment of principal taxes to 31st December, 2019 for taxpayers who had

- a) applied to the Commissioner General for remission of interest and penalty;
- b) been granted remission;
- c) executed a settlement agreement with the Commissioner General for remission of interest and penalty under the Tax Administration (Remission `of Interest and Penalty) Order, 2018;
- d) agreed to pay the principal tax assessed in lump sum or installment; and
- e) up to 30<sup>th</sup> June, 2019 failed to liquidate the agreed amount of principal tax assessed.

Eligible persons granted with the remission of interest and penalty are required to liquidate their principal tax as specified in the settlement agreement on or before 31st December, 2019 and no further extension will be granted.

It should be noted that, where an eligible person who has been granted with a remission under the Tax Administration (Remission of Interest and Penalty) Order, 2018 fails to implement any of the terms of the settlement agreement, the Commissioner General shall rescind the settlement agreement and proceed to demand the eligible tax as if no remission was granted.

From  $2^{\text{nd}}$  January 2020, recovery measures shall be applied to collect any tax outstanding without further notice.



He said putting on short dresses, drunkenness, nonattendance, and general unac-

countability are intolerable in the Fifth-Phase government led by President John Magufuli.

The minister reminded them that the teaching profession is good but needs composure to deal with students at schools, considering the fact that they have learned a lot at the college they were graduating from,



the availability of food and individuals' ability to access it. Affordability is only factor. There is evidence of food security being a concern many thousands of years ago, with central authorities in ancient China and ancient Egypt being known to release food from storage in times of famine. At the 1974 World Food Conference the term "food security" was defined with an emphasis on supply. Food security, they said, is the "availability at all times of adequate, nourishing, diverse, balanced and moderate world food supplies of basic foodstuffs to sustain a steady expansion of food consumption and to offset fluctuations in production and prices". Later definitions added demand and access issues to the definition. The final report of the 1996 World Food Summit states that food security "exists when all people, at all times, have physical and economic access to sufficient, safe and nutritious food to meet their dietary needs and food preferences for an active and healthy life".

Household food security exists when all members, at all times, have access to enough food for an active, healthy life. Individuals who are food secure do not live in hunger or fear of starvation.

Food insecurity, on the other hand, is defined by the United States Department of Agriculture (USDA) as a situation of "limited or uncertain availability of nutritionally adequate and safe foods or limited or uncertain ability to acquire acceptable foods in socially acceptable

Food security incorporates a measure of resilience to future disruption or unavailability of critical food supply due to various risk factors including droughts, shipping disruptions, fuel shortages, economic instability, and wars. In the vears 2011-2013, an estimated 842 mil-

OOD security is a measure of lion people were suffering from chronic hunger. The Food and Agriculture Organisation of the United Nations, or FAO, identified the four pillars of food security as availability, access, utilization, and stability. The United Nations (UN) recognized the Right to Food in the Declaration of Human Rights in 1948, ] and has since said that it is vital for the enjoyment of all other rights.

The 1996 World Summit on Food Security declared that "food should not be used as an instrument for political and economic pressure.

A food security crisis looms in Africa, experts and leaders in the agriculture sector have warned, calling for urgent action for the continent to meet its goal to end hunger by 2025.

They made the call recently in Kigali during the Africa Food Security Leadership Dialogue-which seeks to stimulate more investment in agriculture to halt the worsening food security crisis by building climate resilient agricultural systems.

Three consecutive global food security and nutrition reports that consistently show a deteriorating situation of the food and nutrition security in the world and particularly in Africa.

Globally, nearly 821 million people live with hunger, of whom 31 per cent are in sub-Saharan Africa, on the basis of the 2019 State of Food Security and Nutrition published by the United Nations Food and Agriculture Organisation (FAO).

The report shows that food crises are caused primarily by conflict and climate change shocks.

Hunger is on the rise in almost all African sub regions, making Africa the region with the highest prevalence of undernourishment at almost 20 percent of its estimated 1.2 billion population, the report underlines.

### Let's strive to reduce impact of natural catastrophies for sake of our own future

disaster is a serious disruption occurring over a relatively short period of time that causes widespread human, material, economic or environmental loss which exceeds the ability of the affected community or society to cope on a timely basis using its own resources. Developing countries suffer the greatest costs when a disaster hits - more than 95 per cent of all deaths caused by hazards occur in developing countries, and losses due to natural hazards are 20 times greater (as a percentage of GDP) in developing countries than in industrialised countries.

Disasters are routinely divided into natural or human-made, although complex disasters, where there is no single root cause, are more common in developing countries. A specific disaster may spawn a secondary disaster that increases the impact. A classic example is an earthquake that causes a tsunami, resulting in coastal flooding. Some manufactured disasters have been ascribed to nature.

A natural disaster is a natural process or phenomenon that may cause loss of life, injury or other health impacts, property damage, loss of livelihoods and services, social and economic disruption, or environmental

Various phenomena like earthquakes, landslides, volcanic eruptions, floods, hurricanes, tornadoes, blizzards, tsunamis, and cyclones are all natural disasters that kill thousands of people and destroy billions of dollars of habitat and property each year. Airplane crashes and terrorist attacks are examples of man-made disasters: they cause pollution, kill people, and damage property.

Human-instigated disasters are the consequence of technological or human hazards. Examples include stampedes, fires, transport accidents,

industrial accidents, oil spills, nuclear explosions/nuclear radiation. War and deliberate attacks may also be put in this category. One opinion argues that disasters can be seen as human-made, due to human failure to introduce appropriate emergency management measures.

Many people around the world have lost their lives, homes or access to essential facilities, such as hospitals, due to natural disasters, including earthquakes, droughts, tsunamis, heavy flooding, hurricanes or cyclones. Some of these disasters have caused economic damage to some countries. The UN acknowledges that education, training, and information exchanges are effective ways to help people become better equipped in withstanding natural disasters.

On December 22, 1989, the UN General Assembly designated the second Wednesday of October as the International Day for Natural Disaster Reduction. This event was to be observed annually during the International Decade for Natural Disaster Reduction, 1990-1999. On December 20, 2001, the assembly decided to maintain the observance to promote a global culture of natural disaster reduction, including disaster prevention, mitigation and preparedness.

Activities for the International Day for Natural Disaster Reduction usually include media announcements about launches for campaigns that center on the day's theme. Governments and communities also take part in the International Day for Natural Disaster Reduction through various events such as drawing, drama, essay or photography competitions that focus on making people aware of natural disaster reduction and increasing their preparedness for such situations. Other activities include: community tree planting; conferences, fairs and seminars; and street parades.

# Commonwealth model offers hope for easing multilateral trade tensions

GLOBAL uncertainties and tensions are escalating and affecting trade in every region. We see rising protectionism, while multilateral cooperation including through the World Trade Organisation - is increasingly under threat.

Meanwhile, the resilience of many smaller or less developed countries is being undermined by the impact of climate change and extreme weather unprecedented in living memory, together with other natural disasters.

These factors combine to make the general outlook for economic growth and prosperity sombre. Yet through the encompassing gloom, Commonwealth connection and cooperation shine as beacons of hope guiding towards safer and saner waters.

This year, world GDP is projected to grow 2.6 per cent, down from 2.9 per cent last year, while world merchandise trade volumes are now expected to rise by only 1.2 per cent in 2019 - the weakest growth since the global financial crisis.

Our citizens experience the effects of these trends in their day-to-day lives as the prices of food, fuel and basic services rise, jobs become harder to find, and there is reduced potential for businesses to grow.

Against this backdrop, this week in London the UK is chairing a meeting of trade ministers from the 53 countries of the Commonwealth. Building on the distinctive nature of Commonwealth connection and cooperation, ministers will consider approaches for tackling pressures on international trade, and for making even more of the Commonwealth Advantage enjoyed among our member countries.

Most importantly, ministers will review progress towards the target agreed by Heads of Government at CHOGM 2018 for annual trade within the Commonwealth to be worth at least \$2 trillion by 2030 - a goal closely linked to achieving the UN Sustainable Development Goals.

The challenges may seem daunting, but our governments know that through coordination and with the right policies in place the prizes can be brought within reach. Collective strategic action can unlock promising opportunities for all members of our diverse

and geographically widespread family of 53 Commonwealth countries.

Our studies have shown that on average the nations of the Commonwealth countries tend to trade 20 per cent more with each other than with non-Commonwealth countries.

This very real and valuable tendency is an important factor in Commonwealth Advantage. It is the product of historical ties, shared language, and similar legislative, governance and administrative systems based on the common law. As a result, trade costs are on average 19 per cent lower between Commonwealth country pairs than comparable non-Commonwealth counterparts, and our member states also invest on average 10 per cent more in each other than they do in nonmembers.

These benefits are now further bolstered by our Commonwealth Connectivity Agenda, which provides powerful mechanisms for structured dialogue, sharing of best pracration on trade and investment among our member countries.

Intra-Commonwealth trade in goods has increased by around \$100 billion over the past three years, reaching almost \$450 billion in 2018. With rapid population and per capita income growth in developing countries, especially in Asia, trade in goods and services is expected to reach the

\$700 billion mark by 2020. With more than 60 per cent of the combined Commonwealth population of 2.4 billion under the age of 30, these drivers of growth and prosperity are unlikely to slow for some very considerable time.

The digital economy holds further untapped opportunities, with the number of internet users globally trebling over the past decade. Yet in low-income Commonwealth countries only 18 per cent of the population currently have internet access, compared with 85 per cent in high-income

suasive: full access to broadband internet could add up to \$1 trillion to combined Commonwealth GDP.

Certainly, with 49 of our members belonging to the WTO, the Commonwealth can play an increasingly strategic role as a champion of free trade, advocating for a transparent, inclusive, fair and open rules-based multilateral trading

Commonwealth discussions provide space for broader wide-ranging dialogue in the spirit of goodwill and an atmosphere of trust rather than treaty.

This means that deadlocks are less likely to hinder pragmatic progress towards practical solutions. Our member countries gain advantage through cooperation and coordinated action, and remain free to move forward with their preferred domestic reforms unfettered by obligations, deadlines or legally binding commitments.

It is within this context that we can look forward to Commonwealth trade ministers, when they meet this week, offering powerful messages which, while rooted in reality and notwithstanding the diverse economic interests represented, proffer the prospect of progress towards hope and harmony within a broad unity of purpose.

For, while the global trading system may be far from perfect, it is the most potent pathway towards eradicating poverty. That is a prize not to be lost. By enhancing opportunities for enterprise and investment among all our member nations, and by working together for the common good, we shall truly live up to the ambition and aspiration of being a

### Agriculture ministry gives sorghum farming a face-lift through morden technologies

ARI Hombolo in Dodoma which is under the Ministry of Agriculture is working to ensure Agronomy plays a big role in ensuring effective and efficient sorghum production in the country. The Centre, through the department of research and innovation is also working to ensure availability of technologies useful for farmers to increase sorghum production. Our reporter GERALD KITABU caught up with Agricultural research officer from the research centre MASHENENE MALIMA who is currently pursuing his PhD on Molecular Plant Virology at Ondokuz Mayis University in Turkey and here he sheds light on the subject matter:

### **QUESTION: Briefly explain what** do you mean by agronomy?

**ANSWER:** Agronomy is the science and technology that focuses on yielding optimum food production through effective field management. The scope of Agronomy as being a branch of agriculture is promising for those who love plants and love to experiment of producing and using plants for food, fuel, fiber, and land reclamation. Agronomy has come to encompass work in the areas of plant genetics, plant breeding, plant physiology, meteorology, and soil science. Thus, Agronomy is a science that looks at agriculture from an integrated, holistic perspective, informing practical decisions pertaining to food and fiber production.

### Q: What is the contribution of agronomy in ensuring sorghum production?

A: Agronomists work to develop methods that will improve the use of soil and increase production of food and fiber crops. They conduct research in farming techniques such as (intercropping, mono cropping, and

crop rotation), irrigation and drainage, plant breeding, soil classification, soil fertility, weed control, and other areas. The main importance of agronomy in sorghum production is to provide farmers with agricultural information about how to grow and care for sorghum and soils in certain environments. Factors such as climate, roots, moisture, weeds, pests, fungi, and erosion can pose significant challenges when farmers attempt to produce a plentiful harvest.

### Q: What are the challenges associated with sorghum production

A: In Tanzania, sorghum is grown in the central zone, covering Dodoma and Singida regions, Lake Zone covering Geita, Mwanza, Mara, Simiyu and Shinyanga regions, and southern zone

covering Lindi and Mtwara regions. Although the value of the crop has increased substantially, its supply to meet industrial market demand is still low. This is partly because sorghum is still produced in a traditional way that depends on the natural rainfall, which is erratic and unpredictable. The yields obtained are usually below farm's potential, with stagnant or decreasing trends with time. Farmers keep on expanding their farms believing that the yield per unit area would increase.

Thus, the most attributes to sorghum farming are characterized as abiotic and biotic constraints that include low soil fertility (nutrient deficiency), drought, lack of irrigation facilities, inadequate infrastructure, information barriers, less productivity enhancing technologies use improved seeds), unreliable market, weeds, birds, disease like smut, insect pests like stalk borer infestation and pathogens. Although these constraints cause a significant loss of grain, the level of losses varies from region to region. The genus Striga is a major production constraint in most sorghum producing areas. The weed limits the productivity of the crop by allelopathy, competition for nutrients and limiting

ghum plants in the marginal lands.

### O: What are the technologies useful for farmers to increase sorghum production?.

A: Although the majority of the farmers still grow local varieties, there is a substantial use of inputs such as seeds of new cultivars. The local varieties include a group of varieties that have been locally adapted or selected. The local varieties are obtained from other farmers and passed from generation to generation. Almost all local varieties are tall, long season maturity, bad threshing ability and tolerance to weevil. Due to highest effort by TARI staff working with sorghum section, currently farmers' are adapting new technologies developed by researchers such as soil fertility practices which include fertilizer incorporation, integrated nutrient management, fallowing, use of livestock manure (goats, cattle, chicken), crop rotation (beans, cowpeas and sorghum), incorporation of stover and grass or avoid burning of grass and intercropping.

Also in the list are better and efficient use of water resources available (that is in situ soil water harvesting techniques) that include tiredridges, infiltration pit and ripping. Integrating technologies that include in situ water harvesting techniques in combination with farmyard manure using Striga-resistant varieties (HAKIKA and WAHI). In areas where there is no Striga weed, integrating other drought-tolerant genotypes notably NACO1, MACIA, PATO and TEGEMEO with promising local plant nutrient sources. There is also bird scaring and application of pesticides, land preparation, integrated weed management, quality seeds and planting period, spacing and thinning are other agronomic packages that farmers follows to increase sorghum production in their respective areas.

### Q: As TARI Hombolo, what have you achieved in Agronomy?

In the past, the average yield of sorghum ranged from 0.9 to 1.17 tones per hectare in Tanzania, which was less than the world average yield (1.48 tones per hectare). However, high consistent effects of researchers, the productivity have risen to 2 tones per hectare. This is due to the fact that we have developed different technologies and disseminated to farmers for adaption in sorghum production. curity, income and livelihood in the country.

the expression of the full genetic potential of sor- Among of them are; curtailing the effect of Striga weed, improving moisture availability and increasing soil fertility are essential strategies to increase the productivity of agriculture in the sorghum producing semi-arid areas of Tanzania. The adoption of Striga resistant sorghum varieties and inorganic fertilizer on small subsistence farms in Striga prone areas of Tanzania was reported to be sustainable solution to reduce hunger and lasting poverty. It is therefore assumed that combining these technologies, we do share with farmers through field experimentation, training, field days, seed fair, demonstration plots and creation of swahili leaflets have enhanced sorghum grain yield and consequently contribute to sustained household food security, livelihood and poverty alleviation.

> TARI- Hombolo we have different strategies that have increased sorghum production. The main strategies are to produce new and welladapted sorghum genotypes with high yield potential and the genetic capacity to withstand major constraints (biotic and abiotic stresses). This mostly achieved by evaluating sorghum lines developed in different locations, keeping the breeding pipeline full and finding locations for testing breeding materials. Strengthen seed production and delivery systems for improved varieties (achieved by training the Trainers and Quality declared seed "QDS" producers). ### Q: So, What is your call?

# DO DIGITAL DEVICES HARM OUR EYES?

information in visual form. When the input information that is supplied has an electrical signal, the display is called an electronic visual display. These devices include laptop and desktop computers, tablets, smartphones, e-reader etc.

Since the advent of personal computers, these devices have become an integral part of modern-day life and they have become more portable, versatile and indispensable. Furthermore, these ubiquitous devices have taken over the lives of younger and younger people to the point where children and toddlers are now using them to greater degrees.

The increased use of digital devices in the society at large has brought about the development of a number of health concerns. According to experts, computers do not emit any harmful rays to cause damage or 'burn' the eyes. However, many individuals who use these devices report a high level of complaints and symptoms. These include ocular discomfort, muscular strain and stress. The level of discomfort appears to increase with the amount of computer use.

This is known as digital eye strain or computer vision syndrome which is defined as the physical discomfort felt after two or more hours within close or mid-range distance of a digital device. Unlike typewritten or printed pages, the images on

precise or sharply defined, contrast is reduced and the presence of glare and flicker the screen may make viewing more difficult.

Viewing distances and angles used for computer work are also often different from those commonly used for other reading or writing tasks. As a result, the eye focusing and eye movement requirements for computer work can place additional demands on the visual system. Children who stare at tablets or use computers during the day at school can have issues too, especially if the lighting and their posture are less than ideal.

People who tend to focus on a computer or other digital devices for protracted, uninterrupted periods of time may experience;



# Can the Central African Republic's peace deal be saved?

IGHT months after the 6 February peace deal was concluded between the Central African Republic (CAR) government and 14 armed groups, several important challenges continue to affect the country's stability.

The most recent major episode of violence was last month's conflict between the Mouvement des libérateurs centrafricains pour la justice (MLCJ) and the Front Populaire pour la Renaissance de la Centrafrique in Birao in the country's north. Both groups had signed the peace agreement and MLCJ's head, Gilbert Toumou Deya, is now a cabinet member in charge of relations with armed groups, as per the agreement.

Presidential and legislative elections scheduled for December 2020 could lead to further instability, as opposition leaders and parties are already gearing up to face off with incumbent President Faustin-Archange Touadéra.

A breakdown of the peace deal will reverse the progress made so far in stabilising the country. The African Union (AU), as guarantor of the 6 February agreement, should implement the clauses that sanction spoilers and ensure that those armed groups still on board remain compliant.

Since February dozens of violations of the peace agreement have occurred each week. Following negotiations in Addis Ababa in March, Sidiki Abass (also known as Bi Sidi Souleymane), leader of Retour Réconciliation Réhabilitation (3R), was appointed military adviser to Prime Minister Firmin Ngrébada.

Abass was put in charge of the mixed special security unit - comprising government forces and armed group members - in the Ouham-Pendé region, which his group already controlled. This was part of the AU's attempt to iron out differences over the post-Khar-

toum national unity government and salvage the February peace agreement. But the 3R group subsequently massacred 46 civilians in Paoua, Ouham-Pendé, in May.

Two other rebel leaders, Ali Darassa and Mahamat al-Khatim, entered the government at the same time as Abass. Both were made military advisers in charge of mixed special security units, also in areas they controlled before their appointments. The decision to appoint rebel leaders to lead regions already under their control was bound to create challenges for the peace agree-

Subsequently both Abass and al-Khatim resigned from the government over unclear roles and differences with the prime minister. They have officially reneged on the February peace deal and gone back to the bush.

On 30 July another rebel leader, Abdoulaye Miskine, called on Touadéra to resign, short of which he would be 'removed by all means necessary.' Miskine was also a signatory to the Khartoum peace agreement and was appointed to the government, but declined to take up the position, although his group is represented in cabinet. Miskine has now formed an alliance with the Parti du Rassemblement de la Nation Centrafricaine, a rebel group created in

The commitment of armed groups to implement the peace agreement they signed is clearly in question. The opportunity they have been given to remain in charge of areas they already controlled has revealed its drawbacks. It has helped preserve the prevailing power balance and has failed to incentivise armed groups to fully commit to tend with a proxy battle between Rusthe agreement, while legitimising their control over those areas.

Compounding these problems, the United Nations Panel of Experts on the CAR reports that weapons are still flowing into the country. Several armed internal political dissension which is groups have shown their reluctance to likely to intensify, especially in the run-

comply with the disarmament, demobilisation and reintegration process, scheduled to end in January 2020.

The tri-border area - between Chad, Sudan and the CAR - has always been a hotbed of various kinds of trafficking and has fuelled instability in all three countries. Instability in both Sudan and Chad contribute to the CAR's fragility.

Meanwhile the CAR also has to consia and France. The CAR is historically a preserve of France, and CAR authorities have built strong ties with Russia since 2017. The Russian presence and France's pushback are exacerbating up to the 2020 presidential polls.

Another political complication ahead of the 2020 elections is that at the end of May 2019, civil society and opposition parties set up a platform called the United Front for the Defence of the Nation, or E Zingo Biani. It blames the government for appointing armed group leaders to government in what it calls a bad compromise.

E Zingo Biani places itself in radical opposition to Touadéra's rule, which is bound to contribute to a tense political climate. In the past, violence has erupted before elections to prevent them from taking place or to highlight the government's incapacity to stem insecurity.

Too many diverging interests, both among Central African leaders themselves and among external powers, make the Central African quagmire even more intractable.

The guarantors and partners should review the implementation of the agreement and the challenges it has faced so far. One possibility is reversing the balance of power, which overwhelmingly favours armed groups. They should also look at whether mixed special security units are still appropriate, and what strong coercive and mitigating measures can be taken against spoilers. All this must be done within a clear time frame

The AU as the primary guarantor

must fully play its role by ensuring the timely allocation of resources to implement and monitor the agreement, if it can be saved

The diverging interests of external powers and those within the CAR, as well as the instability in neighbouring Sudan and Chad, will continue to pose obstacles to peace and stability in the country. Unless these are addressed in parallel, the prevailing situation will not improve and the future of the CAR will remain bleak, at best.

# Multiple measures taken by Hong Kong to boost economy

NUMBER of measures have been taken by the government of China's Hong Kong Special Administrative Region (HKSAR) to support enterprises, ensure employment and alleviate the pressure of local people, according to Chief Executive of the HKSAR Carrie Lam Cheng Yuet-ngor.

The HKSAR government pays great attention to economic pressure felt by Hong Kong citizens and small and medium-sized enterprises (SMEs) amid the sluggish economy. These measures were issued to tackle the challenges currently faced by the special administrative region, Lam said in a recent public

Lam also received supports from many Hong Kong officials, who posted supporting messages on the internet, saying that the HKSAR is inputting huge amount of resources to improve people's livelihood and promote economic

Enterprises are major players in market economy, and their fate is under direct influence of the economic condition. The HKSAR government, considering the impacts faced by the SMEs in the region, has issued multiple measures to relieve their stress.

Not long ago, the HKSAR government offered a 12-month exemption for 27 categories of administrative charges to help reduce costs for enterprises, benefiting many sectors such as the maritime, logistics, retailing, catering, tourism, construction, fishery, and agriculture industries.

Besides, tenants of short-term land leasing, street-side market stalls, restaurants, retail stores, cargo handling berths, and booths in wholesale produce and fish markets can also enjoy a 50-percent discount in the rent for half a year.

To help SMEs find accessible and affordable financing, the HKSAR government extended the application period of the Special Concessionary Measures under the SME Financing Guarantee Scheme and the validity period of three "Enhancement Measures" the government rolling out last year to June 30, 2022.

There were about 40 government

funds available with funding worth HK\$35 billion (about \$4.46 billion) up for grabs, said Edward Yau

The government will streamline the procedures and eligibility requirements of these funds so as to help more SMEs ride out the storm, said Yau.

In order to expand employment, Hong Kong government has intensified its efforts to launch small construction projects, including the Pier Improvement Programme, Lift Modernisation Subsidy Scheme, and Fire Safety Improvement Works Subsidy Scheme. These projects all help create new jobs for Hong Kong citizens.

Moreover, the HKSAR government are planning to initiate special training programs to help those

who lost their jobs to the current recession. To enhance the competitiveness of Hong Kong's

human resources, the Development Bureau established the Centre of Excellence for Major Project Tang-wah, Hong Kong Secretary for Commerce Leaders this July. The first two batches of students from the center have started taking courses at Oxford University this August and September respec-

> Infrastructure construction and cultivation of talents for project management are important investment for Hong Kong's future, said Hong Kong's financial secretary Paul Chan Mo-po, noting that the HKSAR government will make great efforts to boost progress in these areas and promote continuous development of Hong Kong.

> A series of relief measures worth HK\$ 13 billion were recently rolled out by the HKSAR government, issuing subsidies to social security recipients and students from kindergarten to secondary

Besides, the government will grant each eligible residential electricity account a electricity charges relief of HK\$2,000, and provide one-off subsistence allowance for eligible low-income residents.

In addition, the government of HKSAR has adopted a proposal put forward by the Hong Kong Commission on Poverty, and is going to raise the subsidies for low-income families living subdivided

Two new types of family structures, families with three and families with four or more, will be included in the subsidy scheme, and they will receive up to HK\$11,500 and HK\$13,000, respectively. It's estimated that about 24,000 citzens will benefit from the scheme.


Meanwhile, under the efforts of the HKSAR government, a series of new measures and moves targeting the housing problem in the city are being

introduced and put into practice, such as gazetting the proposal of vacancy tax on properties, resuming land for urban renewal projects, and paying one month's rent for lower income public rental housing tenants.

The HKSAR government is preparing a platform for dialogue, which is expected to bring Chief Executive Lam and heads of government departments and bureaus to communities in an effort to hold discussions with citizens on solutions to long backlogged issues concerning such aspects as economy, society, and people's livelihood, said Chan.

It is hoped that various sides can work together in a peaceful, rational and mutually respectful atmosphere, so that the HKSAR government can draw on the wisdom of everyone and formulate

more powerful measures, Chan added. People's Daily

# Three ways to end HIV stigma and discrimination

**ABUJA** 

S a Public Health Doctor, I often meet people who experience stigma simply because they live with HIV. One person who still haunts me is a woman who is HIV positive and when she was in labor, a midwife would not help her. Instead she shouted at her to just push out the baby and then she stood far away from the bedside, disgusted by the woman's HIV status.

No one should go through such stigma at a vulnerable situation when they are about to birth life. Another lady I met was denied university admission because she is HIV positive. She was screened for HIV without her consent, her HIV-positive status was disclosed publicly, and she was asked to leave the private university.

This is not okay. All forms of HIVrelated stigma must stop. When people experience stigma and discrimination they may be afraid or ashamed to access HIV services. This fear of stigma has farreaching implications - it could cause people to delay being tested and knowing their HIV status and getting help, before it's too late.

Globally, there are approximately 37.9 million people living with HIV, with 770,000 deaths, based on 2018 data. In 2018, there were 1.7 new HIV infections. Seventy-five million people have been infected by HIV since the epidemic began and 32 million have died as a result. HIV-related stigma can have serious consequences.

### These are ways to deal with it.

First, government across the globe should increase investments in health education to improve people's knowledge of HIV and its modes of transmission. It should not be taken for granted that people are aware.

For instance, according to a survey of Americans by the Kaiser Family Foundation, Americans wrongly believe that HIV can be transmitted through sharing glass (27%); touching toilet seat (17%); and swimming in a pool with someone who is HIV positive (11%). Instead, one can get



HIV when there is contact with body fluids such as blood, semen, vaginal fluids and breast milk.

Targeted information should be deployed on platforms where people congregate and interact. Social media platforms such as Facebook, Instagram, Twitter and WhatsApp serve this purpose and should be used. Globally, there about 3.5 billion social media users - an estimated than 2.7 billion of these are Facebook users.

In 2016 at peak of the Zika virus epidemic in Brazil, Facebook pulled anonymized posts about conversations on Zika virus. This was shared with UNICEF to design a campaign that provided the right information for individuals to protect themselves against Zika virus.

Facebook can replicate the same to tackle misinformation about HIV and reduce stigma.

Second, enforce HIV antidiscrimination laws to deter offenders from discriminating against people living with HIV. For instance, In 2015, the Nigerian President Jonathan signed the HIV/AIDS Anti-Discrimination law.

One of the objectives of the law is to help more Nigerians to seek testing, treatment and care services without fear of facing stigma and discrimination. The law does not permit HIV screening as a prerequisite for employment and school admissions. There are fines of \$1400 for individuals and \$5,700 for institutions who violate the law. The fines could come with prison term of up to one year in addition to these fines. Although not as robust as Nigeria's HIV antidiscrimination law, Ghana's patient's charter protects individuals from discrimination

based on type of illness. Third, end the discrimination against key populations like men who have sex with men, sex workers and transgender people as this discourages them from accessing care, pushes them underground and increases their risk of transmitting HIV. Globally, these populations account for 54% of new HIV infections - 88% in Western and central Europe and North America; 95% in Middle East and North Africa; and 64% in Western and central Africa. Compared to non-key populations, the risk of acquiring HIV is 22 times

higher among men who have sex with men and injection drugs users; 21 times higher among sex workers and 12 times higher for transgender people.

Specific changes include ending discriminatory laws. Countries including Algeria, Morocco, Nigeria, Pakistan, Kenya, Zambia and others criminalize LGBT folks and that needs to change. Further, transgender people are harmed and killed without consequences for the perpetrators. For example, recently, a black transgender woman was burned to death in Florida. Therefore, donors must keep working with governments to repeal these laws and punish those who perpetrate violence against key popula-

The Former Wales rugby captain, Gareth Thomas' revelation this month that he is HIV positive because someone threatened to blackmail him, shows that no one is immune to stigma. As long as new HIV infections occur, governments, donors, private sector and communities must continue work to end HIV-related stigma and discrimination.

food While housing is a major issue, another is urban transportation. As most of the human population will be living in cities, urban mobility plays a key role. To reduce greenhouse gas emissions the most effective way is to network every moving object and use it as efficiently as possible.

# Isles TAMWA working to erase negative attitude to women leadership in politics

ANZIBAR society still has negative attitude towards women participation in politics and political leadership in shehia, ward up to constituency level.

A lot of challenges have been raised in community meetings led by TAMWA Zanzibar in collaboration with Male Change Agents in 31 shehias, with 19 located in Unguja and 12 in Pemba.

In sensitization meetings conducted by Male Change Agents in 11 districts of Unguja and Pemba, women have been emerging in large numbers, describing the stumbling blocks in reaching leadership levels in the society.

Among other things, superstition plays a big role in discouraging women from appearing for leadership positions.

Mwandiwe Makame, a resident of Unguja North A district, states that she tried to run in the 2015 general election in her constituency and was threatened by a fellow candidate who asked her to withdraw from candidacy or else it would cost her a lot. "As if the threats were not enough, he sent emissaries from the community to advise me to surrender...

"I continued with my plans but I was dropped in the early stages. However I did not survive physically as my health to this day is fragile; my legs are affected, I can't walk, the problem is unknown, medical tests failed to diagnose the disease," says Mwandiwe.

These are just some of the problems women face when trying to run for leadership positions, since the community feels that leadership belongs to men as a right.

Another woman who once emerged to contest for a leadership position at the district level says that another stumbling block is corruption. "Many of our fellow candidates (men) are economically viable so they allocate money to voters starting from party polls. Among us (women) with our limited resource it is more difficult to pass," says Bahati Suleiman, a resident of Unguja Central



However, there is hope gained from the one-year initiative to encourage communities to change attitudes and view women as legitimate candidates and give them a chance to

Communities need to change attitudes and view the woman as a legitimate candidate, activists emphasize. Huzaima Ali Hamdani from CHADEMA says that they have realized that "there is a need to support our fellow women when they stand up because it is clear that the development agenda has no party and women have great power and will to push

that agenda forward.'

Maryam Saleh from Chama cha Umma (CHAUMA) Chake Chake in Pemba talked about the high cost of taking on a contesting form which holds them back since their investments are so small that it becomes a barrier to having that money. In previous elections for some parties the candidate forms cost Sh200,000 apiece.

Political parties also play a key role in stopping women from holding leadership positions especially when they feel that they will lose the seat to male candidates contesting via other parties, although there are examples of women who contested and won.

TAMWA advises communities and political parties to change negative attitudes towards women in the contest for leadership positions as reality shows that when women get leadership positions they work better than

men and maintain peace and tranquility. TAMWA Zanzibar in partnership with UN Women from November 2018 to November 2019 is implementing the Women's Participation in Leadership and Politics project, encouraging the community to view the woman as a legitimate candidate and capable of being a leader at all levels.

# **Deficit falls** as Kenyans spend less on imports

Kenyans cut their appetite for foreign goods in the first six months of the year, reducing the trade deficit by Sh567.89 billion.

Expenditure on imports dropped by Sh27.85 billion or 3.1 percent (year-on-year) to Sh871 billion in the first half of the year, according to data from the Kenya National Bureau of Statistics (KNBS). For instance, spending on imported clothes, furniture and beddings dropped by Sh976 million in the six months to June compared to a similar period a year earlier.

China and India remain Kenya's largest source of imports, accounting for Sh141.82 billion, or 31.52 percent of total import bill in the six months through June, and rising to 39.33 percent of non-oil orders.

According to the KNBS data, earnings from exports also contracted by Sh16.7 billion to stand at Sh303.31 billion in the same period. This narrowed the trade deficit marginally by 1.93 percent in the first half of 2019 compared with the same period a year earlier.

The deficit - the gap between imports and exports - dipped to Sh567.89 billion in the January-June period from Sh579.05 billion in the first half of 2018.

**Industrial machinery** 

Shipments of industrial machinery and metals into Kenya dropped by Sh19 billion in the six months to June, reflecting a cooling of economic activity. Machinery imports dropped by Sh13.9 billion, iron and steel (Sh5.1 billion) while agricultural machinery like tractors were down Sh912 million.

The slowdown in industrial spending works against Kenya's quest to rev up its manufacturing for growth and jobs creation. The sector has stagnated at 10 percent of the gross domestic product for the past 10 years, despite previous government efforts to put the economy on the path to industrialisation

Kenya's economy grew by 5.6 percent per cent in the second quarter of the year under review, down from expanding 6.4 percent in the same period a year earlier. A flat growth in exports suggests a difficult operating environment for domestic enterprises, hurting income and job opportunities.

Kenya's main exports are agro-based such as tea, horticulture and coffee which are usually prone to shocks largely as vagaries of weather and a glut in international markets, which reduces prices.

Trade deficit

A persistently higher trade deficit, economists say, slows down the creation of new job opportunities for the growing number of graduates as most revenue earned in Kenya is spent on buying goods abroad, boosting foreign factories.

Sachen Gudka, who chairs the Kenya Association of Manufacturers, said enhanced power and tax incentives for factories producing clothing, iron and steel products can help ease pressure on Kenya's import

# **Under-fire Shoprite** to overhaul exec pay

**JOHANNESBURG** 

Shoprite Holdings, which has been under significant pressure on executive pay in recent years, will overhaul the remuneration of its top managers. However, the changes will only be implemented

The group has been criticised for the performance criteria on both its short- and long-term incentives, which are identical. Previously, the CEO's short-term incentive was based on a single metric: trading profit. Shareholders have also called into question the vesting of long-term incentives, which is not conditional on future performance.

The changes come following the astonishing result at its last AGM where 73% of ordinary shareholders voted against the group's remuneration policy and 69% against its implementation.

The detailed votes on resolutions were disclosed by the group for the first time in April. Previously, it would publish only a single result that is distorted by the high-voting deferred shares under the control of chair Christo Wiese's Thibault Square Financial Services. The group says its remuneration committee, "together with executives and the company secretary, led the engagement with dissenting shareholders [following the AGM] to understand their concerns".

The result is a fundamental overhaul of the group's remuneration policy, a process being steered by new lead independent director, Professor Shirley Zinn. Zinn joined the board in August 2018. Performance criteria?

From 2020, short-term incentives will now be measured on an expanded set of "performance criteria that will apply to 11 executives, including the CEO and CFO". Elsewhere in the remuneration report, the group says there will now be five criteria, without detailing what these are.

"For 2020, we will revise the performance criteria and adjust the designs relating to long- and shortterm incentives," it adds. "These changes will first affect executives and senior management before being rolled out to additional eligible employees in 2021."

Comprehensive changes to the long-term incentive scheme will be finalised during the coming year and presented to shareholders for approval at the next AGM. The group further proposes increasing the number of remuneration committee meetings per year. In 2019, it held just two.

Top earners

In the year to August 2019, CEO Pieter Engelbrecht received total remuneration of R21.27 million, an increase of 4.5% on the prior year. The bulk of this was comprised of a 7.5% increase in his salary. His short-term incentive was marginally lower than the prior year at R4.4 million. New CFO Anton de Bruyn's total remuneration was R6.7 mil-

The group's largest shareholder, the Public Investment Corporation (PIC), with 11.85%, voted against both (non-binding) resolutions on remuneration last year. It says: "The remuneration policy appears to be inconsistent with best practice. Although the remuneration policy

does disclose some information, there are some shortfalls as they relate to other disclosures that aim to foster enhanced accountability on remuneration."

The PIC says it "voted against the implementation as a result of not endorsing the company's remuneration policy." "Even though the implementation report does contain the details of the remuneration awarded during the reporting period, the remuneration was awarded based on the principles that we do not support as disclosed in the company's remuneration policy."

One further change is that the proposed remuneration for chair Christo Wiese for the past year, if approved, will be implemented retrospectively. The group proposes that Wiese's director fees more than double to R1.209 million for 2019. Defending this, the group says "the median remuneration for the board chairperson at comparator companies is R1 456 269 (PwC Shoprite Holdings Ltd: Non-executive directors remuneration benchmark, June 2019)."

Wiese's remuneration as chair of Shoprite has soared since 2017. In that year, director fees for the group's chairperson totalled R397 000. It jumped to R598 000 in 2018. If approved at the November AGM, Wiese's fees will have increased by 205% in the past two years.

The group will also align the fees paidtothechair of the remuneration committee (Zinn) to what it calls "comparator companies." The group says benchmarking by PwC found the "median remuneration for the remuneration committee chairs" was R193 679. If approved, Zinn's fees for this role will increase by 146% to R193 000 for 2019.

# **Exxon to finalise LNG investment** today - Mozambique government

US energy giant Exxon Mobil will finalise its investment in Mozambique's lucrative liquefied natural gas fields in a signing ceremony on Tuesday, the African country's government said via state television.

Exxon's Rovuma LNG project, jointly operated with Italian firm Eni, will produce, liquefy and sell natural gas from three res-

ervoirs located in the Area 4 block offshore troleum gas (LPG) per year during the pro-Mozambique's northern coast. Exxon estimates the fields, which are due to come online in 2024, will cost \$30 billion to develop.


State television news channel TVM on Sunday said the Ministry of Mineral Resources and Energy would host a signing ceremony with Exxon and other firms in the capital Maputo on Tuesday. Exxon has said it expects 17 000 tons of liquefied peduction phase, with the signing of an initial investment decision paving the way for the massive infrastructure project to begin.

# Posta woes intensify as letters fall to new lows

**NAIROBI** 

The number of letters posted locally in a year fell to 47.1 million to June – the lowest in a decade on the increased use of Internet-based mailing systems shinning the light on the waning demand for the services by Postal Corporation of Kenya.

Latest industry data by the Communications Authority of Kenya (CA) shows that this was a 24.4 per cent fall from 62.3 sent in 12 months to June last year as the once-dominant state corporation faces bleak days ahead.

The sharp fall coincides with the growing coverage of fibre connections to homes and offices and Internet use that offer users the faster and convenient Web-based mailing platforms and the private couriers.

In the period under review, the number of fixed Internet connections rose by 13 percent to 420,980 at the back of growing increased investments by the telcos to link more homes and offices to fibre-optics network. "During

the period under review, postal and courier subsector registered mixed trends as most consumers take preference in digital communication services," the CA said in the report.

The record fall in letters posted come at the back of financial constrains at PCK which has, in turn, turned to other business portfolios to shore up its revenues. At 47.1 million letters posted in 12 months, this is a decline of more than double from 109 million posted in the 2010-11 period-the days when Posta enjoyed dominance through its traditional mailing services.

While the number of post offices dropped from 623 in 2017 to 592 last vear, the number of private couriers increased from 997 to 1,027 in the same period piling pressure on the Posta that is already fighting to stay afloat as telcos increase Internet coverage.

Safaricom – the second-largest service provider in the fixed Internet after Zuku-owned Wananchi Group increased its fibre connections to homes and offices to 6,700km from about 5,000km last year. In the last 10 years, Internet service providers and the entry of giant telco Safaricom, have drastically cut the reliance on Posta for the physical delivery of letters.

The parastatal struggles are further underlined by the high number of idle boxes that stood at 70,000 as at September 2017. The State corporation in a bid to stay afloat entered the clearing and forwarding business mainly handling car imports from September last year. Some of its customers include National Oil Corporation of Kenya, the Central Bank of Kenya and individuals.

# Subscribers lose out on kykNET, Mzansi Magic as MultiChoice shuts down DStv Select

**CAPE TOWN** 

Many DStv subscribers are set to lose access to the Mzansi Magic and kykNET channels with MultiChoice that in turn will lose DStv customers altogether after the pay-TV operator told subscribers on DStv Select for as long as they keep that it will shut down its two DStv Select packages at the end of the month.

DStv Select subscribers who have had access to kykNET for instance, are suddenly facing an almost 100% increase in what they will have to pay if they want to continue watching it, with many shocked customers saying they can't afford it and are done with DStv.

MultiChoice is eliminating its two legacy packages - DStv Select 1 that contains Mzansi Magic as a TV channel as part of its collection, as well as DStv Select 2 that provides kykNET as a part of its collection.

Exclusive to DStv HGTV (channel 177) is the global authority on everything home, with engaging on-screen superstar experts, fascinating families, compelling renovations and stunning transformations that make all things home fun.

MultiChoice is putting DStv Select customers before the choice of either tor and cancel their service altogether cancelling their DStv subscription, switching to the DStv Family package which doesn't contain these channels, or to suddenly pay a lot more for access to the channels they used to get.

DStv Select 1 subscribers who are paying R265 will now have to pay R399 per month for DStv Compact to get Mzansi Magic. DStv Select 2 customers will suddenly have to fork out R519 per month - a sudden once-off increase of around 96% - which many existing DStv customers say they simply can't afford.

DStv Select subscribers have complained that they don't know what's going on, can't understand why MultiChoice is taking their package away, and are accusing MultiChoice of not having communicated with them properly. They are saying that they are being forced to now drop DStv as loyal customers because they can't afford the massive subscription fee jump just to continue to watch the channels and shows that they used to get.

MultiChoice stopped offering the DStv Select packages in April 2013 which it started as an offering in conjunction with Vodacom. At the time MultiChoice promised existing DStv Select subscribers that they can remain paying for it.

Over the past five years MultiChoice took several channels away from DStv Select and didn't replace channels that it terminated with new ones as it does on its other bouquets. It also didn't add any new channels.

Yet, DStv Select subscribers kept holding on to their DStv Select subscriptions and for good reason - the Mzansi Magic and kykNET channels. When MultiChoice terminated its legacy M-Net analogue package, Multi-Choice moved those loyal subscribers to a like-for-like DStv service that still included M-Net without making them pay more, but the same isn't happening for DStv Select subscribers.

MultiChoice told DStv subscribers that they will be moved to DStv Family at R265 per month from 29 October 2019. DStv Select subscribers have the option to contact the pay-TV operaor upgrade to a much more expensive package.

"Your favourite channels are however still available on our various other packages," MultiChoice is telling DStv Select subscribers.

"This is so painful. I have supported DStv and kykNET for many years as a loyal subscriber, but I can't suddenly pay double," said a distraught DStv Select subscriber from Port Elizabeth.

# African economies with greatest potential for trade growth named

frican economies come first and third in the Standard Chartered Trade20 Index, which identifies the markets with the greatest potential for future trade growth.

Côte d'Ivoire is the market that has most rapidly improved its trade growth potential over the past decade, according to new research from Standard Chartered. The Trade20 index, which identifies the 20 rising stars of trade, places African markets Côte d'Ivoire in the top spot, and Kenya at number

The Trade20 index determines each market's trade growth potential by analysing changes within the last decade across a wide range of variables, grouped into three equally-weighted pillars: economic dynamism, trade readiness and export diversity.

The study examines 66 markets around the world. It finds that while existing trade powers like China and India continue to rapidly improve their trade potential, African economies are making particularly strong progress from a relatively low starting point.

Kenya is consolidating its position as the trading hub of East Africa, while Côte d'Ivoire is cementing its position as a West African trading hub. Ghana also performs well in the index, placing just outside the top 10.

 $The \, key \, findings \, of \, the \, Trade 20 \, index$ for African markets are: Côte d'Ivoire and Kenya have significantly improved their trade readiness, demonstrating that investments in infrastructure and business environment improvements are paying off. Côte d'Ivoire and Ghana also fare well for economic dynamism, with Côte d'Ivoire enjoying robust GDP

and export growth, and Ghana seeing an influx of FDI.

Already connected with the trading powers in Asia, particularly China, through the Belt and Road Initiative, and with the launch of the African Continental Free Trade Area, we see numerous growth opportunities for trade and investment in the years ahead. Additionally, the growing young, digitally-savvy population and an increasing female workforce will aid in the continent's economic transformation."

Trade20 examines 12 metrics across 66 global markets - the major global economies plus the major economies in each region - to reveal the 20 economies that are most rapidly improving their potential for trade growth.

While most traditional trade indices are based on a market's present performance, the Trade20 index captures changes over time to reveal the markets that have seen the most improvement within the last decade. This enables us to identify the economies where recent positive developments may point to an acceleration in trade growth potential.

These markets are identified by measuring changes in 12 metrics under three pillars: economic dynamism (foreign direct investment, export and GDP growth), trade readiness (infrastructure, e-commerce, and ease of doing business) and export diversity (the range of exports).

While most traditional trade indices are based on a market's present performance, our index captures changes over time to reveal the markets that have seen the most improvement during the last decade. A high ranking also suggests a market that is improving as a possible outsourcing location.

# Nigeria misses the mobile money revolution

**LAGOS** 

Every month, Ifevinwa Abel, the secretary of a Pentecostal church in Lagos, spends as much as a quarter of her salary sending money to pay for diabetes drugs to her mother 430 miles away in Abia Ohafia, a small agricultural village.

It isn't easy. First Abel, 35, has to go to a bank branch in Lagos, the country's commercial hub, and transfer 6 000 naira (\$17) into the account of a friend in Ebem Ohafia, another town in Abia state. Then she's got to pay 2 000 naira to 4 000 naira for her 65-year-old mother, Uche Arua, to get on the back of a motorcycle and ride 8 miles from her village to Ebem Ohafia to pick up the money.

At least that's what happens if this fragile arrangement doesn't break down. Some months, Abel can't afford the motorcycle fare; other times, rains make the dirt road impassable. "Sometimes I am unable to send the money, and she stays without the drug, and I am pained," Abel says, shaken and dabbing her eyes with a handkerchief. "She must get the money and buy her drugs to survive."

Abel's story would be unusual across much of the rest of sub-Saharan Africa. In a region that accounts for half of the world's 866 million mobile banking and payment accounts and two-thirds of all money transferred by phone, Nigeria is a laggard. There are an estimated 172 million mobile phones in the country, but it didn't award a single mobile banking license until July, when it gave one to South Africa's MTN Group. Its foot-dragging encouraged by the traditional banking sector, say industry analysts and telecommunications companies - is blamed for declining financial inclusion in this country of almost 209 million people.

Nigeria vies with South Africa as the continent's largest economy and is its most populous, but it's a "sleeping giant" in the world of fintech, according to GSMA, a trade body that represents 750 mobile phone operators globally. Across sub-Saharan Africa, the adoption of mobile payments, which incur lower costs than traditional banking, has helped bring financial tools to the masses. Financial inclusion in the region grew by more than 8 percentage points from 2014 to 2017, to an average of 43%, according to World Bank data. In Nigeria the rate dropped almost 4 percentage points, to 39% – far short of the Central Bank of Nigeria target of 80% by 2020.

Even with its new license, MTN doesn't look much like a bank: It can't lend money or pay interest. In Kenya, by contrast, Safaricom acts much more like one. Part-owned by a unit of Vodafone, it launched its M-pesa app in Kenya in 2007. Today 22 million people, almost half of the population, use M-pesa as a mobile bank – buying groceries, borrowing money, transferring cash. "There's no excuse for not sending money home because it's now very easy," says Kip Ngetichi, a 28-year-old waiter in Nairobi, who, with a few keystrokes,

sends money twice a month to his mother 240 miles away in the western town of Kitale.

Telecommunications companies and analysts say Nigeria is straggling behind its neighbours because its banks successfully campaigned to forestall the introduction of mobile payments. "The banks have been lobbying hard to protect their interests," says Christophe Meunier, a senior partner at Delta Partners Group, an advisory firm for technology and media companies.

The new law, critics say, is hardly a cure-all; indeed, the way it's structured will likely slow MTN and its rivals in line for licenses - Bharti Airtel, Globacom, and 9Mobile – in their attempts to roll out services. Without the ability to lend or pay interest, mobile operators may struggle to encourage people to keep money in their accounts, says Usoro Usoro, the general manager of mobile financial services for MTN Nigeria. "Mobile money in its delivery is intrinsically a collaboration of multiple industries," he says. "We haven't received as much collaboration as required." As things stand, says Meunier, "the way the legislation is written, even now, is very favourable to the banks."

With 61.5 million subscribers and a network that spans all of Nigeria's 774 local government jurisdictions, MTN can offer a larger consumer base than any of the nation's banks. It plans to accredit 500 000 agents just to pay money out to recipients of mobile transfers if they want hard cash. Still, Usoro says, adoption of the technology will be slower than it could have been if regulators had allowed MTN to provide a wider range of financial services, including savings accounts and loans. "For mobile money to make the impact that we've seen in other African countries, it needs to be utilised as far more than a simple money-transfer business," he

For their part, Nigeria's banks are adamant that they haven't intentionally slowed the introduction of mobile money. They blame the country's low literacy levels and poor financial infrastructure in rural areas. Nigeria's literacy level is 51%, compared with 79% in Kenya, according to the World Bank. "Financial presence as well as financial literacy is not adequate in rural and remote areas," says Iphy Onibuje, head of digital banking at Lagos-based Fidelity Bank Plc. Digital transfers only began to be piloted in 2012, she says. To win more business, she adds, the bank is willing to partner with mobile phone companies that have greater reach into rural areas.

As inadequate as the new legislation is from the standpoint of the mobile phone companies, their services are hugely in demand and are expected to take off fast as more licenses are granted. The country's adult population of 111 million – which dwarfs the 64 million in Ethiopia, another major sub-Saharan country where mobile banking has made limited inroads – is a big draw for providers.

# **US diplomats to** testify about Trump-Ukraine efforts as **Democrats build** impeachment case

### **WASHINGTON**

A PARADE of U.S. diplomats will head to Capitol Hill for closed-door testimony this week as Democrats build their impeachment case against President Donald Trump, while the White House considers ways to slow down the process.

The interviews could yield more fodder for Democrats' impeachment drive over a whistleblower's allegations that Trump leveraged \$400 million in aid to secure a promise from Ukrainian President Volodymyr Zelenskiy to investigate political rival Joe Biden, and his son Hunter, who sat on the board of a Ukrainian energy com-

Trump has denied wrongdoing and assailed the probe.

Among those due to testify: Gordon Sondland, the U.S. ambassador to the

Fate of future DPRK-US dialogue depends on US attitude - DPRK

**PYONGYANG** 

THE Foreign Ministry of the Democratic People's Republic of Korea (DPRK) said on Sunday that the fate of future DPRK-U.S. di-

spokesperson for the Foreign Ministry, the DPRK blamed the United States for the failure of the recent working-level talks in Sweden and said it has no intention for further negotiations unless Washington changes its "hostile policy."

Pyongyang approached the negotiations "with expectations and optimism" because Washington repeatedly expressed that it was ready for dialogue based on "a new method" and "creative solution," said the statement.

"However, the trite stance shown by the delegates of the U.S. side at the negotiations venue made us feel that our expectations were no better than an empty hope and rather increased a doubt as to whether the U.S. truly has a stand to solve the issue through dialogue," it said.

The spokesperson also noted that "the recent negotiations have left us skeptical about the U.S. political will to improve the DPRK-U.S. relations and made us think if it isn't its real intention to abuse the bilateral relations for gratifying its party interests."

Delegations from the DPRK and the United States held a meeting that lasted over eight hours in Stockholm on Saturday, in a bid to revive a nuclear diplomacy that has stalled since DPRK top leader Kim Jong Un and U.S. President Donald Trump ended their second summit without a deal in Hanoi, Vietnam, in February.

But shortly after the meeting, DPRK delegation's chief negotiator Kim Myong Gil called the talks a "failure" as the United States did not offer a new proposal.

U.S. State Department spokesperson Morgan Ortagus, contradicting Kim's remarks, said that its delegation "brought creative ideas and had good discussions with its DPRK counterparts."

### Russia worried over escalation of tension over drilling activities in Cyprus economic zone

### **MOSCOW**

MOSCOW is worried over the escalation of tension around the development of hydrocarbon fields in Cyprus' exclusive economic zone and call on all parties concerned to refrain from destabilizing steps, the Russian foreign ministry said on Sunday

"We follow with concern the escalation of tension around the development of hydrocarbon fields in Cyprus' exclusive economic zone," the ministry said. "We call for refraining from steps that may entail destabilization and buildup of the crisis potential in Eastern Mediterranean, for strict compliance with the principles of international law, for resolving disputable issues only by peaceful means."

The ministry also called for the soonest relaunch of a negotiating process in order to reach a lasting, viable and fair solution to the Cypriot problem in the interests of all Cyprus' residents. "As a permanent member of the United Nations Security Council, we will do our best to promote this process," the ministry stressed.

Large natural gas field have been discovered on Cyprus' shelf and in its exclusive economic zone. Thus, the Aphrodite field discovered by US' Noble Energy in 2011 is believed to hold about 140 billion cubic meters of gas.

Turkey, which does not recognize the Republic of Cyprus, challenges the borders of its exclusive economic zone, saying it won't tolerate any drilling activities off Cyprus' coastline without consent from the Turkish Cypriot community.

Drilling vessels dispatched to the area by Ankara under licenses from the self-proclaimed Turkish Republic of Northern Cyprus enjoy protection from Turkey's Naval Forces. **Agencies**

# US withdraws troops from northeast Syria ahead of Turkish offensive

### **ISTANBUL**

THE United States said it was pulling troops from northeast Syria, in a major policy shift which opens the way for a Turkish offensive against Kurdish-led forces and hands Turkey responsibility for thousands of Islamic State captives.

The move angered the Kurdish-led forces who have been Washington's most capable partner in fighting Islamic State in Syria. The forces, known as the Syrian Democratic Forces (SDF), accused Washington of reneging on an ally, warning it would have a "great negative" impact on the war against the jihadists.

Reflecting concern about potential harm to civilians, a U.N. official said civilians must be spared in any Turkish

military operation in northeast Syria, adding the United Nations hoped that displacement and atrocities can be prevented.

"We are hoping for the best but preparing for the worst,'

Panos Moumtzis, U.N. regional humanitarian coordinator for the Syria crisis, told reporters in Geneva.

A U.S. official said American troops had withdrawn from two observation posts on the border, at Tel Abyad and Ras al-Ain, and had told the commander of the SDF that the United States would not defend the SDF from an imminent Turkish offensive.

"Turkey will soon be moving forward with its long-planned operation into Northern Syria," the White House said after President Donald Trump spoke



to Turkey's President Tayyip Erdogan (pictured) on Sunday.

"The United States Armed Forces will not support or be involved in the operation, and United States forces, having defeated the ISIS territorial "Caliphate", will no longer be in the immediate area," it added in a statement.

Turkey has long argued for the establishment of a 20-mile (32 km) "safe zone" along the border, under Turkish control. driving back the Syrian Kurdish YPG militia - which is the dominant force in the SDF alliance and which Ankara considers a terrorist organization and a threat to its national security.

The United States helped the YPG defeat Islamic State militants in Syria, and had been seeking a joint 'security mechanism' with Turkey along the border to meet Turkey's security needs without threatening the SDF.

The SDF accused Washington

of turning its back on an ally.

"The American forces did not fulfill their commitments and withdrew their forces from the border areas with Turkey, and Turkey is now preparing for an invasion operation of northern and eastern Syria," it said in a statement.

SDF official Mustafa Bali said U.S. forces were "leaving the areas to turn into a war zone".

The White House statement appeared to hand over to Turkey responsibility for captured Islamic State jihadists who are currently held in SDF facilities to the south of Turkey's initially proposed safe zone.

# MSF warns of decline in international funding for fighting HIV/TB

### **CAPE TOWN**

DOCTORS Without Borders (MSF) yesterday warned of a decline in international funding and rapid shifting of the financial burden to affected countries after a decade of strong commitments to fight the twin epidemics of HIV and tuberculosis (TB).

The decline is in danger of reversing lifesaving gains and causing an "epidemic rebound" in some countries, MSF said in a report emailed to Xinhua.

The goal of ending HIV and TB is still far from being achieved as the diseases together still kill upwards of two million people each year, MSF said.

Despite this, donor and domestic funding for HIV programs declined in 2018 for the first time in more than a decade, falling by 1 billion U.S. dollars in low and middle-income countries,

while the funding gap for TB programs widened further, reaching 3.5 billion dollars per year, MSF cited UN figures as saying.

"This recent downward trajectory in funding comes at a critical juncture for the HIV and TB response," said Dr Mit Philips, one of the contributing authors of the report.

"While gains made in countries such as Mozambique are at significant risk of backtracking, there is an even higher risk that countries in regions such as West and Central Africa, which are already lagging behind in the HIV and TB response, may see the situation deteriorate even further."

Based on studies in nine countries where MSF runs HIV and TB programs, the report documents how international funding shortfalls and insufficient domestic resources available are already



causing wide-ranging gaps in HIV and TB diagnosis, prevention and care ser-

"Every day, MSF teams in these countries witness how patients are suffering and dying from these treatable dis-

eases," said Dr. Maria Guevara, another contributing authors of the report.

"The number of people on lifetime HIV treatment keeps on expanding, but the money available to support them keeps on shrinking," he said.

services available, many people are not starting treatment on time or are forced to abandon treatment altogether, while others must dig deep into their pockets to pay for drugs so as not to interrupt their treatment, Dr. Guevara said.

With not enough drugs or support

All of this contributes to increased transmission, higher mortality, more treatment failures and an even higher prevalence of drug resistance, further increasing the cost of care for HIV and TB, he said.

According to MSF's report, the impact of current HIV and TB funding gaps are underestimated and likely to increase, as vulnerable countries struggle to compensate for the decline in external financial support. Even where the political will exists to contribute more, many countries are not ready to take on this responsibility in the short term.



Rioters also hurled petrol bombs at police officers, with one petrol bomb hitting a reporter at the scene. Local radio RTHK later confirmed that the victim was one of its journalists, and he was sent to hospital for treatment.

The statement said in response to the rapidly deteriorating situation, the police "conducted dispersal operation with appropriate force, including tear gases, rubber bullets and bean bag rounds."

Condemning the rioters for "taking the law into their own hands," the police said one taxi driver was pulled out from his vehicle after a traffic ac-

cident in Sham Shui Po and severely battered by rioters to unconscious

Another large group of rioters later attacked a man and left him unconscious in Mong Kok, where a woman was also beaten up allegedly for taking photos of rioters' vandalism acts the police said.

Noting that the violent acts are spreading and escalating drastically, and Hong Kong is being pushed to the verge of a very dangerous situation, the police pledged to continue with resolute enforcement action and bring all lawbreakers to justice.

# **Macron: EU Brexit deal** decision 'at end of week'

LONDON

THE EU will decide at the end of the week whether a Brexit deal is going to be possible, French President Emmanuel Macron has told Boris Johnson.

President Macron said talks should now proceed swiftly to see if an agreement could "respect" EU principles.

Johnson said the EU should not be "lured" into thinking there would be a delay to Brexit beyond 31 October.

The PM will hold further calls with EU leaders on Monday to discuss his latest proposals for the Irish border.

Downing Street said Johnson was expected to hold phone calls with the leaders of Sweden, Denmark and Poland, after speaking to Macron on

The prime minister told the French president over the phone he believed a deal could be achieved, but that the EU must match compromises made by the UK.

A French government official said President Macron told Mr Johnson "that the negotiations should continue swiftly with Michel Barnier's team in coming days, in order to evaluate at the end of the week whether a deal is possible that respects European Union principles".

The comments come ahead of a key few days of negotiations as both parties try to find a new agreement in time for a summit of European leaders on 17 and 18 October.

Arrangements for preventing a hard border on the island of Ireland continue to be a sticking point, with the EU calling for "fundamental changes" to the UK's latest proposals.

A senior Number 10 source said: "The UK has made a big, important offer but it's time for the Commission to show a willingness to compromise too. If not the UK will leave with no deal."

Under the Benn Act, passed last month, the prime minister must write to the EU requesting a Brexit extension if no deal is signed off by Parlia-

### **African expert** lauds China's development miracle in past 70 years

**ADDIS ABABA** 

CHINA'S socio-economic development miracle over the past 70 years has helped the country to become one of the major global economies and political powerhouses, an Ethiopian scholar said on Sunday.

Claiming China's economic showcase over the past decades as a miracle, Costantinos BT Costantinos, who served as an economic adviser to the African Union and the UN Economic Commission for Africa, told Xinhua on Sunday that China has been "rapidly globalizing, fine-tuning to emerging technological prowess, building dazzling infrastructure and capitalizing heavily on human development."

Costantinos, also a professor of public policy at the Addis Ababa University in Ethiopia, further stressed that China has been working together with Africa mainly through the Forum on China-Africa Cooperation (FOCAC) as well as various other joint initiatives.

China and African countries are, within the framework of the FOCAC, vigorously advancing economic and trade cooperation, and actively exploring a common path that reflects both China's and Africa's realities, the scholar said.

"Through the common efforts of China and Africa, bilateral economic and trade cooperation now enjoys a consolidated foundation and improved mechanisms, with new common interests and growth points in cooperation constantly emerging,' he added.

Costantinos said that China's policymakers are already focused on how to change the country's growth strategy to respond to the new challenges that will come.

Describing the current international situation as experiencing "profound and intricate changes," Costantinos also stressed that "newly emerging and developing economies have become the major force pushing forward the world's economic development."

Noting that "skeptics are wary of China's interest in Africa," the expert also emphasized African leaders' comments in refuting negative claims in China-Africa overall ties.

"As President Cyril Ramaphosa stated -- In the values that it promotes, in the manner that it operates, and in the impact that it has on African countries, FOCAC refutes the view that a new colonialism is taking hold in Africa, as our detractors would have us believe," said Costantinos.

cles on the path of Syrian settlement. We know that certain perspectives are opening up and we understand that it will be a long and thorny path.

And now that the Syrian Constitutional Committee has been formed and when the date for its meetings has been appointed, it is vital to refrain from any steps that may harm Syrian settlement," he said. Meanwhile the Kremlin expects that in its preparations for an operation in northeastern Syria Turkey will proceed from the postulate that the territorial and political integrity of that country must be preserved.

"The Kremlin knows Turkey is committed to the postulate of Svria's territorial and political integrity, to the understanding that Syria's territorial integrity is the point of departure – both in the course of efforts to achieve a settlement in Syria and in all other matters. We hope that our Turkish counterparts will first and foremost adhere to this postulate in all situations," Russian Presidential Spokesman Dmitry Peskov told the media.

# China's agricultural modernity wows foreign journalists

FOREIGN journalists were park. amazed by China's modern agricultural facilities and lauded the country's agricultural modernity as they visited Yangling Agriculture Hi-Tech Industrial Demonstration Zone, a national-level high-tech development zone in northwest China's Shaanxi Province during a recent media workshop held by the Belt and Road News Network (BRNN).

Their questions about Chinese agriculture such as spray and drip irrigations, as well as fertilizers "stormed" Ma Xinshi, president of an entrepreneurship and innovation park of professional farmers in Yangling, who was surrounded by enthusiastic Latin American and Spanish journalists at the

Several journalists from Spain's Radio International and Agencia EFE were attracted by the irrigation system of the park which according to Ma, has a high efficiency and can save 70 percent of water thanks to its drip irrigation.

Referring to a row of bags containing farmyard manure and organic fertilizers that lined up in a fruit greenhouse, Ma introduced that such fertilizing method would bring down the restrictions of local soil qualities on the growth of plants, and these bags are easy to carry.

China has done a great job applying organic fertilizers, said Cinthia Velarde, a journalist from Peruvian news agency

Agencia de Noticias Andina, explaining that the original taste of the food has been better preserved thanks to the agricultural innovations made by the parks in the region.

Leaving the entrepreneurship and innovation park, journalists visited the Sino-Israel Agriculture High-tech Demonstration Park in Neixiang County, central China's Henan Province, where the Internet of Things (IoT) system for greenhouses in a fertigation control center caught their eyes.

# Basketball's NBA under fire over Rockets' twitter furore

Basketball THE National Association came under fire on Monday for its response to a tweet by a Houston Rockets official in support of Hong Kong protests for democracy, the latest overseas business to run afoul of political issues in China.

Rockets' general manager Daryl Morey apologised on Monday for the tweet, which he swiftly deleted over the weekend, but his support for protests in the Chinese-ruled city angered Beijing, Chinese fans and the team's business partners in a key NBA market.

"I did not intend my tweet to cause any offense to Rockets fans and friends of mine in China," Morey tweeted on Monday.

"I was merely voicing one thought, based on one interpretation, of one complicated event," he said, adding that he had since heard and considered other perspectives.

The Rockets are widely followed in China, partly because they drafted Yao Ming in 2002, who became a star for Houston and helped build the NBA's following in China.

Morey's initial tweet included an image captioned: "Fight For Freedom. Stand With Hong Kong."

It prompted sportswear brand Li-Ning and sponsor Shanghai Pudong Development Bank (SPD Bank) Credit Card Center to suspend work with the Rockets, while the team's games were dropped by China's state broadcaster.

In a separate statement, the NBA said it recognised Morey's views have "deeply offended many of our friends and fans in China, which is regrettable." "We have great respect for the

history and culture of China and hope that sports and the NBA can be used as a unifying force to bridge cultural divides and bring people together," it said.

# Silverwood replaces Bayliss as England head coach

CHRIS Silverwood was named England head coach on Monday in place of Trevor Bayliss as the England and Wales Cricket Board (ECB) opted against another overseas candidate to take the team forward.

British media reported last week that former India and South Africa coach Gary Kirsten had emerged as the leading contender, but Silverwood, the team's former bowling coach, was preferred.

Australian Bayliss departed last month after England's drawn home Ashes series against Australia having led the

They struggled for consistency in tests under his guidance, slipping to fourth in the world rankings, but enjoyed sustained success in one-day cricket, rising to the top of the rankings and winning their first 50-over World Cup title this year on home soil.

The 44-year-old Silverwood played six tests and seven one-day internationals for England as a fast bowler during his playing career, the majority of which was spent with his native county Yorkshire.

He moved into coaching and in 2017 led Essex to their first County Championship title for 25 years before becoming England pace bowling coach.

"Chris was the standout candidate," England director of cricket Ashley Giles said in a statement.

"He is what we need to take our international teams forward. He's somebody we know well, but it is his intimate understanding of our structures and systems and his close relationships with test captain Joe Root and white-ball captain Eoin Morgan that will help us develop our plans for the next few years," Giles added.

"He has performed exceptionally well during his role as an assistant coach and has the ultimate respect of the players' that have worked with him."

Silverwood's first assignment will be England's tour of New Zealand on which they play five Twenty20 internationals starting on Nov. 1 and two tests, before they travel to South Africa.

### 'Nervous' City have a lot to do in title race - Pep

MANCHESTER, ENGLAND

MANCHESTER City manager Pep Guardiola has admitted his team have it all to do in the title race after being hit by nerves during their shock 2-0 defeat to Wolves.

City slipped eight points behind leaders Liverpool after suffering their first defeat at the Etihad Stadium since December thanks to two late goals from Adama Traore.

"It was a bad day, sometimes it happens," said Guardiola. "We started quite well and after we conceded two situations in our build-up where it's impossible to defend, we got a little bit nervous.

"It is a lot of points. They [Liverpool] didn't drop points for many circumstances. It is better not to think that one team is eight points ahead."

Liverpool opened up a seven point gap on Boxing Day last season but City still managed to rein them in to secure back-to-back titles.

They have now lost two of their first eight league games -- their worst start to a campaign since 2013 -- but Guardiola still believes his team can make it three in a row.

"I know these guys," he added.

"Still they are incredibly involved and can do it. What happened, hap-

"Most of the teams who won in the past, the year after, don't win. Today was the day not in our level. The previous games were good.

"But the distance is big. I know that. Liverpool is not dropping points. But we are in October, still a lot of games."

Guardiola revealed he was forced to substitute Kyle Walker at halftime because the full-back was suffering the effects of a stomach virus that prevented him from training during the week.

He also refused to criticise centreback Nicolas Otamendi despite the Argentinian making a series of mistakes which led to Wolves' chances, including diving in on Raul Jimenez in the build up to the first goal.

"They [centre-backs Fernandinho and Otamendi] were quite good," said Guardiola. "They suffered because we lost the position in front

Matthew Longstaff's second-half winner increased the gloom for United who will enter the international break languishing in 12th place – 15 points behind leaders Liverpool.

Solskjaer's side had plenty of possession on Tyneside on Sunday, they were toothless with England striker Marcus Rashford barely having a sight of goal all afternoon.

A United line-up missing the likes of Anthony Martial, Paul Pogba and Jesse Lingard looked powder-puff against a defence that leaked five goals last week against Leicester

While Solskjaer rightly pointed to the absentees, he said there was no quick fix for United's current malaise which stretches back to the latter stages of last season.

"It will take as long as it will take," he said when asked for a realistic time frame for the club's fortunes to revive.

"I can't give you a time but we will get there. We have given ourselves a big, big uphill task to get in the top

four, never mind the top six.

"We need to get a run together and get the confidence back. If you only walk on sunny days you will never get to your destination.

"It's disappointing, but we know where we want to get to."

Solskjaer said he would try and "evaluate" the opening eight Premier League games, from which United have only nine points in their worst start to a league campaign since 1989-90, during the international break.

"We are disappointed, of course," the Norwegian said. "The boys worked their socks off. But we don't create enough chances to win a game of football."

Goalkeeper David de Gea said it was the worst moment for the club since he joined in 2011.

Asked what was missing, the Spaniard said: "Everything. There is lots to improve. We just try to keep trying and fighting, improving ev-

ery day. It's a hard moment for us." Former United defender Gary Neville, analysing the game for Sky Sports, said this could be a season of pain for the club. **REUTERS**

MANCHESTER City's Premier League title defence suffered another huge blow in a shock 2-0 defeat to Wolves, while Manchester United endured another miserable day in a 1-0 loss at Newcastle on Sunday.

City now trail runaway leaders Liverpool by eight points after just eight games as Adama Traore punished a sloppy performance by the champions with two goals in the final 10 minutes at the Etihad.

"Today we were not at our level," admitted City boss Pep Guardiola. "We had problems to make our game. We have faced many teams defending deep and found a solution, but not this time."

City badly missed the presence of injured duo Aymeric Laporte and Kevin de Bruyne as Wolves soaked up plenty of possession from the hosts, but always looked the more dangerous side on the counter-attack.

Raul Jimenez failed to make the most of three breakaway chances before the interval, but the Mexican made amends with a great run past the hapless Nicolas Otamendi to set up Traore's opener.

The same two players then combined in stoppage time as Traore raced through to seal a famous win for Wolves.

"The first thing you have to do is stop them and we did that because the players were running like crazy," said a proud Wolves boss Nuno Espirito Santo.

City have now dropped more

# Are Manchester United facing a relegation battle?

IT is a thought most Manchester United fans would never imagine, especially during the trophy-laden glory years of Sir Alex Ferguson, but after losing 1-0 to Matthew Longstaff's goal at Newcastle United on Sunday, the nightmare scenario of a relegation battle cannot be ruled out.

While Liverpool have surged eight points clear of champions Manchester City at the top of the Premier League table with eight wins from eight games, United are languishing in 12th position, just two points above the bottom three after their third league defeat. They have won only twice and scored just nine times; four of those goals came in one game on the opening weekend against Chelsea.

If this was any other club, alarm bells would be ringing ahead of a long struggle for survival. And with barely a quarter of the campaign gone, it would be foolish to suggest that United will find themselves locked in a battle against the drop between now and next May.

When you consider both the shortand long-term form slide suffered by Ole Gunnar Solskjaer's team, though, there are few positives. Since a remarkable 3-1 Champions League victory against Paris Saint Germain in March, United have not won a single away game in any competition.

And since that famous victory at Parc des Princes, United have the third-worst record among teams that played in the Premier League this season and last. The word from within Old Trafford is that the Glazer family are determined to stand by their manager as he attempts to rebuild the club's squad. United's owners, who bore the brunt of hostile chants from supporters at St James' Park, persisted with David Moyes, Louis van Gaal and Mourinho long after it became clear those managers had lost the plot, so Solskjkaer may be safe for a while yet.

But one point per game from the equivalent of half a season is relegation form, plain and simple. Clearly, United are one of the richest clubs in the world and so possess the financial muscle to make changes in January when the transfer window

reopens.

Where will this team be by that stage? Liverpool visit Old Trafford next, with a difficult trip to Norwich immediately afterward for Solskjaer and Co. If United lose at Carrow Road, To place Solskjaer's woeful run it will be impossible to find reason to argue against a battle for survival.

> It could be argued that one big reason for the current woes is Solskiaer's failure to sign a replacement for Romelu Lukaku or Alexis Sanchez, both of whom were shipped off to Inter during the summer transfer window. Moreover, at Newcastle, the starting XI was shorn of first-team regulars such as Victor Lindelof. Aaron Wan-Bissaka, Luke Shaw, Jesse Lingard, Anthony Martial and Paul Pogba due to injury.

> When those players are fit and available, United will be much stronger. But if their squad is so shallow that it cannot cope with the loss of five players -- none of whom could be classed as a world-class gamechanger -- then it does not bode well for a long season that also involves the distraction of Thursday football

in the Europa League.

Of those who have been available, Marcus Rashford has become a nonscoring striker, Juan Mata is no longer capable of making an impact at this level and Brazil international Fred is repeatedly anonymous in midfield.

As manager, Solskjaer must find a way to make his squad perform better and come up with a tactical plan that creates and converts chances in front of goal. If he survives in the job, he also needs to inject some fight into a team that is too timid and lacking the ability to respond to setbacks.

Despite this latest setback, Solskjaer insisted that his players possess

"We have started a rebuild, so this is not a similar situation to Everton (last season, lost 4-0), where I felt some had given up," he said. "These boys haven't given up. They have given everything for the shirt.

"But it's where we are at the moment. We don't create enough chances to deserve to win a game of football. I couldn't see that (performance) coming before the game. Ball seemed like a hot potato; it was bouncing off our feet.'

With two whole weeks until his side's next game, United's manager pledged to examine what has gone wrong, before Liverpool come to

"Luckily for us it's now the international break," Solskjaer said. "We get time to evaluate what's gone on over these eight games. But it's my responsibility. I need to sort their heads out. Young boys lacking confidence; they need some help from experienced players and staff."

Solskjaer also looks like he needs help, but will he get it and will it come in time? The reality of Manchester United is that there are more questions than answers.

"I must admit that we had a very difficult time coming up with the final team, and that is mainly because the boys we had called up in our provisional squad were just too good in their respective positions," Khumalo

disclosed. "After a thorough assessment we had to go with the 20 players as per the regulations of the tournament, but I know that even the ones being left behind are very talented unfortunately we can't take them with."

"I am also confident that they will represent the country well in the COSAFA Cup. I am very positive they will fight to reach the final."

Khumalo added that he has gone for much younger players to compete in the tournament, because the focus is on the future, not the immediate.


"We could have brought in much older players as compared to the Under-14s and Under-15s we had selected to compete in this year's COSAFA edition. However, that approach was going to hurt our plans in the long run as we are preparing for next year's COSAFA tournament, which will also double up as the 2021 Under-17 Africa Cup of Nations which we want to qualify for," he disclosed.

"Getting a spot there will give us an advantage as our ultimate goal is to qualify for the 2021 FIFA Under-17 Men's World Cup - and we can only achieve that by giving these young players the needed experience to grow from this year's tournament, so that they can get used to this level of competition come next year's U-17 AF-CON qualifiers."

In the 2019 edition of the COSAFA Cup, Amajimbos are pitted in Group A alongside hosts Malawi, Zambia and Eswatini.

The top two nations will proceed to the semi-finals of the competition.
