

# 'Dar port laxity causing losses'

• MPs shelve Health ministry estimates to debate 'go-slow' at the port

#### By Songa wa Songa, Dodoma

EMBERS of Parliament yesterday called on the government to take action and end laxity at the port of Dar es Salaam after it emerged that operations at the facility had slowed down, occasioning huge losses.

This came after Mafinga Urban MP Cosato Chumi raised an argument of urgency, asking the House to suspend debate on estimates of the Ministry of Health and deliberate on the matter.

The move was supported by a number of lawmakers who stood up, reaching the required threshold and Deputy Speaker Tulia Ackson allowed the matter to be discussed.

Chumi argued that he had reliable information that loading and offloading of at the port was at a snail's pace for the past two days, leading to pile-up of goods hence massive losses to both the government and companies whose businesses depend on efficiency at the facility.

Maswa East legislator Stanslaus Nyongo said the slow pace of loading and offloading of goods had affected a chain of businesses in Tanzania and neighbouring countries using the port.

"There is a problem with flow meters and forklifts. This needs to be sorted out because the impact of delaying loading



# SIDA, TAHA inaugurate uplift drive on avocados

WITH millions of people around the world suddenly developing insatiable craving for buttery avocado, the Swedish International Development Cooperation Agency has moved in to assist Tanzanian growers to capitalise on the ever increasing global demand for the crop.

SIDA is working with the Tanzania Horticultural Association (TAHA) which serves fruit and flower farmers especially in the northern zone, with the new initiative kicked off on Wednesday. launching the 'avocado cluster' in Arumeru District.

"As coffee prices drop globally, avocadoes are becoming the next green gold commanding high prices coupled with increasing demand," said the TAHA Executive Director. Jacqueline Mkindi, at the avocado cluster launching event held at Ngyani Cooperative Union, about six kilometers from the Leganga Road Junction of Usa-River, in Meru District.

China inks 35.3bn/- project aid accord

THE government yesterday signed a grant agreement worth 35.3bn/- with China for various development projects countrywide.

Emanuel Tutuba, the Permanent Secretary for the Treasury, said yesterday that the funds under the framework agreement will be utilized to finance expansion of the Jakava Kikwete Cardiac Institute (JKCI), upgrading the National Institute of Transport (NIT) into a university, improving the Ngorongoro Lengai Geopark and other priority projects being discussed between the two countries..

China has been supporting Tanzania in areas such as railway infrastructures, education, health, information communication technology (ICT), energy, water, the industrial sector, the agriculture sector and others.

Chinese support through concessional loans for completed projects since 2010 stands at about

#### Ward councillors, local growers, local government officials, producers and association officials were present, with TAHA tasked with facilitating smallholder farmers in the district to establish an avocado cluster for Hass variety needed by export markets. Ward representatives said that local farmers had started to uproot coffee trees as the crop was no longer beneficial commercially but were yet to find a replacement. "We are relieved that avocados have come to the rescue." they affirmed. These are growers operating at altitudes ranging from 1200m -1500m above sea level, described to be ideal conditions for excellent avocado production. TAHA will help enable these farmers realise the potentiality of their land through practical training using proven technologies on the production and marketing of Hass avocado, the director noted.

The global avocado market is currently being valued at \$9.14bn, with the United States, Canada, Japan, Spain and the Netherlands the major importers of Hass avocados.

# EAC sets up 'hotline' in cross-border trade

THE EAST African Community (EAC) Secretariat is set to avail a trade hotline providing cross-border traders with a platform to register challenges encountered and get prompt feedback, across all EAC border posts.

This measure comes in to resolve persistent non-tariff barriers (NTBs) and reduce the time spent in moving goods and persons, hence increasing intra EAC trade, which currently stands at 15 per cent of the The hotline will enable the secretariat to register persistent trade barriers, provide feedback and make follow ups

partner states' total trade volumes.

EAC Secretary General Dr Peter Mathuki made his first visit to the Namanga One Stop Border Post (OSBP) yesterday, meeting officials of trade facilitation agencies and cross border traders to exchange views on how to ease cross border trade.

"The hotline will enable the secretariat to register persistent trade barriers, provide feedback and make follow ups," he said

The East African Business Council (EABC), facilitating dialogue of government authorities and the private sector, affirmed that the movement of goods and persons at the Namanga OSBP and truck traffic impasse has been eased following the directive by President Uhuru Kenyatta during the two day state visit by President Samia Suluhu Hassan.

healthy food products for clinical reasons or a healthy lifestyle are impelling market growth of avocado. The fruits contain most vitamins and minerals required to boost immunity, with the ongoing Covid-19 pandemic further compelling buyers to seek out avocados, thus pushing up demand.

The idea of an avocado cluster in the northern zone is meant to facilitate large enough volumes for the

export market, given that the avocado market is not as yet saturated, she stated. They include; Évariste Ndayishimiye (Burundi), Mohamed Abdullahi Mohamed (Somalia), Emmerson Mnangagwa (Zimbabwe), Salva Kiir (South Sudan), Hage Gottfried Geingob (Namibia) and Alpha Conde (Guinea).

The presidents were received by Uganda's State Minister for Foreign Affairs, Henry Oryem Okello at

Museveni's swearing-in ceremony for his sixth-elective term of office at Kololo Independence Grounds.

On Tuesday evening, president Museveni treated his counterparts to a state dinner at Speke Resort Munyonyo "Interactions with the different

visiting Heads of State before the State Dinner at Speke Resort Munyonyo earlier. On behalf of Ugandans, I am supremely honored to host the different leaders here," Museveni said.

Museveni was declared winner of the January elections with 58 per cent of the votes cast while his closest

Entebbe Airport ahead of President contender, musician turned politician, Robert Kyagulanyi alias Bobi Wine got 35 per cent, according to the Electoral Commission.

# Mussa Zungu retains Parliament chair post

ILALA lawmaker Mussa Zungu (CCM) who served as chairman of the 11th Parliament has retained the position, this time sailing through unopposed.

Najma Giga, Special Seats lawmaker from Zanzibar who served in the previous Parliament has also retained the position, according to results announced yesterday.

Deputy Speaker Dr Tulia Ackson also named David Kihenzile of Mufindi South (CCM) as another Parliament Chairman; bringing the number to mandatory three.

Kihenzile is therefore the newcomer in the role because his two colleagues are experienced after serving in the same position in the last parliament after the 2015 General Election.

Another Chairman in the last parliament was then Bariadi West lawmaker and former Attorney General Andrew Chenge who did not make it back to the august house in the 2020 General Election.

As opposed to yesteryears, there was no actual voting in the floor of the House to get the three chairs because the Parliamentary Steering Committee sent only three names.

"On Monday 10 May 2021, the Parliamentary Steering Committee forwarded to the Office of the Speaker names of Mussa Zungu, David Kihenzile and Na-

jma Giga as candidates for parliamentary chairmanship," said Deputy Speaker Dr Tulia Ackson.

"If the number of approved candidates is the same as the number of positions, then the candidates sail though automatically."

The three chairs of parliament help the Speaker and Deputy Speaker in chairing parliamentary proceedings,

The speaker's official role is to moderate debate, make rulings on procedure, announce the results of votes, and the like. The speaker decides who may speak and has the powers to discipline members who break the procedures of the House.

CCM politician Zungu now returns to the seat not only as experienced House Chairman but also as a seasoned Member of Parliament for Ilala constituency having been elected since 2005. He has continued to retain the parliamentary seat in 2010, 2015 and 2020 General Elections.

# REPOA calls for agro-processing industries, agriculture investment

THE country's top thinktank-REPOA yesterday suggested the need for the government to invest more on modern agriculture and agroprocessing industries to maintain its economic growth.

Speaking in an interview with journalists during a tour at the Guardian ltd to mark the institution's silver jubilee celebration, the executive director of REPOA Dr. Donald Mmari said that the country is endorsed with resources which if effectively utilised will contribute a great deal in the country's development.

"There are a lot of resource based industries that the country can provide comparative advantages and one is agriculture but it needs to be converted into modern and very

productive agriculture" he said He added that considering the fact that the majority of people currently found in the fare agricultural system are small holders but the productivity yields, insisting that investments should be made in

this sector to make sure that
this productivity increases.
Dr Donald also called for a
strong linkage between natural based resource sectors like

agriculture, forestry (timber industry), minerals, and natural gases and other sectors including industry manufacturing.

`In order for these sectors to coexist they need to be a policy environment that fosters investment like good roads to connect raw material sources, production sites and market" he said. Also they have to be power which is reliable, adequate and cheap so that it can make our

production competitive, he added.

He also said that it is true that from 1991 to 2017 the country has experienced a drop in the poverty rate that is from 48percent to 26.1 according to the National Bureau of Statistics which now takes the country to a middle income level but more can still be done to maintain that.

"We must continue to accelerate the economic growth rate,

we need to attain a minimum of 8percent but if we can reach double digit growth that will be best because it can accelerate the speed of growth and that has to be sustained for a reasonably and the poverty rate" he said.
Dr Donald added that the economic structure has to be restructured in line with the growing economy paving the

way for more productive sectors

to grow. This will create jobs in technology driven sectors and manufacturing sectors away from the former economy.

He further expressed the need for the promotion of further domestic and foreign investments which are very important requirements for economic growth which he said also requires policy reforms to be able to attract both domestic and foreign investors.

# Govt appeals to farmers, maize traders to grab Kenyan market

AGRUCULTURE Minister Prof Adolf Mkenda has called on farmers and maize traders to grab the opportunity of Kenya's maize market as part of cooperation with East African countries.

The minister was addressing reporters here at the weekend soon after meeting with cassava crop stakeholders during which he also unveiled the crop's strategy.

In regard to his ministry's position to spur agricultural development and the strategy for the cassava crop, Prof Mkenda said his ministry is well mobilised to ensure benefits from production are increased including the availability of market for maize in Kenya.

"Recently presidents of Tanzania and Kenya met and discussed challenges in conducting business between the two countries, resulting in the opening of the border for traders to continue with their businesses for the benefit of all," he said.

He added that the recent visit of President Samia Suluhu Hassan to Kenya was a great success for farmers and traders as they received the opportunity to sell their crops in Kenya.

"In that score I have had talks with Kenya's Ministers for Trade and Agriculture Peter Munya who was on his way to Namanga border post to oversee the implementation of the directives from our two presidents," he added.

He stressed that maize and other goods were safe as before export, the Tanzania Bureau of Standards (TBS) make examination to ensure the crop meets the required safety standards.

"Our government's goal is to ensure we conduct quality competitive trade. In doing so we must use our TBS experts to verify the goods quality and safety standards in order to compete in the market," stressed Prof Mkenda.

He also assured maize buyers and other goods in the E. A. Community (EAC) that Tanzania maize are of the high market standard.

Meanwhile the Minister called upon cassava crop stakeholders to use quality seeds created by the country's researchers to increase income to farmers.

He said the Ministry will continue researching via the country's experts to increase the production of the cassava crop which is in high demand in China.

He said the Agriculture Ministry continues to work closely together with agriculture stakeholders by involving other ministries including the Ministry of Industry and Trade, the PM Office and Foreign Affairs to ensure cooperation that would strengthen agriculture by involving all stakeholders.

# MPs want stable insurance scheme in Health ministry's 1trn/- budget

MEMBERS of Parliament yesterday called for radical changes in the health insurance schemes and fast-tracking of Universal Healthcare Bill to enable all Tanzanians access quality services.

Debating 2021/2022 budget estimates for the Ministry of Health, Community Development, Gender, Elderly and Children in the National Assembly yesterday, the lawmakers reported several weaknesses in the National Health Insurance Fund (NHIF) and the improved Community Health Fund (iCHF) schemes. With only select packages covered and lack of some essential medicines in public health facilities, the MPs called on the government to make hard decisions to sal-

vage health sector. In its report, the Parliamentary Standing Committee on Social Services said that Universal Healthcare is the only solution to the current challenges facing health sector.

"Universal Health Coverage has been the agenda of this parliament though this com-

mittee for a very long time. However, this matter has not been resolved and the committees has been told that funds have been allocated for preparation of its Bill; it the hope of the committee that the Bill will be brought to parliament as promised so that all Tanzanians access quality healthcare," said committee chairman Stanslaus Nyongo.

"Because there are complaints from members of NHIF that they do not get some services and medicines, the ministry should take immediate and bold action to resolves these challenges." Grace Tendegu (Special Seats) said one of the challenges members of NHIF and iCHF face is going through lengthy consultations and diagnosis processes only to be directed a medical store to purchase prescribed drugs.

"If health facilities continue directing patients to go and buy drugs somewhere else, then even the said Universal Health Coverage will not help," she said.

Regina Kway (Special Seats) said patients with long term health conditions such as diabetes and low or high blood pressure are not covered by expublic health schemes, risking their lives.

"Our health insurance should provide medications to such for patients because truth be told, p they deserve to get them for free," she said.

The lawmaker also spoke of the plight of senior citizens whom she said do not get free treatment as directed in the government's own policy, warning all will one day get old and need reliable healthcare. Dr Christia Mzava (Special Seats)– CCM charged that there are public health facilities in Dar es Salaam that decline to attend to pregnant women who have other health issues.

"I urge the government to follow up this matter. Denying pregnant women with medical cover other services is unacceptable," she said.

Tarime Urban MP Michael Kiambati reported poor services in the Tarime District Hospital where he said workers compel patients to do works other people are employed to do. "Patients are forced to do cleaning at the hospital; I plead with the ministry to look into this matter," he said. Mainmuna Mtanda (Newala Rural)–CCM said free health service for elders of 60 years and above, children under five and expectant mothers is a pipe dream for the target groups.

Dr Dorothy Gwajima, Minister for Health, Community Development, Gender, Elderly and Children tabled a 1,077,759,224,000/- budget estimates for the 2021/22 financial with a range of priorities.

Out of the total amount, 491,730,236,000/- is meant for development projects while 586,028,988,000/- is meant for other charges.

#### Z'bar to tighten investment policy and laws to do away with red tape

THE Zanzibar government says it plans to strengthen policies and laws that would ensure to have in place conducive investment environment and do away with red tape.

The remarks were made by the Minister of State in the President's Office (Labour, Economic Affairs and Investment) Mudrik Ramadhan Soraga in the House of Representatives when winding up and responding to members questions in regard to the ministry's budget estimates for FY 2021/22.

Soraga said special investment areas allocated at Micheweni in Pemba will be developed and already there were good signs for investors to invest in the area.

He mentioned the projects for building factories for processing seaweed and production of oil from spices.

He said as for now the main task by his government which is the foremost priority is to install essential infrastructures in the area including electricity, clean water and roads.

"I would like to make a pledge on behalf of the government that the free areas at Micheweni in Pemba is among the government priorities for investment as it plans Pemba Island to become a special investment area," he added.

Soraga further said the government has opened up doors to more investors as well as the private sector for investing in the construction of an oil and gas terminals and port at Mangapwani and Mpiga Duri in Unguja.

He said the government thrives to have good relations with the private sector for Zanzibar's economic growth.

The House endorsed the ministry's budget estimates for revenue and expenditure for FY 2021-2022 whereby a total of 34.8bn/- for both current and development expenditure.

# Mbeya commuter bus drivers blame govt for ongoing strike

COMMUTER transport in Mbeya City came to a standstill for two days running following the strike by bus drivers claiming failure by the government to honour its obligations in the agreement reached with them to control motor cycle (bodaboda) and tri-cycle (Bajaj) drivers.

The bus drivers claim that Bajaj drivers have been invading their routes and take passengers, the situation that make them difficult to meet their daily monetary returns to bus owners.

The strike, the second one this year had caused great inconveniences to commuters including

school children who have been forced to walk, with some opting to the costly Bajaj means of conveyance.

Speaking to this paper yesterday, some of the bus drivers said they will continue with the strike until the government honours the agreement with them by having in place a good procedure to ensure Bajaj and bodaboda drivers do not intrude in their routes

One of the leaders of the bus drivers' association Raphael Simbeye said during an earlier meeting with the government they agreed in more than 10 resolutions, but only one was implemented, the situation that continue to adversely affect their operations. He said the resolution implemented was to restrict bajaj drivers to enter the Kabwe Bus Tand to pick up passengers, but the rest, including the abiding by road traffic laws and stop them using routes used by commuter buses have not been implemented.

He said after seeing the resolutions not being implemented they decided to stop providing commuter service until such time they are implemented, saying they were simply following the directives of the bus owners.

"Bajaj drivers pick passengers even at 'no parking" stages without being challenged but if I do the same City askaris promptly come to arrest me and get fined," lamented Simbeye. He said they have repeatedly been fines of up to 400,000/-, the situation that has greatly been affecting their business.

Some Mbeya residents called on the government to come to terms with the bus drivers and remove inconveniences posed by frequent strikes that have been affecting their day to day activities.

Pascalina Kipeta, Uyole resident following the strike by commuter bus drivers said Bajaj drivers have raised fares, more than what they used to pay for buses.

She said earlier they used to pay 800/- from Uyole to Mbalizi but now they were charging up to 2.000/-.

#### **Banks to seek new collateral** in retaken properties - govt

BANKS that issued loans on securities retaken by authorities are obliged to get new collateral from their clients, parliament heard yesterday.

Deputy Minister for Lands and Human Settlement Development Angelina Mabula said this after it emerged that a parcel of land being retaken by the government was used as loan collateral.

"The owner will be issued with a notice of ownership withdrawal and the financial institution that issued loan on that property will be formally notified so that it gets new collateral," she said.

Mabula said this is in compliance with Land Act Cap 113 which allows the government to retake land properties that have not been developed by their owners in accordance with agreed terms and conditions.

She was responding to a question by Mkinga MP Dunstan Kitandula (CCM) who asked when the government will cancel the title deeds of over 2000 acres at Kwamtili in Tanga Region that have not been developed for 20 years as agreed during allocation.

The lawmaker wanted the government to retake the land and distribute it to local residents for other uses.

"It is true that the land with title deeds number 14501 (2841 acres) and number 4722 (58 acres) located in Mkinga District which were allocated to Kwamtili Estate Ltd for agricultural development have violated terms including underdevelopment and failure to pay

#### TAWIRI teaches youth on how to deal with destructive jumbos By Guardian Correspondent, Meatu

TANZANIA Wildlife Research Institute (TAWIRI) in collaboration with the Natural Resources and Tourism ministry continue to educate people bordering wildlife parks and other reserve forests on how to deal with destructive wild animals including elephants.

The institution has also been educating the people on various techniques to fight with the beasts without harming them, with one among the techniques being use of male condoms.

Speaking soon after a training seminar for 30 youth from Itilima, Meatu and Bariadi districts bordering Maswa Forest Reserve in Simiyu Region, the Acting Tanzania Wildlife Authority (TAWA) Director, Dr Janemary Ntalwila said condoms are to be used to make 'bombs' for chasing away elephants.

He said apart from teaching the youth four ways to deal with elephants, the use of condoms was easy and were easilv obtained.

Dr Ntalwila said another technique taught is beekeeping in the farms, tying of strings immersed in pepper around the farms and making bricks doused with pepper.

He elaborated that other techniques taught to the youth include the use of candle 'bombs' and those using male condoms. He said all these methods have provided achievements, saying in the event the beasts refuse to go away, then the 'bombs' are to be applied.

"Candlelight 'bombs' are costly as each costs more than 30,000/- inside which are five explosives but is the quickest way to chase away elephants, but our institution saw a better 'bombs' method - condom 'bombs' that are affordable to many people," said Dr Ntalwila.

# Coop Union constructs 3.9 billion/worth crops packaging bags factory

SONGEA-NAMTUMBO Cooperative Union (SONAMCU) in Ruvuma Region says it is in the process of constructing packing bags factory aimed to ensure farmers in the region do away with challenges in packing their crops including maize, soya beans, and pigeon peas.

This was revealed by SOMNACU Manager Juma Mwanga in his report to the country's Registrar of Cooperatives Dr Benson Ndiege during the latter's visit at the factory project in Namtumbo District on Monday.

Mwanga said in his report that apart from the factory whose bags would be sold at an affordable cost to farmers and other Ruvuma Region residents, the factory is owned by SNAMCU members by 100 percent and expects to cost 3.98bn/-

He added that the project began in 2020 and is expected to be completed in 2022.

"As for now SONAMCU gets its pack-

ing bags from Dar es Salaam, but we expect that upon completion the factory will be able to manufacture 10 million bags per year," he said.

Mwanga also said that up to the current construction stage, the cost is being met from the Union's internal income by 100 percent from its various sources, and added that it also expects to source loans from financial institutions.

Namtumbo District Administrative Secretary Aden Nchimbi said Namtumbo District expects to benefit by the project in job opportunities that it will create.

For his part, Dr Ndiege praised the factory's construction saying the packaging bags were in great demand in the market due to many kinds of crops produced by cooperatives inside and outside Ruvuma Region.

"Due to the bags great demand it is in our expectations that cooperative societies will be our big customers and I must congratulate SONAMCU for its support of government efforts in the country's industrial development, said Dr Ndiege.

Meanwhile, on Monday May 10 SONAMCU has conducted its first simsim auction in Ruvuma Region at OTC Lilambo Marker area being the second such simsim auction nationally after the one conducted in Songwe Region recently.

During the auction, the Cooperatives Registrar had the opportunity to explain that the Warehouse Receipt System benefits both sides seller and buyer.

He added that a huge collection of crops from farmers to the warehouse simplified the burden of following each farmer in different area to collect the crops.

"Ruvuma is among regions that have been doing well in the Warehouse Receipt System due to its sale of various crops including cashew nuts, simsim, soya and pigeon peas whereby both farmers and traders have benefitted," he added.

# **GBV stigma in Mbarali District during 2015-2020**

A TOTAL of 4,223 people underwent various acts of gender based violence (GBV) and child abuse in Mbarali District, Mbeya Region in the period of five years between 2015 and 2020, the situation that threatens community development of the district's residents.

This was disclosed early this week by Mbarali District Community Development Officer, David Makere at Madibila Ward at the launching of the campaign against gender based violence and protection of water sources spearheaded by Save Life Organisation of Tanzania (SALIOTA), a Non-Governmental Organisation (NGO).

Makere said out of the number more women than men reported the acts of violence done to them to various authorities.

He said 3,449 women and 774 men reported the acts of violence they underwent to Community Health Centres, police stations and Community Development offices including non-governmental organisations (NGOs).

"We have been educating the community to work together to fight this vice, as for now we have provided this education to heads of schools as well as other pressure groups," he said.

SALIOTA Director Elisha Mwanikawage said the aim of the NGO is to ensure acts of gender based violence and child abuse in the District are eliminated including equal treatment in the provision of community services.

He said they will make sure there was equality for the provision of education to both girls and boys including in the provision of health and water services. Mwanikawage also said they would make sure rampant cutting of trees and setting fires to forests are stopped to preserve the environment.

"We will also raise our voices against wildlife poaching in both national parks and reserve forests to make sure the wildlife benefits the present and future generations," he added.

For his part, Mbarali Special Seats Member of Parliament Bahati Ndingo called on the stakeholders to ensure they take the education against GBV and child abuse to the villages, as they were the ones rampant with the problem.

She said among the causes for GBV acts is misleading traditional beliefs among the communities especially in rural areas.

#### TAMWA calls upon parents, guardians to protect children during Eid al-Fitr festivals

DIRECTOR of the Tanzania Media Women's Association (TAMWA- Zanzibar) Dr Mzuri Issa has called on parents and guardians to increase the protection of their children during Eid al-Fitr celebration.

Speaking ahead of a canonical festival of Islam-Eid al-Fitr, that marks the end of Ramadan, the Muslim holy month of fasting, Dr Mzuri said that the celebrations are accompanied by child abuse incidents such as rape, incest, and even disappearances.

Despite the day being a joy for all citizens, Dr Mzuri said they shouldn't leave children wandering the streets as there are some people with bad intentions that can cause serious harm.

"We've been witnessing many cases of child abuse during these festivities. On average, five cases are recorded per day, whereby children who are under 18 are being raped and taken away. That's why it is important for parents and guardians to take care of their children all the time," she said.

According to him, between December and March this year, genderbased violence (GBV) networks have revealed and worked on 76 incidents - 44 in Unguja and 32 in Pemba, a situation that indicates such incidents still exist and should be carefully considered.

"In normal circumstances, there are groups of children who appear to be roaming the streets throughout the festive period unprotected asking for a hand for Eid in an environment in which we believe people can use it as part of the opportunity to do their evil," she added.

Sometimes children unknowingly find themselves entering homes where bad people live who lure children by giving them gifts and eventually committing atrocities that are holding back the national workforce.

Dr Mzuri also urged the police force to heighten security at various areas including playgrounds as well as to inspect vehicles providing passenger services throughout the festive period.

#### researchers outlines oppo inities in wastewater

ARDHI University (ARU) researchers have outlined different opportunities that can be obtained from wastewater and hard fossil that emanates from human waste after being refined.

The opportunities are biogas which is for domestic use, fertilisers, and refined wastewater that can be used in different activities like irrigation schemes instead of depending on rain season.

This was revealed yesterday by ARU researchers when speaking to people who visited Sanitation Biotechnologies Research Center on how

they produce biogas and fertilizers from hard fossils. One of the researchers who

are a PhD student, Edward Ruhinda said one of the products in their center is biogas which can be used in domestic activities.

Ruhinda is doing research on how to refine hard fossils from human waste to get biogas, fertilizers and refine wastewater to get clean water

to be used in different activities

Jonas Gervas is doing research on the impact of using refined wastewater on soil and crops that are cultivated by using refined wastewater for irrigation.

Fredrick Ligate is doing research on decentralized wastewater collection and cotreatment with putrescible domestic wastewater to enhance biogas generation and

effluent quality. Ruhinda said they have been taking wastewater from different areas and refine them and after that, they can be used for irrigation and the crops become safe for human consumption.

He said they also take hard fossil that emanates from human waste and process it to produce fertilizers which can be used in agriculture activities and get crops that are health for human consumption.

He said the cost of transporting wastewater is very high due to poor infrastructure so their research will come up with the simplest way that people can use to deal with liquid waste.

He cited an example that currently there are only two places to dump wastewater that cannot handle all wastewater from the city so it is important to conduct research on the simple way that can be used to handle it.

Speaking on how they process hard fossils from human waste, Ruhinda said they create an artificial situation like in the human body's stomach to enable the digestion system to continue and in the end, they

get biogas and fertilizers. He added that due to water shortages all over the world many developed and developing countries use the system to refine wastewater and use it in different development activities. He said in order to find if

the refined wastewater that is used for irrigation is safe they have introduced a special farm at the university research center where they use refined wastewater for irrigation and finally research the crops if they are safe for human consumption.

He said on their farm there is evidence that where they use refined wastewater for irrigation, crops seem to grow faster and healthier than those using normal water.

"People should not worry about refined wastewater because they are used all around the world due to water shortage and they must know that wastewater after being processed the final product is safe for human consumption," he said.



# **President revels in achievements, not words**

ONE important function of Independence Day is that it is a convenient point for us to take stock of where we are, where we have come from and where we still have to go, and in his wide-ranging interview this year to mark this important day President Mnangagwa did precisely that.

But he concentrated on the present rather than on the achievements of the past, at what the Second Republic has faced and is facing as it puts Zimbabwe back on course and this time on course in a real world rather than one of make-belief.

Besides the capital investment in our decaying infrastructure. And building new dams as well as rehabilitating older irrigation systems, and fixing the national highway system, which includes pricing tolls properly to pay for this, the Government has been able to step in to start addressing the mess in our urban authorities: bad roads, inadequate water supplies, decaved infrastructure.

Legally municipalities are supposed to be exemplars of local government, funding, maintaining and expanding their services.

Some of the problems, like Bulawayo's shortage of raw water, are being rapidly addressed as a legitimate central government responsibility. But others require declarations of disaster to allow the central Government to step in. The President was in many ways easy on the opposition, simply urging them to identify with national goals, which surely means a more prosperous and functioning Zimbabwe, and then contributing to the debate and the efforts. He was not looking for agreement, but rather proper input and argument rather than trying to wreck what we have first. But the urban local government mess does show quite dramatically the limited input of too much of the opposition. One would assume that since opposition parties control most urban councils that they would be using that opportunity to show how much smarter they were and testing out alternative policies. Their only alternative offered is largely disaster and to ask someone else to bail them out. Well their foreign friends are not helping them make Harare great. The President's impatience is justified, that he has to step in to fix stuff in the richest parts of Zimbabwe because opposition leaders want to organise demonstrations rather than repair roads and replace water pipes. One feels he would prefer competing on efficiency and seeing which ideas work the best so the flow of really good ideas would be a two-way process and so accelerate progress. President Mnangagwa is not fond of rhetoric and that interview once again showed how he prefers to talk about what has been done and achieved, and what is being done right now, by workers on the ground. And, yes, he was able to list a lot of accomplishments. In the end that is what he was elected to do and how he wants to be judged.

#### Hypertension Day: Should focus on keeping blood pressure under control

HYPERTENSION also known as high blood pressure (HBP), is a long-term medical condition in which the blood pressure in the arteries is persistently elevated. High blood pressure typically does not cause symptoms. Long-term high blood pressure, however, is a major risk factor for stroke, coronary artery disease, heart failure, atrial fibrillation, peripheral arterial disease, vision loss, chronic kidney disease, and dementia.

High blood pressure is classified as primary (essential) hypertension or secondary hypertension. About 90-95 per cent of cases are primary, defined as high blood pressure due to nonspecific lifestyle and genetic factors. Lifestyle factors that increase the risk include excess salt in the diet, excess body weight, smoking, and alcohol use. The remaining 5-10 per cent of cases are categorised as secondary high blood pressure, defined as high blood pressure due to an identifiable cause, such as chronic kidney disease, narrowing of the kidney arteries, an endocrine disorder, or the use of birth control pills.

Blood pressure is classified by two measurements, the systolic and diastolic pressures, which are the maximum and minimum pressures, respectively. Lifestyle changes and medications can lower blood pressure and decrease the risk of health complications. Lifestyle changes include weight loss, physical exercise, decreased salt intake, reducing alcohol intake, and a healthy diet. If lifestyle changes are not sufficient, then blood pressure medications are used.

Hypertension is rarely accompa-

nied by symptoms, and its identification is usually through screening, or when seeking healthcare for an unrelated problem. Some people with high blood pressure report headaches (particularly at the back of the head and in the morning), as well as lightheadedness, vertigo, tinnitus (buzzing or hissing in the ears), altered vision or fainting episodes. These symptoms, however, might be related to associated anxiety rather than the high blood pressure itself. On physical examination, hypertension may be associated with the presence of changes in the optic fundus seen by ophthalmoscopy.

World Hypertension Day is a day designated and initiated by The World Hypertension League (WHL), which is itself an umbrella to organisations of 85 national hypertension societies and leagues.

The day was initiated to increase the awareness of hypertension. This was especially important because of the lack of appropriate knowledge among hypertensive patients. The WHL launched its first WHD on May 14, 2005. Since 2006, the WHL has been dedicating May 17 of every year as WHD.

In 2005, as the inaugural effort, the theme was simply 'Awareness of high blood pressure'. The 2006 theme was 'Treat to goal', with a focus on keeping blood pressure under control.

The recommended blood pressures are less than 140/90 mmHg for the general population and for the hypertensive population without any other complications, and less than 130/80 mmHg for those with diabetes mellitus or chronic kidney disease.

he won his own mandate in 2018, he and the team of technocrats he assembled to help sort out the problems faced a daunting task. So the subsidy menace was eliminated, cutting one major source of privatesector corruption, pricing was altered to cover real costs, and eventually the honest parts of the private sector were mobilised to fill the gaps.

taxes for petrol and diesel to end the last element of temptation.

So in the end Zimbabweans paid more for energy, but in return had guaranteed supplies. Not that the Government was totally trusting. The energy regulator, Zera, acquired teeth and could audit and examine the accounts and start doing its job properly, making sure that those in the energy sectors, and this included the Government-owned Zesa, could charge fair prices without profiteering. Perhaps the level of that achievement has been seen in the total destruction of the fuel black market and now in price competition at the petrol pumps. Zimbabwe is back in a normal world.

The resurrection and growth of the industrial sector, which started getting products back on shelves, was not a single policy. Rather it was built on the dramatic and far reaching reform of the fiscal and monetary systems.

And that was built on a host of policies. First, and fundamentally, the Second Republic started living within its means, running the country on what it raised in taxes rather than pretending Zimbabwe was rich and printing money, either literally or electronically, to fill the increasing gaps.

That in turn allowed the monetary reforms, which included the return of the local currency, carefully and in stages so there was no total meltdown, but surprisingly swiftly.

That policy was finally brought to fruition with the foreign currency auctions, and for the first time in over half a century market forces under regulation, but not control, could operate. The result has been a surge in production and, in many but regrettably not all sectors yet, competitive forces operating that ensured consumer choice and an increasing degree of competitive pricing.

Competitive pricing works when there is abundance and other Government policies, now coming to fruition, of ensuring that our farmers could grow what we needed have been filling gaps.

Black markets, profiteering and cartels require scarcity to work. When you open investment to newcomers, and fix the foreign exchange allocations to be open to all, you remove the props that too many relied on.

Admittedly those reforms did lead to a burst of high inflation, now largely tamed, as the underlying mess rose to the surface. And there was more than we expected, but it has now been accounted for. The monthly inflation rates are very low.

There are still too many economists who look at annual inflation rates, which are falling fast, but these are not useful and will not be useful until about September when the sudden stability will have been running for a full year. Then they start measuring something that is important and valid for our economy.

As President Mnangagwa noted, none of this was easy. And as he also recognised it did affect his Government's popularity, but as he stressed it was necessary. When he started the reforms he did not sell them as the easy option. He simply told us they were needed if Zimbabwe was ever to grow economically by producing more rather than shuffling paper around. And he was right. Now the Government can do things having fixed its spending. This meant it can cope with emergencies, such as drought and cyclones, and with the major menace of Covid-19.

We had major, and very welcome, help in coping with these emergen-

# Ugandan nurses persevere at their posts amid COVID-19 hardships

Teopista Asimwe, another nurse, told Xinhua that despite the meager pay, they still stay at their posts to provide health care to the people who come to the health center."We have few nurses and midwives providing prenatal, delivery, and postnatal services.

Being a health facility that's within the town center, we end up providing delivery and postnatal services, including family planning and immunizations," said Asimwe.

"The workload is heavy and we sometimes need extra hands, especially on peak days," said the nurse. Juliet Nalwanga, a 25-year-old mother of two, said she was happy because she at least got the health care provided by the nurses and midwives."The nurses here are friendly and I feel happy whenever I come here to immunize my children, although sometimes the health center is filled with many people, especially during these pandemic periods," Nalwanga told Xinhua at Goma Health Center in the central district of Mukono.

Justus Cherop Kiplangat, president of the Uganda Nurses and Midwives Union, told Xinhua that, although many nurses and midwives work under terrible conditions, they still continue to provide health

Kiplangat said many health workers do not have decent accommodation and some live far away from their workplaces.

The Ugandan government in May 2018 pledged to increase the wellbeing of nurses and midwives, including increasing their lunch allowance.

But the government reportedly failed to fulfill the pledge, which forced nurses and midwives to stage a sit-down strike several days ago. Ugandan government officials said the pandemic had changed the government's priority for funding allocations.

Robinah Nabbanja, minister of state for health in charge of general duties, told Xinhua that once the pandemic slows down, the medical workers would be the priority.

"My advice to nurses and midwives is to remain working as the government looks for funds to fulfill its promise," she said.

David Karubanga, minister of state for public service, told reporters that the leadership of the Nurses and Midwives Union had reached a consensus with the government over the payment of their lunch allowance.

OME 40 km outside Cape Town, Leebah Bessick wipes sweat from her forehead as she digs a pitchfork into the earth at a neighbourhood community garden.

It's an unseasonably hot day here at Blackheath Secondary School and even a shady corner of the garden offers Bessick and the other gardeners little respite from the midday sun.

Still, she finds refuge here these days after enduring a year of hardship and unemployment caused by the onset of the Covid-19 pandemic, which hit South Africans hard.

"I learned that the only way to survive is through asking for help and accepting it from kind people," Bessick says, adding: "In return, I've learned to appreciate the little things in life. I try to help out in community projects to return the favour.'

Bessick (43) had a fairly comfortable middle-class lifestyle until the pandemic shut down borders and businesses across the world last year, including in South Africa, which has experienced one of Africa's worst outbreaks.

The bookkeeper at a small financial services firm was first forced to take a pay cut; then, in July 2020, she was laid off.

The government child support grant she has received each month as a single mother of three since her savings ran out, has been a lifeline. She receives the equivalent of US\$90 a month - US\$30 each for her 15-year-old daughter and two boys, aged 7 and 8.

She says: "I didn't have a lot of money, but I was comfortable. There was money through the month for things like going to the doctor's. Now I'm stuck with the same contact lenses. My glasses broke. I haven't been able to change them for a year."

Millions of Bessick's compatriots are in much the same predicament as a result of the pandemic's twin health and economic crises. The coronavirus has infected more than 1.5 million South Africans and killed 54,417, according to the country's national health department statistics released on May 2.

An estimated 2.6 million South Africans have lost their jobs since the pandemic hit, according to the African Development Bank's (AfDB) 2021 African Economic Outlook report.

Like many financially constrained African countries, South Africa turned to the bank to support its Covid-19 health and economic response efforts. In This has helped lift more than five million people above 



July 2020, the bank approved a loan of around US\$288 million to the government.

The funding supported the provision of essential healthcare needs. By February 2021, South Africa had boosted its Covid-19 testing capacity roughly sevenfold to conduct 35,000 tests per day. The same month, it became one of a handful of African countries to launch a vaccination programme, although the rollout has been slow.

To counter the social and economic effects of the crisis, 18 million people - or close to one-third of the country's population - have received additional social grants. the food poverty line and alleviated widespread hunger. Over 4.5 million workers have received more than US\$3.8 billion in wage support through a temporary unemployment insurance fund. In spite of these interventions, the conservative estimate of South Africa's unemployment rate is 30 per cent.

Patricia Blows, who runs the community garden in Blackheath, encouraged Bessick to join her in growing vegetables on the school-donated plot of land.

Affectionately known as Aunty Pat, Blows recalls that during the worst of the Covid-19 pandemic, people constantly knocked at her door in search of food. After a while, she said, she could no longer turn them away and

that is how she - and the rest of her family - contracted the coronavirus.

"Luckily enough, it's starting to get better now. But now we must rebuild," she said, as the chatter of young people spilled out into the afternoon air.

By some strange quirk of fate, Leebah Bessick found employment shortly after this interview was conducted.

# From genocide widow to successful businesswoman -- Rwandan woman walking out of shadow

#### KIGALI

#### 100 days starting from April 7.

N an April rainy morning in Nyanza district, about a two-hour drive from the Rwandan capital city Kigali, Immaculee Kayitesi was seated at the counter of her dairy business, listening to the radio, while busy passing a bottle of sanitizer to one of her customers to sanitize his hands before buying milk products from her company.

Dozens of customers lined up waiting to be served with different milk products such as vogurt, pasteurized milk, and fermented milk in the shop while scores of workers were it was "almost impossible" to operating milk processing

Although almost all of her immediate family members including husband, parents, siblings, cousins as well as inlaws were killed during the genocide, the then secondary school teacher managed to escape from the killers by hiding in swamps and dense vegetation for one month until she came across Rwanda Patriotic Army soldiers, who later ended the genocide and turned into the national military. She had even thought she might be the last woman left standing in the whole Nyanza district because survive.

# Clean cooking energy solutions key in transforming the people's lives

#### **By Correspondent Gerald Kitabu**

ENERGY stakeholders have called on Tanzanians to adopt clean cooking energy solutions to transform lives and rescue the environment and the forests in particular from rapid deforestation.

They were speaking at energy stakeholders' conference and exhibitions held in Dar es Salaam on the importance of clean cooking energy solutions over the weekend.

They said it saves forests by avoiding the over-use of green natural resource which result into saving water sources and reduced level of carbon emissions, improved health to users by avoiding health problems caused by smoke and other hazardous emissions from combustion of biomass.

One of the stakeholders, Estomiah Sawe said there are a lot of potential opportunities and benefits associated with clean cooking energy solutions such as highly efficient electric pressure cookers (EPC).

Citing an example, Sawe who is also the executive director of Tanzania Traditional Energy Development Organization (TaTEDO) said cooking energy remains a central part when it comes towards achieving the UN Sustainable Development Goal 7 and the Paris Agreement.

He recommend that as the country is making major efforts on electrification; all efforts need to be made to link these efforts with sustainable clean cooking.

According to him, the current technological developments on highly efficient electric cooking appliances bring about a huge opportunity to now link electrification, not only for lighting, but also for cooking. Depending on the source of electricity, this is now considered by many as the long term ultimate sustainable clean cooking solution for Tanzania.

TaREDO project manager Mary Lema said: "There is a wide range of benefits for individuals who use the EPCs but also national benefits if there is sustained use and adaption of the EPCs by majority."

Jensen Shuma from TaTEDO said: "Despite the recognised benefits of modern energy cooking services for health, local environment and climate change, large-scale adoption and sustained use of clean cooking solutions such as highly efficient electric pressure cooker and other clean cooking solutions is not succeeding.

"This is due to a variety of context specific barriers both on the demand and supply side. Among the challenges includes; poor enabling environment such as inadequate supportive policies that favours incentives for ing solutions as priority during preparations and im-

electricity cooking appliances."

He mentioned other challenges as lack of information on the availability of the clean cooking solutions and poor affordability, practicing cooking culture which are resistant to new changes, as some are embedded and linked into cooking habits, traditions, cultural appropriateness of the device, and perceptions about the taste of food.

The stakeholders recommended that on the basis of the potential and wide benefits associated with cooking with EPCs, the government should increase its commitment, lead the efforts and put clean cook-

plementation of its progressive policies and strategies which will ensure significant budget allocation to promote, advocate and create awareness on the uses of clean cooking solutions.

There should be collaborative efforts among stakeholders in promoting and creating awareness on the use of highly efficient EPCs in areas with access to reliable electricity. Waive and provide tax incentives and other legal requirements. Reduce import duty tariffs and value added taxes (VAT) to EPCs as it is applied to LPGs and solar equipment, this can promote and facilitate massive influx and supply of the appliance as to make them affordable to majority of the end users. En-

sure that only the best quality and highly efficient appliances are certified and imported by strengthen and enforcing bylaws through Tanzania Bureau of standards (TBS) and fair competition Commission (FCC) and the government should encourage the energy service providers which includes Tanzania Electric Supply Company Limited (TANESCO), Rural Energy Agency (REA) and mini-grid developers to prioritize delivering cooking services to their customers.

"This can be through developing on-bill financing mechanisms that can enable customers to repay the high upfront cost of the appliance each time they top up their electricity units. A subsidy mechanism can also be adapted to enable many connected customers to access EPCs," he said.

In her response, representative from the Ministry of Energy, Joyce Msangi said that the ministry has been creating enabling environment including providing necessary support and awareness creation to the general public on clean cooking energies.

"The government has taken several initiatives aimed at supporting clean energy. We are working on clean cooking energy sub-sector. We have National Energy Policy of 2015 which recognise the importance of clean cooking energy for economic and social development of the country.

Program Manager responsible for Energy from the European Union Massimiliano Pedretti said private-public partnership is crucial for enhancing development of lean cooking energy in the country

# African youth's China perception improves amid blossoming ties

ELIAS Gebreselassie grew up in Addis Ababa, Ethiopia, and he, like his peers, has long thought that skyscrapers, shopping malls and highways could only be scenes in Hollywood movies.

The 34-year-old Ellas Gebreselassie praised China's investment in modern infrastructure such as roads and social facilities, which made the capital a charming international metropolis and the headquarters of the African Union.

Gebreselassie said his understanding of China has been greatly improved after witnessing its contribution to Africa's socio-economic development through the construction of industrial parks, skyscrapers and electrified railway lines.

"This has inspired Ethiopian youths to know more about China and the Chinese people. Many young people, including one of my nieces, choose to study in China, and many others prefer to go to Ethiopian universities to study Chinese through Confucius Institutes," Gebreselassie said during a recent interview.

He said that the Kung Fu movies he had watched as a child gave him first exposure to the Chinese culture. His understanding of China has been further enriched through the east Asian country's technological prowess and rapid economic development.

"Recently, an increasing number of young Ethiopians have also gained a better understanding of China and the Chinese lifestyle through social media platforms such as TikTok," in addition to old movies, said Worku, another young Ethiopian.

According to the survey results released in November 2020 by Afrobarometer, a non-partisan research network, about 60 percent of young respondents aged 18 to 35 from 18 African countries think that China's economic and political influence on the African continent is "somewhat positive" or "very positive."

William Douglas, a 21-year-old young Tanzanian, said that household appliances, building materials and machinery made in China are popular among local customers due to high quality and reasonable prices.

"In Tanzania, mobile phone brands like Huawei and Oppo are very popular," said Douglas.

"We watched many Chinese movies and TV series through the cable network," said Nurdin, a 25-year-old man, adding that his affinity to the Chinese culture has grown over the years thanks to thriving people-to-

Ibrahima Diao, a student at Cheikh Anta Diop University of Dakar in Senegal, believes that young Senegalese now know much more about Chinese culture than they did a few years ago, noting that the two countries have seen robust cooperation.

Abdou Seck, Diao's schoolmate, said that China has provided his home country with tangible support to spur development.

According to the World Population Prospects 2019: Highlights by the Population Division of the United Nations Department of

Economic and Social Affairs, in sub-Saharan Africa, 62 percent of the population is below age 25 in 2019.

African youths have injected vitality into cultural and economic ties with China, through learning the Chinese language and embracing smart phones from China to power digital revolution in their native countries.

In Cameroon, a university student surnamed Oumar, said that Chinese smart phone brands have gained popularity with the central African nation's youths at a time when digital commerce and remote learning has become the norm.

"Young Africans are slowly but surely developing a lot of interest in China unlike before. They are particularly impressed by infrastructure development brought by China to many African countries," said Ndiye Kidet, an electronics student at the Botswana Accountancy College.

Kidet said that African youths have disregarded the false narrative that China's kindness towards the continent was based on ulterior motives, adding that China has proved a reliable partner in Africa's quest for dignity and self-reliance.

A survey conducted in Gaborone, Botswana early this year indicated that the country's youths were appreciative of China's benevolence towards Africa, and requested loans from China to support start-ups in agriculture, arts, sports and manufacturing sectors.

Clifford Mboya, a Kenyan researcher who majored in international politics at Fudan University in Shanghai, China said that his life in China was very interesting, and unique in some ways.

Mboya said it was quite eye-opening to live in China and the country has its own challenges just like any other country in the world. "I think it is one country that is focused on achieving its goals. And I like the way they pursue their dreams and their projects in an efficient way."

Mboya recalled that most of the reports on the media about China were negative before he went to China.

"But, you know, I was impressed by what I saw, because it's not any different from here, it's just that they have their own political system, their work ethic ... the culture is different. But once you come to understand how things work there, you begin to appreciate their culture and their way of doing things," he added.

# India under siege from Covid-19: The worst yet to come

HE Coronavirus infections and deaths in India recorded a daily high on Monday, 10 May, with 366,161 new infections and 3,754 deaths as reported by the Indian health ministry, taking India's total tally to 22.66 million with 246,116 deaths. Experts have raised a flag stating India's actual figures could be far higher than what is currently being reported.

The rise in case numbers have been exponential in the second wave, and has been widely attributed to the B.1.1.7 variant, which was first identified in the U.K. and also a homegrown variant, called B.1.617, with double mutations.

The World Health Organization has classified the B.1.617 variant as a variant of global concern, with some preliminary studies showing it spreads more easily.

Reopening of public places, crowded election rallies and big religious gatherings are being blamed for the uptick.

The national vice-president of the Indian Medical Association (IMA) Dr Navjot Dahiya called Prime Minister Narendra Modi a 'super spreader' and blamed him for the second wave of COVID-19. In his interview given to an English Daily, Dr Dahiya said, "while the medical fraternity is trying hard to make people understand mandatory covid norms, PM Modi did not hesitate to address the big political rallies tossing all Covid norms in the air."

While the rallies were later converted to 'virtual rallies', people were still being called to watch and attend those virtual rallies in large gatherings.

India, which is one of the largest economies in the world, spends only 1 % of its GDP on its healthcare, making it even more difficult for public health systems to survive the burden of this pandemic.

What's worse is at a time when the government should have focused all its time, energy and effort in managing and organising a pandemic response, Prime Minister Modi chose to prioritise elections.

The government turned away, ignoring all the helpless citizens who died on the streets, outside hospitals, in makeshift ambulances and homes, gasping for oxygen, medicine or any form of medical help.

# **CAG counsels NAOT auditors to** regularly update knowledge, skills

UDITORS in the country have been challenged to regularly undergo short training to align their knowledge and skills with the latest standards prevailing globally.

Controller and Auditor General, Charles Kichere said in Dar es Salaam this week while opening Diploma in International Financial Reporting (DipIFR) training for 20 auditors from his office that auditing is a profession that is regular growing by welcoming new standards.

In a speech read on his behalf by NAOT's Director of Administration and Human Resources Management, Novati Mfalamagoha, the CAG urged the participants to concentrate on what the experts will be imparting to them during the training.

"The five weeks training is designed specifically for the NAOT auditors to provide a comprehensive understanding of the International Financial Reporting Standards (IFRS)," he said while emphasising that there is need to observe high level of commitment during the training to ensure that both technical and practical knowledge shared by facilitators on DipIFRS is absorbed.

Mfalamagoha said apart from passing an international examination that the NAOT auditors will have to sit at the end of the course before being awarded the Diplomas, it is equally important for them to be able to apply the knowledge

In remarks at the opening ceremony, Head of Association of Chartered Certified Accountants (ACCA) in Tanzania, Jenard Lazaro told the participants that qualifications that will be gained from the course will enable them to develop knowledge and skills to understand details of IFRS hence put them into practice as well as the concepts and principles which underpin

"It should be noted that ACCA works very closely with NAOT on public finance management and through this initiative, the organization's capability is being transformed," said Lazaro who backed Mfalamagoha's observations that the 20 NAOT candidates have an opportunity to become globally acceptable.

# Kenya plans to set up emissions trading system

#### NAIROBI

Kenya aims to set up an emissions trading system that will allow companies and other bodies to buy emissions allowances, the finance minister Ukur Yatani said on Tuesday, 11 May, as the country strives to limit the release of greenhouse gases.

Emissions trading is a pollution control mechanism where a central authority issues a limited number of permits for the release of specific greenhouse gases. Companies can then buy these permits and also trade them. Many countries are using a price on carbon to meet climate goals in the form of a tax or under an emissions trading or cap-and-trade plan where companies or countries face a carbon limit.

"The government is at an advanced stage in establishing the Kenya Emissions Trading System, allowing companies and organisations to buy Emission Allowance and thereby enable Kenya to meet her commitments in limiting greenhouse emissions," Yatani told an online conference of Kenyan and European officials. Yatani said the system would be managed

against buying cryptocurrencies on Thursday, urging enthusiasts to only "buy them if you're prepared to lose all your money." When Mr Bailey was asked by journalists whether the BoE was concerned about wild price swings in the cryptocurrency markets, he said: "I'm afraid they don't have intrinsic value."

"Now that doesn't mean to say that people don't put value on them because they can have extrinsic value. But they have no intrinsic value," Mr Bailey said. "So, I'm going to say this very bluntly again; buy them only if you're prepared to lose all your money. I'm afraid currency and crypto are two words that don't go together for me."

The BoE chief was speaking at the end of a press conference on the central bank's latest Monetary Policy Report, in which the lender

said it expected the UK economy to expand 7.25 per cent this year as the country eases out of the Covid-19 crisis.

The bank held interest rates at record lows on Thursday and kept the size of its stimulus programme unchanged, with Britain set to enjoy its strongest peacetime growth as Covid-19 restrictions ease.

Bitcoin and ethereum, the two biggest cryptocurrencies, surged to record highs earlier this year as institutional investors piled into the digital asset space and retailers flocked back. Meanwhile, Memebased virtual currency Dogecoin soared to an all-time high this week, extending its 2021 rally to become the fourth-biggest digital coin.

Dogecoin, launched as a satirical critique of 2013's cryptocurrency frenzy, has risen more than 14,000 per cent since December 31, taking it past more widelyused cryptocurrencies such as the Tether stablecoin and XRP to become the fourth-largest by market capitalisation. Mr Bailey has long been dismissive of the

He said while there been huge innovation in payments in recent years and that digital innovation is here to stay, existing digital currencies do not have a structure that will allow them to last. "Have we landed on what I would call the design, governance, and arrangements for what I might call a lasting digital currency," he asked the WEF panel. "No, I don't think we're there yet, honestly. I don't think cryptocurrencies as originally formulated are it."

Last month, the BoE said it would join forces with the UK Treasury to weigh the potential creation of its own central bank digital currency, joining authorities across the globe exploring the next big step in the future of money. If approved, the UK's digital currency would exist alongside cash and bank deposits, rather than replacing them, the central bank said.

JPMorgan Chase & Co., the largest US lender, already has about 30 to 40 investment bankers travelling daily, according to Jim Casey, the firm's co-head of global investment banking. It's another sign that big Wall Street firms are returning to their pre-pandemic ways as vaccination rates climb. industry, the Across dealmakers have a strong new

Nobody wants to cede an edge in winning lucrative and, at the moment, unusually abundant investment banking mandates, as corporate leaders prepare for Covid-19 to subside. JPMorgan's bankers are traveling within the US, which is ahead of major European and Asian countries in vaccinating the public. Its dealmakers aren't yet clocking as many trips as before the pandemic, but the numbers have been climbing, Casey said. ago, when all but the most essential travel stopped, many financial executives praised the potential of video conferencing to make pitching deals faster and cheaper than flying. # African e-commerce firm Jumia cuts Q1 losses

LAGOS

African e-commerce firm Jumia Technologies AG said on Tuesday that cost discipline and "selective" usage growth helped it cut first-quarter losses for the fifth consecutive quarter.

Jumia's chief executive, Sacha Poignonnec, said the 24% narrowing in losses was evidence that its path to profitability was on track. Jumia, the first Africa-focused tech startup to list on the New York Stock Exchange, aims to sell fewer expensive one-off products such as electronics and more inexpensive, frequently ordered items such as beauty and cleaning supplies.

The adjusted loss before interest, tax, depreciation and amortisation narrowed to 27 million euros (\$32.85 million), compared with a loss of 35.6 million in the first quarter of 2020. Average order value slid 16% to 24.9 euros.

"All the work that we have done is paying off and we are in a very good position to accelerate the growth," Poignonnec told Reuters. Jumia shares were down 5.1% at \$22.27 in late morning in New York, well below the all-time peak of \$65.51 hit on Feb. 10.

The shares have gyrated dramatically since listing at \$14.50 on April 26, 2019. They rose shortly after listing to \$49.77 but later plunged close to \$2 a share after a negative short-seller report. Poignonnec brushed off the volatility and said the long-term strategy would keep investors happy.

Jumia has raised more than \$570 million over the past six months, which Poignonnec said would be used for gradual investments in core businesses, including improving payment platform JumiaPay and other technology platforms and expanding in existing markets. Jumia warned that the Covid-19 pandemic could hit consumer confidence and spending power.

While the pandemic boosted business for e-retailers in other regions, such as Amazon.com Inc and Alibaba, Jumia's revenue fell due to 2020 lockdowns. It warned that renewed curfews and lockdowns in countries including Morocco and Kenya created disruptions, especially for food delivery business.

# Mobile lender Branch to buy Sh230m microfinance majority stake

#### NAIROBI

US-based digital lender Branch International will pay Sh230 million for a majority stake in a local microfinance bank, amid proposed tough regulations for mobile lenders in Kenyan market.

The San Fransisco Californiaheadquartered fintech with offices in Lagos, Mumbai, and Nairobi has received regulatory nod to acquire a 84.89 percent stake in Century Microfinance Bank. Competition Authority of Kenya (CAK) has already cleared Branch for the deal that will give it control in the deposit-taking microfinance institution that was licensed in September 2012 with focus on agricultural finance.

"The acquirer and the target will each maintain the terms agreed with the borrowers in respect of all loans existing in their loan books at the time of the acquisition," said Wang'ombe Kariuki, CAK director general.

The deal comes on the back of Central Bank of Kenya (Amendment) Bill of 2021 that

Like it or not, humans use appearance to predict behaviour. We want the people who serve our food to look clean, the people who work on our health to look competent, and the people who look after our money to look



trustworthy. For most this starts with taking some basic care of your appearance. Reading the room wrong, in terms of the wrong appearance has the potential to cost business.

Of late, we have witnessed major global and local corporates relax their dress code rules urging employees to use 'good judgment' in their dressing and fashion choices. # **Africans urged** to trade more with each other

#### **ADDIS ABABA**

African countries continue to trade more with the outside world than among themselves, according to findings of the UN Economic Commission for Africa (ECA) assessment report on progress made on regional integration in the context of the Covid-19 pandemic.

The report was presented during the 39th ECA Committee of Experts of the Conference of African Ministers of Finance, Planning and Economic Development in Addis Ababa, Ethiopia. The European Union, the report says, is taking the largest share of the market, accounting for 29.8% of total trade in 2018. The trend is, however, changing following Brexit and also due to increasing trade between China and Africa.

Stephen Karingi, the director of the Regional Integration and Trade Division at the ECA, while presenting the report findings, said Covid-19 had severely disrupted the implementation of regional integration initiatives, including the African Continental Free Trade Area (AfCFTA), particularly trade through national border closures.

Importance of digitalisation

"Implementation of regional integration continues to be hampered by governance, peace and security challenges," said Karingi, adding: "Digitalisation is key in maintaining trade competitiveness and enabling effective participation in cross border e-commerce."

The report shows that in 2018, Africa accounted for only 2.6% of global trade, which is a slight increase from 0.2% from 2017. Intra-African trade increased to 16.1% in 2018 (\$159.1bn), up from 15.5% in 2017. Globally, output slightly decreased to 3.6% in 2018 from 3.8% in 2017.

While progress continues to be made in pursuit of the continent's regional integration agenda throughout the eight regional economic communities (RECs), challenges to the achievement of deeper integration remained. In particular, most RECs and member states are struggling to achieve progress in the area of productive integration. Karingi noted that before the Covid-19 pandemic there was a rise in intra-trade in Africa, but compared to other regions, it remained low.

Key pillars of regional integration

"Trade, economic movement of people and services, infrastructure, governance, peace and security are the key pillars of regional integration," he noted, adding that many countries were doing a lot to implement the AfCFTA.

Karingi said peace and security "create environments conducive to the pursuit of regional integration and the attainment of broader continental development objectives", noting that progress on integration was uneven, adding the free movement of people was critical for the realisation of the AfCFTA.

The report presents an assessment of progress on regional integration in Africa with a particular focus on progress made by RECs in key dimensions of regional integration, including macroeconomic integration;

shareholders. They do this through various forms of corporate social responsibility, based on the idea that businesses should "strive to make a profit, obey the law, be ethical and be a good corporate citizen."

The benefits of corporate social responsibility practices for businesses include enhanced reputation, legitimacy and customer loyalty. But these practices are not just marketing to make businesses look good. They are also a way to develop markets and sustain business.

In particular, the empowerment of women through corporate social responsibility is now an established pillar of international development. Women are important to the economic and commercial development of emerging markets. They are also important stake-

holders in society.

In Nigeria, women are generally disadvantaged in health provision and employment. For example, the maternal mortality rate is 576 per 100,000 live births, the fourth highest in the world. Women are also marginalised in the labour force. Their unemployment rate rose from 25.9% in 2018 to 31% in 2020. All these challenges limit their inclusion in financial and economic activities.

In our research as marketing academics, we explored the way banks

in Nigeria try to empower women to participate in financial and commercial activities. We were interested in the guiding principles that shape the banks' corporate social responsibility activities; how these activities empower women; and which groups of women they reach.

We found that Nigerian banks appreciated the significant role that women played in the development of society and as a powerful catalyst for change. However, they could do more and they could communicate their ef-

forts more effectively.

We analysed 15 Nigerian banks' annual corporate social responsibility and sustainability reports. We wanted to know how they used these to empower women. These reports are regulatory documents produced by companies and can be considered a true reflection of the banks' activities. Of the 22 commercial banks active in Nigeria, according to the Central Bank of Nigeria, only 15 had a form of corporate social responsibility report that was available for the research.

In all the RECs, Karingi said, productive integration was their poorest performing dimension of regional integration. "Most of the communities are lagging in terms of intra-regional intermediate exports and imports, and are recording a very low merchandise trade complementarity index," he said, adding that productive integration was central to enhancing industrialisation and trade. "Productive integration is also critical to integrating African economies into regional value chains and global value chains, as envisioned in Agenda 2063."

#### AMU and EAC taking the lead

According to the report, the Arab Maghreb Union (AMU) and East African Community (EAC) are taking the lead in productive integration, with index scores of 0.449 and 0.434, respectively, while Ecowas is the least integrated regional bloc in the productive integration dimension, with an index score of 0.220.

Despite the low performance of the majority of the RECs on productive integration, there were several initiatives being carried out to improve the situation, including some that are supported by ECA. Economic Community of Central African States (ECCAS) and EAC are the highest-performing communities in terms of macroeconomic integration, with scores of 0.684 and 0.660, respectively, on the index.

# Google enters global remittance market after tie-up with Western Union and Wise

#### **NEW YORK**

Mobile wallet platform Google Pay tied up with money transfer companies Wise and Western Union to allow its US-based users to remit money to India and Singapore, marking the tech company's first foray in the multibillion-dollar global remittance market.

The new service integrates the platforms of London-based Wise (formerly known as TransferWise) and Western Union, the world's largest money transfer service, into the Google Play app. Users can choose between the two platforms to send

money to Google's e-wallet users in India and Singapore, Google Pay said in a blog post on Tuesday.

"For some, sending money back to their home countries is a regular activity and we are making it more accessible by adding it to the app that you use for your everyday money tasks," the blog's author, Viola Gauci, product manager at Google Pay, said. "We're now able to give those with family abroad a simple, safe and reliable way to send money abroad."

In October, the World Bank said remittances would fall 14 per cent by the end of 2021 compared with

Washington-based lender projected global remittances would decline 7 per cent to \$508 billion in 2020 and 7.5 per cent to \$470bn in 2021.

The mobile wallet industry is set to become a \$2.4 trillion industry this year, growing 24 per cent yearon-year, according to a report by finance and investment company Finaria. This trend is forecast to continue, with the market estimated to reach \$3.5tn by 2023, the report added.

The social media firm also launched Facebook Pay, which allows users to securely send payments to others. Ride-hailing company Uber launched a new division called Uber Money, which includes a digital wallet and upgraded debit and credit cards.

# **Death toll rises in Gaza**, **Israel in most intense** hostilities in years

strikes in Gaza yesterday and Palestinian militants fired multiple rocket barrages at Tel Aviv and the southern city of Beersheba in the region's most intense hostilities in years.

At least 43 people have been killed in Gaza since violence escalated on Monday, according to the enclave's health ministry. Six people have been killed in Israel, medical officials said.

Gaza's health ministry said that of the people reported dead in the enclave, 13 were children. The Israeli military said it was looking into these reports and that preventing civilian casualties was a priority.

In Gaza, a multi-story residential building collapsed after Israel warned its occupants in advance to evacuate, and another was heavily damaged, after they were hit in the air strikes.

Israel said its warplanes had targeted and killed several Hamas intelligence leaders early on Wednesday. Other strikes hit what the military said were rocket launch sites, Hamas offices and the homes of Hamas leaders.

Israel and Hamas since a 2014 war in missiles streaked into the sky.

ISRAEL carried out hundreds of air Gaza, and prompted international concern that the situation could spiral out of control.

"Israel has gone crazy," said one man on a Gaza street, where people ran out of their homes as explosions rocked the city.

Many Israelis also spent a sleepless night, with sirens sounding at 3 am in Tel Aviv, heralding several waves of rocket strikes in Israel's heartland.

"The children have escaped the coronavirus, and now a new trauma," one Israeli woman in the coastal city of Ashkelon said on Channel 11 television.

UN Middle East peace envoy Tor Wennesland said the United Nations was working with all sides to restore calm. Egypt made calls overnight to Palestinian leaders to urge restraint, Egyptian security sources said.

Gazans' homes shook and the sky lit up from Israeli attacks, outgoing rockets and Israeli air defense missiles.

Israelis ran for shelters or flattened themselves on pavements in communities more than 70 kilometers up the coast and into southern Israel amid It was the heaviest offensive between sounds of explosions as interceptor

An Israeli was killed on Wednesday by an anti-tank missile fired from Gaza at a vehicle near the border, Israel's national ambulance service said. Two people were killed by a rocket that hit their car in Lod, near Tel Aviv. Israeli media reported one was a 7-year-old girl.

Lod and other mixed towns have been gripped by angry demonstrations over the Gaza violence and tensions in Jerusalem.

In Gaza, 11 people were killed in Israeli strikes on Wednesday, the health ministry said.

#### New challenge

Hamas' armed wing said it fired 210 rockets towards Beersheba and Tel Aviv in response to the bombing of the tower buildings in Gaza City. Israel's military says that around a third of the rockets have fallen short, landing within Gaza.

For Israel, the militants' targeting of Tel Aviv, its commercial capital,

posed a new challenge in the confrontation with the Islamist Hamas group, regarded as a terrorist organization by Israel and the United States.

The violence followed weeks of tension in Jerusalem during the Muslim fasting month of Ramadan, with clashes between Israeli police and Palestinian protesters in and around Al-Aqsa Mosque, on the compound revered by Jews as Temple Mount and by Muslims as the Noble Sanctuary.

These escalated in recent days ahead of a - now postponed - court hearing in a case that could end with Palestinian families evicted from East Jerusalem homes claimed by Jewish settlers.

Violence has also flared in the occupied West Bank. Medical sources said a 16-year-old Palestinian was killed in clashes with Israeli forces vesterday.

The march participants carrying the portraits of their relatives who had fought during World War Two gathered near the main building of the Beijing Exhibition at 09:30 local time (04:30 Moscow time). There were not only Russian citizens but also representatives of China, CIS and other states among the participants.

"The Chinese side treats this action [the Immortal Regiment march] very well and considers it as an element of our common victory over fascism and the Japanese militarism," Minister-Counsellor of the Russian Embassy in China Dmitry Lukyantsev told reporters.

"This year, Chinese citizens are also taking part in the march, which is really very good," he added.

The Immortal Regiment march is an annual public event held in Russia and other countries to commemorate those who fought or died during the Soviet Union's 1941-1945 Great Patriotic War against Nazi Germany.

#### CPC wins overwhelming trust among Chinese people, says former Lao deputy PM

THE Communist Party of China (CPC) has won 'the Chinese people's overwhelming trust" and always put the people's interests first, former Lao Deputy Prime Minister Somsavat Lengsavad has said.

On the centenary of the CPC's founding, Somsavat (pictured), a former politburo member of the Central Committee of the Lao People's Revolutionary Party (LPRP), expressed confidence that the CPC will "stay true to its founding mission and remember its original aspiration and mission."

"In the early days of Wuhan's fight against the COVID-19 epidemic, this metropolis with a population of 10 million swiftly calmed down, when every people strictly followed the requirements of self-isolation at home," Somsavat told Chinese media in a recent interview.

# Inquiry: British Army killed innocent civilians in Belfast in 1971

#### BELFAST

BRITISH soldiers unjustifiably shot or used disproportionate force in the deaths of nine of the 10 innocent people killed in a 1971 incident in Belfast that sparked an upsurge of violence during Northern Ireland's "Troubles," a judgeled inquiry found.

A Catholic priest and a mother of eight who served soldiers tea were among the victims in an event Irish Foreign Minister Simon Coveney described on Tuesday as "one of the most tragic days" of Northern Ireland's three decades of bloodshed

Judge Siobhan Keegan delivered

her findings to applause from families of the victims shortly after the British government announced it would introduce legislation to give greater protection to former soldiers who served in Northern Ireland, plans Dublin and many in Belfast fiercely oppose.

"All of the deceased were entirely innocent of any wrongdoing on the day in question," Keegan, the coroner for the case, concluded.

The British government's minister for Northern Ireland Brandon Lewis said he would carefully consider the findings, but it was clear that those who died were "entirely innocent of wrongdoing."

The victims' grief has been "com-

process of waiting for answers for so many years," Lewis said in a statement.

According to China's Customs Office data, Russia ranked second after Saudi Arabia in terms of oil supplies to China 2020.

#### French lawmakers approve virus 'health pass' at second attempt

#### PARIS

FRANCE'S National Assembly approved on Wednesday the creation of a COVID-19 "health pass" that people can use to attend sports events, festivals and theme parks with large crowds, a hotly contested government measure to help safely re-open the economy.

The health pass, which will come into effect from June 9, will provide proof that a person has either been vaccinated against the coronavirus, holds a recent negative PCR test, or is recovering from COVID-19 and therefore has natural antibodies.

The proposal was initially shot down in the lower house on Tuesday evening over fears it would impinge on civil freedoms, a rare defeat for President Emmanuel Macron's ruling party, after centrist MoDem allies rebelled.

The health pass was approved on a second vote in the early hours of Wednesday after the government shortened the transition period during which it will be able to re-impose restrictions such as a curfew without the permission of parliament once France's state of emergency is lifted on June 2.

Macron has said the health pass, which can be digital or paper-based, will curb the spread of the virus at events with crowds of more than 1,000 people. It will not be used for every day venues such as restaurants and cinemas or for access to public transport.

# **Oxygen shortage hits India as 2nd wave of COVID-19 rages**

#### **NEW DELHI**

AT least 11 COVID-19 patients died on Monday evening in a hospital in the southeastern Indian state of Andhra Pradesh due to oxygen shortages, local media reported on Tuesday.

Sadly, this was just one of the many tragedies the South Asian country has witnessed in recent weeks following an oxygen supply breakdown amid the second wave of the pandemic nationwide.

While families and friends of the dead grieved for their beloved ones, they also raged against governments and hospital administrations over oxygen shortages amid a pandemic-induced chaotic mess, prompting them to take immediate actions to turn the tables.

On Wednesday, India's COVID-19 tally rose to 22,992,517 and the total death toll reached 249,992. Since the second wave, a number of incidents have unfolded across Indian hospitals in wake of the shortage of essential medical supplies, especially oxygen.

On April 23, at least 26 COVID-19 patients died at a hospital in New Delhi when the oxygen supply in its intensive care units ran out completely.Seven days later, six more died at night due to oxygen shortages in a hospital in Gurugram, a city southwest of New Delhi. "We came to the hospital thinking doctors are there to take care of our loved ones. But then we are told oxygen is not available," said Amritha, an attendant.

"Whose responsibility is it to provide the oxygen and who should we blame for the deaths that are taking place simply because hospitals are not having facilities?"

The tragedy happened again on the afternoon of May 1, as at least 12 died due to lack of medical oxygen at Batra Hospital & Medical Research Center in the capital city, including Dr. R K Himthani, the hospital's head of the gastroenterology unit.

"Rest in peace Dr. R K Himthani. We lost a cheerful and smiling face today, not because of the virus but due to lack of oxygen," Himthani's colleague Dr. Tushar Mehta wrote on social media.Experts said the bottlenecks of India's oxygen supply lie in transportation and storage.

While most oxygen producers are in eastern India, the soaring demand comes mainly from western, central and northern regions. Besides, there is a shortage of cryogenic tankers, which are necessary to transport liquid oxygen at very low temperatures to distributors. Also, many Indian hospitals do not have on-site plants to store oxygen.

In many hospitals, infected patients have to share beds or lay down on the floor in wards and corridors. And there are even more who have to lie down on stretchers or inside their own vehicles outside hospi-

tals, gasping for breath.Experts said doctors and paramedical staff have to take tougher decisions on who among the patients should get oxygen and who should be left out.

"The situation is really bad. We are being trained to save each and everyone without any distinction, but in the ongoing pandemic, when the hospitals are inundated and facilities are scarce, we are forced to make tough decisions," said a doctor pleading anonymity. "It is really hard, for after all we too are humans."

As oxygen shortages are hitting hospitals, attendants have been asked to get oxygen for their beloved ones on their own. As a result, social media platforms have been flooded with requests by desperate families hunting for oxygen cylinders and refills.

This has in turn stoked up a thriving unregulated black market for cylinders and concentrators, which are sold much above their usual retail prices.Reports said an oxygen cylinder which would normally cost 82-137 U.S. dollars is now sold 10 times the price, and not many people can afford it. Besides, police have arrested a few for resorting to the black market.

"It is a chaotic situation all around. Who would have thought that people would have to carry oxygen cylinders for their ailing family members?" said Ashish Vardhan, a volunteer helping people to access oxygen cylinders and hospital beds.

"This massive shortage could have been avoided had the government planned things in advance and not ignored the expert opinions about the outbreak of the second CO-

VID-19 wave."

Volunteers of the Sikh community have set up makeshift facilities in and around New Delhi to provide free oxygen to COVID-19 patients, and also a temporary hospital with 250 beds.

"People are crying saying they have lost three family members, the fourth is dying, please help with oxygen and a bed," said Manjinder Singh Sirsa, president of the Delhi Gurdwara Management Committee.

"I think, on this earth, you would never have seen this situation where people are dying and we are forced to give oxygen, or a miracle assistance."

"As hospitals are inundated and people are being turned away, so they come to us as a last resort and we provide them oxygen here," said Jasmeer Singh, a Sikh volunteer. "We too are facing storages and have to manage things with our limited stocks."

The oxygen shortages have brought states face to face with the federal government over their quota. Last week, Allahabad High Court in the northern Indian state of Uttar Pradesh said the death of CO-VID-19 patients out of oxygen shortages in the cities of Lucknow and Meerut is a criminal act, "not less than a genocide" at the hands of authorities entrusted with the task to ensure the oxygen supply chain is maintained.

#### **Colonial Pipeline hack exposes lack** of federal cybersecurity oversight for US energy industry, says media

#### WASHINGTON

THE ransomware attack on Colonial Pipeline Co. has hit a U.S. industry that largely lacks federal cybersecurity oversight, leading to uneven digital defenses against such hacks, reported The Wall Street Journal on Tuesday. The temporary shutdown of Colonial's pipeline, the country's largest conduit for gasoline and diesel to the East Coast, follows warnings by U.S. officials in recent months of the danger of cyberattacks against privately held infrastructure. It also highlights the need for additional protections to help shield the oil-and-gas companies that power much of the country's economic activity, cyber experts and lawmakers were quoted as saying. "The pipeline sector is a bit of the Wild West," said John Cusimano, vice president of cybersecurity at ae-Solutions, a consulting firm that works with energy companies and other industrial firms on cybersecurity.

Iran's former hardline president Ahmadinejad to run again

IRAN'S hardline former president Mahmoud Ahmadinejad yesterday registered to run again in an election in June which is being seen as a test of the legitimacy of the country's clerical rulers.

Vilified in the West for his questioning of the Holocaust, Ahmadinejad (pictured) had to step down in 2013 because of term limit rules, when incumbent President Hassan Rouhani, who negotiated Iran's 2015

nuclear deal with world powers, won in a landslide.

"People should be involved in Iran's decision-making process... We must all prepare ourselves for fundamental reform," state TV quoted Ahmadinejad as saying after submitting his registration.

Candidates began signing up for the polls on Tuesday with the clerical rulers hoping for a high turnout which may be hit by rising discontent over an economy crippled by US sanctions reimposed after Washington exited the nuclear deal three years ago.

Registration will end on Saturday, after which entrants will be screened for their political and Islamic qualifications by a 12-member vetting body, the Guardian Council. Six members of the hardline body are appointed by Supreme Leader Avatollah Ali Khamenei.

A rift developed between the Ayatollah and Ahmadinejad after then-president Ahmadinejad explicitly advocated checks on the Ayatollah's ultimate authority. Ahmadinejad was disqualified by the Guardian Council in the 2017 presidential election.

In an open letter to the Ayatollah in 2018, Ahmadinejad called for "fundamental reforms" in the three branches of government - executive, parliament and judiciary - as well as the office of the Supreme Leader.

A former officer of the Guards, who has tried to rebrand himself as a moderate politician by criticizing the clerical establishment, Ahmadinejad relies on Iran's devout poor and working class who have grown impatient with the mounting economic pressure.

However, his popularity remains in question and hardline political groups are expected to back prominent cleric and judiciary chief Ebrahim Raisi if he decides to run.

Rouhani cannot seek re-election under Iran's constitution.

Several hardline candidates, including some IRGC commanders, have said they would withdraw if Raisi enters the race to avoid splitting the vote.

Appointed by the supreme leader as head of the judiciary, Raisi has emerged as one of Iran's most powerful figures and a contender to succeed Khamenei.

But many don't take basic precautions such as encrypting data or conducting dry runs of attacks, said Andy Lee, who chairs the firm's privacy and security team.

"The overconfidence issue is a serious phenomenon," Lee said.

Electric utilities are governed by rules enforced by the North American Electric Reliability Corp., a nonprofit that reviews companies' security measures and has the power to impose million-dollar fines if they don't meet standards.

There is no such regulatory body enforcing standards for oil-and-gas companies, said Tobias Whitney, vice president of energy security solutions at Fortress Information Security, a company that helps energy firms vet business partners for cyber readiness.

"There aren't any million-dollar-a-day potential fines associated with oil-and-gas infrastructure at this point," he said. "There's no annual audit."

Colonial Pipeline said on Friday that it proactively shut down its 5,500-mile pipeline, which stretches from the Gulf Coast to New Jersey, after a ransomware attack on its computer networks. The company said on Monday that the hack affected only its information technology, rather than control systems used to run the pipeline, and that it aims to restore substantial service by week's end.

Lawmakers from both parties said the incident reinforces the need to create new legal obligations for protecting critical infrastructure.

The Energy Department also will launch a 100-day "sprint" to improve pipeline security.

# Busquets: Barca's La Liga hopes 'practically over'

#### BARCELONA

SERGIO Busquets conceded that Barcelona's hopes of winning La Liga evaporated with Tuesday's 3-3 draw against Levante.

Barca led 2-0 and 3-2 in Valencia before conceding a late equaliser to leave their title hopes hanging by a thread after picking up just five points from their last four games.

In addition to winning their remaining two fixtures, Barca need Atletico to drop at least five points from their final three matches and Real Madrid to lose one or draw two of their last three games.

"We don't have much of a chance now," Busquets told Movistar after the final whistle at the Ciutat de Valencia stadium. "It will depend on our rivals, but this is our own fault, [bad] decisions, a lack of concentration. We concede goals too easily.

"We don't feel good because it was always going to be difficult, but we wanted to put pressure on those at the top. We had the lead, but as has happened this season, [Levante] scored goals too easily. The point doesn't mean much because that's the league practically over for us. We've dropped too many points to fight for the title."

Atletico can open a four-point lead over Barca with just two games to go if they beat Real Sociedad on Wednesday. Real Madrid, meanwhile, can move two points clear of the Blaugrana if they win at Granada on Thursday.

Barca's chances are further hindered by the fact both Atletico and Madrid have the superior head-tohead record against them, which is the determining factor should two teams finish level on points after 38 games.

The draw with Levante brought further questions about coach Ronald Koeman's future at the club.

Sources told ESPN earlier this week that there are doubts about the Dutchman's long-term suitability to the role, regardless of whether or not Barca go on to win the title to add to their Copa del Rey success earlier in the campaign.

However, a failure to claim top spot this season, given Barca had their fate in their own hands before the defeat to Granada on April 29, could accelerate calls for him to go.

"There are always questions about coaches, that won't change," Koeman said in a news conference when asked about his job prospects. "But after that second half, I understand there will be questions, of course.

Lionel Messi's 29th league goal of the season and Pedri had helped Barca into a two-goal half-time lead but quick-fire goals after the break from Gonzalo Melero and Jose Luis Morales drew the hosts level.

Ousmane Dembele restored Barca's lead in the 64th minute but a late goal from Sergio Leon earned Levante a point.

EP Guardiola always was likely to change the landscape of English football when he arrived at Manchester City in 2016, but five years on, the Spaniard and his players have ripped up the record books and the rulebook by becoming the dominant force in the Premier League, and their latest title triumph on Tuesday -- a third in four seasons -- confirms they belong in the

pantheon. This season's league title is the fifth in nine years for City, with two FA Cups and six EFL Cups also added to their roll of honour since the 2008 arrival of owner Sheikh Mansour bin Zayed al Nahyan. This time, they have been crowned champions while breaking the unwritten rules

of doing it -- lacking a 20goal striker and finishing on top after making the club's worst start to a season in more than a decade.

Everything usually needs to be perfect for a team to win a title, but City have done it by ticking only a few of the boxes that had long been regarded as crucial elements of a championship-winning team. Yet doing it this way is pure Guardiola. Why follow convention when you can do it better by proving to everyone that the old rules no longer apply?

If City win the Champions League for the first time when they face Chelsea in the final on May 29, the manner of their Premier League

title triumph will inevitably be overlooked because of their long wait

for European glory. But two European Cups be-

while this title success lacks the record-breaking feel of previous ones, it might ultimately prove to be the most significant because of where it puts Guardiola's side among the greats.

had already City carved out their own history by becoming the first, and only, Premier League champions to amass 100 points when winning the title in 2017-18. That season also saw them seal the title with the biggest winning margin -- 19 points -- eclipsing the 18-point gap achieved by Manchester

United in 1999-2000. A year later, Guardiola and his team achieved a domestic treble, becoming the first team in English football history to complete a clean sweep in one season, but this year's title is the one that seals City's status as a side that can now measure itself alongside the great Liverpool team of the 1970s and 1980s and Sir Alex Ferguson's United side of the 1990s and 2000s.

When it comes to those "boxes" that every champion must tick on their way to glory, City have covered most of them this time around. All title-winning teams

need an outstanding goalkeeper: Go back through the years and you won't find a champion with an error-prone No. 1, and City have arguably the world's best in Ederson. The Brazilian is on course to win the Golden Glove award for most clean sheets (he has 18 in the league so far this season), but he is much more than the guy who keeps the ball out of the net. His ability to turn defence into attack with his incredible distribution sets him apart from the rest, and there have been several occasions this season when a long, pinpoint clearance by Ederson has created a goal at the other end of

the pitch seconds later.

ponent of a title-winning side is a solid defence, marshalled by at least one commanding centre-half. ## FIFA president accused of masterminding European Super League by La Liga chief

#### MADRID

LA Liga president Javier Tebas has said he thinks FIFA president Gianni Infantino is behind the "failed" European Super League project.

Tebas claims that Infantino is referred to as "WO1" in the secret Super League documents he had access to.

"It's he who is behind the Super League and I already told him in person," Tebas said of Infantino on Tuesday. "I've said it before and I will say it again, behind all of this is FIFA president Gianni Infantino. He's pushing, saying things ...'

Infantino, who headed up UEFA from 2009 to 2016, announced his and FIFA's opposition to the breakaway project that was founded by 12 European clubs on April 18.

Six English teams, including Champions League finalists Manchester City and Chelsea, withdrew 48 hours later following fan pressure and UK government pressure.

Inter Milan, Atletico Madrid and AC Milan followed, but Real Madrid, Barcelona and Juventus have yet to withdraw.

The nine clubs that pulled out have been handed financial punishments by UEFA and have agreed to make a combined €15 million goodwill contribution to benefit youth and grassroots football across Europe.

UEFA said on Friday that the three clubs will face sanctions, and European soccer's ruling body has started disciplinary proceedings against them.

On Saturday, the three defiant clubs denounced "intolerable" pressure from UEFA to drop the project.



"The mistrust remains, due to this the minister will as soon as possible hold a meeting between the two parties," said part of the release.
