Samia wants Kigoma port revamped to spur growth

PRESIDENT Samia Suluhu Hassan yesterday directed authorities in Kigoma Region to prepare a map for the construction and rehabilitation of infrastructure including ports on Lake Tanganyika.

Addressing a public meeting during the end of her four-day tour of the region, she said she was not impressed with the infrastructure when visiting the port.

"Let me call upon the regional authorities to work on this as I work on supporting you

financially," she said, raising this initiative to spur growth in the western part of the country.

After launching various development projects, she said ports to be prioritized in the revamping are Kigoma, Kibirizi and Katosi.

The government intends to construct a new market for the region where small scale traders will do business in a conducive environment. The region has set aside 23 acres of land for hawkers to put up stalls for

'Take bigger role in next polio vaccination drive'

REGIONAL and district medical officers have been ordered to work closely with other stakeholders in the coming phase of the polio vaccination campaign to increase coverage rates in their areas.

Prof Abel Makubi (pictured), the Health ministry permanent secretary, issued this instruction yesterday when commissioning the polio emergency operations centre in the capital.

He expressed concern that three phases of the polio vaccination campaign saw several areas performing below the target. Administrative medical officers heighten their involvement in the next phase, he urged.

More than 17m children under five years



of age were inoculated, surpassing the international vaccination target of 85 per cent, he said.

The 176m/- polio services facility is a base for the coordination of emergency services, deploying of responders, identifying needed experts for each unique situation and developing strategies to stop the spread of the disease, he said.

The Global Polio Eradication Initiative (GPEI) and the Bill and Melinda Gates Foundation (BMGF) helped to finance the facility through the eHealth initiative, he

It will bring under one roof efforts to fight epidemic threats, he said, urging health sector partners to assist in establishing emergency operations centres in border regions especially.

Surveillance of epidemics is a sixth phase government priority in view of the threat from neighbouring countries, like the spread of Ebola, he stated.

Dr Zabulon Yoti, acting country representative for the World Health Organisation (WHO) commended government efforts in preventing polio, outbreak, satisfied with support by the

World Bank says Tanzania economy strong, loanable

Tanzania has visibly more sound economic management in comparison with many other countries in Sub-Saharan Africa, a high ranking coordinator of World Bank activities in Africa has declared.

Dr Taufila Nyamadzabo, managing director for the bank's Africa Group 1 constituency made this observation in talks with Finance and Planning minister Dr Mwigulu Nchemba.

They conferred on the sidelines of the annual meeting of the World Bank and the International Monetary Fund (IMF) in Washington DC, where he showered praise on the country's economic management and implementation of various IDA

emulated in supervising its economy, as despite the Covid-19 challenges and fallout from the Ukraine war Tanzania's economy was in a better shape at present.

He pledged further support from the development lender, assisting Tanzania to alleviate poverty by extending financial resources for various economic and social projects.

The minister assured the World Bank executive that the government was taking vital steps to ensure the economy grows and welfare improves for the population.

He explained that in the current financial year's first quarter, the economy grew by 5.4 per cent, from 5.0 per cent in the period a year earlier, intoning that grand plans put up by the government explain the upward trend.

Livestock registration nears end, cattle keepers facing fines, losses

LIVESTOCK branding and registration using electronic earrings is set to be closed at the end of the month, the Livestock and Fisheries ministry has said.

Prof Hezron Nonga (pictured), the director of livestock services, told a press conference yesterday that thereafter animal keepers who failed to meet the deadline will face fines and other measures

The 2010 Livestock Identification and Registration Act and the regulations made the following year require that unidentified livestock will not be taken to livestock auctions or abattoirs.

Alternatively, if otherwise transported, the violators will be liable to 2m/- fine,"



he said, underlining that livestock identification, registration and subsequent follow up is essential for the sector's growth.

As it is a legal requirement, every livestock keeper is required to have his livestock identified and registered, as the target is to identify and register 45.9m livestock.

Up to October 15, 4.1m cattle had been registered, just 10 per cent of the target, close to a year since the registration drive was launched, he said.

He alluded to numerous challenges explaining the low turnout, including the failure of local government authorities in allocating adequate funds for the exercise.

Herders were complaining over the 1,750/charge for cattle and donkey earrings and

PM disappointed over construction of Namtumbo district hospital pace

Minister Kassim Majaliwa yesterday expressed dissatisfaction with the progress of the construction of Namtumbo district hospital which he found does match the money invested in

...... Five years of violence in Mozambique has forced nearly a million to flee

NEARLY one million people have fled extreme violence perpetrated by non-State armed groups in northern Mozambique over the past five years, the UN refugee agency UNHCR reported yesterday.

As the conflict in Cabo Delgado province has not subsided, UNHCR is appealing for both an end to the bloodshed and greater international support for the displaced and local communities hosting them.

The situation has had a devastating impact on the population, Spokesperson Matthew Saltmarsh told journalists in Geneva.

"People have witnessed their loved ones being killed, beheaded, and raped, and their houses and other infrastructure burned to the ground," he said.

"Men and boys have also been forcibly enrolled in armed groups. Livelihoods have been lost, and education stalled while access to necessities such as food and healthcare has been hampered. Many people have been retraumatized after being forced to move multiple times to save their lives."

Meanwhile, the humanitarian situation has continued to deteriorate, with displacement figures increasing by 20 per cent, to over 946,000 in the first half of this

The violence has now spilled into the neighbouring province of Nampula, where four attacks were reported in September affecting at least 47,000 people and displacing 12,000.

"People displaced during those latest attacks told UNHCR that they are scared and hungry. They lack medicine and are living in crowded conditions - with four to five families sharing one house," said Mr. Saltmarsh.

"Some sleep under open skies. Lack of privacy and exposure to cold

at night and the elements during the day, create additional safety and health concerns, particularly for women and children."

UNHCR has been responding to the needs of displaced populations in Cabo Delgado, Nampula and Niassa provinces, through humanitarian assistance protection support.

Staff are providing shelter and household items, helping survivors of gender-based violence with legal, medical, and psycho-social support, and supporting displaced people to obtain legal documentation. UNHCR also supports those at higher risk, including children, people with disabilities, and older persons.

The agency requires \$36.7 million to deliver life-saving protection services and assistance in Mozambique but has so far received around 60 per cent of the funding.

Despite ongoing displacement in Cabo Delgado, some people have returned to their homes in areas they perceive as safe, said Saltmarsh.

Last month, UNHCR and partners conducted the first protection assessment mission to Palma, a town in the far north-east which saw deadly attacks in March 2021. Most of the 70,000 residents were displaced and the majority have returned in recent weeks.

"People who have lost everything are returning to areas where and humanitarian assistance are largely unavailable. UNHCR is concerned about the risks people face should they continue to return to their areas of origin before conditions are stabilized," said Saltmarsh.

While UNHCR is in favour of returns when they are voluntary, safe, informed and dignified, current security conditions in Cabo Delgado are too volatile for people to go back to the province.

Queen Maxima meets with farmers, representatives of ACRE Africa

QUEEN Maxima of the Netherlands has expressed her satisfaction with the way the Agriculture and Climate Risk Enterprise Ltd (ACRE Africa) in Tanzania has enabled farmers to get crop compensation due to the drought crisis through 'Bima Pima'.

Queen of the Netherlands said this yesterday while discussing with maize farmers at the Uduru Makoa Primary Cooperative Union in Hai District, Kilimanjaro region.

The visiting Queen, who appeared to ask many questions to the farmers, expressed her satisfaction with the way in which the farmers explained how to benefit from the insurance.

A mobilizing farmer, Cleopa Mushi who participated in motivating farmers to buy vouchers (insurance) to deal with the disasters of drought and lack of rain said that next season he and his fellow farmers have planned to buy more vouchers as they have seen the benefits.

"I have received an insurance payment of 120,000/-, I have seen the benefit of this project because the money was used on my phone during the preparation for another farming season. So it helped me because last small farmers is called 'Bima Pima', that withstand the challenges of the

season I did not get a good harvest so I would have to go sell other things so that I can start preparing the farm but ACRE Africa's payment for the farm has helped me a lot," said Mushi.

Another farmer Irene Ndenshao said that she bought one insurance voucher which is sold for 1,000/- for fear that she might be cheated so after the season ended the harvest was not

"I was surprised to see that I was being charged 12,000/- on my phone and I was very surprised because I had forgotten if I had taken out crop insurance so this season I plan to buy more vouchers," said Ndenshao.

Director of the Acre Africa company in Tanzania, Chrisofa Mzali said that they are implementing an insurance plan in this country starting in 2015 where they have started with Kilimanjaro and Arusha regions.

"Queen Maxima's visit here in Uduru ward was to learn about the crop insurance service we provide to maize farmers where we are managing similar projects in the districts of Siha in Kilimanjaro region and Arumeru in Arusha region," said Mzali and added.

it is insurance we provide through a voucher system which aims to introduce farmers to the insurance system where one voucher is sold for 1,000/-.'

"This protects investment costs of up to 12,000/- for one card, so if a farmer suffers a loss, he can be compensated up to 12,000/-, where the farmer can buy more than one voucher according to the cost he wants to protect in his farming."

Mzali said that they have started operating their activities in the country since 2015 where they have been using mobilizing farmers to educate them on the importance of the insurance that pays for disasters such as drought and heavy rains that damage crops.

"We have planned to provide insurance to one hundred thousand farmers for the next farming season and we will do so in seven regions in the country. In addition to corn, we will look at other crops such as sunflower, cotton, coffee, tobacco and other crops that face the challenge of climate change," said Mzali.

SeedCo Director of the East Africa region, Clive Mugadza said that they "The insurance we provide to are focused on producing seeds climate, thus enabling farmers to get more and better harvests.

"We advise farmers to join agricultural insurance because when disasters occur that may cause them not to get a harvest, including lack of rain, then they can get compensation, including being given a free bag of maize seeds for the next season," stressed Mugadza.

CRDB bank's Insurance Manager Wilson Mzava said that they are collaborating with the ACRE Africa institution and have prepared a very good agricultural insurance program that provides compensation to farmers when they are hit by disasters.

"The crop insurance offered by CRDB bank increases food security in the country and also increases the farmer's income security, so we advise many farmers to join this insurance," said Mzava.

One of the farmers informed Queen Maxima that they have seen great success through the insurance because it has enabled them to move from farming local seeds where they used to get four sacks of 100 kg each to one acre where they are now buying seeds from the SeedCo company which enables them to get an average of 25 sacks up to 40 per acre.

230bn/- to implement agricultural projects

THE government in collaboration with Alliance for a Green Revolution in Africa (AGRA) is looking for funding totaling \$100million (230bn/-) to implement agricultural projects in the country.

More Tanzanians, especially youths are to be empowered economically by the project, which upon completion would cover about 1,000 hectares.

The revelation was made here by the Minister of Agriculture, Hussein Bashe, here.

He was speaking during a joint working tour of various agricultural projects being implemented in Dodoma Region by the Minister and the President of AGRA Dr Agnes Kalibata.

Speaking on separate occasions after inspecting the projects in Chamwino and Dodoma districts respectively, both the Minister and the

AGRA president expressed their commitments to extending partnership in tandem with efforts to maintain a green revolution in the country which will make Tanzania in feeding herself and the continent at large.

According to Bashe, AGRA was now putting everything in place for the implementation of the next Five-Year Strategic Plan, that is why the latter's president had made an official visit to the country to have intensive discussions and consultations with the government of Tanzania on all possible areas of collaboration so as to help the country to meet its targets in the agricultural sector.

continue to grow fast hence there is a need to invest more in the sector.

"In the circumstances, we shall continue working together with various countries to ensure the sector is improved, especially in regard to modern water management technology as well as empowering our own experts," said Dr Tax.

Tanzanians encouraged to seize opportunities in govt's projects

PRIME Minister, Kassim Majaliwa has tasked Tanzanians to fully mobilise themselves and grab opportunities provided by various strategic projects implemented by the government.

Majaliwa made the remarks on Monday after inspecting the construction of Mwanza Main Bus stand at Nyegezi and the building of MV Mwanza ship.

Majaliwa is in three-day visit to inspect development projects in Mwanza Region.

He assured Tanzanians that no strategic project will get stuck as the government is fully mobilised by allocating adequate funds thereon, and called for their trust in the government.

The Nyegezi Bus Stand is expected to cost more than 15bn/- and upon completion at the end of this year, it will hold 120 large buses and 80 small vehicles.

The project, now 98 per cent complete will also be able to inject 2.5bn/- in revenue to Mwanza City Council coffers.

In regard to MV Mwanza "Hapa Kazi Tu," Majaliwa expressed his satisfaction with work progress and stressed on the contractor to finish its construction in time and to adhere to standards.

During his inspection of the vessel on May 7 this year, Majaliwa ordered the Immigration Department to seize passports of the officials of the shipbuilding contractor - Gas Entec Building Engineering for failing to abide by the contract's conditions.

Thereafter, it was discovered that Gas Entec Building Engineering had sold its shares to some other firms without the government's knowledge, and those who bought the said shares were later surprised to see ship building activities in progress, saying shipbuilding was beyond their capabilities.

Majaliwa said at that time the government had already paid 80

per cent of the construction cost but the work done was only at 55 per cent.

He said according to reports received there were only 118 workers, but later only 22 remained.

"We cannot pay all that money while the work was not progressing as it should. Suppose tomorrow these 22 will also be fired and firm officials travel to Nairobi and fly away to their countries?" he queried.

Works and Transport Deputy Minister, Eng Godfrey Kasekenya said the contractor returned on May 16 this year and continued with the project, and following Majaliwa's directives on May 7 2022, all workers who were suspended were reinstated.

He said as for now the project was 73 per cent complete and come November 30 this year, the ship will be launched into Lake Victoria at a cost of 108bn/-.

It will have the capacity to carry 1,200 passengers and 400 tonnes of cargo.

Kipanga was speaking yesterday when celebrating 60 years of the University of Dar es Salaam (UDSM)'s School of Education (SoED) themed "Ensuring equal access to quality education, a reflection of the university's support services to students with special needs.

He said that the government has been striving to ensure that equal and quality education is provided to every citizen in the country.

Citing an example of wavering school fees from primary to secondary government school, the decision increases great opportunities for students with special needs to enroll and get an education more than before when they couldn't afford it due to economic reasons, he said.

"This clearly shows that the education of students with special needs and the solution to their challenges in the education sector in general, is a priority of our government and we will make sure that they achieve their goals," he

He further noted that the government pays close attention to the right to education for all groups, including priority groups such as girls and people with special needs.

The government is currently implementing a five-year project funded by the World Bank which aims to make higher education an economic stimulus in our country, he said.

This project is going to touch higher education as its goal, but it will also touch students with special needs, support the improvement of infrastructures, the availability of modern equipment for students with special needs and the training of employees, he noted.

"I congratulate the university through its SoED for facilitating access to education for all students, especially students with special needs and I can assure you that the Ministry of Education recognizes your contribution and efforts in the provision of services to students with special needs since you started providing services to the first two students with visual challenges until now when you are supporting more than 150 students, keep the good work." he commented.

It is clear that through the service you provide, you have enabled people with special needs to fulfill their educational and employment dreams, he said.

UDSM Vice Chancellor Pro William Anangisye said that the most important mission of special education is to provide students with special needs with development opportunities and a learning process that will improve the quality of their life.

This can only be done through the cooperation of different stakeholders in the country that provide free appropriate education and in this way, people with special needs acquire knowledge in line with their unique needs and abilities, he noted.

Kinondoni's deputy mayor calls on teachers, parents to monitor children's behaviour

KINONDONI Municipal Council, deputy mayor Joseph Rwegasira has called on teachers and parents to be close to children and monitor their behavior to curb violence against them.

Rwegasira made the call in Dar es Salaam yesterday when speaking at the Kilimani Primary School's standard seven graduations.

He asked school owners to establish forums that will help build understanding, confidence to express themselves and selfawareness in students.

He said in the research they did for a few children, they managed to find out the sad things that they claimed were happening in the school environment while asking parents to raise children well and follow up on their behaviour so that in the coming years they can have strong, useful and productive children for the nation.

"In order for these young people to be good in our nation, they need good education and education starts at home and school, because that is where they spend most of their time, you may find that the teacher knows the child's behavior better than the parent," he said and added:

"The government encourages teachers as well as school owners to ensure our young people get the best education in their school environment, the other day the Ministry of Social Development launched a campaign to fight sexual violence and cruelty to children," said Rwegasira.

He added that available researches have been showing a lot of violence against children taking place in schools and at the family level, so he insisted that teachers and parents make friends with children so that they can tell them what is happening to them.

According to him, the government is looking at the issue of child abuse and sexual violence with a third

eye, giving an opinion to the school leadership to set up a procedure to have conferences to enable children to express themselves so that they can realise who they are.

He also congratulated various schools in the council including Kilimani Primary School for being good stakeholders in the education sector, and that they have been collaborating with them in following policies, guidelines and regulations that ensure education is provided in accordance with the country's guidelines.

"We are very grateful to Kilimani as our stakeholders, we promise to provide any kind of cooperation and ensure that together with the nation as a whole, we achieve our goals of finding strong young people who will help our nation move forward," said Rwegasira.

Nape: Communications regulator serves as Telco sector's protector

THE Tanzania Communications Regulatory Authority (TCRA) will continue to be in charge of the entire communications sector in the country in a mother-child-like relation to ensure that it makes more positive contribution to the growth of the sector, which helps build the digital economy.

Nape Nnauye Minister for Information, Communications and Information Technology made the remarks in a televised interview earlier this week.

The minister emphasised that one of the duties of the communications regulatory body is to analyse user information and provide feedback to Law Enforcement Agencies

(LEAs) like the police who are tasked with combating cybercrimes and other vices that occur in the online platforms.

"TCRA does not enforce; it is outlawed for TCRA to conduct any seizures; even when there appears to be an obvious cyber-crime, their duty is to conduct cyberanalysis and provide feedback to relevant LEAs," he said, stating: "Their feedback enables other agencies to identify who is who and what is being done in the space."

As a result of the fact that content on the Internet is always available, Minister Nape underlined that every person who uses online services should be sure to make responsible and safe use of the same.

He emphasised that the authority would continue to concentrate more focus on educating communication service providers who have TCRA's licences, rather than punishing them, particularly in situations where it is discovered that they have violated licenses criteria and other guidelines as issued by the regulatory.

"TCRA has changed significantly; penalties that the authority used to impose on licensees have been

ZRB advised not to charge tax based on estimates

THE Zanzibar Revenue Board (ZRB) has been advised to charge tax using sales reports from electronic fiscal devices instead of making mere estimates which is against the goals for the establishing of the Virtual Fiscal Management System (VFMS).

The advice was given by a cross section of businessmen as they addressed reporters on challenges that came up since the establishment of electronic receipts sales.

They said tax payment by some traders have been rejected and returned to them and were called to pay more than the amounts reflected in the sales report through the electronic fiscal

"We went to make payments but unfortunately ZRB refused to accept the money telling us to pay contrary to the amount reflected by sales recorded by the electronic machines," said Ali said, one of the businessmen in Zanzibar.

He said there emerged huge inconveniences in regard to inspections in shops due to a string of letters from ZRB instead of making normal auditing, thereby creating difficult environment in conducting their businesses.

"What is surprising is that VAT was reduced by three percent on building materials, including iron bars, roofing sheets and cement, but now it has been reverted to 15 per cent thereby creating well as government's aims in

Mohammed, owner of a shop who sells building materials in Mlandege area, Unguja.

"For example, a roofing sheet costing 18,000/-, the government takes 2,478/- in tax and we remain with only 1,000/- in profit," he added.

"They have sold to us the electronic machines at 400,000/each but we own small shops and are forced to pay 400,000/- per year, or 2 per cent of the 2m/- sales in disregard they sell the goods or not," said another owner of shop selling curios in Kiponda area.

A Zanzibar economy analyst, Abdulrahman Mshangama said collecting tax based on mere estimates is against the law as

unnecessary inflation," said Juma establishing the electronic system in tax collection.

> "In business, tax should be paid according to the volume of the business done, and if the people were sold the electronic machines to record sales, why estimates should continue to be done?" asked Mshangama.

However, addressing reporters, ZRB Acting Tax Payers Education Manager, Makame Mohamed Khamis said one is forced to pay tax on estimates if there is a doubtful environment especially when the tax is smaller than what it used to be paid in the past.

In addition, he said the law empowers them to conduct audit inspections in shops at any time in case they sense any signs of tax

Ministry called on to ban the use of dental amalgam by children, women

THE Ministry of Health has been urged to ban the use of dental amalgam on children and women of childbearing age as it can cause adverse health effects.

Dorah Swai, Agenda for Environment and Responsible Development senior programme officer made the call yesterday in Dar es Salaam when commemorating Africa Week for Mercury-free Dentistry.

She said that dental amalgam should be banned as it is known to cause adverse health effects particularly when the extent of exposure is high in individuals who have reduced ability to remove mercury from their bodies.

"This call is for Tanzanian and African governments to take deliberate steps toward protecting their populations, especially children and mothers as required by the Minamata Convention amendment aiming at prohibiting the use of dental amalgam to children under 15 years old and women of childbearing age by the end of 2023 similar to the requirements stated in the Tanzania Mercury Regulations (2020) and The Second Guidelines for provision of Oral Health Services in Tanzania (2020)," she noted.

The mentioned above is for facilitating the implementation of the Minamata Convention in Tanzania as it has banned the use of dental amalgam on most vulnerable populations in Tanzania which include children under 15 years old, women of childbearing age, pregnant women and breastfeeding women, she said.

"We argue the government to ensure that dental clinics strictly abide by those restrictions since Mercury-free dental filling material including, but not limited to composite resin and glass ionomer are available and have been in use for decades in Tanzania and other African countries," she commented.

She further noted that the Ministry of Health should set aside a special amount of money that will be used in giving education to people about the effects of amalgam on children and women of childbearing age.

Silvani Mng'anya, AGENDA principal programme officer said that installation of dental amalgam separators in dental clinics is costly and complicated since the device and amalgam waste trapped therein have to be shipped to western countries for sound disposal once full.

He further noted that effects in brain development may have severe negative effects on a child's intelligence quotient (IQ) making the child unable to contribute adequately to learning and ultimately to economic development in the future.

He continued that instead of using such complicated practices, the operator of dental clinics (public and private) should direct their effort on promoting the use of Mercury-free dental filling materials which are superior, tooth-friendly, non-hazardous and nonpolluting.

1. BACKGROUND

The Eastern Arc Mountains Conservation Endowment Fund (EAMCEF) is a Trust Fund that was established as a mechanism to provide sustainable financing for effective conservation of biological resources in the Eastern Arc Mountains of Tanzania. The Eastern Arc Mountains Conservation Endowment Fund was initially conceived as a joint initiative of the Government of the United Republic of Tanzania, the founder members of the Board of Trustees, the World Bank and the Global Environment Facility (GEF). The Fund aims at providing long- term and reliable funding support to conservation activities related to the promotion of biological richness and diversity, improvement of ecological functions and sustainable use of natural resources in priority areas of the Eastern Arc Mountains (EAMs). The Eastern Arc Mountains ecosystem forms a major portion of the Eastern Afromontane Region which is recognized globally as one of the 34 biodiversity hotspots characterized by high concentrations of endemic species now under serious threat. Major mountain blocks of the Eastern Arc spread over fifteen districts in five regions of Tanzania namely, Tanga (East and West Usambara and Nguu Mountains), Kilimanjaro (South and North Pare Mountains), Morogoro (Udzungwa, Ukaguru, Nguru, Rubeho, Malundwe, Mahenge and Uluguru Mountains), Iringa (Udzungwa Mountains) and Dodoma (Rubeho Mountains). Governed by a multi-sectoral Board of Trustees, the Fund was officially registered in Tanzania in June 2001 under the Trustees' Incorporation Act (Cap. 318 R.E. 2002) and it operates as an independent not-for-profit Conservation Finance Trust. Headed by the Executive Director and based in Morogoro Municipality, the Endowment Fund Secretariat is charged with the running of the day-to-day operations and functions of the Trust.

The Eastern Arc Mountains forests are under considerable pressure due to various human activities as a result of increased population. Threats leading to biodiversity loss include expansion of human settlements, shifting cultivation, forest fires, extraction of wood for commercial and domestic uses, gold mining, dry season grazing, extraction of non-wood forest products including honey, fruits, medicines, natural ropes, resins, mushrooms and game hunting. Whereas requirements for financial resources necessary for effective conservation of the Eastern Arc Mountains are quite enormous, the financial position of EAMCEF is currently very modest. Thus, EAMCEF needs to mobilize more resources from all possible sources so as to increase its capital base as well as enhance its capacity to finance its operations and programme activities.

In order for the resource mobilization efforts to be plausibly effective, aggressive fundraising, promotion and marketing, engagement and visibility activities needs to be concurrently undertaken. This will be possible only if the now vacant position will be filled by a right candidate. With 40,000 cattle dead, we should look beyond indigenous knowledge

of the scale of drought and its impact in Arusha Region are bringing to stark reality what is generally identified with climate change. Nearly 40,000 animals, mostly herded livestock have died for lack of grazing pastures and water as drought conditions spread over most parts of the northern zone. The most affected district is apparently Longido, but at an earlier period it was Simanjiro that reported cattle dying from lack of water and pasture, in which case the situation was now true of other areas, without visible, rapid solutions.

One substantial reaction to be heard from this zone isn't firstly that of district officials despite being involved, for instance Nestory Daggaro, who oversees livestock and climate change at the border district of Longido, was making an overview of the situation lately, at a meeting to review recent reports on indigenous communities' resilience to the effects of climate change. It was not too clear whether this initiative was scaled for the issue, or merely parallels the

Organising officials said that material collected from recent research activities was being placed for discussion in the meeting organised by a NGO, Media Aid for Indigenous and Pastoralist Community (MAIPAC) with sponsorship of the United Nations Development Programme (UNDP). The latter has a working agency on the ground linked with the World Bank, namely the Global Environment Fund (GEF) which worked with local activists in the Tanzania Natural Resources Forum (TNRF) to map out the project. Participants explored the traditional protection of water sources and

STONISHING reports forests, as part of efforts to control the impact of climate change.

There is an expression in English that says 'too little, too late' as observable in a range of circumstances in life, on account of the fact that crises break out since we aren't prepared for them (as a society, or any other society). So when we try to find remedies, it is a bit of 'more of the same' if not outright 'business as usual' as there will be a huge push to make a difference. That is what we see in this instance, that organisations whose very existence is tied up with traditional livestock rearing methods, try answers for a situation where nearly 40,000 cattle died in one district.

What was especially noticeable about the situation was that it was devastating for numbers of livestock that has succumbed to the crisis, estimated at upwards of 39,000 but with only a scatter of wildlife that also perished.

The dead wildlife counted at 18 zebras, four giraffes and two gazelles, apart from 19 donkeys, sheep and goats added to the mix. It would appear that cattle need large amounts of water, with seemingly a greater difficulty withstanding drought, compared to other livestock and definitely compared with wild animals. But that is beside the point.

Adding the problem of invasive plant species stifling edible grass and causing diseases to animals that consume the strange crops, it is also clearer that cattle are nonresilient in that situation, unlike wildlife. Activists must figure how to rehabilitate the apart from stabilizing water supply, and clearly credit is needed. Migratory herders are unlikely to fetch those funds from banks, nor contribute such the cash themselves, so NGO must find a way to fit cattle into the new landscape.

True, elaborate regulatory innovations can make Kigoma industrial, trade hub

ESPITE that the big minerals, vast arable land some of news as President Samia Suluhu Hassan started a tour of Kigoma region in her current tour of the western zone was delays to start registering farmers in the fertiliser subsidy scheme, the more strategic news was a bit hidden. It was covered in the switching off of generators after the region was connected to the national grid. The president noted that more investors are likely to opt for Kigoma in the wake of improved electricity services, whereupon the wider potential of the region was noticed by accompanying cabinet ministers and experts.

minister for Works and Transport said that road construction opens up economic and social opportunities by easing the transportation of people and goods. When itemizing how the new roads being launched or completed are capable of stimulating industrial production, elevating fishing and agriculture sectors, he unavoidably looked at how trade can improve with Rwanda, Burundi, Uganda and the Democratic Republic of Congo. Here one needs attractiveness similar to special economic zones now being planned for the coast, or Zanzibar, as industrial layouts require a definite affinity with land as well as the country, firstly.

One method would be to grant special residential status for citizens of member countries of the East African Community, with rights similar to those they will be meeting there, as falling short of voting, but insurance or credit being made accessible. It is a question of dusting our EPZ formats on the basis of best practices elsewhere in the world, as we seek to make Tanzania not just a gateway via the port of Dar es Salaam but also a manufacturing and service hub by our financial sector strength, which is game protected, etc.

The tour by President Samia more or less lays the framework for these conditions, namely in switching off unreliable thermal generators (putting them on some kind of standby function) and hundreds of kilometers of highways surfaced to tarmac level. With regulatory reform in residential rights, property rights and access to banking facilities, investors will do the rest, but the political establishment is more used to calling for 'more production' with scant knowledge of nearby markets,

Such a shift in the regulatory environment would offer new opportunities for those in refugee camps debating whether to say or to leave, as investors would integrate them to new activities where their knowledge of nearby countries would be of some use. It can be an altogether new branch of economic strategy that few other countries in the region can reproduce, meanwhile as a similar push is possible in the south-western zone where we have borders with the southern part of DRC, plus Zambia, Malawi; Mozambique. Terrorists ravage regions sleeping economically.

Tanzania's envoys in nearby countries, like those posted abroad, have overall instructions of fostering economic diplomacy, and they are making efforts. But when investors come with best practices formats on links to land, credits and property they may not find it easy to respond, which diminishes their effectiveness. This doesn't call for overhauling of institutions but merely adapting them to the pivotal need to attract investors, make various parts of the country more dynamic, to even use profitably some of the costly infrastructure we are building at

OLIDARITY has become a global buzzword in the development sector and even more in the recent context of global pandemic. However, Solidarity is not a new way of doing things in Africa.

In Africa, we have a philosophy called Ubuntu; meaning, 'I am, Because We are'.

Ubuntu is not just an African philosophy, but a spirituality and an ethic, a powerful tradition demonstrating the need for solidarity at all levels. It expresses compassion, dignity, harmony and humanity in the interests of building and maintaining community with justice and solidarity.

In this increasingly globalized world we live in, our interdependence. and the interconnectedness of the challenges we face collectively makes global solidarity a precondition for our survival and well-being more than

Global solidarity is not limited to aid, charity or humanitarian assistance; it is a broader concept that includes sustainability in economic relations, peaceful coexistence, equal partnerships, and equitable sharing of benefits and burdens.

Global solidarity does not seek to homogenize (unlike the old-fashioned By Riad Meddeb

development aid approach) but rather Africa, where war crimes against expectations to policy convergence to be the bridge across differences, connecting diverse people and countries with their heterogeneous interests, in a mutually respectful, and equitable manner.

But global solidarity to whom?

As James Baldwin (1972) stated, "If one really wishes to know how justice is administered in a country, one does not question the police, the lawyers, the judges, or the protected members of the middle class. One goes to the unprotected... and listens to their testimony."

In this case, if we want to show solidarity, it is for the most unprotected.

Human rights-based approach to Global solidarity is meant to be universal, regardless of where one come from, regardless of skin color, religion, and political stands. However, as it was a common practice in the development aid approach, we must not associate the vulnerable groups to the crisis they are facing. This is to the extent that crisis looks like the identity of the global south, as if agony is innate and natural to these groups.

For example, the attitudes towards

civilians in countries far from the West have become almost acceptable.

On the other hand, the war in a Western County is perceived as unnatural and alarming where refugees are welcomed with open arms, even at household level.

War is not African! The pain of women and children is not African!

We must change this world view. Global solidarity must acknowledge and address crisis as a fixable socio-politically manufactured phenomenon, wherever the location

Yes, there must be a shift from the old and colonial approach to development aid:

Where donors tag Africans with their logo and t-shirts

Where the poverty of women and children is romanticized with undignified photographs in media and project reports

the southern Where perspectives and experiences are pushed to the periphery and Africa is only the site of primarily of data collection in policy development and knowledge production

Where aid is tied to are'.

and homogeneity at the cost of the recipient's autonomy, rather than a virtue of only human solidarity

What is a shift to a good global solidarity?

Global solidarity fundamentally needs democratization of knowledge and development cooperation. As Raewyn Connell (2007) argued that democratization of knowledge is to utilize the potential of the southern intellectuals to produce new knowledge and new theories that are relevant for their context.

In the development cooperation, it is important to end tied-aid approach where partners stand on mutual respect and dignity. Dismantling the systems of sexism, racism and classism against the oppressive structures is possible through a good global solidarity for all.

It is important to build Intersectional, democratic, and feminist global solidarity approach against all forms of oppression and marginalization, regardless of where one come from.

When this happens, we can all one day say Ubuntu - 'I am, Because We

S much of the world was starting to glimpse recovery from COVID-19 pandemic, it now finds itself amid a cost-of-living crisis brought on by disruptions in global energy and food markets that are the result of conflict and climate change.

This again highlights how societal and planetary imbalances reinforce each other, as well as the need for a truly inclusive and green recovery. One that is foundational for achieving the Sustainable Development Goals

COVID-19 pandemic demonstrated that digital is no longer optional. Countries with existing digital foundations were much better equipped to respond to citizens' needs, including through the effective delivery of public services such as healthcare, social security benefits, and remote education. Digital will play a similarly important role in shaping a global green recovery.

Bevond building national socioeconomic resilience, digital transformation is also proving a key enabler in advancing global climate commitments. Countries supported by UNDP are leveraging digital in innovative ways to redouble their efforts to adopt renewable energy, transition to a circular economy, and to protect biodiversity.

Ecuador is building a digital traceability system for monitoring land use change and to track

commodities through the supply chain. Papua New Guinea has piloted a mobile phone application to assist law enforcers to quickly record and report environmental harms such as illegal logging and bush fires.

Whether it's emerging technologies like Artificial Intelligence (AI) or more established digital tools like the mobile phone digital can be a fundamental driver of change. It is reshaping the dynamics between the economy, governments, businesses, and civil society and is an important tool in rebalancing our planetary, societal, and economic priorities.

However, digital is fast becoming the global metric of both inclusion and exclusion. With 37 percent of the world's population still offline, the digital divide, notably, the lack of accessible broadband, gaps in digital skills, and marginalized groups excluded from technology, has become a key barrier for countries wanting to capitalize on the potential opportunities of the increasingly digital economy.

And digital technologies themselves could constrain a Green Recovery. The industry's carbon footprint could account for about 14 percent of global emissions by 2040. If digital were a country, it would nearly surpass the US as the second largest contributor to climate change. And this impact may worsen, with emerging technologies also contributing to increased

Digital and a green recovery Integrating sustainable development in digital is central to ensuring a green recovery - one that drives inclusive digital access and capacity, promotes openness and open data, and fosters innovations that increase the efficiency of digital technologies and mitigates their

environmental footprint.

In this context, the UNDP Global Centre for Technology, Innovation Sustainable Development organized its flagship event 'Digital for a Green Recovery' on the sidelines of the World Cities Summit in Singapore. The event highlighted three priorities for an inclusive and green digital transformation.

First, we must put people at the centre of innovation. This includes ensuring the availability of foundational digital infrastructure so that everyone can benefit. We must also ensure that the technical standards and explorations of emerging technologies are 'humancentred', founded on the local needs and aspirations of populations, but also 'environment-centred'.

Second, we need to strengthen collaboration between innovation ecosystems. Innovation doesn't happen in a vacuum. It requires an enabling ecosystem comprising policies and regulations, investors, incubators and accelerators; and educational institutions. Digital can be a potent enabler for connecting

How digital can drive a green recovery dispersed national and global innovation ecosystems in pursuit of sustainability.

> Third, data is the lifeblood of digital transformation and could be an important equalizer for countries in accelerating their efforts towards the Sustainable Development Goals.

> However, a number of countries lack even foundational data infrastructure, such as data centres, communication networks, and energy grids. We need to accelerate efforts to build data capacity to ensure that existing digital divides are not widened.

Digital is an indispensable enabler for driving a green and inclusive recovery. But it is truly a 'whole-ofsociety' endeavour.

As a platform to showcase innovation, best practice, and to foster partnerships, the UNDP Global Centre for Technology, Innovation, and Sustainable Development will continue to convene global discussions, support and align innovation ecosystems around the world, and guide governments in leveraging the potential afforded by digital. Through driving the experimentation, adoption, and scaling of digital, we can shape a Green Recovery that works for both

OUNG graduates with brown envelopes containing copies of their academic papers are commonplace in Tanzanian cities. These are brilliant young men and women looking for white collar jobs which are not available for all and it is not their mistake.

Our education system is wired such that graduates from higher learning institutions-including those teaching agriculture-expect to work in white collar environment. As a result, many waste years living with parents or relatives as they wait for employment opportunity.

But all indications point to agriculture as the solution if we change mindset and invest in the sector to make it attractive to young people. Tanzania's agriculture sector which contributes nearly one-third of our GDP and employs over 75 per cent of the population has the potential to create millions of jobs, increase incomes and improve livelihoods.

According to the World Bank, agricultural development is one of the most powerful tools to end extreme poverty, boost shared prosperity, and feed a projected 9.7 billion people in the world by 2050. Growth in the agriculture sector is two to four times more effective in raising incomes among the poorest compared to other sectors.

We know that jobs can be easily created in agriculture but waste time looking for white collar jobs which are not the only way to attain social significance and prestige which nearly every educated young person would prefer.

I remember an advice given to youth who were to graduate in a platform which aimed at promoting creativity and innovation. The advice from the academician who was a Rector of one of higher learning institutions was: "Competences are many but employment opportunities are few."

HE BBC celebrated its 100th birthday yesterday (October 18). The big day came as the institution faces increasing competition for audiences from global entertainment providers, anxieties about the sustainability of its funding, and a highly competitive global news

Its international broadcasting operation, the BBC World Service, is only a little younger - established 90 years ago. Delivering news and programmes in 40 languages across the continents, it faces similar, significant questions about financing, purpose and its ability to deliver in a world of increased social media and online news consumption.

Currently, the BBC's international services are mostly funded by British people who pay a television licence fee, with one-third of the total cost covered by the UK government.

The BBC claimed that, as of November 2021, the World Service reached a global audience of 364 million people each week.

The role of radio

Radio is still clearly a key means to extend the reach of the World Service and a core part of the BBC's global news package. It is highly adaptable and reasonably affordable.

It also gives people in parts of the world where access to media can be difficult relatively easy access to news. Short-wave radio, the traditional means of broadcasting over very long distances, is also difficult for hostile regimes to block.

Recently, fears that Russia would target Ukraine's internet infrastructure and erect firewalls to prevent its own citizens' accessing western media sources led the BBC to reactivate short-wave radio news services for listeners in both countries. UK government funding of £4.1 million supported this.

Current thinking about the World Service has been shaped by a 2010 decision of UK prime minister David Cameron's government to withdraw Foreign and Commonwealth Office funding for BBC international operations from 2014.

This seemed to end a 60-year-long era when the BBC was the key subcontractor for British global "soft power", meaning using cultural resources and information to promote British interests overseas.

The plan was that British TV licence-fee payers would fund the World Service, seemingly as an act of international benevolence, free of government links. However, this seemed unlikely to be sustainable at a time when BBC income was being progressively squeezed.

In 2015, World Service revenues were boosted by a major grant from the UK's Official Development Assistance fund, covering around one-third of the it purchased FM transmitter time in major cities around the

One anonymous BBC insider was quoted by The Guardian (UK) as saying that this would sustain the corporation's "strong commitment to uphold global democracy through accurate, impartial and independent news".

Even before the Second World War, the BBC claimed that it only broadcast truthful and objective news. Policy makers recognized this as a crucial asset for promoting British interests overseas and seldom sought to challenge (openly at least) the "editorial independence" of the BBC.

The BBC's 2016 royal charter further entrenched this thinking, stating that news for overseas audiences should be "firmly based on British values of accuracy, impartiality and

The idea that a truthful approach to news was a core "British value" that could help promote democracy around the world became part of the BBC's basic mission statement.

In 2017, the BBC established 17 new foreign-language radio and online services. To maximise possibilities for listening,

world and deployed internet radio increasingly accessible to many users via mobile devices.

The focus was on Africa and Asia. However, the World Service also strengthened its Arabic and Russian provision to serve those who "sorely need reliable information".

Fake news factor

The World Service's rationale has been strengthened by growing concerns about "fake news": distorted and untrue reports designed to serve the commercial or geopolitical interests of those who manufacture it.

The BBC has, in response, further emphasized its historic role as a truthful broadcaster. In its trusted news initiative it has worked with other global media outlets to tackle disinformation, hosting debate and discussion and sharing intelligence about the most misleading campaigns.

Claims for continued relevance also rest on a drive to bring news to an ever larger audience. The BBC's stated aim at the UK's University of Brisis to reach 500 million people this year -and a billion within another decade.

In 2021 the BBC claimed to be on course to realize this goal, reaching a global audience of 489 million. The audience for the World Service accounted for the single largest component of this global figure.

What then should we make of the BBC's announcement in September 2022 that 400 jobs would have to go at the World Service owing to the freezing of the licence fee and rapidly rising

Radio services in languages including Arabic, Persian, Hindi and Chinese will disappear, while programme production for the English-language radio service will be pared down.

Certainly, these cuts will reduce the BBC's impact overseas. But they should also be understood as part of a longstanding and ongoing transition from shortwave radio to web

Similarly, cutting back on World Service non-news programming might not be a major cause for concern. In an age of global streaming services and social media, audiences can receive programmes from providers from across the globe.

The World Service would find it hard to compete with many of these services. However, the BBC remains in a pre-eminent position to offer trusted news.

By focusing on providing news online, the World Service is putting its resources where it can best promote British soft power and international influence, thereby improving prospects for its own continued existence.

However, abandoning radio entirely would be a mistake. As the Russian invasion of Ukraine has demonstrated, radio remains a crucial way to reach audiences who might find their access to trusted news via the internet suddenly cut off.

Botswana entrepreneur turns to indigenous trees for livestock fodder

However, 26-year-old Tlotlo Phuduhudu from the Molepolole village, some 60km west of Gaborone, the capital of Botswana, is slowly but surely changing such a trend through her indigenous trees fodder.

Through her company called Healthy Delights, which was established in 2016, Phuduhudu is producing livestock feeds using natural resources within her community. "Our livestock feeds are a composition of crushed crop residues mixed with sunflower and maize together with fodder trees and shrubs,"

Phuduhudu told Xinhua in an interview.

According to Phuduhudu, in Botswana are often this type of livestock feed is blamed for prevent- very cheap and affordable ing the regeneration to community farmers who are not into commercialized breeding and fattening of cattle, goats and sheep.

Besides being Phuduhudu said the livestock feed is very nutritious. She said most farmers in her native village of Molepolole now prefer her feeds compared to modern ones since they are very nutritious.

"Farmers are now saving a lot of money because the feeds are now readily available in the country," said Phuduhudu, adding that Botswana imports raw materials for livestock feed production worth an estimated 1.6 million U.S. dollars annually. In addition to cutting Botswana's import bill, Phuduhudu said fodder trees and shrubs are

"Fodder tree plantations could thus be an effective intervention for supporting the survival of smallholder livestock farmers," said Phuduhudu, who exhibited her product at the 2022 Forbes Under 30 Summit Africa, which was held in Gaborone earlier this year. Dick Ketshabathupa, who is working closely with Phuduhudu and using livestock feeds from Healthy Delights, said the feeds have made a noticeable difference to his flock of lambs.

Ketshabathupa hailed Phuduhudu's initiative, saying it is promoting reforestation since farmers are now giving Phuduhudu is also assisting trees and shrubs that provide farmers with the know-how fodder an opportunity to regrow in order to benefit again in the next season.

Interestingly, distinct species of fodder trees also hold spiritual, emotional, and cultural significance in different religions and traditional communities historically, he said.

Fidelis Molao, Botswana's Minister of Agriculture, told Xinhua in a telephone interview last week that the meat of animals fed from indigenous fodder trees and shrubs is of good quality. He said the meat is very tasty and easy to cook.

Agriculture contributes about three percent to Botswana's gross domestic product and 80 percent of this contribution stems from the livestock industry.

Poaching surges in birthplace of white rhino conservation

IN the first nine months of this year, poachers have killed 190 rhinos in state-run protected areas in South Africa's KwaZulu-Natal province. That's one rhino killed every 35 hours. Most of this surge in poaching has taken place in Hluhluwe-Imfolozi Park, better known as HIP.

HIP is one of Africa's earliest proclaimed conservation areas, established in 1895 in large part to protect the southern white rhino (Ceratotherium simum simum) from extinction. At the time, there were believed to have been fewer than 100 left, all in Kwa-Zulu-Natal. HIP's rhino conservation was so successful that white rhinos have now been translocated back to many countries across their previous range. White rhinos can now be found in Namibia, Zimbabwe, Kenya, Rwanda, Mozambique and Zambia – all of them a direct result of the work done in HIP.

"Wherever you see a [southern] white rhino, it's from this park," says Amos Tembe, head of HIP's anti-poaching unit. "That's why it's so special."

After several decades of recovery, white rhino populations are once again in decline, with 18,064 left in the wild, according to the latest figures from the IUCN, the global wildlife conservation authority. HIP is home to one of the largest and densest white rhino populations anywhere on Earth. But unless something can be done to stem the recent tide of poaching, the future looks uncertain for the rhinos of this historic park. HIP is one of Africa's earliest proclaimed conservation areas, established in 1895 in large part to protect the southern white rhino.

No one can say for certain what has driven the spike in poaching in at HIP in 2022, but there are a couple of plausible explanations and factors that are likely exacerbating the demic.

The first is that HIP quite simply has such a large population of white rhinos as well as a smaller population of black rhinos. South Africa's flagship Kruger National Park has been the epicenter of the country's rhino poaching crisis, losing 75% of its rhinos between 2011 and 2021.

"Kruger has lost so many rhino that they are actually bloody difficult to find," says Dave Cooper, recently retired chief veterinarian for Ezemvelo, the government body responsible for managing conservation areas in KwaZulu-Natal. "They tracked it from Kruger and a lot of [the poachers] have come down this side.'

Ezemvelo no longer release their rhino numbers for security reasons but based on previous figures HIP's white rhino population is currently approximately 70% that in Kruger National Park in an area 20 times smaller.

Another factor is that many parks and private reserves in South Africa are also now choosing to dehorn their rhinos, including selective dehorning of certain female rhinos in Kruger National Park.

"We haven't dehorned," Cooper says. "I'm not saying dehorning is the silver bullet, the private sector has dehorned and we're the only significant population that hasn't, and we're being hammered."

And then there's COVID-19. With more police on the road and restrictions on movement, the pandemic was actually a period of relative respite for anti-poaching teams. As things slowly return to normal, poaching activity has escalated, possibly a sign that syndicates are making up for lost time, Tembe says, but there are also more people who have been pushed into desperate economic conditions and difficult choices by the pan-



HIP is a challenging park for rangers to cover. It spans 960 square kilometers (371 square miles) and is surrounded by communities on all sides, in many cases living right against the boundary, while a public road runs through the middle of the reserve. The high rhino density means the animals can often be seen from outside the fence, and the smaller area means poachers can be in and out in hours, rather than the days they may need to be in Kruger National Park.

Issues with HIP's fences have also long been a problem: they allow wildlife out, which creates tension with local communities through human wildlife-conflict, and allow poachers in. The situation has improved in recent years, in part through a partnership between Ezemvelo and Wildlife ACT, a conservation NGO, to install a "smart" fence that can detect poachers. But problem areas still remain.

To make matters worse, the rhino poaching crisis has come at a difficult time for Ezemvelo. A report into rhino poaching in KwaZulu-Natal, commissioned in 2016 by the province's Executive Council but never fully released, was highly critical of Ezemvelo's performance. The report describes issues around staffing shortages, dilapidated tourism facilities hampering Ezemvelo's ability to generate revenue, limited opportunities being provided for surrounding communities, and poor coordination with wider law enforcement agencies.

In particular, the report took aim at mismanagement by a

board it described as disconnected from conservation operations on the ground – a point that was emphasised when Ezemvelo's CEO was forced to step down amid controversy in 2017 and the entire Ezemvelo board was dismissed in

Mismanagement and a faltering economy squeezing government revenues have left Ezemvelo severely underresourced. Tembe estimates he has fewer than half of the rangers he would need to effectively patrol the reserve, and with incursions by poachers occurring daily, including coordinated incursions from multiple points, the anti-poaching team is stretched to breaking point.

A visit to the nearby Manyoni Private Game Reserve gives some insight into what it takes to curb rhino poaching. Reserve manager Karen Odendaal runs a slick and wellresourced operation using what she describes as a toolbox of anti-poaching measures. The tools range from the LoRa network that monitors the location of all the reserve's rhinos, to the well-drilled anti-poaching teams who undergo regular integrity testing, to a community outreach program. But the tool that Odendaal says has had the most impact is dehorning. "Considering the number of rhinos we lost prior to dehorning compared to post, it's night and day for us," she says.

CCRO: Challenges, solutions for rural women in Tanzania

ON my recent visit to Ikongosi village of Mufindi District in Iringa Region, a woman shared her excitement upon receiving her Certificate of Customary Right of Occupancy (CCRO)

"I can't believe I now have a CCRO that shows I own a piece of land! I can now farm freely and produce food for my family. In the past, there were many family conflicts over land use and ownership. As a woman, you could farm on the family land, but your brother could take over the same piece of land - and vou are told vou're a woman you will get married..., said Consolata Kibiki, a resident of Ikongosi Village.

Around the world, women play a pivotal role, as they comprise 80 per cent of farm producers and 70 per cent of the labour force, according to the Food and Agriculture Organization (FAO).

In Tanzania too, the majority of workers in agriculture are women accounting for 70 percent of the labor force. Thus, rural women significantly contribute to food production and food security.

The theme for this year's International Rural Women Day 2022celebrations on October 15th was "Rural women Cultivating Good Food for All" and the national theme was "Mwanamke wa Kijijini ni Mzalishaji Mkuu wa Chakula: Tumwezeshe." Both themes mean rural women are key food producers, let us empower them. Both international and national themescentered on recognizing rural women's fundamental contribution to food systems.

Despite this fundamental role and contribution to the country's food systems and development, the majority of women in Tanzania still face multiple barriers when it comes to access, ownership, and control of land, all of which are essential for women's participation in agriculture.

In 2017, it was reported that only25 percent of women owned land individually. Joint ownership accounted for 16 percent as per the Land Tenure Support Program evaluation re-

Reflecting on rural women's contribution to food systems, both at global, regional, and national levels, International Rural Women Day should not only celebrate rural women for their contributions but also deliberate, call for action, and draw practical solutions to respond to their needs and address structural and socio-cultural norms that hinder women from ac-

cessing, owning, and controlling

For instance, in typical Tanzania's patriarchal societies, land titles are held through male lineage where young women are less likely to get land from their families. They are expected to get married and access land from their husbands' families. In the case of inheritance rights, under customary law widows are not entitled to inheritance girls are placed at the 3rddegree of inheritance. Sometimes women are given less productive lands compared to men.

On the other hand, structural challenges include the ineffective participation of women inland governance and decisionmaking bodies partly due to customary norms and gender roles. Underdeveloped land markets where both formal and informal markets present complexity and fee requirements make it difficult for women to navigate the socio-cultural barrier by acquiring land through this avenue due to a lack of resources.

The Stand for Her Land (S4HL) campaign in Tanzania is supporting rural women by addressing socio - cultural norms that are discriminating against women from realizing their land rights individually, jointly, and

communally. Understanding that land is foundational to rural women livelihood and sustainable food systems, S4HL partners in collaboration with central and local governments are supporting villages to undertake land use planning and issuance of Certificate of Customary Rights of Occupancy (CCROs) to ensure the community's security of tenure particularly women.

Mid-September In 2022,Landesain collaboration with PELUM Tanzania and the Mufindi District Council issued more than 2000 CCROs in Ikongosi and Ikongosi Juu villages of Mufindi district, Iringa region

where 45 percent of CCROs were issued to women individually and jointly with spouses. Other campaign partners, the Land Rights Research & Resources Institute (HAKIARDHI), Pastoral Women Council (PWC),UN Women, Tanzania Natural Resources Forum (TNRF), Tanzania Women Lawyers Association (TAWLA), and Ujamaa Community Resource Team (UCRT), are also supporting villagers to undertake land use planning and issuance of CCROs in different parts of the country.

However, apart from secure land right's needs, women also need access to extension services, affordable input and seeds and weather forecasting information to mention a few. Therefore, to address rural women's challenges, and draw practical solutions, it is important to take holistic approaches where land rights challenges and other related needs will be addressed and responded to in order to increase women's contribution to sustainable food systems.

Strategic development in digital industrial hubs can unlock Africa's economic transformation

IGITAL innovation enables transparency in public services and new opportunities in commerce, health, education and agriculture. But Africa lags behind the rest of the world in nearly every digitalrelated indicator except mobile money.

It is especially behind on innovation and digitalisation in industry and manufacturing to spur economic transformation. There are great examples of African companies using 3D printing or machine learning or drones, but these mostly represent Africa's aspirations, not its reality.

Even where there is chains, and better export progress, countries aren't benefiting enough from new technology and innovation because of low absorptive capacity and lagging digital infrastructure. The average internet penetration in sub-Saharan Africa is 25%

 half the global average. The impact of doubling internet penetration on manufacturing labour productivity is also significantly lower in these countries.

Digitalisation can create new opportunities in manufacturing. These include increases in efficiency, diversification into more value-added products, expansion in regional and global trade, lower production costs, optimising supply


competitiveness. to achieve this, governments must incentivise innovation in industry and manufacturing while providing an appropriate business environment for the private sector.

The African Center for Economic Transformation (Acet) recently analysed seven countries (Côte d'Ivoire, Ethiopia, Ghana, Morocco, Senegal, Togo and Tunisia) to better understand where industrial innovation policies were in place. It found that the private sector had limited indigital, and the Fourth Industrial Revolution technologies. Governments promote smart technology and incentivise industrial innovation.

The Acet study concluded that the biggest challenge to building an industrial innovation ecosystem in the countries reviewed was the lack of substantive engagement with the private sector.

Good policies and a conducive macroeconomic framework are enablers but aren't enough to drive industrial innovation. Governments were drafting policies but not engaging enough with industries, tech hubs and start-ups. Besides Tunisia and Morocco (where gaps vestments in innovation, remain), there was little strategic contact with the private sector.

Tanzania Revenue Authority (TRA) wishes to remind employers that all employees are required to have a Taxpayer Identification Number (TIN) as per Section 22 of the Tax Administration Act, Chapter 438 R.E 2019. Use of a valid employees' TIN is important in keeping accurate records that enables submission of monthly returns and payment of income taxes withheld from remunerations of employees i.e. Pay as You Earn (PAYE) through the electronic filing system (e-filing).

It should be noted that, the Authority issued a deadline that all employers had to ensure that their employees have TINs way back on 31st December, 2020. Inspite of the fact that many employers have complied, there are still a few who have not complied with this legal requirement and have not been using the correct TINs for their employees and instead use the dummy TIN 999 999 999 which was only allowed during the transition.

In view of this, the Authority would like to remind all employers and employees to ensure that they comply with this legal requirement and use of correct employees' TIN. Please note that TIN is issued free of charge by the TRA and easily obtainable. For employees with registration numbers (TIN) issued by the National Identification Authority (NIDA), they can apply for a TIN through the online TIN Registration system available on the TRA website (which is www.tra.go.tz). Employees who do not have TIN are required to physically visit the nearby TRA Offices for TIN application and appropriate biometric registration.

Institute of Development Studies research in 2021 showed that projects such as digital industrial hubs must be implemented in partnership with local tech providers. These providers can offer maintenance, repair and troubleshooting services for digital hardware and software. This will require building local capacity and facilitating links with local tech providers.

Political economy thinking needs to be embedded into Africa's digital industrial hub design. This will show how structural factors shape their uptake and who is involved in their design. It will also shed light on the formal and informal 'rules of the game' – how social, cultural and gender norms affect the adoption of digital hubs.

For example, a 2020 World Trade Organization and World Bank study found that smaller firms with female CEOs suffered the most from inefficiencies in IT connectivity, infrastructure and digital regulations.

There are significant opportunities for African countries to prepare for an acceleration of investment in digital industrial hubs. For example, e-commerce protocols in the African Continental Free Trade Area agreement are being negotiated by the African Union (AU). Also, global tech giants such as Google and Microsoft are investing substantially in Africa. And efforts such as the European Union-AU digital partnership and the G20 Compact with Africa facilitate investment.

There are concerns about the impact of digitalisation on employment. But a key roadblock to largescale job creation in African countries is a lack of integration between the local manufacturing and technology sectors.

In many developing countries, manufacturing firms import digital solutions due to a lack of awareness and trust in domestic options. To scale up local production in Africa – and thereby create jobs – requires more focus on domestic integration. Global firms should be linked with potential local suppliers, and domestic digital start-ups and small and medium enterprises (SMEs) with existing manufacturing supply chains.

Acet's business incubator for start-ups works with SMEs with a manufacturing or assembly component in their business model. The aim is to integrate them into regional markets and the global value chains of large multinationals. The programme provides free technical and managerial services, financial support and transaction advice. But Acet finds that even firms that invest in technology often respond to market trends that present opportunities rather than having a strategy to scale and enter value

Digitalisation provides opportunities for expanding Africa's manufacturing, but this requires incen-

tivising industrial innovation policy. Regional and global efforts can support the evolution to digital industrial hubs as long as there is domestic integration and backing for companies entering regional and international value chains.

Well-integrated digital industrial hubs can help African firms create economies of scale, grow demand and provide jobs. As pockets of digital infrastructure and skills, they can inform policy and attract local and foreign investment, with the potential to nurture regional hubs with access to regional value chains.

More information is needed on the potential of digital industrial hubs in different countries, sectors and policy environments. Digital start-ups also need help integrating into manufacturing value chains through digital services and e-commerce.

To achieve this, African governments must tackle digital infrastructure deficiencies and policy gaps related to intellectual property, data protection and privacy. National digital industrialisation roadmaps are also needed that target female workers and entrepreneurs.

As fissures in the global economy continue, African governments and companies must prepare for an economic rebound by an increasingly digitised industrial base with new regional and global value chains. Digital industrial hubs will be central to the continent's economic transformation, poverty reduction and equitable growth.



There are significant opportunities for African countries to prepare for an acceleration of investment in digital industrial hubs. For example, e-commerce protocols in the African Continental Free Trade Area agreement are being negotiated by the African Union (AU). Also, global tech giants such as Google and Microsoft are investing substantially in Africa. And efforts such as the European **Union-AU digital partnership** and the G20 Compact with Africa facilitate investment

EABL market caps up by 474bn/- after share buying notice

THE share price of Dar es Salaam Stock Exchange (DSE) cross listed brewery- the East African Breweries Limited (EABL) jumped by more than one- fifth in one day, pushing its market capitalization sharply up by 474.47bn/during the week's opening.

The DSE daily market report shows EABL share price closed at 3,240/- on Monday this week, from 2,640/- recorded during the closing session of last week, an increase of 22.73 percent.

This has increased its market capitalization to 2,562.11bn/- during Monday close, from 2,087.64bn/- recorded on Friday last week, overtaking KCB Bank from the position of the second largest listed company.

The major price gain by EABL has

also pushed the DSE market capitalization to 15,697.52bn/- on Monday close from 15,283.09bn/ on Friday's close.

EABL is the majority shareholder of Tanzania's Serengeti Breweries Limited, owning 85 percent stake.

This follows after Diageo, through its subsidiary Diageo Kenya Limited announced on October 14 that has served notice on EABL of its intention to increase its equity stake up to 65pct, by means of a partial tender offer made to other shareholders of EABL.

As at the date of the announcement, Diageo Kenya was holding 50.03 percent of the issued share capital of

"Subject to receipt of the relevant regulatory approvals, details of the proposed partial tender offer will be set out in a tender offer document,

which will be made available to shareholders of EABL," Diageo said in a statement last week.

Diageo Plc, which is listed on the London Stock Exchange, said is seeking to raise its stake in EABL, through the purchase of an additional 118.39 million shares, at a price of Ksh192 (3,600/-) per share.

Diageo Kenya, which holds 395.6 million shares in EABL, will pay Ksh22.7 billion (437bn/-) for the additional stake, whose purchase it expects to conduct in two phases between January 30, 2023 and February 7, 2023, and February 20 and March 10, 2023, Kenyan media reported.

After the announcement, the firm's share price rallied by 23 percent Nairobi Securities Exchange (NSE), to Ksh170- (3,273/-) valuing the brewer at Ksh134.4 billion (2.57trn/-), which also meant a removal of the daily 10 percent cap on share price movement at the bourse on the day.

"The tender price represents a premium to the volume weighted average price (VWAP) at which shares of EABL traded on the NSE days up to October 12 ... of 31.4 percent to the last 30 days VWAP; 42.5 percent to the last 90 days VWAP and a premium of 33.5 percent to the last 180 days VWAP," said Diageo in its notice.

The willingness by Diageo to offer a steep premium on the EABL shares indicates that the firm sees

undervaluation on the stock, but also an intention to take advantage of the prevailing lower prices at the NSE to strengthen its hold on the brewer, Kenya's based Business Daily reported.

EABL has been one of the most profitable listed companies at the NSE in Kenya, offering a stable dividend policy due to the maturity of its business in terms of capital investments.

Meanwhile the DSE share indices opened the week on high note following the appreciation of

EABL and NICOL share prices.

The DSE All Share Index (DSEI) gained by 49.73 points to 1,883.53 pints on Monday close, from 1833.80 points recorded on Friday last week while the Tanzania Share Index (TSI) slightly gained by 0.12 points to 3,840.40 points from 3840.28 points respectively.

Oil prices rise on softer dollar, supply woes

SINGAPORE

OIL prices climbed on Tuesday, bolstered by a weaker US dollar and supply woes, although gains were capped by the spectre of lower fuel demand from China as it persists with its stringent zero-COVID policy.

Brent crude futures rose 82 cents, or 0.9%, to \$92.44 per barrel by 0643 GMT, while US West Texas Intermediate (WTI) crude futures gained 86 cents, or 1.0%, to \$86.32 per barrel.

The US dollar index - which measures the greenback against six major peers including sterling - sagged to its lowest since Oct. 6. A weaker dollar makes oil cheaper for buyers holding other currencies, mak-

ing them more likely to make purchases. Following the steep production cut agreed on by OPEC+ - the Organization of the Production Exporting Countries (OPEC) and its allies, including Russia - earlier this month, investors have been seen increasing their long positions in futures,

ANZ Research analysts said in a note. OPEC+ member states have been lining up to endorse the cut to the output target after the White House accused Riyadh of coercing some other nations into supporting the move.

Meanwhile, expectations that China will stick to a loose monetary policy to help its economy, hobbled by COVID-19 restrictions, lent some support to oil prices. The country's central bank rolled over maturing medium-term policy loans on Monday while keeping its key interest rate unchanged for a second month.

China's fuel demand outlook, however, weighed on sentiment after the world's top crude oil importer delayed the release of its economic indicators, originally scheduled to be out on Tuesday, CMC Markets analyst Tina Teng said. No date for a rescheduled release has been given.

China's adherence to its zero-COVID policy has continued to increase the uncertainties about the country's economic growth, Teng said.

On the supply side, US crude oil stocks were expected to have risen a second consecutive week and are estimated to have increased by 1.6 million barrels in the week to Oct. 14, a preliminary Reuters poll showed on Monday.

Output in the Permian Basin of Texas and New Mexico, the biggest U.S. shale oil basin, is forecast to rise by about 50,000 barrels per day (bpd) to a record 5.453 million bpd this month, the Energy Information Administration said.

Asia stocks, pound savour relief following UK U-turn

ASIA stocks rose yesterday as the dramatic Uturn in British fiscal policy brightened investor sentiment, while sterling flirted with two-weeks high on hopes the Bank of England may further delay plans for quantitative tightening.

MSCI's broadest index of Asia-Pacific shares outside Japan was up 1.55%, while Japan's Nikkei rose 1.59%.

European stock futures indicated stocks were set to continue their ascent, with the Eurostoxx 50 futures up 1.25%, German DAX futures up 1.22% and FTSE futures up 0.87%. U.S. futures also pointed to a higher opening with S&P 500 futures up 1.6% and Nasdaq futures up 1.8%.

The British central bank, which had already delayed the start of a scheme to sell down 838 billion pounds (\$954.90 billion) of government bond holdings, is likely to push the sale of the bonds, the Financial Times reported on Tuesday.

The FT report comes a day after Britain's new finance minister Jeremy Hunt abandoned most of Prime Minister Liz Truss' economic plan that



had led to a political maelstrom fuelled by market turmoil, resulting in the Bank of England being forced to intervene to calm the bond market.

Sterling was last trading at \$1.1382, up 0.26% on the day, adding to its gains of 1.6% in the previous session. The pound had jumped 0.36% to \$1.1398, near Monday's high of \$1.144, the strongest since

Oct. 5.

Morgan Stanley analysts said the fiscal U-turn was likely to have significant implications for the BoE as its economists now revise their call for the November meeting to a 75-basis-point rate hike, from 100 basis points.

"Given such a wholesale scrapping of Truss' Tory leadership promises, it remains an open question how long Truss will remain in power," said Tapas Strickland, head of market economics at National Australia Bank.

China's stock market nudged higher, up 0.2% as the Chinese ruling Communist Party's twicea-decade congress remains in session this week.

Chinese state banks are stepping up intervention to defend the weakening yuan, banking sources told Reuters on Monday, while many companies have announced share buyback programmes.

The dollar index fell 0.178%,

touching its lowest levels since Oct. 6, while the euro was up 0.21% to \$0.9859.

The Australian dollar rose on Tuesday after the Reserve Bank of Australia said it expects to raise interest rates further over the coming months.

The yen touched a fresh 32year low of 149.10 per dollar on Monday, not far off the psychological metric of 150. [/FRX]

Investors have been watching out for any signs of further intervention by the Bank of Japan, with authorities repeatedly warning of a firm response to overly rapid yen declines.

Intervention is more about speed of moves than it is levels, said Ray Attrill, head of foreignexchange strategy at National Australia Bank.

"I don't think the Japanese authorities are particularly keen to see dollar yen at 150 in the immediate term and that's why markets are being a bit guarded."



Global oil, gas exploration dive 60 pct in 2022

WASHINGTON

PRESIDENT Joe Biden has repeatedly urged US oil companies to step up production in a bid to increase oil supply and ease fuel prices.

However, it appears his pleas have been falling on deaf ears considering the dearth of oil and gas exploration--which is, of course, perfectly understandable given his historic hostility toward fossil fuels as well as the very real risk that new drilling won't pay off over the long term.

When the energy crisis hit a nadir two years ago, highly indebted oil and gas companies quickly changed their play-

book, adopting stricter cost discipline, cutting back on expensive drilling programs and vowing to return more cash to shareholders in the form of dividends and buybacks.

Many energy companies are still reluctant to go back to their trigger-happy exploration and drilling days despite high oil and gas prices and record profits, and have mainly been falling back on their dwindling stocks of drilled but uncompleted wells (DUCs) to keep going.

But the biggest African sources lie south of the Sahara--including Nigeria, which has about a third of the continent's reserves, and Tanzania. Senegal has recently discovered major offshore fields.

Norwegian energy intelligence firm Rystad Energy has revealed that a mere 44 oil and gas lease rounds will take place globally this year, the fewest since the year 2000 and a far cry from a record 105 rounds in 2019.

According to the Norwegian energy punter, only two new blocks had been licensed for drilling in the U.S. as of the end of August this year with no new offers for oil and gas leases originating with the Biden administration itself.

Indeed, the handful of auctions that have gone ahead under Biden or bled into his presidency were decided upon during the presidency of Donald Trump. Meanwhile, Rystad has revealed that Brazil, Norway and India are the world leaders in terms of new licenses.

But such low levels of exploratory interest is not sustainable and might come back to bite the world before long.

A year ago, Rystad Energy warned that Big Oil could see its proven reserves run out in less than 15 years, thanks to produced volumes not being fully replaced with new discoveries.

Global oil and gas companies cut their capex by a staggering 34% in 2020, in response to shrinking demand and investors growing wary of persistently poor returns by the sector. Capex is only set to rise 12% in the current year.

ExxonMobil, whose proven reserves shrank by 7 billion boe in 2020, or 30%, from 2019 levels, was the worst hit after major reductions in Canadian oil sands and US shale gas properties.

Shell, meanwhile, saw its proven reserves fall by 20% to 9 billion boe last year; Chevron lost 2 billion boe of proven reserves due to impairment charges while BP lost 1 boe. Only Total and Eni have avoided reductions in proven reserves over the past decade.

to open up the North Sea for oil and gas exploration with more than 100 licenses likely to be issued for the coast off Yorkshire, Lincolnshire and Norfolk. However, this is unlikely to become a trend across Europe due to strict climate mandates, meaning the continent might have to at least consider the final frontier as it looks to solve its energy crisis: Africa.

Germany and the EU are already working to expand pipeline capacity connecting Spain with France, from where more Algerian gas could flow to Germany and elsewhere. Libyan gas fields are connected by pipeline to Italy.

Bitcoin volatility falls to two-year low

WASHINGTON

DESPITE its reputation as an unpredictable and risky asset class, crypto hasn't been especially volatile in recent weeks.

According to crypto market data provider Kaiko, Bitcoin's 20-day volatility has come to equal that of the NASDAQ for the first time in two years.

But while Bitcoin's price has remained roughly the same since the start of September, both the NASDAO and S&P have fallen 13% and 10% respectively since that time.

Historically, Bitcoin has been tightly correlated with tech stocks, but with higher beta (volatility relative to the rest of the market)-thus defying its label in some circles as a safe-haven asset, or "digital gold." However, despite a violent crash in June, crypto has proven to be one of the best-performing asset classes in Q3, next to the US dollar.

As with its volatility, Bitcoin's actual price descended to late 2020 lows last week after the core U.S. Consumer Price Index or CPI (which excludes food and energy) reached another 40-year high.

Bitcoin and stocks both fell on the



their respective ranges.

June's initial collapse followed the release of May's CPI data, which revealed inflation at 8.6%. Markets took it as a sign that the Fed wouldn't be ending its aggressive policy stance any time soon, inspiring participants to withdraw from "riskier" assets.

That said, although inflation has remained elevated by rough equal measure, crypto hasn't seen much significant price action with subsequent CPI updates. Stocks, by contrast, continue to trickle downwards.

Meanwhile, the hawkish stances of central banks worldwide are beginning to turn bonds into a volatile-yet-rewarding asset class.

As Bloomberg reported last month, bond yields have been skyrocketing thanks to Fed policy, while DeFi yields have fallen to under 100 basis points on protocols like

SENIOR Safaricom managers were awarded 15.28 million shares with a current market value of Sh390 million for free in the year ended March as compensation for past performance.

The employees had cashed out 17.8 million units of stock the year before, with the company's cumulative

spending on the share-based compensation scheme standing at more than Sh4 billion.

The Nairobi Securities Exchange-listed firm buys its own shares in the open market and allocates them to specific employees who eventually take ownership three years later when they are free to sell the stocks or

continue holding them. "Additionally, 15.28 million shares historically valued at Sh519.4 million (2021: 16.42 million shares valued at Sh480.7 million) vested and were exercised by eligible staff," the telco says in its latest annual report.

IFC invests new Sh55 billion in Kenyan firms

THE International Finance Corporation has invested an additional \$459.8 million (Sh55.6 billion) in Kenyan companies, cementing its position as the largest provider of capital to local

The institutional investor says in its latest annual report that its cumulative investments in Kenyan companies rose to \$4.1 billion (Sh497 billion) in the year ended June.

This was an increase from \$3.6 billion (Sh442 billion) the year before. Banks, manufacturers, insurers, and real estate developers are among the entities that have benefitted from IFC's backing in the form of loans and capital subscriptions.

The number of companies supported by the IFC rose to 143 in the review period, up from 138 a year earlier.

The global financier, which is part of the World Bank Group, also participated in offering loans and guarantees to local financial institutions to the tune of \$267.2 million (Sh32.3 billion) in the year ended June, helping to spur lending to the private sector.

This marked an increase from \$168.9 million (Sh20.4 billion) of such participation a year earlier. Altogether, IFC's local commitments in Kenya rose 14.6 percent to \$4.3 (Sh530 billion) from \$3.8 billion (Sh462 billion).

Some of IFC's recent activities in Kenya are the purchase of a 6.7 percent stake in Equity Group for Sh14 billion. The institutional investor also sold its minority stake in supermarket operator Naivas Limited after more than doubling its twoyear investment of \$15 million (Sh1.8 billion).

IFC has become the biggest lender to local banks that in turn use the funds to boost their capital and expand lending including categories prioritised by the global financier such as climatefriendly projects and women-owned businesses.

For the local banks, these IFC loans help to augment their capital for onward lending to small businesses, with a significant amount coming in

when the Covid-19 pandemic hit Kenya in March 2020.

Equity Group accounted for the largest share of these loans at Sh38.9 billion, which it took for its Kenyan and Democratic Republic of the Congo subsidiaries by the end of last year.

KCB Group and Co-op Bank carried IFC loans worth Sh27.9 billion and Sh17.9 billion respectively by the end of last year, while loans to DTB and NCBA stood at Sh6.35 billion and Sh814 million respectively.

The foreign currency loan also builds up these banks' forex positions –just like the government's external borrowing bulks up official forex reserves— which allows them to support businesses that import products or raw materials.

The tenor of these loans is also an important factor for the banks, allowing them to offer smaller businesses longer

Equity's IFC loans, for instance, were pegged at rates of between 1.9 percent and 5.6 percent above the benchmark US dollar Libor (London Inter-Bank Offered Rate).

Zambia restricts number of mining licences to five

LUSAKA

ZAMBIA, Africa's second-largest copper producer, said on Monday the number of mining licences that a company can hold at a time will be restricted to five to curb speculative purchases within the country's licensing system.

The ministry of mines in February suspended the issuance of mining licences and commissioned an audit in response to public complaints about a lack of transparency.

"Every miner will be restricted to five licences and those that need more will have to justify it," Zambia's mines minister Paul Kabuswe said during a briefing on mining

"We have had a lot of licences being used for speculative purposes and we want to curtail that," Kabuswe said.

He did not name the companies holding more than five licenses but said those should get in touch with the min-

The audit revealed that some companies owned as many as 50 licences. It also found that some were not registered with Zambia's patents and companies registration agency and may not be paying tax.

The licensing department, which was expected to reopen on April 11, will resume work on October 19, Kabuswe

He also said illegal miners would be given 90 days of amnesty to register with the ministry of mines.

Report: Trump administration impeded federal COVID fight

Trump and his top aides repeatedly attacked the Centers for Disease Control and Prevention's scientists, compromised the agency's public health guidance, and suppressed scientific reports in an effort to downplay the seriousness of the coronavirus, Congressman James Clyburn, chair of the panel, said in a statement.

"This prioritization of politics, contempt for science, and refusal to follow the advice of public health experts harmed the nation's ability to respond effectively to the coronavirus crisis and

put Americans at risk," Clyburn alleged. The investigation uncovered that



BEIJING

PEOPLE from across China have been reinvigorated by a sense of mission to build the country as the Communist Party of China convenes its fiveyearly national congress this week in Beijing.

From villagers in deep mountains to jetliner designers, members of the public from all walks of life have expressed an eagerness to contribute to the country's modernization drive.

On Sunday, the CPC unveiled its blueprint for building a modern socialist China in all respects for the next five years and beyond as the 20th CPC National Congress opened.

"The achievements in the past decade have shown us the power of dream," said Zhao. "It is a dream of the country and the expectation of the people to have China's homegrown large jetliner fly in the sky."

On Sunday, Xi stressed maintaining absolute Party leadership over the people's armed forces and further modernizing national defense and the military. The remarks came through loud and clear to the People's Liberation Army (PLA).

"We will never fail the Party

No one will be able to drive a wedge between Russia and Kazakhstan – Lavrov

MOSCOW

THE level of mutual trust allows Russia and Kazakhstan to frankly discuss and resolve the most difficult issues, and no one will ever manage to drive a wedge between the two countries, Russian Foreign Minister Sergey Lavrov said in a message to the readers of the International Affairs Journal on the occasion of the 30th anniversary of diplomatic relations between Russia and Kazakhstan.

"We are looking with optimism into the future of our new highs to the benefit of our

relations with our Kazakh friends. No one will manage to drive a wedge between us.

The current level of mutual trust allows us to frankly discuss any issues, even the most difficult ones that our countries are faced with in real life, and to agree on mutually acceptable ways of solving them," Lavrov stressed.

"At the same time, we are not going to feel satisfied with what we have achieved," Lavrov continued. "We will continue to work together to bring bilateral relations to



fraternal peoples and in the name of strengthening regional security and stability."

He noted that over the past three decades, the two countries have managed to strengthen the centuries-old ties of friendship and good neighborliness that unite their peoples. Today's relations between Russia and Kazakhstan continue to develop in the spirit of strategic partnership and alliance.

"Large-scale joint projects are being implemented in crucial economic sectors and in the scientific and educational sphere. The advantages of Russia's and Kazakhstan's transit potentials are being used effectively.

Ties are expanding among small and medium-sized businesses. Interaction is being stepped up along the world's longest land border," Lavrov recalled.

"The Baikonur cosmodrome is a vivid example of a truly strategic partnership. The same-name city can rightly be considered as a symbol of Russian-Kazakhstani friendship and privileged researchintensive cooperation".

UK reverses bulk of tax-cutting package to calm markets

LONDON

THE United Kingdom government on Monday announced a reversal of the bulk of its September tax-cutting measures in yet another emergency action to ensure economic stability and provide confidence in its commitment to fiscal discipline.

The basic rate of income tax is set to remain at 20 percent until economic conditions allow for it to be cut, Chancellor of the Exchequer Jeremy Hunt said in a statement.

The 1.25-percentage-point increase in dividends tax will remain and the VAT-free (value-added tax) shopping scheme for foreign visitors to the country will no longer be taken forward.

Added to the earlier package of government decisions worth 21 billion British pounds (\$23.9 billion) aimed at keeping the increase in corporation tax and the highest 45-percent rate of income tax, these changes, taken together, are estimated to be worth around 32 billion pounds a year, according to the statement.

Hunt also said the support scheme for UK households and businesses facing rising energy costs will only run until next April, and a Treasury-led review will be conducted after that to consider what support will be needed then.

Also on Monday, the UK Treasury said the chancellor will deliver the full medium-term fiscal plan by the end of October, and the chancellor has briefed the Bank of England and the Debt Management Office on these plans. Addressing the House of Commons on Monday, Hunt said

that "the central responsibility of any government is to do what is necessary for economic stability." Whether reductions in spending or increases in tax, the government will prioritize the needs of the most vulner-

able, he added. On keeping the basic rate of income tax at 20 percent, the chancellor said that "at a time when markets are asking

serious questions about our commitment to sound public finances, we cannot afford a permanent, discretionary increase in borrowing worth 6 billion pounds a year." He also announced the formation of a new Economic

Advisory Council to advise the government on economic policy. Its members will include a former chief of staff to the chancellor of the exchequer and experts from financial companies like J. P. Morgan.

"The British people rightly want stability, which is why we are addressing the serious challenges we face in worsening economic conditions," UK Prime Minister Liz Truss tweeted on Monday.

rejuvenation of the nation, he said, adding that it's the CPC's strong leadership that has led to China's great success to-

UN envoy urges political progress to resolve Syrian crisis

DAMASCUS

THE visiting UN special envoy to Syria, Geir Pedersen, on Monday called for progress on the political front to resolve the Syrian crisis.

Speaking to reporters following his meeting with Syria's Foreign Minister Faisal Mekdad, Pedersen recounted the difficulties facing the Syrian people, saying that despite a ceasefire being established in 2020, many civilians are still being killed, and 15 million Syrians still need humanitarian assistance.

Pedersen made it clear that the UN is still committed to working on providing humanitarian assistance and supporting a nationwide ceasefire, but these two factors are not enough without progress achieved on the political front.

The UN envoy said he and Mekdad discussed ways to establish "confidence-building measures" in line with Security Council resolution 2254 that provides for a roadmap for a political settlement of the Syrian crisis.

"We start slowly but steadily to implement the different provisions of the UN Security Council resolutions, and the good news is that all parties say they are committed. The question is can we build a little bit of confidence so that we are able to move forward," he said.

The two officials also discussed the UN-facilitated Syrian Constitutional Committee, said Pedersen, adding although the mechanism hasn't been working so far, its prospects remain.

The Syrian Constitution Committee was launched in late 2019 in Geneva, as part of the peace process that seeks to reconcile the Syrian Government with its opposition and to revise the Syrian constitution or draft a new one. Since then, it has held several meetings but has yet to agree on an agenda.

China's geospatial industry sees strong growth

FROM the BeiDou Navigation Satellite System tens of thousands of kilometers above the ground, to the map applications in our mobile phones, the rapid technological development has made China's geospatial industry one of the most powerful engines driving the country's digital economy, by highly integrated with smart city construction, digital government, health governance and smart lifestyles.

With geospatial technologies, one can easily find available parking space on a mobile phone via satellite navigation, browse the information of all the companies in an office building through 3D scene platforms, and manage underground pipelines with advanced devices that can "see through" the ground surface.

Recently, the 2022 Conference of Chinese Geospatial Industry and Sciences was held in Hefei, east China's Anhui province.

As the highest-level, largestscale and most influential conference of China's geospatial industry, the event was highlighted by a series of technological advances.

At the conference, Chinese drone giant DJI displayed a dock, which makes drone operations completely automated and unattended. CHC Navigation based in Shanghai presented its latest breakthroughs in long-range laser radar, which made China a step closer to the independent development of high-precision long-range laser radars.

Industry-leading spatial-intelligent infrastructure company Qianxun SI also brought a new technology that helps with the impacts of ionospheric variability on unmanned aerial vehicle surveying, high-precision laser

The Chinese geospatial industry has achieved fruitful results in innovation and shown strong resilience.

According to statistics released by the conference, the total output of China's geospatial industry reached 752.4 billion yuan (\$105 billion) in 2021, up 9.2 percent year on year. The compound output growth rate of the industry stood at 11.5 percent in the recent five years and 17.5 in the past decade.

The constantly expanding industry is driving employment growth. As of the end of 2021, there were over 164,000 entities engaged in the industry, up 18.5 percent from a year ago. Enterprises accounted for 94.7 percent of these entities

cent of these entities.

Around 35,800 entities in the

industry were newly registered last year, up 29.2 percent year on year. Besides, nearly 4 million people were working in the industry as of the end of 2021, growing 18.5 percent from a year ago.

Deqing county, Huzhou, east China's Zhejiang province has established a 3D model of its territory that precisely presents its landscape. Based on the model, the county launched a series of digital applications to assist its farming, disaster management, pandemic control and other work.

In Hefei, geospatial technologies are employed for the ecological conservation of the Chaohu Lake, one of the major freshwater lakes in China. The city has set up a digital platform to share data and trace sources of pollution, which is able to perform

real-time monitoring of water quality and volume, and algal bloom on the Chaohu Lake.

Encouraging the development of smart city construction, digital twin and geospatial technologies will create new opportunities for China's geospatial industry.

Xu Guanhua, former Minister of Science and Technology of China and academician of the Chinese Academy of Sciences, noted that massive geospatial data have been generated and stored through basic surveying, satellite remote sensing and major engineering projects launched over the past years.

Making good use of such data will be a key priority for future development, and making these data serve the demand of the country will accelerate the industry's development, Xu said.

Russian envoy says German authorities crossed the red line with arms deliveries to Kiev

BERLIN

GERMAN authorities should not have crossed the red line with arms supplies to Kiev, given the country's historical responsibility to the Russian people, Russian envoy to Germany Sergey Nechayev said in an interview with TASS.

"The German-made lethal weapons, supplied to the Kiev regime, are used not only against Russian servicemen, but also against civilians. It is certainly a red line that the German authorities should not have crossed, given Germany's historical responsibility to our people for Nazi crimes during the Great Patriotic War," the diplomat stressed. "Not to mention our contribution to the postwar reunification of Germany." he added.

"And one should understand that this red line has always existed in Germany as well," Nechaev pointed out, recalling that for decades Berlin refrained from sending weapons, especially heavy military equipment, to armed conflict zones.

"There was a broad domestic political consensus on this. The practice has changed only now and only with regard to Russia," he stressed. "It was a decision of the new coalition government of Germany, which we consider a serious mistake," the envoy said.

"Of course, such a turn could not help but have a most negative effect on our bilateral relations and the prospects for their development," he noted.

Nechaev warned that "the uncontrolled

pumping of Ukraine with weapons in violation of international arms trade and export control rules only leads to a prolongation of the conflict, new destruction, civilian casualties, and further destabilization of the situation in Europe, including Germany itself."

"There is a real threat of Western weapons from Ukraine, including anti-tank guided missiles (ATGMs) and man-portable air-defense systems (MANPADS), falling into the hands of terrorist groups and extremist organizations," he said.

The Russian diplomat pointed out that "the sale of lethal systems on the darknet is in full swing." "One would hope that common sense would prevail, but so far we only hear about plans for more and more German arms deliveries to Ukraine," Nechaev concluded.

On February 24, Russian President Vladimir Putin launched a special military operation in Ukraine following a request for assistance from the leaders of the Donbass republics.

The West then imposed sweeping sanctions against Russia and ramped up shipments of weapons and military equipment to Kiev by billions of dollars at this stage.

Former Yanga midfielder explains reasons for local players' failure

MTIBWA Sugar attacking midfielder Balama Mapinduzi has opened up on the reasons behind the failure of some local players to make their presence felt once signed by Simba SC and Yanga.

Mapinduzi revealed a lack of trust from the clubs' coaches despite the footballers' hard work has been a challenge to many players, missing out on a chance to play regularly as was the case with their spell in former clubs.

The skilful diminutive midfielder is still remembered, to a large extent, by Yanga fans for his thunderbolt which went straight in when the Iangwani Street side confronted rivals Simba SC in a thrilling Premier League clash in the 2020/21 season which had the clubs locked to 2-2 draw.

Mapinduzi was signed by Yanga for a threeyear contract from Mwanza's Alliance FC and the midfielder played for only one season due to injuries he sustained.

He spent the remaining years of his contract on the sidelines and no agreement for contract extension took place, a situation which brought about his move to Mtibwa Sugar as a free agent.

Mapinduzi was injured in June 2020 after the Mainland Premier League had resumed following the break which was occasioned by the outbreak of the COVID-19 pandemic, and since then he had been sidelined.

When the new season kicked off, Yanga had hoped the player will return to action but it was not the case as he had failed to recover from the injury that saw him stay out for another season.

"There is no player who does not like to be

the best, everyone wants to be great through big clubs like Simba and Yanga, when local players get the chance to be registered and trust is not invested in them by the coaches, it becomes for the players to impress because they rarely get game time, hindering the opportunity to get into the first eleven directly to show what the players have," the midfielder noted.

Balama has started six games for Mtibwa Sugar in the Premier League this season, the player came from the bench in one tie.

The attacking midfielder has yet to score a goal this season, with his outfit winning two outings, settling for a draw in three, and losing two in the seven clashes.

"Many local players have the potential, the problem is failure to win coaches' trust, something that causes many players to find themselves going back to sides they previously served, a problem that has been hurting many of us, but I believe that if we were trusted and played regularly we would have an impact and score goals," Mapinduzi noted.

Speaking about his move to Mtibwa Sugar, he said it is the right place as he has been out of the field for a long time due to injuries, but he believes he will regain his form.

"To be trusted and get a chance to play regularly at Mtibwa sugar is the dream of any player who has not played for a long time," the player pointed out.

The footballer stated: "It will take time to return to my best but this will be enhanced by getting the chance to play every day in competitive matches so that I can regain my confidence and fitness."

Blackmail 'not uncommon' in football, says France star Pogba's agent

PARIS

PROFESSIONAL footballers are frequent targets for blackmailers, says Paul Pogba's agent with the France star embroiled in an alleged extortion plot

In August Pogba's elder brother Mathias published a bizarre video online promising "great revelations" about the Juventus midfielder, who according to sources is being targeted by a criminal gang.

And Rafaela Pimenta, the heir to deceased superagent Mino Raiola's empire, told Italian daily Tuttosport that players are often targeted by people hoping to extort money from very rich sportsmen.

"Being extorted or living under threat is not an uncommon problem with footballers. They're threatened because they are very exposed," Pimenta said in an interview published on Monday.

"Tve seen it all, especially blackmail. The players are scared to flag these things up because they're worried about their image or they're ashamed. They keep quiet and live under incredible stress."

Sources close to the Pogba family

have told AFP that money is being demanded from Paul Pogba if he wants to avoid the dissemination of allegedly compromising videos.

Mathias Pogba, 32, was charged last month along with four other people, all close to the World Cup winner who filed a complaint with Turin prosecutors in July which said he was being blackmailed for 13 million euros (\$12.6m).

Paul Pogba told investigators that his blackmailers wanted to discredit him by claiming he asked a marabout (holy man) to cast a spell on Paris Saint-Germain and France star Kylian Mbappe, which Pogba denies.

"When Paul finally asked for help, his situation improved and he realised that there is a solution," added Pimenta

"Everything is in the hands of the lawyers. Paul has done everything he could do"

On the field, Pogba's hopes of playing for France at the World Cup in Qatar next month hang in the balance after a knee injury. He had surgery that was described as "successful" earlier this month

Man City to avoid charge on fan chants - sources

LONDON

MANCHESTER City will not face sanctions for supporters chanting "Murderers" during Sunday's Premier League 1-0 defeat against Liverpool at Anfield, sources have told ESPN, with the Football Association (FA) powerless to take action unless the chants are deemed to be discriminatory.

Sources have told ESPN that allegations of Liverpool fans throwing coins at City boss Pep Guardiola (pictured) and of away team bus being attacked by objects after the game are also likely to be outside of FA jurisdiction.

However, Liverpool manager Jurgen Klopp could still be charged by the FA and receive a touchline ban after he was sent off during the second half by referee Anthony Taylor.

The FA have condemned the chanting by the City supporters of "murderers" and "Always the victims, it's never your fault" -- both chants relate to the deaths of 97 Liverpool supporters at the 1989 Hillsborough disaster -- but sources have told ESPN that no action will be taken against City for failing to control their supporters unless it can be proved that the chants were discriminatory, such as if they were racially motivated or an anti-gay.

Liverpool issued a statement after the game on Sunday to highlight the chanting and offensive, tragedy-related graffiti in the away section, adding they would work closely with City to "ensure that these chants are eradicated from football altogether."

City are yet to issue a statement in response to Liverpool, although City sources have told ESPN that the chants were an unfortunate consequence of comments made by Klopp in his prematch news conference when he said rival clubs could not compete with the wealth of Gulfowned clubs such as City, Paris Saint-Germain and Newcastle United. City declined to address the matter on the record when contacted by

ESPN.
ESPN has also been told that City's claims of coin-throwing at Guardiola and of their team bus being attacked by objects after the game are

likely to be outside of FA jurisdiction.

If Guardiola was attacked by individuals throwing coins, it will be a matter for Liverpool and Merseyside Police to address. The FA can only act if it is judged to have been a large section of the stand throwing mis-

siles at the City boss.

Claims of the bus being attacked are also due to be dealt with by the police rather than the FA unless the incident happened within the stadium posimeter.

ESPN witnessed City's two buses emerging from Anfield without incident after the game, although City sources have said that the missiles were thrown away from the stadium, further down Anfield Road.



Benzema wins Ballon d'Or; Gavi best U21 player

PARIS

KARIM Benzema was awarded the 2022 Ballon d'Or at a ceremony in Paris on Monday after a stellar 2021-22 season saw him lead Real Madrid to a Champions League and LaLiga double.

Benzema, 34, scored a careerbest 27 times in LaLiga and was top scorer in the Champions League with 15 goals, including hat tricks against Paris Saint-Germain and Chelsea.

He finished ahead of Bayern Munich's Sadio Mane and Manchester City's Kevin de Bruyne, who came in second and third, respectively. PSG striker Kylian Mbappe came in sixth, while Manchester United forward Cristiano Ronaldo was 20th.

"I'm really proud seeing this prize, it's been my dream since I was a kid. I grew up with this in my head, and after that I had the motivation," Benzema said.

"I had two role models in my life: Zizou [Zinedine Zidane] and [Brazil legend] Ronaldo. It's a lot of work; I never gave up and I kept that dream in my head. Anything is possible.

"It's been difficult for me. There was a time when I wasn't playing for the national team, but I didn't give up. It's been difficult for me and that just makes me stronger mentally. I'm really happy with my work."

The France international picked up the prize -- which is awarded by the magazine France Football -- for the first time in his career at a ceremony at the Theatre du Chatelet in Paris.

A day earlier, Benzema opened the scoring as Madrid beat Barcelona 3-1 in El Clasico to go three points clear at the top of the LaLiga table. He is the first Madrid player to receive the award since Luka Modric in 2018, and the first Frenchman to win since 1998 honoree Zidane, who awarded Benzema the trophy.

"I'd like to thank my teammates at Real Madrid and the national team,

my president [Florentino Perez] who is like family to me, and also the Lyon academy and president [Jean Michel] Aulas, thanks to him I fulfilled my dream of playing for Real Madrid," Benzema added.

Lionel Messi won the award in 2019 and 2021, while no Ballon d'Or was given out in 2020 because of the COVID-19 pandemic.

In 13 years at Madrid, Benzema has lifted five Champions League trophies, four LaLiga titles, two Copas del Rey, four UEFA Super Cups and four Spanish Supercopas.

Benzema received widespread recognition for his performances in the Champions League last season, scoring 10 goals in Madrid's knockout stage wins over PSG, Chelsea and Manchester City on the way to winning the club's 14th European Cup.

After a six-year absence from the France national team, he returned to help them win the UEFA Nations League in 2021 and is expected to lead their attack at the 2022 World Cup in Qatar.

Earlier in the ceremony, Barca midfielder Gavi won the Kopa Trophy, the award presented to the best player under age 21.

Gavi, who turned 18 in August, claimed the prize ahead of Borussia Dortmund's Jude Bellingham and Bayern Munich's Jamal Musiala. He succeeds Barca teammate Pedri, last year's winner.

After breaking into the first-team setup at age 16 last year, Gavi went on to make 47 appearances for Barca in all competitions in 2021-22, scoring two goals.

His performances for the Catalan club earned him a call-up to the Spain national team and he became the youngest player to ever represent La Roja, at the age of 17 years and 62 days.

Gavi has since won 12 caps for Spain and is a regular for club and country heading into next month's World Cup.

Meanwhile, Robert Lewandowski won the Gerd Muller award for the best striker of the year, and Madrid's Thibaut Courtois won the Lev Yashin for best goalkeeper.

Ballon d'Or organisers added a humanitarian prize named after the late Brazil midfielder Socrates. The trophy went to Mane for his charity work in Senegal, including building a hospital and donating to Meanwhile, Barcelona midfielder Alexia Putellas has won the Ballon d'Or Feminin for a second successive year, becoming the first woman to win the award twice since it launched in 2018

Putellas, 28, was named the best women's player in the world at the Monday gala in Paris despite being sidelined since June with a torn anterior cruciate ligament.

She finished ahead of Arsenal's Beth Mead and Chelsea's Sam Kerr, who were second and third, respectively. "Without my teammates this would not have been possible," Putellas said after receiving the award. "I want to thank the staff and the coach and everyone involved at Barcelona.

"I'm very happy to be back here and pleased because a year ago I was able to win this prize and it pushed me to want to be even better."

Prior to her injury in the summer, Putellas captained Barcelona to a third successive Primera Division title. The Catalan side made history by winning all 30 of their league games throughout the 2021-22 campaign.

She also led Barcelona to success in the Spanish Super Cup and the Copa de la Reina to complete a domestic treble, although they came up short in the Champions League.

Putellas' strike in the final was not enough to stop French side Lyon from beating Barcelona 3-1 in Turin.

However, after scoring 11 goals in the Champions League, more than any other player in the competition, Putellas was later named UEFA Women's Player of the Year ahead of Mead and Lena Oberdorf.

In addition to those 11 goals in Europe, she scored 18 league goals from midfield, four in the Copa de la Reina and one in the Super Cup.

Putellas had hoped success would follow for Spain in the summer, but she tore her left ACL in training with the national team ahead of the European Championship in England.

She has not played since and is expected to remain out of action for several more months.

Premier League is wide open and even Man United, Liverpool can win something

LIVERPOOL's 1-0 victory over Manchester City on Sunday did more than end the reigning Premier League champions' unbeaten record this season; Mohamed Salah's decisive goal at Anfield also set up the prospect of the most unpredictable and open title race for years.

Only the most optimistic Arsenal supporter would argue against the suggestion that City, champions in four of the past five seasons, remain favourites to win the Premier League again this time, despite Mikel Arteta's Gunners opening up a four-point lead at the top of the table following Sunday's 1-0 win at Leeds and City's loss at Liverpool.

But while the goals of Erling Haaland and the title-winning experience of Pep Guardiola's squad give City the edge, there is a distinct sense that all of the so-called Big Six, and an emerging Newcastle United, are capable of achieving their respective ambitions this season.

Arsenal could yet surprise us all by emerging as champions. Leicester City in 2015-16 and Blackburn in 1994-95 both held their nerve to capitalise on strong starts and end the campaign by raising the Premier League trophy and Arsenal have now given themselves a cushion and momentum to go all the way and win a first title since Arsene Wenger's "Invincibles" in 2003-04

Meanwhile, third-placed Tottenham Hotspur's 2-0 win against Everton on Saturday confirmed their best start to a season in the Premier League era -- it is their best start for 59 years -- yet Antonio Conte's side have so far managed to avoid the spotlight and scrutiny that comes with challenging for a title. With Harry Kane's goals (nine in 10 games) and Conte's track record of having won titles in England and Italy (with Chelsea and Juventus), Spurs are contenders and their trip to Manchester United today will offer a true gauge of both clubs' prospects this season.

United, who are in fifth position after Sunday's goalless draw against Newcastle at Old Trafford, are clearly still some distance from being title

challengers, but perhaps for the first time since Sir Alex Ferguson retired in 2013, they appear to have a manager with a coherent plan to take the club out of its decade-long malaise. Erik ten Hag has plenty of rebuilding to do, but his summer signings, particularly Lisandro Martinez and Christian Eriksen, have significantly improved the team and United look to be a club that, finally, have everyone pulling in the same direction.

They won't win the league this season, but victories against Liverpool and Arsenal so far show that United can rise to the occasion and, therefore, foster hope that they could win a cup and end a six-year silverware drought.

Just over a month ago, suggesting that Chelsea could enjoy a successful season would have seemed outlandish following the firing of coach Thomas Tuchel after three defeats in seven games. But since appointing Graham Potter as Tuchel's successor, Chelsea have won five out of six under the former Brighton manager.

If they win their game in hand, Chelsea would move to within a point of Spurs and City and, having spent over £250 million on new players this summer, begin to look like a team that has just enjoyed a period of major reinforcement.

And although Liverpool are the one team in the Big Six that are unquestionably underperforming this season, winning just three of nine Premier League games to sit eighth, last week's 7-1 Champions League demolition of Rangers and Sunday's win against City proved that Jurgen Klopp's team are still a side capable of beating anyone and winning any competition.

Klopp has a midfield to rebuild, there are defensive issues to address and £75m club-record signing Darwin Nunez has endured a difficult start to life in England, scoring just four goals in 11 games, but despite all of Liverpool's problems, they are still one of the best teams in the world and capable of anything this season.

Newcastle, under Eddie Howe, are the big threat to the established Big Six due

to the immense wealth of their Saudi Arabia-backed owners. In time, Newcastle $\,$

could go on to dominate as City have done in recent years if they are as astute and ambitious in terms of player recruitment. We are still some way from Newcastle being title challengers, they are overperforming so far this season (sitting in sixth position) and will be able to accelerate their plans by attracting better players if they secure European qualification.

There has rarely been such a Premier League season when all of the major clubs are in a position to win something. Throughout the 30-year history of the competition, there has often been one or two dominant teams, a couple in a period of transition, with the others lurching from one crisis to another.

Liverpool, United and Arsenal have all enjoyed great success, but also seasons of despair, while City and Chelsea were nothing more than also-rans – City spent a season in the third tier in 1998-99 – prior to each club being acquired by billionaires who transformed their fortunes and the makeup of the Premier League. Tottenham are still waiting for years of promise to come to fruition, while Newcastle's hopes of recreating their exciting times under Kevin Keegan in the mid-1990s looked to be a distant dream until the Saudi takeover 12 months ago.

But for the first time, the stars are aligning for all of the top clubs to be competitive during the same period. City's dominance might continue this season, but the 2022-23 season feels like a campaign that will signal a new era and could define what happens, and who wins, for the next 10 years.

Yanga faces trip to Tunisia for 2022/23 **CAF Confederation Cup playoff**

TANZANIA'S Young Africans SC has discovered the outfit's next opponent in the CAF Confederation Cup, as the club attempts to qualify for the group stages of the 2022/23 edition of the continental competition.

Following a draw conducted by CAF in Egypt on Tuesday afternoon, it has been confirmed that the Green and Yellow club, alias Yanga, will face Tunisian outfit, Club Africain.

This represents another toughest test yet for the Jangwani Street side, which has failed to win in previous outings on Tunisia soil.

It will be the second time this season that the Tunisian club plays a Tanzanian side after eliminating Zanzibar's Kipanga in the 2022/23 CAF Champions League first preliminary round.

They eliminated Kipanga with a 7-0 aggregate score over two legs, as the first leg held in Zanzibar culminated in a 0-0 draw and the second leg had Club Africain trouncing Kipanga 7-0.

In 1991, Club Africain became the first Tunisian team to win the CAF Champions League. They have won the Tunisian Premier League 13 times, the last time being seven years ago.

The Tanzanian representatives, Yanga, were knocked out of the 2022/23 CAF Champions League after losing 2-1 on aggregate to Sudanese giants Al Hilal SC.

They return to the 2022/23 CAF Confederation Cup for the sixth time in their history, having last competed in 2018 where they reached the group stage.

Victory for Yanga over the Tunisians will ensure that they enter the group stage for the second season running after exiting in the quarterfinals in their last at-

Yanga will host the first leg scheduled to take place on November 2, while Club Africain will host the second leg to be played on November 9.
