JPM blasts municipality staff exploiting traders

GOVERNMENT officials allocated themselves stalls at the newly-built modern market in Morogoro municipality for lease, pocketing 30,000 per month from traders.

Launching the 17bn/- facility yesterday, President John Maguuli ordered all state officials who engaged in the corrupt dealing to cough up all the monies they received from genuine traders if they want to continue in government employment.

The president said that he had established that civil servants from the municipal council, the office of the regional commissioner as well as district commissioner are the main beneficiaries of the government funded project and not traders as intended.

While the construction was going on, state officials colluded to allocate themselves the slots and leased them to real traders at 50,000/- instead of the official 20,000/-, he

"Imagine civil servants earning 30,000/per month from a project that was meant to benefit traders. This is corruption," he asserted, expressing anger with the practice, saying that it was sad that it was taking place at the watch of the RC and the DC who are his representatives.

Kiswahili replaces English as main language in courts

THE government has tabled in the National Assembly the Written Laws (Miscellaneous Amendments) Act, 2021 which will among other matters change The Magistrates' Courts Act to allow shifting of legal materials from English to Kiswahili.

However, a statement signed by the Clerk of the National Assembly, Stephen Kagaigai (pictured) said the Constitution and Legal Affairs Committee will today start hearing stakeholders' opinions on the proposed bill as part of legislative procedure, in accordance with Parliamentary Standing

The tabled bill proposes amending two other laws, namely the Interpretation of Laws Act, Cap.1 and the Land Disputes Courts Act, Cap. 216.

The proposed amendment in Section 84 (6) of the Act states that "the minister

TMA sees five days storms in 13 regions

Tanzania Meteorological Authority (TMA) has predicted heavy rains accompanied by strong winds and coastal high tides, all this over 13 regions for up to five consecutive days.

A statement released yesterday by the weatherman said that Dar es Salaam, Coast (including Mafia Island, Tanga, Mtwara and Zanzibar (Unguja and Pemba) are today expected to see strong winds of up to 40 kilometres per hour and high tides of up to two metres.

The forecast named other regions that will receive heavy rains in the course of five days as Lindi, Ruvuma, Njombe, Mbeya, Iringa, Rukwa, Songwe and

southern parts of Morogoro.

The forecast says five days of heavy rains in most parts of these regions was likely to have started yesterday.

"The weather will cause disruptions in areas like marine transport and fishing. Residents of the aforementioned regions are advised to take precautionary measures to avoid possible adverse impact," the agency noted.

TMA director general Dr Agnes Kijazi who is also third vice-president of the World Meteorological Organization (WMO) yesterday led the second conference of the Panel of the WMO Enabling Central Committee.

PM discounts salary review

Says inflation worse for workers altogether

THE government has said it will continue improving the welfare of civil servants but not initiate salary rises, to avoid hiking the cost of living.

Prime Minister Kassim Majaliwa told the National Assembly in his impromptu question and answer session yesterday that whenever the government announces salary changes for civil servants; automatically the cost of living goes high as businessmen hike the cost of various goods.

This negatively affects all the people, he stated, noting that apart from salary hikes, there are multiple ways of improving employee welfare such as promotions

and reduction in tax deductions from double digit to single digit brackets.

"The government lowered workers' Pay as You Earn (Payee) deductions to single digit, and we are continuing to take other initiatives that are beyond salary increases, for the greater interest of the working class," he asserted.

He acknowledged the role and efforts of civil servants in national development, asking them to continue working hard as the government is working on their needs.

"This approach is a way better than adding some 20,000/- or 30,000/- in salaries. These options increase the take home package of an employee for a living. We don't want to affect the cost of living

responsible for legal affairs may make regulations prescribing circumstances and conditions where a law may be in a language other than Kiswahili language."

The changes will ensure that proceedings and rulings in courts, tribunals and other bodies charged with dispensing justice shall be in Kiswahili.

Under the Interpretation of

Laws Act, Cap.1, Kiswahili will be where the dispensation of justice declared the language of the laws of the country and the language to be used in the administration and dispensation of justice.

"The use of Kiswahili will facilitate the realization of access to justice by all. The amendment further gives power to the Minister responsible for justice in consultation with the Chief Justice to determine circumstances and conditions

may be made in a language other than Kiswahili," read part of the

Speaking at the opening of this year's Tanzania Law Day week and the 100th anniversary of the High Court, Vice President Samia Suluhu Hassan said the executive and the judiciary have agreed to fully switch the legal system and legal materials from English to Kiswahili.

The VP said that it was unjust to deny justice to a group of the citizens on the grounds of a language barrier because rural residents are unaware of most legal processes, thus limiting access to justice in their communities.

At least 70 percent of court proceedings in the country are run in Kiswahili, with legal materials such as judgments still being recorded in English.

UNFPA elevates climate action to safeguard women and girls

THE impact of climate change is already being felt and is projected to intensify significantly over the next 10 years.

During the Nairobi Summit in Kenya in 2019, a signature session on climate change adaptation and justice focused on the centrality of solutions driven by and aimed at safeguarding the wellbeing of women and girls, young people and marginalized groups, who bear the brunt of climate change and environmental degradation.

Fast forward to 2020: the COVID-19 pandemic has exposed systemic vulnerabilities, and lack of inequalities, protection, bringing new threats to and new impacts for women and girls, young people and, indeed, all people. UNFPA is stepping up its game to ensure that adaptation responses are rights focused, gender sensitive and people centered.

"Women and girls suffer from vulnerabilities exacerbated by climate change, including rapidly expanding food insecurity, inadequate access to safe, clean water and improved sanitation, and inadequate access to essential health and gender-based violence services," said Diene Keita, UNFPA Deputy Executive Director -Programme.

"We must protect progress on the transformative results from the effects of climate change, and we must enhance our humanitarian preparedness and response to climate-related emergencies," said Keita.

She made the remarks during a recent webinar, UNFPA and the Climate Crisis: Strengthening Resilience and Protecting Progress within the Decade of Action, organized by the UNFPA Climate Change Working Group.

The webinar presented UNFPA's value proposition and provided direction for engagement and discussion with climate change champions and activists such governments, youth-led organizations, donors and civil society groups, with a clear offer of support on climate change policies and actions.

Working with champions for a better world

It is imperative that we move with speed to implement climate action as we build stronger, safer and more resilient communities and systems that will safeguard the livelihoods of all, including women and girls, to ensure that no one is left behind.

"Climate change development emergency and it has the potential to derail the achievements of our transformative results, so indeed, we need to step up," said Dr. Julitta Onabanjo, UNFPA Regional Director for East and Southern Africa.

Policy experts challenged to put together strategies for better results in agriculture

EXPERTS in policy, research and agriculture have been challenged to come up with strategies that could bring in more benefits and better results for the development of Tanzanians.

Permanent Secretary in the Ministry of Agriculture, Gerald Kusaya issued the challenge yesterday at a meeting that brought together experts in policy and research on agricultural crops from the Mainland's Ministry of Agriculture and Zanzibar's Ministry of Agriculture, Irrigation, Natural Resources and Livestock.

The two-day meeting offered the opportunity to the experts to discuss cooperation between the two ministries.

Kusaya called on the experts to supply answers to some of the

challenges in the agricultural crops sector, saving Tanzanians from both sides of the Union expect to benefit from positive results from the economic sectors agriculture and fisheries in particular.

Earlier, the meeting's chairman, the representative of the Director Policy and Planning Department from the Mainland's Ministry of Agriculture, Irene Lucas said the meeting will dwell on several resolutions, including that of cooperation in research, training and issuance of copyrights to innovators.

Other resolutions include provision of joint training to agricultural experts on the crops pests control.

Another resolution includes extending cooperation in the areas of irrigation, farming equipment, joint policy and planning and crops development.

Agricultural Development Bank (TADB) Managing Director Japhet Justine said experts from the Zanzibar Agriculture ministry wanted to know the procedure in accessing loans for agricultural development.

He said TADB is a public institution for all Tanzanians and it is strategic for the development of the sector, and has been in close relationship with the Zanzibar government, whereas in 2019 it provided 6.6bn/- in loans in support of purchase of cloves from farmers before being exported. He said the bank was ready to provide loans towards all agricultural projects that are seen to economically empower Tanzanians, hence, he said all Tanzanians were welcome.

Govt working on possibility of setting uniform fee for relaying water in rural areas - Majaliwa

Kassim Minister Majaliwa said yesterday that the government is conducting an assessment on the possibility of setting a uniform water connection fee in rural areas.

follows successful implementation of the rural electrifying programme under the Rural Energy Authority (REA) whereas the government has set a 27,000/- power connection fee as a uniform cost per a household.

"Theministry of water is working on it and upon completion of the assessment, it will issue an official communication to announce the cost of connecting water services to all the households in the country," said Premier Majaliwa as he was responding to a question from Vunjo legislator, Dr Charles Kimei (CCM) on the need for the government to cut the cost of connecting water services in rural

The lawmaker claimed that in some parts of the country, the cost of connecting water stands at between 300,000/- and 600,000/- **water service**

per household, the amount which acknowledged being is unaffordable to most of the rural dwellers.

Dr Kimei added: "Due to the high cost of connecting services to rural areas, most villagers have decided to use water from other sources including streams."

He asked for the possibility of the government, through the ministry of Water and the Rural Water Supply and Sanitation Agency (RUWASA) to apply the modality used by REA in lowering the cost of connecting the service at the uniform charges in all villages.

Reacting, the Premier



Despite the challenge, the government through water authorities has set the normal charges for all

of the variance in the cost of connecting water infrastructure at households, assuring legislators that the ministry of water is working on it.

Majaliwa reiterated government commitment to continue working to increase the supply and accessibility of the precious liquid across the country. He however admitted that there are challenges in availability of reliable water sources in most parts of the country.

"Despite the challenge, the government through water authorities has set the normal charges for all people to access water service. There are also challenges on the distance from the source to the final consumer, this contributes to the variance in the cost of connecting water to the villagers," elaborated the Premier adding to address the shortage, the government is constructing water centres for the villagers to access the service at once.

He said the established water centres reduce the cost of the precious liquid.

Govt to construct markets at border posts

THE government has embarked on construction of markets at various border posts to facilitate trade with neighboring countries and guarantee market for farmers' crops.

The facilities currently constructed at the Hororo border post in Kilimanjaro Region, Kagunga in Kigoma Region and the 3.5bn/- market at Nyakanazi in Kagera Region will also include zonal markets.

Prime Minister Kassim Majaliwa made the statement in the National Assembly adding the market at Kagunga in Kigoma

Region will facilitate trade between Tanzania, Burundi and Rwanda while the Nyakanazi market will ease trading activities between Tanzania, Rwanda and Democratic Republic of Congo (DRC).

He said the government is now consulting officials in Zambia and DRC for the countries to start purchasing agricultural crops produced in Rukwa Region.

PM Majaliwa was responding to a question from Special Seats MP, Neema Lugakingira (CCM) who raised concerns over lack of markets for agricultural crops. She asked government plans to ensure availability of markets for farmer's crops.

In his response, the Premier insisted that efforts are done to market Tanzania's agricultural crops abroad through embassies. He said that each of the embassies have been tasked to promote the agricultural crops and look for markets.

"We have been using our embassies to promote our crops; the strategy has been successful as many crops are now exported to various countries," said the prime minister.

He informed that other strategies to ensure market and good prices for the crops includes introduction of the warehouse

receipt system which is now applicable for different crops.

The warehouse receipt system requires farmers to deliver their crops to primary cooperative societies whereas the warehouse operators accept the deposit of crops in the warehouses and provide a receipt to the farmers.

Under the system, farmers receive part of the payments through bank financing based on the receipts.

"Farmers have been getting the best prices through the warehouse receipt system," he said adding that measures are taken to improve the market systems.

Needy households to access health services more easily

SELEMANI Jafo, minister of State, President's Office (Regional Administration and Local Government) has launched a new initiative meant to distribute improved Community Health Fund (iCHF)/ Tiba kwa Kadi (iTIKA) cards to vulnerable households.

The programme will be implemented in partnership with the United States Agency for International Development (USAID) and The President's Emergency Plan for AIDS Relief (PEPFAR), through their KizaziKipya ("New Generation") project, which supports orphans and vulnerable children.

Speaking during the launching event, minister Jafo extended his gratitude to the United States government through PEPFAR/ USAID for the support vowing that the government of Tanzania will continue to work hand-inhand with partners to ensure marginalized groups access quality health services where and when they need it most.

He said that iCHF/iTIKA health insurance cards cover the costs of general health services, including child health services.

He noted that the USAID Kizazi-Kipya project has subsidized the first year of premiums worth a total of 4.7 billion Tanzanian shillings (\$2 million USD).

"To ensure that these vulnerable populations can pay for the modest premiums in subsequent years, USAID KizaziKipya helps these households increase their income by supporting them to set up small businesses and engage with savings and lending groups," he said.

The USAID KizaziKipya will use its existing networks to provide iCHF/iTIKA cards to nearly 93,000 vulnerable households with a total reach of over 360,000 people.

The supported households come from 85 councils across 25 regions in Tanzania. Primary beneficiaries from this service include those with children living with HIV, child-headed households, households with elderly and chronically ill caregivers, and extremely poor households unable to meet the basic needs of their families.

USAID Mission Director, Andy Karas, urged the government to continue investing in the health sector to improve health services for marginalized populations.

"Investing in healthcare is a strategic decision to promote inclusive economic growth. When people have access to quality healthcare and education, they live healthier and more productive lives." he said.

The Mission Director commented on PEPFAR's collaboration with Tanzania in their efforts to achieve HIV epidemic control. "For total HIV epidemic control, we will continue to strengthen our partnerships with the Government of Tanzania and civil society to advance sustainable, local solutions to ensure that the most vulnerable Tanzanians can access quality healthcare."

Don't despair, get ready for upcoming elections, Zanzibar women told

ZANZIBAR women who lost last year's general election should not despair and instead have been asked not to give up and prepare for the upcoming 2025 elections.

The call was made here yesterday at the meeting that involved some of the participants, who are taking part in the 'Male Change Agent' project, which is being implemented by Tamwa-Zanzibar, with the support from UN Women. The project is aimed at encouraging Zanzibar women to actively participate in decisionmaking bodies.

One of the participants from Unguja North Region, Hassan Jani said some people in the community are not giving priority to women and leadership and that they need to be transformed so that they can provide more opportunities and support

He said despite the hard work of encouraging women to take part in the last year's election, many women have failed to achieve their goals of becoming leaders due to lack of solidarity in the community, noting: "Solidarity is the main way that would uplift all women candidates."

He further said the issue of solidarity and peace in various areas will enable more women to be accepted and empowered while continuing to educate the community more to see the importance of supporting women.

In another development, he said that while many areas are still waiting for the appointment of new regional commissioners, they have a responsibility to look into the issue and the importance of women's participation in the appointment of new posts.

He said that despite the existence of a movement to empower women in leadership positions, still some community members have little understanding and feel women should not be leaders.

Another participant, Almas Mohamed Ally, said there was a need to influence people at the higher levels of the parties, which make decisions to approve candidates. He also urged political parties to ensure that women are given priorities when it comes to the election so as to increase the number of the group in decisionmaking bodies.

For her part, Ukhty Amina Salum Khalfan from the ministry of Education and Vocational Training in Zanzibar said that there are some people in the community including clerics, who still have an attitude that oppresses women when it comes to leadership, something that needs to be changed.

JUMAZA files case against Z'bar alcoholic drinks' control board

ZANZIBAR Council of Imams (JUMAZA) has decided to file a court case against Zanzibar Alcoholic Drinks Control and Advisory Board following the latter's issuance of licences to eight firms to import alcoholic drinks instead of three as provided for under the 2020 law on alcoholic

Addressing reporters here vesterday, the community's advocate from Mohas Law and Advocates Chamber, Omar Sheha Omar said the intention for petition has been submitted to the Chief Secretary and the Zanzibar Attorney General on February 8 this year.

He said JUMAZA has decided to file the case following violation of Sections 28(k) and 33(1) of the Zanzibar Alcohol Control Act (No

9 of 2020). "Licenses for the import of alcoholics drinks will be given to Drinks Control and Advisory

not more than three importers on laid down conditions, including the importer must be a Zanzibari, must be a tax payer, must have a warehouse and vehicle(s) for distribution," he said, quoting the relevant legislation enacted last

He said the aim to revoke the previous 1928 law (Cap 163) and

enact a new law was a result of many complaints from the people. He said the Zanzibar Alcoholic Board has failed to respect Section 28(k) of the Act that has set a condition for bars to be more than 1,000 metres away from areas with basic social services including schools, health centres, mosques, churches, madrassas markets or bus stands.

"The case will be filed under a certificate of urgency due to its importance after having been satisfied that the Zanzibar Alcoholic Drinks Control and Advisory Board violated the parent Act for licensing eight alcoholic drinks importers instead of three," the advocate.

He said all the evidence has already been gathered including the identification of the licensed importers, including the bars that have been licensed, some of which close to houses of worship and schools.

For their part some members of the House of Representatives who participated in enacting the legislation said they were depressed by the decision of the Zanzibar Alcoholic Drinks Control and Advisory Board that violated the aims in the enactment of the

However, the Chairman of the Zanzibar Alcoholic Drinks Control and Advisory Board Abdulrazak Abdulkadir said they decided to place the law aside for the interest of government revenues, by increasing the number of alcoholic drinks importers from three to eight.

East African countries called on to improve infrastructure to hasten cross-border trade

THE East African Business Council (EABC), a private sector investment lobby on Wednesday called for prioritisation of infrastructure development at border posts to facilitate seamless flow of goods and movement of persons as cross border business rebounds.

Peter Mathuki, CEO of EABC, particularly stressed improvement of the infrastructure at Kenya's Busia One-Stop Border Post via the construction of a fourlane road to ease cargo clearance.

"The first lane should be to transport general cargo. The second lane to be used by passengers. The third can be for fresh produce and the fourth for hazardous products," Mathuki said in a statement.

The EABC official said poor infrastructure continues to be a huge trade barrier in East Africa and a major constraint to regional integration and development.

Mathuki who had visited the Busia One-Stop Border Post (OSBP) urged revenue authorities to install cargo scanners at border points to facilitate trade.

He said the OSBP is efficiently operating with only a kilometer truck traffic holding an average of 55 trucks.

He said nearly 1,000 trucks were moving goods through the border on weekdays with the number increasing to 2,000 trucks on weekends and reiterated the need for parking spaces to be built for cargo trucks near the Busia OSBP.

In October 2020, truck traffic snarl-up to the Busia border exceeded 15 kilometers, disrupting cross-border trade and escalating the cost of doing

Mathuki said insufficient parking space for cargo trucks along the northern transport corridor trunk routes still poses a safety challenge for the traders and border communities.



decades-old Tanzania Posts Corporation (TPC) is a headache that all holders of the portfolio under which it has fallen over the year have had problems sorting out how to treat or cure.

It was in the early days of this century that the postal mode of delivery of letters, packages and other luggage more or less ran out, with scant use of either post office boxes to start with.

In addition, the onset of a free market opened a channel where private couriers had more direct affinity with service demanders in a way that could scarcely be expected in post offices; mass migration ensued to new service providers.

And even then there only was 'carcass' being fought over, namely, the parcels freight business, earlier taken up by 'upcountry' bus operators (from the city of Dar es Salaam and back to the city), and then commercial couriers with whom contracts could be signed for more dependable relationships.

It was a time that offices were retrenching non-essential staff and using a contractual mode of service delivery, as such method was a saving; these specialised firms employed casual labour, not salaried employees.

With all these changes, it became especially difficult to see how Posts as a profession fits into this arrangement.

But authorities either in the posts corporation or in the government have not tired figuring out how to go about it, but there are differences as to how this matter is handled.

That obviously leads to losses, constant appeals for subsidies, and thus inability to deliver dividends to the Treasury.

This is precisely the sort of operational format that the government finds increasingly difficult to tolerate, for it amounts to setting up a welfare scheme for a certain category of citizens specialised in postal office skills.

That is evidently no way of running a modern economy and amounts to a shambles that those employed won't necessarily see as negative until someone else looks at their books of accounts and annual returns to really appreciate the seriousness of the situation.

That is what the government has lately been doing, and newly appointed Communication and Information Technology minister Dr Faustine Ndugulile has pointedly raised the matter with the TPC Workers Council, issuing clear instructions.

He said that the law governing the corporation is obsolete and not in tune with the current environment, and hence the need for its review and a major overhaul of the corporation.

Meanwhile, as such changes are awaited, there are shuffles of a regulatory character that the minister wants the board and management to carry out. However, chances are that they will hardly be any real changes

- unless there is a new set-up in tune with the changes the minister indicated. It is some wait and see game here.

HE pledges countries made to reduce emissions as part of the 2015 Paris agreement are woefully inadequate, and the world must nearly double its greenhouse gas-cutting goals to avoid the most catastrophic effects of climate change, according to just-released research findings.

"The commitments are not enough," said Adrian Raftery, a University of Washington statistics professor and coauthor of the study, published in Communications Earth & Environment.

The study found that even if countries were to meet their existing pledges, the world has only about a 5 per cent chance to limit the Earth's warming to "well below" 2 degrees Celsius (3.6 degrees Fahrenheit) over preindustrial levels - a key aim of the international agreement.

Raftery and a colleague calculated that global emissions would need to fall steadily - about 1.8 per cent each year on average - to put the world on a more sustainable course.

He said that, while no two countries are alike, that amounts to overall emissions reductions roughly 80 per cent more ambitious than those pledged under the Paris agreement.

In many respects, the race to slow the Earth's warming is a daunting math problem. Emissions have risen by about 1.4 per cent annually on average over the past decade, not including last year's abnormal plunge driven by the coronavirus pandemic.

In 2019, the world logged the highest emissions ever recorded, at 59 billion tonnes of carbon dioxide equivalent emissions, a category that includes not only carbon dioxide but also methane other climate-warming agents.

If that trend continues unabated, scientists say, the world could begin to cross troubling climate thresholds within the coming decade.

The architects of the Paris accord and numerous world leaders have long underscored that the pledges made in 2015 were not enough to limit warming to acceptable levels. The expectation was always that nations would grow more ambitious with time, and there is evidence that is happening.

But as global emissions have continued to rise, as countries have failed to hit even modest targets and as the consequences of a warming world have become more tangible, the push for leaders to act more aggressively has become only more urgent.

"Time is running out," Niklas Höhne, a German climatologist

founding and interview, warning: "The longer we wait, the more difficult it will be to turn emissions downwards."

Höhne is also part of the team behind Climate Action Tracker, an effort that tracks what cuts countries have vowed to take and how they are, or aren't, living up to those promises.

He said that, with the pledges countries have made, the world is currently on pace to reach 2.6 Celsius (4.7 Fahrenheit) of warming by the end of the century. But, based on measures they have actually put in place, the figure is closer to 2.9 Celsius (5.2 Fahrenheit).

At either level, scientists say humans would be forced to grapple with ever more extreme weather events, crippling heat waves and wildfires, and disastrous levels of flooding that could leave some coastal

communities uninhabitable. The level of ambition necessary varies greatly between countries, Raftery said, noting that the United States would need to increase its existing goal by 38 per cent to do its part towards achieving the 2C goal.

The UK, which has already made progress on its promises, would need a boost of about 17 per cent. Countries such as Brazil, which have seen emissions climb despite promises to scale them back, would meanwhile need bolder action to make up for lost

Kelly Levin, a senior associate at the World Resources Institute, noted that the research referred to did not take into account more recent policies that some large countries have adopted or have already begun to implement, and which could put the world on a more hopeful path.

"Given the recent momentum we have seen - for example, from the (US President Joe)

> Still, she said, by any calculation there remains "a wide gulf between where emissions are headed today" and where they need to be to avoid the worst impacts of climate change.

> The findings also echo the ones published late last year by the UN Environment Programme to the effect that nations would need to "roughly triple" their current emissions-cutting pledges to limit the Earth's warming to "well

below" 2 degrees Celsius. To reach the loftier goal of holding warming to 1.5 degrees Celsius (2.7 degrees Fahrenheit), that report found, countries would need to increase their targets at least five-fold - a change that would require rapid and profound shifts in how societies travel, produce electricity and eat.

A critical moment will arrive later this year when leaders from around the world assemble in Glasgow for a UN climate conference, which was delayed for a year owing to the coronavirus pandemic.

Presidents and prime ministers around the globe already are facing pressure to show up with more ambitious pledges in hand.

Some of the world's biggest economies have said they intend to do just that. China, the world's largest emitter, has promised to reach zero net carbon emissions by 2060. For its part, the European Union has said that it intends to cut emissions "at least 55 per cent" from 1990 levels by the end of the decade.

More than 125 countries, representing more than twothirds of global emissions, have either adopted or are discussing century, Höhne said.

The US, which is rejoining the Paris accord after President Donald Trump withdrew from it last year, has not yet formally submitted a new pledge. But President Biden has made clear that he will aim to put the world's second-biggest emitter on a path to net zero emissions by 2050, while also decarbonising the electricity sector by 2035.

"President Biden knows that we have to mobilise in unprecedented ways to meet a challenge that is fast accelerating. And he knows that we have limited time to get it under control," US climate envoy John F. Kerry told an online summit last month.

UN Secretary General António Guterres has meanwhile continued to press nations to go further and faster, as the world has already surpassed 1 degree Celsius of warming.

"The drive for net zero emissions must become the new normal for everyone, everywhere," Guterres said in a speech on Monday, adding: "At the same time, all commitments to net zero must be underpinned by clear and credible plans to achieve them. Words are not enough."

Raftery said that while the findings of the study might initially seem discouraging, he sees glimmers of optimism: "Major countries are promising bold action, markets are moving away from fossil fuels, businesses are paying attention to climate concerns and upcoming stimulus funding could prioritise greener investments."

"I'm a bit surprised in a way to see it's not as hopeless as I would have felt three years ago. It's a heavy lift, but it's not impossible," he said of the changes needed to alter the world's course.

Freedom fighters' routes are vital African heritage

PUZZLE is being set up by Tanzania, Africa and **L**other regional states in the form of a proposal by South African President Cyril Ramaphosa and supported by Tanzania - that the world should formally recognise the routes used by freedom fighters as part of world heritage.

We say it is a puzzle because the world or, rather, United Nations institutions recognise freedom around the world and sovereignty though they are not in a position to exalt armed struggles per se.

The reason is that the UN was created to foster peace among nations and the peaceful resolution of conflicts within nations and among nations, including equal rights.

All the same, this particular proposal shows how far Africa and the world have come from the days where Southern Africa liberation movements were seen as terrorist crusaders.

The new US authorities are restoring relations with the UN agency helping Palestinian refugees, who have opted not to be citizens of other countries more than 70 years after Israel was created.

The reason is an intractable character of the Middle East issue, and the whole issue of designating those movements as terrorists or freedom fighters is up to each country to decide, and UN agencies only seek a minimum of consensus.

That minimum is achievement of democratic objectives by peaceful methods, not through

So there is something of excessive ambition in the proposal, where the factually valid element is that these routes are a heritage site, for Southern Africa first and Africa by extension, and sympathetic groups around the world especially of African heritage in the vast Diaspora.

But asking UN agencies to take up such relics or artifacts as part of the world body's own heritage opens a can of worms that sours the amicable ties that these countries have with Western countries and UN agencies.

Indeed, the region doesn't need cash from any UN agency to keep these routes known, for instance by raising them to usable road level with light tarmac surface if it is deep in rural areas as in Mtwara (Tanzania) and Cabo Delgado province (in Mozambique) or from any point in Zambia to Botswana and on to Namibia. It would mean a minor infrastructure project and a proper survey if the tracks

In the wider international setting, such a proposal for wider recognition of these routes can be directed at organisations with the same outlook as the old Non-Aligned Movement - say, the South Centre previously chaired by Mwalimu Julius Nyerere.

There is also the UN Decolonisation Committee which, by a separate resolution, can make these tracks a heritage site, while in the UN General Assembly or UNESCO the level of dissent might be much higher.

And it is this sort of affinity that would lead to repeated discord between the US and UN organisations, like when the US withdrew from the World Health Organisation on account of a psychological tussle on the origins of Covid-19.

My end of mandate reflections – AU youth envoy

T has been an honour to serve Africa's youth as the first African Union (AU) Special Envoy on Youth for the past two years and to engage thousands of youth from around the continent and the diaspora.

It has been an honour - in the process - to visit countless cities and communities to learn from brave and passionate young people, listen to their stories of agency and hope and explore how the AU can better support their crucial work.

These are young people that I shared a cup of tea with at the many youth engagements: we cried together at the struggles we went through, we laughed and danced together, we shaped the Office of the Youth Envoy (OYE) into what it has become today, by "Shaking Things Up".

In the two years of our term, my team and I have demonstrated that young people are up to the challenge. Looking back to the Banjul+10 meeting in the Gambia, where the idea of a Youth Envoy was first broached, a lot has since happened.

We have seen the AU evolve because of growing numbers of young people within its structures using the arts, technology and advocacy to advance the development agenda.

The 2019/2020 Action Plan, which was the result of six months of consultations with young people, guided our work throughout the mandate. During our tenure, we built collaborations with over 170 partners and elevated the African youth agenda by launching a number of national, regional and global initiatives.

In 2020, when many were still trying to comprehend the outbreak of Covid-19, at OYE, we immediately adopted the 'new normal'. With young people, we mobilised to ensure mainstreaming of the youth agenda in various AU member states, ensuring that the activities, missions, consultations and Intergenerational Dialogues continued.

I look back on two years of important advances, but I would like to share ten key milestones.

One: In the last two years, starting from within the (AU) commission, we solidly anchored youth platforms in the different departments - notably, the Saleema Youth Victorious Ambassadors and African Youth Ambassadors for Peace.

We worked with various AUC departments, directorates and organs engaging all commissioners to champion the youth agenda in joint advocacy efforts - including on ending female genital mutilation and early child marriage as well as putting youth central to the African Free Trade Area (AFTA), Free movement protocol, Digital Transformation, Diaspora engagement, to mention a few.

Two: In an effort to bring the AU closer to the grassroots, together with the Youth Advisory Council, we undertook 73 missions to 35 AU member states and global platforms and we reached over 80,000 youth through town halls, meetings and consultations and over 160 government officials - including in Ethiopia, Zimbabwe, Senegal, Morocco, Namibia, Côte D'ivoire, Eritrea, Uganda, Liberia, Chad, Egypt, Kenya and Mauritania.

During the recent Africa Youth Day (November 1) com-



memoration, I also joined the young peacebuilders of South Sudan's Rumbek community at the Weapons Collection Site where over 1000 guns were collected in voluntary disarmament.

Prior to this visit, I had also spent a day with displaced youth at POC 3 Equatorial State in the South Sudanese capital Juba, where we discussed youth engagement in that country's revitalisation and peace process.

Three: In my role as the AU Youth Envoy, I used every platform within reach to bridge the generation gap and bring youth to the table - and it is working! We hope OYE will be remembered for building the foundation for "Intergenerational Co-leadership" as an approach to the reforming of decision-making and prevent emerging conflicts.

We consistently advocated for collaborative leadership between generations in governments and regional structures. This led to an increase in youth participation in member states' delegations at the AU Summit in 2020, and an increase in the number of youths occupying ministerial portfolios and parliamentary seats in Chad, Namibia, Sudan,

South Sudan, Ethiopia, Kenya and Angola, among other countries.

We institutionalised intergenerational co-leadership through the organisation of 100 intergenerational dialogues with diverse stakeholders, including Global Peace, and brought over 150,000 African youths to the table with over 800 Elders offline while reaching 14.9 million people through #100IGD online.

In the same vein, we reinvigorated conversations on public policies on youth and particularly reforms related to African youth in public service. This led to the publication of the "Greater Inclusion of African Youth in Public Service and Governance" report in partnership with the African Leadership Institute - which additionally resulted in the development of a network of African Youth in Public Service.

Four: Through various briefings, consultations and advocacy efforts, the OYE played an instrumental role in advancing the Youth, Peace and Security (YPS) agenda and contributed to policy outcomes.

I briefed the United Nations Security

Council in 2019 and 2020 as well as the AU Peace and Security Council (PSC) Briefing in 2019 and 2020, amplifying refugee voices and demanding support for young peacebuilders.

At the AU PSC, the past two years brought tremendous advancements in the YPS agenda, culminating in the Adoption of the premier Continental Framework on Youth Peace and Security

In addition, the Youth Silencing the Guns campaign has become the AU's main platform for rallying youth on the theme of the year - which increased youth agency in Silencing the Guns.

Through support from partners, we launched the Youth Silencing the Guns Awards with a \$20,000 grant, as a platform to recognise the exceptional work of youth organisations across the continent.

It's no surprise that the #ShutItAllDown movement emerged as one of our winners, their incredible mass mobilisation to highlight sexual violence in Namibia standing as a solid testament to youth power.

We also convened six Regional Silencing The Guns Intergenerational Dialogues with over 1,800 participants, which resulted in Youth Silencing the Guns Declaration.

In order to highlight the pivotal role women played in the peace agenda, we trained 38 young African women and equipped them with tools and knowledge on peace, security and international instruments through the Fellowship on Silencing the Guns.

We are positive that these steps have moved us closer to the full integration and inclusion of young people in YPS. However, further financial investment in youth-led peacebuilding and development of National Action Plans on YPS are now the next crucial steps.

Five: We built a movement of youth-led accountability of 110 African Youth Charter Hustlers to work closely with the AU to monitor progress on the ratification and implementation of the African Youth Charter.

A young man and woman per country, from each of the AU member states,

were selected from 2,100+ applications. The initiative opened up closed intergovernmental spaces with inclusive gender balance and diaspora engagement.

This is the first AU initiative with fully inclusive youth representation across the 55 AU member states. Continued support for this initiative in partnership with UNITAR will be crucial in solidifying youth-led advocacy, agency and collaboration with governments, national youth councils and other structures in advancing the youth agenda as well as link the AU better to the grassroots in Africa - a key feature still missing in several well-intended AU interventions on the continent.

Six: The Gender agenda has been among my top priorities as AU Youth Envoy. I am immensely proud of the work we did with the over 1,500 youths, both young women and men, from 45 countries.

We convened these in five regional barazas and developed the Africa Young Women Beijing+25 Manifesto with ten concrete demands on the urgent interventions so desperately needed by young African women. In addition, we established Sauti (the Kiswahili for Voice) as a feminist platform where 25 young women told their stories on the first ever AU blog.

These stories were a collection of text, visual art and other forms of digital means of self-expression to fully capture the desire, demands and agency of young African women, especially during the Covid-19 pandemic. This was accompanied by a \$5000 grant to support the contributors.

To move these efforts forward Sauti voices should continue to be heard in an annual publication and the Manifesto should be presented to Generation Equality Forums in Mexico and France and adopted by Action Coalitions Leadership.

Seven: In all our activities, we consistently ensured that vulnerable youth were present and the spaces were designed to have a bottom-up consultative approach and consistent feedback.

Seven new predictions for a post-Covid-19-pandemic world

N the early months of the Covid-19 pandemic, I published my predictions about how the coronavirus pandemic would reshape our lives. While many of these predictions are currently bearing out, it is increasingly clear that the disruptions caused by Covid-19 are only just getting started.

The magnitude of any crisis is a function of both its striking force and of the strength - or fragility - of the system it attacks.

Long before this pandemic, developed societies were plagued by widening inequalities and staring down a technological abyss. In 2021 and beyond, the knock-on effects of shifts accelerated by the pandemic will cascade through our institutions and individual behaviours.

Here are seven additional shifts we should expect in the aftermath of the pandemic era. Some will create enormous challenges, but many will open opportunities to revise our foundational assumptions about economics, business and public policy so that, after the public health war has been won, we effectively mobilise to take advantage of abandoned and updated norms.

One: Equity markets will continue to soar, as fears of inflation drive commodity and crypto booms. So far, the US Congress has approved pandemic relief packages worth more than \$4.1 trillion. It funded these outlays not by raising taxes or selling bonds to the public, but rather by printing new money, marking an unprecedented expansion in the overall money supply.

Roughly one-fourth of all circulating US dollars was printed in the past year; much of it has ended up in the capital markets, sending financial assets rocketing to record highs.

Generous stimulus checks and pent-up demand from months in lockdown have also left consumers with record-high savings rates, which could propel a post-pandemic spending spree.

Taken together, these factors will make investors increasingly uneasy about inflation. This will drive demand for traditional store-of-value commodities, like gold and silver, and fuel the continued ascent of cryptocurrencies like bitcoin that are valued against a finite supply of coins rather than a basket of other currencies.

Banking giants like JPMorgan, Guggenheim, financier Paul Tudor Jones and insurer MassMutual have already bet hundreds of millions of dollars on bitcoin's future as a critical hedge against USD devaluation, publicly touting price targets upwards of \$400,000 per bitcoin.

Enterprise companies will increasingly follow their lead, as most corporate balance sheets come to include some a small percentage of crypto-denominated reserves

Two: While Amazon builds its empire, Shopify will keep bolstering the rebels. The online retail revolution has arrived ahead of schedule. Merchants that once relied on dominating retail shelf space or physical proximity to their customers will need to learn to sell on-

In practice, this means either joining crowded direct-to-consumer markets or capitulating to Amazon, which controls nearly half of all US ecommerce - and counting. This will set the stage for e-commerce wars pitting Amazon against effectively everyone else.

Shopify will lead the anti-Amazon coalition, by continuing to help level the e-commerce playing field for smaller online sellers.

The company's core innovation was to leverage its economies of scale to provide sophisticated, affordable e-commerce tools rivalling those of the largest incumbents. It has since expanded to off-line logis-

tics and fulfilment, hoping that one day it will match Amazon's customer service, fast shipping and easy returns.

It does not, however, help merchants find and attract customers online. To avoid an "Amazon takes all" future, that will need to change.

The central challenge for Shopify - and independent sellers in general - is that Amazon effectively controls online demand. A full 82 per cent of US households have Amazon Prime memberships, and most Prime members start their shopping journeys on Amazon, now the second largest search engine in the US.

In that this lowers customer acquisition costs, more sellers join Amazon Marketplace. Amazon's vast selection attracts more buyers, which further drives down customer acqui-

sition costs on the platform.

For independent merchants to survive in Amazon's e-commerce future, Shopify will need to provide an alternative by embracing a strategy focused on localising and personalising e-commerce.

Independent sellers will never match Amazon's economies of scale and scope, but they can outperform it with consumers who want to shop in their community, support brands whose values they share, or embrace compelling and highly differentiated brands.

For users to find those merchants, however, they need a searchable platform - which Shopify is ideally positioned to provide by expanding its Shop app into something that looks more like a local marketplace.

Three: The rapid transition to a gig

economy will upend US health insurance markets. To increase their resilience to future shocks, businesses will look to limit the stickiness of their cost structures.

Accordingly, fixed asset ownership will go down, office leases will get shorter, and full-time positions will be automated away or replaced with short-term contract workers. This transition is well under way in industries like grocery delivery; eventually, it will affect all sectors of the US labour market.

The accelerated transition to a gig economy will upend US health insurance markets, which rely on employment-based group insurance to shield risk pools from adverse selection pressures.

When a bloc of employees, rather than only its sickest members, receives coverage from an employer, young and healthy employees effectively subsidise those with greater coverage needs.

This balance will not hold when tens of millions of gig workers suddenly become responsible for buying their own insurance. Many - particularly the young and healthy - will choose to go without.

Advice to independent journalists before they see whether to go solo

HE rise of newsletter platforms like Substack, Medium and Forbes' recently launched Journalist Entrepreneur have opened up avenues for journalists to build and monetise their own fol-

Add to that a range of membership and podcast platforms, and journalists are not short on options to be truly independent and start their own publishing brands.

But it takes more than shiny tools to make publishing business sustainable; you need sharp commercial acumen and good planning skills too.

In a podcast with Journalism.co.uk, entrepreneurial journalist Isabelle Roughol, founder and host of the Borderline podcast and newsletter, shares her story into the world of 'indie journalism'.

Roughol had worked for LinkedIn for the past seven years in various editorial positions, with her last role being international editor. She had taken her sabbatical leave at the start of 2020 in need of a breather and in search of a new challenge.

She founded Borderline six months later armed with the professional know-how she had amassed during her time at the company.

But it was not just her skills that helped her launch her new brand. She saw the gap in the market as no publisher caters specifically for people who live in a different country from where they were born.

Roughol, originally from France, studied and lived in the US before moving to the UK. This life experience helped her to understand and connect with the large community of immigrants worldwide.

Roughol shared some lessons that she has learned so far for those considering taking the plunge.

Take time to cleanse yourself of burnout

Before you even start, make sure you have the energy to commit to your project in the long-term. Roughol's sabbatical had afforded her enough time of rest and reflection to start from a clean slate.

"You really need to go for weeks and weeks of nothing happening, and then one morning you wake up and there's something that appeals again which is a very nice feeling when you're a creative person," she explains.

Diving into a project already burned out from your previous occupation is a sure-fire way to fail quickly - so take care of your mental wellbeing first.

Discover your market

Working independently grants you total editorial control and freedom. But to stand out in the crowd, you must have a community in mind that your content speaks to.

"I don't know if I had pitched this to a traditional media outlet they would have responded to it, given how few immigrants there are in the media and how nationally focused most media are. This idea of this thing that crosses borders would be a bit alien to them," Roughol says.

She elaborates: "I am no longer representing anyone but myself. But it has downsides; it's hard to work without someone to bounce ideas off of. It might be even harder to do this for deeper, investigative reporting."

Work in whatever way makes sense to you

The other perk is setting your own hours. So, whether you are an early bird or a night owl, pull shifts around the clock at whatever hours best suit

"There's no-one telling me that my work hours aren't right, but the thing that keeps you accountable is that you have to make the rent cheque at the end of the month," Roughol says.

Have realistic goals and expectations

It is easy to get caught up in the euphoria of the big success stories. In reality, growth and monetisation are painfully slow.

"It's going to be more work than you think, and it's going to grow more slowly than you think, especially podcasts -and newsletters too. But audience growth is so hard and saturated," Roughol says.

She adds: "And it's going to make less money than you think; you can't live. From Roughol's experience, you just open up a Patreon membership should have at least one year's worth tight schedules?

and think 'everyone thinks what I do is amazing'."

Roughol recommends the assigning of yearly goals around numbers of subscribers gained and in total then building a plan with a clear route about how to get there.

"I wish I could spend every minute of my day working on my own business. However, if you want to keep the lights on, you also have to do other work for income, and that distracts you from your business," she ex-

She adds: "That means that your growth is even slower, that you are pushing back the date on which you can concentrate on your business, so it's always a balance."

Focus, focus, focus

Roughol also started a podcast for her French listeners, which she has always been eager to do. But as these account for a fraction of her audience, it is not a priority, attached as she is to it.

Products should always serve a purpose, she advises. Plenty of projects are "worthy", but not all play into the core business objectives.

This is something Roughol learned during her time with LinkedIn. For her, the podcast is the main shop window -free at the point of access, and widely available - then newsletters and Patreon membership tools provide extra value or early access

"Focus is the hardest and most important thing in business, especially when you are starting out and your resources are so limited."

Quickfire advice

Connect with industry peers. Other independent journalists are happy to offer visibility, exchange projects or do last-minute stand-in interviews when your guest cancels an appointment.

Make sure your initial posting schedule is manageable. A weekly podcast guest sounds like great fun, but how realistic will that be with all your other deliverables and amongst guests'

Should journalists use social media to give their opinions?

ALL views are my own, not those of my employer' is an oft-seen disclaimer on journalists' social media profiles -but these days hardly anyone buys any of that.

Even when it is not the intention, our online activity has an impact on our news outlets' public image. Some journalists self-censor and do not share their personal opinions on news, or at least they think very, very carefully before hitting the "Tweet" button.

Others follow their employer's social media guidelines that provide at least some framework for what is and what is not acceptable behaviour on social platforms. But for most, finding the right balance is a true

To help you navigate the choppy waters of Twitter storms, we recently invited four experts to Newsrewired to talk about the pros and cons of getting personal on social platforms.

Shifting attitudes

Many organisations have recently tightened their social media policies for journalists. But the BBC took this one step further with its new social media guidance that tells employees not to 'express a personal opinion on matters of public policy, politics, or controversial subjects' on online platforms.

Richard Sambrook, professor of journalism at Cardiff University, spent 30 years at BBC News as a producer, editor and director of Global News and the World Service. Earlier this year, he led an independent review on how the corporation maintains impartiality on social media and he also advised on the new rules, although he was not the one drafting them.

As a public broadcaster, the BBC is required by the law to be impartial in its news coverage. Expressing, say, political allegiance or judging public policies on social media goes directly against this. And once a journalist has the BBC brand in their bio, users may easily consider individual views as those of the corporation and feel that their public news service is biased.

"A lot of journalists and organisations are still thinking about social media as it used to be," says Sambrook, adding: "Some think it's informal, some think it's quite fun - a way of getting closer to your audiences, but things have moved on. It is now a significant channel of communication."

He encouraged organisations and journalists to use social media as a professional output tool rather than



a personal media channel.

"In many respects social media have become toxic," he says, noting: "There is a lot of abuse and criticism, and both organisations and individuals' approach to social media need to wake up a little bit to how it works

Objectivity vs impartiality

Robyn Vinter, founder of the independent news outlet The Overtake, spoke of the challenges entailed in navigating different social media guidelines when working with several outlets.

"My goal is to serve the reader," she said, adding that it can be difficult to be careful and diplomatic when posting something a journalist has strong feelings about -"but you can do both of those things; it's about finding the right balance".

Vinter, who has been a prolific Tweeter for a decade, added that she sometimes realises that sharing strong views may have alienated some people. On the other hand, she noted, speaking with an authentic voice helps her audiences to see her as a real human being and not a "corporate robot" who just shares her stories.

There is another advantage to this human relationship. When she was a freelancer, Vinter would often get commissioned after having shared strong views on a news topic at the right time.

Finally, she says, when the readers can identify themselves with the journalist, they are more likely to share

"I had people who told me: 'I don't speak to journalists but I will speak to you'," she concluded.

Why objectivity matters

Jo Adetunji, managing editor of The Conversation UK, provided a contrasting opinion on the need for impartiality within journalism.

"You have to show that you can be objective, of course we all have opinions, but I think it's not enough - especially in an industry that suffers from trust issues - to say 'you just have to trust us'," she explains.

As an editor you have to be able to commission people with different views, she added, especially as we are seeing a rise of "activist journalism".

Social media constitute a great way for journalists to engage in debates on topics that may not normally be

relevant or interesting to the wider audience.

Therefore, journalists can find it challenging to keep their personal and professional online lives separate, as seen by Adetunji, who shared her own experiences of social media and upkeeping her professionalism.

She says: "I remember thinking Twitter is where I'll do professional stuff, Facebook is where I'll do personal stuff, and then you just end up getting very confused about where you're putting anything."

But more than that, journalists often get too sucked into Twitter storms and online debates, forgetting that there is a much wider community who does not engage with - or care about - online debates.

Challenging the norm

Adriana Lacy, senior associate for audience and growth at Axios, spoke about how the Black Lives Matter movement and the US presidential elections tested the notions of objectivity and impartiality in US news-

"Whose objectivity are we following?" she asked, adding that both events prompted many black and also immigrant journalists to become vocal about their experiences on social media.

"For many people, these are not our opinions, these are our lives," she said.

Since working on audience growth, Lacy saw how important it is for reporters to be online and share their stories. Sometimes when they share stories they are personally connected with, these perform much better than when they are shared by the official outlet account.

While understanding the way in which journalists use opinions, she also acknowledged how incredible the power of social media is in reaching audiences traditionally not acknowledged by the media.

"Social media have been a really great tool for journalists to spread their work and reach communities who are often not reached," she said, adding: "I'm hoping that social media will continue to be a healthy and more productive way to share thoughts online."

NGO joins hands with govt in waging war against TB

EVERY year, there are estimated 9 million new TB cases worldwide but consistently three million cases were not diagnosed, treated or registered by National TB Programmes (NTPs), according to the World Health Organisation (WHO). Among the new TB cases nearly 1.5 million people die each year.

TB is among the top ten causes of global mortality and morbidity accounting for about 26 per cent of all preventable deaths. It is the third leading killer of adults behind Malaria and Acquired Immune-Deficiency Syndrome (AIDS).

Speaking in Dar es Salaam recently during Policy Forum's Breakfast debate on decentralisation of childhood tuberculosis diagnostic services: What should be done to address systemic policy issues? Project Manager-Elizabeth Glaser Pediatric Aids Foundation (EGPAF), Dr Leo Haule, said that childhood TB in NSP VI, had targeted to maintain proportion of children-TB among the notified cases at 15 per cent and; increasing the ratio of ages '0-4'; 5-14 years from 1.3 in 2019 to 1.5 by 2025.

Dr Haule said that the main intervention of his organisation in combating TB among others was to expand advance sample collection (75% of hospitals perform sputum indication and gastric aspiration), integrate TB services to child and adolescent health services in the facilities and communities.

Considering the gap for under five children, National Strategic Plan (NSP) V have added advance sample collection as well as target 0-4/5-15 ratio increase.

EGPAF together with many other likeminded actors in Tanzania have continued with their effort to reduce morbidity and mortality associated with pediatric TB through active TB screening and intensified case finding in health facilities and communities. And by strengthening linkages to diagnosis and treatment for both active and latent TB infection in 45 sites that currently receive direct support from EGPAF (3.3% of all EGPAF sites) across the two of the country's 31 regions-Singida and Tabora in the Central Zone.

Considering the size, geographic and social diversity of Tanzania, a range of regions is required, to demonstrate the generalisability and scalability of the models proposed, without significant increase in the costs of implementation.

The sites have been chosen to maximise the yield of pediatric TB cases, making the CaP TB Project's contribution significant to the Ministry of Health, Community Development, Gender, Elderly and Children and

Specific site selection criteria include-burden of TB and HIV where facilities with high burden of either disease were selected basing on the assumption that increasing efforts in TB screening among HIV clients will bring an increase in TB case detection in facilities that currently have low TB numbers.

According to Dr Haule, in Tanzania EGPAF has been a key implementing partner in reproductive health

to the Ministry of Health, Community Development, Gender, Elderly and Children in Tanzania since 2003. Through its Boresha Afva Project (2016-2021) EGPAF is now also a leading TB partner for USAID in six of the country's 31 regions.

Pediatric TB is included as a priority focus in Tanzania's National Strategic Plan (NSP) V for Tuberculosis and Leprosy Programme 2015-2020, which was developed by the ministry through the National TB and Leprosy Programme (NTLP) and in collaboration with a multi-sectoral group of partners and stakeholders.

The NSP focuses on children as a key vulnerable group, and calls for intensified efforts to increase the number of childhood TB cases identified, diagnosed, and treated, as well as increased integration of TB care into other reproductive and child health services.

The Tanzanian government has demonstrated its strong commitment to improving pediatric TB services in Tanzania.

For example, in 2016 the National TB and Leprosy Programme (NTLP) revised the national guidelines for management of Tuberculosis in Children and training curriculum to accommodate current WHO recommendation including use of new FDCs and have taken advantage of Expert MTB/Rif rollout to improve case detection by including children in the testing algo-

To support the integration and demand for new drugs and technologies, EGPAF has been following up on the existing regulatory framework for introduction of TB drugs/technologies in the country, which requires that there is available global evidence that the new drugs/technology is approved and has WHO endorsement.

Having recognised that low capacity among health care workers (HCWs) was a barrier to improving pediatric TB services, EGPAF/Tanzania was leveraging its existing TA and mentorship plans under the USAIDfunded Boresha Afya project to intensify training for HCWs and CHWs in pediatric TB management.

Under USAID Boresha Afya Project, EGPAF has received funding to support facilities with TB screening tools and build HCW capacity in pediatric TB clinical diagnosis and management through training on pediatric TB and TB/HIV case finding and infection control.

It expected that by the end of the project (2021), CaP TB will: More than double the number of children diagnosed with active TB; double the number of children initiated on first-line TB treatment and treat more than 16,000 children with active TB.

Ensure that 90 per cent of children diagnosed with active TB are initiated on treatment and that 90 per cent achieve treatment success; increase the proportion of children who are initiated on TB preventive treatment (TPT) for latent TB infection (LTBI), treat more than 52,000 children with LTBI, and increase the share of children completing LTBI treatment from 50 per cent to 80 per cent.

In 2019 the project achieved the following: A total of 81059 pediatrics where screened for TB in all entry and HIV prevention, care, treatment and support propoints of 22 supported facilities, 2046 of them were Iringa, Kilimanjaro and Tanga.

The Global Plan to End TB for 2016 - 2020 says by achieving 90 per cent of all people living with TB including key populations such drug users and by achieving 90 per cent treatment success of all these people with TB will achieve the target.

While great strides have been made to control and cure TB, people still get sick and die from this disease in many countries including Tanzania.

Speaking in a different platform the Manager of NTLP, Dr Beatrice Mutayoba was quoted as saying that Tanzania was the first country in the world to successfully combine the control of TB and Leprosy into a single programme.

Dr Mutayoba said although major efforts were taken by the government but TB was still a major public health problem in the country.

For the past ten years, statistics from health facilities in Tanzania show that ten regions were leading in TB cases and were being led by the country's business centre of Dar es Salaam. The other regions include Mwanza, Shinyanga, Mbeya, Morogoro, Mara, Arusha,

scale of the TB problem in Tanzania showed that the disease has also been spreading to the rural areas.

Earlier findings had painted a different picture, which showed that TB cases were rampant in congested urban areas only, but now the rural areas are in big danger. And it showed that the most affected group were the youth.

It also indicated that the growing number of adults aged over 50 years, were suffering from TB compared to other groups in society.

Men are the most affected group in the society, compared to women. It was alleged that men easily contract the disease due to the nature of their lifestyles, which force them to assemble in beer drinking sites, cigarette smoking groups and many other activities including mining, just to mention a few.

TB is a chronic infectious disease caused bacillus Mycobacterium tuberculosis. It typically affects the lungs (PTB) but can also affect other sites (ETB).

TB is mainly airborne; spread to children by adults, older children and adolescents who have TB of the lungs. Once exposed to someone who has pulmonary TB disease a child may end up with; infection - No symptoms.

Southern Africa: Homes become dangerous place for women and girls during Covid-19 lockdown

DURING the COVID-19 lockdowns imposed by Southern African countries, some homes across the region became enclaves of cruelty, rape and violence for women and girls trapped with abusive family members and nowhere to report or escape the danger, Amnesty International has said.

Harmful gender stereotypes embedded in social and cultural norms, which suggest that women must always submit to men or that a man who beats his wife does so because he loves her, have fueled the rise in violence against women and girls in Madagascar, Mozambique, South Africa, Zambia and Zimbabwe. As one activist in Mozambique said: "Girls are taught that husbands only beat their wives when they love them."

Amnesty International also found in its briefing, "Treated like furniture: Gender-based violence and COV-ID-19 response in Southern Africa", that women and girls who dare to report violence and abuse risk social rejection for failing to conform to gender roles -- and when they do speak out, their complaints are not taken seriously by authorities.

"The COVID-19 pandemic has prompted an escalation in gender-based violence

Southern Africa. It has also magnified existing structural problems such as poverty, inequality, crime, high unemployment and systematic criminal justice failures," said Deprose Muchena, Amnesty International's Director for East and Southern Africa.

"Lockdown measures meant that women could not escape abusive partners or leave their homes to seek protection. Across Southern Africa, women who suffered gender-based violence struggled to report abuse because both women and organizations working to provide protection and support to women were not seen as an "essential service", and so faced severe restrictions of movement, resulting in them abandoning filing cases."

Of the five countries where gender-based violence was documented in this briefing, Mozambique, South Africa and Zimbabwe stand out as countries where support services to women and girls subjected to violence and abuse were not taken into consideration in the design of the measures to control the spread of COVID-19.

Rape, beatings and killings during lockdown

Within weeks of countries being on lockdown, violence against women increased sharply across the region. against women and girls in
In the first week of the lock-



country. One emblematic case was the brutal murder of 28-year-old Tshegofatso Pule, who went missing on 4 June and was found four days later, stabbed and hanging from a tree in Johannesburg while eight months pregnant.

In Mozambique, civil society organizations received unusually high numbers of domestic violence cases after the start of the state of emergency in March 2020. In one case, a man killed his wife and then himself on 6 June in Matola district in Maputo province.

Horrifying details also emerged of the robbery, rape and murder of a Maputo Central Hospital employee on 31 May 2020. She was on her way home, late at night because of the scarcity of public transport during the state of emergency restrictions.

In Zimbabwe, an organization that offers protection for women survivors of domestic violence, had documented 764 cases of gender-based violence in the first 11 days of the national lockdown. By 13 June 2020, the number was 2,768.

One Zimbabwean woman, Maria* (not her real name), was violently thrown out of her home by her husband after he moved his mistress in during the lockdown.

In Madagascar, the rise in poverty due to lockdown was a major factor for the increase in gender-based violence during the lockdown period, with women and girls becoming poorer, more economically dependent on abusive partners and therefore more exposed to abuse.

Zambia was the only country that recorded a slight decrease in gender-based violence during the national lockdown compared to the same period in 2019, according to official police statistics. The country recorded a 10% decrease in the first quarter of 2020, which may reflect the fact that women were unable to call for help rather than a decline in gender-based violence cases. However, one NGO, Young Women's Christian Association, recorded an increase in sexual violence cases during the first quarter of 2020.

Barriers to justice

The briefing identified several barriers to justice for victims and survivors of gender-based violence across Southern Africa. These include a lack of trust in the criminal justice system and secondary trauma which victims and survivors often suffer at the hands of authorities, including the police, and health services when they attempt to report cases.

These barriers came into sharper focus during the COVID-19 pandemic. In South Africa for example, there has been public outrage about the institutional failures to administer justice for women and girls who are victims and survivors of gender-based violence, even though the country's Domestic Violence Act of 1998 explicitly states that victims may lay criminal complaints

against offenders. One rape survivor, Natasha* (not her real name) said violence against women had increased because "police don't take gender-based violence victims seriously enough when they file cas-

South Africa's Minister of Justice and Constitutional Development, Ronald Lamola, admitted on radio in June 2020 that there were weaknesses in the system that frequently failed victims of gender-based violence.

In Mozambique, when a gender-based violence complaint is filed, police are required to open an investigation. However, like in South Africa, many victims are reluctant to come forward because of pressure from society to put up with domestic violence, financial dependence on the perpetrator, and a lack of confidence in the

criminal justice system. According to civil society organizations, in some instances, police officers were accused of dismissing gender-based violence complaints because they saw them as family matters and not crimes. The stigma around sexual violence was also cited as a contributing factor to underreporting.

"It is shocking that for many in Southern Africa, the most dangerous place to be a woman or a girl during the COVID-19 pandemic is at home. This is simply inexcusable. The leaders of the Southern African Development Community (SADC) must ensure that prevention and protection of women from gender-based and domestic violence is an integral part of national responses to pandemics and other emergencies," Deprose Muchena said.

"States must ensure that women and girls continue to have access to police protection and justice as well as to shelters and other support services to escape the blight of gender-based violence.'

To prevent another civil war, South Sudan must create a unique political system

HE threat of a full-blown civil war in South Sudan remains unless the country's leaders can broaden power sharing, warns a new report by the International Crisis Group (ICG) released almost year into the country's formation of a government of national unity.

The report titled "Toward a Viable Future for South Sudan" formulates a stark conclusion. Almost a decade after its 2011 independence from Sudan, "South Sudan - the world's newest country - needs a reset, if not a redo."

"Our argument is that South Sudan is so fragile and faces so many challenges and is so diverse that we think the only way to govern South Sudan peacefully is through radical consensus as a form of power sharing and government," Alan Boswell, ICG's Senior Analyst for South Sudan and one of the authors of the report, told IPS

The report urged South Sudanese elite, religious leaders and civil society to rethink the country's system of governance and create a political system that would work for one of Africa's most diverse nations with more than 60 different ethnic groups.

Upcoming elections, which could possibly be set for 2022, as well as the country's "winner-take-all" political system which "ill suits a country that requires consensus among major blocs to avert cyclical power struggles," could inflame tensions, said the report released today,

"Incentives for post-election violence will be acute. South Sudan's highly centralised power structure and political economy raises the election's stakes, since there are limited consolation prizes especially if [President Salva] Kiir continues to flout the constitution by refusing to devolve oil revenues and removing powerful governors by decree," the report said. South Sudan has the third-largest oil reserves in sub-Saharan Africa, which generates the majority of the government's wealth.

South Sudan gained independent after Africa's longest civil war, which lasted from 1956 to 1972 and then again from 1983 to independence. But two years later, in 2013, the nation descended into civil war after Kiir fired his cabinet and accused his vice president, Riek Machar, of being behind a plot to oust him.

Majoritarian democracy proved itself to not be a successful model for South Sudan.

"We make the argument that although South Sudan has structured itself along with many other states around the world as a majoritarian democracy, where in theory they go to polls and whoever the majority picks rules. That in practice in South Sudan's context is likely a recipe for many groups feeling shut out of power, and a recipe for the ongoing power struggles that have already killed 100,000s of South Sudanese," Boswell said.

In September 2018, all sides signed the Revitalised Agreement on the Resolution of the Conflict in South Sudan (R-ARCSS), which included a power sharing agreement. The government of national unity was formed almost a year ago, at the end of February 2020, as part of the conditions of the agreement.

Boswell urged South Sudanese elites and the country's external partners to support the country and "go back to the drawing board" and think "how they create the political system that works for them rather than copying po- teeing them positions of influence to Administrative Area. remained internally displaced and

litical systems from other places that might not be as appropriate."

Boswell said in order to prevent more conflict, the ICG called for preand post-election power sharing. "In order to prevent more conflict South Sudan really needs a very broad, inclusive power sharing before, during and after the vote. What you don't want is a situation where the election is seen as a path by the one party to defeat another party," Boswell said.

The report cited examples of rotational power sharing that could "encourage multi-ethnic alliances or mean losers of elections feel they have a shot at the presidency next time around," the report stated.

For example, Nigeria - where through informal agreement the country rotates its presidency between the Muslim north and the Christian south; and Tanzania – where the presidency is rotated between a Muslim and Christian every decade.

Additional recommendations included, among others:

Setting aside prominent positions in the national government for electoral runners-up as a way of guaran-

prevent them from taking up arms.

Having regional leaders broker preelection dialogue, to extract assurances from losing parties in order to lower the stakes as well as guaranteeing in advance another broad-based unity government.

A system where power can be shared more equitably at the centre.

Agree to designate the first vice president position, for the presidential runner-up, while allocating at least one other vice presidential position to the next most successful con-

Life for South Sudanese remains a harsh reality of food insecurity and continued conflict.

Last September, Yasmin Sooka Chair of the United Nations Commission on Human Rights in South Sudan said in a statement that the implementation of key areas of the revitalised agreement had stalled. "While the COV-ID-19 pandemic can take some of the blame, the lack of progress poses a threat to the peace process," she said, noting the the escalation in violence in Central Equatoria, Jonglei, Lakes, Unity, Western Bahr el-Ghazal, and Warrap States, and the Greater Pibor

"A breakdown in the ceasefire with armed groups in the Equatorias has fuelled the violence and already displaced thousands of South Sudanese civilians," she said in a statement to the Human Rights Commission.

According to the UN Refugee Agency (UNHCR), "more than four million South Sudanese have been displaced across the region and within their own country in one of Africa's largest displacement crises". Of the four million displaced, UNHCR notes that there are almost 2,3 million refugees and asylum seekers, with the largest number in Uganda (over 890,000), followed closely by Sudan (736,700), followed by Ethiopia, Kenya and the Democratic Republic of Congo.

Last December, the UN Office for the Coordination of Humanitarian Affairs (OCHA) reported that almost half – 5.8 million – of the country's 11 million people were acutely food insecure. "In 2020, communities were hit hard by the triple shock of intensified conflict and sub-national violence, a second consecutive year of major flooding, and the impacts of COVID-19. Some 1.6 million people

another 2.2 million as refugees in the region," OCHA said in its 2021 Humanitarian Needs Overview for South Sudan.

Meanwhile, the ICG report also noted that development partners, fatigued by years of conflict resolution had "no clear plan for finding peace, despite the substantial sums still devoted to humanitarian aid."

There was also widespread cynicism among donors, Boswell said. "They have lost any vision of what a peaceful South Sudan could look like and how to help get it there," he said.

He cautioned this was not very sustainable.

"If there is not a vision or a plan that both South Sudanese and both donors can look upon and push towards where the country is heading and what a peaceful situation looks like then we fear that donors would gradually, as they have been, pull more and more out of South Sudan and start doing the bare minimum of just keeping people alive," Boswell said.

South Sudanese have lost a lot of hope in their country, because they have lost faith in their leaders after seeing them act in ways that are clearly selfish, Boswell

One example of this is the large-scale corruption within the

According to Transparency International, in 2012 Kiir accused at least 75 government and ex-government officials of embezzling \$4 billion of public funds and in a public statement urged for the money to be returned. Only \$60 million was reportedly returned to a bank account in Kenya.

Last September, during her statement to the Human Rights Commission, Sooka cautioned that "lives are being destroyed by financial corruption on an epic scale" in South Sudan.

She referred to a recent report to parliament by South Sudan's National Revenue Authority that had shown "that approximately \$300 million have been "lost" in the last three months alone".

Four years on, Xi's idea of building a community with a shared future for mankind is particularly inspiring when the world is plagued by the raging COVID-19.

The world today is experiencing unprecedented changes, which have been worsened by the once-in-acentury pandemic.


The global economy has been put into deep recession, the world is entering a period of turbulence and transformation, and human society is faced with nu-

TANGOLD TO START PAYING COMPENSATION AT BACKREEF MINE

OLLOWING approval by Ministry of Minerals and Mining Commission, Tanzanian Gold Corporation will start paying compensation to residents of Geita District who will pave way for the construction of a 40 tons per hour oxide mining and

In a statement last week, TanGold said its officials accompanied by their peers from State Mining Corporation, met with Mining Minister Dotto Biteko and Mining Commission representative to discuss the project.

"TanGold and Stamico will move forward the documentation and approval process for the previously agreed to amendments of the Buckreef Joint Venture Agreement as disclosed in January. Buckreef Gold Corporation Limited will also begin the land compensation and procurement process required under Tanzanian mining law," the statement said.

In order to speed up the project, Tan-Gold announced that it has entered into a definitive agreement with several institutional investors for the purchase and sale of32,923,078 shares of its common stock at a purchase price of U\$0.65 per share in a registered direct offering.

"The company has also agreed to issue to the investors warrants to purchase up to an aggregate of 16,461,539 common stock in a concurrent private placement. The common stock warrants will be exercisable six months after the date of issuance, have an exercise price of U\$0.80 per share and will expire five years from the date of issuance," the statement

added.

The statement further noted that closing of the offering is expected to occur on or about February 11, 2021, sub-

ject to the satisfaction of customary closing conditions. A.G.P./Alliance Global Partners is acting as sole placement agent for the offering.

"The company intends to use the net proceeds from the offering for continued development of the Buckreef Gold Project, including capital expenditures, continued exploration, general corporate purposes and working capital," the statement added.

Meanwhile TanGold has announced the appointment of Andrew Cheatle as Chief Operating Officer after receiving the approval of the updated mine plan for the Buckreef Gold Project from the Mining Commission.

Cheatle is an accomplished mining executive, geoscientist and director having graduated from Royal School of Mines, Imperial College in London and has 30-plus-years of experience in operations/production, development and exploration in both the senior and junior mining sectors.

His considerable operational and project management experience includes senior positions with the development of (at that time) Anglo American Corporation's Moab Khotsong Gold Mine, JCI's South Deep Project and major expansions of Placer Dome's/ Goldcorp's Musselwhite Mine.

Cheatle currently sits on the board of directors at Condor Gold Plc, Troilus Gold Corp., and TanGold. He also volunteers on the advisory councils of the Development Partner Institute, the Canada-International Finance Corporation Africa Local Economic Development Partnership and as a director of International Women in Mining.

Economic opportunities in Kigali's wetlands

KIGALI

AS the government continues to mobilize funds to invest in recreational wetlands in Kigali City, Rwanda Environment Management Authority (REMA) has committed to encourage ecotourism investments among the private sector.

Different recreational wetlands are expected to generate revenues once developed. Doing Business has looked into some wetlands and how their conservation could generate or are generating revenues.

Nyandungu wetland

Among the wetlands where biodiversity conservation could generate revenues is Nyandungu wetland connecting the sectors of Nyarugunga of Kicukiro District and Ndera of Gasabo District where an ecotourism park is being created, 130 hectares.

Ngaboyamahina, the Environmental Theogene Mainstreaming Officer at REMA said, last week, during wetland day celebrations that the construction works are at 72 percent and are set to be complete in May, 2021. The urban park is being created to increase and conserve biodiversity, create green jobs, manage pollution and reduce floods.

The Ecotourism Park will feature walkways, cycling routes, boardwalks and bridges, nature viewing areas, bird hides, kiosks and picnic areas among other facilities that a modern park would have. Initial projections indicated that the park should generate over Rwf1 billion profit in the first 12 years of operation.

The park will offer several revenue streams including entry fees using differential pricing whereby visitors will be charged for entry to the park, guiding fees where visitors can choose to employ a freelance guide for the guide to earn an income while some areas in the park will be offered for wedding photos for a fee.

They also include ground rent on restaurant /café whereby

a site in the park will be offered as a concession and the restaurant / café then pay a ground rent to the park. Sale of native plant species is another revenue stream as gardeners working at the site will grow native species of trees and other plants that will be offered for sale to visitors and others.

The revenue sources again include entertainment and cultural events. The park may choose to rent out areas of the park for events, providing that they fit the ethos of the park. REMA is set to work with Rwanda Development Board for a long-term management plan.

Gikondo wetland

The green and environmentally friendly Gikondo Recreational Park is being developed in the former Gikondo industrial park. On one part of the wetland, gardens with green lawns, colorful indigenous tree species and refreshment facilities have been established.

Different species of indigenous trees such as sycamore trees, acacia trees have been planted as well as small ponds of waters with paths designed for pedestrians coming for sightseeing. Kiosks from which different products can be sold such as refreshments and snacks for people will be set up to generate revenues. Other facilities such as benches and chairs around swimming pools, showers and washing rooms, bicycles lanes, seats, Public Park, lights and sites for photography among many others are expected.

In order to fully restore the wetland, Gikondo is among the wetlands that are part of \$175 million (approx. Rwf173bn) project to green the city and rehabilitate wetlands. The wetlands to be rehabilitated include Gikondo, Nyabugogo, Rugenge, Kibumba, Rwintare, and Rugunga.

Umusambi village

Already, players like Olivier Nsengimana, a renowned conservationist, have revamped a popular wetland formerly called Bambino Super-city along the Kigali-Rwamagana road,

into a nature reserve for wild crowned cranes.

Umusambi Village is a beautifully restored wetland area, providing a sanctuary for over 70 endangered Grey Crowned Cranes saved from the illegal pet trade from private gardens around Kigali and other parts.

The village is a 21-hectare nature reserve, the first of its kind in Kigali that will allow visitors to enjoy walking trails while learning about the importance of protecting natural environments. Last week, Nsengimana said that during peak seasons, the village is visited by about 4,000 visitors per month.

Sunday Park

The wetland separates the affluent neighbourhood of

Nyarutarama and Kacyiru in the Gasabo sector, opposite to the golf course. According to the developers, the wetland had been polluted with

The park has gardens, small lakes, a mini-golf course, a nature park and an art exhibition that conserve biodiversity and attract tourists. It has tree species that attract birds which are rare in Kigali city. The birds help in conservation education in schools and different research.

PepsiCo aims for net-zero emissions by 2040

NEW YORK

FOOD and beverage giant PepsiCo plans to more than double its science-based climate goal, targeting a reduction of absolute greenhouse gas (GHG) emissions across its value chain by more than 40% by 2030. In addition, the company has pledged to achieve net-zero emissions by 2040, one decade earlier than called for in the Paris Agreement.

Specifically, PepsiCo plans to reduce absolute GHG emissions across its direct operations (Scope 1 and 2) by 75% and its indirect value chain (Scope 3) by 40% by 2030 (2015 baseline). This action is expected to result in the reduction of more than 26 million metric tonnes of GHG emissions or the equivalent of taking more than five million cars off the road for a full year.

"The severe impacts from climate change are worsening, and we must accelerate the urgent systemic changes needed to address it," said PepsiCo Laguarta. "Climate action is core to our business as a global food and beverage leader and propels our PepsiCo Positive journey to deliver positive outcomes for the planet and people. Our ambitious climate goal will guide us on the steep but critical path forward there is simply no other option but immediate and aggressive action."

sustainability strategy, informed by sciencebased measures and cost-benefit analysis, focuses on the areas where it can have the most impact, while creating scalable models and partnerships for accelerated progress across the full value target aligns to the Business Ambition for 1.5°C pledge and has been approved by the Science Based Targets initiative as the most ambitious designation available through their process.

Gas power plant planned for Malalane, **Mpumalanga**


A state-of-the-art power plant, propelled by piped gas from Mozambique, has been proposed by a private company to be erected near Malalane town.

road on the way to Hectorspruit, about one of the environmental impact study before 275-kilovolt overhead powerline from the DNG Energy was contacted. It admitted its plans, which include a proposed development of approximately 500 metres for a

proposed power plant to the existing Eskom Khanyazwe Substation.

"The proposed facility involves the de-

velopment of the power plant, the aboveground gas pipeline from the existing Republic of Mozambique Pipeline Investments Company (Rompco) gas pipeline to the power plant, and aboveground storage tanks to store liquefied natural gas," added The gas that will power the project

will be transported from Mozambique through the Rompco pipeline. Eskom will be the beneficiary of the electricity produced by the plant.

"The power that we will produce from our project, if approved, will be for the benefit of all South Africans who are electrified. The power would be fed into the national grid and transmitted to various parts of the country under the stewardship of Eskom," Rikhotso added.

"However, as it is fed into the grid at the local Malalane Substation, this will have the effect of significantly strengthening the local grid and helping to contribute to a more reliable local supply of electricity."

The project is still in the assessment phase, which means the interested and affected parties, including Nkomazi Local Municipality and Ehlanzeni District Municipality, have not yet been notified of the plans. "The project is still in the planning and EIA phase, and will only proceed to commencement on receipt of the relevant approvals," Rikhotso added.

UBA Bank has revived its bid to sell troubled Uchumi's Supermarket land situated on Langata Road over a debt of Sh172 million.

In an application before the High Court, UBA says Uchumi has failed to implement a Company Voluntary Agreement (CVA) agreed in March last year between the supermarket and 121 suppliers on how to settle Sh4.2 billion owed to them. Under the CVA agreement that was initially opposed by UBA Bank, the retailer was to form a committee to ensure the payments are made on time.

'The Company's (Uchumi) failure to review and meet the terms of the CVA has had a detrimental effect on the Applicant/ Bank as a secured creditor as it unjustly relieves the Company of its obligation to service the loan facility extended to it," the application reads. The lender says Uchumi has been in default of its facility for close to four years, terming it a huge concern to both the bank and its regulators given the negative impact it has on its depositors' funds.

"That in view of the foregoing, it is in the interests of justice and fairness that the Applicant/Bank be granted leave to enforce its security," the lender says. Last year, the High Court stopped the planned sale and all pending debt recovery cases, outstanding loans and rent claims in favour of the CVA.

The lender accuses the troubled chain of failing to implement the CVA as agreed.

CARNIVAL BOSS 'CAUTIOUSLY OPTIMISTIC' ENTIRE FLEET WILL RETURN TO OPERATIONS THIS YEAR

FLORIDA

HE chief executive of Carnival Corporation, the world's biggest cruise ship operator, said he remains "cautiously optimistic" that the company will be able to get its entire fleet back on the waters by the end of the year.

The company, which had to suspend sailings in March last year, has largely been unable to sail since and does not know when it will be able to recommence operations, chief executive Arnold Donald told the Bloomberg Year Ahead conference on Tuesday evening. Carnival not only needs approval from the US Centres for Disease Control to recommence sailing, but also clearance from the destinations to which its cruises sail, Mr Donald said.

"We're not going to be able to start at once. We'll stagger our starts - a few ships at a time. We'll be slower coming back, but we will come back, depending on when it's in the best interests of public health to sail here in the US and elsewhere in the world," Mr Donald said.

"We're cautiously optimistic, hopeful, that we can have nearly all of the fleet back sailing by the end of the year." Carnival Corporation has a fleet of 87 ships operating under the Carnival, Princess Cruises, Cunard and P&O Cruises brands, among oth-

The suspension of services has hit the company's finances hard, though. It lost \$2.2 billion in the last quarter of 2020 alone, adding to an \$8bn loss in the first nine months of the year. Earlier this month, Carnival said it

"To have a business with no revenue for an extended period of time and a significant burn rate - because, obviously we have to keep our ships operational ... it's been very challenging. On the other hand, the company has proven its resilience. Our people have been fantastic," Mr Donald said.

Since the onset of the pandemic, Carnival has also raised more than \$19bn of capital through debt and equity funding. Saudi Arabia's Public Investment Fund took part and was the company's second-biggest shareholder as of the end of the third quarter of 2020, with a stake of just over 7 per cent. The fundraising gives the expects to burn through cash at a rate company enough liquidity to make

of about \$600 million a month during it through 2021 without earning any is still out there," he said. revenue, Mr Donald said.

"That gives us time. And we've already publicly stated we have additional capacity for debt," he said. "Obviously, as we move forwards, we will pay attention to the balance sheet and if we determine it makes sense we can do additional equity raise if we need to. So we have some flexibility, which gives us confidence we can weather the storm."

Once cruises recommence, they will do so with advanced health protocols and mandatory Covid-19 testing for passengers, Mr Donald said. "Even with the advent of vaccines, even with the acceleration of low-cost, rapid [and] more accurate testing, even with the advancement of treatments, Covid

Initially, the company will probably limit the number of passengers, Mr Donald said.

"But the ships are vast ... the most important thing is not how many people but in those situations where you can have a congregation of people, is there adequate room for distancing? "There will probably be some limitation ... but maybe not as much as people think. Our ships initially will start slow but chances are we will be back to relatively full occupancy, just with different practices," Mr Donald said.

Marriott grows resorts portfolio through deal with Sunwing Travel Group

MARRIOTT International is expanding into all-inclusive resorts, adding nearly 7,000 rooms in the Caribbean and Central America in a move highlighting how hotel giants are plotting a recovery from the Covid-19 travel bust.

Marriott has struck a deal to add 19 resorts owned by Sunwing Travel Group, including properties in Mexico, Jamaica and Costa Rica, as the world's largest hotel company bets that vaccination campaigns will unleash a boom in vacation travel.

'This is a transformative transaction that helps us really solidify our position in a segment we think will continue to grow rapidly," said Tony Capuano, president of the global development, design and operations services group at Marriott. "There is enormous pent-up demand for those destinations." Marriott shares slipped 1.6 per cent to \$127.01 on Tuesday in New

Toronto-based Sunwing will continue to own the properties, including the 566-room Planet Hollywood Beach Resort Cancun and the Royalton Punta Cana Resort & Casino in the Dominican Republic. The hotels will convert to Marriott's Autograph Collection, a so-called soft brand that lets independent hotels access corporate loyalty programmes and reservation systems.

The deal more than doubles Marriott's all-inclusive portfolio, according to a statement on Tuesday.

Caribbean hotels were hit hard by the pandemic, with occupancy rates falling to 30 per cent in 2020, down from 64 per cent in the prior year, according to lodging data provider STR. But proximity to US holidaymakers bodes well for the region, especially compared to properties that will rely on corporate travel to spur recovery.

In the long term, the hotel

industry needs business travellers to get back on the road. But for now, pent-up demand for leisure travel is the best bet to drive a hotels rebound, according to a research note from Michael Bellisario, an analyst Robert W Baird & Co.

Marriott is navigating its pandemic recovery without its longtime leader, chief executive Arne Sorenson. The company said recently that Mr Sorenson, who has led the company since 2012, would reduce his work schedule to undergo demanding treatment for pancreatic cancer. Mr Capuano is one of two executives who are handling the company's day-to-day opera-

For Marriott, the deal with Sunwing marks the next step in a foray that began before Covid-19 rattled the global hospitality industry. The company splashed into all-inclusive resorts in the summer of 2019, announcing plans for two new resort properties, including a Ritz-Carlton on Mexico's Riviera Nayarit.

Those deals represented a milestone for Marriott and the business model. For decades, all-inclusive resorts had been the domain of specialist operators, which offered budgetminded travellers lodging, meals and other items for a single price.

As the concept gained popularity with holidaymakers, the world's largest hotel companies determined that loyalty members who accrue points on business trips would like to spend them at all-inclusive resorts.

The model is especially appealing to hotel companies now, when demand for leisure travel is outstripping bookings by corporate road warriors and conference-goers. "The pandemic has been a historic challenge to the travel industry, and we're finally seeing a light at end of tunnel," said Mr Capuano. "We want to be prepared to take full advantage when demand comes roaring back."

Florentia Village opens Chongqing outlet mall

BEIJING

THE COVID-19 pandemic put a dent in China's transformation to a consumption-driven economy last year, but the slowdown in the country's retail market has not deterred the expansion of luxury mall developer Florentia Village.

The outlet mall specialist opened its seventh Greater China location on February 3rd when it debuted its Chongqing outlet before the spring festival holiday, giving its Italian parent firm RDM its second location in south-western China.

With 37,000 square metres (398,265 square feet) of leaseable shop space in its first phase, the luxury shopping destination is poised to bring global fashion brands to one of China's fastestgrowing economic hubs after Florentia Village's three-yearold location in nearby Chengdu.

Bringing global designers to Chongqing

Florentia Village Chongqing will bring more than 100 designer shops in its first phase to its location in the metropolis of more than 30.5 million people, where the group's approach of offering global designer goods at ongoing discounts of up to 80 percent is projected to replicate the success of Florentia Village's locations in Chengdu and other

The project, which covers a total construction area of over 60,000 square metres (645,835 square feet), will offer local residents and visitors access to brands from Europe, United States, and Asia including Furla, Calvin Klein, Karl Lagerfeld, Ports, Brooks Brothers, I.T, Tommy Hilfiger, Agatha, Adidas, Under Armour, New Balance, Puma, Vans, Skechers, Asics, and Sasa.

Based on RDM's experience in China, where it now manages a combined leasing area of 300,000 square metres across its properties, the company projects that Florentia Village Chongqing will attract percent, according to official gov-

800,000 visitors this year, with those guests expected to spend around \$77.2 million.

During 2020, despite nationwide restrictions during the first quarter due to the coronavirus pandemic, Florentia Village's outlet in Chengdu saw its visitor total for the full year rise by 25 percent, compared to the prior 12 month period, to reach 2.5 million people. During last year the location in Chengdu, which at 16.33 million has just over half of Chongqing's population, rang up \$123.5 million in sales - an increase of 78 percent over 2019.

Shoppers defy pandemic

Last year's performance for Florentia Village's Chengdu location is in line with southwestern China's status as a maior growth hub for the country, which saw economic expansion and growth after recovering from the early shocks of the pandemic. In Chongqing, the gross domestic product grew by 3.9 percent for the full year of 2020, with retail sales of consumer goods expanding by 1.3

ernment statistics. As 2020 progressed, retail sales

of consumer goods in Chongqing quickly bounced back with third quarter statistics showing 8.3 percent growth over the same period in 2019. Country-wide, retail sales in China grew steadily last year after the lock-down period ended in March.

While the COVID-19 pandemic was the biggest challenge that Florentia Village had faced in China, the company saw its investment in omni-channel platforms and e-commerce pay off as online sales grew by 500 percent in the early part of 2020. In addition, the total portfolio of Florentia Village offline locations achieved close to \$1.54 billion sales and saw 19 million visitors

Ongoing expansion

This year marks 10 years since Florentia Village was first introduced to China market. The company rapidly expanded its business and now has total of seven locations in Shanghai, Guangzhou, Wuhan and Hong Kong, in addition to its Tianjin, Chengdu and Chongqing stores.

Florentia Village development is backed by major institutional investors as it completes its pipeline with the seventh outlet location. A joint venture backed by Nuveen Real Estate, Hong Kong Gaw Capital, Fingen Group, and Waitex has helped boost the company's footprint across Greater China, including a new pipeline to be disclosed in the second half of the year.

Besides opening in Chongqing, this year Florentia Village is expanding its existing locations in Shanghai and Chengdu as it continues to target value-conscious mainland China luxury shoppers and maintains its position as leading international luxury designer outlet in China.

The Florentia Village Shanghai Phase II project targets to open in the middle of this year with total construction area of around 27,000 square meters (290,626 square feet), accommodating 120 new stores; while the Chengdu Phase II project is expected to be open in the fourth quarter with a construction area of around 30,000 square meters (322,917 square feet) and approximately 100 new brand stores.

Prime property market in Dubai showing signs of improvement

DEMAND for prime residential property in a number of flagship communities in Dubai rebounded in the second half of last year, recording higher prices and transaction levels, according to Knight Frank.

Transaction volumes for prime properties increased by 7.9 per cent in 2020, compared to an overall 16.4 per cent market decline, the company's UAE Market Review and Forecast said. "On the prime side of things, it's been a relatively good year. In the vast majority of markets, we've actually seen greater volumes in terms of transaction numbers in 2020 than we've seen in a few years," Taimur Khan, associate director at Knight Frank Middle East told The National.

Although prime residential values decreased by 4.2 per cent in 2020, in the second half of the year apartment and villa prices on Palm Jumeirah increased by 5.1 per cent and 9.4 per cent, respectively. Prices for villas in the Mohammed Bin Rashid City District One Community were 3.5 per cent higher and other prime markets such as Downtown Dubai and Emirates Hills also showed signs of improvement, the report showed.

The reasons for recovery are area-specific, but a common theme is a demand for mature communities. "If you look at what's happening on the Palm, a lot of it is fairly developed out now. You can't really get the Dubai continuous additional development," Mr Khan says.

There had also been a readjustment in prices that meant even prior to the pandemic, "we were seeing a bottom for villas on the Palm". Improvements to roads and the addition of amenities such as the malls and other leisure attractions have helped drive de-

Similarly, new community facilities at District One, where Meydan Mall is moving closer to completion, is also making the community attractive to prospective buyers, Mr Khan said. "District One has done well because it's a really good product in a really good location - the ABCs of property," Mr Khan said.

Dozens of former Republican officials in talks to form anti-Trump third party

WASHINGTON

DOZENS of former Republican officials, who view the party as unwilling to stand up to former President Donald Trump and his attempts to undermine U.S. democracy, are in talks to form a center-right breakaway party, four people involved in the discussions told

The early stage discussions include former elected Republicans, former officials in the Republican administrations of Ronald Reagan, George H.W. Bush, George W. Bush and Trump, ex-Republican ambassadors and Republican strategists, the people involved say.

More than 120 of them held a Zoom call last Friday to discuss the breakaway group, which would run on a platform of "principled conservatism," including adherence to the Constitution and the rule of law - ideas those involved say have been trashed by Trump.

The plan would be to run candidates in some races but also to endorse center-right candidates in others, be they Republicans, independents or Democrats, the people say.

Evan McMullin, who was chief policy director for the House Republican Conference and ran as an independent in the 2016 presidential election, told Reuters that he co-hosted the Zoom call with former officials concerned about Trump's grip on Republicans and the nativist turn the party has taken.

Three other people confirmed to Reuters the call and the discussions for a potential

splinter party, but asked not to be identified.

Among the call participants were John Mitnick, general counsel for the Department of Homeland Security under Trump; former Republican congressman Charlie Dent; Elizabeth Neumann, deputy chief of staff in the Homeland Security Department under Trump; and Miles Taylor, another former Trump homeland security official.

The talks highlight the wide intraparty rift over Trump's false claims of election fraud and the deadly Jan. 6 storming of the U.S. Capitol. Most Republicans remain fiercely loyal to the former president, but others seek a new direction for the party.

The House of Representatives impeached Trump on Jan. 13 on a charge of inciting an insurrection by exhorting thousands of supporters to march on the Capitol on the day Congress was gathered to certify Democrat Joe Biden's election victory.

Call participants said they were particularly dismayed by the fact that more than half of the Republicans in Congress - eight senators and 139 House representatives - voted to block certification of Biden's election victory just hours after the Capitol siege.

Most Republican senators have also indicated they will not support the conviction of Trump in this week's Senate impeachment trial. "Large portions of the Republican Party are radicalizing and threatening American democracy," McMullin told Reuters. "The party needs to recommit to truth, reason and

founding ideals or there clearly needs to be something new."

'THESE LOSERS'

Asked about the discussions for a third party, Jason Miller, a Trump spokesman, said: "These losers left the Republican Party when they voted for Joe Biden."

A representative for the Republican National Committee referred to a recent statement from Chairwoman Ronna McDaniel.

"If we continue to attack each other and focus on attacking on fellow Republicans, if we have disagreements within our party, then we are losing sight of 2022 (elections)," McDaniel said on Fox News last month.

"The only way we're going to win is if we come together," she

The Biden White House did not immediately respond to a request

for comment. McMullin said just over 40% of those on last week's Zoom call backed the idea of a breakaway, national third party. Another option under discussion is to form a "faction" that would operate either inside the current Republican Party or outside it.

Names under consideration for a new party include the Integrity Party and the Center Right Party. If it is decided instead to form a faction, one name under discussion is the Center Right Republi-

Members are aware that the U.S. political landscape is littered with the remains of previous failed attempts at national third parties. "But there is a far greater hunger for a new political party out there than I have ever experienced in my lifetime," one participant said.

A close aide to ousted Myanmar leader Aung San Suu Kyi was detained in a new wave of arrests following last week's military coup, a party official said yesterday, as Washington moved a step closer to imposing sanctions on

the junta. The aide, Kyaw Tint Swe, had served as minister for the office of the state counsellor under Suu Kyi, who has been detained since

the Feb. 1 coup. Regarded as Suu Kyi's righthand man, Kyaw Tint Swe had been one of her representatives in crunch talks with the military days before the civilian government was overthrown.

Kyi Toe, an information committee member of Suu Kyi's National League for Democracy (NLD), said Kyaw Tint Swe and four other people linked to the taken from their homes overnight, and the top leadership of the former electoral commission had all been arrested.

The military launched the coup after what it said was widespread fraud in November elections, won by the NLD in a landslide. The electoral commission had rejected those claims. Myanmar authorities did not immediately respond to a request for comment, and Reuters was unable to confirm the arrests independently. Scores of officials have been detained since the coup, including many of the NLD's top leaders.

Protesters gathered across the country for a sixth straight day yesterday. Hundreds of workers lined a road in the capital Naypyitaw in support of the civil disobedience movement, chanting previous government had been anti-junta slogans and carrying port dictators," read one of the downs, until the military began



placards supporting Suu Kyi.

In keeping with the creativity of recent demonstrations, where some protesters have worn ball gowns and costumes, rallies in Yangon included men and boys dressed in short skirts. "We don't take off our skirt until we get democracy back," one sign read.

Hundreds of protesters also demonstrated outside the Chinese embassy in Yangon, accusing Beijing of supporting the military junta despite Chinese denials.

U.S. SANCTIONS LOOM

The protests have revived memories of almost half a century of direct army rule, punctuated with bloody army crackrelinquishing some power in 2011. U.S. President Joe Biden on Wednesday approved an executive order for new sanctions on those responsible for the coup, and repeated demands for the generals to give up power and free civilian leaders.

Washington would identify the first round of targets this week and was taking steps to prevent the generals in Myanmar, also known as Burma, having access to \$1 billion in Myanmar government funds held in the United States. "We're also going to impose strong exports controls. We're freezing U.S. assets that benefit the Burmese government, while maintaining our support for health care, civil society groups, and other areas that benefit the people of Burma directly," Biden said at the White House.

Benefits of the COVID-19 vaccine developed by AstraZeneca and Oxford University outweigh known and potential risks, the World Health Organization (WHO) has ruled amid concerns over vaccine's efficacy against the coronavirus variant found in South Africa.

The WHO Strategic Advisory Group of Experts on Immunization (SAGE) panel on Wednesday said the two-dose AstraZeneca vaccine efficacy tended to be higher when the interval between doses was within the four to 12 weeks range. It also added that although preliminary analyses based on a small sample size in South Africa indicate a marked reduction in vaccine effectiveness against mild and moderate disease, it did not allow a specific assessment of vaccine efficacy against severe COVID-19.

As indirect evidence is compatible with protection against severe COVID-19, the situation remains to be demonstrated in ongoing clinical trials and post-implementation evalua-

In view of this, WHO currently recommends the use of the AstraZeneca vaccine even if the variants are present in a country. Countries should conduct a benefit-risk assessment according to the local epidemiological situation, including the extent of circulating virus variants.

EU rejects most UK demands on N. Ireland trade, except steel

THE European Union rejected on Wednesday most of Britain's demands for easier trade with Northern Ireland but said it was examining more flexibility on steel.

In a letter to British Cabinet Minister Michael Gove, European Commission Vice-President Maros Sefcovic (pictured) said the EU executive arm was "examining possible amendments" to make steel imports into Northern Ireland from Britain

"There is elements that the British government could sort out, but likewise on the European side, I would say some member states need to cool it as well," Martin told RTE radio. "I think we need to dial down the rhetoric on both sides here."

On Feb 3, Gove asked for the removal of barriers on pet travel between Britain and Northern Ireland and movement of seed potatoes and other plants and plant products, but the EU appeared to reject that as well. **Agencies**

BRAZIL'S Health Regulatory Agency (Anvisa) announced on Jan. 17 that it has approved the emergency use of the CoronaVac vaccine, from the Chinese biotech firm Sinovac. The first batch of Brazilian vaccines were

This made Brazil the third country in the world to approve the emergency use of the CoronaVac vaccine, after Indonesia and Turkey. Chinese vaccines' overall safety and efficacy are widely being recognized in the

The CoronaVac vaccine started Phase I and II clinical trials in last April. After bring proved to be safe and effective, it was put into Phase III clinical trials in Brazil, Turkey, Indonesia and Chile. According to Turkey's interim data, the Chinese vaccine is 91.25 percent effective. It was also proved to have an efficacy rate of 65.3 percent by Indone-

China's CoronaVac vaccine recognised by multiple countries

sia's Phase III clinical trials. Brazil's Phase III clinical trials showed that the vaccine is 100 percent effective against severe symptoms and 78 percent for mild cases, which led to a general efficacy of 50.38 percent.

Yin Weidong, chairman of Sinovac, said on a Jan. 13 press conference that the Phase III clinical studies have already proved the safety and efficacy of the Chinese vaccine in the global context.

"We have a projected annual production capacity of more than 1 billion doses," Yin said, adding that the biotech firm has built a production line that is able to produce about 500 million doses of the CoronaVac vaccine solutions annually. "The production line for the second phase of our vaccine solutions will be put into operation in February this year," he continued.

It is reported that multiple countries, including Indonesia, Turkey, Malaysia, Singapore and the Philippines have signed deals with Sinovac for vaccine supply. The vaccine developed by the company was also injected to multiple state leaders, which demonstrated their trust to the Chinese vaccine.

Turkish President Recep Tayyip Erdogan received his first dose of the CoronaVac vaccine in Ankara on Jan. 14, local time, a day after Turkey announced to approve Sinovac vaccines for emergency use. CoronaVac is the first COVID-19 vaccine approved by the country.

Indonesian President Joko Widodo re-

ceived the first dose of CoronaVac on Jan. 13, live on television. Indonesia's food and drug authority BPOM issued an emergency use authorization to the vaccine on Jan. 11, explaining the vaccine has undergone a Phase III trial in Bandung, and its efficacy was higher than the 50 percent threshold stipulated by the World Health Organization.

Malaysian state-run pharmaceutical company Pharmaniaga on Jan. 12 reached a deal on COVID-19 vaccine cooperation with Sinovac. The Chinese firm will provide 14 million doses of ready-to-fill COVID-19 vaccines to Malaysia, and the Malaysian company will carry out a fill-and-finish process of the vac-

cine in Malaysia. The Ukrainian Lekhim Group also part-

nered with Sinovac on the purchase of 5 million doses of CoronaVac vaccine. Besides, the Ukrainian firm is planning to produce locally multiple Sinovac vaccines, including the CoronaVac, from 2022.

Brazilian Health Minister Eduardo Pazuello said on Jan. 7 that Brazil has signed an agreement with the Butantan Institute of Sao Paulo to purchase 100 million doses of CoronaVac vaccine. The Department of Health of the Philip-

pines recently disclosed that the Philippine government has secured 25 million doses of Sinovac-developed CoronaVac vaccine. The country's Food and Drug Administration said it has received an application from the Chinese firm seeking an emergency use authorization for the CoronaVac vaccine. The vaccine is expected to be granted as early as this February . People's Daily

Xi speaks with Biden on phone on eve of Lunar New Year

Biden conveyed festive greetings to the Chinese people and wished the Chinese people a happy and prosperous New Year. Xi congratulated Biden once again on taking office as US president, and wished the people of China and the United States a happy and auspicious Year of the Ox.

Xi pointed out that the restoration and growth of China-US relations has been the most important development in international relations over the past half century and more.

Despite various twists and difficulties, he added, the relationship has on the whole kept moving forward and delivered enormous benefits to the Chinese and American peoples and contributed to global peace, stability and prosperity.

Xi stressed that China and the United States both gain from cooperation and lose from confrontation; cooperation is the only right choice for both

When China and the United States work together, they can accomplish a great deal for the good of both countries and the world at large; confrontation between the two countries, however, will definitely be disastrous for both countries and the world, he

Emphasizing that the China-US relationship is currently at an important juncture, Xi said it is the common desire of both peoples and the wider international community to see the sound and stable development of China-US relations.

"You have said that America can be defined in one word: Possibilities. We hope the possibilities will now point toward an improvement of China-US relations," Xi said to Biden.

Biden, for his part, noted that China has a long history and a great culture and the Chinese people are a great people.

The United States and China must avoid conflict and they may work together on climate change and many other issues, he added.

The US side, he said, is prepared to have candid and constructive dialogue with the Chinese side in the spirit of mutual respect and to improve mutual understanding and avoid miscommunication and miscalculation.

The two presidents agreed that their phone conversation today will send a positive signal to the world and the two sides will maintain close communication on China-US relations and issues of mutual interest.

CDC experiments show double masks substantially reducing exposure to virus

WASHINGTON

THE U.S. Centers for Disease Control and Prevention (CDC) has recently conducted experiments to improve the fit of masks amid COVID-19 pandemic, suggesting that combining cloth mask and medical procedure mask could reduce a wearer's exposure to virus by over 90 percent.

In January, the CDC conducted experiments to assess two ways of improving the fit of medical procedure masks: fitting a cloth mask over a medical procedure mask, and knotting the ear loops of a medical procedure mask and then tucking in and flattening the extra material close to the face.

Each modification substantially improved source control and reduced wearer exposure, according to a report released by the CDC on Wednesday.

"Based on experiments that measured the filtration efficiencies of various cloth masks and a medical procedure mask, it was estimated that the better fit achieved by combining these two mask types, specifically a cloth mask over a medical procedure mask, could reduce a wearer's exposure by over 90 percent," said the report.

These laboratory-based experiments highlight the importance of good fit to optimize mask performance.Until vaccine-induced population immunity is achieved, universal masking is a highly effective means to slow the spread of SARS-CoV-2 when combined with other protective measures, such as physical distancing, avoiding crowds and poorly ventilated indoor spaces, and good hand hygiene, according to the

Western hysteria directed at Russia won't change Moscow's policy, diplomat says

RUSSIAN policy does not depend on pressure of external players, hysteria of Western countries regarding Moscow cannot change its political course, Russian Foreign Ministry Spokeswoman Maria Zakharova told Channel One.

"Let's not focus on this hysteria as on something that can cancel out, change our policy. Our policy

is not formed depending on somebody wanting to hurt us, do harm and so on," she said.

The spokeswoman noted that the situation with deportation of Russian diplomats from Germany, Sweden and Poland is not an unprecedented one, "roughly repeating what we have already seen and experienced." "This has been going on for years, decades, centuries. People, and I mean our collective



West, defend their own interests. When they don't have any opportunities for equitable competition which would be based on law, on legislation, on common rules of regulation, they move on to aggressive policy," she added.

On February 5, the Russian Foreign Ministry reported that Russia declared a Swedish, a Polish and a German diplomat personae non gratae for participating in unauthorized rallies in Moscow and St. Petersburg on January 23. Representatives of these countries' embassies were summoned to the Russian Foreign Ministry and handed notes of protest.

On February 8, as a retaliatory measure, these countries deported Russian diplomats. The Russian Foreign Ministry pointed out the baselessness of these actions.

China's GDP exceeds 100 trillion yuan for first time

CHINA'S GDP expanded 2.3 percent and hit 101.5986 trillion yuan (\$15.51 trillion) in 2020, exceeding the 100 trillion yuan mark for the first time, official data showed re-

Facing the rare COVID-19 pandemic, the world economy plunged into the most severe recession since the end of the World War II over the last year. The Chinese economy also slipped 6.8 percent yearon-year in the first quarter, the first ever negative growth registered since the country started recording quarterly economic data.

At the critical moment, the Chinese government precisely assessed the situation, took decisive actions and coordinated epidemic prevention and control and economic and social development. Launching a battle against the epidemic by mobilizing all resources and blocking the spread of the virus, China pledged to increase its deficit by 1 trillion yuan over last year and issue 1 trillion yuan of government bonds for COVID-19 control. It also called on financial institutions to concede 1.5 trillion yuan worth of their profits to companies and increased tax and fee cuts by 2.5 trillion yuan.

Thanks to these efforts, Chi-

na became the first country to control the pandemic and resumed work and production, being the first major economy to recover positive growth. The growths of the country's economy in the four quarters last year were -6.8 percent, 3.2 percent, 4.9 percent and 6.5 percent, respectively, and China is predicted to be the only major economy that is able to secure positive growth. The country's economic value now accounts for 17 percent of the total global economy, up from 16.3 percent in 2019, making a new historical record.

As the country steps onto a higher level economy-wise, great strides have also been made in its social, technological and ecological progress.

The last nine impoverished counties of the country, all in southwest China's Guizhou province, have eliminated absolute poverty, the province announced on Nov. 23, 2020. This meant that all 832 registered poor counties in China have shaken off poverty, indicating that the country has achieved the poverty reduction target of the UN 2030 Agenda for Sustainable Development 10 years ahead of schedule.

The country's Chang'e-5 probe returned the Earth after retrieving lunar samples, and

its Mars mission Tianwen-1 was successfully launched. In addition, China announces the completion of the BeiDou Navigation Satellite System and started providing all Beidou services. Its quantum computer prototype Jiuzhang was also created.

Though impacted by CO-VID-19, China's innovation and development still step forward. The country unswervingly implemented its new vision for development and promoted high-quality development, which resulted in a steady rise in both the quality and benefits of its economic growth, said Ning Jizhe, head of the National Bureau of Statistics (NBS). China has brought its social productive forces to a new level, he added.

What's behind the 100 trillion

yuan mark is the constant improvement in China's comprehensive national strength. Last year, China's total grain output hit a new record in history, exceeding 650 billion kilograms for six consecutive years and ranking the first in the world. Its added value of manufacturing industry is also expected to top the world for 11 years in a row. The total mileage of operational high-speed rails in China has hit 38,000 kilometers, and its expressways add up to over 155,000 kilometers, both ranking the first in the world. Besides, China is also a country that holds the most 5G users, with more than 200 million terminals connected to its 5G network.

concentration," he stated.

"There are times when they are very aggressive and fail to return quickly to catch, which can be detrimental if they meet running wingers, so be more careful in the game," he said.

In addition to giving tactics to the peripheral defenders, he said even the midfielders should get along with the attacking midfielders to make sure they start attacking their opponents before they reach the opponents' area.

"The opponents must be given a central position, that will relieve the pressure on the goalkeeper to regularly save AS Vita Club strikers' attempts, however I believe Simba can do wonders in the game, they should be confident and play against the opponents with discipline," he said.

And the team's former coach, Abdallah Kibadeni, echoed Pawasa's statement, maintaining Simba's fans should be confident that their club is facing 11 players on the pitch.

Kibadeni was of the opinion Simba need to attack, an approach that will shock opponents and force them to settle for different tactic.

He noted: "Players should not go on the field with a lot of fear, they should showcase commitment, discipline and resort to attacking approach, the move will shock AS Vita Club."

TFF issues ban on Shinyanga, Tabora football officials

THE Tanzania Football Federation (TFF) has banned Shinyanga Regional Football Association (SHIREFA) Chairman Bannister Misango from participating in football activities for two years after violating the sport's rules.

The leader has been suspended through the TFF Ethics Committee immediately after failing to perform his duties professionally, violating SHIREFA constitution's article 41

In 2009, Misango breached the rules via appointing a representative of the region's clubs, Michael Kaijage, as SHIREFA's acting secretary general, instead of the association's assistant secretary, Stephen Mihambo.

The SHIREFA Chairman pleaded guilty before the TFF Ethics Committee.

A statement from the TFF stated that the leader was punished in accordance with Article 2 (6) (1) and Article 3 (9)(1) of the 2013 Ethics Manual.

The TFF Ethics Committee also banned Dikson Mulimuka, a candidate for the Tabora Regional Football Association (TAREFA) chairmanship and party leader Stella Maganga from engaging in football activities for 10 years.

Mulimuka, who was a candidate in the TAREFA election, had overseen the Urambo District Football Association election, an act which is contrary to Article 19 (2) of the 2013 TFF code of conduct.

In the case of Stella, a TAREFA leader, she was suspended by the TFF Ethics Committee after she had served as a candidate, an administrator and a voter in the Sikonge District Football Association election contrary to Article 3 (3.1) of the TFF Code of Ethics, 2013 edition.

THE government has said it expects a total of 17 more athletes to qualify for the Olympic Games, which will take place in Tokyo, Japan from July 23 to August 8.

Athletics, judo, boxing and swimming are sports disciplines that the country is expected to participate in.

Recently, Athletics Tanzania announced 25 athletes in search of qualification.

Open Boxing Federation of Tanzania announced 15 boxers seeking qualification, and judo associatio disclosed that 10 players are seeking to make it to the Olympics

The metioned players will be responsible for finding the qualifying

marks for the Olympics.

The Tanzania Swimming Association announced three swimmers who will be responsible for finding the qualifying marks.

While the athletes are in the process of preparing for the showpiece, Director of Sports in the Ministry of Information, Culture, Arts, and Sports, Yusuph Singo, said so far they are not satisfied with the number of qualified athletes and they expect to see others win qualifying

Singo said they expect to see six more athletes make it to Olympics, as well as four boxers.

"We also expect all three swimmers to qualify for the competition to get a satisfactory number, not these two that we currently have," Singo revealed.

He said the government has now put in place a strategic plan for the competition, whereby they have held various forums to see how they are going to increase the number of athletes in the competition.

"We have held various meetings and

delegated responsibilities. Apart from the four associations, the meeting also involved the Tanzania Olympic Committee (TOC). It is our hope that we will be able to successfully increase the number of athletes," he disclosed.

The Summer Olympic Games also known as the Games of the Olympiad, are a major international multi-sport event normally held once every four years. The Games were first held in 1896 in Athens, Greece, and were most recently held in 2016 in Rio de Janeiro,

The International Olympic Committee (IOC) organises the Games and oversees the host city's preparations.

In each Olympic event, gold medals are awarded for first place, silver medals are awarded for second place, and bronze medals are awarded for third place.

This tradition began in 1904. The Winter Olympic Games were created out of the success of the Summer Olympics.

Bennacer credits vocal Ibrahimovic with inspiring AC Milan's young guns

MILAN

ZLATAN Ibrahimovic rarely hesitates to harangue his young AC Milan teammates but "it's better than if he said nothing", says Algeria midfielder Ismael Ben-

France-born Bennacer joined Milan from Empoli in 2019 and has, over the past two seasons, become one of the key members of the team who are currently leading Serie A.

"Even if sometimes we see that he's screaming on the pitch, it's better than if he didn't say anything, otherwise it would mean that he doesn't care," the 23-yearold told AFP.

"He brings us a lot. With all the experience he has acquired, he tries to take us to the highest level with him, he always seeks perfection. He gives us a lot of advice."

The 39-year-old Swedish star has been a talismanic figure since returning to Milan in January 2020, reviving the fallen European giants.

Ibrahimovic has become a standard bearer among a new generation of young talent, with the average age of the seven-time European champions one of the lowest in Serie A.

Playing alongside Bennacer is 24-year-old Ivory Coast midfielder Franck Kessie, France's Theo Hernandez, 23, Portuguese Rafael Leao and Belgian Alexis Saelemaekers, both 21.

Despite his experience, goalkeeper Gianluigi Donnarumma is also only 21.

Milan were top of the league at the halfway point in January for the first time since 2011, the year they went on to win their 18th and last Scudetto.

The catalyst for the revival was possibly their humiliating 5-0 defeat by Atalanta at the end of 2019.

"After this defeat, there was a lot of soul searching," said Bennacer, who was born in Arles, in the south of France, to an Algerian mother and a Moroccan father.

Current Milan coach Stefano Pioli arrived a few weeks before the Atalanta humiliation.

"(Pioli) knows how to manage the group, he's close to us, he always asks us if we are tired, if we are well and so on.

"(He brought) that team spirit that maybe we didn't have enough of before, how to wear this jersey."

- 'A good feeling' -

Milan lead city rivals Inter by two points before their trip to Spezia on Saturday.

But there is still a long way to go if they are to last the distance and deny Juventus a 10th consecutive Serie A title.

"I work a lot on my faults. I was a little too aggressive, not thinking," admits Bennacer, who has been learning quickly under the tutelage of Ibrahimovic.

Mourinho's remarks came just 24 hours after 31-year-old Bale shared a picture of himself training on Instagram. Tottenham, who battled back from 3-1 and 4-3 down having taken the lead in the third minute, have now lost four of their last five games.

Maradona death: Three suspects added to probe

BUENOS AIRES

TWO nurses and a psychologist have been added to the investigation nto the death of Diego Maradona.

Maradona died at the age of 60 of a heart attack on Nov. 25, two weeks after being released from a hospital in Buenos Aires following successful

A probe was opened by authorities in Argentina to establish if there was negligence in Maradona's treatment following the operation and if so, for those individuals to face a criminal case for manslaughter.

Leopoldo Luque, the neurosurgeon who performed Maradona's brain surgery, and psychiatrist Agustina Cosachov, who had treated the former Napoli star, are under investigation and had their homes and offices searched shortly after his death.

Psychologist Carlos Diaz, who treated Maradona in the months prior to his passing, and nurses Dahiana Gisela Madrid and Ricardo Almiron, have now been placed under investigation, according to sources from San Isidro's Prosecutors' Office.

Shortly after Maradona's death, his lawyer, Matias Morla, had requested a full investigation of the circumstances of the footballing legend's death,

criticising what he said was a slow response by emergency service.

Atletico's battle-scarred stars key in march to La Liga title

SINCE Atletico Madrid last won the Spanish title in 2014, the average number of points needed to win La Liga has been 86. Even if Monday night's 2-2 draw at home to Celta Vigo was disappointing, especially conceding such a late equaliser, it's a very good bet that with 51 points in the bag Atleti are, at most, 12 wins away from what would be only their third Spanish title win in 44 years. Heady times.

In fact, if you take into account Atleti have games in hand on Barcelona, Real Madrid and Sevilla FC, perhaps it's as few as eight or nine wins which will give Diego Simeone and his band of brothers that golden champion feeling.

But hold on a minute. The fixture list has obstacles for Los Rojiblancos. The champions-elect must try to win away in some of Spain's most testing places -- at Sevilla, at Villarreal, at Athletic Bilbao, at Barcelona, at Levante and at Real Betis.

The "Amen Corner" of Atleti's title charge, if I may call it that in honour of them trying to "Master" Spain, runs like this: away to Granada, away to Levante, at home to Levante four days later, away to Villarreal, at home to Madrid, at home to Athletic, away to Getafe, at home to Alaves, away to Sevilla and then away to Betis.

In the midst of all that there are Champions League tests against a tougher, revived Chelsea under new manager Thomas Tuchel.

You emerge from that bruising run without too many "bogey" matches, without a bloody nose, points sliding out of your grasp, without injuries, suspensions or a loss of morale and, frankly, you're nearly on top of the podium.

Whether Atleti achieve it or not isn't simply about the marvellous squad they've assembled, about their points advantage or the fact that Spain's "Big Two" (Madrid and Barca) are in deep upheaval.

It's less evident than their playing attributes but Simeone has a strong central core of gnarled, battle-scarred footballers who've been disrespected, discarded, pushed around, insulted, felt fear for their lives -- but who, to a man, have re-

This isn't quite the "Dirty Dozen" - a specially assembled squad of streetwise misfits who'll break all the rules, nick your medals if you drop vour guard but fulfil the mission because they've nothing left to lose but self respect.

But it is a squad full of those who've fed off the survival instinct, who are fired by an aggression and determination which should see them through the bumps, bad luck and wobbly moments of an intense title run-in.

Simeone is a good starting example. Top general, massive salary, the most successful coach in Atleti's entire history - but haunted.

Their Champions League final defeats, particularly the acid burn of losing to Madrid twice, each time in the most horrible circumstances of either conceding a last-minute equaliser (2014 in Lisbon) or Juanfran's crucial penalty clipping the post and bouncing wide (2016 in Milan), absolutely haunt him.

He's admitted, perhaps not wisely, that the infamous Champions League anthem, which gives so many football people goosebumps and fills them with ambition, "makes me feel pure pain every time I hear it."

A driven man? More driven than Miss Daisy.

His first lieutenant in this "Dirty Dozen" metaphor is, of course, Luis "El Pistolero" Suarez.

All his life he's had to fight. Fight to work his way up the football ladder, fight to win recognition, fight to win the sport's big prizes and, above all, fight to restore people's respect and admiration after the various controversial episodes which, temporarily, have made him a pariah figure. Every damn time he's fought back and moved up.

Then, at Barcelona, he not only establishes himself as the best striker partner Lionel Messi has ever enjoyed but he proves that he's one of the most technical, smartest centreforwards of the modern era.

Until he falls foul of the embarrass-

ing, now former, Camp Nou president Josep Maria Bartomeu.

Picked upon, booted out the door and shown zero respect, never mind affection or gratitude. Just the other day he used Spanish radio to confirm: "It was brutal the way that I was disrespected by FC Barcelona. I wanted my kids to see me leaving with dignity and honour. The proper way. When the moment came to tell the kids what they were doing to me it was very hard.

"Maybe I could have insisted on staving, taken my salary and done my best in the circumstances but I knew that at the first hint of difficulties I'd come under attack. For my own pride and self respect, given how they were treating me, I needed to move."

You think he's putting all that anger, all that competitive rage into his season at Atleti? Damn tootin' he is - 16 goals, two assists, leader of the Pichichi scoring charts and both Barcelona and Madrid looking at his heels at the top of the division. Burn baby burn. It's a Suarez inferno.

These narratives count in the deep midwinter of a title challenge. Who's driven more by the scent of silverware than salary? Who's got something to prove or experiences which are psychological scars - events to tell you never to be intimidated or tentative

Strangely enough, Jan Oblak's in that group. He's had something to prove since almost the very beginning at Atleti. Signed to replace the outgoing Thibaut Courtois in the summer after the 2014 title season and a Champions League final loss, the Slovenia international had been Benfica's No. 1 as they won the domestic Treble.

Moving to Atleti for €14 million, Oblak was suddenly relegated to second choice behind Miguel Angel Moya and, out of the blue, had to confront the idea that Atleti had immediately lost all faith in him and wanted to send him back to Portugal.

Benfica president Luis Filipe Vieira told the club's TV station that: "I never thought that Oblak would be returning here but the world's a weird place and Atleti have offered him back to us... we said 'no' of course."

Whether it was true, whether there was some mischief making... whatever. Oblak, in a new, strange, demanding environment, was hit with doubt and disrespect.

It's an experience which either makes or breaks you. From that day to this, where many would argue he's the best keeper in the world, has been quite a journey -- still fuelled by the 'I'll show everyone!' mentality.

The list goes on - many, perhaps most, of Simeone's disciples have steel about them, forged by experiences which have no relationship to their talent, their wealth, their exalted status.

Take Saul, for example. He was a Real Madrid starlet -- they call them "Mirlos" (after birds who are usually dark or mottled in colour but who, when they have white plumage, are exceptional). For whatever reason his talents weren't appreciated and he's often explained how he was bullied -by fellow players but, in his view, by those who were central to the structure of the youth Academy.

After having his boots and his snacks "stolen" the worst came when an offensive letter was sent to one of the coaches -- purporting to be from Saul when, categorically, it wasn't. He quit. Atleti came calling, he loved the idea and... here we are.

He's won five trophies with Atleti and played in three youth-level European finals for Spain. Don't for a second think that being mistreated and picked upon hasn't fired him up to be the man, the winner, he is. The names and the similar character traits just keep coming. Simeone's fighters.

Kieran Trippier is another good example. Beaten in his, now, home stadium for Tottenham Hotspur in a Champions League final where they never got going against Liverpool, he left the Metropolitano that night willing enough to speak to reporters. He castigated himself for poor form, a poor season and swore that he'd be ferocious in pressing a "restart" but-

Weeks later he'd secured a move to Atleti, was diligently learning Spanish at a rate which would have scared the daylights out of Gareth Bale and he established himself as an essential part of Simeone's attacking wide-defender system. An Englishman abroad - but one fuelled by an iron desire to replace bitter memories with sweet, silverware alternatives.

Koke? Held up at gunpoint a couple of years ago so that the thugs could rob his expensive watch. Shrugged it off. Barely an impact. He hated, though, the fact that last season some of the most loyal Atleti fans and media were speculating about his form, his worth to the team and his motivation.

Especially at a time when he'd been dropped by Spain's national team since the disastrous 2018 World Cup in Russia. Response? A special season this term; driven, important, responsible. Leading the team he's always supported and adored, he was restored to La Roja starting XI by Luis Enrique just in time to be one of the standout players when Spain thrashed Germany

Made of the right stuff, Koke - like Simeone, Suarez, Trippier, Oblak, Saul, and Angel Correa, who could only arrive and play for Atleti after a sixmonth recuperation following heart surgery in 2014 at the age of 19.

Joao Felix -- rejected by Porto as a kid for being "too slight" is Atleti's record signing. He is awfully glad he fought through the temptation to quit football altogether in disgust at his treatment at Os Dragões.



Yanga trio regains fitness
